# Majaliwa joins Sumaye - after he is named as premier again

#### **By Guardian Reporter**

KASSIM Majaliwa has joined a short list of individuals appointed to serve as Prime Minister for two consecutive terms, the only other being Frederick Sumaye.

The Ruangwa lawmaker was yesterday confirmed by the National Assembly as Prime Minister for the next five years after being nominated by President John Magufuli.

If he completes the term, he will have fully matched Sumaye who served under the late Benjamin Mkapa for 10 sold years–from 1995 to 2005.

His predecessor Mizengo Pinda was picked at mid first term of President Jakaya Kikwete after

the dramatic resignation of Edward Lowassa, proceeding to serve for seven years.

Cleopa Msuya served as PM twice: first for two years under the late Julius Nyerere from November 1980 to February 1983 and then for a year, from December 1994 to November 1995 during the transition to multiparty system, under second phase President Ali Hassan Mwinyi.

Also serving twice was the late Edward Sokoine, first from early 1977 to polls 1980 and from early 1983 to early 1984 when he died in a road accident in Morogoro Region, travelling from Dodoma to Dar es Salaam.

The doyen of prime ministers however is the late Rashidi Kawawa, first serving from January

### Biden picks White House insider as next chief of staff washington dc

US President-elect Joe Biden yesterday picked veteran political operative Ron Klain to be White House chief of staff.

Klain has served as a top aide to Biden since the 1980s in the Senate and later when he was vice-president.

The ultimate Washington insider, Klain was also a senior White House aide to Barack Obama and chief of staff to Vice-President Al Gore.

He was played by actor Kevin Spacey in the movie Recount, about the presidential election of 2000.

The White House chief of staff - who manages the president's daily schedule and is often described as his gatekeeper - is a political appointee who does not require confirmation by the Senate.

Biden paid tribute to Klain in a statement issued by his transition team on Wednesday.

"His deep, varied experience and capacity to work with people all across the political spectrum," said Biden, "is precisely what I need in a White House chief of staff as we confront this moment of crisis and bring our country together again."

In the same statement, Klain said he was "humbled" by the president-elect's confidence in him.

"I look forward to helping him and the vice president-elect assemble a talented and diverse team to work in the White House, as

### Upbeat MPs give work plans after swearing-in

A SECTION of newly elected members of Parliament yesterday expressed optimism that they will serve to the satisfaction of their voters, highlighting development priorities for the next five years.

# USAID: Conservation model extensively curbed poaching

A CONSERVATION project that has been ongoing for the past five years that employed strategies such as involvement of MPs, magistrates, the private sector and the media managed to reduce poaching by 80 per cent.

A statement released yesterday by the United States Embassy in Dar es Salaam said that the project supported various targeted initiatives, such as interregional exchange programmes and trainings to fight poaching.

The project is a brainchild of the United States Agency for International Development (USAID), named 'Promoting Tanzania's



Environment, Conservation, and Tourism' (PROTECT), implemented at a cost of \$19.1 million (over 40bn/-

"As a result, Tanzania was better prepared to fight wildlife crime on all levels through stronger wildlife crime policies, a better understanding of how to identify wildlife trafficking and try wildlife crimes," it reads, as part of a virtual seminar held yesterday to celebrate five-years of safeguarding Tanzania's biodiversity and tourism-driven economy.

The digital event, "Celebrating USAID PROTECT: Five Years of Conserving Tanzanian Wildlife," highlighted successes of the project, citing the reduction of poaching in the country by 80 percent, opn the basis of affirmations by the Ministry of Natural Resources and Tourism.

1962 to December 1962, remaining vice president for ten years, and then from 1972 to 1977 took the title of Prime Minister and Second Vice President, under founder President Nyerere.

The father of the nation also served as prime minister for a few months, from Madaraka Day on May 1 to Independence on December 9 and up to January 1, 1962 when he resigned to build up TANU, leaving the post to Kawawa.

The latter all the same served under Governor General Sir Richard Turnbull, who was commander in chief of the armed forces.

Judge Joseph Warioba served a full term as premier from late 1985 to polls 1990, while John Malecela served for most of the second term of President Mwinyi, from late 1990 to late 1994.

Dr Salim Ahmed Salim served briefly as premier, from April 1984 to polls 1985, following the death of Sokoine.

In the third session of the first meeting of the 12th Parliament yesterday, Speaker Job Ndugai received a handwritten nomination letter from President Magufuli.

Majaliwa was then confirmed by MPs, taking all 350 votes cast by the lawmakers who were in the House, equal to 100 percent of available votes.

Presenting the biography of the Prime Minister as well as the Parliament's declaration, Attorney General Dr Adelardus Kilangi described Majaliwa as a good and hardworking leader who will help the country to achieve its development goals in time.

He said that Majaliwa has proved to be a good leader due to initiatives he took improve government performance, helping to bring about an economic revolution in the country.

"He has respectable experience to serve in this post, he is a real hard worker, he has in the past five years supported President Magufuli to implement his vision including the fight against corruption and embezzlement of public funds, thus restoring respect for the public service," he said, urging the House to endorse Majaliwa in the post.

In his remarks, Majaliwa said that the appointment has been a surprise as he wasn't expecting to be re-appointed.

"I am here as per God's will. I really appreciate President Magufuli for having high faith in me; I am so humbled by this trust. This is not a minor thing, I will work hard to prove right his faith in me and the nation at large," he said.

He vowed to serving the post well and deliver the best so as to achieve the goals that the government has set out in the coming years.

Speaker Ndugai hailed President Magufuli's decision to re-appoint Majaliwa as Prime Minister.

"I'm sure that through you, Tanzanians will benefit a lot. I assure you, premier, that the House is going to provide full support to achieve our goals," he declared.

A section of MPs also expressed their confidences in the reappointment of premier Majaliwa.

William Lukuvi (Ismani) commended President Magufuli for bringing back the hero to serve in the post

"Majaliwa has performed higher, contrary to what others were thinking of him. His performance in the first five years of the fifth phase government surprised many, we are ready to provide him close support," he said.

George Mkuchika (Newala Urban) described Majaliwa as having supervised and contributed immensely to transform the country and achieve its middle income status.

"I know Majaliwa very well. He is a good person, he implemented his duties fairly without discrimination inside and outside the legislagture. He spent hours and hours travelling all over the country to address people's problems; he has indeed done a wonderful job." he said.

Majaliwa made numerous efforts to ensure that farmers and livestock keepers reap big from the sector, he affirmed.

Salma Kikwete (Mchinga) urged MPs and the general public to support Majaliwa and thus enable him implement his duties well for the country's development.

David Silinde (Tunduma) said Majaliwa has proved to the legislature and the public that he can do the impossible.

The premier has been able to walk the talk and vision of President Magufuli thus bringing relief to people locked in various challenges that were chronic to Tanzanians for years, he stated.

"He is humble, faithful and a hard worker. I am sure that in the next five years he will prove to Tanzanians how good he is, in transforming the country's economy," he declared.

Majaliwa was first elected to the House in the 2010 general election from Ruangwa constituency. He was Deputy Minister of State in the Prime Minister's Office (Regional Administration and Local Governments) from 2010 to 2015.

In the 2015 general election, Majaliwa was reelected in Ruangwa, defeating Omari Makota of the Civic United Front (CUF) with 31,281 votes for the opponent's 25,536 votes.

After Dr Magufuli was sworn in, he nominated Majaliwa as Prime Minister on 19 November 2015.

Klain served as chief of staff to Biden from 2009 to 2011, the first few years of Biden's tenure as vice-president in the Obama White House.

He later served as President Obama's "Ebola czar" during a minor outbreak of the deadly disease in 2014.

The longstanding Democratic operative was also involved in both of Bill Clinton's presidential campaigns and was an adviser to John Kerry's failed White House run in 2004.

He has been a presidential debate coach for Bill Clinton, Al Gore, John Kerry, Barack Obama, Hillary Clinton and Joe Biden.

Meanwhile, Biden's transition team announced he had spoken with the

leaders of Australia, Japan and South Korea

All three are key US allies in the region, and the president-elect told Australia's Prime Minister Scott Morrison, Japan's Prime Minister Yoshihide Suga and President Moon Jae-in of South Korea that he wanted to deepen those ties.

Trump made security in the region particularly against a nucleararmed North Korea - a key feature of his presidency, holding historic meetings with its leader Kim Jongun. But he also clashed on occasion with traditional US allies in the area, including Australia. Trump infamously rang then-Australian Prime Minister Malcolm Turnbull at the start of 2017 over the fate of some 1,000 refugees a call Turnbull called "very frank and forthright".

OFFICIALS of the Tanzania Wildlife Management Authority (TAWA) have been urged to work diligently and refrain from corruption, which is a menace to conservation.

TAWA acting Commissioner for Conservation, Mabula Nyanda made the call here yesterday when wrapping up a four-day meeting of TAWA officials and heads of various reserve centres from across the country.

He said that the authority in collaboration with the Prevention and Combating of Corruption Bureau (PCCB) has been working hard to address corruption.

"We've mobilised our selfs to tackle the issue of corruption and began by holding to account heads of reserve centres who fail to submit reports

### of the said challenges on time," he said, noting: "It's shame for the big institutions like TAWA to be involved in issues of corruption."

Nyanda said following reported cases of corruption at various reserve centres, TAWA had taken various steps to unfaithful wardens, including dismissal, and had now started training all heads of the centres to educate their wardens as well. Between August 2018 and December 2019, fifteen staffs were taken to court over corruption allegations. They were from Maswa, Swagaswaga, Moyowosi, Rungwa/ Muhesi/Kizigo, Liparamba, and Selous Game Reserve and from Bunda and Manyoni anti-poaching units.

Work diligently and desist from corruption, TAWA staff advised "If you, as heads of a reserve centre do not report corruption under your

charge, and if we at headquarters come to know about it, we shall start with you, we are tired of dismissing those in the lower ranks," Nyanda said.

He however said that between July and October this year, the authority had trained 351 staffs with antipoaching skills and on corruption awareness

TAWA acting Assistant Commissioner for the south east zone Henock Msocha said they will make sure they enhance cooperation in the anti-poaching thrust including well utilising the knowledge they had received from the meeting on the issues mentioned.

# Angola ready for joint railway project with Tanzania, states envoy

THE government of Angola has said it is ready for engagement with Tanzania on planning and implementation of a railway project to link its port of Lobito to Dar es Salaam so as to boost trade between the two countries and create jobs for their citizens.

Angola's ambassador to Tanzania, Sandro De Oliveira, disclosed the plan at the occasion to mark the country's 45th independence anniversaries held in Dar es Salaam.

He said currently, the largest part of goods transportation takes place by for the users due to the bad roads, especially during the rainy season.

He said the referred railway corridor will connect the important ports of Lobito and of Dar es Salaam, allowing the transit of goods from and to the markets in America, Asia and Europe that utilise the Atlantic and Indian Oceans, respectively.

"Angola is ready to carry out at least two experimental trips, as soon as the logistical and institutional conditions are created, for which we count on Tanzania's collaboration in these efforts, "he said.

Oliveira hinted that Angolan economy has an enormous potential of underexplored natural resources in the sectors of agriculture and livestock, extractive and manufacturing industries, fishing, tourism, energy, water, transport, logistic, civil construction among others.

"We want to count on the Tanzania experience and investment in the aforementioned sectors which possess great feasibility and strong probabilities of profitable returns, thus supporting the creation of competitive domestic industries, "he stated.

# **Speaker saddened** seeing opposition parties' reluctance over Special Seats

THE National Assembly Speaker Job Ndugai has expressed dismay over the act of opposition political parties to boycott nominating their women members to legislative special seats saying it is against the constitution and limits efforts to enhance their rights.

Political parties that gain more than five per cent in the general election are required by the constitution and country laws to nominate female candidates to become Special Seats MPs. But speaking in the National Assembly here yesterday the Speaker said the political parties would have hurried to nominate their names if it was to include men in the nomination process

"We have parties that have not submitted the names of their MPs and are urging on social media and other platforms not to submit Special Seats lawmakers," he said shortly after the election of Deputy Speaker in which Dr Tulia Ackson was re-elected.

Dr Ackson who is the MP for Mbeya-Urban (CCM) was re-elected with 350 votes out of 354 valid votes counted. The Speaker said it was shocking and disgrace among the political parties to hold names of women who qualify to be Special Seats MPs.

"How do you prevent women from coming to defend the rights of fellow Tanzanians," he said. "This is unacceptable and does not qualify to be debated." Ndugai was explained that the nomination process was

an opportunity enshrined in the constitution.

He noted that whether the parties nominate or boycott it does not affect or limit the Parliament to proceed. On another development the

National Assembly Speaker said the parliamentary committees will be formed during the forthcoming parliamentary session, hoping the president will have completed naming the cabinet.

The parliamentary committees are expected to be formed based on the ministries set by the president.

"We have ongoing elections including getting representatives for the Southern African Development Community (SADC), the East African Community (EAC) and Great Lakes,' he said requesting MPs to explore the opportunities that come with the regional cooperation. "All this comes with the elective position," he added. The Parliament, however. cautioned MPs especially the newly elected first comers for unnecessary non-attendance of parliamentary proceedings, saying permanent and frequent absentees will be reported to their parties for further decision.

### RC warns officials against theft of farmers' cashews

COAST Regional Commissioner Evarist Ndikilo has warned top officials of cooperatives against embezzlement of cashew nuts belonging to farmers.

He said he would not like to hear the issue of cashew nuts loss due to wilting, and stern steps would be taken against those responsible.

The RC was speaking at the first

cashew nuts auction launched early this week in Kibiti District, saying he would not close his eyes to any official who would be involved in such kind of theft

He urged farmers to ensure they dry their crop including classification according to quality.

He said farmers will go on complaining about the market due to the poor quality crop they take to the

auction for sale.

At the auction, farmers agreed to sell grade 1 cashew nuts at 2,153/- per kg while grade 2 crop was transferred to another auction because they were not satisfied by the price offered by buyers of 1,400/- per kg.

Said Seif, one of the farmers said farmers cannot agree to sell their crop at 1,400/- claiming it was too low compared to the production costs they had incurred.

Earlier the Assistant District Administrative Secretary (Economy and Production) Shangwe Twamala said the auction planned to sell 2,073,293 kgs of the crop, are 55.9 per cent of all the cashew nuts collected by Agricultural Marketing Cooperative Societies (AMCOS)'

He said from the quantity, 512,786 kgs was grade 1 and 1,560,507 grade 2.

THE greater horn of the Africa region may not realize food and nutrition security for farmers and herders amid suppressed October to December rains, the Intergovernmental Authority on Development (IGAD) said in its latest weather forecast released on Wednesday.

According to IGAD, a drier than usual season linked to the La Nina phenomenon is expected in large swathes of the east and horn of the Africa region in the last quarter of this year, hence posing risk to crops and pasture for livestock.

"The drier than usual season might impact southern Ethiopia, northern and western Somalia, eastern and western regions of Kenya, northern

around the region," said IGAD.

"For farming communities, this could lead to poorer than usual harvests, due to reduced rainfall when crops are at the reproduction stage," it added.

The horn of African region is already battling multiple shocks like COVID-19, desert locust invasion, civil unrest and recurrent droughts that have undermined efforts to eradicate hunger and malnutrition.

IGAD said the drier than usual weather is likely to last till January, thereby complicating efforts to feed

Tanzania, and other sparse areas vulnerable demographics like children acute malnutrition among infants and the elderly.

> "The resulting poor nutrition status may reduce the immunity of all agegroups, further complicating the vulnerability to the possible effects of COVID-19," said IGAD.

> It singled out nomadic communities as likely to bear the brunt of suppressed rains amid shortage of pasture and water for their livestock that could lead to widespread hunger and skirmishes.

> "The overall poor food and nutrition security could increase the levels of

and young children. Atypical crossborder livestock migrations may spark resource-based conflicts," said IGAD. Statistics from IGAD indicate that currently, about 29.5 million people in the horn of African region are in urgent

need of food assistance due to the negative impact of climatic shocks and COVID-19 pandemic.

The bloc urged countries in the region to establish robust mitigation measures in order to avert a humanitarian crisis amid an extended drier than usual season.

The remarks were given by the UN projects coordinator in Tanzania Zlatan Milisic here this week at an evaluation meeting that brought together government officials and nations that sponsor refugees.

Projects under Kigoma joint project were established in 2017 and end in 2022 and aimed to help communities in issues of energy environment, economic and empowerment to various vulnerable groups, and tackle gender based violence and child abuse.

Others include girls' education, modern farming practices and looking for reliable markets, education against HIV/Aids and the importance of using clean and safe water. Milisic said the main responsibility

implemented. Kigoma Regional Commissioner Thobias Andengenye said the government will continue to offer cooperation to ensure the successful completion of the project.

An official from the Norwegian embassy in Tanzania Bjørn Midthun pledged his government will provide financial assistance towards the project.

Chlóe Horne, an official from the Irish embassy called on stakeholders to fully implement the project in order to benefit those targeted,

The project is expected to cost USD 63 million and so far money provided by donors totaled USD 30.6 million and two years remain before completion.

# **Tanzanians encouraged to value writing of wills**

### By Correspondent Sabato Kasika

DEPUTY Registrar of the High Court Devotha Kamuzora has encouraged Tanzanians to take up the culture of writing will, a document which expresses the wishes of a person after death.

The official made the call in Dar es Salaam yesterday when speaking at the seminar on inheritance Law and Will writingorganised by Tanzania Gender Networking Programme (TGNP).

The seminar was meant to educate participants on the importance of writing Will, taking into account that people have been associating Will with bad omen.

She said the society has an obligation in seeing that writing Will was their responsibility so that those who remain should oversee their implementation in accordance to the wishes of the deceased.

"Since every human being is on a journey towards death, it is better for one to prepare himself during lifetime so that after his death those left behind have security by avoiding unnecessary

conflicts among family members," Kamuzora stressed.

He said that was the time when document will become important as they enable to file an inheritance case as early as possible.

"There are two kinds of Will, verbal and written, but the written one should be given in front of not less than two witnesses, one family member and another from outside. It should be using indelible ink and the witnesses should be literate," she added.

She said the Will should be dated and bear the signature of the one writing it, and if he is illiterate he should put his right thumbprint.

On verbal Will, she said this should be given in front of not less than four witnesses, two of whom were close family members.

On the issue of the inheritance supervisor, she said when selected, he should ensure the family left behind does not come into any conflicts.

"The supervisor is not allowed, and it is against the law to grab the deceased's property, utilise them for his own or other people's benefit who are not knowledge on the subject.

inheritors or beneficiaries thereof," Kamuzora explained.

He said it was essential for the inheritance supervisor to be trustworthy and who must not be showing favour to any one among the inheritors.

She said for the society that respect justice and equality should not stick to customary and traditional considerations for classifying inheritance among the beneficiaries.

Selemani Bishagazi, seminar participant, from Information and Knowledge Centre in Kipunguni in Dar Salaam said there were some inheritance supervisors who have been disconcerting widows.

"You find a woman whose husband died, but the supervisor introduces sex corruption on promise that she can quickly help her to get her inheritance in court, this is not right," he said.

Fatuma Mapunda, another seminar participant said education on issues of inheritance should be provided in its entirety as some widows have been living in hard times for lack of legal

Undergo routine medical check-ups to curb diabetes, medical expert advises Tanzanians

A DAR ES SALAAM-based medical expert has called on the community members to help fight increasing levels of diabetes by going for routine checkups at the country's heath facilities

Director of Diagnosis and Nursing Services at Shree Hindu Mandal Hospital Dr Kishan Mistry made the call yesterday when speaking at free diabetes and hypertension screening as part of commemorating the World Diabetes Day, themed 'nurses and diabetes', highlighting the role of nurses in prevention and management of diabetes.

Dr Mistry said diabetes is a noncommunicable disease but is currently gaining momentum as most people do not monitor their eating habits especially when it comes to avoiding foods that cause the disease.

He said routine checks on sugar levels will help reduce the vice and that negligence over the disease can cause health complications.

THE public has been reminded to adhere to regular medical checkups to keep them free from Non Communicable Diseases (NCDs) which are reported to have increased causing deaths.

said that there were already He initiatives to control the burden of NCDs, noting: "There is a need to focus more on primary prevention at population level targeting interventions to reduce

healthy diets and physical activity."

He mentioned main risk factors for NCDs namely smoking, alcohol intake, unhealthy diet and low physical activity are prevalent in both rural and urban communities.

"NCD have an economic impact on the community since they take longer time and leave the patient and family bankrupt," he said.

According to him, diabetes and other NCD affect people of all ages adding that early diagnosis will help to control it.

Globally there is evidence of the growing burden of Non Communicable diseases (NCDs) especially in developing countries including Tanzania.

Historically, acute illnesses have been the most important health problems in sub-Saharan Africa (SSA). However, there is growing evidence that the particular that of NCDs, is increasing rapidly in the country.

The World Health Organization (WHO) estimates that deaths from NCDs in the African region will increase by 27 percent by the year 2030, which is 28 million additional deaths.

Calling for urgent action to prevent and control NCD. It highlights solutions to tackle the NCD epidemic and help deliver health for all.

In Tanzania, at least 31 percent of

exposure to tobacco, reduce alcohol all deaths have been associated with intake, reduce salt intake, promote NCDs, with the main killers identified as Cardiovascular Diseases at nine percent and Cancers at five percent.

According to latest estimates at Dar es Salaam Ocean Road Cancer Institute, Tanzania registers around 50,000 new cases of cancer every year.

But the country's largest cancer referral hospital can only handle 5,000 patients. Cancer is just a fraction of the burden of non-communicable diseases in the country.

Astrider Batista who was screened for diabetes and hypertension thanked for the free services.

She said after the screening, she was given medical advice on how to be free from diseases including using a healthy diet.

Philemon Matiko,a resident of Kinyerezi called on the community to go and test their body to diagnose if there are diseases at an early stage.

### Awareness key to ending harassment at workplace

Convention new and accompanying recommendation to combat violence and harassment in the world of work have been adopted by the International Labour Conference (ILC).

It is against this backdrop that representatives from government ministries responsible for gender and other stakeholders are meeting in Arusha to discuss measures on the first International Labour Organisation (ILO) labour standards that address violence and harassment at workplace.

Violence and Harassment The Convention, 2019, and Violence and Harassment Recommendation, 2019, were adopted by delegates on the final day of the Centenary International Labour Conference, in Geneva. For the Convention, 439 votes were cast in favour, seven against, with 30 abstentions. The Recommendation was passed with 397 votes in favour, 12 votes against and 44 abstentions.

The Convention recognises that violence and harassment in the world of work can constitute a human rights violation or abuse...is a threat to equal opportunities, is unacceptable and incompatible with decent work. It defines violence and harassment as behaviours, practices or threats that aim at, result in, or are likely to result in physical, psychological, sexual or economic harm. It reminds member states that they have a responsibility to promote a general environment of zero tolerance.

The new international labour standard aims to protect workers and employees, irrespective of their contractual status, and includes persons in training, interns and apprentices, workers whose employment has been terminated, volunteers, job seekers and job applicants. It recognises that individuals exercising the authority, duties or responsibilities of an employer can also be subjected to violence and

The new standards recognise the right of everyone to a world of work free from violence and harassment, according to

Guy Ryder, ILO Director-General The standard covers violence and harassment occurring in the workplace; places where a worker is paid, takes a rest or meal break, or uses sanitary, washing or changing facilities; during work-related trips, travel, training, events or social activities; work-related communications (including through information and communication technologies), in employer-provided accommodation; and when commuting to and from work. It also recognises that violence and harassment may involve third parties.

ILO Director-General Guy Ryder welcomed the adoption. "The new standards recognise the right of everyone to a world of work free from violence and harassment," he said. "The next step is to put these protections into practice, so that we create a better, safer, decent, working environment for women and men. I am sure that, given the co-operation and solidarity we have seen on this issue, and the public demand for action, we will see speedy and widespread ratifications and action to implement.'

Manuela Tomei, Director of the ILO's Work quality Department, said: " Without respect, there is no dignity at work, and, without dignity, there is no social justice. This is the first time that a Convention and Recommendation on violence and harassment in the world of work have been adopted. We now have an agreed definition of violence and harassment. We know what needs to be done to prevent and address it, and by whom. We hope these new standards will lead us into the future of work we want to see.

The Convention will enter into force 12 months after two member states have ratified it. The Recommendation, which is not legally binding, provides guidelines on how the Convention

# Rise of candida auris fungus attributed to global warming

fungus that grows as yeast. It is one of the few species of the genus Candida which cause candidiasis in humans. Often, candidiasis is acquired in hospitals by patients with weakened immune systems. It has attracted widespread attention because of its multiple drug resistance. Treatment is also complicated because it is easily misidentified as other Candida species.

Global warming may have played a pivotal role in the emergence of Candida auris, according to a new study. C. auris, which is often multi-drug resistant and is a serious public health threat, may be the first example of a new fungal disease emerging from climate change.

Scientists have a new theory about the origins of a dangerous, drugresistant fungus that can strike the sickest patients in hospitals and other facilities that provide long-term care: global warming.

The fungus, a type of yeast called candida auris, was discovered just 10 years ago in a Japanese patient with an ear infection. ( auris is Latin for ear. ) Since then, it has been diagnosed in patients around the world.

But candida auris didn't spread like a virus would, radiating out from one location. Instead, it popped up simultaneously in different parts of the world, including India, South Africa and South America.

"It was really mystifying that Candida auris appeared at the same time in three continents," said lead study author Dr. Arturo Casadevall, chair of the molecular microbiology and immunology department at the Johns Hopkins Bloomberg School of Public Health. Casadevall and his team thought the fungus's emergence must have been the result of some kind of change in the

ANDIDA auris is a species of Earth's environment – in this case, a gradual rise in temperature.

That's odd for fungi, which generally like ambient, cooler temperatures, like a cool forest floor where you might find a toadstool. Indeed, most fungal infections in people are found on the coolest parts of the human body, including the feet and in nail beds. The fungus tends to stay on the skin and doesn't cause an internal infection because it can't survive the warmer temperatures inside the body, where it is around 98 degrees Fahrenheit.

Candida auris is different. While it poses no threat to most healthy people, it can survive inside the bodies of very sick people with weakened immune systems and cause serious complications.

Casadevall's research involved what's called a phylogenetic analysis of C. auris and its closest relatives in the fungi world. The researchers compared different types of fungus related to C. auris, looking at whether each fungus could survive at higher temperatures. C. auris was the only one that was able to do it effectively.

The teams says it's evidence that fungi have begun to adapt to live at hotter temperatures. In theory, that makes them much more likely to make the jump from living on cooler skin, to warmer temperatures inside the body.

C. auris first showed up in the United States in 2016. Since then, the Centres for Disease Control and Prevention have recorded 716 cases of the infection.

Climate change has been implicated in other changes in disease-causing pathogens, especially bacteria that like to live in warm water, and the spread of mosquito-borne viruses such as Zika and West Nile. And a recent report from the CDC also suggested climate change has played a role in the emergence of drug-resistant fungal infections.

Now is the time we end the cycle. Africa requires fresh, young and able leadership without any ties to the liberation movements of the past. We acknowledge their contribution to our continent, but we now boldly proclaim it's time for a break with the past and a commitment to the future.

### A few thoughts on national unity and identity

HERE are many who refer to the amalgamation documents as if they tell us something about the unnatural nature of present day Nigeria. For me, the amalgamation document is simply a document of some historical interest. It doesn't say anything to me about whether Nigeria should or should not be one. Briefly put, these are my rough views. I invite other views from fellow countrymen and women.

The British declared a Southern Nigeria state. That was an artificial creation. It created a Lagos colony. That was an artificial creation. It merged the two into a Southern Nigeria. That was artificial. The British then merged a Southern Nigeria with a Northern Nigeria. That was artificial. I do not believe that the amalgamation of North and South Nigeria was any more artificial than the British grouping together of various groups into a Southern Nigeria.

There is a common misperception that there is such a thing as a natural nation as opposed to an artificial nation. There is no such thing as a natural nation in my mind. Differences

and commonalities are selected and defined and heightened by elites and leaders. If you look at virtually any country, you will see a history of differences and commonalities. Nigeria is no different.

Outstanding leadership brings together people by stressing commonalities and uniting with a vision and provide purpose that enables us all to move forward together. Italy was for 30 centuries plus fiercely antagonistic city states. Germany was a collection of Kingdoms. India was created by the British, uniting many kingdoms. Spain arose after the marriage of two people heading different kingdoms. China was not united until the 20th century.

The only country in the world that had a single tribe, a single religion was Somalia. It has become one of the worst examples of state failure. Somali leaders discovered and stressed new differences. They stressed clans within tribe and that became the dividing line. I believe that the search for a natural basis for the division of the country based on a common identity is a doomed exercise. Because identities are socially constructed. You can continue to subdivide ad infinitum. Agitation for state creation has shown this

My father used to tell me that when for centuries. The villages and towns he grew up he was told that he was a Bini man. He later on arrival at Kings College became a Westerner. (Western Region). He then became a Mid-Westerner in 1963. He was later renamed a Bendelite. His son Keem started as a Bendelite and then later became an Edo man. And now in his old age, he is a South South man. All these identities are fluid and made by men and women. I have decided to be a Nigerian and an African. I have no reason to question that choice. I have embraced it for all time.

My father used to tell me that even the words Igbo and Yoruba are relatively recent terms. He told me that when he was in Kings College, a man told you he was from Onitsha or Aba, and he referred to himself as an Easterner. He hardly referred to himself as Igbo man. Other friends would refer to themselves as Egbas or Ijebus, not as Yorubas. If we had a leader like Nkrumah, or Nyerere, or Nehru who stressed national commonalities, we would have made progress as a country. Instead, we had leaders who united the Ijebus and Egbas into Sons of Oduduwa. We had leaders who united the competing kingdoms of Bornu, Katsina, Zaria, Kano into a North. They had competed

of Onitsha and Aba were turned into an Igbo nation. They did not think on a large enough scale.

Our leaders in the 1940s and 1950s made choices. There was nothing natural about the decisions they took. The divisions they met were no greater than in Ghana, China, India, Tanzania or Uganda. They simply lacked a national or continental vision. We must not repeat their mistakes.

The failure of Nigeria is, for me, not so much a failure of structure but more of values and vision. The study of businesses and political systems confirms that values always outweigh structures as the determinant of success. My time in university over the last few years has led me to the same conclusion. That is why I am sceptical of the current rush for restructuring along lines of identity. Or ratherm a supposed common identity.

We should be able to have multiple identities and a common Nigerian identity. I do not think it is too late. In fact, I think that heading anywhere else is the beginning of a never ending set of subdivisions birthed and accompanied by violence until we become 20 or 30 Benin or Togo republics. Irrelevant. And still badly governed."

## Interrogating the responsibilities of education authorities to ensure schools are safe

30 January 2017, a Grade 12 learner attend-Geluksdal ing Secondary School in Brakpan on Gauteng's East Rand ran into a mobile classroom during break time to shelter from a heavy thunderstorm. As she entered the doorway, the 17-year-old touched the metal door frame and was electrocuted. She died on the scene.

This was not the first death or injury to occur in a school environment as a result of unsafe infrastructure.

Due to the apartheid system's underspending on, and neglect of, schools for black learners, South Africa has a substantial backlog in providing decent school infrastructure.

Unsafe and unlawful structures and neglected electrical equipment and sanitation facilities remain a persistent problem in schools across the country.

While our current government may have inherited a schooling system with poor and unsafe school infrastructure, it has nevertheless failed to adequately remedy this state of affairs for more than two decades.

Therefore, a fundamental question that needs to be asked is: What role do education officials have today in keeping learners free from harm while at school?

To what extent can authorities at various levels of the basic education system be held accountable for the deaths of learners like the girl at Geluksdal Secondary, or others, including Michael Komape, Enoch Mpianzi and Lumka Mkhethwa?

The continued lack of concern for pupil safety and neglect of school infrastructure are systemic problems for which structural redress is urgently required.

In the Supreme Court of Appeal's judgment on the case concerning the death of five-year-old Michael Komape, the court avoided the development of these questions by including grief as part of the family's claim for pain and suffering.

The teenager at Geluksdal Secondary died because the electrical equipment necessary for a safe environment circuit breakers, cables, earth leakage and distribution boxes - were repeatedly stolen or vandalised.

This meant that while mobile classrooms, like the one she sought shelter inside back in 2017, were provided with electricity for power and lighting, nothing was earthed and the distribution boxes (which help send electrical current to different points in the classroom) had no circuit breakers.

In this regard, regulations 4(3)(c) and 4(1)(b)(ii) of the Regulations Relating to Minimum Norms and Standards for Public School Infrastructure, published by the minister of basic education in 2013, state that the MEC must provide perimeter security within seven years of the publication of the regulations, by 29 November 2020.

In addition to this, the regulations indicate that every school site, including outbuildings and sporting and recreational facilities, must be surrounded by appropriate fencing, and that school buildings must have at least one safety and security measure in place, such as burglar proofing, a security guard or an alarm system.

In addition to these, Section 28(2) of the Constitution stipulates that the best interests of the child must be of paramount importance in every matter concerning the child, which includes all decisions taken by a school in relation to learner safety.

Significantly, the minister of basic education published regulations dedicated solely to safety measures in public schools, and which detail the steps these schools must take to address learner safety.

Notably, Regulation 8A(2) provides that a public school must take measures to ensure the safety of learners during any school activity.

SGBs have a statutory duty to en-

sure that schools are well maintained, repairs are attended to and security is provided. In particular, Section 20(1)(g) of the South African Schools Act states that the SGB of a public school must "administer and control the school's property, buildings and grounds occupied by the school, including school hostels, if applicable".

With regard to funding school maintenance and repairs, the National Norms and Standards for School Funding also state that funds received by school governing bodies from a provincial education department must, among others, be used for items including services relating to repairs and maintenance, as well as security

services.

This legislative and regulatory framework establishes that there is an obligation to keep learners safe from the dangers that arise from poor maintenance and the lack of security. When a learner's life is taken at school as a result of a wiring problem that could have been fixed, it signals a carelessness that violates every child's right to basic education.

We need to hold role players accountable for failing in their responsibilities to prevent senseless accidents and losses in the school environment, and to ensure that school infrastructure challenges are addressed in a sustainable way. DM

### Focus on forests key to survival amid pandemic

### ROME

WHILE the world grapples with the COVID-19 pandemic, forest loss is also an ongoing emergency that directly affects human survival, said a senior official of the Rome-based Food and Agriculture Organization of the United Nations (FAO) in a recent interview with Xinhua.

A call to focus on forests during a deadly global pandemic with devastating economic consequences may seem contradictory, but the opposite is true, according to FAO Forestry Division Director Mette Wilkie.

"There is a clear tendency to focus on the immediate needs in response to COVID-19: human health, food security, getting people back to work -- this is not surprising and of course these should be the primary concerns," Wilkie said.

However, she added, the pandemic is "providing an opportunity, where the wheels of the economy are turning much slower than normal, to design new pathways" to a sustainable future.

"We must make sure we don't repeat past mistakes, but build back better -and this means tackling the economic crisis, the climate change crisis and the biodiversity crisis all at the same time," Wilkie explained.

"Focusing on forests helps us do just

in forest restoration now makes sense on many levels because it creates jobs while mitigating climate change and preserving biodiversity -- all key actions on the path to the UN Sustainable Development Goals (SDGs).

Ultimately "societies worldwide will need to be convinced of the global restoration imperative by rational economic argument, compassion for current and future generations, and an emotional connection to nature," Wilkie said.

#### CHINA

The warning on forest loss also appeared in the latest edition of FAO's quarterly forestry publication Unasylva, which dedicates a chapter to China's successful reforestation efforts.

Titled "Restoring the Earth: the next decade," the new Unasylva edition points to China's successes in reforesting vast tracts of its national territory since the founding of the People's Republic of China in 1949.

Along with countries such as Costa Rica and Vietnam, China is one of a few countries to have reversed centuries of forest loss in recent decades, increasing its forest cover from 8.6 percent of the national land area in 1949 to 23 percent today.

Overall, between 1978 and 2015

that," she said, adding that investing China invested US\$378.5 billion in 16 major sustainability programs -- including reforestation -- across more than 600 million hectares, or about 62 percent of China's land area.

ALSO READ: Zoonoses a clear and present, growing danger

Wilkie pointed out that, according to data reported to FAO's Global Forest Resources Assessment (FRA 2020), China has been continuously increasing its forest cover -- from 152 million hectares in 1986 to 220 million hectares in 2020.

Much of this expansion has been driven by large-scale eco-forestry projects designed to control erosion and desertification, protect watersheds, reduce sediment in major rivers, and restore animal and plant habitats while increasing crop production and food security.

"China's success in reversing centuries of forest loss shows that largescale restoration is possible," according to the Unasylva report.

Among the reasons for that success is that "China had the political will at the highest levels -- including a strong, long-term commitment by the government -- plus the expertise and the human and financial resources" as well as a strong local community involvement, Wilkie explained.

### South Africa playing catch-up to secure access to Covid vaccines, including the Pfizer version

#### **By Adele Baleta**

HIS week's announcement of a breakthrough in development of a Covid-19 vaccine is "a massive development", according to Dr Essack Mitha, a clinical trial specialist whose team has helped with the clinical trials.

"It's very exciting, and the interim results are very promising. It leaves me with lots of hope as this could pave the way for a vaccine to be developed before the end of the year," says Mitha, owner of Newtown Clinical Research in Johannesburg.

Pfizer and BioNTech, a German company, announced this week that their vaccine candidate was successful in preventing symptomatic Covid-19 disease in the first interim analysis from the Phase 3 trial that includes 44,000 people across a range of countries.

While the news has been largely well received and global stock markets surged after the announcement, there has been some caution and criticism. There is consensus that more data is needed and some commentators have said the companies' announcement via press release (and not peerreviewed publication) is neither good scientific practice nor does it help to build public trust in vaccines.

#### Will South Africa have access?

Pfizer and BioNtech have said they will have 500 million doses of the vaccine available by end-December and 1.3 billion doses in early 2021. Several countries have already entered into deals with the manufacturers for access to the vaccine.

Thus far, South Africa has not secured doses of candidate vaccines from Pfizer or any other manufacturer.

The country also missed the first deadline to commit to Covax - an initiative co-lead by the World Health Organisation that aims to ensure developing countries get access to Covid-19 vaccines

Spokesman for the Department of Health, Popo Maja, confirmed South Africa had not concluded any vaccine deal, but added negotiations with manufacturers and Covax were underwav

Reuters news agency has reported that Botswana made an upfront payment to Covax this week, giving it the option to secure more than 940,000 doses of a Covid vaccine under a twodose regimen for 20% of its popula-

showed that individuals who received two injections of the vaccine three weeks apart experienced over 90% fewer cases of symptomatic Covid-19 than those who received a placebo (a dummy, usually salt water). Researchers have consistently cautioned that a vaccine might only be 60% or 70% effective.

Pfizer and BioNtech have so far analysed the data from 94 individuals who developed Covid-19 and the study will close with analysing data from 164 trial participants who develop the disease. The primary end point of the trial is not prevention of infection with SARS-CoV-2 but rather prevention of clinically recognisable disease (i.e. Covid-19).

#### There are still many unanswered questions.

Although there have not been major safety issues to date, the safety of the vaccine needs to be assessed continually and this would include during a Phase 4 study as well as with postmarketing surveillance.

It is not yet known if the vaccine works in elderly people, those with HIV, Hepatitis B and C infection and those with co-morbidities such as diabetes and hypertension.

It is also not yet known if a vaccinated person who has symptoms can spread it to others. It is also not known whether the vaccine equally protects against mild, moderate and severe cases of Covid-19.

The South African arm of the trial includes 800 participants at four sites in Johannesburg, Pretoria, Western Cape and Limpopo.

"I have so much pride for our teams in South Africa that have pulled together with this particular protocol," comments Mitha. "It has been very hectic over the last few weeks because timelines are short, but things like this make it all worthwhile."

South Africa joined the trial at the end of September, a month after the global study had started.

Mitha, who has been doing clinical trials since 2004, says he was hoping to recruit more than 800 participants.

"We completed our recruitment ahead of schedule hoping that the company would allow us more patients, but there were delays in our Department of Health approving additional numbers, which actually limited had queues of people lining up to take

tional Department of Health has no jurisdiction. "It does not give permission for trial participation."

Trial participants were given the first dose at the end of September and the second dose at the end of October. Mitha believes some data from early participants in South Africa were included in the interim data analysis presented this week.

The selection of South Africa as one of the global hosts of the study was based on local scientific expertise and capabilities, the epidemiology of the disease, and South Africa's prior experience in running clinical trials.

Mitha adds that other factors to include in the trial were that "we have a diverse genetic profile and a high prevalence of HIV, people with Hepatitis B and C infection and co-morbid diseases such as hypertension and diabetes".

### **Cold chain concerns**

A major concern is future distribution of the possible vaccine in low-income countries. The vaccine has to be transported and stored at an extreme temperature of minus 80 degrees Celsius.

"This does pose a challenge, but there is a flicker of optimism. These types of vaccines are able to be manipulated. us. It was sad, because at the end we It's likely that in the next few months the vaccine will be tweaked to make it more stable at different temperatures,"

"It is unlikely that the storage of the vaccine has been a priority until now because they first had to see if the vaccine works, but future development will look at making it accessible in terms of distribution."

#### The mRNA vaccine

The Pfizer/BioNTech vaccine is based on the genetic material mRNA (or messenger ribonucleic acid). The mRNA vaccines have a piece of genetic material that codes for viral proteins, or parts of them. Once inside the cells, the mRNA instructs the cells' protein factories to make copies of the viral proteins. These then stimulate the immune system to mount a protective immune response.

Hanekom savs interim results are also encouraging for most of the other candidate vaccines that want to induce similar kinds of immunity against the spike protein. ## **Disgraceful state of the nation's federal roads**

OR the sake of being polite and not using appropriately abusive language, the best way to describe the state of the nation's highways is to use words such as deplorable, terrible, awful, dreadful, shocking, lamentable, disgraceful, shameful and unpardonable.

If there is one single factor that indicates the imperative to restructure the nation's finances and politics and bring government closer to the people, it's the unpardonable state of the nation's federal road network.

It's unpardonable simply because the nation is structured in such a manner that the Executive and National Assembly allocate to themselves a disproportionate share of the budget, while serially failing to alleviate the suffering of ordinary citizens.

It simply doesn't make sense to expect anyone sitting down in Abuja to have any idea of the atrocious conditions of so called "federal roads" nationwide. What is worse is that in most states of the federation, these federal roads are the major roads, which the federal government has neither capacity, nor plan to repair, leaving citizens to suffer unconscionably.

The abysmal conditions of federal roads are a stain on the reputation of the Federal Road Maintenance Agency (FERMA). However, to be fair, FERMA officials have said time and again that the budget needed to maintain federal roads nationwide is approximately four times what is allocated. In 2020, they claimed they needed N125 Billion not the N36 Billion earmarked in the budget. For reasons best known to the federal government and officials of the Federal Ministry of Works, the cost of constructing and maintaining roads in Nigeria is Even if there are justifiable reasons for this



anomaly, federal government's excuse that there is no money for road maintenance is not tenable. An analogy is in order. Consider the case of a family man who insists on consuming two bottles of beer and fish-head pepper soup daily as his self-granted reward for being head of the family. If such a man claims he has no money to pay his children's school fees or his wife's hospital bill, would he not be called irresponsible? This is akin to the federal government's attitude towards providing for citizens welfare. They design lopsided budgets to ensure funds are available to maintain luxurious presidential jets to galivant all over the world, sometimes on unofficial jaunts, ensure there are fleets of brand new multi-million Naira exmuch higher than in other African countries. ecutive jeeps to carry assorted self-important political office holders to social functions

nationwide, and ensure there are private jets to carry governors and political godfathers around the country to attend their children's weddings. After this they take foreign loans to construct railway lines to other countries, and universities in rural areas which cannot boast of 100 qualified secondary school leavers annually. The truth is that the federal government has money; what political leaders lack is compassion towards mass suffering and a willingness to sacrifice their personal comfort for the public good. The African Development Bank's 2018 report on Nigeria's economic outlook stated that over 80 percent of the population lives on less than N1,000 per day. Yet in the 2020 budget, N2.5 billion was allocated for the President's local and international travels, and N98 million for catering and foodstuff supplies. Astoundingly, the budget for refreshments and meals in the Presidency is approximately N68,000 per day! The totally inappropriate budgeting at federal level is highlighted by the fact that total revenue cannot cover recurrent expenditure. Nevertheless, rather than tighten their belt, government is increasing its allocations to itself! In 2020, the National Assembly's budget was increased by N3 billion to N128 billion.

Despite this, there is also a budgetary provision for N36 billion to "renovate" their luxurious offices! In addition to government preferring to spend money on itself rather than on road maintenance and citizens' welfare, there are several other important reasons why Nigerian roads routinely fall into disrepair. Whenever the Minister of Works talks about the

rainy season, one would think that perhaps it's a new phenomenon. It isn't and should not be used as an excuse for the collapse of roads. The fact is that there are many nations worldwide in which it rains almost daily, yet their roads are in good shape. Cost cutting measures are allegedly standard practice when constructing Nigerian roads which are poorly designed without adequate drainage. Corruptly constructed at the cost of billions they were never designed to stand the test of time. Whereas in Germany, all roads are laid with a concrete base and are higher in the centre than the edge to ensure that water drains naturally off the road, Nigerian roads are flat ensuring that even the newest ones hold water and quickly develop potholes.

In addition to defective design, another important consideration is overloaded trailers. When Nigerian "Express Roads" were built, there were weighbridges which trailers had to pass through before commencing their journey. All that has gone by the wayside and anyone who travels by roads can testify to the carnage done by overloaded trailers.

They turn small potholes into large craters, and convert tarred roads into laterite swamps within no time. It seems nothing short of unwise if not foolhardy for government to even consider building new roads when existing ones are in such a state. US President Trump is loved by Nigerians simply because he says there is no country run by a black man which is an example of how to manage the nation's finances prudently and in a principled fashion to place citizens' welfare in the front-burner.

### British Fund to address climate change threat to cultural heritage in E. Africa

THE British Council's Cultural Protection Fund has awarded funding to five global heritage projects, which will use technology, skills development and community engagement to respond to the risk of climate change to heritage in East Africa.

Selected as part of the Cultural Protection Fund's Disaster and Climate Change Mitigation round, the projects will address the threat to valuable cultural heritage in Ethiopia, Kenya, Tanzania and Uganda by increasing capacity and resilience through risk planning, training programmes and digital innovation.

The fund continues a partnership between British Council and UK Government's Department for Digital, Culture, Media and Sport partnership to protect threatened heritage in and around the Middle East and Africa.

East African organisations and experts will partner with counterparts in the UK and Italy to support the exchange of knowledge and shared solidarity within the global heritage community.

A Greenpeace scientific report released yesterday reveals that extreme weather events such as heat waves, floods and intense rain are increasing in intensity, frequency and severity across many parts of Africa, gravely threatening human health, food security, peace, and biodiversity.

Weather across sub-Saharan Africa has become more extreme and unpredictable in the twenty-first century, a trend that climate scientists project will become more pronounced in future decades. This is the key finding confirmed by the comprehensive report published yesterday by Greenpeace Africa and the Greenpeace Science Unit.

The report 'Weathering the Storm: Extreme Weather and Climate Change in Africa explores the relationship between extreme weather events and climate change in Africa and summarises the scientific data on how the climate crisis is spiralling out of control across Africa, including irregular extreme heatwaves, floods, droughts and cyclones at a scale hitherto unknown. Climaterelated problems can often be disproportionately felt in the poorest communities because they are least equipped to cope with and adjust to changes.

"Science shows there is very little that is natural in the disasters striking our continent. A humanmade crisis requires a human-made solution. Africa is the cradle of humanity and it shall be the cradle of climate action for our future. Health, safety, peace and justice will not be achieved only through prayers and bags of rice and maize in the aftermath of a disaster. Only the one who preserves has no misfortune - and African leaders must declare a climate emergency to preserve our collective future," said Melita Steele, Greenpeace Africa Programme Director.

Key findings of the report include future average temperatures in Africa are projected to increase at a rate faster than the global average in all warming scenarios, the mean annual temperature increase for much of Africa is projected to exceed 2 or to fall within the range of 3 to 6 by the end of the twenty-first century if high emissions continue two to four times beyond the rise permitted in the Paris Agreement.

The rising temperature is likely to lead to deaths, displacement, climate-related conflict, irregular rainfall, drinking water shortages, and obstruction of agricultural production and accelerated extinction of endemic African species.

The frequency, intensity, and duration of extreme heat events are expected to increase, following trends already observed in Southern, East and Northern Africa.

Climate Scientist, founder of Black Women in Science and co-author of the report Ndoni Mcunu: "There needs to be better incorporation of indigenous knowledge in scientific evidence on extreme weather events in Africa.

"African countries need to be more involved in leading the development of new databases and models rather than being dependent on countries outside Africa. This will ensure better communication, planning and future projects of events. Access to information needs to be provided at a community level," he said.

Hindou Oumarou Ibrahim, Director of the Association for Indigenous Women and Peoples of Chad (AFPAT): "Over the last 50 years, we have already experienced a warming of 1.5C, well over the world average. In the Sahel, climate change destroyed our crops, our homes and tore families apart through forced migration."

'But Africa is not only the stage where the worst climate impacts will play out; it is a continent of millions of citizens determined to stop climate change, to move away from fossil fuels, who will stand up to protect our forests and our biodiversity from industrial agriculture."

### As long as we men turn a blind eye to the hyenas in our midst, the GBV plague will continue

"HAT are we men and boys doing to combat gender-based violence? Come on, rise up. Stop talking, singing and marching. Do something tangible. Call perpetrators out - at home, at work, church, school, and your social circle.

A protest action led by the Congress of South African Trade Unions (Cosatu) early in October highlighted once more the problem of gender-based violence (GBV) in South Africa. Narratives of the suffering of women in South Africa and the yearly escalation of GBV can make even a stone weep. In 2018, for example, the Crime Against Women in South Africa report by Statistics SA (Report No 03-40-05 of June 2018), showed that femicide in South Africa is five times higher than the global average.

In August 2019, the Constitutional Court in the case of Tshabalala versus the State heard of a group of heartless men who went on a late-night reign of terror in Umthambeka in Tembisa, which included the gang-raping of a visibly pregnant woman and a 14-year-old girl. Justice Rammaka Mathopo noted in this case that women in South Africa have been relegated to second-class citizens through acts of GBV, by men who think they are entitled to have control over women and who suffer from "the social construction of masculinity in South Africa".

As a man, husband, father, brother and uncle of dandelions, I am lost for words in writing about GBV. Luckily I have found a solution by troubleshooting my writer's block through musical lyrics to write this opinion dedicated to women and children in South Africa suffering from GBV.

Normally, the perception - and rightly so - is that men just stand by as attacks on human rights, life and limb, and bodily integrity take place. Murders, abusers, rapists, paedophiles and other perpetrators of GBV thrive in contexts of complacency, disregard for the rule of law, continuing discriminatory practices, other occupational segregation practices, and the use of women's suffering for political expediency. Those close to women have been their deadliest predators. Every protest in South Africa is marked by people singing their lungs out and followed by little or no action at all.

Why not express my continuing contribution to the movement against GBV with reference to musical tapestry? As eloquently said by the late Busi Mhlongo in her song ukuThula, "Bantu bakith' kumnand' uk'hlala ngok'thul' ezweni". (My people, "people of our land", it's nice to live in peace in our nation.) However, living in peace will never be nice if made the preserve of men only. Women deserve peace too. "Nom' ungang'bulala ngek' uwathol' amandl' ami. ...Kumnandi ukuhlala ngokuthula." (...It's nice to live in peace.) Women have the right to live in peace and harmony too. As the legendary Caiphus Semenya said: "Woman got a right to be."

The strength of our sisters, mothers and grandmothers who are gruesomely killed at the hands of men does not have to be gone with the wind. It is for us as a society to take it into our hearts and continue the fight against GBV. The lyrics of Mhlongo's song further say: "Noma ungangibulala ngeke uwathole amandle ami." (Though you may kill me, vou will never gain my strength.) This truth is explicated by Siphokazi in her song Ubuntu Bam (meaning, My Humanity), which should be shared with every man and boy, particularly the lyrics that: "My humanity is in my rhythm, my view of life and nature can't be taken away. It's engraved in my soul." Another lyrical masterpiece by Mhlongo, "We Baba Omncane" (meaning, father's younger brother ["small father" or uncle]) illustrates what women and children have to go through for the rest of their lives. They are chased from their homes, with no good reason. "We bab'omncane, Wang'xosha kabuhlung" (You chased me away so sorely.) "Kodwa yini na?" (What's the matter?/But what is it?) The 



children call uncles or "small fathers" is far from exemplary of what being a father means.

We are a society with the hyena-like behaviour of men steeped in the culture of patriarchal behaviour. A society where girl children are subjected almost daily to every imaginable form of GBV, including rape, femicide, sexual discrimination, sexual harassment, sexual abuse and sexual exploitation. A non-profit organisation called Matla A Bana - A Voice Against Child Abuse once estimated that 50% of South Africa's children will be abused before the age of 18 and that 85% of them will be by perpetrators known to them. Matla A Bana reports that every three minutes a child is raped in South Africa, most being girls between three and 12 years of age, and by men known to them.

Nobody can deny the truth in Siphokazi's 2007 song Amacala, that women always have to explain themselves nonstop ("Seng' thetha amacala ekuze kuse"), so much so that her home has turned into a courtroom ("Usephenduk' inkantolo umuzi wam"), and she has no way but to go back home ("Ndibuyel' ekhaya"). Unfortunately, a society that is ready to always excuse GBV will mock and shun a woman as a "returnee" when in fact her parents' house should be her fortress. The scourge of GBV in South Africa has been highlighted over many years, but it is not abating. Although we recognise the need to do something to safeguard the rights of women and children and eradicate the harms and dangers they are faced with daily, our efforts are often meaningless. We are like empty tins making the loudest of noise and promises, but carrying nothing to show for it. In Africa, the elephant in the room is the endless promises that things are about to change, and governments not delivering on their promises to end behaviour of men, particularly those whom girl GBV. Can we trust what we are being told by gov-

ernments across Africa to end or combat GBV? I do not have an answer to this question. However, I am inclined to borrow from the lyrical prowess of the late Brenda Fassie in her song Promises, when the Queen of Pop sang: "Standing back I can't believe how you've led me on... Your promises have never been anything you made them seem."

You will pardon me using the lyrics of musical greats to drive my point home. I love music that is lyrically meaningful, and listening to the likes of women such as Busi Mhlongo, Brenda Fassie, Miriam Makeba, Siphokazi, and other contemporary artists such as Kanyi Mavi is listening to artists who sang back at GBV.

I also marvel at the artistic creations of women who depict in some way women suffering, including artists like Lungiswa Gqunta who has the audacity to tackle issues of the postcolonial cultural landscape regarding inequality and patriarchy; Zanele Muholi, whose portraits form an important part of the discourse on black lesbian, gay, transgender and intersex people; and the fabulous holder of The Order of Ikhamanga in Silver, Dr Esther Mahlangu, one of whose works adorns the walls of a New York boulevard. In the same way, music and other artistic creations can plant the seeds of negative attitudes towards women and children, it is through music that we can start challenging the widely held attitudes and beliefs that provide fertile germination ground for GBV. Young artists like Líricas del Caos, a feminist rap group from Colombia, have succeeded in promoting a hip-hop scene free of sexist violence and profanities against women through the composition of anti-patriarchal lyrics. As did the musical offering of Andy Mkosi following the rape and murder of another dandelion, Uyinene Mrwetyana in 2019. The Minister in the Presidency for Women, Youth and Persons with Disabilities, Maite Nkoana-Mashabane, officially launched the 365 Days of Activism against Gender-Based Violence and Femicide (GBVF) on 10 December 2019 in part-

nership with UN Women and First for Women Insurance. At the time the minister uttered comforting words, giving a commitment that "enough is enough" and that "together, we need to play our part, not just for 16 days but for 365 days a year, every year".

On a different perspective, I am reminded of a colleague who said to me that society is always willing to excuse the predatory behaviour of men. And further, that the plight of women and children has been worsened by having to work from home amid Covid-19 with the general workplace protections and basic conditions of work not equally extended to the "work-from-home" environment. What has the government done to ensure that working from home is not a GBV trap for many women?

What I know is that governments have a much bigger role to play in the fight against GBV. In 2013 the World Health Organisation reported that about 35% of women worldwide had experienced GBV in their lifetimes, and that the highest proportion of GBV incidents happened in Africa.

This brings me to my next point: the African Union must lead the continental fight against GBV. Already there are best practices continentally and globally that have paved the way for something to be done. For instance, the International Labour Organisation (ILO) on its 100th anniversary on 21 June 2019 adopted the first legally binding Violence and Harassment Convention. Notable is that article 4(2) of the convention states that, "Each Member shall adopt, in accordance with national law and circumstances and in consultation with representative employers' and workers' organisations, an inclusive, integrated and gender-responsive approach for the prevention and elimination of violence and harassment in the world of work."

The ILO took this bold step to answer the call by millions of women around the world to be protected from the sharp claws of GBV in the workplace, and so should African governments and the AU take the lead.

What are we men and boys doing to combat GBV? In the words of Minister Nkoana-Mashabane:

"Men can do this by calling out other men who insult, denigrate, abuse, or treat women like objects."

Having started and pitched this opinion against the backdrop of some lyrical foundations by some of the best musicians of all time, I should conclude with the call to men taken from the song My City of Ruins by Bruce Springsteen and The E Street Band - "My city of ruins. Dear men and boys, come on, rise up" against GBV. Stop talking, singing and marching. Do something tangible. Call perpetrators out. You know who they are - at home, at work, church, school, and your social circle. ### A seven-point plan to increase revenue for Indian news publishers

#### **By Elizabeth Shilpa**

"OVER the last ten years, pre-Covid, the time spent on digital consumption went up by ten per cent. Print and radio have continued to decline in terms of consumption and advertising spend. We see it likely to continue.'

This is according to Nithin Chandalia, Managing Director and partner at Boston Consulting Group India.

Chandalia made these remarks when taking part in a discussion with Krishna Prasad, former editor at Outlook magazine, during WAN-IFRA's (World Association of Newspapers) recent Indian Media Leaders eSummit.

Likewise, substantial growth in digital media spend during the past decade underscores the need for news media organisations to ratchet up the digital portion of their revenues, Chandalia said.

Globally, for media organisations, one-third of their revenue comes from advertising. In India, however, this has been about two-

During the coronavirus pandemic, overall advertising budgets have dropped drastically. Despite some signs of economic revival, sectors such as tourism, hospitality and retail, all of which contribute significantly to print, continue to struggle. This calls for a rethink of news publishing business models.

thirds.

#### A plan for digital growth

According to Chandalia, digital in India is expected to grow close to three times in the next five years - and Covid-19 is expediting this. Most news media players in India today operate in digital, but the size of their digital business is fairly small.

"The one thing each player has to look at is 'How do you drive the digital part of the revenue up across different formats?" he said, offering a seven-point agenda for future operating models for news publishers.

One: Put your audience first. Almost 75 per cent of a publisher's revenue should come from sub-



scribers and readers for a sustainable future. That means that you have to put your reader at the centre of your business. Two: Transform advertising

sales. Create an efficient advertising sales organisation. Media sales organisations have worked in very different formats. Between ing. 2005 and 2015, when advertising

growth was just beginning, advertisers often came to publishers.

Today, like the audience, the advertiser is also a stakeholder. Publishers, therefore, need to think of how to create products that drive more outcome-oriented pricing instead of mere display advertis-

Three: Investing in marketing

technology. Many global players, in the move to performance-driven marketing, have invested in creating digital assets and capabilities. These are meant to help them leverage not just the print reach but also the reach of the digital business to help boost performance-driven marketing and performance-driven advertising solutions.

Build scale quickly through alliance. Google and Facebook are the two stalwarts in the digital marketing space and everyone else is a minor player compared to them. So how do you compete in this space?

There has been a lot of talk about creating alliances and joint go-to-market platforms where publishers can come together, offer the inventory and get a fair price. In Europe, some publisher alliances have been able to create a reach that is equal to the big platforms within their markets.

Four: Cost optimisation. The cost optimisation cannot be just incremental; rather, the entire cost structure needs to be rethought.

Five: Accelerate to consumer pay models. In India, most readers refrain from paying for content from Indian news media, but at the same time many consumers will pay for subscriptions to international publications, such as The New York Times. So publishers need to think about how to get

readers to pay by providing them differentiated quality content.

Six: Leveraging analytics. Use insights and analytics to understand how to make news more relevant for readers and drive engagement.

Chandalia noted that, globally, consumers have been demonstrating a greater willingness to pay for content. "Whether it's about news, OTT, Pay TV, consumers have shown an appetite to pay for content," he said.

He added: "And wherever that has happened it has been through differentiated content which is driven and led by a point of view, and offering a unique perspective to the reader."

According to him, whether it is through digital or print, publishers need to make reader revenue the main share of their revenue mix. "Companies that get to that point faster will be the ones that would be able to operate profitably and survive not just the pandemic, but the long run," he noted

# EQUITY BANK PARTNERS ZOLA TO LIGHT UP 8M HOMES WITH SOLAR POWER

OME eight million people who have no access to national power grid in the country will be connected to off-grid solar power thanks to a partnership forged by Equity Bank Tanzania and Zola Electric.

Announcing the partnership in Dar es Salaam earlier this week, Equity Bank Managing Director, Robert Kiboti said under the deal, the families will access Zola's solar power system devices at affordable prices of between 332,000/- and 2m/-.

"Today we are here to announce partnership between Zola and Equity Bank that aims to facilitate Tanzanians acquire solar system for domestic use at very affordable price and to contribute to solving the energy deficit sustainably," said Kiboti.

He pointed out that by investing in solar energy system, the public will avert the likelihood of outages associated with the national grid-tied system while depending on professionals and use particular infrastructures to make use sun generated electricity.

The Equity Bank chief further noted that investment in Zola Electric's solar energy system is a onetime cost for customers because the production relies only on sunshine to generate energy for a household without paying any

"With this partnership between Equity Bank and Zola, Equity Bank will provide a loan to eligible customers to purchase the solar system and be installed at their homes immediately after Equity pays Zola," Kiboti added.

Speaking at the same event, Zola Electric East Africa's Managing Director, Johnson Kiwango said their research into major challenges facing off-grid rural families in accessing solar energy established that financing is paramount.

"This agreement with Equity will ensure that the majority low income families in off grid areas get genuine Zola solar products at

affordable prices," said Kiwango who noted that because of lack of financing, most consumers buy cheap fake solar systems.

He said his company has enough supplies of solar products and manpower to enable quick installation arguing that solar power will help wean rural based families from using fossil fuels including kerosene and firewood.

"We know that many rural areas have no access to electricity and hope to work with government agencies to ensure that such areas get solar power access," the Zola EA chief added while stressing that apart from lighting rural homes, solar power will also allow rural folks start businesses to generate income.

### Petra Diamonds investigates charges Tanzanian subsistence miners abused

### DAR ES SALAAM

PETRA Diamonds said it was investigating allegations by a British non-governmental organisation that subsistence miners who trespassed on the firm's Williamson mine in Tanzania were detained, beaten and shot at, with at least seven of them killed.

The RAID report, based on research conducted between September 2019 and November 2020, alleged that security contractors and security employees of Petra's subsidiary Williamson Diamonds Limited (WDL) used excessive force.

Petra Diamonds told Reuters a specialist external adviser was conducting an investigation and said an external consultancy had been appointed to assess WDL's management of its security. "The board of Petra Diamonds finds the allegations of human rights abuses at the Williamson mine in Tanzania to be deeply concerning and is taking the matter extremely seriously," said support services manager, an interim measure taken "whether or not there is any substance in the allegations", Petra Chief Executive Richard Duffy said in a letter to RAID dated October 13.

In its report, RAID said it had "found evidence indicating that since Petra Diamonds acquired the Williamson Mine in 2009, there have been at least seven killings and 41 assaults of local residents, many leading to life-changing injuries." Zenith Security Services Ltd, the security contractor named in the report, did not respond to a Reuters request via email for comment.

The allegations highlight tensions caused when mining companies co-exist with communities who rely on subsistence mining to supplement their income, as in other parts of Tanzania and across resource-rich countries in Africa.

Subsistence or "artisanal" miners, who typically use

It said the investigation would be completed by the end of 2020. Simon Msanjila, a permanent secretary at Tanzania's Ministry of Minerals, told Reuters he had not seen the RAID report and could not comment on it.

WDL has suspended the mine chief security officer and the

rudimentary techniques, number around 40 million worldwide, according to a 2019 estimate by Delve, an artisanal mining database. Britain-based law firm Leigh Day had filed a claim in the High Court of England and Wales in September on behalf of more than 30 Tanzanians who alleged "abuse breaches of human rights at the Williamson mine," Petra previously said. The Williamson mine, active since 1940, is in Shinyanga, one

### Joy in Nairobi as plan to uproot iconic fig tree abandoned

#### NAIROBI

ENVIRONMENTAL activists in Kenya have hailed an official decision to save an iconic, century-old fig tree from being taken down to make way for a highway in the capital, Nairobi.

A decree issued by President Uhuru Kenyatta described the famed tree the height of a four-storey building - as a "beacon of Kenya's cultural and ecological heritage." Kenya's roads agency had said in October that it planned to uproot and transplant the fig tree in order to erect a pillar to support the Chinese-funded expressway built to reduce traffic jams. In response, environmentalists launched a campaign to protect the tree, which stands on Waiyaki Way in the west of the city, where engineers are building the expressway above the existing road on pillars.

"We did it!" Elizabeth Wathuti, a prominent environmental activist and head of campaigns at the Wangari Maathai Foundation, wrote on Twitter on Wednesday after the issuing of the declaration. "We'll keep doing it for all green spaces!" Activism works! We did it! We'll keep doing it for all green spaces!

The tree will be adopted by the NMS on behalf of the city's residents and both the China Road and Bridge Corporation and the Kenya National Highways Authority have agreed to

reroute the road. The tree will now stand as a sign of the city's aspirations, added Wathuti. "This particular fig tree is just a symbol of the bigger picture of what we are asking for," she said. "We want a green and clean city, and clean Kenya."

### ArcelorMittal SA says it's addressing a crippling shortage of steel products

### JOHANNESBURG

JSE-listed steel producer ArcelorMittal South Africa is implementing a number of measures to address the critical shortage of steel products, which has severely negatively impacted the building and construction and manufacturing sectors.

ArcelorMittal SA group manager stakeholder engagement and communications Tami Didiza said the company aims to significantly reduce the temporary supply backlogs during December, which is traditionally a quieter period for the industry.

He added that the company's second blast furnace in Vanderbijlpark will be restarted in December and, with all three of its furnaces fully operational from January 2021, ArcelorMittal South Africa "will be able to meet more than the steel requirements in South Africa and neighbouring countries." He confirmed that ArcelorMittal SA is experiencing temporary backlogs in supply, adding that a range of flat and long products are in short supply locally and globally from most steel mills.

Lockdown and 'other factors' to blame

These shortages are attributed to almost three months of lockdown-related disrupted production and "other temporary production delays caused by external factors".

"There are increased lead times for the supply from steel mills around the world, with most mills now quoting delivery in Q1 of 2021 or for some specific products even into Q2 of 2021. "Similar shortages are [being] experienced in many other industries and ArcelorMittal South Africa is also battling to receive certain input material," he said.

Didiza added that the company ceased operations at all its blast furnaces as required by the Covid-19 lockdown regulations and completely stopped production "for the first time in the history of the integrated steel industry in the country." This resulted in an abrupt disruption in the entire steel supply chain, the effects of which the company is progressively addressing, he said.

Didiza said the lockdown also resulted in depleted inventories at every stage of the supply chain and Arcelor-

His Majesty the King thus gave instructions to the competent authorities to ensure the proper preparation and the smooth running of the large-scale national operation as part of the fight against Covid-19.

Morocco managed to secure the supply of vaccine against the Covid-19 thanks to the King's personal involvement with the country taking part in clinical trials of the vaccine candidate developed by Sinopharm's China National Biotec Group (CNBG), which has agreed to provide with 10 million doses before the end of the year if results are positive.

Health minister Khalid Ait Taleb told parliament last week the imminent arrival of a COVID-19 vaccine in December. "All the available information we have tells us that a promising vaccine is expected towards the end of 2020 after reaching advanced stages of development," Ait Taleb told lawmakers.

# Malawi abandons Shire-Zambezi waterway project

MALAWI has dropped its proposal to use the rivers Shire and Zambezi for its imports and exports, according to a report in the Maputo daily "Noticias."

The decision follows a recent understanding between Mozambican President Filipe Nyusi and his Malawian counterpart, Lazarus Chakwera, on facilitating increased use of the Mozambican port and rail systems for Malawian trade.

The project to use the rivers was the brainchild of a previous Malawian President, Bingu wa Mutharika, who considered the "Shire-Zambezi Waterway" as key to lowering transport costs to the Indian Ocean.

Malawi even went as far as building a port at Nsanje, on the Shire, at a cost of twenty million US dollars. In October 2010 it actually held an inauguration ceremony attended by VIPs, including the then President of Zimbabwe, Robert Mugabe, and Zambia's for-

mer president Rupiah Banda. But Mutharika had not bothered to consult Mozambique, through whose territory the two rivers run. So the launch of the Nsanje inland port became a huge embarrassment when the Mozambican authorities blocked fertilizer laden barges that were en route to the ceremony.

The whole scenario was bizarre as the Mozambican government has always been crystal clear that its waterways can only be used after the correct steps have been taken, which include environmental impact assessments.

At the time, the then president of Mozambique, Armando Guebuza, explained that, while he understood Malawi's desire to use the two rivers for its trade, that could only happen after viability and environmental studies.

These were undertaken - and showed that the Malawian proposal would have enormous environmental costs, particularly because it implied continually dredging the Zambezi. In 2015, the then Mozambican Transport Minister, Carlos Mesquita, pointed out "Mozambique would need to spend 100 million dollars to dredge the Zambezi and deepen the waters. This is not economically viable."

The need for the Shire-Zambezi Waterway was always highly questionable, since all of Malawi's trade can be handled comfortably by the Mozambican ports of Beira and Nacala and the railways that connect them to Malawi. The new Malawian government seems to have come to terms with this reality, and accepts that the Mozambican ports are quite capable of dealing with Malawian exports and imports.

Nacala is generally regarded as the best deep water port on the east African coast, and its broad access channel never requires dredging. The Mozambican authorities assured their Malawian counterparts that they will continue the programme to rehabilitate and modernise Nacala, costed at around 300 million US dollars. This will raise the handling capacity of the port from 100,000 to 250,000 containers a year.

### **Investcorp sells US residential** property for over \$900 million

#### ABU DHABI

Bahrain-listed private equity and alternative asset manager Investcorp said on Tuesday it sold eight multifamily properties in the US to multiple buyers for more than \$900 million. The garden and townhome-style apartment buildings were located in major metropolitan areas in Arizona, California, Florida and New York, Investcorp said.

### Heathrow calls for judicial review of UK'S decision to do away with tax-free shopping

### LONDON

HEATHROW, Britain's biggest airport, is preparing a legal challenge against the government's decision to scrap VAT-free shopping for international tourists on goods such as perfume, clothes and electronics.

In a letter to UK finance minister Rishi Sunak from Heathrow's chief executive John Holland Kaye, cosigned by tax refund specialist Global Blue and the World Duty Free Group, the airport said it wants a judicial review of the decision to abolish the VAT Retail Export Scheme and withdraw airside tax-free shopping in all UK airports at the end of this year.

The move, which comes as the aviation and retail industries are already struggling amid a second Covid-19 lockdown, would cause "irreparable and unnecessary damage to high streets and airports across the UK."

"We believe there are solutions available that can address concerns, while protecting the UK's competitiveness as a shopping destination and airport retail in a year that will be so critical as it recovers from the worst year in history," the claimants involved said, in a joint statement sent to The National. "All are responsible for employing thousands of people and securing billions of inward spend each year. We are exploring all options available to us on this decision."

In September, the government said tax-free shopping would end for all visitors to the UK after the end of the Brexit transition period on December 31. The move will prevent non-EU visitors from receiving a VAT refund on items they buy in Britain and take home in their luggage. It will also stop tax-free sales on goods such as clothes, electronics and perfumes bought at airports. VAT stands at 20 per cent.

Industry bodies had expected the government to extend the scheme to include EU nationals once the Brexit process was completed. Now they fear

that wealthy Middle East and Chinese travellers will be discouraged from flying into the UK to shop once the tax rebates are abolished.

"In this consultation period the Government stated in March that "following the transition period, the UK is minded to extend airside tax-free sales to those travelling to the EU," John Holland Kaye said in the letter.

"We were therefore deeply shocked and concerned to learn that the Government will instead withdraw tax-free shopping altogether, making the UK the only country in Europe not to offer such a benefit to international visitors."

In September, the government said the post-Brexit changes would also bring benefits, with EU passengers travelling from the UK able to buy alcohol and tobacco without paying VAT and excise duty once they have passed through security controls.

It said overseas visitors would still be able buy VATitems in stores and have them sent directly to their overseas addresses. With less than 10 per cent of non-EU visitors to the UK using the VAT refund shopping scheme, extending the scheme to EU visitors could cost up to £1.4bn (\$1.8bn) a year, according to HM Treasury.

In the letter, Mr Holland Kaye said the government was yet to publish a comprehensive economic impact assessment of its decision, and said the Treasury had "failed to take in to account a second wave which has plummeted millions more into lockdown and unable to work as hotels, 'nonessential' retail and tourism numbers remain decimated."

"Coupled with slow progress behind a testing regime that will facilitate safe tourism into the UK, and no meaningful recovery plan for struggling sectors, this decision will put us on the back foot as the world looks on post-Brexit," he wrote.

Last month, UK retailers, hoteliers and airports said scrapping VAT-free shopping would put 70,000 jobs at risk and trigger a £10bn reduction to spending in British stores and cost the UK finance ministry £2bn in lost tax revenue. Mr Holland Kaye's letter said a further 25,000 UK jobs reliant on tourism spend, such as positions in theatres, restaurants and hotels, would also be put at risk from the move.

"It is not too later for the government to review this decision," Mr Holland Kaye said. Heathrow was overtaken as Europe's busiest airport for the first time by Paris Charles de Gaulle late last month, amid falling air travel demand during Covid-19, as almost 200 airports in the continent face going bust by the end of the year, according to ACI Europe.

Retail executives including leaders from Fortnum & Mason, Ted Baker and Paul Smith said last month that the tax changes would encourage tourists to "spend their money in Paris, Milan or Madrid" rather than Britain.

### Airbnb to reveal its financials next Thursday - ahead of IPO

### **NEW YORK**

AIRBNB is opening its books as soon as next Thursday ahead of a much-anticipated initial public offering, according to people with knowledge of the matter.

The home-rental start-up, which said in August it filed confidentially for a listing with the US Securities and Exchange Commission, will show the public the listing documents and its financial information for the first time as it seeks to woo investors. Airbnb is aiming to raise as much as \$3 billion in an IPO before year end, Bloomberg has reported. Timing of the IPO filing could still change, said the people, who declined to be named discussing private information.

Airbnb's listing will come in a tight window for public debuts during an eventful year. Covid-19 has led companies to think twice before tapping the market, while the holiday calendar in the remainder of the year means there is a shorter time frame to get deals done. A representative for Airbnb declined to comment. Reuters earlier reported on the filing coming next week.

While Airbnb had been sending incremental updates to the market signalling its debut is on the way, such as announcing that it has chosen Nasdag Global Select Market to host its listing, the public filing will serve as the key milestone. It will be allowed to start taking orders for shares from investors 15 days after the documents are available.

The San Francisco-based company was valued at \$18bn in April when it raised \$2bn in debt from investors at the depth of the pandemic. That was a significant drop from its earlier peak valuation of \$31bn in a 2017 fundraising round.

A quicker-than-expected rebound from the pandemic has brought the company's valuation back to \$22bn at end of September, based on the value of its common shares at a recent stock split, **Bloomberg News reported.**

### **Biden reassures US allies in** calls with leaders of Japan, South Korea, Australia

### SEOUL/TOKYO/WILMINGTON, Del

IN their first calls with Joe Biden since the U.S. election, the leaders of Japan, South Korea and Australia vesterday reaffirmed plans to form close ties with the president-elect to tackle issues including climate change and regional security.

The three key Asian allies - Japanese Prime Minister Yoshihide Suga, South Korean President Moon Jae-in and Australian Prime Minister Scott Morrison - join other global leaders in recognizing the Democratic challenger's Nov. 3 victory over incumbent Donald Trump, who has so far refused to concede.

Biden's projected win comes against a backdrop of China's growing military and economic assertiveness in the region, and after years of sometimes tumultuous relations between Asian allies and the United States under Trump over issues including trade, defence and the environment.

All sides expressed their determination to strengthen bilateral ties as well as tackle global issues such as the coronavirus pandemic and climate change, Biden's office said.

Biden by telephone and confirmed the importance of bilateral ties.

"President-elect Biden said that he looks forward to strengthening the U.S.-Japan alliance and working together on achieving a free and open Indo-Pacific," Suga said to reporters, in separate comments made at the Prime Minister's Office.

Biden had earlier spoken to the leaders of Germany, the UK, Canada and France, but China and Russia have so far held off passing on their congratulations and speaking with the President-elect.

### SECURITY AND PROSPERITY

Biden on Wednesday named Ron Klain as his White House chief of staff, his first major appointment as he builds his administration. Anthony Blinken, a diplomat and longtime confidant of Biden is seen as a likely pick for Secretary of State or National Security Adviser, both key roles for Asian allies.

Speaking to South Korea's Moon, Biden reaffirmed the U.S. commitment to defend South Korea, high-Japan's Suga said he spoke with Indo-Pacific region," Moon's spokes- sula.

"President Moon asked for close cooperation for the forward-looking development of the bilateral alliance, and the denuclearisation and peace on the Korean peninsula," Kang told a briefing. "President-elect Biden said he would closely cooperate to resolve the North Korean nuclear issue."

Trump and North Korean leader Kim Jong Un vowed to work towards denuclearisation at their unprecedented summit in 2018, but little progress has been made since their second summit and working-level talks collapsed last vear.

While Biden has said he would not meet with Kim without preconditions, he has also said he would embrace "principled diplomacy" with North Korea.

South Korean officials are also hopeful that Biden will quickly resolve a drawn-out, multilighting the Asian ally as a "lynchpin billion dollar dispute with Washington over the of the security and prosperity of the cost of thousands of U.S. troops on the penin-

Tackling the global coronavirus pandemic and climate change were key themes in Biden's calls with all three leaders, readouts from Biden's office showed.

Australia's Morrison said he spoke with Biden about emission reduction technology, though a target for zero net emissions by 2050 was not discussed.

"I raised with the president-elect the similarity between the president-elect's comments and policies regarding emissions reduction technologies that we needed to achieve that, and we look forward to working on those issues," Morrison told reporters in Canberra.

Both Moon and Suga said they agreed to arrange summits with the new president shortly after his inauguration in January.

Biden will also face the challenge of managing unresolved political and economic disputes between South Korea and Japan, which have threatened a military intelligence-sharing arrangement and complicated U.S. efforts to counter China. **Agencies** 

### Russia set to establish naval logistics base in Sudan

### MOSCOW

RUSSIA'S Prime Minister Mikhail Mishustin approved a draft agreement on establishing a naval logistics base in Sudan and gave instructions to submit a proposal to the president on signing the document, according to the information posted on the government's legal information web portal on Wednesday.

The draft agreement between Russia and Sudan on the naval logistics facility was submitted by Russia's Defense Minstry, approved by the Foreign Ministry, the Supreme Court, the Prosecutor General's Office and the Investigative Committee of Russia and preliminary agreed with the Sudanese side

As the draft agreement says, the Russian Navy's logistics facility in Sudan "meets the goals of maintaining peace and stability in the region, is defensive and is not aimed against other countries.

The naval logistics base can be used for carrying out repairs and replenishing supplies and for the crewmembers of Russian naval ships to have a rest.

The Russian Navy's logistics base in Sudan is expected to embrace the coastal, water and mooring areas.

"The Sudanese side has the right to use the mooring area upon agreement with the authorized body of the Russian side," the document reads.

The draft agreement stipulates that a maximum of four warships may stay at the naval logistics base, including "naval ships with the nuclear propulsion system on condition of observing nuclear and environmental safety norms."

During a visit by then-President of Sudan Omar al-Bashir to Moscow in November 2017, agreements were reached on Russia's assistance in modernizing the Sudanese armed forces. Khartoum also said at the time it was interested in discussing the issue of using Red Sea bases with Moscow.

In May 2019, a bilateral agreement on military cooperation for a term of seven years came into force. It stipulates, in particular, "an exchange of opinions and information on military and political issues and the issues of strengthening mutual trust and international security, an exchange of the experience of peacekeeping operations under the UN aegis, interaction in the search for and rescue at sea and the development of relations in the troops' joint training."



### Donations under \$8K to Trump 'election defence' instead go to president, RNC

#### WASHINGTON

AS President Donald Trump seeks to discredit last week's election with baseless claims of voter fraud, his team has bombarded his supporters with requests for money to help pay for legal challenges to the results: "The Left will try to STEAL this election!" reads one text.

But any small-dollar donations from Trump's grassroots donors won't be going to legal expenses at all, according to a Reuters review of the legal language in the solicitations.

A donor would have to give more than \$8,000 before any money goes to the "recount account" established to finance election challenges, including recounts and lawsuits over alleged improprieties, the fundraising disclosures show

The emailed solicitations send supporters to an "Official Election Defense Fund" website that asks them to sign up for recurring donations to "protect the results and keep fighting even after Election Day."

The fine print makes clear most of the money will go to other priorities.

A large portion of the money goes to "Save America," a Trump leadership PAC, or political action committee, set up on Monday, and the Republican National Committee (RNC). Under Federal Election Commission rules, both groups have broad leeway in how they can use the funds.

The Trump campaign, the RNC and

Trump's new Save America PAC did not respond to requests for comment. Leadership PACs such as Save America are often set up by prominent political figures to spend money on other candidates, while also paying for personal expenses, such as travel and hotel stays.

The disclosures would allow Trump and the RNC to channel the donations into other political causes or campaigns, such as the two highstakes January Senate runoff races in Georgia that could determine control of the Senate and are likely to rank among the most expensive races in U.S. history.

Trump's solicitation website carries a banner headline that says "OF-FICIAL ELECTION DEFENSE FUND" and "CONTRIBUTE NOW."

Scrolling down the page would take a donor to the fine print, which shows that donations are split between "Save America," which gets 60% of the money, and the RNC, which gets the other 40%. None of the money flows to Trump's official "recount" committee fund until Trump's Save America share reaches the legal contribution limit of \$5,000, according to the disclosures.

That means that, before a dollar goes into the recount fund, Save America would receive \$5,000 and the RNC around \$3,300. Donations to the recount committee are legally limited to \$2,800.

### **FLURRY OF LAWSUITS**

The fundraising pitches have channeled Trump's rage and his refusal to accept the results of an election that major media outlets called on Saturday for his Democratic opponent Joe Biden, the former Vice President. Most of the Republican Party has fallen in line with Trump's rhetoric, either by staying silent or publicly supporting the election challenges.

Trump's campaign has filed a flurry of lawsuits to overturn the results in key states without producing evidence to back his charges of illegal voting. Trump's lawsuits have instead generally alleged violations of process, such as a lack of access for Republican observers. Legal experts said none of the cases were broad enough to invalidate the number of votes required to overturn Biden's presumed victory.

Judges have quickly dismissed many of the lawsuits. State election officials, including Republicans, have said there was no widespread fraud. Just a handful of Republican senators have recognized Biden's win. Many more have not but some Republicans have suggested their patience with Trump's legal fight may run out soon. Agencies

In addition, new industrial parks will not be allowed to be built within a range of 5 kilometers from the river banks.

built to green the urban area. Outside the cities, river banks are also covered by shades of green. "Narrow-ridged finless porpoise, a first-grade state protection animal, were seen jumping above the river in January this year." Wang told People's Daily.

Wang introduced that when he was just employed, his vessel was powered by diesel. In June 2018, two diesel vessels of his company were added with liquefied natural gas (LNG) power system, and the vessel he now works on is one of them. Now the two ships consume less fuel compared with traditionally powered ships, which significantly reduce the cost for the company.

According to Wang, it saves over 3,000 yuan for a trip from Chongqing's Guoyuan port to Yichang port in central China's

Hubei province. In addition, the LNG-powered vessels are more environmentally friendly. They can reduce 90 percent of oxynitride emission, and almost 100 percent of sulfur oxide and PM2.5.

"Our crew members live on the deck, and due to the lack of the awareness of environmental protection, we used to pour our sewage into the river," he said. Thanks to continuous persuasion, education and supervision, now the crew members would throw nothing into the river, he said. Today, nearly 120,000 cargo

vessels are running in the Yangtze River system, which means hundreds of thousands of crew members are living on the rivers. This would produce massive pollutants. Therefore, regions said, adding that similar terminals have been put into service in Chongqing, Yichang and Anqing in east China's Anhui province.

In recent years, the provinces and municipalities along the Yangtze River, by implementing green development vision, has constantly improved local ecology and nurtured prospering green industries.

Zhacai, a kind of Chinese preserved pickles, is a well-known product of Chongqing's Fuling district. However, the water used to make zhacai was always discharged into the Yangtze River in the past. Nowadays, the water is used to make high-quality seasoning sauce, which makes the industry greener and more sustainable.

Chongqing's Changshou Economic and Technological Development Zone has improved its environmental protection infrastructure and established an incubation platform for circular economy. Over 30 circular economy projects have been launched, and 97 percent of industrial solid wastes are recy-**People's Daily** cled.

**Nigeria ratifies membership of AfCFTA** 

### ABUJA

THE Nigerian government on Wednesday ratified the country's membership of the African Continental Free Trade Area Agreement (AfCFTA) created for a single continental market for goods and services, with free movement of business persons and investments within the African region.

With the ratification, Nigeria has beaten the Dec. 5 deadline set for all countries to ratify their membership of the intra-Africa trade deal. President Muhammadu Buhari supervised the ratification process during the weekly Federal Executive

Council (FEC) meeting which he headed at the Presidential Villa, said Lai Mohammed, minister for information and culture. On July 7, 2019, Nigeria signed the AfCFTA agreement in Niamey during the 12th extraordinary session of the Assembly of the African Union. The operational phase of the AfCFTA was launched on the same day.

The effective date for the agreement to come into force ought to have been July 2020, however, it was postponed to Jan. 1, 2021 as a result of the COVID-19 pandemic. All member states were given up to Dec. 5 to ratify the agreement.

### Zimbabwe to start locally manufacturing buses for mass public transport system

#### HARARE

ZIMBABWE will soon start to locally manufacture buses for the mass public transport system as it seeks to revitalize the once vibrant automotive sector.

The move is part of the government's efforts to promote the consumption of local products and to reduce the import bill. Speaking during a tour of Quest Motors, a vehicle manufacturing company based at the eastern city of Mutare on Wednesday, Finance and Economic Development Minister Mtuli Ncube said the support of local industries by government would boost the economy.

"We, as government, should support local industries in our vehicle sourcing and also in bus manufacturing. We will see more of this happening over time," Ncube (pictured) said.

"We need to promote the 'Buy Zimbabwe' mantra as it is important for us to support our local value chains and industries.

A lot of it has to do with the incentive system that we need to put in place for that to happen.

That is exactly what we are developing and fine-tuning to make sure that we make local goods more attractive direction to make sure we support dothan foreign products. So you will find that our policy will be changing in that



mestication of local value chains," said Ncube.

In addition to creating employment, the assembling of buses locally is also expected to have ripple effects on the economy since a substantial amount of materials would be sourced locally. Earlier this year, government outlawed the use of privately owned commuter omnibuses on urban routes in a bid to restore sanity in the public transport system and to provide affordable transport to the commuting public.

State-run Zimbabwe United Passenger Company (Zupco) remain the sole provider of urban public transport. However, the Zupco fleet cannot meet the high demand, and has been operating with buses sourced from the

private sector players under its franchise.In response to the shortage of public transport, the Zimbabwean government has over the past year been facilitating importation of buses from China, South Africa and Belarus.

Local vehicle manufactures have raised concern over their exclusion from the supply of buses, arguing that they are capable of producing quality vehicles for the local market.

There are three vehicle assembling companies in Zimbabwe, namely AVM Africa, a bus and truck maker, Quest Motors and Willowvale Motor Industries (WMI) including its bus-making subsidiary Deven Engineering.

Ouest has over the years assembled Volvo, Leyland and Nissan buses, and currently holds the franchise to build Chinese owned Yutong and Zhong Tong buses.

Through a joint venture cooperation with Belarus, AVM Africa has been roped to assemble 300 of the 500 buses that will be supplied from the eastern European country.

Zimbabwe's vehicle manufactures have been struggling to stay afloat as the government, which is their biggest customer, has over the years shunned locally produced vehicles preferring imports instead.



### Pazi seeks re-match with Kassim

FAMOUS TanzanianSuper Middleweight boxer, Abdallah Pazi 'DullaMbabe', has requested his compatriot, Twaha Kassim, to step into the ring with the former for the third time after having failed to post victory over the latter in the two boxers' previous two bouts.

The first of the previous two bouts was declared a draw whereas the second had Kassim winning convincingly.

Speaking with confidence and pride in Dar es Salaam recently, Pazi, famed for his powerful right-hand punch and uppers cuts, has placed emphasis on Kassimby telling the latter he is ready to fight him anywhere, be it Dar es Salaam or Morogoro where Kassim, aka Kiduku, hails from.

He disclosed: "If he fails to find the promoter for our fight, I will do it for him to promote the fight because I have a lot of efficient people, I know who can coordinate and manage that fight if he fails to find his promoter."

Pazisaid he hopes the fight will be his first fight to pay attention to in 2021, after finishing his fight against a Zimbabwean opponent, which will take place at the end of this year.

Asked about the effects of participating in three consecutive bouts within three months, Pazi disclosed he will not be affected by the move.

He noted: "Negative effect might occur, if a boxer does so, because legally and physically he has to rest for three months, but, for me, it will not have much side effects because I have fought 10 rounds against Kassim, I fought six rounds against KasfaceBekNurmaganbet of Kazakhstan and I will feature in next year's bout."

"In Boxing Day's fight (against Zimbabwean opponent), I will fight 10 rounds, for that division and ratio it will not have as much negative impacts on me as a boxer," he insisted.

Pazi also congratulated Kassimfor the first time after the two boxers' latest fight, admitting that the latter used his weaknesses in the previous fight and that is why he was

able to emerge victorious.

He stated he hopes that he will work on the weaknesses, an approach that will enable him to emerge victorious when they meet in the next fight.

Speaking on his previous fight against Kassim, Pazi stated: "I can't blame anyone. I have accepted the results. This is a game like any other sport, it has three outcomes, win, loss and draw, and I have accepted the results, I can't put blames on my coach, judges or promoters of the fight."

He also stressed that the Minister for Information, Culture, Arts and Sports, who will be appointed by President John Magufuli, should also put focus on boxing promotion because, if he does not do so, many Tanzanian boxers will perform horribly in their fights.

Pazi also stated domestic boxing promoters in the likes of ShomariKimbau and JumaNdambileshould resign because they are, according to him, putting domestic boxing into disrepute.

The boxer issued a plea that a respected professional boxing official, Joe Anea, who recently resigned from the Tanzania Professional Boxing Regulatory Commission (TPBRC)'s president's post, should return to the sport's administration, given he is a good leader. Pazi noted that Anea had what it takes to promote professional boxing at the domestic level, since he has a huge exposure and connections with international boxing federations.

He further pointed out that losing his recent bout Nurmaganbet has had negative impact on his ranking in Boxrec.

Pazi, who was placed 92nd in the Super Middleweight boxing ranking globally as per the Boxrec, a network which keeps records of professional boxers from all over the world, has now dropped to 115th place.

Guinea edged dogged Chad 1-0, Burundi surprised Mauritania by forcing a late draw and Kenya could manage only a 1-1 draw with 10-man Comoros in other qualifiers.

The matches were the first since last November in the Cup of Nations qualifiers as the coronavirus pandemic severely disrupted the African international schedule.

A limited number of sociallydistanced spectators were permitted in Mauritania while the other matches went ahead behind closed doors

Liverpool star Mane converted a penalty just before half-time in Thies near Dakar to give Group I leaders Senegal a half-time advantage.

Victory for the Teranga Lions was sealed on 74 minutes when Mane set up Opa Nguette to score just two minutes after he had come off the bench.

The Senegalese have a maximum nine points from three matches in a mini-league they seem certain to win, Congo Brazzaville and Guinea-Bissau have three each and eSwatini none.

Meanwhile, the Comoros overcame having scorer Youssouf M'Changama red-carded just before half-time to keep alive dreams of a first Cup of Nations appearance.

M'Changama was yellow-carded, scored from a deflected free-kick was cautioned a second time and sent off in an eventful first half for the French Ligue 2 midfielder.

Kenya, with Jacob Mulee starting a fifth spell as national coach, levelled through Masoud Juma midway into the second half in Nairobi. The Comorans top Group G with five points, Kenya have three, record seven-time African champions Egypt two and Togo one.

Mauritania rank among the most improved African national teams over the past five years with much of the credit belonging to French coach Corentin Martins.

Substitute Saido Berahino equalised for Burundi, giving Jimmy Ndayizeye a satisfactory start as coach and the Swallows a first Group E point.

Mauritania have five points, Morocco four, the Central African Republic three and Burundi one, but the frontrunners will view the draw as two points lost rather than one gained. Greece-based Mady Camara, who is attracting attention from clubs in bigger European leagues, netted in the final minute of the opening half to earn pacesetters Guinea a three-point Group A lead. The Guineans, who kicked off against lowly ranked Chad in Conakry leading Mali on goal difference, found the going as tough as French coach Didier Six expected.

"There are no longer any weak teams," warned the former star before the match. "In Africa, the playing field levels out towards the top and not the bottom." AFP

before it happened, and while Ole Gunnar Solskjaer is not there yet, the similarities are striking. Two managers wrestling with the suspicion they were not backed by the club when it mattered, an inconsistent team struggling to quieten the critics and another coach sitting in the shadows.

For Van Gaal, it was Jose Mourinho. For Solskjaer, it is Mauricio Pochettino. Van Gaal's time ended with Mourinho famously taking over; Solskjaer is still battling away to make sure he doesn't suffer the same fate.

Victory at Everton on Saturday was the latest example of the Norwegian manager conjuring up a result when he needed one most, but there's no escaping the fact that after seven games, United are 14th in the table. Already this season, they have lost to Crystal Palace and beaten Paris Saint-Germain. They have suffered dire home defeats to Tottenham and Arsenal, but they also dismantled Newcastle and RB Leipzig.

Inconsistency has dogged Solskjaer's spell at Old Trafford and, as he approaches his two-year anniversary, United remain a team that's difficult to work out. Privately, United have been at pains to stress that Solskjaer retains the faith of vice-chairman Ed Woodward and the board, but it is ultimately up to Woodward and the owners, the Glazers, to decipher whether the good outweighs the bad.

Van Gaal remains convinced that by January 2016, Woodward had already decided to replace him with Mourinho. Enquiries were made via intermediaries to ensure that neither Woodward nor Mourinho got their hands dirty while another manager remained in the post. It also gave United plausible deniability even when Mourinho's agent, Jorge Mendes, was strategically leaking information in the background to ramp up the pressure.

Pochettino and his allies are different, already shying away from opportunities to rock the boat. His Nov. 2 appearance on Sky's Monday Night Football was well timed -- it had been in the pipeline for nearly a year and came 24 hours after Man United lost 1-0 at home to Arsenal -- but he made it clear he would not comment directly on United or Solskjaer.

Asked an open-ended question about whether he would like to return to the Premier League, Pochettino gave an open-ended answer: "I'm not going to close any door. I am waiting to feel what is the right project for us, which is the right way to take."

Sources have told ESPN that third-party agents sought to find out more about Pochettino's plans for the future in late September ahead of a tough run of fixtures for United that included games against Tottenham, PSG, Chelsea, RB Leipzig, Arsenal and Everton. Now through that spell, their run of games after the international break appears to offer Solskjaer more of a chance to stabilise the campaign.

Pochettino also remains the most likely candidate for Manchester City, who are keen admirers of the 48-year-old if Pep Guardiola does not sign an extension to the contract that is due to expire in June. All of which raises the possibility United could miss out on Pochettino for a second time.

She disclosed that night racing usually takes place in developed countries mostly during New Year eve as part of the festive vigils.
