## Lake Victoria ports for uplift in Uganda's trade to boost drive

By Guardian Reporter, Mwanza

A VISITING Ugandan minister has expressed satisfaction with improvements at Mwanza port, pledging to do the same on the country's lakeside ports to promote marine transport and trade between the two countries.

Fred Byamukama, the State Minister for Transport, aired this plan here yesterday after visiting the ongoing construction of a new ship at the port, designed to carry 1,200 passengers and 400 tonnes of cargo.

"We have seen the importance of improving our ports, Tanzania has done a tremendous job in developing Mwanza port, and we are going to do the same in Uganda," he said, urging the business community on both sides of the lake to fully utilise opportunities offered by easing marine transport.

He praised President Samia Suluhu Hassan for the vessels construction projects, noting that the ship under construction will, upon completion, ease export and import activity or Uganda and Tanzania, with much-reduced cost and time," he concluded.

Okandju Flory, executive secretary at the central corridor transit transport facilitation agency (CCTTFA), said that the ship will accelerate trade growth along the corridor, providing employment to large numbers of

PRESIDENT Samia Suluhu Hassan said yesterday that the government is determined to promote Kiswahili globally, outlining strategies to enhance output of professionals to help with teaching the language where they are needed.

In her virtual address to delegates attending celebrations to mark the first World Kiswahili Language Day in Dar es Salaam, the president said the country was establishing Kiswahili learning centres at Tanzanian embassies worldwide. Teachers will be recruited amongst Tanzanian graduates, she stated.

"We are implementing a national strategy to promote Kiswahili language and culture globally. This includes capacitating graduates with adequate skills such as editing, proof reading, interpretation, writing and broadcasting," she declared.

The celebrations were preceded with the signing of a formal agreement between Tanzania and South Africa, where the latter will start teaching Kiswahili in various levels of schooling, with Prof Adolf Mkenda, the Education, Science and Technology minister and his South African counterpart for Basic Education, Angelina Motshekga.

Vice President Dr Philip Mpango, chief guest at the celebration, witnesses the signing, with the pact seen as a pace setter to use the language in promoting greater social cohesion among people of various countries in the

It will also offer more opportunities to Swahili speakers from East African countries to spread Kiswahili language and culture, the president said in her remarks, pointing out that yesterday's launch of the World Kiswahili Language would result in an increased workforce, infrastructure and budget to various councils, institutions, universities teaching and promoting the language.

She praised the role of former Mozambican president Joachim Chissano in promoting Kiswahili internationally, noting that Chissano


## NMB opens 227th branch, channels 8.6trn/- revenues

NMB Bank has consolidated its market outreach, extending the branch network to 227 countrywide, with the new Buhongwa branch in Mwanza city at midweek.

Retail banking chief Filbert Mponzi said at the launching ceremony that from 2019 to 2021, the bank helped the government collect revenues amounting to 8.6trn/-, where the branch network helps it to better serve residents and boost its contribution to nation-building efforts.

Enabling the government to collect revenue through its digital channels was a pivotal aspect of this contribution, he explained, noting that the Government e-Payment Gateway (GePG) with over 1,100 public institutions participating



is connected to the bank's platforms.

With over 14,600 agents and a total of 800 ATMs, the bank was in a position to forge its partnership with the government, a major stakeholder in the bank, he stated, noting that the new outlet is NMB's 13th branch in Mwanza and beings its Lake Zone branches to 38.

It is a fully fledged branch offering all sorts of banking services, including agricultural loans at a nine per cent charge on credit, he said, qualifying this facility as part of the bank's support for government efforts to transform farming

NMB has already extended 100bn/- in agricultural loans at less than 10 per cent interest charge, with an additional 100bn/- set to be loaned at a nine per cent charge, he elaborated.

The new branch will be offering transactional services including loans, consultation, opening accounts, foreign exchange and insurance, an opportunity for local residents to use the bank for their progress and widening development activities, he stated.

Sauda Msemo, deputy governor for the Bank of Tanzania (BoT), officiated at the ceremony, underlining that NMB was a strategic partner to the government in various development projects

virtual address similarly The acknowledged the United Nations Educational, Scientific and Cultural Organization (UNESCO) for declaring July 7th as World Kiswahili Language Day, underlining that it was an honour to Tanzania and the East African coast, from where the language originates.

President Felipe Nyusi of Mozambique, speaking alongside the president at an African Union summit in the Senegalese capital of Dakar, said Kiswahili is one of the most widely spoken languages in Africa, being a Bantu language originating from the western rim of the Indian Ocean.

He said Kiswahili is among the ten most spoken languages in the world with estimated 200m speakers globally, also being used by a section of the Mozambican population, an official language of the African Union (AU), the Southern Africa Development Community (SADC) and the East African Community (EAC).

"Kiswahili is used in parliaments, courts and the media. It is taught at various universities around the world. Kiswahili is growing at an amazing speed while being used as a tool towards uniting people and simplifying communications," the Mozambican leader asserted.

In his remarks, Burundi President Evariste Ndayishimiye said that despite Tanzania having a vast number of tribes, Kiswahili has continued to unite the people. The language is also widely spoken in Burundi, Kenya, Uganda, Rwanda and the Democratic Republic of Congo (DRC), he specified

"Kiswahili can cross borders; using it as the medium of communication amongst our people is clear testimony of existing cooperation between our people. It is good to use one language as Africans. We are thankful to all the people who are using the language globally," he declared.

Vice President Mpango said the government is ready to collaborate intended to make Kiswahili a global with various stakeholders to promote commodity, he added.

the use of Kiswahili and consult with other countries to include Kiswahili in their curricula to continue spreading it around the world, happy that South Africa and Uganda have already announced plans to start teaching Kiswahili in school.

"UNESCO's recognition of the Kiswahili language makes it among seven official languages used by the United Nations. Apart from Tanzania, it is spoken in Kenya, Uganda, Rwanda, Burundi, DRC, South Sudan, Somalia, Zambia, Mozambique, Malawi, Comoro, Oman and Yemen," he remarked.

Kiswahili has been used as a teaching language here since 1929, with the nationalist movement taking up Kiswahili as the language to unite the people during the independence campaign.

In December 1962, Nyerere addressed the first Tanganyika Parliament in Kiswahili and in February 1963, Kiswahili was formally recognized as the national language, he elaborated.

In Zanzibar Kiswahili was an official language before and after the January 1964 revolution, he noted, while South Africa's Basic Education minister Angelina Motshekga said the government there made deliberate efforts to make sure children in South Africa are taught Kiswahili in schools. "To us Kiswahili is more than

a language," she told the participants. Technical teams from Tanzania and South Africa should immediately meet to complete the processes for teaching of the language, he urged, recalling that the key decisions were made back in 2019.

Mohamed Mchengerwa, the Culture, Arts and Sports portfolio holder said the government will from next week start consulting with UNESCO on possibilities of constructing a higher education facility exclusive for Kiswahili in Tanzania.

It would be helpful in promoting the language and culture of its users, with the ministry having set aside a 100 acres plot of land for the project,

religious leaders and other key stakeholders.

The visit was aimed at taking stock of where Tanzania is in meeting its vaccination coverage objectives and identifying the way forward, to address bottlenecks and scale up the vaccination programme, he stated.

Flanked by Health minister Ummy Mwalimu, the Finance and Planning Minister and the Minister of State in the President's Office (Regional Administration and Local Governments), he stressed that the pandemic is far from over.

There is a risk of new variants, especially in under-vaccinated populations where it remains high, he explained, underlining the need to ensure that we protect those most at risk including the elderly, people with

workers and those working in sectors such as tourism and hospitality.

"The vaccine is our best protection against COVID-19. No one is safe until we are all safe," he declared, citing the local motto on vaccinating, that 'the clever thing to do is to take the jab.'

Much as Tanzania has not reached the international target of administering the vaccine to 70 per cent of the adult population, the country has been able to increase the vaccination rate from 6.3 per cent in late 2021 to 12.4 per cent at present, he said.

"Tanzania was late in launching the vaccination campaign," he said, nonetheless commending the government for being able to take measures enabling an increase in the number of people taking the jab through outreach facilities and health

Tanzania now needs to keep the underlying conditions, frontline health momentum and accelerate the

vaccination drive, especially by ensuring that groups such as the elderly and people with chronic illnesses are given priority and to ensure that all are vaccinated, he stated.

Visiting the country to meet with international and local stakeholders to support accelerating the Covid-19 vaccinations drive, he was of the view that rolling out the campaign should directly involve district and regional authorities to reach its target.

Creating public awareness for employees in the education and tourism sectors to promote vaccination campaign in their midst was equally vital, he stated, highlighting that challenges brought by the Covid-19 pandemic provide a lesson to developing countries on effective basic healthcare facilities. Locally made drugs are needed to address disease outbreaks, he stated.

the government has set out various strategies to increase awareness and push up the inoculation take up. She pointed to continuous improvement in health systems, including capacity building for medical personnel to tackle the pandemic.

THE government in Mbeya region says it is preparing a special event to congratulate district commissioners, councils' executive directors and heads of financial departments for attaining 106 per cent of revenue collection targets during Fiscal Year 2021/22.

Mbeya Regional Commissioner, Juma Homera made the remarks here on Wednesday when submitting revenue collection statement for the region, saying the region was targeted to 42.68bn/- but collected 45.06bn/-.

He said the collection was attained due to proficiency and ethical behaviour by officials from regional commissioner's office, Executive Directors, heads of councils' departments and that in order to encourage them he plans to organise an event to commend them.

Homera said the officials will be given certificates and assemble in on one tourist attraction area inside the region as part of supporting the Royal Tour documentary film featuring President Samia Suluhu Hassan.

"We shall party together at Matema Beach along Lake Nyasa, as these officials have displayed great patriotism in regard to revenue

collection contributing to the 14 per cent rise of income compared to what we had targeted," he said.

He added that they also plan to have in place a good plan in the supervision of the revenue collected to make sure the money is well spent in development projects and to stamp out any avenues for corruption.

He said out of the region's seven local councils, Mbeya District Council led in revenue collection during the period, it was targeted to collect 4.3bn/- but instead collected 5.2bn/- or 121 per cent of the target.

He said Chunya district council came second - it was targeted to collect 4.8bn/- but collected 5.2bn/- or 108.8 per cent, followed by Busokelo district council that was targeted to collect 1.5bn/-, but collected 1.6bn/- or 104.6

per cent of the target. The fourth was Mbeya city council that was targeted to collect 16.6bn/but collected 17.2bn/- or 103.7 per cent, followed by Rungwe District - targeted to collect 5.3bn/- but collected 5.4bn/or 103.1 per cent of the target.

## Pool resources to participate in LNG project, local firms told

TANZANIAN entrepreneurs and companies interested in the Liquefied Natural Gas (LNG) project have been urged to pool financial resources and expertise together so as to qualify for the USD30 billion (75trn/-) investment whose implementation is slated for

Acting director of the Petroleum Upstream Regulatory Authority (PURA) Eng Charles Sangweni who is also the chief negotiator of the project said the LNG was coming with a number of opportunities which the locals have to get ready to utilize them.

Addressing journalists yesterday at the ongoing 46th Dar es Salaam International Trade Fair Eng Sangweni even though multinational companies with high technology will implement the project, Local firms have many opportunities in the construction and services

He said PURA and other authorities will invest efforts towards promoting understanding of the project and the local content opportunities available to facilitate the locals to grab the opportunities.

"To support this, PURA in collaboration with EWURA has developed a Common Qualification System (CQS) which will contain a database of Tanzanian service providers and professionals. The database includes suppliers and service providers' experts in the petroleum upstream sector to enable domestic and foreign investors to access qualified experts for business partnerships," he noted.

He said local contractors, engineers, entrepreneurs and suppliers should now demonstrate capacity and readiness to deliver most of the services both technical and non-technical that will be required in the project.

Eng Sangweni added that more than 10,000 jobs would be created during the construction and operations phase. Mid last month, the government signed the LNG framework agreement

with the UK's Shell and Norway's

Equinor that is expected to kick-start construction of the export terminal to commercialize the country's deepwater offshore gas reserves.

The deal signed by the three parties is foundational to the Tanzanian government's issuance of a Host Government Agreement (HGA) later this year which will outline the project's technical, commercial, and legal terms.

Front-end engineering and design (FEED and pre-FEED) will be completed within 3 years of HGA signing, with a final investment decision targeted in 2025. A 4- to 5-year construction period will follow with a first LNG drop planned by 2029-2030.

The plant will be built on the coast of Lindi Region. It will be linked via a 100km subsea pipeline to significant deepwater gas discoveries off Tanzania's southern coast and have a 30-year life

Reports show that over 50 percent of the country's total area (534,000km2) has been blessed with potential sedimentary basins which, if well explored could transform the oil and gas sector in the country.

It is against procedures in developing them to enable the minister seek permission from President Samia Suluhu Hassan to endorse change in their uses.

The Minister made the remarks in Moshi. Kilimanjaro Region yesterday when she was addressing various regional officials, saying in case there will be any violations in regard to land ownership, legal steps should be taken during the period given.

She said there have been rampant violations on procedures in regard to some farms, the situation that make people take up loans and use the farms as collateral, while the loans taken are not utilised to develop them.

"President Samia has opened up opportunities to investors and as for now there are so many of them coming to the country to invest, hence we cannot just abandon such farm land." she elaborated.

She also instructed all District Council Directors countrywide to make sure they oversee the issue of settlements unplanned so that towns should be well planned in according to the country's laws and

Dr Mabula further said according to the Town Planning Act, local councils are the ones with authority in town planning; it is not the work of the Ministry which only makes sectoral supervision to ensure things go well.

## TAWIRI starts production of alternative firewood from invasive plant species

Wildlife Research TANZANIA Institute (TAWIRI) has started producing alternative firewood from invasive plant species that are a threat to wildlife's health and the ecological nature of the conserved areas and national parks.

TAWIRI has since April this year rolled-out a project that targets at reducing rampant invasive plants in national parks and conserved areas by cutting them down and making alternative firewood out of it.

Dubbed as 'RangelandsCARE Project' it is being implemented in the Ngorongoro Conservation Area (NCA) by producing alternative firewood known as biomass briquette from one of the invasive plant known as Makutian grass which is rampant in the conserved area.

Addressing reporter at the 46 Dar es Salaam International Trade Fair in Dar es Salaam yesterday, Dr Jerome Kimaro, TAWIRI Senior Research Officer and RangelandsCARE Project Leader, who also invented the alternative firewood technology, said that the project goes up to 2026.

"There are many species of invasive plants in the national parks and conserved areas. We have opted to start with the Ngorongoro conserved Area because the Makutian grasses are becoming a major threat to wildlife health," said Dr Kimaro.

According to him, the alternative firewood has features that are friendly to the environment. He said the firewood has low quantity of smoke, it burns easily, emits high heat and it lasts for a long time compared to normal firewood.

Dr Kimaro said that he had presented the technology at this year's National Science, Technology and Innovation Competition well known in Kiswahili as Makisatu and scoped an award.

Organized by the Commission for

Science and Technology (COSTECH) this year's Makisatu competition had seen 868 innovators from the Mainland and Zanzibar presenting their innovative ideas that are intended at addressing challenges that hinders achievement s for social development goals (SDGs).

Dr Kimaro's innovative idea had enabled TAWIRI to scope an award on the category of the best Research and Development Institution.

At the climax of the Makisatu week held on May 7, 2022, the Ministry of Education, Science and Technology's Permanent Secretary, Eliamani Sedoyeka said that in the 2022/23 budget the government has allocated 5.5billion/- for supporting innovators.

According to him, during the 2021/22 financial year the ministry had allocated 2.3billion/- for supporting innovative projects in the country.

## MV Mwanza project reaches 68 per cent

CONSTRUCTION of the state-of-theart ship of MV Mwanza Hapa Kazi tu has now reached 68 per cent, Marine Services Company Limited (MSCL)'s project manager Vitus Mapunda, asserts that the modern vessel will be in operation next year in October.

In his brief to Uganda's State Minister for Transport Fred Byamukama, MSCL project manager said that they are on last touches to conclude building the body of the ship.

"In October or mid-November the ship

will be taken to the slipway for other enforced the marine pollution regulation by having the working activities, and in October next year, sewage tank and protected fuel tank with double sides and the ship will be ready," he said.

He added: "The MV Mwanza Hapa Kazi Tu is a 1200 passenger ship under construction at Mwanza shipvard. The ship shall be powered by twin engines, each developing 2380 kW."



# Mark your products with made in Tanzania logo to market country's resources, minister tells investors

MINISTER for Natural Resources and Tourism Dr Pindi Chana has called upon all timber manufacturers in the country to make sure they mark their products with the Tanzania's logo so as to market the country's creativity abroad.

She made the statement on Sunday in Mufindi district during her one -day official tour in Iringa Region, where she visited the Dazhong Wood Industry Company Ltd that is producing various wood products and found that the factory -produced products were not marked made in Tanzania.

The factory, owned by an investor from China, was introduced last year and manufactures a variety of wood products such as Wood Veneer, Plywood and Marine Ply Boards employing more than 450 workers.

The minister called on the owner of the factory Wu Bin from China to implement the order by complying with Tanzania's rules and regulations.

Dazhong Wood Industry Company Ltd is located in Sao Hill Village, Mafinga Township in Mufindi District of Iringa Region.

According to Wu, the main products of the factory include eucalyptus, veneer, pine swanned timber and plywood.

He said that the first phase of the Dazhong investment is about 34.5

veneer producing lines, producing 400-500 cubic meters daily.

Wu also said the factory plans to invest in 09 pine swanned timber producing lines, producing 400-500 cubic meters daily and also 400-600 pieces of plywood produced daily with two plywood production lines.

He also said the first phase of his factory (Dazhong) plans to purchase 500,000 cubic meters of logs annually, producing 300,000-350,000 cubic meters of various forest products.

The investor requested the government through Tanzania Forest Services Agency (TFS) to consider establishing an integrated logging system in its forest plantations.

He noted that in that system, trees will be felled by government owned logging and transport teams and sold by assortment like match logs, like sawing logs, pulpwood logs, transition poles, telephone poles, fencing poles and firewood.

"We also advise that the government should revise its tree volume measurements method because of the great difference in tree volume and log volume we noted when we purchased logs from Sao Hill Forest Plantation," he said.

For instance, in one bill of standing trees we bought a coupe with 534.04 cubic meters of standing trees for 20,142,959/- but out of it we managed

also plans to invest in 10 eucalyptus good logs, meaning the rest 160,212 cubic meters were useless and left in the forest," Wu said.

> He said by doing so, the government will provide more employment and add more revenue sources from felling, skidding and loading charges.

> In addition, Dr Chana praised the country's forest conservation efforts by the Tanzania Forest Service Agency (TFS) and called on the institution to continue to cooperate with district councils, stakeholders and citizens in the role of forest conservation, managing forest -based industries.

## Battle against wildlife poachers is increasingly crime high-tech

In 1998, environmental scientists from the University of Massachusetts Amherst proposed the concept of poaching as an environmental crime, defining any activity as illegal that contravenes the laws and regulations established to protect renewable natural resources including the illegal harvest of wildlife with the intention of possessing, transporting, consuming or selling it and using its body parts.

They considered poaching as one of the most serious threats to the survival of plant and animal populations. Wildlife biologists and conservationists consider poaching to have a detrimental effect on biodiversity both within and outside protected areas as wildlife populations decline, species are depleted locally, and the functionality of ecosystems is disturbed.

This year marked a milestone in the battle to protect endangered species, when an international team of scientists announced they had successfully created two northern white rhino embryos.

The landmark achievement is a promising step towards pulling the white rhino back from the brink of extinction.

It also highlights how technology is being harnessed to protect wildlife - including efforts beyond the lab in places like South Africa.

More than 760 rhinos are killed annually in South Africa - including 421 slaughtered last year in Kruger National Park.

Rhinos are killed for their horns, which are prized in traditional Asian medicine and command high prices when poachers hawk them on black

Research indicates that tech innovations have already helped to curb poaching in Africa. Black and white rhinoceros - the continent's two rhino species, classified as endangered and threatened, respectively - have increased in population in recent years, reports

In conservation hotspots across the world, artificial intelligence, drones, and surveillance platforms are among the technologies that have become the latest line of defence against the \$23bn global illegal wildlife trade, which claims the lives of 800 rhinos - along with 15,000 elephants and untold numbers of pangolins, impalas, bush pigs, warthogs and other animals - in Africa every year.

Only 25,000 rhinos, 415 African elephants, and dwindling numbers of other at-risk species survive on the continent in the wild today.

"There is too much to protect, and too few people to protect it, so technology has become essential when addressing the global poaching crisis," says Rohit Singh, head of the Zero Poaching initiative for the World Wildlife Fund (WWF).

As conservation groups get smarter about technology, so do the poachers they are battling to stop. Environmentalists say the fear of never being more than one step ahead is tangible in their campaign to save animals hunted for their horns, tusks, pelts, scales or skin - or for capture as exotic pets.

"With illegal wildlife trade being run by increasingly organised crime syndicates, poachers already use technology and are often far better equipped than those protecting nature and wildlife," says Singh.



## Ban on coups: Applaudable but

decision made by ECOWAS and the AU to crack down on coups d'état in Africa by imposing a ban on the practice is an interesting development. Given the high frequency of coups in Africa as opposed to other continents and the fact that coups engender bloodletting, terror, economic crises and political instability in most cases, the move is a welcome one.

However, one is amply justified in wondering whether the move is a sincere one on the part of our leaders and whether it can help remedy the situation. In a region where many of the leaders came to power through the barrel of the gun and overstaying in power is the norm, it is extremely hard to believe that such a move is meant for public good. Judging by the behaviour of most African leaders and their associates, characterized by blatant plundering and squandering of exiguous, direly needed public funds, coupled with flagrant violation of human rights in the form of victimization and brutalization of citizens for political reasons, adding insults to injury, it is sheer shortsightedness to believe that the move can help stop the practice once and for

There is every indication that the move is meant to safeguard the political interest of current African leaders by guaranteeing their security and safety rather than just to ensure peace and stability for the benefit of the public as our leaders want to make

us believe. If our leaders were sincere in the move, those among them who mounted power by staging coups would repent their acts and apologize to their people or be asked by their colleagues to do so. But what we have seen is the contrary. Some coup-makers continue to insist that they had genuine reasons for toppling their predecessors and endeavour to convince people in this regard without being challenged by their colleagues. Hence, those coupmakers can be likened to a person trying to lock the door of a dining room just after entering, so as to prevent others from entering through the same door. The fact that our leaders have imposed a ban on coups without going a step further to take measures to prevent overstaying in power also casts a big shadow of doubt on their sincerity.

It can be cogently argued that banning coups without addressing the root cause of the problem will yield very little dividends, if any. The prevalence of coups in Africa can,

to a very large extent, be ascribed to the behaviour of our leaders. The dictatorial, egotistic, egoistic, sadistic, megalomaniacal and bigoted tendency of some of our leaders is a causative factor of coups. Therefore, any action taken to crack down on coups without taking this factor into account may have very little effect or prove to be an exercise in futility.

Some African leaders endeavour to cling onto power at all cost. They use various means to achieve their aims, which include terrorizing the population through harassment, arbitrary arrests, detention, torture andkillings; issuing threats intimidate opponents; doctoring their constitutions to suit their political interest; promulgating draconian laws to gag the press; suppressing dissent and freedom of expression; meddling in matters appertaining to the judiciary; manipulating civil servants, parliamentarians and electoral officers; monopolizing the public media; denying citizens their dues or depriving them of basic necessities; and the like. In short, those leaders seek to obtain sweeping powers and attain total control of everything to rule with iron hands, making it extremely difficult or impossible for them to be removed from power through peaceful means. When their oppression becomes unendurable to the masses, they resort to violent means of extricating themselves, as a cat can do anything to save itself when pushed to the wall. Some leaders, especially coup-makers and their associates, personalize state properties. They enrich themselves in the twinkling of an eye and lead flamboyant life styles, spending thriftlessly improvidently. and This behaviour has the danger of encouraging coups. It arouses the envy or anger of others who may resort to violent, unconstitutional means to weed out those greedy, selfish people in

save their compatriots from economic crises by freeing them from the clutches of the rapacious, materiallyminded, extravagantly-behaved clique.

Hence, any action geared towards cracking down on coups should not fall short of imposing a presidential term-limit and introducing strict, drastic measures to curb human rights violations and corruption. If our leaders really meant business, they would make efforts to mend the cracks on the wall rather than plastering them. Simply put, they would try to address the root cause of the problem if they were sincere in their move. In so doing, they would not need to impose a ban on coups, for the situation would automatically take care of itself. No leader should be allowed to cling onto power or oppress his people continuously, for no one is indispensable or superior to others as some leaders and their sycophants want to fool people into believing. Believing in the indispensability of a leader or his superiority over others or portrayal of a leader as such is not only folly but also insulting to God's intelligence. How can you expect God the Omniscient to endow only one person in a country with the capability or ability to govern that country? If only one person in a country had the ability to rule, what would happen when he goes to eternity or dies? Are those portrayed as indispensable leaders immortal? Given the fact that all human beings are made of bones, blood and flesh and share the seven characteristics of living organisms and that leaders are human beings, is it reasonable for a leader to be intoxicated with power or be arrogant to the extent of feeling superior to others or be portrayed as such? Are there superhuman leaders or leaders made of materials that are more valuable than those mentioned above, unlike their fellow human

or not, leaders must relinquish power peacefully or step down to pave the way for others to contribute their quota. Indispensability cannot be used to justify overstaying in power, for anybody can claim to be indispensable or be portrayed as such by sycophants. The desire to eternize one's stay in power can only be interpreted as greed and selfishness. That is the fact of the

Coming back to the main point of the discourse, I would like to expand on the matter by contending that coups can be eradicated or at least minimized with the imposition of a presidential termlimit. Imposing a term-limit can render coups unjustifiable. For instance, coupmakers may find it difficult to gain national and international recognition after overthrowing a democratically elected president whose tenure of office cannot go beyond eight or ten years. Cognizant of this fact, wouldbe coup-makers may be deterred. Besides, aggrieved, discontented or disgruntled parties may not feel the need to fall back on violent means of removing a president from office with the knowledge that his tenure of office is ephemeral. Additionally, having a presidential term-limit in place can help deter oppression or disregard for the rule of law on the part of leaders, which, in turn, can help deter coups. Knowing fully well that they have very limited or short time in office and that they may be held accountable for their misdeeds when they dismount power, leaders may avoid wronging their people and think twice before acting or making decisions while in office. In other words, having a presidential termlimit can scare leaders into behaving well or avoiding misbehaviour and malpractice, which can earn them the respect and love of their compatriots, thereby guaranteeing their security and safety by discouraging would-be coup-makers.

Given the fact that our leaders have overlooked the importance of imposing a presidential term-limit, we should not be surprised if coups continue to occur in Africa despite this ban on the practice. As pointed out earlier, overstaying in power and oppression should stop if we are to succeed in banning coups.

To sum up, our leaders must see reason and change attitude for the better, as their behaviour leaves much to be desired. They should stop playing with our intelligence if they really intend to crack down on coups as a way of ensuring peace and stability. I urge them to try this medicine. I am confident that it will prove to be efficacious.

The country's economic growth is currently improving at 7 per cent, this should be reflected on the lives of workers who are the main contributors to national development.



here is a tea place in Old Town by the edge of the sea. I don't frequent it that much these days but when life gives me too much, that's where you'll find me.

Drowning it all in a steaming dark sweet cocktail of coffee, cinnamon and ginger-a lot of ginger that is, you'll find me watching the ocean outstretch like a trembling blue carpet to the other side.

There's a quiet understanding between the regulars here. Though misery doesn't deserve company, we recognize we're all running away from something, according to the ones I've talked to.

Whether it's from a hectic long day of work, a nagging wife or boring husband at home, the looming expectations of society on you or just hiding from yourself in the company of others but there always something to run away from.

We're runners away here. The upper bench for solitude and contemplation and the lower one is for everybody and everything else. Its busy most evenings, and you won't turn your head left or right without bumping into somebody's big plans.

I remember one evening before my graduation when a heated discussion became personal on the everyday frustrations of your normal 20-somethings.

Circling around getting a job which none of us had at that time or internships which were hard to come by, yet none of us wanted to be employed as we were high on the spirits of entrepreneurship. In the perfect world, working for someone wasn't really an option for any of us.

Ideas darted back and forth. One, to start out, had plans to open a cybercafé because there weren't any in the block. Another, the water business and he spoke of a desalination



plant he was already researching on. Spirits were high. Another went, and another came and ideas were vomited all over the place. And just like that, all went quiet until one guy chimed in.

"But why is it that when we talk about entrepreneurship, our thinking is always skewed along these lines? Subscribing to the fallacy that an idea has to be 'in-your-face' and big to be great when most of the time, great ideas spring from the most nuanced and arise when we think along smaller lines?"

"See that old man over there?" He then pointed at this grey bearded clad smartly in a blue kanzu. "He grew up in India.

He had this brother he tells me his family depended on. When there was an issue pertaining to money, he was the brother you sought out. Yet surprisingly, he hardly did much the whole day. When everyone else left for work, he was asleep and was the last person to wake up. So where was this golden goose he was hiding?

Turns out the brother used to wake up at 3 every morning and head to the market. His clientele was the many grocers in the city; he'd purchase whatever they needed for the day and deliver it to them. By the time the rest of the family woke up, he was done for the day and earned his freedom to do whatever he wanted, in his case, sleep some more."

I smile every time I remember that story. I smiled, even more, when I encountered that concept in MJ Demarco's book, 'Unscripted' (a recommended read). He calls it crowd-feeding. Where instead of being part of the chain, why not just serve it; provide a small convenience and the market will reward you

So long as people will be lazy, presenting convenience will have you welcomed with open arms. As long as the world isn't perfect, there never will be a shortage of ideas. And the world will never lack funding

for a good idea. At least that's what I think. Well then, where are these opportunities we don't see? To kick, off, I'd like to present three concepts I hope will stir something in

#### **Listening to the market**

A common mistake new entrepreneurs make is wanting to set an enterprise in their area of specialization. "Oh! Since I'm an editor, and I'm pretty good at it, maybe I should start a publishing business," when that area is maybe saturated or the market has no need for it.

A better approach when looking for what to start, when you're in need of an idea, it pays to pay attention to all the negative language used by people: I hate it, this sucks, I'm tired of this, I wish it were different, this is really frustrating, isn't there any other place? And so on and so forth.

Arbitrage is a sort of common sense yet unconventional approach to things. Not wanting to get into the economics of it. Imagine being one of the traders in a market where you all sell tomatoes for 500/-.Then suddenly, one trader drops his tomatoes to 300/-. That means the rest of you will have to match his or her price and sell at a loss or close that business because all the customers will line up at that stall.

So, how do you handle that? Well, an arbitrageur would notice the small window he has to buy out the other trader's tomatoes at 300/- so no one else has to lower their prices. The market stays as it is and you still earn your profit for selling at 500/-.

Arbitrage comes in different ways. There's value arbitrage; this is when you add value to a poorly made or old product. Like buying old furniture and repairing them by varnishing, fixing a leg, and then reselling it at a higher margin.


I'm guessing that's the deal with refurbished computers too. There's marketing arbitrage which can be as simple as taking better pictures of a product for those who sell things online, improving on the packaging and better order fulfillment. You could look more into it.

#### **Crowd-feeding**

And we're back at where we started. In a crowded market, let's say overrun by government or company-subsidized restaurants, rather than being another cog in that wheel and starting your own restaurant, you could linchpin all around it and supply everything the restaurant needs, except for the

The best opportunities rarely come from joining the crowd, but by serving it. When people are rioting, don't riot with them, sell them water and branded T-shirts. When everyone has a grocery store, be like our old man from India.

## English syllabus for primary schools needs revisiting to make it tick

EVELOPMENT is a gradual process and the case is the same in education which is said to be the engine for socioeconomic development of any country. There are a lot of improvements to be made in education due to defects which are obvious in the entire system.

It is easy to see the defects but it is not so in identifying causes of those defects. This kind of proposition makes it necessary to reveal hidden aspects in our education system which owes us the unsatisfying results such as the claim that our graduates are not employable.

To point out one of the causes of poor performance of our education, we cannot escape mentioning syllabuses and for today's analysis it is English syllabus for primary schools.

Before evaluating the syllabus let me say that it will be very wrong to try to say that those people who prepared the syllabus did not do a good job but it is encouraging to air out views which can lead to improvements, especially when geared by freedom of expression which our constitution guarantees.

There are two major areas in the English syllabus where one can raise some claims which can hardly be rejected. The first area is content delivery. There are contents which the teacher is expected to teach but they are not shown in the syllabus.

The other area is expressivity for contents. The syllabus does not provide in-depth explanation on what should be taught. One can say that the syllabus for English for primary schools has been too general, posing a tussle job of analysis that a teacher has to do. Due to lack of expressivity in the English syllabus for primary schools, there are some challenges which the education stakeholders may encounter.

One of those challenges is failure by the

teacher to cover the required contents because they are not shown clearly in the syllabus. A teacher is a professional who should be able to interpret the syllabus and develop lessons, but what can this professional do if the syllabus is not clear?

The challenge is that the teacher will prepare lessons which are not broad enough to meet the intents of the syllabus and hence reducing the confidence of the teacher.

If the teacher is not confident, it is indubitable that he or she cannot guide pupils into the paths of assurance of knowledge, therefore subjecting the educator into possibility of credibility been shaken by the pupils, something which is disgraceful.

The ultimate effect of defects in the syllabus is failure by the pupils due to impaired teaching process as a result of the syllabus which is not self-explanatory.

One can opt for divergent thinking, holding that if the syllabus is not detailed, let us consult books written following the syllabus. Again there are defects in those books by the Tanzania Institute of Education (TIE), a body mandated to interpret curricula and produce syllabuses and other teaching and learning documents.

The defects in those books written by TIE necessitate revisiting the syllabus as the recourse is non-existent.

With the books for English for primary schools, two defects if not more are seen. One is presence of very good exercises but without introductory part to initiate learning of those concepts revealed by the exercises. This situation makes it difficult for the teacher to rely on those

The second defect is missing or partial delivery of contents. This situation makes the use of a single book a challenge while some analysts propose it as among remedies to our educational challenges.

The challenges in education calibrate

the conviction that the government should revisit the English syllabus and books for primary schools to ensure their validity in the struggles we have in making our education able to provide solutions to the challenges we face as a

The improvements in the syllabus and English books will enable teachers improve the learning and teaching processes as they will be away from confusion and wasting time in finding what is worthy of being taught regarding

nation.

However, despite the challenges in those books by TIE, the institute can be hailed for being able to write books which are rich in illustrations and good exercises. There are a few things which if improved the institution will be outstanding and the stronghold for

treasures of education in the country. With some issues not fixed in our English syllabus for primary schools, an alternative should be conceived. Examining questions which appear in English national examinations can help the teacher know areas which he or she has to cover so that pupils can be able to face examinations which for centuries have been a measure of understanding in

We cannot improve on what we have not done. As we have put our syllabus for English for primary schools into use, we can now improve it to make sure the objectives in education are realized.

The contribution may come in a form of criticism but it should be positive and constructive, valuing the freedom of expression without forgetting the basics of civilization. Let us collaborate to improve our education.

## Tap into indigenous knowledge to preserve our forests

few years ago, I found myself in the Baka indigenous sacred forest Lin Assok, in Cameroon in the course of my work in supporting them to preserve their forest against land grabbers. We were building a forest hut using only leaves and the knowledge of our indigenous partners.

I was skeptical when we started. "What about rain," I thought. But the leaves were placed in a way that the rain simply flowed down the sides. Inside was warm and dry.

Indigenous forest peoples are recognized as the first inhabitants of the forests around the world. For millennia Indigenous People have lived symbiotically with nature gathering fruits and insects; hunting, and protecting the environment they rely upon.

In the Congo Basin, around 50 million Indigenous Peoples depend on forests yet they are the most vulnerable, the most marginalized and the poorest inhabitants of a region that stretches across some five countries including Cameroon, Gabon and the Democratic Republic of Congo.

I have interacted with various indigenous people over the last decade as part of my work as environmental advocate. In Cameroon, where I live, the Indigenous World 2022 Report estimates Baka, Bagyeli and Bedzang peoples represent 0.4% of the total population while the Mbororo pastoralists make up 12%. These interactions include numerous field visits to their ancestral land where I have admired their solidarity and harmony in living with nature.

Over the generations, Indigenous People have developed their own codes of forest conservation, including preventing overhunting with methods that include rotational hunting and harvesting. For instance, the Baka don't hunt in sacred sites, at a place where a newborn has been circumcised and nor do they hunt large mammals. They eat only fresh meat so hunt only that which can be

I am amazed by their extensive knowledge of forest medicinal plants and their uses. Prior to the expropriation of their ancestral land by logging and Agribusiness companies, they hardly went to the hospital. While COVID-19 and deforestation have changed that, we still have much to learn from them. For them, forest conservation is not an isolated, compartmentalized concept but an integrated part of their lives

Yet their very rich traditional

risk: experts say up to 10 indigenous linguistic identities are at risk of disappearing. Embedded in that

cultural knowledge, which will also disappear.

When we mark International

Peoples on August 9, we can expect politicians to invite them for photo

ops and public appearances. But

to really prevent them and their language and expertise from disappearing? I've seen the power of

Indigenous Peoples' ancestral knowledge and wisdom about forest and biodiversity sustainable management. If we embrace this expertise we will be taking the most cost-effective ways to reduce poverty, preserve biodiversity, halt deforestation and contribute to reducing the harmful effects of climate change. Globally, this is a powerful

path forward for responding to climate change, improving the environmental, and advancing justice. Indigenous Peoples make up about 6.2% of the world's population, but they safeguard 80% of the planet's biodiversity. Their sophisticated knowledge of the natural forest - documented by scientific research worldwide allows forests and biodiversity to flourish. Their sustainable land use fights climate change and builds resilience to natural disasters and pandemic.

Among the recommendations made by Indigenous leaders at the last COP 26 global climate conference, was the recognition

of the rights and land tenure of Indigenous Peoples' to land, forest and water and that Indigenous Peoples, as knowledge holders, should be able to participate directly with their own voices in the UN process to ensure that their "rights, cultures, lands and ways of life" be respected. US\$1.7 billion was announced during the last COP 26 to help Indigenous and local communities protect the biodiversity of tropical forests that are vital to protecting the planet from climate change, biodiversity loss, and pandemic

Little has changed on the ground, despite another recent paper further confirming that traditional ways of using and managing biodiversity are grounded in progressive principles of sustainability. In short, indigenous knowledge and management systems represent critical yet frequently untapped resources in global conservation efforts.

Despite this evidence and policy recommendations, it is business as usual where conflict, insecurity, lack of recognition of Indigenous Peoples land rights, expropriation, lack of inclusion and participation in the decision-making process continues.

COP27 will take place in Egypt, an African country, this year. It is my hope that a delegation from the Congo Basin will not only be there but will influence climate change policies and decisions.

Indigenous Forest Peoples cannot assume the burden of global conservation and climate mitigation challenges without our support.

My question to the global climate leaders and government authorities is this: what has happened to the COP 26 IPLC forest tenure Joint Donor Statement that pledged for support indigenous people's land tenure rights and guardianship of the world's forests?

Business as usual will not save us. If we don't act to preserve our forest guardians and their knowledge and properly involve them in our conservation effort, we will lose their rich wisdom and knowledge.

Without healthy, thriving forests, we will never see the sustainable future we are aiming for.

TEAM of global development partners visited the Tanzania Agriculture Research Institute (TARI) -Uyole centre in Mbeva Region to experience the implementation of the Accelerated Varietal Improvement and Seed Delivery of Legumes and Cereals in Africa (AVISA).

The team involves representatives of Bill and Melinda Gates Foundation (BMGF), the International Maize and Wheat Improvement Centre (CIMMITY), Alliance of Biovity as well as the International Centre for Tropical Agriculture (CIAT).

TARI Uvole Director Dr Tulole Bucheyeki, said that the BGMF delegate visited experimental trials and seed multiplication farms at TARI Uyole centre, the vital ongoing trials which he observed are focused on improving sugar and red kidney genotypes, particularly large-seeded which will replace the old varieties and respond to the grain market demands.

"In Tanzania AVISA crops were common bean, groundnut, sorghum, and finger millet and these partners during their visit interacted with various value chain actors including Researchers, farmers, seed producers and off takers who are either direct or indirect beneficially of this project," he said.

According to him, BMGF is funding TARI through the Alliance of biodiversity International and CIAT in common bean research under AVISA project that aims to improve the livelihoods of small-scale farmers and consumers of common bean, sorghum, millet and groundnut.

Hai' project areas in Luhundwa vil-

seed multiplication farms, at TARI Uyole centre, had both sugar and yellow varieties that have recently been released, adding: "These two varieties are largely demanded by off takers in the zone and the demand-led breeding approach where knowledge of developing new varieties and multiplying seeds based on

off takers' demanded varieties." During the visit, the BGMF delegate were also able to witness how

researchers respond to client demand by completing the crop chain from off takers (marketers) who provides their need in terms of varieties and other non varietal technologies through market researches and finding made available to direct other researchers (breeders) to respond to market demand this also were highly commendable.

The team from BMGF was represented by Dr Renee Lafitte, Deputy

Director for Crop Research and Development and Dr Jeffrey Ehlers, a Senior Program Officer, also targeted to interact with various value chain actors through the bean corridor approach and determining how the operation has improved business among the actors.

"During the visit, we also got ample opportunity to share with them (the stakeholders) key updates on activities conducted, achievements mentation of the project. But also, the linkages between TARI, seed companies, grain aggregators and producers and how it has helped in opening the business opportunities to other value chain actors including seed producers, input suppliers, financial institutions and mechanization were highlighted," Dr Bucheveki added.

The visitors also applauded TARI

for playing a crucial role in connecting the value chain actors, training the farmers on Quality Declared Seed (QDS) and good agronomic practices as well as postharvest handling.

"With increasing world population, climate change and vulnerability, insect and disease insurgency and multiple land use while the land is constant, human beings should find a shortest path of increasing food production," he insisted.

Through positive linkages with TARI, he expressed, the majority of farmers in the Northern Highlands are fully engaged in bean marketing and their grain quality is premium according to end users of the crop. "The quantities of the grain have also increased substantially since they started working with the farmers," he bragged.

He further stated that the robust project has so far helped to attract more women into the bean industry within the country.

"A good example is the Mbeya-based Zinduka women's group with 21 members who are based in the Mshewe village within the southern highlands of Tanzania," he said.

So far, he said the group's productivity has increased from 300 kilograms to 1,750 kilograms per hectare between 2013 and 2019 respectively, added that as a result, group members have built permanent houses and installed electric power and tape water.

"From the proceeds, they're now standing on a better side to pay school fees for their children and build stores for their produce," he divulged.

AVISA project coordinator Dr Chris Ojiewo congratulated all the participants in the visit for their exemplary work and the successful visit.

## Experts warn novel treatments for parasitic worm diseases a needed

ADVANCES in biology and medicinal chemistry, in conjunction with rising investment in research, have led to the development of promising new candidate treatments for some of the main neglected tropical diseases (NTDs) in recent years.

However, scant progress has been made on parasitic worm diseases, which affect more people worldwide than other NTDs in absolute numbers, in terms of moving on from in vitro studies to clinical and pre-clinical trials.

This is one of the conclusions of a study published in the journal Drug Discovery Today by researchers affiliated with the University of São Paulo (USP) and Universidade Guarulhos (UnG) in

"Over a billion people in the world are affected by helminth [parasitic worm] diseases, but these are the NTDs with the least treatment of all. Some 250 million people have schistosomiasis, for which there's only one drug, while more funding is allocated to the other NTDs for the pursuit of treatment options," said Josué de Moraes, one of the three co-authors of the article. Moraes is a researcher at UnG supported by FAPESP and leads the university's Center for Research on Neglected Diseases (NPDN).

In 2021, the World Health Organization (WHO) issued an action plan to eradicate 
Innovation and Disseminaor control 20 diseases that affect one in five people worldwide and kill some 500,000 per year by 2030. The vast majority of the people who suffer from these diseases are poor. The goals include development of novel medications, given the lack of effective treatments and vaccines for the diseases in question.

In the study just published, the researchers note that despite a longstanding lack of innovation in drugs for these diseases, partnerships between public, private and nonprofit entities have funded and accelerated the discovery of possible novel medications using advanced medicinal chemistry strategies.

"Drug development strategies have undergone deep-seated changes in recent years. In the past, researchers performed random screening and testing of compounds on infectious agents by trial and error. With the advance of medicinal chemistry, as well as enhanced experimental and computational tools, we can now conduct more rational screening before embarking on laboratory trials," said Adriano Andricopulo, also a co-author of the study. Andricopulo is a professor at the São Carlos Institute of Physics (IFSC-USP) and a researcher at the Center for Innovation in Biodiversity and Drug Discovery (CIB-Far)-one of the Research,

tion Centers (RIDCs) supported by FAPESP.

As the researchers show in the article, major progress has been made in developing candidate treatments for leishmaniasis, Chagas disease and African human trypanosomiasis (AHT), also known as sleeping sickness. The same is not true of schistosomiasis and other helminth diseases.

Several compounds for leishmaniasis are currently being tested in clinical trials. Studies on Chagas disease, in contrast, face difficulties in progressing from the drug discovery stage to the preclinical stage. The complex biology of the parasite that causes the disease, Trypanosoma cruzi, and its interaction with different types of human tissue continue to represent a daunting challenge for scientists.

"Most parasitic diseases are silent and chronic. In the case of Chagas, when a patient is diagnosed, it's typically because they already have heart failure, and the parasite has infected cardiac tissue. The challenge is how to have the medication reach T. cruzi without harming the patient," Moraes

The authors add, however, that recent studies have pointed to novel molecular targets and parasite signaling pathways, which could contribute to the development of new treatments.

or 30 years, Tomasa Chávez visited the Central nos Aires and rummaged through the tons of fruits and vegetables that the stallholders discarded, in search of food. Today she continues to do so, but there is a difference: since 2021 she has been one of the workers hired to recover food as part of a formal program launched by the Central Market.

"Before, I used to come almost every day and collect whatever was edible and whatever could be sold in my neighborhood. Food, cardboard, wood... Now I still come to separate edible food, but I work from 7:00 to 15:00 and I get paid some money," the short, good-natured woman told IPS.

The Central Market of the Argentine capital is a universe that seems vast and unfathomable to those who venture into it for the first

Covering 550 hectares in the municipality of La Matanza, on the outskirts of Buenos Aires, it is full of life; to describe it merely as a central market that supplies fruits and vegetables to a metropolis of 15 million inhabitants would be an oversimplification.

In the market there are large companies and small businesses, streets, avenues, warehouses, buildings and even areas taken over by

# Recovering edible food from waste provides environmental and social solutions in Argentina

are also large empty areas where everything is quiet.

Nearly 1,000 trucks enter the Central Market every day to pick noise is overwhelming, but there stores of the city and Greater

Buenos Aires. Every month, 106,000 tons of fruits and vegetables are sold, according to official data.

There is also a retail market with food of all kinds, attended by thousands of people from all over the city, in search of better prices than in their neighborhoods, in a context of inflation that does not stop growing - it already exceeds 60 percent annually - and which is destroying the buying power of the middle class and the poor.

As a reflection of the social situation in Argentina, where even before the COVID-19 pandemic the poverty rate exceeded 40 percent, a common image of the Market has been that of hundreds of people like Chávez rummaging through the waste, looking for something to eat or to sell.

But since August 2021, much of that energy has been poured into the Waste Reduction and Recovery Program, which is based on two main ideas: to use food fit for consumption for social assistance and the rest for the production of compost or organic fertilizer to promote agroecology.

'There was a social and environmental problem that needed to be addressed. Today we have fewer losses, we provide social assistance and create jobs," Marisol Troya, quality and transparency manager at the Central Market, told IPS.

#### Coping with the crisis

The 12 gigantic bays where fruits and vegetables are sold wholesale are the heart of the Central Market. which employs 800 people and where a total of 10,000 people work every day.

At 2:00 a.m. the activity begins every day in the market with frenetic movement of crates containing local products from all over Argentina and neighboring countries, which are a festival of colors. Each bay has 55 stalls.

"The search for food among the Market's waste was spurred by the economic crisis and the pandemic," said Marcelo Pascal, a consultant to the management. "We realized very quickly that there was a lot of merchandise in good condition that was discarded for commercial reasons but could be recuperated.

"There were even small stands that used vegetables found in the garbage. A lot of edible products were recovered, but the process was disorderly, so an effort was made to organize it," he told IPS.

From August 2021 to June 2022, 1,891 tons of food were recovered for social aid, while 3,276 tons have been used to make compost, according to official figures from the Central Market, which is run by a board of directors made up of representatives of the central, provincial and city governments.

"We have reduced by 48 percent the amount of garbage that the Market was sending to landfills for final disposal, which was 50 tons a day," agronomist Fabián Rainoldi, head of the Waste Reduction Program, told

#### Orderly recovery of edible products

a crate of bruised tomatoes, impossible to sell at a store, but many of which are ripe and edible. His task is to separate the edible ones from the waste.

"I live here in the Market, in the Hogar de Cristo San Cayetano, and six months ago I got this job," Ayala said, referring to the rehab center for addicts that opened in 2020 inside the Market it-

"There were always a lot of products to recover in the Market, but now we do it better," added Ayala, who is one of the workers hired for the Program.

He clarified, however, that the scenario varies depending on the temperature. "In summertime, because of the heat, the fruits and vegetables last much less time and the stallholders throw away more products. Now in winter we don't find so much."

The workers work in eight of the market's 12 bays. There are a total of 24 workers, divided into groups of three, who separate the merchandise that the stallholders are asked to leave in the center of the bay.

The recovered goods are loaded onto trucks that are taken to a huge warehouse in the Community Action section of the Market, where they are prepared for use in social aid projects.

"We deliver food to 700 soup kitchens, according to a weekly schedule: about 130 per day," said Martin Romero, head of the Community Action section, where 22 workers perform their duties, as the first vehicles begin to arrive to pick

up their cargo. "We also put together eight-kilo bags, with whatever we have available, which we deliver to 130 families," he added to IPS.

What is not fit for human consumption ends up in the composting yard, a plot of land covering almost three hectares, where the process of decomposition of organic matter takes about four months.

"The organic waste is mixed with wood chips made from the crates, which absorb water and reduce the leachate that contaminates the soil. The organic compost is donated to agroecological gardens which use it for fertilization and the recovery of degraded soils," explained Rainoldi.

## **CONSTRUCTION OF WALLS TO PROTECT** HISTORICAL MIKINDANI TOWN STARTS

ONSTRUCTION of walls and grovnes along Mikindani beach in Mtwara Region kicked off yesterday to interrupt flow of salty water that threatens to destroy Mikindani heritage site—a historic town dating back to the 16th century.

Deputy Permanent in the Vice President's Office (Union) Abdallah Mitawi yesterday handed over the construction site to Mtwara-Mikindani Municipality and the contractor Dezo Civil Contractors Company on behalf of the Permanent Secretary in the Vice President's Office Mary Maganga.

He said the completion of the wall and groynes construction project will help solve the challenge of the effects of climate change facing the heritage site and residents of the area.

Mitawi said the project will involve the construction of wall and groynes to prevent the effects of salt water entering the residential areas of more than 790 meters and also several walls more than 1,000 meters high will enter the sea.

duced," he said.

## **Interest rates** predicted to hike as South Africans brace themselves for a tough July

SOUTH Africans, already battling to keep their heads above water, are likely to be hit again later this month when the MPC meets with all signs pointing to yet another interest

Adding to the woes of homeowners - some who bought at the edge of their capabilities when interest rates were at a record 50-year low - is that some experts have predicted a bump of 75 basis points.

This means that depending on the size of your bond you could be adding hundreds or even thousands to your monthly bond repay-

Added to that, while some estate agencies say they are still seeing first-time home buyers enter the market, the rising interest rates have put a cap on their buying powers.

And, while the property buying market hasn't drastically waned yet, a top estate agent boss has warned agents themselves to save for a rainy day, as sales could be contracted in the months to come, and this could put pressure on their earnings.

Latest FNB stats have shown an already significant number of South Africans being forced to sell their homes because of financial pressure.

With this month's electricity price hike and a food basket costing more and more each month plus fuel set to hit record highs from midnight, South Africans are going to have to think out of the box to hold on to their homes.

Existing homeowners and buyers alike should check what their repayments will be at various interest rate levels, advises Goslett.

The amount grows the higher the loan amount is. For example, on a R2 million home loan taken over 20 years, the repayment amount could grow by over R2000.

"Equipped with this knowledge, existing homeowners can work out where to cut back to afford the higher repayments.

"For buyers, preparing a table looking at all the permutations can ensure that they purchase a home that they can truly afford even if interest rates climb further," says Goslett.

Carl Coetzee, chief executive of BetterBond, also advised that after more than a year of record-low interest rates, "consumers need to look at their monthly expenses and what they can afford as interest rates start to once again

"Those who have the financial means to do so are advised to pay extra into their bond if they can to reduce the amount of interest payable over the whole loan period," he adds.

"Also, start building a savings buffer so that you have the financial reserves to manage rising prices - fuel, food, and bond repayments - if necessary. Look at your household budget and cut costs to reduce monthly expenses."

## TRC TO APPLY PPP IN BUILDING KIGOMA-BURUNDI RAILWAY LINE

ANZANIA Railway Corporation (TRC) has opted to use the Public Private Partnership (PPP) in the construction of a railway line from Uvinza in Kigoma Region to Gitega city in Burundi (282kilometres.

According to the agreement signed by the Minister's for Finance and Infrastructure from Burundi and Tanzanian on January 28 this year, Tanzanian's railway portion will take up 156 km Uvinza-Malagarasi rail section whereas the Burundi part starts from Malagarasi to Musongati and onward to Gitega, which is 126 kms long.

Speaking after touring the 46th Tanzania International Trade Fair 2022 in Dar es Salaam yesterday, TRC director general Masanja Kadogosa said that currently, procurement procedures were underway.

"Private sector in the country including the financial institutions is ready to be part of the coming construction and we are ready to involve them. I call on members from the private sector to get ready and become part of the construction," he

Kadogosa said once the construction was over, the project would unlock trade opportunities between the two countries and with other neighbouring countries.

He said TRC had already completed the renovation of the meter gauge railway - Tanzania - Intermodal & Rail Development Project (TIRP) , a US \$ 300 million World Bank-funded project



for the revival of the meter-gauge railway network in Tanzania.

The project intended to rehabilitate the meter-gauge railway from Dar es Salaam to Isaka (970km) to increase its capacity of carrying freight from date 13.5 tonnes axle load to 18.5 axle loads.

He said one great achievement reached by TRC was expanding the country's rail network with

the construction of a Standard Gauge Railway (SGR) to replace its meter-gauge railway.

Other was to increase in carriage of cargo from 180,000 tonnes to 400,000 tonnes up to

Speaking after the signing ceremony early this year, Minister for Finance Dr Mwegulu Nchemba said Tanzania has considerable experience in sourcing for funds for implementing strategic projects of this kind, in like manner as it did in relation to the other parts of the SGR construction, he stated, referring to the Dar es Salaam-Morogoro and then to Makutupora SGR portions.

The proper cost for the Burundi link will be set out after the completion of engineering studies, but it was estimated at around \$900m.

Prof Mbarawa said project implementation will start in the near future, billed to bring into use modern fast trains travelling at 160 km/hour or thereabouts.

"This project is important for our country, Burundi as well as Congo DRC that use the port of Dar es Salaam for its imports," he said, underlining that the completion of the project will simplify cargo transportation.

# Chinese real-estate developers are accepting wheat, Garlic, peaches as down payments for properties

IN China's depressed realestate market, desperate developers are accepting wheat and garlic as down payments for rural properties to boost

The alternative payment method comes as analysts expect property sales in China to have dropped by 25% from January to June amid China's zero-Covid strategy.

China's citizens are also shying away from real-estate investments, preferring to hoard cash in China's uncertain economic climate.

To boost sales, property developer Central China Real Estate is offering a "swap wheat for house" promotion for homes in Minquan County, Henan Province, CNN reported, referring to a now-removed ad on the company's official WeChat account. Priced at 2 Chinese yuan (\$0.30) for every catty (21 ounces), buyers can pay up to 160,000 yuan (\$23,900) of their down payment with wheat. Prices of houses in the development range from 600,000 yuan (\$89,550) to 900,000 yuan (\$134,300.)

The promotion will end on July 10 and is targeted at farm-



ers in the region, an agent from Central China Real Estate told Business Standard.

The company is no stranger to launching marketing campaigns targeting farmers. At the start of China's garlic season in May, the company accepted garlic as payment for another project in Henan Province, per the development's official Wechat account.

"On the occasion of the new garlic season, the company has made a resolute decision to benefit garlic farmers in Qi County," the company wrote in the WeChat post. "We are helping farmers with love, and making it easier for them to buy homes," it added.

Central China Real Estate fell by 40.4% in net profit in 2021, per the firm's 2021 Annual Investor Relations report. The company did not immediately respond to Insider's request for comment.

The marketing strategy is not limited to one developer: Two other developers in the eastern Chinese cities of Nanjing and Wuxi were accepting watermelons and peaches from farmers according to state-run media outlet China News Weekly.

Chinese real-estate developer defaults renew fears of contagion to financial markets

The gloom in buyer sentiment is

exacerbating stresses for Chinese property firms, with another large real-estate developer defaulting on its debt. On Sunday, Shimao Group announced it missed interest and principal payments on \$1 billion of

offshore bonds due on the same day.
"Due to the significant changes to
the macro environment of the property sector in China since the second
half of 2021 and the impact of COVID-19, the Group has experienced a
noticeable decline in its contracted
sales in recent months," Shimao
wrote in a Hong Kong Stock Exchange filing. Sales by value plunged
72%in the first five months of 2022

when compared to the same period

in 2021, contributing to the company's liquidity crunch, Shimao added.

Other Chinese developers that have also defaulted on their dollar bonds since December 2021 include Evergrande, Kaisa Group, and Sunac China. The liquidity crisis started after Beijing cracked down on excessive borrowing by property developers

Evergrande was the first major Chinese real-estate developer to default on its debt. This spilled over to other companies as banks tightened sector-wide lending, spurring concerns of a domino effect on China's financial sector and the rest of the world.

The Chinese government has stepped in to manage Evergrande's crisis, but with more Chinese property firms defaulting recently, contagion fears are resurfacing among investors. Dutch bank ING expects more property developer bond defaults in the second half of 2022 and into 2023, Iris Pang, its Greater China chief economist, wrote last week.

That's even though home sales have improved recently after Beijing pledged in March to support the property market. China's property sales in May fell 31.8% on-year an improvement from the 39% plunge in April, according to Reuters calculations using official statistics.

"Although this is a positive move for home sales, it is not positive for property developers that have defaulted on their bonds, whether onshore or offshore, as potential home buyers will stay away from homes sold by those developers to avoid non-completion risk and aftersales property management risk," wrote

"With developer debt stress expected to persist, authorities will probably continue to focus on boosting home sales to stabilize conditions by year-end rather than resort to bailing out developers," wrote analysts from the Eurasia Group, a risk consultancy, in a note on June 24.

## Boris Johnson digs in as ministers, lawmakers desert UK government

LONDON

PRIME Minister Boris Johnson was defiantly hanging onto power yesterday despite the resignation of four top ministers and a seemingly unstoppable revolt by his own lawmakers, threatening to paralyse the British government.

More than 50 ministers have quit the government in less than 48 hours, saying Johnson was not fit to be in charge after a series of scandals, while dozens in his Conservative Party are in

Brandon Lewis, the Northern Ireland Secretary, became the latest Cabinet minister to quit early on Thursday, following the resignations of the finance, health and Welsh ministers.

"I cannot sacrifice my personal integrity to defend things as they stand now," Lewis said. It is clear that our party, parliamentary colleagues, volunteers and the whole country, deserve bet-

A delegation of senior ministers and a senior figure representing Conservative lawmakers who are not in government went to Downing Street on Wednesday evening to tell Johnson he needed to go and to make a dignified exit.

But he refused to budge, and even sacked Michael Gove, one of his most effective ministers who, according to media reports, had told the British leader he should quit.

Opposition lawmakers said the chaos meant government could not function. Committees due to meet on Thursday to scrutinise legislation, including the National Security Bill, were being cancelled because there was no minister available.

"I do think the time has come for the prime minister to step down," Suella Braverman, the attorney general for England and Wales, told ITV late on Wednesday, although she said she herself would stay in post. "If there is a leadership con-

test I will put my name into the ring."

"The prime minister is deluded if he feels he can cling on in the face of collapsed parliamentary support," said a senior Conservative lawmaker on condition of anonymity. "He is embarrassing the Conservative Party and showing contempt for the electorate."

But culture minister Nadine Dories said she was behind Johnson and, when asked if others also still backed him, she replied: "Yes, definitely."

The dramatic resignations on Tuesday of his health and finance ministers triggered a growing swell of other ministerial departures and many Conservative lawmakers questioned his fitness to govern.

At parliamentary questions on Wednesday, some Conservatives struggled not to laugh when others poked fun at him and he took a pummeling from a committee of senior politicians over his past behavior, his motivation and some of the scandals that have come to define much of his tenure.

#### 'Enough is enough'

The ebullient Johnson came to power nearly three years ago, promising to deliver Britain's exit from the European Union and rescue it from the bitter wrangling that followed the 2016 Brexit referendum.

Since then, some Conservatives have enthusiastically backed the former journalist and London mayor while others, despite reservations, supported him because he was able to appeal to parts of the electorate

that usually rejected their party. That was borne out in the December 2019 election. But his administration's combative and often chaotic approach to governing and a series of scandals have exhausted the goodwill of many of his lawmakers while opinion polls show he is no longer popular with the public at large.

In addition to the scandals, there have also been policy U-turns, an ill-fated defense of a lawmaker who broke lobbying rules, and criticism that he has not done enough to tackle inflation, with many Britons struggling to cope with rising fuel and food

Despite even one-time supporters saying the current crisis could only end with his resignation, Johnson's spokesperson said he was confident of winning another vote by his party.

All might change next week when the 1922 Committee that sets the rules for the Conservative parliamentary party holds an election to its executive that could usher in a rule change to allow a second confidence vote on his leadership.

Johnson has tried to reassert his authority by quickly appointing Zahawi, a rising Conservative star widely praised for the successful rollout of COVID-19 vaccines, as finance minis-

In parliament, senior ministers struggled to contain their laughter as the opposition Labor leader poked fun at his cabinet for being in the "charge of the lightweight brigade".

"At some point, we have to conclude that enough is enough. I believe that point is now," said Sajid Javid, in his resignation speech as health minister, with Johnson listening stony-faced.

## Iran says it arrested UK deputy envoy, foreigners for 'spying'

IRAN'S Islamic Revolution Guards Corps arrested the British deputy ambassador and other foreigners for "spying" activities such as collecting soil samples in prohibited areas, the official IRNA news agency reported Wednesday.

According to a video released by the IRGC Intelligence Organization, the IRGC has identified some diplomats of foreign embassies, including the British deputy ambassador, who were "spying" instead of carrying out their diplomatic missions, said the report.

"The British deputy ambassador had gone to Shahdad desert (in central Iran) with his family as a tourist, but as the recorded images show, this person was collecting soil samples in this area," the report said.

Western news outlets have identified the arrested British diplomat as Giles Whitaker, the deputy head of mission at the British embassy in Iran.

However, a spokesperson for Britain's Foreign Office said "reports of the arrest of a British diplomat in Iran are completely false.'

Iran also identified, Maciej Walczak, a Polish scientist who visited Iran "under the guise of scientific exchanges," as another arrestee, saying he, as a tourist, went to the Shahdad region in Kerman province, where IRGC was holding a missile test, according to the IRNA report.

He and his companions collected samples of soil, water, rock, salt, and mud from the region near the testing area, the report reads.

Another arrestee is the spouse of a cultural advisor of the Austrian embassy, who visited the villages of Damghan city in Semnan province, and collected samples of the soil of the area, it added.

## **DPR** embassy staff begin work in Russia, top diplomat says

THE Donetsk People's Republic's (DPR) Ambassador to Russia Olga Makeyeva and other embassy staff have already begun their work in Moscow, DPR Foreign Minister



Natalya Nikonorova said in an interview with TASS.

"The ambassador and other embassy staff are already in Moscow, they have begun their work on the political track, as well as on consular, administrative and other issues," she pointed out. According to Nikonorova, the embassy will open on July 12.

The top diplomat noted that the ministry was actively boosting cooperation with the republics who had recognized the DPR. "First of all, it is about the republics who recognized our independence back in 2014," Ninokorova said, referring to the Lugansk People's Republic and South

"The Republic of Abkhazia recognized us in February 2022 and in March, we established diplomatic relations. We continue to strengthen interaction with Abkhazia," the DPR foreign minister added.

## Climate change escalating humanelephant conflicts in Africa

**NAIROBI** 

THE unfolding climate crisis in Africa is behind an upsurge of violent clashes pitting local communities and elephants, senior officials said Wednesday at a virtual briefing convened by Elephant Protection Initiative, a conservation lobby.

Najib Balala, Kenya's Cabinet Secretary for Tourism and Wildlife said climate emergencies, habitat loss and illegal settlements are fueling human-elephant conflicts in the continent, to the detriment of economic progress.

"Climate change is emerging as the key driver of conflict between communities and elephants even as poaching remains a minimal threat to the iconic species," Balala told the forum in Nairobi, the capital of Kenya. More than 50 elephants have lately been killed in Kenya as

a result of retaliatory attacks from subsistence farmers and herders, said Balala, adding that between January to June, the country lost 149 elephants due to acute drought.

As a stop-gap measure, he said, the government has invested in water pans inside wildlife sanctuaries, protective barriers and community engagement to minimize human-elephant conflict in the current drought cycle.

Paula Francisco Coelho, the Secretary of State for the Environment in Angola said despite taming elephant loss due to poaching, African countries are grappling with extreme weather events, shrinking habitats and unsustainable landuse practices that have fueled violent encounters between lo-

cal communities and the giant land mammals.

## Forest Law builds legal protection for ecology

Forest Law took effect in China on July In the past two years, judiciary authorities have strictly abided by the principle stipulated by the law, which requires the country to prioritize ecol-

ogy and protection and pursue sustainable development through a method that combines conservation and afforestation. As a result, a legal protection wall has been built and constantly consolidated for forest ecology. In January this year, a case of destruction of ecological resources proposed

by the Yuelu District People's Procuratorate in Changsha, central China's Hunan province came to trial, which involved illegal logging of 454.84 cubic meters of timber and serious damage to the local woodland.

According to law, the six criminals

in the case were put into jail with sentences ranging from a year to three years and 11 months. Besides, they were ordered to pay over 104,000 yuan (\$15,528) in total to compensate for ecological losses and apologize to the public on media outlets above the municipal level for civil public interest action.

It was the first case in Changsha in which the suspects were requested to compensate for the ecological damages they had caused in the whole process of the crime, including illegal felling, transporting and trading of trees.

The case mirrored the judiciary protection of forest ecology carried out by Chinese judiciary authorities with the strictest system and rule of law.

Since 2019, courts at all levels across China have concluded 403,989 cases of first instance related to forest resources, including 268,180 civil lawsuits.

On June 14 this year, the Supreme People's Court, China's top court, released an interpretation on dealing with forest-related civil disputes, as well as 10 supporting model cases, to improve the system of rules applicable to environmental and ecological laws, and promote science-based protection and utilization of forest resources from the legal perspective.

In recent years, innovative compensation measures were emerging, such as alternative restoration and non-insitu greening.

Procuratorates in southwest China's Guizhou province have introduced civil compensation to the evaluation system of criminal offenses, urging suspects and defendants to restore the ecological environment through afforestation

The people's court in Anji county, Huzhou, east China's Zhejiang province has dispatched 120 court officers to 215 villages and communities to ensure that compensation is made for every criminal case related to environmental

The Intermediate People's Court of Chunlin district, Changchun, northeast China's Jilin province has signed 164 re-greening agreements since 2018,

replanting 886.74 mu (59 hectares) of forests.

"The Forest Law stipulates an approach combining conservation and afforestation, so we should make innovations in the way we restore ecology based on particular forest environment, to ensure a science-based and timely recovery of the functions of the forest ecology," said Xie Deti, a professor with the College of Resources and Environment, Southwest University.

Upholding the concept of restorative justice, judiciary departments are guiding the perpetrators to turn from "destroyers" to "recovers" of the ecological environment, which synergizes the legal, social and ecological effects of the

judicature, Xie said.

Over the past two years, the Forest Law has provided a legal basis for advancing ecological progress, protection, cultivation, and utilization of forest resources, said Wang Xiang, an official with the Legislative Affairs Commission of the National People's Congress Standing Committee, adding that the law is promoting coordinated eco-socio development and forest ecological protection.

To strive for carbon peak and carbon neutrality goals is an important measure for China to address acute resource and environmental constraints and achieve sustained development. Forest is the largest carbon pool in the terrestrial ecosystem. It bears important ecological functions such as carbon sequestration.

## **UN report warns global hunger** figure rose to 828m in 2021

**ROME** 

THE number of people affected by hunger rose to 828 million in 2021, an increase of 46 million from the previous year, the United Nations (UN) Food and Agriculture Organization (FAO) said in a report on Wednesday.

The 2022 edition of "The State of Food Security and Nutrition in the World" (SOFI) report -- drafted by the FAO and four other UN agencies -- carries fresh figures on nutrition and food accessibility at the global level, including the latest estimates of the costs and affordability of a healthy diet.

The report said the number of people affected by hunger has increased by 150 million since the outbreak of the COVID-19 pandemic.

This would risk pushing the international community further away from reaching Goal 2 of the UN Sustainable Development Agenda, which is to end hunger and malnutrition by 2030.

"After remaining relatively unchanged since 2015, the proportion of people affected by hunger jumped in 2020 and continued to rise in 2021 to 9.8 percent of the world population," the SOFI said. "This compares with 8 percent in 2019 and 9.3 percent in

The number of people unable to afford a healthy diet rose by 112 million to almost 3.1 billion, "reflecting the impacts of rising consumer food prices during the pandemic."

The UN agencies added that the actual figure could be even larger once final data on income losses in 2020 become available.

"The ongoing war in Ukraine is disrupting supply chains and further affecting prices of grain, fertilizer and energy," the report warned. "In the first half of 2022, this resulted in further food price increases.

At the same time, more frequent and severe extreme climate events are disrupting supply chains, especially in low-income countries.'

Around 2.3 billion people in the world -- or 29.3 percent of the global population -- suffered from moderate or severe food insecurity in 2021, an increase of 350 million compared to before the pandemic.

Nearly 924 million people -- or 11.7 percent of the global population -faced food insecurity at severe levels, an increase of 207 million in two years, according to the report.

The SOFI also highlighted that "the gender gap in food insecurity continued to rise in 2021," with an estimated 31.9 percent of women suffering moderate or severe food insecurity compared to 27.6 percent of men. Some 45 million children under the age of five suffered from wasting (the deadliest form of malnutrition) last year. Overall, some 149 million children under five had stunted growth and development due to a chronic lack of essential nutrients, while 39 million were overweight.

"Looking forward, projections are that nearly 670 million people -- or 8 percent of the world population -- will still be facing hunger in 2030, even if a global economic recovery is taken into consideration," the SOFI said.

The UN agencies urged governments to "repurpose the resources they are using to incentivize the production, supply and consumption of nutritious foods" in order to help making healthy diets less costly and more affordable

Finally, the report suggested that governments could do more to reduce trade barriers for nutritious foods, such as fruits and vegetables.

Assessing the situation of hunger, malnutrition and food accessibility at media content creator, told Xinhua the global level, the SOFI is jointly published every year by the FAO in cooperation with the International Fund for Agricultural Development, the United Nations Children's Fund, the UN World Food Programme and the World Health Organization.

## Young Africans see China as most influential country

YOUNG Africans consider China as the country wielding most influence on their continent, according to the "African Youth Survey 2022" commissioned by South Africa's Ichikowitz Foundation last month.

The survey, which was conducted in 15 African countries, showed that 76 percent of young people view China's influence as positive while 77 percent see China as the foreign country with most influence on their continent.

Ivor Ichikowitz, chairperson of the Ichikowitz Foundation, told Xinhua that the African youth have faith in the future of the relations between China and Africa.Chinese products, ranging from clothes and plastic products to home appliances, can be found on the shelves of street stores as well as large shopping malls across Africa.

"I have many Chinese-made household appliances and a washing machine, they have helped me a lot," says Kenyan actress Fridah Mure, adding that Chinese products are both affordable and made with high-quality standards.

In recent years, young Africans buyers have been attracted not only to Chinese-made necessities, but also to electronic products from Chinese manufacturers such as Huawei and OPPO, and to applications such as TikTok.

"China is the manufacturing center of the world. Most of the products we consume would come from China, both in terms of technology and other areas you know," Martin Githinji, a 30-year-old Kenyan social at the launch of the newest Tecno smartphones in Kenya's capital Nairobi on June 20.

## China's biological economy gets on higher stage

CHINA is one of the countries in the world that boast the greatest tems of the biological industry, the

team completed the evolution of breeding technology; in Zhangjiang new hopes; in Heze, east China's Shandong province, 229 million kWh of electricity is generated annually with a straw-fueled condensing turbine and a high-temperature and high-pressure water cooled vibrating grate, which helps reduce emission of 100,000 tonnes of carbon dioxide and 1,500 tonnes of sulfur dioxide.

Technological breakthroughs are constantly being made. Artemisinin earned China the first Nobel Prize in the field of physical science. Currently, China ranks second in the world in terms of the number of innovative drugs developed, and also enjoys comparative advantages in domains such as gene detection, super rice, artificially synthesized starch, and vaccines.

Industrial innovation stays active. In recent years, 1/3 of the enterprises listed on the Shanghai Stock Exchange's sci-tech innovation board were engaged in the biological sector. Between 2016 and 2020, the R&D spending of pharmaceutical enterprises above designated size, or those with annual main business revenue of 20 million yuan (\$2.99 million) or more, was growing 8 percent on average each year. Today, China's biological fermentation products account for over 70 percent of the global market share.

Regional agglomerations are taking shape. In the sector of biological economy, the Beijing-Tianjin-Hebei region, Yangtze River delta, Guangdong-Hong Kong-Macao Greater Bay Area and Sichuan-Chongqing economic circle have become new high grounds of innovation. They are home to around 80 percent of

To create a sound environment for innovation and development of biotechnologies, the plan also proposes to set up several pioneer zones to pilot reforms in key links of biological economy, such as sci-tech innovation, admission, and regulation.

She appealed to fellow artists to learn not to force themselves into having expensive possessions that they can hardly afford.

Shamsa stressed: "They should further not compare their lives with other people's so that they can live peacefully.'

"They will otherwise suffer humiliation for seeking to live a fake life, showcasing they own certain things while they hardly do," Shamsa disclosed.

# Registration output indicates higher competitiveness in CAF tournaments

RENETIC activity is being noticed in the manner in which the leading Premier League sides, especially the top three now gearing for continental tournaments, are seeking out players from near and far to strengthen their strength in various departments.

Even newly crowned Premier League champions, Young Africans SC, alias Yanga, who earlier seemed content with the squad they built or administered over the past year, have spared no effort in seeking out some key

Neither Yanga nor their next street rivals have said for sure who among their foreign professionals will stay or leave, some were removed a bit earlier.

Who precisely makes the continental competitions was decided at the last minute in the Azam Sports Federation Cup final encounter between Yanga and versatile Coastal Union.

Everybody knew the Tanga club, somewhat middleranked in the final Premier League standings, would put up their very best- and an additional run- to hit the continental bar.

In addition, it was clear that the league winners would have a difficult time putting up the game required to put away a spirited challenge, being engrossed with festivities nearly the whole week earlier, with the FA Cup being little more than a prestige addition.

There was a joking atmosphere as to who wished for a Yanga win in the final and who would have wished

for something else, but that assumes there is a psychic input in the result, as to which was the more popular

to the sponsoring firms of the three top sides.

Again, with an effort, the gold miners can build a better squad at short notice as they have deep pockets, even if their spending plans are yet to hit any headlines as yet, but the mere fact that they are making an effort at holding to George Mpole vainly, many will swear - and tapping others is noticeable.

It is a side with financial potential, unlike the struggling Premier League sides.

At the same time, the hitherto dormant Azam FC is showing airs of revitalization in recruitment, going some ways to compete with the city archrivals for signing George Mpole, aside from its other solo efforts.

Being assigned uncontested club sponsors to whom the management is accountable will in a sense be accompanied by a vision of what is to be done, to recover the glory that the club enjoyed at the start.

Similarly, the side has started to build a sort of fan base, that it isn't just Simba SC, Yanga grey matter.

While the collapse of regional competitions has diminished somewhat the soccer flavour in the months that follow the end of the season, the solid achievements of Simba SC and repeated admission of four teams in the regional tournament are kind of making up for this loss.

When four capable teams can play more than one round at least, the fans are likely to have plenty of entertainment and also much to talk about, well beyond reducing the continental run to the local rivalry, discounting all other teams or issues.

Were it that Azam FC and Geita Gold FC put their resources to beef up club needs, and both put up a reasonable show in the CAF runs as Yanga might conceivably do as well, the soccer scenario would be altered

It would be much more pluralistic, though it could take some years.

He revealed the offers came about because of the good performance Suleiman showed in the 2021/22 Azam Sports Federation Cup final between the Tanga squad and Yanga at Sheikh Amri Abeid Stadium in Arusha last

Suleiman did not only score a hat-trick in the clash which ended with Yanga winning 4-1 in the penalty shootout but also troubled Yanga's defense.

Mgunda noted: "A player's transfer from one team to another as soon as Premier League comes to an end is unavoidable, teams compete to acquire player's sign by coming up with good offers."

"If you know your financial status is limited, why stop a player to move elsewhere?"

"I don't want to, in one way or another, stop a player from moving on if he gets a good offer, it's sin.'

The gaffer revealed: "The negative effect of prohibiting player from moving to other outfit is that you are creating hatred between you and the player, frustrating good relationship."

He further disclosed that he is pleased with Coastal Union midfielder Victor Akpan's move to Simba SC for next season's Premier League.

Suleiman had earlier conceded to have received many offers from various teams but Coastal Union remained his priority, whenever an agreement with another outfit would not be sealed.

The midfielder re-"Despite many vealed: offers I have received I'm waiting for my bosses' say, if we fail to agree, I will find another outfit."

## Ronaldo signing ruled out by Bayern CEO

BAYERN Munich have no intention of signing Cristiano Ronaldo from Manchester United this summer, with CEO Oliver Kahn stating that a deal for the 37-year-old would not "fit with our philosophy.

Sources have told ESPN that Ronaldo has informed United bosses that he would like to move during the transfer window, with Bayern, Chelsea and Napoli cited as potential destinations.

But, according to Kahn, Bayern will not be making a move for the Portuguese great.

"As highly as I rate Cristiano Ronaldo as one of the greatest, a transfer wouldn't be a fit with our philosophy," he told German magazine Kicker.

Bayern's attack has long been led by the prolific Robert Lewandowski, however the 33-yearold has told the Bundesliga champions that he wants to leave the Allianz Arena this summer.

Sources have told ESPN that Barcelona made a third offer for Lewandowski last week, worth more than €40 million. Kahn has publicly insisted that the Poland striker is not for sale.

United similarly insist that Ronaldo, who scored 24 goals last season, is not available for transfer and that new manager Erik ten Hag "wants and expects" him to be part of the squad next season.

However, sources have told ESPN that in reality that stance is softer, although they would prefer Ronaldo moved abroad rather than join Premier League rivals Chelsea. He has a year left on his contract at Old Trafford with the option of another year.

Ronaldo is keen to continue playing in the Champions League and competing for major honors in the late stages of his career. United missed out on qualification for Europe's top competition and are again making a fresh start under Ten Hag.

Ronaldo was due to begin training with the rest of United's international players at Carrington on Monday but was given permission by the club to take an extended break because of "family reasons."

The squad are scheduled to fly to Bangkok on Friday but sources have told ESPN that Ten Hag does not yet know whether Ronaldo plans to train in Manchester this week or make himself available for the tour.

## **Bullish Laporta says Barca** want to keep De Jong

BARCELONA president Joan Laporta has again said the club wish to keep Frenkie de Jong, despite continuing to negotiate his possible departure with Manchester United.

ESPN reported last week that Barca and United had reached an agreement over a transfer worth an initial €65 million rising to €85m, although the makeup of the add-ons remained a source of discussion.

However, Laporta said on Saturday that he would do all he could to retain De Jong's services, and he repeated the same message at the presentation of new signing Franck Kessie on Wednesday.

"Frenkie is a Barcelona player and, save there was the need to let him go him, he is not available," Laporta

"We do not want to sell him. There are offers for him and if at any moment it was in our interests, we could do a deal, but that is not the case. We don't want to sell

Throughout United's pursuit of De Jong, sources have told ESPN that the player's preference is to remain at Barca, who he joined from Ajax in 2019.

Reports in Spain have said Barca would like De Jong to take a pay cut as they attempt to bring their wage bill down, but sources have told ESPN the Dutch international is unlikely to do so.

De Jong, 25, previously agreed a salary cut when he penned a new deal in 2020 and, over the last 18 months, has earned significantly less than he should have with the promise he will be compensated over the final four years of his deal, which expires in 2026.

Meanwhile, Laporta said a contract offer remains on the table for Ousmane Dembele, who has technically been a free agent since his Barca deal expired last

Laporta said there is "no deadline" for the French winger to decide his future and that his camp "want to keep talking."

The Barca chief also expressed optimism that the club will be able make further signings once they have sold a further 15% of their television rights.

Milan midfielder and Chelsea defender AndreasChristensen haveboth signed on free transfers this week, and sources have told ESPNthat BayernMunich's RobertLewandowski, Leeds United's Raphinha and Sevilla's Jules Kounde remain

Barca sold 10% of their domestic TV rights for €207.5m last week, but the club still need to bring in more capital to be able to operate outside of LaLiga's tough financial restrictions.

"We are working on further signings which can be executed when further commercial deals are in place," Laporta added.

"I won't give a number in terms of how many players will come in. What I will say is we will have a more competitive team next season with the players we have signed and those we will sign."

## PSG's new manager, Christophe Galtier, sounds the part but must hit the ground running

HE good thing about having to wait for so long to be officially appointed is that at least you have plenty of time to prepare. This was especially true for Christophe Galtier, Paris Saint-Germain's new manager and the sixth appointment of the Qatar Sports Investment (QSI) era in charge of the club, as he was more than ready for his first-ever press conference in his new role.

It took what felt forever to officially sack Mauricio Pochettino after 18 tumultuous months in charge and in the mean time, Galtier was getting ready. He had known for days that he would be next to take up position on the Parc des Princes bench, so he was able to think carefully about what to say, how to say it and how to start his era in the right way.

He did just that on Tuesday. He used strong words "discipline", "demanding," "collective" -- when asked about his approach with this squad. His tone was strong and self-assured. He wanted to look the part and start defining the new rules under him, starting with timekeeping. "It's good to see that all the players were on time today..." he said, which

A broad lack of discipline within the squad was an issue under Pochettino, and Galtier knows it. He has already decided that as early as their trip to Japan next week for PSG's preseason tour, there will be team rules and sanctions if they are not followed to the let-

That attention to detail and order is one of the reasons why Paris went for him. Zinedine Zidane was QSI's first choice and their preferred option, but once it was clear that he was waiting for the France job, Galtier became the man and in pivoting to the former Nice coach, PSG went in a direction more oriented around hard work than

Galtier certainly fits that vision, though his relationship with PSG's new sporting director, Luis together in Lille for three seasons -- played a big part. Notable, the decision to bring in Campos was Kylian Mbappe's call. The France star forward wanted to work with him again, like when they were in Monaco at the beginning of it all. Galtier was Campos' call so in a way, hiring Galtier is also Mbappé's call. The Paris-born prodigy is certainly happy with the appointment of the former Nice manager.

But how long will this

harmony last? Galtier knows the rules and pressure he'll face at PSG; he'll also be aware that he and his new team must hit the ground running pretty quickly. There will be a bit of patience, of course: as for every new manager, it is understandable that he will need a bit of time to implement his ideas, and it could well take some time.

One of the reasons why Pochettino was sacked was because the style of football was poor. PSG have to play well even if they fell short in big games, but they rarely did under the former Tottenham manager. Galtier will have to do better.

"When you have such a great squad, you have to also play well, not just win," said Galtier during his introductory press could be a losing battle

Galtier will pull in the same clubs -- Galtier spent sevenand-a-half years at Saint-Etienne, followed by threeand-a-half at Lille and last season at Nice -- Galtier managed to foster a strong, collective spirit and built teams capable of hitting you hard on the counter-

attack, especially Lille. At Nice, Galtier wanted possession and control of games, but his squad struggled to fulfill this brief, with results below what was expected. However, PSG is arguably the best squad he will ever manage and he should find it a little easier to implement his methods and deliver his message. "It's a privilege to have a squad of this level," he added.

Galtier's first idea is to start the season with a three-man defence, which is intriguing because he played with a "flat" 4-4-2 formation at Lille and at Nice. But he believes that the 3-5-2 or the 3-4-1-2 will ultimately be the right formation for this squad, but it will come with puzzles to solve higher up the pitch. For example, he'll have to decide where to play Lionel Messi in this "back three" system. And what if Neymar ends up staying? There's no way to accommodate Mbappe, Messi and the Brazilian in a formation with three defenders. It begins depending on PSG's transfer business.

He will also have to

untangle the hierarchy between the posts. With two world-class goalkeepers in the squad last season, Pochettino chose to not name an official between Gianluigi Donnarumma and Keylor Navas, but it will be different under Frenchman. Expect him to make a call and stick to it: it's also worth noting that in his career as a manager, his reserve goalkeeper at the start of the season never became the No.1 over

Overall, Galtier hit all the right notes at his unveiling, but he will need to quickly convince fans, QSI and the players of his vision. It's not just because he only signed a two-year contract (with the option of a third season), but also because he knows that there is scepticism around his appointment: he is from Marseille, he is not a big name, he has been successful as a coach, but while setting up his teams to play quite basic football. A lot of the ultras are reportedly not impressed by his arrival.

The short deal offered to him also shows that PSG as an organization are waiting to see if he will be up for the task. At times in recent years, PSG has proven too tough for most. Can Galtier

## Jury finds man guilty of murdering rapper Nipsey Hussle

A 32-year-old man who grew up on the same streets in the same gang as degree murder in the 2019 shooting of the Grammywinning rapper, who rose above his circumstances to become an inspiration to he was eventually gunned

The Los Angeles County iurv also found Eric R. Holder Jr. guilty of two counts of attempted voluntary manslaughter for gunfire that hit other men at the scene. Prosecutors had sought two counts of attempted murder. Holder also was found guilty of two counts of assault with a firearm on the same men.

Holder, wearing a blue suit and face mask, stood up in the small court room next to his lawyer as the verdict was read. He had no visible reaction. His lawyer, Deputy Public Defender Aaron Jansen, conceded during the trial that Holder shot Hussle, 33, whose legal name is Ermias Asghedom, but had sought a lesser verdict of voluntary manslaughter.

Jansen said in an email that he was deeply disappointed in the first-degree murder verdict.

"It was always going to be tough given the high profile circumstances surrounding the case," Jansen said.

He added that he and Holder were grateful that the jury agreed that the attempted murder counts were overcharged. They plan to appeal the murder conviction, he said.

A jury of nine women and three men deliberated for about six hours over

the verdict. Most of their deliberations took place Friday, and they promptly came to their unanimous decision Wednesday, Nipsey Hussle was found briefly reconvening after guilty Wednesday of first- a four-day break. A pair of typos on the verdict form discovered as the results were read forced jurors to briefly return to deliberations before the outcome the neighborhood where could be made official, but they had no bearing on the

"We are both proud and I am a little relieved that the verdict came in a complete, absolute agreement with the charges that Eric Holder murdered Ermias Asghedom in cold blood," Deputy District Attorney John McKinney said outside the courtroom. The verdict brings an end to a legal saga that has lasted more than three years and a trial that was often delayed because of the pandemic.



He was a widely beloved figure in Los Angeles, especially in the South LA area where he grew up and remained after gaining fame, buying property and opening businesses.

A year after his death, Hussle was mourned at a memorial at the arena then known as Staples Center. and celebrated in a performance at the Grammy Awards that included DJ Khaled and John Legend.

It was more than two years after that when the man who shot him would go on trial.

"Today was really about Nipsey Hussle and the legacy that he leaves behind," McKinney said Wednesday. "This verdict and the story of his life will be talked about for sure at Crenshaw and Slauson, but the meaning of it will carry far beyond those streets."
