Northern pastoralists this year alter grazing migration patterns

NOMADIC pastoralist communities in the northern zone seem to have revised their movement patterns and dates in view of rainfall and grazing areas hazards tied up with effects of climate change.

Maasai cattle keepers at Longido and Monduli reportedly started moving from their locations as early as May.

This actually happens to be four months earlier, compared to usual migration time starting in September, moving with their livestock in search of water and pastures. This time the pastoralists seem to be fleeing drought, as average rainfall for the area dropped to less than 50milimeters during the heavy rains period, a district council official said.

Ally Msangi of the Longido District Council says the usual rainfall expectation is 500mm to 900mm of precipitation in a year, while this year the district weather unit rain gauged 45mm of rain, a shocking drop by any standards.

The long rains commence at mid-March and continue intermittently all the way to early June but this year March to April rains failed, so the Maasai in Longido and Monduli started to migrate in May.

Some took their cattle across the border into Kenya and others went south to other districts and regions, expecting pastures back home to be replenished.

Musa Juma, executive director of Media Aid for Indigenous and Pastoralist Community (MAIPAC) lobby, says that when pastoralists move out other people invade the vacant

MPs: NHC ought to collect debts, restart big projects

THE National Housing Corporation (NHC) has been told to increase the speed of debt collection from defaulting debtors to enable it implement big projects.

Dar targets Africa's bread basket status ahead of key policy forum

She was speaking at the Tanzania Agribusiness Investment Summit 2022 (TAI Summit 2022) themed "Grow, Nourish, Reward - Bold Actions for Resilient Food Systems in Tanzania" in Dar es Salaam

The local event was convened to prepare for one of the largest global agriculture forums, the Africa Green Revolution Forum (AGRF) 2022, where the minister sought to lay the framework for a national plan ahead of the AGRF Summit in Kigali next week, as President Samia Suluhu Hassan is expected to be a keynote speaker.

The ministry in collaboration with Agriculture and Livestock ministries where the Tanzania Investment Centre (TIC) coordinated the liaisons and helped to organize the one-day TAI Summit 2022, with experts from public institutions and the private sector being involved, with civil society and donor agencies.

Officiating at the start of work meeting for regional police commanders and senior officers from headquarters at the Tanzania Police School (TPS) in Moshi yesterday, the president said she had all the evidence that officers were taking fuel for their own interests.

Such officers were refuelling on business vehicles like commuter buses and private cars while police field vehicles are often found with no fuel, disrupting daily operations and patrols, she

She expressed satisfaction with efforts by the Inspector General of Police (IGP) to ensure that fuel funds were going to districts, hinting that there is information that districts are not supplied with fuel as senior officers take the fuel for business activities.

She said the government has been spending a lot of money to purchase the fuel for the purpose of serving citizens but inappropriately the fuel ends up in the hands of dishonest

"We will not tolerate this huge mistake. IGP, go and supervise to ensure that the fuel reaches the targeted areas," she emphasized, similarly pointing at misuse of the money in the funeral fund. A majority of officers do not benefit from it when such challenges occur, including death.

The fund is meant to support police force staff, but expenditures are conducted outside the rules, she said, referring to the annual report of the Controller and Auditor General (CAG) who requested a special audit on the fund.

She cautioned against seeking for or accepting sponsorships for work meetings as this can weaken its operations. The meeting at Moshi has six sponsors from both the public and private sector, "and these are human beings who will one

day conduct offenses and make it difficult for you to work on them," she told the gathering.

Lack of training for police officers was a major cause for ethical challenges in the force, a failing she said will be corrected. Committee chairman, David Kihenzile made the directives here yesterday shortly after meeting with the officials of Ministry of Investment, Industry and Trade.

Kihenzile said that the project has been 124 years ago and has been sung without being implemented.

"This project should start now and we have directed the people to be compensated this year. They planned to do a review so that later they start paying, now we have only advised them that if possible by December the government should find a way to get money to pay the people, because for a long time the people have reserved those areas," he said.

He said the mission of the committee is to see that the projects are now being implemented, noting that the government is implementing 17 strategic projects of which three are in the committee including the project.



UNHCR hails govt's move to issue birth certificates to refugee children

United THE Nations High Commissioner for Refugees, Filippo Grandi has hailed the government's move to identify, register and issue birth certificates to refugee children in various camps in the country, something which helps protect rights of the group.

He said the efforts will help confer important legal protections on the children and reduce the risk of statelessness, while also providing a form of identity when they return to their country of origin.

Addressing journalists in Dar es Salaam last Friday soon after concluding a three-day official visit in the country, the UNHCR boss noted that every child has the right of identification and registration so as to receive all the required services for him/her to grow and achieve full potential.

He asserted that it is crucial for the children to be able to use their birth certificates as identification documents when they return to their home countries.

"This is something to applaud, UNHCR sees this as an important step and we thank the government of Tanzania for implementing this initiative as it helps the children to live happily while accessing all their rights," he said.

He said the UN refugee organisation in collaboration with partners, will continue implementing various strategies to further promote children protection in the camps while also ensuring that they have access to all basic rights including education and health.

The government through the Insolvency Registration, Trusteeship Agency (RITA) in collaboration with partners such as UNICEF, Tigo and the Canadian government is implementing a genderresponsive simplified birth registration programme that aims to reach all under-five children across the country.

Under the system, children are registered and given birth certificates at a short time in ward offices and health centres compared to the previous time when parents had to travel to reach district officers to get the service.

According to RITA, since the programme commenced in 2013, a total of 7.7 million children under the age of five have been registered and given birth certificates across 23 regions in Tanzania Mainland.

RITA also implements another programme focusing on school children where a good number of children have been registered and given birth certificates.

TMDA reminds drugs dealers to abide by drugs expiry dates

TANZANIA Medicines and Medical Devices Authority (TMDA) in Southern Highlands Zone have reminded traders in drugs and medicines to abide by the expiry dates of the drugs to protect the health of the people against expired medicines.

The call was made here yesterday

by TMDA manager in the Southern Highlands Zone, Anitha Mshighati, who said they expect to institute inspections in every pharmacy to enforce the order in regard to expiry dates of the drugs being sold.

"Traders should adhere to regulations and procedures issued by TMDA in regard to sale of expired or prohibited drugs," she added.

She added that apart from the planned crackdown on pharmacies, she stressed on traders to have an electronic invoice copy of the consignment, as well as permits from other registration institutions.

She said they are also calling on the drug dispensing outlets to make sure they fill the customer's registration form for submission to TMDA in order

to get the identification number and password.

"We are calling on drug dispensing outlets to abide by legal procedures in regard to sale of human medicines as well as laws and regulations governing import of drugs to protect the health of the people," Mshighati said.

She said drugs are registered in order to protect users against negative effects.

She elaborated that all registered drugs have a shelf life of five years and in case they are not condemned, a trader can apply for the registration

HEALTH Deputy Minister Dr Godwin Mollel has invited Indian Pharmaceutical companies to explore potential investment opportunities in the country to develop the ever demanding sector.

Speaking yesterday in Dar es Salaam at the launching of the East Africa Medical and Healthcare International Exhibition, the Deputy Minister said the move will help to improve the ever demanding sector.

Dubbed 'Pharma Tech East Africa' the platform is meant for industry players to connect, collaborate, explore and network. It is an opportunity to display the latest products and services as well as comparing prices and quality.

Dr Mollel said investment in pharmaceutical industries will not only create employment but also reduce the prices of medicine compared to those imported.

He said currently, the Medical Store Department (MSD) procures medicines and other medical supplies directly from the manufacturers where according to him, it faces stiff competition. "I have been informed that the volume of drugs imported from India has significantly dropped. I wish to take the opportunity to invite the pharmaceutical companies from India to open new factories to access the medical and pharmaceutical market directly," he said.

The deputy minister said investing in local pharmaceutical factories will change the medical and pharmacy business in the country, adding that the government was ready to collaborate with investors to produce profits.

According to him, the government has reduced the number of patients referred to India for further medical treatment by 97 percent, encouraging

them to think of investing locally in state-of-the-art hospitals such as Apollo.

Indian High Commissioner to Tanzania, Binaya Srikanta Pradhan said that he was impressed to see more than 60 pharmaceutical companies attending the exhibition.

He said in 2022, between 57 and 60 percent of medicines used in Tanzania were imported from Indian pharmaceutical companies, signifying the quality of medicines the country manufactures.

Pradhan added that India has remained a place for medical tourism and supplier of medicines and equipment to the Tanzania government for decades.

President of the Pharmaceutical Society of Tanzania (PST) Fadhili Hezekiah said the exhibition was a platform that was going to change the healthcare system in Tanzania.

THE government has promised to work in collaboration with traditional medicine practitioners to ensure their researches and training becomes sustainable and meets quality.

Prof Esron Karimuribo, Director of Postgraduate studies and research at Sokoine University of Agriculture (SUA) said that in the first African Traditional Medicine Day Scientific Conference held at SUA premises in Morogoro region.

He said convocation was organised by SUA in collaboration with the Ministry of Health and different stakeholders. The aim of this important day is to promote the role of African traditional medicine to improve the health of Africans.

RAS bans traditional elders to settle GBV, child abuse cases

THE Manyara Region Administrative Secretary, Karolina Mthapula has imposed ban on traditional elders and parents to encourage people involved in family based violence to informally settle the matter by offering livestock in order to evade the arm of the law.

Mthapula announced the ban at the weekend when she visited a family of two children (names withheld) who were sprayed with boiling water by their biological mother at Nakwa things," said Mthapula. Village, Babati district.

She said children who were subjected to the cruelty are aged seven -studying in Standard One and the other aged 14 studying in Std Six.

RAS called on the community, especially parents, to stop subjecting their children to cruelty for whatever

"Parents should refrain from vengeance on children as they are innocent and uninformed about many

She said traditional elders are still problematic as they keep on telling the community that those involved in such cruelty should settle the matter informally by offering goats, sheep or cows as penalty.

She said the decision by the mother of the two children to spray her children with hot boiling water was not human at all, and added that she could have blinded them or infringing other permanent disabilities.

She also called upon the people to report such acts of cruelty to appropriate authorities as well as taking the victims to hospital for prompt treatment.

Meanwhile, Babati Town Council Director, Anna Fisoo who accompanied by RAS said when people commit acts of violence, they create a violent generation.

She called on them to refuse receiving livestock as penalty to settle the matter.

Fisoo directed Nakwa Village officials to convene a public meeting, after the completion of the census exercise in which a team of officials from community development officers will educate them on issues of gender based violence and child abuse.

Govt allots 800m/for construction of water project in Mkunywa village

THE government has provided more than 800m/- for the construction of a water project in Mkunywa village, Madibira ward, Mbarali district, Mbeya Region and the project after completion will serve seven villages.

Rural and Urban Water Agency (RUWASA) manager in Mbarali District, Eng. Samwel Heche said that the project was started 12 years ago but due to various reasons it could not be completed despite giving an amount of 90m/- at that time.

She said that the project is one of the worst projects in the Ministry of Water and that they will not accept to see it stalled again and instead RUWASA should manage to ensure that the people start getting clean and safe tap water service.

Speaking with Madibira residents. Maryprisca explained the hardships they are going through due to the water problem in their areas.

danger of breaking up due to spending too much time searching for water and failing to take care of her marriage.

She said that she spends more than eight hours searching for water, a situation that causes her husband to see that he does not get a chance to sit together and make plans asking the government to complete the project so that they can start getting clean and safe water services because 12 years have passed since the construction of the project started but it was not completed.

She said women are the biggest victims of the water problem as it is needed for many activities in the family, so the completion of the project will help their marriages to be safe and other things to be done.

Zanzibar faces tough nut to crack over corruption

Hussein Mwinyi is battling to bring executive agencies to act on mishandling of government revenues as reported in the annual report of the Zanzibar Controller and Auditor General (Z-CAG). On the basis of recent remarks by the Isles leader, there is hardly an instance where measures are taken on those who help themselves to government funds, often as inappropriate loans and they return the cash later. Listening to audiovisual discussion, this is normal.

When pundits make an effort to show that this is normal, the crucial aspect there is the cultural environment, that there is a community spirit of gains where a sort of generalized welfare consideration is part of the issue, not just individual actions. As Zanzibar is a fairly closely knit community, and is often intolerant of those who seek to upset social, economic and political arrangements there, many will take it that access to public resources is part of benefits of loyalty. It is hard to remove this sentiment, and it is definitely this kind of outlook that the president is battling.

Zanzibar is not alone in facing such problems, as they have occurred time and again in the Union government, where reports of the CAG are basically advisory to the legislature. During the fifth phase the government started to be more concerned with their contents, and the same spirit is being noticed in Zanzibar, as part of a wider drive to generate reforms that permit contractual arrangements with foreign firms. Investments or joint ventures presume the rule of law, not communal ways of doing things where people

While it is entirely possible that those responsible will start taking measures to tidy up good governance in various departments, chances that resistances ossify in this or that department are high. Ordinarily people react positively to what is in their interests rather than contrary to what they want, and if they feel they have support around them, their readiness to act is diminished. Thus remedial measures to this situation need to involve change of roles, extra benefits for going the change way.

That is why the current Blue Economy drive by President Mwinyi is vital in the effort to reshape governance outlooks, from a conservative communalism to a more innovative liberal outlook of individual responsibility. When government departments are engaged in contractual links with private companies, proper or contractual use of cash becomes a habit. They say 'the guest helps out the tenant,' in which case broadening accountability to add contractual ties would help a lot.

When there are new tasks to be achieved and most government officials find they have a stake in the changes, so long as they play by the rules, infusing a change in behaviour will be eased. A more open approach can help, in implementation of the current Blue Economy vision, by taking it up in a slightly different environment. It is what US economists would say is a 'soft landing' approach, even if it isn't a panacea for all governance problems enumerated, since as the adage goes 'Rome wasn't built in a day.' Nor will corruption be eradicated in one term of office, but a lot can still be achieved.

Foreign beef exports need own agents

here, not just inoculation or cattle dips OLICY makers in the stakeholders here, in which case those Livestock and Fisheries ministry are working around the clock to put in place a functioning cattle handling slaughter and meat processing modality that can significantly increase chances of exporting beef to Western markets, especially Europe. So far there are emerging markets in the Middle East and esOpecially the Gulf Zone, where the light has been flickering for more than a decade but it is hard to say if there is a substantial market yet. appeared a bit new. This is what the ministry is seeking to address, but what it can achieve can rapidly be said to suffice for regional markets and partially, the Gulf Zone is they have sealed agreements on that score, now or in the past. Europe and other markets may still have to be convinced, where the best way forward isn't to initiate rounds of economic diplomacy in foreign missions but to ease their efforts, by solving clear bottlenecks. One way is to have agents of foreign beef firms being

markets can't reject products of their own companies.

An example is the way Tanzania over the past year started to access the Indian market for avocado, a market it has continuously sought for perishable vegetables to no avail. It was after an Indian agri-business firm obtained a patch of land to cultivate that crop, such that it is classified as Tanzanian but the law has to be altered to allow Tanzanian horticulture to enter that country without tariff barriers. Nearly the same thing needs to be applied to Europe but for the sanitary or phytosanitary aspect, where that same element of ownership applies, to identify with it.

It means that some investments must be sought for by the government in order to ease market access abroad. When foreign missions know exactly what the country needs in this or that area, instead of merely piling arguments for the country being allowed to sell beef or such other product, it will be easier to attract investors, instead of waiting for them to discover what is relevant for their markets. We often err by thinking they come for available opportunities, instead of strategic pursuits.

To unlock the beef exports potential the ministry will do better seeking out EU investors to tie up with local entrepreneurs, even if they will not be breeding the cattle on their own, at

least in first stages. The duality can live on for a while as beef ranches expand while traditional rearing is also there for the local market and even portions of the regional market. It is worth trying it out, not just pleading.



HE upcoming summit on Education, part of the UN Secretary General's ambitious agenda, can truly bring accountability and participation to the inevitably new ways education will be imparted in the future.

With scorching temperatures, uncontrolled flames and floods devastating our planet, millions of people are realizing that we are all going to pay a high price for climate inaction.

The current climate crisis is furthering compounding the other emergency that is still affecting all of us, a public health crisis fully exposed by the Covid pandemic.

Amid this gloomy scenario, the international community cannot forego its duties not only to strengthen the global education system but also its moral obligation to re-think it and re-

While it is easy to criticize the UN as a system incapable of effectively tackling these multidimensional challenges, we cannot but praise Secretary General Antonio Guterres for his far sighted vision encapsulated in his global blue print, Our Common Agenda.

It's a bold statement that contains multiple proposals including the ambitious goal of reinventing the global education.

In this context, and on September, the UN will host the most important forum to discuss how education can emerge as the thread that can equip the citizens of the world with the right tools to thrive in a truly sustainable and equitable planet.

The Transforming Summit, scheduled to take place at the UN September 19, should be seen as a stand-alone effort while it is intended to be the beginning of an ambitious global brainstorming. It is also the culmination of several other major events in the past few years.

In 2015 the Incheon Declaration and Framework for Action provided the vision for implementing the SDG 4, the global sustainable goal focused on inclusive and quality education.

We know how brutal the effects of the pandemic were on learners worldwide especially in developing and emerging nations.

In face of these challenges, with the global headlines focused on the public health emergency and the futile attempts at negotiating a breakthrough climate change agreement at the COP 26, few noticed that the international community tried to take action.

In November 2021, it gathered in Paris for a Global Education Meeting's High Level Segment hosted by UNESCO and the Government of France. The outcome was the Paris Declaration that building on the work of a previous summit, the Extraordinary session of the Global Education Meeting (2020 GEM), held in October 2020, provided

a clear call for more financing and a stronger global multilateral cooperation system.

The fact that our attention was totally focused to other existential crises should not deter us from reflecting on how such events were neglected by world media and, as a consequence, how little discussion about the future of education happened.

Iam not just talking about discussions among professionals on the ground but also a debate that involves teachers and students alike. The upcoming Transforming the Education Summit will try to revert this lack of attention and overall weak engagement among the people.

The Secretariat of the event, hosted by UNESCO, one of the agencies within the UN system that lacks financial support but still proves to be real value for money, is trying its best to enable a global conversation on how the future of education should be.

It is in this precise context that UNESCO has set up an interactive knowledge and debate hub, the socalled Hub that, hopefully, will become a permanent global platform for discussing education globally.

Imagine a sort of civic agora where experts, students, parents, policy makers alike can share their best practices and bring forwards their opinions on how to follow up on the decisions that will be taken in September.

It is also extremely positive that a Pre-Summit event at the end of June in Paris, laid out some grounds for the September's gathering especially because youths also had a chance to speak and share their views.

It is not the first-time youths are involved, but the full involvement of the Office of the Secretary-General's Envoy on Youth in the preparation of the

Transforming the Education Summit could be a turning point, shifting from mere and tokenistic engagements to real shared power with the youth.

That's why the existence of a specific process within the preparation of the summit, focused on youth, is extremely important and welcome not just because it will generate a special declaration but because it could potentially become a space where youths can have their voices and opinions heard permanently.

Let's not forget that the ongoing preparations were instrumental to revive the outcomes of the "Reimagining our Futures Together: A New Social Contract for Education" developed over two years by the International Commission on the Futures of Education, a body chaired by President Sahle-Work Zewde of Ethiopia, and published in 2021.

It is truly transformative because the title itself is aligned to the aspirational vision of Secretary General Guterres to establish a new social contract.

A new social contract in the field of education really needs to rethink the domains of learning and its established but now outdated goals. Learning should become, according to this report, a holistic tool to create personal agency and sustainable and just development.

For example, education for sustainable development and lifelong education together with global citizenships should stopped being considered as "nice" but burdensome adds on.

Today's challenges, the report explains, must be focused on "reinventing education" and knowledge it provides must be "anchored in social, economic, and

environmental justice." Wisely, Guterres intends the summit in September to be the starting point for a much longer conversation that will build on the insights and knowledge emerged in these last few

Governance of the global education system will also be central and with this, we will have an opportunity to find creative ways, ways that just few years ago were imaginable, to include people, especially the youths.

No matter the efforts now put in place to create awareness and participation for the summit, no matter how inclusive the Youth Process will be, the fact that there is still a very long way before creating spaces where persons on the ground can truly participate.

Too few are aware of the existence of a Global Education Cooperation Mechanism led by the SDG4-Education 2030 High-Level Steering Committee that also includes representatives of youth and teachers and NGOs.

While there is no doubt that such inclusive format is itself innovative, the challenges ahead require a much more accessible and holistic set-up.

The existence of a accountability mechanism was one of the key points discussed and emerged in the Youths Consultations during the Pre-Summit in Paris.

The High-Level Steering Committee needs not only more visibility because of its "political" aim of galvanizing global attention and energizing and influencing global leaders so that education can become a global priority at the same levels of climate action and public health.

It should also have a stronger representation of youths, teachers and NGOs and it can evolve into a real permanent forum for discussions and even decision making.

As difficult as it to imagine a new global governance for education, what we need is a space, virtual and as well formally established as an institution, where not only experts and governments' representatives gather and decide.

A space for accountability but also for enhanced participation.

There is still a long way before reaching a consensus on how education will look like in the years to come but there is no doubt that bold decisions must be taken also to reimagine its governance.

The Transforming the Education Summit can herald the beginning of a

FRICA'S growing strategic value to global powers has been reinforced by international tensions and economic volatility spurred on by Russia's invasion of Ukraine and the Covid-19 fallout.

African states have long featured prominently in the foreign policy calculus of the great powers and middle powers in more recent times. This is particularly in terms of natural resource extraction, energy security and finding new markets for trade and investment.

But due to their relatively limited hard-power profiles (or material capabilities), no single African country can challenge or obstruct the global ambitions of powers such as the United States (US), China, Russia, the United Kingdom (UK) and France.

As a result, the continent has struggled to influence the international agenda outside of bodies like the United Nations (UN) and African Union (AU). However, 2022 may come to be seen as the year that marked a decisive turning point.

In hindsight, multilateral responses to Russia's invasion of Ukraine are perceived as far more significant than individual states' reactions to a specific crisis. Positions adopted in the UN General Assembly's 11th Emergency Special Session on Ukraine have been interpreted (primarily by the West) as a key signifier of countries' commitment to the current rules-based, global order.

The conflict has been framed as an attack on the normative bedrock of the international system – pitting revisionist forces against those seeking to maintain the status quo. An analysis of regional voting patterns for the three UN resolutions adopted on Russia's invasion of Ukraine (see chart) is revealing.

Across all three votes, the Western European grouping (which includes the US, Canada, Australia, New Zealand, Turkey and Israel) maintained an extraordinarily high level of unity in opposing the invasion and supporting all three resolutions. This was mirrored by the Eastern European group, with a handful of excep-

Union Commission president Ursula von der worldviews on how the crisis is understood po-Leven, among others – show that the West expected states from other UN blocs to share this worldview. While many did for the first two resolutions, there was a considerable drop-off in the third resolution, which booted Russia off the UN Human Rights Council.

Votes from Africa, and Asia-Pacific to a lesser extent, underscored a sharp global divide on the unfolding conflict. African states were split almost down the middle in their support of the first two resolutions - while being far more mut-

ed on the issue in other diplomatic engagements. Reasons for the different voting outcomes are specific to each country, but there's a clear mismatch between Western and African states' litically. As a result, Africa has become a significant site of global power contestation for influence and support – reminiscent of the Cold War

This has bolstered the continent's strategic importance on the world stage. African countries are seen as 'swing states' in a grand battle between those attempting to maintain or undermine the current international order. This was exemplified in recent months by a series of highlevel diplomatic tours.

German Chancellor Olaf Scholz conducted his first official visit to Africa in late May, visiting Senegal, Niger and South Africa. The trip informed Germany's hosting of the G7 summit in

June, which focused on the economic impact of the Russia-Ukraine conflict. South African President Cyril Ramaphosa and current AU chair, Senegalese president Macky Sall were invited, showing Scholz's acknowledgement that African perspectives should be considered. African states (and the AU) aren't part of the G7.

In July, French President Emmanuel Macron visited the continent, seeking to reboot relations with Cameroon, Benin and Guinea-Bissau. Concurrently, Russian Foreign Minister Sergey Lavrov travelled to Egypt, Congo, Uganda and Ethiopia to garner support and provide reassurances on the impact of the conflict on Africa's food security.

Early August saw US State Secretary Antony

Blinken visit South Africa, the Democratic Republic of the Congo and Rwanda to revitalise relations and promote the US's new strategy for sub-Saharan Africa. The strategy follows the Countering Malign Russian Activities in Africa Act in April, which links to ideas in the US's 2017 National Security Strategy, 2018 National Defense Strategy and 2022 North Atlantic Treaty Organization Strategic Concept adopted in June. Both strategies point to the return of long-term strategic competition among states.

Together, these engagements show a concerted effort among global powers to revamp relations with African partners against the backdrop of increasing rivalry. Beyond the search for new markets and natural resources, African states are being included in influential countries' foreign policy planning in a bid to secure support for competing worldviews on the international order.

The critical question for the continent's leaders is how to make use of this rising strategic value. That this value is externally derived is irrelevant. What matters is how it could be leveraged to achieve Africa's collective political and developmental

This is the moment for Africa's leaders to agree on and pursue longstanding big-ticket items, like meaningful UN Security Council reform. Accomplishing that will be difficult and may require a considerable recalibration of relations among African states themselves.

As global power rivalries intensify, it's worth remembering that the current international order has rarely worked in Africa's favour - and has arguably reinforced the continent's marginal position in world affairs. So African countries are naturally positioned as revisionist forces, striving for a more representative and equitable international system that could better respond to the challenges all states face.

At the same time, a new international order that is more transactional and lacks a robust normative bedrock could prove far more sinister than the current one.

In either case, Africa's rising strategic stock on the world stage cannot be squandered if its leaders are committed to a common political, developmental and human security agenda.

More refugees, migrants find safe haven in Egypt amid instability in neighbouring countries

CAIRO

TROLLING in the 6th of October City to the southwest of the Egyptian capital of Cairo, one might feel like traveling in a Syrian city as it is teemed with Syrian-styled restaurants, shops, and groceries selling shawarma, barbeque chicken, pickles and spices.

These businesses are mostly run by Syrian refugees living in the city, whose number is estimated to be thousands.

Amaar Abdel Rahman, a 44-year-old owner of a restaurant owner selling Syrian sandwiches, is one of them. Having fled the war-torn homeland with his family in 2012, he has found safe heaven in Egypt ever since.

"I suffered at the beginning to find a job until I opened, in partnership with an Egyptian, a restaurant selling Syrian sandwiches," Rahman said.

Rahman is very satisfied with his current life in Egypt where his family is living in an apartment rented at the same price offered to Egyptians, while his children get free education in Egyptian governmental schools.

"I had the chance to travel to a European coun-

try illegally, but I feel more comfortable here because there are no language, culture, or religious barriers," the Syrian refugee told Xinhua.

There are over 9 million refugees and illegal migrants living in Egypt originating from about 130 countries, according to a report of the International Organization for Migration (IOM) published on Aug. 7.

"The current number of international migrants residing in Egypt is 9,012,582 migrants, which is equivalent to 8.7 percent of the Egyptian population," the report said.

Among the total, it's estimated that there are 4 million Sudanese, 1.5 million Syrians, 1 million Yemenis, and 1 million Libyans. Combined, they account for about 80 percent of the total population of refugees and illegal migrants currently residing in Egypt.

Naela Gabr, the chairperson of the Cairo-based National Coordinating Committee for Combating and Preventing Illegal Migration and Trafficking in Persons, said that the number of refugees and migrants in Egypt has notably increased due to protracted instability in the neighboring countries.

"Egypt is an oasis of security and safety in a re-

gion experiencing several economic and political problems which have driven many Syrians, Iraqi, Libyan, Yemeni, Sudanese, South Sudanese, Ethiopian and Eritrean individuals to find shelter in the most populous Arab county," Gabr told Xinhua.

The Egyptian official explained that the legal status of the 9 million individuals accommodated by Egypt is refugees and migrants with no legal properties or residency permits.

Only 275,000 of them have the "status of refugee" in accordance with the 1951 UN Refugee Convention, she said.

Egypt has adopted a lenient policy toward the refugees and illegal migrants, without taking negative measures against them or putting them into refugee camps, Gabr said.

They enjoy equal rights with the Egyptian citizens in terms of education and national health care despite the world economic stagnation that has adversely impacted the Egyptian economy and employment, she noted.

The Egyptian official stressed that there are no major problems that have been caused by the refugees and migrants, adding that the foreign presence even contributes to the richness crimination," she added. of the Egyptian economy and culture.

Gabr denied the western reports that Egypt is a transit country for the migrants, as "transit is not easy now as before because border guard forces have completely controlled the Sinai Peninsula, western borders, and the Mediterranean Sea coast."

She referred to the National Strategy on Combating Illegal Migration (2016-2026) and Egypt's Law On Combating Illegal Migration & Smuggling of Migrants which was issued in 2016 for maximizing penalties against illegal migrants as a tool for preventing migration through the Egyptian territories.

Gabr called for better cooperation with Europe, which she said should abandon its double standards in dealing with illegal migrants.

"Europe has to work on creating job opportunities and settling the political problems in the African countries that export migrants," she said.

"Compared to welcoming the Ukrainians, Europe in defending the human rights has dealt with Afghan, Arab and African people with dis-

Still, some refugees or illegal migrants living in Egypt try to use the country as a springboard for migrating to Europe.

A 17-year-old Eritrean girl, who refused to be named as she has no legal residence permit in Egypt, admitted that Egypt for her is only "a transit country for migrating to Europe."

The girl, working as a secretary at a music academy in the Maadi district in southeastern Cairo, arrived in Egypt with her family four years ago.

She said that she has been saving money for getting a possible ticket to a secured boat taking her and her family to Europe.

"Egyptians are kind, but Egypt is not a rich country and there is no job opportunity for my father, and we cannot live on aid forever. I have dreams to get a good education and legal life," she told Xinhua

It is crucial to invest in early childhood education development, parents advised

PARENTS and guardians have been urged to invest heavily in early childhood education development to build a strong foundation that would shape the future of kids hence the society.

Jane Mutua Save the Children Tanzania, director of programme development and quality made the remarks during a Policy Forum's breakfast debate, themed: "Investing in early childhood development: What should be done to improve children's learning."

Mutua said findings have shown that investing a single dollar in early childhood will return 17 dollars hence the need for more investment in the area.

She said outcomes of a project which the agency carried in Mbozi, Songwe region dubbed 'Tuwekeze pamoja project' have shown for the improvement in pre-primary teaching and learning environment.

The project's outcome also suggested the need for creation of an enabling environment for children's development and learn-

"The findings also showed there is an increased awareness that when parents fight in front of children, the children may be anxious about the peace at home," she said.

She added that before the project, there was a high level of inter-partner violence, mainly due to alcohol abuse among male caregivers, whereby most home environment and caregiver indicating that having a supportive home environment has a direct relationship with development outcomes.

"This may be because, on average, mothers in project areas spend more time with children than fathers. Fathers' engagement in these activities would similarly influence outcomes," she said.

The project was aimed at empowering caregivers expand their understanding of parenting - from providing basic needs to nurturing all aspects of child development.

Mutua detailed further that through the project in Mbozi District they have been able to support capacity building activities with local government officials, training on how to engage in the

prioritization, planning and budgeting process and supporting them to integrate issues into village development plans.

"We worked to standardize village development plans in partnership with ward and village officials and supported them to

obtain training on how to engage in existing planning and prioritization processes," she added.

The programme also helped to design activities that enable the engagement of male caregivers in areas where they are more easily accessed, such as local markets or bars or in their workplaces.

Jamii Initiative Head of programme, Godwin Mongi said that the children upbringing, nurturing and development can lead to changes in national development. "What we are experiencing occurring in most families of having stubborn and cruel children is an outcome of what parents did in the past," he said.

Mongi urged parents and guardians to speak to their children face to face so as to establish trust in, "one hour can be very meaningful to spend with your child."

"Changes of children should start with parents and guardians," he said, urging the government to invest heavily in early education because it is a key for a child's development.

Flora Emmanuel from the Tanzania Women Lawyers Association (TAW-LA), urged parents and guardians to be careful on what they are giving to their children.

"Provide them with films which create innovations and creativity to your children," she said.

Other findings indicate that globally, there is consensus among education stakeholders that early childhood education sets a foundation for children's development, learning, and future life achievements.

LSF supports use of census data in accessing justice programming

Human Census as key in providing a valuable resource to assist the legal sector in the planning for access to justice programs as well as the delivery of legal aid services.

LSF chief executive officer, Lulu Ng'wanakilala said that the 2022 Census data will thus provide the facility with a valuable resource to assist the legal sector in the planning for access to justice programs as well as the delivery of legal aid services.

He said that the LSF has interventions that demonstrate new and innovative ways data on how census data is being used to enhance service planning to better meet the needs of community justice.

"With the increase in the needy groups against an age of restricted funding from the government and development partners, LSF is keen to track Census data to help the legal sector align resources prudently for legal assistance services to the vulnerable people needing it the most," she said in a statement.

LSF works to improve access to justice in Mainland Tanzania and Zanzibar, particularly for socially and economically disadvantaged people.

"It has been doing this important work for more than 10 years beginning in 2011. As such, LSF work has very much relied on official national statistics relating to vulnerability and socio-economic conditions to inform its access to justice programming,"

LSF has dealt with millions of Tanzanians struggling with matrimonial issues, child marriage, child support and child abuse, property and inheritance for women and girls, labor and employment, tenancy, and disability discrimination among many other community justice problems.

"Through LSF intervention, Tanzania has seen a massive expansion in paralegal services in the rural and remote areas of the country with even geographical distribution of such services.

Paralegals have offered a signifi-

cant opportunity to access remote and rural localities where the poor LEGAL Services Facility (LSF) has are severely limited in their access to described this year's Population and justice. Paralegals have been able to reach large numbers of people in rural and remote areas and offer basic education on the law, both formal and informal, in ways that can be easily understood."

According to her, LSF interventions have also contributed to generating and documenting voluminous data that are gradually being integrated into National statistical systems and used by researchers and stakeholders within and outside Tanzania.

Explaining how PHC data informs access justice programming, Lulu stated that on the issue of illiteracy, the last five national census exercises had illiteracy levels as a key indicator as Tanzania like many other African countries has been battling with low levels of literacy since independence.

Many researchers in Africa, Tanzania inclusive, have cited illiteracy as a significant reason for groups' relative lack of access to justice.

Illiteracy usually goes with a lack of information, and as such, groups of people in this category fail to understand information relating to stipulations of the law on their rights as well as the vindication of rights through

"Access to justice research and surveys in Tanzania has established that illiterate people feel intimidated by the formal legal systems like courts of law and would rather engage only with the informal systems." Previous Census information reveals that Women constitute a key group of illiterate people compared to their male counterparts with adult female illiteracy constituting more than 60 percent in the previous census.

The previous Census data also revealed that illiteracy is a high prevalence in rural areas making the rural population more challenged to access iustice.

On the household income data, the LSF official said that information relating to household income in the national census in the past has revealed that a significant section of the population in Tanzania lives in serious pov-



erty. According to her, poverty represents a significant challenge to access justice in Tanzania.

"The principal barrier poised by poverty is the inability to meet the costs of legal representation, and in particular for women who are in the lowest income bracket far below their male counterparts," Lulu elaborated.

Data revolution within the framework of sustainable development Goals (SDGs) constitutes a unique opportunity for strengthening the links between statistics and human rights.

A human rights-based approach to the data revolution in the SDGs Agenda entails five pillars--disaggregating human rights and access to justice indicators, whereby human rights standards stipulated in international human rights instruments have prohibited discrimination in terms of income, gender, age, race, ethnicity, migratory status, disability, geographic location, and other characteristics relevant in national contexts, Prohibition against discrimination basing on the above indicators is a constitutional safeguard under the United Republic of Tanzania Constitution and Zanzibar Constitution.

Thus, statistical data produced through the national census assist in providing the actual number, location, and situation of persons needing protection in the framework of such disaggregated human rights indicators.

Measuring implementation of human rights standards is also another pillar, whereby realization of human rights is achieved by ensuring the availability and accessibility of rightsrelated services such as healthcare, clean and safe water, universal education, improved detention conditions, etc.

Census data provides the basis for measuring the implementation of such human rights standards by establishing the extent of availability and accessibility of such services to a most vulnerable group of the population on principles of non-discrimination, equality, participation, access to justice and freedom from violence.

It also facilitates the participation of rights holders and stakeholders, which is now a major principle in human rights endeavors-the first step however is to know exactly the different groups of rights holders and the census data provides such a basis.

"From there, all government efforts should be done collaboratively with the rights holders in addressing their needs as a major pillar of human rights. For that reason, therefore even the designing of census questions in many countries now involves the rights holders to ensure capturing of all relevant data.

A good example is the involvement of representatives of persons with disability, women, and girl's rights advocates, and health rights actors who have been evidenced to work closely with the government statistics offices."

Data collection safeguards is also another pillar where the national census exercise itself may be prone to human rights abuse if a framework to ensure human rights safeguard in the collection, processing, and dissemina-

tion, and the results for the concerned populations using multiple data sources like statistical surveys, administrative records, big data, civil society organizations' interventions, and available human rights mechanisms at national, regional and global levels.

According to the Office of the United Nations High commissioner for Human Rights (OHCHR), human rights correlate with the availability of sound official statistics. The UN Human Rights Office notes that the last decade has witnessed a growing demand for statistical information emanating from the human rights fields, including from the international human rights mechanisms, states, and Civil Society.

Efforts at national and international levels are increasingly using disaggregated statistics, indicators, targets, and other benchmarks to enable measurement that is more systematic and implementation of human rights, norms, and principles.

Reliable data and statistics provide a powerful tool for focused advocacy, identification of gaps in the realization of human rights, and the creation of a culture of accountability and transparency.

HE heavy and incessant monsoon downpours across Pakistan in the last two months have triggered floods wreaking havoc across the country, submerging entire villages and vast tracts of land and entrapping people. Anything coming in the way of the relentless water is being destroyed, including roads, bridges, and standing

The Pakistani government has declared a national emergency with more than 30 million without shelter. According to the UN Office for the Coordination of Humanitarian Affairs (OCHA), 66 districts have officially been declared 'calamity hit' by the government of Pakistan - 31 in Balochistan, 23 in Sindh, nine in Khyber Pakhtunkhwa (KP), and three in Punjab. Many have likened the destruction to the 2010 super floods.

With government stretched and communications networks disrupted, flood survivors complain that help is scarce.

Saeeda Khatoon, 28, likened her village of Zakaria Mahesar to the famous 3rd millennium BC Moenjodaro ruins of the ancient Indus civilization, in her district of Larkana, in Sindh province, after the rains destroyed over 200 houses, some made of mud and straw and others, like hers, of brick. She, along with 11 members of her family, has found temporary shelter on higher ground, on the outskirts of the village, under the open sky, unprotected from the vagaries of the unpredictable monsoon rains.

"The water gushed into our home suddenly, and we rushed out just moments before the roof caved in," she

water still waist deep, she said there was no way of retrieving their belongings from under the debris.

The monsoon season hit Pakistan this year in June, earlier than usual. Torrential rains continued well into July, with 181% above average rainfall. The Pakistan Meteorological Department (PMD) said it rained 177.5mm against its normal of 63.1mm, making this July the wettest since 1961.

"July 2022 rainfall was excessively above average over Balochistan (+450%) and Sindh (+307%), both rank as the wettest ever during past 62 years," said the PMD's monthly summary. And the rains continue to batter the country well into the end of August, spreading more destruction across the provinces of Punjab, KP, and the mountainous region of Gilgit-Baltistan, after annihilating Balochistan and Sindh.

According to the National Disaster Management Authority, the rains have caused havoc across Pakistan, claiming nearly 1,000 lives and more than 1400 rain-related injuries since June. More than half the casualties are from Balochistan and Sindh province.

Over 3,000 km of road network has been damaged, of which over 2,300 km is in Sindh, making it difficult for the government and non-governmental organizations to reach and rescue. "The whole province is inundated with flood water, and roads are battered; it is difficult to reach and provide relief," said Inayatullah Ismail, senior manager, coordination at the non-profit Al Khidmat Welfare Society. "We are providing tents to the displaced people and will be setting up kitchens on the highways where people are seeking refuge.'

"Since the last three days, our teams have been distributing cooked food to nearly 30,000 flood victims who have set up makeshift camps around RDF offices," said Soomro.

"Giving cooked meals is best as it is difficult for the displaced to cook having lost everything," said Aqsa Iqbal, who volunteers with Serve Humanity Together. She suggested: "All those who are providing cooked food to affectees may also want to add drinking water bottles, packed snacks or biscuits, juices and fruits (dates) as well, so that they could have something that does not get spoiled, and they can consume over the next few days." She also said most people urgently needed tents, plastic sheets, and medical aid.

Further, she said, rescue and relief workers were finding it difficult to reach people stuck in remote villages, surrounded by stagnant rainwater.

"Many of these people are young volunteers with a lot of zeal but not professionally trained. Wading through water, even shallow, was difficult, and there is always the fear that they could be bitten by snakes or fall in open potholes," said Iqbal. That is why, she said, it would be best to bring the flood affectees to dry land, where it is easier to provide them with food, water, and medicines.

So far, the NDMA has recorded nearly 680,000 houses affected, of which over 58,000 are in Sindh alone. Up to 19,000 of these homes in Sindh have been destroyed.

"I have never seen a greater catastrophe in my life," said Sindh chief minister Murad Ali Shah after visiting various flood-affected districts of Sindh. He said his government was stretched for funds and had run out of tents and food. Over 10 million people in Sindh have been rendered home-

The government of Sindh has formally reached out to NGOs requesting help with rescue and relief work.

Rani Malukhani, a social activist from Khuda Baksh Marri, a village in Sanghar district, said they were starving and sitting on the roadside with nothing to protect them from the lashing rain. "Where is the government; where are the NGOs?" she said over a WhatsApp video phone call, showing how her community was sitting stranded on the roadside.

"Our homes and standing crops have been destroyed," she cried in dis-

"There are close to 700 people in this village, and all are sitting on both sides of the 2-3 km long road under the sky," confirmed Azra Gandehi, who works with the NGO, Research and Development Foundation (RDF). She was visiting the village for a preliminary survey and assessment of the damage so she could return with assistance. "The water is chest deep, and all had to evacuate along with their livestock."

In the neighbouring Mirpur Khas district, things are no better. Motan Bheel, 52, and her five children and two goats, belonging to Jhudo village, had to wade through waist-deep water to reach the safety of the bank of Puraan (a sub-drain that collects saline water, agricultural effluent, and floodwater to the Arabian Sea). "There is water all around us, but not a drop to drink," she said. "We have not received any help from the government, NGOs or philanthropists.

The EABL Plc share price also increased by 2.08 percent to 2,940/- on Monday's close from 2,880/- recorded during Friday's close, increasing its market capitalization to 2,324.88bn/from 2,277.43bn/- respectively.

The appreciation of two companies share prices also pushed up total market capitalization to 15.86trn/ from 15.79trn/- respectively.

However, trading activity closed low on Monday, compared with Friday last

Reports show winners, losers of mobile telecoms market share

MOBILE telecommunication operators are continuing to battle for subscribers market share, after the recent report showed winners and losers of the market for the year ending June.

The quarterly report shows mobile telecommunications subscribers amounted 56.22 million as at June this year from 53.18 million recorded during the period ended in June last year.

Top market winner, in terms of market share was Tigo Tanzania which increased its share to 27 percent by June this year from 24.5 percent recorded in June last year, with number of subscribers reaching 14,923,064 from 13,011,395 respectively, making it the third largest.

Vodacom Tanzania, which accounts for nearly a third of market share also improved its number to 31 percent in June this year from 30 percent in Iune last year, with number of subscribers



jumped to 17,192,496 from 15,980,922 respectively. Tanzania Telecommuication Regulatory Authority (TCRA) head office in Dar es Salaam PHOTO/FILE

Airtel Tanzania also managed to slightly expand its market share to 27 percent from 26.6 percent after increasing number of subscribers to 15,290,789 during the end of June this year from 14,162,213 recorded during the end of June last year, making it the second largest.

The report shows Tanzania Telecommunication Company Limited (TTCL), the government whollyowned market share closed at 3 percent from 2.4 percent respectively, as number of subscribers increased to 1,783,301 in June this year from 1,300,295 recorded in June 2021.

However, Halotel Tanzania lost part of their market share during the period reviewed to 12 percent in June this year from 13 percent in June last year with number of subscribers slowed to 7,021,425 in June this year from 7,581,691 in June last year.

Smile and Zantel also lost their market shares to 0 percent each in June

this year from 0.02 percent and 2.1 percent in June last year.

However, smile managed to increase its subscribers to 13,672 in June this year from 11,120 in June last year while there was no data for Zantel for June this year, as the telecom was combined by Tigo. In June last year the company had 1,135,015 subscribers.

Tigo and Zantel merged in November 2019, whereby the two combined their operations in the mainland and on the archipelago of Zanziba.

In April this year, Axian Group of Madagascar announced that it has partnered with Mr Aziz to close the \$100 million acquisition of Tigo and Zantel in Tanzania.

The new owners of the local telecommunication companies Tigo and Zantel in later month outlined future plans to invest over 1trn/- in strengthening network coverage, especially in the rural areas where there is poten

Oil price edges down as high inflation to impact demands

OIL prices dipped on Tuesday, paring some gains from the previous session, as the market feared that more aggressive interest rates hikes from central banks may lead to a global economic slowdown and soften fuel demand.

Brent crude futures for October settlement dropped 56 cents, or 0.5 percent, to \$104.53 a barrel by 0620 GMT, after climbing 4.1 percent on Monday, the biggest increase in more than a month.

The October contract expires on Wednesday and the more active November contract was at \$102.57, down 0.4 percent.

US West Texas Intermediate crude was at \$96.86 a barrel, down 14 cents, or 0.1%, following a 4.2 percent rise in the previous session.

Inflation is near double-digit territory in many of the world's biggest economies, a level not seen in close to a half century, which could prompt central banks in the United States and Europe to resort to more aggressive interest rate

"Risk appetite has cooled over an anticipation that the barrels per day, (Iraq's) domestic situation has no less im-

Federal Reserve would continue to increase interest rates ... A pull-back of natural gas prices in Europe also adds uncertainties to the picture of energy crisis," said analysts from Haitong Futures.

Also weighing on prices, Russia's oil output has exceeded expectations in the wake of the war in Ukraine, the head of the International Energy Agency (IEA) said on Monday. But he said that Moscow, which calls its actions in Ukraine "a special operation", will find it increasingly difficult to uphold production as Western sanctions begin to bite.

IEA members nations could release more oil from strategic petroleum reserves (SPR) if they find it necessary when the current scheme expires, the head of the agency also said. However, political violence on Monday night in Iraq, OPEC's second-largest producer, supported prices.

Government security forces and militias loyal to Shi'ite cleric Moqtada al-Sadr clashed around the Green Zone that houses government headquarters and embassies in the capital Baghdad, killing 20, in a long-running dispute over the formation of a new government since elections last year.

"As a major oil exporter with an output of over 4 million



pact on oil prices than Iran," Haitong's analysts said.

Also offering some support to prices is tight supply. Saudi Arabia, top producer in the Organization of the Petroleum Exporting Countries (OPEC), last week raised the possibil-

Volt Resources to update Tanzania graphite study

AUSTRALIA Stock Exchange (ASX) listed Volt Resources has started a feasibility study to update Stage 1 of its Bunyu graphite project, in Tanzania.

The graphite producer has said that it would update the processing, infrastructure and logistics for the Stage 1 study, which was initially released in 2018, and would also update capital and operating cost estimates.

Volt would also re-examine other study aspects, including regulatory requirements, marketing and sales, financial analysis, project risks and environmental, social and community re-

The 2018 Stage 1 study was based on a mining and processing plant with a throughput rate of 400 000 t/y of ore, to produce an average 23 700 t/y of graphite products, estimating a capital cost of \$31.8-million to deliver.

The Stage 1 project is aimed to estab-

lish Volt's market position and infrastructure to support the development of the larger Stage 2 expansion project, which would increase production to 170 000 t/y of graphite product annually.

"Completing an updated feasibility study for Bunyu Stage 1 will provide us with a current estimate of what the project will cost to deliver and what its economic returns will be. Many factors have changed since the existing study in 2018 and it is important we account for these as we move ahead with its development," said Volt MD Trevor Matthews.

"With existing production and scalable opportunities from our long-life Zavalievsky graphite operations in Europe, I look forward to the outcomes of this update so that we can continue to progress the development of Bunyu as part of our future graphite supply and position Volt as an integrated supplier of battery anode and other battery products to lithium-ion battery and



The Bunyu graphite project is estimated to contain measured, indicated and inferred mineral resource of 461Mt graded at a total

other battery technologies in the US and Europe.

The Bunyu Graphite Project is wholly owned by Volt Resources and is located in Tanzania, East Africa, near sealed roads and 140km from the deep water Mtwara port.

The Bunyu graphite project received environmental impact assessment certificate in September 2018 from the National Environment Management Council of Tanzania (NEMC).

The graphite flake concentrate hosted at the mine is 99 percent purity commercial battery-grade graphite, which can also be used to produce graphite foil, refractory and lubrication products.

More than 80 percent of the concentrate consists of super jumbo, jumbo and large flakes of graphite.

The Bunyu graphite project is estimated to contain measured, indicated and inferred mineral resource of 461Mt graded at a total graphite content (TGC) of 4.9 percent.

The proven and probable ore reserves at Bunyu are estimated to be 127.4Mt graded at a TGC of 4.36 percent, containing 5.6Mt of graphite con-

SportPesa bags licence as BCLB climbs down

SPORTPESA has been awarded a licence to operate in the current financial year ending June 2023, ending years of regulatory and court battles pitting the firm against the Betting Control and Licensing Board (BCLB).

A list of betting firms authorised to operate in the 2022/23 fiscal year shows that Milestone Games Limited -which operates under the SportPesa brand- has been awarded licence number 0000448.

The regulator published the updated list of authorised betting firms on its website. Milestone has in the past two years relied on a temporary court order to operate amid battles over ownership of the SportPesa trademark.

Pevans East Africa pioneered sports betting in the country in November 2013 with the SportPesa brand and operated until July 2019 when its licence was cancelled for what BCLB said was non-payment of taxes amounting to Sh95 billion.

Milestone subsequently entered the betting business on October 30, 2020, using the SportPesa trade name and it was issued a directive by BCLB on the same day to stop using the

The regulator at the time said the trademark belonged to Pevans. It later emerged that two shareholders of Pevans -Paul Wanderi Ndung'u and Asenath Wacera Maina- were left out of the ownership of Milestone.

The duo has sued the Registrar of Trademarks and Milestone, arguing that the brand was irregularly transferred from Pevans.

It was not immediately clear what prompted the change of stance at BCLB that saw the regulator issue Milestone with a permit. Mr Ndung'u had, however, issued a public statement recently, predicting that the regulator would soon clear Milestone due to pressure from powerful individuals close to the outgoing administration.

"The same Cabinet Secretary (Fred Matiang'i) has ensured that all the relevant government institutions and multi agencies have cleared Milestone Games Limited to get a licence within the June/July within all necessary means that the power of state confers to the institutions," Mr Ndungu wrote in a letter dated July 30, 2022.

The letter was addressed to President Uhuru Kenyatta to whom he appealed to reverse the takeover of the SportPesa brand and assets. Milestone is among 46 firms cleared by BCLB to operate in the current fiscal year.

A majority of the companies were cleared by the taxman between the start of last month and August 5, paving the way for the issuance of their licenses by the BCLB. "Between 1st July and 5th August 2022, a total of one hun-

dred and five (105) companies have been cleared by KRA for issuance of BCLB licence." KRA said in a response to Busi-

STOCK and bond markets attempted to steady on Tuesday, as investors turned their focus to inflation data and this week's US labour market report, to gauge if interest rate hikes that have been priced in around the world are justified.

By early afternoon, MSCI's broadest index of Asia-Pacific shares outside Japan was up 0.2%, while Japan's Nikkei stock index rose 1.2%, in part helped by a fresh round of weakness in the Japanese yen.

Wall Street indexes fell on Monday, but the pace of selling was reduced and U.S. stock futures edged up by 0.3% in Asia. European stock futures strengthened, with the pan-region Euro Stoxx 50 futures up 0.6% and German DAX futures up 0.6%.

Global stocks, bonds fumble for footing as focus turns to data

FTSE futures were down 0.26%.

Besides interest rates, the health of China's economy is also at the forefront of investor concerns. China's benchmark Shanghai Composite Index shed 0.6% on news that several big cities had ramped up COV-ID-19 restrictions.

Hong Kong's Hang Seng was also dragged 0.9% lower as investors have started walking back their enthusiasm about an agreement struck between China and the United States for access to Chinese companies' audit papers.

At the Jackson Hole conference last week, Federal Reserve Chair Jerome Powell and European Central Bank speakers struck a hawkish tone, driving



selling of bonds and equities as traders jacked up near-term interest rate expectations.

"The markets focus for the next couple of weeks at least, will be the likely Fed action," said Manishi Raychaudhuri, head of APAC equity research at BNP Paribas.

"Earlier, there was talk of a pivot of a possible cutting of interest rates by the Fed, maybe in 2023 second half or so, but that is now sort of falling by the wayside," he said.

"Higher for longer (interest rate) is possibly the kind of narrative that's building up."

U.S. non-farm payrolls data is due on Friday, and markets may not like a strong number if it supports the basis for a continuation of aggressive interest rate hikes. Ahead of that, German inflation figures due 1200 GMT Tuesday and China's manufacturing survey due on Wednesday will be closely watched.

U.S. Treasuries settled down on Tuesday morning. The twoyear yield fell to 3.3987%, after rising as high as 3.489% on Monday, its highest since late

Benchmark 10-year yields also fell to 3.0670%, down from 3.13% on Monday. Gilts will likely face pressure when British markets return on Tuesday from a holiday on Monday.

Stanbic Bank to auction Jubilee building for Sh435m

A SEVEN-STOREY building in Nairobi leased out for nearly a decade to the ruling Jubilee Party has been put up for auction, with the bank targeting raising Sh435 million from the prime property.

Stanbic Bank Kenya, a unit of South Africa's Standard Bank, is seeking to recover the millions of shillings over a debt that fell into default last year, people familiar with loan say.

The building, which sits 0.56 acres, is associated with a former top official in the administration of President Daniel arap Moi and who served as MP in the Rift Valley.

The Business Daily was unable to establish the size of the unpaid loan in an economy where a number of prominent personalities have fallen into hard times as they battle auctioneers over unpaid bank loans.

They are struggling to hold onto their prime assets over mounting bank loans as Kenya's economy slows down and repossessions pick

The Nairobi office bloc, which was Jubilee party's centre of operations in 2013 and 2017 elections, will be sold when the auctioneer's hammer falls on September 13.

Bank loan defaults have crossed the half-a-trillion shilling mark for the first time, setting up thousands of borrowers for property seizures in an economy hit with reduced cash flows and inflation that has squeezed household

budgets and demand for goods.

The latest Central Bank of Kenya (CBK) data shows that defaulted loans rose by Sh30.6 billion in June to Sh514.4 billion -- the sharpest monthly increase in recent history.

A severe drought, surging inflation

Inflation hit a 62-month high in July at 8.3 percent on the back of a jump in the price of essential items like cooking oil, food, fuel and soap, squeezing household budgets and demand for goods and services.

EU draws up emergency plan to cut energy costs

BRUSSELS

BRUSSELS is drawing up emergency plans to reduce the cost of energy, amid warnings from the boss of Shell that the gas crisis is set to last for several years.

Ursula von der Leyen, president of the European Commission, said the bloc needed an "emergency instrument" to cope with the crisis and would try to break the link between gas and electricity prices which amplifies the impact of gas shortages.

The move will increase the pressure on the UK to do the same, with ministers setting out similar plans in a review of electricity market arrangements published in July which is being reviewed by industry.

Gas and electricity costs have soared as Russia cuts gas supplies to Europe triggering a major economic shock, with British households facing an 80pc hike to annual energy bills in October, to £3,549, and many businesses struggling to survive.

Yesterday Uniper, Germany's largest importer of Russian gas, which owns a string of power stations in Britain, asked for a further €4bn (£3.4bn) in help from the German government, having drawn down a €9bn state-funded credit line to cope with soaring costs.

Ben van Beurden, chief executive of Shell, one of Europe's largest energy companies, warned that the energy crisis will last for several winters and it was a "fantasy" to think shortages could be resolved quickly.

He said energy rationing may be needed for years, underlining the scale of the challenge facing politicians as they try to find a way out of the crisis.

Speaking at an energy conference in Norway, he said: "I do not think this crisis is going to be limited to just one winter. It may well be that we have a number of winters where we have to somehow find solutions through efficiency savings, through rationing, and through a very quick build out of alternatives that you may have [such as] alternative gas imports [and] hopefully alternative en-

His warning came as Elon Musk said "civilisation will crumble" without oil and gas as he warned the switch to green energy will take several decades.

The Tesla chief said the world needed to continue extracting oil and gas while it develops renewable energy. He told the same conference, ONS 2022 in Stavanger, that the transition to sustainable energy was "one of the biggest challenges the world has ever faced".

"Realistically I think we need to use oil and gas in the short term, because otherwise civilization will crumble," he said. "One of the biggest challenges the world has ever faced is the transition to sustainable energy and to a sustainable economy. That will take some decades to complete." The European gas benchmark fell 11pc yesterday to €267 per MWh, compared to long-term pre-crisis averages of around €20 per MWh. Meanwhile, forward electricity prices in Germany climbed above €1,000 per MWh for the first time - about 20 times higher than historical long-term averages.

Flows along the key Nord Stream 1 pipeline to Germany are down to 20pc of capacity and there are concerns Russia will use a three-day maintenance shut down from Wednesday to curtail supplies further.

EU countries have agreed to cut demand for natural gas by 15pc this winter to try and cope, with prices already forcing many households and businesses to use less.

Electricity prices rise alongside the price of gas partly because so much electricity is still made in gas-fired power stations, more than 35pc in the UK and in the EU.

Angola's governing party wins election, extends long rule

LISBON

ANGOLA'S electoral commission on Monday declared the ruling MPLA, in power for nearly five decades since independence, the winner of last week's national election, handing President Joao Lourenco a second term amid concerns about possible fraud.

The commission gave the ex-Marxist People's Movement for the Liberation of Angola a 51.17 percent majority after all votes were counted. Its longtime opponent, the National Union for the Total Independence of Angola, or UNITA, got 43.95 percent, its best result ever.

Fewer than half of Angola's registered voters turned out for Wednesday's election which, despite being the closest fought yet, extends the rule of the MPLA that has ruled since independence from Portugal in 1975 and defeated UNITA in a long civil war.

UNITA leader Adalberto Costa Junior has rejected the results, citing discrepancies between the commission's count and the main opposition coalition's own

Analysts fear any dispute could ignite mass street protests and possible violence among a poor and frustrated youth who voted for Costa Junior.

UNITA won in Luanda, Angola's most populous province, and in Cabinda and Zaire, the provinces which produce most of the coun-

The final tally came a day after the funeral of Angola's long-serving ex-ruler and MPLA stalwart, Jose Eduardo dos Santos, who died in Spain in July.

Lourenco, 68, has pledged to press on with reforms in his second term, including privatising poorly run state assets and continuing to clean up corruption after investigating wealthy and powerful members of the Dos Santos family.

But his reforms have so far failed to create a fairer distribution of Angola's vast oil wealth, which remains mostly in the hands of a few well-connected MPLA officials.

'Return money stolen from Afghans': Russia tells US to pay for 20-year occupation

UNITED NATIONS

RUSSIAN Permanent Representative to the UN Vasily Nebenzya called on his US counterpart Linda Thomas-Greenfield return the money stolen from the Afghan people, instead of trying to make others pay for someone else's bills during the UN Security Council meeting on Afghanistan.



Thomas-Greenfield claimed during the meeting that Russia allegedly contributes too little to funding the restoration of Afghanistan.

"From the long-winded speculations of our US colleagues, this could be perceived as a call to Russia and China to pay for the restoration of Afghanistan. Allegedly, it is the US and its allies who are paying for everything, while all that Russia and China only do is just empty talk.'

"The cynicism of such claims is simply shocking. We are being called upon to pay for restoring the country, whose economy was effectively destroyed by the 20-year-long occupation by the US and NATO," the diplomat noted. "Instead of admitting it's own mistakes and trying to fix them, we are being accused of being unwilling to pay for someone else's bill. It is an interesting proposal."

"No, our dear former Western partners, it is you who must pay for your own mistakes," the diplomat specified. "And, for starters, it is necessary to return the money stolen from the Afghan people back to them. We have been helping and will help Afghanistan. And we suggest that you focus on paying the bills to the Afghan people for the 20 years of [your] pointless occupation, which destroyed Afghanistan and which put its people on the brink of sur-

"Not everything can be measured in money. The lives of those who died during your imposition of democracy in Afghanistan cannot be measured with money; nor can money buy the loyalty of the people of Afghanistan, which the US has completely lost, apparently," Nebenzya

Pakistan floods cost at least \$10 billion, planning minister says

ISLAMABAD

EARLY estimates put the damage from Pakistan's recent deadly floods at more than \$10 billion, its planning minister said on Monday, adding the world has an obligation to help the South Asian nation cope with the effects of man-made climate change.

Unprecedented flash floods caused by historic monsoon rains have washed away roads, crops, infrastructure and bridges, killing at least 1,000 people in recent weeks and affecting more than 33 million, over 15% of the country's 220 million population.

The climate change minister has called the situation a "cli-

mate-induced humanitarian disaster of epic proportions." "I think it is going to be huge. So far, (a) very early, preliminary estimate is that it is big, it is higher than \$10 billion," Ahsan Iqbal told Reuters in an interview.

"So far we have lost 1,000 human lives. There is damage to almost nearly one million houses," Iqbal said at his office.

"People have actually lost their complete livelihood." Iqbal rated the recent floods worst than those that hit Pakistan in 2010, for which United Nations had issued its largest ever disaster appeal.

The minister said it might take five years to rebuild and rehabilitate the nation, while in the near term it will be confronted with acute food shortages.

To mitigate food shortfalls, Finance Minister Miftah Ismail said the country could consider importing vegetables from arch-rival India.

The two neighboring countries have not had any trade for a long time.

"We can consider importing vegetables from India," Ismail told local Geo News TV, adding other possible sources of food imports included Turkey and Iran.

Food prices have already shot up due to flooded crops and impassable roads.

India Prime Minister Narendra Modi said he was saddened by the devastation caused by the floods.

Climate change victim

Social media users posted videos showing stranded people and whole families washed away by floodwater. Reuters was unable to independently verify the footage.

Southern, southwestern and northern Pakistan have been the hardest hit by the floods, which have swept large swaths of farmland and stored crops, also isolating the regions from rest of the country for the last several days.

CHINA'S foreign trade maintained double-digit growth in the first seven months of this year, despite the unfavorable external situation, intermittent COVID-19 impacts and other negative factors.

The country's foreign trade volume reached 23.6 trillion yuan (\$3.49 trillion) between January and July, increasing 10.4 percent year-on-year, according to statistics released by the General Administration of Customs (GAC).

In particular, exports grew 14.7 percent year-on-year to 13.37 trillion yuan, and imports reached 10.23 trillion yuan, up 5.3 percent. The country's trade surplus expanded 62.1 percent to 3.14 trillion yuan during the same period.

China's foreign trade growth sees stable recovery in January-July period

The ASEAN, the EU, the U.S. and South Korea maintained the four largest trading partners of China in the January-July period. Their trade volume with China stood at 3.53 trillion yuan, 3.23 trillion yuan, 2.93 trillion yuan and 1.39 trillion yuan, up13.2 percent, 8.9 percent, 11.8 percent and

8.9 percent, respectively. China's trade volume with Belt and Road countries expanded 19.8 percent year on year, and that with the 14 Regional Comprehensive Economic Partnership (RCEP) economies was up by 7.5 percent in the first seven

months of this year. In the first half of this year, Shanghai's foreign trade had withstood the test of the Pandemic. With the acceleration of the resumption of work and production, Shanghai's local economy has returned to normal, strongly boosting the city's imports and exports.

In June, Shanghai's foreign trade growth turned positive, standing at 9.6 percent, up 46.2 percentage points from that in April.

"Both the numbers of incoming containers and enterprises' pickups have significantly increased. We are currently working at full capacity," said customs officer Wei Jianhua from Shanghai's Wusong district. Wei

told People's Daily that the Wusong customs handled 37,000 batches of goods in June, up 46.3 percent from a year ago and 370 percent from a month ago.

Statistics indicate that Shanghai municipality, as well as Jiangsu, Zhejiang and Anhui provinces, all of which are located in the Yangtze River delta, reported combined foreign trade growth of 11.7 percent in the January-July period, up 2.5 percentage points from that in the first half of this year. The figure was 25.7 percent in July alone, contributing over half to the national foreign trade growth.

According to statistics, China's

trade with RCEP partners reached 1.17 trillion yuan in July, up 18.8 percent year on year, boosting China's overall foreign trade growth by 5.6 percent-

age points. "The policy dividends released by the RCEP have helped us expand the overseas market. We'll learn more about the requirements on imports from China set by Thailand, Singapore, Vietnam and other RCEP members, so as to introduce our products to these countries," said Zhang Hao, who heads a high-tech company in south China's Inner Mongolia autono-

mous region. Recently, a batch of sea-buckthorn

drinks weighing 115 tons and worth 1.62 million yuan produced by Zhang's company received a certificate of origin under the RCEP. These products will enjoy a tariff cut of over 30,000 yuan when exported to Japan.

The company has exported 2,556 tons of sea-buckthorn drinks and capsules this year, with a total value of 35.16 million yuan.

"The tariff for our formic acid exports to Japan has been reduced to zero from 4.3 percent, while that for hexafluoropropylene from 3.1 percent to 0.3 percent," said Zhang Guoqing, director of the sales division of Luxi Chemical Corp, a chemicals company based in east China's Shandong province.

Sanctions hamper Russian gas supplies to Europe – Kremlin

MOSCOW

NOTHING hampers the supply of Russian gas to Europe, except sanctions-related technological problems, Kremlin spokesman Dmitry Peskov told reporters yesterday.

Gas supplies to Europe via the Nord Stream gas pipeline will be suspended for three days from August 31 due to the repair of the only gas pumping unit remaining in operation.

"For sure, apart from technological problems caused by sanctions, nothing hampers supplies. Russia was and remains ready to fulfill all its obligations," the Kremlin spokesman said in response to a question about whether there are guarantees of resuming supplies via this route after the work was completed.

He recalled that EU countries, the UK, Canada and the US had imposed sanctions against Russia, which "do not allow normal service and repair work, and gives no rooms for the legal registration of the return of necessary units and assemblies to their places of operation." There are no other obstacles facing Russia to fulfill its obligations, Peskov noted.

"This concerns those irrational actions of Europeans, which are very difficult to understand and, probably, impossible to explain, but for which ordinary citizens have to pay a lot," he concluded.

The Nord Stream gas pipeline, which supplies gas from Russia to Europe, has been operating at about 20% of its maximum capacity since July 27 due to the shutdown of several gas turbines.

One of them, made in Canada by Siemens Energy, was sent to Montreal for repairs. Due to Ottawa's sanctions against Russia, the manufacturer initially refused to return the repaired turbine to Germany, but after numerous requests from Berlin, the company decided to do it.

On July 25, Gazprom announced the forced shutdown of another gas turbine engine at the Portovaya compressor station. Consequently, only one turbine remains in operation.

US Department of Justice completes review of documents seized in Trump raid

WASHINGTON

THE U.S. Department of Justice (DOJ) on Monday finished examining documents seized in the raid of former President Donald Trump's Mar-a-Lago residence in Florida.

The completion of the review could undermine Trump's legal team's efforts to prevent any such examination of the documents until a third party is appointed to review them.

This comes just days after a federal judge in Florida on Saturday signaled she could appoint a "special master" to review some of the documents obtained in the raid. U.S. District Judge Aileen Cannon, who had been appointed by Trump himself, did not order a review but rather said she had a "preliminary intent" to do so. That was after the judge heard arguments in her courtroom on Thursday.

Trump's legal team had filed a request last week for a third party to look over the documents that the Federal Bureau of Investigation (FBI) agents obtained during the Aug. 8 raid of the former president's Mar-a-Lago residence.

The FBI raid of a former president's home sparked outrage from Republican lawmakers and conservative media. The FBI claimed it had "probable cause" that warranted a raid, as the bureau believed it would find "evidence of obstruction" -- a crime in the United States -- at Trump's residence.

Trump's legal team said the search was too broad and noted that agents whisked away the former president's passports. On Friday, Bruce Reinhart, another federal judge, ordered the release of a copy of the search warrant affidavit that allegedly described how agents in May had discovered nearly 200 documents that were marked according to how secret they were.

Those documents were located in boxes at Trump's Florida address. But the affidavit was so heavily redacted that entire pages were blacked out, according to U.S. media.

The affidavit said 25 of those documents were labeled "top secret." Sixty-seven were marked as "confidential" and 92 labeled "secret." White House press secretary Karine Jean-Pierre on Monday emphasized that the FBI is conducting an independent investigation and that "we have not been involved."

That came after critics' accusations that the White House is using the DOJ -- whose head was appointed by U.S. President Joe Biden -- to prevent Trump from running for re-election against Biden in 2024.

Meanwhile, Trump on Sunday took to Truth Social, the social media platform he founded, to claim the FBI and DOJ were engaged in election interference "at the highest and most dishonest level our country has ever seen before, both in the Midterms, and the 2024 Presidential Election."

That followed a Trump post on Saturday that the FBI raid was a "disgrace to our now Third World Nation!" Trump called the raid an "unprecedented, unnecessary, and unannounced FBI/DOJ Raid (Break-In!) of my home, Mar-a-Lago.

This assault was done for political purposes just prior to the Midterm Elections (and 2024, of course!). It is a disgrace to our now Third World Na-

Trump posted. The FBI raid has caused a GOP uproar, with Republican lawmakers alleging that the action has turned the leader of the West into a "banana Republic.'

Republican Florida Governor Ron DeSantis labeled the search "another escalation in the weaponization of federal agencies against the Regime's political opponents."

Experts: Nuclear deal survival 'up to the US'

HONG KONG

THE longevity of any newly restored Iran nuclear deal will depend on the United States who unilaterally abandoned the original pact in 2018, according to experts.

The expert comments came as the US irons out concessions with Iran with a possible resurrection of the scuppered 2015 deal on the horizon.

The analysts also said Iran's re-engagement with the world economy, currently limited by US-led sanctions, through a renewal of the deal, would offer relief to a global system which has been battered by the COVID-19 pandemic and the Ukraine-Russia conflict.

In a press conference in Tehran on Aug 29, Iranian President Ebrahim Raisi said that the lifting of anti-Iran sanctions and unfreezing of Iranian assets abroad have been at the core of the nuclear talks

He said that Iran did not seek to develop nuclear weapons but would employ nuclear technology for civilian purposes and that Iran's nuclear industry and nuclear capability "are the right of the Islamic Republic and the people of Iran."

Raisi said his country seeks to use nuclear technology in agriculture, oil and gas, medicine and many other civilian sectors and that safeguard issues should be resolved before reaching an agreement between Iran and other signatories to the deal, namely China, France, Russia, the UK and the US plus Gemany.

He was referring to reports from the International Atomic Energy Agency, or IAEA, about the alleged "discovery of uranium traces" in three locations that "has not been announced" by Iran. Iran insists the accusations are "political" and that the case should be closed "forever." man-made nuclear particles were

Jawaid Iqbal, chairman of the Department of West Asian and North African Studies at Aligarh Muslim University in India, said the latest mediated talks by the European Union between Iran and the US regarding the Joint Comprehensive Plan of Action, or JCPOA, "will not play out in a simple

Iqbal said that Tehran has laid down three conditions for accepting the EU's proposals, which include the lifting of sanctions, the guarantee that no future US president would renege on the nuclear deal if it were revived, and the closure of the IAEA's probe into several Iranian nuclear sites, where found several years ago.

"The US has been unwilling to allow these concessions due to the presence of hawkish foreign policy experts in US President Joe Biden's administration and the pressure being applied by the Zionist lobby," Iqbal said.

"The planned visit of Mossad head David Barnea to Washington next week for talks on the Iranian nuclear deal is indicative of the fact that anti-Iranian hysteria will continue to act as a stumbling block in the restoration of the JCPOA," he added.

English language online newspaper Times of Israel reported on Aug 28 that Barnea, the chief of Israel's intelligence agency, will travel to Wash-

ington next week to discuss the Iran deal, which Barnea and Israeli senior government officials have criticized as a bad deal.

The report said a senior Israeli government confirmed that the White House was aware of Barnea's trip but was keeping quiet on whether the Biden administration was involved in its planning.

Despite the challenges, Arhama Siddiqa, a Middle East expert and research fellow at the Institute of Strategic Studies Islamabad in Pakistan, said that the US and Iran appear to have resolved many "bones of contention" that have been impediments to the revival of the deal - something which was "unthinkable even until last year.'

She said it would not have been possible had it not been for the Russia-Ukraine standoff earlier this year, which has left a significant gap in the supply of oil.

"The longevity of the deal will depend upon a concrete assurance by the US to not unilaterally withdraw from the deal as it did the last time. It should acknowledge that Iran and Russia are staunch partners as is Iran and China - and the US should not let Iran's bilateral relations cloud its judgment," Siddiqa said.

Negotiations on the revival of the 2015 nuclear deal began in April last year in the Austrian capital of Vienna but were suspended in March this year because of political differences between Tehran and Wash-

The latest round of the nuclear talks was held in Austria's capital Vienna in early August after a fivemonth hiatus. On Aug 8, the EU put forward a "final text" of the draft decision on reviving the 2015 nuclear deal.

"The Russia-Ukraine standoff has been heavy, yes, globally, but primarily for European countries. Russia supplied the EU with 40 percent of its natural gas last year. Revival of the JCPOA means resumption of Iranian gas exports globally," Siddiqa said.

"With a renewal of the deal, there can be a resumption of Iranian oil and gas exports worldwide, thus filling the void and much needed relief for conflict fatigued global consumers," Siddiqa added.

Economic blocs seen to serve US goals in supply chains

IN recent months, business advisers and scholars have raised sharp questions over the feasibility and the geopolitical intentions behind a slew of fresh exclusive economic blocs being pushed by the United States.

These new groupings have campaigned for a "free and open" economy, but the real plan is to secure US economic and geopolitical hegemony at the cost of existing relevant regional cooperation platforms and the very interests of countries around the world, they said.

The Indo-Pacific Economic Framework for Prosperity was launched during US President Joe Biden's visit to Ja-

The first in-person ministerial meeting of the framework is expected to be held Sept 8 and 9 in Los Angeles, Japan's Kyodo News agency quoted government sources as saving.

Aside from the US, the framework comprises 13 nations, including Australia, Japan, South Korea and some ASEAN member countries.

"The framework, known as the IPEF, is aimed at balancing Beijing's rising economic clout in the fast-growing region," Kvodo said.

Many business advisers, media and experts warned that the framework offers limited value for the Asian nations involved.

German broadcaster Deutsche Welle said the framework is not about a freetrade pact and that it boasts "high-standard commitments" to "deepen economic engagement".

The framework is an executive agreement that "will not require congressional approval, meaning that it will lack the force of law within the United States and will be at the mercy of changing political winds", South Korea's JoongAng Daily newspaper said on Aug 21. Deborah Elms, founder and executive

director of trade policy analyst the Asian Trade Centre in Singapore, said in a briefing for the National Press Foundation last month that "almost nothing in the Trans-Pacific Partnership is in IPEF."

The Trans-Pacific Partnership was a free-trade agreement that the administration of then US president Donald Trump withdrew from in 2017.

Wang Peng, a research fellow at Huazhong University of Science and

Technology's Institute of State Governance, said the framework of the IPEF is "a combination featuring strong ideological values and norms "when pursuing a resilient and flexible supply chain that will minimize their ties with

"Engaging countries like Japan and South Korea will help sustain the US comparative advantage in cutting-edge sectors such as semiconductors and chips," he said.

At the same time, the US "aims to keep its allies and partners locked in various economic and defense arrangements" as it keeps lobbying the framework, contracting countries such as India and those in Southeast Asia to replace China's role in some middle- and low-end supply chains, he added.

Xu Liping, director of the Center of Southeast Asian Studies of the Chinese Academy of Social Sciences, said there are seven ASEAN countries among the framework's founding members.

"Joining the framework may sow discord and lead to conflict of interests between China and the seven ASEAN countries, and may mean more pressure on them when they are required by Washington to take a side between China and US," Xu said.

Separately, a group called The Partners in the Blue Pacific, an initiative including Australia, Japan, New Zealand, the United Kingdom and the US, mainly offering aid to Pacific island countries, was announced on June 24.

The five PBP countries said in a joint statement issued on that day that they are united in how they realize the initiative is to be "led and guided by the Pacific islands". However, scholars and analysts from countries, including Australia and the US, criticized the initiative as "deceptive, controlling and hypocritical.

"The PBP initiative ... effectively forms a special group of five 'likeminded' partners with a shared interest in displacing or competing with China. This, then, becomes a new grouping in the regional architecture an inner circle which complicates and ignores existing structures," said an article by Greg Fry, honorary associate professor at Australian National University, and Tarcisius Kabutaulaka and Terence Wesley-Smith, both scholars with the University of Hawaii.

Zhong Feiteng, director of the Center of Regional Security Studies of the Chinese Academy of Social Sciences, said the initiative is "working on fanning up a new round of bloc confrontation in the pretext of advancing economic and development assistance".

In contrast, China has been working on collaboration and exchanges with Pacific island countries since the 1970s. From 1992 to ye 2021, the trade volume between China and Pacific island countries having diplomatic relations with China registered an average annual increase of 13 percent and expanded by over 30 times.

More African countries regret Morocco's absence from TICAD

tries, the Central African Republic, Burundi, and Equatorial Guinea have all regretted Morocco's absence from the 8th edition of the Tokyo International Conference on Africa Development (TICAD), which was held over the weekend in Tunis.

As a result of Tunisia's abrupt abandonment of its decadesold neutrality in the Western Sahara dispute by inviting the Polisario leader Brahim Ghali to the TICAD, Morocco decided to boycott the conference, escalating tensions between the two neighboring countries.

"The Central African Republic supports the statement of President Macky Sall, Chairman-in-Office of the African Union regarding the absence of Morocco and the failure to comply with the rules established for participation in this Summit," said the country's President Faustin Archange Touadera at the con-

Macky Sall, President of Senegal and current Chairman of the African Union, had expressed regret that Morocco, "a prominent member of the African Union," was not present at TICAD.

The Senegalese president also urged Rabat and Tunis to work toward finding "a lasting solution in the future for the smooth running of our organization and our partnership in a serene and peaceful way."

Also expressing regret over Morocco's absence from the TICAD summit was Burundian President Evariste Ndayishimi-

"We regret the absence of the Kingdom of Morocco from TICAD due to the lack of consensus during the negotiations that preceded these meetings," Ndayishimiye said during a plenary session on peace and secu-

"Our most fervent wish from JOINING other African coun- Burundi is to avoid such divisions in future sessions," he added, recalling that TICAD's goal is to have their visions and approaches operating in unison for the sake of worldwide solidarity.

> Equatorial Guinea's Minister of Foreign Affairs Simeon Oyono Esono also expressed his country's regret for Morocco's absence at the conference.

> "We regret the absence of the Kingdom of Morocco, a country of particular importance, from TICAD," Oyono Esono said, adding that he hopes Rabat and Tunis can find a long-term solution to the crisis.

> These positions are consistent with those of other African countries, which have condemned Tunisia's unilateral invitation of the separatist entity, opposed Japan's recommendation and in breach of the planning process and established procedures.

Mwakinyo aims to upset UK boxing fans in WBO title bout

TANZANIAN pugilist Hassan Mwakinyo is in high spirits as he continues to train intensively for his bout against Liam Smith for the World Boxing Organization (WBO) Super Welterweight title.

The world title fight will be held at the M&S Bank Arena in Liverpool, England September

Mwakinyo, alias 'Champez', who is regarded as a heavy puncher, revealed that he wants to take the WBO World title with the motivation he has in training for his bout.

The 27-year-old Tanzanian boxer most recently stopped former unified world champion, Namibian Julius Indongo, last September.

Through his social media platforms, Mwakinyo has written about how he boosts his morale, thinking of winning the title and he wants to return with the boxing honour back home.

"I think a lot about the night when I will be announced as the official WBO champion from Makorora, Tanga, Tanzania," Mwakinyo

The boxer who temporarily moved his residence to the United States has delved into strength training to ensure that he fulfills his dreams of becoming the WBO world champion.

Liverpool's Smith, alias 'Beefy', aged 34, (31-3-1, 18 KOs) will begin his campaign for a

second world title shot when he headlines at the M&S Bank Arena against Tanzania's number one boxer in Super Welterweight.

Making his way to Merseyside to face the hometown hero is the heavy-handed Mwakinyo (20-2, 14 KO's).

The Tanzanian pugilist shocked the British boxing fanbase on his 2018 visit to the UK when he demolished the infamously tough Sam Eggington in just two rounds.

Mwakinyo is undefeated since then and is coming off three consecutive stoppage victories, the former World Boxing Federation (WBF) Intercontinental champion has scored 70% of his victories by either KO or TKO.

The pugilist has to stop power in both hands and is traveling to the UK intent on upsetting the home fans once again.

Smith can edge closer to a world Super Welterweight title fight with a win over Mwakinyo after his ruthless stoppage win over Jessie Vargas in Madison Square Garden in New York, the USA earlier this year.

Currently ranked in the top five by three of boxing's major sanctioning bodies, Smith last won the WBO World Light Middleweight title in 2015.

The boxer has propelled his name back into the world championship contender conversation with stoppage wins in his last two fights and is now set on winning a second world title as part of the BOXXER stable.

Inside Jesse Marsch's Leeds revolution: 'it's not harmony, it's about identity'

MARC Roca lets out a shout of frustration as a move breaks down, and his group head back to halfway to try again. It's early Wednesday morning at Leeds United's training ground Thorpe Arch and the team are preparing for the Sunday match against Chelsea.

The whole passage of play restarts. The attack wins the ball off the defence in midfield, Jack Harrison emerges down the wing, zips past a defender and slips it to Roca, who squares it for Tyler Adams to thump it home. Roca turns to two people watching and roars approval, and amid some laughter they head back to start the drill again. All the while Jesse Marsch and his coaches watch, offering tweaks here and there.

Once training has finished and the players have had lunch and showered, they head off in various directions, but Brenden Aaronson is left holding a soaked sponge; the USMNT star is covered in water and foam. He lost one of the games in training, and his forfeit was to clean Adams' car.

It's all very relaxed. Four days later, Leeds hammered Chelsea 3-0 and moved up to second in the Premier League. You wouldn't know that months earlier, the club were scrapping against relegation.

When Marsch took over from Marcelo Bielsa at the start of March, Leeds were fighting for their Premier League life. The environment he encountered was tense, the strain of the situation getting to the players. "I could see the stress when I came in, and I knew the job I thought I had to do was maybe five times harder," Marsch tells ESPN.

But as they hit a midseason reset, they started clocking up the points and on the final day, the club avoided relegation thanks to their win at Brentford and Burnley dropping points elsewhere. Then the focus shifted to the next season in the Premier League under their new boss.

The summer saw two star players leave in Raphinha and Kalvin Phillips, with that money reinvested in seven new faces, giving Leeds an opportunity to evolve. The players brought in all slot into how Marsch wants his team to play: high-pressing, quick-tempo, relentless, claustrophobic football. The recruits were perfect for Marsch's system and made an immediate impact. But though there's a short-, medium- and long-term plan for the club, none of that detracts from the weekly necessity of racking up points and making sure they're nowhere near another relegation scrap.

"I know the longevity of a person in these positions is not great," Marsch says. "But every job I take, I treat it as I'm the custodian of the club. I try to operate in the best interests of the club and team, and I find if you do that effectively, you can create both short-term, and long-term success. Now, here at this level, it's the biggest challenge of my life, right?"

When he was first approached by Leeds, Marsch wasn't sure if he was ready for a return to the hot seat. The outgoing manager was seen as a footballing deity by Leeds fans, having led the club back into the Premier League for the first time in 16 years and into the ninth spot in their return to the top flight. But their form was troubling in the 2021-22 season and by the end of February, the club and Bielsa went their separate ways.

When February ticked around into March, Marsch was enjoying time away from the daily rigours of management. His previous role at RB Leipzig hadn't worked out, and he left in December after just four months in the post.

He spent the intervening period travelling, visiting friends, spending time with his family and soaking up new experiences. Then the phone

"Leeds came knocking before I thought I would get back to work, and my first thought was the timing wasn't right," Marsch says. He spoke to his wife, Kim, and to his three children. Hearing he was approached by a club is nothing new. Kim's message

to Jesse has always been to not tell the family of potential interest "until it gets serious because things get tossed around all the time," he says.

Marsch was approached by the club after sporting director Victor Orta had identified him as the best man from 42 potential candidates to replace the outgoing Bielsa. "I would say Victor and his team do a really good job of scouring the world really looking for – and using data very heavily, data and analytics – the right types of players that can fit into the way that we think about football," Marsch says. "This was how they found me as the coach."

Marsch was originally keen to take over at the end of the season, rather than midway through the campaign, but as he thought more about the opportunity, he envisaged these jigsaw pieces clicking together.

"The more I looked at the potential of what I thought the club and the team could be, the more excited I got," Marsch says. "I changed my mind overnight. I knew I was going to have to dig into everything on a higher level and faster than I wanted to, but that the reward and opportunity was bigger than the threat of failure. I came here because I felt like Leeds was the right place for me."

On arrival, he knew the potential and ability of the group, but the key was to tap into it amid a period as stressful as the club had endured for some time. "At the start Andrea [Radrizzani, the majority shareholder at Leeds] asked me how quickly I could transform the team from the way Marcelo played into the way I wanted to play. I wasn't totally sure, because I'd never taken over a team so deeply ingrained in a specific style to what I wanted. But I think we did well; it wasn't just the style of play, but also the stress of the relegation situation. It meant we had to free the players to commit intellectually, physically and emotionally to what we needed to become."

Marsch emptied the tank over those twoand-a-half months leading up to the final day. Rodrigo, the Spain striker, speaking back in March, said Marsch's first on-field steps were to shift the team away from one-vs.-one marking to zonal, and it helped their transitional play from defense to attack. He also emphasised how Marsch "tried to understand everyone" to figure out how to get the best out of the squad. Some players needed picking up, other players needed reminding of their ability.

"As soon as he came in, he's been brilliant," Daniel James tells ESPN. "He's good with everyone, giving information all the time. He's someone you can approach with anything, anytime."

After several heart-stopping moments and twists and turns, goals from Raphinha and Harrison gave Leeds a 2-1 win at Brentford, while Burnley losing to Newcastle United meant Marsch's side had successfully retained their top-flight status. "It wasn't easy to manage and I was trying to think of ways to help the group tactically and, to be fair, we have had good performances, it's just trying to put it all together that hasn't always looked perfect," Marsch said at the time.

"The stress has been high for three months, I've tried to stay calm and focus on us and you see the quality of the mentality and character."

As he reflects on the end of last season, Marsch smiles, but also exhales. He says it "required all of the experience and insight and expertise that I've gathered over my years to get this moving the way I wanted it to," though his memories of that day aren't around the goals but instead the fans and that connection they had with the team. After his first three months of working on psychology to get the team out of a relegation battle, the next stage was shifting attention to the football and the future.

Marsch headed back to the U.S. to refuel after the season. A couple of days in, he needed a new pair of jeans. He was in New York at the time, so he headed to the Levi's shop in Times Square. It was the usual routine he'd done tens of times before: train to Penn Station, 15-minute walk to the store. But this time, he had football fans asking him for a photo.

"That for me was an eye-opening moment, because I'd never been treated like that," he says. "You know, sometimes here around Leeds people know who I am. But back home, I never thought that that would be the case. So you know, there's obviously a sense of responsibility in terms of what that means."

His favourite on-field moment so far is Joe Gelhardt's goal against Norwich last term, but his most memorable off-field memories shift daily, from the fans he meets while out walking his dogs, to those waiting outside the training ground asking him to autograph a shirt while advising him which player to sign.

Leeds' summer outlay to date is roughly the same as the outgoings, with Raphinha moving to Barcelona for a £55 million transfer fee and Phillips to Manchester City for £42m. Both were key players, but the money has been reinvested in new faces: Aaronson and Rasmus Kristensen from FC Salzburg, Adams from Leipzig, Luis Sinisterra from Feyenoord, Joel Robles from Real Betis, Roca from Bayern Munich and Darko Gyabi from Manchester City.

From their opening three matches, we've seen Leeds operate in a 4-2-3-1, which shifts to a 4-2-2-2. The front three players -- Harrison, Aaronson and James started there against Chelsea - are largely interchangeable behind Rodrigo leading the line, and it's their mission to run like hell at the opposition. They hustle the opponents until they give up the ball and then attack at pace, in as quick and direct a manner as possible. Leeds are playing more vertically this season than before, but it's anchored on fitness and sprinting. You can see how the summer recruits have slotted in: Adams and Roca causing mischief in the midfield but forcing turnovers, and then it's up to Aaronson and Sinisterra to turn the opportunity of a counterattack into a goal-scoring chance.

Leeds also went for younger players, and it's their policy to offer such talents long-term contracts. They have the sixth-youngest average age of their starting XI in the Premier League, and it's all tuned into their policy in the transfer market.

"It's always an opportunity," Marsch says of the summer's business. "I don't care. If you're talking about failure, success, money, losing players, gaining players, it's always about seeing the opportunity and then seizing it. And so it's the reason I came here in the end was because I saw the opportunity even in a relegation fight of what Leeds United could become.

"And we tried to, at every moment, see what's happening within our team, within our transfer

politics. Within every decision we make we see where the opportunities are and how to grow and how to get better."

Their vast database includes many matching capabilities, but it comes down to a human touch. "Once the metrics match their metrics, then it's about really investing in who the person is to ensure the person we're bringing in honours the environment that we really are establishing and trying to create every day," Marsch explains. "And I think the balance of the two is what Victor does so well."

Some of the transfers were planned before Marsch's arrival, such as Aaronson from Salzburg. Leeds went for him in the January transfer window, but he decided to see the season out in Austria. And just days after Leeds' survival was confirmed, he was the first signing of the Marsch era.

Aaronson remembers his first meeting with Leeds and the appeal of the club. "Just the plan that the club had, you know, and the people surrounding it," Aaronson tells ESPN. "The club wanted me here and was so supportive and showed me how much they wanted me here and how they wanted me to be a part of that plan. We have high expectations of the club and the fans do, too. And that's something I want to be a part of developing me as a player and as a person."

He was later joined by fellow USMNT starter Adams. While Aaronson finished the 2021-22 campaign on a high, Adams struggled in his last season at Leipzig while managing some niggling injuries, but his class endured. He was the player Leeds identified to form a double pivot with Roca in midfield, but they had to be sure about where his head was at first.

"I had a tough conversation with Jesse before I came here about finding the old Tyler," Adams said. "I felt like in my time at Leipzig I lost a little bit of confidence. I lost the way of, you know, who I was and what I wanted to become. And I got a little bit too much in my comfort zone.

"So we had a tough conversation, we talked over it, not an argument in any way or sense but some difficult points came across."

"I've known him for so long," Marsch said. "I'm very proud of him and I've always believed in him. Always, but I've also known that he's had challenges, you know, big challenges. And it's not just about playing or not, it's about how an environment works and how popula interest.

"When I brought him here, I said we just need you to get back to being the kind of player that you are and more freedom in the way that you express yourself as a person, as a player on the pitch. We have a really strong foundation of a team here and we have leaders in the team, but I wanted to make sure that he knew there was a responsibility to commit to the team fully in a selfless manner, because I know what the mental-

ity of the group and the character of the group is here."

"We took a week to reconnect," Adams said, "and I reflected on my time at Leipzig, you know, [and] what I wanted to become as a player and person, and when we reconnected I was all-in and bought into the idea of coming here and finding the old Tyler."

Adams describes the old Tyler as an "absolute beast on the field," someone who "doesn't really overthink anything." He fits the bill of what Marsch pictures as your archetypal Leeds player. Marsch says he wants his team to be known for their hard work, with his players "ready to fight and run and commit and do everything they can for every second of the match."

There may yet be further recruits this summer – Leeds are looking into bolstering their options up front – but only if the right player is there.

"I know that those transfers are always a lightning rod in the public and they want to see us continue to invest," Marsch says. "But we just want to make sure that every decision we make is the right one.

"I think the additions we've made have been perfect. Perfect. Right, really, I think the seven additions we've made have been fabulous. And the key is to keep that 100% rate. And it's almost impossible to do, but that's our job."

Leeds' season began with Wolverhampton Wanderers coming to Elland Road. The new-look team edged past Bruno Lage's side 2-1, thanks to goals from Rodrigo and (officially) an owngoal from Rayan Ait-Nouri, though Aaronson still claims he had the final touch. But there were no doubts over Aaronson's first in Leeds' win over Chelsea on Sunday, as he hustled Edouard Mendy to force the error that gave the team their opener. Their third was reminiscent of what they were practising in training Wednesday: winning the ball back, countering at pace and punishing the opponent.

But Marsch would have loved one statistic above all in that match, exhibiting exactly what he wants from his team: after 80 minutes, Leeds had run 11 kilometres farther than Chelsea. When Aaronson is told that statistic postmatch, the young American smiles and says that's what they want to be known for: work rate.

When you talk to the new signings about their first impressions of the Premier League, Adams says he was "absolutely shattered." But without prompting, they mention the Elland Road atmosphere. Aaronson says it was "electric," while Adams adds: "It gave me goosebumps. This kind of support is what pushes you on in the 90th minute to make that extra sprint back to tackle harder."

For Marsch, there are many moments that have emphasised how big a job managing the team is: like when he saw his first Leeds United tattoo on a supporter's leg on his first day, or when he heard the club's anthem coming from the stands. "This is what I love. You know, I don't like when they chant my name. I just don't, and I know they're doing it to be unified in what we're doing. But I love it so much more when I hear 'Marching on Together' or Leeds or Yorkshire or whatever, you know, it's not me I care about, it's the club and this is why I love being here."

He quickens the pace as he talks more about why he feels so at home at the club. "It's just a selflessness from every member of this entire sporting organization to help the team and to do whatever they need to do in their role for the on-the-field product to be what we all want it to become."

Marsch has also enjoyed interacting with the San Francisco 49ers, with 49ers Enterprises owning a 44% stake in Leeds. "I liked going to watch the 49ers train, seeing how they work, seeing how organized they are, and how they are structured," Marsch says, referring to his visit to the 49ers minicamp in the offseason. "That's been a bit of an eye-opener and very interesting to see. And I think it's helped me even organize things. And I like to be organized. I like to be on top of things. I don't like to be caught by surprises."


The focus shifts to what Marsch hopes Leeds achieve in the future. "We can't feel too good about ourselves, we can't feel too bad about ourselves. We just have to have a relentless commitment to keep moving forward.

"The goal isn't to have total harmony, but to create a common understanding as to what we are, our identity and to commit to that every day. I don't have a problem of telling somebody if they're not carrying their weight, or of telling them how disappointed or angry I am because I will protect the environment above everything. That's the most important thing: it's not harmony, it's about identity, expectation and making sure that in every way we're maximising the potential of each other and of the group every day."

Marsch and his family are settled in Yorkshire: the Wisconsinite who found a home in Leeds. "I think what I've learnt more than anything, it's just that I belong here," he says. But he's just getting going. He's aware of how managers are an endangered species, and his responsibility in keeping the ship steered in the right direction.
