German president sees local organic pesticide

AN organic pesticide or biocide derived from natural fungal parasites to control crop pests, especially the moth family, was yesterday shown to visiting German president, Dr Frank-Walter Steinmeier.

Dr Never Mwambela, lecturer at the College of African Wildlife Management Mweka, made a presentation in Dar es Salaam yesterday before the visiting statesmen, noting that the biocide is a product of her startup company, Plant Biodefenders.

It seeks to use biological methods for containing pests named 'Tuta absoluta,' described as a leaf miner, and fall armyworms without polluting the environment, thus ensuring the good health of consumers

The scientist who invented the pesticide, impressed the visitor who pledged further German support for innovation, after he heard a pitch from the researcher, pointing at "desire and ambition" as having enabled the key innovation.

Describing herself as proud and yet humbled, she said she had successfully found a lasting solution for the invasive pests, with more than 9,000 farmers so far benefitting from this invention.

President Steinmeier, leading a highprofile delegation of members of the German business community, commended the scientist for her breakthrough innovation, thanks to the support extended by

WCF investment earnings at 665bn/-**By Carlos Banda**

EARNINGS in the Workers' Compensation Fund (WCF) have increased to 665bn/- due to positive compliance in fund contributions by employers in the formal sector.

John Mduma, the WCF director general, made note of this increase when unveiling the WCF biennial performance report before journalists in Dar es Salaam yesterday.

WCF earnings have been growing year on year, as it started by earning 12.02bn/- back in 2017 and this year it has already earned 345bn/- bringing up the cumulative income of 665bn/-.

"We have been generating income by investing the contributed funds," he said, noting that the fund has so far contributed 62.7bn/in income taxes generated from investment income "earned from the money injected by companies whose employers have been contributing to the fund."

WCF praised government policies for improvements, including lowering the interest charged on employers delivering their contributions late from ten percent per month to two percent.

Other improvements include the increase in minimum compensation to 275,702.83/- for employees with 100 percent disability, reduction in contribution for private sector employers from 1 percent to 0.5 per cent.

Anselim Peter, the WCF director of operations, stated that the fund plays a key role in

Zuma fought unsuccessfully all the way to the Concourt over whether he had the right to privately prosecute both Downer and legal journalist Karyn Maughan for allegedly leaking and publishing Zuma's medical condition. That case was recently dismissed by the Constitutional Court, which ruled that Zuma's attempted prosecution of Downer and Maughan was unlawful, but that has not stopped Zuma's legal team from revisiting the alleged issue of Downer's 'bias' against Zuma. For observers of Zuma's various ongoing legal problems, the renewed effort to remove Downer from the prosecution team seemed like a time warp back to two years ago, when the exact same argument was unsuccessfully made to the previous trial judge. Advocate Dali Mpofu, appearing for the former president, told the court that after the Constitutional Court had been approached, the issue was once again "live" and required the new judge's assessment. "What has since happened is that as of 25 October...the application for leave to appeal in that matter (in the Constitutional Court) was served," said Mpofu. Having heard all these arguments, and having rejected Zuma's legal efforts to remove Downer from the prosecution team, former trial judge Piet Koen recused himself from the case earlier this year. "I have come to the conclusion that I must recuse myself from the trial," Judge Koen declared at the time. "This is what the proper administration of justice, the Constitution and my conscience dictates," he said, setting the stage for a repeat of Zuma's efforts to remove Downer from the case.

He is charged with fraud, corruption, racketeering and money laundering and, if found guilty, could face a 15-year jail term.

Jacob Zuma, the former president of South Africa, is 80. But he seems to remember how to use old tactics to survive.

Yesterday, he went on trial to face 783 counts of corruption, fraud, money laundering and related charges stemming from alleged kickbacks in a 1990s arms deal.

But his legal team wanted to remove the prosecutor, a matter that had already been decided by higher courts.

With a new judge hearing the case after the previous judge recused himself in January, the issue of Zuma's attempt to get rid of lead prosecutor Billy Downer surfaced in the Pietermaritzburg High Court session.

This matter had already been dismissed by the previous judge. The matter was then taken up by a full bench of the High Court, and on appeal, Zuma fell at each hurdle.

Zuma's team argued that the revived application to remove Downer for allegedly failing to take an impartial approach to Zuma's prosecution was not more of Zuma's notorious 'Stalingrad defence' of arguing every conceivable legal point in order to further distract justice and prevent the start of evidence in the much-delayed trial.

Zuma's determination to remove Downer -- who in 2006 successfully prosecuted Zuma's friend and former 'financial advisor' Shabir Shaik on the same charges now facing Zuma -- was underpinned by an announcement to the new presiding officer that Zuma had lodged a 'final appeal' with the Constitutional Court against earlier findings that Downer was entitled to prosecute the case.

MCT commemorates IDEI

THE Media Council of Tanzania (MCT) vesterday joined the world in commemorating the International Day to End Impunity for Crimes Against Journalists (IDEI).

In a statement issued by MCT secretary, Kajubi executive Mukajanga said: "This day is of specific importance bearing in mind that journalists are essential pillars in media in strengthening democracy, good governance and accountability which are crucial elements for spurring development in the country."

"Each year, this day has been marked reflecting actions and events taking place in different countries in the world. In every part, journalists still face varying challenges including death while doing their work," Mukajanga said.

In the period between January and November, this year MCT through its database has recorded that 21 violations were committed against journalists impeding them to access information or threatening them not to carry on their duties as journalists.

The incidents of violations included denial to access information - eight incidents (8) threats (5) arrests (3) attacks (2) and harassment (3).

This year incidents of denial of information have increased as compared in the past three years, whereby in 2020 there were three such incidents, 2021 four incidents and 2022 two incidents.

The Council has established that there are still challenges to access information, despite the directive given by Prime Minister Kassim Majaliwa on March 27, 2023 during the meeting of public information and communications officers held in Dar es Salaam.

The Prime Minister had ordered ministries, public institutions and government departments to earmark budgets for disseminating information to the public, accurately and expeditiously.

Despite negating the directive, we

have noticed some officials issuing decisions contrary to the Access to Information Act of 2016, compelling information seekers to get a letter from the President's Office Regional Administration and Local Government (PO-RALG) asking for information from the councils.

Laudes Foundation, GIZ and Helvetas teaming up for the regeneration project

LAUDES Foundation, Deutsche Gesellschaft für Internationale Zusammenarbeit (GIZ) and Helvetas Tanzania have launched a special programme to establish a resilient agricultural production system.

Dubbed: "Regenerative Production Landscape", the programme is also aimed to help safeguard natural resources and biodiversity.

Tanzania's regions are marked by large-scale landscape and ecosystem degradation owing to deforestation, erosion and unsustainable use of the landscape. This multi-stakeholder partnership by climate-positive foundations, Laudes Foundation and Helvetas Tanzania alongside the German development agency, GIZ, brings together various stakeholders, including farming communities, and public and private sector entities, to address the intricate challenges associated with climate, nature, and human well-being at a landscape level.

Hendrik Buermann, project director of the Regenerative Production Landscape Collaborative, emphasised the need for a holistic, place-based approach that transcends the conventional farm-level and single-commodity focus.

The initiative aims to tackle Tanzania's issues such as deforestation, overgrazing, water resource mismanagement, soil erosion, and loss of biodiversity. The overarching goal is to transition from a production model that degrades and pollutes to a sustainable agri-business model that conserves, restores, and regenerates the environment.

The programme's key features include smallholder farmers adopting regenerative agriculture practices, participating in inclusive business models, conserving enhancing biodiversity, and resilience to climate change.

Village committees identify

solutions for land and water source restoration and integrate these solutions into local spatial planning. District Spatial and Environmental Action Plans incorporating interventions at the farm and community levels.

Private sector involvement in promoting farming models that regenerate the land and investing in the prosperity of farmers and communities.

THE Parliament has directed the Public Procurement Regulatory Authority (PPRA) to conduct a special audit into the procurement of 874,019 electricity meters worth 115bn/- by the Tanzania Electricity Supply Company (TANESCO) which were not tested by the Weights and Measures Agency (WMA) as required by the law.

The move is said to have led to the entering into the market of counterfeit meters, exposing the power utility company to losses according to the Public Accounts Committee of parliament (PAC).

Deputy committee chairman Japhet Hasunga made the sentiments in the National Assembly when tabling the committee's report from an audited report on the Controller and Auditor General (CAG) report for various government institutions for the

financial year ending June, 2022.

Hasunga said in the year 2021/2022 Tanesco purchased 874,019 meters worth 115bn/- of which its quality was not tested by WMA causing losses.

"The move by Tanesco is against regulation 22(1) of the Weight and Measures Act of 2019 which states that there will be no meter which will be used by a contractor to measure electricity unless it is measured by WMA," he said.

Hasunga said the committee was aware of the rush in which Tanesco is usually associated with which is caused by the demand to have electricity connected by the general public which also tempts overpass laws.

He said, however, that Tanesco of public fund embezzlement and has the opportunity to sit down with WMA to prepare a system to which, despite the rush, the meters must be tested for quality.

"Tanesco can also consider establishing tender requirements through incorporating meter test, calibration and verification evidence by WMA as a criterion of accepting meters," he said.

He said the untested meters risks leading to increased electricity theft but also contaminates the whole market with fake and counterfeit meters which can affect businesses. In the report the committee issued various recommendations to be taken for consideration by the government to facilitate tight control for actions to be taken.

He said that number is equal to an average of three quarters of all institutions registered in the system, where the total number of institutions registered so far is 1,042.

"Heads of public institutions should use PPRA facilitators to conduct training on the use of the system, as using facilitators from outside PPRA greatly jeopardizes the effectiveness of training, because some external facilitators do not have sufficient understanding of the correct use of NeST," he said

He said that among the shortcomings that arise in the conduct of the training are some of the employees who were recommended to participate in not coming to the training or arriving out of time.

However, he said PPRA continues to provide training on the NeST system in various selected centers to ensure that all key stakeholders use the system properly.

A Total of 271 Tanzanian journalists have been reported to have been mistreated while at work and 94 media outlets have been illtreated over the past 10 years, while important institutions are also involved.

Victor Maleko, Union of Tanzania Press Clubs (UTPC)'s programme Officer, training, research and publications said on Tuesday when presenting a report during the debate on the journalists protection and safety before members of Manyara Press Club (MNRPC) and police force in the region.

The debate aimed strengthening journalists' and police force relations in better serving the community.

271 Tanzanian scribes mistreated-says report

He said according to the Media Council of Tanzania (MCT) data, out of 271 scribes who were mistreated, 219 were male journalists and 53 were female. Some of the abuses journalists faced include being arrested, beaten, their equipment being destroyed, captured, humiliated and killed.

Maleko mentioned the 10 leading regions for having sex events are Dar es Salaam, Shinyanga, Arusha, Dodoma, Mara, Kagera, Kilimanjaro, Tanga, Ruvuma and Singida.

He also stated that the number of incidents that happened every year where in 2013 there were 38 incidents, in 2014 (27), 2015 (20), 2016 (32), 2017 (5), 2018 (24), 2019 (40), 2020 (41), 2021 (26) and 2022 (18).

He explained that incidents of violence have been decreasing as a result of the dialogues.

Regional Police Manyara Commander, George Katabazi said writers should focus on providing education and condemning sexual violence, especially sexual violence against children.

Katabazi asked journalists in the region to shout about cruelty to children and citizens to take the law into their own hands.

He asked journalists to be patriotic and prioritize the national interests in order to build the nation.

Zacharia Mtigandi, MNRPC chairman urged scribes to adhere to ethics when executing their daily duties.

EATED discussion was being heard in the legislature of late when some MPs expressed concern with withdrawal of local government loans for special groups of needy people, where youths, women and persons with disabilities obtain particular portions of council revenues.

The government is designing a new modality for the loans but as this is taking time, a section of MPs feel that emergency arrangements could be used while a new format is being prepared. The government was unsure how far that method would be usable, as it would not have removed those errors.

Outside the specific terms of the debate, the background to the dispute is that too many of the loans were not being repaid, which implies that repayment is one of the conditions to obtain the loan.

It is unclear if this is how the matter is perceived at the grassroots level, as it would imply it seeks out strictly those who deserve the loans in terms of their lack of means to earn a living. But if that criterion was duly followed, chances that they make a profit and return the loans are equally minimal.

There are dichotomies in overall policy design on loans to needy groups, arising from the wish to take care of such issues on a selective basis depending on who is raising the matter. In the matter of using 10 per cent of council earnings for loans to needy groups, we find reports of the Controller and Auditor General raising sharp questions on why the loans were not being returned.

Meanwhile there is another government funds remain on arrangement, located within the catering for other donors, etc.

> The best source of loans for poor people could easily be the TASAF finances, as it would make a vast difference in who obtains loans if one compares the sums with a paltry ten per cent of council earnings directed at the needy.

> Then as it is supposed to be a fund to aid needy people; it would be able to more easily cancel loans repaid to a certain threshold, or postpone such payments depending on conditions, including death of those credited, bereavement, disease.

Additionally, when such loans are administered by financial organisations acting as agents of a statutory body like TASAF, they are less likely to be misused by well-placed individuals cultivating influenceinlocalgovernmentcircles for taking loans, or repeatedly so. Local government administration is more politically networked than central government institutions, in which case the government's efforts as to closing the loopholes or leakages of such loans would rectify the modus operandi by shifting from offices to agencies.

But then with polls due next year and the following year, the pressure is to win hearts and much less so, minds. In that case the programme may remain frozen for a while, and a reorganization of the larger central government funds remain on hold, catering for other donors, etc. The Guardian Limited Key Contacts



The struggle for free press continues as cracks widen

HIS week's International Day to End Impunity for Crimes Against Journalists takes on renewed significance as threats to independent media in Ethiopia mount. As the world commemorates the International Day to End Impunity for Crimes Against Journalists this week from November 2 to 3, the state of media around the world continues to deteriorate at an alarming rate.

The situation in Ethiopia is particularly grim as statesanctioned impunity strengthens its hold.

Samuel Aseffa knows all too well the risks of investigative reporting in the repressive environment.

One a sunny morning few months back, Samuel, reporter at Ethiopian



refuse to provide clear reasoning or support from media regulators.

works. Robberies targeting major outlets like Ethiopia Insider and Ethio-251 have become another intimidation tactic. Unlawful detentions, harassment, torture and forced

In Ethiopia, whether by security forces or protest participants, reporters have increasingly become targets without consequence for aggressors. This culture of impunity undermines press freedom, silences critical voices, and erodes the foundations of democracy.

Alarmed by the deteriorating situation for media freedoms,

According to the Council, perpetrators of crimes against journalists must be held accountable, a safe environment for journalists to carry out their work without fear of reprisals must be ensured, and legal frameworks that protect press freedom must be strengthened.

A media advocacy expert, wishing to remain anonymous, posited that the media landscape has improved since the political transition in 2018. They highlighted that there is now greater freedom of expression, media freedom, and revised media laws. However, the expert stated that stakeholders in the sector need to work collaboratively to ensure continued progress.

The expert also expressed concern about the safety of journalists, particularly in relation to government and unidentified

Therefore, we need to educate people about insurance on a very basic level.

All in all, currently insurance is an offer-driven product in Tanzania. We have to push the products to the people to increase the market penetration. There are vast opportunities in the life and general insurance industry in Tanzania .Nonetheless, there are vast opportunities in the life and general insurance industry in Tanzania.

TIRA has said that half of the country's population should be covered by some sort of insurance by 2028.

As the country focuses on industrialisation, insurers should be open for new investments and business to cover a wider population. The country is now set for new regulations and directives on cash and carry as well as minimum rates which will enhance the market and companies will now have to compete on factors other than price.

Agricultural insurance is one of the key sectors of investment that insurers should be striving venture into immediately.

Insurers in the country believe agriculture is too risky to cover because smallholder farmers face challenges such as climate change, insecure land ownership and difficulties in accessing capital and farm inputs.

Now is the right time to invest in general insurance in line with the advancing technology and peoples' changing needs.

Strategis Insurance (Tanzania) Limited (SITL) was the first private specialist health insurer to be registered in Tanzania and licensed by Tira in 2002 and became the latest insurer to have decided to venture in the general insurance business.

Tanzanians should now be wishing to be covered by a private insurer in all aspects; motor insurance, fire, fidelity cover, goods in transit, marine cover, burglary and professional indemnity, among others.

The cancellation came after a warning letter from the Ethiopian Media Authority (EMA), the government regulatory body for media. The letter stated the television station was not operating in line with Ethiopia's media laws, though no specific violations were mentioned. The pressures on Ethiopia's independent media show no signs of letting up.

Fikadu Matemework, publisher of the Ghion magazine, now faces the potential closure of his publication after five years due to the unjust pressure coming from an "nonidentified authority" that hinders the rights of Freedom of Media.

The publisher and editorin-chief of the magazine were illegally imprisoned last august, by government forces.

"I was held for 10 days with no justification given," Fikadu said. "The law requires charges to be brought within 48 hours, but they ignored this."

The magazine's equipment and files remain seized as authorities

closures persist as the norms constricting Ethiopia's media landscape.

While killings of journalists have not been reported recently, impunity for such abuses enables further repression.

The states of emergency declared in recent years have amplified the government's policing overreach. In a country already experiencing conflict and instability, crackdowns on independent media have intensified to the brink of wiping out a sector battered by the previous regime.

Samuel and Fikadu's ordeals illustrate the daily hardships faced by many Ethiopian journalists -struggling to support their families amid job losses while living under constant threats.

The Ethiopian Constitution, particularly Article 29, Section 4, enshrines the principle of freedom of expression. It emphasizes the importance of allowing diverse perspectives and the free flow of information, ideas, and opinions as essential components of a democratic society.

Multiple media outlets and journalists have endured extrajudicial detention, harassment, assaults and theft of equipment at the hands of security forces. Several journalists have even reportedly lost their lives covering conflicts.

Blocking publication distribution has made daily operations challenging. These crackdowns undermine the very spirit of the constitution and Ethiopia's democratic aspirations.

As the UN's "Safety of Journalists" initiative highlights, journalism plays a critical role in development, rights and democracy worldwide. However, a staggering 90 percent of journalist murders go unpunished according to UNESCO's Observatory of Killed Journalists, with over 1,600 deaths globally since 1993.

Threats online and off continue

the Ethiopian Media Council emphasized on November 23, 2013 that even during a state of emergency, journalists and media outlets must be held accountable through legal processes. However, reports indicate that media outlets and journalists are being illegally detained and their publications banned.

In Ethiopia, journalists live with the harrowing reality of being deliberately targeted, attacked, and even killed without consequence, according to Deputy Council Chairperson Tamirat Haile.

He notes this alarming trend carries grave implications for the fundamental rights of both news outlets and journalists. "Fear and intimidation force them to resort to self-censorship, leading to less coverage of sensitive issues. This not only demoralizes journalists but also directly impacts the right to freedom of expression."

These actions, according to Tamirat, undermine press freedom, transparency and ultimately cause journalists to leave the profession.

Regrettably, Samuel also expresses his frustration at being incarcerated, despite exercising his professional right to access information. He laments that even though he sought to uphold his rights, it proved futile in preventing the assault that resulted in his imprisonment.

"This is truly disheartening. A law enforcer breaking the very laws they are supposed to uphold and violating the fundamental human rights of individuals is a serious issue," Samuel told The Reporter adding, "The Ethiopian Broadcasting Law, which was created to regulate media organizations, is not effectively protecting journalists from harm. As a result, the practice of journalism is at risk of collapsing, putting the country's democracy and human rights at stake." security forces. He noted that such forces often use unjust measures against media practitioners. However, the expert says that the UN safety instruments are in place, which focus on protecting, preventing, and prosecuting individuals before any adverse incidents may occur.

To this end, the expert explained that, along with local and international organisations, their institution is working together to create a safe and conducive working environment for media practitioners, with emphasis of that the freedom of expression is a fundamental human right, but safety is equally important for media practitioners.

government "The views everything as a security and national interest issue due to ongoing conflicts in the country, leading to a perception that it is challenging to provide protection and safety for journalists," The expert said, acknowledging that the rule of law and policy standards have improved since 2018, making it possible to provide better protection and safety in collaboration with regulatory bodies and other civil organisations. Despite harbouring deep resentment and enduring lingering pain from losing his employment, Samuel ardently depicts his distressing experience as a potent call to arms, imploring an end to the prevailing culture of impunity surrounding crimes against journalists.

"I am unable to provide for my family due to lack of work, and even in the face of this financial hardship, the intimidation and threats persist," Samuel said.

Mohammed Idris, director general of the Ethiopian Media Authority, and other officials refrained from commenting on this issue, after repeated requests from The Reporter went unanswered as of press time. **FEATURES**

Rights of a spouse during disposition of land in Tanzania

ROTECTION of matrimonial properties varies in different books of statutes as well as court decisions on rights of a spouse. This article intends to look at the rights of a spouse in a property acquired in a marriage at the time of disposition of the same.

The question of what falls under matrimonial property is a matter of facts. One has to establish contribution which is not mandatory to be monetary because even petty tasks can amount to a certain property falling under the ambit of matrimonial property.

This can be seen in the cases of Hawa Mohamed vs Ally Sefu [1983] TLR 32, Thabitha Muhondwa vs Mwango Ramadhani & another, Civil Appeal No. 28 of 2012 and Gabriel Nimrod Kurwijila vs Theresia Hassan Malongo, Civil Appeal No. 102 of 2018 and a recent Civil Appeal No. 10 of 2022 between Habiba Ahmadi Nangulukuta vs Hassani Ausi Mchopa. Matrimonial home is the property in which the

family resides. Marriages that are legal in Tanzania are religious unions such as Islamic, Christian, Hindu or otherwise; customary marriage after following all legal requirements until registration of the same and civil marriage. Thus, for one to acquire rights as a spouse, then he or she has to establish existence of one of the marriage types.

The Marriage Act mainly governs these kinds of relationships in a wide range. Specific sections that cut across or provide for protection of spouses in disposition of property are sections 56, 57, 58, 59 and 60 of the Law of Marriage Act, [Cap 29 R.E. 2019].

This article dwells on section 59 which provides that one spouse shall have to require consent from another spouse when alienating matrimonial home be it by way of sale, gift, lease, mortgage or otherwise. Thus, the law requires one to seek spousal consent when making disposition of any kind.

Another piece of statute



that tends to protect a spouse from surprise or unknown disposition is the Land Act. Section 114 of Land Act [Cap 113 R.E 2019] provides that the bank or mortgagee once a landed property is placed as collateral, have a duty to seek spousal consent and if not, the same has some legal impact whether in regards to legality of the placed mortgage or an innocent part can seek for damages for noncompliance with the law.

Another section to be looked at is section 161 of the Land Act [Cap 113 R.E. 2019]. This section requires also spousal con-

spouse, then the same should be sought.

Once the Court of Appeal faced a scenario that a spousal consent was not sought and it had no other remedy than to nullify the mortgage.

The High Court in the case of Specioza Kokushubira vs TWB Bank LTD, Land Appeal No. 119 of 2020 was faced with a scenario that one was claiming spousal consent but legality of the marriage was questionable. The court looked at the marriage certificate tendered and overall evidence and found itself in a dilemma

and if there are more than one also in court had different names from what were identi-

fied in the marriage certificate. The court ruled that it could not grasp whether the one who placed the landed property was the appellant's spouse or otherwise hence dismissed the case. Therefore, when suing, one is to be clear on identification and names of the spouse.

In another case, there was dilemma as to which property needed consent: is it matrimonial home alone or all matrimonial properties? The Law of Marriage Act states that a spousal consent is a requiresent in case of any disposition as the other spouse who was ment to be sought in matrimo-

nial home.

Many decisions show that if collateral is not a matrimonial home, then consent is not necessary. However, some sections of the Land Act require consent and now the same has been settled in the Civil Appeal No. 287 of 2017between National Bank of Commerce Ltd vs Nurbano Abdallah.

Also, there was a dilemma on how the mortgagee could have discharged the task granted for identifying whether there was a spouse or not, a burden that many people have used as a bush to escape liability.

In 2008, Section 114 of the Mortgage Financing (Special Provision) Act 2008 was amended and imposed a new requirement whereby banks have a duty only to seek the mortgagor to identify if he or she has a spouse or not and if yes, then spousal consent is necessary.

But if the answer is no. then a statutory declaration or affidavit is to be sought to that effect. This protects the bank at later litigation because if it is proved that they adhered

be subjected to nullification. This was also determined by court in the case of Warda Hassan vs National Bank of Commerce, Land Case No.159 of 2014. In a nutshell, for any buyer or mortgagee or any financial institution, it is necessary to obtain spousal consent or affidavit of the seller's or mortgagor's marital status. Note: the material and

Steinmeier visit: The apology paves way for stronger ties

POLOGY, a gesture formerly considered a sign of weakness has evolved over centuries to now represent moral strength and a crucial step towards potential reconciliation. Like appreciation for a good deed and care for others, it is not commonplace though.

Individuals, communities, governments, religious organisations, state agencies, companies and professional organisations all over the world nowadays publicly issue apologies to those they wronged in the past than before.

Perhaps, the world is becoming more



aware of the power of apology. For, offering an apology implies that you harmed another person in some way. which can elicit feelings of shame. Psychologists hold that people who cannot apologise often have such deep feelings of low self-worth that their fragile egos cannot absorb the blow of admitting they were wrong.

But to simply say that 'I am sorry' or 'I apologise' is not enough. People who have been wronged are natural lie detectors. Yes, they can figure our when you are acting and when you mean it. A true apology that heals the victim must be sincere and heartfelt.

That is why when German President Frank-Walter Steinmeier publicly apologised for atrocities committed by his country's forces in then Tanganyika on Wednesday, it was big news reported across the world.

Speaking in Songea town, Ruvuma Region where he met the descendants of Chief Songea Mbano who was executed by Germans for leading a revolt, Steinmeier appeared and sounded remorseful although he was not there when the atrocities were being committed.

It should be remembered that the acts were committed during the German East Africa era which covered Mainland Tanzania, Rwanda and Burundi and spanned a period from 1885 until the end of World War I.

"My dear family, I mourn with you for Chief Songea, and for all the others who were executed. I wish to pay my respects to the victims of the German colonial rule. And as German president I would like to ask for forgiveness for what Germans did to your ancestors here," he said.

In what many did not expect, including yours truly, he went on to describe Mbano as "a brave leader" in the rebellion. Yes, he said that.

"I beg your forgiveness and I would like to assure you that we Germans will search with you for answers to the

open, unanswered, outstanding questions that give you no peace."

The move to acknowledge the atrocities by the former colonial master is a moral gesture that has been sought by many African countries - some verbally and some silently - with the demand in wealth, heritage, and ancestral remains being among the key things needed to be returned to their respective African countries - showing an act of accepting responsibility.

The apology sets a 'stepping stone' for Tanzania and Germany's relationship in various strategic matters such as trade and investment, water, health, gender, equality, women's empowerment, biodiversity conservation, finance management, tourism heritage and culture to flourish and cement the latter's investment and trade in these sectors

Also, Steinmeier's apology is a gesture that also sets a positive and lasting tone that will help change the perception built against the Germans by the locals, hence curving a path for more tourists and friendliness that is no longer marred by historical bloodshed.

Steinmeier also laid a rose at Chief Songea Mbano's grave and a wreath at a mass grave of 66 other fighters in the Maji Maji uprising. Up to 300,000 people are believed to have died during the Maji Maji rebellion between 1905 and 1907.

Skulls of people taken to Germany are believed to include that of chief Mbano and return of the same was one of the topics of discussion during Steinmeier's three-day visit.

In her address to the media at the State House Dar es Salaam, President Samia Suluhu Hassan took the opportunity to laud the German leader for agreeing to visit the country upon her invitation, adding that the visit creat-

ed opportunity for stronger economic and social-cultural affairs between the two countries.

According to President Samia, economic ties between Tanzania and Germany are substantial, with bilateral trade standing at around euros 300 million, with Germany being among the leading countries placing investments in Tanzania.

This status is complemented by Germany's Foreign Direct Investment (FDI) in the country whereas in 2018, it was reported that German firms had invested a total of \$324.12mn (732.2bn/- leading to the creation of 14,80 jobs for Tanzanians in sectors such as manufacturing, tourism, agriculture and environmental protection.

President Samia reiterated that German-based firms had initiated a total of 178 projects billed to take up \$408.11mn in total, registered with

the Tanzania Investment Centre (TIC) adding significantly to employment opportunities.

With these numbers, it is evident that the Deutsche speaking nation is striving to see Tanzania thrive while also benefiting from Tanzania's export commodity value which stood at \$42mn versus Germany's export value to Tanzania at \$237.4mn.

Though the trade figures denote thriving socioeconomic relations, it is the cultural aspect of the President Steinmeier's visit that serves as a sign of relief after revealing that he intends to acknowledge and address past injustices citing the move as a key facet of reconciliation and a stepping stone towards a shared future.

line with global trends, Kenya has seen a significant temperature increase of 0.3°C to 0.6°C per decade, impacting key sectors like agriculture and water resources. This rapid warming trend was a major focus at the inaugural Africa Climate Summit (ACS23) in Nairobi last month which among others highlighted the link between climate change, regional food systems and economic transformation.

The ACS23 emphasized the consequences of inaction on food security and economic sovereignty, rallying an Africa's unified climate agenda ahead of the 28th UN climate change conference (COP28) in the UAE.

Concurrently, the 2023 Africa Food Systems Forum (AFS Forum 23) in Dar es Salaam stressed the urgent need for climate-responsive solutions by African governments to address the continent's food system challenges. Kenyan President, Dr William Ruto, has since come through on his promise to explore more green and environmental friendly fertilizers alongside a 10-year initiative to grow 15 billion trees by 2032, raising Kenya's tree cover to 30 percent, enhancing carbon sequestration, restoring 5.1 million hectares of deforested areas, and benefiting households as 30 percent of these trees will be fruit, nut, and fodder species.

President Ruto has also banned single-use plastic bags and initiated trials for biodegradable tubing bags in line with a United Nations resolution from UNEA 5.2. Meanwhile, Kenya is at the forefront of climate change efforts in Africa, with the Climate Change Act of 2016, and recent amendments to enhance its carbon market regime, driving its responses. The government is also actively implementing the third cycle of the National Climate Change Action Plan (NCCAP III) to promote low-carbon, climate-resilient development.

Yet even as we celebrate these great interventions, we must recognize that climate change is a complex issue

The fight against climate change calls for significant collaboration



that no single country can solve independently; a collaborative approach involving partnerships across national governments, the private sector and the international community is required for rapid transformation.

We are glad to report that African leaders are focusing their development strategies on sustainable solutions at both the national and continental levels. The Africa Environment Action Plan, the Africa Clean Energy Corridor, and the Africa Renewable Energy Initiative all indicate the continent's strategic commitment

to addressing the climate crisis. The actions proposed in these initiatives were restated in the Nairobi Declaration, which summed up the outcomes of the ACS23. Africa's common position on food systems will benefit from cross-sectional collaboration to ensure resource efficiency and high-impact transformation.

The Declaration comprises 23 commitments, primarily addressing policy areas related to investment attraction, economic development (with a focus on youth empowerment), enhanced continental cooperation,

increased renewable energy financing, support for smallscale farmers, and the expedited implementation of the African Union Climate Change and Resilient Development Strategy and Action Plan (2022-2032).

Notably, the Declaration emphasizes the need for global collaboration to secure adequate capital for both development and climate initiatives, echoing the principles of the Paris Pact for People and the Planet, which aims to ensure that no country must choose between its development goals, climate action and the basic human right to feed people.

The time is now for environmental, energy and food systems experts to resolutely come together to help the continent fight hunger, land degradation and ensure economic prosperity.

Hence, Africa is capitalizing on the momentum of ACS23 and AFS Forum 23 to prioritize its climate discussions and facilitate decisionmaking areas most critical to Africa on the global front. This was evident at the recent UN General Assembly (UNGA) where Africa's key concerns, such as transitioning to a low-carbon economy and

improving living standards, building resilience to climate shocks, especially for rain-fed agricultural nations, were a common theme in speeches and discussions. Coming off the challenges of the Covid-19 pandemic, which exposed vulnerabilities, there is a strong focus on fast tracking climate action and development, as emphasized by Africa's delegation at UNGA.

Our countries are up against a huge task: the need to transform food systems to feed people, to rehabilitate and safeguard environment and to ensure resilient to shocks caused by the ongoing climate change. There is no doubt that African leaders are more committed than ever before to build on the lessons of the recent crisis that our continent has faced to deliver stronger resilience for people, the environment, and our economies. Certainly, this is not an easy undertaking which will require stronger collaboration.

Today, Acapulco is devastated. A Category 5 hurricane-the deadliest possible rating-called "Otis" hit the beach on October 25 with incomparable force. No one anticipated it. Hours before it made landfall, it was just an inconvenient storm. Suddenly it became a deadly cyclone. Most of the hotels are destroyed, the sea swallowed people, houses were blown away, and dozens of people are dead.

In the last century, its beauty attracted the world's most influential celebrities. Its tranquil mornings and lively nightlife attracted actresses, singers, politicians, aristocratic musicians, and families who wanted to spend their summers by the sea. I myself spent my youth at the family timeshare apartment in Acapulco, and it was there that I met my husband Alejandro, with whom I've been married for 40 years. My life is permanently connected to Acapulco.

Luxury businessmen, millionaire athletes, and Michelin-starred chefs arrived. Also drug dealers, money launderers, and men looking for girls and boys to rape in exchange for food or a few dollars for their parents who lived in the city's poor areas.

Because there are two Acapulcos. They both share an airport and roads, so all roads lead to that pair of versions of the same city. There is a "diamond Acapulco" where the rich vacation with all the amenities at their disposal. And there is a "traditional Acapulco," where the poor live who work for wealthy tourists.

The people who inhabit "diamond Acapulco" and "traditional Acapulco" do not usually cross paths. They live in the same city, but they are separated by golf courses and exclusive shopping malls. Only rich foreigners and wealthy nationals cross to the poor side when they feel a repugnant urge: to make their plans for child sex tourism a reality with girls and boys as young as 3 years old.

Acapulco is one of the most unequal tourist destinations in the world. In Mexico, it is the most unequal municipality of all: more than 60% of its 900,000 inhabitants live in extreme poverty, which means they do not know what they will eat today or tomorrow. They are the workers who serve plates of fresh seafood, who sweep marble floors,



who fill the wine glasses of tourists. For years, journalists and human rights organizations have told horrific stories that combine poverty, inequality, and sex tour-

ism: a 6-year-old boy rented out to be photographed naked in exchange for milk and eggs; a 9-year-old girl sold to a Canadian tourist to be his wife for a month; homeless

teenagers invited to sex parties on lavish yachts in exchange for food; parents and mothers waiting outside hotels for their children to be raped for a price paid in dolremains of the port that enchanted singers Agustín Lara and Luis Miguel. There are thousands of poor families without homes, hundreds of workers who lost their jobs, and dozens of fishermen without boats to go out to sea to find sustenance. The destruction is so extensive that complete economic recovery is estimated to take decades, not years.

Under these conditions, childhood is at very high risk. Many families have lost so much that their bodies are the only currency they have left. And in the dirty business of forced prostitution, child bodies are the most sought after.

Amid this unprecedented crisis in Mexico, the Chamber of Deputies approved amendments to the general law against human trafficking. These changes aim to broaden the scope of the law enacted in 2012 and update it to address new technologies that traffickers and organized crime engaged in sexual exploitation can use. The wording has some issues that we are still analyzing, but it also includes positive aspects.

For example, it introduces new protections for individuals with injuries, intellectual disabilities, and Afro-Mexican towns and communities. The latter represent 6.5% of the total population in Guerrero and 4% of the residents in Acapulco, according to the National Population Council.

Civil society organizations are monitoring these changes and hope that the deputies will honor their commitment to protecting the victims.

Meanwhile, it is the responsibility of all, not just in Mexico, to help Acapulco back on its feet, a place that has given so much to both nationals and foreigners. It won't be easy or quick, but every day we delay puts the vulnerable children at risk due to the magnitude of sexual tourism in that beautiful port.

After Hurricane Otis, Acapulco will be different. Its reconstruction is an opportunity to build a new city on the ruins of depravity, one with values and respect for human dignity. I long for the day to see it standing and for its coastline, beach, and air to remain a paradise, especially for children like me who grew up happily by the sea.

The collaboration with FtMA in Kenya is just one of the many initiatives led by Boomitra to unleash gigatonnes-scale soil carbon removal.

This global consortium of FtMA, which includes AGRA, Bayer, Rabobank, Syngenta, WFP, and Yara, operates in Kenya, Tanzania, Rwanda, and Zambia and provides farmers across East Africa with comprehensive support to transition to climate-smart agriculture practices - from farm planning and seed selection to market access.

Together, FtMA and Boomitra have already on boarded 89,000 acres of farmland and equipped farmers with the necessary resources to improve soil health and yields while unlocking carbon revenue opportunities.

At the heart of the soil carbon project's implementation is FtMA's Farmer Service Center (FSC) model. These service hubs connect private and public partners with smallholder farmers, serving an average of 200 farmers per hub.

FSCs act as trusted links to farming communities, improving access to critical resources such as information, qualstorage solutions, market connections, and more. This innovative model places local people at the forefront of the

ity inputs, affordable financing,

project, ensuring that the solutions and interventions are tailored to the unique needs and challenges of each community.

The FSCs also benefit by earning income through direct sales or commissions from the linkages they create. In remote farming areas, FSCs play an essential role in mobilizing farmers and delivering swift and cost effective agricultural interventions to smallholder farmers.

"Carbon credits will create an extra revenue stream to smallholder farmers and enhance the extension services provided to farmers by FSCs, which are critical to the adoption of climate smart agricultural practices," said Antony Kweyu, Project Manager at Participatory Approaches for Integrated Development (PAFID).

Boomitra and FtMA will work closely with 570 FSCs to implement the carbon farming project. This initiative will focus on four main activities. First, it will identify and enrol farmers into the program. Second, it will map and monitor farmland using geospatial

and remote sensing technology.

Third, it will submit carbon credits to the international verification body (VERRA). Fourth, it will transfer carbon credit finance to farmers based on their carbon sequestration activities.

This project is expected to remove an additional 300,000 tCO2e of carbon from the atmosphere annually. After the success of the pilot phase, there are plans to expand the partnership to other countries in East Africa where FtMA operates.

"There are a growing number of agricultural carbon projects around the world, but most of rollment limits that are much larger than the sizes of the majority of farms in the world. This project will be unique in its ability to engage with even the smallest farmers in a meaningful manner that is not only financially viable for both the farmers and the project in the long run, but also has the propensity to scale rapidly to a healthy percentage of farmers in the broader region," said Aadith Moorthy, Founder & CEO of Boomitra.

Building on WFP's legacy of innovation, the WFP Innovation Accelerator was launched in 2015 to scale promising innovations to disrupt hunger.

The collaboration between Boomitra and WFP aims to enhance the climate resilience of smallholder farmers, boost cropland productivity, and raise farmer incomes by a target of 20 percentenabling them to reinvest in their farms and communities.

With over 2,700 farmers enrolled to date, Boomitra, FtMA and WFP remain dedicated to scaling up carbon farming practices in East Africa, to create sustainable agricultural models that will benefit the farmers and their communities for generations to come.

Hardworking women who correct historical injustices

LTHOUGH women account for more than three-quarters of the agricultural labour force and manage 40 percent of small-scale farms, historically, they neither owned nor controlled the land because land rights were passed down to male relatives. It is a historic gender injustice whereby women could only access land through close male relatives.

But as the vagaries of drought wreak havoc in the agricultural sector due to more failed rainfall seasons - with 2022 alone showing signs of a serious hydrological and ecological drought - gender and climate experts, such as Grace Gakii, tell IPS that women's decision-making powers are much needed to ensure that extreme weather patterns do not paralyse the agricultural sector.

"The agriculture sector is the backbone of Kenya's economy. It accounts for an estimated 33 percent of the country's GDP and employs at least 40 percent of its population and 70 percent of the rural population. Without land rights, women cannot make the necessary decisions to either adapt or mitigate climate change," she says.

"In mitigation, they cannot, for instance, decide if and when trees are planted. In adaptation, they have no say in, for instance, shifting to more climate-resilient crops. We have no shortage of indigenous seeds to help us navigate the rainfall deficit we are increasingly experiencing. But women have historically been denied the power to make these decisions even though it is women who provide the dayto-day farm labour."

Serah Nyokabi says the revolutionary Savings and Credit Cooperative Society (SACCO) is increasingly putting land rights in the hands of women and facilitating access to the tools needed to build climate-resilient farming and food systems.

"I am a member of Afya SACCO. We save and take loans at a low interest. I use the loans to hire land in Central Kenya for farming and buy items such as seeds, fertilizer and

SACCOs are a cash pooling scheme by a group of people to save and borrow low-interest loans amongst themselves. Kenya's SACCO sector is popular and on an upward trajectory. Recent

Gakii says that regulated SACCOs represent about half of all SACCOs in Kenya, as many others are unregulated. She says there are at least 22,000 SACCOs and more than 14 million members overall in this East African nation, transacting billions every year amongst themselves. Some SACCOs, such as Afya SACCO, have thousands of members and others less than 100 members.

SACCOs have helped women navigate these challenges as all they need is to save with a SACCO, produce three guarantors within the SACCO to take a loan or simply borrow against their own savings," Gakii explains.

Although the percentage of women holding land title deeds is still very small, as only one percent of all land title deeds are in the hands of women alone and five percent held jointly with men, Gakii stresses that this is progress and is to be celebrated.

"We have another large category of women that hire land for commercial farming. This would not have been possible without the loans from schemes such as SACCOs," she says.

Gakii says women need access and control over land to play a much-needed role in the five pillars of climate resilience, including threshold capacity, coping capacity, recovery capacity, adaptive capacity, and transformative capacity.

"I taught agriculture in secondary schools for many years, and during that time, I had access to the small farm at the school for practical sessions, but back home, I could only execute the instructions from my husband. He was an accountant, and I was essentially the farmer, but he made all the decisions. Women interact with the soil on a day-to-day basis, but they cannot make decisions about how to best address the climate crisis. The result is a serious food crisis. We have large tracks of fertile lands, but here we are with a begging bowl," Nyokabi observes.

"We started by experiencing floods and droughts in close succession. In 2018, we had two extremes in one season, whereby March, April and May were very rainy, followed by a very dry season in October, November, and December. Last month we were repeatedly warned to prepare for El Niño in the October-November-December season, but now we have been told that there will be no El Niño. In fact, there is no rain at all, and yet we are in the short rain season where we plant in October and harvest in December-January. The person who is more likely to note these changes and see a pattern is the one who is doing the day-to-day farming activities, and so the role of women in building resilient farming systems cannot be ignored."

CHINA EYES TO REALISE CONVENIENT TRANSPORT SYSTEMS ACROSS ITS DEVELOPING PROVINCES

HINA is fully equipped with all it takes to make major investments in the transportation and infrastructure sub sectors as it eagerly eyes to turn its cities and provinces into smart and green.

A current report on Shaanxi province states that in line with mega transformations in the high-tech industry, the second global economic giant is keen on creating smart cities.

Property Watch has learnt from the report by the Information Office of Shaanxi Provincial Government as at the end of December 2022 that the province has achieved major transformation during the past ten years of the Belt and Road Initiative (BRI) implementation in different sectors including transportation.

The province whose capital city is Xian, is unfolding the magnificent progress and inspiring China's history, legacy and lifestyle in the contemporary times

The report states that in 2022 the province's comprehensive transportation investment amounted to 81.8 billion

In that case, the report states, Shaanxi expressway reached 978 kilometers, with four lines open to traffic, including the Ningshau to Shiquan, the southern section of Xian outer ring expressway, Chengcheng to Weizhuang to Luofu resulting in 212 kilometers of new expressway for the traffic.

It states that the construction of ordinary national and provincial trunk highways exceeded 1,600 kilometers, with an additional mileage of 230 kilometers.

The opening of phase two in Metro line six at the end of December 2022 added another 19.5 kilometers mileage, thus overtaking Suzhou to rank 12th in terms of metro mileage cities in China which is one position up compared to 2021.

On hygiene and protection of the environment for sustainable green cities, Shaanxi has effectively intensified the ecological and environmental protection

high-quality development.

In line with the 14th Five Year Plan 2021/25 for National Economic and Social Development and the Long-Range objectives through 2035, the province has formulated its plan, strictly implemented t5he comprehensive sewage discharge standards, and strengthened the management of the red line of water function zones to limit pollution.

Almost 231,300 hectares of forests have been planted in the Yellow River Basin, including 181,693 hectares of afforestation and 49,607 hectares of nurturing forest. However, 62,667 hectares of desertification land have been under control, and the ecosystem continues to improve.

The report states that in 2022 sustained efforts were exerted to rectify the water pollution caused by sulfur mine in southern Shaanxi.

The province has successfully held wetland protection law month and carried out more than 150 wetland law promotion activities, with the total number of participants exceeding 100,000, which has vigorously raised the awareness of the whole society on wetlands protection and effectively protected the entire ecosystem.

Housing levy hits Sh12bn in the first three month

Employers and employees paid out Sh11.83 billion under the mandatory housing development levy in the first quarter of the financial year, says Treasury in a document.

The document covering July to September 2023 and tabled before the National Assembly's Finance Committee shows the Treasury collected Sh7.9 billion in August and Sh3.93 billion in September.

CHARGES FOR NON-EXISTENT INTERNET IN PUBLIC BUSES RAISE DEBATE IN PARLIAMENT SESSIONS

embers of Parliament have raised concerns about the fees charged for non-existent internet in public buses and have recommended an immediate halt to these charges, and requested Rwanda Utilities Regulatory Authority (RURA) to urgently address the issue.

This was raised on November 1. as Members of the Public Accounts Committee (PAC) presented a report and resolutions made after scrutinising the Auditor General Report for 2021/2022.

The internet connection was introduced in buses in 2015 as part of the broad Smart Kigali Initiative.

In the following years, the project flopped after the government stopped the then service provider after a series of complaints from people who experienced years of poor service.

"In Kigali City, there are concerns over Rwf417 million paid by commuters for the internet in public buses but they never accessed it. There is no internet in many public buses," said Beline Uwineza, PAC vice-chairperson.

MP Safari Theoneste Begumisa suggested that fees charged

stopped.

"Why does RURA charge passengers fees for the internet in buses which they do not get? This should stop immediately. We can't wait for such months. There is also a violation of rights," he said.

Other issues in public transport that need urgent action are the shortage of buses and poor management of bus routes in Kigali City and upcountry.

The Auditor General report shows that RURA did not conduct regular and comprehensive transport needs assessments to establish existing market demand and supply of public bus services. As a result, it was not able to

make informed decisions that respond to passengers' needs.

"The assessment should analyse both existing and new routes, the number of passengers, bus capacity requirements, and the performance of current operators to establish the number of buses needed on different routes," Auditor General said.

This is illustrated by a decrease in the number of bus seats in the City of Kigali from 22,238 seats in 2015 to 19,961 seats in 2022, resulting in a reduction of 2,277 seats. This reduction is attributed on idle internet be immediately to a decrease in the number of

buses and resulted in long queues at bus parks and stops.

"RURA should regularly assess and monitor market changes to ensure that the demand for public transport across the country is met in a timely manner.

"There is also the issue of 9.8 per cent of fares that is charged on Yego Moto metres yet it is not clear what was based on to calculate the amount. There are also issues in e-ticketing. There is an issue of 5 per cent charged on e-ticketing turnover by public transport companies yet it is not clear what was based on to charge it," Uwineza said.

In June 2018, in a surprising move, transport authorities announced that the wireless internet connectivity, commonly known as 4G Long Term Evolution (LTE) was being re-introduced on all Kigali public transport buses.

Jean de Dieu Uwihanganye, the Minister of State in for Transport twitted that "4G internet is back on Kigali Public Transport Buses".

He said that at least 50 per cent of all buses in the city of Kigali have been installed with new better routers.

By then, Rwanda Utilities Regulatory Authority (RURA) had said the Wi-Fi connectivity system failed after the installed wireless devices were incompatible with the fleet, among other challenges. **Telecom Network Solution Pro**viders Ltd (TNSP) which was providing internet on public buses lost its contract in 2016, and the Government directed that more

research be done so that people get a better experience.

In an interview with Sunday Times, the state minister for transport reaffirmed the development to reinstall the broadband connection, highlighting that they had conducted several surveys on several buses before re-introducing the wireless connectivity.

"We are assured that it will work because we have taken enough time to re-study the project. What we found out is that previous routers were quite weak and were not able to adapt to Kigali terrain," he said, adding that they also revised the financing model of the internet which he believes will be sustainable and fair to all the operators.

The minister also highlighted that they spend nearly five months conducting ground studies before taking the final decision to reinstall 4G on public service buses.

Vodacom DR Congo tests 5G, pushes for data, mobile money

KINSHASA

Vodacom is testing 5G connectivity in the Democratic Republic of the Congo (DRC), under the supervision of the industry regulator, but its primary focus is on improving 4G base station deployment and expanding mobile money capabilities across the populous African country.

That's according to CEO, Khalil Al Americani, talking to ITWeb Africa, in an exclusive interview, on Monday.

Al Americani said that the Congolese 5G test will help lead the company in developing viable use cases, when it rolls out the network upgrades in the future.

"Under the regulator's supervision, we are testing 5G technology, with certain sets of frequencies to ensure that we are technically prepared," he said.

However, the Congolese mobile operator was 'yet to get clarity' on the licencing criteria for commercial rollout, from the government.

Nonetheless, Vodacom Congo expects that use cases will probably be directed towards its enterprise segment, as well as 'some applications' for government and the Internet of Things.

100 million people, while Vodacom has 21 million mobile subscribers, and data subscribers account for 7 million of the company's mobile network consumers.

For the time being, according to Al Americani, Vodacom's top operational and commercial objective in the DRC is to continue building out 4G across the country and 3G in some places.

In its June 2023 quarterly report, Vodacom stated that it has bought additional spectrum in the country, an investment it sees as critical to providing 'affordable data pricing'

"Data usage per customer per month increased by 19.4% (in the half-year period ending September) to 5.1 GB per month, up from 4.3 GB a year ago. This increase was driven by increased smartphone penetration as well as an increase in home broadband and enterprise users," according to Airtel Africa.

This resulted in a 28.1% increase in half-year period under evaluation.

Airtel Africa's data consumption per 4G subscriber increased to at least 8.4GB per month on average during the halfyear period, with data income increasing to \$385 million.

Overall, data customers climbed by 23.0% to 59.8 million. This was accomplished despite Africa's relatively low smartphone penetration, which also means poor data penetration, according to the business.

This, however, gave Airtel Africa and its competitors a "significant opportunity to enhance both digital" and financial inclusion. Some African mobile providers offer cheaper devices to subscribers in order to increase data usage, while others are developing super apps for their mobile money operations.

Airtel Africa has had to "invest in expanding our 4G network footprint to increase data capacity in our networks to support future business growth, as well as deploying new sites, particularly in rural areas, to enhance coverage" and connectivity in order to stimulate data usage

With a strong emphasis on 4G deployment, nearly all of Airtel Africa's locations can now provide LTE connectivity. 4G users provided 85.3% of overall data usage for the three-month period ending September 2023, with 4G data usage for the September 2023 quarter alone now standing at 11.7GB per month, a 41.3% increase over the September 2022 quarter.

Airtel Africa laid an extra 5,000 kilometres of fibre during the six-month reporting period under review, increasing the total to 73,600 kilometres throughout its African markets. The firm, a branch of Bharti Airtel, has also increased its international data capacity via submarine cables.

This increased its African data capacity by 48.8% to 28,200+ terabytes (TB) per day, resulting in 48.3% peak hour data utilisation

Olusegun Ogunsanya, Group CEO of Airtel Africa, stated that the increase in phone, internet, and mobile money usage "reflects the inherent demand for these essential services" in the African regions where the company operates.

India, 27 other nations and EU sign first international declaration to address AI risks

INDIA, along with 27 other countries and the European Union signed a declaration at a meeting in the United Kingdom pledging to work together to assess the risks associated with artificial intelligence.

The countries represented were: Australia, Brazil, Canada, Chile, China, France, Germany, India, Indonesia, Ireland, Israel, Italy, Japan, Kenya, Saudi, Arabia, Netherlands, Nigeria, The Philippines, the Republic of Korea, Rwanda, Singapore, Spain, Switzerland, Turkey, Ukraine, United Arab Emirates, United Kingdom of Great Britain and Northern Ireland, the United States of America, and the European Union.

Taking to social media platform X, the official page for Prime Minister Rishi Sunak's office said, "Leading AI nations have reached a world-first agreement on AI Safety.'

"The Bletchley Park Declaration sees 28 countries agree on opportunities, risks and the need for international action on frontier AI, systems that pose the most urgent and dangerous risks," it added.

The UK government on Wednesday issued a statement titled "The Bletchley Declaration", which was signed by delegates from the 28 participating nations--including the EU-- and issued a dire warning about the threats presented by the most sophisticated "frontier" artificial intelligence systems.

"Artificial Intelligence (AI) presents enormous global opportunities: it has the potential to transform and enhance human wellbeing, peace and prosperity. To realise this, we affirm that, for the good of all, AI should be designed, developed, deployed, and used, in a manner that is safe, in such a way as to be human-centric, trustworthy and responsible," the declaration read.

The Bletchley Park declaration also noted the importance of AI systems in various domains of daily routine like housing, employment, transport, education, health, accessibility, justice, and added that their use is likely to see an ascent. "We recognise that this is therefore a unique moment to act and affirm the need for the safe development of AI and for the transformative opportunities of AI to be used for good and for all, in an inclusive manner in our countries and globally," it read.

"Alongside these opportunities, AI also poses significant risks, including in

the global South, but we cannot discuss the global South without acknowledging the immense suffering endured by its people, particularly in the occupied lands of Palestine," he said.

"The current situation presents a prime opportunity for India to lend its support to the voice of the global South," he added.

'Future UN convention on countering the use of ICTs for criminal purposes is doomed to success'

THE objective transition of humankind to the virtual environment is accompanied by a breakdown of many existing stereotypes about the functioning of the mechanisms of interaction between states, society and business. This, in turn, requires adjustment and creation of new contours for ensuring the security of states.

At the same time, there are changes associated with the transformation of the global information order.

leading industrialized The powers are trying to maintain their status as the dominant force in the information field and slow down the transition to a polycentric model of its management based on legally binding norms, rather than on some rules that can be changed to suit the political conjuncture.

The absence of relevant universal international legal treaties in this area has led to a huge wave of crime in the information space, with serious damage to the economic activity of states and the well-being of millions of people.

Thus, according to independent international experts, the annual damage from the activities of criminals in the information space of EU Member States alone is about 5.5 trillion euro.

ICT crime has become a profitable business. There has been a tendency of incitement by some states to take illegal actions against others, and to place ready-made malware in the public domain of the Internet by these states.

The prospects for the global digitalization process as a whole, the effectiveness and dynamics of which depend on ensuring security, are in question.

It is against this background that the work of the UN Ad Hoc Committee for the Elaboration of a Comprehensive International Convention on Countering the Use of Information and Communication Technologies (ICTs) for Criminal Purposes is taking place. This negotiating mechanism was established at the initiative of Russia, with the co-sponsorship of 46 and support of 87 states, by UN General Assembly resolution 74/247. It is aimed at creating by the world community the first ever universal and legally binding instrument to combat crime in

the information space. Paradoxically, even in the current political realities, the work of the Ad Hoc Committee, due

to the cross-border nature of ICT crimes, has become even more relevant and in demand for most states of the world.

The sessions were attended by subject matter experts from more than 160 states and 200 non-governmental organizations representing political and law enforcement agencies, as well as academic, scientific and business communities. Since the very establishment

of the Ad Hoc Committee, Russia has been and is still in favour of elaborating such a comprehensive treaty that would lay the foundations for effective and transparent international cooperation to combat this threat.

The Convention to counter the use of ICTs for criminal purposes, drafted under the auspices of the UN, should give consideration to the interests of all states without exception and be based on the principles of state sovereignty protection, equality of parties and non-interference in the internal affairs of states. It should also provide for a broad scope and criminalization.

At the same time, the United States, the EU and their allies, at all stages of the discussions, strongly opposed the establishment of such a specialized UN



body in general and the development of a convention in particular, and voted against the establishment of an ad hoc committee at the UN General Assembly.

One of the formal arguments of the West countries was that "the world is not yet ready for such a convention.

The hidden informal reason for rejecting the very idea of a UN treaty was the 2001 Council of Europe Convention on Cybercrime, developed at the instigation of the United States, known as the Budapest Convention, whereby Washington undermines state sovereignty and controls the Member States information space.

After all, the future universal UN treaty becomes a direct competitor to the Budapest Convention and can put an end to the "chosenness"

and ambitions of technologically developed states.

Having lost the vote for the "minds and hearts" of the developing world at the 74th session of the UN General Assembly, the United States and its allies completely changed their approaches, declaring that "the world needs such a convention."

They tried to quickly realign themselves and take the lead in drafting the UN convention. Thus, Washington and its allies moved from direct rejection of the idea of a future convention to tactics of covert sabotage and emasculating the content of the international treaty from within.

In contrast to Russia, Washington advocates maximum harmonization of the UN and Budapest conventions.

This means that instead of a comprehensive approach, as enshrined in the mandate of the Ad Hoc Committee, the countries of the collective West are agitating for a narrow scope and criminalization, and are aggressively imposing gender and human rights issues.

Thus, the United States is trying to breathe life into a regional document of the Council of Europe written more than 20 years ago, which is already thoroughly outdated and is not in demand among develop-

ing countries. Does the world need such a treaty? Apparently not.

Besides, all of the Ad Hoc Committee's work is accompanied by an aggressive media background of the US-controlled media, which claims that "with the help of the convention, Russia and China are going to control the whole world," or "the convention will create a dangerous precedent that plays into the hands of authoritarian regimes." Then a rhetorical question arises: who controls the Internet

and the global information space now? Another important reason for

the strong opposition to the new UN treaty is the fact that the UN process does not fit into the US-imposed paradigm of a "rules-based order.'

Equal international cooperation is not implied. The main role in the future search for ICT criminals is assigned to the International Criminal Court (ICC), which is seen by the West as another alternative to the UN Convention on Countering the Use of ICTs for Criminal Purposes.

Giving the ICC broad powers to conduct ICT investigations and create an attribution mechanism, Washington plans to use it to deliver verdicts and assign responsibility.

That is why the West is trying to bracket out extensive criminalization in the future UN treaty, assuming that all these "complex" acts, including ICT terrorism, will not be considered in the UN, but in the US-controlled ICC.

The responsibility of finding traces and providing evidence, on the other hand, will fall to American IT giants.

Bypassing the mechanisms of mutual legal cooperation between states, citizens of any state suspected of committing crimes in the information space will be "hunted". Thus, the mechanisms of international cooperation of the UN in decision-making will be substituted.

Based on this, we can conclude that there is no alternative to a future comprehensive convention under the auspices of the UN. Russia, for its part, will continue to provide technical assistance to countries in need based on the principle of protecting State sovereignty and to debunk any manifestations of neo-colonial practices in the global information space.

Digital twin technology brings new prospects for development

digital twin is a digital representation of a physical object or process. It builds a bond between the real and virtual worlds.

In today's China, the digital twin technology is empowering various booming industries, such as digital transportation, smart city and environmental protection, making economic and social development more intelligent.

A new expressway currently under construction in east China's Anhui province has utilized digital twin technology from its inception. A virtual version of the expressway is being built concurrently as construction progresses.

"As the first intelligent expressway in Anhui, it incorporates emerging technologies to construct an underlying digital twin model," said a representative from Anhui Transport Consulting & Design Institute. It allows real-time collection of vehicle movements, weather and other multi-dimensional traffic data, and thus enables precise monitoring and management of the expressway.

According to the representative, digital twin technology is expected to enhance the traffic efficiency of the expressway, bolster its whole-process emergency response capabilities, and reduce the duration of closures resulting from adverse weather condi-

N the first three quarters, the total value added of industrial enterprises above the designated size grew by 4 percent year on year, 0.2 percentage points higher than that of the first half year.

China's industrial production has achieved stable growth, with continuous optimization of industrial structure and positive development momentum in the manufacturing sector. The overall industrial economy has shown signs of stabilization and recovery.

"The proportion of value-added output of manufacturing to GDP remained relatively stable in the first three quarters this year. Manufacturing investment continued to grow, with the growth rate gradually increasing since July," said Zhao Zhiguo, spokesperson of the Ministry of Industry and Information Technology (MIIT).

In August, profits made by industrial enterprises above designated size increased by 17.2 percent year on year. Both operating income and profits have turned positive, indicating a faster recovery in enterprise performance. In particular, small- and mediumsized enterprises (SMEs) achieved significant progress.

In the first three quarters, China fostered 12,000 specialized and sophisticated enterprises that produce new and unique products and 200 featured SME clusters, which played an important role in reinforcing and upgrading weak links in the industrial chains.

According to Zhao, investment in manufacturing kept growing in the January-September period. In particular, the investment in high-tech manufacturing increased by 11.3 percent year on year in the first three quarters, and has kept a double-digit growth for 36 consecutive months. Additionally, the decline in industrial exports has narrowed, Zhao added.

Specifically, basic industries have maintained steady growth. The value added of equipment manufacturing went up by 6.0 percent, 2.0 percentage points faster than that of the whole industrial enterprises above the designated size. In September, the electrical machinery, chemical, electronic, and automotive industries contributed nearly 60 percent to the overall industrial growth.

At the same time, emerging industries showed strong momentum. According to data from the China Association of Automobile Manufacturers, the pro-

duction and sales of new energy vehicles (NEVs) in the first three quarters reached 6.31 million and 6.27 million units, growing 33.7 percent and 37.5 percent year on year, respectively. NEVs accounted for 29.8 percent of the total sales of new vehicles.

The new materials industry embraced vigorous and accelerated development. The total output value of the sector maintained double-digit growth in the first nine months of this year. Breakthroughs were made in the development of a

Photovoltaic products and aerospace equipment achieved rapid growth, while the shipbuilding industry continued to lead globally in three major indicators.

"We have been vigorously accelerating the development of advanced manufacturing. In the first three quarters, the investment growth in high-tech manufacturing was 5.1 percentage points higher



China now ranks second globally in terms of computing power, and major projects are advancing rapidly, including one that aims to channel more computing resources from the eastern areas to the less developed western regions.

So far, the 5G technology has been applied in 67 major categories of China's national economy. The number of projects employing 5G and industrial internet exceeds 7,000 nationwide, and there are 2.22 billion users of mobile internet of things terminals.





MTIBWA Sugar's dismal start to the 2023-24 NBC Premier League campaign continued when they suffered a 1-0 away defeat to Kinondoni Municipal Council FC at Uhuru Stadium in Dar es Salaam on Tuesday. A second-half strike by Somali attacking midfielder Ibrahim Elias Ahmed condemned them to their fifth loss of the season. Mtibwa Sugar has won just one game this season after a 3-1 victory over Geita Gold FC at Manungu Stadium in Morogoro last week, and this win took the former seven games to rack up too. The Turiani-based side can ill-afford to drop more points in a favourablelooking fixture against JKT Tanzania, considering that tricky encounters with Azam FC, Young Africans, Namungo FC, and Tabora United are on the horizon. Head coach Zubeir Katwila recently returned to Mtibwa Sugar following Habib Kondo's dismissal and will be searching for back-to-back home victories to prove he is turning things around.



the NBC Premier League so far can certainly be described as a mixed bag for newly-promoted JKT Tanzania.

Speaking to journalists at the Parliament grounds in Dodoma, Sophia said the fight aims to promote tourism as President Samia did through the Royal Tour film, and the fight will be witnessed by people from inside and outside the country.

Sophia said apart from an attractive prize to be presented to the main bout's winner, he will have the opportunity to choose the name of the animal he wants as a nickname.

According to the promoter, such a nickname will be paid for on the pugilist's behalf as a symbol of identity for the country.

Sophia said that the boxers will before and after their fights have the opportunity to visit zoos to witness attractions so that they can be part of promoting the country's tourism.

Pazi's record lately stands at victory in 33 fights- 29 of which are Knockouts (KOs), defeat in 12 fights- two of which are knockouts- and one bout was adjudged a draw.

In Pazi's recent three bouts, the flamboyant pugilist won all of them gallantly. Pazi won against Chimwemwe Chiotcha of Malawi by Technical Knockout in a non-title fight that took place in Tanga early this year.

Pazi had previously registered victory over Limbani Lano, also from Malawi, by Knockout in a non-title fight in Morogoro on November 25, 2022.

The triumph had succeeded in a Knockout victory that Pazi secured over fellow countryman Amour Haji, when the pugilists took on each other in a nontitle bout held in Dar es Salaam.

Katompa is currently rated second out of nine boxers in the Super Middleweight division in DR Congo and is placed 224th in the weight category's list of 1,423 boxers globally.

The pugilist's record now stands at victory in nine bouts, three of which are Knockouts, three lossesone of which is a Knockout- and one fight being adjudged a draw.

On the bright side, the attack has been decent. Only the top three, Young Africans, Simba SC. and Azam FC have scored more goals than Mtibwa Sugar (nine) this season.

Experienced forward Matheo Anthony has spearheaded that attack. He has four goals and one assist so far.

Ladack Chasambi is currently

one of the hottest youngsters in the NBC Premier League and will be a key figure in attempting to get the club back on track again.

He has assisted three times and found the back of the net once in his eight appearances so far.

On the flip side, three wins, two draws and three losses in

place in the table - four points shy of fourthplaced Kinondoni Municipal Council FC.

JKT Tanzania's recent results on the road are far from ideal. In their last four away matches, they have won only once.

Two of those matches ended in defeats as well. It is also worth noting that they have scored just six goals in eight matches this term, meaning only five teams have netted fewer Premier League goals.

Malale will hope his strikers Danny Lyanga, Sixtus Sabilo, and Edward Songo discover their scoring boots if they are to walk away with a victory against Mtibwa Sugar.
