# Experts elated after US agency restores funding for Tanzania

We must work with advanced countries with genuine interest to support our development efforts

CONOMISTS have welcomed with relief the country's reinstatement dinto the Millennium Challenge ✓ Corporation (MCC) arrangement, after its being excluded in 2016.

Interviewed experts expressed these sentiments in the wake of a conversation between President Samia Suluhu Hassan with MCC chief executive officer Alice Albright via zoom on Wednesday, where the US government official said that Tanzania had been reinstated into its funding eligibility list.

The US government suspended Tanzania from MCC inclusion in March 2016 on account of shrinking democratic space, where a \$472m grant was cancelled, being directed to the energy sector.

Dr Donath Olomi, the Institute of Management and Entrepreneurship Development (IMED) chief executive officer said that restoring MCC funding was a huge plus for the country's development agenda.

Noting that this is a sign of improved ties with key organizations, he pointed at the

# Wildlife invasions cost **govt 5.5bn/- since 2018**

**By Marc Nkwame** 

TENS of thousands of planted acreage were destroyed and upwards of 28,000 killed or badly injured across 88 administrative districts since 2018, with the government paying over 5.5bn/- in compensation.

Angellah Kairuki, the Natu-

ral Resources and Tourism minister, made this observation at the first annual wildlife corridor conference at the Julius Nyerere International Convention Center (JNICC) yesterday.

She said that where lives are lost, the government does not compensate for death but offers consolation, urging conservators and other authorities to work together to address the rising incidences of invasions of wild animals in villages.

The two days conference will see scientists, researchers, conservators and min

# IMF extends \$150.5m financial stability loan

The multilateral financial institution said the IMF executive board had completed the second review of the extended credit facility, where this allocation brings Tanzania's total access under this allocation schedule to \$455.3m.

The board approved in July 2022 a total access of special drawing rights, a credit unit of account, amounting to 795.58m (200 percent of the country's quota, or \$1,046.4m) at the time of programme approval, it said.

The credit arrangement aims to support economic recovery, preserve macro-financial stability, while promoting sustainable and inclusive growth, it affirmed elaborating that the reforms envisaged center on strengthening fiscal space.

Reforms also target enhancing the monetary policy framework and strengthening financial sector supervision and advancing structural reforms, it affirmed.

Noting that Tanzania's economic reform programme is broadly on track, the board assessment highlights that most end-June 2023 quantitative performance criteria and indicative targets were met.

The government's structural reform agenda is progressing well, with financial year structural benchmarks completed on time, reflecting ardent commitment to the reform agenda, it stated. After slowing down in 2022, growth was expected to rebound in 2023 but an unfavourable global economic environment and domestic factors continue to weigh on Tanzania's economic recovery, it further

Inflation has moderated and is within the Bank of Tanzania's target, with the fiscal deficit wider than expected at the closure of fiscal 2022/23, it affirmed, explaining the situation as largely reflecting shortfalls in revenue collections.

The government is committed to implement the fiscal consolidation envisaged in the current 2023/24 budget, it said, underlining that a wider current account deficit for fiscal 2022/23 and tighter external financial conditions resulted in pressures in the foreign exchange market.

"Economic recovery is expected to regain momentum going forward but faces headwinds from the unfavourable global economic environment. Near-term policy priorities include exchange rate flexibility combined with tightening of local currency liquidity and fiscal consolidation, while preserving priority social spending," it elaborated, specifying that the mediumterm outlook is positive subject to steadfast implementation of the government's reform agenda, anchored by the credit arrangement. Bo Li, deputy managing director and acting board chairman, issued a statement at the end of discussions that the fiscal consolidation envisaged in the budget will help buttress fiscal sustainability.

"Efforts to enhance domestic revenue mobilisation and improve spending efficiency are important to create fiscal space, finance priority investment and social spending, and safeguard debt sustainability," he said. "Further, closing gaps in Tanzania's human and social development will require prioritizing social spending during budget planning and execution." he insisted. asserting that strengthening public financial management and oversight of state-owned enterprises "will help contain fiscal risks."

"A coordinated macroeconomic policy response is necessary to address pressures in the foreign exchange market. The authorities' response to the emerging foreign exchange market pressures has focused on interventions and regulatory measures," the IMF executive affirmed.

Addressing the root causes of imbalances, Li calls for a more comprehensive policy response that includes exchange rate flexibility, fiscal consolidation, and mopping up local currency liquidity.

Modernizing the monetary policy framework for a transition to an interest rate-based monetary policy is key to enhance the effectiveness of monetary policy, he emphasised.

Upgrading the financial supervision framework, including by implementing structural adjustment recommendations, will help to buttress financial sector stability and promote financial deepening, he similarly affirmed, demanding measures to align Tanzania's legal framework with FATF standards.

Implementing the standards will improve the effectiveness of the anti-money laundering and combating the financing of terrorism (AML/CFT) framework.

"Structural reforms are essential to promote inclusive, resilient, and sustainable growth. Business reforms should focus on streamlining bureaucratic procedures, simplifying the regulatory regime and enhancing regulatory transparency. "Implementation and enforcement of the authorities' anti-corruption legislation and strategies is central to enhancing governance. Tanzania's high vulnerability to climate change calls for continued efforts to increase resilience through mitigation and adaptation policies," the statement added.

A report tabled at the confer-

ence asserts that 61 wildlife cor- asked that villages near corriridors are in use at present, with two of the vital connectivity passages listed in the Government Gazette.

Dr Julius Keyyu, operational director at the Tanzania Wildlife Research Institute (TAWIRI), said that 41 listed passages are on the verge of disappearance owing to increasing agro-habitat infringements.

The corridor restoration advisory committee has listed 20 corridors for priority in restoration owing to their biodiversity importance, while the minister

dors and other reserved areas be placed under acute land use planning supervision.

The US Agency for International Development (USAID) aided the restoration of seven wildlife corridors in the country through participatory approach by empowering local communities to that effect.

Threatened connectivity routes are Kwakuchinja corridor linking Tarangire and Manyara national parks, the Tarangire to Simanjiro plains said to be vital dispersal areas for

Tarangire wildlife, the Kigosi Moyowosi - Uvinza corridor connecting the conservation complex with Ugalla reserved

Others include the Selous to Udzungwa corridor linking the game reserve with the southern mountain range, along with the Pemba Channel Conservation Area (PECCA), a marine corridor off the island.

There is also the Mahale Park to Katavi connection and the Amani to Nilo corridor, described as a patch of forest linking Amani and the Nilo forest reserves near Tanga city.

Gazetted corridors are the Kitendeni corridor linking Longido and West Kilimanjaro and Mpanga to Kipengere corridor, said to be decrepit despite being gazetted, he stated.

Contributors urged that wildlife corridors be gazetted, in a path breaking conference bringing together local conservation and research entities as well as experts from USAID, the United Nations Development Programme (UNDP) and the Frankfurt Zoological Society (FZS)

# Access to clean water soars by 13pct in Mbinga District

ACCESS to clean and safe water in rural areas of Mbinga District has jumped by 13 per cent in a space of four years, Rural Water Supply and Sanitation Agency (RUWASA) revealed over the weekend.

Access to clean and safe water now stands at 62 per cent, up from only 49 per cent recorded in 2019, according to Ruwasa acting manager for Mbinga District, Frolian Francis.

He made this promising revelation on Saturday (December 9, 2023) during the climax of the 62nd Independence Day Celebration held at Kigonsera high school here in Mbinga District.

Francis said more is coming, banking his hopes on the 15 projects worth 17bn/-, whose implementation is in progress in various parts of Mbinga District.

"After the completion of the projects, access to clean and safe water in rural areas will reach over 85 per cent come 2025," he said.

Before the Independence in 1961, Mbinga District had not even one single water project for

its people, but for colonisers.

# anguage isn't barrier towards executing new education policy'

THE Vice Chancellor of the Open University of Tanzania (OUT) Prof Elifas Bisanda has argued that medium of instruction is not a hindrance towards implementation of the newly revised education and training policy 2023.

Prof Bisanda made the remarks yesterday during the annual general meeting (AGM) of convocation held at OUT Ruvuma Regional Centre and attended by participants 

from Tanzania and the international community.

According to him, language is not the only leading factor as many people say. Instead the focus should be on others if they really exist as what is needed is compatibility of the skills that teachers impart to the learners.

"The language of teaching is not a problem to children, instead to teachers who are taught by using Kiswahili", said Prof Bisanda.

He however insisted that the lan-

guage of teaching should be compatible with the local environment that molds a child from his/her childhood endeavor.

Prof Makenya Maboko from University of Dar es Salaam who was a keynote speaker said the time has come that Tanzania need to transform its curricula through policy and implement best practices of it through competent based education from lower levels that will determine the future of learners after completing a certain educa-

tion level.

He was of the view that through the newly revised education and training programmes will have to be redesigned to emphasize acquisition of knowledge, skills and attitudes that uphold employability and self-employment.

"Establishment of programmes shall be more closely aligned with the needs of labour market and economic opportunities in the country", said Prof Maboko.

A lecturer from Faculty of Busi-

ness Management of the Open University of Tanzania, Dr Chacha Matoka said the implementation of the new revised policy should be delayed as there is no proper preparation of the implementation of the same from infrastructures to human resources something that can have undesired results.

"For instance, provision of tablets to teachers in the country is of no use as many of them are used for chatting and other non-beneficial uses for themselves and the public at large," said Dr Chacha.

# JKCI now do transcatheter aortic valve implantation procedure for the elderly

HEAVY investment made by the government has made the Jakaya Kikwete Cardiac Institute (JKCI) to easily do transcatheter aortic valve implantation procedure (TAVI) for the elderly aged between 75 and 80

Dr John Jingu (pictured), permanent secretary in the ministry of Health made the remarks yesterday in Dar es Salaam, when visited three JKCI patients, who had their coronary artery valve replaced with a small hole without opening the chest, which is the first in the country and second in Sub-Saharan Africa.

He said that the move is after ongoing investments made in the sector, including the allocation of 5bn/- for the training of specialists and super specialists) abroad, who are among the successful TAVI.

"Next year, 10.9bn/- will be allocated to 700 specialists from different hospitals in the country, including JKCI, for the training of specialists in specialized and specialist services," said Dr Jingu.

He aligned the benefits of investment in the sector, which has come from JKCI is an income of 920m/-



ber, this year, due to income from 3,000 patients who were treated from inside and outside about 20 countries.

"This investment saves lives, the cost is not only for us but also for neighboring countries, and there are also those who come from outside the continent of Africa. We will continue to launch services like this, the TAVI service. When I did research I found out that it is done in South Africa and here in Tanzania, in Sub-Saharan Africa," said Dr

JKCI Executive Director Dr Peter Kisenge said three adults between the ages of 75 and 80 have received the service, for approximately one for the period from July to Decemand a half to two hours per person

and the cost is 80m/- for each patient.

Cardiologist, Dr Tatizo Waane said that the TAVI service reduces the harm to the patient, because it takes less than two days, treatment and the patient is discharged.

Cardiologist, from Stancare hospital in India, Dr Ashishkumar Mandalay, together with his colleagues, said that the implementation of the TAVI service and cooperation with JKCI, has increased their experience.

He said that the presence of modern medical equipment has made the service successful, also saying that the local champions' skills helped the surgery to be done easily.

"Before the establishment of the Rural Water and Sanitation Agency (Ruwasa), the government was suffering to make sure that it runs fast to solve the challenges which however did not succeed to a large extent," he observed.

The minister directed the Permanent Secretary (PS) in the parent ministry to take punitive measures against all executives who are sabotaging water projects in the country.

"There are some unscrupulous people who work habitually and for their self-interest, such officers should take strict disciplinary measures, noting that it was

### Let's drive to arrive alive this Xmas

CHRISTMAS comes but once We have ten days to go moving into the climax of this festive season. We also begin tallying road accidents, fatalities and injuries as more traffic will be on our roads, more drivers will be drinking and speeding, and more of them will die or kill their families or kill others using the roads. Police roadblocks help a little. They ensure drivers are licensed and are not obviously drunk and that vehicles are licensed and therefore that they are also insured. But this is about as far it goes: a quick check that reminds most drivers to be careful and then back to as it was.

Of far more value are those police speed-traps and the highway patrol vehicles that go round looking for bad driving as well as mounting quick surprise speed-traps at unexpected places.

We hope that the police will be able to use every one of the limited number of speed cameras they have this festive season, for that will at least reduce one big killer.

A second major killer is alcohol. Unfortunately, Tanzania does not test much to see if drivers are over the limit or even drunk. We have to rely on the common sense of drivers, and it is clear that many Tanzanians feel they are quite capable of controlling a car when they have downed a few

Statistics show they are wrong, and part of the holiday death toll comes from the higher likelihood that many drivers, being off work, are drinking during the day.

We have suggested before that equipping roadblocks with the basic breathalysers common in some countries would do a great deal to keeping our roads a lot safer, and we suspect that at least in the early stages of zero tolerance to drinking and driving, the fines would more than pay for the equipment.

The third killer is bad driving,

and Tanzania has a lot of bad drivers plus a lot of fairly reasonable drivers who try and drive when tired, drive long distances as quickly as possible, and drive too fast on dark roads.

Bad driving and wrong driving kill. We have seen that over the years. Sometimes, in some places and some conditions, the speed limit is far too fast at lower speeds it is easier for two vehicles to pass, especially on curves or where the road is raised to cross a stream.

Night driving kills more than it should, largely because so few people take the trouble to work out what is their minimum braking distance and then checking to see if their headlights will light up an obstruction in time. If not they will have a problem.

We might need to borrow the law in several countries that compels drivers to carry a spare headlight bulb. These are cheap and easy to replace and having both bulbs does give a driver a better chance of seeing obstructions.

Even roadblocks would be a useful place to be told a bulb was out and would offer protection while this was changed. The offence can be not having a spare, not having a dead light.

A final major killer is the impatience so many show on the roads. Taking a trip a little easier, going with the flow and enjoying the ride a bit more does not add much to the travel time few trips would be more than 15 per cent longer and would be a lot safer and more enjoyable.

Leaving early enough to complete a trip in daylight will boost the chances of living through that trip.

Most drivers know the rules and have heard the suggestions. What is needed now is for them to follow them and assume that sometimes the expert does know better. If we drive more safely we can demand others do the same.

## The UN Food Systems summits: We need voices from around globe

TWO years ago and this year, the UN convened Food Systems Summit. A historic moment for centering food in many critical issues facing people all over our planet today: from hunger and malnutrition; to environment and nature; to livelihoods and human rights; to resilience to shocks and stresses like COVID 19 and the climate emergency.

Many African countries have seen good progress against some malnutrition indicators.

Like other middle-income countries, Tanzania also faces a complex battle against malnutrition in all its forms, with a growing obesity and diet-related noncommunicable disease burden together with continuing high levels of undernutrition.

At the same time, large parts of the country are vulnerable to the impacts of climate change, with hazards like heat waves, droughts, and disrupted weather patterns threatening rainfed agriculture and linked livelihoods.

Tanzania also faces a complex battle against malnutrition in all its forms, with a growing obesity and diet-related non-communicable disease burden together with continuing high levels of undernutrition.

At the national level, Tanzania joins over 125 countries that have embarked on coordinating efforts for inclusive, multistakeholder Food Systems Summit Dialogues to engage around the vision of the 'people's summit'. All over the world, countries have been holding - and in some cases continue to hold - national and sub-national dialogues to surface

and prioritise needs and actions.

These convenings bring stakeholders from different areas of public sector, national and subnational, representing ministries like agriculture, food, health, and environment together with private sector players like food industry bodies or small and medium-sized enterprises; together with UN agency representatives from the likes of the Food and Agriculture Organisation (FAO), the International Fund for Agricultural Development (IFAD), the World Food Programme (WFP), and the United Nations Children's Fund (UNICEF); together with academics and representatives from international and national Non-governmental organisations and civil society organisations (NGOs and CSOs); and finally and very crucially, together with representatives of stakeholders from groups with voices that too often go unheard - women's groups, consumer groups, young people, indigenous people, and farmer organisations.

In countries where women are most marginalised, discriminated under the law and where gendered norms prevent women from owning property and resources, people are also the hungriest. This is because gender equality and food systems are intertwined.

However, too often, we only focus on the roles that women play in production, processing, trading of food and in making decisions about consumption and purchase of food at household



# Africa at COP28: Africa's great blue wall: Delivering climate-positive growth through the blue economy

MOBILIZING financing for such ambitious projects that provides climate adaptation and sustainable use of marine resources is key

As an Islander from the Seychelles, Africa's smallest country, I find that the ocean is intricately woven into my heritage. It not only defines my roots but also shapes the trajectory of my journey. When I think of the future, I can't help but also look at the boundless possibilities reflected in the vast expanse of the ocean.

Jean-Paul Adam I am therefore encouraged that the growing trend of African leaders turning their attention to the ocean as a catalyst for achieving "climate positive growth". This is the premise of the Nairobi Climate Action Summit, where African leaders emphasized that 'Africa possesses both the potential and the ambition to be a vital component of the global solution to climate change'.

African leaders are emphasizing that 'climate positive growth' will be built by Africans, for Africans. Of course, support is needed - no one can achieve the scale of change needed without massive upscaling of investment.

The Great Blue Wall- climate resilience and a 'regenerative blue economy'

The Great Blue Wall is an initiative which aims to catalyze the promise of 'climate positive growth' into action.

Under the Comoros Presidency, the African Union seeks, now more than ever, a 'blue future'. Spearheaded by African countries in the Western Indian Ocean, as outlined in the Moroni Declaration adopted in June 2023, the Great Blue Wall initiative aims to shield African countries from impacts of climate change and natural disasters uplifting and delivering economic empowerment to local coastal and island communities.

The existing industrialized fishing practices of distant nations is completely detached from the eco-system which supports the biomass and hence poses a threat. The Indian Ocean Tuna Commission has underlined overfishing of tuna species, especially the big-eye tuna and yellow-fin tuna. At the same time, the warming ocean, increasing acidification of the water and consequent bleaching of coral reefs affects the availability of the prey species such as mackerel for the much-prized tunas.

Coastal African nations find themselves at risk, often reaping limited benefits from their marine resources, similar to challenges faced with mineral exports from the mainland. FAO and other UN agencies are working with African countries to allow them to reap more benefit from their marine resources.

The Great Blue Wall aims to conserve marine resources through Marine Protected Areas as well as empower local communities by boosting the sustainable fisheries value chain and establishing of additional economic opportunities through eco-tourism and related economic activities.

The 2022 Kunming-Montreal Framework on Biological Diversity delivered a global pledge to place 30% of the world's oceans under protection-further reinforced by the 2023 adoption of an agreement on protecting marine biodiversity beyond areas of national jurisdiction.

The Great Blue Wall is the blueprint for 'regenerative blue economy' A regenerative model also implies actively investing in the ocean for climate resilience. In this instance, mangroves in particular are nature's best line of defense. Mangroves provide some of the most effective protections against coastal erosion, while they are also critical spawning grounds for numerous commercial fish species and crustaceans.

Marine-based eco-tourism is also one of the most valuable forms of economic activity to provide opportunities for local populations.

These are some of the elements that underpin the transformation from 'extraction' to 'regeneration'.

How does this fit into Africa's

drive for sustainable industrialization?

The Great Blue Wall not only of-

fers a model for a 'regenerative blue economy' but also addresses broader challenges associated with Africa's maritime space.

As Africa's trade heavily relies on sea transport, ensuring climate-resistant port infrastructure becomes pivotal, most pressing is the development of Africa's maritime corridors for trade to build on the promise of the African Continental Free Trade Area (AfCFTA).

Reliable and affordable energy is a key enabler of sustainable value chains. Opportunities exist for offshore wind energy, for example, as being explored by Morocco. Meanwhile, floating solar is being tested in Seychelles, while using the ocean temperature differential for cooling purposes is being piloted in Mauritius.

Financing the vision

As the Great Blue

As the Great Blue Wall envisions climate resilience built on community-focused economic empowerment, financing is key. As we head to COP28, the gap in climate finance is glaring- all the while conflicts divert resources away from climate and development priorities. The climate finance gap highlighted by the High Level Expert Panel on Climate Finance co-chaired by Nick Stern and Vera Songwe showed that \$2.4 trillion was required by 2030.

Large-scale climate finance availability would allow the Great Blue Wall initiative to mobilize quickly and at scale. Additionally, the Great Blue Wall also aims to generate income streams that support communities, reducing dependency and helps to boost domestic resource mobilization.

Among these opportunities including tapping into the potential of 'blue carbon' or issuing carbon credits based on the sequestration potential of oceanic resources. Successful small scale projects such as Mikoko Pamoja in Kenya have delivered high quality results for local communities through mangrove rehabilitation.

Recognizing increased debt burdens of African countries, the opportunity to use debt swap instruments to replace existing expensive debt with more affordable longer-term lending could potentially liberate fiscal space to be redeployed to finance some of the priorities of the Great Blue Wall. The Seychelles debt for climate swap of 2015 for example delivered new and predictable flows of finance for marine conservation.

Looking ahead: COP28 and beyond

The Great Blue Wall has highlevel political backing and is a priority for the African Union and its partners.

Efforts are underway to expand its adoption to other African countries, connecting the ambitions of the countries along the Indian Ocean to those along the Atlantic.

At COP28, the focus is on mobilizing seed financing for this ambitious project which not only provides climate adaptation, but also seeks to fundamentally transform the economic model for management of marine resources.

The Great Blue Wall captures the essence of the 'climate positive growth' we hope to see.

EMOCRATIC Republic of the Congo's (DRC) ourth election on 20 December will occur against a protracted conflict shaping the nation's political landscape. These polls are plagued by numerous interconnected challenges likely to result in contested outcomes and political unrest.

A complex interplay of political turbulence and democratic aspirations characterises the backdrop of previous elections in the country. In 2006, following decades of authoritarian rule and violent conflict, the DRC witnessed its inaugural multi-party elections. Joseph Kabila controversially became president, with 58% of the votes, over Jean-Pierre Bemba's 42%.

In 2011, Kabila's contentious re-election led to violent protests and a disputed ballot outcome. Subsequent political tensions compromised the country's stability. Initially scheduled for November 2016, the polls were postponed to December 2018. This sparked widespread anger and protests amid concerns about Kabila's reluctance to step down after his constitutionally mandated second term.

Félix Tshisekedi won with 39.57% of the votes defeating Martin Fayulu's 34.83%. Although the 2018 elections marked a historic peaceful transfer of power since independence in 1960, they were marred by allegations of vote manipulation favouring Tshisekedi.

Several hurdles must be overcome before this year's voting to ensure participation, anticipate post-election mediation and prevent violence.

The appointment of Denis Kadima Kazadi, a close associate of the president, as head of the electoral commission (Ceni) sparked opposition protests. It is regarded as government's attempt to obstruct the process. The controversy over the deployment of European Union (EU) election observers adds doubts, jeopardising the fairness of the process.

### Security issues persist

The prevailing security challenges, especially in the eastern provinces, present a major obstacle, making electoral registration in Rutshuru and Masisi in North Kivu impossible. Those communities will be unable to participate in the upcoming presidential and legislative elections. The official electoral body confirmed that violence in eastern DRC would disenfranchise voters in North Kivu, and many displaced populations could also be excluded due to ongoing unrest.

This situation undermines the legitimacy of the elections, accentuating the sense of exclusion among eastern communities. In addition to this denial of a constitutional right, for many people in the DRC, voter cards have served as a sole form of national identity for decades. Not having access to them amplifies this feeling of abandonment. This potentially fosters further polarisation and creates a breeding ground for militias and armed groups that rely on community-based and ethnic mobilisation strategies.

In 2018, the Yumbi, Beni and Butembo couldn't vote due to the Ebola epidemic and insecurity. Partial elections were later organised to remedy the situation. However, insecurity in North Kivu raises uncertainty about holding similar partial elections.

### **Logistical concerns**

Logistical hurdles persist, with the distribution of voter cards and publication of electoral rolls still incomplete in some areas. According to interviews conducted by the Institute for Security Studies in Goma in early December,

'AMIBIA'S desert-adapted lions are not a different species but are admired for their acquired knowledge of survival in harsh, unforgiving conditions. They're a worldwide tourist attraction and are closely monitored by conser-

On 12 October a satellite collar on a male lion known as XPL 107 (but affectionately named Mwezi) was tracked from the Palmwag concession area to the Wild Veld Hunting Camp near Khowarib village. There could be only one reason: he had been shot (this was later confirmed by Desert Lion Conservation).

An NGO alerted Izak Smit of Desert Lions Human Relations Aid (DeLHRA) who was then told by a contact in Khowarib that the lion had been seen near the village. He then contacted the gatekeeper at the entry gate to the Palmwag concession, a logical entry point to access the area, who said two people in a government vehicle had escorted a vehicle with a hunting party of five with rifles into the concession. They told him they were 'policing'. They later returned.

Smit said he "arrived at the conclusion that this Lion had been hunted and shot at the last recorded position in the Skeleton Coast Park or just inside the Palmwag concession area's Western boundary around mid-day 11th October 2023".

"[Mwezi] was shot in the Skeleton Coast National Park, which is shocking," said Smit. "The Ministry used the collar to track the lion to accommodate a hunter. That collar was sponsored by a private organisation to protect the lion and to help prevent conflict situations. It's like canned hunting because he's technically cap-

### 'Problem-causing animal'

He sent an email to Kenneth Uiseb, Deputy Director of Wildlife Monitoring and Research at the Ministry of Environment (MEFT), asking if the hunt was legitimate as it was in a protected area and asked for copies of the hunting permit and the report of the official who accompanied the hunters.

The email went unanswered, but instead, the Department issued a Press release seeking to legitimise the hunt, saying the lion was a "problem-causing animal" and destroyed for "persistently killing people's livestock". It indicated that the 'conservation' hunt raised N\$320,000, most of which would be paid 'to the affect-

According to Smit, those alleged incidents happened a long time before the hunt and cannot be exclusively attributed to him. A month earlier the NGO Desert Lion Conservation had celebrated a mating between the li-

most polling stations were yet to receive electoral machines.

Another logistical problem is accessibility in certain parts of the country due to bad or non-existent roads. In previous years, the United Nations Organization Stabilization Mission in the DRC (Monusco) played a key role in deploying electoral equipment and teams. The decrease of Monusco presence in other provinces and some eastern territories, along with its imminent departure reduces this possibility. This could compromise access to certain areas, worsen security, and undermine inclusivity.

Finally, the electoral campaign has been peppered with recurrent references

to identity, hate and exclusion speeches. Primarily between the ethnic groups or electoral strongholds of the leading candidates, in particular between Kasai natives supporting the outgoing president and the Katangese supporting Moise Katumbi. Discriminatory rhetoric against those deemed non-Congolese and violent incidents have also occurred in Kindu (Maniema) and Kin-

These dynamics, along with the controversies in DRC polls since 2006, may undermine the election legitimacy, opening the door to post-election protests and violence in an already fragile context. Political turmoil and further instability can only be

avoided with free and fair elections, especially in a political climate riddled with tension, fear, and disillusionment.

Civil society and influential religious lead-

ers must continue their efforts to educate

the public about their civic responsibility to vote and non-violence practices. This proactive engagement can enhance participation and help prevent outbreaks of violence. The government and Ceni must ensure the transparency and credibility of the elec-

# Storm brewing over hunt of iconic collared desert lion in Namibia

oness ZPL-108 and Mwezi, described as "one of the most reproductively successful males in the population".

Its website speculated that "XPL-108 may lead the male XPL-7 to the coast and expose him to the availability of the marine food resources. In fact, after they separated, he searched for her and followed the Uniab River westwards into the Skeleton Coast Park". That was where he was shot.

Joe Mburu of Preserving Our Animals in the Wild wrote that Namibia has zero respect for wildlife. "Trophy hunting is not a form of conservation, but rather a contributing factor to extinction. In Namibia, there are only 25 desert lions remaining."

According to a report in Africa Geographic, no designated officials within the relevant conservancies or concession holders were informed that there was a legitimate hunt authorised in the area. "We are also informed that neither the Directorate of Scientific Services at MEFT nor the relevant MEFT lion-conflict manager were informed about the planned hunt."

In its press release, the department rounded on those who reported the hunt, saying "there are individuals and groups that are keen on discrediting Namibia's conservation methods" and animal rights groups who "continue to spread unfounded rumours aimed at tarnishing the image of our country".

The lion, said the press release, had killed 14 goats and a Brahman bull and had been collared making it easier for the Ministry to track it. It had been destroyed through 'conservation hunting'.

### Smit wasn't buying it.

"No evidence was given of the assertion that the lion continued to prey on livestock, causing serious concerns to communities and farmers in the area".

The press release, he said, seemed to assert that the lion was collared after the incidents to manage the conflict. However, he added, it is well known that this specific lion was collared many years ago.

"The press release also does not explain what is meant by 'conservation hunting' and where the [money] from the hunt comes from. I therefore believe ... that the so-called conservation hunting was in fact a trophy hunt."

Smit added that if a problem animal was to be killed, notice of this had by law to first be tabled in the Official Gazette.

"The hunted lion was not declared a problem animal in terms of section 53 of the Nature Conservation Ordinance 4 of 1975 after a proper evaluation clearly required before such declaration can take place. Nor was such declaration published in the Official Gazette as is required. The Ministry therefore was not entitled to treat the lion that was shot and killed as

a problem animal. Nor was it entitled to request a fee to be paid.

Undoubtedly aware of the international furore that took place in Zimbabwe on the killing of Cecil the Lion, Ministry public relations officer Romeo Muyunda called on "all tourists, visitors and all Namibians to disregard the advocacy against our country aimed at nothing but discrediting our conserva-

tion efforts". Smit is sticking to his guns: "I stand convinced that the Ministry of Environment, Forestry and Tourism has, in this instance, acted ultra vires and therefore request a full criminal investigation for a contravention of section 27(1) of The Nature Conservation Ordinance 4 of 1975 for the illegal hunting of protected game."

# Impeachment inquiry threatens Biden with election-year headache

Y voting to formally authorise the congressional investigation into Joe Biden, Republicans in the House of Representatives have started the ball rolling towards his impeachment.

It may be difficult to stop.

Three of the four previous times the House took this step, the chamber ultimately opted to impeach. The one time it did not was because Richard Nixon resigned before a vote could be held.

Republicans allege the president benefited from his family's foreign business dealings, although they have not yet produced any solid evidence that he did.

In the short-term, the House's action gives the investigating committees more power to subpoena documents and testimony and for judges to enforce those requests. The Biden White House, which has cited the lack of a formal vote as grounds for refusing to provide some information, may now be compelled to comply.

Ultimately, this vote could clear the path for House Republicans, despite their narrow majority, to stick together and back impeachment sometime in early 2024.

They now are on the record agreeing to move the process forward. If centrist Republicans in congressional districts won by Mr Biden in 2020 are going to take the political hit for starting the investigation, they may conclude it is best to see it through to the end.

The end in the House, at least. The matter would then move to the Democratic-controlled Senate, where it takes a two-thirds majority to convict and remove a president.

That is a high bar that has never been reached for a president in US history. And at least some Republicans have expressed concern that Wednesday's vote could be another indication that the impeachment process is being diminished.

There is no telling what kind of twists and turns are in store for this inquiry, either. While no evidence directly linking Mr Biden to his son's professional and personal failings has yet to be presented, sweeping powers can sometimes yield surprising results.

Bill Clinton's impeachment for lying about an affair with an intern began with an inquiry into a failed real estate deal. Hillary Clinton's email server saga came from a probe into a US ambassador's death in Libya.

# Imperfect COP28' gives direction for managed, equitable move from fossil fuels

**DUBAI** 

comes of COP28 are being hotly debated in both the scientific and social justice arenas, the climate conference has taken an unprecedented step forward toward a just transition, says Yamide Dagnet, Director for Climate Justice at the Open Society Foundations.

Making some preliminary remarks a day after the climate conference ended, she said: "COP28 ends like it started: imperfect, yet an important and unprecedented step forward in our "course correction" for a just transition towards resilient and greener economies.'

The UN decision acknowledged the need for the decline of coal, oil, and gas for the first time in an agreement that talks about transitioning out of fossil fuels. It will also be known for operationalizing the Loss and Damages Fund, even if the funding falls far below the requirements for climate-stressed countries and communities.

UN Climate Change Executive Secretary Simon Stiell acknowledged these contractions in his final speech.

"While we didn't turn the page on the fossil fuel era in Dubai, this outcome is the beginning of the end," Stiell said.

He also noted that climate

finance, which he said was a great enabler of climate action, fell short of the trillions needed to support developing countries with clean energy transitions and adaptation efforts.

He urged ordinary people everywhere to not relent in their demands for a climatejust world.

"In the crucial years ahead, your voices and determination will be more important than ever. I urge vou never to relent. We are still in this race. We will be with you every single step of the way." Dagnet believes that COP28 is the start of a new era in climate justice.

"This is not an end; rather, just the beginning of an implementation journey that we know is hard but can be so positively transformative, and just if we manage to mobilize, in an equitable manner, all handson deck. A climate-just journey and outcome require vigilance, creativity, and accountability: stronger solidarity and engagement at all levels; promoting human rights: and shared prosperity for all," she says.

This COP, Danget says, laid bare the issues with the Paris Agreement, especially with the just transition.

"More specifically, this COP exposed all the contradictions and challenges faced when implementing the promises of the Paris Agreement, especially a managed, equitable transition away from fossil fuels and the sustained mobilization, alignment, and access to financial flows domestically and internationally to decarbonize and build resilience," Dagnet says."

While some signals got clearer with more substantive commitments, challenges remain, however, in how the just and equitable transition is se-

"Inclusive processes matter to foster shared prosperity and benefits throughout the journey, together with adequate safeguards to minimize unintended adverse impacts of climate-related measures and technologies and to protect frontline and marginalized communities.

"Similarly, the just operationalization and continued capitalization of the Loss and Damage Fund will require vigilance, effective guidance, and mechanisms to make sure commensurate funding is actually mobilized and reaches the communities that need it the most in a timely manner. Adequate mobilization of finance for adaptation by the donor community is also essential to tackle losses and damages with dignity. We are happy that a dozen of them committed to join OSF efforts in this regard."

## China-Africa cooperation propels Africa's digital economy development, says WTO

IN recent years, amid a sluggish global economy, an increasing number of African nations have recognized the digital economy as a pivotal driver for their development, and China, with close connections with Africa, naturally emerges as a crucial partner in propelling the continent's digital economy and realizing its modernization aspirations, Deputy Director-General of the World Trade Organization (WTO) Zhang Xiangchen has said.

In the process of economic globalization, there exists an imbalance in the distribution of interests between the Global North and the Global South, Zhang said in a recent interview with Xinhua in Nairobi, the capital of Kenya, noting that developing countries, especially African nations, have reaped limited benefits.

Developing the digital economy is a crucial pathway to gaining advantages in international competition in the future, Zhang said. And developing countries, including those in Africa, should benefit from "re-globalization" distinguished by its emphasis on digitalization, he added.

Africa has a vast market, a sound market environment and the youngest population globally, which, Zhang said, "are advantages for Africa to develop the digital economy." However, research conducted by the WTO found that African countries have a relatively low share in global digital

"Africa's slower pace in digitization primarily stems from the digital gap, including deficiencies in digital infrastructure, lack of knowledge and skills for digitalization and regulations," said Zhang. "If these issues can be addressed in African countries, I believe Africa will catch up in this field."

He said that China's long-standing relationship with Africa holds significant value in terms of sharing develop-

In recent years, guided by mechanisms such as the Forum on China-Africa Cooperation and the Belt and Road Initiative, an increasing number of Chinese companies have continuously expanded their investments in Africa.

In countries like Nigeria and Kenya, Chinese-funded enterprises have established mobile payment platforms, providing secure and convenient digital payment services to millions of users. Additionally, Chinese e-commerce platforms enable many African people to sell distinctive

While the digital economy can be a country's competitive advantage, "the digital economy cannot entirely replace traditional industries such as manufacturing, especially for African countries that have not yet completed industrialization. The digital economy is one of the drivers for growth," he said.

"While African countries develop the digital economy, they should also strengthen their manufacturing sector to achieve industrialization as soon as possible," he added.

Zhang highlighted China's initiatives for supporting Africa's industrialization, agricultural modernization and talent development, saying that these will further drive Africa's economic and social development.

He anticipated that an increasing number of Chinese companies are poised to invest in Africa, thereby expediting Africa's digital transformation.

One of the major challenges for Africa in achieving digital transformation is education, Zhang said, stressing that "Africa needs a significant number of skilled young individuals engaged in digital-related-work; therefore, cooperation between Africa and China on talent development is crucial."

"China is a reliable friend to Africa, and their cooperation will continuously provide momentum for Africa's development of the digital economy," Zhang said.

# Study shows risks of using painkillers too early in life

### LONDON

THE prolonged use of painkillers in children and young individuals may be associated with later-life challenges in mental health and addiction, a new study shows.

Researchers said treating chronic pain in those under the age of 25 is essential, but warned the regular use of painkillers could lead to overreliance.

The study by scientists at St George's, University of London alongside the University of Liverpool, looked at anonymous medical records of 853,625 people aged two to 24.

The analysis revealed that 115,101 patients were diagnosed with chronic pain lasting more than three months. Among this group, 20,298 received repeat prescriptions for painkillers without a specific diagnosis while 11,032 were both diagnosed and prescribed pain-

Subsequent follow-ups, spanning an average of five years after turning 25, revealed that the 11,644 individuals experienced a "substance misuse event", 143,838 reported poor mental health, and 77,337 received at least one opioid prescription.

"The findings are concerning as those under 25 are particularly vulnerable. This means regular use of painkillers to

ease chronic pain may lead to unintentional over-reliance on pain medication in adult life. Exploring when the right time is to refer these young people to specialised pain services for more targeted support will also be a vital factor when revamping pain management practice," said Professor Reecha Sofat from the University of Liverpool, who was involved in the research.

Highlighted in the study was

the over-representation of patients with learning disabilities and autism in the cohort receiving repeat prescriptions, signalling potential over-prescribing within this vulnerable group.

The team also suggested that the observed trends in their study might be attributed to various factors, one of which could be that individuals prescribed painkillers from a young age may have experienced more severe or frequent pain.

"It's clear that chronic pain non-prescription drugs in later management in young people needs to be optimised," Dr Andrew Lambarth, an academic clinical fellow in clinical pharmacology and therapeutics at St George's, University of London, said.

"We know under-treating pain can cause harm in both the short and long term, but it's also essential to avoid over-reliance on medicines that could lead to dependence on prescription or

life," Lambarth said.

"We now need to work with all healthcare providers to help them weigh up the risks and benefits of prescribing painkillers at a young age, and encourage the consideration of other recognised and effective non-drug management approaches." The findings have been published in The Lancet Regional Health - Europe.

# DR Congo election: 'We would vote for peace - if we had a vote'

FTER heavily armed rebels surrounded her small village in eastern Democratic Republic Congo, Musa Bi walked for seven days with six young children until she reached a UN-run refugee camp.

The 42-year-old is filled with worry, with no idea of the fate of her husband and two other children, as the family was separated in the chaos that followed the advance by the M23 rebels.

She has little thought for the 20 December presidential election - and while the conflict taking place around her may be dominating the campaign, there will be no voting in several areas of the North Kivu province where she lives because of the unrest.

"M23 came. They were fighting with our [government] soldiers. We started running and those who could not run away, they were killed," she tells the BBC.

Fortunate to survive, Mrs Bi and her children slept in other villages until they reached the Bushagala camp only to be once more spending the nights out in the open, often

When the BBC met them, they had been at the camp at the base of the Mount Nyiragongo volcano for six days, waiting for the UN refugee agency to register them so they get a tent - and food rations.

But the agency is so overwhelmed by the influx of those fleeing - 700 to 1,000 each day - that Mrs Bi is patiently waiting her turn, while relying on those already registered to share their food - normally made of sorghum and millet flour - with her and her little ones.

The UN estimates that nearly seven million people are internally displaced in DR Congo, the highest number on

Yet at Mrs Bi's village near the town of Masisi, her family was self-sufficient, growing food on their nearby farm - until they were driven out by M23, who are on the offensive again as a regional ceasefire initiative flounders.

The fighters, initially Congolese army deserters, accuse the government of marginalising the country's ethnic Tutsi minority and refusing to negotiate with them. They regard the verdant hills around Masisi as their true homeland.

President Félix Tshisekedi, who is seeking a second fiveyear term, has been whipping up nationalist fervour by casting the rebels as a front for what he calls the "expansionist aims" of neighbouring Rwanda - and going as far as

# Africa needs just trade for a just energy transition, **AfDB** head recommends

THE President of the African Development Bank Group Dr Akinwumi Adesina has reiterated his warning that the introduction of a carbon border tax by the European Union could push Africa back into export- oping countries to attain neting raw commodities and un- zero carbon emissions much dermine its industrialisation earlier than stipulated.

The European Union recently launched the initial phase of a Europe-wide carbon tax on imported goods as part of its climate change reduction measures. Adesina said this could penalize African countries.

"African companies that are making cement, steel, aluminium, fertilizers and trying to export to Europe are going to be charged a border tax of 80 euros per tonne. That is very expensive, and all that is going to do is that countries in Africa that already suffer from tariff escalation when they add value to what they produce, now you are forcing them down the value chain," Adesina said.

Adesina spoke during a highlevel panel session at the Doha Forum recently, on "Decoding the Debt Dilemma-Unveiling Multilateral Solutions." Other speakers were Qatar's Minister of Finance Ali bin Ahmed Al Kuwari and Børge Brende, President of the World Economic Forum. CNBC Anchor and Correspondent Dan Murphy moderated the session.

"Africa is going to lose \$25 billion annually," Adesina said. "Africa deserves a carve-out on that [taxation] because we are financing Africa's transition. You cannot industrialise just by renewables; you need a balanced energy mix that allows you to use your natural gas to be able to industrialise."

He described natural gas as an essential resource for Africa that should not be restricted in foreign trade.

"Just trade is what we need, but give us just trade for a just energy transition," Adesina added. "Africa should not be penalised."

He noted that by introducing general punitive measures that also affect developing countries, developed countries are "shifting the goal post" in the differentiated responsibility within the Paris Agreement by forcing devel-

Commenting on the difficulty of achieving consensus on climate restrictions, including taxation, Brende said it would be a long road to political agreement on a global carbon price. But at the same time, energy access and security are

"Moving to a society which is decarbonised takes time," Brende noted. "We have to find bridges between coal as the most extreme form of fossil fuel through natural gas. We have to move at a speed which makes sense, is cost-effective, and there is a price to be paid," Brende said.

Minister Al Kuwari said targets set by climate change experts had at times been "too ambitious, too aggressive, and had not properly taken into consideration transition periods. Qatar, on the other hand, has established a reputation as a responsible supplier of energy to the world, the minister said.

"Qatar believes that natural gas will be the transition fuel and should be adopted. We have invested in increasing our production by 65% and reach a maximum of that production by 2027. 'It's very important for climate change goals to be realistic,' Al Kuwari

# **South Africa** opts for nuclear power as part of measures to address electricity crisis

SOUTH Africa, economically crippled by a serious electricity crisis and repeated power cuts, plans to increase its nuclear power production, which is currently marginal, the government announced on Tuesday.

To date, Africa's leading industrial power has only one nuclear power plant, the only one on the continent. But the Koeberg plant, near Cape Town, is only operating at half capac-

The government announced on Tuesday that it had launched discussions with "several potential suppliers" for the acquisition of new production units. These could be conventional reactors or small modular reactors, which are less powerful but also less costly.

Zizamele Mbambo, in charge of nuclear power at the Ministry of Energy, told a press conference that he hoped to see the first reactors in service by 2032-2033.

"An important milestone", stressed Electricity Minister Kgosientsho Ramokgopa, which should bring an additional 2,500 MW of electricity generation capacity.

The Company has more than 50 years of experience in maritime transport across Lakes Victoria, Tanganyika and Nyasa.

MSCL services across the three lakes serves as a linchpin for the communities along the lakes and provides intermodal connectivity for the Northern and Central Corridors as well as East and Central African countries bordering the lakes.

MSCL has a fleet of 17 vessels for both passenger and cargo transportation. Nine (9) of these vessels are deployed in Lake Victoria, 3 in Lake Tanganyika and 5 in Lake Nyasa.

The fleet is made up of 9 passenger-cargo vessels, 2 Oil Tankers, 3 Cargo vessels, 1 Tug, 2 self-propelled barges and 1 tourist boat. The Company has three branches: Mwanza, Kigoma and Kvela - Mbeva.

The projects were intended to construct the new MV Mwanza ship "Hapa Kazi Tu", with the capacity to carry 1,200 passengers and 400 tons of cargo in Lake Victoria which has now reached 92%, at a cost of more than 107 billion shillings and executed by GAS Entec, company.

Other projects include the repairing of MV Umoja which was laam Merchant Group at a cost carried out by SM SOLUTION of Shs.8,892,804,020.63. This CO. LTD from South Korea, and completed in September 2023. The ship was repaired at the cost of USD 8,422,840, equivalent to Shs.19,811,446,192.40.

MSCL has also repaired MT Sangara's petroleum ship at the

cost of Shs8.4 billion in Lake Tanganyika. The ship has the capacity of carrying 410,000 litres of oil and was repaired by KTMI Co. Ltd from South Korea.

The Contract for the Repair of MV Liemba in Lake Tanganyika was done by M/S Brodosplit JSC of Croatia in collaboration with M/S Dar es Salaam Merchant Group of Tanzania at the cost of US D \$13,192,850.00 (equivalent to Shs 32,982,125,000.00). This project will be implemented for a period of 24 months.

Meanwhile, the contract for the repairing of the MT Nyangumi in Lake Victoria will be implemented by M/S Dar es Saproject will be implemented for 10 months according to the con-

For the Cargo ship (Ro-Ro & Wagon Ferry) Construction Project in Lake Victoria tender, the project will be implemented by DEARSAN SHIPYARD Company of Turkey at the cost of \$58,171,706.00 (145bn/-). This project will be implemented for 24 months.

How the company's prospects are planning for the year 2024 and to what extent has MSCL sought to position itself well in the maritime transport

**A**:For the year 2024, we are planning to insist on administering the implementation and managing of all the Projects that we have entered in 2023 but also to strengthen ourselves in the transportation of cargo to East and Central African countries. In our Strategic Plan, MSCL expects to have at least 22 ships by 2026.

Q: What have been MSCL's

key projects in 2023?

On challenges, we've fewer ships that are currently working, only seven (7) ships working, including the cargo ship - MV Umoja which started trial voyages in October 2023. This number is too small for MSCL to be independent but also to contribute to transportation that will bring productivity to the national economy.

Q:You have recently entered into a pact with Dar es Salaam Merchant Group (DMG) to repair the MV Liemba, formerly Graf Goetzen or Graf von Goetzen, a passenger and cargo ferry that runs along the eastern shore of Lake Tanganyika as well as repairing MT. Ukerewe and renovation of MT Nyangumi which is the Marine Tug (MT) for carrying petroleum products operating in Lake Victoria. What should Tanzanians expect after the renovations of these ships?

A: People should get prepared to take advantage of commercial opportunities that will be generated through improvements in the Transportation Sector.

ii. Availability of employment opportunities that will be generated during the implementation

iii. The repair of the passenger and cargo ship MV Liemba will help to restore passenger and cargo transport services to the residents of the shores of Lake Tanganyika as well as the neighbouring countries of DRC, Burundi and Zambia.

# Chinese-built expressway helps cut carbon emissions in Nairobi

## **NAIROBI**

NAIROBI, the capital of Kenya, harbors the dream of becoming a green city, with the government and private developers ensuring that the projects they undertake are climate-smart.

From roads to buildings, the city is making great strides towards realizing the green dream, one project at a time.

Leading from the front in making Nairobi a friendly city to the environment are Chinese projects, with the Nairobi Expressway standing out not only as an architectural masterpiece but also as a monument in environmental conservation.

Linking the Mlolongo, south of Nairobi, and Westlands in the west, the Expressway takes care of the environment in a way never seen before in the East African

To begin with, flowers planted in pots spruce up sections of the 27-km thoroughfare, making it not only beautiful but also environmentally friendly. Then there are other plants like bougainvillea, and grass grown on the ground at different sections of the road to eliminate soil erosion.

Also, growing various plants in plastic trays beautifully supports the massive pillars that suspend sections of the road, a first in East Africa's biggest economy. These plants take in carbon dioxide emitted by vehicles and give out clean oxygen. "I like the idea of growing the


plants on the pillars. It is not only unique but shows how we can take care of the environment using simple ideas," said Christine Majali, an environmental enthu-Julia Ondeyo, a deputy director

at the Kenya National Highways Authority, said in a recent interview that the character of most of the engineering structures has been that they don't create a peaceful environment for people as they travel through.

The Nairobi Expressway infrastructure, according to her, has blended environmental aspects in its design, starting a novel way of building roads in Kenya.

"These plants are creating a carbon sink in the fight against climate change as they absorb carbon dioxide generated by the vehicles and clean the air," she said, adding that besides the flowers, more than 3,000 trees have been planted along the road.

The biggest environmental advantage of the Nairobi Expressway lies in the fact that it has cut travel time from two hours to 20 minutes along the key artery that is part of Kenya's Northern Corridor, linking the port of Mombasa

and the hinterlands.

More than 70,000 vehicles use the Nairobi Expressway daily, according to Moja Expressway Chief Executive Officer Steve Zhao.

These vehicles, the majority of them using fossil fuels, include saloon cars and commuter minibuses, commonly known as ma-

tatus in Kenya. While the saloon vehicles have a fuel capacity of about 40 liters, the minibuses have 70 liters.

"If I use the Expressway during peak hours in the morning and evening, the 70 liters I fuel lasts me slightly over a day. But if I use the lower road, it only lasts a day,"

said John Wafula, a matatu driver part of the efforts to protect the with Rembo Classic that plies the Nairobi-Kitengela route.

The reduced fuel consumption means a decline in carbon emissions from Kenva's public transport sector, one of the biggest contributors to greenhouse gas emissions in the country.

In a 2022 study on carbon emissions of greenhouse gases like carbon dioxide (CO2), nitrous oxide (N2O) and ozone (O3) on Nairobi roads in five years, four Kenyan scholars of the University of Nairobi -- Cynthia Sitati, Christopher Oludhe, Leah Oyake and Aderiana Mbandi -- found that matatus had emitted 6.89 million grams of carbon dioxide equivalent (gCO2e), light commercial vehicles 1.82 million gCO2e, heavy goods vehicles 251,683 gCO2e and motorcycles 181,054 gCO2e.

Private vehicles, according to the study, were the highest contributors to carbon emissions with a total of 25.3 gCO2e during the five years.

While matatus have found the Expressway a perfect road to aid them earn more and save on fuel, a majority of the 70,000 vehicles that use the road every day are private cars, therefore, cutting down on carbon emissions due

to reduced travel time. "Every motorist in Kenya should use the Expressway as

environment, the cash saved on fuel notwithstanding," said John Kariuki, a telecommunication engineer, who lives in Kitengela, south of Nairobi, and uses the road every day.

According to Moja Expressway, the Chinese firm that runs the toll road, if a motorist makes 10,000 trips on the Expressway and pays using the electronic option, they save about 314 liters of fuel.

"The Nairobi Expressway not only reduces travel time but also minimizes fuel consumption," the company notes.

Moja Expressway is also supporting other green initiatives targeting the road, as it recently joined hands with Kenyan matatu saccos Super Metro and Metro Trans, which launched a new direct route via the Expressway from Nairobi's central business district to the main airport, Jomo Kenyatta International, some 18 km away.

"In line with our drive towards a greener future, the new route will be covered using electric buses promoting sustainability by lowering carbon emissions and saving fuel," the firm said.

Kenya is committed to reducing greenhouse gas emissions by 32 percent by 2030, according to its climate change action plan.

# **COP28 President lauds** adoption of UAE Consensus

SULTAN bin Ahmed Al Jaber, Minister of Industry and Advanced Technology of the United Arab Emirates and COP28 President, lauded the success of the parties in delivering a comprehensive response to the Global Stocktake and all the other mandates, and finding a new way.

"We have travelled a long road together in a short amount of time. Over the last two weeks, we have worked very hard to secure a better future for our people and our planet. We should be proud of our historic achievement. And the United Arab Emirates, my country, is rightly proud of its role in helping you to move this forward," the COP28 President continued. "It is an enhanced, balanced, but, make no mistake, historic package to accelerate climate action. It is the UAE Consensus."

He added, "Many said this could not be done. But when I spoke to you at the very start of COP. I promised a different sort of COP. A COP that brought everyone together, private and public sectors, civil society and faith leaders, youth and indigenous peoples. Everyone

## China's marine economy continues to expand with diverse highlights

CHINA'S gross ocean product grew 5.8 percent year on year to 7.2 trillion yuan (\$1 trillion) in the first three quarters of 2023, indicating that the country's marine economy has maintained its positive overall

recovery momentum. The country's traditional marine industries have shown strong growth momentum. In the first three quarters of this year, China remained a global leader in terms of seagoing vessel market share, with new orders for seacraft growing faster and shipbuilding companies seeing continuous rebound in their economic benefits, according to Cui Xiaojian, deputy director of the National Marine Data and Information Service.

"New orders for seagoing vessels, seacraft output, and the number of sea ship orders in the hands of shipbuilders nationwide increased by 40.2 percent, 23.3 percent and 34.3 percent year on year, respectively," Cui said.

"In particular, there has been a significant increase in the number of high-tech and high value-added ships delivered during the period. And a batch of container vessels with a TEU (20-foot equivalent unit) capacity of 24,000, LNG dualfuel powered bulk carriers, and gas carriers were also delivered during the first three quarters," Cui added.

The country's marine tourism industry has strode into a new stage of full recovery, witnessing a 121 percent year-on-year growth in marine passenger volume in the first three quarters of this year, which has exceeded the level of the same period in 2019.

China's marine resource supply capacity has steadily improved. In the first three quarters of 2023, 1,219 projects of sea area and island use were approved nationThese projects involve combined investment totaling over 600 billion yuan. The country has made continuous efforts to increase its offshore oil and gas reserves and production. In the first three quarters of 2023, its offshore crude oil and natural gas production grew by 4.6 percent and 9.7 percent, respectively, compared to the same period last year, while multiple projects were completed and commenced production in the country.

wide, up 4.6 percent year on year. try's "blue granary" has been steadily advanced in the first three quarters of this year, when the growth rates of domestic marine aquatic products output and mariculture output both exceeded 5 percent year on year.

# 'Cannot have old wine in new bottles and expect new results'

**NEW YORK** 

REITERATING New Delhi's stand for the expansion of the multilateral institutions, India's permanent ambassador to the United Nations, Ruchira Kamboj said that multilateral institutions "rarely die", they simply "fade into irrelevance."

She was speaking at the Intergovernmental Negotiations on Security Council Reforms in New York on Wednesday.

Kamboj highlighted that this September, UNGA heard unequivocal calls for comprehensive and meaningful reforms from more than 85 global leaders.

"These calls must be answered. We must all realize that the clock is ticking, and turning the other way in the face of global challenges is just not an option, I have said this before Co-Chairs and I say so again, Multilateral institutions rarely die, they simply fade into irrelevance," she said.

The Indian envoy also cited the African Union's inclusion into the G20 during New Delhi's presidency making the group a more "representative" and relevant institution".

# UN official calls Gaza 'living hell' at Global Refugee Forum

**GENEVA** 

A top United Nations (UN) official told the 2023 Global Refugee Forum opened in Geneva on Wednesday that Gaza is now "a living hell," calling for an immediate humanitarian ceasefire.

Philippe Lazzarini, commissioner-general of the UN Relief and Works Agency for Palestine Refugees in the Near East (UN-RWA), flew to the forum directly from Gaza.

Most of Gaza's population has been forcibly displaced, he said, largely into the southern city of Rafah. The city has now swelled from 280,000 people to well over a million, and has therefore become "a tented community."

"Inside our own warehouses, families live in tiny spaces that are separated by blankets hung on thin wooden structures. Out in the open, flimsy shelters have emerged everywhere," Lazzarini said, adding that the spaces around UNRWA buildings are congested with shelters and desperate, hungry people.

"What can 100 trucks or so per day offer to 2.2 million people?" must roll out "meaningful" humanitarian assistance, he under-

"The high-level discussions about the number of trucks per day have taken up so much time and energy that I have no answer to a father of five in Rafah who asked me how he and his children can survive on one can of beans for three days," he said.

According to the UN official, the sight of a truck carrying humanitarian assistance now provokes chaos. Hungry people stop the truck and ask for food, and they eat it on the street. "I witnessed this firsthand when I entered into Gaza on Monday evening," Lazzarini said.

UNRWA is now sheltering more than a million people in its schools and other facilities, distributing whatever food it manages to bring in, "but this is often as little as a bottle of water and a can of tuna per day, per family, often numbering six or seven people." "I asked one colleague how he managed to remain composed and offer help in a shelter. He told me that he looks for a corner in the building to cry forum.

We are shaping our foreign policy agenda on our own, guided by our own priorities, while observing, I should emphasize, the recognized norms of international law and taking into account the interests of our partners who are ready to work with us based on mutual respect and consideration of [sovereign] interests," Lavrov stressed.

### China-Africa cooperation propels Africa's digital economy development, says WTO deputy director-general

IN recent years, amid a sluggish global economy, an increasing number of African nations have recognized the digital economy as a pivotal driver for their development, and China, with close connections with Africa, naturally emerges as a crucial partner in propelling the continent's digital economy and realizing its modernization aspirations, Deputy Director-General of the World Trade Organization (WTO) Zhang Xiangchen has

In the process of economic globalization, there exists an imbalance in the distribution of interests between the Global North and the Global South, Zhang said in a recent interview with Xinhua in Nairobi, the capital of Kenya, noting that developing countries, especially African nations, have reaped limited

Developing the digital economy is a crucial pathway to gaining advantages in international competition in the future, Zhang said. And developing countries, including those in Africa, should benefit from "re-globalization" distinguished by its emphasis on digitalization, he added. Africa has a vast market, a sound market environment and the youngest population globally, which, Zhang said, "are advantages for Africa to develop the digital economy."

However, research conducted by the WTO found that African countries have a relatively low share in global digital trade."Africa's slower pace in digitization primarily stems from the digital gap, including deficiencies in digital infrastructure, lack of knowledge and skills for digitalization and regulations,"

"If these issues can be addressed in African countries, I believe Africa will catch up in this field."He said that China's longstanding relationship with Africa holds significant value in terms of sharing development experiences.

In recent years, guided by mechanisms such as the Forum on China-Africa Cooperation and the Belt and Road Initiative, an increasing number of Chinese companies have continuously expanded their investments in Africa. In countries like Nigeria and Kenya, Chinese-funded enterprises have established mobile payment platforms, providing secure and convenient digital payment services to millions of users.

Additionally, Chinese e-commerce platforms enable many African people to sell distinctive products worldwide without leaving their homes. While the digital economy can be a country's competitive advantage, "the digital economy cannot entirely replace traditional industries such as manufacturing, especially for African countries that have not yet completed in-

The digital economy is one of the drivers for growth," he said. "While African countries develop the digital economy, they should also strengthen their manufacturing sector to achieve industrialization as soon as possible," he added.

# China, Vietnam deepen practical cooperation, benefit two peoples

CHINA and Vietnam are connected by mountains and rivers. They enjoy cultural proximity, cherish the same ideals, and have a shared future ahead of them.

In recent years, the two countries have brought out the full potential in their geographical proximity and complementarity of industries, and accelerated synergizing the Belt and Road Initiative (BRI) and the Two Corridors and One Economic Circle strategy, in a bid to better serve their respective national development and benefit the two peoples.

To the west of Kong Chro District, Gia Lai Province in south-central Vietnam, there stand dozens of huge wind turbines with their blades slowly rotating, providing steady electricity for local production and life.

These belong to a wind power project designed and constructed by China Energy Engineering Corporation (CEEC), which includes two wind farms. So far, all 64 wind turbines of the project have been erected with grid-connected power generation capacity, some of which have been put

According to Lin Lingli, deputy gen-

eral manager of the new energy division of Guangdong Electric Power Design Institute of CEEC, the project uses internationally advanced onshore wind turbines with large capacity and high towers, which have a large power generation capacity and occupy less land. Compared with coal-fired power plants of similar size, the wind power project can reduce carbon dioxide emissions by about 897,000 tons annually.

Driven by a series of policies and measures, a number of Chinese enterprises helped develop Vietnam's renewable energy power generation, contributing to the country's energy transition and development. Wind farms invested in or constructed by Chinese enterprises have provided Chinese solutions to alleviating power shortages in Vietnam, offering many families with green electricity.

Long Jiang Industrial Park in south Vietnam's Tien Giang Province enjoys prominent geographical advantages. It's only 50 kilometers away from Tan Son Nhat International Airport in Ho Chi Minh City and also 50 kilometers away from the container terminal of the Saigon Port. A hectic scene could

The industrial park has received strong support from both Chinese and Viet-

According to statistics, the industrial output value of the park accounts for over 35 percent of the annual industrial output value of Tien Giang Province, and over 45 percent of the

province's foreign trade volume. The industrial park has created more than 30,000 jobs for Tien Giang Province and neighboring provinces, significantly improving the life quality of local people.

Deputy general director of the industrial park Tang Zhenyu said that expanding employment is one of the most direct and sustainable ways to improve the life quality of local peo-

"We will step up efforts to attract outstanding companies in various fields to the park, providing more job opportunities for young people in Vietnam and making them the main force driving local economic development," Tang said.

Early in the morning of Dec. 7, many students were seen in the carriages of a train on the Cat Linh-Ha Dong metro line in Hanoi. These students, on their way to school, told People's Daily that

# **Turkey referee punch:** Turkish FA says referee is not going to quit

Ankaragucu president Faruk Koca was arrested on Tuesday after he ran on to the pitch and struck Meler following Monday's 1-1 draw with Cavkur Rizespor.

All leagues were suspended but the TFF say they will resume on 19 December.

Meler was released from hospital on Wednesday with a swollen eye.

The 37-year-old is one of Turkey's top referees and officiates international games for Fifa.

He is also on Uefa's elite referee list and Buyukeksi said in a news conference on Wednesday that he still expects Meler to officiate at Euro 2024 in

"We expect Halil Umut Meler to take part in Euro 2024. There is no possibility of him quitting refereeing right now," said Buyukeksi.

Turkish football bosses suspended all leagues following the incident but Buyukeksi added: "We had decided to postpone the matches in all leagues indefinitely. With the decision we took today, all leagues will restart on Tuesday, December

Buyukeksi said the football federation's disciplinary committee would "do what is necessary and announce its decision on Thursday".

"There is never any room for violence in the game. What happened in the match is in no way acceptable," he said.

"We will show zero tolerance for any similar incident on or off the field, and we will not tolerate any action against our referees and the refereeing

This week's postponed games will be played on 10 January.

After Koca punched Meler to the ground, he received several blows from others as he lay on the turf, and suffered injuries including a minor fracture.

# PSG, Porto into Champions League last 16 as Newcastle exit

ARIS Saint-Germain and Porto qualified for the Champions League last 16 on Wednesday as Newcastle bowed out of Europe after losing 2-1 at home to AC Milan.

PSG drew 1-1 away to Group F winners Borussia Dortmund to go through as runners-up after Milan came from behind to beat Newcastle at St James' Park and eliminate Eddie Howe's side.

Newcastle, who needed to win and for PSG to drop points to keep their first Champions League campaign in 20 years alive, took the lead through a brilliant Joelinton strike in the first half.

By the final whistle they were out of Europe completely and could have conceded three or four goals to an AC Milan side who consigned them to last place in their group. Football can be cruel.
