# Reforms: Samia asks for patience, key stakeholders root for urgency

PRESIDENT Samia Suluhu Hassan yesterday appealed to Tanzanians to be patient as they await a final report by the taskforce coordinating views on legal reforms to broaden democratic space in the country.

In an article released by the Presidential Communications directorate yesterday for the International Day of Democracy, the Head of State acknowledged that political parties have been agitating for freedom to conduct political activities including public rallies and free engagement with their members.

The taskforce has since indicated that parties can continue with political rallies but expressed reservations with regards to existing legal provisions for such activities.

"Therefore, in that context, I advise that we wait for opinions and recommendation of the taskforce on legal reforms," the article affirmed, promising a statement on the matter soon.

At an activisti forum, democracy stakeholders called on the taskforce coordinating the collecting of views on the new constitution to speed up the work to enable progress in drafting a new mother

Some participants at an event to mark the International Day of Democracy in Dar es Salaam accused the team appointed by the Registrar of Political Parties, Judge Francis Mutungi, of delaying the work.

# Grain surplus in vast decline in 2021/2022

Prices on the rise, no supply shortage yet, minister says

THE government has attributed increasing prices of food staples in the country to little rains in the outgoing farming season but insists the country is not experiencing any food shortage yet.

Dr Ashatu Kijaji, the Investment, Industry and Trade minister, told reporters in Dar es Salaam yesterday that poor rains led to low food production in many parts of the country, leading to an increase in prices of rice, beans

and maize.

The lowly situation in food crops should not crowd out increases in the production of building materials like cement, iron sheets and iron bars, she said.

Maize output for the year 2020/2021 stood at 7,039,064 tonnes while demand stood at 5,978,257 tonnes, implying a 1,060,807 tonnes surplus. In 2021/2022 production dropped by 7.1 percent to 6,537,203 tonnes, with demand rising by 0.9 percent to

THE National Assembly yesterday demanded that the government take immediate steps to contain a wave of ongoing crime in major urban areas tied up with teenage gangs terrorizing the streets, nicknamed 'panya road.'

Speaker Dr Tulia Ackson issued this demand during the morning question and answer session after two MPs moved a motion, under section 54 (1) of the standing orders, to seek the Speaker's ruling on their proposal for the House to shelve other business and discuss the criminality situation as an emergency.

Segerea MP Bona Kamoli and Bahati Ndingo (Special Seats) sought for the Speaker's directive on the matter, pointing out that the situation has claimed lives and placed safety on a shoestring for thousands of urban dwellers, including MPs.

The city suburb legislator said the situation has affected people of all walks of life, "Therefore I am requesting the National Assembly to shelve


# Govt, WFP reach accord over school feeding plans

SCHOOL feeding programmes will get a new impetus on the basis of a new five-year country strategic plan which started two months ago.

Sarah Gordon-Gibson, the country director for the World Food Programme (WFP) made this affirmation at the signing ceremony where the government to join the school meals coalition, set up during the 2021 UN Food Systems Summit.

Applauding the government for joining the coalition, she said that in the past the UN agency supported the school feeding programme for years and recognizes the importance of the programme.



Activist organisations have in the past few years worked to ensure that every child has the opportunity to grow, learn and thrive, bringing a group of WFP member states and partners to form the coalition.

The director commended the government for adopting the national guidelines on school feeding and nutrition services to basic education level pupils, embedded in signing into the International School Meals Coalition, an initiative aimed at providing school meals in a gradual manner.

The pact requires that nutritious food be available to all school children everywhere by 2030, with 67 countries signing up along with 68 partner organisations. After 26 countries ratified the agreement, Tanzania becomes the 27th country to actually agree to start implementing the pact, and thus obliged to broaden availability of government funds for the school meals programme.

The programme is led by founding member states and supported by a secretariat supported by the UN agency, aiming to assist governments and their

direct the government to address the matter with urgency and the heaviness that is required because this involves the security of our people and their properties," she elaborated.

On Wednesday, a University of Dar es Salaam second year student at the School of Journalism and Mass Communications, Maria Basso Paschal was killed by a gang of criminals during a home invasion.

The marauders, estimated at more than 10 young delinquents, invaded Kawe neighborhood in the city armed with machetes, raiding homes randomly and robbing people of their valuables.

When they reached Maria's residence, they forced their way into the 15-room house, knocking down doors. They injured three people and killed the 24-year-old student.

United Front (CUF) said that it is a temporary taskforce with specific terms of reference but it acts as a permanent body.

"They should not take this open door to democracy for granted," he said, noting that no political party has the sole right to lead the country.

Earlier in March, the 25-man team chaired by Prof Rwekaza Mukandala, former vice chancellor for the University of Dar es Salaam, recommended in the preliminary report that the process of obtaining a new constitution stars after the 2025 general election.

President Samia Suluhu Hassan instructed the team to work on the preliminary process of collecting ideas and submit proposals.

Legislator Neema Lugangira (Special Seats) said the new law is important to resolve critical issues such as gender inequality in decision-making organs.

"There is very low representation of women from local authorities to national organs. In the National Assembly for instance, women make up only 9.1 per cent of elected MPs,"

"To change this, the new law must clearly stipulate candidate quotas to ensure that a certain percentage is reserved for women."

Prof. Kitila Mkumbo, the Ubungo MP, said that when it comes to leading the country within the multiparty context, the key issue is the party's survival potential in governing the country.

"Much strength has to be invested in the survival of political parties to be able to walk in tandem with the needs of the people. It is time we stop pointing fingers at the ruling party and invest more on building a trusted party," he declared.

Fr. Dr. Charles Kitima, general secretary of the Tanzania Episcopal Conference (TEC) said the multiparty system in the country seems to favor a few and undermine the weak. Democracy awareness should provide a healthier political environment, he

"For so long democracy stakeholders have been advocating a multiparty system in Tanzania. It's not new. Despite the platform, it's only a few parties that are favored which I think has reached a point where we need to break the narrative towards real political pluralism`," he stated.

Dialogue on the International Day of Democracy sought to deliberate on the 30 years of the multiparty system in Tanzania and how to strengthen democratic resilience in the face of current challenges.

# UUVL ASSUICS farmers on availability of quality seeds

THE government has assured farmers that there will be steady availability of quality seeds despite drought challenges facing some parts of the country.

Deputy Permanent Secretary in the Ministry of Agriculture, Gerald Mweli said this on Wednesday here while briefing reporters during his visit at the farm owned by Agricultural Seeds Agency (ASA) at Msimba in Kilosa District and the Kilangali rice farm.

Mweli said the government through ASA has been producing enough quality seeds which are distributed to farmers countrywide at affordable

He said apart from the drought impacting the farming season in some areas, ASA warehouses have adequate stocks of quality seeds.

"I assure farmers that there are sufficient stocks of seeds for maize, sunflower, sorghum and many other crops which will be sold to them at affordable prices," said Mweli.

However, he stressed on farmers to register their names to village executives in order to get government subsidized fertiliser.

He called on all officials starting at village level to educate farmers to make sure they are registered to get the

subsidized fertiliser. The deputy PS also called on fertiliser dealers to sell the farm input as per the

fertiliser and has already been distributed to all dealers who had entered into contracts with the government.

ASA chief executive officer, Dr Sophia Kashenge said ASA has ample seeds stocks which they have started distributing to all regions.

She said all the seeds have been certified by Tanzania Official Seed Certification Institute (TOSCI).

Dr Kashenge further said during this season ASA expects to begin production of quality rice seeds at its Kilangali farm.

She said in the past two seasons the farm used to produce 400 to 500 tonnes of rice seeds per year, but after the completion of its irrigation infrastructures, the anticipation is to produce 1,490 tonnes per season, more than three times what they used to produce previously.

6,034,943 tonnes, with the maize surplus dropping 56.6 percent to 502,260 tonnes.

Rice production in 2020/21 season stood at 2,686,829 tonnes while demand was pegged at 1,095,743 tonnes, thus a net surplus of 1,591,089 tonnes, she stated, highlighting that in the 2021/2022 farming season the rice harvest dropped by 30.9 percent to 1,856,731 tonnes. Demand inched up

declined by 50.3 percent to 791,198

In the year 2021/2022 the production of rice dropped by 11.1 percent to 1,269,487 tonnes with demand peaking at 488,753 tonnes, thus a fall in the surplus to 780,734 tonnes, she said.

Cement production during 2021/2022 rose by 0.5 percent to 6,531,000 tonnes from 6,496,000 increased by 4.7 percent to 291,000 to 1,065,534 tonnes, while the surplus tonnes from 278,000 the previous year. of its output and foreign trade data.

The production of iron sheets increased by 5.6 percent to 114,000 tonnes from 108,000 tonnes in the previous year, she further noted

# Tarura enters into 92 agreements for road construction in Mbeya Region

TANZANIA Rural Roads Agency (TARURA) in Mbeya Region has signed 92 agreements with various contractors valued at 20.5bn/- for road construction in all seven districts of the region during FY 2022/23.

Mbeya TARURA Manager, Wilson Charles signed the agreement on Wednesday this week with the contractors saying the funds for the projects have come from various sources.

He named the sources as including Tanzania Road Fund (TRF), Constituency Fund, levies on petrol and diesel and appeals from other various sources

He said the contracts signed are part of all contracts, adding that the signing of other contracts was witnessed by President Samia Suluhu Hassan.

"All these projects will be implemented in all districts of our region, we are making sure the projects will be implemented according to the required standard, as they aim to boost road infrastructures in our region," he added.

Mbeya Regional Commissioner, Juma Homera called on the contractors who signed to make sure they abide by

the periods of the contracts to avoid legal steps for those who will fail to complete them in time.

He said once the time for the contract elapses there will be no additional time, hence they should do the work day and night.

He called on the contractors to do the job in adherence to the listed work standards according to the money

He also called on them to report to local officials in their project areas in order to be accorded with collaboration for smooth implementation of these projects.

Some of the contractors who signed their contracts thanked the government for trusting them and pledged to implement the work according to the required standards.

One of them, Esther Msiu, who is the chairperson of the women group that was awarded a tender, said earlier the government used to trust foreign contractors, but now it has also started to trust local ones.

She said in order to encourage the government to continue trusting them; they will make sure they will do the work by adhering to implementation procedures and guidelines provided.

# Activists appeal for amendment of Section 197 of the Penal Code

HUMAN rights activists have suggested the need for the government to amend Section 197 of the Penal Code of Tanzania (Chapter 16) and thus abolish the mandatory imposition of the death penalty.

They made the call in Dar es Salaam recently at a dialogue to share insights and best practices in East Africa on death penalty convened by the East Africa Law Society, REPRIEVE UK and the Pan African Legal Empowerment Initiatives (PALEI).

They tasked the government to overhaul the whole Tanzania criminal justice system inclusive of the amendment of section 197 of the Penal Code.

Section 197 of the Penal Code reads: 'any person convicted of murder shall be sentenced

This provision requires the Judge to sentence the accused convicted of murder to death without any other option. In fact, this provision negates the discretionary power of the Judge to consider the circumstances of the offender and the offence, and to determine whether the offence is one of the worst of its kind, warranting imposition of the death sentence.

PALEI chief executive officer William Kivuyo said: "As long as section 197 remains, it will be difficult for judges to impose different sentences considering the circumstances under which the offence of murder is committed."

Retired Justice Engera Kileo called upon the need for Tanzania to review penal policy adding that even in places where people are sentenced to life imprisonment unlike other sentences, there is remission.

"There is a need to review our penal policies, even life imprisonment could be certain number of years, and can get remission. A life sentence is better than the death penalty, as there is at least hope that one may come out one day, but upon conviction of death penalty, one has no hope for life," said the retired Justice.

Retired Justice Kileo is one of the few bold Judges who while in office issued some dissenting opinions in regard to death penalty thus setting precedent.

In one of the hearings on a case of Sadiki Mkindi Vs. the Director of Public Prosecution the retired Justice was quoted as saying "as for the sentence of death imposed on the appellant, I would not however endorse it because I am of the settled mind that it is unconstitutional."

She said: "Another aspect of the death penalty which concerns me is the fact that this is the only penalty where we do to the culprit according to what he did an eye for an eye. In my humble opinion we are reducing ourselves to the level of the accused."

This is not the first time that the government has been called to review the said provision as in 2019, the African Court called upon Tanzania to amend section 197 of the Penal code, on account that it was a violation of article 4 of the African Charter on Human and People's Rights. In a celebrated case of Ally Rajabu, Others Vs.

# TCRA: Tanzania firmly on track on financial inclusion

TANZANIA is firmly on course towards financial inclusion, with the number of users of mobile money services increasing remarkably between March and June 2022, according to a recent report issued by the Tanzania Communications Regulatory Authority (TCRA).

The June 2022 telecommunications, broadcasting and postal statistics by TCRA paint a rosy picture on access, usage and applications.

The number of mobile money accounts, transactions and the value of the transactions have increased significantly. It is estimated that more than one-third (41 per cent) of Tanzanians use mobile money

The statistics show that some 37.4 million mobile money accounts were active in Tanzania by June 2022. They made a total of 343.6 million transactions; with a value of about 11.6 trillion shillings. The transactions include sending and receiving money and paying for services and utilities.

The report shows that in the quarter period from March, 2022 to June 2022, the number of accounts increased from 36,749,298 to 37,407,233.

The number of transactions in the same period also rose from 30,148,997 to 343.639,879. Value of transaction also increased from 10,703,041,422,029 to 11,608,009,983,537

The statistics show the trend in data usage and tariffs; with bundled and unbundled data services being the cheapest compared to voice and short messages (SMS).

Date tariffs are determined in megabytes, or MBS. One unbundled MB was sold for 8/-) compared to 32/for voice calls on the user's network (on-net) and another network (offnet). Local SMS were charged eleven shillings. One minute of voice is more expensive than a unit of SMS and data.

International calls continued to cost more than in the previous quarter

(March 2022). One minute was 1,888/compared to 1,601/-, an 18 per cent increase.

Calling neighbouring countries (East Africa) cost 1,151/- a minute; It was slightly higher than in the previous quarter when it cost 960/-.

The statistics show that people talk and send SMS across networks (off-net) than within their networks (on-net), dispelling the belief that more calls, hence minutes, were made within networks.

The belief that people talk more within networks because of cheaper rates has been dispelled. The choice of SIM cards does not necessarily depend on the price of service within or across a network. They are now the same; partly thanks to the current interconnection rate. Consumers now opt for quality of services.

The statistics show that by June 2022, there were 56.2 million active SIM cards; of which 52 per cent are online. The number of registered SIM cards increased by two (2) per cent; from 55.4 million in March 2022 to 56.2 million in June. Telecom and internet penetration - the proportion of subscriptions compared to a country's population - stood at 92 and 48 per cent respectively.

The June 2022 statistics have a breakdown of SIM card registration by regions; with an overall average subscription of 1.9m/- per region.

In the postal sector, the statistics show that despite major advances in electronic communications, postal and courier communication still has a share in communications. Averages of 783 domestic items are posted daily. Internationally, 144 and 1,216 are posted daily to East African countries (EAs) and the Rest of the world (RoW) respectively.

TCRA collects communications statistics from all Communications Service Providers (CSPs); namely, telecommunications, internet, mobile money, broadcasting the national postal operator and courier companies.

CITIZENS have been urged to reveal violence acts done against women and children in order to enable relevant authorities to take immediate required measures so as to eradicate the evil incidents in the country.

Speaking yesterday during the 9th Muhimbili University of Health and Allied Science (MUHAS) Wide Dissemination Symposium "Themed Addressing Violence and Mental Health Challenges in Tanzania; role of Research and Multisector Engagement" Commissioner for Social Welfare from the Ministry of Community Development, Gender, Women and Special Groups, Dr Nandera Mhando said that citizens need to support the fight by unearthing and reporting the incidents.

"Violence against women and children remains a big challenge in the country, and if you look at statistics more than 70 percent of those subjected to such acts are women, so concerted efforts are needed to fight this problem," she said.

She raised concern on the increase

### Act on cases of violence against women and children, public told the government and stakeholders so as giving to journalists so that they help in

to address it.

Dr Nandera noted that violence against children is implemented by close family members, something which affects the development of the children.

"Unfortunately most of the perpetrators do not face the law due to lack of sufficient evidence from families, neighbors, friends and siblings mostly because they are afraid of how the society and community is going to view them going forward which is not right," she noted.

She said: "Along with the government's efforts to increase community awareness on preventing and reporting incidents of violence, citizens have not yet reported these incidents for fear of being isolated from their communities and thus making such acts flourish in some areas in the country."

She further noted that violence of violence cases saying that the actions are widely reported due to situation needed collective efforts of the education that welfare officers are

exposing these actions.

"I call upon different stakeholders to work with our gender desk in giving education to more journalists so that they can be able to report these incidents in respective areas," he said.

Senior researcher at MUHAS, Dr Jessie Mbwambo said that mental health and violence has a significant impact on the national economy, maternal, and child health and to address such complex challenges need evidence based and informed policies.

She further noted that mental health and violence are intertwined and has remained one of the important research agenda for MUHAS.

"MUHAS has a role to play in addressing this burden through one of its strengths which is research," she

The effort aims to address the growing burden of violence in Tanzania that could partly be attributed to a growing burden of mental health challenges, she noted.

### **Mpango inaugurates** bus terminal, truck parking in Mwanza

VICE President Dr Philip Mpango has inaugurated a bus terminal and truck parking in Nyamhongolo area of Ilemela Municipality in Mwanza Region worth 26.6bn/-.

Speaking soon after launching the two facilities on Wednesday, Dr Mpango asked the Mwanza Regional authorities to provide the business cages allocated at the terminal without bias.

The VP asked the Mwanza Regional Commissioner to ensure that there is transparency in the procedure that will be used to distribute the cages considering specific groups of the disabled, youth and women.

Dr Mpango instructed all citizens to ensure that they protect the infrastructure of the centre including water, electricity, and toilets.

He also asked the leadership of Ilemela Municipality to put in place measures to deal with disasters such as fire, first aid and proper waste management including equipment and technology suitable for waste collection and management.

The Vice President said that the Sixth Phase government continues to provide priority for strengthening transportation infrastructure in the Lake Zone region through the implementation of various projects.

He stated that Mwanza is a strategic region and the government leaders must ensure progress is achieved.

Dr Mpango criticized the construction of fuel stations for not following the established procedure including 500 meters after each station.

He asked the building permit issuers to comply with laws and regulations in order to avoid disaster that may occur to citizens in the event of an emergency.

Innocent Bashungwa, the Minister of State in the President's Office (Regional Administration and Local Governments) said the government expects to send 28.8bn/- to Ilemela Municipality to improve Mwanza city

through tactical projects aimed to beautify the cities. Bashungwa explained that the project will build a central kirumba market along with the roads that surround the market with 2.9 kilometers which together will cost a total of 12.7bn/-. He added that the project will involve construction of the Buswelu-Busenga-Coca-Cola Road with a length of 3.3 kilometers at tarmac level that will cost 4.6bn/- and Buswelu-Nyamadoke - Nyamhongolo road of 9.5 kilometers which will cost 11.5bn/-.

Ilemela district executive director Eng Modest Apolinary said that the projects are aimed at increasing income for the municipality, attracting investment as well as increasing the number of traders within the municipality.

He added that the project is expected to improve the transport environment and transportation of passengers and cargo as well as increased employment opportunities where it is estimated that 1300 different jobs will be available.

percent annually. Of the total avocado production, around 65 percent was absorbed by the domestic market, 14 percent was consumed on- farm, including six percent waste and only 21 percent was exported mainly to the European Union market.

Prominent avocado producing areas in the country are the regions of Mbeya, Njombe, Songwe and Iringa in the southwest, as well as in Kilimanjaro, Arusha and Tanga in the northeast of the country. The other regions are Kigoma and Kagera in the northwest and Morogoro in the east of Tanzania.

### Govt advises MIGA to increase support to key sectors in Africa

FINANCE and Planning minister Dr Mwigulu Nchemba has requested the Multilateral Investment Guarantee Agency (MIGA) to strengthen their engagements and support to Africa so as to support development of key priority sectors.

Dr Nchemba was speaking in Dar es Salaam on Wednesday during the opening of a two-day African Investment Dialogue.

He said that the dialogue comes at the right time where Africa is at a critical development juncture in the sense that it seeks to accelerate economic growth to meet national development goals in line with the sustainable goals (SDGs) and the African Union's Agenda 2063 during these challenging times.

He said active engagement will drive Africa's recovery and build resilience from unforeseen shocks.

"It is therefore important for our countries to discuss a topic that is critical in driving sustainable recovery in the African continent. Africa's economy, still reeling from the pandemic and the war in Ukraine, is facing an increasingly gloomy and uncertain outlook with risks tilting on the downside."

According to Nchemba, the Ukraine war has complicated domestic resource mobilization in African countries, already worsened by the COVID-19 pandemic and the increased frequency of natural disasters in the context of climate change.

He further said that in the midst of rising and unsustainable debt levels, African countries are being forced to reduce their fiscal space at a time when they should be increasing it. Thus, the role of international investment in complementing domestic public investment is now of paramount importance.

Nchemba said that international trade and foreign investment are important recipes for economic growth and development. "I believe we can jointly agree that foreign direct investment is among the significant external sources of capital inflows.

Together they serve as an important vehicle for transferring of financial resources, technology, management know-how, job creation, and access to new markets," he explained.

Dr Nchemba noted that countries that are open to international trade tend to grow faster, be innovative and improve productivity which provides higher income and more opportunities to their people.

"Open trade also benefits lower income households by offering consumers more affordable goods and services. Integrating with the world economy through trade and global value chains helps drive economic growth and reduce poverty.

Global flows of FDI are seen to recover following the myriad negative shocks triggered in 2020 by the COVID-19 pandemic. Global trade is also seen to recover strongly by 26.6 percent after contradicting by 7.5 per cent in the previous year.

The ongoing war in Ukraine on top of the pandemic effects is resulting in triple pressures in food, fuel and finance to most countries.

### **Technology solutions on water** scarcity not vital just for Z'bar

ANZIBAR authorities and experts from across Africa have been attending a two-day water conference in Zanzibar on ways to sustain the management of groundwater resources in a changing climate scenario.

Researchers in the management of water resources from several African countries have been deliberating on the issue as experienced and addressed in many countries.

Zanzibar President Dr Hussein Ali Mwinyi has fittingly graced the event and found occasion to point that even developed countries face such problems, requiring the designing of workable and effective solutions.

The Zanzibar authorities were engaged in a brainstorming session with researchers in the water sector to find ways of ensuring the reliable supply of clean and safe water in the wake of climate change effects.

One of the proposals discussed was the use of technology to 'transform' hard water into soft water, which the authorities recognise as a challenge for the long run.

The more realistic position was that reliance on ground sourced water in Africa will be the way to go for years to come, thus requiring practicable conservation techniques and stop-gap measures to forestall intense shortages later.

Meeting sources said that there were 57 abstracts from the scientific researchers present, with vital insights to share the water for all sorts of domestic and industrial uses, as well as public and private claims to water flows.

But there was an air of pessimism as data from the European Environment Agency indicated that some 20 per cent of Africa's land is under threat of water shortages, with Europe more at ease in relation to water supply owing in part to its temperate climate.

While governments and development are realising the urgency of the need for funds to steer alternative approaches in enabling people to access water at the

Just as applies elsewhere in Africa, Zanzibar relies heavily on underground sourced water including from bore holes, natural springs and drilled wells.

Replenishing these sources with predictable and adequate rains is proving increasingly unassured, and hence the need for even bigger funds with which to adopt better technologies for conservation, enabling greater precipitation, etc.

Combating tghe effects of climate change requires not just conservation of water that exists underground but also making it better for supply of the precious liquid to increase, which means making the planting of trees a large-scale and endless activity.

Even as experts point out the impact of expanding agro-based activities on remaining woodlands and in forest reserves, we must admit that there are millions of hectares of territory that need replanting with trees and other vegetation.

Clearly, that can't be done to satisfaction by local government orders and corporate social responsibility alone; it needs a World Bank-kind of expansive and well-supported initiative.

That is why international development cooperation agencies taking part in the Zanzibar conference and likely to take up that subject not only with their hosts for this week but with other governments as well need to brainstorm on their own to find means of executing a global tree planting campaign.

There is similarly the need to evaluate performance in terms of hundreds of thousands of square kilometres of land planted with trees each year, with assured supply of water for the seedlings.

That could mean sparing existing resources for pumping up water, accessing pumps and hiring part-timers to water seedlings across ranges of

Continuing merely to protect existing forest patches would evidently be unrealistic as those zones are under the same population pressures which have right time and at affordable cost, 'big long led to global deforestation.

# Brazilian journalist: 'Brazilian president puts our model of journalism to the test'

RAZILIAN journalist Sérgio Dávila is leader of what is widely regarded as the most respected and feared newspaper in South America generally and Brazil in particular, Folha de Sao

With his country's upcoming (October 2) elections, he faces a great challenge for the country and for his newspaper.

So in just three weeks, after the elections, Dávila will know whether the newspaper where he grew up as a journalist and which he now edits. will have to deal with Jair Messias Bolsonaro, a leader with serious antidemocratic leanings, or with Lula da Silva, whose return could further agitate a country in constant turmoil.

The two presidential candidates, representatives of this global era of extreme polarisation, are well aware of Folha de Sao Paulo's onslaught.

### Question to Dávila: How do you cover such a decisive election?

The challenge for us is always to be non-partisan. Folha's editorial principles are independence, impartiality and critical journalism. But we don't want to treat different candidates as equals either. There are two main candidates, Jair Bolsonaro and Lula da Silva, but the former stands out for constantly attacking democracy and the Brazilian electoral system itself, so we have to provide extremely critical coverage based on facts. This does not mean that we are going to do friendly coverage of the other candidates, such as Lula. No. We will do a very critical coverage of everyone.

### Folha de Sao Paulo stood out in the early 1980s for its defence of democratic restoration. Now you are very critical of the Bolsonaro government. Are the two eras comparable?

The role of journalism is fundamental in both moments, which are historical but also different. Before there was a country under a dictatorship and now we have a democracy. In the 1980s the newspaper gave a voice to people who fought against the dictatorship, while now there are many voices that can express themselves freely.

There have been direct online attacks by the president of Brazil on one of your journalists and also online persecution of other editors. How do you protect your professionals?

This president is very combative with journalists, especially if they

### journalism) training cover?

It teaches techniques to be safe important. After two years of the Covid-19 pandemic, we had to be concerned about mental health and we expanded that initiative because of the exposure of our journalists on social media. We also hired a psychologist to listen to our professionals. Any editor can book an appointment and talk about what she or he needs. The (lady expert) consults Monday to Friday all afternoon and has no more time for the next two months. She is doing a great job. It is very important to deal with mental health professionals.

Former US President Donald Trump cancelled subscriptions to The New York Times as soon as he came to the White House and Bolsonaro announced the same decision about Folha de Sao Paulo when he came to power in Brazil. How do you see this parallel?

We refuse to do that. I think the Bolsonaro presidency tests our model of journalism. It is easier to be The New York Times, which is a partisan newspaper positioned in favour of the Democratic Party than to be Folha, which is a newspaper critical of all the candidates. We were very critical of Lula's presidency and published big exclusives. Now we are doing the same with Bolsonaro. But opinion is plural. This principle cannot be put aside because to do so would be **to give up** 

Decades ago, your company in the social environment. It is very **took on the major challenge** distributing the newspaper throughout Brazil, with more than 1,300,000 copies sold on Sundays. How do you work on the presence of your medium in society when the physical product is falling?

> These numbers are very important, but the digital ones have an enormous dimension. The Internet has 120 million users in Brazil and Folha reaches 30 million of them. We also have 360,000 digital subscribers, a big number for the Brazilian reality. The positive side is that Brazil is a continental country, so getting the print edition to every corner is very expensive. Also, we have many readers in Portugal or the United States who no longer depend on the print edition. We are not in the business of printing pages, but in the business of producing content according to professional journalistic principles. That is our job.

### What challenges do you face in the digital environment?

Our challenge is for Folha to make the best possible transition from print to digital, maintaining its great influence in the Brazilian public debate. Very modestly, I think we are achieving this. We were the first to have a digital subscription model in Brazil and we stand out for being pioneers in big digital bets.

### To what extent does the digital subscription strategy set the newsroom on its path?

Having large revenues from subscribers makes you less dependent on the moods of the market - on the economic situation or advertisers. In the end, the subscription makes you even more independent.

### Years ago you left Facebook because the platform changed its rules unilaterally. What is your current relationship with the platforms?

We were the first to leave Facebook because they changed the algorithm in a way that was detrimental to group, which includes ABC.

professional journalism. Years later, when they changed it again, we came back. Our line of argument with the platforms was always that they should pay for content that helps drive their business model. This is because what we produce, the product of professional journalism, is what drives social media businesses. Kitten videos have their limit....

### To tackle the digital challenge, you will place a lot of importance on training and the selection of new journalists...Right?

It is absolutely key. We subsidise courses that journalists want to do and we always promote specific seminars. We are also very rigorous in the recruitment process. We have a job bank and three or four very demanding professionals examine each candidate. We focus on diversity.

### Why did you decide three years ago to bring in a diversity editor?

Brazilian society is incredibly diverse and tremendously unequal. We wanted to respond to this problem with an ambitious programme and we were pioneers in creating the position. The main mission of this editor is to ensure a diversified vision, which affects the hires we make, but also our content, our interviewees, our sources and even our readers, as we want them to better represent the Brazilian plurality. The editor has very broad responsibility and has the capacity to act horizontally throughout the company. We have data that show that our audience has diversified and that this is already working. We also have the highest percentage of black journalists ever at Folha.

### Do you think this is a good time to be a journalist?

Yes, I think it is. Journalism is more fundamental now than ever - because of everything we are going through, because of the polarisation, because of the attacks on democracy and because of the attacks on journalism itself. If I were a young student today, I would choose journalism again. It may sound very funny, but an old Folha columnist used to say that after World War III only cockroaches and journalists would remain in the world. I say journalists will tell the story of the cockroaches.

### New highway safety features could be pursued with the utmost urgency

optimism for highway road users at midweek following news that the government was launching a US\$500m (over 1bn/-) road assessment project to identify weaknesses on highways and upgrade safety features, chiefly with a view to curbing road carnage in the country.

The optimism arose from the introduction of the Tanzania Road Safety Assessment Programme (TanRAP), which stems from the United Nations road safety collaboration project backed by the United Nations Economic Commission for Africa (UNECA). This translates into a new Africa-wide project meant to help sort out road carnage.

According to a technical presentation, this is a ten-step plan designed to protect road users from road crashes via

deliverables constituting the approach. The technique is admittedly a bit detailed, but we have local examples of elaborate service roads, at times having a roundabout facility to ease the burden

borne by main roads. Distinct trouble spots have different improvement approaches that are best applicable, with the ready option of separating the major lanes at specific spots. Where the danger is low, service roads may suffice.

There are several highway spots where occurrence of accidents is notoriously frequent, apart from city intersections that are quite often problematic.

At times it is driver error or negligence like ignoring traffic lights owing to speeding, which is simply unacceptable.

Technical solutions are often pursued because it is impossible to eradicate true human error, nor indeed map out its frequency, but diminishing chances of

fatalities is attainable. Experts talk of having vehicles installed

HERE were reason for with software to check the country's highways and determine safety levels along existing roads and proposed road upgrades.

If information collected could be used in road designing and upgrading to reduce or tame crashes and fatalities, that would be the best-case scenario. The total bill underlined so far is upwards of 1bn/-, but no amount it too high if we are to stop road crashes that claim the lives of thousands of people annually with a lot more people maimed.

While this pursuit of technological solutions could make a difference in highway travel, it is harder to think of a similar approach to forestall accidents involving speeding motorcycles, especially with youths ride them.

The younger the riders are, the more they appear to relish motorised recklessness - which commonly leads to deaths and costly amputations in hospitals. The crucial input there is safety helmets, but regulatory authorities also need to serioulsy consider the state opf

roads, just to be on the safe side. Placid Badji, a UNECA official, has aptly noted that safer road systems "should not only be forgiving of human errors but also responsive to the needs of road

The idea that by 2030 all new roads need to have achieved technical standards for all road users that take into account roads meeting a three-star rating or better is vital, but further improvement would come in handy.

With highways the problem is lorries, buses or cars in mixed-crash scenarios. This view seems to encompass all that the UNECA project sees, while safety measures are needed on narrow roads where motorcycle crashes reign. Debate and action on this should continue



fter a quarter century of economic stagna-⊾tion, African economic recovery early in the 21st century was under great pressure even before the pandemic, due to new trade arrangements, falling commodity prices and severe environmental stress.

### European scramble for **Africa**

Africa's borders were drawn up by European powers, especially following their 'Scramble for Africa' from 1881 ending by World War One. Various culturally, linguistically and religiously different 'ethnic' groups were forced together into colonies, to later become post-colonial 'nations'.

Europeans came to Africa seeking slaves and minerals, later building colonial empires. The US attended the 1884 Berlin Congress, dividing Africa among European powers. Colony-less 'latecomer' Germany got Southwest Africa and Tanganyika, now Namibia and mainland Tanzania respectively.

Namibia's Herero and Nama peoples revolted unsuccessfully against German occupation in 1904. General Lothar von Trotha then ordered "every Herero ... shot". Four-fifths of the Herero and half the Nama died!

Communities were surrounded, with many killed. Others were held, with many dying in concentration camps, or driven into the desert to die of starvation. In 1984, the UN Whitaker Report concluded the atrocities were among the worst 20th century genocides.

### Asymmetric interde-

pendence?

post-Second Europe's World War recovery benefited immensely from their primary commodity exporting colonies. After the wartime devastation, European imperial powers relied on colonial currency arrangements for precious foreign exchange.

Imperial power also ensured captive colonial markets for uncompetitive post-war European manufactures. Recovery and competition brought down commodity prices, especially after the Korean War boom. For well over a century, such

prices have declined against those for manufactures.

As decolonization became inevitable, French politicians promoted the notion of 'Eurafrica', mimicking the US Monroe Doctrine's claim to Latin America. French elite discourse insisted African independence should be defined by (asymmetric) 'interdependence', not 'sovereignty'.

Although Germany lost its few colonies in Africa after losing the First World War, the influential West German Die Welt wondered wistfully in 1960, "Is Africa getting away from Eu-

### From decolonization to **Cold War**

The US was the first nation to recognize Belgian King Leopold II's personal claim to the Congo River basin in 1884. When Leopold's brutal atrocities and exploitation of his private Congo Free State domain, killing millions, could no longer be denied, other European powers forced Belgium to directly colonize the country!

Since then, the US has shaped the Congo's destiny. governments which collaborat-The US has been keenly interested in its massive mineral rivals. resources. Congolese uranium, the richest in the world, was used in the Hiroshima and Nagasaki nuclear bombs. But Washington would not allow Africans control of their own strategic materials.

Patrice Lumumba became the first elected prime minister of the Democratic Republic of the Congo (DRC). An advocate

of pan-African economic independence, his wish for genuine independence and sovereign control of DRC resources threatened powerful interests.

Lumumba was brutally humiliated, tortured and murdered in January 1961. The shameful assassination involved both US and Belgian ed with Lumumba's Congolese

### Struggling to stand up

Pan-Africanist leader Kwame Nkrumah wanted independent Ghana to chart an 'anti-imperialist' path, staying non-aligned in the Cold War. He wanted hydroelectric dams to power Ghana's industrial progress, beginning by smelting its bauxite to develop an aluminium value chain.

The US, UK and World Bank agreed to finance the Akosombo Dam, on condition it provided cheap energy to a Kaiser Aluminium subsidiary to process alumina for export to Kaiser. This arrangement was only rescinded decades later, early this century.

Ghana made technical cooperation agreements with the Czechs and Soviets to build two other dams. But both were ended after Nkrumah was overthrown in a military coup abetted by Washington in February 1966. Thus, Nkrumah's development ambitions for Ghana were killed.

A scaled-down Bui dam was finally built by Chinese contractors decades later. Nkrumah's 1965 book, Neo-colonialism: The Last Stage of Imperialism, was probably the final straw in embarrassing the West.

Tanzania's Elsewhere, Julius Nyerere's Ujamaa 'African socialism' focused on developing villages and food security. Western antagonism ensured Ujamaa's failure, while his efforts were harshly condemned to deter other Africans from trying to chart their own paths.

Meanwhile, Nyerere's pro-Western contemporaries were supported by the West. Such countries, e.g., neighbouring Kenya and Uganda, received much more Western aid although their development records have not been much better.

### A luta continua

At independence, Zambia had no universities, with only 0.5% completing primary education. The country's copper mines were mostly in British hands. Most people survived on limited land for the villagers, without electricity and other amenities.

Hemmed in by Westernsupported racist states, President Kenneth Kaunda - a devout Christian - sought foreign help to bypass hostile South Africa and Rhodesia (now Zimbabwe) to change the landlocked nation's fate.

After the US and World Bank refused to help, he reached out to the Soviet bloc and China. China built a \$500 million railway linking Zambia to the Indian Ocean through Tanzania.

Côte d'Ivoire has long been a major producer of cocoa and coffee. But three decades of misrule by its pro-Western founding father, Felix Houphouet-Boigny, ensured endemic poverty and stark inequalities, culminating in civil war.

In 2020, almost 40% of its people lived in 'extreme poverty'. In 2019, the middle-income country's human development index score was a low 0.538, which dropped to 0.346, when adjusted for inequality.

Both Kaunda and Houphouet-Boigny later abandoned their early, more neocolonial policies. Zambia nationalized copper mines, hoping to improve living conditions, instead of enriching foreign investors.

Meanwhile, Ivorian cocoa was withheld to secure better prices. But both efforts failed, as copper and cocoa prices collapsed. Thus, both nations were severely punished for trying to better their fates.

### Non-alignment best

During the first Cold War, Western hostility to African aspirations forced many to turn to the 'socialist camp' to build infrastructure and develop human resources. Washington then was as concerned with economic gain as countering 'Reds'.

The Kennedy administration had increased foreign aid, urging allies to do likewise. But instead of supporting African aspirations, the West pursued its own economic interests while claiming to support post-colonial aspirations.

Increasing African government indebtedness over the 1970s forced many to accept structural adjustment programme policy conditions imposed by international financial institutions from the 1980s. Of course, developing countries following International Monetary Fund (IMF) and World Bank prescriptions became Western darlings.

Nyerere observed: "The IMF ... makes conditions and says, 'if you follow these examples, your economy will improve'. But where are the examples of economies booming in the Third World because they accepted the conditions of the IMF?"

Cold War considerations have also meant US interest in Africa has waxed and waned. Now, the West warns of imminent Chinese 'takeovers' and nefarious Russian designs. China seems more interested in financing and building infrastructure, while Putin promotes Russian exports.

Neglected by the US after the first Cold War until its 21st century African initiatives, including Africom, African nations have increasingly welcomed alternatives to the West, albeit somewhat warily.

Together, the world can help Africa progress. But if support for the long cruelly exploited continent remains hostage to new Cold War considerations, Africans will choose accordingly. Nonalignment is now the pan-African choice.

Tanzania 'Communications Regulatory Authority (TCRA) has urged users of communication services in the country to avoid dumping lots of private or personal information so as to protect themselves from being conned and swindled.

TCRA principal communication officer, Semu Mwakyanjala, said although most of the users of telecommunication services in the country conform to rules and regulations for online services, there are some few who misuse and abuse them, engaging themselves in criminal acts like online theft, conning and theft of information used in online money transactions.

Semu wants the users to ensure that confidential information like passwords used for mobile money or bank transactions are well protected and should not be shared to anyone.

He made the call recently in Kigoma when he spoke to members of the public at Kalinzi village near the Tanzania-Burundi border.

The education is part of TCRA's ongoing campaign known as "Kwea Kidijitali "to enhance the level of understanding on the significance of proper and safe

Mwakyanjala discouraged the use of patterns on smartphones as a means to encrypt user information alerting that it is possible for third parties to guess and break into and access personal information in their gadgets.

Due to the increase of cybercrimes, the use of strong passwords that involve combination of different characters is very important alerting that conmen have started to guess simpler passwords like those that include year of birth.

"It is important for users of communication devices to refrain from generating simpler passwords that could be guessed by people with bad intention who want to get into their personal information," Semu

As most on-line conmen are bent to acquiring personal information posted on social networks, the TCRA officer advised communicationservice users should exercise caution whenever deciding what to share on on-line platforms. Furthermore, he urged users

not to engage with individuals who phone them seeking their passwords or personal information; emphasizing on not cooperating with them even if the caller claims to be from the network provider they use.

"If you receive a call from a normal phone number, do not follow the instructions; instead, send the fraudulent number or a text message to the number "15040" so that legal action can be taken against the suspected criminals. This number is tall free; attracting no charge for the service," Mwakyanjala emphasised.

He advised mobile phone users to verify total of number of Sim cards registered using each user's National Identification Number (NIN) from National Identification Authority (NIDA) by dialing \*106#. The short code is also used for the verification of status of registration.

Kigoma is the country's leading region in palm trees cultivation that yield palm oil where Mwakyanjala urged the locals of the to utilize communication opportunities to find markets for the rare, valuable crop.

# Climate-smart agricultural practices delivering lifechanging benefits for Tanzanian women

MARIAM Tungu, a woman farmer from Ikungi District in Singida Region spent decades cultivating the small piece of land behind her home and had resigned herself to yielding only enough to sustain her

In 2020, women from her village of Kipumbuiko joined forces and formed agricultural groups to pool resources and cultivate large pieces of

"If we got lucky, we had a little extra to sell and give our children some meat or eggs that week but sustaining this didn't seem possible at the time".

Mariam's story is similar to that of many women farmers in the country, experiencing challenges of access to land, discriminatory social norms and attitudes, and limited access to credit and agricultural inputs like improved seeds and modern farming equipment.

In 2020, women from her village of Kipumbuiko joined forces and formed agricultural groups to pool resources and cultivate large pieces of land.

That same year, as part of the UN Women and UNFPA joint programme "Realizing Gender Equality through Empowering Women and Adolescent Girls", supported by KOICA, UN Women partnered with Farm Africa to capacitate small-holder farmers' groups in Kipumbuiko and surrounding villages on modern, climate-smart agricultural practices to improve sunflower farming productivity

The partnership with the Ministry of Lands and the district council has demonstrated how it can yield positive



The groups were trained and given improved sunflower seeds and enhanced access to markets through Agricultural Marketing Cooperatives. They will also improve crop storage through a newly constructed warehouse boosting post-harvest sales.

To date, over 300 women have benefited from the programme, increasing their income almost two-fold.

With the increased income, Mariam started a small chicken farm, and her group diversified their crops, adding tomatoes, onions, and watermelon.

With evidence showing that increasing women's land ownership improves their farming productivity, under the UN Joint Programme, UN Women

partnered with the Ministry of Lands, Housing and Human Settlements, and local authorities to draft village landuse plans for women to obtain certificates of customary rights of occupancy (CCROs), allowing for the ownership of land under customary law.

"This enabled the issuance of over 5,000 CCROs in four villages of the Ikungi district, most of which were issued to women," said Hodan Addou, UN Women Representative in

"The partnership with the Ministry of Lands and the district council has demonstrated how it can yield positive results," she added. "Through the multi-faceted approach, the programme employs, women have not only been

able to increase their access to land to expand farming activities, and are also better equipped to employ better, more modern practices to improve their productivity. Furthermore, through the newly constructed warehouse in Ikungi, they can store their produce after harvest and negotiate better sale prices," said

Addou. As beneficiaries of the capacity building on land rights, Mariam and her husband agreed to register both their names on their land, giving her joint ownership rights.

"I am now officially a landowner. And if anything happens to my husband, my rights will be protected. I couldn't hope for a greater blessing,"

# Outreach campaign increases Covid -19 vaccine uptake in Tanzania, states WHO

AS Tanzania continue to implement and promote uptake of COV-ID-19 vaccine following a slow start last year, several regions have now shown a huge improvement due to the implementation of community mobilisation campaigns, the World Health Organisation (WHO) has acknowledged.

Vaccination is important to avoid severe COVID-19, in turn relieving the health system the burden of hospitalising critically ill patients. Moreover, controlling the virus curtails evolution of newer variants.

Dr Zabulon Yoti, acting WHO country representative to Tanzania said in a statement that: "With the low coverage in specific regions, we have decided to get involved at regional and district levels including, working with partners on community engagement and mobilization at grassroots level."

He said WHO has been supporting the national response to COVID-19 since 2020, with national plans, sub national plans, surge personnel, equipment and supplies. In vaccination, the WHO has been supporting national and micro planning at dis-

He said while maintaining technical support at national and sub national level, the WHO additionally focused on Manyara, Rukwa and Songwe and four districts in Zanzibar for additional technical and financial support.

Until June 2022, the regions that have these districts had not attained 11 percent coverage of COVID-19 vaccination.

But due to the outreach campaigns reaching communities in various parts have increased uptake of Covid-19 vaccine, he said.

"As of the August 5, this year, the total number of fully vaccinated people in Tanzania stood at 14,893,598. This translates to about 24 percent of the total population and 48.4 percent of the eligible population 18 years and above," he noted.

He said: "Intensification of advocacy and community level outreach was also adopted by many regions during the third round of intensified campaign, learning from its effectiveness in Ruvuma region that consistently maintained a high vaccination rate. Fittingly, the Minister of Health recognized Ruvuma with

an award placard when launching the third round in Dar es Salaam on June 2, this year," he noted.

He said results of the engagement at community level show that the approach has potential to take Tanzania to its goal of reaching 70 percent of the population with Covid-19 vaccination, therefore protecting its people from the worst of the pandemic.

"Different from our earlier approach, this time went deeper and wider in our communities. Earlier our advocacy took place at regional level and left it to leaders to cascade. This time the regional commissioner himself addressed advocacy meetings a district level, where community leaders participated" said Suleiman Manoza, Regional Immunization and Vaccination Officer in Manyara.

Leveraging its global technical leadership and in collaboration with the RHMT, WHO led the process of micro-planning, developed the curriculum for training of health workers and community champions, developed standard data collection tools, vaccine distribution plan and management as well as supportive supervisory plans to guide the cam-

WHO deployed public health experts in technical coordination, risk communication and community engagement, finance and administration, data management, monitoring and evaluation to orient the campaign to results-increased number of people that vaccinate daily.

"With that, it was possible to monitor daily performance at the ward and district levels and notice health facilities or wards performed below expectations and therefore needed extra support. In this approach, we take vaccination where people are which is what we usually do in house to house campaign. However, in this approach, we take advantage of gatherings of people be it in markets, churches, schools, meetings

To avoid duplication of efforts from Johns Hopkins Program for International Education in Gynecology and Obstetrics, (JHPIEGO) and Clinton Health Access Initiative (CHAI) coordinated with WHO so that WHO provided technical and financial support for the implementation of the campaign for four days while JHPIEGO, extended the campaign for five more days and CHAI

leveraged on WHO presence in Babati District council to ensure that the council met its target.

During the nine-day campaign supported by WHO (five days) and JHPIEGO and CHAI (four days) the target population coverage in Manyara region increased from a baseline of 4.3 percent to 20 percent. No doubt the effort has contributed to increase the percentage of COV-ID-19. "WHO has enabled us reach at the point we have reached today. They engaged with the top regional leadership and together decided to take the approach of infusing advocacy downward and take advantage of events and house to house approach in the campaign.

It is expected that the results in increased vaccination rate in these regions, will provide practical lessons that can replicated to increase vaccination in other areas facing similar challenges.

The initiative is already showing encouraging results. In Manyara region, where WHO provided technical and financial support during advocacy meetings at regional district level vaccination increased four folds.

To extend the momentum WHO Tanzania turned toward two regions the bottom of the chart-Rukwa and Songwe. A community mobilization campaign that engaged popularly appreciated persons (champions) to promote vaccination in their localities was launched in Sumbawanga Rukwa by the regional Commissioner, Joseph Mkirikiri.

Supported by WHO, champions traverse their communities and engage their communities to accept vaccination. As WHO promotes vaccination, another partner, JHM-RI has facilitated vaccination team in all four districts. Paid for their performance, these team have welcomed the intensified promotion.

WHO is supporting a total of 219 champions in Nkasi district and Sumbawanga municipality and 130 champions in Zanzibar's West A and West B districts as well as Mkoani and Micheweni districts.

The new impetus has not been limited to Manyara and Rukwa alone. The ministry of health and regional and district authorities across the country have taken advantage of implementing partners in their area to leverage resources and reach deeper in their commu-

# UN South-South event highlights power of cooperation for peace and development

UN panel held underlined the impact of South-South Triangular Cooperation (SSTC) projects as vital tools for enabling sustainable development and peace in developing countries.

Organized by the UN Department of Political and Peacebuilding Affairs (UNDPPA) and the UN Development Programme (UNDP), the joint virtual side event explored how to strengthen cooperation among developing countries and discussed various SSTC projects. The panel was part of the annual Global South-South Development (GSSD) Expo occurring from Sept. 12 to 14 in Bangkok. Thailand.

SSTC refers to a collaboration whereby traditional donor countries and multilateral organizations help create initiatives between two or more Global South nations. Support is typically given in the form of funding, training, and/or management.

In her opening remarks, Elizabeth Spehar, Assistant Secretary-General for Peacebuilding Support, emphasized the importance of these collaborations. She pointed to the role that organizations like the Group of Seven Plus-a collective of 20 conflict-affected countries that promotes stability through peer learning and advocacy-can play in helping vulnerable countries tackle their most pressing problems.

Only 18 percent of conflict-affected countries are currently on track to reach the UN Sustainable Development Goals, she noted.

"The resource and capacity limitations that many fragile and conflict-affected countries face can be enormous. Solidarity and peer-to-peer support through cooperation spearheaded by entities like the group of seven plus today, are more important than ever."

The need to bolster South-South initiatives became especially clear during the pandemic, Ruchira Kamboj, Permanent Representative of India to the United Nations, asserted

during the event's panel. "As we witnessed, the COVID pandemic has tested the resilience of multilateral institutions, and the global south has been largely fending for itself. In realizing that, [...] South-South cooperation has become even more crucial."

Kamboj gave several examples of contributions India has made in recent years to bolster the capacity of other developing countries, including launching the first single country UN Development Partnership Fund (India-UN Fund) and offering its open source COVID-19 vaccine delivery software to interested nations.

She also emphasized the power of knowledge sharing among developing nations.

"Sharing valuable capacities, experience and knowledge amongst developing countries can be a catalyst for development as opportunities have improved for sharing the fruits of knowledge, technology, and growth."

The panel also discussed how cooperation could help countries during conflict

Alhaji Fanday Turay, Permanent Representative of Sierra Leone to the United Nations, commented on how SSTCs were crucial to resolving his country's civil war.

"Sierra Leone was plagued with 11 years of civil war that led to not only the loss of lives and properties but a breakdown in institutions and a retardation of development in all forms. However, through regional and cross-regional interventions and cooperation, Sierra Leone was reinstated as a democratic and peaceful state."

Turay cited key examples that showcased how Sierra Leone had benefitted from SSTC collaboration around ensuring peace. This included the deployment of a Western African peacekeeping mission to implement the Lomé peace agreement and the establishment of the Truth and Reconciliation Committee in Sierra Leone–a step set out in the peace accord, which was overseen by the UN.

"It is very clear that the civil war in Sierra Leone ended as a result of collaborative efforts from member states of the global south and other development partners."

SSTCs have also been used to boost the capacity of women's participation in peace negotiations.

Panelist Juanita Millan Hernandez, UN Senior Mediation Adviser from Colombia, detailed her experience leading an intensive ceasefire training course for women in conflict areas, whereby training one group led to a ripple effect; the newly trained officers shared their expertise with others.


This sharing created important networks in areas where before, there were very few women equipped to participate in negotiations. Hernandez noted that establishing these networks was especially important given the peacekeeping field is dominated by older men, with specific views of security and peace.

By making the training comprehensive, the course also ensured trainees were able to tackle various types of conflict, significantly bolstering their ability to meaningfully participate.

"The idea is for them to not only be part of one attack, one negotiation, but also [to be] the face of security arrangements that can go to a very local situation in which all of these techniques, tools, and technical knowledge will be useful for them to solve and to participate in the more technical part of these processes. [...] We are trying to build the capacity of each course around 25 women, but they will [be able to] replicate the knowledge to two more women in the locality.

In closing the event, Haoliang Xu, Assistant Secretary-General and UNDP Director of Bureau for Policy and Programme Support underscored the need for developing countries to lean on each other's expertise and collaborate in tackling tough issues.

"There is no international system in which the national governments have to transfer resources to support less developed areas [...] To ensure that the level of development meets certain standards internationally, the best tool we have is solidarity and development cooperation."

# **MORTGAGE FINANCE BAD LOANS RATE LOW AT 0.2 PCT**

ortgage lenders are not experiencing bad debts compared to other sectors of the economy, after the new report indicated that it has the lowest Non-Performing Loans (NPLs) rate.

According to banking supervision annual report for 2021by Bank of Tanzania (BoT) NPL mortgage finance accounted for 0.2 percent last year, which was within the tolerable rate of not more than 5 percent.

This was experienced after the report shows audited profit after tax of mortgage finance institutions increased to 1,823.7mn/last year compared to 1,538.3mn/- recorded in the preceding year.

The increase in profitability was attributed to increase in interest income by 2.1 percent to 21,775.3mn/-

compared to 21,338.1mn/recorded in 2020.

"Performance of the mortgage finance institutions business continued to improve as supported by increase in capital, total assets, loan portfolio and profitability," says BoT report.

Total capital of mortgage finance institutions also increased by 5.9 percent to 51,345.0mn/- compared with 48,476.9mn/- recorded in 2020, attributed to increase in profitability.

The report says mortgage finance institutions therefore met capital adequacy requirements as provided in respective regulations.

Total assets of mortgage finance institutions increased by 5.6 percent to 219,400.8mn/- from 207,800.7mn/- recorded in 2020.

The increase was attributed to increase in investment in government securities by 22.4 percent to 64,146.3m/-

During this year, BoT reports that mortgage market registered 7.5 percent annual growth in value of loans, during the year ending June 2022, compared with June 2021; the market update report issued by Bank of Tanzania (BoT) has shown.

The outstanding mortgage debt during the year ending June this year increased to 509.99bn/- equivalent to \$220.23 million from 474.45bn/- equivalent to \$205.36 million recorded in June 2021.

A quarterly average mortgage debt size increased to 82.56mn/- equivalent to \$35,654, from 76.74mn/equivalent to \$33,213 recorded in June last year and 81.49m/- equivalent to \$35,276 in March 2022.

However, the ratio of outstanding mortgage debt to Gross Domestic Product (GDP) decreased to 0.29

percent in June compared to 0.35 percent recorded in June 2021.

The update notes that there was one new entrant into the mortgage market during the year, as the number of banks reporting to have mortgage portfolios increased to 33 from 32 in June last year.

Mortgage debt advanced by the top 5 Primary Mortgage Lenders (PMLs) accounted for 65 percent of the total outstanding mortgage debt while typical interest rates offered by mortgage lenders ranged between averages of 15 - 19 percent, the update says.

CRDB Bank Plc is the market leader commanding 38.02 percent of the mortgage market share, followed by Stanbic Bank (8.11 percent), Azania Bank (7.13 percent), NMB Bank Plc. (6.82 percent) and NCBA Bank (4.63 percent).

# Kenyan SGR by 7.8 pct to

Cargo and passenger revenues from the Standard Gauge Railway (SGR) rose 7.8 percent to Sh7.1 billion in the six months to June, extending recovery from the global Covid-19

The latest data from the Kenya National Bureau of Statistics (KNBS) shows that the passenger train crossed the Sh1 billion mark in a half year period for the first time since the train was launched, boosting efforts for the project to break even.

The passenger train raked in Sh1.24 billion in the six months ended June, a 49.6 percent jump from Sh829 million posted in similar period last year.

The cargo service, which mainly subsidises the passenger line, marginally grew to Sh6.17 billion in the six months from Sh6.04 billion in similar period last year.

This comes even as the modern rail prepares to take a hit coming from increased competition from the road transporters following President William Ruto's order to revert port operations to Mombasa.

The government is banking on improved performance of the SGR to ease the burden on taxpayers who have in the past been forced to pay for operational costs of the trains as the project struggles to break even.

Kenya requires additional cash from the railway business to ease the taxpayers' burden of paying the loan and also the Chinese firm that runs that SGR passenger and cargo trains.

The collections largely driven by a spike in the number of passengers in the period is the highest in the first half of the year since the SGR started operations in 2017.

The growth reflects the surge in passenger traffic as the SGR sold 1.121 million tickets in the six months to June, a 48.7 percent jump from 754,313 tickets over similar period a year

Operating costs of the SGR have in the past dwarfed revenues, fueling public outrage over the viability of the landmark project.

The project cost \$3.2 billion (Sh323.2 billion) that was largely borrowed from the Exim Bank of China from May 2014.

SGR operates passenger services from Nairobi to Mombasa and an inter-county service with stations at Athi River, Emali, Kibwezi, Mtito Andei, Voi, Miasenyi, and Mariakani stations.

Passengers pay Sh1,000 on economy class seats and Sh3, 000 on fast class seats between Nairobi and Mombasa aboard the express train.

# **Starbucks** stores count to increase 2025 in China

Coffee giant Starbucks said Wednesday that its store count on the Chinese mainland is expected to grow to 9,000 by 2025, providing 35,000 new jobs for employees.

"Through the launch of the Starbucks China 2025 purpose-driven growth agenda, we reaffirm our strong confidence in the prospects and opportunities of the Chinese market with concrete commitments and actions," said Belinda Wong, chairwoman of Starbucks China, adding Starbucks is now more resilient than ever after navigating challenges since the onset of the COVID-19 pandemic.

With an investment of about 1.1 billion yuan (about \$159 million), a Starbucks coffee creative park in Kunshan, east China's Jiangsu Province, will be completed and put into operation in the summer of 2023.

Starbucks revealed that they plan to set up its first digital technology innovation center on the Chinese mainland, for which the company will spend more than 1.4 billion yuan.

The number of Starbucks stores on the Chinese mainland has grown dramatically over the past decade and will reach 6,000 by the end of the company's fiscal year in September 2022.

"I joined Acacia North Mara Gold Mine as a Section Lead for Mining Projects and Services for Open pit in 2015 and later in 2017 on underground team as Section Lead...That was how I later came to be Barrick Gold's Mining Superintendent," explains Asha who is registered as a professional Mining Engineer by the Engineers Registration Board.

Asha, who is currently doing an online course for the award of the First Class Mine Manager certification from Western Australia, delights in enrolling and coaching more women in the mine and seeing that their number in that field rises.

From other recently-hired women engineers to women truck operators and from women drillers to dispatchers, Asha happy to see them progressing well in their career paths.

"We currently have two amazing women Engineers in the names of Dominica and Noela who work as planners. Recently, we hired Happiness as Truck operator who was awarded as the best employee for the year in 2021. We also have a brilliant Mining Engineer in the name of Kesia who works as a driller... Ulinde and Edna are our two other Women Engineers who work as Mining Dispatchers," she details, adding that she was looking up to working with many more women in the near future. But all this could not have been possible had it not been for Barrick's gender diversity

and inclusion policy. The policy, she says, supports gender diversity and inclusion, from the recruitment, on-thejob training to the management levels.

# **Dubai planning** to provide 15,800 homes to citizens

# Firm for two 100MW solar projects in South Africa

Sola Group and Tronox have finally reached financial close on two 100 MW solar projects in South Africa, roughly six months after signing power purchase agreements.

Two 100 MW solar power plants in South Africa's North West province have reached financial close, with construction now expected to begin Sola Group, a Cape Townbased renewables developer, secured approval from the National Energy Regulator of South Africa (Nersa) to build the projects back in May.

The corporate power purchase agreement was signed in March with US-based titanium products supplier Tronox, which operates several mines and smelters in the region.

The electricity will be supplied to five Tronox facilities in the Western Cape and KwaZulu-Natal through wheeling agreements, under which state-owned utility Eskom will pay for the maintenance and upkeep of infrastructure to transmit the electricity.

# WHO chief: End of COVID pandemic is 'in sight'

LONDON

THE world has never been in a better position to end the COVID-19 pandemic, the head of the World Health Organization said on Wednesday, his most optimistic outlook vet on the years-long health crisis which has killed over six million

"We are not there yet. But the end is in sight," WHO Director-General Tedros Adhanom Ghebreyesus told reporters at a virtual press confer-

That was the most upbeat assessment from the UN agency since it declared an international emergency in January 2020 and started describing COVID-19 as a pandemic three months later.

The virus has killed nearly 6.5 million people and infected 606 million, roiling global economies and overwhelming healthcare systems.

The rollout of vaccines and therapies have helped to stem deaths and hospital admissions, and the Omicron variant which emerged late last year causes less severe disease. Deaths from COVID-19 last week were the lowest since March

2020, the UN agency reported.

Still on Wednesday, he again urged nations to maintain their vigilance and likened the pandemic to a marathon race.

"Now is the time to run harder and make sure we cross the line and reap the rewards of all our hard work."

Countries need to take a hard look at their policies and strengthen them for COVID-19 and future viruses, Tedros said. He also urged nations to vaccinate 100 percent of their high-risk groups and keep testing for the virus.

The WHO said countries need to maintain adequate supplies of medical equipment and healthcare workers.

"We expect there to be future waves of infections, potentially at different time points throughout the world caused by different subvariants of Omicron or even different variants of concern," said WHO's senior epidemiologist Maria Van Kerkhove.

With over 1 million deaths this year alone, the pandemic remains an emergency globally and within most countries.

Following the Bourita-Ruto meeting, Morocco and Kenya issued a joint statement stressing the East African country's support for Morocco's Autonomy Plan for Western Sahara.

The statement reads: "Out of respect for the principle of territorial integrity and non-interference, Kenya fully supports the serious and credible autonomy plan proposed by the Kingdom of Morocco, as the only solution based on Morocco's territorial integrity, to resolve the dispute."

It went on to add that "Kenya supports the United Nations framework as the exclusive mechanism to achieve a lasting and permanent political solution to the dispute over the Sahara issue."

Prior to announcing his country's support for Morocco's territorial integrity, President Ruto had received from King Mohammed VI a message in which the Moroccan monarch congratulated him on his election as Kenya's fifth democratically-elected president.

Arguing that Kenya's August 2022 elections have further consolidated the country's position as a beacon of democracy on the continent, the Moroccan monarch expressed satisfaction with the new Kenyan president's pledge to strengthen and deepen bilateral relations between his country and various states in Africa and beyond.

Meanwhile, Ruto stressed his country's willingness and commitment to work to strengthen relations with Morocco, praising the leadership of Majesty King Mohammed VI in promoting policies of tolerance in the Maghreb region, as well as his contributions to continental peace and security.

The news comes as a further indication of Morocco's largely effective continental diplomacy, with Kenya joining a growing list of African countries that have embraced Morocco's stance on the Sahara dispute.

However, the newfound Kenyan support for Morocco is particularly telling as the East African country has long had an ambiguous and sometimes even slightly pro-Polisario stance on the Sahara dispute.

In March of last year, Ruto, who was then Kenya's Vice-President, took issue with the presence of a Polisario diplomatic mission in Kenya. He appeared to describe his country's Western Sahara stance as problematic, saying: "The representation of the Polisario in Nairobi makes no sense."

He also urged the African Union to once and for all put an end to the Western Sahara dispute by recognizing Morocco's sovereignty over the region.

"The conflict around the Sahara is only an excuse to allow Algeria to continue to squander the wealth of its people on lost causes," he said. "Instead of causing unnecessary conflicts and divisions within the African Union, this pan-African body must ensure that the territorial integrity of the 54 members is respected according to the AU charter which prohibits interference in the internal affairs of sovereign

### South Sudan to offer 14 new oil blocks to investors

SOUTH Sudan said Wednesday that it will offer 14 new oil blocks to investors in a bid to increase production to pre-war levels of 350,000 barrels a day.

Chol Deng Thon Abel, Managing Director of South Sudan's state-owned oil consortium, the Nile Petroleum Corporation Limited (Nilepet), told this to journalists in Juba, the capital of South Sudan, during the closure of the 5th annual oil and power confer-

"We have 14 oil blocks that are not been taken, and we invite international companies that are here to seize the opportunity to apply for these blocks. South Sudan is actually very busy nowadays attracting international companies to come and invest in the oil industry and this conference is a very good platform to exchange ideas with international companies," Thon said.

South Sudan is currently producing 175,000 barrels a day in blocks 1, 2 and 4 and blocks 3 and 7, and block 5A in Unity state. "We have a lot of countries now saying that we actually need to increase production because there is a huge need for crude because you have the sanctions on Iran, Venezuela and of recent Russia and this is where South Sudan is positioning itself to do production enhancement," Thon said. Nilepet is among 15 entities sanctioned in 2018 by the U.S. State Department on allegations of funding the conflict that broke out in December 2013.

SWEDEN'S Prime Minister Magdalena Andersson announced her resignation on Wednesday after losing the

Andersson (pictured), also leader of the ruling Social Democratic Party, conceded defeat at a press conference following the election on Sunday.

She said she would hand in her resignation notice yesterday after it emerged that the opposition blue bloc consisting of the Moderate Party, the Christian Democrats, the Liberal Party and the Sweden Democrats, had won 176 of the 349 seats in parliament.

Meanwhile Andersson's red bloc, consisting of her Social Democratic Party, the Left Party, the Green Party, and the Centre Party, won 173 seats.

"Tomorrow I will, therefore, request my dismissal as prime minister, and the responsibility for the continued process will pass to the Speaker and the Parliament," Andersson said.

She will now lead a transitional government until the new one has been installed, and thereafter she will lead the Social Democrats in opposition.

"We have made the largest increase in voter support in 20 years and we are not only Sweden's largest party -we are also the largest party in northern Europe. I am proud and grateful that almost two million Swedes chose to vote for us," Andersson said.

Despite the blue bloc ending up with three seats more than the red bloc, some analysts consider the blue bloc as fragile, since the Liberal Party has vowed not to tolerate a government that includes the Sweden Demo-

There are also fundamental differences between the Sweden Democrats and the other parties in the bloc when it comes to issues such as the unemployment insurance and other



economic issues

Also, during the election campaign Ulf Kristersson, leader of the Moderate Party -- which after decades lost its position as Sweden's second largest party to the far-right Sweden Democrats -- repeatedly said that the Sweden Democrats would not be included in his government should his bloc be victorious.

"It is now clear that the Sweden Democrats is now Sweden's second largest party and I know that this worries many Swedes." Andersson said.

In a video posted on Facebook, Kristersson said that political polarization had "become far too great also in Sweden."

Meanwhile, Andersson said she was prepared to explore another solution should Kristersson's efforts to form a government fail. "If it turns out that Ulf Kristersson's intended basis does not hold together, then of course my door is open," Andersson said.

"We Social Democrats are ready to cooperate with anyone who wants to be part of the solution to the problems that Sweden is facing."

Andersson took over from Stefan Lofven as both leader of the Social Democrats and the country's prime minister last November, following a period of political turbulence. She therefore became Sweden's first female prime minister.

# Swedish PM announces resignation Thousands file past Queen Elizabeth's coffin in London

LONDON

MOURNERS from all walks of life filed past the coffin of Queen Elizabeth through the night as she lay in state in London's ancient Westminster Hall, paying their final respects to Britain's longest-reigning monarch before her funeral on Monday.

After days of processions and ritual as the queen's body was brought to London from Balmoral, Scotland, where she died last Thursday at the age of 96, this was the opportunity for ordinary people to take a direct part in a ceremony.

As King Charles returned to his Highgrove home in the southern English region of Gloucestershire after days of scheduled events, officials expected some 750,000 people to view his mother's coffin before the lying in state ends at 6:30 am (0730 GMT) on

The line stretched back several miles along the south bank of the River Thames, past landmarks such as Tower Bridge and a replica of Shakespeare's Globe Theater, crossing Lambeth Bridge as it neared Westminster Hall. People waited many hours.

Thomas Hughes, 20, who waited nearly 14 hours overnight with his brother, said finally viewing the coffin was overwhelming.

"You do it all because you want to pay respect to this lady ... and I think when you put yourself through that, and then you get to the moment you're waiting for you are just that little bit more emotional," he said. "It's a very powerful thing."

Most were Britons but some were from overseas. They were young and old, and included former soldiers in military medals and babies being carried by their parents. Many stopped by the coffin to bow their head. Others wiped away tears.

Some were there to represent elderly parents, others to witness history and to thank a woman who, having ascended the throne in 1952, was still holding official government meetings just two days before she died.

Oueen Elizabeth's coffin lay in the center of Westminster Hall on a purple catafalque placed on a red platform. It was covered by the Royal Standard flag and topped with the Imperial State Crown placed on a cushion, alongside a wreath of flowers.

Soldiers and 'Beefeaters' - the red-coated warders usually found guarding the Tower of London - stood vigil with

Among the first inside was Kenneth Taylor, 72, from Reading in central England, who had come with a neighbor and stayed overnight in a tent in the queue.

Tearing up, Taylor said that on seeing the queen lying in state, he felt sad. "A lump came to my throat."

"You know, we've lost someone special. Her service to

this country was really steadfast and unswerving. And she's probably what I would call the queen of queens." The casket had been brought to the hall from Bucking-

ham Palace atop a gun carriage and escorted by soldiers in scarlet ceremonial uniforms in a solemn procession on

King Charles, his sons Princes William and Harry and other senior royals walked behind - the two princes united

in grief despite a rift between them. Harry marks his 38th birthday on Thursday.

William and his wife Kate will travel to the royal residence of Sandringham in eastern England on Thursday to view floral tributes left there by members of the public.

The full-scale ceremonial procession on the day of the queen's funeral is likely to be one of the biggest the country has ever witnessed and will pose a huge security challenge. Royalty, presidents and other world leaders are expected

to attend, although certain nations, including Russia, Afghanistan, and Syria, were not extended invites.

French President Emmanuel Macron was the latest leader to say he would attend the funeral.

US President Joe Biden, who has also said he will be there, spoke to the new king on Wednesday and "conveyed the great admiration of the American people for the Queen," the White House said.

The Times newspaper reported that British Prime Minister Liz Truss was expected to hold one-on-one talks with Biden and other world leaders on the sidelines of the funeral, but officials have said any such meetings will be informal.

Zimbabwe relocates 100 elephants to northern parts of country amid drought

MOSCOW

THE main purpose of the sanitary shield created in Russia, is to protect the people from possible future biological threats, President Vladimir Putin said on Wednesday as he met with the staff of the Russian sanitary watchdog that marks its 100th birthday.

"Among the priorities is the creation country. Its main goal is to protect Russian citizens from biological threats possible in the future. The implementation of this project will make the diagnostics of infections quick and accessible," the president noted.

Thus, it will be possible to diagnose any unknown infection within a day, he explained. Experts believe a test system to detect it can be developed within four days.

# Rising 'excavator index' indicates China's dynamic economy

THE climbing "excavator index" mirrors China's endeavors to rev up infrastructure construction and stabilize investment and

Statistics showed that 65.4 percent of all engineering equipment across China were operating in July, higher than the January-June figure of 60.37 percent. In the first half of this year, the total working hours of excavators increased 6.86 percent year on year.

The rising trend of the "excavator index" is corroborated by relevant statistics released by the National Bureau of Statistics of China (NBSC).

According to the NBSC, infrastructure investment grew 7.4 percent year on year in the first seven months of this year, which was 0.3 percentage points higher than the January-June figure.

Over 134,000 new infrastructure projects commenced in the first half of this year, up 26,000 from a year ago. The total investment of new projects expanded 22.9 percent year on year during the same period, and the paid-in investment (real estate investment not included) went up by 18.8 percent.

These figures fully indicate that China's efforts to make proactive investments in infrastructure have paid off. As a matter of fact, it takes time for engineering projects to turn investment into tangible achievements. It is believed that as more policies are implemented to stabilize the economy, effective investments will be further expanded. Infrastructure offers solid sup-

port for economic and social development. Major infrastructure projects, involving a number of industries, can attract huge investment and create massive job opportunities. They play an important role in stabilizing macro

This year, both central and local policies have been issued to improve traditional and new infrastructure construction.

To bolster areas of weakness, China is steadily pushing forward the implementation of 102 megaprojects earmarked for the 14th Five-Year Plan (2021-2025) period, and some 2,600 smaller projects were already spun off from these megaprojects.

Besides, the country has kicked off a vast plan to build regional data center clusters in its western region that process data generated in the east. Currently, over 3,100 "5G+Industrial Internet" projects are under construction across China, and more than 1.85 million 5G base stations have been estab-

This not only offers solid support for stabilizing the fundamentals of the Chinese economy, but also contributes to the construction of the country's modern infrastructure sys-

China is currently at a critical stage of economic recovery. It should give full play to

the role of effective investment in economic recovery to consolidate previous achievements and further stabilize macro economy. It should give support to projects that aim at both near-term and long-term benefits. Transport, energy, logistics, and rural infrastructure, as well as new infrastructure projects shall be major areas of investment, so that more momentums will be gathered for expanding effective investment.

Besides, effective investment must be well utilized through market-oriented manners. For instance, the leading role of special bonds must be brought into full play. In the first half of 2022, effective investment driven by special bonds offered important support for stabilizing economy. Gross capital formation contributed to a 0.8-percentage rise in

China's economic growth.

Though the Chinese economy still faces challenges and problems, the fundamentals sustaining China's long-term stable economic growth remain unchanged.

The rising "excavator index" reflects China's accelerating infrastructure construction, as well as growing benefits of and confidence in investment. Such a positive trend is generating new impetus driving continuous development of the Chinese economy.

THE Zimbabwe National Parks and Wildlife Management Authority (Zim-Parks) said Wednesday that since July this year, it has relocated 100 elephants and a significant number of wild animals from the arid southern parts of the country to the north where there is better vegetation and water.

ZimParks spokesperson Tinashe Farawo told Xinhua that the Authority issued permits for the transfer of 2,650 animals from the Save Valley Conservancy to three national parks in the north namely Tsapi, Chizarira and Matusadonha.

The animals targeted for relocation include 400 elephants, 2,000 impalas, 70 giraffes, 50 zebras, 50 buffaloes, 50 elands, 10 lions and 10 wild dogs. The relocation exercise began in July

and so far, 100 elephants and a "significant number of other wild animals" had been relocated, he said.

He said the main reason for relocation was to depopulate overcrowded areas and create a balance in the ecosystem. Climate change induced-drought re-

sulting in loss of habitat, food, and water was posing a risk to the animals and the only way to protect the habitat was to make sure that we create a balance by relieving pressure on overcrowded areas, Farawo said.

Zimbabwe has become prone to frequent droughts in recent years due to climate change, posing the risk of hunger not only to humans but also to wild animals.

Zimbabwe has an overpopulation of elephants numbering over 100,000 against an ecological carrying capacity of 45,000. The jumbos are located in four main ecological zones, and two of the zones are overpopulated.

The four zones are North West Matabeleland where the country's biggest game park Hwange is located, South East Lowveld where the second biggest park Gonarezhou is located, as well as the Sebungwe region and mid Zambezi in the northern part of the country.

This is not the first time that Zim-Parks has moved the animals. In 2018, it moved 100 elephants from the South East Lowveld to mid Zambezi while plans to relocate 600 elephants in 2020 were affected by the COVID-19 pandemic.

The relocation programme is an expensive exercise and ZimParks has in the past lamented inadequate funds to successfully carry out the programme. Xinhua

CONSTRUCTION of the proposed ultra-modern sports venue in Dodoma is still on course and is scheduled to start soon, the parliament was informed yesterday.

building 100,000-capacity stadium complex was proposed about six years ago during the Moroccan King's visit to Tanzania at an estimated cost of

The government's preparedness to start the construction was revealed in Dodoma on Monday by Deputy Minister for Culture, Arts, and Sports, Pauline Gekul, when responding to a question asked by Morogoro South MP, Innocent Kalogeris (CCM).

"What is the government doing the country's proposed Dodoma to start the construction as soon as possible instead of waiting for support from the Moroccan leader?" Kalogeris asked.

In response, the Deputy Minister noted that the government is looking for funds for the projects, adding that the construction will start soon.

"The project is unavoidable since it is in the ruling party manifesto and it is also a key facility for the capital city," Deputy Minister stated.

A lot has been said about the project, with many wondering when it will officially start.

The then Minister for Information, Culture, Arts, and Sports, Harrison Mwakyembe, once revealed that accuracy purposes, had to be

Stadium project had moved closer to the construction stage following the completion of seismic, topographical, and feasibility studies which had to be repeated to ensure maximum safety of the

structure and the spectators. The project has been in the pipeline since 2017 after King Mohamed VI of Morocco pledged to build the biggest stadium in the East African country following his visit in 2016.

Mwakvembe explained that Dodoma city is prone to earthquakes and therefore his ministry had a huge task of conducting seismic, topographical, and feasibility studies, which for repeated.

He also mentioned that the national government has already acquired land for the Dodoma Stadium project, which is bigger than the initial hectors needed.

The proposed mega stadium will, upon completion, have the capacity to accommodate between 85, 000 to 100, 000 spectators, more than any other stadium on the continent.

The delivery of the new stadium will put Tanzania in a better position to bid for hosting major continental sports events such as the Africa Cup of Nations (AFCON), African Canadian Soccer & Cultural Association (ACSCA), as well as other top athletics events such as All-Africa Games and World Athletics Championships.

### Potter frustrated as Salzburg hold Chelsea

GRAHAM Potter admitted Chelsea have to "improve the little details" after Red Bull Salzburg spoiled his first match in charge with a late equaliser in Wednesday's 1-1 draw in the Champions League.

Potter was on course for a winning debut when Raheem Sterling put Chelsea ahead early in the second half at Stamford Bridge.

But the former Brighton boss, who replaced Thomas Tuchel last week, had to settle for a point as Noah Okafor punished sloppy defending to equalise in the clos-

It was a largely underwhelming performance from Chelsea, underlining the work Potter must do to repair the flaws in the expensively assembled squad left behind by Tuchel.

"It's always irritating when you concede a goal. Overall the defensive performance was quite good, it's just the little details we will have to improve," Potter said.

"We're disappointed with the result. We scored a good goal, but lost a bit in the second half."

Tuchel was dismissed last Wednesday in the aftermath of Chelsea's embarrassing 1-0 loss at Dinamo Zagreb in their Champions League opener.

Having taken just one point from their first two Group E matches, Chelsea now face a fight to qualify for the knockout stages with two matches against AC Milan looming.

"It is what it is, we have to dust ourselves down. Personality and application was good, we will get better,"

"It has not been easy for the boys. They have responded to us really well over the last few days. The attitude has been fantastic. No complaints apart from the fact we have not taken three points."

With Sunday's Premier League game against Liverpool postponed due to the forthcoming funeral of Queen Elizabeth II, Potter will have to wait until October 1 for his second game when Chelsea travel to Crystal Palace after the international break.

At least that will give Potter time to find his feet after he was appointed just 24 hours after Tuchel's shock exit -- sparking what the 47-year-old described as a "whirlwind" week as he starts the biggest challenge of his career.

Potter earned widespread admiration for his impressive work with Brighton, who enjoyed their highest Premier League finish last season when the Englishman led them to ninth place.

But thriving on a limited budget at Brighton provides only scant preparation for the unique demands of handling a club of Chelsea's ambition.

Potter had never even been to a Champions League game before walking into Stamford Bridge on Wednes-

# Napoli overcomes missed penalties to beat Rangers 3-0

AFTER missing two penalty kicks, Napoli finally scored on its third try en route to a 3-0 win at Rangers in the Champions League on Wednesday.

Forty-year-old Allan McGregor saved two penalty kicks from Piotr Zieli ski, but the Rangers goalkeeper could not keep out the third scored by Matteo Politano in the 68th minute.

Defeat for 10-man Rangers was sealed with late goals by Napoli substitutes Giacomo Raspadori in the 85th and Tanguy Ndombele in stoppage time.

Napoli has recorded back-to-back three-goal wins to lead Group A with six points. Rangers is in last place after losing heavily again. Liverpool beat Ajax 2-1 in the

A game in Glasgow postponed for 24 hours – because of the demands on police resources after the death of Queen Elizabeth II in Scotland – proved worth waiting for in a frenetic 13-minute spell in the second half.

The spot-kick saga started in the 55th when Rangers defender James Sands, the United States international on loan from New York City FC, got a second yellow card and was sent off for bringing down Giovanni Simeone as he prepared to shoot.

Zieli ski's right-footed penalty low to McGregor's right was parried toward Politano who slotted the ball between McGregor's legs.

Haaland's spectacular goal earns City 2-1 win over Dortmund

cross reached Erling Haaland at shoulder height, about a meter in front of the Manchester City striker. No problem for this generational talent.

Producing a spectacular acrobatic volley with the outside of his left foot, Haaland completed a late comeback by City against Borussia Dortmund – the German club he left in the offseason – in a 2-1 win in the Champions League on Wednesday.

Dortmund kept its former star in check for almost the whole game, with City unusually sloppy in possession and getting increasingly frustrated at Etihad Stadium.

Indeed, Pep Guardiola's team hadn't even had a shot on target before John Stones – a center back playing out of position at right back – popped up just outside the area and, egged on by the home crowd, smashed a swerving shot high into the net from outside the area in the 80th minute.

Haaland's winner four minutes later was even better. Joao Cancelo sent in a cross from the left with the outside of his right foot and Haaland showed amazing agility to leap high and redirect the ball into the net with his left foot.

Guardiola said it reminded him of a famous goal scored by Johan Cruyff for Barcelona against Atlético Madrid in 1973-74.

Haaland impressed himself, too, with the goal that took his overall tally in the

"That shows his quality," said Dortmund midfielder Jude Bellingham, who put the German team ahead in the 56th. "He's not always in the game, but you give him half a sniff and it ends

City has opened Group G with two straight wins in its latest bid for a first Champions League title, and now heads into a double-header against FC Copenhagen. Two wins against the Danish champions and City might seal a place in the last 16 with two games to

Guardiola was not happy with his team's performance against Dortmund, however.

"We played in the wrong gear today," he said. "No aggression. Incredibly passive.'

After a forgettable first half that saw Dortmund

successfully smother City, Bellingham gave the visitors the lead by darting in between Manuel Akanji and Haaland – who were his teammates last season – and glanced in Marco Reus' cross from the left.

City was transformed after the introduction of Bernardo Silva, Phil Foden and Julian Alvarez in a triple substitution. "They changed our pace

and there were two excellent goals," Guardiola said.

Meanwhile, in Milan, AC Milan will likely be even more eager to extend Rafael Leão's contract after the Portugal forward again starred in a Rossoneri win.

Leão earned a penalty – converted by Olivier Giroud – and set up Milan's second for Alexis Saelemaekers to help his team beat Dinamo Zagreb 3-1 in the Champions League on Wednesday. Tommaso Pobega all but sealed the result 13 minutes from time.

The 23-year-old Leão was one of the stars of Milan's title-winning team last season. He has also scored three goals in six Serie A matches this season and will be sorely missed when Milan hosts Napoli as he is suspended for this weekend's match.

"There's not much difference between Italian matches and the Champions League," Milan coach Stefano Pioli said. "Now we're facing Napoli, which is a top team like Chelsea, we will have to find solutions in attack seeing as Leão is suspended.

"If we play at our top level we can win all the matches in all the competitions."

Milan is already in talks to extend Leão's contract, which expires in 2024. Chelsea, which is also in Milan's Champions League group, is one of the clubs interested in him.

"We've already started talking with him about renewing, many months ago," Milan director Paolo Maldini said. "Rafa knows that to become even stronger than now the best solution is to stay with us. We are a young squad that is growing.

"He still has to learn a lot of things, but then if he gets to a level that's better than Milan I think it's also normal that he'd leave. But we intend to do great things

and grow with him. We didn't receive an official written offer from Chelsea. but there was an informal one and naturally it was rejected."

It was Milan's first win in the competition this season after it opened with a 1-1 draw at Salzburg. Dinamo beat Chelsea in their opener. It was also Milan's first home win in the Champions League in almost nine years, since a win over Celtic was followed by three losses and three draws at San Siro.

Milan dominated on Wednesday but lacked accuracy up front and it took it until the stroke of halftime to break the deadlock after Leão had been brought down by Dinamo defender Josip Šutalo.

Giroud drilled the penalty into the bottom right corner.

And Milan doubled its tally immediately after the break when Leão shimmied his way into the area and crossed for Saelemaekers to head in from close range.

Dinamo pulled one back in the 56th minute, also through a lovely bit of skill, when Bruno Petkovi released Mislav Orši with a cheeky back-heeled pass and the Croatia forward slotted the ball into the bottom right corner.

Leão also had a hand in Milan's third. He picked out Pobega and the Italy midfielder played a onetwo with Theo Hernández before firing in off the underside of the crossbar for his first Champions League

Madrid stayed calm.

It was just a matter of time before the defending European champions punished Leipzig.

fended off Madrid Leipzig's good start and scored late goals with Federico Valverde and Marco Asensio to extend its perfect start to the season with a hard-fought 2-0 win in the group stage of the Champions League on Wednesday.

Valverde found the net from inside the area in the 80th minute and Asensio added to the lead in stoppage time to salvage Madrid's eighth victory in a row in all competitions.

In its first home game in the competition since winning a record 14th European title, Madrid had struggled from the start and failed to pose much of a threat against a tough Leipzig squad until Valverde opened the scoring.

The visitors created most of the scoring opportunities early on in the Group F match at the Santiago Bernabéu Stadium, with Christopher Nkunku and Timo Werner failing to capitalize on their chances for Leipzig.

"We are brutally disappointed," Leipzig defender David Raum said. "We were able to make it an even game. If you take the lead, take it into the break, maybe something is possible for us. Them scoring with the first and second shot on goal is brutal, but that's Real Madrid."

Valverde got on the board with a curling left-footed

Madrid was without the injured Karim Benzema, the team's best player last season. Ancelotti played with Valverde, Rodrygo and Vinícius up front, leaving Eden Hazard on the bench.

Kroos also started on

Modric. In defense, Ancelotti played with David Alaba as a left back and Nacho Fernández as a central defender along with Antonio Rüdiger.

# TFF sets date and venue for Ordinary **General Assembly**

TANZANIA Football Federation (TFF) has confirmed the date and venue for this year's Ordinary General Assembly.

It will be the 17th general assembly and will be hosted in Mwanza on November 14, 2022. "The 17th Tanzania Football Federation Ordinary

General Assembly shall be held on November 14, 2022, in Mwanza," reads the press issued by the federation. Twenty-five member associations make up the delegates in the TFF General Assembly.

Also expected to attend the AGM are 16 NBC Premier League clubs' representatives, a representative each from TFF recognized association for football coaches, an association for football referees, women, and an association of football players.

Members of the TFF executive committee, invited dignitaries, the federation's management and staff and several other stakeholders are also expected to attend the meeting in Mwanza.

The assembly is hosted on a rotational basis with each region of TFF given an opportunity upon a decision by the executive committee. Last year's AGM was hosted in Arusha and the year before that it took

Previously, the TFF AGM was mostly held in Dar es Salaam where stakeholders would be called from all over the country to discuss the game.

The assembly takes place annually where delegates convene and review activities carried out in the previous 12 months plus planning for the future.

Some of the key areas of address in the Ordinary General Assembly include activity reports, financial statements, approval of budgets, admission of new members, and dismissal of members among others.

In the technical report, among the items that are likely to dominate discussions at the meeting are Taifa Stars' head coach Honour Janza's appointment and the roles of Kim Poulsen in the national junior team following his removal from the senior team.

The General Assembly will discuss a schedule for it as well as any other matters that may be brought up by either federation members or executive committee

The recent failure to qualify for the 2023 African Nations Championship and the foreign player rule amendment might as well form part of the discussion on the way forward for Tanzanian football.

# DTB Gymkhana secures progression to 2022 Petrofuel DC Caravans T20 Cup last four

THE DTB Gymkhana cricketers have booked a place in the 2022 Petrofuel Dar es Salaam Cricket (DC) Caravans T20 Cup tournament's lastfour, thrashing Novum Strikers by five wickets in a knockout clash that took place last weekend.

The knockout match, dubbed 'Eliminator', brought together sides that finished in second place in groups A and B of the showpiece, seeking to secure progression to the last-four round.

Novum Strikers finished second in Group B with a 0.0034 net run rate, following victory in four matches and loss in one.

The tournament's Group B had witnessed DTB Gymkhana taking the second position having recorded a 0.4240 net run rate, having come out victorious in four ties and loss in one.

Fireworks were set to be on show in the knockout clash given both clubs enjoyed an impressive run in the round-robin stage and they made the duel worth watching.

Novum Strikers raced to 120/8 in the allotted 20 overs once they had got the opportunity to take the crease first, with the club's top-order heroics coming in handy. Jatin Darji, deployed at number

three, was the batsman with the most runs having recorded 48 runs which included two boundaries and two sixes.

The veteran cricket ensured his outfit solidly take on DTB Gymkhana's attack, pushing the batting side's total to 120 runs with 1.1 over remain-

Earlier the openers Amin Solanki and Morris Auma did their best to impose themselves in the duel despite facing pressure posed by DTB Gymkhana's bowling unit. Solanki recorded 17 runs that included three boundaries, and fellow opener Auma ended with 15 runs.

Experienced performer Issa Kikasi played part in the batting team's efforts to end the innings with a better total, notching 23 runs.

Efforts by Novum Strikers to put a bigger score were frustrated by early exits of the remaining members of the batting unit, with none managing to end with two-digit scores. Amit Raghuvanshi, Gurvinder Singh, and Mohammed Yunus had impressive bowling figures when

DTB Gymkhana fielded, as the trio

notched two wickets each.

The youthful DTB Gymkhana side, later, efficiently mounted a successful chase, notching 122/5 in 19 overs to make it to the last four.

Abdullah Jabiri led the batting onslaught having posted 26 runs whilst nailing a boundary and a six.

Openers Kheel Suchak and Raghuvanshi had early on given the club a good start, with Suchak posting

16 runs and Raghuvanshi vans T20 Cup tournament, notching 19 runs.

Yunus took the crease following skipper Harsheel Shah's exit and forged an unbeaten partnership with Gurvinder Singh to catapult their club to victory.

The youthful Yunus notched 25 runs not out, whereas Singh made his way back with unbeaten 15

It is the only cricket competition organized by a private entity under the affiliation of the Tanzania Cricket Association (TCA) and the DC.

The showdown is regarded as the country's biggest T20 tournament and it is usually held during the last quarter of the year.

The competition is backed by several companies in the country which support the initiative as part of their Corporate Social Responsibilities.

Previous editions of the tournament have been graced by government officials and foreign envoys.

They include former Minister for Information, Culture, Arts and Sports Harrison Mwakyembe, his deputy Juliana Shonza, and Director of Sports in the Ministry of Culture, Arts and Sports, Yusuph Singo.

Former India's High Commissioner to Tanzania, Sandeep Arya, and top officials from various firms are other dignitaries that have graced the competition's previous editions.
