



## 100,000 lose homes as lake banks collapse

CLIMATE shocks, mainly the rapid rise of Lake Tanganyika, caused unprecedented internal migration in Burundi in recent years, a global NGO says.

Save the Children, a UK-based charity says that floods, storms and landslides led to a new displacement crisis in the region where at least 103,305 people were dislodged due to effects of climate change.

In a statement released over the weekend, it said that Burundi is among the 20 countries most vulnerable to climate change. It has the most people living along the shores of Lake Tanganyika among the four countries bordering it, it stated.

Bernard Sindayihebura, an environment management professor at the University of Burundi, said that the

lake – Africa's second-largest – rose to 776.4 metres above sea level in April compared to the normal average of 772.7 metres, due to storms, flooding and landslides.

Numerous homes and farms were inundated as a result, with hundreds of

THE Police Force has said that it is determined to eradicate criminal activities in Lake Victoria to enable fishermen to engage in their activities peacefully.

The pledge was made here yesterday by Commissioner of Police Liberatus Sabas, the head of operations and training at police headquarters, at a task force meeting with regional police commanders, regional CID officers, officers commanding districts (OCDs), fisheries officers and representatives of fishermen, and others.

The stakeholders came from Mwanza, Geita, Kagera, Simiyu and Mara regions while Tarime/Rorya district was represented as a special police zone. The key issue was how to eradicate criminal activities in the lake, which disrupt fishing and public security.

Commissioner Sabas said criminal incidents have gone down in Lake Victoria, but they need to be completely eradicated to enable the people conduct their businesses without fear all the time.

The task force meeting was convened to lay the basis for reinforced operations across all regions bordering the lake as well as particular strategies for trouble spots. The police will make sure they work together with other stakeholders to collect all relevant



families being displaced. In a survey early this month, those interviewed said they have no hope of returning home because their land had been lost to the swollen lake.

Communities in three other lakeside stated of Tanzania, Zambia and the Democratic Republic of Congo were also affected as during the past two years, persistent heavy rain and floods, landslides and strong winds raised Lake Tanganyika to overwhelm a portion of inhabitants near its banks

"People described waking up at night to find their homes and farms swallowed by the lake. Entire fields of crops were wiped out," the agency affirmed.

Over 90 per cent of the country's population lives in rural areas and depend on agriculture and livestock, with small landholdings, double- or triple-cropped plots are mostly rainfed, farmed by hand, and produce little or no marketed surplus.

The country faces the burden of impacts of global emissions and is poorly adapted to climate change (ranked 171 out of 181 countries in the 2015 Notre Dame Global Adaptation Index).

THE number of internet users in Tanzania has tremendously gone up from 3.6 million in 2005 to 29.2 million as of June, this year, a senior government official has said.

Deputy Permanent Secretary for the Ministry of Communications, Information and Technology (ICT), Dr. Jim Yonazi made the revelation recently in Dar es Salaam when speaking at the 1st International Conference on Digital transformation, themed; "Towards Digital Transformation in Education and Research".

Organized by the Tanzania Education and Research Network (TERNET), the conference brought on board academicians, researchers and innovators from Tanzania and International Stakeholders to share the knowledge in ICT industry, and Digital Transformation.

Dr Yonazi reiterated government's commitment to support the IT sector adding that Tanzania National ICT backbone will connect and reach every district in Tanzania by the year 2025.

"In order to bring about digital and economic transformation, Tanzania needs to have experts to manage, develop, plan, and utilise ICT for development," he said.

ICT consultant from Research Network for Uganda, Dr Tusu Tusubira who virtually participated in the conference said in developing countries context, digital transformation needs to specifically focus on higher education by harnessing the internet of things, artificial intelligence and open research in order for Africa to get in the forefront in the fifth industrial revolution.

Tusubira added that many African countries still face countless connectivity challenges and called upon African governments including Tanzania to take the same direction taken by Kenya and South Africa to ensure every student at higher learning institution owns a laptop.

A Rwandan court on Monday sentenced Paul Rusesabagina, a onetime hotel manager portrayed as a hero in a Hollywood film about the 1994 genocide, to 25 years in prison after he was convicted of terrorrelated charges.

Rusesabagina, 67, who was feted around the world after being portrayed by actor Don Cheadle in the film "Hotel Rwanda," is a vocal critic of President Paul Kagame. He has denied all charges and said he was kidnapped from Dubai this year to be put on trial. His supporters called the trial a sham, and proof of Kagame's ruthless treatment of political opponents.

sentence for Rusesabagina on nine charges, including terrorism, directed from abroad.

Rusesabagina has acknowledged his membership of the Rwanda Movement for Democratic Change (MRCD); a group opposed to Kagame's rule, but denied responsibility for violence carried out by its armed wing, the National Liberation Front (FLN).

Other defendants tried with him include Callixte Nsabimana, popularly known as Sankara, who

was a spokesman for the FLN and told the court Rusesabagina was not arson, taking hostages and forming a member of the armed wing. The an armed rebel group which he judges said the two groups were indistinguishable, referring to them as the MRCD-FLN.

"Rusesabagina is guilty of being a member of a terror group and participating in terror activities," Judge Beatrice Mukamurenzi said. "His act of terrorism led to death."

She said it was his first conviction, so he did not receive a life sentence, but that he could not get a lesser sentence because he boycotted the trial.

A swarm of bees has killed 63 endangered African penguins on a beach outside Cape Town.

**CAPE TOWN** 

The birds were found dead on Friday on the beach at Boulders, a popular tourist destination south of Cape Town.

They were part of a colony of African penguins (Spheniscus demersus) living in a nature reserve, which are considered endangered, according to the International Union for Conservation of Nature (IUCN) Red List.

The area is a national park and the Cape honey bees are part of the ecosystem.

"After tests, we found bee stings around the penguins' eyes," David

## Bees kill dozens of penguins facing threat in South Africa

Roberts, a clinical veterinarian and part of the Southern African Foundation for the Conservation of Coastal Birds, said on Sunday.

"This is a very rare occurrence. We do not expect it to happen often, it's a fluke. There were also dead bees on the scene."

The South African National Parks said the birds were taken to the foundation for post-mortem which showed all the penguins had multiple bee stings - and samples sent for disease and toxicology testing.

"There were no external physical injuries found on any of the birds," a parks statement said.

Some of the animals were found with 20 or more bee stings, spokeswoman for the South African Nature Conservation Authority SANParks Lauren Howard-Clayton, told the news agency on Monday.

Subsequent tests for toxins or pathogens were inconclusive.

Authorities are now searching for the hive to find out what may have triggered the bee attack, Howard-Clayton said.

The penguins, also known as Cape, black-footed or jackass penguins breed in South Africa and neighbouring Namibia.


Also gender based violence among women, persons with disabilities, youth and children are among the areas which need special attention as they are avenues which deny peace to many.



# AMREF pledges support in war on TB in Tanzania

AMREF Health Africa Tanzania has pledged continued cooperation with the government in the fight against tuberculosis (TB) and provision of reproductive health services.

The organisation through its USAID Afya Shirikishi project, funded by the United States Agency for International Development (USAID) Tanzania, is implementing a project which aims to increase access to and improve TB services and reproductive health services at the community level.

The assurance was made here by head of programmes, Amref Health Africa Tanzania, Dr Aisa Muya while speaking at the launch of 'Tanzania Stop TB Partnership', a programme aim at ending the diseases in the country.

She applauded the government for the efforts aimed at improving provision of health services in the country as well as dealing with both communicable and noncommunicable diseases.

Speaking about the launch of the programme, Dr Muya said "Tuberculosis is one of the world's top infectious killer today, it is airborne and can affect any one of us thus today's launch is a milestone".

The event was also attended by parliamentary TB caucus. Speaker of the National Assembly, Job Ndugai who was the chief guest at the launch observed that the efforts of various stakeholders who work with the government are important because Tanzania is among 30 countries with high TB burden worldwide.

According to speaker Ndugai, it is reported that globally, approximately there are 70 TB related deaths daily, translating to three deaths every hour.

"This coordination and partnership will contribute to reduce number of people with TB disease left undiagnosed and

untreated each year," said Ndugai

He said collaboration between the Stop TB chapter and Parliamentary TB caucus will not only increase political will, but also enhance accountability on domestic resources for TB in Tanzania.

Stop TB Tanzania board chairperson, Dr Peter Bujari noted that the struggles to eradicate TB is everyone battle, more now where co-infection of TB and COVID -19 can be even deadly and so the impact is far worse than expected.

"It is therefore, imperative that all key partners come together to plan, assess comparative advantage of each partners to build national movement that will ensure that all those at TB risk are tested and those infected are put on treatment," said the board chair.

AMREF Health Africa Tanzania through the USAID Afya Shirikishi project aims to increase access to and improve TB services and reproductive health services at the community level.

Project areas include Dar es Salaam, Geita, Katavi, Kigoma, Mwanza, Pwani, Rukwa, and Songwe.

It is working in collaboration with ministry of Health, Community Development, Gender, Elderly and Children, Zanzibar Ministry of Health and President's Office Regional Authority and Local Government, and Ministry of Education, Science and Technology (MOEST).



Olengurumwa stressed that there are still a lot of grievances from the people and human rights defenders at various levels of democratic processes and good governance adding that THRDC has been closely following up on the participation of human rights defenders to make

democratic processes.

"There has been an outcry that the results of the 2020 general election did not reflect a multi-party system in a democratic country, citizens rely on representation that reflects political systems," he intoned thus insisting that Tanzanian citizens rely on representation that reflects that democracy urging that all democratic processes be participatory.

He also cautioned the government to closely observe principles of democracy including inclusive citizen participation, freedom of assembly and access to information.

"Human rights are the foundation of democracy and the development of any nation and for any nation to prosper, the fundamentals of human rights must be respected in order to achieve sustainable development," he emphasized.

## Number of households using improved toilets in Iringa up by 80 per cent, reports RMO

#### Mufindi

THE implementation of a national sanitization campaign has led to an 80-percent increase in the number of households with improved toilets in Iringa Region.

Iringa Regional Medical Officer Khadija Haruni said this here over the weekend while inaugurating the upgrade of toilets from open-pit latrines to closed pit latrines at Mtili 'A' Primary School in Ikongosi Ward, Mufindi District.

She said that the campaign has helped improve sanitation in the region saying before the region had 17-percent of households with better toilets, but currently, the region has more than 80 percent of households with better toilets.

"I urge the school administration to develop a system to manage the cleanliness of these toilets in collaboration with the school's sanitation club that is" SWASH "of the school and eventually the toilets can last," said Khadija.

She said Mufindi district is one of the model districts in Iringa Region with no households that have no toilets at all, due to the implementation of a national sanitation campaign.

In 2011, as part of the Water Sector Development Programme (WSDP), the government launched the NSC, aiming to stimulate demand for and improve the supply of sanitation nationally with the overall goal of delivering health and education improvements.

The campaign has two phases. The first phase (2011-2015) focused on improving sanitation and hygiene conditions in households and schools in rural Tanzania.

The second phase (2016-2020) centered on improving these conditions in urban areas, in public spaces such as hospitals and health

He said the school, which was established in 1975, has a total of more than 350 students, so improving the toilets in the school will help improve sanitation and ultimately reduce epidemics.

Mufindi District Acting Education Officer Labrey Urassa thanked stakeholders through LIXIL for supporting the government's efforts to provide modern toilet facilities that will help improve sanitation for schools.

For his part, LIXIL Manager Justin Mbowe said that pit latrines provide an affordable solution to sanitation, especially to communities without access to sewage systems.

He pointed out that children can easily fall in, there is high risk of contact to faeces with flies flying in and out of the pit latrine, and bad odour becomes a challenge with constant use.

Mbowe elaborated that in collaboration with UNICEF and ministry of Health, LIXIL converted open pit latrines into closed pit latrines using smart toilets (SATO) toilet pans at Mtili 'A' Primary School in Mufindi.

## Despite good news, coffee investors facing problems

across the country time and time again find it hard bridging popular expectations by the citizenry and the reality - or what is achievable.

The case of crop purchasing either by government agencies or by private buyers provides a ready scenario.

One intense theme over the past few years in relation to agrosector development is the building of processing factories so that smallholder farmers find a ready and reliable market.

The snag is that world market prices for all crops, just like metals, finished commodities, clothing or electronics, keep fluctuating tend to decline yearly.

When prices for instance of coffee or maize rise, the reason is that there is frost (for coffee, say, in Brazil, the world's perennial top producer) or there is drought in neighbouring countries - and so we in Tanzania sell maize plentifully.

Images of this situation were visible when Prime Minister Kassim Majaliwa was assuring investors that the government is committed to protecting them and facilitating smooth investments in the country.

The assurance had different aspects of resonance, depending on the nature of the issue. For instance, there can be problems of permits issued by government officials, where it is perhaps charges by district councils which are at issue.

> Still, if one were to ask those officials, perhaps they would say that it is factory operators who either oppress peasants by offering low prices or don't take up corporate social responsibility intensely enough One reason investors are likely to continue facing problems is that there are sharply contrasting agencies at work in agro-sector transactions or facilitation, often with divergent interests and ability to turn events in their favour.

> The government may indeed be making the most it can to reassure investors against bureaucracy, but the result is that its popularity could still risk taking a dip.

> Bureaucratic happiness is tied with effectiveness in ensuring that investors toe the line of regulatory agencies, district councils, etc., and this may not work to satisfaction.

> These pressures could pull down agro-sector performance: coffee production is low in many districts because when prices are low for two years running, some farmers find no option but to turn to better-priced horticultural and other products.

> Smallholders need higher prices to survive, while global markets compete by lowering prices. Investors must meanwhile deal with marketing cooperatives, and capacity utilisation stalls.

### News organisations use automated news to cover Covid-19

N a sense, Covid-19 could be the perfect story to automate. As the virus spread across the world at the beginning of 2020, governments and health authorities made a considerable amount of open-source data available to the public, such as the number of deaths, patients in intensive care units, and seven-day incidence rates.

This type of well-arranged data, which can fit into narratives that can be created in advance, lavs the groundwork for a recent journalistic development known as "automated journalism", a computational process that creates automated pieces of news without any human intervention - except for the initial programming.

iournalists with their own writing. In my report for the Tow Centre, I documented the experiences of nine media organisations that have used automated news for reporting on Covid-19.

I found that most organisations used such news to provide a statistical overview of the spread of the coronavirus, through userfacing interfaces and new media products.

For instance, Swiss media company Tamedia and The Times (UK) featured national and international dashboards that summarised the latest Covid-19 data with automated text, along with a great many automated or semi-

newspaper, adding that this made comparisons between regions even more difficult.

In Norway, the news agency NTB faced an even bigger challenge. "Every Norwegian municipality has a different way of providing the data on their own pages. So it's like 356 municipalities, and they have 356 different ways of sharing the data," said a chief development officer at NTB.

Another challenge of relying on external datasets to automate Covid-19 stories had to do with erroneous data and sudden changes of format.

First, data published by health and governmental bodies could connected to these kinds of sources.

#### Adopting a computational mindset

To overcome the challenges of having to rely on external datasets to cover Covid-19 with automated news, media practitioners with a strong computing background at some of the organisations that I've studied developed ad hoc solutions to work around those.

To deal with data being released in various time zones, the Canadian Press set up an advanced shared spreadsheet system that involved the participation of journalists in all Canadian provinces and territories.

Too bad, experience shows that nations all over the world will gladly walk into war and destruction rather than "risk losing face or dignity" by buying the political compromise option.

There is something in popular management called a 'win-win' situation, which few of those who spend time in strategic studies or political analysis will admit really exists at the level of competitive politics or where economic interests are at issue.

All 'win-win' situations usually involve secondary matters where nothing is really contested, which often stalls progress or at times even leads to outbreaks of violence.

UN write-ups show a whole series of ceremonies linked to the commemoration of World Peace Day, with some countries devoted to observing it more than others on account of history.

For instance, Japan suffered untold destruction in 1945 made possible by an atomic bomb and has for decades anchored its institutions in a peaceful outlook in global order.

But this situation is under threat from newly emerging competition in the Far Eastern seas and nuclear weapons proliferation in the Korean Peninsula.

The US is still providing a nuclear umbrella in the zone, otherwise

**T**ORLD Peace Day, Japan would likely be rapidly scaling up its nuclear preparedness.

> There is something that the UN calls the 'culture of peace initiative'. but it hard to say at what point nations will durably choose a culture of peace and to what extent.

> No country avowedly wants war - and even the most deliberate aggressors during World War II had grievances as to the right to living room, or uniting different peoples.

> Hard-won peace in South Sudan is now breaking down owing to factional fighting in the ranks of the weaker party in the unity government, while Somalia is bogged down in president vs prime minister contests - amid a guerrilla war.

> Following insurgency-induced problems in parts of Mozambique, there is a new agenda by the Southern African Development Community (SADC) for security there.

Meanwhile, Tanzania's own participation in peace building efforts in Democratic Republic of Congo and the Sudan have proven of monumental use and relevance.

There is a rather similar scenario with respect to the IGAD intervention in war-ravaged Somalia, while the recent US departure from Afghanistan is a reminder of the futility of some invasions or wars.

Tanzania has every reason to cherish the much happier times it has enjoyed over the decades relative to many other countries, including just across its borders.

The cases we have touched on show that breaking up a nation is much easier than building it, as a tiny spark can trigger an inferno - no matter the status of that nation and hence the need to treasure the unity, peace and security we boast.

Automated journalism generally implies the use of algorithms that fetch information on external or internal datasets, and then fill in the blanks left on templates that have been pre-written.

This process, which can be compared to the word game Mad Libs, constitutes a basic application of Natural Language Generation (NLG), a computer technique that has been around for several decades in domains such as weather forecasts, sports and financial results.

NLG made a leap into journalism and was more widely discussed in the first half of the 2010s as The Los Angeles Times used automated text to report on homicides and earthquake alerts.

The Associated Press meanwhile partnered with the firm Automated Insights to automate stories on corporate earnings.

Numerous media organisations including major ones like Le Monde, The Washington Post and the BBC have subsequently adopted, or with automated experimented, journalism.

#### In-house, outsourced or thirdparty

Proponents of automated journalism typically develop their technology in-house, outsource it to an external content provider such as Syllabs in France and Narrativa in Spain and in the United States, or use third-party solutions so that journalists can design their own automated news, as it is made through Automated possible Insights' Wordsmith and Arria NLG Studio.

Automated news can then be published simultaneously at massive scale or used as first drafts to assist

automated graphics.

that some I also found organisations deployed new forms of newsroom workflows, where journalists contributed to the creation of automated news or worked directly with them.

At the British news agency RADAR, a new form of workflow where journalists are involved all the way into the process of setting up automated news - from finding storylines in newly published datasets to authoring templates using a third-party tool - demonstrated to be robust enough to handle the data deluge that followed the spread of the coronavirus.

At the Finnish newspaper Helsingin Sanomat, an algorithm set up by the data team fetched new Covid-19 numbers on a governmental API so as to generate short pieces of text that were sent to Slack to inform reporters. They could then decide to publish these as-is or tweak them before publication.

Challenges of relying on external datasets

In my report, I also illustrated some of the challenges that newsrooms faced when using automated news to cover Covid-19. Overall, these demonstrated the difficulties associated with having to rely on external datasets.

This was most notably the case with newsrooms trying to get data from several levels of government.

In Canada, a journalist-developer at the Canadian Press said that it was hard to get Covid-19 data from multiple governments.

"They all put it up in a different fashion; they put it up at different times," he said.

In the UK, The Times grappled with the same lack of cohesive efforts. "England, Scotland, Wales and Northern Ireland all publish it in different ways," said a data and interactive journalist at the

prove to be inaccurate. "Sometimes the data have been wrong and they're not corrected," said an editor at NTB. This could be even more problematic when it concerned the number of patients who have died from the virus.

Second, sudden changes of format were also considered to be a major obstacle in automating the coverage of the virus. For instance, the data team at Helsingin Sanomat experienced difficulties with some data being released in an HTML table format.

A data journalist explained that the table's structure kept changing all the time, for instance when the number of patients hospitalised was being moved from one column to another, making it very hard to use for automated news.

Finally, releasing data too soon or too late also came into consideration when working with external datasets to generate automated news on the spread of the disease.

Some media organisations occasionally reported a lag in releasing data on the pandemic, resulting in numbers accumulating over a few days before being published all at once with more upto-date data.

"In today's numbers, they might publish some deaths for a week ago," said an editor at RADAR, cautioning that reporters then needed to be extra careful when reporting differences between each of these dates.

On the other side of the coin, news organisations could also get the latest Covid-19 numbers before any official announcement, while connecting to an API service set up by governments or health authorities.

"Sometimes we have actually managed to kind of beat, so to speak, the local health sources on their own news," said a managing editor at Omni, a Swedish news service that used an automated dashboard

The Times and Helsingin Sanomat meanwhile developed an alert system to work around tight deadlines and sudden changes of format.

All in all, these ad hoc solutions demonstrate the importance for media practitioners being able to solve problems by applying computing skills, a form of knowledge commonly known as computational thinking or computational journalism in a newsroom setting.

This type of mindset has given journalists a considerable edge in deploying automated news quickly and efficiently in the midst of a global pandemic, but may also fuel ideas for the next iteration of these products.

Although the template-based approaches are sometimes criticised for being too formulaic and less enjoyable to read than human-written news, they can at least be tweaked to achieve editorial goals.

The more media practitioners engage with this tinkering of automated news systems, the more they develop their programmatic skills and thus reinforce their ability to exert control and have a say over the computational turn that journalism is taking.

## Potential for SA cities to suffer urban heat island effect an increasingly deadly threat

TTH rapidly rising temperatures due to climate change, South Africa's growing urban areas are a ticking time bomb. The building materials used in cities absorb and trap heat, contributing to the potentially deadly Urban Heat Island effect. And while heatwaves are less dramatic than hurricanes, floods and wildfires, they pose a significant threat to health and life.

Council for Scientific and Industrial Research (CSIR) studies on South African cities estimate that the urban heat island effect can increase temperatures by 3°C to 10°C compared to a city's hinterland. Those most at risk are the poor, elderly and young, people living in informal dwellings without proper insulation and ventilation, those reliant on public transport, and communities without access to green spaces and water.

Heatwaves are a global phenomenon, and in the past four decades the International Disaster Database has recorded 196 heat-related disasters. However, African statistics on heat emergencies are scarce – only eight of the 196 events came from the continent, and one was from South Africa.

Officially, just 11 fatalities have been attributed to severe heat in South Africa. Yet researchers studying excess deaths through temperature correlations found a very high mortality burden associated with warmer weather. Nearly 30,000 deaths in the country were directly attributable to increased temperatures from 1997 to 2013, pointing to severe underreporting.

While long-term and climate change adaptation plans acknowledge heat as a significant threat to South Africa, this isn't reflected in city preparedness or emergency response plans. Risk assessments are based on historical records, and if these are missing, they become almost invisible to disaster managers.

The CSIR's 2019 Green Book created a heat-stress matrix that highlights the cities most at risk. This is based on a projected rise

454 cities and towns primarily located towards the northwest, northern and central highlands face severe heat stress by 2050. The most significant risk will be in Upington and Kimberley (Northern Cape), Mahikeng (North West), Bloemfontein and Botshabelo (Free State), Lephalale and Musina (Limpopo) and Mbombela (Mpumalanga). In addition to more heatwaves and very hot days, these cities are all growing and expanding.

The building inventory created by GeoTerraImage shows that nearly half a million people live in 188,212 informal dwellings within these eight high-risk cities. All of them face a growing but imminent threat of increased morbidity and mortality.

Many of these at-risk cities and municipalities are utterly unprepared. All spheres of government should undertake disaster risk reduction, and the Disaster Management Act makes risk assessments compulsory. But these evaluations seldom translate into good practice. And although heatrelated hazards are mentioned in many local disaster management plans, a lack of historical data means few consider heatwaves a prevalent disaster. As a result, contingency plans are lacking.

The worst is yet to come, and the next couple of decades will bring more heat stress as temperatures rise and heatwaves increase in magnitude and frequency. Projections show that heat-related deaths among the elderly in South Africa can climb from a baseline of two deaths per 100,000 to as many as 20 to 50 deaths per 100,000 by 2050.

Europe's deadly 2003 heatwave cost 72,000 lives, with France alone losing nearly 20,000 people in under three weeks. Temperatures rose to record-breaking levels of 43°C. This tested Europe's climate change readiness and found it wanting. Now South Africa finds itself in a similar situation – unprepared and risking a significant loss of life.

After the disaster, France put avoid future devastation. A na-

The CSIR research shows that school closures, labour restrictions between certain hours and parks opening for extended periods. Databases of vulnerable people were drawn up, cooling rooms opened, and awareness campaigns were run. Shade and showers were provided at homeless shelters, water was placed in public spaces and on transport routes, and temporary spray parks were created.

> Longer-term climate adaptation steps were taken to make France more resilient in future. Cities started rolling out green roofs, increasing vegetation coverage, restoring ecosystems, protecting water provision services and changing construction regulations for better insulation and ventilation.

> These plans were tested in 2016 and again in 2019 when France experienced two back-to-back heatwaves that set all-time records. Mortality rates were significantly lower, even despite thermometers showing highs of 46°C.

> South Africa can learn from countries like France even if our circumstances are different. Many of the steps taken there are not suited to a water-scarce, electricity-constrained and unequal country such as South Africa.

As urbanisation continues, building adaptive capacity into the design of settlements will be vital for saving lives. Worthwhile initiatives such as C40's climate action plans are seeing cities such as Cape Town, Ekurhuleni, Ethikwini, Tshwane and Johannesburg pledge to build urban resilience. But South Africa needs to urgently pass the draft Climate Change Bill and implement the National Climate Change Adaptation Strategy.

Decisive mitigation actions worldwide will protect against future losses from heatwaves. However good disaster management plans and responses are needed to safeguard cities within the next few years. Municipalities must conduct a heat risk assessment and put in place heatwave contingency plans for high-risk settlements.

Good communication channels in place a series of responses to are needed between early warning systems and local govern-

## Plea for stronger partnership amid growing global uncertainties

#### BEIJING

N the face of multiple pressing challenges and growing uncertainties across the globe, the 20-year-old Shanghai Cooperation Organization (SCO), the world's largest and most populous regional institution, has both the responsibility and the capacity to play a more constructive role in enhancing regional security and pursuing common development.

As leaders of the SCO members -- China, Kazakhstan, Kyrgyzstan, Russia, Tajikistan, Uzbekistan, India and Pakistan -- convene via video link on Friday, all eyes are on them to see how they will take the good opportunity to better coordinate and pool their endeavors to tide over the trying times and draw a blueprint for a shared future. Under the guidance of the Shanghai Spirit, a bedrock principle of the bloc, the SCO countries have rendered each other respect and support, forging a new type of international relations featuring mutual respect and win-win cooperation.

After two decades of growth, the organization, now with eight full members, four observer countries and six dialogue partners, has become not only a strong pillar of regional peace and security, but also a major platform to promote cooperation and exchanges on the vast Eurasian landmass. Its members have been joining forces to fight against the "three evil forces" of terrorism, separatism and extremism, bolster trade and economic growth, and advance people-to-people ties.

In 2020, the combined economic size of the SCO countries reached 18.4 trillion U.S. dollars, an 11-fold increase since its founding, while intra-SCO trade jumped eight times to 6.2 trillion dollars over the same period. People-to-people exchanges have also maintained strong momentum.

Back in 2019, before the COVID-19 pandemic, the number of visits between China and other SCO members exceeded 7 million, 3.5 times as many as in 2001.

When the contagious disease broke out in many parts of the world, the SCO members have demonstrated a spirit of solidarity. They have helped each other to control the spread of the coronavirus and safeguard public health, and taken a clear stance against political manipulation of the pandemic.

The 20-year landmark is a new starting point. The organization, which covers three-fifths of the Eurasian continent, nearly half of the world's population, and over 20 percent of the global gross domestic product, is looking to work more closely and earnestly to enhance its "three pillars," or the three major cooperation areas of security, economy and people-to-people exchanges.

The SCO members need to maintain close coordination and forge a stronger partnership to safeguard the region's peace and stability, which is also the primary purpose of the organization.

As for the Afghanistan issue, the SCO needs to build consensus and work together with other groups such as the Collective Security Treaty Organization to prevent a resurgence of terrorism, promote reconciliation, help reconstruct the war-torn country, and make sure that the country will not fall into chaos once again.

Another pressing task for the organization is to step up cooperation in public health governance. Its members have to accelerate vaccine distribution and make vaccines more accessible, and strengthen coordination to facilitate the cross-border movements of both people and goods in an orderly and safe manner.

The difficult moment calls for more support and efforts in keeping the global industrial chains running smoothly and building a more open, equitable and inclusive world economy.

To revitalize the hard-hit economy in the throes of a still-raging pandemic, the SCO members should firmly stick to multilateralism and openness, facilitate trade and investment, and boost connectivity and integration in the region.

The Belt and Road Initiative has offered a unique chance for the SCO countries to synergize their respective development plans, tap further into their huge potential and rev up practical cooperation.

Last but not the least, it is necessary to increase people-to-people exchanges

and enhance mutual understanding within the organization, as flourishing peopleto-people exchanges have consolidated public support for the SCO's growth, and will continue to play a key role in its allround cooperation.

Shanghai, the six founding members announced the creation of the SCO, ushering in a new era that countries in the region are jointly pursuing security, development and prosperity.

Today, as the world is going through Twenty years ago, in the Chinese city of an era of profound changes, it befits its

Fundamental changes needed at UN summit to tackle global food insecurity

OVID-19 has exposed numerous fractures in global food systems that leave millions at risk of food insecurity. Like the numerous political failures in dealing with COVID, the repercussions of food system failings are experienced by rich and poor countries alike, with the poorest and most marginalised paying the greatest price.

To be clear, while the numbers of those who are un-

focused on its inclusion of 'Big Food', including names such as PepsiCo who were invited to 'fireside chats' as part of the Pre-Summit in Rome.

Of course, food companies are an essential part of the food system. Indeed, had the Summit engaged first in a root cause analysis of the problems that have contributed to the syndemic (synergistic epidemic) - of undernutrition, obesity and

highly and ultraprocessed foods.

Discussion of such issues, alongside such products' environmental impacts, have been minimised as part of the Summit process. Was that to avoid Big Food's' discomfort at discussing the most unhealthy and unsustainable foods?

UN organisations and their staff are well aware of such issues but have been pressured to "come to the table" with companies they know are more interested in driving shareholder value than contributing to sustainability and public health. Such companies have a history of unethical marketing of unhealthy foods to children, or persuading poor mothers not to breastfeed. Fortunately, there are conflict of interest rules and protocols that exist to protect the day to day work of UN organisations so that they can fulfil their public mandate without such unethical interference. As part of our own contribution to the Summit planning and to help it overcome such criticisms, two of us led an ad-hoc committee focused on the Summit's own 'principles of engagement'. We also wrote to the UN Secretary General and the Summit leadership to suggest that the Summit simply follow the UN's own conflict of interest rules and be transparent about who was involved in shaping Summit processes and why.

What we have seen ahead of this week's Summit is a lot of "nutri-washing" and thousands of proposals reflecting the voices of well-nourished people and little (if any) proposals for putting an end to hunger and other forms of malnourishment as a political priority by governments around the world.

dernourished remain shamefully high, this is a food crisis that is not just about hunger or famine. There is also a silent and growing crisis of an estimated 38.9 million children worldwide affected by overweight and in too many cases, these children grow into adults facing unhealthy eating and chronic diseases associated with obesity (diabetes, heart disease and some cancers etc.).

Alongside these dual burdens of malnutrition, there is a third crisis - climate change - which the food and agriculture is a major contributor to as well as being vulnerable to its impacts, and therefore further threatening food security.

The United Nations (UN) Food Systems Summit on 23 September 2021 was conceived (in the jargon of the UN) to develop equitable, healthy and sustainable responses to ensure that "no one is left behind" as we "build back better" from COVID-19.

Forty one thousand people have taken part in Summit dialogues but the process has been marred by continual criticism, particularly for its inadequate attention to human rights, the sovereignty of indigenous peoples over their own food systems, and worker rights across the food system.

More than anything, criticism of the Summit has

climate change - all issues the Summit portends to address - corporate concentration, negligence and unbridled power would have been identified as the primary cause of policy inertia.

There is no doubt that corporations will need to radically transform as part of the changes advocated by the Summit. But they won't do that on their own and they certainly won't do that as part of cosy fireside chats.

Yes, this will take dialogue, but the record on this to date is poor. In many global and national spaces, rather than be "part of the conversation", there is widely documented academic evidence of big food companies trying to shape the outcomes in their interest: towards voluntary measures and empty promises, away from the regulation (such as front of packet labels) and taxation (such as soda taxes) which have been shown to be most effective in minimising the damage from unhealthy,

letter due to popular demand, including the American Heart Association and a co-author of this opinion article, the ex-Director of the UN Food and Agriculture Organisation (now Director General of Brazil's Zero Hunger Institute).

But from the leadership of the summit itself, nothing in reply.

You may ask who cares about these UN summits, really? We do and everyone else should too. Such summits set the scene for national action, they define future funding patterns for UN and bilateral aid organisations, they spawn decades of debate on the issues raised, and, if not well conceived, they provide nice sounding cover for the status-quo.

Behind the multiple fights that have raged in the privileged world of these global debates, there are real issues that will play out in multiple ways in every country faced with the global food and climate emergencies and the inequities that caused them, made all the more raw

The final speech by UN Secretary General Antonio Guterres could be a turning point to change this, but not if he chooses to paper over the sensitivities when addressing contentious issues, as UN leaders are wont to do.

If you haven't yet, get involved, even after the Summit on 23rd September. This battle will rage on including in your own country as it faces up to these multiple food and climate crises and as policy makers face numerous influences over policy directions in response.

All future UN processes should be governed by a simple set of rules set by the precedent of past UN organisations and international summits where conflicts of interest have been taken seriously. This will set the standard for national debates across the world, which is where the real work begins.

## Tanroads urges govt to switch to new culverts technology

THE Tanzania National Roads Agency (Tanroads) has called on the government to venture into the Weholite technology, which has proved to be effective, affordable, and makes roads durable.

Tanroads Coast regional manager Eng. Upendo Mshana made the call over the weekend when she inspected the Visegese pilot project in Kisarawe District.

"We have received this technology and see how effective it is to our pilot project, therefore we would like to advise the government to increase budget so that we can adopt this technology in most of our roads, as it is easy and uses a short period of times," she said, adding that the technology can be installed in all weather conditions.

Eng. Mshana also highlighted that though the Weholite technol-

ogy is expensive compared to the concrete culverts its affordability comes from time and durability.

"We spent 85m/- when installing three Weholite technologies at Visegese Bridge, but it was at the peak of the raining season with floods and we managed and also spent one week to finish it and return communications," she emphasized.

For his part, Director of the Tanzania Rural and Urban Roads Agency (TARURA) Kibaha, Abdul Digaga said the agency has started using the technology in some of its projects insisting that this time the government set aside more funds for its roads.

Digaga also said that the technology is effective for emergency purposes in rural areas because of its quick installation and flexibility to withstand high loads.

our projects so that we can be able to use this technology in our culverts and other projects especially in highly emergency needs," he stressed, adding: "We're now looking at how we can include the ministry and experts in order to adopt Weholite in our projects.'

"TARURA believes that in fighting against various disasters like floods it is a must to have solutions like this technology because concrete culverts are expensive compared to Weholite technology," he stated He gave an example that Weholite culverts are 30 percent less compared to concrete culverts whereby the completion of a structure is constructed for 100m/-, then it can be completed with only 70m/- by using Weholite technology.

Plasco Ltd chief operating officer, Alimiya Osman said Weholite technology is an alternative for "We are planning to set funds in concrete culverts in roads and railways culverts construction because it is lightweight, tolerant to ground movement and easy to handle.

"The world is changing and hence we should change by adopting the latest technologies because it saves time and money," he encouraged, adding that while using concrete culverts, there is a need to complete some processes for it to be installed but Weholite doesn't need time to dry compared to concrete which uses cement.

Osman underscored that a contractor can spend from 3 to 4 weeks in putting concrete culverts, something which needs money and time but with Weholite a contractor can save time and money by taking only a day or even a week to finish the project.

He mentioned that during disasters where communications are destroyed and special and economic activities stop, Weholite can be the best solution in restoring those activities.

"As a company, we are incredibly proud to think that we can contribute to a better Tanzania, by helping to build our nation on world-class infrastructure such as Weholite," he intoned.

UBBED 'the People's Summit, the United Nations Food Systems Summit (UNFSS) hopes to put the world back on a path to achieve the Sustainable Development Goals by 2030, through food systems overhauling. From the tempered to the extremely optimistic, experts in various food system sectors share their expectations of transformation.

The world has been lagging on ambitious climate, biodiversity and sustainable development goals, but the UNFSS is hoping that commitments to transform global food systems will get the world back on track to meeting the Sustainable Development Goals by 2030.

The inaugural UNFSS will take place virtually during the UN General Assembly High-Level Week, under the leadership of UN Secretary-General António Guterres.

Barilla Foundation Report Highlights Need for Food Companies to Align with Sustainable Development Goals

Q&A: Why the World 'Can't Afford to Wait' for Transparent, Equitable Food Systems

It promises to bring together the public and private sectors, non-governmental organisations, farmers groups, indigenous leaders, youth representatives and researchers to outline a clear path to ensure that the world's food production and distribution are safe, healthy, sustainable and equitable.

Learning from the lessons of the COVID-19 pandemic, the summit also hopes to make food production and distribution more resilient to vulnerabilities, stress and shocks.

Experts in sustainability and various food system sectors have been speaking about their expec-

tations and hopes for a summit that is built on solutions to some of the world's most pressing issues such as land degradation, inequality, rising hunger, and obesity.

Panellists at a Barilla Center for Food and Nutrition (BCFN) 'Fixing the Business of Food' webinar held on September 16, 2021, were asked how optimistic they were, on a scale of 1 to 10, of real food systems transformation in the next 12 months, triggered by the private sector.

"I am going to give a full 10," said Viktoria de Bourbon de Parme, Head of Food Processing at the World Benchmarking Alliance. "I am super optimistic," she added. "I think we are there. Momentum is there, and it is going to happen." Executive Director of Food and

Nature at the World Business Council for Sustainable Development Diane Holdorf is similarly optimistic.

"I would say an 8 out of 10, but I do have to preface this by saying that systems change is complex. With individual leading companies demonstrating what is possible and bringing others along, we are going to see for sure actual system changes," she said.

Not all experts are optimistic that the UNFSS will bring about the urgent changes required for food systems transformation.

IPS spoke with Million Belay, the Alliance for Food Sovereignty in Africa (AFSA) head, about his expectations for the summit.

Belay, who is also an advisory board member for BCFN and a food systems researcher, said that he and alliance members disagree with the summit's agenda and structure. The alliance represents farmers, pastoralists, hunter/gatherers, faith-based organisations, indigenous peoples and women's groups,

"The pre-summit has happened in Rome. During that presummit, we had our own summit, organised by civil society mechanisms, and it was clear that farmers, fisherfolk, indigenous people, local

groups, and women's organisations were all saying no, the UNFFS summit does not represent us. There is no reason to be part of that," Belay said.

Belay believes that the Committee on World Food Security (CFS) should have been responsible for organising the Summit.

"This is a space where the civil society in general and the civil society mechanism and governments come together to negotiate about food-related issues, so the agenda should have been set there," he said, adding that, "the UNF-SS has set up a scientific body as part of the structure, but we already have a scientific body in the CFS, that is called the High-Level Panel of Experts on Food Security and Nutrition. It is a scientific body, and you can say that we need to beef up this body, but they have established a totally different scientific body."

While expectations from the summit differ,

the experts are unanimous in their view that the world is in urgent need of radical change in how food is grown, sold and distributed to tackle food insecurity, land degradation and rising poverty. "(The Summit) is one step on a very, very long journey. Perhaps more than ever, as the UN General Assembly opens, we feel the weight and burdens of non-sustainability in the world," said Jeffrey Sachs, Director of the Center for Sustainable Development at Columbia University.

Sachs says the transformation to sustainable development will demand deep energy and fiscal policy change.

With land-use accounting for about 30 percent of all greenhouse gas emissions and ensuing issues like deforestation and loss of habitat, he is calling for fundamental change in landuse policies across the globe, adding that current, unsustainable use is a 'massive contributor to crises the board.'

Another aspect of the complex global food system that requires urgent attention is the need for healthy diets.

"About half the world does not have a healthy diet. Of the 8 billion people on the planet, roughly 1 billion live in extreme hunger. Another 2 billion live with one or more micronutrient deficiencies, anaemia, vitamin deficiencies or omega-three fatty acid deficiencies, which are absolutely debilitating for health. Another billion people are obese," Sachs said.

This week's UNFSS hopes to get commitments from governments, the private sector, farmers and indigenous groups to work together and change global food production and consumption.

'US a disruptor of global peace in every sense'

#### BEIJING

N the bloody drone strike on what the U.S. military claimed "suspected suicide bombers" in Afghanistan late August, 10 members of one family, including a twoyear-old girl, were killed. All of them were innocent civilians.

However, when U.S. media raised doubts with evidences suggesting the targeted vehicle contained no explosives and the family had no connection to terrorist groups, a spokesperson for the U.S. Ministry of Defense understated the attack, saying "not aware of any plans to put investigators on the

ground." The remarks are a typical reflection of Washington's disregard for life. For centuries, the United States has been obsessed with aggressive wars. Its endless military actions have seriously violated human rights and caused tremendous humanitarian disasters across the world, and made the country the biggest saboteur of global peace and stability.

As U.S. historian Paul Atwood put it, "War is the American way of life." Since its independence on July 4, 1776, in more than 240 years, the United States was not at war for merely 16 years. Its path towards global dominance was built on wars, directly killed in war-relat-

slavery and slaughters. After the end of World War II, the United States has launched a series of wars in foreign lands and brought about conflicts and chaos in many places of the world, leaving horrific civilian casualties and property damage. Take the Iraq War as an example. Amid global oppositions, Washington invaded the oilrich country in 2003 with allegations that the country possessed weapons of mass destruction, although there was no concrete evidence. According to Brown University's Watson Institute for International and Public Affairs, between 184,382 and 207,156 Iraqi civilians were

ed violence in the country. The invaders also deployed such weapons as depleted uranium bombs and whitephosphorus bombs during the war, which has posed a grave threat to local environment and the public health. According to the Iraqi authorities, prior to the First Gulf War in 1991, the rate of cancer cases in Iraq was 40 out of 100,000 people, while by 2005, the figure had soared to at least 1,600 out of 100,000.

## Coast RC calls on corporations to back donation of artificial limbs as thousands in need

record 130,000 residents of Coast Region have defective limbs emanating from accidents but also natural disabilities hence companies should back government efforts to provide ⊾ them with artificial limbs.

Coast Regional Commissioner, Abubakari Kunenge said last week during a ceremony where Kamal Group donated 100 artificial limbs to assist maimed people, that many of the victims need donations because they cannot afford to buy them.

## Nigeria's Dangote in talks with traders for oil refinery finding

The 650,000 barrel-per-day refinery, once complete, will be the continent's largest plant and redraw major trade flows of crude and fuel in the Atlantic basin. Despite being Africa's biggest oil producer and exporter, the country depends almost entirely on fuel imports after allowing its significant refining capacity, 445,000 barrels-perday, to become dilapidated over several decades. Many past and current Nigerian officials, inwill has been lacking.

The Natural Resources Governance Institute, a non-profit policy think tank, has previously pointed to the moribund refineries as a key focus of oil corruption and waste in the country. Hit by economic consequences of the Covid-19 pandemic and soaring construction costs, Dangote needs a cash iniection.

Nigeria's state oil firm NNPC has agreed to buy a 20% stake in the refinery for about \$2.8bn, but Dangote is looking for outside cash. NNPC's head Mele Kyari said a process was ongoing to raise \$1bn with Afreximbank to fund part of its stake purchase.

The billionaire has held talks as recently as a month ago with executives from the world's top has ballooned to \$19bn from cluding President Muhammadu two oil traders - Trafigura and Dangote's earlier estimates of

"The company is not in any talks with the aforementioned oil traders to seek a loan to finance our project," the management of Dangote Industries Ltd said in a statement. Trafigura and Vitol declined to comment. Two separate sources with direct knowledge of the matter said the option of raising another \$500m from a trade house or consortium was being explored. The details of a potential loan from a trading firm have not been finalised but the trader could receive a longterm contract to supply crude and receive cargoes of refined products as repayment.

The refinery has been delayed by several years and the cost

ers like Vitol, along with Nigerian firms, have cashed-in for years in gasoline-short Nigeria by supplying mega tenders and being part of lucrative crude-for-fuel swap deals for over a decade.

Getting a hold of Dangote's fuel will give the trader a stranglehold on a key set of new oil flows. Nigeria's new oil bill, approved last month after nearly 20 years of political wrangling, has added fuelimport licence requirements that experts fear will give Dangote an effective monopoly.

Under the new laws, the regulator will prioritise local refiners for import licences and volumes would be based on production capacity or market share. While Nigeria will remain open in theory to international trading houses, a partnership with Dangote would be the only way to guarantee a foothold in Africa's biggest economy.

## Climate finance by rich countries surges 2pc in 2019 but set to miss \$100bn target

#### PARIS

FINANCE provided and mobilised by developed countries to help poor countries tackle climate change rose 2 per cent annually in 2019 to \$79.6 billion but is expected to fall short of the target of \$100bn by 2020, according to a report from the Organisation for Economic Co-operation and Development (OECD). The data has yet to be calculated for 2020.

"Climate finance continued to grow in 2019 but developed countries remain \$20bn short of meeting the 2020 goal of mobilising \$100bn," OECD secretary general Mathias Cormann said on Friday. "The limited progress in overall climate finance volumes between 2018 and 2019 is disappointing, particularly ahead of Cop26. While appropriately verified data for 2020 will not be available until early next year, it is clear that climate finance will remain well short of its target," Mr Cormann said.

The report comes as UN chief Antonio

Guterres urged developed countries to do more to help poor countries fight the adverse effects of the climate change and make the upcoming Cop26 conference a success. The UN Cop26 conference in Glasgow, Scotland, in November aims to bring much more ambitious climate action and mobilise funds from participants around the globe to tackle climate change.

"More needs to be done. We know that donor countries recognise this, with Canada and Germany now taking forward a delivery plan for mobilising the additional finance required to reach the \$100bn a year goal," Mr Cormann added.

Asia has been the main beneficiary of climate finance over 2016 to 2019 period, receiving 43 per cent of the total on average, followed by Africa on 26 per cent and the Americas at 17 per cent, according to OECD data.

Climate finance for Least Developed Countries rose strongly in 2019, up 27 per cent compared to the previous year, but

funding for Small Island Developing States (SIDS) fell back to 2017 levels, after an increase in 2018.

"SIDS face specific challenges in accessing climate finance. The international community needs to consider financing for climate that is appropriate for the challenges that SIDS face, less fragmented, easier to access, predictable and long-term," the OECD report said.

Public climate finance from developed countries accounted for the lion's share of the 2019 figure, amounting to \$62.9bn, while government-backed export credits reached \$2.6bn. The rest, about \$14bn, came from private investment mobilised by public mechanisms.

The public grant financing jumped 30 per cent year-on-year to reach \$16.7bn in 2019, after having remained stable during the three previous years, according to the data. The volume of public loans, on the other hand fell by 5 per cent in 2019.

The report also shows more than half of total climate finance targeted economic infrastructure, mostly energy and transport, with much of the remainder going to agriculture and social infrastructure - notably water and sanitation.

"It is more urgent than ever that developed countries step up their efforts to deliver finance for climate action in developing countries, particularly to support poor and vulnerable countries to build resilience against the growing impacts of climate change," Mr Cormann said. The EU this week committed more climate funds for developing countries and urged the US to step up, according to Reuters.

US President Joe Biden in April committed to double US public climate finance by 2024, compared to average levels during former president Barack Obama's administration. Experts and campaigners are urging the world's biggest economy to do more.

# Big relief as UK removes Kenya from travel ban list

#### NAIROBI

TRAVELLERS from Kenya will now be allowed into the United Kingdom from next week after Britain revised its Covid-19 travel list in a fresh boost for tourism, which is currently in its peak season. The UK moved Kenya from its Red List to Amber along with seven other countries -Egypt, Turkey, Pakistan, Maldives, Sri Lanka, Oman, and Bangladesh.

Travellers arriving in the UK from countries on the Red List are denied entry while returning Britons must submit to 10 days of mandatory quarantine in hotels. UK nationals are barred from travelling to those countries.

Kenya was placed in the Red List in April following the spread of the highly contagious Covid-19 Delta variant in the country, dealing a blow to the tourism sector.

The revision, announced by British Transport Secretary Grant Shapps on Friday, offers a boost to the Kenyan hospitality industry, whose tourism season traditionally peaks from July to September, coinciding with the country's dry season and the worldrenowned migration of wildebeest and zebra through Maasai Mara Game Reserve. Kenya is a popular tourism

destination for Britons, with the UK ranking fourth for the fourth largest arrivals through the Jomo Kenvatta International Airport in 2019.

After the announcement, British High Commissioner to Kenva, Ms Jane Marriott, said: "Kenya is off the red list. I know how this has been difficult but our Kenya-UK partnership remains strong. Thank you, the Government of Kenya, for working closely with us over the past few months. The fight against Covid-19 is still not over, from vaccines to genomic sequencing - we will continue to work together to beat the pandemic." The UK has segmented countries into green, amber and red lists, each carrying different degrees of restrictions for arrivals back to Britain.

People coming from Amber List countries quarantine for 10 days at home or place of stay and have to provide evidence of three negative Covid tests -- one before returning to the UK, one on day two and another on day eight.

People coming from Green List countries do not have to quarantine and have to provide evidence of two negative Covid tests -- one before returning to the UK and one on day two. The move to the Amber list will take effect from 4am on Wednesday, September 22.

THE shipping industry urged the UK to back its "moon-shot" \$5 billion research and development fund on Thursday, which aims to get ocean going zero-emission ships in the water by 2030 and help the sector achieve net zero by 2050

While the British government called for net zero global shipping emissions by 2050 earlier this week, the UK has yet to back a proposal to fund the research and development of alternative zero-carbon fuels and propulsion systems to ensure that target is achievable, according to the International Chamber of Shipping.

Simon Bennett, deputy secretary general at the ICS, said the UK government needs to be asked "why they are not publicly supporting" the industry proposal, before the country hosts the Cop26 environment summit in November.

"At the moment, the UK has not had its name on that paper, despite being asked repeatedly to put its name on it. Why is that?", Mr Bennett said, at a seminar ICS hosted to tie in with London International Shipping Week.

"Net zero is plausible, but it's what is required in order to make it happen. And that includes approving this research fund so that we can accelerate the technology."

To date, the \$5bn R&D fund has been backed by 10 countries, including Japan, Malta, Nigeria, Singapore, Switzerland and Denmark. While international regulations require the global shipping industry to cut its emissions by 50 per cent compared with 2008 levels, the UK Chamber of Shipping said at the start of the week it wants the International Maritime Organisation to double this target and commit to net zero emissions by the middle of the century.

## Shipping industry urges UK to back \$5bn **R&D** fund and meet net zero challenge

"Taking action now allows us to lead only plausible if governments in the charge on this global shift, creating co-operation with the industry, do highly skilled jobs for British workers and shaping the landscape for what clean shipping and trade will look like for future generations," UK Transport Secretary Grant Shapps said earlier this week.

The government said it was pushing for absolute zero emissions, which means no offsetting and no carbon emissions, a significant increase in ambition for the sector, which is currently accountable for 3 per cent of global emissions.

The UK's backing of a 2050 net zero target for international shipping, which transports about \$14 trillion worth of goods every year, must be agreed through the IMO, the UN's regulatory body on shipping.

This week, Mr Shapps also highlighted his ambition to have zero-emission vessels entering into commercial service by 2025. Mr Bennett said the industry has accepted the challenge to meet the IMO's target of halving emissions by 2050.

However, "The problem at the moment is that the technology readiness levels are simply not mature enough," he said. "There's always announcements about exciting new developments with zero carbon ships, but realistically, it's very hard to see how we're going to have thousands of zero carbon ships appear by 2030, which given the 25-year lifespan of ships is going to be necessary if we are going to have a realistic chance of meeting that 2050 target," he said. Guy Platten, secretary general of the ICS, said decarbonisation is top of the agenda for every single shipping company, with the industry understanding the need to "compromise" and to do so quickly.

# Ethiopia Telecom is moved closer to being privatised

THE Ethiopian government has finally released a Request for Proposal (RFP) for the partial privatisation of state-owned operator Ethio Telecom. The government wants to sell a 40% stake in the company in a move that is widely considered an effort to make the telco more competitive.

The aim of the RFP is to invite proposals from interested parties who, according to authorities, "can add value to the company by bringing in the best practices in terms of operations, infrastructure management and next generation technological capabilities."

The government wants to tap into the potential of the country's telecommunications industry and believes Ethiopia's fast-growing economy, its youthful population and its low tele-density are key reasons to attract private investment. According to the RFP, Ethio Telecom's robust telecommunication infrastructure coupled with a strong financial performance will offer significant competitive to any investor.

Ethiopia's Ministry of Finance stated: "This RFP is open to all interested parties and not limited to those companies who indicated their interest by submitting an Expression of Interest." The government also plans to sell a 5% stake in the company to local investors via an initial public offering (IPO). The government will retain a 55% controlling share in the company.

In June this year, Deputy Director of Public Enterprises Holding and Administration Agency Zinabu Yirga said, "The government wants to make sure that the state-owned enterprises become competitive and productive and therefore, 40% of Ethio Telecom will be sold to a foreign operator."

Kenya's Safaricom, part of a consortium of operators including Vodafone, Vodacom, the UK's CDC Group and Japan's Sumitomo Corp is set to launch operations in Ethiopia next year after being awarded an operating licence and compete with Ethio Telecom that has been providing telecommunication services in the country as a monopoly. Currently, Ethio Telecom has over 53 million mobile phone subscribers.

The WB report highlighted tourism as central to the country's economy, livelihoods and poverty reduction, particularly for women, who make up 72 percent of all workers in the tourism sector. "The economic system around tourism has grown in value over the years and in 2019

was the largest foreign exchange earner, the second largest contributor to GDP and the third largest contributor to employment, " the report noted.

"Tourism offers countries like Tanzania which has abundant natural and cultural endowments, access to lucrative foreign markets," according to Shaun Mann, the World Bank Senior Private Sector Development Specialist and co-author of the Tanzania Economic Update.

The semi autonomous island of Zanzibar has also witnessed its economy is also struggling with reports indicating that it has severely impacted on GDP growth, slowing down to an estimated 1.3 percent.

Tanzania still faces an uphill task in promoting its full tourism potential but with the Royal Tour as a benchmark, the tourism sector players should come up with long-term strategies to ensure sustainable recovery of the tourism industry so as to attract new foreign and domestic investments.

Revamping Tanzania's tourism sector should go hand in hand in addressing the long-term challenges of the sector if it is to record positive results in the future. Special focus should be put on reducing red tape and improving the investment climate, market diversification and tourism players should come up with new business models under the Public Private Partnerships model.

Now that President Samia has taken an impressive action to bolster the sector, Ministry of Natural Resources and Tourism should embark on building a resilient and sustainable tourism sector by implementing an aggressive 'Visit Tanzania' global marketing campaign to increase international tourists numbers. This campaign should ensure that the tourists get unmatched services at competitive prices.

#### Salt firms sue Kilifi over 'illegal' cess NAIROBI

FOUR large scale salt producers in the country have challenged a demand for cess for salt by the county government of Kilifi without a supporting legal framework.

They claim that the county, government through its Finance Bill 2018, proposed to increase cess on salt from Sh60 to Sh200 per tonne and further issued a verbal demand for payment for the salt extracted and transported from salt mines. The companies, which have also sued the County Assembly of Kilifi and the Attorney-General are Krystaline Salt, Ken Salt, Malindi Salt Works and Kurawa Industries, all based in Kilifi.

In their petition filed at the High Court in Malindi, they want an order stopping the county government from levying of cess for salt. According to the companies, the increment of cess fee affects the cost of extraction, processing, packaging, transportation and exportation of the salt, which in turn has adverse financial impact on the national government.

"There exists no such constitutional or statutory foundation for the levying of cess on salt extraction. Despite the illegal and unconstitutional collection, the county government has never channelled any money collected in form of cess back to the salt industry," argue the companies. The firms, in their suit papers, claim that the respondents do not provide any service to them that would warrant to charge cess on salt.

They also argue that they not only contribute towards generating revenue for the national government through salt exportation, but continue to engage in corporate social responsibility projects within the county.

The companies further argue that the salt industry is being forced to deal with extortion coupled with operations that are labour intensive with high cost of maintaining plants and equipment due to heavy corrosion arising from the proximity to sea water. They argue that the salt industry employs over 7,000 people with an estimated 70,000 community members and traders among other stakeholders depending on it for livelihood.

"The tax burden imposed on the petitioners is a ploy to coerce them to pay the county government and the county assembly money that is not due and owing," argues the petitioners. The salt firms also accuse the county government of demanding land rates based on various rates prescribed in the county's valuation roll and payable to the (county's) revenue fund.

Krystaline Salt, Ken Salt, Malindi Salt Works and Kurawa Industries further say that over the years, the rates have risen over 1,000 per cent. "For the respondents to pass a law increasing the rates with an excess of four per cent of unimproved site value, an approval is required from the Cabinet Secretary, which has never been sought," argue the companies.

The companies said that the formulation process of the draft valuation roll was done without their involvement or consultation yet the county government continues to demand land rates from them and other rate payers.

## Swiss-financed ActionAid-implemented project changing women's lives in

A Swiss Agency for Development Cooperation backed project being implemented by ActionAid Tanzania is changing lives of smallholder women farmers in Mbozi district of Songwe region.

The SDC's National Project Manager, Samwely Mkwatwa said recently that the U\$800,000 (over 1.6bn/-) project has trained and equipped the women with knowledge and skills in agro-ecology farming hence weaning them from artificial inputs modern farming.

Mkwatwa said the smallholder women farmers are now using modern agro-ecology farming methods, access extension officers while accessing agro-inputs which boost quality and quantity of their farm produce

"We have also been working with the government in this project which can be spread to other parts of the country because there are many women farmers in rural areas who cannot afford to purchase inputs such hybrid seeds, fertilizers and the like," he said.

The SDC Manager further explained that since 2019, the Swiss agency donated the money to ActionAid Tanzania to implement Phase 11 of the project that will be completed in 2023. In Phase I, the agency donated U\$500,000 in 2016 for the implementation of Public Resources Management in Health and Agriculture in Southern Africa.

The Project is being implemented by ActionAid Tanzania in collaboration with a not for profit organization called MIICO which is based in Mbeya. "We are working with smallholder women farmers at ward and district level," he said.

Among other things, the project seeks to improve public service delivery in agriculture sector (food security), and health (HIV/AIDS, sexual and reproductive health and rights) by strengthening the oversight and social accountability roles of five target groups in Southern Africa Development Community region.

Specifically, the five year project also

government departments and agencies, issue-based civil society organisation and smallholder farmer organisations but also the media for dissemination of information. One of the beneficiaries of the project from Mbozi district is Maria Munduwi, a mother of two who lives at Itaka Village.

In an interview, Munduwi said she has received training in how to use modern agro-inputs, make traditional pesticides and manures from some indigenous species of plants to improve soil fertility and prevent pests that attack crops.

She and her peers were also trained in leadership, gender equality, environmental and health principles, budget analysis, public expenditure tracking, organic farming, agro-forestry and the importance of women participation in hamlet and villages meetings.

Through the knowledge gained from MIICO and ActionAid Tanzania trainers, Munduwi has been able to engaged in agro-ecological farming for sunflower and groundnuts using indigenous seeds, traditional pesticides, local organic manure that are safe to both people and the environment.

"To start with in 2020/21farming season, I managed to cultivated a quarter acre of sunflower intercropping with groundnuts in my farm using indigenous seeds, traditional pesticides and managed to harvest two sacks which made 30 jerry cans of edible oil for both domestic and commercial use," she said.

Through the training, Munduwi revealed that she has reduced farming cost to zero during the 2020/21 season hence made a savings of 192,000/- used to buy industrial made inputs such as fertilizers and hybrid seeds.

She said before receiving training from the project, she used to buy DAP for 60,000/-UREA 54,000/-, pay casual workers 58,000/and planting 20,000/- per acre which is very expensive to many smallholder farmers.

Agro-ecological farming which uses natural inputs helps reduce farming cost; targets relevant parliamentary committees, protect people's health and the environment

while helping farmers reduce costs."As smallholder farmers, we are requesting the government to invest in this type of farming by allocating enough budget to support its adoption by the majority of smallholder farmers," Munduwi urged.

Backing Munduwi's observation, Project Officer, Gloria Mdindile said agro-ecological farming has become so popular among smallholder women farmers and that so far 52 women's groups comprising of 1,560 members in five villages of Mbozi district are engaging in the environmentally friendly farming.

She said the women have also been able to access funding to invent in their projects and so far six groups have been able to get 16m/- credit from Mbozi District Council funds allocated to women for investment in income generating projects.

"The beneficiaries have also established village community banks which enable members to save and access credit to

invest in small businesses easily. We are so far satisfied with what has been achieved in Mbozi district," Mdindile said. She noted that district officials have also increased the agriculture budget from 2.5 percent to 12.5 percent to support extension services and boost agro-ecology cultivation.

The project's Focal Person at Mbozi District Council, Peter Ndalakwa said this year, they have allocated over 265.9m/- to the agriculture budget with main focus on agro-ecology farming which is largely being practices by women's groups.

"We are also investing in improvement of extension services to boost agro-ecological farming by training more extension officers, soil testing, produce traditional seedlings and other related activities for 2021/22 season," Ndalakwa said while adding that another 64m/has been allocated to support for irrigation farming.

Commenting on the project, MIICO Executive Director, Catheline Mulaga said the organization has been working in the Agriculture sector with focus in three advocacy areas that includes; allocation of extension officers, quality extension services provided meeting and addressing women's issues and experiment on alternative means of agriculture production for sustainability.

"Apart from training the farmers, MIICO also support the women through market linkages so that they are able to sell their produce directly to processors," Mulaga said while noting that they also equip them with agribusiness skills.

WORLD NYC returns to hosting UN week as New Yorkers fear virus spike

A scaled-back United Nations General Assembly is returning to Manhattan this week after going completely virtual last year, but fears about a possible spike in COVID-19 cases are making people in the host city less enthusiastic about the annual diplomatic gathering.

New Yorkers, aware of the extra traffic and maze of street closures prompted by hosting more than 100 world leaders and their entourages, might normally embrace the economic boost provided by the event, more than 18 months after the pandemic prompted the city's shutdown.

But this year's UNGA won't be an economic lifeline, and the delta variant is still raging

"My biggest concern is what happens outside the UN complex," City Council member Mark Levine said in an interview. "This gathering is famous for all the side meetings in hotels, bars, cafes, and restaurants. Many of these happen without regular screenings, where New Yorkers will be exposed."

This isn't exactly the mega-event New Yorkers have grown accustomed

to. While 10,000 delegates typically descended on Manhattan in a normal, pre-COVID-19 year, Vijay Dandapani, president of the Hotel Association of New York City, says about 1,000 are expected this time. Countries have agreed to limit their delegations to seven people inside the UN building and side events will be mostly virtual.

Mayor Bill de Blasio pressed the UN to "help us protect the progress we've made" fighting the pandemic. Penny Abeywardena, the city's International Affairs Commissioner, wrote a letter to the UN General Assembly president noting that under New York rules, proof of vaccination should be required for entering UN headquarters. The president of the General Assembly, Abdulla Shahid, responded that he would work to ensure that happens.

But some leaders, such as Brazil's Jair Bolsonaro, aren't vaccinated, and the UN has not signaled it intends to stop them from coming in. Instead, UN Chief Antonio Guterres told Bloomberg in an interview that an honor system will be used, meaning diplomats who swipe into the building are attesting to having been vaccinated.

"As a national and global leader in embracing the vaccine, New York City encourages all attendees of the General Assembly to get vaccinated to protect not only the participants of this gathering, but the people of New York City as well."



French observers believe West has something to learn from Russian elections

THE latest elections in Russia were organized on the supreme level, and, from this point of view, Western countries have something to learn from Russia, a European Parliament member from France, Jean-Lin Lacapelle, said after monitor-



ing the elections in Russia's second largest city of St. Petersburg.

"I note with satisfaction that the organization was at the supreme level," Lacapelle said, summing up the results of his three-day observation of voting at various polling stations in St. Petersburg. "There are even some things that the West should learn from you."

"I would like to particularly note measures taken to ensure the participation of persons with limited mobility: athome vote was available, as well as various technologies allowing them to cast their ballot directly at the polling station. I think that this is something we can learn from."

The head of the delegation of foreign observers, European Parliament member Thierry Mariani, said that security measures at polling stations in Russia are becoming more and more serious.

"For example, there are cameras everywhere now. Very often, no such security measures are taken in other states. For example, we have no cameras in France," he said.

"We noted that, regretfully, the turnout was not high, but this tendency can be observed everywhere," Mariani said.

Mariani stressed that he and his colleagues arrived to Russia in their personal capacity, not as members of the European Parliament.

French senator Stephane Ravier, in turn, said he saw "a truly democratic electoral process" in St. Petersburg.

European Parliament member Herve Juvin said the group of foreign observers visited about two dozens of polling stations and met with representatives of various political parties.

"I would like to note that <...> I saw no violations with my own eyes at the polling stations that we visited, and received no reports about them," he said.

## US regulators set to allow 3rd Pfizer shot for elderly this week LONDON

US regulators are expected to authorize a third booster shot of the Pfizer Inc/BioNTech SE COVID-19 vaccine for older and some high-risk Americans early this week in time for the government to roll them out by on Friday as hoped.

The Food and Drug Administration is expected to give the nod to the shots for at least this group in the days ahead of a meeting of advisers to the US Centers for Disease Control and Prevention scheduled for Wednesday afternoon.

The CDC panel will discuss more precise recommendations for how the shots will be administered.

On Friday, an FDA advisory committee voted to recommend emergency authorization of the additional Pfizer shots for Americans 65 and older and those at high risk of severe illness.

**Right-wing rally near US Capitol shrinks amid high police** 

#### WASHINGTON

A sharply shrunk right-wing rally on Saturday was held peacefully before the long fencing of U.S. Capitol amid high police alert and tight media presence, crying out over the treatment of Jan. 6 Capitol rioters

Just a crowd of not many people gathered at noon time in a small park with the Capitol in clear view, far less than the number that authorities had estimated. Prior to the event, the U.S. Department of Homeland Security reportedly ex-

#### pected about 700 protesters would show up.

During the "Justice for J6" rally lasting about 90 minutes, dozens of law enforcement officers, wearing riot gear, stood straight between protesters and the security fencing surrounding the Capitol. Many more police officers and vehicles were seen on closed roads near the Capitol in preparation for any violence.

Police Chief Robert Contee told NBC News that stepped-up police presence might have kept the number of rally attendees lower.

"It's very small, you know, they didn't advertise this on social media the way they did on Jan. 6. A lot of people are saying they don't come to this," Frank Higgins, a local tech analyst, told Xinhua outside the rally.

Barbara Kerns, a Virginia housewife in her fifties, told Xinhua that she came to the rally because she believed those Jan. 6 Capitol rioters "were not violent people" and didn't get their due process. She also said she believed the 2020 U.S. presidential election had been stolen, just as former President Donald Trump claimed.

"It's not an insurrection. It was a protest going out of hand. That's about it. I'm here in support of those people's rights," another protester wearing Batman costumes, told Xinhua. He only gave the name of Batman.

The 2020 presidential election was "absolutely stolen" by the Democratic Party, he claimed, adding that election fraud is the top issue he is concerned about most for this country.

"I am glad that very few protesters showed up, but I want to make sure I'm here to stand physically to show my opposition to the Jan. 6 insurrection," Pam, a counter-protester holding a banner that reads "Lies aren't equal to free speech", told Xinhua.

The middle-aged woman, who only gave her first name, called Jan. 6 Capitol rioters "traitors" and said she was very angry about what had happened that day.

"It's going to be a very long time to overcome" the current bitter political division in the country, Higgins said. There is probably a way forward for the United States to become better but "50% of the country will not follow that way," said Higgins.

NBC News reported that Capitol

Police arrested a man with a knife for a weapons violation less than one hour before the rally began.

More than 600 people have been arrested since the Jan. 6 Capitol attack, over 50 of whom have pleaded guilty to federal crimes, according to media reports.

A mob of Trump supporters breached the Capitol on Jan. 6 in an attempt to stop Congress from certifying the 2020 election results for President Joe Biden. The riot, later deemed an insurrection, left five dead, including a Capitol Police officer. Xinhua

#### **OTTAWA**

CANADA'S 44th national election yesterday will not only decide whether Prime Minister Justin Trudeau's Liberal Party receives a third mandate, but could determine whether fissures that emerged during the 36-day campaign become a social reality across the country.

Trudeau's Liberal Party and the Erin O'Toole-led Conservative Party have been locked in a dead heat and have been bouncing back and forth in the lead position, with each claiming between 30-percent and 32-percent support in public polling.

A win for either would result in a minority government -- and for the governing Liberal Party, not the majority Trudeau sought when he called the snap election on Aug. 15.

The Liberals have the advantage for a win on Monday based on the slight edge of support the party is registering in Ontario, Canada's most populous province, which has the most seats -- 121 -- out of the 338 that comprise the House of Commons.

But it could be a Pyrrhic victory in light of polling that forecasts the Liberals to drop from the 157 seats they won in the last federal election in 2019, and went on to form a minority government. To form a majority government, the Liberals would need to win 170 seats.

Nipping at the Liberals' heels for the progressive vote are the left-of-center New Democrats, led by Jagmeet Singh, the first non-white leader of a Canadian national party, who are polling around 20 percent and are expected to add seats to the 24 they won nearly two years ago.

At the opposite end of the political spectrum is the rise of the far-right populist People's Party of Canada (PPC) led by former Conservative cabinet minister Max-

-- unduly interfering with their right to choose, creating a division with the majority of Canadians who have willingly received both doses of a vaccine.

His government's management of the pandemic was the issue for which Trudeau decided to send Canadians back to the polls two years earlier than they would otherwise have voted under a fixed-election date law.

In so doing, Canada's 23rd prime minister sought to highlight his leadership -- a point picked up by former U.S. President Barack Obama and the former U.S. First Lady Hillary Clinton, both Democrats, in their Twitter endorsements of Trudeau last week.

However, there was not unanimity on the progressive side of American politics. Independent U.S. Senator and former Democratic presidential candidate Bernie Sanders tweeted his support for Singh and his party "that stood up for working people in the pandemic."

Meanwhile, Francois Legault, the premier of Canada's French-speaking province of Quebec, has said that he would prefer to see the Conservatives form a minority government since O'Toole has signaled that he would not interfere with Quebec's provincial jurisdiction over health and immigration issues.

It will be up to Canadians to decide what form of government they will have following Monday's vote. But it could take days before the final results are in since Elections Canada sent out more than 1 million special ballot voting kits -- many of them for voters opting to mail in their ballots -- and counting them will not begin with full force until today. #### Algeria holds funeral for late ex-president Bouteflika

#### ALGIERS

ALGERIA on Sunday held the funeral in the capital Algiers for former President Abdelaziz Bouteflika, who died on Friday night at age 84.

Bouteflika was buried Sunday afternoon at the Square of the Martyrs in the cemetery of El-Alia where several former presidents were buried. Algerian President Abdelmadjid Tebboune,

Prime Minister Aymene Benabderrahmane, parliament leaders, army leaders, government members, as well as Bouteflika's family members attended the funeral.

Tebboune on Saturday ordered flags to be flown at half-mast throughout the country for three days in honor of Bouteflika. Bouteflika became the Algerian foreign minister in 1963.

He participated in the presidential election in 1999 and scored an overwhelming victory.

Against the backdrop of diversifying consumption needs and growing number of young consumers, intelligentization and personalization become a driver for the development of small home appliance industry, Dai pointed out, adding that families in less developed cities are showing increasing consumption demand for smart home appliances.

Livestreaming has also contributed to the rising sales of the industry. According to an executive of Ecovacs Robotics, a leading service robot maker in China, most of the offline experience stores of the company promote products through livestreaming.

During this year's June 18 online shopping festival, the company's store located in a shopping mall in Shanghai received more than 60 percent of its orders from viewers of its livestreaming sales promotion, said the executive.

Small home appliance brands' increased investment in the online market and their increasingly mature sales approach featuring coordinated development of online and offline business have played an important role in the continuous growth of the market, suggests a report released recently by the CCID.

"Small home appliances are cheaper and have greater diversity, shorter life cycle, and more attributes of consumer goods, compared to traditional large ones. Meanwhile, their attractive appearances, rich functions, and important roles in people's social life suit young consumers' taste for personalized and exquisite products," said an executive of the e-commerce division of Chinese online videosharing platform Douyin.

What attracts small home appliance enterprises to short video and livestreaming platforms is their appeal to young people, according to the executive.

Small home appliance enterprises are generally optimistic about their products' prospects in China. They believe that industrial structure optimization, increase in people's income, and continuous upgrade of consumption, among other factors, will bring new growth points to the industry in the long run.

"More consumers will enjoy the convenience brought by various kinds of small home appliances and show more consumption desires," said an executive in charge of the smart small appliance division of Chinese home appliance giant Midea Group.

The customer resources and products accumulated during the expansion stage of companies will translate into huge demand for new products, thus driving constant upgrading of products and improvement in services, the executive added.

"There is still a gap between the small home appliances ownership per household in China and that in developed countries," said Leng, who believes the trend of consumption upgrading in China will generate tremendous opportunities to the small home appliance market.

In a 90-minute debate that was one of the last opportunities for Laschet to spark his flagging campaign, frontrunner Olaf Scholz of the Social Democrats and Green candidate Annalena Baerbock at times joined forces. Scholz made it clear that his party favors forming a coalition with the Greens after the Sept 26 election.

"I think that most voters, after all these years, want the Union to go into opposition," Scholz said, referring to Merkel's Christian Democratic Union-led bloc. Baerbock agreed.

Scholz was ranked the winner in two previous televised debates and 42 percent of viewers in a Forsa poll after Sunday's face-off said he also won this one, compared with 27 percent for Laschet and 25 percent for Baerbock.

The SPD under Scholz has staged an unprecedented reversal in the last two months, moving from a distant third behind Merkel's bloc and the Greens to first place, as Laschet has failed to gain traction among voters. In a fragmented political environment, a Scholz victory wouldn't guarantee him the chancellorship, since Merkel's successor will likely have to forge an agreement between three parties.

Laschet was back-footed from the beginning of the debate, with more than half of it focusing on wealth disparity and climate, issues that the SPD and Green candidates were able to dominate.

With Scholz scheduled to testify to a Bundestag committee on Monday on a raid at his Finance Ministry, the format meant that Laschet was unable to open a clear line of attack on the issue.

Merkel's bloc has attacked Scholz for his response to the Sept 9 raid, conducted by prosecutors investigating a money-laundering watchdog within his ministry only two weeks before the vote. The topic was addressed briefly, with Baerbock demanding that Scholz come clean with lawmakers on the committee.

Viewers were treated to a policy-heavy debate with Laschet and Baerbock engaging in spirited attacks and Scholz sticking to a matter-of-fact delivery.

Laschet, after sustaining a grilling from Baerbock, gained traction on the issue of domestic security, a policy area he's been touting for the last week. He drew a distinction on refugees, saying those who break the law must leave the country.

"If somebody is a criminal, he should be deported," said Laschet, who has backed Merkel's decision not to close Germany's borders to asylum seekers.

A few of these malaises include unequal pay, the gross lack of promotion, and the sadly titanic difficulties of securing sponsorship.

Unmistakably, the aforesaid hindrances are issues that require constant attention, and they should not just be put under the spotlight when the hour of the women's sports festival has dawned.

That being said, there can be no opposing the incontrovertible truism that the women's sports festival was a genuine masterstroke of an idea.

One can only hope that the festival paves the way for the obstacles impeding women's sports to receive greater attention than has already been the case.

Let us now turn our focus to the Taifa Stars who are on cloud nine after climbing three places up in the FIFA World Rankings.

Indeed, before their recent ascension, the Stars were stuck in 135th place but jollily, they are now a tad more comfortably placed in the 132nd position.

But, before we begin popping the champagne and oohing as well as aahing over the Stars' recent accomplishment, a cautionary note should be sounded.

Granted, it is a worthy achievement. However, perhaps what would taste sweeter is if we were able to outperform and outplay Benin in our forthcoming World Cup qualifier and that needs to be kept uppermost in our minds.

Moving on, I have often excoriated and put the Tanzania Tennis Association (TTA) under fire for its

woeful failure to cater to the needs of adult tennis players on the home front.

This criticism has also been echoed by other figures in local tennis, such as adult tennis

However, the million-dollar question left hovering in the air is this, if we continue to blindly put our faith in youth tennis alone, what happens then when these youngsters grow up?

That is the nagging question which the TTA has thus far catastrophically failed to answer.

# Chelsea benefit from Tuchel's tweak to display title credentials

THOMAS Tuchel is not one of Chelsea's most expensive signings, but he showed in Sunday's 3-0 Premier League win at Tottenham that he is rapidly becoming one of the club's best.

The leap in stamina required from Champions League winners to Premier League title contenders requires precisely the sort of managerial acumen Tuchel delivered to turn a tight game into a comfortable win.

Of course, it helps when a player with the calibre of N'Golo Kante is at your disposal off the bench as a halftime substitute with the game goalless, but Tuchel sensed an opportunity by taking off Mason Mount and adjusting his 3-4-2-1 system in an intervention from which Spurs never recovered.

Few Chelsea managers have embraced the game's ruthless culture like Tuchel. After a brutal sacking at Paris Saint-Germain last year -- on Christmas Eve, no less -- he is acutely aware of the nature at clubs built remorselessly for success. As such, the 48-year-old has the enthusiasm of someone not interested in waiting to win, shunning talk of longevity to revel in the here and now.

Against Tottenham, he came, he saw, he substituted. Tuchel spent much of the first half on his feet in the visitors' technical area, visibly frustrated at poor decision-making in the final third. Some of the scrambled thinking was due to Tottenham's relentless early press, which harassed Chelsea's back three and central midfield duo into mistakes that encouraged a raucous home crowd.

Mount was a particular focus of Tuchel's ire, notably midway through the opening period when checking back to retain possession rather than risking a drive forward to maintain a counter-attack. This followed an earlier instance when delaying his pass to Romelu Lukaku blunted another breakaway.

It was, nevertheless, a surprise that Mount was replaced at the interval, even if it marked the second successive weekend on which Tuchel has made a half-time change following Saul Niguez's dreadful debut against Aston Villa. Perhaps, though, most important bring on because he is unique and can change any momentum," the Chelsea manager continued.

"So the change appeared to be, in terms of characteristics, a bit more defensive but we wanted to improve our compactness, ball wins, and spirit as a team." The impact was almost immediate. The reshuffle in midfield saw Kante operate slightly deeper than Mount, giving Chelsea a better chance of escaping the Tottenham press. Within four minutes of the second period beginning, the away side was ahead.

Marcus Alonso had just had a brilliant volley tipped over by Spurs goalkeeper Hugo Lloris, but the left wing-back's subsequent corner found an unmarked Thiago Silva to plant a header into the net. It was the standout moment in another fine display by the Brazilian defender, who turns 37 next week.

Chelsea were frustrated in their pursuit of Sevilla's Jules Kounde over the summer, opting not to pay the centre-back's €80 million release clause despite Kurt Zouma joining West Ham, but that decision can be vindicated by their remaining defenders excelling as Silva did here, defying a mismatch in pace with Son Heung-Min Son through exquisite positioning and commanding a reasonably high defensive line.

Kante, meanwhile, is hardly renowned for his goal scoring -- his strike, which took a wicked deflection off Eric Dier, was only his 12th goal in more than 200 appearances for Chelsea -- but the space he was afforded to line up his shot was further evidence of how Tuchel's tweak, with Mateo Kovacic, shifted slightly to the left, scrambled the home side.

Two goals in eight minutes ended the game as a contest. Spurs manager Nuno Espirito Santo had been brave in his team selection and Spurs began with tremendous energy despite a Thursday trip to Rennes, but Kepa Arrizabalaga, deputising in goal for the absent Edouard Mendy, was not truly tested and Nuno then failed to react as the game changed around him.

## Why PSG and Premier League clubs are set to dominate the Champions League

Barcelona's decline is no surprise, it's their new reality (PICHA: Joan Laporta -Ronald Koeman)

By Sid Lowe, ESPN Spain writer "IT is what it is. We are who we are." Gerard Pique wasn't wrong, but that didn't make it right. In the final minutes of Barcelona's opening Champions League match, the fans were having a whale of a time. From the south stand came laughter. Every time the ball was passed, there was another cheer. But it had nothing to do with what was happening on the pitch: they'd found a ball of their own to play with. It was better that way.

Out on the pitch Barcelona were losing 3-0, defeated on the opening night of the Champions League for the first time. The club that had gone 38 consecutive European games unbeaten at the Camp Nou was about to lose three in a row – from one record to another. They'd not managed a shot on target all night. That had never happened before, either. They had let in three goals, you couldn't help thinking, because their opponents didn't really need them to let in any more.

Yet this was not a sudden collapse, still less a one-off. It was not that much of a surprise, either. Their opponents were Bayern Munich, a genuinely good side. The last time they had met, only 13 months before, but a lifetime ago, Bayern had put eight past them and since then, Barcelona had lost all three of forwards who started that game: first Luis Suarez, then Lionel Messi and then Antoine Griezmann. On Tuesday night, Ansu Fati was injured, and Ousmane Dembele, and Sergio Aguero and Martin Braithwaite.

Standing at the side of the pitch at the end, Pique said there were "I don't know, four or five" kids out there. There were three 18-year-olds and a 17-yearold on the pitch. This, he said, is just the way it is. "Frankly," he said, "we're not among the favourites."

When asked about his captain's words, the coach Ronald Koeman agreed. There is a "gap" between Barcelona and teams like Bayern, they said. And few could disagree. Just look at the team sheets. The front cover of one Catalan newspaper ran with "Sad reality." It is what it is.

There was an acceptance of that reality, which may have been part of the problem. There was resignation, not rebellion. Not just after the game, but before it too. Even during it. For 20 minutes or so Barcelona had played quite well, they had resisted. It might not have been much, but it was something. It was noisy at the Camp Nou and you could almost sense supporters looking around and thinking: Well, this isn't so bad. And then it was. Writing in AS, Santi Gimenez recalled Mike Tyson's famous line about how everyone has a plan until you punch them in the mouth. In recent years, the ease with which Barcelona have collapsed when they've been hit is alarming -- there's a deep mental trauma to the way they lost 4-0 at Anfield in 2019 - but just as important this time is that the plan appeared to be to just try and get through it somehow, maybe fearing a trauma far worse. To continue the metaphor, it's as if a smalltown flyweight, standing there before Iron Mike, decided to hide in the corner of the ring, cover his face and hope to avoid getting punched in the mouth, counting the seconds until the bell. Which, of course, they couldn't do. And if Bayern didn't pound away at them until they knocked them through the ropes and onto the judges' table below, cartoon birdies circling their heads, it was because, well, what for? Once the first punch had landed, with defender Eric Garcia backing off and Thomas Muller's shot deflecting in, it was done. But still Barcelona stayed there, hanging on. As if to say, "Well, we lost, but at least it wasn't 8-2. At least we can still walk out of here, live to fight another day." It's like they knew they couldn't win and the only question was about how they would lose or, somehow, hold on for a point. Like there were some defeats that wouldn't matter. And, actually, maybe that's true, but that's where the debate lies, and some of the frustration too. "It is what it is" is a line that was forever held against former Barca manager Ernesto Valverde after that chastening defeat at Liverpool - mostly by people who clearly didn't understand it right. (And one day, it might be worth revisiting Valverde and the two successful seasons sandwiched between three

unsuccessful seasons, a lid kept on a coming crisis.)

Back then, the Spanish set phrase "es lo que hay" was not used as an expression of inferiority or acceptance of the inevitable. This time, while still a set phrase, it was. This is the just the way it is. Everyone knows that, but you're not supposed to accept it. Or are you? Barcelona can't be a small team. Or can they? Must they? Is it what they are?

Everyone knows about the club's debt (almost €1.4 billion). They are aware of the reasons for this summer's emergency measures, even if they might question which measures were needed and how they were applied. Most fans welcome the fact that something is actually being done and are realistic enough to know that it affects the team, their expectations altered accordingly. You can't not notice that Messi went, either – for all that things might have been handled differently, Messi's exit is the ultimate expression of mind, you may be in favour of patience, even while that's a virtue for which clubs this size don't usually have the time. When Koeman says the team "will look totally different in four weeks," or when Pique says "Tm convinced we will end up competing," you might be on the same page as them. You may have been one of those excited by the introduction of Gavi, Demir and Balde, or the emergence of Nico. You probably do like Ronald Araujo, and you may believe in Garcia. You might like Riqui Puig, even if the manager doesn't. You must be excited by Pedri.

But none of that makes it easy to watch, even if you agreed with the tactical approach for now. And, more importantly, none of that makes it an easy process to work through. Because if you have to be patient, you have to be patient. If there is belief, you have to be lieve. Everyone has to, which is not easy. Because if, on Tuesday night against Bayern, there was a certain acceptance exactly? Laporta asks for trust for those running the club, but not the manager. He asks for patience, but "indignant" isn't a word that invites it. His clear, public disconnect with Koeman mitigates against it.

"Indignant" is not really a word that fits with a situation you foresaw, either. Unless, of course, it is Koeman doing this you foresaw, your mistrust of him confirmed. Fix...that? It's already public knowledge that Laporta wants Koeman to play a certain way, which is not this way. That for all that the structural problems are a reality, for all that the squad is unquestionably weaker than it was, for all that Bayern are a huge side and better than us, reality – our reality – needn't be this.

The very fact that such doubts are there makes coming through this harder - certainly coming through it together. As one sporting director puts it, there are two types of managers: weak and strong. And once the players know he is weak, he is finished. There is a hint of a threat to his manager in the video, a very public reproach. More to the point, there's been more than a hint of a threat in previous briefings, stories immediately following meetings with media. Koeman has called him out on those, the whole thing increasingly open. There have been reports that Laporta will give Koeman three more games - such ultimatums always seem absurd - which means he might as well give him none. Which, put bluntly, many would welcome. But your manager is your manager until he's not. Laporta does not believe in Koeman, and Koeman does not trust Laporta. In the summer, Laporta publicly admitted that he would keep Koeman only if he couldn't come up with something better. He couldn't. Koeman is still in the job because of the cost - €12m that Barcelona don't have -- of kicking him out of it. Better if Koeman goes, but he won't: This is the job he always wanted even like this, one that deep down he knows he probably wouldn't have got in different circumstances. And so here they are, stuck in a marriage of convenience that, like so much else at Barcelona, has become deeply inconvenient. But then, like so much else at Barcelona, it is what it is.

#### Solskjaer mocks Man Utd sack claims after win

OLE Gunnar Solskjaer refused to answer questions about Manchester United's title hopes following their victory over West Ham instead joking about the turnaround in mood at Old Trafford following defeat in the Champions League to Young Boys.

Solskjaer was on the end of heavy criticism for his role in the 2-1 defeat in Switzerland on Tuesday only for a 2-1 win at the London Stadium on Sunday - - thanks in part to Jesse Lingard's last-gasp winner and an even later penalty save from David De Gea - - to prompt questions about the Premier League title.

"You're not gonna get me on that one now," Solskjaer said. "It's five games into the season. I was probably down and out and lost my job yesterday. That's the way it is at Man United.

"We deserved three points [against West Ham]. It's a hard place to come, here. Hopefully these points can make a difference. Let's see [about the title] when we get towards April and May."

Despite watching Lingard score in the 89th minute and De Gea save Mark Noble's penalty in stoppage time, Solskjaer wasn't completely happy.

United went a goal behind thanks to Said Benrahma's deflected effort before Cristiano Ronaldo scored his fourth goal in three games to equalise, and the Norwegian was critical of his team's defending.

"We have to defend better," Solskjaer said. "We have to make it harder to break us down. For their goal the structure was wrong for whatever reason and we'll have to work on it."

United play West Ham again on Wednesday when their Carabao Cup campaign kicks off at Old Trafford.


