SUA unveils rare bacterial disease

NEW study has called for urgent steps to contain an alarming rate of leptospirosis - a little-known neglected tropical disease which is silently spreading and affecting a large proportion of humans and domestic animals.

Researchers say that in humans, leptospirosis can cause a wide range of symptoms, including high fever, headache, chills, muscle aches, vomiting, jaundice (yellow skin and eyes), red eyes and abdominal pain.

The extent of the problem is highlighted in the findings of a study by the Sokoine University of Agriculture (SUA) which shows that awareness of the disease is very low in the general public and even among healthcare providers.

SUA researcher Dr Abdul Katakweba said increasing high prevalence of leptospirosis has been reported in humans in a number of regions including Morogoro, Kilimanjaro and Katavi. The disease is caused by a spirochete bacterium called leptospira and can be transmitted to humans from animals, mainly

rodents.

Leptospirosis is transmitted through contaminated soil and water where bacteria can persist for longer periods of time, the study noted, which the report says it was funded by the Commission for Science and Technology (COSTECH) under the National Fund for Advancement of Science and Technology (NFAST).

It says there are high risks of transmission from animals to humans countrywide, with 70-percent of its local people engaging in agriculture, animal husbandry and fishing. "The bacterium is transmitted to humans by rodents and other small mammals through contact with infected urine, meat or body fluids," the study underlines.

There is a high prevalence of human leptospirosis in Morogoro by 10.8-13percent average exposure in 2015 while Kilimanjaro Region showed 9-20 percent exposure in 2013.

'Prepaid water meters will end complaints from users'

WATER ministry authorities have said they are working on ways to introduce prepaid meters as an effective means of ending complaints by consumers arising from estimated bills.

The minister, Jumaa Aweso (pictured), said in Dar es Salaam yesterday that complaints over inflated estimated bills are rampant in the docket, and the only permanent solution is prepaid meters in similar manner as the Energy ministry stopped metering problems with prepaid (LUKU) meters.

He made these remarks at a function to sign the project proposal with the outlying areas of the city selected for a start of implementation in Kibamba ward, bringing together the Dar es



Salaam Water Supply and Sanitation Authority (DAWASA) and Advent Construction Ltd.

Aweso said the project worth 5.4bn/- will serve Mbezi Msakuzi, Magari Saba, Luguruni, Machimbo, Miti Mirefu, Masaki Street and Mshikamano Mpya, and other parts of the ward.

"I assure you that after installation of prepaid metres there will be no more complaints from clients caused by unfaithful DA-WASA staff," he stated.

"LUKU in the electricity industry ended inflated bills therefore time is ripe to introduce the same prepaid metres to give wa-

ter users relief from paying huge bills," he affirmed.

The minister directed DA-WASA to come up with regulations that will govern the cost of connecting water services, and that once the fee is paid the work should be finished within 14 days.

The prepaid meters project is fully funded by the government. with advance payment to the contractor being set for the coming week, he further noted.

Access to clean water was among the key directives from President Samia Suluhu Hassan to remove the bucket from mothers' heads by accessing water on their doorsteps. The president has added 207bn/- from the 680bn/- budgeted earlier for

UDSM team, Berlin museum in 100m years dinosaur find

A TEAM of archaeologists from the University of Dares Salaam working with German museum experts have discovered a skeleton of a giant prehistoric creature dating back to over 100m years ago at the Tendaguru Hill in Lindi Region.

That is the same location from which remains of another dinosaur were discovered during the German colonial period, about 110 years ago.

Bones of the 'Brachiosaurus Brancai' were later transported to Germany; while experts believe this time Tanzania is likely to retain the newly discovered remains.

Dr Agnes Gidna, senior palaeontologist at the National Museum, said that the skeletal remains relate to dinosaurs, large reptiles which roamed the earth around 150m years

"We have managed to excavate various components of the prehistoric giant's skeleton, including rib-cage, spinal and lower limbs all weighing over 2 tons," she stated, noting that the remains look like they come from a single animal.

Skeletal remains of the 'Dysalotosaurus lettow-vorbecki' were embedded in deposits of the 'middle dinosaur member (MDM) of the Tendaguru fossilferous formation, a place with rich heritage of prehistoric fossils in Lindi, named after the German World War I

NHIF to scale up enrolment as govt readies universal care bill

AS the government finalises the Universal Health Coverage (UHC) Bill to be tabled in the legislature next month, the National Health Insurance Fund (NHIF) has been asked to get ready for changes including massive enrolment of new mem-

Dr Dorothy Gwajima, the Minister for Health, Community Development, Gender, Elderly and Children said here at the weekend that the new law will cover other health insurance service providers, apart

The government is committed to ensuring that people from all walks of life get improved health services, in which case a universal health care law remains the best approach, she said, praising the NHIF board and management for their good work to improve services.

The forthcoming UHC will regulate health insurance institutions, with NHIF standing out as the biggest fund with many members, she asserted at the climax of events to mark 20 years of the NHIF, starting from July 1.

Many people who cannot afford paying for health services will get relief once the new law is in place,

sector in the fiscal 2021/2022 estimates, he said to applause.

DAWAWA must also promptly compensate people living along the project construction zone before it kicks off, he emphasised, noting also that the government is implementing 1,176 water projects in rural areas intended to ensure that 90 percent of people living in rural areas get clean water.

For his part, DAWASA executive director Cyprian Luhemeja said the project construction will involve distributing and fitting pipes, installation of pumps and construction of water storage

Once it is over the project will end the shortage of water lasting for decades in the area, lying just outside the principal city suburbs, he stated, asserting that rural areas access to water must be reached by 90 percent and urban areas by 100 percent

As part of Vision 2025, the government has pledged to increase access to improved sanitation to 95 per cent by 2025. The Second Five Year Development Plan (FYDP II) has also set the target for access to improved sanitation to 85 per cent in rural areas within that period, he added.

Quick observations indicate that the particular dinosaur was three-times larger than an ordinary elephant and could be of the same size as the re-constructed dinosaur displayed in the German

From 1909 to 1913, 250 tons of 'Brachiosaurus Brancai' bones were recovered from diggings at more than 100 sites in the Tendaguru area, which the museum team says it is among the most successful dinosaur excavations of all

Dr Frank Masele, an archaeology lecturer who led the research team, explained that despite being rich in fossilized history. Lindi and

Mtwara regions have not been extensively studied.

"The ongoing archaeological studies will hopefully rectify this and rebrand the Southern Tanzania precinct as even more potential for Jurassic era discovery and thus for historical tourism," he declared.

Dr Daniela Schwarz of the Naturkunde Museum of Natural History in Berlin said that the most remarkable aspect of the ongoing research cooperation is how it brings the global family of archaeologists together.

The sedimentology and palaeontology of the 'middle dinosaur member' suggests that deposition occurred mainly in a tidally-influenced shallow marine littoral environment, she added.

the minister underlined, pointing out that currently just 14 percent of the population has access to health insurance, and eight per cent or around 4.5m people are registered with NHIF.

"There is still a great job to ensure that many people are registered for health insurance services and NHIF should be prepared to cope with the new changes," she emphasised, urging that the fund has to improve all areas of service provision.

She challenged the fund leadership to have in place strategies to reach the rural-based population, most of who do not understand health insurance and others who don't seek such services as they aren't close to them. NHIF should improve its operational systems and where

needed, seek additional support from other ministerial agencies and administration. It must similarly strengthen cooperation with other stakeholders among health sector service providers to sort out challenges and complaints raised by beneficiaries or targeted members of the public, the minister intoned. Citing frauds and misappropriation of funds as among core challenges NHIF faces, she appealed to the management to put in place better mechanisms on claims, while acknowledging that NHIF officers were often involved in frauds. Those found in misconduct will face disciplinary measures, she affirmed. "It is completely wrong to close services to the public because of misconduct of a few individuals," she cautioned, saying it was more

appropriate to "strongly deal

She called on the fund to increase public education by reaching many people, using collaborative approaches as those used to combat the spread of the Covid-19 pan-

Earlier NHIF chief executive officer Bernard Konga said the fund had 4.5m members as of last month, including civil servants, private employees, farmers and informal sector entities.

With over 8000 offices in health centres nationwide, the fund is modernizing information flows with digitalized systems, more efficient compared to the old paperwork operational system, he said. Registration of new members and lodging of claims can now be done online, reducing costs and time unlike in the past, which brings the fund closer to the people. "As of now, one can do everything online and get a health insurance card

within 14 days," he said, in the aftermath of establishing an electronic registration

Outlining achievements of the fund, he said NHIF has disbursed 132.06bn/- in loans to health facilities as part of a programme to improve its services to service providers noting that about 8482 health facilities have been registered with the fund, including government, private and religious health facilities around the country.

The NHIF management is working hard to ensure that far more people get its services, pointing out that there are over 1000 kidney patients now obtaining treatment through NHIF funding. The government's decision to adopt a universal health coverage policy was the surest way to provide health services to the people and especially the poor, he added.

Govt wants NBAA to have robust strategies to produce more competent professionals

THE government has urged the National Board of Auditors and Accountants (NBAA) to put robust strategies so as to produce more competent professionals to work in the country's public and private sectors especially the highly growing mineral, oil and gas industries.

Minister for Finance and Planning Dr Mwigulu Nchemba made the call in

Dar es Salaam at the weekend during the NBAA 43rd graduation ceremony that saw a total of 944 candidates of accounting and auditing related courses, graduating.

In his speech which was read on behalf by the Minister for Industries and Trade Exaud Kigahe, he said the board should make sure that it enrolls more students in the accounting and auditing sector to cater for the country's demand.

But also warned that along that enrolment, the board should remember producing qualified professionals for the country's develop-

He said the government is taking several measures to ensure that the country's resources are protected, a move which also requires competent accountants and auditors to supervise.

He said statistics show that the country still faces shortage of professional accountant and auditors with the deficiency hitting both public and private sector something that needs more vigorous measures to produce more professionals to address the gap.

"Minerals, oil and gas sectors are among key sectors that need strengthened protection. So, NBAA should strengthen systems, come up with more robust strategies to supervise the sectors by bringing into the market, well trained professionals and experts," he said.

The minister noted that there is no doubt that, in today's national agenda, accountants will play an important role in the development of the economy.

"Any economy in the world depends on the excellence of finance professionals. These professionals should be well prepared to serve the country by ensuring that all finance issues are well designed and properly controlled...so NBAA has a great role to play here," she said.

Bus collision kills two, injures three in Tarime

TWO people were confirmed dead and three others injured following a head-on collision involving a passenger bus and a private-Toyota Prado yesterday at Gamasara village in the outskirts of Tarime town

Tarime/Rorya Special Zone Police Commander William Mkonda said the accident which occurred yesterday morning involved a passenger bus with registration number T.906 DLJ and a Toyota Prado number T 184 AQT.

He said the Zakaria company passenger bus was coming from Mwanza with the other one coming from Tarime town.

RPC Mkonda said the fatalities whose names are yet to be identified have been kept at the Tarime Town Council Hospital. It was said that the deceased are relatives from the same family.

He wanted motor vehicles and road users to adhere to road safety rules and regulations so as to avoid causing unnecessary accidents.

Reports show that 80 percent of accidents are caused by reckless drivers, 12 percent caused by the mechanical problems of the vehicles, 6 percent by climate change, while only 2 percent of the road accidents are caused by poor infrastructures.

The Global figures as provided by WHO in 2018, indicates that, each year 1.35 million people die as a result of road traffic crashes, and millions more are injured or disabled while head injuries remain the leading cause of death and disability among motorcycle riders.

CSOs urged govt: Bring safety strategic plan

THE Coalition for Road Safety Civil Society Organisations has appealed to the government to take road safety issues as a priority agenda instead of relying on police and related institutes

The coalition is made up of the Tanzania Women Lawyers Association, Tanganyika Law Society, Tanzania Media Women Association, Road safety Ambassadors, Tanzania Child rights forum, AMEND, Tanzania association of People with disabilities. Others are Tanzania Bus owners association (TABOA), National Institute of Transport (NIT), Tanzania Media Foundation (TMF), Safe Speed Foundation and other individuals with expertise and passion on road safety.

In a statement TAWLA executive director Tike Mwambipile said that although various measures have been taken by the government, enforcement agencies and NGOs, Tanzania is still hit by daily accident deaths and casualties on the roads.

Mwambipile said that when winding the stakeholder's meeting to advocate for the improvement of the road safety legal and policy framework in Tanzania.

She said that the workshop objective was to identify key milestones (success) and lessons learned, understanding the road traffic Act (RTA) tabled Bill and development of action Plan/way forward towards amendment of the

The executive director explained that Road

safety is a complex process that not only depends on technical and environmental improvements, but in a major part from human

"Despite efforts made by the government and stakeholders in addressing road safety issues, traffic accidents remain a major cause of death and injury around the entire world and in particular Tanzania, "she said.

"We therefore call on the government to take the road safety issue very seriously by collaborating with other road safety stakeholders to increase awareness to the public, "she added. Expressing success recorded so far, was strengthened teamwork collaboration for common goals, developing advocacy tools and increased public awareness.

Others were linked concepts between the road safety, public health and human rights, establishment of parliament network on road safety, recognition by the government and the road traffic amendment was tabled before the parliament for the first time June 30 this year.

She however said that conflict priorities of the ministry was one of major hurdles they encountered during the whole process of pushing forward the amendment of the Traffic Act of 1973.

In Tanzania, TAWLA is both a member and host championing legal review.

EAMCEF provides Kilolo District 400m/- for social projects in nature forest reserves

KILOLO District Council in Iringa Region has received 400m/- subsidy from the Eastern Arc Mountains Conservation Endowment Fund (EAMCEF) for various social development projects for communities surrounding natural reserves including Udzungwa Scarp and Kilombero aimed at involving the people

in the communities in environmental conservation and reduce dependency on forest resources.

The projects include fish farming and livestock keeping for food and income genera-

The Council's Acting Executive Director Dr John Mwingira revealed this here at the weekend, saying the subsidy was received beginning 2006 and that in the current Financial Year they expect to receive about 116m/- after EAMCEF was satisfied with the implementation of the projects.

He said positive results have been attained in villages implementing the projects following community members changing their activities from small game wildlife hunting to the new activities in livestock keeping.

Fish farmers in Lulindi Village said fish production increased from one fish pond they started with to 29.

"Village is fast growing as we now produce surplus fish fingerlings," said Leo Sowo, the Secretary of fish farmers' union in Kilolo District and called on Tanzanians from various areas to go to buy the fingerlings from the village.

Keepers of dairy cows, pigs, and goats in Ipalamwa and Mkalinga villages said they have benefitted from the activities.

The EAMCEF Project Coordinator incorporating environmental conservation in Kilombero, Uzungwa Scarp, Udzungwa Mountains, Mkingu and Uluguru Mountains said the Fund has continued providing subsidies via the district councils after yearly assessments of the natural reserves.

The subsidy has been targeting three main areas in the environmental preservation in the nature reserves aimed at protecting their existing biodiversity, research and community projects for people living near them to discourage them depending on forest products for their gions.

There are nine nature reserves that benefit from EAM-CEF's subsidy.

These include Chome, Amani, Nillo and Magambanature Reserves located in northern regions of Kilimaniaro and Tanga; and Uluguru, Kilombero, Uzungwa, Mkingu and Udzungwa National Park in Iringa and Morogoro re-



Higher learning students call for govt to support private sector

HIGHER learning students have called upon the government to support private sector with resources to expand their capacity to intensify internship and apprenticeship programmes which help learners to gain job skills.

The students also want an increase of the practical period from the current eight weeks to at least one year.

They were speaking after finishing their practical studies at Malembo farms where they have been carrying out practical training in various areas of their studies.

One of the students, Janet James from the University of Dar es Salaam (UDSM) who is pursuing a bachelor degree in Environmental Geography said the programme has been beneficial to her as she leant of soil affects plants and vice versa.

"I have leant on how to write a field report as well as project reports which can help me get funds to carry out studies on various issues," she said lamenting that the time was short and called for extension of the internship period.

Another student, Anthony Sekumbo from the Sokoine University of Agriculture (SUA) animal science said he had learned a great deal from training offered at the farm which will add value to the training which he got at university.

He however called upon the government to facilitate private investors such as Malembo farms so that they are able to accommodate more students.

Another student from UDSM Lucy Masele who is pursuing her bachelor degree in Agriculture economics said the direct interaction with farmers which they got at the farm was beneficial to the education which he received at school.

"The problem now is the limited time for the internship programme because I have stayed at school for two years and now receiving practical training for only eight weeks which is not enough," she said.

In 2020 the government announced a plan which allows all graduates to undergo six to 12 month internship in government offices to equip them with practical work experience before being employed or pursuing self-employment.

The decision by the ministry of State in the Prime Minister's Office (Policy, Parliamentary Affairs, Coordination, Labour, Youth, Employment and Disabled) was informed by the fact that 79.9 per cent of new employees in the country currently lack experience.

TRA excise duty collections on increase by 60 per cent

EXERCISE duty collections by the Tanzania Revenue Authority (TRA) increased by 60-percent in the last two and half years following the adoption of Electronic Tax Stamps (ETS).

Latest data shows TRA collected 297.2bn/- as excise duty on beer, wine and spirits (both locally-produced and imported ones) during the three years before January 15, 2019, the amount rose to 476.7bn/- by June this year.

"This is a 60-percent increase if the three years prior to the rollout of ETS' on beer, wines and spirits was compared to an almost similar period after the rollout," said ETS project manager at TRA, Innocent Minja.

Minja said Excise duty and VAT on bottled of water has gone up by almost 156 percent. Excise duty and VAT on beer has gone up by 15- percent while that of soft drinks has risen by 29- percent.

The government introduced plans to adopt the ETS system in June 2018 and the first phase of the project was conducted on January 15, 2019 whereby stamps were installed on companies that produce beer, wine and spirits.

Phase two of the project was rolled out on August 1, 2019 when ETS' were stamped on sweetened flavored water and other non-alcoholic beverages, like energy and malt drinks and

He however said there could always be room for further improvement in the management of the project, adding that so far, the benefits extend even to manufacturers.

One of the key issues that Minja said, there was need for review of the ETs rates which he said he believed would be beneficial to both sides.

The third phase of ETS, which involved enrolling electronic stamps on fruit juices (including grape must), vegetable juices (under Heading 20.09), and bottled drinking water, was conducted November 1,

He said there had been doubledigits excise duty growth rates from all the products on which ETS' have been stamped.

Before the adoption of ETS', excise duty on locally produced and imported products were being determined through paper stamps which, TRA says, were easy to tamper with.

The ETS enables the government to use modern technology to obtain production data timely from manufacturers. That way, it does not only enable the government to collect the right amount of excise duty but it also discourages the entry of counterfeits into the market.

Government developing new regulations to curb production of coloured plastic bottles iconic look of its leading sparkling

THE government is developing new regulations so as curb production of coloured plastic bottles in efforts aimed to fight environmental pollution in the country.

Minister of State in Vice-President's Office, Union and Environment, Selemani Jafo made the statement in Dar es Salaam during the weekend when launching a new transparent look of Sprite soft drink.

Jafo said that the preparation of the new regulations under the 2004 Environmental Act is on final stages and will commence operation before the end of this year. "I am calling on producers of soft

drinks to prepare for this to start producing and packaging the products in colorless or transparent bottles to facilitate easy collection and recycling of the bottles once used," he said. The minister said plastic pollution

Bar, entertainment buildings' owners urge govt to reduce cost of doing EIA

BAR and entertainment buildings' owners have asked the government to reduce the cost of doing environment impact assessment (EIA) to enable them afford to hire consultants for the services.

They made the appeal over the weekend in Dar es Salaam when they were speaking in a meeting organized by National Environment Management Council (NEMC), for night clubs and bar owners and entertainment clubs.

They said many people opt to start their business without doing EIA because of the expensive fees they are charged by their consultants which starts from 3m/-.

One of the owners who attended the NEMC meeting, Robert Yohana, said it is important for the government to ensure they lower the cost to enable people who start business to hire consultant for

"NEMC should create enabling environment for all people to be able to conduct EIA before they start their business. Private consultant charges are very high sometimes it reaches up to three million so it is better if NEMC can do it by using its experts," he said

Another business person who participated, Hamad Hussein said the cost of private consultants in doing EIA is very high and there is need for the government to intervene and reduce at least to

"People look for a shortcut because of the high cost. Sometimes they corrupt officials to fulfill their needs and save cost. I Support EIA but it should be affordable for everyone and if they need most of us to undergo EIA they must lower the price," he said NEMC Director, Dr. Samuel Gwamaka, said the matter of lowering the EIA charges can be discussed but they should first know that to do environment impact assessment is requirement of the law.

"Before they ask for the reduction of the charges they must understand that EIA is a must because it is a matter of environment law and they must think positive about it because it help them to know important things to consider in their investment so that

they comply with environment law," he said

Dr. Gwamaka said NEMC itself cannot conduct EIA because the law doesn't allow them to do so and instead it has registered many consultants whom people can choose of their choice during the time they want to do environment impact assess-

"We have registered a good number of EIA consultants so if someone is not happy with

the charges can choice another one that may have lower price or if you are two people in one place you can hire one consultant to do that so that you minimize the cost," he said

Dr. Gwamaka said NEMC has been doing regular noise pollution inspections all the country and the fine for someone who commit the offense is between two million up to ten million and can be punished between two years and seven years imprisonment.

This is no time to neglect hepatitis

IN 2016, the World Health Organisation (WHO) set an ambitious target to eliminate viral hepatitis by 2030. This was followed by commitments from governments including African countries to develop national strategic plans for viral hepatitis and earmark resources to eliminate the disease.

Hepatitis results in the inflammation of the liver. There are different forms of hepatitis - A, B, C, D and E - each attributed to a different type of virus. Unfortunately, most people who have the most serious forms of the disease, particularly the B and C viruses, are unaware of infection. This allows the infection to spread unchecked, leading to serious damage to the liver.

Many African countries that committed to eliminating the disease have either not ratified their guidelines or not increased access to hepatitis care. Of the 47 countries in the WHO Africa region, 28 have developed national plans to eliminate the disease. However, only 13 countries have disseminated them.

These challenges have been further compounded by the COVID-19 pandemic, which has eroded some of the gains that had been made in the past few years. With movement restrictions and social distancing as part of the responses to curb the spread of infections, people have been less able to use services to prevent and cure hepatitis and other dis-

In Africa, 70 million people are infected and 200,000 die annually from hepatitis. This is despite the availability of treatment.

The mainstay strategy for managing hepatitis B is prevention through the administration of a vaccine. It is also treatable, through oral antiviral drugs which in most cases must be taken for life. This is because the treatment, in most people, only leads to the suppression of the virus and not its complete eradi-

To prevent its progression, it is highly recommended that treatment begins within the first three months of infection.

The call again this year is therefore for renewed efforts to ensure that no baby is born with hepatitis, pregnant women get tested and treated, awareness is raised about the disease as well as testing and treatment, and governments invest more in efforts to end the disease.

More concerted efforts are needed to keep services going even amid the disruptions caused by the pandemic.

Mobile health services have effectively worked in Madagascar and South Africa in increasing access to vaccines and family planning services. Using mobile clinics that can reach communities in far-flung areas could enable health workers to provide hepatitis screening and treatment services.

These would be supported by mainstream and social media platforms, as well as opinion leaders, to create more awareness about the disease and planned community outreach services. Platforms like this are also needed to conduct more advocacy to raise awareness and generate more support for prevention and treatment programmes. Successful campaigns have been run to create awareness about HIV/ AIDS, the dangers of drugs and substance abuse and road safety among others.

Africa needs to mark International Day of Non-Violence with resolve

WHILE most national independence movements in Africa were clothed in beliefs of nonviolence, the spirit of humanism as Zambian leader the late Dr Kenneth Kaunda more resolutely conceived it, the going has been tougher than anticipated. Still it is undeniable that countries espousing non-violence from the start were shielded from the worst that the warrior culture (Africa's and indeed the global opposite of non-violence) can produce, and on the whole the wrestling is still engaged between the two ethos. Africa yearns for non-violent democratic politics but it is nearly everywhere a swan song.

The International Day of Non-Violence is observed on October 2, given as the birthday of Indian independence leader Mahatma Gandhi who espoused non-violence as a philosophy, in a way due to the fact that it was deeply anchored in the Hindu religious tradition. Part of its basic expression is the prohibition of eating meat as it is predicated on cruelty to animals. Gandhi wasn't so successful as at independence in 1947 India went through a harrowing split between Hindus and Muslims, and Gandhi himself assassinated.

Shirin Ebadi, an Iranian political activist, lawyer, a former judge and human rights activist founded the Defenders of Human Rights Center in Iran. She was dismissed as judge after the 1978 revolution in Tehran and shifted to legal practice and in 2003 won the Nobel Peace Prize. In 2004 she took a proposal for an International Day of Non-Violence from a Hindi teacher in Paris teaching international students to the World Social Forum in Mumbai, and it won UN General Assembly adhesion in 2007.

What is interesting about this

principle is that it doesn't have explicit supporters and opponents, as it attracts nearly universal adhesion in principle but often ignored when there are group-based or state interests to be pursued. Globally organised crime has torn asunder states in South America, Africa and parts of Asia. At times there are political groups wielding arms but seeking no political talks, or they take whole countries to ransom as militarized political parties

Resistance to change bring about violent expression when military commanders exercise violence on society to stop change as in Myanmar, or having to stop political leaders who refuse change, like recently in Guinea. Sometimes it is social groups who refuse new modes of society where older slavery structures and respect e.g. for cattle herders are submerged to competition with outsiders for jobs or marriage opportunities. Guerilla wars break out under a litany of ideologies, political circumstances causes and divergent alliances. Sweeping violence against migrants in South Africa because of mild successes, or jihadists in the Sahel belt wishing for social hegemony, are clear examples.

Groups defending human rights and espousing non-violence mean well in their purposes but avoid links with social reform. Administrators stress mitigating conflicts between migrating herders and crop farmers nut can't move towards defined individual land ownership. Again, state-dominated economies are habitually inefficient, creating armies of unemployed and soaring crime, upon which fester power seekers thriving on chaos.



Crime, violence in South Africa slide back to pre-Covid-19 levels

CAPE TOWN

AFTER a respite in 2020 caused by COVID-19 lockdowns and curfews, it appears that crime and violence in South Africa are returning to pre-pandemic levels.

In recent days, a candidate for the ruling African National Congress (ANC) party was gunned down ahead of forthcoming local elections, while three women were killed and several others injured in a drive-by shooting, also of ANC members.

Such killings have become almost 'normal' in the country, political violence in the democratic era, beginning in 1994, never fully subsiding. And in recent months, it has resurged as an important poll looms.

But there are many types of murderous violence at play.

In incidents over the last week, three young women were shot in the head in the sprawling shantytown of Khayelitsha, outside Cape Town, in an execution-style killing.

While still under investigation, these murders may have links to socalled 'blessers', older men who trade sex for gifts and money with young

In Johannesburg's 'sister city' of Soweto, a well-known 'richman' was killed along with a young woman who was with him when gunmen riddled his Ferrari sports car with dozens of bullets, rendering the vehicle "unrecognisable".

Meanwhile, a former policewoman is in court facing multiple murder and conspiracy to murder charges of loved ones and family members.

At least six people are alleged to have been killed by hitmen on her orders so that she could cash in on life insurance policies she had taken out on them.

Among the people she allegedly ordered hits on were her elderly mother, her partner, two sisters and five nephews and nieces, one surviving an attempted hit.

According to evidence in this headline-capturing case, which has shocked even violence-hardened South Africans, one of the 'hits', on her mother, was to be undertaken for just \$170.

Police Minister Bheki Cele has again this week addressed the issue of how cheap life has become in SA, referencing, as he has repeatedly, the problem of a "nest of killers" mostly operating out of the Zulu homeland of KwaZulu-Natal, but also in Gauteng (great Johannesburg) or anywhere in the county, as required by those who use them.

Among those most closely associated with the use of hitmen to 13, Europe's 3 and Asia 2.3 per settle scores with rivals are SA's no- 100,000. torious minibus taxi (matatu) owners and owners' associations.

The 'hitmen for hire' frequently involved, often with innocent commuters being among casualties, are also identified with ongoing political violence plaguing KwaZulu-Natal especially, as well as with 'ordinary' murders.

For most of the mid- to late-1990s and into the 2000s, SA topped global murder rates, with killings running to a high of 63.9 per 100,000 people in 1995, according to World Bank data.

Partly, the violence was then, and still is, ascribed to the ongoing negative effects of the apartheid system of racial oppression, and consequently to South Africa being one of the most unequal societies in the world.

But, through that same period and up to today, SA has also topped the global rape rate, with 132.4 per 100,000 people, compared with the US's 27.3, in ninth place globally.

Taken together with murder and other violent crime rates, the rape figures indicate to sociologists and criminologists that there are other societal factors at play in SA's continuing sky-high incidence of interpersonal violence.

With a population of some 60 million, less than a fifth that of the US, South Africa has substantially more murders per year than that vast country of over 330 million.

SA's adjusted murder rate per 100,000 people is currently at 31.8, compared to the US's 4.2.

By comparison, Africa's overall murder rate (for 2017, the latest year available as assessed by the World Population Review) was

Within Africa, Kenya had 4.87 murders per 100,000, while Uganda recorded 11.5 and Somalia just

From its peak killings of the mid-1990s, SA steadily dropped in its murder rate through 2011, when it recorded 29.8 murders per 100,000, roughly half the rate of the immediate post-apartheid

But since 2012 it has seen a steady increase, only briefly interrupted by covid-19 social controls, including bans on alcohol sales and public consumption, as well as curfews, reducing many alcohol-related violent crimes.

Not counting this year's sharp rise, South Africa had dropped in 2020 indices and is ranked only the fifth most dangerous country out of the 144 covered.

Liberia, Venezuela, Gabon and

Afghanistan had eclipsed SA, but the country seems headed back to the top of the murder list, based on current trends.

As a measure of the situation, just 29 per cent of South Africans feel safe walking alone at any time

By another measure, that of the Numbeo 2021 Crime Index, South Africa is the third most dangerous country in the world to live in, with six cities featuring in the top

20 most dangerous cities globally.

The independent Institute for Security Studies highlighted the main contributors to the 'culture of violence' ravaging this society as poverty and inequality, as well as social stress from harsh environments in early childhood, lack of adequate parenting, high recidivism of nearly 90 percent for many violent crimes, and an overburdened criminal justice

So widespread is violence in SA that the government has an ongoing programme against genderbased violence (GBV), and a new term has been coined for violence in schools, also on the increase, and dubbed learner-on-educator violence (LOEV).

Violence between school-going and tertiary institution students is also common.

Most recently, two University of the Free State female students were killed, and others injured, during a vicious robbery on the campus.

Reflecting the mood of many South Africans, the university's vice-chancellor Francis Petersen said the violence had to stop, adding: "Enough is enough".

Well, its seven years since the news here was dominated by the historic visit of the Chinese President, and accompanied by much analysis. This merged with the debate on the building of the African Union headquarters, which has never really gone away, exemplifying as it does 'foreign' influence on the African continent.

At the time, I was weaning myself of thoughts of Asia, when a news item from "ghanaweb" re-kindled my in-

"Nkrumah would have rejected China's 'gift' to Africa "proclaimed the writer, referring to the then new twenty story headquarters of the African Union in Addis Ababa, a contentious construction since its completion in December 2011.

The impressive-looking building with the statue of Kwame Nkkrumah in front, was not a gift at all he said, but a bribe, or as the Chinese proverb says, "If you want to do something secret, do it in public".

He said that with the erection of the \$200 million colossus, in one swoop, China achieved what the western colonial powers took so long to do. Very true, but if my school history books were correct, their 'invasion' gifts to influentiall chieftains of long ago, began with only rolls of cloth, coloured beads and tin buckets...no wonder progress was so slow!

I suppose this "swoop' in marketing terms is what's called "product placement", which in this instance translates as "China in the heart of Africa". Indeed, the seventy two years have witnessed fruitful efforts undertaken, and great achievements spearheaded, by the Communist Party of China (CPC)and the Chinese Government to transform not only the Chinese society, but also the world economically, socially and politically. Surely, it is through that transformation that cooperation and partnerships were forged with both developed and developing worlds, and more specifically with the African countries.

Prior to the establishment of the Forum on China-Africa Cooperation (FOCAC) in October 10-12, 2000, some African countries, such as Tanzania, had already forged strong cooperation with China which was championed by the founding fathers of the two Republics, namely Mao Zedong and Julius Nyerere respectively. Today, the China-Tanzania friendship is more than half a century old and remains solid and unshakable.More importantly, it has become a living symbol of China-Africa friendship. Therefore, FOCAC, as a successor cum extension of earlier cooperation arrangements laid the foundation for development of China-Africa socio-economic relations in the new era.

In this regard, the two sides committed themselves to developing a new partnership underpinned by the principles of mutual respect, equality, mutual benefit win-win cooperation and international justice. Indeed, it is in the context of the foregoing that FOCAC focused on ten areas for spearheading the cooperation. These are the following: Industrialization, infrastructure development, finance, green development, trade and investment facilitation, poverty reduction, public health, culture, and peace and security.

Research observations show that African countries who seized the unfolding opportunity have realized tangible results ranging from heightened economic growth rates, reduced poverty rates, improved investment climate and connectivity, higher level of industrialization. to widened and deepened involvement in global value chains. Such countries, among others, include South Africa, Nigeria, Egypt, Kenya, Tanzania and Rwanda.

These positive results notwithstanding, the onset of the coronavirus (COVID-19) which has virtually brought the whole world to a stand-still, both economically and socially, has made pessimists and the enemies of China and Africa to believe that the Belt and Road Initiative (BRI) would not be able to withstand the pandemic's headwinds. To the contrary, the Initiative pressed ahead against all odds, by making encouraging progress

and coming up with new proposals for building resilience, as well as making it more comprehensive and up-to-date. This is the good news.

First, trade in goods between China and BRI countries, including Africa, reached 5.35 trillion Chinese yuan (equivalent to US\$827 billion) in the first half of this year, registering a year-on-year growth of 27.5%. Trade in goods with BRI countries now accounts for 29.6% of China's total trade volume.

Second, connectivity-building initiatives in the partner countries continue to be undertaken and these infrastructures have played a major role in fighting the virus. Indeed, without them the transfer and transportation of medical facilities would have been an uphill task. This being the case, connectivity strengthening will continue to be the foundation of economic recovery and keep the industrial and supply chains secure, open and stable. All these will take place in the context of globalization, coupled with adherence to objectives, principles and agreements of multilateral, trilateral and bilateral cooperation. Ultimately, they will create a prosperous and peaceful world with a shared future.

Third, China provided assistance to 122 BRI partners to support their responses to the pandemic. The assistance consists of, among others, sending of medical expert teams and sharing of experience in containment, diagnosis and therapy, donation and supply of COVID-19 vaccines, and cooperation with BRI countries in localization of vaccine production. All these actions were taken when Western countries, especially the USA, were busy with finger-pointing, stigmatization, racism and xenophobia as well as embracing unilateralism and loudly raising anti-globalization voices. In this regard, China's actions are a clear testimony of "a friend in need is a friend indeed", and Africa needs to enhance its trust on China, while scaling-up its pro-

Fourth, with a view to make BRI more comprehensive and cognizant of the challenges of the pandemic. a new component was incorporated into the BRI, i.e. the "silk road of health". This incorporation would go a long way in putting in place a global architecture for planning the responses, managing and mitigating the impact of future pandemics. The main beneficiaries of this added component would be African countries, given the fragility of their public health systems and the low level of vaccination at four percent. Indeed, China's intent to produce the vaccines in Africa, will go a long way in improving vaccines distribution in the continent and hence narrow the observed inequality in vaccination between developed and developing

Fifth, technology has been the blood nerves and arteries of economies during the COVID-19 pandemic. This being the case, the post-pandemic development has to continue relying on and developing farther the requisite technologies, hence the added component of "technological silk road".

Indeed, with this in mind, the proposal was to enhance cooperation in digital economy, promotion of e-commerce, smart cities and other applications of digital technology, as well as the use of artificial intel-

ligence and big data technology.

It is clear that the five aspects enumerated above are a morale booster, given the devastating impact of COVID-19 on world economies in general, and Africa in particular. However, in order for Africa to effectively seize the ongoing and unfolding opportunities embedded in the cooperation menu, it has to address the following challenges.

One, change the mindset of both leaders and ordinary citizens from that of selfishness to one which is more development-oriented and

Two, enhance the human and institutional capacity for policy formulation, planning and above all implementation.

Three, scaleup negotiation capacity underpinned by the realities of Africa in terms of diversity and richness in resources.

Therefore, it is imperative to managenatural resources effectively and efficiently, while ensuring that some components of the cooperation are either country or continental tailored or both, reflective of equal partnership, with a view to realize win-win outcomes in the context of mutual benefit instead of zero-sum framework.

Long live China-Africa cooperation and long live China-Tanzania friendship!

VER the last few days, the headline-grabbing mass shootings that occurred nearly back to back across the United States have once again cast doubt on the freedom of bearing arms, a controversial right that has been guarded by the U.S. constitution.

When lawmakers adopted the Second Amendment to the United States Constitution in 1791, they might have not foreseen that more than 200 years later, what they treasured as fundamental individual freedom has become the main culprit in nationwide shooting crimes, with people killed and families broken on a daily basis.

The easy accessibility to fatal arms guaranteed by the amendment has also created such tragedies as a 4-year-old kid killing himself with a gun and a 3-yearold child shooting his brother dead by accident.

It has even resulted in a horrible scene: arming the teachers to protect themselves against students who bear guns.

Since 1972, more than 80 people on average, including about 12 children, have been killed by gunshots per day in the United States, according to statistics.

The staggering figures can find their root causes in America's pervasive social problems. In recent years, the widening wealth gap and growing social division have prompted some marginalized groups to go to extremes and resort to vio-

pressures resulting from the COVID-19 outbreak have also played their roles, causing a surge in violent crimes, especially shootings with racist tendencies. It is a vicious circle that the freedom of owning arms fuels social violence, which in turn pushes people to buy more weapons.

The recurrent shootings have laid bare the incompetence of the U.S. governance. Even though there are loud voices within the country opposing bearing arms, Washington has hardly taken a step forward on the issue. Among the main obstacles to gun control efforts in the United States are influential interest groups.

CCBRT pavilion in Dodoma was a crowd puller since a big number of visitors went there to know services the institution has rendering in the country.

Leticia Sadiki, a resident of Kondoa who is beneficiary of CCBRT described the services provided by the institution as unique, saying CCBRT treated her without paying single.

"I was no body before getting treatment. My husband deserted the family because of my illness, but with help from CCBRT I am now cured. They supported me everything transport, accommodation plus free treatment," she During the past ten years, we have said without exposing what she was suffering.

World far behind on global vaccine targets, while poorer nations remain back of dosage queue

NLY 4% of Africa's population has been fully vaccinated against Covid-19. This is despite the continent's efforts, including those of the Africa Centres for Disease Control and Prevention (Africa CDC) and the campaign led by South African President Cyril Ramaphosa as chair of the African Union (AU) last year. Just 6.4% have received one dose, according to the Africa CDC.

Global instruments such as Covax aimed to get vaccines to poor and middle-income countries, and the World Health Organization's (WHO) Covid-19 Tools Accelerator was launched to speed up production and access to tests, treatments and jabs. African initiatives to get more vaccines include the AU Covid-19 Response Fund and the Africa Pool Procurement Portal.

The rate of vaccination on the continent is increasing. But attaining the WHO's target of 30% fully inoculated in Africa by the end of 2021 looks impossible. Ramaphosa pointed out at the United Nations (UN) last week that, "Of the around six billion vaccine doses administered worldwide, only 2% of these have been administered in Africa, a continent of more than 1.2 billion people. This is unjust and immoral."

He noted that globally the world was also falling well short. The WHO set a target of vaccinating at least 70% of the world's population by September 2022. cut off support to the WHO - certainly didn't help. Last week his successor Joe Biden attempted to step into the leadership vacuum by convening a Covid-19 summit on the margins of the UN General As-

He announced a raft of measures to address the pandemic and meet the target of 70% vaccination in all countries by next year's General Assembly. These included a pledge by the United States (US) to donate an extra 500 million vaccines through Covax, bringing US vaccine donations to 1.1 billion. The European Union (EU) pledged to donate one billion, and Italy, Denmark, Japan, Spain, Sweden, Australia and New Zealand increased donations.

Biden's most important announcement was perhaps to call on his peers to support the establishment this year of the \$10-billion global health security fund to tackle Covid-19 vaccines and treatment. This would likely be something like the Global Fund to fight Aids, Tuberculosis and Malaria.

Biden offered to kickstart the fund almost with \$1.1-billion of US money. Several other heads of state, including Ramaphosa and the leaders of the EU, Italy and Norway, expressed support for the idea, though evidently did not pledge specific amounts.

The big question, of course, is why would this particular fund succeed where so many other efforts to get Covid-19 vaccines to the world have failed? Mark Heywood, a veteran health activist in South Africa, is cautiously optimistic about the prospects, noting that the Global Fund has been quite successful in mobilising funds to fight Aids, TB and malaria.

But perhaps Biden's initiative has a better chance simply because world leaders seem at last to be mobilised. As Carolyn Reynolds of the Center for Strategic and International Studies (CSIS) pointed out at a 24 September seminar in Washington, the WHO's 70% target

White House last year – who even had been around for many months. Yet last week was the first time global leaders had assembled to decide how to meet the target.

This year's G7 summit of the richest countries had been expected to do that but failed, she said. Reynolds and other experts on the CSIS panel agreed that Biden's summit had been a success in at last mobilising global support to achieve equity in Covid-19 vaccination – and also in therapeutics.

The summit had important gaps though. As J Stephen Morrison of the CSIS underscored, China and Russia were conspicuously absent, and the private pharmaceutical sector was also largely not in attendance. He noted that many developing world leaders told Biden's meeting that they didn't want charity – they wanted the means to manufacture vaccines and therapeutics themselves.

One of those was Ramaphosa. He used the opportunity to plug for a temporary waiver of the World Trade Organization's Trips provision that protects the patent rights of pharmaceutical companies. He wants that protection to be suspended temporarily to allow others to manufacture Covid-19 vaccines at no cost. Heywood agrees that it is necessary to meet the world's vaccine demand.

But while that remedy is vital, it would probably take two to three years to kick in, according to some experts. Action is needed in the meantime. One option the CSIS panellists agreed should be expanded on was to back licensed manufacturing.

The US is already supporting South Africa to manufacture Johnson & Johnson vaccines to supply Africa. And the US, Germany, France and World Bank support the development of mRNA Covid-19 vaccines in South Africa, Senegal and Rwanda. Yet even these admirable manufacturing enterprises aren't enough or will come too late.

Rich nations pitch billions in aid to fund South Africa's coal exit

JOHANNESBURG

Envoys from some of the world's richest nations have met with South African cabinet ministers to discuss a climate deal that could see billions of dollars put towards ending the country's dependence on coal.

The delegation is trying to hammer out an agreement that can be announced at the Cop26 climate talks, which start in Glasgow, Scotland on 31 October, two people familiar with the talks said. The discussions with South Africa - the world's 12th biggest emitter of greenhouse gases - include representatives from the US, UK, Germany, France and the European Union.

While South Africa is under pressure to cut its dependence on coal - which accounts for more than 80% of its power generation – it needs finance to facilitate the transition to cleaner energy. Developed nations may also need to find a way to address the challenges faced by Eskom, which is burdened by R400-billion of debt.

The envoys met on Tuesday with South African ministers including Pravin Gordhan, the public enterprises minister whose portfolio includes oversight of Eskom, Barbara Creecy, the environment minister, and Ebrahim Patel, the trade & industry minister, the people said, asking not to be identified as a public announcement has yet to be made. Talks were due to be held on Wednesday with trade unions, business leaders and the Presidential Climate Change Coordinating Commission, three people familiar with the arrangements said.

The ministers pressed for details on

ADDIS ABABA

Soaring gas prices are eating into the margins of greenhouses in the Netherlands and elsewhere in Europe. Europe's gas shortages have boosted demand for flowers from East Africa, although Kenya, a major producer, is struggling to grasp the opportunity because of freight capacity constraints.

Soaring gas prices are eating into the margins of greenhouses in the Netherlands and elsewhere in Europe. Some producers are cutting their growing seasons short to cut back on fuel use - forcing buyers to look for alternatives.

"It's a wonderful opportunity for us and Kenya," said Tewodros Zewdie, executive director of the Ethiopian Horticulture Producers Exporters Association. "We generally have better labour, energy and freight costs that have brought a lot of interest, and we are expecting more," he said by phone from Addis Ababa.

Ethiopian growers can pounce on the situation in Europe and readily ex-

port their blooms because of abundant freight space on the national carrier, Ethiopian Airlines. Not so for Kenyan producers, who supply about a quarter of the cut flowers sold in Europe. About 70% of Kenya's blooms go through Amsterdam. A 1 000-ton-per-week shortfall in freight space that's left cold storages full has been compounded by a 10% jump in shipping costs effective October 1, according to the Kenya Flower Council.

"We have the volumes, we have the demand in the market, but freight is a major issue." Clement Tulezi, the council's chief executive officer, said by phone from Nairobi. "We are in a desperate situation. In about two weeks, we are expecting bigger demand, so if we don't have the capacity, it will be a shame."

Kenya's horticultural exports, including fruits and vegetables as well as flowers, were worth 151.2 billion shillings (\$1.37 billion) in 2020, according to industry data. Comparable Ethiopian exports were worth \$530 million in the fiscal year that ended July 7.

UGARCANE out-growers in Kilombero have all the reasons to smile following the signing of a two year contract that allows them to sell their commodity to Kilombero Sugar Company Lim-

The deal which was signed between KSCL's Managing Director, Guy Williams and Kilombero Sugarcane Cooperative Union's Onesmo Mwakyambo last week gives the out-growers a reliable and lucrative market for their commodity.

Speaking after signing the agreement, KSCL's Williams said the deal is very important for the sugar manufacturing company because the farmers supply more than 600,000 metric tons of the cane used as raw material per

He said the current focus of his company is to expand the factory with an investment of 571bn/hence the two year contract assured KSCL of reliable supply of cane as raw material. "This agreement is very important because apart from guaranteeing the sustainable supply of cane, it also assures us of raw materials for factory after expansion," Williams said.

Under the deal, the total number of small-scale farmers supplying cane will increase to between 14, 000 and 16, 000 out-growers from 7,500 while direct employment will also increase by over 2,000 throughout cane supply value chain.

In remarks after inking the deal, KSCU's Chairman, Onesmo Mwakyambo said the renewed contract is very important to the farmers because it assures them of the market especially after the factory expansion project is completed.

"We currently have the capacity of producing more cane than what the mills can crush annually, and the quantity as well as quality of our cane has improved very much particularly due to improved road infrastructure that has made it easier to transport sugar cane from farms to the factory," he noted.

KSCL's Head of Corporate Affairs, Joseph Rugaimukamu said the two sides have signed the two year contract after a one year contract signed last year expired. Rugaimukamu said the market for sugarcane in the country is currently favourable to farmers thanks to the government's effort in protecting local sugar industries. "The price of sugarcane has increased from 95,112/- per ton during the past season to 103,361/per ton in the current season," he

Treasury seeks Sh1bn subsidy for KTDA farmers as fertiliser price rises

The Treasury is processing Sh1 billion to offer fertiliser subsidy to farmers affiliated to Kenya Tea Development Agency (KTDA) following a sharp rise in cost of the commodity.

Agriculture Cabinet Secretary Peter Munya said they requested the fund to help farmers afford the essential input. The local price of fertiliser, pushed by rising international prices, has risen to Sh3,073 for a 50- kilogramme (kg) bag, a 54 percent increment compared with the previous season.

"KTDA through my ministry has requested the government for fertiliser subsidy amounting to Sh1 billion, which will reduce the cost by Sh600 to Sh2,473 per 50Kg bag," said Mr Munya. "The request is currently being processed by the National Treasury," added Mr Munya.

The small scale tea farmers had to content with the lack of subsidised fertiliser from KTDA last year after its importation was affected by outbreak of the coronavirus pandemic that impacted on global logistics chain that was characterised with a shortage of shipping containers. KTDA suspended the importation of the inputs last year and even refunded farmers Sh1.3 billion it had earlier deducted from their pay.

The move saw farmers procure the input for their crop from local dealers at a relatively high cost of up to Sh3,000 for a 50 kg bag as compared to Sh1,700 to Sh2,000 that they pay when they are being supplied by the tea Agency.

The tea agency imports the fertilisers from Europe, mainly Russia by direction from the Ministry of Agriculture. A ship loaded with 65,000 tonnes of fertiliser (1.5 million bags of 50kgs) docked at the Port of Mombasa for distribution to out-growers across the country recently.

China is sending shockwaves through SA markets

CAPE TOWN

The country's benchmark equity index has posted its worst quarter since the first three months of 2020 amid concern about an energy crunch weighing on China's economic growth and Beijing's regulatory crackdown on key sectors including technology. China is the biggest buyer of South African raw materials.

With the 18-month rally in industrial metals on shaky ground, and the Federal Reserve poised to start scaling back stimulus, investors are preparing for more volatility in the FTSE JSE Africa All Share Index.

"The key value drivers, in terms of the currency and the commodity bull market, are weaker than they were a year ago," said Peter Brooke, the Cape Town-based head of macro solutions at Old Mutual Investment Group, which oversees about \$40 billion. "We have a big chunk of our markets linked to China." These charts illustrate how China's troubles are weighing on South African stocks:

The Africa All Share Index slipped 3% in the first quarter or more than 8% in dollar terms - and extended the decline on Friday.

Global airline bosses to chart future of travel at 'milestone' aviation summit

Global airline chiefs will gather in person for the first time in two years at their annual industry meeting, signalling a rebound from the disastrous effects of the Covid-19 pandemic, to discuss pressing issues from charting a post-crisis recovery path to tackling growing environmental pres-

The industry's bosses will converge in Boston on Sunday to reflect on an aviation landscape ravaged by the worst crisis in its history and trace the future of travel in a post-Covid era. At the top of their agenda will be the challenges of reducing carbon emissions, restarting global travel while mitigating Covid-19 health risks, eco-friendly technologies such as hydrogen-powered planes and progress on improving the persistently-low levels of diversity in senior ranks.

The International Air Transport Association's 77th Annual General Meeting will be held from October 3 to October 5 alongside the World Air Transport Summit, after it was

postponed in June and held online in 2020. "This year's AGM is expected to become one of the most symbolic and significant in-person gatherings of global aviation leaders in history," Linus Bauer, founder and managing director of Bauer Aviation Advisory, said. "The 77th AGM will mark a milestone on the flightpath to a brighter future in the post-pandemic era. The inperson interaction is undoubtedly

essential in driving business opportunities, tackling current issues in aviation and in sparking innova-

The three-day summit will reveal Iata's latest economic forecast for the industry's losses this year and the latest projection of recovery to pre-crisis levels. In April, Iata predicted industry losses of \$47.7 billion in 2021, an improvement on last year's \$126.4bn deficit. The summit will also explore air passenger and cargo trends, key indicators of consumer confidence and world trade as the global economy recov-

The gathering of some 100 aviation chief executives will be the first inperson AGM with Iata director-general Willie Walsh since he took the helm in April. The meeting will set an example to encourage the return of business travel that continues to lag behind leisure trips, analysts say.

"It's important for the industry to support the wider return of conferences which are an important market for the airlines," John Grant, chief analyst at data specialist firm OAG, said. "They can hardly bemoan the slow recovery of the MICE [meetings, incentives, conventions and exhibitions] market if they don't hold their own event." Air travel demand is currently in better shape compared to 2020 as rising vaccine and testing levels worldwide encourage more governments to reopen their borders.

The US reopening to international travellers will also boost the lucrative transatlantic market and provide much-needed relief to cash-strapped airlines. "There are some really positive signs, particularly the imminent opening up of the Europe-US market, but nevertheless there's a long way to go before getting close to any broad normality," aviation consultant John Strickland said.

However, developed countries have better access and faster roll out of vaccines than developing economies, which has led to an uneven global economic growth and affected the shape and pace of airlines' recovery. "For any meaningful aviation recovery to take place and be sustained, there has to be a rapid and equitable roll out of vaccines in all countries, something which is currently far from the reality," Mr Strickland said.

The International Monetary Fund in July forecast global economic growth of 6 per cent in 2021 and 4.9 per cent for 2022. The fund also warned of an uneven recovery and downgraded its growth outlook for emerging market and developing economies because of the unequal access to vaccines and the emergence of Covid-19 variants.

"The aviation industry is a barometer for the global economy and developing markets are a challenge for airlines," Mr Grant said, pointing to the low vaccine rates in Africa and ensuing complications of flying internationally.

OAG expects global airlines' capacity to be only 10 per cent to 15 per cent more than last year with travel demand "still very soft", making this year only slightly better than 2020, Mr Grant said. The industry is healthier now than in 2020, but it "isn't healthy enough to leave the intensive care unit yet," Mr Bauer said.

In August, total demand for air travel (measured in revenue passenger kilometers or RPKs) was down 56 per cent compared to August 2019, and slowed down from 53 per cent in July, according to Iata's monthly

"August results reflect the impact of concerns over the Delta variant on domestic travel, even as international travel continued at a snail's pace toward a full recovery that cannot happen until governments restore the freedom to travel," Mr Walsh said.

As we plan for the industry recovery from Covid-19 and address critical climate change issues, the in-person discussions and debates among the industry's top leaders and stakeholders will be particularly sig-

Coal surges to record high global scramble for energy accelerates

LONDON

Coal prices soared to their highest on record as China accelerated a global struggle for resources that's brought the dirtiest fossil fuel roaring back.

High-quality thermal coal loaded on ships at Newcastle port in Australia surged to \$203.20 a ton, breaking the previous record set in July 2008. That's the benchmark price for Asia, the world's largest market for the fuel by far.

The rally comes during a global energy crunch that's hitting China, the world's biggest coal producer and consumer, especially hard. And as gas prices spike higher in Europe, there's been a resurgence in demand for the fossil fuel that the continent's policy makers have long been trying to phase out. Still, there isn't enough coal to go around. A German electricity producer closed one of its plants recently after it ran out of the fuel.

Earlier this week, Chinese Vice Premier Han Zheng ordered stateowned energy giants to secure fuel supplies for winter at any cost. China consumes and mines half the world's coal, and it's also the largest importer. The government told miners to keep digging even if they've exceeded their annual quota.

Prices for thermal coal tracked by IHS Markit and Argus have surged since late 2020 as demand rebounded from the depths of

the pandemic and with substitute fuels like natural gas becoming more expensive. The emissionsheavy fuel is back in vogue just weeks before nations gather in Scotland for the COP26 summit on climate change.

Supply issues also boosted prices. China has struggled to raise output amid tighter safety controls following fatal accidents, while torrential rains, labour problems and transportation bottlenecks hampered exports from countries such as Indonesia, Australia, Colombia and South Africa, among others. The Newcastle coal benchmark could average \$190 a ton from October to December, Goldman Sachs Group said in a note in September.

The gains come as the world plans to shift away from the emissions-intensive fuel in favour of renewable sources that will help reach net-zero targets. Even China aims to start reducing domestic consumption by 2026, and President Xi Jinping pledged to stop building new coal-fired power plants abroad.

In the short term, demand in key nations is proving resilient. Thermal power generation in China was 14% higher in the year through August than in the previous two years. Demand in 2022 could be marginally higher than this year, potentially rising 1%, said Shirley Zhang, a coal analyst with Wood Mackenzie.

Russia

Russia registered 25,219 new coronavirus cases in the past 24 hours, the largest daily number since July 16, the government's task force in charge of fighting the illness said.

Meanwhile, the country's health chief said all the barriers to register Russia's Sputnik V COVID-19 vaccine with the World Health Organization have been cleared and only some paperwork remains to be completed.

The Sputnik V shot, widely used in Russia and approved for use in over 70 countries, is undergoing a review by the WHO and the European Medicines Agency. Their approval could open up new markets for the shot, especially in Europe.

Russian Health Minister Mikhail Murashko said on Saturday that the company which is dealing with only "has to sign a few documents submit a few additional papers".

The WHO said in July its review of how Russia produces the Sput nik V vaccine had found some issues with the filling of vials at one plant. The manufacturer said it had since addressed all of the WHO's concerns.

US President Joe Biden marked the "painful milestone" of 700,000 US deaths from COVID-19, saying it's a reminder for Americans to get vaccinated. He said "we must not become numb to the sorrow."

Hamas leaders to discuss in Cairo cease-fire, prisoner swap deal with Israel - official

LEADERS of the Islamic Resistance Movement (Hamas) will discuss in the Egyptian capital Cairo on Sunday for a cease-fire in the Gaza Strip and a possible prisoners' swap deal with Israel, a senior official said on Saturday.

Yahva Sinwar, leader of Hamas in the Gaza Strip, tweeted that he will join a Hamas delegation headed by the movement's politburo chief Ismail Haniyeh that will go to Cairo on Sunday to meet with senior Egyptian security intelligence officials.

"The talks with the Egyptian officials will handle the issue of the cease-fire and the issue of a prisoners' swap deal that might be reached between the Palestinian factions and Israel," Sinwar added.

On May 10, Israel waged a military offensive on the Gaza Strip that lasted for 11 days in response to the launching of rockets towards Israel. The offensive ended after Egypt and other mediators brokered a cease-fire between Israel and Hamas-led militants.

Since then, the Egyptian-brokered cease-fire between Israel and Hamas had been fragile and was violated several times by militants who fired rockets and activists who launched incendiary balloons towards Israel.

In response, Israel carried out airstrikes on militants' facilities and posts, most of which belong to the armed wing of Hamas.

A few days ago, Hamas leaders said they presented to the Egyptian side a roadmap for reaching a prisoners' swap deal with Israel. They said they are ready to indirectly negotiate a deal with Israel through a mediator.

Algeria recalls ambassador to France for consultations

ALGIERS

ALGERIA has recalled its ambassador to France for consultations after what it called "irresponsible" comments attributed to French President Emmanuel Macron, Algeria's presidency said on Saturday.

"Following comments that several sources attributed to ... Macron, Algeria expresses its categorical rejection of inadmissible interference in its internal affairs," the presidency said in a statement.

"Faced with the particularly inadmissible situation inflicted by these irresponsible remarks, President Abdelmadjid Tebboune decided to immediately recall the ambassador," it said.

The statement said the remarks, which have not been denied by French authorities, are harmful to Algerian martyrs who fought for independence from France, without giving details.

"Those remarks are an intolerable attack on the memory of martyrs," it said.

On Thursday, the government said it had summoned the French ambassador to Algiers after Paris decided to slash the number of visas it issues to nationals of Algeria and other countries in North African's Maghreb region.

Algeria's foreign ministry described the move, which France said was in response to Maghreb governments' refusal to take back illegal migrants sent home by Paris, as a "unilateral decision of the French government".

FORMER US president Donald Trump asked a federal judge to force Twitter to temporarily reinstate his account while he sues to permanently return to the social media network.



Trump's request for a preliminary injunction against Twitter was filed late Fon riday in Miami, Florida. The Republican, who lost his bid for a second term in office, claims Twitter canceled his account in January under pressure from his political rivals in Congress.

Twitter declined to comment on the filing.

Trump had more than 88 million followers on Twitter. The company kicked him off its platform on Jan 8, two days after a mob of his supporters carried out a deadly attack on the Capitol to prevent President Joe Biden's victory from being confirmed by Congress. Trump used Twitter and other social media platforms to falsely and repeatedly claim that the election had been rigged.

Twitter "exercises a degree of power and control over political discourse in this country that is immeasurable, historically unprecedented, and profoundly dangerous to open democratic debate," the former president's lawyers said in the filing.

Trump also claims Twitter improperly censored him during his presidency by labeling his tweets as "misleading information" or indicating they violated the company's rules against "glorifying violence."

Pause in Israeli settlement activity in occupied Palestinian territory must become permanent -- UN envoy

UN Special Coordinator for the Middle East Peace Process Tor Wennesland said on Wednesday that the current pause in Israel's settlement activity in the occupied Palestinian territory, including East Jerusalem, must become permanent.

There were no new settlement housing plans advanced, approved or tendered between June 12 and Sept. 27, Wennesland told the Security Council in a briefing.

"I reiterate that all (Israeli) settlements are illegal under international law and that they undermine the prospect of achieving a viable twostate solution in line with UN resolutions, international law and prior

The pause in new advancements and tenders of plans for housing units in settlements observed during this reporting period must become permanent," he said. He expressed deep concern over the continued demolitions and seizures of Palestinian-owned structures, which have included internationally funded humanitarian projects.

He urged Israel to cease demolitions and evictions and to approve plans that would enable these communities to build legally and address their development needs.

Citing the absence of Israeli-issued building permits, which are almost impossible for Palestinians to obtain, 302 structures were demolished or

seized by Israeli authorities or demolished by their owners to avoid heavy Israeli demolition fees during the reporting period. These actions displaced 433 people, including 251 children and 102 women, said Wennesland.

On July 7, Israeli authorities demolished some 30 structures, of which 17 were provided as humanitarian assistance, in the Bedouin community of Humsa Al Bqai'a in the Jordan Valley.

On July 14, Israeli authorities confiscated at least 49 structures in the Bedouin community of Ras al Tin in the Ramallah governorate. As a result, 84 people, including 53 children and 14 women, were displaced.

On Aug. 11, the Jerusalem Local Affairs Court froze the demolition of several dozen structures in the al-Bustan section of the Silwan neighborhood until Feb. 10, 2022, pending ongoing planning discussions, he

On Aug. 2, Israel's Supreme Court held a hearing to consider an appeal request by four Palestinian families facing forced eviction in the Sheikh Jarrah neighborhood in East Jerusa-

The judges made a proposal, which was not accepted, and the hearing was adjourned with no date to reconvene. There are currently some 970 Palestinians facing eviction in East Jerusalem, he said.

On July 2, some 50 Israeli settler families left the settlement outpost



of Evyatar, illegal also under Israeli law, following an agreement with the Israeli government that the Israeli military would re-establish a presence at the site and a land survey would be conducted to determine

land status, he said.

Wennesland also voiced deep concern about the continued settlerrelated violence in the occupied West Bank, including East Jerusalem. Across the occupied West Bank, including East Jerusalem, settler-related violence continued, including reports of armed settlers carrying out attacks against Palestinians in proximity to Israeli security forces, he said.

On Aug. 17, a 15-year-old Palestinian boy was attacked in the northern part of the occupied West Bank, during which a group of Israeli settlers kidnapped the boy and brutally assaulted him, said Wennesland.

During the reporting period, a total of 102 attacks occurred in which Israeli settlers or other civilians injured 36 Palestinians or reportedly damaged property.

Palestinians perpetrated 193 at-

tacks against Israeli settlers and other civilians in the occupied West Bank, including the throwing of stones, Molotov cocktails, and pipe bombs at civilian vehicles, resulting in 27 injuries and damage to property, he said.

"Israel, as the occupying power, has an obligation to ensure the safety and security of the Palestinian population and to investigate such attacks. I underscore that all perpetrators of violence must be held accountable and swiftly brought to justice," said the envoy. Xinhua Russia, US agree to set up two working groups on strategic stability - Russian

RUSSIA and the United States have agreed to set up two working groups on strategic stability issues, Russian Deputy Foreign Minister Sergey Ryabkov said on Thursday.

"We agreed to set up two working groups that will address these [strategic stability] issues," he said.

"First, we will have to continue the exchange of signals, rather than questions and answers, which are the core of the work at the current stage. It can be done as the work proceeds.

For instance, today the methodology included responding to questions that each side had sent to the other before," he said, adding that the groups will be tasked to analyze each other's approaches.

"Then, we will see more clearly when it is time for another offline meeting," he noted.

According to Ryabkov, one of the groups will address arms control issues and the other will deal with technical aspects of the sides' nuclear arsenals and "each other's actions" that might have a strategic

"In other words, concepts and theories on the one hand and practical aspects and what the sides have on the other hand," he added.

Gross ecosystem product of tropical rainforest national park in Hainan exceeds 204.5 billion yuan

THE gross ecosystem product (GEP) of the Hainan Tropical Rainforest National Park in south China's Hainan province, a pilot area of the country's national park system, surpassed 204.5 billion yuan (\$31.6 billion) in 2019, according to research results released on Sept. 26.

GEP, referring to the total economic value of all the final ecosystem products and services supplied by ecosystems to human well-being and economic and social sustainable development, mainly includes the value of material products, regulating services, and cultural services provided by ecosystems.

Li Yide, a research fellow at the Chinese Academy of Forestry (CAF), believes that GEP, which places a price tag on ecosystem products and services and specifies the amount of their economic value, helps people better understand that a sound ecological environment means tremendous wealth for Hainan, home to China's densest, best-preserved, and largest contiguous tropical rainfor-

Besides, the calculation of GEP is an essential precondition for promoting its application in ecological protection incentives, ecological damage compensation, financing for ecosystem product and service development and operation, as well as trade in ecological resource rights.

The calculation of the GEP of the national park mainly requires drawing a map of ecosystems in the region, determining ecosystem products and services to be calculated, collecting data and establishing models, measuring the biophysical value of ecosystem goods and services, as well as pricing them and calculating their monetary value.

During the first step, drawing a map of ecosystems, the national park was divided into different geographical units, each of which was marked with its ecosystem type, tree species, height and crown density, as well as other attributes. Then 19 indexes under the three indicators of material products, regulating services and cultural services were considered in the GEP calculation for the national

To obtain these key parameters, the research team conducted extensive field research, with more than 200 fixed sample plots set up, and conducted interviews and questionnaire surveys.

Pricing ecosystem goods and services is necessary for determining their value based on previous surveys.

"For ecological products that haven't entered the market yet, we mainly calculate their monetary value through a surrogate market approach and a simulated market method," pointed out Chen Dexiang, director of the Jianfengling national field scientific observation and research station for forest ecosystem in Hainan under the CAF.

"To put it simply, a surrogate market approach means determining the value of nonmarketed ecological goods by replacing them with similar ones with known prices; and by a simulated market method, we price non-marketed goods based on consumers' willingness to pay," Chen explained.

The GEP calculation has improved people's ecological awareness. "I never thought the natural environment in my hometown can be so valuable," said Fu Jingkai, secretary of the Communist Party of China (CPC) committee in Qingsong township, Baisha Li autonomous county of Hainan. The township is located in the Hainan Tropical Rainforest National Park.

"We can also try including the total value of ecological products in the comprehensive performance evaluation of the achievements of CPC committees and governments in promoting high-quality development," Li noted.

Based on GEP, it is also possible to establish a benefitoriented mechanism for ecological and environmental protection, and encourage local governments in China to establish diversified capital investment mechanisms, and call on social organizations to set up ecological public welfare funds to promote the realization of the value of ecological products, he added.

LDP new leader Kishida to take office as PM, launch new govt

TOKYO

THE newly elected leader of Japan's ruling Liberal Democratic Party, Fumio Kishida, will take office as the Japanese prime minister yesterday and launch his new government, aiming to promote economic recovery while keeping

COVID-19 infections under control. With the LDP-led ruling coalition controlling both chambers, the 64-year-old Kishida is almost guaranteed to be elected prime minister at an extraordinary parliamentary session yesterday.

The new leader plans to dissolve the House of Representatives on Oct 14, and consequently, a general election is likely to be held on Nov 7, local media reported, citing sources.

Kishida (pictured) has promised to increase middle-class incomes and reduce wealth disparity under his "new form of capitalism", which is viewed as a break from the

"neoliberal policies" that the Japanese government has pursued over the past two decades.

In addition, he said that an economic package worth "tens of trillions of yen" is in preparation to help people and businesses suffering from the COV-ID-19 pandemic.

Benitez's flying start silences **Everton sceptics**

LONDON

RAFAEL Benitez's appointment as Everton boss was not a popular one with supporters given his past as a Champions League-winning Liverpool manager, but the Spaniard's tactical nous has the Toffees dreaming of European football.

Everton have lost just one of Benitez's first seven Premier League games in charge despite a limited budget due to financial fair-play restrictions and injuries to star strikers Dominic Calvert-Lewin and Richarlison.

A 1-1 draw away to Manchester United kept Benitez's men level on points with the Red Devils and Liverpool and one ahead of Manchester City ahead of the champions' trip to Anfield on

United boss Ole Gunnar Solskjaer could afford the luxury of bringing Cristiano Ronaldo, Jadon Sancho and Paul Pogba on as substitutes, while Benitez had to name three teenagers to fill out

But a point was the least the visitors deserved from a performance that married the defensive organisation Benitez's sides are famous for with a potent threat on the counter-attack.

Everton's goal showed the impact the 61-yearold has had in just a few months in charge.

After an Everton outlay of £240 million (\$325 million) in transfer fees over the past three years, Benitez's spending was limited to £1.7 million to bring in Demarai Gray and Andros Townsend during the transfer window.

At the same time he had to shave down the wage bill with James Rodriguez frozen out before his move to Oatari side Al-Rayvan.

But Gray and Townsend have shone as Everton have taken 14 points from a possible 21.

Gray showed his blend of strength, determination and pace to twice dispossess Fred and set in motion the counter-attack for Everton's equal-

Abdoulaye Doucoure is another player transformed by Benitez's arrival and the Frenchman provided his fourth assist of the season by rolling the ball into the path of Townsend for his fifth goal in nine games as an Everton player.

Townsend was available on a free transfer from Crystal Palace with his career seemingly in decline but he has been revived by reuniting with Benitez after the pair worked together previously at Newcastle.

"The manager demands the very best. He got the best out of me when I was at Newcastle and he seems to be getting the best out of me again at the minute," said Townsend.

"If I keep working hard, keep listening to the manager, hopefully I can continue getting on the

But for a matter of centimetres Everton could even have grabbed their first victory at Old Traf-

ford since 2013. Yerry Mina tapped home Tom Davies' cross in the dying minutes but the Colombian had just strayed offside, which was spotted by a VAR

Even a point felt like three for Benitez, given the side he had to cobble together due to inju-

"It is a good draw, mentally like a victory, with the players who aren't playing," said Benitez. "If we have everybody available and continue with the same team spirit, we can win more games.

"Hopefully, we can bring back some players but be sure that we keep the same mentality, the same commitment, the same intensity."

Calvert-Lewin, Richarlison, captain Seamus Coleman and Andre Gomes could return after the international break to bolster a bid to qualify for Europe next season.

That may be beyond a squad punching above its weight, but Benitez could not have asked for a better start to silence any lingering scepticism as to whether he was the best man for the job.

No Ronaldo heroics as Solskjaer's problems mount at Man United

OTHING is coming easily for Manches-United at the moment, and it's making life hard for Ole Gunnar Solskjaer.

Three days after the dramatic late Champions League win against Villarreal, there was another frantic finish at Old Trafford. This time, though, there were no Cristiano Ronaldo heroics and Everton held on for a 1-1 draw in the Premier League on Saturday.

It's not about to get any easier for Solskjaer after the international break with the next four league games against Leicester City, Tottenham Hotspur, Liverpool and Manchester City.

Andros Townsend's equaliser for Everton to cancel out Anthony Martial's goal just before the break also means United are without a Premier League clean sheet at Old Trafford since March. That run of nine games is their worst streak for 50 years, although they have still managed to accumulate four more points than at the same stage last season when they went on to finish second. Football can be a strange game.

"You are sat here a bit disappointed and deflated," Solskjaer said. "We just have to be focused and make sure we use the international break well. Come back with energy again, clear focus and a good mindset. Today we dominated; we just couldn't get that sec-

ond goal we needed. "We had 75% possession and got hit on one break that cost us. We lacked that cutting edge to get a second goal. We concede one and that is one too many. Today it was a counter-attack that they throw at us. We were well enough organised -- we should have dealt with it much better."

It was as good a goal as United have scored this season -- and all while Ronaldo, Pogba and Sancho watched on from the bench.

In four straight home games against West Ham United, Aston Villa, Villarreal and Everton, United have scored just three times. There are issues to solve at both ends of the pitch.

LUIS Suarez piled more misery on Barcelona by scoring in a 2-0 victory for Atletico Madrid on Saturday but Ronald Koeman insists he has the club's support to continue as coach.

Barca president Ioan Laporta had said a few hours before kick-off that Koeman would continue as coach "regardless of the result" at the Wanda Metropolitano. another limp display will put that commitment to the test over the two-week international break.

Koeman confirmed after the game he spoke to Laporta on Friday night and Saturday morning.

He said he welcomed the clarity over his future, which he believes will benefit the team.

"Clarity is very important, for the confidence of the coach, for the players too, for them to know the coach is still here," said Koeman.

"He has made his decision, as he said this afternoon, so everything is perfect."

Goal scorer Suarez put his hands together and looked up to the sky in what was initially a muted celebration, out of respect for his former club, where he spent six years and scored 198 goals.

"(It was) out of respect, love, for the journey I had at Barca and for the period they're in at the moment, for the fans as well," said Suarez after the game.
