

THREE people died, and two others suffered serious injuries in a car crash after a saloon car hit a parked lorry at Mbwewe area along the Chalinze-Tanga road at dawn vesterday.

Z'bar VP1 roots for environment efforts

ZANZIBAR First Vice President Othman Masoud Othman has called for collaborative efforts in the conservation of the environment and restore biodiversity in Zanzibar.

He was flagging off a project for water system strengthening at Masingini in the Urban West 'A' District in Zanzibar as part of celebrations to mark 60 years of the Zanzibar Revolution.

Collaborative efforts would help to develop the natural resource to benefit all Zanzibaris, he said, noting that it water comes from the environment so it is the responsibility of the general public and state officials to protect the project, for current and future benefits.

To emphasize the vital importance of environment, the government will launch a large tree planting project in all islands in the archipelago, he said, on the background of the environment portfolio within the FVP's office.

This will require the participation of every citizen and leaders to succeed in restoring Zanzibar's biodiversity, he said, asking water users to ensure that they pay their water bills in order timely, so that water projects are sustainable.

Group of Kyela natives donate 100 text books to help school students

A GROUP of natives from Kyela district who are in diaspora (Kyela Ibasa festival) has donated 100 text books to help students within schools in the district.

Chairman of the group Vanessa Nyesyenge handed over the books yesterday to the councillor for Ikimba Omary Rashid Mwinyijuma.

Vanessa said the books which will be given to Njisi secondary school, will help students to have more time to read.

"Among the visions of Ibasa is to help the Kyela community in the field of education, we are celebrating five years since the establishment of Ibasa, we have donated desks and now books that we believe will increase the motivation of students to study hard," said Vanessa.

deputy prime minister and a Mideast expert, was appointed the UN coordinator for humanitarian aid to war-torn Gaza, the United Nations chief has announced.

The announcement by UN Secretary-General Antonio Guterres follows the Security Council's adoption of a resolution on Friday requesting him to expeditiously appoint a senior humanitarian and reconstruction coordinator for Gaza, where more than 2 million civilians are in desperate need of food, water and medicine.

Guterres said Kaag, who speaks fluent Arabic and five other languages, "brings

a wealth of experience in political, humanitarian and development affairs as well as in diplomacy" to her new post.

"She will facilitate, coordinate, monitor, and verify humanitarian relief consignments to Gaza," he said, adding that Kaag will also establish a UN mechanism to accelerate aid deliveries "through states which are not party to the conflict."

Gaza's entire 2.3 million population is in food crisis, with 576,000 people at catastrophic or starvation levels and the risk of famine is "increasing each day," according to a report released by 23 UN and nongovernmental organizations. It blamed the widespread hunger on insufficient aid entering Gaza. Israel stopped all deliveries of food,

water, medicine and fuel into Gaza after the militant Hamas group's Oct. 7 incursion into southern Israel that killed about 1,200 people.

The Israel-Hamas war has so far killed more than 20,900 people in Gaza, twothirds of them women and children, according to the Health Ministry in Hamas-run Gaza, which doesn't differentiate between civilians and combatants among the dead.

After U.S. pressure, Israel allowed a trickle of aid in through Egypt, but UN agencies say that for weeks, only 10% of food needs has been entering Gaza. Last week, Israel opened the Kerem Shalom

crossing into Gaza and truck traffic increased but an Israeli strike on Thursday morning on the Palestinian side of the crossing stopped aid pickups, the UN agency for Palestinian refugees, or UNRWA, said.

Kaag has for years worked in the Middle East, including in the Palestinian territories. She started working for the United Nations in 1994 in Sudan and has worked for UNRWA and as regional director for the Mideast for the U.N. children's agency UNICEF.

She also served as assistant director of the UN Development Program, headed the UN mission to destroy Syria's chemical weapons, and was UN special envoy for Lebanon until October 2017.

Cow fattening farm in Chalinze lauds TADB's financial support

CANBE Farming limited, a localbased cow fattening farm has hailed the Tanzania Agriculture Development Bank (TADB) for supporting them with a 1.5bn/- loan which has greatly helped improve infrastructure and operations at the area.

Located in Chalinze, Coast Region, the 1000-acre farm at Mazizi village has been engaging with animals rearing specifically fattening cows to bring value.

Speaking to editors who visited the farm recently, Ephantus Mwangi, the farm's manager said that the bank has been of great support for its development as well as the surrounding Maasai community who have also benefited from the loan.

"We have conducted major improvements of our livestock keeping infrastructure as well as a pasture farm, we have been fattening cows to reach 150kgs thus adding value and income, this is a big step from the previous ones when we were rearing livestock traditionally who are reaching 70kgs," he said.

According to him, they are also slaughtering 10 cows compared to five which they were slaughtering in the previous period which is a great step in reaching more in the market.

"We were not getting any income when we started this project, operations costs were too high which included purchasing pastures for the animals, but now things are going well as we have our own pasture growing farm which are important for fattening the cows," he asserted.

TADB business officer, Kezilahabi Jumanne said in different phases since 2020, the bank has been supporting farmers in the Canbe cattle fattening farm with loans in order to increase quality of the product and incomes.

According to him, initially, the bank issued a 320m/- loan for the improvement of the farm's infrastructure and a 810m/- loan to eight Maasai people for the procurement of cattle to small-scale pastoralists.

"In this farm, Maasai communities have entered into agreement with the farm owner for the fattening of cattle and later for slaughtering before transporting the meat to the market in Dar es Salaam," Jumanne explained.

The officer also said that the bank has provided 650m/- in loan to help reduce operations costs in procurement of pastures.

He said that the bank will continue improving and expanding services to reach farmers in various parts of the country.

Worldveg introduces rootstock lines to assist tomato farmers

IN EFFORTS to improve performance of the tomato sub-sector, the World Vegetable Centre (Worldveg) has developed and screened eggplant and tomato rootstock lines for resistance reaction for Tanzanian ralstonia solanacearum strains in screen house.

It has been unveiled that, in Tanzania, between 40 to 100 per cent of tomato yield loss is due to bacterial wilt disease, primarily caused by ralstonia solanacearum species complex, and an important disease of solanaceous crops such as tomatoes, peppers, eggplants, potatoes, nightshade and watermelon.

The helpful development, among others focuses to empower the tomato growers to overcome negative effects of the sector's prone diseases that have been often thwarting the farmers to yield bumper.

Bacterial wilt is a bacterium that causes wilting and death of solanaceous plants like potato and tomato.

According to Dr Judith Hubert, a plant pathologist at the Arusha-based veggie centre, to start with, the helpful rootstock lines have been introduced in Zanzibar through the Accelerated Innovations Delivery Initiative (AIDI) Zanzibar CIMMYT project.

"The robust project, AIDI which commenced in March 2023 has so far managed to introduce and upscalling grafting technology transfer and distribution of resistant rootstocks to at least 80 farmers in Unguja and Pemba," she explained.

Dr Hubert added that implementing of the crucial project in the archipelago of Zanzibar was part to ensure for an alternative to harmful pesticides, whereby planting resistant rootstocks are effective and environmentallyfriendly management strategies.

"Through execution of the initiative, majority of famers in Zanzibar are currently managing to grow tomato successful, as well as many vegetables with better management and improved yields," she said.

Due to the so far attained successes, Dr Hubert unveiled that plans are afoot to extend the project into several regions of Tanzania mainland in order to support the tomato farmers, come

Dispensing under the key theme of 'Sowing Seeds, Meeting Seeds' Worldveg which recently celebrated 50 years anniversary of it excelling performance launched its mission in 1992 in Arusha, Northern Tanzania and today the centre has professional research and development staff working across Africa on important vegetable crops such as tomato, pepper, onion and cabbage, as well as a range of African traditional vegetables, and partners with more than 40 national institutions and many international organizations.

The Centre operates three regional bases in Africa: in Tanzania for Eastern and Southern Africa, in Mali for West and Central Africa - Dry Regions (established 2014), and in Benin for West and Central Africa - coastal and humid regions (2017). There is a liaison office in Cameroon to reach into sub-Saharan Africa with improved vegetable varieties and production technologies.

She said reports from the office of the chief statistician of the government–Zanzibar shows that 199 incidents of child abuse were reported in October this year. She said that, of the number, 78.9 percent were children and 16.2 percent women.

The PS insisted that parents should not get tired of talking to their children since it is their responsibility.

She however called upon participants of the seminar to properly use the gained entrepreneurship skills to improve their businesses. She said the government in Zanzibar has been issuing loans to small scale entrepreneurs for purposes of empowering them economically.

Tanzania, Russia coffee, cashew nut stakeholders set to double production

TANZANIA and Russia have agreed to double production of cashew nuts and coffee in order to benefit from the exportation of the two products.

In a statement, Russian Embassy in Tanzania said that the agreement was a result of a joint meeting between the Tanzania cashew nuts and coffee stakeholders and their counterpart from Russia that was held at Russian Cultural Centre in Dar es Salaam.

The aim of the meeting was to discuss how the two parties could cooperate and benefit from the cashew and coffee exportation.

Among the participants in the meeting were from Tanzania Trade Development Authority (TanTrade), Tanzania Investment Centre (TIC),Coffee and Cashew Board, Private Sector and Russia was represented by the largest Russian confectionery holding, "United confectioners."

It further said that the visit of the delegation of the "United confectioners" to Tanzania was a follow-up to the round-table virtual meetings between Russian and Tanzanian private entities that was businessmen. organized as an initiative of the of the Tanzanian Coffee Board and areas that investors could invest over \$200 million.

As Tanzania lacks cashew processing facilities and 95 percent of domestically produced cashew nuts are exported as raw materials, the destinations for its cashew nuts exports are mainly India and Vietnam with their developed cashew processing industry.

Ivory Coast will deliver 50 million liters of fuel monthly to Guinea

ABIDJAN

IVORY Coast will deliver 50 million liters of fuel per month to Guinea, following the explosion and fire at the country's main fuel depot, Ivorian national television announced Wednesday evening.

"Côte d'Ivoire is committed to delivering 50 million liters of gasoline per month to Guinea," said a journalist from Radiotélévision Ivoirienne (RTI), without specifying the duration of this aid.

"The practical terms of the contract and the security of the convoys will be signed this Thursday," said another journalist from the channel, specifying that Guinea had a monthly need of 70 million liters of gasoline.

The Guinean Minister of the Economy, Moussa Cissé, met on Wednesday in Abidjan with the Ivorian Minister of Mines, Oil and Energy, Mamadou Sangafowa Coulibaly.

Saturday, five days after the explosion and fire in Conakry of the country's main fuel depot which left 24 dead and 454 injured, according to a new report, the Guinean government announced the resumption of gasoline distribution, in rationing it.

Twenty-five liters per vehicle and five liters per motorcycle and tricycle were authorized, with the use of cans prohibited.

The population was deprived of gasoline throughout the territory since the explosion and fire, leading to the paralysis of a large part of the economy.

Demonstrations in several localities last week sometimes turned into clashes between groups of young people demanding the return of gasoline to service stations and the security forces.

Furthermore, the Guinean government announced Wednesday that the fire at the fuel depot was "completely

extinguished", in a press release sent to AFP. In total, more than 11,000 people were directly affected by the fire.

Training women on climate resilience can reduce unpredictable food supply

organisation is training 2000 women, including young girls on what to do in the face of climate change, so that homes can be more resilient in working on the land along with immediate surroundings. While this kind of initiative may not be the formula that was missing in the latest global conference on the issue, it is in line with proposals discussed on what can be done to alleviate the situation, for instance in relation to issues of shifting to clean cooking energy. Yet the idea of spanning out methods or agro-sector techniques usable for the majority of women and likely to uplift their ability to face the climate change crisis is a relief.

Reports from the area talk of an effort to provide training to 250 women and girls in three wards, assisted by Women Fund Tanzania Trust (WFTT) to eventually reach 2000 women and girls. Officials said that WFTT provided 20m/- for the project, starting July 2023 to August 2024, where women and girls also plant trees in different areas in the island. Advocacy is being conducted with councilors and the district authorities, with a range of bylaws that need to be altered to uplift efforts to stem effects of climate change. The women will he put to training on effects of cutting down trees for charcoal and firewood, avoiding farming near water sources.

While it is helpful that women are set to participate in different workshops, share experiences with other participants and learn about climate and its impacts, one wishes to see an actual change element. Women will be avoiding to plant crops on the edge of water sources, but they need to have elementary pumps to harvest water, for instance locating plastic tanks in neighbourhoods, obtaining pumps to fill tanks, then have wheelbarrows to water plants, especially rapidly

TK E R E W E - B A S E D maturing vegetables. Asking people not to farm near water sources is not good enough as the message has been there for decades; if they can draw the water they won't have to do that as they will have the moisture they are seeking, if they have the right tools at the moment.

One can see that the big talk during the gender festival where large numbers of women joined hands with activists to deliberate on collective actions doesn't have to focus on formulating new policies or legal frameworks. Anything that is beneficial to the population simply needs friendly advice and the means to do things differently, and from the glimpses one gets from the Ukerewe project, there seems to be more of education on good environmental practices than resilience - which means farming under all climatic conditions. Project designers need to work on such gaps so that there is an actual resonance with project purposes, to actually share knowledge about proper use of water by protecting trees and avoiding river banks. Placing a buzzing pump and later fit solar panels and a well enclosed pump would change a lot of things, ushering resilience.

Perhaps one aspect of the problem is that the project has been designed by activists rather than agro-sector extension personnel working with activists on the issue. The latter have a role to enabling women to enabling women to do things differently, not just understand the need to protect water sources and then they have no water, and if they break the rules activists start another education campaign. It will not work, but if the right tools are there, changing habits will not be a big problem, as often the issue isn't exposure to water source defending but poverty. In addition, the clearer a proposal will be on what to change on the farm, the easier it is financed especially by international stakeholders. It is hence time to alter the seminars culture for results.

Low quality products flood the market, sidestepping regulators

by the Tanzania Official Seed Certification Institute (TOSCI) that an increasing number of dealers are distributing low-quality seeds, vowing to take such traders to court. Periodic inspections at dealers' and agents' stores are conducted to make sure farmers get quality certified seeds but as experience shows, functioning markets need to be part of that equation as regulators can also trade on loopholes for fast cash. Experience with distribution of subsidized fertiliser showed how coy products are placed in store as fertiliser is smuggled out.

For the regulator to call upon seed dealers and agents to adhere to the set regulations and seed standards is one thing, and the capacity of buyers to differentiate between them is another aspect. One problem is protectionism where a local seed producer or a few of them, are given the monopoly of the local market, so foreign seeds will be taxed and thus come in as contraband or as ordinary produce like beans or maize, etc. They can be repackaged and sold as seeds, and it all depends on who is the producer, as certification can be imitated as with a spirits factory in Namanga that had all the revenue stamps and standards appendages, all of it cleverly crafted.

It is possible that ardent inspectors can find out about all these fake seeds and throw them out, but only if there are no efforts to protect local seeds which aren't different from the smuggled ones. In addition any deliberate protection is a situation where one decides to privilege a specific producer as a matter of policy; that same person can be induced by pecuniary considerations to create competition for the one who was favoured in a bureaucratic act. What the bureaucrat can't do is to decide which seeds will be purchased if the competition is free and farmers

N alert has been raised see or tell one another which seeds are the best. There is a huge lobby against multinationals seeking to dominate local markets, putting indigenous seeds on the road to extinction, and thus be One may for instance raise the

question as to the difference between indigenous seeds and fake seeds, for the simple reason that fake seeds are likely to be indigenous seeds repackaged as certified seeds. And since there is no well-known brand, or two, that dominate the market, selling certified seeds becomes an uncertain business, and at times a free market of fake seeds, as most protected seeds aren't good enough if they need protection to survive. In other words the very existence of a certification body instead of a patent office is a problem as what it certifies is at best acceptable and not the best, easily because best brands have a tag, need no re-certification.

Asking seed agents and dealers to respect the set regulations by distributing quality seeds for increased productivity in the agriculture sector is one thing, and for farmers to actually find out which seeds they buy in openmarkets are the best takes time. The clincher in the matter is thus whether they can tell which is which or just go for the pricing, a problem that arises from the lack of dominant brands, since local seeds, being altered each passing day, and smuggled seeds, all of them having no distinctive marks or recognised quality, mingle freely in the

Certification is valid for inspection but the farmer only notices the difference after using a type of seed, and if it was a situation where major brands are available, he would ditch imitators. In that case regulation and reliance on certification is an aspect of market inefficiency and it thus can't be its own cure. Farmers - and regulators will simply have to live with the reality.

WFP helps families in Somalia as floods hit food and drive hunger before Abdi. "It helped us. It came at the

S climate change takes a heavy toll in the country, and government authorities work anticipate and mitigate the effects of weather extremes

"I was forced to move by the flash floods. In the middle of the night, water started to pour through the village," says Bashir Abdi. It's been one week since he, his wife and nine children fled to the Iftin camp for displaced people, outside the town of Beletweyne in central Somalia.

"[But] the warning messages were good," he adds of assistance he received from the World Food Programme (WFP). "We were told everything: what to do, where to go, and to collect important household items. And the cash vouchers helped."

Abdi is one of 700,000 people driven from their homes by deadly floods sweeping southern and central Somalia, made worse by El Niño weather patterns. He and his family evacuated to the higher ground of Iftin from nearby Wadi Shabelle, now a ghost town of empty tents mired in stagnant water and stinking mud.

The floods feel like a cruel joke, coming just months after the longest drought in Somalia's recorded history. The drought pushed the country to the brink of famine, barely averted through a massive humanitarian scale-up. Now torrential rains and rising waters, which

have lashed much of East Africa, have too long." robbed vulnerable communities of any chance to recover.

But WFP and government authorities equipped Abdi and his family, along with many others, with the funds and knowledge to prepare for the floods before they hit. The family counts among tens of thousands of Somalis reached with our first anticipatory action programme against floods in Africa. The programme, to anticipate and mitigate the fallout of weather extremes, was recently launched in coordination with the Somali Disaster Management Agency.

"The most vulnerable people in Somalia have been hit once again by climate change," says Laura Turner, WFP Somalia Deputy Country Director. "We need to provide communities with the tools and knowledge to weather these extremes to break the crisis-driven cycle of hunger that has afflicted Somalia for

As soon as rainfall forecasts passed key thresholds, WFP sent pre-emptive cash transfers to over 200,000 people in anticipated flood zones along the Juba and Shabelle rivers. The money enabled them to pay for their evacuation or buy vital supplies once they had moved.

WFP also used local radio, loudspeakers and cell phone voice messages to warn hundreds of thousands more people about the coming deluge and to guide them in their planning.

These initiatives can mean fewer people needing urgent humanitarian assistance when disaster does strike. For many of those in Iftin, it has come just in

"I heard the radio messages, and I received US\$70...I bought rice, spaghetti and oil," says 80-year-old Madina Odawye, who moved to the camp with her three grandchildren just a few days right time."

Today, Iftin bustles with activity. Other flood evacuees are taking advantage of a brief lull in the rains to build temporary shelters from whatever they can find: tree branches, old fabric, corrugated iron. But, overhead, the sky is already darkening again. The rains are coming back and the waters are rising day by

A few days from now, much of Beletweyne town itself will be flooded. The roads are already full of families fleeing in trucks and donkey carts, piled high with furniture and often with children perched on top. The people in Iftin can only hope their new homes will stay safely above water.

This devastating cycle of drought and flood is tragically recurrent in Somalia. Climate change is making things even worse - the seasonal droughts and floods are growing more extreme, driving some of the worst hunger levels in over a decade. Over 4 million people, a quarter of the population, face acute hunger by the end of 2023.

"This is the fourth time we suffered from floods, and the fourth time we came here," says Abdi. "But we were not expecting these kinds of flash floods...we were not aware that our valley would flood so quickly [this time]."

"The price of food is increasing, and there is less available," he adds. "And with these floods, everybody is frustrated. There are fewer opportunities to work."

An obituary of Professor Teddy Maliyamkono

"Death. The undiscovere'd country, from whose bourn No traveler returns," William Shakespeare, Hamlet

'n the immediate aftermath of celebrations we have all had of Christmas and other religious rites during this end of the year holiday season of 2023, and especially if you happen to hail or related to person who hails from Kagera Region in northwestern Tanzania, please spare a moment to read this obituary of Professor Teddy Maliyamkono. As a human being, he had his faults but he certainly left an indelible mark on the educational history of Tanzania in general and that of the Kagera Region in particular. He left us on Sunday the 15th of November, 2023, traveling to what William Shakespeare called "the undiscovered country, from whose bourn no traveler returns."

Please join me in mourning a great academic icon and in saying farewell to a sharp witted University of Dar es Salaam don who hailed from Bugabo ward in Bukoba Rural District in Kagera Region. The author of this obituary hails from a village, Bumai, near the village, Katare, which shaped the preschool worldview of this Professor who was, at least in Bugabo ward, a legend in his own lifetime. One aspect of scholarly life that distinguished him from many others of his kind was his unwillingness to shy away from thought-provoking controversy. Yes, he could be described as an establishment academic but one who was nevertheless a trailblazer. Professor Teddy Maliyamkono was a pioneer academic entrepreneur who knew how to raise funds as an accomplished bourgeois economist would; but he was also an academic who was good at independently crafting research projects that had an educational value to his country and continent. He certainly was no stooge of the establishment that he served so well!

He was truly a world class educational economist; albeit of a bourgeois kind who consciously kept at arm's length what some may characterize as leftleaning committed scholarship that was associated with the University of Dar es Salaam in the 1970s, 1980s, and 1990s. All the same, Professor Teddy Maliyamkono contributed immensely in the production and distribution of knowledge that had a distinct and unique homegrown Tanzanian flavor.

The most significant research project he participated fully in crafting and that will for a long time symbolize his life and work on earth is the Eastern and Southern Africa Universities Research Project (ESAURP). He was its undisputed founding Managing Director. From the ESAURP office building that continues to dominate the Mlalakuwa neighborhood, close to Mlimami City, the Ardhi University and the Nyerere Campus of the University of Dar es Salaam, Professor Teddy Maliyamkono led research endeavors that saw ESAURP take the lead in securing funding and implementing numerous research projects on several disciplinary subjects with an economics of education bent, though not exclusively. The early research and publications efforts of Professor Teddy Maliyamkono did indeed concentrate on topics of an economics of education orientation. One of the major publications that resulted from this pioneering research work on the economics of education, with specific reference to the impact of overseas training in Tanzania and the Eastern and Southern Africa region, in the earlier years of these countries' independence in the 1960s, 1970s, and 1980s, was the book titled Higher Education and Development in Eastern Africa that Professor Teddy Maliyamkono co-authored with Professor Abel Ishumi, and Dr. S.J. Wells (London: Heinemann, 1982). The other major publication in this subject field was titled Training and Productivity in Eastern Africa (London: Heinemann, 1982) that Professor Teddy Maliyamkono co-authored with Dr. S.J. Wells, Dr. S.E. Migot-Adholla and Professor A. G.M.

Later on, Professor Teddy Maliyamkono's intellectual curiosity branched

out to topics relating to the political economy of Tanzania after Mwalimu Julius Kambarage Nyerere's politically earthquake-making retirement from the Presidency in 1985 (see T.L. Maliyamkono, C.G. Kahama and S.J. Wells (Editors) The Challenge for Tanzania's Economy. London: James Currey, 1986). Furthermore, Professor Teddy Maliyamkono went further and guided critical inquiry, together with a number academics from the University of Dar es Salaam and beyond, into the issue of the interface between taxation and economic development in Tanzania that resulted in the publication titled Why Pay Tax (Dar es Salaam: TEMA Publishing Company, 2009) that Professor Teddy Maliyamkono co-edited with H. Mason, A. Ndunguru, N. E. Osoro and A. Ryder. Relatedly, Professor Teddy Maliyamkono then went on to engage in the long term study of what came to be known as the informal economy in Tanzania (see T. L. Maliyamkono Transforming the Informal Sector: How to overcome the Challenges. Dar es Salaam: TEMA Publishing Company, 2012).

This intellectual curiosity in the political economy of the informal sector in Tanzania resulted in yet another one of Professor Teddy Maliyamkono's earliest research projects, also undertaken under the auspices of ESAURP, whose publication, The Second Economy in Tanzania (Nairobi: Heinemann Kenya & London: James Currey), co-authored with the late Professor Mboya S. D. Bagachwa, was his magnum opus.

Further down the line, Professor Teddy Maliyamkono was to nudge ESAURP into research that branched out further into political economy subjects such as multiparty democratic politics (see Who votes in Tanzania and Why? by T. L. Maliyamkono, Dar es Salaam: Tanzania Publishing House, 1995; and When Political Parties Clash by T. L. Maliyamkono, Fidelis Edge Kanyongolo Dar es Salaam: TEMA Publishing Company, 2003); the political Union between Tanganvika and Zanzibar (see The Political Plight of Zanzibar, edited by T. L. Maliyamkono. Dar es Salaam: Tema Publishers Company, 2000; and Muafaka: the Roots of Peace in Zanzibar. Dar es Salaam: TEMA Publishers, 2004.), and what would constitute the best political Union structure for Tanzania.

On the Union issue, Professor Teddy

Maliyamkono argued, controversially, though in line with perhaps the original wishes of Mwalimu Julius Nyerere, that a One Government Union structure will be ideal against the recommendation of the Presidential Commission on Constitutional Reform, otherwise known as the Judge Warioba Presidential Commission, that argued for a Three Government Union Structure. This position is presented in a book Professor Teddy Maliyamkono co-edited with Dr. H. Mason and Professor B. Rutinwa and published as A 100 Academics Search for Katiba Bora Tanzania (Dar es Salaam: TEMA Publishers Company, 2014).

Professor Teddy Maliyamkono also did some interesting work in collaboration with other scholars from the University of Dar es Salaam and some overseas ones, on Tanzania's return to multiparty democracy and the various styles of presidential leadership that accompanied that return. Discussion on the Third Phase Presidency of William Benjamin Mkapa (1995-2005) and the guarded optimism that informed the beginning of this Third Phase Presidency is summarized in 2 of his books: The Race for the Presidency: The First Multiparty Democracy in Tanzania (Dar es Salaam: Tema Publishers Company, 1995) and Tanzania on the Move (Dar es Salaam: TEMA Publishers Company,

Professor Teddy Maliyamkono did also research and publish works on the styles of leadership of subsequent Presidential Phases after that of William Benjamin Mkapa. Firstly, it was that of the Fourth Phase Presidency of Jakaya Mrisho Kikwete (2005-2015) that was critically assessed in the book titled The Promise (Dar es Slaam: TEMA Publishing Company, 2006) that Professor Teddy Maliyamkono co-edited with H. Mason. Secondly, it was the assessment of the Fifth Phase Presidency of John Pombe Magufuli (2015-2021) that is discussed in the book titled Viwanda: Moving Tanzania Forward that Professor Maliyamkono co-edited with Dr. H.L. Mason (Dar es Salaam: TEMA Publishing Company, 2019). Thirdly and finally, just before his sad demise, it was an optimistic review of the Sixth Phase Presidency of Samia Suluhu Hassan (2021-todate) that is discussed in the book titled The Continuity with Vision: The Roadmap to Success for President Samia Suluhu Hassan (Dar es Salaam: TEMA Publishing Company, 2022) that Professor Teddy Maliyamkono co-edited with Dr. H.L. Mason and Dr. P. Dimoso.

Going back to the Fifth Phase Presidency of John Magufuli, Professor Teddy Maliyamkono did, earlier on in 2020, publish a book, co-edited with Dr H.L. Mason that argued, controversially in my humble view, that the Government of President John Magufuli was a game changer. The book itself is titled The Game Changer: President Magufuli's First Term in Office (Dar es Salaam: TEMA Publishing Company, 2020).

By now you may be asking yourself who was this Professor Teddy Maliyamkono. Well, the good Professor was born as Thadeo Lutatina Maliyamkono, the son of two relatively small scale peasant farmers, Ta Maliyamkono, his father, and, Ma Elizabeth Tibahindurwa, the wife of Ta Maliyamkono. This was during the Second World War in March 1939, which was 17 years after the birth of the Founding Father of the Tanzania Nation, Mwalimu Iulius Nverere. Unlike Julius Nyerere, he was not a son of a so-called African native Chief who would have benefited from privileges accorded to children of such Chiefs who happened to be compliant to the British colonial order. Admittedly, he was one of those of whom it can correctly be stated that success in acquiring formal Western education was not in a linear progression of classroom based school events and whose outcome was uncertain, though when success was attained it literary lifted one from rags to riches.

The village where Professor Teddy Maliyamkono was born and raised was a farmers' village, the majority of whose residents are neither poor nor rich. The majority are subsistence farmers who grow bananas, cassava, potatoes and beans as well as perennially keep coffee trees as a cash crop that they sell raw to the district-based cooperative society to earn extra income with which to send their children to school. To send your child to school was seen as an investment in the future of the household and the child. In this regard, Professor Teddy Maliyamkono did not disappoint his parents.

He did very well at school, enrolling and completing lower primary education at Katare Primary School that was a walking distance from home in that very

village of his birth. He thereafter enrolled and completed, as a private candidate, upper primary and secondary education at various relevant schools in Bukoba Rural District before enrolling and successfully earning; at first, a Certificate in Education at Butimba, teaching for a short period at Kigarama Primary School in Kiziba (what is now called Misenyi District), and later on, earning a Diploma in Education at Changómbe, in Dar es Salaam. Thereafter, he did some teaching at secondary school level at Bwiru in Mwanza and Malangali in Iringa and back to Bwiru in Mwanza.

Subsequently, having showed erudition at all educational establishments, he secured a Canadian Development Agency scholarship to go to Canada in 1968 where he enrolled and completed his Bachelors, Masters and PhD education in quick succession at University of Alberta. After his studies in Canada, and a brief postdoctoral attachment at Stanford University in the United States of America (USA) Professor he returned to Tanzania in 1975 where he worked at the University of Dar es Salaam, with fellow educationists such as Professor Abel Ishumi and Professor Geofrey Mmari.

As observed earlier on, it was while he was teaching and doing research at the University of Dar es Salaam that he secured overseas funding for the launch of the Eastern and Southern Africa Universities Research Project that was to host most of his research endeavors. These are the research projects that resulted in the major publications discussed earlier on that established the academic legacy of Professor Teddy Maliyamkono.

Professor Teddy Maliyamkono is survived by seven children who, too, will keep his legacy alive in their own ways since they all seem to have imbibed the entrepreneurial spirit from their Professorial father. For as the American novelist and educator Claude Campbell has suggested in his famous poem:

"To live in hearts we leave behind is not to die".

Professor Teddy Maliyamkono's oldest offspring is called Mutasingwa who is 60 years of age and an entrepreneur based in Zanzibar who holds an O-Level secondary school certificate. The next oldest is Mugisha who is 58 years old and has an Advanced Diploma in Computer Science and is an entrepreneur based in Kahama, in Shinyanga Region. The next oldest is Mujuni, who is 53 years of age and has a Doctorate degree in Occupational Epidemiology as well as being a registered Pharmacist in Tanzania, currently resides in Houston, Texas in the USA. Then next, there is Linda who is 47 years old and has Associate Degrees in Childhood Education and Graphic Arts. She currently resides in California, USA, working in the real estate business.

Next, there is Kimuli who is 41 years old and has high school education who resides in the Bahari Beach area in Dar es Salaam. He is engaged in entrepreneurship. Then there is John who is 37 years of age and has an Advance Diploma in Hospitality and Tourism who resides in the Mlalakuwa area in Dar es Salaam, not far from the ESAURP building and is engaged in entrepreneurship. Lastly, there is Kerage who is a 27 year old film maker, story teller and photographer. She has a Bachelor of Arts degree in Motion Picture Medium.

As I say farewell to my elder brother, one of those few highly educated people from the place of my birth in Bukoba Rural District, that is to say Bugabo Division, and more specifically Kishanje Ward, I recall Bishop Dr. Benson Bagonza, of the Karagwe Diocese of the Christian Lutheran Church of Tanzania stating that the passing on of Professor. Teddy Maliyamkono, who worked hard to establish a University in Bukoba that started well but did not receive adequate support to continue to exist, reminds us that we who hail from Kagera Region owe it to ourselves to remember him by revisiting and reviving Professor Teddy Maliyamkono's dream.

I am consoled by the fact that the University of Dar es Salaam is at an advanced stage of establishing a constituent college of the University of Dar es Salaam in Bukoba. When this plan is fully implemented, perhaps one way of honoring this great Professor from Bugabo is by calling the Bukoba Campus of the University of Dar es Salaam the Professor Maliyam-

With a rich legacy like this; of research, publication, and outreach outputs that will continue to be discussed and academic-cumpolitical positions that will continue to raise controversy for years to come, and with seven children each one of whom is unique but equally enterprising, we all have to agree with the American novelist and educator Claude Campbell who wrote the poem that opines

"To live in hearts we leave behind is not to die".

African, Asian parliamentarians debate how peoplecentered policies aid development of women, youth

sian and African parliamentarians have committed to accelerate the implementa-⊾tion of a people-centered development agenda as the African continent continues to face rapid demographic change with several challenges, such as youth unemployment and gender inequities.

During the African and Asian Parliamentarians' Dialogue towards ICPD30 and AADPD10, which took place in October 2023 in Kigali, Rwanda, lawmakers shared measures their countries have undertaken by adopting new legislation seeking to provide opportunities for the youth while empowering women as a critical step for reaping the demographic dividend in Africa.

Official estimates show that young people between 18 years and 35 years of age make up more than 70 percent of the population in Africa, where women account for more than 50 percent of the continent's combined population.

According to Professor Kiyoko Ikegami, the Executive Director of the Japan-based Asian Population and Development Association (APDA), a basic condition for building global partnerships is to use legislation to promote transparency, accountability, and good governance for the people.

Whereas Africa is expected to account for more than 90 percent of the future increase in world population, Ikegami stresses the need to boldly implement those changes as well as respond to newly emerging needs in the population structure.

In 1994, the International Conference on Population and Development (ICPD), held in Cairo, Egypt, set a bold new vision of the relationships between population, development, and individual rights and well-being.

Its framework for action, endorsed then by 179 governments at the global level, affirmed that inclusive, sustainable development is not possible without prioritizing human rights, including reproductive rights; empowering women and girls; and addressing inequalities as well as the needs, aspirations, and rights of individuals.

As stakeholders are now set to celebrate the 30th anniversary of implementing ICDP resolutions, Ikegami emphasizes the need for African and Asian nations to consolidate views on how countries should specifically carry out parliamentary activities for the global

"As the representative body of the people, lawmakers play a critical role in enacting policies that advance sustainable outcomes guiding to people-centered development progress," Ikegami

Although nearly 30 years since the landmark conference in Cairo, peoplecentered development has enabled numerous gains in different parts of Africa; experts still believe that the long-term solution to the pending population issues still requires elected representatives to be actively engaged in formulating and implementing appropriate

policies and programmes.

"Lagging regions in Africa have employed various policies and instruments to put in place the comprehensive needs of people and communities, but there are several reasons why some countries can still do better," she said.

Some participants at the African and Asian Parliamentarians' Dialogue in Kigali emphasized the need to take lessons from experience towards implementing ICDP's commitments stressing the lack of effective monitoring strategies.

Kwabena Asante-Ntiamoah, country representative in Rwanda for the United Nations Population Fund (UNFPA) pointed out that demographic change is one of the key challenges in Africa, where there is unprecedented growth of the youth population.

"This current demographic structure with a large youthful population, he observed, can be leveraged for socioeconomic transformation, with the right investments," he said.

Jeanne Henriette Mukabikino, chair of the Rwandan Parliamentarians' Network on Population and Development (RPRPD), told IPS that considering the current population growth, Africa should utilize its youthful population potential for its socio-economic progress.

Both Asante-Ntiamoah and Mukabikino are convinced that Africa's young population brings many opportunities for economic growth despite deepening inequality within and across the continent.

Apart from conflicts and climate change, such as cyclones and droughts, which continue to contribute to food insecurity in Africa, some lawmakers see hope in positive trends at a time when Africa and Asia are working together to tackle global issues of population and development.

However, some lawmakers believe that despite progress made by several African countries in addressing population and development issues, these efforts are still threatened by multifaceted challenges, backsliding on the rights and choices of women and girls, and the polarization of the sexual and reproductive health and rights agenda.

The 2022 UNFPA's State of World Population 2022 report indicates that nearly half of all pregnancies, totaling 121 million each year throughout the world, are unintended.

The report urges policymakers, community leaders, and all individuals to empower women and girls to make affirmative decisions about sex, contraception, and motherhood and to foster societies that recognize the full worth of women and girls.

Dr Celestin Fiarovana Lovanirina, member of the National Assembly of Madagascar, told IPS that with such a large population of young people, supportive policies and programs on inclusive youth development are critical more than ever.

"As legislators, we have a responsibility to make laws in a move to address such kind of issue that is presently affecting our population," he said.

During the three-day parliamentary dialogue, which featured multiple sessions covering topics such as the ICPD30 review process and Addis Ababa Declaration on Population and Development (AADPD10), some participants shared experiences of their countries where for example, adopting a new law on minimum legal age of marriage for girls has been critical to harnessing the demographic

Latest estimates by the United Nations Population Fund (UNFPA) show that in many parts of Africa, women and girls are still vulnerable to a disproportionate range of risks, particularly to their sexual and reproductive health.

The UN agency's report shows that in most cases, girls are subject to child marriage, female genital mutilation, and limited education and are denied equal opportunities.

Experts point out that with more people in the labor force and fewer children to support, a country has a window of opportunity for rapid economic growth if the right social and economic investments and policies are made in health, education, governance, and the economy.

Madina Ndangiza, a member of the Rwandan parliament, shared her experience in adopting new laws to ensure that girls and boys enjoy the dignity and human rights to expand their capabilities.

"We believe that education is a corner-

stone to protecting girls from child marriage ... at 21 young girls are supposed to have graduated from university and are healthier to make their choice and participate more in the formal labor," Ndangiza told delegates.

On the sidelines of the parliamentary dialogue, some lawmakers agreed that the lack of an implementation plan of policy has been a hindrance to many countries needed to capture demographic dividends.

However, Ikegami pointed out that beyond the current situation, most African and Asian countries are also experiencing a demographic transition which they should use to their advantage.

"This dialogue serves as a platform of exchanges between African and Asian lawmakers to assess how their framework legislation should create an enabling environment for decision-making, to harness the growing population to accelerate the achievement of development aspirations," she said.

While the aging population is the most emerging issue in Asia, Ikegami points out that youth unemployment is an issue that might be a concern for Africa.

"Context and realities are different at each continent and country's levels, but we are trying to create opportunities for lawmakers to learn from each other," she

Education the key to realise shared Sino-African goals

FRICA is a land of immense beauty and promise, and China is a rising nation with huge potential in different fields. But despite being different in many ways, culturally, politically and socially, the two sides share the same aspirations for development and the wellbeing and prosperity of their people.

Education, the linchpin of sustainable development, plays a key role in Sino-African cooperation. Education facilitates exchanges of ideas, spreads knowledge and fosters skills. It serves as a driver for equitable, quality and inclusive education, and a catalyst for achieving sustainable development goals. And deeper cooperation between Africa and China in education will help advance economic growth, enhance social cohesion and strengthen nation-building.

There have been a variety of education exchanges and cooperation activities between Africa and China since the 1950s. Many students from Africa have come to China for higher studies thanks to the scholarships offered by the Chinese government and higher education institutions, and more have learned (and are learning) the Chinese language and history at Confucius Institutes, in order to brighten their career prospects in China.

On the other hand, the Luban Workshop, since its establishment as the first of its kind platform in Diibouti in 2019, has been offering a range of skill development programs, combining academic education and vocational training, to promote youth employment and improve the quality of life of the African peo-

Recent years have seen increasing Sino-African institutionalized cooperation arrangements, including inter-university networks. For instance, the China-Africa Universities

20+20 Cooperation Plan in 2010, which links 20 African universities with 20 Chinese universities, has been scaled up to "China-Africa 100 Universities Cooperation Pro-

Moreover, ways to deepen Africa-China education cooperation is being discussed even at high-level

meetings such as the Forum on China-Africa Cooperation's ministerial conference and multilateral platforms such as BRICS and the ning economic and social develop-Belt and Road Forum for International Cooperation.

In August 2023, the Plan for China-Africa Cooperation on Talent year, and 10,000 technical person-Development was launched at the nel with both Chinese language

BRICS Summit in Johannesburg, South Africa. Asserting that talent is the primary resource underpinment, the plan aims to train 500 principals and high-calibre teachers of vocational colleges every

and vocational skills for Africa, as well as invite 20,000 government officials and technicians from African countries to participate in workshops and seminars.

As a result, a Sino-African education cooperation architecture has taken shape. Yet it will take time to have an impact on people in such

a large and diverse continent as Africa and country as China. To be sure, the challenges Africa and China face in developing education are different. While it is more about quality education in China, it is about universalizing education at the primary and secondary level in Africa, partly due to a shortage of teachers.

Nonetheless, there is more common ground between the two sides: both aim to provide inclusive, equitable and quality education, and shift from the examination-oriented education to competency-based education. And both recognize technology as a catalyst for educational development for digital empowerment.

What binds Africa and China together are developmental needs and their shared future. China's education policy and approach to education development over the past decades could inspire African countries to reform their policies, and synergize their measures with China and other relevant stakeholders to produce better and more

The potential for boosting Sino-African cooperation is huge. But for that, it is necessary to scale up exchanges of students and academicians through not only government scholarships but also other types of scholarships including those offered by local administrations, higher education institutions, and industries and businesses.

There is also a need for the two sides to use digital technologies to expand virtual mobility as well as exchange and cooperation in science and technology in universities and beyond, scale up exchanges and deepen cooperation in skill development, particularly through government-industry-academia cooperation to boost the employability of youths and fuel economic development.

This will not only enhance South-South learning and capacity building, but also bring about positive changes by creating more and better education and employment opportunities for youths in both China and Africa.

Central Africa blames fuel shortage on supply disruptions, smuggling

ENTRAL Africa has, for months, been plagued with acute fuel shortages that have stifled regional economic growth, disrupted local businesses, and contributed to rising food prices and social unrest. The shortages are partly blamed on increased demand coupled with disruptions in supply, and on illegal trade in conflict zones.

Officials in several central African states say vehicle owners, truck drivers and motorcyclists in major cities wait for several hours, sometimes days, to fill their tanks as pumps have been regularly running dry since fuel shortages started several months ago.

Cameroonian officials partly blame ongoing disruptions to stormy weather off the Atlantic coast, stranding cargo ships at the regional hub port of Lome, Togo.

The landlocked Central African Republic, which receives fuel sup-

plies through Cameroon's Douala seaport, also reports disruptions. Aid agencies in the country, which has been hit by sectarian violence, say if nothing is done to stop the fuel crisis, delivery of needed humanitarian aid will be affected.

A severe fuel crisis is also stirring social unrest in Chad. Officials there report protests in the capital, N'djamena, and in towns including Bongor, Moundou, Faya-Largeau and Abeche, where the military this week said it dispersed protesters with tear gas.

Chad's military government said this week that its troops seized hundreds of containers of fuel illegally transported to the border with Sudan. Chad says contraband fuel trade increased on its border with Sudan since ferocious fighting broke out in Sudan's civil war in April.

Amina Ehemir Torna, director General of Chad's Downstream Sector Regularization Authority, which is responsible for the regulation, control and monitoring of standards of petroleum operations there, said merchants should immediately stop illegal exports to neighboring countries that are also facing severe fuel shortages. Torna said gasoline and diesel fuel are highly combustible and should not be stored in jerry cans and buckets at home with the hope of selling to illegal vendors at exorbitant rates should the ongoing fuel shortage persist.

Sudan's fighting shut down businesses and forced civilians and fuel merchants to flee the north eastern African state. Chadian officials say Sudanese civilians who brave the fighting, as well as troops of Sudan's national army and a rival national paramilitary force, rush to Chad's porous 1,400-kilometer border for fuel regularly.

Salisu Yunissa, president of Chad's Consumers Union in Adré, a town in Ouaddai province that is home to about 210,000 Sudanese refugees, said the shortage has plunged host communities and refugees into deeper poverty and is causing unprecedented increases in the prices of rice, onions, corn, millet and sorghum. He said a 30-kilogram bag of onions that sold at \$40 had tripled in price to about \$120 within the past two months.

Yunissa said the price hikes, environmental disasters, and armed conflicts make living very difficult for a majority of civilians who are not sure of a meal each day.

There is some hope the situation will change soon in the region. Chad, Cameroon and the CAR this month regulated fuel sales to 20 liters per motorist with the aim of stabilizing supply and demand. Chad says its shortage will improve when a refinery in N'Djamena that closed in April for maintenance reopens, although it did not say when that would happen.

Cameroon says besides the liberalization of petroleum products imports, it is importing what it calls enough quantities to meet the country's increasing demand for fuel.

'Mentorship key to building Africa's research capacity

MENTORING the next generation of scientists helps improve the depth of knowledge, but is difficult and requires patience, says Stephen Syampungani, a chair of an African research initiative dedicated to antiapartheid icon Oliver Tam-

The O.R. Tambo Africa Research Chairs Initiative (OR-TARCHI) works to support research for socio-economic development across the continent.

It aims to revolutionize education, promote science, and bolster knowledge. The initiative, implemented by South Africa's National Research Foundation (NRF), pays homage to Oliver Tambo's legacy and his belief in the transformative power of education and research for Africa's development.

There are ten chairs who lead multidisciplinary research teams, contribute to knowledge production aligned with Africa's development goals and train the next generation of research-

"Mentoring young researchers call for a lot of patience for several reasons. For instance, differences in expectations among the young mind... make it difficult for them to appreciate the mentorship program," said Stephen Syampungani, ORTARCHI chair and environment and development researcher from Zambia

Syampungani, an environment and development researcher from Zambia, underscored the difficulties in mentoring young researchers, emphasizing differences in expectations and capacity variations among mentees.

He said balancing project performance indicators with the aspirations of young minds adds an additional layer of complexity for mentors.

"Mentoring young re-

searchers' calls for a lot of patience for several reasons. For instance, differences in expectations among the young mind... make it difficult for them to appreciate the mentorship program," Syampungani said, offering a glimpse into the complexities of the mentoring dynamic.

Syampungani said that mentorship, through student supervision, teaching, and the coordination of other researchers' work, helps improve the depth of knowledge and quality of life of the next generation of highly skilled people.

He also encouraged aspiring researchers to be patient, emphasizing that research requires a willingness to learn and perseverance.

He adds that the OR-TARChI initiative is strategic and has enhanced research collaborations and innovation capacities among universities both within and outside the continent.

Syampungani sized the strategic importance of the ORTARCHI initiative, collaborating with organizations such as the Science Granting Councils Initiative (SGCI), African Research Universities Alliance (ARUA), Strengthening Higher Agricultural Education in Africa (SHAEA) initiative, and the Alliance for Accelerating Excellence in Science in Africa (AESA).

These collaborations, Syampungani says, contribute to ORTARChI's mission, focusing on institutional capacity strengthening, high-end skill development, recruitment and retention of excellent researchers, and incentivizing research for socio-economic and transformative development.

Each chair of ORTARChi focuses on a critical development challenge identified by the host institution. The chairs are expected to produce high-quality research, train postgraduate students, and build partnerships with African and international institutions.

The interventions are geared towards institutional capacity strengthening; development of high-end skills; recruitment and retention of excellent researchers; and incentives to support research that contributes to socioeconomic and transformative development.

From bureaucratic labyrinths to accessible civil registration

BANGKOK, Thailand

ive you ever tried to register a birth, a death or maybe vour own marriage? Unfortunately, many of these vital events in Asia and the Pacific remain unregistered often with dire consequences for individuals, families and communities

Civil registration can be a labyrinth to navigate, comprising of multiple stages with many bureaucratic hurdles. Such complex systems discourage individuals from either commencing or completing the arduous registration process.

But what if the process of registering a birth or death could be made less stressful for a new parent or a grieving relative? As an implementing partner of the Bloomberg Philanthropies Data for Health Initiative, ES-CAP has been working with selected countries in the region to improve their Civil Registration and Vital Statistics (CRVS) systems using the CRVS Systems Improvement Framework.

This framework provides the tools for a participatory approach to identify bottlenecks and solutions to streamline registration processes. The framework has now been used in Niue, Maldives, Nauru, Fiji, Vanuatu, Samoa, and Turkmenistan

In many cases, people are not aware of the legal timeframes for registering vital events, leading to late registration of births often at school enrol-

ment age, which often means having to pay additional late registration fees or the submission of additional documentation.

People living overseas may be unaware of the need to notify a vital event in their home country or are unable to visit a civil registration office to register the event. Lack of systems for recording overseas

vital events in many countries means that events are either not captured, or in some cases may be double counted.

So, why is registering a vital event so complex?

In many countries, notification of a birth or death occurs at a health facility,

but an individual must then register the event at a civil registration office. This multi-stage process means several trips to different offices for family members, which can be expensive and time-consuming, especially for those in remote areas.

Additionally, births or deaths occurring outside of health facilities frequently remain unregistered.

Civil registration processes are not only cumbersome for people attempting to register an event, but also for staff engaged in the process. Paperbased registration forms slow down the transfer of information between health facilities and civil registration offices and sometimes staff must (re) enter personal information by hand.

Where digital civil registration systems are used, staff often encounter obstacles in leveraging the potential benefits due to outdated ICT hardware and software, as well as limited internet connectivity. This 'system' may be something as simple as a spreadsheet or an MS Access database.

It is hardly surprising that this process is time-consuming for already understaffed facilities, often resulting in long queues at registration offices, not to mention the increased scope for errors or misplaced

forms. In many countries, replacing lost forms or changing a mistake is akin to reaching a dead end in the registration labyrinth! The lack of training and in-

consistent forms for coding causes of death in line with the International Classification of Diseases (ICD) is also an issue. This means that accurate statistics on causes of death cannot be utilized by government agencies for future planning. Additionally, in many countries, the sharing of data may not be possible among government agencies due to regulations or the absence of integrated digital data systems. This means important data is not utilized to its full potential.

These facilitate immediate improvements that require minimal investment (e.g.

amending a field on a registration form) to minimize the burden on families and combat the lack of awareness about the importance of registering vital events. 'Quick win' solutions may be used as an advocacy tool for increasing future resources for CRVS system improvements.

Examples of longer-term sustainable solutions have included the development of online registration forms, appointment booking systems, SMS mobile messaging communications and development of standard operating procedures for civil registry staff.



HIGH COST OF CONSTRUCTION PUTS AFFORDABLE HOMES OUT OF REACH

NAIROBI

he average cost of home loans under the State-backed affordable housing programme has this year jumped by a third, or nearly Sh1 million, on the back of climbing cost of construction.

Analysis of data shows the average size of mortgage increased 32.65 percent in 12 months through September to Sh3.96 million compared to Sh2.98 million in a similar period in the prior year and Sh2.36 million in 2021.

The Sh0.97 million increment in one year, according to data from the Kenya Mortgage Refinance Company (KMRC), came in a period of elevated inflation amid a depreciating shilling pressured the cost of building

Key construction materials such as steel, paint and cement have been hit by price growth at a time the shilling has been losing value against major international currencies, sliding about 25.7 percent against the US dollar between January and December 22.

The Architectural Association of Kenya wrote in the latest report that the cost of building per square metre ranged from Sh41,600 to Sh100,800 towards the end of the year from between

Sh34,650 and to Sh77,500 at the start of the year.

This points to a growth of between 20 and 30 percent, going by the numbers in the lobby's State of the Built Environment report.

"The construction industry in Kenya has witnessed a notable surge in material costs over the past year, significantly impacting project budgets and timelines. Various economic factors, including currency devaluation and increased import costs, have contributed to this escalation," AAK wrote in the report.

Cost of construction has been a major impediment to building affordable housing units, and was largely blamed for hurting the State's flopped plan to erect 500,000 units in five years through 2022 under the previous regime of retired President Uhuru Kenyatta.

His successor William Ruto, has set an ambitious target of up to 250,000 units every year.

"As government, we shall do all that is necessary including providing infrastructure, providing land to private developers so that we are able to meet the planned units at an affordable price," Housing and Urban Development Principal Secretary Charles Hinga said on December 5.

Kenya has a thin retail mortgage market, estimated at 27,786 home loans worth Sh261.8 billion in December 2022, according to latest data from the Central Bank of Kenya.

The average loan size for commercial banks increased to Sh9.4 million in 2022 from Sh9.2 million the year before, locking out lowto mid-income workers.

The mortgage refinance was formed largely to cater for workers who have been locked out of the homeownership due to high cost loans which come with a short repayment period of about 10

KMRC offers funds to participating banks and saccos at a fixed annual interest of five percent for onward lending to homebuyers – meaning the repayments are not impacted by inflation and resultant increase in interest rates.

President Ruto has made construction of affordable houses a priority in his first term in office, largely funded by a 1.5 percent housing levy which the courts in November ruled unconstitutional.

The levy is gross-on-gross taxation on workers income where the KRA uses the same gross to also calculate

the Pay As You Earn, thus a form of double taxation.

The lowest priced unit (a single-room on a 20 square metre space) will cost Sh840,000 which will require prospective homebuyers to deposit Sh84,000 and clear the remainder through monthly payments of Sh3,200 over 30 years.

A two-roomed house of 30sqm will cost Sh1.26 million with prospective owners required to deposit Sh126,000 and thereafter pay Sh4,800 monthly for 30 years, while the price for a 40sqm three-roomed unit is Sh1.68 million paid through Sh168,000 deposit and

Sh6,400 monthly payments. A bedsitter, or studio, on 20 square metres space will cost Sh960,000 with

occupiers charged Sh5,200 monthly payments for 30 years on top of Sh96,000 deposit. The cost of building went up by 2.71 percent year-on-

year in the third quarter of 2023 driven by a rise in the cost of cement, steel, fuel and other key inputs. Data from the Kenya National Bureau of Statistics (KNBS) shows the Construction Cost Index rose to 116.45

since the fourth quarter of 2022 when the index rose by 7.1 percent, the third fastest rate on record.

During the period, almost all construction material indices increased except for paints, sanitary fittings, water fittings, water waste appliances, and electrical fittings which dropped by 0.7 percent, one percent, 0.2 percent, 2 percent, and 0.8 percent.

The index of cement steel and reinforcement bars went up by 0.5 per cent and 1.6 percent, respectively, from the second quarter to the third quarter of 2023. The index of hardcore, dense bitumen macadam, metal doors, and windows all went up by 1.6 percent.

Meanwhile, the transport and fuels index, increased by three percent in the same period under review.

"The construction labour wages index increased slightly by one percent from 108.44 to 109.55 in Q3 2023. The equipment index also increased from 106.26 in Q2 to 107.08 in Q3 2023," said the KNBS.

The rapid depreciation of the Kenya shilling against the US dollar has played a pivotal role in the cost of construction inputs during the period. Kenya imports the same period last year. It most of its construction ma-

> This has slowed down the construction sector, which recorded a subdued growth of 2.6 percent in the second quarter of 2023 compared to 4.5 percent growth in the second quarter of 2022.

The rising construction costs are a blow to President William Ruto's plan to spur the construction – mostly by the private sector – of 250,000 affordable housing units per year.

Dr Ruto introduced the housing levy charged at 1.5 percent of workers' gross pay, which is then matched by their employers, to fund the affordable housing programme.

The National Housing Corporation is the lead implementer of the government's housing programme under the State Department for Housing and Urban Development and is among the developers of the low-cost

A State Department report shows that the low-cost homes will cost between Sh840,000 and Sh5.76 million and will comprise studio apartments, one, two, and three-room units.

He said China could raise its 2024 budget deficit ratio to around 3.5 percent to spur growth, expecting the government to set its 2024 quota of 3.8 trillion yuan to 4 trillion yuan in local government special bonds.

He noted that more efforts should also be made to support manufacturing development, such as offering more subsidies for enterprises' digital technology upgrades and low-carbon and green technology upgrades.

Internet centres to aid digital literacy targets

Rwanda aims to provide digital literacy to five million adult citizens, and experts in the ICT sector are advocating for the expansion of internet access centres.

These centres are available to community members and schools, to enhance basic digital literacy in using information and communication technologies.

Alex Ntare, Chief Executive Officer of the Rwanda ICT Chamber, told a local outlet that internet access centres equipped with computers are needed to ensure 60 per cent of citizens are digitally literate by 2024.

"The ratio of devices to citizens is still low and leveraging existing facilities would increase inclusion and ensure equitable digital growth," he noted.

Currently, 35.1 per cent of citizens aged 15 and above are reported to have attained basic digital literacy skills, according to the Ministry of ICT and Innovation.

The ratio is expected to be updated in the upcoming Six Integrated Household Living Condi-



tions Survey (EICV6), which has not vet been published due to the Covid-19 restrictions that prevented the conducting of EICV6.

The target to reach five million citizens is part of the National Digital Talent Policy unveiled in 2017.

The training in digital literacy has an emphasis on primary education and general citizens. Particular focus is on youth, women and people with special needs. The policy also looks at workforce upskilling to enhance digital adoption, starting with education systems at secondary and tertiary levels, as well as the national work-

This plan aims to increase digital skills and literacy across all levels of Rwandan society and increase the demand for electronic services and content.

"With the new initiative of ConnectRwanda 2.0 increasing device penetration will also accelerate the process," Ntare added.

The overarching goal of the ConnectRwanda 2.0 campaign is to narrow the digital divide by providing affordable 4G smartphones to over a million Rwandans across the country.

Emmanuel Mfitumukiza, Chairperson of Internet Society Rwanda Chapter, said internet access cen-

Enterprise WLAN market shrinked in third quarter 2023

NEW YORK

According to the International Data Corporation (IDC) Worldwide Quarterly WLAN Tracker, the enterprise segment of the global wireless local area network (WLAN) market decreased 5.2 percent year on year to \$2,5 billion in the third quarter of 2023 (Q3).

In the most recent quarter, IDC says organisations throughout the world have been taking their time to deploy the large volume of product that has been supplied in prior quarters, resulting in decreased growth rates, which is projected to continue in the future quarter.

At the same time, adoption of Wi-Fi 6E, the newest WLAN standard that increases WiFi's use to include the 6 GHz band of spectrum, increased in 3Q 2023.

WiFi 6E revenue increased 13 percent between the second and third quarters, accounting for 20.4 percent of dependent access point (AP) revenue and 9.6 percent of unit shipments. WiFi 6 accounted for the majority of the remaining dependent AP revenues (74.8 percwnt) and unit shipments (76.6 percent), with the legacy WiFi 5 standard accounting for the remainder.

In 3Q23, the consumer segment of the WLAN market fell 13.7 percent year on year. WiFi 6 accounted for 57.9 percent of market revenue, whereas WiFi 5 accounted for 32.4 percent. WiFi 6E penetration remains fledgling in the consumer category, accounting for only 6.2% of revenues.

NO CONSTRUCTION PERMITS FOR RESIDENTIAL PLOTS UNDER 300 SQUARE METERS - OFFICIAL

KIGALI

o construction permit can be issued for a residential house if it sits on a plot of land less than 300 square metres in size, an official from the Ministry of Finance and Economic Planning told a local outlet recently, while shedding light on new standard rates of fees levied on building permits under a new presidential order.

As noted, the only acceptable standard size of a residential plot of land for which a construction permit can be given is 300 square metres, and above.

Emmanuel Kubwimana, the Fiscal Decentralisation Division Manager in the Ministry of Finance and Economic Planning, said: "The fees for building permits are levied on the size of the residential house to be constructed but not on the standard size of a plot in which the house is located."

"A landowner should have a plot with at least 300 square metres but the residential house to be constructed in this plot of land can sit on a floor area with less than 100 square metres. Construction permit fees are levied on the size of the house [100 square metres] to be constructed but not the size of the whole plot of land [300 square metres]."

Kubwimana's explanation comes after misinterpretation by some in the public who assumed that a landowner with a plot on a 100 square metre piece of land can get a construction permit for a residential house. The confusion started after the publication of a new presidential order - on December 4 determining fees levied on services and certificates delivered by decentralised



A construction site.

The latter shows that the standard rates of fees levied on building permits include Rwf20, 000 for a floor area not exceeding 100 square metres, Rwf100, 000 for a floor area ranging from above 100 square metres to 200 square metres, Rwf150, 000 for a floor area ranging from above 200 square metres to 500 square metres and Rwf200, 000 for a floor area of more than 500 square metres.

These standard rates also apply to renewal of a building permit or for authorisation to change reasons based on the request for the building permit, according to

the presidential order.

The new standards rates show an increase of fees on floor areas above 100 square meters.

In the 2012 presidential order, Rwf20, 000 used to be charged for the floor area ranging from zero square metres to 100 square metres, Rwf40,000 for the floor area ranging from 100 to 500 square metres, and Rwf60,000 for the floor area above 500 square metres.

Districts have been warned against increasing fees for construction permits, which Rwanda Housing Authority (RHA) says is contrary to the law. Janvier Muhire, the building

regulations specialist at RHA told the local outlet in an interview that the warning was issued after thorough investigation in Bugesera district as a sample before inspecting other districts.

He said that according to the 2012 presidential order and 2019 infrastructure minister order, landowners or investors should pay Rwf20,000 fee for a construction permit on a plot/ Unique Parcel Identifier (UPI) whose size ranges from one to 100 square metres.

A fee of Rwf40,000 should be paid for a construction permit on a UPI whose size is between 100 and 500 square metres while Rwf60, 000 has to be paid on a UPI that exceeds 500 square

All construction permits across the country are issued through the system called Building Permit Information System Management (BPMIS) which the housing authority supervises.

However, he noted, a recent probe discovered violations of the recommended fees.

"By investigating through the system and on the field, realized that districts misinterpreted or misused the law which triggered complaints from people," he said.

He said that the districts were charging a construction permit fee per each house in a plot/UPI yet the fee should be charged on the plot irrespective of the number of structures on that

"This means, for instance, that even if a plot (UPI) of over 500 square metres can accommodate 20 houses, the developer will only have to pay Rwf60, 000 instead of paying for every house," he noted.

According to the investigation, he said, people were being asked to pay Rwf1.2 million per 20 houses in the plot.

"In just Bugesera district, the probe found that over 180 construction permits were overcharged fees contrary to the law. Some were charged Rwf80, 000, Rwf120,000 or Rwf200,000, while others paid up to Rwf920, 000. This is not acceptable unless the law is revised," he said.

'Nigeria's electricity subsidy not sustainable'

THE convener and Executive Director of PowerUp Nigeria, a Power Consumer Advocacy Group, Adetayo Adegbemle, has said that Nigeria's electricity subsidy is unsustainable as it constitutes a huge financial burden on the federal government.

In an industry overview obtained by Vanguard, he stated: "Historically, Nigerian Government has been paying electricity subsidy to the Nigeria Electricity Supply Industry (NESI). This means that there is the Cost Reflective Tariff of supplying 1kWh (kilowatt hour), and the Allowed Tariff that consumers are "allowed" to pay.

"This variance, otherwise called "subsidy" has now turned into an elephant in the chinaware shop. The subsidy is as a result of Government policy consideration on welfarism, targeted at supporting social welfare of consumers who might not be able to pay the high true cost of the service.

"Economic stability, aimed at ensuring a stable and affordable energy supply is essential for economic development, and political that further aimed at mitigating possible social unrest and create political

"The Federal Government of Nigeria, in 2020, with the introduction of Service Based Tariff (SBT) decided to phase out subsidy on electricity tariff, because of the strain it is putting on Government finances, and inefficiencies it promotes in the energy sector.

"The Minister of Finance, Budgets and National Planning under President Muhammadu Buhari, Mrs. Zainab Ahmed had said that the Federal Government had quietly removed all subsidies in the power sector with a plan to gradually end subsidies on petrol.

"This was necessitated by the fact that payment of Subsidy, both on petrol and electricity, has become an albatross on Government finances. Between 2015 and 2020, the shortfall in allowed tariff reportedly stood at about N2.4 trillion, averaging N200 billion yearly, and in 2022 alone, over N600bn has been paid in subsidies, and it has been estimated to skyrocket to at least N1trillion in 2024."

According to him, "In 2022, NERC, the Nigeria Electricity Regulatory Commission, NERC rolled out the Multi Year Tariff Order that gradually phases out subsidy so that Nigerians can start paying Cost Reflective Tariff. For instance, inthe MYTO 2022, the Cost Reflective Tariff, on the average, should be N68.42 per kilowatt hour (kWh), while the Allowed Tariff the DisCos were to charge was N59.89/kWh.

"With this, the Federal Government provided N8.53/kWh as subsidy. Between January and March 2023 alone (Q1, 2023), the total subsidy of N52.7bn was paid to the 11 Discos".

Palestinian death toll in Gaza tops 21,000, says Health Ministry

GAZA/CAIRO/PARIS

THE number of Palestinian casualties due to Israel's attacks on the Gaza Strip has now risen to 21,110 deaths and 55,243 injuries, the Gaza-based Health Ministry said on Wednesday.

Within the past 24 hours, 195 people were killed while 325 were injured and transported to hospitals due to Israeli at-

The ministry later added that an Israeli bombardment near a hospital in southern Gaza killed at least 20 people and wounded dozens more on Wednesday.

Ashraf al-Qidra, the spokesperson of the ministry, said in a statement that the death toll could rise as rescuers searched for survivors under the rubble of a residential building near Al Amal Hospital in Khan Younis, a densely-populated city in south-

Local sources told Xinhua that there were many displaced Palestinians inside the building when the attack happened, while rescuers at the site said most of the victims were retrieved in "dismembered

Al-Qidra warned against the deliberate targeting by the Israeli army of the vicinity surrounding the Nasser Medical Complex in Khan Younis, southern Gaza, urging international institutions to take effective and immediate steps to ensure the protection of the complex, its staff, the wounded, and the thousands of displaced people

Meanwhile, Israel has returned the bodies of 80 Palestinians killed in Gaza, according to Reuters reports citing the Palestinian health ministry.

Israel said it was returning the bodies after confirming that they were not Israeli hostages taken by Hamas on Oct 7.

The ministry said the bodies were buried and the authorities recorded details to help with later identification. Gaza authorities were trying to figure out when and where the men were killed and who they were.

Palestinian Prime Minister Mohammed Shtayyeh announced on Wednesday the cancellation of all New Year celebrations due to Israel's continuous military operation on the Gaza Strip.

Shtayyeh said the Palestinian government in Ramallah decided during a weekly

meeting "to cancel all New Year's Eve celian aid to the besieged enclave through borebrations, and there will be marches of anger against the occupation's crimes.'

Egypt, Jordan call for ceasefire

In Cairo, Egyptian President Abdel-Fattah al-Sisi held talks with visiting King Abdullah II of Jordan on Wednesday on the Gaza conflict, during which they reiterated the call for an immediate ceasefire in the warravaged Palestinian enclave.

During the meeting, the two state leaders agreed that the international community needs to push for an immediate ceasefire and facilitate the entry of more aid in a speedier manner to "make a real difference" in Gaza, the Egyptian presidency said in a statement.

The two leaders affirmed their complete rejection of "all attempts to liquidate the Palestinian issue, displace the Palestinians from their lands or force their internal displacement," according to the statement.

They also warned against the risks of an expanding conflict that could destabilize regional security and stability.

Egypt and Jordan have sent humanitar-

der crossings, most of which was delivered via Egypt's Rafah crossing, a lifeline to Gaza since Oct 21.

Also on Wednesday, French President Emmanuel Macron held a phone call with Israeli Prime Minister Benjamin Netanya-

Macron expressed his deep concern over the heavy civilian casualties and the intensifying humanitarian emergency in Gaza.

The French President reiterated Israel's obligation to protect civilians, the urgent need to deliver aid to the people of Gaza and the importance of working towards a lasting ceasefire by all regional and international partners, according to a statement issued by the presidential Elysee Palace.

To this end, France will be working with Jordan in the coming days to carry out humanitarian operations in Gaza, Macron said, urging Israel to take all necessary steps to stop violence committed by certain settlers against Palestinian civilians, and suspend any settlement project in the West Bank that threatens the two-state solution.

2023 witnesses more economic, political, social chaos in the US

IF asked to describe U.S. politics for the year 2023 in just one word, it would be "chaos."

Washington has witnessed an intensification of fierce confrontations between the Democratic and Republican parties, exposing a perceived dysfunction and disorder of the American democratic system. Former President Donald Trump faces criminal charges for mishandling classified documents, making him the first ex-president under criminal prosecution in U.S. history.

Current President Joe Biden's son, Hunter Biden, is dealing with accusations related to taxes and firearms, the first criminal charges against a sitting president's child. Earlier in December, House Republicans voted to formalize an impeachment inquiry into Biden, highlighting the stark partisan lines that dominate the country's political life. Rewind to January, House Republicans spent four days and 15 tries just to pick their speaker, Rep. Kevin McCarthy. He got the boot nine months later, leaving the whole place leaderless and paralyzed for three weeks while they duked it out over who should fill the spot.

"The U.S. now is confronting a very unique political situation. Not only is there a huge divide between Republicans and Democrats, but there's also a huge divide within each of the political parties between, for example, moderate Republicans and conservative Republicans," Denis Simon, a distinguished fellow at the Institute for China-America Studies, told Xinhua in a recent interview.

"So the tension is within parties, and the tension is between parties, shaping the American political situation in very negative ways. And it is having a major impact on the way people view the political system, particularly in terms of the role of government," said Simon, also former executive vice chancellor of Duke Kunshan University.

Renowned American economist Jeffrey Sachs told Xinhua that the dysfunction of U.S. political institutions has worsened due to corruption in campaign funds from the wealthy, major corporations and specific interest groups. This has made policies by Congress and the White House deviate from public interests, eroding public confidence in the gov-

A whopping 63 percent of Americans have little or no confidence in the future of the U.S. political system, according to a latest Pew Research Center poll. Congress, the Supreme Court, and the political parties aren't exactly winning any popularity contests either.

UNCERTAIN SOFT LANDING

The U.S. economy seems to have temporarily avoided the recession risks predicted by many economists, but whether a "soft landing" can be achieved remains uncertain. In 2023, the Federal Reserve, through a series of interest rate hikes and balance sheet reduction measures, has kept pushing inflation levels lower, but the index remains high above its long-term target of 2 percent.

The aggressive interest rate hikes, however, briefly caused financial turmoil in the United States, greatly affecting the world and leading to the closure of several banks in the United States and Europe. "The U.S. economy has held up rather well this year with inflation coming down, the economic recovery continuing and unemployment remaining at close to record low levels," Desmond Lachman, a senior fellow at the American Enterprise Institute and a former official at the International Monetary Fund, told Xinhua.

"However, knowing that monetary policy operates with long and variable lags and that the commercial real estate bubble has burst, the jury is still out as to whether the Fed will have succeeded in securing a soft economic landing," said Lachman.

"The continued political dysfunction in Washington that has put the public finances on an unsustainable path as underlined by an 8 percent of GDP budget deficit at a time of full employment and by a public debt that is well on its way to exceed the level recorded during the Second World War," he said.

"The regional banking crisis centered on Silicon Valley Bank and First Republic Bank early this year could be the forerunner of more financial system problems next year as a delayed response to the Fed's hawkish monetary policy stance," said Lachman.

Despite the year-on-year decline in the Consumer Price Index (CPI) from over 6 percent at the beginning of the year to around 3 percent, with prices remaining high, middle- and low-income Americans continue to bear a heavy economic burden. Recent polls show most Americans feel the U.S. economy is in tough shape and getting worse. "The domestic economy is filled with great anxiety. First of all, we have the continued problem of the income inequality gap. The rich are getting richer, and the poor therefore seem to be getting poorer," said Simon.

Regardless of income, households said they are feeling the pressure at about the same amount, according to a recent survey by Bankrate. Sixty percent of respondents in the lowest-income households, making under 50,000 U.S. dollars a year, said the economy feels like it is in a recession.

"We have outpaced the growth rates over the past year. We have surpassed all the growth that we had last year over 9 months only," The EAM is on a Russia visit Putin said, attributing the growth from December 25 to 29 as a to trade in oil, refined products, coal, and high-tech spheres.

> He highlighted the multifaceted nature of the Russia-India partnership, extending beyond energy cooperation to encompass technology and other sectors.

He also accused Erdogan of "committing genocide" against Kurds and imprisoning journalists opposing his regime.

Netanyahu further said that Israel Defense Forces (IDF) is the "most moral army" in the world and is fighting to eliminate "Hamas-ISIS" whose 'crimes against humanity' were "praised" by Erdogan.

"Erdogan, who is committing genocide against the Kurds and who holds the world record for imprisoning journalists who oppose his regime, is the last person who can preach morality to us. The IDF, which is the most moral army in the world, is fighting to eliminate the most abhorrent and brutal terrorist organization in the world, Hamas-ISIS, which has committed crimes against humanity, and which Erdogan has praised and whose leaders he hosts," Netanyahu posted on X (formerly Twitter).

This comes after Turkish President Erdogan compared Netanyahu with German dictator Adolf Hitler and said that Netanyahu's actions over Gaza are "no different" from those of Hitler, Anadolu Agency reported.

"Israel is implementing a strategy of total annihilation of a city and its people. I say very clearly and frankly that Israel is a terrorist state," he said.

India's assistance holds the boat for Sri Lanka as it battles waves of economic crisis

AS Sri Lanka's battle against economic crisis remains persistent, India's assistance to the island nation gives the country an anchorage to hold its boat under its 'neighbourhood first' policy.

The External Affairs Minister, S Jaishankar visited India twice this year. His first visit took place at the start of this year (January 2023) and his second one in October.

During his January visit, Jaishankar not only assured Sri Lanka of India's unwavering support to the island nation in its economic recovery but also invited the country's President Ranil Wickremesinghe to visit India.

Following this, the Sri Lankan President arrived here in New Delhi in July this year at the invitation of Prime Minister Narendra Modi.

During his visit, President Wickremesinghe met his Indian counterpart Droupadi Murmu and discussed various issues of mutual interest with Prime Minister Narendra Modi and other Indian dignitaries as well.

According to an MEA release, Wickremesinghe's visit was to reinforce the longstanding friendship between the two countries and explore avenues for enhanced connectivity and mutually beneficial cooperation across sectors.

Celebrating the 75 years of diplomatic relationship with each other, India and Sri Lanka also unveiled a logo earlier in

Posting the logo on his social media platform, X. Jaishankar then wrote, "India and Sri Lanka launched a logo celebrating the 75 Years of our diplomatic relationship today." "Captures our deep historical, cultural and people-topeople bonds," he had said, at the time when the logo was launched.

Time and again, the frequent visits from the leaders of both countries have proven the diplomatic ties between the two countries have always remained cordial and friendly.

India and Sri Lanka, apart from engaging on various fora, also are a good maritime neighbour to each other.

The highly advanced Indian Naval Ship 'Nireekshak' arrived at the port of Trincomalee in September this year to facilitate Mixed Gas Diving training for the Sri Lanka Navy, according to the press release from the Indian High Commission in Colombo.

Previously, in September 2019 and March 2022, the ship made two trips to Trincomalee as part of an SLN diver training mission.

The ongoing interaction between Indian Naval vessels and the Sri Lankan Navy aligns with the Government of India's 'Neighbourhood First' policy, which aims to enhance capabilities.

The foreign minister of Sri Lanka, Ali Sabry, in an interview to ANI, had stated earlier in September that his country is attempting to establish better ties with India in the areas of port shipping connectivity, tourism, electricity, and renewable energy.

Sabry further stressed that Sri Lanka has seen a big opportunity in India.

"We have seen a big opportunity here, that's the idea. I'm sure we will be able to do that and that will be better for both countries." He said that Sri Lanka wants a good region with prosperity, peace, harmony, and among all, "we want a good and prosperous neighbour." Sabry further praised India and added, "India is going that path. We want to go with them." While talking about the current situation in the country and India's assistance, Sebry highlighted that the situation is much better compared to

"Inflation has come down, the Rupee has stabilised, reserves have risen, and tourism has increased... It is India who provided us with various forms of assistance worth 3.9 billion," he added.

Moreover, he expressed his gratitude and said that India can proudly claim a ice and snow continues to rise. great part of the credit that Sri Lanka has achieved today.

Underscoring his meeting with External Affairs Minister S Jaishankar, Serby expressed his happiness to meet him and said that the two ministers had a small conversation on ways to strengthen the India-Sri Lanka relationship.

"I have invited him to visit Sri Lanka for the IORA. He promised that he would try his level best to make it and to take the country forward," he said.

Last year, India supplied over 270,000 MT of fuel to Sri Lanka so far to help ease the power crisis in the island country which was witnessing acute power cuts. Moreover, Sri Lanka also signed a USD 1 billion credit line with India for procurement of food, medicines and other essential items, amid the island nation's worsening economic crisis. The agreement was signed between the State Bank of India (SBI) and the Government of Sri Lanka, during Sri Lankan Finance Minister Basil Rajapaksha's two-day visit to India.

Meanwhile, Jaishankar, who visited Colombo for the second time in October in 2023, had bilateral meetings with the Sri Lankan leaders there.

He had said that India's commitment to the Indian Ocean Rim Association (IORA) is deeply rooted in the principles of peaceful coexistence, shared prosperity, and regional collaboration.

"For Member States to grow and prosper, development challenges must be continuously and effectively ad-

In particular, we should cooperate on various aspects of the maritime economy, resources, connectivity and security," the EAM said at the press conference of the 23rd IORA Council of Ministers Meeting in Sri Lanka.

The Indian Ocean Rim Association (IORA) is an inter-governmental organisation aimed at strengthening regional cooperation and sustainable development within the Indian Ocean region through its 23 Member States and 11 Dialogue Partners, as per the IORA website.

UK's Hunt to deliver budget on March 6 as election looms

LONDON

BRITISH finance minister Jeremy Hunt will present the spring budget on March 6, in what is likely to be the government's last major chance to prepare the ground for an election that must be held by January

Prime Minister Rishi Sunak's Conservatives are heavily trailing the main opposition Labour Party in the polls, but the country's weak economy and budget deficit mean Sunak and Hunt have little room for pre-election giveaways.

Many Conservative lawmakers have called for fresh tax cuts in the run-up to the election to help win back voters, many of whom are indicating they want change after 13 years of Conservative government.

According to the latest opinion poll by Ipsos in December, support for the Conservatives stood at 24 percent, far behind the opposition Labour Party's 41 percent.

Xinjiang fosters new advantages of ice-snow industry

LEVERAGING its abundant ice-and-snow resources, Xinjiang Uygur autonomous region in northwest China has developed new business forms and products, and fostered new advantages of its ice-snow industry in recent years. More and more people are attracted to experience the charm of the ice and snow leisure tourism.

At the Jiangjun Mountain ski resort in Altay, Xinjiang, Huang Jianzhong and his family from Shenzhen, south China's Guangdong province, put on skiing equipment and got ready to go on the slopes with their coach.

"In previous winters, we came here for only sightseeing. This year we specifically hired a coach to teach my children how to ski," Huang told People's Daily. Nowadays, more and more tourists, like Huang and his family, would visit Xinjiang to experience the joy of winter sports.

Lyu Yaoping, a coach from a skiing training center at the Jiangjun Mountain ski resort, told People's Daily that the training center had only about 50 coaches when she joined it four years ago, and the number today has exceeded 180.

Besides, the number of relevant venues has also increased year by year. Today, Xinjiang is home to 101 ski resorts, 27 indoor ice rinks and 60 ice-snow amusement

In addition to winter sports, Xinjiang fully utilizes its resources such as scenic spots, parks, ice and snow venues, and themed towns to host events such as ice and snow photography exhibitions, ice sculpture exhibitions, and snow sculpture exhibitions. The public's enthusiasm for

Chi Shaoquan, deputy governor of Fuhai county in Altay, noted that the county was preparing to host a winter fishing festival that would take place soon. So far, Fuhai county has held 16 sessions of the festival, benefiting both the aquaculture and tourism industries.

In a workshop in Altay, Kuanishbek Slanbek, a master craftsman of ancient fur skis production, was busy making his products. Altay is the birthplace of skiing, and fur skis were an important tool for winter production and daily life in ancient times. Today, the craft of fur ski-making has regained vitality thanks to winter sports.

According to Kuanishbek Slanbek, those who purchase the fur skis are mainly skiing enthusiasts. They use the skis to experience local-style skiing, and some buy the prod-

It takes about 15 days to make a pair of fur skis, which are priced at around 1,000 yuan (\$140). Since the beginning of this winter, Kuanishbek Slanbek has already made 60 pairs and still has pending orders.

"I have trained a group of young people to make fur skis. This has not only increased our income, but also ensured the inheritance of this craft," Kuanishbek Slanbek said.

county, which is over 100 kilometers away from Kuanishbek Slanbek's workshop, were also rushing to fulfill orders. The company just finished producing 5,000 pieces of ski suits lately, and now they have received a new order for 12,000 pieces

ramping up production. The company had to deliver three "magic carpets" to Kyrgyzstan in January next year.

"We mainly produce ski lifts, 'magic carpets,' snowmaking equipment, and snowboards. Our products not only meet the needs of local ski resorts but also sell to other regions," said Liao Yuan, the company's manager. According to him, the sales volume of the company has been increasing at an average of 30 percent per year.

Xinjiang enterprises have made inroads into ice and snow equipment manufacturing, covering personal equipment such as skiing suits, gloves, and snowboards, as well as specialized equipment for ski resorts like tow ropes, magic carpets, and ski lifts. This development has become an important part of the ice and snow industry in Xinjiang.

Helatibek Musai, a villager from Fuyun counTY, Altay, has been working at the international ski resort in Koktokay for five years. Every winter, he and his wife head to work early at the resort.

"There's no more leisure time now, as we are all busy making money! I'm the snowmaking supervisor and my wife is the guest room supervisor. Together, we earn over 10,000 yuan per month,"

the man told People's Daily.

In 2018, the construction of the international ski resort commenced, and the facility officially opened for business in 2020. Since then, it has received over 1 million visits.

Currently, the ski resort provides stable employ-A ski equipment company in Urumqi was also ment for more than 210 local farmers and herdsmen, with an average annual income of 32,000 yuan per person. Additionally, it has also created flexible job opportunities for over 7,000 people in the surrounding area.

> With the increasing number of tourists, more and more local specialty products in Xinjiang have found a market. For instance, a cultural and creative park in Shuixigou township, Urumqi county, has built "bubble houses" that come with heating facilities, so that tourists can get a view of the beautiful sceneries outside these transparent "bubbles" in winter. The park also provides free stalls for local villagers to sell agricultural and sideline products, as well as handicrafts.

"These camel ornaments, felt purses, and felt jewelry boxes were all handmade by female members of our cooperative. Through selling these handicrafts, each of us earns around 4,500 yuan per month," said Hatima Ened, president of a cooperative in Urumqi county.

Hatima Ened, also an inheritor of the intangible cultural heritage item of Kazakh embroidery, told People's Daily that the booming tourism at the cultural and creative park has enabled many local families to increase their income. **People's Daily**

US gives Ukraine year's final weapons package as Biden administration exhausts funding

WASHINGTON

THE U.S. State Department on Wednesday announced this year's final package of weapons and equipment to aid Ukraine, exhausting existing funding still at the Biden administration's disposal.

The arms and equipment in the package are worth up to 250 million U.S. dollars and are being provided "under previously directed drawdowns for Ukraine," Secretary of State Antony Blinken said in a statement.

"Capabilities provided in today's package include air defense munitions, other air defense system components, additional ammunition for high mobility artillery rocket systems, 155mm and 105mm artillery ammunition, anti-armor munitions, and over

15 million rounds of ammunition," Blinken said.

Assistance packages such as this just-announced one fall under the Presidential Drawdown Authority, which allows weapons to be pulled directly from the stocks of the Department of Defense so that they can be delivered to Ukraine in a swift man-

The United States has already used up funds from another form of assistance for Ukraine, the congressionally-appropriated Ukraine Security Assistance Initiative, which enables the Department of Defense to purchase weapons for Kiev by signing contracts with arms manufacturers.

In his statement, Blinken reiterated the urgent need for Congress to get their work done. "It is imperative that

Congress act swiftly, as soon as possible, to advance our national security interests by helping Ukraine defend itself and secure its future," he said.

Warning that the funding Congress previously approved for providing assistance to Ukraine would soon dry up, the Biden administration said last week that lacking lawmakers' renewed commitment to further appropriation meeting the White House's over 60-billion-dollar supplemental budget request for Ukraine, the administration would be able to announce but one additional package for Kiev before year's end.

"We are still planning one more aid package to Ukraine later this month," John Kirby, the National Security Council's Coordinator for Strategic Communications, told reporters on

"However, when that one's done ... we will have no more replenishment authority available to us, and we're going to need Congress to act without delay, as we have been saying," Kirby

On Capitol Hill, Republicans are withholding their votes for new money for Ukraine, conditioning their approval on Democrats making compromises to satisfy the GOP's demand for tighter control measures on the border to keep incoming migrants at bay.

Since the Russia-Ukraine conflict broke out in February 2022, the United States has committed more than 44.2 billion dollars in military aid to Ukraine, the Pentagon said in a fact sheet published on Wednesday.

Karia can hardly avoid criticism from Tanzania's soccer stakeholders

CCORDING to the nature of Tanzania's soccer, before getting used to it, an individual needs a lot of time to understand that the country's football has a unique way of governing it and it has some politics.

It is very difficult for an individual to find a football fan in the country who is neither Simba SC nor Yanga supporter.

There may be few soccer followers rooting for renowned Tanga teams- African Sports and Coastal Union-but research shows they are lately very few.

Most of the two clubs' fans, and those who were rooting for Cosmopolitan FC, have jumped onto Simba SC and Yanga band-

I said the fans have jumped into the two popular outfits' bandwagon because their teams have not played top-flight football for a long time.

The rest are Simba SC and Yanga fans, and this is the culture of the soccer fanbase in Tanzania.

Two years ago, Tanzania Football Federation president Wallace Karia was allegedly accused by a section of fans rooting for Young Africans, alias Yanga, that he is a Simba SC fan.

He was accused of favouring Simba SC during that period, which saw the club clinch the Premier League top honour four times in a row.

Karia and the rest of the Tanzania Football Federation leadership were accused of suppressing Yanga, which was registering average players because the outfit was struggling financially.

Yanga had players who could not take the team to the promised land, days passed, the sunset and the Simba SC domination in the league ended.

The Jangwani Street-based Yanga, which was then under the new leadership led by president Hersi Said, registered

three players from DR Congo- Djuma Shabani, Fiston Mayele, and Yannick

They joined their compatriot Tuisila Kisinda- by then playing his second season at the club.

Finally, Yanga won the Premier League trophy for two consecutive seasons and noises that alleged Karia and Tanzania Football Federation are favouring Simba SC disappeared.

After Simba SC had won the Premier League four times in a row sold its midfielders Clatous Chama and Luis Miquissoine, there was a drop in form among several players including midfielder Rally Bwalya.

Simba SC did not win a major trophy since the departure of the mentioned players, with some having returned to the club a few seasons later.

Ugandan midfielder Taddeo Lwanga, Zambian attacker Chris Mugalu, Rwandan striker Meddie Kagere, and Ivorian central defender Pascal Wawa, later on, left Simba SC, and the outfit lost steam.

Rumours thereafter circulated, claiming Karia was favouring Yanga. That is how local football operates.

Simba SC's leadership stated it was ready to relocate the club to the Zambian Super League due to the injustice the outfit was allegedly experiencing in Mainland Tanzania Premier League.

was unfair to it and, at the same time, gratifying Yanga.

A soccer fanatic needs critical analvsis to understand Tanzania's soccerfrom the sport's fans, club leaders, and how they operate.

Every team that lifts the NBC Premier League is endorsed by TFF and a couple of outfits that have lost out on the top flight's silverware blame the federation.

No club is ready to lose because of mistakes it committed throughout the season, team leaders are not ready to tell their clubs' fans the truth about their failure.

Every team seems to be bullied by TFF and points accusing fingers at the federation. When Simba SC is successful, Karia is reported to be the team's member and, when Yanga is on top, Karia is believed to be a Yanga

That is Mainland Tanzania soccer and its fandom, it is how the game operates- a culture that every individual has to understand.

Since Yanga understood how to invest in good players the club's officials and supporters no longer blame

Son leads South Korea squad 'ready' to win Asian Cup

SEOUL

TOTTENHAM Hotspur's Son Heung-min was named in South Korea's Asian Cup squad yesterday and coach Jurgen Klinsmann said it was "about time" they ended their 64-year continental title drought.

Wolves forward Hwang Hee-chan, who scored his 10th Premier League goal of the season against Brentford on Wednesday, was also among Klinsmann's 26man selection for the tournament, which kicks off in Qatar on January 12.

Son will captain a squad that includes Bayern Munich defender Kim Min-jae and 22-year-old Paris Saint-Germain attacking midfielder Lee Kang-in.

South Korea have not won the Asian Cup since 1960 and Klinsmann said: "It's all about timing now and I

think we are ready for this big, big competition. "It's 64 years -- 64 years is a long time for Korea. It's about time that we get this done."

South Korea have been drawn in Group E and will face Malaysia, Jordan and Bahrain in the first round.

They lost 1-0 to eventual champions Oatar in the quarter-finals of the 2019 Asian Cup in the United Arab

Klinsmann, a World Cup winner with Germany in 1990, will have one of the strongest squads in the tournament in Qatar and he said he could "see it in their eyes that they are hungry for it".

"I have a good feeling because they're doing well at their clubs," he said. "They're healthy, they're fit, they're ambitious and they're very hungry. This is the foundation for playing a good tournament."

Son will be appearing at his fourth Asian Cup and was part of the South Korea team that lost to hosts Australia in the 2015 final.

Hwang scored twice in Wolves' 4-1 win over Brentford to move one goal behind Son, who has 11, in the Premier League scoring charts.

Lee is also making a splash after moving to Paris from Mallorca in the summer, and Klinsmann described him as "a flower that starts to bloom".

"We have a lot of different pieces in that roster and that makes us one of the favourites for the Asian Cup," said Klinsmann. "We have to fine tune these elements over the next couple of weeks and then go into the tournament with confidence."

Klinsmann was unable to select Hwang Ui-jo, who has been suspended by South Korea because of a police investigation into allegations he illegally filmed an

Manchester City show title-winning character to find way to beat Everton

HIL Foden took it upon himself to be the matchmaker who reunited Manchester City with their swagger.

City were contemplating what seemed to be their 1,000th sideway pass of the evening, traits such as pace, imagination and aggression did not appear to be high on their list of aspirations, and their historic 2023 seemed destined for an unfulfilling domestic finale.

Foden receiv-Then ing possession on the edge of Everton's penalty area, let rip from 20 yards to leave his England teammate Jordan Pickford floundering, and 37 minutes later the champions left Goodison Park vaguely resembling their old selves.

Should they go on to win a fourth consecutive evening, Pep Guardiola will surely reflect on Foden's equaliser as a critical moment, his injury hit side overcoming adversity to secure one of those grinding wins that defines title triumphs.

Not that Guardiola was overly gushing about his young midfielder.

As his tendency, the manager's praise for Foden was caveated, referencing how he 'learned' from a less positive contribution in the draw against Crystal Palace a fortnight ago.

"There are still things he can improve to be a top class player for many years," said Guardiola.



URA FC reveals reasons for pulling out of Mapinduzi Cup

FOUR-TIME Uganda Premier League champion, URA FC, has revealed reasons for pulling out of the 2024 Mapinduzi Cup tournament slated to start yesterday and come to an end on January 13 in Zanzibar.

According to URA FC, it received an official invitation from the tournament organizers, which was also accompanied by a letter from the Tanzania Football Federation to the Federation of Uganda Football Associations.

The tax collectors affirmed their willingness to form part in the tournament, only for the tough conditions set by FUFA to force their withdrawal.

The local football custodians insisted that URA FC could only participate if they did not violate their schedule in the Uganda Premier League.

In the two weeks of the tournament, URA FC had three UPL matches scheduled, and FUFA could not allow a postponement for the sake of the Mapinduzi Cup.

"In a letter from FUFA dated December 22, after expressing readiness to travel to Zanzibar to represent the country, the approval to go and take part in the tournament was subjected to the following conditions as agreed upon by FUFA and UPL:" URA FC's statement said.

"All URA FC's SUPL fixtures must continue uninterrupted," URA FC revealed FUFA's tough condition for the outfit's

In the same period of the tournament, URA FC will play Mbarara City FC (December 28), KCCA FC (January 2) and SC

"It left us with no option apart from withdrawing in order to honour our fixtures," the club added.

The taxmen had been pooled in Group A of 2024 Mapinduzi

Cup along with Mainland Tanzania's Azam FC and Zanzibar outfits Mlandege FC and Chipukizi United.

It has since been confirmed that South Sudan's Jamus FC has taken up URA FC's spot in the annual tournament.

In 2016, the tax collectors became the second Ugandan club to win the tournament after KCCA FC had lifted the top honour in 2014, when URA FC beat Tanzania's Mtibwa Sugar 3-1 in the final.
