Samia initiates Foreign Service fellowships to revamp ministry

PRESIDENTIAL fellowships for mastering services linked with foreign countries will soon be launched to groom Tanzanian youth for international relations and economic diplomacy.

President Samia Suluhu Hassan unveiled this intention in Dar es Salaam yesterday, explaining that the programme to be set within the President's Office, will take up talented and qualified youths from various spheres.

They will be trained for two years and attached to various units once they graduate, basically to revamp operations in the Ministry of Foreign Affairs and East African Cooperation.

There is need for new input to make the ministry work efficiently in serving different spheres in the international community and excel in attracting investments, she said.

She made the remarks at the State House after receiving a report from a committee formed six months ago to review the ministry's performance, affirming that reviewing the National Foreign Policy of 2001 was in the final stages.

The purpose of the review is to help stimulate initiatives in strengthening economic diplomacy, attract investments and utilise

THE number of small holder farmers joining agro-business clusters initiated by the Southern Agricultural Growth Corridor of Tanzania (SAGCOT increased eight fold from 100,000 to 847,385 in the past decade.

Mloganzila carries out four kidney transplants

MUHIMBILI National Hospital (MNH) Mloganzila branch has conducted kidney transplants to four patients using hand assisted lapa-

roscopic nephrectomy technology, saying it is the first in East Africa.

Prof Mohamed Janabi, the MNH director general, made this observation at a ceremony to discharge the four patients who went through the transplant operations six weeks ago, on October 2.

The new technology enables patients to spend shorter times in hospital before being

Chalinze power cooling station is 84.3pc ready By Henry Mwangonde

CONSTRUCTION of the 400-KV Chalinze power cooling station has reached 84.3 percent, an affirmation delivered during an inspection tour by Dr Doto Biteko, the deputy prime minister and Energy minister yesterday.

In his remarks, the senior minister said that completion of the power station will reduce uncertainty in electricity supply, having inspected the work progress project yesterday expressing satisfaction with the construction progress.

Project managers assured the deputy premier that works will be completed by the end of the year, with Coast Region and nearby areas benefiting from the cooling station.

The station is poised to receive 2,115MW from the Julius Nyerere hydropower station from which the power is directed to

ment in information and communication technology (ICT) systems to ease operations, she said, pointing at a number of complaints from various stakeholders on the poor coordination and operations at the ministry.

"This pushed me to form this committee to look into the challenges, so today the committee has presented its recommendations to help clear the gaps," the president underlined.

Many recommendations issued by the committee will be incorporated in the National Foreign Policy so as to achieve intended goals, she said, acknowledging that it is important to form essential units in the ministry to oversee issues that are key for promoting international relations and marketing Tanzania overseas.

She said bringing people from outside and making Tanzania proud is contributing to building the economy, putting up a conducive investment and trade environment, plus strengthening peace and security are essential this effort.

The government is working to ensure that embassies get quality premises instead of working from old buildings, where the government is seeking to work with commercial banks and other sources of financing she stated.

Ambassador Yahya Simba, the committee chairman, had earlier said they spotted a number of challenges in the ministry, partly due to the poor utilisation of ICT systems.

The committee urged that the government allows procurement procedures of the respective countries to be used to get contractors, supervisors and designers of various buildings in the foreign countries instead of using Tanzania's laws.

This orientation will ease smooth project implementation, he said, also recommending setting up an independent unit within the ministry to coordinate public diplomacy, strategic communication, national branding and media monitoring.

A nation-wide committee is needed to coordinate the promotion of opportunities that will incorporate experts from public institutions and the private sector as it is the case in countries like South Africa, Malavsia and India, he said.

The Diaspora still faces a number of challenges like the absence of robust policies directed at members of the Diaspora, thus the need for a Diaspora unit in the ministry.

As members of the Diaspora contribute to the country's development, there is need to speed up the special status formula in place of dual citizenship, to scale up opportunities for Tanzanians living abroad.

The government needs to come up with guidelines for teaching Kiswahili overseas including curriculums, along with investing in online systems to widen the number of people joining such course, he added.

discharged, he said, affirming that this brings to seven patients undergoing that operation.

Prof Janabi said MNH-Mloganzila performed the surgery in collaboration with Korean top specialist Prof Park Kwan Tae with backing from the Korea Foundation for International Health Care (KOFIH) and the Africa Future Foundation.

"We are currently building internal capacity for our local staff to perform the surgeries under the mentorship of Prof Park," he said, expressing the hope that kidney transplant surgeries near future.

He cited data from the World Health Organisation (WHO) that upwards of 10 percent of the global population has chronic kidney failure at any particular moment.

At Mloganzila doctors attend to 20 or even 30 patients in clinics conducted twice a week, while 90 patients are put to dialysis services at the Mloganzila facility every day and 150 attend clinics at Muhimbili, he stated.

Major contributors of kidney failure include hypertension, diabetes, infectious diseases and excessive use of painkillers, with statistics raising alarm

cable diseases (NCDs).

Dr Kim Sun Pyo, the Korean ambassador, said it was a historic occasion for the facility with the successful kidney transplantation, hailing the success as a symbol of Tanzania-Korea relations.

"Our bilateral cooperation will continue to grow in different areas including the health sector," he declared.

Dr Antony Gyunda, nephrologist at the facility, said that patients with kidney failure benefit by transplant as it saves time compared to attending dialysis sessions.

DAR ES SALAAM regional commissioner, Albert Chalamila has issued a 14 days ultimatum to the Dar es Salaam Rapid Transit (DART) to renovate all the 70 buses to ease transport services in the city.

He gave the ultimatum yesterday in Dar es Salaam when he visited DART to see efficiency of the transportation services for residents of Dar es Salaam. His visit followed complaints from people about congestion in its stations.

Chalamila said the service provider has been paid money to run the project, hence the need to ensure better services. He said it is wrong for the agency to have a big number of buses that are not working. "After two weeks, I want to see all the 70 buses operating; we need to reduce congestion at our stations and this can only be possible

The RC noted that he is not ready to see the efforts and good intentions of President Samia Suluhu Hassan of ensuring smooth transport services to the people being hindered due to negligence of some servants who fail to fulfil their responsibilities.

He said President Samia has invested a lot of energy on improving the road infrastructure, especially BRT in the city of Dar es Salaam, with an intention of bringing development to the people.

He said improved transportation services make it easier for people to do business. He also promised to do a follow up for one week to check how the buses operate.

transmission lines to Morogoro, Dar es Salaam and Coast regions, they said.

Addressing workers at the worksite, he appealed for transparency and patriotism in project implementation, with Newton Mwakifwamba, the station manager, hailing the government for timely facilitation of the project.

He said the project was initially following the Covid-19 outbreak which delayed machine procurement, after kicking off, as building the Chalinze 400/220/33 kV power station started in 2021, with a view to be completed in 2022.

He said the step-in voltage of the project is 400kV and the step-out voltage is 33kV while upon completion, the substation will have a 250 megavolt amperes (MVA) capacity.

The power supply company, TANE-SCO says Tanzania faces a 400 megawatts supply shortage arising from pe-

riodic repairs of plants and increased energy demand, with power rationing being pursued until March next year.

The government has started working on the shortages with intent to reduce the shortfall by half within late September to early October.

Tanzania produces about 1,900 MW through hydro-power and natural gas for 64.04 percent, while solar, fuel and other means account for 3.69-percent of total generation.

The government similarly wants to direct its efforts, and new investments, into renewable energy sources to reduce dependence on hydropower, increasingly unreliable due to climate change.

Prime Minister Kassim Majaliwa said during the recent 5th Tanzania Energy Congress that the government is focused on diversifying energy sources by venturing into solar and wind energy generation using available natural resources.

livestock keeping activities are instrumental in poverty alleviation in the areas that farmers groups are linked with agri-business supply firms and service providers.

An evaluation of SAGCOT activities for 20220 focused on the clusters constituted as geographic concentrations of small owners, supply companies and other service providers, a SAGCOT write up says.

Agribusiness-focused clusters are areas of high concentration of actors (in specific locations of the country) active in production, processing, marketing, supply of inputs and services as well as supporting institutions.

They connect investments to benefit smallholders, medium to large scale farmers on the basis of economies of scale, where small farmers, mecha-

nized producers and service providers work through value chains and strategies to unlock the potential of each aspect of the strategic partnerships, it says.

At the time of the write up, there were six agribusiness-focused clusters in Rufiji, Kilombero, Ihemi, Mbarali, Ludewa and Sumbawanga areas in the SAGCOT zone.

Ihemi cluster was the first to be established, followed by the Mbarali and Kilombero clusters, with projections of being developed in a phased approach for impact and delivery of lessons rolled out to the newer clusters, it said.

Njombe regional commissioner Antony Mtaka said at the occasion that massive food crop surpluses in the Southern Highlands regions would raise grain exports to nearby African countries.

This would enhance prospects of realizing the target espoused by President Samia Hassan of Tanzania being a continental food basket by 2030, he stated.

A sharp increase in food and cash crops production in those regions is likely if stakeholders cooperate in the clusters system that SAGCOT initiated. This will help small farmers to adopt proper crop husbandry as SAGCOT has vast experience and ability to pull small farmers into conventional agricultural activities, he asserted.

The meeting was attended by agrosector public institutions and private firms in the three regions, reviewing progress in implementing resolutions adopted last year and adopting new resolutions.

The RC emphasized that Tanzania can play a big role in helping to solve Africa's grain shortages as this is now

substantive agenda of the government. He described SAGCOT as an experienced and delivering agricultural stakeholder, capable of understanding the president's agenda.

It entails raising the production of food and cash crops and registering food crop surpluses for export, he said, pointing out that President Samia was keen on increased crop production. That is why subsidised fertilizers are being distributed to farmers, he declared.

The SAGCOT executive said that current political will to increase agricultural production is supported and defended by the president herself. "She wants to see 68,000 bore holes drilled countrywide and dams created in appropriate places. This is a grand vision of the head of state," she stated, affirming that SAGCOT understand this goal and is working to realise the vision.

90pct of 1,900 wards connected with communication services, says UCSAF

THE Universal Communications Service Access Fund (UCSAF) has said 90 per cent of the 1,900 wards countrywide have been connected with communication services.

UCSAF Chief Executive Officer Justina Mashiba gave the statistics when explaining how the fund has been implementing its duties to ensure people have reliable access to communication.

Mashiba said the project to connect communication to 1,900 wards is progressing well, saying the remaining 10 percent of construction of the communication towers will be done soon.

"On the access to communication,

especially in rural areas, we signed wards countrywide, so far the task has been undertaken by almost 90 per cent and the remaining ten per cent will be completed within a short period," she said.

When the project is completed, UCSAF will have facilitated access to communication to more than to the villagers. 15-million Tanzanians who did not have the facility.

provision of reliable On communication services to residents of Msomera village in Handeni District, Tanga Region, who have relocated from Ngorongoro Conservation Area (NCA), Ms Mashiba said everything was on track to connect the village.

She said UCSAF is in close a contract for the construction of cooperation with TTCL Corporation communication towers in 1,900 who are implementing three projects of tower construction in Msomera village.

Mashiba said the construction of a TTCL tower at Msomera will offer access to other mobile phone companies to connect, thus increasing the scope of communication access

Moreover, UCSAF in collaboration with TTCL are in the final stages of the construction of a communication tower in Mkababu village where more than 5,000 houses are being constructed for the next phase of people who will relocate from Ngorongoro to the village.

"We are pleased because we are

in the final stages of completion of the construction of a TTCL tower in Mkababu village before residents of Ngorongoro shift to the areas," said the UCSAF CEO.

"I thank all communication service providers for their support to UCSAF, you have been a clear example of the cooperation between public and private sector for improved access to communication, let us keep up the team work, for universal access communication to all Tanzanians" said Mashiba.

The CEO said the fund has supported Samia Suluhu Hassan Primary School with ICT equipment, including computer, projector and printer since they have been connected with the national fibre optic cable being part of the UCSAF implementation of a project to equip public schools with information and communication technologies gadgets.

Focus studies on climate change mitigation, Jafo urges scientists

have been challenged to focus their new studies on how to help the country mitigate the impact of climate which is already ravaging vulnerable communities.

Dr Selemani Jafo, Minister of State in the Vice President's Office (Union and Environment), threw the challenge in Dar es Salaam yesterday while launching a research programme on climate change at the Commission for Science and Technology (COSTECH).

A statement released by the Vice President's Office said Tanzania has received more than 9bn/- from the government of Norway for research in the programme.

Minister Jafo said that the economy is being affected due to environmental challenges when productivity of communities decreases sharply due to extreme and unpredictable weather events, hence a need for more research on mitigation measures.

He said that in response to the challenge, researchers are expected to provide answers about which sector can help in dealing with the effects of climate change.

"In these areas, we have a big task to find out which studies, for example, which type of agriculture or crops can be planted in areas facing the effects of climate change, you researchers have a big responsibility to help us in this," he said.

He thanked all stakeholders who support the efforts of the President Samia Suluhu Hassan who is the number one environmentalist and among the panel of important people chosen to manage the world's environment.

He said that in September 2023 the Tanzanian government of Tanzania signed an agreement with the Government of Norway to strengthen development activities in the country and joint cooperation in dealing with the effects of climate change.

Mineral dealer is held over smuggling of 562m/- gold

THE Director of Nadoyo Mineral Trading Ltd, Devraj Kerai in connection with the has been arrested by the police for smuggling out of the country of 4.3 kgs of gold valued at 562m/-.

The smuggling incident happened on October 10 this year at 1:00 pm and had he succeeded to get the gold out and sell it, he could have denied the government more than 50m/- revenue. Kahama Minerals Officer, Jeremia Hango told the visiting Minerals Minister Anthony Mavunde during his one-day visit in Kahama that the mineral dealers have had such habit for a long time in various areas of the country.

said the 50m/-s of Hango government revenue include loyalty, inspection levy, service charges and VAT and that the issue was still under investigation, to know the extent of the smuggling network in order to break it

He also appealed to the Minister to legal steps to act as a lesson to others with similar activities.

Kahama District, Emmanuel Kidenya said some of the dealers have been unfaithful and have been smuggling minerals through unauthorized routes, despite the government putting in place friendly systems for buying and selling the minerals for them, and added that all those with such practices should have their licences revoked.

Kahama District Commissioner, Mboni Mhita said gold smuggling in the district was now rampant compared to neighbouring districts and added that recently at the Mwime Mineral Market in Zongomela Ward four dealers were nabbed as they were smuggling minerals, and that the war against mineral smuggling will

continue relentlessly.

Minister for Minerals, Anthony revoke the dealer's licence and take Mavunde instructed the executive secretary of the Commission of Mining to revoke Nadoyo Mineral Trading Chairman of the Mineral Market in Ltd.'s licence and that its owner, Devraj Kerai should be referred to court.

> He said during his leadership at the Ministry he will not tolerate ant dealers involving himself in smuggling of minerals, reaping money illegally thereby denying the government of its much-needed revenue.

> Mavunde further said one task he was given to do is to oversee and plug all mineral smuggling loopholes and pledged that this dealer will be a lesson to others harbouring similar intentions.

Meanwhile the Minister expressed his pleasure in seeing many Tanzania youth grabbing opportunities in mining for earning income rather than depending on the government to provide them with employment.

'WVT provided lunch to 57,000 students in three regions' schools in 2022'

MORE than 57,000 from 92 schools in Manyara, Arusha and Tanga regions were provided with meals at school last year by World Vision Tanzania (WVT) to enable them attend lessons and clamp down truancy.

This was disclosed Wednesday by WVT Disaster unit, Victor Katambala in a special interview with this paper. Katambala said they decided to provide meals to the students following a spate of hunger that prevented them from attending classes regularly.

"After being provided with meals, the students were able to listen to what they were being taught and the studies went well," he added.

He also said after food were being provided, the students were insisting on the parents for them to attend school, different to what was in the past.

Katambala said that teachers have reported that during afternoon classes, the students were good listeners to what they were being taught.

He added that the government had issued guidelines in regard to provision of meals at schools, saying that the food should contain starch, protein and fat and that they are mobilising students to grow vegetables to boost their nutrition intake.

For his part, Manyara Region Nutrition Officer, January Dalushi, told this paper that the Ministry of education launched guidelines on food and nutrition in schools.

Dalushi said the guidelines targeted all students, with many of them being those in elementary classes as most of these are under five years of age, hence thy need food to help in their growth.

According to Dalushi, the guidelines should come from the community, should be of high quality and touch on the five food groupings.

Karen Christopher, Babati resident said meals at schools is important sine many students don't dot get evening meals in sufficiency.

Angry hippo kills two people in Mpanda DC

TWO people have died after being attacked by a hippopotamus as they were hunting for food at Milala Dam in Katavi Region.

The incident happened on the night of October 10 at the dam in Mpanda municipality.

Eye witnesses said they went to the dam in the morning and found a dead hippo, but those responsible were not to be found with the exception of shoes beside the carcass.

Later people came and saw a canoe and shoes and the fire brigade appealed for cooperation from the people to look for the deceased's bodies, but it was the following day when one body was found and informed the Village Chairman.

"Yesterday two people were hunting for the hippos and one of them was wounded and got angry and tipped the boat which capsized and failed to save themselves, no down they were drowned, but we have recovered one body," said Juma Shabani, resident from the area.

According to the Shanwe Street Chairman, Mustapha Kimasa, he received a call by one of his officials regarding the killing of the beast and the death of two people.

"When I arrived at the dam, one person I found told me that during the night he heard gun shots in the water.

"He the hears people's screams calling for help but we did not respond to the screams but later he saw a hippo floating in the dam and then reported the issue," said Kimasa.

Shanwe Ward Councillor, Masumbuko Fadhil said the number of hippos has risen in the area and have been destroying farmers' crops and added that game officials called to shoot them some of the bullets ended up in people's homes, and added that this happened in more than three incidents.

Mpanda District Commissioner, Jamila Yusuf gave seven days to the Police in Mpanda to make sure they interrogate authorities overseeing the Milala Dam, including TAWA to know the legality of activities carried out there, some of which cause panic among the residents.

She also instructed the Fire Brigade and rescue Services to camp in the area to make sure all the bodies are recovered and also told the people not to blame the government due to people not carrying out their responsibilities as required.

Three out of ten children sustain road traffic injury in Tanga Region annually

AN average of 3 out of 10 children sustained mild to severe road traffic injuries in the past twelve months in Tanga Region, according to findings by an international road safety nongovernmental organization-AMEND.

Addressing delegates during the annual road safety stakeholder workshop and closure of the road safety project that lasted for four years (2019-2023) in Tanga yesterday, AMEND Country Manager, Simon Kalolo said in Tanzania, 80 to 90 percent of children walk to school, usually unaccompanied by an adult, thus becoming vulnerable to road accidents.

"Our research has consistently shown that at high-risk primary schools in urban Tanzania over 1 percent of children suffer road traffic injuries every year," said Kalolo.

Road traffic injuries kill over 1.35 million people around the world each year and are the leading cause of death globally for children, adolescents and young adults aged between 5 and 29 years. Africa has a higher RTI death rate than the global average: 26.6 per 100,000 people.

Kalolo said through their collaboration with the government in Tanga Region, they have successfully implemented the project-'safe and healthy journeys to school for children and adolescents' whereas they have improved infrastructures at schools including footpaths, a pedestrian footbridge, road signs, speed humps, rumble strips and zebra crossings.

He said they also provided road safety education to over 12,000 primary school children, facilitated training for traffic police and conducted road safety awareness campaigns through community development officers and messages through local politicians.

Tanga City Mayor, Abdulrahman Shiloow commended AMEND for implementing the road safety project saying it has helped to reduce accidents as well as broadening the understanding of people on road safety issues.

The project apart from imparting road safety education to students and residents, also improved infrastructures at primary schools, he

added. "The project has been successful implemented with establishment of kids' court at five primary schools-Usagara, Mwanzange, Martin Shamba, Mwenge and Mwakizaro," he said adding the kid's court project was purposely introduced to punish reckless drivers violating traffic rules when driving at school areas.

He said road safety education was also given to 900 motorcycle and motor vehicle drivers.

Shiloow noted that before the project there was a low level of action, coordination and commitment to tackle road safety.

"Each agency was just doing their day-to-day work. In the context of this project, it was the first time that different stakeholders and agencies were brought together sharing their views on road safety for the first time," he remarked.

AMEND works with governments, communities, development banks, foundations, private-sector companies and others to deliver safe and healthy journeys in developing countries.

It runs projects in more than fifteen countries, and with offices in Ghana, Mozambique, and Tanzania, our focus is on sub-Saharan Africa.

Its work involves everything from scientific research to the provision of safe infrastructure, engineering, education, training, advocacy, consulting and beyond. Amend has been active in Tanzania since 2009.

According to him, within only eight years, the hospital has already introduced several specialists and super specialised services that have helped the country to save billions of shillings in reducing referrals outside the country. "Also, many patients who were being forced to travel

Dr Chandika made the revelation Muhimbili National Hospital (MNH) when outlining the key achievements are now accessing almost all medical services at BMH," said Dr Chandika.

At the similar event, Dr Chandika handed over an award to Dr Stella Malangahe who was recognised as the overall winner of the 'Doctor of the Year Award'. Dr Malangahe was awarded at the 10th Anniversary of Tanzania Health Summit on October 4th, 2023.

Dr Malangahe is an Assistant Director in the Department of Haematology and Oncology at BMH. This year at BMH, Dr Malangahe led a team that performed the first Bone Marrow Transplant in three patients with Sickle cell disease.

This makes Tanzania the first country in East and Central Africa and the sixth in Africa to excel in such a rare and needy curative type of medical intervention worldwide. All transplanted patients are no longer sickle cell disease patients - they are sickle cell disease - free.

Speaking yesterday, Dr Malangahe said she will continue bringing an endless smile to her patients by expanding curative services that require bone marrow transplant treatment. "This award is not for me in Haematology and Blood Transfusion alone but it is for the BMH team and I request my fellow staff to maintain this team work spirit," she said.

Ultimatum by Lands minister Silaa will only work if he plays hardball JUST the other day, Lands, pronounced or serious ones linked to

Housing and Human Settlements Development minister Jerry Slaa was quoted as having given the authorities concerned one week to come up with a lasting end to the longstanding challenges facing efforts to formalise unplanned settlements in Dar es Salaam.

The ultimatum was prompted by the fact that complaints and differences of opinion relating to land ownership, management and use have for decades stood as a common feature not only in Dar es Salaam and other urban areas in Tanzania but indeed across the country though with varying degrees of intensity and severity.

Strategies meant to rectify matters by at least mitigating the damage or forestalling recurrences of the consequences have not come to very much.

These include the likes of what is popularly known by its Kiswahili acronym MKURABITA, translating into Property and Business Formalisation Programme. It is government initiative primarily meant to facilitate and expedite the formalisation of property and business assets in the informal sector into legally held and formally operated entities in the formal sector of the economy.

In whichever way one looks at the matter, there is no denying that not only has the perceived popularity of some of these strategies faded but also some has shown precious little to go bragging about.

So, now, does one applaud the good minister for the braveness with which he is fighting to do the impossible or rather pity him for engaging in a sure exercise in futility?

Time will obviously tell, but he deserves all the support he will need in turning things around for the benefit of Dar es Salaam - both the city and the region - and, by extension, the country generally.

abuse of office generally and misuse of land administration powers in particular.

It is a near universal fact that people have a very special attachment to land, and that is why problems with land ownership, allocation and use have touched off bloody battles or even full-blown wars in various parts of the world.

The problems have not spared Tanzania, the intermittent conflicts between farmers and pastoralists and between local residents and 'foreign' investors witnessed in different parts of the country bearing witness to this fact.

It was precisely this that once made the Benjamin Mkapa presidency promise to continue supporting efforts by the previous (Ali Hassan Mwinyi) government to conclude a national land policy.

The idea was to further enrich the idea through as much public debate as conditions would allow before asking the National Assembly to endorse it.

In Mkapa's words then: "It (the policy) essentially aims at making the land user more committed to that land so that it becomes an asset in terms of investment opportunities... It will recognise the land user's attitude, perhaps not so much towards ownership, but towards land use. Make it more permanent, more recognisable, more legal and so on so that it becomes an asset in terms of borrowing conditionalities.'

It must have been part of the logical extension of this argument that Tanzania began experimenting with MKURABITA as a development strategy.

We all need to feel obliged to have persons with special needs in mind

ANZANIANS have done other disabilities. much to be proud of in ensuring that they lead meaningful lives. However, they still ought to do a lot more.

One of the sectors calling for very special attention in this regard is education - all levels and types of education.

HakiElimu, a highly rated Tanzanian NGO the thrust of whose advocacy work is on issues relating to education, has kept conducting research and coming up with eye-opening and demonstrably useful findings about deficiencies in the sector.

For instance, one of its studies once cited problems with infrastructure as one of the factors constraining learning by students with disabilities.

At the launch of the respective report, the agency talked of the construction of 95 per cent of school buildings in the country not caring to remember that some of the people the buildings were meant for had special needs, including physical, mental and

Admittedly, there had been talk of plans to make it mandatory for buildings in urban areas to accommodate the needs of all manner of people, including those in the above-named categories.

But few had since walked that talk and most such structures effectively remained danger zones or out of bounds for massive numbers of people who could not scale staircases or cross busy streets unaided.

More judicious use of resources at the disposal of the various institutions willing to help out persons with special needs would surely improve the scenario appreciably.

Here we mean the likes of government ministries, parastatals, UN agencies and HelpAge International, and they would be readily doing so in line with the demands of things like the Universal Declaration of Human Rights. The larger society would be expected to feel compelled to chip in.

"New health technologies have the potential to save millions of lives, but R&D funding is going in the wrong direction," said Gates, adding: "Donors need to step up their commitments to ensure health innovations reach those who need them more quickly, so that more lives can be saved."

Gates has just announced that the foundation is investing US\$30 million to support a new artificial intelligence (AI) platform in Africa.

The platform will provide African scientists and innovators with the technical and operational support they need to turn promising ideas into scalable health and development solutions

It is a step towards ensuring that the benefits of AI are relevant, affordable and accessible to everyone -particularly those in low- and middleincome countries (LMICs) - and that these critical tools are developed safely, ethically and equitably.

The foundation has promised to continue to work closely with government and its technical partners in further advancing the platform and identifying opportunities to jointly advance the use of AI for health and development.

The foundation has also just announced new investments aimed at expanding access to a novel mRNA vaccine manufacturing platform that gives countries, including Senegal and South Africa, the technology to develop and manufacture their own vaccines.

mRNA technology is considered a potential game-changer for a range of infectious diseases, including tuberculosis, malaria and Lassa fever, which disproportionately affect people in LMICs.

This additional local vaccine manufacturing capacity will support LMICs to develop low-cost, highquality vaccines that address their most urgent health priorities.

"What started as a single programme funded by the Gates Foundation and its partners has grown into a family of initiatives and partnerships across national borders, fields of study and sectors that catalyse research, products and partnerships to save and improve the lives of the world's most vulnerable people," said Kedest

Applying for work and residence permits in Tanzania

HE influx of investors through multinational corporations franchises, tourists and availability of international organizations in our country have necessitated the revisiting of the requirements for work and residence permits for foreigners working and living in Tanzania.


This has been done in order to ensure compliance and smooth operations of these corporations, taking into account the fact that we do not leave in isolation but with other countries in the world. This article focuses on the types of work and residence permits and their requirements for each one.

Work permits and residence permits are important requirements for non-citizen who wish to start any business or be employed in Tanzania. Work permit gives the foreigner permission to work in Tanzania while residence permit gives a foreigner the permission to live in Tanzania.

So, every foreigner who intends to work and reside in Tanzania needs to have both permits. Validity of the two permits is a period of two years with the possibility of renewal. The law which governs this area is the Non-Citizens (Employment Regulations) Act 2015 (No. 1 of 2015).

Types of work permit

The first step for foreign investors who wishe to invest in Tanzania and companies which wishe to employ foreign employees in



Tanzania is to apply for their work permit. Essentially, there are three types of work permits. The first is class A which is reserved for investors, class B which is for foreign employees in exceptional cadres like science expatriates (oil and gas engineers, science and mathematics teachers), pilots, medical doctors et cetera and class C which is reserved for expatriates in other professions.

The applicant has to ensure that he or she applies for the appropriate work permit based on the company's requirements but also the skills of the prospective employee. For example, shareholders or investors in a company need to apply for work permit class A while directors who are not shareholders need to apply for work permit class C unless they possess the exceptional qualifications which can entitle them work permit class B. How and where to apply

Nowadays applications for work permit can be done in two ways depending on the status of the applicant. Companies which qualify as investors can make their online application through the Tanzania Investment Centre (TIC) while companies which do not qualify as investors fill online forms through the ministry responsible for labour's website but both applications are processed by the Labour Commissioner.

An applicant needs to fill work permit assessment form online and attach the applicant's photograph then submit the filled work permit assessment form online in order to get control number thereafter make payment and submit the work permit assessment form and other requisite documents to the ministry of labour or TIC in case the business of the applicant is recognized as investor. One thing to note is that procedures for application of work permit at the ministry and TIC are almost similar, except for documents submitted whereby application at TIC needs a certificate of incentive.

Requisite documents to be attached when making application for work permit comprises of basic documents like justification letter narrating the need of employing non-citizens and the skills that foreigner possesses which is filled in application form TFN901.

Others are recent passport size photo, copy of valid passport, sectoral approvals (where applicable), copy of industrial or business or operating license, copy of taxpayer identification number, value added tax certificate, copy of certificate of incorporation or business name, memorandum and articles of association or extract from the registrar of companies or constitution or any legal document evidencing the status of the legal entity concerned.

Although the above documents are basic, there could be additional documents for example certificate of incentive for investor, letter of no objection from the previous employer in case the employee had previous employment, succession plan for renewals and so on.

When to apply

Application for work permit is required to be done while the applicant is out of Tanzania. The logic here is that the Labour Commissioner has to evaluate skills of to state the areas or regions within the prospective employee and ascertain whether there are no such skills, qualifications and experience locally hence the need for a foreign employee. Section 9 (1) of the Non-citizens (Employment Regulation) Act No.1 of 2015 prohibits noncitizen to engage in any occupation for reward, profit or non-profit unless he or she has a valid work permit.

Among the accompaniments of work permit application is the contract of employment which is dully signed by the respective parties. Therefore, the employer and the prospective employee have to ensure that the contract of employment is executed but to protect the employer, one may need to put a clause that execution of such contract is subject to the grant of work and residence permit.

In practice, however, some employers sneak in prospective employees through other types of visa like tourist or business and process the requisite permits while they are in the country. This practice is not legal and most of the times such employers find themselves liable to pay fines for such misconduct.

Requirements for work permit

Apart from the basic personal information about the prospective employee like academic qualifications, the employer need to state the post for which such employee is to be employed in and the job description which matches the qualification he or she possesses. This is crucial because once the permit is granted it normally comes with restrictive clauses which prohibit him or her to work under a different post or title. Another thing is the area of employ-

ment where the prospective employee will operate from. The work permit has

Tanzania where the prospective employee is required to work in.

Also important is the name of any dependents that the prospective employee is to live with while working in Tanzania but one thing to note is that recognition of dependents does not give an automatic right to work or engage in any type of employment in Tanzania.

In a recent case of Civil Appeal No 320 of 2020 between Zorica Vejapi vs Wilderness Trail-Karama Lodge (2023) TZCA 17567 (29 August 2023), the Court of Appeal emphasized the importance of compliance with work and residence permits requirements for non-citizen employees by both non-citizen employee and the prospecting employer.

Therefore, all noncitizens need to be aware of the procedures and law to ensure they discharge their stay in the country without violates the law since ignorance of law is not a defence.

GRICULTURE in Africa has the potential to satisfy not only its own domestic food but also those of the rest of the world. Agriculture remains one of the driving engine sectors for the continent, empowering most of the population and accounting for 14 percent of GDP in sub-Saharan Africa.

Agriculture is becoming more integrated into the agri-food chain and the global market. However, it is faced with a number of challenges to meet the growing demand for food with a fast-

audio-visual content.

In addition, seed companies are increasingly creating awareness to farmers through provision of seed samples freely, especially for new varieties, normally for maize packed in 50 - 100 grams to test the ecological viability and performance of such particular seeds so as to attract demand for the next cropping season.

Digital technology is increasingly growing to improve value-chain efficiencies across various interventions from farm to markets. The agri-input companies utilize digital platforms to advertise and market products and services but also promote eextension in this era of digitization. The platforms connect farmers with value chains actors from production, information and markets. The platforms ease access to information and extension, input supply, access to finance and linkages with financial institutions to aggregation, marketing and sales. Digitization is fundamental to inspire vouth through "making agriculture smart" by offering innovative solutions through addressing existing gaps to improve adoption rate of technology with rural farming communities. Therefore, the input companies play a significant role in promoting and scaling private-led extensions not only to market their products and services but also the adoption of yield-enhancing technologies. Correspondingly, the VBA model is supplementing access to advisory services while also helping to curb the limited number of public extension agencies since the lower the ratio the better access to farmers with technical advice and other relevant agricultural technologies. VBAs provide information on the use of quality seeds, fertilizer, improved certified varieties, mechanization and other yield-enhancing technologies to smallholder farmers. These ultimately sustain improved crop yield, farm nutrition and income, reduce poverty and minimize food insecurity. It's high time for public and private stakeholders to recognize, incentivize the model, scale and sustain the private-led extension model (VBA) to accelerate the adoption rate for a wider impact to transform the food system holistically.

growing population, competitiveness in the global markets and quality of agricultural products to compete in overseas markets.

Agricultural extension is a vehicle for modernizing, commercializing and transforming agriculture in many sub-Saharan African countries. Extension services targeting smallholder farmers have increased in recent years, but there are gaps in many African countries. Extension systems and service provision face several challenges, including few extension officers, limited resources and lack of awareness among smallholder farmers hence affecting sector development and smallholder farmers economically and socially.

The system largely leaves women and youth behind on access to extension services. Most African countries experience significant problems with the availability and dissemination of agricultural advisory services to the majority of smallholder farmers.

In most countries, the ratio of extension agents to farmers even exceeds 1:3000 and 1:10000. For instance, in Nigeria, the current ratio of extension agents to farmers is between 1:5000 and 1:10000 with a total workforce of about 7000 public agents (TASAI, 2020). In Tanzania, the average ratio of extension workers to farmers is 1:1172 and 1:500 for crop and livestock farmers respectively (Busungu, C., et al. (2019).

These constraints prescribe the broader vision to revolutionize and commercialize the agriculture sector with the recommended lower ratio of 1:500 down to 1:250 to ensure efficient technical advice to farming communities on proper utilization of improved technologies for improved crop productivity and livelihood in general.

Agricultural inputs are key to scale innovation and productivity enhancement to accelerate adoption rate through better yield for improved nutrition and income to rural farming communities. Farmers need support beyond their purchase of seeds to adopt improved agricultural technologies to realize the potential of high-yielding

crop varieties on their farms. That is why technical know-how is important for farmers to realize high crop productivity and increased income of value chains.

Therefore, the private-led extension model was engineered to curb the existing gap of a limited number of public extension agents to save marginalized farmers. Private sector actors are increasingly providing extension and advisory services to farmers as part of their service delivery. This has enabled an increase in sales turnover, expanded zone of influence, geographies of coverage, and positioned brand reputation to farmers.

With the increasing market competition for seed, fertilizer and crop protection products, most agricultural input companies are driving rural advisory services to educate, inspire and persuade farmers to buy their products. Seed and chemical companies tend to develop demonstration plots along the main roads, village centers and markets to showcase the performance of their products, especially seeds, chemical and fertilizer. Some input companies are working closely with Village-based advisors and theory session with a deeper (VBAs) through the development and supervision of learning sites (demonstration plots).

Such a role incentivized VBA and earned a commission to continue supporting farmers with technical know-how on sustainable farming while aggregating input demand from farming communities. This has enabled seed, fertilizer and chemical companies to market and advertise their products and thus building good relationships with farmers for future business.

AGRA Tanzania has strived to strengthen private-led extension through recruitment and training of more than 6,000 VBAs to envision sustainably growing Africa's food systems. VBAs are self-employed farmers trained in good agronomic practices and other rural income-generating activities so that they cascade the knowledge to their local communities.

The VBA is selected by farmers themselves and works closely with public extension agents to support advisory service to smallholder farmers. Training in VBA expose them to both practical

understanding of sustainable farming practices from seed selection, planting spacing, timely planting, compost making, usage of organic and chemical fertilizer, disease and pest management, harvesting, post-harvest handling, storage, aggregation and other rural entrepreneurships.

VBAs are connected to different business avenues ranging from input companies (seed, fertilizer, crop protection), hub agrodealers, aggregators or off-takers, traders, mechanization and processors. Similarly, others are connected to NGOs to extend education and disseminate required products and services to farming communities for improved livelihoods.

In the process with such linkages, VBAs have the opportunity to generate income through commission and even start their own agro-enterprises. These profitdriven activities promote sustainability of the VBAs which allows them to continue to offer services to farmers in their communities. The VBA model has become a game-changer for many young male and female farmers through

changing mindset on agribusiness, exploiting rural agri-entrepreneurship opportunities and inclusion in farming activities.

Most input companies established and strengthened agronomy or extension departments to extend advisory services to rural farming communities. They have expanded input supply networks to reach farmers through VBA, retail, and hub agro-dealers as preferred input distribution channels and service delivery.

Moreover, input companies are actively transforming their mindset by showcasing agri-innovation through farmer field days and agricultural exhibitions to advertise and cultivate mutual business partnerships. Also, the extension services provided by companies include technical guidance and training on crop agronomy, crop care and harvesting methods to improve crop yield.

Some companies also provide education on the safe use of pesticides, insecticides, fungicides and nematicides through meetings with smallholders, field demonstrations, field days and visual materials such as posters, brochures, leaflets, banners and

El Niño's impact on Central America's small farmers gets more intense

By Edgardo Ayala

HE effects of Niño on El agriculture in Central America are once again putting pressure on thousands of small farmer families who are feeling more vulnerable economically and in terms of food, as they lose their crops, due to climate change.

But that is not all. In addition to the obvious fact that poor harvests lead to higher food prices and food insecurity, they also generate a lack of employment in the countryside, further driving migration flows, said several experts interviewed by IPS. The El Niño Southern

Oscillation (ENSO) weather phenomenon had not been felt in the area since 2016. But now it has reappeared with stronger impacts. Meteorologists define ENSO as having three phases, and the one whose consequences are currently being felt on the ground is the third, the strongest.

Impact on the families "The lack of water made us plant later, in June, when a drought hit us and ruined our corn and beans," Gustavo Panameño, 46, told IPS as he looked disconsolately at

the few plants still standing in his cornfield. The plot Gustavo leases to farm, less than one hectare in size, is located in Lomas de Apancinte, a hill in the vicinity of Santa María Ostuma, in the central Salvadoran department of La Paz. "The beans were com-

pletely lost, I expected to harvest about 300 pounds," he said. The corn and bean har-

vest "was for the consumption of the family, close relatives, and from time to time to sell," said Gustavo.

South Africa by-elections: ANC loses two seats, retains two

OUTH Africa ruling party the ANC has lost two seats in the latest round of by-elections - a safe seat to the EFF in the small town of Breyten in Mpumalanga, and a competitive seat to the Patriotic Alliance in Kimberley. It did, however, retain two key seats in other Northern Cape by-elections, while the DA held two seats in the town of Klerksdorp.

The February 2023 by-election: The ANC prevailed in a tough four-horse race, beating the DA to second place, with the PA making major inroads to finish third. The ANC received 197 more votes than the DA and 213 more votes than the PA. A former ANC ward councillor running as an independent took votes away from the ANC in Roodepan to finish in a credible fourth place. The PA won both Roodepan voting districts, taking two of the three districts in the

ward. The PA came stuck in

Platfontein. It could not replicate its impressive returns in Roodepan. This allowed the ANC to retain the ward and also saw the DA finish second. The victory for the ANC allowed it to retain its outright majority in the municipality. The by-election: Ferguson Moses, the ANC ward councillor, defected to the PA four months after winning the byelection. He elected to stand again for the ward councillor position. This saw the PA field-

Another key development was the DA candidate standing down after nominations for candidates had closed for the by-election. The DA candidate abandoned the race and defected to the PA. It was the third DA candidate in 2023 to accept the party's nomination and then defect to the PA. In two of those three cases, the candidate defected after nominations had closed, meaning that while the party remained on the ballot, it could not replace its candidate. The PA was expected to be the major

longer fielding a candidate. The PA also knew that if it could improve its returns in Platfontein, it could take this ward from the ANC.

The ANC was boosted by the independent candidate who hurt the party in the February 2023 by-election, electing to not stand again. There was another independent candidate on the ballot this time round. This was also the by-election debut for Mmusi Maimane's Build One South Africa (BOSA) party.

The PA beat the ANC by 568 votes as the party won its first by-election in the Northern Cape. The PA benefited from the DA's candidate withdrawing from the race after the nomination period had closed. However, the PA also made strides in Platfontein, a part of the ward where they struggled in the by-election here earlier in the year.

The PA built on its strong showing in Roodepan in the previous by-election. At Lucretia Primary School it

Turnout was very high here in 2021 - just under twothirds of registered voters. The ANC beat HFTF by 10% points and the DA finished a distant third. By winning this district, the ANC carried the ward. The EFF and the

The setting: Ward 6 is a large, rural ward east of Douglas, between Douglas and Kimberley. It includes the small village of Schmidtsdrift, farms, games lodges and rural settlements. Most of the voters are in Schmidtsdrift. The ward also includes the Mokala National Park. Siyancuma's seat of power is the town of Douglas. This is the confluence of the Orange and Vaal rivers. Griekwastad and Campbell are also part of Sivancuma. Sivancuma is in Pixley Ka Seme which includes De Aar, Colesberg

and Prieska. The 2021 local government elections: There was also a unique result in this municipality in 2021. The ANC won 52% of the vote but lost its outright majority. Two wards were won by independent candidates from an informal grouping called Siyancuma Independents. The candidates ran as independents. This meant that you could only vote for them on the ward ballot because the Siyancuma Independents did not run as a political party and they were not on the proportional representation (PR) ballots. The ANC lost two seats in

the municipality to fall one seat short. It won six out of 13 seats. The two independents worked with the DA, the FF+ and the EFF to oust the ANC. Well-known septuagenarian farmer Wim van Bergen was elected mayor, with the DA winning the speaker's position.



TANZANIA'S CONSTRUCTION MARKET TO HIT 12.8 TRILLION/- IN 2023, SAYS REPORT

t is estimated that the Tanzania's total market value of construction activities in 2023 will be valued at 22.8tm/in 2023 (approx. US\$9.5 billion), the construction market report by Construct Africa, the construction intelligence website has said.

Construction activities have been driven by private projects such as residential and commercial real estate as well as public projects such as the construction of roads, energy, railways, bridges, water systems, telecommunications, and air transport networks.

According to the report, allocation to capital expenditure rose consistently at 10.8 percent from 12trn/- to 13.3trn/in the four years from 2019 to 2022.

In the 2023 budget, the allocation to capital expenditure on construction is a 13.1 percent increase from the allocation in 2022.

Tanzania's construction sector recorded an impressive compound annual growth rate of 11.5 percent in 10 years from 2012 to 2021, according to the report

"The construction sector will continue to be driven mainly by public sector development initiatives in the housing sector, education, and civil works. Private sector activities would augment this growth through real estate, industrial and commercial development," it says.

"The government's renewed drive to develop Dodoma to a standard befitting of a capital city will also drive growth in the country's construction sector. Infrastructure construction works and, eventually, industrial construction will also follow, driven by exploratory activities in the natural gas and mining sectors."

The report notes that the construc-

tion sector in Tanzania is transparent as the public procurement process is transitioning towards the electronic platform, TANePS, which is now being replaced by locally developed NEST.

Public spending on projects is directed by Tanzania's National Five-Year Development Plans.

The flagship project under the current plan, covering the period 2021-26, is the ongoing 2,115MW Julius Nyerere hydro power plant.

The US\$2.9 billion megaproject is intended to help Tanzania achieve its goal of 100 percent electricity access by 2025.

Tackling the country's housing deficit, estimated at 3 million units, is another key area of focus along with improving transportation.

More than 1,400km of roads are currently under construction and several airports are being developed. Ports infrastructure is also being expanded.

In recent years, the government has been putting in place legislation and institutional support to enable publicprivate partnerships.

The role of the private sector in project delivery in Tanzania is expected to grow as a result. The authorities are working to develop a healthy pipeline of projects to bring to the market.

This month, Tanzania Roads Agency (TANROADS) launched the tender process to find contractors to build the fifth phase of its long-running Dar es Salaam Bus Rapid Transit (BRT) project, which seeks to alleviate traffic congestion in the country's chief port city.

The project entails the development and expansion of bus lanes, roads, bus stations, depots and terminals, and pedestrian bridges across Dar es Salaam to improve the public transportation network.



TANROADS has invited contractors to submit bids 27 October for Package A (road works) and Package B (building works) under the fifth phase of the programme. Package A has been divided into two lots.

Lot 1 involves building 19.3km of road works, 20 conventional bus stations and two pedestrian bridges while Lot 2 involves building 9.4km of road works and 12 conventional bus stations.

The scope of work includes upgrading the existing road from two lanes to four lanes, construction of embankments, drainage structures involving bridges, box culverts, pipe culverts and pavement layers, and ancillary works. Package B covers the construction of

depots, terminals and feeder stations. The fifth phase is being supported by the French Development Agency

(AFD). The Dar es Salaam Bus Rapid Transit (BRT) project is being executed over six phases.

Construction of the US\$96.2 million World Bank-funded first phase, involving 20.9km of roads and 27 bus stations, began in 2011 and was completed in 2016. Austria's Strabag International was the main contractor and the consultant was Australia's SMEC.

Phase 2 nearly completion and includes the construction of 20.3km of BRT lanes.

The work was split into two lots with China's Sinohydro the contractor for Lot 1, which is still underway and China Civil Engineering Construction Corporation (CCECC), the contactor for Lot 2, which has been completed.

The local Inter-Consult was the consultant for Lot 2 and the Turkey's Botek Bosphorus Technical Consulting Corporation and the local Apex Engineering are the consultants for Lot 2.

The total cost of phase 2 has been estimated at US\$159.32m and is being jointly financed by the African Development Bank (AfDB; 61.1 percent), Africa Growing Together Fund (AGTF; 27.8 percent) and the government of Tanzania (11.1percent).

Sinohvdro is also working on phase 3. Phase 3 is again divided into two lots: Lot 1 deals with road works and Lot 2 with building works.

Sinohydro is the contractor for Lot 1, which includes 23.33km of roadworks, 32 bus stations, five pedestrian bridges, a bus terminal and a bus depot. Work started in August 2022 and had reached 5% completion as of 31 March. The supervising consultants are SMEC and the local Mhandisi Consultancy and Habconsult for the road works and the local Unitec Civil Consultants for the building works. This phase is being funded by the World Bank.

Phase 4 is divided into both packages and lots.Package A concerns the road works and Package B the building works. The construction contracts were awarded in July this year to three Chinese firms.

China Geo-Engineering Corporation was awarded a US\$71.3 million contract for Package A Lot 1, covering 13.5km of road works and one bridge.

Shandong Luqiao Group Company was awarded a US\$79.3 million contract for Package A Lot 2 covering 15.63km of road works, four bridges and three terminals.

China Communications Construction was awarded a US\$24.9 million contract for Package B Lot 3 to build two depots and a terminal.

The contract period for each lot is 18 months. The consultants are Kunhwa Engineering & Consulting and Aqgola Engineering & Management Services. The World Bank is supporting this phase.

Phase 6 will involve the construction of 33.5km of roads. The concept design has been completed and the government is currently working on getting funding in place.

In another energy infrastructure project funded by the World Bank, Tanzania's Arusha Technical College is also inviting bids without prequalification for the design, supply, installation, testing, and commissioning of a 1.65MW hydropower plant to be built at Kikuletwa Renewable Energy Training and Research Centre, Hai district, Kilimanjaro region.

A compulsory site visit and pre-bid meeting is scheduled for 24 October 2023 at 10h00 (EAT) at Kikuletwa Renewable Energy Training and Research Centre.

China property creditors facing worsening restructuring terms

HONG KONG/NEW YORK

As more Chinese property developers move towards restructuring billions of dollars of debt, their offshore creditors are expected to face another setback - the prospects of revamp terms being tightened due to a worsening outlook for the county's real estate sector.

So far, developers accounting for 40 percent of Chinese home sales have defaulted on their debt obligations since 2021, according to JPMorgan. Those defaulted companies, mostly private, have issued around \$110 billion worth of high-yield offshore bonds.

Despite a raft of Beijing's supportive policies in recent months, home sales are showing few signs of improvement. Developers, financial advisers and bondholders said that could make debt restructuring terms much worse than expected earlier.

and CIFI Holdings have reduced offers to offshore creditors in the past few weeks, citing a worsening environment, six sources with knowledge of the matter said.

Dubai apartment prices up 1.5pc in September

DUBAI

Dubai's real estate market maintained its unprecedented growth track in September, as investors continued to rush in, new data showed on Monday.

The apartment submarket saw capital gains of 1.6 per cent monthly in September and expanded at a new record 11 per cent annually, the highest capital growth for apartments witnessed in a decade, data from Valustrat showed.

The ValuStrat Price Index or the VPI for September 2023 accelerated 2.1 per cent monthly and 15.1 per cent annually to reach 96.6 points. Apartments were at 79.7 points, and villas at 123.6 points, this is compared to 100 points set in January 2014.

The VPI is a valuation-based price index constructed to rep-



resent periodic change in capital values and rental values experienced by typical residential and commercial properties.

Villa and apartment capital gains accelerate during September across the board. In addition to prime properties, cheaper homes within the mid-affordable segment witnessed increased valuations. Off-plan transactions declined, high growth in the ready

(secondary) home market, the report showed.

The best apartment annual performance was recorded in Palm Jumeirah (20 per cent), The Greens (17.8 per cent), Discovery Gardens (17.1 per cent), Motor City (15.2 per cent), and Jumeirah Beach Residence (11.6 per cent). On average, apartments were 29.2 per cent below their mid-2014 price peaks.

Villa prices increased 2.6 per cent when compared with August, and 19.8 per cent since last year. The top annual performers were villas in Jumeirah Islands (26.3 per cent), Dubai Hills Estate (24.4 per cent), Palm Jumeirah (24.2 per cent), and Emirates Hills (21.8 per cent). Apart from Al Furjan and Jumeirah Village Triangle, all villas and townhouses monitored by the VPI have surpassed their 2014 price peaks.

However, home sales declined 29.7 per cent monthly and 10.9 per cent annually. Off-plan Oqood (contract) registrations fell 55.7 per cent monthly 37.5 per cent annually, representing a minority share of 40 per cent of overall monthly sales. Ready homes transactions increased 15.5 per cent monthly and 24.4 per cent annually.

According to its press released recently in Pretoria, South Africa, ATAF enlightened that the Suggested Approach includes extensive explanatory notes to understand better what each provision seeks to achieve as well as to anticipate African countries to enact the GloBE rules.

The revisions also aim to provide tax administrators, policymakers, and stakeholders with an enhanced framework to address contemporary challenges and ensure a fair and efficient taxation environment.

Logan Wort, the ATAF Executive Secretary, commented, "The release of this revised Suggested Approaches marks a significant milestone in our collective efforts to strengthen domestic revenue mobilization. ATAF remains committed to supporting African nations in developing and implementing tax policies that are effective and contribute to sustainable economic development."

Wort highlighted the key points of the revised suggested approaches that include:

Alignment with International Standards: The updated Suggested Approaches that align with international best practices to facilitate harmonization and coherence in tax rules.

Another area is the Inclusivity and Consultation; in which ATAF has prioritized inclusivity by engaging in extensive consultations with tax experts, government officials, and other stakeholders.

This collaborative approach ensures that the Suggested Approaches are well-grounded and practical.

Adaptability to National Contexts: Considering the diversity of tax systems across African nations, the revised guidelines provide flexibility for adapting to individual countries' unique needs and contexts.

"ATAF stands ready to support its members to draft Domestic Minimum Top-up Tax Legislation using the Suggested Approach" stated Logan Wort. "ATAF is launching an extensive programme to assist countries undergoing

Many African countries have granted tax incentives which result in an effective tax rate of less than 15 percent for some multinationals.

Under the GloBE rules, where a tax incentive results in an effective rate of less than 15 percent, the GloBE rules will lead to another tax jurisdiction, usually the jurisdiction where the multinational is headquartered, collecting the difference between the effective tax under the tax incentive and the minimum effective rate of 15 percent (the top-up tax).

The DMTT allows the country where the low tax profits arise from the tax incentive to collect that top-up tax rather than allowing it to be collected by the headquarter jurisdiction.

Over 50 countries have announced that they will enact GloBE rules in 2024, and many will start collecting top-up tax that year.

Therefore, African countries are strongly recommended to immediately enact DMTT rules to protect themselves from giving away taxing rights to developed countries on top-up tax arising from their own tax incentives.

However, commenting on the approach by ATAF, a Tanzanian based Geita Gold Mining Limited Tax Manager, Mr Godvictor Lyimo said that over the years, Tanzania has made significant steps in enhancing a fair taxation system not only from the Multinational companies but for the entire private sector. While the DMTT is proposing a minimum of 15%, the country is way above that. Even with the incentives currently being offered our legislation requires all companies who are perpetual loss makers to pay a turnover tax to safeguard the interests of the country. There is now a need to focus more on base erosion and profit shifting as an area of concern globally.

"I believe a detailed analysis needs to be done on DMTT proposal in the Tanzania context to ascertain how best it can work in enhancing more investments and safe guarding Government Revenues". he commented.

The Portfolio Committee on Water and Sanitation has raised concerns over weaknesses in finalising bulk infrastructure projects within the water and sanitation portfolio.

Following the receipt of progress reports on the implementation of the Department of Water and Sanitation (DWS) and its entities' annual performance targets, the committee said that the delays required urgent action, including strengthening project management and monitoring.

"The committee considers it unacceptable that 71% of total projects funded through the Regional Bulk Infrastructure Grant programme have been delayed. The direct impact of the delays is the non-delivery of quality water to the people, as well as undermining the economic potential that could be unlocked by provision of water," said Portfolio Committee on Water and Sanitation chairperson Robert Mashego.

Concern was further raised over the impact on the projected budgets of these delayed projects, which continue to increase, placing further stress on the already constrained fiscus, with the committee highlighting the Office of the Auditor-General's projections that the increase in revised budgets owing to delayed projects amounts to R9.4-billion.

"To remedy this weakness, the committee has called for improved project management, monitoring and procurement processes. Further, the committee called on the department to capacitate its project management unit to enhance oversight and monitoring," he said.

Surge in expat population spurs house demands in Oman- report

MUSCAT

Recent growth in the expatriate population in Oman, coupled with strategic investments to boost the economy, has spurred property demand and rent increases in the country, according to a Savills report.

After falling in 2017 and during the COVID-19 pandemic, the number of expatriate residents in Oman has started rising in recent times, posting a 33 percent growth from a low point of 1.63 million in September 2022 to a record-breaking 2.17 million in May 2023

increased demand for rental properties, especially in higher-quality localities."

Savills said there has been an increase in demand in central locations like Al Mouj, Qurum, Shatti Al Qurum and Madinat Al Sultan Qaboos, among others. It is anticipated that expatriate numbers will continue to grow as the Omani economy continues to recover and oil prices remain favourable.

"Over the coming 12 months, we would expect rental values for mid-to-highend units to remain relatively stable (and even show moderate increases in some locations)," said Matthew Wright, Head of Consultancy at Savills Oman.

Additionally, Mashego pointed to the Water Trading Entity's (WTE's) maintenance of water infrastructure as an area of concern for the committee.

"The committee is concerned that 42 percent of the WTE bulk infrastructure assets are reported to be in poor condition, which leads to high water losses, loss of revenue and the inability to deliver water to clients."

The committee has urged stakeholders to increase investment in maintenance from the current 2.1% to 8 percent, as prescribed by the National Treasury.

Inflation affects UK house prices

LONDON

Inflation has masked the true extent of recent falls in UK house prices, with many regions and nations of the UK no better off in real terms housing wealth than on the eve of the 2008 financial crisis, research has found.

UK house prices have fallen by a modest 2.8 per cent in nominal terms since their peak in March 2022, but 13.4 per cent in real terms, according to analysis of the Nationwide house price index by estate agent Savills. After adjusting for inflation, average real house prices are no higher than they were in late 2015, Savills said.

"Because of high inflation, the adjustment in the average price of a UK home has been much more significant in real terms," said Lucian Cook, residential research director at Savills. The analysis suggests the average buyer will have seen a real-terms loss in the value of their home if they bought after December 2015.

Across some regions and nations of the UK, house prices have yet to recover to 2007 levels after adjusting for inflation. Prices in north-west England, Yorkshire and the Humber and West Midlands, as well as Wales, Scotland



ly below their peak before the 2008-09 financial crisis, Savills found.

Real-terms prices in the north of England have fallen by 27 per cent since their peak in the third quarter of 2007. Over the same period, Yorkshire and the Humber is 21 per cent down; the East Midlands by 11 per cent; and Wales by 18 per cent.

Cook said property owners may not have felt the loss of value since the nominal value of their homes may have gone up or not fallen significantly in the past few years, but inflation had done its work of eroding underlying value, leading to the adjustment in real terms. To find the last time house

price growth exceeded inflation over any sustained period one had to go back to the period between the mid-1990s and 2007, he added.

UK consumer price inflation - excluding housing – was running above 10 per cent in the seven months from September 2022 to March 2023. It has since fallen to 6.7 per cent in the year to August, but remains elevated.

Higher inflation has led the Bank of England to raise its official rate of interest from 0.1 per cent to 5.25 per cent since December 2021 and pushed up mortgage rates, damping demand in the housing market.

While lenders have competed more vigorously on mortgage rates in recent

Moneyfacts, said the average two- and five-year fixed rates had fallen for the second month running, offering borrowers potentially cheaper deals. "These are encouraging signs for borrowers who may be looking for a new fixed-rate deal, but they still may be on the fence about locking in, hoping rates will fall further in the weeks to come."

Israel kills senior Hamas official as death toll reaches 1,300

JERUSALEM/GAZA

THE number of fatalities in Israel since the beginning of Hamas' surprise attack has reached at least 1,300, Israel's state-owned Kan TV news reported vesterday.

Over 3,268 people were injured, and 443 of them are still in hospitals, the Israeli Health Ministry said.

Attempts to find bodies in southern towns and villages continued on Thursday, Israeli authorities said.

In Gaza, more than 1,200 individuals have been killed by Israeli airstrikes, according to the Palestinian Health Ministry in Gaza.

Meanwhile, the Israel Defense Forces (IDF) said in a statement on Thursday morning that Israel has killed a senior member of the Hamas naval force in an airstrike overnight.

The IDF killed Muhammed Abu Shamala, a senior member of the Rafah Brigade in the Hamas naval force, and destroyed his house, which was used to store weapons to be used in operations against Israel, according to the statement.

Earlier on Wednesday, Israel formed a unity government and a war cabinet to oversee the deadly conflict triggered by Hamas' weekend surprise attack as it continued to launch airstrikes on the Palestinian enclave of the Gaza Strip.

Fighting continued on Wednesday, with Israeli airstrikes continuing to demolish neighborhoods in the blockaded enclave, while militants in Gaza continued to fire rockets towards southern and northern Israel. The Israeli army also reported several infiltrations of gunmen in which at least five militants were killed.

The Palestine Red Crescent Society said on Wednesday that four of its paramedics were killed during Israeli airstrikes on Gaza. The United Nations Relief and Works Agency for Palestine Refugees (UNRWA) reported the loss of eleven employees in the Gaza Strip since the weekend.

According to United Nations figures, some 250,000 people were displaced or lost their homes in Gaza. The Palestinian would be sent through the Rafah border Energy Ministry said the only power plant The Israeli army also struck multiple ground attacks on the Israeli towns border- in Gaza ran out of fuel. The Health Ministry

in Gaza said in a statement Wednesday all hospital beds in the Palestinian enclave had been occupied, and medicines were about to run out as the conflict continued.

To resolve the conflict, an Arab League (AL) extraordinary meeting at the level of foreign ministers was held in Cairo on Wednesday. Participants of the meeting called for an immediate halt to the ongoing Israel-Gaza conflict and the revival of the stalled Palestinian-Israeli peace process.

In the final communique of the meeting, the top Arab diplomats urged all parties to exercise self-restraint, warning of "the catastrophic humanitarian and security repercussions" of further escalation.

They also emphasized the necessity of lifting the Israeli siege imposed on Gaza and immediately providing humanitarian aid, food, and fuel to the people there.

Egypt said Wednesday it is in discussions with the United States and other countries to provide humanitarian aid to Gaza through a temporary ceasefire. The aid crossing between Gaza and Egypt.

Putin: Russia supports two-state solution in Gaza conflict

MOSCOW

MOSCOW has always supported a two-state solution to the Palestinian-Israeli conflict, Russian President Vladimir Putin said on Wednesday.

Speaking at the plenary session of the Russian Energy Week, Putin (putin) said that Russia's position on the Palestinian-Israeli conflict has remained the same over decades, and this stance is well known in both Israel and Palestine.

"We have always advocated for the implementation of the decisions of the

United Nations Security Council, which involve the establishment of an independent and sovereign Palestinian state," the Russian president said.

He criticized Washington's policies in the Middle East, noting that the United States tried to focus on financial assistance, rather than finding solutions to existing fundamental political challenges.

The Russian leader said that such moves only escalate the situation, and it is necessary to find compromises.

"It is unclear whether it will be possible to somehow calm the situation in the near future, but we must strive for this because the expansion of the conflict zone can lead to dire consequences," Putin said.

He further said it was crucial to minimize civilian casualties on both sides.

The Palestinian Islamic Resistance Movement (Hamas) on Saturday launched a surprise attack on Israeli towns adjacent to the Gaza Strip, prompting Israel to launch retaliatory strikes on Gaza. The Israel-Hamas conflict has so far caused heavy casualties on both sides.

U.S. House Republicans on Wednesday nominated House Majority Leader Steve Scalise for speaker in a closed-door voting

amid deep divisions, paving the way for a floor vote in the chamber to elect a new speaker after Kevin McCarthy's historical ouster last week.

Scalise (pictured), the No. 2 Republican in the U.S. House of Representatives, won the nomination in a 113-99 vote over Jim Iordan, chairman of the House Judiciary Committee and cofounder of the conservative House Freedom Caucus.

The vote came after the unprecedented ouster of McCarthy, who was booted out of his position on Tuesday last week, in a move initiated by a member of his own party. It marked the first time in U.S. history that a House speaker has been voted out of office in the middle of a term.

A win of only 14 votes by Scalise indicated the deep divisions



Louisiana Republican in order to reach the required simple majority threshold in the chamber to elect a speaker, as Republicans hold a slim 221-212 majority.

Despite Scalise winning the Republican conference vote, several Republican lawmakers said they still plan to support Jordan on the House floor, raising uncertainty as to whether Scalise would be able to garner enough House Republican votes to actually become speaker. US House Republicans nominate Steve Scalise for speaker amid deep divisions

The House convened Wednesday afternoon, but Speaker Pro Tempore Representative Patrick McHenry, a North Carolina Republican, quickly called the chamber to recess after gaveling.

"The speaker designee has the right to put his votes together for the floor and make sure the timing is right, so we're gonna let that happen," McHenry said. House Republicans will certainly try to avoid a repeat of McCarthy's speaker election in January, when he clawed his way to victory by cutting a deal with conservatives after 15 rounds of voting. For their part, House Democrats unanimously renominated House Minority Leader Hakeem Jeffries in a closed door meeting Tuesday night.

The House can't move forward on its legislative process until a speaker is chosen, and lawmakers need to pass a spending bill before government funding runs out in mid-November. The House is also under pressure to take action following the escalated Palestinian-Israeli conflict.

"Until a speaker is elected there's not going to be anything meaningful happening in the House, and the clock is ticking on

stay open," Christopher Galdieri, a political science professor at Saint Anselm College, told Xinhua.

"It's really, really important that this Congress get back to work," Scalise said, noting that a strong resolution expressing support for Israel would be his priority if elected speaker.

While the U.S. government narrowly dodged a partial shutdown and the House ousted its speaker for the first time in history, a recent Reuters/Ipsos poll found that two-thirds of Americans believe Washington politicians cannot put aside their partisan differences to do their jobs.

IMF raises India's growth forecast second time citing strong consumption

NEW DELHI

THE International Monetary Fund (IMF) has raised India's GDP growth forecast for India for the financial year 2023-24 to 6.3 per cent, its second upward revision since the April report.

According to the latest World Economic Outlook report by the multilateral agency, which was released on Tuesday, the growth is expected to grow by 6.3 per cent this fiscal year, 20 basis points (100 basis points is equal to 1 percentage point) higher than what it had estimated in its previous report.

IMF attributed stronger-than-expected consumption during April-June for the upward projection in the growth estimate

The growth forecast was raised from 5.9 per cent in April, 6.1 per cent in July, to 6.3 per cent now, taking it closer to the 6.5 per cent predicted by the Indian authorities.

For 2024-25, IMF pegged India's GDP growth at 6.3 per cent, though unchanged from its earlier two projections.

IMF projected India's consumer inflation at 5.5 per cent this fiscal, against RBI's 5.4 per cent forecast. RBI expects Q2 (Jul-Sep) inflation at 6.4 per cent, Q3 (Oct-Dec) at 5.6 per cent and Q4 (Jan-Mar) at 5.2 per cent. For Q1 (2024-25 fiscal), it is projected at 5.2 per cent. Overall, the IMF forecast global growth to slow from 3.5 per cent in 2022 to 3.0 per cent in 2023 and 2.9 per cent in 2024, well below the historical (2000-19) average of 3.8 per cent. Advanced economies are expected to slow from 2.6 per cent in 2022 to 1.5 per cent in 2023 and 1.4 per cent in 2024 as monetary policy tightening

2023 and 2024.

Global inflation is forecast to decline steadily, from 8.7 per cent in 2022 to 6.9 per cent in 2023 and 5.8 per cent in 2024, due to tighter monetary policy aided by lower international commodity prices.

"Food security concerns prompted recent export restrictions in India, the world's largest rice exporter. Risks to prices are tilted to the upside, stemming mostly from the ramifications of the end of the Black Sea Grain Initiative and uncertain effects of El Nino (see chapter text), possibly exacerbated by the proliferation of food export restrictions," IMF said.

Core inflation, which is the change in the costs of goods and services barring those from the food and energy basket, is generally projected to decline more gradually, and inflation is not expected to return to the target until 2025 in most cases

East African bloc warns of El Nino rains in Horn of Africa

NAIROBI

EL NINO rains will begin in the Horn of Africa region from mid-October, experts from the Intergovernmental Authority on Development (IGAD), an East African bloc, said on Monday, noting that there has been a delay in onset.

Eunice Koech, a climate modeling assistant at the IGAD Climate Prediction and Applications Center based in the Kenyan capital of Nairobi, said during a virtual meeting that the forecast for the region to receive heavier-than-normal rains during the October to December season still stands, as El Nino conditions have already formed.

Koech noted that the Indian Ocean Dipole, a phenomenon that causes heavy rains, is in a positive phase; thus, the rains would begin anytime. "El Nino rains will affect Uganda, Rwanda, Burundi, Tanzania, southern Somalia, Ethiopia, and Kenya. Onset for most countries is from mid-October to mid-November. People should not be worried that the rains have not come; they are coming," she said.

One of the sectors that would be affected by the heavy rains is agriculture, Koech added

Jasper Batureine Mwesigwa, a food security expert at the Food and Agriculture Organization of the United Nations, said the positive impact of the rains would be improved pasture in arid areas, availability of water, good crop performance, and enhanced food security.

Negatively, he said, farmers should expect flash floods that may lead to the burying of crops on farmlands, causing displacements and food shortages. He further warned that there is also a likelihood of desert locust outbreak due to the heavy rains that would provide perfect conditions for the pests to thrive.

Terrorist group Hamas launched

a rocket attack at Israel's southern according to The Times of Israel. coastal city of Ashkelon on Tuesday, The Times of Israel reported.

As the barrage of rockets pounded the coastal city, sirens sounded in the city and other nearby towns.

The terrorist organisation had earlier issued a warning that it would attack Ashkelon at 5 o'clock in retaliation for Israeli attacks on the Gaza Strip.

The spokesperson for Hamas's Izz ad-Din al-Qassam Brigades, Abu Obeida, had threatened Israel's coastal city of Ashkelon with a major rocket barrage in the coming hours, The Times of Israel reported.

The Hamas leader has also asked the residents to leave their homes in order to not fall victim to the attacks.

"In response to the enemy's crime of displacing our people and forcing them to flee their homes in several areas of the Gaza Strip, we give the residents of the occupied city of Ashkelon a deadline to leave before 5 p.m," Abu Obeida said on his Telegram channel,

As Israel is subject to rocket assaults

from both the Gaza Strip and Lebanon, the approaching rocket sirens are once more audible in the western Galilee and the southern coastal city of Ashkelon, The Times of Israel reported.

There are no immediate reports of damage or injuries in the attacks.

Over 770 Palestinians have been killed in air raids after Israel launched a strong retaliation after the 'surprise attack' by Hamas, Al Jazeera reported on Tuesday.

The Health Ministry in Gaza said that at least 770 Palestinians have been killed and 4,000 wounded in Israeli air raids. Among the dead are 140 children and 120 women, a ministry spokesperson said.

In addition to this, at least 18 people have also been killed and around 100 were injured in the West Bank region since Saturday, Al Jazeera reported. Meanwhile, at least 900 Israelis were killed and over 2,616 people injured


after Hamas launched a barbaric 'surprise attack' on Israel on October 7.

In a war update shared by Israel Defence Forces (IDF) on X, the IDF said that about 30 hostages have been held by Hamas in Gaza in the ongoing conflict. It also stated that about 4,500 rockets have been fired from Gaza on Israel after which the Israeli defence forces struck 1290 Hamas targets in Gaza.

An IDF Spokesperson has confirmed that 123 soldiers have been killed in the fighting, and 50 families have been informed that a relative was kidnapped by Hamas.

Earlier in the day, in a stern warning to Hamas, Israeli Prime Minister Benjamin Netanyahu said that "though Israel did not start this war" but "will finish it".

"Israel is at war. We didn't want this war. It was forced upon us in the most brutal and savage way. But though Israel didn't start this war, Israel will finish it," said Netanyahu in an address to the nation. ANI

UEFA president expresses 'profound sorrow' to Israel

UEFA president Aleksander Ceferin has expressed 'profound sorrow' about "the tragic acts of violence" in Israel.

Palestinian militant group Hamas launched a series of attacks on the country, killing hundreds and taking up to 150 people hostage.

Ceferin made his remarks on behalf of the European football community in a letter sent to the chairman of the Israel Football Association.

Israel's Euro 2024 qualifier against Kosovo on Sunday has been postponed.

Israeli authorities will not allow the national team to travel abroad, and a new date for the fixture will be announced in due course.

In response to the attacks by Hamas, Israel has launched air strikes on Gaza and prevented the passage of food, water, fuel and medicine into the territory.

"On behalf of UEFA and the European football community, I am writing to express our profound sorrow upon learning about the tragic acts of violence that occurred last week in Israel, resulting in the loss of innocent lives," said Ceferin in his letter.

"My heart goes out to all the victims and their families during these difficult times. It is an unimaginable tragedy, and the pain and sorrow are fears of a backlash from some comprofound and resonate across the entire football community.

"We sincerely hope no one will ever again experience such grief.

"My friend, I pray for these deep wounds to heal and for a world where such senseless acts of violence have no place."

The UK government has written a letter encouraging governing bodies in sport to "appropriately" mark the attacks in Israel this week with shows of support for the victims.

The Football Association is unlikely to light the Wembley arch in the colours of the Israel flag because of munities and, rather than lighting the arch, BBC Sport understands a message of peace and unity will be conveyed before England face Australia in a friendly on Friday.

A decision on how to mark the attacks is expected to be made on Thursday.

The FA, Premier League and individual clubs have not yet commented about the ongoing conflict between Israel and Hamas. BBC

Namibia's Brave Warriors ready for AFCON return

NAMIBIA coach Collin Benjamin has said his team's opponents will need to be "really good" against the fourth-lowest ranked side at the 2023 Africa Cup of Nations (AFCON).

Benjamin is expected to be among the national coaches in Abidjan for the Afcon draw, which takes place on 12 October, after leading the Brave Warriors to qualification for the first time since 2019.

"We're going to have to be 'brave warriors' on that field," Benjamin told Newsday on the BBC World Service.

Former Hamburg defender Benjamin, who is seeking Namibia's first win at AFCON, feels his country has a point to prove at the finals, which start on 13 January, after a turbulent time in the Namibian domestic game.

"We didn't have active football for three years and we were not able to play our matches at home," he said. "So it's basically against all odds and everything was

against us. It's restoration for the country - it's pride for the country, it's pride for the players." Football came to a halt in Namibia after the end of

the 2018-2019 domestic season because of a long-running and acrid dispute between the Namibia Football Association and the Namibia Premier League.

Football finally made its return in 2022 - but Benjamin faced a challenge when he succeeded Bobby Samaria as the head of the national team in June that vear.

The lack of football had left players unfit, and the Confederation of African Football (CAF) declared the national Sam Nujoma Stadium was not up to international standard, so Namibia could not host any home matches.

Despite those challenges, Namibia will hope to progress beyond the group stages for the first time when they make their fourth AFCON appearance.

Government 'has taken a backseat'

Namibia produced two memorable results against Cameroon in qualifying, holding the five-time Afcon champions to a 1-1 draw on 24 March before beating them 2-1 four days later.

They pipped Burundi to qualification and will join four other southern African nations in Thursday's draw in Abidjan: South Africa, Zambia, Mozambique and Angola.

Benjamin believes there is still a long way to go before the Namibian government is ready to commit to investment in football.

"If I'm being honest, since we came back from the 2019 African Nations Cup in Egypt, the government has basically taken a backseat," he said.

"They are not visible, they're not around and I just obviously hope that, with us qualifying, we're looking for that engagement with government now. I hope things will change."

"It's tournament soccer. It doesn't have to be beautiful, it has to be effective. To be effective, you have to have a lot of discipline and to have discipline you need to put the work in.

"We need to go into camp a little bit earlier, work a little bit harder, jump a little higher and kick a bit higher than the rest.'

Benjamin played in the 2008 AFCON tournament and returned as an assistant coach in 2019.

If he is to take the Brave Warriors past the group phase for the first time, much depends on the hand they are dealt in Thursday's draw.

"In southern Africa, we're basically small boys, if you look at it in the context of the continent," he said.

"We're going to be courageous and we want to stamp our authority, saying 'listen big boys - we're sitting here on this table with you all and we want a piece of that bread. If you want to take all of it, you'd better be really good because we are prepared to take that fight on."

Teams are placed in pots for the draw based on their FIFA ranking, with Namibia in pot four alongside Guinea-Bissau, Mozambique, Angola, Tanzania and The Gambia.

ZIMBABWE have completed the semi-final line-up at the 2023 Hollywoodbets COSAFA Women's Championship in Gauteng, South Africa following a 1-1 draw with Botswana in the Group C decider on Wednesday.

They join Malawi, who topped Group A with nine points, and Zambia and Mozambique, who finished in first and second places with seven points respectively from Group B.

Zambia and Zimbabwe will clash in a titanic battle in the first semi-final on Friday at 12h00 before Malawi and Mozambique go head-to-head at 15h30.

Both games will be played at the Lucas Moripe Stadium in Atteridgeville and the much anticipated Video Assistant Referee (VAR) technology will be used for the first time at a COSAFA tournament at this stage.

Botswana survived an early injury scare against Zimbabwe as goalkeeper Lesego Moeng needed medical attention in the first minute.

Three minutes later Zimbabwe won a corner kick and it was Priviledge Mupeti who found Ennety Chemhere, who headed home the opener in the opening five minutes to give her side the lead.

Botswana won a free-kick 25 minutes later and captain Kesegofetse Mochawe delivered it and forced Cynthia Shonga to punch away to deny them the equalizer.

Moments later Lesego Radiakanyo found Gaonyadiwe Ontlametse in the box and she missed the target.
