COMESA, EAC plan to boost horticulture regional trade

By Guardian Correspondent, Arusha

THE East African Community (EAC) and the Common Market for Eastern and Southern Africa (COMESA) plan to boost intra-regional trade in horticulture.

Appolo Owuor, the COMESA-EAC Horticultural Accelerator (CEHA) regional coordinator told the pre-launch stakeholders' meeting here over the weekend that CEHA is committed to fostering intra-regional trade in fruits and vegetables valued at \$25m by end of the decade.

The instrument set to be inaugurated next month is expected to transform the regional horticultural landscape, multiplying opportunities and availability of the targeted products in the EAC-COMESA zone, he said.

"Through collaborative initiatives and strategic partnerships, we aim to remove trade barriers, improve infrastructure and promote sustainable agricultural practices to unleash the full potential of our vibrant and diverse

Burundi signs up for \$3m 'backbone' extension

BURUNDI and Tanzania have signed a \$3.3m agreement for extension of the fibre optic backbone services to Burundi.

Nape Nnauye, the Information, Communication, and Information Technology minister graced the signing event, where the Burundi Backbone System (BBS) and Tanzania Telecommunications Co. Ltd (TTCL), entered into a commercial agreement spanning five years, quoted at the value of \$3.3m (8.3bn/-).

OLICE in Arusha are investigating the whereabouts of the Kenyan truck driver at the heart of Saturday's road crash that has left at least 25 people dead.

Justine Masejo, the regional police commander (RPC), said that the driver was unhurt and then disappeared from the scene of the accident. He may still be holed up somewhere in the city environs, the RPC asserted.

Meanwhile President Samia Suluhu Hassan has sent a message of condolence to Arusha Regional Commissioner John Mongella following the deaths of 25 people and 21 survivors injured in a multiple car crash on Saturday evening.

A State House statement signed by Zuhura Yunus, the director of presidential communications, said that the government will bear treatment costs for the survivors of the accident.

Wishing those injured a quick recovery, she directed that responsible authorities in Arusha ensure that the injured obtain free treatment, expressing sympathy for the survivors and all the bereaved, joining with those families in their hour of grief.

The road accident occurred at around 5pm at the junction of the newly built East African bypass road at the Ngaramtoni suburb in Arumeru District along

horticultural sub-sector," he stated.

The regional cooperation blocks with to unlock the full potential of avocado, onion and Irish potato value chains, he said, noting that they are the most traded crops within the eastern and southern parts of Africa.

"Avocado, onion, and Irish potato can generate a combined \$230m per year for upwards of 450,000 smallholder farmers with 0.4 hectare holding 60 avocado trees or 1 hectare for onion farmers," the coordinator explained.

Potential value chain products like tomato and cabbage may be added in future if recommended by CEHA stakeholders and structured interest groups, he said.

The maiden stakeholders' meeting for the Tanzania chapter was held here at the weekend under the auspices of the Tanzania Horticultural Association (TAHA), with the CEHA CEO affirming that the target is to harmonise COMESA-EAC fragmented regulatory and standard policies.

They will also seek to coordinate the production chain, address poor storage and transportation snags for the perishable crops and ensure availability of quality and sufficient seeds, he elaborated.

The volume of preserved or processed fruits and vegetables is expected to double from 8 per cent in 2021 to 16 per cent, decline of time from farm-to-market by 50 per cent during the period, while farm gate prices are likely to come down by up to 25 per cent.

The value of fresh and processed horticultural products is projected to reach \$500m while creating 100,000 jobs along the value chains, he stated, pro-

jecting halving of post-harvest losses from 40 per cent at the

Farmers will be adopting climate-smart practices to maintain profitability, including by growing crops that are resilient to predicted changes in local weather patterns, he said.

Building the capacity of the horticultural industry across Eastern and Southern Africa is part of a decade long plan of action for commodity trade at COMESA, to integrate smallholder farmers in domestic, regional and international markets.

The EAC has a similar plan, the Fruit and Vegetable Strategy 2021-2031,1 here


CEHA will now co-ordinate private sector-led investments into production and processing clusters.

It will also facilitate access to working capital and layout financing, plus making available technical assistance for processors, farmers, and other agribusinesses across the value chains to accelerate growth.

Five countries, namely Ethiopia, Kenya, Rwanda, Tanzania and Uganda have been selected in the accelerator drive, based on financial contribution of the industry to their economies, he

In Kenya alone, avocadoes are expected to create 50,000 jobs while Irish potatoes add 380,000 job openings, projecting that in Tanzania and Uganda, the onion value chain is expected to capitalise on strong brand quality and growing demand to create more than 230,000 rural jobs

Currently at \$4bn, high value fruits and vegetables are consistently more profitable than cereals and other traditional staple crops, with demand in domestic and export markets on the rise, he added.

said that so far the death toll from the multiple-vehicle crash stands at 25 in the busy Kibaoni spot on the outskirts of the city.

The dead are 14 men, 10 women and the latest addition being a young girl, he said, noting that seven foreigners from different countries died, from Kenya, Togo, Madagascar, Burkina Faso, South Africa, Nigeria

and the United States, while those injured include travellers from Nigeria, Ivory Coast, Switzerland, Cameroon, Britain, Mali and Hawaii, a part of the US.

SACP Masejo said that the accident involved four vehicles, including a large semi-trailer truck of Mack model, a Kenyan transit cargo haulier with KAC 943H plate number.

The truck belonging to KAY Construction Co. of Nairobi was

pulling a trailer with plate number ZF 6778 when it crashed into three other vehicles, namely a passenger commuter van, a school bus and a private car.

The speeding Mack truck's brakes failed and it crashed into the three vehicles, one a yellow school bus - a Toyota Coaster with plate number T 673 DEW for the New Vision School.

The passenger carrier was a Nissan Caravan combi with plate number T623 CQF

which yielded the bigger number of victims, the police chief noted, identifying the private car as a Mercedes Benz sedan, T 879 DBY

Mount Meru referral hospital sources affirming that 21 injured persons from the accident scene were being treated there.

Residents want import of 'cheaper' sugar from Zambia, Malawi

THE government has been urged to temporarily lift customs conditions for sugar coming from the neighbouring Zambia and Malawi in order to help reduce the ongoing shortage crisis.

A section of residents in Mbeya Region decried the acute shortage of sugar in the area, saying it does not only affect daily consumption needs but goes further to affect trade and economic development.

Speaking to this paper in different interviews at the weekend, the residents said that usually sugar from the two countries is sold at lower price compared to Tanzania's brands but due to hard customs restrictions, it is hard to import it into the country.

Mariam Mwakimbasi, a food vender at Mbalizi area in Mbeya City, said that there is a lot of sugar sold at a very low price at the border of Tanzania and Zambia but it is hard to enter the country due to customs conditions.

"Because the country is going through a hard time of shortage of sugar, and that the same commodity is highly available in our neighbouring countries, it is important to allow the commodity to enter the country smoothly to address the shortage," she said.

According to her, one kilogramme of sugar is sold at 2500/- at the border areas but not allowed to enter the country until levies are paid, a situation which does not address the ongoing crisis.

"The situation has now become intense and we do not know if our businesses are going to survive especially those of us who need a lot of sugar to prepare foods. Cus-

tomers do not take tea anymore because we have hiked prices of a cup of tea and coffee from 300/- to 500/- with snacks also being sold at higher prices then before," she

Jailos Kijalo said sugar from Zambia and Malawi is sold at border areas at a very affordable price but it is hard to bring it to Tanzania, adding that it is hard for his family to take tea every day as before.

Kijalo who conducts business between Tunduma town, Mbeya city and Kyela in the region said he has been witnessing Tanzanian law enforcement officers arresting people who transport sugar from Zambia and Malawi to Mbeya.

According to him, the officers have been entering commuter buses for inspection and whenever they catch bags of sugar, they seize them and detain the owners.

"Sugar crisis has pushed people to engage in the illegal business of smuggling sugar into Tanzania; it is now sold as cannabis. To reverse the situation, the government has to ease conditions and allow the commodity to enter the country legally," he said.

A trader who sought anonymity said the situation is chaotic as the government tries to control the skyrocketing prices, something she said is impossible.

"Even me, whenever I get the sugar, I am forced to sell it at 5,000/- per kilo as there is no other way because despite selling it at this price, we do not get profit," she said.

Recently, Mbeya Regional Commissioner Juma Homera directed all districts to supervise cap prices of the commodity and ensure that it is not sold above 3,000/-.

He wanted leaders in the districts to take stern measures against all traders who sell the commodity at higher price.

> According to him, governments around the world have focused on health and safety issues at workplaces and that everyone should pay attention and invest in strategies to promote a safe working environment.

TAHOSA Chairperson Caroline Balaza said the meeting brought

together number of experts and the government to recognise ocemployers to discuss safer and healthier workplace and later came up with a joint resolution.

"Everyone has the right to work and all workers have the right to a safe and healthy working environment. We should ensure that employees are happy at their workplaces and they get all the required services," she said.

She underscored the need for

cupational health and safety professionals as well as engage them in the improvement of policies in order to achieve intended goals.

Isaack Senya, occupational health and safety manager at Geita Gold Mining Limited (GGML) emphasised the importance of adhering to safety at workplace.

"I advise other companies to participate in meetings like this as they are very important in reminding us of various important things to do in order to have a safer working environment," he said.

David Ongesa, president of the Workplace Safety Professionals Association of Kenya (WSPAK) said the meeting was of great importance and stimulated unity among professionals who have a big role to advocate for healthier and safer working environments.

Call for lifestyle change as overweight fuels NCDs

TANZANIANS have been urged to adopt better ways of cutting down body weight to avoid non-communicable diseases (NCDs) such as diabetes and cardiovascular diseases.

Shreya Shah, a medical practitioner at the Regency Medical Centre made the call at the weekend in Dar es Salaam when speaking shortly after the hospital conducted free health screening for residents of Ukonga area. The free medical screening camp was organized by Ukonga MP Jerry Silaa.

She said that most people who attended the screening were found to be overweight, especially women, adding that they were at risk of NCDs such as high blood pressure and diabetes

She said it is important that people are educated about health lifestyle such as avoiding excessive use of alcoholic beverages and foods with a lot of sugar and salt in order to avoid such diseases.

"We have attended to more than 400 people and we have found that most of them are heavier than their

height, especially women; we have advised them to do daily exercise and reduce consumption of oily and sugary foods," she said.

She asked Tanzanians to develop the habit of listening to advice given by medical experts about health matters.

She asked Tanzanians to also develop the habit of doing exercise every day to avoid NCDs. Alex Ngomola, one of Ukonga residents who attended the camp, said many people he know do not have the habit of testing their health until they are in a bad health condition.

He appealed to health facilities to continue providing screening services to reach many people who do not have financial resources for medical testing.

Maria Gwemela, another

attendee urged Tanzanians to build a culture of testing their health regularly for early diagnosis and treatment of diseases.

"Let's not wait for free testing like what happened today. It is advisable to do general check-up at least once a year because doctors say that early diagnosis means ease of treatment and the vice versa is also true," she said.



Southern wildlife corridor loses 70pc of water sources

AT least 70 percent of water bodies that used to feed the Selous-Niassa corridor in Southern Tanzania have dried up, threatening the survival of wildlife species in

Water sources and rivers have reportedly been disappearing from the precinct between 1990 and the present, according to environmental research to be published soon.

Dr Maria Montero, a researcher from the German International Development Agency (GIZ) who has been conducting studies in the Southern Corridors, points out that the number of elephants within the corridor has also been dwindling.

"Invasion of human activities, including settlements has taken a drastic toll on the elephants' breeding areas," she said recently while presenting a topic on 'Human Wildlife Conflict (HWC) causes and mitigation strategies.'

It was also revealed that the number of jumbos dropped from over 3000 that roamed the Selous-Niassa corridor in the early 1990s down to around 600 elephants as of 2018.

The expert researcher was addressing reporters and writers attending training classes on HWC mitigation organized by the Journalists Association of Tanzania (JET) in association with the GIZ.

Dr Montero listed some of the possible causes as hu-

man and livestock intrusion of wildlife habitats; inadequate land use planning, blockage of animal passages and disregard for advice from experts and authorities.

Isaac Chamba, a conservation officer with the Tanzania Wildlife Management Authority (TAWA), said that cases of HWC increase by over 23.76 percent annually, with effects of climate change also being among the contributing factors.

"As far as data from TAWA stations are concerned, the rate of damaged crops averages at nearly 120 percent every year," he said.

The Selous-Niassa Wildlife Corridor which extends for a total of approximately 160 to 180 kilometres in length, following the Ruvuma River is an important corridor mapped within the international Trans-Frontier Conservation Area (TFCA).

It is one of the largest TFCA in Africa, covering approximately 154,000 square kilometers.

Two thirds of the area is mapped within the Selous-Nyerere ecosystem, forming the northern component of the TFCA which measures 48,000 square kilometers and happens to be Africa's largest single protected

The Selous Game Reserve is also one of Africa's oldest formally protected areas, dating back to 1896.

Its counterpart, the Niassa National Reserve, across the border to Mozambique is the country's largest conservation area and covers a total of 42,000 square kilometres.

Project now seeks to protect endangered migratory birds

MOST communities in Kongwa and Mpwapwa districts in Dodoma Region lack awareness about biodiversity conservation, derailing efforts to protect white stork, one of the rare species of birds found in the two districts, it has been said.

Neema Mwaja, Nature Tanzania Project Officer at Kongwa Field Office, told journalists here at the weekend that white storks are migratory birds which migrate from Europe, especially Germany to Africa including Tanzania.

Mwaja said that the origin of white storks is Europe but they normally move from the continent during winter season when the food becomes scarce to Tanzania between December and February in search of food, especially insects like caterpillars.

They fly back to Europe in March. She said when the white storks migrate from Tanzania they pass through Kenya, South Sudan, Israel and finally to Germany, and while in Europe, they lay eggs and hatch chicks. According to her, the number of white storks in Kongwa and Mpwapwa was more than 600 last year but currently there are only 100 white storks due to their migratory behaviour.

"Low awareness about biodiversity conservation makes area residents kill them with poison either for business purposes or food. In collaboration with other stakeholders, we have already started educating the communities about the importance of such birds," she said.

She said they once took samples from killed or poisoned birds to the Government Chemist Laboratory Authority (GCLA) for investigation and the results showed that the residents

of Kongwa and Mpwapwa face the risk of contracting diseases by eating poisoned white storks.

She said that Nature Tanzania is committed to changing the behaviour of killing birds illegally. In this regard, the organisation supported communities to establish income generating activities as an alternative way to stop the illegal killing of birds.

Mwaja further noted that communities were supplied with 50 beehives, honey harvesting gear and honey processing machines. According to her, the micro-project enabled the communities to harvest more than 400 kilograms of honey in two rounds of production.

Other groups, including the youth (previous hunters) were supported to form two football teams and established poultry projects alongside piggery. She said that there are also programmes being implemented at school level involving primary and secondary schools, aimed at educating pupils and motivating them to become ambassadors of biodiversity conservation and environment protection. "Our project runs bird-watching and tree nursery programmes in six schools. In addition, the communities were provided with 15,000 seedlings to plant at their homes and open spaces as part of landscape restoration," she said.

Mwaja said the conservation of white storks in Kongwa and Mpwapwa in Dodoma started in 2021 in four villages, two in Kongwa and the other two in Mpwapwa.

She said Nature Tanzania commends its stakeholders, including offices of district commissioner in Kongwa and Mpwapwa, Tanzania Forest Service Agency and funders NABU International Foundation and Sustainable Health Initiative.

TOSCI officials calls on farmers to use quality seeds for increased yields

FARMERS have been urged to adopt modern farming practices which involve use of quality seeds approved by the Tanzania Official Seed Certification Institute (TOSCI) to increase yields and incomes.

Zera Mwankemwa. Ouality Control Officer at TOSCI, made the call here at the weekend during a training session for journalists on how to use their profession to promote the importance of quality seeds.

She said use of seeds which are of low quality leads farmers to get little harvests and thus affecting their economy and development in general.

"Many farmers are still reluctant to adopt new and quality seeds; they still rely on normal traditionally preserved seeds which eventually do not reward them during harvests. So, it is important for them to change their mindset and start using seeds that are certified by TOSCI," she said.

She said that farmers who use TOSCI-approved seeds can get between 13 to 15 sacks of maize weighing 100kg per acre while traditional seeds produce between two to three sacks. Joseph Pagu, another Quality

Control Officer at TOSCI urged farmers to be careful when purchasing seeds as there are others which are counterfeit.

"It is important for farmers to verify if the seeds have been approved by TOSCI and this can be done through mobile phone by entering special numbers which are found on the seed bags by typing *148*52# and following instructions," he said.

Experts validate occupational standards for crucial sectors

MORE than 100 experts from government institutions, including Technical and Vocational Education and Training (TVET) met here for two days recently and validated occupational standards for five key sectors of the economy.

Rutayuga said the workshop reviewed and endorsed and joint diploma programmes between Chinese and the developed work standards to guide vocational Tanzanian institutions.

education and training in the preparation and implementation of programmes that meet the needs of the labour market and the country's economic agenda.

The occupational standards cover five sectors namely construction, transport, energy, agriculture and information and communications technology, he said, adding that occupational standards are crucial in Tanzania as the country is currently building an industrial economy that requires many qualified and skilled workers.

Zhang Yujia, acting country director for Sunmaker Tanzania, said the organization aims to develop skills for African youth and began partnering with NACTVET in 2022 to carry out a series of projects.

Zhang said the projects include the revision and development of occupational standards and programme development standards, the development of curriculum, the digitalization of TVET teaching and learning materials, capacity building for TVET leaders and staff and joint diploma programmes between Chinese and Tanzanian institutions.

Rwanda arts festival showcases importance of African culture

A NEW arts festival launched by Rwanda provides a platform for African artists and curators to explore new narratives and build relationships while highlighting the vibrancy of the African cultural scene.

Organized by the Rwanda Arts Initiative (RAI) art center and the Rwandan Ministry of Youth and Arts, the Kigali Triennial is a pan-African event that weaves together literature, theater, dance, music, cinema, fashion, digital arts, gastronomy and design.

The festival, themed 'Where art, knowledge and business converge' ran from Feb. 16 to 25 in the Rwandan capital of Kigali.

"A festival like this provides a platform for the young generation to find the sweetness and beauty of African culture in what is performed, including cultural dances," James Mazimpaka, a Rwandan actor and writer, told Xinhua in an interview.

"I hope to meet so many artists from all over the world that I can get something from them, and they can get something from me.

It is two-way. Let's build our lives around art; art is our life, and our life is art," said Mazimpaka, who also acts as an art mentor.

With more than 200 artists from 25 countries performing in 60 shows, the festival is a celebration of African excellence that also seeks to showcase Kigali as an emerging cultural capital.

Mazimpaka, who claimed he was born an actor, believed that while one can be an artist by their work, their culture is still their identity. "There is richness in our culture. There is a need to expose the young generation to African culture."

According to Sandrine Umutoni, Rwanda's minister of state for youth and arts, hosting the festival demonstrates Rwanda's appreciation of the vital role of the arts in youth development, its importance in creating bonds, and its contribution to the overall enrichment of society's cultural heritage.

The festival, the first of its kind, was initiated to educate not only the public but also professional artists, said Jules Cezar Niyonkuru, one of the organizers.

"It's an art market that will take place every three years to unite all of Africa and all disciplines. What we are trying to achieve is professionalization, building bridges with people who are here," said Niyonkuru, who is also an author, actor and theater director. "People learn not only about their own culture but also about other people's cultures. They also learn practical skills that they can use in their own careers after the festival."

ANC launches manifesto ahead of May elections

SOUTH Africa's President Cyril Ramaphosa on Saturday highlighted the achievements of his African National Congress, which has ruled the country for all of its 30 years of democracy, as it heads into a tight race in May's elections.

Ramaphosa delivered the party's manifesto to thousands of ANC supporters at the Moses Mabhida Stadium in Durban. The rally came as South Africa faces increasing poverty, unemployment and crime as well as a crippling electricity crisis.

Party supporters dressed in yellow, green and black party regalia packed the stadium and sang struggle songs praising Ramaphosa and the ANC, while others took advantage of the event to sell food, refreshments and party merchandise to the thousands attending.

A procession of motorbikes with bikers waving ANC flags was among the first displays to entertain the crowd before Ramaphosa arrived to the delight of supporters

However, the tension surrounding this year's elections was laid bare when some supporters entered the stadium grounds carrying a caricature coffin bearing the name of the uMkhonto we Sizwe political party, a new political organization formed by former ANC president Jacob Zuma.

The party is set to compete in this year's elections after Zuma denounced the ANC.

In what has become somewhat of a popularity contest between parties to show who can pull in the biggest crowds to their election rallies, thousands of ANC supporters were bussed in from various parts of the country to ensure the stadium was full as early as possible.

The ANC also brought in popular musicians to entertain supporters. They performed after Ramaphosa's speech, concluding with ANC slogans and colourful fireworks and confetti.

However, millions of South Africans will likely be more interested in whether the ANC can deliver on its promises and address the many challenges the country faces. These include stagnant economic growth, rising levels of poverty, unemployment, crime and a crippling electricity crisis that has resulted in rolling power blackouts.

According to Ramaphosa, the ANC plans to create more than 2.5 million job opportunities in the next five years. He said some of these would come from South

Nigerian health team visit reason for hope

given to a vital sphere of government policy and project implementation, in the visit by a state level Nigerian delegation arriving in the country to learn how Tanzania has succeeded to reduce maternal mortality rates.

The Health ministry permanent secretary welcomed the delegation saying that Tanzania feels happy to receive the team as is ready to share information and experience how the country managed to reduce maternal mortality. It was uplifting.

Background data show that the Tanzania Demographic and Health Survey and the Malaria Indicator Survey for 2022 show that maternal mortality went down to 104 deaths per 100,000 live births in 2022, from 530 deaths per 100,000 live births in 2015/2016. This is a space of six to seven years, and the reduction was roughly three quarters of the rate, quite at variance with practically all other indicators put together. Why isn't stunting being drastically cut out as well, not to add poverty?

The key explanation provided for this achievement by the Health ministry top executive was the strategy to reduce maternal and child deaths via the M-mama emergency call system.

It is described online as an affordable emergency transport service that connects mothers and newborns to vital life-saving healthcare in the rural areas.

That explains plenty of the reduction in deaths definitely, but earlier data at around 2009 had shown that maternal and newborn deaths were too high in coastal regions, even when dispensary or health centre facilities were just nearby.

Introducing an emergency call system and being aware of how certain of our emergency services operate is at best a mitigated answer. and it is hard to credit it with a 75 per

A SORT of vindication has been cent reduction in fatalities arising from complications of giving birth.

More than this there was auxiliary praise of creativity and investments in fighting maternal and child deaths, which it is plainly uncertain if it will convince the visiting team and any who may seek to inquire.

The data may have meanwhile to be scanned for possible errors, considering the fact that the period 2016 to 2022 at the least was characterised by a situation where independent actors can't issue data that can be used in the media. One could fear systematic data failure.

Still, there are pieces of data that reasonably complement an impression of a drastic change in birth complications and fatalities, even without authenticating official figures.

One is the huge change in budgetary sums provided to the Health ministry for a number of years after the change from 74 per cent recurrent expenditure to 61per cent, and development funds raised from 26 per cent to 39 per cent. Health notably benefited.

In a way, the top-level Health ministry officials receiving the Nigerian team may not be in the best position to explain the situation as they appeared to the working on the basis of what was being done during the current phase of government even as the database ends 2022 and thus relates to five previous years at most.

While it is somewhat misplaced in relation to the 2022 data, emphasis on the post-2021 situation adds crucial material in another direction.

That is as to how the maternal deaths turnaround was achieved well before the 2021 International Monetary Fund disbursements for post-Covid 19 recovery were obtained. It is from the funds that numerous health centres came up, and the maternal health impact be noticed two to three years from dis-

Reversing 50 pc stunting rate requires vast food price shifts

CERTAIN appeals often issued to the public, public authorities or at times the diplomatic community, the latter usually referred to as international community, resonate not with what can readily be done but rather with desperation.

This is for instance the case when authorities in Rukwa Region issue a strident appeal to development stakeholders to help address stunting in children which is as high as 50 per cent. The key issue there is to factorise the stakeholders suggested, and one finds it hard to think that it is international aid groups they had in mind, not local practi-

Usually the term 'development partners' refers to aid agencies, while 'stakeholders' is more general and includes local parties to this or that need. But when the local partners or stakeholders come up, the reference is more or less commercial in character, as stakeholder is someone who has something to gain from the sort of activity being suggested.

When the issue is to help reduce a high rate of stunting of school age children, starting five years, commerce isn't at issue; rather, donations. Top regional officials say the region has a 50 per cent stunting rate, noting also that it is higher than the national average of 30.4 per cent, and a 19.4 per cent malnutrition rate compared to the national average of 12 per cent.

Overweight rate stands at 3.2 per cent against 3.5 per cent national average; underweight rate stands at 8.3 per cent while nationally it is 3.2 per cent.

There is alarm in a number of those figures, but the issue is whether the solution lies with outside stakeholders or within the confines or Rukwa Region.

The situation in the region, which is a broken mirror model for Tanzania and Africa as a whole, shows in a graphic manner what is actually wrong not with agriculture as such but with the wider economic

Stunting is a result of sheer lack of a balanced diet for a child, which sharply reminds one of a family where children take porridge in the morning or tea without milk and a sprinkling of sugar, lunch or supper essentially backed by thin vegetables and scant protein.

Fruit is no longer something to be taken for granted as in the past where the land was much greener and the population much smaller than at present. It is easy to think this up.

That is why it sounds a bit like a joke when the regional authorities remind one and all that Rukwa Region is one of the top seven regions for producing grains and other food crops. It was ranked second for food production in the past farming season but it is still experiencing severe stunting, while other data produced like clinic attendance by expectant mothers stands at above 90 per

Children vaccination is more than 90 per cent but stunting is prevalent, which implies that these aren't the key issues put purchasing power, ownership of produce and how the cash is used especially by household heads. There is some stunting there too.

The RC painted a bleak picture as regards an educated path ahead with mass Std VII failures in the region, but left some shaking heads in The Guardian Limited Key Contacts



Time is now to act against false election promises and grandiose manifesto claims

"If elected, I promise..." This coming from political parties sounds more like an oath of office, and it is not unreasonable for the voters to expect the promises to be fulfilled.

But is the fulfilment of these election promises a lived reality? "Despite being written in black and white, circulated in public, election manifestos do not have any legal implications on political parties, which results in flowery promises being made by parties to gather votes, often forgotten after elections."

These words are by Ragini Kanungo, published in the Indraprastha Law Review. The observation in the article that "in absence of proper regulation, election manifestos have been reduced to rhetoric documents aimed at manipulating marginalised, gullible populations by promising temporary benefits in the name of 'freebies'" resonates profoundly.

The exploitation of voters through election manifestos remains distressingly common. Political parties often make promises in these manifestos with the intention of wielding significant influence over the voting popula-

Blatant lies and populist rhetoric

However, many of these pledges amount to nothing more than blatant lies and populist rhetoric, specifically targeting frustrated and vulnerable communities.

With each passing election cycle, the landscape of promises grows increasingly bleak, inundated with empty pledges and unfulfilled commitments. From grandiose vows of ending load shedding, providing sustainably free education, eradicating unemployment and poverty, to lofty aspirations of ending corruption, the gap between rhetoric and reality widens, leaving citizens disillusioned and disheartened.

South Africa's recent descent in international rankings, particularly in perceptions of corruption within the public sector, further compounds the crisis of governance. As our nation finds itself categorised among flawed democracies, teetering precariously close to non-functioning regimes, concrete actions must replace hollow promises to restore faith in our democracy and governance.

In our fledgling constitutional democracy, founded on the principles of human rights and freedoms, the proliferation of false campaign promises has emerged as a formidable challenge. This troubling trend has contributed to a pervasive distrust of political speech, depriving voters of the accurate information necessary to make informed

political choices.

Tainted by deceit

When campaign rhetoric is tainted by deceit, it stifles genuine dialogue and deprives citizens of the opportunity to engage in meaningful discussions about the future of our nation.

Ethicist Prof Sissela Bok, makes a telling argument about the negative psychological consequences that political lies and false promises have on voters in her 1978 book, Lying: Moral Choice in Public and Private Life.

According to Bok, "voters and candidates alike are the losers when a political system has reached such a low level of trust. Once elected, officials find that their warnings and their calls to common sacrifice meet with disbelief and apathy, even when their cooperation is most urgently need-

"The fact that candidates, should they win, are not expected to have meant what they said while campaigning, nor held accountable for discrepancies, only reinforces the incentives for them to bend the truth the next time, thus adding further to the distrust of the voters. Political lies, so often assumed to be trivial by those who tell them, rarely are... When political representatives or entire governments arrogate to themselves the right to lie, they take power from the public that they would not have been given up voluntarily."

Admittedly, my proposal that

"failure to honour election manifesto promises should be deemed an unethical, if not illegal, act" will, in a country like ours, need many years to be taken seriously.

Crucial need

In light of recurring issues with unfulfilled election promises, there arises a crucial need to contemplate some level of regulation regarding election manifestos. While acknowledging the potential challenges and backlash associated with such regulations, it is essential not to be discouraged.

The Supreme Court of India, for instance, in 2013 directed the Indian Electoral Commission to frame guidelines on election manifestos to be included as part of their Model Code of Conduct.

After three decades of democracy in South Africa, the recurring cycle of elections and unfulfilled promises has eroded public trust in the political process. It's imperative for the Independent Electoral Commission (IEC) to embark on a comprehensive review of the Electoral Code of Conduct.

This review should prioritise the inclusion of provisions that establish clear guidelines on election manifestos. By delineating specific criteria for election manifestos, such as feasibility and accountability, the revised Electoral Code can ensure that political parties commit to realistic and achievable promises.

Electoral credibility the bed-

rock of trust

It is a fact – the credibility of electoral promises forms the bedrock of citizens' trust in their leaders. However, when politicians make false pledges during election campaigns, it undermines this trust and erodes the very foundation of democracy.

Beyond the immediate impact on voter disillusionment, such deception often leads to a domino effect, resulting in the failure of governments to deliver essential services and meet the needs of the

From infrastructure development to fiscal security, the repercussions of broken promises reverberate throughout society. The prevalence of false election manifesto promises not only threatens the legitimacy of democratic institutions, but also hampers effective governance and service delivery, ultimately jeopardising the wellbeing of citizens.

While the road ahead may be daunting, it is important that we confront these challenges headon. By demanding accountability, transparency, and ethical leadership, the populace can reclaim the promise of a better future for all South Africans. It is time to have formal election manifesto guide-


At the beginning of the Chinese New Year, the medical team aiding Tanzania received a letter of thanks from families of local patients.

Students from Bwiru Girls Secondary School, Kitangiri Secondary school, Mnarani Secondary School and Bwiru Boy's Secondary School answered the questionnaire.

"During a visit at MWAUWASA, different data was collected whereas we collected data. The official demonstrated to use on how water is treated and purified," said Philipo.

Two years into Russia's onslaught, tired Ukrainians refuse to give

'translates as 'crooked horn', but President Zelensky calls Kryvyi Rih his 'big soul and heart'. He credits this gritty, industrial city with moulding his character. He grew up in a sprawling block of flats known as the Anthill.

When you stand in front of this towering structure, Volodymyr Zelensky's journey from this setting to wartime leader feels remarkable.

"I want the war to end soon," says Vita, who lived near Zelensky's parents. "He's a normal, good guy who fights for people. I just want this war and the sirens to end sooner."

But with minimal Ukrainian progress and growing Russian dominance, there is no end in sight, and that's both fuelling and being fuelled by influential pockets of Western doubters.

At the recent Munich Security Conference, President Zelensky told delegates not to ask Ukraine when the war would end, but instead to "ask why Putin is still able to continue it".

With blocked military aid now directly hampering his forces on the front line, it was a swipe at those delaying the ammunition and weapons his soldiers desperately need.

We must fight; we won't tolerate anything else.

"I'm no politician," confesses Valeriy, a man in his 80s perched outside a grocery shop. "We can't ask when the war will stop again.

"We must fight; we won't tolerate anything else. People are so angry now."

That appetite to defend has remained mostly intact since that morning on 24 February 2022. Against a terrifying unknown, people volunteered in their thousands to join Ukraine's fight.

The world's gaze turned to Kyiv, from where I was reporting.

President Zelensky's profile and popularity went stratospheric as he turned down offers of evacuation and remained in Kyiv.

"I need ammunition, not a ride," he said in a now

His needs have not changed, but his pleas have lost their electrifying impact.

of liberating its territory.

Republican doubters in the US are hindering Ukraine's ability to fight by blocking billions of dollars' worth of military aid. Kyiv says more frontline troops are dying as a result of weapon shortages and dwindling ammunition.

All the while, Russia has remained on a war footing, and its allies North Korea and Iran are supplying more missiles to rain down on Ukrainian cities.

Kryvyi Rih isn't immune to the fatigue most of the country feels. Some have had enough of this war, many men are fearful of being conscripted, and yet they say the conflict is still a fight for survival.

The idea of a compromise or concession to Russia is viewed as a defeat. It's existential.

In a symptom of the world Ukrainians live in, I now as-

The last time I saw children play in one was at a school next to my flat in Kyiv, before the invasion. Now they are the site of a devastating missile strike, lying abandoned on a front line, or in Brovary, near Kyiv, the scene of a helicopter crash. Youthful innocence replaced with body bags and destruction.

In Kryvyi Rih, we meet a tearful Yuriy as he watches his flat get demolished after a missile strike last year. Exposed wallpaper patterns reveal the different lives destroyed.

"No one needs this war, what is it for anyway?" he asks. "So many people are being killed." So, does he think Ukraine should swap territory for

"Definitely not," he replies bluntly. "A lot of people died

for those territories. There is no point in giving them up." The lack of battlefield progress caused a corrosive rift be-

tween President Zelensky and the head of his armed forces Valerii Zaluzhnyi. Now sacked, General Zaluzhnyi is seen as a potential political rival to his old boss.

Around Kryvyi Rih, Ukrainians try to help where their country's allies increasingly will not. In one inconspicuous building, a growing army of volunteers stitch camouflage nettings for troops on the front line.

The men and women are kept separate because of "their different jokes," explains the organiser.

In another industrial wing of the city, a former bike club has swapped cycling for smoke. Teams mix chemicals into canisters which will become smoke grenades. A useful military tool if you are trying to attack, or evacuate the injured.

"It's impossible to stay at home with my thoughts when my husband is fighting," explains Ines, one of the volunteers. "Here I feel I can do something to make it easier for them."

Russia's decade of aggression towards Ukraine began with the annexation of Crimea in 2014 and then spilled into a draining war in the country's east. On the 731st day of the full-scale invasion, it's a different kind of war.

While extraordinary, Ukraine's successes in defence and degrading Russia's navy have not changed the tide in its favour.

The novelty of this war has gone. Ukraine, Kryvyi Rih and its famous son will need to find new reserves of strength and a clever playbook to keep the world engaged.

Like cigarettes, junk food should come with a warning: 'Can kill'

HE 1970s was a confusing decade in which to be a smoker. People knew, of course, that smoking was bad for them: the evidence linking vertible since 1956. But despite government education programmes, hiked taxes and restrictions in selling to children, these warnings hadn't fully permeated the atmosphere.

How could they? Daily life bathed the brain in the idea that smoking was fine. Cigarettes were advertised in magazines, on billboards and at sporting events; they dangled from the mouths of the suave or rebellious in film and on TV; and a nicotine fug enveloped offices, bars and public transport. Could something that everyone was doing, and which suffused the culture, really be that shockingly dangerous?

It was a confusing time, also, to be a tobacco company. You could no longer claim that smoking was supported by doctors, as you did in the 50s - but you were not yet forced to admit on every packet that your product actually killed people.

It was only in the 80s and 90s that, festooned with obligatory warnings, cigarette ads started to flirt openly

with death: one advert for Silk Cut referenced the shower scene in Hitchcock's Psycho, another for Benson & Hedges featured a dead fish on a coffin-like piano. (If you're going to die, die with us.)

But in the 70s these companies it to lung cancer had been incontro- were still making the uneasy transition between denial and nihilistic acceptance. The idea that you could make cigarettes healthier, that you could acknowledge the warnings but claim they did not apply to your own product, became a central defence and marketing ploy.

switched to "low-tar" cigarettes in an effort to make a healthy choice.

to either quit or smoke True. I smoke True" ran one advert in 1976, featuring a sporty-looking girl at a tennis net - "The low-tar, low-nicotine ciga-

New "filter" cigarettes (themselves sometimes tainted with dangerous chemicals) flooded the market. falsely claiming to protect against the worst harms of smoking. Thousands

And this is where we are, I think, in 2024, with what used to be called junk food, and which is now beginning to be called ultra-processed food. UPF is food that has at some stage been ground into unrecognisable pulp and bathed in additives, a



definition that is gaining acceptance among experts.

But it is nothing too new. We are now, and have been for years, talking about the kind of food that encourages us to eat vast quantities of salt, sugar and fat in one barely chewed gulp. It is hamburgers, crisps, chocolate bars, ice-cream, fizzy drinks and pappy processed ce-

As with cigarettes in the 70s, much of the evidence is in. Junk food is linked to cancer. Two landmark studies last year showed UPFs caused heart disease and

It is also beyond question that these kinds of foods cause obesity, a condition linked to 30,000 deaths a year in England alone. One in five children are obese by the final year of primary school and levels of obesity are spiralling upwards. Unhealthy diets are, worldwide, now killing more people than tobacco.

But these warnings have yet to filter through to our

daily environment, in which junk food is beamed at us from bus stops and TV ad breaks - framed as an indulgence, a guilty pleasure, but not a scourge.

Our brains, evolved for scarcity, navigate a world of cheap, easy, delicious dopamine hits on high streets and supermarket aisles. Fast food companies follow teens online and use cartoons to sell unhealthy cereals. Last week, an 18-year-old told the Times that, when she got her GCSE results, she was congratulated by the pizza chain Domino's before her mother.

Last week, the youth activist movement Bite Back published its study Fuel Us, Don't Fool Us, developed with researchers at Oxford University, and reported that Ferrero made 100 percent of its UK sales in 2022 from foods high in saturated fat, salt and sugar (HFSS). In response, a company spokesperson claimed it

was "supporting consumers" by "offering our products in small, individually wrapped portions" along with

"education on how to enjoy our products as part of a balanced lifestyle". Are you really supposed to stop after a single (wrapped) Ferrero Rocher?

Unilever, which the study found had made 84% of its UK sales from HFSS the same year, stressed its lower fat options: "Ben & Jerry's Lighten Up, Carte D'Or Vanilla Light". The owner of Kellogg's, just behind at 77 percent, told reporters it had reduced sugar in its cereals by 18 percent, and salt by 23 percent.

Yet these are foods saturated in unhealthy substances and designed to make you eat more and more of them. Removing 18% of the sugar is going to do very little. There is no such thing as healthy junk food.

We know what has to happen next: tobacco has given us the blueprint. Food high in salt, sugar and fat has to be more strictly regulated.

And regulation is the only way. Highly processed food is profitable - the business models of the world's largest food companies rely on it. Expecting them to fix themselves is like expecting a tired and hungry commuter to resist a burger. Good intentions and willpower go only so far.

But the psychological shift - the recognition that this thing that everyone does is dangerous - is overdue. Every government for the past 30 years has identified obesity as a problem. Even food companies - some of them - are asking for new legislation: at present, they say, retailers that want to do good are penalised.

Labour claims it will "steamroll" the food industry into a healthier model, banning online junk food ads aimed at children and bringing in more restrictions on packaging. It would be a start.

Access to bicycles improves lives of women, girls in rural Zambia

MPONGWE, Zambia

OVER the years, bicycles have emerged as a catalyst for change, offering newfound independence, opportunities, and freedom to many women and girls in rural Zambia.

One of the places in the country that has seen a rise in the number of women and girls using bicycles as a means of transport is Mpongwe, a district in Copperbelt Province. It is common to see women and girls riding

bicycles in Mpongwe, a predominantly rural community.

Charity Chanda, a 37-year-old vegetable trader, said owning a bicycle has transformed her life and enhanced her business.

"Before, I would walk for hours carrying heavy loads of vegetables to the market, often missing out on potential buyers," she said. "Now, with my bicycle, I can transport my produce quickly and easily, reaching more customers and increasing my income."

She said more and more women in Mpongwe are investing in bicycles as a means of effective and reliable transport.

For Alice Musanshi, 35, a homemaker, owning a bicycle allows her and her family to access healthcare services faster and run daily errands with more ease.

"I can make sure that my children get thing of the past."

healthcare services when they fall sick or need to go for vaccinations at the health facility. I also use the bicycle to go and attend community meetings and for my grocery shopping," said Musanshi, a mother of five.

Owning a bicycle has boosted her confidence and instilled in her a sense of self-reliance, she added.

"In years past, it was only men that were allowed to own and ride bicycles," Musanshi said. "Today, women are working hard to save money so that they, too, can own bicycles."

"A bicycle is not just a mode of transport; it is a pathway to a better future for women and girls," she said.

And Theresa Bwalya, 15, radiated enthusiasm as she recounted her daily journey to school on her bicycle.

"With my long commute to school, having a bicycle has not only reduced the time it takes me to get there but also increased my punctuality and concentration in class," she

Since she started cycling to school about a year ago, her grades have improved tremendously, Bwalya said.

"I used to feel tired as a result of walking long distances. That affected my performance in class," she said. "But that is now a


Rice researcher using statistics to shed light on the untold story of Lake Chad

LONDON

WHILE governments and international authorities have pushed a narrative by which the lake is drying out due to climate change, there is a lack of published data or studies to support these claims. This was the impetus for a team of researchers from Rice University and Imperial College London to develop an innovative approach to studying and telling the story of Lake Chad and its agrarian people – using statistics.

Frederi Viens, a professor in Rice's Department of Statistics, and Philip Ernst, chair in statistics and Royal Society Wolfson Fellow at Imperial College London (and formerly a professor at Rice), are the recipients of a grant from the British Academy and the Wolfson the Lake Chad Basin.'

During their three-year research project, Ernst and Viens will study how the Lake Chad Basin's farmers and pastoralists in Northeast Nigeria have operated over the long term and dealt with difficult circumstances, including devastating droughts in the 1970s and 1980s. In particular, they will look at wheth-

population and potential for adverse climate events grow.

been an endemic problem since Boko Haram, one of the world's most notorious terrorist groups, started operating in the region two decades ago. But that should not be a carte blanche to make up narratives based on no evidence. Our connections with Nigerian officials and academics will facilitate this work."

The research team will work with African colleagues and local stakeholders, including village chiefs and elders, as they create a comprehensive climate and agriculture dataset and analyze it using probability models and Bayesian statistics. Their primary collaborators in Africa include: Udo Herbert, deputy vice chancellor (academic) and professor of animal physiology at Michael Okpara University of Agriculture in Umudike, Nigeria; Dennis Ikpe, research associate at the African Institute of Mathematical Sciences in Cape Town, South Africa, and data scientist in the Office of Institutional Research at SUNY Binghamton in New York, United States; and Bethel Ukazu, project team leader at Thels Impact Consulting, a development cooperation firm in Abuja, Nigeria.

They plan to bring into the discussion other academics with whom Viens has been in contact over the years about agrarian lives in the Lake Chad Basin, including Nigerian research specialists in meteorology and in natural resources and members of the G-EAU water resources research group at the Institute for Development Research in Montpellier, France.

Ernst and Viens are currently working with Herbert, Ikpe and Ukazu to organize a unique symposium on agrarian lives in the Lake Chad Basin. It will be held at the University of Maiduguri in Northeast Nigeria's Borno State May 7-8. This meeting will bring together academic researchers, government officials, members of the development economics community and local rural stakeholders including village chiefs and elders. A main objective is to provide a forum for academic and professional actors to listen to these villagers' stories and accounts and understand more about day-to-day living in the Lake Chad Basin's rural communities in Nigeria.

Ernst and Viens hope their research will provide new insights into this understudied region for its more than 30 million residents who rely on the lake's basin as part of their livelihood.

Call for scaled up funding for much-needed and successful joint programme in Nigeria

NIGERIA is home to 15 percent of the world's out-of-school children. More than 7.6 million girls are not in school, and only nine percent of the poorest girls in the country are in secondary school. The Boko Haram insurgency and other armed groups fuel the out-of-school crisis in northeast Nigeria, disrupting the education of nearly two million school-age

Grave violations of children's rights prevail in north-eastern areas, including the abduction of thousands of children and young people; girls are enslaved and sexually exploited, and boys forced to become child soldiers.

Education Cannot Wait (ECW) Executive Director Yasmine Sherif visited communities affected by the conflict and interconnected crises, witnessing first-hand the positive impact of ECW's initial Multi-Year Resilience Programme (2021-2024).

"We visited a primary school, a transitional centre for boys that fled Boko Haram areas, and one non-formal education centre that provides vocational skills training. We have seen the power of holistic education to rehabilitate and reintegrate boys who have fled from Boko Haram areas back into society. ECW and partners, the national Ministry of Education, the Federal State Government, local organizations, teachers, students, and psychologists are all working hand-in-hand, leveraging education to heal children from traumatic experiences-providing them with better life prospects," said

Sherif met with senior government officials, including the Minister of Education, Dr. Tahir Mamman, and Borno State Governor, Prof. Babagana Umara Zulum, and aid partners, all working to ensure the right to education for boys and girls. She stressed that ECW's expanded funding for crisis-affected girls and boys in north-east Nigeria is "an investment in a more stable, prosperous, and peaceful future for the whole region. ECW's plans to continue providing safe, quality holistic education and learning opportunities towards protecting children and youth from exploitation-empowering them to achieve their dreams of touching humanity."

Sherif was also accompanied by a high-level delegation from UNICEF and the governments of Germany and Norway. Germany is ECW's leading donor with USD 366 million in total contributions, and Norway is the Fund's fifth largest donor with total contributions of USD 131 million. Building resilient education systems is both critical and urgent for Nige-



ECW's initial Multi-Year Resilience Programme, delivered by the Norwegian Refugee Council, Save the Children, and UNICEF, has consistently achieved its targets, and has so far reached nearly 500,000 children and adolescents with quality, holistic education in areas affected by the crisis in north-east Nigeria.

"We need additional funding to reach all two million children in north-east Nigeria and end the out-of-school crisis. Meanwhile, the rest of the world cannot wait-we have dire needs in the Middle East, the refugees in Latin America, across the Sahel region, and in the Sub-Saharan Africa region, where nine in 10 children cannot read simple sentences," Sherif emphasizes.

"ECW appeals for additional strategic donor

partners-governments, the private sector, philanthropic foundations, and high-net-worth individuals-to join our efforts in mobilizing an additional US\$600 million to reach our target of US\$1.5 billion for ECW, allowing our partners to reach, by 2026, a total of 20 million girls and boys in crises-affected areas of the world quality education."

Dr. Heike Kuhn, Co-Chair of the ECW Executive Committee and Head of Education Division at Germany's Federal Ministry for Economic Cooperation and Development, agrees, saying that building "resilient education systems for increased access to inclusive, quality, and lifelong learning is crucial for Nigeria, as half of its population are children and youth. and letting them participate in building peaceful, sustain-

Merete Lundemo, Co-Chair of the ECW Executive Committee and Special Envoy for Education in Crisis and Conflict for Norway's Ministry of Foreign Affairs also emphasized that education is a lifeline for crisis-impacted children and that education projects bring much needed relief and normalcy to children in affected areas. Welcoming strengthened cooperation with ECW to ensure that no child is left behind and that this is part of Norway's wider engagement for children living in armed conflict.

"This joint program and the education needs and dreams of Nigeria's crisis-impacted children align with the African Union's call on all governments to ensure that all children access quality education, officially declaring 2024 as the 'Year of Education.' We must all come together with urgency and commitment to make this a reality for the poor, vulnerable children in Africa living on the margins of abject poverty, fleeing from the traumas of violent conflict and interconnected crises," Sherif

The delegation also met with survivors of conflictrelated sexual violence who are co-creating a new innovative project launched by the Global Survivors Fund with funding support from ECW. The initiative provides formal and non-formal education as a form of reparation for survivors of conflict-related sexual violence and their children. The expanded funding for the planned Multi-Year Resilience Programme shall build on ECW's \$23.6 million investments in the north-east of Nigeria since 2018. The investments are delivered in partnership with the Ministry of Education, UN agencies, and international and local civil society partners.

With a focus on building lasting solutions applying the humanitarian-development-peace nexus, ECW investments in the north-east of Nigeria have provided children with learning materials, supported teacher training and incentives, school feeding, provided essential mental health and psychosocial support for girls and boys impacted by the conflict, and worked with national authorities to get children back to school through permanent Educating children means changing their lives community-based programmes.

ITH the growing technology, Eng Alpha Mbennah, a resident of Dodoma City in Dodoma Region has developed a computer programme that can help in education system, all the way from primary to university levels.

The 'SPIN-ED Academic Performance Management System', is a computer program and electronic tool, used mostly by educators from primary/elementary level till university levels.

According to Eng Mbennah, SPIN-ED does the academic data processing for each student whereby the program allows for an educator from any of the aforementioned levels, to collect and enter student data, for every student that has been registered on the system.

Upon receiving this information, the program takes the entered data, processes it by auto-creating 'weighted' or 'unweight averages, it then auto-determines a letter grade that each of the marks falls for example A,B, C, D, among others.

The auto-determines the class average, for the corresponding class (es) that the students are in and auto-determines the position of each student, the position for each student, per subject as well as the overall position in class, for each student.

The 35 years old engineer said the system auto-generates academic progress report cards for every student registered on the system, for every class. It autocomments on the report cards for every student with regards to their academic performance.

At the same time, it provides autographs to display academic performance view at a glance for every registered student.

"All the things mentioned, are done automatically and I find it necessary to point out that these are (only) some of the features that

SPIN-ED has, and it is important to note that they each have great significance when it comes to academic performance processing", said Eng Mbennah.

Furthermore, the methods employed by SPIN-ED to do all this work,

g- facilitate the work of teachers and other (various) education stake-holders, helping them to make informed decisions about academic affairs and ultimately increasing efficiency in terms of teaching and learning techniques.

On the storage of pupil/student academic data the SPIN-ED pro-

gram can be easily linked with various cloud storage units/facilities, for proper storage of academic data, for many academic years; an estimated 200 -250 academic years' worth of data storage.

Some of the benefits of SPIN-ED include enabling teachers/edu-

include enabling teachers/educators to generate accurate and/ or correct reports and shed some light to the educator(s) with regards to how he/she can employ strategies or techniques that would enable pupils/students to excel academically.

The system is also intended to help save time when it comes to the creation of reports and to encourage the educator(s) to assess the understanding of their students regularly

It also guides, ensure and create fairness when it comes to creating academic results as well as increase awareness and awaken competition when it comes to the use of technology in education globally.

According to the engineer it also

facilitate the work of teachers/educators, that involves preparation and evaluation of results obtained from academic assessments, as well as to provide objectivity.

With regards to the history of SPIN-ED, he developed the system in 2021 and it started working in the same year. "Till now, there are three schools using it but due to specific business principles, I will not be able to mention the schools here," he added.

Dr Mbennah said he was mostly inclined to develop the SPIN-ED program due to challenges that he witnessed when he was a voluntary teacher at one of the schools within the country.

He graduated from two different universities, both in Minnesota, USA, with a Dual Bachelor's engineering degree, BSc. Engineering Sciences from the University of Northwestern - St Paul (2010 - 2012) and Bachelor's in Electrical Engineering from the University of Minnesota - Twin Cities (2013 - 2016)

Eng Mbenna returned to Tanzania in 2017 and whereby in 2021, he served as a volunteer teacher in one of the schools in the country where he discovered several challenges.

One of the challenges was especially ones pertaining to the preparation of academic progress

reports. But he also witnessed at various schools such as educators using a lot of time in progress report preparation.

He witnessed educators using a lot of time in calculating marks and everything related to students' academic performance, even if most of the teachers were not Mathssavvy.

However, he also pointed out that English language is still a challenge to most teachers when it comes to the preparation of the progress reports, hence the development of auto-comments in the SPIN-ED program.

He point out, that these are some of the challenges, but they happen to be the main ones that he had identified that year, that drove him to develop SPIN-ED.

He now introduces the SPIN-ED and appeals to education stakeholders and the community at large to adopt the system that makes academic work processing much easier, emphasizing the importance of using SPIN-ED.

"I have a strong belief that it will increase efficiency in education, especially in the aforementioned levels once the community will be familiarized with the system."

"I would like to recognize and applaud the government under leadership of President, Samia Suluhu Hassan, through the Ministry of Education, Science and Technology, led by Prof. Adolf Mkenda, for all the efforts it (the government) is making in bettering our education system, in a bid to align ourselves with the changes and pace of the world, by bringing about positive change recently, for example, giving out tablets to teachers and also modifications to our curriculum, towards the end of last year," he said


He argued that it is very evident and obvious that Tanzania is not falling behind the rest of other countries in the world, expressing faith that even when it comes to the use of technology in bringing about efficiency in teaching, the country will continue witnessing positive changes.

The engineer appealed to the government, the education sector, private sector and the Tanzanian community as a whole, to support the use of the SPIN-ED academic performance management system, but also to continue to support the efforts of the Tanzanian youth that have been discovering/inventing various things for our nation as well as individuals.

Ruth, Emmanuel, one of the long serving teachers in Dodoma Region who shared her opinions on the system noted that it is likely to help teacher, most of whom have a lot of tasks.

She said, "Such innovations are likely to bring great changes in education system in the country and it would be very grateful if education stakeholders adopt such technologies".

With experience dating back from 1987 to 1995 as a primary school teacher, before upgrading and teaching linguistics at the Mt, Meru University in 2004, she said there are a lot of challenges facing teachers throughout their profession, thus such systems can save them the daunting tasks.

Makete farmers to receive 1,000 tons of wheat seeds

armers in Makete district are expected to receive a total of 1,000 tonnes of wheat seeds from the Tanzania Agricultural Seeds Agen-

This move is part of the efforts by the ministry of agriculture to revamp and improve wheat production to meet the shortages.

To help counter the tall shortage, the ministry is working with ASA to open a major estate for the mass production of the crop in Makete district, the potential area for the production of the crop.

The other potential areas suitable for wheat production in the country include Arusha, Mbeya, Iringa, Manyara, and Kilimanjaro

Speaking over the weekend during a brief event to handover the first consignment of the seeds, at least 450tons, on behalf of ASA's Chief Executive Officer Dr. Sophia Kashenge, the manager for ASA's Dabaga seed farm, Nicholas Msange expressed that the seeds meant to enable the growers in the area to engage into professional cultivation of the crop.

He added that the remaining 550 tons of the improved seed variety, of coded Sifa, would soon be arrived in the districts in readiness to be distributed to the farmers.

According to ASA's Chief Executive Officer (CEO) Dr. Sophia Kashenge, the prospectus wheat farm to be established in the district will cover a total of 1,000 hectares, and to start with, the expectation is to produce between 2,500 to 3,000 tons of wheat seeds.

"We're very eager to embark onto implementation of the project in order to help solve the longstanding challenge of shortage of wheat seeds in the country," she

expressed.

Dr. Kashenge informed that demand for the wheat seeds in the country are around 30,000 tonnes annually, but what is currently being produced is less than 500 tonnes.

As an urgent and short-term measure to help containing the poor situation, Dr. Kashenge said the state-owned seeds Agency was expecting to import at least 500 tonnes of wheat seeds to help assist the local farmers in the coming growing season.

"The vision is to assure the farmers are supplied with adequate seeds while we're working to expand home production," she assured.

The ASA's chief boss, Dr. Kashenge, underscored over the need for the accumulation of more lands to enable vast pro- yield per hectare is estimated at

duction for the seeds in all areas across the country where the starch-grass crop can flourish.

The Government is now resulting in transforming the country's Southern Highlands, especially the Makete district, into wheat production corridor as demand for the produce heightens locally, as well as in the world market.

Wheat is among important crops for food and income generation in Tanzania, but despite its importance, the production of the crop remains significantly low, around 100,000MT annually, compared to the crop demand of 1,000,000 MT per year.

The low production is 'armtwisting; the government to annually import about 90 percent of wheat for home consumption, whereby the current average 1.6 tons and strategies of increasing productivity through intensification and intensification to attain at least 3.0 tons per hectare is in place, among others.

The Makate district is currently producing 8,242 tons of wheat from the district's estates.

Recently, the ministry of agriculture through the Tanzania Agricultural Research Institute (TARI) has hatched an important initiative in the district, which intends to double the rate of production at the moment, and then increase it to reach an output of more than 200,000 tons by the year 2026.

Among others, the timely initiative focuses on increasing the area meant for wheat production in the district from the current 17,120 hectares to a total of 118,000 hectares by 2026.

The Dar es Salaam Stock Exchange (DSE) indices slipped at the end of last week, following the decline of NMB Bank and Swissport Tanzania shares prices.

The market report shows the All Share Index (DSEI) closed at 1,765.96 points on Friday last week, a decrease of 2.62 points recorded a day before, while the Tanzania Share Index (TSI), which measure the performance of local firms declined by 8.27 points after closing at 4,385.83 points.

According to the report, the NMB share price closed the week 0.85 percent down to 4,660/compared to 4,700/- recorded a day before, while Swissport share price closed at 1,200/- compared to 1,220/-, which was 6.67 percent



down.

Top mover during the end of the week was Tanzania Breweries Limited (TBL) counter, which recorded a transaction of 100,000 shares valued 550mn/- sold at 50 percent discounted price of 5,500/- per share through pre-

arranged block trade in one deal. All the traded shares of the largest listed company at DSE were floated by local investors and

bought by local investors. The second top mover was CRDB Bank counter, which recorded the transaction of 41,409

shares valued 20.9mn/- traded at a price ranging from 500/- to 520/per share in 90 deals, followed by NMB counter which recorded the transaction of 17,607 shares valued 82mn/- traded at a price ranging from 4,520/- to 4,700/- per share in 15 deals.

Other active counter included Swissport, which recorded the transaction of 5,822 shares valued 6.5mn/- traded at a price ranging from 1,100/- to 1,120/- per share in five deals and NICO counter which recorded the transaction of 15,904 shares valued 9.2mn/- traded at a price of 580/- per share in 16 deals.

DCB Commercial Bank counter recorded the transaction of 10,401 shares valued 1.5mn/- traded at a price ranging from 140/- to 150/per share in seven deals.

LHRO advocates strategies to enhance economic welfare for recovering youth

AL-KARIM Bhanji, the visionary Executive Director behind Life & Hope Rehabilitation Organisation (LHRO), is advocating for gamechanging strategies to uplift economically the youth trapped in the grips of drug addiction.

Bhanji outlined key strategies such as providing entrepreneurship education and offering capital to facilitate their engagement in incomegenerating activities, ensuring sustainable livelihoods for struggling

Delivering his impactful message in Bagamoyo, Pwani region, just two health promotion meeting organized by the organization across five wards of the district.

Identifying project wards including Dunda, Magomeni, Nianjema, Kisutu, and Kiromo, Bhanji spearheaded a one-year initiative aimed at empowering addicts to reclaim their fundamental rights, generously supported by funding from the US Ambassador Fund for HIV/AIDS Relief (AFHR Grant) and Pepfar.

At this pivotal gathering, Husna Kipilipili, the Coordinator of Mental Health and Drug Rehabilitation, revealed a remarkable milestone:

days ago, Bhanji addressed a crucial 744 young individuals have courageously stepped away from drug abuse, now seeking recovery through methadone treatment at the district hospital.

"Youth are the nation's workforce, and here we are informed that 744 have stopped using drugs. It is important for the government and various stakeholders to find ways to economically empower them," said

He elaborated that with education and capital, young people could also engage in backyard farming and break away from dependency,

which sometimes leads to stigma. He emphasized that if young people leave drug abuse but continue living in the same environments that led them to drug use without any meaningful activities, they might relapse. Bhanji stated that if they relapse, they become burdens to their families and even contribute to losses by being fed or sometimes resorting to theft.

"A young person engaged in some activity, including small-scale business, finds it easier to sustain their livelihoods. Therefore, my plea is for strategies to support this group economically," he said.

He noted several key things to consider for young people, including educating them about the

dangers of drug abuse, providing entrepreneurship education, and giving them capital to engage in any income-generating activity.

"I believe among these 744 young people, there are those with various skills ranging from automobile mechanics, motorcycle repair, radio repair, phone repair, and even carpentry. So, if they receive capital to buy tools, they can return to their activities and sustain their livelihoods," he said.

The guest of honor at the meeting, the Chief Medical Officer of the district hospital, Dr. Kandi Lussingu, thanked the leaders of the community development department, local police, gender desk, and other stakeholders for their collaboration in helping young people out of drug addiction.

"Removing young people from

drug addiction is a crucial step, so let's continue to collaborate to save the next generation, as they are the future workforce of the nation," said Dr. Kandi. The district police chief, Mushana

Mujema, said that the involvement of the police in the project by the organization's Director is a clear sign of wanting to help young people break away from dependency.

"Our job is to prevent all forms of crime, as some young people using these drugs engage in such activities. We are ready to provide assistance that will help our youth break away from their former drug lives to become assets to their families, communities, and the nation as a whole," said Mujema.

Dr Kijaji emphasizes on steel products' quality NMB Bank

The minister was instructing Business Registration and Licensing Agency (BRELA), which deals with business licensing, the Tanzania Standards Agency (TBS) for quality assurance as well as the Measurement Agency

Minister Kijaji gave this instruction over the weekend in Dodoma, when visiting ALAF and Herosean Enterprises, which produces Dragon steel, as an implementation of President Samia Suluhu Hassan's direc-

President Samia once directed government authorities to check quality assurance for the products produced by factories in this country.

While at the Herosean Enterprises factory that produces Dragon steel, the minister noted

that there are other products in the factory that are not related to the actual objectives of the license issued by BRELA.

"Today I have visited these two factories but unfortunately this Dragon galvanized steel factory is involved in the business

of selling other products including Refrigerators, PVC, Tiles and Ceiling board," she said.

"I have asked them to show

me the registration of selling those products, different from the galvanized products in the factory but I did not get the right answers. I am instructing the institutions involved in this issue to deal with it to find out the truth," said Kijaji

Similarly, Dr. Kijaji called on the owners of factories producing galvanized products in the country to sell the product at friendly price to benefit all groups of consumers.

"Another thing I want to tell Tanzanians about the products I visited today, compared to other countries, we in Tanzania, our price is lower than any country in the East African Community. So, I ask you not to listen to the noise in the street; continue to build factories and we, the government will continue to implement our projects," Dr. Kijaji said.

The customer service officer of the ALAF galvanized steel factory, Herry Jailos, thanked the Government for conducting a visit and identifying the challenges they are facing, including the lack of markets due to stiff competition.

Kenya grey listed for dirty cash flow

enya has again been put under high watch for not having strong safeguards against the flow of dirty cash, joining 23 other countries in a list of shame known as the 'grey list.'

On Friday, the Finance Action Task Force (FATF), the global anti-money laundering watchdog, made a decision to put Kenya on the grey list, a move that is likely to hurt Nairobi's standing as the financial centre of the region.

The grey list refers to countries that have deficiencies in dealing with money laundering and terrorist financing.

Kenya will be under increased scrutiny by the FATF, with the country expected to make critical changes to its financial infrastructure to reduce the risk of being a haven for dirty money.

Kenya, a financial hub in the region, has also been flagged as a regional hub for illicit gold as well as a transit for drug and wildlife traffickers, with law firms, casinos, and real es-

tate agents being highlighted as some of the enablers of money laundering.

With Uganda removed from the list following recommendations of FATF's fifth plenary meeting, Kenya now joins Tanzania and South Sudan in the grey list. Other African countries on the list include Nigeria, South Africa, Mali, Mozambique, Burkina Faso, Senegal and Cameroon.

The downgrade means Kenya might be subjected to stricter due diligence when dealing with the rest of the world, with far-reaching impact to the economy, including difficulty in securing funding and reputation damage.

This is a blow to the government which had made several amendments in a bid to forestall the damning rating.

The National Treasury in a statement confirming that Kenya had been placed on the 'grey list' explained that it had made several amendments to laws against money laundering and terrorism financing including the AML/CFT (Amendment) Act, 2023.

"We wish to address

the recent development concerning Kenya's status with the Finance Action Task Force (FATF). Kenya has officially been placed on 'grey list,' indicating enhanced monitoring to ensure compliance with international Anti-Money Laundering, Counter-

ing the Financing of Terrorism, and proliferation of Weapons of Mass Destruction (AML/CFT/CPF)," said Treasury Cabinet Secretary Professor Njuguna Ndung'u.

"This underscores the imperative for swift and comprehensive action

to bolster our compliance efforts. It is important to note that Kenya underwent an assessment conducted by the Eastern and Southern Africa Anti-Money Laundering Group (ES-AAMLG) in 2022. The evaluation revealed a mixed picture."

A 2022 mutual assessment report by a regional anti-money laundering watchdog identified several strategic deficiencies in its framework for the fight against dirty cash.

The evaluation by the Eastern and Southern Africa Anti-Money Laundering Group (ESAAMLG) found Kenya to be 'partially compliant' with the global standards on anti-money laundering and terrorism financing.

Prof Ndung'u was however optimistic that the

latest rating would not impact the country's economy negatively.

"While there are still strategic deficiencies that require urgent attention, Kenya remains fully committed to implementing the FATF Action Plan comprehensively and expeditiously," he said.

"We will review the progress made to date and develop a comprehensive strategy to address remaining deficiencies. Adequate resources will be allocated to ensure timely compliance and exit from the grey list." He said that the National Treasury is actively engaged in the process and anticipates minimal effects on the country's financial stability and the costs of conducting business in Kenya.

Nevertheless, the government remains vigilant and committed to managing domestic ML/TF/PF risks effectively, he added.

In 2010, FATF placed Kenya on a list of highrisk countries for delays in enacting laws to tackle criminal financial activity as well as a failure to track money laundering. It was removed from the list four years later.



Warren Buffett's Berkshire

Warren Buffett's Berkshire posts record profits

Warren Buffett's Berkshire Hathaway has posted its second straight record annual operating profit, with its insurance business benefiting from improved underwriting and higher income from investments as interest

Net income also reached a record \$96.2 billion, as the rising stock market boosted the value of Berkshire's \$354 billion equity portfolio, half of which is in Apple.

In his annual letter to Berkshire shareholders, Buffett said Berkshire's insurance businesses performed "exceptionally well" - among them, Geico, where better underwriting quality helped it more than reverse year-earlier losses

This helped offset declining fourth-quarter and fullyear profit at the BNSF railroad, where rising wages and costs for upkeep increased as revenue fell, and Berkshire Hathaway Energy, beset by wildfire litigation and a tougher regulatory climate.

Buffett nevertheless assured investors that his approximately \$903 billion conglomerate's "extreme fiscal conservatism" - including a now-record \$167.6 billion cash stake - would serve them well.

Operating profit rose 28 percent to \$8.48 billion, or about \$5,884 per Class A share, in the fourth quarter, topping the average analyst forecast for \$5,471 per share according to LSEG IBES.

For the year, operating profit rose 21% to \$37.4 billion. "Results reflect the value of holding a diversified collection of operating businesses," said Edward Jones ana-


lyst Jim Shanahan. He said Geico benefited from a willingness to cede market share by writing fewer risky policies, while also

cutting advertising expenses.

The cash stake helped Berkshire's insurance businesses, which have \$169 billion of so-called "float," generate 38% more investment income in the quarter, as the Federal Reserve boosted short-term interest rates to curb

Results also included some of Occidental Petroleum's earnings, from Berkshire's roughly 28% stake in the oil

Buffett said Berkshire plans to keep its stake indefinitely but has "no interest" in buying all of Occidental. Berkshire is also a big investor in oil company Chevron.

Trump defeats Haley in her home state, but Haley vows to head into Super Tuesday

WASHINGTON

FORMER U.S. President Donald Trump on Saturday secured victory over Nikki Haley, his former ambassador to the United Nations, in South Carolina's Republican primary, advancing a step closer to a potential face-off with incumbent Joe Biden in the upcoming presidential election in November.

Despite her aspirations to regain momentum after three losses in Iowa, New Hampshire and Nevada, Haley -- South Carolina's first female governor from 2011 to 2017 -got roughly 40 percent of the vote, trailing Trump by approximately 20 percentage points.

As Trump and Haley traverse the primary landscape, vying for the Republican presidential nomination state by state, Trump's firm hold on a significant faction of the party is evident.

However, he remains embroiled in controversies surrounding his efforts to overturn the 2020 U.S. presidential election results and his alleged role in inciting the Jan. 6 Capitol Riot.Meanwhile, despite growing inner-party pressure to drop out and allow Republicans to unite around Trump, Haley vowed she was "not giving up this fight."

"We're getting around 40 percent of the vote. That's about what we got in New Hampshire, too. I'm an accountant. I know 40 percent is not 50 percent. But I also know 40 percent is not some tiny group," Haley told supporters in her election-night remarks.

"In the next 10 days, another 21 states and territories will speak," she said. Her next station is Michigan, and then Super Tuesday on March 5, when 15 states and one territory will vote to choose candidates to compete in the general elections.

Trump, who has swept all the early states, has contended that the Republican primary election was effectively over. "This was a little sooner than we anticipated." he said in his victory speech in Columbia in South Carolina, adding that he had "never seen the Republican Party so unified as it is right now.

"A Marquette Law School national poll of registered voters conducted from Feb. 5 to 15 showed that Haley could hold a larger lead over Biden than Trump in a hypothetical general election match-up, considering "her strength with Republicans combined with an ability to attract more Democratic and independent voters than does Trump."

But most observers believe Trump's leadership in the party can hardly be shaken, and more discussion has been switched to who Trump's election partner will be. A Morning Consult tracking poll conducted from Jan. 23 to Feb. 4 showed Trump is considerably ahead in every major Super Tuesday state.

A daughter of Indian immigrants, Haley, 52, who portrays herself as a leader from "a new generation" and attacks Trump about his age and records in making America "chaos," has aimed to court independent voters and moderate Republicans.

But that strategy appeared to be ineffective. In the first Republican primary in Iowa, Trump secured over 50 percent of votes, while Haley even placed behind Florida Governor Ron DeSantis, previously considered a promising right-wing challenger to Trump who

In the recent Nevada contest, featuring both a state-run primary and a partyrun caucus, only the caucus results dictated delegate allocation. Having chosen to participate in the primary, Haley was consequently excluded from the caucus.

She suffered a significant setback, losing the primary to the "none of these candidates" option by a considerable 30 percent margin. Trump's name was not on the ballot. The outcome underscored her formidable challenge in securing the nomination.

The odds are against her, even in some of her targeted groups. For instance, according to an ABC News poll, even among college-educated voters, where Haley has experienced the greatest growth of support, she's trailing Trump by about 30 points nationally."

Trump has established a powerful, identity-based relationship with his most dedicated supporters, and his opponents in the GOP have generally been unwilling to challenge this," Christopher Galdieri, a political science professor at Saint Anselm College in the northeastern state of New Hampshire, told Xinhua.

Haley and her campaign have shown no sign of relenting. Calling the election "a building situation," she said in an NBC interview that she did not necessarily need to win her hometown but had to do better than she did in New Hampshire, which was better than she did in Io

Two years on, peace still elusive in Ukraine crisis

AS the full-scale fight in Ukraine reaches its second anniversary, Russia appears to have the upper hand with the capture of Avdiivka, a strategic stronghold in the Donetsk region, leaving Kiev and its backers in an even harder situation than before.

The weariness caused by the two-year-long conflict, dubbed by some analysts as "Ukraine Fatigue," is now permeating Western nations, leading to a divided stance on providing further support to the country.

The recent Israeli-Palestinian conflict has further limited the ability of the West, particularly the United States, to focus on Ukraine.

However, the two countries, which remain committed to advancing military operations, show no signs of initiating peace talks.

Battlefield dilemma

In recent months, Russia and Ukraine have both focused on the strategic importance of Avdiivka, located just 20 km from Donetsk and controlled by Russian forces.

The city plays a crucial role in securing the northern front lines for the Ukrainian army in the Donetsk region.

Oleksandr Syrsky, commander-in-chief of the Ukrainian Armed Forces, said last week that Ukraine had ordered the withdrawal of troops from the frontline eastern town of Avdiivka.

"To avoid encirclement and preserve the lives and health of servicemen, I decided to withdraw our units from the city and move to defense on more favorable lines," he said.

According to Russia's Defense Ministry, Russian troops have taken full control of the town of Avdiivka.

Sean Bell, a British military analyst, said the fall of Avdiivka has given Russia its most important battlefield victory since it seized Bakhmut after months of grueling attritional warfare.

Many analysts believe the balance of war is tipping in Russia's favor but not to the point where Ukraine is at risk of a full-scale collapse.

In fact, the front lines of the conflict have barely moved since 2023 as Ukraine's midyear offensive failed. This also holds true even after the fall of Avdiivka.

"Militarily, it's not a big loss," said Rob Bauer, chair of the NATO Military Committee, concerning the fall of Avdiivka. "They destroyed the whole infrastructure. So, you don't have a city. You have another couple of hundred meters," he said of Russia's territorial gains.

As the former commander-in-chief of the Ukrainian Armed Forces, Valerii Zaluzhnyi, said recently, the Russia-Ukraine conflict has now entered a phase characterized by stalemate and

According to analysts, it is seemingly difficult for both sides to achieve a major breakthrough on the battlefield this year, but the intensity of the conflict may somewhat decline.

Ukraine will probably switch from offensive to defensive, while Russia will also find it hard to expand its territory beyond the four areas it con-

The upcoming US and Russian presidential elections, the amount of aid Ukraine can obtain from the West, as well as the quantity of troop personnel replenishment for both will all decide the trend of the conflict.

Declining Western aid

Admit it or not, global attention to the Ukraine crisis has dwindled recently, and people in the West, particularly in the United States, are becoming increasingly tired of the ongoing crisis.

Nearly half of the US public believes the country is spending too much on Ukraine, according to a recent Gallup

The US election campaign has already negatively affected the delivery of more aid to Ukraine.

Currently, a \$60-billion package of aid to Ukraine is stalled in US Congress by right-wing Republicans.

US officials admitted that little could be done before America elects a new president.

The situation is comparably better for the Europeans, with the EU countries sealing a deal at the beginning of February to provide Ukraine with 50 billion euros (about \$54 billion) in support for Ukraine after Hungary dropped its veto threats.

But converting this commitment into ammunition available to frontline soldiers is still a challenge.

Even so, it seems that some Western countries don't want to lose this opportunity to weaken Russia, and continue to exacerbate the conflict and profit from it.

In the two years of the conflict, the US defense industry has experienced a boom in orders for weapons and munitions, The Wall Street Journal reported recently.

Business is coming from European allies trying to beef up their military capabilities as well as from the Pentagon, which is both buying new equipment from defense manufacturers and replenishing military stocks depleted by deliveries to Ukraine, it said.

The State Department recently said the United States made more than 80 billion dollars in major arms deals in the year through September, of which about 50 billion dollars went to European allies - more than five times the historical norm, Myles Walton, a military industry analyst at Wolfe Research, was quoted by The Wall Street Journal as saying.

At the recently closed Munich Security Conference, increasing military aid to Ukraine was still the focal topic.

Moreover, the North Atlantic Treaty Organization last month kicked off "Steadfast Defender 2024," its largest military drill in decades, which is deemed to be directed at Russia.

Unreachable peace

The year 2023 started with high hopes for Ukrainian troops planning a counteroffensive against Russia, but ended with disappointment on the battlefield.

"Whatever else the war may be achieving, it has not been good for Ukraine," said Charles W. Freeman, a retired American diplomat and writer, adding that Ukraine's bargaining position against Russia has been greatly weakened.

Both Russia and Ukraine have repeatedly said they want the war to end, but on their terms.

In January, Ukrainian President Volodymyr Zelensky warned that a ceasefire then would only give Russia the chance to regroup and replenish its units and weapon

"Talking about a ceasefire in Ukraine, it would not constitute peace. It would not mean the war would stop. It also provides no opportunity for political dialogue," Zelensky said on a visit to Estonia.

For its part, the Kremlin said in December that it saw no current basis for peace talks, and called Kiev's peace plan an "absurd process" as it excluded Russia.

Meanwhile, Western countries have continued, though reluctantly, to deliver dwindling aid to Ukraine.

For most analysts, a negotiated solution in 2024 does not look promising at this point.

A survey conducted in January across 12 EU countries found that pessimism about the conflict's outcome was being fueled by Ukraine's failed counteroffensive, a potential US policy shift and the possibility of Donald Trump being reelected president.

Though support for Ukraine among Europeans remains high, some form of "compromise settlement" is seen as the most likely solution to the conflict in the survey of over 17,000 respondents by the European Council on Foreign Relations. This marks a shift in sentiment, however, as a majority of Europeans upon the first anniversary of the conflict said Ukraine must regain all of its lost territory.

In November, Italian Prime Minister Giorgia Meloni said about the Ukraine issue: "There is a lot of fatigue. We are near the moment in which everybody understands that we need a way out."

Russian defence chief listens to commanders' reports in special military

Russian Defense Minister Sergey Shoigu ordered during the visit to the Battlegroup Center headquarters to further reinforce the battlegroup with electronic warfare equipment, the Russian Defense Ministry said.

"The Russian Defense Minister set the task to further strengthen the group with electronic warfare means, primarily at the tactical level," the ministry said.

Orlan-30 reconnaissance drone proved to be good during Avdeyevka liberation, Battlegroup Center Commander Andrey Mordvichev reported to Defense Minister Sergey Shoigu.

"The Orlan-30 unmanned aerial vehicle system proved to be very good in the course of liberating Avdeyevka settlement," the Russian Defense Ministry said.

Strike drones of the Battlegroup Center destroyed more than 700 various enemy targets in the Avdeyevka direction, Battlegroup Center Commander Andrey Mordvichev reported to Defense Minister Sergey Shoigu.

"During the last fortnight alone, strike drones in the Avdeyevka direction destroyed more than 700 various enemy targets, including armored vehicles, artillery systems, radars and manpower of the adversary," the Russian Defense Ministry **Agencies** said.

South Sudanese President Kiir visits Rwanda, Burundi and DRC amid rising regional tensions EAC Secretary-General Peter

South Sudanese President Salva Kiir, who currently serves as the chairperson of the summit of the East African Community (EAC) heads of state, on Thursday embarked on a significant working visit to Rwanda in a bid to address escalating tensions in the East African re-

Rwandan foreign minister Vincent Biruta received Kiir who was accompanied by

Mathuki at Kigali International Airport, Rwanda. President Kiir later engaged in a consultative meeting with Rwandan President Paul Kagame at the president's office in Kigali, the capital of Rwanda.

The discussions, as outlined in the communique released by the EAC secretariat Friday, focused on the critical status of peace and security within the EAC, a regional bloc that groups Burundi, the Democratic Republic of the Congo, Kenya, Rwanda, South Sudan, Uganda, Tanzania, and Somalia.

Both leaders emphasized the pivotal role of peace and security in fostering social and economic development within the community and achieving the objectives of the EAC, according to the communique.

They called on partner states to comply with their obligations as enshrined in the treaty for the establishment of the EAC.

The two leaders underscored the need for expeditious complimentary implementation of the political track of the EACled Nairobi process and the Luanda process to avert the unfolding dire security situation in the eastern Democratic Republic of the Congo (DRC) which risks spilling over into neighboring partner states. The Luanda and Nairobi processes refer to African regional efforts to ease the tension in the eastern DRC, including meetings in the Angolan and Kenyan capi-

The DRC has accused Rwanda of backing M23 rebels, an

accusation rejected by both Kigali and the M23 rebel group. South Sudanese President Kiir started assuming the one-year chairmanship of the summit of EAC heads of state in November 2023.

He took over the rotating chairmanship from Burundian President Evariste Ndayishimiye. Kiir extended his visit to neighboring Burundi Friday before proceeding to the DRC.

During his one-day visit to Burundi, President Kiir held a meeting with Burundian Presi-

where they recommended the respect and implementation of agreements to solve regional

A communique issued at the end of the consultative meeting between both presidents showed that they discussed regional issues notably the tension between Burundi and Rwanda, as well as the crisis in the eastern Democratic Republic of the Congo.

"Both leaders noted the need for the two sister states

dent Evariste Ndayishimiye, of Burundi and Rwanda to ensure the implementation of all previously agreed upon commitments arising out of the bilateral dialogue between the two countries," said EAC Secretary General Peter Mathuki who read the communique, adding that the implementation of those commitments will energize the implementation of the EAC integration imperatives that include free movement of people, goods and services.

What are the hidden motives behind US refusal to stop two ongoing fights?

BEIJING

OVER the weekend, the full-scale war in Ukraine has hit a two-year mark, and the Palestinian death toll in the Gaza conflict is nearing 30,000.

Two ongoing conflicts are causing humanitarian catastrophes. Ignoring this fact, the United States persists in its plans to sustain funding for the conflict in Ukraine and has, for the fourth time, vetoed a UN resolution advocating for a ceasefire in Gaza last week.

Why is the United States not stopping the fighting? Analysts have assessed the scenario and reached a resounding conclusion: It is a combination of factors. including the U.S. strategic interests for global dominance and the lucrative war business.

STRATEGIC INTERESTS

Obviously, the United States has its strategic priorities in these two conflicts. By prolonging both conflicts, its aim is to attain geopolitical objectives in order to uphold its global dominance.

Not long after fighting broke out in Ukraine, U.S. Defense Secretary Lloyd Austin said in April 2022 that the United States hopes the war in Ukraine will result in a "weakened" Russia, a country that was named as a rival power by Washington since 2017.

"It has already lost a lot of military capability and a lot of its troops, quite frankly, and we want to see them not have the capability to very quickly reproduce that capability," Austin said.

Meanwhile, the United States is seeking to bolster its influence and control in Europe, especially through NATO. Austin also said the United States hopes "to see the international community more united, especially NATO." He cited the sanctions imposed on Russia by the United States and its allies as an example of how the fighting in Ukraine has made the security alliance more uni-

Furthermore, under the pretext of fortifying security amid the conflict in Ukraine, the United States has taken

a number of steps to strengthen its military presence and operations in and around Europe, showed a report to U.S. Congress titled "A Great Power Competition: Implications for Defense" updated on Jan. 10. 2024.

While in the Middle East, the U.S. persistent refusal to stop the Israel-Hamas conflict has drawn attention, as analysts argue that this ongoing conflict has diverted Western leaders' time and political energy away from

Then why the United States is not stopping this conflict? "That's primarily because the United States agrees with Israel's goal of destroying Hamas," said an opinion piece published by Politico.

A prolonged Israel war on Hamas will dismantle the militant group and "undercuts Tehran," said the article.

Echoing the point, a Wilson Center report, "National Security Challenges for the United States and Israel in the Biden Era," said: "Maintaining the U.S. presence in the Middle East is a vested Israeli interest. The United States could consider ... operations to push back against Iran in the region."

"The United States has little interest in negotiating with the Palestinians," Elias Fuentes, an international affairs expert at the National

Autonomous University of Mexico pointed out. While explaining the U.S. stance in the Israel-Hamas conflict, Fuentes said, "its primary focus is safeguarding its own interests."

ECONOMIC SPINOFFS

U.S. defense giants are faring well amid heavy government demand for military aid to Ukraine and Israel.

According to Biden administration officials, of the 60.7 billion U.S. dollars earmarked for Ukraine in a 95 billion supplemental defense bill, 64 percent will actually flow back to the U.S. defense industrial base.

Industrial production in the U.S. defense and space sector has increased 17.5 percent since the Russia-Ukraine conflict broke out two years ago, Federal Reserve data show.

"The Pentagon's increased demand for goods and services from U.S. defense companies has likely improved their potential profits," William Courtney, a retired U.S. ambassador and adjunct senior fellow at the RAND Corporation, told Xinhua.

Seen from financial reports for the year 2023 of major U.S. arms dealers, sales of defense company Raytheon, or RTX, were close to 20 billion U.S. dollars in the fourth quarter, exceeding the third quarter and up by 10 per-

cent compared to the same period last year. Defense firm Lockheed Martin's stock price surged at the outset of the Ukraine crisis from around the 400 dollar-per-share mark to nearly 500 dollars per share in less than a year.

"Since most of the fight involves ground operations, U.S. and other Western producers of equipment, ammunition, and other supplies for ground forces, including ground-based air defenses such as the Patriot, may have benefitted the most," Courtney

Over the past year, the United States raked in more than 80 billion dollars in major arms deals, with about 50 billion dollars coming from European allies, according to the U.S. State Department.

Likewise, the United States is Israel's largest military aid provider. The Israeli Air Force uses air-to-ground missiles produced by Raytheon, while Boeing provides Israel with a large quantity of Small Diameter Bombs, Joint Direct Attack Munitions kits, and more.

Lockheed Martin also supplies Israel with "Hellfire" missiles. According to Bloomberg, just over a month after the conflict in Gaza began, around 2,000 "Hellfire" missiles were shipped from the United States to Israel.

Data also showed that the United States has provided Israel with over 130 billion dollars in security and weapon aid since its founding in 1948, with approximately 80 percent of Israel's military equipment imports coming from the United States.

Besides raking in profits from arms sales, the United States is also making serious money as the Russia-Ukraine conflict has driven up European demand for U.S. liquefied natural gas.

The U.S. has become the biggest exporter of LNG to Europe, as EU countries have raced to replace Russian fuel. Over 60 percent of U.S. LNG exports went to Europe in the last two years.

A sharp critique from a recent Wall Street Journal article said: "While war often has economic spinoffs, these are occurring without the U.S. actually doing any of the fighting."

During a press conference, the Spanish PM called for a permanent ceasefire in Gaza and renewed support for the UN agency for Palestinian refugees.

"In our opinion it is imperative that a permanent ceasefire be reached, that hostilities cease and that all hostages that are held right now by Hamas be freed. We must also guarantee access to humanitarian aid, and for that the work of the UN Relief and Works Agency for Palestine Refugees in the Near East, is fundamental, this is an argument that Spain has been making," Sanchez said.

Neuer said Tuchel's exit "cast a bad light on us as players, that we weren't able to make it work with a top coach like Thomas Tuchel.

"It's our mistake. We want to keep things going professionally until the end.'

Newcastle offered nothing in attack, but worse still was the absence of commitment. "Hugely disappointing," Howe reflected. "We didn't compete tonight. It's not like us."

Without Nick Pope

and Martin Dubravka, ruled out due to illness, it was Karius, with his nightmare in the 2018 Champions League final still hanging over him, who saved Newcastle from an even heavier defeat. Karius was perhaps spared further embarrassment, though the same could not be said for those in front of him, as Newcastle's miserable defensive record since Pope's injury continued. Botman's comical own goal gifted Arsenal the lead but Newcastle's defending was statuesque in the face of Arsenal's thrilling speed and movement.

Jorginho, the only change from Wednesday's late heartbreak in Porto, conducted play expertly from the base of Arsenal's midfield, setting up Saka and Gaand drew circles around the visitors, Declan Rice surged, and the emerging surprise package of Arsenal's season, Ben White, in his midfieldhybrid role, pulled various strings together. Newcastle's response was non-existent and Arsenal could have been

out of sight. Havertz buried Arsenal's second from close range after Jorginho played an exquisite ball through and Martinelli's electric pace then rescued a touch from going over the byline, as Botman failed to close him down. The centre-back appeared to give up, just as Howe's side were lifeless, finishing the first half without a shot on the Arsenal goal. Schar almost gifted Arsenal a third but Sean Longstaff's interception denied Havertz another tap-in. Martinelli headed over following a sumptuous flick from Odegaard. Saka rifled a shot that

Karius kept out well at his near post.

Karius would be left shaking his head again in the second half: Newcastle briefly improved after the restart, finally mustering a shot on target as Anthony Gordon tested David Raya, then as the returning Alexander Isak cut inside before firing over. Yet Howe's side should have been left with no way back, after Havertz dragged wide following a lightning surge from Saka and Martinelli. Eventually, Saka took charge, dancing inside Livramento before firing into the far corner. Then, another corner. This time, Jakub Kiwior's header deflected in off Lewis Miley.

Arteta could afford to ring the changes with his side four goals up, offering all of Odegaard, Saka, Martinelli and Havertz some rest after largely sticking with his starting line-up from Wednesday night. This was some response. As for Newcastle, the away fans in the corner remained as one despite the scoreline, the 8pm kick-off, and the long return home. They danced in the away end at full-time. By then, substitute and former Gunner Joe Willock had met Dan Burn's cross to loop a header over Raya, pulling one back. But those away fans deserved much more than this.
