## MPs lament fuel, edible oil imports dependency

EASURES need to be taken by the government to control the balance payments and encourage local production to boost foreign currency liquidity, a section of MPs assert.

Charles Mwijage (Muleba North) made this suggestion when contributing to debate on the National Development Plan 2024/25, arguing that the government focuses on promoting the use of locally produced goods and control imports of goods whose raw materials

are locally available.

This will help to control foreign currency deficits, he said, noting that the lack of a reexport policy hurts balance of payments "as the country is now importing almost every-

Now is the time to empower the Small Industries Development Organization (SIDO) to facilitate the start of small industries in rural areas to increase local production, he



## UK inviting 65 states to duty-free trading scheme

TANZANIA is set to start exporting 98 percent of its products to Britain dutyfree on the basis of a newly unveiled Developing Countries Trading Scheme (DCTS).

Mbelwa Kairuki, the country's high commissioner to the UK, made this affirmation to Diaspora Tanzanians in a virtual meeting yesterday, noting that Tanzania is among 65 countries included in the programme.

Sales of Tanzanian products in the UK are still small, with £49m sales reached last year, compared to Uganda's £89m

and Kenya sales hitting £600m, he said. He said the local business community needs to organize ourselves and reorganise strategically so that sales increase more and more, elaborating that at the High Commission, "we have set ourselves the goal of increasing the sales of Tanzanian products from last year's £49m to £150m within the next two years".

Having 98 percent of goods from Tan-

zania entering the UK duty free is a great opportunity, he said, highlighting that the High Commission is taking steps to establish a tourism desk and hire an expert on tour arrangements.

The High Commission is projecting to increase the number of tourists from all over the UK from an average of 60,116 tourists annually to 200,000 by 2027, he

## EWURA quickens natural gas filling station permit issuance

The works now stand at 92 percent to conclusion and when completed it will generate 2,115MW, eliminate power shortages and reduce natural gas use

THE Energy and Water Utilities Regulatory Authority (EWURA) is multiplying issuance of licences for building compressed natural gas (CNG) filling stations. Dr James Andilile, the EWURA director

general, told journalists in Dar es Salaam yesterday that so far three natural gas filling stations are operating, one linking the Tanzania Petroleum Development Corporation (TPDC) and Pan Africa Energy in Ubungo in the city, another station located in TAZARA area in the city,

as well as the Dangote gas filling station

in Mtwara. He said the Dangote gas station serves about 250 cars used by the Dangote cement factory transporting the bulk cargo to various regions, while the two city filling stations serve an average of 350 cars a day. The next gas station is billed for the Julius Nyerere International Airport,

The meeting with editors and a number of other journalists representing various news outlets was intended to review developments in water, natural gas, elec-

### **VPO** restoring 5.2m hectares degraded land by year 2030

STRATEGIES to restore natural vegetation in 5.2m hectares of degraded land by 2030 are being implemented by the Vice President's Office (VPO).

Mary Maganga, the VPO permanent secretary made this observation in Dar es Salaam on Monday at the start of The Restoration Initiative (TRI) forum grouping participants from ten countries.

The project funded by the Global Environmental Facility (GEF) issues grants through the UN Environment Programme (UNEP). Other participating countries are Cameroon, the Central African Republic, China, the Democratic Republic of Congo, Guinea-Bissau, Kenya, Myanmar, Pakistan as well as Sao Tome and Principe.

They are carrying out an integrated ecosystem management approach for landscape restoration and biodiversity

Issuing permits and licenses for gas stations was rapid, implying that the services will soon be available, he said, not citing the timeframe for starting operations of other sta-

EWURA recently conducted a study on areas with fuel stations along the natural gas pipeline and found out that operators of the fuel stations are ready for connection to the pipeline using valves at each point. They can be enabled to access the natural gas for fuel stations for use by adapted motor vehicles, he stated.

Fuel station operators are inclined to reserve a portion of their fuel storage and pumping facilities for natural gas filling while natural gas filling stations are being built, he said.

President Samia Suluhu Hassan worked hard to revive the liquefied natural gas (LNG) project which, once implemented, will strengthen the availability of natural gas for most spheres of domestic use and exports, he pointed out.

Current information indicates that 54 factories countrywide are using natural gas, seven public institutions and 1,511 households in Dar es Salaam, Mtwara and Lindi regions are using the cleaner fuel, the

Natural gas use accounts for 1,193MW of electricity, along with 3,758 motor vehicles shifting to gas use, where the portion of gas electricity is expected to diminish with the imminent conclusion of the Julius Nyerere Hydropower Project

(JNHPP) works, he stated.

The works now stand at 92 percent to conclusion and when completed it will generate 2,115MW, eliminate power shortages and reduce natural gas use, experts say.

Back in 2015 Tanzania was producing 1,400MW, now elevated to 1.900MW, with new hydropower projects coming up in tandem with natural gas facilities.

About 65 per cent of households were connected to electricity, now rising to 78 per cent, he stated.

In 1974 natural gas was first discovered at Songo Songo, followed by Mnazibay in 1982 and in 2004, gas from Songo Songo started to be used in industrial production. Mnazibay gas use in factories followed in 2006, he added.

strategies to reduce importation and promote local production including encouraging the use of gas instead of petrol. This demands setting up vehicle gas convention centres across the country," he elabo-

Josephat Gwajima (Kawe) stated that in his constituency, the Tanzania Petroleum Development Corporation (TPDC) has launched a project to connect houses with gas, where the price per unit falls from 20,000/- to 3,000/-.

Joseph Mhagama (Madaba) said the country needs to choose a few key sectors to focus available resources, like improving the livestock sector where the country has adequate supplies.

Illustrating, he said up to last year 12 percent of fertilisers used by the country was produced locally, with

the bulk of 617,000 tons being imports.

"If the ministry managed to increase local production by five percent annually, it will control importation and raise local production," he said, insisting that there is a need to control importation of petrol and its products and use alternative products.

"It is a shame that as a country we are still importing edible oils while we have all the raw materials. This denies Tanzanians the right to access markets," he said.

Edward ole Lekaita (Kiteto) hailed President Samia Suluhu Hassan for 4R (Reconciliation, Resilience, Reform and Rebuild which he said has facilitated the flow of investment and tourists.

He however said if the country was to move fast the proposed development plan must focus on rural development by heavily investing in agriculture.

'We need tangible plans because, if you look at the data, only seven percent has been set aside for farming while this is a sector which moves with the majority of the population," he said.

The proposed plan has little about farmers and the agriculture sector as a whole, while livestock and agriculture are the main sectors which can transform the country's fortunes, he said.

Elibariki Kingu (Singida West), said the government was spending a lot in importing edible oils while the country has all the resources to produce oils. "We need to adjust our policies to accommodate this need," he added.

conservation project, as global programme geared at improving people's livelihoods through the restoration of degraded and deforested landscapes, she said.

Noting that the country's economy greatly depends on natural resources like forests, coastline, lakes, rivers, wetlands, wildlife and other lands contributing to economic growth and poverty reduction, she said that unsustainable use of these resources was threatening their sustainability.

Biodiversity loss, which also includes marine species, is largely contributed by unsustainable human activities, including agriculture and improper land use, she said, noting that VPO has initiated various programmes for the restoration of natural vegetation, including tree planting campaigns.

Experts estimate that each year 18.7m acres of woodland are lost to deforestation, causing land and soil damage, displacing plants and animals that rely on the woodland ecosystem.

In support of global efforts for restoration of nature and biodiversity, the government launched a new environment policy last year and an environment master plan to guide implementation of environmental

interventions for the next ten years. Kemilembe Mutasa, the VPO acting environment director, said the five-day forum brings together experts to discuss joint strategies in implementing projects to restore biodiversity in ten nations and how to get enough resources to achieve that goal.

Dr Francis Masau, evaluation and monitoring manager with the International Union for Conservation of Nature (IUCN) expressed gratitude to VPO for overseeing the project well. Tanzania is among exemplary countries in implementing TRI projects, he said.

Dr Damas Mapunda, the VPO national project coordinator, said the project is aimed at enhancing the national enabling environment and stakeholder capacity for sustainable landscape restoration (SLR)

Five regions are implementing the project, in seven district councils, 18 wards and 54 villages, with the project area including ecosystems of three valleys of the Great Ruaha and Lake Rukwa.

The districts are Iringa Rural in Iringa Region, Mbeya and Mbarali (Mbeya Region), Wanging'ombe (Njombe), Sumbawanga Rural (Rukwa), Tanganyika and Mpimbwe (Katavi), he added.

## Paper Mill to generate electricity using sugarcane leftovers by 2026

MUFINDI Paper Mill has expressed its intention to start generating electricity using sugarcane remains by 2026.

Annoop Singh, Paper Mill's executive director unveiled the plan when briefing the plant plan in Dodoma on Monday when he met with deputy Minister for Energy, Judith Kapinga.

The meeting was attended by Kasulu District Commissioner, Col. Isaac Mwakisu and officials from the Ministry of Energy and Tanzania Electric Supply Company (TANESCO),

So far, the company owns sugarcane farms in Kasulu District in Kigoma Region.

they are well prepared to achieve substation," he said. the plan of producing power.

He said that the company, which has 30,000 hectares of sugarcane farms in Kasulu district, expects to produce 24 megawatts of electricity by 2026 and by 2028 they will increase production to reach 60 megawatts.

He said that the power which will be produced by the company will be used to run plants in the company and the rest is expected to be included in the national grid after discussions with TANESCO.

"To achieve this, we are calling for the government to help construct a 132 KV or 400 KV power transmission infrastructure from the factory to the national grid and construction of a 11 KV/132 Singh informed Kapinga that KV power station or 11KV/400KV

The deputy minister Kapiunga commended the company for the good intention assuring that the government will continue supporting them to achieve the goal.

She directed experts from TANESCO and Mufindi Paper Mill to sit together, collaborate to see the best way that the government can implement to enable the execution of the submitted requests.

Kapinga also held talks with leaders of Songas Limited led by the company's CEO, Anael Samuel who came to introduce themselves to the deputy minister as well as inform her on the company's operations which produces 190 megawatts for the national grid.

## New push for Tanzania to have National Digital Economy Framework in the offing

push THE Tanzania to have a competitive digital economy in the world is on doorstep because the national digital economy framework (DEF) has been completed.

Dr Mohammed Abdulla, Permanent Secretary in the Ministry of Information, Communication Information Technology unveiled this yesterday when addressing special meeting of the Tanzania National Business Council's (TNBC) Digital Transformation Working Group (DTWG). Formulation of the strategy was overseen by the DTWG.

Dr Abdulla said his ministry and non-state actors have, for quite some time, been working on the framework. "Now the framework is in place awaiting clearance for implementation," he confirmed, explaining that the framework is another example of concreted joint efforts of representatives of the private and public sectors. "It is a product of many meetings of technical groups from both sides," he said.

He explained that in order for the nation to have a solid digital foundation, government worked with varied stakeholders drawn the private universities, sector, social groups and the development partners.

Explaining cooperative joint public-

private efforts are paying Samia Hassan called for off, Dr Abdulla said the efforts helped in realizing the national vision in this regard. Statistics, he said, show that registered telephone lines went up from 55.7 lines in April 2022 to 62.3 in April 2023. Internet users also correspondingly rose from 29.9 million to 33.1 million. Telephone transactions went up from 35.7 million to 44.3 million.

## Tanzania's GDP higher by 5.3pct in last financial year, in spite of 'global shocks'

FINANCE minister Dr Mwigulu Nchemba has said that Tanzania's Gross Domestic Product (GDP) grew at an average 5.3percent in the last financial year, compared to a growth of 5.1 percent during the same period in 2022.

Tabling the proposed budget for 2024/25 in the house on Monday, Dr Nchemba said that the growth was a result of various strategic investments in key sectors of energy, transport and services, increased production in the mineral sector and tourism.

"Economic activities that have led to the growth include agriculture, works and mineral extraction and many others which the government has been investing in heavily," he

The shocks include the Russia/ Ukraine war and Covid-19 in which the government introduced subsidies in fertilizers and fuel to cushion the economy.

He said Tanzania's economy grew at a rate of 4.7percent in the year 2022 and is expected to grow further at a rate of 5.2 percent in 2023 and 5.8 percent in 2024 respectively.

He said the targets which were used to prepare the plan's expectations was the participation of the private sector in the investment sector, business and its sustainability to shocks such as drought, wars and pandemics.

Others are the availability of peace and political stability in the country caused by strengthened food security and the security of neighbouring countries.

The minister said there were opportunities which emerged during the implementation period of the previous budget include increased food demand on the global market, increased food demand on the local market and increased manpower caused by the fact that rise in the population whose majority are youth.

The varsity has also validated the revised curriculum of post diplomas to bridge the gap of experts and thus meet the market driven demand.

The don said MUHAS has done a number of researches in malarias and AIDS/HIV to mention a few and have contributed tangibly to the health sector and formulation of policies.

"As a result MUHAS has been ranked third in the 2023 Sub Saharan University rankings, and the fifth in the list of African best universities," he said.

HEET Coordinator at MUHAS, Dr Nathanaeli Sirili said so far the university has reviewed 79 and form new 21 curricula at post diploma which is equivalent to 29 percent.

He said the revised curricula will be submitted to the varsity's senate before handing it to the Tanzania Commission for Universities ((TCU).

HEET is a \$425million funded project. It was approved by the World Bank in May 2021 and will be implemented over five years until July 2026. The project is an investment Project financing (IPF).

Nvanto who doubles as Chairperson of the conference organizing committee noted that apart from policies, education is a powerful tool for dismantling the post slavery legacy and the government must ensure that the educational curricula include a comprehensive and accurate account of the history of slavery and its effect to raise awareness and promote understanding among younger generations.

Dar es Salaam Regional Commissioner, Albert Chalamila said that eradicating post slavery legacy in modern African countries is complex and multifaceted since

He noted that while the progress may be slow and obstacles formidable, the pursuit of justice, equality, and healing is essential for the well-being and prosperity of the citizens and African nation in general.

By acknowledging the past, investing in education, promoting economic empowerment and fostering cultural preservation we can overcome the slavery legacy and pave the way for the future, he said.

"Currently we have an on-going mission of abolishing all illegal dens that are hosting children against their will for their own benefit and all this is to eradicate all forms of slavery that is conducted to these voungsters without them knowing," noted Chalamila.

## Newsrooms need to develop a mental health strategy for climate journalists

T has been four years since Hurricane Dorian ripped across the Caribbean islands, Lyet some of the images from that storm still haunt me.

As the team from CCN TV6 from Trinidad and Tobago landed in the Abaco islands, in northern Bahamas, we were met with a hot, putrid stench. There were no birds. There were no trees.

The stress of working near places of death, infection and continued conflict was gradually settling in. It was not my first assignment abroad during hurricane season in the Caribbean, but it was the first one for which I felt mentally unprepared.

Journalists are often the first to respond to major weather disasters. Our role is to provide information even when we are working in the most dangerous, upsetting and hazardous settings.

And yet witnessing trauma can impact us long after the incident has ended. When it comes to disasters fuelled by climate change, we also face the prospect of covering the same kinds of disasters again and again, wearing down our sense of agency and impact.

We already know that frontline journalists face physical risks in the course of doing their jobs, particularly when covering war or conflict. Many newsrooms throughout the world have regular checklists to prepare for and manage the dangers of covering certain hazards and events.

The same preparedness for mental health, especially covering climate-linked disasters, is however almost unheard of. It is past time to fix that.

Journalists covering climaterelated catastrophes should be given mental health checklists that outline what their newsrooms will do before, during and after a potentially stressful assignment.

The media industry also needs to prepare support for journalists to recover from mental health issues when they do happen. In general, communicating about mental health, including anxiety and depression, should be part of newsroom culture.

We already know that journalists can suffer psychologically while doing their jobs. Multiple studies have shown that at least 80 per cent of journalists have witnessed a traumatic event, according to the DART Centre for Journalism and

The centre reports that many journalists have experienced not

just one but multiple traumatic

A 2019 paper on journalists covering Hurricane Harvey, for example, found that 20 per cent of journalists developed storm-related PTSD afterwards, while 40 per cent developed signs of depression.

Incidentally, PTSD - or posttraumatic stress disorder commonly described as a disorder that develops in some people who have experienced a shocking, scary or dangerous event.

It is natural to feel afraid during and after a traumatic situation. Fear is regarded as a part of the body's "fight-or-flight" response, which helps people avoid or respond to potential danger.

And yet, rather strangely, it is often assumed that journalists are only exposed to traumatic events on certain beats - covering deadly crimes or wars, for example.

Unfortunately, mental health is particularly taboo in many newsrooms and many parts of the world. At a recent TechCamp Bridgetown for Caribbean journalists in Miami, Florida, there were deliberations on how many news organisations do not provide counselling services following catastrophic weather-related disasters and other traumatic events.

Many Caribbean journalists I have spoken with say that they keep this trauma to themselves, and attempt to find ways to manage the stress on their own.

Meanwhile, disaster reporting is becoming more common at Caribbean news organisations. This is because climate change is making these events more frequent and more intense - there are simply more storms, more severe droughts, more disasters...

As my colleagues and I flew over the Bahamas' hurricane-ravaged islands that day, we became quiet. We worked non-stop for three days, reporting on the efforts of emergency response personnel and filming as individuals were escorted onto boats and flights out of the most disaster-stricken areas.

I can still clearly picture the island where the hurricane's landfall took place. People sobbed in both French and English while clinging to their family members and whatever possessions they could find.

Many individuals stood in the heat looking up at the sky in search of hope. To this day, I still worry that my interview questions caused further harm to the already vulnerable situation that so many individuals were in.

Many journalists are discouraged from getting treatment when they need it because the people they cover are experiencing much greater suffering. The media practitioners feel guilty for being upset by what they have seen, when they believe someone else has it far worse.

This guilt, however, does not lessen the impact of a traumatic event. It just prevents reporters from receiving assistance and makes recovery more difficult.

Upon returning to our island after covering the hurricane, we were congratulated by peers for our great work. But there was no culture for recovery. Deadlines were fast approaching and more storms were looming.

We had no official psychological support in the days that would follow - that is, besides the comfort we found in each other through our brief chats about our experiences. I wore my anguish well and reminded my colleagues to be strong, because the job was not done yet.

Although some in the Caribbean may view the mental health burden on journalists as taboo, it doesn't need to be this way. There are simple things newsrooms can do to recognize the impact this has on their staff and therefore help them cope.

By creating a mental health checklist, managers can quickly draw on the frameworks they already have for dealing with physical hazards.

They can also draw from resources like the DART Centre, and can recognize the impact which disasters have not just on the frontline reporters and camera crews but also on the video and content editors back in the office who will view distressing footage.

Climate journalists fulfil one of the most crucial roles in civil society: informing the public about how warming temperatures influence their daily lives and threaten their safety. But journalists are also people. We require support and compassion just like anyone else.

methods of production and service delivery have historically suffered from advances in technology and often lost the battle since the trend in economy is competition, and that means lowering prices.

It is unclear whether there are vast differences in payments to those who help tourists climb Mount Kilimaniaro relative to those offering similar services elsewhere - and indeed with how labourers in the country generally are paid. Seeking elevated packages often cripples industries.

That is why those interested in tourism expansion will be looking askance at any pressure to raise what porters and cooks are being paid. This would apply even as, only a few months ago, the government issued a pay scale of minimum wages for various categories of domestic servants.

As these include guards, it is evident that porters and cooks are regarded as household aides and not professional or formal sector employees per se. On that basis, there won't be much for arbitration.

There are efforts to arbitrate in a wage conflict involving porters, cooks and tour guides on Mount Kilimanjaro, the idea being to propose wage rates for placing before a board of arbitration.

A constituency legislator boasting many years of experience as a bank executive raised the matter in the legislature not so long ago, bringing greater public attention to the issue.

The MP's demand was a review of rates paid to porters, cooks and tour guides, but it was unclear if the levels are below the formal recommended pay as minimal

There was a time tourism administrators were speaking with disdain about 'budget tourists' and ostensibly seeking 'upper class tourists' capable of spending more for the scenery and the services.

However, the government has been busy moving to attract more tourists, without any visible concern for the levels of spending, whereas wage hikes can unravel such plans.

Some of the deputy minister's remarks weren't quite clear on the direction the matter has taken, including in explaining that the ministry and tour agencies' representatives, their employers have started executing implement a number of strategies to make improvements of the pay rates for their wages.

## More efforts needed for fight against child abuse, GBV to succeed

ANZANIA is credited as the first country in Africa to undertake A National Study on Violence against Children - giving national estimates on the magnitude of sexual, physical and emotional violence affecting girls and boys. Multisectoral Task Force was conceived in September 2008, which consists of representatives from government ministries and partners including the police and justice sectors, social welfare, education and health care sectors; the United Nations and civil society organisations.

The study entitled 'Violence against children in Tanzania' found that nearly three out of every 10 girls (27.9 [percent) aged 13 to

24 years in Tanzania reported at least one experience of sexual violence prior to the age of 18. Among boys in the same age group, one out of every seven boys (13.4 percent) reported experiencing at least one incident of sexual violence prior to the age of 18 while nearly 6% of girls have been physical forced to have sexual intercourse before the age 18.

November 25 to December 10 this have been scheduled by The United Nations-funded project 'Women, Leadership, and Economic Rights' for the fight against Gender-Based Violence (GBV) and child abuse in Tanza-

However, informed by prevalence of the vice, Temeke Municipal Council started organized awareness raising events from November 2 towards the climax next month. The events brought together pupils from Mtoni, Sandali and Martin Lumbanga primary schools whereby they were sensitized about the importance of speaking up against any form of abuse as well as self-protection against the vice.

Speaking at one of the events recently, Temeke Municipal Council Senior Community Development Officer, Herieth Kamara, noted that children were the major target in sending the message against all forms of violence against them owing to their level of understanding.

"We focus on primary school children because they are too young to note the violence. They are prone to physical and emotional abuse. Children are at risk of being physically abused in school and at home and are mostly unaware of how to report the vice to relevant authorities," she said.

"We think that by engaging them in open talks and discussions, they will be in a better position to avert the imminent crisis.'

Inspector Blandina Ndunguru, officer in-charge of gender and child desk at Chang'ombe Police Station who was a facilitator said the authorities had seen the significance of ensuring children know their rights alongside means of fighting all forms of physical and emotional abuse together with the tactics of self-protection against

"Experience has shown that children are mostly abused by older people who are closer to them in a fam-

ilv. But I think parents are dutybound to ensure their children's safety. Parents should also refrain from fronting self-interests at the expense of the abused child, a situation that sees most of them bribed by the perpetrators to avoid litigation," she said.

Common abuses that are frequently reported are related to physical violence including corporal punishment and sexual violence to children especially from underprivileged families.

Such cases of abuse in school settings are increasing in most Tanzanian schools. Instead of the learning facilities becoming centers of support, they are becoming places where different kinds of abuse happen.

Corporal punishment in Tanzania is still allowed under a 1930 law and is the most common type of punishment imposed by the courts for persons less than 18 years of age for almost all kinds of offenses.

It is widely accepted as a disci-

plinary measure in childrearing and is not perceived as harmful or abusive. It only becomes violence when it exceeds and hence violates children's rights that are to be pro-

Sexual abuse of children is also rife in most schools. It is fundamentally an expression of power over a child's life, and children have little control over their lives and are usually disciplined with corporal punishment.

Tanzanian children are accustomed to seeing men hurt weaker people without censure, and the children do not have the power to defend themselves against physical, psychological, or sexual abuse.

A recent report by the Legal and Human Rights Center showed that child abuse is on the rise and is the leading violation of human rights in Tanzania. The report documented 350 cases of violence against children in 2022 alone, with 81 percent of them being sexual abuse.

Devotha Nchia, Temeke Munici-

pal Council Development Officer, expressed concern that in all child abuse cases, children are being harmed by the same people who should be protecting them, including uncles, parents, guardians, teachers, and family members, citing an example where she had intervened to educate a neighbour who had been incessantly spanking a grade two girl over trivial mistakes, only for the neighbor to accuse her of meddling in family

According to Nchia, education against child abuse should not only end in awareness sessions with school children but also the entire community which must understand hence live in fear of facing the wrath of the law in case prosecution and conviction.

Florence Mugarula, a parent who once lived in in the United Kingdom, said that children should always have sessions with teachers where they get an opportunity to explain anything related to violence

or any kind of mistreatment, expounding that while at home, they should be raised in a way that makes them comfortable to report anything unusual to their parents or guardians.

According to Mugarula, children in the UK are made to cram emergency numbers and can ring to the police or an ambulance anytime they encounter a kind of abuse in a given environment, adding that there is no excuse for violence against children because there are evidencebased tools to prevent the vice whereby almost all major streets are inundated with telephone booths to facilitate reporting of crime.

Recently, there have been calls to tighten penalties in the Child Act of 2009 to enforce legal provisions that would protect Tanzanian children from violence in different forms, including at family levels.

Dr Dorothy Gwajima, the Minister for Community Development, Gender, Women, and Special Groups, was quoted as saying a special taskforce has been formed to work closely with the Director of Public Prosecutions in reviewing the act for proper amendment.

"My ministry has seen weakness in section 29 of the Child Act, and already the government is in the process of working on it accordingly," she said in one of her press statements last year. The taskforce is meant to partner with other stakeholders to ensure that children are protected from the effects of digital transformations.

The 2009 Child Act provides reform and consolidation of laws relating to children, stipulates the rights of the child, and promotes, protects, and maintains the welfare of a child with a view to giving effect to international and regional conventions on the rights of the child in Tanzania.

The Act also provides for affiliation, foster care, adoption, and custody of the child, to further regulate employment and apprenticeship, to make provisions with respect to a child in conflict with the law, and to provide for related matters.

The United Nations Children's Fund (UNICEF) has also joined the media, children's rights activists and the government to push for further steps aimed at protecting children from violence.

The up-to-date data from the Ministry of Community Development, Gender, Women and Special Groups shows that Tanzania has more than 800,000 street children in various cities.

Evidence on Online Child Sexual Exploitation and Abuse (OCSEA) report released in June last year indicated that 67 percent of children in Tanzania aged between 12 and 17 years are internet users.

The report says that four percent of internet-using children were victims of grave instances of online sexual exploitation and abuse. Those children were either blackmailed to engage in sexual activities, their sexual images shared without permission, or they were coerced to engage in sexual activities through promises of money or other gifts.

## Facts behind high-incidence but undetected hypertension

INCE her childhood, Parveen Begum, 52, has been adding extra salt while eating her meals. However, she did not know that this contributed to high blood pressure.

Recently, she suffered severe headaches, forcing her to go to a physician, and when the doctor checked her health, he she had hy-

"I could not take my daily meals without taking additional salt, which helped develop the chronic disease in my health. Now I have to take medicines for blood pressure regularly, putting an extra financial burden on my family," said Parveen, a resident of Musapur at Raipura in Narsingdi district.

Rabeya Begum, 50, is a resident of the saline-prone Ashabaria village of Rangabali in the Patuakhali coastal district. Like many others, she and her family members often drink saline water since freshwater sources are affected every year due to coastal flooding, cyclones, and storm surges. Salinity instruction has reached the aquifer in her locality.

Local people face scarcity of drinking water during the dry season as salinity reaches an acute level that time, so they are compelled to drink saline water, Rabeya said.

"I felt symptoms of high blood pressure like headache and chest pain. So, I checked it and found blood pressure. But there are not enough facilities for screening blood pressure in our remote village," she

Like Parveen and Rabeya, a huge number of people have been suffering from high blood pressure, also called hypertension, in Bangladesh, but most of the cases remain undiagnosed. High blood pressure is a chronic disease and a silent killer,

More than 4.5 crore people, or 25% of Bangladesh's total population, have high blood pressure, according to recent research by Bangladesh's National Centre for Disease Control (NCDC).

Hypertension or high blood pressure develops when the pressure level in one's blood vessels reaches 140/90 mmHg or higher. A healthy lifestyle, quitting tobacco, and remaining more active can help lower blood pressure.

According to the World Health Organization (WHO), around 1.28 billion adults aged 30-79 years worldwide have hypertension, with two-thirds of them living in low- and middle-income countries. An estimated 46 percent of adults with hypertension are unaware of their condition. Only less than half of adults (42 percent) with hypertension are diagnosed and treated.

#### **Undiagnosed hypertension**

Undetected high blood pressure could add to the health burden in Bangladesh. Many people are not on medication as they are unaware of their condition. According to a survey, more than half of hypertensive patients are ignorant of their condi-

Experts say early identification and improved hypertension screening can reduce the high global burden of untreated high blood pres-

According to a 2022 study, hypertension is common in elderly people, and undiagnosed hypertension increases with age. The risk of undetected hypertension was high among people aged 33-35. Overall prevalence of undiagnosed hypertension among men and women was similar. Men aged above 50 had lower levels of awareness and participation in early detection initiatives.

The study revealed that the prevalence of hypertension is significantly higher among the residents of Bangladesh's coastal and eastern regions.

It suggested that early detection and screening are urgent for checking the prevalence of undiagnosed hypertension. The study suggested the authorities should take robust health promotion measures in the coastal and northern regions of Bangladesh.

Dr Mahfuzur Rahman Bhuiyan, programme manager of the High Blood Pressure Control Programme at National Heart Foundation Hospital and Research Institute, said it would be possible to reduce the risk of high blood pressure by 50 percent if people avoid the intake of extra salt while taking meals.

He recommended screening people to identify those with high blood pressure.

#### Hypertension amplifies risk of heart diseases

Hypertensive heart disease is a long-term condition that worsens with time. In Bangladesh, around 68 percent of deaths are caused by non-communicable diseases, with hypertension accounting for 15-20 percent.

According to the first Global Report on Hypertension 2023, released by the WHO, about 273,000 people die of cardiovascular diseases each year in Bangladesh, while around 54 percent of these fatalities are attributable to hypertension.

The report also reveals that half of the people having hypertension are not even aware of their condition, and the rate of those receiving medical treatment for hypertension is alarmingly low, merely 38 percent.

"Hypertension is one of the leading causes of deaths associated with non-communicable diseases. The prevalence of heart diseases can be reduced to a great extent by keeping hypertension under control," Prof Sohel Reza Choudhury, Head of the

Department of Epidemiology and Research at the National Heart Foundation, told a webinar recently.

National Professional Officer at WHO Bangladesh Office Dr Farzana Akter Dorin, suggested strengthening the

primary healthcare system and ensuring free hypertension medicine to cut the risk of developing heart diseases among people.

## The relentless struggles of India's seawall mammas

THE sun is high in the noon skyhumidity unrelenting at 95 percent in this Indian sea-coast village. The monsoon has been deficient; rice paddies are yellowing on the edges from the salty surf misting in on them. Waves now break barely 200 metres from the farms and homes.

Sixty-year-old Bengalata Rout heads for the Casuarina "forest wall" off the shoreline, trees that the women in the 108-household village Tandahara planted after the 1999 Super Cyclonic Storm decimated their mud-walled thatched-roof huts leaving their fertile farms salt-poisoned.

That year, 33 years ago, they planted the trees on the village boundary, a good distance away from the shoreline; today, on a stormy night, the sea crashes against the tree trunks, threatening to run amok into their homes.

Tandahara, sitting on the Bay of Bengal, is one of the last villages in the eastern Indian State Odisha, some 20 kilometres from Konark Sun Temple, UNESCO's designated heritage site that is itself showing the impacts of seas closing in.

#### The 'big storm' discovery

"When the big cyclone hit us, the Casuarina shelter belt that was standing from before, planted by the government, lay battered," Rout told Inter Press Service (IPS) as we walked toward the Casuarina forest. "We immediately realised had it not been standing there between the sea and our village we would have been wiped out."

And it was a life-changing discovery for these rural women.

The category-5 storm, carrying wind speeds of 160 miles hourly that made landfall over Odisha in October 1999, killed more than 10,000 people, mostly owing to 20 ft high storm surges that brought water 16 to 20 miles inland.

But Tandahara had not lost a single life. Losing no time, every woman volunteering, even the children clamouring to pitch in, they sorted themselves into ten groups of ten members with a mix of young and government and non-profits who came to help. Planting was done; the men lent a hand, but the women took it upon themselves to make sure the saplings survived.

"It was challenging. The soil had salted up, and the young plants struggled to survive," said Kanaka Behera, 32, one of the younger women. "And the water we got in our village had turned a bit saline also."

"We thought, for our cooking and drinking, we fetch groundwater from a shallow dug pit; why not get the sweet water for the plants, too? But that was a kilometre inland from our village, more distance from the plantation in the opposite direction. We will do it, we decided and dug the pit wider to get more water," Behera added.

"For months till the plants survived, we would be up before the sun, lining up our buckets around the water pit where water replenishes naturally overnight. Then the real arduous work began," said middle-aged Bena Mallika dressed in a bright green sari. Some ten of them would fill the buckets and hand them to ten others who relayed them to more waiting women till the saplings, one-and-half kilometres away, were sloshed and glistening. Only by noon, they were done, exhausted but triumphant, having carried one thousand buckets to the plants. They did this every alternate day. Meticulously, around each baby tree, they gouged a six-inch wide circular channel with their bare hands to hold the sweet water for longer and create an oasis of nutrition.

#### Climate events more frequent, intense as the sea keeps getting

But growing tree shields is a daunting exercise against a wounded, intermittently raging ocean. It is a handful of strong-willed women pitted against climate events getting more frequent and more intense from a rapidly warming sea. Odisha has encountered 10 cyclones in a

span of 22 years from 1999 to 2021, with frequency rising over earlier decades, according to data from the Odisha State Disaster Management Authority (OSDMA), which works to reduce disaster risk.

More broadly, the Indian subcontinent has witnessed more than 478 extreme events since 1970, whose frequency has accelerated after 2005, IPS had earlier reported.

But another phenomenon, more insidiously devastating, is creeping in on Tandahara.

Sitting on a cemented platform under the shade of an ageing banyan tree, there are several elders who share how the sea has moved closer. Remembering over five decades back, 70-year-old Tahali Kalia Gopal Behera narrated to IPS, "When I was 18, we youngsters went to the sea to catch the red beach crabs. We carried our lunch and left home in the morning, returning only in the evening. Those days, the sea was more than 3 kilometres away.'

"The sea has eaten away 20 hectares of our village land," Bidyadhar Bhuyan, another elderly man, said.

Of Odisha State's over the 480-kilometre coastline, a high 79 percent has experienced drastic modifica-

The State's coastline change trend shows 21 percent has been subject to erosion, and 51 percent is impacted by accretion. Based on 26 years of old. Saplings were requested from satellite images, the 2018 study by the National Centre for Coastal Research of Earth Sciences Ministry remains the latest using such extensive

Oxford University research from across 52 sites worldwide on 'naturebased solutions' said coastal forest walls, mangroves and coral reefs cause waves to break before they hit the shore or ingress towards human habitats, lowering both the force and height of the swell and in the process reducing the likelihood of the sea breaching over into people's land.

The study found that natural habitats were 2-5 times more cost-effective than engineered structures, like the geotextile tube installed in another affected district in Odisha, which was in tatters within 10 years. These (like Tandahara's bio-wall) can help to protect from climate change impacts while slowing further warming (by carbon sequestration), supporting biodiversity, and securing ecosystem services, researchers widely believe.

#### Of bulls, goats and other challenges

As the Bay of Bengal became a hotspot for tropical storms and waves inched closer to Tandahara, coating salty mist day and night on everything, their staple rice crops began failing. Employable males migrated

Left behind with children and ageing parents to make ends meet were again the women. They began goatkeeping. The 108 households have no less than 500 goats today.

One adult goat weighing 15kg can easily fetch up to INR 8000 (USD 96.3), extra during festive seasons.

will rush and help chase it out. "If cattle destroy the plants, their owners have to pay a 100 rupees (USD 1.2) penalty, Rout explains, sighing in relief on seeing no intruder. "To get a hungry bull off the plantation requires more than one woman. If a help call is shouted out, but the group member whose house is closest does not respond, they are charged 100 rupees as well," she explains how strict community rules have helped them grow the tree wall.

Seeing their zeal, in 2000, the forestry officials mentored them to form a village Forest Protection Committee. They were provided, one-time and free of cost, several large party-sized ironware pots worth 60,000 rupees (USD 722.8) to rent out to village events and maintain bank funds.

"Were this active group not been looking after the coastal forest, even when the government plants and sometimes waters them too, they would not remain alive beyond a month. There is a strong sense of ownership instilled within them. With them, we have a true partnership," a local supervisory-level government forest official told IPS, wishing not to be named as they were not allowed to speak to the media.

#### Green walls provide direct and indirect income for an entire vil-

When forest officials came with saplings this monsoon, the nearby beach was littered with dead Casuarina stumps and branches left from an earlier storm and proliferating beach creepers. The women's group offered to clear the large stretches. In return, they got to take home the dead wood.

"With the thinner branches, we were able to repair seaside fences,' Kanaka Behera told IPS. The official would otherwise have hired contractors' men on wages. "We take ownership of the storm walls. We will patrol till the saplings are grown."

#### Eco-friendly library built from plastic bottles to help needy Ghanaian children

A MULTIMEDIA library, built from recycled plastic bottles by an African architect, was inaugurated late Tuesday in Kokrobite, a fishing community on the outskirts of the Ghanaian capital of Accra, providing schoolchildren from impoverished families with access to an array of learning resources.

The newly constructed building, which stands out from the many modest structures around it, was built using 45,000 recycled plastic bottles. Inside, the library is wellstocked with books covering topics from archaeology to zoology, as well as tablets and laptops fully connected to the Internet. The serene environment provides an ideal space for learning.

Martial Bruce Zohoungbogbo, who holds dual citizenship in Ghana and Benin, told Xinhua that he built the "bottle house" with funds raised by him and his wife, with the help of many locals from one of the least developed communities in the region, where most families rely on traditional fishing and struggle to afford better education for their children.

The building is primarily composed of two sizes of plastic bottles. The larger bottles, filled with soil and securely tied with ropes, were used as "bricks" for the walls, while the smaller bottles were

layered to form columns. Martial described the structure as "waterproof, fire-resistant, bullet-proof, and earthquake-proof."

Martial, who came to this community some 30 years ago, learned the technique of building architecture with plastic bottles from a German architect. After learning that local children had long been grappling with inadequate spaces and resources for learning, he decided to use his architectural expertise to make a difference.


Jane Zohoungbogbo, Martial's wife and the chief executive officer of the Kokrobite Chiltern Center, a non-governmental organization, said the facility will greatly support academic work in the community.

"Children from communities like this don't have many opportunities. But if you have an education, you have a choice, and then you are much more likely to have opportunities," Jane said.

Students use tablets at a multimedia library built from recycled plastic bottles in Kokrobite, a fish-

"The library is the first one we built with bottles, but it's our second center. At our first center, we currently have about 50 children who come every afternoon during the week and up to about 140 or 150 on Saturday mornings," she added.

The building has also boosted the community's confidence in the fu-

## Africans urged to wake up and smell the coffee

AFRICANS must wake up and smell the coffee and start believing in themselves and their brands if they want to be a force to be reckoned with in the global world.

These were the words of Thebe Ikalafeng, one of the 100 Most Influential Africans, when he delivered his address at The Bull's Kraal Black Conversations organised by Castle Mild Sout to celebrate African culture.

"For as long as Africans still uphold and continue to admire Western brands at the expense of their own, they will never reach the top-notch mark with their own brands. We should learn to uphold and admire our own brands and build them to the level of those from the Western world," Ikalafend said.

He narrated a story of a boy from Daveyton who once remarked that he would not buy jeans created by Tshepo Jeans for R2 000 because they were too expensive for a Kasi boy that he grew up with in Daveyton and said he would rather buy these Western brand for even much more than a brand from a Kasi boy.

"With this mentality, we will never go far in building our own brands and developing ourselves as African people because we look down on ourselves and so much believe in Western

"If our own Kasi boy has created these amazing top-quality jeans, why can't we support him and grow his brand to be up there with the best the world can offer? There is also the Batho tekkies brand that some top American brand has been wanting to buy out because it was killing the market for theirs. I am glad Batho stood firm and never cowered to this elimination process so the West can always dominate us with their

own brands," he said. This was also echoed by Mzilikazi Wa Afrika, an investigative journalist and advocate for a brand-led African renaissance, who urged Africans to outgrow the belief in Western brands and start building their own.

"For how long are we going to be enslaved by Western brands and suits in our own Parliament and not wear our own traditional clothing attire, which in this country is worn once a year during Heritage Day," Wa Afrika asked.

He also mentioned an incident at some mall in Midrand where a Ndebele man wearing his traditional gear was booted out of the mall and accused of being scantly dressed and exposing himself to the disgust of other shoppers. "What nonsense is this in this day and age of our democracy," Wa Afrika wondered.

This was echoed by Buhlebendalo Mda, a heritage enthusiast and healer, who urged Africans to transcend such belittlements and start the journey to build and market their own brands without fear.

"We need to try harder and be fearless in building our brands and marketing ourselves as African regardless of what the next person says and believes. We live in a world where we are influenced by so many things and cultures and as South Africans, we must try never to lose our culture and focus. We need to give ourselves credit instead of constantly criticising and blaming each other for losing our-

## Programme bears fruit in southern highlands regions, as new-borns are now free from HIV

THE HIV prevention-of-mother-to-child-transmission (PMTCT) programme implemented by the HJF Medical Research International (HJFMRI) in the Mbeya Region has to a large extent helped pregnant and breastfeeding mothers to prevent their new-borns from contracting HIV and suppress their viral load.

The HIV positive mothers receive care and treatmentantiretroviral therapy (ART) at their health facilities.

Lucy Mwambaje, a resident of Ihanga village in Mbarali District, Mbeya Region is one of the beneficiaries of the programme despite being diagnosed with HIV in 2008, she has been able to give birth to three children and they are all negative.

"When I was diagnosed HIV positive at the Mbarali District hospital, I accepted the situation and was ready to start antiretroviral (ARV) treatment. Doctors advised me to wait because, at that time, my CD4 count was high (600). I started medication in 2009 when I got pregnant and that's when I knew about the PMTCT program. I started taking drugs to protect my baby and was also educated on how to breastfeed and care for the infant so that I don't infect him," said Mwambaje, noting that her husband is also HIV positive and is on medication.

Winfrida John, a mom-to-mom (m2m) mentor under the HJFMRI programme who was born positive in 1991 has successfully given birth to two children who are HIVnegative, linking the situation with medication adherence.

Narrating her journey, she said that before knowing her status, she was suffering from several diseases until November 5th, 2005 when she tested positive at Mbeya referral hospital and started medication (ART) by that time, her CD4 count was 9.

"I was taking my medicines properly; in 2015, doctors told me that my viral load was suppressed with a CD4



count of 1,000. I started the mentorship program in 2016 and I have so far reached 200 HIV positive pregnant and breastfeeding mothers," she said.

The HJFMRI implements a supported HIV care and treatment programs with funding from the US President's Emergency Plan for AIDS Relief (PEPFAR) through the Walter Reed Army Institute of Research (WRAIR) of the US-Department of Defense (DoD) in close collaboration with the Tanzanian Min-

istry of Health (MoH) and the President's Office of the Regional Administration and Local Government (PORALG).

The interventions supported under this program include PMTCT which mainly focuses on preventing vertical transmission of HIV to new infants before and after their births in the regions of Rukwa, Katavi, Mbeya, and Songwe.

Winfrida John thanked the HJFMRI and the Tanzanian government for ensuring the availability of these interventions.

ers she mentored have given birth to HIV-negative babies. She however said there are few pregnant women who could dodge the clinic and sometimes fail to collect their medicine on time. Winfrida said she conducts vis-

its to pregnant women who are on HIV treatment and looks out for women who are reported 'lost to follow-up' and re-link them to care. Atuita Chaula, a mom-to-mom

(m2m) mentor at Igawa dispensary in Mbarali District who was diagnosed HIV positive in 2013 said that she has reached over 70 pregnant women who are on HIV treatment.

"We have succeeded in making sure all the HIV-positive pregnant mothers linked to care continue with the service. Of the 72 mothers on treatment, 52 are now breastfeeding," she said, commending HIFMRI for training them on how to link pregnant women to care.

The In-charge of the Reproductive and Child Health (RCH) department at the Mbarali District Hospital, Bertha Masawe said that all the mothers who seek maternity clinics at the hospital are tested for HIV whereas those diagnosed positive are enrolled for treatment.

She said while on medication, mothers are closely monitored until they give birth. She said the newborns are also monitored to make sure they don't get infections from their mothers through the provision of education to mothers on how to breastfeed and use medicines properly.

"The engagement of mom-tomom (m2m) mentors in the program is good because apart from providing education to pregnant mothers also they remind them on the dates to collect medicines and the importance of using the drugs correctly. Mom-to-mom (m2m) assists us to inspire newly diagnosed HIV-positive mothers because even the pregnant women who are HIV positive get motivated by seeing their peers in a jovial mood and healthier," said Masawe.

## Fighting malnutrition and changing mindsets in Rwanda

F the many things one might associate with a modern teenager, passion for wholegrain food is probably not the first that comes to mind. An innovative school-meals project in Rwanda, however, has young people singing its praises.

"Eating wholegrain maize makes our bodies strong and healthy," said Julienne, a 15-year-old student at Kibirizi primary school in the Nyamagabe district in the south of the country.

"It is very tasty and nutritious."

Julienne is one of thousands of Rwandan students who have been getting school meals as part of a UN World Food Programme (WFP) project in which fortified refined maize meal has been replaced by a fortified wholegrain version.

The fortified wholegrain maize meal is used to make "kaunga", a sort of stiff porridge that is served with beans and vegetables in schools.

It is an exciting trial for WFP, which was awarded the Nobel Peace Prize in 2020 for its efforts to provide food assistance in conflict zones and to prevent the use of hunger as a weapon of war, to integrate wholegrains into school meals. Food is usually fortified to reduce micronutrient deficiencies in the people who eat it by adding vitamins and minerals to the refined versions of staple grains.

Fortification of wholegrain flours, where virtually all the grain remains in the processed product, has largely been unchartered territory up to now.

But it is potentially a promising way to increase the micronutrient content while maintaining the health benefits of wholegrains, which provide more protein, fibre and micronutrients than refined foods.

Wholegrain foods also have a cost advantage over refined versions because a higher yield is extracted from the raw materials.

So getting people to acquire a taste for wholegrains is a good way to boost nutrition and food security.

The WFP project in Rwanda, which was launched in 2021 in partnership with The Rockefeller Foundation, is doing precisely that. The Rockefeller Foundation has also enlisted the help of a local partner, Vanguard Economics, to support the project.

The WFP Country Office has reported a big shift in student preferences thanks to the programme, with 97% saying they preferred the wholegrain versions to the refined equivalent because they liked the rich taste.

It also led to parents asking where they can buy the product on the market.

"The more nutritious foods children eat, the more active they are, and they perform better in school too," said Faustin, Julienne's father.

"I like the taste of the wholegrain maize and I would like to add it to the food we eat at home so that Julienne's siblings can also enjoy it".

WFP buys the fortified wholegrain maize meal from the same miller it got the fortified refined maize meal from.

"Before the pilot (project), fortified maize meal, purchased from a local supplier, was already a main component of school lunches along with fortified rice, fresh vegetables from school gardens, beans, fortified oil and iodized salt," said WFP's Tiina Honkanen.

"Together with The Rockefeller Foundation, we saw that if we could work with the existing WFP supplier miller to fortify the wholegrain maize meal instead of the refined flour, we could further increase the nutritional value of the school lunches, combining the benefits of both fortification and wholegrain, without having to change the school meal.

"We did not try to introduce a completely new product but focused on a food that was already being eaten".

The project also helps the local economy. WFP supports smallholder farmers to improve their quality and vields and connects them to viable markets to sell their supply. Such is the case for a number of WFP-supported maize farmers, who sell their maize to the WFP supplier miller who produces the forti-

fied wholegrain maize meal. "Before, getting buyers was not so smooth. What

excites me most is knowing that WFP buys [the end product] to distribute in school meals," said Immaculée, a farmer from Nyaruguru district of Rwanda.

"It feels good to know that your produce is reaching children in your very own community."

Aside from the success of the project itself, what makes it especially worthy of attention is the potential for it to be a model to replicate elsewhere.

In fact, fortified whole maize meal is now enjoyed by 180,000 school children in Burundi and another 60,000 in Kenya, with exciting scale-up prospects in all three countries.

"The pilot demonstrated that the substitution (of refined foods with wholegrain versions) can be feasible. budget-neutral and be well accepted by students and the school community," said Honkanen.

## Euro zone bond yields decline again, with central bank speakers in focus

LONDON

EURO zone bond yields fell slightly on Tuesday after rising the previous day, as investors focused on speeches by central bank officials in a relatively quiet week for economic data.

Global yields tumbled last week, dragged lower by a drop in US yields after the Federal Reserve held interest rates steady; the US Treasury said it would issue less longer-dated debt than expected; and data suggested the US economy might be slowing.

Germany's 10-year bond yield was last down 3 basis points (bps) at 2.705%. Yields move inversely to prices.

The yield, the benchmark for the euro zone, fell to its lowest in almost two months last week at 2.629%.

Emmanouil Karimalis, macro rates strategist at UBS, said bond yields were likely to waver around current levels as investors weigh up incoming data.

"The markets moved a lot last week on the back of data and more dovish central banks ... and yesterday we saw some repricing. So I think markets will probably be range-bound and wait for the next set of data," he said.

The economic calendar is relatively light this week, although data on Tuesday showed that German industrial production dropped by 1.4 percent monthon-month in September, far worse than the 0.1% fall economists expected.

central bank speakers' views on the likely path of interest rates.

Notable central bank speakers on Tuesday include ECB policymaker and German Bundesbank chief Joachim Nagel and Fed vice chair Michael Barr. Fed Chair Jerome Powell is due to speak on both Wednesday and Thursday.

The gap between Italian and German 10-year yields was little changed at 182 bps. The so-called spread, a gauge of investor confidence in the euro zone's more indebted countries, narrowed to its smallest since mid-September last week at 174 bps.

On Monday, European Central Bank policymaker Robert Holzmann said the central bank must remain vigilant on inflation and be prepared to raise rates again if needed. The ECB held rates at a record high of 4 percent at its last meeting in late October.

Germany's 2-year bond yield, which is sensitive to expectations about ECB interest rates, was last 1 bp lower at 3.085 percent on Tuesday. It has fallen from a 15-year high of 3.393 percent in July.

Australia's central bank raised interest rates on Tuesday, bucking the trend among developed economy central banks for keeping borrowing costs on

As of Tuesday, traders saw effectively no chance that the ECB would raise interest rates again, according to pricing in derivatives markets.

Markets think the ECB will cut interest rates by around 95 bps by the end of 2024, having only expected 80 bps of cuts as recently as two weeks ago.

## BoT determined to 'mop up' 100/-billion from the market

THE Bank of Tanzania (BoT) is seeking to mop up 100bn/- from the market, as part of implementation of less monetary accommodative policy.

The amount is expected to be wiped through Treasury bills, which will be auctioned today.

According to the BoT invitation tender, a total of 172.8bn/- are expected to be raised during the auction, as the remaining 72.8bn/- will be for government financing purpose.

Last month, the central bank also conducted two Treasury bills auctions, seeking to mop up 80bn/- for each auction.

During the first auction held on

11th October, the central bank intended to raise 152.9bn/- from the market of which 72.8bn/- were intended for government financing purposes and the remaining were for liquidity purpose.

However, during the auction, the central bank offered 51.9bn/for 182 days maturity, of which 83.56bn/- were tendered and 72.6bn/- for one year maturity of which 83.5bn/- were tendered.

At the end of the auction, the central bank accepted all tendered amount for both maturities, at a minimum discounted bid prices of 96.16/100 and 91.53/100 respectively.

Another T-bills auction was conducted on October 25th, of which the central bank intended to raise 72.89bn/- for government financing purpose and 80bn/- for liquidity purpose. At the end of the auction, the central bank intended to raise 152bn/- of which 8.9bn/- was for 35 days maturity, 18.9bn/- for 91 days maturity, 51.9bn/- for 182 days maturity and 72.67bn/- for one year maturity.

At the end of the auction, no bid was recorded on 35-days maturity, 4.5bn/- were tendered for 91 days maturity; no amount was tendered for six months maturity and only 19.1bn/- were tendered for one year maturity.

The results show the central bank accepted all tendered amount (23.6bn/-), which was massive under subscription against offered amount.

In its statement issued after the meeting last month, the Monetary Policy Committee (MPC) chaired by the central bank governor, decided to sustain the less accommodative monetary policy.

"The policy stance will continue to be implemented in close collaboration with fiscal and structural policies. Monetary policy measures will also be implemented to achieve the targets under the Extended Credit Facility Program for the quarter ending December 2023," the MPC said in a statement.

The MPC noted that the implementation of the less accommodative monetary policy successfully maintained liquidity in the economy at appropriate levels in August, September, and October 2023.

## Agricultural development bank gains Tier-2 status

THE Tanzania Agricultural Development Bank (TADB) has graduated into Tier-2 bank status, after its total assets surpassed half a trillion shillings

"Following seven years of our establishment, we have managed to graduate into Tier-2 bank status. This will increase our visibility in the market," said Dr. Kaanaeli Nnko, finance director and managing director, acting

Speaking yesterday when presenting the bank's financial results for the third quarter of this year, Dr Nnko said during the end of the quarter, total assets amounted to 535.2bn/-, slight higher than 500bn/- requirements.

During the third quarter, he said the bank's pre-tax profit amounted to 4.8bn/-, which is an increase by 28 per cent, from 3.8bn/- recorded during similar quarter of last year.

he said resulted from growth of both interest and non-interest incomes, which grew by 26 and 18 per cent respectively. Year-on-year interest in-

come amounted to 10.94bn/during the third quarter from 8.6bn/- recorded as at September last year, while non-interest income was 1.52bn/-. The finance director said,

the bank cumulative pre-tax profit at the end of the third quarter of this year amounted to 12.34bn/-, at the end of Sep-He said the bank has also

managed to maintain efficient cost to income ratio of 46 per cent during the end of third

The bank has also managed to improve its assets quality after lowering the rate of Non-Performing Loans (NPLs) to 4.58 per cent, which is less than the regulatory benchmark of 5 per cent from 5.4 per cent in September 2022.

According to Dr Nnko, the bank's impairment losses coverage is at 90 per cent.

"Loans and advances surged by an impressive 94.7bn/-, a 36 per cent increase. This surge solidifies the bank's unwavering commitment to providing vital financial support to farmers, agribusinesses, and various stakeholders across Tanzania," he elaborated.

The bank's Ag. Director of Credit and Business, Afia Sigge, said that in the third Quarter of this Year (Q3), a total of 61.8bn/- were issued as loans in the crop, livestock and fishing sectors in the country, reaching 1.7 million farmers in 27 regions and 124 districts of Tanzania.

Of the 61bn/-was disbursed to farmers, she said 40.2bn/disbursed for the purchase of inputs and costs of agricultural operations. 19bn/borrowed for the cost of construction of agricultural projects.

According to Sigge, a total of 1.2bn/- were borrowed from irrigation projects, while 1.19bn/- borrowed for the purpose of purchasing livestock, modern agricultural materials and warehouse construction.

On his part, George Nyamrunda who is the Agency Fund Manager for the Smallholder Credit Guarantee Scheme (SCGS), one of TADB's flagship initiatives, said the credit facility continues to make substantial progress.

He said the bank's collaboration with 16 participating financial institutions (PFIs) has extended its reach to beneficiaries in 27 regions and 127 districts, with a total disbursement of 228.2bn/- at the end of September this year, from 159bn/- recorded in Q3, 2022.

## Africa's e-commerce revenue to reach US\$59.18bn by 2027

NAIROBI

DESPITE many African ecommerce platforms struggling to attain profitability, the sector's outlook remains promising, driven by the digitalization of payments, the implementation of the African Continental Free Trade Area, and the advancement of deferred payment systems.

The overall revenue of active e-commerce platforms in Africa is expected to reach \$59.18 billion in 2027, up from \$32.49 billion in 2018, as estimated by the digital economy consultancy firm TechCabal Insights in a report released on October 12.

Entitled "Future of Commerce: Outlook for 2024," the report forecasts an average

annual growth of 10.4 percent in this revenue between 2023 and 2027, thanks to the increased number of online buyers, a surge in e-commerce platforms, and the continent's rising population.

Over the period, the number of African online buyers is also projected to increase by an average of 17.9 percent annually, reaching 609.3 million buyers in 2027 compared to 387.5 million in 2022

Consequently, the e-commerce adoption rate across the continent is projected to rise from 32 percent in 2022 to 44 percent by 2027, marking a notable increase of 12 percentage points over five years.

The primary contributing factors to this upsurge include the growing number of mobile internet users and the expanding embrace of digital financial services



such as mobile money and internet banking.

With sales forecasted to climb from \$13.93 billion in 2023 to \$20.08 billion in 2025, the electronics segment will steer the overall e-commerce revenue growth in the coming years on the continent.

Following closely are the segments of fashion items, with sales anticipated to reach \$11.44 billion in 2025 compared to \$8.46 billion in 2023, as well as toys & leisure, personal care, and furniture.

The report further unveils that 129 African startups specializing in online commerce raised a combined total of \$948.5 million between January 1, 2019, and June 30, 2023. The most substantial funding was secured by the Kenyan online platform Wasoko, focusing on food products, amounting to \$125 million.

Despite these funding rounds, a significant number of these budding companies are fac ing huge operational challenges and are

struggling to achieve profitability. Consequently, Zumi, Wabi, and Sendy have ceased operations, while Copia Global, Twiga Foods, and Marketforce have respectively laid off 700, 494, and 54 employees since the beginning of 2022.

Meanwhile, Jumia, despite implementing an aggressive cost reduction program, is still grappling with reaching profitability, mainly due to the escalating inflation across the various markets it serves.

Losses in the initial years of e-commerce platforms are not exclusive to African startups. An example is the American giant Amazon, which took eight years to become a profitable enterprise.

The report suggests a promising outlook for African startups operating in the e-commerce sector over the coming years.

The outlook is positive, especially as the companies are expected to capitalize on the growth of electronic payments in the continent, improved infrastructural and logistical capabilities following the implementation of the African Continental Free Trade Area (AfCFTA), and the ongoing development of Buy-Now-

Pay-Later (BNPL) services.

## China offers support to stressed developer

BEIJING

AFTER letting two of the world's biggest property developers' plunge into default, Chinese authorities are attempting to save a third industry giant from following suit.

China Vanke Co., the country's second-largest builder by contracted sales, received an unusually strong show of support from officials in its hometown of Shenzhen on Monday – following a dollar-bond plunge that made Vanke Asia's worst investment-grade performer last month. Its notes climbed as much as 4 cents Tuesday after some surged a record 12 cents a day earlier. Still, several of them remain at distressed levels of below 80 cents.

In an online call with financial firms Monday, the city's State-owned Assets Supervision and Management Commission said it has confidence in Vanke and enough cash and tools to support the builder if needed, according to people who listened into the call. State-owned Shenzhen Metro Group Co., Vanke's largest shareholder, said it has no plans to cut its stake and is actively preparing to purchase Vanke's publicly-traded bonds at the right time.

"The show of support from local authorities for Vanke is stronger than anticipated," said Leonard Law, senior credit analyst with Lucror Analytics Pte. While the move "certainly bodes well" for developers partially or fully owned by the state, it's "unlikely to benefit those that have already defaulted" or to be a turning point for the wider industry

Founded by Wang Shi in 1984 when China's economy was in the early stages of opening up, Vanke was the country's largest property developer for years before more aggressive peers Country Garden

Holdings Co. and China Evergrande Group topped it. Apart from its quality projects tailored to China's emerging and vast middle class, Vanke also became famous for a unique corporate style in the industry – an engaged board, diffuse shareholders and an entrepreneurial culture.

After Wang cautioned in 2013 that China's real estate sector faced the risk of a "bubble," Vanke made early efforts to diversify from property development. It operates rental apartments and has built a logistics portfolio and growing services business that has included an investment in and partnership with US-based office-property broker Cushman & Wakefield Plc.

Authorities' comments on Monday about Vanke – one of China's few remaining investment-grade builders – contrast with more muted official efforts to restore market confidence in Evergrande and Country Garden. Both of them defaulted on dollar bonds and are facing uncertain futures that include drastic restructurings or possibly liquidation.

As China's property crisis heads into its fourth year, authorities at both the national and local level have expressed greater urgency to stem the fallout from a sector that by some estimates had accounted for about a quarter of economic output.

Vanke is no stranger to having official support. State-owned conglomerate China Resources (Holdings) Co. was its largest stakeholder for almost two decades, until a yearlong takeover drama emerged in 2016. Evergrande briefly owned more than one-quarter of Vanke before Wang brought in Shenzhen Metro, owned by the city's stateowned assets supervisor. He then stepped down as Vanke's chairman.



Recent sector worries, fueled in part by Country Garden's woes, engulfed Vanke's notes last month. They lost 35 percent, the worst in a Bloomberg index of Asia investment-grade dollar bonds.

One note fell as low as 36 cents last week; it's since rebounded to 57 cents. That's the low end of Vanke dollar bonds' indicated range, which goes as high as 96 cents for a security due in March. The price disparity highlights how near-term investor concerns have eased substantially, even as longer-term uncertainty about repayment prospects persists.

The builder said in a statement after Monday's call that it "will definitely repay offshore and onshore debt on time," and that the "market doesn't need to worry about that at all."

Whether this marks a turning point for the broader property industry is unclear. Vanke's government-backing via Shenzhen distinguishes it from other privately run developers that have struggled to gain access to financing despite recent government efforts to provide more funding. Dollar bonds of investment-grade peer Longfor Group Holdings Ltd. trade at low levels below 50 cents.

Still, putting a line under the Vanke selloff would help authorities reduce the risk of another major property giant collapsing while they grapple with the fallout at Country Garden, Evergrande and a slew of other smaller distressed developers.

While regulators are unwilling to see defaults expand to other property firms, be they privately-run or state-backed, the reality is there has been no significant improvement in property sales or financing channels, said Wang Chen. He is co-founder of The Belt&Road Origin (Beijing) Tech Co., a credit risk analysis provider.

"If sales cannot improve," he said, "it is meaningless to talk about anything else."

## Aramco pays \$29bn dividend despite production decrease

ARAMCO maintained its dividend to the Saudi government despite a drop in production and weaker oil prices as the kingdom tackles a widening budget deficit.

The total payout of \$29.4 billion to the state and other investors, including a special component, held at the previous quarter's level even as lower output helped push net income 23 percent down year-on-year to \$32.6 billion in the third quarter.

The world's biggest crude oil exporter provides much of the Saudi government's income via generous dividends.

The distribution is becoming ever more vital as Crown Prince Mohammed bin Salman pursues expensive projects such as the futuristic city Neom, the purchase of high-profile footballers and stakes in sporting leagues, while looking to diversify the economy from oil.

But for now, oil remains key for Saudi finances. The market has shrugged off concerns that Israel's war on Hamas will spill over to the wider region and threaten global supplies. Brent crude is back to where it was before Hamas's Oct. 7 attack on Israel, at about \$85 a barrel. That's keeping the Saudis and their OPEC+ partner Russia intent on maintaining their unilateral output cuts for now.

They may be forced to prolong those curbs into next year amid signs that the physical oil market is weakening. Demand for fuels such as diesel is softening in Europe in a sign of lackluster economic growth.

Aramco's profit from its upstream business, which includes oil and gas output, dropped 23% to \$60.6 billion. Saudi Arabia is keeping production at near 9 million barrels a day, about 1 million below the average of the past decade. The Organization of Petroleum Exporting Countries and allied producers are scheduled to meet later this month to review their supply policy.

Aramco partially compensated for the drop in upstream earnings with better third-quarter refining margins, which pushed the unit to a \$5.3 billion profit from a loss in the same quarter a year ago.

The dividend for the quarter, a combination of a base payout and a component linked to free cash flow, draws on last year's bumper profits when oil averaged nearly \$100 a barrel. Other international oil majors have also prioritized shareholder returns, with Shell Plc increasing its stock buyback program.



## Africa needs enhanced tax collection to safe guide external Shocks

AFRICA needs enhanced tax collection systems that are supported by trade and investment to safeguard against external shocks as well as legislation to protect tax bases.

The improved tax collection systems and revenue generation could generate an additional \$220 billion in revenue, and cross-border transactions and e-commerce with the potential to generate \$40 billion in revenue by 2023.

These were the key takeaways and recommendations presented by The Dr Patrick Olomo - Acting Head: Economic Policy and Sustainable Development Division at Africa Union Commission on 2 November, 2023 during the ongoing ATAF Annual Meeting in Cape Town, South Africa.

Presenting a paper titled; Strengthening International Cooperation: A United Front Against Illicit Financial Flows (IFF) Dr Olomo further explained that active engagement in global tax reforms should start with a Continental dialogue on inclusive and effective tax cooperation in which Africa should organize a continental dialogue on inclusive and effective tax cooperation at the United Nations, and the OECD Two Pillar rules and involving various African institutions, to guide future discussions and ensure Africa's interests are represented.

Dr Olomo added that that Regional harmonization and protection of tax bases through legislation should be implemented to protect tax bases from losses due to incentives.

Contributing to the discussion as panelists Tax Justice Network Africa (TJNA) Executive Director; Chenai Mukumba mentioned that the Policy Tracker Tool on Illicit Financial Flows (IFFs): TJNA will be conducting validation meetings with Member States, facilitated by the African Union Commission (AUC), to ensure the Policy Tracker Tool is fit for purpose and builds upon existing efforts.

"Once finalized, the tool will be presented to relevant AU Policy Organs for consideration and endorsement; This highlights the importance of collaborative validation and the endorsement process to ensure the tool's effectiveness and acceptance", Mukumba commented.

The Two-Pillar Solution acknowledges the calls from developing countries for more mechanical, predictable rules, and more generally, provides a redistribution of taxing rights to market jurisdictions based on where sales and users are located.

## Mittal's Uganda IPO flops as bonds attract investors

INDIAN billionaire Sunil Mittal's Airtel Uganda Ltd. failed to sell about half of the shares on offer in its initial public offering as investors stayed away, preferring high-yield government bonds.

Airtel said it managed to raise 211.4 billion shillings (\$56 million) after selling 54.5 percent of the 8 billion shares on offer. Retail investors bought just 0.3 percent of the IPO. Shares were trading unchanged at 100 shillings on its debut on Tues-

Government bonds in the East African country yield as much as 15 percent. By comparison, shares of Airtel's rival MTN Uganda Ltd. have dropped 14 percent since its IPO in 2021. Investors have also been wary after Uganda enacted a draconian anti-LGBTO law, prompting US President Joe Biden to withdraw the nation's preferential trade access.

Investors may have opted for less risky government securities while disregarding the future value of the stock, the Uganda Security Exchange's Chief Executive Officer Paul Bwiso said in the nation's capital, Kampala.

"It comes down to financial literacy, understanding the asset classes," Bwiso said. "If I buy Airtel today, can I in two years consistently get a dividend like I would get an interest return from my fixed deposit from my market fund or from treasury bonds?"



The demand for Ugandan government bonds maturing in 2033 exceeded the amount on sale by eight fold in an auction on Thursday.

President Yoweri Museveni's government four years ago ordered wireless companies to sell 20% stakes to local investors in a bid to deepen the market.

The state-controlled National Social Security Fund bought 10.55% of the IPO, according to Airtel.

A decision by the company to spin off its mobile-money business, also played a role in the IPO's failure, according to Centenary Bank financial markets head Benoni Okwenje.

African telecom operators have been devising plans to capitalize on their lucrative mobile-money businesses. TPG invested in Airtel's unit valuing it at \$2.65 billion in 2021, and more recently MTN sold a minority stake of its fintech business to Mastercard valuing the business at \$5.2 billion.

### **Dollar rebounds on** hawkish Fed speak

#### **NEW YORK**

THE US dollar rose in early European trade Tuesday, rebounding from recent lows, while the Australian dollar slumped after the RBA hinted at the end of its cycle of rate hikes.

At 03:25 ET (08:25 GMT), the Dollar Index, which tracks the greenback against a basket of six other currencies, climbed 0.2 percent to 105.285, above the near two-month low of 104.84 seen on Monday. The dollar index slumped 1.3 percent last week, its

steepest decline since mid-July, after the Federal Reserve offered up dovish signals on the likelihood for more interest rate hikes this year.

However, this tone has changed after Federal Reserve Bank of Minneapolis President Neel Kashkari hinted at the need for more interest rate increases to control in-"The economy has proved to be really resilient even

though we've raised interest rates a lot over the past couple of years. That's good news," Kashkari said in an interview on Monday.

But he added: "We haven't completely solved the inflation problem. We still have more work ahead of us to get it done."

The Fed kept its overnight short-term interest rate target unchanged at between 5.25% and 5.5% last week.

Fed Chairman Jerome Powell is due to speak on Wednesday and Thursday, and traders will be looking to see if he backs up this more hawkish stance.

EUR/USD fell 0.1 percent to 1.0701, after German industrial production fell more than expected in September, slumping 1.4 percent compared with the previous

This adds to the mounting signs that the eurozone's largest economy is in difficulty, and is likely to end the year in a technical recession.

The European Central Bank must remain vigilant on inflation and be prepared to raise interest rates again if needed, its policymaker Robert Holzmann said on Monday, after the central bank halted its tightening cycle in late October.

However, Holzmann, the governor of Austria's central bank, is on the hawkish end of the spectrum as far as ECB policymakers are concerned, and the majority of his colleagues may not hold these views given the region's slowing growth.

GBP/USD dropped 0.2 percent to 1.2321, having hit a seven-week high of 1.2428 on Monday.

British grocery inflation has fallen below 10 percent for the first time since July 2022, according to data from market researcher Kantar, providing some relief for consumers as they enter the key Christmas shopping period.

Hamas regards the attack as a response to Israeli actions against the Al-Aqsa Mosque on Jerusalem's Temple Mount. Israel has declared a complete siege of the Gaza Strip and has started delivering strikes on that area and parts of Lebanon and Syria. Clashes are also taking place in the West Bank.

#### **FAO urges focus on hidden costs** of global agrifood systems

STAKEHOLDERS should factor the hidden environmental, social and health costs associated with the transformation of agrifood systems into their decision making processes, the United Nations Food and Agriculture Organization (FAO) urged in a flagship report released on Mon-

Unveiled at FAO's headquarters here, the 2023 edition of the State of Food and Agriculture (SOFA) report said that the global quantified hidden costs of agrifood systems amount to 10 trillion U.S. dollars a year at 2020 purchasing power parity, representing nearly 10 percent of annual global gross domestic product (GDP).

Adopting a true cost accounting method, FAO estimated in this 154-country research the hidden costs generated by market as well as institutional and policy failures. According to the study, more than 70 percent of the hidden costs globally are driven by people's unhealthy diets with heavy consumption of ultra-processed foods and foods high in fats and sugars, which lead to diseases and lower labor productivity.

This type of loss is most prominent in high and middleincome countries. Some 20 percent of the hidden costs are environment-related, which are associated with greenhouse gas and nitrogen emissions, as well as land-use change and water use. Xinhua


"The CIIE is an important platform for us to showcase our latest innovative technologies for China and the

This year, more than 200 U.S. exhibitors in semiconductors, medical devices, new energy vehicles, cosmetics, and other sectors attended the annual import expo, marking the largest U.S. presence in the history of the CIIE. Among the exhibitors are 17 from the agricultural and food industry, led by the U.S. government for the first time.

Since 2018, U.S. firms have been at the forefront of the CIIE participant countries in exhibition areas and exhibitor numbers.

In the previous five editions, the CIIE witnessed debuts of some 2,000 items of new products, technologies, and services and a total intended turnover reaching nearly 350 billion U.S. dollars. The grand event is proof of global participants' firm confidence in the Chinese market and its growth prospects.

## African countries urged to exert robust security collaboration to prevent security perils

**ADDIS ABABA** 

THE African Union (AU) has called on African countries to exert robust security collaboration and coordination to prevent terrorist and criminal groups from deepening their roots in the continent.

The urgent call was made by Alhaji Sarjoh Bah, director of Conflict Management within the AU's Political Affairs, Peace and Security Department, as he underscored the crucial need to exert concerted efforts as security threats continue to emerge and mutate in different parts of the

The AU director made the remarks during a peace and security-themed meeting, which is underway in Nouakchott, capital of Mauritania, on Nov. 5-7, with particular emphasis on addressing security threats in the Sahel-Sahara and Horn of Africa regions, according to an AU statement issued Monday.

"The security situations in the two regions continue to deterio-

The director further expressed concerns that terrorist groups could spread to the coastal countries and link up with transnational criminal groups involved in piracy and armed robbery, as well as with human and contraband trafficking gangs, to fund their operations.

"States must, therefore, focus on fully operationalizing maritime security architecture as an integral part of the African Peace and Security Architecture (APSA).

This will contribute to fighting

cutting off sinister financial schemes sustaining terrorist and criminal networks through trafficking and smuggling," he said.

Bah highlighted ongoing regional approaches that underlined the seriousness with which states are joining efforts to effectively combat, degrade and defeat the terrorist and criminal groups operating in the region.

According to the AU, the three-day meeting, among other things, seeks to reflect on the growing threat of terrorism, with a view to reaching a shared appreciation of the scope, dimensions and magnitude of the threat.

The meeting envisaged creating agreement on modalities towards enhanced information and intelligence sharing and cooperation while also identifying ways to support AU member states to address existential threats, and collectively agree on modalities and roadmap for collaboration in 2024, the AU said.

US-Russia ties' stabilisation unlikely if Washington keeps stance of strength – ambassador

#### **WASHINGTON**

STABILISATION in the US-Russian relations is unlikely as long as Washington resorts to attempts of speaking with Moscow from a position of strength, Russian Ambassador to the United States Anatoly Antonov said.

"Any attempts to conduct a dialogue with our country 'from a position of strength' are doomed to failure," the Russian diplomat stated on the Telegram channel.

"Until this approach is abandoned, we cannot talk about even the slightest stabilization of Russia-U.S. relations. Washington should realize that any unfriendly steps will be met with a tough and adequate response," he continued.

"There will be no negotiations on a retreat from Russian national interests," Antonov noted. "We have repeatedly proposed to resolve issues on Russia's western borders through dialogue."

"However, all our ideas were scornfully rejected. The United States therefore left us no choice and provoked us to launch a special military operation," the Russian ambassador stressed.


Antonov also said in his statement that Russia "repeatedly conveyed to local officials the message that neither confrontation nor economic sanctions, much less attempts to undermine the unity of Russia, will help Washington to achieve the necessary objectives.'

"The Russian side has never closed the door to diplomacy, but at the same time emphasized that any progress is possible only through mutually respectful dialogue and finding a balance of interests on a strictly equal basis. And the principle of indivisible security for all should be put at the center," the Russian ambassador to the United States added.

## China to build 5th Antarctic research station



The Ross Sea is the most southward-extending sea among all marginal seas of Antarctica. The top of the bay is located at about 78 degrees south latitude, which is very close to the South Pole.

The unique geographical location of the Ross Sea brings differentiated scientific research value, making it a beneficial complement to China's Antarctic scientific research layout deserving greater investment for comprehensive scientific observation.

The construction of the new research station is of great significance.

Carrying out surveys, observation and monitoring of marine ecology, sea ice, glaciers, sea level, atmosphere, geophysics, high-altitude atmospheric physics, terrestrial ecology, terrestrial and marine geology, birds and more in this region will provide fundamental support for assessing the Antarctic ecological environment and climate change.

"The Ross Sea region has a strong appeal to scientists because it is like an 'ice factory.' It is an important gen-

and a key origin of Antarctic bottom water," said Sun Bo with the Polar Research Institute of China under the MNR.

The region features multi-circle interactions of the Earth system, including the geosphere, cryosphere, biosphere and atmosphere, which will help researchers explore important scientific issues such as Antarctic changes and global linkages, according to

The construction of the new station also reflects China's active efforts to fulfill its responsibilities and obligations under the Antarctic Treaty system.

According to Long Wei, deputy director of Chinese Arctic and Antarctic Administration, a subsidiary of the MNR, China will cooperate with relevant countries in managing the Antarctic Specially Protected Area at Inexpressible Island and conduct ecological monitoring of the Ross Sea region Marine Protected Area, contributing to the protection of the Antarctic ecological environment and supporting China's participation in Antarctic international governance.

Relying on the new station, China will carry out international cooperation on scientific expeditions and logistical support in Antarctica with neighboring research stations of other countries, striving to make new and greater contributions to the peaceful use of Antarctica by mankind, Long said.

With a building area of 5,244 square me-

erator of sea ice in the entire Southern Ocean, ters, the new Chinese Antarctic research station is expected to accommodate 80 expedition team members during summers and 30 members during winters after completion.

It is planned to be used for atmospheric,

oceanic, glacial, biological and other multidisciplinary observation, monitoring and scientific research. The philosophy of "green expedition" will

run through the entire construction process of the new research station.

While ensuring quality, safety and other basic requirements of the station, relevant personnel will make overall plans and adopt integrated designs for various systems of the station, in a bid to conserve resources and minimize environmental impact during the construction of the new research station.

Customized prefabrication and pre-assembly at home, as well as intensive management of construction materials, will also help the expedition team save energy, water, materials and other resources and protect the environment.

By reducing the disturbed area in Antarctica, cutting the number of temporary facilities and construction personnel, and maximizing control over the scope of construction activities, the expedition team will try to achieve the goal of green and ecofriendly construction.

In addition to the construction of the new station, the expedition team will also investigate the impacts of climate change on the tries. **People's Daily** 

Antarctic ecosystems and relevant consequences, while thoroughly studying the role of Antarctica in global climate change, according to Zhang Beichen, leader and chief scientist of China's 40th Antarctic expedition.

Collaborative research in the frontiers of international Antarctic science will also represent an important part of this expedition.

### **COP28: Impasse broken on climate** fund but tough road ahead

FINAL talks over the weekend to agree deal. a proposal for a new climate disaster fund averted a deadlock ahead of the UN's COP28 climate summit later this month, but cracked open tough new questions about who will pay and how soon.

The fifth meeting of a 24-member UN committee tasked with designing the fund concluded in Abu Dhabi over the weekend, with support for a "take-it-or-leave-it" deal that would make the World Bank the interim home of the fund and encourage but not oblige - all countries to contribute

A loss and damage fund would be the first United Nations mechanism dedicated to helping countries that have suffered irreparable climate-driven damage from drought, floods and rising sea levels. It would aim to divert billions of dollars towards nations that are "particularly vul-

After months of contentious talks, negotiators produced recommendations for the fund that will be put to nearly 200 governments for approval at the annual UN climate summit COP28, from Nov 30 to Dec 12 in Dubai.

Both developing and developed countries said they had made major concessions to avoid a failure that would have soured COP28 - where governments will face pressure to unlock other deals on phasing out fossil fuels and increasing funding for climate action.

"There was a lot at stake at this meeting," Avinash Persaud, special envoy to the Prime Minister of Barbados and the country's representative on the UN committee, told Reuters. "The value of the agreement is that it avoided a disaster ahead of COP and gives positive momentum."

The recommendation "urges" developed countries to take the lead in capitalizing the fund and also "invites" contributions from other countries and funding sources like carbon markets.

That means no country would be legally obliged to pay into the fund - reflecting a hard-fought compromise. Developing nations argue that rich countries responsible for most of the historical CO2 emissions causing climate change should be obliged to pay - something the United States and other rich nations refused to accept.

"It's like a GoFundMe account for climate destruction," Persaud said of the

#### **Big questions for COP**

As the hours passed on the second day of talks, negotiators haggled over wording and punctuation on the section of the text on countries' financial commitments to the fund.

A US State Department official told Reuters the country had sought - unsuccessfully - to get a footnote included in the text to clarify that any contribution to the fund would be voluntary.

The official welcomed the fact that the committee agreed on "many aspects of loss and damage funding" but expressed regret that the text does not "reflect consensus concerning the need for clarity on the voluntary nature of contributions".

Egypt, which represents African countries on the committee, also raised concerns in the meeting after the deal was agreed, noting that some of their key demands had not been met - such as agreeing the size of the fund or clearer obligations for rich nations to contribute.

Such complaints could risk a blow-up at COP28 if countries attempt to reopen the

"I suppose from both sides there will be attempts to break open the text," one European negotiator told Reuters.

But that could complicate efforts to actually put money in the fund - if donor countries don't have a clear idea of the rules that will govern their contributions, and which countries would be in line to receive it.

"You're not going to pledge to the fund if you don't know where the money's going to go," the European negotiator said.

The European Union, which is the biggest source of other types of climate finance - money that helps poorer countries invest in cleaner energy, or adapt to worsening storms and heat - is already preparing to contribute to the fund.

Jennifer Morgan, Climate Envoy for Germany - Europe's biggest economy - said in a post on X that Berlin is also working on a contribution.

Mohamed Nasr, Egypt's lead climate negotiator and representative on the committee, told Reuters such pledges would be crucial to the overall COP28 negotiations.

## Simba SC's double standards on Ally Salim prove a bit costly

EVEN with sorcery indicators strewn here and there as the city archrivals took to the pitch at Benjamin Mkapa Stadium in Dar es Salaam, nicknamed Estadio Lupaso, nothing in the usual run of things would have allowed anyone to project a 5-1 win for Young Africans SC, alias Yanga.

Not long after, Simba SC held muchvaunted Egyptian giants, Al Ahly, on two ends of a competitive and rewarding encounter in the African Football League (AFL), and came out head high with a double draw.

How the Jangwani Street side would humiliate the AFL giants was a paradox that needed a singular explanation, not a stretch of reasons as they could at best lead to a thin-margin win or thin draw

That the two sides were largely comparable was noticed in the way Yanga moved ahead unexpectedly only in the third minute, but before anyone was tired of waiting, the score was canceled, and play returned to normal.

It could have stayed that way for the rest of the game despite runs of various sorts either way but, in the second half, the AFL aspirants broke down more or less totally, for no clear reason.

Everything remaining equal, there had to be a singular external factor that was by and large unattended, and this could be the goalkeeping shift.

What is unclear is where the pressure to field veteran goalkeeper Aishi Manula stemmed from, if it was the coach himself who was satisfied with his training performance or if it is the leadership.

While not much of such pressure is being heard from the camp, there was in the past some sort of agitation for Moses Phiri 'General Phiri' to appear for the side, as the substitute center forward has been having inadequate playing time since the arrival of sharpshooter Jean Baleke at the short registration

There was a need for either two or three Premier League matches to test

There were explanations for first-half ability and second-half breakdown the focus on withdrawing Kibu Denis, who at his usual right-wing position was sort of playmaker.

Why it then appeared that everything relied on him was far from clear, but it also appeared that there was a gap at the

a new realization.

Sometimes in the past in major continental tourneys, some opponents were also working from that hypothesis of weakness, as it was for Joash Onyango earlier.

Those looking at social media remarks after the match saw comments like the idea that only Kibu Denis was serious about the match; the others looked lackluster. Simba SC appears to have been too sure of a win and let this idea stick to their heads.

What was also surprising was the idea that a side like the Msimbazi Street side would lose bearings to let in goals flow, and without ability to respond except for the first goal.

It means they used plenty of energy to rectify the score and then hoped against the tide that the Jangwani Street side would not be able to repeat the feat, and then it happened though much later, they were not in a position to make a second rally.

Then the coach inflicted a blow on the side by benching Kibu Denis, who was the playmaker, in a situation where neither Clatous Chama, Sadio Kanoute, Fabrice Ngoma nor others were prepared to step in.

Strictly speaking, for a side seeking top honours, it means they now equal their next street rivals in seeking a cure for their soft spots that it takes a match as good as a derby, and results of that sort, to brainstorm what the problem is likely to be.

At the same time, it provides an opportunity for investments in the next registration window, that there is a need for a more reliable fellow where their rivals found a niche to direct most of their attacks. Left at that it could happen in other big ties.

There was also a way in which overconfidence explained several failings in the tie, as the same Roberto Oliveira who did not trust Manula for the rear with Mohamed Hussein 'Tshabalala' starting line-up against Al Ahly in both encounters, facing the 'firing squad'. It is not entirely suddenly found him appropriate in the derby.

That can only be explained by having taken it lightly, and in that sense saw an opportunity for rotation of players, partly as leaders will reiterate that some players earn big salaries and spend their time on the bench, which is probably not fair for the club.

But instead of trying him out in a routine league match, the coach opted for the derby, as the squad had chosen a 'biriani' event on Friday before the 'kill' on Sunday, and premonition brought major domo Ahmed Ally to announce Kibu Denis as a special guest in the match. He lived to its worth in dollars.

There was a tantalizing element somewhere as Yanga saw Kibu Denis as the best player on the pitch and could have guessed that if he skipped out - frankly not on a stretcher - that would be beneficial.

The difference is that such work is not usually handed to a goalkeeper, and that is where the playmaker met with his injury, in which case it was an accident like any other.

It thus remains that it was foresight, planning the way to tackle Simba SC while the latter felt no need for a deep strategy against Yanga as they would hardly play at the level of Al Ahly, to wit.

In contrast, the business as usual for goalkeeping has to do with what pundits often say about Ally Salim.

They make an effort to patronizingly speak about his skills as he is only aged 23. The latest we heard was that he is still young, and makes some mistakeswhich is pointless as it means an elderly keeper

TANZANIA's veteran Hip Hop musician, Joseph Haule, has established an institution known as 'Professor Jay Foundation' to offer his contribution to serving patients with kidney ailments.

The artist, popularly known as 'Professor Jay', was recently quoted by a social network in Dar es Salaam saying that the institution will be officially launched on November 24.

The Hip Hop star was recently admitted to Muhimbili National Hospital in Dar es Salaam because of experiencing kidney ailments.

The artist revealed when he was admitted, he witnessed people struggling with the cost of kidney treatment because it is high.

"Others lost their lives due to lack of money for the treatment, there are also syringes I used for injection, one of which costs 5m/-," 'Professor Jay' noted in the interview.

He disclosed that the injection pushed him to establish his institution to help patients with the same problem, adding that he is still undergoing kidney dialysis. "For example, if the patient starts

his/her treatment at Muhimbili National Hospital, the cost ranges from 80,000/- to 100,000/-," the artist noted.

"The patient coming from abroad is required to pay 350,000/-, kidney dialysis is done three to four times a week depending on the condition of the patient," he said. He further noted due to the

circumstances that kidney patients are going through, he has decided to start the 'Professor Jay Foundation' because they are suffering, adding the costs they incur are high.

"All people cannot be reached by the

### Postecoglou blasts VAR after nineman Spurs beaten by Chelsea

ANGE Postecoglou admitted he does not like VAR as the Tottenham boss blasted the replay system's influence on his side's "out of control" 4-1 defeat against Chelsea on Monday.

Tottenham had Cristian Romero and Destiny Udogie sent off and were denied two goals by VAR in a remarkable Premier League clash.

The dismissals of Romero, for a studs-up foul on Enzo Fernandez, and Udogie, who earned a second booking for chopping down Raheem Sterling, appeared correct on further review, as did Son Heungmin and Eric Dier's disallowed goals.

Nicolas Jackson scored three times in the closing stages to win the London derby for Chelsea after Cole Palmer's penalty cancelled out Dejan Kulusevski's early opener for Tot-

But with Chelsea also having three goals chalked off by VAR, Postecoglou was left infuriated by the amount of time spent waiting for decisions to be made.

"I felt like I was standing around waiting for things to happen with VAR intervention," he said.

"There will be a forensic study of every decision out there. That is the way the game is going and I don't like

"Decisions are decisions, you either accept it or you don't. If you look at all that standing around we did today, maybe people enjoy that sort

And Postecoglou claimed he would prefer the referee and his linesmen to have the final say on

crucial decisions, rather than a VAR official who is not even based in the stadium.

"You have to accept the referee's decision, that is how I grew up. This constant erosion of the referee's authority is where the game is going to get," the Australian said.

"They are not going to have any authority. We are going to be under the control of someone with a TV screen a few miles away.

"I don't like it but I am probably in the wilderness with that because I keep getting told that's where we want to go. I am too old school.

"It is almost impossible to analyse the game because it just seemed to get out of control for large parts of it."

Chelsea boss Mauricio Pochettino had no such complaints about VAR as he savoured a victory over his old club on his first return since being sacked in 2019.

"This is football. We won and deserved it. The technology is there and we need to accept. Many things happen on the pitch and you need to verify and check," he said.

"I'm happy to come back and see people I didn't get the chance to say bye too. Most important for me is the win. It is Tottenham and it is not more special because of that."

Pochettino has endured a difficult start with Chelsea following his close-season appointment, making this a much-needed morale boost for the Argentine and his injury-hit

"We deserve the credit. Tottenham are doing fantastic but tonight we were the better team," he said.

"It's clear from the beginning we didn't have the whole squad. We need to build this momentum.

"It is amazing for Nicolas (Jackson). There was massive pressure on him but I hope this hat-trick allows him to play more relaxed and be more confident."

## What's gone wrong for Erik ten Hag at Man Utd?

MANCHESTER United are in desperate need of a win at FC Copenhagen in the Champions League today as they battle to avoid an embarrassing group-stage exit.

The three-time European champions sneaked past the Danish side 1-0 at Old Trafford last month thanks to a last-gasp penalty save from goalkeeper Andre Onana.

Heavy defeats by Manchester City and Newcastle have since ramped up the pressure on manager Erik ten Hag, which was only eased slightly by a 1-0 win at Fulham on Saturday.

United are third in Group A, six points behind leaders Bayern Munich and one adrift of Galatasaray.

If they fail to win in Copenhagen, Galatasaray could be in a position knock United out when the sides meet in Istanbul on November 29.

AFP Sport looks at what has gone wrong for Ten Hag in his second season at Old Trafford.

Recruitment

United fans have frequently voiced intense frustration at the running of the club by the Glazer family, but Ten Hag has still enjoyed a huge transfer budget.

More than £400 million (\$497 million) has been spent in the past three transfer windows, with few obvious successes.

Former Ajax winger Antony,



bought last year for £86 million, has rarely lived up to his huge price tag, scoring just eight goals in 55 appearances.

Mason Mount, like Antony, has regularly found himself on the bench in recent weeks just months after a £55 million move from Chelsea, and has yet to score for his new club.

Onana's penalty save against Copenhagen was atonement for costly errors against Bayern and Galatasaray as United lost their opening two group games of a Champions League campaign for the first time.

Eight of his signings have previous experience of playing in the Eredivisie but many of them have struggled with the extra demands of playing for one of the world's biggest clubs in the Premier League.

United performed impressively in the Dutchman's first campaign in charge, ending a six-year trophy drought and finishing third in the Premier League.

This season, long-term absences for Luke Shaw, Tyrell Malacia and Lisandro Martinez, as well as injuries to Raphael Varane and Aaron Wan-Bissaka, have stretched his defensive resources to breaking point.

In a further headache for the former Ajax manager, midfielder Casemiro has been ruled out for "several weeks" with a hamstring

Veteran centre-back Jonny Evans, brought back to the club as defensive cover, believes the absence of so many players has destabilised the squad.

"I think the manager's found out difficulties having to sort of work Ten Hag is that he has been too relion the team, on tactics and having

to change the personnel quite a lot with only two days in between games," he said.

Misfiring stars

Manchester United's marquee players have failed to deliver this season, with Marcus Rashford, Casemiro and Bruno Fernandes all well below par.

Rashford's decline is the most stark -- he has just a solitary goal in 14 matches, compared with 30 for the club last season, when he found a new level.

Ten Hag says the England forward is "very motivated to put things right" but he desperately needs his main man to find form quickly.

Brazilian international midfielder Casemiro, 31, has failed to match the high standards he set during an impressive first season at United.

Casemiro is top scorer, with four goals in all competitions, but he has struggled with the defensive side of his game, leaving a leaky defence even more vulnerable.

Portugal midfielder Fernandes has often cut a frustrated figure and has not been a consistent creative force for a side that have managed just 12 goals in 11 Premier League games this season.

## Chelsea triumph over Tottenham in Premier League clash that had everything and more

A FARCE that sums up a lot of modern football, or one of the games of the season? It maybe sums up how confusing and contradictory this game was that it could genuinely be both. Chelsea's eventual 4-1 victory at Tottenham Hotspur could have huge effects for both of their seasons too.

Mauricio Pochettino's side have got the win it feels like they have been waiting for, and that at the stadium that still means more to him than any other in football. Ange Postecoglou's scarcely believable high line with nine men and no main centre-halves did make it borderline for some time. Such a creditable approach earned the applause of the home crowd when it finally went wrong for Nicolas Jackson's decisive second goal, but there was that unsettling feeling of momentum being undone.

Spurs have not just lost their first league game under Postecoglou but also Destiny Udogie and Sergio Romero to suspensions and possibly James Maddison and Micky van de Ven to iniury.

That all has the feeling of bringing down a flight that had been improbably soaring for some time.

Postecoglou could of course tell his players it was a freak game. That's one way of putting it. It was almost several different events in one, as we saw a spell akin to the infamous Battle of the Bridge as well as Saturdav's Copa Libertadores final, a grand staging for every debate about VAR over and over and then what amounted to a bizarre but brave training session, where Postecoglou seemingly set up the irrepressible Guglielmo Vicario against the entirety of Chelsea's young attack.

To top it off, and turn everything on its head, the previously misfiring Jackson got a hat-trick late on.

It wasn't quite an exhibition of finishing but there was enough to show the potential that is there.

Whatever about this evening exhibiting various types of football events in one, mind, there were alternating periods that looked like it could have come from completely different matches.

It was incredible to contemplate this by even the half-hour mark, but the first 18 minutes looked like it would be a comprehensive and confident Spurs win to continue their early-season surge.

They were shredding Chelsea, especially on the wings. Both sides were being targeted, something inevitable given all the space, and the



first real attack brought a goal. Dejan Kulusevski shot and the ball cannoned off Levi Colwell and past Robert Sanchez.

Reece James was even more exposed on the other side, allowing Brennan Johnson to just saunter through and square for Son Heung-Min to slide the ball in. It was all so easy that Spurs were getting ahead of themselves, as the Korean's wayward foot saw the goal ruled out for offside.

That was what made what happened next all the more inexplicable, as Udogie went in with a dismally reckless challenge on Raheem Sterling. He didn't get sent off - yet - but it was like the entire tone changed. It was also a bit of Chekov's foul, as Udogie would go for similar later on.

That itself was influenced by what the match briefly became, which was somewhere between an old storyline from this fixture like the Battle of the Bridge and the Libertadores final. Cristian Romero was at the centre of it, with two challenges of his own that each could have received red cards. He was eventually sent off as part of the same sequence that saw a second Chelsea goal chalked off, to bring a penalty.

It was almost difficult to keep up, the sense of dislocation added to by how the match was played at a frenetic pace and yet also frequently stopped for long VAR checks. Cole Palmer's ensuing penalty consequently may not have been as pure as he'd have liked but it did make

For Pochettino's part, Udogie's challenge wasn't the only big change. He altered Chelsea's formation to ensure they had taken tactical control of the game even before Romero's red card.

It probably shouldn't have got to that for Spurs, though. It was going to get worse. Both Maddison and Van de Ven had to go off injured before Udogie eventually got his red card.

What happened next was perhaps the most unexpected development of all, though. Postecoglou refused to back down. He doubled down.

Despite nine-man Spurs losing two of their leading players to injury, with both of their main centre-halves off the pitch, Postecoglou seemed to go even higher with his line. Spurs basically offered up the entirety of their half to Chelsea's attack.

It was bold, to say the least. It immediately led to Chelsea setting up a series of one-on-ones, the game almost becoming a training exercise

between their forwards and Guglielmo Vicario, with some vague use of the offside trap in between.

And yet this might well have been where there was a clear logic. Given how inexperienced this Chelsea squad is, many of them seemed to keep making the bad choices when such good chances were offered. There was rarely a third-man run. Mykhailo Mudryk and Nicolas Jackson kept going outside when they should have gone inside, or vice versa.

Vicario, for his part, was brilliant. Every unlikely stop amplified the atmosphere. It was as if every wasted one-on-one - and they were becoming countless - was further eroding their confidence.

This could have been a hugely embarrassing game for Chelsea, rather than the humiliation for Spurs it was almost set up for.

Except, the risk was just too great. A team with someone as experienced as Sterling was eventually going to get one right. It was duly his pass that set up Jackson.

At 2-1, Spurs had no choice but to go for it even more. Jackson claimed even more, twice scoring in stoppage time. That may be a turning point for him as well as Spurs, but only after a night that really did the rounds.

SIMBA SC has parted ways with head coach Robert 'Robertinho' Oliveira following a 5-1 home defeat by bitter city rivals, Young Africans SC, in a 2023/24 NBC Premier League encounter which took place in Dar es Salaam on Sunday.

Goalkeeping coach Daniel Cadena, who holds a UEFA A Pro license, will take on the role of interim head coach and will be supported by Selemani Matola as the club searches for Robertinho's replacement.

Simba SC will face Namungo FC in an NBC Premier League game at Benjamin Mkapa Stadium in Dar es Salaam tomorrow as the former looks to bounce back to the winning column.

The squad, popularly known as 'Msimbazi Reds' was well-beaten by Yanga, with goals from Maxi Nzengeli, Kennedy Musonda, Pacome Zouzoua, and Stephane Aziz Ki condemning them to their heaviest derby defeat in more than 40 years.

The first defeat of the season left Simba SC placed third in the table after taking 18 points from the side's opening seven matches.

A club statement read: "The Simba SC management thanks the coaches for their contributions to our club and wishes them the best of luck in their new endeavours."

"During this transition period, the team will be under the caretaker coach Cadena who will be assisted by Seleman Matola. The process of acquiring new coaches has begun and is expected to be finalized soon," the statement noted.

Rwandan fitness coach Corneille Hategekimama and assistant coach Tunisian-born Ouanane Sellami are also part of Robertinho's backroom casualties.

Robertinho, the former Brazil national team striker, was named as Simba SC coach in January, replacing Juma Mgunda.

He led the team to the CAF Champions League quarterfinal last season and also won the Community Shield at the start of this campaign.

Although Simba SC won the squad's first Premier League matches under Robertinho, and also qualified for the CAF Champions League Group Stage, the side was still criticized for showcasing unconvincing performance and a not-so-exciting brand of football.

## Yanga aims to stay top before FIFA break
