# CUF promise: Our win will bring govt of national unity

THE opposition Civic United Front (CUF) will form a Government of National Unity (GNU) if it emerges as the best positioned party in the October 28 general election

The party's presidential candidate, Prof Ibrahim Lipumba, made this declaration at the official launch of the party's election campaign at the Nangwanda Sijaona Stadium in Mtwara yesterday, insisting also that he would supervise the process to get a new

"I will make sure that I create a government which respects human rights; I am going to transform the economy, strengthen democracy and freedom. Supervise and improve the Tanganyika and Zanzibar union for mutual

benefit," the candidate intoned The CUF presidential running mate Hamida

Abduallah Huweishi said that the country's economy has deteriorated and poverty has increased due to lack of committed leaders.

"So do not make a mistake in the forthcoming election. Go and vote for CUF so as to bring you development," she said

Along with the intention to create a government which respects human rights, freedom and democracy, the candidate said he would conduct reforms in the health, education and agriculture sectors so as to benefit the majority of Tanzanians.

If elected, he would seek to improve the trade, business and investment environment to stimulate employment opportunities and spur the country's economic growth, he stated.

He said the southern zone regions have been neglected for years, vowing that a CUF government will prioritizes the development of

EARNINGS of up to US\$1 million (over 230bn/-) annually as profits from gold mining operations will be flowing to the Treasury on the basis of an agreement between the government and Barrick Gold Corporation, CCM presidential candidate Dr John Magufuli said yesterday.

He said the agreement was a milestone in addressing mining related disputes, speaking at a campaign rally at the CCM Kirumba Stadium in Mwanza City. The agreement represents a joint venture arrangement which guarantees the government full participation in decisions on the three Barrick Gold mines-Bulyanhulu, North Mara and Buzwagi.

The pact with the mining firm cleared the way for the country to more handily benefit from its natural resources, he stated.

significant stakes in three gold mines, ending a long-running tax dispute and setting a usable framework for negotiations with other firms.

# ACT-Wazalendo Kinondoni candidate faces court action

SAED Kubenea (pictured), the opposition ACT-Wazalendo's parliamentary candidate for Kinondoni constituency in Dar es Salaam Region, risks court action over alleged illegal entry into the country and suspicions relating to money laundering.

Director of Public Prosecutions Biswalo Mganga said in a statement yesterday that the former Ubungo (Dar es Salaam) legislator from the opposition Chadema was suspected to have violated the Anti-Money Laundering (Cross-Border Declaration of Currency and Bearer of Negotiable Instruments) Regulations of 2016 and Section 12 of the Anti-Money Laundering Act of 2006.

He said Kubenea was arrested when crossing the Tanzania-Kenya (from Kenya) border at Namanga at the weekend aboard a passenger





bus with registration number T 645 DKR.

According to the DPP, the suspect was heading to Arusha and had allegedly crossed the border to Kenya after arriving in Arusha from Dar es Salaam three days earlier - on September 2.

He said the former legislator told the police upon interrogation that he spent one night at his brother's house on September 3 and that the following day he travelled to the Namanga border, where he received the sum of money from a Kenyan national.

In the course of a police body, according to DPP Mganga, the suspect was found in possession of US\$8,000, 491,000 Kenya shillings and Tanzanian currency totalling

The DPP said Kubenea was also found with a ticket dated September 5, 2020 showing that he travelled on a Super Coach bus with registration numbers KCP 4230 from Nairobi to Namanga alongside a Memorandum of Understanding involving between Hali-Halisi (Tanzania) and Buni Media Limited (Kenya).

The suspect also allegedly had a hotel receipt bearing the name Kubenea, Saed Ahmed showing that he slept at the 'After 40 Hotels Limited' in Nairobi from September 3 to September 5 as well as his passport.

In the past five years efforts were made to link the city's suburbs more effectively by building roads to link the city centre with Usagara, Pansiansi and Buzuruga-Isamilo.

On health, Dr Magufuli said about 11.4bn/has been used in the last five years to build dispensaries, health centres and buying essential medicines.

On agriculture, he said that Mwanza cooperative unions obtained a loan from the Tanzania Agriculture Development Bank to buy 33 tractors so as to modernize the agro-cooperative sector in the region.

The rally was the second major public meeting after whistle stop rallies on Sunday on his way from Musoma in Mara Region. The candidate took time to ask voters to elect CCM candidates for the parliamentary and councillorship seats.

The CCM Kirumba stadium which holds35,000 people was arguably full as Mwanza residents from all walks of life thronged it as early as 6am to get a better view of the president and hear him from close range. Dr Magufuli is expected to hold a rally in Geita today.

# DRC's Tshisekedi invites region's presidents to security meeting

Congolese President Felix Tshisekedi has invited neighbours to a regional meeting in the eastern part of the country to discuss peace and security.

President Tshisekedi's office said he has invited Ugandan President Yoweri Museveni, Rwanda's Paul Kagame, Burundi's Evariste Ndayishimiye and Angola's Joao Lurenço to a summit in Goma, North Kivu Province, some 1500 km east of the capital Kinshasa.

Jolino Makelele, the Minister of Communication and spokesperson for the Congolese government, said the meeting will focus on peace and security but also discuss relations among those countries.

"This high-impact mini-summit will look at three themes - peace and security in the region, diplomatic and political relations among the states and the revival of economic be their first one together in five years. activities in the current context of the fight against covid-19," he said at the weekend.

A meeting date has not been set but officials have rushed to finalise logistics as they await the leaders' confirmation of attendance. The meeting is, however, expected to take place this week.

Historic meeting

# Majaliwa declares govt will continue working together with private sector

PRIME Minister Kassim Majaliwa has said the government will continue working together with entrepreneurs in all categories in the country aimed at strengthening the private sector for the nation's benefit.

He said the 2020/25 CCM election manifesto directs the government officials in the next five years to adopt positive view on the private sector, especially in the establishment of industries within the blue print for Business and Investment Environment Plan.

# TPRI seizes counterfeit pesticide from shops at Tunduma border town

THE Tanzania Pesticide Research Institute (TPRI) has seized a consignment of counterfeit pesticide that was being sold at two shops in Tunduma border town in Songwe

The pesticide was seized at the weekend when TPRI, Police and PCCB officials made an impromptu inspection at the town and three workers of the said shops were arrested.

Researcher and pesticide inspector from TPRI's headquarters in Arusha Marciale Mkombozi said they received information on the pesticide's entry into the town and decided to act on the tip.

He said after the inspection they found the consignment of the pesticide that did not satisfy the country's quality standard hence they were deemed hazardous to users.

"This pesticide has not been registered in the country by the registration authority - the TPRI, so we do not know its quality and the hazard it poses to users, hence we are supposed to remove them from the market, according to what the laws say," Mkombozi said.

He also called on other pesticide dealers to conduct business according to the country's laws to avoid prosecution that may end in heavy fines or imprisonment or both punishments.

TPRI Inspector for Southern Highlands Zone Emmanuel Mausa called on people using pesticides to ensure they were genuine or counterfeit by looking at their registration marks.

He said to simplify the identification of TPRI registered or unregistered pesticide they have established a special digital procedure which people can scratch for a special number.

# Dodoma records increase in enrolment of Standard One pupils by 121 percent

By Guardian Reporter, Dodoma

THE Dodoma city council has outlined 14 achievements attained in the past five years in primary education including increased enrolment of Standard One pupils by 121 percent.

The City Director, Joseph Mafuru said this yesterday when speaking to this paper on the successes of the council for a period between 2014/15 to 2019/20.

Mafuru said that Standard One enrollment has increased from 13,277 students (101 percent) in 2015 to 16,874 pupils equivalent to 121 percent of the enrollment target set for 2020.

"During the five years under the leadership of President John Magufuli, we have recorded major achievements in the improvement of primary school education," he said.

He said the pre-primary enrollment rate has increased from 9,214 pupils (114 percent) in 2015 to 10,939 pupils (116 percent) in 2020.

Mafuru attributed the success

Standard One pupils to implementation state-owned and 47 private. He said of the free education policy.

"As a result of the free education policy, we are now receiving a subsidy of 918.2m/- from the central government, which is higher compared to 361.9m/we received in 2015/2016.

In November 27, 2015 the government issued Circular 5 which implements the Education and Training Policy 2014 that directed public bodies to offer free primary and secondary school education to ensure that children in the country enjoy eleven years of free schooling.

Free education which includes the removal of all forms of fees and contributions supports government efforts to attain the Sustainable Development Goals (SDGs) related to primary education and Sustainable Development Goal 4 which requires countries to ensure that everyone completes free, equitable and quality primary and secondary education.

the number of Standard Seven leavers have also increased from 8,237 in 2015 to 10,495 in 2019, an increase of 2,258 pupils. "Academic performance has increased from 62 percent in 2015 to 85.36 percent in 2019, an increase of 23.36 percent," he said.

On construction of school infrastructure, Mafuru said classrooms have increased from 839 in 2015/16 to 993 in 2019/20 equivalent to 19 percent.

#### Clean air important factor in health and the economy

Indoor air pollution and poor urban air quality are listed as two of the world's worst toxic pollution problems in the 2008 Blacksmith Institute World's Worst Polluted Places report. Outdoor air pollution alone causes 2.1 to 4.21 million deaths annually. Overall, air pollution causes the deaths of around 7 million people worldwide each year, and is the world's largest single environmental health risk.

#### Literacy is not an end by itself, but a fundamental human right

'NTERNATIONAL Literacy Day (ILD) 2020 which was held on September 8, this year focused Lon teaching and learning in the COVID-19 crisis and beyond with a focus on the role of educators and changing pedagogies. The theme highlighted literacy learning from a lifelong learning perspective and mainly focused on youth and adults. The recent COVID-19 crisis has been a stark reminder of the existing gap between policy discourse and reality: a gap that already existed in the pre-COVID-19 era and is negatively affecting the learning of youth and adults who have no or low literacy skills and therefore tend to face multiple disadvantages. During Covid-19, in many countries, adult literacy programmes were absent in the initial education response plans, so the majority of adult literacy programmes that did exist were suspended with just a few courses continuing virtually, through TV and radio, or in open air spaces. What is the impact of the COVID-19 crisis on youth and adult literacy educators and teaching and learning? What are the lessons learnt? How can we effectively position youth and adult literacy learning in global and national responses and strategies for the recovery and resilience-building phase?

By exploring these questions, International Literacy Day 2020 provided an opportunity to reflect on and discussed how innovative and effective pedagogies and teaching methodologies can be used in youth and adult literacy programmes during this pandemic and beyond. The Day also gave an opportunity to analyse the role of educators, as well as effective policies, systems, governance and measures that can support educators in providing effective instruction and learning. Through a virtual conference, a collective global discussion was initiated to reimagine the literacy teaching and learning of youth and adults in the post-COVID-19 era towards the achievement of the SDG4.

Therefore needless to say literacy is

a fundamental human right and the foundation for lifelong learning. It is fully essential to social and human development in its ability to transform lives. For individual, families, and societies alike, it is an instrument of empowerment to improve one's health, ones' income, and one's relationship with the world."

The millions of adults and children who are illiterate are victims of discrimination; their basic human rights are being violated.

Lifelong learning is a process and should be the basis of educational policies. Learning does not stop when we graduate; hopefully, it colors our everyday activities and is not limited by age or gender. Literacy not only has academic applications, it also informs our consumer decisions, our on-thejob choices, and our decision making in a democratic culture. 8 September was declared international literacy day by UNESCO on 26 October 1966 at 14th session of UNESCO's General conference. It was celebrated for the first time in 1967. Its aim is to highlight the importance of literacy to individuals, communities and societies.

It is reported that some 775 million adults lack minimum literacy skills; one in five adults are still not literate and two-thirds of them are women; 60.7 million children are out-of-school and many more attend irregularly or drop

According to UNESCO's "Global Monitoring Report on Education for All (2006)", South Asia has the lowest regional adult literacy rate followed by sub-Saharan Africa. Countries with the lowest literacy rates in the world are Burkina Faso, Niger and Mali. The report shows a clear connection between illiteracy and countries in severe poverty, and between illiteracy and prejudice against women.

Celebrations of International Literacy Day have included specific themes, in line with Education For All goals and other United Nations programmes such as the United Nations Literacy Decade.



# It is time to end the controversial World Bank's doing business report

N 27 August the World Bank announced that it will suspend the Doing Business Report over data irregularities, until it conducts a review and audit. The halting of the report was welcomed by trade unions, academics and human rights groups.

The World Bank's Doing Business Report ranks countries based on business regulations in 190 economies. The more regulations are slashed, the better a country does in the ranking. Most indicators are based on a standardized case study such as the conditions facing a small firm in the largest commercial city -this study characterizes the country.

Global reports that present comparable international statistics are highly valued. For example, the much acclaimed Human Development Report of the United Nations' Development Program presents national progress on social development through a set of indications updated annually. The Human Development Report serves to create pressure on governments to perform better on education, health and other social development areas by comparing achievements in the basic dimensions of human development across countries.

In contrast, the World Bank's Doing Business Report undermines social progress and promotes inequality. Since it was launched in 2003, the Doing Business Report has generated outrage for its anti-regulation bias. Inspired by the "Index of Economic Freedom" at the conservative Heritage Foundation, the report has encouraged countries to take part in the "deregulation experience" including reductions in employment protection, lower social security contributions (denominated as "labor tax") and lesser corporate

In the report, a country ranks better when its social security contributions are low, that is, when employees have lesser social protection benefits for their families and retire with low pensions. Countries also get better rankings if corporate tax is low, no matter if this will generate further inequality and starve resources for national sustainable development. For example, India has improved in the reports' international ranking as the government has eroded environmental and labor protections and reduced



corporate taxation, resulting detrimental social impacts.

After the global economic crisis, the Bank suspended the publication's labor market flexibility indicator. However, the raw data was still published until attention from the US Congress stopped efforts to revive the indicator.

In 2013, an independent review panel established by the World Bank's executive board and led by Trevor Manuel recommended that the use of rankings be discontinued. The panel also recommended the permanent deletion of the labor market flexibility and tax rate indicators, as the latter penalizes countries that require business to pay taxes or make contributions to pensions and other social protection schemes that support households.

The World Bank's independent review panel also expressed concerns that the report, "tends to ignore the positive effects of regulation", highlighting "black box" data gaps and "cherry picking" of background papers. A key source of information for the report are surveys completed by corporate consultants and law firms - not businesses engaged in productive activities whose needs are usually different from the ideological prerogatives of the report, such as benefitting from a social protection floor and tax-financed investment in infrastructure.

made by the 2013 independent panel, it continued to use the report to guide programs and loans in developing countries, a fact denounced by civil society think tanks. Meanwhile, questions began to circle about the integrity of report findings.

In January 2018, Paul Romer, the World Bank's chief economist, said that "political motivation" of Bank staff may have contributed to a decline in Chile's ranking under the social democratic President Michelle Bachelet. Romer resigned after Bank leadership disavowed his remarks. An audit commissioned by the Bank in 2018 found no evidence of interference, but detailed constant methodological changes that took the meaning out of ranking changes.

Next, it was discovered that a change in methodology (instead of reforms) explains most of India's rise in the rankings. The government of Prime Minister Narendra Modi lobbied for favorable methodology, and when rebuffed sought to "game the system" with reforms chosen to artificially increase their rank.

Last week, the report brought the latest scandal. "A number of irregularities have been reported regarding changes to the data in the Doing Business 2018 and Doing Business 2020 reports," said the World Bank on August 27. This means that International Labour Organization Not only did Bank management interference is suspected in 2017 but

not uncovered in the 2018 audit.

Academics, legal experts and trade unions have pointed how the report's ideological and technical preferences work against economic and social development. The report is even at odds with the evolving approach of the World Bank, such as the "Balancing Regulations to Promote Jobs" manual.

Regardless of data manipulation, the Doing Business Report has always been an act of ideological interference in policymaking. If the Bank clings to this relic, it should at the very least remove the most regressive elements including those on social security contributions and corporate taxation, and follow the recommendations of the 2013 independent review panel.

These blunt indicators are against the Sustainable Development Goals, human rights and international conventions agreed by all countries. Continuing to use the profile and name of the World Bank to promote less worker protections, less social protection benefits and less corporate taxation will only increase inequality and worsen the effects of the COVID19 pandemic. It is time to end the Doing Business Report.

# The first clinical trial to support Vitamin D therapy for Covid-19

study from Spain finally presents the first clinical evidence for the use of vitamin D to treat Covid-19. The study, "Effect of Calcifediol Treatment and best Available Therapy versus best Available Therapy on Intensive Care Unit Admission and Mortality Among Patients Hospitalised for COVID-19: A Pilot Randomised Clinical study," was published in The Journal of Steroid Biochemistry and Molecular Biology this August 29.

It's called a pilot because the sample size is still small, but its randomisation and prospective design still make it a robust research.

#### What the study did and found

Researchers randomly allocated 76 confirmed cases of Covid-19 into either oral calcifediol (50 patients) or no-calcifediol control (26 patients) groups on the day of the hospital admission.

Oral calcifediol was given at high doses at 0.532 mg on the first day and then at 0.266 mg on the third and seventh day, and then weekly until discharge or admission to the intensive care unit (ICU). Calcifediol, also called 25-hydroxyvitamin D3, is the main metabolite (effector) of vitamin D3.

All patients also received the best available standard care at that time, which was hydroxychloroquine plus azithromycin. Note that this study was conducted a few months ago when hydroxychloroquine has not yet been proven as ineffective for Covid-19, the study authors admitted.

Both calcifediol and control groups had similar baseline characteristics in terms of age, sex, comorbidities (lung, cardiovascular, and kidney diseases, type 2 diabetes and immunosuppression), and clinical biomarkers of disease severity (oxygen levels, C-reactive protein, interleukin-6, ferritin, D-dimer, lactate dehydrogenase, and lymphocyte count).

The only difference is that the control group had a higher prevalence of hypertension than the calcifediol group (57.69 per cent versus 24.19 per cent).

Results revealed that 13 out of 26 pa-

tients (50 per cent) in the control group were admitted to ICU, and two died in the end. In the calcifediol group, only one out of 50 (2 per cent) required ICU admission, and none died.

These results were statistically significant, equating to a 93 per cent reduction in odds of ICU admission after adjusting for possible confounders - including hypertension.

"Our pilot study demonstrated that administration of a high dose of calcifediol... significantly reduced the need for ICU treatment of patients requiring hospitalisation due to proven Covid-19," the study authors noted.

They added: "Calcifediol seems to be able to reduce the severity of the disease, but larger trials with groups properly matched will be required to show a definitive answer."

There are a few more questions about the study, the first being: What does the study not tell us? All patients received standard care.

Thus, it is not known if calcifediol would be effective on its own. And calcifediol is a medical drug used to treat parathyroid problems, so it is unclear if normal vitamin D supplementation would achieve the same effect.

The researchers also did not measure the vitamin D3 levels of the patients, but they were probably deficient based on prior population data.

Still, it remains uncertain if vitamin D3 levels would affect the efficacy of calcifediol treatment for Covid-19. And other possible confounders in this study that the researchers did not measure are obesity, ethnicity, and socioeconomic status.

#### Second: Why calcifediol over native vitamin D3?

Calcifediol is the actual hormonal effector of vitamin D3. Upon contact with sun rays (UV-B spectrum), the skin makes vitamin D3, which can also be taken as a supplement.

The liver then converts vitamin D3 into 25-hydroxyvitamin D3, also called calcifediol or calcidiol that has wideranging effects on the immune system and other physiological systems. In this

sense, calcifediol is a better biomarker for the body's stores of vitamin D3.

Calcifediol is also 3.2-fold more effective than native vitamin D3 supplements in restoring low blood levels of vitamin D3. Because normal vitamin D3 needs to undergo liver processing first, which is not required for calcifediol. Another perk of calcifediol is its higher intestinal absorption rate.

#### Third: Is the study in line with prior clinical evidence?

The clinical trial from Spain provided the strongest evidence to date that vitamin D3 therapy could work for Covid-19. These results support prior cohort and observational studies that found low vitamin D3 levels (calcifediol) in the blood as an independent risk factor for severe Covid-19.

Low vitamin D3 status not only increases the risk of greater Covid-19 severity but of positive diagnosis as well.

In a paper published September in JAMA Network Open involving 489 Covid-19 patients, those likely deficient in vitamin D3 had a 1.77-times increased risk of testing positive for Covid-19 than those with likely sufficient levels.

The term 'likely' is used because vitamin D3 levels were measured one year before Covid-19 testing.

This result agrees with a previously published paper in Nutrients in April where investigators found that, in a sample of 107 Covid-19 cases in Switzerland, those tested positive had significantly lower vitamin D3 levels (median 11.1 ng/ml) than those tested negative (22.0 ng/ml) for SARS-CoV-2. And vitamin D3 measurement was done three days after the testing.

#### Fourth: How does vitamin D3 help fight Covid-19?

A recent breakthrough has uncovered that Covid-19 kills by bradykinin storm, in addition to the cytokine storm. The RAS regulates blood pressure and fluid volume and breaks down bradykinin.

According to the bradykinin hypothesis, SARS-CoV-2 dysregulates the RAS via its interaction with the angiotensin-

converting enzyme 2 (ACE2) receptor.

This leads to the accumulation of bradykinin, which makes blood vessels leaky. This poses multiorgan consequences; for example, it causes leakage of fluid and immune cells into the lungs and breakdown of the blood-brain-barrier.

From a mechanistic standpoint, vitamin D3 and Covid-19 both target similar physiological systems - namely, the reninangiotensin system (RAS) and immune system.

The research team that formulated the bradykinin hypothesis then proposes vitamin D as a potential treatment for Covid-10

This is because vitamin D is one of the very few hormones that regulates the RAS and prevents bradykinin accumulation. Vitamin D also acts as an immunomodulator that keeps inflammation at bay while supporting functions of B-cells and T-cells, which are essential in fighting infections and generating immunological memory.

Finally, there is a pilot randomised controlled clinical trial that supports vitamin D3 therapy for Covid-19. Oral calcifediol

(the main metabolite of vitamin D3) reduced the risk of ICU admission by 93 per cent compared to no calcifediol in Covid-19 patients.

Specifically, 50 per cent of patients in the control group were admitted to the ICU, and two died in the end. But only 2 per cent of patients receiving calcifediol required ICU admission, and none died.

This clinical trial supports prior evidence that low vitamin D3 status increases the risk of more severe Covid-19 and positive Covid-19 diagnosis.

Further, mechanistically speaking, there is no reason why vitamin D3 could not be helpful. Vitamin D3 regulates the RAS and immune system, both of which are critical determinants of how one responds to Covid-19.

BOUT 5 per cent of hospital admissions are due to adverse drug reactions (ADRs), such as headaches, drowsiness, nausea, depression, weight gain, cognitive impairments, hallucinations, agitation and cardiac irregularities.

Established risk factors for ADRs include old age, liver and renal issues, and female sex. Over two-thirds of ADRs cases are females. Female patients also have nearly a two-fold increased risk of

Although sex-specific differences in drug metabolism exist, both sexes are still medicated the same. Hardly any adjustments to dosage were practised.

"Most drugs are prescribed to women and men at the same dose," integrative biology emeritus professor Irving H. Zucker and psychoneuroimmunology professor Brian J. Prendergast wrote in their 2020 paper printed in Biology of Sex Differences, entitled "Sex differences in pharmacokinetics predict adverse drug reactions in women.

In this research, the professors reviewed over 5,000 medical papers on

drugs approved by the US Food and factor affecting drug metabolism. Drugs Administration (FDA). They found that 86 drugs are metabolised differently in males and females.

However, 86 is still an underestimate as there are other drugs with sex-specific effects in clinical practice - only that they lack pharmacokinetics (the study of drug metabolism) data. A 2017 research review, for instance, estimated that 30 per cent of drugs lack sex-specific pharmacokinetics data.

Over 90 per cent of these 86 drugs have an ADR bias towards women, examples including anxiolytics, antidepressants, cardiovascular medications and painkillers.

Why? The main reason is that these drugs have a slower clearance rate in females than males with the same dosage. So these drugs remain active for longer in the blood circulation of women.

These sex-specific differences in pharmacokinetics are also not explained by body weight, which is another known

An example is the popular sleeping pill zolpidem, marketed as Ambien, which that persists longer in the system of females than males. Women taking zolpidem often experience drowsiness and profound cognitive deficits the next morning, which might lead to driving accidents. But the FDA has already cut the prescribed dosage of zolpidem to women by half in 2013.

#### Why do drugs have sex-specific ef-

One reason is inherent biological sex differences. Women generally have a lower gastric pH and emptying rate, plasma (a blood component) volume, body mass index, lean body mass, organ blood flow, organ sizes and total body water.

There are also variations in the immune system and hormonal reactions between sexes - all of which contribute to disparities in drug metabolism, distri-



bution and absorption.

Lifestyle factors also play a role. Women tend to use more drugs related to reproductive and mental health, which may complicate reactions to other medications.

A population study of over 16 million women and 13.5 million men undergoing medications in the US showed that women took more types of drugs than men (5 vs. 3.7 different medications per year), and women were also less likely to adhere to chronic prescriptions.

So, the higher rates of ADRs in women may be partly a result of increased usage and decreased adherence to medica-

#### Females underrepresentation in research

Why do current drugs have a strong ADR bias against females? Research shows that the number one reason may be a result of the underrepresentation of females in clinical trials. Therefore, any positive outcomes from a clinical trial may only be applicable to males, and less so in females.

Only as recently as in 1993 did the FDA lift the ban of women of childbearing age to participate in clinical trials. The ban was initially made in 1977 in response to the disaster of thalidomide, a drug to treat pneumonia or nausea during pregnancy, that later caused thousands of birth defects.

Although the ban was revoked, most prescribed drugs today were approved

by the FDA before 1993; for example, zolpidem - as discussed above - was approved in 1992. And clinical trials still face the underrepresentation of females.

A machine reading study extracted sex data from 43,135 published reports and 13,165 clinical trials between 1966 and 2018. Analyses unveiled male overrepresentation in seven out of 11 disease categories: HIV/AIDS, chronic kidney diseases, cardiovascular diseases, neoplasms, digestive diseases, neurological disorders, and hepatitis.

Only the musculoskeletal disorders category had female dominance. The remaining three groups - diabetes, mental disorders, and respiratory diseases - had more balanced sex representations.

A research review of 107 clinical trials conducted in the US in 2015 - funded by the National Institutes of Health (NIH) calculated that 72 per cent of trials did not consider sex as a factor in their analyses. So these trials would not know if the drug(s) of interest had any sex-specific

"When it comes to prescribing drugs, a one-size-fits-all approach, based on maledominated clinical trials, is not working and women are getting the short end of the stick," Professor Zucker noted, adding: "Neglect of females is widespread, even in cell and animal studies where the subjects have been predominantly male.

I can vouch for this; the majority of neurobiology or brain research used male animals. This is to avoid the confounding effects of hormonal fluctuations in females, we think.

It is not just neurobiology; in fact, "female subjects are underrepresented in animal research across disciplines", stated a 2018 review in Current Opinion in Behavioural Sciences.

However, such an assumption is unfounded, and the review title speaks for itself: "Inclusion of females does not increase variability in rodent research studies."

#### Is lowering drug dosage the answer?

"The common practice of prescribing equal drug doses to women and men neglects sex differences in pharmacokinetics and dimorphisms in body weight, risks overmedication of women, and contributes to female-biased adverse drug reactions," professors Zucker and Prendergast wrote, adding: "We recommend evidence-based dose reductions for women to counteract this sex bias."

Lowering drug dosage is a solution, but not an easy one - and this owing to the lack of pharmacokinetic data on women. If the drug becomes useless or not useful enough to relieve symptoms at a lower dosage, then there is no point.

Blindly reducing drug dosage in women is not practical. Any dose limitations must be evidence-based, as the professors said. Finding the lowest safe, effective dose is tricky, which relies on the field of precision dosing.

To sum up: Women are twice as likely to face adverse drug reactions (ADRs) than men at the same dosage, owing to biological and lifestyle differences that affect drug metabolism.

Knowing this, why are most drugs prescribed at the same dose to both sexes? The reason is the underrepresentation of women in clinical trials.

Thus, any clinical results better predict how men respond to the drug and less so about women's response. On top of that, numerous trials also did not count sex as a factor in their analyses, so data of sex-specific drug reactions for many medications have been lacking.

This makes evidence-based reductions in drug dosage, yet not compromising on efficacy, difficult in women.

# 'Tanzania emerges regional star with dozens of irritating levies abolished'

was founded in November 1998 with a globalised world economy having presented multifaceted opportunities and challenges for governments and business firms the world over. Three years later the Tanzania National Business Council (TNBC) was formed. The two institutions were formed to promote public private dialogue (PPD) so that Tanzania could face challenges presented by the globalised world economy and also

QUESTION: TPSF prides itself as the voice of the private sector in Tanzania. How this is possible?

**ANSWER:** Of course it is. And if I may add, the private sector too is proud of its organization as TPSF belongs to members. It is an NGO, which incorporated under the Companies Act, Chapter 212. TPSF has no income other than the revenue accumulated from members' voluntary contribution. The TPSF uses that revenue to felicitate its core mandate. That is why I have said our members are proud of TPSF; they founded it, they fund it and they use it for the good of private sector and the nation as a whole. Together with the Tanzania National Business Council (TNBC), the two institutions promote public private dialogue (PPD). And let me tell you PPD has done wonders for the private sector and for this nation.

#### Q: Wonders, what kind of wonders?

A: PPD has enabled us to engage harmoniously and effectively the government. The private sector has to engage the government in order to create conditions favourable to investment and doing business in our country. You need things like regulatory reforms to achieve this goal. PPD has helped us to achieve the kind of regulatory reforms we had in mind. Remember Tanzania does business with her neighbours in the East African Community (EAC) and in the Southern African Development Community (SADC).

#### Q: Some reports suggest that Tanzania tops the list in implementing the PPD in the EAC or the SADC. Is this

A: That is actually the case. This is not the first time I have been asked about Tanzania's performance on this issue. And my answer has always been the same, that: using the PPD, Tanzania has developed and implemented a Blue Print (BP) on regulatory reforms. The Blue Print seeks to improve business environment. To fast track the Blue Print implementation, Tanzania has formed BP Sector specific TWGs which bring together private and public sector representatives. Similarly, the private sector has responded with a model to streamline private sector action areas or action plans by forming private sector-led BP TWGs. I wish to put on record that as a result of the PPD, as of July 1st this year, a total of irritating 233 levies had been removed. This is a big number of levies that have been swept away in just

four years --- between fiscal year 2017/2018 and 2019/2020. We are proud of this achievement; it is big one.

O: Now that you are talking about SADC, I want to remind you that TPSF was chairing the SADC Business Council until recently before handing over to Mozambique. Do you have anything to talk about?

A: Yes there is something to talk about. Our membership in the SADC Business Council is beneficial. SADC Business Council is a regional body where regional policy issues are discussed to promote regional cooperation and intra-trade. I said in recent past that when Tanzania was chairing the SADC Business Council it was in a unique position to help Tanzania make its opportunities known to SADC countries; it had a unique opportunity to connect Tanzania's private sector to counterparts in the SADC region so that they can create business partnerships. And this has happened.

#### Q: What is TPSF's mandate?

A: Our mandate is to function as an apex and focal private sector organization in Tanzania. As an apex and focal private sector organization we have to enhance private sector development and ensure there is effective engagement with the government; in short we have to ensure there is effective PPD I have earlier referred to. We have to engage effectively other stakeholders in matters of development policy and in the provision of services to our members.

#### Q: Why are you forceful about your blue print for regulatory reforms?

A: The Blue Print for Regulatory Reforms has been a very welcome development. It seeks to improve business environment. This Blueprint provides Government with main framework for a holistic review of business-enabling environment (BEE) in order to improve the business climate in Tanzania. It presents key challenges affecting the business environment in Tanzania along with a set of recommendations for reform to put in place a more business-friendly environment.

Many policies have been reformed by our engagement of the government and other stakeholders. For example the fiscal policy, or the tax regime, has been reformed for the good of our nation; these reforms sought to make the private sector work effectively and in a friendly environment. A good number of regulatory constraints have been addressed as a result of implementing the BP on regulatory reforms. As I reported earlier some 233 levies which had been a burden to the business community have been abolished. However, the business environment is not static, it is dynamic. New constraints do emerge hence making TPSF's engagement with the government continuous.

#### Q: What is the relationship between TPSF and TNBC?

A: Correct. Both of us work together to strengthen the PPD. We have a close history. It is the TPSF that convinced the government to establish the TNBC. We needed a platform that is well-structured to enhance PPD. In the TNBC you have that kind of well-structured platform.

The TNBC Executive Secretary is one of our Board Directors. This keeps the two institutions closely engaged and informed of each other's strategies and objectives. We are very close.

#### Q: Tell us something about TPSF's representation in the TNBC's meetings.

A: The TPSF has the mandate to suggest private sector representatives in the TNBC meetings. Using its clusterbased membership structure, TPSF forms its board of governance. Cluster representation is important in ensuring good representation in the TPSF itself. Cluster chairpersons automatically form our board of directors. These directors, or cluster chairpersons, represent their members in TNBC meetings. These directors present views and concerns of our members in all key sectors of the economy in TNBC meetings. The TPSF picks companies, associations and individuals it deems have such a big contribution to our nation's economic growth to attend TNBC meetings. From this explanation you can see how the private sector is well represented in the TNBC meetings.

#### Q: How do you sum up TPSF's major achievements?

A: I have just said that it TPSF that convinced the government to form the TNBC. Twenty members from the public sector and another

20 from the private sector form a good platform I always talk about. The president of the United Republic is the Chairman of the of the meetings of the council and the co-chairman is the chairman of TPSF. This council meets twice every year to discuss the business environment and investment climate. Formation of the TNBC was one of our laudable achievements.

The TPSF has launched the Sector Skills Council (SSC) with a view of bridging existing skills gaps in Tanzania. This effort seeks to equip the workforce with skills that are required for the jobs of today and those of tomorrow. We consider this to be a strategic concern that will help Tanzania to realize the envisaged industrial economy come 2025. Employers are feeling the impact of the talent shortage and they foresee this skills gap getting even worse over the coming years. To prevent the situation from worsening, the government mandated TPSF to coordinate the establishment of SSC. This is another big achievement.

I have talked about the establishment of the Blue Print for Regulatory Reforms to improve business environment. We need a more business-friendly environment for the good of our nation.

#### Q: Can TPSF talk independently to foreign stakehold-

A: It can; it does. TPSF engages foreign stakeholders with a view to see the private sector flourish and contribute to enhancement of Tanzania's economic growth or Tanzania's gross domestic product (GDP) and development. I have once said that we have had very productive engagement with European Union. Our foundation has been instrumental in facilitating cooperative efforts Tanzania has had with foreign missions represented here. One such good foreign stakeholder is the Japanese International Cooperation Agency (JICA).



# Mtwara RC counsels NMB to target teachers with tailor-made products

ANKS including NMB Bank plc should come up with tailor made products that target teachers and prevent them from acquiring loans unnecessarily which affects their progress in

Mtwara Regional Commissioner, Gelasius Byakanwa said last week during an NMB Teachers Day for this year that many teachers are struggling to repay multiple loans some of which taken unnecessarily from loan sharks hence the need to wean them.

"Thank you NMB for bringing this training to teachers so that they should learn the discipline of acquiring loans to invest in profitable businesses and not consumption," Byakanwa who officiated the event said.

He said because of poor loan expenditure many teachers are suffering with their families because of the burden of repaying such loans which simply squandered. " Stop borrowing unnecessarily to avoid the burden of repaying the loan which does not generate any income," he advised.

The Mtwara RC commended NMB for organizing the forum and extending banking services to teachers saying it is President John Magufuli's order to have formal banking services extended to the majority of Tanzanians including those in rural areas.

He also dared the teachers to stop fearing

to borrow and invest in sustainable income generating projects that will help them improve their standards of living. "Learn to invest in farming, livestock keeping and even fisheries to make money," the Mtwara Regional Commissioner noted.

Briefing participants of the annual meeting, NMB's Senior Manager for Retail Banking, Ally Ngingite said the bank has been training its customers on financial discipline before disbursing loans so that they should invest and not consume.

"NMB's pride is not only to give loans to teachers and other clients but to get borrowers who invest in opportunities that will lead to their growth as individuals, the bank as an institution and the national economy," Ngingite said.

He said the country's largest bank has 3.2 million customers of which 2.5 million are connected to its digital platforms including thousands of teachers. The NMB Senior Manager named the digital platforms as NMB Mkononi, NMB Pamoja Account, NMB Mortgage Loan and NMB Bancassurance, among others.

The bank's Southern Zone Manager, Janeth Shango backed Ngingite's arguments saying teachers in Mtwara Region are good and reliable clients of the bank.

# **UNCTAD** report says FDI flows to African nations hit by COVID-19

THE novel coronavirus will reduce foreign direct investments to Africa from last year's U\$45 billion to an average of U\$30 billion this year.

United Nations Conference on Trade and Development's World Investment Report titled 'International production beyond the pandemic' said the downturn will be exacerbated by low oil and commodity prices.

"FDI flows to Africa are forecast to decline by 25 to 40 percent based on gross domestic product growth projections and a range of investment-specific factors. In 2019, FDI flows to Africa already declined by 10 percent to U\$45 billion," the UNCTAD report said. The UN agency also warned

chain for intensive manufacturing industries will be among the hardest but will in turn affect efforts to promote economic diversification and industrialization on the continent.

Relatively, UNCTAD said global FDI flows will also decrease by up to 40 percent this year from U\$1.54 trillion last year to about one trillion dollars this year. The global FDI is projected to decrease by a further 5-10 percent in 2021 before some recovery in

"A rebound in 2022, with FDI reverting to the pre-pandemic underlying trend, is possible, but only at the upper bound of expectations," the report cau-

alerts are an early warning sign with the top 5'000 MNEs worldwide, which account for most of global FDI, having seen expected earnings for the year revised down by 40 percent on average.


Lower profits will hurt reinvested earnings, which account for more than 50 percent of FDI on average. "After an increase in 2018, FDI flows to Sub-Saharan Africa decreased again by 10 percent in 2019 to U\$32 billion. FDI to West Africa fell by 21 percent to U\$11 billion in 2019 largely driven by the steep decline in investment in Nigeria," the report underlined.

In the same year, FDI flows to East Africa decreased, by nine percent to U\$7.8 billion as in-

that investment in global value Multinational enterprise profit flows to Ethiopia contracted by a fourth to U\$2.5 billion. Central Africa received U\$8.7 billion in FDI which was a decline of seven percent mainly due to the fall in flows to the Democratic Republic

of the Congo. Southern Africa was the only sub-region that received higher inflows in 2019 with a 22 percent increase to U\$4.4 billion but only due to the slowdown in net divestment from Angola

FDI inflows to North Africa decreased by 11 percent to U\$14 billion, with reduced inflows in all countries except Egypt. Egypt remained the largest FDI recipient in Africa in 2019, with inflows increasing by 11 percent to U\$9 billion.

#### **African Union-backed** app seeks to speed up border re-openings

**ADDIS ABABA** 

TWO major African public bodies are promoting a new technology that could connect the continent's Covid-19 testing centres and ease a reopening of travel across the region.

The African Union and the Africa Centres for Disease Control and Prevention are encouraging member states to integrate the mobile-based PanaBIOS platform that would allow results from facilities across the continent to be centralised. So far, only Ghana is using the service.

"Ghana is being used as the pioneer," the West African country's communication minister, Ursula Owusu-Ekuful, said in the capital, Accra. "The learnings from the uptake of the app and the usage of the app will be shared with the Africa CDC and be applied by other African countries," she said.

Most African nations have either kept their borders closed since the pandemic began to spread or reopened with tight restrictions. Some require multiple negative coronavirus tests and, in some cases, self-isolation at a designated hotel at the expense of the traveler. Ghana, which resumed international flights Tuesday, still requires a pre-arrival and on-arrival test to gain entry.

PanaBIOS may eliminate the need for travellers to take repeated tests so long as they are coming from a country that's also signed up to the platform, Preston Asante, a spokesman, said at the Ghanaian launch. The implementation of the technology,

developed by Koldchain, a Kenyan startup, is being funded by AfroChampions, an organization that brings together some of the biggest companies on the continent.

#### **Reviving economy**

Easing travel restrictions is vital for the success of an African Union-led plan to implement the world's largest free-trade zone, which is now due to start in 2021 following a delay caused by the pandemic. A full deal could cover a market of more than 1.2 billion people with a combined gross domestic product of \$2.5 trillion. All but one of Africa's 55 countries – Eritrea – have signed up to the

agreement

"The reopening of the points of entry and exit which have been temporarily closed to mitigate the spread of the Covid-19 is necessary," the African Union said in an emailed response to questions. The bloc proposes a reopening at least one month before the trade deal takes effect, it said. The Africa CDC is keen to "facilitate the movement of people while at the same time ensuring critical public health measures are in place," its director, John Nkengasong, said last month.

### Sanofi and GSK hoping to price Covid-19 vaccine at under €10

**PARIS** 

A CORONAVIRUS vaccine that Sanofi is developing with Britain's GlaxoSmithKline is likely to be priced at less than €10 (\$11.80) per shot if it is approved for use, Sanofi's chief in France said on Saturday.

"The price is not totally set ... We are assessing production costs for the coming months ... We will be below €10," Olivier Bogillot told France Inter radio. Drugmakers and government agencies are racing to come up with vaccines for the new coronavirus and treatments for Covid-19, the respiratory diseases it causes which has killed more than 879,000 worldwide and wrecked economies.

Asked about rival AstraZeneca, which is expected to price its shot at about €2.50 in Europe, Mr Bogillot said: "The price gap for us can be that we use all our internal resources, our own researchers, our own research centres. AstraZeneca outsources part of its production."

A Sanofi spokeswoman said in an emailed statement on Sunday that a final price would only be decided when the vaccine reaches its final testing stage. "We anticipate being able to determine a final price at the time of our Phase III trials, when we know more about dosing. At this stage, any figure is imprecise. Less than €10 is only one of the hypotheses we are working on."

Earlier this week, Sanofi and GSK said they had started a clinical trial of their proteinbased coronavirus vaccine candidate, with the ambition of reaching the final testing stage, also known as Phase III, by December.

If the results are positive, Sanofi and GSK hope to get the vaccine approved in the first half of next year. Sanofi is also working on another coronavirus vaccine candidate with US group Translate Bio that will use another technology known as messenger RNA.

# Lindi communities plead with state for gazetting of their forest reserves

OMMUNITIES in Mtama District of Lindi Region are up in arms with authorities demanding that their virgin natural forest be gazetted so that it earn them money to finance development projects.

The Chiodya And B villagers whose main occupation is farming have already allocated their village land forest reserve which they have been guarding jealously to prevent illegal logging but now want legal backing to enable them sustainably harvest their hardwood rich forest.

Briefing journalists who were on a field visit to the areas last week, Chiodya A and B Village Chairman, Juma Chijinga said both villages have already endorsed their land use plans with allocations for the forest reserve where sustainable log harvest will produce timber for selling.

"What we need from the government right now is to help us declare our forest as a reserve so that we can earn revenue to invest in community development projects similarly to other villages within the region," Chijinga said.

He pointed out that hundreds of youth in the area have no work to do as sesame farming has been badly affected by poor roads which has prevented traders from accessing the villages to buy the commodity. "Our villages are also famous for oranges cultivation but the problem is the same, poor roads are keeping customers away and even if they reach us then prices are determined by the traders," he said.

The Chiodya Village Chairman further noted that with such bottlenecks agriculture is attracting less young people hence threatening the future of the villages food security. "More revenue from hardwood harvesting will enable us to repair roads and allow traders access to our commodities," Chijinga argued noting that their peers in Lindi District are already enjoying increased revenue thanks to the government's decision to gazette their villages' forest reserves.

Under a Community Based Forest Management Project, several villages in Lindi Region have been gazzetted to prevent illegal logging while at the same time allowing communities to sustainably harvest hardwood and earn revenue legally.

The villagers have undergone training on participatory forest management, timber measurement in terms of volumes and cubic meters, processing of forest products and use of modern machinery for log processing into timber.

"Using modern machines will help us improve quality, quantity and value of timber that we produce from our forest reserves," the Chiodya A and B Chairman added.

Seconding his village chairman, a young man from Chiodya A, Suleiman Mwilole said many young people are struggling in destitution because agriculture is no longer rewarding due to poor roads. "We cultivate sesame and oranges but customers can't access our villages because of bad roads," said the 26 year old young farmer who called on the government to gazette

their village forest

"We need legal powers to conserve and sustainably harvest from our forest reserve to earn revenue that will be invested in projects such as repairing of major roads connecting the village to Lindi District," Mwilole argued.

He pointed out that the two villages which also cultivate maize, pigeon peas and millet are de-touched from markets hence the commodities are left to rot or sold to middlemen at through away prices which discourages young farmers.

"Apart from such challenges, we are also burdened by taxes which choke the profit margin of our commodities," he stated while giving an example that for every 5/- that a trader pays for an orange, taxes gobble 3/-.

Mwilole's observation was backed by a village government member, Amina Mkongo who said although both villages have active farmers producing all types of commodities, poor road infrastructure has been a major hurdle to access markets for commodities.

"Bad roads have meant that transport costs are very high hence denying smallholder farmers better earnings from their commodities," Mkongo said adding that selling timber from the designated forest reserve will enable them invest the proceeds in infrastructure improvement

According to her, villagers usually use motorcycle taxis to travel to Mtama Urban paying between 20 and 24,000/- for a return trip covering seven kilometres. "Paying between 20 and 24,000/- as fare for 'Bodaboda' to go to Mtama District headquarters which is very expensive for an average Tanzania to afford," she argued saying women and children also suffer because a health centre is also located there.

Lindi District Commissioner, Shaibu Ndemanga who recently announced that through Government Notice No. 487 published in June, nine villages in his district have their forest reserves officially recognized by the state. Ndemanga named the villages as Mahima, Kiwawa,

Ruhoma, Milola Magharibi, Kinyope, Likwaya Muungano, Mkombamisi and Makumba.

"This is an important step towards making these villagers own their forests and use them sustainably by adopting forest management plans," Ndemanga naming Mahima Village as one of them already making progress since the legal recognition.

"Right now the village will has a mandate to own the forest reserve and harvest trees sustainably by developing bylaws that support management plans," he added noting that the forests are directly under the Village Natural Resources Committees.

He commended Mahima villagers with 3,125 acres for conserving their forest through establishment of village land forest reserve for several years which led to government's decision to grant them legal recognition. The Lindi DC also thanked partners including Tanzania Forests Conservation Group for backing the villagers achieve the feat.

# External trade rebounds on easing global restrictions

#### NAIROBI

KENYA'S expenditure on imports in July rose 14 per cent month-on-month to Sh138.76 billion, signalling increased trade activity in the economy as countries continue to ease measures put in place to reduce the spread of Covid-19.

Data from the Kenya National Bureau of Statistics (KNBS) also reveals a continuous increase in the country's export earnings to Sh52 billion in July from a low of Sh43 billion April. July's consumption of imported goods was the second highest this year after January's Sh155 billion. The country's import bill fell to a low of Sh108 billion in May as a result of the pandemic.

Consequently, due to the lower imports in the April to June period, the trade deficit for the first seven months of 2020 narrowed by 19.5 per cent to Sh546 billion from Sh678.9 billion reported over a similar period last year. At the onset of the pandemic global trade volumes were expected to fall, reversing gains made in inter-regional trade, which has been growing over the years.

"Shutdown in mass production and supply chain disruptions due to the rare twin supply-demand shock will cause further uncertainty in Africa, a continent already grappling with widespread geopolitical and economic instability," said the World Bank in June.

In a bid to control the spread of the virus, Kenya in April instituted measures that included travel restrictions from countries that were hard hit by the virus, and a ban on importation of second-hand clothes, which was only lifted last month.

Non-food industrial suppliers accounted for 39 per cent (Sh54.5 billion) of the country's July imports, indicating that businesses were coming back to activity. They were followed by machinery and capital equipment imports, which took up Sh26.7 billion in the month.

On the export side, food and beverages

remained Kenya's biggest earner, bringing in Sh21 billion during the month and Sh153 billion in the first seven months of the year. China remained Kenya's top import source, accounting for Sh34 billion in July and Sh193 billion in the seven-month period, followed by India at Sh15 billion and Sh192 billion, respectively.

In the seven months to July, Pakistan which is the biggest consumer of Kenya's tea, beat Uganda as the biggest destination of Kenyan goods, importing Kenyan goods worth Sh32.4 billion ahead of Uganda's Sh30.2 billion.

# Consumer confidence improves in third quarter as lockdown eases

#### **JOHANNESBURG**

SOUTH African consumers regained some confidence in the economy in the third quarter after consumer confidence hit a 35-year low in the previous quarter, a survey showed on Monday, as the country businesses from the lockdown.

The consumer confidence index (CCI), sponsored by First National Bank and compiled by the Bureau for Economic Research, edged up to minus 23 points in the quarter from minus 33 points in the second quarter.

According to the survey, the partial recovery took place as consumers were able to resume work and add to household finances, which spurred spending on some durable goods. However, big-ticket purchases such as vehicles and furniture were still low priority.

"The gradual lifting of restrictions and the resumption of economic activity as South Africa moved from level 4 of the risk-adjusted strategy in May to level 3 in June and level 2 in August have finally allowed most consumers to go back to work and earn a living," FNB chief economist Mamello Matikinca-Ngwenya said.

The survey, however, reinforced economists' view that the Covid-19 crisis and economic restrictions were a blow to consumers' ability to spend – and that it may take years for the confidence and household incomes to rebound. Between March and June, South Africa enforced one the world's strictest lockdowns, forcing mines, manufacturers, retailers and services to shut down or operate under tight regulation.

Last month, South Africa re-opened its borders for leisure travel, lifting the bans on the sale of alcohol and tobacco products and permitting visits to family and friends in small groups. #### China's August exports rise as trading partners ease corona virus containment restrictions

#### BEIJING

CHINA'S exports rose for the third consecutive month in August, eclipsing an extended fall in imports, as more of its trading partners relaxed coronavirus lockdowns in a further boost to the recovery in the world's second-biggest economy.

Exports in August rose 9.5 per cent from a year earlier, customs data showed on Monday, marking the strongest gain since March 2019. The figure also beat analysts' expectations for 7.1 per cent growth and compared with a 7.2 per cent increase in July.

Imports however slumped 2.1 per cent, compared with market expectations for a 0.1 per cent increase and extending a 1.4 per cent fall in July. The strong exports suggest a faster and more balanced recovery for the Chinese economy, which is rebounding from a record first-quarter slump thanks largely to domestic stimulus measures.

"China's exports continue to defy expectations and to grow significantly faster than global trade, thus gaining global market share," said Louis Kuijs of Oxford Economics. "The import data disappointed, pointing to the need for caution as we assess growth of China's domestic demand."

A private survey on manufacturing activity last week showed Chinese factories reported the first increase in new export orders this year in August as overseas demand slowly revives. The pick-up in business also led to a further expansion in production, marking the sharpest gain in almost a decade.

China's export performance, boosted by record shipments of medical supplies and robust demand for electronic products, has not been as severely affected by the global slowdown as some analysts had feared. But imports unexpectedly slipped further into contraction, suggesting softer domestic demand.

Copper imports in August eased from the previous month's all-time high, as an arbitrage window to bring in overseas metal shut and demand from key consumption sectors slowed. Coal imports slipped 20.8 per cent from the month before. China posted a trade surplus of \$58.93 billion last month, compared with the poll's forecast for a \$50.5bn surplus and \$62.33bn surplus in July.

The outlook is still far from rosy as external demand could suffer if virus control measures have to be re-imposed by trade partners later this year on a resurgence of the epidemic. China also is looking to reduce its reliance on overseas markets for its development as US hostility and the pandemic increase external risks that could hamper longer-term progress.

Already heightened US-China tensions are expected to escalate ahead of the US presidential election. China remains well behind on its pledge to boost purchases of US goods under an agreement that was launched in February. China's trade surplus with the US widened to \$34.24bn in August from \$32.46bn in July.

Top US and Chinese trade officials reaffirmed their commitment to a Phase-1 trade deal in a phone call last month. "Both sides see progress and are committed to taking the steps necessary to ensure the success of the agreement," the US Trade Representative's Office said.

It last week extended tariff exclusions for a wide range of Chinese goods such as smartwatches and some medical masks but only through the end of 2020, a move that may create some leverage for Washington in the bilateral trade negotiations but increasing uncertainty for businesses.

# Kilimo-Viwanda Scholarship Programme churning out experts in agricultural sector

AS the government targets to turn the country's into a semi industrialised economy by 2025, some private companies are in the forefront of backing such efforts through investment in agriculture.

Experts argue that in order to have a successful industrial revolution, an agrarian revolution must happen first because commodities which feed industries as raw materials come from farming.

Serengeti Breweries Limited is championing an agrarian revolution through its 'Kilimo-viwanda' Scholarship Program which targets to train youths coming from poor families in areas where the brewer sources its

One such beneficiary of the program is Sarah Hassan whose rags to riches story is unique. "Life is tough when you are born and raised in poverty. It becomes even tougher when you have no access to education, an important tool that can liberate someone from abject poverty," said Hassan whose story can drive a tender soul to near-

twenty-two-year-old young lady never saw her father because he passed away when she was still a infant. She lived with her mother together with four sisters in Iramba District of Singida Region until at age seven when her mother too passed away. After her mother's death, she went to live with her grandmother.

"Life was equally tough as my grandmother was old and depending on rain-fed subsistence farming which quite often failed," she said adding that her mother's death also led to disintegration of the family, with her siblings going their own ways. Her elder sister went to Arusha where she managed to secure a job at a horticultural farm and took her as life was unbearable with an aged grandee in Singida.

She started living with her sister in a small rented room with no electricity when she was ten years old. "I took advantage of the government's free education program, studied very hard and was able to get into secondary school," she narrated.

After completing form four, she applied for a course in agriculture at Iringa- based Saint Maria Goretti Agriculture Training Institute where she was enrolled but failed to join as her sister could not afford to pay fees. "I had to postpone joining the college and assist my sister to raise my school fee for the following academic year," Hassan noted.

Following a year-long struggle to raise the required school fees for the first semester, she luckily heard the college principal announcing funding available under SBL's 'Kilimoviwanda' Scholarship program.

"I immediately applied for the scholarship and thank God, I was successful. With the scholarship I was a brighter future unfolding for me," said the young lady who has since graduated from college and leading a decent life.

Dozens other youth coming from poor families are currently benefiting from the brewer's scholarship program countrywide. Ten such students who were with Hassan at Saint Maria Goretti, have written a letter to express their appreciation to SBL's management and staff while explaining what the scholarships means to their future.

Dated 11th July 2020, the letter, signed by all the ten beneficiaries reads in part: "We, students from Saint Maria Goretti Agriculture Training Institute, would like to extend our heartfelt thanks to SBL for supporting our education during this difficult period. We really needed this assistance which has now shaped our future. If we had not received this scholarship, our academic future would have been unpredictable. The scholarship has given us a reason to believe in a brighter future. Our poor families too are very grateful. May God bless you all!"

But beneficiaries of the scholarships are also studying at Moshi-based Kilacha Agricultural and Livestock Training Centre in Kilimanjaro Region. One of them is 25-year-old Domina Minja who was raised by her single mother which forced her to engage in odd jobs to raise money for her

"In 2016, I was forced, due to lack of fees, to postpone my studies because my peasant mother could not afford the fees. I had to seek odd jobs with meagre payment to raise money for my college fees. It was sweet news when I learnt that I was a proud recipient of SBL's 'Kilimo-viwanda' Scholarship," narrated the young woman who has since stopped worrying about where her fees will come from.

SBL's 'Kilimo-viwanda' Scholarship Program has been supporting 30 students annually who are attending classes at Kaole Wazazi Collage of Agriculture in Bagamoyo District of Coast Region and Igabiro Training Institute of Agriculture in Bukoba District of Kagera Region.

Kaole Wazazi College of Agriculture's Principal, Sinani Simba said training of the young agriculture technicians is one of the priorities spelt out in the Agriculture Sector Development Program Phase 2, as a prerequisite to increase productivity and boost incomes of smallholder farmers.

The brewer's Corporate Relations Director, John Wanyancha said SBL has allocates 120m/-annually to bankroll 40 students pursuing agro-related disciplines at the named tertiary colleges with an objective to reduce shortage of technical officers in the agriculture sector.

"Our scholarship program is tailored to benefit students from underprivileged backgrounds who cannot afford to pay for their studies. We believe this program will go a long way in strengthening the existing pool of agricultural experts in the country which is necessary in helping farmers increase productivity and ultimately their incomes," Wanyancha said.

#### **Companies effect payments of** 'carbon debt' to erase past sins

COMPANIES routinely set targets for reducing their greenhouse gas emissions. But a new kind of environmental target is emerging that has been likened to paying reparations to victims of past injustice. The idea is to eliminate not only current pollution but also to account for and counteract climate damage from the corporate past.

The first big company to make such a pledge was Microsoft Corp. In January it announced plans to remove enough greenhouse gas to zero out its emissions and energy use dating back to its founding in 1975–some 27.3 million tons of carbon dioxide. Now on Tuesday, Velux A/S, a Danish maker of roof windows, pledged to eliminate carbon dioxide that matches its estimated emissions since its founding in 1941. That effort, along with a new 2030 climate goal, would allow Velux to claim "lifetime carbon neutral" status by its centenary in 2041.

The idea of measuring historical CO has been gaining traction, particularly following the 2015 Paris Agreement that emphasised the need for equity between rich and poor countries in the effort to limit global warming to 1.5 degrees Celsius. Wealthy nations have historically emitted far more greenhouse gas than poorer nations, and so the Paris framework asserts a responsibility for them to take the lead.

The UK, for example, became the first country to adopt a target for zeroing out greenhouse gases by 2050, in part because of its past pollution. Despite making up only 1% of the global population today, the UK is responsible for between 2% and 3% of global temperature rise, according to the UK Committee on Climate Change. Some companies are starting to think along similar lines.

"You're trying to eliminate prior damage," says Cynthia Cummis, director of private sector climate change mitigation at the World Resources Institute. Measuring and eliminating historical carbon, she says, is similar to paying reparations–and sometimes, it seems, nearly as controversial to implement and difficult to measure.

For Velux, these payments for emissions of its past will take the form of investments in forest conservation projects, which can act to reduce carbon dioxide by preventing deforestation. Microsoft also backs forest projects as well as other nature-based methods, and the software giant created a \$1 billion climate investment fund to bolster carbon-removal technologies, a nascent field that works to pull planet-warming gases from the atmosphere.

Accounting for the past is a tricky matter, with virtually no independent assessment at the corporate level. A project by the Climate Accountability Institute, a watchdog group, tracks the historical emissions of the world's biggest oil companies. The group's data, which goes back to 1965, ranks Saudi Aramco at No. 1 with past emissions equal to nearly 60 billion tons of carbon dioxide. Exxon-Mobil, Chevron, BP and Shell all rank in the top seven.

There's no comparable data for most

other industries. An early adopter of climate action, Velux has been recording its own operational emissions since 2007. This left a gap covering its energy use data between 1941 and 2006, without an easy way to account for those emissions. "Our strategy is fully homegrown, so it's totally our own people who have come up with how ambitious should we be," said David Briggs, chief executive officer

To estimate the footprint of its first Danish factory in 1941, the privately held window maker took the emissions factor of coal-reliant Poland in 1990 which was the worst in Europe - and then added 10%. The carbon intensity of electricity has improved dramatically since World War II, driven by the first oil crisis in 1972. But it's hard to calculate accurately because countries vary in the rate at which they've switched to cleaner fuels, and Velux now operates in 40 countries.

The final figure came to about 4 million tons of CO equivalent in its historical operations and electricity use, known in carbon accounting terms as Scope 1 and Scope 2 emissions. These estimates have been verified by the Carbon Trust, an organisation that tracks carbon footprints. Velux added a 25% safety buffer, assigning itself a total of 5.6 million tons through 2041.

The company joined with environmental charity World Wide Fund for Nature to work on forest conservation projects in Uganda and Myanmar that will start to repay the carbon debt over the next two decades. Briggs said that Velux won't claim any carbon credits from those projects. Many companies, rather than reduce their carbon output, will buy credits to meet targets. If one of the forestry projects fail or under-delivers, Briggs added, the safety buffer in its carbon accounting makes for allowances. "This is not offsetting," Briggs said. "This is our-I hesitate to use the word-but this is our gift to society."

For both Microsoft and Velux, the goal is to eliminate only those past emissions from direct operations and electricity. The vast majority of corporate emissions often come from either the supply chain or through the use of products, which is known as Scope 3. For Velux, this category accounts for about 94% of emissions. Briggs said the company plans to halve those emissions by 2030, largely by finding ways of reducing the energy intensiveness of making aluminum and glass, a process that emits much of its carbon.

Like Microsoft, Velux won't seek to eliminate its past supply chain emissions. The old data would be too sketchy to measure. That's fine with World Resources Institute's Cummis, who thinks companies ought to first work on decarbonising their current business operations before tackling past pollution.

Perhaps the biggest impact of these early carbon-debt plans will be to encourage other companies and even governments to follow suit. "Companies often do what they can to influence the direction of policy," Cummis said. "It could be interesting to see how you could translate that into a national tar-

# Why more Ugandan farmers aren't adopting drought-tolerant maize

MAIZE is one of the most important cereal crops in Uganda. In particular, smallholder farmers rely on it for food and as a cash crop. They also grow it as an important export

Over the years, total maize production in Uganda has gradually increased, from roughly 800,000 tonnes in 2000 to 2,575,000 tonnes in 2019. But this is largely due to a steady expansion of maize acreage, little from improved productivity.

Low productivity is one of the biggest challenges facing Uganda's maize industry. The reason for this is that, as most maize farmers are smallholders, their use of agricultural technology, such as fertiliser and improved seed, is very limited. There are also concerns that changes in temperature and rainfall - specifically increases in temperature and decreases in rainfall - will further affect maize production.

To address these challenges, in 1991 Uganda released improved maize varieties with drought tolerance. Although it depends on the conditions of the maize growing areas, studies indicated that compared with local varieties, drought-tolerant maize can increase yields by 15%. It also reduced the probability of crop failure by 30%.

But, even after 30 years, drought-tolerant

maize has yet to be widely adopted by smallholders. In one study, which covered 1,000 households, just 14% used the modified seed in their fields. I set out to understand why smallholders did or didn't plant drought tolerant maize. To do this I used available literature, policy documents and reports.

I found that the constraints to adoption included: Different farmer characteristics such as wealth or education level; A lack of information or understanding about the seeds; The attributes of the seeds themselves and whether they meet the farmers' needs; and Counterfeit seed and fertiliser in markets.

For drought-tolerant maize to be more widely adopted, it's crucial that policymakers support smallholders with effective information campaigns and subsidies. They must also ensure the markets for the seed and complementary fertiliser are reliable and meet farmer needs.

#### **Current constraints**

There are two seed systems in Uganda. One is formal and the other informal. Through the formal system, improved seeds, including drought-tolerant seeds, are developed under the National Agricultural Research Organisation. The National Seed Certification Services regulates the formal seed sector from variety listing to seed certification for commercial seeds that private seed

companies distribute. But in Uganda, 85% of seeds planted - which includes local maize varieties - are through the informal system.

Most maize farmers in Uganda are resourceconstrained smallholders. Thus, their decision to adopt the drought-tolerant maize may be influenced by perceived economic risks. The seeds of the local maize varieties that farmers use are ones that they've saved from previous harvests, and may cost them

depending on the variety, while the local seed cost nothing.

However, a study calculating the costs and benefits of modified seed found that the drought-tolerant maize could be more economically beneficial. For instance, local maize could require more labour costs due to less resistance, if any, to pests, weeds and diseases. Also, the higher yield of the improved maize could compensate for nothing. In 2015, modified maize seed could the higher seed and fertiliser costs. This cost up to Ush6,000 per kilo (about US\$1.60) suggested that the reason for low adoption

by smallholders may not be financial.

#### **Information and education**

A number of factors determine whether small-scale farmers adopt a new seed or not. Farmers need information on how the seeds work, and will decide whether or not to use them based on this. Whether a farmer has relevant information is based on the farmers' network, specifically, contact with extension services, NGOs or cooperative memberships. Their understanding is also affected by levels of education or farming experiences. If the farmer decides to cultivate the new seed, it must be physically available, accessible, and

However, studies also show that even when critical conditions are met - farmers have awareness, access and can afford the seeds universal adoption is highly unlikely. One of the reasons for this is because farmers prefer traditional varieties. This could be because the traditional varieties may be more resistant to pests, taste more familiar or mature faster. There's also evidence that some drought tolerant varieties don't suit certain local conditions.

Counterfeit seeds are another issue. Between 30% and 40% of seeds traded in Uganda are thought to be counterfeit. Farmers will be less likely to take the risk of using modified seeds if they believe they might be counterfeit.

#### The state that has others green with envy

**NEW YORK** 

AS several states in the United States deal with rising cases of COVID-19, one state, Vermont, has bucked the trend as well as the hardest ravages of the initial pandemic.

Known for its small villages, low population, rolling hills, maple syrup, autumn foliage, skiing and for being the home of the former Democratic presidential contender Senator Bernie Sanders, the Green Mountain State in New England has avoided the coronavirus toll that has hit other states, especially its neighbors New York and Massachusetts.

Massachusetts to the south has had more than 119,000 coronavirus cases and more than 8,830 deaths, and New York to the west, once the epicenter of the virus in the US, has had more than 440,000 cases and more than 32,900 deaths. The US has had more than 6 million confirmed cases of the virus and more than 184,800 deaths.

By Saturday, Vermont had had 1,647 infections and 58 deaths, and 143,088 people had been tested for the virus since mid-March, the state health department said.

Those numbers have put a national spotlight on the state, with media coverage that has asked how it has performed so well compared with others.

The state's motto is "Freedom and Unity", and the latter, health department officials say, is part of the answer. They also give credit to Republican Governor Phil Scott.

"Neighbors are concerned about neighbors," said Tracy Dolan, deputy commissioner of the state health department. "They help each other out, making sure that people can get to the grocery stores. We have a good Meals-on-Wheels program for the elderly, and there is positive peer pressure to wear masks. ... We're in good shape."

Residents have "a high level of trust" for public health experts and listen to information on TV and public radio, she said. Many are used to stocking up on supplies to cope with harsh winters. Some grow vegetables and chickens, and this discipline has helped them adapt to quarantining. Public health science

Dolan also singled out strong leadership from state health officials and from the commissioner of health, Mark Levine, and praised Scott for paying attention to science:"The governor has been really open to understanding and paying attention to public health science and has listened closely to it and has been guided by it."

Preemptive action by Scott and the state health department officials and Vermont being a rural state with a low population aided the success, she said.

It is the second least-populous state, with 623,989 people. Residents are 92.4 percent white, 1.4 percent African American, 1.9 percent Asian, 0.4 percent American Indian and 2 percent Latino.

In May Scott said Vermont was "the envy of the nation" because of how it had handled the pandemic.

"We took a lot of steps early, and we didn't waste a lot of time, and Vermonters accepted that," he said in June, heaping praise on the state's residents. "And they also complied with all the measures."

Scott declared a state of emergency on March 13 and the order was extended on Aug 14 to Sept 15. He has allowed local discretion for size limits on gatherings and sales of

Scott said that one of his most important decisions was to shut bars and restaurants before St Patrick's Day. He also shut hotels and put homeless people in motels and

# 'Hotel Rwanda' hero was not kidnapped - Kagame

**KIGALI** 

RWANDAN President Paul Kagame denied on Sunday that his government had kidnapped from abroad Paul Rusesabagina, whose widely acclaimed heroism inspired a Hollywood movie but who has been detained on terrorism and other charges.

At a virtual news conference in the capital, Kigali, Kagame (pictured) did not say exactly how Rusesabagina had been taken into custody but suggested he had been tricked into travelling to Rwanda before he was arrested.

"It was not the case," Kagame said, referring to accusations of kidnapping.

"There was no kidnap. There was no any wrongdoing in the process of his getting here. He got here on the basis of what he believed and wanted to do, and he found himself here ... that's how it happened.'

Kigali announced Rusasebagina's detention on Aug 31, parading him before the press in handcuffs.

The country's criminal investigations agency, the Rwanda Investigation Bureau (RIB), has said Rusesabagina will face charges including terrorism, financing terrorism, arson, kidnap and murder.

The Rwandan government has accused Rusesabagina of having a hand in alleged attacks by National Liberation Front (FLN) rebels in southern Rwanda along the border with Burundi in 2018.

A former hotel manager during Rwanda's 1994 genocide, Rusesabagina used his job and his connections with the ethnic Hutu elite to protect Tutsis fleeing the

Rusesabagina left Rwanda shortly after the genocide and later acquired Belgian citizenship. He has

# Liaison office of central govt in HKSAR supports law enforcement against violation of national security law

**HONG KONG** 

THE Liaison Office of the Central People's Government in the Hong Kong Special Administrative Region (HKSAR) on Sunday voiced firm support for the HK-SAR government and the Hong Kong police in resolutely enforcing the law and safeguarding Hong Kong's social stability and rule of law.

#### Moscow plans mass coronavirus vaccination for end of year

**MOSCOW** 

MOSCOW plans to start mass vaccination against the coronavirus at the end of the year, the city's Mayor Sergei Sobyanin said in an interview with Channel One.

"A large-scale vaccination campaign is highly likely to take place at the end of the year or early next year," the mayor

He added that the post-registration trials of Russia's coronavirus vaccine, set to begin next week, would last two to six months. Mass production of the vaccine will begin in Decem-At first, people in risk groups will be vaccinated, including

medical workers, teachers, law enforcement officers, those employed in trade, and "probably journalists," Sobyanin specified. "We have to bear in mind that the danger is still there. As

we enter the fall and winter, there are going to be issues. However, I think it will be easier than last spring but we still need to brace ourselves for problems," the Moscow mayor noted.

Sobyanin said earlier during an online meeting with Russian President Vladimir Putin that he had been vaccinated against the coronavirus.

On August 11, Russia became the first country to register a coronavirus vaccine, which was named Sputnik V. The vaccine was developed by the Gamaleya Scientific Research Institute of Epidemiology and Microbiology and underwent clinical trials in June and July. Agencies

## China launches urgent use of COVID-19 vaccines for one month

ONE month has passed since China officially launched the urgent use of COVID-19 vaccines on July 22, while the vaccines were going through clinical trials, said a National Health Commission official on Saturday. Recipients who got their first dose since then revealed they had few adverse reactions and none reported a fever.

According to China's Law on Vaccine Management, when a particularly severe public health emergency occurs, vaccines in clinical trials can be used in a limited scope to protect medical and epidemic prevention personnel, border officers and other people working in stable city operations, said Zheng Zhongwei, director of the Development Center for Medical Science and Technology of the National Health Commission, in an interview with China

Central Television on Saturday night. Zheng now leads China's vaccine development work.

The Global Times has previously reported that employees of state-owned enterprises (SOEs) preparing to go abroad and frontline medics have been offered two choices of domestic inactivated vaccine candidates developed by Sinopharm for urgent use.

On Thursday and Friday, Sinopharm signed cooperation agreements on phase III clinical trials of inactivated vaccines with

Peru, Morocco and Argentina. Zheng noted that for the next step of preventing a possible outbreak this autumn and winter, vaccines' availability will be extended to people working in food markets, transport systems and services industries.

A document circulated online from a Chinese company in the tourism sector -TravelSky Technology - revealed that the company's key researchers, inspectors in airport terminals, and other employees with frequent business overseas can get

priority for free vaccinations. The number of people being vaccinated on an urgent basis may reach hundreds of thousands across China, considering that personnel in wider sectors are being offered free injections, said Tao Lina, a Shanghai-based immunology expert, on Sunday.

"But it's difficult to give an accurate fig-

ure since the Chinese military has begun mass vaccinations but has not released details," Tao said.

The inactivated vaccine is very likely to be approved for marketing by the end of the year though the timeline will be mainly dependent on the progress of late-stage clinical trials overseas, vaccine producer Sinopharm said on Sunday.

Wu, an employee of a state-owned company handling overseas construction projects along the Belt and Road Initiative (BRI) in Asian and African countries, told the Global Times on Sunday that all staff in her company have been offered inactivated vaccine injections on a voluntary

Wu, who took the vaccine on August 7 along with many of her colleagues for free injections, said she had not had any obvious adverse reactions, similar to everyone else in her group.

"My colleagues and I felt only a little dizzy on the afternoon of the vaccination, but we got over it pretty quickly. There was no local redness, swelling or pain, and we did not hear of anyone reporting a fever," said Wu, who will take her second dose on day 28 after the first shot.

"People seem to be relaxed over the vaccination as most of us feel confident in do-

mestically developed vaccines," she said.. At least 10 percent of the employees, mainly those in charge of projects over-

seas, have been vaccinated in groups since they were notified on July 30. The vaccination process is ongoing, Wu said.

Some employees who were overseas during the epidemic have also been vaccinated by Chinese medical teams that went abroad, Wu said.

Vaccinations are not given to those with severe allergies, those who tested positive for novel coronavirus nucleic acid or antibodies, or for pregnant women, according to the notification.

One of Sinopharm's inactivated COV-ID-19 vaccines on August 13 was revealed to have had a low rate of adverse reactions for patients in phase I and II clinical trials, while also demonstrating immunogenicity results.

As the cooperation expands, more and more bulbs are being lighted in African families

At the bank of the winding Tana River in Kenya's North Eastern Province, a gigantic "blue sheet" is embedded on the golden savanna. The sheet, consisting of over 200,000 photovoltaic panels, covers an area of 85 hectares. It is by far the largest photovoltaic power project in Kenya, and even in East Africa. The 50 MW Garissa Solar Power Plant has largely reduced the local price of clean energy - the electricity is purchased by Kenya's power department at 12 Kenyan shillings (\$0.12) per kilowatt hours, which is 40 percent lower than the price of diesel power generation.

The project was raised by Kenya's Ministry of Energy and financed by the Export-Import Bank of China. A consortium was established by China Jiangxi International Economic and Technical Cooperation Co., Ltd. and JinkoSolar, one of the largest and most innovative solar module manufacturers in the world, to take charge for design, purchase, construction, installation and training. The project was completed and put into operation at the end of the last year.

Mumin Gedi, Chairman of Rahma village near the project witnessed the huge changes brought by the power

According to him, there were only a few diesel generators in the village that lighted several shops before the photovoltaic power plant was built, and all activities had to come to an end when the sun sank. Most of the villagers chose to work outside due to the dull lifestyle, he said.

He told People's Daily that the construction of the photovoltaic power plant not only created jobs for local people, but also taught them skills. The plant's construction and operation brought vitality to the village and lighted up the night.

A merchant there noted that the cheap electricity and night-time economy made him wealthy. "The stable power supply realized dreams of many villagers," he said.

Peter Mbugua, CEO of Rural Electrification and Renewable Energy Corporation of Kenya, introduced that the power plant generates nearly 88 million kilowatt hours of electricity on an annual basis, which is able to satisfy the demand of around 350,000 residents. benefitting half of the population in Garissa. capital of North Eastern Province.

Half of Kenya's electricity is generated hydraulically, so the power supply capability of the country is severely impacted in winter. Photovoltaic power generation is a great solution to the problem.

Plant has received high recognition from Kenyan President Uhuru Muigai Kenyatta, who said the stable power supply will greatly drive local economy.

#### Lavrov assures relations with Turkey will not affect Russia-Cyprus dialogue

#### MOSCOW

THE development of Russian-Turkish cooperation will in no way affect the dialogue between Moscow and Nicosia, Russian Foreign Minister Sergey Lavrov said in an interview with the Cypriot newspaper Phileleftheros.

"I would like to reassure our Cypriot friends that the deepening of Russian-Turkish cooperation and the need to interact with Ankara on regional issues in no way affect and will not affect our dialogue with Nicosia," he stressed.

According to Russia's top diplomat, Moscow is concerned about regular



crises in the Eastern Mediterranean. "We consider any actions that are fraught with a further increase in the potential for conflict to be unacceptable," he stressed.

"We have repeatedly urged the leaderships of the countries in the region to show political foresight, resolve disputes exclusively by peaceful means and within the legal framework. It is better to resolve contradictions at the negotiating table rather than aggravate them with public rhetorical duels."

At the same time, Lavrov is certain that both Nicosia and Ankara have the political will "to prevent further destabilization of the situation in the region."

As protests rock US cities on holiday weekend, Jacob Blake speaks out

#### WASHINGTON

JACOB Blake, the Black man who was shot in the back by a white police officer in Wisconsin last month, spoke out for the first time from his hospital bed as dueling demonstrations over racial justice and policing continued to roil a handful of U.S.

In a video posted on Twitter, Blake (pictured), dressed in a green hospital gown, described being in constant pain after the shooting that left him paralyzed from the waist

"I got staples in my back, staples in my damn stomach," he said in the video posted by his attorney, Ben Crump, late on Saturday. "It hurts to breathe, it hurts to sleep, it hurts to move from side to side, it hurts to

The Aug. 23 shooting of Blake, 29, reignited protests over racism and police brutality that swept the United States after another Black man, George Floyd, died in May when a Minneapolis police officer knelt on his neck for nearly nine minutes.

The demonstrations have coincided with widespread upheaval over the social and economic consequences of the coronavirus pandemic, which has killed nearly 190,000 people in the United States, the highest death toll in the world.

The protests have also moved to the forefront of the presidential election campaign, with President Donald Trump now focused on a platform of law and order in his effort to be re-elected on Nov. 3.

At the start of the three-day Labor Day weekend, police in Rochester, New York, used tear gas to disperse some 2,000 protesters in the fourth night of unrest over the death of Daniel Prude, a Black man who died after an encounter with police in March.

Nine people were arrested and three police officers were treated at local hospitals for injuries sustained during the clashes, the Rochester police department said on Sunday.

Mayor Lovely Warren announced that Rochester was moving its family crisis intervention team and its funding out of the police department and into the Department of Youth and Recreation Services in response to the demands for change

"I am committed to addressing these challenges in ensuring that change truly comes," Warren told a news conference. She said she was glad that New York Attorney General Letitia James had moved to form a grand jury to investigate Prude's

# Brexit back in crisis as UK threatens to override pact

#### LONDON

BREXIT trade talks plunged into fresh crisis yesterday after Britain warned the European Union that it could undercut the divorce deal it signed unless the bloc agrees to a free trade deal by Oct 15.

In one of the most startling turns of the four-year Brexit saga, Britain is reportedly planning new legislation to override parts of January's Brexit Withdrawal Agreement, potentially jeopardising the treaty and creating frictions in Northern Ireland.

Sections of the internal market bill, due to be published on Wednesday, are expected to "eliminate the legal force of parts of the withdrawal agreement" in areas including state aid and Northern Ireland customs, the Financial Times said, citing three people familiar with the plans.

EU diplomats were aghast, cautioning that such a step would tarnish Britain's global prestige and heighten chances of a tumultuous EU exit on Dec 31.

Sterling fell around half a percent against the dollar and euro on Monday. Britain has set a deadline of Oct 15 to strike a deal.

"If we can't agree by then, then I do not see that there will be a free trade agreement between us, and we should both accept that and move on," Prime Minister Boris Johnson was to say on Monday, according to his office. Britain left the EU on Jan 31 but talks aimed at clinching a new trade deal before the end of a statusquo transition arrangement in December have so far snagged on state aid rules and fishing.

Without a deal nearly US\$1 trillion in trade between Britain and the EU could be thrown into uncertainty with rules over everything from car parts and medicines to fruit and data.

#### 'Desperate' strategy?

Some Brexit-supporting members of the ruling Conservatives argue that Britain should denounce the

Withdrawal Agreement because, they say, it poses constitutional dangers to Britain even if the two sides secure a future partnership deal.

They refer to article 184 of the agreement binding both sides to using "their best endeavours, in good faith and in full respect of their respective legal orders" to try to secure a future relationship agreement, and argue the EU has not done so.

The reported plan to undermine the Withdrawal Agreement - disclosed on the eve of new talks in London - was condemned by parties on both sides of the Irish border and elicited surprise in Brussels.

"If the UK chose not to respect its international obligations, it would undermine its international standing," said one EU diplomat. "Who would want to agree trade deals with a country that doesn't implement international treaties? It would be a desperate and ultimately self-defeating strategy."

Leaders of Northern Ireland's Sinn Fein and SDLP parties, the Britishruled region's two largest Irish nationalist groups, also criticised the government's plan, as reported by the newspaper.

Asked about the report in the Financial Times, British Environment Secretary George Eustice said there might be some minor "legal ambiguities" that needed to be tidied up over the Northern Irish protocol.

"We have a Withdrawal Agreement, and that includes Northern Ireland Protocol, and we are committed to implementing that," he told BBC radio.

Negotiations were ongoing to "iron out a few remaining technical details" on how the protocol would work and there might then be a need for legislation to provide legal certainty, he said "We are not moving the goal posts,"

he told Sky News.

EU chief negotiator Michel Barnier acknowledged anxiety but declined to comment on the FT report. "I remain worried ... the negotiations are difficult, because the British want the best of both worlds," Barnier told France Inter radio.

If no deal is agreed, Britain would have a trading relationship with the bloc like Australia's, which would be "a good outcome", Johnson was also expected to say yesterday.

#### Museveni says detained minister to be prosecuted over election violence

ment (NRM) party primaries for legislators held on Friday. The minister and his three body guards are facing charges of inciting violence, attempted murder by shooting, and malicious damage of property, according to police. The party primaries were characterized by violence in some parts of the country with losers

claiming that their vote was stolen. Museveni said all those who caused violence or engaged in some form of ille-

gality would be arrested and prosecuted. "Those who beat people... are all in jail or on the run. Minister Rukutana is in jail and will be prosecuted." Museveni said.

"They will be fully accountable with robust charges: assault, attempted murder, murder, etc.," the president added.

The primaries were held as different political parties in the country are preparing for next year's general elections.

## James, Davis help Lakers hold on to beat Rockets, tie series

LAKE BUENA VISTA, Fla.

THE Los Angeles Lakers were on a wild ride at Disney.

A huge lead in the first half had turned into a two-point deficit after three quarters. If they didn't turn things around, the No. 1 seeds would be down 2-0, though Anthony Davis said they weren't thinking about that.

"Our mindset was, 'How do we win this game?" he said.

Having LeBron James take over usually does the trick.

James had 28 points, 11 rebounds and nine assists, Davis added 34 points and 10 rebounds and the Lakers evened the Western Conference semifinals by beating the Houston Rockets 117-109 on Sunday night.

Markieff Morris scored 16 points for the Lakers. They opened a 21-point lead in the first half, gave up 41 points in the third quarter to fall behind, and then regrouped behind some high-flying plays by James to pull away again.

"We're at our best when he's in attack mode," Lakers coach Frank Vogel said.

James took only 15 shots in Game 1 and was scoreless in the fourth quarter of the Lakers' 112-97 loss, saying afterward that the Lakers needed to experience a game to understand how fast the small-ball Rockets play.

"I think we adjusted from Game 1 to Game 2," James said.

And when the Rockets adjusted from the first half to the second, James was dominant on both ends in the final period. He had eight points in the quarter and a powerful blocked shot on Russell Westbrook that flew far out of bounds.

James Harden scored 27 points and Eric Gordon made six 3-pointers and added 24 for the Rockets, who made 22 3-pointers. P.J. Tucker had 18 points and Robert Covington 17, but Westbrook finished only 4 for 15 while scoring 10 points and grabbing 13 rebounds.

"They just came out and played harder than us, I feel like," Harden said. "In the second half, we woke up and took the lead. We've just got to have that intensity at the beginning of the game and we'll be all right." Game 3 is Tuesday night.

The Lakers also dropped their opener against Portland in the first round but won Game 2 comfortably on their way to four

straight victories. This one appeared it would be easy, then

appeared it might not come at all.

But James had a dunk to open the fourth and tie the game and another dunk on a lob during an 8-0 run that gave them the lead for good. They put it away later in the period with a 9-0 burst, featuring two baskets from Davis, to make it 113-101.

Morris sparked a big finish to the first quarter. He had a 3-pointer with 1:11 left, then connected again at 52 seconds and a third time with 31 seconds left, pushing the lead to 33-17. Rajon Rondo made one more at the buzzer to give the Lakers a 36-20 cushion.

"Middle of the first all the way to end of the first, they just hit us in the mouth," Houston coach Mike D'Antoni said. "We didn't play with enough intensity to match their fire. We adjusted in the second half in the sense that we played harder."

James scored six quick points in the second to make it 42-21. Houston had a good stretch to cut it to nine with just under 5 minutes remaining in the half, but the Lakers quickly ran off 10 straight to push the lead back to 61-42, and it was 67-51 at the break.



"He readily admits to lying routinely but expects people to believe him now so that he can make money from book sales," White House spokesman Brian Morgenstern said in a statement. "It's unfortunate that the media is exploiting this sad and desperate man to attack President Trump."

The Associated Press obtained an early copy of the book, which is scheduled to be released Tuesday.

# Djokovic out of US Open after hitting line judge with ball

**NEW YORK** 

NOVAK Djokovic was kicked out of the U.S. Open for accidentally big 3-pointer with 6.4 seconds left in overtime, hitting a line judge in the throat with by beating the Miami Heat 118-115 in overtime a tennis ball after dropping a game in his fourth-round match Sunday, a stunning end to his 29-match winning streak and bid for an 18th best team in the regular season – are still Grand Slam title.

As he walked to the Arthur Ashe Stadium sideline for a changeover, trailing Pablo Carreño Busta 6-5 in the first set, Djokovic - who Budenholzer said. "He's got a way about him. was seeded and ranked No. 1 and an overwhelming favorite for the championship - angrily smacked a ball behind him. The ball flew right at the line judge, who dropped to her knees at the back of the court and reached for her neck.

During a discussion of about 10 minutes near the net involving tournament referee Soeren Friemel, Grand Slam supervisor Andreas Egli and chair umpire Aurelie Tourte, Djokovic pleaded his case.

"His point was that he didn't hit the line umpire intentionally. He said, 'Yes, I was angry. I hit the ball. I hit the line umpire. The facts are very clear. But it wasn't my intent. I didn't do it on purpose.' So he said he shouldn't be defaulted for it," said Friemel, who made the decision to end the match. "And we all agree that he didn't do it on purpose, but the facts are still that he hit the line umpire and the line umpire was clearly hurt."

Friemel didn't see what happened, and said he was not allowed to check a video replay, but was given a rundown by Egli and Tourte. Friemel said that even if Djokovic didn't intend to hurt the line judge, she was hurt, and that was enough to merit the ruling.

Eventually, Djokovic walked over to shake hands with Carreño Busta. Tourte then announced that Djokovic was defaulted, the tennis equivalent of an ejection.

"I was a little bit in shock, no?" Carreño Busta said later at a news conference done via video conference because of socialdistancing rules at the U.S. Open, the first Grand Slam tournament staged right ankle with 10:18 left in the second quarter, amid the coronavirus pandemic.

Asked whether he thought Djokovic should have been allowed to continue to play, Carreño Busta shrugged and replied: "Well, the rules are the rules. ... The referee and the supervisor (did) the right thing, but it's not easy to do it."

Indeed, the U.S. Tennis Association issued a statement saying that Friemel defaulted Djokovic "in accordance with the Grand Slam rulebook, following his actions of intentionally hitting a ball dangerously or recklessly within the court or hitting a ball with negligent disregard of the consequences."

The USTA went on to say Djokovic forfeits the ranking points and \$250,000 in prize money he earned in the tournament -"in addition to any or all fines levied with respect to the offending incident."

"Novak was angry. He hit the ball recklessly, angrily back. And taking everything into consideration, there was no discretion involved," Friemel said. "Defaulting a player at a Grand Slam is a very important, very tough decision. And for that reason, it

doesn't matter if it's on Ashe, if it's No. 1, or the ball, and there was concern any other player on any other court, you need to get it right."

This was the latest example of Djokovic finding himself at the center of the tennis world for a reason other than his best-in-thegame returns, can't-miss groundstrokes and body-contorting defensive prowess. Djokovictested positive for the coronavirus

as did his wife, one of his coaches and other players - after participating in a series of exhibition matches with zero social distancing he organized in Serbia and

Croatia in Iune. Then, on the eve of the U.S. Open, he helped establish a new association he says will represent men's tennis players.

And, of course, there's been his dominance

on the court. Djokovic began the day 26-0 this season and with an unbeaten run that extended to his last three matches of 2019. He had won five of the past seven Grand Slam tournaments to raise his total to 17, closing in on rivals Roger Federer, who has a men'srecord 20, and Rafael Nadal, who has 19.

With reigning U.S. Open champion Nadal, who cited concerns about traveling amid the pandemic, and Federer, sidelined after two knee operations, not in the field, the 33-yearold from Serbia was expected to claim a fourth trophy in New York and gain on them.

But it all came apart so suddenly Sunday. Djokovic wasn't looking in the line judge's direction when his racket made contact with

on his face as soon as he realized what had happened. Players who hit a ball out of anger and make contact with an on-court official have been disqualified in the past.

In 2017, Denis Shapovalov - the 21-year-old Canadian who is Carreño Busta's next opponent – was defaulted from a Davis Cup match against Britain when he accidentally hit the chair umpire in the face with a ball. At Wimbledon in 1995, Tim Henman hit a ball into the head of a ball girl and was defaulted from a doubles match.

"I've been through that myself. Honestly, I feel awful for him. I feel terrible for everybody. Nobody wants to be in this situation," Shapovalov said after beating No. 7 David Goffin 6-7 (0), 6-3, 6-4, 6-3 Sunday night. "Just a fluke. It's accidents like this that happen. Same thing with me." No. 5 seed Alexander Zverev, who will face No. 27 Borna Coric in the other quarterfinal on that side of the draw, called Djokovic "unlucky."

#### Fati arrives on international stage as Spain take control

ANSU Fati announced his arrival in international football on Sunday after becoming the youngest goalscorer in the history of the Spanish national team in a 4-0 thumping of Ukraine that put them top their UEFA Nations League group.

Barcelona forward Fati put Spain three goals ahead after just 31 minutes of the League A, Group 4 clash at the empty Alfredo di Stefano Stadium in Madrid with a fine individual strike that came amid a scintillating debut start for his adopted

Aged 17 years and 311 days, Fati, who was born in Guinea-Bissau and obtained Spanish nationality a year ago after moving to Spain when he was seven, beat the previous record held by Juan Errazquin, who scored three goals aged 18 against Switzerland in 1925.

"As soon as I was showered and changed I called my family - they are the people who have helped me reach this day and who always help me overcome challenges," Fati said after the match.

"I'll ask all the guys to sign this Spain shirt and it'll go up on the wall in a special place in my house."

Having already won the penalty that captain Sergio Ramos converted just two minutes after kick-off, he could have scored just minutes before finding the net when his close-range bicycle kick was unwittingly cleared just as it looked to be heading in.

Fati's strike -- a super curling shot after fine footwork on the edge of area -- came just three minutes after Ramos had put Spain two up with a beautiful looping header from Dani Olmo's cross. Substitute Ferran Torres completed the rout five minutes from the end.

The easy win leaves Spain top of Group 4 on four points, one ahead of Sunday's opponents but more importantly two in front of Germany who were held to a second consecutive 1-1 draw, this time with Switzerland.

They deservedly equalised when Borussia Moenchengladbach striker Breel Embolo, one of six in the Swiss team who play for German clubs, picked out Widmer who beat Bernd Leno on 58 minutes.

Germany had Leno to thank they earned a point, with the Arsenal man making a string of good saves, in particular from a well-struck freekick from his Gunners teammate Granit Xhaka five minutes before the end.

Earlier Russia carried on their strong start in League B with a 3-2 win over Hungary in Budapest that would have been less tense had they not switched off when three goals

Russian coach Stanislav Cherchesov blasted as "unacceptable" his team letting the hosts back from the dead, with a deft chip from Freiburg attacker Roland Sallai and Nemanja Nikolic's powerful finish giving Hungary 20 minutes to try to complete what would have been a remarkable comeback

However the Russians held out to make it two wins from two and take top spot in Group 3, three points ahead of the Hungarians.

"Two games, two wins -- that's the main thing and besides, we've now got food for thought before the next games," said Cherchesov.

Wales also kept their perfect record in Group 4 following promising teen Neco Williams's last-gasp header which gave them a hard-fought 1-0 win over Bulgaria.

Williams' first goal in professional football at the age of 19 made it four successive wins in all competitions for Wales and leaves Ryan Giggs' side top of the group on six points.

They are three ahead of Finland who earned a 1-0 win over the Republic of Ireland in Dublin thanks to Fredrik Jensen's strike just seconds ised for the hosts just before the after coming on midway through

#### Wuhan fans in tears as they watch their first match since virus

BEIJING

FANS of Wuhan Zall, the Chinese Super League club from the epicentre of the coronavirus, on Sunday attended their first match since the pandemic - and burst into tears as their team fought back to draw 2-2.

About 300 Wuhan supporters made the 750-kilometre (450 miles) trip eastwards to Suzhou and saw their side score twice in three minutes in the second half against title contenders Beijing Guoan.

The CSL has been slowly opening up to a very limited number of spectators, having started the season behind closed doors in July, but they must pass a coronavirus test in the seven days leading up to the game.

Beforehand, Wuhan supporters held a banner outside the stadium thanking the rest of China for its support in the central city's battle against

the coronavirus. Once inside they refused to sit down and sang almost non-stop, even when down at half-time, before Brazilian Leo Baptistao and Jean Evrard Kouassi of the Ivory Coast struck to drag Zall back into the game.

"We have hearts of absolute sincerity and stay united through the wind and waves," the Zall fans sang, the chant reverberating around the mostly empty Suzhou arena, where they were spaced out by one metre (three feet) as part of epidemic prevention

But at the end, after witnessing their team rescue a point, all social distancing was forgotten. The Zall fans, bouncing on their feet, banging drums and with their arms flung over each other's shoulders, serenaded their side with cries of "Wuhan! Wuhan!"

The whole squad and coaching staff went over to that corner of the stadium and applauded.

"When the two foreign players scored and we equalised, we couldn't help but burst into tears in the stands," said Gao Yajun, who had left Wuhan for the first time since the coronavirus their team looked doomed at 0-2 emerged there late last year.

# Meet Liverpool's secret weapon: throw-in coach Thomas Grønnemark

WHEN Liverpool hoisted the Premier League trophy into the firework-lit night sky back in late June, one of their staff was watching on from Denmark. Thomas Grønnemark, their throw-in coach, was drinking from his Liverpool mug -- a souvenir he collects from the different clubs he's worked with -- and felt immense personal pride.

Jurgen Klopp was derided when he brought in Grønnemark back in 2018. The doubters said a throw-in is a basic part of football -- look for the man, throw it to them. Why invest in a coach? But Klopp knew different, and Grønnemark had, before Klopp called, spent the previous 14 years convinced football was getting it wrong on their lax attitude to this aspect of the game.

Grønnemark has silenced the doubters -- his results speak for themselves. Liverpool scored 14 of their 85 Premier League goals from throw-in situations in their title-winning 2019-20 campaign. His services are so in demand, he can now afford to turn down some approaches if his philosophy doesn't fit with the club's needs. But he wants to take his message to the world. "My biggest dream is to change football," Grønnemark tells ESPN. "So instead of throw-ins being a thing that has to be done, it's developed instead into something totally fantastic and entertaining for fans."

When the founding members of the Football Association met in 1863 to draw up the original rules of football at the Freemasons' Arms in London, throw-ins were only granted a cursory nod -- whichever player got to the ball first could chuck it back in. It was 10 years and 11 revisions later that we started to see some semblance of modern-day throw-ins, except these had to be launched back in at 90 degrees to the touchline, and finally in 1877 they agreed on a format that is familiar today. In 75 words they summed up this aspect of the game as one of 13 rules regarding how the sport should be played.

Over a century later and Grønnemark is still shocked at how little attention some of the world's biggest clubs give this aspect of the game. "Throw-ins are gigantic in football," Grønnemark says. "We've been playing football for 140 years and all the time it's been a case of hurling it down

"The frightening thing is you still see the big clubs in the Premier League, the Bundesliga and Champions League, do that -- who haven't got throw-in coaches.

"That's the worst thing you can do in football." Grønnemark is talking via Zoom from his home in Denmark; COVID-19 curtailed a number of his coaching plans but he still worked remotely, guiding his clients through his three-point throwin plan. "My philosophy is called the long, the fast, the clever throw-ins," he says. As we talk he is clasping a TinTin mug (the two share a remarkable resemblance). "I don't want to show any favouritism," he laughs. He has worked with Liverpool since 2018 while a quick scan of his coaching resume, or his globe-trotting Twitter account, shows he's also spent time with Ajax, RB Leipzig, Atlanta United, KAA Gent and FC Midtjylland.

His own coaching journey started back in 2004, when he was midway through a four-year spell as a member of the Danish bobsled team. Up to this point, he'd already tried to become a professional footballer -- playing in the same Denmark Under-19 team as Thomas Gravesen -- but failed to make the grade and thus turned to athletics as a sprinter and later bobsledder. He also honed his throw-in technique and secured the Guinness World Record in 2010 for the longest flip throwin (51.33 metres). He remembers going to the library keen to learn more about throw-ins within football but couldn't find anything on the topic, so over six months in 2004 he developed his technique, filmed tutorials and created his own three-point course.

"Normally there are between 40 and 60 throwins in a match," he says. "Most players or teams are losing the ball in more than 50% of the occasions when they have a throw-in under pressure, where the players are marked. I tell the players, if you had the same percentage with your feet, you'd only play Sunday league football!"

As he searched for his football break, he looked to local amateur teams but plucked up the courage to approach Danish Super League side Viborg, and having improved their throw-ins, the season after he was approached by FC Midtjylland, where he worked for the next six years.

When Andreas Poulsen moved from Midtjylland to Borussia Monchengladbach in the summer of 2018, Grønnemark tweeted a congratulatory message wishing him well. He'd worked closely with the Danish left-back and had improved his throwing from 24.25 metres to 37.9 metres. The tweet caught the attention of a fanzine, which did a feature on Grønnemark, and from there German newspaper Bild contacted him to do the same. As chance had it, Klopp read that article and rang Grønnemark inviting him to come to Liverpool's Melwood training ground and tell the staff everything he knows about throw-ins.

Klopp was frustrated about Liverpool's throwin record; the previous 2017-18 season, Liverpool were 18th out of the 20 Premier League teams in

retaining a throw-in under pressure.

Grønnemark remembers his first meeting with the players. "I said to them, 'I am not going to turn you into Stoke Mark II,' that meant we're not going to start taking a lot of long throw-ins, that's not how I work. Then Jurgen Klopp said 'we had a fantastic season in '17-18 but we were really bad at the throw-ins --I've invited Thomas to help us and I'm 100 percent sure we can improve."

A season later, Liverpool improved their throw-in retention under pressure percentage from 45.4% to 68.4% and had risen from 18th in these standings to first in the Premier League -- second in Europe behind Grønnemark's other side FC Midtjylland. Grønnemark is reluctant to pick out goals or moves he's proud of -- he doesn't want to give away any secrets of the trade. But from last season there are two which have been wellanalysed: Roberto Firmino's goal against Wolves on Jan. 23 and Firmino's opener against Tottenham on Jan. 11.

"When I met him, it was 100% clear I wanted to employ him," Klopp said of Grønnemark back in the 2018-19 season. "You cannot have enough specialists around you. I must always be the guy who makes the decisions on when we use them, but you cannot have enough.

"Already [he has made a difference], it's good, the boys like it. Somebody who knows what he is talking about, it always helps when you want to improve something."

Grønnemark says it took courage from Klopp to think outside the box and seek out his services. "There were a lot of sceptical people. When I went to Liverpool many fans said, 'Oh, that's totally crazy, weird stuff'. You have to be brave to take me in like me. Jurgen Klopp is really open-minded, he looked at the club's weaknesses and could've decided to sort this within themselves, but he decided to bring me in.

"It shows how much of a leader he is [and] you have to have patience, and be able to listen. He's a fantastic listener, a fantastic talker and a fantastic guy. I remember that first meeting in Melwood -- I remember how much he listens. He could have told me, 'OK we've done these things before, can you polish it?' No, instead he asked me, 'Tell me everything you know.' That's an innovator -- being innovative is not only having great ideas and telling them to people, but also to have patience

That's why I think a lot of people can learn from him in their daily life."

He says the methods he uses are 90-95% focused on "mechanical, technical" work, rather than conditioning. "The [Liverpool] players bought in from the start," Grønnemark says. "If you'd speak to players and ask if they'd rather play with their hands or feet, they'll all say feet -- that's natural. But once you give them the 'why' at the start of the training as a motivator. Then you bring in competitions, focus on movement and space."

The three-point plan he derived is easy to understand but is packed with intricacies. The long throw-in part addresses the reach a player can achieve. With Andrew Robertson, the Liverpool left-back, Grønnemark improved his throw-in distance from 19 metres to 27 players to determine when to go quick, or wait. "Sometimes it's really stupid to throw fast if you're throwing the ball a counter-attack. For the 'clever throwin' part: "That's how we can create space all around the pitch with specific movements.

"For me it's much more dangerous than, say, an American football playbook, because if you read that playbook, you'll know what will happen.

"But no, sometimes I see two or three players doing things to create a certain kind of space -- that's really intelligent. For people who don't have that knowledge, it looks like they're moving, but in fact, they're looking at space, timing and angles, things like that."

Grønnemark knows there are people who think his job is a luxury or, at worst, redundant. "Criticism is OK for me. But if people are making fun, but don't have any knowledge, I don't care what they say. But if people are curious, but have no knowledge and ask how it works, I'm really happy to explain to them. The more knowledge we have, the more exciting things we can talk about."

He also gives short shrift to the theory throw-ins are of minimal importance, merely a potential area of football's 'marginal gains' (a theory deriving from cycling where teams would look to shave off nanoseconds by adapting

yourself and open up to new thoughts. aerodynamics or even minimalizing body hair). "If you're looking at the time spent on throw-ins or related situations, that's 15 to 20 minutes of a game," Grønnemark says. "If you're calling that marginal -- I would say you have misunderstood marginal.'


Grønnemark hopes his work will cause sceptics to think twice about questioning the importance of throwins in football. "I think football fans will look at throws like they do in basketball -- where they're creating space for each other -- as fans there appreciate space grading because they know what will or perhaps will happen. When the fans have that knowledge in football, they'll find it more exciting."

Once travel becomes easier, it will be back to travelling the world, passing on his knowledge. He has signed up with Liverpool for another season and -- "that's an improvement in his throw- is looking forward to getting back to in area of 500 square metres". With the working with Klopp. As one of the few fast throw-in aspect, that works with lucky enough to see the inner workings at Melwood, he feels their togetherness is one reason why they have managed to enjoy this recent success. "They're into pressure." On other occasions, a really good at helping each other," quick throw-in can be the catalyst for Grønnemark says. "The players like pressing until the 97th minute [of a match] and you can see that with throwins. It's not about, 'I' have to get the ball, it's about 'we' have to get the ball. I think everybody working together is a big part of their success at Liverpool."

If you'd told Grønnemark back in 2004 when he was starting on this journey he'd have helped Liverpool to a Premier League title, he'd have smiled, but not been surprised. "I had my knowledge, I had my data, I have my proof. It was a question of when the breakthrough would come. I was always 100 percent sure I would coach in a Premier League club: it's always been my biggest dream."

He takes huge pride at being at the forefront of the growing awareness of throw-ins and his own role in Liverpool's success. But while he has a mug from his trips to Liverpool -- sometimes as many as two or three sessions a week -- he's yet to receive a medal.

"I don't know if I'm getting one," Grønnemark says. "But, to be honest, it's not important. The most important thing for me is that I've been making a difference for the team, for the club. And that's the biggest medal for me. I'd be happy to get one, but you know, it's the other things that mean more to me."

#### Western Australia quarantine snub forces India tour to the east

A cold shoulder from the Western Australia (WA) state government has clarified the options for Australia's international season, with India's tour set to begin in Adelaide and Brisbane.

Adelaide Oval stands prepared to host back-to-back Tests- a day-night game and then a day match over the holiday period - should the MCG remain unsuitable for the Boxing Day showpiece amid Victoria's coronavirus lockdown.

The need for flexibility has also seen Cricket Australia (CA) lean heavily upon state associations in their planning, with matches to be primarily staged by staff already located in each state - a major departure from recent seasons in which CA has flown a massive travelling roadshow of events-team members around the country for international games.

This model was introduced under the financial model that had CA taking on direct responsibility for managing international fixtures and passing on fixed annual distributions to the states.

Initial plans devised by CA and the WACA had Australian and Indian players entering the country via Perth and preparing for the season via a relaxed quarantine that would have allowed them to train.

However, the final decision by the WA state government, and its Premier Mark McGowan, to insist on a strict hotel quarantine for any international visitors, has forced the governing body to look towards Brisbane and Adelaide for the start of India's tour, likely to commence with a suite of limited-overs matches before the four-Test series begins.

"We acknowledge the WA government has a firm position on quarantine and border arrangements," a CA spokesperson said. "The Australian men's team will not be quarantining in Perth upon their return from the UK." Where this leaves the scheduled Test between Australia and Afghanistan in Perth is unclear, although WA's frustration with not being allotted one of the India Tests in the original schedule was plain. CA is still working assiduously to try to get the Afghanistan match played, and it would be of most value as a red-ball match for the home Test side led by Tim Paine immediately before the series against India.

"We didn't think it was acceptable to have the team return from a high-risk overseas location and then take part in normal training activities outside of quarantine, before flying out to another state to play games," McGowan said. "There were just too many risks in the model put forward by Cricket Australia. We need to remain vigilant and do the right thing by all Western Australians and not take unnecessary chances."

It is plausible that Brisbane's Test against India under the original schedule would instead become a cluster of white-ball matches, with three ODIs and three T20Is - all slated to be played by Virat Kohli's team. That may then give way to the Afghanistan Test match, before the Australian squad travels to Adelaide for the start of the India Test series in mid-December.

While Melbourne is likely to be kept in theoretical calculations as host of the traditional Boxing Day Test for as long as possible, the realities of crowds and Co-

He said his target is to promote the country across its boarder and become notable player.


