

# Census attains 17.1pc on first day, eclipsing official target

AT Least 17.13 per cent of households countrywide were enumerated in the first day of the Population and Housing Census (PHC), surpassing the 15 per cent target.

Anna Makinda, the 2022 census commissar, told reporters in Dar es Salaam yesterday that with this first day achievement, it is clear that the exercise will be completed on time.

The results were collected from the monitoring dashboard late Tuesday, at the end of the first day of the seven-day exercise, she said, noting that there is still ample time for all households to be

To ensure that the exercise rolls on time, census clerks will distribute forms to households and inform them of when they come for collecting filled forms, she said, noting that the head of a household must be interviewed to get detailed

Local street leaders need to escort the

census clerks to ease accessing houses, she said, appealing to large numbers of reportedly disgruntled clerks to remain calm as the census secretariat is working overnight to ensure their allowances are delivered on time.

Emiliani Karugendo, the director of statistical operations at the National Bureau of Statistics (NBS) admitted that there were challenges that led to delaying delivery of census clerks' allowances.

Those allowances will be paid as agreed, he emphasized, asking them to pursue their work diligently, noting that the challenges related to allowances tied to demarcations between streets, but since then "everything is under control."

Seif Kuchengo, the census coordinator in the capital, said that a total of 2.35m households with 10.26m inhabitants had been counted on the first day of the census, representing 15.45percent of anticipated total target.

The national database shows 2,345,964 households counted by late Tuesday with

## Dar set for removals of banned packaging bags

AUTHORITIES in Dar es Salaam have launched a campaign to remove illegal plastic bags finding their way back to the

Regional Commissioner Amos Makala announced the campaign at a meeting



with officials of district councils, major city markets and the National Environment Council Management (NEMC)

He directed NEMC to prepare a team for the campaign, also holding accountable those found to be producing and supplying banned plastic bags, asserting that he had checked the matter with Vice President Dr Phillip Mpango and obtained green light for the campaign.

This campaign is likely to be taken up in other regions, he asserted, with NEMC officials also expected to prepare teams to tackle the presence of banned plastic bags all over the country.

The government banned single use plastic bags for routine carrying of foodstuffs and shopping in June 2019 but since then alternative bags have appeared on the

sending applications will have to redo the exercise, after 75,163 candidates were enrolled in various universities.

This year's first window had 106,295 while 92,809 applicants turned up last year for the first window, while a total of 172,168 study opportunities are available this year, he stated, noting that all eligible applicants are welcomed to use the second window to pick relevant courses or universities.

There is also an increase in university programmes from 724 last year to 757 this academic year, explained from ongoing technological changes and job market needs, he said.

For those who sent applications to different universities and obtained enrolment in more than one university need to ensure that they confirm enrolment in one university before September 7, he elaborated.

Applicants and the general public "must avoid being misled by some dishonest people who claim to provide services on how to join higher education institutions, he stated.

"We have three groups of people who are eligible to apply for higher studies and these are form six leavers, ordinary diploma holders and those who underwent foundation courses at the Open University of Tanzania (OUT). All information on how to apply and the minimum requirements are found on the TCU website and those of respective varsities," he emphasised.

Those with secondary school certificates obtained in foreign countries should submit them to the National Examinations Council of Tanzania (NECTA) or the National Council for Technical and Vocational Education and Training (NACTEVET) for certification and eligibility before applying, he added.

market, some not meeting standards for recyclable bags, those which aren't

Apart from evading tax, illegal plastic bags cause unfair competition in the market as alternative plastic bags users incur purchase costs dissimilar to illegal plastic bag dispensers.

Markets and shop operators in the city need to collaborate with government officials supervising the exercise, helping to conserve the environment for current and future generations, he said.

Dr Samuel Gwamaka, the NEMC director general, said the council conducted a public education campaign on plastic bags in packaging

during the run up to their formal ban in June 2019. Last year some businessmen started to produce the bags again, carting them into the market, he said.

NEMC along with the Tanzania Bureau of Standards (TBS) and the Tanzania Revenue Authority (TRA) made far reaching awareness campaigns, moved to control the importation of plastic bags but some consignments are infiltrated through informal routes, he explained.

The main challenge was that some neighboring countries still use plastic bags in packaging and some local business people take advantage of this discrepancy to make them cheaply available for shoppers and in markets,

# TRA vows to hunt bogus accountants

TANZANIA Revenue Authority (TRA) in Kahama Tax Region says it will hunt all sham accountants who have been causing losses to traders by raising amounts of taxes when preparing their annual tax returns.

This was revealed Monday this week by Acting TRA Manager for the Kahama tax region, Honest Mushi in a training seminar on new tax rates of the 2022/23 Finance Act, saying every businessman has the responsibility correct statistics when preparing tax

accountancy firms opening offices in the district managed by unqualified accountants while qualified ones remain in their offices in Dar es Salaam.

Mushi added that the person required to prepare tax returns is the trader himself in collaboration with the accountant he hired, but even traders themselves often provide incorrect data to the accountants especially in regard to lower income from sales of goods than actual ones.

He said there has been the practice it will hunt down all unqualified accountants not registered with TRA as tax consultants to clamp down on the practice.

"We register tax accountants, but often they do not do their work well, they raise the tax payable by their clients that spur many complaints, this issue has reached our office and will work on it for evidence," he added.

For his part, Kahama District Member of the Chamber of Commerce, Industry and Agriculture (CCIA), Frank Jerome said some traders who have had

In the circumstances, Mushi said their amount of tax payable increased thereby making many of them thinking about closing their businesses.

> He further said after calculations, one of the traders was told to pay 25m/- as tax while the volume of his business was not proportionate to the amount.

He said members at the conference was the need to work on them, and sure that governments of all countries, including Tanzania implement reporters, Tanzania their responsibilities accordingly by adequately investing in education.

Wayoga added that the conference has found out that the effects of COVID-19 still exist in various areas of the African continent, hence there

gave an example of Kenya that closed its schools for almost a year while Tanzania did so for three months.

"Another issue we discussed in the conference is the need for investing in elementary education, which for a long time was ignored by African countries in one way or another," Wayoga added.

The international conference on quality education was attended by over 300 participants from 11 countries who discussed issues of education in the African continent.

# Pesticides dealers lack correct information about application of crop inputs - officials

A CROSS section of sellers of pesticides in the southern highlands regions have claimed to lack training in regards to the correct use of the farm inputs resulting in farmers not getting correct information for their application.

This was revealed early this week by sellers of pesticides shops in Mbeya, Katavi and Songwe regions during a special training seminar for the correct use of the farm inputs organised jointly by Tanzania Plant Health Regulatory Authority (TPHRA) and HELVETAS

The seminar involved 44 participants from the regions 12 of whom paid for the training cost and for 32 others the cost was met by HELVETAS Tanzania - a co-implementer of the AGRI-CONNECT programme that deals in improving the value chain for horticulture crops, coffee and tea.

Reading a statement to the seminar participants, Mataliwa Rubuye said as a result there has been an increase of the improper use of pesticides.

"The effects of this include destruction to the environment, livestock and fisheries products, hence we appeal for the enhancing of the pesticides control," Rubuye said.

TPHRA Head for the Southern Highlands Zone, Emmanuel Mausa said every year they have been providing the training to owners of shops selling pesticides to ensure the correct application of the farm inputs.

He said owners of these shops are supposed to educate farmers in order to reduce the effects from toxic chemicals found in the pesticides.

He added that apart from education to pesticides dealers, they have also

been making frequent inspections in the shops to make sure every staff in them are trained and has a certificate issued by TPHRA.

For his part, HELVETAS Tanzania Verification and Monitoring officer Shoma Nangale said they decided to sponsor the training through the project for the improvement of horticultural crops (KIBOWAVI).

He praised seminar participants for their decision to participate in order to get permits that would enable them to do the work legally without friction with government authorities.

Closing the five-day seminar Mbeya Regional Administrative Secretary (Economy and Production), Saidi Madito thanked the two institutions for the seminar, saying it will also help the government to attain its goals.

# Government gets rid of NTDs in sixty seven districts

THE government has successfully eradicated neglected tropical diseases (NTDs) in sixty seven districts out of seventy seven found with the diseases.

NTDs coordinator at the ministry of Health Ambakisye Mhiche said yesterday in a strategic meeting with stakeholders to ensure the diseases are eradicated by 2030.

He said the government was working hard to eliminate the diseases in according to him, are found in the northern, central part of the country and Kalambo district in the Rukwa "Our target is to ensure the diseases are eradicated completely in the country as per World health Organisations (WHO) and the Rwanda declaration," he said.

The Kigali Declaration on NTDs which aims to mobilize political will and secure commitments to achieve

the remaining seven districts that, the Sustainable Development Goal 3 (SDG3) target on NTDs and to deliver the targets set out in the World Health Organizations' Neglected Tropical Disease Roadmap (2021-2030).

> He called on the public to join the president's efforts to reach the government target of eradicating the diseases by 2030.

NTDs are a group of 20 diseases that was a high-level, political declaration include leprosy, elephantiasis, rabies, river blindness, and trachoma, and more than 1.7 billion people worldwide

- 35 percent of whom live in Africa - hardest hit by NTDs. Nearly half of the suffer from them. But although these country's population - more than 29 diseases debilitate, disfigure, and can kill, they receive far less attention than other diseases, in part because they primarily affect the world's poorest people.

On August 2, in 2021, Tanzania and Rwanda signed several bilateral agreements including in health and immigration during President Samia Suluhu Hassan's two-day visit to Kigali.

Tanzania is among the countries

The effects of NTDs are devastating, and they fall disproportionately on women and girls, because high-risk activities such as washing clothes in rivers are a typical part of their daily routine, making them more likely to fall ill.

When they do, they cannot attend

school, go to work, or take care of themselves or their families.

Tanzania's success in the fight against NTDs echoes a pattern of progress globally. 46 countries have eradicated at least one NTD so far, and 600 million people no longer require treatment for

The infection rates of diseases that have plagued humanity for centuries, such as leprosy, sleeping sickness, and Guinea worm disease, are at an all-time

## The 2022 Population and Housing Census



#### What is Population and Housing Census?

Population and Housing Census is a total count of the country's population, where demographic, social, economic and environmental information as well as information about housing conditions of the people who live in the country is gathered.

#### ■ Why do we conduct Population and Housing Census?

The government conducts census to collect information which will assist in planning, decision-making, monitoring and evaluation of development policies and programs. Indeed, the information collected is also used by private sector, development partners and social institutions in planning and implementation of their day-to-day activities.

#### Which information is collected during census?

The information collected includes demographic variables such as age, sex, marital status, educational attainment, disability status and housing condition as well as economic activities of household members. Other information includes ownership of identity documents such as National ID. Zanzibar Resident Identity Card, Passport, Driving License, Health Insurance Card and Machinga ID card.

### When will Census be held?

Census count begins on the night of 23rd August, 2022 and enumeration will continue for up to six days through 29th August, 2022. However, all information collected will be referred to the census night; that is 23rd August, 2022

## ■ Who will be enumerated during Census?

Everyone who will be within the geographical boundaries of the United Republic of Tanzania on the census night irrespective of his or her citizenship status.

## Is it important to take part in census?

Yes, because government and all other partners including the private sector need accurate information for effective planning and policy making. Census data assist government as well as private sector to establish the needs of different population groups in the society and be able to plan and address them accordingly.





#### How will census be conducted?

On the census day, enumerator will visit households with census questionnaire and conduct interview with head of household or any other person entrusted to represent him or her

#### How can I identify an Enumerator

Enumerator will visit your household accompanied with your local leader wearing special uniform and with identity card.

### Should I let the enumerator into my house?

Yes, as the interview is expected to take about thirty minutes depending on the size of the household, and the need to keep the information collected confidential, it is advised to let the enumerator into your house or somewhere within the compound where the anticipated privacy can be assured once you have done all necessary checks and satisfied that the person is

### What is my responsibility?

Everyone is responsible to provide correct and accurate information during the interview. Remember that providing correct and accurate information will result in producing quality census data.

## Am I legally bound to participate?

Section 351 of the Statistics Act obliges respondent to answer all questions put to him/her by the enumerator.

## Is my collected information safe and confidential?

## Students decry 'humiliation' in public transport

A CROSS-section of secondary school students in Dar es Salaam have complained of spending much of their learning time waiting for transport after some public transport operators deny them the service on grounds that they are not profitable.

In separate interviews, students said they use most of their precious learning time in the morning waiting for transport to school, the same situation when coming back home.

One of the students from Kiluvya Secondary School in Dar es Salaam Glory Munishi said it takes two to three hours from home to school every day due to transport challenges.

"In the morning it is very hard to go

early to school because most of the conductors reject us or they decide to take few students and to leave a huge move which affects their studies," she

Most commuter bus operators said they prefer taking a few students to balance their output which has been affected by rising cost of fuel.

Another student from Mbezi Secondary School Abdul Mohammed said the situation affects their learning as they arrive late for classes hence perform poorly.

Kelvin, also a student from Mbezi Secondary School said the bus operators deny them because they do not make profits as the students do not pay the same amount as adult passengers.

The students called for government intervention on the matter including coming up with a new strategy to number of students in bus stands, a ensure students get the required transport services to facilitate their

A student pays between 200/- on any route in Dar es Salaam against an adult fare of a minimum fare of 600/- to any

When asked about the tendency, a commuter bus conductor Thomas Peter said they deny carrying students because of the rising cost of life as the student fare takes time to accumulate and achieve the targets set by their

"So sometimes we decide to take a few students and leave others at-least to balance between making money and offering services.

## Poor hygienic sanitation threatens lives, businesses

PEDESTRIANS, bodaboda and Bajaj drivers along Soldering Road in Kinondoni District, Dar es Salaam have expressed their concerns over foul smelling stagnant water caused by poor drainage system, threatening their health and survival of businesses.

In separate interviews, they said the situation has become hard to tolerate and thus calling upon the government to intervene and address the matter.

Hussein Ndutu, a Bajaj driver said: "This challenge has been here for a very long time and the main source is some of the food vendors who have been pouring dirty water in the trenches where they remain stagnant for a long time and thus causing bad smell that bothers us a lot and threatens our

Another Bajaj driver Maulid Bakari said: "The government has to take measures on this immediately because we have been in this situation for a long time now, the drainage system is poor as it doesn't allow water to pass."

He however said that while waiting for the government to address the problem, dwellers and traders should come together and clean the areas while controlling improper pouring of waste water.

A shopkeeper near the area, Ibrahim Mnung'a said the problem affects his business as sometimes traders as well as customers feel unwell staying in the area due to bad smell. "The situation chases away customers because when they reach the area and come across with the situation, they decide not to come again, we appeal to the responsible authorities to see this and

extend their help, we want the water to flow in the drainage system and not remain stagnant," he added.

Getrude Humphrey, one of the customers said: "I normally use this way but the problem here is the bad smell from the trenches. I see some food vendors as the main source as they are not properly handling their wastes but throwing them in trenches." Sophina Hamis, one of the food

traders said they have no other alternative areas to pour their wastes and thus find themselves putting them in the ditches.

Mikocheni Industrial Area Street's assistant secretary, Arnold Richard confirmed the matter, saying it has been reported to the district level and the National Environment Management Council (NEMC) for action.

"The idea is to address the challenge in the said area and if possible legal action will be taken to those behind the matter," he said.

Richard urged food vendors in the area to abide by-laws governing their businesses, by making sure that the area is clean all the time.

## Makutupora lab equipped with new digital gadgets to bolster wine sector

INSTALLATION works for the highly technological wine manufacturing machines has commenced at the Tanzania Agricultural Research Institute (TARI) Makutupora Centre's laboratory in Dodoma region.

Procured from France, Italy and South Africa, the state-of-the-art wine bottling facilities are projected to enable the center-which is designated for research and promotion of grapesto strengthen its research capacity, wine production and training to the farmers and wine makers on how best to manufacture quality wine varieties.

Moreover, with the equipped lab, the Dodoma-based agro center (TARI Makutupora) will stand a better chance to bridge the existing gap in the country's wine making sector and thus, enabling the county to start producing advanced wine varieties that would penetrate and compete highly in the world market.

In an exclusive interview to this publication, the Centre's Director, Dr Cornel Massawe unveiled that the exercise for the installation of the modern apparatuses has reached at least a good pace.

capping machine and wine pump. Others, according to her, include the digital PH meter, digital refractometer and a special wine cooling unit.

"With the well-equipped lab, we will also be able to make effective monitoring of production of wine,

Meanwhile, Felista Mpore, the research officer at the department of Crop Innovation and Post-Harvest Management at TARI Makutupora Center, noted that installation of the digital equipment will help to push for fresh impetus in the country's wine sector. And she added: "Upon completion, we expect to use the laboratory to train the farmers and wine processors on professional stages in bottling the best wines."

She said the exercise will also incorporate installation of the modern walk -in solar drier to facilitate professional production of raisin (drying of grapes).

"Apart from generating wine varieties, we're planning to expand the use of grapes by producing other products, including raisins, jam as well as grape juice," she unveiled.

On the same vein, she added that the development will see grape farmers within the semi- arid region effectively trained on how best to produce grape bulk juice, but also, all vital processes involved in wine making, from for measuring wine quality, screw professional preservation of wine.



## We can't afford to lose rhino population battle

OACHING syndicates have protection. decimated upwards of 1,500 rhinos since 2017, on the basis of a recent report by the African Rhino Specialist Group (AfRSG) linked with the World Wildlife Fund for Nature (WWF). It has detailed information on rhino population trends, indicating that threats to African rhinos from transnational crime networks remain high, despite a relative decline in poaching during the COVID-19 lockdowns. What is evident is that law and order remains ineffective.

The report affirms that on a continental scale the threat of killing African rhinos for trading its horn has declined to a 2.3 per cent poaching rate on the total population annually from the peak in 2015 (5.3 per cent poaching rate). This has facilitated increase in overall numbers of the black rhino, cited at three per cent per annum to 6,200 at the last count within a wider tendency of decline at around 3.1 per cent per year to reach less than 16,000 in total by 2021 count. It is hard to stop the decline.

What many observers may just notice in passing is an affirmation that the declining white rhino populations are found in the large state-managed protected areas in South Africa in particular. The specialist group highlighted that rhino populations which are co-managed through partnerships between local people, the private sector and state agencies are performing better than those managed solely by state agencies. The private sector came in for particular praise in rhino numbers efforts.

The group underlines that private ownership of rhinos increased to 53.2 percent of the South African national white rhino population, thanks to the sector's sustained investment in their

It shows that endangered species are safer with private wildlife entities, in which case the case is made for joint ventures in that field, where range management issues are handled by agents of private investors. This aspect is rather clear but activists focus their attention on a different matter.

Noting the clear decline of rhino numbers by more than two thousand since the last survey in 2017, it proposes to table proposals on the issue at the next jamboree of the Convention on International Trade in Endangered Species of Wild Fauna and Flora (CITES) holding its 19th Conference of Parties (CoP19) in Panama later in November. The proposals will focus on "this recognition of the importance of the role of local communities in biodiversity conservation in Africa," which the report says it echoes the activists' Kigali Call to Action for People and Nature tied to the International Union for the Conservation of Nature (IUCN) chapter on Africa's Protected Areas. It isn't about enhancing joint ventures but the role of villagers.

What is surprising is that this tonality can only be meant to enhance the role of non-governmental organisations charged with building local capacities to protect animals by obtaining a chunk of the revenues. NGOs on the other hand obtain the bulk of conservation fieldwork financing which private firms could obtain from banks basically as revolving credit targeting conservation activities, where loaned companies pay for others to be loaned. That way the funds are sustainable in the long run and conservation succeeds, while the NGOs-villagers format is pegged on durable dependency and mixed results, as vast areas will remain under state bodies.

## Tanzania ought to comply with advice to prevent monkeypox

infectious viral disease can occur in humans and some other animals. Symptoms include fever, swollen lymph nodes, and a rash that forms blisters and then crusts over. The time from exposure to onset of symptoms ranges from five to twentyone days. The duration of symptoms is typically two to four weeks. There may be mild symptoms, and it may occur without any symptoms being known. The classic presentation of fever and muscle pains, followed by swollen glands, with lesions all at the same stage, has not been found to be common to all outbreaks. Cases may be severe, especially in children, pregnant women or people with suppressed immune systems.

The World Health Organisation (WHO) has said monkeypox infections continue to rise globally, with more than 35,000 cases across 92 countries and territories and 12 deaths.

WHO Director General, Dr Adhanom Ghebreyesus, disclosed this while speaking at a news conference from WHO headquarters in Geneva recently.

"Almost 7,500 cases were reported last week, a 20 per cent increase over the previous week, which was also 20 per cent more than the week before,"

According to him, the majority of cases are being reported from Europe and the Americas, and mostly among men who have sex with men.

Ghebreyesus said that the primary focus for all countries must be to ensure they are ready for monkeypox, and to stop transmission.

He said countries should focus on stopping monkeypox transmission by using effective public health tools, including enhanced disease surveillance, careful contact tracing, tailored risk communication and community engagement, and risk reduction measures.

Currently, global supplies of monkeypox vaccines are limited, as is data about their effectiveness, noting that WHO is in contact with manufacturers, and with countries and organisations willing to share vaccine

"We remain concerned that the inequitable access to vaccines we saw during the COVID-19 pandemic will be repeated, and that the poorest will continue to be left behind," he said.

Ghebreyesus reported that it is becoming harder to understand how the virus might be changing.

The number of sequences shared per week has fallen by 90 per cent since the beginning of the year, and the number of countries sharing sequences has also dropped by 75 per cent.

He warned that with colder weather approaching in the northern hemisphere, and people spending more time indoors, the risk for more intense transmissions will only increase.

"But none of us is helpless - please get vaccinated if you are not, and if you need a booster, get one," he advised.

In addition, he said measures such as wearing a mask and avoiding crowds, especially indoors should be embraced.

"There is a lot of talk about learning to live with this virus. But we cannot live with 15,000 deaths a week".

The WHO chief also highlighted the ongoing crisis in the Horn of Africa, where millions are facing starvation and disease due to drought, conflict, climate change and rising prices for food, fuel and fertiliser.

WHO has provided more than \$16 million from an emergency fund to meet the needs, but more support is

required. The agency is appealing for \$123.7 million which will be used to prevent and control outbreaks, treat malnutrition, and provide essential health services as well as medicines.



## The troubles of an unintended 'know-all'

T will sound paradoxical for me to say that I was "unlucky" to get a very good teacher at the very beginning of my school career. The guy was called Teacher [Kwasi]

Akwa, and Class one of the Asiakwa Presbyterian Junior School was the very first class he taught, upon graduating from the Akropong Teacher Training College.

He came to us in 1945, in the company of a classmate of his, Kwasi Aryeh (a slightly fair-coloured man, who taught Standard Six in the senior school).

These two teachers were full of beans. They wore the same Boy Scouts outfits a lot of the time. This meant that when they were walking on the cement floor of our school veranda, we could hear them a mile away. They had also been taught to speak loudly and clearly. So their voices carried very far and no-one could remain unaware of their presence. (In the voice category, however, they were not quite up to the standard of another teacher, Teacher Osae (whose deep, bass voice was so authoritative that he would have been much appreciated by the Gold Coast army, had become a parade commander in it!)

In January 1945, when we started at Class One, the Second World War was yet to draw to its fierce end, and these teachers probably desired to demonstrate to all that they too were "fit" to be soldiers, though they had been trained to be "mere" teachers...

Such a desire, if it was present in them, would have been due to the fact that the British, being great propagandists, had subtly spread the word that "able-bodied" men who didn't join the army and fight against Hitler, in defence of the British Empire, were "slackers" or "the rejected", who were physically lacking in something.

This was a serious charge to be made against any man. In fact, one of my own uncles, Kwasi Aade, had been sent back from a recruitment centre, because they said "gyat" (yaws) had been uncovered in the soles of his feet, during his medical examination!) So, young men like the three teachers must have resented the fact that to some in our community, they were what were contemptuously termed "k sa-ank bifo" [literally, "those who had evaded the war"!]

Being regarded as a k sa-ank binii" was a terrible disaster, for a man was enormously "heroic" if he deserted wife, children and family and got himself sent to Burma, by ship, to fight on the side of one group of white men (the Brits) against another group of white men (the Germans). Men plotted in secret for weeks before "running away" to go and "di soja" (be recruited



as soldiers.)

One early morning, all a man's kinsmen would notice was that he had not joined in the early morning gathering, as usual. His mother would be roughly awakened and informed. She would then wail and wail and refuse to eat the whole day.

Mourning would be appropriate, for next would come news, a few months later (usually brought by a cryptic telegram) that the man had been killed. (Indeed, up to the arrival of the universal mobile phone, the arrival of a telegram was dreaded throughout Ghana! The killing ground could be in Burma or Abyssinia or somewhere in "East Africa". (No-one in the family would have the slightest idea where geographical expressions these existed!) Few would ever have seen the sea, either!).

It didn't matter that a dead Ghanaian might never have set eyes on a German. Even the British were only seen occasionally -- at the parade ground. But the Good Coast soldier would be as "dead as a door-nail, all the same. That was how one fought to save 'King and Country' one would never set eyes upon!

Teacher Akwa brought an unrealised military zeal into his teaching. He was a great psychologist, for if he asked one a question and one got the answer correct, he would praise one to high heaven. A wrong answer attracted the bitter b taste of his raffia cane.

Because elder brother of mine was already in Standard Three) when I started in Class One, I had had a good collection of textbooks to study privately before I ever set foot in a classroom. So I could answer most of the questions Akwa asked us. He took my ability to parrot what I had read before as evidence of genius, and would get the whole class to clap for

On one occasion, he embarrassed me by giving me a desk all to myself (whilst everyone else shared desks with another child). This was because when I had scored ten-ten in an examination, the second best person had only got eight-ten! Akwa went berserk in his excitement: beneath the "One-pupil" desk, he wrote, in large letters, DANGER 'DD' BOY! And he invited older children from the more senior classes to come and see it and

Naturally, the flattery went to my head and I studied even more ardently, to try and win more plaudits. The result was that he divided the class into two -one to be taught by him, and the other to be taken through their lessons by me (under a tree). The bigger boys (some of whom owed their ability to evade being whipped by Akwa to my efforts) adored me. But some classmates of an equal size to me began to hate me. Was I some freak inserted into their midst

to show them up as "numbskulls"? With misguided enthusiasm and a desire b to broadcast my standing in the school and provide other children an incentive to study hard, Akwa promoted me to Class two, before the end of the year. It turned out, however, to be the worst decision he could have take with regard to my future. For when I got to Class Two, I found that the class teacher, a sleepy fellow called Teacher Otu, had no interest, whatsoever in teaching me what he had already taught my new classmates, so that I could catch up with them. In fact, he was so lazy that he left the class to a bully, who could ensure that the classroom was as quiet as the teacher wanted. Otherwise, the teacher would keep shouting "QUIET!" all day.

Well, without any warning, Teacher Otu one day suddenly sent me back to Class One! It was a major blow, but I was pleased. Yes, those of my classmates who were jealous of me could mock at me for getting my "comeuppance". But I didn't care. I was again "lord of all I surveved".

Best of all, at the end of the year, I was jumped to Class Three! I was as happy as a lark, for I was going to rejoin the Class Two pupils, out of whose ranks I had been thrown earlier. In the new class, we would all have the same brand new teacher and start on an equal footing in every sense of the word. Just let them wait and see, (I confidently told myself!)

# Celebrating our different cultures good for national unity and tolerance

 $\Gamma$  is human nature to fear unknown. Cultural differences come up as top causes of conflicts in the world. And understanding of different cultures and tolerance of the same is credited for peaceful coexistence of communities and

The government through the National Museum of Tanzania (NMT) introduced the National Cultural Festival in 1994 to showcase what the over 120 tribes in the country has to offer in terms of cultural heritage.

The event organizers select at least one tribe annually to showcase various aspects of culture such as dances, food, attire and various rites such as initiation to adulthood. It is normally a colourful event full of fanfare and normally grazed by highlevel government officials.

The recent event which took place at the Village Museum grounds in Dar es Salaam showcased the cultural wealth of the Safwa people from Mbeya Region. A traditional dance group from the tribe wowed the crowd in attendance with their energetic renditions.

In her speech, Deputy Minister for Tourism Mary Masanja who was the guest of honour said the main purpose of organizing such an event is to remind Tanzanians of the basic cultural issues and values which need to be promoted and maintained.

She said the significance of this occasion is that it can be used as an important platform through which development programmes and plans can reach people especially the youth,

"This is one way of showcasing Tanzania's traditional culture to other nations and communities; it reminds us where our ethnic groups came from and who the leaders were before colonization of African continent," she said.

NMT Director General Dr Noel Luoga told this writer in an interview that since its inception, a total of 33 tribes have participated in the event and more are lined up for the coming celebrations.

"There are certain cultural elements which are showcased at the festival to make people learn ways of life in selected ethnic groups in in our country especially their values and traditions," he said.

These include rites of passage to adulthood, courtships and marriage, traditional delicacies, dances, adornment and the general way of life in the selected ethnic group way back before the disruptions that came

with colonialism and modernity. According to Dr Luoga, also show-

cased is how various Tanzanian tribes dealt with difficult situations such as epidemics, famine, natural hazards such as floods as well as other unforeseen disasters. He said rituals were also performed in communities to restore peace and tranquility among tribesmen.

Different tribes have different ritual practices and the initiation rites are also different although there are predominant aspects among many tribes such as male

According to various interpretations, African traditional ceremonies are events based on social, spiritual, religious or public significance performed on special occasions for various reasons.

In some instances, they involve events or community gatherings, usually staged by

local communities and sometimes center danced enthusiastically to the tune of drum on some unique aspects of people's lives in

The recent occasion involved three different clans of the Safwa ethnic group namely Mbeta traditional dancers from Iduda clan, Simba Machezo from Galijele and another group came from Eleje.

Manzori Mwasanga Mwandere stole the show after he was introduced before the crowd as the oldest person among the Safwa traditional dancers at 102 years yet she still makes some energetic moves.

Looking at her physical appearance closely while dressed in her traditional dancing attire, one could be forgiven for thinking that she anywhere between 60

Mwandere became an attraction as she

especially when the Mwengulo group took to the stage, seeing many revelers on their feet in awe and disbelief.

Roketi Mwanshinga, Chief of Safwa whose official title is Mwene who introduced Mwandere said Mwengulo dance is played by family members who have lost a loved one to complete the mourning and resume normal life

Mwandere who spoke through an interpreter told this writer in an interview that she was born in 1920 and got married, had four children but three have already died.

She recalled that in late 1930s when she first came into contact with a white man in her village. The white men who visited her village were looking for energetic young African men for enlistment in the army for

the Second World War.

"Because it was forceful, I remember how men including my late husband ran and hid in the bush and returned when the white men had left," she said.

Safwa is a member of the large Niger-Congo group who are estimated to have come to the country between 1836 and 1843. Alternate names for Safwa language are Ishisafwa, Cisafwa, and Kisafwa. Its dialects are Guruka, Mbwila, Poroto and

Chief Mwanshinga said that the official traditional title of the Safwa chiefs is Mwene for a man and Mpoli for a woman. The clan that has held the Mweneship for many years is the Mwanshinga who trace their origins to Igawilo in Mbeya Urban Dis-

# Transforming governance practices is necessary or SADC's groundwater potential will remain subdued'

▲ THERE is an urgent need to intensify comprehensive groundwater governance to address the current challenges, achieve the future significance of groundwater and make use of opportunities

for protecting and augmenting groundwater resources," says James Sauramba. Sauramba is the executive director of SADC-

GMI, the Groundwater Management Institute of the Southern African Development Commu-Water security in the SADC region has been

subjected to the impacts of climate change and severe weather events. These have impacted negatively on the livelihoods of a significant proportion of the region's population which relies on groundwater for their daily activities.

It is estimated that 70 per cent of the SADC population depends on groundwater for their everyday uses, with groundwater having the potential to support further socio-economic growth on the continent.

Groundwater is today estimated globally to provide 36 per cent of potable water, 42 per cent of water for irrigated agriculture and 24 per cent of direct industrial water supply.

This dependence on groundwater calls for robust policy frameworks and institutional arrangements at local, national and regional lev-

Considering the pivotal role played by groundwater in the region, it is disheartening to learn that groundwater resources are still often poorly understood and managed.

In some areas, particularly urban and intensively cultivated areas, groundwater is often overexploited or contaminated.

It is important for policies and institutional frameworks at all levels to be revisited if we want to tap into the benefits potentially presented by groundwater resources. These include, but are not limited to, irrigated agriculture, contribution to employment and economic growth, increased water supply during extended droughts and protection of groundwater-dependent eco-systems.

Groundwater is a fundamental resource for social, economic and environmental sustainability across the 16 SADC member states.

As climate change intensifies and surface water levels continue to dwindle, human wellbeing, livelihoods, food security, ecosystems, natural habitats, industries and growing cities turn to groundwater for their primary source of the all-important.

Through improved policies and practices, groundwater could prove a catalyst for sustainable and equitable socio-economic develop-

ment and food security for resilient livelihoods across the African continent and in the SADC region in particular.

However, unless concerted efforts are made to vigorously transform groundwater governance practices, its potential remains subdued.

Some SADC member states have recorded great strides in integrating groundwater into their water resources management policies and institutional frameworks.

However, according to the UNESCO report: Groundwater Governance: A call for Action, legal instruments for groundwater governance are still in their infancy.

Notably, groundwater is not prominently featured in water legislation or policies in southern Africa. The resource is often excluded in water planning, and there is a general shortage of skills to monitor compliance with standards and abstraction.

The UNESCO report warns that the world's groundwater resources are falling victim to a lack of effective governance.

Information systems to measure and manage groundwater differ from country to country, while institutions to manage groundwater have limited capacity and suffer from scarce financial and human resources.

Through Sustainable Groundwater Management in SADC Member States Project Phase 1

(2015-2021), SADC-GMI implemented robust interventions aimed at promoting sustainable groundwater development in the region.

One such initiative was the implementation of the Policy, Legal and Institutional Development for Groundwater Management project across SADC member states.

The project focused on identifying gaps that existed in policy, legal and institutional frameworks and devised mitigating actions/strategies to address inconsistencies identified.

Culminating from the project, a SADC Regional Gap Analysis Report and 16 national gap analyses reports were produced. These reports are now serving as guiding documents for the member states in addressing the gaps identi-

The USAID Resilient Waters Programme is currently supporting SADC-GMI in converting the gap analyses for the four Limpopo River basin countries, namely, Botswana, Mozambique, South Africa, and Zimbabwe into national road maps for each of the countries to implement.

This activity forms part of the implementation of the work of the Limpopo Groundwater Committee, a structure set up and operationalised with support from the USAID Resilient Waters Programme.

Sauramba believes that informed management of groundwater resources is needed for unlocking the sustainable development of groundwater in Africa for the benefit of socioeconomic development, water and food security, and climate change resilience.

This would be made possible by using an improved knowledge base and human and institutional capacity as well as enhanced governance through the implementation of effective policy and legal instruments.

However, he gives the lack of scientific and technical knowledge on trans-boundary or national aquifers as one of the major challenges to proper governance.

If well managed, he adds, groundwater could ensure long-term water supply to meet the increasing demands brought about by the anticipated climate variability.

SADC-GMI activities towards ensuring sustainable groundwater management in the SADC region are funded by the Multi Donor Trust Fund (MDTF) for Cooperation on International Waters for Africa (CIWA), Global Environment Facility (GEF) through the World Bank and USAID, and implemented under the strategic guidance of the Water Division in the SADC Secretariat's Infrastructure Directorate, in the Botswana capital, Gaborone.

"Companies and governments have supported [industrial agriculture] by billions of dollars of investment, which has gone into systems that lock farmers into certain types of production," says Ronnie Brathwaite, Senior Agriculture Officer at the U.N. Food and Agriculture Organization (FAO), at a recent symposium focusing on the African region.

agricultural Industrial systems rely heavily on inputs from a few major suppliers and often require shipping food products across the globe, Brathwaite says. And weaknesses in these systems threaten food security across Africa and the globe, as recent crises like the COVID-19 pandemic and the war in Ukraine have exposed.

Brathwaite emphasizes that systemic change is necessary for food security and food sovereignty. And it's important for the additional benefits that communities can gain from better farming practices, such as employment opportunities, income generation, strengthened rural economies, and more.

"That can come from agroecology,' Brathwaite.

Janet Maro, Executive Director of Sustainable Agriculture Tanzania, defines agroecology as a sustainable and holistic farming system that works with nature, reducing the use of heavy external inputs, improving and sustaining biodiversity, recycling resources, and prioritizing local supply chains-all of which contrib-

ute to climate change mitigation.

This is a transformative approach, Maro says: "Agroecology is the way to go if we aim to feed the growing population and ensure that we're able to produce food in ways that are sustainable also for the future genera-

According to the results from the Tool for Agroecology Performance Evaluation (TAPE) in Africa, households using more advanced agroecological practices are linked to a range of benefits. They have higher scores in soil health, agrobiodiversity, and the presence of natural vegetation and pollinators, more diversified diets, and

better economic perfor-Rural areas in Africa with agroecological households, is a nonprofit conducting

more agroecological farms can sustain more people. They tend to have a higher population and higher employment in farming, and "as a result, young people are less prone to emigrate," says Dario Lucantoni, Agroecology and Livestock Specialist at the FAO.

The TAPE also showed that in areas with more

"women are enjoying higher gender parity and they have more voice in the decisionmaking," says Lucantoni.

Agroecological practices have already promoted gender equality throughout Northern Malawi, says Lizzie Shumba, Agriculture and Nutrition Manager at Soils, Food and Healthy Communities (SFHC). SFHC

community-based training on agroecology through a participatory co-learning approach.

"After applying different agroecological practices involving both men and women, we have seen significant changes in terms of gender relations within the household as well as the community," says Shumba. This includes equality in owner-

ship of assets, control over income, input in agriculture decisions, workload and leisure, and more.

Meanwhile, these households have significantly improved soil fertility, climate resilience, and biodiversity. According to Shumba, they are 32 percent less likely to be severely food insecure per additional food crop grown.

But despite the studies presented, Gungu Mibavu, Senior Economist with the Government of Tanzania says there is not enough scientific evidence to support the commercialization of agroecological practices.

"We're missing a common platform on this, in the region or as a continent... we could have some agroecological centers or a kind of platform where we can all share what we have, our experiences, and also build knowledge and disseminate issues," says Mibavu.

According to Brathwaite, there is ample evidence to prove agroecology is effective, but it does not see the number of resources devoted to large chemical or seed companies.

"That is where the big money lies, and it is within the private sector," says Brathwaite. "We either need foundations to help us upscale agroecology or we need to woo the private sector over to our way of thinking more about sustainability rather than profit-the latter is more difficult."

Brathwaite emphasizes that while the FAO has joined several partners to consolidate agencies, institutions, and farmers' groups under the Agroecology Coalition, these activities still need donor funding: "Many of the activities that we do are quite modest in terms of the scale at which we can do them because funds are not available."

Throughout the discussion, speakers agree that effectively scaling agroecological practices in Africa will need all sectors and stakeholders at the table.

"Farmers alone, scientists alone, or policymakers alone cannot make really big change and also bring the transformation that we need in the food system," says Maro. "We need interaction, co-creation, collaboration, and working together." 

# 'Census will stimulate communication services in Tanzania' Closer China-Africa

HE increase in the number of mobile phones has enabled Tanzania to be the first country in the world to achieve a full interoperability system by allowing mobile money transfers between various mobile networks.

According to the Tanzania Communications Regulatory Authority (TCRA), the number of registered sim cards reached 56.3 million by June, this year, which means that telecommunication services have continued to penetrate in various areas in the country.

In a statement, TCRA Director General Dr Jabiri Bakari said mobile phones have penetrated by 94 percent whereby their several uses including financial transactions have contributed to strengthen financial inclusion in the country.

He said along with benefits to users, agencies and financial institutions, the financial services through mobile phones have enabled the communication sector to grow.

"Mobile money transactions are rapidly increasing. A report of the Bank of Tanzania (BoT) in 2019/20 shows that mobile money transactions have grown by 21.8 percent in volume and 8.9 percent in value compared to 2018/2019.

Dr Jabiri said this is an important milestone and first of its kind in the world to create a cashless society with flexible payment options and with full participation in Tanzania's formal financial system by spreading financial inclusion.

He said the ongoing 2022 Population and Housing Census e was important to facilitate proper development planning by knowing the actual situation of people and settlements so as to prepare enough resources that will address the ex-



isting problems.

He said that the census statistics will enable the government to compare its plans with existing resources, know the needs of its people, review plans and strategies with the aim of improving them and using resources in a sustainable way.

He noted that Tanzania is implementing the plan to build a digital economy, strengthen communication in rural areas and reduce the cost of operations making the country a centre of excellence in e-commerce in East Africa and SADC. This requires accurate statistics of communication so as to

achieve the intended goals.

He said information such as gender, disability, education levels and daily activities can be used in preparing strategies to eliminate differences in the use of mobile services in gender, geographic, economic, understanding and ability to

"There are three types of differences in the access and use of communication services; these are between men and women; urban and rural users, the ability to afford communication devices and the costs of use and understanding, so all these information are important

to enable the government at the same time enabling to improve communication services to its people," he

The 2021 OECD report shows that hurdles to access, affordability, lack of education and skills and technological literacy, and inherent gender biases and socio-cultural norms, are at the root of gender-based digital exclusion. It shows that women are lagging behind in owning and use of mobile phones.

The report suggests that addressing the digital gender divide requires raising awareness and tackling gender stereotypes, while enhanced, safer and more affordable access to digital tools and fostering strong cooperation across stakeholders to remove barriers to girls and women's full participation in the digital

world. It also recommends strengthening the data collection system to facilitate sustainable decision-making. This includes improving access to statistics for all stakeholders so as to speed up the removal of the gaps in the access and use of com-

munication services. Tanzania is implement-

remove the barriers in the access of communication services which included the establishment of the Universal Communication Service Access Fund (UCSAF) to strengthen the capacity and partner with telecommunications service providers in the country to ensure availability of communication services in rural and urban under-served areas.

# cooperation boosting Africa's supply chain development: report

CLOSER cooperation between China and Africa is boosting Africa's supply chains amid various headwinds, according to a report released on

The report, titled "Chinese Investment in Africa (2022): China-Africa Cooperation from a Supply Chain Perspective," was published by the China-Africa Business Council. It elaborated on China's role in Africa's supply chains, Chinese enterprises' efforts in this regard and the challenges faced.

Africa's supply chains were under stress, the report said, citing negative factors such as diseases, regional conflicts and logistical snags.

However, considering its rapid population growth, Africa is still an ideal market for supply chain investment with significant potential, it

The report highlighted Chinese contributions, both at the policy and local levels, that are playing crucial roles in boosting Africa's supply chain development.

Thanks to the Forum on China-Africa Cooperation, the Belt and Road Initiative and other government efforts, China and Africa have realized practical cooperation in a wide range of areas, in particular in industrial and supply chain develop-

Deeper Belt and Road cooperation between China and African countries "will play an important role in building a more integrated African continent as well as connecting Africa to global supply chains," the report noted.

Chinese enterprises have also made a great contribution to advancing Africa's supply chains in the fields of logistics, agriculture and e-commerce, among others, according to the report.

It also provided recommendations for governments and enterprises to further incentivize highlevel China-Africa supply chain cooperation.

# UN labour report highlights employment challenges for youth

UNITED NATIONS,

prompted economic shutdowns across the globe, many analysts predicted that youth would be especially at risk. This is because young people tend to have fewer economic assets and limited experience in the labor market.

A recent International Labour Organisation (ILO) report published on August 11, 2022, confirmed this vulnerability. The Global Employment Trends for Youth 2022 found that the pandemic set employment rates for youth back more than for any other age group.

Certain regions struggle with youth employment more than others. High-income countries would see their youth employment rates back to pre-pandemic levels by the end of the year, the report revealed. In Africa, however, the decline would only serve to worsen a state of affairs that was already growing perilous.

Africa hosts the world's youngest population. Seventy percent of Sub-Saharan

Closing its report, the ILO noted that the COVID-19 recovery presents opportunities for governments to pursue policies that boost youth employment.

"What young people need most is well-functioning labor markets with decent job opportunities for those already participating in the labor market, along with quality education and training opportunities for those yet to enter it," Martha Newton, ILO Deputy-Director General for Policy, stated in the report's press release.

On South Africa's unemployment problem, Graham stressed that no matter what policies get selected to tackle the crisis, policymakers should consider poverty-related barriers that may hinder young people's ability to access employment.

"Young people in [South Africa] also struggle to transition into the labor market at the same time as they face multiple forms of deprivation including food and income insecurity, care responsibilities, and in some cases strained mental health."

The suggested policies were all necessary and welcome. Graham told IPS, but they will need to be evaluated to see how young people fare in their wake to measure their true impact.

## Large banks beat tier-two lenders in profitability

## **NAIROBI**

Large banks are widening the profitability gap between them and their tier two and three counterparts, leveraging on their wider reach and cheaper cost of funds to extract a higher return on assets.

The tier-one lenders significantly extended the gap in earnings in 2021 as they made a better recovery from the Covid-19-led slowdown of 2020 compared to the other tiers, nearly doubling their gross earnings in the process.

The nine banks that make up the top tier are Equity, KCB, Cooperative Bank, NCBA, Standard Chartered Bank Kenya, Absa Bank Kenya, Stanbic, DTB, and I&M.

Together, they grew their pre-tax profit by 84 percent or Sh78 billion to Sh170.6 billion last year, while the eight tier two lenders grew theirs by 38 percent or Sh6.5 billion to Sh23.58 billion.

Tier three lenders, which number 22, raised their pre-tax profits by 39 percent or Sh970 million to Sh3.48 billion.

The Kenya Bankers Association (KBA) attributed the higher return on assets and equity of tier one banks to their advantage in market share in both deposits and assetsparticularly cheaper deposits.

The nine tier one banks account for 75.3 percent of both assets and deposits of the industry by the end of last year, data from the Central

Bank of Kenya (CBK) shows. "Across bank sizes, profitability (measured by Return on Assets

and Return on Equity) was highest among tier one banks in 2021; an observation that supports the

view that larger operations allow banks to exploit economies of scale, thereby enhancing their profitability.

Further, efficient banks - that is, those with lower cost-toincome ratios - have a higher RoA and RoE than less efficient banks" said KBA in its 2022 State of the Banking Industry report that was released last month.

Return on Equity (RoE) is a measure of a bank's ability to generate profits using shareholder funds, giving investors a measure of how much they are getting from every shilling of retained capital.

Return on Assets (RoA) is a measure of a lender's capacity

to make profits from the total resources it controls, including borrowed funds

For tier one lenders, RoA stood at 3.79 percent last year. compared to 1.83 percent for tier twos and 1.53 for tier threes, indicating that they were able to extract a higher return from their assets, which are mainly in form of customer loans and

lending to the government. In terms of value to their shareholders, tier one average RoE stood at 25.6 percent on average in 2021, marginally ahead of tier two RoE of 25.5 percent, while tier three lenders trailed significantly at 4.83 percent.

## Banking graduate pandemic boom fades after junior exodus

LONDON

Thousands of top graduates vie for just a handful of high-paying jobs at the world's biggest investment banks each year.

But at some banks, competition for places is getting less intense.

Credit Suisse, HSBC and Morgan Stanley all saw a drop in applications for graduate and internship places this year, either in Europe or globally, according to figures obtained by Financial News.

The sharpest drop was at HSBC, where the number of students vying for graduate places in Europe fell by 49% to 3,558. Globally, applications fell by 36% to 10,763. The UK lender increased the number of hires within its global banking and markets unit by 27% on 2021 to 108 this year.

At Credit Suisse, which has been rocked by successive crises and executive departures over the past year, applications in Emea fell by 10% to 23,500, and by 7% globally to 77,000, according to people familiar with the numbers. The bank hired 100 interns in the UK, largely within its investment bank

Meanwhile, Morgan Stanley received nearly 6,000 fewer applications for its European internship programme this year, a decline of 12% on the previous year. It had 41,211 students com-

peting for 816 internship places in 2019 and 2020. in Emea.

Banking graduate spots are known for their brutal hours. A handful of Goldman Sachs analysts leaked a presentation last year outlining physical and mental exhaustion as they endured 100-hour weeks, and the sector battled an exodus of burnt-out

Investment banks have been forced to hike entry-level salaries by 40% in London over the past year, with most shifting from £50,000 to £70,000 for graduates fresh out of university.

But while some investment banks have seen a drop in applications this year, the battle for a select number of jobs remains intense.

Morgan Stanley and Credit Suisse's 2022 numbers, while below last year, are still in line with the number of applications received

"Demand remains super-high and fiercely competitive," said Logan Naidu, chief executive of headhunters Dartmouth Partners, which recruits for graduate banking roles. "There aren't many jobs where you can earn £100,000 in total compensation straight out of university. Students going into investment banking, more than ever, know what they're getting into."

Other banks drew more interest from juniors, including Goldman Sachs, despite the negative attention of its analysts' leaked memo.

Goldman received 236,000 applications for its internship programme globally, a 17% increase. It takes on around 3,000 employees each year.

JPMorgan had 270,855 students competing for 4,604 internship places globally, an increase of

20%. However, the rise within its investment banking division was not as sharp - 54,000 applications for 480 places, a 5% increase. In Emea, applications are up by 19% for the same unit, a bank spokesperson said.

Citigroup received 73,000 applications for 805 intern and fulltime positions within its Emea business, which is flat on a year earlier as the number of recruits has increased.

A Bank of America spokesperson declined to comment on graduate recruits. Deutsche Bank did not respond to requests for

Investment banks did not cut back on graduate recruitment during the pandemic even as other sectors pulled back, said Martin Birchall, chief executive of High Fliers Research, which tracks graduate recruitment

"We're seeing growth across all the sectors that cut during the pandemic, but investment banks are stable going into 2023," he said. "Banks have largely stayed away from campuses, preferring fully online recruitment initiatives that broaden the array of candidates applying. Whether that means they recruit beyond the business students from top universities remains to be seen."

As well as hiking salaries, banks have enforced restricted working hours, including protected weekends and allowing 'connection free' holidays.

However, senior bankers told Financial News that real change would be difficult without drastically increasing the number of recruits, which would both reduce the exclusivity of the industry and necessitate cuts

Nicola Thomas, head of research at the Institute of Student Employers, said that there were 118 applications for every available role within the wider financial services sector last year, an increase of 17% and the highest rate since 2001. Students who stayed in higher education or struggled to break into the labour market during the height of the pandemic in 2020, contributed to the rise she said.

However, she added there has been a "big drop" in applications across financial and professional in 2022. Across all sectors, graduate applications have dropped by 48% compared to a year earlier, according to ISE's annual vacancy survey.

These are two of the first few banking companies that have integrated blockchain into their trading and business operations. The traditional banking

industry has this gigantic task of maintaining the records and processing the transactions of their everincreasing customer base. They have to follow several procedures to ensure the safety and security of their customers. This makes the ing experience seamless for entire banking procedure quite costly and lengthy.

The use of blockchain technology in banking helps in alleviating these issues and streamlining the operations of banks. It reduces costs, improves transparency and fraud detection, increases automation, reduces the amount of paperwork, hastens verification process, and ensures



decentralization of lengthy banking procedures, among other things.

Now, let's learn more about how the aforementioned banking giants are utilizing blockchain technology to make the banktheir customers:

## JPMorgan Chase (JPM)

With a market cap of around \$375 billion, JPMorgan Chase is one of the first banks to offer a blockchainbased platform, called Onyx, to its customers to carry out wholesale payment transactions. The platform helps facilitate payments, digital assets, and information sharing within the banking sector. Onyx's services include

Liink, an information exchange network, Coin Systems for digital clearing and transfer of money, and Onyx Digital Assets for smooth exchange of different types of digital assets. JPM also has a center of excellence, which is focused on the development and launch of new blockchain networks, applications, and shared platform technol-

These offerings make the New York-based financial services provider a pioneer in the transformation of the banking industry.

Based on 10 Buys, seven Holds, and one Sell, JPMorgan has a Moderate Buy consensus rating on TipRanks. JPM's average price target of \$138.33 implies upside potential of 19.8% over current levels.

## Goldman Sachs (GS)

Goldman Sachs is catching up with JPMorgan in the use of blockchain technology within the banking segment. In June last year, it worked with the European Investment Bank for the first public digital issuance on Ethereum public blockchain. The two-year, €100 million bond was the first of its kind and unlocked a new

era of transparency and speed for capital market transactions

Additionally, the investment banking firm recently collaborated with Swiss financial technology company HQLAx for the execution of the first agency securities lending transaction on the blockchain. According to a press release by HQLAx, the transaction involved hundreds of millions of dollars and included a combined series of 35-day term transactions.

These initiatives show the \$117.6 billion company's commitment toward enhancing the banking experience of customers.

Meanwhile, on TipRanks, Goldman Sachs has a Strong Buy consensus rating based on 14 Buys and three Holds. GS' average stock forecast of \$394.27 implies 15.9% upside potential.

#### Can Blockchain Technology Disrupt the **Banking Industry?**

Blockchain technology has the potential to disrupt the banking industry with its shared ledger feature. This feature can get rid of financial intermediaries and establish trust and transparency between the unknown transacting parties. The shared ledger technology makes use of cryptography to allow all transacting parties to control the data.

Blockchain technology is still new in the market, with not a lot of takers. It needs to gain mass acceptance to demonstrate its true potential. The technology also needs to overcome regulatory hurdles across the world to boost its uptake by financial institutions.

## Islamic banking in Egypt market reached \$23.38bn by June



**CAIRO** 

Mohamed Al-Beltagy - President of the Egyptian Association for Islamic Finance – said that the volume of Islamic banking in Egypt recorded EGP 443bn by the end of June – an increase of EGP 52.8bn and a growth rate of 13.5 percent from June 2021.

He pointed out that the volume of Islamic banking represents about 5% of the total size of the Egyptian banking market as a whole.

The Egyptian banking market includes 14 banks that have a license from the Central Bank of Egypt (CBE) to provide Islamic banking products, and there are three fully Islamic banks - namely Faisal Islamic Bank of Egypt, Al-Baraka Bank Egypt, and Abu Dhabi Islamic Bank Egypt – in addition to 11 banks that have Islamic branches alongside their traditional ones.

Al-Beltagy explained in a recent report issued by the association that the Faisal Islamic Bank of Egypt came in first in the Islamic banking market in Egypt with a business volume of EGP 138.3bn, accounting for 31.3% of the total industry.

In second place, Abu Dhabi Islamic Bank Egypt achieved a turnover of EGP 98.7bn and a share of 22.3%. And in third place was Banque Misr's Islamic branches with a turnover of EGP 91.6bn and a share of 20.7%, followed by Al-Baraka Bank in fourth place with a business volume of EGP 82.8bn and a share of 18.7%.

According to Al-Beltagy, the volume of deposits conforming to Islamic law in the Egyptian market amounted to about EGP 360.2bn by the end of the first half (1H) of 2022 – an increase of EGP 17bn and a growth rate of 5% compared to 1H

He explained that Islamic deposits represent about 6.3% of the total volume of deposits in the Egyptian banking market, pointing out that the increase in those deposits was concentrated by 88% in Faisal Islamic Bank of Egypt's branches with a value of EGP 6bn, Abu Dhabi Islamic Bank Egypt with EGP 7bn, and the

Islamic branches of Banque Misr at EGP 2bn.

He added that the volume of Islamic Sharia-compliant financing in the Egyptian market recorded about EGP 348.5bn - an increase of EGP 52.4bn and a growth rate of 17.7% – pointing out that this form of financing represents about 5% of the volume of financing in the Egyptian banking market.

Al-Beltagy also pointed out that the increase in Islamic finance was concentrated by 96% in Faisal banks at a value of EGP 13bn, Abu Dhabi Islamic Bank EGP 19bn, and the Islamic branches of Banque Misr EGP

# Top ten UAE banks net income jumps 24.4pct in Q2

**DUBAI** 

he top ten UAE banks' net income jumped 24.4 percent to AED12.6 billion (\$3.43 billion) in the second quarter (Q2) driven by better asset quality, improved profitability and margins, said Alvarez & Marsal (A&M).

The country's 10 largest listed banks are First Abu Dhabi Bank (FAB), Emirates NBD (ENBD), Abu Dhabi Commercial Bank (ADCB), Dubai Islamic Bank (DIB), Mashreq Bank (Mashreq), Abu Dhabi Islamic Bank (ADIB), Commercial Bank of Dubai (CBD), National Bank of Fujairah (NBF), National Bank of Ras Al-Khaimah (RAK) and Sharjah Islamic Bank (SIB).

Total interest income of the banks grew drastically by 19.5 pct QoQ (quarter-on-quarter) in Q2'22, boosted by higher interest income, said A&M, leading global professional services firm, in its latest United Arab Emirates Banking Pulse for Q2 2022.

The push and pull between loans

and deposits reveals an improvement in customers' personal economic standing. The rise in interest income has been spurred by a sharp rise in both advances and deposits. Total advances grew by 1.8pct while deposits grew faster at 4.5pct.

Aggregate non-interest income (NII) surged by 15.1pct QoQ and the overall net interest margin (NIM) jumped by 26.1 bps QoQ due to higher benchmark rates. Overall asset quality improved as non-performing loans (NPL)/ loans and advances (L&A) fell by 0.4pct to 5.7pct during the quarter.

A&M's UAE Banking Pulse examines data of the 10 largest listed banks in the UAE, comparing the Q2'22 results against Q1'22 results. Using independently sourced published market data and 16 different metrics, the report assesses banks' key performance areas, including size, liquidity, income, operating efficiency, risk, profitability, and capital.

The top ten UAE banks' aggregate L&A increased by 1.8pct QoQ in Q2'22,



while the deposits grew at 4.5pct QoQ. Consequently, aggregate loan-to-deposit ratio (LDR) decreased to 82.4pct QoQ in Q2'22 compared to 84.5pct

Operating income witnessed an uptick primarily due to higher interest income (19.5pct QoQ) supported by NII such as foreign exchange income and investment gains.

The total operating income increased by 13.6pct QoQ as compared to -6.4pct in Q1'22. The growth was primarily driven by NII which increased substantially by 15.1pct QoQ and foreign exchange and investment related income of +24.1pct QoQ.

The UAE banking sector's NIM noted an improvement as the benchmark interest rate increased. Although NIM increased to 2.3pct it is still below the pre-pandemic levels of 2.6pct.

The NIM improved by 26.1bps QoQ as aggregate NII of +15.1pct QoQ grew at a faster pace as compared to net interest-bearing assets of +3.9pct QoQ. The yield on credit jumped 84bps QoQ to 5.9pct for Q2'22 largely due to a substantial increase in interest Income at +19.5pctQoQ due to interest rate hike. The cost of funds deteriorated by 26.2bps QoQ to 1.3pct in Q2'22.

Operational efficiency improved in Q2'22 despite an increase in operating expenses. The cost-to-income (C/I) ratio improved by 2.9bps QoQ to reach 31.5pct.

The drop in C/I ratio was due operating income of +13.6pct QoQ growing at a faster pace than operating expense of +4.1pct QoQ. Eight out of ten UAE banks reported an improved C/I ratio in Q2'22.

Cost of risk (CoR) improved as aggregate impairment charges continued to decline for the sixth consecutive quarter.

The aggregate CoR fell by ~9.7bps QoQ to 0.72pct in Q2'22 and the decline is attributed mainly to the decrease in total provisioning to AED3.1 billion at -9.7pct QoQ in Q2'22 from AED3.5 billion in Q1'22.

The return ratios witnessed an uptick in Q2'22 as profitability improved across the board. The aggregate net income increased by 24.4pct QoQ, as a result the return ratios such as return on equity (ROE) and return on assets (ROA) improved by 1.9pct points QoQ and 0.3pct points QoQ respectively.

Asad Ahmed, A&M Managing Director and Head of Middle East Financial Services commented: "The regional banking sector, including that of the UAE is expected to report continued strong profitability on the back of increasing interest rates, improving credit quality and robust economic growth.

# Indian banks to gain from rising credit demands

Indian banks will get a lift from higher lending for the remainder of this year, though rising costs may drag on profits.

Most Indian banks reported better growth in lending and net interest income in the April-to-June quarter. Still, many missed earnings expectations on mark-to-market losses, or unrealized losses on investments, caused by market volatility.

For the remainder of the fiscal year to March 31, 2023, rising interest rates will help banks' net interest margins.

"Outlook for the Indian banking sector for fiscal year 2023 remains positive, supported by the improved asset quality and increase in loan book," said Tusharika Aggarwal, research analyst at APAC Dividend Forecasting at S&P Global Market Intelligence.

Overall bank credit grew 14.3 percent year over year as of July 29 to 127.35 trillion rupees, according to Reserve Bank of India data released Aug. 10. Credit uptake has accelerated in recent months as the economy recovers from the COV-ID-19 pandemic.

The International Monetary Fund expects India's gross domestic product to grow 7.4 percent in 2022, according to a July 26 press release.

In contrast, the world economy may



slow to 3.2 percent expansion this year, compared with 6.1 percent in 2021, dragged by downturns in Russia and China in the second

Most Indian banks "have raised their growth guidance for [fiscal 2023], factoring strong [first quarter] and improving growth impulses in retail, [small and medium-sized enterprises], and

corporate portfolio," said Anand Dama, analyst at Emkay Global, in a note on Aug. 11. Overall nonperforming loan ratios are likely to decrease due to a better credit growth trajectory, and banks already have healthy provision buffers that should support their prof-

However, operating costs have increased due to elevated business expenses, staff compensation, and investments in branches and technology. That "kept core profitability in check," Dama said, adding that banks will need to pass on the rate hikes and raise fees to protect their core profitability.

State Bank of India expects to continue its credit growth in the next few months. The nation's biggest lender by assets will be able to the June quarter.

sustain its 14.93% growth in gross advances reported in the fiscal first quarter, as the bank has nearly 5 trillion rupees in term loans and underutilized working capital credit lines to its customers, Chairman Dinesh Khara said at a post-earnings conference call on Aug. 6.

Punjab National Bank CEO Atul Kumar Goel said during the company's July 29 earnings call that the lender is expecting 10% loan growth over last year, although that may be revised upward as "there is traction in the market.'

Still, banks will be buffeted by market volatility. State Bank of India reported a 6.7% year-over-year decline in stand-alone net profit for the fiscal first quarter to 60.68 billion rupees, primarily due to mark-to-market losses on its investment book of 65.49 billion rupees. Similarly, Punjab National Bank posted 14.09 billion rupees in unrealized loss in

## **Pope instructs** holy entities to move cash to Vatican bank

Pope Francis has ordered that the Holy See and connected entities move all financial assets to the Institute for Works of Religion (IOR), commonly known as the Vatican bank.

The pope's rescript, issued Aug. 23, clarifies the interpretation of a paragraph in the new constitution of the Roman Curia, Praedicate Evangelium, promulgated in March.

According to Francis' rescript, financial and liquid assets held in banks other than the IOR must be moved to the Vatican bank within 30 days of Sept. 1, 2022.

The IOR, based in Vatican City State, has 110 employees and 14,519 clients. As of 2021, it looked after 5.2 billion euros (\$5.6 billion) of client as-

Though commonly called a "bank," the IOR is technically a financial institute, with no branches, working within Vatican City State to provide services to clients, which include the Holy See and connected entities, religious orders, clergy, Catholic institutions, and Holy See employees.

The IOR saw its number of clients decline by 472, from 14,991 clients at the end of 2020 to 14,519 in 2021. Nearly half of its clients in 2019 were religious orders.

According to its annual report, the financial institution's \$19 million net profit in 2021 was also down from \$44 million in 2020 and \$46 million in 2019.

In his Aug. 23 rescript, Pope Francis said article 219, paragraph 3 of Praedicate Evangelium "must be interpreted to mean that the activity of asset manager and custodian of the movable patrimony of the Holy See and of the Institutions connected with the Holy See is the exclusive responsibility of the Institute for Works of Religion."

The decree will force Holy See institutions, including the Secretariat of State, to move their financial assets to the IOR by the end of September. The Secretariat of State is known to have had accounts in Swiss financial institutions, including Credit Suisse, through which the controversial London building investment was initially carried out.

Article 219, paragraph 3 of the new curial constitution says: "The execution of the financial transactions referred to in §§ 1 and 2 is carried out through the Institute for the Works of Religion," the IOR.

The financial transactions described in paragraphs 1 and 2 of article 219 are the administration and management of the Holy See's real estate and movable assets and entities entrusting their assets to the Holy

## FBI finds 700-plus pages of classified records at **Donald Trump's home**

**WASHINGTON** 

THE US National Archives discovered more than 700 pages of classified documents at Donald Trump's Florida home in addition to material seized this month by FBI agents, according to a newly disclosed May letter the records agency sent to the Republican former president's attorney.

The large quantity of classified material in 15 boxes recovered in January by the National Archives and Records Administration, some marked as "top secret," provides more insight into what led to the FBI's courtauthorized Aug 8 search of Trump's residence at the Mar-a-Lago resort in Palm Beach.

The agency is responsible for preserving government records.

The May 10 letter was sent by Acting US Archivist Debra Steidel Wall to Trump attorney Evan Corcoran. It was released late on Monday by John Solomon, a conservative journalist who Trump authorized in June to access his presidential records. The National Archives posted a copy on its website on Tuesday.

"Among the materials in the boxes are over 100 documents with classi-

fication markings, comprising more than 700 pages. Some include the highest levels of classification, including Special Access Program materials," Wall's letter said, referring to security protocols reserved for some of the country's most closely held se-

The letter contains additional information about Trump's handling of classified materials and his efforts to delay federal officials from reviewing the documents.

The letter shows that Trump's legal team repeatedly tried to stall the Archives from letting the FBI and intelligence officials review the materials, saying he needed more time to determine if any of the records were covered by a doctrine called executive privilege that enables a president to shield some records.

President Joe Biden's administration - specifically the Justice Department's Office of Legal Counsel - has determined that the materials were not covered by executive privilege. It found "there is no precedent" for a former president to shield records from a sitting president using executive privilege when the materials in question legally belong to the federal

## **Pope Francis expresses condolences** over death of Darya Dugina

POPE Francis expressed condolences over the death of Russian Darya Dugina, calling her an "innocent victim."



"I think of the poor girl who was blown up by a bomb placed under the car seat in Moscow. The innocent pay the price of war," the ANSA news agency quoted the pontiff as saying yesterday at a collective audience.

Francis said he turned his thoughts to Russia and Ukraine on that day. "I pray that she, the Mother of God, will look to these two beloved countries and lead them to the peace we all so desperately need," he said.

The pontiff once again condemned those who make their money by selling weapons. "They (arms dealers -TASS) are criminals who kill humanity," the pope noted, recalling other conflicts, including those in Yemen and

On the evening of August 20, an explosive device went off in a Toyota Land Cruiser car on a road near the village of Bolshiye Vyazyomy, the Moscow Region. The car caught

As it was found out later, the explosive device had been planted under the vehicle's floor on the driver's side. Dugina, who was driving the car, died on the spot.

The Russian Federal Security Service's Public Relations Center told TASS that the murder had been solved. It was prepared by the Ukrainian special services, the perpetrator was Ukrainian citizen Natalia Vovk.

## Russian diplomat slams Zelensky's denial of Kiev's involvement in journalist's murder

**MOSCOW** 

UKRAINIAN President Vladimir Zelensky's denial of Kiev's involvement in the murder of Russian journalist Darya Dugina is "another link in the chain of lies," Russian Foreign Ministry Spokeswoman Maria Zakharova told Sputnik radio yesterday.



"Zelensky appeared in front of cameras once again, saying that they had nothing to do with it because she wasn't a Ukrainian national, nor was she staying in Ukraine. Well, it's nothing new. Another link in the chain of lies. However, the West is ignoring that. Not because it can't see it, but because the Kiev regime is doing exactly what Western guidelines say," she pointed out.

Zakharova noted that the Mirotvorets (or Peacemaker) website containing people's personal data had been operating in Ukraine for years.

"And now, as Russian Permanent Representative to the UN Mr Nebenzya said at a Security Council meeting and as he told reporters, Dasha's page is marked as 'eliminated'," the diplomat added.

Dugina, 29 (pictured), was a media professional who particularly covered developments in Donbass. The journalist was killed in a car explosion in the Moscow Region on August 20. Russia's Federal Security Service (FSB) announced on August 22 that Dugina's murder had been solved. According to the FSB, it had been masterminded by Ukrainian intelligence agencies and executed by Ukrainian national Natalia Vovk, who fled to Estonia following the crime.

UN decries fighting in S.Sudan's northern state

THE United Nations Mission in South Sudan (UNMISS) on Tuesday decried renewed clashes between rival armed groups in South Sudan's Upper Nile State, a northern region.

The UN mission expressed concern about the safety and security of thousands of civilians caught up in the clashes, calling on all parties to respect international law and safeguard freedom of movement for humanitarian organizations in the Upper Nile area.

"Over 200 of the displaced persons have sought refuge at the UN Protection of Civilians site in Malakal, the capital of Upper Nile State. Many children are reported to be missing or separated from their families." UNMISS said in a statement in Juba, the capital of South Sudan.

The renewed fighting that began last week in Tonga town has displaced more than 15,000 people, while flooding is hindering their access to humanitarian aid and safer areas while others sought refuge at the UN base. It said it is engaging with the affected communities, government, and local authorities, to quell tensions and support efforts toward a peaceful resolution.

UNMISS urged feuding parties to immediately stop the violence and adhere to the Revitalized Peace Agreement. The UN mission said it supports the movement of humanitarian organizations and deploying additional peacekeepers to the UN protection site to increase security and mitigate the risk of spillover Xinhua

## China's help on Africa's supply chain called crucial

CHINA has played an essential role in Africa's supply chain development by addressing related challenges, such as the COVID-19 pandemic and regional conflicts, and has helped improve socioeconomic development on the continent, African officials said on Tuesday.

The remarks were made at a ceremony marking the release of a report published by the China-Africa Business Council on China's investment in Africa. From a supply chain perspective, the report showcased efforts made by Chinese enterprises to improve Africa's supply chain and support the independent and sustainable development of Africa.

Rahamtalla M. Osman, permanent representative of the African Union to China, said the Forum on China-Africa Cooperation and the Belt and Road Initiative are closely aligned with Africa's development blueprint and strategies, such as the AU's Agenda 2063 and the African Continental Free Trade Area.

Deeper BRI and AfCFTA cooperation would play an important role in building a more integrated African continent as well as connecting Africa to global supply chains, Osman added.

He also said that by 2021, China's trade with Africa had increased twentyfold, and its investment stock in Africa saw a hundredfold increase since 2000. More than 3,800 Chinese enterprises have invested in Africa, he added. "All of this has contributed to China-Africa cooperation in supply chain develop-

According to the China-Africa Business Council report, China has been Africa's largest trading partner for the past 13 years and was Africa's fourthlargest bilateral investor in 2021.

Mary Muthoni Gichohi, Kenya's ambassador to China, said China has always firmly supported Africa's development, adding that the report was of great significance to the development of Africa-China relations.

The report will help promote comprehensive Africa-China cooperation and bring more much-needed investment to the continent, she said.

Teshome Toga Chanaka, Ethiopia's ambassador to China, highlighted China's contribution to infrastructure in his country and called for more such investment.

He noted that the China-built Addis

## Drought in Africa puts children 'one disease away from catastrophe'

CHILDREN in the Horn of Africa and the Sahel could die in devastating numbers unless urgent support is provided, as severe malnutrition and the risk of water-borne disease collide, warned UNICEF on Tuesday.

"History shows that when high levels of severe acute malnutrition in children combine with deadly outbreaks of dis-

The number of drought-hit people in Ethiopia, Kenya and Somalia without reliable access to safe water jumped from 9.5 million in February to 16.2 million in July, putting children and their families in increased danger of contracting illnesses like cholera and diarrhea, said UNICEF.

high to extremely high levels of water vulnerability in Burkina Faso, Chad, Mali, Niger and Nigeria as drought, conflict and insecurity are driving water insecurity, it said.

More than 2.8 million children in the Horn of Africa and the Sahel are already suffering from severe acute malnutrition, which means they are up to 11 times more at risk of dying from

water-borne diseases than wellnourished children, it said. In Somalia, outbreaks of acute

# Twenty-five years since Paris death, Princess Diana still captivates

A QUARTER of a century after her death at the age of just 36, Princess Diana remains a source of fascination to people around the world and her fate still casts a shadow over the British roy-

Diana was killed on Aug 31, 1997, when the limousine carrying her and her lover Dodi al-Fayed crashed in the Pont de L'Alma tunnel in Paris as it sped away from chasing paparazzi photographers on motorbikes.

Her death plunged the monarchy into crisis, coming after the highly public disintegration of her marriage to heir Prince Charles with its revelations of feuding, adultery, and the misery she had felt in her royal role.

Millions globally mourned the "people's princess", as the then British Prime Minister Tony Blair described Diana, who was one the world's most recognised and photographed woman.

Twenty-five years on, her allure shows little sign of faltering.

There has been "Spencer", a movie about the tumultuous end of Charles and Diana's marriage; "The Princess", a documentary by Oscar-nominated director Ed Perkins; while the hit Netflix drama "The Crown" has focused on Diana in its recent series.

There have been books, countless newspaper articles, numerous TV programmes, recriminations over a controversial 1995 interview she gave to the BBC, and even "Diana, The Musical", a much panned and shortlived Broadway

still documentaries being made about her, stories written about her, people are still intrigued by this woman," said author Andrew Morton, whose 1992 biography first exposed the deep divisions in her marriage and with whom she secretly cooperated.

"She just had a charisma, she had an appeal which went beyond her royal moniker - it was of an extraordinary human being," Morton told Reuters.

#### **Ominipresent**

For the royals themselves, Diana is still omnipresent, not least for her two sons, Princes William, 40, and Harry, 37, who have spoken of the trauma her death caused, and how it affected their mental health for years afterwards.

They were just 15 and 12 when they walked slowly behind their mother's coffin, past a throng of mourners, through the streets of London to her funeral.

"Every day, we wish she were still with us," William said when the two brothers unveiled a statue in her honour last year at Kensington Palace in central London, her former home."I feel her presence in almost everything that I do now," Prince Harry told a US television interview in

Prince Charles has slowly emerged from the shadow cast by his ex-wife's death, and has now been married for 17 years to Camilla, the woman Diana held responsible for their relationship failing. But, polls show the issue lingers with some.

### Why the interest still?

So why does Diana and her death generate such interest?

"I think the only other moment in my life that I really feel like time just stopped was 9/11," filmmaker Perkins told Reuters. "Diana's death really was a moment where the whole world just seemed to be focused on this singular event."

He was 11 at the time, and remembers the collective outpouring of emotion and the unprecedented scenes of mourning.

"We as humans have been telling ourselves variations of the fairytale myth for thousands and thousands of years. And suddenly this real life fairytale sort of came into being," he said.

"And this marriage, this fairytale romance, came onto the public stage and gave a lot of people a beacon of hope, something that they really bought into and wanted to work. And I think a lot of people became emotionally invested in wanting that story to work."

In his 2010 biography, Blair wrote that his famous description of the "people's princess" now seemed "corny" and "over the top", but said it was how Diana saw herself and should be remembered.

"Was Diana, the queen of people's hearts? Just look at the evidence," Morton said. "The mountains of flowers, the fact that people mourned her loss probably in some ways greater than their own members of their own family."

Russian ambassador hopes Japan will help stop Ukraine's attacks against Zaporozhye NPP

RUSSIA'S ambassador to Japan, Mikhail Galuzin, hopes that the Japanese government will do everything in its powers to put an end to the Ukrainian military's attacks against the Zaporozhye NPP.

"We hope that the government of Japan, the only country in the world that has suffered from nuclear weapons, and it should be remembered, American ones, will do everything possible for the sake of ending the Ukrainian army's attacks on the Zaporozhye nuclear power plant and preventing a catastrophe looming over Europe today," Galuzin said in messages posted his behalf on the Russian embassy's pages in social networks on Wednesday.

Galuzin (pictured) rejected accusations by Japanese officials Russia was involved in the aggravation of the situation at the nuclear power plant.

"We are obliged to stress that the Zaporozhye nuclear power plant is being shelled by the Ukrainian army, and not by our country. Russia presented exhaustive evidence to this effect at a meeting of the UN Security Council on August 23," Galuzin added.

The Zaporozhye nuclear power plant in Energodar is controlled by Russian troops. Over the past few days, Ukrainian forces have delivered several strikes on the NPP's premises, using, among other things, drones, heavy artillery and multiple-launch rocket systems.

The majority of attacks have been deflected by air defense systems. however, shells hit some infrastructure facilities and the vicinity of a nuclear waste storage facility.

On August 19, IAEA Director-General Rafael Grossi announced that active negotiations were underway on sending the agency's mission to the ZNPP.



## China's 'king of forages' paves way to prosperity for Mauritanian herdsmen

"THANKS to the 'king of forages' from China, livestock now have enough food to eat and the environment is getting better," said Abdu, a herdsman from Al-Idiny, a village 60 kilometers away from Nouakchott, the capital of Mauritania.

Lying in the outer peripheral area of the Sahara Desert, Al-Idiny was once a barren piece of land covered by sands, Abdu told People's Daily. The "king of pastures" he said


is Medicago sativa, also known as lucerne. It was introduced to the African country by Chinese animal husbandry experts. As an herbaceous plant in the legume family Fabaceae, lucerne is excellent for fattening livestock.

According to local customs, when a man asks for permission to marry a woman from the woman's family, he has to send at least 10 sheep to the family as a betrothal gift.

Abdu told People's Daily that he only kept five sheep in the past, and three of them died because there was not enough forage. The remaining two were skin and bones, he said.

It was the arrival of Chinese experts that promoted the progress of local animal husbandry. "Now I keep 10 sheep and all of them are fat. I'll be able to get married soon. I appreciate the assistance from our Chinese friends," Abdu noted.

Animal husbandry is one of the pillar industries in Mauritania. However, over 80 percent of the country's land is covered by sands and the dry season there spans as long as nine months. Rainfall is scarce and meadows are becoming deserts. Many people in Al-Idiny, including Abdu, once believed that it was

## Malaysia ex-PM Najib moves from luxurious lifestyle to lockup

KUALA LUMPUR - Former Malaysian Prime Minister Najib Razak's new prison lodgings may be less than an hour's drive from his mansion in Kuala Lumpur's affluent Bukit Tunku neighbourhood, but it is a world away from the luxury he is used to.

Najib (pictured) lost his final appeal on a 12-year jail sentence for corruption on Tuesday, and was taken under heavy security to the country's largest jailhouse in Kajang - a sprawling complex southeast of the capital that holds up to 5,000 prisoners and includes a women's facility.

First convicted in July 2020, Najib had been out on bail pending appeals. The country's top court upheld his guilty verdict over criminal breach of trust, abuse of power, and money laundering charges for illegally receiving about \$10 million from a former unit of state fund 1Malaysia Development Berhad.

The son of Malaysia's second prime minister, Najib held the premiership from 2009 to 2018, when public anger over the multi-billion dollar graft scandal at 1MDB brought elec-

Having been golf buddies with US presidents Barack Obama and Donald Trump and other world leaders, the British-educated son of Malay nobility will now count murderers and drug traffickers among his fellow inmates in Kajang. One of them, Azilah Hadri, was a member of Najib's security detail before he was convicted of murder for the 2006 killing of Mongolian model Altantuya Shaariibuu.

Azilah is currently on death row, while a fellow policeman who was convicted along with him sought sanctuary in Australia, where he remains.

In a 2019 court filing seeking to set aside his conviction, Azilah accused Najib of ordering the murder, a claim the expremier denied. The Federal Court rejected Azilah's application in 2020. The Prisons Department did not respond to an emailed request for comment on what conditions Najib will face in jail. On Facebook, it denied as fake news a post by another user saying that the prisons provided special privileges for "VIP inmates" such as televisions and air-conditioning.

Otherwise, rights groups say Malaysian prisons suffer from overcrowding, poor hygiene, and lack of medical facilities, with infectious diseases such as tuberculosis and sca-

Opposition leader Anwar Ibrahim, who spent a total of eight years incarcerated at another Malaysian prison, has said he experienced inhumane and degrading conditions, including being served rotten fish "all the time", according to media reports.

However, Najib's former deputy prime minister, Ahmad



Zahid Hamidi, told parliament in 2016 that Anwar obtained privileges based on medical advice, including a customized hospital bed, a desk, hot showers, and a special diet. Anwar was also given access to the prison library, received regular visitors, and was allowed to leave for hospital treatments and to attend trial, according to Ahmad

Anwar was jailed twice on corruption and sodomy charges, which he maintains were politically motivated. He was pardoned by the king and released days after Najib's election defeat in 2018.

## More cases

The only times that Najib is likely to leave Kajang, are when he is escorted to court to attend hearings in four other cases related to corruption at 1MDB and other government agencies.

US and Malaysian authorities say over \$4.5 billion was stolen.

Malaysian investigators say they traced more than \$1 billion to Najib's bank accounts, but he has steadfastly denied any wrongdoing and pleaded not guilty to all charges.

The opulent lifestyle of Najib and his family came to light with the discovery of about \$275 million worth of cash, jewellery, and other luxury goods in residences used by Najib and his fam-

# Seeing Mbwana Samatta at Aston Villa via Dejan Georgijevic, but at Simba SC

ERBIAN striker Dejan Georgijevi (aged 28) has become an instant celebrity at Simba SC almost from the moment he was on the

Technically he is a replacement for Congolese Chris Mugalu at either the center-forward position or in a pattern of the play directed by the coach.

The first day he was on the pitch he did not score despite that his very mention excited the fans, seemingly recruited by the new coach also of that part of Europe. In the second encounter, he scored, largely sealing his acquired celebrity.

An online chronicle says that the Serbian forward has a twoyear contract with the Msimbazi Street giants, who for once appear to be taking seriously their plan to reach the semi-finals of the 2022/23 CAF Champions League.

Already there are players that the coach wants to see released, in other words, based on a feeling that they cannot be trained to come up to the standards required, which by implication is also a change of standards.

Nigerian midfielder Victor Akpan earned a promotion to Simba SC from Coastal Union, while John Bocco is a veteran player, and often, captain.

There is something about Dejan Georgijevic that reminds some of us of the way Tanzanian Mbwana Samatta arrived at Aston Villa and instantly the club became a household name in Dar es Salaam and elsewhere.

It was in a sense a mixture of the novelty of playing at an England Premier League side, that had not occurred before, meanwhile, for our next-door neighbours it is commonplace, virtually like playing anywhere else. About West Africa, they scarcely notice but much-vaunted signings.

It is unclear how far the new coach instilled an impression of plenty to be expected from



the striker, or it was partially in a training field that such hopes were to an extent cultivated.

Still, it cannot be from such sources that instant celebrity status is cultivated but the mere fact of being present, just like Samatta, that no other player from the European circuit has been recruited in our premier league.

It is also a sort of elevation of the league itself when its recruiting

reach is longer and more selective. At the time that he joined Aston Villa, Samatta had registered phenomenal success at KRC Genk, even enabling the side to reach the UEFA Champions League for the first time, and in his first half-season, taking the side to the Europa League.

The fans expected that he would do much the same thing at the England Premier League club, whereas those who signed him were under no such illusion.

He was a standby player purchased at something like 8.5m pounds which is fairly low in that

This valuation back in 2020 has by now come down considerably, where the transfer market valuation is pegged at around \$3m, substantial amounts for league circuits outside the England Premier League.

As Samatta was departing, strategic signing Oliver Watkins fetched \$25m from Brentford, a record that can be compared to the Serbian striker.

Georgijevic comes to a club whose total budget in a year, that is, the cash it has on the transfer market is put at \$5.3m, peanuts by England Premier League stan- Drogba. All that was misplaced. dards. His transfer price from the

Serbian club was not given.

That is why the celebrity status of the Serbian player, despite the initial promise, is an illustration of the lowly level of our premier league by international standards, where sensational players on this side can hardly play in an advanced league.

Samatta has been a success in Belgium as its best professionals play in richer premier league circuits in Europe, so the Serbian player can succeed here in like manner as Samatta did in Belgium.

Comparison can also be made with Burkina Faso's Stephane Aziz Ki who could not make an impression in Cyprus (unlike Samatta) but he is a star in the Ivory Coast. Tanzanian Simon Msuva failed in Greece but succeeded in Morocco.

The funny side of the matter is less the soccer expectations where local fans had profoundly misplaced projections for Samatta in his Aston Villa arrival, thinking his KRC Genk exploits could be duplicated at Aston Villa.

It is unlikely that the Serbian striker just wishes for a tropical experience of the game but rather that the coach saw he was a good enough player for his CAF Champions League semi-finals negotiating format with his new employ-

Assuming that the coach's attitude - and even the last encounter where he scored - are good indications of his abilities - it would follow that he is better than Bocco, or club marksman Clatous Chama must struggle to equal him, based on preliminary indications.

There is every reason to believe that this time the fans' expectations of a rather strange new player, a European for that matter, will be realized whereas the local fans woefully failed to raise the right expectations about Samatta at Aston Villa.

## Real Madrid and rivals await Champions League draw in Istanbul

TITLE holders Real Madrid and the rest of Europe's elite clubs will be able to start plotting their route to Champions League glory when the draw for this season's group stage is made in Istanbul today from 1600

All going to plan, the journey will end back in the Turkish city on June 10 next year for the final at the Ataturk Olympic Stadium, the same venue where Liverpool defeated AC Milan on penalties in 2005.

Istanbul was supposed to host the final in 2020 and again in 2021, but on each occasion UEFA moved the game to Portugal due to pandemic-related restrictions.

Another late change was required last season, with Saint-Petersburg being stripped of the final after Russia invaded Ukraine, and Paris instead stepping in to host Madrid's 1-0 victory over Liverpool.

The Spanish giants have now been crowned kings of Europe 14 times, twice as many times as the competition's next most successful club, AC Milan, and they started this season by defeating Europa League winners Eintracht Frankfurt in Helsinki to lift the UEFA

"The joy and satisfaction you get after such wins tends to stick around, making you feel like no one should ever take your place. And that's a pretty strong motivation to keep winning," coach Carlo Ancelotti told UEFA.com in a recent interview when asked about the chances of a repeat triumph for his side.

As for the draw itself, Real are in Pot One along with the champions of Europe's other leading leagues in the shape of City, Bayern Munich, Milan, Paris Saint-Germain, Porto and Ajax, as well as Europa League win-

Liverpool will be in Pot Two, meaning there is a possibility that they could get a rematch with Real. Chelsea, winners in 2021, and Tottenham Hotspur are the other English representatives.

# 'I'm concerned': Liverpool under scrutiny after slow start

HEIR foreheads nearly touching, Liverpool team-James Milner and Virgil van Dijk exchanged furious words on the field. They pointed, gesticulated, looked utterly disgusted.

Liverpool had just fallen behind for the seventh straight Premier League and, amid the bedlam inside a reawakened Old Trafford, two of the team's senior players were going after each other.

A sign that they care? Maybe.

To many people, though, that moment will be used to show all is not quite right inside Jurgen Klopp's team.

The results bear that out, too.

It's always dangerous to jump to early-season conclusions – only three rounds of games have been played, after all – but such have been the fine margins in Premier League title races in recent years that every point counts.

And Liverpool, already, have dropped seven of them after the 2-1 loss to Manchester United on Monday followed draws against Fulham and Crystal Palace.

The Premier League's crisis club for the first two weeks was United. Now, much of the scrutiny will

## Ruthless Ten Hag makes his mark to lift Man United over Liverpool

IF things work out for Erik ten Hag at Manchester United, he may well look back on Liverpool's visit to Old Trafford early in his first season as some-

thing of a pivotal moment.

course, to get his first competitive win since arriving from Ajax Amsterdam this summer and delighted to have done it against an archrival in a big game, one that a saw large group of Manchester United supporters protest the Glazers' ownership.

Instead, Monday's 2-1 victory over Liverpool also will be remembered -- perhaps just as importantly -- as the night the Dutch manager put his stamp on the squad.

In dropping Cristiano Ronaldo and Harry Maguire for arguably the biggest game of the season, Ten Hag gave notice to his players that he is in charge. After a demoralising start that briefly saw United fall to the bottom of the Premier League table, victory over Liverpool will do everything for the confidence and self-belief in a dressing room that looked at rock bottom following the 4-0 defeat to Brentford nine days earlier. But it could be the team selection that ends up having a far bigger impact.

Ten Hag spent the summer ruling with a quiet authority but picked his moment to show his teeth. You can't get much more ruthless than benching your star striker and club captain (with Bruno Fernandes instead wearing the armband) against Liverpool at home.

"I have a squad, and we have to use the squad," Ten Hag said afterward. "We play 50 or 60 games, and from game to game, we will see what team we will pick. Maguire.

I don't have to mention Maguire and Ronaldo; they are amazing players, and they will play a role in the future and the short-term future, as well.

"We have a squad and a way of play, of style, but also a game plan. You look at what's the best approach He will be relieved, of for the game. We need a squad because we have many games to cover, so we make a team out of the squad, we stick together as a squad and we achieve a lot. I'm confident about that."

It is understandable that Ten Hag would want to play down the significance of benching two of his highest-profile players for such a key game, but he will know better than anyone that it sends a strong message to his squad very early in his reign. He made his feelings clear after the defeat at Brentford, accusing his players of a lack of "hunger" and cancelling a planned day off so they could make up the distance by which they had been outrun by Thomas

Ten Hag resisted the temptation to single out those he felt were most culpable, saying only that he wished he could have made 11 substitutions at half-time. But when it came to picking his team against Liverpool, he didn't shy away from the big decisions.

He could have left out Lisandro Martinez -replaced after 45 minutes at Brentford -- pushed the Argentine defender into midfield, or switched to a back five with three centre-backs. Instead, he dropped Maguire, his captain. Already well aware of the constant noise around Ronaldo, the easy decision would have been to keep the 37-year-old in the team, but instead, he was handed a seat on the bench behind

It was telling too that when Anthony Elanga was substituted at half-time, it was Anthony Martial, rather than Ronaldo, who was sent on in his place. Ronaldo eventually came on with only four minutes left, but his introduction at the same time as that of Donny van de Beek and Aaron Wan-Bissaka was

more than an afterthought as Ten Hag tried to see out the final stages of the win.

Maguire, meanwhile, barely even warmed up and spent the night watching from the sidelines. He is unlikely to get back in for the trip to Southampton on Saturday, after Martinez and Raphael Varane defended with

such resilience against Mohamed Salah, Roberto Firmino and Luis Diaz.

Ronaldo won't be expecting a recall at St Mary's, either, after contributing one shot toward goal that sailed into the Stretford End. It felt pointed too that afterimportance of "leadership" on the pitch despite playing without his captain and most experienced player.

"I wanted a different approach and a different attitude, and that is what they brought on the pitch," Ten Hag added. "Be a team and have a good spirit, and that is what we saw today. It is not always about what I said. I said we have to act and not to talk a lot and make sure you are a team and battle and be brave and give each other options.

"Fernandes took the responsibility, and the captaincy encouraged him. He showed leadership with Varane. They made a huge difference. It is not just them; we need more leaders. When you want to win, you need leaders and the spirit we showed today."

Ten Hag's decisions will do nothing to dampen the speculation around Ronaldo's future, while there also have been reports of inter-

est in Maguire from Chelsea. Ronaldo could find his path back into the team further complicated if United are successful in their efforts to sign a winger -- Ajax's Antony, Chelsea's Christian Pulisic or PSV's Cody Gakpo among ward Ten Hag stressed the those reportedly considered -- before the transfer deadline, although Ten Hag maintains the Portugal forward remains part of his plans.

Whether Ronaldo wants to be part of those plans remains up for debate, but if nothing else, Ten Hag has shown that it's Ronaldo who will have to adapt to his manager and not the other way around. United fans have believed for a while that there has been a lack of accountability among the players, that they have regularly been able to turn in miserable performances over the past 18 months without seeing consequences when the team was announced for the next game.

For now, at least, the cycle has been broken, and while Ten Hag has eased some of the pressure on himself, he also has made sure his players are reminded there is plenty of pressure on their places.

The Petrofuel DC Caravans Cup is an annual T20 Cricket Competition hosted by the Caravans Cricket Club. Petrofuel Limited is the title



squad to victory over Uganda. He said that all players have shown the spirit to fight while insisting on playing patriotically in the game against Uganda which will decide the fate of Taifa Stars in this year's continental prize.

"Each player has a great desire to do well, the preparations are going well and all players arrived at the camp on time, the coach continues to give them good training to ensure that we win in that important game," Haroub noted.

Coach Poulsen said that the remaining time does not give his team a chance to play any friendly game, but he will use it to prepare various methods to achieve what is intended in the first round's first leg tie before the second leg that will be played in Uganda next week.

"For us to continue to hope to play CHAN we must win against Uganda. We have a few days of preparation, which are not enough to give us a friendly game but we will use them well to make sure we are better," the Danish coach noted.

This will be the third time both nations clash in the qualifiers, with either winning once.

Tanzania beat Uganda 3-1 in the qualifiers for the 2009 edition and the Cranes paid back by eliminating Taifa Stars with a 4-1 victory for the 2014 edition.

Uganda has played in all but the first edition (2009) since the inception of the competition.
