EADS of State and government as well as various multilateral agencies have sent condolences messages to Tanzania, in the wake of the devastating Hanang flash floods and mudslides where 63 people died and hundreds were injured or left

The messages had a uniform tone of solidarity, underlining that it was time for global action against climate change.

CLIMATE advisory services and early warning systems will be strengthened by applying new reporting frameworks, policies and technologies, the government has declared.

Dr Selemani Iafo, the Union and Envi-

ronment state minister in the Vice President's Office (VPO) said this yesterday at the high-level roundtable ministerial forum at the global conference on climate change, saying the measures will ease mitigation and adaptation to its devastat-

He told the roundtable exploring the

situation of implementation of early warning for all in its Africa Action Plan, as part of networking issues for COP28 in Dubai, United Arab Emirates.

Citing his remarks, VPO said in a statement the government is working to reduce the effects of disasters by improving the well-being of the people and stability of their economic activities.

This is part of the national development strategy as disasters affect development plans and goals envisaged, thus it is important to prepare through early warning systems that can significantly re-TURN TO PAGE 2

330 new health, education jobs

UPWARDS of 330 new public service positions will be allocated to people with dis-

abilities (PWDs), the government has stated. Patrobas Katambi, the Youth, Employment and the Disabled state minister in the Prime Minister's Office (PMO) made this affirmation at a workshop for Persons with Disabilities here yesterday, held under the auspices of the World Health Organisation (WHO) and coordinated by the Tanzania Federation of Disabled People's Organisa-

The 330 positions are part of the 11,000 new jobs to be set out soon by the government chiefly in education and health spheres, as part of efforts to empower those living with disabilities, he said.

Current government policy is to set aside three percent of new employment offers in the public service to PWDs, he said, noting that workshop was organised due to the need to create awareness about disabilities and promote inclusivity.

The federation worked with WHO organised the recent workshop for PWDs ahead of the International Day of Persons with Disabilities marked annually on December 2.

The workshop stood as testament to determination and resilience of individuals to rise above their challenges, a rallying point to raise awareness, cultivate understanding and work towards a society that embraces and empowers all its members, he stated.

Prime Minister Kassim Majaliwa has meanwhile appealed for humanitarian support from individuals and institutions to quicken the provision of support to victims of the mudflow and heavy rainfall in Katesh town and nearby villages in Hanang District.

He made this appeal in a public meeting on Monday, explaining to residents in Katesh town and surrounding areas that his office will coordinate the provision of assistance.

He asked Manyara residents wishing to provide support to mudflow victims to hand their contributions to the office of the district commissioner and those from further afield, send assistance to the regional commissioner's office.

He cautioned against ad hoc groups of support from Good Samaritans, intimating that stern measures will be taken against anyone misusing the donated items.

A Good Samaritan from Mbeya Region has volunteered a caterpillar to help in removing the mud spread, he affirmed, asking for close coordination between agencies under PMO and the three regions, Arusha, Dodoma and Singida.

This would save lives and property, in which case the government has prepared a national strategy to cope with climate change (2021-2026) with a national contribution in the United Nations national determined contribution, to stem emissions of noxious gases, he said.

He referred to the Tanzania Climate Authority Act No. 2 of 2019, reinforcing the work of the Tanzania Meteorological Authority to provide early warning services, elaborating that the government initiated the national weather service system.

It was launched in August 2018 in hance readiness ahead of the rains. to be completed. secretariat, the statement added.

conjunction with installing seven weather radars, amplifying the data from three weather radars, plus initiating a degree programme at the University of Dar es Salaam on weather and climate change, he stated

The government also moved to strengthen the development of human resources in that field, especially for employees of the Tanzania Meteorological Authority (TMA), he said.

TMA weather information helped the various decision making levers and the relevant stakeholders to prepare the national emergency plan for expected El Nino rains back in August, contributing to enhance readiness ahead of the rains. TMA provides accurate weather forecasts by up to more than 86 percent, he said, affirming that 14.5 percent of TMA staff have exposed to alert programmes in local and foreign raining institutions.

He urged that the climate change adaptation fund (operating under the United Nations Development Programme -UNDP) complete the second accreditation for the National Environment Management Council (NEMC).

In discussions with fund director Mikko Ollikainen, he said that NEMC, which is in charge of the fund's finances in Tanzania, has worked on the certification process for two years, so the process need to be completed.

He similarly urged speed in reviewing the annual reports of ongoing projects, as their approval enables funds for the following year to be released, the statement noted, affirming that the minister's discussions were immensely beneficial.

The fund secretariat has promised to work on those issues, with some of them having started to be addressed shortly after the meeting, it said, with the minister remarking that institutions applying for registration in the fund will be regarded favourably as registration enables access to benefit from its resources.

Top NEMC officials attended the minister's discussions with the fund secretariat, the statement added.

Emirates ships make first direct transit from China

evening at a reception for Emirates Shipping Lines (ESL), starting direct trips from China to Dar es Salaam port.

The government is committed to improving port infrastructures, he said, noting that arrival of the ships is an indication of positive results being witnessed after port infrastructure was improved, he said.

The new ship taking a direct trip from China would largely reduce the cost of transportation as containers, he said, asking the Tanzania Ports Authority (TPA) to ensure quality services in ports across the country

Mrisho Mrisho, the TPA director general, said that major improvements at Dar port involved construction of berths, to enhance han-

dling of cargos at one time.

He assured the deputy minister

that TPA will put to use available equipment to ensure services are efficient, citing end of year port pressures.

Captain Nithin Nath, the ESL regional executive director, said the launch of the direct transit shipping services will reduce the cargo transportation time from 45 days to 22 days.

Reduced transportation cost would impact the prices of various commodities, he said, noting that ESL has plans to transport containers from China to the ports of Tanga, Mtwara and Zanzibar.

When ESL ships made journeys for the first time they were able to unload and load about 600 containers, all within 48 hours.

TPA needs to ensure that quality services are provided to all ships served at the port to attracting more shippers to use the port, he added.

This is why the role of technology in health care financing cannot be overstated."

Dr Heri Marwa, country director for PharmAccess said that policy makers need to use research findings because research studies play a pivotal role in the leapfrog to development.

US embassy new partnership with WiLDAF to eliminate FGM

THE United Embassy in Dar es Salaam has announced a new partnership with Women in Law and Development in Africa (WiLDAF) for implementation of interventions to eliminate Female Genital Mutilation (FGM).

Through the Africa Regional Development Fund (ARDF), the embassy will support WiLDAF's 18-month project called 'Achieving Zero FGM in Mara-Jamii Imara' to be implemented in Mara Region.

The project seeks to contribute to accelerate elimination of FGM in Tanzania as outlined in the National Anti-FGM Strategy. Jamii Imara will be implemented in three Mara districts-Tarime, Butiama, and Serengeti.

A statement issued yesterday by the US Embassy said the Jamii Imara's goal is to accelerate social and gender norms transformation to eliminate FGM.

The project will work with groups of women and girls to empower them on their rights to safety and bodily autonomy.

For women and out-of-school

girls, the project includes an economic empowerment component to provide alternative sources of income, build financial resilience and reduce vulnerability to FGM and other forms of GBV.

Jamii Imara will also work with male youth, religious and traditional leaders to become champions of change and lead social transformation initiatives at the grassroot levels. At the institutional level, Jamii Imara seeks to support building of strong networks of civil society and government for mutual learning, sharing experiences, collaboration and strengthening collective actions to end FGM in all its forms, including crossborder practices.

Arusha

AS Tanzania hosts the annual global scientific conference in Arusha Region, the issue of coexistence between human and wildlife will most likely be on top of the agenda throughout the three days of the event.

The Arusha-based Tanzania Wildlife Research Institute is organising the event and according to a statement from TAWIRI, 'Human-Wildlife Coexistence for biodiversity conservation and socio-economic development,' is the guiding theme for the 14th scientific conference.

Human-wildlife coexistence issues top agenda as world gather in Arusha for scientific meet

Tanzania will be tackling the issue of wildlife corridors, many of which have been disappearing Africa due to invasion of unplanned human activities and settlements.

The conference which has brought hundreds of scientists, researchers, environmentalists and conservators from around the globe kicks off at the Arusha International Conference Centre (AICC) on Wednesday, December 6, 2023 and will be taking place for three days until Friday, December 8.

Some of the main topics during Tourism development by Prof. the conference include Human and wildlife coexistence with in the country as well as around biodiversity as the basis for a sustainable future being presented by Professor Veldhuis M. Paul.

Dr Paul is an Assistant Professor on fundamental principles in the organisation of ecosystems at the Institute of Environmental Sciences, Leiden Public University of Netherlands.

There will also be a topic on Innovation and Technology for Conservation and Sustainable

Wineaster Anderson, the deputy Vice Chancellor of the University of Dodoma responsible for planning, finance and administration.

The chief development and coordination officer and the director of research at the Tanzania Wildlife Research Institute, Dr Julius Keyyu will be addressing the issue of Wildlife corridors, their current Status, threats and implications for sustainable biodiversity conservation and community livelihood in Tanzania.

As it happens, Tanzania is currently working to restore the country's wildlife corridors and so far about 61 such natural connectivity passages have been reinstated.

The other sub-themes of the TAWIRI Scientific Conference 2023 Human-Wildlife Conflicts comprise emerging technologies for wildlife conservation; tourism development and diversifications for social-economic development; wildlife ecology and ecological interactions.

Scientists are also discussing monitoring of wildlife population and threatened species; ecosystem health and wildlife diseases; water resources and wetland conservation; climate change and - ecological resilience; bee ecology, beekeeping and Api-tourism development as well as vegetation ecology, invasive species and habitat conservation. TAWIRI scientific conferences

usually take place every year in Arusha during the months of December. This year, individual researchers, Non-Governmental civil organisations, society government organisations, institutions, local government authorities are also participating.

THE Drug Control and Enforcement Authority (DCEA) has provided education to over 150 drug addicts in Arusha Region, calling upon them to stop using drugs to enjoy a healthier life.

The training is part of DCEA education programmes currently conducted at different places countrywide. In Arusha, the training was held at the Arusha Technical College (ATC).

DCEA senior official in northern zone, Shaban Miraji said the trainings are provided as part of efforts to control drug usage among youth. He urged drug addicts to change their behaviours, insisting continued use of the drugs exposes them to a number of health risks.

"We have started with regions in the northern zone-Arusha, Kilimanjaro, Tanga and Manyara because there are many youth using drugs especially khat and cannabis," he said.

Miraji noted that between September and November, 2023, the authority has seized more than 237 sacks of dried cannabis as well as 210

were seized in special operation conducted in northern zone regions.

"The authority has succeeded to provide education to various community groups including university and college students. We have also reached primary and secondary schools aiming to ensure no more youth engages with drug abuse," he added.

He said DCEA has also discovered that there are some drug addicts who have yet started Methadone medication, adding the government is taking measures to ensure treatment services are selected centers in each of the regions. He said so far the treatment centres are in Arusha and Tanga regions.

Miraji added: "There are 16 medication centers for drug addicts in the country and more than 53 sober houses. Northern regions have 24 sober houses."

Masasi education officer found dead in Tanzania Union Office

In an unsettling incident that has shaken the Masasi District in Mtwara Region, a 46-yearold education officer, Angelus Mwinyuku, has been found dead in the offices of the Teachers' Union (CWT). Mwinyuku allegedly took his life by hanging on December 5, 2023, as confirmed by Mtwara Regional Police Commander, ACP Nicodemus Katembo.

Mwinyuku, who served as the education coordinator for Matawale Ward, was discovered in the office bathroom, with a manila rope tied around his neck connected to the window. The preliminary police investigation identified asphyxiation due to hanging as the cause of death. However, the reasons behind Mwinyuku's drastic action remain elusive.

In light of this tragic event, the police have urged the public to maintain vigilance and encouraged individuals grappling with personal struggles to seek help. The incident serves as a stark reminder of the importance of mental health assistance and support in times of crisis.

As news of Mwinyuku's death spread, shock and sorrow reverberated among his colleagues. Remembered as a cooperative and friendly individual, Mwinyuku was

known to have been suffering from ill-health recently, reportedly consuming medication for malaria. He also held the position of treasurer for the CWT in Masasi and was seen attending church on the day of the incident.

In the face of this disconcerting event, it is critical to remember Mwinyuku for his contributions to education and the community, even as authorities continue to probe into the circumstances surrounding his untimely death.

Confirming the incident, Mtwara Regional Police Commander, Nikodemus Katembo said that it occurred yesterday in Masasi District at around 12 noon. He said that his fellow workers found his body hanging in one of the toilets at the TTU office in Wapiwapi Street.

Katembo said: "We are yet to establish why he decided to hang himself; we are investigating the matter and will issue a statement after our investigation officers complete their work."

Doctor in-charge at Mkomaindo hospital in Masasi District, Salumu Gembe said he received the deceased's body early yesterday.

TTU chairman in Msasi District, Thabiti Thabiti said they are mourners the late Mwinyuku, adding that the office is collaborating with his family for funeral arrangements.

"Article 9 of the Constitution explains that the country's authorities and all its agencies are responsible for directing all its policies and activities in order to ensure that human dignity is protected and maintained in compliance with the principles of the World Declaration on Human Rights," Dr Chana detailed.

She said the government will continue to implement various strategies and programs to help negate and erode all forms of embezzlement and corruption in public and private sectors.

She challenged the public servants to execute their daily responsibilities while embracing the spirit of patriotism and do away with all forms of corruption.

IFAD unveils financing mechanism to support smallholder food producers

THE United Nations International Fund for Agricultural Development (IFAD) and partners have unveiled a new financing mechanism to beef up support to small-scale food producers in rural communities in Kenya, Rwanda, Tanzania and Uganda to adapt to a changing climate.

This follows the recently released data indicating that there is a sharp global decline in climate finance dedicated to adaptation efforts.

The Africa Rural Climate Adaptation Finance Mechanism (ARCAFIM) is a large-scale model of tailored finance for poor smallscale food producers and rural microenterprises. Small and medium-sized rural agribusinesses will also access concessional loans through this new scheme. The mechanism is scalable and can be replicated in other countries and regions.

"We need to invest at speed and scale to ensure rural populations, including rural small scale food producers, are able to adapt to climate impacts now," said Alvaro Lario, President of IFAD, at ARCAFIM'S launch event at the climate change conference (COP

'New investment law will turn the Isles into the world centre for investments'

ZANZIBAR minister for Labour, Economy and Investments, Mudrik Ramadhan Soraga said the new investment law will turn the Isles into the world centre for investments.

Soraga made the remarks yesterday when tabling proposals for amendment of the Zanzibar Investment Act in the House of Representatives.

He said the new law would reduce bureaucracy thus allowing potential investors to complete the required procedures within a short period. He said the government decided to amend the law to increase efficiency in dealing with investment issues as well as attracting more investors from within and outside the country.

The Minister gave an example of the Zanzibar Investment Promotion and Protection Act, saying it has not mentioned oil and gas as well as the blue economy among the sectors that requires investors.

He said the previous law also did not mention the small islands within Pemba and Unguja which the government is now calling for investors to develop them.

"The new investment law has come with many things that are in line with our investment policy and strategies outlined by Zanzibar President, Dr Hussein Ali Mwiny. It will reduce bureaucracy thus allowing completion of all the procedures on time," he added.

Deputy Minister of State-President's Office (Finance and Planning) Ali Suleiman Ameir, said

the new investment law is in line with the existing investment laws in other countries such as Ghana and Ethiopia.

Contributing to the bill, some members of the House of Representatives praised the government for coming up with the amendments which will simplify investment procedures.

A Representative of Dimani Constituency, Mwanasha Khamis Juma, wanted the new investment law to bring major reforms as well as provide employment opportunities to locals.

Zanzibar Minister for Tourism and Antiquities, Simai Mohamed Said, said that the changes will enable people to rent the small islands in Unguja and Pemba for investment activities that will generate jobs.

Uplift building modern residential houses to formal estate businesses

struck between the Housing **C**orporation (ZHC) and CRDB Bank Ltd, a leading commercial bank, to enable clients of the housing enterprise to obtain loans to purchase houses or housing space in projects that ZHC is operating in Zanzibar. A tripartite arrangement involving a state construction body, clients and a commercial bank offers greater security than if the bank had to deal with one client at a time, and at times court battles for possession of collateral. It is thus a model that will be copied, depending on how inspiring it turns out to be.

A senior ZHC official said past loan arrangements did not work, implying a situation where the corporation hands houses to clients and expects that they remit rental or other repayment sums on time, and predictably it can be tiresome to follow up on such schedules. In addition, as a state body in an environment where building modern houses is culturally an aspect of government duties, repayment might not be high on the agenda for beneficiaries of such houses. Bringing in a middleman, a bank to act as the deliverer of the loan arrangement, is different.

The bank on its part is seeking usable opportunities for private loan arrangements of up to one billion shillings per client if the business is bankable, and usually real estate is an assured channel as land is always rising in value. Real estate may temporarily lose capital to higher yield investments depending on the business cycle, but finally the value of land, and even of real estate, stands the pressures of time. Populations rise rather than decline, and people

GREEMENT has been look for better environments to live, so making a loss on real estate is a temporary experience by and large.

> Yet to limit this arrangement to a welfare aspect might not cover the breadth of institutional significance of a modern housing sector in Zanzibar especially, now that it is setting up its stock exchange. A stock market needs to add land values for it to work optimally, nut just industrial or commercial values. Because when there is a depression of sorts in industrial or service values, money shifts to land values, and then drifts back to industry or services when things are much better. This is the case even when land isn't on the stock market, for instance the depression in services for half a decade in the Mainland led to fast modernization of frame space.

> There is now more business space being put up in Dar es Salaam and presumably elsewhere, as lower circulation of easy money uplifts investment strategies. So far the consumption levels of the earlier years have not returned, to business space investments are dominant. Earlier it was hotel and accommodation preferences.

> Adding real estate business into stock market activity needs broader policy changes where those who occupy the land are facilitated to actually own it, in which case they can sell to rich people, especially from the Mainland and northward Diaspora. The key is to change old references focusing on ethnic groups to one directed at business opportunity, in which case the state corporation and any other major land dealer register on the new exchange, and land firms engage in land purchases, which gives capital for land occupants to do business; renting, building elsewhere.

companies in the city of Dar es Salaam have joined up to collect upwards of 240m/- to assist in current efforts to find shelter and some other assistance for victims of the torrential rains touching off massive mudflows in Hanang District, Manyara Region.

As it is always the case, resilience is what defines the spirit of life, so in the worst of circumstances people do with what they have and go out to look for opportunities.

TELECOMMUNICATIONS The chaos there is also a chance for paid labour to clear the streets of vast scatter of rocks, plant remains or household objects that were swept into the mud and left on the wayside as the flow thinned out in its pressure.

> The donations now being made are likely to be directed at obtaining tents for those rendered homeless, and then rebuilding their places by obtaining iron sheets roofing and working with others to make clay bricks more or less quickly. With community solidarity and a spate of donations for instance to get meals for those turning out to help those affected, promptly paying those clearing the streets, as well as those needed in rapidly repairing bridges or culverts, things should go back to normal quickly. It has been a shock to the public as we don't have disasters every few months, but we need to get used to shocks due to new climate patterns.

> Indeed this incident, coming amidst strong gushes of rainfall sporadic impact neighbourhoods, is a reminder that outside global frameworks of reducing the use of crude fossil fuels, the path to adaptation is acute for each country.

> It is clear that Katesh was an exposed community living on the slopes of an unpredictable mountain, not so much to spew out volcano but largely denuded of trees or any dense vegetation. This is the first lesson on where not to inhabit, as it isn't just the valleys that are at risk; unprotected hillsides can similarly be dangerously exposed. Those in similar surroundings ought to think of their habitation, and government agencies assist them to relocate, not await greater disasters before getting the point.

Nelson Mandela legacy battered by South Africa's troubles

JOHANNESBURG

OWETO'S Vilakazi Street is packed each day with tourists and hawkers outside the home of Nelson Mandela (pictured) that has been meticulously kept even as the democracy pioneer's legacy has become rundown in the decade since his death.

Ntsiki Madela, who lives nearby and sells jewellery and hats on a table near the Matchbox House Museum at number 8115, is among many South Africans who feel let down. While thankful that Mandela's 16-

year presence in the township now draws tourists, the 47-year-old said: "I haven't seen any change from Mandela's democracy and I don't even see the need to vote."

Polls suggest the scandal-tainted ANC's vote share could fall below 50 percent for the first time as Africa's biggest economy slumbers and corruption taints its image.

Unemployment is among the world's highest at 32 percent of adults and wages for those in work

Despite the end of apartheid. South Africa has the world's lowest equality ranking, according to the World Bank.

The government and state firms are carrying more than \$300 billion of debt and the figure worsens

Street crime and murders have also grown over the past decade and some days Madela and her

neighbours go without electricity for almost 12 hours a day.

"We only have enough income to feed our kids, there is constant loadshedding and the cost of living is unbearable," said Madela, referring to the chronic power cuts.

Mandela is seen around the world as a moral compass for the way he wore down white minority rule and his vision of a multi-racial South Africa.

Critics say the ANC leaders who took over quickly dropped Mandela's torch. Mandela's legacy has been "undermined" by his own party officials who are "corrupt" and have "deviated" from his "moral consciousness", independent political analyst Prince Mashele told

Nic Borain, a political analyst working in financial markets, said there was a "kind of mythology" around the Mandela years that meant anyone following would

The government and the ANC have as big a fight on their hands to tackle apathy as they do debt.

Former president Jacob Zuma, who was forced out of office over corruption allegations, only avoided prison because of his poor health and a remission approved this year by his successor, President Cyril Ramaphosa.

In June the graft watchdog cleared Ramaphosa of allegations that he breached ethics by not reporting the theft of more than \$500,000 in cash hidden in a sofa at his farm.

Down the road from Mandela's house, 27-year-old teacher Sive Jizana sat with friends at a popular pub. Mandela's legacy was "dying",

She noted the lack of running water and proper roads outside main cities. "And now we don't have

Zandile Cubeni, a 24-year-old unemployed sociology graduate, said she would not join the voters' list.," Cubeni said, adding that Mandela's legacy "has been made out to seem like something without any flaws, that's not true."

Some say Mandela's name was over-hyped.

"We don't really see what Mandela and all the others did for us... we are still poor," a 43-year-old cashier, Thobile Cele, told AFP.

"We simply don't even have a democracy anymore as long as... ANC is in power," said Leigh-Ann Mathys, a member of parliament for the leftist Economic Freedom Fighters party.

She said courts had been "captured" to operate in the ANC's favour and there are doubts about institutions like the electoral commission during the 2024 vote.

Some Mandela loyalists are trying to make the public look beyond the apartheid battler's name to map out a future direction. But Mandela's family is publicly keeping the faith.

His grandson, Mandla Mandela, an ANC lawmaker, said the party had achieved many successes and some "spectacular failures" but overall South Africa's democracy was still "healthy".

"The key evil of colonialism was that it robbed our people of their land, and this remains the litmus test for how we measure transformation," the 49-year-old said.

RESIDENT Samia Suluhu Hassan on Monday cut short her participation at the 2023 United Nations Climate Change Conference (COP23) in Dubai to attend to an unforeseen pressing issue here at home—the unprecedented mudslide in the wake of flash floods in Hanang District, Manyara Region, whose death toll was over 60 and thousands affected in one way or another.

The never-seen-before mudslide from Hanang hill caught residents unaware in the wee hours of Sunday, leaving many in shock as lifeless human bodies, livestock and parts of destroyed properties were being swept away in a steady slow motion.

A statement released by the Directorate of Presidential Communications on Monday said the Head of State instructed Prime Minister Kassim Majaliwa in whose office the Department of Disaster Management is domiciled to coordinate rescue and humanitarian efforts.

"The government will cover the treatment expenses for all injured individuals, provide permanent shelter for those who have lost their homes, and ensure that all government divisions and institutions involved in disaster management maintain their presence in the affected area and work around the clock to restore normalcy," she was quoted in the advisory.

Similarly, President Samia directed that an in-depth evaluation be conducted on the causes of the landslide to stem similar happenings in the area or similar geological areas. Public agencies need to work day and night to make sure the situation returns to normal, the statement underlined.

The initial reports indicated that 1,150 households and 5,600 people were affected and countless number of livestock swept away and a total of 750 acres of farmland destroyed. The disaster severely affected Katesh town which is the headquarters of Hanang District and the surrounding villages of Jorodom, Ganana, Dumbeta, Gendabi, Sarijandu, Arukushay and Sebasi.

The press statement released on Monday said President Samia was "shocked"

after receiving the news to the point that she could not continue with her scheduled engagements at the COP23.

The death toll, the destruction of property and the displacement really shocks. But the question is what may have caused such unusual tragedy? Floods and mudslides like the ones that devastated Hanang are closely associated with climate change.

PM Majaliwa who rushed to the area on Monday told mourners at an identification ceremony of the dead that the government was bearing the costs of burial of those who lost their lives in the unforeseen disaster.

After the tragedy, the little-known Katesh town and the affected surrounding villages were thrown into the limelight as the disaster caught the attention

of Tanzanian, regional and international media due to its peculiarity.

"Many people think climate change mainly means warmer temperatures. But temperature rise is only the beginning of the story. Because the earth is a system, where everything is connected, changes in one area can influence changes in all others, writes the United Nations. "The consequences of climate change now include, among others, intense droughts, water scarcity, severe fires, rising sea levels, flooding, melting polar ice, catastrophic storms and declining biodiversity."

The UN notes that climate action requires significant financial investments by governments and businesses, adding that climate inaction is vastly more expensive.

"One critical step is for industrialized countries to fulfill their commitment to provide \$100 billion a year to developing countries so they can adapt and move towards greener economies."

According to charity Oxfam, climate hazards are natural events in weather cycles and the world has always seen hurricanes, droughts and wildfires, flooding and high winds.

"However, we are currently witnessing a scale of destruction and devastation that is new and terrifying."

"The last year alone has seen a series of devastating climate disasters in various parts of the world such as Cyclone Idai, deadly heatwaves in India, Pakistan, and Europe, and flooding in south-east Asia. From Mozambique to Bangladesh millions of people have already lost their homes, livelihoods, and loved ones as a result of more dangerous and more frequent extreme weather events."

The charity adds that changes in the global climate exacerbate climate hazards and amplify the risk of extreme weather disasters. Increases of air and water temperatures lead to rising sea levels, supercharged storms and higher wind speeds, more intense and prolonged droughts and wildfire seasons, heavier precipitation and flooding and that the evidence is overwhelming and the results devastating:

"The number of climate-related disasters has tripled in the last 30 years. Between 2006 and 2016, the rate of global sea-level rise was 2.5 times faster than it was for almost all of the 20th century," it states.

"More than 20 million people a year are forced from their homes by climate change. The United Nations Environment Programme estimates that adapting to climate change and coping with damages will cost developing countries \$140-300 billion per year by 2030."

Hope for African women as Samia launches clean cooking drive at COP28

ORE women in Arica now hope to shift to clean energy sources in the next few years after leaders from around the world declared their commitment to provide clean cooking energy by 2032 to nearly a billion people on the continent who still cook using firewood and other forms of biomass.

The leaders rallied around the African Women Clean Cooking Support Programme (AWCCSP) launched by the President Samia Suluhu Hassan on Saturday which was a sideline event at COP28 in Dubai.

The launch was attended by South Africa's President Cyril Ramaphosa, the President of the African Development Bank Group Dr Akinwumi Adesina, 26 government representatives and international organisations including various UN agencies and philanthropists.

President Suluhu said it is unacceptable that 80 per cent of households in sub-Saharan Africa still rely on wooden biomass for cooking.

"Women and girls are disproportionately affected when there is no access to clean cooking solutions. Exposure to toxic fumes affects their health and wellbeing," she said.

The Head of State expressed hope that the programme will ensure the long hours women and girls spend fetching firewood, are spent on productive economic activities.

President Samia said cooking with wooden biomass accelerates deforestation. "This has led to the loss of 3.9 million hectares of forest between 2010 and 2020 in Africa," she said and pointed out that while access to clean cooking had increased across the world, in Africa it is the use of wooden biomass that is growing.

President Samia said the wooden biomass energy has been also lead-

ing to women and girls' health problems after a prolonged inhalation of thick fumes from firewood, saying it is from this ground the AWCCSP is designed to solve the problems pertaining to loss of biodiversity.

"We decided to launch this programme to show our own commitment to mitigations, we want to show that even though our emission levels are relatively low, we will also act and deliver," she said.

"Clean cooking energy is about mitigation, women empowerment and welfare. Women and girls bear the brunt of lack of sustainable energy cooking solutions."

She said for decades women in Africa have been using a lot of their time in gathering firewood which comes with lack of time engaging in economic production, adding that the AWCCSP will bridge the economic disparity while making Africa green.

Dr Adesina said: "300,000 women and 300,000 children die every

year due to respiratory diseases because of simply trying to cook a meal—what is taken for granted in developed economies."

He added that the global economic cost of women's hours spent fetching firewood is estimated at \$800 billion annually and the health cost for that is estimated at \$1.4 trillion annually. "The risk of women dying from a lack of clean cooking solutions is three times higher than the risk of dying from malaria."

Dr Adesina said Africa requires \$4 billion a year in investment to provide clean cooking equipment to 250 million women by 2030 and outlined how sub-Saharan Africa could achieve 100 percent access to clean cooking solutions.

"This requires that governments direct at least 5% of the current \$70 billion energy investments annually, into provision of clean cooking solutions. That would provide the close to the required \$4 billion, an-

nually. This is not too much to ask."

"Second, accessibility and affordability to clean cooking solutions should be assured through the development of liquified petroleum gas upstream capacity, especially for production, storage and distribution infrastructure."

"Third, multilateral finance institutions should set aside a significant share of their annual energy financing specifically for providing clean cooking solutions at scale. This should include concessional blended financing, as well as guarantees to de-risk lending by commercial banks and other financial institutions," said Adesina.

President Ramaphosa described his country's experience in transitioning rural communities from firewood and cow dung to coal-generated electricity and now to renewable energy "on an equitable basis".

He said even though access to electricity had increased to 93% from about 50% over the past nearly 30 years, the electricity was generated from coal, a fossil fuel. "We are beginning the transit route to cleaner energy. It is a necessary journey that addresses gender equality and poverty."

Norwegian Minister for International Development Anne Beathe Tvinnereim who pledged support for the programme and said: "It takes women to truly drive these gender-related issues."

Zimbabwe's Minister for Women Affairs, Community, Small and Medium Enterprises Development, Monica Mutsvangwa, said investing in clean cooking for women is "possible and affordable".

Dr Jean d'Arc Mujawamariya, Rwandan Minister for the Environment, representing the President of Rwanda, Paul Kagame, said: "Let us support this noble cause of supporting African women"

The UN Capital Development Fund Director and Head of Local Transformative Finance, David Jackson praised the AWCCSP saying, "This initiative will free up space in the lives of women and girls for them to be able to progress."

COP28: Taking charge against plastic pollution in India

DITI Agarwal, a brilliant computer science engineer and Gold Medalist, once thrived in the tech world, contributing to innovations at Microsoft. However, she felt a calling to address real-world challenges, particularly those related to carbon emissions and plastic pollution. In pursuit of a nobler cause, she joined a company called Go Rewise, a youth-led initiative in India dedicated to recycling PET bottles through a circular economy approach.

Agarwal's passion for environmental sustainability is palpable as she explains, "There is no better and nobler cause than reducing carbon emissions in the world today because that is the only way we are going to create a balance and survive." Her decision to "switch gears" from the corporate world to environmental activism reflects a deep commitment to making a tangible difference.

Go Rewise focuses on the staggering issue of plastic waste in India, specifically targeting the 10 million PET bottles discarded annually.

Agarwal elucidates the essence of their initiative, stating, "It means 'go recycle wisely'. We believe in circularity-any resource extracted from the earth should be in balance, in circulation as long as possible." The team's groundbreaking efforts involve technical recycling, a meticulous

process involving more than 20 steps of decontamination to ensure the recycled raw material is safe for human contact.

Agarwal's passion shines through as she describes the impact of the work: "For the first time in India, we are creating a bottle out of a bottle."

The significance lies not only in recycling but also in preventing hazardous waste from accumulating in landfills. Agarwal emphasizes the urgency of their mission.

"Imagine 10 million bottles every year going into landfills; how much space it will take, and this plastic wouldn't biodegrade in just six months or a year."

The initiative is not just about recycling; it's a holistic approach that involves collaboration with beverage companies and obtaining licenses from food regulators. "We have a license from food regulators for doing so. We are working with many beverage companies."

The strategic partnerships enable Go Rewise to intervene at various stages of the plastic lifecycle, preventing pollution and promoting sustainability.

"We collect from ragpickers, and we train them on what is PET and what is non-PET."

The initiative empowers individuals on the ground, creating awareness about different types of plastics and their impact on the environment.

Once the collected bottles reach Go Rewise, they undergo a meticulous process of segregation, washing, and drying before being put to use again.

Agarwal explains, "We wash the bottles, and the chemical properties of the polymer are regulated." This commitment to quality ensures that the recycled bottles can go through the process multiple times, contributing to a sustainable and circular economy.

AAgarwal, now serving as the Assistant Vice President overseeing marketing for Go Rewise, is a driving force behind the initiative. She attends COP28 not only to showcase the innovative solutions they are implementing but also to inspire others to think critically about their contributions to environmental sustainability.

"I am here at COP28 to inspire and get inspired," she told the Inter Press Service.

Reflecting on her journey, Agarwal emphasizes the importance of assessing solutions carefully "Activism doesn't mean discarding the solution without assessment. We want people to assess the solutions they are creating. There is a need for thoughtful and sustainable approaches that cater to the demands of billions of people on Earth."

As a computer science engineer who once excelled in the corporate world, Agarwal's story is a testament to the power of individuals to make a difference. Her decision to step away from the conventional path and delve into real-world problems echoes a broader call for a paradigm shift in how we approach environmental challenges.

Agarwal's journey with Go Rewise is a story of transformation-from a tech-driven career to a passionate advocate for environmental sustainability. Her words serve as a rallying cry for a circular economy, challenging the prevailing linear approach, which, according to her, is make-take and waste.

As she stands at COP28, Agarwal seeks not only to inspire but also to ignite a collective movement towards a future where products reenter the value chain, contributing to a healthier planet for generations to come.

AfDB's US \$1 billion insurance facility to protect millions of farmers in Africa

DUBAI

HE African Development Bank Group has presented its planned \$1 billion facility to provide insurance to more than 40 million farmers across the continent against severe impacts of climate change.

The facility was widely praised by the World Food Programme (WFP), development agencies, insurance companies and the private sector during a side event at COP28 in Dubai.

AfDB President, Akinwumi Adesina said the Africa Climate Risk Insurance Facility for Adaptation (ACRIFA) aims to mobilise \$1 billion of concessionary financing, high-risk capital and grants to support the African insurance industry.

The Facility is designed to protect farmers and countries against catastrophic weather-related events and to stimulate private sector investment in agriculture by mitigating risks.

"We have to support farmers, not abandon them, in the face of rising frequency and intensity of extreme weather events like drought, floods and pest infestation... We need to ensure that farmers and actors along the agricultural value chain are covered by insurance at scale," the Bank President said.

Adesina said over 97 percent of farmers in Africa do not have ag-

ricultural insurance. "Their only insurance is to pray... when they plant that it will rain. Pray when they harvest that there will not be rains or pest devastation and pray when they market their crops that prices will not collapse."

"The eyes of more than 40 million smallholder farmers in Africa are on us. Let us make ACRIFA the answer to their prayers," the Bank President said.

Adesina said ACRIFA "will systematically support the African insurance industry to unlock financing for investments in climate-smart and green technologies."

"It will strengthen local insurers and foster integration with national and international reinsurers," he added.

Unveiled at the Africa Climate Summit held in Nairobi in September, ACRIFA brings together governments, development agencies, the insurance sector and the private sector.

The successful roll out of the facility will depend largely on partnerships such as the World Food Programme to deliver services to clients.

"The climate crisis is affecting agricultural communities across Africa. This programme will play an important role in protecting smallholder farmers, pastoralists and small businesses from climate shocks," said Cindy McCain, Executive Director of the World Food Programme.

"We are excited about our grow-



ing partnership with the African Development Bank, which is allowing us to offer more support to governments, as they respond to the climate crisis," she added.

During the presentation, the United Nations Assistant Secretary General and Director General of the African Risk Capacity Group, Ibrahima Diong and Bogolo Kenewendo, the Special Advisor to the United Nations Climate Change High-Level Champion, said ACRIFA will boost investment and resilience in the continent's agri-food systems.

The presentation was followed by a panel discussion on how largescale deployment and use of quality. climate risk-related insurance solutions can boost Africa's food security, and open business opportuni-

was moderated by Dr Victor Oladokun the Senior Communication and Stakeholder Engagement Advisor to the Bank President.

The Head of Government Relations at the One Acre Fund Michelle Kigari said, "Insurance is absolutely critical in building resilience, meaningful resilience, for Africa's farmers," and added, "Farmers are not able to bounce back from some shocks if they don't have a safety net, and insurance helps build that safety

The Founder of Takaful Insurance Group of Africa and ACRIFA Senior Advisor Hassan Bashir urged insurance companies to consider taking on large-scale group clusters of farmers for insurance cover. "Africa

16-Days of Activism against Gender - based violence :Zanzibar grapples to address GBV

AS the international community celebrates the 16 Days of Activism against gender-based violence (GBV), the Zanzibar government has made a number of strides to address the barbaric behaviour, which deprives women and children rights.

Among the initiatives made by the Zanzibar government include the establishment of special sexual offenses court so that the GBV victims get justice on time.

The government also enacted various laws to combat such acts, including the penal law number 6 of 2018, which increased the punishment for moral offenses such as rape, prostitution, indecent assault.

It has also enacted the criminal conduct law number 7 of 2018 where section 151(1) does not allow the granting of bail to any person charged with GBV cases and increasing the sentences that the courts may pass.

Despite all these initiatives and others that were taken and continue to be taken, still such actions exist and children and women are the most affected.

Statistics from the Office of the Chief Government Statistician Zanzibar (OCGS, show that every month the incidents have been increasing, and for the October, this year, a total of 199 incidents of sexual violence have been reported, with a number of 199 victims of those incidents, where most of the victims are children at 78.9 percent, women 16.1 percent and men 5.0 percent.

The number of 199 incidents in the month of October is an increase of 26.8 percent from the 157 incidents reported in September 2023 and the incidents of rape in the month of September were 59, while in the October they have reached 89, which is an increase of 30 offenses.

Of the 199 incidents that occurred, 30.2 percent were committed by people close to the family, including neighbours who are relied upon to increase protection for chil-



dren in order to live safely without being subjected to GBV.

Khamis Ramadhan Abdalla, Zanzibar's Chief Justice says the High Court has put in place various strategies to ensure that the problem of humiliation is greatly reduced or completely eliminated from the country.

He says that one of the strategies is to create a special court for each Region as well as to appoint special judges to hear these

He also says the aim is to ensure that these matters are heard and decisions are made quickly and to ask the community to be ready to give evidence when needed in

"In fact, we've been successful in that and currently, the hearings of humiliation if the witnesses are found on time take an average of six months to finish in court from the first day of its opening," the CJ says.

However, he says in line with that due

to the court's self-imposed strategies, it has succeeded in ensuring that in the GBV courts when the accused are found guilty, they have been given severe punishment according to the law.

"Now let me just say that although this problem is not completely over, but now many members of the community have a great fear of committing such crimes due to the severe punishments given by the Court," he says.

He also says that as a result of these strategies, some areas where the problems of humiliation have been significantly reduced and the daily court statistics show that the Courts of Pemba have been receiving few GBV cases, and efforts are being taken to ensure that it reduces the speed of these crimes in these areas.

Zaina Abdallah, lawyer at the Tanzania Media Women's Association (TAMWA- Zanzibar) says according to the child law num-

ber 6 of 2011, explains that the child should be taken care of, protected by the govern-

ment, family and society. She says that the law is growing with the challenge of conflicting with the law in recognizing the age of the child as 18 years, where other laws set it at 14 years, along with recommending the existence of schools to correct the behaviour of children as recognized by the government.

The legal practitioner asks the Zanzibar government to put a special provision in the law, on conducting an inspection of the child's residence in order to satisfy him and avoid putting him in a difficult environment.

"My suggestions to the Ministry of Education and Vocational Training in Zanzibar to develop a special guide for additional training to create a good environment for the protection of children when they are in fulltime studies," she says.

Abeda Rashid Abdalla, Permanent Secretary in the Ministry of Community Development, Elders, Gender and Children, says efforts are still needed in managing children and protecting them from acts of humiliation.

She says that a child who is subjected to humiliation and cruelty needs to be given psychological education because such actions also affect them mentally and cause

Riziki Pembe Juma, the Minister for Community Development, Elders, Gender and Children says that the increase in the statistics of reported acts of humiliation indicates two things, including the community's motivation to report these incidents because in previous years these incidents were not reported.

She also says that in previous years there was no courage to report a parent who has committed acts of humiliation to his child, so now society is motivated and under-

stands the concept of humiliation. "In the past years, when these actions took place in our homes, but who dares to report it, no one dared to say that my husband is humiliating my child, there was no such behaviour. This was due to the fact that women are afraid of divorce and shame in society, but now there are women who stand up and say that my husband, who is the father of the child I gave birth to, did the act of procreating my daughter or my boy," she says.

Minister Riziki says: "This is one of the achievements that the community is motivated to report these incidents and have an understanding of the concept of humiliation because some people think that child molestation is rape and rape when there are children they face worse incidents that lead to loss of life."

She however says celebrating 16 Days of Activism helps to motivate the community to talk and take action in reporting incidents of humiliation and the government continues to administer the law.

He also says that if you compare with 10 years ago and now the statistics are on those events but the actions are still going on in the society so everyone should take responsibility to fight against those actions because those actions are done by close people.

She urged the community to cooperate together in fighting such acts with all their strength and various stakeholders cooperate with government in punishing such ac-

The minister says that these incidents of humiliation are not only for women and children; even adult men are also humiliated in society, so men do not feel ashamed in reporting such actions so that justice can be done.

The 16 Days of Activism against GBV is a key international moment to call for an end to violence against women and girls. It runs from 25th November until 10th December, Human Rights Day.

Green Climate Fund: 10 African countries to get USD 100 million

HE Green Climate Fund (GCF) has announced the release of USD 100 million at the ongoing United Nations Framework Convention on Climate Change (UNFCCC) 28th Conference of Parties (COP 28) in Dubai, UAE, to support 10 African countries in adapting food loss reduction solutions.

The funds, which will be disbursed through AGRA, will be used to enhance African smallholders' access to technologies, make food loss reduction solutions more accessible and affordable, and support the creation of enabling environments for food system transformation on the continent.

The GCF was created under the Paris Agreement and is currently the world's largest climate fund, mandated to support developing countries in raising and realizing their Nationally Determined Contributions (NDC) ambitions towards low-emissions, climateresilient pathways.

Isaiah Esipisu interviewed Dr Agnes Kalibata, the President of AGRA and a member of the COP 28 Presidency Advisory Committee.

IPS: Give a brief overview of the \$100 million GCF investment in Africa's food systems.

Kalibata: At the start of COP 28, the Green Climate Fund (GCF), AGRA, and a number of other partners announced an investment of USD 100 million in what we are calling Reducing Post-Harvest Losses in Agriculture. One of the challenges farmers in Africa have is that they produce a lot of food, but 40 percent of it goes to waste. This initiative will begin by investing in seven countries that AGRA works in to ensure that we can support farmers to reduce postharvest losses.

It is also important to note that most of the food wasted ends up producing methane from organic matter, which is a dangerous greenhouse gas. Reducing losses will therefore mean reducing such emissions.

IPS: When are farmers likely going to start benefiting from the \$100 million from the GCF?

Kalibata: Working with GCF takes some time. We need time to prepare the investments, and we also need time to make the programs and projects ready. So far, GCF has released what they call the preparatory facility for investment, which is usually the initial process.

However, it is not the only investment we work with as AGRA. There are others. But this particular investment is targeted at supporting the building of systems, strengthening the systems for better post-harvest management, and ensuring that farmers have access to the appropriate technologies.

IPS: When disbursing these funds, will AGRA work directly with governments, or will it be through communityand farmer-based organisations?

Kalibata: AGRA works in a number of ways. Where governments have the ability to work with us, we engage them. Where we have different partco-funders such as the ners to work with, we en-Rockefeller Foundation, gage them. We also work with businesses to enable the private sector's ecosystems.

> **IPS:** In your role as the advisor to the COP Presidency, do you see the money committed at **COP 28 for the Loss and Damage Fund coming** in to salvage pastoralists and smallholders in ASALs who have always

lost their livelihoods either to droughts or floods?

Kalibata: Let's begin by celebrating the fact that the Loss and Damage Fund is now active at the World Bank, and it is going to be available for countries. One of the things we are trying to push for is for this money to become accessible to those who need it. It shouldn't come in the form of expensive loans that are difficult to access. This is because we are dealing with losses and damages that have already happened.

What will be good in terms of managing the use of the Loss and Damage Fund to support the agricultural sector and food systems would be to strengthen the resilience of farmers. They need access to good-quality seeds; they need access to disease-, pest-, and droughttolerant seeds, keeping in mind that flood-tolerant varieties are already on the market.


This is also an opportunity for us to strengthen the business ecosystem that supports agriculture.

The third point is that there is so much loss happening in the system. When people lose everything, then the impact is so great. If we can only start by managing that kind of impact, then people will have enough food to eat and enough ability to recover because, with climate change, farmers even lose the seeds for the next season. Yet the most important thing for many farmers is to save seed for the next season.

IPS: Why is the African continent not food secure despite its abundance of arable land?

Kalibata: It is because the issue with Africa's food security is not about land. It is about being able to produce enough per unit area. Farmers who do not have access to good seeds cannot produce enough. Farmers with no access to appropriate fertilizers cannot produce enough. We are actually making efforts in those areas, but it is not enough.

But most importantly, there is a need for good leadership to ensure that all these things reach the smallholder farmers in good time. You have to create systems that reach out to them, and that is what AGRA is investing in.



S. African auto industry to produce first EVs in 2026



JOHANNESBURG

The Department of Trade, Industry and Competition (dtic) on December 4 released the Electric Vehicles (EV) White Paper, as well as the Green Hydrogen Commercialisation Strategy final report.

Speaking at a media briefing on the release of the documents, Trade, Industry and Competition Minister Ebrahim Patel (pictured) said the EV White Paper was the final iteration, following its approval and adoption by Cabinet last

The White Paper outlines a course to transition the country's automotive industry from primarily producing internal combustion engine (ICE) vehicles to a dual platform that includes EVs in the production and consumption mix, alongside ICE vehicles in South Africa

The White Paper was drawn up following considerable international and domestic research and consultations, spanning from 2019 to this year.

Patel averred that, following the release of the paper, South Africa's production of EVs could begin as early as 2026, as indicated by the dtic's engagements with various original-equipment manufacturers (OEMs) in finalising the paper. There is, however, one outlying OEM, which would begin production at a later stage, he said.

Patel pointed out that the White Paper was developed with the country's energy crisis in mind and was aimed at facilitating the addition of more renewable energy sources to the energy grid.

The paper sets out the policy goals and actions that will be taken to support the transition towards broader new energy vehicle (NEV) production and consumption in South Africa, with an immediate focus on EVs.

A set of six core principles underpin the policy goals and actions to be taken. Firstly, the transition to EVs and NEVs is necessary, and the pace at which key decisions are required is urgent given the speed at which markets are developing, and the long lead times for investment decisions.

Secondly, attracting investment requires a technology-agnostic approach, including embracing a range of clean energy sources to ensure an appropriate transition.

Thirdly, investment support is required to boost productive capacity, while, fourth, policy actions have to reflect cost-effective and fiscally sustainable solutions.

Fifth, deepening localisation of the

through beneficiation of critical minerals through the development of regional value chains is essential and, lastly, policy actions must reflect the need for a just transition in the automotive industry.

Patel emphasised that key to the approach was the importance of domestic production of EVs.

He highlighted a technology-agnostic stance, with the paper encompassing a variety of different technologies, ranging from battery electric vehicle (BEV) to fuel-cell technologies and sustainable fuels (also called synthetic fuels), and aiming to position the country as a production destination for vehicles and components in emerging technologies.

He also emphasised the commitment to public measures including fiscal support.

The use of Just Energy Transition Investment Plan (JET-IP) funding will complement yearly budget appropriations and announcements in the National Budget next vear.

Following publication of the White Paper, the government will make the first announcements of resource allocations in the February 2024 Budget.

The White Paper highlights the considerable industrialisation opportunity for South Africa and the region to develop regional 'critical minerals to batteries' value chains.

It outlines that capitalising on this would require a regional approach to critical mineral beneficiation.

It therefore aims to establish a framework under which African countries can work with partner countries to develop the industrial capacity necessary to make the continent a key industrial player, rather than just a source of critical minerals, in the transition to EVs.

The White Paper outlines a twopronged strategy approach, with the first focus area being considerable investments in component production and vehicle assembly for EVs, particularly for markets affected by regulatory changes that will require net-zero emission vehicles.

It also includes investment in local production and standardisation of charging infrastructure.

The second focus area is characterised by a balanced market development approach, including increasing grid capacity to support domestic EV uptake, public procurement of domestically produced EVs, exploring appropriate incentives for EV uptake by consumers of domestically produced vehicles, promoting benefits of EVs to consumers and using the African Continental Free automotive supply chain, including Trade Area to expand demand for EVs

BoT to mop up 6bn/- from the markets though T-bills auction

he Bank of Tanzania (BoT) is seeking to wipe 6bn/- from the financial markets through Treasury bills, which are expected to be auctioned today.

The T-bills auction tender announcement shows that the central bank, on behalf of the government, is expected to raise 78.89bn/-, of which 72.89bn/- will be allocated for government financing purposes.

The move is part of the implementation of less accommodative monetary policy aimed at maintaining the liquidity, curb inflation as well as attaining the Extended Credit Facility (ECF) program targets.

Last month, the central bank also planned to mop up 180bn/- from the market through two Treasury Bills auctions, conducted on 8th and 22nd Novem-

Bank of Tanzania, Dar es Salaam office

During the first auction conducted on 8th November, the central bank targeted to raise 142.17bn/for both liquidity and financing purposes, but only 225.3bn/- were tendered, which translated into under subscription 152.37bn/-.

During the second auction held on 22nd November, the central bank also targeted to raise152.37bn/for both purposes, but at the end of the auction, only 90.4bn/- were ten-

The monetary targets

for the first half of 2023/24 include maintaining the growth of reserve money of 10.1 percent, growth of extended broad money of 10.1 percent, and private sector credit growth of

16.4 percent.

In its statement at the end of October, the Monetary Policy Committee (MPC) of the central bank noted that the implementation of the less accommodative monetary policy successfully maintained liquidity in the economy at appropriate levels in August, September, and Octo-

This, combined with supportive fiscal and structural policies, contained inflationary pressures, facilitated economic activities, and preserved the stability of the financial sector amidst challenges in the global economic environment, the statement said.

According to the MPS, Money supply (M3) grew at around 17.7 percent in the first quarter of 2023/24 above the target of 10.1 percent for end-December 2023, driven by strong private sector credit growth.

Credit to private sector grew at around 22 percent in July and August, before moderating to 19.5 percent in September 2023, which was above the projection of 16.4 percent for end December 2023.

The robust growth of credit is attributable to the improving business environment, reinforced by the less accommodative monetary policy.

Credit was largely registered in agricultural activities relative to others.

Inflation trended downward since June 2023, reaching 3.2 percent in October 2023, higher than targeted 5 percent, from 3.6 percent in June 2023, associated with declining food prices.

The price pattern indicates continued improvement of food supplies in the market as harvests in the 2022/23 crop season, which are higher relative to the preceding season, penetrate the market.

In September, the stock of cereals held by the National Food Reserve Agency (NFRA) surged, reaching 244,169 tonnes, depicting an improvement from the stock held in the preceding month by 34,149 tonnes.

The central bank is optimistic that inflation is projected to remain lower than the targets, despite the recent increase in oil

Drinking water producer calls for tax relief

PRODUCER of drinking water in Dodoma region has asked the government to reduce taxes in order to help attract more investors.

The producer raised the concern during a special forum convened here over the weekend, attended by entrepreneurs and businessmen to brainstorm ways to improve business environment in the region.

The one-day forum was organised by the Dodoma Regional Commissioner Rosemary Senyamule, who was the chairperson.

Director of Royal African Pride Limited, Hellen Lyimo said unfriendly taxes thwarts the producers of drinking water in the region to run their production successfully.

"On November 30, 2019, the government adopted changes to the Product Tax Law which directs that every liter of water that is produced and packaged in the country to be charged 58.00/- per liter," Lyimo

Lyimo observed that, water producers in Dodoma region rely on raw materials such as bottles, handles and covers from Dar es Salaam, because as there's no factory in the region manufacturing packaging materials, and thus imposing them with high taxes is like 'adding salt' in

"A 13-liter bottle of water that is ready to be sent to the market, as per the factory price is sold at 3,500/-. If you subtract the cost of purchase, shipping and labels, you will be left with only 1,300/-," she unveiled.

the wound.

She mentioned other costs such as stamp duty, which currently for every one liter stands at 58/-, therefore total tax for 13 while realising the needed

"For the manner to which we're running our business, in every 13-liter bottle of water there is 546/- which is required to run the company by paying various fees, payment of business tax, salaries of employees and other costs of running the office and business," she detailed.

With such high costs and expenses in operating their business, she said it would be prudent if the government will consider how to cut down the taxes in order to allow them to provide the crucial service

profits. "As the price of water goes down with the increase in liters of water, so should this tax go down? For example, if one liter of water whose price in the market is 1,000/-, the tax is 58/-, we're asking for 13 liters of water whose price is 4,500 and the tax should be14.5/- per liter, as a percentage discount of 75 of 58 charged per liter, since the volume of water increases and the value of water decreases," he expressed.

Dodoma region has four factories that produce safe drinking water starting from 6, 13, 18 and 20 liters.

"I have visited two factories out of 250 and one of them is for textile and I have been told that the manufactured products are used in Tanzania and are exported in Dubai and Zambia, enabling our country to earn foreign exchange from these investments,"

I commend the President for opening the doors for investors," said Dr. Kijaji.

In addition, she said the government expects that more jobs will be created in SINO-

The completion of the industrial park will cost US\$320 million and is expected to create 100,000 direct jobs.

The industrial park which will have 200 factories will create 500,000 indirect jobs for natives who will work in factories.

The chairman of SINO TAN, Janson Huang, said that the construction started in May last year after the area was handed over by the government and they expect to complete the construction within the next five years.

"One year ago this area was a big forest and there was no road from Morogoro main road to reach here, but in just one year we have been able to build a tarmac road to come here with big buildings. We expect that in the next five years, this will be an interesting area," he said.

He said they have been promoting the area in China and neighboring countries and many investors have shown interest in coming to invest, noting that four investors are interested to invest factories in the area.

He said next year they expect to receive between 15 and 20 factories and SINO TAN intention is to build a chain of factories that will have the capacity to produce \$6 billion

Gov't to revisit used vehicles importation policy

HE government is planning to revisit the used vehicles importation policy and law, to give a wider room for encouraging the purchase of locally assembled cars.

The proposed policy change is expected to be submitted in the National Assembly next year, as part of environmental protection measures from smoke generated by imported old fossil fuel vehicles.

Under the targeted policy change, the government will also propose the prioritization of cleaner energy vehicles imports.

Prof Kitila Mkumbo, Minister of Planning and Investment in the President's Office said this yesterday in Dar es Salaam when he graced the new business partnership entered between GF Automobiles and Mahindra.

However, it is an advanced stage of already made reforms in July this year when the National Assembly approved restriction of imported used cars aged not more than eight years, from the previous ten years after manufacturing.

Setting a fair ground, the parliament decided that if an imported car is older than eight years, it will face additional excise duty upon impor-The rate is 25 percent for regular

cars and five percent for utility vehi-

Beyond the eight-year limit, there may also be additional fees, often re-

ferred to as dumping fees.

Finance Minister Dr Mwigulu Nchemba noted that the age restriction mainly applies to standard cars and trucks, not to specialized machinery, cargo in transit, or heavy equipment such as bulldozers and

agricultural machinery.

The minister noted that the ministry is eager at protecting direct investments entering into the country.

"The partnership between GF Automobile and Mahindra needs to be protected by the country's laws

and policies. There have been many emerging vehicle assembling plants during the recent years that dearly need this protection," said Prof Mkumbo.

China's role highlighted at COP28 in global climate action

DUBAI

AS the 28th session of the Conference of the Parties to the United Nations Framework Convention on Climate Change (COP28) unfolds in Dubai, China stands out as a proactive force in global climate governance, contributing both resolve and wisdom to addressing the pressing challenges posed by climate change.

It has to be understood that many achievements have been made in China, said Fatih Birol, chief of the International Energy Agency (IEA).

With excellent progress in developing solar and wind power, electric vehicles and power batteries, China is a champion of the world in clean energy, said the IEA executive director at a side event held at the China Pavilion of the ongoing COP28 climate change conference.

Strong commitment

China will promote the establishment of a fair, reasonable, cooperative and win-win global climate governance system, said Chinese Vice-Premier Ding Xuexiang in Dubai during a meeting with United Nations Secretary-General Antonio Guterres.

In recent years, China has actively yet prudently promoted the targets for carbon peak and carbon neutrality, said Ding.

China has committed to a "dual carbon" goal of reaching the peak of carbon emissions by 2030 and attaining carbon neutrality by 2060. The country has formulated a "1+N" policy framework to facilitate its implementa-

In addition to its commitment to domestic carbon reduction initiatives, China extends its support to developing countries, aiding them in their endeavors to effectively reduce emissions by sharing expertise, technology, and resources.

In his speech on Friday, Ding said that China has always kept its promise and made important contributions to global climate governance and vigorously promoted international cooperation on green development, energy revolution and climate change, and supported developing countries in

China has signed 43 South-South cooperation documents on cli- Joint Statement of BRICS Highmate response with 38 developing countries, trained about 2,000 officials and professional personnel specializing in climate response and a shared commitment to for more than 120 countries, and made notable contributions to building a fair and rational global climate governance system for win-win results.

Significant progress

China has made significant strides in promoting environmental sustainability. In 2022, the country's emission intensity of carbon dioxide decreased by more than 51 percent from 2005, while the installed capacity of non-fossil energy surged to 50.9 percent.

In response to climate change, there has been a substantial reducenvironment and climate. tion in coal consumption per unit of GDP and China's forest coverage and stock have both risen over the past 30 years.

China also stands as a global leader in the new energy vehicles (NEV) industry. Its production and sales of NEVs rank first in the world, accounting for more than half of the world's total with more than 18 million NEVs in use.

Major economies are the main emitters of greenhouse gases and any action they take toward transitioning to renewable energy could have significant impacts, said Jordi Sole, a Spanish climate development and transition. change expert and professor at the University of Barcelona.

China's transition towards clean energy has achieved significant climate change stems not only progress: The aggregate reduction in CO2 emissions from China's from its eagerness to achieve electric vehicle shift could be at least 1 billion tons during 2023-40, equivalent to Japan's 2020 emissions, according to Bloomberg.

In November 2023, China and the United States issued "The Sunnylands Statement on Enhancing Cooperation to Address the Climate Crisis," emphasizing their commitment to work together and with other countries in addressing the climate crisis.

In 2022, the BRICS High-level Meeting on Climate Change was hosted by China via video link, resulting in the adoption of the level Meeting on Climate Change jointly driving policy research on low-carbon green growth, technology cooperation, and collaborative pilot projects.

In 2021, China launched the Belt and Road Green Development Partnership Initiative with 28 countries and held nearly 20 thematic activities in the field of

China also put forward the Qingdao Initiative for Belt and Road Green Energy Cooperation, set up regional energy cooperation platforms, and held the Second Belt and Road Energy Ministerial Conference, consolidating the global consensus on green

Germany suffers most from 'frozen' relations with Russia, says Putin

MOSCOW

THE "frozen" state of relations between Russia and Germany benefits neither country, but it is Germany who suffers most here, Russian President Vladimir Putin said at a ceremony ushering in new ambassadors of foreign states.



"The current 'frozen' state of relations with Russia, and not on our initiative, I want to stress this, is not beneficial, it is not beneficial either to us or to you. But first of all, in my opinion, to Germany," the Russian President said.

Putin recalled that Russia and Germany had been developing "pragmatic, business-like cooperation" for more than half a century.

"This has benefited both states, and, perhaps, not only us, but the entire European continent. Notably, energy has always been an attractive area of bilateral coopera-

For decades, our country had been supplying Germany with environmentally friendly gas fuel, oil, and other energy products, other raw energy materials reliably, without interruption, at affordable, reasonable prices. And this cooperation was literally undermined, including by sabotage on the Nord Streams," the President said.

On September 27, 2022, Nord Stream AG, the operator of the pipelines, reported "unprecedented destruction" that occurred "on three strings of the Nord Stream and Nord Stream 2 offshore gas pipelines." On September 26, Swedish seismologists registered two explosions on offshore routes of the pipelines.

After that, Russia's Prosecutor General's Office launched a probe into the act of international terrorism. Germany, Denmark and Sweden announced their own national investigations, but refused to involve Russia in

The Russian leader also said that, in addition to political and economic ties, relations between Russia and Germany that had previously developed so successfully in the scientific, educational, cultural and humanitarian areas, as well as ties between the people of the countries themselves, have been interrupted.

"Russia, I want to stress this, has always advocated building Russian-German relations on the principles of equality, mutual benefit, respect for each other's interests. I repeat: such relations are important not only for the two countries, but for the whole of Europe," Putin

On June 21, 2023, the Russian Foreign Ministry announced that Russia had signed off on the appointment of Alexander Lambsdorff as the German Ambassador to Moscow. Geza Andreas von Geyr, the previous ambassador, served in the post for four years before leaving Moscow at the end of July.

Lambsdorff is considered a leading foreign policy expert in the Free Democratic Party (FDP) of Germany. He is known for his harsh criticism of Russia. In particular, the FDP representative spoke about the importance of maintaining the "unity of the West" in matters of supporting Ukraine. In his opinion, representatives of Western countries should prevent "Russia from increasing pressure on its neighbors."

BUOYED by his party's recent wins in the state assembly elections in the Hindi heartland states, Prime Minister Narendra Modi took a swipe at the opposition asking them to be at peace with their "arrogance, lies, pessimism and ignorance" while asking people to be aware of their "divisive agenda".

"May they be happy with their arrogance, lies, pessimism and ignorance. But.. Beware of their divisive agenda. An old habit of 70 years can't go away so easily," Modi said in a post on 'X' on Tuesday while commenting on a video snippet from a television news analysis.

The Prime Minister also snapped at the opposition saying that they need to be prepared for several such "meltdowns" in the future as well.

"Also, such is the wisdom of the people that they have to be prepared for many more meltdowns ahead," he said.

The video posted by Modi listed the excuses supposedly chalked out by Congress supporters to blame for their defeat in Rajasthan, Madhya Pradesh and Chhattisgarh. These excuses were often problematic and even went on to blame the voters for their choices. Reacting to this post, the Bharatiya Janata Party (BJP) IT cell Amit Malviya said that the Prime Minister's post is "not out of character" but "aggressive" and he is taking the opposition ecosystem head on.

"It has been the case with BJP's content on social media in general too for the last few months now. Its campaign and reels have seen aggressive tone and traction," Malviva added.

NZ Maori lawmakers protest King Charles at parliament's opening

WELLINGTON

INDIGENOUS Maori politicians broke with protocol at the opening of New Zealand's parliament on Tuesday, pledging allegiance first to their descendants and the country's founding document before swearing an oath to Britain's King Charles III.

New Zealand's parliament was sitting for the first time since the Oct 14 election. Parliamentarians must all swear an oath to King Charles III, who is the country's head of state.

The six lawmakers who belong to the Te Pati Maori, which is the smallest party in parliament and represents the Maori people, each made a pledge to their mokopuna, or descendants, to tikanga, or Maori practices, and the Maori version of the Treaty of Wait-

The Treaty of Waitangi signed in 1840, laid down a set of principles under which the British and Maori agreed to govern New Zealand, but the English and Maori versions differ and there is debate over whether Maori ceded sovereignty.

Several of the Te Pati Maori members wore feathered headdresses and cloaks honouring their traditional roots and sang or performed an Indigenous challenge.

The party members later swore allegiance to the king but at least two chose to change the word Kingi Tiare government.

for Kingi Harehare. Te Pati Maori coleader Rawiri Waititi told local media Harehare was just another name for Charles. However, it can also translate to something objectionable or offen-

Other parliamentarians who speak Maori were unconcerned by the

Te Pati Maori, which would like to remove the king as head of state, said in a statement on Friday the oath was symbolic of the colonial power that Parliament places above the standing of Indigenous people.

The move comes as race relations issues in New Zealand heat up. Te Pati Maori led protests across the country earlier in the day.

While New Zealand's republican movement is not huge there has been debate for some time on whether the Pacific nation should become a republic, with a citizen as the head of state. In some Indigenous communities this feeling is stronger, both in New Zealand and elsewhere, as the king is a symbol of colonializtion.

In 2022, Indigenous Australian parliamentarian Lidia Thorpe had to retake her parliamentary oath after she changed it to label Britain's queen a colonizer.

Brazil to invite Putin to G20 summit in September 2024, says president

RIO DE JANEIRO

THE Brazilian authorities will invite Russian President Vladimir Putin to the G20 summit to be held in the country in September 2024, even though Brasilia recognizes the jurisdiction of the International Criminal Court (ICC), which has issued an arrest warrant for the Russian leader for alleged involvement in war crimes, President Luiz Inacio Lula da Silva (pictured) said.



"Whether Putin comes or not is up to him, [but] he'll be invited. There is a case against him [at the International Criminal Court], he must assess the consequences," the Correio Brasiliense newspaper quoted the president as saying. "Since Brazil is a signatory [to the Rome Statute], Brazil is responsible," he point-

According to electoral law, Russia's presidential election is scheduled for mid-March 2024. On November 13, Kremlin Spokesman Dmitry Peskov said that Putin had not yet made any decisions about running for president in 2024. The G20 summit is expected to be held next fall in Brazil, which assumed the

chairmanship over the group on December 1.

On March 17, the ICC issued an arrest warrant for Putin and Russian Presidential Commissioner for Children's Rights Maria Lvova-Belova on charges of "illegal deportation" of Ukrainian children.

Under the Convention on the Prevention and Punishment of Crimes against Internationally Protected Persons of December 14, 1973, heads of state enjoy absolute immunity from the jurisdiction of foreign states. Agencies

Through independent innovation, we have been able to produce key components such as joints domestically," Gu said.

Shanghai has made early and rapid progress in the development of the AI industry. Currently, there are over 350 AI enterprises above designated size in Shanghai, with a total output value of over 380 billion yuan (\$53.6 billion), which is approximately three times of that five years ago.

Intelligent robots, involving advanced technologies such as AI, high-end manufacturing, and new materials, have become a new engine driving economic growth and a new frontier for technological competition.

Shanghai is proactively cultivating intelligent robots in order to build new engines of growth and competitive strengths for the future.

In October this year, Shanghai released an action plan on promoting high-quality innovative development of the intelligent robot industry in the 2023-2025 period. The plan aims at building Shanghai into a globally influential innovation hub for the industry by 2025.

According to the plan, Shanghai will create 10 leading robot brands, establish 100 exemplary robot application scenarios, and expand the total value of robotrelated industries to 100 billion yuan.



AT begins preps for constitutional amendment

ATHLETICS Tanzania (AT) Special Constitutional Amendment Committee says it will use 30 days to collect views from its affiliates and stakeholders to amend the association's

Wilhelm Gidabuday, the committee's secretary-general, said yesterday the body believes that the views it will collect from various AT stakeholders will help the sports achieve progress in the country.

Gidabuday- the former AT Secretary-General- appealed to all affiliates of the association to use the 30 days to avail themselves to express their views on the amendments to the constitution.

The Special Committee, which was formed by AT early last year, is headed by lawyer Farida Jawela, has Gidabuday as its secretary-general while members are Kurwajia Malina, Rogath John, Boniface Tamba, Marian Said, Angelious Likwenda, and Alphonce Simbu.

"From today (Monday), the AT Special Constitutional Amendment Committee will start collecting views and contributions of our stakeholders, this exercise will take 30 days," the official noted.

The former athlete stated: "We will reach all regions of the country and others will use our social media platform to express their views."

"I'm asking stakeholders to take part in this exercise, we are relying on stakeholders and affiliates because they have the mandate to amend the constitution," he said.

Gidabuday also said it is the view of the AT Special Constitutional Amendment Committee that other relevant authorities will give the committee guidance.

Some athletics stakeholders in the country have been asking for a constitutional amendment at AT.

They noted the changes will improve working conditions that will, in turn, improve athletics in the country and ensure the sport matches international standards.

The AT constitution, which was first adopted in 2020, highlighted topics such as who should be members of the association, the roles of technical officials, and vacancies available at the association.

However, after its adaptation, many AT affiliates and stakeholders have been expressing their displeasure with the requirement of a university degree as the minimum qualification for one to hold the position of the association's president and the body employing a full-time secretary-general.

They argued that anyone with a proven record in managing the running of the sport and has passion for athletics, with a minimum of secondary education and experience can be elected as AT president.

The secretary-general of the association, they appealed, should be elected, not employed, given AT has no reliable finances to hire full-time personnel for the role.

of winger Pape Ousmane Sakho. The Tanzania football giants were banned from executing the international transfer of players by the world's football governing body,

The decision to impose the ban on Simba SC was made after Teungueth FC won its case against the former over the transfer of the Senegalese side's former player, Sakho.

The lifting of the transfer ban was revealed through a statement released by the Tanzania Football Federation (TFF).

The Senegalese club filed a case with FIFA against Simba SC, claiming part of the payment due and Sakho

Simba SC lost the case and had to pay the Senegalese club within 45 days after the decision was issued.

The directive, though, was not implemented and Simba SC therefore incurred the consequences. After completing the payment, TFF has also opened the door for Simba SC to make internal transfers of players.

Sakho, the 26-year-old left winger, joined Simba SC in August 2021 from Teungueth FC in his hometown, Senegal.

He left the Msimbazi Street side after two good seasons to Union Sportive Quevillaise-Rouen Métropole, better known as US Quevilly-Rouen, or US Quevilly, or QRM is a team that competes in France Ligue 2.

English Premier League announces record \$8.45 bn domestic TV deal

LONDON

THE Premier League announced on Monday it had agreed a record £6.7 billion (\$8.45 billion) domestic television rights deal for a four-year period starting from the 2025/26 season.

The current deal is reported to be worth around £5 billion over a three-year cycle and covers 200 matches per season.

The English top flight hailed the agreements shared between different broadcasters as the "largest sports media rights deals ever concluded in the UK".

Sky Sports and TNT Sports have retained their rights to show live matches, with Amazon, currently showing 20 matches per season, not part of the next cycle.

Sky will screen a minimum of 215 live matches per season while TNT will broadcast 52. BBC Sport will continue to broadcast highlights via its Match of the Day programme.

A Saturday afternoon blackout, designed to protect attendances in the lower leagues, will remain but for the first time all matches outside of those scheduled for 3:00 pm on Saturday will be screened live.

The Premier League boasted of a four percent increase in live rights value compared with the previous process but the broadcasters will be paying significantly less per game because they will be showing more matches each season.

"The outcome of this process underlines the strength of the Premier League," said the Premier League's chief executive, Richard Masters.

"It is testament to our clubs, players and managers who continue to deliver the world's most competitive football in full stadiums, and to supporters, who create an unrivalled atmosphere every week."

He added: "As longstanding and valued partners, Sky Sports and TNT Sports are renowned for consistently delivering world-class coverage and programming.

Careless Man City's bad habit has blown title race wide open

T is not Pep Guardiola's most famous treble of 2023. It won't be his favourite one, either. First Cole Palmer, then Trent Alexander-Arnold and now Dejan Kulusevski have scored late equalisers against his team. Manchester City's serial winners have become habitual drawers, taking the lead six times in their last three league games and dropping six points.

Had City done as expected, closing games down with enviable ease, even against opponents of the calibre of Chelsea, Liverpool and Tottenham, then the Premier League table would take on a very different look: Guardiola's side would be three points ahead of Arsenal, seven clear of Liverpool, with nine straight wins in all competitions. Another title would seem theirs for the tak-

Instead, there has been a rare frailty, an uncharacteristic carelessness. City suffocated games with excellence at times in the past. Now they have enlivened them with entertainment; Guardiola was not supposed to be the new Kevin Keegan, offering anarchy, showing a self-destructive streak.

It may just be a phase. It is scarcely unknown for Guardiola to tinker in search of a compelling formula at the start of seasons before em-

barking on extending winning runs. It may yet happen again; or the near perfection of past glories rendered it inevitable that, sooner or later, standards

For the first time in six-anda-half years, City have gone three league games without a win. They have dropped 12 points already; they only mislaid 14 when they were centurions. The broader significance may lie in a different number, a lower one than in recent seasons. City have won titles with 100, 98, 86, 93 and 89 points. Most are unattainable for even the finest of other teams. At their current rate of progress, they are on course for 82. That renders them beatable. Even a tally in the high eighties may be reachable for Arsenal or Liv-

erpool.

Guardiola has often countered his own argument, insisting the Premier League is the toughest in the world, listing a series of supposed contenders and then distancing them. Thus far, City's superiority has not been as apparent in meetings with their challengers.

Chelsea, Liverpool and Spurs have all held them. Arsenal have beaten them. City did well to grind out a 1-0 win over Newcastle but their only emphatic victory against the nominal big seven was the 3-0 against Manchester United, which may say more about Erik ten Hag's ragged bunch. It gives them nine points from a possible 18 against those six sides; last season, they took 25 out of 36.

should have won each of the last three but Guardiola did not plead misfortune. "I learn from Johan Cruyff that bad luck in football doesn't exist," he said, citing his lodestar. City may instead rue their bad decisions, poor discipline, defensive difficulties and certain misses.
