### PM: Revive idle specialised crop sector training institutions now

**By Guardian Reporter** 

PRIME Minister Kassim Majaliwa (pictured) has directed the Ministry of Agriculture to set aside funds from its annual budget allocations for the revival of collapsed research and training institutions.

Speaking yesterday during a visit at the Naliendele Agricultural Research Institute in Mtwara Region, he said it is the responsibility of the ministry to ensure that institutions that are out of use start operating.

Naliendele serves as the national coordinating research centre for cashew, oilseeds as well as for roots and tubers, he said.

"I recently visited Mlingano training institute which was established way back in 1970 and Kihinga research centre we set up recently in Kigoma Region," he elaborated.

The revival of dilapidated centres and building new agricultural training and research centres is vital in the country's bid to unleash the potential for economic growth especially in rural areas, he pursued.

The centres play a pivotal role in spurring investments in agriculture and facilitate public-private collaboration to improve the business environment for small and medium enterprises (SMEs).

"We want to see more money going to these institutions and the outcome research reaching farmers for increased output. That

AN African Development Bank (AfDB) project to enhance market infrastructure, value addition and rural finance (MIVARF) in Tanzania has increased the incomes of rural producers and traders threefold.

A report released yesterday by the project

team shows that the initiative rolled out from 2012to 2017 has substantially altered income

expectations of the beneficiaries. With \$56.8m in funding from the AfDB, the programme was undertaken in 32 districts with a population of 6.1m in 1.2m households. Around 78 per cent of beneficiaries reported

EAST Africa remains the fastest growing region in the continent despite COVID-19 disruptions, a new report has

The East Africa Regional Economic Outlook, unveiled yesterday in video conference by the African Development Bank (AfDB), shows that the region's economy grew by an average of 5.0 per cent last year - higher than Africa's average of 3.3 per cent and global average of 2.9 per cent.

The report says that the region was projected to grow by 5.1 percent against a continental average of 3.9 percent and a global average of 3.4 percent.

With Covid-19 shocks, the region's real Gross Domestic Product (GDP) is projected to decline sharply during 2020, at 1.2 percent growth or down to 0.2 percent as baseline and worst case scenarios.

However, the region still remains above Africa's average of -1.7 percent and -3.4 percent under the Covid-19 effects as minimal and abysmal levels of projected growth, it said.

Covid-19 will reverse the region's growth momentum in 2020 but partial recovery in GDP growth to 3.7 percent (baseline) and 2.8 percent (worst case) is projected in 2021 assuming the pandemic is contained in the short to medium term," it says.

The report mentioned service sectors like hospitality, tourism, travel and aviation as the most susceptible to Covid-19 restrictive measures and lockdowns enforced in the region and outside.

It projected inflation at 17.3 to 18 percent from 13.5 percent

## COVID-19: Kenya issues new 'relaxed' travel rules

**NAIROBI** 

There will be no mandatory quarantine for travellers arriving in Kenya if they do not show Covid-19 symptoms, the government announced yesterday.

To enhance safety measures and curb the spread of Covid-19, Transport Cabinet Minister James Macharia said airports across the country will be restricted to workers and travellers only, except for cases where travelers need special assistance.

"The new protocol also includes measures to minimise contact between crew and passengers at the airport terminus, and to limit physical contact between security officers and passengers, and between airport staff and luggage.

"Air Operators will also reduce onboard service to the bare minimum, and introduce phased boarding and disembarking procedures to eliminate crowding at the aisles," the CS said.

The Transport minister also announced the Madaraka Express train services will resume on Monday between Nairobi and Mombasa.

"Kenya Railways will deploy 10 coaches for passengers with a total one-way capacity of 600 passengers (or 50 percent of capacity), and one additional coach that shall be used to isolate passengers suspected to be infected with Covid-19," he said.

Only one train will leave Nairobi for Mombasa at 8:00am and the train out of the coastal city leave at 1:25pm, the CS said.

improved incomes, rising from an average of \$41 in 2012 to \$133 in 2017, researchers noted.

"This increase is attributable to the sale of value-added products, improved access to markets, and increased productivity. It also involved the use of improved techniques (like rice intensification and using fertilizer and improved seeds), plus enhanced capacity to negotiate better prices," team leader Salum Ramadhani explained.

Small producers and traders gained greater access to agro-markets, cutting post-harvest losses of staple crops. One beneficiary, the Meru Dairy Company, recorded an 85 per cent spike in production by installation of a cold room, boosting its milk-production and cold storage capacity from 400 to 2200 litres.

Transportation costs on refurbished roads dropped by an average of 20 to 50 per cent, as transporting a bag of onions on a renovated road to Mang'ola market in Karatu fell from \$1.30 to \$0.22l while transport times for stored produce fell from an average of over three hours to less than one hour.

Downstream, the use of warehouses has led to a sharp decline in post-harvest losses, from 57 to 15 per cent overall,

"Despite challenges in terms of coverage, the programme has worked well thanks to efficiency of communication with district and regional liaison officers, along with effective relationships with district and regional administrative structures," the report underlined.

The successful implementation of the project helped rural poverty reduction and economic growth, by improving incomes and food security. The project complemented the work of government agencies by boosting access to markets and increasing the quantity of value-added agricultural products, it stated.

The project completion report was released on 27 February and while preparations were continuing for its being unveiled, the Covid-19 restrictions on all social gatherings were introduced, officials intoned.

# **National Statistics Bureau:** Headline inflation for June stood at a stagnant 3.2 pct

THE annual headline inflation rate for last month stagnated at 3.2 per cent, the same rate recorded in May 2020, the National Bureau of Statistics (NBS) said yesterday.

Releasing the statistics yesterday, the director of population census and social statistics, Ruth Davison said the stagnation of the headline inflation explains that ,the speed of price change for commodities for the year ended June,2020 remained constant as that recorded for the year ended May 2020.

She said the overall index went up to 120.74 in June, 2020 from 117.23 recorded in June 2019, adding that food and non alcoholic beverages inflation rate for the month of May, 2020 has decreased to 4.4 percent from 4.6 percent recorded in April 2020.

The director observed that the annual inflation rate which excludes food and energy for the month of June, 2020 has increased to 2.6 percent

from 2.2 per cent that was recorded in May, 2020. She added that the overall monthly consumer index for the month of June, 2020 has decreased to 120.74 from 120.93 recorded in May, 2020, noting that the decrease of the overall index is mainly attributed to the price decrease for both food non food items.

Some of the food items that contributed to such decrease include ricer by 1.4 percent, maize grain (5.1), maize flour(2.1) sorghum flour(3.1) and sweet potatoes (3.5).

On the other hand, some of the non food items that contributed to such a decrease include refrigerators by 2.2 percent, diesel (15.4), and

The consumer price index has shown a relatively stable price movement from June, 2019 to June, 2020 and the annual headline inflation rate over the same period have shown a stable trend that range between 3.2 per cent recorded in May and June,2020 and 3.8 per cent recorded in November and December, 2019.

In comparison with other East African countries of Kenya and Uganda, she said the annual inflation rate in Kenya has decreased to 4.59 percent in June, 2020 from 5.33 per cent recorded in May

Uganda has recorded an increase in the annual headline inflation rate from 2.8 per cent in May.2020 to 4.1 per cent in June.2020.

## TRA explains ETS delay on soft drinks and bottled water

THE Tanzania Revenue Authority has explained the reason behind delays in the eagerly awaited rollout of Electronic Tax Stamp (ETS) on soft drinks-water, juice and soda.

Speaking when he addressed journalists at the ongoing 44th Dar es Salaam International Trade Fair (DITF), TRA Deputy Commissioner General Msafiri Mbibo said the exercise to install special machines and train manufacturers on the ETS was ongoing.

This comes after ETS has shown great success in products such as beer, cigarettes and wine which has boosted revenue collection by 30 per cent.

"We are currently in the final stages of training the manufacturers of the products and we have begun installing ETS machines in their factories," said

He however, didn't mention when exactly those products will have an electronic stamp but he said for the stage that authority has reached, soon the implementation will take place.

#### Keep off politics but stand for fairness, clerics urged

RELIGIOUS leaders have called on their colleagues all over the country to keep off active politics but stand for fairness of the playing field ahead of the October general elections.

"As religious leaders it is not ethical for us to engage in partisan politics; our role is to support and uphold democratic principles including that apart from leading their followers

fairness to all those taking part in the process," he said.

Speaking during the symposium aimed at maintaining peace and harmony in the country, Bishop Dr Glorious Shoo from the Tanzania Assemblies of God (TAG) said that the symposium dubbed 'Different Religions-Peace and Love' also aims at promoting the role played by the religious institutions in spurring socioeconomic activities in the country.

"Interfaith meeting is a very crucial platform that brings us together for the sustainable peace, love and socio economic development of Tanzania as a nation regardless our differences in our belief," he said.

Chief Sheikh of the Muslim Council of Tanzania (BAKWATA) in Kilimanjaro region Sheikh Mlewa Shaaban said to abide by commandments of their faiths, religious leaders should also tell their followers to work hard to improve heir individual livelihoods and for the sustainable economic development of the country. "We also have the duty to help and support the needy people in our communities," he said.

Catholic Church leader Fr Colman Siriwa added that the role of religion is also to ensure that human beings lead a responsible but happy life.

### Minister warns private power producers over tariff inflation

# Funding constraints fail cultivation of pyrethrum

#### By Guardian Correspondent, Morogoro

LIMITED funding and research for quality seeds have been cited as among the reasons disrupting the production of the crop.

Pyrethrum researcher from the Uyole Centre of Tanzania Agricultural Research Institute (TARI-Uyole) Baraka Mvile revealed this over the weekend when speaking with this

He said that as of now the country pyrethrum production is between 2,000 to 3,000 tonnes per year while demand is great in Africa and the world in general.

It is estimated that the global demand is over 16,000 tonnes and the price has been going up rapidly due to its use in making pesticides and as domestic aerosols.

Mvile said the biggest global pyrethrum producer is Australia with 8,000 tonnes per year, but of whose quality is incomparable to the Tanzania's crop.

Mvile further said the biggest challenge in the research of better

seeds for pyrethrum production is financial resources and added that as of now they depend on the pyrethrum factory at Mufindi for processing who have been selling the concentrates thereof to the United States.

He appealed to the government to allocate enough funding for the crop's research.

TARI-Uyole crops director Daud Mbongo said low pyrethrum production is attributed by farmers using old seeds with low yields and added that the only solution is to ensure the research centre produce modern technology seeds.

TARI-Uyole Director Dr Tulole Bucheyeki said pyrethrum is unique for the manufacture of pesticides that are environmental friendly and safe to the users.

He said as of now it is estimated that more than 20,000 farmers are engaged in the production of the crop in Mbeya, Songwe, Njombe, Iringa, Arusha, Manyara and Kilimanjaro regions, even though large production is concentrated in the Southern Zone

#### Govt pledges to take action against unscrupulous cooperative officials

THE government will take legal steps against cooperative officials who will be found to abuse office by enhancing their own personal interests instead of the people's interest.

The caution was given by the Permanent Secretary to the Ministry of Agriculture Gerard Kusaya early this week during the event to mark international Cooperatives Day that was held at the national level in Morogoro Region.

He said there are some cooperative officials who are untrustworthy, they use the cooperatives' resources for their own interests, and added that the government, through its various organs including the PCCB continues to make investigations on the cooperatives.

"As government we have received many complaints from farmers including traders on fraudulent acts done to them by some of the cooperative officials, and we are closely making follow ups on these complaints," he said.

### DC: Let small traders with IDs do business in freedom

RUNGWE District Commissioner Julius Chalya has directed leaders in the district to stop charging levies from small traders who have special Identity Cards.

According to Chalya, authorities should be aware that any entrepreneur with a capital of less than 4m/- is eligible to get the ID.

Chalya made the directives here after receiving several complaints from traders at Kiwira market that there were some government officials who harass them including beating them to pay levies even if they have the IDs.

He reminded officials to uphold high moral standards when serving small scale traders which include respecting their activities.

"It is against rules to force the trade to pay other levies and taxes while they have already paid for the annual ID fee of 20,000/-. Any leader who is doing this should stop immediately, we have to let our petty traders conduct their activities freely," Chalya said.

Nuru Mwaituka, a rice trader at Kiwira said that they are usually being forced to pay high levies which they cannot afford.

"The leaders sometimes bar us from entering the market if we fail to pay the charges, we have to spend several hours outside the gate just because we cannot afford to pay the multiple levies and taxes," Waituka said.

For his part, Fadhiri Sanje, one of the traders at the market said that they are usually forced to pay 15,000/- as levy for one tonne of cargo which is too high for them to afford. "We have been selling our products

at high prices due to the levies, this situation makes us lose customers and thus end up incurring losses," Sanje added. He called on the District Commissioner to intervene as the

situation has affected a number of traders whereby most of them have lost their businesses due to lack of capital. "We have witnessed some traders closing their shops with others moving to other places. Majority of traders have

changed their businesses and they are now conducting their activities in informal areas," Sanje explained. Late 2018, President John Magufuli launched the programme to provide vendors and small-scale entrepreneurs

with special taxpayer ID cards which he printed in efforts to expand the tax base in the country. When handing over the cards

to regional commissioners, he charged the leaders to ensure proper distribution of the cards. The ID cards will be renewable

annually and are available at a price of 20,000/-. Anyone running a business with a maximum profit turnaround of 4m/- is eligible to have one.

#### **Population growth remains** cause for immense concern

is an annual event, observed on July 11 every year, which seeks to raise awareness of growing global population issues and urgency of family planning and the need to curb it.

The current world population is 7.8 billion as of June 2020 according to the most recent United Nations estimates elaborated by Worldometer. Worldometer, formerly Worldometers, is a reference website that provides counters and real-time statistics for diverse topics.

The event was established by the Governing Council of the United Nations Development Programme in 1989. World Population Day aims to increase people's awareness on various population issues such as the importance of family planning, gender equality, poverty, maternal health and human rights.

Population, in simpler terms, is the number of people in a city or town, region, country or world; population is usually determined by a process called census (a process of collecting, analysing, compiling and publishing

In 2017 the United Nations Population Division projected that the world's population will reach about 9.8 billion in 2050 and 11.2 billion in 2100. In the future, the world's population is expected to peak, after which it will decline due to economic reasons, health concerns, land exhaustion and environmental hazards. According to one report, it is very likely that the world's population will stop growing before the end of the 21st century. Further, there is some likelihood that population will actually decline before

More than half of the projected increase in the global population up to 2050 will be concentrated in just nine countries: the Democratic Republic

ORLD Population Day Indonesia, Nigeria, Pakistan, the United Republic of Tanzania, and the United States of America.

> The population pattern of lessdeveloped regions of the world in recent years has been marked by gradually declining birth rates. These followed an earlier sharp reduction in death rates. This transition from high birth and death rates to low birth and death rates is often referred to as the demographic transition. Human population control is the practice of altering the rate of growth of a human population. Historically, human population control has been implemented with the goal of limiting the rate of population growth. In the period from the 1950s to the 1980s, concerns about global population growth and its effects on poverty, environmental degradation, and political stability led to efforts to reduce population growth rates. While population control can involve measures that improve people's lives by giving them greater control of their reproduction, a few programmes, most notably the Chinese government's onechild per family policy, have resorted to coercive measures.

In the 1970s, tension grew between population control advocates and women's health activists who advanced women's reproductive rights as part of a human rights-based approach. Growing opposition to the narrow population control focus led to a significant change in population control policies in the early 1980s.

While press interest and general awareness in the global population surges only at the increments of whole billions of people, the world population increases annually by 100 million approximately every 14 months. The world population reached 7,400,000,000 on February 6, 2016; the world population had reached 7.500,000,000 at around 16:21 on April 24, 2017. The world population had of the Congo, Egypt, Ethiopia, India, reached 7,700,000,000 on year 2019.

## Towards 50/50 Representation: Women's leadership, participation in decision-making must be prioritised

**By AWLN Tanzania** 

THEN President John Magufuli addressed the National Assembly on June 16, the final day before Parliament was dissolved; he made a strong statement encouraging political parties to give adequate opportunities to women, youth and people with disabilities in the upcoming general elections, a very important message for the country and women's future political participation.

Similarly, as processes towards the general elections begin to gain traction and potential candidates make their aspirations to hold leadership roles come November 2020 known, there is growing discourse among various stakeholders, from the women's rights activists, political leaders and gender equality champions across different fields - to ensure that more and more women are nominated and supported throughout the process to enable them to participate in the elections with the ultimate aim of attaining 50:50 representation.

The importance of women's representation, not just for women but for inclusive and sustainable development has increasingly received recognition. Time and time again, women have proved themselves as skilled and capable leaders, with studies showing that women's leadership can result in greater socio-economic benefits. Although this recognition presents a ray of hope for the women's rights and gender equality activists who have been working in this area for decades, aspiring women leaders, and women and girls everywhere, the African Women Leaders Network (AWLN) Tanzania Chapter posits that what is even more critical, is for everyone involved to have a realistic understanding of what needs to be done to get there.

milestones as a result of national efforts to promote women's political leadership. From the introduction of temporary special measures for women in 1985, women's representation in parliament has experienced substantial growth. The proportion of women in parliament increased from 3.5% in 1970 to 5.9% after the introduction of the quota system in 1985. It rose to 29.9% in the year 2005, and stood at 37.8% in the recently dissolved parliament. Amendments to the constitution in 2005 requires for women to make up no less than 30% of all members of parliament, and in 2015 the government decided to increase the proportion of women parliamentarians through Temporary Special Measures (TSM) from 30 per cent (which is provided for in the current constitution) to 40 per

Assembly and the Zanzibar House of Representatives from 2105-2020, and in the same period, the first woman

These are undoubtedly great achievements; however, we must remain mindful that the numbers still fall short of national commitments for 50:50 representation, including the SADC protocol and 2030 Agenda Sustainable Development. Furthermore, outside of the temporary special measures, there is still a lot of work to be done. Only 10% of women in the National Assembly and 12% in the ZHoR have been elected through constituencies, and at the local level, only 5% of women have been elected as Councilors in Mainland Tanzania, with 21% in Zanzibar. In terms of nominations by political parties, although the proportion of women nominated grew by 14% from 1995-2015, only 19% of candidates nominated to contest for constituencies in 2015 were

Looking at why these proportions remain significantly low, we see that a number of barriers exist that continue to hinder women from taking up leadership and political positions. Political parties remain the only gateway to political office in Tanzania while gender discrimination within political parties remains a serious challenge. This is partly caused by male-dominated leadership within political parties, gender irresponsive party policy documents and intraparty nomination guidelines. Political

parties have been favouring the selection/nomination of men over women for leadership positions, particularly in 'winnable seats' as women are often left out. This, combined with other challenges such as violence against women in politics (VAWP); discriminatory laws, practices, attitudes and gender stereotypes; low levels of education and access to information; in addition to poverty disproportionately affect women in achieving their leadership aspirations.

In responding to the challenges that are hindering women from making strides in assuming leadership within political institutions, in 2019 the URT Parliament passed the new Political Parties (Amendment) Act, 2019 (PPA) integrating provisions that promote women's leadership and political participation. The principles incorporated in the amended law require political parties to adhere to principles of non-discrimination, gender equality, youth, and social inclusion, with Article 6A specifically emphasizing that political parties need to promote these principles in the formulation and implementation of its policies; the nomination of candidates for elections; and election of its leaders.

It is in these areas that AWLN Tanzania urges political parties to place a greater focus, to make 2020 an exemplary year towards the achievement of gender equality in political leadership. And we recognize that this does not only require building on the existing political will, but the concerted efforts of multiple stakeholders.

As a network that seeks to empower Tanzanian women leaders for the transformation of the nation, promoting women's political leadership is a key priority for AWLN Tanzania. female leaders in Africa.

We are committed to amplifying the voices of women leaders in the country towards significantly increasing the role of women in leadership and political spaces. We aspire to see 50:50 representation in key decision-making organs including in the Parliament, Councils and cabinet, and we are committed to supporting efforts to ensure that women's leadership capacity is strengthened, and for women, including young women and women with disabilities to be accepted as legitimate leaders. We are committed to further building on the achievements that have been made thus far, collaborating with government, political organs, civil society, development partners, and the many other ongoing initiatives towards this end.

At the launch of the AWLN Tanzania Chapter in February 2020, the chief guest Vice President Samia Suluhu Hassan urged the network to ensure that it plays a significant role in advocating for progress towards 50:50 representation in the coming general elections. AWLN Tanzania will ensure that we pursue this mission tirelessly.We believe that through collective action, Tanzania can make 50:50 representation a reality. We can increase women's participation in the 2020 elections, we can achieve unprecedented numbers of women in constituency seats, and we can ensure that not only do we have equal numbers, but an equal recognition of women's abilities as leaders. This is not just for the sake of women, but the entire country - because when more women lead, everyone benefits.

But how do others pull it off without a steady income?How is surviving in the city without a permanent job even possible? And if it is, can you live a highquality life and even manage to save a few coins at the end of the day?

Well, It is possible and I will be sharing with you a few routines you need to follow that a good friend and colleague shared with me.

More than a year ago, he moved to the city after completing college

He would be working in a company based in one of the suburbs in the city which was a great opportunity to grow careerwise and he didn't need to think twice about it, despite having established his brand online as a fulltime freelancer at the time.He wasn't sure whether she was making the right decision because he had dreaded living in the city all his life. But because his colleagues were also moving out and they would be working together in the startup company, he then had to make the gamble.He wasn't sure of surviving in

the city but then he went. Starting from scratch and work his way to the top like most youths his age.

A few weeks in his new job and new environment, he settled in his residential apartment at the expense of all his savings.Well,his savings account were empty and the account had an overdraft. Before moving to the city he had already secured two projects from his freelancing clients which would last him two months.Then he wasn't able to complete those projects which meant he did not get paid. Things weren't moving in the right direction and he knew it.He literary lived from hand to mouth and this was to continue for the next eight months. Life in the city was not very lenient on him and he never gave in either. He maintained the struggle and promised himself that he was going to hold on until he made it.

Then came the global pandemic that made it even worse. By then, he was on paternal leave so he didn't quite feel the intensity it had on the company he worked with. Most companies in the region laid off a large percentage of their employees.The remaining received a pay cut of up to 50%. The global economy was collapsing the ripple effect on companies especially startups such as theirs was adverse. A few people lost their jobs but his spot was waiting for him to report after his leave. However, his paycheck took a hit and reduced by 20% which was fair, or was it? Things got worse because he had to work from home after his paternal leave was over. The economy was falling and life was becoming unbearable.

The prices of most basic accessories shot up unprecedentedly. With a decrease in pay and an increase in prices, life wasn't easy for

typical citizens like her,me and you too of course.He had to act fast and hard.He then traced his steps back to freelancing network where he once worked. The prodigal son was back and this time he vowed to be as resilient as ever. Working up to twenty hours a day, nothing was going to stop him. After a few weeks of sleepless nights and working unbelievablylong hours, the financial status of his young family was afloat.

was tough,but eventually,he had a few essential bills under control. Work at his place of employment continued to be frustrating because clients continued to close their businesses. One thing led to another and he had to send his resignation letter to his boss. It was not an easy decision for him because the notion of surviving in the city without a permanent job freaked him out. But he had to do what he thought was right for him and for his young family. So, now he had no permanent employer yet he had recurrent and exaggerated bills to pay. One day after the other, one foot ahead of the other, he kept working hard and soon managed to turn things around.

The secrets? Hard work and resilience. as possible. It was during



He had to work extremely hard to elevate himself from his then position. There was no shortcut. He couldn't ask for help from anyone, or probably he did and it didn't work out. But by understanding the gravity of his own status, he knew that he needed to man up and get his life together." I took all kinds of jobs online whether they were worth the pay or not."he said. Slowly, he accumulated one dollar after the other, and even when it was enough for one bill, he settled it and kept working because he knew that he was surfing through troubled

The freelancing world is very unpredictable. One month you make a fortune and the next 'rivers are dry'. Discipline determines how you survive. The quality of your life depends on your ability to earn and save for a rainy day.He had to learn how to spend as little as possible and save as much that time he began thinking about health insurance among other types of insurance that would help him save on recurrent and critical bills for his family. He was learning new life skills and he credits that to hardships in the city. Surviving in the city is tough, but it toughens one to become a more skilled individual.

He also mentioned how much it also comes down to disciplined saving. Saving will allow you to live anywhere and make major moves in your life. It does not matter how much you save, eventually the little will accumulate and surprise you. There are a lot of opportunities and challenges equally.

Life is expensive around the city but jobs pay better equally. Minimize your spending, save the little you manage and eventually you catch your break. But it also depends on you, and your beliefs. If you believe you can pull it off then you can.

# The health crisis at home: Covering domestic abuse

ender-based violence and abuse is the leading public health issue around the world, with research estimating that one out of every four women will experience harassment or abuse.

pandemic and lockdowns and quarantines around the world, advocates worry that gender-based violence is on the rise - even if the number of reported incidents remains low.

"Gender-based violence is not the shadow pandemic, it is the primary pandemic. It feeds on so many other social and economic ills," said Hazel Friedman, author and TV documentary producer for Special Assignment on the South African Broadcasting Corporation (SABC), in an ICFJ Global Health Crisis Reporting Forum webinar last month.

Other panelists included Luisa Ortiz Pérez, executive director and co-founder of Vita-Activa.org; Ann Marie Cunningham, the 2020 Lipman senior fellow in civil and human rights reporting at Columbia Journalism School; and Jess Hill, Australian investigative journalist and author of "See What You Made Me Do: Power, Control and Domestic Abuse." Taylor Mulcahey, IJNet (International Journalists' Network) editor, moderated the event.

Hill said domestic abuse rises at times of economic recession when perpetrators experience increased levels of humiliation or shame, such as losing a job or a sense of public identity. They're likely to express that as fury in the family space as a way of reasserting some semblance of control, which is what is happening now during the coronavirus cri-

But the sensitive and traumatic nature of genderbased violence makes it complicated for journalists

to report on. Experts used the webinar to share hints, informed by their own regional experiences, on reporting GBV.

#### Consider the terminol-

There is a great deal of debate over what terminology In the face of the Covid-19 to use when describing this type of violence or abuse. Domestic violence, violence against women, domestic abuse, gender-based abuse and intimate partner violence all describe similar experiences, but different advocates use different terms.

Pérez says journalists should let survivors define what has happened to them, and then reflect that concept back to them. This way, reporters and readers can better understand the realities of what happened.

Context, culture, region and language all matter, as does your audience. You shouldn't use the same language in policy circles as you would in academic circles and the same goes with the people on the ground experiencing it.

In her book, Hill used the term 'domestic abuse' instead of 'violence', as many people had a hard time moving past physical manifestations of violence.

"Every time I used the word 'violence' and tried to explain that it can mean psychological violence - it doesn't need to mean physical - it didn't come across to people straight away," she said. Using the term 'domestic abuse' has spurred a discussion in Australia on the parts of abuse that go unnoticed, such as coercive control and systematic campaigns of domination and degradation.

#### Limit reliance on data

The panelists agreed that statistics can grab headlines, but they don't tell the full story - and they can mislead how audiences think about



gender-based abuse.

Many statistics rely on counting incidents, which are mostly physical. This is a limited way to frame gender-based violence or abuse, which is actually "a system of ongoing abuse that never switches off", according to Hill.

Coercive control and campaigns of domination through isolation and micromanagement often go unnoticed, and are rarely reflected in statistics.

However, statistics can be useful in showing increases in the number of threats. "There was a UN report that came out and said that if the lockdown continued for six months longer, we would be looking at 31 million additional cases of genderbased violence or domestic violence," said Hill, demonstrating that statistics can be important for audiences to understand rising - or falling

levels of violence.

#### Pay attention to online forms of violence "In the case of Latin Amer-

ica, there is a growing trend of connection with the digital world and the attempt to control and to abuse, using extortion with intimate pictures or intimate materials, trolling or even revenge pornography as a way to attack or to suppress and to silence the women," said Pérez.

"Online violence is real as well. And it is increasing in the context of the pandemic because there are a lot of idle people online just looking for a way to control the rest," she added.

#### Find underreported sto-

Friedman says reporters need to keep police accountable. By following up with cases that police have investigated, or where the perpe-

trator has appeared in court, reporters can help survivors and their families find resolution after years without closure.

Reporters should also explore the compounded impact of police brutality and lack of trust in law enforcement. Cunningham, whose research will focus on violence in communities of colour in Mississippi, says that there are many cases where Black women have called the police to report domestic violence, and have ended

up shot by the police. In Australia, Hill said, police routinely arrest or fine First Nations women for small things such as unpaid fines, or an unregistered dog, for simply calling the police for help.

Another underreported story is women's resistance. Women are not just vulnerable; they are surviving on a minute-to-minute level each

passing day, and becoming masterful strategists.

"I was on a panel just yesterday with two survivors talking about resistance and agency. They are really sick of hearing victims described as vulnerable," said Hill.

She elaborated: "They said: 'I needed help. I needed assistance. I needed a place to just be safe. But don't pity me. I don't want your pity.' It's almost insulting for some women. And it and it stops them from identifying as victims of domestic abuse when they keep on hearing the same thing. And it stops courts from seeing victims as anything other than the ideal, passive, submissive victim when they see violent resistance."

#### Avoid 'trauma porn'

The panelists agreed that journalists should approach these topics with care to avoid hurting sources, re-

traumatising survivors or exploiting women's experiences.

It's not your role to perpetuate 'trauma porn', especially when working with images, said Friedman.

"As a television producer, it is an incredibly sensitive topic because we have got to tell why we show it," she noted, adding: "But we have also got to respect the boundaries - the intimate spaces of pain - of loss and of grief that we encounter. Sometimes you've got to know when you do not lift that camera and all you've got to do is to listen and take your cue from the person who has entrusted you into that horribly emotional, grief-stricken place."

#### Care for yourself

"You have to take care of yourselves. These are not easy topics," said Pérez, adding: "We need to be able to protect ourselves from vicarious trauma as much as we can by being good to ourselves, by being honest to why and how we are doing the reporting that we are doing. And we really need to work on our triggers, and the connection that we bring into the story."

"We need to show up with our full selves, our full racialised, full genderedised, full intersectional selves. That is when we do good reporting: when we show up," she noted.

# Wearing of masks is critical, and here's how to sustain it...

are making headway (maskway?) here in the United States, with more consensus that masks are key. Collectively, we can drive transmission down big time by wearing them. But if we accept that the average person - talking about myself here - can't wear a mask 24/7, then we need to make sure that we have the best masks possible, and that we wear them when it is most critical.

Masks are important because they both block transmission to others and protect the wearer. They don't do either perfectly -the better the mask, the better it works - but perfect is the enemy of good enough to keep the RO below one. So, masks are better than no masks. That's the most important point.

Incidentally: RO, or the basic reproduction number/rate, refers to the contagiousness and transmissibility of infectious pathogens. It varies depending on a variety of factors and is critical in public health management to en-



sure infectious epidemics workers and those at high (or global pandemics) are controlled.

We would greatly benefit from better masks. Folded up T-shirts work, but the better the mask, the less the viral transmission. This is especially true for essential

risk of severe disease. Higher filtration masks are kev.

How do we get better masks? In the US, this will have to happen either through the federal government - which seems unlikely, unless officials invoked

the Defence Production Act - or through the private sector. Investors and companies should be racing towards making these, with a huge market opportunity in addition to the massive public health benefit.

Masking is not an "all or nothing" behaviour, either.

I keep seeing people running outside alone with masks on, yet not masking

When you mask is almost as important as if you mask. If people can only realistically mask for X number of hours, then they must do so when transmission risk is highest.

This means masking indoors. This may very well mean masking around family or relatives as well, especially if they are in vulnerable risk groups and you live in a high-transmission area. In addition, this means masking while using public transport and at work.

Masking while alone in your car or when you are on a walk by yourself or for the second you pass by someone on the street is less useful. Your mask here likely won't do too much as vour risk of transmission is already very low.

So in short: masks work, better masks work better, and masking during highrisk transmission situations matters more than during those which are low risk.

Lastly, don't shame those not wearing a mask. It won't work. A genuine conversation may go further - but keep your own mask on.

**66** During Covid-19 we are proving the case that a lot of women thought have all along that remote workspaces - being outside of the newsroom, working on schedules that work for us and for our families - are fully effective," says Emily Ramshaw, co-founder and

CEO of The 19th. The 19th is nonprofit, nonpartisan news organisation at the intersection of gender, politics and policy. It was established earlier this year and is based in Austin, Texas, the thrust of its operations being on empowering women - particularly those underserved by and underrepresented in American media - with the information, community and tools they need to be equal participants in democracy.

"I think this moment is, I hope, going to prove to everyone that we know best and we can manage our schedules and our lives and still produce extraordinary products without being tethered to a chair in a newsroom," Ramshaw told the audience during WAN-IFRA's recent World Media Leaders eSummit.

Ramshaw was taking part in a panel along with Pamella Sittoni, executive editor and managing editor of Kenya's Daily Nation and María Ramírez, head of strategy at El Diario, Spain, at the panel discussion on "Post pandemic role of women in the Media," moderated by author and former editor-in-chief of USA Today Joanne Lipman.

Lipman pointed out that women continue to be underrepresented in newsrooms globally and in news coverage. Studies have found that in the US, UK and Canada, 75 per cent or more of those who are described as experts on the front pages of newspapers are men.

"In the US, women make up the majority of journalism graduates and yet the minority in newsrooms and a vanishingly small number of our top editors. And globally, a recent study of English language news

those mentioned in articles are men," Lipman said.

She said researchers had concluded that women are "routinely marginalised and symbolically annihilated in news coverage".

Bringing in more women into the newsroom and into leadership positions will both help elevate the status of women and add diversity to the content being produced.

Sittoni explained it further: "Where you have gender diversity in a newsroom or where you have diversity at the table where you are making such a decision, you are likely to bring at the end of every month in more voices and more to find out the gender bal-

"What we have seen here in Africa is that women start off strong at the lower cadres but, as they get older and start having families, they drop off and go into PR and communications and government organisations, which promise them lighter schedules and more manageable time for the families. But now we

can have the best of both worlds and it should encourage more women to be in the newsroom," she said. However, no change hap-

pens overnight, and changes in a newsroom are no different. But a good example to look up to is El Diario - where half of the editors are women and one of the

top two people in power is

a woman. El Diario also makes sure that gender balance is reflected in its hiring processes, Ramírez said: "At least find women candidates. You just have to keep looking because sometimes women don't apply (for jobs) at the same rates as men do. The 50:50 thing is part of our policy now, and we don't do interviews unless half the candidates are women."

Ramshaw added that applying peer pressure to other organisations to encourage them to do the right thing when it comes to representative newsrooms might also be a good option.

#### **Being optimistic**

Sittoni further noted that there has been a lot of growth for women journalists in Africa recently, particularly among those who are coming out of programmes where they have been mentored and have developed management skills.

Before the pandemic, it was not uncommon for women's voices to go unheard at meetings, or for them to be interrupted or silenced. Ramírez feels that the Covid situation has helped in addressing the matter.

"In meetings women are interrupted a lot, but that doesn't happen a lot in virtual meetings. There are fewer issues of office politics. So let us not waste this crisis and let us do more to make sure women are at the top," she said.

# Covid-19: Wear masks in crowded public spaces, says science body

VERYONE should carry a covering when they leave home in order to tackle coronavirus, the head of the UK's national academy of science has said.

Prof Sir Venki Ramakrishnan, president of the Royal Society, said the coverings should then be worn "whenever you are in crowded public spaces".

He said evidence shows they protect the wearer and those nearby, and the UK was "way behind" other countries in usage.

No 10 said the use of face masks is always kept "under review."

Current guidance on face coverings varies across the UK, but Public Health England previously said they did not need to be worn

Speaking as the Royal Society published two reports on face coverings, Prof Ramakrishnan said the public remained "skeptical" about their benefits because "the message has not been clear enough" and guidelines have been inconsistent

He added: "What we would like for the government is to be a bit stronger and clearer about the messaging and require it whenever you are in crowded public spaces where you



cannot get more than two metres away from the next

passing the virus on to someone else.

"We have been very clear about the benefits of people wearing face coverings," said the prime minister's official spokesman, following Prof Ramakrishnan's comments.

"Face coverings can help us protect others and re-

duce the spread of the virus if people are infected but not showing symptoms."

The Downing Street spokesman added that face coverings "should cover both the nose and mouth to reduce the spread of coronavirus droplets, helping to protect others".

The government has said

that face coverings can be made at home from cloth, and do not need to be hospital-standard masks.

Face coverings are compulsory on public transport in England, where they should also be worn in hospitals by staff, outpatients and visitors. People visiting shops are also advised, but not required, to cover their face if they judge that social distancing is not always possible.

In Scotland, masks are also mandatory on public transport, and will be in shops from 10 July.

People in Wales are being asked to wear non-medical face coverings where social distancing is not possible including on public transport. But the government stopped short of making their use mandatory.

Plans to make wearing face masks on public transport compulsory in Northern Ireland have been put on hold, pending legal clarification.

In late April, only about 25% of people in the UK wore face coverings, compared to 83.4% in Italy, 65.8% in the United States and 63.8% in Spain, according to one of the reports, which examined the factors limiting the take-up.

Not wearing a face covering should be regarded as "anti-social" in the same way as drink driving or failing to wear a seatbelt, Prof Ramakrishnan said.

"Not doing so increases the risk for everyone, from NHS workers to your grandmother," he said.

The World Health Organization changed its advice on face coverings in June, saying they should be worn in public where social distancing is not possible to help stop the spread of coronavirus - but countries set their own guidelines and

The WHO had previously argued there was not enough evidence to say that healthy people should wear masks, despite their widespread use in many countries.

Prof Paul Edelstein from the University of Pennsylvania, who wrote the other report which examined the effectiveness of masks and other coverings, said the evidence that they protected other people was "clearer all the time", but there was also "some evidence" they protected the wearer.

"There are people without symptoms going about their daily business who are unknowingly breathing out droplets that are carrying the virus," he said.

"If they had their faces covered the majority of those droplets would be caught before they can infect other people. Wearing face coverings can help save lives and prevent disabling illnesses."

# Post Covid-19: Africa's growth stands to rebound to 3 pct next year - AfDB

It is estimated that an additional 49 million Africans could be pushed into extreme poverty by the pandemic and its aftermath; West and Central Africa stand to be worst hit

Africa's economic growth could rebound in 2021, provided that governments manage the COVID-19 infection rate well, according to updated forecasts from the African Development Bank (AfDB), released on Tuesday.

In a comprehensive socioeconomic assessment of the pandemic's impact, the Bank said growth was now projected to rebound to 3% in 2021 from -3.4% in the worst-case scenario for 2020.

The predictions are contained in a supplement to the Bank's African Economic Outlook, which was released on 30 January. At the time, Africa's growth was forecast at 3.9% in 2020 and 4.1% in 2021.

The supplement cautioned that the growth outlook for 2021 and beyond would depend largely on African governments' effectiveness in flattening the curve of the outbreak and policies to reopen economies.

Charles Leyeka Lufumpa, Acting Chief Economist and Vice President for Economic Governance and Knowledge Management, at the African Development Bank, said: "To reopen economies, policymakers needed to follow a phased and incremental approach that carefully evaluates the trade-offs between restarting economic activity too quickly and safeguarding the health of the population. "

"Economic activities can be restarted incrementally on the basis of the transmission risks of different sectors," Lufumpa said.

Executive Director of the African Economic Research Consortium and Former Governor of the Central Bank of Kenya, Njuguna Ndung'u described the African Economic Outlook 2020 supplement as "a very important and useful policy tool for African countries who actually need it at

"It will be useful now and in the future. It gives us important short, medium- and long-term strategies," he added, stressing crises like COVID-19 present a good opportunity for innovative reforms in countries.

The supplement noted that the curve of the pandemic in Africa was flattening gradually. However, COVID-19 remains a serious threat to lives and livelihoods, given weak healthcare systems and limited social protection. The continent also remains vulnerable to other regional threats such as the locust swarms that have struck East Africa, as well as to extreme climate events.

Under projected scenarios for contraction of growth, Africa could lose between \$145.5 billion and \$189.7 billion of GDP in 2020, according to the publication.

Hanan Morsy, Director of the Macroeconomic Policy, Forecasting and Research Department at the African Development Bank, said "The African Economic Outlook 2020 Supplement shows that for the first time in the last half-century, Africa would be facing an economic recession as a fallout of the COVID-19 pandemic. This would affect the gains achieved in poverty reduction as an estimated 49 million Africans could be pushed into poverty, with about 30 million jobs at the verge of disappearing. Policymakers need to act fast to allevi-

# African airlines take off with clipped wings

THE Covid-19 pandemic brought everyday air traffic to a halt. But African airlines are preparing to take to the skies once more. Many airlines are facing a difficult path ahead to stay competitive.

Many passenger planes remain firmly on the ground around the world because of the coronavirus pandemic. In Africa too, radars picked up very little movement in the sky. But since the beginning of June, air traffic over the continent has increased.

"Most of the airlines in Africa have started operations," South African aviation expert Phuthego Mojapelo said.

Two of the countries low cost airlines, FlySafair and Mango Airlines have already resumed flights. Both are affiliated with the national airline South African Airways (SAA), which filed for bankruptcy before the outbreak in December 2019.

The South African government decided not to continue funding the airline in April 2020. According to authorities, the state no longer wanted to pump money into the bankrupt fight the coronavirus pandemic instead.

"SAA is developing a plan of starting a new airline, SAA 2.0," explains Mojapelo.

"That plan is still before the unions and creditors and they still have to vote on the plan."The failure of SAA leaves a big gap, however – it was one of Africa's largest airlines, along with Ethiopian Airlines and Kenya Airways.

Kenya Airways has also experienced significant losses and is currently going through the process of being nationalized. The most financially stable of Africa's big three airlines – Ethiopian Airlines – had already flagged a loss of \$550 million (€488 million) in April.

"That would have been our income if we were able to fly at full capacity," said Tewolde GebreMariam, Ethiopian Airlines Group CEO.

According to the International Civil Aviation Association (ICAO), African airlines are at risk of losing \$6 billion in revenue compared to 2019 and three million jobs.

But now long-haul flights are on the cards again: Ethiopian Airlines and Kenya Airways airline – it was now needed to plan to fly to Paris, Geneva and is a lower risk of infection on

Brussels again this month – albeit on a reduced schedule.

But will this increase in air traffic contribute to the spread of coronavirus? Mojapelo is optimistic that passengers will be safe:

"Most of our aircraft in Africa are fitted with HEPA, a highly efficient filter, which makes sure that the virus does not survive in the airplane."

German aviation expert Cord Schellenberg also believes the environment inside an aircraft poses very little danger to pas-

"Worldwide, airlines will be ensuring that people are maintaining distance on the ground during check-in, at the gate and at the baggage counter," he

Wearing masks on board also helps to stop the spread of the virus, as well as removing and replacing the air conditioning systems that allow air to flow in from the cabin ceiling.

Passengers also have their body temperature measured in South African airports and rows on the aircraft are allowed to be fully occupied. South Africa's Transport Minister Fikile Mbalula emphasized that there board than inside a normal

closed room. Airlines are operating on the assumption that it will take some time for the economy to return to pre-pandemic levels. This could have an impact on ticket prices.

So far, prices have remained the same on the domestic market, explains Mojapelo. He has a positive outlook on the future of the industry: "Africa is a magnet for tourists and the airlines will continue to position themselves for this business. The continent is also a popular destination for conferences, so the industry will recover when the pandemic wanes."

But his colleague Joachim Vermoorten is more skeptical about the overall impact of the coronavirus crisis, which has hit South Africa particularly hard. "The market has certainly not returned to normality," he said.

"For that to happen, all air travel restrictions would have to be removed and air travel should be freely accessible for bookings, including leisure travellers. People have gotten used to video conferencing and the personal distance issue is still a major factor to consider."

## What's false and what's true on China-related human rights matters (Part 3)

**Prologue** 

ULL of ignorance of and bias against China, some people from certain countries have recently made groundless accusations against and disseminated many fallacies about China's human rights conditions concerning Hong Kong, COVID-19, and Xinjiang.

Even a small discrepancy will lead to a great error. Malicious lies will, still worse, result in huge misconception and misunderstanding.

In this connection, the Ministry of Foreign Affairs of China have compiled What's False and What's True on Chinarelated Human Rights Matters, with the purpose of setting the record straight with facts.

Falsehoods find no market among the fair-minded, as we are confident that people will tell right from wrong!

16 False: The vocational education and training centers in Xinjiang are "concentration camps" detaining over one million Uyghurs.

The vocational education and training centers, established in accordance with law in Xinjiang, are no different in nature from the community corrections in the US, the Desistance and Disengagement Programme (DDP) in the UK, and the deradicalization centers in France. All of them are useful measures and positive explorations for preventive counter-terrorism and deradicalization, and are in line with the principles and spirit of the UN Global Counter-Terrorism Strategy and other counter-terrorism resolutions.

The education and training work in Xinjiang is guided by the spirit of the rule of law as well as international principles on counter-terrorism and deradicalization. It has solid legal basis and follows well-defined legal procedures, and is done in a way that makes no linkage to any specific region, ethnic group or religion. There is no such thing as "suppression on ethnic minorities" or "persecution of Muslims".

The claim that "nearly one million Uyghurs are detained", an outright rumor, is based on two highly dubious "studies".

The first "study" was done by the US government-backed Network of Chinese Human Rights Defenders (CHRD) with interviews of only eight people. The CHRD applied the estimated ratio shown in this absurdly small sample to the whole of Xinjiang, drawing a crude conclusion that one million people were detained in the "re-education detention camps" and two million were "forced to attend day/evening re-education sessions".

The second "study" was done by a farright fundamentalist Christian Adrian Zenz, a.k.a. Zheng Guoen. According to The Grayzone, a US-based independent news website, Zenz is a senior fellow in China studies at the far-right Victims of Communism Memorial Foundation established by the US government in 1983. and a senior member in a research group set up with the masterminding of the US intelligence community to study Xinjiang's vocational education and training centers. He believes he is "led

by God" on a "mission" against China. In September 2018, Zenz wrote an article published in the Central Asian Survey journal, concluding that "Xinjiang's total re-education internment figure may be estimated at just over one million." According to The Grayzone, Zenz based this conclusion on a single report by Istiqlal TV, a Uyghur exile media organization based in Turkey. Far from a journalistic organization, Istiqlal TV advances separatism while playing host to an assortment of extremist figures. One such character who often appears on Istiqlal TV is Abduqadir Yaqupjan, a leader of the East Turkestan Islamic Movement (ETIM). Maybe it was because the reference he cited was too absurd even to himself, that Zenz admitted that "there is no certainty" to his estimate. But Zenz "bumped up" his estimate again in November 2019, claiming China was detaining 1.8 million people.

17. False: The vocational education and training centers in Xinjiang carried out "political indoctrination and intimidation" over the Uyghurs and other ethnic minorities.

The vocational education and training centers in Xinjiang provided courses — is fully respected and protected at the on standard spoken and written Chinese language, legal knowledge, professional skills and deradicalization, to address the inadequate language proficiency, lack of legal literacy and job skills, as well as the varying degrees of religious extremism influence among their trainees. The purpose of the centers is to tackle terrorism and religious extremism at the root, not so-called "political indoctrination and intimidation" by any means.

Through all-round learning, the trainees have freed themselves from the influence of terrorism and religious extremism. Their overall capacity has been improved, as evidenced by a markedly increased understanding of the law, the ability to speak and write in standard Chinese, acquisition of practical

skills and the general improvement in employability. Most of them have found jobs that give them a stable income, and notably improved their families' living

18. False: The vocational education and training centers are poorly conditioned and lack medical facilities. The trainees are subjected to forced political indoctrination and torture, and are deprived of their rights to exercise religious customs, use local ethnic languages among others.

The vocational education and training centers strictly follow the basic principle of respecting and protecting human rights enshrined in China's Constitution and other laws. The trainees' basic rights and personal dignity are well protected, and insults or abuse against the trainees in any manner are prohibited. The centers fully guarantee the personal freedom of trainees. The centers are managed as boarding schools where trainees may go home on a regular basis and ask for leave to attend to personal matters, and enjoy the freedom of correspondence.

Trainees' freedom of religious belief centers. Those with a religious belief can decide on their own whether to take part in legal religious activities when they are at home.

The centers fully respect and protect the customs of all ethnic groups and provide a rich variety of nutritious halal food free of charge.

The trainees' right to use the spoken and written languages of their own ethnicity is fully protected at the centers. All regulations, curricula and canteen menus at the centers are written in both standard Chinese and local ethnic languages.

The centers have well-equipped facilities. Dorms are furnished with radio, television, and air conditioning or electric fans. Medical facilities are set up to provide free health counseling

There are also venues for basketball, volleyball, table tennis and other sports, cultural venues such as reading rooms, computer rooms and cinemas, as well as venues for performances like auditoriums and open-air stages. Singing and dancing performances of different ethnic groups, sports games and other extra-curricular activities are often held to meet trainees' learning, living and entertainment needs to the greatest extent possible.

Legal counseling rooms are set up in the centers to help address trainees' law-related difficulties and questions promptly. There are psychotherapy rooms to provide psychological counseling services and care for trainees' mental health. All trainees are covered by old-age, medical and other social insurances and free medical check-ups.

19. False: Detainees in the mass internment camps in Xinjiang include permanent residents of the US and Australia.

The vocational education and training centers in Xinjiang have never received trainees who are not Chinese nationals.

20. False: Xinjiang's special operations against violent terrorist activities aim to suppress ethnic minorities under the pretext of fighting terror-

True:

Xinjiang had suffered long and deep from terrorism and extremism. Statistics show that from 1990 to 2016, ethnic separatists, religious extremists and violent terrorists plotted and conducted several thousand violent terrorist cases and incidents, killing a large number of innocent civilians and several hundred police officers, and causing immeasurable property losses. These incidents inflicted untold sufferings on the people of various ethnic groups in Xinjiang.

In the face of a grave and complicated counter-terrorism situation and the urgent demand from people of all ethnic groups for suppressing violence and terrorist crimes and protecting life and property safety, China's Xinjiang region has taken a series of active measures. Responding to the United Nations Global Counter-Terrorism Strategy and other counter-terrorism resolutions, Xinjiang has upheld the principle of not linking terrorism with any particular region, ethnic group or religion, and acted in accordance with the law to crack down on violence and terrorist activities that violate human rights, endanger public security, undermine ethnic unity and aim at separating the country. Since 2014, a total of 1,588 violent and terrorist groups have been taken out, 12,995 violent terrorists arrested and 2,052 explosive devices seized. Such operations have effectively curbed the rising trend of frequent terrorist activities and protected people's right to life, right to health, right to development and other basic rights to the maximum extent. These measures have received full support from people of all ethnic groups in Xinjiang.

Through law-based counter-terrorism, deradicalization and vocational education and training, Xinjiang has not seen a single violent terrorist case in the past three-odd years. Extremist public security significantly improved and people's sense of fulfillment, happiness and security markedly enhanced.

In October 2019, more than 60 countries spoke in support of China's Xinjiang policy at the United Nations General Assembly. Among them, over 30 are Islamic countries. In contrast, none of the few countries criticizing China's Xinjiang policy are Islamic countries.

Since late December 2018, more than 1,000 people from over 90 countries visited Xinjiang in 70-plus groups. They include UN officials, foreign envoys to China, representatives of relevant countries to Geneva, journalists and members of religious groups. After their visits, they expressed the view that Xinjiang's counter-terrorism and deradicalization efforts are in line with the purposes and principles of the UN in fighting terrorism and upholding basic human rights and that these efforts deserve to be fully recognized and emulated by others.

21. False: China restricts the freedom of communication and movement of Uyghurs in Xinjiang in the name of counter-terrorism and deradicalization.

Xinjiang has never restricted the freedom of movement of Uyghurs or people of any other ethnic group. In Xinjiang, anyone from any ethnic group, except those prohibited from leaving the country for suspected crimes, can exit and enter China freely. Several hundred thousand people from Xinjiang are now overseas.

Xinjiang has never restricted Uyghurs or people of other ethnic groups from contacting their overseas relatives. They can do so not only through international phone calls, but also through voice and video chats on instant messaging apps such as WeChat and QQ. They can also do business and trade with people in other countries through various communication

#### 22. False: Xinjiang conducts largescale surveillance on local ethnic minorities.

True:

It is an international common practice to harness modern technology and big data in improving social governance. For example, there were 4.2 million surveillance cameras installed in the UK as early as 2010, the highest number in the world then. Today the country has about six million cameras, one for every ten people. In the United States, facial recognition is conducted in the top 20 airports against passengers. The city surveillance system built by New York police has devices covering every neighborhood of the city watching people and vehicles on the street and tracking and screening information on people's mobile phones. What Xinjiang has done in this respect pales significantly in comparison with these two countries.

The cameras in urban and rural public places, main roads and transport hubs in Xinjiang are installed in accordance with the law for the purpose of improving social governance and forestalling and combating crimes. These measures make people feel safer and are widely supported by people of all ethnic groups. The measure does infiltration has been effectively curbed, not target any specific ethnicity, not to

mention that cameras by themselves identify or target no specific ethnicity. They are there to deter bad guys and protect good people.

#### 23. False: Mass forced labor against ethnic minorities is taking place in Xinjiang.

True:

According to a US news website the Greyzone, the forced labor stories were in fact a PR blitz orchestrated by anti-China forces from the US and Australia.

The stories were cooked up by the Australian Strategic Policy Institute (ASPI) which has long been funded by the US government and American arms dealers. To serve the interests of its sponsors, the institute blatantly spread disinformation to vilify and demonize China, particularly on Xinjiang-related issues. Together with anti-China forces in the US, the ASPI made up baseless and biased stories to smear and attack Xinjiang's counter-terrorism and deradicalization efforts. The institute has no credibility whatsoever. Former Australian Ambassador to China Geoff Raby sees the ASPI as "the architect of the China threat theory in Australia". Former Qantas Airways CEO John Menadue said the institute "lacks integrity and brings shame to Australia".

Ethnic minority workers from Xinjiang are part and parcel of the country's labor force. They have the rights to be employed, sign labor contracts, obtain labor remunerations, take rest and vacations, acquire labor safety and health protection, and enjoy social insurance and welfare as prescribed by law. They have the freedom to choose their occupation. Their personal freedom has never been restricted.

There are only limited job opportunities in the four southern Xinjiang prefectures (Hotan, Aksu and Kashi prefectures, and Kizilsu Kirgiz autonomous prefecture) as industrialization and urbanization there are underdeveloped. The government of the Xinjiang Autonomous Region has taken measures based on the wishes of local people to help them find jobs in their hometowns, nearby cities or other areas of Xinjiang, or in the provinces and cities that have pair-up assistance programs with Xinjiang, thus ensuring peoples' right to work to the maximum extent. Since 2018, Xinjiang has helped 151,000 surplus rural workers from poor families in the southern prefectures to find employment elsewhere. With an average annual income of over 45,000 yuan, these workers have all been lifted out of poverty.

China has been improving its legal system and its State Council has established an inter-agency mechanism to crack down on crimes such as human trafficking and forced labor. Such efforts have proven effective. China earnestly fulfills its international obligations and has ratified 26 international conventions on human rights. China will continue to strengthen exchanges with all parties and fight forced labor and other crimes together.

#### 24. False: Xinjiang has demolished a large number of mosques. True:


Xinjiang has seen sound development of the religion of Islam. The number of mosques in Xinjiang has grown from some 2,000 at the beginning of reform and opening-up in the late 1970s to 24,400 today, more than 10 times that in the United States. In Xinjiang, there is a mosque for every 530 Muslims on average.

Xinjiang takes the preservation and maintenance of mosques very seriously. Some cramped and dilapidated mosques, those with poor layout designs and those inconvenient for religious activities have been rebuilt, relocated or expanded in light of the needs and wishes of local Muslim communities. Such adjustments have been welcomed by religious leaders and be-

#### 25. False: Graveyards of ethnic minorities are demolished in parts of Xinjiang.

True:

Under the regulations of the local authorities, the government does not promote cremation for ethnic minorities observing traditional ways of interment. On the contrary, it takes concrete measures to help preserve the tradition, by designating burial ground and building dedicated cemeteries. Besides, there is no restriction on other ethnic customs followed in weddings, funerals, and name-giving ceremonies.

# **NCBA** obtains yard for seized cars as loan defaults rise

**NAIROBI** 

NCBA Group has acquired a yard for storing cars repossessed from loan defaulters, pointing to a rise in asset seizures in Kenya's struggling economy.

The group, which was formed last year following the merger between CBA group and NIC group, says in latest annual report that the yard has helped it maintain the vehicles and sell them at a better price.

This represents a departure from the common practice by banks where repossessed vehicles are taken directly to auctioneers' yards for public sale. Sluggish economic activity has created a growing pool of distressed borrowers who are increasingly seeing their assets being seized by aggressive lenders. NCBA assets finance division deals mainly with cars

"This has seen a 15 percent increase in the selling price of repossessed vehicles and faster turnaround in their disposal as we are now able to conduct basic maintenance like regular cleaning of vehicles and ensuring proper tyre pressure to restore their value," said the bank.

NCBA has not disclosed how much it spent on the yard, which comes at a time many auctioneers are recording increased vehicles in their yards amid reduced sales. The lender says it has financed over 4,300 vehicles worth around Sh17 billion, with over 80 percent of them being for commercial use by small and medium-sized enterprises.

The mounting defaults are a reflection of the struggles that loan holders are undergoing in an economy that has witnessed a string of job losses and closure of small business in the face of Covid-19. Many commercial banks are struggling to auction properties seized from loan defaulters with potential buyers hesitating to pay above the minimum bid price set

Buyers are increasingly seeking to buy auction properties such as vehicles cheaply and at outsized discounts but their prices have not been possible due to the Land Act 2012. The Act bars banks from auctioning seized assets at below 75 percent of the prevailing market value, leading to few takers with offers that match reserved bid prices.

The delayed fall of auctioneer hammer has prompted repeat advertisements for auctions even the targeted properties suffer diminished value. NCBA has listed asset financing as among the priority growth areas, continuing the business that was popular with NIC group before the merger.

The group last year also implemented and online platform for hire purchase applications, which it says has led to about 56 percent of the applications originate from the platform. The online platform provides an automated loan application process that allows customers to apply for loans through their computer or mobile devices without having to visit a branch.

# Canada's central bank says business sentiment at its lowest for 11 years

Canadian business sentiment has fallen to its lowest level since the 2008-2009 recession as sales slow and uncertainty about future growth remains elevated, according to a survey of executives released Monday by the Bank of Canada.

The Ottawa-based central bank polled businesses between May 12 and June 5 to gauge sentiment during the pandemic. The results show that even as provinces begin to reopen their economies, many businesses are still struggling with weak demand.

The plunge in sentiment is hardly a surprise, given that the nation fell into its deepest recession last quarter since the Great Depression. While there are some positive notes with the central bank highlighting that many businesses expect a fairly quick rebound, the overall gist of the data paints a business sector that has suffered a major shock.

Results "suggest that business sentiment is strongly negative in all regions and sectors due to impacts from the Covid-19 pandemic and the drop in oil prices", the Bank of Canada said in a summary of its findings.

The composite gauge of sentiment declined to -7, the lowest reading since the financial crisis. Companies reported growing slack in capacity, easing price pressures and collapsing forward-sales expectations. Firms also signalled a significant decrease in capital spending plans, along with weakening hiring intentions despite the massive increase in job losses in recent months.

The survey "was extraordinarily weak, but that comes as no surprise given the survey was taken when swathes of the economy were still shut", Benjamin Reitzes, Canadian rates and macro strategist at Bank of Montreal, said in a report.

Almost half of all executives surveyed reported a decline in sales in the past 12 months because of the impact from Covid-19, lower energy prices and heightened uncertainty. Businesses continue to expect weak demand in the future with more firms expecting lower future sales growth in the next year. Indicators of future sales - such as orders and sales inquiries - fell to record lows.

"Firms reported that, while capacity could resume quickly as the economy reopens and containment measures are lifted, the recovery in demand is expected to be more gradual," the report said. Still, business seems to be less pessimistic than they were during the financial crisis - with more than half of firms expecting their sales and employment levels to be near pre-pandemic levels within a year.

Government support seems to be buffering the economic fallout, with some firms citing the federal government's wage subsidy program as helping to reduce the need for layoffs. The survey was also taken in May when lockdowns were being lifted, mitigating the impact on the numbers.

"The headline reading probably could have been even worse if the survey had been conducted a month earlier," Andrew Grantham and Katherine Judge, economists at Canadian Imperial Bank of Commerce, said in a report.

While millions of jobs were lost in March and April due to the pandemic-induced shutdowns, jobs have started to come back and the results of the survey reinforce the view that employers are looking to rehire. A majority of firms that recently let go workers have plans to refill at least some of the positions in the next 12 months, the survey found.

Despite this, the era of tight labour markets in Canada is over. The share of businesses reporting major shortages of workers has declined significantly, suggesting a "broad-based increase in labour market slack."

# Visa launches Click to Pay service in the Middle East

**DUBAI** 

**Payments** technology company Visa rolled out its 'Click to Pay' service in the Middle East on Wednesday, aimed at allowing its customers to make quick and secure online payments.

The Click to Pay icon will be displayed on participating merchants' websites and consumers who opt to use it will not have to fill out forms giving details such as their card number, password or shipping address to make purchases.

"Whenever the consumer sees Click to Pay icon next will not be shared with the

There are cases when they make mistakes and abandon the purchase in-between or move to other merchants,

causing a loss to the business." First launched in the US

in October last year, Click to Pay had more than 10,000 merchants registered by January. In the Middle East, the service is beginning in the UAE, Saudi Arabia, Kuwait and Qatar. Other regional markets will follow soon, said Mr Raad.

"We have plans to expand but I cannot give the timeline. Eventually, we want this experience to become a global standard. "Hundreds of regional merchants have already opted for this service", he added, without disclosing an exact number. Some of the early adopters include Emirates, Etisalat, Freedom Pizza and Kcal.

# rates, resort to govt securities, as a strategy to protect profits

#### **NAIROBI**

Commercial banks are likely to lower their cost of funds and increasingly retreat to government securities in coming months in a bid to cushion their profitability, analysts at KCB Capital say.

In practice it means that lenders will push down deposit and savings rates, which were last recorded in April by the Central Bank of Kenya at an average of 7.01 and 4.21 percent respectively, to protect net interest margins.

The institutions will be trying to cope with the restructuring of hundreds of billions of shillings in loans that has caused repayments to be deferred thereby depressing their interest income in the face of Covid-19 pandemic.

Banks are also facing subdued non-funded income with the removal of fees for cash transfers between customer accounts and mobile wallets. "We expect banks to respond by lowering the cost of funding to cushion interest income (and consequently net interest margins), while enforcing cost rationalisation measures to contain operating expenses and restrict the expected spike in the cost-to-income ratio (CIR)," KCB Capital wrote in a report to clients.

Growth in loans is also likely to remain low as a way to curb the rise in non-performing loans (NPLs) that are projected to lead to an increase in provisioning. the analysts say. Some banks are also cutting dividend payments to preserve cash. "Banks [will] respond by increased allocation to government securities and depressed loan growth on the back of a rise in NPLs and preserving capital, through reduced dividend payments in the 2020 financial year," said the analysts.

Meanwhile Kenya's current account deficit narrowed to 5.2 per cent in the 12 months to May from 5.6 per cent in April, attributed to lower oil imports and improvement in exports of tea, horticulture and remittances.

The figure is below the projected current account deficit of 5.8 per cent of gross domestic product (GDP) by the end of the year. The Central Bank of Kenya (CBK) said last week a faster than expected recovery in key exports has raised the prospects of the deficit ending the year better than previously projected.

"Provisional data on the balance of payments shows that the current account deficit narrowed to 5.2 per cent of GDP in the 12 months to May 2020 compared to 5.6 per cent of GDP in the 12 months to April," said the CBK in its latest weekly bulletin.

The improvement in the current account - which records the net of inflows from trade/cross-border investments and external payments - comes after it had gone up to 6.2 per cent in March due to a decline in horticulture export and tourism earnings due to the Covid-19 pandemic. # CBN devalues official naira to N381/\$

**LAGOS** 

The naira weakened some 5.8 percent to N381 per dollar at the official market, Tuesday, as the Central Bank of Nigeria (CBN) took vet another step towards a convergence of its multiple exchange

The official rate which had been at N360/\$ since March was quoted at N381/\$ at market close on FMDQ, with analysts expecting the CBN to reflect the change on its website tomorrow. It's the second time the CBN has devalued the official rate this year following the crash in oil receipts, Nigeria's major foreign exchange earner. The CBN first devalued the official rate in March when it moved from N306/\$, where it had been for over two years, to N360/\$.

With the latest move, the CBN has collapsed the official rate with its special market intervention sales (SMIS) rate, bringing the country's multiple rates to within three. The SMIS rate was also devalued to N380/\$ from N360/\$ last Friday.

# More loans issued from R200 billion Covid-19 loan scheme

**JOHANNESBURG** 

Banks have disbursed just over 5% of the R200 billion Covid-19 loan scheme created to assist small businesses that were experiencing liquidity issues due to the nationwide lockdown and Covid-19.

The loan guarantee scheme was launched in May to provide loans to businesses with an annual turnover of less than R300 million. The use of the loans is limited for operational purposes and may not be used for things such as repaying other loans or providing dividends.

In its latest update on the various initiatives run through the banks to provide customers with relief through this period the Banking Association of South Africa (Basa) said R10.6 billion in loans has been provided to just under 7 500 business. An initial R100 billion has been provided for the scheme, with the option of increasing it to R200 billion depending on demand.

Numbers

"Cash flow relief for eligible individuals and businesses is critical to the preservation of jobs and businesses and to maintaining a functioning economy." said Bongiwe Kunene, managing director of Basa. "Banks hold in trust the salaries and savings of South Africa's workers, professionals and businesses. It is therefore essential that we continue to extend credit responsibly and avoid blanket debt write-offs or any other actions that might place depositors' funds at risk or otherwise undermine the integrity of the financial sector".

Since the scheme was launched participating banks have received close to 33 965 applications, of which 37% (12 660) were rejected either for not meeting the bank eligibility criteria or the eligibility criteria set out by the National Treasury or the South Africa Reserve Bank (Sarb).

The loan scheme's low uptake has been blamed on the qualifying criteria, which places onerous de-

mands on entrepreneurs and does not increase the banks' appetite to approve loans, in turn, subverting the purpose of the scheme to get funding out to businesses in need in order to avoid closures and a job

Financial market research group Intellidex, whose proposal underpins the final design for the scheme, has noted that restrictions on what the money can be spent on, requests for personal suretyship and a short payment relief period of six months were some of the issues which contributed to business owners being reluctant to take up the loans.

While the National Treasury provides over 90% guarantee for loans disbursed through the scheme, it requires banks to apply their normal credit risk processes. Failure to do so could result in Treasury refusing to pay out guarantees on defaulting loans. As a result, banks are not incentivised to lend more.

Basa said that discussions between the banks, Treasury and the Sarb on amending some of the criteria to make the crisis loans more accessible to businesses are still continuing and "details will be made available as soon as they are agreed."

Payment holidays

Beyond the loan guarantee scheme, banks had also provided customers with the option of taking up a three-month payment relief for individuals and businesses under financial distress in this period. Over R30.6 billion in relief was approved as at June 27, three days before the initiative expired.

Relief granted to businesses of all sizes amounted to R12.4 billion, with a 95% approval rate from the just under 140 000 applications received. "A number of banks have already announced details of further relief on offer to their customers. The offering of each bank depends on their individual capacity and risk management policies," said Basa.

Basa also clarified that the debt relief programmes are not debt writeoffs but "a relaxation of repayment terms to assist otherwise viable businesses to remain solvent and continue to pay suppliers and employees during the current crisis." Similarly, loans through the Covid-19 Guarantee Scheme should not be regarded as grants but rather commercial agreements with "low-interest rates and [a] preferential repayment

# US colleges scramble after new Trump order on foreign students

**NEW YORK/WASHINGTON** 

MANY US colleges were scrambling on Tuesday to modify plans for the fall semester in the midst of the coronavirus pandemic a day after the Trump administration issued an order that could force tens of thousands of foreign students to leave the country if their schools hold all classes online.

The announcement blindsided academic institutions grappling with the logistical challenges of safely resuming classes, particularly after the federal government had granted exceptions to the rules limiting online learning for foreign students when colleges and universities in March rushed to shutter campuses and move to online classes as the pandemic forced lockdowns.

There are more than a million foreign students at US colleges and universities, and many schools depend on revenue from foreign students, who often pay full tuition.

The US Immigration and Customs

Enforcement (ICE) agency said institutions moving entirely to online learning must submit plans to the agency by July 15. Schools that will use only in-person learning, shortened or delayed classes, or a blend of in-person and online learning must submit plans by Aug 1.

The guidance applies to holders of F-1 and M-1 visas, which are for academic and vocational students.

During a roundtable in Washington on reopening schools, President Donald Trump criticized a decision by Harvard University to conduct courses online in the coming academic year.

"I think it's ridiculous, I think it's an easy way out," Trump said. "I think they ought to be ashamed of themselves."

The chancellor of Rutgers University-Newark, Nancy Cantor, said in a statement on Tuesday that the school, along with other colleges across the country and lawmakers in Congress, was working to "to fully understand and respond to this announcement".

#### Mexican president to hold first meeting with Trump as US election looms

**WASHINGTON** 

MEXICAN President Andres Manuel Lopez Obrador met with his U.S. counterpart, Donald Trump, for the first time yesterday, in a potentially awkward encounter that has drawn flak



from some U.S. Democrats unhappy it is coming so close to the presidential election.

The leftist leader has brushed off criticism at home to push ahead with plans to meet Trump, a Republican widely disliked in Mexico because of his incendiary remarks about its people.

The meeting is ostensibly meant to celebrate a new North American trade deal, but friction over illegal immigration and energy investment in Mexico could surface as the two men get together yesterday afternoon.

Lopez Obrador (pictured) joined by a delegation of business officials, including Mexico's richest man, telecoms magnate Carlos Slim. They will dine on Wednesday evening with Trump and American business executives at the White House.

Ongoing Mexican support for Trump's immigration policies is likely to feature prominently on the agenda, as well as how to mitigate coronavirus disruptions and keep goods flowing between the neighbors, whose economies are deeply entwined.

It is unclear if Trump will address disputes between U.S. companies and Lopez Obrador's government, which is rolling back a 2013-14 opening of the energy industry in favor of a state-led model, and has called a number of major contracts into question.

A senior Trump administration official said Mexico's government had pledged to uphold those contracts.

"So, we are certainly hoping that they will keep their word," the official said in a briefing with reporters.

The trip, Lopez Obrador's first foreign visit since taking office in late 2018, saw him travel commercially to Washington. One video posted on Twitter on Tuesday showed him wearing a face mask and flying coach on a packed plane.

The summit was pitched to mark the July start of the United States-Mexico-Canada Agreement (USMCA), which replaced the North American Free Trade Agreement that Trump has called a "nightmare" that cost American jobs.

But the two-day gathering was scaled back to a single day after Canadian Prime Minister Justin Trudeau declined to join, amid new U.S. threats of tariffs on Canadian goods.

Lopez Obrador's critics and some U.S. Democrats say Trump wants to use the meeting to drum up support among Hispanic voters ahead of the Nov. 3 presidential election. Opinion polls show Hispanic voters favor Trump's Democratic challenger, Joe Biden.

Lopez Obrador will not meet Biden during the trip.

"Understanding that the narrative and the pathway by which this virus entered the human population is extremely important, but it's not always a straightforward process of being able to get that answer," he said.

THE consequences of the US election scheduled for November 3, 2020, and the trade war between the United States and China may adversely affect the Russian economy, according to experts interviewed by TASS.

"On the one hand, the Russian economy might face negative influence from economic turbulence, and on the other hand, a slowdown in the global economy and a corresponding decrease in demand for raw materials due to the US-China trade war," Director of HSE Centre for Business Tendencies Studies

Sergey Khestanov believes it is likely that the United States will try to tighten trade restrictions against China during the presidential election race, which will reduce global demand for raw materials.

"The United States is approaching the presidential election in conditions of a significant economic downturn and a strong polarization of society. All acute political issues are

becoming the subject of the preelection debate. Against this background, attempts to tighten trade restrictions against China are very likely. For Russia, this is a negative factor, since it would lead to a decrease in trade between the US and China, reducing, as a result, global demand for raw materials," he said. According to the expert, an additional risk factor is associated with the possible tightening of anti-Rus-

sian sanctions, which is very likely if a candidate from the Democratic Party wins the election. "However, any effects should not be expected until early 2021, when the president-elect takes office and forms a new administration," Khestanov said.

Geopolitical risks to the Russian economy are rearing their heads again, Head of Analytical Depart-

ment at Zenith Bank Vladimir Evstifeev said. "A Democratic victory in the US presidential election would spell increased sanctions risks. Joe Biden is already speaking in favor of a tougher foreign policy towards Russia," the expert insisted.

US election is not the most significant factor affecting the exchange rate of the Russian currency, Khestanov said.

"The influence of the oil market and the budget process is much stronger. The basic scenario includes a smooth depreciation of the ruble by 5-7% by the end of 2020. However, any significant events related to the dynamics of the oil market and/or changes in budget policy will necessitate a reviewed forecast," he believes.

According to Evstifeev, the main risk is possible sanctions by the United States imposed on the ruble public debt. "In the context of stimulating budget policy, the Ministry of Finance announces an increase in domestic borrowing, so sanctions on OFZs may violate the plans of Russian financial authorities.

In turn, this will negatively affect the dynamics of the ruble, which could lose 10-15% after such sanc-

The weakening of the ruble traditionally spurs inflation and will continue to negatively affect such components of GDP as final consumption and investment," he said.

Experts agree that it is beneficial for Russia that large economies - the United States, China, and the European Union - develop.

#### Merkel's party aims to 'fill 50% of key posts with women by 2025'

## China sees expansion of new businesses, upgrading of new consumption

# Analysts see deep impact from Bolton's tell-all memoir

TWO weeks after the release of the memoir of John Bolton, the former US national security adviser to President Donald Trump, the media and the public are still unceasingly discussing the details of the tell-all book, as it is full of bold revelations of the administration's policies and ideas. With the book ranked first in current US book sales lists, analysts say that its impact on the future of the US should not be underestimated.

The Room Where It Happened, which was released nine months after Bolton's unceremonious exit from the White House, details in 500 pages the current US government's fraught relationship with other countries and its approach to foreign policy objectives, as experienced by Bolton.

At various points in the book, Bolton describes himself as "flabbergasted" or "stunned" by the US administration's ideas or philosophy. Trump has claimed Bolton "made things up", while the director of national intelligence and the Justice Department accuses Bolton of publishing classified information.

According to media reports, the controversial book has sold more than 780,000 copies in its first week to top The New York Times and Amazon top-seller lists, with its publisher Simon& Schuster set to print a total of 1 million copies.

After the release of the book, Bolton was asked in some interviews as to why he saved for the book key allegations he could have shared in testimony during Trump's impeachment trial.

In response, he told the media that he had refused to testify before the House of Representatives unless under subpoena, but House Democrats declined to issue one, fearing the issue would get tied up in the courts. The White House would have likely objected to his testimony, and Democrats were concerned that a decision would be delayed for months.

The book exposes some of the most controversial practices by the US admin-

The most important nugget was Bolton's claim that Trump told him in August last year that security assistance to Ukraine should remain on hold until the country agreed to investigate Joe Biden, now the presumptive Democratic nominee for president, and his son. The claim contradicted Trump's central impeachment defense that holding up the aid and his interest in investigating the Bidens were unrelated.

Less explosive details in the book included Bolton's worries about Trump lawyer Rudy Giuliani's freelancing in Ukraine, and his claim that Secretary of State Mike Pompeo and Defense Sec-

retary Mark Esper joined him in pushing Trump to release the military aid to

According to Bolton, Trump also allegedly said that invading Venezuela would be "cool" and that the country was "really part of the United States".

The details from the book also confirm his public attitude toward journalists, as Bolton writes that Trump told him "these people should be executed" in a meeting where he said that reporters should be jailed in order to find out their sources. "They are scumbags."

## Libya's LNA ready to sign ceasefire agreement but Tripoli is unwilling - Lavrov

#### **MOSCOW**

THE Libyan National Army (LNA) is ready to sign the immediate ceasefire treaty, but the government in Tripoli is unwilling to do so, as it counts on the military solution, Russian Foreign Minister Sergey Lavrov said yesterday following the videoconference with his counterparts from the African Union trio (Democratic Republic of the Congo, Egypt and South Africa).

"At some stage, when we in-

vited the main protagonists, gentlemen [Khalifa] Haftar, [Fayez] Sarraj, [Aguila] Saleh, in January this year ahead of the Berlin conference – the Libyan National Army thought its positions on the ground to be more favorable and was not ready to sign a document that Sarraj considered accept-

Now, the LNA, according to our assessments, is ready to sign such a document on immediate ceasefire, but this time it is the Tripoli government who does not want



to do it, counting on the military solution," he said.

The foreign minister expressed his regret that although all sides declare that there is no military solution to the Libyan conflict, this does not translate into practi-

US tries to hinder appointment of new UN envoy to Libya

The US actions give the impression of efforts to interfere with the designation of a new UN special representative in Libya, Russia's top diplomat stated.

"It's been half a year already that the UN secretary-general cannot appoint a new special representative in Libya. Both Algeria's foreign minister and the former head of Ghana's Foreign Ministry were nominated but the US refused to support them. The impression is that our American colleagues are trying to sideline Mr. Secretary-General Guterres," he said.

The top diplomat noted that currently the acting special representative in Libya is US citizen Stephanie Williams. "It wouldn't do for the US to 'hold down' the UN Secretariat, hindering the appointment of a special envoy counting on their fellow countrywoman to deal with some issues unclear to us," Lavrov stressed.

Libya has had two parallel ex-

ecutive power structures for a long while now. The Tripoli-based Government of National Accord (GNA) headed by Fayez al-Sarraj and the interim government operating in the country's east together with the parliament and supported by the Libyan National Army (LNA) led by Commander Khalifa Haftar. Over a year ago the opposing parties began fighting for the capital city after on April 4, 2019 Haftar attacked the capital in order to rid it of terrorists, as he claimed. **Agencies** 

Footage showed police kicking and beating people with truncheons while protesters pelted officers with stones and bottles, after thousands chanting for the resignation of President Aleksandar Vucic gathered outside the building. Police director Vladimir Rebic said

The government's critics say the government's decisions to allow soccer matches, religious festivities, parties, and private gatherings to resume, and parliamentary elections to go ahead on June 21, are to blame for the spike in infections. They say people should not have to pay the price for another lock-

After Vucic's statement, several thousand people began gathering in front of the parliament in Belgrade's central square.

### US 'strongly supports' ROK-DPRK cooperation - envoy

#### **SEOUL / PYONGYANG**

US Deputy Secretary of State Stephen Biegun said here yesterday that his country strongly supports cooperation between the Republic of Korea (ROK) and the Democratic People's Republic of Korea (DPRK) amid Seoul's efforts to resume inter-Korean cooperation.

"The United States strongly supports inter-Korean cooperation, and we believe this plays an important component in creating a more stable environment on the Korean Peninsula," Biegun told reporters in Seoul after talks with Lee Dohoon, ROK's special representative for Korean Peninsula peace and security affairs, according to Yonhap news agency.

"We look forward to fully supporting the government of (South) Korea as it advances its goals with North Korea in inter-Korean cooperation," the US top nuclear envoy

The ROK is also referred to as South Korea and the DPRK as North Korea.

His comment came as ROK is seeking US support for the resumption of inter-Korean cooperation projects that were suspended under international sanctions on Pyongyang.

ROK President Moon Jae-in offered in late April to the DPRK resuming inter-Korean cooperation by jointly tackling the COVID-19 outbreak, before expanding the cooperation.

Moon vowed in his New Year address to seek realistic ways for a broader inter-Korean cooperation

while continuing efforts for the success of the DPRK-US denuclearization negotiations.

Citing the vision US President Donald Trump and top DPRK leader Kim Jong-un had through summits for the past two years, Biegun said his team will focus on "creating a more durable peace on the Korean Peninsula, transforming relations on the Korean Peninsula, elimination of nuclear weapons on the Korean Peninsula and a brighter future for the Korean People."

Kim and Trump met three times in 2018 and 2019, but the talks between Pyongyang and Washington to denuclearize the Korean Peninsula have been stalled since the Hanoi summit between the leaders in February 2019 ended with no agreement.

"When Chairman Kim appoints a counterpart to me who is prepared and empowered to negotiate on these issues, they will find us ready at that very moment," said Biegun.

"I believe this is very much possible. President Trump has given us his full support to continue this effort," he noted.

Kwon Jong-gun, director general of the Department of US Affairs of the DPRK's Foreign Ministry, said Tuesday that the DPRK was unwilling to talk face to face with the United States, urging the ROK to stay away from meddling in Pyongvang's affairs.

Kwon's remarks reaffirmed the statement issued earlier by Choe Son-hui, first vice minister of foreign affairs of the DPRK, who said last weekend that the DPRK had no interest in holding another DPRK-US summit, which was proposed last week by ROK President Moon, before the US presidential election in November.

Trump said on Tuesday he is

open to another meeting with Kim and thinks it might be helpful, Voice of America reported, citing a transcript of an interview Trump gave to Atlanta, Georgia-based Gray Television, due to be aired on

Kim has been maintaining a low profile in recent months, making far fewer public appearances than usual, according to analysts who monitor his movements.

Yesterday, DPRK state media reported Kim marked the 26th anniversary of the death of his grandfather, DPRK founding leader Kim Il-sung, by visiting Pyongyang's Kumsusan Palace of the Sun, which serves as the mausoleum for Kim Ilsung and Kim Jong-il, father of Kim

Jong-un. The report from the official Korean Central News Agency said Kim, together with other senior officials, paid high tribute to the statues of both leaders, and a floral basket in the name of Kim Jong-un was placed at the statues.

Tensions escalated on the peninsula after the DPRK demolished the inter-Korean liaison office building in the DPRK's border city of Kaesong last month in protest against anti-Pyongyang leaflets sent across the border by ROK civic group activists, mostly defectors from the DPRK. Pyongyang has cut off all communication lines with Seoul.

Biegun arrived in ROK on Tuesday for a three-day visit. He paid a courtesy call earlier in the day on ROK Foreign Minister Kang Kyungwha and held a strategic dialogue with Cho Sei-young, ROK's first vice foreign minister. **Agencies** 

#### US begins to withdraw from WHO amid mounting criticisms, surging COVID-19 cases

#### **WASHINGTON**

THE United States has officially moved to withdraw from the World Health Organization (WHO) as its national count of COVID-19 cases is approaching 3 million with over 130,000 deaths.

On Tuesday, Congress received formal notification of the decision from President Donald Trump, tweeted Democratic Senator Bob Menendez, ranking member of the Senate Committee on Foreign Relations.

"To call Trump's response to COVID chaotic & incoherent doesn't do it justice. This won't protect American lives or interests -- it leaves Americans sick & America alone," Menendez

Stephane Dujarric, spokesman for UN Secretary-General Antonio Guterres, confirmed on Tuesday that the United States had submitted its withdrawal notification to Guterres on Monday.

According to the spokesman, the United States is a party to the WHO Constitution since June 1948, and its participation in the organization was accepted by the World Health Assembly "with certain conditions set out by the U.S. for its eventual withdrawal from the WHO."

"The said conditions include giving a one-year notice and fully meeting the payment of assessed financial obligations,"



said Dujarric.

#### **MOUNTING CRITICISMS**

Trump and his administration have repeatedly assailed the WHO for months and threatened to cut ties with the organization. In mid-April, he announced that his administration would halt U.S. funding to the international health agency.

The administration's move "has few supporters, even from Republicans in Congress," noted Lauren Clason in a story posted on Roll Call, a newspaper and website published in Washington, D.C., on Tuesday.

"I disagree with the president's decision," said Chair of Senate Committee on Health, Education, Labor and Pensions Lamar Alexander -- a top Republican -- in a statement.

"Withdrawing U.S. membership could, among other things, interfere with clinical trials that are essential to the development of vaccines, which citizens of the United States, as well as others in the world, need," said Alexander, the senior Senator from Tennessee.

According to a piece published by the Hill, public health experts and Democrats have also raised alarms that the decision may be "short-sighted and could undercut the global response to the pandemic."

"The timing of the administration's decision has drawn intense scrutiny and is likely to spur questions about U.S. involvement in global efforts to develop a coronavirus vaccine," said the Hill report.

"Abandoning our seat at the table leaves the United States out of global decision-making to combat the virus and global efforts to develop and access vaccines and therapeutics, leaving us more vulnerable to COVID-19 while diminishing our position as the leader in global health," said Thomas File, Jr., president of the Infectious Diseases Society of America, in a statement.

## Hong Kong national security law helps ensure long-term stability of 'one country, two systems'

ON June 30, the Standing Committee of the 13th National People's Congress (NPC) passed the Law of the People's Republic of China on Safeguarding National Security in the Hong Kong Special Administrative Region (HKSAR) and adopted a decision to list the law in Annex III to the HKSAR Basic Law.

As a major move of the central government to manage Hong Kong affairs since its return to the motherland in 1997, the law will fully and faithfully implement the principle of "one country, two systems" and the HKSAR Basic Law, help safeguard national sovereignty, security and development interests, maintain Hong Kong's lasting prosperity and stability, and ensure the long-term stability of "one country, two systems". It bears both practical and historical significance.

The practice of "one country, two systems" has achieved a universally recognized success in Hong Kong since its return to the motherland. However, it has also encountered new circumstances and problems.

Especially since the disturbance

related to the now-withdrawn ordinance amendments concerning the transfer of fugitives in the HKSAR last June, the "anti-China" forces in Hong Kong have publicly supported "Hong Kong's independence," "selfdetermination" and "referendum" and engaged in activities to undermine the national unity and separate Hong Kong from China.

Meanwhile, some foreign and external forces blatantly interfered in Hong Kong affairs, supporting and protecting the "anti-China" forces in Hong Kong and using Hong Kong to damage the national security of China.

The Chinese people, including the Hong Kong compatriots, have realized more than ever that the longterm absence of a national security law in Hong Kong has plunged the special administrative region into the gravest situation since its return to the motherland and that the collusion of "anti-China" forces inside and outside Hong Kong has greatly hindered the long-term stability of the "one country, two systems" prin-

The principle of "one country, two systems" was proposed to achieve and maintain national unity, while safeguarding national security is at the core of the principle.

Enacting the law on safeguarding national security in the HKSAR based on the authorization of the NPC, the Standing Committee of the NPC aims to improve institutional mechanisms related to the implementation of the Constitution, the HKSAR Basic Law, and the NPC Decision on Establishing and Improving the Legal System and

Enforcement Mechanisms for the HKSAR to Safeguard National Security under new circumstances. It will work to plug the legal loopholes, make up for the lack of relevant mechanisms and deal with shortcomings of the HKSAR in safeguarding national security. Besides, it will also prompt the HKSAR to fulfill its constitutional and major responsibilities to safeguard national security, make systematic and comprehensive regulation in legal system and implementation mechanism at both national and the HKSAR levels,


and properly handle the docking, compatibility, and complementarity between the law on safeguarding national security in the HKSAR and relevant national and HKSAR laws.

These efforts are made to fully and faithfully implement the principle of "one country, two systems" and make sure the principle is not distorted in practice and keeps advancing in the right direction.

The legislation on national security is a legislative power of every sovereign state, be it unitary or federal.

# NBA teams on the cusp of having real practices again

No team has had an actual practice yet.

Most of the work that has gone on in those buildings during the NBA's shutdown has been voluntary, and all of it has been of the individual variety – one player working at one basket with one ball. That changes starting Thursday, when the first handful of teams at the Disney complex will be permitted to have full-fledged practices again.

"Every day will be an adventure, a little bit of, 'OK, here's where we are today, this practice will reflect this, tomorrow's practice might be totally different," Houston coach Mike D'Antoni said. "And that's what makes it interesting. It makes it fun. But it's a little bit like a training camp. Every year you know you lay out all these grand plans and about the third practice you go, 'Ooop, they're out."

The teams that arrived at Disney on Tuesday, assuming quarantines are completed and other issues haven't popped up, will likely be permitted to practice sometime Thursday. More teams arrive Wednesday and Thursday, so their first practice sessions, in theory, would be as early as Friday and Saturday respectively.

Teams will be assigned a three-hour window and be able to run practice on a pair of side-by-side courts, with training and weight rooms nearby. Disney staff will clean and disinfect everything after one team leaves, preparing it for the next team to ar-

"Just like with probably everything the league is doing, I think it'd be wise to have a degree of flexibility sprinkled in with everything that you're planning, a degree of being able to either back off or turn it up a little bit, either way," Milwaukee coach Mike Budenholzer said. "But to be honest with you, that happens a lot even in the normal season. There's a plan for the first practice and we'll see how it goes."

Players haven't even been allowed to play 1-on-1 yet at team facilities, per the rules of the individual workouts. That all changes at Disney, where teams will be able to practice for about two weeks before a series of three scrimmages begin on July 22.

The season resumes on July 30. Players have said throughout the shutdown that having only three weeks of actual practice

open for a couple of months, with one ma- Most NBA coaches – D'Antoni, Budenholzer, Dallas' Rick Carlisle and more - are going into this believing that plans have to be flexible.

"It's not going to be a typical training camp where you jump in on Day One and just go full-bore," Carlisle said. "Our players have done a great job of working on their individual conditioning with individual workouts with the coaches on the floor on a 1-to-1 basis ... so I feel really good about where we're at. But this is a different situation, it's a different time, it's a different set

of circumstances." Toronto, the reigning NBA champion, has been on the road for a couple of weeks already, getting their individual work in at a pre-camp of sorts in Fort Myers, Florida. The Raptors couldn't get their pre-Disney work in at home because of travel restrictions that would have applied to players coming into Canada from the U.S.

Raptors coach Nick Nurse said his players haven't dreaded the 1-on-0 work that they've been limited to so far, saying his team has approached these weeks with "great professionalism" and that his plans for Disney are fairly loose right now.

"I don't really know where we're at," Nurse said. "I can see individually. I think we look really good. But, what will that translate to when we get back into, you know, calling plays and running defenses and doing some things? ... I know that I'm sensing they really want to play basketball."

The Los Angeles Lakers arrive at Disney on Thursday, and while coach Frank Vogel isn't looking forward to weeks and potentially months away from his family, he believes the individual workouts have gotten the Western Conference leaders ready.

He said those solo sessions have been designed in large part to get players back into some sort of practice shape, with the hope of being able to hit the ground running when everyone can finally be together again at Disney.

"We just want it to be as high as possible to minimize risk of injury and just further the conditioning along as much as we can," Vogel said. "So, guys have been able to work pretty diligently the last few days or so. And, you know, we're looking forward to wrapping this up and getting on that plane."

# Chelsea cling on to win five-goal thriller, Leicester held at Arsenal

HELSEA moved up to third the Premier League table after holding out to win a 3-2 thriller at Crystal Palace, while Leicester could only manage a draw at 10-man Arsenal on Tuesday.

Frank Lampard's men edged closer to sealing a place in next season's Champions League as a seventh win in eight games takes them one point ahead of Leicester and opened up a five-point lead on fifth-placed Manchester United.

The Blues were fortunate when opening the scoring at Selhurst Park as former Chelsea captain Gary Cahill fell to the ground clutching his hamstring to allow Willian to tee up Olivier Giroud for his fourth goal in six games.

Christian Pulisic's form since the Premier League's restart has led to comparisons with Eden Hazard, the man he replaced at Stamford Bridge, and the Belgian would have been proud of Chelsea's second as the 21-year-old American skipped past Joel Ward and hammered in off the inside of the near post.

"Christian is hugely important," added Lampard. "You look at the top attacking players in the world and they score goals and make assists regularly that win games and at the moment he is doing that, so I am delighted with him."

As so often this season, Lampard's men failed to capitalise on their dominance and were suddenly on the back foot when Wilfried Zaha thundered a shot high past Kepa Arrizabalaga from long range for Palace's first goal in four games.

# Zlatan fires Milan comeback as Juve miss chance to stretch lead

JUVENTUS wasted the chance to move 10 points clear at the top of Serie A as the defending champions blew a two-goal lead to lose 4-2 at a Zlatan Ibrahimovic-inspired AC Milan on Tuesday, after second-placed Lazio's shock defeat at Lecce.

Maurizio Sarri's men led through goals from Adrien Rabiot and Cristiano Ronaldo early in the second half, but were then blown away by a brilliant Milan display as Ibrahimovic scored and had an assist.

Milan coach Stefano Pioli, who could reportedly be sacked at the end of the season, saw his side boost their hopes of European qualification by moving above Roma and Napoli into fifth.

"I am not remotely thinking about August 3 or the future. I am thinking of the next game," Pioli told DAZN. "There have been some tough moments, but I love what I do."

Juve remain on track for a ninth straight title, sitting seven points clear of Lazio with seven matches remaining, but could have rendered the race all but over with a victory.

The loss snapped the Turin giants' seven-game winning run in the league.

Juventus dominated the first half without finding a breakthrough as the closest they came was when Leonardo Bonucci glanced Miralem Pjanic's free-kick wide when unmarked only three yards from goal.

Ibrahimovic had a couple of speculative efforts easily held by Wojciech Szczesny at the other end and also saw a goal ruled out for offside.

The reigning champions burst into life after the interval though, as French international Adrien Rabiot drove forward and fired a fine leftfooted shot from the edge of the area into the top corner to score his first Serie A goal.

Ronaldo doubled the advantage less than eight minutes into the second half, netting for the fifth consecutive game and for the 26th time in Serie A this term with a cool finish.

But Milan were handed a lifeline out of nowhere on the hour mark as Bonucci was penalised for handball, and Ibrahimovic stepped up to score his sixth goal since returning to the San Siro from LA Galaxy in January.

The 38-year-old made it back-to-
