Fuel price hike ignites small businesses panic

FEARS for the stability of small businesses and low income earners making ends meet have risen in the wake of an announcement by the Energy and Water Utilities Regulatory Authority (EWURA) of new cap prices for various types of fuel products.

A number of those interviewed said the new fuel prices would 'paralyse' purchasing power



situation," he lamented.

Bruno Damas, also at the lakeside city, said that the fuel price increase will make life miserable as fares tend to go up and the cost of living is driven up as well, wishing that the government would intervene.

Govt to oversee full participation of local firms in oil, gas industry

ENACTMENT of laws in the energy sector meant to facilitate the full participation of Tanzanian companies in the development of the sector's value chain is among the government's priorities, Prime Minister Kassim Majaliwa said yesterday.

He made this affirmation at the start of the two day Tanzania Energy Congress, the fourth in a series which kicked off at the Julius Nyerere International Convention Centre (JNICC) in the city yesterday.

The government will facilitate acquisition of appropriate technology and ensure that foreign companies in the petroleum sub-sector help to develop the necessary skills, transfer technology and develop local personnel to managerial positions. The government will also establish approaches for local participation in each stage of the value chain so that local businesses

The minister issued the prohibition order yesterday when unveiling the new board of the Jakaya Kikwete Heart Institute (JKCI) at the Muhimbili National Hospital (MNH) compound in Dar es Salaam yesterday, in the wake of consultations after NHIF introduced the new procedure starting this month.

While affirming the good intentions of the


Regional project to enhance weather forecasting - TMA

A 2.5million euro project known as 'Finkerat Finland' is being implemented by the Tanzania Meteorological Authority (TMA) to enhance the capacity of weather forecasting, early warning services and air quality monitoring to improve climate change resilience.

Atupele Mwakibete, the Works and Transport deputy minister said at the launching ceremony yesterday that the project will go a long way into supporting Tanzania's economy which is dependent on climate sensitive sectors like agriculture, tourism, livestock rearing, fisheries, tourism and transport.

The Finland-backed capacity building effort is a regional project aimed at improving the climate resilience of beneficiary countries and mitigate



climate change impacts, he stated.

The project will be implemented in Tanzania, Kenya and Rwanda through their respective meteorological agencies, likely to benefit well over 200m people via strategic inputs in these sectors, as well in hydroelectric power generation, he said.

"The inherent variability of climate system is more pronounced in the tropics, which poses a great risk to the lives, properties and livelihoods of our people," he said, pointing out that the most vulnerable communities are at risk, along with the national economy generally.

Variability of weather and climate systems has contributed to extreme weather and climate events like prolonged droughts and flash floods, such that "with the impact of climate change, Tanzania like many other countries witnesses an unprecedented increase of drought and flood events in their frequency and intensity," he declared.

These events lead to widespread socioeconomic impacts, as World Meteorological Organisation (WMO) data on mortality and economic losses from weather, climate and water extremes of 2020 shows that weather, climate, and water-related hazards accounted for over two million deaths and TURN TO PAGE 2

effectively participate in the sector, he said.

Such measures would ensure that the larger firms implement career development programmes and put in place succession plans for Tanzanians employed in their companies, he said. The series of measures is in line with facilitating the private sector to acquire technical skills for higher participation in the energy sector. Training institutions need to impart the necessary skills and a knowledge base on energy business to local entrepreneurs and experts.

Establishment of a regional natural gas infrastructure and investment in renewable energy in addition to local content development were equally important strategic issues in the sector, he said.

Skills and capacity building for small and medium scale enterprises (SMEs) was vital, he said, pointing at the major priorities of the government in the energy sector as the construction of East Africa Crude Oil Pipeline (EACOP) from Hoima in northern Uganda to the port of Tanga. The other project is building a Liquefied Natural Gas (LNG) plant at Likong'o Mchinga area in Lindi region.

"However, these sources will not automatically be a blessing without having a clear vision and mission backed up with appropriate policy, legal and institutional framework that guides the entire value chain of natural gas exploration and exploitation," the premier asserted.

Energy minister January Makamba said the congress is a vital forum in raising awareness and promoting investments in the energy sector, starting from electricity to oil and gas, and a scatter of other concerns.

"It is obvious that this gathering will enable stakeholders of the oil, gas and power sectors to deliberate on the energy business in the country and in particular.

worldwide," he stated.

The main elements of the Tanzania Energy Policy (2015) include developing domestic energy resources as least cost options, promoting lower energy pricing, along with improving energy reliability, security.

Enhancing efficiency, energy encouraging local private sector participation in the energy value chain, reducing deforestation and developing human resources are vital goals for the sub-sector, he said.

the solar stove can be used in all regions with long periods of sunlight including Njombe, Iringa, Mbeya, Dodoma and Singida regions," he said.

The Second Report on the Environment Situation issued in 2014 showed that more than 46,942 hectares of forest area are destroyed due to charcoal making and farming activities.

Iringa Region's natural resources and Tourism Officer, Dr Bahati Goliama said the region has lost more than 281bn/in 2021 due to wanton setting fires to forests. He said if the forests hadn't been burned and its trees allowed to reach 16 years old, the region would have earned 491bn/-.

Nchemba orders TRA officials to work for solutions to challenges facing Kariakoo traders

Dr Mwigulu Nchemba, Finance and Planning minister has directed the Tanzania Revenue Authority (TRA) to work on the various challenges facing traders at Kariakoo market to stimulate businesses to attract sellers and buyers from within and outside the country.

Dr Nchemba gave the order yesterday during his impromptu visit at the market accompanied by Ilala legislator–Mussa Zungu, Ilala District Commissioner, Ng'wilabuzu Ludigija and top officials from TRA.

His directive followed complaints raised by traders whereas most of them raised concerns over frequent and unfriendly inspections by TRA officials which had affected foreign businesses.

They claimed that foreign traders are being harassed by the officials saying the receipts given to them were not genuine, resulting in their luggage to be held.

They asked the minister to intervene in the matter to revive and stimulate businesses at the market. Traders also asked the government to consider revising the estimation rate for a trader to be registered as a Value Added Tax (VAT) taxpayer from 100m/- to 500m/-. To reduce tax payment challenges,

the traders suggested for the government to make sure all the taxes are paid at the port upon arrival of consignments. They also complained over unfaithful TRA officers who have been asking for bribes from them.

Ilala MP, Mussa Zungu who doubles as Deputy Speaker urged the minister to take stringent measures against unfaithful TRA officers demanding bribes from traders because they deny the government a lot of revenues.

Zungu advised the government to consider revising the VAT rates

to enable traders to pay taxes easily and voluntarily. He said the move will promote businesses and enable traders to make profits.

In his response, Dr Nchemba directed TRA officials to meet with the traders saying the government is determined to improve the business environment since it is aware of its contribution to the country's economy and job creation.

He said in the 2023/2024 financial year, the government will make changes in its tax payment systems as well as reducing the VAT rates. He said the current 100m/- rate required for a trader to be registered from VAT is small compared to businesses conducted at the market.

"We are going to take stringent legal measures against dishonest officials demanding bribes from traders. You should report them to relevant authorities," he remarked.

Dr Nchemba promised the traders that he will return to the market in near future with intentions of listening to their concerns and challenges. He said the aim is to make sure Kariakoo market continues to contribute to the government's income and the economy of individual traders.

RA's Commissioner for Domestic Revenue, Herbert Kabyemela promised to work on the challenges presented by traders, adding the major challenge facing authority is the issue of deceitful traders, especially in issuing receipts of the real prices of the products they have sold.

UNAIDS report paints gloomy picture on HIV/Aids infections

NEW report from the Joint United Nations Programme on HIV/AIDS (UNAIDS) for 2021 says young women and adolescent girls in Africa are still faced with HIV infections, that every two minutes a girl gets infected.

The report, dubbed "In Danger" was unveiled July 28 this year before the 24th International AIDS Council (IAC) in Montreal, Canada.

According to the report, UNAIDS found 1.5 million people with new infections while women made 49 per cent for that year, with sub-Sahara Africa recording 63 per cent.

In these countries women, girls and young women were three times more liable to be infected with HIV than male youths.

In addition, during two years of the Covid-19 pandemic and other world disasters, the fight against HIV/AIDS slumped, resources thereof diminished and millions of lives were exposed to danger

UNAIDS says apart from the drop in investments there was little drop in regard to new infections by 3.6 per cent only between 2020 and 2021, with very dismal new yearly infections since 2016.

However adverse effects of HIV gender-wise especially to young African women and girls happened due to the suspension of essential HIV/ AIDS treatment.

In addition, efforts in ensuring

people living with HIV/AIDS get treatment to save their lives slumped. UNAIDS Director General Winnie Byanyima, said: "These statistics show that the fight against HIV/AIDS is in great danger if we cannot take immediate steps, the disaster flourishes within the Covid-19 pandemic, we should imagine the millions of deaths that could be prevented."





Joint ventures, stock listing key to Tanzania-Zambia rail, pipe uplift

NEW epoch is dawning visible in other areas, for instance in bilateral ties between Tanzania and Zambia, in the wake of the short visit by President Hakainde Hichilema in Dar es Salaam, with accords signed that may change the picture in the two vital infrastructure units, the railway line and oil pipeline. For one thing, the rail line is already of the standard gauge level, thus likely to be adaptable to modernised speed trains, despite that this much wasn't being discusses as yet. It is as if the projects need a new coat of paint.

The revitalization of ties between the two countries to take a higher economic profile is partly a result of a changing international situation that is pushing African countries to become as self-reliant as they can manage. That obviously won't be realized in a day but there has to be preliminary measures, where the quest to uplift five decades old infrastructure to be aligned to modern logistics requirements is a major step. When it is done, it provides a foundation for an industrialization thrust

The wider picture of the accords on the rail and pipeline infrastructure was the wish to work closely with Zambia in promoting trade and investment, which starts with logistics and anchors in the removal of trade barriers. In her remarks, President Samia Suluhu Hassan said the two countries have agreed to mobilize resources to revive the railway line to make it modern, lessening the pressure on roads in the two countries. When transport costs are lessened, so are prices, and that provides a better atmosphere for industrial investments, thriving on low costs

A measure of goodwill was equally

as the two leaders agreed to liaise to remove trade barriers by reviewing custom duties and cross border levies on goods carried by small scale traders. At first, traders from both countries crossing the respective border points will be serving small markets within the vicinity, and then to the respective capital cities or major cities generally. Then they will discover that some of the goods have a market if one crosses another border to the west, and reciprocally. It is the African Continental Free Trade Area (AfCFTA) being realized with a giant step of reviving dormant infrastructure being used at sub-optimal level, eliminating barriers, widening reach.

Equally noticeable was likely cooperation in supplying processed meat for the beef market in Saudi Arabia with joint venture initiatives. For one thing, the joint venture model is also applicable to uplifting infrastructure, to lessen loan burdens on concessional and non-concessional lenders. It is something to be pursued later.

When a workable joint venture format is in place and cutting across a range of strategic activities, not just meat processing, it will be easier to dream of southward bound industrialization, now visible in the coastal area, more or less. The presence of iron ore (without direct back up of coal in the current situation) is in need of a workable costing structure to host a few industries that can feed budding iron-based industries in the region. The dream goes back to the 1970s, but it appears there was a half a century lag between the dream and the basics of its coming into reality being put into place.

URUNDI, which marked 60 years of independence on 1 July 2022, ranks as the poorest country on the planet in terms of GDP per capita. This must be understood in the light of a history punctuated by political upheavals. Until 1996, the country lived to the rhythm of coups, massacres and political assassinations - before plunging into a long civil war.

STAMICO coal-based 'charcoal' will push up environment agenda

experts have been suggesting since the environment debate started having a profound impact on policy making are on the way to being realized. One such idea is the plan being pursued by the State Mining Corporation (STAMICO) to start supplying alternative charcoal sold at lower prices compared to wood charcoal, making it friendly to environmental conservation. The 50year old parastatal has for some reason discovered this potential large scale use of coal.

Top officials of the corporation unveiled this plan at the start of a ten day festival to mark 50 years since it was created, noting that this alternative product has the capacity to remove from the market wood-based charcoal. A number of critics were arguing for that approach but the dominant approach among environmental activists was to spread the use of stoves consuming less charcoal.

How far this was achieved is a bit unclear, but it focused more on household costs and especially the gender mainstreaming aspect, costs of women-led houses, not environment per se.

At the same time there are wider conditions for a turn of perspective on the part of STAMICO, given that for many years their most cherished project was to generate 600MW of power from coal. With the Nyerere power project and current global outlook, it is unlikely they can find such investors. 'Selling charcoal' is an option.

The project outline indicates that the coal-based product will be produced in excess of current levels of charcoal demand to meet domestic cooking needs or roadside roasting activities. Four production facilities will be installed in the course of this financial year of what is code-named

HINGS that a number of '(environment) friendly briquettes' made from timber powder, maize and other husks along with a coal base. This has always been the standard format but it isn't as lucrative as a megavolt power plan.

So each idea has its local and global conditions, as what planners think of this or that economic venture has to do with financing and market opportunities locally and abroad. So despite that coal isn't down and out as yet, alternative uses needing careful planning and prudent use of resources are seeing the light of day. Taking 50 years of being aware of the coal deposits before coming up with a public resources idea to use the coal to replace firewood shows how good ideas germinate slowly.

When the plan is formally launched next week in the capital, environmental control shall have moved a step higher, from planting trees to figure out stopping all wood charcoal making countrywide. There are technical or scientific issues involved like crushing the coal to get powder to mix with dry materials like sawdust or maize cob core, while the husk can be fed to cattle. Creating a network of supplying the raw materials is an even more challenging task than the marketing parameter as here only the price matters, and the briquettes being friendly to cooking pots. As for the rest, those now selling charcoal will shift to 'alternative charcoal,' period.

It should also be expected that there will be firm guidance on the matter so that no stakeholders should come up and object to the plan. If they want to sell wood from planted trees harvested periodically, the right price need to be set for them to supply to the new producers. Allowing competition with old charcoal is negative, as if the quality aspect and the pricing is right, people can be encouraged to shift.

I have studied the politics and economies around the Great Lakes region for more than 40 years - including the links between governance and poverty. The countries that form the region are Burundi, Rwanda, Democratic Republic of Congo and Uganda. , Democratic Republic of Congo and Uganda. It's my view that the end of the Belgian and British colonial empires upset the political, economic and social frameworks of the two nations formed out of the former Ruanda-Urundi colonial entity.

Present-day Rwanda and Burundi served as reservoirs of labour for the exploitation of the wealth of the vast agricultural and mining areas of the Belgian Congo to the west and the British colonies in the east. Refocused within their borders following independence in the 1962, they were reduced to small, overcrowded and landlocked micro-states.

Burundi is a country familiar with various military regimes since independence. These regimes have succeeded in appropriating state resources while ordinary citizens mostly rural farmers - have borne the brunt of the civil war.

The divide that has emerged between military elites and "people of the hills" - as rural farmers are commonly referred to - runs deeper than ethnic and regional differences. The peasantry still provides almost all the resources of the party-state. But most of the agrarian policy decisions are taken without consultation, including at the grassroots levels where party delegates, often peasants, do as directed.

The state has imposed itself as the exclusive economic operator. Civil servants and party cadres programme and direct investments. Ordinary people are for the most part powerless.

Nkurunziza's missed opportunity Following the gradual return of peace nearly 20 years ago, Pierre Nkurunziza was elected president in

2005. Drawn from the majority Hutu ethnic group, Nkurunziza ended 25 years of pro-Tutsi military regimes. The minority Tutsi make up 14% of the population and the Hutu 85%. In the next five years, the president and his party - the National Council for the Defense of Democracy - Forces for the Defense of Democracy (CNDD-FDD) went about consolidating power.

Hopes for stability were stronger at the next election in 2010. For the first time in the country's history, voters were called upon to vote at the normal end of an electoral cycle. CNDD-FDD secured another mandate thanks to a divided opposition and the charismatic personality of the incumbent president, who enjoyed massive support from rural populations.

A party that had managed to reconcile ethnic divisions and to integrate the armed forces with former rebels now had a resounding national mandate.

Unchallenged, Nkurunziza concentrated power in his hands under a de facto one-party state. A youth militia loyal to his party kept an eye on dissent among local populations and neutralised any organised opposition. But the mood soured quickly when Nkurunziza sought a "third term" in the 2015 elections, contrary to the constitution.

A popular protest was immediate and strengthened despite the mobilisation of the police. Within weeks a failed military coup laid bare the fractures within the armed forces. A violent repression followed in which freedom of expression and independent media were crushed.

In July 2015, after elections "neither free nor credible" according to the UN, the CNDD-FDD exceeded the two-thirds majority in the National Assembly.

Nkurunziza's victory was Burundi's loss. Amid the repression of opponents, the country's economy slowed down, foreign capital took flight and infrastructure crumbled. There was looting of public resources and a sharp reduction in social benefits.

At the end of his third term, the leaders of the CNDD-FDD party were happy to see the back of the "eternal supreme leader" who had become a liability.

The electoral rescue of 2020

Burundi's GDP had been battered badly during the civil war, which ended in 2005. It was on the rise for ten years from 2005 to 2014. Following the Nkurunziza-instigated political crisis in 2015 the economy dipped sharply again. Ranked second poorest country in the world in 2013 and 2014, it fell to the poorest in 2015 and has remained there ever since.

The UN Human Development Index, which measures longevity, education and inequality, also attests to this deterioration. Burundi was ranked 180th in 2015, falling to 185th in 2019 and 2020.

Thus, in almost all socio-economic measures, Burundi's performance is among the lowest on the planet thanks mainly to conflict and elite corruption. The failed coup of May 2015 upset a delicate balance in which the army were jointly managed. Pro-Nkurunziza democratic country.

elements in the army who crushed the coup sensed an opportunity for self-enrichment to match the fortunes of their senior Tutsi colleagues and graduates of military schools.

Hitherto contained or concealed, this "financial catch-up" was transformed into an open competition for personal enrichment commensurate with each person's powers.

In May 2020, General Evariste Ndayishimiye, a wise and withdrawn man, became the new president. Nkurunziza died shortly afterwards officially from COVID-19, a disease whose danger he had always underestimated. Burundi, on the other hand, continues to suffer the effects of Nkurunziza's political legacy.

Struggle between elites

Having experienced since independence all forms of divisions that can be exploited by authoritarian regimes, the "people of the hills" now know that their lot is the result of struggles between elites for the capture of national resources.

Only the re-appropriation of the state, to make it legitimate once more in the eyes of the population, could free resources for their purposes.

This implies that peasants emancipate themselves from co-opted administrative and economic bureaucracies which have appropriated power and wealth by force, first for the benefit of a Tutsi and then of a Hutu elite. Burundians need to impose themselves through free and credible elections as self-organised including former rebels - and the police citizens responsible for the future of a

LOBAL wheat consumption is headed for its biggest annual decline in decades as record inflation forces consumers and companies to use less and replace the grain with cheaper alternatives, amid growing food insecurity.

Consumers may face even higher wheat prices in the second half of 2022 as importers, who until now have supplied cargoes bought several months earlier at cheaper prices, pass on the costs from when wheat prices scaled decade highs in May.

Global wheat consumption in July-December could drop by 5-8 percent from a year ago, analysts, traders and millers say, much faster than the US Department of Agriculture's forecast 1 percent contraction.

"There is going to be a drop in wheat demand for animal feed in Europe.. Wheat demand for human consumption has also slowed in key importing countries around the world," said Erin Collier, an economist at UN's Food and Agriculture Organisation.

"High prices have raised food security worries in parts of Asia and Africa where countries are not able to secure enough supplies from the international market.'

Millions are facing mounting food costs and insecurity after the Russia-Ukraine conflict started and adverse weather in key exporting countries drove cereal prices to all-time highs.

Benchmark wheat futures jumped 40 percent this year to a record high in March before retreating recently, though physical prices remain high.

Wheat shipments from the Black Sea region are quoted at around \$400-\$410 a tonne, including cost and freight for delivery to the Middle East and Asia. Prices are down from a peak of about \$500 a tonne reached a few months ago, but remain well above last year's

"Wheat supplies are still super tight," said Ole Houe at brokerage IKON Commodities in Sydney. "We are not sure how much wheat is going to come out of the Black Sea and there is adverse weather in other exporting countries."

baker in Jakarta, is paying around 10,000 rupiah (\$0.6720) per kilogram for wheat flour, up from around 8,200 rupiah earlier this year.

"I had to increase my selling price... but I fear that higher prices will discourage consumers," she said.

Switching out

As consumers cut purchases, bakers and noodle manufacturers are replacing wheat with rice.

"Wheat flour prices are almost at par with rice - automatically there will be shifting," said Franciscus Welirang, chairman of the Indonesian Flour Millers Association.

He noted the last time wheat flour prices rose significantly, Indonesia's consumption dropped by 4.5 percent. While wheat prices have jumped, Vietnam's 5 percent broken rice was quoted around \$404 per tonne, largely unchanged from late 2021.

Brazil, the biggest market for US wheat, saw purchases decline more than 3 percent in January-June period, even though the country paid 20 percent more for the staple, data showed.

"In the northeast of Brazil, maybe consumers will replace wheat products with regional ones, like tapioca," said Roberto Sandoli, senior risk manager at HedgePoint Global Markets.

Animal feed

Red-hot wheat prices are also

changing ingredients livestock farmers use for animal feed.

The French Farm Office FranceAgriMer forecasts demand for wheat feed is likely to drop 13 percent to 3.9 million tonnes in 2022/23 from 2021/22.

"The drop in EU wheat consumption is mainly the consequence of very cheap corn," said Helen Duflot, analyst with Strategie Grains. "Then of course, there is the economic issue."

In Vietnam, one of the world's fastest growing animal feed markets, rice is replacing wheat.

One purchasing manager at a mill in Ho Chi Minh City said they have been asked by the government to source alternatives amid supply chain disruption.

Thailand had earlier this year increased its corn import quota to 600,000 tonnes from 54,700 tonnes, and cut import duties to alleviate a tight feed market, Bangkok-based traders said.

In response to changing feed use, the USDA in July cut its global wheat consumption forecast for the 2022/23 marketing year to 784.22 million, down 1.77 million tonnes from its June estimate and 6.29 million tonnes below the prior year.

Black Sea hit

Buyers in Africa and the Middle East have been impacted more than other consumers by Black Sea disruptions since the Ukraine crisis began, and have been forced to switch to higher-priced suppliers such as Germany and France.

There are hopes of a resumption in Black Sea supplies after Russia, Ukraine, Türkiye and the UN signed a deal last week to unlock Ukrainian grain. The first grain ship to leave Ukraine safely anchored off Türkiye on Tuesday. But the market remains sceptical about Black Sea trade making a more meaningful return.

Africa needs to forge unified approach to Russia before 2023 Russia-Africa Summit

URING five days in July 2022, Russia's Foreign Minister Sergey Lavrov travelled to four African nations to signal Russia's push into the continent. The visit to Egypt, Democratic Republic of the Congo, Uganda and Ethiopia symbolises the Russian offensive to gain and reinforce international support.

Ramping up ties with Africa

The first Russia-Africa Summit, co-chaired with Egypt in Sochi in 2019, was an attempt to strengthen partnerships between Russia and the continent. Forty-three heads of state attended. A second summit was expected to be held in late 2022. Due to developments in Ukraine, it is now scheduled for mid-2023.

In the aftermath of Russia's invasion of Ukraine, African



was around \$2.7-trillion, while Russia's amounted to about \$1.7-trillion.

Perhaps the most important way forward is for African countries to work in cooperation with one another. Thus, developing relationships beyond short-term impact is critical to ensure the continent is not dominated by other global powers' interests.

The promise of enhanced integration through the African Continental Free Trade Area is a substantial opportunity for the continent. As seen in Europe, North America and South America, strengthening regional integration yields results beyond trade measures. It also creates a space for interdependence, where African states see one another as partners in a competitive global market.

strategy. To that end, the AU can and should - engage with its members in a more structured manner and help them put together joint positions on critical issues related to Russia and other partners, like the US, China, Europe and others. The first step in this direction

should be strengthening the AU's Partnership Management and Coordination Division. The division can serve as a more appropriate place for reflection on how its member states can bet-

ThE trip has underscored the importance for African countries to develop well-crafted positions when engaging with external powers. Without this, Africa risks being caught up in geopolitical disputes, diminishing its global voice and agency.

As the Kremlin's relationship with the West deteriorated after the annexation of Crimea in 2014, Russia expanded its engagement with other countries, particularly in the Global South. While the July 2022 engagements in Africa yielded few tangible outcomes, Lavrov reinforced the criticism of Western policies in Africa, with a complementing narrative of the independent stance Africa has taken.

states faced criticism for their voting at the UN General Assembly. In March 2022, the General Assembly adopted a resolution denouncing Russia's invasion. Some 48% of African member states abstained (or did not vote), and 48% of member states voted in favour of the resolution. Significantly, no African state has imposed sanctions on Russia since the beginning of the war.

Russia has been ramping up its military relationships with several African countries for at least a decade. Its approach is often influenced by close ties between Russia's arms industry and its infamous private security contractor, the Wagner Group.

According to Sipri, a Swedish think tank. Russia was the largest arms supplier to Africa in 2021, accounting for 44% of continental imports of major arms. In total, Russia has signed military agreements with more than 20 African countries. While Russia is not among Af-

rica's largest trading partners, its presence cannot be discounted. It is estimated that in 2020, Russia's trade with African countries amounted to more than \$14-billion, with Egypt accounting for

about 30% of this total.

Economically, the sharp increase in international grain prices has been particularly punitive, as Ukraine and Russia are two major producers and exporters. Between 2018 and 2020, some 32% of Africa's wheat imports came from Russia and 12% from Ukraine. The added impact of global inflation, rising oil prices, drought and the Covid-19 shock could have a catastrophic effect on the continent.

The June visit to Russia by the AU's 2022 chair, Senegalese Presi-

dent Macky Sall, contributed to the July agreement between Russia and Ukraine (facilitated by Turkey and the UN) to attempt to restore trade in the Black Sea.

Collective action

It is not hard to see why taking sides is problematic for African states. But, while the Russian economy and size of its military are much larger than that of any single African country, collectively, the continent can hold more sway. In 2021, Africa's collective GDP

Overcoming passivity

Given the continent's relatively weak global position, it would be naïve to expect African countries to take a common position on every topic related to Russia. However, there is a need to overcome the current passivity in the relationship and work towards establishing a more structured and effective communication channel. Africa urgently needs a Russia

ter advocate for the continent's needs, and ensure African voices are heard in discussions with countries like Russia.

Russia's role in Africa is expected to remain controversial and contested. It is clear that Russia knows what it wants from the continent: access to markets, political support and general influence. Now it is time for the continent to clarify what it wants from Russia in return.

In the lead-up to the 2023 Russia-Africa Summit, the AU and its member states should strengthen their positions regarding external partnerships. If not, the continent risks being left behind and used as a pawn in an increasingly divided global order. **DM**

Kili challenge fund redeems hundreds of youth, orphans

A Number of organizations engaged in controlling the transmission of HIV/Aids have benefited from the money generated through GGM Kili Challenge Campaign since its inception in 2002.

Most of the benefited organizations have been reaching various groups of mothers, young people and children, who in one way or another have been affected or are at risk of being affected by HIV/Aids.

Founded by Geita Gold Mining Limited (GGML) in collaboration with the Tanzania Commission for AIDS (TACAIDS), the campaign has continued to be a great help to the organizations considering that since its inception 11bn/- have been collected.

Started 20 years ago, the campaign is meant to collect money every year to contribute to the efforts of the government towards achieving the three goals of zero in the sense of zero per cent of new infections, zero stigma and zero deaths from HIV/Aids.

Rainbow Center, which is owned and operated by the Catholic Diocese of Moshi is one of the organizations that have benefited with the funds by receiving a grant of 30m/-.

The center Coordinator, Winfrida Tillya described the fund as a redeemer, saying it will help them to provide reproductive health education to 20,047 people, among them, 7,418 are men and 12,629 women.

She said beneficiaries will be from different areas in Moshi Municipality including Kilema, Kibosho, Hai and Himo.

"It has also enabled us to provide counselling and tests to 2,452 people," she said.

"We've distributed food such as rice, corn and beans to 100 victims living in difficult environments as well as 100 orphans. We have also given health insurance to 100 children and distributed learning materials to 100 vulnerable children including those who have been selected to join A-Level secondary education."

One of the children served by the Rainbow Center-Moshi, Hosea Patrick, a Form Six leaver commended the support saying it is through the assistance he has been able to perform well in national examinations.

The GGM Kili Challenge fund has also benefited the

This year, GGML collected 1.1bn/- through the GGM Kili Challenge 2022 campaign which is meant to provide education about HIV/Aids to complement the government's efforts to reach three zeros- new HIV infections, AIDS-related deaths and discrimination.

This year's campaign involved 52 participants, of whom 28 climbed Mount Kilimanjaro on foot and 24 cycled around it using a bicycle through the Machame gate and descended to Mweka.

Simon Shayo, AngloGold Ashanti's Vice President (Sustainability) Tanzania and Ghana said: "This year's campaign has been a unique success."

It was officially launched on June 29 in Dodoma and was followed by a donation drive for the campaign that took place on July 14 and then July 15, 2022, participants were allocated for the mountain climbing exercise, which also involved provision of testing services and vaccines for residents of Moshi town and the Kilimanjaro region in general.



Findings further revealed that people close to children are the major perpetrators of sexual violence against children, including family relatives, uncles, stepfathers and fathers, bodaboda drivers and teachers.

Government statistics for the year 2021 indicate that incidents of violence against children (VAC) decreased from 15.870 in 2020 to 11.499 in 2021, a decrease of 27.5%

Out of the 11,499 reported incidents, 85% involved female victims and the remaining 15% were male victims. Over 60% of incidents were rape cases, approximately 13% sodomy cases.

26% of the incidents recorded in Arusha, Tanga, Shinyanga, Mwanza, and Ilala Police Regions.

Rape incidents decreased from 7,263 in 2020 to 6,305 in 2021, equal to a decrease of 13.2%.

A study by End Child Sexual Exploitation (ECPAT), the International Criminal Police Organization (INTERPOL); and the United Nations Children's Fund (UNICEF), revealed that approximately 200,000 children were victims of grave instances of online sexual exploitation and abuse in Tanzania in 2021

3% of internet-using children aged 12-17 surveyed were offered money or gifts to engage in sexual acts in person. 2% of the surveyed children were offered money or gifts in exchange for sexual images; 3% were asked to share images and videos showing their private parts to others.

Law of Marriage Act, 1971 remained unamended, more than two years since the decision of the Court of Appeal of Tanzania. calling for amendment of the law to abolish child marriage.

THE youth will drive Africa's digital economy; hence the need to invest in their skills development to accelerate innovations and growth on the continent, African Development Bank director general for East Africa Nnenna Nwabufo has said.

Speaking at the 9th World Financial Innovation Series in Nairobi, Nwabufo noted that the youth are ambitious, enterprising, and eager for change.

"Africa's young people are the institutions to discuss ways of most avid adopters of ICTs and digital solutions," she said.

Recent statistics show that 60% of Africa's population is below 25 years old. "We anticipate a future that will be very different from today in terms of innovation, enterprise, and job and wealth creation," Nwabufo added.

The two-day event brought together around 1,500 technology and business heads from banks, insurance, and micro-finance

accelerating financial innovation for a digital and futuristic Africa.

Nwabufo called for the scaling up of startup investments across the continent to grow tech entrepreneurs and enhance financial inclusion. She noted that the number of tech hubs had increased dramatically, with the largest concentration in South Africa, Nigeria, Egypt, Kenya, Morocco, and Ghana.

Siberian tigers been frequently have spotted in the forests in the east of northeast China's Jilin province over recent years. The frequent appearance of the predator at the top of the food chain mirrors China's improving ecosystem. For a long time, Jilin province has been taking huge efforts to protect the authenticity and integrity of its natural ecosystem, including Siberian tigers, Amur leopards and other wildlife, so as

to preserve the biodiversity and natural ecology in the area. In 2017, the pilot system of the Northeast China Tiger and Leopard National Park was officially launched. Four years later, the park was listed as one of the first five national parks in China.

Spanning Jilin and its neighboring Heilongjiang province, the national park covers an area of 14,100 square kilometers, with forest coverage of 97.74 percent. It is the only stable habitat and source of wild Siberian tigers and Amur leopards in China

Over the years, Jilin province has thrown in a great deal of manpower and material resources to restore and maintain the forest ecology. It has prohibited commercial logging of all natural forests and shut down mining enterprises in forests to provide a free habitat for Siberian tigers and Amur leopards.

According to statistics, since the pilot system of the Northeast China Tiger and Leopard National Park was launched, 400 hectares of climax forestry communities have been restored or cultivated and 2,000 hectares of Korean pines have been planted. Three wildlife passages have been built.

Jilin province has also returned 2.243.21 hectares of forests and restored 620.91 hectares of ecology at mining sites.

A qualified national park requires not only a sound ecological environment, but also advanced monitoring methods and protection practices.

Feng and his team have established an integrated monitoring system for the Northeast China Tiger and Leopard National Park, which includes nearly 30,000 infrared cameras and employs modern communication, cloud computing, artificial intelligence and big data technologies.

The system is able to capture realtime images and footage of wildlife and acquire information about biodiversity, ecological elements and human activities. Over 6,800 rangers are on patrol missions in the park to record GPS waypoints and video data and protect

the safety of wild animals with the help of the system.


Huge changes had taken place in the park between 2017 and 2021. The quality of the park's ecosystem was further enhanced, while grazing and other human disturbance were on a decline. A rapid increase was recorded in the number of herbivore animals, such as sika deer, which helped recover the food chain.

In the past, only 33 percent of the Siberian tiger cubs in the park could grow into adulthood, while the figure has surged to over 50 percent today. Stable activities of Siberian tigers and Amur leopards are recorded now in over half of the areas in the park, and Siberian tigers are seen on almost every mountain in Huichun, a core zone of the national park.

It was predicted 10 years ago that wild Siberian tigers might become extinct in China. However, according to monitoring data, as of the end of 2021. the numbers of wild Siberian tigers and Amur leopards in the park had increased to 50 and 60 respectively from 27 and 42 in 2017. Over 10 tiger cubs and 7 leopard cubs were spotted.

"From now on and till 2025, we will integrate nature reserves and stateowned forest farms, launch habitat restoration programs, and build ecological corridors for Siberian tigers and Amur leopards, so as to enhance the suitability and connectivity of the habitats for the big cats and strive for steady reproduction of them," said an employee with the Northeast China Tiger and Leopard National Park

KCB Bank targets Equity with Sh15bn DRC bank acquisition

NAIROBI

CB Group has agreed to acquire a majority stake in a top bank in the Democratic Republic of Congo for an estimated Sh15 billion, opening up a fresh battlefront with Equity Bank in the vast mineral-endowed central African country.

KCB, which already has operations in Rwanda, Burundi, Tanzania, Uganda and South Sudan, said it had reached a deal to acquire an 85 percent stake in Trust Merchant Bank and plans to buy the remaining shares within two years.

Kenyan commercial banks are looking beyond their borders for acquisitions, seeking to tap opportunities in Eastern and Central Africa on the back of rapid economic growth and trade integration, with DRC the fresh target.

The deal will see KCB in to head-to-head with Equity, which entered the DRC in 2015 through a buyout and increased market share in 2020 after acquiring another lender--Banque Commerciale du Congo (BCDC).

The banks have for long coveted Africa's top copper-producing country, attracted by opportunities in lending, fees and transaction incomes in the lucrative market.

Equity, the only local lender with a presence in DRC, earned Sh4.6 billion gross profit, which is larger than the combined earnings of Sh4.4 billion that the seven Kenyanbanks earned in Uganda.

"The transaction is expected to close by the end of the third quarter of 2022, subject to regu-

latory, shareholders and other approvals," KCB Group chairman Andrew Wambari Kairu said in a statement.

"This will see KCB acquire 85 percent of the shares in TMB while the existing shareholders will continue to hold the balance for a period of not less than two years after which, KCB will acquire their shares."

KCB did not disclose the value of the deal but said it would buy the majority stake at 1.49 times the book value of Trust Merchant Bank. Three analysts contacted by the Business Daily estimated the deal to be worth between Sh15 billion and Sh20 billion.

Equity in 2019 paid Sh10.7 billion to a wealthy family to acquire a 66.5 percent stake in BCDC. The Kenya bank already had a subsidiary in DR Congo, which it acquired in May 2015, and integrated the two banks in a merger that created the second largest bank in the Central African nation.

Trust Merchant Bank is the third largest bank and is based in Lubumbashi, which hosts many of the DRC's biggest mining companies. The country produces more than three percent of the world's copper and half its cobalt, most of which comes from the Katanga region.

DRC is one of the biggest countries on the continent by land mass and has more than 90 million people, making it appealing to ambitious lenders looking for growth on the continent.

The market is mainly focused on serving big companies with operations there, making it necessary to have a big balance sheet to be able to compete and grow, said an analyst

Higher interest rates a 'bright spot' for Europe's banks

EUROPEAN banks are hoping the boost to their businesses from higher

interest rates will be long-lasting as they navigate the economic fallout of war, soaring inflation, and a looming energy crisis.

The German lender Commerzbank on Wednesday reported a bigger-thanexpected second-quarter net profit that it said was especially helped by higher interest rates.

Exhibiting a trend seen across Europe, Commerzbank's net interest income jumped 26% in the period from a year earlier as longer-term interest rates rose in Germany and as the central bank in Poland, where it has a big presence, hiked official borrowing costs.

Manfred Knof, the bank's chief executive, described "considerable" risks on the horizon, but singled out interest rates as a "bright spot".

For years, bank executives on the continent have bemoaned the European Central Bank's ultra-low monetary policy and charging of fees to park their cash as a drag on their bottom lines.

But now, central bank efforts to arrest runaway inflation rates across Europe are proving a change of fortune. Banks from Spain to Britain are only just starting to benefit from the increased gap between what they charge borrowers and what they pay savers.

"Higher interest rates will strongly benefit all European banks' net interest margins and overall profitability, but the effect will be gradual and will vary between countries," Moody's said in a recent report.

Moody's pointed to banks in Spain, Italy and Portugal as among those that will in particular profit from higher rates because more bank loans there are variable rate, giving lenders a "more pronounced increase in bank revenues".

The higher income is bolstering executives' confidence about revenue, even as European officials cut growth forecasts amid soaring inflation and business activity contracts.

In Spain, Bankinter raised its guidance for net interest income from a low singledigit to a mid-to-high single-digit percentage growth for 2022, and Banco Sabadell

made a similar upgrade.

Big British lenders including HSBC, Lloyds Banking Group and NatWest raised their forecasts for 2022 when reporting first half earnings over the last week, citing rising interest rates which are boosting lending margins.

Higher rates drove profits at Italy's top two banks Intesa Sanpaolo and UniCredit above market expectations in the second quarter.

Even banks in Germany, where stiff competition has depressed profits for the industry for years, are set to benefit with

11 billion euros in increased revenues in the 2023 as a result of higher interest rates, according to a recent study by Pricewa-

terhouseCoopers. That's a significant figure, representing more than five times last year's annual profit of Deutsche Bank, the country's largest lender.

Commerzbank reckons on earning at least 300 million euros more in additional interest income this year compared with 2021, rising to 800 million more in 2024. That compares with analyst expectations of total revenues of 9 billion for this year.

But the ultimate benefit is still unclear. "We don't yet know how customers will react after many years of ultra-low rates," Commerzbank Chief Financial Officer told journalists.

In the case of Commerzbank, as with other banks, the tailwind will only partly counteract hits from potential writedowns for corporate loans that turn sour if energy sources dry up.

The bank sees provisions and writedowns of 700 million euros this year, up from 570 million last year. THE government bonds have continued to attract investors among other investment avenues as both individuals and corporates targeting the market aggressively. Recent reports from the Bank of Tanzania (BoT) have showed massive attraction of bonds from in-

vestors, both local and foreign. There have been massive oversubscriptions of treasury bonds with maturity periods of 20 years at the issued by the central bank.

Recent auction results for a fixed interest rate of 12.10 percent 20 years treasury bond closed July 27 this year witnessed an oversubscription of 26.47bn/- as the amount offered was 136.23bn/-. As the total tendered amount topped 162.70bn/-.

The auction results show successful bids worth 125.68bn/-. The number of bids received amounted to 262 as the number of successful bids amounted to 244. The highest bid was 105 while the lowest bid was 94.6820.



PAN African Energy Tanzania (PAET) has said will continue to work with the government in tapping the downstream natural gas market to ensure the transitional energy play an important role in the economy through job creation, revenue generation and boosting production of goods and services.

He said the company, which operates two gas processing plant will continue to cautiously tap downstream gas market inform is virtual pipelines to remote regions of Tanzania. The company license is expecting to expire in 2026.

PAET has been producing gas from Songo Songo fields, operating gas pipeline from the island to Dar es Salaam for the last 18 years, making massive contribution to the economy, but Hanna is worried about the future supply shortages.

He said the company is now making efforts to ensure that gas is available to cater the increased demands from energy producers, manufacturers and households,

The future of stablecoins is commercial bank money

AS the world of decentralised finance continues to grow, there is much demand for a digital currency fit for use in blockchain-based applications with near-real-time, peer-to-peer global settlement that can be used as a medium of exchange.

However, most cryptocurrencies are too volatile for this and there are also issues with central bank digital currencies. CBDCs may not be based on the distributed ledger technology of blockchain or be available for retail use. They might also be slow to materialise.

As a result, stablecoins or emoney tokens have taken off to meet the market's demands.

Stablecoins come in many varieties. We believe the only ones likely to function as a medium of exchange in the foreseeable future are the most widely used type – those pegged to a fiat currency with the issuer holding reserves. Issuers offer to redeem their tokens on demand, claiming they are fully backed by reserves to meet this pledge.

The tokens, which do not pay interest, are usable as money in blockchain applications and trades in them can be settled on a near-real-time, peer-to-peer basis. In addition to being a medium of exchange, they serve as collateral in DeFi.

Issuers of these stablecoins have thrived while nominal interest rates have been near zero. With high positive interest rates, the opportunity cost of holding zero-interest stablecoins increases and the issuers lose business.

With significantly negative rates, the value of safe reserves declines but the tokens are still redeemable at par. Issuers face insolvency and must invest in riskier reserves for a chance to survive. If stablecoins are no longer fully backed by safe and liquid assets and are widely used, this creates financial stability risks.

Suppose the issuers could pass on their interest earnings (or costs if rates are negative) on reserves to the token holders on a one-on-one basis. If interest rates are high, stablecoins are a competitive liquid store of value. If they are significantly negative, the issuers' liabilities shrink along with their reserve; the issuer remains solvent. Stablecoins could be sustainable in all interest rate environments.

There is a problem though, at least for the EU with the Regulation on Markets in Crypto-assets (MiCA) that is expected to come into force in 2024. This pro-



scribes the paying of interest on money tokens. That would force issuers to adopt a business model that is only sustainable with near-zero interest rates.

We see no sensible reason for the ban but such regulation will force stablecoins to evolve. Shares in a regulated retail money market fund, issued as security tokens on a public blockchain under the applicable securities legislation, might be an alternative. Like stablecoins, they would be pegged to a unit of fiat currency but would pay interest.

Like MMFs that seek to maintain a constant net asset value, they would be at risk of self-fulfilling runs if investors rush to sell tokens, triggering further sales. As a result, they should have access to central bank lender-of-resort facilities such as MMFs. This sort of fund sits outside Mica and is allowed. It is telling, however, that one needs to circumvent Mica to design a stable stablecoin.

Tokenised deposits offered by commercial banks are another possibility. Banks would administer deposits on a distributed database rather than their own. In legal and economic terms, these are identical to conventional deposits; they do not fall under Mica and can pay interest.

Tokenising deposits would enable peer-to-peer settlement and make commercial bank money usable in blockchain applications without impacting the broader financial system.

Tokenising commercial bank deposits has advantages over alternative stablecoins. They can fall under existing deposit insurance schemes and may qualify as legal tender in some jurisdictions. Finally, banks have access to the central bank as lender of last resort; widening the scope of assets that the token holders' funds can be invested in while maintaining sufficient liquidity.

If interest rates deviate significantly from zero, stablecoin issuers are likely to apply for banking licences to benefit from the regulatory advantages. Existing banks will probably introduce tokenised deposits in order to compete. Stablecoin issuers, as intermediaries, will probably be only a temporary phenomenon. What will remain is commercial bank money with enhanced technical functionality.

Banks loans interest rates slightly go down, BoT says

INTEREST rates charged by commercial banks on loans remained broadly unchanged in May 2022 thus encouraging borrowers to seek more funds for social and economic development activities.

The central bank's Monthly Economic Review for June shows that the overall lending rate averaged 16.25 percent compared with 16.61 percent recorded in the corresponding period in May 2021.

The BoT's report however shows that commercial banks had charged an average interest rate on loans of 16.31 percent as of April this year.

charged to prime customers. An average of 14.4 percent was therefore charged during the period under review compared with 13.64 percent recorded in May 2021," reads the review in part.

As of April this year, the BoT figures show lenders have paid 14.12 percent in interest rate for the loans they had secured from commercial banks. On the other hand, the

review shows that interest rates offered by commercial banks on deposits recorded a marginal decrease in May 2022. The review highlights that

6.69 percent, compared with 6.89 percent recorded in the corresponding period in 2021. It further shows that banks had paid depositors an average deposit interest rate of 6.81 percent in April this year.

"Meanwhile, negotiated deposit rates averaged 9.63 percent compared with 9.33 percent the corresponding period last year and 9.73 percent in April this year," reads the review.

On a monetary supply basis, the review shows that credit by commercial banks to the private sector grew

percent in May 2021. During the preceding month of April credit extended by commercial banks to the private sector was rated at 13.4 percent.

"The growth in credit to the private sector was attributed to improved business conditions, coupled with supportive monetary and fiscal policies," reads the review.

This was revealed by the Conservation Commissioner of the Tanzania Forest Services Agency (TFS) Prof Dos Santos Silayo during the opening of the regional training involving enforcement officers from Tanzania, Kenya, Uganda, seeks to improve their skills in fighting illegal wildlife trade.

Professor Silayo reiterated that one key challenge to effective law enforcement in Africa is the deficiency of knowledge and skills among law enforcement personnel which is aggravated by

He added that to effectively mitigate the negative effects occasioned by wildlife crime, there is need to pragmatically enforce the applicable laws and regulations as stringent as possible to ensure that such training programs are instrumental in bolstering the law enforcement capacity of the agencies in addressing these potent threats in Africa.

The second phase of a regional training, is currently underway in Dar es Salaam as international organizations buttress their efforts to combat maritime trafficking of wildlife between Africa and Asia.

The past training programs were conducted in Mombasa, Kenya and in Arusha, Tanzania with the last one scheduled to be held in Uganda in October, 2022.

The training has drawn participants from enforcement agencies namely wildlife, forestry, police, prosecution, customs and other bodies from the three (3) East African countries.

Zawahiri's militant path surprised neighbours in Cairo suburb

AL Qaeda leader Ayman al-Zawahiri, who was killed by a US drone strike in Kabul, seemed harmless to neighbors when he was a young man growing up in a leafy Cairo suburb.

"Years went by, and then all of a sudden we heard about Ayman al-Zawahiri doing all these things, he became something we would have never imagined," said Attia Salama, his former neighbor in the upscale Cairo suburb of Maadi.

"He used to be quiet, no one used to pay attention to him at all. Our experience with him and his family was totally normal, we had no idea he was with that movement."

Zawahiri, an Egyptian surgeon, went on to become the leader of one of the country's most feared militant groups,

Islamic Jihad, convincing disillusioned young men to turn against the USbacked state.

A lawyer for the Zawahiri family could not immediately be reached for comment on Tuesday.

Zawahiri orchestrated a campaign in the mid 1990s to overthrow the government and set up a purist Islamic State. More than 1,200 Egyptians were killed.

Egyptian authorities mounted a crackdown on Islamic Jihad after an assassination attempt on President Hosni Mubarak in June of 1995 in Addis Ababa. The greying, white-turbaned Zawahiri responded by ordering a 1995 attack on the Egyptian embassy in Islamabad. Two cars filled with explosives rammed through the compound's gates, killing 16 people. Zawahiri did not emerge from Cairo's slums, like others drawn to mili-

tant groups who promised a noble cause. Born in 1951 to a prominent Cairo family, Zawahiri was a grandson of the grand imam of Al Azhar, one of Islam's most important mosques.

Zawahiri was raised in Maadi suburb, a place favored by expatriates from the Western nations he railed against. The son of a pharmacology professor, Zawahiri first embraced Islamic fundamentalism at the age of 15. Zawahiri was killed on Sunday in Kabul, Afghanistan, by a US drone missile, officials in Washington said.

Climbs Al Qaeda ranks

His former neighbor Salama stood on a typical Egyptian street filled with vegetable vendors, cafes, mechanics and buses as he reflected on Zawahiri's life before he climbed the ranks of Al Qaeda determined to terrorize the United States and other Western countries. Zawahiri's friends used to come by and then they would all go and pray, Salama said.

"We were surprised to see the state security coming in two cars and taking him and his brother Hussein and detaining them," said Salama, referring to state security agents working for Mubarak.

"He used to go around and pray and go to his clinic. And then all of sudden it changed, and security came and got him.'

Zawahiri disappeared after he was released from prison and

eventually headed to Afghanistan to fight Soviet occupation troops. Determined to keep tabs on Zawahiri, security forces would pass by Maadi and question his father and mother about his whereabouts.

He would go on to become the mastermind of some of Al Qaeda's most spectacular attacks. He had a \$25 million bounty on his head and helped to coordinate the Sept 11, 2001, attacks on the United States that killed nearly 3,000 people. Another acquaintance from the neighborhood, Hassan Izzeldin, said his family were well-known, decent people.

'Russia rejects accusations of initiating conflict in Ukraine'

RUSSIA definitely rejects accusations of "unprovoked aggression" against Ukraine, a high-ranking Russian foreign ministry's official said on Tuesday.

"We would like to definitely reject all accusations against us of 'unprovoked aggression' against Ukraine that have been voiced. Kiev's current regime rose to power in a coup and straightaway raised persecution, later an armed struggle against the Russian-speaking population of Donbass.

During eight years Ukrainian nationalists were killing civilians on this territory almost with impunity and preparing a major military entry into republics that had virtually separated from Ukraine," deputy director of the ministry's non-proliferation and arms control department Igor Vishnevsky said at the Review Conference for the Treaty on the Non-Proliferation of Nuclear Weapons.

"That said, having signed the Minsk accords that were the only way to bring peace to this land, Kiev's authorities were even not going to implement them," the diplomat noted, adding that "Russia's actions became a forced response to atrocities there."

Moscow also rejects insinuations about threatening with nuclear weapons and acting to undermine physical nuclear security in Ukraine, he said. "We will provide our detailed response on insinuations about allegedly threatening with nuclear weapons and acting to undermine nuclear and physical nuclear security in Ukraine later," Vishnevsky said.

Russian President Vladimir Putin said on February 24 that in response to a request by the heads of the Donbass republics he had made a decision to carry out a special military operation, after which the US, EU states, the UK, as well as some other states, imposed sanctions against Russian persons and legal entities, as well as sped up arms supplies to Kiev. Global health experts vow to act with courage to end AIDS

MONTREAL

World health experts have vowed to act with courage to end AIDS at the just-concluded 24th International AIDS Conference.

The five-day conference, known as AIDS 2022, brought together scientists, clinicians, community leaders, advocates, people with lived experience of HIV, health providers, decisionmakers and others from around the world to enhance the HIV and AIDS response.

"The issues lifted up at AIDS 2022 could enable a turning point in the global AIDS response. The new UNAIDS report released at the conference, In Danger, shows how the AIDS response has been blown off course, making action urgent," Joint United Nations Programme on HIV/AIDS (UNAIDS) Executive Director Winnie Byanyima said.

The report showed that about 1.5 million new HIV infections occurred in 2021, over 1 million more than the global targets. Globally, only 52 percent of children living with HIV are on lifesaving treatment, far behind adults, among whom 76 percent are receiving antiretrovirals.

"We call upon governments to urgently increase funding for the Global Fund and for the UN Joint Programme to enable the findings of this conference to turn into reality on the ground," said Byanyima.

Canada served as the host country for AIDS 2022, the largest global gathering on any health issue in the world. Canadian Health Minister Jean-Yves Duclos delivered closing remarks for the conference, during which he reaffirmed Canada's commitment to reaching global HIV targets and encouraged international partners to take collaborative action toward reducing stigma around HIV as a way to reach the undiagnosed and remove barriers to testing, treatment, and care.

During the conference, Duclos announced nearly 18 million Canadian dollars (14.4 million U.S. dollars) in funding to make decentralized forms of HIV testing, including HIV self-test kits, more widely available across Canada. However, the Canadian government was criticized by the International AIDS Society (IAS), the conference organizer, for the high number of delayed and denied visas which prevented many people from some of the countries most affected by HIV from entering Canada and attending AIDS 2022, including IAS staff and leadership.

DEMOCRATIC Republic of Congo's government will re-evaluate the withdrawal plan of the United Nations peacekeeping mission after deadly anti-UN protests last week, it said late on Monday, suggesting it may ask the force to leave sooner than expected.

The UN peacekeeping mission, known as MONUSCO, said on Tuesday that it supports the government's decision and is also ready to reassess its withdrawal plan, which currently has it staying for at least two more years.

Thirty-six people, including four UN peacekeepers, were killed last week during violent demonstrations in the country's east, the government said.

DRC to reassess UN withdrawal plan after deadly protests failing to protect civilians against militia groups that have wreaked havoc in the region for decades.

UN troops were accused of retaliating with force, and in some cases, live bullets, as hundreds of protesters threw rocks and petrol bombs, vandalised and set fire to UN buildings.

In a plan drawn up last year, the United Nations laid out a set of minimum conditions that would be necessary for MONUSCO's withdrawal, which it aimed to achieve by the end of 2024.

MONUSCO, which took over from an earlier UN operation in 2010, had more than 12,000 troops and 1,600 police deployed in Congo as of November 2021, according to its website. Frustrations against the mission were stoked by the recent resurgence of the M23 rebel group, which has displaced thousands.

Hopes riding on grain shipment from Odessa BRUSSELS

THE departure on Monday of a grain shipment from the Ukrainian Black Sea port of Odessa, the first since the outbreak of the Russia-Ukraine conflict in February, has been welcomed around the world as a major move toward easing a global food crisis.

The Sierra Leone-flagged cargo ship Razoni left with more than 26,000 tons of corn destined for the Mediterranean port of Tripoli in Lebanon.

Russia, Ukraine and Turkiye inked an agreement overseen by the United Nations on July 22 in the Turkish city of Istanbul to allow the export of grain and fertilizer by Ukraine and Russia. The arrangement is known as the Black Sea Grain Initiative.

"The day of relief for the world, especially for our friends in the Middle East, Asia, and Africa, as the first Ukrainian grain leaves Odessa after months of Russian blockade," Ukrainian Foreign Minister Dmytro Kuleba said in a tweet.

Kremlin spokesman Dmitry Peskov called the Razoni's departure "very positive" news, saying it would help test the "efficiency of the mechanisms that were agreed to during the talks in Istanbul".

Russia has blamed Western sanctions for slowing its exports and Ukraine for mining the approaches to its ports.

Before the Razoni's departure, Ukrainian officials said 17 ships were docked in Black Sea ports with some 600,000 tons of cargo, mostly grain.

UN Secretary-General Antonio Guterres said in a statement on Monday that ensuring "existing grain and foodstuffs can move to global markets is a humanitarian imperative".

"The secretary-general salutes their efforts, and he is grateful to Turkiye for its leadership," the UN statement said

"The secretary-general hopes that this will be the first of many commercial ships moving in accordance with the initiative signed, and that this will bring much-needed stability and relief to global food security, especially in the most fragile humanitarian contexts.'

Urgent needs

Guterres told reporters at the UN headquarters in New York that the ship was loaded with two commodities in short supply: "corn and hope".

"People on the verge of famine need these agreements to work, in order to survive. Countries on the verge of bankruptcy need these agreements to work, in order to keep their economies alive," he said.

Ukraine and Russia account for nearly a third of global wheat imports, with the two countries supplying more than 45 million tons annually, according to the UN Food and Agriculture Organization.

The Black Sea Grain Initiative allows for significant volumes of exports from Odessa and nearby Chernomorsk and Yuzhny. Inspection teams will monitor the loading of grain at the ports. Ukrainian pilot vessels will guide the ships through the Black Sea, after which they will head out through the Bosporus Strait, passing Istanbul, along an agreed corridor.

BEIJING

On 2 August, in disregard of China's strong opposition and serious representations, Speaker of the U.S. House of Representatives Nancy Pelosi visited China's Taiwan region.

This is a serious violation of the one-China principle and the provisions of the three China-U.S. joint communiqués. It has a severe impact on the political foundation of China-U.S. relations, and seriously infringes upon China's sovereignty and territorial integrity.

It gravely undermines peace and stability across the Taiwan Strait, and sends a seriously wrong signal to the separatist forces for "Taiwan independence". China firmly opposes and sternly condemns this, and has made serious démarche and strong protest to the United States

There is but one China in the world, Taiwan is an inalienable part of China's territory, and the Government of the People's Republic of China is the sole legal government representing the whole of China. This has been clearly recognized by United Nations General Assembly Resolution 2758 of 1971.

Since the founding of the People's Republic of China in 1949, 181 countries have established diplomatic relations with China on the basis of the one-China principle.

The one-China principle is a universal consensus of the international community and a basic norm in international relations. In 1979, the United States

China-U.S. Joint Communiqué on the Establishment of Diplomatic Relations -- "The United States of America recognizes the Government of the People's Republic of China as the sole legal Government of China.

Congress, as a part of the U.S. Government, is inherently obliged to strictly observe the one-China policy of the U.S. Government and refrain from having any official exchanges with China's Taiwan region.

patients recover from lingering physical and mental fatigue, although the drug developed by Axcella Health Inc failed on the small study's main goal of restoring the normal function of mitochondria - the energy factories of cells.

In the 41-patient pilot study released on Tuesday, for three of 21 patients who received the drug, AXA1125, their physical fatigue scores returned to normal levels after 28 days of treatment, Axcella Chief Medical Officer Margaret Koziel said in a phone interview.

Others who received the drug also reported physical and mental improvements that were deemed to be statistically significant as shown on a scale developed to measure chronic fatigue, according to the preliminary results, and the drug was shown to be safe and well tolerated.

"This trial is suggesting that a drug that's very safe to take and has minimal side effects is causing substantial improvement in people's physical and cognitive experience of fatigue," said Dr. Jason Maley, a consultant for Axcella who runs a long COVID-19 clinic at Beth Israel Deaconess Medical Center

in Boston The drug, originally developed for fatty liver disease, aims to treat the crushing chronic fatigue reported by more than half of long COVID-19 sufferers by restoring normal function of mitochondria, the minuscule power plants that help cells perform properly

People in the trial conducted at the University of Oxford received either the Axcella drug or a placebo over a period of 28 days. All were more than 12 weeks post COVID-19 infection and had an abnormal phosphocreatine recovery time, a measure of mitochon-

drial function. For the study's primary goal, there was no statistically significant difference between the groups on phosphocreatine recovery time.

The trial also looked at blood tests measuring lactate, a sign of muscle health, as well as patient-reported



measures of mental and physical faigue.

There are currently no approved treatments for chronic fatigue in patients with long COVID-19, a condition estimated to affect more than one hundred million people worldwide. Axcella Chief Executive Bill Hinshaw said the company is designing new trials and plans to meet with US and UK regulators with hopes of seeking an accelerated approval pathway for this enormous unmet need.

Botswana

As the number of reported cases of COVID-19 has decreased in recent months, the government of Botswana announced on Tuesday that wearing face masks outdoor will no longer be required.

Having reviewed the disease burden in the country and most importantly, the high numbers of people vaccinated against the global pandemic, Botswana has decided to relax some protocols in order to allow for more increased economic activity, Christopher Nyanga, Botswana's Ministry of Health spokesperson said in a statement.

"Effective today, wearing of masks in outdoor areas will no longer be mandatory," Nyanga said.

He also stated that social distancing protocols in schools will now be optional. Those who test positive will no longer need to be isolated unless the physician or medical doctor orders it. Botswana has so far reported 325,470 COVID-19 cases with 2,770 deaths. Agencies

Napoli owner: We will no longer sign African players

MILAN

NAPOLI owner Aurelio De Laurentiis said on Tuesday he would not sign any more African players unless they agreed to not take part in the Africa Cup of Nations.

Senegal defender Kalidou Koulibaly -now at Premier League side Chelsea -and Cameroon midfielder Andre Zambo Anguissa missed several Napoli games while on international duty at this year's AFCON, which took place between January and February.

"Or they sign a waiver giving up their right to participate to the Africa Cup of Nations tournaments or between AFCON and the championships in South America ... I never have them [Napoli players] available," he said in a Wall Street Italia talk show.

He criticised the fact that clubs were agreeing to more and more games, suggesting a European tournament with the top clubs from the strongest five countries instead of the Champions League, Europa League and Europa Conference League.

"The world of football cannot self-manage because we do the puppet show for others ... if we could play 100 games, it would be a happy ending for everyone and we [clubs] like cretins agree to that."

The Italian film producer also said he did not support the breakaway European Super League which folded less than 48 hours after it was announced last year as it was an elite club.

"You cannot create a super club of privileged members who invite others [to the

league]. You need to democratically keep the door open for everyone," he said.

De Laurentiis added he was tired of offers from investment funds for the club, adding that he was offered €900 million around four to five years ago by American investors.

"You [bidders] did not understand a thing [about me]. I am a pure entrepreneur who enjoys doing business ... let me play," he said.

"I want to be the 12th player on the pitch. Actually the 12th player is the fan, I can be the 13th or even the 14th, as 14 is my favourite number."

Barca signing Kounde ahead of Chelsea is a coup for the club and LaLiga

AS is often true during the ceremony when a club unveils its new signing, the most interesting thing said when Barcelona paraded Jules Kounde at their training ground on Monday wasn't uttered by the player. Instead, it was said about him.

It came when Mateu Alemany, Barcelona's new director of football and "get-it-done" guy who ensures the club's dealings are now robust, intelligent and strategic, insisted on going back to the question as to why the €55 million defender wasn't already a Chelsea player.

Alemany emphasised that he'd several times told Kounde (via his agent Jonathan Kebe) that "... if you want things sorted out quickly, then take one of those other big offers you've got, but stop calling me because I've got no news ..."

Barca's representative was emphasising how brutally complicated it has been for the club to negotiate the economic "levers," with Sixth Street and Socios.com, worth several hundred million euros, that have left the club liquid and hungry to spend.

He looked out into the massed ranks of media to find Kede, who was seated there with some of Kounde's family, and asked: "What was it, Jonathan? Did you phone me every single day, or only every two days, for the last two months?"

Alemany made crystal clear that Kounde had chosen Barcelona as his destination over two months ago and despite weeks of the club being unable to give him any hope or encouragement, the 23-year-old had stubbornly resisted Chelsea and waited patiently for the green light from Camp Nou.

Under normal circumstances, a France international like Kounde would by now be a pillar of Chelsea's rebuild following Roman Abramovich's departure. But he wanted to stay in LaLiga, he wanted to join Barcelona and, above all, he wanted to play for Xavi.

In Kounde, the Catalan coach has grabbed a seriously talented defender who: knows LaLiga inside out; fits his new club's playing philosophy to perfection; can play in a

few positions depending on forma-

heated and very physical 1-1 draw in Sevilla, when the left-back elbowed and shoulder-barged him twice in short succession.

It's a "score" that should now be quickly sorted. Alba loves a gritty competitor ... just so long as they're wearing the same colour shirt as him.

Kounde's other red card? When Espanyol's Javi Puado man-handled and tugged him back four times over 15 metres and Kounde tried to push him off. It was a terribly soft expulsion, but on each occasion, it showed a little remnant of the kid who used to kick his mum's shins.

The defender finally decided that enough was enough at Sevilla back in April when Los Rojiblancos, 2-0 up at the break against eventual champions Madrid, collapsed to an ultra-dramatic 3-2 defeat in added time. Kounde hammered his team for having "tossed a good first half in the bin" and criticised Sevilla's "lack of character and personality" in the second half. Harsh words, even if accurate, but career-changing. It was time to go.

This is a guy who is normally serene, fun, curious about life, multilingual and absolutely obstandards or attitudes. It's a trait that was hammered into him. He's previously explained where this demand came from: "Joining Bordeaux [Kounde's first senior club] was tough at first -- me being shy and withdrawn didn't help. My coach, Jean-Luc Dogon, worked really hard to get me to open up and bring more aggression to my game. I'm really grateful to him."

Various coaches at Bordeaux forged the guy that Barcelona just brought in. "Jocelyn Gourvennec was a hard man," said Kounde. "I might miss one pass while a teammate would miss two or three, but Gourvennec would come down on me like a ton of bricks and let the other guy off. It felt very unfair at the time, but it definitely left me with a strong work ethic plus a determination never to take my foot off the gas."

I was working for LaLiga TV with Chelsea, Uruguay and Real Zaragoza legend Gustavo Poyet, himself a former Bordeaux coach, the day that Sevilla signed Kounde. Off-camera, Gus immediately told me: "Fantastic kid, he just loves to go for adventures up the pitch, but so long as he continues with his attitude and his willingness to defend as well as attack, he'll become a fabulous player." He was right. Kounde recalls that spell: "Gustavo really believed in me and gave me huge confidence in my own abilities. He wanted us to love everything about football, to take risks, play creatively and enjoy being part of a group. Maybe the best coach I ever had!"

ALWAYS known as a great motivator, José Mourinho is also excelling as a pitchman in his latest coaching job at Roma.

When "Mou" calls, players come running to the Italian capital.

It all started a year ago when Mourinho lured Tammy Abraham away from European champion Chelsea to join him in Rome.

At first, the young striker wasn't all that convinced about joining a team that hadn't won a trophy in nearly 15 years and has historically been a notch below Italy's northern powers Juventus, AC Milan and Inter Milan.

Then Mourinho asked him: "Do you want

So far, though, Mourinho has been a perfect fit for Roma, which has a big fan base in a major European capital but which had been starved of trophies.

The arrival of Dybala, who was named Serie A's MVP two seasons ago, has Roma fans dreaming of more trophies – like the domestic league titles that Mourinho became so accustomed to winning earlier in his career at Porto, Chelsea, Inter Milan and Real Madrid.

That was before Mourinho's career met some turbulence in his previous job at Tot-

Cup and 2004 Champions League finals with Porto; the 2010 Champions League final with Inter Milan; and the 2017 Europa

To commemorate his status as the only coach to win all three of the current European titles on offer, Mourinho put a tattoo of the Europa League, Champions League and Conference League trophies on his right arm.

"Now I am staying, there are no doubts," said Mourinho, who is entering the second season of a three-year contract. "I only want to remain at Roma. We must understand what our owners, who are fantastic people, want to do next season, because this is history, but we can build a really strong project with honest professionals."

Players like Dybala were attracted to Mourinho's revival of Roma, which has reignited the team's fan base.

"For us South Americans, it's special playing in the (Stadio) Olimpico," said Dybala, an Argentina international. "It makes you feel like you're in Argentina or Brazil, which isn't something easy to find in Europe. So playing for these fans will be something unique."

"Eventually she sought professional advice and the doctor told her 'do it back to him. If he kicks you, kick him back. He'll soon calm down!' That period didn't last long, but it wasn't great at the time."

These days, Kounde is far from a hothead. Take note that despite being a fast, aggressive, "see-the-ballwin-the-ball" type of player, he's been booked a mere 26 times in 227 club and international matches. Few lunges and almost zero dissent; his misjudgements are rare.

That's a properly remarkable stat. Nevertheless, Barcelona fans will recall that one of his two red cards in Spain was for chucking the ball at Jordi Alba during a
