TPDC, gas explorer in refinery logistics talks

HOW to transport natural gas discovered at Ntorya fields in Ruvuma Region to the Madimba processing plant within the Mtwara Mikindani municipality for purification is being hammered out by the Tanzania Petroleum Development Corporation (TPDC) and the prospecting firm, ARA Petroleum of Muscat.

Francis Lupokela, the TPDC public relations officer, said yesterday that recoverable volumes of natural gas have been discovered at the Ntorya field, covered by the Ruvuma Petroleum Sharing Agreement for which the company holds the Mtwara natural gas exploration license.

Though the volume of discovered natural gas is vet to be announced to the public, exploration started in 2006 after the agreement was reached in 2005, with some initial discoveries being reported, he said at the 46th Dar es Salaam International Trade Fair.

The firm expects to drill a well offshore and another onshore at the Ntorya development field, with the area being within the Mtwara gas block, a few kilometers from the Madimba gas plant. ARA Petroleum is conducting a three-dimensional seismic survey that will boost prospects of developing the Chikumbi-1 exploration well, he stated.

There are so far five natural gas processing plants countrywide, namely Pan African Energy (T) Ltd (PAET) Songo Songo plant processing 110m standard cubic feet per day, the Maurel & Prom plant at Mnazi Bay processing 10m cubic feet, while TPDC operates a Songo Songo plant processing 140m such units, TPDC Madimba plant processing 210m cubic feet, making a total of 470m units by late April.

TPDC's natural gas plants fuelling the Tanzania Electric Supply Co. Ltd (Tanesco) grid generate 102.32 megawatts of electricity, amounting to 62percent of the power source at TPDC, with other clients being 48 manufacturing and processing industries, 1,500 households, six public organisations in Dar es Salaam and Mtwara, a city hotel and around 1,400 vehicles converted to gas use in the city, he added.

PRESIDENT Samia Suluhu Hassan has been saddened by reports that most patients who seek treatment for obstetric fistula at the Comprehensive Community-Based Rehabilitation in Tanzania (CCBRT) hospital facility in Dar es Salaam are girls as young as 11 who are victims of

Launching the hospital's new maternal and newborn wing costing 101bn/-, she praised its contribution towards improving healthcare in the country, expressing her sadness over the fistula

She recited a briefing from CCBRT officials with an observation that more efforts are needed to protect girl children and support them to achieve their dreams in life.

"I have been told that CCBRT receives a number of patients with obstetric fistula with a majority of the cases being adolescent girls. As a society, we need to see this problem and take measures on the challenge of rape, to which we are largely turning a blind eye," she said.

The president underlined the need to strengthen efforts to fight rape, early marriages and teenage pregnancies, while also addressing delays in accessing maternal health services.

Experts say obstetric fistula is one of the more serious and tragic injuries often occurring during childbirth. It is a hole, or abnormal opening in the birth canal that results in chronic leakage of urine and/or feces. Women with fistula are often shunned in their communities, activists say.

CCBRT Hospital was complementing government efforts in transforming the health sector and social welfare in general for the betterment of all Tanzanians, she said, acknowledging the problem of shortage of staff. She directed Health minister Ummy Mwalimu to work on the matter.

The hospital's chief executive officer, Brenda Msangi said the new wing will help provide answers to congestion of patients in health facilities in the city, as vulnerable expectant mothers often face stigma, neglect and seek to deliver in an


Loliondo: Police nab 72 foreigners, 30 arraigned

A ten-day operation by Immigration Department officers has found 72 foreigners living and working in the area without permits, the regional authorities say.

Hosea Kagimbo, the regional immigration officer, told reporters yesterday that 57 of those arrested are Kenyan citizens, seven French citizens and eight other migrants, found in Sale and Loliondo divisions.

Hamad Yussuf Masauni, the Home Affairs minister, visited the areas on June 15 after a spate of agitation, directing a thorough investigation into a flare-up as boundary beacons for the Loliondo Game Controlled Area were being installed.



The resulting inspection focused on activities of non-governmental organisations (NGOs) in the two divisions, the regional official noted, pointing out that among those arrested, 30 will be taken to court, 13 were released and investigations on 29 others

Investigations faced some challenges as some local people fled their homesteads (bomas), but efforts to pursue them were continuing, he said, noting that inspections were conducted on 10 NGOs, where in-depth interrogations were conducted with their officials.

Earlier reports said that some pastoralists from the other side of the border were bringing in huge herds of livestock for grazing with the connivance of district officials, which is causing unease with conservation officials at the Loliondo Game Controlled Area,

The government has reduced the size of the Loliondo Game Controlled Area from 4,000 to 1,500 square kilometres, leaving to local people the use of the 2,500 square kilometres portion, but activists want the 1,500 sq. km area remaining for native use.

He said that Advanced Certificate of Secondary Education Examination (ACSEE) results showed pass performance of the 93,136 candidates as having improved to 99.97 per cent compared to 99.06 per cent of a total of 87,043 candidates who sat ACSEE last year.

The number of girls who passed stands at 40,907 or about 99.51 per cent while for boys 52,229 passed, same as 98.57 per cent of the 94,456 male candidates, he said.

School candidates who passed the test stand at 84,404 or 99.87 per cent of those who passed, with private candidates sitting for the exams numbered 8,732 compared to 7,447 last year, he said.

The council cancelled results of 15 candidates involved in examination irregularities including cheating. It has also withheld results of 21 candidates who had health issues and will be allowed to write the exam next year.

Uganda adopts Kiswahili as EAC's official language

Uganda has adopted the resolution by the East African Community (EAC) to make Kiswahili an official language for the bloc alongside English.

The Ugandan Cabinet on Monday nodded to the implementation of the directive made during the 21st EAC extraordinary summit in Dar es Salaam in February 2021.

During the summit, heads of states amended Article 137 of the bloc's treaty to introduce the lingua franca as an alternative language for transacting EAC's official business.

Consequently, the government of President Yoweri Museveni has recommended compulsory teaching of Kiswahili in primary and secondary schools in Uganda.

"It was further agreed that training programmes for Parliament, Cabinet and the media be initiated," Dr Chris Baryomunsi, Uganda's minister for ICT and National Guidance, said.

That move is likely to bring to an end the age-old joke that "Kiswahili was born in Zanzibar, grew up in mainland Tanzania, fell sick in Kenya, died in Uganda, and was buried in Democratic Republic of Congo".

And with Uganda government's commitment to institutionalize the language, public perception and buyin remain the biggest hurdles in the country where English is the official language.

Since 1970s, Ugandans have associated Kiswahili with death and destruction following human rights abuses and other atrocities meted out during Idi Amin's dictatorship and civil

Amin spoke and supported the language in his rebellion against colonialists whom he had vowed to "teach a lesson".

Some of his soldiers used the language as they unleashed terror on Ugandans, hence the dark memories among Kiswahili opponents.

Kiswahili, the language of Swahili people, is spoken by more than 200 million people around the world.

In February this year, the African Union adopted Kiswahili as one of its official working languages, three months after the United Nations Educational, Scientific and Cultural Organization (UNESCO) designated July 7 as World Kiswahili Language Day.

It's already a national and official language in Kenya and Tanzania and one of four national languages in DRC, the latest EAC member state. It is also spoken by nearly 50 and 70 per cent of the general public in Rwanda and Burundi, respectively.

A product of the fusion of Bantu and Arabic dialects, Kiswahili is not only recognised as a unifying language spoken by East Africans but it is rich in dialect and expression. The language

is used for social interaction and trade in many urban centres in EAC member

Kampala's decision comes almost five years after the EAC Council of Ministers directed partner states to formulate national Kiswahili language policies and enhance the use of the language in official domains.

The council in April 2017 also asked member states to initiate institutionalization of Kiswahili by setting up national Kiswahili councils and national Kiswahili associations.

Article 119 of the EAC Treaty provides for the development and promotion of indigenous languages, especially Kiswahili, as lingua franca. The adoption of Kiswahili as the

second official language is set to not only boost the unity of the bloc but also deepen and widen integration. Embracing the language at the regional level will also increase

people's participation in the affairs of

the community. Beyond East Africa, Kiswahili has spread on the continent and is widely spoken in Zambia, Malawi, Mozambique, Madagascar and the

Comoros Islands. In June 2020, South Africa introduced Kiswahili as an optional subject in the hope that the language could become a tool to foster cohesion among Africans.

According to Global Voicesinternational multi-lingual organisation of writers, translators, academics and digital rights activistscurrently, there are more than 7,100 languages spoken around the world, 28 per cent of which are spoken on the African continent.

Despite the existence of some 2,140 local languages in Africa, English, French and Arabic reign supreme. English on the other hand dominates online spaces in the region.

But this has shrunk to between 51-55 per cent as opposed to 80 per cent on online dominance two decades ago. Projections indicate that Kiswahili, which is now online, will become an increasingly important instrument of trade.

Kiswahili is taught in universities around the world, including in China, while in the USA, an estimated 100 universities offer Kiswahili courses, including Harvard University.

Minister decries continued cases of child violence in the country

THE Minister for Community Development, Gender, Women and Special Groups, Dr Dorothy Gwajima, has decried continued cases of child violence in the country.

She said despite the government and other stakeholders' efforts to end child violence, awareness on the prevention and strategies are generally inadequate, especially at the local governance authorities.

According to the minister, violence against children has revealed a profound impact on core aspects of emotional, behavioral, and physical health as well as social development throughout life and mostly in education settings where child skills are developed.

Dr Gwajima termed the vice as a serious human rights, social and public health issue in Tanzania, as in many other parts of the world.

"Violence erodes the strong foundation that children need to lead healthy and productive lives." said the minister.

Speaking while officiating at the opening of a six-days training for community development officers, social workers and journalist from ten regions in the minister said Tanzanians ought to join hands in the fight against child violence.

meeting organized in The collaboration of between Children in Crossfire, Tanzanian Early Childhood Development Network (TECDEN) and the Union of Tanzanian Press Clubs (UTPC) brought together 79 participants.

She noted that statistics around 6,376 incidents of violence against children were reported to the police by mid-2018 – up from 4,728 incidents by mid-2017.

The minister added that Tanzania will face a human rights crisis if nothing is done to address violence against children.

After many years of grassroots capacity-building and advocacy by the Derry organisation, the Tanzanian government launched a new programme in December that aims to see every child in the country benefit from early years' education.

He noted that the training is very important in effort to help improve welfare of Tanzania children. "Children in Crossfire's vision of a compassionate world where every child can realise their full potential is one that resonates so deeply with our values and vision as a Foundation."he said, stressing the importance of the training.

Poaching, drought among culprits for declining number of elephants

POACHING, drought and other climate change related lands where there is land use for agriculture, issues have been named as among the major factors that livestock and environmental protection in contributed to the decline of elephants from 300,000 in late 1950s to the current 60,000.

Tanzania Wildlife Research Institute (TAWIRI) principal research officer Dr Steven Nindi said this recently during a virtual biodiversity conservation breakfast debate organized by Journalists' Environmental Association of Tanzania (JET), through the USAID Tuhifadhi Maliasili Project.

He noted that reports show that Tanzania had the highest estimate of over 300,000 elephants in the late 1950s, but currently there are 60,000 elephants which is a drop of 250,000.

The USAID Tuhifadhi Maliasili Activity "Preserve Natural Resources' '-is a five-year nationwide project that works to conserve Tanzania's critical biodiversity, enhance habitat connectivity and support community livelihoods.

Dr Nindi noted that some wildlife corridors have been encroached by people doing economic activities hence fuelling human-wildlife conflicts.

The wildlife corridors are safe areas and transition zones for wildlife animals to cross from one habitat to another but due to people interference with these corridors they have developed into a human -wildlife challenge.

But today conflicts have become more widespread between humans and wildlife, with declining wildlife due to a variety of factors including corridors that pass through human settlements.

"People are engaged in various activities, such as housing, agriculture, animal husbandry and so on, due to the interaction of people using these corridors for economic activities," he noted.

Dr Nindi said there are 52 wildlife corridors in Tanzania but 44 have been carefully reviewed and organized.

These wildlife corridors are terrestrial corridors but there are basically marine and Ariel corridors that are used by migratory birds to travel from one country to another.

There are times when these wildlife stay in the corridors for a long time due to various reasons. For example, in a national park or game reserve the animals can stay in the corridors for a long time.

In the corridors there are good habitats so these animals can live in the corridors for a long time," he added.

Dr Joseph Layson, director of research, compliance and information at the National Land Use Planning Commission (NLUPC) said that the commission's main function is to coordinate and manage all land use at various levels.

He said that one of the approaches to reducing existing challenges is the importance of land use planning to reduce land use conflicts.

Dr Layson said; "Basically those wildlife corridors run through all those administrative, and landscape areas. The Commission's main task is to ensure that it coordinates land use plans based on existing uses and the needs of existing land users.

Among the existing uses is the use of protected land as one of the categories, but there are village He said that the government in collaboration

with various stakeholders, the commission was making sure vital resources are protected for sustainable development.

Dr Joseph pointed out that the land use plan we have now is from 2013 to 2033, there are 42 district land use plans, 2,584 village land use plans, and detailed plans in 28 village centers.

WHO's emergency preparedness and response projects roll out in Tanzania

TANZANIA is among the priority countries benefitting from the implementation of World Health Organization Emergency Preparedness and Response projects that aim to promote multisectoral convergence of resources and skills for rapid and efficient response to a disaster.

Called Emergency Preparedness and Response Flagship projects the initiative seeks to ensure Health Security in the African Region; builds upon existing infrastructure to put in place a well-organized partner support system that augments national capacity when needed, incorporating lessons learned from Covid-19, Ebola, and other health emergencies.

Initially implemented in select countries, the projects will be scaled up regionally over the next five years. To initiate the projects in Tanzania, WHO Tanzania has received eight vehicles that will be positioned within the Ministry of Health multisector coordination mechanism after the capacity-building activities with guidance from the Regional EPR Cluster.

Implementation of these projects embraces the fact that preparedness, and response to emergencies is a multisectoral undertaking, therefore preparedness efforts must also reflect that reality.

This is an opportunity for Tanzania to further strengthen the capacity in emergency preparedness, early detection and response.

The three flagship projects are named: Promoting Resilience of Systems for Emergencies (PROSE) Flagship Project, Transforming African Surveillance Systems (TASS) Flagship Project, and Strengthening and Utilizing Response Groups for Emergencies (SURGE).

The aim of these projects is

to develop in-country teams of highly skilled, resourced, and wellcoordinated professionals capable of arriving at a location of disasters or disease outbreaks within the shortest time possible (within 72 hours) and coordinating a rapid response to minimize their effects.

The EPR cluster at WHO Regional Office for Africa (AFRO) works with national governments in the African region to strengthen their capacity to prevent, prepare for, detect, and respond to health emergencies. The flagships will integrate and strengthen existing human resources for emergency response. Most countries across the continent have existing Public Health Emergency Operating Centres (PHEOCs), Rapid Response Teams (RRTs) and Emergency Medical Teams (EMTs) run by national governments.

"This is an opportunity for Tanzania to further strengthen the capacity in emergency preparedness, early detection and response. The resources, including the vehicles that have arrived already, will be positioned with the government. The aim is to foster government leadership, with WHO support and collaboration with a wide range of partners," said, Dr ZabulonYoti, Acting WHO Representative in Tanzania.

The Emergency Preparedness and Response Lead at WHO Tanzania, Dr Grace Saguti said the arrival of the 8 vehicles were an assurance that Tanzania will participate in the implementation of the Flagship Project.

"In the coming months we will be rolling out training building on available capacity in areas of coordination, surveillance, risk communication, but especially to this approach we are taking multisectoral outlook because disasters do not affect health exclusively," said Dr Yoti.

Drought, heat, insects: Climate crisis threatens Tanzanian coffee farmers

COFEE farmers in Kilimanjaro region are bearing the brunt of climate change, affecting their incomes and livelihoods.

Damian Mtega, a coffee improvement manager at the Tanzania Coffee Research Institute, said rising temperatures around Mount Kilimanjaro and insect outbreaks have reduced coffee production by up to 75

"The rising temperatures have brought drought, increased diseases and killed insects that pollinate coffee plants," he said.

According to government statistics, Tanzania is the third-largest coffee producer in Africa, producing on an average 40,000 metric tonnes of coffee annually, generating revenue of \$162 million a year.

According to Mtega, Arabica - the most lucrative variety of coffee that accounts for up to 70 percent of Tanzania's production - is vulnerable to temperature fluctuations.

"The Arabica variety requires mild rainfall and at least four months of dry weather to grow well," he said.

Areas at lower elevations are no longer suitable for coffee farming, Mtega also said, adding that some farmers in Kilimanjaro have been forced to move to higher ground, where temperatures remain sufficiently cool.

Vicky Massawe, who is growing coffee on her 1-acre (0.4-hectare) farm in the rolling hills of Machame in north Kilimanjaro, said bad weather has disrupted the growing cycle.

"We are suffering a lot from drought. Even rains have become unpredictable," she said.

Massawe, also the head of a local group that represents hundreds of small coffee farmers, said the region's climate was once ideal for growing coffee, with stable temperatures and

adequate rainfall. But in recent decades, the climate

has become increasingly hostile, she said. Temperatures are rising and there is a delay in rains that adversely affect coffee growers.

Extreme weather conditions such as heavy rainfall and frequent drought spells are threatening the livelihoods of many farmers like Massawe in the region.

The farmers blamed drought for damaged, twisted, or undersized beans while also complaining that too much rain during the critical flowering stage has also damaged flowers even before the beans could take shape.

"I have lost hope with this crop. I have focused all my attention on bananas and vegetables to earn an extra income because coffee is no longer profitable," said Verdiana Temu, a coffee farmer in Kilema. The Kilimanjaro Native Cooperative

Union (KNCU) is now equipping farmers with skills to adapt to changing conditions, providing resilient seeds, monitoring production, and suggesting new agriculture techniques.

Philemon Ndossi, the KNCU's chairperson, said the organization has teamed up with researchers to revive the industry by growing and developing resilient coffee seedlings.

"We have obtained more than 60,000 quality coffee seedlings which we distribute to farmers," he said.

Arabica coffee is grown on the slopes of Mount Kilimanjaro, under the shades of banana trees.

Military foundation boosting HIV/AIDS care and treatment in southern highlands regions

ongoing interventions undertaken by the Henry Jackson Military Foundation Research International (HJFMRI), have helped strengthen HIV/Aids care and treatment as well as reducing new infections in southern highlands regions.

Speaking during the meeting with the Parliamentary Committee on HIV/Aids recently, HJFMRI executive director Sali Chalamila said reports have shown that efforts of the foundation, government and other stakeholders to fight HIV/AIDS were showing positive results but still more concerted efforts are needed so as to prevent new infections and thus reduce the incidence rate.

She said that on biomedical interventions, the organisation has been educating and promoting HIV testing, risk reduction counseling and latex condoms; on behavioral interventions, the foundation works groups to change especially women and Songwe. engaged in sex work (WESW), men as well as those using drugs.

Chalamila noted that the global goal including Tanzania is to reach HIV epidemic control by 2030, with 95 percent of people living with the disease to be aware of their HIV status, 95 percent of those testing positive placed on continuous HIV treatment, and 95 percent of those on treatment reaching viral suppression.

UN official hails Tanzania's effort in increasing uptake of Covid vaccines

The United Nations (UN) assistant secretary-general and The Global Lead coordinator for Covid-19 Vaccine Delivery Partnership, Ted Chaiban has hailed Tanzania's effort in increasing the uptake of vaccines to fight the pandemic.

Chaiban is in the country for an official visit to meet government officials and key partners so as to support the acceleration of Covid-19 fight, although Tanzania has not yet reached the international goal of providing the Covid-19 vaccine with 70 percent of the population, was able to increase vaccination rates from 6.3 percent by the end of 2021 to the current 12.4 percent.

The leader yesterday met the Vice President Dr Philip Mpango in Dar es Salaam and visited Makangarawe Dispensary in Temeke district.

He also met the Minister for Foreign Affairs and East African Cooperation Ambassador Liberata Mulamula.

"Tanzania was late in launching the vaccination but we commend it for being able to take steps to increase the number of people vaccinating through campaigns in health facilities," Chaiban

He added that the country now needs to keep the momentum and accelerate vaccination, especially by ensuring that groups such as the elderly, people with chronic illnesses are given priority to ensure that all are vaccinated.

At Makangarawe Dispensary, he had the opportunity to meet the health care service providers at the center and community health care workers that provide outreach services to those who provide wallet services in the community where he exchanged ideas with them to find out how they are doing their job and the challenges they face. "I am very happy to meet people that are at the forefront of vaccination delivery. They dedicate their time to educate others about the importance of the vaccine and giving them that vaccine," he said.

Chaiban's visit to Tanzania aims to engage in joint political advocacy for she said.

ramping up Covid-19 vaccination at the highest level with the government, the diplomatic corps and partners, secure commitment for the 'one team. one plan, one budget approach' and in collaboration with government and stakeholders examine specific vaccination bottlenecks/proposed solutions and how to roll out the solutions.

Recognizing the urgency of turning vaccine doses into vaccinated, protected communities, WHO, UNICEF and Gavi, the Vaccine Alliance launched the COVID-19 Vaccine Delivery Partnership (CoVDP).

The CoVDP builds on existing resources to support the AMC 92 and focuses foremost on the 34 countries that were at or below 10 percent coverage in January 2022. Working closely with countries to understand bottlenecks to vaccination, the CoVDP offers access to urgent operational funding, technical assistance and political engagement to rapidly scale up vaccination and monitor progress towards targets.

The CoVDP builds on the substantial body of work realized by the Country Readiness and Delivery (CRD) work stream that was part of COVAX since early 2020, and which made available global guidance and coordinated technical support for the implementation of COVID-19 vaccines.

The aim of this programme is to work closely with the various nations to collectively understand the environment and impediments to the proliferation of immunisation and to access financial resources and expertise to shape the rapid development of immunisation.

Dr Irene Haule, Temeke district chief medical officer said that due to vaccination strategies in the district it surpasses the daily vaccination targets by almost one hundred percent.

"By using immunization strategies in various cases, door-to-door and in health facilities we are now reaching up to vaccinating 7000 people per day unlike before where we were lagging behind by vaccinating 500 per day,"

UN Women hands over 200 tablets to NBS to ease data collection in August census

UN Women Tanzania has handed over 200 tablets to the National Bureau of Statistics (NBS) to facilitate easy data collection and processing in the coming 2022 Population and Housing

Speaking during the handing over ceremony in Dar es Salaam recently, UN Women Tanzania Representative, Hodan Addou said that they have extended the support to ensure that the population census is achieved where everyone is counted.

The obtained data will help Tanzania and UN Women to shape genderresponsive policies, laws, plans, programmes and budgets to uplift women and girls across the country.

"We will look more closely at data that will inform and support our new four -vear programme implemented in six regions mainly Arusha, Coast, Dar es Salaam, Lindi, Mtwara and Singida and 18 districts," she said.

She said it was vital that concerted efforts are made for women and girls at the local level to take part in the census to determine where to focus on development efforts and UN Women has seized every available opportunity during the past few months to promote this important exercise.

"Ensuring that they are counted also means addressing existing gender biases in data collection. This also requires having an adequate number of women enumerators to obtain correct responses from women, and I am happy to note that this is something Tanzania has made sure of for the census," she added.

Addou asserted that the ICT tools, funded by the Embassy of Finland, are in line with the long and productive partnership between UN Women and the National Bureau of Statistics.

Since 2018, UN Women has been collaborating with NBS to implement the Make Every Woman and Girl Count Programme, with the goal to produce quality gender data to inform national policies and programmes.

As the largest statistical exercise conducted in the country, providing invaluable data on individuals and households, the census ties in well with UN Women programming.

Following the census, UN Women will also support NBS to develop a gender monograph from the data to understand the key demographic issues of women at national and more specifically at the local level - not only in terms of burdens and responsibilities, but also in sharing resources and benefits.

This analysis will provide insights into the different types of predominant gender gaps, and help identify how much they affect progress towards sustainable development, and in turn inform actions required for gender equality and women's empowerment and equality.

UN Women has been able to provide these tablets thanks to the support of the Government of Finland as part of the United Nations System and international community's support to the census.

"We are particularly grateful to the government of Finland who is one of the largest donors for UN Women globally, as well as here in Tanzania, for the sustained partnership and continued commitment to advance gender equality," he said.

Also the handover is in line with a long and productive partnership between UN Women, NBS and OCGS where since 2018, UN Women has been collaborating with NBS to implement the Make Every Woman and Girl Count programme.

The programme aims to create a radical shift in how gender statistics are used, created, shared and accessed.

She said Tanzania has made many positive gains for women and girls in recent decades. However there are still a number of women who still experience numerous challenges. Those with disabilities are especially vulnerable, face even more forms of discrimination and are further left behind.

As they comprise a relatively small number in the population, conventional household surveys cannot always adequately identify and represent their needs. That is why the population Census is absolutely crucial to identify where marginalized populations are as well as the challenges they face."

"I also commend NBS and the entire government of Tanzania for the steps it has taken to ensure that everyone including women, people with disabilities and other marginalized groups are counted and this is yet another demonstration of the government's commitment to gender equality and inclusivity," she said.

Chief Government Statistician for Zanzibar, Salum Ali said the 200 tablets was an important donation this time when the preparations of the census

Census clerks warned against divulging info on households

POPULATION and Housing Census clerks have been called upon to adopt ethical behaviour and to maintain secrecy on every household and whoever will violate their oaths will be severely dealt with according to the laws including facing jail terms.

The remarks were made here yesterday by the Census Commissar, Anne Makinda when addressing leaders, government religious officials, local council directors, ward executives and stakeholder from nongovernmental organisations (NGOs).

Makinda said in the census exercise top secrecy will be maintained whereby census clerks and enumerators will take oath to maintain secrecy on households they will visit during the exercise and if they disclose the secrets they will be liable to imprisonment.

"I appeal to all Tanzanians to display patriotism in this exercise and should offer your cooperation by submitting correct information because these will be kept secret, and any enumerator who will divulge the secrets will be

jailed," she said.

She added that during the census exercise every Tanzanian will be enumerated only once saying the data gathered are important for their own development.

She cited the census' benefits as including the government's getting the country's correct population to help better development planning and provision of appropriate social services according to their population.

Meanwhile, Makinda called on the stakeholders to continue mobilising the people for the census with only 49 days to go.

Pastory Ulimali, senior statistician from the National Bureau of Statistics (NBS) said all procedure for the event have been completed, adding that it will be conducted digitally and there will be no household that will be left out because once that happens the system will indicate.

Some participants at the meeting pledged to offer cooperation in mobilising the people to participate in the census exercise slated for August 23 this year.



Electronic tags for cattle may do some good but it isn't a panacea

Ministry of Livestock and Fisheries, relating to tagging electronic devices on ears for up to 10m domestic animals, especially cattle, by end of next month - or even by the end of the year - appear to be a hard climb to make. Well placed ministerial officials admit that so far just around three percent of the targeted animals already have ear tags to track them if the need arises, to know the movement of animals when a sample have those tags. If the big idea is to keep domesticated or reared animals under watch, just a sample would suffice on each heard, for a start.

As a matter of fact this is an exercise that the ministry have always found difficult to take up, as officials say that this exercise is being undertaken to comply with provisions of the Livestock Identification, Registration and Traceability Act of 2010. That makes close to 12 years for the exercise to be done, and definitely the reason wouldn't be the funding, for instance as the matter cuts across a significant breadth of interested parties and several could have made funds available to conduct it. The problem seems to relate to sustainability; animals fixed with the tags could be the first to be sold, making the data too

XPECTATIONS being aired authorities will hire clerks to update by senior officials of the the data on each animal, as such data recording may to some extent be relevant on ranch animals of a mature web of transactions, linked to the milk processing industry, beef exports, etc. Walking cows to a rural cattle market calls for no such data, so it is relevant for cattle movement and breaking regulations, but here it is to no avail, definitely.

There is plenty in the movement of herders and their livestock that is to say the least objectionable. So many communities are affected by the cattle rampage when they descend on their farms, so this device can be an 'early warning' method as to where the herd is heading. But technology without the rule of law isn't of much help as the herders know where they are, as well as the police but commerce is transacted.

The problem of herders' movements and the chaos it unfolds where they pass can't be resolved by tagging the animals to know where they are, nor is it likely that the devices will have usable data for any commercial purposes aside from possible certification of who owns that animal. But as the herders are sufficiently knowledgeable of their animal numbers even if that appears tantalizing for onlookers, the devices don't help them; they need anonymity to move around freely. The device that could check random movements is elevating land occupancy to freehold titles, as that would now be an act of

frustration at high levels government with the legal framework of public procurement and forging of partnerships, as the law involves taking up an elaborate jigsaw. The African Union at 20: Some reason to cheer, but a lot of work remaining

THE European Union (EU) has lived up to the primary reason it was created ensuring that member states will not wage physical war against one another, but settle their differences amicably. It owes some of its successes to a combination of enforcement and management mechanisms to ensure member states conform to rules and

Other regional bodies, like the Association of Southeast Asian Nations (Asean), are advancing towards their objectives of economic growth, social progress and cultural development. Asean draws on its distinctive informal and consensus-based principles and decision making.

What about the African Union (AU), which was modelled on the EU?

There is some reason to cheer as the continental body celebrates its 20th anniversary on 9 July. Key among its achievements is the African Continental Free Trade Area, which commenced on 1 January 2021. It is expected to boost intra-African trade by about \$35 billion by end of 2022.

The larger market area will likely attract investment for continental infrastructure development. The increasedtradewillcreatejobs,enhance Africa's global competitiveness, improve social welfare and position Africa for greater industrialisation. The resultant economic growth should help contribute to peace and stability for the continent's more than one billion population.

Permanent mission in Beijing

On the diplomatic front, the AU has established a permanent mission in Beijing, China, to strengthen economic, commercial and cultural ties with Africa's largest trading partner. This consolidates Africa's global profile and ability to speak with one voice on world affairs.

Still to be achieved is reform of the UN Security Council to give Africa at least two permanent seats. Over twothirds of the council's agenda concerns Africa, yet the continent is excluded from permanent representation.

In my view, the AU still needs to address two main problems to steer Africa into a prosperous future. These are the use of unconstitutional means by leaders to hold on to power; and disregard for the rule of law.

Unconstitutional hold on power Africa has seen a troubling

resurgence of military coups and led to political instability. But that does leaders using unconstitutional means to cling to power. There have been at least 32 coups and coup attempts since 2013, when General Abdel Fattah El-Sisi toppled the government in Egypt.

The AU handed him its rotating chair-ship in 2019, tacitly endorsing power grabs.

Following the October 2021 coup in Sudan, United Nations secretary general Antonio Guterres expressed concern that some military leaders felt they could do whatever they wanted.

Five out of the seven coup attempts since 2020 succeeded. The coup leaders in the five countries - Burkina Faso, Chad, Guinea, Mali and Sudan violently suppressed pro-democracy

The death toll from the suppression of anti-coup protestors in Sudan, for instance, is over 100. Over 18 million Sudanese are threatened by food insecurity.

Sudan political paralysis

But the AU acts as if it's unaware of the political paralysis in Sudan.

Some coup plotters justify their actions by pointing to poor social, political and economic conditions in their countries. For example, Colonel Mamady Doumbouya of Guinea cited endemic corruption and lack of economic progress to justify deposing President Alpha Condé in September

Condé had manipulated the constitution to extend his term. This

not justify the coup.

Turning a blind unconstitutional leaders and their actions indicates a backsliding from peaceful handover of power and democracy. It threatens Africa's

Some African leaders have perfected the art of unconstitutionally holding on to power. They use violence to rig elections. Or they doctor the rules of participation to exclude rivals. That happened in Tanzania, where laws that clamped down on freedoms of expression and assembly were passed and enforced ahead of the 2020 election.

criminalise Others popular opposition leaders, as happened to leading opposition challenger Bobi Wine in Uganda. Some feign constitutional reform to change constitutions and prolong their stay.

Disregard for rule of law

Africa is seeing a relapse into the autocratic rule of the Cold War era. An increasing number of democratically elected and legitimate governments are cracking down on civil society organisations. This is worrying, even if it is part of a global trend.

The governments are squeezing out institutions that should hold them accountable and are silencing the media. They arrest activists and enact laws that restrict civil society

organisations and their activities. This reversal in democratic norms

flies in the face of the normative framework mechanisms of the AU, which are about the rule of law, peace, security, democracy, good governance and human rights.

The AU should deal decisively with member states that undermine the rule of law within their territories. The rule of law is essential for sustained and inclusive economic growth, sustainable development, and the eradication of poverty and hunger. The rule of law enables people, business and commerce to flourish.

Looking ahead

African leaders should address the problems which military leaders use as the pretext for coups in African states - mainly corruption, misrule and insecurity. Solving these problems would deny the military an excuse to interfere in civilian matters.

Instead of cracking down on citizens and civil society, states should use their natural resources to grow their economies and empower citizens. Collective economic strength will improve Africa's standing as a global actor.

The response to coups and instability can't be limited to sanctions.

The AU must also be firm and consistent in dealing with constitutional violations. It's no use hoping that illegitimate officials will relinquish power. Recent examples show that perpetrators simply defy calls to restore constitutional order.

Small abacus supports Nigerian young woman's dream in education startup

NE afternoon in mid-June, Shirley Ben stood by the stage in the auditorium of an elementary school in the southern Nigerian city of Port Harcourt, where she dictated a series of numbers to several children on stage.

The children's pen-holding hands made a few strokes in the air, quickly wrote numbers on the sketchpad held in the other hands, and raised them to show the audience, causing a burst of applause.

This is the final of an abacus and mental math competition held by a local abacus and mental arithmetic training school. On that day, 300 pupils experienced a preliminary contest, while eventually, 15 winners stood out to participate in the final.

"We have trained these children over a period of time and they are using the abacus right now to show the skills that they have gained from using it. So with this competition, parents and everybody are able to see how fast their children can calculate using the abacus as a tool," said Ben, 35, the principal of this abacus and mental arithmetic training school, while addressing the media at the scene of the competition.

According to Ben, her training school offers three levels of training courses, with each level requiring a study period of four months.

And the 300 contestants were chosen from about 3,000 pupils currently in abacus and mental arithmetic training in Port Harcourt after an evaluation test held in May. Four years ago, at the recommendation of a relative study-

ing in China, Ben went to east China's Shandong Province to better understand the "magic" brainstimulating skills for children. Abacus and mental math originated from the Chinese Zhusuan, a timehonored traditional method of performing mathematical calculations with an abacus.

Zhusuan was listed as an intangible cultural heritage by the United Nations Educational, Scientific and Cultural Organization (UNESCO) in 2013. "I saw how the Chinese children were using the abacus to do the calculation, I was very interested in this, and decided to bring this knowledge here in Nigeria," the former stock manager told Xinhua.

After six months of training in the abacus in China in 2018, Ben returned to Port Harcourt to set up a training school and led her team to promote the abacusbased mental math courses in local primary schools.

Because the mental training skill works well to improve children's counting ability, the courses they offer were quickly accepted by teachers, students and parents.

Today, Ben's training school has two direct teaching centers in Port Harcourt, with 10 professional teachers, and more than 40 part-

In an interview with reporters at the scene of the competition, Kike David, a mother whose two children attended the abacus and mental arithmetic training class and the competition, said her children have developed self-confidence and love for mathematics since they started studying the abacus. "We want to encourage the government to buy into this

program and take it to our public schools," David said.

Roberta Ide, a private primary school principal who watched the competition, told Xinhua she was really impressed by the children's outstanding performance and expects more schools to sign up abacus in the Nigerian curriculum system. "I used to think the abacus

was only used for counting but with what I have witnessed here today, (I now understand) the abacus skill is a brain-stimulating process and it is highly beneficial for learning especially in young kids," she said. In a video interview with Xinhua, Li Mianjun, the founder of China Shenmo Education, believed to be the pioneer and

leader of abacus and mental arithmetic training, said abacus and mental math is a technique that originates from the abacus. This technique, he explained, encourages the learner to depict the abacus's plate, beads and grade in the mind, and complete the counting process without using the physi-

This technique has been effective in improving children's cognitive function and attention, Li said. And now, with the growing global influence of Chinese culture, the abacus has spread to more countries. According to him, since 2018, Shenmo Education has funded the establishment of abacus and mental math training schools in

more than ten countries including Nigeria, Rwanda, Tanzania, and Zambia. The Chinese-inspired Ben now has an even bigger wish to expand the abacus training business to other cities in Nigeria in the coming years and promote the establishment of abacus training and certification standards in Xinhua

ENYA'S campaign for the presidency has entered a decisive moment ahead of the country's general elections slated for August 9, with each of the four candidates outlining bold, ambitious albeit controversial blueprints to win the hearts and minds of 22.1 million registered voters.

For the first time in the country's history of multiparty politics dating back three decades ago, the presidential candidates have focused primarily on the economic plight of citizens, saddled by inflationary pressure and unemployment.

So far, three out of the four presidential candidates have launched their manifesto, outlining their key priorities including economic renewal, anti-graft war, youth and women empowerment if elected to the highest office in the land.

Raila Odinga, the 77-year-old veteran opposition leader who is vying for presidency under the Azimio La Umoja (Resolution for Unity) One Kenya Coalition of 26 political parties, was the first to launch his manifesto on June 6, with a firm pledge to unite the country, hasten economic growth, improve governance and revamp provision of basic services like education, health, water, and shelter.

With backing from Kenyan President Uhuru Kenyatta and a large sec-

Determined to maintain an edge in the presidential race, Odinga's three rivals have also been traversing the country, making a strong pitch for economic empowerment in a bid to win

Local pollsters have placed Odinga neck to neck with his closest rival William Ruto, the 56-year-old sitting deputy president who is eyeing the presidency under the Kenya Kwanza (Kenya First) alliance of more than ten political parties.

When he launched his manifesto last Thursday night, Ruto stressed that his grassroots-centered economic model would channel more resources to small and medium-sized enterprises, agro-processing, and indigenous manufacturing, to spur growth and tackle youth unemployment.

Pundits noted that while Ruto and Odinga were fierce competitors in the race for the presidency, their point of convergence was the urgency to address the soaring cost of living and unemployment, which threatened Kenya's stability.

The two candidates have divergent views on how to reinvigorate economic growth, fight graft, and govern the country effectively, but are united in their call for people-centered growth, gender

Both Ruto and Odinga represent mainstream political formations and have avoided taking controversial positions unlike their nearest competitor, George Wajackoyah, a legal scholar who has caused a sensation on the campaign trail, for pledging to legalize marijuana cultivation. When he launched his manifesto last Thursday night, the 63-year-old Wajackoyah who is vying for presidency under the Roots Party vowed to make marijuana a cash crop besides encouraging farmers to rear snakes, to boost Kenya's export earnings.

According to Wajackoyah, large-scale cultivation and export of medical marijuana could fetch 78.03 billion dollars to the Kenyan economy annually, while each local farmer would make 6,300 dollars from the sale of a vial of cobra snake's venom.

His controversial proposals like relocating the capital Nairobi to Isiolo, a semi-arid county in northern Kenya, suspending sections of the constitution, and allowing Kenyans to work for only four days a week, veered to the extreme.

Analysts opine that Wajackoyah could deny Ruto and Odinga a sizable chunk of youthful voters who are animated by his comical and sometimes controversial policy prescriptions, even as he unsettles the

A decade of transformation turns China's financial market into larger global presence

HINA'S financial market, young and fastgrowing, is at a new outset to open up further to the global markets, building on the transformative steps it has taken in the past decade.

The country's equity market and bond market expanded 238.9 percent and 444.3 percent respectively over the past 10 years, now both the second largest worldwide, official data showed.

It has also attracted more foreign investors and institutional investors, diversified investment options, and given rise to a bevy of world-class industry bellwethers.

"Looking ahead, China's financial sector will remain committed to unremitting reform and opening up to ensure long-term stability," said Chen Yulu, vice governor of the People's Bank of China, at a recent press conference.

BETTER PLAYING FIELD

Over the past decade, China's financial market has sharpened its appeal to investors worldwide through reforms to render a more market-oriented and rules-based environment.

"A major milestone is the introduction of a registration-based initial public offering (IPO) system, which signifies that China's capital market is taking the market-oriented turn," said Wu Xiaoqiu, former vice president of the Renmin University of China and president of its China Capital Market Research Institute.

The country vowed to carry out the system in a decision adopted at the Third Plenary Session of the 18th Central Committee of the Communist Party of China in 2013. It was first piloted at the sci-tech innovation board at the Shanghai Stock Exchange in 2019.

It helped improve the transparency of China's capital market and spur innovation and growth potential of listed companies, making the equity market more investment-worthy and paving the way for further opening of the capital market, said Wu.

To tilt financing more in favor of smaller companies and innovation-powered ones, China launched the sci-tech innovation board in 2019

and the Beijing Stock Exchange in 2021 in supplement to the blue chip-dominant main boards of the Shanghai and Shenzhen bours

Official data showed that 46 of the around 2,200 Chinese listed firms in emerging industries are each valued at over 100 billion yuan (about 14.9 billion U.S. dollars), up from zero 10 years ago.

The market is given an increasingly prominent role in China's financial sector to discern the quality firms and sift out the underperformers. In the A-shares, funds now distinctively favor firms with robust earnings, said Li Chao, vice chairman of the China Securities Regulatory Commission (CSRC), adding that companies delisted between 2019 and 2021 more than tripled that of the previous decade combined thanks to an upgraded regulatory mecha-

The rule of law is also being strengthened in the capital market. The new securities law effective since March 1, 2020, and a series of regulatory documents raised penalties for financial crimes, while the "zero-tolerance" policy of law enforcement enhanced deter-

In a nod to the evolution of China's capital market, major global benchmarks like MSCI, FTSE Russell, and the S&P Dow Jones have included the A-shares and strengthened their weightings. China's government bonds also made their way into three major global bond market indices.

A welcoming playing field has benefited financial institutions and investors from home and abroad.

"The expansion of China's capital market in the past decade spawned and nurtured financial services providers, including brokerages, mutual funds and banks," said Zhai Chenxi, vice president

The total asset of China's futures and securities brokers increased 5.5 times over the period, while public offering funds now manage 26 trillion yuan of assets, nine times that of 10 years ago.

To attract foreign investors, China scrapped foreign ownership caps for securities, fund management, futures, and life insurance firms; and launched the Shanghai-Hong Kong, and Shenzhen-Hong Kong stock connect schemes. It also allowed eligible overseas institutional investors to invest directly or through connectivity in the exchange bond market from June 30.

As a result, overseas entities' holdings of domestic renminbi (RMB) financial assets have increased by 2.4 times compared with 10 years ago, while the weighting of the RMB in the International Monetary Fund's Special Drawing Rights basket has risen from 10.92 percent in 2016 to 12.28 percent.

"China has made substantial progress in opening its financial

At present, RMB accounts for only 2.79 percent of global forex reserves. Foreign investors' holdings in China's stock and bond markets stand at a relatively low level of 3 percent to 5 percent compared with economies

such as Japan, the Republic of Korea,

"China will eventually be home to a top financial center of the world," said Wu. To achieve this goal would require better transparency, rule of law, the long-term credit of the RMB, and stronger listed companies, he said.

Industry insiders also called for further facilitating foreign access to the Chinese financial market.

Authorities are on the move. The registration-based IPO system, now extended to the Beijing Stock Exchange and the tech-heavy ChiNext market on the Shenzhen Stock Exchange, will be implemented across the board to further improve the quality of China's listed firms.

The country will expand the scope of Shanghai-Hong Kong and Shenzhen-Hong Kong stock connect schemes and offer overseas investors more cross-border investment and risk management products, said Wang Jianjun, vice chairman of the

It will also build up supervision capacities and enhance cooperation with other countries, he added.

Overseas investors have acknowledged the appeal of RMB assets, with more than 60 percent of overseas financial institutions surveyed by the Bank of China saying they will increase their holdings of RMB-denominated assets.

Many global financial institutions expanded their footprints in China, a token of their faith in the country's continued financial opening. UBS and Credit Suisse Group increased stakes in their respective brokerages on the Chinese mainland, while JP Morgan, Goldman Sachs, and Citigroup are actively staffing up.

It's time for parents to sensitise children on friendly reproductive health services

YOUTH in the contemporary world represents a tremendous potential development of human capital which a nation cannot afford to neglect. However, they face myriad issues that need concerted efforts from all stakeholders to address them.

The issues surrounding youth are as old as humanity. However, the issues facing youth in the 21st Century are far much different from issues of youth in the yester centuries.

There is no doubt that certain efforts have been made by the government and other key players towards addressing the plight of youth. However, developing economies like Tanzania are still grappling with numerous youth issues of varied magnitude.

Speaking in an exclusive interview with this paper over the weekend in Dar es Salaam, Director of Binti Makini Foundation [BMF] Janeth Kiko said that in partnership with Binti Salha Foundation under the sponsorship of the Women's Global Network for Reproductive Rights [WGNER AFRICAl are implementing a three months project called "You Can Project," mainly targeting youth on how they can address all issues related to stigmatisation so that they can access reproductive and gender services.

Kiko said that they empower the youth with proper knowledge on

sexual/reproductive health, HIV/ AIDS, substance abuse, on how to get rid of stigma, discrimination and self denial.

She said that having detected the existing gap between parents/ guardians and their children they organised a half day seminar that brought together over 100 parents and some youth from Temeke District to discuss on how to address issues facing their children.

Kiko said "We intend to know if these parents really educate their children/youth on comprehensive safe reproductive health.'

She urged parents to openly tell/ caution their children on how they can behave as grownups and at the end become good and responsible

Kiko has urged parents to seriously teach their children to behave cautiously so as to avoid acquiring HIV/ AIDS epidemic, which has been affecting many youth today who are the national manpower.

For her part, Director of Salha Foundation Salha Aziz said that they have been implementing this project to ensure the girls have proper knowledge so as to get rid with reproductive health and gender issues.

She noted "There are many challenges facing the youth that have made them fail to get friendly reproductive health services and proper

So, she has urged girls who

Tanzania's special training centre provides a second chance for out-of-school youths

HADIA Baruti Wimbi was only six years old when she left her parents' home, eventually leading to her spending much of her childhood without any schooling. "An elderly member of my family came to see my parents, asking if she could take me away. She promised my parents that she would enrol me in school. When she became my guardian, she enrolled her own children, but not me," Wimbi explained.

For a long time, it seemed the youngster would go the same way as so many of her peers in Zanzibar,

Tanzania, where many lack skills came one of the beneficiaries of sought by the job market. Thankfully, Wimbi was thrown a lifeline by her uncle and a project supported by the African Development Fund.

"I was 13; he came to get me and entrusted me to a teacher," she said. But it was far from easy.

I'm sure that once I've finished my studies, I'll be able to set Nearly 95percent of them had become Ministry of Education and Vocationup my own business. Wimbi is one of hundreds who have benefited from the Alternative Learning and Skills Development Project, which is helping the government of Tanzania make strides in addressing the skills challenge.

Starting with around a dozen boarders at first, the centers have grown and now have more than 2,000 students gaining a basic education.

"We had just 32 students in the Raha Leo Alternative Learning Center when we opened in 2006. Every one of them had dropped out of school.

Rufiji villagers advise govt to conduct elections of leaders

TAWI villagers in Rufiii district, Coast Region, are up in arms against the locality leaders for failing to execute their duties and responsibilities properly.

It is now more than one year, the villagers through the village meeting have removed the chairman and also fired a total of three village executive officers in three years period, the village is currently led by hamlet leaders of Mkukiki, Kikobo, Gege and Mkwili on a rotational basis.

Speaking to The Guardian, former chairman of the village natural resource committee Habibu Said Mniwa said the leaders were taking advantage of the distant village location especially long distance between the village and the district's headquarters which is more than 50kms to fail the village for personal gain.

They thought they could do anything they wanted because they couldn't be reached and monitored easily by the district leaders.

"We thank you The Guardian paper very much for coming here to listen to us. We have so many grievances. We have no one to defend us and present our grievances to the district because of distant location of the village," said another villager Salum Ally Kitango.

Mniwa explained that the village set aside the village land forest reserve which has 2,887hectares in 2016, then they started harvesting in 2018

and the village started getting big profits from community based forest conservation but audit from forest stakeholders' revealed huge embezzlement of public funds.

"There were audit cases which the village leaders were supposed to answer at the village meeting but they have never answered and no one villager could be courageous enough to make follow up due to the village complex infrastructures and its distance from the district headquarters.

He said for the ousted village leaders could stay in power for more than six months without convening any village meeting to read income and expenditure of the revenues accrued from community based forest management (CBFM) efforts.

"When you criticize them openly they would fire you from your position in the natural resource committee. They only want polite people who would follow their wishes and supports their ill-gain," he said.

He said violation of good governance and the rule of law was the order of the day and no one would be able to make follow up because the village is located far away from Rufiji district headquarters.

He said the villagers wanted leaders who would be able to manage and supervise the village natural resources and the money accrued from the community based forest management (CBFM).

The villagers therefore call on the government to arrest them and conduct fresh elections of

based forest management (CBFM). Kitango who is also Mbwara ward CCM party publicity secretary also called on fresh elections.

These forest stakeholders have played their part, they provided education on good governance and book keeping, but those who received that education could not practice what they have learnt.

They didn't even consult the former leaders who were trained to tap on their knowledge and experience; as a result they end up misleading the villagers.

The district commissioner major Edward Gowele reinstated the village council and promised to make close follow up on the villagers claim.

HE African Union's (AU) 16th extraordinary summit on 28 May sought solutions to the threats of terrorism and unconstitutional changes of government (UCGs) in Africa. These were "hindering Africa from achieving its goals of becoming a peaceful and prosperous continent," said AU Commission chairperson Moussa Faki Mahamat.

The summit in Malabo, Equatorial Guinea, which came at a time of increasing terrorist attacks and UCGs in Africa, resulted in a draft declaration and draft decision. African heads of state endorsed previous recommendations by the Peace and Security Council (PSC) and other organs that could enhance AU responses to these threats. The outcomes are a continental commitment to addressing these problems, without signalling a significant policy shift in AU responses to

Whether and how these decisions are implemented remains to be seen. Especially considering the significant financial and human resource restrictions the AU faces, particularly the AU Commission, which is expected to be central to implementing these decisions.

The summit declaration adopted the theme "robust response, deepening democracy and collective security." It's mostly a political statement that reiterates AU member states' commitment to previous AU decisions, frameworks and mechanisms on terrorism and UCGs.

It acknowledges how severely the two issues threaten African peace and

Africa's security depends on strategic action – not just verbal commitment

security, and calls on member states to ratify and implement AU decisions and instruments on both. It also reaffirms AU decisions, including establishing a counter-terrorism unit under the African Standby Force (ASF) and implementing a fund to fight terrorism and violent extremism.

The declaration endorses the AU Specialised Technical Committee on Defence, Safety and Security's May 2022 recommendation for an AU and regional economic communities (RECs) agreement on the ASF. It further recommends establishing a counter-terrorism coordination task force at ministerial level to enhance synergy and harmonise counter-terrorism responses at different levels.

The more succinct draft decision includes seven major action-oriented resolutions that provide more guidance on AU responses to UCGs beyond the declaration. The draft decision seeks immediate reactivation of the sanctions sub-committee and establishment of a PSC sub-committee on UCGs to monitor other potential UCGs, including national constitution amendments. The AU Commission has been tasked with developing guidelines for such amendments by the February 2023 summit.

The draft calls for prompt activation of the PSC sub-committee on counterterrorism established in 2010, which has never been functional. It also tasks the AU Commission with consolidating a comprehensive continental strategic plan of action for countering terrorism and violent extremism. This should synthesise the AU's policy frameworks on countering terrorism, mercenarism, small arms and light weapons, transnational organised crime and criminalisation of ransom payments.

At their July executive council meeting, foreign ministers are expected to determine how much funding to allocate to the AU's rapid response capability for emerging conflicts, including terrorism. The funds will come from the Peace Fund's Crisis Reserve Facility. The other two decisions focus on implementing the African Governance Architecture and the African Peace and Security Architecture, and for the next African Peer Review Mechanism governance report to

Establishing a sub-committee on UCGs, independent of the sanctions subcommittee, and renewed commitment to developing guidelines for national constitution amendments, signal AU readiness to go beyond sanctions to manage UCGs. The sub-committee would focus increasingly on preventing and responding early to UCGs, including monitoring incumbents' attempts to amend constitutions to expand their powers or extend terms.

This is a move in the right direction. Contestations over constitutional amendments have contributed to political instability and triggered public protests leading to military interventions in some African countries. Consolidating a continental strategic action plan to counter-terrorism and violent extremism also shows the realisation that a more holistic and coordinated response

is needed. However while the summit's outcomes widened the AU's response to UCGs and terrorism, governance deficits that drive both were again off the table. Addressing governance continentally is challenging due to the sovereignty issue. The AU can only encourage states to make changes. But it can ensure continental policy frameworks provide a holistic response to the threats.

The summit outcomes also seem to have overlooked complementarity between new provisions and previous summit decisions. For example, the February 2022 summit stipulated that a high-level hybrid committee of sitting and former heads of state and government would be established. It would engage incumbents who try to amend national constitutions "without national consen-

The last summit had also decided that a monitoring and oversight committee be established including the AU Commission, RECs, the APRM and member states. It's unclear whether the sub-committee on UCGs will now take over its responsibilities or if they'll work together in a structure yet to be estab-

Implementing the summit decisions will have serious cost implications. The declaration promises a budget for national and regional response to terrorism and violent extremism. However, given the AU's track record of allocating funding to initiatives, member states will have difficulty deciding on a budget and meeting their commitments.

It's also unclear whether this finance will come from the AU's regular budget, the Peace Fund Crisis Reserve Facility or the newly established special counter-terrorism fund. While establishing the counter-terror unit under the ASF was endorsed by the summit, its realisation will face similar financial challenges.

The decision to develop guidelines for the amendment of national constitutions is also not new. Since 2010, member states have asked the AU Commission to develop such a guideline that will be universally applicable to its members. The Commission, however, can't do with its constrained human and financial resources.

The sub-committees on counterterrorism and sanctions have never operated due to inadequate human resources in delegations of member states and the AU Commission. The AU lacks the human resources and financial capacity to monitor and enforce sanction regimes.


Moreover, while various AU agencies working on terrorism and violent extremism might actively support that sub-committee, there are no active units focusing on governance issues to support the UCGs sub-committee.

The AGA is a coordination platform rather than a governance advisory body, while the APRM operates by the invitation of member states. The PSC is the only member of the AGA platform with a mandate to scrutinise the governance performance of member states. However, it has always shied away from this responsibility.

While the summit may have made significant strides in responding to terrorism and UCGs, its success can be measured only to the extent that these decisions are implemented.

Trials for grapevine lines from SA show big promise

TANZANIAN's grape and wine subsector is heading towards a bright future as ongoing trials of the 13 grapevine lines for best wine grape seeds varieties from South Africa are proving impressive successes, it has been said.

The grapevine lines that were planted in special isolated areas at the Tanzania Agricultural Research Institute (TARI-Makutupora) and Hombolo centers have shown good development in adopting the local (Dodoma) weather.

TARI Makutupora director general Dr Cornel Masawe told The Guardian in an interview that the wine grapevine lines have appeared to be resistant to local grapes-related common diseases, which is a good sign for the development of the sub-sector.

As per the Tanzania Plant Health and Pesticide Authority (TPHPA) all plants from outside the country must be planted in isolated areas, a distance from relevant local plant species, for special screening and limitation of contamination of possi-

He informed that the wine grapevines lines were imported into the country through collaboration between giant local wine stakeholders, TARI and the ministry of agriculture with an eye to help improve performance of wine and grape

Though placed second after South Africa for brewing best wines within the

continent, there are only two wine grape varieties grown in Tanzania, Makutupora Red and Chenin White, a situation which limits the country's ability to produce wider varieties of wines and thus, the stakeholders realized over the need

"As per the professional procedures, the grapevine lines will later on be planted into different multilocation trials in Chamwino and Bahi districts as well as in Dodoma municipality. The multilocafor the introduction of more grape wine tion trials will allow the grapevine lines

to be evaluated further by the Tanzania Official Seeds Certification Institute (TOSCI), especially in terms of their distinctiveness, uniformity as well as stability (DUS)," Dr. Masawe stated.

He named the 13 grapevine lines in

white grafted scions as pinotage, cabernet sauvignon, syrah, merlot, during and carignan, chardonnay, chenin black, semillon, ramsey, R99, R110, and S04.

Dr Masawe expressed optimism that the envisaged varieties is expected to play a major role in helping improve performance and status of wine processing industry within the country and thus, curving a fresh successive niche.

"The imported varieties are the most global famous for bottling international wines and thus, we are remaining optimistic that upon their official release they will enable local processors to manufacture quality wines for local use and export," he observed.

Last year, Prime Minister Kassim Majaliwa held a round table meeting with grape farmers and wine processors to deliberate among others, viable ways to heighten performance of the wine sector, the gathering in which the processors raised concern over shortage of grape wine varieties in the

To that end, the processors opted to import the best wine grape seed varieties from South Africa under the supervision support from TARI-Makutupora.

In a joint announcement on Monday, CEO of H2O Securities Julius Steyn said, "The focus with the H2ON token is mainly on the financing of water projects internationally and not so much on the technical engineering and construction of such projects." GEM Digital is no stranger to investing in technologies designed to improve environmental effects and living conditions for humanity. Its portfolio includes investments in Changing World Technologies, a food waste processing

firm, and Neos Ocular, a firm that produces lasers to improve vision.

GEM previously invested in the digital asset management service QBNK Holding AB. H2ON will be used to settle bills between H20N network participants, including water plant operators and their clients. By raising funds to finance water projects, it claims to reduce the time it takes for water suppliers to deliver to new clients compared with traditional means.

Invest more in Africa, Dr Adesina calls upon Irish business community

SINCE joining the African Development Bank Group (AfDB) as its 81st shareholder in 2020, Ireland has shown steadily increasing interest in strengthening its economic ties with Africa.

That mission received a strong boost last week at the 7th Africa Ireland Economic Forum in Dublin, as African Development Bank Group President Dr. Akinwumi Adesina enjoined the Irish business community to invest more in Africa.

"If you are not investing in Africa, you're not in business," Adesina told his audience.

"Foreign direct investment of Ireland in Africa was \$572 million at the end of 2020 and represented only 0.05% of Ireland's total net foreign direct," Adesina

"This is too low. Ireland should invest a lot more in Africa. Let's set a target of 15% of Irish invest-

The exhortation from Africa's premier development finance institution's chief was matched by the Irish authorities' publicly expressed enthusiasm about Ireland-Africa cooperation. Speaking at the forum on Thursday, Minister of Foreign Affairs and Minister of Defence Simon Coveney talked about Ireland's deepening economic and cultural links with Africa. He noted the prospects for closer trading links with the continent, pointing out that trade between Ireland and Africa would likely reach €5 billion by 2025.

Receiving the Bank Group chief on Friday, Irish President Michael D. Higgins congratulated Adesina for his work on the recent establishment of the African Pharmaceutical Technology Foundation. "Nothing is more important than that," said President Higgins. He spoke about his long-time interest in Africa

and his optimism for its economic advancement. Discussing the looming global food crisis prompted by Russia's war in Ukraine, President Higgins welcomed the pre-emptive steps the Bank had taken to ensure food security for the continent.

Describing their meeting, Adesina said: "President Higgins so warmly received me. He has a heart and passion for Africa. He told me: 'You are doing such an incredible job for Africa with your leadership in running the African Development Bank. I am inspired by your vision."

Similar support for continued strong cooperation came from senior Irish officials with whom Adesina met during his visit, notably: Colm Brophy, Minister of State for Overseas Development Aid and Diaspora; John Hogan, Secretary General of the Department of Finance and Alternate Governor for Ireland at the African Development Bank

Group; and Paul Ryan, Director of the department's International Finance and Climate Division, which is responsible for managing Ireland's shareholding in international financial institutions.

Adesina thanked the Irish government for joining the African Development Bank and the African Development Fund, the Bank Group's concessional lending arm, and he expressed appreciation for Ireland's contribution-announced by Foreign Affairs and Defence Minister Coveney on Thursday–of €2 million to the African Development Bank for climate adaptation.

In an address to the forum on Thursday, the African Development Bank head held a packed conference hall captive as he spoke about the current African economic environment, the continent's challenges, its many opportunities, and about the African Development Bank Group's role as a "solutions bank," a

valued partner to its regional member countries, its international development partners, and to the international business community, whose investment he said was desirable. "You can count on the African Development Bank as a partner," he stressed.

The Bank president was also interviewed at the Institute of International European Affairs (IIEA) by Ambassador David Donoghue, Ireland's former Permanent Representative to the United Nations. Welcoming Adesina, he said: "Dr Adesina is often described as Africa's Optimist-in-Chief and is widely praised for his visionary leadership and passion for the transformation of Africa. Since he took over as President of the African Development Bank in 2015, the Bank has achieved the highest capital increase since its establishment in 1964."

In his opening remarks, Paul

Ryan said: "As well as being Africa's Optimist-in-Chief, I'd like to say to Dr. Adesina that he is also Ireland's closest friend in the African Development Bank and in the continent of Africa as well. He has been a fabulous partner for Ireland for the last couple of years, particularly since we joined the Bank in February of 2020. [...] The response by the Bank-under the leadership of the President-to Covid and now to the Ukrainian war, has been absolutely exemplary. A lot of future-proofing kicking has been done in relation to food security, renewable energy, economic development, and it's exactly in line with our developmesnt objectives. We are very happy to join the bank, very pleased with the level of engagement and really pleased with the work that the Bank has been doing in the continent."

Ryan added that Adesina-"first elected President of the Bank in 2015 and unanimously re-elected for another five-year term in August of 2020"-is a bold reformer who completely transformed the agriculture sector in Nigeria as agriculture minister over four years, and that he has replicated that same success at the African Development Bank. "We are very happy with the President. Our fellow colleagues in the constituency are very happy. And more importantly, the wider membership in the continent of Africa are very happy.'

Adesina spoke about the work of the Bank-in particular the High 5 Strategic Priorities that he is credited with developing for the institution-and how he saw these priorities as the fulcrum for both transforming Africa and helping to achieve the UN Sustainable Development Goals.

Adesina invited officials and private sector operatives to the next edition of the Bank's Africa Investment Forum, taking place

ADF approves \$27.19m for skills development infrastructure to promote post-Covid-19 recovery

THE Board of Directors of the African Development Fund (ADF) has approved a \$27.19 million grant to Ghana for infrastructure for skills development and job creation for youth and women in its post-Covid-19 recovery efforts. The grant will enhance higher-level skills delivery in the health system in the West African nation and create jobs for youth and women.

ADF is the concessional financing window of the African Development Bank Group (AfDB) that provides low income Regional Member Countries (RMCs) with concessional loans and grants, guarantees as well as technical assistance.

The Post-Covid-19 Skills Development and Productivity Enhancement Project, comprising two interrelated technical components and a project management component, will be implemented by Ghana's Ministry of Finance over five years – from 2022 to 2027. Targeted primary beneficiaries include youth and women operating small businesses and cooperatives, including people with disabilities. Overall, the project will benefit at least 24,800 people directly and 50,000 indi-

rectly

"This grant aligns with what the Skills for Employability and Productivity in Africa (SEPA) Action Plan 2022-2025 seeks to achieve.

It is a giant step in the right direction. Under SEPA, the Bank will support African countries to invest in science, technology, engineering and mathematics, as well as technical and vocational training to improve productivity and drive innovation across the continent. It is our blueprint for equipping Africans with the skills the labour market requires," said Martha Phiri, the Bank's Director for Human Capital, Youth and Skills Development.

The grant will support the University of Ghana to build three facilities for microbiological research and training, biotechnological research and nursing, and midwifery research and training.

The capacity-building aspect of the project will involve the skilling of lecturers, researchers and health workers in higher institutions of education and health-related fields at the University of Ghana. This support will help increase human resource capacity to manage cur-

rent and future diseases in Ghana.

In addition, the project will provide a credit facility to support women and youth significantly affected by the Covid-19 pandemic at affordable interest rates – 12% per annum.

The intermediary and rural and community banks will provide the credit facility to avoid high-default rates associated with government-sponsored credit schemes. Rural banks will participate by ensuring loan repayments and improving the efficiency and timeliness of small-loan processing.

The Bank's Director-General of the

West Africa Region, Marie Laure Akin-Olugbade, said: "The restoration of livelihoods through strengthening the capacities of MSMEs, as well as the building of infrastructure at the higher education level for health-related skills development, will be a major morale booster for women affected by Covid-19 and will set the stage for fighting diseases and future pandemics in the country." Eyerusalem Fasika, the Bank's Ghana Country Manager, welcomed the project, saying it will address youth unemployment and recovery for vulnerable women whose sources of livelihood were adversely affected by the pandemic. She said the project is in line with the Bank's High 5s, or top priorities, one of which is "Improve the quality of life for the people of Africa."

Wingcopter to deploy fleet of 12,000 cargo drones across Africa

DARMSTADT, Germany

A tech company has signed a deal to roll out 12,000 of its longrange, triple-drop delivery drones across Africa, in what promises to be the largest commercial drone deployment ever attempted.

German firm Wingcopter said the move will address insufficient infrastructure in many African regions; one of the biggest barriers to universal health coverage and economic development.

The partnership with Continental Drones covers all 49 sub-Saharan countries, with the roll-out goal scheduled for over the next five years. Wingcopter also announced this month it has raised \$42 million from investors, tripling the company's total equity raised to more than \$60 million to date.

The company explained: "Setting up large-scale drone delivery networks across African airspace will propel logistics in these countries to a new level and help build an entirely new transport framework - much faster, cheaper, more sustainable, and more efficient than the development of conventional ground-based infrastructure with all its unhealthy and climate-damaging emissions."

Wingcopter said its technology will be deployed to improve the delivery of items including on-demand medicines, vaccines, laboratory samples, as well as essential goods for daily use. The fully electric Wingcopter 198 drone is also expected to contribute to a more sustainable African logistics sector and help move economies towards net-zero emissions.

Tom Plümmer, Co-Founder and CEO of Wingcopter, added: "Wingcopter is well-positioned to execute against the tremendous opportunity of drone delivery in the next decade. We are convinced that our cooperation with Alex and his Continental Drones team will unlock the African drone delivery market on a large scale, allowing us to jointly improve and save millions of lives."

China's Anhui ensures daily supplies amid latest COVID-19 resurgence

HEFEI

EAST China's Anhui Province, which is combating the latest COVID-19 resurgence, has taken a range of measures to guarantee the supply of daily necessities

From June 26 to July 4, a total of 186 confirmed COVID-19 cases and 895 asymptomatic carriers had been logged in the latest epidemic resurgence in Anhui, with the majority of cases being reported in Sixian County, the provincial health commission said Tuesday.

More than 60 supermarkets have been arranged to supply daily necessities to residents in the virus-hit Sixian, where 52

confirmed cases and 164 asymptomatic carriers were reported on Monday alone.

To reduce people-to-people contact, residents can place orders online. Nearly 30,000 orders of individual and collective buying are delivered per day on average in Sixian, according to Lu Qiang, head of the county's bureau of commerce.

"I bought two packages of chicken wings, four apples, eight steamed buns and some vegetables. It cost me less than 80 yuan (around 12 U.S. dollars), which is about the same price at normal times," said a resident surnamed Yao, who did the grocery shopping online.

Local authorities are also

monitoring prices and cracking down on illegal behaviors such as hoarding, fabricating information and price gouging. At present, daily necessities such as flour, rice, meat, cooking oil and more are in stable supply in Sixian.

"We deliver about 3,000 orders of groceries per day on average," said Meng Tao, general manager of Jiamei supermarket in the county.

Meng and 94 other supermarket employees have been living in the supermarket or designated hotels since the latest COVID-19 emergence.

"We try to arrange one delivery vehicle for each residential community after we gather all

the orders. The groceries will be picked up by volunteers waiting at community gates and then sent to each household after disinfection," said

A management system of "three heads" has been implemented in the county to ensure the smooth delivery of supplies and the needs of residents are met in a timely and orderly manner.

Xu Ke, 27, a local government official, is appointed as the head of the Taoliwenyuan community in Sixian. Together with 14 building heads and 68 unit heads, Xu is responsible for collecting the needs of and delivering supplies to the

households in the community.

Each unit head is in charge of the daily supplies of 13 households. For the vulnerable group such as the aged and the disabled, the unit heads will call them or go to their homes to provide services. "The management system breaks down our work to each individual, which enables us to respond to people's needs more precise-

ly," Xu said.

"Some residents have also donated rice, vegetables and instant noodles to those in need in the community. We are all like a big family in this special situation, trying to weather through the difficult time together," she added.

Envoy: India-Africa ties crucial for socio-economic development

THE Harambee Factor is a book written by Gurjit Singh a former Indian Ambassador to Ethiopia, the African Union, Indonesia, ASEAN and Germany.

In the book Singh discusses the India-Africa Economic and Development Partnership and is based on secondary sources and his own experiences in dealing with several issues in a decision making capacity.

The book assesses India's economic and development partnership with Africa and this started early and was enhanced with the launch of the India-Africa Forum Summit (IAFS) in 2008.

The title of the book is 'The 'Harambee Factor' meant pulling together in a cooperation spirit that relates to team work and community bonding to achieve common aims.

The book touches different ways on how India relates with African countries in terms of economic and development partnership. In the book, Singh had shown an abiding knowledge about India's Africa engagement and, how it developed and blossomed.

The book promotes greater business linkages in Africa with India and trilateral partners.

He is a frequent commentator on Africa issues and India's engagement with Africa. He shares his experience with young people including as honorary professor of International Studies at the Indian Institutes of Technology (ITT), Indore.

This book explains Africa continental Free Trade Area and Opportunities for India, it shows that Since May 2019, the Africa Continental Free Trade Area (AfCFTA) has come into force with 24 countries filling ratification papers with the Africa Union Commission

By July 2021, 37 countries had deposited their instruments of ratification. Fifty-four of Africa's 55 countries and Africa Union (AU) members signed the Agreement.

Once all do so the AfCFTA will cover 1.2 billion people, a cumulative GDP of USD trillion.

It is, along with the RCEP, among the largest trade areas since the founding of the WTO in 1995. It is most promising for Africa, but the real challenge will come from clarity between the lines of the Agreement and minute negotiations which are underway.

The objective of the AfCFTA as set out within the Agenda 2063 in the vision that Africa has for enhancing its economic development and do more in cooperation with each other.

The aim is to have a single market for goods and services across the whole continent, allow free movement of business people, let a continental customs union emerge and hence promote more trade and intra-African investment as well as Foreign Direct Investment (FDI).

It was put into operation at the AU Summit in Niamey, Niger on 7th July 2019, and its secretariat is located in Accra, Ghana.

This was based on the adoption of five key instruments that includes The Rules of Origin, The Tariff Concessions, and The Online Mechanism for Monitoring, the Pan-African Payment and Settlement System and the African Trade Observatory.

One of the positive aspects in Africa's growth story is to improve trade facilitation, remove barriers, unify markets and create regional markets which will attract higher Foreign Direct Investment (FDI) and enable smoother trade.

The Successes of the East Africa Community (EAC) covering Tanzania, Uganda, Kenya, Rwanda, Burundi and South Sudan shows that they increased their intra-regional trade over the last decade by about 15% annually.

A similar success was noted by the 15 members of the Southern African Development Community (SADC). Other Regional Economic Communities (RECs) have been slower to organize themselves, but the EAC and SADC members are the main stay of the consequent success of the 25 member Common Market for Eastern and Southern Africa (COMESA).

Also the book looks at the Southern African Customs Union (SACU) with the regards to the Tanzanian trade and other African countries.

It indicates that the SACU experience must hold India in good stead as the South African approach to India is not what the rest of the continent wants with

Several SACU countries often told India that they could not avail of the Lines of Credit (LoC) or other preferences with India due to South Africa views.

A study mentioned in a review of literature indicates that South Africa has ambivalent feelings about India in Africa.

It welcomes India for ICT and human resources development but not much else.

India's focus for trade expansion needs to be with its largest export destinations in Africa, and these are besides South Africa, Tanzania, Nigeria, Kenya, Egypt, Mauritius and Mozambique.

Of these, the last two are Least Developed Countries (LDCs) and getting non-reciprocal Duty Free Tariff Preference (DFTP) advantage leaving the four countries as the effective trade focus for our Free Trade Agreement (FTA) consideration.

With the progress with SACU floundering and no discussion taking place since 2012, India opened a new effort by engaging the COMESA.

A joint study Group Report to examine the feasibility of a Preferential Trade Agreement (PTA)/Free Trade Agreement (FTA) between India and COMESA was established, and its first meeting was held on 30th July 2011 in Lusaka.

The books also elaborates on inadequate information on the markets on both sides (India and Africa) contributes to poor partnerships and low number of ioint ventures.

Business trust as in the India-Africa Business Coun-



cil (IABC) has not been built up enough to promote greater trade and economic expansion between India and Africa.

The business visa issues also encumber better communication and trade meetings, especially for exporting services to African firms and these, in turn, also become impediments for trade.

These ideas were echoed by a group of nearly 400 business people from the Indian diaspora in 11countries in Africa in a video interaction with Ministry of External Affairs (MEA) and Minister for Commerce and Industry (MOCI in May 2019.

Tanzania, Uganda, Kenya, Zambia, Mauritius, Nigeria, Mozambique, Ghana, South Africa, Botswana and Madagascar were countries covered.

Their major suggestions were improving the LoC (see chapter 8), support from more Indian banks through their presence in Africa, introduction of more direct flights between India and Africa, to seek rupee trading terms in view of foreign currency shortages in Africa for trade, a robust dispute settlement mechanism and more offices of the Confederation of Indian Industry (CII) and

the Federation of Indian Chambers of Centre, between 1990 and 2018, India Commerce and Industry (FICCI) in Af-

Action was promised on these issues, but as discussion in this chapter and the next will show these problems seem to have become endemic and defy solutions. Is there inadequate interest shown towards these issues about Africa?

Also the book elaborates on India's major investment partners in Africa, in this survey of African interlocutors carried out for this book, a question that was posed was: "Which part of partnership with India is most valuable for Africa?" in response to this question, the result showed that a huge favour for India Foreign Direct Investment (FDI).

Foreign direct investment was seen by 61.6 percent of respondents as a valuable part of the partnership and 60 percent saw the training programmes. The book also stated those scholarships, the human resource and capacity building as extremely valuable.

"This is far higher than the LoCs which were supported by 28.3 percent, closely followed by the support to venture capital and start-ups from 26.6 percent," Singh said in the book.

Interestingly 40 percent of respondents saw cooperation in agriculture and food security as a valuable asset of the partnership with India.

Also among other elements a few mentions were made of the health sector, PPP projects and social impact.

In his book, Singh stated that Tanzania has a vibrant Indian community and this perhaps assists in higher trade and FDI figure.

According to the Tanzania Investment

invested USD 210 million in 433 projects securing 55,000 jobs. Table 10.1 shows FDI of USD 8.33 million over 33 projects.

Apart from that South Africa is the largest investment partner for India in terms of its 91 projects.

The FDI of USD 5226 million is also substantial, a joint study by CII and PricewaterhouseCoopers (PwC), published in May 2018, indicated that about 140 Indian companies had invested USD 4 billion in South Africa thereby creating direct employment for over 18,000 people.

Also the book elaborates on results of the survey of Indian companies doing business with Africa.

In his book, Singh stated that the interest of Indian companies to do business in Africa is undiminished, they want more support, opportunities and better access to those opportunities to do more

East Africa emerged as the most popular destination among the respondents for doing business and increasing their investments in Africa.

59 percent of the respondents chose this region with country-wise preferences showing Kenya to be the leader with 24 percent voting for it, followed by Tanzania at 13.5 percent and Ethiopia at eight percent.

West Africa drew the interest of 35 percent of the respondents with Ghana being preferred by 10.8 percent of the respondents, followed by Nigeria and Senegal with eight percent each.

The book also touches several areas that Tanzania benefits from the India relationship as technical vocational education and Training, technology sharing, health, telecommunication, tele-

education, trade and investments and telemedicine.

DR Congo declares 14th Ebola outbreak over

KINSHASA

THE health ministry of the Democratic Republic of the Congo (DRC) on Monday declared an end of the latest Ebola outbreak that erupted less than three months ago in Mbandaka, the capital of the northwestern Equateur province.

It was the third outbreak in the province since 2018 and the country's 14th

With greater experience in Ebola control, DRC national emergency teams, with the support from World Health Organization (WHO) and partners, mounted a swift response soon after the outbreak was declared on April 23, rolling out key countermeasures including testing, contact tracing, infection prevention and control, treatment and community engagement.

Vaccination, a crucial protective measure, was launched just four days after the outbreak was declared.

There were four confirmed cases and one probable case, all of whom died, in the latest outbreak.

In the previous outbreak, in Equateur province in June-November 2020, there were 130 confirmed cases and 55 deaths.

"Thanks to the robust response by the national authorities, this outbreak has been brought to an end swiftly with limited transmission of the virus," said Matshidiso Moeti, WHO regional director for Africa. "Crucial lessons have been learned from past outbreaks and they have been applied to devise and deploy an ever more effective Ebola response."

The just-ended outbreak saw a total of 2,104 people vaccinated, including 302 contacts and 1,307 frontline workers.

To facilitate the vaccination rollout, an ultra-cold chain freezer was installed in Mbandaka, allowing for vaccine doses to be safely stored locally and deliv-

The DRC has now recorded 14 Ebola outbreaks since 1976, six of which have occurred since 2018.

"Africa is seeing an increase in Ebola and other infectious diseases that jump from animals to humans impacting large urban areas," said

"We need to be ever more vigilant to ensure we catch cases quickly. This outbreak response shows that by bolstering preparedness, disease surveillance, and swift detection, we can stay a step ahead," she said.

Although the outbreak in Mbandaka has been declared over, health authorities will maintain

surveillance and stand ready to respond quickly to any flare-ups. It is not unusual for sporadic cases to occur following an outbreak, according to a statement by the WHO regional office for Af-

The disease, which affects humans and other primates, is severe and often fatal. Case fatality rates have varied from 25 percent to 90 percent in past outbreaks.

However, with the currently available effective treatment, patients have a significantly higher chance of survival if they are treated early and

given supportive care.

RUSSIA and Mongolia intend to boost friendly ties, progress is observed in many spheres related the implementation of joint projects, Russian Foreign Minister Sergey Lavrov said at a meeting with Mongolian President Ukhnaagiin yesterday.



"I would like to convey greetings and best regards from President Putin. He confirms our adherence to the implementation of all the agreements we reached last December. All these agreements are based on our shared aspiration to strengthen our friendship and preserve the historical memory," the Russian top diplomat noted.

He emphasized that Russia and Mongolia are united by a "shared history, a combat camaraderie forged and hardened in the fight against Nazism and militarism" and noted the goal of preserving the historical memory "in the hearts of Russian and Mongolian citizens."

"Today, we [with Mongolian Foreign Minister Batmunkh Battsetseg] discussed many directions of our strategic partnership, including trade, investments, ethics, transport, the protection of the environment, humanitarian and educational ties and future cooperation in the sphere of peaceful space exploration," the Russian foreign minister explained.

"There is progress in many directions concerning the implementation of joint projects. Trade is recovering well," he added.

In his turn, the Mongolian leader stressed that Russia and Mongolia "have no disagreements" in the political

"Nowadays, we should increase our interaction, <...> boost trade and economic cooperation," the head of state noted. "I think that the historical truth should always remain. All these initiatives and achievements that have been previously attained should continue," he added.

In Ulaanbaatar, Lavrov also met with Mongolian Prime Minister Luvsannamsrain Oyun-Erdene to whom he conveyed best regards from the Russian government and his Russian counterpart Mikhail Mishustin.

"Progress is seen along the entire range of directions after many years when the advancement was very insignificant. And today we emphasized the important role of an intergovernmental commission on trade and economic cooperation in translating this progress to the language of practical results," the Russian minister said.

Copenhagen shooting suspect sectioned, terrorism ruled out

COPENHAGEN

THE man accused of killing three people in a shooting in a Danish shopping mall was ordered on Monday to be held in a closed psychiatric ward, and authorities said they did not suspect the crime to be an act of terrorism.

The 22-year-old Danish male, accused of opening fire on Sunday afternoon on shoppers in the Field's mall a few kilometers south of downtown Copenhagen, was arrested and charged with manslaughter and intent to kill. He was remanded into custody

for 24 days and will undergo a psychiatric evaluation, authorities said. The court has barred publication of his name, which is common in criminal cases in Denmark.

The incident shocked Denmark at the end of an otherwise festive

week in which it hosted the first three stages of the Tour de France cycle race and hundreds of thousands of cheering Danes took to the streets across the country.

The shooter killed two 17-yearolds and a 47-year-old. Seven other people were wounded with gunshots, four with serious injuries, including a 16-year-old girl. Twenty people received other injuries fleeing the scene.

The incident could not be viewed as an "act of terror" based on current evidence, Chief Police Inspector Soren Thomassen told reporters, adding there was no indication the suspect had acted together with others.

"There has been some sort of deliberation and preparation (by the suspect) up to this terrible event," Thomassen told a news conference without providing details on the perpetrator's possible is that these are random victims."

The attack took place when many young people were visiting the mall ahead of a concert due to be held nearby by British singer Harry Styles. The concert was canceled.

"I'm heartbroken along with the

people of Copenhagen. I adore this city. The people are so warm and full of love. I'm devastated for the victims, their families, and everyone hurting," Styles wrote on Twitter. "I'm sorry we couldn't be together. Please look after each other." The suspect, who police said was known to psychiatrists in Denmark, was in possession of a rifle, ammunition and a knife when he was arrested.

Danish gun laws are strict and all firearms, with the exception of some hunting rifles, require a motives. i"Our current assessment license issued by the police. The shooter did not have such a license. Denmark's largest cinema operator Nordisk Film, which has a venue at the Field's shopping center, said it had decided to close its theaters across the country on Monday due to the shooting.

Australia floods worsen as more Sydney residents evacuated

SYDNEY

TORRENTIAL rains kept battering Australia's east coast yesterday, intensifying the flood crisis in Sydney as thousands more residents were ordered to leave their homes after rivers swiftly rose past danger levels.

About 50,000 residents in New South Wales, most in Sydney's western suburbs, have been told to either evacuate or warned they might receive evacuation orders, up from Monday's 30,000, authorities said.

"This event is far from over, please don't be complacent," New

South Wales Premier Dominic Perrottet told reporters. "Wherever you are, please be careful when you're driving on our roads. There are still substantial risks for flash flooding.'

The latest wild storm cell which brought heavy rains with several places receiving more than Australia's annual average rainfall in three days - is likely to ease in Sydney from Tuesday as the coastal trough moves north, the Bureau of Meteorology (BoM)

But the risk of flooding could remain through the week with most river catchments already near capacity even before the latest deluge.

About 90mm (3.5 inches) of rain could fall over six hours in the state's mid-north coast from Tuesday, reaching up to 125mm in some places, BoM said.

Winds up to 90km per hour (56 miles per hour) are also forecast in several flood-hit places, raising the risk of falling trees and power

"We're asking people across Sydney today to please stay at home unless you really need to leave the house," state Emergency Management Minister Steph Cooke said.

The federal government late on Monday declared the floods a natural disaster, helping floodhit residents receive emergency funding support.

Emergency crews will continue their rescue operation on Tuesday to tow a bulk carrier ship that lost power off the coast of Sydney after tow lines broke in severe weather, officials said.

Major flooding is occurring at Windsor in Sydney's west, which is going through its third flood this year, with current water levels higher than seen in the deluge early this year, the weather bureau said.

Footage on social media showed submerged roads and bridges, while emergency crews rescued stranded people from partially submerged vehicles that became stuck in rising waters.

Nigel Myron, a Windsor resident, said he has kept an inflatable boat ready if he had to evacuate though he is looking to move back to his place once waters recede.

"At the end of the day, what can you do? It is what it is and we dust ourselves off from the ashes and rebuild after the floods have come and gone," Myron told ABC televi-Agencies

PALESTINE on Monday rejected the results of the ballistic investigation attended by U.S. experts into the gunshot that killed veteran Palestinian-American journalist in northern West Bank in Mav. Earlier in the day, the Israeli army announced that the in-

vestigation could not determine the party responsible for the killing of Shireen Abu Akleh, the reporter of the Qatari Al-Jazeera news channel in the Palestinian territories.

Palestinian presidential spokesman Nabil Abu Rudeineh said in a statement that the Palestinian side "holds Israel fully responsible for the killing of Abu Akleh" and called on the United States "to maintain its credibility."

On Saturday, the bullet that killed Abu Akleh was received by Michael Wenzel, the U.S. security coordinator for Israel and the Palestinian Authority, for a professional and independent ballistic examination.

The ballistic test was conducted in an Israeli forensic laboratory with experienced representatives from the United States attending all the stages of the test to determine the weapon from which it was fired, the Israeli military said in a statement.

"Despite the efforts made, it has been found that in light of the condition of the bullet and the quality of the markings on it, it is not possible to determine whether the bullet was fired from the weapon tested or not," the statement added.

By summarizing both Israeli and Palestinian investigations, the U.S. security coordinator said in a statement that gunfire from Israeli positions was "likely responsible" for the death of Abu Akleh but no reason was found "to believe that this was intentional."

Abu Rudeineh said that the Palestinian side "won't accept, under any circumstances, the tampering with the outcome of the Palestinian investigation." "We will pursue the case of her (Abu Akleh) assassination in international courts, especially before the Criminal Court," he added.

He learned Chinese at Beijing Language Institute, or what's known today as Beijing Language and Culture University, and learned TCM at Beijing Medical College, which is currently known as Peking University Health Science Center. In Beijing, he graduated with a degree of doctor of medicine.

"When I first arrived in China, the country has just started its reform and opening up drive, and there was vitality everywhere. In the following 10 years, drastic changes happened throughout the country. I saw the energy of an ancient civilization in its transition," Khalil noted.

After returning to his motherland, Khalil became a TCM doctor. He always introduced China to his fellow countrymen to promote Moroccan's understanding of China and the Chinese people. He told People's Daily that he has been receiving

more patients after getting the Award for Outstanding Contribution to China-Arab Friendship, which makes him

busier, but happier, too. "I always remember what President Xi told me. I'm acting as an envoy for Morocco-China friendship and building a bridge between the two peoples by spreading traditional Chinese culture,

including TCM," he said. "The Moroccans are interested in the outstanding traditional Chinese culture, and also impressed by the modern development miracle of China," Khalil

These years, Khalil has been spending a lot of time reading the book Xi Jinping: The Governance of China, through which he has gained a more profound understanding of why China could make such huge changes and become more confident about China's development prospects.

"It's unquestionable that President Xi has brilliant political wisdom. Under his leadership, the Chinese people's aspiration for a better life is gradually turning into reality," he said.

Khalil believes that by drawing wisdom from its long history, China has achieved peaceful development, which not only makes China a strong and prospering country, but also contributes to the stability and development of the world.

ETF trading under mainland-Hong Kong stock connect kicks off

TRADING of exchange-traded funds (ETFs) under the mainland-Hong Kong stock connect programs began on Monday, marking a significant step to deepening the cooperation of capital markets in both the Chinese mainland and Hong Kong.

The inclusion of ETFs in stock connect programs will facilitate investment for both domestic and overseas investors, and help asset managers and brokers of the Chinese mainland and Hong Kong further improve their management and service, said Cai Jianchun, general manager of the Shanghai Stock Exchange, at Monday's online launch ceremony.

The move will be conducive to the integration of capital markets in the Chinese mainland and Hong Kong, and is of far-reaching significance for promoting the two-way opening-up of the financial sector, according to Bosera Funds.

Among the first batch of ETFs included in the stock connect programs, 83 ETFs are from the domestic A-share market and four are from the Hong Kong stock market.

As an investment product widely recognized by domestic and overseas investors, ETF has the advantages of diversified investment, openness, low transaction cost and high efficiency, Sha Yan, general manager of the Shenzhen Stock Exchange, noted.

The inclusion of ETFs will enrich crossborder investment products, provide more investment convenience and opportunities for domestic and overseas investors, and promote the sustained, stable and healthy development of both the Chinese mainland and Hong Kong market, she added.

Lawrence Lau, leader of EY Greater China Financial Accounting Advisory, who saw the launch of ETF as a "win-win" move for the capital markets, said that in the first half of the year, Chinese A-share and Hong Kong took a lead in the initial public offerings among global bourses.

With more sci-tech innovation enterprises listed on the Shanghai and Shenzhen bourses, the A-share market holds great appeal for overseas investors, while investors from the Chinese mainland also have the demand to purchase Hong Kong stocks, Lau said.

Brutal police shooting of African American man tears open scar of US racism

WASHINGTON

THE brutal police shooting of African American Jayland Walker by multiple officers with dozens of shots in Akron, Ohio, a week ago has torn open the nation's scar of racism.

Protesters continued to take to the streets in Akron on Monday to demand justice for Walker while decrying police violence and racism. A day earlier, the Akron Police Department released bodycamera footage of the deadly encounter, which took place after midnight on June 27 during an attempted traffic stop.

Officers attempted to pull over Walker on unspecified traffic violations and they chased his vehicle on the expressway for several minutes, according to the police. Walker then allegedly jumped out of his car while the footage showed officers pursuing him on foot before opening fire.

The police department said officers "reported a firearm being dis-

charged from the suspect vehicle" during the encounter. Walker, 25, suffered more than 60 gunshot wounds and was unarmed at the time, Akron Police Chief Steve Mylett told reporters on Sunday.

Eight officers who were directly involved in the shooting have been placed on administrative leave as part of the protocol in a police shooting.

The city had contacted the Ohio Attorney General's Bureau of Criminal Investigation and requested an independent investigation into the incident. The process is underway.

"A traffic violation ended in 60 gunshot wounds before they handcuffed his dead body," Brian Normoyle, an American political and social commentator and writer tweeted. "There can be no excuse." "Remember it. Don't forget it. And add it to the interminable list of atrocities against Black Americans perpetrated by systemic racism," Normoyle wrote.

and kill over 1,000 people each year, and African Americans are victims at a disproportionate rate, according to data from Mapping Police Violence. African Americans are nearly three times more likely to be shot and killed by law enforcement than their white counterparts, the data showed.

China ramps up efforts in intellectual property protection for better innovation

AS the global center of innovation is shifting to Asia, China has established itself as a leader in global innovation, said Liu Hua, Director of the World Intellectual Property Organization Office in China.

According to statistics, China's R&D spending grew from 1.03 trillion yuan (\$153.76 billion) in 2012 to 2.79 trillion yuan in 2021, ranking second in the world. The R&D intensity increased from 1.91 percent to 2.44 percent during the same period.

The country is the only middleincome economy in the world that has made it into the top 15 on the moving its position from 34th place in 2012 to 12th in 2021.

At present, China is the world's second-largest digital economy, and it's also a forerunner in solar photovoltaic, wind power, new display, semiconductor lighting and advanced energy storage industries. The power of innovation is driving every sector of the country.

The achievement of Chinese tech giant Huawei is a miniature of China making major breakthroughs in technological development and innovation in recent

At the latest Broadening the Innovation Landscape 2022 forum, the company released a batch of its latest self-developed technologies in areas such as autopilot, industrial Internet, communication network and smartphone. These technologies feature higher performance and lower energy consumption. Some of them have been commercialized, and others will be introduced to the market

Huawei has also achieved stellar performance as an innovative

global player. Last year, it had more granted patents than any other Chinese company, filed the most patent applications with the European Patent Office, and ranked fifth in terms of new patents granted in the U.S.

In 2021, Huawei published 6,952 PCT applications, up nearly 1,500 from a year ago, which made it the top filer globally for five consecutive years. As of the end of 2021, the company held more than 110,000 active patents across over 45,000 patent families, over 90 percent of which were invention

The strong innovation vitality couldn't have been achieved without the firm steps taken by China in intellectual property rights (IPR) protection.

In 2021, China cracked down upon 50,100 cases of patent and trademark infringement, handled 49,800 cases of administrative adjudications on patent infringement and disputes, and launched mediation for 64,800 IPR disputes. In addition, the country

also investigated 2,957 counterfeiting crimes and deleted nearly 1.2 million copyright-infringing links.

According to an investigation report, the public's satisfaction with IPR protection in China grew to 80.61 points. Last year, the number of inven-

tion patents granted on applicants from foreign countries reached 110,000, up 23 percent from the previous year, and over 194,000 trademarks were registered by foreign applicants, up 5.2 percent vear on vear.

The number of patents granted to applicants from the U.S. rose by 32.1 percent, and the number of trademarks registered by U.S. applicants went up by 17.3 percent.

According to the Business Confidence Survey 2021 released by the European Union Chamber of Commerce in China, over half of the respondents considered Chinese IPR law enforcement "good enough" and "very good," which was unprecedented in previous

surveys. China needs to advance interna-

tional cooperation on intellectual property to better serve the development of an open economy, said a plan on the protection and utilization of IPR during the 14th Five-Year Plan period (2021-2025) issued by the State Council. In this period, China will be more active in the global intellectual property governance, and work with the rest of the world to improve the quality of international cooperation on intellectual property. Intellectual property is a bridge

linking innovation and the market, as well as a bond that connects technology and the economy. Thanks to the improved IPR protection and business environment, China has witnessed 100 million new market entities in the recent 10 years.

The country will keep promoting innovation and IPR protection to drive technological progress, industrial upgrading and sustainable development, despite the rising uncertainties in the global economic recovery.

Reality bites in Asia over NATO push

WHEN NATO leaders met last week in Madrid, they were joined for the first time by leaders from Japan, South Korea, Australia and New Zealand. The invitations extended to the Asia-Pacific countries show that the trans-Atlantic alliance's ambitions far exceed the boundaries of its traditional geographical

Although the participation of the four countries did help put on a show of unity for the alliance, especially after they agreed to cooperate with NATO to condemn Russia while hyping up the so-called China threat, their resolve remains to be tested by growing economic pressures at home.

On Monday, the chief of Japan's Mitsui OSK Lines, one of world's largest shipping companies, said Japan will have to continue importing Russian liquefied natural gas regardless of

Russia's national policy. Takeshi Hashimoto, president and chief executive of the shipping giant, said: "Nowadays, the spot market for both LNG and coal is quite expensive. That is one of the reasons why Japan is so reluctant to stop LNG imports from Russia."

Hashimoto's comments reveal how influential figures in Japan, which followed the United States' lead in imposing sanctions on Russia, are having second thoughts about that approach.

They also suggest that, beyond the hugs and handshakes, the leaders at the gathering in the Spanish capital may start diverging from the common line on banning Russia's energy

Since the Ukraine crisis started, Japan has not hesitated



in taking provocative actions against Russia. However, as Japan's power system comes under pressure from a scorching heat wave, Tokyo has avoided any direct action on Russian LNG, which makes up 9 percent of Japan's imports.

Growing tensions "The US and NATO members

keep bragging that they are socalled like-minded countries but the talks could not disguise the growing tensions between them as the economic burden becomes more apparent and more pressing," said Wang Qi, a researcher of East Asian studies at the Chinese Academy of Social Sciences in Beijing. "In this context, people in Asia should stay on high alert over NATO because historically the alliance has constantly sought to make advances into new areas and domains and waged wars in various countries in the world to divert problems at home."

At the Madrid summit, NATO formally defined China for the first time as a challenge in its socalled Strategic Concept for the next decade, prompting grave concerns and expressions of firm opposition from Beijing. "It is NATO that poses system-

ic challenges to world security and stability," said Zhao Lijian, a spokesman for the Chinese Foreign Ministry, in a recent news conference. Attempts to undermine Asia's peace and stability are "bound to fail", he added.

Mustafa Hyder Sayed, executive director of the Pakistan-China Institute, a think tank in Islamabad, said NATO's tilt toward Asia is built on shaky foun-

In this approach, Washington and its allies have decided to jump on the new Cold War bandwagon, Sayed said. "Unfortunately, this will make the region more insecure and more susceptible to conflict," he said.

needs to give the coach another option. It is no wonder they began by signing Ivorian attacking midfielder Kipre Junior from Sol FC, then added Tape Edinho from the same

In a bid to strengthen the midfield, Nigerian

Issah Ndala has been recruited from Plateau United. Cleophace Mkandala was the first local

signing for Azam FC. He comes from Dodoma Jiji FC as a direct replacement for the released Frank Domayo.

On fullback Nicholas Wadada, Azam FC will release him, if they have not already done so.

He did not play much last season because of injuries, but he is still a quality and class player who can add value to any team. The club was forced to deploy Lusajo Mwaikenda on the right full-back.

Mwaikenda has strengths to his game, particularly in defensive situations, but he loses value to Azam FC when you consider how modern teams wish to use their full-backs on both sides of the ball.

Azam FC would certainly need a more attack-minded right full-back.

But the problem could be solved with rumours flying around that Azam FC has already signed Ruvu Shooting's youngster Nathaniel Chilambo.

They have also been heavily linked with Geita Gold FC's David Kameta 'Duchu'.

While Chilambo proved to be a prospect at Ruvu Shooting last season, he is just that - a prospect.

If he were to be the go-to man on the right

flank he could break because of Azam FC's

He would need another big experienced right full-back who can take the pressure and

Azam FC has done well to start their signings and release the players they no longer needed before going on the break at the end of the justconcluded season.

This means the technical bench led by head coach Moallin can start planning properly knowing which players he would have in his

It is said that a coach must sometimes adjust his style, system, and philosophy based on the players he has. And for Moallin it helps that he knows his team before going on the short

But there are still other issues that the club has not solved, chiefly the defense.

Out of the top four teams, they conceded the highest number of goals, a fact that highlights their defensive issues. Mathias Kigonya and Ahmed Salula were not convincing between the goalposts

Youngster Wilbol Maseke had to be called in to steady the ship but a need for an experienced quality goalkeeper is clear to all.

While they did well in releasing Kigonya who was surplus to the requirement under Moallin from the onset, they have not been able to find his replacements as yet.

A centre-back is also a pressing issue. It is believed the club is thinking about whether or not to sign new attackers in this transfer

The Ice Cream makers' current options up front have struggled at times throughout the season, the squad scoring a total of just 41 league goals.

Despite Rodgers Kola and Idris Mbombo finishing with nine goals apiece, it felt like Azam FC had no recognized first-choice striker in the whole season.

Prince Dube's injury woes continued in a difficult campaign that ended with just one league goal to his name.

Mid-season arrival, Shaban Chilunda is yet to regain his form. It would not be a surprise the club may look to sign new players in the forward positions to compete on various fronts once again next season.

They cannot afford to once again struggle with efficiency, goal-scoring records, consistency, determination, and precision in the box against teams.

Azam FC's struggles last season could also be attributed to missing key players through longterm injuries and that one solution to this is to add quality options to the squad as Yanga and Simba have been doing.

Admittedly, although we as a country do not have large cadres of Yanga have unseated them from the local talents playing abroad, it is still nevertheless a giant stride forward whenever one of our brightest stars gets the golden opportunity to

play professional football overseas.

It is also hoped that Dismas will grab this opportunity with both hands and give a great account of himself on Belgian football's grandest stage.

We should as well cross our fingers that Dismas' transfer to Belgium will pave the way for other talented Tanzanian players to move overseas to play professional football in the sport's toughest leagues.

The evolution of Gabriel Jesus: How new Arsenal striker's game has changed

AFTER 5½ years at Manchester City, Gabriel Jesus will begin a new chapter in his Premier League career after completing his £45 million transfer to Arsenal this summer.

for City Jesus signed from Palmeiras in the summer of 2016 for around £30m but didn't join up with his new team until January 2017, when the 19-year-old was finally freed up to make the switch to the Premier League.

He first arrived at the Etihad as an energetic, versatile, all-action forward who had scored 26 goals in 67 senior appearances for his boyhood club prior to joining City. He leaves having scored 95 goals in 236 games in all competitions (and also registering 46 assists) while playing his part in four Premier League title wins, one FA Cup, three EFL Cups and a run to the 2021 Champions League final.

However, the Brazil international was restricted to just 20 starts in the league last season, and while he still pitched in with eight goals and nine assists, the time is obviously right for Jesus to seek a fresh challenge elsewhere - especially with City bringing in Erling Haaland from Borussia Dortmund this summer.

During his early career at City, Jesus was mainly deployed as a specialist goal poacher in a central role. He was undoubtedly effective, and quickly made a habit of scoring from close range with one-touch finishes. In fact, only one of his first 14 Premier League goals was scored from more than 8 yards out, and that was a penalty against Leicester in May 2017.

Since then his game has evolved and Jesus has adapted to become a much more rounded, Pep Guardiola-style forward, playing off either flank or down the middle when required. As such, he has added many more adept passes, touches in the penalty area, assists and even goals from outside the box to his rep-

With the 25-year-old on his

stats for Jesus' goal contributions and all-round play and a seasonby-season look at precisely how Jesus has changed his game.

A 19-year-old Jesus first started life at City operating mainly as a classic out-and-out No. 9, specialising in instinctive bursts of movement, close-range manoeuvering and one-touch finishes.

His very first goal for the club emphasises the point, with the striker opening his account by scoring City's third goal in a 4-0 victory over West Ham at the London Stadium on Feb. 1, 2017 - a tap-in from the edge of the 6-yard box to finish off an incisive passing move, i.e. the textbook Guardiola goal.

In his first half-season, Jesus continued in much the same vein and ended the 2016-17 campaign with seven goals in his first 11 games for City. While two of those goals came via his left foot, four via his right and one via his head, all seven of them were scored from inside the penalty

Iesus' first full season under Guardiola at City saw the forward make 42 appearances in all competitions, with 34 of them coming as a central striker.

Demonstrating an impressive efficiency in front of goal, Jesus scored 17 goals in all competitions from an xG rating of just 17.72. Once again, all 17 of his goals came from inside the box (eight from inside the 6-yard box). He also averaged just 4.2 touches of the ball inside the penalty area per 90 minutes -- the lowest season tally of his City career.

As well as returning his lowest single-season pass completion rate (80.3%), the Brazilian also completed fewer dribbles per game (0.8) and registered fewer assists (three) in 2017-18 than during any other season he spent at the Etihad, thus demonstrating the heavy emphasis on goal scoring rather than goal creation.

Jesus' crowning moment of the 2017-18 season came in the 94th minute of the final league game of the season when he scored deep into stoppage time

way to the Emirates, here are the to secure a narrow 1-0 victory over Southampton. City were already champions by that point, but the Brazilian's strike ensured that Guardiola's side became the first in history to reach 100 points in a top-flight campaign, leading to them being dubbed the "Cen-

His hat trick against Shakhtar Donetsk in the group stages of the Champions League is also notable for containing, along with two penalties, the one and only goal Jesus ever scored for City from outside the 18-yard box. When you look at his delicious 20-yard lob, scored in the 92nd minute, you wonder why he didn't score more.

> The season after that treble proved to be the most prolific season of Jesus' City career, thanks at least in part to a succession of injury issues that regularly kept first-choice striker Sergio Aguero out of contention. Jesus capitalised and scored 23 goals in 53 games for City -- his best return for the club -- while also chipping in with 11 assists.

> While City had to make do with the EFL Cup as their only silverware after finishing runners-up behind Liverpool in a COVIDmired Premier League campaign, their Brazilian striker achieved several career highs in statistical

point during his City stint, and also saw his average completed dribbles rank rise to 1.3 per game - signifying the beginning of a subtle shift in his style of

Jesus also became only the second player in Champions League history to score for an English club in both legs of a knockout tie against Real Madrid after Ruud van Nistelrooy did likewise for Manchester United in 2003-04.

Minor injuries, a positive COVID-19 test and a suspension all combined to reduce the amount of time Jesus spent on the pitch throughout 2020-21, with his stats suffering accordingly. The striker made just 42 appearances for City in all competitions (down from 53 the previous season), scored 14 goals and laid on four assists -- his lowest goal contribution return in any of his five full seasons at the Etihad.

Exactly half of Jesus' 14 goals were scored at close range inside the 6-yard box - five with his left foot, seven with his right and two with his head. Compounding his struggles, the striker's average for touches inside the area fell almost 20% from 5.7 per game in 2019-20 to 4.7 per game in 2020-21.

On the upside, the Brazilian's total of 14 goals were scored from an xG rating of just 14.2, his pass-completion rate remained steady (84.6%) and he also successfully completed more dribbles on average (1.6 per 90 minutes) than during any other season at the Etihad. In short, he carried and moved the ball more effectively in the build-up of attacks, but at the cost of being in the right place at the right time to convert chances. The fact that midfielders Ilkay Gundogan (17 goals), Phil Foden (16) Raheem Sterling (14) and Rivad Mahrez (14) emerged as the club's top goal scorers in 2020-21 suggests a more holistic approach to sharing the goals around.

City once again shared the goals around in 2021-22, with Mahrez emerging top of the club's scoring charts in all competitions with 24 goals to his name, followed by Kevin De Bruyne (19) and Sterling (17). Jesus made the fewest appearances for City (41) in any of his five full seasons at the Etihad and also amassed his lowest goal tally (13), though he was able to ramp up his assist count to a joint-high of 11.

Of the forward's 13 goals, just one came via his left foot and one other with his head, with all 13 being scored from inside the 18-yard box. However, only four were scored from inside the 6-vard box, which represents Jesus' lowest yield of closerange tap-ins since his first few months at City in 2016-17.

Jesus' reduced participation will have naturally had a negative effect on his productivity in terms of goal contributions, but it is perhaps worth noting that he enjoyed a spike in average touches inside the area (5.8 per game - a career high), pass completion (85.1%) and minutes per assist (233.7 - again, a career

The future?

Last season saw Arsenal ship Pierre-Emerick Aubameyang out of the club on a free transfer to Barcelona in February, Aubameyang having been stripped of the club captaincy and frozen out of the squad two months earlier, while Alexandre Lacazette left as a free agent in a more dignified exit when his own contract expired at the end of the campaign.

Given that the Gunners' top scorer in all competition in 2021-22 was 19-yearold winger Bukayo Saka (12 goals), and that only three members of Mikel Arteta's squad successfully reached double figures in terms of goals, the Gunners will no doubt be hoping Jesus can revert back into the ruthless poacher of yester-

Whether the Brazilian is able to bring those qualities back to the fore and readapt to life as a penalty-box predator capable of scoring 20-plus goals a season remains to be seen. Perhaps a mix of both wouldn't be a bad thing either, especially as the Gunners aren't overly blessed with an abundance of seasoned, Premier League-proven goal scorers.

Young academy product Eddie Nketiah has been rewarded for his lateseason form -- when he scored five goals in the final seven games -- with a new contract, but the 23-year-old is still far from the finished article. And, with Fabio Vieira joining the ranks of attacking midfielders and wide forwards at Arteta's disposal, actually having someone in the area to finish chances with reliable regularity will be key to Arsenal's hopes of finishing in the top four next season. No pressure, Gabriel.

Ronaldo has left Man United high and dry with handling of desire to leave

THE endgame of Cristiano Ronaldo's Manchester United career is now in play. Despite the club's public position stating that the Portugal forward will not be leaving Old Trafford this summer, it is increasingly likely that he has already made his final appearance in a United shirt.

A delayed return to the first day of preseason training on Monday, due to family reasons, follows after sources told ESPN at the weekend that Ronaldo wants to leave United less than a year after returning to Old Trafford, 12 years after initially leaving the club for Real Madrid. It is also unclear as to whether Ronaldo will fly to Bangkok on Friday with the rest of the squad for the start of United's 21/2-week tour of Thailand and Australia.

Erik ten Hag was always going to have a bumpy ride in his early months as United's new manager due to the mountain of problems he inherited from his predecessors, but a frenzy of speculation around the future of his most high-profile player is a distraction he could do without.

Sources have told ESPN, however, that United would be open to offloading Ronaldo, 37, if a club outside the Premier League is prepared to take on the final 12 months of his £500,000-a-week contract. As reported by ESPN on Saturday, there is tentative interest from Bayern Munich and Napoli, while sources said on Monday that Chelsea have been told the former Real Madrid and Juventus player could be willing to move to Stamford Bridge but are yet to decide whether to make a formal offer.

A move to Chelsea would, right now, be unpalatable to United due to the club's determination to qualify for the 2023-24 Champions League. With Chelsea being a direct competitor for a top-four finish in the Premier League, there is little prospect of Ronaldo being allowed to move to Stamford Bridge, but there would be less resistance within the United hierarchy to a deal being struck with Bayern, Napoli or any other European team that may yet emerge as a potential destination.

And while the consistent message from United throughout the summer has been that Ronaldo is part of new boss Ten Hag's plans and will be at the club next season, sources have said that there is an acceptance that allowing him to leave now will ultimately help accelerate the former Ajax coach's rebuilding programme. But perhaps for the first time in his two spells at United, Ronaldo has let the team down by waiting until now - just five weeks before the start of the new season - to signal his desire to leave Old Trafford in order to play in the Champions League next season.

On June 3, Ronaldo spoke to United's official website and, without directly saying that he would stay, gave a strong hint that he would remain at the club by speaking of wanting to "win trophies next year" and giving Ten Hag "time to make changes." Sources have told ESPN, though, that there has been a constant sense behind the scenes at United this summer that Ronaldo was waiting for the right moment to push for a move and that there would be few tears shed in the dressing room if he chose to leave, pointing to tensions within the squad centred around Ronaldo and his demanding personality.

But while many of his teammates may be happy to see Ronaldo go, by allowing news of his unhappiness at the club to emerge now, he has left United on the back foot in terms of finding a replacement. United are already toiling in the transfer market this summer with no new signings being made before all the squad return to training. Sources have said that Feyenoord left-back Tyrell Malacia will complete a move within the next 48 hours, Christian Eriksen has agreed to join the club on a three-year deal and there is a hope that Ajax defender Lisandro Martinez will also arrive this week, but primary target Frenkie de Jong has still to be signed from Barcelona and there have been no additions to the attacking options. If Ronaldo goes, United will have to find a replacement for the player who was their 24-goal top scorer last season. Ajax winger Antony is high on the list of targets, but the 22-year-old would be a gamble rather than the proven goal scorer United would clearly need.

But by keeping United waiting until now to make his intentions clear, Ronaldo has prevented the club from competing for forwards who have already made big moves. Richarlison (Everton to Tottenham Hotspur) and Gabriel Jesus (Manchester City to Arsenal) would have offered proven options, while United could have made a more concerted effort to thwart Liverpool's move to sign Darwin Nunez from Benfica. As it stands now, they could attempt to beat Barcelona to Bayern Munich's Robert Lewandowski or even offer Paris Saint-Germain the chance to take Neymar off their hands, but those are the kinds of last-minute, high-profile deals that United are trying to consign to the past. But Ronaldo has ensured that everything must now be on the table.

Nobody comes out of this situation well. Ronaldo should have made his intentions clear at the end of last season, but United and Ten Hag have also had opportunities to force the issue and deal with it much sooner. The end result of the communications failure on both sides is a situation that leaves both parties in a race against time, which suits neither.

Ronaldo must find a club ready and willing to fund his signing, while United have to identify a replacement and sign him, at the same time as attempting to bolster Ten Hag's squad with the reinforcements they already desperately needed.

But one thing is certain: Ronaldo's time at United is up.


