"I appeal to the government to officially declare the day Dr Mengi passed away as a special day for tree-planting in the country," suggested Prof Msafiri in an interview with this paper.

RC Mghwira said that considering the late

Dr Mengi's contribution in environmental conservation whereby he sponsored planting of millions of trees in the country, there can be no other befitting way of remembering him than planting trees.

"We are proud of late Dr Mengi for his outstanding contribution towards greening Kilimanjaro region in particular and Tanzania in general. We must continue these efforts because our country has for the past 20 years been adversely affected by environmental degradation," she stated.

## Councillors aghast at hippos, jumbos threat

RESIDENTS of villages neighbouring the Mtera Dam and Ruaha National Park in Iringa Region have called on relevant authorities to control large numbers of hippopotamus and elephants that have reportedly killed seven people in one month.

Speaking at a council meeting over the weekend, councillors from various wards in the surrounding areas of the dam and the park said hippos and elephants have become a big concern because, apart from attacking and killing people, the animals destroy crops in the fields.

Migoli Ward Councillor Majaliwa Lyaki (Chadema) said that attacks in the Mtera dam by hippos have increased such that the government should reduce their number by harvesting them.

He said it has been a long time that these

## PM awaits 10,000 East Asian visitors

LESS than a fortnight after a thousand visitors from the Middle East toured Tanzania, the country has just received the first batch of expected 10,000 tourists from the Far East.

Landing at the Kilimanjaro International Airport (KIA) on Sunday evening, more than 350 tourists from China kicked off their itinerary by sampling Northern Zone attractions, including the Ngorongoro Crater and Serengeti National Park.

They were received at the terminal by Prime Minister Kassim Majaliwa, who described the entourage as yet another indication that Tanzania

is becoming a lucrative destination for visitors and investors from overseas.

The 10,000 visitors from China will be touring Tanzania through the "Tour Africa - New Horizon" program coordinated by Touch Road International Holding Group, which in addition to opening doors for tourists from the Far East, is hatching a new initiative where some visitors are going to identify potential areas of investments in Tanzania.

The arrival of tourists from China follows an agreement inked last year between the Tanzania Tourist Board (TTB) and Touch Road

# Sumatra nabs bus tracking violators

THE Surface and Marine Transport Regulatory Authority (SUMATRA) in Morogoro region has suspended seven upcountry buses plying the Dar es Salaam to eastern and western regions route for tempering with the Vehicle Tracking System (VTS) to enable them speed without being detected.

The vehicles have been caught violating road safety rules by driving beyond the permitted 80km per hour in an Eastern zone joint inspection which commenced on Monday last week.


SUMATRA in collaboration with Morogoro police authorities conducted the inspection by erecting two check points at Msamvu regional bus terminal and Mikese on the outskirts of the town, for trucks.

Speaking to The Guardian at the weekend about the operation, SUMATRA Director General Gilliard Ngewe named the suspended buses as BM with registration number T 591 DCL owned by Blaston Makundi, which routes Dar to Morogoro, along with two Classic Coach buses with registration number CGO 4624 AE19 and CGO 5594E19.

Another one is Complex Safari Ltd with registration number T 402 CRY, Kasire Luxury with registration number 443 DFJ owned by Kasire Trans Ltd and Frester Investment, registration number T 647 AWD.

He pointed out a decrease of offenses from trucks, listing 84 trucks with no road license since that inspection started, but the number of trucks with road offenses decreased.

"As an operation was being conducted trucks' offenses minimized compared o the earlier period. Besides, more drivers show cooperation once arrested rather aggressive behavior as some did on day one," he remarked.

Regional Traffic Officer (RTO), Senior Superintendent of Police (SSP)Deleli Stephen declared intention to seize driving license of any driver found with the same mistakes.

He said the police force in Morogoro conduct capacity building to bus drivers and motorcycle riders, making a point of taking immediate measures on those who ignore those seminars.

"The RTO's office now cross-checks drivers' licenses and once one found with same repeated mistakes it proceeds to seize their licenses. This will be taken as a lesson to others as the target is to end or minimize road crashes," he elaborated.

MEAT and milk processors have commended the government for controlling importation of dairy products saying the move protects local investors and ensures market for locally made goods.

They said reduced imports of dairy products will also boost livestock keepers as they will be selling their cattle to the factories.

They made the remarks when speaking shortly after the Livestock and Fisheries Minister, Luhaga Mpina visited construction of a new meat processing factory–Eliya Foods Over Seas Limited at Longido and milk processing factory-Kilimanjaro Fresh located in Arusha city.

Director, Eliya Foods Over Seas Limited, Shabbir Virjee said they resolved to establish the factories after being impressed with measures the government is taking to protect local manufacturers in various sectors including dairy.

Acoording to Virjee, the factory will thus affecting their expansion plans. have the capacity to laughter 500 cows and 2,000 goats per day. He said they are expected to offer 200 direct and indirect employments to Tanzanians as well as buying cattle from livestock keepers in Longido and other places across the country.

"We commend the government for controlling importation of dairy products. We are sure of the markets for our dairy products", he said.

General Manager, Galaxy Food & Beverage Ltd which produces Kilimanjaro Fresh branded milk, Irfhan Virjee thanked the government for imposing new charges on imported milk, the thing that creates fair playing

hardly competing with imported milk and investment environment", said investors and their resources.

He said they are constructing the factory because they are sure of the market.

He noted that they are currently processing 5,000 liters of milk per day but the factory has a capacity to process 75,000 liters of milk every day. The factory gets raw milk from dairy farmers in Longido, he added.

Livestock and Fisheries Minister, Luhaga Mpina assured meat and milk processors of a readymade market across the country since the government are determined to protect local manufacturers.

"The initiatives we are taking are not meant to harass anyone, but to protect local manufacturers as He said local milk processors were well as create friendly business

Mpina said the ministry is taking various initiatives to improve cattle genetics to ensure quality breeds that will be sold to the industry.

Tanzania has a total of 30.5 cows, 18.8 goats and 5.3 sheep. It is the second country in Africa with the largest number of cattle. At least 1.4 percent of all the cattle in the globe are in Tanzania.

Registrar of the Tanzania Meat Board (TMB), Imani Sichwalwe said they will continue attracting investors in the meat processing sub-sector as well as search for international markets such as China and Europe.

Longido District Commissioner, Frank Mwaisumbe said the government in Longido will continue to protect

For six years the government has not conducted a species census at Mtera dam, thus failing to notice a problem preoccupying the area's inhabitants, he said, noting that the residents are key economic stakeholders as they pay income tax to the

If the hippos are not going to be harvested to reduce their number it will affect lives and revenue collection, he emphasized.

Special Seats Councillor for Isimani division, Yuster Kinyaga (CCM) said that hippos have been attacking fishermen.

So the government needs to come to their help and harvest massive mammals which have killed seven people in the past month, she said.

Other wild animals causing havoc in Migoli Ward include elephants from the Ruaha National Park, invading the villages in big groups. "There are too many of them around Mtera dam," the councillor underlined.

She reminded the district authorities that President Dr John Magufuli directed the authorities to assure those hippos are harvested to reduce deaths of fishermen working in the dam.

"When he came to Iringa I told the president about the hippos and he ordered authorities to deal with the issue. But since the president left so far seven people have been killed, because the authorities have done nothing on the president's directive," the councillor noted.

Authorities need to ensure they harvest hippos to reduce the deaths of fishermen

that cause many women to become widows. "Those who work for fishing are men who are usually married, so these dangerous

mammals cause families to disrupt and women to live as widows," she further noted. Ilolo Mpya councillor Fundi Mihayo said that elephants have done damage to the ward population as a large group of

elephants routinely damage crops of nearby residents. "This year the large group of elephants we do not know where they are coming from

but they destroyed crops...," said Mihayo Elephants also make it hard for pupils to go to school for fear of meeting the huge

beasts lurking in the vicinity, he said. Footpaths that are used by pupils are frequented by elephants as well, he pointed

Since the sdtart of the year elephants have damaged crops in Ilolo Mpya, Nzihi and Kiwere wards, the councillor said,

elaborating that people need to know that

elephants are found around the area. Responding to the complaints the District Land and Natural Resources Officer for Iringa, Evidence Machenje said the department was working on the matter, while advising residents to take precautions

as regards the dangerous animals. "We are indeed aware of the impact of the hippos but the council does not have the authority to harvest those animals. So we must contact the relevant authorities to come and harvest them," he said.

In addition, Machenje reminded the meeting that despite the damage that elephants and hippos have caused, everything has to be done in accordance with laws and regulations of the country, so people have to be patient.

Iringa District Council chairperson Stephen Mhapa directed the District Executive Director, Robert Masunya to ensure that those animals don't cause problems, to save the lives of the surrounding

## Police holding 2 people for allegedly killing child Rose

POLICE in Mbeya Region are holding two people for allegedly killing a sixyear-old Rose Japhet in an event linked to superstitious beliefs.

Regional Police Mbeya Commander, Ulrich Matei told reporters here that those who were arrested include Andrew Mwambuluma, a resident of Mbalizi on the outskirts of Mbeya city and Iaphet Nguku (37) the father of the deceased, who is a resident of Msewe village in Mbarali District.

He said that the suspects allegedly killed the child on May 3, this year and went away with her body parts, so that they can 'get rich.'

RPC Matei said that after that the remains of the baby girl were found at

was found decapitated and with the right foot amputated. And the foot was found buried nearby."

The regional police chief said: "The motive of this murder was monetary. The father of the deceased took his daughter to a businessman for five million shillings for her to be killed and her right foot amputated."

The businessman, who was also arrested, was meant to "give the foot to a healer so that he would make a product which would make him (the father) prosperous," Matei said.

The businessman admitted his involvement and police are still hunting for the healer.

The incident happens barely three months, when ten children aged between three and six years

> Reports have it that the killers were also chopping off the children's reproductive and respiratory organs in the killings that are linked to superstitious beliefs.

Njombe Regional Commissioner, Christopher Ole Sendeka, had ordered the immediate arrest of all witchdoctors who are linked to the brutal deaths of innocent children.

The United Nations condemned the killings at the time.

Such killings are not unusual in Tanzania, where albinos are often kidnapped and their body parts hacked off for use as charms and magical potions in the belief that they bring wealth and good luck.

#### Violators of plastic bags ban to face 20m/- fine

AS the nation races towards the June 1 plastic bags ban deadline, the National Environment Management Council (NEMC) announced in Dar es Salaam yesterday that during the interim period district officials will demarcate dumping zones and it further warned that violators of the ban risk a fine of up to 20m/-.

In an interview in the city, the NEMC director general, Dr Samuel Gwamaka, said districts will allocate damping zones of plastic bags and the public will be well informed on the move.

He explained that regulations made under the Environment Act of 2004, award a 20m/- fine to a convicted importer and exporter of banned bags; production, storage and distribution of the bags will attract a 10m/- fine and selling of the bags will earn the seller a 10,000/- fine and person caught using the bags will be fined 30,000/-.

The DG said the public should not worry about alternative carrier bags because, he said, production of alternative bags was progressing well. "At the moment we have 25 local industries producing paper bags and other industries producing other types of alternative bags. Production of such bags is expected to increase in the very near future," he assured.

He clarified that the ban excludes plastic wrap ups of medicines, wrap ups of edibles such as milk or cashew nuts or wrap ups of industrial, farm and construction products. But, he emphasized, all such wrap ups must meet quality standards of the Tanzania Bureau of Standards (TBS).

He said prospective investors should contact the Tanzania Investment Centre, NEMC, TBS, the Small Scale Industries Organisation (SIDO), and financial institutions.

He also said a national task force has been formed working under the Vice-President's Office.

### Tour guides appeal for insurance cover

THOUSANDS of tour guides in the country have no insurance cover despite working in risky environments, their umbrella body has said, calling for intervention from stakeholders.

Speaking during the Tanzania Tour Guides Association (TTGA) annual general meeting at the weekend, the TTGA Chairperson, Halifa Msangi revealed here that the number of Tour, Safari and Mountain Guides in the country has reached 6000 so far, but only 730 of them have been enrolled into the National Health Insurance Scheme, leaving 5270 others without the crucial cover.

According to Msangi even when it comes to the affiliation of the Tanzania Tour Guides Association, most Safari Guides continue to stay out of the enrolment because the association has just 1360 members. "Through TTGA we have started special arrangements to provide members with NHIF cards under joint scheme but it seems many will still be left out," of them have been enrolled in industry oriented association, thus missing out on plenty of associated benefits.


It was explained during the meeting that the reason why most Tour and Safari Guides in the country have been operating without the National Health Insurance Fund (NHIF) cover or any of the related schemes was because majority of these people happen to be freelancers, working outside formal employment arrangements.

The TTGA Board Chairman Ally Ramadhan said at the moment the association members are covered under 'flying doctor services,' as per recently hatched contract which is an important step on that many guides work far away in the field or remote places thus needing rescue. Safari Guides take tourists to visit National Parks, Game reserves and other attractions in the country, being exposed to various risky situations such as road accidents, beasts' attacks, sudden sickness occurrences and natural disasters but it seems a few of them find health insurance to be important thing.

Hosiana Siao is a lady tour and driver guide in-charge of disciplinary department at the Tanzania Tour Guides Association (TTGA); "The position I have endowed with is simply meant to encourage other ladies to join the male dominated industry," she said.

According to Siao, Staying far away from families and working in remote and dangerous plains are factors that make most women to stay far away from the tour and safari guide profession.

# Dodoma targets to register 50,000 people for the improved community health fund

DODOMA region targets to register at least 50,000 people in the improved Community Health Fund (CHF) system by the end of this year, thanks to the support from the Health Promotion and Systems Strengthening Project (HPSS) in the region.

The main focus of health system strengthening is to improve the health financing system which includes strengthening of the public financial management, supporting Community Health Funds through re-organizing them into viable social health insurance schemes, and improving the flows of funding from the National Health Insurance Fund (NHIF) to the health services in Dodoma region.

HPSS is a project funded by the Swiss Agency for Development and Cooperation (SDC) in collaboration with the government of Tanzania and it has been implemented by Swiss Tropical and Public Health Institute in Dodoma, Morogoro and Shinyanga.

Speaking here recently after receiving equipment worth 19 million from the HPSS, the Regional CHF Coordinator, Francis Lutulala said the support will help upscale improved CHF coverage.

He noted that since the improved system was launched in November, 2018, some 13,730 households have been registered by early this month.

Lutulala thanked HPSS for the support that included ICT equipment and office furniture, saying it will help accelerate coverage of households in the improved CHF programme.

"Our target is to register at least 50,000 households into the prgramme by the end of this year and the materials we receive today will help realize that goal" he said.

The coordinator noted that health facilities have received substantial amount of money through improved system, being Sh 10 million in January, Sh 12 million in February, Sh 19 in March and about Sh 25 million yet to be paid for April this year.

Speaking while officiating the event Dodoma Regional Administrative Secretary(RAS), Maduka Kessy also thanked HPSS for the and sponsorship, saying it will help regional CHF office to work more efficiently.

He urged those involved in using the equipment to ensure they are used accordingly and take good care of them, noting that without such ICT equipment, the regional office will find work very difficult.

"We thank HPSS for the support that will increase our performance but I urge the responsible officers to take good care of the equipment aimed at improving services" he said.

According to Kilanga, Moduli district Medical Officer at Mto wa Mbu health has been frequently attacked with

anthrax outbreak since most of the residents are livestock keepers. He said the outbreak of the disease have been causing several deaths of animals and human beings.

Training coordinator, Joyce Shanghai said the organization has been conducting to training to various groups such as health practitioners, doctors, laboratory technicians and security guards.

In February this year, anthrax killed two people in Kilimanjaro region.

In January, the disease killed four people in south-western Tanzania's district of Momba, Songwe Region.

In September 2017, an outbreak of the disease killed at least 42 hippos in Ruaha National Park.

changed Chinese people's way of life, but they have also gained great commercial success by contributing to China's development. "As Maotai, we choose Africa for both the

beautiful past between China and Africa and the bright future lies ahead," he said. On the Maotai liquor, he said as China's most

influential brand comes top in various international lists such as WPP and Kantar Millward Brown, Forbes and Financial Times.

"Just like in China, people here love good liquor or wine because they bring happiness.

We also hope that the arrival of Moutai would bring more joy and happiness to the people in Tanzania," he said.

In 2018, the revenue of Maotai Group hit 12.6 billion US dollars, net profit reached 5.8 billion US dollars and tax revenue 5.6 billion US dollars. The total assets exceeded 30 billion US dollars.

THE Kilimanjaro-based Kilimahewa Women's and Orphan's Centre for Education (Kiwoce) is determined to empower youth with better skills that will make them realize their dreams.

Lyimo said that despite of the successes recorded in the country's education sector, there are still some women to meet and learn various challenges that thwart youth from poor families to get formal education.

"My dream is to ensure that all those who can't read and write realize their dreams, by empowering them and individual attention, the Center with practical skills," she said, citing:

#### We can end shame: Fistula is curable

Nations Population Fund (UNFPA) as many as 3,000 Tanzanian women develop obstetric fistula each year, a condition that leaves them incontinent, leaking urine or faeces uncontrollably. As a result, they are often excluded from their families and communities. Obstetric fistula is a childbirth injury caused by prolonged, obstructed labour. It occurs when pressure from the baby's head compresses the mother's soft tissue in the birth canal, which obstructs blood flow. Without blood, the tissues die and a hole forms between the bladder and the vagina or the rectum and the vagina.

Community Comprehensive Based Rehabilitation in Tanzania (CCBRT) is a Tanzanian health care organisation which works to prevent disability, provide affordable medical and rehabilitative services, and aid empowerment of people with disabilities and their families. It also seeks to prevent disability through early identification by strengthening the maternal and newborn health system throughout Dar es Salaam.

To help remove barriers to treatment, CCBRT covers the cost of all obstetric fistula patients' treatment, accommodation, and meals throughout their course of care. CCBRT also supports six partner hospitals in Tanzania to provide treatment, making fistula care more accessible for all Tanzanian women. CCBRT and its partner facilities performed more than 1,012 fistula surgeries.

In the same vein, the government has said plans are underway to ensure specialised clinical services aimed at curbing the increasing number of deaths caused by the pregnancyrelated obstetric fistula disease are available right across the country.

The comprehensive emergency

CCORDING to the United will be installed in all public health centres. The services will target pregnant women experiencing fatal complications, including severe bleeding, infection, prolonged or obstructed labour, and eclampsia, as well as newborns with asphyxia.

They will be provided with safe blood transfusions, provision of oxytocin and antibiotics, caesarean section surgery, manual removals of the placenta, assisted vaginal delivery, controlled abortions, and resuscitation of newborns.

Although official figures show that roughly 3,000 women suffer from obstetric fistula in the country each year, the number is much lower than the real situation on the ground where most cases go unreported for fear of stigmatisation for patients. Only 113 of the country's 484 public health centres are providing the treatment services in a comprehensive manner so far.

The target is to ensure the remaining centres also do the same, he said.

The government first launched its National Fistula Programme in 2005.

At least 400,000 expectant mothers die every year in the country due to complications arising from being unable to afford the necessary delivery kits.. We are told that the government will distribute baby delivery packs to 500,000 women in the country. This is a commendable move to bail out the victims.

The national health policy of 2007 is aimed at improving the health status of all people in the country, including the elderly and expectant mothers.

Indeed, such services are the only proven approach to saving the lives of women who die while pregnant, giving birth, or right after birth. Available data shows that hundreds of thousands of women die each vear worldwide due to fistula, a disease caused by a hole in the birth canal leading to delayed or obstetric and newborn care services obstructed labour.

Y mission to Venezuela in November/December 2017 was the first by **L**a UN rapporteur in 21 years. It was intended to open the door to the visit of other rapporteurs and to explore ways how to help the Venezuelan people overcome the protracted economic and institutional

In preparation of the mission I studied all pertinent reports by the Inter-American Commission on Human Rights, UN High Commissioner, Amnesty International, Human Rights Watch, Provea, Fundalatin, Grupo Sures, Red Nacional de Derechos Humanos, etc.

During the mission, thanks to the professionalism of UNDP, I was able to meet with members of the opposition, National Assembly, chamber of churches, professors, students, representatives of OAS, Carter Center, victims of violence, and civil society. Since my mother tongue is Spanish, it was easy to inter-relate with Venezuelans, walk the streets, visit the supermarkets. I learned about the scarcity of foods and medicines, black markets, smuggling of subsidized petrol, foods and medicines into neighbouring countries. The situation did not reach and still does not reach the threshold of a "humanitarian crisis" as we know from Gaza, Yemen, Syria, Sudan, Haiti, etc.

A major obstacle to solving the problems was the polarization of the population and the dearth of confidence-building measures. recognized that the government needed advisory services and technical assistance from UN agencies in order to carry out needed economic and institutional reforms.

I convened a meeting with UN agencies in order to explore concrete

strategies. In a 6-page confidential early, and the CIA cooperated with coup. We observe a Machiavellian, memorandum to the government and in my report to the UN Human Rights Council I formulated constructive recommendations, some of which were quickly put into effect. I had requested the release of 23 detainees, 80 were released on 23 December 2017, more in the course of 2018. UN agencies noticeably intensified their assistance, in particular FAO and UNIDO, especially to manage the impacts of the sanctions.

Following my visit I continued follow developments documentation, and arguments from all sides. My diagnosis: The crisis is not caused by the ideological "failure of socialism as an economic model" (socialism has not failed in Norway, Sweden, China), but by concrete and palpable causes, the dramatic fall in the price of crude oil, the over-dependence on exports, the failure to diversify the economy, an excess of ideologues and relative scarcity of technocrats in government.

Most importantly, the crisis is the result of the cumulative impacts of 20 vears of internal and external economic war, financial blockade, and sanctions. The mainstream narrative attributes the crisis to incompetence and corruption, but these also plague most Latin American countries. Besides, the level of corruption in Venezuela in the 1980's and 1990's was higher and Chavez won the 1998 elections on a wave of disgust at the corruption of the neo-liberal governments. I spent two hours with the current Attorney General in Caracas, from whom I received ample documentation on the government's vigorous anti-corruption campaign, investigations and on-going prosecutions.

the Venezuelan oligarchy in the failed coup against Chavez on 11/12 April 2002. The 48-hour President Pedro Carmona had promptly issued a decree doing away with 49 pieces of social legislation, suspending the Supreme Court, the Chavez National Assembly, dismissing governors, etc. Although there is nothing more undemocratic than a coup - Carmona and the US media spoke of "restoring democracy" in Venezuela.

Back in 1970, when Allende was democratically elected President of Chile, Nixon called in Kissinger and told him that the US would not tolerate an alternative socio-economic system in Latin America and that the US would make the Chilean economy "scream". When in spite of sanctions the Allende government proved resilient, it was necessary to use more muscle and General Pinochet carried out the coup that ushered 17 years of "democracy" - and torture - in Chile. As we know from the studies of Stephen Kinzer and William Blum, US Military and CIA interventions in Cuba, Haiti, Dominican Republic, Grenada, Panama, Nicaragua, Paraguay etc. have cost tens of thousands of lives and brought untold misery to millions of Latin Americans.

"Human Rights" has nothing to do with the US Venezuela policy. As it was in Iraq 2003 and Libya 2011, it is OIL. The US covets the largest oil reserves in the world, as well as the third largest reserves in gold and coltan. If Maduro is toppled, it will be a bonanza for US investors and transnational

What is sad is that some countries ostensibly committed to democracy, the rule of law and human rights, are US efforts to topple Chavez started supporting the sanctions and the Guaidó

cynical instrumentalization of human rights and humanitarian aid for purely geopolitical reasons.

A solution of the crisis depends on direct dialogue between the opposition and the government. Such dialogue already took place in 2016-2018. Former Spanish Prime Minister Jose Luis Rodriguez Zapatero hosted these talks and arrived at a reasonable accord. On the day of signature, 6 February 2018, Julio Borges, the leader of the opposition refused to sign. This augurs badly for any kind of international mediation by the UN Secretary General Antonio Guterres, by the High Commissioner for Human Rights Michelle Bachelet or by Mexico and Uruguay in the context of the Montevideo mechanism.

History shows us that sanctions kill, and when the level of killing reaches a certain threshold, sanctions become a crime against humanity. This is a worthy challenge for the International Criminal Court. What Venezuela needs is an end to sanctions and interference in is internal affairs, an end to the violations of Articles 1-2 of the UN Charter and of articles 3, 19 and 20 of the OAS Charter by the US and its "coalition". Venezuela needs international solidarity and respect of its sovereignty.

## We ought to see value of having medical health insurance

EALTH care in Tanzania available depending one's income and accessibility. People in urban areas have better access to private and public medical facilities. Insurance has only in recent years been introduced where as pension schemes have been around longer but the limitations of either are vast and not attending to the needs of majority of Tanzanians.

Health care financing is among the key component of a functional health system. Financing involves three aspects, namely revenue collection, risk pooling, and purchasing. In recent years, there has been a growing demand for access to high-quality and affordable care for all, thus the government is committed to respond with a process of developing health financing strategy was underway since early 2013. An inter-ministerial steering committee has been developed, composed of key ministries and department to ensure that the proposed reforms meet the needs of the population. Improving the prepayment mechanisms are the main agenda in the development of the strategy, which is assumed to be a potential facilitator in the progress towards UHC.

The Arusha Declaration in 1967 initiated by the founding father of the nation Mwalimu Julius Nyerere, outlined the principles of Ujamaa (Nyerere vision of social and economic policies) to develop the national

It marked the start of a series of health sector reforms with the intention of increasing universal access to social services to the poor and those living in marginalized rural areas.

However, by the early 1990s, the strain of providing free health care for all became evident in the face of

rising health care costs and a struggling economy. Early 1990s the government adopted health sector reforms that changed the financing system from free services to mixed financing mechanisms including cost sharing

In the same vein, a Local health organisation-Nordic Foundation Tanzania (NOFOTA) recently launched a three-month special campaign on medical insurance for all titled "Afyabando" which is designed to encourage ordinary citizens to have medical insurance for their wellbeing.

According to the lead consultant of special campaign on medical insurance the initiative is aimed at reaching the underserved communities in urban and rural areas such the elderly, children and women.

Indeed health insurance coverage in Tanzania is still very low and as of June 2013 National Health Insurance Fund (NHIF) had covered about 6.6 per cent of the population while Community Health Fund (CHF) covers about 7.3 per cent of the population based on 2012 Census. Beneficiaries of NHIF include the contributing members, spouse and up to four dependants.

It is our hope that the campaign should to scale up the health insurance coverage in Tanzania to at least 75 per cent of the country's population.

This shows that the majority of Tanzanians lack completely medical insurance and some end up dying of preventable deaths.

We are also told that the fund, which will be obtained from the lottery will partly be used to purchase medical equipment and hospital consumables for few selected health centres, namely the Community Centre for Preventive Medicine (CCP) in Kinyerezi and a new medical facility called Tanzania Nordic Medical Centre in Kinyerezi.

Well, Tanzania is battling the drugs blight, but another equalling damaging addiction has yet to be fully quantified.

It is some time now, since the British government allowed betting and gambling on the nations high street, but this took off in such a big way, that the character of many town centres are now altered, and not for the better, with the domination of the betting establishments outnumbering the small shopping outlets, and angering the public.

This seems like revenue raising at any cost, as do the taxes gained from this business, really justify the damage it can cause for those who increasingly frequent them, and become hooked.

...and just as the constant access to alcohol, keeps the well known Alcoholics Anonymous organisation busy weaning addicts off their "booze", similar counselling bodies have started up to deal with the misery gambling can cause to those in search of quick riches, but who often get painful empty pocket poverty

Not surprisingly, alcoholics, drug addicts and gamblers have similar sad tales to recount, as all three addictions, can result in a loss of jobs, getting into debt with borrowing, and with gamblers especially, who play on till they've nothing left, the loss of their homes, and ultimately families also.

A local press article reported how gambling has become a huge and growing industry in the country, worth billions of shillings a year, but is resulting in concerns about youth becoming addicted to sports betting particularly.

## The gaming industry...should it be promoted...or restricted?



As in other parts of Africa, gambling and sports betting in Tanzania, has proved to be very popular, contributing billions of shillings to state coffers in tax revenue. But in the greater public interest, critics have said since gambling is highly addictive, the **Gaming Board of** Tanzania, should re-locate, or close down any betting centres operating in residential areas, and particularly near schools or universities. (File photo)

An M.P. last year warned the government that gambling is becoming a national crisis, and asked what was being done to curb its rapid growth.

Surprisingly, a complacent sounding Deputy Minister for Finance and Planning, responded by supporting the betting shops, saying they were licensed to operate by the Gaming Board of Tanzania. But unless she was misquoted, this was obviously no answer at all.

However, with 80% or more of the nations population aged 35 or below, there's certainly a fertile market for the gaming sector, or as the newspaper put it "these favourable demographics, have enticed dozens of international and local companies to open all manner of gambling businesses in the country, to tempt the youth, and middle class Tanzanians."

One young gambler speaking to the media, said "I've lost a lot of money, but will carry on betting, because I know that one day I'll win even more, just like my friend did". For sure, hope springs eternal in the human heart, and how fortunate for the betting industry that the customers convince themselves that they'll get lucky, and don't need to be persuaded by exacross the country, of which 178

pensive advertising.

Despite complaints that it could ruin many lives, two yearts ago, sports betting was said to be contributing about 1.6 billion shillings each month to government tax coffers, and presumably this has since greatly increased.


Acting Director General of the Gaming Board of Tanzania James Mbalwe, said at the time, that previously 80% of total gaming revenue came from casinos, but this had been overtaken by sports betting, and that there were 231 shops

were in Dar es Salaam, making it the gaming capital of the country, and he urged operators to open up more centres in rural areas.

Well, what a thought...let's add possible debt, worry and mental misery to the already anxious lives of the ragged rural peasants in the hinterland. But does Mr. Mbalwe really not know that betting can be as addictive and harmful as drugs, and cause as much devastation to those trapped by it.

...and that figure of 178 betting shops in Dar es Salaam, which has no doubt increased by now, is it really to be applauded... how much better if they had been rural libraries, or something beneficial, instead of possibly damaging.

To me, the gambling industry, is about as appropriate or meaningful for this nation as shopping malls on mount Kilimanjaro, or state run brothels. But more mentally unsettling, is the knowledge that if anything can be mislabelled as 'progress' and result in large tax revenue rewards, ...it can be officially sanctioned...so who knows what's possibly to come in future ...should we bet on it?!

## After ousting Bashir, Sudan's activists struggle to loosen the military's grip

**DUBAI** 

FTER spearheading the rallies that toppled former Omar President al-Bashir, Sudan's main protest group is now locked in a stand-off with the country's new military rulers that is testing its clout as a political force.

The Sudanese Professionals Association (SPA) gained widespread support during more than four months of protests and it has helped win a string of apparent concessions from the military council that took over from Bashir on April 11.

But as the unionists and activists in the SPA try to chart a course to full-fledged democracy, they are coming up against a powerful rival that has shown little sign yet that it is willing to move aside for a civilian-led transition.

Frustrated by a lack of progress, the Declaration of Freedom and Change Forces (DFCF), a broad coalition of opposition groups headed by the SPA, called on Wednesday for a campaign of civil disobedience to crank up the pressure on the military.

"We have all options open from now on," Ahmed Rabie, an influential SPA member, told Reuters. "If (the council) insists on holding on to power, we are going to consider this a military coup, and we will escalate our tactics, peacefully."

The SPA has said such a campaign would likely focus on mass strikes, which have been successful in previous uprisings in post-independence Sudan. Strikes called by the SPA before Bashir's fall met with limited success, but workers may be less cowed following his removal.

It may also call for a boycott of non-essential goods and public services in a bid to starve the government of tax revenue, and intensify rallies and sit-ins across Sudan.

The biggest ongoing sit-in, which began on April 6 outside the Defence Ministry in Khartoum, has become the focal point of the uprising. The Transitional Military

Council (TMC) has said it will

not use force to end the sit-in. But the SPA could be undermined by manoeuvring due to its lack of political experi-"The politicking is starting.

#### This is a terrain that the professionals association might not be as well-equipped for as it seems," said Sudanese analyst Magdi el-Gizouli.

#### **Concessions**

To try to placate protesters the TMC replaced its first head after one day, dismissed senior allies of Bashir, announced anti-corruption measures and moved to restructure security and intelligence agencies.

Bashir, who is wanted by the International Criminal Court (ICC) for alleged war crimes in Darfur, is in prison in the capital Khartoum.

But while the DFCF wants a transitional body led by civilians to steer a four-year transition, the TMC has indicated that it wants to retain overall control of any joint military and civilian sovereign council.

after six months if there's no agreement on an interim government - well ahead of the end of the council's planned two-year The SPA's civil disobedience could put pressure on the military council given Sudan's economic vulnerability. The country is already suffering from spiralling inflation and shortages of cash and basic goods.

But its rivals in the TMC have powerful and wealthy backers.

The TMC's leaders, Lieutenant General Abdel Fattah al-Burhan and General Mohamed Hamdan Dagalo, have ties to Saudi Arabia and the United Arab Emirates, which together promised Sudan \$3 billion to support the central bank and provide fuel, wheat and medicine.

Dagalo, commonly known as Hemedti, controls the feared Rapid Support Forces, which fought in Darfur and are participating in the Saudiled coalition in Yemen. They are also deployed across Khartoum.

"This is an army establishment and they don't want to lose control," said Sudanese writer and commentator Reem Abbas. "There's a lot of things at stake: resources, land, immunity for war crimes."

#### **Shadow Unions**

The SPA, by contrast, was formed in 2016 from unofficial parallel trade unions outside the state apparatus representing doctors, lawyers, journalists and other

professions. It was campaigning for higher wages when demonstrations against Bashir, triggered by a deepening economic crisis, spread across Sudan from Dec. 19 and propelled the SPA into the role of protest coordinator. It has since expanded to include

more than 20 unions. The SPA's non-political image was key to its success in ousting Bashir after three decades in power, said Rabie, a high school physics teacher from the Haj Yousif neighbourhood on the outskirts of Khartoum.

Despite its large following, the SPA says it will not become a political party. It has no leader or strict hierarchy and, until recently, operated largely underground.

That could leave a vacuum. Under Bashir, opposition parties' activities were limited and membership dwindled. Analysts say they still have much work to do to become effective political forces. The opposition also faces a

ed front. The DFCF is made up of a wide range of political parties, civil society associations and armed groups from across Sudan and they have already made conflicting statements about their ap-

proach to the negotiations. Many protesters believe the SPA shouldn't be negotiating with the military at all, chanting: "Civilian rule is the decision of the people." The SPA has sought to reassure them, saying it will act as a guarantor of the revolution and democracy during the transition.

"We always work hard to get democracy in this country and then we lose it," said Rabie, who was jailed from Jan. 4 until shortly after Bashir's downfall. "We worked hard to get it, and, God willing, we can protect it."

## The unsafe abortion will continue to wreak havoc on women and girls

UNLESS societies change their attitude towards access to safe abortion, unsafe abortion will continue to wreak havoc on women and girls' precious lives, and continue to be one of the greatest human right and public health crisis in East African

These are some of the responses given by some of the reproductive health, human rights and public health experts in Dar es Salaam and Nairobi.

The Guardian sought for people's opinions following billboards posted across Nairobi County in Kenya along Oloitoktok Road, Ngong road, Dennis Pritt road, University Way and other roads, conveying anti abortion messages including 'Abortion is Murder' and 'Shut down abortion

Human rights, and public health experts unanimously say that the billboards are fuelling stigma and endangering women and girls lives, but apostle Kathy Kageni-Oganga from a Kenyan based Sozo Church of God which is behind the billboards claim that they are doing so, so as to save women with pregnancy crisis.

"The messages on the billboards fuel stigma and misinformation on abortion creating an environment that adversely affects reproductive health providers and women seeking these services. The messages also contradict provisions of the Constitution, which is the supreme law of the land and one we all have a duty to defend," Evelyne Opondo, Senior Regional Director for the Centre for Reproductive Rights is quoted as saying in press release issued by 14 Kenyan CSOs following the posting of the billboards

' It is not politically or morally acceptable for people to use arguments of culture and religion to deny women and girls their right to life, healthcare and health protection, or doing anything that will curtail women and girls access to the highest attainable standard of physical and mental health and hence render them to needless death resulting from unsafe abortion," said Dotto Mnyandi .

### Dar hotel to undergo major facelift to woo more tourists

IN a bid to complement government's efforts to boost the number of tourist to two million by 2020, a Dar es Salaambased Kunduchi Beach Hotel is set to undergo an extensive expansion and refurbishment program.

The idea is to make the facility to offer exceptional quality, efficiency, service and get five-star status.

Addressing journalists in Dar es Salaam over the weekend, Saimon Nguka, administrative officer of the Wellworth Group of companies, said that the facility will be closed down between six and ten months for the expansion of the project.

"Before closing down the facility we're supposed to inform the Tanzania Revenue Authority (TRA)," he said, adding that the renovation cost is estimated be between US\$9million and US\$11million.

The hotel was privatized in 1997 and was renovated and the numbers of rooms were added to 138 from 84 rooms, with the capacity of serving between 276 and

414 guests at once, according to Simon. "After refurbishing, the hotel will be handed over to one of the giant interna-

tional company, which are experienced in running hotel business," he said, without divulging the name of the international firm that will be given the hotel, which is being owned by Tanzanians by 100

"This will also provide a room for us to increase the number of local and foreign tourists and our staff will also give a platform for them to exchange views and skills on running international ho-

The official insisted that the hotel ownership and management won't be changed and the idea is that after five years, the facility will be a public entity and its shares will be sold to Tanzanians.

Currently, the hotel has employed 202 people, who are mostly Tanzanians.

Located on the coastline of the Indian Ocean, the facility was re-opened in 2005 by the former Vice President Dr Ali Mohamed Shein, who is the Zanzibar President.

Apart from Kunduchio Beach hotel, the company also runs Oldeani Ngorongoro Mountain Lodge, Oleserai Lodge (Serengeti), Zanzibar Beach and Kilimam-

OWADAYS almost every commentator on social and mainstream media outlets, especially on early morning radio and television talk shows, is an expert on security mat-

Even among road-side gatherings of friends, every contributor to discussions on the security situation in the country will speak in ways that shows he believes he knows how to manage it better than those in charge. This is a big fallacy.

The pervasive false assumptions on security management mechanics and the pseudo solutions mouthed or discussed loudly in the type of fora listed in the opening paragraphs of this item, cannot in any way help in resolving the problem that has made certain parts of the country danger-

Those discussions, uninformed as they might be, on such a sensitive matter, are an expression of opinions and the exercise of constitutional freedom of speech, which every citizen is entitled to.

The snag is that those discussions do not in any way recall and reflect on the security situation in Nigeria after the civil war to date. They concentrate on the current situation of kidnappings for ransom, abductions for human sacrifice by ritualists, banditry, highway robbery and cattle rustling. Farmer-herders conflicts and those between Jukuns and Kuteb and Tiv people, are also listed.

This item will only refresh our memories of the security challenges faced by the country from the restoration of democracy in 1999 to date.

Many Nigerians may recall that in the period served by Chief Olusegun Obasanjo between 1999 and 2008, for most of the eight years under his watch, the country recorded so much violent communal conflicts and killings across the country that some people thought that Nigeria was on the brink of going the way of failed nations. It did not go that way.

It is on record that kidnapping for ransom started in the Niger Delta in 2006. By the time Chief Obasanjo's second term in office was ending, more than 500 expatriates oil work- tracted from its territory. It was intro-

## Stateless people living in Kenya vow to reclaim shattered dreams

#### **NAIROBI**

HEN she was born 24 years ago in a farming village on the outskirts of the Kenyan capital Nairobi, Happiness Kapota, in her aptly comprehensible toddler innocence, knew that her home is the only domicile she could proudly identify with.

Her late paternal grandparents, Kephas Kapota and Gloria Nyati Kapota, entered Kenya from Zimbabwe during the colonial era and sought employment from the British settlers' lands in central Kenyan county of Kiambu as well as running errands for the Christian missionaries.

Kapota's grandparents died in the early 1950s, leaving behind children who were unidentified since they had not registered them as Kenyans.

Back then, the custom laws were lenient and would from time to time permit individuals to pass through the porous borders with negligence of armed guards.

In this state of affairs, the Kapotas were rendered stateless, and three generations down the line have no recognition of the Kapota names in the registrar of persons.

The Kapota lineage is among thousands of stateless people living in Kenya who live in fear and deprivation since they can't access basic services like education and healthcare.

"Being stateless means we lack recognition of nationality and that has got very devastating effect on respect for our rights as human beings," said Kapota who currently lives with maternal grandparents Dickson Ncube and Lagina Sibindi.

She narrated the harrowing story of how her mother died while giving birth through the help of a mid-wife.

"My mother died when I was 16 years old, she could not have gone to the hospital for lack of identity documents, so she gave birth in a nearby house with help of village midwives," Kapota recalled.

She reckoned that without a proof

that a person is a national of the country where they live - or of any other country - a person finds it very difficult to live in that society.

"Such a person is unable to work, to access healthcare and education, to hold secure rights to land and other property, or to enforce any of these claims in court, and we go through that each day," said Kapota.

She said that stateless people live a life of great deprivation and hardship and remain marginalized economically, socially, politically and culturally.

Just like any other child, Kapota was bouncing on her mother's hands until the day she got old enough to have the reality dawn on her that together with her four siblings they were treated as stateless persons.

"The moment my mother revealed to me that my siblings and I were stateless persons, I could not understand what that meant," said Kapota. She recalled that whenever she got into a tiff with the other young playmates in the village, she was in trouble.

"I was made to understand that as a stateless person, that meant that I was not supposed to for example talk freely, shout, play with other children and go outside our compound at will, whenever another child did injustice to me, it was not a big deal but when we were on the wrong, it was treated as a heinous crime," said Kapota.

However, Kapota's resolve to become a human rights defender could not allow her to keep quiet and suffer in silence, instead she would shout, but the more she shouted, the more trouble she attracted, at the end of the day her voices remained unheard; she was literally muzzled.

"All my other siblings lived in fear since we were told that if they talked openly, they would be chased away and so they had nothing to be proud of," said Kapota.

"As I grew up, I admired strongwilled women in Kenya and dreamt to join their league," said Kapota. At 24, she is now married and a mother of three but could not attain her dream



since the highest level of education she got was elementary, and being the first born, she had to drop out of school to work and fend for her younger siblings after the mother died.

"I was employed as a domestic worker for a Zimbabwean immigrant who worked for an NGO on a contract, then I would earn 6, 000 shillings (60 U.S. dollars) per month, money that went to buying food for the family, my father too worked for a prominent farmer in Kiambu and his proceeds would pay for our house rent," said Kapota.

Currently, she weaves multicolored baskets and jewelries from plastics which she sells to there are great talents among brokers at a throw away price. the stateless persons, they are She gets her raw materials from equally talented if not better,"

Nairobi's industrial area.

"With fear to be exposed, I usually sell the baskets to middlemen at one dollar but they make a kill by selling them at between nine dollars to 10 dollars making almost a hundred percent profit, "said Kapota" The baskets have however enabled me to put food on the table for my family", she added.

Lisa Wanja Munaita, United Nations High Commissioner for Refugees (UNHCR) assistant protection officer, said there is need to recognize the stateless individuals to enable them realize their potential.

"Given an opportunity,

said Munaita.

She said that stateless people are a discriminated lot while their efforts to seek employment or to join saving groups remained an exercise in futility.

"As a stateless person, one can't achieve the aspiration of living as true citizens enjoying all the rights and freedoms, citizenship is therefore a crucial element in enjoyment of the rights of individuals and communities and therefore all those that qualify for it should be granted," said Munaita.

Participants at a recent ministerial conference on the eradication of statelessness in the African Great Lakes region which took place in Nairobi urged governments to enhance protection

of this vulnerable group.

On its part, Kenya reaffirmed its commitment towards devising interventions to assist the stateless people. Such interventions include the oncoming national census which will help classify the stateless people as a special category, making it easier to identify their needs.

"The Kenya government has resolved to factor in number of stateless during the oncoming census as a step to take stock the persons so as to profile and register their security and social concerns," said Patrick Ole Ntutu, chief administrative secretary of Kenya's Ministry of Interior and Coordination of National Government.

## Kenyan MPs warn farmers: Release maize or it will be imported

**NAIROBI** 

The government will be forced to import maize if farmers continue to hoard their produce and demand high prices, the National Assembly Committee on Agriculture has warned.

Committee chairman Adan Ali said growers have refused to part with maize in the hope of making more money. "If farmers continue to hoard their produce with prospects of making more money, then importation of maize under the current situation is inevitable," Mr Ali told the Sunday Nation in an interview.

He said the local market is offering better prices than the government, thus farmers are avoiding the National Cereals and Produce Board (NCPB). But farmers have vowed to oppose any bid to import maize.

Producers under the Cereal Growers Association said importation of duty-free maize will jeopardise food security as well as increase the cost of farming. "Our government seems to show more preference to foreign farmers than its own. We still have maize in our stores which we would like it to buy instead of importing," said the association's chairman, Mr

The farmers also accused the government of hatching a plot to import maize from Mexico through some listed traders. But the Agriculture committee said the government, through the Strategic Food Reserve (SFR), has only managed to purchase 417, 000, 90kg bags of maize from farmers visà-vis a target of two million bags.

The two million bags target was

set by President Kenyatta in January when he ordered NCPB to buy maize from farmers at a cost of Sh2,500 per 90kg bag. Although long queues were witnessed at NCPB depots immediately the President made the announcement, they later diminished after the long rains failed.

According to Agriculture CS Mwangi Kiunjuri, they have tried to convince farmers to deliver maize to NCPB depots in vain. "I personally asked those with more than 400 bags to sell to NCPB but the situation at the depots has not improved," added Mr

The CS said NCPB failed to meet its target of buying two million bags owing to better prices offered by the market and the worsening drought in the country.

The CS also refuted claims that the government has already listed some traders to import maize from Mexico. However, the CS reiterated that he has a responsibility to ensure that Kenyans are protected from escalating flour prices, whether caused by hoarding or by maize shortage.

He stated further that the country is safe because there is little maize trickling in from Tanzania and Ethiopia. The chairman of the Strategic Food Reserve Fund, Mr Noah Wekesa, said they would only import when it is nec-

"We must make sure we don't repeat the same blunder we made last year. We will only import when the right time comes and also avoid interfering with this year's harvest," he told the Sunday Nation in a telephone

## US life sciences professor urges govt to have policy on agro-ecology

HE government has urged to come up with a policy that supports agro-ecological farming which is good for the environment and guarantees smallholder farmers of food security.

An associate Professor at Cornell University's College of Agriculture and Life Sciences in the US, Rachel Kerr said in Singida last week during the closing ceremony of Singida Nutrition and Agro-ecology Project (SNAP) that agro-ecological farming needs policy backing so that it can be implemented by farmers effectively.

Prof Kerr pointed out that agroecological farming is good for smallholder farmers because it improves soil fertility, conserve environment, protects water sources while encouraging use of indigenous

"Agro-ecological farming represents ecology farming and gender equality the future of farming especially for smallholder farmers who use tradition farming methods," Prof Kerr noted while commending SNAP managers for training Singida region's farmers on the

She advised the beneficiaries to practice what they learnt but also impart the knowledge acquired to their peers so that many of them should engage in agro-ecological farming which involves intercropping.

Under the SNAP, the smallholder farmers were trained by experts from ActionAid Tanzania, Cornell University, Nelson Mandela University and Ilonga Agricultural Research Institute with funding from US-based McKnight Foundation.

SNAP was a three year which started in 2016 in Singida region and involved 20 villages and more that 1,200 households with main goals being to promote agroamong farming communities but also assure farmers of food security.

"As researcher from Cornell university I am very glad to see what is you have accomplished in Singida because as smallholder farmers you have made big changes as far as food availability at home and healthy children are concerned," she added.

Speaking at the same ceremony, Singida District Executive Director, Rashid Mandoa expressed his appreciation to McKnight Foundation for the financial support accorded to SNAP which has benefited thousands in Singida.

"As the project comes to an end, we have vowed to disseminate this knowledge to other villages across the region so that many farmers should know about benefits of agro-ecological farming, nutrition and gender issues,"

He further noted that Singida district council has 84 villages, 21 wards and 334 sub locations but has only 16 extension officers which means that peer mentoring among themselves is important to propagate the environmental friendly farming practice. "We will disseminate this knowledge effectively to our farmers because 80 percent of Singida residents are farmers " he underlined.

Speaking on behalf of mentor farmers who benefitted from the project, Pili Shaban called upon district and regional authorities to allocate funds to assist farmers practice agro-ecological

"In order for us to disseminate and practice skills that we learnt from SNAP, we need funding,' Shaban said while paying tribute to the experts who taught them during the three year project tenure.

## Falling confidence hits African airlines' international business

**GENEVA** 

The upward trend in African airlines' international passenger travel demand has softened since mid-2018, in line with falling business confidence in some of the continent's key economies.

This is according to global passenger data for March 2019 released by the International Transport Association (IATA). The report shows that African airlines' demand for international passenger travel increased by 2.1% compared to March 2018. At the same time capacity increased by 1.1%, and the load factor strengthened by 0.7 of a percentage point to 71.4%.

IATA points out that more than 12.5 million passengers board flights globally each day. Global passenger traffic results for March 2019 showed that demand rose 3.1%, compared to March 2018. This was the slowest pace for any month in nine years. According to IATA, this was largely due to the timing of the Easter holiday period this

"While (global) traffic growth slowed considerably in March, we do not see the month as a bellwether for the rest of 2019," Alexandre de Juniac, IATA's director general and CEO, said in a statement.

"Nevertheless, the economic backdrop has become somewhat favourable, with the International Monetary Fund (IMF) having recently revised its gross domestic product (GDP) outlook downward for a fourth time in the past year."

March's slowdown, the outlook for air travel remains solid.

"Global connectivity has never been better. Consumers can choose from more than 21 000 city pair combinations on more than 125 000 daily flights. And air fares continue to decline in real terms," he said.

March international passenger demand rose just 2.5% compared to March 2018, which was down from 4.5% year-over-year growth recorded in February and almost 5 percentage points below its five-year average pace.

All regions showed growth with the exception of the Middle East. Total capacity climbed 4.0%, and the load factor fell 1.2 percentage points to 80.8%. European carriers saw March demand increase 4.7% over March 2018, down from 7.5% annual growth in February. The result partly reflects falling business confidence in the Eurozone and ongoing uncertainty about Brexit.

Globally domestic demand rose 4.1% in March, which was a deceleration from 6.2% growth recorded in February that was driven largely by developments in China and India. Domestic capacity climbed 4.5%, and load factor dipped 0.3 percentage point to 83.4%. # MultiChoice explains DStv streaming crash: Systems upgrade failed

**CAPE TOWN** 

MultiChoice says the latest hours-long crash of its DStv Now streaming service was the result of a systems upgrade that failed when it was made live.

Thursday's DStv Now blackout was the second in four weeks since many DStv subscribers in South Africa and across sub-Saharan Africa couldn't watch the 8th season premiere episode of HBO's Game of Thrones live on MultiChoice's video streaming service when it crashed on Monday 15 April after they stayed up and woke up wanting to watch it at

On Thursday night DStv subscribers who wanted to watch the first season finale of The Bachelor South Africa on M-Net (DStv 101) and soccer on SuperSport couldn't do so, getting a black screen saying "Error 500 - There is a problem with the page you requested."

It was eventually fixed later on Thursday night after several hours but after MultiChoice's nonservice outraged many M-Net and sports viewers who complained not just about the technical breakdown and bad customer experience but also the lack of DStv customer communication.

Richard Boorman, MultiChoice Connected Video head of communications responded to a media enquiry on Friday afternoon and told Channel24 that "we're currently busy with a full post-mortem to determine the exact cause, but broadly the cause was a systems update which we'd tested ahead of deployment without any issues arising, but unfortunately in the live environment it failed".

Asked if it was the same problem or connected to the DStv Now outage that messed up the Game of Thrones live viewing on 15 April he said that it "isn't related to the incident four weeks ago".

Wealthy foreign hunters are sent WhatsApp messages with detailed images of captive lions available for them to hunt in South Africa for prices of up to R780,000 each.

Up to 200 farms in South Africa breed lions for such "canned" highpriced trophy hunts, according to an investigation published on the front page of the UK's Mail on Sunday this week.

The investigation was funded by politician and philanthropist,

## Carlos Ghosn's successor under fire as Nissan profit sinks

arlos Ghosn's arrest threw Nissan Motor into a corporate tailspin with allegations of self-dealing, profligate spending and filing false statements. Now the car maker's profits are falling off a cliff, and successor Hiroto Saikawa may go down with them.

Troubled by slumping US sales, aging models and a product cycle that is out of sync, the Yokohama-based company will announce on Tuesday its lowest annual operating profit in a decade, raising the possibility of a dividend cut. The outlook for the current fiscal year to March 2020 probably will not be any more promising.

Chief executive Mr Saikawa has yet to announce a turnaround plan since the arrest of former chairman Mr Ghosn in November, and sources say there is internal strife over whether he is the

right executive to fix Nissan. duct." Alliance partner Renault may not look too favourably on Mr Saikawa's reappointment if he continues to oppose a merger said to be backed by its own chairman Jean-Dominique Senard, who is also a Nissan director.

In addition, alliance partner said it would block Mr Saikawa's reappointment if he did not agree to a merger - a request made by Renault's new chairman that Mr Saikawa batted away, the Yomiuri newspaper reported last month. "A new management team

Mr Saikawa's job security will come next month, when Nissan's directors are set to formally adopt new corporate governance rules that include creating a more independent board. In an extraordinary shareholders' meeting held last month to remove Mr Ghosn from the board, Mr Saikawa was peppered with questions as to why he was not stepping down to take responsibility for Nissan's poor govern-

That would mark the first time the Japanese car maker earned less than Renault in a decade. An out-of-sync product cycle, aging lineup and poor consumer reviews "will take years, not months to fix," Ms Lewis said.

## Turkish state banks sell dollars to support falling lira

Turkish state banks sold more than \$1 billion on Thursday and overnight, sources said. helping the lira to firm more than 2 per cent at one stage and stem declines triggered by a decision this week to re-run Istanbul's mayoral election.

Ziraat Bank, Turkey's largest lender by asset size, was one of the banks that sold dollars to support the lira, according to the sources familiar with the matter. Ziraat Bank was not immediately available for comment.

The lira has lost as much as 15 per cent against the dollar this year, with the latest weakness driven by investor concerns over Monday's decision to re-run a mayoral election in Istanbul that was narrowly won by the main opposition party.

Electoral authorities cancelled the result of the March 31 vote in Turkey's largest city and commercial hub after weeks of appeals from President Tayyip Erdogan's defeated AK Party.

On Thursday, Turkey's central bank effectively tightened policy by funding the market through a higher rate and took additional liquidity steps to bolster the lira.

"The steady trend of lira depreciation could potentially push inflation significantly

higher than expected even beyond 2019. The central bank move has had markedly limited positive impact on the currency this time around," Yatirim Finansman, the Instanbulbased brokerage house, said in a note to cli-

"If CBRT (Central Bank of the Republic of Turkey) wants to stop (lira) volatility effectively, it might have to introduce monetary tightening." Investors fear that the decision to repeat the Istanbul election on June 23 will add nearly two months of uncertainty over Turkey's plans to rebalance and stabilise the economy.

Turkish banks have also told foreign investors they were in no rush to sell problem loans on their books, and were focused on restructuring them, three people present at a meeting discussing bad debt on Thursday in Istanbul told Reuters.

Deutsche Bank, Cerberus, Goldman Sachs, Bain Capital and the European Bank for Reconstruction and Development attended the meeting to discuss the possible sale of problem loans, the attendees said.

Economists have expressed concerns about the transparency of non-performing loans held by Turkish banks, which surged after last year's lira crisis.

### Tata Steel's European plans thrown back into doubt as venture collapses

**NEW DELHI** 

The future of Tata Steel's two giant European plants has been thrown into doubt after a long-proposed venture with German rival Thyssenkrupp looked at risk of collapsing.

Tata, which operates the iconic blast furnace at Port Talbot in the UK and another big plant in the Netherlands, has been trying to find a solution for its European business since being hit by the 2016 commodity crisis, though many of its troubles stem before then. With a European joint venture now likely to be rejected, it will have to find a plan

Thyssenkrupp said on Friday that it's abandoning plans to split itself in two

and that it didn't expect regulators to approve the joint venture with Tata. The reaction from shareholders was telling: Thyssenkrupp surged the most on record while Tata slumped as much as 7.7 per cent in Mumbai. The Indian company said it will keep focusing on improving its European business, while looking for new options that can clear regulatory hurdles.

"The proposed joint venture was an important strategic initiative for Tata Steel to create a sustainable portfolio in Europe" that would have benefited its balance sheet, Tata said in a statement. "Tata Steel remains committed to the above strategy and would explore all options to achieve similar outcomes in the future.'

## **Democrat Warren** confronts 2020 electability question head-on in Ohio

**CHILLICOTHE, OHIO** 

AT a veterans hall in the mostly white, working-class town of Chillicothe, Ohio, U.S. Senator Elizabeth Warren spoke to about 200 people on Friday about her plans to fight the opioid epidemic, Washington corruption and economic inequality.

Warren's decision to campaign in Ohio - a state President Donald Trump won by eight percentage points in 2016 - so soon in the Democratic presidential nominating battle is telling.

Ohio does not host one of next year's early nominating contests. Yet there is growing consensus among Democrats that a nominee's ability to beat Trump in November 2020 is the number one priority - and Warren aims to convince voters there and elsewhere that she has broad enough appeal to do it.

"I believe that if you're running for president of the United States you ought to be running for president of all the people and not just spend your time in a handful of so-called battleground states," Warren told reporters at an earlier stop on Friday in Kermit, West Virginia, a solidly Republican

Party strategists and voters are divided over what type of candidate is best positioned to take on the president.

Some believe it is critical to have a nominee who can win back the working-class, white voters who supported Barack Obama but then handed Trump victories in formerly blue states in the

Midwest like Ohio, Michigan, Pennsylvania and Wisconsin. Others say a candidate who can drive turnout by appealing to young, minority and firsttime voters is the best path to the White House.

Ed Rendell, a former Democratic governor of Pennsylvania, thinks moderate candidates like former Vice President Joe Biden or U.S. Senator Amy Klobuchar would be best at wooing back working-class voters in the nonurban areas of his state.

Warren's progressive policies - she backs free college tuition, a wealth tax and Medicare-for-all healthcare - make her an "easy target" for Trump to accuse her of being a socialist, Rendell

But he agrees with other Democrats who say where candidates stand on the issues may not be the deciding factor for voters.

"I've never seen voters more singleminded than on the issue of beating Donald Trump," Rendell said, adding he would work to win Pennsylvania for whoever emerges as the nominee.

HIGH STAKES

Recent opinion surveys show electability topping issues for many Demo-

In a Monmouth University poll of 987 likely Democratic primary voters conducted May 2-7 in New Hampshire, which hosts the second nominating contest, 68 percent said they would choose a candidate they did not agree with on most issues if the individual

were a stronger candidate against Trump. Just 25 percent said they would pick the candidate they agreed with on most issues but who would have a hard time beating Trump.

Forty-nine percent of Democrats in an Ipsos online poll of 960 adults taken April 29-30 said the ability to beat Trump in the general election is the most important factor in choosing a primary candidate, ahead of policies on healthcare, jobs and the environment.

"Democrats view this not as a regular election but as an existential election for the country. The stakes are high. Each candidate is trying to show how they will take on Trump," said Ben LaBolt, a former spokesman for Obama's re-election cam-

Ideally, a candidate will emerge like Obama who can appeal to a wide swath of Democratic voters,

With just 3 percent of Democrats in the Ipsos poll picking Warren as the candidate most likely to beat Trump, the Massachusetts senator has work to do. Forty-six percent chose Biden as the strongest Trump opponent, and 25 percent said they did not know who was best positioned from the field of 22 Democrats running.

Ohio Democratic Party Chairman David Pepper rejected the idea that only a moderate Democrat can make inroads there. As a roadmap, he pointed to Senator Sherrod Brown's re-election in 2018. when he won by a higher margin than in 2012 when Obama was on the ballot.

Brown, like Warren, focuses on themes of income inequality and creating an economy that protects and benefits middle- and working-class households. Pepper said that economic message resonates in rural and suburban areas, even if other parts of a candidate's platform are more liberal than voters would typically support.

"These are the places that responded to Donald Trump saying 'let's make America great again," Pepper said of Chillicothe. "A ticket that includes that kind of candidate like Sherrod Brown's did and can hold down losses in rural parts of the state and suburbs and energize our urban core that combination is the ticket that will win Ohio."

In largely rural Ross County, where Warren met with voters on Friday, Trump got roughly twothirds of the vote in 2016.

But Chillicothe Mayor Luke Feeney, a Democrat, said the party should not count it out.

"I told her Ross County is definitely in play in 2020 and Chillicothe is definitely in play in 2020 and the state of Ohio is a swing state in 2020, not a red state," Feeney said as he introduced Warren at her event.

Retired teacher Kathleen Burgess, 70, was in the crowd. She said Warren's early call to impeach Trump pleased her as a progressive voter, but she thought Warren's economic policies also would appeal to swing voters in the state.

"By advocating for free public college and healthcare, those are kitchen table issues for working-class people," Burgess said. **Agencies** 

#### Serbia one of Russia's key partners, says senator

SERBIA is one of Russia's key partners in Europe and in the world, Chairman of the Russian Federation Council's (upper house of parliament) Foreign Affairs Committee Konstantin Kosachev stated on Saturday in an interview with Serbia's RTS channel.

"We have a great deal of common interests. We both have the same stance on the necessity of maintaining the UN's role and respecting international law. We have huge projects in the sphere of gas, nuclear energy, healthcare, education, agriculture. We are very interesting partners for each other. That is why Serbia is one of our key, most interesting partners in Europe and in a more global context," Kosachev said.

The Russian senator also noted the particular relevance of Victory Day in Serbia. On May 9, Kosachev took part in the Immortal Regiment demonstrations in Belgrade, attended by over 10,000 people.

The 'Immortal Regiment' march is an annual event held throughout Russia and in other countries. The event is dedicated to the victory in Great Patriotic War (or WWII) that claimed lives of about 28 million Soviet people, both soldiers and civilians.

During the march, people carry portraits of their relatives who fought or died during the war.

The idea was born in the Russian Siberian city of Tyumen in 2007 and the march was called the Victors' Parade. In 2012, another Siberian city of Tomsk picked up the torch renaming the rally as 'Immortal Regiment.'

The next year, about 120 cities joined in. A year later, people carried portraits of their relatives, who fought during WWII, in 500 cities in seven countries. Since 2015, the 'Immortal Regiment' march has become a nationwide

#### **Premier Li underlines tax** cuts to benefit enterprises, boost market vitality

**BEIJING** 

CHINESE Premier Li Kegiang on Friday called for more efforts to implement tax and fee cuts in a bid to let enterprises enjoy concrete benefits and further boost the vitality of market entities.

Li, a member of the Standing Committee of the Political Bureau of the Communist Party of China (CPC) Central Committee, made the remarks at a symposium on the implementation of reducing taxes and fees.

Larger-scale tax and fee reductions are a key measure to improve the business environment and boost the vitality of market entities, which not only contribute to steady economic growth and stable employment but also encourage enterprises to increase investment on innovation and enhance competitiveness, Li said.

As a key task for this year, tax and fee cuts have been carried out and are proceeding as expected, Li said, demanding more efforts to ensure the complete implementation of related poli-

At the meeting, several

entrepreneurs shared their opinions and made suggestions on tax and fee reductions.

The tax burden for the manufacturing sector should be lowered significantly and industries which create many jobs such as construction should also see tax reductions.

Li urged efforts to ensure the tax burden for all industries is lowered and micro and small enterprises should see a substantive reduction of their tax burden.

Measures, including stricter market supervision, will be taken to guarantee the effects of tax and fee cuts.

Besides tax and fee-reduction policies, China plans to unveil more measures to deepen reform and openingup, encourage entrepreneurship and innovation as well as foster fair competition to withstand economic hardship amid downward pressure, he said.

Vice Premier Han Zheng, also a member of the Standing Committee of the Political Bureau of the CPC Central Committee, attended the symposium.

#### ANC keeps power in South Africa but scandals cost it votes

SOUTH Africa's ruling African National Congress (ANC) on Saturday marked its weakest victory in national elections in a quartercentury, while President Cyril Ramaphosa declared that the vote had given him and others "a firm mandate to build a better South Africa for all."

With all votes counted, the ANC had 57.5 percent, the electoral commission said.

It was the worst-ever showing at the polls for the party of the late Nelson Mandela that has ruled since the end of the apartheid system of racial discrimination 25 years ago. The party won 62 percent of the vote in 2014.

Voter turnout was another low at 65 percent, reflecting the frustration of many South Africans after corruption scandals around the ANC that led former president Jacob Zuma to resign last year under party pressure. Turnout was 74 percent in 2014.

Ramaphosa, a Mandela protege, has vowed to clean up the rot and apologized to South Africans. But his new five-year term is threat-

ened by Zuma allies within the ANC's leadership, who could pressure the party to oust him from

Observers have said South Africa's economy, the most developed in sub-Saharan Africa, would be further weakened if Ramaphosa is removed by his own party. He narrowly won the party leadership in late 2017, weeks before Zuma was pushed out.

Ramaphosa's image as a leader willing to rid the government of graft helped the ANC's election showing, political analyst Karima Brown said. "It's a departure from a president who faced continuous allegations of corruption," she

But ANC secretary-general Ace Magashule, seen as leading the party faction opposed to Ramaphosa, has said the victory could not be attributed to the president alone.

Widespread disillusionment over the ANC and long-standing issues of high unemployment and poor delivery of basic services had been expected to give top opposition parties a boost in Wednesday's election. A record 48

parties were on the ballot.

Top opposition party the liberal Democratic Alliance slipped in its share of votes, however, winning 20.7 percent, down from 22.2 percent in 2014. The populist Economic Freedom Fighters (EFF) in just their second showing in parliamentary and presidential elections did gain ground, winning 10.7 percent of the vote, up from 6.3 percent five years ago.

The EFF won support notably

among younger voters with its outspoken demands for a bigger share of South Africa's wealth from the country's white minority. It struck a chord in a country where unemployment is 27 percent and many in the black majority struggle to get by. The party also had promised to expropriate white-owned land without compensation and nationalize mines and banks.

With an eye on the country's

## UN commences renovation works to modernise iconic Africa Hall

#### **ADDIS ABABA**

THE UN Economic Commission for Africa (ECA) has revealed the signing of contract agreement with three international companies to renovate the historic Africa Hall in Ethiopia's capital Addis Ababa.

The latest agreement among the UN-ECA and the three construction companies marks the commencement of renovation works of the Africa Hall inside the premises of the ECA headquarters in Addis Ababa at a cost of 28.2 million U.S. dollars, the ECA said in a statement issued on Saturday.

The overall Africa Hall Renovation and Modernization Project, which was approved by the United Nations General Assembly in 2015 with a budget of about 57 million, mainly envisioned a complete renovation of Africa Hall

main building. "The signing with contractors, Africa Hall Projects FZE, marks a paramount milestone of this iconic project," an ECA statement read. "The contract for the renovation and refurbishment of Africa Hall is the biggest ever signed by the ECA with a supplier."

Africa Hall, which was inaugurated prior to the establishment of the Organization of the African Unity (OAU) in 1963, is considered as a historic venue mainly for hosting the formation of the OAU - predecessor of the 55-member African bloc, African Union (AU).

According to ECA's Director of Administration Carlos Haddad, "the renovation will be completed on time and delivered in 2021 as budgeted for." "We are excited by the signing of the main renovation works contract which paves way to upgrade the safety standards and restore the state-of-the-art technology while preserving the historic and heritage values to Africa Hall.

We are confident," an ECA statement

quoted Haddad as saying. The iconic resentative for Africa Hall Projects hall was built between 1959 and 1961 and inaugurated on February 26, 1961 by Ethiopia's former Emperor Haileselassie, who is considered as one of the founding fathers of the African Union,

the former OAU. The complete renovation of Africa Hall main building embraces various works that include surrounding landscape works, a new Visitor Entry Building, upgrading the ECA compound perimeter's wall, a new visitor car park and road-works external to the ECA

compound, it was noted. Alem Kiros, Director and Legal RepFZE, said that the restoration work is a "great opportunity" that followed two and a half years of negotiations.

"The project will be delivered up to expectation and even beyond with the expertise of the contractors who have special skills with such levels of renovation," Kiros said.

The ECA had previously indicated that the renovation project, when completed, aims to transform Africa Hall into a rejuvenated facility, complying with the highest international stand-

ards for conference facilities. As part of preserving and restoring

the historical and cultural values embedded in its architecture, the project also include a permanent exhibition to turn historic hall into one of the leading tourist destinations in Addis Ababa and highlight its significant role in the UN and in modern African history, according to the ECA.

George Ogboro, Chief of Supply Chain Management Section at the ECA, said that the project "is a major milestone not only for the contractor but also for Africa as a whole. African countries will be proud of the hall even more when the modernization project is completed." Xinhua

## Top negotiator: China seeks equal, dignified trade deal

WHAT China wants is an equal and dignified trade agreement, for which there are some key disparities to close, but it must address the country's core concerns, such as lifting all additional tariffs, making trade procurement figures realistic and that the text to any deal must be "balanced".

Vice-Premier Liu He said this late on Friday, at the end of two days of trade talks in Washington. He said the two sides had agreed to continue talks in Beijing, an indication that the negotiations between the world's top two economies haven't yet broken down.

For the first time, Liu, chief of the Chinese side of the China-US comprehensive economic dialogue, revealed the extent of the "differences" remaining in the marathon China-US trade talks, though in the course the two sides have reached consensus on many things

He also refuted allegations that China "reneged" on its commitments and highlighted the need for the two countries to cooperate for the benefit of themselves and the whole world.

Before elaborating on the existing differences, Liu said China-US economic and trade relations, which have served as the ballast and propeller of the overall bilateral relationship, concern not only the well-being of the peoples of the two countries, but also world peace and prosperity.

The differences center first on the tariffs, which Liu said are the genesis of the trade dispute. "If both sides want to reach an agreement, then all (additional) tariffs must be eliminated," Liu told reporters before flying back to Beijing.

Liu was apparently referring to the additional tariffs being imposed on billions of dollars of Chinese goods over the past few months.

Hours after the Chinese delegation left town, US Trade Representative Robert Lighthizer announced Friday

evening that he was preparing to impose additional tariffs on the remaining approximate US\$300 billion worth of Chinese imports that haven't already been targeted.

Liu reiterated that raising tariffs harms China, the US and the whole world. "If the US increases tariffs, we must respond," he said.

"We surely hope the US side will adopt a restrained attitude, and the Chinese side will also do, so as to avoid an infinite upgrade."

The vice-premier said China is firmly opposed to the trade war, but the country is fully prepared to fight one. Still, for the interests of its own and US people, and the whole world, China will deal with the trade fight "with utmost rationality", he said.

Asked how the latest tariffs could affect the Chinese economy, Liu said that despite the pressure, he was optimistic about China's economy in the longer term, adding that the economy had entered an up-cycle after bottoming out somewhat in 2018.

He said he believed the Chinese economy would maintain the good momentum of stable and healthy growth, and the country has ample room for fiscal and monetary policy

China and the US now also have differing views on the volumes of trade purchases that China would make, though an initial consensus was reached between Chinese and US leaders in Argentina nearly half a year ago, Liu said.

"We think this is a serious issue that could not be easily changed," he add-

Chinese analysts have earlier said the trade procurement targets should be realistic and in line with real demand, and Chinese consumers would have options to buy from the US and also from other markets.

The third difference is over how balanced the text of the draft trade agreement should be. "We know that every

nation has its dignity, so the text ought to be balanced," Liu said.

Overall, the two sides are meeting each other halfway in the draft text, but there needs to be discussions on some key issues, Liu said.

"We believe that these things are major issues of principle. So every country has important principles, and we absolutely cannot make concessions on such issues of principle," the vice-premier said.

Liu, however, added that he hoped both sides would exhibit flexibility in

He refuted the criticism of the US side that China reneged on its promises in the draft trade text.

"We believe that it is only natural to

have changes before a final deal; it is something that surely occurs in the process, so we don't think the Chinese side has back-walked," he said, adding that he disagreed with the wording of "renege".

"We just had differing views on how to phrase some things in the text, and we hope to resolve it, so it's unnecessary to overreact to the issue," he said.

Liu said that at the level of trade representatives, both sides have the sincerity to solve the existing problems.

"The purpose decides everything," Liu said, in English. "China wants a very equal and dignified deal, and under this premise, a good, cooperative deal," he said. "I hope our US colleagues would understand this."

Liu said he believed both sides have a strong desire to reach a deal. "We need to work hard together to surpass the temporary difficult period of time, and then we'll have a bright future," he

Asked by China Daily how China and the US could help world economic growth, whose prospects have been already compromised by the escalation of trade tensions between the two countries, Liu said cooperation serves the interests of the two sides and the whole world, while conflict hurts both.

"We have tremendous common interests and many common foes, only through cooperation could we solve these problems," Liu said.

Russia-Japan Council of Governors to discuss humanitarian contacts, says Russian senator

**MOSCOW** 

THE issue of humanitarian cooperation will dominate the agenda of the Russian-Japanese Council of Governors which is expected to be held today in Moscow, Chairman of the Russian Federation Council's (upper house) Foreign Affairs Committee, Senator Konstantin Kosachev said in an interview published by the Parliamentary Newspaper on Saturday.

"The discussion will focus on expansion of humanitarian contacts, particularly youth, educational, scientific, cultural exchanges at the level of the two countries' regions. I am confident that each Russian constituent entity, same as each Japanese region, has something to offer and to ask for, that is a two-way road," he noted.

Kosachev added that the meeting would also dwell upon the subject of regions' authorities facilitating expansion of cooperation in the real sector of the economy. "We will separately discuss the prospects of cooperation in the field of small and medium-sized enterprises of the two countries.

Another relevant issue is the development of innovative economy, particularly digital technologies," the senator said. Over the past couple of years, economic cooperation between Moscow and Tokyo has been based on a cooperation plan offered by Shinzo Abe at a meeting with Russian President Vladimir Putin in Sochi on May 6, 2016.

The plan includes efforts to foster relations between Japan and Russia in the energy sector, small and mediumsized businesses, the promotion of industrialization of the Far East, expansion of the export base, as well as the proposal to strengthen cooperation in the cutting-edge technologies, including nuclear energy, and the sphere of humanitarian exchanges.

### Giving babies mothers' maiden names gains popularity in China

IN China, newborn babies raditionally take the surnames of their fathers. But in recent years, an increasing number of people are choosing to use the mother's maiden name.

Each time Ren Ran introduces his baby girl, he sees the surprise on people's faces. However, he has never regretted the decision to give his daughter her mother's surname instead of

"Before my wife gave birth a year ago, her water broke too early, and she had to receive oxytocin," Ren recalled. "She suffered for an entire day in the delivery room, and I could do nothing.'

So Ren decided to give their baby girl his wife's surname Ding as a way to show gratitude."Mothers are some of the greatest people in the world," Ren said. "They spend almost a whole year pregnant, and they suffer during labor." Ren Ran was born in the 1980s, after China began to adopt the family planning policy. Ren's mother knows all too well the pains and difficulties of bearing and raising a baby, so when she heard about Ren's decision, she was supportive.

"My mom has always been quite open-minded, and she believes names are just names," Ren said. "She said no matter what surname I chose for my girl, she would always love her



granddaughter."For thousands of years, giving a child the father's surname has been the status quo in many societies.

But as the values of gender equality permeate societies, it is more common in China to see diverse name choices for babies. China's marriage law also allows babies to bear the surnames of either the father or mother.

However, changing centuriesold traditions does not happen overnight. In China, where values from patriarchal systems in a traditionally male-dominated society still prevails, many parents give "compound surnames" to their babies.

A compound surname includes the surnames of both the father and the mother.Wang Ying, 33, has two children. Her husband is surnamed Xu.

And just like Ren Ran, Xu was born during the era of the one-child policy. When their first child was born, the couple decided to use a compound surname, as they wanted to satisfy Xu's father's wish to "pass on the family name."

The baby was eventually surnamed Xuwang.When China scrapped the one-child policy, the couple had a second child. The baby followed the surname of Wang."My father-in-law is open-minded, and he decided to give my surname to the baby," Wang recalled. "My father was

The baby was named Wang Yitong. Yitong, meaning togeth-

er in Chinese, bears the common wish of the two families to live amicably together forever, Wang said.

In March, police in Shanghai released a report about names

According to the report, of more than 90,000 newborns last year, 8.8 percent took their mother's surnames, and 2.5 percent bore compound surnames.

In Yinchuan, capital of northwest China's Ningxia Hui Autonomous Region, police officer Guo Yanmiao said that of the 439 newborn babies in his district in 2018, three had compound surnames, while nine took the mother's surname.

"When we handle baby registrations, it is not uncommon to see compound surnames these days," Guo said. "People are becoming more open-minded, and men and women are also becoming more equal."But the phenomenon has also courted some controversy.

On China's famous Q&A website Zhihu.com, supporters of babies taking their mothers' surnames say that the situation highlights gender equality, while many say traditional values should not be broken.

"My baby having my surname shows that women's roles in families are rising," Wang Ying said."Whether a baby takes the mother's surname or not should be a consensus among families," she added. "It should not be an issue of conflict." Xinhua

## **Guterres: Political will to fight** climate change seems fading

WELLINGTON, NEW ZEALAND

UN Secretary-General Antonio Guterres said yesterday that the political will to fight climate change seems to be fading at the same time as things are getting worse for those feeling the effects.

Guterres (pictured) made the comments after arriving in New Zealand, where he spoke to media alongside Prime Minister Jacinda Ardern in Auckland. Guterres plans to spend three days in New Zealand as part of a trip to the South Pacific to highlight the problems of climate change.

In Christchurch, he will also meet with Muslim leaders following the March 15 slaughter of 51 worshippers by a gunman who attacked two mosques during Friday prayers.

Guterres said he usually visits a Muslim country during the holy month of Ramadan but this year decided to visit Muslims in New Zealand as a tribute to their courage and resilience after the attack.

He said he admired the solidarity New Zealand showed after the attack, and praised Ardern for helping implement new gun control laws and for urging other world leaders and tech companies to find a way to prevent acts of extremism from being shown online, after

the gunman livestreamed his New Zealand mostly carbon attack on Facebook.

Ardern this week plans to travel to Paris, where she and French President Emmanuel Macron will host a meeting seeking to eliminate such acts from being shown online.

Guterres said countries were not living up to their commitments under the 2016 Paris Agreement to keep the global temperature rise to below 2 degrees Celsius above pre-indus-

"We are not on track to achieve the objectives defined in the Paris Agreement," Guterres said. "And the paradox is that as things are getting worse on the ground, political will seems to be fading.'

He commended Ardern on last week introducing an ambitious bill that aims to make

neutral by 2050 while giving some leeway to farmers. The bill is expected to come to a final vote in Parliament later this

Guterres said Pacific Island nations are on the front line of climate change.

"We cannot allow for runaway climate change," he said. "We need to protect the lives of our people and we need to protect our planet."

Guterres also plans to visit the island nations of Fiji, Tuvalu and Vanuatu. In Fiji, he will meet with leaders and senior government officials from the Pacific Islands Forum. His trip comes ahead of the Climate Action Summit that he plans to convene in September in New York.

SRI LANKAN authorities have arrested a Saudi-educated scholar for what they claim are links with Zahran Hashim, the suspected ringleader of the Easter Sunday bombings, throwing a spotlight on the rising influence of Salafi-Wahhabi Islam on the island's Muslims.

Mohamed Aliyar, 60, is the founder of the Centre for Islamic Guidance, which boasts a mosque, a religious school and a library in Zahran's hometown of Kattankudy, a Muslimdominated city on Sri Lanka's eastern shores.

"Information has been revealed that the suspect arrested had a close relationship with ... Zahran and had been operating financial transactions," reads a

police statement late on Friday. According to the statement, Alivar was "involved" with training in the southern town of Hambantota for the group of suicide bombers who attacked hotels and churches on Easter, killing over 250 people.

A police spokesman declined to provide details on the accusa-

Calls to Aliyar and his associates went unanswered. Reuters was unable to find contact details for a lawyer.

The government says Zahran, a radical Tamil-speaking preacher, was a leader of the group.

Two Muslim community

sources in Kattankudy told Reuters his hardline views were partly shaped by ultraconservative Salafi-Wahhabi texts that he picked up at the Centre for Islamic Guidance's library around 2-3 years ago.

The sources are not affiliated with the centre.

"I used to always run into him at the centre, reading Saudi journals and literature," said one of the sources.

During that time, Zahran started criticizing the practice of asking God for help, for instance, arguing that such pleas were an affront to pure Islam.

"That kind of teaching was not in Sri Lanka in 2016, unless you read it in Salafi literature," the source added, requesting anonymity to avoid repercussions in Kattankudy

Salafism, a puritanical interpretation of Islam that advocates a return to the values of the first three generations of Muslims and is closely linked to Wahhabism, has often been criticized as the ideology of

radical Islamists worldwide. Wahhabi Islam has its roots in Saudi Arabia and is backed by its rulers, although Crown Prince Mohammed bin Salman has committed the kingdom to a more moderate form of Islam.

Other than the fact that Zahran visited the centre, the sources in Kattankudy said they did not know of any personal ties between him and Aliyar.

Aliyar founded the centre in 1990, a year after he graduated from the Imam Muhammad ibn Saud Islamic University in Riyadh, in what one resident said marked a key moment in the spread of Salafi doctrine in Kattankudy.

The centre was partly funded by Saudi and Kuwaiti donors, according to a plaque outside.



Reuters spoke to three members of the centre's board before Aliyar's arrest. They asked to remain anonymous, citing security concerns amid a backlash against some Muslims.

They said Zahran was a troublemaker and that they had warned authorities about his extremist views.

The members said they thought Zahran frequented the library around a decade ago, but had no recollection of him visiting recently and denied that any of its books were to blame for his views. Agencies

## Warriors move to conference finals despite missing Durant

HOUSTON

The Golden State Warriors still have plenty of work to do if they hope to win their third straight championship.

But after fending off the Houston Rockets on Friday night without leading playoff scorer Kevin Durant to advance to the Western Conference finals, they did take a moment to celebrate the accomplishment.

"It shows you how much respect we have for Houston," coach Steve Kerr said. "We just finished the conference semifinals series. We're only halfway home to where we want to be. And yet the celebration in there felt like a much bigger occasion and that's because of the challenge that this team put before us."

Stephen Curry scored all of his 33 points in the second half to lead the Warriors to a 118-113 win.

Klay Thompson added 27 points to help twotime defending champion Golden State reach the conference finals for a franchise-record fifth straight year and eliminate Houston for the fourth time in five seasons. The Warriors did it with Durant sidelined by a calf injury sustained in the second half of their Game 5 victory.

"We're all very happy, but now we've got to get home and get some rest and prepare for the next round," Kerr said.

There won't be a lot of time to recuperate with the conference finals starting on Tuesday night in Oakland against the winner of the Denver-Portland series. Kerr said he'd give his team the weekend off after most of his key players logged heavy minutes in this series in which each game was decided by six points or fewer.

Though this team has had plenty of big victories as it won the NBA title in three of the last four seasons, Kerr and many of his players acknowledged that this win was pretty special.

"It's one of the most satisfying victories we've had during this run," Kerr said.

Draymond Green said that downing the Rockets again also meant a bit more since Houston

has said since losing to the Warriors in last year's conference finals that its main focus was beating them this season.

"This one feels good ... just because it was a team that said for years: 'We're built to beat them," Green said. "Then Kevin goes down and no one gives us a chance. You take all those things into account, this one feels amazing. If I said otherwise, I'd be sitting here lying to you."

Curry struggled early, failing to score in the first half for the first time in 102 career playoff games, and had just 10 points through three periods. But he got going in the fourth, scoring 23 points.

There were questions entering the game about how the Warriors would weather the loss of Durant – and his more than 34 points a game. But they didn't seem to miss a beat, getting 21 from Thompson in the first half before Curry closed it in the fourth.

The team said on Thursday that Durant would be re-evaluated next week and Kerr said after the game that it was too early to know if he could return at some point in the next series.

Though the Warriors were able to get past the Rockets behind big nights from Curry and Thompson, they know that their chances for defending the title are much better with Durant

on the floor. "I'm happy we won so we can get some rest and get him healthy," Thompson said. "Because if we want to get this three-peat, we desperately need him back. He's our best player, so we dearly miss him. We'll hold it down while he's out but it's not the same."

Curry finished out the series strong, but faced criticism for most of it as he struggled with his shot. He discussed the "noise" surrounding him lately and how he never let it get to him.

"I know what I'm capable of and it's bigger than me," he said. "I don't get caught up in that. I don't need any extra motivation. I don't need to hear who I am as a player. I know that. My confidence never wavers."

## North and South Korean musicians perform together in China

A SOUTH Korean violinist and a North Korean singer yesterday held a rare joint performance they hope would help bring the divided Koreas closer together via music – especially at a time of emerging tensions amid deadlocked nuclear

Violinist Won Hyung Joon and his North Korean soprano partner, Kim Song Mi, performed together at Shanghai Oriental Art Center with a Chinese orchestra. Their concert came three days after South Korea said North Korea fired two suspected short-range missiles toward the sea in the second such weapons test in five days.

For both, it was their first concert with a musician from the other side of the Korean border, the world's most heavily fortified. They met several times last year in Beijing and agreed on a joint performance to help promote peace on the Korean Peninsula.

As a duet, Kim sang Antonin Dvorak's "Songs My Mother Taught Me" while

Won played the violin. Kim later sang "Arirang," a Korean traditional folk tune beloved in both countries, while the Shanghai City Symphony Orchestra

"When I met her (Kim) for the first time, I felt like I was reuniting with an old friend who's been on the same

wavelength with me," Won said before Sunday's concert. "This performance shouldn't be the end ... and what's important now is what other dreams we can have together."

In a pre-concert written interview, Kim also said she "heartily wishes" that her songs would help bring back reconciliation mood. "I'm nervous and anxious about what inspiration the audience would have and what reaction North and South Korean compatriots would show to our joint performance,"

North and South Korean musicians performing together is extremely rare as their governments don't even allow their citizens to exchange phone calls, letter and emails without special approvals. Last year saw an unusual wave of crossborder exchanges after North Korean leader Kim Jong Un abruptly entered talks on the fate of his advancing nuclear arsenal. A group of North Korean dancers and singers performed in South Korea during the Pyeongchang Winter

Olympics, before South Korean K-pop stars flew to Pyongyang and sang in the presence of Kim and his young wife Ri Sol Ju. Both events were the first of their kind in more than 10 years.

But such exchange programs are now becoming a rarity again as North Korea is resuming provocative weapons tests in an apparent protest against the lack of progress in nuclear negotiations with the United States. Kim returned home empty handed from his second summit with President Donald Trump in Vietnam in February after Trump rebuffed his calls for major sanctions relief in return for his promise to conduct partial disarmament measures. No publicly known high-level meetings between Pyongyang and Washington have since

been reported. Sunday's concert won't likely work as a breakthrough in the stalled nuclear diplomacy. But it could still "establish an environment" that could make it easier to improve ties between the Koreas, said analyst Cho Han Bum at Seoul's Korea

### **Alves: Blame Barcelona** for UCL woes, not Messi

DANI Alves has questioned Barcelona's transfer policy and defended Lionel Messi in an interview with ESPN FC following his former side's Champions League elimination at the hands of Liverpool.

Under Pep Guardiola, Barca won two Champions League titles in three seasons with the core of their players coming from the famed La Masia academy. However, recently they have favoured expensive acquisitions over nurturing their own talent.

Saint-Germain And Paris defender Alves said he feels the club have focused more on bigname signings.

Asked whether Barcelona had lost their style of play, Alves, 36, told ESPN FC: "I agree with that somewhat. When I see stories about how Barca are now buying players to market them, you can sense that they are changing their philosophy a bit. Barca were about developing players.

"They didn't change their style, they signed players for specific positions. Now the feeling is they make too many moves on the market. But I also think that criticism is opportunistic. It's easy to lecture after elimination. You know Barca still like to take care of the ball and make good passes. It doesn't matter who comes in or who leaves, that's their identity.

"Their philosophy on the pitch isn't going to change. But it's changed a little when it comes to the market. That happens in football. If they would have won the Treble, nobody would have said anything. In the last 10, 11 years, Barca have won plenty of league titles, something that Real Madrid haven't done, but people defend [Real Madrid] because of their success in the Champions

"When Madrid are knocked out [of the Champions League], it's like: 'Hey, they haven't won the league in so many years,' but nobody talks about that. So it sounds a little opportunistic to analyse right after

elimination, against a really, really good opponent such as Liverpool."

Messi is leading the race to win this year's European Golden Shoe and scored two goals as Barcelona took a seemingly commanding 3-0 lead to Anfield for their Champions League semifinal second leg.

"Even if things don't turn out well, Leo's always fine. But this is a team sport and everyone has his responsibility. Cristiano [Ronaldo], Leo and Neymar get the cover when things go well for their teams, but they also have to be on the cover when things don't

"They're not going to write a headline that says: 'Eliminated' with Dani on the cover. No, they are part of it too. So for better or for worse, they are the ones who will be on the cover.

"When it comes to football, I don't think you can speak badly of

### Former FIFA boss Blatter says money risks ruining the sport

SEPP Blatter, the former boss of soccer's world governing body FIFA who was ousted during a corruption scandal, has said money risks ruining the sport.

FIFA's Ethics Committee banned Blatter, who led FIFA for 17 years, from "all football activities" in 2015 after finding him guilty of unethical conduct related to a global corruption scandal which rocked the organisation.

Switzerland's attorney general is still investigating cases of suspected corruption involving FIFA, which is based in Zurich, dating back to 2014 and Blatter's presidency.

"People already pay a lot to get into the stadium. Prices are getting

higher and higher, because clubs need more money," Blatter said in an interview with Swiss newspaper Schweiz am Wochenende published on Saturday.

The 83-year-old added his belief that viewer numbers are falling this season in the French, Italian, English, Spanish and German leagues.

"That is a bad sign. Football must remain accessible," he said.

Blatter has told various media that he plans to take legal action against his successor Gianni Infantino over damage done to his reputation by the corruption scandal and information FIFA made public about payments to him that he says was inaccurate.

## After craziest week in UCL, who will (and won't) win final?

AFTER the most extraordinary week in recent football memory, with Liverpool completing an unthinkable 4-0 turnaround against Barcelona and then Spurs shocking Ajax 3-2 in Amsterdam the following day, predictions for the Champions League final on June 1 seem futile at this point.

So here's a preview suggesting why Liverpool and Tottenham will, and won't, lift the trophy next month.

#### WHY LIVERPOOL WILL WIN

Ultimately, Liverpool are the better side. They sit 24 points ahead of Tottenham in the Premier League table and have recorded a pair of 2-1 victories over Spurs -- in September at Wembley, then in March back at Anfield.

Jurgen Klopp can count upon the most dynamic, ruthless front three in Europe. The peculiar thing is that this wasn't a factor in the incredible comeback against Barcelona: Roberto Firmino and Mohamed Salah were out injured, and Sadio Mane was relatively quiet by his standards. Firmino will probably drop into deeper positions to find space away from Spurs' centre-backs, and the threat should come from the wider positions.

Salah was quiet in the first league meeting, although his late header forced Toby Alderweireld into an unfortunate own goal in the return at Anfield. The real key will be Mane -- likely to be up against Kieran Trippier, who has endured a hugely disappointing campaign at right-back.

That's the other area where Liverpool are clearly stronger: full-back. Trent Alexander-Arnold has taken on a role that is closer to playmaker than right-back at times, and continually fires incredible crosses into the box, while on the opposite flank Andy Robertson does something similar. Spurs' pairing of Trippier and Danny Rose simply don't exert the same level of influence.

#### WHY LIVERPOOL WON'T WIN

Klopp has a poor record in cup finals. Since his Dortmund side thrashed Bayern 5-2 to complete an historic double back in 2012, Klopp has lost all six major finals he has competed in. He has lost the Champions League final twice, the German Cup final twice, the Europa League final and the League Cup final.

It's important to put this in context: In almost all of those contests, Klopp's side went into the final as underdogs. There was no shame in Dortmund losing to a Bayern side



If there is a common cause, it's probably been fatigue. Klopp's insistence upon energetic, dynamic football has often caused a drop-off in the final stages of seasons, which has sometimes manifested itself in late defeats in finals. The 2013 Champions League final loss to Bayern is the obvious example -- Dortmund's pressing meant they dominated the start of both halves, then dropped off dramatically.

But a few weeks of rest between the final Premier League game and the final in Madrid means this shouldn't be an issue. Besides, Liverpool are up against a side who have looked more fatigued than them in recent weeks.

#### WHY TOTTENHAM WILL WIN

can compete over a 55-game season with such a limited squad. In the end, they've managed very well, effectively confirming their place in the Champions League next season via the top four, while battling through to the final itself.

There's less doubt, though, over Spurs' ability to compete in a one-off

game, especially with two weeks' rest and time for Mauricio Pochettino to devise a specific game plan on the training pitch. With the likes of Moussa Sissoko and Dele Alli nearer full fitness, Tottenham are very much capable of matching Liverpool's intensity and pressing ability in the centre of the pitch.

There's also a suspicion that Harry Kane, seemingly ruled out for the season, could be fit to lead the line. His ankle injury wasn't bad enough to prevent him sprinting onto the pitch to celebrate after Spurs completed their remarkable comeback against Ajax on Wednesday night, and while it's difficult to read too much into a tweet consistently solely of an emoji, you suspect Kane wouldn't have responded to the question if there was no chance of him making the game.

For all Spurs' excellence without him, particularly in the semifinal away leg at Manchester City, Kane provides Spurs with a different option, the ability to come towards play and whip the ball around the corner The doubt over Tottenham this to onrushing counter-attackers. He's season has been about whether they also, clearly, a ruthless penalty box No. 9 -- and, in that respect, something Liverpool don't quite have.

#### WHY TOTTENHAM WON'T WIN

While Liverpool have a similar starting XI to the side defeated last season by Real Madrid, and offer more experience of European competition overall, this will be by far the Barcelona.

biggest game for almost every Tottenham player, with the arguable exception of Hugo Lloris, France's World Cup-winning captain last season. The same is true for Pochettino, who has minimal experience of showpiece occasions like this.

The value of experience is debatable, but it's also worth considering Spurs' reputation for collapsing at key moments. The fan bases here have very different mentalities: Liverpool's are generally optimistic and talk about their collective belief and the concept of destiny, while Spurs' have been conditioned to expect the worst.

Perhaps it's also worth considering the number of fans at the Wanda Metropolitano, too. It would be a surprise if Spurs supporters weren't outnumbered by Liverpool fans -their official allocations are equal, but there will be plenty of "neutral" tickets being exchanged for huge prices, and Liverpool fans will probably dominate by weight of numbers.

Spurs also have more obvious areas and the two-week break between matches means Klopp will be studying the videos of Pochettino's side and working out how best to expose them. This is likely to mean a serious test for Spurs in the full-back positions, particularly as Liverpool were so effective down the flanks against

## Antonio Valencia's Manchester United exit reminds fans of better days

ANTONIO Valencia is as renowned for sentiment as he is for speaking English, but romanticism has not been lacking in his recent social media output. The Ecuadorian international is about to leave Manchester United and Sunday's final game of the season against relegated Cardiff City will be the last that the club plays with him on the books.

"Unlike with previous partners on the right where I had a 50/50 partnership, my legs had gone playing behind Antonio," Gary Neville tole me. "Ronaldo said: 'I attack, you defend!' With Antonio, I needed him to defend and attack for me and I sat there hoping that he's do that and cover me. He was 90 percent and I was 10 percent."

Valencia broke his leg against Rangers in September 2010, but returned to play a role in his club's run to the following year's Champions League final, which he started vs. Barcelona. In 2011-12, having signed a new contract, his form saw him "I had a good first season (he was named United's player of the year named in the 2009-10 PFA team of and players' player of the year.

"I scored at Blackburn, one goal Valencia said. "It was close to 80 minutes when I scored, an important goal and one we thought would help us win the league. It was a shame we didn't win the league that year."

Valencia started 24 league games when United won the league in Ferguson's final season, 2012-13, but endured mixed fortunes under subsequent managers. He gave up the No. 7 shirt after one season, then struggled for form and fitness under David Moyes and Louis van Gaal.

The arrival of Jose Mourinho in 2016, however, led to a turnaround in Valencia's form and a permanent move to a new position. The newlyestablished right-back made 43 appearances in all competitions, starting League Cup and Europa League final wins vs. Southampton and Ajax respectively, and once again won the club's players' player of the year award. He also frequently wore the captain's armband.

"[Mourinho] told me that if I concentrated then I'd play every minute of every game," Valencia told me. "We talk tactics; we talk football. We have a good understanding. I see

my future as a defender." The switch, one that Ashley Young has since copied, was an almostimmediate success and Valencia did not find it too difficult.
