



Local finance development puts 96.5bn/in credits for 2.8m people

DISBURSEMENTS from the Local Finance Initiative (LFI) programme, a franchise of the United Nations Capital Development Fund (UNCDF) have so far reached 2.8m Tanzanians, obtaining seed capital and technical assistance.

Peter Malika, the head of UNCDF (T) and LFI country manager said on Friday that the programme covered a number of projects relating to clean energy, women empowerment, building agricultural value chains and food security. The loans were disbursed during the past three years on the basis of a \$42m (96.57bn/-) investment.

LFT took up about 32 projects, 17 hosted by local government authorities and 15 hosted by non-government organizations, running from January 2017 to December 2019 and also absorbing ventures in public service delivery infrastructure.

"During the period 32 projects were successfully implemented with UNCDF seed capital and technical assistance to all beneficiaries, where 15 per cent of the funding went to seed capital and the larger portion financed access to technical assistance," he said, unveiling a report on the programme.

The beneficiaries were grouped into 1.5m women and 1.3m men, taking up



NEC summons Lissu over rigging plot rant

appear before the ethics committee of the National Electoral Commission (NEC) tomorrow.

While addressing a campaign rally in Musoma, Mara Region on Saturday, Lissu charged that President Magufuli had convened a meeting with district executive directors (DEDs) in Dodoma whose agenda was how to rig the October 28 General Election, the polls director explained.

DDDs are empowered by law to act as constituency returning officers during general elections.

Dr Mahera said that the Magufuli-DEDs meeting claim was preceded by a document that made rounds on social media on Friday to the effect that director of elections also took part in the meeting.

"Both claims are false, unfounded and meant to cause alarm and confusion amongst voters," he said.

"These claims are meant to paint a picture that the elections will not be free, fair and credible so that when they (Lissu's party) lose fairly, they persuade Tanzanians to create chaos to fulfill their own agenda."

Dr Mahera said that on Friday and Saturday when the allegations on the said meeting were made, he was nowhere near Dodoma but was touring Manyara, Arusha and Kilimanjaro regions to coordinate preparations for the polls.

He said during his visits he met election returning officers at their workplaces to discuss matters of preparedness ahead of the polls and not a rigging scheme as charged by Lissu.

"We want him to come and shed light on this claim and give us evidence of the same if he has it," he said. Dr Mahera appealed to politicians on the campaign trail to watch their utterances, abide by the set timetable and most importantly understand the election law and its regulations to avoid getting into trouble.

NEC databases show that some 29,188,347 people have been registered to vote in the upcoming election. There are 80,155 polling stations scattered in all corners of the country.

Dr Mahera also reiterated that NEC had concluded the hearing and determination of appeals and objections raised after the nomination of candidates.

This declaration comes in the wake of Chadema's complaint last week that NEC was mum on the fate of hundreds of its aspirants who were disqualified and sought to be put on the ballot box.

The party's director of elections Reginald Munisi told reporters in Dar es Salaam that the NEC had not formally communicated to them with regard to the fate of thousands of appeals its aspirants lodged objecting their disqualification from the race.

The official said that the party's 15 parliamentary aspirants and over 300 who sought councillorship have been barred to contest.

"If elected, I will make sure you benefit with available markets in the East African Community (EAC). For our economy to grow, we need to facilitate exportation of our agricultural and other locally manufactured goods to regional markets," the candidate affirmed. He promised to settle wage and benefits arrears of public servants, which would rejuvenate the circulation of credit. A CUF government will ensure timely payment of civil servants, he emphasized.

He also glanced in the direction of teachers, promising to improve teachers' working environment with Information and Communication Technology (ICT) equipment spread in primary and secondary schools. A better working environment would boost teachers' morale and thus improve learning performance, he pointed out.

"We will connect all schools with internet services to facilitate e-learning. My government will invest more in developing skilled manpower to accelerate the country's develop-

He said that if elected, he will form a government of national unity (GNU) to allow Tanzanians from different political affiliations to contribute in the country's development.

"One of our priorities will be to write a Constitution that will ensure justice and promote human rights," the former presidential economic adviser intoned.

Prof Lipumba is contesting for the Union presidency for the fifth time, starting from 1995 when he garnered 6.43 per-

The CUF chairman also vied for the post in 2000 where he obtained 16.26 percent of the votes and in 2005 he secured 11.68 percent of the ballots cast, coming third in 2010 with 8.3 percent of the votes.

About 29m Tanzanians are registered to vote in this year's election, on the basis of data from the National Electoral Commission (NEC). In 2015, the electoral body registered 23m voters.

NEC has cleared 15 candidates to vie for the Union presidency, namely Dr John Magufuli (CCM), Leopold Mahona (NRA), John Shibuda (ADA-Tadea), Mutamwega Mgaywa (SAU), Jeremiah Maganja (NCCR), Cecilia Mbaga (DM), Prof Ibrahim Lipumba (CUF) and Philipo Fumbo (DP).

Others are Bernard Membe (ACT-Wazalendo), Queen Sendiga (ADC), Hashim Rungwe (Chaumma), Khalfan Mazrui (UMD), Seif Maalim Seif (AAFP), Twalib Kadege (UPDP) and Tundu Lissu (Chadema).

Come up with fish-farming project to fight poaching

VILLAGERS around the Ruaha National Park have suggested the need for the Tanzania National Parks (Tanapa) to come up with fish farming project to curb poaching in the conservancy.

In separate interviews villagers said that they've been illegally conducting fishing activities in the park because they don't have fish ponds to grow fish.

"Fish farming will not only provide food to the villagers; the project would be an income generator as well as help in curbing illegal fishing in the national park," said Alphonce Delile, Itipingi village chairman.

According establishment of a fish farming project would also end disputes between villagers and the park.

He said the park authority has banned villagers from Commissioner for Conservation

conducting fishing activities in in the southern zone, Pius where the project will be the reserve, but some villagers are secretly entering the park and carrying out fishing.

"The villagers are doing so to earn a living; having a fish pond at the village will completely end fishing in the reserve," said Delile when speaking to journalists who were on a field visit in Mbarali District, Mbeya Region.

The tour was organised by the Journalists' Environmental Association of Tanzania (JET) with support from the USAID PROTECT project.

Vikawe Village Executive Officer, Brastus Mninzi linked the illegal fishing activities in the reserve with life difficulties. He said some villagers were arrested and handed over to security organs, but yet similar incidences are reported repeatedly.

Tanapa Assistant Mzimbe said that fish poaching implemented. has remained one of the biggest conservation challenges in the in establishing a fish farming Ruaha National Park.

The assistant commissioner added that poaching for food is rarely practiced. He said the authority has been taking various initiatives to assist the villagers to establish income generating activities. Mzimbe said they have

to Tanapa zonal offices for implementation.

TAWA collects 28.4bn/- fines in last four years

Tanzania Authority (TAWA) has collected 28.47bn/- in the period of 2016/2020 which includes various fines as well as those over poaching issues.

TAWA Acting Commissioner Conservation, Mabula Nyanda said on Thursday that the authority has put in place an arrangement where stakeholders $dealing\,with\,wild life\,conservation$ are also provided with funds to enhance their activities.

Nyanda said that out of the collected money, 15.55bn/- was given to communities within Wildlife Management the Areas (WMAs) while 4.22bn/was directed to the villages surrounding national parks.

"The authority provides the monies to boost wildlife conservation activities WMAs as well as supporting development activities," he noted.

He said 8.82bn/- was submitted to local district councils that have conservation areas in them.

Nyanda further said that people should appreciate the benefits of conservation activities so that they involve themselves more in wildlife conservation.

He said they have also introduced a system which allows private companies and individuals to establish wild animal farms and butcheries as a way to ensure the community participates and benefit from conservation activities.

He said TAWA as well as its stakeholders have been contributing to development projects in villages surrounding national parks and WMAs whereas in the last four years it has spent an average of 350m/which was distributed to 10

Over 1,700 tonnes of pigeon peas remain unsold in Lindi District

OVER 1,700 tonnes of pigeon peas in Lindi Region are lying in the region's various warehouses for lack of buyers, the situation that had put farmers at crossroads.

The peas come from Nachingwea and Ruangwa districts and are stored in warehouses owned by Ruangwa, Nanchingwea and Liwale Cooperative Union Ltd (RUNALI).

This was revealed by the registrar of cooperatives in Lindi Region Edmund Massawe when responding to complaints from members convened here recently.

He said out of the 1,700 tonnes of the unsold peas, 540 tonnes were in Ruangwa District.

Massawe said there were buyers who wanted to buy the crop from

the farmers at 400/- per kilogramme on condition of not paying any levies, including local government levies, the condition that was hard for producers

Nachingwea District Commissioner Hashim Komba wanted to know the fate of farmers of the unsold peas. In the last five years the price for the pigeon peas in the country had been dropping from an average of 2,700/- per kilo in 2014/2015 to 700/- per kilo in 2016/2017.

The situation is attributed to an increase of the crop's production in India, China and Brazil.

In addition, in August 2017 India, that had been Tanzania's big buyer of pigeon peas stopped importing the crop from foreign countries as they were producing more of their

Youth group makes a fortune from strawberries cultivation

doma Region has embarked on markets, outside the country. large scale strawberry plantation in a project aimed improving livelihoods of its members.

The project launched by Tusumuke Youth Entrepreneurs Group targets to curtail production shortage, as well as tapping into economic fortunes of the cash crop.

Group chairman, Christopher Dioniz said they had decided to venture in the farming project after becoming aware over expanded demand for strawberries within and outside the country.

According to him, the group has opened a 1000 square meter greenhouse farm at Mbabala area of least 3,000 seedlings.

"Growing strawberries is not complicated since the crop is disease- free and it can be harvested after only two months," he said.

Moreover, he added that the crop was attracting lucrative prices at the market, currently at 10,000/-per one kilogramme.

"Thanks God as we have started to receive good market responses from different parts within the country though we're encountering some challenges, "he observed.

> He added:"In order to export strawberries outside the country there's a need of having professional packaging systems, including refrigerators and freezers.

> He urged the youth in the region and the country to venture into strawberries cultivation in order to generate profits and escape from shackles of poverty.

> "This is our pilot project, but in the near future, we're are planning to expand our farming scope in order to generate more profits since the market is very available," he said.

> Strawberries are potential in production of diverse items, ranging from jams, yoghurt, juices, cookies and perfumes for ladies apart from being consumed as a sweet fruit.

Most of the strawberries that are used in the Tanzanian market are imported from neighboring Kenya, South Africa and other countries, which means there's high demand for mass production of the crop in Tanzania.

Other regions that support cultivation of strawberries in Tanzania include Morogoro, Mbeya, Arusha, Iringa, Kilimanjaro and Coast.

National parks realised nearly 2trn/- in ten years

A TOTAL of 9.54 million tourists have visited the country's national parks within the last ten years and managed to bring into Tanzania revenues to nearly 2 trillion/- into the national cof-

That is according to official tourism figures from the Arusha-based, Tanzania National Parks (TANAPA), a state institution which oversees the operations of the country's now 21 national parks.

Speaking during the annual observation of the 'World Tourism Day,' in Arusha, the TANAPA deputy Conservation Commissioner in charge of conservation and business development, William Mwakilema stated here that in the period spanning a decade, between 2010 and 2020 the local national parks has been getting a cumulative figure of 9,536,135 tourists.

The visitors have been generating more than 9.5 billion/- annually, which can be nearly 200 billion/ per year. This applies to national parks only, discounting conservation areas and game

"Out of the figure, we recorded 5.6 million foreign visitors and 3.9 domestic tourists," stated Mwakilema. Apparently when citing domestic tourists, this group includes visitors from East African countries such as Kenya, Rwanda, Uganda and Burundi that are usually charged local entry fees at national parks' gates.

It was explained that, from the tourism earnings, the Tanzania national parks had managed to contribute into community development projects to the tune of 26.2billion/- benefitting a to-

tal of 1270 villages located around national parks and game reserves.

According to Mwakilema, a total of 73 villagers that have formed local entrepreneur groups, had also been receiving supporting funds amounting

to 862 million/-. The World Tourism Day 2020 which was marked with special symposium held at the National Tourism College of Arusha was under the theme of 'Tourism and Rural Development,' celebrating the sector's unique ability to drive economic development and provide opportunities

outside big cities, including in those communities that would otherwise be left behind.

The International 'World Tourism Day 2020,' was also meant to highlight the important role tourism plays in preserving and promoting culture and heritage all around the world.

The Karatu District Commissioner, Abbas Kayanda graced the occasion here and stated that the tourism sector in addition to pumping 17 per cent of gross national income, is also a goose which lays golden eggs by attracting 25 per cent of foreign earnings.

The executive chairperson of Fishers Union Organisation (FUO), Juvenary Matagili said that fishing activities and processing industries had contributed a ated in Sengerema District, Mwanza lot to the destruction of the natural envi-

ronment in the area.

Matagili noted that before the establishment of the fish processing industries in the early 1990s, islands in the lake had been covered by natural vegetation and were green.

He mentioned some of the islands as Zilagula, Yozu, Kasalazi, Gembale, Nyamango, Nyamuguma, Chemagati, Chembaya, Biswa, Juma, Lyakanyasi, Nyazune, Ikulu and Ito all of them situ-

"All these islands had natural vegetation but fishing for commercial purposes to supply fish to processing industries had caused the vegetation to nearly disappear, he noted.

He pointed out that fishermen have been cutting trees to establish fishing camps and some of them do not use toilets as well as baths, a situation that can lead to environmental degradation.

According to him, if that situation is left to escalate uncontrollably the islater that is detrimental to the environ-

Matagili further stated that it is important for the processors to improve the environment of the islands as these are areas which they mostly depend on getting fish to process in their firms.

"The natural vegetation on the islands was also supporting the lives of other living organisms for the ecosystem of the areas", he said.

The chairman said that the best lands may turn into desert sooner or practice the processors could do is to

see how they can restore the natural vegetation by supporting tree planting campaigns and helping to put systematic residential plans on the islands for environmental protection.

According to her, lack of hostels in the school usually fuel absenteeism and drop- outs among students resulting into early pregnancies and marriages.

The district commissioner pointed out that the challenge of teenage pregnancy, truancy and drop-outs for both male and female students was compounded by the lack of hostels or dormitories for female students, especially in secondary schools.

Roselyne Mariki, director of Lyra in Africa said that the organisation has been cooperating with the community and the government in implementing various social projects including the construction of girls' dormitories in ward secondary schools in Iringa Region. She said that Lyra in collaboration with the government and the community has built a total of eleven dormitories in eight schools located in Mufindi, Kilolo and Iringa District Councils.

Roselyne said that the dormitories have capacity to accommodate a number of students from 72 to 96 students and so far, all dormitories are occupied by at least 1,000 students.

In addition, she said that the Lyra, being a major stakeholder in ensuring the girl gets a safe place to live and study to increase her performance; they received applications and agreed to work with the community in ensuring the student house is built and completed as soon as possible.

"The total cost of the construction of the dormitories, toilets and bathrooms is 60,575,000 / -, of which Lyra has contributed 54,575,000 / and the Irole community actively participated in donating stones, sand, crash stones and labour all worth 6m /-.

Students at Lundamatwe hailed the organisation for building two dormitories for their school, saying the dormitories will help reduce student pregnancies, rape and thus increase their academic performance.

"It is more beneficial for students staying in hostels compared to students who walk long distances to school, living in hostels stimulate attendance and performance in examinations," said Lillian Kiteki, a Form Three student.

She said that many students, especially girls, are facing various temptations along the way, many of whom are given favours by people, and at the end of the day they pay tribute to those who gave them lifts and as a result are given unintended pregnancies at a young age.

Be proactive, increase coverage, reporting on tax matters, TRA tells media personnel

MEDIA practitioners have been urged to be more proactive, increase coverage and reporting on tax matters so as to deepen public awareness to broaden voluntary tax payment in the country.

"Media stations and platforms are the main source of providing various

information on taxes to our clients, that's why we decided to organize this training to educate journalists, equipping them with more knowledge on accurate reporting," he said.

He warned Kilimanjaro region residents against tax evasion and illegal businesses particularly the border residents who engage in smugglling different kinds of products from Kenya using illegal routes famously known as 'panya routes'.

Agriculture can advance Africa's economic growth

Agriculture was the key development in the rise of sedentary human civilization, whereby farming of domesticated species created food surpluses that enabled people to live in cities. The history of agriculture began thousands of years ago. After gathering wild grains beginning at least 105,000 years ago, nascent farmers began to plant them around 11,500 years ago. Pigs, sheep and cattle were domesticated over 10,000 years ago. Plants were independently cultivated in at least 11 regions of the world. Industrial agriculture based on large-scale monoculture in the twentieth century came to dominate agricultural output, though about 2 billion people still depended on subsistence agriculture into the twenty-

Modern agronomy, plant breeding, agrochemicals such as pesticides and fertilizers, and technological developments have sharply increased yields, while causing widespread ecological and environmental damage.

Selective breeding and modern practices in animal husbandry have similarly increased the output of meat, but have raised concerns about animal welfare and environmental damage.

Environmental issues include contributions to global warming, depletion of aquifers, deforestation, antibiotic resistance, and growth hormones in industrial meat production. Genetically modified organisms are widely used, although some are banned in certain countries.

The major agricultural products can be broadly grouped into foods, fibers, fuels and raw materials (such as rubber). Food classes include cereals (grains), vegetables, fruits, oils, meat, milk, fungi and eggs. Over one-third of the world's workers are employed in agriculture, second only to the service sec-

The 2020 Africa Agriculture Status Report (AASR) has been launched at the African Green Revolution Forum (AGRF) virtual summit in Kigali, Rwanda.

This year's AASR focuses on Feeding Africa's Cities by assessing the opportunities, challenges and policies required to enable African farmers and agribusinesses to serve the rapidly growing urban food markets. The report seeks to find ways for smallholder farmers to drive food security, rural prosperity, and inclusive economic growth.

"This report highlights the opportunity for all agriculture industry stakeholders to bring together viewpoints that define the transformation agenda while outlining the practical next steps to an agricultural revolution," said Dr Agnes Kalibata, President of the Alliance for a Green Revolution in Africa (AGRA).

The report begins by outlining the opportunities provided by Africa's urban food markets to the continent's 60 million farms. It indicates that cities shape Africa's agribusiness environment by affecting patterns of agricultural production and inducing the rapid expansion of food processing and distribution plans.

Subsequent chapters touch on the opportunities in Africa's growing urban food markets while recognizing that the effective governance of urban food systems requires inclusive models that coordinate and harmonize the actions of the many diverse players now shaping African agri-food systems.

While recognizing the debilitating effects of the COVID-19 pandemic and its role in exacerbating existing economic and social inequalities, the report defines five focus areas in a bid to overcome the problem of urban undernutrition and accelerate the urgency of urban food system planning.

Advancement of access to information tangible tool for development

CCESS to information is an enabler of all the 17 Sustainable Development Goals (SDGs) facilitating both implementation and the measurement of progress. In addition to the fact that access to information is necessary for the realization of the 17 SDGs, it is also important to facilitate the measurement of progress being made towards the realization of these goals.

Setting aside of September 28 as International Day for Universal Access to Information provides an opportunity to raise awareness on the importance of the right to information, and create a platform for governments, civil society, citizens and development partners to reflect on challenges and ways to promote the advancement of access to information as a tangible tool for development and the realisation of the SDGs.

The International Day for Universal Access to Information was proclaimed on 15 October 2019 at the 74th UN General Assembly to be held on 28 Septem-

Initially the day (commonly called the Access to Information Day) was designated by the UNESCO general conference. It was inaugurated in November 2015 and was first held on 28 September 2016.

The day had been recognised as International Right to Know Day since 2002 and was developed by international civil society advocates beginning in 2012. The UNESCO resolution creating the day was pushed by African civil society groups seeking greater information transparency.

Currently only 17 African Union member states have adopted national right to information laws, and groups like Open Government Partnership hope that the recognition of the right to information will "provide an important platform for all stakeholders at national level to discuss the adoption and effective implementation of national right to in-

CCESS to information is an formation laws in line with continental and international standards and obligations."

Access to information is the ability for an individual to seek, receive and impart information effectively. This sometimes includes "scientific, indigenous, and traditional knowledge; freedom of information, building of open knowledge resources, including open Internet and open standards, and open access and availability of data; preservation of digital heritage; respect for cultural and linguistic diversity, such as fostering access to local content in accessible languages; quality education for all, including lifelong and e-learning; diffusion of new media and information literacy and skills, and social inclusion online, including addressing inequalities based on skills, education, gender, age, race, ethnicity, and accessibility by those with disabilities; and the development of connectivity and affordable ICTs, including mobile, the Internet, and broadband infrastructures".

There has been a significant increase in access to the Internet, which reached just over three billion users in 2014, amounting to about 42 per cent of the world's population. But the digital divide continues to exclude over half of the world's population, particularly women and girls, and especially in Africa. Further, individuals with disabilities can either be advantaged or further disadvantaged by the design of technologies or through the presence or absence of training and education.

Access to information faces great difficulties because of the global digital divide. A digital divide is an economic and social inequality with regard to access to, use of, or impact of information and communication technologies (ICT).

Inequities in access to information technologies are present among individuals living with a disability in comparison to those who are not living with

Reps and that evil called estimated billing

FOR many decades, Nigerians have been grappling with the problem of what is called estimated billing in the power sector. Until nearly about a decade and a half ago, when prepaid metres were introduced in major cities of the country in 2006, electricity consumers in Nigeria had resigned to their fate.

So, what is estimated billing? Though all electricity consumers are familiar with what has now become an evil act, a rough definition may not be a bad idea. Estimated billing, simply put, and as the name implies, is a billing system where various electricity distribution companies (Discos) sit in the comfort zones of their offices and decide what a household or a business organisation consumes of electricity in a month without using any verifiable and known yardstick.

In other words, the Discos bill their customers based on assumptions, not minding the actual consumption within a particular period. A situation where citizens use their hard-earned money to pay for the electricity that they never consume should not be allowed by any society. Unfortunately, that has been the practice since the days of the National Electric Power Authority (NEPA) and the Power Holding Company of Nigeria (PHCN), both of which are now defunct. This looks more like a heist going on for years.

Nigerians, from all walks of life, have complained bitterly about the exorbitant amounts they pay through the noses for electricity supply that has been epileptic. At some point, they had to surrender. The practice is so weird and bizarre that even unoccupied houses are billed.

Disturbed by the way Discos take advantage of millions of Nigerians through estimated billing, invariably reaping where they do not sow, fleecing the citizens in the process, the Speaker of the House of Representatives, Rep. Femi Gbajabiamila, introduced a bill that seeks to prohibit and criminalise the act in all instances except where a consumer's metre cannot be accessed by the service provider.

The draft legislation, first tabled before the House in 2018 when Gbajabiamila was the House Leader, has the long title 'A Bill for an Act to amend the Electric Power Sector Reforms Act to Prohibit and Criminalise Estimated Billing by Electricity Distribution Companies and provide for compulsory installation of prepaid metres to all power consumers in Nigeria and other related matters.' Its short title is 'The Electric Power Sector Reform Act (Amendment) Bill.'

Passed for the first, second and third readings by the 8th House of Repre-



sentatives, the Bill could not be assented to by the president.

Determined to ameliorate the hardships Nigerians go through in the hands of the Discos, Gbajabiamila reintroduced the Bill in the current 9th Assembly. In fact, it was one of the earliest Bills introduced in the life of the

What does the Bill say? It provides that Discos must install prepaid metres on the premises of a consumer within 30 days of receiving an application and payment from such consumer or face penalties.

Thus, the Bill states that any Disco that fails to provide prepaid metres within the stipulated time frame is prevented from refusing a consumer access to power supply, disconnecting them, where connection has already been granted, or reverting to estimated billing.

What this means is that once the Bill becomes a law, it will become criminal for Discos to issue estimated bills, and failure to comply with this provision attracts either a one-year jail term or a fine of N1 million or both.

Leading the debate on the bill during its reintroduction, Gbajabiamila, who came down from the Chair, where he was presiding, noted that the action of the Discos was highly condemnable and unacceptable by every standard. He argued that: "This billing is not known by any scientific rule."

The proposed law vests the powers of ensuring that Discos comply with its provisions on the National Electricity Regulatory Commission (NERC).

In October last year, the House concluded work on the Bill and transmitted it to the Senate for concurrence before it will be forwarded to the president for his assent. The bill is still in the Red Chamber.

At every forum, Gbajabiamila voiced his opposition to the estimated billing system. On June 9 this year, when he inaugurated the House Ad-hoc Committee on Power Sector Reforms, the Speaker said "Estimated billing remains a no, no for me and members of the House. However, we need to do it, we have to do it."

On August 26, NERC, through its chairman, Mr James Momoh, came out with what was cheering news to Nigerian electricity consumers, saying President Buhari has directed the commencement of mass-metering programme nationwide. This, he said, was part of efforts to bring an end to estimated billing.

A day earlier, precisely on August 25, the Minister of Finance, Budget and National Planning, Hajiya Zainab Ahmed, announced that President Buhari had approved a one-year deferment of the 35 percent import adjustment tax (levy) imposed on fully built unit electricity metres.

She said the approval was to support NERC in rolling out three million electricity metres under the Metre Asset Provider (MAP) framework.

The minister said: "The 35 percent levy was imposed on the recommendation of the Federal Ministry of Industry, Trade and Investment, to encourage local production, as well

as protect investments in the local assembly of electricity metres."

The two actions taken by the president are indeed laudable, coming at a time that Nigerians demand value for their hard-to-get money, not just in the electricity they consume but also in other aspects of their lives.

Matter-of-factly speaking, there is an urgent need for the Bill at this time that the Discos have hiked electricity tariff, which will leave more sour tastes in the mouths of their customers, especially those under estimated billing.

This is where the synergy and the good working relationship that exists between the Executive and the Legislature since the take-off of the 9th National Assembly could come to play.

The president has, between June 11 last year and now, signed into law several bills passed by the National Assembly, including the Finance Act, the Deep Offshore Sharing Formula Act, the Companies and Allied Matters Act, among others.

With President Buhari's posture on addressing the hydra-headed challenges in the power sector, it is given that once the Power Sector Reforms Act (Amendment) Bill gets to his table, he would not waste time in appending his signature to it.

When that is achieved, Nigerians can go to sleep with their two eyes closed, believing that they can get value for the electricity they pay and consume.

TaTEDO makes assessment of modern cooking energy market in Tanzania

ANZANIA modern cooking energy market is said to be underdeveloped and dominated by fuel wood and charcoal burned in inefficient stoves. The Three Stone Fire place remains the most commonly used fuel wood-based stove in 2019 in rural areas where about 95 percent of the Tanzanians were using this stove. The traditional metal charcoal stoves dominate in urban areas where charcoal is used by the majority for cooking.

Executive Director of Tanzania Traditional Energy Development Organization (TaTEDO) Eng. Estomiah Sawe explains that the government of Tanzania has set a long-term goal of having 75 per cent of households adopt clean cooking services by 2030. The clean cooking under consideration include LPG, biogas systems, electric cookers, and improved cook stoves to address the current overreliance on inefficient stoves and low-quality fuels. None of the above efforts have produced large scale satisfactory results.

Biogas have not been adopted on large scale due to a number of factors including high initial costs and the required tedious operational practices. Electric hot plate cookers' high initial costs and related high monthly bills have been major barriers to adoption

Some efforts have been devoted to promoting improved cook stoves; however, success has been very limited due to mostly limited financing both for producers and consumers. In spite of such efforts, improved cookstoves are best understood as interim measures, rather than truly long-term, sustainable cooking solutions. In the light of the rapid population growth anticipated in the country, reliant on wood fuels based cooking is likely to become less and less sustainable in the long term simply due to the underlying demographic trends, which will put an increasing burden on forest resources, exacerbate desertification, reduce access to water and put long term prosperity at risky.

LPG which is seen by some policy makers as the clean cooking solution is derived from fossil fuels and is also deemed unsustainable in the long term. First and foremost as it is nonrenewable. Beyond the fact that LPG is non-renewable, it is inherently volatile in price as it is linked to oil price, this increases the risk of sudden reversion to wood fuels such as firewood and charcoal LPG is also exposed to greater geopolitical and other risks, as Tanzania do not produce own LPG. making supply inherently interrupt-

long-term solution to the challenge of achieving sustainable clean cooking in

Natural gas is available in Tanzania and efforts are ongoing to promote it as a cooking fuel, however, like LPG, it is not sustainable as it is non-renewable. Also, the required high cost of developing its supply and demand infrastructure makes it only accessible to a limited number of populations in the country. There has also been the questioning of the opportunity cost of using natural gas for cooking, as there are higher value products that can be made from the natural gas.

On the basis of the above, there is a need for the country to explore the potential for more transformational solutions that move beyond the above unsustainable fuels-based cooking al-

Eng. Sawe explain further that as the country is making major efforts on electrification, all efforts need to be made to link these efforts with sustainable clean cooking. The current technological developments on highly efficient electric cooking appliances such as electric pressure cooker (EPC), bring about a huge opportunity to now link electrification, not only for lighting, but also for cooking. Depending on the source of electricity, this is now considered by many as the long term ultimate sustainable clean cooking solution for Tanzania.

Citing an example, he said an electric pressure cooker (multi-cooker) is simply a highly insulated sealed pot which works on a simple principle, steam pressure. The steam enclosed inside builds up high pressure and temperature thus helping food to cook faster and stay tasty and nutritious. The timer switch and temperature and pressure sensors switch the power off as soon as it reaches the right point in the cooking cycle. The EPCs can carry out various cooking operations such as frying, boiling, steaming, pressure cooking and baking.

The EPC combines several familiar cooking appliances: fireless cooker (insulator), electric hot plate and pressure cooker.

"Advantages of Using Electric Pressure Cookers (EPCs) are many. Forexample, they save time - Cook food in a fraction of the time and it still tastes good, can boil, fry, steam and bake, retains nutrients - no steam escapes hence nutrients are retained, the lated retain the heat and steam so that if allowed to depressurize naturally,"

Mind the gap: Here's how to stop the world's poorest students falling behind

NVESTING now in bringing students back to school and helping them catch up is far cheaper than providing a second-chance education for those who have fallen out of education due to COVID-19.

Never before have so many children been out of school, with the most disadvantaged at risk of never seeing the inside of a classroom again.

Distance education is not an option for at least 580 million students according to a UN-ESCO-UNICEF-World Bank survey. Even when there are distance learning options available, they only reach learners for a fraction of the time they were attending school before. The vast majority of students have now fallen behind. It is no exaggeration to talk of the risk of a lost generation: according to a UNESCO estimate, 11 million children may never go back to school. The life prospects of millions of learners from poor backgrounds hang in the bal-

Five years ago, the world committed to Sustainable Development Goal 4 - to ensure inclusive and quality education for all by 2030. The Global Education Monitoring (GEM) Report estimated at the time what governments in lowand lower-middle-income countries needed to spend to meet this goal and how much external financial aid was required to support them.

We concluded that, even before COVID-19, the total annual cost of universal pre-primary, primary and secondary education for these countries is US\$504 billion a year. Of that amount, US\$356 billion is projected to be covered by domestic resources, under plausible assumptions on growth, tax revenues, and the priority assigned to education. This means there is an annual funding gap of US\$148 bil-



lion between now and 2030.

Impossible, you might think. But that depends on your priorities. Global military expenditure per year is US\$1.8 trillion, for instance. Just one month of this spending could send all children to school around the world.

Priorities are coming into question with COVID-19 too, with governments weighing up health and economic benefits every day.

School closures, the GEM Report has found, risk increasing the funding gap by up to 30% because of costs related to remediation and re-enrolment programmes for students who have missed out. Also driving higher costs is the need to ensure children are safe when they return to school in a pandemic by allowing for

additional spaces and proper hygiene facilities. There is an opportunity to prevent these costs from spiralling further. Investing now in bringing students back to school and helping them catch up is far cheaper than providing a second-chance education for those who have fallen out of education. Upfront investment, the Report calculates, could reduce the potential cost of COVID-19 on education by 75%.

Stopping the education emergency that has fallen out of this health crisis requires, therefore, systemic change. One of the problems, however, is that education has long been losing ground as a donor priority. Its share of total aid fell from 14.8% in 2003 to 10.8% in 2018. Only about US\$7.4 billion goes to primary and secondary education in lowand lower-middle-income countries. But, instead of increasing further to stop this education crisis, recent analysis from the GEM Report warned that total aid to education is likely to decline by up to US\$2 billion until 2022 as a result of the economic consequences of the pandemic.

Finance ministers are being convened this week by the United Nations Secretary-General to look at financing in the 'Era of COVID-19'. Our message to them is to see education as key to the recovery from the effects of the pandemic.

Education aid and education budgets must at the very least be maintained if not increased and targeted at the most marginalised countries and students. Education ministers need to work collaboratively with the finance and social protection ministries on programmes such as cash transfers aimed at the most vulnerable, to make it easier for families to send their children back to school.

Investing in education now is not just good will; it is also good sense: it will save funds in the long-term and is critical for getting our societies back to some form of normality.

Achieving SDG 4 is still possible, but it requires a strong commitment to investing in education for the world's most marginalized students. The coming months are critical if we want to prevent this student cohort from becoming a lost generation.

Peaceful transition to democracy in Ethiopia: Why is it so enigmatic?

N December 2019 Ethiopia is going through a political transition to democracy that began under the incumbent Ethiopian Peoples' Revolutionary Democratic Front (EPRDF), a coalition of four ethnic-based political groups that ruled the country since 1991. Despite its authoritarian past, the EPRDF initially committed itself to transition to democracy that is open to all opposition political parties. After a few months into the transition, the ruling EPRDF fractured following serious political differences between leaders of the party who support democratic reforms and those who want to retain the status quo.

On November 22, 2019, the chairman of the EPRDF, PM Abiy Ahmed, announced the decision to merge three of the four members of the EPRDF coalition to establish a new national incumbent successor political party named Prosperity Party. Other hitherto independent regional parties are also expected to join the Prosperity Party (incumbent successor party). This commentary reflects on why the birth of the new incumbent successor party is a step forward in the transition to democracy and highlights three major issues (ethnicity, dealing with the past, and personal rule) that are crucial for the strength and stability of the new party.

On April 02/2018 the outgoing PM Hailemariam Desalegn handed over power to the current PM Abiy Ahmed in what was hailed as the first of its kind peace transition of power. Two years and five months later, Ethiopia is back to its familiar territory: the road to authoritarianism.

Time and again our politics has been continuously squandering opportunities that could have otherwise facilitated the country's path towards a democratic rule. The 1974 revolution would have been a marvelous moment to initiate the long journey to democracy had it not been spoiled mainly by the military junta's (Derg) ruthless approaches to control power single-handedly. In its wake it left a gloomy juncture that took the lives of large number of selfless dynamic political champions and a dysfunctional political order.

Similarly, ending the longest civil war in the country, 1991 came as a harbinger for a multi-party democracy in Ethiopia. However, it too didn't take long before the EPRDF ruling coalition mustered power under its dominant one-party rule. Later on, the 2005 election, which constituted a radical turning-point in the country's election history, revealed a captivating instance of electoral democracy with extraordinary participation of opposition political parties. Nevertheless, it too was reversed by the ruling party when it showed results at odds

with its expectations. The recent development as well stirred hope for peaceful democratic transition. The widespread protests across the country that caused the dominant EPRDF ruling party to crack under pressure and comply with public demands led to its own initiate of unprecedented reform proposals; now it all seems hanging in the balance. Two years and five months later, we are yet to see the promised reforms for a stable country; on the contrary the country is forced to experience one crisis after another, almost

entirely political in nature. This op-ed will look into the recent opportunity, which is the last in the series and is peculiar in many aspects.

Transition from within

Considering the extent to which it controlled monopoly of power, it was hard to conceive a moment in which the EPRDF coalition would lose its momentum. Its engagement with the military structure, its privileged encroachment in the (then) booming economy, and its remarkable use of the security apparatus for political purposes could tell how daunting it was to see any peaceful transfer of power any time soon.

The Oromo protests, which began in April 2014 and ended with the designation of Abiy Ahmed as prime minister in April 2018, was consequential. Even though the external pressure from the protests and the discontent from every corner of the country, including the Amhara protest, had been instrumental, it was very hard to think



of any shift in power had it not been for the rise of some reformist elements from within the coalition who embraced the people's demand for change. The role played by the familiar phrase 'team Lemma' in realizing this change was substantial.

For a country that had been tightly controlled by a single party, the crisis that might have resulted with its demolition would have been devastating. Moreover, the absence of competent opposition parties that could qualify to replace the ruling coalition, could have resulted in multiple crises of its

Nonetheless, the emergence of this reformist bloc from within the party was welcomed with a collective sigh of relief in a country which was on the verge of a complete collapse due to political, ethnic, religious and ideological divides. It was this group that sparked a lot of hope to the different actors in all sides of the spectrum and restored faith in the political process that followed.

What went wrong?

The first months of Abiy's leadership witnessed important developments, including but not limited to, the lifting of the state of emergency, release of political prisoners, opening up the media, and legalizing outlawed political parties. His attempts to make peace with Eritrea has earned PM Abiy last year's Nobel Peace Prize. Furthermore, his rhetoric of peace and reconciliation was acclaimed by many in spite of a host of differences across the country. The combined effects of these resulted in an unprecedented support for him and the incumbent regime which was hoped to direct the country to a better sociopolitical path.

However, it was only for about the first six months that the unanimous support PM Abiy enjoyed from all corners of the country could last. The security deterioration across the country was the first manifestation that caused many to question his ability to deliver the expected leadership the time has needed.

Even if his supporters justified the developments as an intentional compassionate gesture of avoiding the use of force, his critics presented it as his inability to enforce the rule of law in the country. However, many have already started to criticize his leadership in the early days due mainly to his lack of presenting a proper roadmap to guide the transition.

Even if several outlawed political parties came into the country, including those who were engaged in armed struggles, and many more proliferated anew, there was no clear plan for involving them in the supposed transition. His declaration and intransigence to lead the transition solo was also widely condemned. Many observers have noted skeptically the paucity of platforms for collaborative engagements with the opposition groups.

Later on, his decision to create a new party (Prosperity Party) to replace the

age old Ethiopian People's Revolutionary Democratic Front (EPRDF) was a significant development that provoked varied reactions. One of the parties in the coalition - TPLF, which was arguably taken as the original maker, questioned the development for its legality, eventually exiting membership of PP. Others accused the move as an attempt to deny different nations and nationalities in Ethiopia the institutional frameworks which could help them advance their group rights.

Lemma Megersa, who was considered the front runner of the reformist team, stood against the decision, creating the first signs of a consequential rift between him and Abiy. In less than a year, the exceptional unanimous support the new reformist group enjoyed began to get thinner and the political landscape deeply split up between polarized supporters and opponents.

Despite criticisms and the fragile political situation the incumbent regime continued in its own non stop, unaccompanied course. It was amidst these consequential developments that COVID-19 was reported as global pandemic for which the government declared a state of emergency followed shortly by the electoral board's decision to postpone Ethiopia's much anticipated election. The decision left in its weak a constitutional deadlock as the term limit of the incumbent would come to an end before elections were

The government's handling of the state of affairs in resolving this deadlock was very controversial. The use of the two houses, which are fully constituted with members of the incumbent itself, to instrumentalize a decision in its own favor escalated the tension between Abiv and key political actors: it also revealed the Prime Minister's reluctance for negotiated political settlement, including an all inclusive dialogue on how the incumbent should continue once its term in office came to an end.

The current crisis that we are witnessing after the assassination of legendary Oromo artist Hachalu Hundessa only heightened the existing tension as it was followed by the imprisonment of leading oppostion political figures like Bekele Gerba, Lidetu Ayalew, Jawar Mohammed, and Eskinder Nega, and many others; by all accounts it can be taken as the last laps towards an obvious authoritarian rule. The excessive reliance on the use of force to cross the political frontier is

becoming strongly evident. Below, i will discuss the main factors that I believe have contributed to this authoritarian proclivity that PM Abiy's regime seems to settle on, despite high level of expectation, both locally and internationally. Without ruling out the contribution of many other intricate elements, these factors have impacted the current failure to a peaceful democratic transition that many of us optimistically anticipated.

Hierarchical and highly centered

power structure

Unlike other African states, which are mere post-colonial constructions, state structure in Ethiopia has longer history. It nurtured a hierarchical power structure with a formidable center. This in consequence helped to manipulate the power structure in one's favor for whomever controls the seat at the palace in Arat-kilo.

This creates a conducive political environment to pursue authoritarian ambitions. If we try to scrutinize those who seized power at different occasions, most of them precisely changed their declared interest to pursue power-sharing and democratic transitions and ended up with dictatorship and tvranny

This highly centralized hierarchical power structure, in addition to helping in enforcing one's aspirations, made the acts of targeting and attacking whoever mistakenly or openly opposes this center. It has also been instrumental to subdue the public who often revolt against it. This dominance of central power structure has been highly conspicuous in all the regimes through the Emperor, to Mengistu and Meles.

The incumbent is simply capitalizing on this long established power structure. The failure for the current transition to democracy is mainly ascribed to this factor and PM Abiy, who inadvertently came to power as a result of the protests, has in time resorted to manipulate this state structure towards consolidating his grip and influence.

If we look back at the developments, had it not been the hierarchical power-center, it would not have been easy for him to continue exerting influence without such a formidable structural backing especially after his moves to demolish the EPRDF coalition, changing it into a single party PP (Prosperity Party) with Medemer as a political ideology. Without using this long established power structure, orchestrating constitutional interpretation to extend his term in office would have been much challenging too. This dynamic could represent a case of power structure reigning over agency, which are key notions in the conventional political science analysis.

What makes this factor interesting in this particular case is the fact that the major contributing factor for PM Abyi's ascent to power and the regime legitimacy was popular public demand articulated through the protests. One could say that it was the public agency that prevailed over structural dominance at the start.

This was different from Derg's case which was considered as military coup by the Emperor's own army, although it was preceded by popular public discontent . It is also distinct from the TPLF/EPRDF's 1991 power control, which followed the military defeat of the Marxist regime. That is why the use of similar hierarchical central power for authoritarian ambitions to meet these demands was to invite

seems paradoxical under PM Abiy.

In relation to this, some construe the ad hoc quietened public reaction against the center's dominance as a case of subservient political culture which is prevalent among Ethiopians. It is also presented as a major contributing factor for the recurrence of structural domination in Ethiopian politics. But that is not true.

This is essentialist reading of a political culture as static throughout history. This couldn't grasp the changes across generations and the diversity among the population within Ethiopia. Moreover, if we could look back how regime changes happened in the past, they were the consequences of public revolt and grievances - a demand for freedom. The public showed its capacity to say enough and opted

Debilitated opposition

The vicious cycle of authoritarian rule weakens opposition; and as the last three decades of experience in Ethiopia show, a weak opposition never overcomes authoritarian rule. The EPRDF coalition tenure was known for mercilessly crushing the opposition and cracking the emergence of dissenting voices.

In general, intimidation and harassment were the norm towards major opposition parties, civic society and independent media. This ensued the opposition camp that went disarray characterized by lack of one thing in common: formidable strength that could competitively challenge the incumbent.

When PM Abiy came to power, he called for all parties to join the transition. But the only change on the ground was the proliferation in numbers of opposition political parties. For some who were able to make it, it justifiably took more than a year to make alliances and partnerships. The paucity of strong parties that could rally the public in favor of them was evident. (This proposition never refutes the emergence of one or two opposition parties which were heading in that direction).

But by in large we haven't seen them making strong commitments that could challenge the ruling party. This futile situation must have lured the ruling party, which have a good knowledge of their inefficiency, to manipulate that to remain in power. We have observed this from the insignificant attention the ruling party gave for the opposition in spite of their insistence for dialogue and reconciliation.

Even after the constitutional crisis event that signaled the regime's end of term, the PM and his party were stubborn enough to manipulate the legal system to extend their term in office despite the call from opposition parties to have an all inclusive dialogue, and establish a care-taker govern-

The closest the incumbent has come

opposition parties (often in the eve) for a meeting without a shared agenda where the PM exerts the a maximum power asymmetry and pressure to his points acceptable. The four alternatives he delivered with regard to the differed election was the same; he even scorned them on their unpreparedness for "such critical national

Their insistence to come with their own alternatives was categorically rejected. Giving deaf ear to opposition calls, the ruling party useed the rather homogeneously established houses to pick one of its own alternatives and made the decision in favor of extending his term in office, as some interpreted it: ostensibly indefinitely

Existential choice

When PP established itself as a new party with purportedly different ideological departure from that of EPRDF (excluding TPLF), individuals who were the members of the former party continued their status. All the structures that served the older party continued to serve the new one without laudable reform measures. Even among the higher officials, it was only Lemma Megerssa, who had a leading role at the start of the transition, who stood up against it.

For a country that has been suffering high levels of unemployment and in a country where most government jobs are allotted based on political affiliation and party loyalty, loosing position from party membership is equivalent to loosing one's livelihood. This especially becomes very serious for party members who have been accused of rampant corruption at all levels, including the top officials. Allowing the transition to go forward may come with many uncertainties that they are not willing to face. The change may bring forth developments that may hasten their calamity.

Therefore, clinging to the party and dying for its continuity could be an existential struggle that many have opted to fight for. If not all, a good number of party members may not care about ideas and ideologies as much as the importance of keeping their position in the government.

They will work for whomever that may come with whatever ideological disposition as long as it does not imperil their life styles. The PP party exploited this ambivalent force in its favor. This certainly has benefited its newly minted President, PM Abiy, to consolidate his grip on power, at least for the time being.

Other players' priority for security

The role of some global powers, which have special geopolitical and economic interest in the Horn in general and in Ethiopia in particular, in influencing the current political dynamic has been substantial. There may not be direct king makers, but the impact of these third parties in influencing political changes, particularly in times of this transition, in visible.

that time then the insurance will cover their children's education," he added.



Modern amaranth farming project benefits about 150 small-scale farmers in Bagamoyo

regions are currently benefiting from an "Amazing Amaranth Project" which is aimed to equip them with essential skills, techniques and knowledge to grow the crop to improve incomes.

Amaranthus is a cosmopolitan genus of annual or shortlived perennial plants collectively known as amaranths. Some amaranth species are cultivated as leaf vegetables, pseudocereals, and ornamental plants. Most of the Amaranthus species are summer annual weeds and are commonly referred to as pigweeds.

The project is funded by the German government through its Federal Ministry of Economic Cooperation and Development (BMZ) and the World Vegetable Centre.

Speaking during the 'Farmers' Field Day' held at Chambezi Research Centre in Bagamoyo District, project's coordinator Dr Ruth Minja said that to implement the project which commenced in 2018-2021, involves establishment of demonstration plots to create public awareness about different improved varieties of amaranth.

She said that among others, the project also aims to contribute to better livelihoods and better nutrition in the country.

An enabling environment will draw investors to Liberia

N a conversation with Gulf New last November, Liberian President George Manneh Weah proclaimed that Liberia was opened for business. "Liberia is open for business and we are creating the right environment that makes it seamless for investors to get a head-start," the President declared.

According to the president, his administration has in recent reduced some of what have been described as hurdles in the way of starting a business in Liberia. "Large-scale corporations too have also been offered incentives for choosing to invest in Liberia. The arable land is vast and untapped. Young people, who make up the bulk of the population, are eager to work.

The president said the potential exists in various areas, including agriculture, mining, infrastructure and tourism, among others. "We have barely scratched the surface with each of these sectors. But like I said earlier, our tourism sector is beginning to gain international attention. It's an area where investment can yield enormous return. The agriculture sector too remains largely intact."

This was not the first time that the President had made the assertions. Following his inauguration in January 2018, the President declared the country open to investment and pledged to tackle entrenched corruption.

Ironically, President Weah's assertions appear to be only on paper and in words - and stakeholders are taking

This week, the U.S. Embassy in Monrovia noted that an enabling environment is necessary to attract the kind of reputable businesses that will move Liberia's economy forward and create jobs. The embassy said that Liberia's productive soil, iron ore, diamonds, gold, and its ideal climate for growing rubber and palm oil cannot make up for an uncertain business environment

The embassy observed with concern new challenges in Liberia's ex-



the last few years, leading concessions here to either pause, streamline, or halt operations.

Charges d'affaires alyson grunder, speaking a policy dialogue on Promoting Transparency and Accountability in the Management of Extractive Industries to Enhance National Development in Liberia, said: "From the perspective of the U.S. Embassy, we have experienced a number of instances in which U.S. businesses have expressed interest in doing business in Liberia. But they invest their money and other resources elsewhere when they hear about perceived difficulties in negotiating contracts and retaining respect for them, obtaining permits, and maintaining good relationships with the public"

According to madam grunder Liberia's extractive industries are key tractives and agriculture sectors in to its economic development and to the livelihoods of many, adding that transparent and open discussions of the necessary policy environment for businesses in the country to thrive will be advanced through dialogue that is inclusive of all stakeholders.

The US diplomat averred that while the COVID-19 pandemic and its impact on global prices may be partly to blame for some of the recent economic downturn, a difficult local business environment also disproportionately affects investment, like is the case right now in Liberia. "Obstacles to doing business in Liberia as evidenced by the 2020 World Bank Doing Business report are a dissuading factor for individuals and corporations deciding on countries in which to set up shop", Madam Grunder said.

The sad reality is that since the end of the civil war and the ushering of democratic governance, Liberia has al-

ways been trumpeted as being opened for business.

Following her election in 2005, former President Ellen Johnson-Sirleaf declared the country opened for business and launched an international effort to lure investors to the post-war

Eyeing the US business community because of its economic power and historical bond with Liberia, the Sirleaf administration

Liberia was founded by freed American slaves and the US dollar remains legal tender in the country. The Sirleaf administration, during its two-term in office also spread its nets as wide as possible for sources of investment, including those from Africa itself, such as South Africa and Nigeria, and with the world's rising economic power,

been Liberia's inconsistency regarding governance and accountability issues.

In May 2013, for example, an audit of lucrative resource deals in Liberia found that almost all the concessions awarded by the government since 2009 were not compliant with the law.

In a damning report commissioned by the Liberian government, international auditors found that only two out of 68 resource contracts worth \$8bn (£5.1bn) were conducted properly. Concessions granted in agriculture, forestry, mining and oil - including a lucrative deal with oil company Chevron - were either wholly or partially flawed.

Today, the country remains entrenched in familiarities of the very problems that persisted then, and those which kept investors at bay.

Last year, Forbes magazine conducted a study of countries business climate and ranked Liberia as the first on the list of the top 10 worst destinations for doing business. In simple terms, the magazine is cautioning foreign investors not to venture into pouring their moneys into the country. The ranking is tallied after evaluation of the level of innovation, taxes, technology, corruption, freedom (personal, trade and monetary), red tape and investor protection of a particular country.

Liberia, which has a GDP of US\$2 billion, is below DR Congo, Mauritania, Togo, Zimbabwe, Burundi, Guinea, Libya, Gambia, and Chad on the index. South Africa, Morocco and Rwanda are three African countries that scored impressively on the list of countries suitable for investment.

While it is a good thing to trumpet a country as being opened for business, it is even better to strive to maintain an enabling environment that would lure investors and encourage investments in Liberia.

We agree with the US diplomat that strong oversight regime is necessary to ensure that Liberia receives the most revenue for its natural resources and ultimately its develop-

The fact of the matter is that the Weah administration got off on the wrong foot in the way it handled the illegal removal of Mr. Konah Karmo, Head of Secretariat of the Liberia Extractive Industries Transparency Initiative (LEITI).

The administration rejected criticisms and condemnation at the time and lost a lot of points in the eyes of the donor community, dealing even more setbacks for the investment climate. But that is in the past

Moving forward, President Weah and his team must work toward ensuring that the environment is safe, in terms of security for Liberians to reside; that investors are comfortable doing business in Liberia and that local as well as foreign businesses are able to operate in a relax business climate void of extreme bottlenecks and unnecessary demands.

A nation that is truly opened for business will leave no stone unturned in making sure that the climate is condu-The problem though has always cive for both investors and consumers.



ria. All three are enrolled in schools, already on the path to learning and gaining the necessary skills to make a life for themselves and contribute to society.

But they all experience reading challenges. Their school contexts have proven insufficient in providing the tools they need to overcome these challenges. In William's case, his parents changed his school four times. The desired improvement did not materialise.

Currently, 90% of children are out of school globally, due to the closures.

We have also set our sights on preparing Africans for the future of work via our Grow with Google programs including Digital Skills for Africa and CS First and our developer scholarships. This is in line with our commitment to training 10 million Africans on digital skills. So far, we have trained over 5million people with 60% of them reporting are very proud to be a part of it all.

Global trade recovers to 75% of pre-pandemic levels as monthly exports rise

GENEVA

Global trade has recovered to about 75 per cent of its pre-Covid-19 crisis levels as every region recorded a rise in monthly exports, although at varying degrees of speed and strength, according to Capital Economics.

China and the US recorded the biggest increases in monthly exports among all regions, Capital Economics said in its Global Monitor report on September 25. However, while China's exports had returned to their pre-virus levels by the end of July, exports from the US were still 13 per cent lower, it said, citing world trade data from the CPB Netherlands Bureau for Economic Policy Analysis. More recent data, including Purchasing Managers Index readings for September, indicate the recovery has continued throughout the third quarter.

"Given the encouraging signs from the timely hard data and survey evidence, we suspect that trade is currently three quarters of the way back to its pre-virus level," the report by Capital Economics' global economist Gabriella Dickens

The signs of recovery come after the Covid-19 pandemic hammered the global economy during the second quarter, disrupting international trade flows, supply chains and air travel. The virus has infected more than 32.7 million people and the death toll has exceeded 994,000, according to Worldometer statistics. About 24 million people have

recovered so far.

In July, world trade had regained two-thirds of flows wiped out by the

Covid-19 pandemic, standing at 6.6 per cent below its December 2019 peak. This was an improvement from May, when world trade fell 17 per cent below its December 2019 level. World trade volumes jumped by 4.8 per cent in July following a record 7.8 per cent rise in June, Capital Economics said, citing CPB Netherlands Bureau data.

Trade among Asian countries - Japan, South Korea, Taiwan and Singapore continued to recover in August with volumes just 1.2 per cent below previrus levels, compared to 4.8 per cent below in July, the report said.

September's Purchasing Managers' Index (PMI) estimates for advanced economies showed that exports for developed markets manufacturers iumped to 51.8, up from 50.8 in August one of the only sub-components to rise.

World trade has performed better than gross domestic product declines as "strong demand for Covid-related products has partially offset weakness elsewhere", it said. For example, in China, exports of goods such as personal protective equipment, medical products and electronics has accounted for roughly half of the 10 per cent year-on-year growth in exports in

Similarly, the International Institute of Finance suggests that trade across emerging markets is also starting to recover this month, according to an EM Growth Tracker report published earlier this month.

"August marks the first time since the Covid-19 shock with improving trade figures" across emerging markets, the report said. However, questions on the trade front remain with restrictions in place to contain the pandemic deemed a "drag on activity" and US-China trade tensions continuing to weigh on the trade outlook for emerging markets, it

The global economy will contract this year by more than 4 per cent, with an estimated swing of 6.8 percentage points leaving a shortfall in global output by the year end of more than \$6 trillion according to the United Nations Conference on Trade and Development.

Trade will shrink by around one-fifth this year, foreign direct investment by up to 40 per cent and remittances will drop by over \$100 billion, the UN agency said in its Trade and Development Report on September 22.

While the largest monthly increases in exports were in China and the US, China's exports had returned to their pre-virus levels, but exports from the US were still 13% below.

"We have collaborated with the University of Dar es Salaam to make sure that the ruling Chama Cha Mapinduzi's manifesto is well implemented this time around," he said adding that the world will see Tanzania have its electric vehicles made in Geita next vear hence supporting President John Magufuli's industrialization drive.

In remarks after the signing, UDSM's College of Engineering and Technology's Manager for Technology Development and Transfer Centre Engineer, Dr Simon Marandu said in 2019, Technology Development and Transfer Centre (TDTC) of CoET pioneered to develop an electric vehicle. TDTC started the design and sought funds to develop the prototype." TDTC could secure funds for developing the vehicle in a year," he

Eng Marandu added that in January this year, Geita Regional Commissioner, Eng. Robert Gabriel visited the university during which he met with CoET management under its Principal, Prof Bakari Mwinyiwiwa where plans

He further explained that the design of the two battery electric vehicles started in February, 2020 with one of them being for police patrolling with capacity of carrying two officers while the second one is for urban transportation with capacity of carrying five passengers, including the driver.

"The design of the two EVs has been

Kitchen gardens plan to cushion poor households

The government is in the process of setting up kitchen gardens for vulnerable households in 21 counties in an effort to avert a looming food crisis following adverse effects of Covid-19 pan-

The initiative being implemented by the Ministry of Agriculture targets to establish one million gardens according to the Cabinet Administrative Secretary Anne Nyaga. Already, 200,000 households have been covered in the first phase while the second phase to cover a similar number is currently ongoing.

Other than receiving a startup kit of a 50 litre tank and a shade net, each household will get 10gms seeds of various vegetables including amaranthus, kales, black nightshade, cowpeas and spinach. To showcase technologies available for the establishment of a kitchen garden, the CAS indicated that the ministry has set up a demonstration and learning site at the ministry headquarters at Kilimo House.

Currently, the learning site has 12 kitchen garden technologies that households can choose from. "We are appealing to households to visit the site and implement the kitchen garden concept to collectively contribute to food and nutrition security," she said. Some of the kitchen garden plans include multi-storey, micro garden, moist bed garden, tire garden, simple drip irrigation garden cone gardens, staircase gardens, hanging gardens and aquaponics.

The project being implemented in partnership with the Kenya Climate Smart Agriculture Project, National Agricultural and Rural Inclusive Growth Project and the Small-Scale Irrigation and Value Addition Project will closely work with counties to identify the beneficiaries.

He explained that corruption can make a good mediator or arbitrator compromise their positions and issue rulings in favour of their interested party hence worsening the conflict instead of solving it.

"Be it in areas of procurement or elsewhere, keep corruption out of your mercial disputes follow the forget about solving it but

guiding rules, otherwise you will not succeed," Eng Msita advised the participants of the NCC course.

rather expect to extend it due to the unfair decision made."

Adv Mbwambo further added that mediators and arbitrators should consider the key role that they have in improving the country's economy hence should stick to mediation rules which are aimed at solving p commercial disputes in a manner that conflicting parties appreciate.

"There is no need for a mediator or an arbitrator to prolong disputes for any reason hence the need to be fair, follow rules and solve the conflict in a manner accepted by the conflicting

parties," Adv Mbwambo noted. The course which was the 14th to be conducted by NCC, was geared towards empowering participants from different professions with skills to resolve commercial disputes by alternative resolution mechanisms other than courts of law.

Profits of China's industrial firms rise for fourth straight month

BEIJING

rofits at China's ndustrial firms fourth month in August, buoyed in part by a rebound in commodities prices and equipment manufacturing, the statistics bureau said on Sunday.

China's recovery has been gaining momentum as pentup demand, government stimulus and surprisingly resilient exports propel a rebound. Industrial firm profits grew 19.1 per cent year-on-year in August to 612.81 billion yuan (\$89.8bn), the statistics bureau said.

per cent increase in July and is the fourth straight month of profit growth. However, industrial firms' profits still face external pressures as rising tensions between

cloud the global trade outlook.

manufacturing profits increased by 32.5 per cent in August, up from 14.7 per cent in July, according to Zhu Hong, an official at the statistics bureau. This was driven in part by a rebound in the prices of international commodities such as crude oil and iron ore, he added. Meanwhile, profits of the general equipment manufacturing sector rose 37 per cent in August from the same period last year, with electrical machinery up by 13.3 per cent over the same period.

indicators Economic That compares with a 19.6 in August, ranging from exports to producer prices and factory output, all pointed to a further pickup in the industrial sector. However, factory activity grew at a slower pace with Washington and Beijing smaller firms facing sluggish

market demand and financial strain.

The country has introduced a slew of measures to kick-start the economy, from tax and fee reductions to grace periods for the calling in of debt. China's economy may stagnate if it fails to lift the value chain, as it faces increasing competition from countries with advanced technologies and lower labour costs, economists warned.

Authorities have pledged to boost investment in strategic industries including core tech sectors such as 5G, artificial intelligence and semiconductors, and accelerate new material development to ensure stable supply chains.

For the January to August period, industrial firms' profits fell 4.4 per cent from a year earlier to 3.72tn yuan. Liabilities at industrial firms rose 6.6 per cent -vear-on-vear at the end of August, edging higher than the 6.5 per cent at the end of July.

Earnings at state-owned industrial firms were down 17 per cent on an annual basis for the first eight months of the year, versus a 23.5 per cent decline in the first seven months. Private-sector profits fell 3.3 per cent in the January to August period, narrowing from January-July period's 5.3

Rich Americans plow their fortunes into European soccer bargains

NEW YORK

Kyle Krause, whose family fortune was built on the Kum & Go convenience store chain in the midwestern US, agreed Friday to acquire control of Italy's Parma. The move came just weeks after billionaire Dan Friedkin, owner of a network of Toyota dealerships, bought rival team Roma in a 591 million-euro (\$693 million) deal.

The last 18 months have also seen American takeovers of Italy's ACF Fiorentina and France's Toulouse FC. Driving this flurry of deals is a belief that European soccer offers better value than US sports, according to Pacific Media Group co-founder Paul Conway, whose firm owns teams on the continent. "Investing in American sports is very expensive and at high valuations," Conway said, noting that professional baseball and basketball teams in the US fetch at least \$1 billion.

Another US investor attracted by the European game is Joseph DaGrosa, who's in talks to purchase English Premier League team Southampton, according to a person with knowledge of the matter. The team's owner, Chinese businessman Gao Jisheng, is seeking about 200 million pounds (\$256 million), said this person, asking not to be identified discussing confidential information.

Gao's investment vehicle, Lander Holdings Ltd., didn't respond to an email and phone calls seeking comment. A representative for DaGrosa said he is looking at various teams across different leagues, declining to comment on any specific targets.

Americans now hold major stakes in about one-fifth of the 60 teams playing across the top soccer leagues in the UK, Italy and

France, according to consultancy KPMG. Their presence is made conspicuous by the retreat of Chinese investors, who in recent years bought teams including Aston Villa, Wolverhampton Wanderers and West Bromwich Albion.

"Chinese investment effectively dried up after its government proposed a more inwardly focused sports investment strategy," said Michael Broughton, an adviser at Acceleration Equity, a fund investing in sports teams. "The vacuum has been principally filled by US investors who see value in European football."

Platform model

DaGrosa wants to emulate the model of Abu Dhabi's City Football Group Ltd., which owns stakes in 10 teams including Manchester City and achieved a valuation of nearly \$5 billion following an investment by US private equity firm Silver Lake Partners last year.

'There's nothing better" than the English Premier League, DaGrosa said in a phone interview earlier this year. "We want to create a football platform that can go public and attract institutional investors and get a multibillion valuation."

More deals could be on the way. American media entrepreneur Henry Mauriss was earlier this year weighing a bid for England's Newcastle United F.C., which is back in play following the collapse of its planned takeover by a Saudi-led consortium.

Meanwhile, U.S. buyout firms including Advent International and Bain Capital are competing to invest in Italy's top league. Bull Horn Holdings Corp., a new blank-check company listing in New York, plans to seek acquisitions in the sports and media industries and has highlighted the relative value offered by European teams.

The coronavirus pandemic has weighed on sports teams, which are losing revenue from empty stadiums and reduced broadcast payments. That hasn't deterred the new crop of American investors, and may have even encouraged some deals by offering lower valuations.

"We made this acquisition knowing that the pandemic was ongoing," Krause, the new owner of Parma, said by email. "We can figure out how we can be as successful as possible in spite of it, and plan for the long-term future when we are beyond it."

RedBird Capital Partners, started by former Goldman Sachs Group Inc. partner Gerry Cardinale, bought a majority stake in French second-division team Toulouse in July. That's after games were suspended in March due to Covid-19. "If you believe in sport and care about it, this will be just a moment in time," said Alec Scheiner, a partner at the \$4 billion US investment firm. "I have no doubt that, in time, sport will return to exactly where it was."

Trump nominates Barrett for US **Supreme Court**

WASHINGTON

US President Donald Trump announced on Saturday that he is nominating Amy Coney Barrett, a conservative federal appellate judge, for the Supreme Court.

"She is a woman of unparalleled achievement, towering intellect, sterling credentials, and unyielding loyalty to the Constitution," Trump said of Barrett from the White House Rose Garden.

"This should be a straightforward and prompt confirmation," he said, while calling for a "respectful and dignified" process for the Supreme Court nomi-

Barrett, who sits on the bench of Chicago-based US Court of Appeals for the 7th Circuit, said that she has "no illusions that the road ahead of me will be easy, either for the short term or the long haul.'

"I assure you that I will meet the challenge with both humility and courage," she continued. "If confirmed, I would not assume that role for the sake of those in my own circle, and certainly not for my own sake, I would assume this role to serve you," she added.

Trump selected Barrett to fill the seat vacated by the death of Justice Ruth Bader Ginsburg, a leading liberal voice on the country's highest court.

Barrett, if confirmed by the Senate, would give the conservative wing a solid

6-3 majority at the Supreme Court. At age 48, she would also be the youngest member of the nine-justice bench and likely serve for decades to come.

Republicans, who enjoy a 53-47 advantage in the Senate, appear to have enough votes to approve Trump's third Supreme Court pick and they intend to hold a confirmation vote before the November election with an eye to energizing the conservative base. Only two Republican senators have said they would not support taking up a nominee prior to Election Day.

Democrats oppose moving forward with a vote on Ginsburg's replacement so close to the election, citing Senate Majority Leader Mitch McConnell's decision in 2016 to block then-US President Barack Obama's Supreme Court nominee because it was an election year, which all but ensures a fierce confirmation battle on Capitol Hill in the coming weeks.

McConnell and Senate Republicans have argued that this time is different because the Senate and the White House are held by the same party.

In a statement on Saturday, McConnell, a Kentucky Republican, said that he looks forward to meeting with Barrett next week, adding that the nomination will receive a vote on the Senate floor in the weeks ahead.

The Senate Judiciary Committee reportedly plans to start the official process to confirm Barrett on Oct 12, which includes hearings, with a full chamber vote tentatively set for the week of Oct 26.

Senate Minority Leader Chuck Schumer said he "will strongly oppose this nomination," calling it "shameless" efforts to replace Ginsburg less than 40 days before the election.

"This reprehensible power grab is cynical attack on the legitimacy of the Court," the New York Democrat wrote in a statement.

A mother of seven, Barrett was nominated by Trump for the US Court of Appeals for the 7th Circuit in 2017 and was later confirmed by the Republican-led Senate with a 55-43 bipartisan vote.

The jurist previously served on the faculty of the Notre Dame Law School, teaching on constitutional law, federal courts, and statutory interpretation. Prior to that, she clerked for Judge Laurence Silberman of the US Court of Appeals for the DC Circuit and for Associate Justice Antonin Scalia of the US Supreme Court.

Barrett, who earned her bachelor's degree from Rhodes College in 1994 and her J.D. from Notre Dame Law School in 1997, also litigated constitutional, criminal, and commercial cases in both trial and appellate courts as an associate at a Washington, D.C.-based law firm.

Trump's announcement on Saturday came a day after Ginsburg became the first woman to lie in state at the US Capitol. She will be laid to rest at Arlington National Cemetery across the Potomac River from Washington, DC

A renowned champion of women's rights, Ginsburg died last week at the age of 87 due to complications related to metastatic pancreas cancer. She was appointed to the Supreme Court by then-U.S. President Bill Clinton in 1993 and was the second woman appointed to the high court.

"My most fervent wish is that I will not be replaced until a new president is installed," Ginsburg reportedly dictated to her granddaughter Clara Spera a few days before her death.

Trump recently suggested that it was Democratic politicians who wrote Ginsburg's dying wish, a claim that critics have called baseless. The president and the justice had traded barbs since mid-2016, when he was the presumptive Republican presidential nominee.

Trump successfully appointed two conservatives on the Supreme Court, Neil Gorsuch in 2017 and Brett Kavanaugh in 2018, tilting it to the right with 5-4 majority.

US Supreme Court justices, who have life tenure and can serve until they die, resign, retire, or are impeached and removed from office, play an enormous role in shaping the country's legislation and policies on issues such as abortion, LGBT rights, gun rights, health care, climate change, and presidential powers.

China's education system withstands test of history with 242 million students returning to campus - MOE

A TOTAL of 242 million students in China from kindergarten children to college students have returned to school as of Friday, accounting for 90 percent of China's total students, showing that China's education system has withstood a major test of history amid the COVID-19 pandemic, according to the Ministry of Education.

It also marked the beginning of a safe, normal and full fall semester, Xu Mei, spokesperson of the ministry, said at Tuesday's press conference. In addition, the last batch of students will resume school after the National Day holiday in early October, Xu said.

In the next step, we will consolidate the hard-won achievements and continue to do a good job in education and teaching amid regular COVID-19 epidemic prevention and control measures, Xu said.

Chinese students have been flocking back to campuses in different batches, with control measures such as partial campus seal-offs, carrying out large lectures online and reducing group activities. Beijing universities requested that freshmen report their health situation 14 days ahead of classes, submit negative nucleic acid test results, and obtain a green code to enter the campus.

In comparison with Chinese schools, which welcomed the return of students eight months after the COVID-19 pandemic first hit China, universities in the US have gone back to online courses and canceled their tests, after an increasing number of confirmed cases involving students were reported since schools reopened in mid-August.

At UN, PMs, foreign ministers vow to resist unilateralism

UNITED NATIONS

PRIME ministers and foreign ministers on Saturday vowed to uphold the principles and purposes of the Charter of the United Nations and resist unilateralism through their pre-recorded speeches addressed to the ongoing 75th session of the UN General Assembly.

OVID-19 threatens gender equality gains - UN Women chief

UNITED NATIONS

UN undersecretary-general and executive director of UN Women, Mlambo-Ngcuka, has called for action to carry forward gender equality and prevent a reversal of hardwon progress because of COVID-19.

Exactly 25 years after the Fourth World Conference on Women in Beijing, the significance of the Beijing Declaration and Platform for Action is undimmed, she said in an exclusive written interview prior to a high-level UN meeting on the 25th anniversary of the Beijing Conference.

The outcome of the 1995 conference remains the most comprehensive and transformative global

agenda for the achievement of gender equality and the empowerment of women and girls, she said.

Despite challenges, in the last quarter-century, countries in all regions have shown that change is possible, she said.

"We have seen the strength and the impact of collective activism grow and underline the importance of multilateralism and partnership. With laws to support women's equality, scaling up education, health and childcare services, and using gender quotas to boost women's representation, the world has found common solutions to shared problems."

However, progress for women in

many areas has been unacceptably slow and the social and economic impacts of the COVID-19 pandemic threaten to reverse many of the hard-won advances made, said Mlambo-Ngcuka (pictured).

Violence against women continues unabated. Men still hold more than 70 percent of parliamentary seats, managerial positions, climate negotiators posts and represent almost all peace negotiators.

In addition, due to persisting inequalities such as women's uneven access to paid work, it is estimated that without change, 47 million women and girls will be pushed into extreme poverty in 2021, bringing the total to 435 million with women



between the ages of 25 to 34 especially affected, she noted.

Mlambo-Ngcuka named "four important catalysts" to ensure that

progress is accelerated.

First, supporting women's move-

ments and leadership. This includes women in decision-making at all levels and a safe and enabling environment for civil society organizations.

Second, harnessing technology for gender equality. This includes closing the gender digital divide and ensuring that women have access to the digital economy.

Third, ensuring that no woman is left behind - by empowering and guaranteeing the rights of those who have been pushed to the margins by decades of structural discrimination, and ending all forms of violence against women, including cyber violence.

"In 1995, the Beijing Conference raised attention to global issues that

remain urgent today. Stepping up to this legacy, we must build back better, bringing women right into decision-making, and instituting the structural changes that intentionally enable this," she said.

A key to success is to support and promote the leadership of young people, she said.

UN Women has launched "Generation Equality" to mark this 25th anniversary and to engage young women and men in support of gender equality, in the hope that this process will mobilize and energize the world, in the same way that the Beijing Conference did, to create a clear path forward for the achievement of gender equality by 2030,

said Mlambo-Ngcuka.

As UN Women celebrates its 10th anniversary amid the COVID-19 pandemic, the human rights of women and girls have more prominence, universality and more urgency than ever before, she said.

"We have been working to demonstrate the central role women can play in economic and social recovery, and to raise the alert on the dangers of failing to do so. We are proud to be the global champion and ally for women and girls. We are 10 years strong and ready for the next 10 years in the UN's Decade of Action (on the Sustainable Development Goals)," she said.

warrants for disappearance of 43 college students

MEXICO CITY

MEXICAN authorities have issued dozens of arrest warrants for police and soldiers whom they believe may have participated in the 2014 disappearance of 43 Mexican college students, head of the investigation said on Saturday.

Omar Gomez, head of the special prosecutor's office for the case, told a new conference in Mexico City the warrants had been issued for the "material and intellectual authors" of the crime, including military members, and federal and municipal police.

The announcement came during a news conference at the National Palace in Mexico City on the sixth anniversary of the students' kidnapping. During the event, Mexican President Andres Manuel Lopez Obrador and Mexico's Undersecretary of Human Rights Alejandro Encinas held fabrics embroidered by relatives of the victims, many of whom attended the ceremony holding large pictures of the disappeared

Saturday marks the first time in the case Mexican authorities have announced arrest warrants for military personnel. Reuters reported earlier in the week that arrest warrants were im-

The Mexican military did not respond to initial requests for comment.

The students from the Ayotzinapa Rural Teachers' College disappeared on September 26, 2014, in the state of Guerrero. The remains of only two of the students have been positively identified so

The unsolved kidnapping of the young men who were training to be teachers convulsed the country, sparking massive protests in 2014 and garnering international condemnation as one of the darkest examples of the government's longstanding difficulty preventing violence or convicting those responsible.

Photovoltaic power stations in NW China's Qinghai province help local villagers secure livelihood

LOCATED on plateau and boasting rich solar energy resources, northwest China's Qinghai province has seized the opportunities generated by favorable policies and vigorously integrated the development of the photovoltaic (PV) industry into its poverty alleviation endeavors, lifting impoverished local residents out of poverty and facilitating steady growth in their in-

So far, the total installed capacity of poverty-relief PV power projects built across the province has reached 731.600 kilowatts, and the annual power generation output value of these projects is expected to reach 880 million yuan (about \$130 million).

These PV power projects have generated 570 million yuan for poverty alleviation, helping secure livelihood for 283,000 poor people from 77,000 local households, accounting for 52.5 percent of the province's poor popula-

"Our life is really good now," said Lhage Gya, a 56-year-old resident in Tibetan autonomous prefecture of Hainan, Qinghai province, who has benefited from the PV power projects a lot.

"I used to live in a shabby adobe house in the mountains and barely had a decent piece

of furniture," he said, adding that he needed to fetch drinking water from more than one kilometer away and his family could hardly make ends meet by raising cattle and sheep as the grass didn't grow well.

The man is now living in a cozy home with Tibetan-style couches and a side-by-side re-

In response to the call of the government, Lhage Gya's family moved to Qiezha village, Niandi township of Gonghe county, Tibetan autonomous prefecture of Hainan, in August 2017, and has gradually become better off ever since.

"Last year, I made over 35,000 yuan, including my wages, subsidies from the prohibition of grazing on grassland, as well as the dividends from the PV power projects," said Lhage Gya.

"The village-level PV power stations have guaranteed a stable source of income for local villagers," noted an official in Niandi township, explaining that 60 percent of the income from the power stations is used to develop collective economy in the village while the rest 40 percent is used to pay salaries of villagers on

public welfare jobs. The village has built hotels, shops and restaurants along national highways near the village in a bid to stimulate tourism, the official said, adding that the effort has helped villagers secure jobs near their

homes and gradually shake off

The PV power stations of Qiezha village are located in a poverty alleviation PV power station industrial park in Tibetan autonomous prefecture

The blue PV panels extending all the way to the foot of the faraway mountains on the green grasslands look spectacular like sparkling sea under the blue sky and white clouds.

The industrial park consists of five county-level PV power stations and 11 village-level stations, according to Dai Helou, chairman of a poverty alleviation and development company in Tibetan autonomous prefecture of Hainan.

As of the end of July, the industrial park had generated 133 million kilowatt-hours of electricity accumulatively, bringing nearly 100 million yuan in revenue to the locality, Dai said.

The income from each village-level PV power station is shared by several poverty-stricken villages, Dai disclosed, adding that these PV power stations have helped increase the income of the 173 poverty-stricken villages across the prefecture by an average of more than 570,000 yuan each.

French minister: Paris stabbing attack an act of terrorism

PARIS

THE stabbing attack in Paris on Friday near the former offices of the satirical magazine Charlie Hebdo was "clearly an act of Islamist terrorism," said French Interior Minister Gerald Darmanin.

"It is clearly an act of Islamist terrorism," Darmanin told France 2 TV channel. "This is the street where there was Charlie Hebdo. It is the operating method of Islamist terrorists, of course, evidently, there is little doubt," he added.

France's National Anti-Terrorist Prosecutor's Office said an investigation was opened for "attempted assassination in connection with a terrorist enterprise" after the attack that left two people injured.

A man armed with a meat cleaver attacked and wounded two people on Friday who had stepped out for a cigarette in front of the Paris office building where Islamist militants gunned down employees of satirical magazine Charlie Hebdo five years ago.

Police soon after detained the man suspected of carrying out the attack, with bloodstains on his clothes, next to the steps of an opera house about 500 meters away.

The suspected attacker was from Pakistan, and had arrived in France three years ago as an

A second man, aged 33 and suspected of being linked to the attack, was arrested by the Railway Network Brigade at 1:30 pm in the Paris metro, officials said.

Five more people were taken into custody as part of the investigation, bringing to seven the number of people held in police custody in this case, reported local channel BFM TV.

"We are still in a war against Islamist terrorism," Darmanin said in a Twitter post.

He said he had ordered law enforcement agents to beef up protection at all sites where Islamist attacks had taken place in the past, and at synagogues, where the city's Jewish community this weekend mark the Yom Kippur holiday.

The victims of Friday's attack were taken to hospital but their lives were not in danger, officials

The attack coincided with the start this month of the trial of 14 alleged accomplices in the 2015 Charlie Hebdo attack. The gunmen behind that attack killed 12 people.

Investigators said the militants at that time wanted to avenge the publication of cartoons depicting the Prophet Mohammad in the magazine. Charlie Hebdo republished the cartoons on the eve of the trial this month.

BRI a functional machinery in global economic recovery - Sri Lankan expert

THE continuation of protectionism by America, the largest economy body in the world, will only result in further contraction of the world economy and aggravation of unemployment, poverty and deprivation, said Luxman Siriwardena, president of the Sri Lanka-based Pathfinder

In a recent interview with People's Daily Online, Siriwardena said that the unilateralism and protectionism currently being championed by the American administration goes against the values the West has promoted since the end of World War II.

"When I was undertaking graduate studies at an American university in

Widening circle of athletics stakeholders a welcome development, at last

ATHLETICS Tanzania (AT) has finally managed to hold the National Athletics Championships that had for a period been gathering dust, with a broad range of observers taking that tendency as indicative of incapacity at organizational and financial level to do better.

Nothing really changed by the fact of holding the championships earlier this month, with regard to the country's level of performance or range of abilities, except that the heart of athletics here is still

It can thus be expected that coordinated efforts leading to holding the championships this year can solidify.

Press reports said that this year's event was jointly organised by the National Sports Council (NSC), the Tanzania Olympic Committee (TOC) and AT, where it was noticeably the first time in five years that this event had taken place.

The newly found success in orgnisation raises hopes that the momentum will not be lost, perhaps translate into more regular lower level competitions especially at school and regional level.

Youths seeing the chance to participate at district or regional events would put an effort, as athletics starts in lower schooling.

The latest event brought together upwards of 200 athletes from 28 regions, having been twice rescheduled, first to August from May, and then shifted to September as preparations like accommodation were as yet inadequate.

It is so far unclear if there was an outside push that helped to galvanise preparations for this year's tournament, as there is scant local reason why this year would be better for AT finances than it was previously.

There is an impression of some sort of regard from outside as to this requirement, for instance to sustain global membership,

The AT officials said that World Athletics Council, the umbrella global body grouping fairly distinctive gatherings with the same abbreviation, the International Amateur Athletics Federation and the International Association of Athletics Federations (IAAF), had directed that members conduct National Championships not later than

It appeared that the reason for this extended instruction to all federations or national associations was the disharmony arising from the global pandemic.

But here it may have rung a different bell, that they know we do not have the tournament.

This kind of impression could predictably have sent top officials at AT and other agencies helter skelter to tie up arrangements for the tournament, so to de-registration for failure to live up to year is daunting. Seeing is believing! membership requirements.

That could explain why this year's National Championships secured support from the Tanzania Olympic Committee (TOC), after the AT requested the committee to assist the facilitation of the two-day championships.

This body was always aware of the startling lack of resources at AT and scarcely moved a finger till now.

Traditionally TOC would take up preparations for an Olympic Games squad after the various national associations had presented a list of athletes qualifying for this or that event.

It did not usually oblige in assisting with financing of tournaments that help to pick eligible or potential qualifiers for the next Games, as each year up to another Olympics, All Africa Games or the Commonwealth Games ought to be a preparatory year.

This factum was not moving anyone there, as it appeared purely an administrative issue, that AT gets athletes and forward the

So it will not be part of history that it took a global pandemic and disarray at IAAF as to what is the state of athletics preparations around the world to send such a reminder, so that athletics bodies here get out of

It appeared to them that the message was singularly for Tanzania as a country that held no championships for four years in a row and was obviously going to chalk up another year in that slumber, until IAAF reminded the former athletes now in top offices that results of their championships ought to be filed by 10th September. It is what got them working.

The AT officials explained that TOC helped to facilitate the championships with support from another activist athletics group, Olympic Solidarity (OS) and the Association of National Olympic Committees of Africa (ANOCA).

Since there are improved communications of a personal and direct sort, or group networking arrangements for instance in mobile phone applications like WhatsApp, it is not entirely clear why these groups suddenly discovered it was vital to get an athletics tournament underway in Tanzania this time round.

Was it because of Covid-19 that it was not difficult to elicit attention of potential stakeholders like these, or because TOC

Chances are that Covid-19 must have been part of the gamble as earlier not just TOC but also the ministry would scarcely take up appeals for assistance from AT or kindred organizations, left to fend for themselves whereas it is incomprehensible how athletics can be commercialized.

Arsenal face acid test of Arteta revolution at Anfield LONDON Arteta "changed the mood" Premier League.

around Arsenal, according to Liverpool boss Jurgen Klopp with the Gunners rejuvenated by winning the FA Cup, Community Shield and their opening two games of the Premier League season.

However, the toughest test of what Arsenal can aim for this season comes on Monday with a trip to Anfield, where Klopp's men have not lost in 60 league games.

Arteta described Liverpool's home as the "toughest place in the world" to go, but Arsenal can take confidence from two victories over the Premier League champions in the past three months.

Trent Alexander-Arnold v Pierre-**Emerick Aubamevang**

Aubameyang has been the key figure in Arsenal's revival, scoring twice in the FA Cup semi-finals and final to defeat Manchester City and Chelsea and his side's goal plus the winning penalty in the shootout against Liverpool in the Community Shield.

Arteta has followed Klopp's example by using his biggest goal threat cutting in from a wide area and Aubameyang will look to exploit the space left by Alexander-Arnold as he marauds forward

"With the speed they have for the counter-attack, that can cause you some trouble," warned Klopp.

However, Liverpool could just as easily benefit from one of the league's most creative players in Alexander-Arnold not being tracked by Aubameyang.

A minor injury meant he missed the Community Shield and Aubameyang made the most of his absence against the inexperienced Neco Williams.

An injury to Jordan Henderson means Thiago is likely to make his first start on Monday and Xhaka has the unenviable task of stopping him dictating the game.

The turnaround in the Swiss international's Arsenal career is symptomatic of the changes since Arteta's arrival.

Seemingly on his way out of the club after tearing off the armband and swearing at his own supporters when substituted against Crystal Palace just less than a year ago, Xhaka has rehabilitated his reputation among the Arsenal support by

The Scotland international is perfectly suited to his role as the left centre-back of Arteta's three-man defence, where he can also push into a more advanced role when in possession, like he did for Celtic prior to his £25 million (\$32 million) move to the Premier League.

So far a strict system of testing has kept the number of cases in the English top-flight low even as Britain faces a second wave of Covid-19.

West Ham boss David Moyes and players Issa Diop and Josh Cullen tested positive this week, while Ilkay Gundogan became the third Manchester City player to return a positive test this month.

But no Premier League game, all taking place behind closed doors, has so far been postponed since last season resumed in June.

Clubs are set to lose their players during next month's international window, which includes European Championship and South American World Cup qualifiers.

Top clubs reportedly held talks with world governing body FIFA this week over the next two international windows, in October and November.

Concerns are growing that players will be at greater risk of contracting the virus as they criss-cross the globe to represent their countries or being forced into periods of quarantine when they return to their clubs.

Arteta, who tested positive for Covid-19 days before the 2019/20 season was put on hold in March, said he had his "fingers crossed".

"We have a system that works, that has created a positive, really, really low across the league," said the Arsenal boss.

"Obviously when everybody starts to fly away to very different countries I think at the moment is a little bit of an experience and we don't know what the outcome is.

Messi and Barcelona: The inside story on how everything fell apart, and what's next - Part 2

THE mechanism by which they thought they could pull off a deal had existed for years. Messi's longterm doubts led his advisers to insert a release clause in his Barca contract when it was renewed in 2017. At the end of the 2019-20 season, within a defined period, he could unilaterally rescind his contract and walk away.

And so, Barcelona's board nervously waited. In the end, the date -- initially widely reported as May 31, later corrected to June 10 -- fell when La Liga was about to resume. Nonetheless, when it had passed, the club were quick to brief the media. As far as they were concerned, Messi would be staying until 2021. Messi has since said he didn't inform the club before then because they were still involved in La Liga and the Champions League; one source, though, says the fact City were banned from European football before winning an appeal also complicated his route out of Camp Nou.

The original date in Messi's contract had been drawn up to coincide with the end of the season. But with the campaign extended because of the coronavirus pandemic, Messi's camp felt they had some wiggle room when it came to the interpretation of the clause.

Sources told ESPN that the feedback Messi received from legal experts was mixed. Only one law firm out of at least four consulted, Cuatrecasas, believed the argument had a realistic chance of success. That was enough and Messi decided to go ahead. If he stood his ground, perhaps Barca would blink first.

AUG. 24 BEGAN WITH A PHONE CALL from Koeman to Suarez.
