Tanzania, DRC to focus on JCC, security

ANZANIA and the Democratic Republic of Congo (DRC) have agreed to step up collaboration in transport, security and infrastructure.

The leaders of the two countries held a joint press conference yesterday where President Samia Suluhu Hassan said the two nations have agreed to revive the Joint Commission for Cooperation (JCC), non-operational for the past two decades.

Key areas the two countries agreed to work on include extending the standard gauge railway (SGR) and intensifying links the financial sector,

Tanzania was reviving MV Sangara to improve transport in Lake Tanganyika, easing the movement of goods and services and improve trade between the two countries, she said.

Tanzania was also working on promoting private sector links as Tanzanian banks already operate in DRC, while uplifting measures to address food shortages that threaten to rock the world in the future, she stated.

Other agreements relate to Air Tanzania Co. Ltd (ATCL) which flies to just one city in DRC, expected to extend the range of flights in the country, she





ny of the high-level forum of women leaders, its 2022 edition, organized by the Organisation of African First Ladies Against HIV/AIDS (OAFLAD) that Burundi hosted at the weekend.

OAFLAD is the Organization of African First Ladies for Development (OAFLAD) established in 2002, where first ladies created the forum as a united voice for Africa's most susceptible citizens.

It is an advocacy organisation where first ladies seek to leverage their unique position to spur health services accessibility and law reform to boost women and youth

empowerment. Burundi launched the zero malnutrition campaign in October 2020 to improve the well-being of the Burundian population, the Burundian leader said, noting that it involves the mobilization of mothers to

vaccinate their children. The conference was held in a week dedicated to mother and child health since 2002, such that at present most newborn babies are vaccinated in hospital.

He also spoke about an awareness campaign on disease prevention and the promotion of the right nutritional practices. Supporting the school feeding program and curbing or managing obstetric fistula are also included.

The campaigns and actions are geared at using various levers and forums to motivate all sections of the population to play their role in promoting maternal and child health and engaging in the fight against malnutrition.

Host first lady Angelina Ndayishimiye said the theme for this year was 'the health and nutrition of women, newborns, children and adolescents,' to enable exchange, reflection and commitment to resilient and sustainable means and actions to improve the health and nutrition of women, children and adolescents. This requires the involvement of women leaders towards achieving the third goal of the sustainable development goals, she added.

Port manager Masoud Mrisha said they received the report on the blaze at around 2:30 am from the port's senior security officer and proceeded to the area. They saw fire engulfing the warehouse which was handed to the TRA for storing seized goods and those awaiting duty

payment or already forfeited, he stated. The port authorities in turn reported the incident to relevant state organs, he said, affirming that as for now the issue has been left with the regional defence and security committee. On October 2, a consignment of sugar and edible oil smuggled in via

the Kasera informal port facility near Tanga was reportedly scuttled away before TRA officials or the police arrived. RC Mgumba said at the time that the goods were removed a short time after arriving at the port, with dhows bringing the goods to the port subsequently abandoned.

The suspected murderer, James Gomes, 47, who was described by local TV stations as a serial criminal who has allegedly spent more than half of his life in prison, is said to have been released recently after serving time in jail for other criminal violations.

A local TV in Raleigh, ABC 11, described the deceased as, "mother, wife, sister, cousin and a psychiatric nurse practitioner, Jane Onkundi was the epitome of love, taken too soon while doing exactly what she loved."

them to operate.

Ministry of Health signs MoU with Egypt's Alameda healthcare group

THE Egyptian-based Alameda Healthcare Group has signed a Memorandum of Understanding (MoU) with the Ministry of Health that is designed to set up a second opinion centre, support and train healthcare professionals in their areas of expertise.

The signed MoU includes conducting surgical camps in various hospitals and treating patients for complex cases like transplants in Cairo.

The signing ceremony of the MoU was held in Dodoma over the weekend and was witnessed by the Permanent Secretary in the Min-

istry of Health Prof Abel Makubi, Alameda Healthcare Group Chief Executive Officer Neeraj Mishra and Alameda healthcare group International Business Development, Dr Amira Hamouda.

Mishra, Alameda Healthcare Group CEO said: "It's a momentous occasion to collaborate with the ministry in improving healthcare services in Tanzania. Under this agreement, we shall conduct surgical camps in areas of cardiac surgery, kidney transplantation, neurosurgery and orthopedics. We shall also set up a second opinion centre in Cairo to support the young clinicians in local hospitals to take advice from senior clini-

istry of Health Prof Abel Makubi, cians working in Alameda Hospi-

Mishra added: "We shall also train the doctors and nurses under observer ship program in our hospitals. Patients who cannot be treated in the country shall be referred to us through the National Health Insurance Fund (NHIF)"

"Alameda Healthcare will also be tasked with receiving nursing and midwifery experts to build capacity to the counterpart in improving care, quality and managing hospitals resources to ensure quality services", said Mishra.

Dr Amira Hamouda - Group Director of International Business Development said: "This has been a long-awaited agreement and will be bringing expertise from Alameda healthcare in Egypt to Tanzania, helping Tanzania become the medical hub for East Africa."

Dr Hamouda stated that in addition to the above MoU, Alameda Healthcare already has an ongoing MoU with Jakaya Kikwete Cardiac Institute and Muhimbili National Hospital (MNH) and has conducted the first cardiac surgery camp in September.

The Ministry's Permanent Secretary, Prof Abel Makubi said the signed MoU will strengthen relations in the provision of training to health workers especially those offering specialized medical treat-

ment.

He said more than 20 medical experts from Tanzania will benefit from the pieces of training at a low cost every year.

"Through exchange programs, our medical experts will have the opportunity to study abroad while experts from other countries will also come and work at our health facilities," he said.

He said the cooperation will also include collaborating in the control of epidemic diseases at the borders, research on medicine as well as prevention and strengthening of digital medical services through Information and Communication Technology (ICT).

The PS noted that Tanzania will also collaborate with the countries in the construction of drug manufacturing industries. He said plans are underway for the signing of other 15 agreements with a number of hospitals abroad.

"The Ministry of Health will continue to cooperate with the international community in managing and implementing its priorities and achieving goals set by the government," he said.

Prof Makubi said the ministry will continue to organize and collaborate with international communities for improved health services in the country.

GCLA donates 786 books on science laboratory chemicals to Tanga schools

THE Government Chemist Laboratory Authority (GCLA) has handed 786 science books and laboratory chemicals to secondary schools in Handeni District, Tanga Region, a move aimed to motivate more students to pursue science subjects.

Speaking at the handing over ceremony recently at Mkata secondary school, Handeni District Commissioner, Siriel Mchembe urged secondary school students to love pursuing science subjects to cope with the global science and technology revolution.

"We have received 786 sciences books and chemicals for our school laboratories from GCLA; their donation compliments the government efforts of ensuring more students love and pursue science subjects to cope with global advance change in technology,'

He said due to the fast development in science, parents, teachers and the community ought to emphasize and inculcate a culture in their children to love pursuing science subjects such as physics, biology, chemistry and mathematics to raise the standards of edu-

Mchembe said the initiative will also produce a large number of experts in science subjects such as doctors, engineers, geologists and teachers. He commended the government for constructing more laboratories including the construction of more than 77 classrooms to solve the shortage of science teachers as well as the recruitment of 40 teachers.

Chief Government Chemist, Dr Fidelice Mafumiko called on the students to use the books and chemical laboratories to improve their performance in science subjects by doing things practically. He noted that science and technology are among the core sources of development, hence the need to ensure more students pursue the subjects. Dr Mafumiko said the government recognizes the importance of science that's why it is constructing classrooms, employing science teachers and installing equipment at school labora-

"It is our hope that these books and chemicals will help the schools to improve student's performance in science subjects considering that the government has put much effort in investing in science and technology by ensuring the availability of teachers and other human resources," he said, adding that GCLA will continue to empower youth to enable them to realize their educational goals,"

Handeni District Education Officer, John Lupenza said that most of the secondary schools in the district are facing a shortage of teachers, laboratories and books, the thing that discourages students to pursue science subjects.

"We thank GCLA for the support. It is my hope that we can move forward adding that the items donated will enhance students' capacity and morality to study advising students to use the opportunity to pass their science subjects," he said.

Mozambique to become regional energy hub

THE director of Market Operations at Mozambique's utility company Electricidade de Mocambique (EDM), Luis Ganje, says that the government is mobilising investments to build new power-generating projects to meet the huge energy demand in the region.

Ganje, who was speaking to the press in Maputo on the sidelines of the 59th general meeting of the Southern African Power Pool (SAPP), said that a financial agreement, estimated at US\$5 billion for the implementation of the Mphanda Nkuwa hydroelectric project would be reached soon.

According to Ganje, the new hydroelectric facility on the Zambezi River, downstream from the Cahora Bassa dam (HCB) in the central province of Tete, will help to alleviate the regional energy deficit, currently estimated to be seven gigawatts.

He also pointed to the construction of a 563-kilometre-long new transmission power line between Temane and Maputo, and the implementation of the Tete-Maputo line, also known as the "backbone," which will make it possible to develop integrated electricity infrastructures to support the industrialisation of Mozambique and the region.

Ganje pointed out that "the energy deficit in the region is much greater than the existing capacity produced in Mozambique at the moment. Mozambique intends to become a power generation hub, not only to meet the demand for universal access by 2030 but also to meet the needs of the region".

"We have several projects underway. Naturally, it is a process that takes time, but we hope that by 2030, with the entry into operation of the Mphanda Nkuwa project, we will be able to provide a more robust response to regional needs", he added.

Students drilled on better ways to ease traffic congestion in Dar

FORTY youth have been empowered with skills on how to address traffic jams that prefab motorists and pedestrians in Tanzania's commercial capital Dar es Salaam.

The training on the best ways to use technology to address the vice has been possible by a Dar es Salaam-based non-governmental organisation-Ujuzi Tanzania's skills

The just-concluded threeday training brought on board male and female youth from primary, secondary schools and universities aged between 12 and 25.

Kai Maembe, Ujuzi forum executive director said in an interview over the weekend that the training was aimed at empowering young people with skills that will make them self-employed soon after completing school.

"The skills we give them are the ones needed in the labour market, as you know there is a lot of noise, many graduates are unemployed, so we teach them how to use technology to make changes in society," she said.

"For example, many roads in Dar es Salaam, especially in the morning and evening, have a problem with queues that cause people to be late

for production activities that have aimed for is that they contribute to the economic growth of the country and individuals."

Kai said that in recognition of the challenge, they have decided to build the capacity of young people by training them to come up with solutions using technology to create an application (APP) that people will use to get rid of queues.

"The important thing we

also start their own businesses, we give them education and in it, there is education on how to get capital, we teach them what to do to get capital," she said.

She also asked the government and other stakeholders to recognize the contribution given to the youth so that it has positive results within the community and the nation at

Kai stressed: "The training is sustainable and we're planning to reach young people in other regions including Arusha, Dodoma, Iringa and Zanzibar."

T-Marc Tanzania board member, Awaichi Mawalla, said they have decided to collaborate with UJUZI to provide the training opportunity to young people who will bring change to society and the nation.

Mawalla has called on parents to allow their children to learn technology instead of ending up using it as a catalyst for moral destruction.

"Here is an 11-year-old girl, her parents have decided that instead of staying at home, she should bring her to study and she has not remained silent, she contributes her thoughts, she knows how to use the internet properly to find educational matters.

"My visit top Portugal has been of great benefit as for the first time in the history of the two countries diplomatic relations, we have signed an agreement for cooperation on political issues with the hope of boosting relations in regard to various sectors for the benefit of the two countries," said Dr Tax.

She added that they have agreed with her Portuguese counterpart to put in place strategies in following up the implementation of various issues of cooperation that had been agreed.

Dr Tax also called upon Tanzanians to utilise the agreement signing in grabbing various opportunities available in Portugal including trade in commodities like coffee, tea, fish, spic-

Also, during their talks, Tanzania stressed the importance to work together with the European country at international platform especially in raising the voice for European countries to assist Tanzania and other African countries in general in fighting challenges stemming from the effects of climate change.

For his part, Portugal Foreign Minister Joao Gomes Cravinho thanked Dr Tax for accepting his invitation to visit his country and that Portugal values the diplomatic relations existing between the two countries.

He said he trusts that the signing of the important agreement should be a new start for the two countries' cooperation.

Stick to working with authorised postal, courier service providers, TCRA tells people

THE Tanzania Communications Regulatory Authority (TCRA) has urged the public to adhere to utilising registered postal services, including courier services, in order to ensure the safety of the letter ship-

Many people use local buses and vehicles to transport their various consignments to various destinations across the country.

The authority's postal services manager, Haruni Lemanya, stressed recently in Dar es Salaam that it is risky for anyone looking for postal services to enquire about and be served with such services by unregistered postal and courier service providers.

"Anyone using postal services in the country should be reminded that only registered courier services are authorised to carry and deliver packages or any other consignment that qualifies for shipping through postal service providers. Additionally, if an individual or business offering transportation services is not registered with TCRA, they are not allowed to transport any postal cargo," reminded Lemanya.

However, he emphasised that no one is entitled to compensation for mailing packages or cargo that is not authorised while highlighting the difficulty that a customer who had their parcels carried by an unregistered courier operator is likely to face because there is now a TCRA-mandated Postal Regulations that dictates how to compensate their customers in the event that the transported goods are lost or damaged.

The regulations even detail how insurance will protect those who ship packages through registered service providers, he added. "It is imperative that whenever you wish to mail a package, you choose a service provider who can guarantee that it will reach its destination," he said, adding that

the law prohibits unregistered service of receiving quality services. The Elecproviders from operating postal services in the country.

He reminded service providers that certain shipments are prohibited from being sent through standard mail and that it is imperative that service providers comply with this obligation, stating that such shipments must adhere to specific shipping procedures earmarked in the regulations.

"The advantage of utilising registered services includes the certainty tronic and Postal Communications Regulations (Quality of Services) stipulate that postal service licensees, including those offering package and parcel delivery services, are accountable for adhering to service quality criteria, "emphasised Lemanya.

Up until June of this year, the authority has registered more than ninety providers of postal services.

United Nations Day special, as worldwide crisis unfolds

of October as an important day in the United Nations calendar, as it marks the anniversary of the entry into force in 1945 of the United Nations Charter. It was thus the proper founding of the global organisation, the nearest the world has of a semblance of collective government, with the ratification of the founding document by most its signatories. The General Assembly serves as an informal world Parliament where everyone represents a constituency, big or small, and the Security Council can take punitive decisions

To many students of international relations, the UN has often been the punch bag for the proverbial 'toothless bulldog' of English literature, but in actual fact it makes a difference. It is a situation where all important sentiments concerning the world condition are made, without which the direction which countries would take becomes singularly unpredictable.

That hasn't stopped some horrendous things happening around the world but that is the quid pro quo of having the UN, that it provides a forum, not allowing any particular country to enact laws for all the rest.

Listening to what young people say when they participate in audience-engaging radio programmes, what theyo wish for is a more effective UN system rather than less of it. This feeling appears to pervading that it is evident that young people are singularly insistent on the UN taking action about this or that crisis, and wondering why nothing seems to be happening, why people are still suffering, etc. As a matter of fact, the UN can't stop people in a country wrecking it, for it basically has a mandate to help governments, not to teach

GLOBAL activists mark the 24th them what to do, as many would wish.

A UN chronicler notes that 24th of October has been celebrated as United Nations Day since 1948, and in 1971, the United Nations General Assembly recommended that the day be observed by member states as a public holiday. It appears there are ceremonies tied to that day but the idea of a public holiday would represent the idea of a world government, when the UN attained sovereign hold of all humanity. That might indeed be the dream but we are nowhere near that idealistic moment.

Africa has played its role, for better or for worse, in shaping up the global UN ethos over the past six decades since independence started becoming the norm in the early 1960s. Several moments of Africa's impact on world conscience can be mentioned or were intensely observed, the first being the struggle against apartheid - as the world moved to reject institutionalized racism as a legitimate political system. The demonstrations in Western capitals and finally in the United States especially as world television showed whipping of demonstrators in 1986, affected US midterm polls and it started distancing itself from the white minority regime.

The other moment was the catastrophic famine of 1974 which led to a worldwide cultural protest as why people are left to die while others look on, activism that helped shape the humanitarian vocation of UN agencies since the 1980s or earlier, But there is sad backdrop, from the death of the second UN Secretary General Dag Hammarskjold in Zambian airspace, over Ndola, in September 1961 trying to bring peace to Congo Leopoldville (later DRC).

Staples crucial for agro-sector resilience, in like manner as strategic export crops

SECTIONS of the agro-sector policy making community are buzzing with excitement following an agreement with Denmark and Sweden, key development partners for the government, to inject over 5bn/- in grants for crop development interventions targeting sunflowers, beans and pigeon peas. They are carefully selected crops having different profiles in the agro-sector landscape, as one is for edible oil production mainly for the local market, another is a staple legume and the last a latter day rising export crop. There are Asian markets opening wide for it.

How far this reflects all the effort or initiative possible from the Agricultural Markets Development Trust (AMDT), can't be said, but there is no doubt that this initiative, arising largely from the private sector, is an excellent input to broadening crop policy and underlying some potential success areas. A project approach for key crops is like contract farming for regular crops, and its mere presence is a sign of assurance that nothing will go wrong. The issue is how far that sort of approach can be applied to other crop value chains as what matters isn't the amounts of cash involved but clarity of ideas and readiness of key stakeholders.

Officials said that the current plant for two vital agricultural value chains starting this farming season target upwards of 100,000 smallholder farmers. In terms of the total farming population could appear to be a drop in the sea, but when one thinks

of the project as a best practices class, the impact is far and wide. Again, even as initial development partner grants can't be extended, assurance of following best practices in a crop or within a district can conceivably facilitate local credit lines.

So there will be a time to wait to see the wider impact of the project especially in the best practices aspect but also in the construction of some vital infrastructure for particular crops. which could have additional usage on a seasonal basis, as the case may be. The projected funding will propel nine market development projects in the two crops farming model in 11 regions across the Mainland under the lead role of private sector organisations via capacity building grants. This kind of networking is another unexplored area in what can be done in each district, especially as climate change impacts affect regions unequally and often a dramatic fashion.

Evidently the need for climate smart agricultural practices and technologies cannot be overemphasized for all crop value chains, building farmers' resilience. Here some choices will have to be made as to how far resilience can be built from what farmers already do, and to what extent regulatory reforms, even on land ownership - and not unusable district land use plans - will be needed. The current project is to start towards clarifying what sort of agriculture is adapted to climate change, and as the clarification will be done on the ground, chances of unsolvable disputes are nar-

rowed down.

BRICS currency: Vision or pipe dream?

COUNTRIES that constitute the BRICS bloc first mooted the idea of a common reserve currency between them as far back as 2011.

Back then the Mail & Guardian, a prominent South African media outlet, reported that South Africa backed the creation of a common currency unit which the BRICS countries would use to trade among themselves. The primary purpose for this move would be to circumvent the need to make Euro and US dollar conversions.

The idea of a BRICS currency unit has merit given that the United States dollar and its economy showed remarkable weakness and vulnerability during the Great Recession of 2008 which began in that country's housing market but quickly spread to the rest of the

•BRICS countries that is Brazil, Russia, India, China, and Russia have discussed the possibility of creating a basket reserve currency which would challenge the dominance of the United States dollar in settlement of international transactions.

•BRICS countries between them it has been reported since 2011 hold nearly half of the world's foreign exchange reserves which places them in an advantageous position should they decide to issue a new currency akin to IMF-issued SDRs.

•Russia has a strong interest in the creation of this alternative reserve currency. The country has seen at least half of its foreign exchange reserves frozen as sanctions on it start to bite.

Secondly, the wisdom of a single monetary unit that is not backed by a centralized fiscus is now starting to be questioned the same way it was in 2011. This is an obvious salvo to the Euro, one such currency unit.

The case for a single BRICS currency unit gains more credence when one realizes that between them BRICS countries hold almost half of the world's foreign exchange reserves at a time when the reserves of the United States and Europe have been falling. So why can't this grouping of nations come up with an alternate reserve currency firstly as a medium of settlement for trade transactions between themselves but also as an alternative system that is disproportionately reliant on the use of the greenback which has historically shown that it is prone to volatility in economic cycles.

China presently has the largest sum of foreign exchange reserves in the world. When its over US\$ 3 trillion in reserves is added to the reserves of the other BRICS member states the questions as to why they cannot issue their own currency start to grow louder.

Talks of a common currency fizzled out as more pressing national and international matters eclipsed the idea. This year 2022 has seen renewed calls for a common reserve currency emerge once again. This time Russia is leading the call for the creation of a reserve currency that will be an alternative to the United States dollar as a mechanism for the settlement of international transactions.

Russia's motive for making such a call is obvious, the country has been at war with Ukraine since February 2022. This aggression against Ukraine has earned Russia some of the most stringent economic sanc- BRICS countries were developing member countries. It has the largtions in history. What has been the greatest pain point is that Russia has lost access to at least half of its foreign exchange reserves since the beginning of its war with Ukraine.

Leading nations in Europe and the United States have announced embargoes on Russian exports of energy. This development has not been straightforward because most of the countries in Europe and the rest of the world are dependent on Russian oil and gas. Russia for its part has retaliated against what it calls hostile nations by deliberately turning off gas taps. Despite Russia making the calls to reinstate the conversation around the BRICS currency, there is no doubt that China would be and is the driving force behind it. China as has already been said has the largest foreign exchange reserves of any country in the world and is the second largest economy in the world after

the United States. China is the biggest economy among BRICS countries and the Asian superpower has never made a secret of having its currency the Yuan or Renminbi taking on the United States dollar as the global reserve currency.

•The BRICS alternative currency idea has scope and merit however, such a currency by mere inclusion of the Russian rouble in its basket would be volatile because Russia's trade and capital account have been under pressure since the invasion of Ukraine.

•The basket currency effort has been undermined by the resurgence of the United States dollar which has been appreciating rapidly relatively to other currencies including those in the BRICS bloc.

Chinese economic influence is growing rapidly. Chinese economic hegemony is most prevalent in Africa in terms of infrastructure projects and sovereign debt. In October 2011 stock exchanges in Brazil, Russia, Hong Kong, and South Africa unveiled a cross-list-

ing agreement, the BRIC Exchange Alliance, for derivatives for their combined market capitalization of \$9 trillion. Some countries now offer Renminbi banking like Zambia and Nigeria. Russia has a large stake in seeing a BRICS currency unit come to fruition. When the second round of talks on creating this alternate global reserve currency began in 2019, Russia was anxious as it was today to circumvent economic sanctions. In 2019 Russia was under sanctions for its invasion and subsequent annexation of Crimea. Russian leader Vladimir Putin, according to a report by banking group ING announced in June 2022 that the a new basket reserve currency which would include roubles, rupees, renminbi, and rand. The rationale of this round of discussions around the creation of a BRICS currency is that it would be an alternative to the Special Drawing Rights issued by the International Monetary Fund.

ING's report also questioned the need for an SDR-like basket of currency and concluded that it is the result of the need to break the US hegemonic dominance over international trade as well as for BRICS member states to create their own spheres of influence.

For Russia, pegging its currency to the basket of currencies is seen to be a measure meant to slow down the depreciation of the rouble which has been free falling since the invasion of Ukraine began in February 2022.

Russia has more skin in the BRICS alternative currency game than other member states especially presently. ING reports that there is mounting pressure on its capital account.

Previously Russia was a net creditor to the rest of the world, meaning that the country was more of a lender to the rest of the world than a borrower. In the years before it became an aggressor, Russia's trade surplus would be balanced out by the foreign investments it would make in other countries.

Russian capital is no longer welcome in most jurisdictions of the world because of sanctions and legal restrictions.

ING has called these discussions around the creation of a BRICS currency a "trial balloon floated by

The banking institution is sceptical of such proposals becoming tangible and raises questions about its feasibility. The first question is whether such a basket would attract significant foreign exchange reserves from countries looking to

These can be friendly nations within their respective spheres or the BRICS countries themselves. ING perhaps most importantly raises a further pertinent issue which is the character and nature of a would-be reserve currency.

•Market pundits like ING are sceptical that the BRICS currency will see the light of day given current geopolitical realities and the fact that such a basket or alternative reserve currency would not be able to stand up to the criteria of a global reserve currency which include safety, liquidity, and re-

•China is the most dominant economic power of the BRICS est amount of foreign exchange reserves of any country in the world. The country is spreading its influence worldwide and is most prev-

This premise questions whether the BRICS basket would be able to stand up to the criteria of what is conventionally believed to be. The qualities of a reserve currency include safety, liquidity, and return. According to ING, in terms of safety, "... sovereign credit quality will clearly be an issue for any BRICSbasket currency, where a simple weighted average of 5-year sovereign credit default swaps (CDS) trades at least twenty times wider than a similar CDS average for SDR currencies. When it comes to FX liquidity, suffice to say a basket of BRICS currencies operates in a different universe to those currencies in the SDR.

The average deposit/yield on a BRICS basket would be far higher, but that is because of the much poorer credit quality where it looks like Russia will shortly go into sovereign default."

Another inadvertent global economic development that has the potential to undermine the efforts to create the BRICS currency basket is the recent rally in the United States dollar which has been appreciating rapidly relative to other currencies in the world.

This strength in the greenback reinforces its position as a global reserve currency.

Investors have been demanding more United States dollars because they perceive it as a safe haven compared to emerging market currencies. The preference for countries one would surmise when it comes to building up national foreign exchange reserves will be to do so in United States dollars.

The idea of a BRICS basket currency has scope and potential however, presently, it is undermined by the country relying on it the most to succeed which is Russia.

It is in social gatherings where, for example, men would discuss nature of women, their likes and dislikes and how to go about them. If people receive detailed account of how marriage life should be organized, youth wouldn't end up committing absurd mistakes on the pretext of jealousy.

Also low level of thinking resulting from poor be-

liefs and socialization escalates mariticide. Individuals get into marriage without awareness that human beings may change due to circumstances facing their life either good or bad. The awareness was to come from socialization which is a part of a child upbringing. Without preparations on how to deal with challenges which may result from some situations in the future predisposes spouses to kill each other because what they face is what they did not prepare for.

Additionally, lack of reflection on the past when solving problems escalates these killings. Similar events must have taken place and solved wisely but patience is needed in doing things wisely.

Patience is too results from socialization especially with elders, something which is becoming a are due to the speed with which that life chases youth or vice versa, depriving them of time to learn new skills which are helpful in life.

It is worthy suggesting that schools should take the responsibility of correcting this derailment so as to make sure that life restores its values. Pupils should be equipped with critical thinking skills that enable them think from a broader perspective and hence being able to reject poor beliefs and make sure they get time to socialize with elders and other knowledgeable individuals so that they make wise decisions.

If we wait for individuals to learn critical thinking when they are already grown up, we are so late and doing so is entertaining the consequences that we are currently seeing. Jealousy is a pretext and not a real cause of mariticide. We should not kill one another for whatever reason.

Conservation stakeholders swing into action as artisanal mining drain forests

RTISANAL and small-scale mining (ASM) is big in Tanzania. According to the United Nations Environment Programme (UNEP), an estimated one million people are directly employed in ASM in Tanzania and many more dependent on it for their livelihood.

While large scale mining in the country is highly mechanised with the active participation of multinational enterprises, ASM is undertaken by individuals or groups with limited equipment and often operate infor-

This has led to a myriad of challenges ranging from those affecting miners themselves such as health risks occasioned by excessive use of mercury in gold processing to those affecting communities surrounding the mines as well as the country as a whole such as environmental degradation.

Lake Zone regions of Simiyu, Shinyanga, Mwanza, Geita and Mara are the heartlands of ASM. The economic benefits of this activity come with huge environmental consequences that are now raising eyebrows.

According to a report by Tanzania Journal of Forestry and Nature Conservation, Volume 91 of 2022, Bukombe-Mbogwe Forest Reserve (BMFR) in Geita Region has substantially lost its vegetation cover due to artisanal and small-scale gold mining.

The report shows that land use and forest cover changes analysis from 1984 to 2020 proved that there was decrease in dense vegetation from 46.4 per cent to 25.62 per cent, bareland from 43.23 per cent to 20.06 per cent and increase in sparse vegetation from 9.4 per cent to 46.86 per cent and built-up land from 0.97 per cent to 7.46 per cent.

The report shows that logs for pit construction in mines were extracted from BMFR by a whopping 67.5 per cent in that period with the authors noting that ASM has negatively changed vegetation cover in BMFR and surrounding villages.

Also, the stakeholders have launched environmental conservation awareness among primary school pupils which goes hand in hand with tree planting programme to instill the skills and love for the environment in the future generation.

Environment conservationists and other stakeholders in Geita Region are now scratching heads on how to

come up with alternative raw material for mining construction to minimize the already huge damage.

Geita-based non-governmental organization with interest in community empowerment Infodigtech has embarked on a research aimed at coming up with alternative tp logs in mining pit construction.

Msajigwa Alfred, Infodigtech managing director revealed the plan here last week during the launch of a three-day tree planting campaign and environment conservation sensitization which targets 3,500 pupils in 70 primary schools in Geita.

"As the research continues, we engage the miners in sensitization so that they can changes easily and embrace the alternative when it is found and approved," he said.

The initiative is supported by African Underground Mining Services (AUMS) whose Project Manager Tom Sawyer participated in the launch of the campaign and said that they decided to support it because it is a noble cause.

"Environmental conservation education to pupils is very important; we will continue to provide cooperation and support to this and any other initiative with the same objectives,"

Salum Omary, Conservator Assistant with Tanzania Forest Services (TFS) in Geita District said the government agency has joined the initiative due to its importance and potential in mitigating environmental degradation.

"Tree planting is essential because we understand that hundreds of thousands of hectares of trees are felled annually," he said.

Earlier, finance manager at Infodigitech Michael Mpamwa, while giving environmental conservation sensitization to pupils before

tree planting exercise said that if the young learners are given environmental conservation and tree planting education at a young age, they can contribute to conservation efforts in the future.

Leticia Deus, a pupil at Pemma Elite Pre and Primary School known as Leticia Deus applauded the initiative, requesting that such sensitization sessions be given regularly to pupils not only in Geita but also other regions with high rates deforestation.

According to PACT world, ASM provides a vital livelihood for nearly 45 million people around the world, with tens of millions more people also dependent on the sector, including family members and small business owners along the ASM supply chain. Artisanal mining is an important driver of development in communities from Africa to Asia, where there are often few other opportunities available for generating income.

"We know that ASM contributes positively to many of the Sustainable Development Goals, and with inclusive, comprehensive formalization, the global community can mitigate ASM's negative impacts."

ANZANIAN entrepreneur Gibson Kawago says that he is working on a project aimed at providing clean and affordable energy to people and controlling the dumping of e-

Kawago, 27, is the owner of a company named "The Wanted Garage," where he is working on reusing laptop batteries to create battery packs, power banks and

He attributed his entrepreneurship to his love for cables in his father's garage from a tender age and his passion for innovation. "When I was young, I was showing my grandmother a wedding ceremony video from my mobile phone before it ran out of battery in the middle of the video," said Kawago in a recent interview with Xinhua at his small workshop in Mbezi Beach suburb in Dar es Salaam, the commercial capi-

"Since my village was off-grid I had to travel over 51.4 km to recharge my phone before I came back the following day to finish watching the video." This challenge forced him to walk his first step toward his long innovative journey by resolving to save himself and the people of his village when he made a solar power bank for charging mobile phones out of trashed materials in his father's garage.

Kawago recalled that in 1999 when he was four years old, he was in his father's garage, happily playing around with the cables in cars in Iringa region, central Tanzania, where his father was working as a mechanical engineer and driver of trucks ferrying logs to the plant for processing into paper.

"I asked myself how many people are facing the same problem. Students studying at night are using kerosene lamps causing some of them to experience lung problems caused by inhaling smoke from the kerosene lamps over the years," said Kawago.

His innovative journey started again when he resolved to look around for a solution to lighting and his passion for reusing dead lithium-ion batteries from laptops started growing up at that moment.

"When I came back from school I used to go to garbage dumping areas and I started scavenging for motherboards for mobile phones, televisions and radios and took them home," he said, adding that from that period he also started making a small power bank for charging mobile phones.

Most Tanzanians, including students, use refurbished laptops whose batteries have been used before, making their lifespan very short and they have to dispose of them, according to him. Kawago said he started to specialize in reusing lithium-ion batteries

which are mostly found in laptops.

He started his company in 2009 when he joined secondary school but it was not formalized until 2016 when he started working on lithium batteries while studying at the Dar es Salaam Institute of Technology (DIT) in electrical engineering.

He graduated from DIT in 2019. The soft-spoken Kawago said he has a team of four permanently employed technicians and five other technicians working part-time.

His main sources of revenue are derived from repairing damaged battery packs for e-bikes, home-powering batteries, Bluetooth rechargeable speakers and customized battery packs for

solar companies. "I work for 20 hours a day on weekdays, 13 hours on Saturdays and six hours on Sundays.

My fellow team members work from Monday to Saturday for eight hours and rest on Sundays," he said. He said a chain of people are involved in his project, including the battery collectors whom he pays 1.5 U.S. dollars for 1 kg of dead laptop batteries, creating jobs for people considered unskilled. "I also train them on how to safely handle the dead batteries because if they are not safely handled they can cause problems," said Kawago. After the batteries are delivered to his small workshop, he breaks them apart and separates the plastics. In the process, he has one

policy that he doesn't want to leave any kind of waste behind.

Kawago has partnered with other companies that are recycling plastics, and electronic and electrical waste to conserve the environ-

He said he has also started making small lithium-ion generators that can be used to power homes for lights, computers and televisions. He lamented the fact that most people in Tanzania don't have knowledge of how to manage e-waste, adding that disposing of e-waste is a massive challenge. "Conserving the environment is everyone's responsibility, it is not for a certain institution or the government that needs to care about that," he observed.

"We can be affected by improper disposal of e-waste. Chemicals of disposed of e-waste start leaching into the soil affecting vegetables and fruits that we eat," added Kawago, saying that eating vegetables or fruits contaminated with e-waste can have an impact on the long-term.

He said he has been working on this project for more than five years making prototypes with online guidance from different stakeholders from China, India, the United States and the United Kingdom."I have shared with them what I do and they have guided me on the prototypes that I make.

It is my vision to make products that meet required standards that can compete in the market," he said. "Right now I am looking at companies that can help me package my products. The functionality is already done and after I get proper package I will start completing compliance issues with authorities that could be in June 2023 before we can be in the market by late July

Chinese hybrid rice technologies cushion the Philippines' agricultural development

HE Philippine-Sino Friendship Farm is located in Maluid Barangay of the municipality of Victoria, Tarlac province, the Philippines. Rice growing is a major business of the farm.

Villager Maniego, 94, who owns the six-hectare farm, often goes to the fields to check the growth of rice.

"I've been cooperating with the Philippine-Sino Center for Agricultural Technology (PhilSCAT) over the past more than a decade. I have grown many varieties of hybrid rice developed by Chinese experts, which improved the yield per hectare to nearly 11 tons from three to four tons in the past," said Maniego.

"I raised the salary for my employees on the farm after the production was lifted," he told People's Daily.

The PhilSCAT was established in Nueva Ecija province, the Philippines in 2001. It focuses on the research, development and promotion of hybrid rice varieties.

The center has helped plant commercial hybrid rice on 514,400 hectares of paddy fields in the Philippines over the past 21 years, and set pilot demonstration programs of rice growing and seed production techniques in 29 Philippine provinces. It has benefited over 300,000 farming households and increased grain production by over 4.8 billion kilograms.

"We believe in China's hybrid rice technologies and Chinese experts," said Manie-

Maniego spoke of his Chinese friend Ma Wendong, who offered technical guidance for his farm. "We used to check rice growth in the paddy fields together, wearing straw hats and barefooted," he told People's Daily.

Ma is a hybrid rice expert sent to the PhilSCAT by Yuan Longping High-tech Agriculture Co., Ltd. (Longping Hightech) which is named after Yuan Longping, known as the father of hybrid rice. Under Ma's guidance, all six hectares of Maniego's farmland are planted with hybrid rice.

Experts sent by Longping High-tech to the PhilSCAT have cultivated and introduced to the Philippines

multiple high-quality hybrid rice varieties, including 18 that have been approved by the country's agricultural authorities and entered the local market.

At the completion ceremony of the PhilSCAT Technical

Cooperation Program Phase III, then Philippine Secretary of Agriculture William D. Dar noted that China's hybrid rice technologies had steadily lifted rice production in his country, which was important for ensuring food secu-

rity and improving farmers' livelihood.

Besides, the PhilSCAT has introduced 449 sets of equipment to the Philippines for training, production and scientific research.

The PhilSCAT Technical

Cooperation Program Phase III is undertaken by Central Luzon State University. In 2019, its employee Efraim Saturno went to China to attend a training program on hybrid rice technologies.

"I saw efficient mechanized

agricultural production in Ningxiang, central China's Hunan Province. All procedures were completed by machines, including seed production, sowing, growing and harvesting. It was very impressive," Saturno said.

So far, the PhilSCAT has trained 15,000 people and sent 11 batches of Philippine technicians to China for training. It also offers suggestions for the Philippines' Department of Agriculture and relevant institutions, promoting reforms on eight local mechanisms.

Edgar Orden, president of Central Luzon State University told People's Daily that the university is a witness to the PhilSCAT's development over the past 21 years, which saw the contributions made by Chinese agricultural experts to Philippines-China agricultural cooperation.

He said the Chinese experts' contributions are important to the Philippines' agricultural development, and Philippines-China agricultural cooperation is conducive to ensuring the Philippines' food security.

"I feel so overwhelmed with your good work and at the same time surprised how you performed competently in supporting farmers from production level by imparting the good agricultural practices embedded with climatesmart farming, market access, and business environment enabling," Macias said, extolling TAHA for its approach of working in partnership with multiple stakeholders in harmony, particularly the Government and other key

She said the organization's success story would prominently feature as one of the key feats of SIDA's 60th anniversary to be marked

TAHA also took the Envoy through the services offered by its key subsidiary companies such as the conformity assessment firm, Greencert and the logistics outfit, TAHA Fresh Handling Ltd, as well as the gender and nutrition unit.

TAHA Group CEO, Dr Jacqueline Mkindi said extensive adoption of climate-smart agricultural technologies, best practices, finance and market access, has marked tremendous productivity and income upsurge for a critical mass of smallholder farmers under SIDA support.

For instance, courtesy of SIDA support, TAHA has been able to foster a modern technology drive, agronomy services, finance and market access as well as dietary education for farmers in different areas, yielding a massive impact in terms of horticultural crops output, income upsurge and health.

Statistics show that TAHA under SIDA support expanded its footprint to reach more than 40,000 horticultural smallholder growers in the country over the five-year stint, prompting a total of 1,837 hectares being cultivated.

As a result, horticultural crops productivity and related income in the areas under SIDA support had also grown by leaps and bounds as the figures show that the farmers ranked in \$4.3 million income from crops sales, production reached 46,558.6 metric tonnes as a total of 11,247 small-scale farmers have been linked to the reliable markets.

The yield of the avocado value chain, for instance, improved by 50 percent, onions by 44 percent, Irish potatoes by 54 percent, tomatoes 20 percent and French beans by 30 percent, thanks to SIDA financial aid, TAHA boss ex-

Market physical infrastructures built by TAHA in the period under review included 10 full-fledged collection centres, and two state-ofthe-art pack houses and were accessed by 8,346 farmers.

In its effort to enable market access compliance, TAHA through its Greencert certification outfit has been able to facilitate four apex farmer groups in Kilimanjaro, Arusha, Songwe and Mbeya to get GlobalG.A.P certification, a total of 650 farmers in the four groups trained on GlobalG.A.P certification and cut cost previously incurred by growers on certification by 50 percent.

TAHA working in partnership with the Ministry of Agriculture has advocated for the removal of 114 agricultural fees, taxes and levies, facilitated the registration of 213 pesticides, cut off inputs registration costs, reduced new inputs testing period, and participated in addressing 36 technical barriers to trade to enhance cross border

A total of 65 percent of women and youth were employed in the industry from 2017 to 2021, 55 percent of households consumed horticultural crops in their diet, 12,481 students benefited from nutrition pieces training through the school garden program, 4,044 numerous people with disabilities.

TAHA also extensively promoted the use of drip irrigation and afforestation by encouraging the planting of fruit trees such as avocados, mangoes and marula to farmers as part of its painstaking initiative to mitigate the impact of climate change.

The organization has also encouraged farmers to apply integrated pest management such as biological control agents (BCAs), live barriers, and the usage of fast rejuvenating staking materials - like bamboo. Dr Mkindi told the visiting diplomat that the move enhanced safe food accessibility to consumers, spurred agro dealers' businesses, thanks to production technology usage and benefited small logistical businesses.

"Owing to improved productivity and profitability, we've witnessed an improvement of farmers' livelihoods, uninterrupted supply of raw material to processors, numerous selfemployment creations as retailers of fruits and vegetables" she

THE latest World Health Organization (WHO) report indicates that almost 500 million people will develop heart disease, obesity, diabetes or other non-communicable diseases (NCDs) attributable to physical inactivity between 2020 and 2030.

The diseases, according to a report-Global status report on ties, environments, and econophysical activity 2022' will be costing \$ 27 billion annually if governments will not take urgent action to encourage more fairer societies for all."

Dr Tedros Ghebreyesus, WHO Director-General said: "We need more countries to scale up implementation of policies to support people to be more active through walking, cycling, sport, and other physical activity. The benefits are huge, not only for the physical and mental health of individuals, but also for sociemies. "We hope countries and partners will use this report to build more active, healthier, and

Fiona Bull, Head of WHO Physical Activity Unit said: "We are missing globally approved indicators to measure access to parks, cycle lanes, footpaths - even though we know that data do exist in some countries. Consequently, we cannot report or track the global provision of infrastructure that will facilitate increases in phys-

ical activity." "It is good for public health and makes economic sense to promote more physical activity for everyone," said Dr Ruediger Krech, Director Department of Health Promotion, WHO, stressing the need to facilitate inclusive programmes for physical activity for all and ensure people have easier access to them.

He said the report issues a clear call to all countries for stronger and accelerated action by all relevant stakeholders working better together to achieve the global target of prevalence of physical inactivity by 2030.

Data from 194 countries show that overall, progress is slow and that countries need to accelerate the development and implementation of policies to increase levels of physical activity and thereby prevent disease and reduce the burden on already overwhelmed healthcare systems.

"We believe in practical education because there are many young people who have studied well but are at home because of unemployment. By providing practical education, many young people will be able to be self-employed instead of relying on employment," Sabaya

"In addition to classroom education, we help talented children to achieve their goals. If a child has a talent for football, let him go there, if he has a talent for drawing, direct him to where it is possible. It is his talent that God gave him, let him develop it," he emphasized.

Could Boris Johnson really make a comeback?

ORIS Johnson, the man ousted as UK prime minister by his own government just three months ago, has emerged as an early frontrunner to be the next prime minis-

His replacement Liz Truss crashed and burned after 45 days in the job, announcing her resignation after being forced to ditch most of her policy programme after it spooked the financial mar-

A second Johnson premiership would be an extraordinary turnaround even for a politician who has made miraculous comebacks

No one has returned as prime minister after resigning as leader since William Gladstone 140 years

Mr Johnson won a landslide election victory in 2019 - but was forced out by his own MPs after three years in office, following a string of scandals. Under the British constitution, the ruling party can change leaders between general elections.

His final months in office were dogged by accusations he broke ministerial rules by not telling the truth about Covid lockdown-busting parties in Downing Street.

He remains under investigation by the Parliamentary Standards Committee, which in theory could lead to him being suspended from Parliament, or even being kicked out as an MP.

The committee could hold televised evidence sessions in the coming weeks - even calling Mr Johnson to respond in person. Mr Johnson's supporters have dismissed the committee's investigation as a

"witch hunt".

The prospect of Johnson's return to Downing Street has been met with horror by some Conservatives. Former leader Lord Hague warned it could lead to a "death spiral" for the Conservative Party.

Foreign Office Minister Jesse Norman said Mr Johnson returning as prime minister would be an "absolutely catastrophic decision" while Tory MP Sir Roger Gale has said he would quit the party.

But Mr Johnson's supporters, including cabinet members Jacob Rees-Mogg and Anne-Marie Trevelyan, and former home secretary Priti Patel, say he is the only contender with the backing of the voting public after winning the 2019

general election. They believe can win the next election for the party too, despite the Labour Party's current commanding poll leads.

Will Boris Johnson return?

Mr Johnson has yet to officially announce he will stand. The only contender to break cover so far is cabinet minister Penny Mordaunt who came third in the last leader-

In his final appearance at Prime Minister's Questions in July this year, Mr Johnson made it clear that he was planning a comeback.

He signed off with "hasta la vista, baby". He could only have dropped a heavier hint that he was not finished yet if he had used another catchphrase from the Terminator films: "I'll be back."

Leadership hopefuls need the backing of at least 100 Tory MPs by Monday afternoon to stay in the race.

This is no small task for a man who had 148 of his colleagues vote against him in a confidence vote in June - followed by nearly 60 ministerial resignations one month later.

The deluge of resignations followed revelations that Mr Johnson had ignored accusations of sexual misconduct against Chris Pincher before appointing him deputy chief whip. On 5 July, two senior cabinet ministers resigned within minutes of each

other - including then chancellor Rishi Sunak, who left claiming Mr Johnson was not competent or serious. But before the resignations, pressure had been building on Mr Johnson

for criticism over his handling of parties that took place in Downing Street during Covid lockdowns.

Mr Johnson was one of 83 people fined by police for a string of illegal parties - including a birthday party for Mr Johnson.

Four times Johnson has bounced back

In 1987, Boris Johnson was fired by The Times for falsifying a quote - but was hired the following year by The Daily Telegraph, as the paper's Brussels correspondent

In 2004, he was fired as the Conservatives' shadow arts minister for lying about an affair - but was back on the front bench a year later

In 2016, he pulled out of his first bid to be Conservative leader and prime minister after his close friend Michael Gove launched a rival bid but he made a surprise comeback as foreign secretary under eventual winner Theresa May

In 2018, he quit Mrs May's cabinet in protest at her Brexit deal, only to return as leader of the party the following year, going on to win a huge majority at a general election

Labour leader Sir Keir Starmer said the former prime minister was "unfit for office". Scotland's Frist Minister Nicola Sturgeon called a Mr Johnson return a "ludicrous suggestion".

He was described as "Britain's Berlusconi" by the Liberal Democrats. Johnson 'has the edge'

According to betting website Oddschecker, Rishi Sunak is the favourite to become the next prime minister. Mr Sunak has odds of 8/13 to take over from Liz Truss while Mr Johnson is 2/1 with Ms Morduant is 35/2.

If only a single candidate emerges the contest will be over on Monday if not the new leader will be chosen by a vote from party membership on Friday 28 October.

Polls taken in the final days of Liz Truss' premiership have consistently shown Mr Johnson as the most popular successor.

Govt to coffee board: Aim for 20m seedlings per year

HE government has directed Tanzania Coffee Board (TCB), to produce 20,000,000 seed of coffee annually the move that will help to boost coffee production in the country.

It also commended the efforts by TCB to work closely with JJAD Kagera Farmers and other private sector practitioners in coffee seed production all over the country.

The directives were given over the weekend by the Deputy Minister for Agriculture, Antony Mavunde, during the launching of 800,000 free Robusta seed distribution to Kagera famers, in the event that took place at Karenge Village Kyerwa District in Kagera Region.

The Robusta seed were produced by JJAD Kagera Farmers and according to the company, their target is to produce 3,000,000 Robusta seed annually.

The Deputy Minister argued farmers who will get free Robusta seed to plant them and do close supervision so that at the end of the day it bring positive changes in coffee production and meat government goals.

"We have given target to TCB to produce 20 million seed annually and am happy that you have engaged private sector I can see today you work with JJAD Kagera Farmers Ltd, we need positive change after three years and we want to see production of coffee increase dramatically," he said

The Deputy Minister also directed TCB to put strong system to monitor farmers who

are provided with free coffee seeds so that they can increase their production and bring about changes in their society.

The banks providing \$13 billion in financing for Tesla CEO Elon Musk's acquisition of Twitter Inc have abandoned plans to sell the debt to investors because of uncertainty around the social media company's fortunes and losses, people familiar with the matter said.

The banks are not planning to syndicate the debt as is typical with such acquisitions, and are instead planning to keep it on their balance sheets until there is more investor appetite, the sources said.

The banks, which include Morgan Stanley, Bank of America, and Barclays Plc, declined to comment. Representatives for Musk and Twitter did not immediately respond to requests for comment.

Musk agreed to pay \$44 billion for Twitter in April, before the Federal Reserve started raising interest rates in a bid to fight inflation. This made the acquisition financing look too cheap in the eyes of credit investors, so the banks would have to take a financial hit totaling hundreds of millions of dollars to get it off their

Also preventing the banks from marketing the debt was uncertainty around the deal's completion. Musk has tried to get out of the deal, arguing Twitter misled him over the number of spam accounts on the platform, and only agreed to comply with a Delaware court judge's Oct. 28 deadline to close the transaction earlier this month. He has not revealed details on Twitter's new leadership and business plan, and many debt investors are holding back until they get more details on that front, the sources said.

The debt package for the Twitter deal is comprised of junk-rated loans, which are risky because of the amount of debt the company is taking on, as well as secured and unsecured bonds.

Rising interest rates and broader market volatility has pushed investors to stay away from some junk-rated debt. For example, Wall Street banks led by Bank of America suffered a \$700 million loss in September on the sale of about \$4.55 billion in debt backing the leveraged buyout of business software company Citrix Systems

In September, a group of banks canceled efforts to sell about \$4 billion of debt that financed Apollo Global Management Inc's deal to buy telecom and broadband assets from Lumen Technologies after failing to find buyers.

Oil buyers crushed by a surging dollar

MUMBAI

Brent oil has dropped more than 30% percent from this year's high, but you wouldn't know it if you live in Paris, Mumbai or Accra.

The decline in the global oil benchmark from nearly \$128 a barrel has dovetailed with a jump in the dollar of about 15% over the same period. That means fuel prices remain a significant factor driving up the cost of living across most of the world.

Oil-demand powerhouses like China, India and the European Union have all seen smaller real-term declines in crude prices than benchmarks would suggest. And for some emerging markets like Sri Lanka, the impact of a spiraling oil price and collapsing currency has already shown up in the form of near-total economic collapse.

"A stronger dollar is a headwind for oil consumer nations whose currencies are not linked to the greenback," said Giovanni Staunovo, commodity analyst at UBS Group AG. "Over the last 12 months, oil prices have increased much more in local currency terms."

There's no easy fix. Lifting interest rates to bolster currencies risks slowing already-fragile economies, while developing countries need to keep an eye on dollar reserves.

Euro-zone countries are highly dependent on imports for their oil. With next to no local crude supplies, each of the currency bloc's five biggest economies -- Germany, France, Italy, Spain and the Netherlands -- is at least 90% dependent on foreign purchases to run refineries.

Against that backdrop, the dollar denomination of oil has proven to be a particular headache for European Central Bank officials in what has already been a testing year. The squeeze on energy supplies from Russia's moves to cut

gas deliveries has driven huge increases in consumer prices, running at a record 9.9% in September.

Asian countries have been feeling similar pain. Through August, the value of China's oil imports was up 50% from a year earlier, despite overall volumes being lower as the country wrestles with restrictions to stop the spread of Covid-19. Bank of Korea Governor

Chang-yong complained last month that his currency's weakness is canceling out the benefits of lower oil prices. Both Korea and Japan have at times sought to shield consumers from the pain of higher fuel prices by offering subsidies effectively transferring some of the burden to the government.

The strain of the strong dollar has prompted India to reach out to trade partners including Saudi Arabia, Russia and the UAE to shift deals to local currencies. The rupee has fallen about 11% against the dollar this year.

UK retail sales fall, consumer confidence slow



etail sales have been falling and consumer confidence has hit record low levels in the United Kingdom (UK) due to the country's persistently high inflation rate, fresh surveys showed on Friday.

The volume of retail sales fell in all the main sectors (food stores, non-food stores, nonstore retailing and fuel) by 1.4 percent in September, making it 1.3 percent below pre-COVID-19 February 2020 levels, the Office for National Statistics (ONS) said on Friday.

The only sub-sector to buck the trend was clothing and footwear stores.

In the three months to September, sales volumes fell by 2.0 percent when compared with the previous three months, continuing the downward trend seen since summer 2021.

"Retail sales continued to fall in September after a weak August, and consumers are now buying less than before the pandemic," ONS Director of Economic Statistics Darren Morgan

According to retailers, the fall in September was partly due to the store closures following the death of Queen Elizabeth II, but also to the continued price pressures leading consumers to be conscious about spending, Morgan added.

Also on Friday, the market research company GfK said its consumer confidence index for the UK increased two points in October to minus 47 as consumers were grappling amid uncertainty and turmoil.

UK consumer confidence continued to bump along close to September's historic low, with all core measures remaining severely depressed, GfK Client Strategy Director Joe Staton

The biggest danger by far is inflation, he noted. "Households are not just running scared of burgeoning energy and food prices, and the prospect of further base rate rises increasing mortgage costs. They are now facing the likelihood of tax rises and even austerity measures."

The negative environment will deflate future spending plans, and cautious consumers could easily slow the UK economy still further, Staton added.

Pushed up by rising food prices, the UK's Consumer Price Index (CPI) rose by 10.1 percent in the 12 months to September, up from 9.9 percent in August and returning to July's 40-year high.

Amid soaring prices, a worsening cost-of-living crisis is already visible.

A survey published on Friday by the UK financial regulator Financial Conduct Authority (FCA) found that 7.8 million people are finding it a heavy burden to keep up with their bills, an increase of around 2.5 million people since 2020.

Conducted between February and June this year, the survey showed one in four UK adults are in financial difficulty or could quickly find themselves in difficulty if they suffered a financial shock, and 4.2 million people have missed bills or loan payments in at least three of the six months before the survey was conducted.

Saudi forum set to draw top US business leaders

Apublic spat between the United States and Saudi Arabia will not deter top Wall Street executives and U.S. business leaders from a flagship investment event starting tomorrow where the kingdom will seek deals to reduce its economy's reliance on oil.

President Joe Biden has vowed "consequences" for U.S.-Saudi ties over an OPEC+ decision this month to cut oil output targets, which Riyadh defended as serving market stability.

The dispute was the latest shadow to be cast over the annual Future Investment Initiative (FII), which was hit by a Western boycott over the 2018 murder of billion), inward FDI for the first Saudi journalist Jamal Khashoggi and by the pandemic in 2020, leaving it a far cry from the 2017 inaugural event that Riyadh billed as "Davos in the Desert".

FII recovered in 2019 after the uproar over Khashoggi's killing by Saudi agents, drawing big names from financial, defence and energy firms with strategic interests in the world's top oil exporter, but garnered relatively meagre foreign inflows.

More than 400 US delegates are expected to attend this week, Richard Attias, CEO of the FII Institute, told Reuters, adding this was the largest representation of a foreign country.

This year's edition, running Oct. 25-27, includes JPMorgan boss Jamie Dimon, Pimco Vice Chairman John Studzinski and a BNY Mellon executive as speakers, and they still plan to go, spokespeople for the companies

Top executives from Goldman Sachs, Blackstone, Bridgewater Associates, Boeing and Franklin Templeton are on the agenda. Goldman Sachs declined comment, while the rest did not respond.

JPMorgan and Goldman Sachs made nearly \$77 million and \$42 million respectively in investment banking fees in Saudi Arabia last year, Refinitiv data showed. JPM remains at the top of the league table in 2022 with over \$39 million

"For the most part, I do not see U.S. companies actively avoiding Saudi Arabia due to recent political tensions," said Adel Hamaizia, managing director at Highbridge Advisory and a visiting fellow at Harvard University.

"US companies will be an important partner to Saudi's investment and growth plans, in traditional sectors, but also in 'newer' fields including tourism, entertainment, EV production, technology and a nascent local defence industry," Hamaizia said.

The FII is a showcase for Crown Prince Mohammed bin Salman's Vision 2030 development plan to wean the economy off oil by creating new industries that also generate jobs for millions of Saudis, and to lure foreign capital and talent.

Foreign direct investment still lags behind targets, though there has been movement in new sectors as the kingdom opens up. As Boeing netted an \$80 million defence contract last year, Fedex announced a \$400 million 10-year investment plan in the country, the Arab world's biggest economy.

At 15.3 billion riyals (\$4.07 half of the year was about a fifth of the \$19.3 billion secured in 2021, which had included a \$12.4 billion investment for Aramco's oil pipeline infrastructure.

It is well below the 2030 target of \$100 billion a year under a national strategy aiming for foreign direct investment equalling almost 6% of GDP by 2030.

Uncertainty lingers around the regulatory and tax environment as well as high operational costs and lack of a skilled local workforce, even after Rivadh handed companies an ultimatum to locate regional headquarters in the kingdom by 2024 or lose out on lucrative government contracts.

"FDI flows have remained stubbornly flat and low, under 1% of GDP, and some of the notable names that have invested have had only modest success, even with government backing," said Justin Alexander, director of Khalij Economics and Gulf analyst at GlobalSource Partners.

This has left the Saudi government and the Public Investment Fund to try to deliver on the crown prince's diversification promises, aided by a petrodollar windfall.

A worsening global economic outlook and oil market volatility has raised the stakes for the government in pursuing Vision 2030, which includes a \$500 billion project to build a huge, high-tech economic zone on the Red Sea called NEOM eventually meant to house nine million people.

"The government cannot afford to drive economic development indefinitely but for the time being there is no real alternative as domestic businesses are unfit to play that role, and FDI continues to disappoint," said Neil Quilliam, associate fellow at Chatham

Iran: US sent a message, 'in hurry' to reach nuke deal

IRAN'S foreign minister on Saturday said his country has received a US message expressing American hastiness to reach the nuclear deal with Iran, official IRNA news agency reported.

"Three days ago, we received a message from the United States, and told them that the (International Atomic Energy) Agency (IAEA)'s accusations against Iran's nuclear program should be resolved" before any agreement, said Hossein Amir-Abdollahian in the Armenian capital of Yerevan.

Asked about US officials' comments about the nuclear negotiations being off the US agenda, he said "Americans are contradictory in their words and behavior, as they are in a hurry to reach the agreement in their (recent) message."

While the United States continues to exchange messages with Iran, they "are seeking to exert political and psychological pressure (on Iran) and want to gain concessions in the negotiations," he said.

"We do not give any concessions to the American side, and we move within the framework of logic and the framework

Zakharova added that Moscow sees the West's accusations that Russia is shelling Ukraine's civilian infrastructure as hypocritical.

"We find the accusations that Russia is 'shelling Ukraine's civilian infrastructure' as utterly hypocritical. The European Union has lost the moral right to say anything about war crimes, since over eight years it had been turning a blind eye to killings of civilians, women and children as a result of the Kiev regime's shelling of the Donbass territories," Zakharova stressed.

The diplomat added that the EU is not willing to find a peaceful solution to the Ukraine conflict.

"We see that the EU does not show any willingness to resolve the conflict peacefully. On the contrary, they continue to thoughtlessly invest considerable funds to protracted hostilities.

For this purpose are aimed the decisions on additional (another 500 million euros) funding for arms supplies to the Ukrainian armed forces and on establishing an EU mission on military support for Ukraine," the Russian Foreign Ministry spokeswoman concluded.

AS a mother who got pregnant at 16, a Rwandan teen identified only as Yvonne to conceal her identity, was eager that her peers can easily access contraceptives to prevent unwanted pregnancies.

Yvonne learned she was pregnant, more than one month after she missed her periods during the height of the COVID-19 pandemic and schools shutdown in 2020. On learning she was pregnant, her stepmother expelled her from home, saying she was spoiled and could spoil her children. With her predicament, Yvonne ran away with the help of her boyfriend who later denied the pregnancy and abandoned her.

Like hundreds of thousands of young girls nationwide, Yvonne was not able to complete her secondary education. While her story is shared by many and draws ire among activists, the solution to addressing teenage pregnancies in Rwanda seems to be complex.

The majority of Rwandan legislators during a plenary session this week voted against a private members' bill that sought to amend the 2016 law on human reproductive health, which would have given girls aged 15 and above the green light to access contraceptives.

The rejection of the bill has become a talking point because of the growing problem of teenage pregnancy in the East African country. Some legislators cited cultural considerations and faith while others

said contraceptives would corrupt the moral values of young girls. Such claims, however, only

served to further muddy the waters around the controversial bill."Allowing access to contraceptives as the first-line choice for young girls wishing to engage in sexual activities would seem prudent," Yvonne told Xinhua, asking "so what solutions are the MPs pro-

"I'm troubled about this." Reports indicate that teens as young as 14 years of age are sexually active, hence the need to equip them with knowledge about contraception in case they choose to engage in sexual activities.

Rwandan gender activist Donatha Gihana, however, said that even if the bill had been passed it would not address the problem of teenage pregnancy.

"But before we rush into girls' access to contraceptives, where are the men who impregnate these girls," she asked. Gihana has come across cases, where teenage girls after producing do not disclose the fathers of their babies, which she described as strange. "I don't think access to contraceptives can alone address the problem of teenage pregnancy. I think it's important to look at a comprehensive approach rather than narrowing down the solution to one." "Access to contraceptives to me is not the problem. We need to address the issue of teenage pregnancy in a more comprehensive way. To me, with or without contraceptives the problem of teenage pregnancy will

continue unless the root causes are addressed," said Gihana.

Gihana believes there is even a lack of awareness around contraceptives, whereby in villages many girls are not aware of the different birth control methods.

"Access to contraceptives would perhaps provide a solution to only a small percentage of girls in Kigali who have the means to buy, yet rural girls bear the big problem of teenage pregnancy. We are talking about the majority of girls in rural areas who don't even have easy access to pharmacies. We need a national approach that speaks to all teenagers," she added.

Child pregnancies in Rwanda are linked partly to growing gaps in parent-child communication, limited access to sexual reproductive health information, and poverty. At least 23,544 children were born to teen mothers in 2019, according to official

On average 20,000 teens are impregnated annually, with 23,000 having been impregnated last year. Other Rwandans, though, praised parliament for rejecting the bill, arguing that contraceptives are not suitable for teens.

Among those is Sheila Mugisha, a nurse and mother of two teenage girls, who said it would be wrong to give teenagers contraceptives. "It would be worrying for a 15-year-old to think of which kind of contraception is best for them since there are many different contraceptive methods on the market," she said. In Rwanda, the consent age is 18, but the legal age for marriage is 21. The bill had been tabled before the Chamber of Deputies by a group of five legislators.

Gamariel Mbonimana, one of the lawmakers, said they drafted the bill thinking it would address the challenge of the high number of teenage pregnancies in the country and their research found out that in some countries children as old as 13 years or 12 years of age have access to contraceptives.

While underlining that addressing the problem of teenage pregnancies requires the role of fathers, mothers, guardians, and the community, Gihana believed that citing culture and faith to deny girls access to contraceptives is a lame excuse because "some aspects of culture have been overridden by modernity or technology.'

"Even with amazing policies and programs the household and family, where girls live, need to have discussions on sexual reproductive health. We cannot stop teenage pregnancy without the roles of the families and community."



Russia still waiting for list of victims of Bucha false flag, envoy says

UNITED NATIONS

MOSCOW is still waiting for a list of the victims of the false flag operation that Ukraine carried out in Bucha, Russian Permanent Representative to the United Nations Vasily Nebenzya said at a UN Security Council meeting on Ukraine.

"I would like to reiterate that despite all the reminders, we still have not received a list of the victims of the false flag operation that Ukraine carried out in Bucha in April. It once again confirms that the Kiev authorities have nothing to share to prove their accusations and allegations," he noted.

Nebnzya also pointed out that Western countries "are trying to pre-

tend that there is no need to prove anything and any of the Kiev regime's allegations can be taken for granted." "You prefer to cover up for the criminal regime of nationalists, radicals and outright Nazis, assisting them in staging provocations and promoting lies about Russia and the actions of Russian troops," Nebenzya empha-

On April 3, the Russian Defense Ministry rejected the Kiev regime's accusations of civilian killings in Bucha, Kiev region. The ministry noted that the Russian Armed Forces had left Bucha on March 30, while "the evidence of crimes" emerged only four days later, after Ukrainian Security Service officers had arrived in the city.

Treasurer: Australia's inflation to peak towards end of year

CANBERRA

AUSTRALIA'S treasurer has warned that inflation in the country is expected to peak towards the end of the year and it will persist for a little bit longer because of the impact of the natural disasters and energy prices.

Jim Chalmers, who will on Tuesday night hand down his first federal budget, on Sunday said inflation is the primary influence on this budget, which guides the approach to cost of living relief.

"On the current Treasury forecasts, inflation will persist for longer than we'd like," he told Australian Broadcasting Corporation television.

Treasury forecasts inflation will peak at 7.75 percent in December.

"This will be a family-friendly budget which recognizes that our pressures on the economy come from around the world, but they're felt around the kitchen table," Chalmers said.

As a result of inflation, government spending on social security payments including the pension is expected to be about AU\$33 billion (US\$20.8 billion) higher than previously forecast.

Earlier this week, the treasurer confirmed the ongoing flooding in Australia's southeast will harm the country's projected economic growth.

Thousands of homes and businesses have been affected by the floods, and the treasury forecasts the floods will drive the price of fruit and vegetables up by 8 percent over the next six months.

Chalmers said the key elements of the strategy have two parts.

"First of all, how do we get wages moving again in this country, and the budget will be about that," he said on Sunday.

"But also how do we help inflation moderate over time. You do that by making sure your cost-of-living relief is responsible and that your investments in the economy don't push up inflation."

Rwandan breast cancer survivors highlight importance of early detection

AS the world marks this year's breast cancer awareness month, 47-year-old Rwandan mother Francine Uwumukiza recalls the nightmares she went through when she was diagnosed with breast cancer

Despite regular exercises and eating a balanced diet and green vegetables, the mother of three never thought it could happen to her."It was not something I imagined, not even in my dreams that I could be a victim," said the resident in Nyarugenge district, on the outskirts of Rwanda's capital Kigali. She was diagnosed with breast cancer in 2016, but luckily, she has recovered and encourages women to take prevention seriously. Awareness campaigns on breast cancer are running throughout October in Rwanda, featuring awareness walks and screening women and girls for breast cancer using breast clinical examination.

In 2020, at least 2.3 million women worldwide were diagnosed with breast cancer and 685,000 died from the disease, according to the World Health Organization (WHO). Four women are

diagnosed with breast cancer every minute, and it is projected that the number of breast cancer cases will double over the next 20 years in less developed countries, the WHO says.In Rwanda, at least 650 patients were diagnosed with breast cancer in 2020, the majority of whom succumbed to the disease due to late diagnosis, according to the Ministry of Health.Breast cancer remains the most common among cases recorded in the east African country, followed by cervical, prostate, stomach and liver cancers.

Talking about her experience, Uwumukiza recalled that it was during a self-check routine when she felt a lump. She underwent a breast clinical examination which confirmed it was cancer."I couldn't believe, and wondered why it had happened to me," she said. Uwumukiza started her chemotherapy at a hospital in neighboring Kenya's capital Nairobi as her family had the financial means.

The therapy succeeded and she had surgery to remove the area where the lump was found. She later underwent radiotherapy." I think this was one of the most difficult moments in my life because of the excruciating pain," she said. "As a survivor, I feel proud because I had a second chance to be still alive today.

Early detection through periodic breast self-examination gives patients the best chance of survival, Daniel Ngamije, Rwanda's Health Minister said during a recent awareness campaign in Kigali."Common symptoms can easily be detected such as a lump in the breast or armpit, swelling of part of the breast, irritation or dimpling of breast skin, pulling in of the nipple," he said.

Other symptoms include nipple discharge, including

blood, pain in the breast, or redness around the nipple.Now Uwumukiza's goal is to spread awareness among young women in Rwanda, in particular about the importance of check-ups. She said other than targeting older women for awareness most times, young women need awareness too. "We need to teach younger women how to care about their bodies and open up to their parents or doctor when they feel anything strange," she said.

Uwumukiza believes while high cost and lack of developed treatment infrastructure in developing countries is a challenge, ignorance and lack of awareness are the real killers of people. Delays in screening, diagnosis, and treatment due to a lack of awareness are a challenge, she said. Health officials say 80 percent of breast lumps are not cancerous but there is still a 20 percent chance.

Women are encouraged to have mammograms before the age of 40.0ther Rwandan breast cancer survivors Jackline Musoni and Charlotte Uwimana said the earlier one finds out, the higher the chances of getting

THE new Italian government formed by appointed Prime Minister Giorgia Meloni was officially sworn in at the presidential Palace on Saturday.

Meloni (pictured) had been formally appointed and accepted the mandate on Friday, after being summoned by President Sergio Mattarella at the end of his short round of consultations with all parties' leaders in parliament.

If Meloni and her cabinet pass confidence vote at the parliament, she will serve as the country's first female prime minister ever.

Italy held a snap general election on Sept 25, following the resignation of Mario Draghi as prime minister in July, which put an end to a government of national unity that led the country for some 17 months.

Meloni -- the leader of right-wing Brothers of Italy -- was asked to form the new government after her party won 26 percent of votes in the recent polls, ending up as the most voted force. She had run the campaign with her two coalition allies, the center-right Forza

Italia party of former prime minister Silvio Berlusconi and the anti-immigrant and Eurosceptic League led by Matteo Salvini, both of which gained a little over 8 percent of the votes.

As such, the right-wing coalition marked a clear victory and, with the current mainly first-past-the-post electoral system, was able to secure a solid majority of seats in both the chambers of the Italian parliament.

The swearing ceremony took place at the Quirinal presidential palace on Satu-

Overall, Brothers of Italy named 9 ministers in the cabinet, while League and Forza Italia 5 ministers each. Further 5 cabinet posts will be covered by technocrat figures

Now, after being officially sworn in, the cabinet will need the confidence of both the Lower House and the Senate in order to enter into force. The voting will take place on two separate days next week.

The new cabinet would count 24 ministers, including some key figures. These include Giancarlo Giorgietti, who would serve as Economy and Finance minister after being Industry minister in the previous cabinet, and Antonio Tajani as next minister of Foreign Affairs and as one of the two deputy prime ministers named

League's leader Matteo Salvini will serve as minister of Infrastructure, and as deputy prime minister as well. Matteo Piantedosi, a former chief of staff to Salvini, will be the next Interior minister, while Aldolfo Urso and Guido Crosetto -- both from Meloni's Brothers of Italy -- would serve as Industry minister and Defence minister, respectively.



Italy's new PM, govt sworn in China's C919 jet obtains milestone airworthiness permit

THE successful development of the C919, China's first homegrown large jetliner, will become a new engine driving the further progress of the Chinese aviation and high-end manufacturing industries, said Qian Zhongyan, executive deputy director of Commercial Aircraft Corporation of China (COMAC).

Qian, also vice-chair of the Shanghai Federation of Returned Overseas Chinese, made the remarks during an interview after the C919 obtained the type certificate issued by the Civil Aviation Administration of China.

The type certificate was issued to the COMAC, the developer of the aircraft, on Sept. 29.

The C919, which has been in development for 15 years, is a witness to the leapfrog progress of China's aviation industry.

Airworthiness certification is a prerequisite step for civil aircraft entry into the market. The C919's obtaining of the type certificate was a milestone in China's development of large passenger jets. It indicates that the design of China's first self-developed trunk jetliner meets airworthiness standards and environmental requirements.

The C919 has independent intellectual property rights. The body of the airplane was designed by the COMAC and jointly manufactured by Chinese enter-

Over the past years, the design and manufacturing teams, following independent innovation and open cooperation, have developed a series of key technologies and forged their core competitiveness. They have nurtured a batch of professionals and driven the development of relevant industries, which forms a platform for China's independent development of large jets.

The C919 took its maiden flight in May 2017. Over the past five years, test aircraft has completed a series of test flights during which its power, electrical and other systems were comprehensively tested. It also

went through tests in various types of extreme situations including stall speed, high temperature, severe cold and freeze.

It marked the first time for China to have joined all the development procedures of a large airplane, including designing, manufacturing, testing, test flights and airworthiness certification. It also indicated that China has become a country that is able to develop large airplanes in accordance with international airworthiness standards.

The Chinese trunk jetliner is competitive in multiple aspects, which will help it stand firm in the aviation market.

It is equipped with advanced systems and materials. According to the COMAC, the supercritical wings of the airplane are able to reduce the resistance by five percent. The advanced materials, such as

compound materials, make the airplane much lighter, safer, more economical and more environmentally friendly. Besides, the C919 is equipped with advanced airborne systems and high-performance engines.

The single-aisle plane has 158 to 192 seats and a range of 4,075 to 5,555 kilometers. It comes with an efficient air filtration system and a passenger-centric lighting system.

The safe and reliable C919 enjoys huge potential thanks to the vast Chinese market. It currently has 28 customers with orders totaling over 800 planes.

The development of the large airplane is in line with China's economic and strategic development. After the C919 is put into commercial use, it will generate positive impacts on China's civil aviation.

It will accelerate the integration aluminium-lithium alloy and other of the aviation industry, amplify the correlation effect between the civil aviation industry and the aviation manufacturing industry, and further improve the quality of China's economic development, said Li Xiaojin, director of the research institute of aviation economy under Civil Aviation University of China.

The successful development of the C919 will offer more choices for airlines and passengers, bring more opportunities to the suppliers and cooperation partners, and further activate the healthy competition and innovation of the global commercial aviation industry.

F there is one with marise the mood pundits among as the 2022/23 Premier League tie between Simba SC and Yanga, popularly known as the 'Dar es Salaam derby', approached, it is that derby psychology is being relied upon by the Jangwani Street outfit fraternity to produce the form that has seen the side triumph over their next street archrivals several times.

Kiunsi, who studied international coaching in swimming at Semmelweis University, is the only local official in the latest list of FINA officials with the capacity to officiate in any level of swimming championships including the Olympics.

Haaland's scoring streak leaves Guardiola speechless

MANCHESTER, England

PEP Guardiola has coached arguably the greatest-ever soccer player in Lionel Messi, so it speaks volumes when he admits he has run out of words to describe Erling Haaland's start to life at Man-

"My English language is not big enough," the City manager said after the Norway striker took his goal tally to 22 this season in a 3-1 win against Brighton in the Premier League on Saturday.

Haaland, who had failed to find the back of the net in last week's 1-0 loss to Liverpool, quickly got over that mini-drought with two first-half goals as the Premier League champion moved to within a point of leader Arsenal.

With 17 goals in the league, Haaland needs just six more to equal the 23 goals that saw Mo Salah and Son Heung-min share the Golden Boot as last season's joint leading scorers.

"Erling has the quality," Guardiola said. "With big space he can do it, but with small space he can do it. This is the reality, it is fantastic.'

Haaland's goals have come in just 15 appearances in all competitions. He looked set to register his fourth hat trick of the season, with both goals coming before halftime.

He opened the scoring after 22 minutes when racing on to Ederson's long clearance. With Brighton goalkeeper Robert Sanchez stranded outside of his goal, Haaland overpowered Adam Webster and rolled the ball into an empty net.

He got his and City's second two minutes before halftime after referee Craig Pawson reviewed a challenge from Lewis Dunk on Bernardo Silva and awarded a penalty.

Haaland stepped up and powered a low shot past Sanchez, which was the club's 600th league goal under Guardiola.

Just as City fans might have been wondering how many goals their team would rack up in a latest rout, Brighton reduced the deficit.

Riyad Mahrez looked set to add to the home team's lead but his tame shot was saved by Sanchez, which allowed Brighton to break. Solly March laid the ball off to Leandro Trossard just outside the penalty box and he unleashed a low drive that beat Ederson at his near post in the

Trossard could have equalized later when running through on goal - but his shot from a tight angle was saved.

Brighton paid the price for that missed opportunity when Kevin de Bruyne made it 3-1 in the 75th with a superb 25-yard shot that curled into the top

While Guardiola has run out of superlatives for Haaland, he is still to be fully satisfied by De Bruvne this season.

"He is not playing at his top level, not yet," he said. "He made a fantastic goal, but he is not playing at his best. He knows, I don't have to tell him. His dynamic is still not perfect, I spoke with him.

It appears that the striker, who won soccer's prestigious individual prize on Monday, is being extra cautious to avoid the risk of any injury that might jeopardize his participation with France at the World Cup in Qatar starting in less than a month.

Vinícius Júnior set up two goals for Madrid as the Brazil winger continues to excel both with, and without, Benzema playing by his side.

Madrid extended its unbeaten streak to 16 games since starting the season across all competitions and increased its lead at the top to six points over Barcelona, which plays Athletic Bilbao on Sunday.

Luka Modric and former Madrid coach Zinedine Zidane, both former Ballon d'Or winners, handed Benzema his award in a ceremony before kickoff. The Madrid striker hoisted it high to receive the applause of fans, who turned out for the celebration and the match amid steady rain in Spain's

Modric then proceeded to ensure that Madrid did not miss Benzema's goals, scoring from an assist by Vinícius to give Madrid the lead five minutes into the game. Vinícius pounced on a poor pass by Gonzalo Montiel near Sevilla's own area, took on the backtracking defenders, and found Modric all alone at the far post to tap in.

While Vinícius squandered an opportunity to add to the lead in the 44th - when he tried to round goalkeeper Yassine Bounou instead of shooting from point-blank range – Sevilla was toothless with midfielder Isco Alarcón up front as a "false nine."

Sevilla had its share of possession but had no strikers in the box to feed. In the 45th Jesús Navas drew the first save from Thibaut Courtois, who was back after missing six matches due to sciatic pain.

Nottingham Forest shocks Liverpool in 1-0 win

NOTTINGHAM, England

OTTING-HAM Forest produced a shock to beat Liverpool 1-0 in the Premier League on Saturday.

The last-place team at the start of the day secured only its second win of the season in the game at the City Ground.

Taiwo Awoniyi struck in the 55th-minute to end Liverpool's mini-revival, which saw it beat Rangers, Manchester City and West Ham in its previous three games.

Awoniyi was on the books at Anfield for six years without ever playing for the first team, but he produced the decisive moment to lift Forest off the foot of the table.

"To score against Liverpool is a day I will never forget," he told BBC Sport. "I will always to be grateful to Liverpool for scouting me from Nigeria and scoring against them is amazing."

The win eases the pressure on Forest manager Steve Cooper, who also used to coach at Liverpool.

"This is not the end, this has got to be a part of the start," Cooper said. "We get back in on Monday and work even harder. We've been on a difficult run but, I told the boys, I've not seen them hide, shy away or sulk. I've seen the opreassurance."

IT seemed the natural and seemingly logical next step in Steven Gerrard's managerial journey, not that he would ever express it publicly himself.


