

AS schools reopen today for the second term, the government has cautioned on the need to observe pandemic spread prevention guidelines.

Strictly adhering to the guidelines to contain the spread of the COVID-19 pandemic was still relevant, meanwhile as the government has

# Armed robbery cells Govt decontrols fertiliser imports

HOME Affairs minister George Simbachawene says police have been conducting silent operations to destroy cells of armed robbers all over the country.

Addressing a rally in Lufu Ward in his Kibakwe constituency, Mpwapwa District in Dodoma region at the weekend, the minister said law enforcers are currently on the second phase of this operation, just in case some violent criminal networks were untouched.

He said the first phase of the operation against bandits was successful and the second one was underway against all those

The suspects were also found in possession of a 32-inch LG TV set, Hisense refrigerator, five mobile phones of various makes and a Dell who think armed robberies are the right way to earn a decent income.

He said that banditry has been rising fast in various urban centres including Dar es Salaam, Arusha and Mwanza,in the wake of a change to a less stringent atmosphere. If the perpetrators think these activities will enable them make a living they are totally mistaken, he declared.

"These include those using firearms in robberies, muggers, those using motorcycles to snatch ladies' handbags in the streets and others.

THE government has lifted control on fertiliser imports, allowing traders to ship in the input without the usual bidding via the Fertilizer Bulk Procurement System (BPS).

Agriculture minister Prof Adolf Mkenda told reporters here at the weekend that the decision has been made to curb skyrocketing prices occasioned by low production due to the Covid-19 pandemic.

Fertiliser requirements for the 2020/21 season reached 718,052 tonnes while actual procurement was 82 per cent up to end of May, he stated.

The country's fertiliser availability depends on production from local manufacturers and

the deficit is made good by imports through bulk procurement licensed by the Tanzania Fertilizer Regulatory Authority (TFRA), he

He said in the pre-pandemic period from July to October the world's big fertiliser manufacturers used to reduce prices in the world market but this year the situation is different as prices shot up.

Regulation 7(4) of the Fertiliser Purchase Regulations of 2017 provides that all dealers needing to import farm inputs were free to do so without going through bulk procurement processes, he stated.

Bulk procurement cannot satisfy supply needs, thus the ministry has permitted



## NMB Bank rolls out health agro-sector insurance policy

HEALTH insurance history was made in Tabora region last weekend when NMB Bank Plc officially rolled out its financing of farmers' medical services scheme in conjunction with the National Health Insurance Fund (NHIF).

The bank has initially set aside 5bn/- to finance the 'Cooperative Health' insurance scheme which last week recruited two Tabora tobacco cooperative unions as partners, allowing their members to get interest-free loans to finance their annual insurance premiums.



Prime Minister Kassim Majaliwa launched the first formal rollout of the scheme on Saturday when he presented three beneficiaries with NHIF cards during an event to mark the International Cooperatives Day held nationally in Tabora.

In his speech, Majaliwa thanked financial institutions such as NMB for supporting the government's efforts to revive cooperatives and make them robust economically. "We in government are satisfied with the support that financial institutions such as NMB are giving to cooperative unions. We are also persuading banks to address the issue of high interest rates which they are now working on with experts at the Bank of Tanzania," he

The NMB sponsored health insurance cards were given by the prime minister to representatives of tobacco farmers, Kulwa Mfaume, Saleh Mpemba and Athanas Semeduke. They are part of an initial 102 cards

He said schools management to put in place he gears needed for prevention and protective actions against spreading the virus. These guidelines were already issued by health authorities, including installing facilities for hand washing, he said.

"We will continue to monitor observation of the guidelines in schools to protect the students. Universities, colleges and all education institutions have to ensure that the COVID-19 preventive measures are adhered to," he said.

He emphasised that people will not be compelled to take the jab once rolled out as it will be voluntary and free of charge, specifying that the government will embark on a public education campaign before starting to administer the jabs

"As it is in other countries, the government will provide the Covid-19 vaccine for free to those who wish to be inoculated or need to do so to travel. We will implement the issuance of vaccines to the public in collaboration with stakeholders," he emphasised.

Prof Makubi said that the government will beef up monitoring systems to control unauthorised imports of vaccines, taking stern measures upon those found to be doing business through importing or administering the vaccines.

"We will start providing the jabs after we are satisfied of the quality and safety," he stated, noting that verification of vaccines would take up to six months.

The decision to enrol with the COVID-19 Vaccines Global Access, abbreviated as COVAX is geared to protect Tanzanians and enabling people to access vaccines in an easier way.

COVAX is a worldwide initiative

aimed at equitable access to COVID-19 vaccines directed by GAVI (the global vaccine alliance), Coalition for Epidemic Preparedness Innovations and the World Health Organization.

"Some countries require that anyone entering the country has to be vaccinated. We are doing this to help a number of Tanzanians who need to travel abroad for work or business," he specified, noting further that plans are underway for construction of a vaccine manufacturing plant under licence, locally.

A number of factories manufacturing animal vaccines were being lined up for inspection of factilities, seeing how the new COVID-19 product can fit in, and other human vaccines, he stated.

The project's feasibility study indicates that until completion the new factory will cost over 80bn/-.he signalled.

Recently, addressing editors at the State House in Dar es Salaam, President Samia said that while the general public awaits the vaccine rollout, private health facilities were free to purchase vaccines and charge people who are ready to pay for vaccination.

missions Foreign international organizations are free to ship in vaccines and inoculate their staff and families, the president noted, elaborating that apart from the COVAX vaccine expected next year, the country has set aside \$477m (over 1trn/-) for a Covid-19 vaccination campaign.

A number of countries and international organizations have shown interest in supporting Tanzania roll out its vaccination programme, thus once experts decide on the type the government will press its order, the president intoned.

Prior to this shift, TFRA used to coordinate importation of fertiliser through tendering for bulk ordering and shipping from outside, also part of the 2017 regulations. It used to prequalify fertiliser dealers (suppliers/ producers) for importation of the input for each cropping season via bulk procurement.

Pre-qualification was conducted through competitive bidding procedures specified in the 2017 guidelines and opened to all interested applicants except existing prequalified suppliers.

TFRA had already announced on its website that it intended to prequalify fertiliser dealers for bulk importation in view of the current cropping season 2021/2022 to the next, 2022/2023, with estimated import quantity per annum put at 570,167 metric tonnes, the minister added

## Tanzania likely to build real life replica of Olduvai Gorge ravine

TANZANIA may soon start to build a real life replica of the 'Olduvai Gorge,' canyon, based on the proposal tabled by the Deputy Minister of Natural Resources and Tourism, Mary Masanja who led a delegation of Members of Parliament to visit the cradle of mankind in Ngorongoro Conservation Area.

Their suggestion comes from the fact that the million-year old segmented ravine is under serious threat of crumbling down like a cookie once the combined weather elements take their toll on the natural edifice.

"As we have just seen, the Olduvai Gorge monolith is susceptible to erosion and weathering due to being exposed to all natural elements, rains, winds, heat and wildlife, which means it is only a matter of time before this important land feature disappears entirely from the face of the earth," pointed out the Deputy Minister.

Deputy Tourism Minister Mary Masanja, was reacting to a lecture on the archaeological site which was being given by the Chief Curator at Olduvai Gorge Museum, Godfrey Ole Moita to the 36 legislators from the National Assembly who were touring the Ngorongoro Conservation Area as part of their domestic tourism excursion after the house was recently adjourned in Dodoma.

"It is true that the Olduvai Gorge is wearing out rapidly due to being exposed to all weather elements and fluctuating temperatures, but we cannot take any artificial steps to protect it as it is located in a conservation area which does not permit human interference," said Ole Moita.

Previously some members of parliament wanted to know if it was possible to protect the historical and internationally acclaimed gorge so that the natural ravine can be sustained for future generations, but the management of Ngorongoro Conservation Area Authority

said it was not possible because conservation laws do not allow tampering with nature.

Eventually the Deputy Minister, Mary Masanja, Members of Parliament who visited Olduvai, especially Yahya Khamis from Zanzibar and officials at the Site Museum agreed that the best way was to create a life-like replica of Olduvai Gorge ravine for future historical records.

So far several replica sets for the 4 million old footprints buried at Laetoli hominid site have already been reproduced and can be found in a number of museums in the country and the current joint proposal from the Minister and National assembly is suggesting that the state through NCAA should work to reproduce a similar edifice to immortalize Olduvai Gorge edifice for future generations.

With its exposed layers of segments indicating timeline geological history, the block-like Olduvai Gorge ravine, is a natural edifice which is the world's only mankind evolution landmark, sticking out from a deep valley located adjacent to the Olduvai archaeological Site Museum on the further end of Ngorongoro Conservation Area.

Olduvai Gorge's archaeological site, with its Laetoli neighbor, holds hominid remains and footprints dating back to about 4 million years, right from the earliest stages of human evolution. These records, including those of the earliest human footprint, date back to about 3.5 million years. This is the site where Dr Louis and Mary Leakey worked for over 40 years in their quest of human history related excavations.

The newly built Olduvai Museum keeps excavated remains older than 2 million years and up to 17,000 years. About 7,000 extinct animal species have been unearthed at the gorge. Historians and other human evolution scientists have concluded that the earliest man or human being evolved at Olduvai then moved to other places of the world.







## PM instructs ministry to tackle challenges facing cooperatives

The Agriculture Ministry has been instructed to fully deal with various challenges that hamper operations and development of cooperative unions in the country.

It should also ensure it builds the cooperatives the capacity to enable them become competitive and strengthened in order to look for crops markets within and outside the country.

The PM issued the instructions on Saturday at the apex on celebrations to mark International Day of Cooperatives (ICA) held at national level at Tabora.

He said cooperative movement is a tool that builds up trust among farmers an d members and the government has been stressing on the issue for the nation's benefit. 

"I understand that cooperatives are robust organisations that connect farmers and fishermen to their economic and social challenges," he added.

He said the provision of education and training on cooperatives to members, officials and other actors should be strengthened to make them understand the entire concept on cooperatives, its foundations, regulations and procedures.

The PM also directed Cooperative Audit and Supervision Corporation (COASCO) to change its auditing system to make sure it provides correct reports to farmers.

He said in FY 2020/2021, the government through the Cooperatives Development Commission (CDC) conducted internal audit of 4,494 out of 9,185.

He also called on all cooperative registrars to make sure every cooperative in their areas has to empower in finding solutions a database of all cooperative members.

> He said the aim for the statistics is for making assessment for channelling various requirements to them, including seeds, fertiliser and pesticides.



## Govt speaks on co-operation with human rights defenders

THE government has reiterated its commitment to collaboration with human rights defenders in the establishment of a brave organization on human rights democracy whose contributions to the implementation of the five years national development plan will easily be pointed out.

Minister for Constitutional and Legal Affairs, Palamagamba Kabudi who represented the Prime Minister, Kasim Mjalaiwa made the statement in Dar es Salaam over the weekend when speaking during an event to commemorate the 7th anniversary of the Tanzania Human Rights Defenders Coalition (THRDC) challenged the coalition managerial organ to be more thoughtful when exercising their duties.

"I recommend you strengthen the managerial organs who will be more engaged in doing their duty, for we are all foot soldiers, where are the thinkers?" he questioned adding that we shouldn't allowed others to think for us

"This is a high prove that you want to contribute to the economic growth of the country, continue working and obeying the laws of the country and cooperate with development partners in the implementation of the 5 years national development plan which will help enhance economic development" he urged

The minister also acknowledged that in the past relationship with the CSOs was affected this explains why the commission of human rights for human rights has been established by the constitution of Tanzania for the protection and preservation of human rights which before that was the permanent commission on enquiry

He called on right defenders to intensify investigation in rural areas like villages, district and the hinterland where some power drunkard leaders violate the human rights

"Most at times those in the rural areas suffer less from other forms of human violation of

rights but are mostly abused by their power drunkard leaders who used the ignorance of the people to abuse of their rights" he said

He therefore urged right defenders to educate people on their rights so that they themselves will know their rights and be able to defend them instead of always standing for



#### Memorable occasion of 20 years since death of Dr Omar Ali Juma

Zanzibar and across country have marked 20 years since third phase Vice President Dr Omar Ali Juma died, on July 4, 2001. On that day as it is still the case today, it was a day devoted to the Dar es Salaam International Trade Fair (DITF) where he officiated during the afternoon on that day, and then spent the evening with his family as usual, but death came knocking It was a shock to the nation the following day to learn that the VP has passed away peacefully in the night, of heart ailment.

One event that will constantly be remembered in the legacy of Dr Omar was that fate designated him to be Acting Union President when the Civic United Front (CUF) moved to conduct a mass demonstration to mark 90 days from the date of a disputed general election, in October 2000. A number of diplomatic missions had objected to the proceedings but the United States, then in the final days of the Clinton administration (Democratic), waived aside those objections. It fortified the government's resolve, and in the demonstrations held January 26-27 2001, scores of people died as the demonstration was suppressed.

What is surprising in the chronicle is that the demonstration early 2001 was an event to climax an earlier demonstration 40 years back, in January 1961 as the independence movement gathered pace, also after disputed results of an election. The gerrymandering (creating more constituencies in pro-Sultanate areas) thus creating an artificial majority was inimical with a proper democratic vote, and this situation was only reversed with the January

people in 1964 revolution. A whole new series of problems started, as those who were being excluded were now in power, but schism in the population remained in place, tormenting the

> The solution to that situation was not yet in view in the days of Dr Omar and President Dr Salmin Amour, as at that time an adamant opposition dominant in the Zanzibar and having fairly effective presence on the Mainland was a thorn on the side of the state. One reason for fearing this opposition - and which actually drew the US Ambassador Dr Charles Stith to ignore polls objections - was that some of its sympathisers in civil society appeared to relish the terrorist strikes of Al Qaeda against US embassy buildings in Dar es Salaam and Nairobi. So it wasn't just the Zanzibar or Union authorities that took exceptions with CUF.

Efforts to bridge the gap between the two sides moved into high gear in the years that followed the January 2001 demonstration but took time to be effected on the ground. A government of national unity materialized nearly 10 years after that event, and it lasted only one term, and failed to come up the following polls owing to the same disputes. With the radical changes in the political landscape under the fifth phase Union presidency, opposition forces were tamed enough for them to brook participating in the government without sorting out the 'ifs and buts' of the general elections. With the sixth phase, more work needs to be conducted to widen opposition participation in the ranks of the government, as return to debating the constitution won't help much. No agreement can be reached as to weakening the presidency.

## Litany of woes in public service calls for higher pace of reforms

OES in the public misunderstandings service can scarcely said to be decreasing, though to a certain extend firm leadership and improved electronic registers have narrowed the range of actions that an ill disposed person can do at any particular moment. There is greater scrutiny, oversight and intervention from the relevant quarters, which unavoidably implies that there is a net reduction in wrongdoing over time. This trend follows in academic expectation of greater institutionalisation, greater professionalisation and greater democratisation - implying a general of transparency, curbing traditional loyalties, feuds.

That is why one need not be alarmed by reports that forged academic papers, truancy and embezzlement of funds are some of the reasons employees in the public sector get fired. This is part of what transpired in a recent biennual general meeting of the Public Service Commission in the city on Friday, covering the 2019/2020-2020/2021 period. The commission handled 626 appeals lodged by sacked civil servants for various reasons, where disciplinary disputes led the list, but education queries weren't really far

There were rather routine items like taking up further studies without permission, which boils down to refusal to grant such permission, often because those in higher positions look askance at more qualified individuals coming back to their posts. There are aspects where the interest of employer is at variance with the public interest, when individuals lacking the relevant qualifications are promoted. But often the reasons aren't far to seek, namely that traditional solidarities matter a lot, and are applied where feasible.

At least one reason for those

bureaucratic prerogative at most, which largely lacked foundation, for instance when the head of communications at the commission talked of the failure to produce form four certificates. If someone has been employed say ten years already, and on the basis of a diploma certificate and even a degree, why would such person have to produce a secondary school leaving certificate? Why do bureaucrats assume that people take care of those documents all their

One relevant datum that the overall report noted was that 59 appeals were brought to the president, who agreed with the commission on 52 appeals and disagreed on seven others. It is possible that on the basis of the statistical notion of significance, rulings of the commission were on the whole seen to be fair, as seven out of 59 is not demonstration of unfairness. Still the commission found out that there is gross abuse of labour laws, rules and guidelines in the handling of disciplinary issues by employers. This is to say that the level of professionalism is low, traditional behavior is high, and we need much less of that.

At the time of independence there was strict adherence to rules in the civil service but we soon expelled Europeans and Indian UK citizens, and since nationals took over we have labored to observe standards. In 1967 and even more so in 1971 party rules became the workplace mainstay, with bureaucratic laxity and employee negligence the norm; since reforms started computers have replaced labour but there is still a dearth of professionalism. Amending citizenship laws would bring in fresh air from the outside world, as those moving in or feeling at home here will have greater reason to stick to standards, unlike at present.

# Covid spreading in Africa at record pace, says WHO

**GENEVA** 

HE Delta variant of coronavirus is driving the pandemic forward in Africa at record speeds, the World Health Organization (WHO) warned on Thursday.

Infection numbers have increased in Africa for six weeks running, rising by a quarter week-on-week to almost 202,000 in the week that ended Sunday, it said.

The continent's weekly record currently stands at 224,000 new

38 African countries to nearly 3,000 in the same period.

"The speed and scale of Africa's third wave is like nothing we've seen before," Matshidiso Moeti, the WHO's regional director for Africa, said in a statement.

The highly contagious Delta variant has been reported in 16 countries, accounting for 97 percent of samples sequenced a tragedy." in Uganda and 79 percent in the Democratic Republic of the Congo (DRC).

Oxygen demand in Africa is now keeps rapidly spreading in the

Deaths rose by 15 per cent across 50 percent higher than at the peak of the first wave, a year ago. "The rampant spread of more

# Nigeria can and must climb out of the hole made by corruption

was 13 years old in 1979, when Nigeria began to slip into a dark, frightening hole that ∟seemed to have appeared overnight and from which it has vet to emerge: corruption.

Until that point, I had walked with a particular adolescent swagger - that of a young citizen of a newly independent nation that really mattered on the world stage; of a country whose voice carried loud and clear in the community of nations. To me, Nigeria was a country that produced wonderful writers, excellent athletes and brilliant leaders. It was the most populous African nation, one where English was spoken well and whose national IQ was one of the highest in the world. Life in Nigeria, while of course not perfect, was in so many respects good. And it was getting

My secondary school, looking back, provided a reflection of what was happening in Nigeria. In 1977, I was fortunate to attend an elite state-run secondary school, whereby any African standard I had access to first-class teachers, academic resources and sporting facilities. Then, that hole emerged seemingly from nowhere and into its bowels vanished so much of what was good about Nigeria.

Suddenly, my school was no longer a centre of excellence, but

an underfunded, overcrowded together and on its way to joining relic of past glory where standards had plummeted overnight. It was a microcosm of the insidious power of the corruption gripping Nigeria, where good was sucked into that forbidding hole and turned into bad. A nation that had up to that point embraced merit in most things, at least those things my childish mind grasped, had done an abrupt aboutturn and chosen instead to pursue mediocrity.

At that time, in 1979, Nigeria had just emerged from military rule, the only system of governance I had known since birth in 1966. Power was again handed to civilian authority - but it was not to last long before the military once again seized power in 1983 (and effectively held it again until the turn of the millennium).

In 1982, a year before the military seized power from our civilian government for the second time, I began my four years of university studies. Not much changed; certainly, things were not getting any better.

Indeed, if I thought that it was the civilians who could not manage our country properly, what followed when we returned to military rule proved that any civilian government is better than a military one. Dictatorship was not only bad socially and economically, but from a global point of view, Nigeria was a the club of failed African states.

Our military administrations from 1983 on are reckoned by some to have been the most corrupt of all, but perhaps Nigeria was so corrupted already that no one really noticed. Perhaps, the hole was now so deep already that it no longer really mattered if it got deeper.

Then the miraculous happened and in 1999, Nigeria returned to civilian rule. For the next eight years, because we had once again embraced meritocracy our country experienced a renaissance. Nigeria made more progress in that short period than it had in the preceding 25 years.

We began to climb out of that terrible hole, the one we had dug for ourselves. But then, just as we got our heads above the ground, we lost our footing and we started slipping back down again. Today, I believe, we are almost in the same position we found ourselves in 1999; we have wasted many of the opportunities and outcomes our eight-year renaissance had afforded

By now our country should be flying!

Consequently, I have found myself asking: does our apparent inability to climb out of the hole we are in mean that we Nigerians have accepted that we cannot do any better? That our lot in life, pariah nation unable to get its act even though we can compete

intellectually with any nation on Earth, is much worse than we had dreamed it would be? That our children are consigned to being third-class citizens of the world (unless they emigrate and find opportunity elsewhere)?

Here is another question to ponder. When I was a small boy, our nation was 60-million strong. When that hole yawned open when I was 13, we stood at around 80 million. Today, we have more than 200-million people mired down there and in 30 years' time, there will be over 400 million in number. Would that not be the very definition of Hell?

These are the things I dwell upon, the fears that I have for my beloved Nigeria. But then, I look to the examples of other countries that have climbed out of their own holes of poor performance and, instead of basket cases, have become success stories: countries such as Malaysia, Indonesia, and China. Surely, if they can, we can, too.

That is the story that I want for my nation. I certainly do not presume to have all the answers - indeed, I might not have many - but I have resolved to employ the resources I have (financial and otherwise) to do my utmost to change Nigeria's sad narrative.

It is an investment in a brighter future for my country and all who live in it - and it is certainly well worth making.

said of the recent G 7, "Yet again, we will see the boys club congratulate themselves for doing the bare minimum, when so much more is needed to address the challenges we face..... and SADAC have created an environment where big corporations enrich themselves at the expense of the people in the region, ..... and have prioritised the perfect environment for the already super wealthy to become even richer"

He writes that "The G7 is particularly irrelevant now because its leaders don't deliver on their promises. They like making symbolic statements and not solving problems. Worse, they give the appearance of solving global problems while really leaving them to fester,

## Dalit and Muslim Indian women leading change in South Sudan

NEW DELHI

WO Indian women, one Muslim and the other Dalit (former untouchables), separated by culture and geography, have found common ground in leading change in conflict-torn South Sudan.

Rama Hansraj, a Dalit, grew up in a humble railway colony in Secunderabad. Huma Khan, a Muslim, born and raised in the controversial north Indian city of Faizabad, now Ayodhya, home to the demolished Babri Masjid. Both agree their personal experiences of experiencing and seeing discrimination in India and the world led to their decisions to work in the international humanitarian field in conflict zones.

The women are activists and feminists who, through their experiences of struggle and years of work with India's most marginalised, decided to work in geographies and contexts which ordinarily many would avoid

"What else do you expect someone, who has grown up five kilometres (three miles) away from the disputed Babri Masjid site in an atmosphere of constant conflict and communal strife, to want to pursue?" says Khan in an exclusive interview with IPS. She was answering a question on why she chose to work in countries like Iraq and Afghanistan instead of choosing a more comfortable position.

In her last role in South Sudan, Khan was the senior women's protection advisor, leading the section on conflict-related sexual violence at the United Nations mission in South Sudan (UNMISS). She is now a senior human rights adviser to the UN in Bangladesh.

Hansraj, country director of Save the Children in South Sudan, shared with IPS how her work on the ground in India and her interactions with the development sector motivated her to take up positions outside the country and institutions with decision-making powers.

"For us Dalits, access to basic facilities like education and land is a challenge. We face discrimination even in disasters," she says while sharing her experience of working post-Tsunami in India.

Here she saw how Dalits, affected by the disaster, were not even allowed to stand in the same queue as others to receive basic aid.

"We started working on developing donor principles in disasters, highlighting the fact that they need to look at the vulnerabilities within the response and how the beneficiary selection needs to be more inclusive. That is when I saw that not working in these bigger organisations was not going to help us," recalls Hansraj.

Khan spent many years in Gujarat as an independent activist living in resettlement colonies after the communal violence of 2002. There she worked to help rebuild communities and assist in the case of a gang rape survivor. Her lived experiences made her



"unapologetically Muslim".

She recalled how she refused to share the stage at an event organised by an international NGO where women were made to "unveil" as a symbol of freeing them

"It was a month after 9/11 that I had a study-cumwork trip planned to the US which I did not want to cancel," Khan says. "I have had an object thrown at me and been called 'Taliban' while walking down a street in the US because I had covered my head to escape the cold."

Hansraj has been part of anti-caste movements for as long as she can remember, and shared caste discrimination crosses borders and continents and is not only an "Indian problem".

"Caste travels where Indians travel, and the international development sector is no exception. Indians abroad always assume I am upper caste, because otherwise how could I be in such high positions, being a Dalit,' she says with sarcasm.

Both Hansraj and Khan were Ford Foundation fellows and got their initial international academic ex-

posure with the fellowship.

One of the driving factors for both moving from India to take up challenging positions in countries like Yemen (for Hansraj) and Darfur and Afghanistan (for Huma) was their disappointment with the development sector in India and its treatment of Muslim and Dalit communities.

"Even if you're working for a Dalit organisation, the funding decisions were still with those upper caste people sitting in the international NGOs, who basically made decisions for us," says Hansraj.

"Even today, most positions of power in the development sector are occupied by upper caste individuals who decide what to fund and what not to, instead of letting us decide on our own issues."

Khan, who co-founded the feminist rights and advocacy group AALI in India, also felt the space to grow, especially for a Muslim woman in the development sector in India, was shrinking, with those who occupied powerful positions continuing to do so for decades.

Both women worked in South Sudan for close to three years. When Khan left the country late last year, she became a senior human rights adviser to the UN in Bangladesh. Hansraj continues to head Save the Children in South Sudan.

South Sudan is the youngest country globally, gaining its independence from the Republic of Sudan in 2011. The country experiences constant

instability and conflict since then. Both Khan and Hansraj, in lead-

ing roles, have held interactions, negotiations and led advocacy and action-oriented processes with the leadership in the country, with tribal chiefs and community elders alike.

Constant armed rifts and coming face to face with former armed groups where negotiations were needed to either release abducted women or children, or both did not deter them.

"My team and I were able to facilitate the process of the release of women who were abducted, many as sexual slaves, in the Western Equatoria region of South Sudan. To deal with the leadership in the capital city of Juba was one thing, and to negotiate with the commanders on the ground had challenges of threat for us and especially for those women," recalls Khan. The negotiation led to the release of dozens of women and children, many of whom were subjected to repeated rape, sexual slavery and forced marriage by members of the Sudan People's Liberation Movement-in-Opposition (SPLM-IO).

"For me, my identity and my experiences as a marginalised person mean I can identify myself with conflict-affected communities and communities that have been deprived of their basic freedoms, like South Sudan," says Hansraj.

Hansraj shared how she lived in constant fear of being raped when she was in the country in 2015-2016, having witnessed compound break-ins and rampant sexual violence. "Women and children are abducted in the process of cattleraiding here. There is intercommunal violence. In India, women and children from Dalit communities were abducted and trafficked for centuries into forced labour and sex work," she says.

Hansraj feels she imported herself into a context, which is so similar and heart wrenching that sometimes she finds herself caught between emotions and practicali-

## Stopping marine plastic pollution a key IUCN congress goal

OCUMENTED images of albatross chicks and marine turtles dying slow deaths from eating plastic bags and other waste are being seared into our consciences. And yet our mass pollution of Earth's seas and oceans, fuelled by singleuse plastics and throw-away consumerism, just gets worse.

Plastic debris is estimated to kill more than a million seabirds, 100,000 marine mammals and countless sea turtles every year. Plastics, with all their benefits and promises, have revolutionised societies and economies since their development in the 1950s, but now some 8 million tonnes end up in the oceans every year.

Waste plastic, making up to 80% of all marine debris from surface waters to deep-sea sediments, breaks down into micro-plastics which enter the digestive systems of sea and land animals and humans. Invisible plastic is in the water we drink, the salt we eat and the air we breathe. Experts are still working out the long-term impacts, such as cancer and impaired reproductive systems.

The fishing industry, nautical activities and aquaculture also leave a massive legacy in terms of ocean waste, poisoning and ensnaring sea life.

Hasna Moudud heads a small NGO in Bangladesh, working to protect coastal areas where vast rivers pour into the Indian Ocean, providing livelihoods and food for

Her NGO, Coastal Area Resource Development and Management Association (Cardma), plants coastal trees, protects olive ridley sea turtles in a conservation hatchery in the Bay of Bengal, and helps women in cottage industries, using cane grass to make

mats instead of plastic.

"Oceans are always neglected," she tells IPS. "Small NGOs like myself take risks to save whatever we can of the fragile ecosystem that is left for our future generations."

But to combine her NGO's efforts with those of others, Moudud says she is "praying" to attend the IUCN World Conservation Congress 2020 in Marseille this September where government, civil society and indigenous peoples' organisations from around the world will join discussions to set priorities and drive conservation and sustainable development action.

Meeting every four years - with this Congress delayed by the Covid pandemic - member organisations of the International Union for Conservation of Nature, vote on major issues to shape human-

ity's response to the planet's conservation crises. This particular Congress in Marseille is offering both in-person and virtual participation options, allowing those unable to make the trip to Marseille for the full Congress the opportunity to join discussions and provide their feedback.

Moudud's NGO is a co-sponsor of Congress Motion 022: "Stopping the global plastic pollution crisis in marine environments by 2030."

The broad resolution goes to the heart of the waste plastics issue. It notes that global production is due to increase by 40% over the next 15 years from current levels of around 300 million tonnes and that the world's "predominant throwaway model" means that over 75% of the plastics ever produced to date are waste, "notably because the price of plastic on the market does not represent all of the costs of its lifecycle to nature or society".

Recalling previous international efforts to set goals for ending marine plastic litter, the motion calls on the international community to reach a wide-ranging global agreement to combat marine plastic pollution. This would entail, among other measures, eliminating unnecessary plastic production, in particular single-use plastic waste; recycling and proper prevention of leakage into the environment; and public awareness campaigns.

Activists say previous international efforts to curb plastic pollution have been toothless. Moudud is among many who want mandatory and enforceable measures, accusing big business of what she calls "manipulative practices through sponsorship and malpractice without helping build the natural world".

"No one is looking or holding the polluters responsible," she says, calling for a toughening up of the resolution. "I am deeply involved in everything IUCN

does to help save the natural world and sustainable living."

Steve Trott, project manager for IUCN-member Watamu Marine Association which is tackling plastic pollution in their Marine Protected Area in Kenya, says Motion 022 clearly sets out the threats posed by plastic waste to marine and coastal environments, economies and human health and well-being.

"Watamu Marine Association and EcoWorld Recycling based on the Kenya coast embrace the IUCN call for action," Trott told IPS.

Pushing circular economy initiatives, their NGO has created dynamic plastic value chains through partnerships between the hotels industry and local communities, sponsoring beach clean-ups and collecting plastic waste for recycling. This provides a second source of income for community waste collectors while local artists are also up-cycling plastic

Reflecting one of the main themes of IUCN's membership structure bringing together civil society and indigenous peoples and government authorities, Trott says Watamu is following a "win-win model which can be replicated and up-scaled, sending out an 'Act Local, Think Global' message to inspire others". He hopes to attend the Congress in Marseille if all goes well.

The Plastic Waste Makers index, a study by Australia's Minderoo Foundation, identifies 20 companies producing more than half of all single-use plastic waste in the world. Some are state-owned and multinational corporations, whose plastic production is financed by major banks. The report notes that nearly 98% of single-use plastic is made from what is called virgin fossil fuels – plastic created without any recycled materials.

Single-use plastics explain why fossil fuel companies are ramping up their production as their two main markets of transport and electricity generation are being decarbonised. By 2050 plastic is expected to account for 5%-10% of global greenhouse gas emis-

Humankind possesses unprecedented levels of knowledge but also the accompanying responsibility, knowing that oceans are in the poorest health since humans started exploiting them.

Single use plastics - and the estimated 130 million tonnes that are dumped each year around the world - have dominated studies and discussions on waste. Plastic bottles, food containers and wrappers, and single-use bags are the four most widespread items polluting the seas.

One element woven into similar narratives of how to tackle the world's burning environmental issues - such as carbon emissions, species loss, and plastic waste - is the potential fix offered by technology. Motion 022 refers to the need for more investment in environmentally sound plastic waste collection, recycling and disposal systems as well as forms of recovery. A study led by biologist Nikoleta Bellou at the Helmholtz-Zentrum Hereon institute focuses on inventive sea-cleaning solutions to date, including floating drones. But her paper suggests that it could take about a century to remove just 5% of plastics currently in the oceans using clean-up devices because plastic production and waste are accumulating so fast.

Activists welcome IUCN's intervention on plastic waste pollution and the strong mandate a successful and unanimous motion can convey to governments and international institutions.

But they also caution against taking too narrow an approach towards tackling marine pollution at the September 3-11 Congress.

Eleonora de Sabata, spokesperson for the Clean Sea Life project, co-funded by the European Union's LIFE programme, told IPS that the narrative needs to shift away from single-use plastic to single-use everything. "Technology" has come up with so-called 'bio' plastics as a replacement for some plastics but only to create a whole suite of problems of their own.

"It's the throwaway culture that creates problems, whether plastic or not. Green washing and sloppy leadership are filling our world of single use," she

Washing our consciences by simply substituting single-use plastics with other single-use items, such as supposedly biodegradable bags and cutlery, are

## Minister showcases its achievements recorded in 100 days of President Samia Suluhu Hassan

THE Ministry of Livestock and Fisheries has unveiled several achievements recorded within 100 days since Samia Suluhu Hassan was sworn in as the sixth President.

The activities were lined up to be executed in the 2020/2021 financial year and most of those tasks were based on President Samia's directives in various forums to improve the livestock and fisheries.

The minister in the portfolio, Mashimba Ndaki, said during the 100 days, the ministry is building two deepwater wells in Iringa District Council (Usolanga) and Mpapa (Manyoni). Its construction has reached 70 percent and 30 percent respectively. The ministry has rehabilitated three dams of Chamakweza (Chalinze), Kimokoua (Longido), and Narakauo (Simanjiro).

According to Ndaki, the ministry has set aside 32,044.21 hectares of land for grazing in three districts of Tanganyika, Nsimbo and Mlele.

"During this period, the government has provided training and licensing to 340 butchers in Dar es Salaam's Kinondoni and Temeke abattoirs. We've also provided equipment to 34 skin inspectors in Mwanza, Simiyu, Shinyanga and Mara regions. The idea here is to ensure that skins/hides meet standards needed by industries," he said.

"The Magena livestock market in Mara Region has been opened to facilitate livestock trade between Tanzania and Kenya. Also, the construction of the Buzirayombo secondary livestock auction in Geita Region has reached 50 percent. The aim is to improve livestock trade within and outside the

According to Minister Ndaki, a total of 146 indigenous cattle in Iringa Region and 152 cattle in Singida Region were analyzed to identify and maintain indigenous cattle breeds.

The Ministry of Livestock and Fisheries (Livestock Sector) on behalf of the United Republic of Tanzania and the Ministry of Agriculture, Zanzibar's Ministry of Irrigation, Natural Resources and Livestock met and agreed to develop practical cooperation at departmental and institutional levels under those Ministries to strengthen the sector on both sides of the union so that they can contribute more to economic growth and human develop-

So far, Tanzania has 33.4 million cattle; 21.3 million goats and 5.65 million sheep, more than 1.85 million pigs, 47.4 million indigenous poultry and other non-conventional species such as donkeys and rabbits

On fisheries, the minister said: "The fishing industry is one of the economic sectors in the country. Fishing activities contribute to food security,

nutrition, income generation, poverty reduction, foreign exchange and contributing to GDP."

Some of those achievements are the completion of the construction of three offices of Fisheries Management Groups (BMU) in Pangani (Kipumbwi), Mkinga (Zingibari), and Bagamoyo (Dunda) districts, the minister said.

Other achievements include improving the enabling infrastructure for fishing activities by commencing the construction of six fish markets in Lake Victoria Zone, construction of the Mbamba Bay-Nyasa fish market in Ruvuma Region, and plans to rehabilitate Ferry international fish market in Dar es Salaam starting this month.

The government has set aside 50bn/- in the 2021/2022 budget for the construction of the Fisheries

Port in Mbegani - Bagamoyo area;

The launch of the Gender Desk in the Fisheries Sector to enable women to participate effectively in the blue economy through the Fisheries Sector and new Regulations for the Management and Development of deep seas fisheries have been prepared and published in Government Gazette no. 334 dated April 23,

The ministry is also promoting investment opportunities available in the fishing industry through national conferences comprising guests from the Kingdom of Saudi Arabia, the People's Republic of China, and the United Arab Emirates.

"In addition, this led on June 22, 2021, for the first time the Deep Sea Fishing Authority (DSFA) to collect a total of US \$ 800,000 equivalent to 1.84bn / - payment for deep seas

fishing licenses for 22 vessels after foreign ships to stop taking Tanzanian licenses in 2017/2018 caused the government to lose revenue and DSFA to fail to operate itself," he said, adding:

"We've purchased twelve boats and six engines for strengthening the protection of fishing resources,'

According to Ndaki, Tanzania Fisheries Research Institute (TAFI-RI) has successfully enabled 100 fishermen in the Indian Ocean coast to fish effectively by providing them with information on marine fish stocks.

DSFA completed the preparations and enabled the Ministers responsible for the United Republic of Tanzania and Zanzibar Fisheries Sector to sign the New Seas Fisheries Regulation and Development 15m/-to increase production.

Regulations of 2021 and came into force on April 23, 2021. The authority has completed the protection of fishery resources and illegal fishing-related activities in the Exclusive Economic Zone (EEZ) which it manages by using its ship tracking systems were on April 23, 2021 it captured and secured the Hg boat flying the Iranian flag containing 859.36 kilograms of drugs.

To take advantage of the Blue Economy opportunities through the aquaculture industry, the government has allocated 18bn/- which will be used to build, rehabilitate and expand infrastructure in six aquaculture development centers in Mwamapuli (Tabora), Ruhila (RuvumaO, Kingolwira (Morogoro), Nyengedi (Lindi), Machui (Tanga), and Rubambagwe (Geita).

This measure will help alleviate the problem of shortage of quality fish fry by increasing production from 2 million chicks to 8 million per year, improving the provision of extension services especially providing practical training to at least 3,000 people to encourage and enable fish and other aquaculture productively and profitably and expand the scope of extension services, as well as establishing 40 demonstration fish farms to be managed by youth and women's

"This is the beginning of the implementation of the ambition of having demonstration farm in every council across Tanzania to promote fish farming for improved nutrition, income generation and economic growth."

The minister said that in order to encourage the development of marine living resources, seaweed farmers in the Mkinga (Tanga) and Mchinga (Lindi) areas as well as Bagamoyo - Coastal reef breeders have purchased equipment worth

## Govt to provide sunflower seedlings subsidy to farmers

THE government is working on a special plan to start providing sunflower seeds subsidy to farmers so as to improve production of the crop in the

Deputy agriculture minister, Hussein Bashe, said that the ministry was determined to increase the availability of improved sunflower seeds at a tune of more than 3,900 tonnes, compared to 886 tonnes estimated to be pro-

duced during the year 2021.

He said the government also eves to heighten production of sunflower from 790,000 to a total of 1,600,000 tonnes, something which will also spearhead the country's efforts to minimize importation of edible oil.

Bashe said that the target is aimed to ensure a total of 35 sunflower oil industries in the country have capacity of processing at least 650,000 tonnes, with 741 other small scale factories to process a total of 1,111,500 tonnes.

"We are working tirelessly to mobilize all potential edible oil resources the country has been endowed with in order to overcome the challenge of acute shortage of cooking oil within the country," Bashe

ministry would motivate and supervise contract farming among the farmers and sunflower processors in order to propel for vast cultivation of the crop. "At ministerial level, we are planning to implement several useful strategies

to ensure increased research on improved sunflower seed varieties, development of agriculture infrastructures as well as provision of deserved extension services towards the sunflower growers," he detailed.

Statistics show that Tanzania He added that the parent imports more than 365,000 metric tons (MT) of edible oil annually which costs the government at least 443bn/-.

The National Coordinator for Sunflower Research, Frank Reuben told The Guardian in an interview that the institute has already developed a key

road map to produce a total of 45 tons of Pre-basic and basic seeds, to be distributed to different seeds companies for mass production.

He briefed, in order to implement the robust initiative successfully, TARI has set to work in partnership with several companies and institutions.

They are the Agriculture Seed Agency (ASA), BioSustain Tanzania Limited, TERMAR, RUDDI, AGRI-SEED Technologies, Southern Highland Seed Growers, Lima Africa, Inades, Agricpays Tanzania Ltd, and registered farmers working with Clinton Foundation and World Vision Tanzania.

"The companies will be responsible to produce at least 4,500 tonnes of seeds, to be certified by the Tanzania Official Seeds Certification Institute (TOSCI)," he stated.

He expressed that, according to the set schedule, the seed tons to be produced will be used to produce 2 million tonnes of sunflower grain for processing.

"This programme is expected to play a paramount role in helping the county contain a shortage of edible oil, as well as reduce importation of sunflower seed varieties," he insisted. On June 13 this year, Prime Minister Kassim Majaliwa launched the national strategic campaign for the mass investment and production of sunflowers in the country.

In his keynote speech at the Social Training Centre -RC Mission, in Singida Region, the premier said the campaign was meant to ensure the country overcome edible oil shortage within a period of two years.

## Water project provides relief to locals in Mara's Masanga village

ACCESS to clean, sufficient, onsight and affordable water presents a major challenge for billions of people around the world.

The World Health Organization estimates that 785 million people lack even basic drinking-water service, while a quarter of the world's population only has access to contaminated sources, the cause for widespread water-born diseases. Of great concern is access to safe water and adequate supply for health care facilities.

In response to this challenge the Dicastery for Promoting Integral Human Development in 2020 launched a project aimed at addressing the situation regarding water, sanitation and hygiene, called "WASH", in Catholic health care facilities around the world.

The project carried out a worldwide survey and then developed strategies and concrete responses for those greatest in need. The project continues today in partnership with Catholic Relief Services, Caritas Internationalis, and Global Water 2020, among others, to network knowledge, best practices, and funding on a vital issue for all.

The Catholic Church runs almost half of all health care facilities around the world where they are practically non-existent, due to poverty or inability for regions to provide healthcare in remote areas. Access to clean, dependable,



on-sight water is essential for providing these services. Without clean water, sinks, soaps, toilets and hygiene procedures, billions of patients, care staff and families are placed at risk because there is no foundation or infrastructure for decent, safe, quality care.

"Fresh drinking water is an issue of primary importance, since it is indispensable for human life and for supporting terrestrial and aquatic ecosystems. Sources of fresh water are necessary for health care (...).One particularly serious problem is the quality of water available to the poor. Every day, unsafe water results in many deaths and the spread of water-related diseases, including those caused by microorganisms and chemical substances. Dysentery and cholera, linked to inadequate hygiene and water supplies, are a significant cause of suffering and of infant mortality.

A concrete example of this reality can be shared by Daughter of Charity Sister Bibiane Bokamba who heads a Church-run health center and dispensary in Masanga, Tanzania, a remote town in the northwest bordering Kenya. She also runs a "DREAM Center" health facility next door. DREAM is a health program established by the Community of Sant'Egidio, in collaboration with the DREAM Foundation, to treat and prevent HIV/AIDS in Africa, but over the years the scope has widened to promote universal health in Africa with DREAM standing for "Disease Relief through Excellent and Advanced Means".

The facilities run by Sister Bokamaba are the only ones to be found in the area with the nearest town a three-hour distance by car. The centers provide close to 400 medical visits per month, in addition to basic

care and counselling for those seeking it. Close by there is also a primary school. The economy in the area and sparsely populated small villages is mainly agricultural, with survival a major challenge for most. Until just over a year ago, water needs were desperate, given that they did not have enough wells or ways to collect water. In addition, assuring safe drinking water was not possible. But then Sister Bokamba worked with the community to get involved in upgrading the water and sanitation infrastructure by partnering with several charitable NGOs working in the field, also in conjunction with the Dicastery for Promoting Integral Human Development.

Thanks to these efforts, more than fifty thousand people now have access to clean water, which supplies the health and Dream centers, essential for their services. Sister Bokamba says now, "We have clean water. We made a well. We bought the tank also to collect water from the rain, so we can keep it and use it" The rainwater collection helps them get through the dry summer months, something that was not possible before a new well was drilled with three tanks linked to it. While the situation has greatly improved, she is hoping to add more wells, since the needs for the population are great.

"We need to add more water. We can build a well like we did at the hospital. So I think we need to be helped again for the water." At the same time, the water supply for the health and Dream centers has saved countless lives. "So our hospital is helping a lot of people", Sister Bokamba says, and "everything for us is a really big help for the population".

The Dicastery for Promoting Integral Human Development released last year a document entitled: "Aqua fons vitae - Orientations on Water, symbol of the cry of the poor and the cry of the Earth". The text looks at the social teachings of the popes, local churches and underscores the importance of water for all as an essential resource that must be safeguarded. Sister Bokamba can relate to it wholeheartedly, based on her own lived experience and that of those she serves in Masanga, Tanzania

HE insurgency in northern Mozambique should have taught southern Africa the obvious lesson that it's safer, cheaper and more effective to resolve conflicts before they explode. Having largely neglected the Cabo Delgado crisis for several years, the Southern African Development Community (SADC) has now decided to send a military force into the province.

Early warning systems are designed to avoid taking such drastic and precarious action – and SADC has such a system. But does it heed early warnings? In Eswatini, for example?

Low-level protests have been simmering there for weeks. They escalated on Saturday into serious rioting that has continued since then. Scores of government buildings, shops and banks – including several South African-owned businesses - and vehicles have been looted or torched. According to opposition activists, the security forces clamped down harshly, killing at least 40 protesters and injuring about 150 by 1 July.


Eswatini is rife with rumour, in large part because the government shut down the internet. On 28 June, King Mswati was widely reported to have fled the country. This was denied by acting Prime Minister Themba Masuku, who insisted the king was still on his throne, governing the country.

Nevertheless, the crisis shows signs of spiralling out of control. Eswatini's periodic episodes of protests against autocratic rule have in the past eventually burnt themselves out. But this one looks more serious and many are calling it an uprising.

The fundamental problem and the common denominator in these disturbances is the country's democracy deficit. Eswatini likes to present itself as a democracy and even has a constitution that says as much. But the constitution is ambiguous – and probably deliberately so.

Instead of the conventional multi-party variety of democracy, Eswatini has the tinkhundla system. Fifty-nine tinkhundla or administrative subdivisions across the country each elect one representative – chosen on merit, not party af-

filiation, as parties are forbidden - to the House of Assembly. This is the lower chamber of the bicameral Parliament. In theory, power is thereby devolved from the centre to the tinkhundla.

In practice, however, Mswati remains an absolute monarchy, not a constitutional one, so the rest is all essentially windowdressing or democratic opera.

In a country where democracy is meagre, such democracy as is on offer arguably becomes more important. The current explosion of protests appears to have been detonated by the government denying even this partial democracy.

Three dissident Members of Parliament (MPs) had called for the prime minister to be elected instead of appointed by the king. Many ordinary citizens began delivering petitions to their MPs supporting the call. In response, Masuku banned the in-person presentation of petitions by citizens to their MPs at their various tinkhundla (the equivalent of conventional constituency offices).

On Saturday, protests erupted in the rural town of Siphofaneni, about 50 km south-east of the capital Mbabane, over this repressive measure. The demonstrations rapidly descended into looting and burning and destruction of shops, government of-

fices and vehicles. And then spread to other towns.

Masuku blamed the local MP, Mduduzi 'Gawuzela' Simelane, a vocal reformist, for stoking the flames by agreeing to receive his constituents' petitions, despite the ban. Masuku insisted the government had heard the grievances of the people and would respond.

He insinuated that the ban on physical delivery of petitions was more about Covid-19 than anything else and gave an email address for delivering grievances. This elicited some wry commentary on Twitter, including by one user who noted that the government had shut down the internet to smother the protests – so how were they to email their

Covid-19 does seem to have been a background factor in the unrest. Mswati may not have physically fled the country, but he's been noticeably absent from the public space to protect himself from infection. That has apparently loosened his hold on power. And the pandemic killed the capable prime minister Ambrose Dlamini in December last year. Local journalists say Masuku has been a poor substitute, and this has further weakened Mswati's grip on the country, including in Parliament where the dissenters have become increasingly vocal. And Covid-19 and its lockdown measures have also aggravated the plight of the ordinary people, thereby fuelling the protests.

The political opposition has called on the region, particularly South Africa, to intervene but Pretoria hasn't responded. On 1 July it issued a mildly critical statement calling on all sides to exercise restraint. The ruling African National Congress was sterner, saying Mswati's government should desist from "autocracy, strong-handed crisis management and brutal repression of legitimate civilian concerns".

It also called on SADC to intervene, as did Simelane. The disturbances are surely early warning signs of more serious conflict and instability in Eswatini. SADC should be sitting up and paying attention, offi-

cially, one would think. The SADC Protocol on Politics, Defence and Security Cooperation empowers it to "seek to resolve any significant intra-state conflict" and says SADC's early warning system is intended "to facilitate timeous action to prevent the outbreak and escalation of conflict." This may include preventive diplomacy, negotiation, conciliation, mediation, good offices, arbitration or adjudication.

ISS Today asked Habib Kambanga, head of SADC's Regional Early Warning Centre (REWC) in Gaborone, whether the centre was monitoring the disturbances and if it might alert SADC member states of possibly deeper conflict. It also asked whether Eswatini would be placed on the agenda of the SADC Organ on Politics, Defence and Security Cooperation.

"SADC REWC is monitoring political and security threats in all member states including Eswatini," he replied. "According to the officials in Eswatini, the situation is not out of hand. so if that is the case, it cannot be an agenda item for SADC meetings for now."

But surely it shouldn't be the sole or even the main prerogative of the country where early warning signs are flashing, to judge whether serious conflict is in the offing? Regional early warning must provide an objective assessment of threats - and so it should be the region, not the troubled member state in question, that makes that call. **DM** 

## Wu Tianyi: 'Guardian of life' on Qinghai-Tibet Plateau

Tianyi, 86, is a member of the Chinese Academy of Engineering and former research fellow with the Qinghai Province Cardiovascular and Cerebrovascular Disease Specialist Hospital.

As a pathfinder of Chinese hypoxia physiology and high altitude medicine, Wu has worked on plateaus for over six decades. He made international standards on the prevention and treatment of altitude sickness, initiated studies on high altitude adaptation in Tibetans, and diagnosed and treated more than 10,000 Tibetan patients. He's nicknamed "doctor on horseback" by local residents.

Responding to the call of the nation to build the Qinghai-Tibet Plateau, Wu came to the northwestern province of Qinghai for work in 1958, where he saw many constructors fall ill and even sacrifice their lives due to anoxia and low pressure.

Back then, high altitude medicine was still an area that no one in China had ever stepped onto, so he determined to get somewhere in this specific field.

To find the cause for altitude sickness and acquire more reliable information, Wu went on

extremely high altitudes.

field trips to remote places with frastructure was still poor on the plateau, so he and his colleagues had to ride horses and have yaks carry instruments and devices. Fighting with altitude stress, Wu slept in tents and lived on frozen bread and

snowmelt. During the past dec- it too fast, which led to an acute ades, he has left his footprints in most of the high-altitude areas in Qinghai, Gansu and Sichuan provinces, as well as Tibet and Xinjiang Uygur autonomous regions.

He has collected millions of pieces of scientific data, laying a solid foundation for the study of high altitude medicine.

Different from general medical studies, high altitude medicine would place researchers in harsher natural environments. Wu has had 14 bone fractures during his field trips. Once four of his ribs were broken, with one almost piercing into his heart. However, he just said that dedication is important for everyone who studies high altitude medicine.

In early 1990s, Wu designed the largest comprehensive hypobaric-hyperbaric chamber in China which was able to simulate pressure ranging from 12,000 meters above the sea level and 30 meters under it. The device played an vital role in the study of high altitude medicine.

After conducting animal experiments. Wu volunteered to be the first human going into the chamber, taking high risks. "I designed it, and I must be the first to try it," he said. Due to a lack of operational experience, the operator of the chamber decompressed

headache of Wu and an eardrum rupture.

Even so, Wu continued the experiment after his eardrum was recovered, but his hearing ability was very much impacted.

Later, his experiment results were massively applied. During the construction of the Qinghai-Tibet railway, which features the highest elevation in the world, Wu made a series of prevention and treatment plans for altitude sickness, as constructors must maintain high work intensity at an altitude of over 4,500 meters.

Under his suggestion, 17 oxygen generation stations and 25 hyperbaric chambers were built up along the construction route, which successfully rescued nearly all who were struck by acute altitude sicknesses, including encephaledema and pneumonedema.

No death was caused by altitude sickness among the 140,000 railway constructors, which was a miracle and earned Wu the tile of the "guardian of life."

Today, Wu, in his eighties, is still working on the plateau region wearing a cardiac pacemaker. Every time someone persuades him to retire, he would refuse and say that the Qinghai-Tibet Plateau is where his career lies.

## **Dar's National Institute of Transport applauds China** over transformation plans

PLANS to transform National Institute of Transport into a university backed by Chinese grant of US62 million for a few African institutions of higher learning are at advanced stage.

NIT Rector Professor Zacharia Mganilwa said in Dar es Salaam last week that Tanzania is among beneficiaries of the Chinese governments' five mega transport universities project to improve logistics for trade and investment for better partnership with the

"We thank the Chinese government for their support in upgrading our institute into a transport university. We are now waiting for them to sign a contract as that the project can move to the next stage of implementation," Prof Mganilwa said.

He added that a new NIT University of Transport will come to life soon thereafter as China which also financed the construction of TAZARA railway line backs training of highly skilled manpower to manage transport and logistics in the country.

The NIT chief further noted that the transport university will incorporate College of Railway and Road Engineering Technology, College of Aerospace Science and Technology and College of Transport and Allied Sciences.

"The Chinese' Southwest Jiaotong University did the feasibility study for the upgrading of NIT into a transport and design of the campus," he underlined saying it will serve countries in East and Central Africa.

Prof Mganilwa pointed out that under the deal, the university will also receive modern high-tech teaching machines and equipment to cater for the needs for rapidly changing and logistics industry with disciplines in aviation, railway, maritime and road network.

Tanzania which through Dar es Salaam Port serves several landlocked countries needs highly qualified personnel to manage it transport and logistics industry. Beneficiaries of the Chi-

nese back plan also include Kenya, Uganda, DR Congo, Burundi, Rwanda, Uganda, Malawi and Zambia.

"NIT as a higher learning institution is undertaking deliberate measures to ensure availability and sustainability of experts in the transport and logistics industry," he added while noting that the

## China halts Kenya loans amid debt reprieve bid

**NAIROBI** 

CHINA has frozen disbursements of active loans to Kenyan projects in the wake of differences over Nairobi's bid to extend debt repayment holiday to December. Chinese-funded projects are facing a cash crunch, with contractors reporting delayed payments from on condition of anonymity. The banks like Exim Bank of China.

Executives at State-owned firms say the projects risk delays due to the funding hitch. Sources familiar with the delay say the Chinese lenders, especially Exim Bank, are uncomfortable with the terms of the Kenyan request for extension

of the debt service suspension beyond June.

"Payment to contractors working on Chinese projects and paid under direct method have delayed since last month. We are told Chinese banks are not settling invoice because of the moratorium," said a CEO of a State corporation who spoke direct method involves Kenyan firms with Chinese loans sending notices for supplier payments to Chinese banks through the Treasury.

China is one of Kenya's biggest foreign creditors, having lent Sh758 billion as at April 2021 to build rail lines, roads and other infrastructure projects in the past decade. Yesterday, the Chinese embassy in Nairobi acknowledged the funding hitch, adding that the matter was being addressed by officials of the two countries.

"To my knowledge, the relevant parties of the two sides are in close communication on specific issues under the DSSI framework," said Huang Xueging, the Chief of Information embassy, said in email response to the Business Daily questions on delayed release of loans.

"They are in communication with each other on this matter also under the framework of DSSI (Debt Service Suspension Initiative (DSSI)." Kenya's Treasury officials denied delays in release of Chinese loans, saying the country had received positive response from all countries where they sought an extension of the debt repayment relief.

"Not true," Finance Cabinet Secretary Ukur Yatani said. "I am not aware. All creditors have been very responsive," Director of the Public Debt Management Office Haron Sirma said. In January, China and other rich countries under the under the Debt Service Suspension Initiative (DSSI) gave Kenya a sixmonths debt repayments relief.

The impact of the Covid-19

pandemic has battered Kenya's tax revenue collection at a time when more of its debts are falling due and as it is still grappling with gaping fiscal deficits. Now, Kenya is seeking deals to suspend debt service with the rich nations under the Paris Club and other creditors, including China, covering the six months to the end of December.

The G20 countries, including Belgium, Canada, Denmark, France Germany, Italy, Japan, Republic of Korea, Spain and the USA, rescheduled payments of Sh32.9 billion in principal and interest due between January and June to the next four years with a one year grace

period. The International Monetary Fund (IMF) has disclosed that Kenya had sought an extension of the debt relief from G20 countries to December, saving an additional Sh39 billion (\$361

While China is a G20 member and a signatory to the deal, a large proportion of its loans to Kenya has been made on a commercial basis by government agencies, quasi-public corporations and by state-owned banks, such as China Development Bank and Exim Bank of China. China has sought to negotiate its debt relief deals separately, but applying the same terms as the G20 countries

while reserving the right on size and which loans will attract the moratorium.

The World Bank had estimated that Kenya could save Sh55.9 billion from China between Ianuary and June under the DSSI deal in principal and interest payment freeze. But China announced that Kenya would be granted a Sh26 billion (\$245 million) relief.

It is unclear how much relief the government was asking for and which specific loans were waived. But parliamentary disclosures indicated a portion of the relief came from the standard gauge railway financier China Exim bank.

## **Industry touts blockchain tech as** catalyst to lift intra-African trade

THE burgeoning blockchain technology will soon have a stimulating effect on intra-Africa trade, especially as the continent emerges from the COVID-19 pandemic, industry players say.

The insiders say blockchain technology provides a decentralised layer of trust between parties, which is critical to trading, and will soon be a key catalyst to economic growth on the continent. The caveat comes at a time the continent is implementing the African Continental Free Trade Area Agreement (AfCFTA), which, if successfully implemented, will create a single African market of over a billion consumers.

Louis du Plessis, head of trade finance at RMB, says despite the laudable ambitions of AfCFTA, intra-African trade is yet to gain momentum, and digitalisation, especially use of blockchain technology, can uplift trade on the continent. "In Europe and Asia, intra-regional trade is well above 50%. It lays bare the enormous potential for much higher volumes of trade on the African continent.

"There is no reason to think intra-African trade couldn't rise 20% to 30% within the next five years with the use of digitisation and blockchain. It will help circumvent the long-running factors which have held trade back, such as costly processes, a lack of finance, and a lack of trustworthy systems that those trading with other countries can rely on.

"Over the last two years, we have seen significant growth in blockchain projects across the whole trade value-chain, including trade finance, supply chain, shipping and freight, as well as digitisation of trade documents.'

Africa is mellow

Similarly, Carel de Jager, a consultant at the Blockchain Academy, says Africa is ripe for blockchain adoption, especially in the payments landscape, which has no real barriers to implementation. "If regulatory guidelines that foster innovation and freedom are adopted, it would place the continent in a very favourable position to lead the world by example," he says. De Jager believes blockchain-facilitated payments are very mature and plug-and-play solutions already exist that can be implemented with little effort.

"These alone have the potential to massively benefit the continent. Africa has thousands of payment methods, but they are often bound to geographical jurisdictions and, therefore, don't speak with each other. There is lots of friction that erodes value when payments are attempted to bridge these networks. Money trails are often opaque or non-existent. A blockchain rail works seamlessly, and can include smart conditions like escrow or multi-party authentication for free."

However, he cautions that most use cases of blockchain technology other than payments and escrow would require further development and a well-defined policy or regulatory framework before they can be used at scale.

**Bureaucracy rules** 

For Farzam Ehsani, VALR co-founder and CEO, blockchain technology is a solution to many problems that are "fundamentally related to inefficient work flows or poor governance", including trade on the continent. He, however, also cautions that while blockchains may help in some domains, "we have a lot of work to do to improve our governance structures in society which will ultimately determine the extent to which we can progress as humanity."

## Stock markets on edge over Delta virus variant, Fed policy

Eswatini's biggest mobile operator, MTN, has been sued after the company cut off users' access to the Internet on 29 June in line with a government directive.

JSE-listed MTN Group, which owns 30% of MTN Eswatini, said on Friday that it is one of several respondents cited in the legal action. Others include the state-controlled Eswatini Mobile and Eswatini Telecommunications as well as acting Prime Minister Themba Masuku and his communications minister. Eswatini was previously known as Swaziland and its government is an absolute monarchy.

MTN confirmed that the legal action is aimed at "the immediate restoration of Internet services in the country". The action was brought by the Institute for Democracy and Leadership (Ideal) as well as several youth organisations.

The matter was heard by the high court on Eswatini on Friday and the respondents were granted leave to file papers next Tuesday, 6 July.

"The application follows a directive on 29 June from the Eswatini Communications Commission to MTN Eswatini and other operators to suspend access to social media

and online platforms until further notice," MTN said. "After carefully assessing the directive, and in line with its licence conditions and the group's digital human rights due diligence framework, MTN Eswatini implemented the directive.'

The government ordered the operators, including MTN, to suspend access to social media – and the Internet generally – after the impoverished landlocked nation was rocked by pro-democracy protests. Protestors are demanding the departure of King Mswati III and the implementation of a democratic dispensation.

#### Uganda suspends operations of eight labour export companies over 'irregularities'

THE Ugandan government has suspended operation of eight labor export companies over human trafficking and forgery of documents, a spokesperson said here on Monday.

Frank Mugabi, the spokesperson for the Ministry of Gender, Labor and Social Development, told Xinhua by telephone that the recruitment companies were involved in forgery of documents submitted

to the ministry for the renewal of their operations, trafficking in persons and receiving money from potential migrant workers without deploying them abroad.

"Some of these companies have been involved in forgery of documents, faking bank guarantees and some were trying to take people out (abroad for jobs) without due clearance from the ministry of labor and security (agencies)," said

"Some of them have accumulated claims; they have been receiving money from people and not deploying them for all the promised jobs.

That is not acceptable." "You are only allowed to pick money from people for facilitating their transfers abroad when the jobs are available."

Mugabi said the ministry has terminated the license renewal of Top Notch Recruitment Services Limited, Fly International Jobs and Sahara Recruitment Agency Limited over submitting forged documents of tax clearance and faking bank guarantees.

## Global taxation nears historic deal amid last-minute hurdles

#### **WASHINGTON**

THE Biden administration and global allies scored a major victory Thursday in their push for a more balanced international corporate tax system, but still face multiple significant obstacles to completing an ambitious plan that has been years in the

The boost came during a round of talks hosted by the Organisation for Economic Cooperation and Development, where 130 countries and jurisdictions backed a plan to set a minimum corporate tax rate and establish a new regime for sharing the taxes imposed on the profits of multinational firms.

Even as governments hailed the news - US Treasury Secretary Janet Yellen called it "an historic day for economic diplomacy" - the agreement remains well short of a done deal. A handful of countries refused to sign on. Most importantly, resistance came from three European Union members, any of which could prevent the 27-member bloc from implementing the plan.

The US Congress could also prove a major obstacle, since the legislature's approval would be required to formalise Washington's participation in the system, and President Joe Biden's Democratic party holds razor-thin majorities that are at risk in next year's midterm elections.


"This will level the playing field and make America more competitive," Biden said in a statement, calling on Congress to pass his tax proposals. Multinational companies "will no longer be able to avoid paying their fair share by hiding profits generated in the United States, or any other country, in lower-tax jurisdictions," he said.

Thursday's deal leaves several details in the proposals unresolved, including important questions over how and when some countries' unilateral taxes on tech firms' revenue will be rolled back. All that casts next week's meeting of Group of 20 finance ministers in Venice in a new light, freeing officials to focus more on topics such as containing the Covid-19 pandemic rather than struggling to reach a deal on

taxes. It could also represent a chance for senior officials to get on immediately with unfinished tax business.

"This will be the kickoff to the last stretch" leading up to the G-20 leaders' meeting scheduled for October 30-31 in

Rome, said Lilian Faulhaber. a law professor at Georgetown University who specialises in international tax issues. "Venice gives them an opportunity to see exactly where are the areas of work that remain."

Minimum rate

The overhaul is aimed at helping countries share the spoils from multinational firms like Facebook Inc. and Alphabet Inc.'s Google, with implementation targeted for 2023. The rules would curtail tax avoidance by making global enterprises pay an effective rate of "at least 15%." They could also give some smaller countries room to collect more from foreign firms by taxing business activity within their borders, though other small nations could see tax revenue fall.

Several key countries that had been question marks agreed to the terms, including India, China and Turkey, according to the OECD. In fact, Argentina and Turkey came on board at the last moment, according to officials familiar with the negotiations, and the technical details may leave room for further concessions to developing economies.

Japan's finance minister acknowledged there were some countries in disagreement, but he said there was still time to bring them on board and their opposition wouldn't necessarily derail the path toward a final deal. "We're going to carefully work to convince the remaining nine countries to join us for a final agreement of all nations by October," Taro Aso said Friday.

#### China's position

India's finance ministry on Friday flagged that "significant issues" still need to be addressed about the tax rules, adding that it expects a consensus agreement by October. China's Foreign Ministry spokesman Wang Wenbin sidestepped several questions seeking clarification on the government's position on the tax agreement during a regular press briefing in Beijing Friday.

"China is willing to uphold multilateralism with all countries and inject new impetus into the global economic recovery," he said. "We hope we can better accommodate the interests of developing countries and properly handle the concerns of all relevant parties."

Most of the remaining holdouts can effectively be ignored without endangering the deal - except for EU members, because implementing the new rules there would require an EU directive, a legal act that must be approved unanimously by all 27 members.

That means Ireland and Hungary, which refused to back the plan, could effectively veto adoption in the EU, or at least force the bloc to resort to exceptional and untried legal measures for implementation. Hungarian Finance Minister Mihaly Varga said in a statement on Friday that the 15% rate is too high, but that his government would continue "constructive" talks.

#### **Unrelenting coal demand poses** huge challenge to climate goals

#### **SYDNEY**

COAL prices across Asia are surging to records, underscoring a challenge for governments seeking a faster energy transition: the dirtiest of fuels they're racing to phase out is enjoying booming

Power plants are rushing to secure adequate electricity supplies as a hot summer adds to demand from the region's post-pandemic industrial revival. On top of that, output in some key producer nations has been hurt, while high natural gas costs mean there's no cheaper alternative for utilities to turn to.

All that has sparked a coal rally in Asia, the centre of demand for the fossil fuel. The price of physical coal cargoes in Australia's Newcastle and China's Qinhuangdao ports have soared more than 50% this year to their highest ever. Futures are also up, with those in Australia jumping almost 50% and prices in China more than doubling. "Coal prices just keep on punching higher," said Sydneybased Peter O'Connor, an analyst at Shaw & Partners. "We're close to the top in terms of pricing, but I don't think we're there yet.'

The rally is highlighting coal's enduring role in the world's energy mix, particularly in Asia's large and growing economies, despite a broader push for more aggressive action to tackle climate change. Coal accounted for more than a third of global electricity generation in 2019, according to BloombergNEF. The top three consumers – China, India and the US – are all forecast to burn

"We can see fairly robust pricing toward year-end," Sakkie Swanepoel, group manager of marketing at Exxaro Resources, the South Africa-based miner and coal producer, said on a Tuesday conference call. "We do not see prices just falling off the cliff."

#### Here's what's driving the rally in key markets:

Much of the tightness in the market can be traced back to China. which produces and burns half the world's supply. Power demand is surging as factories take on orders to supply rebounding economies, and domestic mine output has been slowed by safety inspections after a series of deadly accidents and extra scrutiny because of the Chinese Communist Party's 100th anniversary celebrations.

Power plants are looking to imports to fill the gap, with June deliveries expected to top 30 million tons for the first time this year before rising again in July and August, according to analysts at Fengkuang Coal Logistics. The country still refuses to allow Australian purchases amid a geopolitical rift.

Even with government efforts to cool the market – such as releasing stockpiles and pressuring state-owned suppliers not to let bidding get out of hand – prices will hold at elevated levels this summer, especially as the spot market is facing a "pretty serious" shortage, said Huatai Futures Ltd. analyst Wang Haitao.

Producers have shrugged off the loss of a key export market after diplomatic tensions saw China halt Australian coal purchases from late last year. Cargoes of premium thermal coal have quickly found alternative buyers, while suppliers of mid-quality power station fuel and steel-making coal are poised to benefit as India and parts of Southeast Asia ease Covid-related restrictions, Australia's government said in a report this week.

Benchmark prices for higher-quality physical coal at Australia's Newcastle port have jumped 66% this year to a record of \$136.38 a ton, according to China Coal Resource. Newcastle coal futures on Thursday rose to \$131.45 a ton, the highest since March 2011.

Those gains haven't translated into advances for some Australian producers. Yancoal Australia has declined 18% this year to Thursday's close, while Coronado Global Resources has slumped 20%. "Coal is going up, and yet people don't want to invest in coal," O'Connor said. "There is a dislocation between coal prices and equities." Companies including Whitehaven Coal Ltd. have also faced lengthy legal battles over expansion plans.

## Trump bashes New York charges against company, adviser

**SARASOTA** 

FORMER US President Donald Trump on Saturday condemned New York prosecutors for bringing charges against his namesake company and longtime financial adviser, using a campaign-style rally to air a host of grievances.

"It's really called prosecutorial misconduct. It's a terrible, terrible thing," Trump told thousands of supporters gathered outdoors in Sarasota, Florida.

The Trump Organization and its chief financial officer, Allen Weisselberg, pleaded not guilty on Thursday to what a New York prosecutor called a "sweeping and audacious" tax fraud, arising from a probe into Trump's business and its practices.

Weisselberg and other executives were accused of receiving perks and benefits such as rent-free apartments and leased cars, without reporting them properly on their tax returns. The outcome of the investigations and other lawsuits facing Trump could impact whether he decides to run again for

president in 2024. "They've mobilized every power of government to come after me, my family, my wonderful employees and my company solely because of politics," Trump told the crowd.

The rally was billed as a Fourth of July celebration with fireworks, the latest in a series of appearances as the former president tries to keep Republicans' focus on him.

Trump used his speech to denounce the policies of his successor, Democratic President Joe Biden, and repeat his false claim that he lost the 2020 election due to fraud.

He urged his supporters to back his allies in their midterm campaigns as Republicans fight to take back control of Congress from the Democratic Party next year.

Trump dwelt heavily on Biden's policies along the US border with Mexico and rising crime, two issues that Republicans hope to use to their advantage in the 2022 midterm elections.

Trump's image took a beating after the deadly Jan 6 attack on the US Capitol

by his supporters. But some 53 percent of Republicans believe Trump won last year's election and blame his loss on illegal voting, and one quarter of the overall public agreed Trump won, a May 17-19 Reuters/Ipsos poll showed.

#### **Buildup To 2024**

Trump, 75, has dangled the possibility of running for president again in 2024, and his latest rallies mark an effort to keep his base energized and in his camp.

"We are looking at the election, more than looking at it," said Trump of 2024, prompting cheers from the Sarasota crowd.

Many Republicans see an appealing option for a 2024 party nominee in Florida's 42-year-old governor, Ron DeSantis. A longtime Trump ally, DeSantis has been at the forefront of Republicanled fights against strict anti-coronavirus lockdowns, racial justice protests and expanded ballot access.

dates at a conservative conference in Denver in June, DeSantis finished ahead of Trump, 74 percent to 71 percent.

DeSantis' office has said the governor is focused on winning reelection in Florida next year, not aspiring to national office.

Lindsay Gordon, a 35-year-old Sarasota resident who works in retail, said it was her third time attending a Trump rally and she was excited to show her support for the former president. She said she hopes Trump runs again, but thought DeSantis might be a better, less-polarizing alternative.

"I think DeSantis would probably have a better opportunity seeing as he's younger," Gordon said. "Because he's still new and fresh there's still a chance to get people to understand where he's coming from. There isn't as much of this negativity." **Agencies** 

#### Boost for digital transformation in Africa as Huawei pens deal with ATU

NAIROBI

THE African Telecommunications Union (ATU) has signed a Memorandum of Understanding (MoU) with tech giant Huawei that will see African countries and organizations build capacity for ICT transformation.

Under the agreement, Huawei will provide training on skills development, including reskilling and up skilling for ATU members.

The MoU will also see the two organizations collaborate to support local innovation, share information on latest trends, challenges and solutions in Africa and globally, and expand the digital economy as well as rural connectivity, in the continent, through furthering research.

A 2019 report by the United Nations Conference on Trade and Development (UNCTAD) on digital economies established that Africa and Latin America together account for less than 5 per cent of the world's data centers. If left unaddressed, the report concluded, divides will worsen existing income inequalities.

This, coupled with the fact that in least developed countries (LDCs), only one in five people use the Internet as compared with four out of five in developed countries, is part of the motivation for the Huawei-ATU partnership.

Speaking during the signing ceremony held recently in Nairobi-Kenya at the ATU headquarters, Mr. John OMO, Secretary-General of the ATU, praised Huawei for their contribution to Africa: "Huawei has transformed connectivity and made a major contribution to the continent through its investments in digital infrastructure, ICT skills, environmentally-friendly connectivity solutions, and cutting-edge technologies for rural areas.

The organization is a trusted development partner of Africa. The document we are signing today aims at strengthening this partnership." He added: "Africa has a tremendous opportunity to fully grasp the potential from new technologies".

The two organizations have a long history of working together and this new agreement will support African countries, regulators, and citizens benefit from the transition to a digital economy, adopt new technologies, promote secure and resilient networks, and gain the digital skills necessary to drive their economies forward.

Samuel Chen, Vice President at Huawei Southern Africa region thanked the ATU for leadership and promotion of ICTs in Africa: "The ATU is playing a critical role in the region supporting member countries with their policies and strategies, sharing best practices, building capacity and driving innovation and we are delighted to be able to support them".

He noted: "We have connected hundreds of millions of Africans to secure, high-speed broadband and cloud solutions in the last two decades and earned the trust and support of our customers and regulators; we look forward to doing even more".

According to the MoU, the partners will also start offering cutting-edge trainings to ATU members, access to global experts to discuss the latest technologies and trends, and collaboration on research to help progress the continent's digitization.

#### WASHINGTON

THE remainder of the condominium in Surfside, Florida, that partially collapsed last week will be demolished as soon as Sunday, a local fire official said Saturday as the death toll from the disaster rose to 24.

Miami-Dade Fire Rescue Assistant Fire Chief Raide Jadallah told affected families during a morning news conference that the remaining part of the Champlain Towers South would be brought down "as soon as possible. First thing tomorrow."

He added that the plan is contingent upon further discussions, as a follow-up meeting will be held in the afternoon to finalize details of the demolition.

Also during the briefing, Miami-Dade Mayor Daniella Levine Cava said two more victims were found in the rubble, bringing the death toll to 24 while there are 124 people who remain unaccounted for.

Florida Governor Ron DeSantis said Tropical Storm Elsa's expected arrival in South Florida has made the demolition of the still-standing part of the building necessary.

### European Left Party president praises CPC for respecting different cultures

**BRUSSELS**

## Kremlin says US is behind provocation with British destroyer

MOSCOW

PROVOCATIONS similar to the one involving the British destroyer HMS Defender in Russia's territorial waters off Crimea are masterminded in the United States, Kremlin Spokesman Dmitry Peskov said yesterday.

"I think our intelligence certainly knows who made a decision there [in the situation with the British destroyer]. But certainly I think such operations are basically planned by senior partners from overseas," Kremlin told Moscow. Kremlin. Putin TV program on Rossiya-1 channel.

According to him, "in this case the destroyer was just a tool of provocation."

"And President Vladimir Putin explained that thus some weak spots are sounded out both in the system of monitoring the border integrity and the response system. This is a deliberate and well-planned provocation," he stressed.

#### Respond to provocations

Russia will respond harshly to provocations similar to the incident with the British destroyer, Kremlin Spokesman Dmitry Peskov (pictured) told.

"This is indeed so," Peskov said, agreeing with a stance that in such situations Moscow will act harshly.

He commented on a remark that Russian President Vladimir Putin's reaction "was very harsh and it is clear that no provocations should be repeated, the response will be in accordance with the charter that says - to sink."

Meanwhile, the Kremlin spokesman noted that he does not back the discussion on such doomsday scenarios. "But obviously, the reaction will be certainly harsh," he



stressed.

"And most importantly, as the president said, that information that the reconnaissance plane obtained is not that information that they soughed to get, but this was that information that the Russian side believed it necessary to provide," Peskov said.

The Kremlin spokesman also noted that during this Q&A session Putin revealed the number of the reconnaissance jet's tail number. "Someone even joked [during the event] that the president will now give the first and last names of this plane's pilots and even their address," he said.

Russia's Defense Ministry reported on June 23 that the Black Sea Fleet jointly with the border guards of the Federal Security Service (FSB) halted a violation of the state border by the UK Navy's guided missile destroyer Defender off Crimea's Fiolent Cape.

The British warship ventured three kilometers into the Russian territorial waters. A Russian guard ship fired warning shots while a Su-24M bomber dropped bombs in the UK warship's path to chase it out of Crimean waters.

The Russian Defense Ministry slammed the UK destroyer's operations as a gross viola-

tion of the UN Convention on the Law of the Sea and urged the British side to investigate the warship crew's actions.

London claims that the destroyer was conducting an "innocent passage through Ukrainian territorial waters." According to the UK, the Russian military did not fire any shots at the destroyer but conducted "a gunnery exercise."

On June 30, Putin said at his annual Q&A session that the situation with the British destroyer was a complex provocation "held both by Britons and Americans."

The Russian leader pointed out that the British warship ventured into Russia's territorial waters in the afternoon while early in the morning, at 07:30, a US strategic reconnaissance plane took off from a NATO airfield on Crete in Greece.

### Zhang Guimei, a CPC member igniting hopes for impoverished girls in mountainous areas

ZHANG Guimei, who has dedicated her 40 years to education at China's southwestern border, is a "mother" for more than 170 children, and a principal motivating young girls from impoverished families in mountainous

Trying to cut the intergenerational transmission of poverty, she has ignited the hopes of many with the light

of education.

Zhang was born in Mudanjiang, northeast China's Heilongjiang province in 1957. When she was 17, she came to Yunnan province, which lies in southwest China, with her elder sister, responding to the call of the

country to support the development of border areas. When she first arrived there, she worked a job in the forestry industry. However, she stumbled into teaching and started a career as an educator ever since.

After Zhang's husband passed away in 1996, she went from Dali to teach in Huaping county, Yunnan's Lijiang. Five years later, she established a children's home and worked as a part-time president of it. The organization adopted a total of over 170 children, and Zhang had to take care of them only after coming back from work. The children call her mom though she has never given birth to a child.

Teaching at a middle school in Huaping county at that time, she saw many girls drop out of school due to poverty. It saddened her very much and made her realize that an educated female is able to cut the intergenerational transmission of poverty and change the future of three generations. In 2002, Zhang started her preparation to build a free all-girls high school, in hope of changing the destiny of the girls in the mountain and lifting them out of poverty.

In 2007, Zhang went to Beijing for the 17th Communist Party of China (CPC) National Congress as a deputy. Her report titled "I have a dream" delivered at the meeting made her dream of building a free all-girls high school known to all.

Later, both the Lijiang and Huaping governments sponsored her with a million yuan.

A year later, Zhang's school was completed, becoming the first free allgirls high school in China

The school, born to fight against poverty, is a shelter for a number of girls in mountainous areas. Before it

was established, the enrolment rate of high school entrance exams in Huaping was less than 50 percent. However, the figure surged to over 90 percent last year, and the county has been leading in the enrollment rate of college entrance exams in Lijiang for years. In the past, rural females in the county would choose to marry and get pregnant at a young age, but today, more and more of them are going to high schools for education. During the past 13 years, the school has nurtured over 1,800 students who have made it to universities.

With no offspring and property, Zhang lives in a dormitory building

with her students. She has donated all her cash awards, donations from others, and most of her salaries, which added up to more than a million yuan, to the children in mountainous areas and other people in need.

Zhang suffers from 23 diseases, including heart disease and emphysema, but she is still working selflessly. She gets up at 5:00 am and is always the first to arrive at school. She also checks how the classes are going three times a day. Zhang has made over 1,600 family visits annually for the past 12 years, covering a total distance of 110,000 kilometers.

#### No EU or NATO summit raised question of fate of Assange - Russian ministry

OFFICIAL spokesperson of the Russian Foreign Ministry Maria Zakharova, after one of the witnesses admitted the accusation of perjury in the



case against the founder of WikiLeaks Julian Assange, drew attention to the fact that the leaders of the EU or NATO countries did not touch on the fate of the journalist at any of the summits.

In an interview with Stundin, Sigurdur Ingi Thordarson, a key witness in the US Department of Justice case against Julian Assange, admitted that he fabricated parts of his testimony.

"And after all, not a single EU or NATO summit has even touched on the fate of Assange," she wrote in her Telegram channel. Zakharova recalled that the investigative journalist is now in a UK prison.

"The term of his imprisonment, according to UK law, has long expired. But who cares about it in the West when there are so many interesting things east of liberalism," she said.

According to Zakharova, this story is a bad look for Western liberal values. In addition, the methods, she noted, are not entirely legal. "We are talking about outright pressure, blackmail, and judicial forgery. But for the American repressive power machine, the methods are justified by the goals," she said.

In the United States, 18 criminal charges have been brought against Assange, on which he faces up to 175 years in prison.

He is charged with crimes related to a major case of disclosing classified information. Since April 2019, the founder of WikiLeaks has been in a UK prison awaiting a final decision on his extradition to the United States.

On January 4, a court in London ruled that his extradition to the US authorities would be unlawful, since Assange, who suffers from autism and clinical depression, is ready to commit suicide and will carry out his plan if he ends up in a US prison.

The judge's conclusions were based on evaluations by psychologists and experts. At the same time, the judge recognized the charges against Assange in the United States as completely legitimate and well-grounded.

At the moment, the American prosecutor's office is trying to challenge the decision to refuse extradition, and Assange, who was not allowed by the court to leave prison on bail, remains in custody. **Agencies** 

#### Cardinal among 10 indicted by Vatican for financial crimes

#### **VATICAN CITY**

A PROMINENT Italian cardinal was among 10 people sent to trial in the Vatican on Saturday



charged with financial crimes including embezzlement, money laundering, fraud, extortion and abuse of office.

Cardinal Angelo Becciu, formerly a senior official in the Vatican administration, as well as two top officials at the Vatican's Financial Intelligence Unit will go on trial on July 27 over a multi-million euro scandal involving the Vatican's purchase of a building in one of London's smartest districts.

The trial will inevitably bring a swirl of media interest to the tiny city-state surrounded by Rome, and appears to underscore Pope Francis' determination to cure the rot in Vatican finances, even if it involves messy public hearings.

Becciu, 73, whom the pope fired from his senior clerical post last year for alleged nepotism, and who has always maintained his innocence during a two-year investigation, becomes the most senior Vatican official to be charged with financial crimes.

The pope personally gave the required approval last week for Becciu to be indicted, according to a 487-page indictment request seen by Reuters. The Vatican announced the indictments in a two-page statement.

The charges against Becciu include embezzlement and abuse of office. An Italian woman who worked for him was charged with embezzlement and the cardinal's former secretary, Father Mauro Carlino, was accused of

Becciu said in a statement that he was a victim of a "machination" and reaffirmed his "absolute innocence". Carlino's lawyer said his client was innocent, had been "acting under orders", and had saved the Vatican millions of euros. He said starting a trial so soon did not

give defence lawyers enough time to prepare. Two Italian brokers, Gianluigi Torzi and Raffaele Mincione, were charged with embezzlement, fraud and money laundering. Torzi, for whom Italian magistrates issued an arrest warrant in April, was also charged with

There was no immediate response to attempts to reach their lawyers, but both men have consistently denied wrongdoing.

Four companies associated with individual defendants, two in Switzerland, one in the United States and one in Slovenia, were also indicted, according to the document.

#### **Police Raid**

The investigation into the purchase of the building became public on Oct 1, 2019, when Vatican police raided the offices of the Secretariat of State, the administrative heart of the Catholic Church, and those of the Vatican's Financial Information Authority (AIF).

The then-president of the AIF, Rene Bruelhart, a 48-year-old Swiss, and AIF's former Italian director, Tommaso Di Ruzza, 46, were charged with abuse of office for allegedly failing to adequately protect the Vatican's interests and giving Torzi what the indictment request called an "undue advantage".

Di Ruzza was also accused of embezzlement related to alleged inappropriate use of his official credit card, and of divulging confidential information.

# Game-changer: HIV generic drug for babies distributed in Africa

#### **DUBAI**

AID agencies have distributed a strawberry-flavoured tablet for children living with HIV in six African countries, the first generic pediatric version of a key anti-retroviral, global health agency UNITAID said yesterday.

UNITAID and Clinton Health Access Initiative (CHAI) funding procured 100,000 packs of the dolutegravir formulation across Nigeria, Malawi, Uganda, Kenya, Zimbabwe and Benin, UNITAD's spokesman Herve Verhoosel said in statement to Reuters.

Some 1.8 million children worldwide live with HIV, but only half receive any treatment, often hard to administer due to the bitter taste or incorrectly dosed by crushing adult pills.

Some 100,000 children die of AIDS annually. "With the recent delivery of the formulation in those 6 first countries, this project is now reality," Verhoosel, who is visiting the United Arab Emirates, said of the initiative first announced last December.

He said this procurement is designed to kickstart demand and that major donors have "rapidly moved to sustainable onward procurement, which will enable national scale-up and widespread access for all eligible children at an unprecedented pace".

The first-line HIV treatment is recommended by the World Health Organization from the age of four weeks and 3 kilos (6.6 pounds), but it had been out of reach for babies because of the lack of appropriate formula-

UNITAID and CHAI had reached a pricing agreement with the generic drugmakers Viatris and Macleods for the dispersible pediatric formulation of dolutegravir.

## China is certified malaria-free by WHO

THE World Health Organization (WHO) on Wednesday officially granted China a malaria-free certification. The UN health body called it a notable feat for a country that reported 30 million cases of the disease annu-

WHO Director-General Tedros Adhanom Ghebreyesus congratulated China in a press communique. He said China's success was hard-earned and came only after decades of targeted and sustained action.

"China's tireless effort to achieve this important milestone demonstrates how strong political commitment and strengthening national health systems can result in eliminating a disease that once was a major public health problem. China's achievement takes us one step closer towards the vision of a malaria-free Western Pacific Region," said Takeshi Kasai, Regional Director, WHO Western Pacific Regional Office.

The WHO grants the certification of malaria elimination to a country or a region when it has reported no indigenous malaria transmission for three consecutive years, established an effective and rapid detection and monitoring system for the disease, and set up a plan for malaria prevention and control.

China has seen no locally transmitted cases of malaria for four consecutive years since 2017, and officially applied to the WHO for the certification of malaria elimination last year.

In the press communique, the WHO detailed China's practice and experience of eliminating malaria. Chinese scientists discovered and extracted artemisinin in Chinese herbal medicine, and the core compound of artemisinin-based combination therapies is the most effective antimalarial drugs available to-

This discovery earned Chinese scientist Tu Youyou the Nobel Prize in Physiology or Medicine. China is also one of the first countries in the world to extensively test the use of insecticidetreated nets for the prevention of malaria.

Besides, China has established a national infectious disease reporting system and a laboratory testing network for malaria, and improved the monitoring systems of malaria vectors and drug resistance of plasmodium.

The country further reduced its malaria caseload through a strict adherence to the timelines of the "1-3-7" strategy and the "3+1 defense line" at border areas.

The "1" signifies the one-day deadline for health facilities to report a malaria diagnosis; by the end of day 3, health authorities are required to confirm a

case and determine the risk of spread; and, within 7 days, appropriate measures must be taken to prevent further spread of the disease.

The "1-3-7" model has been promoted worldwide and officially incorporated into the WHO's technical document.

Pedro Alonso, Director of the WHO Global Malaria Programme spoke highly of China's achievements and experience in eliminating malaria.

He said over many decades, China's ability to think outside the box served the country well in its own response to malaria, and also had a significant ripple effect globally.

The Chinese government and its people were always searching for new and innovative ways to accelerate the pace of progress towards elimination, he added.

According to data released by the WHO, there were 229 million cases of malaria worldwide in 2019 and 409,000 deaths.

**Trying conditions** 

For most destinations, 2021 began under even more trying conditions than in 2020, with an average global decline of 88 percent in the first quarter of 2021, compared with the pre-pandemic level, the report said.

Almost half the tourism experts interviewed for the UN report don't expect the sector to fully recover to the pre-pandemic level in 2019 until at least 2024.

Developing countries, where the ranks of international arrivals have plunged by an estimated 60-80 percent, have borne the brunt of the pandemic's impact on tourism, the UN agencies said.

These nations have also been hurt by the "asymmetric rollout of vaccines", which "magnifies the economic blow tourism has suffered in developing countries", the agencies said in a statement. Developing countries could account for up to 60 percent of the global GDP losses, they said.


The tourism industry is expected to recover faster in some countries with higher vaccination rates, such as Israel, the United States and Britain, but for many developing countries the outlook isn't as bright, the UN report said.

### **UAE** passes Seychelles to become most vaccinated nation

#### JAKARTA / DHAKA

THE United Arab Emirates has overtaken Seychelles to become the world's most vaccinated nation, according to Bloomberg's vaccine tracker.

The Persian Gulf nation has so far administered 15.5 million doses, enough to cover 72.1 percent of its mostly expatriate population of 10 million based on a two-dose regimen. The Seychelles has administered enough doses to cover 71.7 percent of its population of just under 100,000.



Cases in the UAE have remained elevated, though. Last week, the US raised its travel warning for the country to its highest level, citing a "very high level" of coronavirus. Saudi Arabia has temporarily prohibited travel and the UAE has been on a "red list" for travel to the UK since January.

Daily infections have hovered at around 2,000 since March from a peak of about 4,000 in February. The UAE, though, tests more people per capita than most nations and has one of the lowest fatality rates in the world. Agencies

LAST month, popular Tanzanian Hip Hop artist, Nickson Simon alias 'Nikki wa Pili', was sworn in as Coast Region's Kisarawe District Commissioner, after being appointed by President Samia Suluhu Hassan to lead the district.

Simon has replaced Jokate Mwegelo, who was transferred to Temeke District in Dar es Salaam.

The rapper from Arusha-based group known as 'Weusi' is becoming another Hip Hop artist in the country holding a major leadership position.

These are just some of the artists who have been in the past and present leadership posts.

#### 1. Joseph Mbilinyi -Chadema MP

This is the first Hip Hop artist to have graced the parliament by popular votes

He won the Mbeya Urban Constituency parliamentary seat via opposition party, Chadema.

In 2015 he was the leader in the election of more voters than any of the 257 MPs elected in the general election that year.

Mbilinyi, alias 'Sugu', managed to get 108,566 votes out of 166,256 that were cast, leaving the others sharing 57,690

#### 2. Joseph Haule 'Professor Jay'

In November 2015, Haule became another hip hop artist to win a parliamentary seat via Chadema party, through Morogoro's Mikumi Constituency people's votes.

Haule won 32,259 votes, with his closest rival, Jonas Nkya, garnering 30,425 votes.

Unlike Mbilinyi, despite Haule winning the legislature he continued to come up with songs as well as perform at major

He has continued his previous career even when he lost his seat in the 2020 General Election and now he has a hit song called 'Utaniambia Nini'.

#### 3. Hamis Mwinjuma 'Mwana FA'

In the October 2020 General Elections Mwinjuma also won the Muheza Constituency parliamentary seat in Tanga with 47,578 votes, while his closest rival, Yosepher Komba, received 12,034 votes.

Accordingly, a person will see from 2010, 2015 to 2020 every general election has been bringing in a Hip Hop artist to parliament and they have now started gracing district offices.

What is the relationship between Hip Hop music and leadership?

Speaking on this agenda, prominent rapper Farid Kubanda, alias 'Fid Q', said

that the music artists seem to be gaining leadership positions around the world as Hip Hop is imaginative music.

The musician added the genre is often based on presenting what is going on in the

"Hip Hop artists often sing about the challenges that exist in the environment around them, so that leads the community to see that they are the right people for leadership through the use of art to raise their voices, to speak for those who do not have the opportunity to talk about their challenges,

"Hip Hop doesn't prepare its artists to be leaders, but when you become a hip hop artist you automatically find yourself a leader because it's a fanatic game, so when you have a fanatic you can't be a follower, you have to be the leader," he disclosed.

And the newly appointed Kisarawe DC, Simon, in an interview towards the General Election in October last year, said he believes every artist, regardless of the type of music or art he or she makes, can become a leader, but it will depend on how he or she portrays himself or herself in the society.

"You can be a Hip Hop artist but people tested you and found you have no constructive ideas, we all see Vick Kamata is a singing artist but she has become an MP. So I see it as a self-centred desire, I don't see it as related to being either a Hip Hop artist or not," he says.

He noted: "I also see that singing artists are strong if they decide to vie for leadership they can do well, but as I said it will start with a musician. They can trust you as an artist, can they trust you as a leader?" he queried.

Rapper Kala Jeremiah says Hip Hop is not just music, it has its foundations and system, so artists living in those two areas have a great opportunity to shape themselves and look fit

"Hip Hop has always been about leadership, leadership is all about listening to or seeing someone's challenge and it's about you, now when you want to be a Hip Hop artist you have to talk about other people's challenges. In doing that you find yourself standing as their leader," he disclosed.

Tanzanian budding female rapper, Claudia Lubao, better known as 'Chemical, who is the winner of the best research at the University of Dar es Salaam (UDSM) 2020/21, noted it all boils down to how one has set himself up, as even those who do Hip Hop sometimes change and make other types of music.

"When it comes to leadership I see it as a person's commitment and how he planned to get it, so I do not want to say that Hip Hop is the most effective than any other type of music, no! What a person is determined to do and what priorities he has set, if one has set himself a good environment to be a leader in the future, he will succeed in achieving that," she disclosed.

## Barbara's argument is speculative, not controversial

When it comes to issues affecting the two sides, it is easy for one to see either a person or a soccer fan make statements and comments that he or she would not normally be able to express.

It is easy for a person to see either a Simba or a Yanga fan praise either something or an event, even if it either does not deserve to be praised or it is bad and inappropriate, as long as it is done by his side.

A soccer fan can see such a supporter criticize and mock a worthy initiative just because it is either done by or refers to the other side.

A large group of critics claim that Barbara should not have made such comments in public due to her position

A large group of domestic players have been facing the problem of not valuing themselves and knowing their role in the team.

The players feel they are the only ones who have the right to earn from the team without them producing. They receive high salaries and other

benefits in the team probably without even making a significant contribution or supporting the team. They feel it is their right but they do

not feel they should be responsible for making sure the teams are doing well through winning fixtures they play.

This leads to many of them being dissatisfied with their commitment and thus placing a heavy burden on the club in serving them without incorporating anything through them.

In other words, an individual can interpret that our clubs have been serving many players who do not benefit the outfits.

Unfortunately for a long time our clubs have been nurturing players, who do not seem to volunteer for the

team, and are eating free salaries and allowances while a few of their peers are sweating for the success that at the end of the day seems to be universal.

In today's world where football is a business, clubs continue to have such unscrupulous players and live like ticks, it is something that should not be perpetuated and the time has come for clubs not to give them priority and show them the way out rather than continue to lose because of them.

Our football will not be able to make progress if our players do not seek to emulate foreign professionals, who are playing and doing well, and instead will continue to go backwards as we continue to complain without taking action.

Tanzania now lacks a large number of players, who play professional football in the competitive leagues in Africa and around the world, not because of the limited abilities of domestic players but because of this laziness and satisfaction that Barbara has shed light on.

They do not see the need for them to ply their trade elsewhere because there is a simple and stress-free life for them when they fail to either do well or commit, compared to where they do not want to go.

Let us not look at Barbara Gonzalez's argument as she only focused on Simba.

She has shown a chronic problem that exists for all clubs from the Premier League to the lower national divisions.

ITALY left-back Leonardo Spinazzola has been ruled out of Euro 2020 after tests on Saturday confirmed he had suffered a torn Achilles tendon.

The 28-year-old has been one of the standout performers for Italy and was impressive again in the 2-1 quarterfinal win over Belgium as he was named star of the match -for the third time in four matches at the tournament -- despite being forced off on 80 minutes with the

Spinazzola was sprinting down the left wing alongside Belgium's Thorgan Hazard when he pulled up and immediately signalled to the bench that a change was required.

He undertook an examination at Sant'Andrea University Hospital in Rome where it was confirmed he had suffered a torn tendon in his left Achilles.

"Unfortunately, we know how it's gone, but our Azzurro dream continues and this is a great opportunity to show that nothing is impossible," Spinazzola wrote on Instagram on Saturday. "I can only tell you that I will be back soon! I am certain!"

Despite leading Italy to a first major tournament semifinal since 2012, manager Roberto Mancini said after the match he was "sad" following Spinazzola's injury.

Spinazzola, who started his career with Juventus but made his name during a loan spell with Atalanta, plays for Roma and has been dogged by injuries throughout his

In January 2020, he saw a move to Inter Milan fall through due to an issue with a medical.

After the victory in Munich over



Belgium, the in-flight entertainment in Italy's returning flight turned out to be the Spinazzola Serenade.

## Denmark show they're no underdogs at Euro 2020

THERE might be a temptation to think Denmark are riding a wave of goodwill at these European Championships after the world watched Christian Eriksen collapse on the pitch three weeks ago, but their run to the semifinals of Euro 2020 is being driven by more than just destiny and fairytale.

There was nothing mysterious about their 2-1 win over Czech Republic on Saturday. Denmark are good players, well coached by Kasper Hjulmand, and are able to score goals of high quality and equally defend with grit. Denmark are ranked as the 10th best team in the world for a reason.

Still, what they have been able to achieve without Eriksen, their best player, remains remarkable. There were Denmark players in tears as they warmed up for the restart of their opening game with Finland after having seen Eriksen leave the pitch on a stretcher, barely conscious. Many of them, understandably, seemed to play out the 1-0 defeat in a daze. Against the Czechs, however, there was energy and determination and, at the final whistle, there were tears of a different kind.

Before the tournament, Denmark had not won a knockout game at the Euros since winning it in 1992, when they were asked to replace Yugoslavia at a weeks' notice. Now they have a semifinal at Wembley to look forward to. They have already won there once this season, beating England 1-0 in the Nations League in October.

Underdogs? Yes. Rank outsiders? Not a chance.

"It's hard to put into words," said Denmark goalkeeper Kasper Schmeichel afterwards.

"The Czech Republic is an insanely difficult team to play against. We played well in the first half, but the second was difficult. We can fight and fight, and we did. It was a great re-

Hajime Moriyasu, who has been in charge of the senior team since 2018, will coach at the Olympics as well.

Moriyasu has opted for versality with players who can adapt to different roles, including Kou Itakura, who plays for Dutch club Groningen at either center back or midfield. Soma Yuki of Nagoya Grampus can play at fullback on either flank.

"We prioritized players who can create opportunities single-handedly, play solid defense at the individual level," Moriyasu said, "and make runs for the team."

While Kubo Takefusa of Real Madrid is on the squad, the winger has yet to play for the Spanish giants' first team and has instead spent periods on loan.

#### **OLYMPICS CLASH**

The clash of the Olympics with the start of the European season makes it hard for teams to often take their best players. So, Japan will be without its biggest star. Forward Takumi Minamino is with Liverpool trying to regain the Premier League title.

Egypt also want to be able to call on Minamino's Liverpool teammate Motrepidation rather than excitement hamed Salah, especially given there is an African Cup of Nations starting Players spreading across the counin January. It's unclear whether he will be able to lead the team in Japan.

> The Egyptians are in a group with Spain, Australia and Argentina. The Olympics is the only major title Lionel Messi has won with Argentina, at the 2008 Beijing Games. But the out-of-contract Barcelona forward is not one of the three permitted overage players in the Argentina squad at a time when he looks to resolve his club future and has been involved in the Copa America in this offseason.

#### WORLD CUP WINNER

France will be looking to become dual Olympic and world champions. While Florian Thauvin has a World Cup winner's medal from 2018, the winger will be hoping to appear in Japan for more than the one minute he played in Russia. He only came on at the World Cup in one game as a late substitute for Kylian Mbappé. Even though the Paris Saint-Germain star failed to score in June as France exited the European Championship in the round of 16, he won't get a chance to quickly make amends given his absence from the Olympic squad.

The one country where clubs have to release players for the Olympics is Spain. That means six men from its Euro 2020 team will get a chance to deliver Spain's first soccer gold since 1992, including senior national team starting goalkeeper Unai Simón.

#### IVORY COAST BACK

The only time the Ivory Coast men have competed at the Olympics was in 2008 when they faced Messi's Argentina before going out in the quarterfinals. They will be hoping to secure the release from Manchester United of Amad Diallo and Franck Kessie from AC Milan. The Ivorians have a fearsome opponents in their group with the defending champions from Brazil, Germany and Saudi

### Kane's England poised to heal decades of heartbreak

TOURNAMENT knockout games involving England aren't supposed to be like this. For a country used to nerveshredding nights of fine margins that, let's be frank, often end in agonising failure, the sight of Gareth Southgate's side breezing into the Euro 2020 semifinals with a 4-0 win over Ukraine in Rome was an almost unbelievable departure from history.

There was a vaguely similar feeling three years ago at the same stage of the 2018 World Cup when England beat Sweden 2-0, but that afternoon did not possess the same serenity as this. It all felt so fragile then. This time, England's display was merely the consequence of Southgate and this galvanised group of players feeling at home at this rarefied level, delivering on their various statements of intent - and nobody more so than Harry Kane.

The Tottenham Hotspur striker was substituted in England's opening game against Croatia after a subdued display that led to speculation over whether he should still lead England's attack. Five games later, he was taken off after 72 minutes at the Stadio Olimpico with a brace under his belt, UEFA's Star of the Match award and one eye on a late run at the Golden Boot.

Before Kane got off the mark in this tournament in Tuesday's last-16 win over Germany, he reflected on how he struggled to sustain his form at the 2018 World Cup, where he still ended up as top goal scorer.

"I felt maybe in Russia I started on fire, scored loads of goals, then maybe didn't have my best performances in the most important games: the quarters and the semifinals," he said. "So, coming into this, physically, I wanted to make sure I was peaking at the right time and obviously we won't know until Tuesday night if that's the case, but that's the way I feel it's going."

We know now. On a muggy night in the Italian capital, where temperatures remained around 25 degrees Celsius at a 9 p.m. local kickoff, a fast start was essential. England played with a high defensive line, squeezed their opponents and scored within four minutes.

Kane finished the move with a smart

run and finish, but Raheem Sterling made it happen. Harry Maguire spread the play out wide to Sterling. Luke Shaw's underlapping run attracted a Ukraine defender away, allowing space for Sterling to run infield, bounce off a challenge from Mykola Shaparenko and slip a superb ball through to Kane, who did the rest.

Five years ago at Euro 2016, Sterling declared himself "the hated one" as the winger bore the brunt of England's underperformance. He faced criticism before this tournament, too, after an underwhelming end to the domestic season with Manchester City, the fans' fall guy in the clamour to include Jack Grealish and Phil Foden in England's starting lineup.

"Teams have to go on a bit of a journey and they have to go through some pain sometimes to be able to progress," Southgate said after the match. "We've

had some great nights over the past four vears but we've also had some painful nights and we've learned from all of those experiences. That has definitely helped us prepare for another tournament and prepare for the individual games, the understanding of each other and how we want to play, and also the recognition that moments like tonight, we didn't want to take a backwards step. We wanted to really grasp the opportunity rather than hope that we might win or let fate have a chance to play its part. I thought the players were decisive and ruthless all night."

Along with Kane, Sterling is now surely the first name on Southgate's team sheet. Ukraine simply did not know how to handle him, and together with Shaw, he formed a formidable pair on the left flank while Jadon Sancho, in his first meaningful minutes of the finals, justified his surprise selection on the

right with Bukayo Saka unavailable due

Shaw had been heavily criticised by Jose Mourinho during their time together at Manchester United and also this summer with the Portuguese working as a pundit for a United Kingdom radio station. The 25-year-old chose to fire back in an interview last weekend - "Hopefully he can find his peace with that and finally move on and stop worrying about me" - and he backed that up on the pitch with two superb performances against Germany and now Ukraine.

A minute after half-time, Shaw delivered a superb set piece for Maguire to plant a header past Ukraine goalkeeper Georgiy Bushchan that almost took the net with it. Maguire's selection in Southgate's final 26-man squad was widely questioned given he had been injured since May 9 due to an ankle problem, but he has grown in stature as his fitness returned.

Shaw delivered again four minutes later, this time picking out Kane unmarked from close range to head his second. Kane went 463 minutes for England without a goal. He now has three in two games and took his tally in major tournaments to nine, one behind Gary Lineker's all-time England record of 10.

"Whenever you are playing you want to be the best you can be and try and become the best that there has been," said Kane. "Maior tournaments are massive for our country, massive for our nation. I love being involved in them. It would be great. Gary was an amazing player, a great English striker.

ìWe didn't play very well and were not very committed in the first half. The second half was better, very good. We had some opportunities to score. We dominated the second half. We missed the first half. It was our mistake today.î Gomes told reporters after his first league defeat as Simba coach, having won 12 of his 14 previous games.

He noted: iWe are very sad, we could have won the league in front of our fans in a big match. We are very disappointed. We were not present in the first 30 minutes, and didn't play well. It is the first time we conceded 12 corner kicks in the first half."

"We watched many Yanga games, we expected this system. What I didn't expect was how we started the match. We made mistakes and did not turn up until the second half. The second half was very good but it is not a win today. The next game against KMC FC will be very important to win the league.

Gomes now faces the task of juggling his Simba squad after being handed a tough weeklong schedule that involves taking on KMC FC on Wednesday and Coastal Union three days

In another development, Yanga's head coach, Nassredine Al Nabi, has revealed the plans his squad used to defeat Simba SC in the Vodacom Premier League

Nabi made the plan known when he spoke to reporters after his team had completed the task of collecting three points against their age-old rivals.

The Tunisian tactician stated: ìSimba are a good team, all we did was read their quality to stop them and make the most of their shortcomings to shut them down and we have succeeded."

He disclosed: "My players have tried their best to apply the instructions we gave them. We will be happy for a while before we prepare for the Federation Cup final game later this month, we know they will come with the intention of revenge and that is why we have to plan.î

It should be noted that Simba only needed a draw to be officially crowned Premier League champions for the fourth consecutive season.

The leaders would therefore need to wait until the next match after their hometown rivals refused to let the former lay their hands on the Premier League trophy with victory in the match.

In the match attended by President Samia Suluhu Hassan, Yanga's only goal was scored by midfielder Zawadi Mauya in the 11th minute with a shot taken from 21 meters after he had pounced on a rebound.

A right foot shot taken by midfielder Feisal Salum ' Fei Toto' was blocked by Simba defenders and onrushing Mauya made the most of the rebound.

With the 1-0 win, Yanga are firmly sitting second, having collected 70 points.

Simba SC continues to sit at the top of the league standings with 73 points, as they prepare to play the next game sixth placed KMC FC at at Benjamin Mkapa Stadium on Wednesday.

#### Mining firm now to build 2bn/modern stadium in Geita

GEITA Gold Mining Limited (GGML) has released more than 2bn/- for construction of a sports stadium, which will include a football ground, athletics, and other infrastructure.

Speaking on behalf of GGML at the signing ceremony of the contract for the construction yesterday, the company's project manager, Moses Rusasa, said the mining company would provide timely funding to complete the project on

He said payment is among issues that are delaying the project, that is why GGML assured the regional leadership that the payment process will be done quickly to complete the project.

He also said GGML will continue to work with the government in various fields.

In addition, the Chairman of Geita Town Council, Constantine Moranda, commended the mining company for setting out to construct modern stadium and urged the contractors to do the work quickly.

Elaborating on the project, Geita Town Council Acting Executive Director, Felix Nlalio, said Geita Town Council has allocated 10.4 hectares (104,570 sqm) for the construction of a state-of-the-art stadium which will also include areas for commercial and car parking.

He said the stadium will be built by EFQ COMPANY LTD and MU-GOO CONSTRUCTION COMPANY JV of Mwanza.

"This project, which is funded by GGML through the CSR community accountability budget, will be able to accommodate seated 12,000 spectators when completed and will be built at a cost of more than 2bn/-," he said.

Geita District Commissioner, Willison Shimo, called on the project managers to do the job in accordance with the standards and conditions of the Tanzania Football Federation (TFF).

The EFQ Company Limited and MUGOO Construction Company Limited JV's representative, Juma Nywataya, said the company will operate on the basis of a fourmonth contract period.

Geita Regional Football Association (GEREFA) secretary general, Pius Kimisha, appreciated the construction of the stadium as it will stimulate the development of sports in Geita.
