

## Lindi outbreak tests negative for COVID-19, Ebola, Marburg

TESTS of samples collected from patients suffering from the yet-to-be-identified disease in Lindi Region have turned negative for Ebola, Marburg and Covid-19, which were the authorities' top suspects.

Dr Aifello Sichalwe, the chief medical officer, said in a statement yesterday that these are the preliminary results from samples collected at Mbekentera health center in Ruangwa District where the condition was first reported from two

They had signs of fever and bleeding profusely from the nose, who underwent medical checks but no signs of Ebola or coronaviruses found, thus the Ministry of Health had formed a task force team of experts in epidemics, the chief

government chemist, the National Institute of Medical Research (NIMR) the Muhimbili University of Health and Allied Sciences (MUHAS) upon hearing the disease outbreak, causing intense apprehension in the area.

On Wednesday, 13 patients were brought to hospital with three bodies of deaths after similar symptoms, where two patients were isolated, treated and discharged. One patient had recovered and progressing well at Mbekenyera village, and several people who came into contact with the patients turned up for checks.

Five of the patients left for home in the Naungo suburb in Kilwa, while the chief medical officer appealed for cooperation among residents when the investigation team arrives there to start intense investigations on the medical

## Road crashes kill eight, police blame speeding

EIGHT people have died in two highway crashes in Simiyu and Arusha regions, with three members of the same family killed in the Arusha accident.

The first accident occurred at Magereza on the outskirts of Bariadi town, Simiyu Region, on Tuesday night, with five people killed and 11 sustaining injuries.

Top regional police officials said vesterday that the accident involved two passenger

## Ministry team out to probe plot sales

ALLEGATIONS that top government officials irregularly acquired plots of land at the prime Isamilo area in Mwanza city are set to be investigated.

This follows a decision by the Lands, Housing and Human Settlement Development minister, Dr Angeline Mabula to direct permanent secretary Dr Allan Kijazi to form an independent team to probe into how the plots ended in the hands of government officials.

The minister who was on a constituency visit

was alerted to the issue by residents of the area complaining that the land area with 38 plots was taken away from them without compensation and later sold to senior government officials.

She issued the directive when briefing reporters on the issue, while going over ministerial objectives at present, in executing budget plans for 2022/23, confessing that Isamilo land area in the city centre was sold to government officials, which the probe team is tasked to clarify the circumstances.



## Govt urges UK outfit, REPOA to formalise digital-link work

MORE research is needed on digital labour occupations to support efforts towards their formalisation, enhancing decent job conditions and social security, a top labour official has declared.

Joseph Nganga, the director of employment services in the Prime Minister's Office (Labour, Youth, Employment and Persons with Disability), made this observation at a seminar in Dar es Salaam



to launch the 'fair work' project themed 'fair work principles for gig workers.'

An expert online describes gig workers as independent contractors working online, oncall workers or temporarily employed staff. Gig workers enter into formal agreements with on-demand companies to provide services to the company's clients, the chronicler states.

Gig workers can't be avoided as technology is growing rapidly but more research is needed to formulate better policies to ensure decent work in the sector, the director noted. The research project is intended to explore local gig economy markets, where the think tank Policy Research for Development (REPOA) is in partnership with Fairwork, a UK non-governmental organisation with a base at Oxford University.

The research exercise will collect data on the fairness of working conditions at digital labour platforms such as fair pay, contracts,

Dr Mabula said every person including government officials have the right to buy land plots sold by the government, in line with laid down procedures. The city council announced the sale of the plots at Isamilo and Luchelele areas starting June 12, with prospective buyer charged 20,000/- to obtain the purchase request forms.

The dispute appears to have who emerged paid for the forms but their efforts to take invoices to pay for the plots stonewalled, the plots had been cleared by the top purchasers.

The city council said in its website post that a square meter of the plot was being sold at 5,000/- for residential plots while Isamilo area low density price is pegged at 25,000/- per square metre.

As the issue moved from purchasing plots to apparent privilege, city director Yahaya was no longer picking questions on the complaints, thus reporters confronted the minister with the matter as she briefed them on plans for the next financial year.

## Police in Kagera Region kill person taken for a gangster

POLICE in Kagera Region have killed a suspected armed robber aged between 30 to 35, in a shootout after allegedly stealing 19.7m/- at a shop belonging to Mussa Maduhu (38) a resident of Biharamulo District in the region.

Confirming the incident yesterday Regional Police Commander (RPC) of Kagera William Mwampaghale said the incident took place on July, 12 at around 1:45 at Nemba village, Biharamulo when four suspected armed robbers invaded a shop and exploded blasts.

The regional police boss said the armed robbers upon invasion threatened the security officer at the shop who later escaped to protect his dear life.

"The security officer escaped to protect himself, the suspects started destroying the shop and left with airtime belonging to Airtel, Tigo whose amount is yet to be discovered," said Mwampaghale.

He said police set up a trap to arrest where they saw the suspects fleeing riding a motorcycle.

He said the police ordered the suspects to stop but they refused, the police fired in the air and the suspects responded.

He said during the shootout police injured two, while one died on the way to the hospital to receive treatment while others escaped.

The RPC said the suspects had traditional weapons including an axe, machete, and a machine for explosives which they abandoned after the chase by law enforcers.

In another development, police in Mwanza are holding two people including Omary Lucas (48), for allegedly stabbing his wife Elizabeth Lusana (61) to death by using machete.

The police in the region are also holding Amos Lucas (29) for hiding the suspect who is his brother.

Regional Police Commander for Mwanza Ramadhan Ng'anzi confirmed the incident saying it happened on July, 11 in Kagera region at Lwahima in Nyamagana district.

"On July, 11 around 1 pm he attacked Elizabeth Lusana by stabbing her in various parts of her body which led to her death," he said.

Preliminary investigations have shown that the two who were married had quarrels on the fateful day when the man accused the woman of cheating while in marriage.

The suspect after allegedly the suspects at Mgera Nyakanazi Ward murdering his wife escaped and went to hide in Tabora at the house of Amos Lucas who has also been arrested for hiding the suspect.

In another development, the police have confirmed the death of a five-year old child Ally Sipendeki who died in a fire accident after the house they were living in caught fire at Nyabulonga in the region.

management and representation. The gig labour sphere is growing especially in cities like Arusha, Dodoma, Dar es Salaam and Zanzibar with more than ten thousand ride-hailing workers including cab drivers, motorcycle and tricycle riders, the research plan underlines.

## Livestock ministry registers 28 poultry breeding companies

TWENTY eight poultry breeding companies have been registered by the Ministry of Livestock and Fisheries as part of efforts to end the shortage of day old

Ministry's Assistant director of veterinary services, Dr Annet Kitambi, told this paper that the move is part of the country's long term plans to revive production after being affected by the outbreak of COVID-19.

Current statistics from the ministry indicates that the country's annual demand for day old chicks is 100 million while the production capacity stands at 88.5 million chicks per year.

Out of the registered companies, four are foreign and 24 are owned by locals.

Dr Kitambi said the pandemic outbreak forced the government to come up with short and long term plans to end the problem as well as ensuring continued production even during disasters and pandemic outbreak.

She said the country's sub-sector was affected by the pandemic outbreak whereas it relied on imported day old chicks. She added that most of the companies have been granted with temporary registration until they meet the required criteria.

On December 16 last year, the government announced its option to invite global poultry -breeding companies to open branches in the country as a longterm plan to reduce shortage of day-old chicks.

The Director of Veterinary Services at the Ministry of Livestock and Fisheries Prof Hezron Nonga said that once the companies open branches in the country it could be easy to produce hatchery eggs as well as chicks.

He said the pandemic has affected the production of day old chicks not only in Tanzania but also other neighbouring

The increasing demand offers many opportunities for companies looking to invest in the poultry sector in Tanzania.

The poultry subsector in Tanzania consists of approximately 72 million chickens, emerging steadily both in indigenous and exotic chicken.

With changing eating habits in urban areas and a growing economy the domestic market for exotic chicken and eggs is likely to keep expanding.

#### Mtwara port's new berth boosts revenue collection

THE new berth at the Mtwara Port has increased revenue collection at the port from 14bn/- in 2020 to 23bn/- in

Speaking soon after visiting the port early this week, the Deputy Minister for Transport, Atupele Mwakibete said the increase of revenue has been contributed by the overall refurbishing of the port including construction of the new berth capable to serve 65,000-tonne ships.

TPA Acting Director of Marketing and Public Relations, Thomas Mushi said already various efforts are being made to advertise the port within and outside the country to attract transporters, in particular traders from Zambia and Malawi who use the port of Dar es Salaam.

The deputy minister was in a two-day visit to Mtwara Region to inspect infrastructures managed by institutions in the transport sector.

## Mwinyi calls upon CPLP nations to provide scholarships to Zanzibaris

ZANZIBAR President Dr Hussein Ali Mwinyi has advised envoys from the Organisation of Portuguese speaking countries Comunidade dos Países de Língua Portuguesa (CPLP) to provide opportunities for scholarships for higher learning in their countries to Zanzibaris as a step to enhance the use of the Portuguese language.

Other CPLP envoys who attended the talks included Antonio Cesare from Brazil and Agostino Abakar Trinta from Mozambique.

Dr Mwinyi said the government supports the intention of CPLP countries to provide opportunities to Zanzibaris to learn Portuguese and underscored the need for starting the programme in the higher learning institutions level.

He said such procedure is also

being used by various world countries including Turkey, China, Russia and others whereby foreign students learn their languages during their first year of studies.

He said Zanzibar, through its State University of Zanzibar (SUZA) has an institution that deals with language issues - the Kiswahili and Foreign Languages Institute, adding that it is an important link in achieving the intention.

Meanwhile, the envoys told Dr Mwinyi on their intention to develop their ties with Zanzibar through the increase in the use of the Portuguese

THE Ministry of Culture, Arts and Sports has formed a ten members taskforce committee to look at modalities on how to review loyalties for artists as well as copyrights for their

The minister in charge of the docket, Mohammed Mchengerwa, made the revelation recently when closing the three-day national cultural festival which was held at national level at Uhuru Stadium in Dar es Salaam.

Mchengerwa said the committee members include experts derived from the National Arts Council of Tanzania (BASATA) who will work in close collaboration with the Copyright Society of Tanzania (COSOTA).

The committee members will be led by Victor Michael as the chairman, assisted by Saudi Mwakaje the Deputy Chairperson while the Secretary will be Demeshi Maujo.

Other members are Hamasi Mwijuma, Dr Omary Mohammed (from Zanzibar) Paul Mathias, Toriano Saramba, Gabriel Kitua, Twiza Mbarouk and Dr Asha Mshana.

The aforementioned committee

members will make a review plan

with the aim of bringing an effective revolution in artistic sector in the country. He said the taskforce committee would also look at various queries

facing artists such as payments of their loyalties and entitlement to copyright for their innovative works. He said the team will work in

#### Background

The WWF Forest Landscape Restoration (FLR) in Africa Initiative is built around removing barriers to successful implementation of restoration at scale in nine African countries namely Cameroon, DRC, Kenya, Madagascar, Mozambique, Tanzania, Uganda, Zambia and Zimbabwe. ## Kilosa District planning to increase sisal production

KILOSA District Council unveiled new strategies to increase sisal production by cultivating 13,109 hectares of the crop by the year 2025.

Speaking during a meeting involving stakeholders including pastoralists, farmers and the Southern Agricultural Growth Corridor of Tanzania (SAGCOT), District Agriculture Officer Dr Yuda Mgeni said the district was committed to meet the set targets.

"We've provided block farms to farmers, registering all sisal cultivators to Tanzania Sisal Board (TSB), training 93 experts and 300 farmers," he said.

Dr Megni cited areas set for sisal cultivation as Kimamba A, Kimamba B, Rudewa, Msowero, Mvumi, Madoto, Masanze, Kilangali, Chanzuru, Tindiga, Magole, Kitete, Ulaya, Mhenda and Magomeni.

Currently, the district owns 6,695 hectares used for sisal cultivation saying the hope was that it will increase to 13,109 hectares before 2025.

He said the district has a special programme of establishing seed nurseries which will be provided to smallholder farmers free of charge the exercise that will be accompanied by emphasizing the establishment of processing industries.

SAGCOT's Project Manager, John Banga hailed the plan saying this has

been achieved after the end of conflicts between farmers and pastoralists which was the main stumbling block.

He said concentration should be on production because the government has already allocated budget for the completion of tarmac road from Kilkosa to Dar es Salaam which will facilitate importation.

"Sisal is one of the key crops and it has all potential to bring about economic gain to local communities and preserve beautiful nature of a region. Cooperation is inevitable to three sectors of private, government and farmers because they all depend on each other."

Ruling CCM chairperson in Kilosa District, Morogoro region, Amer Mbaraka described the crop as a gamechanger because is grown well in hot climates with temperatures between 10 to 32 degrees of Celsius and allows intercropping because is not affected by other crops.

"Annually a farmer has the capacity to harvest three times and there is an assurance of the market," he added.

Tanzania is ranked the second after Brazil on sisal production standing at 27,460.50 tonnes per year and key sisal growing regions are Tanga, Kilimanjaro, Coast, Lindi and Mtwara.

Currently the sisal industry in Tanzania employs over 100,000 people according to the Bank of Tanzania (BoT) and Food and Agriculture Organization (FAO).

## NIRC eyeing 13 irrigation projects in Mbeya Region in FY 2022/2023

THE National Irrigation Commission (NIRC) intends to build 13 irrigation projects in Mbeya Region to increase food production and trade and refrain from relying on rain-fed agriculture.

NIRC director general Raymond Mndolwa said this yesterday here when speaking to reporters about his visit in Katavi, Rukwa, Songwe and Mbeya regions where he said the projects will be implemented in the 2022/2023 financial year.

Mndolwa said among the projects that will be implemented in Mbeya Region, 11 are in Mbarali District, one in Kyela District Council and one in Busokelo municipal Council in Rungwe

According to him, the government's was to eliminate rain-fed agriculture on the grounds that such farming was less productive in the event of climate change.

He said the projects would be for the construction of irrigation schemes as well as the rehabilitation of old ones to increase the efficiency of crop

include the Makwale Project in Kyela District of about 2500 hectares and the Mbaka Irrigation Scheme located in Busokelo Council in Rungwe district with about 300 hectares.

He also named the existing projects in Mbarali district as Lwanyo project with about 1,000 hectares, Gonakuvagogolo 250 hectares, Matebete 1,200 hectares, Chosi with 1,700 hectares, Helman 400 hectares, Uturo 2000 hectares, Isenyela 1,000 hectares and Makangarawe with 1,100

Other projects are the Madibira Scheme with 3,200 hectares, Mbuyuni-Kimani with 3,000 hectares and Msesule with 4,500 hectares and that of those 1,500 hectares will be built in the 2022/2023 financial year.

"But apart from the projects, during this visit we've inspected all Igumbilo / Isitu and Njombe schemes in Mbarali district totaling 900 hectares and we've inspected them to be included in architectural and construction plans," said Mndolwa.

He also stated that apart from He mentioned that the projects building the projects, the government also intends to start building rainwater harvesting dams to further irrigation agriculture.

> Mbeya Regional Commissioner, Juma Homera said the regional government will ensure that it provides co-operation to the commission so that all these projects are completed and benefit farmers in the region by increasing their income and food security.

RC Homera said for the past agricultural season the production of various crops declined due to climate change which led to a decrease in

The Acting Manager of Lake Victoria Ports, Vicent Steven named the five ports that have to be formalised as Nyehunge, Kamanga Ferry, Mkombozi South, Mkombozi North and Bijili.

"We have given these illegal ports until the end of this month to undergo legal process including enacted by various government institutions so as to become formal ports," he said.

He added: "Kamanga port is on good progress to be registered as a formal port, we are calling other four ports to learn from Kamanga so as to make sure that by the end of this month all ports are formal.

#### Completion of Songea Airport expansion to bolster air travel

COMPLETION of Songea Airport expansion at the tune of nearly 37bn/- will enable six planes carrying approximately 70 passengers to be serviced simultaneously for 24 hours seven days a week.

The Deputy Minister for Works and Transport, Atupele Mwakibete said this here on Tuesday when speaking shortly after inspecting the progress of the facility's expansion.

The expansion and rehabilitation of the airport is implemented by the Chinese Construction Company-Chico and the Tanzania Roads Agency (Tanroads) in Ruvuma Region.

He said the government was looking at the opportunities available in Ruvuma region including coal mining, tourism and agriculture as well as deciding to improve the airport to facilitate trade and shipping and transportation activities.

"This region has many opportunities so if the government sees it fit to improve this airport so that traders, investors and citizens can have easy travel as trade has no limits it can be done in 24 hours," said Mwakibete.

He called on the Tanroads and the Tanzania Airports Authority (TAA) to have a vision to upgrade the airport to cater for aircraft capable of carrying 300 passengers.

He also commended TANROADS and TAA for ensuring the contractor adheres to the value for money and standards in the construction of the airport and supervising it closely.

Tanroads manager in Ruvuma Region, Eng Ephatar Mlavi said that currently construction has reached 90 percent and ongoing work includes the completion of a temporary flight guidance and lighting installation on the runway.

Eng Mlavi added that the airport is expected to be completed in August where the contractor expects to hand over all the work in September this year. Songea airport acting manager Jafari Mbana said the completion of Liparamba Forest.

the expansion has increased air travel, especially for Tanzania Airlines (ATCL) as has increased its flights from two to three flights per week.

The expansion of Songea airport has included a runway from 1625 meters to 1860 meters and a width of 30 meters, construction of fences, temporary flight controls, aircraft parking, lighting, fire truck and various systems.

The airport expansion will also attract more tourists in the region which is blessed with a number of tourist attractions such as Lake Nyasa shores, Livingstone Mountains, the Nyerere National Park, the Majimaji war heroes museum and the

Dr Rose highlighted that journalists' news writing target should focus on reporting news with gender content to promote an equal society which will later lead to justice.

"Gender reporting acts as a bus fare to facilitate your career, it will never fade away since it cuts across politics, human rights and agriculture. Your goal as you fulfill your responsibility should always aim at branding your career," she said.

She however stressed that its time journalists evaluate how helpful TAMWA seminars are as its astonishing how the organization strategically

teach tactics to shape their writing skills and end up achieving undesired changes.

Mary Kafyome, an assistant lecturer at Tumaini University Dar es Salaam College (TUDARCO) noted that despite having freedom to cover news, journalists should always put the public at heart.

"People are moved mostly by the content they watch. You should offer equal opportunities without being gender biased. The more content on women holding low levels the more we change the perception of women to the community." she said.

Adding: "We should not be the reason to discriminate against people. The same way men are featured as prominent characters, content experts should also apply to women so as to bring diverse opinions."

However, Kafyome said that journalists that attend TAMWA seminars from time to time ought to be the champions in advocating changes in the media industry as far as gender socialization is concerned.

## TOSCI assists seed dealers by sensitising them on laws

THE Tanzania Official Seed Certification Institute (TOSCI) is implementing a robust programme to assist the seed dealers in the country to deliver services in reflection to the Seed Act, 2003 and its regulations.

The State-owned seed regulatory body has decided to run the initiative in order to contain a spate of irregularities among most of the seed traders, a move that weakens performance of the seed industry within the country.

According to TOSCI's director general (DG), Dr Patrick Ngwediagi some of the seeds dealers are not recognised nor register themselves at TOSCI, which is against the Seeds Act 2003, and Seeds Regulations of 2007.

Expressing other challenges, Dr Ngwediagi noted that some dealers are marketing expired seeds (of above 7 months), while others have a negative tendency of opening seeds packages in order to re-measure and sell it in different quantities.

"After investigating the said irregularities in seeds marketing, we have patriotically decided to take a sober initiative to educate the seeds dealers so as to assist them to perform their business in needed standards," he stated.

Moreover, he added that some of the seed traders are marketing seeds without official labels of TOSCI or the Organisation for Economic Co-operation and Development (OECD).

"As per the ruling regulations, all home-based produced

seeds to be marketed must possess an official label from TOSCI, whereby those from outside the country must have OECD's labels," he detailed.

He stated that the initiative also targets to empower the

traders with professional seeds storage manner, observing that some traders used to store seeds on the cement-floor while others are hoarding the seeds together with fertilizers, which is unprofessional.

He insisted that TOSCI will not hesitate to issue punitive

measures against all traders who will continue their business without adhering to the Seed Act, added: "As per the provisions of the Seed Act 2003, any person/dealer who will found to have violated the set regulations will be imposed with a fine from 1m/- to 500m/- or a jail sentence for one year,"

The TOSCI chief boss insists that the seed traders must ensure all seeds they receive from agencies fulfill all requirements, including TOSCI and OECD labels.

"Apart from the said labels, the seeds packages must also include a special paper note with key information like germination percent, purity percentage as well as seed lot number (fn) 27001TAN 123," he added.

He said the institute has a number of plans ahead to implement in a general quest to ensure the country is equipped with quality seed varieties with the dealers executing their business in accordance with the Seed Act 2003 and the relevant regulations.

With its headquarters based in Morogoro, TOSCI is now recognised internationally since it has been accredited to International Seed Testing Association (ISTA), and Organization for Economic Co-operation and Development (OECD) Seed Certification Schemes, whereby seed produced in Tanzania and certified by TOSCI can now be sold in the country and the excess can be exported to other countries.

TOSCI is responsible for field and seed inspection, sampling, seed testing, variety evaluation and verification through National Performance Trials (NPT), Distinctness, Uniformity and Stability tests (DUS) and control plot testing.

Tanzania is also a member of the International Union for Protection of New Varieties of Plants (UPOV), since 2015.

#### SA's Library for the Blind is an idea worth emulating

OMEWHERE in Grahamstown financial, material and other support in South Africa's Eastern Cape Province lies a facility - or, rather, an institution - called the South African Library for the Blind

Records show that the library was founded in 1918 courtesy of an arrangement between two women - a Grahamstown inhabitant and a missionary from England.

The library service started in earnest the following year with little more than 100 Braille books and pamphlets stacked in a single room.

It's a long story but highlights include the fact that the year 1998 saw the facility receive statutory recognition as a national South African resource.

And, in a word, the law is categorical that the facility's affairs are controlled by a board appointed by the Arts and Culture minister.

Additionally, the library receives some state subsidy and is legally charged with the responsibility of, among other things, serving the reading needs of South Africa's visually impaired and printhandicapped persons.

To ensure enhanced utility and efficiency, the library provides free Braille books - with some now digitally produced and made available to members by e-mail.

One especially heartening feature about the rare institution is that the modest building housing it bears a signpost reading: "Library for the Blind -We are on the same page".

This suggests that part of the mission here is to make deliberate efforts to ensure that both the visually impaired and their sighted peers benefit as much as practicable from the services libraries are supposed - or expected - to offer.

Indeed, Internet searches easily show that the services offered by the pleasantly unique institution are of unparalleled relevance and utility to the visually impaired. The services are also part of evidence of the unwavering efforts of a people socially committed to striving, in co-operation with others, to remove barriers to accessing information.

Indeed, everything pointed to commitment to providing quality services to meet, as fully as human and other resources allow, the information needs of all those meant to be reached This makes us cast another glance

at the history of the facility - that it was born of humble beginnings in the form of a person's private collection of no more than a hundred Braille volumes plus

We are told that SALB received the first talking book machines from overseas in 1949, with the South African Post Office granting it and its members a free post concession some four years later. It was declared a Cultural Institution and National Library for the Blind in 1968, setting up audio and Braille in-house production units in 1992 and entering production of digital audio books in 2004. It is worth noting that the library's mandate is in accordance with the South African Constitution and a 1998 law - and is therefore legally in consonance with the values upon which the country is

the 1918 global flu pandemic.

These values include respect for human dignity, advancement of human rights, accountability and democracy.

The library meanwhile also strives to make a contribution to the African continent generally by standing as a resource of advice and expertise in its focus area. The facility is legally mandated to provide access to free and appropriate information and other services responsive to the needs of all those it is there to serve.

This is in line with its vision of adding value to the quality of the lives of these special-needs people by helping them access information to facilitate their participation in informed decisionmaking alongside taking pleasure in the enjoyment of recreational reading.

SALB ascribes the achievements it has made chiefly to the sacrifice made by people and institutions moved by the plight of the visually impaired and therefore inspired by the need to build a better South Africa.

Despite its decades of existence, though, the library will likely still be experiencing a number of operational challenges - even problems. This would be hardly surprising, considering that few libraries ever enjoy handsome budgetary and other support these days.

However, the mere fact that institutions of the kind exist speaks volumes about the extent to which communities and nations can go towards translating the concept of social responsibility into needs-focused action. Admittedly, Tanzania has made

encouraging headway in empowering the visually impaired and other people with disabilities. But South Africa's SALB experience is well worth learning from, as doing so could mean doing much better for the good of even more variously disadvantaged people.

## India publishers discuss post-Covid recovery: 'The fear of the unknown is no longer there'

FTER the upheaval caused by the Covid-19 health crisis, large parts of the Indian news industry have started to see an upturn.

A recent conversation among publishing executives explored the long-term impacts of the pandemic, including a quicker adoption of new technologies and an accelerated shift from an advertising-driven business model to paid content.

Phrased a bit differently, as the immediate effects of the health crisis start to subside, the mood among Indian publishers is increasingly hopeful about the future. However, there is a renewed urgency to reassess some of the industry's fundamental building blocks. This was the message from a recent

panel at the recent Indian Media Leaders eSUMMIT organised by the World Association of News Publishers (WAN-IFRA).

The participating CEOs took stock of the situation two-plus years after the pandemic started and discussed the steps their companies have taken to ensure that they are braced for a seemingly uncertain future.

#### Covid-19 accelerated productivity

"Any data or metrics of today compared to when Covid-19 hit would look good, positive and hopeful. This is simply because Covid-19 was a disaster in terms of business and in terms of the crisis it posed for us," said Dhruba Mukherjee, CEO of ABP.

Although ABP experienced "zerorevenue days" during the toughest days of the pandemic, Mukherjee said the situation has now greatly improved: advertising has started to recover, even if it's "nowhere near pre-Covid levels", while circulations are now at about 80 per cent compared to before the

He said that beyond the improving business metrics, perhaps the biggest step forward has been psychological.

"The fear of the unknown is no longer there. The fear is out. It's just that you kind of brace for what new challenges each wave will bring and how you respond to that," he added.

Part of that mindset change follows big advances in operational and accelerated streamlining technological adoption, noted Rajeev Beotra, Executive Director of HT Media

He added: "There have been collateral benefits of the pandemic. All of us worked on productivity improvements, several projects were fast-forwarded, technology was adopted faster, and processes were



prepared to face anything - we have seen very different degrees of peaks and troughs."

"It's not as if businesses did not have peaks and troughs earlier, but the cycles have become much shorter now, and I think we've all learned to adapt and cope with it," he said.

#### **Business model with paid content**

While the business outlook may surely be improving, there is no denying that the pandemic caused many publishers to question their revenue models, most notably their reliance on advertising.

Indeed, "The mix of advertising and subscription needs to change by investing in content, investing in journalism," argued Dr Bhaskar Das, Director of Unica Token Pvt Ltd.

Although the rise of digital paid content is a global trend, he said that print has a strong advantage in India as a trusted medium.

He explained: "I'm very optimistic about print, at least in India, and the business model recalibration can take print to new heights. And in this age of lack of credibility and trust, print is the only oasis."

One example of an evolving business model comes from the Hindustan Times, which implemented a paywall during the pandemic, and won first place for Best Reader Revenue Initiative in WAN-IFRA's 2021 South Asian Digital Media Awards.

Beotra said prices were also increased across the company's websites that are behind the paywall, noting about the Covid-19 crisis: "It's not as if we had a lean period throughout but there were windows of opportunity".

He added: "The festive period was good, some elections happened, and briefly, so all of us have learned to now manage those business cycles better compared to earlier."

#### organisational Accelerating changes

Mukherjee stressed that the prevailing kind of volatility was there to stay, and businesses needed to prepare accordingly.

He elaborated: "It has been a very bumpy ride. I can't say right now that we feel that it's going to be smooth sailing. It's not.

"We feel that now it's going to be the order of the day, that there won't be any smooth sailing at least in the near term. There's going to be turbulent waters and we need to just learn to navigate the ship accordingly.'

Mukherjee reported that during the lockdown in April and May 2020, "when we were seeing our newspapers going out without any advertising whatsoever, ABP started a serious reflection on their business fundamentals. The whole revenue model came under scrutiny".

He said that process led to an active diversification of revenue streams, one result of which was the withdrawal of all subscription discounts.

The ABP chief executive noted further: "We always had this question: Will readers pay for good content, the right content?' We believed that we created good content. But we never probably had that strength of conviction to try it out by stopping all discounted subscription schemes and

asking the reader to pay the full price. "Covid helped us do that. And we were lucky to come out unscathed. And then it also gave a huge amount of confidence to the team and to the organisation that, yes, if you publish the right content, people will probably

pay the full price.' Asked if there has been a turning

the economy rebounded in between point in the recovery process, Mukherjee underlined the importance of agility: "It's a cliché, but the turning point has been the ability to believe that you can disrupt yourself and still come out stronger, rather than wait for somebody else to come and disrupt us. Now we are getting to that."

#### Are there good times ahead?

Asked about the outlook for the future, Mukherjee was clearly optimistic: "They say hope is not a strategy but hope is a great motivator. I certainly live in hope and I am a little bullish right now looking at the fundamentals, because we all made fundamental corrections in our model. I think we have a positive outlook for print in general - and for content as a business.'

On the other hand, Beotra highlighted the fact that newspapers ought to be ready to face challenging situations also in the future by learning to spot the opportunities that arise.

"I think it's more about being able to identify the opportunities that will keep coming, so it will eventually boil down to how well we can maximise these opportunities. People have done that in the last two years, and that's how it will be for a while."

Dr Das meanwhile underscored the need for news publishers to rapidly reassess their revenue streams: "Businesses don't die, business models

According to him, a stable foundation to work towards would be a structure where about 65 per cent of a publisher's revenue come from subscriptions and 35 per cent from advertising.

## Not a nightmare if 70 pct vaccination isn't attained

EALTH minister Ummy Mwalimu is fighting hard to ensure that the country attains the 70 per cent Covid-19 immunisation coverage by the end of the year. Very understandably so, as that remains a key objective for the government.

While there is indeed the risk of new Covid-19 variants, and again especially in under-vaccinated populations, the issue of the protection of those most at risk has already been conducted - the elderly in particular.

There was also a special appeal from President Samia Suluhu Hassan for jab turnouts for people with underlying conditions, frontline health workers and people working in sectors such as tourism and hospitality.

In some places, especially in the

tourism sector, it was a requirement just as applied to upper levels of the hospitality industry, including tourist hotels. Too bad, with ordinary hotels or guest houses, it is usually the normal reflex that applies.

While the government will be intensifying campaigns on vaccination against the disease, on the basis of reports that new cases are being reported, it is worth remembering that plenty of discussion went into the whole issue on the local and global stages.

No wonder, it had to take a resurgence of polio cases in northern Nigeria for traditionalist authorities there to accept an immunisation campaign during the past decade. In 1998 some one million US dollars meant for the purchase of polio vaccines was misappropriated

Therefore, it's crucial that we continue reminding people that testing physical resilience against Covid-19 isn't a good thing and that myths suggesting that medication is badly intentioned just do not help.

Yes, infections are far from a daily occurrence and what the UN says is 'herd immunity' is likely to continue coming in handy. Still, that should not mean it would be wise to ignore or rule out the need for taking the jab, surely.

## It has taken long but, now, Kiswahili has received the honour it deserves

N the 1950s the United Nations established Kiswahili Unit of United Nations Radio. And today, it is the only African language within the Directorate of Global Communications at the UN.

Last week, Tanzania joined other countries to celebrate the World Kiswahili Day for the first time since the governing council of the United Nations Educational, Scientific and Cultural Organization (UNESCO) announced 7th July of every year to honour the language.

The move makes Kiswahili the first African language to be recognised by the United Nations and given a special day of its commemoration worldwide.

In Tanzania, Vice-President Dr Phillip Mpango graced the colorful celebrations at an occasion held in Dar es Salaam and attended heads of foreign missions as well as dignitaries from the East African Community (EAC) and Southern African Development Community (SADC).

During the celebrations, Dr Mpango witnessed the signing of an accord between Tanzania and South Africa in which the two countries committed to cooperating in an exchange programme to allow Tanzanian experts teach Kiswahili in South Africa.

This came after a long dialogue the two countries have been holding as part of strategic plans started in 2019 on how Kiswahili should be included in South Africa's education system.

Professor Adolf Mkenda, Minister for Education, Science and Technology and South African Minister for Basic Education Matsie Motshekga signed a Memorandum of Understanding (MOU) for Tanzania to provide teaching services and technical support to primary schools in South Africa.

Apart from African continent, Kiswahili has also acquired an international accolade for having been taught in some universities in countries such

as USA, Germany, China, Japan and South Korea. Within SADC region it has been approved for teaching in Namibia and South Africa.

With over 200 million speakers, it is one of the most widely used African languages, encompassing more than a dozen main dialects. Over the centuries, this Bantu language has emerged as a common form of communication in many parts of sub-Saharan Africa as well as some countries in the Middle East. It enjoys official language status within EAC, SADC and African Union.

In recent days, Ugandan government announced it had realized the role and importance of Kiswahili as it is being used in EAC Legislative Assembly sessions and announced the decision to make it compulsory subject in both primary and secondary schools.

While announcing the country's decision passed by Cabinet, Ugandan Minister for Information, Technology and Communication Dr Chris Baryomunsi said that all government documents will be presented in Kiswahili.

The decision by Ugandan government follows directives issued by heads of EAC member states in their 21st Ordinary Summit held at the bloc's headquarters in Arusha in February 2021. The meeting resolved that Kiswahili be used as an official language in addition to English which has been in use since the community was

formed.

It has become an important language for EAC member states whereas for Tanzania and Kenya, it is officially recognized and widely used as nation-

al language

Apart from Kenya and Tanzania, other nations which speak Kiswahili are Uganda, Rwanda, Burundi, DRC, Malawi, Zambia, Mozambique, Zimbabwe and South Sudan. In Uganda for instance, President Yoweri Museveni speaks fluent Kiswahili. Military and police in Uganda also use Kiswahili.

Speaking at a symposium held a day before the celebration, Abdulrahman Kinana, CCM Vice Chairman of CCM (Mainland) said that Kiswahili helped mobilize people in the struggles for independence in the country as well as liberation of a number of southern African countries.

"Kiswahili Day has a great significance in political landscape in Tanzania because on the same day (7th July) in 1954, at a time when the country was called Tanganyika under British rule, the first African political party called Tanganyika African National Union (TANU) was formed," he said.

Led by Father of the Nation the late Mwalimu Julius Kambarage Nyerere, all TANU founders and top cadres who championed the push for independence used Kiswahili in their public engagements with the people.

Since then, Kiswahili continues to be a symbol of unity to Tanzanians and this is applauded all over Africa because it is rare to find a country on the continent where one can communicate in every corner without language barrier.

Eric Kajiru, Programme Manager for Tanzania National Commission for UN-ESCO said that the recent recognition of Kiswahili language is a step towards acknowledging it among international languages in the world.

According to him, efforts are underway by UNESCO Tanzania office to enable Kiswahili acquire full status as an international language among six others already accepted by the UN.

English is the dominant international language used in most regions of the world in terms of trade, science, medicine, sport and many other key areas such as diplomacy. Other languages are French, Spanish, Russian, Arabic and Chinese.

CHALLENGES in our education are numerous and every day, people and organizations conceive and float various ideas that can help improve provision of not just education but quality education in the country.

The need to improve education is underscored by the value that the society attaches to it. English people have this saying on the importance of education: "If you think education is expensive, try ignorance."

With that saying, it becomes a must to think of how to improve our education. Philosophers and psychologists say that we humans are a product of our thinking. Embracing this, having tireless struggles in improving our education which is the basis of our thinking is justifiable.


One of the areas to improve in our education system is writing of curricula, syllabuses and books which are to be harmonized. If one examines syllabuses and books, they will note that there is no harmony between them hence making implementation of curricula impeded. There are contents which are in syllabuses but not in books and there are contents in books but not in a syllabus.

The effects of disparity in terms of contents between syllabuses and books are several, one of them being challenges in covering contents. A teacher may fail to cover a certain aspect of study due to lack of materials for that particular aspect. Also, a teacher may teach things which are not needed due to relying on a book without consulting the syllabus.

Teaching things which are not in a syllabus will predispose a teacher to waste precious time unnecessarily and hence causing negative effects. The time which is wasted in covering unrequired contents may be used in dealing with areas which have proved difficult for pupils to grasp.

One may argue that how can a professional teacher rely on a book and not both a book and syllabus in preparing lessons? In fact, that argument is valid regarding the pro-

fessional standards observance, but it should not be forgotten that a teacher is a human being who can hardly escape fallibility as other professionals may also do.

Another challenge which may result from disparity between curricula, syllabuses and books is unfair teaching of the contents. Sometimes the curriculum indicates a very few number of periods per week for a certain subject but the reality is that the contents of that particular subject cannot be taught within the time limit stipulated in the curriculum.

A teacher may get confused when planning lesson. He or she fails to know who was mistaken between the writer of curriculum, the syllabus or the book! Eventually, the teacher may force to finish the contents within the time limit of syllabus or curriculum and making most if not all pupils incompetent in certain areas covered.

Also, the disparity in curricula, syllabuses and books may cause conflicts in a school where a teacher can be blamed for not finishing in time a certain topic or three subjects for primary schools for standard seven, we may try to establish a conviction that may prove the validity of harmonizing the writing of curricula,

syllabus regarding the number of periods indicated in a syllabus or curriculum. In this case, the wideness of the subject is measured by the number of periods per week for a particular subject.

In a simple and common way of suggesting which subject is wider than the other, the number of pages in a book can be considered. Taking into account three subjects for primary schools for standard seven, we may try to establish a conviction that may prove the validity of harmonizing the writing of curricula,

syllabuses and books. Those subjects are Social Studies, Vocational Skills and Civic and Moral Education.

The Social Studies book has 186 pages and the subject has been allocated 3 periods per week in the curriculum, Vocational Skills book has 138 pages, and has been allocated 2 periods while the Civic and Moral Education book has 130 pages, and has been allocated 5 periods in the syllabus as well

Any positive critic may try to question the validity of the distribution of peri-

ods per subject per week. One may defend the above arrangement with a claim that there are subjects with concepts that may seem short but having complex and broad meaning when it comes to their coverage and analysis.

That claim may be accepted, but what should be done for those subjects whose concepts are considered simple but have numerous materials when they are to be taught?

The issues raised above justify the argument that the writing of curricula, syllabuses and books should be harmonized so that the objectives in education may be realized.

The outcomes of harmonizing curricula, syllabuses and books are obvious. One is that there will be a correct allocation of periods per subject per week. Also, there will be confidence in the teaching and learning process as the application of the curricula and syllabuses will be practical and hence absence of unnecessary confusions, conflicts and disappointments.

When a big job is done, it's likely to bring big results as well. There is this Kiswahili saying which can literally be translated as a goat eats depending on the length of the rope it is tied to. Working hard for our education will increase the length of the rope, making it possible for us to enjoy a wide range of pastures that our education will guarantee. Success demands a beginning.

## WWF joins the AFR100 management team to further accelerate restoration

HE African Forest Landscape Restoration Initiative (AFR100) is a country-led effort to bring 100 million hectares of land in Africa into restoration by 2030. The African Union (AU) endorsed the 100 million hectares goal in October 2015 as a continental-wide ambition and to provide for strong legitimacy and its ownership by African countries. This initiative is part of the global commitment under the Bonn Challenge and is aimed at supporting countries to realize number of international commitments including Sustainable Development Goals (SDGs), UN Convention of Biodiversity (CBD), UN Convention on Combating Desertification (UNCCD) and the Paris Climate agreement.

The AFR100 international institutional arrangement is made of the Secretariat, among others. The Secretariat, under the African Union Development Agency - New Partnership for Africa's Development (AUDA-NEPAD), with mandate from the African Union Heads of State and Government, is the main contact for the initiative that coordinates partners to jointly mobilize and sustain political support. The Secretariat with support from partners, provides technical support to assess restoration opportunities and support the implementation of Forest Landscape Restoration (FLR) at scale and include number of international organizations such as World-Wide Fund for Nature (WWF). This role is delivered with the support of the AFR100 management team, of which WWF just joined and announced officially during the AFR100 Annual Partnership Meeting in Blantyre Malawi 27th June - 1st July 2022.

WWF being a technical partner and a member of the AFR100 management team, is re-iterating its commitment of working with AFR100 Secretariat, partners and the governments where there is WWF's physical presence to accelerate restoration phase II. WWF has developed a regional FLR programme covering 9 countries in Eastern, Southern and Central Africa. These countries are Cameroon, Democratic Republic of Congo, Kenya, Madagascar, Mozambique, Tanzania, Uganda, Zambia and Zimbabwe.

#### Why this WWF FLR in Africa programme?

Forests and Landscapes are critical components of nature, providing a myriad of benefits to people and ecosystem. High proportion of Africa's population depends on forest resources for their livelihoods. About 90 per cent of Africa's population depends on firewood and charcoal for

energy, especially for cooking. More than 60 per cent of Africa's population depends on goods and services from forests and other ecosystems, whereas 80 per cent of Africans use medicinal products from forests. However, high deforestation and land degradation rates are compromising the sustainability of forest resources production to meet people's demand and ecosystem services provision. Statistics show that forests are being lost at a worrying rate despite their importance to people and nature. About 4.4 million ha of forest is lost annually in Africa, while 65 per cent of productive land in Africa is already de-

Despite the increasing number of challenges, there are emerging positive interventions and opportunities. The FLR in Africa Initiative through the AFR100 is one of them. The FLR is recommended approach in mitigating deforestation and land degradation challenges in Africa to achieve multiple benefits, it is a key activity for green recovery as it stimulates investments and creates jobs primarily in rural areas and helps to secure livelihoods of local communities while also contributing to reverse biodiversity loss and mitigating climate change, and the inclusive conservation through 'Integrated and landscape' approach for FLR is envisaged to reverse the situation in Africa - addressing and solving contested interests.

The FLR is an on-going process of regaining ecological functionality and enhancing human well-being across deforested and degraded forest landscapes. Landscape Restoration is a key activity for green recovery as it stimulates investments and creates jobs and helps to secure livelihoods of local communities while contributing to reversing biodiversity loss and mitigating the impact of climate change.

FLR is more than planting trees: It's about restoring ecological functions across whole landscapes for multiple benefits for people and nature. It does it by bringing on board a wide range of actors to deliver various interventions depending on thematic areas and sectors to achieve multiple benefits for people (human wellbeing) and nature (ecosystem services).

After the Bonn Challenge, which is a global vehicle to bring 350 million hectares of degraded and deforested landscapes into restoration by 2030, the African Forest Landscape Restoration Initiative (AFR100) was born to actionalize the Bonn Challenge in Africa. A total of 32 countries have pledged to restore 128 million hectares to date. Despite the good intentions and commitments from the governments, implementation is already well behind schedule.

Why has the AFR100 commitments' implementation been slow? There are a number of challenges: FLR is a challenging concept and many different interpretations of the term and the approach co-exist, inequitable tenure and property rights, leading to insecurity and conflict with subsequent impacts on FLR investment and implementation and human and technical capacity to implement FLR effectively remain insufficient.

Others are locally relevant tools for FLR are still missing, poor infrastructure creates access difficulties, making it difficult for support staff to enter the landscape and support implementation, but also for products from the landscape to reach markets and information gaps and the lack of mechanisms to share results hamper the dissemination of success stories, and an ability to build on existing knowledge and expertise.

Having been aware of these challenges, WWF conceived the idea and did develop this FLR regional program to accelerate the implementation of FLR in Africa through the AFR100 Secretariat. This WWF FLR in Africa program is an ambitious multi-country initiative that aims to kick-start the restoration of 13.5 million hectares of degraded and deforested landscapes across 9 countries by 2027.

Goal is to enable governments in the 9 target countries to deliver their AFR100 commitments in a just way that promotes sustainable livelihoods of local people, resulting in 13.5 million ha of degraded land and deforested forest landscapes under restoration by 2027. The programme's strategy is based on pursuing three main pillars: One is enabling policy, governance and institutional frameworks; two, promoting finance and market enablers; and three, delivering AFR100 commitments on the ground, at scale.

Pillar 1 is enabling policy, governance and institutional frameworks: lays the foundation for up-scaling FLR by identifying potential areas for advocacy and capacity strengthening on enabling policies and institutional arrangements and tenure security rights that facilitate FLR up-scaling.

Objective is to see that WWF would effectively be engaged in AFR100 promoting enabling policy and institutional frameworks for FLR in the 9 countries generating large-scale restoration opportunities and investment

Pillar 2 is promoting finance and market enablers: seeks to leverage new and enhance existing business models and finance for NbS and FLR, to establish economic development pathways that are decoupled from deforestation and conversion and also build mechanisms that will facilitate structuring partnerships and

Objective of this is to see that WWF would ensure that Business models, financial mechanisms or incentives, and related opportunities are created that restore degraded and deforested landscapes, improve local livelihoods and enable wildlife habitat connectivity

Pillar 3 is delivering AFR100 commitments on the ground, at scale: brings in WWF-led actions on the ground at the national, landscape and community levels through co-design and co-implementation approaches with stakeholders. This pillar will incorporate efforts aimed youth engagement, technology and knowledge transfer, as well as green entrepreneur-

Objective is WWF and partners would ensure that transformational implementation of AFR100 commitments in the 9 countries is catalysed through an integrated and landscape approach and a regional movement.

#### WWF Africa offices are already delivering FLR pro-

This programme, building on previous and ongoing experience, will replicate this experience to avoid mistakes and hence speed up the implementation of sustainable FLR interventions.

WWF believes in power of partnership: Partnership and collaboration are the cornerstone principles for the implementation of this program. To ensure sustainability of this program during the implementation, WWF being AFR100 Sec technical partner and member of the management team, will: directly support the AFR100 implementation success; bring additional and structured capacity and we will promote integration among stakeholders.

Also, it will promote the implementation of the FLR principles across the projects; support to channel additional funds for FLR and bring technology and innovation (monitoring and reporting tools).

## Tanganyika DC wants TARI technical know-how to boost cotton production

UTHORITIES in Tanganyika District, Katavi Region have tasked the Tanzania Agriculture Research Institute (TARI) Ukiriguru to camp in the area and interact with cotton farmers so that they can acquire new technologies of farming various crops to increase production.

Tanganyika District Commissioner Onesmo Buswelu said the district has large virgin land, good climatic condition throughout the year, suitable land for agriculture but the farmers have little knowledge on the latest technologies to farm productively.

Buswelu made the call recently when launching Cotton Victoria project during farmers' field day in a brief ceremony held at Majalila village in the district.

The project is being implemented around Lake Victoria regions of Mwanza, Simiyu, Geita, Shinyanga, Mara, Tabora and Tanganyika in Katavi. In this new project researchers and farmers have proved that the farmers who used to get between 250 kg and 400 kg per acre they can now harvest more than 700 kg per acre. With favourable climatic condition and good agronomic practices, the farmers can

get more than 1000 kg

He said cotton farmers in Tanganyika district are hardworking and are in dire need of new technologies that would increase production and productivity.

He also asked farmers to follow ten steps of good agronomic practices saying TARI can bring useful technologies but without adhering to good agronomic practices, yield will not change.

"Our farming system in Tanganyika will be more efficient if farmers apply principles that are well adapted to the agricultural producconditions here are good, he

He said with the new spacing system, the farmers will be able to expand the farming areas, engage in commercial farming, get more profit and change their live-

Representatives the Ministry of Agriculture Timotheo Semuguruka and Shenal Nyoni called on extension officers who have received training from TARI to work hand in hand with the farmers to improve their agricultural practices in

tion, adding that he climatic their respective villages and

They said the extension officers have been equipped with working tools such as motorcycles that enable them to reach the farmers' field on time and help them to conduct fruitful agricul-

"Make sure that these good agronomic practices are taught and demo plots are established in every village and wards so that many farmers can benefit," said

A representative of TARI Dr Deogratias Lwezaura told Katavi farmers that TARI has a range of technologies available for the farmers. He said the new spacing system aimed at increasing produc-

tion and productivity. "Katavi has a very favorable climate for cotton farming. Technologies are readily available for the farmers. It's up to the farmers to access these technologies in the nearby TARI centres to improve your cotton farming," he said.

TARI Ukiriguru centre director Dr Paul Saidia said in recent year's cotton production and productivity in the to different reasons, one of them being poor agronomic

Giving example of spacing Dr Saidia who is also the National cotton research coordinator said in this new spacing, the distance between rows and holes has reduced yield ranging from 300 kg to 400 kg per acre. Potential yield of UKM08 cotton variety per for example is 1,200 kg per acre and it can go beyond 1400 kg/acre using the new crop spacing of 60/30. So what researchers are doing is to address the gap and increase cotton productivity in Tanzania, he said Saidia who is also Ukiriguru centre acting di-

He said in 2016 researchers from Tanzania Agriculture Research Institute in collaborating with researchers from Brazil and the Tanzania Cotton Board (TCB) started conducting research through Cotton Victoria pro-

The research aimed at increasing yield through proper crop spacing. So a number of farmers were involved. Along the Lake Victoria Zone, the project started in Mwanza region. The farmers found that the yields had gone up twice and in some areas the yield increased four times. Some farmers witnessed increase in yield from 200 kgs per 1,200 kg per acre. So that increase has influenced us to move from Mwanza region to other areas such as Geita, Simiyu, he said.

He further explained that the approach was to invite extension officers at least 20 from each region for training on good agricultural practices. Among other things, the training emphasized on the importance of adoption the new spacing system. Thereafter, it was made clear that those who have received the training should go all the way training the farmers on their respective work stations.

"We made sure that every extension officer train farmers on their respective areas. Finally we communicated with them that they should establish demonstration plots in their respective areas to exhibit to other farmers who did not get chance of attending the training and it worked out very well because seeing is believing," said senior researcher

He said the farmers were convinced that even when

## Cameroon orders investment in wheat production to quell protests sparked by

running shortages

CAMEROON President Paul Biya says the government will increase funding to grow more wheat after protests over wheat shortages and price spikes sparked by Russia's invasion of Ukraine. Before Russia's Black Sea blockade, Cameroon imported 60 percent of its wheat from Ukraine. The cut-off has led to a nearly 50 percent increase in the price of bread.

Cameroon government says President Paul Biya on Monday ordered an immediate disbursement of over \$15 million to grow wheat in the central African state.

Cameroon's agriculture minister, Gabriel Mbairobe, says Biya responded to pleas from civilians that the cost of living is becoming very high, and many Cameroonians are finding it very difficult to put food on the table.

Mbairobe says Russia's war in Ukraine has completely disrupted supply chains of consumer goods, especially wheat, which is the main staple food in Cameroon. He says investing in wheat production is a wise decision because each Cameroonian consumes 33 kilograms of wheat each year which is far more than 23 kilograms of rice each Cameroonian eats annually. He says wheat can be grown in several places in Cameroon.

The government says Cameroon produces less than one-fourth of the 1.6 million tons of wheat it needs each vear. Last vear, the government imported more than 850,000 tons from Russia and Ukraine. Now, according to the Cameroon Importers Union, up to 25,000 tons have been imported since January 2022.

Mbairobe says while the nation waits for its own newly planted wheat to be harvested before the end of the vear, local substitutes like sweet potato, cassava and yams should replace the wheat Cameroon imports from Russia and Ukraine.

Cameroon says while baking bread, backers should replace imported wheat with local substitutes such as cassava, yams and potato.

Biya's instructions for more than \$15 million to be invested to grow more wheat come after several weeks of nationwide protest against cereal shortages. The shortage of wheat has led to a close to 50 percent increase in the price of bread.

Delor Magellan Kamseu Kamgaing, the president of Cameroon's Consumers League, says his league organized the protests to force the government to take immediate actions that will reduce growing hunger and anger among civilians.

Kamgaing says after COVID-19, Russia's war in Ukraine is leading to severe food shortages and unprecedented hikes in the prices of imported staple foods like cereals. He says people are hungry and unable to afford bread which is consumed by a majority of households in Cameroon. Kamgaing says the government should dialogue with its citizens and take measures that will stop a looming famine.

Kamgaing said the government should provide fertilizers and subsidies to local farmers to increase plantain, rice, yam and cassava production.

Kamgaing said the war in Ukraine though causing sufferings should provide an opportunity for Cameroon to invest in its local industries and stop over dependency on imports.

The government says the money ordered by Biya will either be used in buying fertilizers or paid out as subsidies to wheat farmers. Some of the money will be used to purchase trac-

## Africa seeks private sector funding for ocean climate action

COUNTRIES on Africa's west coast are increasingly turning to climate funding initiatives to boost livelihoods of Oceanside communities, aid biodiversity and take climate action.

On the margins of the high-level political forum on sustainable development currently under way at the United Nations headquarters in New York, African coastal and island states and conservation groups outlined plans to boost ocean conservation and economic development. The plan is to use a system of "blue bonds" – a method of financing projects that would

also benefit ocean health. Following on from Africa's Great Green Wall, which spans its Sahel region, east African nations are now seeking funds for the Great Blue Wall initiative, which aims to protect marine areas across the coastline. Both blue and green finance refers to funding aimed at preventing environmental damage and com-

batting climate change while creating sustainable ecosystems.

"The blue bond is a powerful example of the critical role that the capital markets can play in supporting sustainable objectives," said Jorge Familiar, vice president of the World Bank.

The Great Blue Wall initiative, launched last year by 10 western Indian Ocean states during the UN's climate conference in Glasgow, aims to create a network of coastal

and marine protected areas. Supporters say it would restore and conserve some two million hectares of ocean. capture 100 million tonnes of carbon dioxide and secure livelihoods for more than 70 million people.

The project spans the continent's east coast - from Somalia to South Africa - and includes the island states of Comoros, Madagascar, Mauritius, Seychelles, Somalia and the French territories, Mayotte and Reunion.

Jean-Paul Adam, who heads the climate division at the UN Economic Commission for Africa, said the blue wall initiative would recognise "the true value the environment has in future wealth creation and empowerment of local com-

munities".

"We need to dramatically upscale private sector investment into green and blue sectors," he said. Less than one percent of so-called blue and green bonds, which are used for marine and land projects respectively, are issued for African countries.

"The next steps are to make these markets more accessible to African countries," he added.

The UN says many of the financial climate promises made by richer countries are not being committed to in full, meaning that many African nations are unable to take necessary adaptation and mitigation measures against the effect of climate change.

In its latest assessment, the African Development Bank said that between \$1.3 trillion and \$1.6 trillion is needed by 2030 to implement climate action in line with nationally determined contributions targets set by individual countries to limit global warming to 1.5 degrees Celsius (2.7 degrees F) and no more than 2C (3.6 F). But blue bonds are currently just a fraction of ocean conservation funding, the bank added.

"Bonds alone are not a panacea for the financing gap but they can allow us to raise large amounts," Adam said.

## Migrant workers from Mexico caught up in trafficking, forced labour and exploitation

**MEXICO CITY** 

duardo Reyes, originally from Puebla in central Mexico, was offered a 40-hour workweek contract by his recruiter and his employer in the United States, but ended up performing hundreds of hours of unpaid work that was not authorized because his visa had expired, unbeknownst to him.

Hired by recruiter Vazquez Citrus & Hauling (VCH), Reyes and five other temporary workers reached the United States between May and September 2017, months before starting work for Four Star Greenhouse in the Midwest state of Michi-

In 2018, they worked more than 60 hours per week, received bad checks, and never obtained a copy of their contract, even though U.S. laws require that they be given one.

When they complained to Four Star and to their recruiter about the ex-

ploitative conditions, the latter turned them over to immigration authorities for deportation in July of that year because their visas had expired, which they had not been informed of by their

In December 2017, the U.S. Department of Labor (DOL) authorized the arrival of 145 workers to the Four Star facilities in Carleton, Michigan. They were to earn 12.75 dollars per hour for 36 hours a week between January and July 2018.

Reves' case is set forth in complaint 2:20-CV-11692, seen by IPS, filed in the Southern Division of the U.S. District Court for the Eastern District of Michigan by six Mexican workers against the company and its manager, whom they accuse of wage gouging, forced labor and workplace reprisals.

This story of exploitation has an aggravating factor that shows the shortcomings of the U.S. government's H-2A temporary agricultural workers program, or H-2A visa program.

The United States cre-

ated H-2 visas for unskilled temporary foreign workers in 1943 and in the 1980s established H-2A categories for rural workers and 2B for other labor, such as landscaping, construction, and hotel staff.

These visas allow Mexicans, mainly from rural areas, to migrate seasonally to the U.S. to work legally on farms included on a list, with the intermediation of recruiting companies.

In 2016, the US Department of Transportation fined VCH, based in the state of Florida, for 22,000 dollars for a bus accident in which six H-2A workers were killed while returning from Monroe, Michigan to Mexico.

Two years later, the DOL's Wage and Hour Division banned VCH and its owner for three years due to program violations in the state of North Carolina, such as failure to reimburse travel expenses and payroll and workday records. However, both continued to operate in the sector.

The workers' odyssey begins in Mexico, where they are recruited by individual contractors -workers or former workers of a U.S. employer, colleagues, relatives or friends in their home communities - or by private U.S. agencies.

#### **Structural problem**

Reyes' case illustrates the problems of labor exploitation, forced labor and the risk of human trafficking to which participants in the H-2A program are exposed, without intervention by Mexican or U.S. authorities to prevent human rights violations.

Advocates for the rights of the seasonal workers and experts pointed to worsening working conditions, warned of the threat of human trafficking and forced labor, and complained about the prevailing impunity.

because many workers go into debt to get to the United States, and that gives the agencies a lot of power. They can set any kind of requirement for people to get the jobs. Sometimes recruiters make offers that look more attractive than they really are. That is fraud," she told IPS in Mexico City.

National Human Trafficking Hotline operated by Polaris in the US reflects the apparent increase in abuses. Between 2015 and 2017, 800 people on temporary visas, 500 of which were H-2A, called the hotline, compared to 2,890 people between 2018 and 2020 - a 360 percent increase.

Evy Peña, spokesperson for Mexico's Migrant Rights Center, said temporary labor systems are designed to benefit employers, who have all the control, along with the recruiters.

"From the moment the workers are recruited, there is no transparency. There is a lack of oversight by the DOL, there are parts of recruitment that should be overseen by the Mexican government. There are things that the Mexican government should work out at home," she told IPS from the northern city of Monterrey.

She said the situation has worsened because of the pandemic.

The United States and Mexico have idealized the H-2A program because it solves the lack of employment in rural areas, foments remittances that provide financial oxygen to those areas, and meets a vital demand in foodproducing centers that supply U.S. households.

But the humanitarian costs are high, as the cases reviewed attest. Mexico's Ministry of Labor and Social Welfare has 369 labor placement agencies According to Lilián López, registered in 29 of Mexico's recruitment, seven operate - including four in Mexico compared to the thousands

For its part, the DOL reports 241 licensed recruiters in the US working for "Economic vulnerability a handful of companies in

The ones authorized in Mexico do not appear on the US list and vice versa, in another example of the scarce exchange of information between the two partners.

The number of H-2A visas for Mexican workers is on the rise, with the U.S. government authorizing 201,123 in 2020, a high number driven by the pandemic. That number grew 22 percent in 2021, to a total of 246,738.

In the first four months of the year, U.S. consulates in Mexico issued 121,516 such visas, 18 percent more than in the same period of 2021, when they granted 102,952.

In 2021, the states with the highest demand for Mexican labor were Florida, Georgia, California, Washington and North Carolina, in activities such as agriculture, the operation of farm equipment and construction.

The United States and Mexico agreed to issue another 150,000 visas for temporary workers in an attempt to mitigate forced migration from the south, which will also include Central American seasonal workers.


Details of the expansion of the program will be announced by Presidents Joe Biden and Andres Manuel Lopez Obrador at a meeting to be held on Jul. 12 at the White House, with migration as one of the main topics on the agenda.

#### **Indifference**

Lidia Muñoz, a doctoral student at the University of Oregon in the United States who has studied labor recruitment, stresses that there are no policies on the subject in Mexico, even though the government is aware of the problem.

"There are regulations for recruitment agencies that are not followed to the letter," she told IPS from Portland, the largest city in the northwestern state of Oregon. "Most recruiters are not registered. The intermediaries are the ones who earn the most. There is no proper oversight."

Article 28 of Mexico's Federal Labour Law of 1970 regulates the provision of services by workers hired within Mexico for work abroad, but in practice it is not enforced.

## Five economic activities winning the hearts of banking sector in 2022



INERS, small and medium business owners, farmers, traders and manufacturers have continued to win the hearts of banking sector, after recording the strong growth of borrowing internally and externally, pushing smooth recovery of the economy.

Tanzanian economy is currently recovering from the impact of Covid-19, although supply-chain disruption caused by the war in Ukraine and sanctions on Russia are adding up risks to local business activities.

Bank of Tanzania (BoT) computations for the year ending May has shown that credit to private sector, the engine of growth, expanded by 15 percent from 4.7 percent in May last year due to improved business conditions, coupled with supporting monetary and fiscal policies.

The sharp growth of credits recorded on mining and quarrying with 37.9 percent followed by personal (Small and Medium Entreprises) by 26.6 percent, trade by 24.4 percent, manufacturing by 20.8 percent and agriculture



by 14.7 percent.

Credits extended to private sector from banking during the year ending May, according to banks and BoT computations reached nearly 24trn/compared with 21trn/- recorded in May last year.

rowers remain on high interest rates charged by commercial banks on loans, as BoT shows are currently at 16 percent for regular borrowers and 9 percent for farmers.

## Best-performing emerging market fund sounds alarm on debt defaults

**LONDON** 

MORE debt defaults are going to roll across emerging markets because countries can't cope with the sudden increase in borrowing costs, according to Man Group, which runs one of the best-performing funds in the industry.

About 10% of dollar-denominated sovereign debt is at a high risk of default, said portfolio manager Lisa Chua in an interview with Bloomb-

Russia and Sri Lanka have already defaulted this year, and there's now a record 19 developing countries with sovereign debt trading at distressed levels.

Chua, part of a five-person emerging market debt team led by Guillermo Osses that's beaten 99% of peers this year, said the fund was able to avoid some of the risks from Russia's war in Ukraine and steered away from crowded areas of the market.

"Not everyone will be able to roll over their debt in an environment of less abundant liquidity," said Chua. "We do expect to see more defaults and potential restructurings."

The number of nations with debt yields that indicate investors believe default is a real possibility has more than doubled in the past six months, according to data compiled from a Bloomberg index. At stake is \$237 billion due to foreign bondholders, with the market's focus on countries such as El Salvador, Ghana and Pakistan.

"High-vield, frontier markets that have issued more recently in that grab for yield are at risk," said Chua. "It is worth pricing in more default risk than is currently priced in the market."

Man, the world's largest publicly-listed hedge fund with \$151.4 billion under management, topped 99% of its peers with its emergingmarket debt fund returning 4.7% this year, according to data compiled by Bloomberg. By contrast, a Bloomberg in-

While Chua declined to talk about the fund's performance for legal reasons, she implied in a recent blog that the firm may have dodged the pain felt by holders of Russia's debt after its invasion of Ukraine, pointing to how the country's weak ESG governance

metrics, rich valuations and overcrowded positioning by other players were all potential red flags for Man.

"These issues were warning signs to us early on of potential risk on the ESG side and these risks took center stage as Russia started amassing troops at the border of Ukraine in the months before the invasion," she wrote.

"If market participants were truly concerned about downside risk related to an invasion, they should have also been decreasing positions in Ukraine, but that wasn't the case."

Following the effects of the invasion, from higher inflation to food supply disruptions, countries with pegged or heavily managed currencies may now struggle to adjust to economic shocks to pay back external debt, Chua said.

Such concerns have already led investors to pull \$48 billion from global emerging-market debt funds in the first half of 2022, according to Bank of America Corp. citing EPFR Global data. For the coming months, Chua is cautious, but sees opportunities to add higherquality assets if default fears cause a broad selloff.

The yields offered on riskier emerging-market debt are already at a twoyear high, giving investors 1% for every month for taking the risk. Major economies from Mexico and Brazil to Indonesia have also withstood the turbulence so far.

"The focus needs to be on risk reward, mitigating downside risk, and not just blindly buying beta and yield," Chua said. "We are entering a new regime where investors need to be much more focused on alpha generation, country selection."

### **Spain hits** banks and utilities with windfall tax

#### **MADRID**

SPAIN became the largest eurozone country to impose a windfall tax on banks in a sign of European governments' search for funds to lessen the painful impact of price

The move by Socialist prime minister Pedro Sánchez – which the government said was designed to limit banks' gains from rising interest rates - triggered sharp falls in the stocks of Spanish banks.

Shares in CaixaBank, Bankinter and Sabadell fell by about 10 per cent after the levy was announced while those of Santander and BBVA, the country's two biggest banks by market cap, dropped by nearly 4 per

The bank levy came without warning and drew strong criticism from

"This is a crude form of populism. The government argument is that banks are benefiting from rising interest rates," said José Ramón Iturriaga, an analyst at Abante Asesores. "But there was no state compensation during the long period when rates were negative."

Among other measures, the government plans to use the funds raised to build 12,000 homes in Madrid, make most state railway journeys free between September and December, and provide €2bn in scholarships for over-16s.

Sánchez, who leads a coalition government with radical left lawmakers, said a similar tax would be levied on energy utilities as part of the package aimed at protecting the less well-off from the impact of inflation and soaring energy prices.

"We are asking big companies to ensure that any exceptional benefits obtained during the current circumstances are channelled back to workers," Sánchez said in the opening address of a three-day state-of-thenation debate.

Inflation in Spain rose to a 37-year high of 10 per cent in June, up from 8.5 per cent in May.

## DTB set to spend Sh350m on new Kenyan branches

**NAIROBI** 

DTB Group is investing a total of Sh350 million to open 20 new branches in Kenya this year as part of its expansion

The lender has opened three branches and the remaining 17 will be established in the coming months.

"The capital expenditure for the 20 branches is Sh350 million. We are investing in both our digital platforms and physical branches to give customers hybrid services," said Alkarim Jiwa, chief financial officer at

The three branches recently opened are in Imara Daima

(Imaara Mall), Kamakis (Viashla Business Centre) and Kahawa Sukari (Ruhan Plaza) which pushed DTB's physical branch network in Kenya so far to 64.

The Nairobi Securities Exchange-listed bank will have more than 80 branches once all the new outlets have been established.

Mr Jiwa said branches still play an important role in banking despite more than 90 percent of transactions migrating to digital platforms.

The branches are important in terms of acquiring retail customers, solving their issues and offering them advisory services, among others.

DTB is also investing \$30 million (Sh3.5 billion) in digital services including Internet banking over two years. Investments in such platforms has intensified in the banking sector and is seen as a means to enhance efficiencies, grow scale and improve convenience for clients.

"As a tier-one bank, we are keen on increasing our market presence as this underpins our growth strategy. The investments we are making are not only a show of the bank's financial strength but also a sign of commitment to creating more convenience for our customers," DTB chairman Linus Gitahi said.

Chief executive Nasim Devji said the bank's move to continue expanding its branch network is a testament to its confidence in the Kenyan economy.

"As DTB, we remain optimistic about Kenya's economic recovery. We are, therefore, making strides to be closer to our customers to support them to attain their personal and business goals," said Ms Devji.

Other big banks that are also opening more branches in the country are Co-op Bank and NCBA Bank Kenya.

The sector, overall, has gone slow on physical expansion as uptake of apps, mobile, Internet and agency banking grows.

## Bank of China sees liquidity more than ample

**BEIJING** 

IQUIDITY in China's interbank market is more than "reasonably ample," the head of the central bank's monetary policy department said Wednesday, an indication that further rate cuts are unlikely.

The 7-day reverse repurchase rate is at around 1.6%, lower than the costs of short-term policy loans the People's Bank of China provides via its daily open market operations, Zou Lan said at a briefing in Beijing.

He was referring to a key interbank borrowing rate. The rate on the PBOC's 7-day loans for lenders is at

That suggests "liquidity has stayed slightly more than reasonably ample," Zou said in answer to a question on whether the central bank will continue to cut interest rates or the amount of cash lenders must keep in reserve.



The PBOC has taken a cautious easing path this year, refraining from cutting policy rates since January. It has instead relied more on structural measures to support targeted sectors such as the property industry, small firms

and has pushed banks to lend more. Credit jumped more than expected in June due to a rebound in bank loans and record government bond sales.

Governor Yi Gang recently signaled monetary stimulus will likely focus on boosting and infrastructure projects, credit rather than cutting in-

terest rates for the rest of this year, amid concerns over rising inflation and ongoing capital outflows as overseas central banks started tightening. All 18 economists polled by Bloomberg expect the PBOC to hold the rate on one-year policy loans steady on Friday.

Zou said Wednesday that the PBOC is keeping a close eye on domestic inflation as well as shifts of monetary policies in major economies. The Chinese central bank has taken preemptive measures to offset the impact of changes in the external environment on cross-border capital flows and continues to base its policy making mainly on domestic issues, he

With the economy showing early signs of recovery in June as Covid outbreaks and lockdowns eased, the PBOC has slashed its liquidity injections in the daily open-market operations since the start of July. That's sparked speculation that it's moving toward normalizing interbank cash conditions. Previously it kept liquidity flush from April as the virus spread, creating a glut of cash that wasn't able to make its way to the real economy.

Still, "arduous efforts" are needed to stabilize the economy, which continues to face "relatively big uncertainty" in the second half of the year, Zou said.

The PBOC will strengthen the implementation of already-announced policies such as the structural measures and the 1.1 trillion yuan in additional policy bank funding for infrastructure, while it has also reserved "sufficient" policy room and tools to tackle "unexpected new challenges," he said.

#### HOW TO REDUCE POSSIBILITY OF FRAUD IN MOBILE BANKING

obile banking has changed the way we bank. Managing your money has never been easier as now you can do banking transactions anywhere, anytime, thanks to alternative channels like mobile banking. The rapid adoption of digital banking channels, especially mobile, is forcing banks to rethink customer experience and processes. Because of the lower cost of banking, most customers are choosing mobile banking over traditional banking channels. While mobile banking seems like the obvious future of banking because of lower costs, and increased convenience, this convenience and accessibility are opening new doors to people who are always looking for vulnerabilities to exploit the customer's financial data for their gains.

So, the big question today is this: is mobile banking safe for baking transactions? Mobile banking is generally secure but the main challenge is from the customer side as most consumers do not understand the technology their bank is using but need to feel confident that their financial data is protected. I have not seen any research data in Tanzania regarding security concerns of mobile banking but, 73% of non-users of mobile banking in the US Federal Reserve Board Survey cited security concerns as a common

reason for not using mobile banking. The primary responsibility of the safety of mobile banking is with a bank: the bank must ensure that its mobile banking app has adequate fraud prevention built-in to maintain the trust and safety of its customer's data. The secondary responsibility of ensuring mobile banking frauds are limited is with the customer: customers must play their part to mitigate the risks of someone breaching their data. In this article, I will share a few things that customers and banks can do to mitigate the chance of falling victim to mobile banking fraud;

Multi-Factor Authentication - Having a single password methodology to access a customer's account is not recommended because passwords can be easily broken by fraudsters. Multi-factor authentication adds another laver of defence by requiring the user to submit something else other than the login password. For example, a bank can require additional login information such as facial recognition scanning option, biometric ID such as fingerprint, and special generated one-time passwords to ensure that only authenticated person can access your data. In addition, make sure your phone is

always locked when not in use and makes sure your phone's browser does not automatically input your passwords or usernames for you. Also, it is recommended to change your Online or Mobile Banking password at least every 90 days. I would suggest changing your password frequently to help you maintain confidentiality.

Choose and Act Wisely - One of the basic routes for fraudsters to access your information is through phish links, unofficial apps, and non-secure networks. Therefore, don't follow links in any emails that claim to be from your bank. If you want to do your banking, it is widely advised to go to your bank's website directly and not otherwise. In addition, download your bank's app only from the direct official app store or your bank's website as fraudsters are capable of developing similar apps that contain malware and invite you to download them through emails or text messages. Furthermore, makes sure that you are connected to a secured network when you are conducting transactions through mobile banking, hence preventing unauthorized user(s) from accessing your data. So, the usage of public Wi-Fi hotspots for mobile banking should be avoided.

Subscribe for Mobile Notification -It is very important to subscribe to mobile notifications because they will alert you quickly of any suspicious transaction. For any transactions that are done through mobile banking, you will get a notification that helps you monitor your transactions closely. Also, through mobile notification, the bank will alert you of the unsuccessful login attempts to your mobile banking account which helps you to stay vigilant. So if you haven't subscribed to mobile banking notification already, do it now.

Criminals are increasingly turning into mobile fraud as traditional channels have become more protected. In the world of mobile transactions, criminals are constantly preying on customers and banks to exploit vulnerabilities, hence fighting mobile fraud requires speed and flexibility from both banks and customers.

## Govt gets 1.9trn/-since year 2019 from agreements with Barrick Gold

THE government has since September 2019 to date received a maximum of 1.94trn/- (\$832million) from Barrick Gold Corporation following joint venture agreements signed by the two parties in January 2019 through Twiga Minerals Corporation

Briefing journalists at the weekend in North Mara mines on the company's performance for the first half of 2022, President and Chief Executive Officer Mark Bristow said the money is equivalent to 42 percent of the overall economic contribution since assuming operational control of North Mara and Bulyanhulu in September 2019.

"During the period under review the company has paid U\$896million to local suppliers, an equivalent of 45 percent. It has paid salaries amounting U\$169million equivalent to eight percent and another U\$98million was paid in dividend plus loan repayment making a total in-country investment stand at U\$2billion," said Bristow.

According to him, just for the first half of 2022, the mining company has paid U\$158million in taxes, royalties and levies. It has paid the government U\$42million in distributions through dividends and shareholders loan repayments.

Barrick has so far paid U\$210million to local registered suppliers. The company has committed U\$6 for every ounce of gold by its two mines in the country on improving healthcare, education, infrastructure and access to potable water in the host communities.

A further U\$70million has been committed for investment in value-adding national projects, including mining-related training, skills development and scientific facilities at universities, as well as road infrastructure.

Barrick through treasury has so far received U\$140million from Barrick Gold Corporation since it sealed a new deal in January 2019 by the mining company

In February 2019, the government entered a winwin agreement with Barrick after a business shakeup on export of gold concentrates had exploded.

In the agreement, Barrick is required to pay the treasury a sum of U\$300million. Prior to the agreement, the government had in 2017 handed a \$190 billion tax bill - about four times the country's gross domestic product - for underreporting output.

Speaking of the two mines' future operations plan for North Mara, he said the company continued to stretch and improve its operations to exceed last year's record underground performance.

"With North Mara the key focus on investment will be on latest technologies such as Mmulti-lite during replacement cycles and an emphasis on preventative maintenance on the legacy underground fleet during this transition," said Bristow.

For Bulyanhulu, he said the underground operations continue to increase output to be further bolstered by the arrival of the replacement fleet at the end of quarter two.

## Africa-focused fintech rises \$2m to scale cross-border payments

HE remittance inflows to sub-Saharan Africa over the past decade have been on an upward trajectory since 2020; last year, it increased by more than 6% to \$45 billion.

However, the steady rise of remittance inflows to the region hasn't made this activity cheaper. According to the World Bank, sub-Saharan Africa remains the most expensive region to send and receive money; sending \$200 costs an average of 8% in fees compared to a global average of about

Analysts from the World Bank's Recustomers various remittance options, that affects these rates is transparency among remittance providers.

According to the initiative, a lack of transparency around rates and fees reduces competition as consumers continue to use incumbents because "they are not aware of and cannot compare services, fees, and speed of their existing remittance service against other products.

"One way to solve this would be to make an aggregator of cross-border and remittance platforms. Zazuu, a U.K.-based and Africa-focused fintech that does precisely this by offering

mittance Prices Worldwide say a factor is announcing that it has raised \$2 million in a new venture round.

> Financial systems in the U.S. and the U.K. do not favour migrants, particularly African ones. For many, performing certain financial activities like building one's credit history or sending money back home can be difficult.

> With a migrant base of 800,000 people (most of whom are based in the U.S. and the U.K.) sending money home yearly, Nigeria is sub-Saharan Africa's largest recipient of remittance inflows at over \$17 billion.

> Zazuu founders have Nigerian heritage; thus, they could relate very well

to this problem. In an interview with TechCrunch, Zazuu CEO Kay Akinwunmi said he and his co-founders started the company in 2018 after experiencing such institutional biases as Africans living in the diaspora.

"We've experienced this. Seeing my mom send money and the friction there is pretty much the story of millions of Africans and migrants sending money," said the founder who launched the company with Korede Fanilola, Tola Alade and Tosin Ekolie. "Africans in the diaspora, whether you're sending money to another side of the world or trying to get a loan here in the U.K., are at a disadvantage."

Also, the remittance space has become fragmented. There's been an increase in remittance products over the past couple of years, with the entrance of digital upstarts such as NALA, Lemonade Finance and Chipper Cash joining the likes of WorldRemit, Remitly and Western Union, legacy platforms Africans primarily used to carry out remittance activities.

To help users search these various money transfer options in their region and compare rates and fees, Zazuu initially launched as a chatbot in 2020, informing users of the daily remittance rates of various platforms via Facebook and Telegram groups.

"We looked at the typical African customer to understand their behaviour, and we noticed a fascinating trend," Akinwunmi said. "We realised that Africans have this pathological behaviour, which is, we love to shop around, to compare our choices and try different options before we finally make a decision."

According to the CEO, the initial product helped dispel customers' preconceived notions about which service had the best rates as they got introduced to new providers. ial wellbeing for African immigrants across the world," said the chief executive.

### **AfDB promises:** We'll empower **SMEs owned by** women, youths

THE African Development Bank (AfDB) has pledged to work closely with both the government and the private sector in empowering small and medium enterprises particularly those owned by youths and women.

The pledge was declared by Dr. Patricia Laverley, Tanzania AfDB Country Representative at a special engagement meeting with the CEO Roundtable (CEOrt) held on Tuesday evening in Dar es Salaam.

At the meeting that brought the two parties with the intention of discussing post-Covid-19 wayward strategies, Dr Laverley said that youth and women empowerment is one of the bank's priorities in its plans towards enabling African countries to realize the sustainable development goals (SDGs).

"Following the unprecedented challenges posed by Covid-19 and ongoing global conflicts, countries have experienced adverse impacts on socio-economic growth, and are now building back better and on the path to economic recovery," she said.

She asserted that different institutions are needed in place to play key roles in aiding these recovery efforts, and are committed to supporting the government in the achievement of development goals.

"The AfDB has been pivotal in helping the continent overcome various economic challenges, providing access to finance, addressing priority areas and, in a region known for its predominantly youthful population, leading initiatives that make a difference in the lives of young people," she said.

Helping to drive the bank's transformation agenda for Tanzania, Dr. Laverley said the bank spearheads efforts to achieve its 'High 5s' in Tanzania, a strategic vision of the AfDB's 5 priority areas that are intended to support African countries' achievement of the SDGs.

She further noted the high 5s are to light up and power Africa; feed Africa, industrialize Africa, integrate Africa, and improve the quality of life for the people of Africa.

In this case, she asserted, the overarching objective of the AfDB aligns with the CEOrt purpose of aiming to spur sustainable economic development and social progress.

This meeting is part of the organization's monthly engagements to facilitate dialogue on issues critical to Tanzania's sustainable development.

The CEO Roundtable Chairman David Tarimo said that it was important to learn from Dr. Laverley's vast insights, and explore how the private sector can support the country's efforts to foster accelerated growth and development that is sustainable in the

## Alliance One pays 86bn/- to farmers this year alone

MOROGORO'S Alliance One Tobacco Tanzania Limited (AOTTL) has paid a total of 86bn/- to tobacco growers contracted to them in various regions across the country. The Managing Director of the company, Ephraim Mapoore, disclosed this yesterday when Morogoro Regional Commissioner, Martin Shigella toured the factory to launch the crop processing season.

The official said the 86bn/- was spent in purchasing of 22million kilograms of tobacco for this year crop season. He said the monies were paid to 11,000 growers who

are from more than 150 primary societies spread over five tobacco regions in the Mainland. "We have paid a total of 86bn/- to 11,000 tobacco growers

committed at seeing to it that we transform the lives of our farmers and their families," he said. According to Mapoore for the past five years the company has been using 26.5bn/- on salaries and personal cost every year, 11.6bn/- as employment taxes every year, adding that

the company has been contributing 1.718bn to pension

funds yearly. The MD said as part of corporate social responsibility the company has been actively involved in education, health and environment projects as well as contributing towards Uhuru Torch rallies in all the 15 districts in which they have

their presence. "It is also good to note that for two consecutive years National Social Fund (NSSF) has awarded our company as the best employer from the agricultural sector," he elaborated adding that the company has 350 permanent workers and 3000 seasonal workers.

Outlining the challenges of the company its daily operations, he cried foul for the unreliable power supply at the factory no water connection from Moruwasa. He said they currently depend on their own water wells and dam.

He also said AOTTL needs a dedicated power line as the company uses 600 liters of diesel as 31percent of power is from generator, he said due to lack of dedicated power line to the company electricity supply (Tanesco) is losing

## WHO: COVID-19 pandemic 'nowhere near over'

**GENEVA** 

THE ongoing COVID-19 pandemic is "nowhere near over" as the number of new cases worldwide has risen by 30 percent in the last two weeks, the World Health Organization said on Tuesday.

"I am concerned that cases of COVID-19 continue to rise – putting further pressure on stretched health systems and health workers. I am also concerned about the increasing trend of deaths," WHO Director-General Tedros Adhanom Ghebreyesus told journalists here on

According to Michael Ryan, executive director of the WHO Health Emergencies Program,

ported COVID-19 cases has been largely driven by Omicron subvariants BA.4 and BA.5, and by the lifting of public health and social measures. Recent changes in testing policies have also been hindering the detection of new cases and the monitoring of the evolution of the virus, he

Last Friday, the WHO's Emergency Committee concluded that the virus remains a public health emergency of international concern and warned of several interlinked challenges.

For instance, though Omicron subvariants BA.4 and BA.5 continue to drive the new waves of infections, hospitali emissions and deaths around the world, surveillance – including testing and sequencing – has dropped significantly, the recent increase in the number of newly remaking it increasingly difficult to assess the imburden based on their capacity,"

#### Biden en route to Israel for high-stakes Middle East visit

US President Joe Biden arrived in Israel yesterday to kick off a highstakes trip to the Middle East dominated by efforts



and Saudi Arabia closer together. Biden (pictured) will spend two days in Jerusalem for talks with Israeli leaders before meeting Palestinian Pres-

ident Mahmoud Abbas on Friday in the West Bank. Afterward, he will take a direct flight from Israel to Jeddah, Saudi Arabia - a first for an American president - on

Friday for talks with Saudi officials and to attend a summit of Gulf allies. US officials say the trip - Biden's first to the Middle East as president - could produce more steps toward normali-

zation between Israel and Saudi Arabia, historic foes but also two of America's strongest allies in the turbulent re-"We're making steps gradually toward that end," said

an Israeli official. "The fact that President Biden visits Israel, and from here will fly directly to Saudi Arabia encapsulates a lot of the dynamics that have been evolving over the last months."

Biden's trip aims to promote regional stability, deepen Israel's integration in the region.

"This trip will reinforce a vital American role in a strategically consequential region," US national security adviser Jake Sullivan said on Monday.

Biden, under pressure at home to bring down soaring gasoline prices that have damaged his standing in public opinion polls, is expected to press Gulf allies to expand oil production to help bring down gasoline prices.

#### **Pressure over Saudi visit**

A centerpiece of Biden's visit will be talks in Jeddah with Saudi leaders including Saudi Crown Prince Mohammed bin Salman, accused by the US intelligence community of being behind the 2018 murder of Washington Post journalist Jamal Khashoggi.

The meeting is a reversal of Biden's previous position of making Saudi Arabia a "pariah" for the Khashoggi death. How the White House handles the optics of the meeting and whether photos will be released of it will be closely watched.

Aides say he will bring up human rights concerns while in Saudi Arabia, but he has nonetheless drawn fire from a wide array of critics.

"Biden needs the Saudis to increase their oil production to help keep global energy prices in check," wrote Washington Post publisher Fred Ryan in an opinion piece on Tuesday. "The trip sends the message that the United States is willing to look the other way when its commercial interests are at stake."

Biden will make brief remarks on Wednesday at an arrival ceremony in Israel and he will receive a briefing from Israeli defense officials on the US-supported Iron Dome defense system and a new laser-enabled system called Iron Beam.

He will pay his respects at Yad Vashem, Israel's memorial to Holocaust victims in World War Two.

Israel has been jolted by internal political strife with previous prime minister Naftali Bennett's coalition collapsing in June.

This has left Yair Lapid as caretaker prime minister until new elections are held later this year, and Biden will meet with him. The pair will hold a joint news conference on Thursday.

Biden will also meet past prime minister Benjamin Netanyahu, now the opposition leader.

#### **Outreach to Palestinians**

Biden's talks with Abbas will mark the highest level of face-to-face contact between the US and the Palestinians since then-president Donald Trump took a tough approach to the Palestinians upon taking office in 2017.

Tensions are high between Israel and the Palestinians over the killing of Palestinian-American journalist Shireen Abu Akleh in May. Her family, having accused the US of providing impunity for Israel over her killing, has asked to meet Biden during his trip to the region this

The Palestinians, while appreciating the resumption of ties under Biden, want him to make good on pledges to reopen the US consulate in Jerusalem.

They also want the US to remove the Palestine Liberation Organization from the US list of terrorist organizations, preserve the historic status quo in Jerusalem and curb Jewish settlement expansion in the West Bank.

Israeli officials said Biden's visit will include what they called the Jerusalem Declaration on the US-Israel Strategic Partnership.

### Chinese envoy identifies 4 areas to promote UN peacekeeping

A Chinese envoy on Tuesday identified four areas where efforts are needed to promote strategic communications in UN peace-

Strategic communications can help the world know more about peacekeeping, and help peacekeeping better serve the world. The UN secretary-general's Action for Peacekeeping initiative includes strategic communications in the toolbox, which is an important measure to enhance the safety and security of peacekeepers and improve the performance of peacekeeping operations, said Zhang Jun, China's permanent representative to the United Na-

China believes that to enhance strategic communications, there is a need to work on four areas, he told a Security Council open debate on the key role of stratepeacekeeping.

First, creating stronger partnerships.

The United Nations should enhance communications with the host country, troop- and police-contributing countries, and regional organizations, so as to share information, align goals, and coordinate activities. Of all the stakeholders, the host country is the most important one. The United Nations should continue to improve communications with host countries, heed their opinions, address their concerns, and

seek their support. The Security

Council should create the mandate of a peacekeeping mission in a reasonable manner based on the needs of the host country. Missions should also improve their communications with local communities to gain public understanding and support.

Second, better protecting the safety and security of peacekeep-

Peacekeepers are faced with more and more serious safety and security challenges. There is a need to enhance security information exchanges between missions and host governments and improve the situational awareness and risk prevention capacities of missions. In areas where many forces conduct operations, the host governments could consider creating an informationsharing mechanism to avoid misunderstanding or misjudgment.

Third, facilitating effective mandate implementation for peace-

keeping operations. Restoring peace in the host country is the primary responsibility of a peacekeeping operation. A mission should, based on thorough communications with the parties concerned and relevant regional organizations, promote the resolution of conflicts through dialogue and communication. Military means alone cannot fulfill the mandate to protect civilians. Missions should im-

prove communications with local communities so as to be able to detect and address security risks as soon as possible to effectively prevent conflicts and better protect civilians.

Fourth, improving strategic communications capacity-building.

The UN Secretariat will soon update the strategic communications public information policy. China hopes that the Secretariat will take this opportunity to integrate strategic communications into all components and units of peacekeeping operations, and in the process, keep close communications with

The Secretariat should include strategic communications in the training for peacekeepers to help

them get a deeper understanding of local cultures and the situations of the host countries so as to more closely facilitate the implementation of the priority national policies of these countries.

As the second-largest contributor to the UN peacekeeping budget and a major troop contributor, China has always been committed to peace through concrete actions. China has included strategic communications in its training system and has provided peacekeepers from dozens of troop-contributing countries with targeted training. China will continue to work with peace-loving nations to contribute to the maintenance of world peace and security, said

#### Poland nervous about leak of plans of dismembering Ukraine – Russian intelligence chief

POLAND is seeking to conceal its expansion to Western Ukraine and is taking nervously the leak of its plans of dismembering Ukraine, director of Russia's Foreign Intelligence Service Sergey Naryshkin said on Tuesday.

"Information coming to the Service indicates a nervous reaction of Poland's leadership to the fact that its plans of dismembering Ukraine have come in the public eye," the Service's press bureau quoted him as saying.

In his words, Warsaw obviously hoped that amid the tough geopolitical standoff neither

Kiev nor Washington no Moscow would notice its preparations for seizing Ukrainian territories. "Poland hoped that when the conflict in Ukraine reaches a phase of diplomatic

#### Zimbabwe enlists AfDB help to clear external debt arrears

#### **HARARE**

THE Zimbabwean government has enlisted African Development Bank (AfDB) president Akinwumi Adesina to help the southern African nation clear its long-standing, huge external debt arrears amounting to 13.5 billion U.S. dollars.

Adesina arrived in Zimbabwe on Monday to kick start his engagement process with Zimbabwe's President Emmerson Mnangagwa and other senior government officials including Finance Minister Mthuli Ncube.

Apart from meeting Mnangagwa and Ncube on Tuesday, the top AfDB official also met several African and G7 ambassadors and representatives of international financial institutions accredited to Zimbabwe.

Adesina accepted a request in February by the Zimbabwean government to serve as the country's arrears clearance and debt resolution champion among international financial institutions and bilateral creditors.

According to the AfDB, discussions between Adesina and Zimbabwean officials were expected to center on potential areas of technical assistance that the AfDB will provide to the Zimbabwean government.

Speaking at a joint press conference after meeting Mnangagwa, Adesina said he gladly accepted the role because of his firm belief in Zimbabwe's economic potential.

"I came here to listen, to understand and appreciate what needs to be done to get where we need to. I will not work alone but will work closely with President Mnangagwa, Finance Minister Ncube, development partners, multilateral partners and the international community. I am very optimistic that working together we will be able to get there," Adesina said.

Zimbabwe has tried unsuccessfully in the past to clear its huge external debt arrears through various strategies, with the last debt arrears clearance plan, dubbed the Lima plan agreed with global lenders in Peru in 2015, going off the rails.

with the help of the AfDB president. In 2015 and under the Lima plan, Zimbabwe cleared its 15-year debt arrears to the International Monetary Fund amounting to 108 million U.S. dollars, but this has not moved the IMF to release new loans to Zimbabwe, arguing it has to clear arrears with other international financial institutions and bilateral creditors and also implements a strong reform agenda.

Zimbabwe also owes the World Bank, AfDB, European Investment Bank, Paris Club and other bilateral donors billions of U.S. dollars. S

### Eight candidates make cut in race to succeed UK PM Johnson

#### LONDON

EIGHT Conservatives will fight it out to succeed Boris Johnson as party leader and British prime minister after winning enough nominations from their colleagues to go through to the first round of voting on Wednesday.

Only two hopefuls failed to secure the 20 necessary nominations, leaving a wide field of candidates seeking to win the backing of the party with promises of tax cuts, honesty and serious government - a contrast to Johnson who was forced to announce he would resign after a series of scandals.

Former finance minister Rishi Sunak is the bookmakers' favorite, and among those he will be taking on are his successor Nadhim Zahawi and foreign minister Liz Truss in what is becoming an increasingly bitter and divisive con-

The next British leader faces a daunting in-tray while support for the Conservatives is also falling, polls show.

Britain's economy is facing rocketing inflation, high debt, and low growth as people grapple with the tightest squeeze on their finances in decades. All of this is set against a backdrop of an energy crunch exacerbated by the war in Ukraine which has sent fuel prices soaring.

As the contest intensifies, rival campaigns stepped up private criticism of each other and pointed to either financial or other questions hanging over their opponents.

Sunak kicked off his campaign ous candidate, promising "grownextensive tax cuts pledged by most

of the other candidates.

"It is not credible to promise lots more spending and lower taxes," Sunak said, saying tax cuts could only come after soaring inflation was tackled.

As finance minister, Sunak set Britain on course to have its biggest tax burden since the 1950s after he oversaw a huge rise in government spending during the coronavirus pandemic, and most of the other hopefuls have turned their fire on him by saying they would oversee cuts immediately.

#### 'Dirty tricks'

Sunak has the widest support among colleagues who have publicly expressed their view.

Penny Mordaunt, a junior trade minister who is also heavily tipped,

topped a poll of Conservative party members and she too has tried to strike a more measured tone on tax, saying that now is not the time to cut government spending.

"The others will obviously try to secure votes, they will try to put up flares for particular caucuses," she told LBC radio. "This is not the time to be making radical tax policies and promises."

Attorney General Suella Braverman; the former health and foreign minister Jeremy Hunt; Tom Tugendhat, chair of parliament's foreign affairs committee; and Kemi Badenoch, a former junior minister who is scooping up support on the right wing of the party, are the other candidates to enter the first round of the contest.

Transport Secretary Grant Shapps earlier became the first candidate to end his bid, throwing his support behind Sunak, while Home Secretary (interior minister) Priti Patel announced she would not be standing.

Foreign Secretary Truss received the backing of two ministers closest to Johnson - Nadine Dorries and Jacob Rees-Mogg who have both been critical of Sunak.

Dorries accused Sunak of using "dirty tricks" to manipulate the leadership contest, with votes being loaned to Hunt's campaign because they view him as easier to beat.

Sunak's team did not respond to a request for comment.

The 1922 Committee of Conservative members of parliament which is organizing the contest says the field will soon be whittled down with repeated votes in the next few weeks, with the final two then selected by the fewer than 200,000 party members by July 21.

The winner, and Britain's new prime minister. will be announced on Sept 5.

Meanwhile, the opposition Labor Party said the government was "running scared" after it blocked an attempt to call a confidence vote in Johnson on Wednesday to force him from office immediately.

The government said Labor was trying to "play politics" and it would allow Labor to call a confidence vote if the wording of the motion was changed to remove reference to Johnson.

THE Hong Kong Palace Museum (HKPM) opened to the public on The museum was welcomed by

The HKPM is the first collaborative project launched by the Palace Museum outside the Chinese mainland. It was an outcome of the cooperation between the Palace Muse-

Outlined in China's 14th Five-Year Plan (2021-2025), the HKPM represents a creative combination between traditional Chinese culture represented by the Palace Museum, and Hong Kong's modernity and internationalization. It is a milestone of mainland-Hong Kong cultural cooperation that will further promote exchanges, enhance mutual learning and tighten the people-topeople bond.

The sophisticated and elegant golden structure in the shape of an ancient square tripod, which sits by the sea in Tsim Sha Tsui, is expected to become a new cultural landmark with world-class influence.

The seven-storey museum occupies some 13,000 square meters and houses nine galleries. Its design was inspired by the collections and architectural styles seen in Beijing's Palace Museum, illustrating its cultural features in a way that combines Chinese and Western culture with both the ancient and the modern.

The construction has won 19 awards for its outstanding performance in engineering, safety, and environmental protection, demonstrating a high level of China's construction competence.

On July 2, a total of 914 cultural relics from the collection of the Palace Museum in Beijing were displayed at seven galleries of the HKPM. Most of them were exhibited in the special administrative region for the first time and 166 were first-class cultural

relics recognized as national treasures. It was the largest and highest-level cultural relic exhibition of the Palace Museum outside of the mainland since its establishment in 1925.

Respectively presented in seven galleries, thematic exhibitions cover paintings and calligraphy works from Jin (265-420), Tang (618-907), Song (960-1279) and Yuan (1271-1368) Dynasties, collections of the Forbidden City, emperor and empress portraits of Qing Dynasty (1644-1911) and traditional crafts. Besides, 13 precious art objects from the Louvre in Paris were also exhibited in Gallery 9 themed horse culture, in order to highlight the mutual learning between China and other civilizations.

At a thematic exhibition on ceramics staged in Gallery 3, 160 highlights from the 360,000 ceramic works collected by the Palace Museum were displayed. It was the first time the Beijing museum has displayed such a sizable exhibition of its ceramic collections in Hong Kong.

The exhibits were fabricated from the Longshan culture (about 3000 to 1900 BC), a late Neolithic civilization to the reign of Emperor Guangxu (1875-1908) in the Qing Dynasty, including the five famous porcelains during the Song Dynasty, as well as ceramics in the imperial kiln of Jingdezhen, east China's Jiangxi province in the Ming

(1368-1644) and Qing Dynasties. A masterpiece of the Qiantang River tidal bore drawn by artist Li Song in the Southern Song dynasty (1127-1279) is expected to be exhibited at the HKPM soon. The painting was collected by the Palace Museum with help from Hong Kong in the 1950s. Hong Kong has made remarkable contributions to the protection of Chinese cultural

relics lost overseas, and many paintings and calligraphy works that are considered national treasures were returned to the motherland thanks to the efforts of Hong Kong patriots.

Li Qun, Vice Minister of Culture and Tourism and head of the National Cultural Heritage Administration, told People's Daily that the HKPM enables Hong Kong citizens to enjoy the beauty of cultural relics and experience the profound Chinese culture from a close distance, and will enhance the cultural confidence of the Hong Kong society.

"This is a gift from the motherland to Hong Kong," said Louis Ng Chi-wa, director of the HKPM. The museum both showcases traditional Chinese culture and enhances the sense of recognition of Hong Kong citizens, especially the younger generation, he noted.

The museum is a window for spreading Chinese culture overseas, and will help Hong Kong build itself into a center for cultural and art exchanges and contribute to Chinese-foreign cultural communication, he said.

### Simon Msuva rules out return to Yanga

TANZANIAN midfielder Simon Msuva has said it is still too early for him to say whether he will return to his former outfit, Yanga, this season despite successfully winning the case against Wydad Athletic Club of Morocco.

Msuva is linked with a move back to Yanga, with the club's rival, Simba SC, also being linked with a move for the footballer in this transfer window, as the sides are shaping up for the next season's Premier League, Azam Sports Federation Cup, and CAF Champions League.

Msuva revealed he intends to return to Yanga in his football career but at the moment it is difficult to prove it, given he has plans to continue playing football outside Tanzania.

He said he loves and appreciates Yanga and recognizes the club's contribution to his life, but he does not think it is the right time for him to return to the club.



The midfielder stated: "I do not want to disappoint Yanga's fans, one day I will return to serve them as it was the case in the past, at the moment I am very much thinking about playing outside Tanzania.'

"I still want to play abroad, I still have the strength to play abroad," the footballer said.

Msuva stated: "I have met many Yanga leaders and they have strongly influenced me to join the outfit, Simba SC leaders have also been persuading me but the truth is that I plan to play abroad."

This week world soccer governing body, FIFA, instructed the 2021/2022 CAF Champions League's champion, Wydad Athletic Club, to pay Tanzanian midfielder Msuva more than the US \$ 700,000 (over 1.6bn/-).

FIFA issued the order to Wydad Athletic Club after completing a dispute that has been raging between the outfit and Msuva for more than six months.

However, Wydad Athletic Club was the first to file a lawsuit against Msuva, believing the player had an opportunity to respond to allegations that he terminated his contract with the outfit for no reason.

The Moroccan club though turned into the one that has been asked to pay the player his dues.

Msuva later filed a lawsuit against Wydad Athletic Club, demanding payment of his dues which he did not receive for a long time from the African football giants.

The midfielder signed a four-year contract with Wydad Athletic Club and was forced to terminate the contract in December 2021 due to salary arrears as well as signing fees.

Msuva served Yanga from 2012-2017 before moving to Morocco to join Difaâ El Jadida where he served from 2017-2020 and then to Wydad Athletic Club.

The midfielder played for Azam FC from 2010-2011 scoring 11 goals in 35games and later moved to Moro United an outfit he played for from 2011-2012 scoring 15 goals in 37 games.

LeBRON James is publicly criticizing the United States' handling of WNBA All-Star Brittney Griner's case in a trailer for an upcoming episode of his television show: "The Shop: Uninterrupted."

Griner is on trial in Russia for drug possession. She pleaded guilty last week and will appear again in court on

"Now, how can she feel like America has her back?" James said in the trailer. "I would be feeling like, 'Do I even wanna go back to America?"

James tweeted Tuesday night that his comments in the trailer weren't intended to be critical of the U.S. efforts to get

"My comments on "The Shop" regarding Brittney Griner wasn't knocking our beautiful country," he said. "I was simply saying how she's probably feeling emotionally along with so many other emotions, thoughts, etc inside that cage she's been in for over 100+ days! Long story short #BringHerHome'

It's unclear when the show was filmed, although in the trailer it is mentioned that Griner had been in Russia for more than 110 days, which would have been nearly five weeks ago as she was detained on Feb. 17.

During the weeks since day 110, in addition to the trial beginning and the guilty plea, Griner's wife Cherelle has had a phone conversation with President Joe Biden. Biden also received a letter from Brittney Griner on July 4 and sent a letter back to her, which she was given in court last week.

There is also no mention of other detained Americans in the trailer.

NBA Commissioner Adam Silver, speaking later Tuesday after his league's

board of governors meeting in Las Vegas, reiterated that the NBA and WNBA are "doing everything in our power" to bring Griner home. "I'm accepting that the administra-

tion is doing everything they can right now." Silver said. "There are some seriously complex geopolitical issues here. And I'm sure as invariably as they are more focused on Brittney, there are other families who are of course concerned about their loved ones who are being held against their will in Russia right now. ... There are very difficult issues that the Biden administration has to face in terms of what's appropriate."

Washington hasn't disclosed its strategy in the case and the U.S. may have little leverage with Moscow because of strong animosity over its actions in Ukraine. The State Department's designation of Griner being wrongfully detained moves her case under the supervision of its special presidential envoy for hostage affairs, effectively the government's chief hostage negotiator.

U.S. Secretary of State Antony Blinken has said Washington will continue to work for the release of Griner, as well as other Americans held by Moscow, including former Marine Paul Whelan.

"We will not relent until Brittney, Paul Whelan, and all other wrongfully detained Americans are reunited with their loved ones," he tweeted last week,

National Security Adviser Jake Sullivan said Monday that former New Mexico Gov. Bill Richardson had been in contact with the National Security Council, but wouldn't comment on "his travel or what he intends to do" amid reports that Richardson plans to travel to Russia and work on Griner's release.

James' show will air on Friday.

ERIK ten Hag says he will not get carried away with Manchester United's 4-0 win over Liverpool in his first game in charge after seeing "mistakes" in his team's performance.

United kicked off their tour of Thailand and Australia with a resounding win over Jurgen Klopp's side thanks to goals from Jadon Sancho, Fred, Anthony Martial and Facundo

Ten Hag said afterward he was pleased with the result but insisted there was plenty of room for improvement and pointed to Klopp's decision to play three different teams for 30 minutes each as a key reason behind the result.

"Of course we are satisfied today because I think that was a team with a great spirit and we know we are just starting and things went wrong, clearly," he said. "We did the press, we made some mistakes in pressing, we conceded some chances, but also we

"I think our team played brave, played proactive. We have to work really hard to cut out the mistakes, but of course we are happy with the first game.

"I have seen a lot of mistakes. You would not say [when you look] at the result but, be honest, Liverpool plays in three teams.

"They were not at their strongest so we have to not overestimate this result. We have to [be careful]."

Ten Hag picked a strong team to start the game at the Rajamangala National Stadium and made 10 changes at half-time.

Fred's goal was the pick of the bunch after the Brazil midfielder chipped Alisson from the edge of the box. The one downside of the night for United was an injury to David De Gea, which forced him off in the second half.

"I know we have good players," added Ten Hag. "Now we have to construct a team and we started the first game now, so I am happy with the first game.

"I have seen some really good things and I think what you see is we have a lot of creativity and speed up front, so we have potential.' While United next head to Melbourne to play

Melbourne Victory and Crystal Palace, Liverpool travel to Singapore, also taking on Palace.

"The result is there, we have to accept it," said Klopp following the defeat to United. "We could have scored our goals as well and the goals we gave away were almost assists.

"I saw a lot of good stuff but the game came too early. Mistakes happen in football. It was so open and it was pretty clear where we made the mistakes."

PSG reject chance to sign Ronaldo - sources

CRISTIANO Ronaldo was offered to Paris Saint-Germain by his agent Jorge Mendes, but the French champions rejected the possibility of signing

the Manchester United forward, sources told ESPN. Ronaldo, 37, wants to leave Old Trafford in search of Champions League football in the coming season. only a year after rejoining the club and with another year on his contract.

Mendes discussed the availability of the No. 7 with PSG sporting director Luis Campos and club president Nasser Al-Khelaifi. The super agent is very close to both of them after having worked for many years with Campos before his arrival in the French capital this summer.

He has also handled numerous contracts for his players with Al-Khelaifi, including PSG's most recent signing Vitinha, who joined from Porto.

Sources added that PSG don't feel that Ronaldo is the right signing at this moment and that the club doesn't have enough space in their wage bill to pay

From a sporting perspective, there are also concerns that there isn't room for him in the team, with new manager Christophe Galtier wanting to start a season with using a back three.

The former Nice coach may already struggle to find ways to play Neymar, Lionel Messi and Kylian Mbappe together in his preferred formation, so a move for Ronaldo would not make sense.

PSG are not the first club to say no to Ronaldo this summer. Bayern Munich also turned down the chance to take on the former Real Madrid and Juventus star, while Chelsea manager Thomas Tuchel is not keen either, despite a meeting between Mendes and new Blues owner Todd Boehly to discuss the Portugal international's future.

In addition to Ronaldo's desire to play in the Champions League in the upcoming campaign, the six times Ballon d'Or winner is also said to be unhappy with the lack of transfer activity from United so far this summer.

However, Manchester United's new manager Erik ten Hag insisted the club wants Ronaldo to remain with the team as recently as Monday in a press conference before the Red Devils' 4-0 friendly win over Liverpool on Tuesday in Bangkok during their preseason tour.

think of the defining Pep Guardiola players, it obviously starts with Lionel Messi.

In four years together with Barcelona, they won three LaLiga titles and two Champions League trophies. Messi was the individual genius who took Guardiola's ultra-organized collective to never-beforeseen heights. During their time together, there was no question over who was the best player in the world. While they slipped up in LaLiga once and in Europe twice, Messi won the Ballon d'Or in each of the four vears he worked with Guardiola.

Who would be next, though? There's Sergio Busquets, a Guardiolaesque avatar at the base of midfield for those great Barca sides. Maybe Xavi or Andres Iniesta, but they both existed in outsized form before and after Guardiola arrived. At Bayern, same goes for the likes of Philipp Lahm, Arjen Robben and Franck Ribery, who all hit new levels under their new manager but also won the Champions League the year before he came to Germany. Manuel Neuer, perhaps, was the most symbolic Guardiola figure at Bayern, a goalkeeper known and beloved for all of the things other than saving shots.

However, Guardiola has now coached Manchester City for longer than he has either of those clubs, which brings us to this: after Messi, Raheem Sterling has been involved in more goals in all competitions (scored and assisted) under Guardiola than any other player. And that number will remain stuck at 186 for the foreseeable Sterling was already both 88 non-penalty goals in the 6-yard box, five more than defenders on -- 79th perlet Sterling move to Chelsea for a £47.5 million transfer fee any day now.

Yet, Sterling as a defining Guardiola player doesn't feel right, does it? After all, if it were true, would City be willing to let him leave? Still, nothing about Sterling's career really feels right because we'd never really seen anything like him before.
