

Egyptian firm for Dar vehicle, traffic flow scans

N Egyptian technology firm, Go Plus, is gearing to conduct vehicle inspection and offer traffic management solutions in Dar es Salaam to reduce accidents and ease congestion.

Gassey El-Sayed, Go Plus CEO, said in an interview at the weekend that the planned investment arose from discussion the company's management held with President Samia Suluhu Hassan.

The meeting took place on the sidelines of the just-ended 27th Conference of the Parties to the United Nations Framework Convention on Climate Change (COP27), at the resort city of Sharm El Sheikh in Egypt.

The firm has been exploring opportunities in Tanzania and opted for vehicle inspections centres and road transport safety, using updated technology to modernise the services, he said.

The firm has similar investments in Ghana, Chad, Nigeria, Dubai and Saudi Arabia, organized on a public private partnerships (PPP), he said.

Taking up the company's services will help the government uplift revenue generation as is evident in other countries where the technology was set up, improving revenues by an average of 60 percent, he asserted.

The government will install vehicle inspection equipment countrywide to scan their eligibility to be on the road and if they meet environmental friendliness standards.

The firm was set up in Cairo in 2007, a multiproduct conglomerate in fertiliser manufacturing, and leather, apart from other innovations. At the moment it is contracted to

Govt expecting 8bn/- yearly from graphite exploitation

THE government expects to earn over \$3.6m (8.4bn/-) annually once the envisaged graphite mine at Mahenge in Ulanga District, Morogoro Region, starts operations.

Adolph Ndunguru, the Minerals permanent secreglobal market where tary, made this observation at a progress meeting with stakeholders of the Mahenge mining project, grouping the Minerals ministry, the mining commission, the Treasury Registrar's office, the revenue authority (TRA), TANESCO, the Tanzania-Zambia Railway, TanRoads and the Tanzania Ports Authority.

The amount is based on 51 per cent of the surplus from the investment whose total benefit to the national economy is projected at \$8.bn over a period of 26 years.

The project results from an agreement with Black Rock Mining Ltd, Mahenge Resources Ltd (T) and Mahenge Resources Ltd (UK) inked last December 13, to jointly develop the graphite mine.

Under the framework agreement, the parties agreed to establish a joint venture company for the mining activity, setting up Faru Graphite Corporation, at a ceremony attended by President Samia Suluhu Hassan, where the minister, Dr Doto Biteko signed for the government.

The government has a 16 per cent free carried interest, a stake for which it deposits no capital, and the investor, Black



vessels dock with ease, he said. The port manager was directed to sort out complaints raised by traders, including cargo clearance delays compared with other ports in the region. These shortcomings push traders to use neighbouring port

facilities and thus deny the country substantial revenues, he stated. He likewise directed TCRA to enable access to relevant documents in the ongoing investigations on the fire outbreak at revenue warehouse. There is need for in-depth investigations to find those involved, contributing loss of cargo in the warehouse, he stated, similarly asking TRA officials to plug loopholes in revenue collection and boost revenues without harassing traders.

He asked the regional defence and security organ and other state bodies to work together to find

solutions to various challenges at the port, along with clamping down on the drugs trafficking, smuggling, illegal fishing and migrant trafficking. He urged the regional commissioner

to oversee responses to audit queries raised by the Controller and Auditor General (CAG). They must respond as quickly as possible to clamp down on embezzlement of public funds, he emphasized. Tanga port improvement is projected to cost 429bn/-, boosting the port's handling of cargo to three million tons annually from the present 750,000 tonnes, he added.

Two months ago Faru Graphite Corp. was handed the mining license, enabling the project to enter the development stage, envisaging that at full operation the project will create over 1,000 direct job opportunities.

The project is timely as it has the potential to maximise graphite exploitation advantages in the global market where graphite is used in renewable energy technologies, such as solar panels.

An online entry says graphite is resistant to extreme heat, "so it is perfect for the crucibles and moulds used to cast the silicon in solar panels, and works as a heat shield and thermal insulator."

The meeting sought to bring the relevant stakeholders to the same operating framework to ensure alignment on the conduct of various aspects of the project in the national interest, the ministerial executive noted.

Alimiya Osman, the Faru Graphite CEO, said that when the project kicks off, the government is projected to earn up to 800m/- a day through its 16 per cent stake John Vries, the Graphite Mining executive chairman, said that the framework agreement enables the government to secure project benefits through a combination of dividends, taxes and duties.

The company's commitment involves the purchase of goods and services, supply of electricity, rail haulage work and extensive use of port services, he said. Key facilities and infrastructure to be set up

for the project include rail transport from Ifakara to the port of Dar es Salaam via the Tanzania-Zambia railway.

Other facilities are access to land at Ifakara for a railway siding to Tazara line, power supply to the mining site, along with suitable tarmac road from Ifakara to the mining site, he said.

Confirmation of the tax framework will be sought during the construction of the mine as set out in the framework agreement, along with the resettlement and compensation exercise, he added.

The gas stoves were handed over yesterday to pregnant women in Serengeti District, Mara Region during an event to celebrate the day at Rubanda ward.

The function was attended by various government leaders including Deputy Minister for Health Dr Godwin Mollel, Deputy Minister for Natural Resources and Tourism, Mary Masanja and Deputy Minister for Home Affairs, Jumanne Sagini.

In her address, Deputy Minister for Natural Resources and Tourism, Marry Masanja said it was encouraging to see environment.

stakeholders such as Oryx Energies Tanzania supporting efforts to promote clean cooking energy through the Doris Mollel Foundation.

"Provision of the stoves to expectant mothers will promote environmental conservation. Women especially those in rural areas spend hours looking for firewood, but with the gas stoves they will now spend their time on other economic activities," said the Deputy Minister, noting the gas company is among the first firms in the country to come up with cleaner cocking technologies.

Ministry allots 100 farms to teaching of herders on modern livestock keeping

THE Livestock and Fisheries Ministry has allocated 100 livestock farms to teach herders on better livestock keeping practices.

Abdallah Ulega, the Livestock and Fisheries Minister made the disclosure at the weekend at the 8th Annual Meeting of the River Basins Board (RBB) taking place here.

Ulega said the aim of the livestock farms is to teach herders and other livestock keepers to stop shifting their animals from place to place, the practice that destroys the environment, and instead employ a small area for modern livestock keeping practices.

He added that the farms will be established simultaneously with animal feed farms to avoid wanton herding that

destroys the environment including water sources.

The minister said already two tonnes of quality seeds for fodder at the Uyole Centre of Tanzania Livestock Research Institute (TALIRI-Uyole) for use by the herders to improve the health of their livestock including cattle.

He added that the efforts aim to increase the availability of better animal

breeds and fodder for boosting the country's beef sector.

"The ministry is among sectoral ministries implementing strategies against the country's water scarcity, and rampant animal grazing that destroys water sources hence in FY 2022/23 we have mobilised ourselves to provide education to livestock keepers to adopt modern livestock keeping as wel

Power rationing will come to an end by 2025, declares TANESCO

THE Tanzania Electricity Company (TANESCO) has assured the general public that power rationing will completely come to an end by 2025 due to the strong strategies put in place to achieve the goal.

The company's Director General, Maharage Chande made the statement in Dar es Salaam over the weekend when speaking to members of the Tanzania Editors Forum (TEF) on the challenges and successes they have made since he took office a year ago.

Chande said power rationing in Tanzania will remain a history because the company has strong strategies including finding new sources of electricity production instead of depending on the current sources.

He said that in the first three months in the office, they took time to organise themselves so that they can be aware of challenges, opportunities and strategies for using the available opportunities to solve the existing challenges.

Chande mentioned other important areas such as customer care, strategic projects, the efficiency of the company, fundraising, avoiding all risk indicators in daily operations and strengthening communications between the company and its clients.

He said after the completion of the first phase, they came up with a second phase which is the implementation of all that was identified in the first phase including increasing the number of clients and finding more sources of electricity production.

"In this sector, there is one thing called energy mix which means that you must have various sources of electricity production, it is a risk to rely on a single source and for example, if you rely on water sometimes when the drought came you may be in danger

AT LEAST 73 beneficiaries of the Tanzania Social Action Fund (TASAF) in Chemba district, Dodoma region have established additional income-generating projects for livelihood sustainability.

Speaking about the electricity in Kigoma, Chande said before the region was connected to the national grid, it was spending 36 million per day about 6bn/ per month for generators in electricity production.

Chande said they decided to shut down generators and connect them to the national grid because it is very expensive to run through generators but if there are technical challenges, the company engineers will work on them and everything will be okay.

He said the use of gas in power production has been

increasing since 2010 adding that the aim is to make sure the company continues to use it because it is predictable compared to water.

He mentioned another expected project Rusumo which will start production and connect to the national grid by December this year or January 2023 something which will increase power to 1,900 Megawatts in this financial year.

"In the year 2023/2024, we expect to implement a project in Kishapu Shinyanga and we are in a good stage of tender evaluation, we also expect others in Manyoni - Singida, Zuzu Dodoma and Mafia. To make this successful, we have decided to improve the welfare of our staff and motivate them to work hard," he

The residents of MakaMaka village in the district have come to terms with the reality that TASAF's conditional cash transfer programme that they have been benefiting might at one point come to an end, thus the need for another plan for survival.

Through deductions on their remittances, the group has managed to save a total of over 1.8 mn/-, spending 1,860,000/- on the purchase of a posh mill, which will, in turn, give them money.

Despite the financial gains expected from the project that is yet to start, it will also save the village residents the struggle to get milling service some seven kilometres away.

Speaking during a familiarisation tour by TASAF officials and media in the district recently, the group chairperson, Stella Joachim noted that the group members had several ideas for projects but settled on the posho mill.

"After getting training on entrepreneurship and financial training provided by TASAF, we embarked on plans to start a bigger project in addition to individually owned small projects at household levels," she said.

According to the team leader, they have formed a committee that will see the day-to-day running and management of the project and report to the members of the group.

She said the urge to start the project was high and the beneficiaries agreed to have deductions on the TASAF money that they get after every two months. With the guidance of the Ward Extension Officer. Amina Mohamed, they bought the posho mills and constructed a building to install it.

Amina told the visiting team that the group, without a push from anywhere chose the project after she had been guided on the plans and procedures to do so.

"I saw it as a good project bearing in mind the long distance they travel for milling services and it will also help them generate income that they will eventually share," she noted.

Iddi Ibrahim, one of the TASAF beneficiaries and members of the group expressed hope that the project will help them in the near future, more so once the conditional cash transfer programme ends.

The 78 years old father of three children who were enrolled in the programme in 2014, getting 36,000/after every two months has achieved quite a lot and is very happy about TASAF.

He started by buying five chickens which later reproduced and when he sold them, he bought two goats. Using money from TASAF, he managed to till 12 hectares of land, planting crops that he later sold and bought cows.

Currently, he owns ten cows, several goats and a chicken. He gets at least three litres of milk from

I managed to get a community health fund (CHF) card for treatment."

He said the CHF card helped fund treatment for his ten-year-old son who sustained a fractured hand while playing. The father of six children explained that he is able to meet school needs for the children because of TASAF.

He is also a sunflower farmer who by tilling his five-hectare farm has managed to buy two bulls and an ox plough and now provides ploughing services to Neighbours at a fee.

Wine importers concerned over tax increase

WINES importer has expressed concern over the recent changes in excise duty rates for imported wines of fresh grapes saying that the move is going to affect trade and investment.

Paul Hopkins, MMI Tanzania company's country manager said that the changes come after the government submitted to the parliament a proposed bill to amend the Excise (Management and Tariff) Act (CAP. 147) in September 2022.

The Fourth Schedule of the Act has been amended by raising the excise duty rates for imported fresh grape wines which were initially 2,466.45/- per litre to a new amount of 5,600/- per litre.

According to him, the changes in taxes and tariffs will have a great impact on the strategic investments in the country.

Hopkins said: "These charges came outside of the normal budget announcements and without deep industry consultation something which will invariably lead to higher prices for the consumer."

He said that MMI was willing to meet with key stakeholders to help identify where tax is being avoided by unscrupulous importers who are denying the government legitimate revenue streams.

He noted that these changes come at a time when the regime is gearing towards having more investment opportunities and the ease of doing business in Tanzania, but on the other side the changes can greatly affect investments and trade.

In September this year, during the Parliamentary sitting, the government submitted a proposed Bill to amend several laws including the Excise (Management and Tariff) Act which was later passed.

Presenting the Bill in the House, Minister for Finance and Planning Dr Mwigulu Nchemba said the major aim of the bill was to make changes to the laws governing tariffs and taxes so as to make things well and attract more investors from inside and outside the country.

He said that the aim to amend the fourth schedule of the Excise (Management and Tariff) Act (CAP.147) is to promote local grape farming and create a sustainable market for locally grown grapes.

Other laws which were amended under the Bill are The Written Laws (Financial Provisions) (Amendment) Act, 2022 in the Income Tax Act, Cap. 332; Mining Act, Cap. 123; Road and Fuel Tolls Act, Cap. 220; and the Value Added Tax Act, Cap. 148.

Spend more on sanitation, decent toilets, govt urged

WATER, Sanitation and Hygiene (WASH) stakeholders in the country are calling upon the government to continue committing more money to the sanitation sector so everyone has access to decent sanitation services that are safe, reliable, and inclusive to withstand climate change.

Having decent sanitation systems help to prevent the spread of water-borne diseases and protects the most vulnerable and keeps people safe and healthy.

In her message on the international commemoration of World Toilet Day (WTD) in Tanzania, WaterAid Tanzania Country Director, Anna Mzinga said: "Water and sanitation are two aspects that intersect, so we cannot address one without the other. We have been a key partner to the government through the city utilities in constructing the fecal sludge treatment plant, which recycles sludge and wastewater into fertiliser."

WTD is commemorated on November 19th, every

Statistics indicate that in Tanzania's mainland. households in Urban Areas (33.5 percent) are more likely to have improved toilet facilities than those in rural areas (8.9 percent).

Only 70-80 percent of the urban population resides without the necessary sanitation infrastructure and waste collection services.

The study indicates that only ten towns had sewerage systems, and even then, they covered a tiny proportion of the population (20 percent of the total urban population).

WaterAid Tanzania piloted innovative technologies for safe pit emptying and innovative methods by working with small entrepreneurs to test viable sanitation, business models.

However, government and WASH innovators need to plan and roll out appropriate sanitation infrastructure, especially in urban areas, to help communities become more resilient to extreme weather events, considering sanitation workers (informal sector), participation and requirements of women, girls, and disabled communities to ensure toilets are inclusive for everyone, everywhere.

When Abdulmaiid Mussa Nsekela was named as new CRDB Bank Group CEO and Managing Director, shivers of fear and concern gripped most shareholders and clients. For a period of over 22 years, the CRDB Bank group brand was synonymous wrote Dr. Charles Kimei, a man who managed the bank since 1998. Nsekela, a little known young banker was taking over the country's largest bank in terms of assets, and reach at a period when the lender had registered the largest drop in profit earnings since 1998.

"It is our worst performance in recent years and it was caused by a number of reasons including government's decision to withdraw its funds from banks and deposit them with a central account at Bank of Tanzania," Dr. Kimei said during the year when he left the bank.

When Nsekela took over, annual profit had plunged from over Tshs 200bn in 2017 to Tshs 36.2bn in 2018, the worst during Dr. Kimei's 22 Year reign coming at the end of his stellar leadership cycle. The change of leadership would have disrupted the stock market instead, Board Chairman, Dr. Ally Laay assured shareholders and clients that in Nsekela, the tier 1 capital bank was in safe hands.

"I can assure you that Abdulmajid knows the bank very well because he was involved in its growth story for many years before leaving briefly to pursue other ambitions in life," Dr Laay stated while stressing that under the youthful CEO cum MD, the bank will return to its super profit making trend.

In his acceptance speech, Nsekela rallied the entire CRDB Bank family made up of over 3,000 staff members and millions of customers promising to steer the group to super profit making. "But we can only do that by working as a team as we had always done for the past 22 years or so," he said in a statement while promising to invest more in digital banking channels.

In 2018, CRDB Bank Group's profit rose to 64.1bn, almost doubling the amount compared to the previous year. Then in 2019 when Nsekela finished a year at the help, profit surged to Tshs 120bn, a record increase of 87% year on year.

"Our impressive performance is a result of a number of concrete actions taken to

reduce expecting costs, improve service delivery through investment in alternative baking channels and support to government's mega projects," the CEO cum MD told shareholders during this year Annual General Meeting.

Even some shareholder who expressed concern in 2019 during the first annual general meeting held with Nsekela at the helm, started rallying their support behind the new chief executive. "I was one of those that opposed the idea of Dr Kimei's retirement but I am now happy that our own man, who was mentored by Dr. Kimei, has taken over, I no longer have any anxiety about the change of leadership and we must now support the new management under Nsekela," said Captain (rtd) Nkoswe Noel, one of the bank's shareholders from Sumbawanga.

Since then, CRDB Bank Group has returned to super profit making ways. Last year, CRDB Bank which is one of the most profitable banks in the domestic market, stretched its profit making margin to Tshs 268bn thanks to Nsekela's investments

already posted Tshs 174bn in profit, signaling another partnership between the two organisations.

Differences over climate change action cause for genuine concern

stalled at the just-ended (Nov 6 to 18) UN Climate Change Conference at the Egyptian resort of Sharm El-Sheikh, with pivotal developed countries having from the start rejected the US\$100bn annual payments to developing countries, efforts to cope with climate change continues unabated.

One example relates to Germany's granting of 210bn/- to Tanzania, with the fight against gender-based violence given as an essential part of the use of those funds. The debate in COP27 was about terms of the disbursing and use of such funds on climate issues and governance.

Looked at closely, the contested release of large funds is only an extension of money that is now being released multilaterally for instance the Covid-19 recovery funds, or at a bilateral level, as in this instance.

How far Germany took account of the climate situation and adaptation can scarcely be in doubt, as implementing various health, water, tourism, environment, good governance and women's economic empowerment projects can't be isolated from the harrowing effects of drought.

There is another aspect: business opportunities tied up with climate. This too would have been a problem calling for action at COP27 talks as countries wished to see the large funds disbursed to treasuries for climate change adaptation, without connection with the paying countries. It becomes a sort of global tax where the receiving 'local governments' use the cash are restored.

WHILE negotiations were as they please, issuing supply tenders to those they pick.

The West doesn't believe it would get a fair share of such contracts, unless the payments are bilateral in character, which means that the direction of use is clear, discounting procurement.

What has also not been vividly stated at COP27 talks, unless perhaps on the sidelines, is that the conference took off from what was agreed at COP26 (Glasgow, Scotland: 31 Oct to 13 Nov, 2021), as if nothing had happened in between. For instance, delegates at COP27 were seeking to stick to the formal definition of clean energy as excluding all fossil fuels, not just furnace oil and coal. Natural gas, which Tanzania is making frantic efforts to use as widely as possible, was being rejected.

For the developed countries, the idea that natural gas is a fossil fuel and not the way of the future wasn't really new, despite some diplomatic effort even during COP26 to have it considered as clean energy.

The Glasgow conference could at least agree on phasing out coal, especially for developed economies, but the war in Ukraine and sanctions on Russia put global gas supply networks on a tailspin, pushing countries to revert to bad old coal. Countries like Tanzania that would be excused for using coal as local energy for a while can now export.

So there were no conditions for global accords on scrapping fossil fuels in the near future, as even coal will be scrapped only when global natural gas flows

COP27 ends, polluting food systems remain

COP27 was meant to be the "Implementation COP" but, after two weeks of negotiations, existing pledges and national plans remain insufficient to reach the Paris agreement 1.5-degree target.

Although food and agriculture have been higher up the agenda than at any previous round of climate talks, solutions put forward to help tackle their dramatic impact on climate change do not challenge the current status-quo. This confirms once more the overrepresentation of the agrifood industry's interests.

World Philosophy Day not just pastime for teachers or clerics

WORLD Philosophy Day is an international day proclaimed by UNESCO to be celebrated every third Thursday of November.

By celebrating the Day each year, UNESCO underlines the enduring value of philosophy for the development of human thought, for each culture and for each individual. The UN agency has always been closely linked to philosophy, not speculative or normative philosophy, but critical questioning which enables it to give meaning to life and action in the international context.

In establishing WPD, UNESCO highlighted the importance of this discipline, especially for young people, declaring that philosophy was a discipline encouraging critical and independent thought and was capable of working towards a better understanding of the world and promoting tolerance and peace.

In a way, the Day is much like International Day of Mathematics (March 14) which focuses on an enigmatic mathematical quantity known as Pi, setting the geometric relationship between radius and circumference of any round figure. It isn't that something that could be actively reflected upon by more than one per cent of the world population if they weren't in school or teaching. This similarly applies to philosophy.

But taken up in a broader sense, philosophy and its other instruments like digits of calculation or logic is more than visible in daily life. When a person is attacked by thugs and robbed of a wallet or phone, or even harmed, there is something like failed philosophy, which in everyday language is known as upbringing.

Attending a wedding or even in the preparatory stages at home is a veritable class in philosophy, and here the first step in comprehending the problem crops up.

Parliamentarians have of late battled with profound emotions on what is happening in countless homes in the country and well beyond, in Africa to start with.

Tanzania did not have a prolonged or indeed visible lockdown during Covid-19 and in that sense escaped the pandemic's outstretched impact felt among neighbouring states, namely a sharp rise in domestic violence. For practically anything one picks that isn't going right there is philosophy involved, this in the sense that a section of the population profoundly believes in one or other facet of social good.

Then different facets of these convictions enter into conflict and, while such conflicts aren't fatal in many countries, they can be devastating when conditions of a sharp explosion of sentiments exist. At times the signs of danger are visible, but a society may be without the mental strength needed to prevent chaos. At the time of independence and for several decades thereafter, African writers were at peace with themselves trying to relive the salient features of how traditional society was organised. Even to this day we hear refrains about copying foreign cultures.

Yet we see in those foreign cultures the solution of our more pervasive problems like the rule of law and minimising corruption. Could we combine philosophies?

Without an ambitious mandate for the Koronivia mechanism, the world will not be able to deliver sustainable, fair and resilient food systems that enable people and nature to prosper within planetary boundaries.

Slow Food condemns the false solutions that keep being put forward in international climate talks, such as GMOs. If we want to ensure both long-term food security and the survival of the planet,

Africa's changing shopping trends allow e-tailers to meet customers' expectations

THE African continent is widely considered retail's next big gold rush, based on its population of 1.4 billion people - which includes more than 500 million internet users and over 330 million eCommerce consumers.

Additionally, with 19 of the top 20 fastest-growing countries in the world, the continent's trade landscape is set to become even more attractive for new market entrants and pan-African operations in the retail space.

Africa's five largest economies - Nigeria, South Africa, Kenya, Morocco and Egypt - also have the most competitive retail sectors and fast-growing eCommerce industries, this largely thanks to several leading global e-tailers operating across the continent.

According to the McKinsey Global Institute, eCommerce will be worth US\$75 billion by 2025 in Africa's leading economies, yet this sector also faces numerous challenges, such as a lack of national street address systems in many countries and the expense of last-mile delivery. Additionally, a large portion of the African population remains unbanked.

Infrastructure investment

Other challenges faced by both the formal and informal retail sectors include a shortfall in infrastructure investment, which hampers develop-

ment in the logistics space.

Alongside infrastructural challenges, there is a need to educate consumers about online retail - and gain their trust. Currently, a significant tion rate of 75 per cent is boosting the eComnumber of African smartphone users either do not know how to make purchases online or do not trust eCommerce platforms.

As such, Africa remains below the global eCommerce average growth rate, even across its biggest markets. Encouragingly, though, the continent is seeing an increase in technology-related productivity in sectors such as financial services, education, health, retail, agriculture and government. The number of digital shoppers in Africa doubled between 2015 and 2021 but, while digitalisation is a significant game-changer in Africa's retail sector, informal trade remains dominant in consumers' buying habits.

For example, Nigeria has established itself as a vibrant hub for new technology businesses, with several large e-tailers operating in the market. Yet, digitalisation is yet to drive significant transformation in the country's traditional brick-andmortar retail sector.

Social media channels

The rising availability of 4G networks and smartphones is steadily driving the uptake of digital transacting, with smaller retailers selling products via social media channels like Face-

book and WhatsApp, especially when consumers opt for cash-on-delivery.

In contrast, Morocco's high internet penetramerce sector's growth and the industry demonstrated significant year-on-year growth during the Covid-19 pandemic. The pandemic accelerated online food retail, and many Moroccan grocery retail chains launched their own apps and delivery services.

Currently, many eCommerce transactions in Morocco happen outside the banking system, this owing to the fact that many businesses offer cash as a payment option.

However, the volume of digital payments is swelling. Like other retail leaders on the continent, digital B2B start-ups are starting to play a significant role in modernising the country's traditional retail sector.

Similarly, the Covid-19 pandemic also prompted South African retailers to leverage technology to drive sales and better engage with customers, seeing a significant rise in online grocery and clothing purchases in 2020.

More growth expected

Industry experts forecast that this growth is expected to gain momentum, reaching growth figures as high as 100 per cent year-on-year over the next few years.

Just not good enough COP27 - time is up and we're no closer to solutions

HE inevitable extension of COP27 negotiations into the weekend because of deadlocks over final agreements, threatens to reduce this year's United Nations climate summit in Egypt to yet another damp squib.

Now running into reserve time, the negotiations in Sharm El-Sheikh are being marked by backsliding, stalling and, with it, further blows for the most vulnerable communities, which includes many in Africa

Friday 18 November was meant to be the last day of the two-week annual summit intended to set a clear and committed course for collective action in the face of a deepening global climate crisis.

Heart of the deadlock

At the heart of the deadlock are disagreements over the shape of a committed financing mechanism for loss and damage; the timeframes for this to come into effect, and extents of liability.

There also continues to be vague commitments on "phasing out" or "phasing down" of fossil fuels - oil, coal and gas - given the continued appetite of developed nations for fossil fuels, and the still prevailing position of developing nations that fossil fuels represent an essential resource to advance their economies.

Also of contention in the text is the qualifying language that defines "degrees of vulnerabilities" among vulnerable developing nations

It means that ultimately the eleventh-hour negotiations are underpinned by a deepening trust divide between the haves and have-nots of richer and poorer nations, and new questions about the value of COP summits into the future.

Civil society organisations and activists have also slammed working text for not going far enough to push back against fossil fuel industries. Watchdog organisation Global Witness noted that this year's COP saw 636 fossil fuel lobbyists in attendance, which is a 25% increase from COP26 in Glasgow.

The likes of climate scientist Peter Kalmus were tweeting at the tail-end of COP: "What kind of a climate meeting makes no attempt to phase out oil and fossil gas, when fossil fuels in general are the main cause of the crisis? And loss and damage numbers are inching up toward \$100-million - 0.01% what US spends on military in a year." Kalmus pointed out that the world is on track to pass 1.5°C warming in the next decade.

Continued climate-related misery

The Pan African Climate Justice Alliance (PACJA) also warned that despite COP27 being billed as the "Africa COP" it is "ending leaving millions of Africans in continued climate-related misery".

Mithika Mwenda, executive director of PACJA said: "We came with the hope that COP would materialise with concrete outcomes in Egypt."

PACJA added that COP summits are fast becoming obsolete as they fail to build on previous years' gains and are increasingly becoming wasted opportunities and expensive talk shops that ultimately do not deliver for the most vulner-



KIHEWA Project contributes to drop in maternal deaths in Karatu

IMPROVEMENT of health services including the construction of new health centres and availability of medical equipment have contributed to the drop in maternal deaths including children under five vears of age in Karatu District, Arusha Region.

This was revealed at the weekend by Karatu District Medical Officer, Dr Lucas Kazingo when inaugurating the KIHEWA Project whose aim is to eradicate maternal deaths and children under five years of age under the joint sponsorship of World Vision Tanzania and Korea International Cooperation Agency (KOICA).

"Since January this year, we have had two deaths only of women who were giving birth including one from Ngorongoro who came here for treatment, quite different from what used to be in the past," said Dr Kazingo.

He said the drop in maternal deaths has been contributed to the Project that saw the construction of health centres and the provision of medical equipment that helped in the improvement of mother and child care.

For his part, the representative of the Karatu dren under five years of age.

District Commissioner, Faraja Msigwa who was the chief guest at the event appealed to health workers to take care of the medical equipment to encourage sponsors thereof all aimed at benefiting the people, the target of the assistance.

"Some pregnant women in Karau district used to hire men to attend a clinic with, but this project has changed that, they come with their actual husbands," Faraja said.

KOICA Director General, Kyucheol Eo explained the reasons behind their investment in the prevention of maternal deaths, saying they saw a big number of babies dying after delivery.

For his part, Peter Paresso, the one of the beneficiaries of a caring parent said personally he has transformed himself from the habits that used to endanger the lives of mother and child.

KIHEWA Project, costing 3bn/- was established in 2020 in Karatu District through the construction of health centres, provision of medical equipment, construction of toilets, supplying water to areas without water and mobilising the people to in identifying their community development priorities, all aimed at reducing maternal deaths, including chil-

Rwegasira said this in Dar es Salaam at the weekend during the launching of a special sports programme for children with disabilities which was hosted by the non-governmental institution Women Sports Initiatives (WoSI).

The event involved children with special needs from Sinza Special School (Sinza Special) and others from Mapambano Primary Primary school in Kinondoni District.

The launched program is aimed at providing inclusive sports to build cooperation spirit among children with disabilities and thus eradicate the mentality of stigma and isolation from societies.

"All children including those with physical and mental challenges have the right to access education, do not hide them, giving birth to a disabled child is not a sin...please don't hide them at home, by doing so you are creating stigmatize, violence and psychological torture against them," he uttered.

He said the government through Sinza Special School has a conducive curriculum that enables children to cope with the circumstances, teachers are adhering to the teaching guidelines and ethics code while dealing with

welfare, the college is under Ministry of Social Development," the deputy mayor insisted.

He applauded WoSI for coming up with a social idea of associating children with disabilities and others in sports.

WoSI executive director, Lucy Mlula said as a non-profit organization they also motivate children with special needs to participate in sports and physical activities.

"We use sport as a tool to empower women and girls including those with disabilities to achieve gender equality and inclusivity in physical activity and sport," she said.

Mlula said Sinza Special School is merely a sample of many children with physical challenges in the streets, we are expecting to organize a meeting with parents whose children are disabled to ensure they get enough awareness concerning the relevance of taking their children to school hoping that their mindset will be transformed.

"Our plan in the near future is to conduct dialogues which will involve parents of children with special needs and other community members to see how the children get the opportunity and basic rights of participating in social activities including sports and physical exercises," she said.

'Fast-track amendment of Marriage Act for girls' safety'

AS part of marking the International Day of Children, the government has been called for immediate action to review and amend the Marriage Act, of 1971 which sets the minimum marriage age for girls at 15.

Observing the day, which is marked every November 20, a number of Dar es Salaambased children said that although the government has signed various international conventions that require it to safeguard the rights of children, still the Marriage Act of 1971 allows children, and girls under 18 years of age to be married.

Rahabu Francis from Minazini Secondary School of Dar es Salaam said: "We urge the government to do the needful to ensure that the Marriage Act of 1971 is amended so as to safeguard the girl child."

She however lauded the government for

putting in place various systems that allow pupils and students to formulate and participate fully in children's councils.

"We praise the government for formulating policy and different guidelines aiming at safeguarding and controlling the children's rights, like the laws and child's policy. Recently it has released the guidelines on how to establish children's protection desks, and councils," she said.

Sabrina Salum, a pupil from Gilman Ruthinda Primary School Kigogo Ward in Kinondoni commended the government for investing heavily in their rights and working tirelessly to ensure that the group access education and quality health services.

Miraji Ramadhani, a student from Mikocheni Secondary School in Dar es Salaam has urged the government and other key stakeholders in the education sector to

address the humiliation and violence done to children while at the school compound or outside the school compound.

He said the ongoing humiliation done to children at home, by their community and at school, has continued to affect the growth and progress of children.

Ramadhani mentioned bad acts that do affect children physically and psychologically such as beating, raping, insulting, and isolation among others.

He has urged the government to eliminate corporal punishment in schools, and instead come up with alternative punishments that will wisely change the behaviour of children and make them become more self-confident and trust those who teach them.

Sadiki, a pupil from Gilman Rutihinda Primary School said that climate change has posed a major challenge to girls especially when they walk long distances searching for water.

He has therefore urged the government to ensure areas that lack access to clean water, especially during the dry season are provided with enough water, as one of the ways of addressing unwanted pregnancies among young girls.

Sarafina Frank, a student from Mikocheni Secondary school has urged the government and other key stakeholders to involve them when preparing for the national budget, policies, laws and plans, especially on matters touching on their well-being and children's rights

Save the Children's country director, Bester Mulauzi commended the government for its many great efforts in ensuring its children get all the needed rights.

However, he has called upon the government to put children, their voices and demands at the centre of climate commitments and policies, especially children most impacted by inequalities and discrimination.

He also urged the government to invest in safety nets and other essential services such as school feeding programmes. To benefit the children and families threatened by the climate crisis.

Mulauzi has further urged the government to amend the education act and its regulations so as to abolish corporal punishment in schools and promote alternative means of discipline.

"Save the Children is ready to pilot the training and provide support to schools on corporal punishment."

He further requested the government to fast-track the amendment of the marriage act and ensure that children especially girls are safe.

Young software engineer dreams of turning Tanzania into technological hub

ANZANIA'S young software engineer minces no words when he says he spends sleepless nights thinking of how long will it take to making his country a technological hub.

Jumanne Mtambalike, 35, is chief executive officer and co-founder of Sahara Ventures, a company founded in 2016 to build a stable innovation, technology and entrepreneurship ecosystem in Tanzania and Africa through consultancy and investment, with 15 permanent employees in innovation technology and entrepreneurship and more than 60 consultants.

One of Mtambalike's in-tray to do list is the making of the first ever technological district along the New Bagamoyo Road in the country's commercial hub of Dar es Salaam.

"Sahara Ventures and partners decided to push this agenda of making Silicon Dar es Salaam and are now planning to engage with the government through the Kinondoni municipal council authorities to see if we can be able to promote this technological district," the software engineer told Xinhua in his 4th floor office located in a 15-storey building along the New Bagamoyo Road.

He said the technological infrastructure along the New Bagamoyo Road makes it the right candidate for becoming Tanzania's technological district.

Mtambalike said the government has already put in place investments along the road that are suitable for making it a fully fledged technological district, including the headquarters of the Tanzania Commission for Science and Technology (COSTECH), the Universal Communications Service Access Fund (UCSAF), the Tanzania Telecommunications Corporation and the University of Dar es Salaam's College of Information and Communication Technologies (CoICT).

These state-run technological institutions along the New Bagamoyo Road have lately been joined by the country's leading mobile

phone companies, he said, adding: "We are also seeing innovations hubs and data hubs relocating along the road."

"But we are also seeing banks, innovative and startup companies relocating along the same area, naturally making this place a technology district of Tanzania," said Mtambalike, the father of one child.

He added that "if one is looking for startup companies, if one is looking for innovators, if one is looking for young people who are working on emerging technologies such as artificial intelligence, big data and internet of things, this is the place to find them."

Mtambalike said a technology district has many benefits, including creating employment opportunities for young people and at the same time pushing the country toward a digital economy.

"A technology district is also a platform where some innovations can emerge to solve some of the challenges facing our country today, in health, in education and in agriculture," he said.

Mtambalike said in May 2016 he visited China for two weeks under the Migratory Bird Program, a non-profit event hosted in Yunqi Cloud Town, Hangzhou, China, that aims to bring the world's youth together for science and technology.

"My visit to China was an eye opener. I learned how the country is doing in promoting technological districts," said the software engineer who graduated at Bangalore University in India in 2011.

He said he was invited to the 2050 Vision program where he attended an event on Cloud City in China where he was able to visit some of the smart cities in China, adding that he visited some of the software and app development companies as well as gadget production companies. "The visit to China was very inspiring to me because I saw the vision of Silicon Dar es Salaam in practical," said Mtambalike.

He said he learned that a fully fledged technological district can have assembling plants for phones, assembling plants for computers and one can be able to manufacture low cost designs, adding that "I see that this is possible through strategic partnership and collaboration in Tanzania."

Mtambalike said China is leading in the world when one looks at the number of new innovations and new technologies.

"Right now Sahara Ventures has initiated a campaign called startups schools where we encourage university students to start their own startups," he said, adding that the program is being implemented at the CoICT, the Nelson Mandela African Institution of Science and Technology in the northern city of Arusha and the University of Iringa.

"Our goal is to create as many startups founder companies as possible to address the issue of unemployment in the country because we believe that if we can create job creators instead of job seekers then we can have massive impact in the country," said Mtambalike."

Sahara Ventures believes the best way to solve the problem is to build a sustainable business around it," said Mtambalike at the conclusion of the interview with Xinhua.

Malawian student invents sign language gloves in bid to enhance communication

BLANTYRE

AS the saying goes, "necessity is the mother of invention", failure to satisfactorily communicate with a close friend with speech impairment got 21-year-old final year student at Malawi's University of Business and Applied Sciences (MUBAS) thinking.

The young student, Madalitso Mnduwira, has ended up devising gloves that when worn and used in sign language gestures,

so that many people can be assisted." Mnduwira's innovation has already attracted the attention of many, including persons with speech and hearing impairments who rely on sign language to communicate.

A 26-year-old business woman based in Malawi's commercial city of Blantyre, Mercy Kathemba, is among those in praise of the new innovation.

The woman was born deaf and she told Xinhua that communicating with her customers using sign language has always been daunting.



they interpret the communication in speech using English or local languages.

Mnduwira, who is studying Information Technology at the University told Xinhua that in a recent interview, with the innovation, he hopes that those with impairment that require use of sign language to communicate will be able to do so effectively.

"The speech gloves, which have been made using locally made low-cost materials, will help bridging communication gaps between people with hearing impairment and the public," explained the innovator.

The prototype of the invention has undergone trials and, according to Mnduwira, it has proven to be accurate and effective.

The innovative student, who fell in love with science subjects right from his secondary school days, intends to produce as many gloves as possible to ease communication between those with hearing or speech impairments and the public.

"This is just a prototype of the product to come," he explained. "I hope to find sponsors to fund mass production of the product

"It is always tricky and difficult to communicate to my customers: most people in my area cannot understand sign language and it's always expensive to hire someone to interpret my sign language," explained the woman.

"I strongly believe that this development is going to provide solutions to most of our communication problems. I look forward to these speech gloves being more affordable to reach many people," she added.

Malawi Council for the Handicapped (MA-COHA) has also raised its eyebrows in anticipation of advanced communication through the "speech gloves".

The Council's public relations officer, Harriet Kachimanga, also noted that many people are not conversant with sign language and that Mnduwira's innovation will make it easier for people who cannot use sign language to comprehend the gestures.

"This is a very good development: There are persons with hearing and speech impair-

ments with knowledge and skills that can advance the country's development but they do not contribute fully to the society because of communication limitations," explained Kachimanga.

"We believe that development of such

innovations will make it easier for persons with speech and hearing impairments to communicate with the public personally and contribute to matters of national interest," she concluded.

According to the African Sign Language

Resource Centre, Malawi has very few trained interpreters and most of them are not accredited. Out of a population of 52,000 deaf people, there are only 11 interpreters, who work as volunteers and they are not salaried. Xinhua

Shanta to have new gold mine in Singida

Shanta Gold, whose sole current producing asset is the New Luika gold mine in the Lupa goldfield of Tanzania, will soon have a second gold mine -Singida - up and running.

Located in the Ikungi District of the Singida region of Central Tanzania, Singida will initially be a considerably smaller operation than New Luika with a projected annual life of mine (LOM) gold production of 32 000 oz at an all-in sustaining cost (AISC) of US\$950/oz over an initial mine life of seven years.

By comparison, New Luika is expected to produce between 68 and 76 000 oz in 2022 at an AISC of \$1 150-1 275/oz.

Construction of Singida is already over three-quarters complete (as of mid-October 2022) and the project is on course to pour its first gold in

Q1, 2023. Once its production is added to New Luika's, AIM-listed Shanta will be a plus 100 000 ozpa producer.

"Singida is located within a greenstone belt which has been subjected to very little exploration, so clearly there is an excellent chance that we

will find additional resources," he says.

"In addition, only 26% of current resources are included in the existing LOM plan. Most of our reserves are within 150 m of surface, so there is also plenty of scope for reserve expansion at depth." Shanta is so confident that it

will expand the resource base at Singida that it has taken the decision to size the project for expansion by installing a much bigger crusher than the operation will initially need and by over-sizing the tailings facility. Although Singida has been in Shanta's portfolio for many

years, the decision to develop it was only taken two years ago.

Zurrin says: "Going back around 15 years, Shanta had both Singida and New Luika in its portfolio. As a junior, the company didn't have the resources to develop both projects simultaneously, so it concentrated its efforts on New Luika, which entered production in late 2012."

Shanta remained active on Singida - even when it was devoting most of its energies to New Luika - producing an initial resource estimate in 2008, a PFS in 2010, a feasibility study in 2014 and a

technical report in 2017.

In 2018, it initiated fresh exploration and infill drilling on the project; while in 2019 it explored the possibility of an IPO on the Dar es Salaam Stock Exchange to finance Singida's development.

"By 2020 we had come to the conclusion that Singida was an asset of real value that should be progressed through to development," says Zurrin. "The board approved the project and in October 2020 we were able to report that we had updated the project economics and that we were starting construction work on

the mine, with the investment being funded from internally generated cash flow."

The update of the project economics produced some attractive figures: a LOM free cash flow of \$94 million, a posttax NPV (8%) of \$56 million and an unlevered post-tax IRR of 49% using a LOM gold price of \$1 700/oz. The capital cost was estimated at \$36.8 million (including stripping costs of \$10 million) with payback expected within 40 months.

"We have managed to stay within our project budget quite comfortably, which reflects the fact that we ordered the 'big

ticket' items quite early on before the global inflation that we're currently seeing take hold," notes Zurrin.

"The ball mill, for example, was ordered in late 2020 and the crusher in early 2021. We now estimate the project capex at close to \$40 million - somewhat higher than the figure we originally envisaged - but this is mainly accounted for by our decision to oversize some of the project infrastructure. The bigger crusher is costing us an extra \$0.6 million and the bigger tailings facility an extra \$2 million."

Germany tightens rules for firms dependent on China

China's service outsourcing logs vibrant growth

China's service outsourcing industry saw a steady expansion in the first 10 months of this year, according to data from the Ministry of Commerce.

Chinese firms inked service outsourcing contracts worth about 1.54 trillion yuan (about 216 billion U.S. dollars) in the January-October period, up 14.4 percent year on year.

The executed contract value stood at 1.06 trillion yuan during the period, with a year-on-year increase of 13.3 percent.

Of the total, the value of the offshore service outsourcing contract rose 14.6 percent over the same period last year to 875.7 billion yuan.

In terms of the executed contract value, offshore service outsourcing with the United States, the European Union and members of the Regional Comprehensive Economic Partnership expanded 10.5 percent, 19.6 percent and 7.5 percent year on year, respectively, in the first 10 months of this year.

Outsourcing refers to hiring an outside party to carry out services or produce goods typically undertaken by inhouse employees.

Deep trade ties bind Asia and Europe's biggest economies, with rapid Chinese expansion and demand for Germany's cars and machinery fuelling its own growth over the past two decades. China became Germany's single biggest trade partner in 2016.

However, the relationship has come under close scrutiny since Russia's invasion of Ukraine in February, which led to the end of a decade-long energy relationship with Moscow and caused numerous companies to ditch their local businesses.

Global stocks gain on hopes recession waning

Global equities edged up and a key part of the Treasury yield curve inverted further on Friday, a sign the US economy will stall next year and that investors hope will lead the Federal Reserve to back off its aggressive hiking of interest rates

Surprisingly strong retail sales data this week hammered home the idea that the Fed will tighten monetary policy further even though soft consumer and producer price pressures suggested inflation has peaked and would allow for lower rates.

Treasury yields rose for a second day following hawkish comments on Thursday by St. Louis Fed President James Bullard, who said rates needed to rise to at least a range between 5% and 5.25% to choppy session. The Dow Jones be "sufficiently restrictive" to curb inflation.

home sales tumbled for a record ninth straight month in October as the 30-year fixed mortgage rate hit a 20-year high.

The two-year note's yield rose 7.7 basis points to 4.531%, much higher than the 10-year note, which was up 5 basis points at 3.823%.

The MSCI world equities index rose 0.48% but was heading for a loss of about 0.5% on the week, coming off recent two-month highs. The pan-European STOXX 600 index 1.16%, its best one-day performance in more than a week.

"Where we think the market is getting it wrong, is pricing in rate cuts next year," said Dec Mullarkey, managing director of investment strategy and asset allocation at SLC Management.

"Powell often has made the point, 'we're concerned that if you let up too quickly, that you'll have a second surge of inflation,' and that's not something they want to repeat," Mullarkey said, referring to Fed Chairman Jerome Powell.

The market sees a recession next year as the yield spread between two- and 10-year Treasuries was -71 basis points, an inversion of the yield curve that has not reached such depths since at least 2000.

When yields are less on the 10year note than the two-year, a security that reflects interest rate expectations, it suggests a slowdown or worse and that the Fed will cut rates to spur the economy.

The impact of rising rates was felt in housing, where U.S. existing

Industrial Average advanced 0.6%, the S&P 500 gained 0.48% and the Nasdaq Composite crept 0.01% higher. For the week, the Dow was unchanged, the S&P 500 fell 0.69% and the Nasdaq shed 1.57%. The euro fell 0.35% to \$1.0324,

having eased from a four-month peak of \$1.0481 hit on Tuesday as some policymakers argued for caution on tightening.

Japan's Nikkei slipped 0.1% as data showed inflation running at a 40-year high as a weak yen stoked import costs.

Oil fell about 2% and logged its second weekly decline, pressured by concern about weakening demand in China and further increases to U.S. interest rates.

US crude futures fell \$1.56 to settle at \$80.08 a barrel, while Brent settled down \$2.16 at \$87.62.

US gold futures settled 0.5% lower at \$1,754.4 an ounce. Bitcoin fell 0.31% to \$16,634.00.

World's longest-standing president seeks to extend 43-year rule

EQUATORIAL Guinea voted yesterday in a general election in which President Teodoro Obiang Nguema, the world's longest-standing president, is expected to extend his 43-year rule at the helm of the tiny oil-producing West African nation.

Over 400,000 people registered to vote in the country of around 1.5 million. Voters will also cast ballots to elect 100 members of parliament for the lower house, 55 of the country's 70 senators, and local mayors.

80-year-old Obiang has always been elected with over 90 percent of votes in polls whose fairness international observers have questioned given longstanding complaints by rights groups over a lack of political freedom.

He is vying for a sixth term against two opposition candidates - Buenaventura Monsuy Asumu, who is running for the sixth time against Obiang, and Andrés Esono Ondo, who is running for the first time.

"The presidential election is completely devoid of suspense," said Maja Bovcon, a senior Africa analyst at risk in-Observers expect no surprises. The telligence company Verisk Maplecroft.

Closing his campaign on Friday, Obiang said he decided to bring the presidential election forward by several months, and hold it together with the legislative and municipal elections, to save money due to the economic crisis.



Museveni: E. Africa working to restore order in eastern DRC

UGANDAN President Yoweri Museveni has said East African nations working with the Congolese government will bring order in war-torn eastern Democratic Republic of Congo (DRC).

Museveni, according to a State House statement issued here late on Friday, said this while meeting a visiting UN Security Council delegation.



Museveni said while dialogue among Congolese groups would be given priority, force will be used against groups who continue fighting.

"So, these Africans, if they unite, nobody can defeat them on the African continent. There's no force which will defeat East Africa," Museveni said.

On allegations that some neighboring countries are supplying arms to the rebels of the March 23 Movement (M23), Museveni told the delegation that East Africa cannot fail to investigate and know the truth.

"If we work in East Africa, we shall go, investigate and get facts instead of counter accusations which never end," Museveni said.

The UN Security Council delegation is in Uganda, after a similar mission in DRC and Rwanda.

The head of the delegation, Michel Xavier Biang, who is also the chair of the UN sanctions committee on DRC, told Museveni that a brief will be given to the Security Council early next month about the visit.

Moscow calls for worldwide denunciation of Russian POW execution by Ukrainian troops, says MFA

MOSCOW

RUSSIA urges international organizations to condemn the execution of Russian prisoners of war by Ukrainian soldiers and to conduct a thorough investi-



gation, Russian Foreign Ministry Spokeswoman Maria Zakharo va said in a statement on Friday.

"We demand that international organisations condemn and thoroughly investigate this shocking crime. No atrocity committed by Ukrainian military units will remain unpunished. All those guilty and their accomplices will be identified and punished accordingly.

Nobody will escape retribution," the Russian diplomat said, commenting on the video showing Ukrainian soldiers "mercilessly shooting unarmed Russian POWs," which has gone viral on the Internet.

"These shocking videos are further evidence of the crimes committed by Ukrainian neo-Nazis. Ukraine is flagrantly violating international humanitarian law, specifically the 1949 Geneva Convention relative to the Treatment of Prisoners of War and international human rights laws, including the 1966 International Covenant on Civil and Political Rights and the 1984 Convention against Torture and Other Cruel, Inhuman or Degrading Treatment or Punishment," she said.

Ukrainian militants regularly disseminate videos showing how they murder, torture, humiliate and beat people, she said.

"The collective West that supports Kiev totally paid no attention to these numerous facts. Such approval by the US and European curators makes them accomplices to the crimes committed by the Ukrainian neo-Nazis whom they foster," she went on, adding that the above-mentioned atrocities were committed not only by Ukraine's neo-Nazi groups, but by regular troops as well.

"Their commitment to neo-Nazi ideology and actions in furtherance of those principles reveal the criminal essence of the Kiev regime," Zakharova added.

China, Indonesia support each other on journeys ahead as companions

CHINESE President Xi Jinping held talks with Indonesian President Joko Widodo in Bali, Indonesia on Nov. 16. The two heads of state reached important consensus on striving towards building a China-Indonesia community with a shared future.

The two presidents agreed to take the 10th anniversary of the establishment of the comprehensive strategic partnership between the two countries next year as an opportunity to open up new prospects for high-level cooperation.

The two heads of state guide the stable development of China-Indonesia relations from a strategic and long-term view. This will better benefit the two peoples and make greater contributions to world

peace, cooperation and development.

Guided by the two Presidents, China-Indonesia relations have embraced prosperous development over the recent years, demonstrating strong resilience and vitality.

In July this year, Widodo paid a visit to China, during which he and Xi decided on the overall direction of building a China-Indonesia community with a shared future.

As a flagship infrastructure project of China-Indonesia cooperation under the synergy of China's Belt and Road Initiative (BRI) and Indonesia's Global Maritime Fulcrum (GMF), the Jakarta-Bandung HSR has become a symbol of China-Indonesia friendship and a pride shared by the two countries.

It is the first HSR in Southeast Asia, and upon completion, it will slash the traveling time between Jakarta and Bandung to just 40 minutes from over three hours. Once put into operation, the railway will speed up and improve the mobility of people and goods, and new economic growth drives will emerge in Jakarta and Bandung.

Both China and Indonesia uphold the philosophy of seeking people-centered development. They share common ideas, interests and a closely connected future.

By enhancing experience sharing in governance at a higher level and advancing modernization through

joint efforts, the two countries will better promote well-beings for their peoples.

China and Indonesia agreed to carry forward high-quality projects under the synergy of the BRI and GMF and build on more flagship projects such as the Regional Comprehensive Economic Corridor and the "Two Countries, Twin Parks".

Both China and Indonesia are committed to enhancing multilateralism and safeguarding the interests of developing countries and international equity and justice, which demonstrate the sense of responsibility of the two major developing countries.

Zelensky wants no talks in order not to acknowledge fact of Ukraine's break-up, says Medvedev

MOSCOW

THE West does not want to rupture relations with Russia completely, which is fraught with World War III, so they prod Kiev into holding talks with Moscow, but Ukrainian President Vladimir Zelensky does not want them in order not to acknowledge the fact of Ukraine's breakup, Russian Security Council Deputy Chairman

Dmitry Medvedev wrote on his Telegram channel on Saturday. Medvedev pointed out that no one, including the Polish, had not been taken in by Ukraine's "clumsy attempts" to shift responsibility for the missile incident in Poland to Russia. According to the deputy chairman of the Russian Security Council, it largely proves that "everyone is exhausted from the Kiev regime" and especially from Zelensky, who "is constantly stirring up tensions" and "demanding more and

more handouts in money and arms." "The United States, NATO and the European Union are unwilling to eventually break up with Russia, which is fraught with World War III. Hence the increasingly frequent attempts to circumscribe and talk sense into Kiev, and to push it out to enter into negotiations," Medvedev wrote.

Nevertheless, "Zelensky does not want any negotiations for quite obvious selfish reasons. Moreover, they [negotiations] are very dangerous for him," Medvedev continued.

"After all, unless he acknowledges the realities of Ukraine's break-up, it makes no sense to sit down at the [negotiating] table. Once he admits it, he will be bumped off by his own nationalists who are connected with the army top brass, and of whom he is scared out of his wits," Medvedev said, describing the situation by the chess term 'Zugzwang' (in which each move of a player will worsen his/her position).

A missile crashed in the village of Przewodow in eastern Poland's Lublin Voivodeship close to the border with Ukraine on November 15, killing two people. Polish President Andrzej Duda said this was not a deliberate attack on Poland. Warsaw has learned that the projectile was most likely an S-300 missile produced in the 1970s and used by the Ukrainian air defense forces.

The Russian Defense Ministry slammed the Polish media and statements coming from officials in Warsaw that the missile was allegedly Russian-made as a provocation, saying that Moscow did not strike anything near the Ukrainian-Polish border. The top brass pointed out that judging by the published photos, the debris had nothing to do with Russian missiles.

DONALD Trump on Saturday said he had no interest in returning to Twitter even as a slim majority voted in favor of reinstating the former US President, who was banned from the social media service for inciting violence, in a poll organized by new owner Elon Musk.

Slightly over 15 million Twitter users voted in the poll with 51.8 percent voting in favor of reinstatement.

"The people have spoken. Trump will be reinstated," Musk tweeted.

Trump's Twitter account, which had over 88 million followers before he was banned on Jan 8, 2021, began accumulating followers and had nearly 100,000 followers by 10pm ET Saturday. Some users initially reported being unable to follow the reinstated account on Saturday evening.

Trump had appeared less than keen earlier in the day.

"I don't see any reason for it," the former president said via video when asked whether he planned to return to Twitter by a panel at the Republican Jewish Coalition's annual leadership meeting.

He said he would stick with his new platform Truth Social, the app developed by his Trump Media & Technol-

said had better user engagement than Twitter and was doing "phenomenally well".

Twitter did not respond to a request for comment.

Trump, who on Tuesday launched a bid to regain the White House in 2024, praised Musk and said he had always liked him. But Trump also said Twitter suffered from bots, fake accounts and that the problems it faced were "incredible".

Musk first said in May he planned to reverse the ban on Trump, and the timing of any return by Trump was closely watched - and feared - by many of Twitter's advertisers.

The billionaire has since sought to reassure users and advertisers that such a decision would be made with consideration by a content moderation council composed of people with "widely diverse viewpoints" and no account reinstatements would happen before the council convened.

He also said Twitter would not reinstate any banned users until there was a "clear process for doing so.'

But this week, Musk reinstated comedian Kathy Griffin, who had been banned for changing her profile name to "Elon Musk" which violated his new rule against impersonation without indicating it was a parody account. There has been no new information about process or the moderation council.

No reason to return

He has halved the workforce and severely cut the company's trust and safety team, which is responsible for preventing the spread of misinformation and harmful content.

On Saturday, Bloomberg reported Twitter could fire more employees in its sales and partnership divisions, citing unnamed sources, just days after a mass resignation of engineers.

If Trump returned to Twitter, the move would raise questions about his commitment to Truth Social, which launched on Apple's App Store in February and Google's Play Store in October. Trump has some 4.57 million followers on Truth Social.

Truth Social has been Trump's main source of direct communication with his followers since he began posting on the app regularly in May. He has used Truth Social to promote his allies, criticize opponents and defend his reputation amid legal scrutiny from state, congressional and federal investigators.

His agreement with the company, however, opens the door for Trump to engage extensively on other platforms. Trump is obligated to give Truth Social a six-hour exclusive on any post - but is free to post "political messaging, political fundraising or get-out-the vote efforts" on any site, at any time, according to a May SEC filing.

Algerian-Russian operational military relations experiencing a significant turning point

ALGIERS

THE operational military relations between Algiers and Moscow are experiencing a significant turning point. as the two sides are conducting joint military exercises from 16 to 28 November 2022 in the region of Hammaguir in Bechar.

The transition to an operational stage in the Algerian-Russian military relations is not recent as in November 2021 too, the two countries held joint military exercises in South Ossetia, in which an Algerian contingent has taken part. In September 2022, a unit comprising 100 soldiers of the ANP participated in the exercise "VOSTOK 2022", held in the Far East of Russia.

Naval military exercises have been regularly carried out between the two armies in the last two years and a few days before these exercises, the Director of the Federal Service of Military and Technical Cooperation of Russia, Dimitrii CHOUGAEV, travelled to Algeria where he met, on November 10, 2022, with the Chief of Staff of the National People's Army.

This visit consolidated the relations between the two armies as it cornes in the context of the increase in the Algerian military budget (\$ 23 billion) for the year 2023. This has led Russian military officiais to covet Algeria in order to get a significant shore of this budget in the form of arms sales. Moscow will reap substantial benefits from arms sales to Algeria, which will certainly be used to finance and support Russia's invasion of Ukraine.

The Bechar exercises are only a mere message from Moscow to the West, demonstrating Russia's ability to deploy ifs forces close to Western interests in the western Mediterranean. The unbreakable geopolitical relationship between Algeria and Russia places Algiers in the proRussian clan. The discrepancy between the official Algerian discourse, advocating non-alignment and neutrality, and the reality on the ground points to an ironclad alliance between Algeria and Russia.

The existence of a clan within the Algerian establishment considering the alliance with Moscow as sacrosanct and a cornerstone of the Algerian state. This, as Moscow considers Algeria to be an extended front in its strategy of military confrontation with the West. Russia will resort to this front in order for its striking force to maintain a close range, which renders the Algerian-Moroccan border a demarcation line between the zone of Western influence and that of the former socialist clan.

Algeria's alignment on Russian positions harms the geopolitical interests of The West. Therefore, countries of the West should review their strategies and partnerships with Algeria and it is reaping the benefits of its energy contracts with the West, while it continues to enhance its military cooperation with Mos-COW.

Frontier Chinese aviation, aerospace technologies displayed at Airshow China 2022

THE 14th China International Aviation and Aerospace Exhibition, also known as Airshow China 2022, was held at the Zhuhai International Airshow Center, Zhuhai, south China's Guangdong province, between Nov. 8 and 13.

The event was joined by over 740 enterprises from 43 countries in person and online, attracting around 200,000 visitors. Cooperation agreements for 549 aircraft, worth \$39.8 billion, were inked at the event.

The Airshow China is an important platform showcasing the cutting-edge technologies and innovations of the Chinese aviation and aerospace industry as well as national defense.

It is reported that the Aviation Industry Corporation of China (AVIC) took over 200 pieces of independently developed aviation equipment and technologies to the Airshow China 2022, up 34 percent from a year ago. Fifty-five of them were exhibited for the first time at the event.

The exhibition is a witness to the huge progress made by the Chinese aviation and aerospace industry, as well as the improving capability of China in manufacturing high-end weapons and equipment.

It only took three years for China to unveil its stealth fighter jet J-20 after the Chinese transport aircraft Y-20 debuted, and the medium-lift helicopter Z-20 with double China-made engines was also launched three years after the J-20 was unveiled.

Li Weipeng, who flies the J-20, said the engines and the avionics of the J-20 jets exhibited this time have been comprehensively updated, though their appearance remained the same.

Y-20U, a tanker variation of the Y-20; C919, China's first home-

The COMAC said it has received 300 new orders for the C919 and 30 for the ARJ21 from seven leasing firms.

The SLC-18, a new P band solidstate active phased array radar developed by China, was exhibited at the Airshow China 2022. The radar can scan a wide field of space and work in tough weather and environments

FIFA head says fans 'will survive' without beer at World Cup

FIFA president Gianni Infantino downplayed Qatar's last minute ban on the sale of beer at World Cup stadiums as nothing more than a brief inconvenience to spectators.

"If this is the biggest problem we have, I'll sign that (agreement)," Infantino said Saturday, a day after the conservative Muslim emirate did an about-face on the deal it had made to secure the soccer tournament.

Infantino blamed "crowd flows" in Doha for the decision, though it appeared to be a ruling by Qatar's autocratic government to placate its conservative Wahhabi citizens who already have been angered by some events around the tournament they view as Western excesses.

Infantino said the beer ban at stadiums was made jointly by Qatar officials and FIFA.

"We tried until the end to see whether it was possible," Infantino said of allowing alcohol sales. "If for 3 hours a day you cannot drink a beer, you will survive. Maybe there is a reason why in France, in Spain, in Scotland, alcohol is banned in stadiums. Maybe they are more intelligent than us, having thought maybe we should be doing that."

Spectators can drink alcoholic beer in the evenings in "the FIFA Fan Festival," a designated party area that also offers live music and activities. Qatar puts strict limits on the purchase and consumption of alcohol, though its sale has been permitted in hotel bars for years outside of the tournament-run areas.

The World Cup begins Sunday with an opening match between host country Qatar and Ecuador, and when Qatar made its pitch to host the tournament, the country agreed to FIFA's requirements of selling alcohol in stadiums. The alcohol plans were only released 11 weeks before kickoff and then changed on Friday.

FIFA says non-alcoholic beer will still be sold at the eight stadiums, while champagne, wine, whiskey and other alcohol will be served in the luxury hospitality areas of the arenas.

The launch a day before the opening World Cup match seemed designed to supplant a pledge by European teams to wear their own armbands as part of a Netherlands-led anti-discrimination campaign drawing attention to host nation Qatar's laws and record on human rights issues.

World Cup rules require that equipment such as captains' armbands must be authorized and provided by FIFA, but Neuer said he will wear the "One Love" design even if it comes with a fine.

"It's good that we have the power with other nations in western Europe," Neuer said.

Although Germany does not play until Wednesday, against Japan, three teams which joined the "One Love" campaign in September will play on Monday: England, the Netherlands and Wales.

FIFA had not directly addressed the Europeans' request several weeks ago for permission to wear the heart-shaped, multi-colored logo, then unveiled its proposal on Saturday.

The FIFA choice of slogans for group games include "SaveThePlanet," "ProtectChildren" and "ShareTheMeal."

"These campaigns have taken into account feedback received from our member associations who, like FIFA, are committed to using the power of football to effect positive change around the world," the soccer body said.

The slogan "NoDiscrimination" - the only one that aligns with the European teams' wish – is scheduled to appear at the quarterfinal stage.

"Obviously the short notice is surprising," Germany team director Oliver Bierhoff said within two hours of the announcement. "It looks as if FIFA doesn't have a clear stance."

Denmark starts on Tuesday against Tunisia and captain Simon Kjaer should be wearing the "One Love" armband.

"What the consequences will be, I don't know," Eriksen said at a news conference where he wore a plain black T-shirt for practice.

Denmark has the option of playing in a black game jersey, the color of mourning for migrant workers who died helping build infrastructure needed for hosting the tournament.

Denmark sporting director Peter Moller described the timing of FIFA's announcement as "a little bit strange.'

"We think the (armband) that we are playing with," Moller said, "is an even stronger statement."



TANZANIA's national swimming team, alias 'Tanzanite', has triumphed in the 2022 African Swimming Confederation (CANA) Zone Three Championships that took place in Dar es Salaam last weekend.

The Tanzanite squad collected 3,061 points to overshadow the other nine countries' teams that featured in the event held at the Dar es Salaam Gymkhana Club's swimming pool.

Apart from Tanzania, other participating countries were Uganda, Zambia, South Africa, Burundi, Sudan, Djibouti, Rwanda, and Ethiopia. The success has for that matter witnessed Tanzania emerge as the continental showdown's winner for the third time in history.

The second place was won by swimmers who were given chance to compete in the event while their country has been suspended. The swimmers collected 2,768 while Uganda finished third with 2,521.50 points, and Zambia settled for fourth place with 1,878 points.

The fifth position was won by South Africa after collecting 1,385. 50 points while Burundi ended in the sixth position after collecting 653 points, followed by South Sudan which came seventh after collecting 213 points.

The results show that Djibouti notched 87 points, Rwanda (67 points), and Ethiopia (47 points) finishing eighth, ninth, and 10th respectively in the competition's log.

Speaking yesterday, Tanzania Swimming Association (TSA)'s organizing committee Chairperson Hadija Shebe congratulated the swimmers' performances in the championships that attracted 263 swimmers from 10 countries.

Tanzania fielded 63 swimmers who were coached by Alexander Mwaipasi, Michael Livingstone, Kanisi Mabena, Zubeir Likoko, Odilo Kamata, Thobias Mwangunga, and Msabila Charles.

Hadija said they are extremely proud of the swimmers' results and winning the showdown's title for the third time in history.

"We feel proud of the victory and this is the third time in history our swimmers win the title," she said.

Tanzania won the title for the first time in 2016 in Kigali, Rwanda, and later won it in 2017 in the championships held in its backyard.

The TSA boss also commended the swimmers, coaches and the association for ensuring the showdown takes place in the country and facilitating the hosts' swimmers' triumph.
