MPs: Lowassa 'father' of ward secondary schools

CONSENSUS was visible among legislators yesterday on the role played by the late former premier Edward Lowassa in the setting up of ward secondary schools.

In interviews outside the debating chamber of the National Assembly, MPs were in various shades of being touched by the death of the former prime minister, and easily vibrant of the respect he earned as a visionary administrator and supervisor of development activity.

Deputy Speaker Mussa Azzan Zungu (Ilala) said Lowassa's death is a loss for all Tanzanians, recalling having met him in the Defense and Security standing committee that later became the Foreign Affairs standing committee.

He said Lowassa carried influence with ambassadors from different countries and cooperated well with them on diplomatic issues.

"I witnessed how he worked hard on establishing ward secondary schools where today many students get division one," the senior legislator noted, elaborating that Lowassa respected everyone, the youth and adults.

"There are many good things to say about him because I have been his vicechairman of both committees," he said.

Luhaga Mpina (Kisesa) said the nation has lost a hero. He remembers him for many things including his ability in managing government activities.

"When something was planned to be done, Lowassa had the ability to manage and monitor it when he was a legislator, a minister and when he was prime minister." he stated/.

He similarly underlined his experience when the government started the construction of ward secondary schools in 2006 where, as premier, he ensured that leaders at all levels were involved in implementing the project.

Lowassa was adamant that government plans must be well-managed and implemented, especially in the education sector, the MP affirmed, crediting the success of building ward level secondary schools. "You cannot hesitate to compliment Lowassa who pioneered the idea," he declared.

Japan donates to **UNHCR \$0.36m**

JAPAN has donated \$360,000 (900m/-) to the United Nations High Commissioner for Refugees (UNHCR) for the provision of safe shelter, water, sanitation and hygiene for recently arriving Congolese refugees in Kigoma

Misawa Yasushi, the ambassador of Japan, said at the signing event in Dar es Salaam yesterday that since early last year, more than 14,000 asylum seekers from the Democratic Republic of Congo (DRC) have been received

Praising the government for its exceptional generosity and hospitality in supporting the refugees. "Currently, more than 240,000 refugees mainly from Burundi and DR Congo are living in two refugee camps in Tanzania. In this regard I would like to commend President Samia Suluhu Hassan's administration for its significant efforts in supporting refugees," he

To mitigate the burden of the host country; the government of Japan has been extending humanitarian assistance for refugee operations, he said, noting that in recent years, the world has faced a number of new humanitarian crises., Citing the situation in Sudan, Ukraine and Palestine he said that as a result the need for humanitarian assistance has expanded dramatically.

"Given the scale of the overall crisis, the assistance provided by the government of Japan is very limited. However, we commit ourselves to continue to provide steady and assistance to refugee operations to the full extent possible," he stated, underlining that an emergency grant of up to \$500,000 provided last October was also based on these considerations.

TCRA hits fraudsters, shuts 21,788 simcards

UPWARDS of 21,788 simcards have been blacklisted and deactivated from making and receiving phone calls due to various reasons, including involvement multiple dubious acts including online criminal activities, for the last three months.

Dr Jabir Bakari, the Tanzania Communications Regulatory Authority (TCRA) director general, said in delivering an overview of TCRA activities for the past year in Dar es Salaam yesterday said that trend of phone fraud incidents are on steady decrease.

Such incidents dropped from 23,328 blacklisted simcards in July

to September 2023 to 21,788 phone lines from October to December, implying a reduction of 1,540 phone lines caught in acts of fraud.

A technical term, SIM card is an integrated circuit intended to securely store an international mobile subscriber identity number and its related key, thus a secured identity module attached to connecting with a particular service provider.

Phone scams noticed as of December 2023 had Rukwa Region leading with 7,666 incidents followed by Morogoro with 7,171 incidents, with Dar es Salaam eliciting 1,717 incidents.

POPE Francis received President Samia Suluhu Hassan at the Vatican yesterday for their first meeting.

The Holy See press office said in a statement that the discussions were cordial and highlighted existing good relations between Tanzania and the Holy See.

The talks focused on the important role that the Catholic Church plays in the country in favour of the population, especially in the charitable, educational and healthcare spheres, the statement indicated.

Following the private audience with the Pope, President Samia met with Secretary of State Cardinal Pietro Parolin, accompanied by Archbishop Paul Gallagher, the secretary for relations with states and international organisations. The two sides discussed the challenges that Tanzania

faces in the social context, along with the regional situation in Africa and various international current affairs. the statement indicated. Both parties expressed their mutual wish for an ever

greater commitment to the promotion of peace, it elab-

With a delegation that includes representatives from Tanzania's Catholic Church associations and missions, including youth, men, and women, the president was expected to hold a wider audience with the pope on the second day of the visit.

Data by the Ministry of Foreign Affairs and International Cooperation lists the Catholic Church in Tanzania as operating 240 pre-primary schools, 147 primary schools and 244 secondary schools.

It also operates five technical colleges, five universities; five teacher training institutions and two university centres attached to the St. Augustine University of Tan-

The colleges have a total of 31,000 students, while there are 473 health institutions, which the church says is an array of institutions intended to serve the whole person, physically and spiritually.

Observers say that there is a strong relationship between schools operated by the Catholic Church and the spread of evangelization pursued by the Mother Church starting from the third quarter of the 19th century.

Mbeya had 1,549 such incidents, Tabora far below with 590 and Songwe chalking up 328 incidents. Other regions had scattered fraud incidents with Mtwara recording 22 incidents, North Pemba with five and South Pemba registering six incidents of attempted fraud.

TCRA had registered greater success in monitoring such incidents, identifying external fraudulent phone calls, he said, affirming that appropriate mitigation measures were being taken, pulling down the number of reported incidences

One such method is the prevention of stolen, lost or damaged phones from being used, or phones without proper standards, sub-standard or counterfeit phone handsets, he said.

TCRA mitigation measures enabled identifying and deactivating duplicate international mobile equipment identity (IMEI) numbers associated with fraudulent activities, and those reported as lost or stolen, he said.

The regulatory body has made efforts to raise awareness on safer and proper use of mobile phone services to ensure users are shielded from online scammers, he asserted.

"TCRA underscored the importance for the public to exercise vigilance and report any suspi-

cious text messages or calls they receive," he said, pointing especially at the need to report suspicious phone numbers to 15040, toll free number, by short messages (SMS).

Regulatory measures, including sanctions against culprits, will be implemented based on these reports, he added.

Ministers and deputy ministers were required to visit their respective areas all over the country to supervise the numerous construction projects for the schools, he said, specifying that Lowassa pioneered the teacher training crash programme which helped subsequent recruitment of teachers in the new schools.

"Lowassa struggled to increase the number of teachers in secondary schools and made sure that there were learning tools and laboratories," the MP emphasized.

Mariam Kisangi (Special Seats, Dar es Salaam) said that being in the House for 15 years had enabled her to participate in various legislative activities with the late

Dar es Salaam was among regions that had poor provision of learning space, with the former premier solving the challenge of lack of classes as usual with sharply thought out strategies.

Saashisha Mafuwe (Hai) said the late Lowassa will be remembered as an unwavering leader with logical leadership decisions.

"I would really like to live to his age and even more than his age if I'm still in politics," he added.

Z'bar in clean energy drive to mitigate climate change

ZANZIBAR government has embarked on a clean energy promotion campaign to economically empower women entrepreneurs and help them tackle climate change and conserve the environment.

Mudrik Ramadhan Soraga, Zanzibar Minister for Tourism and Heritage made the statement yesterday when addressing delegates at a function to receive 1000 gas cylinders and stoves donated by Oryx Gas Tanzania Limited (OGTL). The gas cylin-

ders and stoves will be distributed to women entrepreneurs especially those involved in the food vending business.

"We commend President Dr Hussein Ali Mwinyi for spearheading efforts to ensure availability of clean energy for cooking. The President is doing all these to conserve the environment but also empower women as they will be able to prepare food in a fast and convenient manner," said the minister noting the country has set a target to ensure by 2032, 80 percent of Tanzanians would be using clean energy for cooking.

He said in a few weeks to come, women entrepreneurs in Pemba will also receive the gas cylinders. He also applauded the energy company for being in the forefront in promoting clean energy for cooking

Soraga said the 8th phase government is determined to empower citizens as well as making sure that they have access to clean energy. He said the government has been putting in place a conducive environment for small scale entrepreneurs to operate which includes issuance of loans.

The government has in three years provided loans amounting to 27bn/- under its empowerment program, he said, adding that more than 26000 people including entrepreneurs have benefitted.

"Efforts by OGTL complement the government initiatives towards empowering Isle residents. This kind of cooperation is commendable as it would ultimately reduce people's dependency on forest as a source of energy," he remarked, noting the move is also geared at ensuring children especially girls have enough time for studies instead of going to look for wood.

Benoit Araman, OGTL Managing Director said:

"This partnership has resulted in the construction of the first LPG terminal in the archipelago which will be fully commissioned before the end of first quarter of 2024. It is a commitment from Oryx Gas Zanzibar and TP to the citizens of the archipelago."

He said President Mwinvi's vision together with the boldness of Oryx energies and its partner, will allow making LPG supply sustainable and more affordable in Zanzibar and Pemba. He said the availability of clean energy also supports the development of the tourism industry.

"Clean energy in cooking will contribute to fighting against pollution in town with future buses equipped with LPG engines which will also have significant savings versus traditional fuels for vehicles. We are proud to contribute to the long-term development of the archipelago," he added.

Araman said that Oryx started trading LPG in Zanzibar and Pemba n 2016, noting since then, Zanzibar has been a key source of inspiration for Oryx to consider further investments on the islands and above all the signing of a long term partnership agreement with the successful Zanzibari Group TP, which has become a 30 percent shareholder of Oryx Gas Zan-

1.8bn/- to refurbish feeder roads damaged by rains in Ubungo MC

UBUNGO Municipal Council in Dar es Salaam has set aside 1.8bn/- for the rehabilitation of feeder roads which have been destroyed by the ongoing rains.

The roads are those which are not served by the Tanzania Rural and Urban Roads Agency (TARU-RA) and Tanzania National Roads Agency (TANROADS).

District Commissioner Hashim Komba said over the weekend that they are in the initial stages of determining maintenance costs for damaged roads before the work to renovate them com-

Earlier, a statement issued by the district's communication department noted that the allocated funds will be sent to the ward and soon to restore communication of the damaged roads.

"We appeal for the citizens to continue to be patient as we are taking the efforts to improve the damaged infrastructure, we hope that soon things will be better and residents will start enjoying smooth road transport in the streets," the statement noted.

Apart from the efforts, the mu-

nicipality is also in the process of preparing the 2024/25 budget where improvement of road infrastructure is among its priorities, especially those that will be damaged by the on-going rains.

The municipality also plans to come up with a special campaign aimed to fast-track construction and improvements of impassable roads in streets to help stimulate economic activities and bring development to the people.

According to the statement, the campaign will engage different stakeholders including citizens and experts from TARURA.






Zitto Kabwe(pictured), party leader made the suggestion yesterday in Dar es Salaam when speaking at the National Executive Committee Meeting

He noted: "Conflicts of this nature have spread throughout our country, and if not addressed, may lead to civil strife and jeopardise our national stability. We have seen and heard complaints from people of Mbarali, Ngorongoro, Kagerankanda, and Kalelani in Kigoma, and massive invasion of livestock in the districts of Kilwa, Nachingwea, Tunduru, and Liwale."

CMO calls for concerted efforts to curtail epilepsy

CONCERTED efforts are highly needed to address epilepsy in the community and stop discrimination against people affected with the disease, which in most cases is being associated with myths particularly in low-income countries

Prof. Tumaini Nagu, Chief Medical Officer made the statement yesterday at the International Epilepsy Day 2024 conference held at Muhimbili National Hospital and organized by Tanzania Epilepsy Association (TEA).

Prof. Naku said that despite scientific evidence that epilepsy is a disease it is still associated with myths related to supernatural causes which include, possession by evil spirits, divine or sacred disease in particularly the low and middleincome countries.

"These factors result in poor health seeking behaviors, affects growth and developmental milestones of children and quality of life patients where by some are not allowed to attend school or be allowed to play with other children and during a seizure they are left unattended. Discrimination of employment or marriage also leaves a lot to be desired," said Prof. Nagu.

Prof. Nagu said that Epilespy is a disease and those affected deserve to receive treatment and should not be discriminated against rather than assisted to leave quality of life as much as possible.

"We still need more advocacy campaigns on creating more awareness about this disease in various platforms that it's curable and preventable therefore people should visit hospitals" said Prof. Nagu.

She said that epilepsy affects about 50 million people worldwide and approximately six million new cases are diagnosed each year, making Epilepsy one of the most common neurological diseases globally.

"In our country, epilepsy prevalence is on average 20 to 37 per 1,000 people. This means over one million people living with epilepsy (PWE) in Tanzania. Furthermore, it is estimated that, the death rate for people with epilepsy is three times that of the general population in developed countries," added Prof. Nagu.

She said some factors for the high prevalence of epilepsy in the country is a high frequency of preventable causes including intrapartum complications, childhood infections and complicated childhood febrile seizures of which are age is highest in those aged 20-29 and another peak after 50 years, reflecting the large burden upon the economically productive age group where by both genders are equally affected.

She said that the theme for International League Against Epilepsy (ILAE) for the International Epilepsy Day 2024 is "My Epilepsy journey" and the country has stretched its journey to "The past, present and future of epilepsy in Tan-

'Create better environment to lure girls into science subjects'

EDUCATION, Science and Technology minister, Prof Adolf Mkenda has called for the need to improve the learning environment to encourage girls to develop interest in science subjects.

Prof Mkenda made the call in Arusha over the weekend during the International Day for Women and Girls in Science.

He noted that the number of girls and women taking science subjects is still low, calling upon stakeholders in collaboration with the government to address this challenge practically.

"We need to do anything possible to ensure

that more girls opt for science subjects or courses and we must promote those scientist women as a testimony to encourage girls to study science," he said.

According to him, there are still great employment opportunities in science fields so girls and boys have to opt for the subjects.

"We are currently reviewing the Science, Technology and Innovation Policy so that it gives us the direction as a country in this area,"

President of the Tanzania Nuclear Women Unit, Prof Najat Mohamed, who is also an expert in nuclear physics, called upon all stakeholders in collaboration with the government to empower girls to achieve their dreams.

Prof Najat urged teachers to inspire girls to acquire leadership positions and while at home they should also be given chances to speak as part of building their confidence.

Deputy Permanent Secretary in the Ministry of Education, Science and Technology, James Mdoe said the day started to be celebrated in the country at the national level in 2021.

He said as part of activities to celebrate the day, the Ministry visited primary and secondary schools to encourage women and girls to study science and to participate fully in the development of the country.

Mdoe said that about 10,000 secondary school students and 1,000 primary school students in nine regions were visited.

Jovian Mley from the Tanzania Gender Networking Programme (TGNP) said the development of science needs to go together with the training of the general public and young female pupils in primary and secondary schools.

Well used, e-procurement can uplift transparency, cut waste

POLICY makers in the Regional Administration and Local Governments ministerial "wing" of the President's Office are determined to oversee the modernisation of procurement in district councils or municipal administration.

The modality would entail the use of facilities in the National e-Procurement System of Tanzania (NeST).

NeST is described as an electronic system designed to facilitate various aspects of procurement - e-registration, e-tendering, e-contract management, e-cataloguing, e-auctions, etc., within the public service.

The state of adopting the method is somewhat perplexing, as shifting to such a system ought to be statutory if it is a matter of policy - with enforcement then following. This distinction was lacking in reported remarks from the PO-RALG minister of state in what appears to have been a promotional event. It was, to be precise, an award presentation ceremony organised by the Public Procurement Regulatory Authority (PPRA).

The minister appealed to other district leaderships to take a leaf from Kwimba District Council in Mwanza Region, which emerged the best in adopting the use of the new system.

It is not quite clear whether it was facilitation or mere temperament that hindered others from adopting the system - or whether it is that PPRA and the ministry are studying NeST use first. Even if the latter view of things was factually correct, it would not lead to an appeal to learn

This is essentially in that the point in the system is not to ease work in district and municipal councils but to trim losses often resulting from sabotage or corruption. If this aspect of things counts for considerable lack of will to adopt the new system, a stream of appeals will not do where regulatory prerogatives

It all implies that PPRA and PO-

RALG ought to first determine how far the required outlays are within reach in the various districts. At that point it would then become mandatory, not something to be promoted but enforced. For PPRA to set out NeST as a tool to enhance transparency, accountability and value for money, where public institutions are sure to increase efficiency by investing in electronic systems could have understandably raised eyebrows.

Indeed, it could have been taken for an advisory from an expert panel. literally for the benefit of the districts themselves. Those targeted could look at policy loopholes to figure out how much more time they could wait, procrastinate, before eventually having to adopt the system, and we believe PPRA knows this.

While one may be asked for evidence in making certain suggestions in a routine manner, it is plausible to suggest that PPRA and PO-RALG are moving cautiously aware that it might not be much to the liking of the targeted entities. Unlike enforcing the use of electronic fiscal devices at fuel filling stations, for instance, here there are issues related to 'proximity' with major upcoming political development.

In a word, the idea is not bad but administrators will likely to have to move carefully and perhaps move to institute regulatory premises for NeST at a most appropriate time.

Top officials at the ceremony commended Kwimba District for a job well done in adopting and making effective use of e-procurement, a rural administrative entity overtaking better-placed urban accounting

However, maybe they ought to have thought a bit harder and longer of the likely fallout from regulatory instruction, and thus enforcement.

We believe that they too are fully aware that e-procurement can uplift transparency and cut waste but only on condition that it is put to good use.



Death, exhaustion and suspicion: Journalists on horrors of Gaza (1)

EVERY DAY since October 7, 2023 AFP's team of journalists in Gaza has been risking their lives to cover a war that has shaken the world. They have all had to flee their homes, working without respite in the shadow of death in a territory they are not allowed to

Here the eight staff still in Gaza tell of the horrors they have witnessed, the threat of becoming targets themselves, and their determination to document this relentless conflict.

Most had covered half a dozen wars before October 7 and, as Gazans, had They were used to having to visit Bassam/SIPA/Rex/Shutterstock the morgues to count the dead and the endless funerals. But their lives changed forever when 1,160 people mostly civilians - were killed in the unprecedented attack by Hamas militants on Israel, according to an AFP count based on official Israeli figures.

"I was outside around six in the morning when I heard explosions that seemed to be coming from everywhere. We were trying to work out if they were Israeli bombardments or Hamas firing rockets," recalled Adel Zaanoun, who has been an AFP journalist in Gaza for

He narrated: "I called all my AFP colleagues to meet up in the office... On the road I rang all the spokesmen of Hamas and Islamic Jihad. They said they didn't know anything. Finally one of them said that the 'Qassam Brigades (Hamas' armed wing) were going to put out a statement'. A little later a communiqué from their chief Mohammed Deif announced that 'Operation Al-Aqsa Flood' had started."

More than four months on, the Gaza Strip has been devastated, with the humanitarian situation there catastrophic. Israel, which has vowed to wipe out Hamas, has been pummelling the territory, with the Palestinian death toll now at more than 27,800, according to the Hamas-run health ministry.

Nothing left but rubble

When humanly possible, AFP's reporters, photographers and video journalists rush to the scene of every new strike.

And every time, beyond the danger of a secondary strike that might kill them, they are faced with the pain, anguish and sometimes the anger of survivors. The horror of mutilated bodies, often of small children, has to be witnessed, described, photographed or filmed.

"If the internet is working, journalists exchange information on the location of the latest strikes on WhatsApp. If the network is down we try to follow the sound and once we are in the area

people guide us," said Mohammed Abed, an AFP photographer in Gaza for 24 years.

But getting around is not easy. With nearly two million people displaced, most now sheltering in Rafah, "there are traffic jams everywhere", he said.

"You have to weave your way through the waves of the displaced, through tents and stalls set up in the middle of the road. Whole districts have been razed with nothing left but rubble," noted Abed.

Meanwhile, Zaanoun said that one litre of petrol can cost US\$45," adding: "So sometimes we would rather walk for an hour than take a car, because we don't know if we will get petrol tomorrow when there could be a more important journey to make.

The news and images gathered on the ground are sent to AFP's editors based in Nicosia in Cyprus, the agency's Middle East headquarters, where they are verified before being sent out to media across the world.

Our boundlessly inventive technician, Ahmed Eissa, found solar panels to recharge cameras and computers and ingenious work-arounds for power and internet cuts. He did so amid so much danger and destruc-

Watching 'Gaza disappear'

Determined as they are, there is no hiding the exhaustion. "We have been working 24/7 for four months," said Zaanoun.

He elaborates: "But we must because what we are watching is Gaza disappearing in front of us. Its homes, its historic heritage is being destroyed, its people are dying; everything is going up in smoke under the Israeli strikes. Nowhere is safe... I have seen children going out under the bombs to rummage through bins in the hope of finding a bit of bread. Their lips were cracked; you could see they had not drunk any water in

a long time..."

Mai Yaghi too has had to face down exhaustion and a sense of powerlessness. When some cast doubt on the Hamas health ministry toll of the number of Gazans killed, Yaghi - an AFP reporter in Gaza for 16 years went around the hospitals herself to investigate. She got officials to show her the computer system where the victims are counted: in one column those killed in the war, in the other those from natural causes.

She narrated: "Because of our work, we see more horrors than anyone else. It is our duty to recount the suffering of people. But when you immerse yourself in it, you realise how enormous it is for us as well. and how powerless we are."

Zaanoun said that when the war started, the AFP team hoped that it wouldn't last long and that life would go on despite all, as it had during past conflicts.

But very quickly "the horror and the danger took over: the strikes from the air, the sea and the land intensified. We had never seen it like this before.

It became particularly difficult to work when Israeli forces ordered the entire population in the north of the Strip including Gaza City, where almost all AFP journalists lived, to move south.

Not only had the journalists to abandon their homes on October 13, but they had also to leave the AFP office, one of the rare international media bureaus in Gaza.

Three weeks later came another bitter blow when the office - a second home for many - was badly damaged in a strike. Shortly later, the camera on the bureau's balcony, which had been transmitting live images since the start of the war to the world's media, stopped working.

'Colleagues dying in front of you' Since Israel placed the Gaza Strip

under a "total siege" on October 9, AFP journalists in Gaza have been cut off. Unlike during some previous conflicts there, no colleagues from Jerusalem or other AFP bureaus across the world have been able to come to back them up. Even calling colleagues in Jerusalem, with whom they always work closely, has become difficult.

Not a single AFP journalist has been allowed to leave Gaza despite numerous appeals to the Israeli authorities, and they feel caught in a

Their fears have not been helped by the number of Gazan journalists already killed in strikes. So far 85 journalists and media professionals have been confirmed dead, according to the Committee to Protect Journalists (CPJ) in their latest toll to February 7.

"One day, there was a strike that claimed the lives of several colleagues, not far from me," said Zaanoun, adding: "Imagine your friends, your colleagues, dying in front of you. Imagine being woken up by the noise of an enormous bombardment, seeing human remains flying in every direction, the tent over your head collapsing and a tonne of dust and sand falling on

"We all know that, at any moment, it could be one of us," Zaanoun said, adding: "Our families know it too. They are panicking. When the telephone works, our wives and our children call us all the time to ask where we are, and what we are doing. They tell us not to be away from them for too long, to be careful. Because they know that wherever we go we are heading to the heart of death and they hope we will sur-

Since the Israeli army told AFP they cannot "guarantee the security" of the agency's journalists in Gaza, all feel under threat.

"Wearing a flak jacket with 'PRESS' on it doesn't protect you. We risk being killed at any moment," said photographer Abed.

Yahya Hassouna, an AFP video journalist in Gaza since 2009, remembers one strike in October in Gaza City: "Residents of a building had been warned that it would be bombed. We set ourselves up with other video journalists under the porch on the building opposite. A few minutes later, it was our building that was targeted. Three of my colleagues were killed."

Vatican dialogue with Africa fruitful, despite cultural gaps

EXCEPT for the fact that we are a nation in mourning following the death of former prime minister Edwards Lowassa, expectations would be high for the scheduled talks between Pope Francis and President Samia Suluhu Hassan to be warm and exciting.

A major reason for the optimism is that there are plenty of areas of understanding which can actually be reinforced, and some issues that aren't unique to Tanzania.

All these would likely to be taken up in other spheres of discussion, as the president would first have a private audience with the Vatican Head of State, followed by an apostolic audience with the Tanzanian delegation.

President Samia will thereafter proceed with a two-day visit to Norway, where the working atmosphere will be a lot more ordinary than the Vatican portion of the European tour.

On the basis of reforms that the president has spearheaded since assuming office in March 21021, and even in the past six months so to speak, there aren't contentious issues that the Tanzanian delegation may expect to face

There were issues on environment and measures of various sorts that are often contested in the European Union but, with farmers blocking roads to protest the removal of diesel price curbs, reality has been altered.

Leaders of church associations accompanying the president are drawn from associations and missions, of the local church.

These include nationwide vouth, men and women wings, according to a ministerial statement on the visit.

How much this is usual or an innovation is debatable, but there seems to be an innovative element, as Africa mostly respects state-to-state relations, while summits are commonly held with community leaders.

This time around the president wants them to actually take up the church and community viewpoint to the top of the Vatican hirearchy.

Current disputes within the church which have also been the subject of extensive commentary and at some points legal initiatives in African countries could in a way surface with the community delegation. But chiefly as a matter of courtesy or respect, they can skip

The Vatican will evidently have some ideas on how the Church can do more to propel and promote peace and harmony across the continent, particularly with regard to notorious hotspots.

Pope Francis once went way far beyond what critics may have wrongly - viewed as his call of duty in the course of a visit to South Sudan. He stooped to kiss the feet of warring leaders President Salva Kiir and his perennial rival, Dr Riek Machar.

But continuing to entertain warmongering or actual bloodshed after that kind of emotionally moving appeal would surely place Africa in a patch it should have long abandoned.

Peter Oloya: The Ugandan LRA child soldier who moulded a new future in art

HE joy former child soldier Oloya Peter finds in sculpture was first sparked while hunting for clay with his grandmother in northern Uganda - an area that became infamous for the terrifying raids led by the Lord's Resistance Army (LRA) rebel group.

grandmother showed me where clay is, what type of clay to be used and why," says the Ugandan artist, who grew up in the village of Lemo Bongolewic in the district of Kitgum.

This was in the early 1980s before much of the population was herded into camps to save them from the attacks and abductions.

Oloya and his late grandmother, Helen Atoo Ocula, would often follow grazing cows as they made a beeline for moist spots under groves of certain large trees.

There was particular clay called 'punu' in Oloya's Acholi language. It was adored by the cows for its minerals - and by Oloya's grandmother because it was

made for cooking and to store water.

A young Oloya was mesmerised and inspired by how his grandmother's hands transformed the clay into beautiful pots.

He was especially enthralled by the designs she made on the pots using small tools. "It was only much later when I turned to art as a profession that I realised how artistic she was," he says.

Oloya is now one of Uganda's best-known sculptors - and a leading sculpture gallery in London is hosting an exhibition of his work this month.

He is also respected because he survived the horrors of being kidnapped as a child by the LRA, led by Joseph Kony, who is wanted by the International Criminal Court for war crimes and crimes against humanity.

The artist is most famous for his Crowned Crane, a bronze sculpture of the national bird and a gift in 2007 from Uganda to the late Brit-

"Pottery is very sculptural, and clay has been part of me since childhood," Olova tells the BBC.

As a child, Olova was sometimes mocked for making pottery with his grandmother - because it is seen by his Acholi culture as an occupation for girls and women.

"Instead, we need to think of the planet as a distressed child, who is asking to be carried, who is asking for our help."

Another striking piece - which is different to his usual work - is a woman's traditional dress that Oloya has made from bark cloth. Attached to the bodice are old mo-

Oloya uses them as symbols of modernity and plastic waste from focuses once again on outside Africa, which

contrast vividly with the organic bark cloth that comes from inside the continent.

"Much of our environment in Africa is not made in Africa. It is brought in and is rotting in Africa," says the artist.

"But I put the dead phones on the dress to give people hope - we can recycle things, we can reuse things."

Oloya also explores the theme of modernity in a series of different sized and shaped gourds, the woody fruit of the calabash trees.

He has burnt on to the surface of the gourds African decorative pat-

At first glance they look like the calabash used in many villages to store milk, oil or water. But on closer inspection, you can also see the logos of the giant global corporations that now dominate the drinks market in most African countries.

"I love art," Oloya says "because it has given me another language - to spark conversations.

Fashioning of a circular future for traditional and alternative leather



By Glenn Scherer

HE practice of turning animal skins into wearable goods dates back thousands of years. But until recently this global fashion industry largely followed a linear "take-makewaste" production model, with unsustainable tanning through finishing processes dependent on chromium salts and other polluting toxins, and requiring massive amounts of water.

Today, as the industry edges slowly toward circular principles, traditional leather products are being forced to compete with all manner of synthetics (some fossil fuel-derived), and others biobased (derived from sources as diverse as cacti and bananas, but often requiring plastic additives to achieve traditional leather's durability).

No matter: leather in all its forms remains a growth industry. In 2023, it was valued at \$460 billion globally, and expected to hit \$700 billion in worth by 2030 as demand surges and the range of synthetic alternatives expands.

Against this booming backdrop, critics argue that using skins provided by the global livestock industry is responsible for a litany of environmental supply chain problems, starting on ranches, moving through tanneries, and extending to leather's end of life.

Still, experts hold out hope that innovative circular solutions could create a far more sustainable traditional leather industry. Meanwhile, all manner of alternatives could lessen environmental harm, though these substitutes could come with their own cost, scaling, technical and environmental conundrums.

The limits of traditional leather's circularity claims

Leather advocates contend that products derived from livestock skins are inherently circular, turning meat industry "waste" into a valuable fashion commodity. Industry representatives even point to tanning as one of the oldest examples of "upcycling," or creative reuse, a pillar of the circular economy. Without leather production, they argue, many thousands of unutilized tons of hide would end up in landfills or incinerated.

"The majority of life-cycle assessment studies on leather production and use assume positive impact mainly because you are finding a reuse for a material that is often a by-product of animal breeding," notes Shahin Rahimifard, an industrial engineer and professor at the U.K.'s Loughborough University. "This assumption has swayed [views of] the overall environmental performance of leather because you are basically saying if I didn't use it, it goes into landfill."

Others argue that the meat and leather industries are inherently linked at the hip, that leather should be seen as a "coproduct" of the meat industry - sharing in the mutual responsibility for environmental harm

of Padova, points out that the narrative portraying the leather industry as circular and sustainable ignores its links to environmental harm all along the fashion supply chain. This includes potential deforestation in cattle-ranching hotspots such as the Amazon, methane release during cattle rearing, heavy resource use and high levels of waste, serious pollution of water and air, along with animal welfare concerns. In her view, "every company that uses leather should understand the supply chain, where it comes from, and mitigate the risks."

"The leather industry is as toxic to the planet as it is cruel to animals," according to Yvonne Taylor, vice president of corporate projects at PETA, the animal rights NGO. Shaping skins into leather relies on the use of harmful chemicals, toxic mineral salts, and other harmful substances, she adds. "Tannery runoff contains large quantities of pollutants such as lime sludge, sulphides and acids."

"Leather is not a 'by product' or 'leftover' of the meat industry, but a \$100-billion industry in itself; it exists because of demand, not due to [meat industry] waste [reuse] concerns," Taylor says

Others believe the industry as a whole gets a hard rap and emphasize how it is changing. "Like many other industries, leather is an input-intensive industry. It does require a lot of chemicals, water, and energy," says Fernando Bellese, WWF's senior director of beef and leather supply chains. "If you're not managing those things well it can lead to water pollution, air pollution, and so on."

But he adds that not all producers follow polluting practic-

es, and progress is being made in reducing impacts across some company supply chains. "If you look at the leading companies nowadays, they are very modern. They have high technology in terms of wastewater treatment, in terms of chemical management," says Bellese.

There are "gradients of maturity" within the industry," agrees Kim Sena, with Leather Naturally, an industry group. He points out that leather is far more durable than other fashion materials, slowing down textile consumption and disposal rates, if used wisely.

Implementing circular practices during production can reduce leather's environmental burden, according to experts. Recovering, reusing and reducing waste is a first step, says Marika Gargano, a researcher at Italy's University of Naples Federico II, whose work focuses on finding natural and biobased solutions within leather production.

A next step is "returning to original tanning methods," using vegetable tanning instead of chrome-based tanning. A recent study, notes that while both techniques have impacts, circular-based vegetable tanning (also dubbed green tanning), achieves "substantial impact reductions" of toxins and released CO2, while saving water.

However, significant barriers, especially involving cost, are impeding implementation of these sustainable solutions globally. Traditional leather is primarily produced in China, Brazil, Russia, India, Italy, South Korea, Argentina, and the U.S., all with varying levels of industrial sophistication, financial access, and environmental regulatory standards.

Likewise, "The concept of reusing, repairing, refurbishing and recycling leather products to extend their life cycles has not been well-established in developing countries."

In Paul's view, a range of industry actions will be required globally to address its large environmental footprint. Alongside needed circular solutions, these include treating wastewater efficiently, minimizing toxic chemical use, and developing "error-proof" management sys-

tems. Other experts emphasize a need for transparency and traceability to cattle ranches to address possible deforestation. A woman is

"The overall system should be monitored and audited as per local and international environmental regulations," Paul wrote in an email. And that "is not a one-time task. The industry should work endlessly to protect the environment."

Leading by example

The Scottish Leather Group is one company aiming to clean up leather's environmental image through its own example. The firm claims that its products have the lowest carbon footprint of any leather manufactured anywhere, achieved through a suite of circular production solutions developed over recent decades.

The company started with a desire to minimize waste, and to utilize all of the leather it sourced in a variety of final products, says Warren Bowden, head of innovation and sustainability at the company. "Historically," he says leather production has used "a linear approach ... with roughly 90 percent of the hide weight never ending up as leather."

The Scottish Leather Group aims at using everything – not only making leather, but also recovering unused raw material to be sold as biofuels or other products, rather than sending it as waste to a landfill. Anything that's not "recoverable saleable commodities" the firm uses as fuel in its leather factory, displacing fossil fuels, says Bowden. "That's a massive piece in terms of reducing the carbon intensity of the product."

The company has also engineered an innovative waste recovery system, taking back leather seats it has sold to airlines, for example, then shredding and burning them to "create the energy for the next set of [manufactured] leather seats," he explains. Though this energy recovery scheme is still relatively small scale, Bowden says the company ultimately plans to recover used leather to be refashioned into other materials. "All that leather must go somewhere. And for me, there's a massive opportunity to recover it, take it back and do something more interesting with it. That's where ... the future is."

Such solutions have so far enabled the company to slash its landfilled waste by nearly 80 percent. The goal, notes Bowden, is to reduce that to zero by 2025. Similarly, water use in manufacturing is down thanks to a treatment system that cycles used water back into production. That has slashed the need for water drawn from a private Scottish loch. "We found that by treating [water] to the point you could recycle it, you could significantly reduce the amount you're actually drawing," he says.

Leather alternatives and the trouble with plastics

While some long-established leather companies aim to reduce impacts and go circular, other firms and researchers are innovating to produce alternative fashion materials.

Jinali Mody, founder of the startup Banofi, for example, sees a sustainable alternative to leather in the millions of tons of banana waste produced in India each year. Her company purchases banana waste directly from smallholder farmers and fashions it into leather-like materials.

"We source our waste directly from the farmers and we provide them with additional income for their waste," she says. "These farmers typically would dump [the banana waste] or burn it."

Currently, Banofi's products consist of around 60 percent banana crop waste, 20 percent other "natural components," and around 20 percent synthetic additives, including recycled plastics

"We're extending the life of waste," Mody says, noting that at the laboratory scale, the firm's product has proven to be 100 percent circular because after its initial use, it can be reworked into harder materials, such as book covers.

According to Mody, her firm's banana leather outperforms both bovine and "vegan" leathers derived entirely from plastics such as PVC. In addition, Banofi requires vastly less water, and achieves roughly a 90% carbon reduction compared to animal and plastic-derived leather, while emitting no toxic waste during production, according to the company.

The future of leather

Steeped in history, the leather industry is changing fast, say analysts. But it's future is advancing in several directions at once, as some manufacturers bet that synthetic materials or plastic-free biobased materials will come to the fore, while others see big opportunities for a cleaner, nonpolluting and toxic-free hide-based leather industry.

In the end, all this diversity may triumph. "I do think we need many materials, we don't only need leather," to achieve sustainability says WWF's Bellese. "What doesn't make sense to me is to discuss not using leather while we are still raising cattle."

In his view, innovating with new materials is necessary. At the same time, the traditional leather industry needs to focus on raising cattle responsibly, replacing and reducing chemical use, limiting water utilization, introducing more renewables, and ensuring effective wastewater treatment. "There are solutions [already available] for all those things," he adds.

Some experts are cautious about exclusively backing leather alternatives because in the attempt to avoid traditional leather production environmental pitfalls, makers may exacerbate other problems. "I have a positive opinion about these [alternative leather] developments, as long as they are not fossil-fuel based," says researcher Mammadova. "Material origin is important, but so are the processes and the chemicals we use in producing leather, and thinking about end of life is essential if we're aiming for circularity."

The latest global tobacco report estimates that there are at least 37 million children aged 13-15 currently using some form of tobacco, with alarming levels of e-cigarette use among adolescents in some countries.

A range of factors, including potential overharvesting of papyrus (Cyperus papyrus) and the conversion of the swamps for agriculture and construction, threaten this remarkable ecosystem. In the shallow channels that wind through the swamps, some fishers use papyrus stalks to build fish traps. In the open wa-

ers cast nets into the lake. They fish for silver cyprinid (Rastrineobola argentea), catfish, tilapia and Nile perch – a harvest that includes introduced species that have thrived in the lake.

During the heat of the day, sand harvesters emerge from the papyrus swamps into the open lake. They climb into the water, often chest- or neck-deep, and fill their boats with sand. Then, using a wooden pole, they push their boats back along the chan-

Riding low, laden with hundreds of kilograms of sand, the boats are unloaded at a site where the owners await. Trucks from Kisumu pull up along the rutted dirt road, and more workers shovel the sand into the truck beds, so it can be hauled away for construction in the city. According to one boat owner, "This is our gold that God has given us."

At dusk, Emmanuelle Frederick Makokha swings his net through the air several times before casting it outward, so that weights on the end of the net sink down, pulling fish into the net; his cousin pilots the wooden boat. They say they fish in the evenings, often past dark.

As night falls, other fishermen eat their evening meals on the shore, before climbing into their boats, three or four people per vessel. Many will spend the whole night on the lake, laying out nets held afloat by strings of buoys that stretch hundreds of meters.

At dawn, they bring their boats to shore next to the papyrus swamps at Dunga Beach, where restaurant owners, merchants and others looking to buy fresh fish meet them.

Pringle's research finds that, since then, Lake Victoria's fishing economy has become more commercial, favouring those who can afford more expensive fishing gear and the cost of Nile perch sold at market value.

One of the most striking birds here, the papyrus gonolek, occurs deep in the reeds, occasionally venturing out to the edges. BirdLife International describes the gonolek as "confined to papyrus Cyperus papyrus swamps and beds, in meandering river valleys and along lake-shores." The BirdLife assessment suggests the brightly colored species is in "moderately rapid population decline owing to the on-going conversion and degradation of its wetland habitats."

Papyrus swamps also offer habitat for the vulnerable papy-

tides gracilirostris), which can be found in Dunga Swamp, a major papyrus swamp near Kisumu. BirdLife International includes natural resource use as a cause of deterioration of the Dunga Swamp Important Bird Area.

As well as providing habitat for fish and bird life, papyrus swamps rapidly take up nutrients and retain sediment, reducing their flow into lakes. Research published in the journal Wetlands Ecology & Management shows that in the right conditions, C. papyrus allows the development of significant detritus and peat deposits – storing carbon. Conversion to agriculture or development risks undermining these ecosystem services as well as biodiversity loss.

But research published in Biological Conservation has suggested that "low-intensity use of papyrus wetlands by people is compatible with the conservation of specialist bird species," especially when large areas of papyrus are protected. It adds that "conservation in tropical wetlands need not require complete exclusion of human resource use." Kenyan environmental scientist Leonard Akwany, a founder and member of the advisory board at Ecofinder Kenya, says papyrus harvesting should be "organized and planned."

Drivers of degradation and loss On the lush areas behind the papyrus swamps, farmers tend to their rice fields. Often, this is former swampland that's been drained, according to Akwany.

He says some people set the papyrus on fire to open up new areas for fishing or sand harvesting. Nicholas Oginga Toya, who lives next to a papyrus swamp, also worries about this burning, which prevents him and his family from harvesting papyrus reeds. Burning could also be a precursor to longer-term agricultural conversion.

Red Cross to grant 108mn/- to floods victims in Hanang

IN response to the devastating impact of heavy rains and mudslides in Hanang District, Manyara Region, in early December 2023, the Tanzania Red Cross Society (TRCS), will disburse 108mn/to supporting affected petty traders, in the recovery and revitalization of their busi-

DSE indicators gain on weekly basis, despite turnover decline

HE Dar es Salaam Stock Exchange (DSE) market indicators gained last week when compared to the previous week, despite of decrease in turno-

The weekly market reports show All Share Index (DSEI) and Tanzania Share Index (TSI), gained by 1.44 percent and 1.53 percent after closing at 1.764.65 and 4.381.71 points during the end of last week respectively.

The index for the Banking, Finance & Investment sector (BI) increased by 4.78 percent, reaching a closing value of 4,773.80 points.

Similarly, the Industrial & Allied (IA) sector index saw an increase of 0.12 percent, closing at 5,199.51 points. However, the Commercial Services sector experienced a slight decline of 0.08 percent, closing at 2,142.69 points.

saw a rise of 1.44 percent, reaching 14,728.54bn/-.

Similarly, the domestic market value edged up by 1.58 percent, hitting 11,606.16bn/-, after the moderate increases in the worth of both locally listed and cross-listed companies.

Top gainer was NICO, after its share price increased by 9.62 percent to 570/- at the end of last week, compared to 520/recorded during the end of the previous week, followed by CRDB Bank Plc, which its share gained by 7.53 percent, after closing at 500/- compared to 465/- respectively.

Cross listed East African Breweries Limited (EABL) and Jubilee Holdings Limited (JHL) also gained during the reviewed weeks after closing 4.55 percent and 4.93 percent up at the end of last week, compared to the previous week.

The market report shows EABL share price closed at 1,840/- on Friday's close, compared to The total market value 1,760/- while JHL share price increased to 2,980/from 2,840/-.

NMB Bank Plc, the second largest listed, in terms of market capitalization, also was on the gainers list, after its share price appreciated by 3.66 percent to 4,660/- at the end of last week, compared to 4,500/- recorded during the previous week.

DSE share price also increased by 1.1 percent, after closing at 1,820/- at the end of last week, compared to 1,800/- recorded during the previous week, followed by Tanzania Portland Cement Company (TPCC), which its share price slightly improved by 0.93 percent to 4,340/compared to 4,300/- respectively.

shows the cross listed KCB share price declined by 4.55 percent, followed by Swissport which depreciated by 3.23 percent and TCCIA Investment Limited (TICL), which its share price declined by 2.56

According to the DSE's The market report daily reports, CRDB Bank Plc counter recorded the trading of 14 million shares during last week whereby the majority of shares of the largest and most profitable bank were sold by foreign investors, of which all were absorbed by local investors, ahead of dividends announcement for 2023.

deals through both prearranged block trade and normal trade at a price ranging traded between 460/- and 500/-, the daily reports show.

The market reports also show since the start of the current quarter, foreign investors have sold shares valued 15.95bn/-, which is 60.67 percent of total value of shares sold, against 1.1bn/- in buying shares, which translates into 14.8bn/- net outflows.

The amount of shares sold by foreign investors is more than twice of the amount recorded during the whole first quarter of last year.

Market analysts are expecting continuing foreign investors' exits from the DSE and other Sub-Saharan African markets due to global economic factors, although this will not affect the stability of the market due to strong local investors' absorption capacities.

In the neigbouring Kenya, foreign investors pulled out Sh178.2 million (\$1.1 million) from the Nairobi Securities Exchange (NSE) in January, marking a fifth straight month of withdrawals and stretching a run of capital flight from the past year.

The continued foreign investor sell-offs in Kenya was linked to a disparity in returns where investments in advanced economies yield greater gains than those in emerging and frontier economies after notable interest rate increases by their respective Central Banks.

Last year, foreign investors remained net sellers at the NSE, marking Ksh21.2 billion (\$132 million) in net portfolio outflows, according to data from the Capital Markets Authority.

Barrick grows its reserve base for third successive year

NYSE- and TSX-listed Barrick Gold has reported growth in attributable proven and probable gold mineral reserves by five-million ounces before 2023 depletion, while also striving to maintain the quality of the mineral reserve base.

As such, the company's attributable proven and probable mineral reserves now stand at 77-million ounces at 1.65 g/t, compared with 76-million ounces at 1.67 g/t in 2022.

Led by the Africa and Middle East region, Barrick has managed to achieve a third consecutive year of organic gold reserve growth above yearly depletion.

The company's focus on driving geographical asset quality has allowed for the replacement of more than 140 percent of the company's gold reserve depletion since the end of 2019, adding almost 29-million ounc-

es of attributable proven and probable reserves or 44-million ounces of proven and probable reserves on a 100 percent basis, excluding acquisitions and divestments.

Barrick says successful drilling programmes at Lumwana, in Zambia, have driven the growth of proven and probable copper reserves by 330 000 t of copper in 2023, allowing the company to replace 124% of yearly global copper depletion at a consistent quality, effectively maintaining attributable proven and probable copper mineral reserves of 5.6-million tonnes at 0.39 percent in 2023.

Attributable measured and indicated gold resources for last year currently stand at 180-million ounces at 16 g/t, with a further 39-million ounces at 0.8 g/t of inferred resources. Attributable measured and indicated copper resources for 2023 stand at 21-mil-

Zimbabwe takes full control of state miner

IMBABWE'S state sovereign wealth fund has now acquired all of state mining company Kuvimba Mining House Ltd., in a bid to end speculation about its ownership.

Kuvimba holds some of Zimbabwe's best mining assets, which were once owned by a company controlled by US- and UK-sanctioned tycoon Kudakwashe Tagwirei, an adviser to Zimbabwe's President Emmerson Mnangagwa. The government has never given details of how they came to fall under its control other than to say they were acquired for an undisclosed amount.

Kuvimba was, in 2021, said by the government to be 65 percent state-owned with 35 percent of it being held by private investors, later described as a management consortium.

Mutapa Investment Fund, the sovereign wealth fund, initially took over the 65



percent held by the government and has now bought the rest, said Simba Chinyemba, Kuvimba's chief executive officer.

"The speculation was unhelpful and the fact that that speculation did not die out despite us presenting the evidence of the structure of

Oil prices slipped on Monday as investors indulged in some profit-taking after both benchmarks ended last week about 6 percent higher on Middle East tensions and as refining outages squeezed refined products markets.

Brent crude futures were down 82 cents, or about 1 percent, at \$81.37 a barrel, while U.S. West Texas Intermediate crude futures slipped 74 cents, also about 1 percent, to \$76.1 a barrel at 1022 GMT.

Last week, the major forces underlying the rally were the persistent threats to shipping in the Red Sea, Ukrainian strikes on Russian the U.S. and Britain. refineries and U.S. refinery maintenance, Tamas Varga of oil broker PVM told Reuters.

This has led to scarce availability of products, particularly in the middle of the barrel, he said.

"These factors have not subsided yet - and for this reason, I believe that what we see at the moment is only a retracement."

Logistics disruptions in the Red Sea continued on Monday, with Yemen-based Houthis saying they had targeted a cargo ship in the Red Sea, which they claimed was American.

Shipping trackers said the Marshall Islands-flagged ship was Greek-owned.

The Houthis have targeted shipping with drones and missiles since November in solidarity with Palestinians in Gaza. The United States has led retaliatory strikes on Houthi missile sites since January.

Private equity returns plunge to global financial crisis levels

PRIVATE equity funds last year returned the lowest amount of cash to their investors since the financial crisis 15 years ago, according to Raymond James Financial Inc., hampering buyout firms in their efforts to launch new investment vehicles.

Distributions to so-called limited partners totaled 11.2 percent of funds' net asset value, the low-

25 percent median figure across new money to the asset class. the last 25 years, according to the investment bank.

Higher borrowing costs, volatile markets and economic uncertainty have made it more difficult for private equity firms to exit their existing investments through sales or initial public offerings. This in turn has hampered their ability to return capital to pension and sovereign wealth funds, besides other key investors, meaning once-reliable clients are est since 2009 and well below the struggling to find cash to allocate

"The cash flow math at the investor level is broken," Sunaina Sinha Haldea, global head of private capital advisory at Raymond James, said in an interview. Because investors aren't getting money back from their existing holdings, they're hampered in their ability to put money to work in new funds or re-top existing investments, she said.

The median holding period for a buyout firm asset is now 5.6 years, according to Raymond

James, wider than the industry norm of about 4 years.

The impact on fundraising is already visible: The median time to raise a new fund is now 21 months, compared with about 18 months just a couple of years ago, according to the bank's research. And the number of new funds raised last year dropped 29 per-

"This is the worst-ever fundraising market, worse than even during the global financial crisis," Haldea said, adding that distribu-

tions will only likely improve in For years, pension funds could 2025 as the "tidal wave" of dealmaking forecast for this year is yet to be seen.

Still, the aggregate capital raised last year by buyout funds reached a record \$500 billion, up 51 percent from 2022, driven by the biggest funds, Raymond James said.

A glut of fundraising in 2021 is also weighing on investors' ability to commit to new funds, especially as the go-to private equity pitch of outsized returns is faltering.

Syria's Assad warns of worsening crisis amid US attacks in Mideast

DAMASCUS

SYRIAN President Bashar al-Assad on Sunday expressed concerns that Washington's attacks in different parts of the Middle East threaten to expand the conflict in the region, the state news agency SANA reported.

In a meeting with visiting Iranian Foreign Minister Hossein Amir-Abdollahian in Syrian capital Damascus, Assad criticized the United States for its approach to the ongoing Israeli military campaign in the Gaza

He expressed concerns about Washington's ongoing provision of "lethal weapons" to Israel and its military operations in various parts of the Middle East, saying they pose a risk of escalating the conflict

During the meeting, Assad highlighted the need for offering maximum support to the Palestinian people, commending their resilience during the recent Israeli attacks on Gaza.

Assad also discussed with Amir-Abdollahian the Israeli attacks on Syrian territories and the overall regional developments, according to SANA.

They stressed the importance for international institutions. particularly the UN Security Council, to take immediate action to halt the looming Israeli

assault in Rafah, the southernmost Gazan city currently sheltering more than half of the displaced Palestinians in the enclave.

Also on Sunday, Syrian Foreign Minister Faisal Mekdad reiterated that Syria's top priority is to defy the presence of any unauthorized foreign forces on

At a joint press conference with his Iranian counterpart Amir-Abdollahian in Damascus, Mekdad said it is a priority of the Syrian leadership to end the Israeli occupation of the Syrian Golan Heights.

Another top task is to "liberate" occupied territories in eastern Syria from American forces and those in northern Syria from the Turks, he noted.

On Israel's repeated attacks on Syria and the repercussions of such actions, Mekdad said "Syria has fought several wars against the racist Zionist entity and is fully prepared to engage in any other wars in which Syria determines when, where, and how."

For his part, Amir-Abdollahian said Tehran condemns the "illegal presence" of foreign parties in parts of Syrian territory.

He noted that Iran's military advisors will continue to support Syria despite recent reports about a possible withdrawal of Iran's military advisors in the wake of repeated Israeli attacks on their positions.

The minister also revealed that he conveyed an invitation from Iran's President Ebrahim Raisi to Syrian President Bashar al-Assad to visit Iran.

Kremlin Spokesman reveals main goal of Putin's interview for Carlson

MOSCOW

RUSSIAN President Vladimir Putin's interview for Tucker Carlson was addressed not to US authorities, but to a wide audience of people in the West, Kremlin Spokesman Dmitry Peskov said.

In a conversation with TASS, he disclosed what exactly the Kremlin considers the main result of this interview and assessed the level of attacks on Russian IT systems during the past two years.

On millions of views

- In the first 24 hours, the interview was viewed for over 150 million times on the X platform alone. But a wide interest of the audience does not mean support, the Kremlin notes. "The most important thing for us is to make our president heard. If he is heard, then more people will wonder whether he is right or not. At least they will think."

- It is difficult for Russia to stand against the US "in terms of propaganda," because the "Anglo-Saxons own all largest broadcasters, all main newspapers in one way or another." In these circumstances, the interview for Carlson "is a very good opportunity" to convey Moscow's position to the people.

On relations with US


- The US authorities are "well aware of Putin's key messages" even without the interview, Peskov noted. "They are well aware of what he thinks. It is not an issue of knowledge, but an issue of desire. A desire to do something to enter the negotiations track. We see no such desire and political will [in the US] so far."

On attacks on Kremlin website, other systems

- Peskov was unable to tell if the interview sparked special attention of hackers to the Kremlin official website, where the interview was published soon after it was published on Carlson's own resources. "There are dozens of attacks on the Kremlin website every day. Everyday throughout the year. Sometimes, there are strong DDoS attacks, and sometimes, there are attacks that aim to seize control over the website and so on. Therefore, our agencies work around the clock, ensuring proper security and integrity of the website.

- The Kremlin also finds it difficult to assess whether external attack on Russia's IT and other systems have increased ahead of the presidential elections. "This is because the attempts to breach our various systems, both in the Internet and in other areas, have been at the maximum level for the past two years; I simply cannot differentiate if this is connected to the elections or not. They [attempts] do not stop."

Putin's interview for Tucker Carlson was published on February 9. A significant portion of the two-hourlong conversation was dedicated to the Ukrainian conflict, Russia's relations with the US, NATO and the West in general. Previously, the journalist said that he already tried to have an interview with Putin one year earlier, but US authorities prohibited it.

He'll have bilateral meetings with President Sheikh Mohammed bin Zayed, as well as with the Vice President, Ruler of Dubai, the Prime Minister, and Sheikh Mohammed bin Rashid in Dubai."

Sunjay Sudhir stated that PM Modi will also address the World Government Summit in Dubai. He further stated that PM Modi will be addressing the Indian community in Abu Dhabi and will inaugurate BAPS Hindu Mandir in Abu Dhabi.

He further said, "On the substantive side, you'll see once the visit starts that there are a lot of very significant documents that will be signed and exchanged, including some treaties, some agreements,

The Indian envoy recalled PM Modi's first visit to the UAE in 2015, which he stressed was the first visit of PM Modi after a gap of 34 years. He said that the ties between India and the UAE have grown very well and noted that the two nations signed the Comprehensive Economic Partnership Agreement (CEPA) in 2022. Asked how the upcoming visit

of PM Modi will enhance bilateral ties between the two nations, he responded, "PM Modi's visit in 2015 was the first visit of an Indian Prime Minister after a gap of 34 years. And since then, the visit, which is going to happen less than 48 hours from now, would actually be his 7th visit. So this speaks of how accelerated our relations have been in the last 19 years."

"In 2017, we signed a comprehensive strategic partnership agreement. And I think, in all dimensions, this relationship has grown very well. We signed the CEPA in 2022. Within less than two years of that, we are going to sign a bilateral investment treaty, and that will make the UAE the only country with which India has both a CEPA as well as a bilateral investment treaty. And then, if you look at other areas like FinTech, just about two weeks ago, the UAE launched its own Jeevan credit and debit card and that card is entirely based on India's tried and tested robust Rupay debit and credit card stack," he added.

WHILE specialty coffee from Africa is gaining popularity among consumers across the world, officials of the African Fine Coffees Association (AFCA) have urged African coffee traders to boost value-added coffee export, and cease export of unprocessed coffee to the international market.

The remark came during the 20th African Fine Coffees Conference and Exhibition and the First African Coffee Week that took place from

Feb. 6 to 10 in Addis Ababa, the capital of Ethiopia, with the aim of advocating the export of value-added coffee from Africa.

The event has brought together more than 800 regional and international coffee roasters, traders, producers, buyers and professionals to discuss policies, sustainability, access to finance and international market regarding coffee industry.

Amir Hamza, chairperson of the AFCA, said coffee exporting African countries need to concentrate on value

addition and apply better marketing strategies to boost their earnings from the coffee export.

"The biggest problem Africa is facing is poor marketing approaches and export of unprocessed coffee, something the AFCA is trying to solve. Africa has the best coffees, but they are not marketed as they should be," Hamza told Xinhua in an interview.

He encouraged African coffee exporting companies to intensify trade promotions, broaden markets while concentrating on quality raising and processing to meet the demands of importing markets and to establish brands for sustainable exports. "After the green beans are exported from Africa, they will be blended and roasted by companies outside the continent, particularly by those companies in Europe and the United States and then they will be sold in the Middle and Far East as coffee products from other ori-

gins," he said.

According to data obtained from AFCA, coffee exports from Africa were valued at over 3.6 billion U.S. dollars in

Ethiopia was the leading exporter, earning around 1.5 billion U.S. dollars, followed by Uganda with an export value of nearly 813 million U.S. dollar during the same year. The chairperson urged the coffee industry in Africa to shift its focus to improving product quality and align-

ing with market taste trends, especially in the major coffee consumption markets, which account for around half of global coffee imports, including the EU and the U.S. Hamza said the expanding inter-Africa trade would give one of the best opportunities for African coffee producing countries to fetch better income from their coffee exports in the coming years.

According to AFCA, noncoffee producing African countries such as Egypt, Sudan, Libya, Algeria and Morocco as well as Nigeria and South Africa will be the most important destinations for the coffee market in Africa.

Speaking about forthcoming European Union's Deforestation Regulations (EUDR), a move that threatens a significant portion of coffee exports to the economic bloc, Hamza said Africa imports more volume of coffee than it exports and he believes that the regulation would little affect Africa's coffee export.

US defence giants fatten wallet amid Ukraine, Gaza conflicts

WASHINGTON

U.S. defense giants are faring well amid heavy government demand for military aid to Ukraine and Israel. Experts expect this to continue in 2024.

"The Pentagon's increased demand for goods and services from U.S. defense companies has likely improved their potential profits," William Courtney, a retired U.S. ambassador and adjunct senior fellow at the RAND Corporation, told Xinhua.

"Since most of the fight involves ground operations, U.S. and other Western producers of equipment, ammunition, and other supplies for ground forces, including groundbased air defenses such as the Patriot, may have benefitted the most," Courtney said.

The latest round of the Israeli-Palestinian conflict is in its fourth month, with the death toll in Gaza exceeding 28,000 and continuing to rise. On the other side of the world is another data set. Major U.S. arms dealers recently released their financial reports for the fourth quarter and full year of 2023.

Sales of defense company Raytheon, or RTX, were close to 20 billion U.S. dollars in the fourth quarter, exceeding the third quarter and up by 10 percent compared to the same period last year.

A recently released financial report saw defense firm Lockheed Martin's fourth-quarter profits beat analysts' estimates.

The company's stock price surged at the outset of the Ukraine crisis from around the 400 dollar-pershare mark to nearly 500 dollarper-share in less than a year and is at around 426 dollars a share at the close of trading on Friday.

Northrop Grumman stock hovered around the 400 dollar-per-share mark when the war in Ukraine broke out in February 2022. Shares surged to a high of around 545 dollars per share before dropping to 455 dollars by Friday. Still, analysts said the stocks have much upside potential.

Aerospace and defense giant Boeing said in November 2023 that it

would ramp up production capacity in its Huntsville factory for sensors used to guide Patriot missiles. The firm reported that the facility will enable Boeing to boost annual production of PAC-3 seekers by over 30 percent.

According to the Defense Post, U.S. weapons behemoth Lockheed Martin is increasing production of GMLRS, a type of GPS-guided rockets that carry 90-kilogram warheads -- from an annual 10,000 to 14,000 units.

These are heavily used in the Ukraine crisis. The excellent performances in the fourth quarter are primarily attributed to the continuous supply of weapons and ammunition provided by American military-industrial giants to Israel with the support of the govern-

The Israeli Air Force uses many air-to-ground missiles produced by Raytheon, while Boeing provides Israel with a large quantity of Small Diameter Bombs, Joint Direct Attack Munitions kits, and more. Lockheed Martin also supplies Israel with "Hellfire" missiles. According to Bloomberg, just over a month after the conflict in Gaza began, around 2,000 "Hellfire" missiles were shipped from the United States to Israel.

The United States is Israel's largest military aid provider. Considering strategic interests, domestic politics and other factors, the United States has provided Israel with over 130 billion dollars in security and weapon aid since its founding in 1948, with approximately 80 percent of Israel's military equipment imports coming from the United States. In recent years, the United States has provided Israel with about 3.8 billion dollars in military aid annually.

The Biden administration recently asked Congress for additional aid to the country. Lockheed Martin, Raytheon and General Dynamics all reported record levels of unfilled orders in their financial reports, indicating strong potential for future performance

While some experts don't believe defense companies drive U.S. strategy significantly, others highlighted the military-industrial complex, in which political donations, lobbying efforts, stock holdings and other interconnections form a complex chain of interests.

Over the years, senior U.S. officials and high-ranking military officers have frequently moved between the political, military and defense industry realms through a "revolving door," engaging in commercial activities upon exiting public service and assuming official positions after being involved in business, resulting in collusion between government and business and shuttle profiteering.

Several senior officials in the Biden administration have had close ties to defense contractors, with Secretary of Defense Lloyd Austin being a former board member of Raytheon, Secretary of State Antony Blinken providing policy consulting for Boeing Corporation and National Intelligence Director Avril Haines serving as an advisor to Palantir Technologies, which provides artificial intelligence support to the military.

This traditional "revolving door" practice has taken on new forms recently.According to a recent report by The New York Times, over the past five years, at least 50 U.S. national security officials, including former Secretary of Defense Mark Esper and former Secretary of the Army Ryan McCarthy, have entered the venture capital and private equity industries after

They regularly interact with Pentagon officials or members of Congress, lobbying to promote specific policies or increase defense spending, thereby benefiting the companies in which they have invested.

Even members of Congress benefit from regional conflicts. Two days before the escalation of the Russia-Ukraine conflict in February 2022, Republican congresswoman Marjorie Taylor Greene purchased shares in Lockheed Martin Corporation, after which the stock price

However, on social media, Greene displayed a stance of indignation towards those who advocate for war. "War is big business to our leaders," she said. Her words and actions exposed the hypocrisy of American politicians and the true nature of the American military-industrial complex.

Following the Oct. 7 Hamas surprise attack, U.S. policy is in many ways captive to immediate Israeli reactions, and U.S. defense contractors are a subordinate part of that, Clay Ramsay, a researcher at the Center for International and Security Studies at the University of Maryland told Xinhua.

Both congressional Democrats and Republicans agree on providing more funding for Ukraine and Israel. Still, a substantial group of House Republicans are against increasing aid to Ukraine.

Meanwhile, a growing number of Americans want less involvement in the Russia-Ukraine conflict, and some even fear the United States will send troops to fight. The enormous U.S. military expenditure is a reminder of the warning issued by former U.S. President Eisenhower in the 1950s: "Every gun that is made, every warship launched, every rocket fired signifies, in the final sense, a theft from those who hunger and are not fed, those who are cold and are not clothed." Russia submits to Canada extradition request for Ukrainian SS veteran Hunka – ambassador

OTTAWA

THE Russian Embassy in Canada has submitted an extradtion request for 98-year-old Ukrainian Nazi war veteran Yaroslav Hunka (Gunka), and is now waiting for the response from the Canadian Department of Justice, Russian Ambassador to Ottawa Oleg Stepanov told TASS.

"On December 19, 2023, we submitted to the foreign ministry of Canada a request by the Russian Prosecutor General's Office to extradite Yaroslav Gunka to Russia. The note says that he is under a criminal investigation by the Russian Investigative Committee, in connection with actions aimed at total elimination of an ethnic group, or, in short, genocide," the diplomat said.

Stepanov said Canada and Russia had no extradition treaty. However, the two states signed a Treaty on Mutual Legal Assistance in

"It is a matter of principle. In fact, Gunka himself acknowledged that he had joined SS voluntarily and, therefore, was involved in the crimes of SS Division 'Galicia.' So, a Nazi is living here. Does the Canadian justice plans to prosecute him here? That's the question," the ambassador added.

The Canadian Department of Justice said it would not comment on whether it received the request for Hunka's extradition, because such documents are deemed confidential until the court verdict is pronounced.

The department said that extradition from Canada is carried out in accordance with relevant domestic laws, international treaties and the Canadian Charter of Rights and Freedoms. It also emphasized that Russia and Canada have never signed an extradition treaty.

Earlier, the Russian Investigative Committee charged Hunka in absentia for genocide of civilians on the territory of Ukraine during World War II.

The investigators obtained documented confirmation about deployment locations and operations of the SS Division "Galicia," where Hunka served, from the Russian Defense Ministry's Central Archive and the National Archive of the Russian Federation.

A Nazi in Canadian parliament

On September 22, during Ukrainian President Vladimir Zelensky's appearance before the Canadian Parliament in Ottawa, the audience gave two standing ovations to invited guest Yaroslav Hunka, a 98-year-old Ukrainian emigre who in 1943 had volunteered to serve in the Nazi 14th SS-Volunteer Division "Galicia."

On September 26, Canadian Foreign Minister Melanie Joly called for the resignation of House of Commons Speaker Anthony Rota, who had introduced Hunka to the audience, praising him as a war veteran who fought "against the Russians" during World War II.

Joly called the incident "absolutely unacceptable" and "a disgrace to the House [of Commons] and to Canadians." Rota subsequently tendered his resignation. On September 27, Canadian Prime Minister Justin Trudeau formally apologized for the incident.

The Russian Foreign Ministry said that the public praise of the Nazi "epitomizes the ruling regime of Prime Minister Justin Trudeau to a T," declaring that Russia does not intend to "tolerate the way Canadian liberals flirt with **Agencies**

Ivory Coast AFCON triumph 'more than a fairytale' for coach Emerse Fae

ABIDJAN

IVORY Coast coach Emerse Fae toasted his team of "miracle survivors" after the host country completed one of the greatest turnarounds in major tournament history to win the Africa Cup of Nations by beating Nigeria 2-1 in Sunday's final.

"It is more than a fairytale. I am struggling to take it all in," Fae said after Ivory Coast recovered from behind at half-time at the Ebimpe Olympic Stadium to win thanks to goals by Franck Kessie and Sebastien Haller.

"When I think about all we have been through, we are miracle survivors. We never gave up and we managed to come back from so many tough blows."

Sunday's victory before an official attendance of over 57,000 in Abidjan allowed the Elephants to win their third continental title.

They are the first host country to win the Cup of Nations since Egypt in 2006, and yet they very nearly went out in the group stage.

The Ivorians lost 1-0 to Nigeria in their second match before losing 4-0 to Equatorial Guinea, their heaviest-ever home defeat.

That made them the first AFCON hosts in 40 years to lose two group games and cost coach Jean-Louis Gasset his job.

However, they squeezed into the last 16 as the last of the four best third-placed teams, with former player Fae taking over on an interim basis.

Ivory Coast beat holders Senegal on penalties in the last 16 after equalising late in normal time. They beat Mali 2-1 in the quarter-finals with a winner in extra time, having been reduced to 10 men in the first half and trailing into the 90th minute. That was followed by a 1-0 victory against the Democratic Republic of Congo in the semi-finals, before another comeback win in the final.

"All our games were difficult. We kept having to come from behind and we really had to draw on all our physical and mental reserves," observed Fae, who turned 40 on the day he became coach.

"I can't properly express my joy. It is massive. I dreamed of winning the AFCON as a player and didn't manage it," added Fae, who played in the side beaten by Egypt in the 2006 final.

"Now I have had the opportunity as a coach, albeit in strange circumstances. I took over when we were not even sure of getting out of our group. It was a strange birthday but thankfully we got a second chance and grabbed it."

The story of Haller's own tournament was remarkable too, with the Borussia Dortmund striker scoring the winner in the semi-final and the final.

He was almost substituted moments before turning in Simon Adingra's cross for the clinching goal in the final.

Africa Cup of Nations: A to Z of dramatic tournament

A GOAL glut, shocks galore, a Moroccan redcarded twice, an astonishing comeback by hosts Ivory Coast to win Sunday's final after two group losses. The 2024 Africa Cup of Nations had it all.

Here, AFP Sport realphabetically calls some of the drama from a 24-nation tournament regarded by many observers as the most exciting since the event debuted in 1957 in Sudan with just three

Quarter-finalists Angola were a revelation under coach Pedro winning Goncalves, three matches in a row having failed to achieve more than one victory at a time in eight previous appearances.

AFCON-winning coach Djamel Belmadi was fired after Algeria flopped, with a loss to minnows Mauritania leading to a firstround exit for the Riyad Mahrez-captained side.

Champions Coast started the fi-

nal with three players based in Saudi Arabia. two each in England, Germany and Turkey, and one each in France and Italy.

Democratic Republic of Congo coach Sebastien Desabre set a minimum target of a quarter-finals place and went one stage further with a hard-working team well led by centreback Chancel Mbemba.

Energy-sapping conditions forced water breaks in each half of matches, with many kicking off in 36 degrees Celsius (97 Fahrenheit) heat and high humidity.

Former international Emerse Fae replaced sacked Ivory Coast coach Jean-Louis Gasset after the group stage without ever having been in charge of a senior team and guided them to the title.

A record 119 goals for a 24-team AFCON tournament were scored in the Ivory Coast -- 17 more than in Egypt five years ago -- at an average of 2.28 per match.

Paris Saint-Germain Achraf Hakimi missed a penalty as shock 2022 World Cup semi-finalists Morocco bowed out in the round of 16 after a 2-0 defeat by South Africa.

A hamstring injury midway through a second-round group match against Ghana forced Egypt talisman Mohamed Salah out of the tournament. Without him, the Pharaohs old who plays in the made a last-16 exit.

A private jet took United Manchester goalkeeper Andre Onana to the AFCON, but Cameroon coach Rigobert Song was not impressed by his late arrival and used him only once in four matches.

West Ham star Mohammed Kudus could not prevent a second straight disastrous campaign by Ghana, whose first-round departure led to former Premier League manager Chris Hughton being axed.

Ademola Lookman played a key role as eventual runners-up Ni-

geria reached an eighth AFCON final, scoring twice against Cameroon and the winner against Angola in knockout matches.

Sadio Mane and Senegal made an ultimately disappointing title defence. After a perfect three-win group record, they lost a last-16 tie on penalties to resurgent Ivory Coast.

Emilio Nsue,a 34-year-Spanish third division, scored a hat-trick against Guinea-Bissau, the first at an AFCON since Moroccan Soufiane Alloudi in 2008.

Reigning African Player of the Year Victor Osimhen may have scored only once for runners-up Nigeria, but his work rate in searing heat and constant harrying of defenders won rave reviews.

Some Premier League players, including Yves Bissouma of Mali and Dango Ouattara of Burkina Faso, did not have the expected impact due to illness and



Having put on a brave face for so long, this was the moment when his torturous twovear journey to the Elephants' tumultuous triumph really hit home and emotions understandably overwhelmed

And now here he was, pitchside in Abidjan's Alassane Ouattara Stadium, witnessing the fevered celebrations after his goal gave the Elephants a 2-1 win over Nigeria and a third Nations Cup title.

"We dreamed of this moment so many times," Haller

His winning goal, a brilliant flicked finish from Simon Adingra's cross, came just four days after Haller had also proved to be the matchwinner in the semi-final win over DR Congo.

"I am so happy for Haller," former Ivory Coast international Kolo Toure, once of Arsenal and Manchester City, said on BBC Three.

"He went through a tough time but he did unbelievably for the team. He is a humble man, and he works hard for the team. He is just some- claim, as he was buried be- took all his words for grantone who wants to help his team-mates.

But, in many ways, it was also amazing that he was even on the pitch - as he referenced in a news conference on the eve of the final.

"The last 18 months have been challenging for me and my family," the 29-year-old said on Saturday. "Given what has happened over the last few months, it's great to be here in front of you."

After two surgeries and The goal came eight various rounds of chemomonths after he had signed therapy, Haller returned to full training in early January 2023, making his debut later that month before scoring against Freiburg, in one of those strange coincidences, on World Cancer Day itself.

Fast forward to this January and injury, albeit much milder, was again preventing the former West Ham and Eintracht Frankfurt forward from featuring for the Ivorians as they hosted the delayed 2023 Nations Cup. After damaging his ankle

on 19 December, Haller was not fit enough to make the squad for the Elephants' first three

But that paved the way for his return as the conquering hero given their calamitous group stage, in which they lost twice, including a heaviest ever home - and Nations Cup finals - defeat when losing 4-0 to Equatorial Guinea.

Ivory Coast sacked coach Jean-Louis Gasset but then progressed to the last 16 just hours later as Zambia failed to get the result needed to finish above the West Africans as a best third-placed side.

"After the big defeat against Equatorial Guinea, we had no choice," Haller said. "We've come back from a long way. There were words, moments, which were not easy for the players, staff and everybody [but] which were necessary."

And, after the team had scored just twice in the group stage, the return of Haller was ever more important. This, after all, was a man

who became the second player after Cristiano Ronaldo to score in all six Cham-

pions League group games in 2021-22 for Dutch side Ajax, before eclipsing the Por-
