

# Minister: Pull out plot sale placards

LANDS, Housing and Human Settlement minister Jerry Silaa has issued a seven days ultimatum to land officers countrywide to ensure that all placards relating to selling plots of land are removed.

He gave these instructions in Dar es Salaam over the weekend when listening to complaints from city residents seeking to rectify frauds where plots they had already purchased being sold by various companies have disputed occupancy rights.

He directed that compa-

nies or individuals who sell land plots to register such plots at the district and regional land offices as a measure to avoid cheating in that business.

"You cannot sell a plot by using a map,' he said, explaining that a plot is sold with a title deed, so the government cannot remain silent when poor citizens have their money being stolen by culprits.

He asked owners of companies engaged in the plot selling business to apply for the title deed of plots they survey first before starting to find interested buyers.

The Land commissioner in the ministry needs to

speed up the process of issuing documents to people who will come to request title deeds of newly surveyed areas to reduce land frauds, he said.

The public must be educated that from all plots belonging to individuals or private companies will be sold in district land offices, saying that people are being cheated a lot.

"You may find that someone tells them that he has plots, but he has a plot that he acquired through fraud and when people go to local government offices they find that he isn't recognised as title holder to plots, so we want to stop this kind of fraud," he added.

# Somalia's judges, MPs set for EAC

SOMALIA is soon going to send representatives to the East African Legislative Assembly (EALA) as well as dispatching Judges to the East African Court of Justice.

Hassan Sheikh Mohamud, president of the Federal Republic of Somalia, made this affirmation at the 23rd ordinary meeting of the EAC summit, in a virtual open session late last week.

President Mohamud said that Somalia was gearing for starting to apply the customs union and common market protocols, also known as the first and second pillars of the integration process.

The summit was chaired by South Sudan President

Salva Kiir Mayardit, who said that the bloc was on the right track as intra-regional trade currently stands at 15 percent of total foreign trade.

Intra-regional trade is expected to rise further as Somalia gradually integrated into the EAC trading zone, while Ugandan President Yoweri Museveni expressed disappointment that nontariff barriers distort the region's potential for trade.

President Samia Suluhu Hassan asked Veronica Nduva, the new EAC secretary general, to focus on improving EAC visibility, along with addressing the lack of shared perception of benefits of integration among East Africans.

Some East Africans are clearly unsure of the benefits of integration, she said, in a meeting also attended by Burundi Vice President Prosper Bazombanza; Kenyan Foreign and Diaspora Affairs cabinet secretary Musalia Mudavadi, and Deng Alor Kuo, the EAC Affairs minister for South Sudan, also chairing the EAC council of min-

Others were Justice Nestor Kayobera; president of the East African Court of Justice (EACJ), EALA Speaker Joseph Ntakirutimana; Annette Ssemuwemba who heads customs, trade and monetary affairs at the EAC Secretariat, and Andrea Malueth who heads infrastructure, productive, social and political affira at the EAC head offices,.

Oryx Energy (T) Ltd (OGTL) and women MPs worked together on the clean cooking solution award, with the Speaker remarking that there is every reason for President Samia awarded by the women parliamentarians.

The energy firm was involved as the president has championed the clean cooking energy drive for Tanzania, Africa and the world in general, she stated, affirming that current data shows that more than 80 percent of sub-Saharan Africa use dirty energy sources for cooking. The use of dirty energy results in serious environmental impairment, with acute social effects for women and girls, spending a lot of time searching for firewood in the bush, she stated.

"President Samia is determined to relieve women and girls from searching for firewood in the bush, thus enabling them to engage in other economic activities," she told the audience.

"We congratulate our President for the steps she is taking to ensure women cook in a convenient manner but also protect them from a der-based violence arising from number of health risks including respiratory illnesses," the par- added.

liamentary leader declared. Data has for some years shown that Tanzania is losing 469,000 hectares of woodland per year, far higher than an estimated 300,000 hectares that use to be lost annually in the 1990s, she said.

Irene Gowele, the Tanesco acting director of communications and corporate affairs, said in a response, o that the company has already paid 116.6m/- out of 121.49m/- to 473 out of 525 people affected by the project.

This marked effective day of the contract roll off and project completion date is slated for November 11, 2024, the note affirmed, showing an impression that the implementation progress rate is satisfactory, and it is likely to be achieved.

The proposed 49.5 MW grid-connected hydropower plant (with an average annual energy production of 181GWh) will mainly serve local demand in Kigoma and surrounding regions.

# What big business wants for South Africa's future

A LEADING figure in South Africa's second biggest political party has warned that a failure to fix the economy "might end up with violence that nobody wants."

In the aftermath of the elections, Dion George, who oversees economic policy for the Democratic Alliance (DA), has told the BBC that political parties need to "set aside our deeply entrenched ideological perspectives" to get the economy growing

again. The African National Congress (ANC), the party that ended white-minority rule in 1994, came first in recent polls, but did not win an outright majority and is trying to put together a government of national unity.

South Africa's President, the ANC's Cyril Ramaphosa, has said the concerns of citizens must be the priority.

"These issues include job creation and the growth of our economy that will be inclusive, the high cost of living, service delivery, crime and cor-

ruption," he said recently. Nearly eight million people are unemployed across the country, meaning the jobless rate is 32.9 percent.

It is one of the highest in the world and has been called a "ticking time bomb" in a UN report.

Amid ongoing power cuts that make it difficult for businesses to function, this week the statistics agency said the economy shrank in the first three months of this year - with manufacturing, mining and construction suffering in particular.

Last year South Africa's economy grew just 0.6 percent.

"A whole lot of small businesses have actually shut down" because of widespread problems with energy supplies as well as the state run transport and water networks, said Busisiwe Mavuso, the chief executive of the influential lobby group Business Leadership South Af-

Its members include local names such as the Bidvest conglomerate and Absa bank as well as international firms such as Amazon, Volkswagen and Nestle.

Muvaso says the "trading environment is not conducive" and that her members' "plea is for the government to really fix

the basics". The central bank says foreign investment fell by a country that the International Monetary Fund (IMF) forecasts will nonetheless return to being Africa's biggest by the end of this year. French bank BNP Pari-

bas and UK oil giant Shell are amongst the big, foreign names pulling out of South Africa. In a recent aborted takeover bid for the mining firm Anglo-American,

The competition for investment is fierce and Ms Mavuso said "we've really made it difficult for capital to land here."

"East Africa is eating South Africa's breakfast," she jests, while remaining hopeful that the size of the domestic market and the rule of law will ensure the return of investment once the economy is back in better shape.

For both foreign and domestic companies, Muvaso said, the government has to "create an environment that is conducive for

The difficulties many are facing in making ends meet in a stagnant economy led the government to increase a range of welfare payments in February's budget.

More than 24.5 million people, or 39 percent of the population, receive some form of financial help from the government. It is one reason why government debt has increased to 74 percent of the country's annual income and that the IMF warned in April that "decisive efforts are needed to cut spending".

South Africa's own

treasury has warned that "debt-service costs are choking the economy and the public finances". They now account for 20 percent of all government spending, more than basic education, social protection or health.

Looking at the electricity problem, the DA's Dion George said that it is "probably" important for the government to borrow money to fix the country's crippled energy network, railways and ports. But he admits that will be difficult to afford.

Another option he says is to "change the model, inject the private sector into it", which would lessen the strain on government finances.

With centre-right DA getting 22 percent of the vote, it may have some influence on future policy and also wants labour laws such as minimum wage rules relaxed to boost employment.

"It's priced workers out of the market, employers are not willing to employ people at the rate of the minimum wage," said Dr George. His white-led party proposes an exemption for 18 to 35-year-olds who have been unemployed for two years.

But it is the sort of policy which puts the DA at odds with South Africa's trade unions, an important ally of the ANC.

# 'All animal feeds ought to be tested for quality before sale'

THE Tanzania Veterinary Laboratory Agency (TVLA) has asked animal feed producers to take samples to the agency for quality tests before reaching the market to protect consumers.

Dr Stella Bitanyi, TVLA Managing Director, made the call yesterday in Dar es Salaam when a team of experts from the Ministry of Livestock and Fisheries and TVLA met after the end of an inspection exercise for producers and manufacturers of animal feeds held in Arusha

Dr Bitanyi said producers must take samples of their products to the agency for certification and qualities testing since laws stipulate that no product should enter the market without being tested.

"All producers and manufacturers should ensure that they produce quality feeds for better outcomes for national development," she said.

Leading a team of experts, director of investigation services at TVLA Dr Zacharia Makondo said it was important for animal feeds to reach markets after being tested for

Dr Makondo said they had realised that some manufacturers mix their products without abiding by the law.

He said it was illegal for manufacturers to pack animals feeds without consulting experts, adding that the malpractice is against the law.

TVLA is expected to continue offering training on proper management and manufacturing of animal feeds to increase production and profit.

### Black medic who saved several lives on D-Day honoured at last

A MEDAL richly deserved but long tured it and started pushing inland. denied to an African American combat medic wounded on Omaha Beach in the D-Day landings has been tenderly laid on the hallowed sands where he saved lives and shed blood.

U.S. First Army soldiers held a ceremony in honour of Waverly Woodson Jr. at the wekend on the beach where he came ashore and was wounded, and where hundreds of American soldiers were killed by withering fire in the June 6, 1944, landings in Normandy, northern France.

The Distinguished Service Cross is the second-highest honour that can be bestowed on a member of the U.S. Army and is awarded for extraordinary heroism. The medal was awarded posthumously to Woodson this month - just ahead of the 80th anniversary of D-Day - following years of lobbying for more recognition of his exploits on that fateful day.

U.S. First Army Maj. Gen. William Ryan gently placed the World War IIera medal on the sand, close to the spot where Woodson is thought to have come ashore on the now-peaceful beach that on D-Day was raked by

German machine-gun and artillery rounds before U.S. forces finally cap-

The soldiers all saluted, still and quiet under blue skies, when U.S. First Army Command Sgt. Maj. Christopher Prosser gave the order to present arms. U.S. First Army historian Capt. Kevin Braafladt explained to the soldiers that the next step would be the medal's presentation to Woodson's widow, 95-year-old Joann. It will be given to his family in a ceremony later this summer.

"We want to be able to say that this medal came from Omaha Beach and was at the site of Woodson's actions," he said. The soldiers delicately passed the medal from hand-to-hand, feeling its weight and inspecting it.

The ceremony moved U.S. First Army Staff Sgt. Aaron Williams who is black to tears.

"Understanding my position as an African American and to learn about Corporal Woodson and everything he experienced here on Omaha and in Normandy is very touching to me, and to be here in the exact spot, it's just historic. It's very, very touching," he said.

# Invasive shrub chocks biodiversity in Arusha

AN alien, invasive shrub which spreads rapidly from Kenya into Northern Tanzania threatens Lake Natron and surrounding biodiversity.

Various environment and community organizations from Kenya and Tanzania gathered in Longido District at the weekend to discuss how to address the imminent danger caused by the poisonous and destructive prosopis shrubs known locally as 'Mrashia.'

The organizations include the Tanzania Forestry Research Institute (TAFORI), Tanzania Natural Resources Forum (TNRF), Tanzania Wildlife Management Authority (TAWA), Community Research and Development Services (CORDS), Ujamaa Community Resources Team (UCRT) and the Centre for Agriculture and Biosciences International (CABI) of Ken-

Longido District Environment Officer Elimeleki Ukwai said during the meeting at Wosiwosi village that proposis shrubs dry water sources wherever they prop up, adding that at the moment, they inch towards Lake Natron, East Africa's most important flamingo breeding site.

So far, the most affected areas in Northern Tanzania include the Wosiwosi Village in Gelai Lumbwa Ward and Matale Ward both in Longido District, Pinyinyi Ward in Ngorongoro District and Kahe Ward in Kilimanjaro

The deadly shrub has infested 2,235 hectares of land in Wosiwosi area and was still spreading fast.

With its cross-cutting toxic effect, the poisonous plant (prosopis Juliflora) was also spreading fast towards the foot of Mount Kilimanjaro on the Leeward side.

In Kenya, prosobis shrubs

have tattered over 118,000 acres of land in Baringo County.

According to Wini Nunda, a researcher from CABI Kenya, the shrub has been declared a national catastrophe in the neighbouring country.

"We have been trying to destroy the deadly plant through direct uprooting, applying chemicals and encouraging people to chop the stems for charcoal," she said. Zacharia Faustin, Director of TNRF, said the deadly weed has led to destruction of large acres of grazing lands, threatening the lives

of livestock. Dickson Xavery, a re-

searcher from TAFORI, said seeds and seedlings souththere are national strategies to eradicate all invasive plant species in the country by at least 50 percent before the year 2029.

The spread of prosopis in Tanzania has been described to be rather accidental, mostly through strong winds blowing its seeds across the border from Kenya.

It was suggested that the donkeys used as a means of transport between the two countries would also feed on prosopis pods and spread the seeds with their dung

along the way. Recent floods have also been sweeping prosopis or

wards and deposing them gradually.

Prosopis is an evergreen, multi-stemmed shrub or small tree with umbrella-like leaves. It can grow to reach over 10 meters in height, with its branches carrying long thorns and featuring flowers that are fragrant

golden-yellow. It was described at the meeting that prosopis inhabits a wide range of soil types. Prosopis is native to the Americas. It was initially introduced in Kenya mainly for rehabilitation of degraded landscapes and prevention of soil erosion.

It now unleashes massive impacts on land quality for livestock grazing and farming, water availability and wildlife in Longido and Ngorongoro districts in Arusha and parts of Kilimanjaro.

According to experts, the species' spread is difficult to contain, physical removal is costly and eradication of large-scale infestations nearly impossible.

Kenya, Ethiopia, Sudan and South Africa have declared prosopis a dangerous weed while South Africa and Ethiopia have already published national management strategies against the invasive pant.

### Long jail terms for Chinese cybercrime gang in Zambia

LENGTHY jail terms have been handed to 22 Chinese citizens - and a Cameroonian man - for cyber-related crimes in Zambia.

The gang's only female convict, Gu Tianjiao, reportedly cried "papa, papa" as her seven-year sentence was announced in the Lusaka Magistrates Court on Fri-

Some in the gang - including its mastermind Li Xianlin - received up to 11 years in prison.

The group's members were also fined between \$1,500 and \$3,000 (£1,180 and £2,360) each.

Victims as far afield as Singapore, Peru and the United Arab Emirates fell prey to their online scams, said Zambian authorities.

After a trial lasting several weeks, the perpetrators pleaded guilty on three charges - computer-related misrepresentation, identity-related crimes, and illegally operating a network or service.

The 22 people jailed on Friday were among a bigger group of 77 suspects arrested in April, in connection with what authorities called a "sophisticated internet fraud syndicate".

The swoop on a Chinese-run company in the capital, Lusaka, followed an alarming rise in in-

ternet fraud cases in the country, targeting people in countries around the world.

Growing numbers of Zambians losing money from their mobile and bank accounts through money-laundering schemes which extend to other foreign countries, the Drug Enforcement Commission (DEC) said in April.

Dozens of young Zambians were also arrested after allegedly being recruited to be call-centre agents in the fraudulent activities, including internet fraud and online scams, the DEC said during the arrests.

The 22 people convicted in Lusaka on Friday held different positions in the Chinese-run Golden Top Support Services, the company at the centre of the raid.

The company, located in Roma, an upmarket suburb of Lusaka, is yet to comment on the allegations. The Zambian nationals were charged in April and released on bail so they could help the authorities with their investi-

Authorities said the Zambians involved had been tasked "with engaging in deceptive conversations with unsuspecting mobile users across various platforms such as WhatsApp, Telegram, chatrooms and others, using scripted dialogues".

### **Audit by RITA unearths** embezzlement of 1bn/at Mwanza city mosque

Presenting an audited report before believers here here at the weekend, RITA Chief Executive Officer Frank Kanyusi said the probe committee formed to audit assets of the mosque discovered misappropriation of the said amount.

"We are here to present to you the audited report of by the probe team that was tasked to audit the assets of your mosque. We promise you that those involved in the scandal will face legal action," he said.

According to Kanyusi, in February this year, RITA formed a probe team tasked to conduct one-month thorough investigation on the mosque's assets and later the team established that the amount of money fell into the wrong hands.

He warned that members of Board of Trustees are not owners of the mosque's properties. Instead, their duties are to oversee and protect assets from misuse for the benefits of members.

Following the suspected misuse of the mosque's property and internal frictions among members, the High in Dodoma directed the formation of interim committee of Board of Trustees before June 20, 2024 to oversee the mosque's properties until the new

"My appeal to the interim committee members is that you should be honest because the assets are not yours; you are just entrusted to oversee them," Kanyusi said.

RITA Legal Officer Emmanuela Mwingira said the agency had already worked on some changes in the constitution and picked some believers and tasked them to conduct election for members of board of trustees.

"We had a work to review their constitution and improved it to avoid repeating the mistakes in future," she said.

Speaking at the same venue, a member of the mosque Sherally Sherally asked for the law to follow its course, commending RITA for timely intervention and taking appropriate action.

"We are confident and optimistic on how the government is addressing this matter," he said.

## SA gvt calls on farmers to help curb spread of FMD

SOUTH Africa's Department of Agriculture, Land Reform and Rural Development has urged farmers and livestock owners in all provinces to limit movement of cloven-hoofed animals as far as possible.

This comes in the wake of an outbreak of Foot and Mouth Disease (FMD) on five farms in Humansdorp and East London in the Eastern Cape.

"Cloven-hoofed animals should not be moved unless it is absolutely necessary, considering among others that the East London farm sourced animals from multiple origins. This will allow the department to find and quarantine further undetected, affected properties to prevent any further spread of the disease," the department said.

The significance of the incubation

"The investigation into the origin and extent of the FMD outbreak in the Eastern Cape is ongoing," the department said.

# Alert from scientists: Coral reefs experiencing bleaching

CORAL reefs around the world are experiencing global bleaching for the fourth time, a result of warming ocean waters amid human-caused climate change according to scientists.

Coral reef bleaching across at least 53 countries, territories or local economies has been confirmed from February 2023 to now, scientists from the National Oceanic and Atmospheric Administration and International Coral Reef Initiative reported in April.

In order for bleaching to be declared on a global scale, significant bleaching had to be documented within each of the major ocean basins, including the Atlantic, Pacific, and Indian oceans, in both the Northern and Southern Hemispheres.

Bleaching happens when stressed coral expel the algae that are their food source and give them their colour. If the bleaching is severe and long-lasting, the coral can die. Bleaching has been happening in various regions for some time.

In the world's largest coral reef ecosystem, Australia's Great Barrier Reef, bleaching affected 90% of the coral assessed in 2022.

In March 2024 Great Barrier Reef Marine Park Authority announced a mass coral bleaching event following aerial surveys.

Scientists observed coral bleaching on 73 per cent of surveyed reefs within the Marine Park according to the Great Barrier Reef Marine Park Authority

"The reality for what's happening in the Great Barrier Reef unfortunately isn't a surprise, and it's a consequence of rising global temperatures, and we're very certain of that, partly because of the science, but also because of what we've seen across the whole of the last 12 months," says Roger Beeden, Great Barrier Reef Marine Park Authority Chief Sci-

The reef has experienced "unprecedented temperatures, widespread coral bleaching seen in all the areas, likely to be at least on par with the substantial events that we saw in 2016 and 2017," adds Beeden.

The world is experiencing the second global bleaching event in the last 10 years.

The last one ended in May 2017. Brought on by a powerful El Nino climate pattern that heated the world's oceans, it lasted three years and was determined to be worse than the prior two bleaching events in 2010 and 1998.

This year's bleaching follows the declaration that 2023 was the hottest year on record.



### Here are African countries expected to suffer most from hunger in 2024

## HIV risk high as climate disasters push African women into sex work

IN Nairobi's informal settlement of Kawangware, Kenyan vegetable seller Beverly confronts a grim reality - her one-room corrugated iron home and everything she owned has been destroyed in the worst floods in

Since March, torrential rains linked to climate change have inundated parts of East Africa, destroying homes and livelihoods, and displacing hundreds of thousands of people.

Now, with hunger knocking, the mother-of-two contemplates a dangerous exchange - sex for food.

"I know others who had to do it,"

23-vear-old who did not want to provide her full name, told Context.

"I know about risks like AIDS. But I have lost everything and I still have to feed my children. At this moment, I am just praying," she said.

Amidst the turmoil of Africa's climate crisis, an unseen threat is unfolding where hunger is pushing women and girls into sexual exploitation and increasing the risk of HIV, health experts and aid workers warned.

The continent is on the frontline of the impacts of climate change. This year has already seen floods in east Africa, heatwaves in the west and drought in the south.

As a hotter planet produces more intense and frequent weather-related events, communities already teetering on the brink are being hit the hardest, their livelihoods, often based on farming, destroyed. Many are forced to migrate to survive.

This is not only exposing girls and women to exploitation in the form of transactional sex and sexual violence, but is also raising the risk of increased HIV infection.

Health experts are now sounding the alarm, cautioning that this neglected crisis might reverse years of advancements in the fight against HIV, potentially undoing hard-won gains.

Research conducted by Frontline AIDS last year found that if temperatures continued to rise as predicted, sub-Saharan Africa could see an additional 16 million cases of HIV by

"We were really shocked with the results of modelling data from the study," said David Clark, head of programmes at Frontline AIDS, a global network of 60 charities tackling HIV.

"We are really concerned that the impacts of climate change could wipe away decades of progress on HIV," he said.

Sub-Saharan Africa has made great strides in tackling HIV since it was discovered more than 40 years ago. In east and southern Africa, for instance, new infections have dropped by 57 percent since 2010.

The region however remains the world's most affected - accounting for 25.6 million of the 39 million people living with virus globally, the United Nations AIDS programme (UNAIDS)

Adolescent girls and young women make up more than 77 percent of new infections among people aged 15-24 years in sub-Saharan Africa, and are more than three times more likely to acquire HIV than their male

"Many of these young women are highly vulnerable," said Pasquine floods, heatwaves and storms.

"They don't have economic power or a proper education so it's very difficult for them to even negotiate for a condom," she said.

Participants were trained on the MIKE Programme's framework, data collection techniques and documentation processes, ensuring consistency and accuracy in monitoring efforts across different sites. The Training of Trainers (ToT) approach aimed to further empower these officials to share their knowledge and train more personnel within their home countries, amplifying the impact of the training programme across borders.

#### **Congressional team stands to improve US** assessment of conservation efforts

FEW would likely have expected to see a group of lawmakers from the United States in the Ngorongoro Conservation Area for a visit that looked anything between tourism and a factfinding mission.

Ngorongoro Conservation Area Authority officials said the team was there to view conservation sites, seeing that initiative as likely to attract many foreign tourists as their whereabouts would definitely be widely publicised in the US and elsewhere.

But that isn't the big issue as a group of US entertainers would have done as much, if not even more, without members of Congress chipping in.

A leading figure in the team is reported to have said that the House committee on natural resources will examine how US conservation policies contribute to conservation and tourism development in Africa.

Yes, indeed, and definitely look at the ground, talk to officials to see which view of displacements of indigenous people makes sense, that of radical publicists or what they will hear from Tanzanian officials and scores of other persons in the vicinity.

They say in an English idiom that two is company and three is a crowd, and that is what is visible in local tourism and environment issues placed before legislators in the US.

There was first the dispute about the East African Crude Oil Pipeline (EACOP) project, though it has ignited less heated debate in the US than in the European Union legislature.

Yet they would no doubt have an inkling of it, as last month US\$50 million in support for our southern circuit agricultural sector and tourism development project was frozen over some form of differences of

Preliminary awareness of increased numbers of major wildlife attractions like rhinos, lions, leopards, elephants and buffalos was a good start. The lawmakers are understood to have lauded the conservation authorities for the care and protection of rare wildlife, most notably 'the big five'. A few watchers in the know might be at hand to ascertain that if indeed the US 'delegates' have a positive impression of the care extended to rhinos in their natural habitats, it makes it easier to appreciate the wider picture.

The radical groups that heavily influence policy in major Western countries are more interested in intact conservation of ecosystems of indigenous people rather than wildlife as such.

They largely don't look at the balances of wildlife and cattle grazing as by definition these are in harmony. It's a paradigm they likely were taught about in anthropology classes at university - and it stays.

As to how whatever assessment the US legislators decide to come up with at the end of its all, the best advice would possibly be that we wait until the dance is, indeed, over.

Despite their equal capabilities and potential to contribute to the field, systemic barriers such as limited opportunities for career growth, and pervasive gender biases persist, impeding their full participation. In addition to these structural hurdles, women in groundwater often face cultural norms and stereotypes that reinforce the idea of male dominance in scientific and technical fields.

champion gender equality.

Within the professional sphere, initiatives aimed at creating inclusive environments are paramount. Groundwater organizations must adopt policies that accommodate the diverse needs of their workforce, particularly women.

Flexible work arrangements tailored to the demands of fieldwork and family responsibilities can remove barriers to entry and retention. Mentorship programs that pair women with experienced professionals offer guidance and support, nurturing talent and fostering career advancement.

Equally essential is ensuring equitable opportunities for pay and progression, underlining the value of every individual's contribution irrespective of gender. By cultivating a culture of inclusivity and support, groundwater institutions can heighten the collective expertise of all professionals, driving innovation and progress in the field.

The journey toward true equity involves more than just providing access; it requires dismantling systemic barriers and fostering an environment where every individual, regardless of gender, can thrive. It demands efforts to challenge ingrained biases, reshape societal norms, and advocate for inclusive policies and practices.

As we navigate this path, it becomes clear that actual progress lies not in isolated initiatives but in a holistic, systemic change. It entails equipping women with the tools, resources, and opportunities they need to excel while simultaneously addressing the underlying structures perpetuating gender disparities. It requires a commitment to fostering an inclusive culture that values diversity and empowers individuals to reach their full potential.

Ultimately, the goal of gender inclusivity is not simply to bridge the gender gap but to create a professional ecosystem where gender is no longer a factor that impedes anyone's ability to succeed.

It is crucial to proactively address gender biases, promote mentorship and networking opportunities, and ensure that contributions from women are recognized and valued equally. Only then we can honestly say that we are not just filling the gender gap but actively equipping women, forging a future where equality and equity is not just a goal but a lived reality.

#### It's inspiring seeing maternal, neonatal death rates declining

THOSE with recollections will remember the agony besetting activists and how broadly public authorities kept agonizing over the high levels of deaths of mothers and newborns for most of the past three decades.

A new tendency has been noticed at least for the past five years or less, with officials saying that the number of women delivering in health facilities has increased and hence the drop in the frequency of maternal and neonatal deaths registered.

The key seems to lie in the spate of health sector facilities added since the late year 2021's Covid-19 recovery credit funds.

This factor is not hard to appreciate for it is recent and the decline in maternal and newborn deaths is largely recent as well, even though the credits from the International Monetary Fund need to be set against a rising development budget from the 2016 restructuring of expenditure.

When recurrent expenditure in the total budget fell from 74 per cent to 61 per cent, and development expenditure rose from 26 per cent to 39 per cent within six months of the start of a new phase of government in 2015, the health sector gained plenty at the particular time. That may have been lost in part owing to inability for most people to appreciate developments when they happened.

We also need to know the part democracy played in the imbalance between recurrent and development expenditure, and indeed if we are taking the highway to the same situation.

Efforts made by the government and various other stakeholders to improve health sector infrastructure, equipment and services had its cost in taming contrasting demands that may seem less important but are made by powerful sections of society.

That is why when top medical authorities attended a recent stakeholders' meeting called to discuss initiatives to further improve access to quality health services it was a truly important event. Even if improvements aren't made fast enough, the mere

fact of avoiding decline matters. Currently, 81 per cent of women deliver in health facilities, which a number of participants said relates to a change in people's mindsets triggered by major investment in the health sector.

That was somewhat baffling as health sector investments help expedite access to dispensaries and health centres. This implies having mindsets related to distance from health facilities, even if not frankly presumed resistance of hesitation to use such facilities.

Yet the progress made is not conclusive, and negative tendencies have a way of resurfacing after lots of effort to combat them.

It pays to appreciate this as maternal deaths have reportedly decreased by over 70 per cent in Shinyanga, Mwanza, Geita, Tabora and Manyara regions where an innovative method known has been put to use. This relates to innovative clinical and training tools for better maternal labour care, newborn resuscitations integrated with new strategies for quality improvement to reduce newborn deaths, stillbirths and maternal

From 14 hospitals in 2018 that had newborn wards to 241 today, plenty has been done even as nursing has to improve further for even better performance.

a mud rotary drilling rig. these challenges truly," she asserts, "we need to challenge stereotypes, dismantle systemic biases, and create pathways for women to thrive. Alina emphasizes."

Phera Ramoeli, Executive Secretary at the Permanent Okavango River Basin Water Commission (OKACOM), echoes Kadhila's sentiments, emphasizing the need for an integrated approach to gender equality and equity. "Gender equality is not just about

promoting the interests of one gender over another," he emphasizes. "It's about creating a level playing field where everyone has equal opportunities to succeed." 



### Africa can turn its poverty, unemployment and inequality challenges into opportunities

LTHOUGH sustainable development goal (SDG) 1 states ending poverty in all its forms everywhere by 2030 - that is in six years' time from now - the number of people living in poverty, especially in Africa, is still increasing. Global Multidimensional Poverty Index (MPI) 2023 suggests that about half of poor people across the world live in sub-Saharan Africa, which translates into about 534 million people (47.8 per cent).

The MPI 2023 also shows the number of poor people living in other parts of the world, but which is less than that of Africa -South Asia: 389 people (34. 9 per cent), East Asia and the Pacific: 106 million people (9.5 per cent), Arab states: 53 million people (4.7 per cent), Latin America and the

Caribbean: 33 million people (3.0 than \$2.15 per day per person). per cent) and Europe and Central Asia: 2 million people (0.2 per

The report says in sub-Saharan Africa the intensity of poverty is particularly serious. "The region is home not only to the highest number of poor people, but also to the poorest of the poor." Furthermore, it suggests that 54.1 per cent of poor children live in sub-Saharan Africa, making poverty reduction for these 306 million children a vital focus for the re-

When it comes to unemployment, which aggravates poverty, a recent report of International Labour Organisation (ILO) titled "World Employment and Social Outlook: Trends 2024" says in 2023, about a third of employed persons in sub-Saharan Africa were living in extreme poverty (in households subsisting on less

The report goes further saving (as it cites World Bank data) "in sub-Saharan Africa alone, in 2023, 145 million people were in extreme working poverty (at the \$2.15 per day threshold, in purchasing power parity terms), equating to a third of the employed population. Per capita incomes are expected to grow less than 1 per cent in 2023-24, and 40 per cent of sub-Saharan Africa's population live in countries (including the three largest economies) where per capita incomes will be lower in 2024 than at the start of the pandemic.'

It says unemployment has remained slightly high since the pandemic and the youth are particularly at risk. Citing IMF data of 2023, the report says limited fiscal space affects African countries' abilities to respond to external shocks.

ability of these countries to be resilient to and rebuild from events resulting from climate change, such as prolonged droughts, crop failure, and storms, which can disrupt key economic drivers such as mining activity and agricultural production."

Furthermore, the report says an additional concern is that much existing growth in GDP is not accompanied by an increase in per capita incomes, which rise too slowly to reduce extreme poverty and working poverty (earning less than \$2.15 per day per person).

Another challenge the report cites is a security threat to some African countries, namely, Mali, Niger, Burkina Faso, Chad and Mauritania, saying "continuing security risks have the potential to depress growth. Such conflict impacts on livelihoods as well as diverting public funds away from growth-enhancing investment."

A UN report titled "Economic Report on Africa 2024: Investing in a Just and Sustainable Transi-

that despite the progress being made across Africa there are still some challenges which interfere in Africa's economic growth. This observation was made by United Nations Economic Commission for Africa (EAC) Under-Secretary General and Executive Secretary Claver Gatete who says "Africa faces persistent hurdles to its inclusive and sustainable development.

Despite several pockets of excellence in the continent's progress towards the Sustainable Development Goals (SDGs) and the African Union's Agenda 2063, the number of SDG targets that require acceleration or reversal exceeds those that are on course.

Gatete says poverty, inequality, food insecurity, and unemployment contribute to poverty intensity as from 2019 to 2023 the number of people vulnerable to poverty rose by 28 per cent. However, as a solution he proposes Africa to enhance its climate resilience and embark on

# Bashe charts new course for agricultural growth corridors

N April 19, this year, Dodoma city was the setting for a significant advancement whereby the government through the Ministry of Agriculture and many stakeholders, participated in the Southern Agricultural Growth Corridor of Tanzania (SAGCOT) 3rd National Consultation on its journey ttoward transforming entity into the Agricultural Growth Corridors of Tanzania (AGCOT).

This critical event emphasised the nation's dedication to rejuvenating and advancing its agricultural sector through strategic and well-coordinated national agricultural corridor initiative.

The meeting served as a platform for strategizing the implementation of the AGCOT rollout, building upon the knowledge and achievements gained from the about ten years of implementing SAGCOT initiative.

Tanzania plans to expand corridor initiatives beyond the SAGCOT areas, focusing on the Mtwara, Central, and Northern Corridors. The new corridors will follow a similar approach to the SAGCOT area, taking into account the specific agricultural zones in each corridor. Existing agribusinesses and previous research findings will be considered in the design and implementation of AGCOT, with a focus on leveraging existing infrastructure and investments in roads, ports, airports, and electricity. The goal is to improve productivity, enhance Tanzania's competitiveness in domestic and international markets, and facilitate access to inputs and capital to support agribusiness development. The initiative will also prioritize compliance with Tanzania's commitments to sustainable use of natural resources and inclusivity especially that of women and youth, and will incorporate climate-smart production practices.

Hussein Bashe (pictured), Minister for Agriculture, stressed the importance of adopting a comprehensive strategic approach to developing agricultural corridors in Tanzania. He emphasised the need for strategic alignment to leverage their economic potential fully, proposing a well defining the corridors based on ecology, economic activity, and export potential.

He also underscored the necessity of financial investment in these corridors.

"We must openly discuss how we will finance these corridors," he stated, adding: "We must explore opportunities for intelligent financing mechanisms to support their development and sustainability."

Bashe urged stakeholders to adopt a forward-thinking perspective, envisioning the trajectory of agricultural corridors over the next several decades.

"We must not only focus on the present," he urged. "We must develop a roadmap that guides our actions for the long term."

Highlighting the potential of high-value commodities, Bashe encouraged a shift in focus towards crops such as avocados and mangoes, which have a higher market value.

He emphasised the importance of comprehensive planning and investment in seedlings and technology to support these crops highlighting the potential of high-value commodities.

Bashe encouraged a shift in focus towards horticultural crops including fruits as avocados and mangoes, which have a higher market value, stressing the importance of comprehensive planning and investment in seedlings and technology to support these crops' cultivation effectively.

Bashe highlighted Tanzania's agricultural corridor's competitive advantage and emphasised the importance of aligning agricultural production with economic activities.

"We must recognize the competitive advantage of Tanzania's agricultural corridors," Bashe asserted, "and align them with our economic objectives. Viewing these corridors solely through the lens of food security is no longer sufficient. We must consider the broader economic activities they support." Emphasising collaboration, the minister urged SAGCOT to work closely with Cereals and Other Produce Regulatory Authority (COPRA) in corridor development.

Bashe urged stakeholders to adopt a forward-looking approach, envisioning the trajectory of agricultural corridors over the next several decades. "We cannot afford to think only about the present," he urged. "We must craft a roadmap that guides our actions for the long term."

Bashe also called for clarity on the required public sector investment and the development of models to demonstrate the economic benefits of investing in agriculture. He emphasised the need for col-

He emphasised the need for collaboration between the Ministry of Agriculture and other government agencies to ensure the success of agricultural corridor development initiatives.

Geoffrey Kirenga, SAGCOT chief executive officer, led a comprehen-

sive review session attended by various stakeholders representing the governmental and private sectors. The one-day meeting, which delved into an in-depth analysis of SAGCOT's progress since its inception, was facilitated through the Zoom platform to ensure broad participation and expert insights. Kirenga highlights the collaborative synergy between governmental bodies and private enterprises in driving the agricultural agenda forward. With a strong focus on tangible achievements, Kirenga emphasized the transformative impact that SAGCOT has had on Tanzania's agrarian landscape.

Directing attention to untapped opportunities beyond the current scope of operations, Kirenga identifies corridors such as Mtwara, Central, and Northern as prime locations for agricultural development initiatives. This strategic shift towards expansion aligns closely with the directives issued by President Samia Suluhu Hassan, demonstrating a broader commitment to elevating Tanzania's agricultural sector.

Prominent stakeholders at the meeting include representatives from government ministries overseeing agriculture, livestock, and fisheries and private sector entities such as ASTA and the Tanzania Horticultural Association (TAHA). Their collective contributions underscore the collaborative ethos driving Tanzania's agricultural agenda.

Kirenga and other stakeholders stressed the need for stakeholders to take action on the matters discussed during recent engagements. Moreover, it was affirmed that the Agriculture Growth Corridors of Tanzania is already underway, with plans to formally introduce it to the public.

Since its inception in 2011, SAG-COT has been at the forefront of agri-development across the Southern Highlands region. Tailored to the ecological nuances of the respective areas, SAGCOT has thrived on partnerships between the government, the private sector, civil society, and the international community. # Devil's Breath': The world's 'scariest' drug

MAGINE walking down a quiet street, minding your own business, when a stranger approaches. They offer you a seemingly harmless business card, and you take it without thinking twice. Little did you know that the card was soaked in a drug, which would be absorbed by your skin within minutes.

Or someone might just blow the powdered drug directly in your face, and after inhaling that, within minutes you find yourself in a "Zombie-like state", unable to control your actions or resist their demands.

"Devil's breath" can render victims suggestible and disoriented, causing them to lose all willpower and readily give up their belongings to criminals. It takes effect within 10 minutes of inhalation, and the victim's memory and brain can't function normally.

The drug leaves victims with no ability to control their actions. According to worldwide urban legends, the victims will do anything for their attackers, from giving up all their belongings to even going as far as killing someone for them.

The drug is scopolamine, derived from nightshade plants. Scopolamine, also known as hyoscine, is a natural or synthetically produced tropane alkaloid and anticholinergic drug which has a few legitimate medical uses, such as treatment for motion sickness, postoperative nausea and for the tremors of Parkinson's disease.

It is said to be one of the first "truth serums" which was used during WWII to obtain information from unwilling targets. However, it's mostly known for its dark-

It is popularly known as "devil's breath", and is globally recognised as "the world's most dangerous drug".

Criminals, particularly in Colombia and Ecuador, have used it to render victims helpless, robbing them blind, stealing their belongings, or even committing more heinous crimes such as murder or rape.

The scariest thing is that the drug has found its way to criminals in Bangladesh.

While returning from a local market, two men posing as charity workers approached her, and when she turned around to talk to them, one of the individuals blew some powder in her face, leaving her disoriented. Under the drug's influence. Fatema lost control over herself and unknow-

ingly complied with the criminals' demands. They stole her valuables, including jewellery worth Tk 80,000, cash, her phone, and a shopping bag.

The incident was captured on CCTV. Bystanders mistook the interaction for a usual encounter.

Double Mooring Police Station Officer-in-Charge Fazlul Kader Patwari said under scopolamine's influence, Fatema did what the criminals told her to do. When Fatema regained her senses after some hours, she realised she had been robbed.

"Scopolamine is made from the Borrachero plant. Known as "devil's breath" in its powdered form, this substance can render victims suggestible and disoriented, causing them to lose all willpower and readily give up their belongings to criminals," Dr Dulal Krishna Saha, chief chemical examiner of the Department of Narcotics Control, said.

By putting it on a visiting card, paper, cloth, or mobile phone screen, it's brought within four to six inches of the target's nose.

"It takes effect within 10 minutes of inhalation, and the victim's memory and brain can't function normally. Some take an hour to return to normal, while many fail to fully recover within three to four hours," he said.

In recent years, robberies using scopolamine have been reported in various parts of the country, including Dhaka, Jashore, Khulna, Rajbari, and Bogura.

Narayanganj Police first recovered 10 grammes of scopolamine from a gang in September 2023 while investigating the murder of a teacher of

Northern University. The gang used to sell scopolamine, potassium cyanide, and chloroform

through online groups. Police do not have exact figures for crimes related to scopolamine, but

they found some Iranian nationals' involvement in them, along with lo-

On January 21, 2023, Jisan, an employee at a travel agency in the capital's Pallabi, fell victim to such a crime when two Iranian men visited the agency and took Tk 4.5 lakh from Jisan's cash box.

Despite watching them and talking with a smile. Jisan did not realise he was being robbed until they left with the money. Later that month, police detained one of the culprits.

In April last year, law enforcement arrested five individuals -- including three Iranians, in Dhaka and Jashore -- following a robbery in Abhaynagar, where a shopkeeper handed over Tk 6 lakh to the perpe-

Later in August, two more Iranians were detained in Shibgani of Bogura, following a similar incident.

Contacted, Enamul Haque Sagor, assistant inspector general (media) of Police Headquarters, said, "It is a different modus operandi than regular crimes. We have already arrested several individuals. Whenever such crimes with unusual methods come to light, we take action."

She explained that the countries of the East African Community have agreed, where once the products have been certified for quality by the standards organizations of those countries, when they cross the borders to other countries, they do not have to be tested again, so this is an important opportunity for milk producers and their products to reach domestic and foreign markets of the country without facing commercial obstacles.

Mtemvu said the service to verify the quality of products for entrepreneurs is provided free of charge by TBS, as every year the sixth-phase government under the leadership of President Samia Suluhu Hassan allocates funds for the purpose.

"We've been providing that education to all producers so that they can get a quality mark," Mtemvu said, adding that through the celebration they provided education to the people regarding the responsibilities of the organization.

Mwanza Regional Commissioner, Said Mtanda, encouraged the people to increase the speed of drinking quality certified milk, as it is safe for the health of consumers.

# ICT commission issues 1bn/- for electronics refurbishment lab

THE Information and Communication Technology (ICT) Commission has extended 1bn/- to the Tanzania Industrial Research and Development Organization (TIRDO) to establish a technological laboratory for refurbishing electronic devices.

Speaking at the Memorandum of Understanding (MoU) signing ceremony held last Friday in Dar es Salaam, Dr. Nkundwe Mwasaga, Director General ICT Commission said that the laboratory will also be a center of excellence for training youth on innovative matters to invent and capacitate new technologies.

He said the investment budget is likely to be increased according to the scope of production which shall be made pub-

According to him, the electronic devices to be refurbished at the laboratory among others include smartphones, printers and laptops.

"The laboratory will play a critical role towards realizing the government's vision of attaining a competitive digital economy. All electronic devices that are about to meet the lifetime deadline shall be collected and bought from the owners for refurbishment in an organized manner," said Dr. Mwasaga.

According to him, the initiative will en-

able more people to own smartphones and other electronic devices through affordable purchasing prices.

"The laboratory shall also be used for assembling new electronic devices from imported materials for the purpose of supplying the local market," said Dr. Mwasaga.

He asserted that a guideline for all procedures and prices of the refurbished items will be developed.

Dr. Mwasaga said that the laboratory will also be used for practical training for young people who are talented but without formal expertise in the ICT sec-

The annual refurbishment capacity shall be known after the ongoing study on the scope of work has been finalized.

Professor Mkumbwa Mtambo said that the refurbished electronic devices will be reintroduced to the market in a specified lifetime and shall be sold at affordable prices with consideration of consumers' rights protection.

"The laboratory will be a center of excellence for young innovators to improve their innovative skills. A lot of imported electronic devices these days don't last longer;

This refurbishing of the devices is of great importance for people to have more options on purchasing," said Prof.

# Tanzania's economy size reaches 149trn/- in 2023

he size of the T a n z a n i a n economy at 2015 constant market price amounted to 149trn/last year, an increase of nearly 8trn/- compared to 141.8trn/- in 2022, Bank of Tanzania (BoT) quarterly statistics have shown.

The increase resulted in expansion of all economic activities including agriculture, industry and construction, services and taxes on products.

The size of agriculture activity, which employs the majority of Tanzanians, increased to 35.7trn/last year, compared to 34.7trn/- in 2022, while size of construction, the second largest slightly went up to 21.7trn/- compared to 21.1trn/- respectively.

The central bank data show that, at 2015 constant prices, the Gross Domestic Product (GDP) grew by an average of 5 percent last year, compared to 4.5 percent in 2022.

Other largest economic activities which recorded the expansionary trends during the reported years were transport and storage, mining and quarrying, financial and insurance services, real estate, trade and repair, public admin-

istration and manufactur-

However, the National Bureau of Statistics (NBS) highlights quarterly GDP reports that show the size of the economy, at current market prices in absolute terms, amounted to 202trn/- last year, compared to 170.3trn/- in 2022.

The tertiary economic activities accounted for the largest share during last year with an average of 40 percent, while secondary and primary activities accounted for 22 and 38 percent respectively, according to NBS quarterly reports.

The expansion of the tertiary sector, which

includes services and businesses, indicates progressive economic development of the country as greater income from the secondary sector opens up new opportunities.

In 2022, the share of agriculture in Tanzania's gross domestic product was 24.27 percent, industry contributed approximately 27.7 percent and the services sector contributed about 30.64 percent.

According to the World Bank's Tanzania economic update, the economy has been resilient; growing by 5.2 percent in 2023, compared to 4.6 percent in 2022, but growth contin-

ues to have minimal impact on poverty reduction in part because of high population growth.

"The country's funda-

mental challenge remains how to make growth more inclusive and generate more opportunities and better jobs for all Tanzanians," said the World Bank. Tanzania is currently ranked by the Internation-

ranked by the International Monetary Fund (IMF) as the tenth largest economy in Africa, behind South Africa, Nigeria, Egypt, Algeria, Ethiopia, Morocco, Kenya, Angola and Cote D'Ivoire.

The Washington-based institution projects that South Africa, Africa's most

industrialised country, will become Africa's biggest economy with a GDP of \$373 billion-a position the IMF expects it to retain un-

Egypt, which held the top position in 2023, is expected to drop to second place behind South Africa, primarily due to a series of currency devaluations.

Nigeria, once dubbed Africa's largest economy, is set to relinquish its crown and slide to fourth place this year for similar reasons.

According to the IMF, South Africa, Egypt, Algeria, and Nigeria will remain the top four economies in Africa until 2030.

## Tobacco farmers in five districts earn 109bn/-

Thousands of farmers in Urambo, Kahama Sikonge, Kigoma and Kaliua districts have pocketed a total of 10bn/- after selling their tobacco leaves to the crop buying firm in four months.

The leaders of Twende Pamoja Amcos located at Kalunde in Tabora municipality confirmed that they were happy with tobacco prices they were getting from the crop buying company under contractual arrangement.

"We greatly congratulate the government for ushering in more competition in the sub sector, which is now driving tobacco prices upwards continuously, hence we farmers are expanding our fields every year," said Chairman of the Amcos Ramadhani Kisena. He said because of good prices

for crops, their Amcos has managed to produce more than 700,000 kilograms this crop season, and out of the total, they have sold 240,000 kilograms and have been paid more than 1bn/- for the same.

Speaking of the previous crop volumes, he said, in the 2021/22 crop season, members of their Amcos produced 350,000 kilograms, while in the 2022/2023 crop season they produced a total of 580,000 kilograms.

He said their success stories mainly revolved around the farmers' readiness to absorb extension services education provided to them by their contracting partner, Alliance One.

"I should mention that these good prices offered to us and timely payment from the crop buying firm, are driving forces towards growing more volumes of the good quality tobacco crop," he said.

Twende Pamoja Amcos Secretary Cum Manager Subira Salum said currently, they have received all the monies for the sold 240,000 kilograms, adding that their members were still sending more tobacco bales to the markets.

"The average price for this crop season is \$2.4 per kilogram, and on top of that the company pays another 102/= per every kilogram as motivation for every grower for the job well done," he said.

He said, because of the glad tid-

their village 350-member Amcos, they were now receiving many requests from other village members, so that they also become members of the Amcos and join tobacco farming like them.

The tobacco buying firm's spokesperson Advocate John

Unlike other cash crops, Tobacco is purchased from Tanzania growers in United States Dollars and it is therefore a major foreign currency earner for the nation.

By law, tobacco buying companies are obliged to pay for the tobacco purchases within 14 days of the sale date.

He said his firm continued to strive to pay its growers within 5 days of the sale date for the current and past three seasons in order to assist its grower base to pay off their bank loans in a timely manner and reduce their interest burden.

"We are happy to announce that we will continue to pay our contracted farmers as quickly as possible to reduce their interest burden to the banks and therefore ensure that they maximize their profits and improve their livelihoods," he said.

The company spokesperson also added that the company acknowledges that this 2023/2024 growing season was an extremely challenging season for the average farmer due to the incessant rains or Eli Nino conditions that prevailed.

Ephraim Mapoore, the company's managing director said; "We hope this positive gesture will create a good and long term working relationship with our growers and subsequently enable the Tanzania tobacco sector and economy in general to flourish".

# African countries boost tax revenues by \$2.4bn

frican nations grappling with substantial financial losses from tax evasion and other illicit financial flows have ramped up their efforts in tax information requests.

In 2023, African countries significantly bolstered their capacities to mobilize national revenues through information exchanges for tax purposes.

According to the latest report from the Africa Initiative on Transparency in Taxation, these efforts resulted in over €2.2 billion (\$2.4 billion) in additional revenues (taxes, interest, and penalties), primarily collected by seven countries leveraging received infor-

The report notes that in 2023 alone, this additional mobilization surpassed the cumulative total of extra revenues collected

between 2009 and 2022, which amounted to €1.6 billion.

In total, African countries made the highest number of information exchange requests ever recorded, marking the continent as a net sender (where total requests sent exceeded those received) for the second time since the Initiative's inception in 2014. This strong and growing commitment by African countries to tax transparency will certainly help reduce tax non-compliance and illicit behaviours, and increase the tax revenues for the continent as a whole," said Muchanga.

According to data, the youth unemployment rate in Tanzania was 3.48 percent in 2022, from 3.81 percent in 2021, a decrease of 0.33 percent.

Data also shows that the youth unemployment rate continues to drop by reaching 2.6 percent last year, while the travel and tourism industry represented a share of 5.3 percent of the country's total employment in 2021.

The sector also contributed to 17 percent of the country's Gross Domestic Products (GDP) and built the country's third-largest source of employment by directly employing over 850,000 workers.

In 2023, tourist arrivals to Tanzania increased by 24.3 percent to a record breaking 1.808.205.from 1,454,920 tourists in 2022, and 922,692 in 2021 and 616.491 in 2020.

With that trend, Tanzania tourism receipts reached a record high USD3,368.7 million in 2023, compared to USD2,527.8 million in 2022 as well as USD 1.310.3 million in 2021.

# Three tech giants' market caps rival Africa's total GDP

Microsoft, Nvidia, and Apple, in corporation individually possessed a market capitalization worth in value more than the 54 countries combined GDP.

According to the United Nation Organization, there are 54 countries in Africa today, home to 1.39 billion people but with \$3.1 trillion GDP.

Microsoft Corporation, an American multinational corporation and technology company headquartered in Redmond, Washington, boasts of US\$3.16 trillion Market capitalization.

Microsoft's best-known software products are the Windows line of operating systems, the Microsoft 365 suite of productivity applications. Apple Inc also has US\$2.98 trillion market capitalization.

Apple is also an American multinational corporation and technology company headquartered in Cupertino, California, in Silicon Valley.

More profoundly, Nvidia (NVDA), a software and fabless company, also based in America, two days ago hit a market capitalization of US\$3 trillion becoming the third U.S. company to do so after Apple (AAPL) and Microsoft (MSFT). Nvidia stock has been on a tear lately.

Nvidia reached the \$3 trillion milestone just 66 trading days after notching a \$2 trillion value.

By contrast, it took Apple and Microsoft 719 and 650 trading days, respectively, to climb from \$2 trillion to \$3 trillion, according to Dow Jones Market Data.

Nvidia is a software and fabless company which designs and supplies graphics processing units (GPUs), application programming interfaces (APIs) for data science and high-performance computing, as well as system on a chip units (SoCs) for the mobile computing and automotive market.

Earlier in February this year, Nasdaq in its analysis theme "Zacks Earnings Trends Highlights: Tesla, Microsoft, Apple and Nvidia" noted that the quarterly results from the Magnificent 7 companies reconfirm why these companies have been market leaders over the

Except for Tesla TSLA, each of the other 6 companies has a market capitalization in excess of a trillion dollars, with Microsoft MSFT at more than \$3 trillion and Apple AAPL right in that vicinity. But it isn't just their size; they are very profitable and still enjoying plenty

Accordingly, it noted that "We still have Nvidia's NVDA report to come, but combining estimates for Nvidia with the actual results for the other 6 members of the group, total Mag 7 earnings for Q4 are on track to increase +48.5 percent from the same period last year on +14.5 percent higher revenues, which would follow the group's +54.2 percent higher earnings on +12.9 percent higher revenues in 2023 Q3.

"The Mag 7 companies combined are on track to account for 23 percent of all S&P 500 earnings in Q4; they account for 29.3 percent of the index's total market capitalization. Had these 7 stocks been a sector. they would have the second biggest weight in the S&P 500 index, behind the Tech sector, which currently accounts for 37.3 percent. The Finance sector, which at one time was the biggest sector in the index, currently accounts for 12 percent.

Importantly, the Mag 7 earnings outlook is steadily improving. The +30.4 percent earnings growth expected for the group in 2024 Q1 is up from +25.7 percent last week, with estimates for the following quarters also going up.

Beyond Mag 7, Q4 earnings for the S&P 500 index are currently expect-

ed to be up +4.9 percent above the year-earlier period on +3.1 percent higher revenues. This would follow the +3.8 percent increase in index earnings in 2023 Q3 on +2.3 percent higher revenues.

Meanwhile African countries or Africa as a whole has abundant natural resources, but much of its economy has remained predominantly agricultural, and subsistence farming still engages more than 60 percent of the population.

According to the IMF's World Economic Outlook, South Africa with a GDP of \$373 bn, is solidifying its status as Africa's most industrialized economy, followed by Egypt, Egypt commands a GDP of US\$347 bn, leveraging its strategic geographical position as a bridge between Africa and the Middle East.

Historically, Egypt has served as a pivotal hub for trade and commerce. Its economy thrives on a robust tourism sector, agriculture, manufacturing, and a burgeoning ICT industry, cementing its significance in the regional and global economic arena.

Others are; Algeria, Algeria has a GDP of \$266 bn, primarily fueled by its abundant natural resources, notably oil and gas, which drive its economy through hydrocarbon exports.

Nigeria often hailed as the "Giant of Africa," holds the fourth position on the list, and has a GDP of \$252 bil-

With its expansive population and rich endowment of natural resources, particularly oil, Nigeria harbours the potential to ascend as one of the globe's foremost economies. Ethiopia. Ethiopia commands a GDP totalling \$205 bn.

Morocco with a GDP of \$152 bn, Kenya boast of a GDP of US\$104 bn, Angola has a GDP totalling US\$92 bn, Cote D'IvoireCote D'Ivoire has a GDP of \$86 bn, while Tanzania concludes the list with a GDP totalling US\$79

Australia-listed Walkabout has produced and shipped its first consignment of on-specification graphite concentrate from the Lindi Jumbo graphite mine, in Tanzania.

The shipment is destined for Europe, marking a milestone for the project during its commissioning phase.

The Lindi Jumbo mine's entry into the market comes at a time when there is a widening gap between Chinese domestic and international prices.

ite concentrate was shipped to Dar es Salaam for sale to Wogen under an exclusive offtake agreement. The sale forms part of a larger order from an end-customer in Europe.

## Saudi to sell 60pc of **Aramco to foreigners**

#### **RIYADH**

Foreign investors were allocated about 60 percent of the shares on offer in Saudi Aramco's \$11.2 billion stock sale, people familiar with the matter said, marking a turnaround from the oil giant's 2019 listing that ended up as a largely local affair.

The deal generated strong demand from the US and Europe, according to the people, who declined to be identified as the information is private. Funds from the UK, Hong Kong and Japan also backed the share sale that drew orders worth more than \$65 billion in total, the

During the oil giant's listing, overseas investors had largely balked at valuation expectations and left the government reliant on local buyers. The \$29.4 billion IPO drew orders worth \$106 billion, and just 23 percent of shares were allocated to foreign buyers.

Aramco shares initially fell as much as 1.4 percent in Riyadh on Sunday, the first day of trading after completion of the secondary offering, before retracing all losses and climbing about 2 percent.

The secondary offer drew about 450 funds, and more than 125 new international investors, people familiar with the matter said.

Aramco confirmed that a majority of shares were allocated to foreign funds. International institutional investors now hold about 0.73% of the firm, it said in a state-


A key draw this time is the firm's dividend, which is one of the world's biggest. Investors willing to look past a steep valuation and the lack of buybacks would cash in on a \$124 billion annual payout that Bloomberg Intelligence estimates will give the company a yield of 6.6 percent

Saudi Arabia drew enough bids to cover all shares within hours after it kicked off the deal. The offer closed Thursday and the kingdom stands to net at least \$11.2 billion in proceeds, excluding over-allotments – cash that will help fund a multitrillion-dollar push to transform the

The final pricing was towards the bottom half of a proposed range of 26.70 riyals to 29 riyals, though Aramco's stock has been trading below the top end since the deal was announced and closed at 28.30 riyals on Thursday.

The extent of foreign participation was closely watched, with Aramco's top executives holding a series of events in London and the US to drum up demand.

The Saudi government owns about 82 percent of Aramco, while the Public Investment Fund holds a further 16 percent stake. The kingdom will continue to be the main shareholder after the offering.

# UN chief urges international community to save oceans

#### **UNITED NATIONS**

Secretary-General Antonio Guterres on Saturday called on the international community to take urgent actions to save the troubled oceans.

"The ocean sustains and enhances all life on Earth, but our ocean is in trouble. And we only have ourselves to blame," the top UN official said in a message for World Oceans Day, observed annually on June 8. Guterres highlighted the impact of "climate change triggering rising seas," which not only threatens "the very existence of small island developing states and coastal populations," but also "are sparking extreme weather events that affect us all."

Other challenges include "ocean acidification destroying coral reefs," which risks marine biodiversity and local tourism, and "unsustainable coastal development, overfishing, deep-sea mining, unchecked pollution, and plastic waste wreaking havoc on marine ecosystems across the globe," he said.

Guterres described the Agreement under the United Nations Convention on the Law of the Sea for the "Conservation and Sustainable Use of Marine Biological Diversity of Areas Beyond National Jurisdiction," adopted in June last year, as "the most significant new treaty on ocean governance in decades."

### Israeli forces rescue 4 hostages in Gaza, at least 210 Palestinians killed during operation

#### JERUSALEM/GAZA

ISRAELI forces on Saturday rescued four hostages from the Nuseirat refugee camp in the central Gaza Strip, where, according to Palestinian sources, a bloody Israeli assault took place, killing at least 210 people and wounding more than 400 others.

Khalil Al-Dakran, director of al-Aqsa Hospital in Deir al-Balah in central Gaza, told Xinhua that many wounded Palestinians were sent to the hospital, with some of them later confirmed dead.

In a statement on Saturday, Hamas armed wing Al-Qassam Brigades denounced the Israeli assault in the Nuseirat area as "a complex war crime."

Ismail Haniyeh, head of the Hamas political bureau, also condemned the deadly Israeli strike, stressing that the Palestinian people "will not surrender, and the resistance will continue to defend their rights."

The Israel Defense Forces (IDF) said this hostage rescue operation had been planned for weeks and was jointly carried out by the army with the police's elite unit and the intelligence body Shin Bet, noting that a police officer was killed during the operation.

The rescued hostages were identified as Noa Argamani, 25, Shlomi Ziv, 40, Almog Meir Jan, 21, and Andrey Kozlov, 27, all of whom were abducted last October by Hamas while attending the Nova festival, an outdoor music event, in a rural area near the Gaza-Israel fence.

IDF spokesman Daniel Hagari said the four were located in two buildings at the heart of the Nuseirat camp. In videos released by the government, Israeli President Isaac Herzog and Prime Minister Benjamin Netanyahu spoke with Argamani over the phone.

Following the rescue of the four, 120 Israeli hostages remain held in Gaza, including 43 feared dead, according to the Israeli army. "We will do everything to get them back," Hagari vowed.

In the wake of the operation, Israel's wartime cabinet minister, Benny Gantz, postponed his expected resignation announcement planned for Saturday eve-

On May 18, Gantz threatened to resign from Netanyahu's government on June 8 if the cabinet did not

In a statement on Saturday evening, Netanyahu urged Gantz not to step down, stressing, "We must remain united in the face of the great tasks ahead of us." Gantz replied in a video, saying, "The challenges Israel faces remain as they were, and therefore, I say

to the prime minister and the entire leadership, even today, we must look responsibly at how it is right and possible to continue from here."

Meanwhile, on Saturday night, tens of thousands of people demonstrated in Israel's Tel Aviv for the release of the remaining hostages and against the government.

The police declared the demonstration illegal and announced the arrest of 10 protestors on suspicion of violating public order, according to a police statement.

Earlier in the day, Israel's state-owned Kan TV news reported that the Israeli wartime cabinet approved a

pilot plan presented by Defense Minister Yoav

Gallant to replace the rule of Hamas in Gaza. According to the plan, the Israeli army will "protect" several areas in northern Gaza and allow the presence of local leadership and the entry of humanitarian aid trucks.

The deadly conflict between Israel and Gazaruling Hamas has raged for eight months since its start on Oct. 7, 2023. It erupted as Israel launched a large offensive in Gaza after Hamas militants stormed southern Israel from Gaza in a surprise attack, killing around 1,200 people and taking about 250 hostages back to the Palestinian en-

The Palestinian death toll from the ongoing Israeli attacks in the enclave has risen to 36,801, with 83,680 people injured, as updated by the health authorities in Gaza on Saturday.

#### FAO appeals for support to vulnerable Ethiopians

THE United Nations Food and Agriculture Organization (FAO) on Friday called for urgent agricultural support to vulnerable Ethiopians facing extreme weather events and conflicts.

**ADDIS ABABA** 

Noting that the East African country faces major humanitarian challenges, mainly driven by climate and economic shocks, armed conflicts and food chain threats, FAO, in its latest Ethiopia humanitarian response plan report that was issued on Friday, said climate-related shocks have left the country particularly vulnerable.

"The combination of these extreme weather events, conflicts and other shocks is deteriorating the food security situation in the country. An estimated 21.4 million people are in need of humani-

tarian assistance across the country, of whom 13 million require agricultural assistance," said the latest FAO report.

FAO said the challenges are underlined by economic and physical constraints that hinder access to key food commodities, even when adequate production has been achieved at the national level. It stressed that restoring

livelihoods is fundamental to the humanitarian response, as over 80 percent of Ethiopians live in rural areas and rely on agriculture to feed and provide for themselves.

According to FAO, timely agricultural assistance will enable households to produce enough food to feed their families for at least six months and reduce any further increase in food insecurity that could peak from October 2024 into 2025, if no help is provided.

#### Xi Story: Safeguarding the Great Wall

#### **BEIJING**

BRAVING the scorching summer sun, Liu Hongyan, 44, wearing an orange vest and carrying a litter picker, treks through waist-high bushes across rugged terrain for about 20 minutes to reach her destination: a 10-km stretch of the Great



Liu and her fellow villagers in Shixia Village, located at the foot of the iconic Badaling section of the Great Wall, are among thousands of Great Wall rangers across the country dedicated to protecting this UNESCO World Heritage Site.

They pick up trash along the Great Wall and inspect bricks for cracks caused by weathering or damage from

Recently, Liu and her fellow villagers wrote to Chinese President Xi Jinping, telling what they had done to protect the Great Wall and the changes taking place in their vil-

In his reply, Xi (pictured), also general secretary of the Communist Party of China Central Committee and chairman of the Central Military Commission, said he was pleased to learn about the villagers' commitment over the years to protecting the Great Wall, passing on the Great Wall culture, and leveraging its resources on their way to prosperity.

Protecting the Great Wall is a long tradition in Shixia. The baton of Great Wall protection was passed on to Liu from her 80-year-old uncle, who had devoted himself to the cause as a volunteer since four decades ago.

The Great Wall is the largest-scale existing cultural heritage in China, consisting of walls scattered across 15 provincial-level regions, with some sections dating back 2,000 years.

In China, safeguarding the Great Wall is a collective responsibility that spans from the top leadership to citizens at the grassroots level.

"When people mention China, they think of the Great Wall, and when they talk about Chinese civilization, they also think of the Great Wall," Xi once said.

It embodies the great resilience of the Chinese nation, which is united as one, like a fortress, and ceaselessly pursues self-improvement, he added.

Since assuming the Party's top office in late 2012, Xi has paid close attention to activities that celebrate and protect the cultural value of the Great Wall, and issued multiple instructions to guide the establishment of a Great Wall national cultural park.

In 2019, a plan to build the cultural park was approved at a leadership meeting chaired by Xi.

During an inspection tour to the northwestern province of Gansu in the same year, Xi visited the Jiayu Pass, the starting point of a Ming Dynasty (1368-1644) section of the

He ascended to the rostrum of the pass to view the layout and terrain of the fortress, which underwent a major renovation in previous years. "We must salute efforts to keep our history and culture alive and strong and strive to preserve our roots for a prospering Chinese spirit," Xi

Over the years, new progress has been made in the conservation of the Great Wall. In Beijing, an all-encompassing system that includes regular repair, emergency reinforcement, preventive measures and daily maintenance has been established.

In addition, high-tech means, such as drones and satellite images, have played an important role in discovering damage with greater speed and accuracy.

For the Great Wall rangers, their endeavors in preserving this iconic cultural heritage also benefit them and fellow villagers. Leveraging its resources related to Great Wall culture, Shixia Village, like many other villages nestled near the wall, has transformed into a popular destination for rural tourism with homestay and restaurants.

In his letter to villagers in Shixia, Xi expressed the hope that they will continue to protect the Great Wall with the same dedication as they protect their own homes. He emphasized the importance of passing on this precious heritage to future generations.

"We will double down on our efforts to protect the Great Wall, promote its culture and better tell its captivating story as required by General Secretary Xi," said Liu the vil-Xinhua lager.

### Genuinely secure world should be one featuring deep integration, interdependence

SECURITY is a common need for countries around the world, but there are always some individuals who, under the guise of safeguarding security, deliberately create risks.

They view the interdependence formed among nations due to economic globalization as a threat and use the pretext of security to create scientific and technological barriers and sever industrial and supply chains, which causes impacts on global economic development and stability.

The mindset of zero-sum game characterized by binary opposition has long been a thing of the past, and a genuinely secure world should be one featuring deep integration and interdependence. Creating division and confrontation with the zero-sum mentality goes against the goal of maintaining security and only leads to collective inse-

In 1996, American columnist Thomas Friedman proposed the theory of "Golden Arches Theory of Conflict Prevention," suggesting that two countries that were sufficiently developed to support a McDonald's would not fight each other because the benefits brought by economic globalization would outweigh the desire for war.

At that time, economic globalization was widely seen as a positive force beneficial to global development and security. However, today, with the trend of economic globalization, some individuals have developed an unfounded "cooperation phobia," constantly seeing imaginary threats.

In this world shaped by economic globalization, goods, capital, people, and information flow around the world ceaselessly, and interdependence among nations has become the norm. Viewing the world through the mindset of zero-sum game and baselessly hyping so-called security threats are severely disconnected from realities and deviate from the historical trend of development.

Every country has security needs, but abusing the concept of security will only harm a country's own security in the

long run. Once obsessed with the so-called absolute security, and arbitrarily expanding the scope of security, country would incline to closed-door policies and exclusion, resulting in misallocation and waste of development resources. Externally, it is prone to creating "imaginary enemies" and getting caught in zero-sum games, undermining normal international coopera-

Past and current experiences show that countries engaging in mutually beneficial cooperation based on market principles not only contribute to each other's development but also help foster healthy and stable relation-

Over the past few decades,

the international system has maintained overall stability and order, which is to a large extent attributed to the continuously improving mutually beneficial cooperation amidst the tide of economic globalization.

Distorting and undermining mutually beneficial cooperation between countries in the name of so-called security will only exacerbate misunderstandings, erode mutual trust, disrupt international relations, and create security risks.

From a long-term perspective, a world influenced by unilateralism and protectionism will be even more insecure.

In today's world, the interests, prosperity and security of countries are closely intertwined. The world will never return to isolation. When considering security issues in the context of economic globalization, one must maintain an objective and dialectical perspective.

Firstly, it is important to abandon the misconception of absolute security and adhere to the concept of common security. Adopting a double standard of demanding other countries to open up while closing one's own doors in the name of "derisking" will only hinder both development and security, and ultimately lead to backfiring.

Secondly, all parties should recognize that seeking security and promoting cooperation are not contradictory, and that absence of cooperation is the

opment the biggest insecurity. Risks should be reasonably defined and prevented, without equating interdependence with insecurity. Major economies that have a significant impact on the world economy, in particular, should balance security and open development with a rational attitude.

Thirdly, in the face of problems that arise in economic and trade cooperation, it is important to stop turning business relations into political, security or ideological issues. Instead, countries should strengthen dialogue, manage and resolve the issues in accordance with relevant international rules.

## Cooperation with China helps Africa realize blue economy aspirations

AT midnight, fishers in Shimoni, a port village in southeastern Kenya's Kwale County, started their day by setting wooden canoes afloat from the shore. They turned on fish-attracting lights to lure in their catch, then relied on luck for the rest.

Three or four hours later, as dawn broke, they hauled in their nets and returned to shore, either jubilant with a bountiful catch or disappointed with a sparse one. Buckets of small pelagic fish, mainly anchovies, kept in ice, were given to the fish processing factory workers waiting on the shore.

"There were times when the market for anchovies was not good," said Abdi Dura, who has been fishing since the age of 15. "I managed to catch great quantities of anchovies but found no market. I used to take my catch to ladies who sold grilled anchovies on the street, and they always bid for a lower price."

Things have changed since Dura, along with hundreds of other fishers in Kwale, started working with China's Jinzai Food Corporation two years ago.

#### WIN-WIN COOPERATION

In 2022, Chinese Customs authorized the import of Kenyan aquatic products. Soon after that, Jinzai Food registered as an importer and established a processing factory in Kwale.

Every morning, after being delivered from the shore, anchovies are cleaned, sorted and boiled in salt water for two minutes to stay fresh for storage. Depending on the sunlight, they are then dried for four to six hours. When their weight is reduced to one-third of the fresh fish, workers manually sort the qualified ones for shipment to China.

The first batch of Kenyan anchovies for import to China was showcased at the third edition of the China-Africa Economic and Trade Expo held in 2023.

"Fishing is a rewarding vocation that has enabled me to educate my children, feed them, and pursue other businesses on the side," said Mohamed Chamira, a fisherman with 57 years of experience.

Chamira said over the past two years, he had partnered with a Chinese company, which helped him acquire advanced fishing techniques.

As the Chinese company inked partnerships with local fishermen and provided them with modern fishery facilities, Dura and his fellow fishermen perceived more opportunities.

"I aspire to own a large boat equipped with sophis-

ticated fishing gear. It is my prayer that Kenyans understand and appreciate the vast resources in the ocean. The ocean is a blessing for us and could provide employment to the youth," Dura

According to the African Union's Africa Blue Economy Strategy, the total gross value-added of fisheries in Africa is estimated to be 1.26 percent of the GDP of all African countries. The scale of Africa's blue economy is projected to increase to 405 billion U.S. dollars by 2030, and 576 billion dollars, creating 78 million jobs,

The African Union's 2063 Agenda identifies the blue economy as a strategic development priority for its members. However, challenges such as immature fishery technology, a lack of professional talents, insufficient investments and backward infrastructure remain to be addressed.

China's marine economy has maintained rapid growth, leading the world in fisheries processing and production, shipbuilding, marine engineering equipment manufacturing, shipping, and port construction and operation.

China has been carrying out fishery cooperation with nearly 20 African countries and their partnerships hold huge potential.

#### TALENT TRAINING

At the Aquaculture Research and Development Centre in Kajjansi, a town in central Uganda, Chinese expert Chen Taihua was crouching by a fishpond, checking on the brood as a local fish breeding technician fed the fish.

The Chinese-built agriculture center is an achievement under the framework of the Food and Agriculture Organization of the United Nations-China South-South Program, now in its third

In November 2022, Chen, along with eight other Chinese experts, arrived in Uganda to implement a three-year experiencesharing project. They applied advanced techniques tailored to the shore of the Gulf of Guinea in Accra, the capilocal conditions, such as implementing a 1,215-square-meter rice-tal of Ghana, has relied on fishing for hundreds of

fish system. The rice provides the fish with shelter and shade, while nitrogenous waste from the fish benefits the rice and reduces insects. Currently, the rice and fish form a mutualistic relationship, and 695 kg of rice has been harvested.

"Uganda is rich in aquatic resources. The problem is the locals' lack of professional knowledge. We compiled 400 copies of manuals on Ugandan aquatic species and their marketing skills to train local farmers," said Chen.

By March 2024, Chen's team had carried out pond farming technology and market sales training in 10 regions in Uganda, benefiting hundreds

Situated off the southeast coast of Africa, Madagascar is blessed with abundant fishery resources and is renowned for its shrimp grounds. In 2009, China National Fisheries Corporation (CNFC) acquired the poorly managed Madagascar Fisheries Company. It now exports about 1,000 tons of wild shrimp and about 4,000 to 5,000 tons of fish to China and the EU every year.

Sun Shengkang, a representative of the CNFC's Madagascar office, said the project has remained profitable over the past 10 years. It has paid a total of 9.2 million dollars in taxes and 1.9 million dollars in resource management fees to Madagascar's government, creating an average of 450 jobs each year, with more than 90 percent of its employees comprised of locals.

"After I completed my studies in accounting, CNFC recruited me in 2015. Over the years, I have gained valuable work experience, and my salary is sufficient to support my family," said Razanadravaoarimanga Annissah, an accountant at CNFC's Madagascar Fisheries Company.

"The company even funded my further studies, and I've obtained my master's degree in management. I would never have had that opportunity without my company's support," said Annissah, who also met her sailor husband at CNFC and now has a happy family.

Shipping activities and modern port cooperation between China and Africa are also rapidly

Jamestown, a traditional fishing community on

years. In August 2020, a China-aided Jamestown Fishing Port Complex project commenced construction.

With a fully functional dock, spacious fish market and a fish processing plant, the modern fishing port is expected to be handed over soon. It will become a complex where fishermen can dock their boats, unload, maintain facilities, store fish, and conduct trading and additional processing activities.

"I cannot wait to see the port put into practice. It will not only improve the working environment and living standards of fishermen but also make Jamestown a neat community," said Paul Owusu, a resident of Jamestown.

According to Jin Xiaodong, general manager of the fishing port project, the modern fishing port will undoubtedly bring new impetus to Ghana's development in fishery. "We are very happy to contribute to the local economic and social development. It is a fruitful result of the friendship between China and Ghana."

In 2016, China Road and Bridge Corporation completed the expansion and reconstruction project of the old Bata port, helping Equatorial Guinea maximize its regional competitiveness in the Gulf of Guinea.

In 2023, Tanzania's first modern fishing harbor. Kilwa Harbor, constructed by China Harbor Engineering Company, was launched. As a flagship project of the Tanzanian government's third fiveyear plan, it is expected to become an engine for economic growth.

Earlier this year, Nigeria's first deep seaport, Lekki Port, developed by a Chinese enterprise, welcomed its largest container ship in history, making Nigerians' longtime dream a reality.

"China has not only supported us in port construction but also provided valuable help in agricultural and fishery technologies. Through the introduction of advanced technology and equipment, our agricultural and fishery output has increased substantially, and the earnings of farmers and fishermen have also seen a notable increase," Abdallah Ulega, minister of livestock and fisheries of Tanzania, told Xinhua.

"I believe that under joint efforts, China and Africa will continue to work together to achieve common prosperity in the vast sea," he said

### Political violence surges in Europe amid rising polarisation

#### **BRUSSELS/BUCHAREST**

THE attack on Denmark's Prime Minister Mette Frederiksen (pictured) on Friday serves as the latest indication of a troubling surge in political violence sweeping Europe, amid the ongoing European Parliament (EP) elections.

Over the past few months, attacks or threats on politicians in Germany, Spain, Ireland, and other European nations, notably including the attempted assassination of the Slovak prime minister and threats against leaders in Poland and Hungary, have further emphasized the growing violence in European politics. Analysts predict that this wave of political aggression is unlikely to dissipate quickly after the elections, as the underlying causes of these violent acts are deeply complex and multifaceted.

#### **SURGING VIOLENCE IN** POLITICS

Days after the shooting of Slovak Prime Minister Robert Fico on May 15, the German Interior Ministry released a report showing that politically motivated crimes in Germany rose by 1.9 percent year-on-year in 2023, reaching a record high of 60,028

Both Chancellor Olaf Scholz's Social Democratic Party (SPD) and its coalition partner, the Greens, as well as the opposition right-wing Alternative for Germany (AfD), have been affected, sparking concerns in the country. German sociologist Wilhelm Heitmeyer noted that the AfD's nationalist rhetoric has shifted public discourse towards the extreme right, while left-wing extremists respond with equally radical positions. These tit-for-tat exchanges have escalated social conflicts, creating a political environment inclined to exert vio-

In France, the Interior Ministry recorded 2,387 reports of physical or verbal offense against political representatives in the first three quarters of 2023, some of them violent. Igor Mekina, editorin-chief of Insajder.com, a Slovenian news website, contextualized the recent violence within Europe's long history of tensions between nations.

He said opposing centers of power and their disputes have been Europe's greatest strength, as well as a curse, from ancient times to medieval city-states and modern Europe. Political events, such as elections, campaigns and protests, can act as catalysts, bringing underlying tensions and grievances to the fore.

A week ago, a German policeman was stabbed to death during an attack on a right-wing demonstration. The attacker also severely injured six others with a knife.

#### **POLARIZATION &** INSECURITY

According to exit polls in the Netherlands on Thursday, the first of the 27 European Union (EU) member states to vote for



the EP elections on June 6-9, the far-right Dutch Party for Freedom (PVV) is projected to make big gains, in line with pre-election predictions of a rise in populist right sentiment across Europe.

Eric Maurice, an analyst at the European Policy Centre, noted a rise in the political extremes, on both the right and the left, ahead of the EP elections, characterized by increasingly pointed language, and even verbal violence or ad hominem attacks, during politi-

Political polarization plays a significant role in the recent spate of violence. As political camps exchanged debates in their campaigns, a more aggressive political environment has been widening divisions on vital issues such as the Russian-Ukraine conflicts, immigration, ecology and secu-

Mekina argues that Europe is increasingly becoming an extension of U.S. influence following the Cold War, particularly in its stance on the Russian-Ukraine conflicts.

This conflict on Europe's bor-

ders has mounted pressure on the continent, exacerbating internal disputes and fostering a black-and-white political mindset where extreme actions become more conceivable.

Economic instability is another critical driver of political violence. Unlike Asia and the United States, Europe's post-pandemic recovery has been sluggish. The combined impact of the energy crisis and high inflation has further increased insecurity in Eu-

Geopolitical tensions, economic challenges and disputes over migration cannot be easily solved by the upcoming European Parliament, at least in the short term, but these issues will still erode the public's trust in political insti-

Such public distrust can also explain why some individuals resort to violence to radically express their ideological stance. A Bertelsmann Foundation study released in February showed that 52 percent of young adults (aged 18-30) expressed distrust in the Federal Government and 45 percent have little confidence in the parliament.

A similar report by the Netherlands Institute for Social Research highlighted increasing public dissatisfaction with the Dutch government, with onethird of citizens advocating for more severe actions against the government and nearly 20 percent believing the system should be overthrown. **Xinhua** 

### Lavrov slams Paris' claims about absence of French instructors in Ukraine as lies

THE statements of the official Paris that there are no French instructors in Ukraine are nothing but lies, Russian Foreign Minister Sergey Lavrov said.

"Look how our French colleagues have become active, the French Prime Minister [Gabriel Attal] suddenly started saying that we (France - TASS) have no instructors there. This is not true, and they know it," he told reporter Pavel Zarubin.

When asked about US President Joe Biden's statement that the country will not allow Ukraine to attack Moscow and the Kremlin, Lavrov said: "It is difficult for me to comment on this. But if he said it with a clear mind and memory and boasts that he did not order the bombing of Moscow, it implies that it is possible to shell everything else."

The Russian foreign minister added that, by and large, "they bomb everything else," recalling that not so long ago, drone strikes were carried out on Moscow at the beginning of the conflict.

"Then no one then stopped the regime of [Ukrainian President] Zelensky. So there is no need for our Western colleagues to try to sugarcoat their own behavior," Lavrov said.

West understood Putin's words about possible arms deliveries to other regions

The West has heard and understood Russian President Vladimir Putin's words about possible deliveries of Russian weapons to other regions of the world in response to the delivery of weapons to Ukraine, Foreign Minister Sergey Lavrov

"I have no doubt that they have heard it. I have no doubt that they understand it. There are still people there who know how to analyze and not just engage in escalation to please their radical electorate every day before another election campaign. I think they have understood and will draw conclusions," the top diplomat told reporter Pavel Zarubin.

"This is absolutely, as they say, a symmetrical response. If you arm our enemy, we will decide for ourselves how to respond to your hostile actions," he said of the signal Moscow is sending to the West.

Speaking at a plenary session of the St. Petersburg International Economic Forum (SPIEF), Putin said that Russia has not yet supplied long-range weapons to the West's enemies, but reserves the right to do so in response to the arming of Ukraine.

# Festival for vulnerable children to promote psychosocial therapy

A TOTAL of 1,400 vulnerable children who live in slums in Temeke, Dar es Salaam were participating in sports and games festival to improve their self-esteem, social skills, build confidence as well as promote psychosocial therapy.

Vaileth Godwin, Women in Social Entrepreneurship (WISE)'s Program Manager, made the statement recently when speaking to journalists about a sports festival that took place at Gwambina sports grounds located in Temeke Municipal Council, Keko Mwanga and Keko Magurumbasi primary schools.

The event involved several teams from Keko Mwanga B Ward who take part in different sports and games that included football, acrobatics, volleyball, sack race, chicken racing, tug of war sport, drums, lemon, spoon game, and others.

The event was organised by WISE with funding from a South Koreanbased Charity organization - Holt Children's Services Incorporation.

"We have decided to come up with this programme after identifying that vulnerable children also need sports and games as one of psychosocial therapy," she said.

According to her, if children feel good about themselves, they can learn better. Sports give children confidence and a sense of worth and when a child does better at sports should be also supported and appre-

"As WISE will continue to support them because participating in sports and games helps children to improve their physical fitness, release stress and anxiety levels, make them feel happy and valued in the community, overcome their challenges, provide children with chances to develop problem-solving skills, manage emotions and behavior and inspire positive social change," she said.

Also helps them to cooperate> Students who have strong social skills develop more positive relationships with peers and are more likely to succeed academically and in life. These skills include communication. cooperation, and problem-solving,

According to her, children who are under pressure at home or school when participating in sports and games forget about the burdens of life and get better social interaction than those who don't.

They also have a more positive attitude towards life and are less likely to engage in bad things like drugs, suicide, and unplanned pregnancy, she added.

Sports and games help them to open up new opportunities in the future and a pupil who is excellent in physical activities will have a bright future and children who are into sports can turn it into a career.

This has been possible through a three-year project dubbed: ~To Improve Welfare of Most Vulnerable Children Lives in Slums in Temeke Municipal Council".

During the event, children got a chance to show their talents and win the best prizes that included exercise books and pens, while others went away with hens to attract other vulnerable children to participate in other upcoming sporting events.

According to her, family challenges such as divorce, financial issues, and conflicts have been cited as key factors that prevent children in Keko Ward from participating in sports and games and affect a child's performance in school.

These challenges can put stress on a child's emotions and contribute to loss of focus or acting out at school that is why WISE has decided to introduce a new programme that will make them happy and reduce the stress they have within their localities and school as well.

According to her, when household chores are poorly organized and planned by parents, it reduces the rest period of children and prevents them from having sufficient time to play with their peers.

Parents were also gathered to watch the event to enable them to understand children have a right to play sports with their peers.

# Denmark a fresh start for Tanzanian ace Kelvin John

FTER having a threevear stint with Belgium's KRC Genk, Tanzanian striker Kelvin John recently secured another chance to redeem himself after sealing a move to Danish side, Aalborg, which has recently made its way back to Denmark's top-flight football.

John arrived at KRC Genk with so much hope as Tanzania's soccer fans hoped he would prosper for the Belgian club, as was the case for the outfit's former striker and Taifa Stars' captain Mbwana Samatta- who now plies his trade in Greece with Greek Premier League champion PAOK Thessaloniki.

Per KRC Genk history, many players have used the team as a platform for a move to one of the other Europe's top leagues.

Samatta is a vivid example given he moved to England's Premier League club, Aston Villa, after impressing in Belgium's Jupiler League and UEFA Champions League with the Belgian

After Samatta, it means if John had met the expectations of KRC Genk, the Belgian outfit would have exhaustively monitored many players in the Tanzania football scene but, after John failed to impress, eventually the club would not trust our country's soccer players.

KRC Genk's trust in Tanzania's footballers was in John's hands, I am not sure if the youthful striker knew he was in Europe for that reason, if he knew this reason, he would have had an extra push to strive for great-

In Ivory Coast, Morocco, Senegal, Mali, and Nigeria players might not get this push because there are many players in Europe, and every player can be replaced, unlike Tanzania which has extremely few players in Europe.

Tanzania's soccer enthusiasts might have questions to ask, one of which is, is this a huge move for John or a step back for him?

When one looks at his age, he still has many years ahead of him to excel, now that he is 20.

He can grow and become a top player.

In analytics, John's career has gone backward and the youngster knows it. His soccer role model, Samatta, elevated his game and went on to ply his trade in England's Premier League, he did not move to any of the European lower leagues.

Aalborg might be one of the oldest teams in Denmark but the outfit's development in terms of players and battling it out in top levels is questionable.

Denmark has top teams including FC Copenhagen, which keeps battling it out in the UEFA Champions League. For that matter, signing for Aalborg is somehow not a bad move but is, to a great extent, a challenge for John.

KRC Genk is a good sign of team development in Belgium. The European country's other clubs like Gent, Royal Antwerp, Anderlecht, and Standard Liege have also become a bridge for players from various parts of the world to secure a move to Europe's top five leagues.

Belgium is behind Spain, England, France, Italy, and Germany in European countries with top leagues where most of Belgium's players go.

KRC Genk believed it would cash in some good money from selling John when the club signed him as a youthful player from Tanzania, a fee of around 12-16 million euros was reasonable for KRC Genk to sell John.

They had signed a young footballing ace from Tanzania who had proved his worth in national team ranks through his extraordinary talent. He was nicknamed 'Mbappe' because many soccer followers believed he had what it takes to play at the top level of European football.

KRC Genk was the only club that had confidence in John to become a top player in Europe because Samatta had already opened doors and proved that there are Tanzania players that can generate profit.

However, John could not live up to the expectations of KRC Genk and Tanzanians. Once he arrived in Europe at the right age with the ability to score goals, they were qualities that were enough to convince everyone that he was a top player in the country at his age.

Many believed he was the next Samatta, if not better than Samatta, what Tanzanians saw in John is exactly what Genk saw in the youthful striker.

His development has though gone backward since he arrived at KRC Genk, many also saw him play when he was called up for the senior national team. At KRC Genk, he was sent to the club's junior team, Jong Genk, to improve his performance.

The striker should also be careful with disciplinary issues. In the senior national team, he was said to have fallen out with the then-head coach, Belgo-Algerian Adel Amrouche, due to misconduct the forward committed. The misconduct is yet to be disclosed, which is good for the player when preserving his

With the nature of Tanzania football fans, such misconduct should remain a secret, given the majority of them do not know how to forgive and forget once a player does something wrong.

What is painful to many fans about John's move to Denmark is that Tanzania has few players in Europe and Asia and, when it comes to Europe's top leagues, the country has no player in such leagues.

Tanzania needs the prowess of players like John in the senior national team, which has seen local players dominate in callups due to a lack of top players

His experience would be vital in the senior national team, especially in high-profile continental competitions like the Africa Cup of Nations.

Tanzania, moreover, needs foreign-based players' community development initiatives like what Samatta has continued to do with this foundation, which is focused on changing people's

The East African country needs players that will make the next generation believe football is a reliable source of income and wealth so that more players can be used as a case study, the country needs many of its players to excel in Europe.

It is not a surprise that the country is still relying on Samatta, despite the player slowly inching closer to the twilight of his career, because many believed John would excel and what is happening to him is not something that Tanzanians are happy with.

Many wanted to see him light up the UEFA Champions League with one of the outfits in Europe's top five leagues. A move to Denmark's Aalborg is a chance for John to review his three-year stint with KRC Genk and know what went wrong for him during his stint in Belgium.

One of the best ways an individual can develop is by realizing where it all went wrong for either him or her. If he/she does that, there is room for him/her to bounce back, many players have done that after being left by their clubs at either a young age or mature stage and flourished in other clubs.

With John now aged 20, I believe Denmark can be a place where he can build his confidence with less pressure and expectations since there is a sense of being written off by fans. A change in attitude and focus on the game will elevate the youthful forward's game.

Football is on his legs, if he plays for his country, he will develop into a top player the way Samatta did - putting the country's interest first-because he knew the merits of such an attitude.

It's part of what makes Mazzulla tick. He truly believes that coaches can help other coaches whether the games are the same or

"I think as you get into this, you start to realize, once you're in a position, nobody can really relate to you other than people in those positions," Mazzulla said Saturday in Boston, where the Celtics will play host to Game 2 of the NBA Finals against Dallas on Sunday night. # Foden, Wirtz and Yamal among the players who could light up Euro 2024

HE Associated Press takes a look at some of the players expected to light up the European Championship in Germany which kicks off on Iune 14.

#### PHIL FODEN (ENGLAND)

Nurtured with care by Pep Guardiola, Foden has taken some time to break through to world-class level. He's there now - and the Manchester City forward is heading into a major international tournament as a certain starter for England for the first time and as the Premier League's best player this season. While defenses occupy themselves with Harry Kane and Jude Bellingham, it might be Foden who benefits the most with his quick feet and eye for goal. Where he starts - as an attacking central midfielder or on one of the wings – will be interesting to see. But he will start, and that's exciting for England fans who have been waiting for Foden to blossom.

#### FLORIAN WIRTZ (GER-MANY)

A player in the mold of Foden – and maybe another Man City player in Jack Grealish because of his low-slung socks – is Wirtz, who has established himself as a standout in the German league at newly crowned champion Bayer Leverkusen. At age 21, Wirtz is a No. 10 with amazing balance, technical ability and creativity who dovetails

that with a relentless pressing game - something demanded of attacking players in the modern era. Once the youngest scorer in Bundesliga history (at age 17), he was one of the youngest ever players for Germany and scored against France after seven seconds in March. It was thought to be the fastest international goal ever before that record was broken later that day. This is his first major international tournament – a knee injury ruled him out of the 2022 World Cup – and surely won't be his last.

#### **LAMINE YAMAL (SPAIN)**

The old saying "if you're good enough, you're old enough" certainly applies to Yamal, the Spain winger who was 15 years, 9 months and 16 days when he made his debut for Barcelona and will still be 16 when Euro 2024 begins. Ya-

mal, born near Barcelona to a mother from Equatorial Guinea and a father from Morocco, is the latest prodigy to come out of Barcelona 's famed La Masia academy and he hasn't stopped breaking records. The youngest player to debut – and score – in the Spanish league, the youngest to start in the Champions League, the youngest to score for Spain's national team and the youngest to score in a European Championship qualifier. Fast and direct, Yamal already has quite a presence despite his

#### RAFAEL LEAO (PORTU-

Portugal will one day arrive at the post-Cristiano Ronaldo era and the team will need an attacking star to build around. Leao has the ability to be that player, even if his standout than many at AC Milan would is still the main man. Modric have wanted this season. Leao's talent is clear – he is one of the world's most exciting wingers and few are able to run with the ball with such pace, power and athleticism. A reported release clause of 175 million euros (\$190 million) is testament to that but there's certainly room for improvement with Leao, particularly when he hasn't got space to run into and he is tasked with breaking down packed defenses.

#### KHVICHA KVARATSKHE-LIA (GEORGIA)

Georgia's success at its first major tournament might boil down to the performances of a winger whose playing style and status at Napoli is such that he has gained the nicknamed "Kvaradona" -in homage to the late Diego Maradona, who also played for the Italian club. A relative unknown when he joined Napoli in the offseason of 2022 from Georgian club Dinamo Batumi, Kvaratskhelia is now one of Europe's most exciting attackers and the poster boy of the Georgia national team that qualified for the Euros through the playoffs. Listen to the decibel levels rise among Georgia's fans whenever he gets the ball.

#### **LUKA MODRIC (CROATIA)**

Now 38, Modric finished the season at Real Madrid largely as a substitute who entered in the second half to bring more control and see out games. performances have been rarer Don't worry: for Croatia, he

might no longer be the force he once was but his technique, vision and game-management is still at a level that will set him apart from most central midfielders at Euro 2024. It was only 18 months ago that Modric, the guy who in 2018 broke the decade-long Ballon d'Or hegemony of Lionel Messi and Cristiano Ronaldo, was one of the best players at the World Cup as Croatia upset the odds to reach the semifinals. #### **SLOVAKIA**

It's the third European Championship in a row for Slovakia. While Czechoslovakia won the title back in 1976, Slo-

vakia's best result since its split with the Czech Republic was getting to the last 16 in 2016 before a one-sided 3-0 loss to Germany. This will be the first time Slovakia has played at a major tournament without midfielder Marek Hamsik, whose retirement last year left a big hole in the squad. Results since then have been mixed, but there's still plenty of experience in the squad, led from defense by captain Milan Skriniar of Paris Saint-Germain, along with two 37-year-olds, right back Peter Pekarik and midfielder Juraj Kucka.

#### **ROMANIA**

The only other team in Group E besides Belgium to qualify unbeaten, Romania impressed by winning a group that also contained Switzerland and Israel. Still, Euro 2024 will test a squad sorely lacking in top-level experience. Tottenham defender Vlad Dragusin is the only member of the squad playing regularly for one of Europe's top clubs this season – and even he played only nine Premier League games since signing in January. Goalkeeper Horatiu Moldovan is a backup at Atletico Madrid. There's a connection to the glory days of Romanian soccer with midfielder Ianis Hagi, son of Gheorghe Hagi, who helped the team to the quarterfinals of the 1994 World Cup and Euro 2000.

YOUNG Africans have reported record revenue of Tsh22 billion for the financial year 2023/24.

The figure is 22% up on the previous 12 months, but the club still reported a deficit of Tsh 1.1 billion.

The club celebrated another successful campaign in the just ended season, completing a third successive domestic double as well as reaching the CAF Champions League quarter-finals where they got eliminated by South African giants Mamelodi Sundowns via a penalty shootout.

The figures were revealed at the enjoyed by the club. club's Annual General Meeting (AGM) yesterday, at the Julius Nyerere International Convention Centre (JNICC).

The wage bill has dramatically increased, thanks in part to the big signings of Pacome Zouzoua among other new names and contract renewals, soaring to a whopping Tsh 7.4 billion from Tsh 5.4 billion, an increase of 27%.

At the same time, Matchday revenue fell 29% to Tsh 1.5 billion while income from membership fees fell by 27%, failing to match the success

Signings made at the start of the season also led to an increase in players' acquisition and registration fees, from Tsh 2.4 billion to Tsh 3.5 billion, a staggering 45% increase.

The club also announced a budget of Tsh 24 billion for the coming financial year. President Hersi Said reiterated their commitment to bolster the squad with new additions.

He also revealed pre-season arrangements that will see the club play international friendlies in South Africa and Kenya as they look to defend their Premier League and

Federation Cup titles.

"I promise the fans and members we will do heavy recruitment next season. Next season we will do big things starting from within and outside the Tanzanian borders. We will do a good pre-season. We have already received invitations from various places including South Africa."

"Kaizer Chiefs have sent us an invitation and Mr. Raila Odinga has asked us to join them at the launch of their stadium in Kisumu as well as one European country" said Engineer Said.
