Samia meets Mbowe at State House

RESIDENT Samia Suluhu Hassan yesterday received a report on the progress of political dialogue and reconciliation between the ruling CCM and main opposition party, Chadema.

A State House twitter page post accompanied by photos of President Samia together with Chadema national chairman Freeman Mbowe and CCM vice-chairman (Mainland) Abdulrahman Kinana, said the leaders met at the State House yesterday.

Those who commented on the post saying the meeting was a welcome move, raising concerns on the snail's pace to a new constitution and an independent National Electoral Commis-

Mukhsyn Khamis wrote: "Let the work continue, President Samia is a leader with a patriotic vision for our country; political diplomacy."

Sheshe wrote: "Amongst all, we need an independent National Electoral Commission and a new constitution."

"I am not comfortable with Mbowe's participation in the political reconciliation process," wrote Ray.

They met for the first time on March 4 in the evening, after prosecutors dropped terrorism charges against Mbowe after a drawn-out trial during which he and his three co-accused persons had spent eight months in remand prison.

The meeting focused on what next for the political scene, with the opposition leader later giving hints on possible areas of convergence.

"We have agreed that the best way to have political reconciliation is to ensure justice. We have gone through a lot of challenges; we should move forward and do our political activities without causing any harm to the government. We are hopeful that the government will support us in our activities so that everyone becomes happy," he told the party faithful.

The first reconciliation meeting between the top party leaders was held on May 20, at the State House involving a wider attendance than the president and the Chadema leader.

'Overcome barriers to employment for people living with disabilities'

THE government intends to make a further review of workplace facilities and employment strictures to create more access for people living with disabilities.

Patrobas Katambi, the Labour, Youth, Employment and People with Disabilities state deputy minister at PMO said here at the weekend that while the law is clear, many employers deny people with disabilities their rights.

He said the Persons with Disabilities Act, No 9 of 2010 clearly stipulates such rights but employers do not adhere to the Act. Some offices do not have friendly infrastructures and equipment for those living with disabilities, he stated.

He was addressing a meeting to discuss challenges facing people with disabilities in public offices. convened by Ikupa Trust Fund and bringing together over 150 persons with disabilities from across the

He said the president has directed the ministry to do all the needful to help solve challenges facing PWDs, underlining that the president had approved a 3bn/- fund to renovate colleges of people with disabilities, while another 3bn/- would be directed to build two new colleges in Mwanza and Kigoma.

Local government authorities and other employers need to comply with the law on people with disabilities, he said, noting that failure to do so

BMH adds third weight curbing surgery method

THE Benjamin Mkapa Hospital (BMH) has introduced two new methods of weight loss procedures, adding to equipment launched in 2019. Dr Martine Sindani, a bariatric surgeon at the BMH, said here yesterday that BMH now performs three types of weight loss procedures, the first being weight loss surgery used since 2019, known

as laparoscopic sleeve gastrectomy (LSG). Weight loss procedure is seen as a solution to reducing the threat of type 2 diabetes and some other medical conditions ignited by obesity. The other procedure is gastric balloon surgery, which involves placing a saline filled silicone balloon in the stomach.

There is also gastric band surgery, an adjustable and reversible procedure where a silicone band, the lap band

around the stomach of a person with obesity, where decreasing food intake is conducted by reducing stomach size. The person feels full sooner, he said. The two recent weight loss procedures are temporary, as failing to comply with the conditions set out, like dieting and exercising restores excess body weight, he stated.

The balloon and band types of surgery are reversible, he asserted, noting that the

first procedure is permanent as upwards of 75 per cent of the stomach is removed leaving a narrow gastric tube or sleeve.

The procedure involves inserting small instruments through multiple incisions in the upper abdomen, he stated, emphasizing that should balance starch foods and take regular exercise to restrain weight gain. Before weight loss surgery is conducted, a medical check-up seeking to find the body weight index (BMI) is conducted, such that a person with BMI 40kg/m2 and above is put to weight loss intervention such as LSG, expecting to recover within a month for usual routines.

The first successful bariatric surgery patient at BMH was Stella Makyao (40) of Sumbawanga District in Rukwa Region, who told this journalist in a telephone interview that she was doing well, up to the moment.

COVID-19: Morocco bans flights from China

RABAT

MOROCCO has banned travelers from China in a bid to stave off a possible new wave of coronavirus infections

A foreign affairs ministry statement said over the weekend that the restrictions would be extended to all people arriving from China regardless of their nationality.

The ban will come into force "from 3 January and until further notice", the statement added.

China ended its strict Covid restrictions in December, leading to a spike in cases. With some of the best vaccination rates in the world, Beijing says most of the cases after the reopening have been mild.

Chinese authorities also announced that the their borders would reopen for inbound and outbound travel starting January 8th, with travelers needing only to present negative PCR tests.

France, Italy, Spain and the United Kingdom, like the United States and South Korea, have also announced they would impose a Covid test on travellers coming from China.

The United States will impose mandatory Covid-19 tests on travellers from China beginning on January 5. All air passengers aged two and older will require a negative result from a test no more than two days before departure from China, Hong Kong or Macau. The Centres for Disease Control and Prevention also said US citizens should also reconsider travel to China, Hong Kong and Macau.

Meanwhile UK will require a pre-departure negative Covid-19 test from passengers from China as of January 5, the Department of Health said on Friday.

France also will require travellers from China to provide a negative Covid test result less than 48 hours before departure, the health and transport ministries said on Friday.

From January 1, France will also carry out random PCR Covid tests upon arrival on some travellers coming from China, a government official told reporters. Time for China's 'zero-Covid' roller coaster to come to an end.

African scholar upbeat about China's economy amid optimisation of COVID-19 response

NAIROBI

CHINA'S economy has proven quite resilient and innovative, with the outlook for the next year upbeat amid the country's latest optimization of COVID-19 response, a scholar has said.

"There are all indications that China's economic growth will be on an upward trend in the coming year," Cavince Adhere, a Kenya-based international relations scholar, told Xinhua in a recent interview.

The recently concluded Central Economic Work Conference in China has underlined the role of consumption in economic development and the role of innovation in economic transformation, he noted.

The scholar said Africa looks forward to another year of closer economic ties with China, which has been the continent's largest trade partner since 2009.

"China is welcoming more African agricultural produce into its largest consumer market. Fortifying the domestic market while promoting global trade by China will see an increased optimism in the economic recovery of the world," he said.

To better coordinate anti-virus efforts and economic development, China has optimized its COVID-19 response policies dynamically. In its latest move, China announced to downgrade the management of COVID-19 from Jan. 8, 2023, treating it as a Class B infection rather than a more serious Class A infection.

Regarding COVID-19 response, Adhere said China has performed well in coordinating pandemic response and economic and social development.

"China is currently implementing new policies aimed at sustainably overcoming the burden of the pandemic while facilitating renewed opening and integration into the global economy. This is welcome," he said.

"When most economies went into recession, China became one of the handfuls that registered positive economic growth," he said. As the world's manufacturing hub, China was the source of many industrial products that enabled other countries to put up a spirited fight against the pandemic and hoist global commerce, Adhere said.

China's gradual recovery from the pandemic has been

a boon for global economic recovery, said the scholar. In regions such as Africa, he said that Chinese companies remained active, implementing infrastructure and connectivity projects as other countries pulled their workforce from the continent.

Villagers in Kyela get clean, safe water

VILLAGERS in Kyela district, Mbeya region have started to get clean and safe water supply following implementation of the 7.9bn/- Ngana water project which was fully funded by the government.

Rural Water Supply and Sanitation Agency (RUWASA) manager in Kyela district, Eng. Tanu Deuli said the project was constructed in 1984 meant

to benefit villagers from 25 villages in seven wards. He said the project required expansion following population.

He said that the project has currently been serving six villages only, leaving the 19 villages without water services, thus forcing the government to decide to rebuild it.

"According to its design, it was supposed to be reconstructed after 20 years in 2004. It was not constructed in Ikolo, Bujonde, and Ngonga. that year but we are thankful to the government for providing funds to rebuild it," said Deuli.

Kyela Member of Parliament, Ally Jumbe said the project will benefit seven wards of the district as well as the Kasumulu town at the border between Tanzania and Malawi.

will benefit with the project as Njisi, Kanjunjumele, Ngana, Ikimba, Katumba-Songwe, He thanked the government

for allocating funds for the project, noting villagers will no longer experience water woes. He said apart from the 19 villages, the project will benefit other people living in nearby villages.

He asked the villagers He mentioned the wards that to protect the project's infrastructures so that it lasts for a longer period as the government has spent too

much money on it.

The project contractor, Suzana Chinoto said they are required to complete the project within a year, but they will work hard to make sure it is completed within schedule.

RUWASA Director, Eng. Clemence Kivegalo directed the officers to properly supervise the project and make sure it is constructed at required standards.

Eng Kivegalo asked the

Women, girls with disabilities raise concern over lack of sign language experts in Iringa

WOMEN and girls with disabilities in Iringa region have raised concern over lack of sign language experts at some important areas of community services, resulting in communication challenges for people with hearing impairment.

Speaking yesterday during a stakeholders meeting of the Tanzania Association of the Physically Handicap (CHAWATA), Iringa Region's Chairperson, Rukia Makweta said there are still places such as police stations, markets, churches and hospitals that do not have sign language experts which is an obstacle to communication for the deaf.

She said the association also works to tackle gender based violence against women and girls with disabilities at their workplaces.

"There are many forms of violence, but structural violence against people with disabilities, especially women and girls, is intolerable. We want such kind of violence reduced," said Makweta, adding the association provides education to the society on the issue of violence against women and girls.

Makweta commended the Action on Disability and Development (ADD) International Tanzania for empowering people with disabilities in Tanzania by enabling them

Community Development Officer, Iringa Municipal Council, Mwantumu Dosi said that currently all the constructed buildings must have friendly infrastructure for people with disabilities as well as sign language experts.

Head of the police gender desk in Iringa Region, Lydia Sospeter said that GBV cases against people with disabilities have been reduced. She said the remaining challenge is infrastructures as some places lack facilities for PwDs.

ADD International works to build an inclusive society that understands disability as part and parcel of human diversity and ensures that all development activities benefit

It works with 15 local disabled associations across the country. The associations have a total of 58,000 members.

In Tanzania the focus is to tackle exclusion of disabled children from all aspects of education, by working with activists to empower disabled children and their families to access education.

An estimated 60-80 million persons with disabilities live in Africa and the vast majority of them are poor and excluded from opportunities to write and study.

Government clarifies use of solar powered lamps in Lake Victoria

THE government has clarified that it hasn't halted the use of solar powered lamps during sardines (dagaa) fishing in Lake Victoria and called on fishermen to continue with their activities by adhering to the set laws and regulations.

According to the director of fisheries at the Ministry of Livestock and Fisheries, Emmanuel Bulayo, the government hasn't banned the use of the solar lamps but it emphasizes the fishermen to adhere to set laws and regulations when conducting their activities.

Addressing reporters during the

weekend here, Bulayi said in supervising protection of fishery resources adheres to the National Fisheries Policy of 2015, Fisheries Act no 22 of 2003 and its regulations of 2009 and their amendments of 2018, 2019, 2029 and 2022.

"So, on sardines fishing, there are rules and regulations that need to be adhered to by fishermen, and these are found in the regulation number 66 of Fisheries Regulations of 2009 and their amendment on the use of solar powered lamps in fishing," he clarified.

He clarified that the government through the Tanzania Fisheries Reconducted a study on all the lake's ecology.

solar lamps used for fishing, including those that are run by motorcycle batteries and those that use kerosene and then recommended solar lamps as the best lights that should be used in fishing.

fishermen should use solar lamps in their boat that do not exceed 90 watts which means that each lamp should not exceed 10 watts, this is where fishermen should be very careful and stop violating the set rules and regulations," he explained.

Bulayi said the research findings have confirmed that motorcycle batteries that use 'lead-acid' cause search Institute (TAFIRI) environment and affect to reach more fishermen.

said: government hasn't issued any order to limit the use of solar lamps as it is claimed by many. However, during the stakeholders meeting held in November 2022 "We then approved that in Mwanza Region, apart from other issues, it discussed this issue where it was reported that some fishermen were misusing the lamps, something against which goes sustainable fishing rules."

According to him, the meeting agreed that more education should be given to fishermen on the proper use of the solar lamps and the resolution has started to be implenegative impacts to the mented and will continue He further urged all and the general public to ensure that they continue with their activities but by only using friendly tools that have been approved by authorities as well as adhering to the country's laws and regulations. fishing tools, Bulayi said the government has a transparent system on the reliefs and subsidies where he called on solar lamp importers and traders to adhere to the current tax procedures.

He said the government will continue creating a conducive environment to promote sustainable fishing as well as attracting stakeholders to invest in various opportunities in the fisheries sector.

Tanzania foreign missions called to explore economic opportunities

PRIME Minister Kassim Majaliwa has directed officials in Tanzania's foreign missions to explore economic opportunities available in their countries to promote trade.

Majaliwa made the remarks when he addressed staff of the Tanzania's High Commission in Pretoria, South Africa where he said it was important for the country's missions to establish business platforms in various sec-

"Urge the business people and investors to come to Tanzania so that they open ventures and share knowledge," he said.

The PM said embassy officials have to create agreements with countries which will clearly state what is needed and available in those countries and what Tanzania can benefit.

Homera made the directives during the weekend when addressing a news conference on various issues including the TMA weather state-

He wanted district commissioners to work hard and supervise the assignment by ensuring that intensive cleanliness is conducted in all areas, especially crowded places, citing that during the rainy season, it is easy for epidemics to occur.

He pointed out that cholera is among the serious diseases and that without taking serious precaunegative impacts to people and the economy.

"So if a Cholera case occurs in any district here, the first person to be responsible for this is the District commissioner, so go and supervise this to ensure that our region is clean," he said.

He wanted the leaders to engage citizens in the sanitation plans so as to get joint effort that will facilitate everyone to fulfill his/her responsibility of conducting cleanliness in their home surroundings, streets, markets and sewerage.

Homera said after receiving the TMA weather alert information, he called a special meeting which then agreed that each council should set aside special funds to deal with the impacts which can be brought by the heavy rains.

He said that the safety and security meeting agreed to start taking precautionary measures including tal cleanliness in various streets of setting aside areas to accommodate

tion measures, it will bring massive victims which can be affected by the heavy rains especially floods.

"We have seen in some areas, where the rain has started bringing challenges, houses and crops in farms have been destroyed and we have extended support to the areas," he asserted.

He said that in Rungwe a number of villages have been affected where houses have been destroyed, banana farms and some schools were also destroyed and we have extended support to restore the

Watershed agroecological project empowers 400 Kongwa farmers

three institutions are working implemented by the Tanzania collaboratively to impart farmers in Kongwa district, Dodoma region with best agro ecological practices to overcome negative impacts of climate change.

The initiative which is also working to restore fertile land at the areas through use of friendly agro ecological practices has so far benefited more than 400 farmers.

Among the agro-ecological practices being injected to the farmers include creation of terraces for containing soil erosion, farmer managed natural regeneration (FMNR) for land restoration as well as tree planting management.

Ashura Dulazi, the researcher from the Tanzania Agricultural Research Institute (TARI-Makutupora centre) expressed that students from at least two primary schools and two secondary schools have so far been trained accordingly.

"We practically trained the students at the relevant schools on how best to create the FanyaJuu/ FanyaChini (FJ/FC) terraces which are the best and friendly way to overcome soil erosion," she informed.

"The training has so far attained fruitful results," the agro pundits expressed, added: "It's very fascinating that the students have positively grasped the relevant knowledge to the tune of creating the FJ/FC at their respective schools, ones to serve as technology hub (TH) for all members from the surrounding communities to learn how best to cheat soil erosion in their plantations,"

She further noted that the students have also received useful knowledge over coppicing of pigeon peas.

She disclosed the beneficiary schools as Moleti secondary school, Visumi primary schools, Laikala 'B' secondary school and Laikala 'A' primary school.

> Kongwa district has potential for the production of numerous key food and economic cash crops but the farmers have for years been failing to harvest enough due to severe effects of land degradation, primarily caused by unfriendly human activities.

> Research by the project established that deforestation and overgrazing, as well as poor farming methods were responsible for occurrences of mass soil erosion and soil infertility across the district, leaving aside the natural effects from climate change.

To further improve agricultural performance within the district, the practical-based project is also introducing the beneficiary farmers to improved drought tolerant seeds varieties to assist them heighten crop yields.

As part to ensure the project fetches needed sustainability, it has gone far to the tune of practically training the students at different primary and secondary schools within the beneficiary villages on the best agro ecological farming methods.

The project is benefiting smallholder farmers in the eight villages of Sagara 'A', Sagara 'B', Laikala 'A', Laikala 'B', Mlali, Nghumbi, Lengaji and Moleti.

"In implementing the project, TARI has a role to impart the involved farmers with useful knowledge on natural resources management, specifically in the areas concerning control of soil erosion as well as rain water harvesting through the use of tied ridges and the FanyaJuu/FanyaChini (FJ/FC) terraces," informed Elirehema Swai, the Coordinator for Research and Innovation at the Tanzania Agricultural Research Institute (TARI) Makutupora Centre).

He briefed that so far, a total of 230 farmers have successfully managed to install the (FJ/FC) Terraces nologies have helped the farmers in conserving moisture and preventing soil erosion, as well as in restoring soil fertility," he said.

Meanwhile, Peter Ngowi, a senior scientific officer (Natural Research Management) at the International Crops Research Institute of the Semi- Arid Tropics (ICRISAT) said their role was based on agronomy and provision of the drought tolerant seed varieties.

"For years, farmers in Kongwa district used to apply landrace seeds, and other 'low-yielding' varieties to the tune of realising poor crop yields, hence a need to introduce them to improved varieties," he stated.

Giving vivid example, he detailed that the dry spell experienced from mid-March 2022 on wards left many farmers who had grown maize in their fields with nothing as opposed to farmers who had planted improved varieties of sorghum (variety macia), maize (variety Tumbi 105, Situka) and pigeon pea (Mali) issued to farmers for planting by the Biovision watershed project.

Winnie Saigodi, a beneficiary farmer from Moleti village who owns and manage an acre of intercropped field of sorghum (macia variety) and pigeon pea (mali) expressed her gratitude for the good work that the project is doing in extending validated agro-ecological technologies from plot level to landscape level."My farm was completely destroyed by massive soil erosion caused by both water and wind but now my land has been restored and I am grateful for the good agro -ecological technologies that the project has taught me such as planting of shelterbelts which have tremendously been solved by fuel wood," she expressed.

Research depicts that, if not timely contained, climate changes will have significant impacts on Tanzania's rain-fed agriculture and will increase poverty and food insecurity, among others.



RUT equips Dodoma youth to obtain loans

THE Dodoma-based NGO Reaching the Unreachable Tanzania (RUT is implementing the youth economic empowerment tailor-made project, which has already benefited youth in four wards within the

Iyumbu, Dodoma-Makulu and Nzuguni wards of Dodoma capital city, the project has so far managed to mobilize youth to form special groups and register to the Ten Percent Management Information System (TPMIS), the vital portal to enable them to access the loans meant to support the youth as disbursed by the government through munici-

The project dubbed: "Promote Youth Financial Inclusion' two-year based project that aims to reduce the unemployment rate among youth communities in the fast-

According to RUT's Project Coordinator, Benjamin Masongi, throughout the project which kicked off in September last year, a total of 17 youth groups have so far been formed, out of which four groups have been officially regis-

"The focus is to impart the ben-

"Above that, the project will also major its focus to train the beneficiary youth over skills on the development of sober business plans evaluation and monitoring, in order to assure they stand a promised side to realize enough profit and thus, manage to repay their loans on framed time," he unveiled.

According to him, the project's vision was also to increase the commitment of local government officials to supporting the youth in their areas of jurisdiction.

"We're also working to sensitize and influence local leaders to expand their commitment and willingness in the execution of existing laws and policies that address the financial needs of youth," he added.

Vitus Msangazi, RUT chief executive officer (CEO) explained that through the capacity-buildingoriented project, the intention is to sensitize the beneficiary youth to form a productive group, at least 12 groups, in order to stand a better side to acquire the loans, but also to effectively venture into profitable economic projects.

"We have decided to introduce this project after conducting thorough research and establishing that most of the youth in Dodoma are conducting pretty business with no good profit, among others due to poor access to capital loans needed to help them expand their executions and profits," he observed.

According to him, to achieve the intended goals, the project will train the beneficiary youth in computer literacy as well as the application of other online platforms, added: "Most capital loans services are now available through online portals hence the need to educate the youth on relevant applications," Msangazi expressed that consid-

as well as the youth with different forms of disabilities.

"Consideration will be given to the youth who have already formed groups and are conducting different business, we're not much interested to deal with the fresh youths that are not doing any business," he

Apart from assisting the youth to acquire capital loans, he briefed that through the project RUT will monitor to assure the youth are running profitable businesses to help them escape from the shackle of poverty, but also manage to refund their loans.

RUT is a national voluntarybased non-governmental organization (NGO) established in 2016 by a group of young public health and community development specialists and got official registration in 2018. RUT works in the communities to address women and girls' health related issues including but not limited to Sexual and Reproductive Health, Nutrition, HIV/AIDS, Gender Based Violence (GBV), Climate Change, Water, Sanitation and Hygiene (WASH), Chronic and Non-Communicable Diseases (NCDs).

With its headcount in Dodoma Region, the NGO has already implemented some key projects, including a project against the prevalence of Female Genital Mutilation (FGM) in Dodoma region, a key initiative that reached at least 963 people.

With a crucial mission to improve Sexual Reproduction Health (SRH) for women and adolescent girls, the target of the project was to deliver to at least 3,550 potential populations (women and girls) but also to ensure at least 3,550 victims of FGM are reporting and seeking psychosocial support from relevant authorities.

The initiative which fetched impressive outcomes was implemented in the wards of Thawi, Mnenia Itololo and Busi in Kondoa districts, while in Kongwa it was based in Chamkoroma, Chitego, Lenjulu and Kongwa wards.

Tanzania needs sunflower sector development strategy

he sunflower seed is the seed of the sunflower. There are three types of commonly used sunflower seeds: linoleic (most common), high oleic, and sunflower oil seeds. Each variety has its own unique levels of monounsaturated, saturated, and polyunsaturated fats. The information in this article refers mainly to the linoleic variety.

For commercial purposes, sunflower seeds are usually classified by the pattern on their husks. If the husk is solid black, the seeds are called black oil sunflower seeds. The crops may be referred to as oilseed sunflower crops. These seeds are usually pressed to extract their oil. Striped sunflower seeds are primarily eaten as a snack food; as a result, they may be called confectionery sunflower seeds.

With an annual output of around 350,000 tonnes of sunflower oilseeds, corresponding to about 90,000 tonnes of oil, Tanzania is one of the top ten sunflower oilseed producers in the world.

Sunflowers are grown all over the country, mostly by small-scale farmers. Therefore the development of the sunflower oil sector has a great potential for improving livelihoods and the welfare of relatively poorer households.

The Dodoma region in the country's central zone is a major producer, accounting for over 20 per cent of national production. About half of the region's farmers are engaged in sunflower oil production, but few small-scale producers have realized the full potential of this sector, either in terms of improved quality or higher volumes. Among the factors contributing to low productivity and quality are inadequate machinery and limited or no access to value-added services and markets.

Since 2012, the United Nations Industrial Development Organization (UNIDO), in collaboration with Tanzania's Ministry of Industry and Trade, has been working to upgrade and modernise the country's agroindustry and improve the competitiveness of locally processed goods, including sunflower oil, on national and international markets.

Within the framework of the industrial upgrading and modernization project, a team consisting of UNIDO international experts and trained national consultants have provided enterprises with diagnostics services and assistance with implementing upgrading plans.

Micro- and small-scale oil producers in Dodoma were advised to form a cluster, invest in common facilities to store, clean and refine sunflower seeds, and to take joint marketing actions in order to enhance the productivity and competitiveness of their businesses. To this end, the project is currently helping relocate processors operating in residential areas to the Chamwino industrial park. The project has also enabled producers to access affordable technology for sunflower oil refining. Recently, UNIDO teamed up with the country's Vocational Education Training Authority (VETA) to help small businesses acquire modern machinery for refining and processing products. This has helped increase the competitiveness of the products and lead to a rise in in-

Farmers who have been using the now available technology to process their sunflower oil, said that the new machinery had helped them produce more refined oil, and as a result, they customers are happier and their product now had a chance to compete on a broader market.

Scholars have indicated that global religiosity may be increasing due to religious countries having higher birth rates in general.[14]

n Sunday, Nigeria will like the rest of the world enter the year, 2023. A New Year is always an opportunity to make new plans, make new projections, while taking cognisance of the progress or lack of it of the old year.

This self-appraisal has become customary for individuals and is also expected of forward looking states and nations!

Every reasonable nation must continue to strive to do better from year to year. In Nigeria, there are so many things we must change, so many pitfalls we should strive not carry over to 2023. As a nation and as a people, we must strive to do better in 2023. We must seek to correct the pitfalls of the last years so that our country will once again be a good place to live in unlike now where everyone wants to migrate.

The areas where efforts must be concentrated upon are economy, health care, education and infrastructure. The security situation is another major area that must be tackled if 2023 will turn out to be better for Nigeria. Indeed, the outgoing year had been terrible one for Nigerians.

The World Bank had cut Nigeria's 2022 growth forecast to 3.1 per cent from a previous forecast of 3.8 per cent. The World Bank said that the revision was due to slow economic growth in the third quarter compared to the year earlier. The nation was dragged down by the oil sector and a weak performance in other critical areas of the economy. Last month, the IMF cut Nigeria's 2022 real GDP growth forecast down to 3 per cent from 3.4 per cent earlier, citing weak oil production and the adverse effects of recent flooding.

Nigeria's inflation rate jumped from 20.77% in September 2022 to 21.09% in October 2022 as the country battles with soaring food prices. The National Bureau of Statistics (NBS) Consumer Price Index (CPI) report for October, noted that food inflation was 23.72% in October 2022, from 23.34% in September 2023.

The National Bureau of Statistics, NBS said that 133 million (63 per cent) Nigerians are suffering from multidimensional poverty, with children constituting more than half of poor people in the country.

This means that two out of every three Nigerians are poor and experience just over one-quarter of all possible deprivations in terms of health, education, living standards, and work and shocks. The NBS disclosed



this in the 2022 Multidimensional Poverty Index, MPI, Report.

The survey was a collaborative effort between the National Bureau of Statistics (NBS), the National Social Safety-Nets Coordinating Office (NASSCO), the United Nations Development Programme (UNDP), the United Nations Children's Fund (UNICEF), and the Oxford Poverty and Human Development Initiative (OPHI), therefore no one can doubt the report's authenticity and credibility.

The number of unemployed individuals in the country hit 23m in 2022, a report by Jobberman in collaboration with Young Africa Works and Mastercard Foundation showed. In the report titled, "Unmasking the Barriers to Women's Participation in Nigeria's Labour Market," Jobberman stated that Nigeria's active population was 122m out of a total population of over 200m.

The above figure of the unemployed Nigerians is bigger than the population of The Gambia and Senegal combined together which is about 19.6 million and 74 per cent of the total population of Ghana. Ghana has a total population of 31 million in 2021. These army of unemployed Nigerians are partly the reason the country is insecure.

About 1,743 Nigerians were reported killed in the first quarter of 2022 owing to insecurity, according to the data sourced and analysed by The-Cable Index, the data and research arm of TheCable.

According to the online newspaper, the figure surpasses the number of civilians reportedly killed in the first month of Russia-Ukraine war. TheCable Index analysed and reviewed daily media reports published between January and March 2022 as well as data sourced from the Council on Foreign Relations. From the data reviewed, TheCable Index found that an average of 19 Nigerians died daily in various violent attacks reported in the media from

January to March 2022. At least 7,222 Nigerians have been killed and 3,823 abducted as the country witnessed 2, 840 incidents of insecurity between January 1 and July 29, 2022. Also, no fewer than 1,499 people were injured during the various attacks witnessed in 505 local government areas in the country. These were contained in a data obtained from the Nigeria Security Incidents Tracker by Beacon Consulting.

The above scenarios are Nigeria's reality in 2022 and more. It does not have to be our reality in 2023, a year that holds so much promise. We have to admit that our politics is broken and we need to fix it.

The New Year being an election year provide perfect opportunity to fix our politics. We have allowed the money-bags to take over our politics.

This is largely because the Independent National Electoral Commission (INEC) has failed in its responsibility of monitoring spendings by political parties, while the Economic and Financial Crimes Commission (EFCC) and the Independent Corrupt Practices and Other Related Offences Commission (ICPC) as well as the Nigeria Police Force (NPF) and the Department of State Services (DSS) turned blind eye as politicians with alleged looted funds bought the tickets of political parties by bribing party delegates with millions of United States dollars. If not checked they are warming up to buy

votes in order to win in 2023.

In 2022, our economy is in dire straits. The managers of our economy have failed woefully. Our country is now unattractive to both local and foreign investors. Nigeria's fiscal position worsened in the first four months of the year

as the cost of repaying debt surpassed the government's revenue in the first quarter of 2022. According to details of the 2022 fiscal performance report for January through April, Nigeria's total revenue stood at N1.63 trillion while debt servicing stood at N1.94 trillion, showing a variance of over N300 billion. Minister of Finance, Budget and National Planning, Zainab Ahmed warned that urgent action is needed to address the nation's revenue challenge and expenditure efficiency at both the national and sub-national levels.

With its current N44.06triillion total debt stock as of September 2022, Nigeria has spent N3.04trillion to service external and domestic debts in nine months of 2022, representing an increase of 23.4 per cent Year-on-Year (YoY) from N2.46 trillion reported in nine months of 2021, the Debt Management Office (DMO) data revealed, recently. A breakdown of the N3.04 trillion debt service payments revealed a total N2.15trillion was used by the federal government to service domestic debts in nine months of 2022. You can see that Nigeria is in a debt mess and needs a leadership that would rescue it from debt enslavement in 2023 and set our economy on the part of growth and development.

Our education sector is in shambles. We have over 20 million out of school children, which is a recipe for future disaster in form of insecurity.

Benedict XVI, the pope whose resignation shook the Catholic world, has died at 95

ENEDICT XVI, who shocked the world's 1.2 billion followers of the Roman Catholic Church when he became the first pope to resign in almost six centuries, has died. He was 95.

Benedict XVI passed away on Saturday at 9.34am in his residence, the official Vatican News agency said on Twitter. The public will be able to pay respects to Benedict from January 2 when his body will be on view in Saint Peter's Basilica, the Vatican said.

"With sorrow I inform you that the Pope Emeritus, Benedict XVI, passed away today at 9:34 in the Mater Ecclesiae Monastery in the Vatican."

Benedict relinquished the leadership of the church in 2013, saying that he no longer had the "strength of mind and body" to fulfil his duties. He was succeeded by Argentinian Pope Francis the following month and took the first title of pope emeritus.

The end to Benedict's almost eight-year papacy capped a tumultuous period for the church, which had come under attack for doing little to punish paedophile priests and covering up evidence of widespread child abuse.

As a German cardinal then known as Joseph Ratzinger, Benedict XVI was elected as pope in 2005 following the death of John Paul II. Succeeding such a charismatic, revered pope - John Paul II was swiftly put on the path to sainthood - wasn't going to be easy even under normal circumstances. But crimes kept buried during his predecessor's time would loom large during Benedict's papacy.

There were allegations of sexual violence by Catholic clergy in Australia, Germany, Ireland, Italy, Poland, the US and elsewhere. As the media uncovered court records of the church's mishandling of sex crimes dating back half a century, Benedict faced questions over why he had failed to act on past

Under John Paul II, he had occupied one of the most important jobs in the church defending Catholic doctrine and investigating crimes such as claims of sexual abuse. As a high-ranking cardinal and head of the Vatican's Congregation for the Doctrine of the Faith, he had been in a position to probe the allegations.

Groups representing victims of abuse demanded his abdication. The scandal plunged the papacy

into what Swiss theologian Hans Kueng called "its worst crisis since the Reformation". Benedict apologised victims of abuse and to their families but was criticised for not turning his words into action.

Church Doctrine

Following his resignation, even some of his detractors recognised that Benedict had inherited a mass of problems that were difficult to manage – especially for a shy intellectual whose main contribution was his writing on church doctrine.

Benedict's "books and encyclicals often went beyond the strictly dogmatic and contained novel and bold reflections on the moral, cultural and existential problems of our times", Nobel laureate and self-proclaimed atheist Mario Vargas Llosa wrote in a column published in Spanish daily El Pais.

Scholz said on Twitter the "world is losing a formative figure for the Catholic Church, a pugnacious personality and an intelligent theologian".

Biographer Peter Seewald argued that Benedict was a good man placed in difficult circumstances and that he had helped guard against fanaticism within the church by articulating a relationship between science and religion.

"He is not far off being the most widely read theological teacher worldwide, with editions of his books published in the millions," Seewald said in a 2017 interview with the Catholic World Report.

He added: "In my opinion, Joseph Ratzinger is one of the most misunderstood personalities of our time."

In response to the report, Benedict denied any personal misconduct but said he was pained by "the abuses and the errors that occurred" while he was a leader within the church.

"Each individual case of sexual abuse is appalling and irreparable," he wrote. "The victims of sexual abuse have continued through his last my deepest sympathy, and I feel great sorrow for each individual case.'

Joseph Ratzinger was born on 16 April 1927, in Marktl am Inn, near Germany's border with Austria. The future pope dreamed of a life in the priesthood since the age of five when the archbishop of Munich, Cardinal Michael von Faulhaber, visited his kindergarten class. Faulhaber

Benedict spent years penning by hand his philosophical take on the life of Jesus Christ in a threevolume work. He was an enemy of "moral relativism" and considered it his main job to resist the changes sweeping modern society.

Clement XII, who was also 78

when chosen in 1730.

"We are moving towards a dictatorship of relativism which does not recognise anything as for certain and which has as its highest goals one's own ego and one's own desires," he said a day before the conclave of cardinals met to elect him pope.

Unsurprisingly, Benedict maintained the church's orthodoxy on homosexuality, marriage for priests and an expanded role for women in the church. He also tried to continue his predecessor's efforts to reach out to other religions, often with mixed results that tested relations with Jews and Muslims alike.

His comments on the Prophet Muhammad in a 2006 lecture sparked condemnation in Muslim countries, forcing Benedict to make several apologies. In 2009, he outraged the Jewish community when he failed to chastise a Holocaust-denying UK bishop.

Until the end of his tenure, Benedict argued it would be a mistake to compromise on ideology to make the faith more accessible to modern societies. Yet he did review the church's stance on contraception and sexually transmitted diseases, adopting a more practical attitude. In 2010, Benedict said condom use could be justified in "single cases", for example by sex workers, as a necessary "humanisation of sexuality".

Betrayed by his own butler, Benedict was forced to deal with the 2012 revelation of suspected dishonesty and political infighting in what became known as the Vatileaks scandal. The massive dump of stolen correspondence portrayed the Vatican as corrupt and Benedict as a frail leader undermined by his all-powerful second-in-command, Cardinal Tarcisio Bertone.

It took months for the pontiff to respond, and then only to remark that the "gratuitous" coverage of the events by the media had "brought sadness to my heart". Benedict pardoned his valet, who confessed to leaking the memos to a journalist.

The year of reporting dangerously — over 60 journalists and media workers killed in 2022

NTERNATIONAL Press Institute (IPI) research reflects that 66 journalists and media workers were killed in 2022. In many cases, investigations into journalists' killings stall because of a lack of political will, as the truth might implicate those in power or bring corrupt systems to a fall.

The past year has seen the highest number of journalists and media workers killed globally since 2018. International Press Institute (IPI) research reflects that 66 journalists and media workers were killed in 2022, a steep increase from the 45 journalists killed in 2021, 49 in 2020 and 51 in 2019.

Leading factors included the Russian invasion of Ukraine, where eight journalists and media workers, including Ukrainian and foreign reporters were killed in the line of duty or because of their journalistic profession. The IPI report states that up to four more Ukrainian journalists and media workers may have been killed by Russian troops in connection with their profession but these cases are unverified.

Many of the journalists were killed while covering the war on the front lines. Under international law, deliberately targeting journalists working in a conflict zone constitutes a war crime.

"This year has again demonstrated the critical and dangerous role of journalists covering wars. Without them, we would only hear from the military," says IPI executive director Frane Maroevi.

Globally, there were 39 targeted killings of journalists in 2022, meaning they were murdered due to their work. Seven journalists were killed while covering armed conflicts, two were killed while covering civil unrest, and two lost their lives while on assignment. In the remaining cases, the circumstances and motives behind the killings remain unconfirmed, but

work-related killings could not be ruled out.

The deadliest place for journalists: Mexico

Fourteen journalists were killed in Mexico in the deadliest year for the country's media since 2017. Those reporting on corruption, local politics and organised crime seem to be most at risk. The high number of deaths is in addition to 15 cases of missing journalists in Mexico, as documented by the Committee to Protect Journalists (CPJ).

Natalie Southwick, CPJ's programme coordinator for Latin America, says Mexico consistently features on CPJ's Global Impunity Index, which highlights countries where journalists are murdered and their killers go free.

"As a result of the spiralling violence and impunity, entire

regions of the country have now become so-called silenced zones, where journalists are no longer able to do meaningful critical or investigative reporting," she says. The CPJ reports that although Mexico's Federal Mechanism for the Protection of Human Rights Defenders and Journalists provides dozens of protective measures,

including camera systems, bulletproof vehicles, panic buttons, police protection and the relocation of journalists at extreme risk of violence, the system is inundated with problems including poor training, insufficient staff and resources and inadequate coordination with state authorities. The shortcomings mean that while the protection exists on paper, it is woefully inadequate in reality, as borne out by the murder of journalist Lourdes Maldonado in January while she was under the protection programme.

The IPI notes that Mexican President Andrés Manuel Lopéz Obrador has become known for his verbal attacks on journalists and, in February, he aggressively rejected a resolution by the European Parliament condemning the rise of violence against the press in Mexico.

"The horrific slaughter of journalists in Mexico shows that the criminals are in control, as they can act with impunity," says IPI executive director Frane Maroevi. "The Mexican government has to act now to protect journalists who are risking their lives and to reinstate the rule of law, ensuring justice for those who were killed."

In Haiti, gang violence and political unrest were key factors in the deaths of eight journalists. At least two journalists, Amady Wesley and Wilguens Louissaint, were burned alive by gang members on the outskirts of Haiti's capital, Port-au-Prince.

In many cases, investigations into journalists' killings stall because of a lack of political will, as the truth might implicate those in power or bring corrupt systems to a fall. Impunity has a chilling effect on press freedom, weakening democracy, preventing journalists from reporting on certain topics, and encouraging more violence towards the media.

"It is outrageous that journalists are killed because they are bringing us information that someone wants to hide. It is unacceptable that families are losing their loved ones and that the public is denied information simply because someone wants to hide the information, because someone is killing the messengers," Maroevi concludes.

2022 was the year limited democracy was formally accepted as new normal

MAJOR changes in a political system at times come unnoticed, where for all intents and purposes the political systems and provisions of law or the constitution remain the same, but the usage has radically changed. Rising expectations during 2021 that the country may revert to its traditional democratic format, from 1992 to 2015, were in for a surprise during 2022, that there is no wellspring for that change in CCM, and even in broader society. The status of political parties in law or in the constitution remains the same but the content of their activity is a regulated matter.

There is hence a new reading of the Political Parties Act of 1985 (with subsequent amendments) where the Act has an appendix of regulations pronounced as policy and don't need legislative approval as they fall under the powers of the president. These regulations include what the opposition intends to speak at political rallies, and how they will be guiding their adherents or crowds generally on what to do next. It is a situation where the government refrains from using the police against rallies to extract a vow of good conduct which key opposition parties don't violate.

So far the tone of stakeholders is to seek that political activity be freed and at most retain the ritual asking for a permit from the police, despite that many will say they were being refused a permit for no plausible reason. That all the same is in the past as at present the political system, in the sense in which it is supervised by those in authority, are disinclined to respect constitutional provisions on rallies as taken for granted with the presence of political parties. That right is now made conditional upon a code of conduct that has so far not been extracted especially from the main opposition party, Chadema. Its virtual raison d'etre is tied up with chaotic pushing.

That is why 2022 was at once a year of promise for reworking the manner in which democracy functions, with a view to restoring the usual parameters of the system, namely political parties that are free to organize and meet with the people. That is the minimum a legal framework accepting multiparty politics ought to accept, but it remains nonetheless valid that under certain circumstances it will be demanded what the parties will be doing, once freedom is extended to them. Here the shoe pinches and its implications aren't just on the opposition but also the ruling party.

Anyone looking at the recent electoral congress of the ruling party will quickly notice that those obtaining the highest number of votes to join the National Executive Committee weren't treasured for their astute loyalty to the current chairperson. These elements of sentiment have little expression in the public arena for the simple reason that political rallies are proscribed, in which case allowing such gatherings isn't just helpful for opposition parties but also for factional expression within the ruling party. In that case the rule about regulating political rallies isn't just what authorities are doing to opposition as it is often believed.

When this dimension is added to the matter. chances that authorities give in easily on the matter are severely limited, since it would also free negative forces within the ruling party, which is unacceptable. This also explains the substance of what happened in the wake of radical alteration of party politics in the early years of the fifth phase government, and incidentally people got used to the new norm, on a developmental effectiveness premise. It is a rationale that opposition parties will find it hard to erode, that chaotic multiparty routines are more important than cohesive systems and clear modes of accountability, in a government that listens.

When President Samia came to office and inaugurated her engagement with 'let the work continue,' as the response to greeting the people in the name of the United Republic, this wasn't an empty formula or mere sloganeering. The manner in which work was organized during the fifth phase was a cohesive modality which is being kept and protected, namely sharply cutting down sleaze in government expenditure, starting strategic development projects. If this is the bonus for not holding rallies to denounce what the government is doing, the public can afford

That is why multiparty activists, who wish to be accepted as human rights activists, will find it difficult to raise the civic temperature sufficiently to bring about a wholly new atmosphere of strenuous respect for old fashioned political rallies where opposition parties - and especially Chadema - can say anything they want. That mark has been crossed during the fifth phase but multiparty activists delude themselves with the idea that the fifth phase was simply a disaster. It was on the contrary a hardline experiment of interpreting the laws, succeeding by legitimizing this stringency with a development drive plus crushing sleaze with vim and vigour.



China moves to hasten agriculature in Uganda

technology transfer and enabled improvements production and productivity of the crop, livestock, and fisheries sub-sectors.

During the phases, the Chinese hybrid rice variety and Chinese foxtail millet variety were introduced to farmers. The rice yields about 10 tonnes per hectare compared to improved and local varieties which yield 3.5 and 2.5 tonnes per hectare respectively, according to MAAIF. The foxtail millet ensured food sovereignty and variety, meanwhile, yields about 5 tonnes per hectare The first and second as compared to local and millet

varieties grown in Uganda which yield 1 and 2.5 tonnes per hectare, respectively.

During the implementation of the first two phases, 220-million-U.S.-dollar China-Uganda Agricultural Cooperation Industrial Park was established in the central part of the country.

Zhang Xiaoqiang, head of the Chinese agriculture team for the third phase said the team is aiming to move local farmers to look at agriculture in a commercial way instead of subsistence. Zhang said the Chinese technicians will transfer knowledge and skills to the farmers through agriculture extension workers.

"In the third phase, we want to promote investment in the agriculture industry, high-quality products, and bring them to the Chinese market. We also encourage more Chinese enterprises to invest in Uganda, and to bring all their value chain," Zhang said.

Muyimbo, Peter coordinator of the third phase on the Ugandan side, said the phase has been designed to commercialize agricultural production with a target of increasing exports to the Chinese market. He said during the phase, Chinese experts and technicians will interact with local farmers, sharing their experiences and best practices.

"We are going to upscale production in Chinese hybrid rice, foxtail millet, and production of livestock where we are dealing with goat production, especially the big ear goat. We shall also have embryo transfer especially in dairy production, we shall also have feeds," said Muyimbo.

He said during the implementation of the phase, Uganda will draw lessons from China on how it has also ended extreme poverty. "We would like to copy and learn this from the Chinese people."

Beekeeping value chain training benefits hundreds of farmers in northern Tanzania

OVER 300 beekeepers from Muheza, Korogwe and Same districts in Tanga and Kilimanjaro regions respectively have benefited from the training on beekeeping value chain.

The training was on management of bee colony, honey value addition, honey processing, packaging and marketing was made possible by Tanzania Forest Conservation Group (TFCG) with funding from the European Union (EU).

Simon Lugazo, TFCG's government liasion and capacity building officer revealed this recently in Morogoro municipality when speaking on the sidelines of the Tanzania Community Forest Conservation Network (MJUMITA) Annual General Meeting (AGM) themed: 'Involve women and youth to improve forest conservation and cope with climate change'.

The beneficiaries were from 20 groups formed in the three districts-Muheza, Korogwe and Same. The groups of farmers are in villages of the three districts, which are in honey production.

"As TFCG, we're very proud for what has been achieved in those areas because the training has changed people's fortunes as of now some of the beneficiaries build modern houses, sending children to school from primary to university level,

Costly rolling blackouts 'game changer' for Cape Town's small and medium businesses

APE Town is having bumper holiday season after the Covid pandemic, but rolling blackouts continue to present a challenge for small businesses seeking to capitalise on boosted tourist numbers. Daily Maverick engaged with local business owners about how outages are affecting their day-to-day operations.

After two years of Covid-related uncertainty and restrictions that spelled disaster for the tourism industry, Cape Town is finally experiencing a bumper holiday season. It's a welcome development for those businesses who cater to the travellers'

The bumper season means a greater number of flights and cruise ships coming into the city, according to Iames Vos. mayoral member for economic growth and tourism at the City of Cape

Between 7 December 2022 and March 2023, 1.6 million two-way aeroplane seats to Cape Town are expected to be available, with 191 international flights landing in the city per week. This will generate about R8-billion in tourism spend. During the same period, about 75 cruise ships are expected to dock.

"From my conversations with tourism operators throughout the City, our attractions and hotels are reporting fantastic numbers and occupancy. In some cases, fully booked and even surpassing pre-Covid figures," said Vos.

However, one factor continues to undercut the lucrative opportunities that come with the summer months - rolling blackouts. As the country heads into New Year's weekend, frequent power outages are an ongoing feature of the South African experience.

Apart from a brief respite on Christmas Day, there have been rolling blackouts throughout the festive period. This week, Stage 3 rolling blackouts have been implemented from 5am to 4pm each day, followed by Stage 4 rolling blackouts from 4pm to 5am. In Cape Town, where outage stages are one below the national level, this means Stage 2 and 3 rolling blackouts.

The City of Cape Town is currently able to limit rolling blackouts in its supply areas by building up reserves from operations at the Steenbras [Dam]

In a respite for New Year celebrations, rolling blackouts will be suspended from 4pm on 31 December 2022 until 5am on 2 January 2023, when stage 2 would be implemented until further notice, according to a Friday announcement by Eskom.

Daily Maverick engaged with small business owners in and around Cape Town to find out more about how rolling blackouts are impacting operations during the holiday season.

'For small business, it's a killer' -Nelson Da Silva

Majestic Café, in the coastal tourism suburb of Muizenberg, has been operating for 85 years. It has withstood rough patches before, but none quite like the present, according to owner Nelson Da Silva.

"We had Covid and then you know, the beaches were shut, so you can imagine what that does to our business here," he said. "Then we had Omicron hit last season. so we never had the season we were anticipating.

"Just when things start to pick up, we're hit with load shedding... Stage 1, Stage 2, you can still make it, but once you get to Stage 6, then it's a game changer."

While generators are marketed as a solution, they are noisy, expensive and only able to support so many appliances. According to Da Silva, a 6.5 kVA generator supports one electric

"We run the kitchen just with one genny [generator], but it's such a horrible thing to run, and you have to restrict the menu because you can't make everything," he continued.

Da Silva has been unable to stock impulse ice cream products - single-serving ice cream options, such as Magnums that cater to impulse-buying tendencies because once they soften during rolling blackouts, they don't freeze again.

"You don't want to buy too much chicken because everything can spoil. Especially when we go to Stage 6 - we had one Saturday here, four-and-a-half hours, which was just unbelievably horrible," he said.

"It's easy for big business to ride this, but for small business, it's a

Lagerchinos restaurant has been in Muizenberg since 2010. I'm definitely getting an terrifying balancing act."

According to James Bowden, manager of the restaurant, rolling blackouts had a big impact on operations when it came to screening recent Fifa World Cup and rugby games.

"We don't own a generator, so we've had to hire our generators. Obviously, that takes off a lot of our profit margin for the day," he said.

"We've been looking at [investing in a generator] for the past year. It is expensive. If you're going to get a big kVA 5 generator for the whole restaurant, it's upwards of R60,000.3

The restaurant currently has an inverter that runs its basic systems, such as the point-of-sale equipment.

"Because the load shedding shut down the sewage plant... we lost quite a bit of business in the first two weeks of season in December," said Bowden, referencing the recent closure of Muizenberg Beach.

Muizenberg Beach was closed on 12 December due to an electrical failure at Clifton Road sewer pump station, caused by a faulty ultrasonic device, according to a media release by the City of Cape Town. The public was advised to avoid contact with the water, as exposure could result in gastrointestinal issues.

The City re-opened the section of the beach between Muizenberg Pavilion and Sunrise Beach on 16 December.

Rolling blackouts were identified as being to blame for the sewage spill, with prolonged outages under higher stages of load shedding taking a toll on sewage infrastructure, according to a TimesLIVE report.

The Commons, vegetarian café and live music venue in Muizenberg, opened during the Covid-19 pandemic. Candice Horn, owner of the establishment, told Daily Maverick that she has been looking forward to the holiday season.

"We haven't had a proper busy season, I've never experienced it, and experience of it now," she said.

While staff at The Commons are largely used to rolling blackouts, running a live music event off a generator is very stressful, continued Horn. It requires a team of people to ensure things run

"[It's] also just the cost factor... we've had to get a backup UPS System to keep the internet running. As a café that runs by day, we have to have the internet going," she said.

The café has lost equipment to rolling blackouts, with electrical surges causing printers, fridges and other appliances to blow. The resultant costs add up to thousands of rands.

"Even buying a generator for us was a huge expense that we actually couldn't afford, and we had to take cash from ourselves, basically, to get the generator," said Horn.

"We don't regret that at all because we really need it. We wouldn't have been able to function without it; we would definitely have had to close down as a business."

To Pringle Bay

in other Businesses Western Cape towns are facing many of the same challenges as those in Cape Town. In some cases, these are compounded by supply chain issues.

In October, Teri Seward-Case took over La Galerie restaurant - in Pringle Bay, a coastal village in the Overberg region of the Western Cape.

"We are about 40 minutes from Cape Town, maybe half an hour from Somerset West and Strand, which has a main supply point, and the whole supply chain has been impacted [by rolling blackouts]," said Seward-Case.

"So, when you're asking for something, you have to give them an extra day or two's notice because they simply will have their own problems to contend with. But if you're dealing with something perishable, you don't have that luxury. It really is quite a

to use the internet during load shedding - a lot of them work remotely as well even when on holiday," she said.

Those few CapeHolidays properties that do not have backup power options are definitely affected when it comes to bookings, continued

Horak. "I had an enquiry today [about] one of the properties where people want to work remotely for the whole month of February, and just because we haven't got that backup for them, they decided they'll go somewhere else," she said.

"We're very upfront with people, so it's in all our descriptions, so people are aware before they book a property whether we've got that backup or not."

Many larger businesses in tourism and affiliate industries are able to mitigate the effects of rolling blackouts through renewable energy solutions or the use of generators, according to Vos.

"It is, sadly, smaller businesses and tourism operators who do not have such resources and are forced to adjust their operations,' he said.

"From engagements with businesses in factories and boardrooms, seen how production lines are affected and there have been tough conversations around how they cope. Often, they are forced to divert budget from things like hiring more staff to taking measures to keep the lights on."

The national picture

South African Tourism has not yet conducted a full economic impact study of rolling blackouts on the national tourism sector, according to spokesperson Thandiwe Mathibela. South African Tourism is the tourism-marketing arm of the South African government.

"Unfortunately, shedding is affecting all spheres of the economy and society, and the tourism sector is not spared from

this," said Mathibela. "We do know that smaller businesses that do not have enough funds and resources to raise the additional capital needed to have these backup systems are the hardest hit and sadly these are also businesses that are trying to still recover from the impact of the Covid-19 pandemic."

According to Mathibela, the Department of Tourism is offering some relief to businesses in the sector through the Green Tourism Incentive Programme (GTIP), a resource efficiency grantfunding mechanism that encourages privately owned tourism enterprises to adopt responsible tourism practices.

"The programme assists graded enterprises to reduce the cost of investing in energy- and water-efficient operations, which will lower their cost of operations and facilitate increased competitiveness and operational sustainability in the tourism sector," she said.

Contour farming brings multiple benefits for farmers on Uluguru Mountains slopes

SMALL-scale farmers along the slopes of Uluguru Mountains in Morogoro Municipality got positive results from contour farming-a practice of tilling sloped land along lines of consistent elevation in order to conserve rainwater and to reduce soil losses from surface erosion.

Uluguru Mountains form part of the Eastern Arc Mountains, a chain of mountain ranges found in Africa's east.

The farmers are from Mlimani, Bigwa and Kilakala wards benefiting from the contour farming project which is being run under the coordination of the Morogoro Municipal Council and facilitated by the Eastern Arc Mountains Conservation Endowment Fund (EAM-CEF).

Shabani Charles, project coordinator told reporters who visited the farmers to see the movements carried out by EAMCEF in collaboration with the Municipal council in preserving the environment of Uluguru Mountains.

Saidi Juma is one of the farmers in Mlimani Ward who are doing contour farming in Uluguru Mountains. He said through the farming venture has got positive results, which made him move in terms of development for the past three years.

In the past, Juma said

that soil and fertiliser were washed away by the rains, thus causing the land to bare with nothing that can support his crops, hence ended up with little productivity, but also pollution on water sources

down streams. "Since I started contour farming, my field has been fertile enough. I grow strawberries that I used to harvest not more than six kilos in my garden, but now I get more than double the yield," said Juma.

Saidi Ngoma of Mlimani ward said that members of the dairy goat farmers' association were trained on the correct dairy goat production methods and later were given goats that there is a procedure to give to each other every

time they give birth and that the goats also give them milk, is for food and income. Ngoma who is a group chairman said that apart from food and income, farmers also get manure which is good for organic farming.

Rosemary Boniface, EAMCEF project officer said that the fund is aimed to ensure that people are involved in the conservation of Uluguru Mountains, which are part of the Eastern Arch that is loaded with resources and biodiver-

"So, been providing people around those areas with environment-friendly projects that will enable them to increase their income and get rid of the culture of entering the areas reserved for


harvesting available resources," she said.

Rosemary explained that EAMCEF has invested in a contour farming project in the area of the mountain ranges to protect the water sources that are relied upon to direct water to the Mindu dam which is the main source of water for the residents of Morogoro Municipality.

The EAMCEF official said that the fund has enabled fruit projects for some of the primary and secondary schools of the municipality to prepare EAMCEF has a generation that cares about the environment as well as beekeeping projects using modern hives for some villages bordering the Uluguru Nature Reserve which has helped to a large percentage to reduce the incidents of burning in the mountain.

Why over 55,000 litres of milk not recorded daily

MORE than 42,000 cows from 10,000 farms from the six most producing sectors of Kayonza District produce more than 75,000 litres of milk, official District statistics indicate. However, as noted, only 20,500 litres are recorded at milk collection centres in the District, each day.

As reported, informal selling of milk brings about a difference of more than 55,000 litres, daily. The situation hinders the attainment of the required target, at least 100,000 litres of milk needed from the district by Inyange Industries, officials

Dairy farmers, including Martin Murindabigwi, blame the situation on a number of factors.

"Some milk suppliers stopped supplying milk to the collection centers due to a number of reasons such as poor transport systems, lack of trust among farmers and collection points due to the previous bad record of missing payments to farmers," Murindabigwi said.

"Lack of market has also been an issue because milk collection centers could not afford the quantities we have to offer, hence, the informal trading of milk. We request Inyange Industries to assure us of a stable market and ask milk collection centers to collect our produce from the farms. I believe if this is done, it will increase the quantity of milk received at the centres."

Frida Murungi, a member of Mwili Milk Collection Center, indicated that absentee land owners and cattle keepers have a hand in the fact that milk centres don't get supplied.

"The milk, instead of being sold in a proper way, you find that employees who take care of the cattle decide to sell the milk in a way that does not follow the right channel. We are urging the cattle owners to monitor things carefully so that milk collection centres are properly supplied with milk."

Kayonza District Mayor, John Bosco Nyemazi, said: "Dairy farmers should change their mindset and instill professionalism in their business; including formal trading of milk. "We urge farmers' cooperatives to work closely with milk collection centers and third parties in the business to increase productivity and limit quantities of milk sold informally."

Nyemazi noted that the current situation not only hinders the attainment of required targets, but also the quality of milk distributed through informal trading might not be good for consumers' health.

Nyemazi said Inyange is in the process of signing contracts with milk collection centres to collect the milk. Currently, it is noted, they are only working with one out of the five milk collection centres in the entire district. Farmers agreed to use available opportunities including government subsidies to avail bailer machines, water management systems at their farms and proper use of the farms.

The Deputy Director General of the Rwanda Agriculture and Animal Resources Development Board (RAB), Dr Solange Uwituze said: "RAB is in discussions with milk collection centres to have private veterinarians who will facilitate the process, these private veterinarians will form cooperatives and have required training from RAB, hence a decentralized service delivery to milk producing farmers."

Taxman eyes billions earned by foreign traders gets on hedging

NAIROBI

THE Kenya Revenue Authority (KRA) will from January go after the billions being made foreign traders profiting from Kenyanbased derivatives, as the taxman casts its net beyond borders.

Gains accruing for foreigners from the derivative financial contracts will start attracting 15 percent withholding tax.

Currently, only local companies that have derivative contracts which include options, swaps, futures, and forward contracts - to protect themselves against financial loss due to price fluctuations have been paying the 15 percent withholding tax on their gains.

According to an analysis by Bowman, a British-based law firm, the move is also a response by the government to earn revenue from increased use of hedging by local entities caused by the need to navigate the volatile international markets due to the ongoing conflict in Eastern Europe.

TARLINK is a satellite broadband service run by Elon private space company, SpaceX, based in Hawthorne, Califor-

As of December 2022, it consists of over 3,300 massproduced small satellites in Low Earth Orbit (LEO), which communicates with designated ground transceivers.

The first two countries on the African continent confirmed to be getting Starlink are Mozambique and Nigeria. It will be launched in Rwanda in the first quarter of 2023, other countries where it is slated to be rolled out include Angola, Eswatini, Gabon, Kenya, Tanzania, and

speed broadband internet with low latency (Starlink's latency ranges between 20 ms to 40 ms and the latency of conventional satellites sometimes goes above 300

The Starlink kit or terminal comes with everything vou need to connect to the internet including a Starlink device, WI-FI router and cables. It does not communicate directly to handsets but through a terminal mounted on a flat surface such as the ground or roof of a house.

This makes it very easy to set up since it is a matter of placing the terminal in an ideal location. Any Rwandan interested in using Starlink will install it with a lot of

Starlink internet does not suffer any internet outage due to disasters. The fact that it has very many base stations around the world, internet can be restored when the sky clears up. This assures faster disaster recovery. This will serve as a guarantee to internet users in Rwanda who think that they will have connectivity issues in case a catastrophe happens.

Uganda locals renew concerns over dust from crude oil facility

RESIDENTS from villages surrounding the oil central processing facility at Kasenyi in Buliisa District have reiterated that dust from the site is posing a health risk to them.

Construction of the facility commenced last year in June and works are being undertaken by Mota-Engil and Karmod Beta, which were contracted by Total-

But residents, who have in the past petitioned the government over the matter, say the use of heavy earth moving equipment such as graders, excavators, vibro rollers and trucks at the site has made life miserable for them.

Mr Denis Chombe, a resident of Kisomere Village in Ngwedo Sub-county, said since construction started, the earth movement equipment is generating dust daily, which flows into their homes, farms and gardens.

Mr Mugisa Jelasy Mulimba, another resident who lives a few meters away from the construction site, said his family stands high chances of contracting airborne disease as result of inhal-

He says their cries for help have always fallen on deaf ears.

"Since ast year when Mota-Engil started clearing close to 750 acres of land in this area, we get a lot of dust from the facility, most of the time our household items such as utensils and clothes are full of dust," Mr Mulimba says.

"We have written several letters to TotalEnergies but they are always dodging to meet us," he

World welcomes 2023 and leaves a stormy year behind

THE world welcomed the new year with a packed party in Times Square and fireworks soaring above European capitals, while hoping for an end to the conflict in Ukraine and a return to post-COVID normality in Asia.

It was a year marked by the Ukraine crisis, economic stresses and the effects of global warming. But it was also a year that saw a dramatic soccer World Cup, rapid technological change, and efforts to meet climate challenges.

After 2023 descended upon Asia, Africa and Europe, New York rang in the new year in typical style as thousands corralled themselves into pens under pouring rain in Times Square, waiting hours for the ball to drop. A 12-foot (3.7-meter) geodesic sphere made of in midnight in the British capital.

Waterford crystal triangles slid down a pole atop a 25-story building to mark the calendar change.

Meanwhile, millions watched the accompanying musical acts and countdown on television from dry and warm living rooms around the world.

Tommy Onolfo, 40, a mechanic from nearby Nassau County, said he wore a diaper during his drenched, 14-hour wait in Times Square, as security measures require spectators to deprive themselves of all comforts to maintain a front-row view.

"I'm a lifeguard in the summer so I'm not afraid of water at all," Onolfo said. "I have my bathroom thing down to a science. I haven't had to use the diaper yet. It's just in case."

Putin's New Year address: Year of major steps and fight for Russia's future

THE outgoing year has been a year of "difficult, necessary decisions, major steps" towards Russia's full independence, and now the country is fighting for its future, President Vladimir Putin said in his New Year's address to Russian citizens on Saturday.

The head of state addressed the people of the country standing next to the military, not against the backdrop of the Kremlin as usual. As Kremlin spokesman Dmitry Peskov explained to reporters, the address was recorded at the headquarters of the Southern Military District.

TASS has collected the key statements of the New Year's address of the President, which lasted nine minutes and became the longest in history.

Results of the year

"It was a year of difficult, necessary decisions, major steps towards gaining the full sovereignty of Russia and the powerful consolidation of our society".

The "truly pivotal, fateful events" of 2022 have become a milestone laying the foundation for the common future of Russians and their true independence: "This is what we are fighting for today".

"It was a year that put a lot in its place, clearly separated courage and heroism from betrayal and cowardice, showed that there is no higher power than love for one's family and friends, loyalty to friends and comrades, devotion to one's Fatherland".

Western aggression

The West has been lying about peace for years, but in fact it was preparing for aggression: "And today it is openly admitting this, no longer embarrassed. They are cynically using Ukraine and its people to weaken and split Russia".

The Western elites hypocritically assured of their peaceful intentions, including the settlement of the conflict in the Donbass, but in fact "in every possible way encouraged the neo-Nazis".

This year, the West declared a "real sanctions war" on Russia: "Those who started it expected the complete destruction of our industry, finances, and transport. This did not happen, because together we created a reliable margin of safety".

About military operation participants

"Russian servicemen, militias, volunteers are now fighting for their native land, for truth and justice. For guarantees of peace and security for Russia to be reliably provided. All of them are our heroes, it is the hardest time for them now".

The authorities will provide all necessary assistance to the families of those participants in the operation who died on the battle field: "We will do our best to help the families of our fallen comrades raise their children, give them a decent education, and get a profession".

Putin thanked the military for their valiant service and congratulated "all personnel of the armed forces" on the New Year: "Our entire vast country is proud of your fortitude, resilience and courage, prayers and hearts of millions of people are with you. And at the New Year's table there will definitely be toasts in your honor".

Fighting for the future

Now "the most important thing is the fate of Russia," its defense is "a sacred duty to ancestors and descendants." "We have always known, and today we are again convinced that the sovereign, independent, secure future of Russia depends only on us, on our strength and will!".

Russia's struggle for its interests and its future will become "an inspiring example for other states in their striving for a fair multipolar world order".

Russians must believe that their country will remain "great and independent" and will "only move forward and

Giving his New Year Address to ring in 2023, Xi lauded the country's economic performance, COVID approach and sci-tech breakthroughs over the past year.

The nationally televised and livestreamed speech delivered in his office in central Beijing is the tenth of its kind since Xi became the Chinese president in

Reviewing the past year, Xi first commended the successful 20th National Congress of the Communist Party of China, which drew an ambitious blueprint for building a modern socialist country in all respects and advancing the great rejuvenation of the Chinese nation on all fronts through a Chinese path to modernization.

On the Chinese economy, Xi said it has remained the second largest in the world and enjoyed sound development, adding that GDP for the whole year is expected to exceed 120 trillion yuan (about 17 trillion U.S. dol-

Chinese people," Xi said.

Preferential tax policies give boost to innovative development of enterprises

ENTERPRISES play a principal role in innovation. They are also the primary driving force for innovation.

Today, the research and development (R&D) expenditure of Chinese enterprises accounts for over 70 percent of all R&D expenditure of China.

To give full play to the guiding and supporting role of key high-tech enterprises and build a sound environment for micro-, small-, and medium-sized tech firms, China has rolled out a series of preferential tax policies, encouraging enterprises to increase R&D expenditure and foster new growth drivers.

Netstar, a software developer in north China's Hebei province, is currently developing a low-code development platform. "It is the tangible benefit brought about by preferential tax policies that encouraged us to expand investment in new technologies and products," said Dong Aijun, chairman of the company.

In 2022, China raised the ratio of additional tax deductions on small- and medium-sized tech firms' R&D costs to 100 percent.

Dong said the higher ratio is great news for enterprises. "Our 2022 R&D expenditure is estimated to reach 18 million yuan (\$2.58 million). Thanks to the increased ratio, an additional 4.5 million yuan will be deducted from taxable income. The corporate income tax is determined by enterprises' profit, and with this extra part of expenditure, we'll pay less corporate income tax," Dong noted.

"We'll use the money saved to make more innovations, introduce more talents, and develop new products and services that better meet the demand of our clients, so as to make our products more competitive," Dong told People's Daily.

Capital shortage remains a severe challenge for the continuous innovation of tech firms, especially small- and medium-sized ones. The additional tax deduction for R&D expenses allows enterprises to expand their R&D expenditure and pay less tax, and encourages them to enhance their efforts in in-

There was also good news for enterprises planning to purchase equipment and instru-

ments. "We planned to purchase 51.2 million yuan of automation equipment the next year. With the new policy, we decided to make the purchase in the fourth quarter of 2022, as it would save a big sum of money," said Wang Qiang, who heads the accounting department of a precision parts manufacturer in Jincheng, north China's Shanxi province.

Wei Hujun, an official with the tax office of Jincheng Economic and Technological Development Area, told People's Daily that according to a previous policy, high-tech firms purchasing new equipment worth less than 5 million yuan would be entitled to a one-off deduction of total purchase costs from taxable income. Now with the new policy, all

equipment purchased by high-tech firms in the fourth quarter of 2022 are eligible for the deduction, and will be 100 percent deducted from enterprises' taxable income, Wei added.

He said this encourages high-tech firms to upgrade equipment and better commercialize their technological outcomes.

Besides, China has also rolled out measures that offer tax preference for enterprises that sponsor non-profit scientific institutions, universities, and government-based natural science funds, which both alleviates capital pressure for these enterprises and supports the innovation in basic research of scientific institutions

Strengthened cooperation with China supports Zimbabwe's socioeconomic development

HARARE

CHINA continued to spread its footprints across Zimbabwe in 2022, with major investments in infrastructure, mining and industry taking place on a huge scale, further cementing the bilateral relations.

China has stood by the mantra "actions speak louder than words" and rallied behind the Zimbabwean government's efforts to uplift the livelihoods of its citizens.

While many projects were undertaken through platforms such as the Forum on China-Africa Cooperation (FOCAC), others were done through private enterprises attracted by the vast opportunities Zimbabwe presented.

A brand-new Parliament Building donated by the Chinese government through China Aid was completed during the year.

The new Parliament Building, which is a combination of Chinese construction finesse and traditional Zimbabwean architecture and is nestled on a hill due north of Harare, the capital of Zimbabwe, will be officially handed over to the Zimbabwean government at a date yet to be announced.

Legislators, however, had their first feel of its comforts -- away from the congestion of the current building in the city center -- in November when President Emmerson Mnangagwa opened the last session of the current Parliament there.

China also remained the cornerstone of Zimbabwe's largely successful fight against COVID-19 by donating millions of doses of vaccines and providing protective clothing and ventilators.

The vaccines were donated within the ambit of FOCAC. As a result of

the donations, Zimbabwe managed to contain the pandemic to a great extent, limiting the number of cases to under 260,000 infections and about 5,600 deaths since March 2020.

Mnangagwa also commissioned in Harare a new pharmaceutical warehouse also funded by China Aid, which has boosted the country's drug storage

Bilateral relations between China and Zimbabwe were raised to a comprehensive strategic cooperative partnership, further enhancing the win-win relationships that China espouses with its partners.

The expansion of Zimbabwe's largest airport -the Robert Gabriel Mugabe International Airport -is progressing under a concessionary loan provided by China Eximbank and is due for completion in 2023. The expansion, which is being done by China Jiangsu International, will allow the airport to grow its passenger handling capacity to about 6 million a year from the current 2.5 million.

In mining, a life-changing development is taking place at Manhize in Mvuma, Midlands Province, where the 1-billion-U.S.-dollar Manhize Iron and Steel Plant is being set up by Dinson Iron and Steel Company (DISCO), a subsidiary of global steel producer Tsingshan Holdings Group.

This has set Zimbabwe on course to be one of the global leaders in steel production. DISCO is slowly turning the once sleepy mining town of Mvuma into a modern one, with ancillary infrastructures such as housing, schools, health centers and social amenities being developed.

The integrated project encompassing mining, processing and beneficiation will employ up to 6,000 workers and will also facilitate skills transfer as the resident Chinese engineers collaborate with

Around 14,000 other upstream and downstream jobs will be created from the project, which will initially produce about 600,000 metric tons of steel

Production is projected to reach 5 million metric tons per year over time, thus contributing significantly to boosting the local economy and turning the country from being an importer to an exporter of iron and steel.

According to trade promotion agency ZimTrade, Zimbabwe has been importing iron and steel products and their articles worth more than 300 million U.S. dollars per year. Another major mining project being undertaken by Chinese investors is Huayou Cobalt's Arcadia Lithium Mine, just outside Harare, which is expected to start exports on a larger scale in 2023 with projections of earning 500 million U.S. dollars a year from 2 million U.S. dollars in 2017.

Zimbabwean economist Paul Musodza said Chinese investments were changing lives in countries fortunate to have attracted them. "This year alone witnessed private Chinese investments pour into Zimbabwe on major mining and industrial projects worth millions of dollars.

These short-term projects contribute strongly to the country's forex reserves. Some are long-term projects that are employing hundreds of Zimbabwean workers," he said in an interview.

"It is in this regard that China wishes to work with the government of Zimbabwe in fully strengthening the financial services markets between the two countries to benefit both countries' industries."

While undergoing its own rejuvenation, China has pledged to make new contributions to humanity's well-being and continue to share new opportunities with the world.

Musodza said a wealthier China provided an expanded market for Zimbabwe and the world in general. Information, Publicity and Broadcasting Services Minister Monica Mutsvangwa during the year also called for more cooperation between China and Zimbabwe anchored on FOCAC principles, noting that Zimbabwe found FOCAC to be the only viable way in the face of sanctions imposed on the country by the West.

130 mln Arab population in poverty - UN survey

BEIRUT

A survey released by the United Nations Economic and Social Commission for Western Asia (ESCWA) on Friday said that poverty affects one-third of the Arab region's population, excluding the Gulf Cooperation Council (GCC) countries and Libya.

Dubbed "Survey of Economic and Social Developments in the Arab Region," it said that "poverty, measured against national poverty lines, increased to affect 130 million people in Arab countries."

The survey expects a further rise in poverty levels in the next two years, reaching 36 percent of the population in 2024.

Moreover, the Arab region registered the world's highest unemployment rate in 2022 at 12 percent, said the survey, adding that there may be a very slight decrease in 2023 to 11.7 percent, owing to post-COVID-19 economic recovery

It expects the region's economy to grow by 4.5 percent in 2023 and 3.4 percent in 2024.

Ahmed Moummi, the lead author of the survey, said that GCC and other oil-exporting countries will continue to benefit from higher energy prices, while oil-importing countries will suffer from several socioeconomic challenges, including rising energy costs, food supply shortages, and drops in both tourism and international aid inflows.

Moummi noted that oil-exporting Arab countries should diversify their economies away from the energy sector by investing in projects that generate inclusive growth and sustainable development.

Lula returns to office in a troubled, divided Brazil


LEFTIST leader Luiz Inacio Lula da Silva will be sworn in as president of Brazil on Sunday under tightened security in the Brazilian capital following threats of violence by supporters of his far-right predecessor Jair Bolsonaro.

The ceremony in Congress begins at 3 pm (1800GMT), after which Lula will go the Planalto palace to don the presidential sash before a crowd of 30,000 supporters, while some 300,000 are expected to gather to celebrate on Brasilia's esplanade.

Lula, 77, narrowly defeated Bolsonaro in October to win an unprecedented third presidential term after a hiatus that saw him spend a year and a half behind bars on corruption convictions that were later overturned.

In his previous years as Workers Party (PT) president from 2003-2010, the former union leader lifted millions of Brazilians from poverty during a commodity boom that buoyed the economy.

Now, he faces the daunting challenge of improving Brazil's stagnant economy while also uniting a country that has become painfully polarized under Bolsonaro.

"A lot is expected of Lula. He'll have the difficult mission to restore normality and predictability in Brazil, and above all to rapidly deliver results that improve the quality of life for its inhabitants," said Creomar de Souza, director of Dharma Political Risk consultancy in Brasilia.

Bolsonaro left Brazil for Florida on Friday, avoiding having to hand over the sash to his rival, whose victory he has yet to recognize, while also removing himself from any immediate legal risks related to his time in office.

His supporters have protested for two months that the election was stolen and called for a military coup to stop Lula returning to office in a climate of vandalism and violence.

One supporter was arrested for making a bomb that was discovered on a truck the country.

laden with aviation fuel at the entrance to Brasilia airport, and confessed he was seeking to sow chaos to provoke a military intervention.

Netanyahu says Israel not bound by 'despicable' UN vote

RAMALLAH

ISRAEL condemned and the Palestinians welcomed on Saturday a United Nations General Assembly vote asking the International Court of Justice to provide an opinion on legal consequences of Israel's occupation of the Palestinian territories.

The Friday vote presents a challenge for Israeli Prime Minister Benjamin Netanyahu (pictured), who this week took office at the head of a government which has set settlement expansion as a priority and which includes parties who want to annex West Bank land on which they are built.

"The Jewish people are not occupiers in their own land nor occupiers in our eternal capital Jerusalem and no UN resolution can distort that historical truth," Netanyahu said in a video message, adding that Israel was not bound by the "despicable decision."

Along with Gaza and East Jerusalem, the Palestinians seek the occupied West Bank for a state. Most countries consider Israel's settlements there illegal, a view Israel disputes citing historical and Biblical ties to the

The Hague-based International Court of Justice (ICJ) also known as the World Court, is the top UN court dealing with disputes between states. Its rulings are binding, though the ICJ has no power to enforce them.

The UN General Assembly asked the ICJ to give an advisory opinion on the legal consequences of Israel's "occupation, settlement and annexation ... including measures aimed at altering the demographic composition, character and status of the Holy City of Jerusalem."

Members of Netanyahu's new government have pledged to bolster settlements with development plans, budgets and authorization of dozens of outposts built without permits.



The cabinet includes newly created posts and restructured roles that grant some of those powers to pro-settler coalition partners, who ultimately aim to extend Israeli sovereignty to the West Bank.

Netanyahu, however, has given no indication of any imminent steps to annex the settlements, a move that would likely shake up its relations with Western and Arab allies alike.

The Palestinians welcomed the UN vote in which 87 members voted in favor of adopting the request; Israel, the United States and 24 other members voted against; and 53 abstained.

"The time has come for Israel to be a state subject to law, and to be held accountable for its ongoing crimes against our people," said Nabil Abu Rudeineh, spokesman for Palestinian President Mahmoud Abbas, whose Palestinian Authority has limited self-rule in the West Bank.

Basem Naim, an official with Hamas, the Islamist militant group that controls Gaza, said it was "an important step toward confining and isolating the state of occupation (Israel)."

Another woman files sex abuse lawsuit against Cosby, NBC

A WOMAN who alleges Bill Cosby drugged and sexually assaulted her in 1986 sued the comedian-actor, NBCUniversal and other companies Friday in New York, where five other women filed a similar lawsuit earlier this month.

Stacey Pinkerton says she was a 21-year-old flight attendant and model that year when she claims Cosby drugged her at a restaurant in Illinois and took her back to a hotel room in Chicago. The lawsuit alleges Cosby "engaged in forced sexual intercourse" with her while she was incapacitated from the drugs.


The lawsuit comes more than a year after Cosby left prison after his 2018 sexual assault conviction in Pennsylvania was overturned. Earlier this year, a Los Angeles jury awarded \$500,000 to a woman who said Cosby sexually abused her at the Playboy Mansion when she was a teenager in 1975.

Pinkerton says the alleged assault came after she had met Cosby in New York and he promised to help her career. She says she had a role in an episode of "The Cosby Show" on NBC, but did not appear in the final edit. Months after the alleged assault, Pinkerton said Cosby invited her to his show at a Chicago theater, where she claims he forcefully kissed and touched her.

"Cosby engaged in the same or similar pattern of conduct with his victims," Pinkerton's lawsuit says, "including expressing interest in advancing their careers, giving them roles on The Cosby Show, using The Cosby Show and its filming locations as a means to access, isolate, sexually harass, and sexually assault women, using drugs to incapacitate his victims, and forcibly engaging in sexual acts with them without their

The lawsuit alleges that NBC, Kaufman Astoria Studios and Carsey-Werner Television should have known Cosby was a danger to women and failed to protect Pinkerton from him.

Wyatt said Friday night that Cosby "continues to vehemently deny all allegations waged against him and looks forward to defending himself in court."

"As we have always stated, and now America can see, this isn't about justice for victims of alleged sexual assault, it's ALL ABOUT MONEY," Wyatt wrote in an email to The Associated Press. "We believe that the courts, as well as the court of public opinion, will follow the rules of law and relieve Mr. Cosby of these alleged accusations."

Representatives of NBCUniversal, Kaufman Astoria Studios and Carsey-Werner Television did not immediately respond to requests for comment Friday night. All three companies were involved in the production of "The Cosby Show," Pinkerton's lawsuit said.

The lawsuits by Pinkerton and the five other women were filed under New York's one-vear window for adults to file sexual abuse complaints for allegations that had fallen outside the statute of limitations to

Cosby served nearly three years in prison before the Pennsylvania Supreme Court overturned his conviction, finding that he gave incriminating testimony in a deposition about the encounter only after believing he had immunity from prosecution. The trial judge and an intermediate appeals court had found no evidence of such immunity.

HERE is something new in Gospel music, for those who follow its love and hate relationship with 'worldly music,' traditionally seen as evil in sermons, that it is one among the doors where doors are opened for 'revolt' against several cardinal prohibitions of preachers.

That isn't surprising for music in history comes up as selfexpression, where youths and priests say what they want, but are mindful of the priests.

If a song is banned it has hurt not public authorities but priests, first.

That is an essential parameter of civilization as what distinguishes civilized life from barbarism is the prohibition of public nudity, along with various forms of violence, but clearly society has struggled to remove inclination to violence from priests.

A minimum of violence is seen as necessary in tradition not just in raising children but in maintaining conjugal loyalties, something that modern society, led by the West, puts into question and admittedly, systematically

This theme of violence is not usually explored in music as it is more accustomed to psychological violence or mental torture arising from rejection or humiliation than if a woman is slapped in conjugal conflicts or tiffs.

That on the contrary is the stuff of social media, not concerned

with the slapping per se but sustainability of their relationship.

It isn't a theme tackled by Gospel music either as their primary concern, at least from early days of the fifth phase presidency, is personal success.

The fifth phase was a sea change in Gospel music as it altered in a profound way the usual expectations of the bureaucracy and those living in relative satisfaction around them, which includes the success of numerous businesses tied up with bureaucratic spending.

It wasn't just Gospel music that was affected but prayer as such, not the regular mass which remained unchanged despite that at times there are themes in preaching that reflect what is trending, being disputed. It was among independent churches, those devoted to psychotherapy, to help one solve

What Gospel music has done independent in character and in this situation isn't to underline the theological fine points involved but merely living the vast difference of sentiments between the older success-presumption of doing business, to obedience like most traditional removing obstacles to success in one's life.

With the newer themes of preaching that actively involve breaking the power of traditional spirits in individual life, undercutting themes of traditional existence that preaching never closed upon, the salvation fear has been erased.

WHETHER or not Pelé scored almost 1,300 goals in his professional soccer career, all of his biographers agree that the three-time World Cup champion wrote more than 100 songs and sold more than 100,000 copies of one of his al-

He was also in the movies, notably in the World War II film "Victory," and was one of the stars of a Brazilian comedy that brought more than 3.6 million people to the theaters in the South American nation.

Pelé, whose full name was Edson Arantes do Nascimento, died Thursday with cancer at a hospital in Sao Paulo. He

Pelé's success on the soccer field made him a sports icon, but he added to that with many performances as an actor and singer.

Ronaldo Saudi move to signal likely end of elite club career

LESS than two weeks after his great rival Lionel Messi lifted the World Cup, Cristiano Ronaldo has completed a move to Saudi Arabian club Al Nassr and likely signalled the end of his career in elite club soccer.

In agreeing a contract until 2025, the five-time Ballon d'Or winner has ended speculation about his future after having his contract terminated by Manchester United last month.

"I am fortunate that I have won everything I set out to win in European football and feel now that this is the right moment to share my experience in Asia," Ronaldo said.

Al Nassr described the deal as "history in the making," however, it is likely to raise questions about Ronaldo's ambition at this stage of his ca-

While Messi finally won the one major trophy that had evaded the two men widely regarded as the greatest players of their generation, after leading Argentina to the World Cup in Qatar, Ronaldo will be playing outside of top level European soccer for the first time in his career.

Media reports have claimed the 37-year-old Portugal international could earn up to \$200 million a year from the move, but he will miss out on the chance to extend his record as the alltime leading scorer in the Champions League with his record currently standing at 140 goals.

Messi is on 129 goals in the competition. Ronaldo is also unlikely to add to his Ballon d'Or collection - the trophy awarded to the best player in the world.

Meanwhile, Messi will be among the favourites to win that trophy for an eighth time next year after his World Cup triumph.

He also has the chance to win the Champions League with Paris Saint-Germain, having lifted European club soccer's biggest prize on four occasions with Barcelona. Ronaldo won the Champions League five times during spells with United and Real Madrid.

Six months ago Ronaldo wanted to join a team playing in the Champions League after United failed to qualify for this season's competition.

However, a move never materialized, with the most serious interest in him coming from an unnamed Saudi Arabian club.

It is not known what other serious offers were made after he became a free agent last month, but the move to Al Nassr represents a significant step down compared to the level he has oper-

ated at throughout his career. Still it is a major coup for soccer in the Middle East and will add to the debate over Saudi Arabia's attempts to use so-called "sportswashing" to improve its reputation internationally after its sovereign wealth fund led a buyout of Pre-

mier League club Newcastle United last year. "This is more than history in the making. This is a signing that will not only inspire our club to achieve even greater success but inspire our league, our nation and future generations, boys and girls to be the best version of themselves," Al Nassr posted on social media.

Ronaldo remains one of soccer's biggest global icons, but the move comes at a time when he has faced questions over his ability to still produce his best form at the highest level.

He managed just three goals for United in 16 games this season, with one of those coming from the penalty spot. He became the first male player to score in five World Cups with his penalty in Portugal's 3-2 win against Ghana in Qatar, but ended the tournament having been dropped for his country's last two games before going out to Morocco in the quarterfinals.

By comparison Messi inspired Argentina's third World Cup triumph, scoring seven goals, including two in the 4-2 penalty shootout win against France in the final after a 3-3 draw through extra time.

Ronaldo and Messi have had their achievements compared throughout their careers.

Messi's World Cup win saw him emulate soccer greats Pele and Diego Maradona by lifting the sport's biggest prize.

To many, it will also have given him the edge in his personal rivalry with Ronaldo. And at the age of 35, he still has time to further embellish his career in top level soccer.

Meanwhile, Ronaldo has earned headlines in recent months for his antics away from the field.

He was dropped and made to train away from United's first team when refusing to come on as a substitute in a game against Tottenham in October. He then conducted an explosive interview with Piers Morgan in which he criticized manager Erik ten Hag and United's owners the Glazer family.

It led to the termination of his contract, his eventual move to Al Nassr and the next chapter of his career away from the glare of top flight European soccer.

The result left secondplaced City seven points behind Arsenal heading into 2023 after the Gunners won 4-2 at Brighton in Saturday's late clash.

City manager Guardiola, reflecting on Everton's tactics, said: "They made a fantastic goal with the first shot on target they had, so we played a real, real good game.

"Of course the result was not expected but that is football, it is not the first time it happened. We did everything to win. They played really well." The Spaniard added:

"Afterwards they broke a bit the rhythm because the referees were not ready but, in general, we did everything and unfortunately could not win."

US soccer owes almost everything to Pele, says former New York Cosmos teammate

US footballer Bobby Smith does not hold back his tears when paying tribute to "King" Pele: the rise of the game in the United States owes almost everything to the Brazilian legend, says his former New York Cosmos teammate.

Still athletic at 71, Robert "Bobby" Smith spoke to AFP at his training center for budding players, the Bob Smith Soccer Academy, in his native New Jersey.

At the edge of the indoor synthetic fields where children train, Smith, who was a top defender in his younger days, gazes fondly at a giant poster of him and Pele, who died Thursday of cancer at the age of 82.

Smith, a professional player in Philadelphia in the 1970s, signed in 1976 with the New York Cosmos for \$100,000. Pele, coming out of semi-retirement at 34, had signed a year earlier for at least 10 times that amount and would lead the Cosmos to the 1977 championship, with 31 goals in 56 games.

Smith hopes, he added, that the trend will continue, with the United States, Canada and Mexico set to co-host the 2026 World Cup.




