Mbowe, 3 others facing six counts of terrorism

PROSECUTION attorneys yesterday read out to Chadema national chairman Freeman Mbowe and his three co-accused persons six counts of terrorism-related offences at the Kisutu Resident Magistrate's

State attorneys Pius Hillary, Christopher Msigwa and Sylvia Mintato told Principal Resident Magistrate Thomas Simba that investigations into case number 63 of 2020are complete.

Hillary named the accused persons as Mbowe, Halfan Hassan, Adam Kasekwa also known as Adamo, and Mohamed

In the first count, he alleged that between May 1 and August 1 2020, at Aishi Hotel located within Moshi municipality in Kilimanjaro Region, and at different places in Dar es Salaam, Morogoro and Arusha regions, all the accused persons conspired to blow up filling stations to endanger national security and cause alarm.

In the second count, the prosecution alleged that within the same time and at the same places, Mbowe facilitated

He ordered that the accused persons be produced in court on Friday next week when witness statements will be read, paving the way for the case to proceed to the High **Court for hearing**

Halfani, Adamu and Lingwenya financially while aware that the money would be used to commit terrorism, namely to blow up filling stations and gatherings to disrupt political stability, constitutional order, the country's economy and put into disrepute the good name of the United Republic of

In the third count, Hillary alleged that Halfani, Adamu and Lingwenya collected money from Mbowe with the intent of using the same to enable blowing up of filling stations and other gatherings.

In the fourth charge, the prosecution alleged that on August 5, 2020, Adamu was found in possession of a pistol, Luger brand number A 5340 without a licence.

In the fifth count, Hillary alleged that within the aforesaid period and places, Adamu was found with ammunitions, namely three bullets, without a licence.

In the sixth count, it was alleged that on August 10, 2020, Halfani was found in possession of military uniforms and other items belonging to the Tanzania People's Defence Force (TPDF) and the National

Hillary named the items as five trousers, one T-shirt, one raincoat, one jacket,

WHO allays fears tied to Covid-19 vaccines safety

THE World Health Organisation (WHO) yesterday responded to questions relating to fears over the safety of the Johnson & Johnson's Janssen Covid-19 vaccine being administered in Tanzania, saying it was approved after passing all safety and efficacy tests.

Addressing journalists in Dar es Salaam yesterday, the WHO representative to Tanzania Dr Tigest Ketsela Mengestu (pictured) said vaccination offers strong immunity which protects against severe and deadly COVID-19.

"In this area, we still need more public awareness programmes to change the negative attitudes which some people express towards the vaccines. We appreciate that the media has been doing a lot to educate the public," she said.

The WHO official noted that mass vaccination started many years ago and has been producing positive results in the health status of millions of people, so Tanzanians should shed doubts on any vaccines which will be brought in the country after having been approved by WHO and other reputed global agencies.

"Yes, it has been done in the past and the same process is on-going for many COVID-19 vaccines available. They have to undergo stringent scrutiny of safety and efficacy," she explained.

Dr Mengestu cautioned that the variant delta is causing devastation and more variants with the potential to be even more dangerous are possible if robust measures will not be taken, including strengthening mass vaccination.

"However vaccines do not replace the need for frequent hand washing, social distancing, masking, sanitizing and avoiding crowds because it doesn't provide 100 per cent protection but it builds strong immunity to the vaccinated person from

National leaders who attended the national last respects ceremony in Dar es Salaam yesterday described the late minister as an example of a very well trained civil servant.



five caps, five overalls, one bag, four badges of corporal rank, four belts, one pair of socks, a sweater, a parachute training bag, a water keg and an AK 47 CCCP knife.

Hillary told the court that the prosecution decided to bring up the fresh charges because on 26 of last month, charges were read against Mbowe alone and the next day charges were dropped against three accused persons, reducing the

number of accused persons from seven to four and counts dropped from 13 to six.

In the new charge sheet, two counts of possession of heroin and five others of forging bank documents were dropped.

After finishing reading the charges, the state attorney said investigations were compete and the file was with the Director of Public Prosecutions (DPP). After the reading witness accounts in the next mention, the case could

proceed to the High Court for hearing, he stated.

The defence team is comprised of nine lawyers, namely Peter Kibatala, Lwekamwa Rweikiza, John Mallya, Fredrick Kihwelo, Selemani Makoweka, Michael Rugina, Iddi Msawanga, Jebra Kambole and Sisty Aloyce.

Lead counsel Kibatala asked that the witness accounts be read as soon as possible so that the case can proceed and the accused persons know what awaits them next.

Magistrate Simba said the case has been dragging in that court since August 2020 and some of the accused persons have been remanded since then, in which case if investigations are now complete, there is no reason to waste time.

serious illness," the WHO medic intoned.

Dr William Mwengee, WHO Tanzania vaccine program manager, remarked that vaccine production passes through several stages including intensive research and trials on animals and at higher stages, human trials before being supplied for mass rollouts.

During clinical trials, a vaccine is checked at preclinical stages where animals are tested and in. phase one it tests the safety and immunogenicity to low-risk individuals to determine tolerability. Then it goes to phase two of monitoring safety, potential side effects, immune response and determining optimum dosage, he

"The third phase involves testing the vaccine efficacy in disease

prevention and further safety information through more diverse populations, multi-country study and longer time observation," he stated.

Mwengee commended Tanzanians for responding well and President Samia Suluhu Hassan for showing way and proving to Tanzanians that vaccines are important for their lives.

"We commend the government from national to lower levels for being in the fore line to show others. Regional and district authorities have played a huge role especially in advocating the importance of vaccination," he further noted.

Kwandikwa attended Shinyanga secondary school for A Level education, enrolled in the Institute of Finance Management and graduated with an advanced diploma in accountancy. He has worked with several organizations as an accountant.

He joined politics in 2014 and in 2015 vied for Ushetu constituency in Shinyanga and once served as deputy minister for Works and Transport.

In 2020 he won the Ushetu parliamentary seat and was appointed minister for Defense and National Service by the late president Dr John Magufuli.

Minister Kwandikwa died on August 2 at the Muhimbili National Hospital, leaving behind a wife and children.

enactment of the Finance Act, 2021 and budgetary recommendations which approved the introduction of the levies.

The outcry reached President Samia Suluhu Hassan who promised that the government will come up with a friendly modality on how to execute the newly-introduced mobile money levy which will not be a burden for the public.

So far this has not happened and top level officials have been defending the levies as they are, and it looks dim that any changes will be made soon.

Still observers wonder if the issue is the Act or the quotations formulated by the regulatory authorities, as in any case the government can levy any business conducted within the United Republic.

The president said the government has listened to concerns from the public and that a solution will be announced soon on the matter.

The Head of State said however that the government decided to introduce the levies to finance rural roads which were impassable and farmers were failing to transport agricultural produce to the market, in which case the levies will remain

CNN fires 3 employees for violating policy on coronavirus pandemic

Three employees at CNN have been fired for violating the network's coronavirus policy by coming into the office unvaccinated, according to US media reports.

In an internal memo emailed to staff Thursday and obtained by several US media outlets, CNN President Jeff Zucker said that in the past week the company had become aware of three employees who came to work unvaccinated. All three were "terminated".

"Let me be clear -- we have a zerotolerance policy on this," he said in snippets of the memo tweeted by CNN media reporter Oliver Darcy.

His memo did not specify the fired employees' names, positions or office locations. CNN did not immediately reply to a request for comment.

The network had been relying on an honor system that required workers to be jabbed but did not demand they show proof. But Zucker said that may change going forward.

Inoculations are mandatory for anyone reporting in the field, working with any other employees or entering the offices, he reportedly

In May, the United States federal government said it was legal for employers to require staff physically entering the workplace to be vaccinated against COVID-19.

Tech giants including Facebook, Google and Microsoft have all said they will require employees to get jabbed before returning to their US

They are among several major US employers that have recently revised their virus policies, vaccine mandates or return-to-office dates as the fast-spreading Delta variant fuels another surge of Covid-19

In his note to staff, Zucker said CNN will postpone its company-wide September 7 return-to-office date likely until sometime in October.

Roughly one-third of the network's American newsroom staff are currently using the offices on a voluntary basis, he said.

NHC to invest in commercial buildings in the country's border areas - Banyani

THE National Housing Corporation (NHC) has started implementing strategies to invest in commercial buildings in the country's border areas.

NHC director general, Dr Maulid Banyani made the statement mid this week here during the launching of 50 new residential houses at Buhare area in Musoma District, Mara Region, an event which graced by deputy minister for Lands, Housing and Human Settlements Development Dr Angelina Mabula

"We have already started implementing strategies of ensuring that NHC operates commercially and improve income, we have already constructed modern commercial buildings in border areas such as Mutukula, Kagera and we are now looking at the possibility to invest in the Tanzania and Kenya border," he said.

US govt hands over TB diagnostic kits to support health facilities in Tanzania

THE US government through the United States Agency for International Development (USAID) has transferred laboratory equipment worth 424,361,043/- (\$ 182,993) to 19 health facilities in Katavi, Kigoma, Rukwa, and Songwe regions.

The equipment will strengthen tuberculosis (TB) diagnostic capacity which will ultimately result in an increase in TB cases identification and hence contribute to TB control in Tanzania. These four regions are supported by USAID's Uhuru TB and Family Planning Facility Solutions Activity for Local Organizations Network (TB & FP LON).

Tanzania Health Promotion Support (THPS) Executive Director, Dr Redempta Mbatia, transferred the eight GeneXpert machines and 11 iLED microscopes to Songwe Regional Commissioner, Omary Mgumba, who received the equipment on behalf of all four regions.

The event took place at Mlowo Dispensary in Songwe Region. Attendees included representatives from the Ministry of Health, Community Development, Gender, Elderly and Children, President's Office Regional Administration and Local Government (PORALG); Songwe's Regional Medical Officer, Regional TB and Leprosy Coordinator, Regional Laboratory Technologist; and District Medical Officers for Mbozi and Tunduma Districts.

The donated equipment will be installed at health facilities with high patient volume, identified by regional health managers. Tanzania ranks among the 30 highest TB burden countries in the world. USAID's Uhuru TB and FP LON Activity aims to improve access to and use of quality TB and family planning services for better health outcomes in Katavi, Kigoma, Rukwa, and Songwe regions.

Prior to this donation, these four regions had only 16 GeneXpert machines and 13 iLED microscopes serving a population of nearly 6 million. This results in low health facility and community TB case identification. GeneXpert diagnostic equipment reduces diagnostic turnaround time from two - three weeks to 90 - 120 minutes. iLED microscopy will be used to increase TB case detection at the facilities with no GeneXpert machines.

Speaking about the event, USAID Mission Director, Kate Somvongsiri said: "The eight GeneXpert machines and 11 iLED microscopes are part of USAID's ongoing commitment to strengthen tuberculosis laboratory services in Tanzania. These gadgets are expected to increase identification of TB patients with an emphasis on reaching marginalized populations and reducing inequities in TB services. In order to realize the country's mission to end tuberculosis by 2030, patients should be identified in a timely manner and treatment initiated early.'

THPS, a Tanzanian non-governmental organization, is implementing this activity in collaboration with Baylor Tanzania, MKUTA, and Ifakara Health Institute. THPS works in partnership with the MOHCDGEC and PORALG, the Ministry of Home Affairs and Ministry of Health in Zanzibar to ensure accessible high-quality health care services to Tanzanians. Their work includes strengthening health and community systems for comprehensive quality health services which address HIV/AIDS; tuberculosis; prevention of gender-based violence; reproductive, maternal, neonatal, child, and adolescent health services; and laboratory and health management information systems.

New TANROADS CEO tasked to supervise country's 36,000 kilometers of road networks

Minister for Works and Transport, Eng Leonard Chamuriho, has directed the newly appointed Chief Executive Officer of the Tanzania National Roads Agency (TANROADS) Eng Rogatus Mativila to work on challenges facing the agency and ensure proper supervision of the country's 36,000 kilometers road networks.

He made the statement in Dar es Salaam on Thursday during an event to invite the new CEO in office.

Eng Matavila was last week appointed by President Samia Suluhu Hassan as the new TANROADS CEO to replace the late Engineer Patrick Mfugale who passed away on June 29, 2021.

Prior to that appointment Mativila was the Director of Roads, at the Ministry of Works and Transport (Construction Sector).

According to the Minister, TANROADS supervises construction and maintenance of the roads at tarmac level as well as construction of bridges countrywide.

He urged the agency to make sure the roads are passable throughout the agency's board members.

It is supported by the Forest and Farm Facility (FFF) which is a partnership involving the Food and Agriculture Organization (FAO) of the United Nations and other partners.

To improve her knowledge in farming, Odilia Jiovin relies on listening to MVIWATA FM's agricultural radio programs, and this has helped her as well as other farmers to learn better farming skills.

The agricultural advisory services have been made easy for Odilia and other farmers through the radio service as they get to learn, ask questions, and gain knowledge that they later apply to their farms.

"I know that I am privileged to listen and follow different programs aired through MVIWATA FM", says Odilia Jiovin, a farmer from Kilosa District, known for production and marketing of sunflower, coconut, sugarcane, and sisal in Morogoro Region.

"I always take the initiative to share the information with my fellow farmers in our community and apply the knowledge shared through the radio on my farm where other farmers come and learn too," she says.

MVIWATA FMattracts smallholder farmers, youth and other marginalized groups, reaching approximately 250,000 people in the rural and urban areas of Tanzania.

The radio station has designed its programs to focus on information, education, knowledge sharing, and entertainment related to agricultural practices, and fills the gap left by mainstream media outlets that provide only limited coverage of issues relevant to rural people.

Listeners can tune in to programs

produced by a team of journalists who work closely with MVIWATA, MVIWATA is the Swahili acronym and the airwaves also carry recordings of farming community group meetings.

> The various agricultural practices shared through MVIWATA FM have significantly helped farmers to improve farm preparation and pest management, which has helped ensure higher yields.

> Odilia says that MVIWATA FM programs, like Uzalishaji endelevu (Sustainable Production), taught her about integrated pest management, a low-cost and effective method which she applied in her horticultural farm and which saved her crops, and her money.

> Educational programs information sessions have also supported farmers at the community level.

> In Ilonga village in Kilosa distric, for example, information on the process of participatory planning helped the community to request a budget for the construction of a health centre. As a result, the central government has allocated some funds for the construction in the 2021/2022 budget.

> Other program topics have included crop diversification, market access, social accountability, and handling land disputes.

The Forest and Farm Facility (FFF) supports MVIWATA to share information with family farmers through the radio, sensitizing them on new processes and better farming techniques to improve their livelihoods.

The FFF is a partnership between FAO, the International Institute for Environment and Development, the International Union for Conservation of Nature and AgriCord, and was launched in 2012 to improve rural farming, forestry, and farmers' organizations through collective action.

Director of Policy and Planning in the Ministry of Health, Community Development, Gender, Elderly and Children Edward Mbanga made the revelation in Dar es Salaam yesterday when addressing participants of a conference aimed to discuss ways to improve provision of health insurance services in the country.

"Not all Tanzanians are capable of paying for health insurance; the government intends to identify them and see how it can assist them to get health insurance. So far, only 14 percent of Tanzanians are registered with health insurance services," said the official who represented Health Minister, Dr Dorothy Gwajima.

According to Mbaga, the government is still working on modalities to implement the exercise. He called upon firms offering health insurance services to further improve their services as well as coming up with different packages to allow more people to register.

"I was depressed and ashamed to interact with friends and relatives because of fistula. My husband who was my source of support told me at one point that he almost abandoned me. I was not a happy woman as a result of fistula predicament," recollected 38-year-old Maseray Bangura, a petty trader from Mambolo, chiefdom headquarter town in the Kambia District.

Obstetric fistula, a childbirth injury wherein a hole develops between the birth canal and the urinary system resulting in constant leakage of urine or faeces is often the direct result of failure by a health system to provide quality health care during childbirth.

Women who develop fistula often have prolonged labour due to the failure to make a timely decision to go to the health facility when labour starts, or a delay in reaching a health facility due to a poor referral system or bad road network, or the failure of a health facility to provide timely and apt treatment to women during childbirth.

Approximately 2 million women currently live with fistula globally.

In 2003, in line with universal targets to advance maternal and new-borns health and with the goal of making fistula as rare as possible, UNFPA and its partners launched a global campaign to end fistula.

In Sierra Leone, therefore, UNFPA is addressing fistula prevention (as well as prevention of maternal and newborn mortality and morbidity, and stillbirth, and improving the quality of maternal care) by supporting the Ministry of Health and Sanitation in improving quality services for pregnant and postnatal women.

When Maseray was discharged a week later, she realized she had developed serious complications, having returned home with fistula. "Four days after returning home, I realized I was leaking urine unconsciously. This was too much her delivery to the Government for me. Obstetric fistula is preventable and in most cases can be repaired surgically. In Sierra Leone, with funding from the Government of Iceland, UNFPA partners with nongovernmental organizations like Haikal Foundation and Aberdeen Women's Centre to conduct screening for women with suspected obstetric fistula, and surgery to repair their fistula and restore their dignity. UNFPA also supports the government in preventing the incidence of obstetric fistula by strengthening the quality of obstetric services, a key component to addressing maternal mortality.

In 2020, for instance, 260 women were screened for suspected obstetric fistula. Of these women, 129 had surgery to repair their fistula, with 31 of them receiving livelihood skills as part of their rehabilitation and reintegration. Since 2011 to date, Aberdeen Women's Centre, with funding support from UNFPA, has successfully performed 1,731 fistula surgeries. When Maseray learned of the work of Aberdeen Women's Centre, she travelled to Freetown with her husband to be admitted at the centre for her fistula surgery.

"I successfully underwent the surgery without paying a cent. I have seen so much improvement and I am beginning to gain my happiness and self-confidence. My dignity has been restored. I have spent a week without experiencing urine leaks. My wish now is to return to my

Tanzania overtakes Kenya as Uganda's largest source of imports in EAC region

KAMPALA

TANZANIA capped an eightmonth surge in exports to Uganda during June, replacing Kenya as Uganda's biggest source of imports within the East African Community (EAC), according to data from Bank of Uganda.

Uganda's imports from Tanzania have for the last three-months doubled, increasing by an average of 18 per cent.

During June, Uganda imported goods worth \$125.12m (Shs444b) from Tanzania, indicating a 43 per cent surge from \$70.07m in the same period last year.

However, this was a reduction from \$149.38m and \$125.91m that had, according to Bank of Uganda, been recorded during May and April, respectively. However, the report indicates a wide trade imbalance

between the two countries with Uganda exporting goods worth \$10.07m during June. Exports during May and April stood at \$8.78m and \$9.34m, respectively.

During the three months from Kenya stood at \$83.25m, \$71.78m and \$66.85m, respectively. This put Tanzania ahead of Kenya as Uganda's main source of imports within EAC.

Imports from Rwanda during June, stood at just \$0.14m, reducing from \$0.24m and \$0.32m during May and April, respectively.

During June imports from Burundi stood at \$0.05m while DR Congo contributed \$1.82m, which was a growth from May's \$1.72m and April's \$1.71m.

Uganda imported goods worth \$0.71m from South Sudan, a reduction from \$0.96m and \$0.79m in May and April, respectively.

According to data from Uganda Bureau of Statistics (Ubos), major imports from Tanzania include gold, rice, trailers and semi-trailers, rolled iron and non-alloy steel and dried and salted fish as well as rice April to June, Uganda's imports from and wheat. Uganda is, however, concerned by the increasing trade deficit that currently stands at \$105.31m within EAC.

> Of this, Tanzania accounts for the largest share, standing at \$138.2m. During the period, South Sudan

and Kenya accounted for the largest export destinations in the region for Uganda's exports, accounting for \$51.5m and \$48m, respectively.

Uganda's export receipts within EAC have grown by 73 per cent from \$67.31m in May last year to \$116.56m, while imports have almost doubled, growing by 44 per cent from \$153.95m to \$221.87m over the same period.

HUMAN-DRIVEN climate change is fuelling weather extremes – from record drought to massive floods that are hammering key agricultural regions around the world.

In July, a video went viral on social media in Argentina showing people walking across what looks like a desert. But it isn't a desert.

Besides damaging crops, the drought also means barge-hauled grains can't get to market cheaply, forcing Argentina to support commodities transport with \$10.4 million, and costing the nation's grain farmers and exporters \$315 million. It's likely consumers will ultimately foot the bill.

Extreme heat waves and drought have smashed records across the U.S. West, from southern California to Nevada and Oregon. As the drought unprecedented mega California's water deepens,

regulators this week took a highly unusual step: forbidding thousands of farmers from extracting water from major rivers and streams for irrigation. The drought is surely going to be bad news for spaghetti lovers: California grows more than 90% of America's canned tomatoes and a third of the world's supply. Expect much higher prices and "cue the tomato hoarding.'

Meanwhile, 91 wildfires are currently raging across the U.S., devastating ecosystems and infrastructure. Three million acres have burned so far this year, with the fire season far from over, while during the same period last year only 2.1 million acres burned.

Western U.S. climate changeinduced mega fires are also having adverse agricultural commodities impacts, with farmers and ranchers now saddled with skyrocketing fire insurance rates, often increasing by tens of thousands of dollars.

"The trend has sent shock waves through California's agricultural regions," says online environmental news service Grist. Those exorbitant insurance rates could push some farms out of business, or make agriculture too risky to insure.

Farther east, in Colorado and Utah, cattle ranchers are feeling the pain too. As their drought worsens, many have reluctantly decided to cull their herds. "Everyone is gonna be selling their cows, so it's probably smarter now to do it, while the price is up, before the market gets flooded," said Buzz Bates, a rancher from Oab, Utah.

The West's drought has also created ideal conditions for grasshopper eggs to hatch, leading to widespread infestation and

crop loss. "I can only describe grasshoppers in expletives," said one Oregon farmer. "They are a scourge of the Earth ... They just destroy the land, destroy the crops."

Drought this year is exacerbating hunger in some of Earth's poorest countries. Southern Madagascar is experiencing its worst drought in four decades. Maliha, 38 years old and a single mother of eight, told Reliefweb: "Since the rain stopped, the children are not eating regularly. I give them whatever I can find, like cactus leaves. With this diet, they have diarrhea and nausea, but we have no choice. At least it doesn't kill them."

According to World Food Programme Executive Director David Beasley, the food crisis in Madagascar has been building for years: "There have been back-toback droughts which have pushed communities right to the very edge of starvation." More than 1 million Madagascans have been left "food insecure," without access to "sufficient, safe and nutritious food," he said.

He's emphatic as to the reason: "This is not because of war or conflict; this is because of climate change."

As disaster follows disaster, some evoke tales of the 10 plagues found in the Old Testament, sent by God to punish humanity for its evil. Not even the plague of locusts is missing: Just a year ago, the Greater Horn of Africa and Yemen suffered the largest desert locust outbreak in 25 years, triggered by record rains. In Ethiopia alone more than 356,000 tons of cereals were lost, leaving almost 1 million people food

Greater regional integration has the potential to support industrialization by increasing intra-African trade and intra-African investments, through the free movement of capital.

Our goal must be to provide jobs and opportunities, particularly for Africa's growing population of youth. Industrialization can and must also be a tool for women's empowerment and gender equality.

For this we must invest in appropriate vocational and skills training and closing the digital divide.

Time is running against the party. The GDC seems to be actively engaging the electorates on its agenda. The GDC leadership has the most effective political articulation which

political mobilization. Going by the party's gains in the 2016 elections, if the numbers increase significantly in terms of support and in a united alliance with other parties then a breakthrough in 2021 elections will be certain.

The party has accomplished a lot in bringing development to communities across the country. The GFA leadership is the most experienced in governance and to a large degree in politics. However, the party hailed from a split party (PPP) and could affect the party's rating and acceptance by the people. An alliance with GFA will be feasible because of the formidable character of its leadership.

Based on the outlook of these parties, predictions as to which of them will win the 2021 elections may be comparatively more accurate after a clear picture of the voter registration exercise. And, also, when the campaign begins and turnouts are assessed, December 4th will be a critical moment in the contest for power. On that day, the pretenders will be separated from the contenders.

Budgetary allocation to fight rape is extremely necessary

OING through budgetary appropriations of the Special Budget that is to cover July to December, there is glaring notice that there is no allocation for the combat of rape - an endemic the country is battling.

IN September 2020, President George Manneh Weah declared rape a national emergency. He also introduced the first set of new measures to address the increase in violence against women. The measures include designating a specific prosecutor to handle rape cases and setting up a national sex offender registry. He is also creating a national security task force to handle sexual and gender-based violence and is allocating \$2 million to address the issue.

Sexual violence against women increased by 50 per cent in Liberia during the pandemic. The Ministry of Justice recorded more than 600 reported rape cases between Ianuary and June 2020 alone, a rate close to reaching annual levels. Liberia recorded 803 rape cases in 2015, according to a UN report.

Women and girls around the world face an increased risk of experiencing gender-based violence because they are more likely to be trapped at home with their abusers and lack resources to escape. Disruptions in social services and health care are making it even more challenging for survivors to seek

China steps up mass inoculation to curb Delta variant

BEIJING

OCAL authorities in China have ramped up mass vaccination drives to contain the latest resurgence of COVID-19 attributable to the highly contagious Delta variant.

A total of 17 provincial-level regions on the Chinese mainland had reported locally transmitted infections linked to this coronavirus strain as of Wednesday.

More than 1.7 billion doses of COVID-19 vaccines had been administered on the Chinese mainland by Tuesday, according to the National Health Commission (NHC). It took China less than a week to administer the most recent 100 million vaccine jabs. The country's mass inoculation campaign has accelerated since multiple places reported local COVID-19 infections related to the Delta variant.

On Wednesday, the Chinese mainland reported 62 new locally transmitted COVID-19 cases -- 40 in Jiangsu, nine in Hunan, three each in Beijing, Shandong, Henan, and Yunnan, and one in Hubei, according to daily updates by the NHC.

In central China's Hunan Province, health authorities have set up over 3,000 vaccination sites to meet the growing demand. Long queues can be seen at several vaccination sites in the provincial capital Chang-

"The public has been keen to get vaccinated in recent days, so we have launched an online appointment platform and trained our staff to provide better services," said Zhang Sili, a nurse at a vaccination station in Changsha's Tianxin District. Zhang added that the vaccination station has so far administered about 87,000 vaccine jabs to some 55,000 local residents.

Official data showed that as of Tuesday, Hunan had administered more than 67.8 million doses of COVID-19 vaccines, with over 25.5 million people in the province fully vaccinated against the novel coronavirus. China is orderly propelling its vaccination program among senior citizens and minors aged between 12 and 17, on the premise of ensuring safety.

By July 28, a total of 150 million people aged 60 and above in the country and 12.48 million minors in the aforementioned age group have been vaccinated against COVID-19, according to the NHC.

In Chengdu, capital of southwest China's Sichuan Province that has recently reported a cluster of local COVID-19 infections, parents have been keen to get their children inoculated since the megacity extended its vaccination program to minors in early August.

"The Delta variant is very infectious, and I will feel safe after my kid gets vaccinated," said a Chengdu resident surnamed Chen, who took her 12-year-old daughter to a local hospital for inoculation. As of Tuesday, more than 3.6 million doses had been administered to minors aged between 12 and 17 in Sichuan, according to the provincial health commission.

China's top medical experts have pointed out that COVID-19 vaccines are effective against the Delta variant. Shao Yiming, a researcher with the Chinese Center for Disease Control and Prevention, said in a recent interview that although no vaccine can provide 100 percent protection against viral infections, various COVID-19 variants can still be controlled with existing

Citing evidence-based studies, Shao noted that China's domestic COVID-19 vaccines can effectively reduce rates of hospitalization, severe cases, and deaths.

Preliminary studies on the latest COVID-19 outbreak in south China's Guangdong Province show that China's homegrown vaccines are effective against the Delta variant, China's top epidemiologist Zhong Nanshan said Saturday. The protective effect of China's domestic vaccines is 100 percent effective against severe cases, 76.9 percent against moderate cases, 67.2 percent against mild ones, and 63.2 percent against asymptomatic carriers, respectively, Zhong added.

Promoting breastfeeding is a shared family and community responsibility

HIS week marks World Breastfeeding Week 2021. The Nourished Child project focuses on how interconnecting systems shape the diets of women and young children. In line with this year's theme of Protect Breastfeeding: A Shared Responsibility, two women in one of the Nourished Child study sites share their experiences of breastfeeding in their community, and talk about the systems and environments that influenced their

Esther Nqakala is 55 years old. She was born in Zweletemba, a low resourced neighbourhood near Worcester, the largest town in the Western Cape interior region, about 120km from Cape Town. Apart from six years spent in Johannesburg in the early 1990s, Zweletemba is the place she's called home for all her life.

Esther is also a keen breastfeeding advocate, as this is something she believes can help the children in her community reach their full potential and get their "minds prepared for school".

But Esther wasn't always this familiar with breastfeeding and all its benefits.

When Esther gave birth to her three daughters in

1985, 1990 and 1995 respectively, no one told her about exclusive breastfeeding, the practice of only offering your baby breastmilk and no other food and drinks. Though South Africa's breastfeeding policy between 1980 and 1999 did include recommendations to exclusively breastfeed for four to six months. Esther was not aware of this.

"I started giving foods like baby cereal from one month already. Nobody told me about exclusive breastfeeding." Though Esther continued to breastfeed all her children until the age of three, she practised mixed feeding from an early age.

South Africa has since aligned itself with Unicef and the World Health Organization recommendations of exclusive breastfeeding for the first six months of life, and the continuation of breastfeeding for two years and beyond. The benefits of breastfeeding are now more well-researched and well-known, with evidence for optimal breastfeeding practices reducing the risk of infant mortality through a variety of mechanisms, including offering protection against diarrhoea and respiratory infections, as well as offering long-term benefits for both the child and the mother.

"If I knew then, I would have done better," says

More than 30 years later, there are however many other women who are still doing exactly what Esther did in the 1980s and 1990s, which is to introduce solid foods and other liquids before the age of six months. Though exclusive breastfeeding rates in South Africa for the first month of life have increased from 11.3% in 2011 to 44% in 2016, only about 32% of women continue to exclusively breastfeed at five months. In a country where diarrhoea and respiratory infections are two of the leading causes of death among children under five, in addition to high levels of food insecurity, this may come as a surprise.

So why aren't more women, especially those whose children are more vulnerable to malnutrition due to unemployment (making formula milk financially out of reach) and diarrhoea due to poor water and hygiene facilities (thus making it more difficult to wash and sterilise bottles) not adhering to these recommendations?

According to Esther, it was only when she was recruited and trained as a fieldworker in 2011 to work on a research project related to breastfeeding, that she came to know and trust the benefits of breastfeeding. She research projects as a fieldworker. So when Esther's youngest, Ermillia Mutombeme, had her baby girl in February of 2020, it was understandable that Esther would encourage her to breastfeed from the start.

Ermillia's experience at Zweletemba hospital also reflected some of the work South Africa has done in promoting breastfeeding. "The nurse at the clinic told me to exclusively breastfeed until six months. She was very supportive and even helped me to hold my child so that she can drink better," Ermillia recalls. "I plan on breastfeeding at least until my little girl is 24 months," Ermillia says.

Ermillia is, however, one of a few that are lucky to have her mother's support. She says one of the biggest challenges is community support. "Women listen management recently, is cur-

to their mothers. But most grandmothers will say 'just give the baby food, then they will stop crying'. Then the mothers do

But even with her mother's support, Ermillia had to constantly remind herself why she chose to breastfeed, as alternative support was lacking.

"Having a baby is hard. For me, the first four months were really difficult. I had issues with the baby's daddy and I didn't sleep. I was depressed. So, it's easy to resort to being negligent and drink alcohol. You start thinking if you really want to be a full-time mom... I also had a lot of pressure from friends. I don't even blame other mothers if they don't breastfeed

 it's difficult if you don't have the motivation or support. But for me, I knew that it was the best for my baby and I wanted to give the best that I can."

Esther and Ermillia's stories echo what many researchers on this topic have found, and this year's World Breastfeeding Week theme calls for: breastfeeding needs to be seen as a shared responsibility.

"There are many reasons people give you not to breastfeed. has since been involved in many For example, they will say that it is too difficult to breastfeed if you work, or others will say you should rather give your baby food so that they don't cry in the evening. People listen too much to each other's advice. I think the fathers should also be more involved," says Esther, highlighting that it is not as simple as an individual choice, but needs to be supported, protected and promoted by communities, health systems and workplaces.

With Covid-19 seeing an increase in the country's food insecurity and unemployment, it makes even more sense not to rely on expensive formula milk and to support breastfeeding.

"At least buying formula milk is one less thing I have to worry about," says Ermillia who, despite having completed a national diploma in human resources rently unemployed and living in a room in her mother's backyard. Since 2016 she has also joined her mother on research projects as a fieldworker.

If they could draw up a wish list of actions they think will improve breastfeeding in their community, Esther and Ermillia both believe that it starts with educating the whole of the community – the grandparents, the men and the younger boys and girls - about the benefits of breastfeeding and the risks of not breastfeeding.

Practical tips for action Esther and Ermillia believe would work to increase breastfeeding in the Zweletemba community:

Create more capacity at clinics so that there is enough time for maternal and child health information sessions. "The clinics are very busy. Even though the nurses want to give more information, there isn't always time with everything else they need to do," Esther reflects.

Bring grandmothers along to clinic visits when the young mothers come for check-ups or bring their children for immunisations so that they too can hear the information sessions where the benefits of breastfeeding are shared. "Because in our community, you do as your mother tells you to do," says Ermillia.

Have workshops for men and young boys about the responsibility of having a child and the importance of healthy living for the mother while she is pregnant and for the baby to be breastfed exclusively for six months because it is superior to formula milk. "Men can have a big influence in this way," Esther suggests.

Emphasise to young men and women some of the personal sacrifices one needs to make when you have a child. "Parents and mothers need to know that life can't just continue like it was before the baby. You need to be okay if the baby cries without giving her food to stay quiet, and you can't always go out when you want to," say Ermillia.

GGML's local content initiative makes businesses in Geita thrive

LOCAL business content is one of the basic ways in which economies especially an emerging one, ensures that its people directly benefit from incoming/ foreign investments.

Upon enactment of the Mining Act in 2010 and supplementing Local Content Regulations in 2018 as well as its amendment in 2019, a new local content regime for Tanzanian mines was introduced to mining companies and their contractors/ suppliers as well as other allied entities.

The amended Mining Act included a requirement for mining companies to have a Local Content Plan. This Plan has always been an integral part of the mining industry, however, historically the main aspect of local content in mining laws pertained to the shareholding structures, employment and training of locals as well as having a succession plan in place.

This was to ensure that there was a clear strategy for the transfer of knowledge and preparing Tanzanians to fill positions which were at the time occupied by non-citizens. The other side of the local content nevertheless also positively impacts local businesses.

AngloGold Ashanti - Geita Gold Mining Limited (GGML) recently awarded a two-year fuel transportation contract, worth approximately \$10.8m a year, to two local Tanzanian contractors.


Amongst the benefitting local companies is Blue Coast Investment Limited, a Geita based company which deals with transport and logistics. Its specialized offerings in transportation, warehousing and value-added service have seen the company grow rapidly and develop a diverse customer base.

"Our strategy is to deliver long-term value for our customers by further leveraging our existing skills to streamline our operations and develop industryleading supply chain capabilities," elaborates Ndahilo Athanas, Managing Director of Blue Coast Investment Limited.

"I am grateful to Geita Gold Mining Limited (GGML) for implementing local content legislation and the Government of the United Republic of Tanzania for creating such a conducive business environment for local companies." says Ndahilo. Initially, Blue Coast Investment Limited struggled to acquire business opportunities from mining companies working in Geita. Winning the fuel transportation tender follows the amendment of the Mining Act and is preceded by a capacity building initiative for host community entrepreneurs funded by GGML. The initiative is implemented jointly with the National Economic Empowerment Council, under the Prime Minister's Office.

"The training has borne results. We learned a lot including compliance with necessary criteria on eligibility for supplying goods and services to the mining and other sectors. Upon reading a newspaper advert on a two-year fuel transportation tender, I felt my company stood a chance. It presented a golden opportunity for us to bid and compete. We are lucky that we were amongst two companies winning the tender," shares Ndahilo.

AfDB launches new transaction guarantee to support SMEs, trade in Africa

THE African Development Bank (AfDB), through its Financial Sector Development's Trade Finance operations, has launched a Transaction Guarantee instrument designed to provide up to 100% cover for non-payment risk to regional trade transactions initiated by local banks in Africa.

The guarantee will cover an array of trade finance instruments, including confirmed letters of credit, trade loans, irrevocable reimbursement undertakings, avalized bills and promissory notes.

In opening remarks at the virtual launch of the guarantee recently, Bank Director for Finan-prises, Small and Medium Sized cial Sector Development, Stefan Enterprises (SMEs) and local

Nalletamby stated: "We are excited about this new instrument as it offers us the flexibility to use our strong AAA rated risk bearing capacity to increase access to trade finance and boost intra/extra- African trade on the continent. Our target end-users will be women entrepreneurs, environment-friendly enter-

corporates through the facilitation of local participating banks. Priority will be given to low income and transition states."

The new instrument will provide much needed opportunities for local financial institutions to build relationships with international correspondent banks, increase links to a global network of trade finance partners and reduce the need for cash collateral, thereby increasing access to finance for SMEs across the continent.

This intervention is therefore strongly aligned with the Bank's High 5s, and its financial sector development strategy. whose main priorities are to broaden and deepen Africa's financial systems by putting finance at the center of the continent's productive capacity.

Trade remains an important driver of Africa's social and economic development despite the persistently huge trade finance gap. This is mostly due to lack of liquidity and risk mitigation facilities across the continent and has been exacerbated by recent market developments, such as increased banking regulations and global shocks like the Covid-19 pandemic.

The launch event was organized in partnership with Making Finance Work for Africa (MFW4A). It included a panel discussion featuring seasoned trade finance experts from IFC, Afreximbank, Ecobank, ODDO BHF and Moza Banco. Study finds that minority of animals host majority of zoonotic viruses

IN May 2020, Shivaprakash Nagaraju, senior scientist at The Nature Conservancy in India, was working in New Delhi when he contracted

"I had breathing problems and other symptoms, and as a result I was isolated in my room for around two months. And around that time there was news that COVID-19 likely originated in a wildlife market, and a lot of people were blaming the wildlife trade, so this built a curiosity in me to understand this connection, he said"

While experts have not yet confirmed the initial source of the novel coronavirus, it is believed to have passed from an animal to a human, a process known as zoonosis, at a major wildlife market in Wuhan, China. This suspected link has drawn intense attention to the wildlife trade both legal and illegal – over the last 18 months.

Alone and completely separated from his family, Nagaraju began collecting literature on the wildlife trade and zoonotic viruses and analyzing it; a task that, he said, staved off depression: "Though I was infected and going through symptoms, to keep my mind thinking positive, I started collecting data. If I had not been infected, I might not have thought seriously about going deeper into this."

As the COVID-19 pandemic continues to rage across much of the world, Nagaraju's new research paper in Current Biology has uncovered vital information: a small minority of animal species in the wildlife trade host the vast majority of known zoonotic viruses. Nagaraju and his team found that just 26.5% of mammals in the wildlife trade host 75% of known zoonotic viruses, "a level much higher than domesticated and non-traded mammals," they write.

Primates, ungulates, carnivores and bats present the highest risk, as these four groups alone harbor 132 of the 226 currently known zoonotic viruses, or 58% overall. However, according to the researchers, bats, rodents and marsupials pose the greatest risk in the future given expected shifts in the wildlife trade.

More specifically, primates alone carry 77 known zoonotic virus, eventoed ungulates host 62, and carnivores 41, highlighting these three groups as particularly acute spillover threats for future pandemics.

"I think one of the key messages we have provided is that most diseases come from just a few mammals with a lot of zoonotic spillover," Nagaraju said. "When you blame the wildlife trade for COVID-19, you could be saying that all animals carry disease, but this shows that specific groups carry a huge proportion of zoonotic diseases."

Trang Nguyen, founder of the Vietnamese wildlife conservation organization WildAct and an expert on the illegal wildlife trade, said data sets

such as this should be used by governments to better target risks of disease transmission.

"Transporting animals will always come with the risk of zoonosis, and it's important for countries to have a government agency that comprehensively screens legal wildlife imports for pathogens," he said.

"There must be collaboration between private industry and government officials to implement safer strategies, which include testing before transport and at the border, so that animal health certificates could accompany wildlife - similar procedures to what's re-

quired for livestock."

Nagaraju also argues for smarter policies built on a better understanding of exactly where zoonotic viruses may come from.

"You can try to keep these groups which actually pose a greater risk out of the wildlife trade," he said. "The legal trade is a \$300 billion industry and millions of people rely on it for their livelihood, and we need to understand that. So there is livelihood and food security associated with the wildlife trade, and complete bans aren't a solution, but you can keep zoonotic reservoir species out of the trade."

Enforcement agencies could also improve pathogen surveillance at wildlife markets to ensure that high-risk species aren't being sold.

Given its nature, the illegal wildlife trade – which in countries like Vietnam, consumes a wide range of mammals including pangolin, tigers, bears and civets - is much harder to monitor, a major concern for Nguyen.

"The risks associated with the illegal wildlife trade are huge," she said. "Over the past 40 years, humans have faced some of the most severe pandemic, including HIV, SARS, avian flu, swine flu, the Ebola virus, Zika and COVID-19, all of which stemmed from trading in and consuming animals and destroying their habitat."

With the world approaching 200 million COVID-19 cases, more than 4.2 million deaths and deep economic damage, Nguyen argues that addressing known high-risk aspects of the wildlife trade is essential: "The risks to human survival that come with the illegal wildlife trade must not be taken lightly, and it is time for actions to end the illegal wildlife trade and provide alternative livelihoods for those who depend on wildlife and resource extraction."

Right to life: Death penalty losing ground worldwide

is common to see a person beaten and hurt with machetes or stoned to death after being accused of committing an offence.

This culture of taking the law into our own hands has cost the lives of many innocent persons, who are survived by widows and children, some of who have turned into hapless dependants.

It's painful to hear that a close relative, friend, colleague or neighbour has been killed merely after being suspected of committing an offence. But even if that person were indeed guilty, he or she would still have the right to live and (possibly) reform. Lynching, judicial murder or extrajudicial killing deprives a suspected offender of this fundamental right.

But even the State itself can turn into an arbitrary killer if it obstinately imposes the death penalty and carries out executions, whose methods include beheading, electrocution, hanging, lethal injection and shooting.

A prominent American lawyer, Clarence Darrow, is quoted as

having said in one of his speeches: "We teach people to kill and the State is the one that kills them. If the State wishes that its citizens respect human life, then it should stop killing. The greater the sanctity that the State pays to life, the greater the feeling of sanctity the individual has to life."

In the Constitution of the United Republic of Tanzania, the right to life is not absolute. It is qualified (Article 14: Every person has the right to live and to the protection of his life by the society in accordance with the law). But in the constitutions of Kenya (Article 26), Rwanda (Article 12), South Africa (Article 11) and Mozambique (Article 40), for instance, it is unqualified - or absolute.

The Constitution of Mozambique expressly states that 'all citizens shall have the right to life' and that 'there shall be no death penalty in the Republic of Mozambique'.

In Tanzania, sections 26 of the Penal Code and 322 of the Criminal Procedure Act provide that a person sentenced to death shall suffer death by hanging. But although Tanzania is a retentionist of the death penalty, it is an abolitionist in practice.

Amnesty International (AI) reports show that the number of executions in the world as of December 31, 2020 dropped by 26 per cent, compared to the 2019 total - when 657 executions were registered - and also dropped by 70 per cent from the peak of 1,634 executions reported in 2015.

Just over two-thirds (about 67 per cent) of



the countries across the world have abolished the death penalty either in law or in practice.

Abolitionist nations for all crimes by December totalled 108, with only eight for ordinary crimes, 28 abolitionist in practice, 144 abolitionist in law or practice, and 55 retentionist.

There was a drop of 1,477 death sentences (36 per cent) in 2020 compared to 2,307 in 2019 and 3,117 (53 per cent) in 2016.

In sub-Saharan Africa, the number of death sentences dropped by 6 per cent - from 325 in 2019 to 305 in 2020. Meanwhile, the number of executions dropped by 36 per cent - from 25 in 2019 to 16 in 2020.

Chad became the first country in sub-Saharan Africa in the 21st century to abolish the death penalty for all crimes, while the commutation of death sentences rose by 87 per cent.

According to AI, there were at least 244 pris-

oners on the death row in Tanzania by the end

However, 123 states backed Resolution 75/183 of December 16, 2020 as adopted by the UN General Assembly (UNGA). This pushed for a moratorium on executions, with a view to abolishing the death penalty.

Kenya's Supreme Court, in Francis Karioko Muruatetu and Wilson Thirimbi Mwangi v Republic, abolished the death penalty for murder in December 2017 - leading to the commutation of the death sentence to life imprisonment.

Therefore, the death penalty is increasingly losing ground across the world. The reasons given include its being cruel, degrading and unconstitutional and above all for annihilating the right to - and sanctity of - life. So, its implementation lacks cogent justification.

The irony of it all is that the victim of execution is denied the right to live and reform, while the ends of criminal justice are deterrence to other would-be offenders, prevention of crime and retribution for the offences committed and the reformation of the offender.

In Republic v Mbushuu @ Dominique Mnyarore and Another [1991], the High Court of Tanzania held that the death penalty was cruel, inhuman and degrading, offended the right to dignity and violated the right to life. was not in the public interest and was unconstitutional.

It was consequently declared null and void. The High Court commuted it to life imprisonment. However, the Court of Appeal subsequently reversed it to death by hanging on the grounds that it was not arbitrary but was reasonably lawful and was constitutional.

In East Africa, Kenya and Tanzania are abolitionist of the death penalty in practice, South Sudan and Uganda are retentionist of the penalty while Burundi and Rwanda are abolitionist for all crimes.

Tanzania has for at least 26 years been an abolitionist of the death penalty in practice (no prisoner on death row is known or reported to have been executed during the period).

It is therefore high time we rethought its constitutionality and effectiveness, with a view to striking it off the statute book and commuting it to life imprisonment. This corresponds better to civility.

African farmers could benefit from more friendly EU agriculture policies

ILBERT Bor manages a small farm in the western highlands of Kenya. Landscapes are hilly, village roads lined with pine trees, his cows mostly of the Friesian breed. He is up at 6:00am daily to lead his animals through the woods into the valley

Most farmers in and around his village in Kapseret grow maize or beans for subsistence. But that is set to change, says Mr. Bor.

East African regional authorities have started promoting cash crops like avocados and coffee to increase Kenyan exports to the European Union and China. At the same time, local farmers are getting organized as well, says Mr. Bor. His own community collectively invested in a milk tank to strengthen its position on regional dairy markets.

"For products like coffee, mangoes or peanuts, Europe is an important market," Mr. Bor explains, enthusiastically. "Crops exported from Kenya are exempt from taxation in Europe. That also goes for exports to Europe from Ghana, Nigeria and the Francophone countries."

The EU is a global agricultural powerhouse. The 27-country bloc feeds a steady stream of processed foods, grains, dairy and meats onto the world market while importing large quantities of raw commodities like soy, sugar cane or palm oil, tropical vegetables and fruits like avocados.

Keeping an eye on EU policies Globalization is making markets better accessible to farmers like Mr.



Bor. He says: "Almost all EU countries purchase Kenyan agricultural goods. Who stands to benefit most will depend on what countries like Germany or the Netherlands decide. African farmers must keep a closer eye on European policymakers."

In particular, African farmers need to watch the evolution of the EU's Common Agricultural Policy (CAP) that was conceived in 1962 to provide affordable food for its population post-World War II.

Under CAP, the EU became so efficient that surpluses piled up. The authorities subsequently introduced export refunds—paving international traders the difference between the EU's high internal prices and lower world market prices.

Those subsidies put pressure on food prices worldwide, leading to detrimental effects on African farming economies.

However, the EU abandoned its trade-distorting subsidies in 2017. A year later the EU-Parliament, for the first time ever, commissioned a study on the impact of the CAP around the globe.

"In recent years we have seen progress in better aligning agriculture with international development goals," says Maria Blanco, head-author of the Technical University in Madrid, Spain.

However, simply increasing international trade in agricultural products would not automatically lead to better incomes for African farmers, experts say.

If unchecked, such trade could damage the environment, lead to the displacements of local peoples or human rights violations.

Ms. Blanco warns: "Importing sugarcane from outside Europe would create economic activity in the global south. But commodity imports from developing countries can also lead to land grabs or environmental pollution."

Commodities are usually grown on large plantations. Once money starts pouring in the stakes, economically and politically, are raised, which put small farmers at risk. The shift to industrial-style agriculture usually puts tremendous pressure on the environment when it comes to chemical usage, deforestation or water pollution.

Pressure from exports

Research by the thinktank ARC2020 and the German NGO Heinrich Böll Stiftung finds that the EU agricultural policy creates ripple effects around the globe.

Trade arrangements with Honduras, for example, concentrated the banana trade in the hands of few multinationals while the demand for grain and soya in Europe encourages land control in Central Asia.

Despite the positive outlook, African farmers are under unrelenting pressure of EU exports. After markets inside Europe were awash with milk after the bloc abandoned its quota system in 2015, Dutch and German producers quickly sought out other export opportunities.

Global dairy players like Danone or FrieslandCampina have increased their processing capabilities in West Africa. The FrieslandCampina subsidiary WAMCO controls no less than 75 percent of the milk market in Ni-

In Ghana increased exports of frozen chicken, from 13,000 metric tons in 2003 to 175,000 in 2019, have affected local production.

Over 90 percent of chicken meats in supermarkets in Ghana are imported from the United States or the

"Poultry has the highest turnover and its short cycle of production is for income generation for farmers in Ghana. But European exports of frozen chickens negatively affect our own meat industry," worries poultry farmer Anthony Akunzule.

Africa's free trade area

The newly established African Continental Free Trade Area (AfCFTA) could boost African farmers' efforts to compete with the EU. The trade agreement, which eliminates tariffs between African countries by 90 per cent and tackles customs delays, could foster intra-African trade in agriculture.

Professor of European Agricultural Policy Alan Matthews of the Trinity College, Dublin, says attention is rightly shifting attention away from the notion that CAP alone is responsible for Africa's agricultural woes.

Mr. Mathews says that African governments had failed to prioritize investment in rural areas, even as most experts now believe the AfCFTA will be a game changer for Africa's development.

What Africa farmers need are favourable policies and actions in both Europe and Africa, says Mr. Bor. For now, he says that, "Opportunities are all around for small farmers like me, mostly in the organic niche. IPS

The looted bronze artefacts of Benin

BENIN CITY

EARLY this week I read that Iraq had reclaimed 17,000 looted artefacts, its largest ever repatriation. The cuneiform tablets and other objects had been held by the Museum of the Bible, founded by the family that owns Hobby Lobby craft store chain, and by Cornell University, an Ivy League university.


The repatriation of so many objects rounds out a remarkable chapter in the story of a country so ravaged by decades of conflict and war that its very history was pulled out of the ground by antiquities thieves and sold abroad, ending up on display in other countries' museums. It is a victory in a global effort by countries to press Western institutions to return culturally vital artefacts. This reminded me of the push to repatriate

the famed Benin Bronzes to Nigeria

The Benin Bronzes are not actually from the country of Benin; they originate from the ancient Kingdom of Benin, now in southern Nigeria. They are also not made of bronze. The various artefacts known as the Benin Bronzes include carved elephant tusks and leopard statues, even wooden heads.

The most famous pieces are 900 brass plaques, dating mainly from the 16th and 17th centuries, once nailed to pillars in Benin's royal palace. There are at least 3,000 items scattered worldwide, maybe thousands more. Nobody is entirely sure.

You can find Benin Bronzes in many of the West's great museums, including London and the Metropolitan Museum of Art in New York. They are to be found in smaller museums too. The Lehman,

Rockefeller, Ford and, de Rothschild families have owned some. So did Pablo Picasso.

Their importance was appreciated in Europe from the moment they were first seen there in the 1890s. Curators at the British Museum compared them at the time to the best of Italian and Greek sculptures.

Today, the artefacts still leave people dumbstruck. Neil Macgregor, the British Museum former director, has called them "great works of art" and "triumphs in metal casting." But how did these precious works of art find their way to the Western

On 2 January 1897, James Phillips, a British official, set out from the coast of Nigeria to visit the oba, or ruler of the Kingdom of Benin. It is said that he took a handful of colleagues with him to persuade the oba to stop interrupting British trade.

Previously he had written to the colonial administrators seeking to overthrow the oba, but he was turned down. When Phillips was told that he could not see the oba because a religious ceremony was taking place, he went anyway. He did not come back.

Within a month, Britain sent

1,200 troops to Benin to take revenge for the killing of Phillips. On 18 February, the British Army took Benin City in a violent raid. The western media was full of colonial jubilation over the event, but none mentioned that the British troops used the opportunity to raid the city of its

precious artefacts. At least one British soldier was "wandering around with a chisel and hammer, knocking off brass figures and collecting all sorts of rubbish as loot," Captain Herbert Sutherland Walker, a British officer wrote in his diary. "All the stuff of any value found in the King's palace and surrounding houses, has been collected," he

Within months, much of the bounty was in England. The artefacts were given to museums, sold at auction, or kept by soldiers for their mantlepieces. Four items, including two ivory leopards, were given to Queen Victoria. Soon, many artefacts ended up in elsewhere in Europe and the United States.

"We were once a mighty empire," said Charles Omorodion, 62, an accountant who grew up in Benin City but now lives in Britain and has campaigned to have the artefacts returned from British museums. "There were stories told about who we were, and these objects showed our strength, our identity," he said.

He said that seeing the Benin Bronzes in the world's museums filled him with pride, as they showed visitors how great the Benin Kingdom had been. But he also added that he felt frustration, bitterness and anger about their being kept outside his country. "It's not just that they were stolen," he said.

"It's that you can see them being displayed and sold at a price." Benin City has been calling for the return of its artefacts for decades. But a key moment came in the 1970s when the organisers of a major festival of Black art and culture in Lagos, Nigeria, asked the British Museum for one prized item: a 16th century ivory mask of a famous oba's mother.

Slum art school where lives are transformed

NAIROBI

SOON after Adam Masava came back from his first successful art exhibition in the Czech Republic, he began teaching art to school children from his old neighborhood Mukuru Kwa Njenga as his way of 'paying back' his 'hood for all it had taught him - both good and bad things—as he grew up.

"I also saw school-age kids 'getting lost' because they didn't have useful things to do in their spare time. I wanted to engage them in art as a way of teaching them they could use their imaginations to solve their problems," Masava says. One of those children, Ann Mumbi, 18, was just age six when she

just came back to studying art with him a few months ago.

As word got around that he was teaching art for free, the age of his students rose. "I eventually had to move out of the school and invite students to come work in my studio," says the artist cum art teacher who currently has over 40 students, aged from 17 to 39.

On the day BDLife went to visit his studio, now known as Mukuru Art Collective, over a dozen students were at the double-decker studio. "Now that schools have reopened, many have gone back to their schools," he

But Masava's same open-door policy re-

doesn't set limits on membership in the collective since he believes that art can serve as a means of uplifting people's lives, giving them a sense of purpose and a means of self-expression.

Now he coaches everyone from an exconvict, female boxer, and former signwriter to a former math teacher, eggshell artist, and award-winning teenager. Alex Mungare, 17, just won the Toyota 'Dream Car' Competition and earned himself Sh50,000 and Sh500,000 for Mukuru Art Collective.

"I'm also the youngest artist here at the studio," he announces proudly. Having

first met him teaching art at her school. She mains, irrespective of the numbers. He joined Masava's art club when he was 10, Alex had already visited Patrick Mukabi's Dust Depo when he met Adam whose studio is just down the road from his family home.

> "Alex shifted to my studio and has been painting there ever since," says Masava who since 2008 has also been exhibiting his art everywhere from Austria, Germany, and the Netherlands to Taiwan, Slovakia, and the US.

> Alex isn't the only award-winning artist who paints at the Collective. Stephen Ndovu, 30, just won second prize in the student category at the annual Manjano Art competition. Two years before, Isaiah Malunga won the Kenya Arts Diary artist's residency at Kitengela Glass Trust.

Besides Ann Mumbi, an increasing number of girls are joining the Collective. Amina Martha, 25, is an amateur boxer who initially went to the gym to lose weight. She was still at Masinda University, studying journalism at the time.

"One of the ways we learned to lose weight at the gym was boxing. Once I started it, I found I enjoyed it," says this petite bantamweight amateur who hopes to one day represent Kenya in international tournaments. "After I had only trained two weeks, I entered a competition and lost; but I also won one round," she says, now determined to keep training and even coaching other young women on boxing and self-defense.

J&J vaccine protects against Delta variant, study shows

JOHANNESBURG

EVIDENCE from the Sisonke Johnson & Johnson (J&J) study shows that the one-iab vaccine is effective against the Delta variant of the virus that causes Covid-19, which is spreading fast.

Speaking during a briefing on Friday morning, co-principal lead of the study Professor Glenda Gray said they found that the vaccine was effective against severe disease and death caused by Covid-19. "Linda-Gail [Bekker] and I and the team provide the first-world evidence that the J&J vaccine is effective against the Delta variant of concern. We know that in South Africa it protects against severe illness and death." The Sisonke study targeted healthcare workers between February and May.

When the study was first implemented, the Beta variant was the most dominant one circulating in the country. She said their evidence showed that the vaccine offered more protection against the two variants.

Gray added: "We can report that the single-jab J&J vaccine protected between 91% and 92% of healthcare workers against death. Consistently, after receiving the vaccine. there is little death occurring." She said there was no evidence yet that people who were vaccinated with J&J would needed a booster shot.

Gray said in cases where healthcare workers were infected after vaccination, the disease was mild. She added that they investigated all deaths that occurred 28 days after a person received the vaccine.

"Every person in Sisonke who died within 28 days [of getting the vaccine], we did a full post mortem to evaluate if there was any association. We did not see any safety signal around the vaccine causing deaths. We saw two clotting dis**BUSINESS NEWS**

Liquor shops up 274pc on Covid-19 measures

NAIROBI

A new phenomenon in Nairobi's estates is worrying residents. It seems every day regular businesses like salons, stalls selling new and second-hand clothes, grocery stores and fruit shops are being replaced by liquor stores.

The number of wines and spirits shops licensed in Nairobi in 2020 has increased 274 percent compared to previous years, says Nairobi County liquor board CEO Hesbon Agwena. In 2020, a total of 1,648 liquor stores were registered in Nairobi alone compared with 440 in 2019 and 430 in 2018.

It all started when Covid-19 first hit the country last year and Kenyans were confined to their homes to help reduce the rate of infection. Enterprising Kenyans snapped up the opportunity that came with millions staying mainly indoors with practically little or nothing to do.

To kill time, many turned to drinking more alcohol. But there was a hitch: bars and clubs were forced to close earlier than usual, leaving thirsty Kenyans to seek alternatives. Pavements in estates were turned into barazas by young men and women where they would meet up in the afternoon to drink alcohol until after curfew hours.

Open grounds were also filled with cars as 'park and chill' became the new flavour of the month. In constituencies, Starehe had the highest number of registered liquor stores (88), followed by Roysambu (48), Lang'ata and Dagoretti North (35 each).

Westlands added 29, Ruaraka six, Mathare 11, Makadara 18, Kibra 14, Kasarani 32, Kamukunji 13, Embakasi West 32, Embakasi South eight, Embakasi North five, Embakasi East 21, Embakasi Central 15 and Dagoretti South 30. Most revellers have also switched from beer to spirits because of their apparent affordability in liquor stores.

"The curfew imposed by the government might have helped stop the rapid spread of Covid-19 but it has left us with a much bigger problem, alcoholism," says Susan Mwende, a resident of Tumaini estate in Embakasi South. Day drinking, she said, has become acceptable because of the night curfew.

Pregnant, breastfeeding mothers encouraged to get Covid vaccine

KIGALI

Rwanda Biomedical Centre (RBC) has encouraged pregnant women and breastfeeding mothers to go for Covid vaccination. "We encourage pregnant women and their health care providers to not miss out on vaccines," Dr. Sabin Nsabimana, the DirectorGeneral of RBC said in a pod-

The message is the latest attempt to protect both the mother's and baby's lives in the wake of the escalating Delta variant of coronavirus. According to Centres for Disease Control and Prevention (CDC), symptomatic pregnant women are more likely to suffer severe illness, hospitalization and deaths when not vaccinated.

In a study done on Maternal and Neonatal Morbidity and Mortality among pregnant women, those with Covid19 diagnosis had a lower rate of spontaneous initiation of labour but higher cesarean delivery rate, reflecting the higher rates of pregnancy complications.

However, CDC said that research shows that people who have received Covid-19 vaccines during pregnancy, mostly during their third trimester, have passed antibodies to their fetuses, which could help protect them after birth.

"Pregnant women have not reported side effects...after vaccination with mRNA vaccines," Dr. Nsabimana said, clarifying that the Covid-19 vaccines are not manufactured from the actual virus in a way that it can cause any disease. "The vaccine does not fuse with blood vessels that a mother shares with a

fetus," he said.

For lactating women, he continued; "Research has proven that the vaccine has no particular side effects on breastfeeding mothers and their infants." According to CDC, breastfeeding people who have received the Covid -19 vaccines have antibodies in their breast milk, which could help protect their ba-

However, it adds, more data are needed to determine what protection these antibodies may provide to the baby. It is advised that mothers continue to wear masks and practice maximum hygiene when in contact with the baby.

UAE helps US in charging Nigerian influencer Hushpuppi

THE UAE played a key role in bringing Nigerian Instagram celebrity Raymond "Hushpuppi" Abbas before a US court to face charges of money laun-

Abbas, 37, was arrested in Dubai last year in a raid at a five-star hotel. He pleaded guilty to money laundering in a US court last month and could face 20 years in prison. Abbas, with five others, faces charges over an elaborate scheme to defraud a Qatari school founder and launder the proceeds through bank accounts around the

"The defendants allegedly faked the financing of a Qatari school by playing the roles of bank officials and creating a bogus website in a scheme that also bribed a foreign official to keep the elaborate pretence going after the victim was tipped off," said acting US attorney Tracy Wilkison.

"Abbas, who played a significant role in the scheme, funded his luxurious lifestyle by laundering illicit proceeds generated by con artists who use increasingly sophisticated means. In conjunction with our law enforcement partners, we will identify and

prosecute perpetrators of business email compromise scams, which is a massive and growing international crime problem.'

Hamid Al Zaabi, director general of the UAE's Executive Office of Anti-Money Laundering and Counter Terrorism Financing, said the case was a testament to UAE's commitment to international co-operation on these cases, state news agency Wam reported.

"This case will act as a landmark for the effectiveness of multinational collaboration," Mr Al Zaabi said. "While led by the Federal Bureau of Investigation, the UAE law enforcement community played a strategic role in the apprehension of the defendants."

The office was established in February to combat money launderers, organisations and people suspected of financing terrorists and organised crime. Abbas, meanwhile, has more than two million followers on Instagram. He is known for his displays of wealth on social media.

The court heard of his extravagant lifestyle - he lived in the residence of the Palazzo Versace on Dubai Creek and owned a fleet of luxury cars. The Nigerian posed as a real estate investor and businessman.

Kindness of strangers: Stellenbosch student has university debt paid off

STELLENBOSCH University psychology student Shayen Gomis is "over the moon" after her student debt was cleared by people she has never met.

At a time when thousands of students across South Africa struggle with enormous pressure and debt, Gomis was donated the costs of her fourth-year studies through Feenix and the V&A Waterfront.

Gomis, who grew up in Rondeberg, near Philadelphia, has always had big dreams for her future. "It was literally a weight off my shoulders, as my debt gave me sleepless nights, wondering how I was going to pay off these fees so that I can graduate," the 23-year-old told News24.

When a lack of funds placed her degree and hopes of giving back to the community in jeopardy, Gomis wasted no time in creating a profile on Feenix, the online student crowdfunding platform where students can fundraise for their outstanding university fees.

She originally went onto Feenix to look for an internship to clear her debt, but saw the success others had in raising money to pay off outstanding fees. She said she received the call in June with the good news that a "Good Samaritan" had cleared her student debt of R15 114.32.

"It still feels 'surreal' that someone saw my plight on the student crowd funder Feenix and decided to clear my debt." Gomis said that she wrote a letter to her sponsors thanking them for their immense generosity. She is now aiming to graduate and serve her community as a psychologist.

She said: "I love listening to people, providing them with strategies and tools to improve their lives. I love empowering people through knowledge and helping them grow and evolve, and once I have graduated, I hope to plough back into the community around me to inspire and empower individuals.'

She continued: "I want to be a resource and asset for those who need psychological assistance." It has not been an easy time trying to study on-

line during the Covid-19 pandemic. "There were plenty of days I felt that I can't do this anymore, it's too much for me. But with the strong support from my family, I managed to pull myself together," Gomis said. But she was always carrying the niggling worry that she would not be able to graduate unless she had paid off her debt.

Cara-Jean Petersen, Feenix Student Engagement Manager, said Gomis's profile stood out and resonated with the V&A Waterfront's CSI programme. "The beauty of the Feenix platform is that it allows potential funders to connect with students' personal stories, who they are and the communities they are from. It allows them to put a face and a name to the futures they invest in," she said.

The benefits of steaming: for face, body, hair and mental health

DUBAI

WHILE modern-day steaming is largely focused on the beauty and pampering aspect of cleansing the face and body, the treatment goes back thousands of years and used to be rooted in ritual. References to steaming can be found in Native American culture, as well as in the ancient Mayan society and, like so many therapies, it was the ancient Greeks and Romans who expanded upon the concept.

The two civilisations used to build huge, elaborate steam baths where people would gather to detoxify the body, at a time when cleanliness was seen as a way to honour the gods. Botanicals, oils, clay and minerals were also introduced for medicinal and aromatherapy purposes

The concept of steam baths still exists, and the modern spa has become the place to get your steaming fix. It is a treatment that has many benefits and plenty of variations to treat all manner of ailments and conditions. As well as the hot steam, there is also cold steam, which is used to treat inflammation, lock in moisture and keep the skin hydrated.

What does steaming actually do?

So how does steaming work? "As the soothing warm steam starts to work on the skin, it causes it to sweat, allowing the natural oils within the skin to flow," explains Naomi Bell, beauty therapist and chief executive of Dubai salon NRBeauty. "This helps to soften the surface layer of dead skin, and supports the release of dirt, oil and bacteria from the pores."

Loosening the skin, in particular opening up the pores, has myriad benefits, especially when it comes to removing stubborn blackheads and acne-causing bacteria. Edwige Gandin, beautician at Pastels Salon Jumeirah, says: "The combination of warm steam and an increase in perspiration dilates your blood vessels and increases circulation." This resultant increase in oxygen intake makes the skin look and feel healthier.

Steaming for absorption and hydration

As well as helping to release bacteria and impurities,



'Steaming supports the release of dirt, oil and bacteria from the pores," says Naomi Bell, beauty therapist and CEO of NRBeauty.

steaming can also help with absorption. "It helps your skin better absorb skincare products," says Dr Eman Kotb, specialist dermatologist at Medcare Medical Centre in Sharjah. "Steam increases the skin's permeability, enabling it to better absorb topical creams.

"The increased blood flow experienced during a steam facial promotes collagen and elastin production. This results in firmer, younger-looking skin." And it's not only the absorption of face and body creams that steaming encourages; it also works on aiding natural moisture, hydrating the skin by increasing oil production.

Inversely, Bell warns of the dangers of over-steaming or using water that is too hot for the process, as this can dehydrate the skin. "Always steam with caution," she advises. "A steam burn is more damaging than a burn from boiling water. Try to limit each steam session to under eight minutes once a week. Over-steaming can cause dehydration and dryness."

Best for... and bad for

Dr Shadan Naji, dermatologist at Dr Kayle Aesthetic Clinic, says acne-prone skin can "really benefit from hot steaming." Experts agree that people with oily skin and outbreaks have much to gain from regular steaming sessions. "Steaming will help to kill bacteria on the surface and increase the skin's natural detox process," says Bell. "In time this will help eliminate the buildup of bacteria and blocked sebum, gradually clearing and restoring healthier, balanced skin.'

However, she advises that anyone with "active acne" should avoid the treatment until their skin has calmed, to avoid further inflammation.

Those with eczema and rosacea should avoid steam treatments, as should anyone with sensitive skin or thread veins, and those suffering from inflammatory diseases, such as psoriasis.

"Hot temperatures at the surface of the skin cause dilation of the blood vessels, while greater circulation in the face can increase inflammation and redness," explains Gandin. Eda Gungor, co-founder of Seva Experience, says: "It can aggravate sensitive skin. The heat and steam may trigger 'facial flushing."

Steaming hair for growth, healing and circulation

Steaming has benefits beyond use on the face and body, with treatments also available for hair. "It releases trapped sebum," says Gungor. "This naturally occurring oil is produced by the skin's sebaceous glands to lubricate skin and hair. When sebum gets trapped beneath the skin's surface, it creates a breeding ground for bacteria."

The benefits for the hair and scalp are numerous, particularly when it comes to hair types that don't easily absorb moisture. Kotb says: "Steaming helps with deeper conditioning; the steam lifts the hair cuticle allowing your treatments to penetrate deeply into the hair shaft helping to heal damaged hair. It allows you to get a deeper clean and is good for low porosity

"This hair type struggles to absorb moisture because the cuticle doesn't open easily. The steam opens the cuticle and helps the hair with absorption. It also encourages blood flow and circulation, which promotes hair growth too."

France, Germany, UK plan to proceed with Covid-19 booster shots despite WHO's plea **GENEVA**

SEVERAL countries are going ahead with plans to administer Covid-19 vaccine booster shots to their populations, despite the World Health Organization (WHO) calling for countries to abstain from administering the additional shot until at least the end of September.

"I understand the concern of all governments to protect their people from the Delta variant. But we cannot accept countries that have already used most of the global supply of vaccines using even more of it, while the world's most vulnerable people remain unprotected," WHO chief Tedros Adhanom Ghebreyesustedros said at a media briefing on August 4.

More than four billion vaccine doses have been administered globally, with more than 80% going to middle- or highincome countries, according to the WHO. France, Germany, and the UK are among countries that plan to offer Covid-19 booster shots next month to the elderly and vulnerable. In the UK alone, 32 million booster shots are expected to be administered, reported the Telegraph.

"We want to provide the vulnerable groups in Germany with a precautionary third vaccination and at the same time support the vaccination of as many people in the world as possible," the German Health Ministry told Reuters.

Israel has administered more than 11 million vaccine doses and over 60% of its nine million population is vaccinated, according to Our World in Data. It started rolling out its booster vaccine program this month to the elderly, citing data that the vaccine's efficacy may fall over time.

Speaking after the WHO briefing, Israeli Prime minister Naftali Bennett said in a Facebook Live event that Israel has a small population that "doesn't significantly affect the global surplus," adding that what the country is doing "dramatically contributes to global knowledge," reported AFP. Bennett also called for the elderly to receive the "great gift" of a booster shot, while encouraging young people to get vaccinated.

The US - which has not announced plans for booster shots yet - also refuted the WHO's plea on Wednesday. At a press briefing, White House Press Secretary Jen Psaki called it "a false choice," saying the US can donate more vaccines while also providing booster shots.

The US has donated over 110 million vaccines to the world more than any country - and intends to donate more, she said, calling for other G7 members and the global community to step up. "If the FDA decides that boosters are recommended for a portion of the population, [the US will] provide those as well. We believe we can do both, and we don't need to make that choice," Psaki said.

S. Africa's Zuma admitted to hospital from prison

LONDON

SOUTH Africa's jailed former president, Jacob Zuma, was admitted to hospital for medical observation yesterday, the government's Correctional Services department said.

Zuma has been held at Estcourt prison in Kwa-Zulu Natal province since handing himself over on July 7 to serve a 15-month sentence for contempt of court. His jailing led to South Africa's worst outbreak of violence in years.

Zuma's foundation, while confirming that he was in hospital, said it was for his annual routine medical check-up.

"No need to be alarmed, ... yet," the foundation said in a tweet.

Correctional Services said in a state-

to take Zuma to an outside hospital for further examination.

"Everyone who is detained, including every sentenced prisoner, has the right to conditions of detention that are consistent with human dignity, including ... medical treatment," the statement said.

It added that, because he was a former president, Zuma's healthcare needs required the involvement of South African Military Health Services.

Zuma, 79, was jailed for defying a Constitutional Court order to give evidence at an inquiry investigating high-level corruption during his nine years in office until 2018.

When Zuma handed himself in, protests by his supporters escalated into riots involving looting and arson that ment earlier that a routine observation President Cyril Ramaphosa described at the prison had prompted authorities as an "insurrection".

Zuma, who was briefly permitted to leave jail on July 22 to attend the funeral of his younger brother, is due to appear in public again on Tuesday for his arms deal corruption trial.

In this case, he is accused of receiving kickbacks over a \$2 billion arms deal as a test of South Africa's ability from the 1990s. He pleaded not guilty to hold powerful politicians to acin May to charges including corruption, count.

fraud and money laundering.

He has evaded prosecution for more than a decade, and portrayed himself as the victim of a politically motivated witch-hunt.

China to provide 2 billion COVID-19 vaccines globally this year - Xi

BEIJING

CHINA will strive to provide 2 billion COVID-19 vaccine doses to the world throughout this year and offer 100 million U.S. dollars to COVAX, Chinese President Xi Jinping said on Thursday in a written message to the first meeting of the international forum on COVID-19 vaccine cooperation.



The 100 million U.S. dollars to COVAX will mainly go to the distribution of vaccines to developing countries, he said, adding that China would do its best to help developing countries cope with the COVID-19 pandemic.

China is committed to building a global community of health for all and has provided vaccines to the world, especially developing countries. The country actively carried out joint production, which illustrates the concept of vaccines as global public goods, Xi (pictured) stressed.

"I hope this forum will promote the accessibility and fair distribution of vaccines around the world, strengthen solidarity and cooperation in developing countries, and make new contributions for an early victory against the pandemic," he said.

At the Global Health Summit this May, Xi announced five measures to support global solidarity against COVID-19. These include the proposal of setting up an international forum on vaccine cooperation for vaccine-developing and producing countries, companies, and other stakeholders to explore ways of promoting fair and equitable distribution of vaccines worldwide.

"We are willing to work with the international community to promote international vaccine cooperation and build a community with a shared future for humanity," he said.

J&J vaccine effective against Delta in South Africa trial

PARIS / BERLIN / NEW YORK

JOHNSON & Johnson's CO-VID-19 vaccine is working well in South Africa, offering protection against severe disease and death, the co-head of a trial in the country said yes-

The J&J vaccine was administered to healthcare workers from mid-February in a research study, which was completed in May, with 477,234 health workers vaccinated, joint lead investigator Glenda Gray told a media briefing.

South Africa's health regulator approved the J&J shot in April, and it is being used in the national vaccine programme alongside Pfizer's.

Gray said the single-shot J&J vaccine offered 91 percent the lowest COVID-19 vaccito 96.2 percent protection nation rates - Florida, Texas, against death, while offering Missouri, Arkansas, Louisiana, 67 percent efficacy against infection when the Beta coronavirus variant dominates and about 71 percent when the Delta variant dominates.

"Consistently after receiving the vaccine, there was very little death occurring in the vaccinated group as compared to the control group and showing a remarkable up-to 96.2 percent protection against

death," Gray said.

"This was our primary endpoint and we are able to say this vaccine protected health workers against death," she added.

Daily new COVID-19 cases have climbed to a six-month high in the United States, with more than 100,000 infections reported nationwide as the Delta variant ravaged Florida and other states with lower vaccination rates.

The seven-day average of new reported cases reached nearly 95,000, a five-fold increase in less than a month, Reuters data through Wednesday showed.

Seven US states with among Alabama and Mississippi - account for half of the country's new cases and hospitalizations in the last week, White House COVID-19 coordinator Jeff Zients told reporters on Thursday.

"We're seeing terrifying #COVID19 trends in our hospitals," County Judge Lina Hidalgo wrote on Twitter. She is the top official of Harris

Some 70.6 million of the total 103 million COVID-19 vaccine doses have been administered, the Africa CDC said.

Five countries, namely Morocco, South Africa, Egypt, Nigeria and Tunisia have acquired and administered the most doses of COVID-19 vaccines to their respective populations, according to the

The North African country of Morocco has so far administered 24.7 million doses of CO-VID-19 vaccines, accounting for 28.3 percent of the country's total population.

As of Thursday afternoon, the number of confirmed COVID-19 cases in Africa had reached 6,866,597, with 174,054 deaths and 6,016,902 recoveries, according to the

Defence minister points to foreign centres spreading propaganda against Russia

KRASNOYARSK

PROPAGANDA facilities that engage in training Russians to carry out seditious activities in the country operate in Latvia, Estonia and



Poland, Russian Defense Minister Sergey Shoigu said at a meeting with workers at the Krasnoyarsk Machine-Building Plant yesterday.

"Information has become a weapon. A propaganda strategy center has been set up in Riga, similar centers have been established in Tallinn and Warsaw. Information weapons are created there that are particularly used against our country," Shoigu pointed out, adding that those centers also spread a lot of rumors.

"You will hardly be able to name a facility in Russia where experts receive training in conducting cyberattacks. We don't train such experts. However, there are several centers in Europe that do provide this kind of training to our country's citizens," Shoigu added.

The Russian defense minister explained that Western centers like those monitored the online information space, detecting those "who won't write anything positive" and offering them grant-based jobs. "Dozens of such people are churned out every three months," Shoigu noted.

According to him, the Russian Defense Ministry paid special attention to the information agenda. In particular,

Sudan reiterates demand to replace **Ethiopian forces within UNISFA**

SUDAN on Thursday reiterated its demand to replace the Ethiopian forces within the United Nations Interim Security Force for Abyei (UNISFA).

During a meeting held at the Presidential Palace in the capital Khartoum, Sudan's Security and Defense Council discussed the JNISFA's situation and its future.

The council reaffirmed Sudan's firm position regarding the necessity of continuing the mission with multinational forces, without Ethiopia being part of it, said Sudan's Defense Minister Yassin Ibrahim Yassin in a statement.

The council expressed concern over "the security violations of military nature and the growing phenomenon of exploitation and use of military uniforms in conducting crimes that threaten social security and peace," the minister said.

He added that the council stressed the need to form a joint force under a unified command, with an appropriate mandate to deal with the violations.

Sudan believes that Ethiopia has failed to help establish peace at the disputed area of Abyei between Sudan and South Sudan.

The UNISFA was established in 2011 by the UN Security Council to monitor the Abyei border. It is mainly composed of Ethiopian forces of around 4,200 troops and 50 police personnel. Later, the size of the forces was increased 5,326, all of whom are from Ethio-

Taliban close in on two provincial Afghan capitals as US forces exit country

KABUL

TALIBAN fighters yesterday intensified clashes with Afghan forces and targeted militias allied with the government, officials said, stretching their dominance of border towns and closing in on two provincial capitals as foreign

At least 10 Afghan soldiers and a commander of armed members belonging to the Abdul Rashid Dostum militia group in the northern province of Jowzjan were killed.

Taliban launched violent attacks on the outskirts of (provincial capital) Sheberghan this week and during heavy clashes a progovernment militia forces' commander loyal to Dustom was killed," said Abdul Qader Malia, the deputy governor of Jowzjan province.

The Taliban, fighting to reimpose strict Islamic law after their 2001 ouster by U.S.-led forces, have stepped up their campaign to defeat the U.S.-

backed government as foreign forces complete their withdrawal after 20 years of war.

Another provincial council member said nine of the 10 districts of Jowzjan were now controlled by the Taliban and the contest to control Sheberghan was under way.

In southern Helmand province, damage to civilian property aggravated the humanitarian crisis as shops caught fire in a week-long battle to control the capital of Lashkar

The United Nations this week said it was deeply concerned about the safety of tens of thousands of people trapped in the city.

"Violence has only escalated and there is no way to assess the damage in Lashkar Gah as both sides are locked in an intense ground battle... it is hard to even recover bodies by aid agencies," a senior Western security official said in Kabul.

The Lashkar Gah office of aid group Action Against Hunger was hit by a bomb during fighting in the area on Thurs-

"Civilians find themselves in between warring parties. They are being displaced from their homes and are often the first victims of the conflict," said Mike Bonke, Action Against Hunger's Country Director in Afghanistan

"Humanitarian organisations like Action Against Hunger try their best to support people's needs, but we need safety guarantees from all parties to be able to operate," he

China continuously improves mechanisms for protection of rights, interests of persons with disabilities

PERSONS with disabilities are equal members of humanity, and the cause of persons with disabilities is a systematic social undertak-

The Law of the People's Republic of China on the Protection of Persons with Disabilities, enacted on May 15, 1991, is the first specialized law in China that comprehensively protects the rights and interests of persons with disabilities.

Over the past three decades since the enacting of the law, China has continuously improved the mechanisms for the protection of rights and interests of persons with

So far, the protection of rights and interests of persons with disabilities has been written in 80 of all laws approved by the National People's Congress and its Standing Committee, and 70 of all administrative laws and regulations approved by the State Council.

Nearly 30 terms in the Civil Code are directly related to the protection of the rights and interests of persons with disabilities. During the past five years, legal assistance for persons with disabilities has

been constantly enhanced. A total of 2,600 organizations of

legal assistance coordination and 2,318 legal aid centers were established across the country for this group during the period.

By constantly improving people's livelihood, China is bringing more assistance to the development of the cause of persons with disabilities and guaranteeing their rights and interests.

Zhang Shundong and Li Guoxiu are a couple that have only one hand and one pair of feet and used to live in poverty. Thanks to the minimum living allowance, employment subsidies, and the government's supporting policies for persons with disabilities, they finally found a path leading to prosperity.

Apart from shaking off poverty themselves, they are also helping farmers sell farm produce on e-commerce platforms. Last year, they were awarded an honorary title for their contributions to the poverty alleviation cause.

During the past five years, China has removed over seven million persons with disabilities from the poverty list. It is doing as much as possible to advance the cause of persons with disabilities, and overcoming its deficiencies in a targeted manner, so as to help the group better fit into the society and share the outcomes of economic and social development.

UN envoys appalled by increase in sexual violence in Somalia

UNITED NATIONS

THE UN secretary-general's special representative for children and armed conflict, Virginia Gamba, and the special representative on sexual violence in conflict, Pramila Patten, said on Thursday that they were appalled by the alarming increase in the scale and severity of sexual violence in Somalia.

In 2020, 400 civilians, primarily girls, were victims of rape and other forms of sexual violence perpetrated by all parties to the conflict in Somalia.

This represents a staggering increase of almost 80 percent compared with 2019, said the two UN envoys in a joint press release. In the first quarter of 2021, over 100 cases of sexual violence against girls were verified by the United Nations.

Often, perpetrators exploited the vulnerability of displaced girls, targeting them when they left camps to perform domestic chores, they said.

Sexual violence was closely linked with the prevailing insecurity in Somalia, marked by political tensions in the run-up to national elections, intercommunal clashes related to land-based disputes, and a surge in Al-Shabaab's activities, which intensified during the climate of uncertainty caused by the COVID-19 pandemic, they said.

"The heightened levels of conflict-related sexual violence in Somalia demand urgent attention and action. We urge all parties to the conflict in Somalia to immediately cease these violations and comply with their obligations and responsibilities under international humanitarian and human rights law, as well as their commitments with the United Nations pursuant to relevant Security Council resolutions," said the two special representatives.

Gamba and Patten were alarmed by the significant increase in the number of cases of sexual violence attributed to Al-Shabaab, which continues to use sexual violence and forced marriage as tactics of domination in areas under their de facto control, forcing many families to flee

The two officials also noted with concern the high number of violations perpetrated by clan militia, which has almost tripled over the past year, and are linked to a proliferation of small arms and light weapons.

In the vast majority of cases, the perpetrators remain unidentified, which perpetuates the vicious cycle of impunity and impedes access to redress and reparations for

Moscow reaches record level of medical equipment exports

MOSCOW

EXPORTS of medical equipment from Moscow climbed 2.1-fold in January-May 2021, reaching the record level compared with the same periods in previous years, according to a statement released on the website of Moscow Mayor yesterday.

"Moscow demonstrated record results in terms of medical equipment exports in first five months of this year compared with the same periods in previous years.

Particularly, exports of goods in this category [in money terms] amounted to \$22.34 mln, up 2.1-fold compared with the same period last year (\$10.33 mln) and by 90.6% compared with January-May 2019 when exports of medical equipment amounted to \$11.72 mln," Moscow Deputy Mayor Vladimir Yefimov was quoted as

"Moscow producers exported medical equipment to 81 countries around the world from January to May this year, with Kazakhstan being the leader in terms of purchases as supplies were worth \$6.85 mln, up by 100.3% compared with 2019," head of Moscow's investment and industrial policy department Alexander Prokhorov was quoted as saying.

Large volumes of medical equipment were exported to Uzbekistan (worth \$2.43 mln), the Netherlands (\$2.24 mln), India (\$2.18 mln), and Belarus (\$1.1 mln), Mexico, Bangladesh, Ecuador, Nepal, Qatar and Norway have become Moscow's importers this year as well. All in all, medical equipment exports from Moscow to those markets exceeded \$187.000.

Philippine ruling party leaders endorse Duterte for VP in 2022

MANILA

LEADERS of Philippine President Rodrigo Duterte's political party have endorsed him to be a vice-presidential candidate in next year's elections, paving the way for him to stay in



power for six more years after he steps down in 2022. The move needs to be approved by the party general assembly, which meets next month.

In the Philippines, the president is limited to one six-year term. Duterte's term ends in June next year, but he has said he is seriously thinking about running for vice-president, which political observers and critics say could be a backdoor to the presidency.

Next year's polls will be a referendum on Duterte's policies, including his bloody war on drugs, in which thousands of people have been killed, and the handling of the pandemic, many political analysts say.

The backing for Duterte was announced by Melvin Matibag, secretary-general of the ruling PDP-Laban party, who said the endorsement by the key officers will be presented to a national assembly of the party next month for approval.

For its presidential candidate, the party leadership endorsed Duterte's top aide and incumbent senator Christopher "Bong" Go, Matibag said, describing Go and Duterte as a "formidable" team.

"We are hoping the entire membership can carry it. That is the popular and logical choice of PDP-Laban leaders," Matibag told a media briefing.

Anti-COVID policies remain contentious in US as cases surge in 'steep fashion'

WASHINGTON

MASKING, vaccination and lockdown policies remain contentious in the United States amid a rapid surge of COVID-19 cases driven by the Delta variant.

More than 18 months since COVID-19 hit its shores, the United States continues to debate the efficacy of mask-wearing as daily infections remain in the tens of thousands, in one of the world's worst containment efforts of the deadly disease.

STANDING IN YOUR WAY VS. GET OUT OF THE

Florida Governor Ron DeSantis hit back at U.S. President Joe Biden on Wednesday, a day after the Democratic president criticized DeSantis and other Republican governors for banning mask mandates in public schools and other places.

"If you're trying to deny kids a proper in-person education, I'm going to stand in your way, and I'm going to stand up for the kids in Florida," DeSantis said at a news conference.

"If you're trying to restrict people, impose mandates, if you're trying to ruin their jobs and their livelihoods and their small business, if you are trying to lock people down, I am standing in your way, and I'm standing for the people of Florida.

Biden said at the White House on Tuesday afternoon that a coordinated effort is needed to stem the virus's spread. "We need leadership from everyone and if some governors aren't willing to do the right thing to beat this pandemic, then they should allow businesses and universities who want to do the right thing to be able to do it," he said.

"I say to these governors, please help. If you aren't going to help, at least get out of the way of people who are trying to do the right thing. Use your power to save lives," Biden added.

In a tweet responding to DeSantis's remarks Wednesday afternoon, White House Press Secretary Jen Psaki noted that 23 percent of new U.S. COVID-19 hospitalizations are in Florida and said the White House hopes DeSantis will join them in the fight against the pandemic.

DeSantis and Biden traded barbs as the United States is struggling with an increase of COVID-19 cases fueled by the more contagious Delta variant and millions of unvaccinated Americans.

COUNTRY COULD BE "IN TROUBLE"

The Delta variant accounted for an estimated 93.4 percent of all new COVID-19 cases in the United States during the last two weeks of July, according to figures published by the U.S. Centers for Disease Control and Prevention on Wednesday. This num-

ber is even higher in certain parts of the country, showed the figures for the week ending July 31. In the Midwest including Iowa, Kansas, Missouri and Nebraska, Delta accounts for more than 98 percent of all cases.

These figures have shown a rapid increase over the past two months. In the two weeks ending May 22, Delta's prevalence was estimated at around 3

The daily average of new cases across the country over the past week rose to 66,606 per day, from 40,597 the previous week, an increase of more than 64 percent, according to official figures.

Almost 72,000 children and teens caught COV-ID-19 last week -- a "substantial" increase from a week earlier, the American Academy of Pediatrics reported Tuesday.

U.S. COVID-19 cases driven by the Delta variant are rising in a "very steep fashion" and may double to 200,000 a day in the fall, said Anthony Fauci, head of the National Institute of Allergy and Infectious Diseases, on Wednesday.

"Remember, just a couple of months ago, we were having about 10,000 cases a day," said Fauci in an interview. "I think you're likely going to wind up somewhere between 100,000 and 200,000 cases.

The United States could be "in trouble" entering the fall unless a large portion of unvaccinated Americans decide to get the shots, said Fauci. "What we're seeing, because of this increase in transmissibility, and because we have about 93 million people in this country who are eligible to get vaccinated who don't get vaccinated -- that you have a significant pool of vulnerable people," he said.

The infectious disease expert said he is concerned the high number of unvaccinated people could lead to a stronger variant emerging that could reduce the efficacy of previously-administered vaccines.

"If we don't crush the outbreak to the point of getting the overwhelming proportion of the population vaccinated, then what will happen is the virus will continue to smolder through the fall into the winter, giving it ample chance to get a variant," Fauci said.

CONTENTIOUS POLICY DEBATES

Most unvaccinated American adults don't believe that COVID-19 vaccines are very effective and see the vaccines as a greater health risk than the virus itself, according to the Kaiser Family Foundation survey published Wednesday.

Fifty-three percent of unvaccinated adults believe the vaccine poses a bigger risk to their health than COVID-19 itself, while an overwhelming majority of 88 percent of vaccinated adults say that getting infected with COVID-19 is a bigger risk to their health than the vaccine.

Fifty-seven percent of unvaccinated adults also say that the news has "generally exaggerated" the seriousness of the pandemic, while three-fourths of vaccinated adults say the news has been "generally correct" or has "underestimated" its seriousness.

Among those who say they will "definitely not" get a vaccine, 75 percent say the news is exaggerated. "The sharply different views of the vaccinated and unvaccinated help to explain the contentiousness of ongoing policy debates about vaccine mandates,' said the foundation.

For example, vaccinated adults are far more likely than unvaccinated adults to say the federal government should recommend employers require vaccination among their workers at 68 percent versus 16

The public overall is split on the issue, with 51 percent saying employers should require vaccination compared to 45 percent who say they should not. Vaccinated adults are also more likely to say they wear masks in grocery stores and other indoor places, at work, and in crowded outdoor settings

"These differences are to a large degree driven by unvaccinated Republicans. Majorities of Republicans say they 'never' wear a mask outdoors in crowded outdoor places, at work, or in a grocery store. Democrats are more likely to report wearing a mask at least most of the time in all of these locations," said Kaiser.

The health-focused nonprofit group surveyed 1,500 U.S. adults between July 15 and 27 for this chapter of its survey, and found little change among those with the most hardened attitudes about vaccination. About 14 percent of those surveyed say they will "definitely not" get vaccinated -- the same proportion as in December.

Secrets to Tongling's prospering copper industry

COPPER foil is considered a " neural network" for signal reception of electronic products and power transmission. It is an indispensable new material for the development of new industries.

How thin can this material be? In a workshop of an enterprise in Tongling, east China's Anhui Province, copper foils are made as thin as cicada wings.

According to an employee of the enterprise, the copper foils, which are only 6 mm (0.23 inches) thick and used in lithium-ion batteries, can be applied in new energy vehicle, smart phone, aviation and aerospace and other industries. They can significantly improve batteries' energy density and thus extend battery life, the employee added.

Today, new discoveries, technologies, products and materials are emerging at a faster speed, and technological innovation and research are generating infinite possibilities. This means that those whoever can do a good job in industrial upgrading and rapidly grasp new technologies and materials will gain an advantage in industrial reform.

For cities, only by taking advantage of the motivating role of reform, accelerating the development of advanced manufacturing, and enhancing real economy, can they find effective paths leading to a new development paradigm.

Tongling, which has been hailed as the "capital of copper" in China since ancient times, enjoys rich resources, and its industries have also been going through constant upgrading.

To pursue high-quality development, new industries in the city, represented by the copper foil sector, have built new industrial clusters based on an upgrade of their industrial chain.

Rolls of copper foils being produced, as well as boxes of products to be shipped to downstream enterprises indicate the vitality of the copper foil sector and development potential of Tongling.

Accurate positioning leads to faster development. In Tongling's Yi'an Economic Development Zone, there is a metalware industrial park where enterprises from Jiaxing, east China's Zhejiang Province have settled and established industrial clusters that integrate the industrial and supply chains.

The trans-provincial cooperation project effectively allocates geographical, technological and land resources, forming a tiered industrial structure in the Yangtze River delta and thus promoting the flow of production factors and optimizing economic structure.

Industrial development is about both quantity and quality, and the two are primarily driven by innovation. Some of Tongling's products and technologies are very competitive, because the manufacturers have to some extent replaced imported high-end integrated circuit materials with domestically produced ones. A part of them are the first of their kinds in China, and some even broke the foreign technological monopoly.

To enhance future-oriented basic research and supply of technologies at the source, and carry out R&D for generic technology will help break technological bottlenecks. Practices have proved that as long as enterprises, universities and institutions work together, technological breakthroughs can be made, and market entities will also gain an edge in competition with technological innovation.

Moderna says its vaccine 93% effective 6 months after 2nd dose

NEW YORK

MODERNA Inc said on Thursday its COVID-19 shot was about 93 percent effective four to six months after the second dose, showing hardly any change from the 94 percent efficacy reported in its original clini-

That compares favorably to data released by rivals Pfizer Inc and BioNTech SE last week in which they suggested their vaccine's efficacy waned around 6 percent every two months, declining to around 84 percent six months after the second shot. Both the Moderna and Pfizer-BioNTech vaccines are based on messenger RNA (mRNA) technology. "We are very pleased that our COVID-19 vac-

cine efficacy is stable at 93 percent from four to six months," Moderna Chief Executive Stephane Bancel said in a statement. "This strong duration will benefit the hundreds of millions of people who have been dosed to date with Moderna vaccines."

Moderna's vaccine was authorized for emergency use in adults in the United States in December and has since been cleared for emergency or conditional use in adults in more than 50 countries.

The company started the process of filing for full approval with the US Food and Drug Administration in June and expects to finish its submission in August.

Global tally

Global COVID-19 cases surpassed 200 million on Wednesday, according to data compiled by Johns Hopkins University, as the more-infectious Delta variant threatens areas with low vaccination rates and strains healthcare systems.

The global tally stood at 200,014,602 while the global toll hit 4,252,873 as of 3:21 pm local time (1921 GMT), according to the data.

The global surge in cases is highlighting the widening gap in inoculation rates between wealthy and poor nations. Cases are rising in about one-third of the world's countries, many of which have not even given half their population a first dose.

The World Health Organization (WHO) on Wednesday called for a moratorium on COVID-19 vaccine boosters until at least 10 percent of the population in every country was vaccinated.

SINCE the Tanzania Football Federation (TFF) ordered Premier League clubs to have a secretariat, which would include employees, including the key role of information officer, there has been a misconception about the job.

Although most of the employees in the position have been journalists, their responsibilities were possibly not well defined.

So those who can make words appealing to people, funny, surprising, and even good words to crush opponents, seemed to be the ones who can competently take up the post, especially for such big clubs like Simba and Yanga.

There are also Mtibwa Sugar and Ruvu Shooting information officers, who have fallen into the trap, thus being an attraction for reporters whenever their clubs are about to play important or major matches or after the games are over.

And because those who offered them the jobs were the ones who believed that talking too much was the best practice, these information officers, who are supposed to be known as speakers, when the speaker is a person with great authority in the institution became the speakers in particular.

The mentioned people can sometimes comment on technical issues, including promising their sides' followers the outfits will come out victorious, something that even coaches are reluctant to prom-

The said people are sometimes talking about leadership issues when they do not attend management meetings.

They were the ones who portrayed the club's information officer as a talkative, fun-loving official, capable of using all sorts of words to bring down opponents, and it came at a time when even important football development issues were turned into unanswered jokes.

Some formed WhatsApp groups to increase the scope of followers, thus appearing to increase the effectiveness of their responsibilities by having larger groups and thus their message reached more people within a short time.

Haji Manara was one of those information officers. There were long-standing rumours that Simba's management

wanted to get rid of him, but it was reluctant due to uncertainty about the outcome of their matches. but Manara remained and appeared to be bigger than the real situation.

A recent audio clip, which had the outspoken official threatening Simba Chief Executive Officer Barbara Gonzalez, was seen as a clash of leaders with the preconceived notion that Manara is a leader and not a person in a position that Barbara oversees and has the power to suspend Manara.

Perhaps that is what shocked Simba officials that there is a need for them to take action as the saga clearly showed that the club is still embracing outdated practices, so much so that even an information officer can insult his employer and the side's management does nothing about it.

So the Simba's Directors Board received the instruction and decided to agree with the decision to part ways with an official who was already believed to be a part of Simba's success and is on the same level as other club

But the subject has not been well received by the members of the Simba's Directors Board.

The information officer role is still too small in either the secretariat or management of the club to the extent that a letter of resignation is written by him.

As Barbara is the club's Chief Executive Officer, the decision of Manara's fate was in her hands as the Board of Directors wants her to have power over her subordi-

The board usually employs the Chief Executive Officer to oversee the secretariat or management, including recruiting or taking disciplinary action under the club's

If the board takes on the responsibility of communicating with the information officer about the latter's duties, then the CEO has no important job and if the board is the one assigned to appoint someone else to fill the vacancy, what is Barbara doing at the team?

The role of the board in most large corporations is to organize and issue directives and not to perform day-today operations when there is a secretariat or manage-

The hiring of lower executives is the responsibility of the CEO-led management.

It is also important for Simba, as it states that it wants to be modern through its transformation to have rules governing the operation of the club's social media accounts.

Madrid mull legal action against LaLiga - sources

MADRID

REAL Madrid are considering taking legal action against LaLiga and CVC Capital Partners after the Spanish league agreed to sell 10% of its business to the investment fund for €2.7 billion, sources have told ESPN.

Barcelona are pouring over the finer details of the deal with CVC, which LaLiga announced on Wednesday, sources have told ESPN, because they have doubts about voting it through at the general assembly on Aug. 12.

The league's executive committee have already unanimously approved the sale, but it must be ratified at the general assembly next

League sources said that despite the concerns some clubs have about the deal, they believe it will be voted through because only two-thirds of the 42 voting clubs in the top two tiers of Spanish football must be in favour.

Spanish news outlet El Independiente first reported on Thursday that Madrid were weighing up taking action for asset misappropriation. The report said that Madrid feel the sale "endangers" their business opportunities by allowing CVC to take make money from, for example, television rights without the club agreeing to the

For their initial investment, CVC will pocket 11% of the money raised by LaLiga through the sale of television rights and sponsorship for the next 40 years.

El Independiente also added that Barca and a third club, Athletic Bilbao, were in opposition to

Madrid said in a statement on Thursday: "This agreement was reached without the involvement or knowledge of Real Madrid and today, for the first time, LaLiga has given us limited access to the terms of the agreement.

"The negotiation was carried out without competitive proceedings and the financial conditions agreed with CVC Capital Partners give them annual returns of over 20%. This opportunistic fund is the same which tried and failed to reach similar agreements with the Italian and German leagues.

"Real Madrid cannot support a venture which hands the future of

42 Primera and Segunda División clubs over to a group of investors, not to mention the futures of those clubs who qualify over the next 50 years.

"Real Madrid will convene the Assembly of Representative Members to debate the agreement and discuss the significant loss of equity, unprecedented in our 119-year

Sources at Madrid have told ESPN there's been no definitive decision yet but confirmed they are looking at what legal action is available to them.

They feel they have managed their finances well in the wake of the pandemic and that a quick cash fix now goes against their interests while benefitting other clubs. They also want a more exhaustive explanation to the clubs about the agreement and what it means long-term beyond the short-term injection of funds.

Barcelona said in a statement: "FC Barcelona considers that the operation that has been made public has not been sufficiently verified with the clubs [owners of the TV rights]; that its amount is not congruent with the years of duration and that part of the audiovisual rights of all the clubs are affected for the next 50 years.

"The Club considers the signing of a half-century contract inappropriate given the uncertainties that always surround the world of football.

"The conditions of the contract that LaLiga is talking about condemn the future of FC Barcelona in terms of audiovisual rights.

"FC Barcelona wants to show its surprise at an agreement promoted by Laliga in which it has not had the criteria of teams, like FC Barcelona itself, and does not even show options among more competitors to be able to evaluate the advantages and disadvantages in a scenario with many questions such as the post-pandemic."

The money raised from the sale will be distributed among the clubs in the form of a loan, repayable over a significant number of years. The payments will be based on the contributions the clubs have had since the centralisation of audiovisual rights in 2015, with Madrid allocated around €261 million and Barca €270m.

Messi to leave Barcelona: Breaking down the scenarios on how this saga will play out

NINETY-NINE words to wipe out 21 years walking hand in hand...not to mention 810 professional games, 683 goals, 10 Liga titles, seven Copas del Rey, four Champions League crowns and three FIFA Club World

Barcelona's terse statement on Thursday appears to leave no doubt, right down to the headline on the club website -- Leo Messi not staying at FC Barcelona -- that arguably the greatest single club career of any player ever has come to an end.

But, as with Messi's own "Burofax" incident less than 12 months ago, there's more here than meets the

Q: A few weeks ago everybody was reporting that Messi and the club had agreed to a new contract. Spanish media were hailing today as "Messi Day" -- the day when it would all become official. What happened?

A: All we know for certain right now is that, according to Barcelona, the club are unable to register the contract due to the Spanish league's rules on player registration, despite having reached an agreement for a new five-year deal with Messi. They don't go into specifics, but it's safe to assume that they're referring to LaLiga's version of the "salary cap" which limits spending on wages and player acquisition costs based on projected club revenue and costs. And since Barcelona are in dire financial straits -- with more than a billion dollars of debt, of which as much as \$800 million is described as short-term -- Messi's new contract won't get the green light. Which means he will

Q: But how did this happen? Surely they knew what the limits were heading into the summer and the Messi negotiations...

A: Yeah, that's one of the mysteries here. Especially since they spent \$9.6 million on Emerson from Real Betis and also made three free agent signings -- Memphis Depay from Lyon, and Sergio Aguero and Eric Garcia from Manchester City -- and the first two come with big salaries. The obvious question is this: If Messi was your priority (and he obviously was), why would you commit around \$50m in wages and the Emerson fee to sign those four other players if it was going to put you over the cap? That's why plenty are speculating there's something else afoot.

Q: Such as?

A: Some reports are suggesting that there was a last-minute hitch in the Messi deal, in terms of commissions to be paid and that he wasn't entirely happy with some of the club's transfer dealings this summer (even though they did sign his buddy and Argentina teammate, Aguero). And, because the club could never blame Messi, they're blaming La-Liga's rules instead. There may be some truth in that, but a much more plausible explanation may be the tense relationship with LaLiga and that it's a power play between Barca president Joan Laporta and Liga boss Javier Tebas.

Q: What's that about?

A: In one word: control. Barcelona are, along with Real Madrid and Juventus, one of only three clubs who have not dropped out of the Super League and, in fact, are taking legal action to push their case. Tebas, as you'd expect, is dead set against the Super League as he believes it would hurt the competitive balance of La-Liga. Perhaps more important than that is the deal Tebas struck with a private equity firm, CVC Capital Partners, which would see LaLiga receive a cash infusion of around \$3.2 billion in return for 10% of future revenues and a 10% stake in a newly formed commercial company. Barcelona, like Real Madrid (who, maybe not coincidentally, issued their own statement lamenting the deal on Thursday) are dead-set against the CVC agreement.

Q: Why don't they like the deal?

Don't they want the cash?

A: I'm sure they do, but they also say Tebas negotiated the agreement without their knowledge and that it hands the future of the clubs over to private investors. They're likely also unhappy with how LaLiga and CVC might redistribute funds going forward. The deal now needs to be approved by the clubs, and Real Madrid and Barcelona are likely to lead the "no" front.

Q: I get that, but how does Messi come into it?

A: Simply put, LaLiga, as a product, is less valuable without Messi. His departure, or even just the possibility of his departure, could turn public opinion against Tebas and his plans. Barcelona and Real Madrid generate the bulk of Liga revenue and a sizable chunk of that trickles down to other clubs. Messi leaving wouldn't just hurt Barcelona, it would hurt LaLiga. And not just in terms of image, but in commercial terms. That's another of the theories being bandied about. But there's a third, somewhat simpler scenario that may be the most plausible.

A: It's hard to believe that, having had months to talk to Messi and his family, Barcelona would not get their sums right and suddenly realize they couldn't afford him. The structure of the five-year deal they agreed suggests they were careful to stay within the cap. Plus, the transfer windows is still open until September. They could, conceivably, move on other players to keep him around. It wouldn't be easy, because the guys they'd like to transfer out of Barca are on high salaries and few clubs could afford them, but there are ways to do it. Not to mention the fact that if Messi was as committed to staying as they suggest, he could lower his wage demands or include more bonuses in his package or whatever. Instead, they're announcing that they're throwing in the towel now.

Q: And what does that suggest?

A: That it's a strategic move to spook Tebas. Either within the context of CVC or the Super League or, more

simply, in terms of cutting them some slack on the salary cap. This feels like giving up without a fight. And I can't see Barcelona -- or Messi -- doing that.

Q: OK, let's assume you're wrong. Let's assume it really is over. Where could he go to next?

A: The usual suspects will be mooted: Paris Saint-Germain, Manchester City, maybe Manchester United, maybe a move to Major League Soccer. But the fact of the matter is that Messi became a free agent on July 1 and, legally, from Jan. 1, he could have signed a pre-contract with anyone. And, while there may have been interest from City 12 months ago, in the Burofax days, it's not as if clubs were beating a path to his door in the past six months. Why? Because many believed he was committed to staying at Barcelona. Now, most clubs have made other plans. City are pursuing Harry Kane. PSG are trying to extend Kylian Mbappe's deal before he becomes a free agent next June (and they've committed huge amounts in salary on big name free agents like Georginio Wijnaldum, Gianluigi Donnarumma and Sergio Ramos). Signing Messi would be a huge undertaking, you don't just magic up close to half a billion dollars over the next five years out of nowhere.

Q: So what's going to happen?

A: I'm purely speculating here, we may know more when Laporta addresses the media on Friday and, by the way, we haven't heard from Messi himself yet. But fundamentally we have a situation where -- at least according to Barca's statement -- Messi wants to stay and the club want to keep him, but the league won't allow it, even though his departure would hurt everyone, league included. Does that sound right or logical to you? No, it doesn't. Because it isn't. My guess is come Sept. 1, he'll still be a Barcelona player. Either because he will have restructured the contract they agreed on, or because Barca will have recouped some transfer fees or because LaLiga will have revised their salary cap to accommodate the club. Or a combination of all three.

Grealish joins City in £100m British record fee

LONDON

MANCHESTER City have announced the signing of Jack Grealish from Aston Villa, breaking the British transfer record in a £100 million deal, the club announced on Thursday.

Grealish leaves his boyhood club Villa having made 213 appearances and scored 32 goals since making his senior debut in 2014. "I've been at Aston Villa for 19

years and I've been a fan my whole life," Grealish wrote in a statement. "I've come through the ranks and captained the club back to the top tier of English football.

"It's impossible to put my feelings into words, but I'll try. When I first came to Villa I had my own personal dreams and ambitions like getting into the first team, scoring my first goal and scoring the winner in a derby. It wasn't until we got relegated that I felt a greater sense of purpose.

"Every time I put on the Villa shirt, I played with my heart on my sleeve. Being given the armband was both a privilege and an honour for me and my family and I've loved every minute of it.

"I want to thank the manager and my teammates, I'll never forget everything we achieved together... and to the fans who supported me through everything, I can't thank you enough. To all my coaches and all the people who work at the club behind the scenes who have done so much for me over the years -thank you.

"I'll always be a Villa fan -- I love this club with all my heart and I hope you understand my reasons for seeking a new challenge. The club are in great hands, the manager, the lads, the news signings coming in -- it's an exciting time to be a Villa fan. I'll see you all again

soon. Until next time."

It will be the second time City have held the British transfer record, joining the arrival of Robinho from Real Madrid in 2008.

Speaking to City TV, Grealish added: "There's obviously a lot of reasons why I decided to come here, obviously the manager has been a massive factor in that. Playing under the best manager in the world was something I couldn't really turn down.

"Competing for major trophies is something that I wanted to do, and it was something that, in the end, I couldn't turn down.'

Manchester United have held the British transfer record seven times in the Premier League, and it has also been held twice by Chelsea.

Sources have told ESPN that Villa offered Grealish, their captain, a vastly improved deal to stay at Villa Park but that the 25-year-old has chosen to join City because of the lure of top trophies and regular Champions League football.

City first proposed a deal including £90m in transfer fees and winger Morgan Rogers -- who is valued at £10m -- but a straight cash offer of £100m has triggered a release clause in Grealish's contract.

After making Grealish their first signing of the summer, City remain keen to sign Tottenham Hotspur striker Harry Kane.

Kane wants to move to the Etihad, but Spurs are privately adamant he is not for sale. Sources have told ESPN that City believe they can finance deals for Grealish and Kane this summer through player sales.

City have raised £109m through sales since the start of the pandemic and could raise another £50m this summer, even without a firstteam player leaving.
