PRIME Minister Kassim Majaliwa has directed the Tanzania Civil Aviation Authority (TCAA) to heighten security in airports and ensure that they are not used as an alley to pass illegal goods including drugs.

Opening an aviation stakeholder meeting as part of commemorating 20 years of establishing the agency in 2003, the premier instructed the Higher Education Students' Loans Board (HESLB) to look for ways of creating a special package for aviation students' loan beneficiaries.

# Zanzibar registers 17 blue economy projects in 3 yrs

ZANZIBAR authorities' fishing sector projects have increased from one project to 17 with a total value of 337.5bn/- in the past three years.

Dr Suleiman Aboud Jumbe, the Blue Economy and Fisheries permanent secretary, made this observation here yesterday when briefing journalists about the three years of blue economy

initiatives since President Dr Hussein Ali Mwinyi launched the programme upon taking office late 2020.

The value of projects stood at 10bn/when the programme was being launched in the islands, he said, noting that the projects cover marine resources subsectors like the fishing industry, seaweed, aquaculture and seafood processing industries.

There are also projects for the con-

struction of markets and restaurants, marine conservation, research, agricul-

ture plus oil and gas research, he stated. Blue economy initiatives promote creativity and set priorities like providing entrepreneurs with tools helping startups and thus creating employment, raising the value of marine habitats, accessing capital and markets as well

## 'Vital climate mitigation technology underfunded'

Increased investment in countering climate change in East Africa is vital as the region is currently experiencing severe environmental degradation and extreme weather events

INVESTORS are choosing digital applications and solar power solutions over

crucial water and temperature technologies that could protect East Africa from the impacts of climate change, a new study asserts.

Allan Kamau, managing director of Weber Shandwick (East Africa), which conducted the research jointly with African Venture Philanthropy Alliance and Geopoll, made this observation in an online summary distributed to the media yesterday.

He said the study focused on Kenya, Uganda and Ethiopia, facing financial distress and limited capacity for adaptation, highlighting challenges in mitigation and adaptation programmes.

Digital and solar power preferences relate to a policy vacuum and incentives for investors relating to the severity or urgency of the climate crisis in East Africa, he stated, pointing at the absence of reliable information on the returns

### TV subscribers up by 300,000 in three months

THE number of subscribers in the country rose from 3.3 million in June 2023 to 3.6 million last month, the regulator has

Dr Jabiri Bakari, the Tanzania Communications Regulatory Authority (TCRA) director-general, said in a statement yesterday that the rise was occasioned by increases in the section of the population using television services.

"There were 3.6m decoders on air by September compared to 3.3m active decoders registered in June, with 1.7m being digital terrestrial television (DTT) and 1.8m used for satellite television, he said.

Dar es Salaam leads with nearly 1.4m decoders followed distantly by Arusha at 287,908 decoders, Mwanza having 282,779 such equipment and Mbeya with 229,570 registered decoders, with Songwe Region the lowest at 1,818 decoders, he said.

Meanwhile, the number of registered television stations decreased from 343 in June to 309 in September, while the number of registered radio stations increased from 228 in June 2023 to 239 in September,

Rising TV subscriptions indicate the healthy growth of the broadcasting sector, he said, noting that this increase was due to the growing use of mobile phones and computers for television viewing.

Daudi Mkwela, a Zanzibar-based broadcasting expert, said there was also popular interest in entertaining content that is now widely available, citing Bongo Flava music and the local premier league.

The growth of broadcasting offers opportunities for television service providers to improve their content to meet customer

underlining the need to strengthen the capacities of airports to detect and intercept drugs in particular.

International airports worldwide are investing in strong control systems to bar the use of such airports as a conduit for drugs, he said, urging transport stakeholders to comply with various laws and regulations governing national, regional and international air transport. Safety must be the number one priority, he declared.

He was affirmative that despite some challenges Tanzania was doing well in airspace safety, ranked fourth in Africa for robust aviation security that assures safety of aircraft operations and visitors entering the country, just behind Nigeria, Kenya and the Ivory Coast.

Investments done by the government in the aviation sector made airspace safer and attracted various international airlines to fly here, thus increasing revenues, he said, pointing out that a recent assessment by the International Civil Aviation Organization (ICAO) gave 86.9 percent in aviation security, apart from the ranking.

The country's performance in the aviation sector rose from 37.8 percent in the 2013 audit, 64.4 percent in 2017 to 69.04 in 2019, in which case ICAO provided a \$1m grant for improving airspace management capabilities, he explained.

Tanzania has recorded passenger traffic increase, from 1.5m in 2003 to 4.6m in 2022/2023, he said, acknowledging the validity of presentations that aviation training expenses were too high, thus needing HESLB to put a special package for such students.

He said the suspects were being transported using a small car with registration numbers T.732 CRB Toyota Mark X, which was being driven by Frank Makunde (38) a resident of Makambako, Njombe Region.

"This driver has been arrested and further legal measures are being taken, but we are also monitoring to identify other transporters as well as the owner of this car that was used to transport these people," he said. and risks associated with climate-related investments in the sub-region.

"It was clear throughout our research for this report that investment opportunities and tools exist, but that communication and knowledge sharing remain critical to accelerate their uptake in climate engagement across Africa," he stated.

The summary affirms that last year, Africa's annual climate finance needs amounted to \$277bn, surpassing total aid spending at \$204bn by donor partnerships worldwide.

However, foreign direct investment into developing countries reached \$1.4trn, demonstrating the potential of private investment to contribute significantly to climate finance, it asserts.

In the past three years, East Africa has suffered severe drought, the largest locust swarms for generations, flooding and surging human, animal and crop diseases, pushing over 60m people into poverty, starvation and disease with the visibly higher temperatures.

The researchers say the sectors most impacted by climate change are agriculture, health and infrastructure, while the study identified high-impact technologies such as low-cost nets for capturing water supplies from the air.

There are also new soil additives that retain long-term soil moisture, road surfaces made from recycled plastic wastes to prevent road damage and paints and surfaces that reduce heat in homes.

As the world prepares for the COP28 climate conference this November, which has emphasised the need for adaptation funding for Africa, research indicates that private investors are focused on reducing Africa's carbon footprint.

On the other hand, innovations for mitigating the adverse effects of climate change - such as rising temperatures, water scarcity and extreme weather conditions - are primarily reliant on piecemeal funding from philanthropists, highlighting a gap in systematic investment towards climate adaptation in Africa," the report noted.

as exports of marine products, he explained.

"When the eighth phase government came into office, fish production stood at 38,107 tonnes, fetching 205.4bn/- per year but now catches stand at 61,794 tonnes priced at 391.37bn/- in yearly earnings," he said, a historic increase.

The fishing sector in Zanzibar, now contributes 6.32 percent to national income (GDP) from 4.5 percent back in 2020, he stated, hailing the pursuit of economic reform by targeting the fishing sector as central to the blue economy plan. Expectations are that 50,000 small fishermen in the islands would benefit from that initiative, he said.

Deep-sea fishing has also taken a turn with initiatives in tandem with

the union authorities, with 100 such as venture capital projects, providlicenses issued to foreign and local vessels, boosting the country's tuna fishing exports at 4000 tons per year, he pointed out.

Tanzania has returned to the International Tuna Fishing Commission of the Indian Ocean, where it has asked for greater allocation of the fishing quota in line with the pace of blue economy projects, he

Tanzania has already entered into partnerships with international fishing companies, he said, citing Albacora SA of Spain, which has given Zanzibar two ice making machines worth \$100,000 and other equipment already installed in the Isles.

The government, in building the capacity of fishermen, has removed them from individual fishing and brought them into group fishing

ing them with interest-free loans to put their hands in deep sea fishing. They are learning to use equipment such as boats, machines and safety equipment at sea, he elaborated.

Fishermen have already been handed 577 boats to benefit 50,000 fishermen fishing every day via a project to strengthen the fishing in-

dustry in Zanzibar, he further noted. The project funded by the International Fund for Agricultural Development (IFAD) is billed to purchase four fishing vessels, the first

such vessel set to cost 5bn/-, he said. A fishing vessel has been purchased by ZanFresh Co. linked with the Zanzibar Fisheries Co. (ZAFICO) and it is being inspected before delivery, the ministerial executive

noted. ZAFICO already operates two

fishing vessels, he said, citing MV Sehewa and has a joint venture arrangement with an international company to conduct deep-sea fishing in territorial waters.

A reliable market for fishermen is the modern market costing \$14m in Malindi area, providing services to upwards of 43,000 people at once including fishermen, brokers, sellers, vendors, shippers and fish car-

Market operators are installing cold plants capable of storing 200 tonnes of fish at one time, along with an ice plant, he said.

The president has been strengthening the fishing industry after disbanding the fisheries department and creating a blue economy replacement to manage the fishing industry after coming into office, he

## Farmers from various villages nationwide benefiting from a new technology system

**FARMERS** from villages various countrywide are benefiting from a new technology system dubbed 'Jambo Maisha Digital Platforms' that has helped to fill the gap of extension officers, resulting in democratisation agricultural information and improved harvests.

Jambo Maisha is a digital platform that aims to improve access to information and offers easily accessible development programs in areas such as agribusiness, peace building, human rights, and financial literacy through a memberbased online system efficiently reaching a wide audience.

platform, The supported by Norwegian Church Aid (NCA), community registers members and ensures real-time information access in remote areas via SMS or smartphone applications.

Testifying on how the digital platform has assisted them, one of the farmers from Hai District in Kilimanjaro Region, Kanaeli Mushi explained that through the platform many farmers have been reached and have access to agricultural and climate change information.

Mushi added that before the system, the officers used to make house to house visits to provide agricultural information to farmers whereby a limited number of farmers were reached.

"With Jambo Maisha Platform, some 100 households and more than 850 individuals have been reached and benefited within a short time," said Mushi.

Godlisten Patrick, also a farmer from Region, Kilimanjaro said the platform has succeeded in mobilising many youth who have been empowered with skills and knowledge of how to practice modern agriculture without being affected by climate change.

Hamida Ramadan from Zanzibar (Pemba) , a beneficiary of the platform, said within

126 farmers in smart and innovative agriculture methods, making them more sustainable against climate change.

The farmers were speaking during the Civil Society Organisations (CSOs) week that took place in Arusha recently for purposes of bringing together civil society organisations, policymakers, technologists, and stakeholders to exchange ideas, experiences, and knowledge on leveraging technology for positive societal impact in Tanzania.

The theme for this year's event was 'Explore the Transformative Power of Tech and Society in Tanzania, Tech X Society: Then, Now and Beyond'.

Speaking during the CSO Week, at a session called 'Climate Smart digital tools for agriculture and market access to small holder farmers' that was 

one month she has been able to train hosted by NCA, Piusi Ngirwa from the Anglican Diocese in Morogoro Region said the digital platform has filled the long existing gap of extensions officers who farmers were previously relying on to provide them with agricultural information.

> Ngirwa added that during that time most farmers could not access agricultural information because the number of extension officers was small and they were not able to reach farmers in some parts of the country due to its geographical position.

Oscar Italazyo from NCA said the goal of Climate Smart Economic Empowerment (CSEE) is to enable people to lift themselves out of poverty while building communities' resilience through micro-investment and next level investments.

Oscar said with the CSEE programme, NCA Tanzania aims to increase income to small scale producers and service providers, ensure climate resilient production and service systems are in place.

Under the CSEE programme, more than 600 small holder farmers have been linked to output markets. Out of the number, 24, 924 are youth.

# 'Plans afoot to create collaborative efforts to have stroke-ready centre at Muhimbili'

PLANS are underway to create collaborative efforts to initiate the first stroke-ready centre at Muhimbili National Hospital (MNH) Mloganzila branch. The mortality rate is now approximately 30 per cent.

Dr Asha Mahita, the head of referral services abroad in the Ministry for Health said that over the weekend during the 14th neurology regional teaching course in sub - Saharan Africa at MNH Mloganzila.

She said training was under the theme: "Brain Health Across the Life Span" and brought together neurologists from Spain, Senegal, Uganda, Kenya, Niger, South Africa and Togo to mention just a few.

She said the World Health Organisation (WHO) estimates that every 40 seconds someone has a stroke, and every 3.5 seconds someone dies of stroke worldwide.

Cerebral vascular diseases like stroke for instance, are a leading cause of death worldwide and permanent debility adding that in Tanzania for instance,

"We hope to make great strides in the treatment of stroke in Tanzania, as there are plans in place to create a collaborative effort to initiate the first strokeready center.

"Currently, there are over 1 million patients with epilepsy in Tanzania. This high prevalence of epilepsy is due to a high prevalence of intracranial infections of bacterial or viral origin, perinatal brain damage and head injuries and brain tumour," she said.

According to her, the government struggles for six

scientific research and scholarship in the field of neuroscience and providing a platform for the exchange of ideas and information among neuroscience professionals in Tanzania and beyond.

"Consequently, a large burden of neurological infections also befalls our people. With better diagnostic and treatment facilities, there is a significant improvement in the rates of these infectious diseases but a huge gap still remains," she states.

She said the life expectancy has increased from 46 years to 67 years adding the longevity has led to another problem.

"We need to be prepared for diseases like Parkinson's disease and dementia with these improvements in longevity," she noted.

She hinted that Tanzania is one of the hardest hit countries in sub-Saharan Africa, due to lack of proper expertise and training on how to manage these patients.

Currently, there are only 14 neurologists in the whole country of 62 million people, where out of these, 11 are adult neurologists, and 3 are Paediatric Neurologists.

Chairman of the Tanzania Neuroscience Association (TNA) Prof William Matuja said that The vision of the Tanzania Neuroscience Association (TNA) is to become a leading organization in Africa that fosters the development of neuroscience research and education in Tanzania.

He said that TNA seeks to enhance public awareness and understanding of the brain and nervous system and their role in human health and disease.



### **NEMC** cautions land developers on beaches

THE National Environmental Management Council (NEMC), has warned people who invade the beach's shores and build permanent structures without having an Environmental Impact Assessment (EIA) certificate.

Rose Mtui, NEMC manager of environmental researchers issued the warning yesterday in Dar es Salaam when opening international regional training workshop on shoreline changes management for coastal municipalities' officials of beaches in the countries of the western Indian Ocean.

Rose said the beaches have been suffering the effects of erosion due to climate change and the effects of human activities even though they are prohibited by law. "There is an Environmental Law that prohibits the construction of permanent buildings on the beaches, especially within 60 meters, so this training will give light to the people who work in planning, especially when land officers issue permits to follow the law," said Rose.

She said that although NEMC has been conducting frequent operations to remove people who build permanent buildings on the beaches, the situation has been repeating frequently, especially in the city of Dar es Salaam.

"There are people who get permits from other institutions before getting an EIA permit from NEMC and we have been monitoring those we give permits to and if we see that they have violated the permit instructions, we have been taking measures," he

Head of the Aquatic Sciences and Fisheries Technologies from University of Dar es Salaam (UDSM), Dr Siajali Pamba, said that due to climate change, many beaches have been eroding and endangering property and infrastructures that is dependent on the implementation of blue economy vision.

He said beach erosion takes a long time to happen but without doing an assessment and checking them regularly has been causing a big impact on various beaches.

He said the conference unites three countries in the Indian Ocean region so that all those countries speak the same language about each other's responsibilities and share experience on the best way to manage beaches so that they are not damaged.

"As we move towards a blue economy where many tourist hotels will be built now without having a good procedure to manage our beaches, we may find ourselves endangering this infrastructure that will help to implement the vision of the blue economy," he said.

"The main goal of this conference is to awaken the land planners not to forget the sea area, especially on the beaches they should see that it is their daily part to look and plan because these days everyone does what he wants," he said.

Executive Secretary of Western **Indian Marine Sciences Association** (WIOMSA), Arthu Tuda, said the sea beaches have been changing many times due to climate change and human activities.

"It is important that we consider the best use of our beaches which have been facing constant challenges such as big waves from the sea, sometimes we hear Tsunamis and the sea has many things so when we do economic activities we should consider the safety of the beaches," he said



#### **Investment forums are never too** many with persisting mindset gap

NOTHER jamboree is set to light up upper circles of government and business with an international conference on enabling environment for investments in Africa, set for Dodoma next month. One highlight of the latest event to bring numerous high flung guests into the country is that former president Jakaya Kikwete will lead discussions at the College of Business Education (VBE) which is at the centre of those arrangements. Local participation is drawn extensively from extensive representation of public institutions and private sector

International conferences are often held in a modicum of contempt as talking shops, or where a number of people get the luxury of paid for travel, accommodation and auxiliaries just for being heard in such occasions. At the policy level, it is often presumed that conferences are a form of tourism, such that it is in the same category as luxury or entertainment, and implicitly not worth the public funds that go to oil such events. As a matter of fact things aren't that easy as policy making in each sector meets with stumbling blocks of choices already made.

A number of these impediments are anchored in the country's fundamental law, for instance the formulation that the country will be led by a policy of socialism and self-reliance/ There is ample effort to evoke the self-reliance imperative in a number of key decisions, but the underlying premise of socialism is at times for plenty of political heat raised when commercial decisions are close to being made. There is great fear that someone will be shortchanging the country, with more effort directed at how the country is being cheated, even if facts show the contrary.

Another source of policy making initiatives is international commitments, set in a hierarchy of values and obligations which aren't always easy to disentangle, as to where commitment to East Africa starts, or to Africa and to non-alignment, to traditional development partners, etc. That is why plenty of such gatherings, and even occasions where public officials travel with top national leaders to attend similar gatherings, aren't a drain on public funds. They help with often painful, now just slow evolution of mindsets, to avoid gross errors that retain far too many people in shackles of poverty, as outward-looking initiatives are too often shirked.

Far too often it is a fact that one is adamant with his or her position until such person meets a person respectable enough in his or her private viewpoint, to bring the person to an alteration of perspective on a particular issue. And when that happens it has an impact in the fellow's appreciation of other matters, as the human mind works in a conjoined manner so as to attain calm, persuasion, comfort and dignity in what one is asserting or supporting. Decisions are made within a broad based framework of convictions, not just haphazard events each with its peculiar arguments and justifications; it meets with a torrent of doubt mentally, publicly.

Then there are decisions that a conference could make out to be unwise, but as in an old literature textbook, making such an observation in a public meeting would reduce the contributor to an 'enemy of the people.' In the seclusion of a conference room, the argument can be made and people get the point. It is quite often the

#### **EU working positively with Africa** in the new hydropower source pact

hydropower sourcing at 'Kakono in Kagera Region is a refreshing news item we have heard of late, to produce 87.8mw of power, while that energy source is both plentiful and doubtful in the country's environment at present. The key reason for outages in the city of Dar es Salaam and elsewhere in the past month or so, and billed to stay for five months longer at the very least, is the same hydropower sources. At the same time for the European Union to extend such support, notice needs to be taken of the wider outlook especially of the European Union Parliament in Brussels. Coalitions of political parties have roundly proposed resolutions as well organising demonstrations in various capitals against the East African crude oil pipeline project, seeking that the whole world abandons fossil fuels, especially the more noxious fuels

ARNERING \$35m for characterized by their black colour, namely coal and crude oil. They want all investment in crude oil extraction to stop, which is to jump the gun.

The policy outlook that Africa accepts is an energy mix, as healthy as can be achieved at the moment, where there are convergences and divergences with EU views in particular. The EU is in environmentalist terms the most forthright and most combatant alliance in the world on that score, which reflects the perils of being trapped between melting glaciers to the north and spiraling oil prices from non-European producers. Those to whom it delivers development support are by and large expected to understand this position, accommodate these concerns, etc.

Yet it is obvious that a radically militant position will not cut the ice with African countries, pushed to the limit working to uplift agriculture and stem hunger amid climate change. Thus the EU leadership skirts clear of the militancy of their EU Parliament colleagues, and works with African countries to develop a positive energy mix as in developing a new hydropower source, without a 'conditionality' of abandoning EACOP as a range of EU parliamentarians would actually demand. It gives Africa more legroom to improve its power mix strategy, for a decade or so.

There is also a noticeable presence of the French authorities in the new deal, as the country's international development agency contributed euro 288.1m (800bn/-) out of the total funds. Kagera Region is strategically positioned with central African states in the EAC. It converges with French interests and helps with regional integration, thus also a positive energy mix.

It also seeks to engage in discussions or regional cooperation platforms that can enhance security interdependence among states bordering the Red Sea, with the view to enhancing the influence of think tanks in shaping regional platforms and promote among them to develop innovative solutions to security challenges.

According to Mesafint, the forum is expected to produce well informed policy makers, research oriented policy and eventually shape public opinion towards peace through research, advocacy, and outreach services.

"By achieving these outcomes we can contribute to the establishment of the Red Sea region forum that is both secure and prosperous, characterized by peace and stability. We have the ability to foster an atmosphere that encourages effective governance, cooperation and inventive ideas by leveraging knowledge and collaboration.

# Ceasefire needed to prevent worse humanitarian disasters

SINCE the outbreak of the latest round of Palestinian-Israeli conflict, the escalating situation has drawn global attention. The large-scale civilian casualties and worsening humanitarian crises are questioning the conscience of humanity.

Currently, the fighting continues and lives are still being lost, and the spillover effect is impacting regional peace and stability.

The international community generally hopes that the parties to the conflict will cease fire and return to the track of negotiation as soon as possible, so as to create opportunities for peace and prevent an even worse humanitarian disaster.

In recent days, the number of casualties resulting from the conflict has continued to rise, and the living conditions of the people in Gaza have been deteriorat-

A deadly blast at the Al-Ahli hospital in Gaza has resulted in heavy casualties. Such acts of killing and maiming innocent lives must be unanimously rejected and condemned by the international community.

Faced with a complex and extremely urgent situation, all parties must prioritize the value of life and conscience of humanity.

Military actions should not go beyond self-defense or impose collective punishment on civilians. Protecting civilians in armed conflicts is a red line defined by international humanitarian law, and the indiscriminate use of force is unacceptable.

The parties to the conflict should adhere to international law and international humanitarian law, including ensuring the safety of civilians and detainees, opening humanitarian corridors, and preventing an even worse humanitarian disaster.

The history of the Palestinian-Israeli conflict has repeatedly demonstrated that the conflict cannot be resolved with military means, and responding to violence with violence will only lead to a vicious cycle.

The parties to the conflict should exercise restraint, immediately cease fire, and seek dialogue. All relevant parties in the region should maintain calm and restraint, uphold objectivity and fairness, promote deescalation of the conflict, and avoid greater impacts on regional and international security.

The international community should take action to oppose any actions that harm civilians, and actively encourage peace talks. United Nations, especially the UN Security Council, must shoulder its responsibility, focus on humanitarian concerns, clearly call for practical measures to a ceasefire, an end to violence, protection of civilians, and the formation of a binding international consensus.

As long as the fighting continues, it will be impossible to avoid further violations of international hu-

manitarian law. Without a full ceasefire, any humanitarian aid will only be a drop in the bucket.

If the current fighting in Gaza is allowed to drag on, the end result will not be a complete military victory for any side, but a wider humanitarian disaster and a more serious crisis.

Currently, the international community is expecting the UN Security Council to play a role in de-escalating the conflict and preventing humanitarian crises. However, a few major countries, while verbally emphasizing the need for the Security Council to take appropriate actions, have triggered doubts about their true intentions through their voting positions on relevant draft resolutions.

In recent years, the international landscape and the situation in the Middle East have undergone numerous changes, with certain major countries pulling the strings in the Palestinian-Israeli conflict. This has led to the gradual marginalization of the Palestinian issue, and relevant UN resolutions have not been

effectively implemented. The current Palestinian-Israeli conflict serves as a painful reminder to the international community that the Palestinian issue has always been at the core of the Middle East issue. Without a just and equitable resolution to the Palestinian issue, lasting peace in the Middle East is unlikely to be achieved.

The Palestinian-Israeli conflict is a long-standing and complex issue, intertwined with disputes over territory, ethnicity, and religion. The difficulty in resolving the conflict lies fundamentally in the prolonged denial of the Palestinian people's right to statehood, right to existence, and right to return.

Israel has the right to statehood, and so does Palestine. the fundamental approach to addressing the Palestinian question is the implementation of the two-state solution, and promoting the establishment of the timetable and roadmap for restoring the legitimate rights of the Palestinian nation. The two-state solution, recognized by the international community, is that the Palestinians have their independent state with East Ierusalem as its capital, along the borders from 1967. The international commu-

nity generally supports the resumption of negotiations between the two sides based on the principles of "land for peace," relevant UN resolutions, and the two-state solu-Despite the differences be-

tween the two sides in terms of implementation, the twostate solution remains the only consensus-based approach to resolving the issue. After the outbreak of the

current conflict, the interna-

tional community has once again come to the profound realization that the true implementation of the two-state solution is essential for resolving the Palestinian-Israeli conflict and bringing genuine peace to the Middle East.

Some said that any solution that deviates from the two-state solution is not feasible, and some believed that there is no alternative to the solution for resolving the issue. Some voices thought that a just and lasting resolution to the Palestinian issue could not be achieved without implementing relevant UN Security Council resolutions and establishing an independent State

On the issue of Palestine, China always stands on the side of peace, justice, international law, the common aspirations of most countries, and human conscience.

Currently, China is in communication with the relevant parties to prevent the escalation of conflict and humanitarian disasters, and will continue to provide emergency humanitarian assistance to the Gaza Strip through the UN and bilateral channels.

China will support all efforts conducive to the implementation of the two-state solution and seeks a comprehensive, just, and lasting resolution to the Palestinian issue, in order to achieve peaceful coexistence between Palestine and Israel. To act responsibly for peace and lives is a shared duty among all peace-loving and fair-minded

In the face of ongoing conflicts and escalating humanitarian disasters, major countries, in particular, need to uphold objectivity and fairness, promote a prompt ceasefire and cessation of hostilities, and explicitly call for the implementation of the two-state solution, so as to eliminate the fertile ground for violence and play a constructive role in maintaining peace and stability in the Middle East.

Meanwhile, more than 20,000 others were wounded, thousands of whom suffered from critical health conditions with no access to basic treatment.

The health authorities also received 1,870 reports of missing persons under the rubble of destroyed buildings, including 1,020

The Gaza-based al-Mezan Center for Human Rights confirmed that the death toll is higher than announced as many are still under the rubble, and there are border areas that rescue crews fail to reach.

Civil defense crews face extreme difficulties in rescue operations due to a lack of specialized capabilities, tools, and fuel to power vehicles and machinery, in

addition to repeated Israeli shelling. Rescue workers have to redirect their tasks, from spending hours trying to recover bodies to rushing to retrieve those who are still alive.

"If we know that someone is still alive, it may take hours to pull him or her out from under the rubble, but we will never leave anyone there," said Mahmoud Basal, spokesman for the Palestinian Civil Defence.

# Climate-friendly biogas becomes 'fashionable' in Tanzanian villages

IN Malambo village, Ngorongoro District, Arusha Region, the lush forests and livestock that once flourished and the rivers that flowed year-long are now a distant memory. Today, gaunt thorny trees and other drought-resistant plants dot the parched landscape along dry ravines.

In this northern region of Tanzania, the bulk of residents are cattle, sheep or goat herders who for many years have depended on their livestock for a living. But with severe droughts spanning over the years, this once-thriving source of livelihood is under threat. Hundreds of farmers are losing their livestock while the prospects of shifting to crops are equally bleak.

Ngorongoro, a remote district in Arusha, is a testament to how rural communities are bearing the brunt of a changing climate that is ravaging many parts of East Africa.

"In the face of these frequent droughts, rural women in Ngorongoro have come to realize that they must mitigate and adapt to the effects of climate change, or their families will also die, just like their livestock," said Maanda Ngoitiko, executive director of the Pastoral Women's Council (PWC).

UN Women partnered with PWC for a project aimed at building new skills for out-of-school pastoralist adolescent girls and young women in biogas and solar energy products, as well as in running sustainable businesses. Ngoitiko explains that in past droughts, women from Malam-

bo had to walk up to 5 km to fetch water and firewood. However, the borehole constructed with support from UN Women has made it easier to provide water to the community and their livestock.

To further build the community's resilience to climate change, UN Women partnered with PWC to help young women benefit from environmentally friendly biogas energy using cow dung. The project trained 100 adolescent girls and young women in Ngorongoro district to build small-scale biogas plants.

Biogas is an environmentally friendly fuel that is naturally produced from the decomposition of organic waste, such as cow dung. It recovers waste that would otherwise release dangerous levels of methane gas, which contributes to global warming. Biogas generation also reduces reliance on fossil fuels, saves money by treating waste on-site, and reduces pollution in landfills, among other benefits.

The project benefited five women in Malambo village by establishing a biogas learning center to disseminate knowledge about this fuel and to provide local construction services. One of the beneficiaries, 26-year-old Teresia Simon, stated that the learning center in Malambo has made using biogas for cooking "fashionable."

"The number of families opting for biogas here in Malambo is increasing and some of the attractions include how it is reducing the burden of walking to faraway places to fetch firewood - and combating deforestation," said Simon. "If all people around the world can stop cutting

down trees - which absorb carbon that causes global warming - and resort to clean energy, we can reclaim our once-beautiful environment."

The use of biogas came with other benefits in Malambo. Besides avoiding soot from their pots, which made washing dishes take longer, some users now have modern kitchens.

One of the users of a biogas stove, 32-year-old Nooretet Lenchoe, explained that her traditional lowroof kitchen wasn't compatible with the stove.

"I am now happy to use a biogas stove in my new modern kitchen," she said. "Collecting firewood from distant places was dangerous because of wild animals that roam this area.'

From the 26 cows her family owns, Lenchoe collects 20 kg of cow dung every two weeks, which she mixes with water to process the waste into biogas.

"Because biogas cooks faster than firewood, I now have more time to focus on my small shop," she ex-

UN Women Representative for Tanzania, Hodan Addou, says time is an essential commodity for rural women.

"Here in Tanzania, we are looking at increasing support for rural women to be able to use green cook stoves as one way to improve their quality of life and to combat deforestation. We are seeing how those we are assisting are also able to spend more time running incomegenerating projects and improving the well-being of their families," she

Addou adds that indoor air pollution caused by burning wood or similar fuels for cooking is a source of sickness and death for poor women around the world.

UN Women is part of the Global Alliance for Clean Cook Stoves, which advocates for the establishment of a global market for clean and efficient household cooking

# Improve special sexual offences courts infrastructure, activists urge Z'bar govt

ZANZIBAR government has been advised to repair and improve the infrastructure of special sexual offences courts in the islands, including facilitating the use of electronic evidence to be friendly to those who use those courts and facilitate access to justice in a better environment.

Human rights activists acts. made the advice over the weekend when speaking during a meeting to present a report on the effectiveness of the Special Court in dealing with human rights abuse cases since its inception.

Aimed at discussing the future of children to be protected against such abuse. the meeting was organized by Tanzania Media Women's Association (TAMWA, Zanzibar) in collaboration with the Foundation for Civil Society (FCS) and the Norwegian Em-

According to the report, despite the court showing great success in hearing cases since its inception, its infrastructure is still insufficient due to the lack of modern instruments for hearing cases, including digital systems (video conference) and the lack of special rooms to keep the children affected by such

Hawra Shamte, who is a researcher of the study conducted by TAMWA, Zanzibar between June 16 and July 16, 2023 involving Shehia 57 Unguja and Pemba said: "Lack of equipment in the courts and poor infrastructure is still a challenge, for example the buildings of the Vuga Court, Mahonda, Mkojani and Wete Pemba is old and almost out of date when the thing that leads to difficulty in conducting those cases."

She also said that research

has revealed that among the successes of the presence of the court is the increase in the hearing of cases of humiliation in those courts.

"They said that this special sexual offences courts shows that these days cases of this type are taken very seriously and even the sentences given are not as small as it used to be, these days you will hear that someone is given from 20 years to 30 years in prison and there are also those who are given life imprisonment," explained Hawra.

As a result of the study, among the challenges that hinder the effectiveness of the courts are many cases involving young people aged from 14 to 18 years, the victims failing to cooperate in giving evidence, the study has advised the government to increase investigative equipment to enable the investigation to be completed early to avoid fickle witnesses.

"We recommend the government to provide adequate equipment to the police department to enable efficiency in conducting investigations without delay, including establishing and facilitating the use of electronic evidence in these cases," the researcher empha-

Zaina Salum, TAMWA Zanzibar anti-GBV project coordinator explained that the organization is conducting various researches to promote positive change on these issues.

Zaina said: "We've been working on various issues related to acts of humiliation through research and delivering them to relevant institutions and stakeholders to work on them to help the community overcome this problem."

Asha Abdi, TAMWA, Zanzibar chairperson advised the community to give children a chance to socialize with their

peers through various platforms in order to build them the ability to be assertive and confident to talk about the challenges and opportunities they face and to protect them from acts of humiliation.

She said that if children are given the same opportunity as parents to fully participate in their platforms, including children's councils starting at the Sheha level, it will build them to grow on the basis of courage and develop the ability to face various obstacles that suppress their rights.

Asha mentioned that female children lack their rights including the right to leadership due to the lack of foundations to be involved in their platforms from the initial level that make them realize their important opportunities and rights.

"Parents should allow our children, especially girls, to interact with their peers

that they have the opportunity to discuss their concerns and this will help them build the confidence to speak openly about their challenges," explained the chairperson.

Wilfred Ezra, who is an investigation officer from the Human Rights and Good Governance Commission, advised the community to continue to report incidents of abuse when they occur to help protect children and control the perpetrators of such acts.

Thuwaiba Ali, one of the students who participated in the meeting, asked the government to increase severe punishments for perpetrators of acts of violence so that these punishments are a warning and a threat to those who violate human rights.

"The government should impose severe punishment on those who commit acts of

through children's forums so humiliation to scare others to continue doing such acts because many continue to humiliate us because they know that even if they are imprisoned, they will be released because there is no severe punishment," explained the student

## PrEP puts brighter future for youth at risk of HIV infection

MARIAM Kawawa (33), a mother of two who works as an attendant at one of the biggest bars at Mbalizi in Mbarali District, Mbeya Region, considers herself as a hero after two years of using pre-exposure prophylaxis (PrEP) to re-duce the risk of acquiring HIV.

Kawawa (pictured) says being a barmaid exposes her to the virus because she comes across a number of men who want to have unprotected sex with her.

"I face a number of challenges during my work including most customers being in need of unprotected sex. I do agree because I need money to feed my two children and care of other family members," narrates Kawawa who considers herself as a hero after being able to convince more than six fellow women to start using the HIV pre-

Kawawa is among the 1,864 women and adolescent girls who receive pre-exposure prophylaxis in Utengule-Usongwe, Nsalala, Iwindi, Igale and Bonde la Songwe wards in Mbarali Rural District.

Kawawa recounted that in September 2021 she met a peer educator from Save Tanzania (SETA) who educated her on the importance of going for HIV tests as well as taking pre-exposure prophylaxis to prevent HIV infection.

"I agreed to take the HIV test and my results were negative. I started using the drugs the same month; after six months of using the drugs, I was tested for HIV and the results were negative. I now continue taking the drugs and I don't fear engaging in unprotected sex," Kawawa said as she commends the Henry Jackson Foundation Military



Research International (HJFMRI) and the U.S govern-ment's President's Emergency Plan for AIDS Relief (PEPFAR) for providing the medicines

Apart from having keen adherence to PrEP medications, Kawawa has inspired almost six women at the Mbalizi area to use the drugs to be safe and protect themselves from being infected with HIV.

Agnes Sanjes, peer educator from SETA in Mbalizi, Mbarali Rural District said: "We provide education to key and vulnerable populations including sex workers and adolescent girls aged between 18 and 24 years. We educate them on the importance of testing and using PrEP. Those who are diagnosed positive are referred to Mbalizi Designated District Hospital for medications which include being enrolled for antiretroviral (ARV) treatment.

Key and vulnerable populations are at a higher risk of acquiring HIV infection. In 2015, the World Health Organization (WHO) recommended Preexposure prophylaxis (PrEP) as part of combination prevention for people at substantial risk of acquiring HIV infec-tion due to risky behaviors.

Data show that adolescent girls and young women account for 74 percent of new HIV infections among all adolescents in sub-Saharan Africa and nearly 1,000 of them were infected with HIV every day.

Health Minister Ummy Mwalimu was recently quoted saying that 96 percent of Tanzanians living with HIV infection are aware of their health condition and that 98 percent of people living with HIV in the country use ARVs.

According to UNAIDS, the countries of Botswana, Eswatini, Rwanda, Tanzania, and Zimbabwe have reached the goal of '95-95-95' targets for ending AIDS

# ANC hopes to capitalise on Zuma's KZN popularity win over voters

HE ANC in KwaZulu-Natal (KZN) hopes to boost its chances of winning elections in the province by capitalising on the popularity of former president Jacob Zuma and other party elders.

This reliance on the man who epitomises the party's descent into State Capture, patronage and corruption flies in the face of its efforts to clean up its act under President Cyril Ramaphosa.

The main reason the provincial leadership of the ANC wants Zuma as a frontman in their 2024 election campaign is because they believe no one has the political and popular clout in KZN that Zuma maintains.

Defending this position, provincial ANC spokesperson Mafika Mndebele said those who criticise Zuma do not have the same capability to campaign successfully for the ANC in KZN.

"President Zuma is the most popular figure in our province - can those people fill a hall then criticise him?" said

The wily 81-year-old was sentenced to 15 months in prison for contempt of court after failing to appear before the Zondo Commission. He is also facing multiple corruption charges related to the 1990s Arms Deal.

He appeared in the KwaZulu-Natal Division of the High Court in Pietermaritzburg on 26 October in yet another bid to remove Billy Downer, the lead prosecutor in this case. Various courts, including the Constitutional Court, have dismissed his previous attempts to do so.

Despite his Stalingrad tactics to avoid his day in court, Zuma's popularity among masses of followers continues unabated.

This was evident in the riots, public violence, looting and rampant destruction of lives, livelihoods and property after his imprisonment in 2021. Long before that, in 2006, he also received immense popular support despite being charged with rape - a charge of which he was acquitted.

Zuma has long mastered the art of playing the victim. It arguably fuelled his victory over Thabo Mbeki at the ANC conference in Polokwane in 2007. Before that, in 2005, Mbeki had fired Zuma as deputy president of South Africa in the wake of Schabir Shaik, his financial adviser and benefactor, being found guilty of corruption and fraud.

Despite the weight of all his court battles and the corruption allegations against him, Zuma's clout in KZN is undeniable. Before he became the president of South Africa in 2009, the ANC had not managed to get an outright majority vote in the province. It lost to the IFP in the first democratic elections in 1994, fared somewhat better in 1999, getting 39% to the IFP's almost 40%, and secured almost 47% of the vote in 2004, when the IFP had fallen to just under 37%.

With Zuma at the helm of the ANC in 2009, the party got an overwhelming 62.95% of the vote in KwaZulu-Natal. It continued to see growth in his second term as South African and ANC president, when its support rose to 64.52% in 2014.

However, in the general election in 2019, the ANC started to decline in the province and only managed to secure 54.22% of the vote.

The voting results at the national level paint a different picture. Under Nelson Mandela's leadership, the ANC had 62.65% of the vote in 1994, and it peaked at 69.69% in 2004 under Mbeki. Zuma's presidency saw the party fall back to 62.15% by 2014.


Its lowest support, however, came under Ramaphosa in 2019, when it only managed 57.50%. Many argue that this was the result of 10 years of State Capture and rampant corruption while Zuma was at the helm.

#### The ANC's renewal project

The ANC under Ramaphosa has recently taken a hard line against corruption and disciplined members found to be complicit in wrongdoing.

For example, secretary-general Ace Magashule was expelled from the party for, among other reasons, having been criminally charged. Members with criminal records have also been prevented from running for positions in the ANC

Though the ANC Veterans' League is leading this "renew-  $\,$

al" project, the party has also assembled a commission to deal with it. Ramaphosa is the chairperson and secretary-general; Fikile Mbalula is the coordinator.

But on 12 October, at a memorial service for struggle stalwart Aziz Pahad, Mbeki raised concerns about the party's failure to arrest its decline and lashed out at the slow pace of renewal.

#### What the polls say about KZN

According to Mndebele, the latest internal ANC polling in KwaZulu-Natal says that the party's support in the province stands at about 52%.

This is vastly different from a poll by The Brenthurst Foundation that was released last week. It put the ANC at 32%, followed by the IFP at 27%, the DA at 19% and the EFF at 15%.

Mndebele shrugged off the idea that the IFP could pose a threat to the ANC and emerge as the largest party in the province.

"We have been answering this question and the media keeps repeating it with a hope of a different outcome. The IFP is busing people [to by-elections], buying ANC councillors and, at times, working jointly with the DA for victory at ward level. But this is not possible in general elections. We are winning elections in KwaZulu-Natal," he claimed.

IFP spokesperson Mkhuleko Hlengwa views the ANC's confidence in an outright electoral victory as the stuff of dreams. "Without evidence, it remains just that - a spurious claim.

"The IFP would never be so irresponsible as to accuse another party of rigging elections without proof. This is a very serious allegation which undermines the integrity of the IEC [Electoral Commission of SA] and the electoral process.

"As the IFP, we believe it is very dangerous to make such claims, particularly those relating to election processes, without evidence to back it up.

"Further, by implication, the ANC is insinuating that the IEC is turning a blind eve to illegal activities.

"As we approach elections, we call on all media houses to report without fear or favour, remaining cognisant of their responsibility to provide news that is accurate and based on facts, not on the unsubstantiated claims of a party that is very clearly on the decline," he said.

The DA's second deputy federal chairperson, Solly Malatsi, also believes the claims by the ANC are inaccurate. "This idea that we can only win wards against the ANC

"So, this claim is outrageous. It seems like the ANC just can't take by-election losses graciously. It is clearly intimidated by the impact of the ever-growing political cooperation between the DA and IFP in consolidating the opposition vote in KZN," he said.

Analyst Levy Ndou said that if there is any wrongdoing by political parties, the matter should be taken to the IEC.

"There is a lot of panic when the results of the by-elections are announced because they could appear as if they provide an indication on how political parties are going to perform in the 2024 elections.

"The claim by the ANC - it would be good if they are able to provide proof that indeed these parties have combined votes only to favour the IFP," Ndou said.

Zuma speaks

Zuma addressed supporters in the ANC's General Gizenga Mpanza Region last weekend and committed himself to campaign for the party. He also encouraged people to vote for the ANC to "defeat the beneficiaries of apartheid who want to see indigenous people forever trapped in abject poverty".

He went on to warn members against leaving the ANC to form small political parties, which he said were aiding those who want to see the collapse of the party.

"It is unwise not to vote for the ANC in next year's general elections because you are aggrieved or because you have a problem with a certain leader. This will never change anything. Instead, such a decision will reverse the gains we have

made over years of struggle for the betterment of the lives of indigenous people," Zuma said.

In a statement issued by the KZN ANC, it said an announcement would be made regarding a "programme of action" that not only includes Zuma, but also senior party members S'bu Ndebele, Zweli Mkhize, Willies Mchunu, Sipho Gcabashe, Senzo Mchunu and Mike Mabuyakhulu.

Mkhize was recently embroiled in the Digital Vibes scandal, but was never charged. He has been fighting for a review of the Special Investigating Unit report on money allegedly being siphoned from the Department of Health for the benefit of his family and associates.

#### **ANC decline in KZN**

The possibility of the ANC in KZN dipping below 50% has arisen as the IFP continues to regain its support in the province.

The ANC provincial leadership in May cited the DA's "moonshot pact" as the reason for its electoral decline in recent by-elections in a report that was presented to the party's National Working Committee (NWC).

Between February 2022 and April 2023, the IFP won seven wards and the DA one from the ANC in the province.

The ANC's provincial structure said the party's decline from 2.5 million votes in the 2014 elections to 1.9 million in 2019 should largely be blamed on a lower voter turnout

However, it did acknowledge the IFP's growing support in the province, despite the death of the party's founder, Mangosuthu Buthelezi, in September.

In the 2014 general election, the IFP registered its lowest support since South Africa became a democracy and was relegated to being the third-largest party in KZN.

However, it has made a strong comeback since the 2016 local government elections and, in the 2019 national election, it won back the status of being the official opposition in KZN. In the 2021 local elections, the IFP managed to maintain its upward trajectory by increasing its support.

In its report to the NWC, the KZN ANC leadership acknowledged "the challenges from other opposition parties".

"The province has seen a shift to the EFF and IFP. Most of the voters where the ANC is losing power are in the former IFP voting districts. The ANC remains strong and maintains power in its strongholds.

"The eThekwini region showed the highest drop in voter turnout and ANC support, and subsequently contributed the largest to the drop in 2019," the report said.

"The DA, Freedom Front Plus and the EFF showed positive growth in the province when comparing two general elections, 2014 and 2019. In the local government elections, the IFP showed a spike turn [sic] from negative growth to a high positive."

Whether Jacob Zuma is the man to turn back the tide of the ANC's slide in KZN remains to be seen. Analyst Sanusha Naidu is sceptical that much will come of the party's renewal project as well as its efforts to appear unified, and doesn't think Zuma will necessarily be able to turn around its fortunes in the province.

"This is kind of a reflection of where the ANC is nationally, regionally, provincially and at branch structure level.

"It seems they are trying to consolidate and trying to get back a sense of coherence, trying to shift away from the fragmentation they find themselves in internally, because it is really quite a disruptive party right now internally when you listen to the secretary-general, when you listen to the National Executive Committee. The internal implosion is evident because they are not speaking with one voice," Naidu said.

"I think it is grasping at straws as they realise that their footprint in the province has been really in a precarious situation. It has been caught in internal power struggles.

"What they are hoping for is that bringing former president Zuma will give them a good chance. It demonstrates how fluid the political architecture and dynamics are. If it's a good or bad idea? This is where it is for them. They may do well in certain parts of the province outside the metro."

# Africa unlikely to follow East Asia's manufacturing growth path - study

**WASHINGTON** 

FRICAN countries are less likely to follow East development model of expanding manufacturing to pull people out of poverty, according to a study that shows a declining share of factory jobs for most countries by mid-century.

The new paper released on Monday by the Center for Global Development shows there will be fewer factory workers in 2050 globally than there are now, and that even in poor countries with abundant cheap labor, manufacturing job growth will stagnate.

Currently, Africa is at the bottom of the global value chain with its share of global manufacturing at around only 1.9 percent.

In 2015, the revenue output of the manufacturing industry in Africa amounted to US\$500 billion. This figure was projected to rise to around US\$930 billion by 2025.

According to the study, China may be an exception, further expanding its share of manufacturing output among 59 countries modeled in the study to 43.8 percent in 2050 from 30 percent in 2018 and 10.5 percent in 1975.

The study's authors say that China will continue to dominate global manufacturing, moving into higher-value segments.

While this may create some space for other developing countries in Africa, Southeast Asia and Latin America to move into lowerend manufacturing in low-end sectors abandoned by China, it won't be enough to replicate the transformative East Asian development model of moving from Agriculture to manufacturing.

Instead, CGD senior fellows Charles Kenny and Ranil Dissanayake say that many countries will move straight from agriculture to services, where jobs will expand rapidly, especially because of new technologies -- even in countries such as Bangladesh and Ethiopia.

"There's still a popular idea that low-income countries will progress naturally from being dominated by agriculture to manufacturingled growth, but mounting evidence suggests that's not going to happen," said Kenny. "We think that farms are going to empty out across Africa and Asia in the coming decades, but people are likely to flood into offices and shops, not



"This doesn't mean that poor countries will never escape poverty. New technologies and the shift to services which can be easily delivered across borders can be transformative. But taking advantage of that will require and governments in developing countries need to be clear-eyed about the future of the world economy," said Ranil Dissanayake.

The study projects global growth through the year 2050 and mod-

good policy and concerted efforts, els changes in the economies of 59 countries accounting for about three quarters of the world's GDP and population.

> It projects that even for the lowest-income countries, the number of factory jobs will barely keep pace

with population growth over the next 30 years, and manufacturing is likely to remain a small part of most of these countries' economies.

Across all low-income countries, manufacturing jobs are projected to hold steady at below 8 percent of total employment, the study finds. It projects the share of manufacturing jobs in high-income countries will continue to fall, to 8.3 percent by 2050 from 11.4 percent currently.

It said that private service sector jobs will make up roughly 37 percent of global jobs by 2050, and 26 percent in today's low-income countries, up from about 12 percent cur-

The researchers also warned that as the world economy becomes even more dominated by service jobs, barriers to migration will pose just as much of a problem to growth as barriers to free exchange of goods once did.

"The world economy in 2050 is going to be even more dependent on service-sector jobs than it is today, which means we're all going to be even more dependent on migration than we are today," said Kenny.

"The easiest way to ensure we live in a poorer world would be to prevent people from moving where the jobs

## Shaanxi province: Inspiring economic progress of modern China

IN just ten years after China had realized the new development era to its fullest, in line with the Belt and Road Initiative (BRI) implementation, Shaanxi province has recorded a remarkable milestone in economic development.

The province whose capital city is Xian, is unfolding the magnificent progress and inspiring China's history, legacy and lifestyle in the modern times.

According to the report by the Information Office of Shaanxi Provincial Government as at the end of December 2022, the province has achieved major transformation during the past ten years in the area of small and medium-sized enterprises among other sectors.

The report shows that Shaanxi's added-value output of industrial enterprises expanded by 7.1 percent year-on-year thus contributing to the country's status of holding a second position as the global economic giant.

The report shows that the province's added value of strategic emerging industries accounted for 12 percent of the gross domestic product (GDP), 0.9 percentage points higher than that of the previous year, a year-on-year growth of 13.1 percent, 8.8 percentage points higher than the GDP growth rate.

"Taking the new energy automobile industry as an example, Shaanxi's automobile output in 2022 reached a record high of 1.338 million, ranking the top eight in the country for the first time," reads the

It asserts that in 2022, the province adhered to three aspects of reform in the transformation of scientific and technological achievements to amplify the effectiveness of Qinchuangyuan, an innovation platform of the province.

A total of 75 universities and institutes in the province have carried out the reform pilot, with 38,000 scientific and technological achievements under independent management and 3,449 scientific and technological achievements successfully transformed.

"The number of small and mediumsized enterprises in science and technology has increased by more than 40 percent, and 52 new national little giant enterprises have emerged, bringing the total number to 162," reads the report.

The report states that Shaanxi has made solid progress in the promotion of the so-called '3+X project' featured agricultural industries. 3 means the vigorous development of three industries represented by the apple industry, the animal husbandry represented by the dairy goat

industry, and the facility agriculture industry represented by greenhouse cultivation. On the other hand, X means making industries with distinctive local features better and stronger in line with local conditions such as medical material, walnuts and red dates to mention a few.

The report states that at present, the 3+X projects have yielded marked results with apple and facility agriculture output value exceeding 100 billion, goat dairy products accounting for 85 percent of the domestic market share.

On the way forward, the report states, Shaanxi will focus on the goal of building a strong agricultural province, and firmly uphold its position of building modern agriculture with distinctive local features.

Based on the construction of the whole industry chain in line with the Belt and Road Initiative (BRI), the province will strengthen the linkage among the province, cities, counties, towns and villages, making coordinated efforts in jointly building a modern rural industrial system with professional villages and strong industrial towns as the base, industrial parks as the driving force.

The other areas are establishing industrial clusters as the backbone, so as to achieve a tiered layout of the province and the coordinated advancement of dif-

"Shaanxi will continue promoting the high-quality development of featured rural industries with the apple industry as the focus, thus laving a solid foundation for the comprehensive revitalization of the rural areas and the modernization of the agriculture sector," states the report.

Generally, during 2022 the province's coal mining and washing industry grew by 9.2 percent, heat production and supply industries grew by 11.9 percent. The added value of non-energy industries grew by 5.8 percent with 23 of the 36 industries achieving positive growth.

In particular, the equipment manufacturing industry has maintained over 10 percent rapid growth throughout the year.

The electrical machinery which accounted for the relatively large proportion had increased by 29.2 percent while the automobile manufacturing industry grew by 21.3 percent.

Situated in the geographical center of China's territory, Shaanxi enjoys a unique location by connecting the south and north of China and linking the east and west of the country.



# BoT Academy, TADB launch agri-finance training programme

■ HE Bank of Tanzania (BoT) Academy and Tanzania Agricultural Development Bank (TADB) have jointly launched an agri-finance training programme meant to prepare individuals with prerequisite competencies required for improving the agricultural sector through financing.

Launched in Dar es Salaam yesterday, the training programme will prepare competent professionals to improve financing linkages between agri-value chain actors, financing institutions and other stakeholders in the industry.

Speaking during the official launch of the programme, the TADB Managing Director Frank Nyabundege said the philosophy behind development of the programme is producing innovative, creative, and positive-minded professionals in agricultural finance.

Nyabundege noted that the program will enhance and augment the technical capacity of banking professionals to understand and assess the opportunities and risks for lending to the agriculture sector with a view to support growth of credit and investments in agriculture to smallholder farmers and agri-SMEs.

"The training program is an important step towards fortifying the technical capabilities of our partner banks. Ultimately, this initiative will contribute to the increased provision of agricultural financing solutions to the agriculture sector,"he said

BoT Deputy Governor for Financial Stability and Deepening Sauda Kassim Msemo said banks and financial institutions are critical partners to the Smallholder Farmers Credit Guarantee Scheme operated by TADB, adding that they play a key role in providing financial products and services to support growth and scaling of the agriculture

However, lack of sufficient technical skills to support product design, transaction structuring and portfolio risk

management for agri-finance can act as a barrier to increased financing interventions in the agriculture sector.

"The capacity building of banking professionals to structure, screen, appraise and manage agri-finance transactions as well as building an understanding of technical, financial, commercial, policy and regulatory aspects of the agriculture sector has been identified as a key area for intervention," she elaborated

The Bank of Tanzania Academy and TADB designed the agri-finance training programme with the goal of enhancing the competencies of banking professionals engaged in agricultural financing.

"This, in turn, will enable them to better support smallholder farmers, cooperatives, and other stakeholders in the agricultural value chain. Moreover, the program aims to nurture future trainers within the banking sector," she

The facilitators of the program, including those from the BoT Academy, in collaboration with experts from Sokoine University of Agriculture (SUA) and St. Augustine University of Tanzania (SAUT), have conducted a comprehensive review and needs assessment, leading to the design of the training program.

Participants from 20 banks and financial institutions will embark on a one-week Fast Track (pilot) Training Pro-

Subsequently, a review process will be conducted, and necessary improvements will be implemented based on feedback received from the participants and other stake-

Following the pilot phase, a full-fledged certification program, known as "The Certified Professional in Agricultural Finance (CPAF)," will be initiated.

This will be followed by a "Training of Trainers (ToT)" program to ensure the sustainability of the program and its ability to meet the demand from the supply side effec-

HE World Standards Day was commemorated recently with a call for countries to join hands in strengthening efforts to raise awareness on the importance of standards and their role in making the world a better

Celebrated each year on October 14, the day is an important platform for recognizing the efforts by experts worldwide in developing technical agreements (international standards) which have a significant impact on businesses, governments, and consumers worldwide by ensuring product quality, safety, promoting international trade, and protecting the environment, public health,

WSD is an important event that highlights the significance of standardization in the global economy. The theme for 2023 was 'Shared Vision for a Better World', focusing on the Sustainable Development Goals (SDGs) to address social imbalances, develop a sustainable economy, and slow the rate of climate change by 2030.

United Nations Industrial Development Organization (UNIDO) recognizes and promotes standards because of their importance in boosting domestic, regional and international trade, while ensuring consumer protection and environmental sustainability.

Over the years, in line with its mandate of enhancing industrial development worldwide, UNIDO has helped many countries, including Tanzania, to integrate into the global economy by meeting regulatory and market requirements and strengthening related national capacities.

This includes the improvement of production processes, value chain development, meeting compliance requirements leading to better market access, use of renewable, clean energy and many other aspects.

This way UNIDO has helped Tanzania to improve production, quality and safety of its products, promoted MSMEs development with the aim to create more jobs, improve livelihoods through the enhancement of domestic and international commerce.

QUALITAN aims to build the capacity of TBS conformity assessment services by improving its conformity assessment services (testing, calibration, inspection, and certification). This translated to strengthening of human resources at TBS, enhancing the scope of accreditation of TBS laboratories and inspection services and certification of management systems. This will allow MSMEs to access internationally recognised compliance requirements at an affordable price and improve the efficiency of TBS in delivering conformity assessment services.

The project is also improving MSMEs' compliance to standards where TBS is supported to improve process with the ultimate goal to increase the level of compliance in Tanzania, thereby increasing market access opportunities.

through Besides, enhancement of the TBS' Information and Communication Technologies (ICT) systems, the QUALITAN project provides modern and scalable digital transformation of TBS' standards development processes and an effective traceability of its Quick Response (QR) code/mark. In addition, the QUALITAN project supports TBS to implement a Laboratory Information Management Systems (LIMS), integrated with its already existing Standardisation, Integrated Quality, Metrology and Testing (iSQMT) system that will lead to a more efficient, error free delivery of TBS' testing and calibration services and facilitate in the collection, use and sharing of data with other government institutions in Tanzania, as well as the private

Furthermore, TBS' project governance and outreach capacity is expected to be improved by building the capacity for outreach by designing and implementing awareness raising campaigns to reach out to TBS customers with a special focus on MSMEs and the general public.

UNIDO's focus on MSMEs is largely due to the role these enterprises play in developing economies, with because of their great potential to lift up millions of people out of poverty. MSMEs have a huge impact in the improvement of peoples' standards of living, overall economy, and job

Estimates show that above 95 per cent of businesses around the world are MSMEs accounting for nearly 60 per cent of jobs in the private sector, while contributing to over 60 per cent of the Gross Domestic Product (GDP) and over 70 percent of total employment in low-income countries. Such figures are undisputable and as such, support to MSMEs is a critical link towards economic growth and

Tanzania's Development Vision 2025 highlights the MSME sector as one important contributor to the country's long-term development objectives. It is estimated that 95percent of the businesses in Tanzania are MSMEs contributing about 35percent to the country's GDP.

However, exporters particularly MSMEs from developing countries including Tanzania, face challenges to conform to requirements, more importantly, prove compliance to these requirements through internationally acceptable the standards development conformity assessment services, hence are often not able to access lucrative markets or get top price for their products.

The Government and other stakeholders have taken various measures to establish regulatory bodies, strengthen the quality infrastructure (QI), and pass policies and regulations in order to comply with international quality and standards.

UNIDO has also developed various tools to measure the QI of a country. One such tool is the index, known as Quality Infrastructure for Sustainable Development (QI4SD) Index, used to rank countries based on their quality infrastructure - which includes standardisation, accreditation, conformity assessment, metrology and policy - contribution to the People, Planet and Prosperity pillars of the Sustainable Development Goals (SDGs).

According to the latest Index, the United Republic of Tanzania is placed at the 16th position amongst sub-Saharan countries that were assessed. The country is ranked high for policy development and standardization but there is still a room to bolster its conformity assessment and accreditation services to rank even higher.

Such a tool may be used by decision makers within the walls of the Government to make informed decisions on where investment is needed to improve the overall ranking of the nation in terms of its quality infrastructure and development goals.

Ali Qazilbash is the Lead International Expert - Conformity and Assessment, QUALITAN project -

Tanzania has no problem with the present laws, but rather the challenge is the implementation of those laws of how to curb IFFs.

She has suggested that what is needed is for the country to increase efforts of collaborating with other countries that would enable them get more information about IFFs practices.

"We need to enter contracts with those countries. There should be proper systems on how to exchange information between one country and another."

According to her the reasons that lead many companies engage in IFFs are due to the fact they get their money illegitimately; through tax evasion and by sending money to countries where they entertain tax havens.

Kawishe further mentioned some of the impacts of IFFs to a nation's economy as: Loss of revenues to a country; government failure to provide social services to its people; create huge gap between the haves and have

According to Kawishe, IFFs refer to the movement of money that is illegally

Senior Lecturer Nora Kawishe said earned, transferred, or utilized. This flow of money is in violation of laws in their origin, or during the movement or use and is therefore considered

There are various forms of IFFs. These include but not limited to: Tax avoidance, this is taking advantage of the loopholes of the law to avoid tax or to minimize tax liability.


Senior Lecturer in economics, finance and research, Catholic University of Mbeya, Dr Barozi Morwa has called for the establishment of a politically exposed person law.

### Small farmers in co-operatives to benefit from agriculture financing

SMALL scale farmers in the country have been urged to join cooperatives in order to access loans issued by the Tanzania Agricultural Development Bank (TADB) easily, to transform farming from subsistence to commercial.

The call was made yesterday by TADB Acting Director of Planning, Policy and Research, Mkani Waziri holder Guarantee Scheme, Wholesale during a meeting with 10 rice lending and Co-financing as a means farmers from AMCOS Tabora-Igunga to amass funds that will advance its representing 970 who have received training on commercial agriculture and received tractors and combined harvesters.

The beneficiaries are scheduled to travel upcountry in an exchange visit to other regions, where they can learn from other farmers on how they have benefitted from TADB's training and financing.

Mkani stated that a large number of small-scale producers have not joined local cooperative societies which makes it difficult for the agro-lender to reach out and support them.

"The country has a lot of smallscale farmers who have not joined the cooperative societies. Last year, population census showed that more than 90 percent of farmers are smallscale. If they join the cooperatives, it will easy for us to support and train them, instead of individuals," he said.

Mkani noted that TADB's main objective is to see that farmers achieve the capacity to move from subsistence production to modern commercial farming in a bid to ensure Tanzania's food security is assured and to alleviate poverty through agri-

"Our key mission is to revolutionize the agricultural sector through transforming the sector from subsistence-based production to commercial production. Another objective is to address poverty and garner economic development, he added.

TADB has been using three approaches to ensure farmers get access to loans through the Smallinitiatives to revolutionize Tanzania's agricultural system and productive capacity.

Speaking on behalf of the beneficiaries of the training program, Ramadhan Muna, the Chairman of the Mwamapuli Cooperative Society in Igunga, Tabora region thanked TADB for supporting farmers and commended the lender for issuing asset loans which also act as collateral unlike other financial institutions.

"On behalf of all farmers I would like to thank TADB for supporting us and I would like to also commend you for issuing asset loans which also double as collaterals unlike other banking institutions which demand loan applicants to provide other forms collaterals. I am sure since collateral is the loan itself no one incapable of paying the loan. Unless, there is poor supervision and management," said Muna. On his part, the TADB's Head of Legal Affairs, Edson Rwechungura, said the bank strives to ensure Tanzania has food security by ensuring farmers continue producing food that is why they issue loans to farmers so they can access quality incentives for production.

## Global efforts needed in waging war against illicit financial flows corruption; commercial tax evasion, trade mis-invoices and abusive

The joint global effort between governments and the people is crucial in the fighting against Illicit Financial Inflow (IFF).

This advice was observed recently by Tax Network Africa's Policy Advisor Francis Kairu, during insightful discussion on addressing IFFs through X space organized by Policy Forum.

He said that it was difficult to make businesses in a single country without involving other countries.

"For instance you cannot export goods from Tanzania to other countries, like China or any other country without collaborating with other traders," he said.

Thus, the systems that are used to send money from within the country to those countries, through either banks or mobiles, are

sometimes used in transacting illicit finance. Kairu mentioned other ways that can be used for IFFs are such as: Through exporting minerals like gold; money obtained through

# Stocks muted by Middle East conflict, central bank meetings

**SYDNEY** 

ASIAN share markets were mixed on Monday as Israel's push into Gaza stirred fears of a wider conflict ahead of central bank meetings in the United States, Britain and Japan, the latter of which might see a policy tightening.

The earnings season also continues with Apple, Airbnb, McDonald's, Moderna and Eli Lilly & Co among the many reporting this week. Results so far have been underwhelming, contributing to the S&P 500's retreat into correction territory.

"The price action is bad as SPX could not defend a key 4,200 level; risk is it heads to the 200-week moving average of 3,941 before a trading rally," BofA analysts said.

S&P 500 futures did edge up 0.4 percent on Monday to 4,153.5, while Nasdaq futures added 0.5 percent. EUROSTOXX 50 futures slipped 0.1 percent and FTSE futures gained 0.2 percent.

Risk appetite was dulled by Israel's push to surround Gaza's main city in a self-declared "second phase" of a three-week war against Iranian-backed Hamas militants.

MSCI's broadest index of Asia-Pacific shares outside Japan eased 0.04 percent, having hit a one-year low last week. Chinese blue chips firmed 0.6 percent.

China Evergrande Group's shares fell as much as 23 percent in the morning session, though later trimmed losses to 5 percent after Hong Kong's High Court adjourned a request to wind up the embattled property

Japan's Nikkei fell 0.95 percent amid speculation the Bank of Japan (BOJ) might tweak its yield curve control (YCC) policy after its two-day policy meeting wraps up on Tues-

Many analysts expect the central bank will lift its inflation forecast to 2.0 percent, but are unsure whether it will finally abandon YCC in the face of market pressure on bonds.

"Remaining uncertainty about the wage outlook, combined with stresses in global bond markets could prompt the BOJ to err on the side of caution, making our view that YCC will be scrapped a very close call," said analysts at Barclays.

"The BOJ could still opt to revise policy but less drastically, perhaps by raising the ceiling for 10-year yields as it did in July.'

Yields are already at their highest since 2013 at 0.89 percent and abandoning YCC altogether would likely add to pressure on global markets already bruised by a vicious sell-off in US Treasuries.

FED ALL DONE?

Yields on 10-year Treasuries stood at 4.8751 percent on Monday, having climbed 30 basis points so far this month and touched 16-year peaks at 5.021 percent.

Sentiment will be tested further this week when Treasury announces its refunding plans, with more increases likely. NatWest Markets expects \$885 billion of marketable borrowing in the fourth quarter and \$700 billion in the following quarter.

The sharp rise in market borrowing costs has convinced analysts the Federal Reserve will stand pat at its policy meeting this week, with futures implying a full chance of rates staying at 5.25-5.5 percent.

The market has also priced in 165 basis points of easing for 2024, starting around

"The Fed appears to have coalesced around the view that the recent tightening in financial conditions led by higher long-term interest rates has made another hike unnecessary," said analysts at Goldman Sachs, who estimated the rise in yields was the equivalent of 100 basis points of rate increases.

"The story of the year so far has been that economic reacceleration has not prevented further labor market rebalancing and progress in the inflation fight," they added. "We expect this to continue in coming months."

### US has 'absolutely no intention' of sending troops to Israel or Gaza - Kamala Harris

**DELAWARE** 

UNITED States Vice President Kamala Harris stressed that Washington has "absolutely no intention" of sending troops to Israel or Gaza amid the ongoing conflict, CNN reported on Sunday.

"We have absolutely no intention, nor do we have any plans, to send combat troops into Israel or Gaza, period," Harris said in an interview with CBS' "60 Minutes" that aired on Sunday when asked about the potential for US troops to be drawn into a war in the region.

Harris (pictured), who has been engaged in discussions and phone conversations concerning the Middle East crisis, expressed full support for the government's plans. Harris said that she supports Israel's right to defend itself while also advocating for the protection of civilians, as reported by CNN. "By most estimates, at least 1,400 Israelis are dead. Israel, without any question, has a right to defend itself," she said.

"That being said, it is very important that there be no conflation between Hamas and the Palestinians. The Palestinians deserve equal measures of safety and security, self-determination and dignity, and we have been very clear that the rules of war must be adhered to and that there be humanitarian aid that flows," CNN quoted Harris as saying.

Earlier on Sunday, US President Joe Biden spoke with Israeli Prime Minister Benjamin Netanyahu and discussed the developments in Gaza.

Biden reiterated that Israel has every right to defend its citizens from terrorism. The two leaders discussed ongoing efforts to locate and secure the release of hostages. Biden underscored the need to immediately and significantly increase the flow of humanitarian assistance to meet the needs of civilians in Gaza.

Amid concerns about the conflict spreading beyond Gaza, Harris also repeated Biden's warnings to Iran not to get involved.

"Don't," she said. "One word. Pretty straightforward."

Regarding questions about the possibility of President Biden not completing his term and who might replace him, Harris stated that she wouldn't engage in "hypotheticals" and affirmed her focus on the job at hand. "I'm not going to engage in that hypothetical because Joe Biden is very much alive and running for reelections," she said.

"I hear from a lot of different people, a lot of different things. But let me just tell you, I'm focused on the job. I truly am. Our democracy is on the line. ... And I, frankly, in my head do not have time for parlour games when we have a president who is running for re-election. That's it," Harris

### Events in Makhachkala were largely provoked from outside – Kremlin

THE events at Makhachkala airport were largely a result of outside interference, including external information influence, Russian Presidential Spokesman Dmitry Peskov has told the media.

"It is well known and obvious that yesterday's events around Makhachkala airport were largely a result of external interference, including information influence from outside," he said.

Peskov (pictured) noted that against the background of television footage showing the horrors of what was happening in the Gaza Strip - the deaths of civilians, children, elderly people and medics - "it is very easy for the ill-wishers to take advantage of the situation for provocations and instigation."



Peskov pointed out that Russian President Vladimir Putin had always paid and continued to pay unflag-

ging attention to these issues.

"Last week alone he held a thorough discussion with the leaders of Russia's confessions, where this topic was also discussed," Peskov recalled.

On October 29, mass unrest broke out at Makhachkala airport over the arrival of a regular flight from Tel Aviv amid the soaring tensions in the Middle East.

A crowd of several hundred entered the airport building and the airfield. Later they were driven back

According to the latest data, more than 20 people, including police officers, were injured and 60 rioters were detained.

The Dagestani authorities and clergy condemned the incident as a provocation.

# ICC prosecutor: Impeding aid to Gaza may be a crime

CAIRO/AMMAN

IMPEDING relief supplies to Gaza's population may constitute a crime under the International Criminal Court's (ICC) jurisdiction, the court's top prosecutor told a news conference in Egypt on Sunday.

Karim Khan (pictured) also said Israel must make "discernable efforts, without further delay to make sure civilians receive basic foods, medicine".

Aid supplies to Gaza have been minimal since Israel began bombarding the densely populated Palestinian enclave in response to a deadly attack by its ruling militant group Hamas on

Israeli officials have said that food, water and medicines have been coming in through the Egyptian border and that it expected the quantities to

United Nations officials have said the aid supplies are limited and do not correspond to the huge need on the ground.

In an unannounced visit, the ICC prosecutor went to the Rafah border crossing between Egypt and Gaza earlier in the day and posted a video statement from his location on X so-

Khan said he was not able to get into Gaza but hopes to visit the Gaza strip and Israel while he is in the re-

The court has been investigating in the occupied Palestinian territories since 2021, looking into possible war crimes and crimes against humanity

there from 2014 onwards. Israel, which is not a member of the ICC, has previously rejected the court's jurisdiction and does not for-

mally engage with its investigations. Khan has previously said that the ICC has jurisdiction over alleged war crimes and crimes against humanity during both the Oct 7 Hamas attack in Israel and in the territory of Gaza.

Also on Sunday, thousands of Gaza residents broke into UN warehouses, grabbing flour and other essential items in a sign they had reached "breaking point", the United Nations Relief and Works Agency (UNRWA) for Palestine Refugees in the Near East said.

One of the warehouses, located in Deir al-Balah in central Gaza, is where UNRWA stores supplies delivered by humanitarian convoys crossing into Gaza from Egypt.

Footage from Khan Younis in southern Gaza showed men frantically carrying boxes and large bags out of a warehouse, hoisting them onto their



shoulders or loading them onto their bicycles. UNRWA's director of communications Juliette

Touma said the organization had been forced to reduce the scale of its humanitarian operation in the densely populated enclave because it could not distribute fuel to some medical facilities. She gether immediately to deliver ursaid UNRWA had not received any additional supgent humanitarian aid to Gaza. plies on Sunday.

"We are asking for a standard and regular flow of humanitarian supplies, including fuel, and an increase in the number of trucks on these convoys," said Touma.

UNRWA has said its ability to help people in Gaza has been completely stretched by air strikes that have killed dozens of its staff and restricted the movement of supplies.

"Fifty-nine colleagues at UNRWA were killed during the war," Touma said.

Meanwhile, Egyptian President Abdel-Fattah al-Sisi and US President Joe Biden on Sunday agreed on the need to increase aid sustainably to Gaza.

During a phone conversation, the two presidents agreed that the aid should enter Gaza in a tangible, effective, and sustainable manner and in quantities that meet the humanitarian needs of the Gazan people, according to a statement from the Egyptian presidency.

Al-Sisi stressed Egypt's firm position of rejecting the policies of collective punishment and forced displacement, reiterating that Egypt will never allow the displacement of the Palestinians from Gaza to Egyptian territories.

For his part, Biden confirmed that the US rejects the displacement of the Palestinians outside their lands, expressing appreciation for the positive role Egypt has played in addressing this crisis.

They also touched on prospects for joint cooperation to mobilize international efforts toward reviving the peace process, with the aim of impleian values and respecting the menting the two-state solution and establishing a lives of civilians. **Xinhua**

# Musk speaks to Israeli security chief on providing Internet in Gaza

TESLA CEO and 'X' owner Elon Musk spoke to Israeli security agency Shin Bet's head Ronen Bar about providing internet in the war-torn Gaza via Starlink satellite network, Israelbased tech news website, mobile. mako reported.

This development came a day after Musk's announcement of providing internet access created an uproar.

"Starlink will support connectivity to internationally recognized aid organizations in Gaza," Musk posted on X on Saturday.

After sparking controversy, Elon (pictured) Musk contacted Ronen Bar, the chief of Shin Bet, within the last 24 hours. During their conversation, Musk emphasised his support for Israel and asserted that the connection would be "only for humanitarian pur-

"We are not so naive. Per my post, no Starlink terminal has attempted to connect from Gaza. If one does, we will take extraordinary measures to confirm that it is used \*only\* for purely humanitarian reasons. Moreover, we will do a security check with both the US and Israeli governments before turning on even a single terminal," Musk added in a subsequent post.

He further stated his intention to conduct security checks in coordination with both the US and Israeli governments before activating any terminals for his Starlink satellite network.

The head of Shin Bet firmly conveyed that Israel would not permit any misuse of this communication channel by terrorist elements in Gaza, mobile.mako reported

Furthermore, Musk stayed in touch with officials in Netanyahu's office, whom he had met about a month ago in the United States

In his conversation with them, he emphasised that he is "not in a hurry to activate satellite communication in Gaza," and asserted that if this were to happen, it would be subject to American supervision and the oversight of the Israeli security establishment.

Earlier, Israeli Communications Minister Shlomo Karhi criticised Musk's idea of providing internet access in Gaza.

"Israel will use all means at its disposal to fight this. HAMAS will use it for terrorist activities. There is no doubt about it, we know it, and Musk knows it. HAMAS is ISIS," Karhi wrote, adding. "Perhaps Musk would be willing to condition it with the release of our abducted babies, sons, daughters, elderly people. All of them! By then, my office will cut any ties with Starlink.



# Somalia approves 1-bln-USD budget for 2024

THE Somali cabinet has approved a 1.03-billion-U.S.-dollar budget for fiscal year 2024 to finance various development projects in the country.

Prime Minister Hamza Abdi Barre said the budget, which was approved by the cabinet during an extraordinary meeting held in the national capital of Mogadishu on Saturday night, will boost security, social services, and debt relief.

"The government's budget this year has reached more than 1 billion dollars, which has come from the domestic revenue that has increased by more than 20 percent, and it focuses on national security and the development of social services," Abdi said in a statement released Saturday.

The budget will be introduced before the parliament for consideration.

The prime minister, who chaired the cabinet meeting, said the budget reflects the needs and circumstances of the country, adding that more funding will be realized after the country receives debt relief in December and be able to provide more services to Somali citizens.

Somalia is expected to receive full debt relief from the International Monetary Fund (IMF) and other lenders in December, following significant reforms to improve domestic revenue collection and transparency in public

finance management. Laura Jaramillo, who led the IMF staff that met with Somalia's finance minister and the governor of the Central Bank of Somalia in September, said despite the challenge, Somalia has met almost all the conditions to qualify for full debt relief.

portant right now." 'We have gathered the best people from all branches of the defense establishment, for this specific mission. You have all seen who Hamas is - there is nothing more important than re-

turning the hostages and eradicating Hamas." "Our activities on the ground are linked to the efforts to return the hostages," added Gallant. "If Hamas does not feel military pressure, nothing will move forward. They seek the collapse of Israeli society from within, and are using the hostages

in a brutal manner. The military operation is intended, among other things, to increase the chance of returning our people." Meanwhile, the Israeli military ground operations inside Gaza continued through the night, with the Israel Defense Forces saying soldiers killed "dozens" of terrorists who had barricaded themselves inside buildings and tunnels and tried

to attack troops. The IDF said that in one incident, a drone struck a building belonging to Hamas with more than 20 of the terror group's operatives inside.

Also overnight, an Israeli fighter jet struck an anti-tank missile launching post in the area of Al-Azhar University in the northern area of the Strip.

JOGGING groups in Tanzania have been asked to actively participate in the fight against sexual corruption to protect girls from such corruption so that they can fulfill their dreams in education.

Dar es Salaam's Tandale Ward Councilor, Abdallah Said, issued the call when speaking to the groups after finishing jogging in the city yesterday.

The race was organized by the nongovernmental organization sensitizing communities on gender issues (WAJIKI), in collaboration with boda boda, bajaj, and daladala drivers.

Speaking on behalf of the councilor, his secretary Muhidin Mtengeleka said jogging groups have a great chance to mobilize the

fight against sextortion, as they involve young women and men. "I thank WAJIKI for bringing the jogging groups from the Makumbusho Ward to us to mobilize this fight, and I ask you to be in the front line to do this work because sexual corruption is rampant in many areas," Mtengeleka stated.

Janeth Mawinza, WAJIKI's Director, said they have been running the campaign, termed 'Safari Salama Bila Rushwa ya Ngono Inawezekana', with the funding of Women Fund Tanzania (WFT).

"We have decided to include jogging groups as there are indicators of corruption (in such groups), that is why we are now collaborating with some jogging groups," Janeth stated. The director said despite the success they continue to achieve in the drive, they are still facing the challenge of a lack of sponsors since they only have one namely WFT.

She mentioned another challenge as the lack of an area for accommodating victims of acts of sexual violence including sexual corruption.

"There is also a lack of parenting skills among parents, guardians, and society in general, it is a problem, as some of them end cases quietly instead of bringing them to the legal authorities," Janeth said.

Janeth said that the act leaves the victims permanently affected psychologically while the suspects roam the streets.

"Despite that, we thank the government for various efforts it is making to a eradicate gender-based violence in the country," she said.

# Man City cruise against Man **Utd exposes gulf in class**

MANCHESTER City once feared a trip to Old Trafford but painted the town blue once more with a 3-0 victory over a demoralised United on Sunday to reassert their dominance.

A double from Erling Haaland before Phil Foden tapped home a third took Pep Guardiola's men nine points clear of United just 10 games into the Premier League season.

Not since United last won the league in Alex Ferguson's final season in charge, in 2012/13, have the Red Devils finished above their local

That run looks destined to go on for another season, with the clubs worlds apart on and off the pitch.

The travelling City support taunted the home fans with chants expressing the hope that United's unpopular owners, the Glazer family, would remain for "10 more years".

Initial optimism among the United fanbase that the Americans would sell the club they have controlled since 2005 looks likely to have been misplaced, with British billionaire Jim Ratcliffe set to settle for a minority stake after a year of negotiations.

United's demise under the Glazers has coincided with the rise of City as the dominant force in English football, thanks to backing from Abu Dhabi's Sheikh Mansour. But money is not the only reason for the disparity in the performances of both clubs.

United have outspent City in the transfer market in recent years but have wasted millions in the process.

Despite his side's struggles to score goals this season, United boss Erik ten Hag left expensive attacking talent in Antony and Mason Mount on the bench on Sunday. By contrast, City have a slick operation behind the scenes to match their football.

Guardiola cut short his successful managerial spells at Barcelona and Bayern Munich but is now into his eighth season at the Etihad.

"I know what we have done. I didn't expect it," he said when asked if he had envisaged the change in fortunes for the clubs after his seventh vear. win at Old Trafford as City boss.

"I said many times we are in the same direction - the chairman, sporting director, manager and the players, we go there. When we lose or things aren't going well we don't find blame for someone. We work out what we have to do better and find solutions.'

Finding solutions for a season that threatens to spiral out of control is now Ten Hag's job.

The Dutchman enjoyed plenty of plaudits for his first season in charge as he returned United to the Champions League and ended a six-year trophy drought by lifting the League

However, after another period of heavy investment in the summer transfer window, United have gone backwards at an alarming rate.

A return of five defeats from their opening 10 league games means the club have made their worst start since 1986/87, while they are also in severe danger of failing to make the Champions League knockouts.

Ten Hag's decision to replace striker Rasmus Hojlund was met with a chorus of boos for the second time this season by the Old Trafford crowd and thousands marched out after Foden's goal 10 minutes from

"It's different levels," said former United midfielder Roy Keane. "The United players are just short in every aspect, technically and tactically. It's a long way back for this team."

Frustration towards the Glazers has largely shielded Ten Hag from criticism so far. But questions are beginning to be asked of the former Ajax boss, with United languishing eighth in the table, eight points adrift of the top four.

Catching City already looks an impossible task as Guardiola's side target another historic landmark.

Fresh from matching United's crowning glory under Ferguson by winning the Premier League, Champions League and FA Cup in the same season, City are now aiming to become the first side to win the English top flight for a fourth consecutive

This was another one-sided encounter between the city rivals, which only confirmed the ongoing dominance of Pep Guardiola's defending Premier League cham-

A 3-0 win on Sunday did not do justice to City's superiority in a game that required Andre Onana to keep Erling Haaland down to just two goals on a day when the Norwegian also provided the assist for Foden.

"It looks easy but it is not. It really, really is not," said Guardiola. "(I have) a lot of respect for United for what they do, but we were at our best, especially in the second half."

On a rainy Manchester day, it was an all too familiar outcome as City eased to victory against the club that was for so long the dominant force in English soccer, with a record 20 league titles.

It is now 10 years since United won its last league championship, while City has lifted the title seven times since being backed by Abu Dhabi's ruling family in 2008. Guardiola has delivered five titles in six years and last season led the club to a treble of trophies the Premier League, Champions League and FA Cup.

Erik ten Hag was supposed to close the gap between the teams when hired in 2022, but after a humbling derby loss, it feels as though the distance is widening.

United has lost seven games in all competitions this season, with this latest defeat leaving it eight points off the Champions League

Ten Hag, however, tried to offer words of optimism to fans who have repeatedly booed during home games this season and jeered his decision to substitute

VILLA CHALLENGE

Aston Villa may be an unlikely Champions League challenger this season as its impressive form under Unai Emery continues.

A team that looked in danger of being relegated before the Spanish coach took charge last year is just one point off fourth-place Liverpool after 10 games. Villa beat Luton 3-1, with John McGinn and Moussa Diaby on the scoresheet. Tom Lockyer's own-goal added a third before Emiliano Martinez also put through his own net to hand Luton a consolation.

Evan Ferguson's reputation keeps growing and he scored his fifth goal of the season in Brighton's 1-1 draw with Fulham, which saw Joao Palhinha score a stunning equalizer from the edge of the box. DIAZ SUPPORT

### Colombian army searches for Liverpool winger Diaz's kidnapped father

**BOGOTA** 

MORE than 120 Colombian soldiers backed by police searched Sunday for the father of Liverpool winger Luis Diaz, kidnapped with his wife, who has since been rescued.

The army said in a statement it had set up roadblocks and deployed two motorized platoons, unmanned aircraft, helicopters and a plane with radar in the search for Luis Manuel Diaz. Colombian authorities did not provide details about the kidnapping, but

media reported the footballer's father and mother Cilenis Marulanda were taken Saturday by armed men on motorcycles at a gas station in their home town of Barrancas in the northern La Guajira department.

President Gustavo Petro said Marulanda was rescued in Barrancas hours after the couple was taken.

Attorney General Francisco Barbosa told a press conference Sunday that Diaz "could be" in Venezuela, without elaborating.

The motive for the kidnapping has not been divulged.

"We are desperate, we are distressed, we know nothing about him," Olmer Diaz, the kidnapped man's brother, told AFP in Barrancas, urging his "prompt release."

Colombia is a country just emerging from decades of civil conflict between rival armed groups that has seen more than 38,000 people kidnapped over the years, mostly for ransom.

Petro, at an event to mark the start of local elections in Bogota, said "all the public forces have been deployed" to find Diaz's father.

Luis Manuel Diaz was an amateur coach at the only football school in Barrancas, a town of about 38,000 inhabitants near the Venezuelan border, where his son showed promise from a very young age.

His father is credited with aiding the meteoric rise of the Liverpool and Colombia striker known as "Lucho."

Diaz, a 26-year-old Wayuu Indigenous man, has not spoken out about the

In his Colombian hometown, resident Leonardo Diaz, 41 (no relation), told AFP he was "sad and dismayed" by the kidnapping of a man he described as "a humble person of the people."

The footballer's Liverpool teammate, Portugal's Diogo Jota, dedicated his goal in a Premier League clash Sunday against Nottingham Forest to Diaz, who did not play. In celebration, Jota ran to manager Jurgen Klopp, who handed him Diaz's shirt, which he held aloft to applause from Liverpool fans. Colombian police have offered a reward equivalent to about \$48,000 for

Liverpool FC issued a statement Sunday saying it was "aware of an ongoing

situation involving the family of Luis Diaz" in Colombia.

"It is our fervent hope that the matter is resolved safely and at the earliest possible opportunity. In the meantime, the player's welfare will continue to be our immediate priority," it said.

Manager Klopp described it as a "worrying situation for all of us."

"We had to obviously make a late change because of the private situation involving Luis Diaz," he said ahead of Sunday's match. "It was a pretty tough night. I have never had that before. It's a new experience I never needed."
