THE Tanzania Horticultural Association (TAHA) has successfully openedup the main Parisian food market, a multibillion dollar spot for fresh vegetables and fruits serving the broad metropolitan area of the French capital.

Unlocking the Rungis market on the southern suburbs of Paris offers another sphere of expectations to horticulture producers across the country and especially in the northern zone, top officials said here at the weekend.

TAHA Group chief executive officer Dr Jacqueline Mkindi, who was on a working visit to France recently, signed agreements with key companies handling fresh fruits and vegetables at the internationally renowned market, connected with sales outlets all over

Rungis covers an area of 234 hectares and is widely seen as Europe's biggest fresh produce market, where around 1,200 companies serve approximately 18m consumers within the vicinity of the capital, with estimated sales of \$9.8bn per annum.

Officials in the Tanzanian embassy in Paris, also charged with links to Spain, Portugal and Morocco, organised the visit after prior consultations so that the CEO could have a successful tour and obtain several produce supply accords, the top executive indicated.

Ambassador Samwel Shelukindo linked TAHA with large French horticultural importers, exporters and dealers located at the market with a view to sealing supply deals for the companies to importing and market fresh produce from Tanzania, she said shortly upon return.

Tanzanian produce will be exported to Rungis market without strictures, adding to the nearly 1.2m metric tonnes of fruit and vegetables sold at the market annually, with the market accords being partly a result of President Samia Suluhu Hassan's brief visit in France, on the sidelines of a European Union-African Union meeting in Brussels.

President Samia engaged with the business community there, thus reinforcing their confidence in the Tanzanian private sector, prompting private sector stakeholders in both countries to forge business links, she further

TAHA group is presently identifying crop varieties to send samples for approval before commencing exports to take portions of the shelves at the Rungis market chain to fulfill its obligations under those accords.

By next month TAHA is supposed to commence exports of avocado, chili (peppers) and French beans to the

## Samia's first year: Govt talks of energy sector milestones

ONGOING efforts to restore confidence among rich countries and big investors worldwide have resulted in increased investment in Tanzania's energy sector, the government has affirmed.

Energy minister January Makamba made this observation in Dar es Salaam at the weekend, addressing reporters on major achievements of the government in the energy field during the year-long

leadership of President Samia Suluhu Hassan.

The president has opened up the country with investment opportunities in the energy sector and others, he said, underlining that for a fast country like Tanzania with a population growth

of nearly 60m people, having 1600 megawatts of electricity is unwarranted. "We need a wider power network with improved transmission services," he emphasised.

The energy sector investment forum during the Dubai Exhibition was an event geared at opening up the energy sector, with the personal attendance of the president, he asserted, hinting

ISTRICT commissioners and district executive directors have until the end of next month to deliver on the construction of health centres, dispensaries and hospitals, the government has cautioned.

Innocent Bashungwa, the Minister of State in the President's Office (Regional Administration and Local Governments), issued this directive here at the weekend in an inspection tour of Igawilo District Hospital being built within Mbeya city.

He said the construction pace in some districts was not satisfactory despite that adequate funds were provided to all areas, cautioning that the ministry was making keen follow-up of health centre building activity all over the country.

The first phase for the construction of 233 health centres in strategic areas was allocated money out of the government's own sources, about 58.2bn/- for the 233 health centres at the rate of 250m/- for outpatients' buildings, laboratories and incinerators, he said.

There are health centres that received the money from October to December and they are supposed to have completed construction by the end of next month, he stated.

District commissioners or directors failing to deliver on the projects by that time will face disciplinary procedures as by February 15 110 out of 233 health centres that received funds had completed their work and obtained the second installment of funds. That amounted to 27.5bn/- for construction of maternity wards, operation theatres, laundry and paths, he elaborated.

The government, in its 2021/22 development subsidy budget set aside 113.7bn/- for building 104 district hospitals, 66.3bn/- for finalizing construction work on hospitals where the building work began in 2018/19 and 2019/20 financial years, the minister specified.

Mbeya DC Dr Rashid Chuachua assured the minister that construction work on Igawilo Hospital will be completed end of April. Construction work wasp well above 90 per cent of total planned works, he added.

"This is a major breakthrough for our horticulture growers, as the market offers unlimited scope of exporting fresh produce all around the year, promising higher returns to smallholder growers," she declared.

TAHA group is also fine-tuning a contract with a strategically placed firm in France for an agreement to promote and brand Tanzania horticultural produce to ease penetration into other European markets.

The CEO visited a respected start-ups centre for mentoring young entrepreneurs to venture into agriculture, and reached accords for initiating plans involving Education and Agriculture ministries plus the private sector for Tanzania to take up the center's training model, she said.

She also set up crucial contacts with high-level experts who expressed readiness to conduct a survey of soil and climatic conditions for appropriate production of grapes, while engaging a well-placed French investor to take up joint venture with TAHA or other local firm to produce top class champagne for local and export markets.

"I had a fruitful interaction with the French councillor for agriculture and food in East Africa, Vicent Abdi, who will support TAHA Group in unlocking more potential markets and solve logistic challenges for fresh crop exportation," she

Ambassador Shelukindo said he saw great opportunity for our horticultural crops to access the Rungis market. "I moved swiftly to link up the TAHA CEO who was on official tour here. As it happened she signed several business deals with strategic fresh crops buyers for mutual benefits," he elaborated.

After successful journey in France, Dr Mkindi is looking up to Germany as her next stop with officials of ten horticultural produce and export firms to participate in the forthcoming Fruit Logistica, described as the world's premier fruits and vegetables fair, slated for Berlin.

"We are in touch with our Ambassador Dr Abdallah Possi who is working so hard to connect us with key buyers," she said, on her upcoming visit to Germany.

Netting the economy \$779m annually by current estimates, the horticulture industry offers Tanzania long-term potential of creating decent jobs, substantial foreign exchange earnings and further diminish poverty levels in rural areas, she added.

at consultations with potential investors expressing readiness to establish projects in power gen-

President Samia's presence at the forum provided a unique impetus, attracting over 400 participants from among the business communities of Tanzania and the Emirates, he stated, especially lauding efforts at speeding up work on the Julius Nyerere Hydro-

power Project (JNHP) at the scenic Stigler's Gorge site.

Since taking office, the president has prioritized funding the project, on the construction of infrastructure to load generated electricity on the national grid, he said, expressing confidence that the government is committed to address challenges in the sector, especially regarding rural electrification.

TANESCO, the utility concern, is in the process of major reforms

to improve its services, he stated, highlighting that the government is aware of the power supply reliability at present, asking the public to exercise patience as the ministry works on solutions to end power disruptions.

The ministry is targeting 100 per cent access to electricity countrywide by 2030, he said, underlining that of the various energy sources like thermal, hydro and some renewables, efforts are directed at

shifting from non-renewable to renewables sources of electricity.

Tanzania has indigenous energy resources as yet under-exploited for lack of planning, financial constraints and a poor transmission and distribution network, he stated. Increasing the share of renewable energy is in line with strategies to bring about an energy mix consistent with availability and reliability of power supply, he pointed out.

The latest power system master plan update for 2020o indicates that electricity demand is likely to expand at 13.82 per cent for 2022 to 2030 period, thus needing 10,176 GWh in 2022 rising to 28,664 GWh in 2030.

To meet this demand, around 6,200 MW of new generation capacity will be added to the national grid, with 71.5 per cent based on hydropower and renewable energy sources, he added.

## Education, health stakeholders call for sexual and reproductive health in school curricula

EDUCATION and health stakeholders have suggested the need to include sexual and reproductive health and rights (SRHR) in school curriculum to reduce teenage pregnancy, promote abstinence and prevent HIV/AIDS.

They made the call in Dar es Salaam recently when speaking at the official launch of a book dubbed; 'A study on Policy and Sexual and Rights Education in primary and secondary schools in Tanzania.

One of them is Dr John Kalage who stated that the findings recommended a curricula preview to the Ministry of Education, Science and Education (MoEST) and Health Ministry to attain a comprehensive knowledge on SRHR.

Dr Kalage who is also the HakiElimu executive director said: "Having questionable depth on SRHR education, the recommendations was to review the curricula from the frontline implementers thus MoEST 

Education (TIE) in collaboration with the Health Ministry to make them more comprehensive focusing on sexuality, human development, relationship, sexual health and its life skills linkage."

Dr Kalage also affirmed that the findings revealed few SRHR contents merged in subjects like biology, science and technology something that grounded the need to have a standout subject that will cut across sexual behaviors, health likewise its link in life generally.

"We noticed that SRHR is not taught as a standalone subject at the school levels, instead the contents are embedded in other subjects. For instance, in primary Puberty is taught as a subtopic in Biology had 83 percent, 76.8 percent of HIV/AIDS and 70 percent of Sexually Transmitted Infections and diseases (STD's)."

The data from Ministry of Health revealed plans on adding training materials from wards to district level as a way forward to implement

through the Tanzania Institute of The national accelerated action and investment agenda for adolescence health and wellbeing (NALA) 2020/21-2023/24) of which they thought MoEST had not addressed it enough.

> Permanent Secretary in the Ministry of Education, Science and Technology, Dr Eliamani Sedoyeka said the sector is entitled to fill a gap on SRHR education due to the arising challenges influenced with biological maturity and body changes hence leading to school dropouts.

> Dr Sedoyeka further said: "There has been more pressure on impacts of teen sex, pregnancies, and early marriages being an example forgetting the prior knowledge that would help reason on the long term effects upon the matter."

> He also said girls dropout of schools and universities after break up as their partners and decide to concentrate more for exams, adding that the forgotten gap is the revelation that studies and sexual affairs don't work together.

#### Shares by the govt in **Williamson Diamond Mining Company up** from 25 pct to 37 pct

THE government has successfully increased ownership of shares in Williamson Diamond Mining Company from 25 per cent to 37 per cent.

The government has also entered Joint Ventures (JV) owning 16 per cent in five companies which are to invest a total of 1.755trn/- namely Black Rock Mining Limited; Strandline Resources Limited; Petra Diamonds Limited; Nyanzaga Mining Limited and LZ Nickel Limited.

Speaking when addressing the media on the government achievements under President Samia Suluhu Hassan's one year in power, Treasury Registrar Mgonya Benedicto said there has been massive achievements in the mining sector. He said during the year, certificates of ownership for Faru Graphite Corporation, Sota Mining Corporation, Williamson Diamond Limited (Class A and Class B Shares), Nyati Minerals Limited as well as Tembo Nickel Refining Limited were signed and handed over to the government.

Benedicto further said his office also managed to implement article 123 which speaks of 'undilutable 16 percent Free Carried Interest.'

"The implementation of article 10 of the minerals Act allowed the government to own shares in mineral companies, it also allows increasing ownership of shares," he said.

Speaking on the payment of retired workers of the defunct East African Community (EAC), the treasury registrar said from March 2021 to March 2022, the government has paid 8.7bn/to retirees who did not start receiving minimum pension as per government notice of 2009 and 2015.

He said out of the amount, 1.77bn/have been used to pay 992 workers of the then Tanzania Railway Corporation (TRC), 798.62m/- for 267 workers of the Tanzania Postal Corporation (TPC), 6.2bn/- for 848 workers of the Tanzania Telecommunication Company Limited (TTCL) and 4.77bn/- was arrears for 636 workers from 2009 to March 2022.

"Donors cannot place their money directly to institutions that lack accountability, especially in regard to their board members, directors and managers," he said.


For his part, senior technical advisor in FH 360 said they empower civil societies which they work together with so that they become strong in the supervision projects especially the ones on HIV/Aids.


"We conducted initial training with financial supervisors to make sure they well manage the sensitive area and also we have established the administration in regard to counting financial management package," he explained.

#### Tanzania needs to help and create awareness about Down syndrome

is marked each year on March 21, beginning in 2006. The 21st day of March (the 3rd month of the year) was selected to signify the uniqueness of the triplication (trisomy) of the 21st chromosome which causes Down syndrome.

Every year on March 21, World Down Syndrome Day is observed to create awareness about Down syndrome.

It is a condition in which a child is born with an extra 21st chromosome. A chromosome is made up of proteins and DNA organized into genes. Each cell normally contains 23 pairs of chromosomes.

Down syndrome or Down's syndrome, also known as trisomy 21, is a genetic disorder caused by the presence of all or part of a third copy of chromosome 21. It is usually associated with physical growth delays, mild to moderate intellectual disability, and characteristic facial features. The average IQ of a young adult with Down syndrome is 50, equivalent to the mental ability of an eight- or nine-year-old child, but this can vary widely.

The parents of the affected individual are usually genetically normal. The probability increases from less than 0.1 in 20-year-old mothers to 3 per cent in those of age 45. The extra chromosome is believed to occur by chance, with no known behavioral activity or environmental factor that changes the probability. Down syndrome can be identified during pregnancy by prenatal screening followed by diagnostic testing or syndrome pregnancies are often aborted.

There is no cure for Down syndrome. Education and proper care have been shown to improve quality of life. Some childers.

WORLD Down Syndrome Day dren with Down syndrome are educated in typical school classes, while others require more specialised education. Some individuals with Down syndrome graduate from high school, and a few attend post-secondary education. In adulthood, about 20 per cent in the United States do paid work in some capacity, with many requiring a sheltered work environment. Support in financial and legal matters is often needed. Life expectancv is around 50 to 60 years in the developed world with proper health care. Regular screening for health problems common in Down syndrome is recommended throughout the person's

Down syndrome is one of the most common chromosome abnormalities in humans. It occurs in about 1 in 1,000 babies born each year. In 2015, Down syndrome was present in 5.4 million individuals globally and resulted in 27,000 deaths, down from 43,000 deaths in 1990. It is named after British doctor John Langdon Down, who fully described the syndrome in 1866. Some aspects of the condition were described earlier by French psychiatrist Jean-Étienne Dominique Esquirol in 1838 and French physician Édouard Séguin in 1844. The genetic cause of Down syndrome was discovered in 1959.

Those with Down syndrome nearly always have physical and intellectual disabilities. As adults, their mental abilities are typically similar to those of an 8- or 9-year-old. They have an increased risk of a number of other health problems, including congenital heart defect, epilepsy, leukemia, thyroid diseases, and mental disor-

The budget of 2022/2023 should focus on driving economic recovery, rebuilding national resilience and catalysing reforms across the private and public sectors.

The worst-hit sectors such as tourism and its related industries should be prioritised, while businesses will be encouraged to enhance their competitive edge and venture into new growth areas to build resilience and withstand future adversities.

To achieve the vision of recovering from the pandemic and becoming a prosperous, inclusive and sustainable nation, the government has to introduce the concept of co-operation and collaboration between stakeholders, irrespective of political affiliation or ideological differences. The existing procedures should be reviewed to promote efficiency in the public service, and enhance its quality to fulfil stakeholders' requirements.

In addition, the government should foster closer collaboration with various organisations to empower them to partake in national devel-

#### **World Day for the Elimination of Racial** Discrimination: More than meets the eve

MARCH 21 is the designated World Day for Elimination of Racial Discrimination, a date that resonates with an ominous racial discrimination horror of the Sharpeville massacre, on March 21, 1960. It was after demonstrating against pass laws, where an African had to get a local government 'pass' to enter into designated European or Indian areas in urban South Africa. A crowd of about 7,000 protesters went to the police station shouting or heckling, and the police started firing on the crowd.

Tallies of those dead or wounded vary or have never really been ascertained, but an influential account put the number of dead at 69 and the wounded well beyond 200 people. About 16 years later in similar circumstances, a large number of school children were killed in systematic shooting by police, when boycotting classes and demonstrating against the use of Afrikaans, instead of English, for teaching. They knew it was a language that would rob them of opportunities in life, in favour of Europeans and Asians.

The June 16 1976 incident, while based on racial discrimination like the Sharpeville massacre, is marked worldwide as the Day of the African Child, celebrating the right of children to have an education that gives them hope in life, and not just any education tailored by some authorities. This also means a lot for policy making just like the problem of discrimination, though the issue of discrimination is somewhat complicated. Often some people wish to be discriminated, that they be valued by other than civic criteria.

This isn't just a problem of some

groups say of a particular group recognising itself by some ties of kinship or religious denomination, wishing that all their members follow a particular structure of social obligations. On the contrary, there is a problem of demanding that the widest definition of civic values be observed everywhere, which is usually well intentioned by can't be swallowed by large numbers of people in other cultures. That is why defining discrimination, even racially speaking, is still problematic.

Prof Kombe added that by improving and investing in land management, governments can reduce transaction costs such as cost of doing business and check investment risks, increase investment attractiveness, adding that individuals can also make fortunes from value of their land or landed property if they or the state invests in land management.

However, Prof Kombe said it is a common knowledge that at present, local and foreign individuals and entities including investors wishing to acquire a piece of land to meet their basic needs for shelter or other requirements incur considerable costs in terms of time and cash because of various reasons including cumbersome protocols, unpredictable and opaque land governance systems such as ambiguous legal and or administrative frameworks.

He said over the years, research and practice have repeatedly highlighted weaknesses in several other areas of land management and these weaknesses are manifested in for instance weak or inappropriate institutions. ineffective land use planning systems and practices, low land registration and tilting, insecure land and property rights for particularly the poor in rural and urban areas and non-compliance with land development, laws and regulations among others.

In turn, Professor Kombe said these challenges contribute to lack of transparency and accountability, fostering corruption, adding that transparency International studies for many African countries including Tanzania have underlined the correlation between low incidences of corruption in the land sector and higher levels of foreign direct investments.

#### RTO urges drivers to go for regular training to curb accidents

KILIMANJARO Regional Traffic Officer (RTO) Michael Stephen has urged drivers to undergo regular training for sustainable road safety as well as reducing road accidents.

RTO Stephen made the call recently when speaking during the refresher road safety course that involved government drivers who are working at Kilimanjaro Regional Office and other public institutions.

The course was aimed at cutting down the rate of accidents that claim to be caused by reckless drivers. The RTO stated public vehicle drivers were leading in traffic offenses, which are caused by human errors, and speeding, that's it's important for drivers to undergo such training to address the challenge, which is costing people's lives and properties."Most of the government drivers are blamed for

leading in traffic offenses that's why my office in collaboration with the Kilimanjaro regional office and other stakeholders decided to have this road safety refresher course for you (government drivers) to remind you on road safety regulations," he said.

According to the RTO, the training entailed modern driving skills, road safety, and first aid skills.

One of the training facilitators, Inspector Francis Maneno said that most of the roads accidents are caused by reckless driving who don't abide by road regulations whereby 80% of accidents are caused by reckless drivers, 12% of the road accidents are caused by mechanical problems of the vehicles, 6% of the road accidents are caused by climate change, while only 2% of the road accidents are

caused by bad road infrastructure. "My appeal to all drivers particularly government drivers, and other road users is to abide by all road regulations to avoid unnecessary road accidents," he insisted.

### Don't risk our multi-billion-dollar pension fund in Wall Street, warn UN staffers

HE United Nations Joint Staff Pension Fund (UN-JSPF), which is expected to provide retirement, death, disability and related benefits for staff, upon cessation of their services- has a staggering portfolio amounting to over \$81.5 billion ranking far, far ahead of the UN's annual budget of \$3.1 billion and its average peacekeeping budget of over \$6.4 billion.

The thousands of UN retirees and their beneficiaries, numbering over 71,000 at last count, who depend on their pensions for economic survival, are relentlessly protective of the Fund-while protesting all attempts at risky investments.

The Coordinating Committee for International Staff Unions and Associations of the UN system (CCISUA), which represents over 60,000 staffers worldwide, is protesting a new proposed plan to "outsource a large part of the pension fund's investments to Wall Street".

In a letter to Pedro Guazo, Representative of the Secretary-General for the investment of UNJSPF assets, Prisca Chaoui, the CCISUA President warned last week that the proposed outsourcing "ultimately calls into question the nature of our pension fund."

"Is it one that continues to be managed prudently by experts employed by the fund, who by being UN staff have a stake in its long-term health, a system that employs the fund's economies of scale to keep down costs and that has by the fund's own telling outperformed the private sector up to now?" she asked.

"Or is it one that is outsourced to Wall Street to be the victim of a short-term get-rich-quick bonus culture with little regard to the welfare of beneficiaries around the world?"

been shared with us", says Chaoui, "we fail to understand the reasons behind the move to external management, given the unnecessary and costly duplication of internal capac-

"We also believe that your intention to "stop the bleeding" has been addressed by the management changes you have implemented in response to issues highlighted by the UN's Office of Internal Oversight Services (OIOS), and through a new Strategic Asset Allocation that significantly reduces our exposure to risky assets".

Given that the pension fund has access to the same financial instruments as Wall Street, and employs equally experienced investment officers, she argues, there should be

no reason for a lower performance. "Indeed, the pension fund's other portfolios have worked fine under internal management."

Meanwhile, a petition currently in circulation among retirees and UN staffers, says Secretary-General Antonio Guterres claims this is a temporary measure that will increase performance.

"However, the plans authorize an increase in outsourcing over a period of three years. And over the long term, our conservative, internally-managed UN pension fund has performed better than many externally-managed final salary funds that have since been forced to close. Indeed, our fund is in actuarial balance," says the petition seeking sig-

Responding to the ongoing protests, Pedro Guazo, Representative of the Secretary-General for the investment of UNISPF assets, said on 16 March the Fund is aware of additional concerns expressed on the temporary outsourcing of part of the fixed income portfolio.

"As presented at the last Pension Board meeting on 24-25 February 2022 (see here) and in my message of 12 March 2022, the investments of the UN Pension Fund are doing very well overall, given the current economic and geopolitical context."

However, argued Guazo, the Fund can do better in the fixed income portfolio. For many years that portfolio has underperformed against its benchmark, as outlined on the Fund's website here.

He pointed out that the Fixed Income Team of the Fund's Office of Investment Management put a proposal to manage part of the portfolio internally (35%) and, temporarily, using an external advisor under the supervision and control by the same internal team (65%).

This 65% of the fixed income portfolio represents around 18% of the total portfolio managed by the Office of Investment Management.

"This proposal has been reviewed by the in-

ternal committee, by the Pension Board and the Fund's Investments Committee, concurring this is a good temporary solution to raise the performance of the fixed income portfo-

lio. The use of temporary external advisors is

a best practice in the pension fund industry

to address underperforming asset classes,"

he noted. The immediate benefit for the UN Pension Fund, he said, will be additional USD 60 million a year in profits and this solution is only

temporary. When the team is ready in some months the Office of Investment Management will again manage the portfolio inter-

"I hope this clarifies the objective and the benefits of this operation, that will, again, be applied only for a limited time," he added.

Meanwhile, Ian Richards, former President of the CCISUA, told IPS following the launch of the union petition, "I've been inundated with messages from staff.

They are looking at what's happening on the markets right now and just don't think it's the time for Wall Street to be taking things

They're asking why now when the pension fund leadership has for years, and as recently as last autumn at the General Assembly, vaunted the advantages of safe, conservative in-house management. A lot of questions, including ones I have raised on this, remain unanswered." **IPS** 

## China's BeiDou system enters new stage of continuous and stable services, rapid development

MEASUREMENT data from the International GNSS Monitoring and Assessment System (iGMAS) show that the positioning, navigation and timing (PNT) services provided by China's BeiDou-3 Navigation Satellite System have recorded high performance indicators worldwide and reached particularly high levels in the Asia-Pacific region, which signifies that China's vision of making its BeiDou Navigation Satellite System (BDS) a first-class system that benefits the entire world is becoming a reality, according to the China Satellite Navigation Office.

The system has entered a new stage featuring continuous and stable services and rapid development, said the

Since it was formally commissioned on July 31, 2020, the BeiDou-3 has been in smooth operation and provided high-quality services for global users. While ensuring the system's stable functioning in all weathers, China has continuously optimized its performance and expanded its application modes.

The country plans to launch new satellites to further improve the system's operational stability and reliability, and test and verify new technologies to ensure the continuous upgrading of the system.

In recent years, the BDS has played a much stronger role in driving economic and social development. The application of the system has expanded continuously in scale and extent and has entered a critical stage of marketization, industrialization and internationalization.

The system has realized extensive application and large-scale development in transportation, disaster relief and mitigation, agriculture, forestry, animal husbandry, fishery and other industries, as well as such fields as electric power and communication infrastructure, registering plenty of fruits and notable benefits.



Studies have shown that Africa's digital economy is a fast-growing market. From IFC (International Finance Corporation) and Google concluded that Africa's digital economy has the potential to reach \$180 billion by 2025, accounting for 5.2% of the continent's gross domestic product (GDP). By 2050, the projected potential contribution could reach \$712 billion, 8.5% of the continent's GDP.

ICT expert Mwajuma Mbele said despite the fast growth in the digital economy, there are still gaps to be filled, as millions of young adults in many African countries are unemployed.

The latest statistics indicate that despite some 800,000 to 1,000,000 young graduates entering the labor market in Tanzania annually (NBS-2015), on average the economy creates only 250,000 jobs a year, as 75 percent of these young remain jobless. In Kenya 34% of the young adults are unemployed. Both examples present a large potential labor force for the global digital economy.

"However, the adaption of right approach and tools, the likes of GetPaid, African countries can witness a huge number of young adults joining and engaging in the digital economy, " observed one jobless UDSM graduate, Asha Mkwezu.

## TARI making efforts to put avocado up production, processing

THE Tanzania Agriculture Research Institute (TARI) has embarked on a robust programme targeting to improve production, productivity as well as additional value to avocados in Tanzania.

The initiative which involves a thorough research and soil testing to establish more regions where the economic cash crop can be grown is being implemented by the Mbeya - based TARI Uvole centre.

Among others, the focus is to continue developing numerous technologies to help improve various levels in avocados production, such as seed preparation and availability of quality seedlings, agronomic practices, and pests' management.

In targets is also improvement of harvesting techniques to mitigate fruit loss, processing and innovation of avocado products, marketing research on new opportunities for avocados, and alternative consumption of new products of avocados.

TARI-Uyole Director Dr Tulole Bucheyeki said over the weekend that the center has so far researched, approved, and introduced to the farmers more than ten seeds verities of improved avocado in

He named the varieties as Hass, Fuerte, Weisal, Pinkerton, X - IKULU, Booth 7, Simmonds, Nabal, X- Mwaikokesya, Uyole line, and Duke.

"The focus is to achieve general improvement of the avocado subsector while making sure the country is equipped with market-oriented quality verities," he said, noting that the programme was also meant to sharpen the performance of seedling exporters, agribusiness sellers, apricot harvesters, and buyers as well as fruit exporters.

"Through this programme we're also conducting soil research and requirements for avocado supplements to increase productivity," he said.

Tanzania is the third largest avocado producer in Africa, after South Africa and Kenya, whereby between 2015 and 2018 annual production rose from 20,000 tonnes to 190,000 tonnes.

According to the Tanzania Private Sector Foundation (TPSF), in 2018 Tanzania exported 7,551 tons with a total value of USD 8.5 million to Europe, Africa, and Asia.

The Tanzania National Bureau of Statistics (NBS) has also indicated that the production was 19,449 metric tonnes in 2016/2017.

Regions, where the cash crop is cultivated in Tanzania, include Mbeya, Njombe, Songwe, Iringa, Kilimanjaro, Arusha, and Tanga. Other regions are Kigoma and Kagera in the northwest and Morogoro in the east of Tanzania.

Reports have it that the most important market for Tanzania's avocado is the Netherlands, with an untapped potential of USD 1.8 million, whereby the secondlargest market in France.

However, other markets with large untapped export potential include Japan, Switzerland, Spain, Germany, the United Arab Emirates, and China.

## SDF brings positive changes for VETA, SIDO beneficiaries in Mwanza Region

## Gas prices changing consumer behaviour

**ORLANDO** 

RIVERS around the nation are beginning to shift their driving habits in response to soaring gas prices as the White House attempts to present the pain at the pump in a full context.

As of March 19, the national average gas price was \$4.26 a gallon. And while that has come down a few pennies from a week ago, U.S. drivers are "without a doubt" making lifestyle changes to adapt to higher fuel costs, Robert Sinclair Jr., the AAA Northeast Public Affairs Senior Manager said.

According to a recent AAA survey 59 pecent of Americans surveyed said they change their driving habits once gas prices cross \$4 per gallon. Should the national average rise beyond \$5 a gallon which is already the case in some states three in four respondents said they would need to make adjustments.

"We're seeing that consumers are having real sticker shock," Vectis Energy Partners Principal Tamar Essner recently said on



And the question is: Does the sticker shock translate into actual demand destruction? And we think in certain parts of the economy that's already happening. In certain parts of the world, that already is.'

President of Lipow Oil Associates, LLC., Andrew Lipow joins Yahoo Finance Live to discuss demand destruction in rising gas prices, surging commodity and energy prices forcing consumers to pay more, and energy infrastructure.

New survey data from AAA finds that two-thirds of

Americans felt gas prices were too expensive just a few weeks ago at \$3.53 per gallon. Now with the national average at an all-time high of over \$4, Americans may have reached a tipping point.

Over half (59%) said they would make changes to their driving habits or lifestyle if the cost of gas rose to \$4 per gallon. If gas were to reach \$5.00, which it has in the Western part of the country, three-quarters said they would need to adjust their lifestyle to offset the spike at the pump.

Among Americans who said they would make

changes in response to higher gas prices, a majority (80%) said they would opt to drive less, with some differences among age groups:

18 to 34 year-olds are almost three times as likely as those 35 and over to consider carpooling (29% vs 11%), which would likely involve major changes to their daily travel plans.

Those 35 and over are more likely to favor combining tips and errands (68% vs 52%) and to reduce shopping or dining out (53% vs. 43%).

While many Americans may adapt their daily habits to make up for higher gas prices, it likely won't have as much of an impact on summer travel. AAA's survey found that 52% of Americans have plans to take a vacation this summer. Of those, 42% said they would not consider changing their travel plans regardless of the price of

Since the New Year, the national average has continued a steady climb due to strained supply and increased demand. But Russia's invasion of Ukraine in late February caused oil prices to spike further and in the 14 days since the conflict began, the national average has risen \$0.70 (as of 3/9/2022).

These are numbers not seen at the pump since the financial crisis in 2008, the highest on record until this week (note: AAA historic data is not adjusted for inflation).

While the conflict continues on the far side of the globe, consumers will likely not see relief any time soon. AAA offers the following advice to help drivers ease some of the pain they're feeling at the pump:

Keep your vehicle in top shape with routine inspections and in between, make sure your tires are properly inflated. Underinflated tires are a drag on fuel economy.

Map your route before you go to minimize unnecessary turnarounds and backtracking. Avoid peak traffic times and if possible go to "one-stop shops" where you can do multiple tasks (banking, shopping, etc.). Fuel economy peaks at around 50 mph on most cars, then drops off as speeds increase. Reducing highway

speeds by 5 to 10 mph can increase fuel economy by as much as 14%.

A car engine consumes one quarter to one-half gallon of fuel per hour when idling, but a warm engine only takes around 10 seconds worth of fuel to restart. Where safe to do so, shut off your engine if you will be stopped for more than a minute.

## Homebuyers scramble to secure low mortgage rates before increases

**LOS ANGELS** 

MORTGAGE rates hit their highest level since April 2019 last week, following a sharp increase in 10-year Treasury yield.

The rate on the average 30-year fixed rate mortgage jumped to 4.16 percent, up from 3.85 percent a week ago, according to Freddie Mac.

The 15-year fixed rate – a common refinance option - also surged, averaging 3.39 percent from 3.09 percent last week.

The more than quarter-point hike in rates in the last week is a blow to many homeowners who may have waited too long to refinance their loan. It's also yet another setback for buyers who are facing some of the worst affordability conditions, as prices push higher amid stubbornly low inventory for homes for sale.

"The potent fuel that propelled real estate markets to new highs over the past couple of years is evaporating," said George Ratiu, Realtor.com manager of economic research.

Rates have marched up notably in recent weeks as rattled markets responded to inflation concerns that ratcheted up even more after the U.S. banned oil imports from

The Federal Reserve's move to hike shortterm interest rates by a quarter-point on Wednesday, with at least five more increases expected this year, is unlikely to slow inflation anytime soon, according to Ratiu, given the ongoing supply chain issues and the effect of higher fuel costs on consumer prices.

Weary buyers already facing the worst affordability conditions are now clambering to snag a low rate before any future increases price them out altogether, according to interviews with real estate pros, while the number of refi candidates coming through the door have dwindled as rates soared past 4% for the first time in almost three years.

Mortgage rates have marched up by a full percentage point since the beginning of 2022, hitting 4.16% this week, according to Freddie Mac, and further increases may come as the Federal Reserve is set to raise a key benchmark rate up to six more times this year to combat inflation.

"The short answer is it's painful, I won't lie. Rates have been escalating every single day for basically the last 45 days," Scott Sheldon, branch manager at New American Funding in California, told Yahoo Money. "It's not very fun to be a mortgage originator in this environment. You quote one rate one day and it's something different a few days later.'

As demand increases and inventory levels remain near historic lows, homebuyers aren't taking any chances with mortgagee rates. Purchase locks increased in February as strong housing demand drove buyers to secure rates despite increases, according Black Knight's latest Originations Market Monitor report.

"I locked many people last week telling them the Fed has said they are going to raise rates ... so let's not take any chances," John Stearns, a senior mortgage loan originator with American Fidelity Mortgage in Wisconsin, told Yahoo Money.

## WHO official: COVID-19 pandemic is 'far from over'

**GENEVA / LONDON / OTTAWA** 

A World Health Organization spokesperson said on Friday that the end of the COVID-19 pandemic was a long way off, citing a rise in cases in its latest weekly data.

The UN health agency has previously said that the acute phase of the pandemic could end this year but it would depend on how quickly we meet its target to vaccinate 70 percent of the population in each country, among other factors.

Asked by a journalist at a Geneva media briefing about the timing of the pandemic's end, Margaret Harris said it was "far from over". "We are definite-

After more than a month of decline, COVID cases started to increase around the world last week,

A combination of factors was causing the increases, including the highly transmissible Omi-

and the lifting of public health and social measures, the WHO said.

#### **Britain**

The estimated range of England's COVID-19 reproduction "R" number is between 1.1 and 1.4, the UK Health Security Agency said on Friday, adding that daily cases could be growing each day.

An R number between 1.1 and 1.4 means that for every 10 people infected, they will on average infect between 11 and 14 other people. The previous week's range was 0.8 to 1.1.

The daily growth of infections was +2 percent to +6 percent compared to an estimated range of between -2 percent to +2 percent, last week.

According to a statement from her office on Friday, recent studies indicated that an mRNA COVID-19 vaccine booster dose could enhance the overall immune response, which can provide longer lasting protection and possibly better effectiveness against variants.

#### Risks posed by worldwide US-funded biolabs cause jitters around globe

RUSSIA'S recent disclosure about the U.S.-funded biolabs in Ukraine has sent jitters around the globe.

Besides Ukraine, the United States has been funding secret biolabs in many countries around the world. The truth behind these biolabs and the risks of leakage of some dangerous pathogens have sparked serious concern in the international community.

#### SECRETIVE BIOLABS

The Biological Threat Reduction Program (BTRP) is part of the U.S. Department of Defense's Cooperative Threat Reduction (CTR) Programme, according to a fact sheet of the defense ministry published on March 11.

Since 2005, when the BTRP has partnered with the government of Ukraine, the United States has invested approximately 200 million U.S. dollars in Ukraine, supporting 46 Ukrainian laboratories, health facilities and diagnostic sites.

Russian Foreign Minister Sergei Lavrov said on Tuesday that in addition to over 30 biolabs in Ukraine, the United States has created "hundreds of such laboratories" in other countries.

According to publicly available data, 336 laboratories in about 30 countries receive funding from the BTRP. The research work conducted by these defense ministry-funded biolabs is highly classified.

Although U.S. officials have dismissed the questions about these biolabs as "disinformation" and "conspiracy theories," there have been calls for Washington to comply with the Biological Weapons Convention (BWC) and make clarifications

on related issues. In face of the documents, pictures and objects discovered by Russia in Ukraine, the United States should make related information public, fully explain its biological research at home and abroad, and accept multilateral verification.

Alastair Hay, Professor Emeritus of Environmental Toxicology at the University of Leeds in Britain, said: "the United States has been supporting various laboratories in the Ukraine through a post-Cold War program.

As I understand it, these labs are generally involved in disease surveillance." "It is unclear why the United States needs to support this work and why, for example, it is not happening under WHO guidance," said the professor.

#### **POTENTIAL DANGERS**

The United States claimed that it has funded biolabs in other countries to "contain biological threats." And yet these labs turn out to be have been designed to store and deal with dangerous pathogens and toxins.

Take Ukraine. A 2012 report by the U.S. National Academy of Sciences said that some Ukrainian labs have been upgraded to the level needed to handle some of the more dangerous pathogens such as anthrax.

Some media reports noted that the U.S.-funded biolabs in Ukraine were set up to create a mechanism for the covert spread of lethal pathogens, which has raised fresh disquietude about potential pathogen leakage.

Why did the United States choose to fund biolabs in Ukraine, which is not a rich country in Europe and does not excel in biomedical research?

While explaining the history of the U.S. biolab program in Ukraine to The American Conservative, Jonathan Askonas, an assistant professor of politics at the Catholic University of America, said the Defense Threat Reduction Agency (DTRA) increased its activities in peripheral countries of the former Soviet Union.

Ukraine was particularly attractive as it has a lot of skilled STEM workers and had a U.S.-friendly government. The U.S.linked labs in Ukraine are not bioweapons facilities, Robert Pope, director of the Cooperative Threat Reduction Programme, also known as the updated Nunn-Lugar program, was quoted by the Bulletin of the Atomic Scientists as saying. The current Ukraine-Russia conflict may put at risk a network of the labs that work with dangerous pathogens.

Former Democratic Representative Tulsi Gabbard has been condemned as a "traitor" for tweeting that more than 25 "U.S.funded bio labs" in Ukraine which, if breached, would release and spread "deadly pathogens".

She called for a ceasefire "now around these labs until they're secured and pathogens destroyed." On Thursday, the World Health Organization advised Ukraine to destroy highthreat pathogens stored in the country's labs to prevent "any potential spills."

#### HALF-HEARTED U.S. MEDIA

In disregard of the worldwide concern over the U.S.-funded overseas biological laboratories, the U.S. mainstream news outlets, which always flaunt the so-called "freedom of the press," have kept silent and just parroted what the U.S. government has said without any verification.

"What is in those Ukrainian biological labs that make them so worrisome and dangerous?" independent journalist Glenn Greenwald queried in an article published on March 9, one day after U.S. Undersecretary of State for Political Affairs Victoria Nuland admitted that "Ukraine has biological research facilities" when testifying before a Senate Foreign Relations Committee hearing.

FORMER British Business Secretary Vince Cable has urged the West to accept that the center of gravity of the world's economy has moved to Asia


"We have to accept that this is a new reality, and the mentality has to change. The center of gravity of the world's economy has moved to Asia," said Cable (pictured), who served as Secretary of State for Business, Innovation and Skills from 2010 to 2015.

Cable, currently a professor in practice at the London School of Economics and Political Science, mentioned "Davos China" in his book "The Chinese Conundrum: Engagement or Conflict" published last

"This is a China that wants to engage globally, through trade and investment, participating in multilateral institutions and contributing to dealing with collective problems, he wrote in the book.

Commenting on China's vision of building a community with a shared future for mankind, he said, "If we can make that happen, and that is desirable, clearly.

In a recent speech, Cable told a joke when talking about the U.S. outrageous demands on China. "If the Chinese were to say 'Ok, we are not going to sit down with you in the



United States, and talk about trade unless you repeal Section II of the American Constitution (referring to the Second Amendment to the United States Constitution) that gives people the right to carry guns.

We in China are very upset at seeing people being killed in America in shooting incidents." Cable said he referred to the rights of Americans to own guns because many would see the right to own guns "a terrible abuse of human rights.'

"But at the moment, the Chinese are not saying you must get rid of your constitutional rights so that we can trade with you, and that would be considered a joke," Cable told Xi-

"There is what's called one-way traffic that people in the West are saying you must change your system because we don't like human rights abuses or whatever," he continued. "There has to be a level playing field on these arguments."

"Human rights are not just a Western concept," Cable said. "I think the West needs to accept that in China, there is an additional dimension to human rights that we perhaps don't appreciate.

One of which is the need to emphasize the movement out of poverty, which has been a big achievement in China." Cable hopes that

there is a recognition in the world that disengagement is a bad process.

"It's fuelling suspicion, and it's becoming a vicious circle. We have to live together, work together, and have a shared economy," he said. Cable stressed that hostile rhetoric only leads to stereotypes and mistrust and negatively impacts the global economy.

But "a lot of investment is still happening despite the rhetoric. There are a lot of Chinese companies investing abroad and foreign companies going to China, particularly in the finance sector," he said, noting that the British welcomes Chinese investments. **Xinhua**

China stands, as always, on the side of peace, cooperation, fairness, and justice, supports any endeavor that helps ease the tense situation and bring a political solution to the crisis, and opposes any action that goes against diplomatic settlement of the issue and escalates the ten-

China has maintained close communication with relevant parties and made efforts to facilitate peace talks. It is ready to continue playing a constructive role in promoting peace talks between Russia and Ukraine and work alongside with the international community to carry out necessary mediation when needed.

China has responded to the Ukraine issue in a responsible way. What it has done to help resolve the crisis has truly demonstrated the sense of responsibility a major country is supposed to have.

In contrast, certain country attempts to create a crisis, benefit from the crisis, and shift its burden of crises onto others, which will only harm both itself and oth-

China does not agree to the idea of resolving the Ukraine issue with sanctions and opposes unilateral sanctions that lack the basis of international law.

The unilateral sanctions imposed by the U.S. have inflicted a lot of trouble on the world and caused persistent and systemic human rights violations. The country should stop abusing sanctions and abandon the futile attempt to coerce other countries into doing things they oppose.

The fact that some politicians and media outlets in the U.S. cooked up and disseminated disinformation over the Ukraine issue has reminded people of America's disgraceful record of using lies and rumors as pretexts to frequent-

Throughout its less than 250 years of history, there were only less than 20 years when the U.S. didn't launch military operations against foreign countries. And among the diverse pretexts for its military interventions abroad, some are even false information fabricated by the U.S. itself.

The U.S. once used a small tube of white powder as evidence of the socalled weapons of mass destruction in Iraq, and launched military strikes against the latter, bringing terrible disasters to the Iraqi people.

It also used a video deliberately staged by the White Helmets, an organization funded by Western intelligence agencies, as evidence to conduct air strikes in Syria.

Such lessons are not long gone. The U.S. should reflect on its wrongful actions rather than repeat the same mis-

George Frost Kennan, former U.S. Ambassador to the Soviet Union. warned the U.S. government in the 1990s that expanding NATO up to Russia's borders would be "the most fateful error of American policy in the entire post-cold-war era".

As the instigator of the Ukraine crisis, the U.S. should reflect on its role in the crisis and stop deceiving and confusing the public. It's about time the country shouldered its due responsibility, took practical actions to help alleviate tensions and solve problems and contributed to world peace.

### US Fed kicks off rate-hiking cycle to combat inflation, adds to global debt concerns

#### **WASHINGTON**

THE U.S. Federal Reserve on Wednesday kicked off an interest-rate hiking cycle and signaled six more rate hikes later this year, as it seeks to tame the highest U.S. inflation in four decades.

However, investors and economists are concerned that a more aggressive Fed hike cycle could tip the U.S. economy into a recession and have adverse spillover effects on emerging markets and developing economies.

It would also push up global borrowing costs significantly, adding to mounting worries about growing debt burdens in the wake of the CO-VID-19 pandemic.

#### HIKES AGAINST INFLATION

The Fed on Wednesday raised its benchmark interest rate, the federal funds rate, by a quarter percentage point to a range of 0.25 percent to 0.5 percent from near zero.

This marked the Fed's first rate hike since 2018 and a major step in exiting from the ultra-loose monetary policy enacted at the start of the pandemic.

"Inflation remains elevated, reflecting supply and demand imbalances related to the pandemic, higher energy prices, and broader price pressures," the Fed said in a statement after a two-day policy meeting, adding the Ukraine crisis and related events are likely to "create additional upward pressure" on inflation.

The U.S. consumer price index surged 7.9 percent in February from a year earlier, the fastest annual pace since January 1982, according to the U.S. Labor Department. "We're not going to let high inflation become en-

The costs of that would be too high," Fed Chair Jerome Powell said on Wednesday afternoon at a virtual press conference, adding every Fed meeting is "a live meeting" regarding raising interest rates. "If we do conclude that it would be appropriate to move more quickly to remove accommodation, then we'll do so," he said, expecting U.S. inflation to "remain high through the middle of the year" before coming down more sharply next year.

The Fed's quarterly economic projections released Wednesday showed that most Fed officials expect the federal funds rate to rise to 1.9 percent by the end of this year and to around 2.8 percent by the end of 2023.

That implies a total of seven quarter-percentage-point rate hikes this year and another three or four next vear. It is a more aggressive pace of hiking than Fed officials projected last December, when their median projection was just three rate increases this year.

"This is a significantly more hawkish Fed, focused on forcefully reining in inflation," said Diane Swonk, chief economist at major accounting firm Grant Thornton.

tion-adjusted terms.

The Fed faces the difficult task of securing a soft landing for the world's largest economy. Raising interest rates too slowly risks allowing inflation to run out of control, while tightening too quickly could tip the U.S. economy into a recession. Noting that the U.S. economy is "well-positioned" to withstand tighter monetary policy,

Powell said the probability of a recession within the next year is not particularly elevated. However, Lachman believed that the Fed is "highly unlikely" to engineer a soft landing for the U.S. economy with inflation so high.

"This is particularly the case since the Fed has not only created an inflation problem, it has also caused an equity, housing and credit market bubble.

There has to be the risk that once the Fed starts raising interest rates in earnest, we will see those bubbles bursting and that bursting will produce a deep economic recession," Lachman said.

Swonk noted that her own analysis suggests that seven rate hikes, coupled with the crimp on spending triggered by the surge in prices associated with the Ukraine crisis, would bring U.S. economic growth down below 1 percent in the second half of the year.

"That is not enough to keep the unemployment rate from rising. Addirecession," she said.

Former U.S. Treasury Secretary Lawrence Summers also warned that the Fed's current policy trajectory is likely to lead to stagflation and ultimately a major recession, with unemployment and inflation both averaging over 5 percent over the next few years.

"Indeed, (the) recent research that I conducted with my Harvard colleague Alex Domash shows that overheating conditions of high inflation and low unemployment are usually followed, in short order, by recession," Summers wrote Tuesday in a Washington Post op-ed.

#### GLOBAL DEBT CONCERNS

The IMF has warned of higher debt burdens for months as the Fed's upcoming rate hikes will push up global borrowing costs significantly and strain public finances. "Public finances will come under strain in the

coming months and years, as global public debt has reached record levels to cover pandemic-related spending at a time when tax receipts plummeted," the IMF said in an update to its World Economic Outlook report released in January.

"Higher interest rates will also make borrowing more expensive, especially for countries borrowing in foreign currencies and at short maturities," the IMF said, noting high post-pandemic debt burdens will be an ongoing challenge for vears to come. Global debt rose to a record 226 trillion U.S. dollars in 2020 as the world was hit by the pandemic and a deep recession, according to the multilateral lender.

Historically, Fed hiking cycles can be a headwind for emerging market debts, as higher yields in the United States make emerging market securities relatively less competitive in the struggle for global capital, analysts said.

In addition, more aggressive Fed rate hikes could rattle global financial markets, leading to capital outflows and currency depreciation in emerging markets and developing countries, they noted.

The average total debt burdens among low- and middle-income countries increased by roughly 9 percentage points of GDP during the first year of the pandemic, compared with an average increase of 1.9 percentage points over the previous decade, according to the World Bank.

"Higher interest rates make debt service more expensive, reinforcing the trend of recent years, and weaker currencies make debt service more burdensome relative to the size of the economy. Liquidity problems could suddenly morph into solvency problems," said World Bank Group President David Mal-

"Emerging economies need to rebuild their buffers and avoid sacrificing the accumulation of capital-both physical and human-along the way. The path chosen for fiscal consolidation is critically important in this respect," Malpass said, adding advanced economies should carefully unwind the extraordinary stimulus policies and avoid creating global turbulence.

#### Call for response over biological security issue in Ukraine

A CHINESE envoy on Friday asked relevant parties to the biological security issue in Ukraine to respond to newly discovered documents and offer clarifications to remove the doubts of the international community. China was once a victim of chemical and biological weapons. China believes that any

information and lead on biological military activities should trigger heightened concern and attention of the international community to avoid irreparable harm, said Zhang Jun, China's permanent representative to the United Nations. "In this regard, relevant parties should take a responsible approach. Russia has further revealed newly discovered relevant documents. The party concerned should respond to

questions, and offer timely and comprehensive clarifications to remove the doubts of the international community," he told a Security Council meeting on the biological security issue in Ukraine. "We do not consider it too much to ask. And on this issue, no double standards should be applied," he said. China's position on weapons of mass destruction and biological security is consistent and clear. China stands for the complete prohibition and destruc-

tion of all weapons of mass destruction, including biological and chemical weapons, said

China resolutely opposes the development, possession or use of biological and chemical weapons by any country under any circumstances, and urges countries that have not done so to destroy their chemical weapons stockpiles as soon as possible. Complying with the Biological Weapons Convention is the obligation of all state parties. China calls for early negotiations on the establishment of a verification regime under the conven-

tion, which will help improve global biosecurity, he said. Under the current situation, it is the shared desire of the international community to achieve a cease-fire in Ukraine as soon as possible to avoid more civilian casualties and to prevent a massive humanitarian crisis. China shares this wish, said Zhang.

Direct negotiations between the parties concerned are the fundamental way to solve the problem. Russia and Ukraine have held four rounds of negotiations. While the negotiations are kept going, there is hope for a cease-fire and a peaceful future. China will continue to facilitate dialogues for peace. China supports the United Nations and all parties in ramping up mediation efforts, and hopes that all parties can do more to promote peace talks, rather than adding fuel to the fire.

"Behind the Ukraine crisis is the issue of European security. It is our hope that the United States, the European Union and NATO can sit down with Russia for in-depth and comprehensive dialogues and explore ways to put in place a balanced, effective and sustainable European security mechanism based on the principle of indivisible security so as to achieve lasting peace and stability in Europe."

## Msuva: Contract shenanigans and national team chicanery

T times one has to go around to either look for novel idioms or search them out from afar to explain a situation that nobody seems to be clear what it is all about, for instance, the situation of soccer middle-aged striker Simon Msuva at Wydad Casablanca and then as to eligibility for Taifa Stars call up.

There seem to be two different waves in which the 'middle aged' star is at the center of the whirlwind, first at Wydad where it is far from clear what the problem is, whether he is in their plans or there is a fallout that is rolled out a scene at a time.

It often happens if there is a conflict situation rather than the end of the contract, a sort of strike.

The issues arising as to his eligibility for call up to play for the national side was less of shenanigans than chicanery, in a dictionary sense of the use of deception or subterfuge to achieve one's purpose, expressed differently as dishonest but attractive talk or behaviour that is used to deceive people.

The point here is that some people came forward or made representations with the national team technical bench that the player is ineligible for he isn't an active player in any club.

They didn't say he wasn't fit for the game as he hasn't been actively training, playing exhibition games with a club side here or outside, as he is training.

When one cites the fact that a player has no club he is actively playing with, it looks like an excellent observation of rules and cited as a matter of principle, that laid-off players sleeping at home and watching television have no place in a national team.

But that shallow impression was deceptive as the player has taken safeguards and precautions about his fitness and ability to play, as in the event of a phone call from his club, depending on the nature of the dispute, he would be expected to be fit.

Even in the event of seeking a contract with another club, first impressions count, and lack of training could ruin his image when taking what is usually given as a medical test - as it is a sporting medical test, too.

In that case, there was an effort at gaining a place for some perhaps ineligible call-up suitors who aren't remotely comparable to the unsettled Wydad striker, by rushing at his contractual and playing position as fatal to his call-up eligibility, which was inaccurate

What is marginally uncertain in that regard is the motivation therein, if someone was trying to make it easier for an acquaintance, for instance, a good club player at the local level or a rising star, to get a first or renew call up at the national side, or perhaps club loyalties.

Outlandish maneuvers for instance an effort to make the player's 'working visit' here a bit uncomfortable can pay, say he drops plans to rejoin Yanga, opts to pick up some other offer. Quite clever!

#### **Troubled Chelsea into** FA Cup semis; Arsenal wins in league

LONDON

NO matter the opponent, no matter the competition, Chelsea's players are managing to maintain their on-field focus amid a troubling period for the club.

It's now six straight wins since Russian billionaire owner Roman Abramovich announced he'd be selling the London club, with Chelsea swatting aside second-tier Middlesbrough in a 2-0 win to reach the FA Cup semifinals on Saturday.

Romelu Lukaku and Hakim Ziyech scored the first-half goals that were celebrated by a smallerthan-normal pocket of visiting fans inside the Riverside Stadium. In light of the economic sanctions placed on Abramovich by the British government for his close links to Russian President Vladimir Putin following the invasion of Ukraine, Chelsea was only able to take around 700 supporters for the match in the northeast.

The disparity in backing didn't make a difference, with Middlesbrough's ambitions of following up victories over Premier League teams Manchester United and Tottenham in the earlier rounds quickly snuffed out.

And so concluded another turbulent week for Chelsea, which advanced in the Champions League on Wednesday – setting up a quarterfinal meeting with Real Madrid – before a deadline passed Friday for bids to buy the club from Abramovich and end his 19-year ownership.

Given the doubts over their futures, Chelsea's players are showing remarkable professionalism

No little skill, too, with both of the goals being length-of-the-field moves that started with Chelsea's ball-playing defenders beating Middlesbrough's high press.

The first ended with Ziyech setting free Mason Mount, whose low cross from the right was tapped home by Lukaku in the 15th minute.

Ziyech made it 2-0 in the 31st by cutting in from the right, aided by Cesar Azpilicueta's decoy run taking away a defender, and drilling a low, angled shot into the far corner from outside the area.

The remaining quarterfinal matches take place on Sunday, with two being all-Premier League contests: Southampton vs. Manchester City and Crystal Palace vs. Everton. Wrapping up the last eight, quadruple-chasing Liverpool visits second-tier Nottingham Forest, which has already eliminated Arsenal and defending champion

#### Candy wants fan involvement as race to buy Chelsea heats up

LONDON

NICK Candy has vowed to involve Chelsea fans if the British property tycoon succeeds in his bid to buy the troubled Premier League club.

Candy is believed to have submitted a bid of over £2 billion (\$2.6 billion) for his boyhood team before Friday's deadline and he promised to give fans a 'golden share' ownership stake.

On a frantic day at Stamford Bridge, former Liverpool chairman Martin Broughton and World Athletics president Sebastian Coe also lodged a

Chicago Cubs owners the Ricketts family followed suit, while LA Dodgers co-owner Todd Boehly's consortium also made a confirmed bid. There are reported to be several other firm bids

on the table, but Candy is a front runner. Candy issued a lengthy statement in confirming the submission of his bid, vowing to write off the loan to Chelsea Pitch Owners to safeguard the Blues' future at Stamford Bridge.

The 49-year-old has promised a total renovation of the stadium, where his property expertise could come to the fore.

Candy has teamed up with South Korean firms Hana Financial Group and C&P Sports Group in his Blue Football Consortium.

"Chelsea is one of the most iconic and successful professional football clubs in the world, with a rich heritage, global following, and a highly valuable brand," Candy said.

"Football clubs are vitally important community and cultural assets, and this is a once-in-a-lifetime opportunity to give football back to the fans and put them at the heart of the operations and strategy of a leading global football club.

"I believe Chelsea has all of the fundamentals to become the most valuable and respected sports club in the world and a force for the greater good in everything it does."

Roman Abramovich put Chelsea up for sale on March 2, amid Russia's invasion of Ukraine.

The 55-year-old was then sanctioned by the UK Government last week, after Downing Street claimed to have proved his links to Vladimir

Russian billionaire Abramovich has always denied those links but UK assets have been frozen by the Government.

Chelsea have been allowed to continue operations under special licence, but Abramovich cannot profit from the sale.

## Unbeaten in two years, Qatar's Invincibles lift World Cup hopes

WHEN Al Sadd wrapped up a second straight Qatar title by stretching their unbeaten league run to 49 games, they were inevitably dubbed the 'Invincibles' after another team that reached the same number.

While the 12-team Qatar League is not as formidable as the 2003-4 English Premier league, unlike Arsenal, Al Sadd have turned their run into two league titles in a championship loaded with millionaire imports.

Their form has inspired hopes for the national team in the country that is hosting the World Cup.

Al Sadd's squad contains the bulk of Oatar's national side, as well as a former Arsenal star Santi Cazorla and ex-Premier League regular Andre Ayew.

Run by owners with seemingly bottomless pockets and training on manicured turf in Doha's notorious heat, Al Sadd have swept aside rivals featuring the likes of Belgian defender Toby Alderweireld at Al Duhail and Colombian James Rodriguez at Al Rayyan.

Alderweireld's side beat Al Sadd this week in the Amir's Cup, the top domestic knockout. Al Rayyan, however, got rid of former France coach Laurent Blanc last month because they could not compete in the 12team Qatar Stars League.

Al Sadd coach Javi Gracia, battle-hardened at Watford in England and Valencia in Spain before taking over when Xavi Hernandez returned to Barcelona in November, said his players had "achieved something very special".

Cazorla, who spent six seasons at Arsenal, said Al Sadd's streak dating back to March 2020 was simply "historic".

Having equalled Arsenal's unbeaten run , the Qataris see nothing stopping them getting past AC Milan's 58game streak in Italy in 1991-93 and Celtic's 69 games in 2016-2017 in Scotland. Romania's Steaua Bucharest went unbeaten for 104 league matches from 1985 to

"The Wolves", as they are known, see their home success as a launchpad for the Asian Champions League starting in April, and the World Cup that Qatar will host in November-December.

Defender Tarek Salman said he felt he was part of a "golden generation" at Al Sadd along with national captain Hassan Al-Haydos and the foreign contingent.
