Maganja noted that his government would make sure that all school girls who got pregnant continue with education after giving birth. His government would work closely with education stakeholders to see how best the girls can continue learning to achieve their life dreams, he declared.

Upon conceiving, the girls will continue attending classes unless the doctors recommend that they be rested.

"We will allow them to continue attending classes until they are about to give birth. This will provide equal opportunities for both boys and girls," the candidate said.

this is a project of its kind and it will benefit our people immensely," the president said.

The pipeline will benefit over 90,000 Tanzanians residing along the project who will be compensated, he pointed out.

Dr Magufuli took some time to explain the reason behind delays in the signing, noting that the coronavirus pandemic and tax issues were among the difficulties.

Upon completion the pipeline will be the longest heat oil pipeline worldwide, he stated.

Ugandan president Museveni meanwhile said his country had agreed to let Tanzania get 60percent profits from oil sales because the pipeline was 70 percent in Tanzania.

The pipeline is expected to transport about 6.8bn barrels of oil annually.

"We reached a point to let things move because this is just the beginning as the oil to be transported through the pipeline comes from just 40-percent of total area where we have discovered oil," the Ugandan leader elaborated.

Earlier, the two ministers responsible for energy signed an agreement for harmonization of cross-cutting issues in the project, a result of long discussions on shareholding, port operations and project financing.

The pipeline project will claim land in eight regions, namely, Kagera, Geita, Shinyanga, Tabora, Singida, Dodoma, Manyara and Tanga.

Uganda discovered oil reserves in 2006 and needs the planned 1,445-km (900-mile) East African Crude Oil Pipeline to be in place to start commercial production.

The pipeline is estimated to cost \$3.5bn, on the basis of commonly agreed data of the two govern-

Uganda has not given a date as to when construction of the pipeline will start but President Museveni said last year that once construction begins, it would take two and a half to three years to be completed.

The agreement on the pipeline construction comes days after French oil company Total said it had reached an agreement with Uganda protecting its rights and obligations in the pipeline's construction and operation, which it said was the host government agreement.

Total is the major shareholder in Uganda's oilfields after agreeing in April to buy Tullow Oil's entire stake in the jointly held onshore fields in Uganda for \$575 million.

Tullow said last week it was confident of finalizing the sale in the fourth quarter of this year.

population of poor people has been increasing every day with government statistics showing that in 2011 there were 12m people living in abject poverty while in 2018 the figure had risen to 14m, he told the rally.

Statistics show that in every 100 children, about 74 live in poverty, a situation which CUF has pledged to deal with by improving nutrition for expectant mothers and infants, he similarly noted.

"At present more than 11,000 pregnant women die during delivery each year, an average of 30 every day. This is a situation that is totally unacceptable and we shall work to improve these services," he said.

Prof Lipumba affirmed that CUF will ensure it oversees economic growth to eradicate poverty and attain sustainable development by 2030.

Regarding agriculture, a CUF government will ensure to make it the pillar of industrial development. "As the party manifesto clearly says, without development in the agricultural sector for a country like Tanzania, it is difficult to have adequate development in the industrial sector," he said, insisting that it is obvious the ruling party has failed to invest in the industrial sector.

Prof Lipumba has held the position of chairman of CUF from 1995 to the present. He has also contested every presidential election in since the country instituted a multiparty system in 1992 except in 2015 when CUF and other opposition outfits supported Chadema candidate Edward

In the first election in 1995, he came third with 6.43 per cent of the vote. He then finished second behind then incumbent President Benjamin Mkapa in 2000, capturing 16.26 per cent of the vote.

Running again as the CUF presidential candidate in the 2005 elections, Prof Lipumba finished a distant second to Jakaya Kikwete, garnering 11.68 per cent of the vote. He again came third in the 2010 presidential election receiving 8.3 per cent of the vote.

## Agro research centre to produce five million sisal seedlings - official

THE Tanzania Agriculture Research Institute (TARI) Mlingano Centre is set to produce at least five million seedlings of sisal in a new drive to revamp mass production of the cash

director for the centre said: "We've earmarked more than 70 hectares, purposefully for the production of sisal seedlings, though due to some limitations we're currently not able to use all hectares."

The Tanga-based centre has been earmarked for the revival of the crop production, including conduction of researches, as well as production of im-

proved seedlings.

However, she said the future focus of the Center was to ensure for mass production of the seedlings in order to supply farmers in the country with enough seedlings.

Permanent Secretary (PS) in the Ministry of Agriculture, Gerald Kusaya unveiled that the government has already trained more than 400 agricul-

ture extension officers on better agronomic practice necessary to be adhered by farmers in cultivating sisal profitably.

He said the government was very determined to see the commercial crop is cultivated at high levels in regions that it flourishes.

"We're working round the clock to ensure sisal is once again cultivated widely and

more professional in order for the crop to play deserved role in boosting the country's economy," he expressed.

Deputy Minister for Agriculture, Omary Mgumba said the intention is to at least start with at least five, out of 12 regions that support sisal production in the country.

The country's leading sisal growing regions include Mo-

rogoro, Tanga, Kilimanjaro, Coast, Lindi and Mtwara. But, under the ongoing fresh strategy, plans are to see farmers in more regions adopt cultivation of sical

Among the targeted regions are Dodoma, Singida, Manyara, Mwanza, Simiyu, Arusha and Mara. In his remarks during inauguration of Tanzania Sisal Board (TSB) in Tanga region,

Prime Minister Kassim Majaliwa expressed that said the revival of sisal production was in line with efforts to revamp production of all major crops, including oil palm, cashew nuts, cotton, tea, tobacco and coffee.

In 1960's, Tanzania was at the helm of the world's sisal production market with capacity of producing at least 200,000 tonnes annually.

# TPSF appeals to govt to review TASAC Act

TANZANIA Private Sector Foundation (TPSF) stakeholders have called on the government to review the law that established Tanzania Shipping Agencies Corporation (TASAC) in order to remove challenges facing business people in the country.

Speaking to reporters in Dar es Salaam at the weekend soon after the meeting that brought together private stakeholders and the government, Acting TPSF Managing director Zacky Mbenna said the Foundation has convened the joint meeting to give recommendations on what was to be done to improve goods clearing at Dar es Salaam Port.

He said there have been good communication environment between TPSF and the government in acting on challenges in doing business in the country that has always enabled business people offer good services to Tanzanians.

"In the past, situation was different, the cooperation between the private and public sectors in all essential issues on business and investment. We trust this meeting will continue to bring positive results because

the private sector is spinal cord in pushing up the nation's development, he said.

TASAC Executive Secretary Abel Uronu said changes in TASAC management was essential to meet Tanzanians' needs taking into consideration the cost, ease and professionalism in doing business.

## Horticultural farmers to receive training on better farming practices

SMALL horticultural farmers in Mbeya, Songwe and Katavi regions are geared to receive training on better farming practices that would help them in inclusive economic growth and increase food security.

The training is to be provided by HELVETAS Tanzania, an NGO through Better Horticultural Farming (KIBOWAVI) under European Union (EU) sponsorship.

This was disclosed by the Director of Helvetas Tanzania, Daniel Kalimbiya, when closing the seminar on better horticultural farming practices to individual service providers and provided by Uyole and Tengeru centres of Tanzania Agricultural Research Institute (TARI).

Kalimbiya sdaid the training beneficiaries will come from 15,000 households from all districts in the three regions and that 500 farmers' groups and food processing institutions will benefit from the training.

"This is a five-year project which we are implementing together with other institutions - CODERT, ADP Mbozi and TAFOPA and whose cost is Euro 5m of which 95 percent will be provided by

EU," he said.

He further said training centres will be established in every district for the people to go for frequent training on horticultural farming.

## Legendary Fort Ikoma to be included in Serengeti tourism

THE remains of the legendary, historical German stronghold at Ikoma are in the process of being refurbished, set to be listed among the new products to be offered for visitors touring Serengeti National Park.

The Germans built Fort Ikoma in 1905 to defend themselves against the rebellious tribe of Ikoma. Later, during the First World War, the Stronghold served as a heliograph station which was used to telegraphically warn off British forces using sun-reflecting apparatus.

Senior Assistant Conservation Commissioner for Tanzania National Parks, Massana Mwishawa, who serves as the Chief Warden at Serengeti, explained that the German Fort is among the

future plans to diversify tourism products at the country's oldest Park, which is now the third largest in Tan-

"We are currently refurbishing the buildings at Fort Ikoma as they have great tourism potential," stated Commissioner Mwishawa during a special interview in his office at Seronera, over the weekend.

Fort Ikoma tourism will complement the already popular attractions in Serengeti such as the annual wildebeests' migration, spectacular ungulates' calving; gravity defying balloon safaris; bird watching and soon to be introduced sky-diving.

Built some two kilometers away from the Grumeti River, the Fort Ikoma structures were an important army base for the German East African troops. Perched on top of a series of low hills in the Serengeti region, the Germans chose this unique location for its tactical benefits over the enemy which now helps the visitors enjoy iconic landscapes below.

The government had previously converted the Fort into a military training institute before moving the facility to the now known Tanzania Military Academy (TMA), in Monduli District of Arusha circa 1979.

Located nearly 22 kilometers from the main Ikoma Gate entry to Serengeti National Park, the former German army stronghold is one of the historical sites in Tanzania with ancient foreign architectural design. It is also being frequented by various wildlife species thus offering double benefits.

The nearby town is also the largest

quarters of the park, which sometimes provide lodging facilities to visitors touring Serengeti who wish to stay outside the National Park.

Serengeti, which is among the country's

seven UNESCO Heritage Sites with a special biosphere reserve status since 1981, also features other cultural tourism sites such as the Moru Rock paintings, Gong Rock and Kopje dotted vast landscapes.

# Regulatory bodies told to promote investment

THE government has called on its regulatory agencies not to frustrate investors and instead work together to promote investment in the country.

While there is no integrated national investment development strategy and programme, they are challenged to closely work together at this time when every country is doing everything possible to improve economy by attracting new investors.

Permanent Secretary in the Prime Minister's Office, Policy Coordination and Investment, Dr Dorothy Mwaluko made the call here over the weekend when speaking at the opening of a validation workshop that brought together representatives from ministries, departments and government institutions for evaluation on the implementation of the National Investment Promotion Policy (NIPP), 1996.

She said that the government is working hard to improve investment climate and attract more quality investment in the country.

Dr Mwaluko noted that the primary objective of the evaluation is to establish the extent to which the NIPP has achieved its objective and identify new emanating challenges to improving investment climate so as to attract more quality investment in the country.

The evaluation is expected to come up with policy, legal and institutional issues to inform the government on the way forward to creating and sustained favourable investment climate.

"We need to have a coherent approach to investment coordination, promotion and facilitation therefore I appeal to you to drop your different sector positions on the matter and have a common outcome" she said.

She argued that some sectors in the government are not doing their best to promote investment, noting that some local government authorities have failed to set aside land for invest despite the government directive to do so.

The PS added that the Prime Minister's Office (PMO) has the overall role of coordination of the investment matters in the country by overseeing the implementation of NIPP. This is in understanding that, among the 57 Sectoral Policies governed under 18 different ministries, a total of 34 policies have provisions which impact investment

She said, however, the existing investment coordination framework still

faces some challenges. One of them is absence an integrated national investment development strategy and programme which hampers the effective coordination role of the PM's office.

The other challenge is absence of implementation strategy of the current National Investment Promotion Policy

According to the PS although the main role of investment promotion and facilitation is vested in the Tanzania Investment Centre (TIC), in principle all sectoral ministries, local government authorities and agencies do play a critical role.

"The facilitation role involves the regulatory framework embedded in their jurisdiction such as issuance of various guidelines, permits and licenses for the establishment, operation, market access, provision of aftercare services and monitoring and evaluation to ensure adherence to policy goals and legal requirements." she said.

Dr Saudin Mwakajega from the University of Dodoma (UDOM) who is also participated in the evaluation process noted that it was important to conduct an assessment of achievements accrued in the course of implementation of the policy, identification of existing gaps, challenges encountered and recognizing policy areas.

He said the aim is to identify also new emerging issues crucial for improving Tanzania's investment competitiveness and taking on board various developments in the global and regional investment frameworks.

"The primary objective of the evaluation was to establish the extent to which the policy has been achieved and identify new emanating challenges to improving investment climate so as to attract more quality investment in the country." he said.

Export Processing Zones Authority (EPZA)'s Director of Promotion and Facilitation James Maziku on his part observed that at macroeconomic level, Tanzania's economic growth remains high relative to other developing countries. He said Tanzania's economic performance continues to rank among the highest in the region, adding that over the past 15 years, Tanzania averaged an annual rate of growth of 6.4 percent.

He said, "This growth was attributed to increased investments especially in infrastructure such as construction of roads, railway and airports; stable supply of electricity; improvement in transport services"

## **Dr Kimei:** I will bring economic revolution in Vunjo if I'm elected

He said another area is to improve road infrastructures to simplify transportation of crops to reach the market.

On health, Dr Kimei said many health centres need quick and major refurbishments, with some of them lacking modern X-ray and ultra sound equipment.

"We shall oversee the completion of Himo District Council that has stopped. We shall also deal with health insurance issues and medical services to elders," Dr Kimei added.

"I have mobilized myself to ensure Himo residents get development just like the CCM Election Manifesto says. I will work together with the Government in every sector to ensure people get development, and benefit from their resources," he said.

He also appealed for the residents to vote for President John Magufuli as well as all CCM councillorship candidates in the constituency.

## Joint village land use planning for resolution of conflicts in Tanzania

THE government is implementing a pilot project on joint village land use planning in pastoral areas as part of solutions to end conflicts between crop farmers, pastoralists and conservators.

Under the project, villages share grazing resources and plan together on establishment of mechanisms to manage the shared rangeland.

Speaking during a breakfast debate on biodiversity conservation over the weekend, Assistant Director (Land for Livestock Development) in the Ministry of Livestock and Fisheries Development, Victor Mwita said they have started with Kiteto District in Manyara Region.

The virtual breakfast meeting was organized by the Journalists Environmental Association of Tanzania

(JET) with support from the United for livestock. States Agency for International Development (USAID).

Mwita who is the Manager of the Dodoma Abattoir noted that plans are to expand the project to other pastoral areas including Mbeya, Morogoro, Manyara and Coast Regions. He said under the plan, villages are provided with Certificates of Customary Rights of Occupancy (CCRO) for the demarcated grazing land to protect it from other users.

"This ensures land tenure security to different land users as well as fairness in the use of available land. For pastoral communities village land use is seen as the solution for combating land use conflicts", said

He added that until June 2020, a total of 1,875 villages have prepared land use plans and demarcated land

According to Mwita, the government has been embarking on various efforts to end conflicts between pastoralists, farmers and conservators whereas it has decided to give part of its land from ranches managed by the National Ranching Company Limited (NARCO), national parks and protected areas to surrounding villagers alleged to encroach the areas.

On these given land, villagers are allowed to construct houses, conducting farming activities and livestock keeping, he said.

The ministry of Livestock and Fisheries chopped some 1,800 hectares of land from the Hanga Ngadinda farm in Ruvuma Region which was given to Gumbiro and Ngadinda villagers. A total of 2,208 hectares from the Ruvu ranch were

also given to surrounding villagers from Bagamoyo and Kibaha Districts.

Mwita said the government has also allocated some 48,502.2 hectares from a number of NARCO owned ranches which will be given to the villagers. The ranches are Kongwa which have 13,591.7 hectares taken back to wananchi.

Other ranches with number of hectares in brackets are Kalambo (10,000.0), West Kilimanjaro (2,416.0), Kikulula (7,381.6), Missenyi (10,049.2), Mabale (1,950.0) and Kagoma 3,113.7 hectares.

He said the ministry has also allocated some areas from the Tanzania Livestock Research Institute (TALIRI) whereas 2,501.03 hectares will be given to pastoral communi-

## Tamwa calls for support in addressing teenage pregnancies

THE Tanzania Media Women's Association, Zanzibar (TAMWA Zanzibar) has called on the public to chip in and support the fight against teen pregnancies in Isles.

In a statement issued yesterday, Dr Mzuri Issa, director of TAMWA Zanzibar expressed concerns over the increasing rape incidents in the Indian Ocean Archipelago, calling on Tanzanians to provide education on the effect of child pregnancies in order to save children from this malaise that affect them physically and psychologically, while others lost their lives.

She said: "This problem can be only addressed by joint efforts among community members including religious leaders, politicians, and women's activists to come up with a specific plan to educate the community on the effects of childbirth at an early age."

According to her, TAMWA Zanzibar has recently received shocking reports of a child under the age of 15 being raped, became pregnant and eventually lost her life during birth.

She cited recent reports from the victim's parent, the incident took place in Wete District, Pemba North region and the victim died on June 25, 2020.

TAMWA Zanzibar conducted a survey on the effects of child pregnancies and found a plethora of problems including physical and psychological trauma as well as the

According to health expert, Dr Kamilia Ali Omar of the maternity unit at Mnazimmoja Hospital in Zanzibar said, child pregnancies could lead to fistulas, cervical cancer and other diseases that occur due to some organs in the body of young girls which are not matured enough hence causing complication during the birth.

"Giving birth under the age of 18 is life-threatening for both mother and baby because the pelvic of a child under the age of 18 are not matured enough to push the baby, so it puts the parent at risk of getting fistula, or the parent loses life or some illnesses, says Dr Kamilia.

Dr. Kamilia said health experts recommend giving birth at least 20 to 22 years of age.

She recommends that if child pregnancy problem arises in a child, it is best to refer to a clinic as early as possible so that health professionals could keep her safe for the life of mother and child.

On the other hands, a psychologist from Zanzibar School of Health, Asya Saleh Abdullatif, said child pregnancies lead to mental congestion that can lead to unnecessary fainting's or mental illness.

Asya also said that child pregnancies lead to frequent outbursts where the carrier may commit a terrible mistake against her or someone else which could cause harm.

TAMWA Zanzibar has identified child pregnancies in four areas - either being raped, forced marriage, child marriage or sexual inducement.

The Ministry of Education and Vocational Training Zanzibar has identified a total of 88 incidences of child pregnancies and 50 child marriages in the past three years.

Therefore, statistics in terms of education are often obtained after children drop out of school due to pregnancy or marriage. It is also possible that there are other girls in the community who dropped out of school in the past or did not go to school before and their information was not

recorded. It is good for the community to be aware of this problem of teenage pregnancy in order to save the lives of these girls and also for the government to take stern action against people who rape young girls and those who marry off their girls at a tender age.



## Barring of many candidates can impact on electoral enthusiasm

LECTION campaigns are blurred in a wide range of constituencies on account of a cloud hanging over the likely number of participants in the poll. Many opposition candidates have yet to be cleared after the National Electoral Commission (NEC) raised queries on details in how the forms were filled. A few dozen such candidates have been cleared but close to 100 had been touched in the first place, in relation to parliamentary candidates alone. That is still a problem.

While the thrust of NEC scrutiny of the forms appears to be veracity of information in relation to how those individuals relate to their parties, and their other records touching on law and order issues, electoral politics are slightly different.

Ordinarily people aren't elected to the legislature because of the party they represent but due to how they are viewed at grassroots level, in which case barring a candidate can impact on electoral enthusiasm.

At a number of instances in the past, CCM rejected aspirants who won the primaries and they were elected upon switching to the opposition, and even making solid contributions there, like ex-Karatu MP Dr Wilibrod Slaa.

In that case, another look needs to be thrown at the issue so that more and indeed most of the still non-cleared candidates who have already been approved by their parties are cleared and get time to campaign. We still have nearly 50 days to polling day and for constituency needs that is plenty of time.

So the fact that NEC hasn't completed the job within the time frame of starting the campaigns or a week later isn't a big problem but it ought to be hurried up to uplift poll interest.

This isn't something that is easy for various levels of authority to grasp, for they are chiefly looking forward to a landslide CCM victory, which is evidently on the cards, but gaps of enthusiasm and electoral interest aren't of much use.

It is vital that NEC .should look at the forms not as if it is picking CCM candidates but individuals from broad sections of the population, from political parties which could have done differently with more resources, etc.

The issue is that the forms need not be perfect, so long as those individuals face no criminal charges or anything else that is expressly disallowed in law, not marginal misdemeanors, etc.

Memories aren't too far off of the days where disputes in parliamentary elections more or less crippled local government functions, where CCM wins the mayoral seat and it has no majority among the councillors.

That may not come up this time but other problems can crop up, if there are too many disgruntled candidates and their supporters in various districts, that is, wards and constituencies

When most of the disqualified candidates are cleared the voters will understand the case for those remaining, as they often know those individuals at the grassroots level as well.

At the same time, it is possible that efforts to ensure that there is cohesion in local governments so that development projects are smoothly executed can lead to contrasting assessments of what ideal picture is needed in the forthcoming poll.

It may well have worked in the aftermath of civic polls late last year but they weren't psychologically important as the current polls. That counts.

## This virus divides as it multiplies

SOCIETIES under stress often rupture along their weakest fault lines. The escalating Covid-19 crisis is amplifying unresolved tensions that have the potential to tear the nation apart even further.

South Africa is arguably the most vulnerable it has ever been in the new democratic dispensation. In 2020, the annual Edelman Barometer survey revealed that public trust in key societal institutions - government, business, media and academia - was lowest in South Africa among all countries that were surveyed. This does not augur well for our prospects to successfully navigate the Covid-19 crisis.

These institutions are not without blame for the decline in public trust in them. Government and business corruption, media sensationalism and academic insensitivity, in a society that has decidedly reproduced the racial and class disparities of apartheid, has withered the "rainbow nation" narrative. We are now a nation divided.

Societies under stress often rupture along their weakest fault lines. The escalating Covid crisis is amplifying unresolved tensions that have the potential to tear the nation apart even further. As the coronavirus multiplied exponentially, claiming the lives of more and more South Africans, it widened the fault lines in our society, dividing people into the very race-based boxes that our democracy was intended to dismantle.

A plague of poverty has combined with a biological plague to exacerbate existing tensions, and it has spilled over into public discourse, most notably on social media. Social media analytics, from a variety of sources, indicates that these tensions worsened as we approached the first peak of infections.

Initially, a fair amount of admirable social cohesion was brokered in tackling the ill effects of the pandemic. Political parties presented a united front, and the planning - we were assured - would be guided by the best scientific advice that we could draw on. Government enjoyed a high level of support from both its political opponents as well as citizens. Civil society, business and ordinary people mobilised to help the poor.

Fear drove us closer together and we responded by cooperating with one of the toughest lockdowns in the world. We put our faith in our key institutions, despite the fact that our faith in them had been steadily declining for over a decade.

For a moment, we put our trust in our academics, government, the media and business to guide us through the crisis.

Yet this was not to last. In this new era

of politics, political spin that actively discredits institutions has become routine. Positioning themselves as experts in eve-

ry arena without qualification, politicians have proven especially guilty of deliberately undermining the very institutions

that we require most to navigate crisis.

Take Helen Zille, for example, who indiscriminately waded into the student protests to discredit critical race theorists and students alike. During the current crisis she became a proponent of the now discredited notion of "herd immunity". With scarcely any expertise in either domain, she waded into these debates and drove wedges between insti-

tutions and society deeper.

And she is not alone. Politicians, wanna-be politicians, industry leaders, social media influencers, celebrities, religious leaders, crackpots and conspiracists have all joined the milieu, resulting in a deafening noise that has all but drowned out the clear institutional signals we desperately need to navigate the crisis successfully.

It is this devastating assault on the integrity of the institutions that we need to preserve social cohesion and organise our response to the pandemic that has deepened the fissures in our society. As doubts and uncertainties are exploited, ordinary people are lost in the gap between what we know about the virus and what we are still discovering as the pandemic unfolds. The consequence is that our ability to act coherently in response to the pandemic has significantly dimin-

It is imperative that a new leadership and social compact is brokered on the understanding that this is not a moment to exploit differences for political and personal gain. This is a moment to forge unity among us and emerge with a stronger sense of who we are, what we stand for, and what we can achieve when we work together.

Not only is it cruel and irresponsible to arrogantly wade into the fray armed with nothing but half-baked "facts" and speculation at best, and opportunism and wild conspiratorial delusions at worst, it puts the lives and livelihoods of ordinary people at risk. By obscuring the clarity of institutional messaging, they have confused the citizenry, leaving them without clear guidelines on how to change everyday behaviours to get society back up and running again.

If people don't take precautionary measures seriously and are in doubt about how to adapt to the new reality, we will endure spike after spike in infections, and businesses, schools and the like will be forced to close.

We will endure a staccato economy, a spiralling death count, and the health-care burden of people who have to live with the lingering after-effects of the virus (the "long-haulers").

Yet most strangely, in the vacuum that has emerged in the wake of public disconnection from our institutions, we have seen the emergence of bizarre, self-serving rhetoric.

Ultranationalist, afrophobic messaging has skyrocketed, threatening to expose us yet again as the pariah of the continent. Alongside the infamously unknown @uLeratoPillay's attacks on foreign migrants and refugees, smaller, more recent political parties such as South Africa First and politicians such as Herman Mashaba are ramping up afrophobic rhetoric, seeking to capitalise on misplaced fear and prejudice. Our once exalted position on the continent as a shining light for tolerance, freedom and constitutional democracy is now an unrecognisable wreck.

Thinly-veiled white supremacy advocates have attempted to disguise their messaging in terms of the "white genocide" narrative, positioning themselves - bizarrely - as comrades alongside the Black Lives Matter movement. This despite the fact that black people are far more likely to be murdered in South Africa. Moreover, the irony of identifying with Black Lives Matter while at the

same time promoting the "All Lives Matter" message appears to escape the proponents of this narrative. Predictably, no "All Murders Matter" rhetoric has emerged from this camp.

Race and class divides have risen to prominence, revealing a nation of two starkly disconnected realities. While the poor, predominantly black and brown people navigate the threat of hunger, white South Africans were ranting that Woolworths had to stop selling rotisserie chicken.

To add to this unholy milieu, an EFF central command member was caught posing as a white woman on social media - Tracey Zille - to put out racist messaging that directed would-be "fellow" racists to internet pages off which he was earning advertising revenue.

In this new reality, truth is stranger than fiction. Catalysed by divisive rhetoric, profound distrust and disengagement from our core societal institutions - stoked by both official and unofficial actors - the virus proceeds to divide as it multiplies. And our nation is left the worse for it.

It is imperative that a new leadership and social compact is brokered on the understanding that this is not a moment to exploit differences for political and personal gain. This is a moment to forge unity among us and emerge with a stronger sense of who we are, what we stand for, and what we can achieve when we work together.

It is a moment to trust our institutions and to hold them accountable at the same time. It is also a moment to begin exposing those who would divide us, and to interrogate their motives.

The alternative - a society and politics driven by divisive, populist, ultranationalist rhetoric - is too scary to contemplate but it may well come to fruition, as it has in so many other nations across the

## Little more could be said about need to ensure ozone layer remains intact

DAY of reflection on the preservation of the ozone layer has been set by the United Nations for September 16 each year, whose importance scarcely needs to be labored upon. It is now close to 30 years since the United Nations Conference on Environment and Development took place in Rio de Janeiro, Brazil in 1992.

It was followed by the Kyoto (Japan) conference to lay the framework for financing basic climate change mitigation initiatives in 1997 and much later in 2012 in the Danish capital of Copenhagen. It is the latter conference that provided a framework for action in use now, but how far is it an answer?

While the world marks the International Day for the preservation of the ozone layer, there are signs that the battle to combat climate change is in the course of being lost, even if its negative consequences or fearsome implications aren't felt around the world in the same way.

We have largely been spared weather excesses that are making life unbearable in many countries, and not singularly the poorest, as the kind of fires that have lately ravaged the western part of the United States are an unheard of phenomenon.

Nor is the massive flooding in the Nile Valley and especially in Sudan something that the region is familiar

It isn't just the US where uncontrollable fires broke out, as earlier it was Australia, and even more surprisingly Brazil, as the Amazon forest is located in a deeply humid tropical atmosphere by average standards, but fires have been spreading unchecked in a large portion of those forests.

There are also plenty of fires that have been ravaging tropical forests in DRC nearby, but they were more limited in range and intensity compared to

Brazil, and ordinarily appear to have arisen from widening traditional agricultural activities. Brazil is different as the forest is being conquered for agri-

business, by and large.

All these massive fires produce the massively excessive carbon dioxide emissions which are the principal threat to preserving the ozone layer.

The wisdom underlying global policy action in that direction is a different source of carbon dioxide emissions, chiefly from the combustion of fossil fuels in transportation and industry in particular, apart from clearing forests to expand farms.

The trouble is that little progress is being registered in that direction as renewable energy production consumes plenty of traditional energy to put into place for instance solar, wind and thermal energy equipment, which doesn't diminish total fuel needs.

Despite the Covid-19 global travel lockdown, global agencies say gas emissions were just as high.

What now looks like the gravest threat to global economy is rising sea levels, touching off devastating hurricanes and cyclones whose impact appears to be rising year after year.

The danger arising from expanding holes in the ozone layer increasing the impact of ultraviolet rays from the sun upon the earth hasn't so far been touted as causing the grave effects of accumulated carbon dioxide in the atmosphere that ignites global warming.

The impact of such gases is adequate even before scientists actually sound the alarm about the ozone layer, but when these days of reflection were being reflected upon, the specific danger of global warming and its impact was being put to plenty of debate, chiefly from 'climate change skeptics.'

It is evident that many of them are starting to acknowledge the grave realities the world faces.

## An asset for West African states

HE President, Nana Addo Dankwa Akufo-Addo, was on Monday elected Chairman of the Authority of Heads of State and Government of the Economic Community of West African States (ECOWAS), at the 57th ECOWAS Summit held in Niamey, Niger.

The President, who was elected unanimously by his peers, takes over the mantle of leadership from the President of Niger, Mahamadou Issoufou, for a period of one year.

Following in the footsteps of his predecessors, Presidents Jerry John Rawlings, John Agyekum Kufuor, and John Dramani Mahama, who also had similar privilege to lead the sub-continental body, President Akufo-Addo in his remark, thanked the Assembly for the honour, and assured member states that he would do his utmost not to let the side down, as he would discharge his duties to the best of his abilities.

"Excellencies, I am fully aware of the challenges which confront West Africa. Past leaders of ECOWAS have demonstrated their collective will and determination to drive the agenda of regional integration, opening up our economic frontiers, encouraging healthy competition amongst Member States, and ensuring that we adhere to our formative principles.

"As much as considerable progress has been made since the establishment of ECOWAS, some 45 years ago, we are all agreed that there is much more to be done to consolidate the socio-economic and political gains made over

According to President Akufo-Addo, five immediate challenges face the regional organisation, ECOWAS, for which Member States must address.

He listed them as the continuing activities of terrorists in the region, concentrated, for the time being, in the Sahelian area, involving Mali, Niger, Burkina Faso and the northern parts of Nigeria; the COVID-19 pandemic, which has attacked the populations and economies of each of the Member States; the imminent coming into force of the African Continental Free Trade

Area on January 1, 2021; the 2020 decision on monetary union within the ECOWAS space; and the consolidation of democratic governance in the face of the turbulent conditions of the Community.

"The challenges, in these critical regional spheres, such as security, economy, trade, currency and health, must be addressed in a spirit of genuine cooperation and solidarity, if we are to succeed in overcoming them, which

"In so doing, we must protect, at all costs, our freedom and independence of action, so that the development of our Community responds to the needs and aspirations of our peoples, and not to the goals of external agencies and

"I am confident that, by the grace of God, I can count on the unstinting support of each one of Your Excellencies in navigating the immediate future of our Community," he added.

The Ghanaian Times commends the President for his assumption of the Chairmanship of ECOWAS and outlining the clear goals he would be pursuing in his one-year tenure.

As already stated, the task ahead is daunting but we have no doubt that the President, with his vast experience in diplomacy and governance would be able to lead in resolving some of the perennial problems of the sub-region.

The Economic Community of West African States, also known as ECOWAS, is a regional political and economic union of fifteen countries located in West Africa. Collectively, these countries



comprise an area of 5,114,162 km2 (1,974,589 sq mi), and in 2015 had an estimated population of over 349 million.

The union was established on 28 May 1975, with the signing of the Treaty of Lagos, with its stated mission to promote economic integration across the region. A revised version of the treaty was agreed and signed on 24 July 1993 in Cotonou. Considered one of the pillar regional blocs of the continent-wide African Economic Community (AEC), the stated goal of ECOWAS is to achieve "collective self-sufficiency" for its member states by creating a single large trade bloc by building a full economic and

The ECOWAS also serves as a peacekeeping force in the region, with member states occasionally sending joint military forces to intervene in the bloc's member countries at times of political instability and unrest. In recent years these included interventions in Ivory Coast in 2003, Liberia in 2003, Guinea-Bissau in 2012, Mali in 2013, and The Gambia in 2017.

ECOWAS includes two sub-regional blocs:

known by its French-language acronym UEMOA) is an organisation of eight, mainly French-speaking, states within the ECOWAS which share a customs union and currency union. Established in 1994 and intended to counterbalance the dominance of English-speaking economies in the bloc (such as Nigeria and Ghana), members of UEMOA are mostly former territories of French West Africa. The currency they all use is the CFA franc, which is pegged to the

The West African Monetary Zone (WAMZ), established in 2000, comprises six mainly English-speaking countries within ECOWAS which plan The West African Economic and Monetary Union (also to work towards adopting their own common currency, the eco.

In addition, ECOWAS includes the following institutions: ECOWAS Commission, Community Court of Justice,[8] Community Parliament, ECOWAS Bank for Investment and Development (EBID), West African Health Organisation (WAHO), and the Inter-Governmental Action Group against Money Laundering and Terrorism Financing in West Africa (GIABA).

The ECOWAS operates in three coofficial languages-French, English, and Portuguese, and consists of two institutions to implement policies: the ECOWAS Commission and the ECO-WAS Bank for Investment and Development (EBID), formerly known as the Fund for Cooperation until it was renamed in 2001. In 1976, Cape Verde joined the ECOWAS, while Mauritania withdrew in December 2000, having announced its intention to do so in December 1999.

In 2011, the ECOWAS adopted its development blueprint for the next decade. Vision 2020, and, to accompany it, a Policy on Science and Technology (ECOPOST).

As of February 2017, ECOWAS has 15 member states; eight of these are French-speaking, five are Englishspeaking, and two Portuguese-speaking. All current members joined the community as founding members in May 1975, except Cape Verde which joined in 1977. The only former member of ECOWAS is Arabic-speaking Mauritania, which was also one of the founding members in 1975 and decided to withdraw in December 2000. Mauritania recently signed a new associate-membership agreement in August 2017.

Morocco officially requested to join ECOWAS in February 2017. The application was endorsed in principle at the summit of heads of state in June 2017, but Morocco's bid for membership was stalled.

## Nigerian Bar Association's 2020 presidential election: A matter of justice, character and integrity

N my Petition dated August 2nd, 2020 to the Chairman, Board of Trustees of the Nigerian Bar Association, I drew attention to the flawed, illegal and unconstitutional process leading to the NBA Election of 29th - 30th of July, 2020 and the electronic fraud that characterised the Election proper. In that Petition, I stated inter alia that, as a past Chairman of NBA Ikeja Branch, past General Secretary of the Association, a Life Member of the National Executive Committee, and a Life Member of the Distinguished Body of Benchers, in addition to other areas of responsibility that I have had the privilege to serve, I can lay claim to being one of the builders of the Association. Consequently, I will hate to see the Association destroyed or destabilised in any way or form. I also stated in that Petition that my participation in the affairs of the NBA, is driven purely and absolutely by the desire to advance the interest and aspirations of the Association in particular, and our beloved Profession in gen-

In drawing attention to the serial violation of the provisions of the NBA Constitution, the cyber fraud perpetrated and the misuse and abuse of powers which I submitted, characterised the election, I called for the cancellation of the Election. Recognising that if the election process is wrongful, illegal and unconstitutional, the product must suffer the same fate.

## **Board of Trustees: Findings and Recommendations**

In a letter authored by the Chairman of the Board of Trustees, Dr. Olisa Agbakoba, SAN, dated 19th of August, 2020, it was stated that: "although you have petitioned to us, we must be clear that we have no judicial authority to give direction to the NBA, our position in the circumstance is at best, advisory. Nonetheless, we have read your Petition, and noted that it raises many general and specific allegations in relation to the Elections.... The Trustees have given careful consideration and deeply reflected on your Petition and all the responses, in particular, that of ECNBA. We note that the Elections were not perfect. We reviewed your Petition and note that it raises serious issues. Nonetheless our advice would be that the overall interest of the Bar should be paramount on the mind of every Nigerian Lawyer, and to that extent, we urge that all Lawyers and no less the Candidates, be mindful of the need to promote a cohesive, united and strong Bar. We regret that we are unable to advice that the election should be cancelled, in the overall interest of the Bar." The Trustees further noted that "our elections continue to present challenges going back to 2016, and strongly recommend that a major transformation of our electoral process and framework must be undertaken, and we are happy to be assigned this very important responsibility... ".

In an earlier letter dated 17th of August, 2020 (an unsigned letter which I received via my email from the Chairman) the Trustees stated that "Nonetheless, we have read your Petition and admit that it is not frivolous. The NBA 2020 Election was marred by irregularities. The ECNBA admitted that the election platform failed, which is why they had to engage another I.T. Consultant. The ECNBA admitted that over 14,000 members could not vote, which is an extremely high number. The ECNBA should have made provision, to enable everyone to vote. This is an omission on their part. You have requested that the NBA 2020 Election be cancelled, but this will be unfair to those who have voted."

The Letter continued: "we urge that all Lawyers and no less the Candidates, and in particular, your good-self, accept the Election with its inadequacies in good faith. We are very mindful in our advisory, on the need to keep the Bar cohesive, united and strong".

The following are evident from the decision of the Board of Trustees: First, the Petition was not frivolous; Second, the Petition raised serious general and specific allegations; Third, the ECNBA had no defence to the serious issues raised in the Petition; Four, since 2016, NBA Elections have been the subject of serious disputations for which they the Trustees were disappointed; Five, that a strong recommendation for a major transformation of our electoral process and framework should be undertaken; and Six, that the Board of Trustees are willing to undertake the job of electoral transformation of the NBA.

I know for a fact that, all the members of the Board of Trustees agreed and were united on the specific findings that the Election was flawed and imperfect. All of them were also united in their desire to terminate the narrative of sham elections in the NBA since 2016, hence, their willingness to undertake the responsibility of carrying out electoral transformation for the Association. They only differed on the consequences of their findings, which is whether to direct an outright cancellation and order a fresh election, or direct a bye-election for the 14,000 voters that were disenfranchised, or allow the election to stand as it is. I believe it is an attempt to marry these different outcomes, that the Board of Trustees came to the advice that the overall interest of the Bar should be paramount on the mind of every Nigerian Lawyer. That the Board of Trustees urged all Lawyers including the Candidates, of the need to promote a cohesive, united and strong Bar and that.

## **The Petition Succeeded**

If my Petition will lead to the transformation of NBA electoral process that will free it from lawlessness, corrupt practices and other forms of cyber-crime for which NBA has become notably reputed since 2016 as promised by the Trustees, I will be satisfied. If my Petition will bring about a definite stop to a manipulated bi-annual electoral process with evidence of producing an appointed President or securing the election of a pre-determined President for the NBA, and make votes count in future NBA Elections, I will be satisfied. If my Petition will enthrone respect for rule of law, respect for due process, and stop misuse and abuse of power by a few individuals who believe that they must get what they want for the NBA and not what the NBA wants, I will be satisfied. If this Petition will inculcate and restore the glory, honour, honesty, dignity, integrity, moral and ethical principles on NBA leadership, particularly its Presidents, and make them do things right to re-establish the NBA as the conscience of the Nation once again, I will be more than satisfied.

As a Legal Practitioner of 38 years post-call and as a matter of practice and experience, I know that when allegation of facts succeeds in a civil claim and defence is held to have no probative value, granting of relief is automatic.

defence is rejected, conviction also follows. In an Election Petition, where Grounds of Petition succeed, such as it has been held by four Trustees out of six in this matter, setting aside of that election is a necessary consequence of the findings. However, in this case, the Board of Trustees have advised in spite of the seriousness of their findings, that we accept the election in good faith because of the \*"need to keep the Bar cohesive, united and strong", in a typical Nigerian mentality.

It must be particularly noted that we raised serious reservations in our letter of 7th of July, 2020 to the ECNBA against the serial breach of the provisions of the Constitution relating to the electoral process and the hap-hazard manner of handling the process, the secrecy surrounding the appointment of the I.T Consultant, and the failure to demonstrate the process in order to ascertain the vulnerability and the integrity of the technology to be deployed for the election.

Similarly, Mr. Olumide Akpata also in a most vehement manner, raised serious reservations in his letter of 20th of July, 2020, to the ECNBA. Both letters were sturdily disregarded and ignored by the ECNBA.

#### NBA and the Culture of Impunity The motto of NBA as enshrined in the Constitution of the

Association is \*Promoting the Rule of Law.\* In his address to the Annual General Meeting of the NBA on 28th of August, 2020, Mr. Paul Usoro, SAN, said surprisingly \*"Whatever one may say about those elections, one thing that cannot be taken away from it, is that that was the first ever of our National Elections where everyone was turned into Election monitors, as well as electoral and returning officers all rolled into one ... . For most of our members and based on the comments I have received, this was an exhilarating experience in transparency. The transparency was unparalleled, and we are expecting that subsequent Bar Elections will build on that quality of transparency". My friend Mr Usoro, certainly did not see what many others saw. He failed to realise that election is a process culminating with voting. He ought not to have directed his mind only to the voting process, to the exclusion of the other

various stages leading to the voting process. Rule of Law in all its ramification presupposes that the Law is supreme and that everything must be done according to law, and the law in this instance includes the Constitution of the Nigerian Bar Association, 2015, as amended. Transparency in relation to the just concluded election, exists only in the fertile imagination of the out-gone President.

The result of these reckless actions on the part of the few who have vowed to secure the appointment of NBA President through sham elections may be delayed, but is never lost. However, it must be recognised by all our members that the character of any leader determines the character of the organisation that he leads, and that everything rises and falls with leadership. It is not surprising that Nigerian Bar Association has contributed nothing to nation-building, in the last few

## Come, invest in agric, fisheries sectors, deputy minister urges foreign investors

THE government has welcomed foreign investors to invest in ventures that will add value to the crop, livestock and fisheries sectors and help support an improved and friendly investment climate.

Omar Mgumba, the Deputy Minister for Agriculture made the call while addressing the 10th Annual Summit of the African Green Revolution Forum (AGRF), in Kigali, via video link from Dodoma.

Mgumba noted Tanzania was ready for catalytic investments in agriculture to push the nation into a more industrialized economy, capture the internal and external market especially within the East African Community (EAC) and the Southern African Development Community (SADC) blocs and beyond.

At the moment, agriculture is one of the top contributors to the economy of Tanzania at 28% of GDP. Tanzania's 2020/21 budget noted the private sector had invested about 3.7trilion/- (2015 to 2020) into the agriculture value chain particularly in tea, coffee, sisal, barley, and rice.

"Tanzania offers one of the most attractive investment destinations in Africa," he posited. The country has experienced an average real GDP increase of about 6% in the last decade, and the deputy minister informed its economy was backed up by sufficient natural resources for raw mate-

"We have identified several major investment opportunities under the Agriculture Sector Development Program Phase 2 (ASDP II), Livestock Master Plan and the Tanzania Agro- Industries Development Flagship (TAIDF)", he noted.

The country has unprecedented opportunities for investments in crop farming and related industries, thanks to a total of about 7.1 million ha of high and medium potential land (2.3 and 4.8 million ha respectively) suitable for irrigation, supported by rivers, lakes, wetlands and aquifers, he noted.

He said value addition of primary products influences the pattern of economic growth in the EAC second-largest economy.

'We have a clear long and medium-term policy frame for the economy in general and the agriculture sector in particular," he noted.

"We have put in place a friendly environment for investors. We are an island of peace. Very, importantly, we have put in place great infrastructure projects opening up great possibilities for local and international markets," he said.

The Deputy Minister assured those attending the AGRF summit, which was attended by over 10,000 delegates online, that Tanzania has made great strides on economic and infrastructure development with the assurance of reliable electrical power in all urban areas and most of the rural areas, giving investors an added ad-

The deputy minister noted that Tanzania's agribusiness economy was highly viable at local, regional and international level in terms of the high market possibilities. Tanzania has consistently in over a decade managed to move beyond food self-sufficiency, thus was ready for industrial development.

The East African food security powerhouse has myriad multi-billion dollar investment opportunities in agriculture, livestock and fisheries; large scale sugarcane and cotton ventures, deep-sea fishing, among others, he noted.

He gave the example of the opportunity for large scale farming for seeds multiplica-

"The annual demand of certified seeds is 187,000 tonnes while available is 76,725 tonnes, local supply is 69,173 tonnes, the import is 7,552 tonnes and traditional uncertified seeds are 110,274 tonnes," he noted. Tanzania also has opportunities for investment in chemical industries (fertilizer production) because the country has enough natural gas and phosphate depos-

The deputy minister said the recent policy changes in the livestock and fishing sectors (including deep-sea fishing) have greatly improved the investment climate and are in line with the ongoing implementation of the nation's agriculture blueprint, ASDP II.

The government of Tanzania would continue to address challenges that might be hampering private-sector delivery, he noted, in the spirit of public-private partnership for the good of the country.

Investors in Tanzania are served by the Tanzania Investment Centre (TIC), a onestop centre, for all they need, TIC Executive Director, Dr Maduhu Kazi, told the AGRF summit, speaking from Dar es Salaam, via video

"We welcome all kinds of investors including strategic investors in the agriculture sector... we have a very improved enabling environment," he noted. There are diverse opportunities for invest-

ments in the agriculture sector, ranging from the chemical industry (fertilizers and pesticides); to agro-processing fishing and livestock industries, and many others, he said.

Vianey Rweyendela, AGRA Country Manager (Tanzania), noted that the Tanzanian government has demonstrated a clear political will to make agro-industrialization happen in a big way.

"We have diverse and multiple investment opportunities for agro-industrialization in Tanzania. Many strides have been made in ag-

riculture sector development and the future is bright. All of these are possible because the current government has a clear political will to make agro-industrialization happen in a big way," Rweyendela noted.

He gave an example of an investment opportunity in maize.

"Maize is the most important food crop for us, and we are the largest producer of maize in East Africa, yet the crop is mostly used for porridge and ugali," he noted.

"We need to industrialise the crop- make factories for producing corn oil, animal feeds, starch, among other products", he continued.

"As one of the top producers of maize and cassava in Africa we should not be importing any starch, we should be exporting. It is a huge opportunity.'

Dr Andrew Komba, Director of Policy and Planning Ministry of Livestock and Fisheries-Fisheries Sector, told the summit that there were many investment opportunities to be found in the sector.

"We need investors in fish processing plants, fishery gears manufacturing (nets, boats etc), ecotourism along the beach, fishing of ornamental fish, aquaculture production (finfish, shrimps, crabs, seaweed etc) and production of aquaculture feed and seed. Other opportunities include cold chain facilities (transportation and storage), fishing Infrastructure (fishing ports, cold chain, fishing boats and vessels), fishing labs (Nyegezi in Mwanza and Dar es salaam), supporting protection units as well as fishing infrastructure (fishing ports, cold chain, fishing boats and vessels).

The virtual summit began on September 8 and ended on Friday, September 11. In Tanzania, some delegates attended online at set centres in Dodoma, Dar es Salaam and Arusha.

## Protecting chimpanzees in Tanzania: COVID-19 posing a serious challenge

GOMBE and Mahale National Parks in the Kigoma Region on the shores of Lake Tanganyika are homes to some of Africa's last remaining wild chimpanzees.

The area was so popular for tourists who were interested to see chimps, but, the outbreak of Covid-19 has affected the wildlife conservation efforts in the conservancy.

Pellagy Marando, head of tourism unit, at Gombe National Park says: "This is due to the fact that the number of tourists has gone since the outbreak of the pandemic; hence the funds to conserve the primates have also gone down."

For the past six months, he says, the revenue from tourism has dropped for about 80 percent as there are no tourists visiting the conservancy.

"This pose a serious impact to our conservation efforts of chimpanzee and other wild animals," he says.

Dr Anthony Collins, a Scottish researcher, working with Jane Goodall Institute says Covid-19 remains a challenge to the conservation of chimps. "It important to put in place all health controls to ensure that tourists and even staff have their health being checked and even reducing the number of people getting into chimpanzee habitats," he suggests.

Isaya Mkude, assistant conservator and leader of wildlife security unit, Gombe National Park points out the difficulties in wildlife protection activities due to the open border of national parks as well as the presence of people encroaching on forests for logging, hunting and agricultural activities in the vicinity and wildlife

Mkude, who always wears a mask when patrolling or touring, says: "It is easy to control the interaction of people and animals, but poor education for some residents and isolated areas leads to deliberate violations of the law, which can also lead to coronavirus infestation. through people entering the park without following procedures."

In June 2018, the government established a Tanzania Chimpanzee-Conservation Action Plan after realizing the need to address the threats facing chim-



panzees of Tanzania and enhance the long-term conservation of endangered species. In the action plan it was agreed that chimpanzee needs to be protected as they deserve. The plan is designed to make sure that by 2023 the ecological and cultural diversity of Chimpanzees in Tanzania is conserved in viable populations across their range, managing linkage between populations to ensure the maintenance of genetic diversity.

Other threats facing chimps climate change, human activities-poaching, agriculture, and livestock are some of the key factors that put the primates in danger of extinction.

According to Marando, chimpanzees are now facing the threat of extinction due to habitat destruction (natural forests) depletion of the reserve, food shortages as well as diseases.

The official suggests the need for putting in place collective efforts to rescue the primates from disappearing.

According to the expert, the number of chimpanzees has plummeted from an average of 150 chimpanzees in 1980 to 90 in 2020. "This indicates that there is a risk of extinction," the official said.

Dr Colins who has been in Tanzania for more than 30 years researching chimpanzees notes that the main cause of the decline of chimpanzees is death from communicable diseases, especially the common cold, which is caused by the interaction of animals and humans entering the park for activities such as tourism, animal husbandry, forestry, agriculture, and poaching.

He says that almost one chimp dies every year and that in 1987 nine chimpanzee dies and ten years letter another up education on the benefits of conser-9 also dies from cold flu, other diseases

and climate change or environmental degradation hence causing hunger to them.

The destruction of food chambers and breeding grounds for chimpanzees has been a major factor leading some chimpanzees to move to informal forests where they rush to find shelter and food, the researcher says.

Poaching is also cited as contributing factors for the decline of chimps in the conservancy.

Conservationists have projected that if left unchecked, chimps in country's conservancies will completely disappeared in the next ten years.

This is due to the rapid community invasion of the reserve and the destruction of biodiversity by believing that wildlife is endangered in forests as well as rapid increasing human population nearby protected areas.

Environmental degradation caused by human activities is said to be caused by citizens not seeing the value of the existence of forests as well as wildlife. Besides, some locals have come to believe only that animals cannot be extinct and thus be encouraged to involve in illegal hunting and deforestation in national parks.

Deus Makungwa, a resident of Mpanda in Katavi Region suggests the need for the government and other stakeholders to chip in and invest heavily in wildlife conservation.

"There are lots of benefits, we can get from conserving wildlife resources, that's why we want more efforts to ensure that wild animals are protected for tourism," he says, urging the government to scale vation of natural resources.

## Chronicle of Xi's leadership in China's war against coronavirus (Part 2)

**BEIJING** 

**GLOBAL FIGHT** 

HE virus respects no borders. From a luxurious cruise ship docking in Japan to a ski resort in the French Alps, from Casablanca's ancient city to downtown Manhattan and the Amazon rainforest, the pandemic has spread all over the world.

By Sept. 6, global COVID-19 cases had exceeded 26 million in more than 210 countries and regions, leaving over 870,000 people dead, according to the WHO tally.

Xi said public health security is a common challenge for humanity, which requires joint efforts from all countries.

This is in the spirit of building a community with a shared future for humanity, a vision put forward by Xi in 2013. Over the past seven years, he has been promoting the vision on the international stage. Amid the global anti-virus fight, the importance of this vision has been made clear to all.

On Jan. 7, Chinese scientists isolated the first novel coronavirus strain. On Jan. 12, the WHO acknowledged receiving the coronavirus full genome sequence from China.

Tedros said China identified the pathogen in record time and shared the genetic sequence with the WHO and other countries. This bought invaluable time for other regions around the world to gear up their response.

China also informed the United States of the outbreak in early January. A U.S. virus hunter came to China in late January to help battle the epidemic.

When China was bearing the full brunt of COVID-19's wrath, leaders of over 170 countries and 50 international and regional organizations expressed their support. A total of 77 countries and 12 international organizations provided assistance.

China fought the virus with openness and transparency as press conferences were held daily, sometimes several times a day, starting from Jan. 26.

Amid the epidemic, Xi met with Tedros, Cambodian Prime Minister Samdech Techo Hun Sen, Mongolian President Khaltmaa Battulga, and Pakistani President Arif Alvi in Beijing. Through video link, Xi met with European Council President Charles Michel and European Commission President Ursula von der Leven.

Xi wrote back to Tedros and Bill Gates and exchanged letters with Argentine President Alberto Fernandez, Peruvian President Martin Vizcarra, Cambodian Prime Minister Samdech Techo Hun Sen and Mongolian Prime Minister Ukhnaa Khurelsukh.

Xi exchanged verbal messages with Kim Jong Un, chairman of the Workers' Party of Korea and chairman of the State Affairs Commission of the Democratic People's Republic of Korea. Xi sent a verbal message to Pakistani President Arif Alvi and exchanged messages with Bounnhang Vorachith, general secretary of the Lao People's Revolutionary Party Central Committee and president of Laos.

Xi also sent a congratulatory letter to the ninth ministerial meeting of the China-Arab States Cooperation Forum, urging efforts to advance cooperation

in various fields including the pandemic response. Since the start of the COVID-19 outbreak, Xi has conducted unprecedented "telephone diplomacy," having more than 60 phone conversations with over 50 foreign leaders.

These included those from Western countries such as British Prime Minister Boris Johnson and French President Emmanuel Macron; those from emerging-market countries -- Russian President Vladimir Putin and South African President Cyril Ramaphosa; and those from developing countries like Pakistani Prime Minister Imran Khan, Ethiopian Prime Minister Abiy Ahmed Ali and Cuban President Miguel Diaz-Canel.

In the talks, Xi said this global public health emergency has driven home the urgent need to build a community with a shared future for humanity. It is only by working together that countries around the world can overcome the pandemic, he said.

As the virus spread, some countries and regions were hit particularly hard. Xi sent messages to their leaders, expressing sympathy.

"Unity is strength;" "Building a community of health for all" -- these have been his messages to the world.

In late March, at an extraordinary G20 summit held via video link, Xi called for resolutely fighting an all-out global war against the COVID-19 outbreak, devising a collective response for control and treatment at the international level, supporting international organizations and enhancing international macroeconomic policy coordination to prevent a recession.

Kuhn, the U.S. scholar, said Xi's proposals to enable humanity as a whole to win the battle against this major infectious disease give meaning to the vision of an international community with a shared future.

COVID-19 has become the worst global public health incident since the end of World War II.

In May, at the World Health Assembly's opening held via video link, Xi mourned for every life lost to COVID-19 and expressed condolences to the bereaved families. He announced China's five measures to support the global

Xi said China will make its COVID-19 vaccine a global public good when available, contributing to vaccine accessibility and affordability in developing countries


In June, Xi chaired an extraordinary China-Africa summit on solidarity against COVID-19 via video conference and called for staying committed to fighting COVID-19 together, enhancing China-Africa cooperation, upholding multilateralism and taking China-Africa friendship forward.

"We oppose the politicization and stigmatization of COVID-19, and we oppose racial discrimination and ideological bias. We stand firm for equity and justice in the world," Xi said.

Whether it is taming the virus or achieving economic recovery, the world cannot succeed without solidarity, cooperation and multilateralism, Xi said in a message to a high-level video conference on Belt and Road international

cooperation.

tainment strategies with 180 countries and over 10 international and regional organizations. Beginning in March, Chinese experts held almost daily video conferences with their foreign peers. China's pioneering use of makeshift hospitals has also been adopted around the world, including in New York's iconic Central Park.

Xi had four phone calls with Putin in as many months. Putin said by providing timely assistance to other countries affected by COVID-19, China has set an example for the international community and responded, loud and clear, to the provocation and stigmatization by some country. Putin also said Russia will stand firmly by China's side.

## RISE ABOVE TRIALS AND TRIBULATIONS

Xi said national rejuvenation would not come easy and great struggles must be fought to realize the great dream.

The epidemic brought severe challenges to the world's largest developing country, but showed the importance of following its own path and adhering to reform and opening up.

Initially, medical materials were in short supply and weak links in hospital protection led to infections among health workers. Practices of bureaucratism and formalities for formalities' sake were exposed at local levels.

While fighting the coronavirus as the most pressing task, Xi pushed for building institutions with a long-term impact.
Last year, the fourth plenary session of the 19th CPC Central Committee

Last year, the fourth plenary session of the 19th CPC Central Committee adopted a decision on institution building. Xi said China must use the strength of its institutions to cope with risks and challenges.

"The epidemic was a big test for China's system and capacity for governance," Xi said bluntly. "We must draw experience and learn our lessons."

He said the exposed shortcomings told of the need to improve the national emergency management system and boost the nation's ability to handle urgent and challenging tasks.

In February, Xi demanded efforts to strengthen public health legislation, reform the disease prevention and control system, and improve public health services when he chaired a meeting of the Central Commission for Comprehensively Deepening Reform.

Two months later, the commission's meeting adopted documents on the provision of public health emergency supplies and on oversight of medical insurance funds.

During the "two sessions," when joining deliberations with lawmakers from Hubei, Xi stressed fortifying the public health protection network.

Several priorities were in the spotlight: reform the disease prevention and control system; boost epidemic monitoring, early warning and emergency response capacity; advance the treatment system for major epidemics; improve public health emergency laws and regulations; and carry out patriotic public health campaigns.

The COVID-19 pandemic is dealing a heavy blow to the world economy. More than four out of every five people in the global workforce of 3.3 billion have been affected by full or partial workplace closures, according to a report by the International Labour Organization in early April. Xi told a symposium on economic and social work that the pandemic will accelerate the profound changes the world is undergoing, changes unseen in a century

The Chinese economy shrank 6.8 percent in the first quarter. On the day the statistics were released, Xi chaired a leadership meeting that pointed out the first quarter of 2020 was "extremely unusual." The sudden COVID-19 outbreak had an unprecedented impact on China's economic and social development.

On dealing with the impact on the economy, Xi said: "We must stay confident and not be frightened by problems and difficulties."

"I have said many times that China is a big country with enormous resilience, huge potential and great flexibility in development," he added.

Xi said at the "two sessions" that China has set no specific target for economic growth this year as the sudden COV-ID-19 outbreak has created challenges to completing the tasks in this final year of the 13th Five-Year Plan.

He emphasized the importance of maintaining stable and sound economic performance in the long run, and devised a series of strategic measures including the creation of a new development pattern in which domestic and foreign markets boost each other, with the domestic market as the mainstay. Since early February, Xi has been giving instructions on stabilizing the econ-

From March to August, he visited villages, rural families and businesses on inspection tours to coordinate regular epidemic control with economic and social development.

In Zhejiang Province, Xi chatted with workers by an assembly line, asking if their return to work had gone smoothly, particularly if they had received their paychecks. He demanded the prices of daily necessities and the income of farmers remain stable.

In Shaanxi Province, he encouraged companies to overcome the negative impact of COVID-19 and actively expand markets. In the village of Jinmi, Xi lauded the local black fungus industry. This went viral online, and 20 million people visited the e-commerce sites, where over 20 tonnes of black fungus were sold out in quick succession.

In Shanxi Province, Xi called on businesses to make up for lost time with the proper safety precautions in place.

In Ningxia Hui Autonomous Region, he said no ethnic minority group should be left behind in building a moderately prosperous society in all respects. He also urged efforts to maintain epidemic control measures while accelerating the return to normalcy in people's daily lives.

In Jilin Province, Xi took a particular interest in the employment of college graduates and migrant workers and ordered Party committees and governments at all levels to actively create favorable conditions for college graduates to find jobs.

The Chinese economy bounced back

The Chinese economy bounced back to growth in the second quarter of 2020, expanding 3.2 percent year on year. Major indicators returned to growth, economic performance steadily recovered and market expectations were positive in general.

Foreign direct investment into the Chinese mainland, in actual use, also grew 8.4 percent year on year in the second quarter, indicating foreign investors' growing confidence in the Chinese market. By mid-April, over 99 percent of major industrial enterprises in China had reopened. They included foreign companies and their local suppliers like Apple, Tesla and Volkswagen.


Writing back to Global CEO Council members' representatives in July, Xi said those CEOs had made the right choice by staying rooted in China.

# Kenyan candidate for WTO top job pledges to double intra-Africa trade

## NAIROB

Organisation (WTO) has promised to advance an open trading system once given the mandate.

She made this promise while addressing a virtual meeting with East African Community business leaders this week. Mohamed is the only candidate from the region for the WTO

The virtual meeting which took place on Wednesday was convened by the East African Business Council (EABC), which brought together industry captains from the region to deliberate on deepening relations between the private sector in East Africa and WTO. Speaking from Geneva, Mohamed told the meeting that once given the mandate, she will push for a vibrant multi-lateral trading system to boost Africa's trade.

"If I was selected, I would be a strong advocate for an open trading system. I'd also be a leader in reforming the system and particularly in recovering

the economy from the Covid-19 pandemic," she said. According to Amina Mohamed, the Kenyan the UN Economic Commission for candidate for the position of Africa, businesses in African countries Director General at the World Trade currently face higher tariffs when they export within Africa than outside the continent.

> "If we eliminated the current overall average tariffs of 6.1 percent in Africa, we would actually double intra-Africa trade among African countries, from 15% to 30%. If we also eliminate some of the pressing tariff barriers, intra-Africa trade will significantly improve," she added. Amina noted that although trade rules are negotiated by Governments of WTO member states, it is the private sector that uses them to expand trade and investments.

"A dynamic East Africa community with an active private sector will ensure that the region benefits significantly from the World Trade System but also the African Continental Free Trade Agreement (AfCFTA)," she stressed.

The EABC CEO, Dr. Peter Mathuki said, "We are confident that in her reform agenda at WTO, the voice of the African private sector shall be articulated and heard, with a focus on deepening engagement between the private sector and the global body." The selection process of the WTO Director-General is now in the third phase where WTO members are consulted to narrow down on the candidate to receive consensus support.

## **BUSINESS** Microsoft and Novartis say AI won't replace health workers

new report released by Microsoft and Novartis Foundation shows that the use of Artificial Intelligence is increasingly entering healthcare, signalling that good governance should ensure physicians will see the upside of less administrative work and more patient-facing time.

According to the report, titled: 'Reimagining Global Health through Artificial Intelligence; The Roadmap to AI Maturity,' released last week, Microsoft and Novartis said there has been a digital health shift, more especially driven by challenges that arose during the Covid-19 pandemic.

The report shows that reduced contact between patients and healthcare providers due to Covid-19 social distancing has led to major growth in technologies such as AI-enabled diagnostics.

It further reveals that low- and middle-income countries such as Tanzania, could soon leapfrog high-income countries in their adoption of new AI-enabled technologies in health, calling on governments to identify and test innovative ways to finance high tech in health solutions.

Accelerated by measures taken to avert transmission of the novel coronavirus, the adoption of digital health technologies means that millions of people have sought digital healthcare solutions - presenting an opportunity for countries to integrate data and Artificial Intelligence (AI) into their health systems.

"In Tanzania, and across many

low and middle income countries, technologies such as mobile phone trading e-banking, platforms, e-commerce as well as block chain applications have often been adopted faster and more comprehensively," the report noted.

Commenting on the report, the head of the Novartis Foundation and co-chair of the Broadband Commission Working Group on Digital and AI in Health, Dr Ann Aerts said, "Many countries are ill-prepared to address a new emerging disease such as Covid-19 in addition to the existing burden of infectious diseases and the ever-increasing tide of chronic diseases.'

"We have to develop a sustainable ecosystem for AI in health in the countries where it is most desperately needed," urged Dr Aerts, adding: "This has to happen while ensuring fairness and access for all. As health systems build back after the pandemic, technological innovation has to be a core part of the agenda."

By May this year, Rwanda, which is now arguably the most digitally connected health system in Africa, has had its virtual consulting service surging past two million users - one-third of the adult population.

In recent years, the Tanzanian technology ecosystem more high-tech communities being established every day from the early days of Dar Google Technology User Group (DarGTUG), the Mozilla Community to Andela Learning Community, Tanzania Blockchain Community, Tanzania Developers Community as well as Tanzania Python Community.

Sub-Saharan currently represents 12 per cent of the global population but faces 25 per cent of the world's disease burden, while housing only 3 per cent of the world's health workers.

A worldwide shortage of healthcare workers, which is particularly serious in has been growing fast with many African countries, is

predicted to reach 18 million by 2030. This boosts the case for investment in supportive AI tools, which can help nurses and community health workers diagnose and treat illnesses traditionally seen by doctors.

"As examples in the report make clear, Africa could do more to build access to medical expertise by rolling out AIbased support tools alongside healthcare programs," said Racey Muchilwa, Head of Novartis Sub-Saharan Africa. AI is boosting access and improving outcomes while also cutting costs by identifying potential health problems before they actually occur.

According to Mr Paul Mitchell of Microsoft, who co-chaired the Working Group, Artificial Intelligence can have a big impact not just in lower-income countries, but across all health systems. "It's clear Covid-19 is driving massive change in the use of technology in health - we are seeing in a few months what I would have expected normally to take years, if not decades," Muchiwa said.

In rural areas of Rwanda, one doctor may serve as many as 60,000 people. The government is working with a private sector partner, Babylon Health, to give every person aged over 12 access to digital health consultations. More than 30 percent of Rwanda's adult population has signed up. The new partnership will also see the introduction of an AI-powered triage and symptom checker platform.

Prime Minister Kassimi Majaliwa said in Dar es Salaam on Saturday when officiating an NMB Bima Marathon 2020, that cancer treatment is a burden as it affects the state's development plans. "But the government of President John Pombe Magufuli has improved the health sector a lot including putting in place the necessary infrastructure to treat cancer locally which is now paying off," Majaliwa said.

He noted that as a result of developing the local health infrastructure, cancer treatment has also saved the government from using hard currency to treat citizens abroad. The PM commended NMB Bank Plc's management and board for organizing the charity marathon which raised 100m/- donated to Muhimbili National Hospital to sponsors treatment of children suffering from the deadly disease.

"I commend NMB Bank for coming up with this marathon to help mobilize resources but also sensitize the public on the importance of exercising for physical fitness which helps keep diseases such as cancer at bay," he

Majaliwa further noted that noncommunicable diseases remain a major health challenge in the country hence both the public and private sectors should work together to address the crisis as NCDs are a huge economic burden.

Citing a 2013 UNDP report, the PM said the cost of treating NCDs globally will rise to U\$ 47 trillion in the coming 20 years, an amount which is enough to reduce the number of people living in abject poverty by 2.5 billion in 50 years.

He challenged Tanzanians to exercise more and engage in sports activities for health fitness saying that doing so was vital in dealing with the NCDs menace and reducing the huge medical costs involved in treating them.

## NICOL pays three years' dividend to its shareholders

National Investments Plc (NICOL) has paid its shareholders dividend for the past three years thanks for its good performance after a long period of struggling.

In a statement last week, NICOL said the dividend payment covers three years of 2016, 2017 and 2018. "We wish to announce to our shareholders that as it was agreed during the past annual general meeting, we have paid dividends through your bank accounts," the statement released last week stated.

The statement further stated that shareholders who have not received their divided should immediately contact the company's management and present relevant documents and their bank accounts.

"If you have not yet been paid, you are required to submit all necessary documents that shows that you are a shareholder before September 30 this year so that dividend should be paid," the statement added.

Since its introduction, the company has never paid dividend to its shareholders and was making losses until in 2012 when Dr Gideon Kaunda was elected as NICOL's Board Chairman. Four years later in 2016, the company paid 25/divided per share, 26/- in 2017 and 6/- in 2018 noting that NICOL has also managed to pay all debts plus 1.5bn/- paid in taxes to Treasury.

## STC's and Vodafone agreement for \$2.4bn in Egypt's stake sale collapses, overtaken by events

Saudi Telecom Company, the biggest telecommunications operator in Saudi Arabia by market value, said it could not reach an agreement on a \$2.4 billion deal to buy a 55 per cent stake in Vodafone Egypt within the agreed

However, the company agreed to continue discussions with the UK-based mobile carrier Vodafone Group for its stake in the Egyptian telecoms firm, it said in a statement to the kingdom's Tadawul exchange, where its shares trade.

STC said the extension period of the preliminary agreement has ended without reaching an agreement to conclude the transaction due to "misalignment with relevant parties". "An understanding has been reached between STC and Vodafone Group to keep the dialogue open", the statement said.

Vodafone Group said it is looking to "finalise the transaction in the near future". It "now looks to Saudi Telecom and Telecom Egypt to find a suitable agreement to enable the transaction to close", Bloomberg cited a separate Vodafone Group statement as saying on Sunday.

In January, STC offered to buy a majority stake in Vodafone's Egyptian unit as part of its regional expansion. It signed a non-binding agreement and extended it in April, citing pandemic-related logistical challenges. The agreement was extended again in July, as "the parties need more time to complete the processes related to the transaction, including the due diligence".

If a deal were to be agreed, a majority stake in Vodafone Egypt will give STC a foothold in the Arab world's most populous country, as it looks to expand its operation in the region and beyond. Egypt is one of the largest telecoms markets in North Africa, making it a prime target for operators looking to enter high-growth territories.

With 44 million subscribers and a 40 per cent market share, Vodafone Egypt is the North African country's biggest mobile operator. Staterun Telecom Egypt holds the remaining 45 per cent stake of the operator.

STC, which is majority owned by Saudi Arabia's sovereign wealth fund, the Public Investment Fund, mounted an unsuccessful bid in 2013 to acquire a 45 per cent stake in Telecom Egypt. However, analysts said earlier this year that Egypt's state-owned operator could be more willing to sell its stake in Vodafone Egypt after launching its own mobile network, known as 'We', in 2017.

In February, Egypt's Financial Regulatory Authority said STC should make an offer to acquire Telecom Egypt's remaining stake in Vodafone Egypt if its deal with Vodafone goes through. The regulator cited a 1992 law that would oblige STC to bid for the outstanding shares if a deal materialises.

## Indian authorities face tough choices in trying to reopen economy as virus rates soar

## Trump rallies supporters in Nevada, seeks to overcome Biden lead in the state

**MINDEN** 

REPUBLICAN President Donald Trump rallied his backers in Nevada on Saturday in a bid to drum up support in a state where polls show his Democratic rival Joe Biden is ahead.

Going through a list of grievances about Democrats, the media, and mail-in voting, Trump spoke to a crowd of thousands at an airport outside of Reno where people stood close to one another and, in many cases, did not wear masks despite the coronavirus pandemic.

The president mused about staying in office 12 years, despite constitutional limits that prohibit U.S. presi-

dents from serving more than two, four-year terms.

"We are going to win four more years in the White House and then after that we'll negotiate, right, because we're probably, based on the way we were treated, we're probably entitled to another four after that," he said.

Trump again accused Democrats of trying to "rig" the Nov. 3 election and he knocked Biden over an ad that criticized Trump for allegedly making derogatory comments about U.S. war dead. Trump has denied making the remarks.

"Now I can be really vicious," in return, the president said, expressing his disgust over the ad and calling

Biden "pathetic."

Trump is trailing the former vice president in national polls and in Nevada, which the former real estate developer and reality television star lost narrowly to Democratic presidential nominee Hillary Clinton in 2016.

Biden has hammered Trump for failing to lay out a national strategy to combat the pandemic, which has killed more than 193,000 people in the United States.

The president, who credits his decision to restrict travel from China at the beginning of the year with saving lives, publicly played down the virus in the early months of 2020 and has pushed for a rapid re-opening of the economy after a lockdown in the spring.

"Nevadans don't need more bluster from the president, and don't need his reckless rallies that ignore the realities of COVID-19 and endanger public health," Biden said in a statement on Saturday.

"Nevada families need solutions – from con-

taining the pandemic to building the economy back better to making quality health care more accessible to millions of Americans."

The president has increased his number of campaign rallies in recent weeks, holding them in airplane hangars or outdoors because of the risk of coronavirus spread. Thousands of supporters have been showing up, many of them without maintaining social distance or wearing face coverings.

Trump has campaign events scheduled in Nevada and Arizona during a three-day Western swing that will also include a stop in California on Monday for a briefing about the devastating fires that are ravaging the West Coast.

The president is ramping up fundraising, too, amid concerns that his campaign is dealing with a cash shortage, leading it to pull back television advertising in crucial states.

A Republican official said some \$18 million would be raised over the weekend through events in Washington and Nevada. *Agencies*

## Better global governance needed to protect digital security

**BEIJING** 

THE emergence of digital technologies has reshaped people's lives and made a difference to the world, but one cannot miss the flip side of the coin: many digital tools have been used to erode security and violate privacy.

Data security risks warrant an urgent need to foster effective global digital governance in a world with growing interconnectivity, in order to safeguard national security, public interests and individual rights of all countries. In recent years, digital security issues have become a major source of concern worldwide.

Cyber attacks, as well as massive data fraud and threats, have ranked among the top five global risks for two consecutive years, according to the Global Risks Report 2019 published by the World Economic Forum.

For some time, the international community has been making steps forward in finding a solution to challenges posed by digital security issues. In June last year, a panel appointed by the United Nations released a report titled "the age of digital interdependence," providing recommendations to maximizing the benefits and minimizing the harms of digital technologies.

Despite stakeholders worldwide making progress over the issue, cyberspace has been exploited by certain countries as a new realm for double standards and hegemonic practices that harm personal privacy and national security.

Edward Snowden's revealing of U.S. surveillance program Prism, documents published by Wikileaks, and reports on the Equation Group have exposed the fact that the United States has been, for a long time, behind numerous activities that tap into user data of global tech giants and spy on other countries, including U.S. allies.

Ironically, some politicians in Washington have made a countercharge, touting the so-called Clean Network program and purging digital tech firms of other countries under the pretext of national and digital security.

Such bullying acts make the need for forming global digital security rules more urgent than ever.

Earlier this week, China proposed its global initiative on data security with three principles which include upholding multilateralism, balancing security and development, and ensuring fairness and justice. The initiative reflects China's determination and sincerity to work with all to safeguard digital security.

Upholding multilateralism is the first step toward enhancing global digital governance. With the aim of pursuing mutual growth, countries should find common ground and shelve differences, and develop a set of international rules on data security that respect both the will and interests of all.

Worldwide countries should also not ignore the importance of balancing security and development, as protecting data security is a prerequisite for sound digital growth. Countries have the right to protect data security according to law, and should provide an open, fair and non-discriminatory environment for all businesses, as the initiative points out.

Russia ready for honest dialogue with US on election interference – top diplomat

**MOSCOW** 

MOSCOW is ready for honest dialogue with Washington regarding the accusations of interference in the US elections, Russian Foreign Minister Sergey Lavrov said on Friday during a press conference on the outcomes of the talks with Chi-

nese Foreign Minister Wang Yi. "We are open for honest dialogue [regarding interference in the US elections]. However, for the dialogue to be honest, it is necessary to formulate one's claims clearly, so that they

can be understood," he said. Lavrov noted that Russia had repeatedly offered the US to discuss "the absolutely baseless accusations" on US election interference. "We offered to relaunch cybersecurity consul-

We offered to make an official bilateral political statement by Russia and the US in which we both categorically undertake not to meddle in each other's domestic affairs. This has been going on for several years. The Americans continue to slack off in all of these areas, still demanding that we stop the unlawful interference in their domestic affairs," the minister

The minister recalled that several years ago, the US approved a law in support of Ukraine, in accordance with which the US Department of State must spend \$200 mln a year on direct financing of Russian non-governmental organizations and on working with the Russian civil society. 'The US itself does not see anything untoward in promoting its interests via illegitimate means on the sly or even approving laws openly. If it's not interference in domestic affairs, then I don't know what it is," he stressed.

The minister also pointed out that in the run-up to the presidential election planned for November 2020, US politicians are often asked about who meddles in their election more: Russia, China or Iran.

## Two years after signing peace deal, South Sudan remains at crossroads

AFTER five years of brutal civil war, several South Sudanese parties signed a revitalized peace agreement in the Sudanese capital Khartoum on September 12, 2018, following ten months of intense negotiations.

Two years on, the peace deal is yet to produce tangible results as political crisis and violence, food insecurity and economic meltdown continue to ravage the world's youngest nation. "I was happy when the peace deal was signed in September 2018 because I thought it was the end of the suffering," said Majok Yen,

who has lived in the UN Protection of Civilians (POC) site in Juba since 2013.

The initialization of the peace agreement provided renewed hope for a return to peace and stability in the east African country. "I feel our leaders have let us down because for over two years, we are still suffering and people

continue to die," he added. "We have been crying for peace to come to our country, but I'm disappointed that two years since the signing of the peace agreement, nothing much has changed in South Sudan and the people continue to suffer," Nelson Sworo, a Juba resident told a local radio station on Saturday morning. "I blame our leaders for the current problems because they only care about their own interests but not the common citizens," he added.

According to a recent report by the United Nations Mission in South Sudan (UNMISS), sporadic violence has killed over 600 civilians in the past six months of

Half of the country's population of an estimated 12 million people are food insecure, and over four million have been displaced both

internally and externally. "It is unacceptable for South Sudanese to continue bearing the burden and consequences of this conflict including impunity, rape, severe hunger, displacement and almost complete lack of services," the Women Monthly Forum, a pressure group that brings together over 40 South Sudanese peace advocates, said in a joint communique on Friday.

The campaigners said that since the signing of the peace deal in 2018, nothing much has changed in South Sudan because violence, economic hardship and human rights abuses have continued unabated.

The group is particularly concerned about the recent escalation in fighting between government troops and forces of holdout rebel group, the National Salvation Front of Thomas Cirilo Swaka in Central Eqautoria state and upsurge in inter-communal violence in several parts of the country.

"We note with concern that security is not only the absence of conflict but the guarantee of freedom of movement, access to resources, food, water, shelter and education, and more importantly a general sense of safety," said the

## US Open winner Osaka hints at more race activism

NAOMI Osaka said she wants to be known for more than just tennis, suggesting she will keep campaigning for racial justice after winning her third Grand Slam at the US Open Saturday.

Osaka, of Japanese and Haitian heritage, wore different masks honoring victims of systemic racism and police brutality in the United States in each of the tournament's seven rounds.

The 22-year-old said thinking time during the coronavirus lockdown, which coincided with protests across the United States over the police killing of black man George Floyd, had led to her political

"I would definitely say it's been an important few months," Osaka told reporters after coming from a set down to beat Victoria Azarenka 1-6, 6-3, 6-3, inside Arthur Ashe Stadium.

"For me, my life was always go-go tennis-wise, especially after the previous US Open that I won (in 2018). It definitely accelerated things, and I've never had a chance to slow down.

"The quarantine definitely gave me a chance to think a lot about things -- what I want to accomplish, what I want people to remember me by. I came into this tournament, or these two tournaments, with that mindset.

Osaka first took an activist stance at the Western & Southern Open, a US Open tuneup event, when she threatened not to play her semi-final match in protest at the police shooting of black man Jacob Blake in Wisconsin.

She said she was "sick to her stomach" and "exhausted" by repeated violence against black people by US police.

Her decision prompted the WTA and ATP to postpone all semi-final matches by a day, inspiring Osaka to change her mind

and make herself available for the final.

Osaka's move came after the Milwaukee Bucks led a historic boycott over the shooting, forcing the NBA to halt its playoff schedule and prompting a wave of walkouts across multiple sports.

She walked onto the court for her first match at the US Open wearing a mask bearing the name Breonna Taylor, a 26-year-old emergency medical technician who was killed when police shot her in her own apartment in March.

Osaka then donned face coverings honoring Elijah McClain, Ahmaud Arbery, Trayvon Martin, George Floyd and Philando Castile.

In Saturday's final she honored Tamir Rice, a 12-year-old African-American boy who was shot dead by a white police officer in Cleveland, Ohio in 2014.

During the tournament Osaka received video messages from Arbery's father and Martin's mother thanking her for her bringing worldwide attention to their sto-

She said Saturday that she would like to meet relatives of the victims.

"Definitely. I feel like for me I learn more through experiences. For me, I feel like sharing stories and hearing people's experiences is very valuable," she said.

Osaka added that her boyfriend, the rapper Cordae, who supported her from the stands at the US Open, had influenced her views about racial and social justice.

"I've read a lot into Haitian history. My dad always talks about that," said Osaka.

"For me, my boyfriend's really like into reading a lot, so he's been passing me

"I try not to get most of my information from the news. I try to form my own opinion sort of."

## Welcome back: Lakers, LeBron headed to the conference finals

LAKE BUENA VISTA, FLA.

THE Los Angeles Lakers are going to the conference finals for the first time in a decade, ending the longest drought in franchise history.

LeBron James is going there for the first time since 2018. For him, that also qualifies as ending a drought.

James scored 29 points and the Lakers wrapped up their first trip to the Western Conference finals since 2010 by topping the Houston Rockets 119-96 on Saturday night in Game 5 at Walt Disney World.

"It's the reason I wanted to be a part of this franchise, to take them back to a place that they were accustomed to being – and that's competing for a championship," James said. "It's an honor for me to wear the purple and gold, and for us, we just try to continue the legacy."

Kyle Kuzma scored 17 points, Markieff Morris had 16, Danny Green added 14 and Anthony Davis finished with 13 for the top-seeded Lakers. They will play either the second-seeded Los Angeles Clippers or third-seeded Denver Nuggets for the West title in a series that won't begin before Wednesday.

James is going to the conference finals for the 11th time overall – six with Cleveland, four with Miami and now with the Lakers. It's his ninth time getting to this round in the last 10 seasons; the one miss in that stretch was last season, when his inaugural year with the Lakers fell apart because of injury and the team missed the play-

"The opportunity to play for a championship, that's what we're all here for, that's what we all signed up for," James said.

James Harden scored 30 points, Jeff Green scored 13 and Russell West-

"We've got a great organization, great city, great fans, team's great," D'Antoni said. "I mean, everything's good here. We'll see what happens, but I couldn't ask for a better situation. I had four years and hopefully it keeps going. You just never know."

It was a tough end to a tough week for the Rockets.

that game.' Houston won Game 1 of the series and lost the next four. ## Brazilians Willian, Gabriel now deliver on debuts in Arsenal win

OPENING day glory for Arsenal, and with Brazilian duo Willian and Gabriel instantly making a difference on their debuts.

Not every opponent Arsenal faces during the rest of the season will, however, be as easy to roll past as Fulham was on Saturday.

For now, Mikel Arteta will savor opening his first full English Premier League as manager with a 3-0 victory produced by a trio of assists from Willian, including for Gabriel's second-half header.

"I don't think it gets much better than that," Arteta said. "It's really good for them, for their confidence, their belief and to settle in the group quickly. That's always a challenge when you bring in new players, but the way they played today and the commitment they showed with the boys was ter-

Willian was back in west London where nearby Chelsea released the 32-year-old winger at the end of last season, which ended only seven weeks ago due to disruption caused by the pandemic.

The free signing took just eight minutes to make an impact with a close-range shot parried by goalkeeper Marek Rodak and tapped in by Alexandre Lacazette.

It was a corner from Willian four minutes into the second half that allowed Gabriel to claim a goal to cap a commanding defensive dis-

"Gabriel was solid as a rock," defender Rob Holding said. "He won everything aerially and finished off with a nice goal as well."

The center back, who joined from Lille for 30 million euros (\$35 million), benefited from slack defending himself as he was left unmarked to head into the net.

"He had only trained (for) a few days with the team," Arteta said. "He hasn't played a competitive match in six months. So obviously

really well, physically he felt good

and he was a handful."

"You need to learn from it, you need to develop, you need to be big enough to understand where the mistakes are made."

The Premier League started a month later than scheduled due to the pandemic that is still preventing fans from attending games.

Arsenal has already played once this season without fans - winning the Community Shield at Wembley Stadium.

Lackluster Liverpool's escape against Leeds United may be a warning sign

AST season, it took nine games for Liverpool to spill its first Premier League points. It took 18 more games to lose points for a second time as the Reds rampaged to the title.

This season, one game was very nearly all that was needed for Liverpool to stumble. The Reds barely escaped Saturday's madcap 4-3 victory – with four disallowed goals, two for each side - over a newly-promoted and utterly scintillating Leeds United. It was a bout between the current Premier League champions and a team that had reached the Champions League semifinals in 2001, only to be relegated to the Championship in 2004 and the third-tier League 1 in 2007.

On paper, you would expect the champions to steamroll a newly promoted team. But Leeds is managed by Marcelo "El Loco" Bielsa. The Madman. For his eccentricities. For his tactical genius that's inspired a generation of elite coaches like Pep Guardiola. For his habit of quitting jobs within months or even days. For doing things like rearranging the Leeds parking lot. For working something bordering on magic with previously pedestrian teams. For figuring out a gameplan against one of the sport's best teams that made a bunch of Premier League debutants instantly competitive.

His counterpart on Saturday, Jurgen Klopp, has a job on his hands that couldn't be more different from Bielsa's, which is staying out of the three bottom places in the league. Klopp has to keep his team atop its perch atop the table. And that's just as difficult.

Sometimes, the trick to doing so isn't to keep the squad's core together, but rather to break it up. There is danger in allowing a team to be taken apart too soon. There is equivalent peril in letting it stay together for too long. With the same faces, year after year, it all becomes a bit routine, a little stale. Complacency sets in.

When that point is, exactly, depends on the team, and it takes an exceptionally deft manager to know when to demolish a team he crafted so carefully and rebuild it. Sir Alex Ferguson was a master at it with Manchester United. The ongoing chaos at Barcelona demonstrates what can go wrong when a core is kept intact for too long, or the plan for its replenishing goes wrong, at any rate.

Now that same task falls to Klopp, after reaching the Champions League final twice and winning the club's first Premier League title in 30 years in the last three seasons.

The defending champions have been together a long time. Of the starters for Saturday's season-opening letdown against Leeds, nine had been at the club since at least the 2017-18 season. The other two, Naby

Keita and goalkeeper Alisson Becker, joined the following year. In that time, there has been little by way of fresh blood. So far this season, the sole reinforcement is Kostas Tsimikas from Olympiakos, to offer some cover at left back. In soccer, that little turnover is un-

usual. To be together that long, unchanged, is an eon.

Klopp is betting that he can coax more from his team, that he can keep things fresh without introducing fresh faces. And when you consider that captain Jordan Henderson is his oldest regular, having only turned 30 in June, there shouldn't be anything precluding more success on account of his squad's physical wellbeing. His players are, without exception, in their prime playing years.

It will all boil down to the psychol-

ogy. To the mentality.

"We will not defend the title, we will attack it," Klopp has said on several occasions.

"People will be afraid that these boys will get lazy but it's just not in their nature," he added, per The Athletic. "We will not stop. This team will not stop wanting it. I think there is a lot to come."

As Klopp sees it, his Reds aren't at the end of a cycle but in the middle

This season will have to bear that out. Was last spring's early Champions League exit a portent? Or what about the fact that Liverpool went an uncharacteristic 5-2-2 after the restart this summer, nothing like its blistering form before the pandemic layoff? Was that perhaps a sign of the rot setting in?

There's no telling from the evidence of Saturday's single game, a splendid affair with an insurgent side high on its return to the top level and the ideas from a tactical genius. Liverpool looked hungry enough, certainly, hounding Leeds early on and earning a penalty just three minutes in, when Mohamed Salah's shot struck Robert Koch's outstretched arm. It was the first goal of Salah's

But the game wasn't decided until the final minutes. Leeds' record-shattering signing Rodrigo, newly arrived from Valencia, made a dumb foul on Fabinho in his own box, allowing Salah to finish his hat trick from the same place he started it, the penalty

For Liverpool, it was uncomfortable. To Leeds, it was disappointing. Disappointing to have gotten within a few minutes of taking a point from the defending champions, from the European champions of two seasons ago. From a Liverpool that might have become vulnerable.

Or maybe it hasn't. That is for Klopp to suss out.

## FIFA on trial as Valcke, Al-Khelaifi trial begins in Swiss court

FIFA's disgraced former secretary general Jerome Valcke and Paris Saint-Germain chief Nasser Al-Khelaifi go on trial in Switzerland on Monday in the latest chapter of football's seemingly endless corruption

The two men have been indicted for alleged corruption in the attribution of football broadcasting rights -- Al-Khelaifi is also the boss of beIN Media.

The hearing, which has already been delayed because of the coronavirus, is scheduled to last until September 25 at the Federal Criminal Court of Bellinzona. But it will open under another cloud as suspicions of collusion between the Swiss prosecution and FIFA have undermined its credibility.

Centre stage is Valcke, former right-hand man of ousted FIFA president Sepp Blatter, who appears in two separate cases of television rights corruption -- he faces up to five years in prison if found guilty.

The 59-year-old Frenchman stands accused of wanting to transfer the Middle East and North Africa rights for screening the 2026 and 2030 World Cups to the Qatari giant beIN Media, in exchange for "unwarranted benefits" from Al-Khelaifi.

According to the prosecution, the case relates to a meeting on October 24, 2013 at the French headquarters of beIN, when Al-Khelaifi allegedly promised to buy a villa in Sardinia for five million euros, granting its exclusive use to Valcke.

Al-Khelaifi, who has denied the charges, was then to hand the property over to the Frenchman two years later under certain conditions.


