



'No guarantee world can find vaccine usable on coronavirus'

LONDON

ONE of the world's leading experts on the new coronavirus has said there is no guarantee that a vaccine will be successfully developed, implying that the threat is going to loom "for the foreseeable

"You don't necessarily develop a vaccine that is safe and effective against every virus," Britain's David Nabarro, a professor of global health at London's Imperial College, and a World Health Organisation envoy on COVID-19, said here on Saturday.

"Some viruses are very, very difficult when it comes to vaccine development so for the foreseeable future, we are going



in pre-clinical stages to have to find ways to go about our lives with this virus as a constant threat," added Nabarro.

"That means isolating those who show signs of the disease and also their contacts," he said. "Older people will have to be protected. In addition hospital capacity for dealing with cases will have to be ensured. That is going to be the new normal for us all."

Over 60 potential vaccine candidates and treatments for coronavirus are being developed in labs around the world, most in pre-clinical stages.

US pharmaceutical Moderna began clinical trials last month, and Oxford University scientists are to commence human trials this week. Another group

Ministry clarifies on Covid-19 face masks

FORMAL government guidelines on proper use of face masks have been set out after chaotic orders and tailoring spree as people rushed to obtain inhibitors of Covid-19 infections.

Dr Faustine Ndugulile, the Deputy Minister for Health, Community Development, Gender, Elderly and Children, told the National Assembly in Dodoma that surgical masks are the most effective in preventing infections, not those made of simple clothing.

He said surgical masks, known technically as N95 respirator types should only be used by health workers taking care of Covid-19 patients.

"The surgical masks should be worn by people in public places for four and six hours and disposed of as they are not meant for reuse," he said in a parliamentary written down As for cloth masks, Ndugulile said they are

not as effective as N95 respirator and surgical masks but can still be used "to reduce the possibility of transmission" in public and work "The cloth must be made of cotton and the

mask should have more than two layers. One person should have at least two masks to allow for washing and ironing of the same," he said.

Earlier, the parliamentary shadow Minister for Health, Cecilia Paresso issued a statement calling for clear guidance, saying wearing any mask made of anything as some people had started doing was likely to expose more people to Covid-19 than protect them.

Z'bar: 23 new COVID-19 cases, while two patients die at home

ZANZIBAR yesterday announced the confirmation of 23 new Covid-19 cases in the Isles and two deaths that occurred at home.

Health Minister Hamad Rashid Mohamed said in a brief statement that the total number of confirmed cases in the islands now stands at 58 and three fatalities, with two new cases being registered in Pemba.

Out of the 23 new cases, 21 are Tanzanian nationals while two are foreigners who are residents of Zanzibar," he said.

The two foreigners who have contracted the disease in the Isles are citizens of France and Cuba. "I call upon Zanzibaris and foreigners living

here to take precautionary measures against coronavirus. The most important is to avoid unnecessary movements and gatherings," said

Mohamed however, did not divulge further details about the two patients who succumbed to the highly contagious disease at home and what was being done to contain further spread in their neighbourhoods.

The country's tally has now reached 171 cases when the 23 Zanzibar cases are added to the total 148 registered countrywide by last Friday.

Ummy Mwalimu, the minister for Health, Community Development, Gender, Elderly and Children, said on Friday that patients on

Govt all out to revive, directly export horticultural produce

A STRATEGY to revive the country's horticultural industry with direct export of flowers, fruits and spices produced in the country will soon be unveiled.

It seeks to change the current situation whereby most horticultural produce from Kilimanjaro and Arusha regions is sent abroad via Kenya and counted as belonging to the neighbouring

Agriculture minister Japhet Hasunga said here at the weekend that in the strategy, the government will review various levies to attract cargo services of international airlines to land at the Kilimanjaro International Airport (KIA), the Julius Nyerere International Airport, along with Songwe and Mwanza airports.

Hasunga spoke when he joined with various private institutions in viewing products of the Tanzania Horticultural Association (TAHA) at KIA,

Zanzibar confirms 23 new COVID-19 cases, with 2 patients dying

the Mainland were in Dar es Salaam, Mwanza, Kilimanjaro, Coast, Lindi and Kagera regions.

With Dar es Salaam having majority of cases, Lindi and Coast regions registered their first cases end of last week while Kagera and Mwanza registered second Covid-19 cases.

She said 11 of the patients had recovered and were discharged from treatment centres.

As of yesterday, globally confirmed cases surpassed 2.35m with over 161.000 fatalities and more than 0.6m recoveries. The coronavirus has affected virtually all countries and territories around the world.

Millions of Orthodox faithfuls in Russia yesterday celebrated Easter with churches closed and services broadcast on TV and online in an attempt to slow the pandemic.

In Moscow the main Easter vigil was held with no congregation. The patriarch told those following at homes that this was to protect them from a "terrible illness."

President Vladimir Putin, who normally attends mass with the patriarch, sent a video message to the nation instead. He assured people that things were "fully under control" and said Russia would come through the "trial" it had been sent.

On a positive side, while countries around the world are trying to prepare a lockdown exit strategy, Denmark is

one of the first nations to have already started lifting restrictions.

Primary schools and nurseries are already open, and small businesses, including hairdressers and beauty clinics, were allowed to open from yesterday.

Iran has become the latest country to ease restrictions by allowing bazaars and shopping malls to reopen from Sunday as part of an easing of lockdown restrictions. Some shops and businesses were allowed to open again on Saturday but Sunday's openings apply to "medium-risk" businesses.

Israel has already allowed some types of shops to reopen, although shopping malls must remain closed for the time being. Poland is gradually lifting lockdown measures from Sunday, with shops among the businesses allowed to reopen.

Europe's largest economy, Germany, will allow shops of up to 800 square metres as well as car dealers and bike shops, to open their doors again.

Covid-19: MP wants police punished

Homa Bay Town MP Peter Kaluma has asked the government to take allowed the 'mourners' to travel from Nairobi to Homa Bay County.

He termed it irresponsible for the officers to allow people to travel from Nairobi and other counties under lockdown as the country battles Covid-19.

He called on Health Cabinet Secretary Mutahi Kagwe to round up the police officers who were manning the roadblocks at the time the said individuals travelled.

The legislator added that the officers should be tested for coronavirus, quarantined and face prosecution for corruption and criminal negligence.

This is comes after the driver of the vehicle which was transporting people to a funeral to Homa Bay tested positive for Covid-19 after passing a number of roadblocks before security officers in Homa Bay got suspicious, opened the coffin and found it empty.

"The government should make public the measures it has put in place to ensure that individuals permitted to travel from Nairobi and other counties under lockdown are tested before being allowed to travel," said Kaluma.

He raised alarm that no serious contact tracing, mass testing and extensive quarantine has been done

by government in the affected area of Homa Bay County to contain the spread of the disease.

Meanwhile, a second group of action against police officers who mourners who sneaked out of Nairobi to Homa Bay County on Saturday have been quarantined at Homa Bay Kenya Medical Training Centre.

In the same vein, Deputy President William Ruto will be operating at least once a week from Jubilee Party headquarters located in Pangani as he takes the fight for the ruling party to the doorstep of his rivals.

Ruto will be operating from Jubilee in his capacity as the deputy party leader to "reclaim the party".

The move will likely escalate the tension since ordinarily, it is the secretariat that runs the day-to-day activities of the political parties.

Two MPs who spoke to the Press and did not want to be named said those behind the strategy (working from Pangani, Nairobi) are keen to intimidate Uhuru allies so as to back off.

The thinking in DP's camp is that the president, whom they seem to have studied over some time now, will likely recall his troops if he feels the intended objective will be drowned in the ensuing anarchy.

Jubilee Vice-Chairman Murathe, an Uhuru ally but a Ruto critic, said the DP is welcome at the party offices anytime.

Dr Reginald A. Mengi legacy

"I grew up in poverty, but I always saw it as a challenge. The good thing is that you can surmount a challenge if you are willing to pay the price. The price is hard work."

EMEMBERING Dr Reginald Abraham Mengi as a public figure is hard to bring down to one thing, or to a particular point of focus.

This is for no other reason than that his involvement in a wide range of activities as well as his achievements in those engagements just can't be brought under a specific or particular sphere of society.

Dr Mengi emerged into the league of those special individuals who tower above their business sector confinements to go deep into the greater society.

Individuals are not just a product of circumstances; they help to model conditions in society so long as there is a starting point, for talent - or money to work.

There are spheres of involvement that can be attributed to professional engagement, which for Dr Mengi was the case at the beginning.

For instance, the fact that he was once a professional auditor means that his tenure at the National Board of Accountants and Auditors (NBAA) could entirely be related to his training and his career as a 'partner' at Coopers and Lybrand.

However, his next vital engagement at a public or countrywide level - that is, the chairmanship of the National Environmental Management Council (NEMC) - arose out of his pointed activism in that direction.

In several other areas there was pointed leadership of corporate interests in the respective fields, among them industry and the media sector, while others arose out of philanthropy.

Explaining this sort of involvement requires some models and the proper starting point, if one can hazard something to that effect, is a kind of supply and demand scenario.

It can also be a demand-driven matter - that all these areas at a certain point needed leadership, and Dr Mengi rose to the occasion and supplied the leadership precisely needed as appropriate.

Here there is a sort of convergence of personal ability and creativity and a clear sense of need expressed at the public level in relation to this or that matter. But there is also his ability to sense what was relevant or needed to

be done.

It is that aspect rather than merely

support that may explain Dr Mengi's overlapping presence in numerous

nearly at the same time.

In order to even be interested in all

to be an element of genuine concern for society. It cannot be articulated the ability to extend direct financial areas of societal leadership needs these areas at the same time, there has merely for the sake of obtaining this

or that sort of benefit. After all, in all of his pursuits, Dr Mengi tended to use money rather than gain it.

Still, the goodwill so created plus the business acumen worked to enable his proper business interests to climb one bottleneck after another and safely cross most of the stumbling blocks.

Many gurus argue that caring for others - call it altruism or philanthropy, if you will - is something that often helps to propel individuals to greatness.

But the kind of benevolence that society expects from such a person would soon thin out. Dr Mengi must have been clear on this, which is why many say the gist of his "message" to the world was that he simply felt compelled to help, everywhere.

Some of Dr Mengi's engagements came from socially felt challenges and he wished to demonstrate that, to steal from Father of the Nation Mwalimu JK Nyerere, "it can be done, if you play

Dr Mengi's professional life was little more than a demonstration of this axiom as there was something of a rise 'From Goatherd to Governor,' - as a probable role model of his, Edwin Mtei, put it in a much-acclaimed autobiography.

At one point, as board chairman for the Tanzania Standard Newspapers Ltd, Dr Mengi directed that one of the newspapers in the stable - Daily News/ Sunday News - be improved from 12 pages to 16 pages.

But the management (and definitely portions of the board) kept saying that it wasn't possible. It is said when Dr Mengi went on safari, and the papers promptly resumed their 'natural' size.

When he came back, board chairman Dr Mengi opted to resign from the board chairmanship and show the board and the management that "it can be done if you play your part".

Dr Mengi thus went into his own newspaper venture, where his newspaper had 16 pages from the start, adding or reducing pages as time went by, on account of operational and wider economic considerations.

But the point was made as to the capacity of the market to take up a 16-page paper - if there is the right aptitude in terms of management.

That was but one illustration of the sort of problems Industrialist Dr Mengi solved with vision and determination, not just with cash.

Police hold man, say he has role in killing of council chairman's wife

POLICE in Ruvuma Region are holding one man for interrogation following death of one Joyce Nespory Pilly (32), the wife of the chairman of Songea District Council Rajabu Mtiula.

Joyce's body was later found in the forest.

Speaking to reporters in his office at the weekend Ruvuma Regional Police Commander Simon Maigwa said the incident happened on April 16, this year during the night at Ngongano village in Litapwasi ward in Songea district.

RPC Maigwa said on April 17, this year at around 7.00 am while he was in his office he received a report from Songea Central Police Station, saying Rajabu Hassan Mtiula (61) his wife's body had been found at Mkurumusi forest in the vicinity of Ngongano village.

Maigwa said thereafter police were sent to the area to search for the woman's body.

The hunt was conducted during the night from house to house without success, and added police—continued with the hunt the next morning and by 7.00 am they found Joyce's body at Mkurumusi forest.

Maigwa said the motive of the murder was yet to be established, saying that they are holding one man whose name was not given because investigation was ongoing to find other perpetrators.

Two villagers injured as rogue hyena strikes

TWO residents of Ngogwa village in Kahama town in Shinyanga region escaped death in a hyena attack after they tried to chase away the beast. The beast had attacked a herd of goats in the village.

The village executive secretary Upendo Shirima said the incident occurred on Saturday morning when the hyena attacked a goat's shed before they started beating it up.

In defence the beast attacked two villagers who and were rushed to Kahama district hospital for treatment.

He mentioned the names of the victims as Donald Simoni (27) and Furaha Ngusa (46). He called upon the Natural resources Ministry to to hunt for the hyenas whose numbers have increased in recent months.

He said fear has gripped the villagers as they beasts are now coming out during day time instead of night as they normally do.

The Councillor Ngogwa Ward Kamuli Mayuga said after receiving treatment at the hospital the two victims were discharged and called on the wananchi to take great care of the beasts.

On April 28, 2019, a group of hyenas have attacked five villagers and killed five goats in of Shinyanga region.

Peter Emmanuel, a councilor for Kilago ward in Shinyanga region, said the hyenas attacked the villagers on Sunday night.

He said the five villagers were attacked and injured when they tried to chase them away from the villages, adding the conditions of three of the five attacked villagers were still unstable.

"The villagers are being treated at Kahama district hospital. The attack by the hyenas has caused panic among villagers," said the official.

Electoral Commission to relocate to Dodoma as new building ready

THE National Electoral Commission (NEC) will soon relocate to Dodoma as its new building nears completion.

According to the contractor carrying out the project, the implementation of the project is now at over 90 per cent. The contractor, SUMA-JKT, was

expecting to hand over the project any time soon, according to the operations commander, Major James Philemon.

The news comes as the country prepares for the next general elections later this year, as President John Magufuli insisted last month that the elections were still intact even as the country continues battling the deadly Covid-19 pandemic.

This means, the national electoral body will soon relocate its activities from Dar es Salaam to Dodoma, and for the first time, the election results for the next general elections will be announced from the country's capital.

SUMA-JKT operations commander announced here shortly after a media tour at the facility to oversee the ongoing construction of NEC office at Njedengwa area in the outskirts of Dodoma city.

The project is now being undertaken by the National Service-SUMA JKT after the first contractor - Tanzania Building Agency (TBA) was relieved for failure to cope with contract biding agreed pace.

The contract between SUMA-JKT and NEC was signed on January 7, 2020, after which the army started clearing the area for the project. According to Major Philemon, the actual construction begun on January 17.

Immediately after the signing ceremony, NEC director of elections Dr Wilson Charles insisted that all activities in the 2020 general elections at the national level will be conducted in Dodoma as the project to construct new headquarters nears completion.

Dr Charles, who accompanied NEC chairman Professor Semistocles

Kaijage gave an assurance when he visited the project site in January, 2020, insisting that the implementation of the project would be completed in April.

This means, the construction of the building will be completed in just within four months, and this according to the head of National Service, Brigadier General Charles Mbuge, the army was fully committed to ensure that all projects under SUMA-JKT were completed on time and with high quality and efficiency.

"The army works for 24 hours that is why you have witnessed many of our projects being handed over to our clients on time," said Mbuge.

Lazaro Masanja who is Suma JKT project manager said at the weekend that he expects to hand over the completed project at high quality and standards.

Stamico conducts outdoor workplace training on coronavirus

THE State Mining Corporation (STAMICO) has joined other public and private institutions in the country in cautioning their staff to take precautions against the deadly coronavirus disease (COVID-19).

In achieving this, STAMICO management organised a oneday outdoor training for its Dar es Salaam-based staff and were encouraged to protect themselves against Covid-19, and told to report immediately to selected health facilities as soon as they detect symptoms of the disease.

The staff were told that timely medical attention would help them to avoid potential impacts from possible infections.

A statement issued by STAMICO said the training was also geared at warning the staff against other infectious viral diseases such as Hepatitis B and HIV-AIDS.

STAMICO acting Director General, Dr. Venance Bahati Mwasse, has been quoted in the statement saying that work places where workers meet for a long time expose them to the risk of contracting the diseases.

"Dr. Mware encouraged STAMICO staff to be vigilant and follow the instructions issued by our government leaders, such as avoiding unnecessary gatherings, washing hands from time to time and continue to work with greater caution so that they can protect themselves (the institution's workforce) and their families," the statement said.

Among the steps that STAMICO staff and visitors have been told to observe to reduce the potential of contracting coronavirus include washing hands with soap, flowing water, use hand sanitizers and checking body temperature using thermal scanners while in office.

Another step was to organize different training sessions on how to avoid infection of viral diseases, the statement added.

In addition, the acting director general has pledged to continue checking infections at work place through cleaning of door locks using chlorine, fumigation and taking disciplinary measures against those who ignore this protective activity against infection.

In the training facilitated by two experts, Dr Macha Njile and Dr Ally Juma from the Special Unit for Prevention of Infectious Diseases under the Ministry of Health Health, Gender, Elders and Children, various topics on viral diseases were covered. The topics also included information on how the diseases are being transmitted, their symptoms and how to protect them.

STAMICO has been at the forefront in provision of training at workplaces, specifically regarding health and safety of employees where a total of 48 employees were able to be trained on Covid-19 and other infectious viral

diseases.

BRELA to save 63.2/- after relocating to new building

THE Business Registration and Licensing Agency (BRELA) is expected to save 63.2 million that was used as office rent per month after they received building that was used by Prison headquarters in Dar es Salaam.

This move is implementation of President Magufuli directives he had given in October 6, last year to all government institutions and companies to move from private buildings to government own buildings.

BRELA chief executive officer Godfrey Nyaisa received the building over the weekend from Prison Commissioner Uwesu Ngarama, who represented Commissioner General of Prisons (CGP), Suleiman Mzee.

The handover ceremony took place over the weekend at the then Prison Head Quarters in Dar es Salaam along junction of Sokoine and Shaaban Robert street.

Speaking at the ceremony, Nyaisa said the next move is to handover the building to the National Housing (NHC) for renovations before they move into the building.

Nyaisa congratulated the government under the leadership of President John Magufuli for the building which he said

would help his institution to save a lot of money which were used for rent in a private building.

"For a long period BRELA has been using a lot of money to pay for the rent in private buildings, but for this help BRELA will save 63.2 million that were used every month" said Nyaisa.

October 6, last year while in Rukwa during the launching of Tunduma-Sumbawanga road, President Magufuli said some government institutions and companies have been using a lot of money to pay as rent to private buildings.

"We have a lot of government buildings but some government institutions and companies still rent in private buildings...for those who will continue in private buildings make sure vou have reasons," cautioned President Magufuli.



conversion of forestland to agriculture and livestock production areas, threatens not only the livelihoods of forest dependent communities and indigenous peoples, but also the variety of life on our planet. Land-use changes result in a loss of valuable habitats, land degradation, soil erosion, a decrease in clean water and the release of carbon into the atmosphere.

Losing forest biodiversity means losing important sources of medicine, food, raw materials and employment opportunities.

Achieving the 2030 Agenda for Sustainable Development, including

the 17 Sustainable Development has continued to provide technical Goals (SDGs), is a commitment made by countries to tackle the complex challenges we face, from ending poverty and hunger and responding to climate change to building resilient communities, achieving inclusive growth and sustainably managing the Earth's natural resources.

While the importance of forests and trees to a healthy, prosperous planet is universally recognized, the depth of those roots may be greater than imagined. Several indicators under SDG15 focus on forests, specifically monitoring forest land and the share of forests under sustainable management.

Bearing in mind the important role that forests play in conserving Deforestation, chiefly caused by the biodiversity, FAO is working with governments of the Member States across the globe to ensure that these resources are utilized in a sustainable manner.

> For instance, through the Global Forest Resources Assessment (FRA), FAO is supporting countries across the globe including Tanzania by strengthening capacities for collection and analysis of official national statistics on forest resources to enable them ensure sustainable use of their natural resources. This way, FRA plays a central role in monitoring progress towards the SDG 15 - Life on Land.

For some years here in Tanzania, FAO

support for the development of the first ever-comprehensive National Forest Inventory - the National Forestry Resources Monitoring and Assessment (NAFORMA).

FAO has also been supporting the Government of Tanzania by providing both technical and financial support for conducting assessments and studies on forests and biodiversity; community forestry based management; forest tenure in the framework of the Voluntary Guidelines on the Responsible Governance of Tenure (VGGT); forestry for sustainable food security and nutrition; cost-benefit analysis of forestry interventions for supplying woodfuel, among others.

With regard to forestry governance instruments- policy, legal and guidelines, FAO has supported the review of the National Forest Policy; development of the National Forestry Policy Implementation Strategy; and currently, review of the National Forestry Management Act.

Managing forests sustainably, and restoring degraded ones, is crucial for people, biodiversity and climate. Forests and Biodiversity are indeed too precious to lose!

2,000 trained Ebola contact tracers being sidelined for 6,000 new Covid-19 'recruits'

By Mosoka P. Fallah

HAVE tried to remain focus on the COVID-19 response over the past several weeks Las I am convinced that if it becomes explosive it would cause irreversible damage to our very existence as a people and as a country. I have remained silent while working 20 hours a day when a few journalist wrote that I should not be confirmed because I prevented Liberians from getting their just benefits from the ebola virus. While this accusation was laughably unfair to me. I chose to remain silent. My silence was never an admission of guilt but I felt that the lives of the 4.5 million Liberians rest on my conscience and on the heads of other like-minded colleagues who are active in this Coronavirus response.

I am now constrained to respond to the article written by Rodney Sieh on April 11, 2020, the publisher of the Front-Page Africa under an article captioned, "LIBERIA: 2,000 TRAINED EBOLA CONTACT TRACERS BEING SIDELINED FOR 6,000 NEW COVID-19 'RE-

In this article he intimated that we failed to recruit 2.000 trained contact tracers for COVID-19 response and that the 6,000 persons recruited by the MCC/NPHIL team are more than all of the teams across the country. He further went on to write that prior to taking over as Director General of NPHIL, I was head of an NGO, named and style Rescue Place International and the my NGO has become a party to this efforts to recruit

which according to the article, torate to help to bring health presents a potential conflict of interest. It was also reported that the Community-based Initiative (CBI) that I founded during the ebola was now being sidelined for the MCC.

In the next few paragraphs, I will attempt to address the issues raised in this article and offer clarity. I am convinced that information cited in the article was provided by corrupt and misguided individuals with no credibility...

Conflict of Interest and using Rescue Place International to benefit from the recruitment of the 6,000 active case finders

I had hoped that my learned publisher would have taken the time to grant me a fair chance to explain myself and my patriotic contribution to our dear country Liberia without any conflict of interest. Firstly, none of the employees of Refuge Place International works with the COVID-19 response team. They are currently involved with the management of our NGO clinics. Secondly, I did not transition from the Founder/CEO of Refuge Place to my current position as Director General of NPHIL. I was appointed as the Deputy Director for Technical Services by Former President Ellen Johnson-Sirleaf, after I helped to build NPHIL. From my appointment in 2017 until I was asked by His Excellency Dr. George Manneh Weah to serve as Director General, I was paid by PREVAIL Liberia and did not take a single dime from National Government as salary.

Thirdly, I founded Refuge Place International in Kentucky, the 6,000 active case finders, USA, when I was doing my doc-

care to poor Liberians. Since, my returned to Liberia in 2013, my board and I have completed 2 clinics that treated over 50,000 patients for free during the ebola outbreak. We are constructing additional 2 clinics in Montserrado County, 1 in lower Bong County and 1 in Lofa County. We have provided free lenses to over 2,000 students. All the funds for these projects have come from two major sources. Royer Charitable Foundation started supporting me since 2014, with the initial 3,000 US dollars, and increased it to \$120,000 in 2019. The second major funder is Liberia Mercy Partners that provides us \$1000.00 US dollars every month and in February of 2020 made a single donation of \$10,000 so we could build more clinics to serve our people. There have been some support from my classmates and board members in the US who believed in my humanitarian work in Liberia. When the COVID-19 preparedness began in December, of 2019, I quickly realized that we needed to quickly mobilize funds to enhance the sur-

contact identification and contact follow up. Contact tracing is a passive process that first waits for a case to be identified. When I deferred my trip back to the USA in 2014 to help my country fight the ebola crisis, I realized that contact tracing would never be sufficient to end the ebola outbreak. I then initiated community-level active case finding using the Tuberculosis model. There was nothing written at the time, I had to adapt the model to Liberia. At the height of the ebola outbreak, there were 5,700 active case finders and over 300 support teams. These were students, teachers, Imams, pastors, community leaders and even a 75 year old Kissi governor. Due to the moderate rate of transmission of ebola, we had 1 active case finders to cover 50 households to check for the sick, the

population of 1.3 million people the 5,700 active case finders was sufficient to ensure that all cases and the sick in Liberia were found and turned over to the contact tracers.

However, if you compare the transmission rates of ebola to COVID-19, you will realize that the rate of transmission of the COVID19 is higher than ebola. Since, 1976 when ebola was first discovered to 2020, there has been about 37,000 cases with an average of 50% deaths. However, from December, 2019 to April, 2020, COVID-19 has had 1.793,728 cases and 110,196 deaths. As a result of these factors, we have realized that we would need 15,000 active ers. Montserrado County needs an adcase finders to support the 2000 contact tracers. Given the fact that there is a higher risk of infection and the special protection it requires to do active

case finder to cover 20 houses a day to check for the sick and provide awareness messages every day for the next three months. We took into consideration that Montserrado County has 1,500,000 people and, at 5 persons per household, we determined that there are 300,000 households in Montserrado County. Hence, we would need 15,000 active case finders to cover the entire Montserrado County. Thus, the 6,000 active case finders was a welcome opportunity for us and would need to work closely with the Montserado County Health Team (MCHT) and incorporate other health workditional 9,000 active case finders to identify all of the potential cases and contain the current spread.

Africa's unique opportunity for post-pandemic rejuvenation

Γ has taken a tiny organism, SARS-CoV-2, to get even the most conservative traditionalists to accept that state institutions are essential to mobilising national resources to protect and promote the common good. The fragilities of neoliberal economics have been laid bare.

Institutional capacity in public health care systems, law enforcement and regulatory agencies, as well as the capacity of the state to commandeer production of essential goods and services, have become decisive interventions in this pandemic. British Prime Minister Boris Johnson, whose conservative government had for years underfunded the public sector, confirmed this unequivocally when he thanked the National Health Service (NHS) for saving his life after he was hospitalised with the coronavirus.

We have President Cyril Ramaphosa to thank for his leadership in mobilising national, continental and global public and private resources to enhance our capacity to tackle this pan-

The admirable collaboration between public and private health care institutions has laid an important foundation for a well resourced and run National Health Insurance (NHI) system. We can learn from Britain's NHS about what works and what doesn't, so we can build our NHI on a firmer footing.

There is no wisdom in hankering after the old socio-economic development models that brought us to the multi-layered global crises (climate, health and socio-economic) we face today. Post-pandemic socio-economic restructuring has to go beyond traditional notions of privatising stateowned enterprises and smaller government.

The entire global socio-economic system we have relied on has been exposed as fragile and a threat to both rich and poor in our society. No economy can prosper while excluding the energies and talents of the majority of its youthful population, as we have done since 1994.

We need to transform our economic and social relationships to build an inclusive prosperous democracy where wellbeing for all people and the planet are sustainably promoted.

Such a system would have to dispense with traditional ideological hangovers of pitting the private and public sectors against each other. We have to leverage the strengths of our very well developed private sector while broadening its base, recognising that its narrow base is a weakness and a missed opportunity for the entire

The future of the global economy lies in innovative enterprises that service the needs of local communities, as well as those of the nation and beyond, in mutually supportive ways. Lessons from China and other successful East Asian countries show how leveraging the strengths of both private and public sectors enabled them to build solid resilient systems able to withstand crises.

Small, medium and microenterprises have struggled to thrive in our society. This is largely because of both legal and institutional biases against them that undermine their access to credit and other essential support. Why should these enterprises be legally permitted to only access no more than a tiny two-and-a-half percent of assets held by major funds, despite being estimated to account for 98.5% of the formal economy and provide 28% of jobs? We need to fundamentally rethink this approach as we restructure our economy and strengthen support for sustainable livelihoods in all local

communities across the country. The Covid-19 crisis presents an invaluable opportunity for Africa to take advantage of its diaspora and get ahead of yet another round of colonialism in the new world order. The rise of nations leveraging the diaspora and minds of its people is well evidenced by the Jewish in the development of Israel; the Indians, especially the ones in the US, spearheading the technological revolution of India; and the model that condemns us to servicing

the development of the modern China through the 'Bamboo network'.

Africa's leaders need not despair nor look too far for African minds committed to developing practical strategic ways to integrate existing progressive policies and to innovate. Young African leaders across the continent are a responsive catalyst ready to be leveraged in the efforts to overcome the global Covid-19 crisis.

Tim Akano, a Nigerian entrepreneur, reflecting on lessons the global lockdown has for Africa, concluded in an online article that African leaders are the only ones who have the obligation to focus on promoting the continent's interests.

Africa needs to harness its comparative advantages - people and natural assets - to shape a future that leapfrogs a traditional linear development Chinese contributing immensely to the needs of others in a lopsided glob-

al economy.

I have taken the liberty of modifying the seven points he listed as "mustdos" for Africa to emerge out of this emergency stronger:

We must strengthen and activate the ACFTA - Africa Continental Free Trade Agreement - and use it as a basis for negotiating with China. Fifty-two countries cannot relate with China on an individual basis and hope to get a fair, equitable deal.

We need a single currency in Africa (AFRO) - not the West Africa's ECO which the French have contaminated. The world currency battle will begin after the lockdown as China and Russia are bent on overthrowing the dollar hegemony. What will strengthen Africa's economy is to have its own currency through which we can trade

in one African market. The race for the 4th Indus-

including Africans. No country has hegemony yet. African youths are hungry and competent enough to compete with their Chinese and American counterparts provided we make the right investment in infrastructure. The Rwanda-based programme initiated by Prof Neil Turok's African Institute of Mathematical Sciences (AIMS) is a great base.

Africa must insist on fair and equitable trade deals (50/50) with China, going forward. The good news is that China's own experience over the years has demonstrated just how effective this is to build local capacity. China's monopoly of the global supply chain has caused a huge dis-equilibrium. This does not augur well for peaceful coexistence.

The African Union (AU) must insist on China writing off Africa's \$145-billion debt once the pandemic is trial Revolution is open to all people under control. This is the only way Af-

rica can breathe! How will Africa come up with \$8-billion in annual interest after the lockdown caused by China? Africa should also take advantage of the IMF/World Bank proposed debt writeoff. China borrowed very strategically from the World Bank in the 1990s in order to access technical capacity to sustainably develop its own national priorities. It never begged for aid from the West.

Then why should we depend on debt and aid to grow? African leaders should desist from going cap-in-hand looking for aid from Russia, China, America, Japan, India and Brazil. Africa has enough resources to build a modern civilization for itself.

According to McKinsey research, the Chinese love to go on vacation abroad and they were projected to spend about \$250-billion in 2020. African countries should target 50% of China's tourism spend by building modern amusement and sustainable natural and wildlife parks across the continent, while modernising other infrastructure accordingly.

Africa's greatest strength lies in the economic power and technical know-how of Africans in the diaspora. Africa should plan to build six modern cities to accommodate its citizens currently in the diaspora and incentivise them to return home.

South Africa needs to take advantage of our president's term as chair of the African Union to strengthen our continental links, not as leaders but as partners with other countries to actualise the African Free Trade Agree-

We need to strategically leverage the unique advantage of Africa - a demographic endowment of a young population of 800 million. Investing in the talents and energies of these young people is essential to building a formidable continental platform of innovation and creative industries, as part of the restructuring of our continental economies for the 21st century in the post-coronavirus era.

This is a moment of great opportunity and we dare not let it slip through our fingers.



The measures have been taken upon Content Committee finding that on 13th April, 2020, Mwananchi Newspaper through its social media platforms published false and misleading content likely to deceive the public and cause dismay contrary to Regulation 5 (1) (a), and 12 (1) of the Electronic and Postal Communications (Online Content) Regulations, 2018.

Upon establishing violation of the Regulations and pursuant to Section 28 (1) (b) and (c), the Tanzania Communications Regulatory Authority Act [CAP 172 R.E 2017], Mwananchi Newspaper was summoned to appear before the Content Committee on 15th April, 2020 to show cause why regulatory measure should not be taken against them for being in violation of the law. In response thereof, Mwananchi Newspaper appeared before the Committee as ordered and admitted the violation.

Having considered Mwanachi Newspaper's defence and mitigations, the Content Committee found Mwananchi Newspaper through online social media platforms had violated Regulation 5 (1) (a), and 12 (1) of the Electronic and Postal Communications (Online Content) Regulations, 2018.

In accordance with Section 28 (1) (b) and (c), the Tanzania Communications Regulatory Authority Act [CAP 172 R.E 2017], the Content Committee has ordered Mwananchi Newspaper as follows:

- 1. To suspend provision of Online Content Services for a period of Six (6) months. A period during which they are expected to reform and reorganise their online delivery operations hence enable management of their online social media platforms in accordance to the law, and media and broadcasting codes of ethics; and
- 2. To pay a fine of Tanzania Shillings Five Million (TZS 5, 000, 000) to Tanzania Communications Regulatory Authority.

Failure to comply with the above orders, TCRA shall proceed to take further regulatory and legal actions against Mwananchi Newspaper without prior notice and at their own peril.

UR problem is not that we don't have enough food in South Africa. Our problem is that the food is only available to those who have cash, and the poorer you are, the less likely you are to live near a retailer.

It pains me to write this, but unless certain actions are taken soon, we will drift towards a worst-case scenario during Covid-19.

First, the president has done a superb job to get the nation moving proactively in response to the pandemic. Health Minister Zweli Mkhize too has been a godsend in his portfolio at this time, and with his team, has done well to stem the spread of the virus.

Let's applaud the command structure for the job done to date, and then get on with the job still to be done - steering the country through the triple challenges of economic incapacity, social vulnerability and rising frustration.

Criminality

Gauteng Education MEC Panyaza Lesufi this weekend lamented the 55 schools vandalised and burgled during the lockdown. While Lesufi bemoaned the damage done to education infrastructure, Police Minister Bheki Cele condemned the looting of 16 liquor stores in the Western Cape during the same period.

Forty-one arrests have now been made in Gauteng in relation to the school break-ins.

Meanwhile, Port Elizabeth, Cape Town and Limpopo have begun to see riotous crowds looting convenience stores. These are worrying trends.

However, insecurity at street level is not our only problem.

Running low on food

Around eight million children in South Africa depend on the school-based food programmes of the Department of Social

Development. This week, activists urged Basic Education Minister Angie Motshekga to restart the programmes, which were suspended nationwide during the lockdown.

What have these children been eating? They have probably survived on the welfare of social grant recipients, who themselves are under pressure.

What about the millions of undocumented migrant workers in South Africa? They have probably been scrounging for meals from friends, who themselves have been unable to work for more than two

It is up to the informal retail distribution channels, such as spaza shops, to reach you.

Pay now, or pay later

Finance Minister Tito Mboweni announced that he is contemplating an extension of social grants to include a basic income grant. Well, the minister better think quickly, because I suspect most food shelves were emptied out during the Easter weekend, and this coming weekend there will be a reckoning.

South Africa has a choice between paying for these social ills now, in the form of fiscal largesse which puts cash in people's pockets and food on their tables, or paying for them later in the form of

Tear gas, rubber bullets and hungry crowds

For all the bravado by the SANDF's General Solly Shoke, who in a speech last week in Tshwane said the army and police will take a tough stance without reverting to "skop en donner" tactics, I doubt the hungry crowds will be intimidated by tear gas and rubber bullets.

Instead, conflict makes a hungry person an angry person. What happens in Manenberg or Diepsloot Extension 2 after a crowd of hungry youths torch a Casspir with three soldiers inside?

Of course, the police and SANDF will put on a brave face, announce stricter measures and kick

down a few doors. But something else happens. The community loses trust in the armed forces and the legitimacy of the state evaporates.

Next, the democratically elected president announces a State of Emergency. It feels like 1985, only this time the enemy is our own ineptitude.

Avoid the downward spiral

Once we allow the looting of spaza shops, we will have to deal with the burning of delivery trucks. Once it comes to that, the SAPS will securitise the streets and institute roadblocks. The community will roll stones onto the roads, taking control of their neighbourhoods, and burn tyres to obstruct their visibility from the onlooking securocrats.

Once these us-and-them postures are in place, running battles turn to reprisals.

In this environment, no food comes into the parts of town where it is needed most. The private sector clams up to protect themselves and the poor suffer more than anyone else. Saving what is left of our national reputation

A recently retweeted video I found after a Twitter search for the word "looting", contains Ian Cameron's footage of the looting of a South African liquor store. The video was tweeted on 9 April by the UK's polariser-in-chief, Katie Hopkins, who asked, "How far away is NYC and London from

She called our looting "civil unrest". The tweet has so far received 761 comments and 2,700

"likes", has been retweeted 1,300 times and viewed 117,400 times worldwide.

What this portrays to the world is that South Africa is broken and will fall apart during this crisis. It magnifies our faults and generalises our faultlines. It obscures the good that is in our society. But to complain about the discontents of social media is to miss the point.

We need to arrest the decline, now, before it becomes a self-fulfilling prophecy.

Emergency measures, before the emergency

In the same way that we proactively responded to the looming health pandemic, we need to respond now to the food riots before they happen.

We can do this by creating a national food security task team, headed by two representatives from the government, two from business and two from civil society.

We can give them a presidential mandate to convene the social partners, to mobilise the resources and develop a nationwide food parcel and voucher distribution strategy for immediate implementation.

We can partner NGOs with churches, businesses with communities, and government can facilitate the integration of these responses. We can use the crisis as a call to society-wide action to ensure that the only thing we need to fight is the virus.

If we do so, we can avert the national disaster which the president has already pre-emptively declared. If we fail to act, we will sleepwalk deeper into the disaster as another day of inaction passes.

Please, Mr President, don't let the military and police subvert the rule of law

THAT the country now fears are Covid-19 responses by law enforcement agencies that threaten the safety and security of communities.

Dear President Cyril Ramapho-

Covid-19 seemingly is approaching the high lethal levels of the influenza pandemic of 1918-1919 – and it might get even worse if there is a secondary outbreak. You probably are inundated with calls to lift or soften the lockdown. I do not envy you your position, particularly considering the statement made on 12 March 2020 by the director-general of the World Health Organisation, Tedros Adhanom, warning that "countries that decide to give up on fundamental public health measures may end up with a larger problem and a heavier burden on the health system that requires more severe measures to control".

But a new problem is emerging. What the country now has to fear are Covid-19 responses by law enforcement agencies that threaten the safety and security of communities. Specifically, alleged misconduct by some members of the South African National Defence Force (SANDF) and the South African Police Services (SAPS) is detracting from the good job you have been doing since the start of the country's Covid-19 response.

"Sic utere tuo ut alterum non laedas" and "salus publica suprema lex est": Mr President, you are schooled in law and I hope will understand my reference to the two principles that democracies based on the rule of law use to justify and sustain the powers of public health law enforcement agencies. Sic utere tuo ut alterum non laedas (use that which is yours so as not to injure others) and salus publica suprema lex est (public wellbeing is the supreme

It would seem South Africa is backsliding from these principles and also from the rule of law and human rights in general since the introduction of a law enforcement dimension to the Covid-19 response. Several articles and commentaries have been written about Covid-19 and the duties of governments to ensure citizens' and residents' rights to health are protected. The question on the engulfs the country. People are lips of many is whether the lockdown is working and whether it is the best solution. And the government is urged to start looking for alternatives.

Some reports indicate a worrying trend of human rights abuses. "Like the SANDF members who walked into a man's home, opened his fridge, found a beer, and then beat him to death with sjamboks. Just like our slave masters used to do. Nine people have tion, disorder, natural disaster or been killed by police and SANDF brutality since lockdown. On 3 April, 30 cases of misconduct were registered at IPID," read one open letter to you, Mr President, published by Daily Maver-

Others have branded the implementation of the lockdown as akin to having placed South African democracy in the emergency room. Shades of the apartheid era are beginning to rear their heads.

"There the police and the army have behaved in ways indistinguishable from and reminiscent of the dark days of PW Botha's successive states of emergency in the eighties," reads a concern about implementation of the extended lockdown.

As if we were back in time during the apartheid period of yellow police vans pouncing on villages and shebeens, we have seen visuals of the SAPS and/or SANDF spilling drums and bottles of umqombothi (traditional African beer) without thinking such actions might be seen as heavyhanded.

I had flashbacks to the growth

of the "European beer" industry following the lifting of prohibition on the sale of so-called European liquor to Africans in the early 1960s while, on the other hand, African beer was banned by the 1927 Liquor Act. Interestingly, in 1937, the Johannesburg municipality assumed the monopoly to brew traditional beer and banned Africans from brewing umqombothi and other African concoctions. One cannot even keep one bottle of beer in the fridge for the fear of being brutalised by the SANDF, who illegally gain forceful entry into houses and impose their own - and not yours, Mr President - ban on the drinking of

beer in the comfort of our homes. Acts of violence against the citizens and residents of our great republic heighten the fear that

asking what is next to come, on 30 April 2020. Is there going to be another extension of the lockdown? Or is the President going to step up the tempo through an Act of Parliament that declares a state of emergency, based on section 37 of the Constitution, according to which a state of emergency may be declared when the life of the nation is threatened by war, invasion, general insurrecother public emergencies?

Some may argue that Covid-19 does not present any sustainable justification to trigger section 37 of the Constitution. In my view, a health pandemic of the magnitude of the 1918 influenza pandemic and now Covid-19 is a public health emergency that calls for public health emergency powers allowing the government to take extraordinary powers to protect the citizens and to flexibly respond to the Covid-19 risks situations without having to strictly adhere to ordinary legal standards and processes. Moreover, the Constitution provides no definition of "other public emergency", leaving it to the governor to determine what constitutes an emergency.

The sometimes barbaric acts suffered by communities - in most cases poor and historically black communities - at the hands of the country's security forces are worrying. It is because of such acts of criminality against citizens in the name of enforcing the lockdown that many are starting to doubt if the extension of the lockdown is legal. This is in addition to the constitutionality of some of the initial lockdown regulations being questioned.

Communitarian bases for subordination of individual rights

It is beyond any argumentation that the communitarian bases of the South African legal system and constitutional order give support for the subordination of individual rights during this dark time of Covid-19, because it is necessary for the preservation of common good - which in this case is public health. It is for this reason that people in South Africa have subjected themselves to quarantines and lockdowns. But that does not mean people must allow our country to become another of the despotic and militarised African countries, a country



where little people do not matter. Reign in your troops, Mr President, you are the commander-in-chief.

The world is no longer operating in the beginning period of the 20th century, when there was a belief that rapid action by law enforcement agencies was necessary to preserve health, even if those actions infringed on individual freedoms. There are legal, social, economic and ideological imperatives and transformations that call for the limitation of such powers.

The actions of the SANDF and the SAPS have brought about profound changes in societal perceptions of the relative weight of individual rights vis-àvis state powers during this lockdown. Take a moment, Mr President, and find ways to recalibrate the role of the SANDF and the SAPS in the enforcement of the lockdown.

I do not need to remind you that on 16 March 2020 the UN Office of the High Commissioner for Human Rights called on states to "avoid overreach of security measures in their response to the coronavirus outbreak" and reminded them that "emergency powers should not be used to quash dissent". It also reminded governments that "any emergency responses to the coronavirus must be proportionate, necessary and non-discriminatory".

The UN experts called on governments "to prevent such excessive powers to become hardwired into legal and political systems; restrictions should be narrowly tailored and should be the least intrusive means to protect public health". They encouraged states "to remain steadfast in maintaining a human rights-based approach to regulating this pandemic, in order to facilitate the emergence of healthy societies with rule of law and human rights protections".

Where is the proportionality and rationality of Covid-19 responses?

All individuals are entitled to human rights and should respect the human rights of others. The right to privacy, for example, is one of the rights that is coming into sharp focus because of the Covid-19 surveillance responses our government has introduced.

Human rights groups including Human Rights Watch, Amnesty International, Access Now, Privacy International, and 103 other organisations (including Unwanted Witness of Uganda, Media Rights Agenda of Nigeria and Open Data Institute Privacy International, for example) released a joint statement on 2 April 2020 calling on governments to be cautious in their use of digital surveillance technologies to fight the Covid-19 pandemic to respect human rights. The joint statement reads, in part, that "surveillance measures adopted to address the pandemic must be lawful, necessary and proportionate. They must be provided for by law and must be justified by legitimate public health objectives, as determined by the appropriate public health authorities, and be proportionate to those needs... We cannot allow the Covid-19 pandemic to serve as an excuse for indiscriminate mass surveillance."

Mr President, as a lawyer you are aware that lockdown regulations do not enjoy any form of a presumption of constitutional validity. Therefore, the South African Covid-19 regulations cannot be allowed to descend into "sledgehammer" measures as opined by Advocate Tembeka Ngcukaitobi SC.

Mr President, I do not believe you deliberately released on your people enforcers with sledgehammers. But only you, supported by the Minister of Police and the Minister of Justice, can stop the killing of your fellow South Africans.

portionality has many formulations, and built into it is the principle of rationality. The implication of proportionality, which was eloquently stated in one of the first cases of the Constitutional Court of South Africa, S v Zuma 1995 4 BCLR 401 (CC) 419, and later fully adopted by the same court in the death penalty case of S v Makwanyane 1995 3 SA 391 (CC), are the following pillars:

The policy or regulation interfering with the right must pursue a legitimate goal (legitimate goal stage). When formulating, adding or amending the regulations you or your team must ask the following questions: Which goals are and which are not legitimate? From the onset, crime control is not the legitimate goal of the Covid-19 lockdown regulations. Clearly, public health protection and promotion are the over-riding goals of the lockdown regula-

There must be a rational connection between the regulations and the achievement of the goal. In other words, interference with rights must be a suitable means of achieving the Covid-19 response goal, at least to a small extent;

The law must be necessary in that there is no less intrusive but equally effective alternative (necessity stage). So, for example, banning the sale of liquor serves a legitimate goal of promoting the lockdown and social distancing to stop the spread of Covid-19 and associated risks. However, beating up people drinking alcohol in the comfort of their homes amounts to extra-judicial banning of drinking alcohol and does not have any rational connection to the legitimate goal of preventing the spread of Covit-19. It must be called for what it is: dictatorship justice. It is not necessary to seize, forfeit and destroy a one-household liquor stash because the goal of keeping people from the streets is already achieved by the ban on the sale of liquor, unless the stash was bought in violation of the liquor ban or was used to host a group of friends and party-goers; and

The law must not impose a disproportionate burden on the right-holder (balancing stage; proportionality in the strict sense). The question is whether the interference with the right is justified in light of the gain in the protection for the competing right or interest?

Boost in production of sunflower set to reduce oil imports

IMPROVED production of sunflower oil will help the country curb 60 percent imports of edible oil which gobble over U\$250 millions (over 577.6bn/-) per annum, a recent study has indicated.

The study 'Progress Review of Industrialization in Tanzania's Sunflower Sector,' was conducted jointly Dalberg, Southern Agricultural Growth Corridor of Tanzania (SAG-COT), Agricultural Markets Development Trust (AMDT), Agriculture Non-State Actors Forum (ANSAF) and Tanzania Agricultural Development Bank backed by USAID funding, said the country's sunflower sub-sector is transforming following the government decision to offer tax incentives hence encouraged industrial investments.

However, Tanzanian companies have recently invested over \$200,000 in growing hybrid seeds in Tanzania. In 2019, 50 metric tons of hybrid seeds were produced locally," the report added.

SAGCOT CEO, Geoffrey Kirenga said, "Industrializing Tanzania's sun-

flower sector helps the country compete in international markets, creates jobs and transforms the economy and that this approach can serve as a model for other value chains in Tanzania."

"This can also inspire other countries pursuing industrialization by industrializing the sunflower sector and replicating this success in other value chains," Kirenga noted saying SAGCOT is part of the development of the value chain transformation in the country.

In addition, local production also includes 243 metric tons of improved sunflower variety popularly named as 'Record,' widespread adoption of improved seeds which an important driver of increased production of sunflower oil in Tanzania making it one the largest producers of the commodity in Africa. The study further reveals that private investment in seed multiplication has cut the price of high-yielding hybrid sunflower seeds by 60 percent thus increasing productivity drastically.

Taha pleads with govt to ease horticultural exports permits

THE government has been requested to issue landing permits of between 3-6 months and also lower airports charges by 50 percent to allow smooth horticultural produce exports from Kilimanjaro International Airport to European markets.

Taha Group CEO, Dr Jacqueline Mkindi said currently the landing permits are issued for each incoming flight with routine airports charges imposed hence making it not only operationally cumbersome to apply, but also uncompetitive during the COVID-19 crisis.

Dr Mkindi said at Kilimanjaro International Airport over the weekend after successfully bringing a second Ethiopian Airlines cargo plane to airlift highvalue perishable commodities to overseas markets, the state need to support the hard currency earning industry by addressing such challenges.

Emirates debuts on-site rapid COVID-19 testing for passengers

DUBAI based Emirates Airlines became the first global carrier to test passengers onsite for coronavirus before boarding planes to their destination.

In a statement, the carrier said in coordination with Dubai Health Authority, it started onsite Covid-19 testing last week

for passengers who flew to Tunisia. The quick blood test was conducted by the DHA and results were available within 10 minutes. This test was done at the airlines' check-in area of Dubai International Airport Ter-

"The testing process has gone smoothly with innovative solutions. This would have not been possible without the support of

Dubai Airport and other government authorities. We are working on plans to scale up testing capabilities in the future and extend it to other flights," said Emirates Chief Operating Officer, Adel Al Redha.

Al Redha added, "This will enable us to conduct on-site tests and provide immediate confirmation for Emirates passengers travelling to countries that require COVID-19 test certificates. The health and safety of staff and passengers at the airport remain of paramount importance.'

Commenting on the exercise, DHA's Director General, Humaid Al Qutami said the authority was glad to work with Emirates on the successful implementation of rapid COVID-19 testing at the airport for departing we have been proactively working with various governmental organisations and the private health sector and we have implemented all necessary measures from public health protection to provision of high-quality health services in line with the latest international guidelines,"

Al Qutami said. "We believe strongly that the most effective solutions require close partnerships with other public and private sector organisations," he noted.

Gloves, masks and hand sanitisers have been made mandatory for all employees at the airport.

Over 20 Rwandan firms authorised to make COVID-19 protective gear

RWANDA Food and Drug Authority (FDA) on Friday approved a list of more than 20 domestic companies that have been authorized to turn their facilities into production of personal protective equipment.

The companies will be producing barrier and surgical masks, as well as face shields, and this is expected to support the country to cut down on the imports of these equipment. Dr. Charles Karangwa, the Director General of Rwanda FDA told The New Times on Saturday that the local companies were given green light after thorough assessment.

"Some (companies) have already been producing informally, so we have done an assessment and inspection of their premises to give them, medical supplies to other countries to

and others a go-ahead," he said. The ensure enough supply in the bloc. companies include some of the big firms in production of garments like UTEXRWA, Pink Mango, Apparel Manufacturing Group (AMG), Pharmalab, and Burera Garments, to mention but

"We are now largely relying on imports, that's why we needed to revise the situation. There are a lot of constraints to imports from outside," the director noted. They are all expected to produce a combined 600,000 masks per day.

Dr. Karangwa indicated that some countries like the United States and China have already put restrictions on exports of personal protective equipment to protect their people. European Union, for instance, adopted a scheme last month to limit exports of

The President of the European Union Ursula von der Leven said at the time that the EU adopted an export authorisation scheme for protective equipment. This means such medical goods can only be exported to non-EU countries with the explicit authorization of EU governments.

The move by domestic firms to produce needed protective gear that helps in the fight against the spread of Covid-19 would go a long way to fill the vacuum left by countries like those in the EU. Other countries are following the same move under the African Union Development Agency.

Apparel Manufacturing Group (AMG), one of the companies that has received green light, will put their 300 machines and 500 tailors to work to exclusively produce masks.

So far, cigarettes and alcohol sales have been temporarily banned in the country to assist government in curbing the rapid spread of the coronavirus. To date, a total number of 3 034 people have tested positive in 108 021 tests conducted, and two more deaths have been re-

The number of deaths has increased to 52. Alcohol Consumption May Increase Odds of Getting COVID-19, Says WHO. Alcohol sales have jumped since the pandemic started. but the World Health Organization (WHO) says drinking may be putting people more at risk. Addressing the nation on Saturday, Mkhize firstly highlighted that smoking caused to one's health.

"It is something we discourage. Once you have Covid-19 as an added infection, we believe that those who smoke are vulnerable because Covid-19 affects the ca-

pacity of the lung to be able to process the normal day-today exchange of gasses in the lungs. "We discourage people from smoking. I still have to find a good beneficial action that the tobacco has in an individual. In general terms, we discourage people from smoking and more so with this Covid-19," said Mkhize.

"We have been talking about active smoking and passive smoking. It induces so many conditions and other conditions

which are related to pulmonary diseases, or chest-related symptoms. "The problem with smoking is that it tends to affect the lining where people breath and creates some reactions. In some instances, it can provoke a reaction where someone's lining is irritated and becomes easy to get infected," he said.

He said smokers could also get bronchitis, and even tuberculosis. "Beyond that, it affects the cardio-vascular system. Nicotine reduces flow of blood into the small blood vessels," Mkhize said. He said alcohol resulted in many problems, including neurological ones.

"Under the circumstances we are working in, we really need everyone to cooperate so we can reduce pressure in hospitals and the possibility of people being infected, because everyone is taking a very responsible approach when they are in sober senses," said Mkhize.

Indian airlines asked not to sell tickets before final decision on lockdown

NEW DELHI

INDIA'S Aviation Ministry has asked airlines to take travel bookings only after a final decision on lifting or easing restrictions on domestic and international flights is announced.

"The Ministry of Civil Aviation clarifies that so far no decision has been taken to open domestic or international operations," Minister Hardeep Singh Puri said in a tweet late on Saturday. It wasn't immediately clear if it was a binding order or an advisory for the country's aviation

The country is currently in the midst of a nationwide lockdown until May 3 to control the spread of coronavirus infections. India had initially announced a 21-day lockdown until April 14 and airlines had started selling tickets for flights before an extension until May 3 was announced on Tuesday. There's been no clarity so far if flights, especially international, will be allowed even when the lockdown is lifted.

Airlines are now selling domestic and international tickets for flights starting from May 4. National carrier Air India on its website on Saturday said it opened bookings on selected domestic routes from May 4 and international ones from June 1.

Most carriers have been offering credit instead of refunds if flights are cancelled due to the travel curbs as the ticket sales are providing them much-needed cash flow at a time when all other sources of revenue have dried up. Passengers worldwide are fighting against that practice, including in the US and some governments have ordered airlines to refund passengers without charging a cancellation fee.

Virus hands China its first economic contraction in decades

BEIJING

CHINA'S economy contracted for the first time in decades last quarter as drastic measures to contain the coronavirus pandemic brought activity to a standstill, official data showed on Friday.

Gross domestic product shrank 6.8% in the January-March quarter from the same period a year earlier, according to figures released by the National Bureau of Statistics (NBS). It was the first negative growth reported by the world's secondlargest economy since Beijing began logging quarterly data in

The figure marks a sharp drop from China's six percent expansion in the fourth quarter of last year, but was slightly better than the 8.2% contraction forecast by economists in an AFP poll. Economists have long harboured doubts about the accuracy of the official Chinese data, however, suspecting that the numbers are massaged for political reasons.

And analysts have warned of tougher times ahead, with weaker external demand for Chinese goods to weigh on growth as key export markets are battered by Covid-19. "We are now facing rising pressure in the prevention of imported epidemic infections, as well as new difficulties and challenges for resuming work and production," NBS spokesperson Mao Shengyong told a press conference.

NEW YORK

THE number of Americans applying for unemployment benefits fell last week to a still-massive 5.25 million, capping four weeks of coronavirus-related shutdowns that erased more than 10 years of job creation.

Initial jobless claims in the week ended April 11 followed 6.62 million the prior week, according to Labour Department figures Thursday.

The median estimate of economists was for 5.5 million, with projections ranging as high as 8 million. The four-week sum of 22 million filings compares with of depleting its \$349 billion roughly 21.5 million jobs added during the expansion that began in June 2009.

The latest figures suggest an unemployment rate currently around at least 17% - far above the 10% reached in the wake of the recession that ended in 2009 - in a sign that the effects of shutdowns have spread well beyond an initial wave of restaurants, hotels and other businesses. Another reason for elevated claims is that Americans are getting through on outdated or overwhelmed systems after previously being stymied.

Even so, the data showed most states reported declines in claims from the prior week on an unadjusted basis, suggesting that the breakneck pace of job losses is starting to slow, if just a bit. Continuing claims, or the total number of Americans receiving unemployment benefits, jumped by at 318 000 and Texas at 274 4.53 million to a record 12 000.

Retail sales also plummeted 15.8% last month as many consumers stayed home and avoided crowds due to fears of a resurgence in virus cases. But the urban unemployment rate dropped slightly to 5.9% last month, after surging to 6.2% in February.

ing a "moderately prosperous society" by the end of 2020, but this is increasingly under threat from the pandemic fallout. "Public records suggest that at least half a million firms were dissolved in the first quarter and more are likely to close shop," said Capital Economics chief Asia economist Mark Williams in a report this week.

Surveys pointed to more layoffs in March, and unemployment will likely remain higher in the coming months, he said. Some analysts believe the worst has passed for China but still expect a slow recovery.

Williams said depressed demand in foreign markets could reduce Chinese exports - which account for 15% of national GDP - by as much as half. The impact on export demand may have shaved 1.8% points off China's real GDP growth in the first quarter, Nomura's chief China economist Lu Ting said earlier.

Virus could kill 300,000 in Africa, even with interventions, says UN

BLOOMBERG

THE coronavirus pandemic could kill 300,000 people in Africa this year, even with assertive government measures to limit social interactions, according to the United Nations Economic Commission for Africa.

Overcrowded slums with no access to water coupled with fragile health-care systems make the continent especially

vulnerable to the disease, the Addis Ababa-based body said in a report on Friday.

Countries across the continent have implemented measures from nationonly allowed to leave their homes to buy food and medicine, to suspending schools, prohibiting public gatherings and halting all travel.

The virus has killed 1,017 people in Africa so far, out of 154,213 deaths worldwide. However, the pace of contagion has picked up with the number of cases more than doubling to 19,895 in two weeks, according to data from the Africa Centres for Disease Control and Prevention.

The pandemic also threatens to push as many as 29 million people into extreme poverty in a continent that is already home to nearly two-thirds of the world's destitute, Uneca said.

The continent's economy could contract as much as 2.6 percent this year.

A third of the 440 million formal and informal jobs in Africa could be affected as lockdowns across the continent deprive people of the means to make a living, according to McKinsey & Co.

Africa needs at least US\$200 billion to respond to the pandemic and its impact, Uneca said. An initial US\$100 billion is needed to beef up its health-care system and social-safety net and another US\$100 billion in emergency economic stimulus.

UN Secretary General Antonio Guterres on Friday urged creditors to grant a debt standstill for all developing countries, not just the poorest, Reuters reported. The International Monetary Fund should allocate new Special Drawing Rights to mobilize more resources, he

Coordinated, continuous international action essential for global recovery from pandemic - IMF

WASHINGTON

COORDINATED and continuous international action will be essential to support vulnerable countries, restore market confidence, contain financial stability risks, and spur global economic recovery from the COVID-19 pandemic, a senior official of the International Monetary Fund (IMF) has said.

"As countries implement necessary quarantines and social distancing practices to contain the pandemic, the world has been put in a Great Lockdown. The magnitude and speed of collapse in activity that has followed is unlike anything experienced in our lifetimes," Zhang Tao, deputy managing director of the IMF, told Xinhua in a recent written interview.

"At this point, there is great uncertainty about its severity and length of the economic downturn," he said.

The global economy is expected to contract sharply by 3 percent this year in a baseline scenario as a result of the pandemic, the worst recession since the Great Depression in the 1930s, according to the IMF's

latest World Economic Outlook (WEO) report released Tuesday.

Advanced economies will contract significantly by 6.1 percent in 2020, and emerging market and developing economies, which typically have growth levels well above advanced economies, will shrink by 1.0 percent, the report showed.

Citing the IMF's newly-released Global Financial Stability Report (GFSR), Zhang (pictured) said the global financial system has already been "dramatically impacted" by the pandemic.

"A further tightening of financial conditions and an intensification of the crisis could threaten global financial stability. The risks to the outlook, globally, are certainly on the downside." he said.

While advanced economies have already absorbed a severe blow, emerging markets and frontier markets could endure a crisis that causes intense economic, financial and social pain, Zhang warned.

"If the economic crisis intensifies, there is a risk - not a certainty, but a risk - that a financial crisis could occur," he said, noting emerging markets have seen exceptionally large



portfolio outflows since the beginning of the COVID-19 outbreak.

"The speed and magnitude of the capital outflows are unprecedented posing policy challenges" for emerging markets, Zhang said, adding the IMF Executive Board has just approved a new short-term liquidity line for countries with strong economic fundamentals, including many emerging markets.

The Fund's membership will also explore whether the use of Special Drawing Rights (SDRs) could be helpful particularly to emerging market and developing economies, according to the IMF official.

"Particularly, a general SDR allocation has been practiced in the past, which by its nature would take time, likely several months as in the

past, to secure, as it was done in 2009 during the Global Financial to address downside risks, he Crisis," he said.

Zhang stressed that authorities should also take vigorous monetary, fiscal, and financial policies to cushion the impact of the shock, as "coordinated, continuous international action" will be essential to support vulnerable countries, restore market confidence, and contain financial stability risks.

"The IMF is working around the clock - it's all-hands-on-deck as we support our 190 member countries with policy advice, technical assistance, and financial resources," he said, adding the IMF has 1 trillion U.S. dollars in lending capacity.

The IMF official observed that the Chinese economy is "gradually turning around" after taking a hit in the first quarter due to the COV-ID-19 outbreak, as "market liquidity and financial stability are generally maintained."

"As a result, the widespread reopening of firms and the fact that employees are returning to work makes us hopeful that we will see a strong recovery starting in Q2,"

But more work needs to be done noted, citing examples of efforts needed to prevent the virus from returning, which could force new containment measures and impede

"In addition, measures need to be taken to meet the challenges associated with the slowdown of global economic demand and the disruptions of global supply chains, as the pandemic and lockdown continue to affect other countries," Zhang said, suggesting policymakers will have to keep an eye on it and be ready to add to the macroeconomic support that is already planned.

It is also important to ensure a strong and sustainable recovery with focus on high-quality growth, as "this will benefit both the Chinese people and the global economy," he said.

Given the increased need for medical instruments and medical supplies around the world so as to fight the pandemic, Zhang hoped these supply chains would work as best as they can to maximize global production and supply.

UN chief pledges to defeat COVID-19, rebuild fairer world

UNITED NATIONS

UNITED Nations Secretary-General Antonio Guterres pledged on Saturday night that all human



beings should unite as one to combat the common enemy of coronavirus and rebuild a fairer world.

"Together, we will defeat this virus and rebuild a fairer world - as united global citizens and united nations," the UN chief said in his video message for "One World: Together At Home" concert organized by international advocacy organization Global Citizen.

"We face a crisis unlike any other. To overcome it, we must unite," he noted.

"Tonight, through the universal language of music, we salute the bravery and sacrifice of health heroes and others," said the secretary-general.

"As we do so, let's remember the most vulnerable," he said. "Please join our call for a global ceasefire to focus on our common enemy - the virus."

"Thank you for your support for the lifesaving work of the World Health Organization (WHO) and the other humanitarian agencies," said Guterres.

Speaking at a virtual press conference in Geneva on March 6, WHO Director-General Dr. Tedros Adhanom Ghebreyesus said that his organization has been working with Global Citizen for several weeks on the "One World: Together At Home" concert series. "Now we're working with Lady Gaga to take this concept and make it even bigger,"

US uses questionable approaches to designating terrorists – Ministry

MOSCOW

WASHINGTON uses questionable approaches while designating certain entities as terrorist organizations and adding them to relevant lists, and this fact is also confirmed by domestic US experts, the Russian Foreign Ministry said in a statement released on Friday.

The Russian Foreign Ministry referred to a report, issued by the US-based non-governmental organization Anti-Defamation League and the George Washington University, headlined 'White Supremacist Terror: Modernizing our Approach to Today's Threat.' The experts named Ukraine's nationalist organization, the Azov Battalion, as the main candidate for becoming designated as a terrorist organization by the United States.

"According to the report, this Ukrainian group presents an evident threat and fully complies with criteria of the blacklist of foreign terrorist organizations," the ministry said. "Estonian ultra-right group, Feuerkrieg Division, which has many US citizens in its ranks, is also mentioned in this context, as well as many others."

However, the US government has not yet paid attention to the opinion of experts.

"Regretfully, as we see, Washington is guided by another approach, based on habitual media-political manipulation and proverbial double standards," the ministry said.

"Conclusions of experts, who undertook to lay down recommendations, including with regard to expanding lists of terrorists, and Washington's reaction to them, once again raise serious doubts about motives of the US side, which brazenly uses its self-proclaimed authority to impose sanctions under the pretext of fighting global terrorism and extremism," the ministry said.

The US Congress recommended including the Azov Battalion into the list of terrorist organizations in the fall of

Nigerian president pays tribute to top aide killed by COVID-19

NIGERIAN President Muhammadu Buhari on Saturday paid tribute to his chief of staff, Mallam Abba Kyari, who died on Friday from the COVID-19 pandemic.

"Mallam Abba Kyari was the very best of us. He was made of the stuff that makes Nigeria great," Buhari said while mourning the top presidential aide. Kyari, 67, who had had underlying health conditions, "was a true Nigerian patriot," the president said. He was notably one of the closest allies of Buhari.

"My loyal friend and compatriot for the last 42 years -and latterly my Chief-of-Staff -- he never wavered in his commitment to the betterment of every one of us," said

Kyari's passing marked the first high-profile death since the novel coronavirus hit the West African country.

WHO timeline shows impartial response to pandemic fight

GENEVA

SINCE the onset of the COV-ID-19 outbreak, the World Health Organization (WHO) has taken timely and decisive measures with an objective, scientific and impartial response to guide global anti-epidemic cooperation, gaining wide recognition from the international community.

Despite the rapid spread of the pandemic, which, according to the latest figures of the WHO, has led to over 2.1 million cases and more than 146,000 deaths globally, the US administration announced earlier this week that it is halting funding to the WHO, after weeks of criticism of the

health organization and its handling of the outbreak.

While some Western politicians have politicized the virus and smeared the efforts of the WHO, China has called for solidarity and

cooperation in the global fight. In an article published in the Qiushi Journal on Thursday, Chinese President Xi Jinping wrote that only with solidarity and cooperation can the international community prevail over the epidemic and protect humanity's common home.

TIMELY WARNINGS

As a specialized agency for public health, the WHO has striven to fulfill its purposes of collecting

information on various infectious diseases globally and issuing timely warnings.

The WHO "has largely served its purpose well" in the COVID-19 crisis, said Thomas Bollyky, director of the global health program and senior fellow for global health, economics, and development at the Council on Foreign Relations, a US think tank, urging Washington not to "degrade it amid a cri-

On Jan 5, the WHO published its first disease outbreak news on the new virus, including a risk assessment, advice, and China's reports on the virus, two days after China informed the organization of



the outbreak, as well as relevant countries and regions.

On Jan 12, the agency said in a press release that "China shared the genetic sequence of the novel coronavirus, which will be of tweeted on April 8, adding that great importance for other countries to use in developing specific diagnostic kits."

On Jan 31, WHO Director-General Tedros Adhanom Ghebreyesus declared the outbreak a Public Health Emergency of International Concern (PHEIC), sending the highest level of alarm.

On March 11, Ghebreyesus said at a press conference that "COV-ID-19 can be characterized as a pandemic."

The WHO quickly declared a PHEIC and classified COVID-19 a pandemic soon after, Lawrence Gostin, a public health law professor at Georgetown University,

"US/Europe had time to prepare. They didn't! Easy to blame @ WHO, but it's our fault."

US President Donald Trump is attacking the WHO "because he loves to have international targets that deflect from his own performance on the pandemic," Darrell West, director of governance studies at Brookings Institution, a Washington D.C.-based think tank, told Xinhua.

In addition to sounding warnings at critical moments, the WHO always sends experts to virus-hit regions to collect information to better understand the situation.

On Jan 28, a senior WHO delega-

tion led by Ghebreyesus traveled to China's capital Beijing. On Feb 16, the WHO-China Joint

Mission, consisting of 25 experts from eight countries and the WHO itself, began its nine-day field study trip in Beijing and the provinces of Guangdong, Sichuan and Hubei.

"China's good cooperation with the World Health Organization has enabled various national authorities to prepare, as best as possible, for the difficulties brought by the wave of contamination," former French prime minister Jean-Pierre Raffarin told Xinhua.



Chinese enterprises quicken steps to resume production

CHINA'S official Purchasing Managers' Index (PMI) rose to 52 percent in March, up 16.3 percentage points from February, according to data jointly released by the National Bureau of Statistics (NBS) and the China Federation of Logistics and Purchasing.

As a month-on-month economic indicator, PMI reflects the short-term changes in economic activity. Generally speaking, 50 percent separates monthly growth from contraction.

When PMI is above the 50-point mark, it indicates an expanding manufacturing economy, and when the figure is below 50 percent, it reflects that the economy is generally contract-

"The data can be interpreted to mean that half of the manufacturing enterprises embraced positive changes in production and business operations in March," according to Zhao Qinghe, a senior statistician with the

Statistics from Chinese steel trading website Zhaogang.com indicated that the country's steel trading volume stood at 880,000 tons in February, only 30 percent

of last year's average level. However, the figure increased explosively in March.

With positive changes taking place in domestic epidemic control and prevention, downstream manufacturing and construction industries resumed production at a faster pace in March, noted Gong Yingxin, secretary of the Party committee and senior vice president of Zhaogang.com.

Gong disclosed that the daily steel trading volume on the platform has reached 160,000 tons, four times that in February, and the platform's trading volume has generally recovered to last vear's average

"Our orders have expanded by 30 percent year-on-year since we resumed production. In March we delivered orders worth \$4.5 million to our overseas clients,"

said Yan Hongjia, president of the company.

China made positive progress in coordinating epidemic control and economic development in March, and enterprises have been resuming production at a faster speed, said Zhao.

However, the single-month rise doesn't necessarily mean the

production and operation have been back to pre-outbreak levels, according to head of the Service Survey Center with the NBS, who told People's Daily that the upturn of economy only comes when the PMI moves up for at least three consecutive months.

A survey indicated that enterprises still face significant pressure to further boost production and operation despite the expanding PMI, Zhao pointed out.

In March, 41.7 percent of manufacturing enterprises reported insufficient capital provisions, up 2.6 percentage points from the previous month and 52.3 percent reported sluggish market demand, 4.1 percentage points higher than February.

Zhongjie Footwear Co., Ltd. in Yifeng county, Yichun of Jiangxi province mainly exports shoes to Europe and the U.S. Due to the global spread of the pandemic, its export orders for the following months have shrunk by 40 to 50 percent, which brings a monthly loss of nearly 4 million yuan to a single branch factory of the company alone.

"We had planned to recruit 300 workers at the beginning of March to complete orders placed before the outbreak,

However, we didn't expect the pandemic to exacerbate so quickly overseas. Many of our foreign clients have been cancelling or postponing orders since mid-March," said He Jiat-

ing, head of the company. The NBS statistics indicated that the index of new export orders and the import index of Chinese enterprises ticked up to 46.4 and 48.4 percent, respectively in March, but were

still mired in contraction. To match effective supply and effective demand is an important criterion to evaluate the effectiveness of production re-

In promoting resumption of work and production, the demand side must be improved, and supply-side structural reform should be deepened in a solid manner.

In addition, targeted measures should be rolled out based on market demand, so as to avoid inefficient and blind development, and reduce overstaffing, wasting of materials and inefficient circulation of capital.

Doing so, the losses caused by the epidemic can be minimized and the foundation for further economic recovery is consolidated.

Currently, epidemic control and the economic situation are seeing major new changes, both in China and abroad, Zhao said. The country faces huge pressure brought by imported cases of novel coronavirus disease, which challenges its economic development, especially the recovery of the industrial chain.

Therefore, PMI data need to be further observed.

'Big Three' discussing ways to help lower-level players, says Djokovic

NOVAK Djokovic has been in touch with fellow ATP Player Council members Roger Federer and Rafa Nadal to discuss ways to assist lower-ranked players facing financial struggles amid the novel coronavirus outbreak, the world number one said on Saturday.

Answering a fan's question during his Instagram live chat with Stan Wawrinka, Player Council chief Djokovic said steps would be taken to ensure that only those players who are most deserving will benefit from any relief plans.

"I spoke to Roger and Rafa a few days ago and we had a conversation about the near future of tennis. How we can contribute to help lower ranked guys who are obviously struggling the most, Djokovic said.

"A majority of players ranked between 250 to 700 or 1,000 don't have federation support or sponsors and are independent and left alone."

The tennis season was suspended in early March due to the pandemic, leaving players in the lower tiers who depend solely on tournament winnings without the chance to earn a living.

The plight of players ranked outside the top 100 in singles has prompted the game's stakeholders - the ATP, WTA, ITF and the organisers of the four Grand Slams - to devise plans to provide some

"Players hopefully will (also) contribute collectively to the relief fund that the ATP (and others) will distribute using models and criteria," Djokovic added.

"You want to avoid giving money to player who fits into this category (low ranking) but does not need the money compared to someone else... hopefully between \$3-4.5 million will be distributed to lower-ranked players."

Djokovic, a 17-times Grand Slam champion, said other short-term solutions could include diverting bonus money meant for top players from season-ending events like the ATP Finals into the relief fund.

"If we don't have any events (in 2020), maybe next year's Australian Open prize money can be contributed to the fund," the Serb added.

"I'm glad the tennis eco-system is coming together. Everyone realises the base of tennis. These guys ranked 250 onwards are the ones making the future of tennis.

"We have to show them they're not forgotten. We also have to send a message to young players that they can live out of tennis when there's a financial crisis."

Meanwhile, tennis personality Patrick McEnroe has recovered from the coronavirus, he said on Saturday while praising the efficiency of New York's drive-through testing operation.

"Great news for me and my wife Melissa. We both tested negative for COVID-19," McEnroe said in a short video he posted o Twitter.

"We just got the tests back this morning from New York state. We both went to the drive-through

which I had gone to a few weeks ago. "It was even more efficient this time, there were six lines instead of two, lots more people helping

out, a very efficient operation."

McEnroe, the younger brother of seven-times grand slam champion John, said on March 31 that

he had a confirmed case of the coronavirus. New York City and the surrounding suburbs have been hard hit by the virus.

New York Governor Andrew Cuomo said on Saturday that about 2,000 people were still being hospitalised every day, though he expressed cautious optimism that the peak of the epidemic may have passed. REUTERS

CAF competition format disturbing moods at leading clubs in Tanzania

CHANGING the continental competition format from the two top clubs in the national Premier League to the league winner and winner of the equivalent of a federation cup is apparently the case of unsettled and often chaotic moods in leading clubs in the city of Dar es Salaam.

For once, it was alright earlier to finish at number two in the Premier League season, as it was dejecting but retained club dignity, as it shifted the competition to the continental scene. It was a matter of who was now going to survive the grueling continental contention, either champs or runners

With the decidedly low key federation tournament replacing the second slot place in the Premier League to pick the participant in the second tier CAF tournament, the Confederations Cup, the situation is different. Winning the league has become all too important, and as it is a competition taking the whole season and is indeed the reason for having major clubs, not the more eclectic and sporadic federation cup tourney.

The other competition is not capable of taking away the prestige of the premier league, and when it is given the slot for contention in CAF, it is only to downgrade the performance of other clubs, chiefly the runners up

in the premier league, simply. In addition, the tournament that is

more or less equivalent of a regional club championship, the Kagame Cup, has usually been a voluntary event, in which case when a city rival side feels it isn't adequately prepared to meet their archrivals, or habitually wishes to avoid them, it skips the competition.

Dissimilar to the CAF events, the regional content is an event that a team flies there and participates during one week and then leaves, where the rewards don't match efforts that have to be invested to do well in the tourney. Were it a regional league that would be something else, and then a continental league be reserved for winners and runners up of regional leagues.

There is a penchant somewhere in CAF for making Africa a country, taking up the European example, whereas Europe is limited in territorial expanse and its league structure is lucrative to an extent, down to second or third division.

In Africa the lower divisions can compare in some flashes of talent with premier league sides, but cannot up sterling competition for continuous periods of time as the basic structures and resources are not comparable. In other words there is need to give priority to the premier league to skip unnecessary instability due to devalorisation.

This is what is now being noticed especially at Jangwani Street, and not so long ago it was Msimbazi Street which was riven with divisions and factions, one of whose results is to increase the level of not just rivalry but hostility towards the next street

The reason is that when someone is distressed inside it will show on the outside, and that is why reports say that it is being noticed that lockdowns due to the coronavirus lead to a rise in domestic violence and abuse. Part of the reason is that lockdown is quite often an economic downturn in fortunes, and it is hard to maintain a placid and harmonious domestic environment amid crying insufficiencies.

There were intimations in the past relating to Simba SC leaders trying to corrupt players of the rival club, and that story was hushed up because people did not wish to take issues with its authenticity and accuracy. And lately a leading official of the club

whose player made rather gratuitous claims on the rival club comes out and makes claims that he ought to have known they plainly invite disciplinary measures on his side.

As the fellow is an experienced sports organizer even with administrative experience in the federation itself, making claims that designate him as a shooting target is sort of bizarre, efforts to apologize notwithstanding. Was it really accidental?

The latter claim like the previous seem to relate to a style, of unnerving the other side and bringing up unnecessary quarrels in its ranks, which would bring up the morale of the weaker side, or so on the basis of championship data until the coronavirus pandemic set in.

Even with a morale boosting draw and then victory over their archrivals, the fact that this can scarcely lead to handing the championship and therefore a prestigious continental competition leaves a dry taste in the mouth. Leadership is thus reduced to fomenting discord on the other side of the invisible soccer curtain in downtown Dar es Salaam, so that pundits have something to talk about.

It is to win a propaganda war and psychological unsettling of the rival club, so that the club's resource standing is weakened if the sponsorship structure begins to wobble, strategic sabotage as it were.

Too early to worry coronavirus will further delay Tokyo Games

IT is premature to think the novel coronavirus outbreak will further delay the Tokyo Olympics, which have already been postponed a year, Brian McCloskey, an expert on global health security and outbreak prevention told Reuters.

Under increasing pressure from athletes, the International Olympic Committee (IOC) and Tokyo Games organisers last month postponed the 2020 Games for one year as the coronavirus spread, shutting down global sport.

Yet as countries try to beat back the pandemic, with experts predicting a vaccine is still 12-18 months away, questions have begun to surface as to whether a year's delay is sufficient time to stage the Games in a safe environment. "I think that's probably a little bit premature in the sense that we've got 15 months more of planning

and preparing for the Olympics in that would have been needed was 2021," McCloskey said. "So, I think it's premature to say it's unrealistic (that the Olympics cannot be held in 2021).

"Clearly, having a vaccine would be extremely helpful, not just for the Olympics, but for all of us. But even without a vaccine I think there are other mitigation measures we will look at to make sure we can run the Games safely.

"So, it's a challenge, but I'd say it's too soon to say it can't happen."

The number of confirmed novel coronavirus cases in Japan rose to 10,000 on Saturday, public broadcaster NHK said, just days after a state of emergency was extended to the entire nation in an attempt to slow the spread of the virus.

WAIT-AND-SEE APPROACH

Just over 200 people have died from

the virus in Japan. "This year for Tokyo, it got to the point where the amount of mitigation

more than we could ask the Japanese government to do when the Japanese government needed to be focusing on looking after its population," said McCloskey, a member of the World Health Organization Novel Coronavirus-19 Mass Gatherings Expert Group.

"But that could well have changed by next year. So, it's quite possible that the outbreak will be at a level where it's manageable without any particular risk. "Or it may be that the vaccine arrives, it may be there's treatment available. So, we just need to think through the options and not jump to too many conclusions too quickly."

McCloskey's wait-and-see approach sounds similar to the one taken by the IOC before it decided to postpone the

Games amid mounting criticism. Athletes were angry at being left in a state of limbo by the IOC and Tokyo organisers and while the postponement has provided a cushion, the clock is once again ticking.

Sports leagues and federations around the world are preparing to emerge from the outbreak and return to action with most seemingly resigned to the fact they will be played in empty arenas and stadiums until it is safe for fans to come back.

"So, we can run through to this time next year," said McCloskey, looking ahead to a 2021 Summer Games. "After that it gets more problematic because people have spent a lot of money, athletes have to make up their mind whether they can come or not.

"So, it gets more and more difficult the closer you get. But I'd say there's a willingness and an enthusiasm to make sure it happens properly.

"So, people will try hard and I think they'll hang on to the last minute to see whether it's safe to go."

Premier League clubs discuss options but left in limbo

MANCHESTER, England

PREMIER League clubs on Friday discussed possible models for finishing the current season but did not consider a specific date for play to resume while U.K. government lockdown restrictions remain in

Representatives of the 20 teams took part in a conference call to look at various possible options for restarting the season and remain committed to completing the fixtures rather than voiding the season.

But after the government announced on Thursday that the lockdown would remain in place for at least another three weeks, all options remain hypothetical.

A Premier League spokesperson said: "Today's Shareholders' Meeting provided an opportunity to discuss possible scheduling models. It remains our objective to complete the 2019-20 season but at this stage all dates are tentative while the impact of COVID-19 develops.

"In common with other businesses and industries, the Premier League and our clubs are working through complex planning scenar-

"We are actively engaging with stakeholders, including broadcast partners, and our aim is to ensure

we are in a position to resume playing when it is safe to do so and with the full support of the Government.

"The health and wellbeing of players, coaches, managers, club staff and supporters are our priority and the League will only restart when medical guidance allows."

There was no discussion during the meeting of the possible complications that could be caused by the season running beyond June 30 when some player and manager contracts run out.

World soccer's governing body FIFA has stated that contracts should be adjusted to reflect the actual end of the season. However, that issue could be open to challenge under English law.

The Football League (EFL), which represents the three divisions below the Premier League, has said that teams should not return to training before May 16 "at the earliest".

Should teams be allowed to train it is expected they would need twoto-three weeks to get prepared for the return to action, making the earliest possible return in June.

But with the ban on mass public gatherings likely to be one of the last restrictions to be removed, rescheduled games could well be held behind closed doors.

Here's how many people are needed to play 'behind closed doors'

FOOTBALL behind closed doors sounds simple: Get the teams in, keep the fans out and limit the other attendees to those people who simply have to be there. But with the sporting world as a whole facing the reality of returning to action without spectators -- once coronavirus lockdown measures are sufficiently relaxed -- even playing in empty stadiums will be a complex issue.

In England, While a resumption date for the Premier League has not been mooted, the Football League is planning to return on June 6, which would be 12 weeks after football in the country was suspended. If, as has been suggested, the aim is to finish the season within 56 days of that date, we are talking about 541 games across the top five tiers -- including the National League -- of the English pyramid.

There is no expectation within the game that supporters will be allowed inside stadiums to watch their team play, but even though the stands will be empty, a professional football match requires people to do certain jobs and fulfill key roles. Up to 200, in fact.

"People don't realise just how many essential staff must be at a football match in order for it to go ahead," a senior figure at a leading EFL club told ESPN. "If, or when, football returns, you are looking at between 150 to 200 people inside a stadium, so it won't simply be a case of 22 players and the match officials.

"For example, we would need six safety officers, even for a closed-doors game. At a bigger Premier League stadium, you would need to multiply that five times, just to cover all the basic requirements. So when football does return, social distancing measures and numbers allowed for public gatherings will have to be much less stringent than they are right

One Championship club has given ESPN a full rundown of the minimum number of people it would expect at a game behind closed doors, and it amounts to 166. In the Premier League, rights-holder media alone would see that number leap toward 300.

A top-flight club source told ESPN that an average of 120 broadcast media are accredited for home games. The people you don't see -- riggers, electricians, technicians, producers, camera crew and sound engineers -- are just as important, if not more so, as the reporter or commentator; they will all need to be inside a stadium once football gets the green light

As for the teams, the modern-day game means we

are talking about a lot more than two teams of 11, plus two managers and three match officials. To start, the two squads have 18 players, including substitutes, while the manager has an assistant and other coaches. The refereeing crew, meanwhile, comprises a referee and two assistants, plus a fourth official and refereeing assessor in the stands. You cannot play a game without a physi-

otherapist, and no Premier League team has just one anyway. The kitman is another essential backroom staff member. And there also is a team of analysts that produces video data for clubs; as many as six members occupy seats in the Manchester City press box due to a lack of space on the bench.

Every club has a doctor; although if efforts are made to cut attendees to an absolute minimum, one on duty might suffice. Legally, though, there would be a necessity for at least four paramedics and an ambulance driver. With police also required, emergency services could be stretched.

Ball boys and ball girls might seem like an extravagance, but if the match ball ends up in Row Z of an empty stand, can you imagine David De Gea or Andy Robertson climbing the stairs to retrieve it? A medium-sized ground would require a team of 12 on the sidelines, with more needed at arenas the size of Old Trafford, the London Stadium or Tottenham's new ground.

Similarly, ground staff are required to ensure playing surfaces are in peak condition before, during and after games. Championship clubs can get by with four, but Premier League teams might employ as many as 20 people, armed with pitchforks and rollers.

Off the pitch, the list goes on: A club secretary liaises with match officials and oversees all matchday operations, and then there are electricians, maintenance workers, cleaners and catering staff. Digital advertising boards are used for televised games, returns and the stands are empty, hunand a technician must ensure they are rundreds must be on hand for games to go ning properly. A trivial job? Not when the ahead.

game is on television and sponsors are paying for the right to be seen.

And let us not forget VAR, which is a necessity for all Premier League games. A source told that ESPN that, under normal circumstances for a seven-match day, approximately 40 people would be needed. Beyond that, the smart technology behind the Hawkeye system that is used for goalline reviews requires monitoring to ensure seven cameras in each goal work properly.

All of the aforementioned people will be monitored and guided by the stewards and officials, whose job it will be to keep the stadium secure -- internally and externally -- from fans who might try to sneak in.

So while the away team's bus driver might have to accept sitting outside, many staff cannot realistically be stood down for a closed-doors game. Even when football

No relegation if no more Premier League play, says Brighton owner

THERE is unlikely to be any relegation from the English Premier League if the season ends with no more play possible because of the coronavirus outbreak, Brighton and Hove Albion owner Tony Bloom has told British media.

Premier League clubs met on Friday to discuss possible models for finishing the season but all options remained hypothetical after the U.K. government extended lockdown restrictions for another three weeks.

Brighton were two points clear of the relegation zone with nine matches remaining when the league was brought to a halt on March 13.

If the season ended with no more play possible, Liverpool would claim the title and Norwich City, Aston Villa and Bournemouth would be for the

Relegation means a financial hit somewhere in the region of \$100 million and Bloom thought it unlikely that the required 70% of clubs would vote to send the three teams down.

"It would be very difficult to relegate somebody, particularly from the Premier League, if the season hasn't played out," Bloom said.

"You may get a title winner, obviously Liverpool deserve it, you may use that criteria for European qualification, but I do not see how anyone can vote for that, certainly the percent needed for teams to get relegated."

With some teams having more matches remaining than others, another proposal is that a club's final position be decided by the average number of points they have won per game.

Bloom thought that option even less likely to succeed.

"I don't foresee a situation, if the season's not played out, that teams will get relegated on a points-per-game basis," he said.

"I just don't think it's fathomable that a team

which is not allowed to play out the season may

lose out on 0.2 points based on this system, and also it does not take into account the strength of the team you have not played." Meanwhile, Arsenal's psychologist has been in constant communication with the Premier

League club's players to offer any help they may need during the lockdown due to the novel coronavirus outbreak, manager Mikel Arteta has said. Soccer in England has been suspended since

March 13 because of the virus that has infected more than 2.23 million people globally causing over 151,000 deaths. Arsenal's players have been self isolating since

March 12 when Arteta tested positive for the virus – before the lockdown in Britain – and the Spaniard said that all efforts were being made to ensure the players were in good spirits.

Jose Luis Martinez-Almeida told the Onda Cero radio station that the coronavirus pandemic likely "won't be under control" by then for events with big crowds to resume normally.

"In the spring and summer there lion). won't be any events with crowds in Spain, and possibly not in the fall either," Martinez-Almeida (pictured) said. "Because obviously the situation will not be fully under control. We will have to change our habits and behaviors even after being allowed to go back on to the streets."

Spain has been one of the hardest-hit countries with more than 190,000 confirmed cases of COV-ID-19, only behind the United States. More than 20,000 have died in the European nation.

The Spanish league is not expecting to resume at least until the end of May. It is working on several scenarios, including playing without fans through the fall

"Soccer matches without fans in the summer is a possibility, as long as health and safety conditions are observed," Martinez-Almeida said.

The soccer federation said this week that if the league can't resume it will use the current standings to decide the four clubs to play in the Champions League, which would

mean giving the spots to Barcelona. Real Madrid, Sevilla and Real Socie-

The league has said the total losses for not finishing the season because of the pandemic could reach nearly 1 billion euros. (\$1.1 billion). The losses if the league resumes with matches in empty stadiums would be about 300 million euros (\$325 million), and if it restarts with fans it would be nearly 150 million euros (\$163 mil-

Martinez-Almeida also said it was a "mistake" for Atletico Madrid fans to play its Champions League game against Liverpool. Nearly 3,000 Atletico fans attended the game on March 11, just days before the Spanish government declared a state of emergency and established lockdown measures that are expected to remain in place at least until April 26.

When asked by Associated Press whether international fixtures were likely to be played before 2021, Montagliani said: "I personally think that might be a bit of a challenge, not so much because of just the health issues around the world and the various degrees of preparedness, but also committing to international travel as soon as we come back."

"I think that domestic football is a priority. September is still in the books, but I would garner to say that I'm not sure it's there on solid ground the way things are trending right now."

The move would allow three weekends in October and November.
