### Putin: Russia has cancelled \$20bn of African debt

**SOCHI** 

THE total amount of African countries' debts to the Russian Federation that Moscow has written off has already exceeded \$20 billion, President Vladimir Putin said at a plenary session of the Russia-Africa Economic Forum on Wednesday, noting that Moscow consistently supports the development of the African continent.

"We provide trade preferences while cooperating within the framework of international structures for example through the World Food Program, International Civil Defense Organization and World Health Organization. Our country participates in the initiative on African countries' debt relief. As of now, the total amount of debt relief exceeds \$20 billion," he said.

Joint programs that envision the use of borrowed funds for financing national economic growth projects have been launched together with a number of African countries, he stated.

A busy agenda is planned within the framework of the forum, with particular ideas and proposals regarding promising areas

Thus, heads of Russian companies together with the Ministry of Economic Development have prepared presentations of key Russian competences that open new possibilities for economic cooperation, he similarly indicated.

On Wednesday and Thursday this week, the resort city of Sochi is hosting the Russia-Africa Summit, co-chaired by Russian President Vladimir Putin and Egypt's head of state Abdel

The leaders of all 54 African countries have been invited, and at least 40 of them have confirmed their participation. Eight major African integration associations and organizations are also involved in the event. On the summit's sidelines, an economic forum is taking place, in which the continent's heads of state and representatives of the business community and government agencies participate. The Roscongress Foundation is the organizer of the event, and TASS is the official photo host agency of the summit and economic forum.

# National Service commander sets tone to uplift army wing

# Child rights NGOs jubilant at marriage age appeal verdict

CHILD rights advocacy organization celebrated as the Court of Appeal yesterday upheld the 2016 judgment by the High Court that declared marriage before the age of 18 as unconstitutional.

The government immediately appealed against the High Court decision to strike out all provisions in the Marriage Act, 1971 which allowed girls to marry at 15 with parental consent and 14 with the permission of a court.

"What a day for girls in Tanzania! Finally the Court of Appeal has upheld the landmark 2016



ruling by the High Court which set the minimum age of marriage for girls from the age of 14 years to 18 yrs," said Plan Tanzania in a tweet.

With a message 'a child is not a wife; end child marriage' Equality Now posted on its social media platforms:

The 2016 High Court decision stated that the 1971 Marriage Act provisions that allow girls to marry at 15 with parental consent and 14 with the permission of a court were unconstitutional.

The judicial move at the time came barely a week after the country, which has one of the

PRIME Minister Kassim Majaliwa has invited state-owned Russian Railways Company for formal talks on implementation of projects ranging from rehabilitation of the existing railway lines to construction of new ones.

The PM, who is representing President John Magufuli in the Russia-Africa Summit which kicked off yesterday, extended the invitation during his meeting with the Managing Director of Russian Railways, Alexander Misharin in the city of Sochi on

A statement released yesterday by the Prime Minister's Office said Majaliwa told Misharin of the government's plan to develop commuter train services in the major cities of Dar es Salaam, Mwanza, Dodoma, Arusha, Mbeya and Tanga.

He said the project also includes the rehabilitation of the Tanzania Zambia Railway (TAZARA), the Tanzania Railway Corporation (TRC) central line from Dar es Salaam to Kigoma and to Mwanza on Lake Victoria as well as the northern line from Tanga to Arusha.

A statement released yesterday by the Prime Minister's Office said **Majaliwa told Misharin** of the government's plan to develop commuter train services in the major cities

The premier said the company was well placed to take up the project given its expertise in managing infrastructure and operating freight and passenger train services.

The PM suggested that should the talks result into a Russian company taking up the job, undertaken in collaboration with Tanzanian companies so that the country benefits from technology transfer at the end of the works.

"The government also plans to build another railway line in the southern corridor from Mtwara to Ruvuma Region. This line will connect the port of Mtwara to hinterlands of the southern regions as well as neighbouring states of Malawi and Zambia," the statement noted, citing remarks from the premier.

For his part, Misharin said the railways giant is ready to work on the projects in collaboration with Tanzanian firms to enable the transfer of technology.

Earlier, Majaliwa met directors of the Russian agricultural machinery manufacturing company BTP, Alexsey Punkov and Ignat Dydyshkoa who expressed interest in investing in Tanzania in the supply of tractors and other

### Tanzania declares stand on ongoing Hong Kong protest

TANZANIA has declared its stand on the ongoing Hong Kong protest insisting to support China's legitimate handling of the matter under the 'one country, two systems' arrangement.

Legal and Constitution Affairs Minister, ambassador Dr Augustine Mahiga made the statement on Tuesday when speaking at the reception to celebrate the 5th anniversary of China-Asian-African Legal Consultative Organization (AALCO) research and exchange programme on international laws.

Ambassador Mahiga said the ongoing issue in Hong Kong is China's internal affair and that it has started measures to address the issue which include meeting with their people to find amicable solutions.

The minister urged other countries to refrain from promoting or instigating riot or engage in unlawful activities.

"Let the people of Hong Kong and China manage the situation in amicable settlement," he noted.

Ambassador Ke added that China had always been staunch upholder of international law and an active promoter of Asian-Africa unity saying it has been willing to work with strengthen exchange and cooperation on international law.

She said AALCO has served as important institutions and platforms for Asian and African countries to strengthen their legal exchanges and cooperation and jointly safeguard the authority of international law.

The AALCO - research and exchange programme on international laws is one of Chinese government initiative set up in 2015 with a view to enhancing exchange and cooperation in international law among Afro-Asian countries.

Since its establishment, AALCO has provided an important platform to promote and advance common position and bringing change at international level for the benefits of the regions.

AALCO is an international governmental organization formed in 1956, initially to serve as an advisory board to member states on matters on international law.

# Veteran politician James Mapalala dies at 83

A VETERAN politician and the first Tanzanian who demanded the reinstatement of the multiparty democracy in 1986, James Mapalala has died at the age of 83.

Bernard James, who is the deceased's son said the founder of Tanzania's multiparty democracy died at the Dar es Salaam's Hubert Kairuki Memorial Hospital (HKMH) where he was receiving treatment.

He said his father died at around 10:30am and he was admitted at the hospital for nearly two weeks after developing breathing

James said family members and friends would be meeting at the deceased's home in Kinondoni Morocco and details of his burial would be announced in the due

In 1986, Mapalala was jailed for several children.

two years in Lindi and later taken to detention in the Mafia Island before being released in 1989.

He was accused of forming a political party contrary to demands of the country's constitution and laws governing the country at that

He officially formed the Chama cha Wananchi (CCW) in 1991, and then united it with another political party formed in Zanzibar-Kamahuru to form the present Civic United Front (CUF) in 1993.

He was elected the first party's national chairman, the position he served until 1994, when his tenure ended following a political wrangle that erupted in the party.

The party was then left in the hands of Prof Ibrahim Lipumba as the national chairman and Seif Shariff Hamad as secretary general. Mapalala is survived by a wife and

highest rates of child marriage globally, made it an offense for people to marry primary and secondary school age girls punishable by up to 30

The High Court ruling was made in response to a petition filed by Rebecca Gyumi, founder of Msichana Initiative, a charity promoting girls'

The group argued that provisions in the Marriage Act violated girls' rights to equality, dignity and access to education as granted by the constitution.

The High Court said in the ruling that the law was discriminatory and unfair because it allowed a girl of 14 to be married while males could only marry once they reach 18.

The court ordered the government to amend the Marriage Act within the next year and ruled that the legal marriage age for men and women should be recognized as 18 years, which the government has not carried out.

Tanzania has one of the highest adolescent pregnancy and birth rates in the world, and 21 percent of girls aged 15 to 19 have given birth, according to a 2015/16 survey by the Tanzania Bureau of Statistics.

TRADERS and entrepreneurs in Coast region have been urged to certify their products to relevant authorities so as enable compete in local and foreign markets.

The advice was given yesterday by the public relations officer of Tanzania Bureau of Standards , Neema Mtemvu at the just ended Coast region industrial week and Investment event.

She said the organisation has participated in the event in order to educate entrepreneurs on the importance of standards and procedures to obtain licence of quality mark.

She noted that the cost of obtaining such mark for entrepreneurs is free, since the government had already covered it.

She explained that any interested entrepreneur must get an introduction letter from Small Industries Development Organisation (SIDO) and forward to TBS where the process to obtain license starts.

Mtemvu said the bureau recognize the role played by entrepreneurs in increasing Gross Domestic Product and employment creation, that is why they have been sensitizing them to obtain

the license.

She said in developing industrial economy, entrepreneurs have to adhere to standards that are the motive behind to which led them to participate in the exhibition.

The TBS official appealed to residents in Coast region and other areas to consume certified products for their health benefits.

In the meantime, she said they have used the opportunity to inform participants on change of roles which was earlier conducted by the former Tanzania Food and Drugs Authority (TFDA) and now are being done by TBS.

The fifth phase government has identified the challenge, and now it is much easier to obtain the quality mark of licence and it has reduced unnecessary procedures.

#### Sixty nine arrested for illegal water connections in Mbeya

SIXTY NINE people have been arrested in Mbeya City accused of sabotaging water infrastructure of the city's Water Supply and Sanitation Authority (WSSA) including illegal water connections.

The acts of sabotage have reportedly caused Mbeya WSSA to suffer 76m/- loss that has been spent to repair the infrastructures.

Speaking to reporters in his office early this week Mbeya WSSA Managing Director Eng. Ndele Mengo said cases against some of those nabbed are already in court whilst others have agreed to settle the issues out of court by agreeing to pay compensation.

Eng. Mengo said: "Up to now a total of 28m/only has been paid as compensation and we have given the others seven days to do so because they are just thieves like any other, and if they fail to pay we will take legal action against them."

He said Mbeya WSSA spends huge sums of money to treat and supply as they have 15 sources of water that use electricity and 10 water treatment plants stations, hence any acts of sabotage cause huge losses to them.

He reiterated that WSSA will not pardon any person who will be arrested stealing water or sabotaging the authority's infrastructures because such acts deny other law abiding citizens to have better water supply service.

In another development Eng Mengo said government institutions owe Mbeya WSSA a total of 1.5b/- in unpaid water bills.

He said the institutions include defense and security, health centres, education institutions and the office of Mbeya City Director.

He said JWTZ owes WSSA 43.9m/-, Police Force (657.9m/-), Prisons Service (631.9m/-) and Prisons Training College (225.8m/-)

He also urged the wananchi to continue to cooperate with WSSA by paying their water bills to enable the authority to operate profitably. He also urged them to cooperate by giving information on any breakdowns to the WSSA infrastructures that may cause loss of

water or leakages to sewerage drainage.

UCSAF to connect 708 wards with communication network

In April this year, the Prime Minister Kassim Majaliwa urged all mobile phone network service providers operating in the east African nation to extend their network to cover all villages by December 2020.

"The mobile phone network providers have no option but to work in line with the government in making it a reality," said Majaliwa at an event to mark 10 years of UCSAF services in the country.

IMMIGRATION authorities in Morogoro region had apprehended 11 illegal immigrants from Ethiopia.

### WCF wins stakeholders commendations for improving workers compensation benefits

TANZANIANS taking part in the 2nd industrial exhibition and business forum going on at Kibaha in Coast region have hailed the government for improving compensation benefits to workers in both, public and private sector.

Speaking after visiting the Workers Compensation Fund (WCF) pavilion yesterday, Coast Regional Commissioner, Eng Evarist Ndikilo said establishment of the fund is a blessing to workers especial those in the industrial sector.

"May I congratulate you and specifically the government for improving social security funds as we now have the best compensation benefits. This has largely contributed into increased workers morale as well as enhanced relations between employers and employees," said Eng Ndikilo.

The RC called upon more Tanzanians to visit the WCF pavilion to broaden their understanding of the fund and its activities. He said the knowledge will help reduce confusions when a worker is injured in the course of executing his

Another visitor, Dr Aden Mpangile said: "I have broadened my understanding of the fund and how it works. Previously, I thought the National Health Insurance Fund (NHIF) was responsible for medical treatment of injured workers, but it is the

"I am told that compensation is paid to injured workers after completion of evaluation," he said.

The Fund's Senior Investment Officer, Michael Semiono said WCF is one of the key stakeholders of the industrial exhibition since it gears to reach most of its stakeholders including workers and employers.

Semiono noted that to support the government's industrialisation agenda, WCF is also taking part in various industrialisation projects in the regions of Dodoma, Morogoro, Tanga and Simiyu.

The senior official noted that WCF provides various types of compensation including medical treatment to injured workers, maintenance services and counseling to injured personnel with permanent disabilities. She said the fund

also pays a certain amount of money to a person who is taking care of an injured worker upon approval from doctors.

WCF was established to provide compensation to employees injured or incapacitated in the course of employment under the Workers' Compensation Act 2008. The Act applies to employees from both the private and government sector.

The act requires all the employers to make contributions to the fund whereby employers from the private sector contribute 1 percent and public sector employers contribute 0.5 percent of their annual tax bill for one year.

Last week, in her opening speech at the opening of the 2nd industrial exhibition and business forum, Vice President Samia Suluhu Hassan stressed on establishment of domestic industries that use readily available resources in production to increase jobs and boost the national economy.

She as well challenged industrialists to focus on manufacturing products that are needed in the domestic market.

The second annual exhibition in the region has attracted 329 exhibitors.

### Modern technology to control motorcycles, vehicles theft unveiled

#### By Guardian Correspondent, Arusha

PERSISTENT thefts of motorcycles and other vehicles could now be past history in Arusha region and the country in general following the launching of new technology to control thefts.

The approach that will employ Internet Communication Technology (ICT) has been unveiled by Benson and Company here in partnership with a Dar es Salaam firm based AfriTrack.

Benson and Co. Chief Operations Officer Miqdaad Kassam said at the launching ceremony here that by using the new technology, when a motorcycle is stolen it can now be recovered as it will be tracked all the time. "It's a simple technology designed to control motorcycle

theft that has become a very big problem. When you fix this 'anti-theft' device to your motorcycle you don't have to worry at all, it will be recovered," stressed Kassam at the launching ceremony. Elaborating, Benson's Chief Customer Service Officer

Salma Rothbletz said the device affixed to the motorcycle is connected to the owner's mobile phone where he obtains all data on the machine's whereabouts. She added that the technique also control's cheating by

to track the vehicles. He said this system is already in use in Ivory Coast, Malawi, Zambia and has now found its way in Tanzania - Dar es Salaam, Arusha, Mwanza and Mbeya regions.

The representative from Kiure Engineering Company, Omar Kiure said at the launching ceremony the system designed to control road vehicles and people driving them is a huge step against theft of fuel that instill huge losses to transport companies.

On his part, Atilio Choga, from Arusha Traffic police dealing with giving education to drivers on road safety said the system will assist the police in reigning road accidents.

He said currently road accidents in Arusha Region have declined substantially, and added that the coming of this new technology will assist them in minimizing road accidents even further.

is an intergovernmental organisation responsible for maintaining international peace and security, developing friendly relations among nations, achieving international cooperation, and being a centre for harmonizing the actions of nations. It is the largest, most familiar, most internationally represented and most powerful intergovernmental organization in the world. The UN is headquartered on international territory in New York City; other main offices are in Geneva, Nairobi, Vienna and The Hague.

United Nations Day is devoted to making known to people of the world the aims and achievements of the United Nations Organisation. United Nations Day is part of United Nations Week, which runs from 20 to 26 October.

In 1948, the United Nations General Assembly declared 24 October, the anniversary of the Charter of the United Nations, as which "shall be devoted to making known to the people of the world the aims and achievements of the United Nations and to gaining their support for" its work.

In 1971, the United Nations General Assembly adopted a further declaring that United Nations Day shall be an international observance or international holiday and recommended that it should be observed as a public holiday by United Nations member states.

The first event called "United Nations Day" was a World War II Allies' day of solidarity and military parades launched by US President Franklin D. Roosevelt tied to US Flag Day on June 14, 1942, six months after the Declaration by United Nations. It was observed in New York City as the "New York at War" parade, in London, and by the Soviet and Chinese governments.

It was observed throughout World War II, during 1942-1944. Prior to the

THE United Nation (UN) foundation of the UN itself, it was not directly connected to the current international observance.

UN Day has traditionally been marked throughout the world with meetings, discussions and exhibits about the achievements and goals of the organization. In 1971, the General Assembly recommended that member states observe it as a public holiday.

Several international schools throughout the world also celebrate the diversity of their student body on United Nations Day (although the event is not necessarily celebrated on 24 October). Celebrations often include a show of cultural performances in the evening and a food fair, where food is available from all over the world.

In the United States, the President has issued a proclamation each year for United Nations Day since 1948.

In Kosovo, United Nations Day is an official non-working day, as the province is administered by the Interim Administration Mission.

In the Philippines, schoolchildren customarily dress in the national costumes of member states and hold a programme on U.N. Day, which is the last school day before semestral break. Individual students, classes, or grade levels are assigned a country to represent and study; students handcraft their assigned country's flag, and prepare cultural presentations and food as part of the day's educational activities.

The UN's World Development Information Day has also been held on 24 October since 1972 Humanity has entered the era of sustainability with a global commitment to fulfill the great promise of the 2030 Agenda for Sustainable Development. It is celebrated on 24 October worldwide. Many institutions celebrate it by conducting quizzes and elocutions. Da Potta Group of Companies in Kenya, Tanzania and India celebrate it with various discussions.

# UN summit on financing for development: SDGs ambition versus financing reality

HE United Nations (UN) an intergovernmental organisation responsible for maintaining international peace and security, developing friendly relations among nations, achieving international cooperation, and being a centre for harmonizing the actions of nations. It is the largest, most familiar, most internationally represented and most powerful intergovernmental organization in the world. The UN is headquartered on international territory in New York City; other main offices are in Geneva, Nairobi, Vienna and The Hague.

The UN was established after World War II with the aim of preventing future wars, succeeding the ineffective League of Nations. On 25 April 1945, 50 governments met in San Francisco for a conference and started drafting the UN Charter, which was adopted on 25 June 1945 and took effect on 24 October 1945, when the UN began operations. Pursuant to the Charter, the organization's objectives include maintaining international peace and security, protecting human rights, delivering humanitarian aid, promoting sustainable development, and upholding international law.[5] At its founding, the UN had 51 member states; there are now 193, representing the vast majority of the world's sovereign states.

The organization's mission to preserve world peace was complicated in its early decades by the Cold War between the United States and Soviet Union and their respective allies. Mobilising public finance

First, can we mobilise enough public finance, spend it well and direct it to SDG investments that individuals and the private sector can't or won't pay for? ODI's report Financing the end of extreme poverty finds that most countries could afford the public investments needed to provide universal healthcare, education and social protection if they allocated enough of their budgets to these goals -and raised more in tax (though this may not be an easy ask, which I'll come to later).

Forty six countries can't afford these investments on their own, but if donors met the UN commitment to give 0.7% of their income as aid, this could provide the missing money, if well targeted. There are growing calls for the UN to take public financing gaps more seriously, particularly as, according to the International Monetary Fund (IMF), more than two out of five low-income countries are at high risk of debt crises, and may therefore find their spending plans seriously undermined.

Shifting private investment patterns Second, can we shift private investment and consumption patterns so that developing countries grow sustainably and inclusively and the global economy moves rapidly to become zero carbon and protect the natural world on which we all depend?

Here the FfD debate has been side-tracked by a focus among many international institutions and rich countries on the smaller sub-issue of 'monumental challenges' remain. how to use public support or subsidies Hunger, for example, is going in the to leverage more private finance an increasingly wide margin.

ODI research finds that on average every dollar of investment through the development finance institutions that are the focus of this agenda leverages only 75 cents of private investment, falling to 37 cents in low-income countries. Clearly, this is not the magic bullet it is sometimes presented as.

Sharing economic gains

Third, can we alter global, regional and national economic structures to share the distribution of the enormous economic gains humanity has made more fairly so that everyone has enough to live well, and those at the top take a smaller slice of the pie?

This issue was emphasised by the G77 group of developing countries in their statement to the Dialogue, which pointed to areas where the international system does not work well, including illicit financial flows and tax evasion.

Just before the Dialogue, the IMF and Copenhagen University warned that 40% of global foreign direct investment some \$15 trillion - is 'phantom', meaning it passes through corporate shell companies often set up to minimise the tax bills of multinationals.

This is part of a broader problem inherent in an international system that does not provide developing countries with enough of the kind of long-term capital investments they need. For example, UNCTAD's new Trade and development report highlights that international private capital proves consistently volatile, and was in fact a net outflow for developing countries in 2018, as the chart shows.

As is normal at these gatherings, a large number of side initiatives were launched or highlighted at the Dialogue, but, while many are welcome, they cannot replace coordinated action by UN member states together. However, there were no agreed concrete outcomes from the Dialogue itself, and governments have yet to use the annual FfD forums as a mechanism for changing course now it is clear we are way off track to finance the SDGs.

To get world leaders to take this critical issue more seriously, there are calls for a new leaders summit on FfD in 2022 (20 years after the first). Without a renewed push like this to put the issue of financing the SDGs back at the top of the global agenda, and tackle the difficult questions highlighted here, it looks increasingly likely that the world will fail to meet the SDGs, and by

#### **World Development Information Day:** Aims to inform, motivate young people

as the resolution of uncertainty; it is that which answers the question of "what an entity is" and thus defines both its essence and nature of its characteristics. It is associated with data, as data represents values attributed to parameters, and information is data in context and with meaning attached. Information relates also to knowledge, as knowledge signifies understanding of an abstract or concrete concept.

In terms of communication, information is expressed either as the content of a message or through direct or indirect observation. That which is perceived can be construed as a message in its own right, and in that sense, information is always conveyed as the content of a message.

Information can be encoded into various forms for transmission and interpretation (for example, information may be encoded into a sequence of signs, or transmitted via a signal). It can also be encrypted for safe storage and communication.

The uncertainty of an event is measured by its probability of occurrence and is inversely proportional to that. The more uncertain an event, the more information is required to resolve uncertainty of that event.

The concept of information has different meanings in different contexts. Thus the concept becomes related to notions of constraint, communication, control, data, form, education, knowledge, meaning, understanding, mental stimuli, pattern, perception,

representation, and entropy, In 1972, the United Nations General Assembly decided to institute a World Development Information Day coinciding with United Nations Day on October 24. The General

> The day was further recognized as the date on which the International Development Strategy for the Second Nations Development Decade was adopted in 1970.

> On May 17, 1972, the UN Conference on Trade and Development (UNCTAD) proposed measures for information dissemination and for the mobilization of public opinion relative to trade and development problems. These became known as resolution 3038 which the UN General Assembly passed on December 19, 1972. This resolution called for introducing World Development Information Day to help draw the attention of people worldwide to development problems. A further aim of the event is to explain to the general public why it is necessary to strengthen international cooperation to find ways to solve these problems. The assembly also decided that the day should coincide with United Nations Day to stress the central role of development in the UN's work. World Development Information Day was first held on October 24, 1973, and has been held on this date each year since then.

#### China's economic performance stable in first three quarters

"SOME foreign media's skepticism about China's recent economic growth figures and their assertion of 'a sharp slowdown' in the Chinese economy were indefensible and groundless," Yuan Da, spokesperson for the National Development and Reform Commission (NDRC) said at a press conference on Mon-

China recently released a set of economic figures in the first three quarters of the year, which aroused heated discussions at home and abroad. Some saw the 6-percent year-on-year growth in the third quarter and started to worry about the growth rate of the economy.

China's GDP expanded 6.2 percent year on year during the first three quarters, which was among the fastest in major economies, Yuan noted.

During the seven-day National Day holiday, China's railways, roads, waterways and civil aviation network saw more than 500 million passenger trips. In particular, 370 million cars passed through toll roads across the country.

In the first three quarters of the year, electricity consumption of the country rose by 4.4 percent year on year, with electricity consumption in service industry and residential power consumption increasing by 8.7 and 6.3 percent respectively, the spokesperson said, adding that freight volume went up 5.9 per cent year on year during the period.

"These indicators were the most direct reflections of economic growth, which prove that the national economy maintained overall stability," Yuan noted.

Since the beginning of the year, China has maintained overall stability in economy and improved its economic structure and the well-being of its people amid rising internal and external risks and challenges, the spokesperson said, adding that Chinese economy has maintained stability while making progress, which was not an easy task.

Although the economic growth rate in the third quarter has slowed slightly, the quality of economic development in China is seeing continuous improvement.

In the first nine months, the country accomplished 99.7 percent of its annual objective for creating new urban jobs. Last month, the country's surveyed urban unemployment rate stood at 5.2 percent.

Transformation and upgrading of industries have accelerated in China during the first three quarters of this year, with the added-value of strategic emerging industries and high-tech manufacturing increasing by 8.4 and 8.7 percent respectively, significantly faster than the growth rate of overall industrial enterprises above designated size.

Meanwhile, China's energy consumption per unit of GDP dropped by 2.7 percent year on year, and the country maintained a generally stable ecological environment.

As China's economy transitions from a phase of rapid growth to a stage of high-quality development, it is acceptable whether

the economic growth is lower or higher than before as long as employment and people's incomes are expanding, and the ecological environment and development quality are improving, the spokesperson said.

He added that Chinese economy still faces a complicated and severe economic development environment both at home and abroad, as well as considerable downward pressure and difficulties and challenges, but China has the condition, ability and confidence to realize steady, sound and sustainable economic development.

Since this year, some enterprises in China have relocated their capacity to Southeast Asia to reduce costs and fend off risks due to rising uncertainties at home and abroad. Certain media spreading hearsays that a handful of firms were leaving China.

In response to such voices, Yuan said it is a normal market phenomenon that some companies establish plants and carry out cooperation in foreign countries to meet new development needs.

In recent years, China's manufacturing has entered a stage of transformation, upgrading and high-quality development as the world witnesses international division of labor and profound adjustments in global industrial landscape, Yuan said, explaining that it is only normal that some companies go global and establish factories, operate and conduct investment cooperation outside of the country in this process.

Besides, the fact that some companies go global doesn't mean that the Chinese market loses its strong appeal to foreign investment.

On the one hand, the fundamentals of the Chinese economy remain strong. With a huge market, abundant human resources, well-developed infrastructure, a complete industrial chain and fullfledged supporting industries, China sees constant vitality and dynamism in making innovations and new creations, and unchanged upward economic trajectory and continuous industrial upgrading.

On the other hand, China has continuously improved its business environment. Chinese government has strived to create a market-oriented and international business environment which is based on the rule of law, further expanded opening-up and eased market access for foreign investment.

In addition, it has taken powerful measures to cut taxes and fees, endeavoring to offer all market entities, including private companies and foreign-invested enterprises, a better and more attractive business environment. **People's Daily** 

# Helmets: Stakeholders show what needs to change in the law

WEARING helmet does not prevent car crash or accident taking place instead it minimizes impact or force in case of collision to head causing serious head, brain injuries and

According to Global Status Report on Road Safety 2018, correct helmet use can lead to a 42 percent reduction in the risk of fatal injuries and a 69 percent reduction in the risk of head injuries.

The report further states that the use of helmets is, as such, an increasingly important means of preventing road traffic deaths.

However, the current Tanzania Road Traffic Act of 1973 is silent about the standard use of helmet.

It neither imposes an obligation to the rider and passenger to wear helmet nor describe the correct way of wearing

The section 39 (1) recognizes the need for helmet only for the riders and is silent for passengers.

Furthermore, it does not prescribe the standards of helmet either in the main Act or the regulations. It is also silent on the use of age appropriate helmets for young children riding on motorcycles

The Transport Licensing Act 1973 (TLA) on the other hand places duty for helmet use for both the rider and passenger.

That's why road safety stakeholders advocate for policy makers and law enforcers to work for mandatory provision for both the driver/rider and passengers to correctly wear helmets which are in conformity with international and national standards.

In 2013, the Tanzania Bureau of Standards (TBS) released the national standard to govern the manufacturing, importation and general usage of motorcycle helmets known as TSZ 1478:2013 - Protective helmets for motorcycle riders-Specification

The specification aims to prohibit all dealers, importers and manufacturers from importing or manufacturing substandard helmets.

It is important to prevent the impacts of motorcycle crashes by supporting and passing Road Traffic Act amendments that include provisions requiring both motorcycle drivers and passengers to wear quality standard helmets to

The Global Status Report on Road Safety 2018 further indicates that motorized two- and three-wheelers users represent 28 percent of all deaths reported in the world while pedestrians and cyclists represent 26 percent.

"Enacting and enforcing legislation on failing to use motorcycle helmets and other key risk behavior factors including speed, drink-driving and non-use of seatbelts, child restraints are critical components to prevent road traffic



deaths," recommends the report.

In his view, the Helmet Vaccine Initiative Tanzania (HVI-T), Chief Executive Officer Alpherio Nchimbi says that the Road Traffic Act, Chapter 168, R.F.2002, the principal legislation for administering safety in road transport has many loopholes and gaps which affect the intended aim of reducing the rate of road crashes.

He went on to say that basically this means that the traffic law only requires the drivers/riders to wear helmets, while passengers (according to this provision are not mandatorily required to wear helmets).

Section 39(11) of the Road traffic Act provides for the requirement of wearing helmets by motorcycle riders/driv-

It states that "no person shall drive a two wheeled or

three wheeled motorcycle unless he is wearing a helmet; but the minister may exempt any person from the requirement to wear helmet while so driving.' Furthermore, it prohibits any person younger than the

age of 16 to ride a motor vehicle, which basically means that children (those under 16) are not covered by helmet laws because they are actually not allowed to ride as passengers.

He said that tnternational best practices stress both legislation for helmets wearing as well as standards and use of quality helmets.

"We need to have a mandatory law for both the driver and passengers to correctly wear helmets which are in conformity with international and national standards," he says.

The Global Status Report on Road Safety report launched

by the World Health Organization (WHO) last year indicated that best practice for motorcycle helmet laws includes a requirement for both motorcyclists and passengers to wear a helmet on all roads, a specification that helmets should be fastened, and a reference to a helmet standard.

The report says that since 2014, five countries have made amendments to existing legislation to align them with best practice, providing coverage to an additional 397 million people.

The Head of Emergency Department (EMD) at Muhimbili National Hospital (MNH),Dr Juma Mfinanga insists that "unless the government amends the section 39 (11) dealing with helmet use so as to be in conformity with international and national standards, the number of victims associated with head injuries will increase."

Equally important, Dr Mfinanga says helmet use plays a big role to reduce risks of head injuries and death.

The expert says motorbike crashes from whatever cause were levying a cruel tax to individuals, families and communities while causing a drain to the health budget.

When a family member becomes mental illy after a road crash, it results into frustration as the victims cannot produce or be employed in any serious task and must depend on relatives for survival.

Civil Society Organizations (CSOs) coalition hosted by the Tanzania Women Lawyers Association (TAWLA)and 15 other members on road safety issues highlight existing gaps in the current road safety legal framework in Tanzania, particular indicating deficiencies in the Road Traffic Act, chapter 169 of 2002 deficiencies

These are Tanzania Women Lawyers Association (TAWLA), Tanganyika Law Society(TLS), Tanzania Media Women Association(TAMWA), Road Safety Ambassadors(RAS), Tanzania Child Rights Forum and AMEND.

Others are Tanzania Association of People with Disabilities, Tanzania Bus Owners Association (TABOA), National Institute of Transport (NIT), Tanzania Media Foundation (TMF), Safe Speed Foundation and other individuals with expertise and passion on road safety.

The coalition team, in their positioned paper, urged amendments in archaic road traffic law, identifying key risk factors as non-use of seat belts/child restraints, use of alcohol while driving, speeding, non-use of helmet and distracted driving, evidenced by the need for a comprehensive Improved Road Safety Legal and Policy Envi-

The paper discloses that although the Act was intended to tackle and reduce the rate of road accidents, the same has not been sufficient to cover the problem.

"There are many loopholes and gaps in the Act which affects the intended aim of reducing the rate of crashes," it underlined.



# Use of improved cook stoves pivotal in saving natural forests, biodiversity

THE Sustainable Holistic Development Foundation (SUHODE Foundation) has suggested the need for the government to enforce mandatory use of improved clean cook stoves for all households and institutions to save the country from turning into semi-desert.

The foundation's director, Frank Luvanda said that the use of improved cook stoves will help reduce 40 percent to 50 per cent of biomass consumption at households and institutions levels hence contribute towards sustainable utilization of biomass from natural forests.

According to Luvanda, the foundation under support from WWF Tanzania and SIDA through a project entitled "Leading the Change: Civil Societies, Rights and Environment" is building affordable improved cook stoves at household levels in two villages-Njungwa village in Gairo district, Morogoro region and Mchakama village in Kilwa district Lindi region.

In the two villages, local communities using improved cook stoves have confirmed reduction of biomass consumption measured through frequencies of entering the forests for firewood, the environmental activist said, adding:

"Most of households used to go to the forests at least twice a week for firewood collection but since they started using improved cook stoves they only go once a week and some firewood collection had showed 50 per cent reduction."

Citing a study by the Center for International Forestry Research, (CIFOR), he said: "The same experience of biomass reduction has been confirmed in Ethiopia whereby improved cook stoves for Injera (a staple food in Ethiopia) showed 40 per cent reduction of biomass consumption as compared to traditional three stones cook stoves."

On affordability and reliability of such improved cook stoves, said that there are lots of such improved cook stoves made by several institutions which can readily be available to users. The costs for proposed improved cook stoves can range from a 15,000/- per improved cook stoves up to 3m/for institutional-based improved cook stoves, he said, noting that there are several varieties to suits urban and rural needs as well as to suits individual's purchasing power.

"As foundation, we're ready and willing to transfer knowledge of making affordable improved cook stoves to local communities something that will reduce costs for rural com-

"SUHODE Foundation is confident and optimistic that introducing and enforcing mandatory uses of improved cook stoves at household and institutional levels will save the quick diminishing of natural forests in Tanzania hence save the country from falling into semi-desert," Luvanda said in an exclusive interview.

According to information from CIFOR, improved cooking stoves (ICS) have a long history in nature conservation and development projects; as they bear the potential to reduce the pressure on forest resources and improve local livelihoods at the same time.

"That's why we're suggesting the need for the government to legally introduce mandatory uses of improved cook stoves at household and institutional levels for the purpose of saving our natural forests in Tanzania," he said.

He added that the recommendation aligns well with various national policies and plans such as the National Energy Policy 2015, National Environmental Action Plan (NEAP) 2013-2018, National Environmental Policy 1997, National Forest Policy 1998, Wildlife Policy 2007, Forest Act No 7 of 2002, Environmental Management Act No 20 of 2004, Wildlife Conservation Act No 5 of 2009, Water Resource Manage ment Act No 11 of 2009, etc; all these aim at sustainable management of natural resources in Tanzania.

"This is also in line with the World Bank Group recommendation, which highlights the importance of access to modern fuels and low impact urbanization. Limiting the amount of biomass fuel consumed by households would have an immediate positive impact on ecosystems and human health."

He also said that SUHODE Foundation will continue working hard to support government's environmental protection initiative and sustainable management of natural resources. "The foundation will embrace natural rejuvenation tech-

landscapes as part of its forest restoration program. It will continue to embark on renewable energy interventions by facilitating local communities to embrace energy efficient cook stoves as well as other renewable energy options."

niques to restore degraded natural forest

According to him, the foundation is quite optimistic that the government of Tanzania will take measures and decisions that favor protection and conservation of natural forests

"SUHODE Foundation hopes that the gov-

ernment of Tanzania will embrace sustainable uses of natural forests to ensure its sustainability in the long term not only for us but for future generation as well."

"The confidence that foundation has right now is based on the fact that the fifth government of Tanzania has taken desired actions to increase efforts in conservation," he said.

Current data shows that forest loss in Tanzania is huge as the country losses 469,420 per annum. According to the World Bank Group Report of 2019, Tanzania is one of the fastest deforesting countries in the world, whereby

firewood and charcoal are among the key drivers of tree felling. Tanzania's Sustainable Energy for All Action Agenda 2015 said that more than 90 percent of the country's rural households use biomass from natural forests for cooking while in urban areas 62 percent of households use charcoal for cooking and

heating. Some of the negative impacts of natural forest loss are biodiversity loss, loss of wildlife habitat, loss of water sources, shrinking of wetlands and water catchment areas, and destruction of river banks.

"Our forests are shrinking year after year hence requiring strong measures to stop deforestation in the general land adjacent to cities and towns as well as in protected areas.

"Personally, I really fear the future of our current and next generations as they may find themselves amidst chaos due to lack of reliable clean water supply, reliable energy sources, as well as reliable natural air cleaning mechanism. The same generations might find engulfed amidst erratic and unpredictable rains, food insecurity, and polluted air," Luvanda said.



# An expanding Sahara leaves broken families and violence in its wake

"We lived happily as a big family before the war and ate and drank as much as we could by growing crops and raising livestock," he tells IPS.

"Then the war broke out and our lives changed forever, pushing us southwards, finally settling in the region of Mopti. Then we went back home in 2013 when the situation stabilised," Abdoulaye explains.

In 2012, various groups of Tuareg rebels grouped together to form and administer a new northern state called Azawad. The civil strife that resulted drove many from their homes, with communities often fleeing with their livestock, only to compete for scarce natural resources in vulnerable host communities, according to the United Nations.

In Mali, three-quarters of the population rely on agriculture for their food and income, and most are subsistence farmers, growing rainfed crops on small plots of land, according to the Food and Agriculture Organisation (FAO) of the U.N. After the security situation began to improve in 2013, many

returned home to rebuild their lives and livelihoods.

But soon it was the turn of the expanding Sahara Desert, drought and land degradation that became the next driver of their displacement.

"As time went by, the land became useless and we found ourselves having no more land to work on. Nothing would come out that could feed us, and our livestock kept dying due the lack of water and grass to eat," Abdoulaye recalls.

"Drought across the Sahel region, followed by conflict in northern Mali, caused a major slump in the country's agricultural production, reducing household assets and leaving many of Mali's poor even more vulnerable," FAO says.

"We used to move up and down with our livestock, looking for water and grass, but most of the times we found none. Life was unliveable. The Sahara is coming down, very fast," Abdoulave says emotionally.

In the end, the Maiga family had to leave their home and broke up; Abdoulaye and his brother Ousmane heading to Benin's commercial capital Cotonou in 2015, after a brief stint in Burkina Faso, as the rest of their family headed for Mali's capital, Bamako.

#### Threatened with creeping desertifi-

The U.N. says nearly 98 percent of Mali is threatened with creeping desertification, as a result of nature and human activity. Besides, the Sahara Desert keeps expanding southward at a rate of 48 km a year, further degrading the land and eradicating the already scarce livelihoods of populations, Reuters reported.

The Sahara, an area of 3.5 million square miles, is the largest 'hot' desert in the world and home to some 70 species of mammals, 90 species of resident birds and 100 species of reptiles, according to DesertUSA. And it is expanding, its size is registered at 10 percent larger than a century ago, LiveScience reported.

The Sahel, the area between The Sahara in the north and the Sudanian Savanna in the south, is the region where temperatures are rising faster than anywhere else on Earth.

# 500 retail shop owners, managers in Dar to undergo 12 month entrepreneurship course

OME 500 retail shop owners and managers will undergo yearlong entrepreneurship training and life skills aimed at growing their sales

Under TechnoServe Tanzania's Pan African Youth Entrepreneur Development (PAYED)'s phase three program covering 2019 to 2020 will enroll 100 individuals from each of Dar es Salaam's five municipalities of Kigamboni, Kinondoni, Ilala, Temeke and Ubungo.

"The 100 participants from each district will undergo one year entrepreneurship and self-employment skills training course aimed at improving retail trading and shop owners' skills in business management," said PAYED Program Manager, Tunsime Kyando.

Speaking in during the launch of phase three of the program in Dar es Salaam this week, Kyando said the course which will also involve mentorship, will be completed next September. Address district trade and business department officials from Dar es Salaam region, Kyando said success made during phase two of the CITI Foundation sponsored program has resulted into the extension.

PAYED phase two ended last month and involved Ilala and Ubungo municipalities only

and successfully managed to enroll 101 retailers above the targeted 250.

During the course, the candidates undergo theory and practical sessions for four months on the topics covering best shop management practices, better operations that involve merchandizing and customer care and financial management, among others.

"The other areas are supply chain management, investment opportunities and business planning," the PAYED Manager added.

Stakeholders who attended the meeting included regional trade officers, Tanzania Revenue authority, Tanzania Bureau of Standards, Weights and Measures Agency and private representative mainly from suppliers such as ASAS Dairy, Shambani Dairy and Azam Group.

TechnoServe, a global not for profit organization has since its establishment in 1968, working on programs that focus on empowering agribusiness entrepreneurs, retail shop traders and enterprises through capacity building.

On his part, Thabit Massa who is Principal Trade officer of Dar es Salaam region said the city has almost 200,000 retail traders and that the government consid-

# Banks facing even bigger risk of cyber attacks - Moody's

GLOBAL retail and commercial banks are facing an increasing risk of cyber attacks as their operations become more digitised, Moody's Investors Service has warned in a new report.

Cyber attacks can in turn end up impacting a bank's credit standing through financial losses, erosion of brand value and regulatory consequences, the rating agency added. The Moody's research for the report suggests that cyber attackers target banks in developed and developing markets alike.

Greater rewards

Banks in developed and wealthy markets are possibly more exposed because of their more prevalent digitalisation, as well as the more lucrative potential rewards of a successful cybercrime attempt. Larger banks in advanced and wealthy markets are at risk because of more widespread digitalisation and the high value of the data they house.

On the other hand, this is counterbalanced by access to security measures. "Smaller banks in developing markets often have fewer resources for cyber defence and internal controls, making them an easy target for financial theft," says Sophia Lee, a Moody's vice president and senior credit of-

"Cyber attacks often target weak links in payment networks or in banks' data platforms and vendors. Smaller banks have fewer resources for cyber defence, often have weaker internal controls and may operate in jurisdictions with few or no cybersecurity laws or regulations.

**Escalating losses** 

The report found that financial losses commonly occur via theft and fraud, and they generally affect banks through one-off reductions in profit and potentially capitalisation. More lasting franchise erosion, with indeterminate losses, can result from large data breaches or business disruption.

According to the report, the costs incurred from cyber attacks can escalate quickly as they increase in sophistication and simultaneously target multiple institutions. Furthermore, the increasing popularity of social networks can also be abused to quicken the propagation and increase the ferocity of cyber attacks, amplifying their potential to destabilise the financial system. In more extreme cases, this could threaten the viability of the targeted bank, states the report.

According to Kaspersky's Managed Detection and Response Analytics Report, sophisticated targeted attacks often use so-called "living off the land" techniques, which hide malicious activity within legitimate user and administrator behaviour.

"If you don't see a large number of 'false-positive' events in your network, that probably means that you are missing a lot of important security incidents," says Sergey Soldatov, head of the security operation centre at Kaspersky.

### Public debt repayments eat 57pc of KRA collections

**NAIROBI** 

For every Sh100 that Kenya collected as taxes in the three months to September, it used Sh57 on debt payments, underlining the heavy burden of mounting government borrowing.

Data from the Treasury shows that Sh214.79 billion was used for loan repayments in the first quarter of the financial year, making it the single-largest expenditure in the period to September. The repayments accounted for 57 percent of the Sh372 billion that the Kenya Revenue Authority (KRA) collected in taxes in the period under review, denying the State the cash it needs for projects like building roads,

power plants and revamping the

Kenya has ramped up spending in recent years to build a modern railway line, new roads and electricity plants, driving up borrowing to plug the Budget deficit.

The public debt crossed the Sh6 trillion mark in July, up from Sh1.89 trillion in June 2013, a growth that has sparked concerns that the ballooning loans risk hurting the economy due to the huge debt repayment burden

The government has defended the increased borrowing, saying the country must invest in its infrastructure, including roads and railways, to spur growth. The debt payment in the quarter to September is 40 per-

cent more than the Sh153 billion that taxpayers paid in a similar period a year earlier, when loan settlement costs took 46.7 percent of taxes.

The debt repayment was more than four times the development spend of Sh48 billion in the three months to September and more than nine times that of infrastructure like roads whose expenditure stood at Sh23 billion.

The Sh55 billion allocated to the 47 counties in the three months was less than a quarter of the cash spent on paying public debt in the quarter. A number of local and international agencies including the International Monetary Fund (IMF) and the World Bank have raised the red flag over Kenya's rising appetite for borrowing to finance State expenditure. Majority of African countries spend Sh1 for every Sh3 they collect in revenue on debt obligations, a

pointer that Kenya's is on the higher

MPs this month approved a change in the law that increased the cap for State borrowing to Sh9 trillion, giving the government leeway to further increase the public debt,

already considered worryingly high. Legislators unanimously supported the review of the law that re-

stricted public debt at half of gross domestic product (GDP). Kenya's public debt as a percentage of GDP has increased to 55 percent from 42 percent when President Uhuru

Kenyatta took office in 2013.

# S. Africa deficits expected to widen on Eskom woes – poll

**JOHANNESBURG** 

SOUTH Africa's finance minister is likely to raise the medium-term targets for budget deficits, a Reuters poll forecast on Tuesday, because of costs related to the state-owned power utility, Eskom.

A poll of 14 economists surveyed in the past week predicted Finance Minister Tito Mboweni would expand the budget deficit to 6.05% of gross domestic product, compared with a 4.5% projection in February for the year that began in April.

The poll put the next fiscal year's deficit at 5.6% of GDP, compared with a 4.3% forecast in February. "The budget deficit forecasts are likely to widen somewhat in the near term until revenue improves on collection efficiencies," said Annabel Bishop, chief economist at Investec.

Jeffrey Schultz, economist at BNP Paribas, said additional state support to Eskom would cut GDP by 1.2% over the next two years. South African President Cyril Ramaphosa said on Monday that the government will soon announce a permanent chief executive for state-run Eskom, after the struggling power utility reintroduced rolling blackouts last week.

"Eskom's long-term turnaround strategy released later this month should also indicate that an Eskom debt restructure is on the cards, with a good chance that a healthy portion of the state's nearly 7% of GDP in Eskom guaranteed debt will move onto the

sovereign balance sheet," Schultz said.

The crisis-hit utility, which produces more than 90% of South Africa's electricity, has been hobbled by technical and financial woes. It imposed days of power cuts last week after a number of its generating units broke down.

The company's debt stood at more than R440 billion in 2018/19, when the company reported a mammoth R20.7 billion annual loss.

As poor as the country's finances are, the poll predicted unanimously that South Africa would avoid a credit rating downgrade when Moody's reviews its status this month. However, Elize Kruger, an economist at NKC African Economics and Rand Merchant Bank economist Mpho Tsebe expect Moody's to lower its outlook to negative from stable on November 1. Some economists reckon a downgrade will follow in 12 months or more.

Last month, Moody's said fiscal risks and political constraints to economic reform in South Africa were reflected in its current credit rating, one notch above speculative grade. But maintaining that rating depended on how fast the government implemented promised reforms, it said.

A majority of economists said a debtto-GDP ratio of more than 70% would be considered a red flag for South Africa, but it would take more than five years to get there. The ratio currently sits around 57%. A separate survey last week predicted economic growth would remain under pressure at 0.6% this year and 1.2% next year.

# Nigeria mulls action to boost competition in telecoms industry

LAGOS

NIGERIAN regulators warned they may have to take action to boost competition in the telecommunications industry, a move that could affect international operators including market leader MTN Group Ltd.

While a formal inquiry isn't underway, authorities are focusing on ownership of data services and infrastructure in Africa's most populous nation, Babatunde Irukera, executive vice chairman of the Federal Competition & Consumer Protection Commission, said in an interview.

"We are slicing it a little slimmer than who has the most subscribers. We are looking more at data capability and data infrastructure," he said in Abuja, Nigeria's capital. "Early indications show that, depending on how it ends, we may have to take certain actions." Irukera declined to name a specific company that could be targeted.

MTN was awarded an additional broadband spectrum earlier this year

after a lengthy regulatory battle in which some rivals accused the Johannesburg-based carrier of undermining competition. The company has fought a number of battles with local authorities in its biggest market, and paid a fine of about \$1 billion in 2016 for missing a deadline to disconnect certain subscribers.

London-listed Airtel Africa and local operator 9Mobile claimed in a 2018 public inquiry that the transfer of 800 MHz from Visafone Communications to MTN could lead to a monopoly in an industry that represents more than 10% of the economy. MTN has denied it is reducing competition for spec-

Any potential measures may involve opening up spectrum to new bidders or ordering a firm to give up a frequency, said Irukera. He added that the concerns stem from an ongoing World Bank-led study about spectrum democratisation in West Africa. Any actions will be carried out in consultation with the Nigerian Communications Commission, Irukera said.

# Heineken profit growth to ease on Africa, Americas slowdown

THE HAGUE

HEINEKEN, the world's second-largest brewer, forecast that growth in operating profit will slow this year as the Dutch brewer sold less beer than expected in Africa and the Americas. Earnings growth is set to rise about 4% this year, down from a rate of 6.4% last year. Heineken's previous forecast was for a mid-single-digit increase.

Key insights

Double-digit growth in Asia, which has been dominated by Anheuser-Busch InBev, helped offset a decline in the US. Heineken is the first of the major brewers to report third-quarter results. Competitors AB InBev and Carlsberg A/S are expected to benefit from demand in Mexico and China, respectively.

The Dutch brewer's namesake brand had double-digit growth in markets such as Brazil, South Africa, the UK and Germany. The company has been depending more on Heineken's strong performance lately as consumers move from low-end beers to international premium brands in developing markets. The shares fell 1.9% early Wednesday in Amsterdam. The stock has gained about 24% this year.

# SBL sustained growth positively impacting local barley farmers

KABAISI Mayideshi considers himself one of the luckiest farmers in the country. The Manyara region based farmer is one of the beneficiaries of Serengeti Breweries Limited's Local Raw Materials Project (LRM) through which the beer brewer gives priority to sourcing raw materials within the country.

The father of four has seen his cereals farming business grow sustainably just like the brewer's annual volumes increase and dominate the domestic market. "This collaboration with Serengeti Breweries has completely changed my life and that of my entire family," he said while noting that SBL through LRM has rescued thousands of farmers in Manyara region.

"The biggest problem we had, for many years, was market for our produce. We had bumper harvests for many years but the place to sell was a problem," said Mayideshi saying SBL has not only given farmers a reliable market but also sustainably profitable.

"We are now sure of the market for our commodities and even the price we are offered is very competitive," he said. Mayideshi is one of the 400 cereal growing farmers who are enrolled under the LRM project.

Slightly over five years ago, SBL, which is the country's second largest beer-maker, introduced the LRM agribusiness programme, which now is impacting positively on the lives of many farmers across the country assuring them a reliable market for their crops.

According to SBL's Managing Director, Mark Occiti, the LRM farmers' support program entails providing farmers with free high

quality seeds, linking them to financial institutions to acquire capital needed for large scale farming as well as with suppliers of fertilizers and other farming inputs.

Occiti said in return, the brewer buys all of the farmers' commodities at market prices hence enabling them to repay loans taken from commercial banks while another profit margin helps them turn around their living standards and those of their dependents.

"SBL currently sources about 15,300

tons of locally produced grains annually from a network of 400 farmers across the country. This is equivalent to 68 percent of SBL total raw material requirement a year," Occiti noted.

He further pointed out that the Dar es Salaam based brewer plans to increase its sourcing of maize, sorghum and barley from local growers to over 17 tonnes in 2020 as part of the company's ambitious expansion in its beer production.

SBL is has already started a 10 million British pounds expansion project of its Dar es Salaam plant which will also see Moshi and Mwanza plants undergo similar expansion starting this year thanks to consumers growing demand of the brewer's beer brands.

Tanzania is among developing nations that are targeting to become semi industrialised and middle- income economy by 2025 in line with Tanzania Development Vision 2025.

As main backbone of both the domestic and the export market, the agricultural sector in the country engages 80 percent of labour force hence significantly contributing to the nation's socioeconomic growth.

Smallholder farmers dominate production in the country's agriculture sector with more than 90 percent of cultivated land. The sector accounts for about 65.5 percent of employment; provides livelihood to more than 70 percent of population, 29 percent of gross domestic product; 30 percent of export earnings and 65 percent of inputs to the industrial sector according to National Bureau of Statistics data of 2014.

About three out of four households name agriculture as their main activity and includes those based urban areas who to a certain extent, are still involved in crop production.

Indeed, agriculture is an important sector for Tanzania, contributing up to 26 percent of the country's GDP. Typically, farmers produce to feed their families but they also sell to the market to earn income for their families.

When farmers make more income from the sale of their produce, it leads to more development in the rural areas which ultimately impacts positively on the overall economy. This is what has contributed to success stories of predominantly agricultural countries dubbed Asian Tigers which include Malaysia and Vietnam.

"In Tanzania, this kind of impact has not yet been felt - at least not on a tangible scale. Agricultural commercialization remains marginal in the country as shown by recent statistics," said Minister for Agriculture, Food Security and Cooperatives, Japhet Hasunga.

Hasunga told parliament during his budget presentation mid this year that statistics show that 26 percent of all farmers did not sell any of their crops because, "They were not connected to markets and only 25 percent sold more than half of their production."

The statistic further show that more than two thirds of maize farmers did not sell any of their harvest and only 25 percent of total maize production was marketed this year. Uganda and Kenya have similar challenges. On the other hand, Vietnam moved from 48 percent of crop production being marketed in 1993 to 87 percent in 2008.

The low rate of commercialization may be explained by many factors such as remoteness, low production, low farm-gate prices, high marketing margins, lack of information and poor

# Nedbank to reskill employees as tech disrupts jobs

BIG four bank Nedbank is moving to redeploy employees impacted by digitisation, saying job losses through retrenchment will be the last resort. This as labour unions fight local banks over widespread job losses in the financial services sector mostly because of the introduction of technology.

"Nedbank's digital and innovation strategy is designed to respond to changing client behaviour and grow our business - not reduce it," Nedbank tells ITWeb in an e-mail. "What we commit to, as always, is to ensure that wherever possible, we minimise the impact of the changing nature of our business on our staff and provide training to ensure staff skills remain relevant. Unfortunately, we cannot commit to not changing the nature of our business as the world around us changes."

The bank says it is mindful of the difficulties being experienced across all

facets of the South African economy and that speculation surrounding the impact on staff numbers from any acceleration in its digital and innovation strategy causes apprehension. However, it notes, the future is very hard for anyone to predict with any degree of precision.

"In this regard, we should be reminded."

"In this regard, we should be reminded that when the ATM was introduced 40 years ago, there were fears that it would make tellers redundant. Today, we have hundreds more tellers and thousands more ATMs as well as many staff working in ancillary services around the ATM ecosystem."

Nedbank says branches are very important to the bank as they remain its most important touch points with clients. Standard Bank recently faced backlash after it closed 104 branches countrywide within a short space of time. To date, one in every five Standard Bank branches has been closed down.

In March, Absa Group announced it



was restructuring its South African retail and business banking unit within months, which would affect 870 jobs. Nedbank in August said it had been in consultations with the unions, noting fewer of its people would be affected.

Capitec last month announced it

has converted some of its branches by removing cashiers and replacing them with self-service technology. Meanwhile, First National Bank CEO Jacques Celliers recently told ITWeb there will be no branch closures at the big four bank.

# **Brexit thrown into** chaos after MPs reject PM's fast track plan

LONDON

PRIME Minister Boris Johnson's Brexit plans were thrown into chaos on Tuesday night when the House of Commons rejected his call for a fast-track debate.

Johnson won a massive boost when MPs voted by 329 to 299 to back the Withdrawal Agreement Bill he needs to bring Britain's membership of the European Union to an end.

But minutes later MPs rejected his call for the legislation to be fast tracked through the House of Commons by this Thursday.

After that vote was lost by 322 to 308, Johnson announced he was pausing the bill to enable him to consult with the European Union.

"I must express my disappointment that the House has again voted for delay rather than a timetable that would have guaranteed the UK would have been in a position to leave the EU (European

Union) on Oct 31 with a deal," the prime minister said in response to the vote re-

"We now face further uncertainty and the EU must now make up their minds over how to answer parliament's request for a delay," he said.

"The first consequence is the government must take the only responsible course and accelerate our preparations for a no-deal outcome," said Johnson.

"Our policy remains that we should not delay, that we should leave the EU on Oct 31 and that is what I will say to the EU," he added

Earlier Tuesday, the prime minister told a parliament debate that he will pull the Brexit bill and push for an election if it is voted down by lawmakers.

Johnson also told MPs he would now step up preparations for a no-deal Brex-

snap general election after telling MPs

earlier that if his plans were blocked he would seek an early vote in the country.

Jeremy Corbyn, leader of the opposition Labour Party, told MPs after the voting: "Tonight the House of Commons has refused to be bounced into debating a hugely significant piece of legislation in just two days with barely any notice and analysis of the economic impact of this bill. The prime minister is the author of his own misfortune."

The speaker of the House of Commons, John Bercow, said that the Withdrawal Agreement Bill. reached by London and Brussels last week, is now "in limbo." The Brexit deal needs to be approved by the British parliament to become legally binding before Britain leaves the European Union.

"Just in case there is any doubt, the technical term for the status of the bill at present is that the bill is in limbo," he said.

Meanwhile, Nigel Farage, leader of the Brexit He did not though mention seeking a Party, twittered in an ironic tone: "Do or die is over, we have now moved on to dying in a ditch. We will

not be leaving the EU on 31st October."

The division list for the program motion showed just five Labour MPs rebelled to support it.

If the British government can force its Brexit bill through parliament in time, the UK could in theory still leave the European Union by the Oct 31 dead-

Given the latest defeat in parliament, Johnson has little chance of getting Brexit done on Oct 31. He vowed to take his country out of the European Union on Oct 31 with or without a deal.

Former British Prime Minister Theresa May, when in office, tried three times to get her Brexit agreement through the House of Commons, but all her efforts ended in failure.

Also in the debate, the opposition Labour Party accused the government of trying to bounce members of parliament to support the bill. Many lawmakers complained that they were given not enough time to scrutinize the bill.

## Putin considers it possible to double Russia-Africa trade in 4-5 years

**SOCHI** 

RUSSIAN President Vladimir Putin sees the possibility of doubling the trade between Russia and Africa in 4-5 years, he said at a plenary meeting of the Russia-Africa economic forum yesterday.

"I believe that it is within our power to at least double the volume of trade in the next 4-5 years," Putin said.

"We are now exporting more agricultural products to the markets of third countries than weapons," Putin added. "Weapons reach \$15 bln, and agricultural products have the mark of \$25 bln.

Therefore, we have very good development potential, there are things to discuss, all this allows us to expect further growth of trade figures," the president said.

According to the Russian leader, the integration processes developing in Africa provide additional opportunities for cooperation.

"We support establishment of close working contacts between the African Union Commission and the Eurasian Economic Commission, which are signing a memorandum of understanding tomorrow," he said.

Putin (pictured) also announced Russia's intention to expand its network of sales offices in Africa, as well as establish new contacts, and support business. According to him, the work of the Coordinating already reached, in my opinion, Committee on Economic Cooperation with the African Countries, established under the auspices of the Russian Chamber of Commerce and Industry, has proven itself.

# US defense secretary in Iraq to discuss troops leaving Syria

**BAGHDAD** 

US Defense Secretary Mark Esper arrived in Baghdad yesterday as chaos swirled along the Turkey-Syria border and Iraqi leaders chafed over reports that the US may want to increase the number of troops based in Iraq, at least temporarily.

Esper's meetings yesterday at the Iraqi Defense Ministry came a day after Iraq's military said American troops leaving northeastern Syria don't have permission to stay in

The Iraqi statement appeared to contradict Esper (pictured), who has said that all US troops leaving Syria will go to western Iraq and that the military would continue

to conduct operations against the Islamic State group to prevent its resurgence in the region.

He later added that the troops would be there temporarily until they are able to go home, but no time period has been set. Esper said yesterday that the US has no plans to leave those troops in Iraq "interminably" and that he plans to talk with Iraqi leaders about the matter.

Meanwhile, Russia and Turkey reached an agreement on Tuesday that would deploy their forces along nearly the entire northeastern border to fill the void left after President Donald Trump's abrupt withdrawal of US forces from the area, a move that essentially cleared the way for the Turkish invasion



earlier this month.

It was unclear yesterday what that means for US forces.

Trump ordered the bulk of the approximately 1,000 US troops in Syria to withdraw after Turkish President Recep Tayyip Erdogan stated in a phone call that his forces were about to invade Syria to push back Syrian Kurdish fighters whom Ankara considers terrorists.

The pullout largely abandons the Kurdish allies who have fought the

Islamic State group alongside US troops for several years. Between 200 and 300 US troops will remain at the southern Syrian outpost of Al-Tanf.

Esper said the troops going into Iraq would have two missions, one to help defend Iraq against a resurgence of Islamic State militants and another to monitor and perform a counter-IS mission.

The US currently has more than 5,000 American forces in Iraq, under an agreement between the two countries. The US pulled its troops out of Iraq in 2011 when combat operations there ended, but they went back in after the Islamic State group began to take over large swaths of the country in 2014.

The number of American forces in Iraq has remained small due to political sensitivities in the country, after years of what some Iraqis consider US occupation during the war that began in 2003. Iraqi leaders may privately condone more US forces to battle IS, but worry if it's widely known that there will be backlash from the citizens.

US troops in Syria fought for five years alongside Kurdish-led forces in northeast Syria and succeeded in bringing down the rule of IS militants - at the cost of thousands of Kurdish fighters' lives. Under the new agreement, much of that territory would be handed over to US rivals.

#### Lack of funding leaves millions of children in conflict zones at risk'

**UNITED NATIONS** 

MILLIONS of children living in areas affected by conflict and disaster are at risk because of substantial shortages in funding for lifesaving humanitarian programs, the United Nations Children's Fund (UNICEF) said on Tuesday.

Stephane Dujarric, spokesman for UN Secretary-General Antonio Guterres, said that UNICEF has received only about half of 4.16 billion U.S. dollars needed to meet the basic health, education, nutrition and protection needs of 41 million children in 59 countries so far this year.

Heading into the final quarter of 2019, the funding gap stands at 46 percent, according to UNICEF.

Emergencies with the largest funding gaps include Pakistan, Cameroon, Burkina Faso and Venezuela. Large-scale emergencies in Syria, Yemen, Democratic Republic of the Congo and Bangladesh also remain significantly underfunded, said the press release.

# Israel faces uncertain future as Netanyahu fails to form unity govt

**JERUSALEM** 

A MONTH after Israel's second general election in a year, the incumbent Israeli Prime Minister Benjamin Netanyahu announced on Monday evening that he is unable to form a coali-

Consequently, President Reuven Rivlin on Tuesday tasked opposition leader Benny Gantz, Netanyahu's main rival to form a governing coalition.

The leader of the centrist Blue and White party will have 28 days to form a government, although his chances of

success are also slim. This may lead Israel into further political uncertainty, raising the probability for a third election within this

year. In a video statement released by Netanyahu (pictured), the Prime Minister said he had tried to create a unity government together with Gantz's Blue and White party.

"I made every effort to bring Gantz to the government, but he repeatedly declined," said Netanyahu.

Netanyahu's failure is the second one this year. After the first general election in April, he failed in organizing a government which led Israel to another election.

In addition to his political woe, Netanyahu is under the threat of corruption charges which will be judged in the coming weeks. Gantz's party has said it refuses to sit in a government with a party led by a politician under

such suspicions.

"There will be many attempts now to form a coalition, and many of them will be quiet and behind the scenes," said Yossi Schein, a professor of the Political Science Department at Tel Aviv University, adding "this is a time of great tension."

Netanyahu is Israel's longest-serving prime minister. His failure to form a government for the second time in a row makes Gantz the first-ever Israeli politician after Netanyahu to try to

form a government in the last decade. As a former military chief of staff, Gantz seems to be less experienced than Netanyahu with regard to poli-

tics. "It is time for action. Blue and White party is determined



to form a liberal unity government led by Benny Gantz," read a statement on the Twitter account of the party. Gantz has 28 days to form a government and the odds are stacked against him.

Gaining support of at least 61 parliament members out of the total 120 is essential to form a government. But

currently he has only 54 votes. As many parties have to align with

each other for Gantz to form a government, scenarios seem currently unlikely. But Israeli politics is unpredictable. "Chances of forming a unity government at this point look very slim," Schein said. "But it can still happen, as we have witnessed such things in the past."

So far Netanyahu is still considered to be "a political magician" rather than Gantz who has yet to rack up experience in the political field.

The sitting Israeli prime minister only gained 55 votes as he reluctantly returned the mandate to the president. The political deadlock in which Israel has been in for several months now does not appear to be ended. Netanyahu started the coalition negotiations by securing a bloc of parties led by the Likud and members of smaller right-wing religious Jewish parties.

When Gantz says he wants a secular government, it is a signal for Netanyahu to lose his partners, something the latter refuses to do so far. According to Yonatan Freeman from the Department of Political Science at the Hebrew University of Jerusalem, this might happen.

"During the Netanyahu-led negotiations, he said Gantz needs to compromise because of very pressing security matters," Freeman told Xinhua. Netanyahu might cite the same reasons in order to justify abandoning the bloc and sitting in the same government Xinhua with Gantz.

### Russia warns Syrian Kurdish YPG must pull back or face Turkish army

#### **MOSCOW**

RUSSIA warned Syrian Kurdish YPG forces yesterday they face further armed conflict with Turkey if they fail to comply with a Russian-Turkish accord calling for their withdrawal from the entire length of Syria's northeastern border with

Moscow's warning came shortly before Russian and Syrian security forces were due to start overseeing the removal of YPG fighters and weapons at least 30 km (19 miles) into Syria, under the deal struck by presidents Vladimir Putin and Tayyip Erdogan.

A complete pullout of the YPG would mark a victory for Erdogan, who launched a cross-border offensive on Oct. 9 to drive the Kurdish militia from the border and create a "safe zone" for the return of Syrian

The accord, which expands on a U.S.-brokered deal last week, also underlines Putin's dominant influence in Syria and seals the return of his ally President Bashar al-Assad's forces to northeast Syria for the first time in years, by endorsing the deployment of Syrian border guards from noon (0900 GMT)yesterday.

Six days later, Russian and Turkish forces will jointly start to patrol a 10

km strip of land in northeast Syria where U.S. troops for years were deployed along with their former Kurd-

Those changes reflect the dizzving pace of changes in Syria since President Donald Trump announced the withdrawal of U.S. forces from northern Syria earlier this month, shaking up the military balance across a quarter of the country after eight years of conflict.

Kurdish militia commanders have yet to respond to the deal reached in Russia's Black Sea resort of Sochi, and it was not immediately clear how their withdrawal could be enforced.

# Support for impeaching Trump soars among independents - poll

#### **NEW YORK**

SUPPORT for impeaching U.S. President Donald Trump surged among political independents and rose by three percentage points overall since last week, according to a Reuters/Ipsos poll released on Tuesday.

More Americans also said they disapproved of the president's handling of foreign threats.

The Oct. 18-22 poll showed public opinion continued to shift as Americans digested a flurry of news over the past several weeks stemming from the congressional impeachment inquiry and Trump's decision to pull troops from northern Syria.

Overall, 46% of Americans said they supported impeachment and 40% said they opposed it.

Support for impeachment was relatively steady among Republicans and Democrats over the past week but it surged among independents, a group that includes people who neither identify as Democrats nor Republicans and do not favor either party when they vote.

Among independents, 45% said in the latest poll they supported impeachment and 32% said they opposed it, the strongest level of support recorded in more than a

A little more than 1 in 3 independents had said they were in favor of impeachment in more than a dozen previous Reuters/Ipsos polls since June 2018.

Trump leveraged his advantage



in support among independents to narrowly win the White House in 2016 and it is expected that he will need them again to be reelected.

The Reuters/Ipsos poll was conducted after several administration officials backed up portions

of a government whistleblower's report that alleged Trump pressured Ukraine President Volodymyr Zelenskiy to investigate one of his main political rivals, former Vice President Joe Biden. The report said Trump linked the probe to the release of foreign aid.

Trump has denied any wrongdoing. He has tried to block administration officials from cooperating with the investigation and this week said he was the victim of a "lynching," a racially charged description that was quickly condemned by many lawmakers.

The president also ordered U.S. troops to withdraw from northern Syria two weeks ago ahead of Turkey's cross-border offensive against the Kurds. The Turkish offensive displaced hundreds of thousands of people and raised concerns that it would allow prisoners from the Islamic State group to escape.

Trump's decision drew a sharp bipartisan rebuke in Congress and the poll shows it may have hurt his standing among rankand-file Republicans.

Overall, the poll found that Americans were more critical of Trump's handling of U.S. foreign policy and Islamic State than they were in a similar poll in April.

Among Republicans, 73% said they approved of the president's handling of U.S. foreign policy and 75% said they approved of his handling of IS, down 6 points and 8 points respectively from April.

The Reuters/Ipsos poll was conducted online, in English, throughout the United States. It gathered responses from 4,083 adults, including 1,773 Democrats, 1,542 Republicans and 447 independents. It has a credibility interval, a measure of precision, of 5 percentage points.

#### Slower growth in China will not affect living standards

#### By Xie Jun

CHINA'S economy slowed but not so dramatically as to affect people's living standards, experts said, predicting that the domestic economy would further stabilize next year as the impact from the trade war is likely to dwindle.

China's GDP growth slowed to 6.0 percent in the third quarter, hitting a 27-year low, data from the National Bureau of Statistics (NBS) showed on Friday. In the first three quarters, China's GDP growth averaged at 6.2 percent.

Liu Xuezhi, a senior economist at the Bank of Communications, said that 6.2 percent growth means that China's economy is still expanding, and although a slowdown is taking place, it is not a "hard landing".

"People will hardly feel their ordinary lives being affected during such moderate slowdown," Liu told the Global Times on Sunday.

Statistics that are closely linked to people's living standards also showed no signs of strong fluctuations recently. Chinese residents' per-capita disposable income rose by 6.1 percent year-on-year in the first three quarters in 2019, compared with 6.6 percent one year earlier, NBS data showed.

Meanwhile, China's consumer price index (CPI) increased 3 percent year-on-year in September.

Several white-collar work-

ers interviewed by the Global Times on Sunday also said that they hardly felt their living standards had been negatively influenced by the slowing GDP growth. One said that she felt commodity price has risen faster this year but still in a tol-

erable range. "Mainly impacted is the manufacturing sector," Liu said. The slowing domestic GDP growth is triggering pessimistic comments among overseas media.

A Reuters report, for example, said that the downbeat data is fanning expectations that Beijing will need new measures to ward off a sharper slowdown that could drive job losses. A CNN report also stressed that the economic figures are "worse than expected."

Li Chunding, a professor at the College of Economics and Agricultural University, told the Global Times that other

countries should realize the double-digit growth era has already passed for China.

"It should be recognized that 6.2 percent is still high growth,"

Data released during the 40th International Monetary and Financial Committee (IMFC) Meeting showed that global economic growth continued to slow down since April and the global economy is expected to grow only 3 percent this year, according to media reports.

Liu predicted that China's economy will stabilize next year with growth possibly slow down further, as the government's proactive policies become more effective.

He also noted that the negative impact of the trade war will also diminish next year. "The US has shown a clear attitude to end the trade war, and the Management under the China room for further tariff punishment is also limited," he said.

# Chinese FM denounces violence, foreign interference in Hong Kong

#### **PARIS**

CHINESE State Councilor and Foreign Minister Wang Yi here on Monday slammed the violence and foreign interference in Hong Kong.

In an interview with AFP during his visit to France, Wang reiterated that issues related to Hong Kong are China's internal affairs, and that according to the Charter of the United Nations, no country has the right to determine the internal affairs of any other nation.

Wang (pictured) said one basic fact about Hong Kong is that what is going on in the Chi-

nese city nowadays is in no way peaceful protests, but pure and simple street violence. Some rioters, wearing similar clothes and face masks and holding iron rods and Molotov cocktails, have unscrupulously committed crimes, he added.

Wang accused the mobs of smashing shops, damaging public facilities, beating up innocent citizens, paralyzing airports and even openly attacking police, threatening their lives. These are crimes and cannot be tolerated in any country or any society, Wang said.

Hong Kong has always been advocating the rule of law, any action should be conducted within the framework of the law, and any discontent should not be an excuse for violence, Wang said.

He noted that the most significant thing for Hong Kong now is to stop violence, curb disorder, restore order and administer the city by law.

Wang said another basic fact about Hong Kong is that some foreign forces, including some media outlets, turning a blind eye to what is really happening and even calling white black, have called the street violence a pro-democracy move and branded the police deploy-



ment in accordance with law as violence.

Wang said some foreign forces have encouraged and indulged the street crimes so as

to upset Hong Kong, and ruin its prosperity built by generations of hard work and its great historic progress achieved since the implementation of the "one

country, two systems" policy. These attempts will never and can never succeed, Wang

People in Hong Kong will certainly recognize these agendas of the foreign forces, the Hong Kong Special Administrative Region government will certainly restore the rule of law, and China's central government will certainly stick to the "one country, two systems" principle according to the constitution and the Basic Law, Wang said.

Wang expressed the hope that people with conscience around the globe will view the situation in Hong Kong objectively and impartially. The violence in Hong Kong

is being imitated elsewhere, for example in Spain's Catalonia, Britain's London, and the streets of Chile, he noted, saying some demonstrators have announced that they would turn their cities into another Hong Kong and imitate the street violence there.

Some even called the violence in Hong Kong "a beautiful landscape," and such remarks made by those people have lost the minimum conscience, Wang said.

# Leonard leads Clippers over LeBron and Lakers 112-102

**LOS ANGELES** 

KAWHI Leonard hit seven straight shots in one stretch, creating a run for the Clippers that his new teammates quickly joined. "It's a great sign of leadership," coach Doc Rivers said. "He talks with his game."

Leonard began a new career chapter Tuesday night, scoring 30 points to go with a strong bench effort in a 112-102 victory over LeBron James and the Lakers in the teams' season opener.

Leonard chose the Clippers because he wanted to come home and his family was on hand. "All those emotions went through me again," he said.

Lou Williams added 21 points and Montrezl Harrell had 17 off the bench when the Clippers began their 50th season overall and 36th in Los Angeles as the once unlikely but now favorites to win the franchise's first NBA championship.

"It's one of 82 (games)," Rivers said. "Next question." Leonard won his second NBA title last season in Toronto.

The Lakers showed off their new 1-2 punch of James and Anthony Davis. Davis scored 25 points, making 9 of 14 free throws, and James had 18.

"For us, we're both aggressive," Davis said. "Sometimes we kind of miss each other. I missed him a couple times and he missed me, so just trying to figure it out."

Danny Green outscored them both with 28 points, including seven 3-pointers, in the highest-scoring debut by a Laker in franchise history. Leonard got it done without his personal recruit Paul George, sidelined indefinitely while rehabbing from a pair of offseason shoulder surgeries.

"It's just the first game of the season, so it's going to take the season and mistakes and success to get us on the same page," Leonard said.

Wearing a black tuxedo jacket and bow tie, George received a mixed reaction when introduced in the playoff-like atmosphere at Staples Center, where the Clippers were the home team for the first of four meetings in the arena the teams share.

"Their fans were very loud early and I thought our fans took over from that point on," Rivers said. "It's great for the city."

The Clippers' reserves outscored the Lakers' bench, 60-19. Last season, Williams and Harrell were the NBA's highest-scoring reserve duo, and they picked up where they left off. "This bench is going to be better this year than even last year," Rivers said. It came down to the fourth quarter, and the Clippers dominated.

Tied 85-all, they opened with a 19-7 run to go up 104-92. Five different players scored and Leonard assisted on Maurice Harkless' 3-pointer.

James had three of the Lakers' six turnovers in the fourth, when Harkless and Leonard each blocked shots by Dwight Howard.

"That was just very careless and they capitalized off of it," James said.

With 4 ½ minutes left, Lakers fans chanted "Let's go, Lakers! Let's go, Lakers!" while others hit the exits.

"The NBA's back and everyone's trying to have the narrative of it's a rivalry game and it's a huge test," James said, "but I think both teams are not where they want to be. We have a lot of room to improve."

The Lakers erased a 14-point deficit in the third, led by Danny Green's 18 points. He capped a 15-O run with his fifth 3-pointer before JaMychal Green's 3-pointer pulled the Clippers into an 85-all tie heading into the fourth.

The Clippers outscored the Lakers 40-29 in the second quarter, buoyed by 16 points from Leonard. He made seven straight shots on a variety of moves - pullups, fadeaways, a cutting dunk.

The Lakers raced to a 13-2 lead, their largest of the game. James scored over Leonard and he later heard "MVP! MVP!" chants while sinking his first free throws of the season.

The Lakers shot 53% from the floor in the first quarter, while the Clippers missed shots and had a basket by Williams taken away when the Lakers challenged a foul call on Howard.

### Ronaldo asks US court to dismiss rape case or OK mediation

CRISTIANO Ronaldo's lawyers have filed court documents asking a U.S. judge in Las Vegas to either dismiss a Nevada woman's lawsuit alleging the soccer star raped her in 2009, or to order closed-door settlement

Attorneys representing Ronaldo's accuser, Kathryn Mayorga, did not immediately respond Tuesday to telephone, email and text messages seeking comment about the two recent court filings about her lawsuit stemming from a 2010 confidentiality agreement and \$375,000 hushmoney payment.

The Associated Press generally does not name people who say they have been victims of sexual assault, but Mayorga gave consent to be named through her lawyers, Leslie Mark Stovall and Larissa Drohobyczer. Ronaldo's lawyer in Las Vegas, Peter Christiansen, declined to comment about the documents he filed

"Mr. Ronaldo has always maintained that this was a consensual encounter," said the filing seeking dismissal of the case.

A companion document also filed Oct.14 in U.S. District court asks the judge to order out-of-court talks to settle the lawsuit.

Mayorga alleges conspiracy, defamation, breach of contract, coercion and fraud. Her lawyers want to void the 2010 deal and collect at least \$200,000 more from Ronaldo. They acknowledge Mayorga received \$375,000 in 2010. The court has kept the original agreement sealed.

Mayorga's lawyers maintain she didn't break the confidentiality pledge. They accuse Ronaldo or his associates of allowing reports of it to appear in European publications in 2017. The soccer star's lawyers have said the information was among electronic data hacked, stolen and sold by cybercriminals, and that Mayorga's lawsuit is being used to damage Ronaldo's reputation.

Mayorga's lawsuit said she met Ronaldo at a nightclub and went with him and other people to his suite at the Palms Hotel and Casino, where he assaulted her in a bedroom.

Las Vegas police last year reinvestigated the rape allegation, but no criminal charge was filed. The local elected prosecutor said there was not enough evidence to take the 10-year-old case to trial.

#### Sterling one of the top five players in the world - Ferdinand

LONDON

FORMER Manchester United defender Rio Ferdinand believes Raheem Sterling is among the five best players in the world right now.

The 24-year-old scored his first Champions League hat-trick on Tuesday in Manchester City's 5-1 win over Atalanta, which continued their perfect start to their European

Sterling has also already netted six goals in the Premier League this season with Ferdinand under no doubt that he belongs among the best based on current form.

"We are running out of great words to say about him," Ferdinand He is an extraordinary player. said on BT Sport.

"He is a young English player who has played a lot of games. He is still improving and adding more to his game. He has a striker's nose to get into certain areas.

"He is in the top five players in the world now. Definitely! I don't care who you mention. The effect he is having, the goals he is scoring, it is impossible to keep him out."

The English attacker has become the domestic front. a reliable outlet under the guidance

of City manager Pep Guardiola and Ferninand believes the Spaniard has been key to Sterling's development.

"Sometimes you are blessed to get a manager to learn from," he said. "Pep Guardiola coming at the time he did, to coach this young player with immense potential."

Guardiola however was quick to deflect any role he's played in Sterling's rise and stressed he has the potential to become even better.

"The credit is just for him. All of the credit. He can be better but he is perfect," Guardiola said post-match.

"His physicality, he is strong, he could play a game the day after a game, his regeneration is so strong.

"He can play both sides, defensively he helps us a lot. He is an incredible player. It depends on him but he has the desire to do better."

### 'Pogba isn't Messi but Man Utd must keep him' - Moyes

PAUL Pogba may not be a match winner in the Lionel Messi mould, admits David Moyes, but the Frenchman is considered to be the Red Devils' "best midfield player" and one they need to keep.

Transfer speculation has raged around the World Cup winner for some time now.

A summer of rumours saw him linked with a big-money switch away from Old Trafford, with the likes of Real Madrid and former employers Juventus said to be keen. No deal was done, but exit talk is never far away when it comes to a figure who has polarised opinion since returning to English football

Consistency is considered to have been an issue for the 26-yearold, but former United manager Moyes believes such talent should not be allowed the slip net by the Red Devils.

He told talkSPORT: "Pogba is still Manchester United's best midfield player. "He could probably play for any team in the world, certainly in Europe. He'd get a game for any team. "I'm not always sure he's a player who's consistent and makes the difference all the time.

"For the profile he's got, you're hoping he makes the difference. He doesn't always make the difference, but do I think he should stay at Manchester United? Yes, I do."

Pogba has sat out United's last eight games with a niggling ankle problem, with that injury also preventing him from figuring for his country in the most recent rounds of Euro 2020 qualifiers.

Ole Gunnar Solskjaer is hoping to have an all-action performer back at his disposal in the near future, but it remains to be seen how much longer he will be sidelined for after being spotted using a walking stick during the Red Devils' Premier League clash with Liverpool. Whenever the time comes for him to return to the fold, Moyes believes Pogba should be one of the first names on the teamsheet, even if he is not quite at the level of other talismanic figures in the global game.

The Scot added: "I don't think he wins games like Messi does for Barcelona or [Cristiano] Ronaldo does for Juventus, but I still think he's a really talented player. He's got a lot to give.

"Watching him at his best was when he was at Juventus, he played a little bit further forward, he got

nearer the box more often. "If you were picking the Manchester United team, Pogba would be in their midfield at the moment, that's for sure.

# Wenger at 70: Arsenal icon is ready to get back into soccer

ARSENE Wenger has never been big on milestones and birthdays. For more than half of his life, his "big day" has been every single day -- preparing his team on the training pitch for a match.

On Tuesday, he turns 70, and for the second year in a row, he will have no training session to set up, no team talk to prepare and no interviews or news conferences to deliver. He will wake up with the whole day ahead of him, perhaps spending time with his ex-wife and companion, Annie, and their daughter, Lea, or close friends like David Dein. But he'll be comforted by the fact that there is indeed football on television that evening.

Wenger recently gave people insight regarding his "new" life, the one far removed from the daily grind of life in charge at Arsenal. "When I wake up, the first thing that comes to my head is, 'Is there an interesting game tonight on TV?' If that's the case, my day is OK," he told the 1,000 guests gathered at the Grosvenor House Hotel in London two weeks ago to see him receive the Legend of Football award, given by the Nordoff Robbins music therapy charity.

Tuesday is a Champions League matchday, so he will be happy. He hasn't missed many football games since leaving Arsenal in May 2018 after over 22 years in charge. Four weeks ago, as he prepared to board a Eurostar from London to Paris, he was eager to discuss Paris Saint-Germain's 3-0 win over Real Madrid the night before and highlight how impressed he had been by the PSG midfielders, Marco Verratti, Marquinhos and Idrissa Gueye.

In the same conversation, he wondered what kind of team Unai Emery would field in Arsenal's upcoming Europa League fixture against Eintracht Frankfurt. Will he rotate? Will he play the kids? When you speak to him, Arsenal is never far from his thoughts. He still affectionately refers to the Gunners as "we" when talking about his former club.

Despite offers from Premier League clubs and interest from Lyon and some national federations, Wenger has yet to return to the Emirates as either a guest or the opposition. He still follows Arsenal games, catches them on television as much as possible -- including Monday night's 1-0 defeat at Shef-

field United -- but his return has not yet happened. It's not that the club doesn't want him there or that he doesn't want to go. It's just too early, perhaps, even though there are no hard feelings toward the club that has defined his career in foot-

"I will always love Arsenal," he said at the awards dinner in his honour. Seemingly happy to be in the company of many of his former players and colleagues, he had nice words for many of them. Even though most of his trusted staff left when he did, Wenger is still in touch with current club employ-

thought he would be back on a bench on aligns to the values he holds so dear. In his Jan. 1, 2019. But as much as he misses the relationship with the players, the tactical aspects of the game and the thrill of being on the training pitch every day, he also doesn't want to rush anything.

Perhaps the birthday present he's looking for is something more challenging that closing remarks when he accepted his award, in his inimitable way he remarked: "You cannot always come first and you cannot always win, but you can never come second to your values."

While Wenger awaits a new bench and a revised daily routine, he will shortly be an-

In the meantime, he'll continue to travel to Qatar, where he is a pundit for beIN Sport, and to France for consulting opportunities where he can put his knowledge and experience to great use. Earlier this year, he even dribbled past Zinedine Zidane, 24 years his junior, in a charity

As he turns 70, Wenger's contribution to the game shows no signs of slowing down. It's just taking different forms, like advising and mentoring. Most recently, he went to Istanbul and enjoyed dinner with Damien Comolli, his former collaborator and protege turned Fenerbahce sporting

There are plenty of people who are enjoying his counsel and company now he is no longer tied to a fixture list and rigorous training schedules.

He also has a chance to stop and reflect and is already working on his first official autobiography, "My Life in Red and White," which will be published next year in France and in the UK.

Since leaving Arsenal, Wenger looks refreshed. He's younger and fitter than ever -- nothing like a 70-year-old man who has weathered the storm of being a Premier League manager over two decades in which the game experienced profound, transformative change. He has plenty of energy and vigour, more ideas and ambition than ever. He is eager to come back to management.

Perhaps the birthday present he's been waiting for will come this year.

#### No quick fix for struggling South Africa Test team - Du Plessis

#### CAPE TOWN

THERE is no quick fix for South Africa's ailing Test team in the wake of their demoralizing series whitewash in India, captain Faf du Plessis said, as retirements, defections abroad and an under-performing domestic scene drag them into mediocrity.

South Africa were thrashed in all three matches and look a shadow of the side that beat Australia in a contentious home Test series just 18 months ago, where their ability to dig in and compete with bat and ball was a big factor.

South Africa have now lost five Tests in a row, including two shock home losses to Sri Lanka, and are struggling with on-field know-how to dig themselves out of tough situations.

Du Plessis is one of the last remaining players from the side that was ranked number one in Tests as recently as 2015.

He admits their lack of succession planning to replace the likes retired batsmen Graeme Smith, AB de Villiers and Hashim Amla, and fast bowlers Morne Morkel and Dale Steyn, is now biting hard.

"If you look back three or four years and someone had the vision of saying that in three or four years' time there will be a lot of experienced guys who could retire, what do you do to make sure you get yourself ready for when that time comes?" Du Plessis said to report one.

"Possibly we are guilty for not planning for all of these guys going at the same time," he said.

"We could have been a little bit smarter in the planning phase and the phasing out of the great players." KOLPAK CALAMITY

It is not only retirements that have stung. The loss of fast bowlers Duane Olivier and Kyle Abbott, batsman Rilee Rossouw and spinner Simon Harmer, among others, to so-called Kolpak contracts to play in England that prevent them playing for the national team has also been a blow.

"We are losing our experience in international cricket, but we are also losing our experience in domestic cricket," Du Plessis said.

"Your top players domestically are going overseas, so you are missing out on a lot of your best players, a talent pool that is all of a sudden a lot smaller.

"And the gap between domestic cricket and intentional cricket - there needs to be things put in place to make sure you can address that a little bit better."

Du Plessis admits South Africa have had to rebuild from scratch, and with a four-test home series against England looming in December and January, they are in a vulnerable place.

"It's a tough place to start, right at the beginning.
Obviously, in a perfect world, you will start some-

Ummy was the guest of honour at the launch of a five-day campaign, which targets to sensitize people on measles vaccination, at Jamhuri Stadium in the region last weekend.

The campaign commenced on October 17 and came to an end on October 21. The vaccination is worth over 10bn/-.

She said the song is an effective means for sending message to remote communities and other people with negative perception on the campaign.

Ummy noted she was impressed with the song's verses which identify the disease's symptoms, running nose, red eyes, sore throat, tiny white bumps on a person's mouth and rashes, which usually start at the hairline and spread to the neck.

"With such culture groups like Waluguru playing part in the campaign, it is hoped the community will look for vaccination," she disclosed.
