

# **Bus owners** want more dialogue on e-ticketing

#### **By Guardian Reporter**

AS the government readies to end the use of paper tickets for most upcountry routes today, bus owners want more sensitization and dialogue on how to operate an electronic ticketing system.

Speaking to this paper in an interview yesterday, the secretary general of the Tanzania Bus Owners' Association (TABOA), Joseph Priskus said that the land transport regulator has not provided enough education on the new system to

the general public and ticketing agents.

Furthermore, there are other issues that still need to be ironed out, such as receipting and amount in taxes remitted to TRA through the system, he stated.

The association has engaged the Tanzania Revenue Authority (TRA) on the matter but no agreement has been reached by the time of the proclamation to start enforcing e-ticketing regulations, he elaborated.

# Verifying northern zone CBOs set for Feb 15 to 23

THE government shall mid next month start verifying community-based and religious organizations in the Northern Zone.

Emmanuel Kihampa, the registrar of organizations in the Ministry of Home Affairs, said in a statement here yesterday that the verification of organizations will be conducted on February 15th to 23rd, in which the various organizations will be asked to pay their annual fees for 2021.

The ministry was continuing to verify religious and community-based organizations throughout the country, the statement indicated, noting that the fifth phase of the verification exercise will take place in the Northern Zone regions

of Arusha, Kilimanjaro and Tanga.

"The verification centre is set for the Immigration College near KNCU offices in Moshi, Kilimanjaro region," it said, elaborating that payment of annual fees will be channeled through the Government Electronic Payment Gateway System.

During the verification process, the organizations are required to submit original and photocopies of their registration certificates, annual fees payment receipts for previous years, plus originals and copies of constitutions of those organisations approved by the registrar.

Other documents include a letter from the local government authority that attest to the existence of the organization in a particular areas, along

# PM: Draw up technicians' databases in key projects

PRIME Minister Kassim Majaliwa has directed that a special database be established with details of Tanzanian technicians participating in implementing major development projects such as ships and bridges for continuous reference.

He issued this instruction when launching MV Mbeya, a newly built vessel which will be making trips to ports in Malawi and Mozambique.

The database will help the concerned technicians to be recognized in various areas of development undertakings and thus be trusted to handle large projects



when they come up, the premier noted.

The new vessel costing 9.1bn/was being built as part of efforts by the fifth phased government improve the transport to

infrastructure for rapid growth, he said, noting that the 200-passenger vessel is expected to vastly alleviate transport woes for residents along the lake's shoreline.

Regions bordering Lake Nyasa are Mbeya, Njombe and Ruvuma, which have numerous commercial links with the other side of the lakeshore, in Malawi and Mozambique.

The ship, with the capacity to carry 200 tonnes of cargo at once, has been certified by the Tanzania Shipping Agencies Corporation (TASAC).

### **NSSF: Employers** must desist from corrupt practices **By Guardian Correspondent**

EMPLOYERS colluding with dishonest employees of the National Social Security Fund (NSSF) to sabotage the fund by facilitating the non-remittance of members' contributions should know that their days are numbered, a senior NSSF official declared vesterday.

Lulu Mengele (pictured), the NSSF public relations manager, also tasked with education to members, issued this caution yesterday in a press conference, saying that the fund was working to stamp out tendencies of corruption.

"NSSF will not tolerate corrupt practices," she said, insisting that members and stakeholders noticing signs of corruption when accessing NSSF services should not hesitate to communicate with the management.

Direct communication with the public relations office, the Director of Operations or the Director General will be appreciated, as well as reporting such instance to law enforcement authorities, she stated.

There are employers colluding with unfaithful employees to engage in corruption, "something that cannot be tolerated, and NSSF will ensure that this is brought to an end," she further noted.

NSSF continues to address loopholes for corruption, she said, pointing out that recently at the NSSF Mwanza regional office the management received information from reliable sources that there is an employee soliciting bribes from an employer.

"After receiving that information we submitted the matter to appropriate

## **'Control influx** of substandard food products into Zanzibar'

THE Speaker of the Zanzibar House of Representatives, Zubeir Ali Maulid, has called on the executives of the Zanzibar Food and Drug Agency (ZFDA) to control the influx of substandard products into the Isles' market outlets to protect human health.

Maulid made the call here vesterday when speaking at the function to lav a foundation stone for the laboratory building of ZFDA in Mombasa area as part of marking the 57th anniversary of the Zanzibar Revolution.

He said the government is committed to strengthening the health sector in the national interest, urging ZFDA to protect the health of the people by preventing the entry of products that are unfit for human consumption.

He said it was important for them to be careful in controlling the importation and sale of expired products in various stores, especially food products such as rice, wheat, and other food products.

The Speaker said: "It's important for you (ZFDA staff) to focus on service delivery to citizens as well as provide quality services and contribute to the development of the country as well as strengthen the growth of entrepreneurs."

However, he thanked the partners for agreeing to support

the revolutionary government of Zanzibar in implementing the project which is essential for the development of the country.

Commenting on the implementation of the ZFDA laboratory project, Acting Permanent Secretary in the Ministry of Health, Social Welfare, Elderly, Gender and Children, Halima Maulid Salum, said the building is being implemented in two phases where it will be a three-story building in line with the installation of laboratory infrastructure where it is expected to be completed in March this year.

She further said the cost of the construction is expected to be 4.8bn/-, which has been provided by the Zanzibar government and development partners from the East African Community and the funds were provided in installments. The PS said that in the first phase, the government pumped in 3.3bn/- and the second phase partners from EAC pumped 1.5bn/-

The project is being executed by the Quality Building Contractor (QBC), under Zanzibar Building Agency as a consultant. The 18-month project was to be completed in September last year, but delayed and is to be accomplished in March this year. It has completed by 80 percent and now the contractor is working on the final touches.

A DRIVE to promote milk consumption in the country is set to kick off early next month with selected public offices fitted with special coolers for refilling.

Coordinated by the Tanzania Board (TDB), the Dairv programme will start with all ministries located at government city in Dodoma where milk will be sold at half street retail price per litre.

Speaking in an exclusive interview with The Guardian yesterday, TDB Assistant Registrar Noel Byamungu said the board has already imported special refrigerators for safe storage of the milk, to be placed at all ministries and later other public offices.

Byamungu said TDB is implementing the drive in three collaboration with Tanzanian milk processors

namely Dar Fresh, Tanga Fresh with the 100 schools to be and Asas Dairies. "The special refrigerators will facilitate continued supply of fresh and safe milk to civil servants at the comfort of their offices," he said.

He added that the storage facilities will continuously be checked and refilled with milk whenever the supplies run out.

The programme is part of series of efforts by the government to promote milk consumption in the country alongside expanding performance of local milk market.

## **TMDA vows crackdown on** smuggling of banned drugs

TANZANIA Medicines and Medical Devices Authority (TMDA) has vowed to conduct a crackdown in all border areas aimed at controlling the importation of banned drugs, medical devices, reagents as well erectile dysfunction medication.

Mitango Fimbo, TMDA Director gave the notice here yesterday during his visit that aimed to inspect medicines seized by the authority in collaboration with the police.

He said there was rampant trade by unfaithful dealers who sell banned medicines that were being smuggled into the country, adding that the network was huge in many areas and which the authority was already mobilised to control.

"TMDA, working together with the police have arrested a dealer selling banned drugs that are harmful to human beings, the vehicle used to transport the drugs has also been seized by the police," Fimbo said, adding that all those who will be found engaging themselves in the racket will face legal action including prosecution on economic sabotage charges whose penalty is five years in jail.

He said TMDA also continues with its investigations to identify the criminal network engaged in distribution and selling of expired drugs but which the expired dates are extended thereby endangering the lives of the people.

He added that they have various means to change the appearance of the medicines which they later distribute to trade that threatens people's lives.

He warned the practice by some traders who deal in drugs that are normally dispensed by the government and which are not supposed to be sold in private pharmacies.

Mbeya Regional Commissioner Albert Chalamila said there was a big network of big businessmen who smuggle in, distribute and sell banned drugs in the country.

He said he was preparing a list, which he will publicly disclose, of businessmen who engage themselves in these drugs, including those for allegedly treating erectile dysfunction.

CONSTRUCTION of Mv Chato II ferry has been completed and it is now providing relief to residents living in Chato Muharamba and Nkome in Geita Region.

Worth 3.1bn / -, the ferry has been built by the Mwanza-based Songoro Marine Transport Boatyard and will be providing services between the two areas–Chato Muharamba and Nkome.

Speaking at the function to hand over the ferry, the Minister for Works and Transport, Dr Leonard Chamuriho commended Electrical, Tanzania Mechanical and Electronics Services Agency (TEMESA) for being able to effectively manage the construction of the ferry until its completion.

# 10billion/- spent to improve quality of Mufindi tea factory

AS Tanzania battles to increase tea exports in and outside Africa, Mufindi Tea & Coffee Limited has installed at Itona factory machines valued at 10 billion/- to ensure plant produces world class tea for local and external markets.

Factory Assistant Manager, Engineer Basil Mhongole, told reporters on a field tour of southern highlands regions that, with installed machines that are straightening the tea leaves, the factory now preserves in good condition 50 tonnes or 50,000 kilogrammes at a goal.

The factory is owned by GL Groups. Other factories under the same group include Luponde, Kibena and Ikanga.

These are costly ultra-modern machines that are straightening tea leaves in the production process thereby improving the quality of Tanzanian tea on the market. The factory now has a big preserving capacity to accommodate tea from outgrowers' farms and from our own estates. We get 25 percent of the tea from villagers and 75 percent is harvested from our farms," he explained adding that the income of smallholders will simultaneously increase because of the modernization in the production process.

The Farm Manager of Itone and Stone Valley Estate, Hekima Sanga, explained that the estate has 490 productive hectares that are currently being harvested. "The amount of tea we are harvesting because of irrigation, justifies and necessitates this costly investment," he said

explaining that the estate has to be irrigated during the August-September spell.

Because of irrigation and fertiliser application, he said, last year the company harvested 18,000 kgs of tea daily, up from 500 kgs the company used to harvest. He said Itona factory alone has 13 machines, all of them are lined up for modernization as part of the national industrialization strategy.

Sanga also said starting last year the company has introduced a pruning system and that a total of 101 ha have been pruned in the two parts of the estate.

Itona smallholder farmer, Evelina Mligo, said the company gives villagers extension officers so that smallholders can produce quality tea and it has also created a reliable market for their tea. "We have learnt proper tea husbandry because extension officers are keen and very cooperative. Otherwise we would not be producing the kind of good tea we are producing," she said.

Tea is one of Tanzania's seven strategic cash crops. Others are cotton, pyrethrum, cashew nuts, sisal, sugar, coffee and tobacco. In 2018/2019 fiscal year, Tanzania produced 35,000 tonnes of tea, up from 31,814 tonnes produce the previous year.

# Kagera Region man in police hands over assault leading to the death of his own son

#### By Guardian Correspondent, Bukoba

POLICE in Kagera Region have detained Amos Rudovick (39), an Ibale village resident in Kyerwa District for causing death of his child, Dastan Amos (13), after beating him with a stick on various parts of his body.

Kagera Regional Police Commander Revocatus Malimi said the incident happened January 2 this year after the deceased, a Standard IV student at Ibale Primary School left home for a walk without permission, and returned home at 3.00 pm.

"When the child was questioned by his father, he failed to provide acceptable answers, hence started beating him with a stick without mercy after which he went to bed to sleep. At around 9.00 pm they saw the child had not woken up and when they went to the room they found him dead," said the RPC.

He said an autopsy conducted showed that the child had his neck broken as well as the spine that caused his death.

The RPC further said the police were still investigating another incident in which Jesca Samson (37), a resident of Ruzinga village in Karagwe District died after she allegedly consumed rat's poison which she also gave to her son, Jordan Samson (3) to drink, but survived after he was rushed to the Designated District Nyakahanga Hospital.

"The deceased was in a family quarrel with her husband following his selling of their land without involving her, the issue of which reached the courts after

which the husband was arrested," he added.

He said after the quarrel the woman moved from the house to stay with her relatives, named Dotto Clemence and Evodia Mussa, and on December 31 last year they all moved to Kayanga town to celebrate New Year.

"New Year found them there but thereafter they returned home, and on the way she escaped and returned home quickly. After she arrived she and her son drank the poison," RPC Malimi added.

She said after her relatives arrived they found her still alive, hence they took the two to Nyakahanga Hospital where she died while receiving treatment.

The RPC said the decision of the woman to take her own life was made one day after her husband was released from prison where he was held for over three months.

an event to receive a report on the importance of education on retirement, planning and quality elder life, the PS applauded work done by researchers in the country.

The report titled, "The Importance of Education on Retirement Planning and Quality Elderly Life for Employees, Primary and Secondary Students in Tanzania" authored by a consultant Dr Mkumbo Mitula indicates that 98.3 percent of both primary and secondary school students interviewed are of the view that they need the education. Some 88 percent of the students admitted that the education on retirement and planning for quality elderly life as taught to in Dodoma, Dr Mkumbo said the study was conducted for 21 months since April 2019 involving 120 interviewees, 60 being lecturers and other public servants and 60, being students.

He said the aim of the study was to identify education gap on retirement planning among public servants and students in the country.

He also observed that 95 percent of employees in the public sector feel that education on retirement to public servants is highly needed, a new study has shown.

It also states that 77 percent of those interviewed admitted not having got it, thus retirement education and planning for quality elderly life should be provided to public servants.

"The government always provides education on retirement to public servants who are about to retire but this study has shown that public servants need more than this, they want this education at the start of their employment, during the employment period and when they about to retire," he said.

He noted what the government is doing at the last minute public servants to help psychologically face and accept the new environment outside employment.

However, he noted that they need to do more than that, like planning for retirement life through different deeper approachs like psychological, health, education economic and social, which they cannot get in two days training or last just before retirement.

On the other hand, most students in the country who are future employees and retirees are not prepared to face life after school, having financial discipline on income and expenditure.

### What of the conmen selling muddy water as edible oil?

TRANGE reports are being heard from Arusha as to what happens when there is a shortage of a key commodity.

This time it is a case of racketeers selling muddy water in containers as edible oils ran scarce in the city. The victims bought containers with the edible oil colour and image while inside lay murky water.

As happened, until the public came to learn about it, quite a number of people had lost cash and otherwise suffered.

Obviously, the racket is unlikely to continue after shockwaves spread relating to how a number were conned at several retail shops. Still, it remains true that a crime has been committed and peace has been disturbed.

Many people are still seething with anger at this show of contempt and arrogance for the trust shown by buyers on persons vending edible oil, paying at face value while wrongly believing that it is oil - as only later did they discover that it has a worthless, even hazardous, waste liquid.

There were no immediate estimates of how many people would have fallen for this trick but given the number of retail shops and reports that containers looked somewhat scarce, it may have taken place at numerous points for a day or two.

At some point the matter went viral after initial hesitation as to reporting such incident for the shame attached to being conned as easily as that. Only when it is noticed for a number of people does it seem plausible to come out and tell it all.

It appears that what the conmen were doing was too fill the 10-litre containers with muddy water and then add an amount of some oil on top so that if one opens the containers one may think if it oil, until one starts to use the stuff, as it quickly emerges that there is something disturbingly wrong with the contents.

Reports said the tricksters used to come to retail shops with the containers and pretend that they were employees who had stolen the oil from some genuine factory within the city, and were selling the liquid at a much lower price so as to dispose of it quickly.

Those who bought the stuff obviously had no idea that 'there

For one thing, the sellers of the foul liquid must have left a significant trail on their path as to who came to what shop with the containers, the sort of clothes they wore, their voices and at times even their phone numbers.

It is definitely likely that police public into idiots.

#### A new era starts with Continental African Free Trade Area take-off

HIS New Year's Day was a moment for a landmark entry into force of the Continental African Free Trade Area, with all but one independent African state, Eritrea, signing the pact, while 33 have ratified it.

Tanzania has signed the pact while not rushing into the ratification of its tenets as they stand. As this is a trade pact between African countries rather than between Africa and the rest of the world, a more liberal environment has no acute overreach.

It is something like a snowball effect, of one thing pushing another, rather than something big pushing everyone at the same time, where easier entrance of goods into a major trading partner affects its trade relationship with nearby countries, on the basis of pre-existing trade arrangements.

For instance, it is well known that bitter trade disputes existed at a bilateral level between Kenya and South Africa but, depending on the state of ratification of CAFTA, trade will be somewhat eased.

Kenya will likely have ratified the pact while South Africa and Nigeria were hesitating, but they already signed on the document.

Closer to home, CAFTA adds up or widens the range of trade regimes that near and distant trade partners can use to bring goods here, or rather widens the sourcing of goods for local merchants or importers, checking with their chambers of commerce on the do's and don'ts of the new situation.

CAFTA adds to the Southern African Development Community (SADC) and the East African Community (EAC) in spheres

of privileged trading relative to raw or rudimentary World Trade Organisation (WTO) rules, where no prior privilege is provided but in regional blocs.

CAFTA is definitely an improved version of WTO, of which most countries are already members, but not quite like SADC or EAC.

That is where the need for finetuning in the trade environment comes up - namely, that goods aren't likely to be sourced from far away by the tonner but that, with a slightly easier trade pact existing, they are likely to flow more easily than before.

The past half a decade has seen South African and Kenyan supermarket chains closing shop for lack of business.

This had largely to do with their market strategies in the first place, but also against the background of taxation regimes that have to do with regional trade affinities, bilateral pacts. To a certain extent this situation is now being eased, as all of us will be part of an African bloc, largely

For those who support economic reforms, what is even more laudable about CAFTA is that it provides an external cushion to existing regional trade blocs, chiefly in engendering a different mechanism of trade liberalisation.

The CAFTA protocol is quite specific about free movement of people, trade and goods, whereas the East African Customs Union protocol enshrines moving goods more or less liberally, by tax margins agreed by Finance ministers each year.

In the light of the new trade instrument, this protocol will have to be more institutionalised so that changes in taxation will not disrupt CAFTA-based harmony.

Apart from rescuing these children, going forward, what steps will Government take to ensure that children are safe while they are in school? Believe it or not, another incident of kidnapping has already been reported in Katsina State after #BringBackOurBoys; one in which about 88 girls were said to have been rescued from their abductors. Beefing up the security in all schools (especially up North) is a given, as children cannot just put a stop to their education.

Education is the key to the development of any society; but, these criminal elements are instilling fear into Parents with their concentrated and continuous attacks on educational institutions, in order to ensure that they keep their children out of school - something that would be tantamount to conceding defeat to those who senselessly say formal education is an abomination, if Parents and their children are scared away (of course, being scared away is a natural reaction who wouldn't be afraid? With the kind of violence that Boko Haram has unleashed in the past and is still unleashing, most people would be fearsome). Already, Nigeria has one of the highest numbers of outpracticable, provide free education up to tertiary level, and even a free adult literacy programme, while Section 38(1) guarantees our right to freedom of thought and religion. The synopsis of a community

reading of afore-mentioned constitutional provisions, is that Nigerians are free to practice any religion which they choose, and even change their religious beliefs; that education is a priority for all in Nigeria, as it is a fundamental objective and directive principle of State Policy; that religion does not play any role in State Policy; and therefore, even if any religion prohibits its devotees from acquiring an education, the provisions of the Constitution which promote formal education, shall prevail.

Islam and Education

In reality, nothing in the Holy Quran or the Holy Bible prohibit education. However, the organisation, Jamaal-u-Ahlis-Sunna-Linda-Awati Wal-Jihad -"the organisation committed to the propagation of the Prophet's teachings and Jihad", aka Boko Haram (literal interpretation "Western Education is forbidden"), says otherwise, having misquoted and misinterpreted the words of the Holy Quran. In fact, it is quite the opposite. Islam promotes the quest for knowledge, and this is evidenced in the Hadith (the traditions and sayings of Prophet Muhammad [PBUH]). Some of the sayings of Prophet Muhammad [PBUH] in the Hadith are:

"Whosever follows a path to seek knowledge therein, God will make easy for him a path to Paradise"; "Education is not only the right, but the duty of every Muslim, male or female"; "The best gift from a father to his child, is education and upbringing". It is said that the first word of the Quran to be revealed was: 'Read'. I do not see any words in these particular quotations of education, which they see as one of the signs of the corruption that has pervaded our nation. They also believe that many aspects of Western education, are contrary to the teachings of Islam.

In Mohammed Abid Ali's Article "Islamic and Western Education Systems - Perceptions of Selected Educationists in Malaysia", Ali quotes Khan (1986) who stated thus: "The philosophy of Education determines the aims and objectives of Education. There are different philosophies of Education. Naturally there are different aims and objectives of Education (p. 41)". I concur. Ali goes on to say that "... .. it is natural that Islam should have a system of education which is different from the western system of education, which has its background either in Christian theology or secular approach". I also agree with Ali that "the West and Islam have quite different philosophies of life... .", and education systems are developed to suit the aim and objectives of the different nations and philosophies.

The sum and substance of this is that, the aims and objectives of Nigeria's educational system, I imagine, are to develop human potential in order to develop the country. This may not necessarily be in consonance with that of Islam, which according to Ali, "prepares man to assume the responsibilities of the highest creation of God and His vicegerent", that is, while the aims and objectives of western education may be worldly, that of Islamic education is obviously, heavenly.

And while I have no issue with either type of educational system, I can only conclude that Section 38 of the Constitution guarantees our right to have any type of education which we so desire, whether religious or formal; and that because Nigeria is officially

I'm almost four years sober, and I've suffered from depression, anxiety and alcohol issues most of my life. My father also suffered from the same thing but, unfortunately, he didn't make it. He was able to seek help for his depression, but he couldn't bring himself to quit drinking. And this eventually took his life.

Alcohol was the single worst cause of my anxiety and depression. I knew this from both my personal experience and because I used to be a mental health nurse. The research is quite clear when it comes to alcohol and mental health - if you suffer from any type of mental health issue, alcohol will make it worse.


Within a month of quitting drinking, my anxiety and depression symptoms improved and not just a little - a lot. I was more relaxed, slept better, and didn't wake up anxious the way I usually did after drinking. I also seemed to digest food better and could gather my thoughts more rationally.

During my drinking binges, the worst anxiety I ever had was after I stopped drinking for a few days. And, of course, I knew why that was - the most common symptom of alcohol withdrawal is anxiety.

And even though I knew this as a nurse, I was addicted to alcohol, so I couldn't face it. It was my crutch, and horrible as it sounds, I preferred to stay sick rather than quit drinking. This was also the same reasoning that my father followed.

I suspect that this is a popular story amongst many who have mental health issues and who also drink





too much. We know that it doesn't help

our physical or mental health, but we can't stop. More so, we can't really talk about it either because doing so would force us to reconsider our drinking habits.

Most of us with mental health issues choose alcohol because it relaxes us and seems to help our symptoms at first. Indeed, one or two drinks usually has a calming effect. The reason for this is that alcohol suppresses our nervous systems, which is why we initially feel good.

Unfortunately, once we have had a few drinks and then stop for the night, the nervous system rebounds from that calm state and snaps in the opposite direction. This is why we feel so damn anxious when the alcohol starts to wear off. It's important to know that even a few drinks can cause this challenging effect. Even more importantly, those who suffer from mental health issues are already known to have a sensitive nervous system.

This means that we're already prone to significant swings in our neurological synapses, so adding more irritating substances can have devastating effects.

The problem is that people with mental health issues already have a lot on their plate. Not only do we have to deal with our life-altering symptoms, but also we cope with stigma and judgment everywhere we turn.

And guess what else has a lot of stigma and paid the ultimate price.

attached to it? Alcohol addiction. So those of us with mental health and addiction issues can really find ourselves in a pickle. No matter which way we turn, someone is going to judge us for both our mental health and alcohol problems.

This is why most of us stay silent. And even if we begin to speak out about our mental health issues, we will usually maintain our silence about alcohol. After all, why would we tattle-tale on our favourite coping mechanism?

Unfortunately, this leads to worsening mental health and addiction symptoms. This was the case for me until I reached out for help and quit drinking. My father stayed silent, continued his drinking,

In the mental health system, we usually refer to people with both mental health and addiction issues as having concurrent disorders. The research shows that those with concurrent disorders are at higher risk of suicide, severe disability, and death.

However, the reason people stay silent about their alcohol issues is that they feel that it helps them cope with their mental health. But what if people knew more about the effects of alcohol and exactly why it makes their mental health worse?

Yes, many of us know that excessive drinking isn't good for us, but most of us don't understand why. More so, when you're already hanging by a thread owing to severe depression, you might need a damn good reason to give up the one thing you believe helps you, right?

The best we can do now is to talk about this more openly and with better information. As a former nurse and alcoholic, I'm committed to getting this info out there the best way I can.

Quitting drinking helped my nervous system find balance again. Only then could I address my depression and anxiety adequately. Alcohol only further confused my mental health and made it virtually impossible to find the root cause.

You should also know that if you take medication for depression or anxiety, alcohol will prevent it from working correctly. Alcohol interacts with most mental health prescriptions by blocking the body from metabolising it properly. Even more frightening is that adding alcohol with prescription medication causes severe stress to the liver.

If that's not bad enough, you should know that a stressed liver also causes problems in our nervous system, which may further our mental health problems.

So you can see that alcohol causes a vicious cycle that only feeds into worsening addiction and mental health issues.

If you're someone who drinks heavily and also has mental health problems, please talk to your doctor about it. Staying silent can have severe repercussions. I know it's hard to find non-judgmental help but, with a little perseverance, you'll find what you need.

You're not alone, and trust me, there is help out there. There are better ways to cope with - and relieve - the symptoms of mental health issues. But unfortunately, alcohol is not one of them.

## Expensive drugs tested for impact on coronavirus's breath-stealing damage

NE of the scariest elements of Covid-19 is that even among those who survive the disease, damage to the lungs can linger afterward, and it's unclear whether that tissue will fully recover with time.

The destruction caused by the virus that causes Covid-19 can be so severe that in some cases patients require a lung transplant to survive.

At the root of this potentially devastating scarring is a cellular process called fibrosis. That phenomenon occurs when cells produce collagen protein in response to injury, which clogs up tissue.

This can occur anywhere in the body and is even part of the normal healing process when, for example, a person accidentally trips and scrapes the knee. But with Covid-19, the body's fibrosis reaction might go overboard.


"It is very concerning because we haven't seen this degree of fibrosis in any other disease in the past, even with the original SARS," says Sachin Chaudhary, MD, director of the Interstitial Lung Disease Programme at the University of Arizona College of Medicine.

"Personally I am seeing quite a lot of fibrosis post Covid-19, and the emerging data are quite a concern," says Gisli Jenkins, MD, PhD, a lung airway expert at the University of Nottingham, a public research university in the UK.

One study published last month showed that 65 per cent of Covid-19 patients discharged from hospital had some evidence of lung damage in scans three months later, but the prognosis is not certain.

Jenkins notes: "It's unknown if it will resolve and get better over time, stay the same, or in the worst-case scenario, turn into something like idiopathic pulmonary fibrosis," a disease of unknown cause in which lung scarring gets worse and worse with time.

"If even a small proportion progresses, then given the numbers of patients with Covid-19 then there will be a big



problem," adds the expert. organisations.

Steve Jones knows firsthand the seriousness of unchecked fibrosis in the lungs. He was diagnosed with idiopathic pulmonary fibrosis in 2008.

"I could no longer go hiking in the hills and even walking up slight ramps, like you have in shopping malls, became a real challenge," Jones recalls.

He says that daily living tasks such as showering and dressing became more and more difficult. Eventually, he needed supplementary oxygen to walk around the house.

"I would have died from respiratory failure but I was really lucky to be accepted for a lung transplant in 2016," says Jones, who is now president of the European Pulmonary Fibrosis Federation and disordered the collagen - which represents 21 patient structures that hold the tissue

A study published in late November last year examined the lung tissue from people with Covid-19 who required lung transplants and found remarkable similarities to end-stage pulmonary fibrosis. These included how messy

however, they cannot reverse the damage. There has been a continued search to find better treatments for lung fibrosis. Oddly, even a chemically modified version of the antimalarial drug hydroxychloroquine -which failed in treating Covid-19 after a massive amount of hype - has been tested in rats as a possible treatment for lung fibrosis.

Nintedanib and pirfenidone are already in clinical trials involving Covid-19 patients, although no results have been reported yet. But Chaudhary cautions against the idea of treating a large number of Covid-19 patients prophylactically with these medications: Not only do they carry side-effects, such as bleeding, but they are also very expensive - costing around \$100,000 a year.

Chaudhary also stresses that viral infections of the lung often only cause temporary fibrosis that resolves with time. One 2005 study of people infected with the original SARS virus found that, a year after their illness, there was some mostly mild scarring in about onethird of individuals.

Chaudhary says that it's far more likely for experts to see lasting fibrosis in people owing to chronic environmental exposures, such as the lasting lung damage observed in coal miners.

This is akin to what happens with a chronic injury such as scraping the knee every day in the same place: the healing process starts to go haywire after chronic injury, leaving one with a scar. A similar process happens in the lung with repeated injury.

Also, some researchers have seen low rates of fibrosis in Covid-19. Emanuela Barisione, MD, of Italy's IRCCS San Martino Polyclinic Hospital, says that some 5 per cent of the Covid-19 patients her team is studying had fibrosis at three months.

there's still a lot of pressure to find drugs that might help treat or prevent scarring. Other drugs currently under study to see whether they might stem fibrosis in Covid-19 include the antibody drug pamrevlumab, which inhibits a protein in the body that encourages the growth of connective tissue.

The anti-inflammatory drug colchicine, which is being assessed in a clinical trial of Covid-19 patients, also has theoretical potential to stop fibrosis.

"A plethora of drugs are being tested in patients with severe Covid-19," Budinger says, further noting that some of these may reduce fibrosis by limiting the severity of the initial injury caused by the virus or by directly targeting the immune system's role in producing fibrosis.

There's even renewed hope that by better understanding the cells known as fibroblasts - which secrete collagen and drive scarring - it might one day be able to have drugs that undo tissue scarring.

But Budinger worries that the studies looking at current drugs' effects on Covid-19 might take too short a view on outcome, especially for something like fibrosis, which may only manifest as chronic or worsening over a longer period: "Because most of these trials focus on survival alone, I am concerned that we might miss a beneficial signal for some of these agents in Covid-19 survivors."

If the benefits of drugs on fibrosis are to be known, survivors of Covid-19 have to be followed and assessed long after they overcome the SARS-CoV-2 infection. No organ is as hard-hit by Covid-19 as the lungs, and so doctors say that it's crucial to keep an eye on Covid-19 patients' lung function far into the future.

## From earthquake recovery to coronavirus battle: A tale of Tibetan dance and African songs

#### BEIJING

s the temperature continues to drop on western China's Qinghai-Tibet Plateau, local school kids still look forward burningly to their recess for a dance. While in Brazzaville, capital of the Republic of the Congo, artists are beating drums with fiery passion as if summer never ends.

Though geographically far apart, the two peoples, both of whom have a rhythmic soul and habitually resort to dance and music during hard times, have always extended a helping hand to each other, which makes a tale of friendship between China and Africa.

#### DANCE OF GRATITUDE

Cewang Pasang, a 20-year-old Tibetan girl, was still emotional when recalling the day when an earthquake hit her hometown, the Yushu Tibetan Autonomous Prefecture, northwest China's Qinghai Province, 11 years ago. In April 2010, a 7.1-magnitude earthquake struck Yushu. Cewang and her friends were safe, but had to spend freezing nights in tents with their school badly damaged from the disaster. "I felt like I've lost my home. I dreamt of reading on my own desk again," she said. Indeed, the school was not merely a place to get education, as it is more of a paradise for Cewang and her schoolmates, many of whom are orphans. While attend-



ing the Shanghai World Expo in 2010, Denis Sassou Nguesso, president of the Republic of the Congo, expressed his country's willingness to rebuild a primary school in the quake-hit area, at whatever cost.

In July 2012, the restoration of Cewang's school was completed under the new name of the Sino-Congolese friendship primary school. "Although our economic

capacity is limited, we should extend help," said Basile Ikouebe, then-foreign minister of the Republic of the Congo at the ceremony to celebrate the completion of the construction. Despite pouring rains, Cewang put on her Tibetan robe and performed with her friends the Tibetan circle dance, representing the highest tribute of her culture, in front of the African guests. For her, the

dance was the hidden language of gratitude. "I was not the best dancer. But I tried to dance in the best way I could as a way to say thanks," said Cewang.

SONG OF ENCOURAGEMENT Ten years after the earthquake, the COVID-19 pandemic is ravaging the world.

In February 2020, when China was battling hard against the virus, Pointe-Noire, the second largest city in the African country, donated 10.000 medical protective masks to their sister city Suzhou in eastern China. "We are convinced that you will come out as a winner," read a letter written by the Congolese mayor Jean Francois Kando. When the African country is faced with challenges, China did not hesitate to reach out. On May 23, a 12-member Chinese medical expert team arrived in Brazzaville to reinforce the country's fight against the pandemic.

Inspired by the joint battle against the coronavirus, Moukila Ngalipe Tessia Harmanie, a Congolese singer, made a song with Babingui Tambour, a local drum band. "The Congolese love music. Music is a byword for us. Our life would be impossible without music," the singer said. Under the name of "Congo China, hand in hand," their song tells a story of solidarity. "We've got medicines from China to help us battle the virus. What can we musicians do to thank China? We composed this song. Let's go hand in hand and prevail over the virus together," Zoubakela Destin, head of the tambour band, said in Chinese.

#### PANDEMIC UNABATED

NYC's COVID-19 test positivity rate on a seven-day average reached 9.08 percent, compared with 9.39 percent one day earlier, Mayor Bill de Blasio tweeted on Sunday. The rate was announced on Jan. 1 to top 9 percent, on Dec. 31 to top 8 percent and on Dec. 27 to top 7 percent. It topped 3 percent in late November, which was believed by the city government to signify the arrival of a second wave of the coronavirus, and has remained above the level ever since. Meanwhile, the mayor said on Sunday that there were 213 new hospitalizations and 3,885 new cases of the coronavirus in the city, adding that "Double down on what works this week -- avoid large gatherings, keep six feet apart and wear that mask." # Experts contribute ideas for NYC to revive from COVID-19 pandemic



positively respond to economic crisis together with health emergency and help communities play a bigger role in the fight against the coronavirus, so that the city can recover from the pandemic better and stronger. "The key to recovery from any disaster is to quickly unify around a recovery plan," said Kathyrn Wylde, president and CEO of the Partnership for New York City, a non-profit organization that works with the city's business leaders, government, labor and the civic sector to make a better New York. "We have not done that, in some ways because the disaster is ongoing. Part of that is a leadership problem. Part of that is the nature of the disaster," she added.

Wylde has seen the city rebound before. From her front-row seat as president and CEO of the Partnership for New York City, she watched the five boroughs recover from a terrorist attack on the World Trade Center in 2001 and the superstorm Hurricane Sandy that wreaked havoc on the city in 2012. The city has responded admirably to the health emergency, but has left it largely up to others to respond to the economic crisis, which, in the long run, might not be so bad, according to Wylde. "These groups are finding out that they basically have to figure out the solution themselves,' she explained. "Leaders are going to come together and turn their solutions into public policy. I've been doing that anecdotally, connecting these grass roots initiatives. I think it's going to become the new way to approach problem solving instead of calling 311 and waiting for a government agency to come and fix their problem."

Wylde also said New Yorkers have become overly dependent on local government to solve their problems. "In the 70s the government was broke and had nothing to offer but to get out of the way," Wylde said. "Communities had to



figure it out and solve their own problems. I really do think that same phenomenon is going to take place as a result of this experience."

CASH

#### FLEXIBILITY, GRANT

Another expert has called on the owners of the eateries and nightlife venues in NYC to have more flexibility, together with cash grant from government, in their efforts to make their businesses recover from the pandemic. Even before the coronavirus crisis, it was challenging to operate a successful eatery or nightlife venue in NYC; innovation and creativity have kept a lot of places from closing their doors, and what they need now is flexibility, said Andrew Rigie, executive director of the New York City Hospitality Alliance, which represents nightclub and restaurant owners. "So much more must be done to give these business owners a fighting chance of survival," Rigie said. "It's not enough to sing the praises of small business. We need concrete action."

Among the ideas Rigie is co

putting on the menu is a cash grant to restaurants that would be drawn from the sales tax they generate. The businesses would reinvest the money to help pay staff or the cost of retrofitting their restaurants to comply with COVID-19 guidelines. "It's a quick way for local government to get cash into the pockets of business owners," he said. Rigie would also like to see some action to stop what he said is the exploitation of restaurants by third-party delivery apps like GrubHub and Uber Eats. Those companies should be transparent with the public about the fees, at least 20 percent to 30 percent for each order, that they are charging the restaurants.

He is also urging congressional lawmakers to get behind the RESTAURANTS Act, which would provide 120 billion U.S. dollars in relief through a grant program administered by the Treasury Department. "The biggest challenge for the restaurant industry is the rent," Rigie said. "New York City will not recover unless our restaurants and nightlife are at the core of the recovery."

A third expert has urged NYC to tap more potential from remote learning and adeptly consider model changing in order to better survive the COVID-19 pandemic to re-emerge strong and resilient. Dennis Walcott, president of the Queens Public Library, underlined the need to make remote learning more inclusive by increasing access to computers and Wi-Fi in underserved communities. Not only is that a necessary component to getting education back on track in the city, but it's also a business opportunity for local entrepreneurial tech firms to cash in on, he said. "That's exactly where the synergy comes in," Walcott said. "You have people who are totally knowledgeable in this area who can come in. That type of mentality creates opportunity for en-

For a restaurant owner forced to close her kitchen, or an out-of-work chef looking to start out on his own, Walcott said the opportunity might come in the form of a food truck or cart.

"People can come up and get their local meals," Walcott said. "You can have that throughout various neighborhoods. There's always a need. I've always been surprised by the lack of service skills in the neighborhoods."

Walcott also said that incentives must be created to tap into neighborhood potential. But, again, he said, it's about the mindset, and changing the model.

"We have to start to pivot mentally in terms of what our potential is," Walcott said. "The more businesses we have going in, the more tax revenue we can generate to make the city a richer place." ## **Embrace responsible** parenting to curb child labour, parents urged

recently in Geita

AUTHORITIES in Geita Region have called upon the public to embrace responsible parenting to reduce child labor.

Geita town council executive director Eng Modest Apolinary made the call in Geita recently while narrating on strategies used by his town to curb the vice.

Eng. Apolinary said child labor relates to street children adding that the vice is a global issue as is the case in his region where the problem is rampant due to mining activities in the area.

Asked on measures taken to curb the vice in his region, the town director said they had been using a local radio in the area to address the vice.

"We have been using a radio program at Storm FM where a community welfare officer has been going on a weekly basis to sensitive the community on child labor and responsible parenting. Our concern has been with streets in Nyakabale where parents send children to steal gold in the mine. This is very risky as some drown in pools with some injured during the practice," said Eng. Apolinary.

According to the Town Director, the radio campaign has helped as the number of beggars and street children has gone down.

For his part, Maulid Mrisho, 14 Kambarage street chairperson said in the past, the problem was prevalent with children as young as 13 who had completed their standard seven education engaging in labour especially in charcoal and mining

"Most parents said they were forced to send children to work because they were too poor to pay for their children to go to school. I advised them to form groups where they got loans from the municipal council and eventually managed to establish business for them to sustain and send their children back to school," said Mrisho.

Mrisho mentions Storm FM as a great partner in the street saying there is no community problem that has gone without their attention saying he has used them to address land conflicts, security and safety issues in his street as well as to address conflict between peasants and pastoralists.

Storm FM has been enjoying support from UNESCO under its SDC project.

THE Tanzania Chamber of Commerce, Industrial and Agriculture (TCCIA) is set to establish a large cashew plantation in Chemba District, Dodoma Region.

The Chamber has already acquired 20,000 acres of land in the district for the commercial cultivation of cash crop which is currently grown mainly in the southern and coastal regions of the country.

TCCIA regional director for Dodoma, Idd Senge told The Guardian in an interview yesterday that the initiative is partly to correspond to the government's call for promoting of cashew in other regions the country with conducive climate for the cash crop whose nuts are one of the top forex earners for Tanzania.

According to him, the project is being implemented by the Chamber through its subsidiary company, TCCIA CODE in partnership with Dodoma -based N & N Trade Company.

He added that added that apart from cashew, the plan is also to cultivate sunflower as well as cassava in the region.

"As key stakeholders in supporting the government to stimulate economic growth, we have decided to adopt cultivation of cashew crop which will soon become a new cash crop in our region," he expressed.

Moreover, he added if all goes well, the project will also incorporate installation of ultra-modern cassava processing plant with the capacity to process cassava chips for local consumption and later export.

Establishment of the cashew farm will become the second in Dodoma region after the one in Kongwa District which is under the ownership of a group of farmers.

Statistically, Tanzania is currently producing 315,000 tonnes of cashewnuts in a year, which is very low compared to the country's potential which can reach millions of tonnes.

To change the poor record, the government has in recent years launched a special programme which among others, includes to identify and set aside chunks of lands in all regions where the crop flourishes, the target being to produce at least 1million tonnes by 2025.

So far, already 20 regions have been selected for the major cashew production.

## **China-Africa cooperation prospers against Covid-19**

he outbreak and spread of COVID-19 since the beginning of 2020 has severely affected economic and social development of countries around the world, and disrupted international cooperation as well. Looking at comments on China-Africa cooperation at the end of last year, we can find out that most were positive, but there were indeed negative tones about such cooperation.

These comments fall into five categories, including the argument that China-Africa trade has gone through a free fall, the prediction that China's investment and financing to African countries will continue declining and never rebound, the pessimism about the future of China-Africa cooperation, the exaggeration of the return of Chinese people back home, and the accusation of environmental pollution by Chinese projects in Africa. These arguments and reports seem to be convincing, but in fact are alarmist and lacking in evidence. So what is the truth?

China and Africa have maintained dynamic economic and trade cooperation. China has contributed to Africa's economic growth by over 20% for consecutive years. Despite a gloomy picture of the global market, China-Africa trade was approaching US\$180 billion in 2020. Although it is lower than US\$208.7 billion of 2019, in comparison with other countries, China will remain the biggest trading partner of African countries for the 12th year in a row.

China has opened its door wider to African products. Over 400 African businesses from more than 40 African countries have attended the China International Import Expo (CIIE) for the past three edition, where the Zambian blueber-



ries and Tanzanian soybeans have been imported for the first time to China.

The Ethiopian coffee, Zambian honey, and Beninese cashew nuts were very popular at the third CIIE. The 3000 packages of coffee from Rwanda that had been difficult to sell due to the pandemic were sold out in a short while on line by Chinese consumers. China has also decided to offer financial support to the Secretariat of the African Continental Free Trade Area (AfCFTA), in order to promote a more balanced and diversified China-Africa cooperation.

China and Africa have continued investment and financing cooperation. Investment and financing cooperation is part and parcel of China-Africa economic and trade cooperation. On the one hand, due to the pandemic, all countries face the downward pressure of their economy while China's financing in Africa faces the same difficulty. However, such a decline will not be irreversible. With the easing of the pandemic in the world,

China's financing in Africa will rebound again.

On the other hand, China's investment in Africa was steady in 2020, with direct investment reaching US\$3 billion, which was not easy at all. In June 2020, the Lekki Deep Sea Port Project in Nigeria was launched, having received over US\$1 billion investment from Chinese business through public-private partnership (PPP).

The project will significantly boost the transportation capacity and competitiveness of West Africa, and create a large number of jobs for the local people. Chinese businesses have also invested US\$680 million in the form build-operate-transfer of (BOT) in the JKIA-Westlands Expressway project in Kenya. Currently, the project is well under way in spite of the pandemic, and is expected to be completed beforehand in 2021. All these projects are undertaken through the new models of China-Africa investment and financing cooperation, striving for a new and high-quality China-Africa cooperation. China has

also signed debt suspension agreements with 14 African countries within the framework of G20, and has decided to forgive interest-free government loans that are due to mature by the end of 2020 for 15 African countries, ranking the first among G20 members in terms of deferral amount.

China and Africa have kept the momentum of practical cooperation. The Extraordinary China-Africa Summit on Solidarity Against COVID-19 was held in June 2020, making China the only major country that convened a summit with countries across Africa in 2020. China has provided rounds of highdemand supplies to all African countries and the African Union to help them combat COVID-19, and African countries have also been firm in their support to China's efforts on fighting against the pandemic. We have demonstrated

China-Africa solidarity in times of difficulty. The "Belt and Road" initiative is very popular in Africa, with 44 African countries and the AU and Road cooperation documents with China, making up about a third of all countries and organizations that have entered into such agreements with China globally.

The Chinese government and the AU Commission have recently signed the cooperation plan on jointly promoting the construction of the Belt and Road initiative. The 14th Senior Officials Meeting of the Forum on China-Africa Cooperation (FOCAC) was successfully held recently.

China and African countries have implemented over 70% of the outcomes of the FOCAC Beijing Summit, with priority shifted to the areas of public health, economic recovery and people's livelihood. China-Africa cooperation on digital economy has seen fast growth, with South Africa's mobile operator and China's Huawei jointly issuing the first 5G commercial network in Africa.

TikTok has become the fastest growing social application in South Africa, Kenya and Nigeria. In the first half of 2020, the newly contracted projects undertaken by the Chinese businesses in Africa totaled US\$29.1 billion in value, a year-onyear increase of 33%.

The freight volume of Mombasa-Nairobi Railway and Addis Ababa-Djibouti Railway, which were constructed by Chinese businesses, was also on the rise despite the difficulties. China is the only major economy that achieved positive growth in 2020, and is accelerating the building of a new development paradigm with domestic and international economic circulations reinforcing each other. The pie of China-Africa practical cooperation will surely grow bigger.

China-Africa people-to-people exchanges have overcome hardships and remain steady. Given the

Commission having signed the Belt severity of the pandemic, countries around the world have tightened their border control, thus making people-to-people exchanges more difficult.

> Nonetheless, over 1100 Chinese cooperation projects have maintained operation in Africa, and a large number of Chinese technicians and workers held on to their positions in Africa. Bearing in mind Africa's development and wellbeing of its people, China has sent thousands of employees of Chinese businesses back to Africa by commercial and temporary chartered flights.

> They are the most beautiful bridge connecting the hearts of the Chinese and African people. China has also sent medical expert teams of 184 people to 15 African countries.

> Nearly 1000 medical staff from 40 plus resident Chinese medical teams have chosen to stay in Africa to help African people go through the difficult time. In the second half of 2020, events like China-Africa Youth Gathering, China-Africa Think tank Forum and China-Africa Private Sector Cooperation Forum have been successively held, strongly promoting China-Africa friendship. Certain media and think tanks have spread the news that a large number of Chinese are leaving Africa, which is out of ulterior motives. With the Chinese Spring Festival arriving soon, it is common and understandable for the Chinese people to travel back home for reunion with their families, which is just like westerners going home for Christmas.

> More importantly, many of the Chinese returning to China still have their businesses in Africa. As Africa has become their second hometown, they will surely come back to Africa after the festival.

for Britain and the European Union. But don't bet on it. The U.K. has chosen to leave the EU, setting a course away from the continental mainland.

But the two sides' histories have been too intertwined for 1,000 years for the split to be simple. Eleven months after Britain's formal departure from the EU, Brexit becomes a fact of daily life on Friday, once a transition period ends and the U.K. fully leaves the world's most powerful trading bloc. But customs controls, red tape and the residue of bile caused by years of acrimonious divorce talks may provide the sting – not the thrill – of the new.

And despite the 4½-year extraction process, loose ends will sur-

face for months, even years, to come. "For one reason or another, the U.K. is likely to be in non-stop negotiations with the EU for decade after decade," said Charles Grant of the Center for European Reform thinktank. Brexit marks the end of

an awkward relationship. Britain joined the then-European Economic Community in 1973, but never fully embraced the bloc's project of ever-closer integration.

The EU was born out of the ashes of World War II and its market by making tariff-free

much differently than, for example, Germany. Still, actually leaving the bloc was long a fringe idea before it gradually gained strength within Britain's Conservative Party. In a 2016 referendum, voters – striking a blow against the status quo - opted by a narrow 52% to 48% to leave.

That political shock is still reverberating. It took 31/2 years for the split to happen last Jan. 31 and another 11 months of fractious wrangling to agree on a trade deal. Sealed on Christmas Eve, it satisfies major demands on both sides. It protects the EU

the European Court of Justice. U.K. Prime Minister Boris Johnson called it "a new starting point for our relationship between sovereign equals." The EU begs to differ.

It considers itself the superior partner, a bloc of 450 million consumers, carried by economic juggernauts like Germany and France. while Britain is a nation of 67 million. It believes the brunt of Brexit's pain will be borne by the U.K.

"We are one of the giants," said European Commission President Ursula von der Leyen. "From a position of strength you can achieve a lot." For British Brexiteers, the blow from erecting new trade barriers is compensated by visions of regained freedom and - a crucial word - "sovereignty." So far, Johnson has given only glimpses of what he plans to do with that sovereignty: forge trade deals around the world, be more competitive through "smarter and better regulation," expand the hightech sector.

From a member of the EU, Britain will become its economic rival. The EU is wary of Britain's potential to seek an edge by slashing standards and becoming a low-tax "Singapore on Thames" on its doorstep.

That's why the Brexit deal contains "level playing field" restrictions on how far the U.K. can diverge without punishment. Britain may soon bristle against those restraints.

Further tensions, spats and negotiations loom in the future. And the agreement is to be reviewed every five years, reviving a debate that many had hoped would fade. "If you thought this was going to be a onehit wonder ... then you will be disappointed," said Catherine Barnard, professor of EU law at Cambridge University.

Trust is already in short supply, and recent events gave a taste of what can happen. Much U.K.-EU goods trade goes across the English Channel, and when France decided to stop all crossings on Dec.

manuel Macron became "Monsieur Roadblock" giving Britain, in keeping with the Christmas theme, a "kick in the baubles." France denied the border closure was related to Brexit. But Macron's office issued a statement this week saying that "France

will be very vigilant from Day 1" in case Britain "disregards its commitments" under the agreement. While Johnson sets Britain out on a solo course, most EU leaders see cooperation as ever more vital, especially with a pandemic ravaging the world and the United States and China ready to squeeze European nations out of the diplomatic game.

"We should cut through the soundbites and ask ourselves what sovereignty actually means," said von der Leyen. "It is about pooling our strength and speaking together in a world full of great powers.

And in a time of crisis, it is about pulling each other up instead of trying to get back to your feet alone." Brexit has already destabilized the U.K. itself. It has boosted support for independence in Scotland, which voted strongly to remain in the EU in 2016.

Northern Ireland, which shares a border with EU member Ireland, remains economically closer to the bloc than the rest of the U.K. under the departure terms, a status that could push it away from Britain. EU chief Brexit negotiator Michel Barnier, a European Unionist and Frenchman to the core, sees tough times ahead for Britain.

Barnier said that "when you see today's world, a dangerous, unstable and unjust world, I definitely think that it is better to be together, with our neighbors in a union, a single market, than everyone being in their own corner, with their own interests."

## Blow for middlemen as court backs 50kg potato packaging

#### NAIROBI

Packaging of potatoes will remain capped at 50 kilogramme at the farm-gate after the High Court ruled, offering relief to farmers exploited by middlemen over the years.

A group of 17 traders had moved to court seeking to quash a 2014 directive by the Agriculture Food Authority (AFA) that potatoes only be packaged in bags not exceeding 50kg, terming it unconstitutional since they were allegedly never consulted. They also wanted the court to issue an order stopping the police from arresting and prosecuting them on the basis of having potatoes packed in gunny bags exceeding the limit.

Led by Mr Julius Mutiga, the traders had urged court to bar government from implementing Section 42 of the Agriculture Fisheries and Food Authority Act, 2013, which makes it illegal to package potatoes in bags of over 50 kilogrammes.

But justice Weldon Korir said in issuing the directive AFA was simply restating the law and therefore the directive was valid. He added that the case had been overtaken by events after coming into force of the Crops (Irish Potato) Regulations, 2019 which replaced the disputed directive.

Justice Korir cited regulation 19(1) & (2) which provides that 'the unit of measurement of all Irish potatoes shall

be the kilogramme. Section (2) states "the maximum weight for each single unit of package of Irish potatoes shall be 50 kilogrammes."

AFA told the court that the disputed directive was issued to curb exploitation of farmers by middlemen who did not adhere to the measurement requirements leading to huge price differences of up to 1000 percent as a result of usage of extended bags of 130-260 kilogrammes.

It added that the directive was guided by international best practice including the International Labour Organization's Convention No.128 of 1967 which recommended a maximum weight of 50 kilogrammes for crop packaging.

The court heard that the recommendation was adopted by Kenya in 2012 through Kenya Bureau of Standards/East African Standard. Further, that the Convention in any case form part of the laws of Kenya by virtue of Article 2(5) & (6) of the Constitution.

The traders had argued that the directive had caused them suffering and losses stemming from harassment by county governments and the police. They also claimed that buyers were refusing to purchase potatoes in the smaller sacks. However, the Ministry of Agriculture said the claim was farfetched as the farmers have the liberty to adjust prices in line with the size of the package.



Mtatiro warns rogue pastoralists of

consequences for 'invading' farms

ASTORALISTS grazing their livestock in farms and forest reserve areas in Tunduru District will face consequences including pros-

ecution with possible jail terms if convicted. Tunduru District Commis-

sioner, Julius Mtatiro said over the phone earlier this week that he is aware of the major challenges facing farmers and conservationists in the district because of an influx

of livestock from other districts in Ruvuma Region.

"As a district, we still have a major challenge with an influx of herds of cattle encroaching on farms and forest reserves which is causing conflicts with farmers but also contributing to environmental degradation," Mtatiro said.

He said his administration appreciates the importance which both farmers and pastoralists play in the food chain of Tunduru but said people have a responsibility to respect rules and regulations. "It is very important for livestock keepers to follow the law, guidelines and directives issued by the district and village governments," the DC noted.

He emphasized that Tunduru has enough room to accommodate both farmers and livestock keepers but warned against herds of cattle arriving almost daily from neighbouring districts and regions where degradation has already caused droughts.

"Livestock keepers will remain in our district because everyone has the right to live freely here but we will ensure that animals graze on farms," he vowed while stressing that encroachment of farms by livestock also threatens peace and security in the district.

In Namakambale Ward where livestock encroachment is rampant, district officials have already issued fourteen days to herders grazing their animals in forest reserve to leave such areas of face legal action which include confiscation of their animals.

Speaking on behalf of Songambele and Namakambale residents, Songambele Village Chairman, Saidi Makale said that the order was issued on December 30 last year by district officials following complaints from farmers and villagers.

"We have asked them to leave because they graze their animals on people's farms and inside the village forest reserve which has damaged crops and the environment," Makale said noting that the pastoralists have already destroyed paddy rice fields and cassava farms in the area.

"What these livestock keepers are doing is unacceptable because our families are now facing a threat of hunger due to destroyed crops," he alerted saying that the villagers have also raised the matter with Deputy Minister of Livestock and Fisheries last year. Songolewa Forest Reserve has a total of 10,217.1 hectares of land.

### Alibaba shares slide as Jack Ma stays away from public eye

#### BEIJING

The year 2020 was a bumper one for many listed tech titans. However it hasn't been all rosy for billionaire Jack Ma's companies.

The anti-monopoly investigation launched by Chinese regulators into Alibaba Group last month, and the absence of the billionaire founder from the public realm over the last two months, since the collapse of Ant Group's initial public offering, are casting a shadow on the performance of the e-commerce giant's shares.

Alibaba Group's stock price dropped 2.15 per cent in Monday trading in Hong Kong to close at HK\$227.6 (\$29.35), as investors grew increasingly nervous over regulatory hurdles. The e-commerce company's share price has fallen by a quarter from its peak since the start of the investigation, according to financial services provider Century Financial.

"However, what is important from Alibaba's perspective is China's newly enacted laws and regulations regarding its monopolistic behaviour," said Yogesh Khairajani, a global market strategist at Century Financial.

"The country's policymakers are concerned and view the company as too big as well as risky. Only clarity regarding the policy can remove the current bearishness in the stock." But he added that Alibaba "is still

the best play on Chinese consumers" and will always be on investors' radar once there is more certainty regarding the country's policy.

Even though investors are shying away from Alibaba's stock, that could change as the company's valuations are cheap when compared to its Western peers, Mr Khairajani said. "And it is generally expected that China will not damage the fortunes of its biggest corporate success story."

Alibaba and payments giant Ant Group are facing antitrust scrutiny and questions over risks to financial stability. The unravelling of Ant's \$35 billion IPO in November set in motion a string of decrees regulating China's technology sector. Stephen Innes, chief global market strategist at Axi, said Mr Ma was instructed to remain in China during the probe by mainland regulators.

"This continues to weigh on Alibaba stocks as Chinese regulators are concerned about technology companies getting too powerful and venturing into financial services, where their monopolistic tendencies can squeeze out banks from a lower fees perspective. Banks do not possess the means or wherewithal to complete with tech sector behemoths."

In a rare move, Mr Ma in October said China's financial system was "stifling" tech innovation. He has since edged away from the public limelight since the Ant IPO collapsed. "When the chief executive becomes AWOL, investors do not think that is a good sign," said Naeem Aslam, chief market analyst at Avatrade.

"In these difficult times, we need assurance from the chief executive that he has what it takes to pull the company out of this mess and steer the business in the right direction. The fact that we have not heard anything from Jack Ma isn't helping the stock or providing any assurance to investors."

Investors are also worried that the anti-trust scrutiny and tighter regulations will spread beyond Mr Ma's internet empire to other powerful tech companies such as Tencent Holdings and JD.com. "Investors are shying away from large China tech in favour of smaller tech [firms] that might sneak in through the side door providing tech services that the large tech might not be allowed to complete," added Mr Innes.

Regulators have asked FinTech giant Ant Group to revamp its business model and return to its original business as a payment services provider. The group is reportedly planning to form a holding company to house its wealth management, consumer lending, insurance and payments services as well as MYbank. Under such a structure, Ant's businesses would likely be subject to more capital restrictions.

## Nigerian tycoon Tony Elumelu's start-up capital competition starts

#### **By Guardian Reporter**

ENTREPRENEURS with scalable business ideas have another chance to apply for mentorship and seed capital from the Tony Elumelu Foundation (TEF).

Run by Nigerian philanthropist Tony Elumelu, the foundation has opened its application portal for African entrepreneurs for three-months ending March 31. This year the TEF is targeting over 3,000 instead of the usual 1,000 small and medium enterprises as part of its covid-19 recovery plan.

"We know that with TEF's tried and tested Programme, we can execute the largest Covid-19 economic recovery plan for African SMEs and break the cycle of poverty in Africa," said TEF chief executive Ifeyinwa Ugochukwu in a statement.

Selected entrepreneurs get a 12-week online training on managing enterprises, mentorship on transforming business at its early stages, a seed capital of Sh500,000 (\$5,000) and networking opportunities. This is the seventh edition of the TEF's 10-year \$100 million commitment to identify, train, mentor and fund 10,000 African entrepreneurs by 2024.

Normally, the TEF selects 1,000 entrepreneurs based on idea viability, including marketability, entrepreneur's financial understanding as well as leadership and demonstrable entrepreneurial skills. This year, the Foundation will open applications to an additional 2,400 young entrepreneurs which will be done in collaboration with global partners.

Applicants must be above 18 years, operate businesses between idea stage and three years, their enterprises be for profit and based in Africa. Since its unveiling in 2015, the TEF has supported hundreds of entrepreneurs in Kenya who are among thousands of alumni already growing their businesses and improving lives.

The Programme is the \$100 million commitment by African investor and philanthropist, Tony O. Elumelu to empower 10,000 entrepreneurs in 10 years, with the goal of creating millions of jobs and new revenue on the continent.

It seeks to implement Mr Elumelu's Africapitalism philosophy, which positions the private sector as the catalyst for African economic transformation, and an investment approach that values the

Safaricom is among a group of lenders and IT companies that have been licensed to offer cashless payments in Public Service Vehicles (PSVs), setting the stage for the ban of use of cash in public transport.

In a notice, National Safety and Transport Authority (NTSA) said the licensed 29 companies will offer a platform for cashless fare payment service. This was in response to a June 16, 2020 tender where NTSA sought tech companies to install mobile software and web applications

for the nearly 2 00,000 matatus in the country. The digital fare collection system will also have the technical capability to contact trace passengers in the fight against the coronavirus disease.

Once the system is in place, all passengers will be required to pay their fares via mobile money platforms, giving the government access to their identities and personal contact information that is needed to combat the Covid-19 pandemic, which has disrupted lives worldwide. Other top firms permitted to offer the cashless

fare system are Craft Silicon (behind taxi-hailing App-Little), JamboPay, Cellullant (a pan-African payments gateway firm), KCB Bank Kenya, and CBA Bank now NCBA.

An earlier cashless fare payment platform fronted by the government, and which was launched in November 2014, flopped following strong opposition from matatu operators who felt that it was a ploy to monitor their daily earnings for taxation measures. The digital payment system required passengers to get prepaid cards or use mobile money

for payment of fares in PSVs.

At the time, the stated interest of the government was to eliminate criminal cartels that had infiltrated the PSV industry and to provide the taxman with a platform to track incomes in a sector that grosses more than Sh420 billion annually. The digital fare collection system was also expected to curb employee fraud by matatu crew because it would have allowed owners to track payments in real time.

The money collected was to be remitted in a bank account, making it easier for

vehicle owners to access loans. Technology firms and banks had come up with products to support the PSV e-ticketing system with their eyes on the one percent processing fee, currently estimated at Sh4 billion annually.

The firms included Safaricom, which declared a "partnership" interest in My 1963 commuter card with Mwakio Ngale, a Nairobi-based techie through his IT firm Fibre Spac. Now, another pressing need for the cashless payment platform has emerged in the form of contacttracing amid the Covid-19

Botswana sets currency to lose value faster in 2021

Botswana has set its pula currency to lose value at a faster rate this year, a senior official said Monday, as it seeks to boost export competitiveness after the COVID-19 pandemic has had a deep impact on

its economy. In the biggest shift for many years, the government has set the pula to lose 2.87% this year from 1.51% in 2020.

## Google employees vote to form trade union, in 'historic' move

#### **SAN FRANCISCO**

Workers at Google and other Alphabet-owned companies voted to form a union aligned to the Communications Workers of America to protect workers' rights and "promote solidarity, democracy and social and economic justice."

The new union, named Alphabet Workers Union, will be open to all employees and contractors, including temporary employees, at any Alphabet company. It will have dues-paying members, an elected board of directors and paid organising staff, the workers' union said on Monday.

"This is historic-the first union at a major tech company by and for all tech workers," said Dylan Baker, a software engineer at the company. "We will elect representatives, we will make decisions democratically, we will pay dues, and we will hire skilled organisers to ensure all workers at Google know they can work with us if they actually want to see their company reflect their values."

Alphabet, which has more than 120,000 workers, is responsible for vast parts of the internet, including the Search, Maps and Gmail tools owned by Google and the Android mobile operating platform used by millions of people around the world. Other subsidiaries include the Waymo self-driving platform, Verily, Fitbit, and Wing.

"I joined because Alphabet wields disproportionate power ... and is not incentivised to use it in the most responsible way," Greg Google, said. "I want to see Alpha-

#### bet act as ethically as possible. The union offers a way to influence Alphabet's culture in the name of ethics," he said.

The company has witnessed a number of skirmishes between employees and management in recent months. Many employees have expressed discontent over the hefty package Alphabet's chief executive Sundar Pichai takes home.

Last month, the company fired leading artificial intelligence researcher Dr Timnit Gebru, who had raised criticisms about structural bias in some of the language used to develop AI. Her dismissal caused outrage among thousands of employees. In January last year, a group of nearly 2,300 cafeteria employees working across Google offices in the San Francisco Bay area unionised after complaining they were underpaid and overworked.

"We've always worked hard to create a supportive and rewarding workplace for our workforce," Kara Silverstein, director of people operations at Google, said in a statement. "Of course, our employees have protected labour rights that we support. But as we've always done, we will continue engaging directly with all our employees," she added.

The unionisation of its workforce comes at a difficult time in the history of the 22-year-old technology company, which has also become embroiled in several anti-trust probes initiated by both US and foreign regulators. ## EU delays decision on Moderna vaccine as blame game heats up

#### AMSTERDAM

The EU's drugs watchdog held off authorising Moderna's coronavirus jab on Monday despite bringing forward a special meeting, as criticism mounts of the bloc's slow vaccine roll-out. The Amsterdam-based European Medicines Agency (EMA) said it would resume talks on Wednesday on whether to give the green light to what would be the EU's second vaccine.

Under pressure from EU nations to speed up, the regulator had earlier fast-tracked the meeting to decide on approval from January 12 to Wednesday, and then again to Monday. Despite launching its vaccination campaign with the Pfizer-BioNTech vaccine, on December 27, the EU's progress has been much slower than in the United States, Britain or Israel.

"EMA's committee for human medicines discussion on Covid-19 vaccine (by) Moderna has not concluded today. It will continue on Wednesday," the EMA said on Twitter. "No further communication will be issued today by EMA." The European Commission had earlier defended the bloc against criticisms of its slow roll-out, and said its plans would get the EU past "bumps on the road."

"It's obvious that such a complex endeavour is always going to bring with it difficulties," spokesman Eric Mamer told journalists. The Pfizer-BioNTech vaccine - developed in Germany - is the only one currently authorised for use in the European Union since its fast-track authorisation by the EMA on December 21.



Flows may continue through this year as investors take comfort from supportive monetary and fiscal measures as well as the global vaccination drive, according to Piotr Matys, a strategist at Rabobank in London. The rally "reflects a sharp acceleration in capital inflows into emerging markets," he said. This "won't set the tone, which is already positive."

China 'standout' China's yuan is likely to be a "standout" beneficiary from a weaker dollar thanks to "yield erosion and twin deficits" that are weighing on the greenback, said Patrick Bennett, strategist at Canadian Imperial Bank of Commerce in Hong Kong. The onshore yuan rose as much as 1.1% on Monday and breached the 6.5 level for the first time since June 2018. "The markets are following the 2021 buy-everything play book to the tee," said Stephen Innes, a strategist at Axicorp.

#### WASHINGTON

POLITICAL jitters are creeping up in the United States ahead of two highstake Senate runoffs in the southeastern state of Georgia, the races that will decide which party controls the upper chamber.

US President-elect Joe Biden and sitting President Donald Trump respectively traveled to Georgia on Monday to rally support for their own party's candidates for the Senate seats.

One of the contests pits Senator David Perdue, a 70-year-old Republican incumbent seeking a second term, against his Democratic challenger Jon Ossoff, a 33-year-old media professional, in a regular election.

In the other race, a special election, Republican Senator Kelly Loeffler, 50, is squaring off against Democrat Raphael Warnock, a 51-year-old pastor at a church in Atlanta, capital of Georgia. Loeffler was appointed to the seat in 2019 after her predecessor retired because of health reasons.

The runoffs, scheduled to take place on Tuesday, will come two months after the candidates' first matchups as part of the elections on Nov 3, 2020, during which neither of them reached the 50-percent threshold for an outright victory, triggering a second round of voting as required by a state dition" from the COVID-19 pandemic gia, had been defeated, rejected, or

election law in Georgia.

The Senate runoffs, which have together cost nearly US\$500 million just in the past two months for advertising, are extremely tight. Ossoff is only 1 percentage point ahead of Perdue, while Warnock has a 1.3 percentagepoint advantage over Loeffler, according to the RealClearPolitics polling average.

Democrats need to win both seats to split control of the Senate 50-50. Vice President-elect Kamala Harris will be the tie-breaking vote once she is sworn into office. For Republicans, they need to win at least one seat to maintain their majority.

"The Georgia Senate runoffs are absolutely crucial to Biden's agenda," Darrell West, vice president and director of Governance Studies at Washington, DC-based think tank Brookings Institution, told Xinhua. "Because they determine which party controls the committees, schedules, and amending process."

If Democrats were in the majority, it would be easier to confirm Biden's Cabinet picks and judicial appointments. If Republicans hold onto the seat advantage, they would be able to largely thwart much of the Democrat's agenda.

A group of Republicans have said they will contest the Electoral College results on that day, a move that has driven a wedge into the party in both chambers of Congress, but their efforts are unlikely to overturn Biden's victory, according to US election pundits and media networks.

Trump hasn't acknowledged defeat and is still pushing for claims of massive election fraud, although dozens of attempts by his legal team and allies to challenge the results in some key states, including Geor-

#### UN holds 1st meet with advisers to Libyan Political Dialogue Forum

A UN representative on Monday held a virtual meeting with the newly established Advisory Committee of the Libyan Political Dialogue Forum (LPDF) to discuss the latter's tasks



and other agendas, the UN Support Mission in Libyan (UN-SMIL) said in a statement.

Stephanie Williams, acting special representative of the UN Secretary-General in Libya, talked with the committee's officials over its mandate, tasks, expected outcomes, and the timeframe for its work, said the UN mission.

"In her opening remarks, Williams (pictured) reiterated that the committee will play an advisory role and will work for a period of two weeks to produce concrete recommendations to address differences that have emerged over the selection mechanism and the nomination procedures of the executive authority, and to build consensus among the LPDF members," UNSMIL said.

Williams urged the participants to seize this opportunity to expedite the establishment of a unified executive authority, and to work together in order to fulfill the aspirations of the Libvan people.

UNSMIL requested the members of the Advisory Committee to submit written proposals to be discussed in the next meeting scheduled to be held virtually on Wednesday.

UNSMIL on Saturday announced the establishment of the Advisory Committee, whose mandate "will be strictly timebound and its main mission shall be to discuss outstanding issues related to the selection of a unified executive and to put forward concrete and practical recommendations upon which the plenary shall decide."

Moreover, the LPDF's Legal Committee (LC) held its third virtual session on Sunday, where the members shared proposals for constitutional arrangements for elections, the UN mission said.

The proposals presented a range of options to facilitate the implementation of the Roadmap agreed upon by the LPDF in November 2020.

"UNSMIL's Electoral Team provided a briefing highlighting the necessary sequencing and time-bound milestones related to constitutional arrangements for holding the national elections on the agreed-upon date of 24 December 2021. The LC agreed to resume its discussions at the end of this week," it added.

The Legal Committee is tasked with following up on the work of the House of Representatives and the High Council of State in relation to constitutional arrangements, and to provide the two institutions with recommendations in an effort to reach an agreement on a constitutional basis leading to holding the national elections on Dec 24, 2021.

During the convocation of the dialogue forum held on Nov 7-15, 2020 in Tunisia's capital Tunis, 75 Libyans representing the social and political spectrum of the Libyan society discussed a political roadmap to achieve lasting peace in the war-torn Libya.

The participants agreed to hold general elections in Libya on Dec 24, 2021. They also voted on a mechanism to select a unified executive authority of the country. Xinhua



IRAN and Russia are preparing a personal meeting on cooperation in producing the vaccine against the novel coronavirus, Iranian Ambassador to Russia Kazem Jalali said in an interview with Izvestia newspaper published on Sunday.

"The phone conversations in April-October 2020 between the presidents of Iran and Russia underlined Iran's interest in cooperation with Russia in the field of producing the coronavirus vaccine and exchanging the experience.

Currently, Russian documents on the vaccines are being studied. It has been decided that soon a personal meeting will take place," the envoy said.

The ambassador also noted that although Tehran had declared the launch of the first phase of testing the first Iranian vaccine on humans, the republic was still considering all vaccines being produced, including the Russian.

On December 22, Deputy Speaker of Iran's Parliament (Majlis) Amir-Hossein Ghazizadeh-Hashemi told the Russian media that Iran and Russia were in talks on creating a joint venture on producing the coronavirus vaccine.

To date, two domestic vaccines against the coronavirus have been registered in Russia: a vaccine developed by the Gamaleya National Research Center for Epidemiology and Microbiology of the Russian Healthcare Ministry and a vaccine by the Vector State Research Center of Virology and Biotechnology of the Federal Service for Surveillance on Consumer Rights Protection and Human Wellbeing.

### **Touadera wins absolute majority in CAR presidential election**

#### BANGUI

FAUSTIN-Archange Touadera, outgoing president of the Central African Republic (CAR), has won the absolute majority in the first round of the presidential election, according to provisional results announced on Monday by the National Elections Authority (ANE), the electoral body of the CAR.

According to the ANE, Touadera received 346,687 votes, or 53.92 percent of all

votes cast. The voter turnout was 76.31 percent. The Constitutional Court will proclaim the final results by Jan 19.

Touadera's main competitor, former prime minister Anicet-Georges Dologuele, came in second with 21.01 percent of all votes cast, according to the ANE.

On Dec 29, the Democratic Opposition Coalition 2020 (COD-2020), a platform of opposition parties of the CAR, called for the cancellation and rerun of presidential and leg-stakeholders of the nation



islative elections.

COD-2020 cited low voter turnout in provinces under threat from armed rebels and electoral irregularities linked to insecurity as the reasons that prompted it to call for a "concertation of the active

before holding the new elections.'

Since mid-December, major armed groups of the CAR have forged to launch an offensive against the government. The new alliance, known as the Coalition of Patriots for Change, multiplied the attacks and vowed to "march on Bangui", the capital.

The CAR government accused Francois Bozize, a former head of state whose presidential candidature was invalidated, of having organ-

ized the attacks with the rebels for "an attempted coup." On Monday afternoon, be-

fore the provisional results were announced by the ANE, the Bangui prosecutor's office declared that it had opened a judicial investigation against Bozize on his support for the rebellion.

The polls on Dec 27 took place in relative calm with the presence of the UN force (MI-NUSCA) across the country, but the rebel offensive contin-Xinhua ued.

China evaluating number of high-risk workers in need of COVID-19 vaccine

CHINA is calculating how many people working in high-risk professions, including cold-chain, medical and port workers, will need to receive COVID-19 vaccines, health officials said recently.

Experts said the mass vaccination of ordinary people is likely to be rolled out in the second quarter of 2021, when vaccines are officially allowed to enter the market.

Previously, the Global Time learned that China is planning to vaccinate 50 million people in high-risk groups before Chinese New Year which falls on February 12. That number was not confirmed by officials at the conference.

Tao Lina, a Shanghai-based expert

on vaccines and a former Shanghai disease prevention and control employee, told the Global Times on Monday that vaccination of some 50 million people in high-risk professions before Spring Festival could prevent a potential infection rise caused by the travel rush.

After the first shot, people could produce a low level of antibodies, but after the second shot, the rate of antibodies is likely to reach 95 percent in about a week, Tao said, adding that "the generated antibodies of those 50 million people will return us to a safe Spring Festival."

The Spring Festival travel rush is also known as the world's biggest

2.97 billion trips were made in 2018 Spring Festival travel rush and about 2.98 billion in 2019. The Spring Festival travel rush will start on January 28, 2021 and end on March 8, authorities said.

But Tao said vaccines against COV-ID-19 will not be open to the general public until vaccines are officially allowed to enter the market.

Also, after the first 50 million people get vaccinated, the risks of an epidemic will be largely reduced, which reduces the urgency of vaccinating everyone, the expert said.

Only when 70 percent of the population is vaccinated will China reach herd immunity against the annual human migration. About novel coronavirus, Chinese officials the vaccines.

Wang Qinghua, chief expert from the National Immunization Program of Chinese Center for Disease Control and Prevention said that building herd immunity requires the majority of people to get vaccinated.

Wang said receiving a vaccination is everyone's right, and it is also everyone's responsibility in order to contain the coronavirus.

Tao said this shows China is determined to reinforce its hard-won fight to contain the virus, as it moves toward mass vaccination.

Tao said Chinese public have confidence in their government and domestic vaccines.

Zheng Zhongwei, director of the Development Center for Medical Science and Technology of the National Health Commission (NHC) dismissed concerns on the safety of Chinese vaccines on Monday.

Nearly 1 million people have been vaccinated voluntarily. China has carried out phase I, II and III clinical trials, which have demonstrated that Chinese vaccines are safe. "There are some minor adverse reactions, but no serious ones," Zheng said.

China is ready for mass production of COVID-19 vaccines and will proceed with the official approval process as soon as possible after the release of phase-III interim clinical data, health officials said at the press

conference.

In the second stage, the population to be vaccinated will expand to groups including the elderly and people with other diseases. "Our goal is to strive to establish the protection of herd immunity, so that the epidemic can be controlled more effectively," Zeng Yixin, an official from National Health Commission, said on Saturday.

The vaccination of key populations has already begun. In addition, health officials stressed that it is still necessary to take personal precautions, as the protection rate of vaccines is not 100 percent.

London court rules against Julian Assange's extradition to US over risk to his life and health

#### LONDON

THE London court has ruled that WikiLeaks founder Julian Assange cannot be extradited to the United States over a significant risk to his life and health, Judge of the Westminster Magistrates' Court Vanessa Baraitser announced on Monday.

The judge, who delivered the ruling at London's Central Criminal Court, known as the Old Bailey, acknowledged that Assange had autism spectrum disorder and suffered from depression and could commit suicide. In addition, Assange's condition could deteriorate in solitary confinement in the United States.

Assange (pictured) also is an intelligent individual who could escape any measures aimed at preventing suicide attempts.

So, the risk to his life was a ground for refusing to extradite him. "In these



harsh conditions, Mr. Assange's mental health would deteriorate causing him to commit suicide with the "single minded determination" of his autism spectrum disorder," the Judge said in the ruling.

"I find that the mental condition of Mr. Assange is such that it would be oppressive to extradite him to the United States of America.".



The following is a transcript of that interview on the international situation and China's diplomacy in 2020.

Question: Security in places like the Middle East and Afghanistan is still a cause for concern to the international community. The future of the Joint Comprehensive Plan of Action (JCPOA) remains uncertain. Would you elaborate on the role China has played in settling international hotspots and the efforts China has made in promoting peace and stability in relevant regions?

Wang Yi: Peace is an eternal aspiration of humankind. As a permanent member of the Security Council and a responsible major country, China has been exploring a distinctive Chinese way of resolving hotspot issues. We follow a vision of common, comprehensive, cooperative and sustainable security for the world. We maintain that regional disputes should be addressed through dialogue and consultation. We uphold non-interference in internal affairs, which is a basic norm governing international relations. We speak for justice from an objective and sensible perspective. We seek solutions that suit the regional reality and accommodate the interests of all parties. We have done what we can to safeguard peace and tranquility in the world.

Over the past year, while firmly upholding the JCPOA, we have joined the international community in opposing moves inconsistent with Security Council resolutions. We have put forward a constructive proposal of building a new platform for multilateral dialogue for the Gulf region. We have given steadfast support to Palestine's just cause and firmly upheld the right direction of the "two-state solution". We have continued to advocate the phased and synchronized approach to achieve the two goals of denuclearization of the Korean Peninsula and establishment of a peace mechanism. We have facilitated consensus-building on Afghanistan's national reconciliation and that among regional players, and supported intra-Afghan talks. We have mediated between Bangladesh and Myanmar in addressing their disagreements, and assisted in maintaining overall stability in northern Myanmar. Having been torn by wars and conflicts in the past, we Chinese know too well the scourge of turmoil and the value of peace. We hope that hotspot issues will be made to cool down and that peace talks will bring true peace. As for major countries that play a key role in various hotspot issues, we hope that instead of anyone's own selfish interests, they can bear in mind the real interests of regional countries and the well-being of all people in the world, and shoulder due responsibilities and play a constructive role in settling disputes.

Committee and with the full support of the Chinese people, we have worked all out to fulfill these responsibilities in an open and thorough way.

China's diplomacy is rooted in the 5,000-year Chinese civilization, and follows the proud tradition of independence and self-perfection fostered since the founding of the People's Republic. We pursue the path of peaceful development and an independent foreign policy of peace. We advocate international law and basic norms of international relations in the conduct of state-to-state exchanges. We uphold equity, justice and other shared values of humanity in handling international affairs. China's diplomacy has acquired a distinct Chinese feature, style and vision.

We accord friends with hospitality and partners with cooperation. But we also have to stand our ground when dealing with those who are not so friendly. We are happy to take well-intentioned criticism and go with helpful suggestions. But we have to respond to defamations and attacks. And more important, we are obliged to speak up for justice when faced with power politics and bullying This is the responsibility of China's diplomacy and the national character of the Chinese people.

#### Question: How has COVID-19 affected Belt and Road cooperation? What will China do to restart the cooperation and take it forward?

**Wang Yi:** COVID-19 has dealt a heavy blow to the world economy and brought challenges to Belt and Road cooperation. That said, instead of stalling altogether, cooperation under the Belt and Road Initiative (BRI) has bucked the

countries along the Belt and Road reached 13 billion US dollars, an increase of nearly 30% year-on-year. Most BRI projects have continued uninterrupted and without layoffs, and a number of new projects have been launched as scheduled. This has brought much-needed warmth to this harsh winter in the world economy and contributed to the efforts of partner countries in fighting the coronavirus, stabilizing the economy, and protecting livelihoods.

Facts abound to show the strong vitality of the BRI. The pandemic has not shaken the commitment of participating countries. Instead, it has highlighted the role of Belt and Road cooperation in powering global development in a post-COVID era.

China is fostering a new development paradigm with domestic circulation as the mainstay and domestic and international circulations reinforcing each other. These efforts will not only boost the high-quality development of the Chinese economy but also provide stronger impetus, more opportunities and more effective pathways for Belt and Road cooperation.

China will work with all parties to deepen the synergy between the BRI and the development strategies of other countries, keeping in mind their needs for COVID-19 response and economic recovery. We believe that by bolstering connectivity and economic reopening and by tapping into the potential of new growth drivers such as health care, digital economy and green development, we will be able to achieve higher-quality Belt and Road cooperation.

We will actively facilitate mutual understanding between countries. We will better communicate to the world the CPC's strong record of governance, our people's extraordinary journey toward the Chinese dream and China's commitment to peaceful development. We call on all countries to overcome differences, seek common development and embrace exchanges, mutual learning and harmony between civilizations. The latest move came amid increasing tension between Washington and Tehran. The Pentagon said late Sunday that US aircraft carrier USS Nimitz would remain in the Middle East waters due to "threats from Iran," reversing a previous decision to order the warship back home.

Meanwhile, the Iranian Foreign Ministry said on Monday that Iran has never negotiated its own defense capabilities and will never do so, semiofficial news agency Fars reported.

As for Iran's defense capabilities, there has never been and will never be any negotiation, Saeed Khatibzadeh, the ministry spokesman, said at a weekly press briefing held in the capital Tehran.

The spokesman's statement came a day after Jake Sullivan, national security advisor-designate for US President-elect Joe Biden, said Iran's missile program "has to be on the table" in follow-on negotiations, provided Washington re-enters the 2015 nuclear agreement.

The question of Iran's missiles is mentioned in the JCPOA as well as in the UN Security Council Resolution 2231 endorsing the agreement, said Khatibzadeh, commenting on Sullivan's remarks.

The US government actually "knows" that Iran's nuclear activities are of peaceful nature, the spokesman noted.

### China-Europe freight trains make institutional innovation to improve efficiency

CHINA-EUROPE freight trains departing Chengdu, capital of southwest China's Sichuan province, delivered surprisingly remarkable performance despite the COVID-19 pandemic. Over 2,000 trips were made in the January-November period this year, up 55 percent from a year ago.

The point-to-point transport offered by the freight services were a major reason for the rocketing figure, said Yang Qiling, general manager of the Chengdu International Railway Port Investment & De-

A slew of favorable policies also contributed to the growth, Yang explained, citing the Chengdu International

Railway Port, which was approved to be one of the first land port logistics hubs in China in September last year, as well as an economic development zone established in the port August this year. Thanks to the favorable policies, the port enjoys gradually maturing logistics, and a number of foreign trade enterprises and platforms have been established around it.

Institutional innovation leads to constantly improving customs clearance efficiency and service quality. Home appliance manufacturer Konka started building assembly lines for TVs in Chengdu's Qingbaijiang district last December, aiming to export its products to Europe. Zhang Wenwu, general manager of the corporation's manufacturing department once worried about the shipping of the products, as the TVs are expected to deliver to a wide range of destinations but in small quantities.

It was the customized transportation services launched by the Chengdu International Railway Port that eased Zhang's concerns. The services are tailored for clients who book only a single or a few containers of a train, so that Konka's products can be sent to as many European countries as possible. At present, there are multiple routes being opened, and they run stably in two-way directions.

Since 2017, the Chengdu International Railway Port has launched a "single waybill" mechanism for multimodal transport, so as to relieve foreign trade enterprises' burden

of settlement and financing when they ship cargos to other countries on rail tracks.

In the past, trade settlement and financing couldn't be finished with waybills as different countries have different rules on rail transport, and waybills were not able to prove the property right of the cargos. Aiming to reform the standards, operation rules, cargo safety and financial settlement, the "single waybill" mechanism has largely improved trade facilitation.

The first train operated un-

der the mechanism departed Tilburg in the Netherlands for Chengdu in April 2017.

Not long ago, a fully loaded freight train arrived at the Chengdu International Railway Port from Russia. Zhong Tao, who received orders from the train, told People's Daily that small and micro enterprises, which are vulnerable capital-wise, had big troubles purchasing products from overseas, as rail waybills were not able to function when it came to financing.



### Carabao Cup can give Manchester United springboard to success

MANCHESTER United have spent the best part of a decade in Manchester City's shadow. The 2011 FA Cup was the first of 11 major trophies for the city's blue side after a 35-year wait for silverware, and it can all be traced back to a win against Sir Alex Ferguson's side in that season's semifinals.

As Ole Gunnar Solskjaer (pictured) prepares his team to face Pep Guardiola's side in Wednesday's Carabao Cup semifinal, could success offer him the chance to begin a new dynasty at Old Trafford?

The 2011 derby win at Wembley was the first time City had beaten United on the way to success since the 1970s. Yaya Toure's goal in a 1-0 victory laid the platform not only for victory against Stoke City in the final, but a Premier League title success the following season and a trophy-winning mentality that has continued, pretty much unabated, to this day.

It was the moment that Roberto Mancini and Co. realised they could dislodge United from the summit of English football; City have since won four league titles compared to United's two (the last coming in 2013) and finished above their rivals in each of the last seven campaigns.

## How does Lampard compare to Chelsea managers under Abramovich?

T's fair to say that pressure -- if only external, for the time being -- is beginning to mount on Frank Lampard as his Chelsea side continue to falter into the New Year. The Blues have endured a rough set of results throughout December and early January, having won just once in

their last seven outings -- a dreary run that culminated in Sunday's 3-1 home defeat against Man City. Lampard has the

club's worst points-pergame record in the Premier League under club owner Roman Abramovich and the Russian billionaire is not inclined toward mercy when it comes to underperforming managers, having hired and fired 14 different coaches since his arrival in 2003.

Not counting interim appointments Ray Wilkins or Steve Holland, here's a list of those who have come and gone in the years before Lampard, their respective records, and what ultimately signalled their managerial demise at Stamford Bridge.

#### 1. Claudio Ranieri (September 2000 **May 2004**)

#### **Games: 199** Win ratio: 54%

Ranieri was already in charge at Chelsea when Abramovich bought the club in the summer of 2003. He lasted just one further season, during which the "Tinkerman" secured the club's highest-ever Premier League finish (second) only to be relieved of his duties a few days later.

sixth manager hired by Abramovich in his first six years at Chelsea.

The Russian owner was intent on ushering in a new era of stability and in fairness, Ancelotti's tenure was fairly serene for the first year, during which he won a league and cup double. However, it came to an abrupt end in the summer of 2011 after the Italian finished his second season without a trophy -- the club's first without silverware for three years -- despite Abramovich bankrolling a huge £50m move for Fernando Torres in the

short stint. Nine months later he was gone, with Abramovich pulling the plug after watching AVB flounder in a 1-0 defeat against West Brom which extended his wretched run to just three wins in 12 league games.

#### 8. Roberto Di Matteo (March 2012 - November 2012) Games: 42

#### Win ratio: 57%

Already a cult hero at Chelsea, Di Matteo was warmly greeted when he initially stepped up from assistant coach to assume the role of interim head coach in the wake of Villas-Boas' departure.

He then somehow managed to win both the Champions League and the FA Cup within his first 21 games in charge before landing a new two-year full-time contract and getting himself sacked for a poor streak of performances, all inside a whirlwind eightmonth period.

11. Guus Hiddink (December 2015 - May 2016)Games: 27 Win ratio: 37%

Bridge, thrusting Chelsea back to the top of the league by winning the 2016-17 title in dominant fashion and setting a new record for most wins in a single season (30 wins from 38 games). He then followed up by winning the FA Cup in the 2017-18 season before it all began falling apart shortly thereafter. Indeed, the Blues finished fifth in the league, thus missing out on vital Champions League qualification.

Conte was sacked and replaced, but not before reportedly costing the club close to £30m in legal fees and compensation as the result of legal wranglings that rumbled on for months after his bitter departure.

#### 13. Maurizio Sarri (July 2018 - June 2019) Games: 63

#### Win ratio: 62%

With the Conte fallout continuing in the background, Sarri was selected as the man to replace his fellow countryman having excelled with Napoli in his homeland.

Unfortunately, the chain-smoking Sarri wasn't able to adapt easily and while results on the pitch were actually quite good, the Italian had issues communicating fluently and quickly became an unpopular figure with fans.

He won the Europa League and finished third in the Premier League in his first season in charge, but that didn't stop him leaving for Juventus after less than a year in England -- 337 days, to be precise.

a force to be reckoned with, having bounced back from low moments in the past two years -- beyond including those semifinal defeats, there was an unconvincing Champions League campaign and October's 6-1 defeat at home to Tottenham -- to sit second in the Premier League and with genuine hopes of challenging for the title.

Bruno Fernandes has become a star since arriving from Sporting Lisbon 12 months ago, Marcus Rashford continues to grow into one of Europe's top strikers, and throughout the team consistency is beginning to develop and belief is growing.

But progress has to deliver a tangible reward at some point and Solskjaer's United now need to stop knocking on the door and actually find a way of walking through it.

Last season, United were beaten at the final-four stage by City in the Carabao Cup, Chelsea in the FA Cup and Sevilla in the Europa League. Each painful experience was a reminder of how the club has fallen in recent years and a contrast to Ferguson guiding United to victory in each of his first 19 domestic cup semifinals, before the run was ended by Jose Mourinho's Chelsea in the 2005 League Cup.

City also had their near misses before finding the winning formula, though. Their 2010 League Cup semifinal defeat against United was regarded by Ferguson as a crucial win which underlined his team's pre-eminence, but it only served to motivate City to turn the tables.

United must use last season's disappointment to fuel their determination, but Wednesday is about more than getting to a final, it is also about beating City in a win-or-bust situation.

Solskjaer has built an impressive record against Guardiola, with three wins, a draw and a defeat in their last five meetings, but that loss was a crucial 3-1 reverse in last season's Carabao Cup semifinal first leg, which gave City the cushion to withstand a 1-0 defeat in the return fixture.

United can rightly claim to have restored balance to the head-to-head rivalry on the pitch against City, but when it comes to winning things, six major trophies have been delivered to the Etihad Stadium since United last won silverware with the Europa League in 2017.

City have shown how one big win can trigger a run of success. Now it's United's turn to do the same by proving they are winners. Wednesday's clash is the perfect opportunity to take the next step.




