MCT alerts on AI 'fake news' Mukajanga quits after 15 years

THE Media Council of Tanzania (MCT) has expressed concern over the advent of artificial intelligence in local media activities and the danger it portends.

Kajubi Mukajanga (pictured), the outgoing executive secretary, cautioned here yesterday at an occasion to mark the 'International Day for Universal Access to Information' that digital technology can be deployed to manipulate images, sound and videos to create false reports and fabricated events.

He said that it will be difficult for ordinary people to distinguish fact from fiction once artificial intelligence is deployed to produce genuinely looking reports, videos, images and even mimicking a particular person's voice.

The event was conducted to examine the importance of online space for access to information, where the MCT administrator

PRIME Minister Kassim Majaliwa has asked clerics of various denominations to enhance collaboration with the government in the fight against drug trafficking and intoxicant abuse.

Standing in for President Samia Suluhu Hassan at the Maulid Baraza at the Jakaya Kikwete Conference Hall in the national capital, Dodoma the premier emphasized on the need to cooperate against drug trafficking.

The use of illicit drugs has affected sections of the youth who anchor the country's expectations in innovation, initiative and hard work, entailing economic, health and environmental problems.

He said that using illicit drugs similarly affects the ability of the user to think, urging religious leaders to ensure that they keep objecting to the decay of moral observance in the society.

Religious adherents should be urged to participate in income earning activities, a major requirement for the public to be able to safeguard the country's peace, the foremost need for development.

Living in peace and praying for our nation and its leaders was vital, he said, underlining that the government will take stern measures upon those found to be engaged in acts of corruption, embezzlement of public funds and abuse of office. Alhaj Nuhu Jabir Mruma, the Muslim Council of Tanzania secretary general, expressed the council's satisfaction with President Samia's performance in economic, political and social sectors, including uplifting the country's democratic space. He appealed to the government to expand the civic education scope by collaborating with religious leaders to enable Tanzanians understanding related to elections to fully participate in the civic elections next year and the General Election in 2025.


Marking the international day went in synchrony with the MCT annual general meeting taking place for two days, with senior journalists getting to discuss, among other things, the current situation in the media industry.

Presenting the council's annual report, he stated that local journalists still face cumbersome impediments in seeking information especially from public offices, from communication officers, heads of institutions or political leaders.

He hailed Zanzibar President Dr Hussein Ali Mwinyi for organizing periodical meetings with members of the press at the Zanzibar State House, while expressing displeasure with the Electronic and Postal Communications Act for controls placed over online content.

The Cybercrime Act similarly inhibits the freedom of expression in the country's media landscape, as people are required to pay 500,000/- to run social media platforms providing YouTube accounts, blogs or

African cities exchange green energy notes with Chinese city

AFRICAN countries are keen on cooperating with China in exploring paths to green and low carbon energy sources, with Kenya showcasing its more than 80 per cent renewable sourcing so far.

This intention was expressed in the Chinese city of Shandong at the 2023 World Cities Forum and regional leaders' summit under the theme 'creating a green vision together for a better home.²

Benjamin Cheboi, the Baringo County governor in Kenya said keynote speech followed by an interactive discussion on the country's long-standing science and technology links with China.

TANZANIA'S manufacturers and exporters have been tasked to increase the use of the African Continental Free Trade Area (AfCFTA) with its unexplored opportunities.

Mwanahamisi Hussein (pictured), the Tanzania Chamber of Commerce, Industry and Agriculture (TCCIA) acting managing director, issued this appeal in Dar es Salaam yesterday at a training session for manufacturers and traders it organised.

The trade bloc will help Tanzanian firms with market outlets, increase foreign earnings and build the wider economy, noting that the continental trade bloc offers opportunities that Tanzanians can't just ignore.

The training sessions are meant to expose local manufacturers and traders to the benefits and opportunities found in AfCFTA, especially for wider markets for Tanzanian products, where trading is conducted without tariffs, she

Chuanshan, a Chinese company licensed by the Kenyan government to harness diatomite resources in Tiaty Sub County in Baringo.

He said Kenya is committed to deepening and expanding cooperation in that field, creating a sustainable green economy, noting that more companies are welcome to partner with the various counties in using abundant renewable resources to establish green industries and solar powered irrigation schemes.

"We want to export our products, especially using this free trade area," she said, noting that TCCIA has an obligation to support government efforts in the matter as the government is prioritising efforts and projects of the private sector.



Uganda announces new population census dates

THE cabinet last week passed a resolution to conduct the national housing and population census

Speaking to journalists in Kampala, the minister for ICT and national guidance, Dr Chris Baryomunsi said by May next year, the government will have raised the required resources of over Shs130 billion to conduct the enumeration exercise across the country.

"Government has marked the night of May 9 as the new census night preceding the actual population enumeration that will commence on May 10," Dr Baryomunsi said.

In July, Uganda Bureau of Statistics (UBOS), the body in charge of the exercise postponed the census that was originally scheduled for last month (August) due to delays in the procurement of the required logistics, especially the tablets that were needed to facilitate the digital approach to the exercise.

The postponement of the sixth national census since independence was also predetermined by UBOS' failure to secure Shs134 billion from the finance ministry that is grappling with challenges of raising the money amidst looming funding cuts from

According to him, May 10 shall be a the international community as a result of the recently passed Anti-Homosexuality Law.

However, Dr Baryomunsi gave assurance that; "All is set for the country to carry out the census exercise because the logistical issues which caused the postponement have been sorted out."

"This is going to be the first census where we are using digital systems and we expect the release of results to be much faster compared to the previous manual exercises," he added.

The last census which took place in 2014 put the country's population at 36 million and it is currently estimated that the number has since surged to slightly above 45 million people.

The census figures play a critical role in guiding planning, policy formulation, programme implementation as well as monitoring development progress in line with the national goals and objectives of the National Development Plan (NDP III).

According to UBOS, approximately 120, 000 people are expected to be recruited and deployed across the country to assist in the enumeration exercise.

The national housing and population census is a mandatory requirement to all UN member countries and it is supposed to be conducted after 10 years to ensure proper planning for the people in various respective countries.

OVER 50 percent of all the medicinal drugs being imported in Tanzania are usually procured to address and treat ailments arising from effects of climate change.

Study says anthropogenetic factors reduce water flow in Mbarali River conservation and protection of the

WATER flow of the Mbarali River is drastically lessening due to increase of demand and other destructive human activities, according to a twoyear study conducted by the Sokoine University (SUA) and the National Environment Management Council (NEMC).

The research was conducted under the implementation of the Sustainable Catchment Management through Enhanced Environmental Flow Assessment (EFLOWS) project. The project was meant to help strengthen protection of the Western Indian Ocean from land-based sources and activities in Tanzania.

Presenting the study's findings at a stakeholders meeting held in Mbarali District, Mbeya Region recently, project principal researcher from SUA, Prof. Japhet Kashaigili said more coordinated efforts are still needed to strengthen protection of the country rivers.

"What we have seen in the research is that the amount of water in the river has continued to decrease, population growth being a major reason and increase of economic activities, expansion of farming and irrigation along the river, something which raises water demand at a time when the country is also facing climate change challenges. Drought that has been hitting the country in recent years has greatly impacted flow of water and the river ecosystem," Prof. Kashaigili said. According to him, increasing human

activities such as agriculture, livestock keeping, brick making at water sources and along the river have contributed significantly to the decline in water flows into the river.

The study shows that due to the major effects in the river that has reduced flow of water, Mbarali river is not contributing anything to the Great Ruaha River especially during dry season.

"The river's ecology and its sustainability has b en affected and thus hampering achieving targets of both national and the global sustainable development goals in Programme (UNEP).

Dr Nchemba makes appeal to SwedFund for aid priority

THE Minister for Finance, Dr Mwigulu Nchemba, has appealed to the Swedish Fund for Development (SwedFund) to accord Tanzania priority in its assistance towards investing in the production sectors in order to boost employment opportunities and the nation's economic growth.

Dr Nchemba made the appeal here this week when he met and held discussions with SwedFund Projects Director, Stefan Falk during which they delved into crosscutting issues between Tanzania and the Fund.

He said that Tanzania's production sectors, including farming, livestock, fishing, tourism and minerals employ many Tanzanians, the youth in particular to which the government has decided to channel huge resources through its Budget and various programmes to boost the sectors.

Dr Nchemba said that when SwedFund is preparing its new five year development strategy early next year, it is important to look into how will contribute in to the government's plans as apart from boosting employment opportunities to a large section of Tanzanians, will also enhance production of crops that will earn the country the much needed foreign currency.

He said the plan should be clear including its financial institutions.

Employers urged to submit workers' claims data online

EMPLOYERS in the country have been urged to use Information and communication Technology (ICT) in submitting details of an employee involved in accident, illness or death from his/her work through his/her work contract in order to simplify the compensation process.

The call was made recently by the Director General of Workers Compensation Fund (WCF), Dr John Mduma when opening a seminar for human resources officers and health

He said from their responsibilities given by the firms they represent, the officials are an important link between the employers and WCF and that the Fund has simplified its service provision to go in tandem with technology changes and that at present all services are online via portal.wcf. go.tz. "Our experience shows that our services uptake is sufficient and obtained online, hence I urge on the use of WCF online services which are cost friendly and fast," he stressed.

He said WCF exists to deal with challenges facing employers at work

Dr Mduma further said the government established the Fund in order to carry the burden of serving an employee who is injured at work place or falls ill, while his employer remains with sustainable production from his firm

Regarding issues discussed at the seminar, WCF Director of assessment services, Dr Abdulsalaam Omar said participants have learned how to submit online details of accidents or illness on employees at work places, including submission of claims, but also they learned on issues of safety and places including social and economic health of workers at their workplaces. On their part, seminar participants nearest WCF office.

commended WCF for the procedure and called on the Fund to provide similar education to various groups in regard to workers' compensation.

Zainab Jereko, one of the participants, urged employers to abide by health safety issues at work places, saying even though WCF's task is to compensate workers, this, she said, does not remove employers' responsibilities to abide by health safety measures at work places.

She also commended the procedure to submit claims online saying "it has been of great help as it has simplified the issue of submission of details including removal of bureaucracy that cause unnecessary details.'

In accordance with the Workers Compensation Act, every employer in Tanzania Mainland is required to register in WCF through portal.wcf. go.tz or apply by filling forms WCR-1 and WCR-2 and submitting them to the

Region from September 27 to 29.

'MSD dispatches medical products six times a year'

THE Medical Stores Department (MSD) has strengthened the distribution system where medical products are currently detached six times a year, contrary to four times as it was before.

The new development as assured health facilities in the country of steady availability of the drugs and tools.

Mavere Tukai, MSD chief executive director, unveiled this on Wednesday when briefing journalists on the department's performance for the past two years.

According to him, previously distribution of medical supplies was uncertain due to various challenges which was leading to the health centres to stay a long period without having the essential medical products.

"With the current situation, medical products are supplied every two months compared to four times for a year or every three months in the 2021/22 fiscal year," he said.

Tukai said the department has managed to purchase16 trailers worth 2.6bn/- so as to speed up the distribution of health products.

This has witnessed an increase of distribution of health products and sales revenue by 373.4bn/- (16 percent) for fiscal 2022/2023 compared to 320bn/- collected during fiscal 2021/2022.

He also stated that MSD has managed to use collaborative IT systems (PoD) to ensure health products are received and monitored electronically in health care centres.

"We have also strengthened vehicle monitoring using systems as well as completed construction of the gloves factory located in Idofi, Njombe Region," he added.

Tukai said that the department engaged the private sector by identifying investment areas for financial capacity.

strategic health products of tablets (tablets), capsules, liquid, and products derived from the cotton crop and to announce the desire for cooperation between MSD and the private sector

"We have also completed registration and operation procedures of the N95 mask factory located in Keko where its production will meet the demand for masks in the country," he said.

The department has also managed to establish a subsidiary company "MSD Medipharma Manufacturing Company Ltd" which will manage the production of health products.

He similarly noted that the joint procurement system with member states of the Southern Africa Development Community (SADC) has also helped where practice in the first three years and attained 6.8bn/- sales revenue.

He said the countries that have used the joint procurement program; Tanzania, Comoros and Seychelles adding that the requirements of the following countries are in the process of completion; Zambia and Malawi.

Measures taken to increase efficiency; improving cooperation and increasing influence at the level of the SADC Secretariat, and at the level of the SADC countries through our embassies.

The director further said that MSD intends to establish and manage health product factories in collaboration with the private sector by building modern warehouses in the regions of Kagera, Dar es Salaam and Mwanza.

"We will increase cooperation with local producers to improve the availability of health products and improve the structure of the institution to be able to fortify efficiency," he said.

On the other hand, they argued that most of those traders are young women with little education and knowledge on trade between two or more countries.

They were speaking during a national policy dialogue on advancing women cross-border trade that brought together women from some six border points in the country.

The meeting was convened by the Eastern African Sub-Regional Support Initiative for the Advancement of Women (EASSI) through its Tanzanian collaborative partners of Tanzania Media Women's Association (TAMWA) and Tanzania Gender Networking Programme (TGNP).

EASSI is a feminist sub-regional Civil Society Organisation made up of committed individuals, Non-Governmental Organisations (NGOs), coalitions and networks driven to transform gender relations globally and especially in the Eastern Africa sub-region. It is registered in Uganda as a Non-Governmental Organization (NGO)

TAMWA's Executive Director Dr. Rose Reuben stressed on the need to look at challenges facing women involved in cross-border trade and how the solutions could be embedded in the policy.

She said TAMWA has been a member of EASSI for a long time just like TGNP and are working to help resolve challenges facing women in cross-border trade, which are quite similar in all East African Community (EAC) countries and beyond.

"Little is known on how difficult women find it to operate and doing business beyond their borders as some face sexual harassment, among them is women cross-border trade.

"We have been doing a lot of cooperative work with the government on tax barriers in effort to ensure that women involved in cross-border trade operate freely" she said.

She said the aim is to ensure review of gender policy, applauding EASSI and women at cross-border trade as well as the government for cooperation aimed at improving trade at border points.

Speaking while officiating the opening of the dialogue, Director of Trade Development Division at the ministry of Investment, Industry and Trade, Christopher Mramba urged the women to openly speak on challenges facing them , adding that the government is always willing to listen to them.

"Always express your views, challenges and other matters affecting you cross-border in effort to help the government improve on issues affecting local and international business" he said.

While thanking the organizers of the meeting, Mrema underscored the importance of women empowerment, stressing on the need for more stakeholders involvement in finding solutions to challenges affecting them.

He said the government has been implementing policies that promote trade and business beyond borders, urging that cross borders traders should always let the government know if regulatory authorities hinder cross-border trade in any way.

Health specialists launch haematology clinic in Dar

TWO health experts have teamed up to launch the first ever private specialized haematology clinic and laboratory in Tanzania to be run by United Kingdom based company SerenOx Africa.

Co- founded by Prof Anna Schuh from the University of Oxford and Dr William Mawalla, a haematologist from Muhimbili University of Health and Allied Sciences - (MUHAS), the clinic will allow patients seeking a precise diagnosis of common blood disorders, including anemias, bleeding and clotting tendencies to access the

facility as walk-in clients.

"Precise diagnosis is essential in delivering the right treatment to the right patient and at the right time, many diseases that can be easily cured well controlled with affordable therapies are currently not being diagnosed for example, if left undiagnosed, 95-percent of children with sickle cell disease die within the first 5 years of life. For cancer, over 90-percent of patients can be cured in-country with treatment if diagnosed early," Prof Schuh said. By contrast, late-stage cancer is incurable, SerenOx Africa has established a testing facility for key underserved patient populations

in Tanzania to provide early cancer detection for high-risk patients and will ultimately expand its services to the rest of Africa.

Dr Lulu Chirande, a Paediatric Haematologist and Oncologist, also a Lecturer at MUHAS said, "We cannot over emphasise the importance of an accurate and timely diagnosis in the treatment of children with cancer and blood disorders," he said.

Most of our patients reach us late with advanced disease, we cannot afford further delays in diagnosis. We cannot start treatment unless we are sure of what we are treating. Dr Mawalla, the Co-Founder, said, "We are excited to launch SerenOx Africa and to offer our services to the people of Tanzania, we are committed to providing high-quality, affordable haematology diagnostic services to all patients, regardless of their background or ability to pay.

THE University of Dar es Salaam (UDSM) has been provided with a 1,000-acre land plot in Mbeya Region for building an inclusive Health and Science campus and a modern practical teaching hospital.

The plot of the former Tanganyika Packers company in Mbalizi Town near Mbeya has been provided by Mbeya region government following a request from the University's Chancellor, Dr Jakaya Kikwete who had requested for a 500-acre plot.

This was revealed by Mbeya Regional Commissioner, Juma Homera early this week when he addressed Mbeya Region Elders Development stakeholders (WAMAMBE) at a meeting convened to discuss various issues of development in Mbeya Region.

RC Homera said earlier there was no land plot to provide to UDSM owing to the tussle in regard to the utilisation of the Tanganyika Packers area, but after the government allowed for the area to continue being used, they decided to apportion it.

He said Mbeya Region government was provided with 4,500 acres of land for investors and hence UDSM is among the main investors who were accorded priority.

"This project is among issues which Mbeya elders have been stressing from time to time, and now we have already provided the plot and I have the documents in my office, they also plan to build a drugs and medical devices factory in the area," said RC Homera.

For his part, WAMAMBE Chairman, Polisiya Mwaiseje, who had once been Member of Parliament for Mbeya Urban Constituency through NCCR-Mageuzi thanked Mbeya regional government for the decision.

He also appealed to the RC to urge President Samia Suluhu Hassan to lay

the cornerstone for the construction of the university campus in order to enhance enthusiasm in the project's implementation

He also advised the government to survey the area so as to provide UDSM with a map for the title deed, saying the project will be among projects that gives Mbeya Region respect.

"Formerly the area housed a meat production factory but did not operate, hence we hail the government for the decision to change its use," added Mwaiseje.

Speaking to the address by phone, UDSM Vice Chancellor, Prof William Anangisye said as for now they continue with the process to build the UDSM campus after being handed over the land plot.

UN considering funding EAC mission in DR Congo

NEW YORK

THE United Nations has agreed to a proposal by the East African Community (EAC) to fund the latter's military mission in DR Congo, according to reports.

The EAC Regional Force (EACRF) in eastern DR Congo is funded by partner states in addition to donations from some partners.

Speaking to journalists after a meeting with the UN Security Council, in New York, which was also attended by the EACRF commander, EAC Secretary General Peter Mathuki said the arrangement could be finalised in

the near future after the withdrawal of UN peacekeeping mission in DR Congo (MONUSCO) by December. to strengthen the EACRF." "We have proposed funding the EACRF, and the UN Security Council said they are

Mathuki's office said the meeting with the Security Council "deliberated on extension of financial and technical support to EACRF."

"What has happened is that the UN Security Council is very keen and appreciative of the role of the EAC in supporting the security of the eastern DRC," Mathuki was quoted as saying.

"They have agreed to work a mechanism that will support our troops in DRC, and they said as MONUSCO closes down [or] reduces their numbers in DRC, they will wish

to strengthen the EACRF." "We have proposed funding the EACRF, and the UN Security Council said they are meeting in December in which we will be able to determine how much they can draw down from Monusco and how much they will be able to get to fund the EACRF," said Mathuki.

The EAC regional force was deployed to eastern DR Congo in November 2022 with a mandate of restoring peace and security and observing a ceasefire between the Congolese army and the M23 rebel group in North Kivu province.

MONUSCO closes down [or] reduces The regional force, with troops from their numbers in DRC, they will wish Kenya, Burundi, Uganda and South

Sudan, currently occupies the rebels' vacated positions.

Early September, EAC leaders extended the regional force's mandate by three months until December 8.

Eastern DR Congo, which is home to more than 130 local and foreign armed groups, has been volatile for nearly three decades.

Multiple interventions, including one of the UN's longest and largest peacekeeping missions, MONUSCO, failed to end the decades of violence. The 25-year-old UN mission in the country has been the target of demonstrations for failing to end the insecurity.

MISUNGWI District Commissioner Paul Chacha has instructed the District Police Commander (OCD) SSP Oscar Mmole to seize a firearm in possession of the District TARURA manager, Eng. Bright Mdeme owing to his threat to shoot various government officials including the head of the PCCB in the district.

Mdeme is claimed to have threatened to shoot the officials when they went to him to investigate alleged bribery claims against him, that he was bribed by a road contractor for failing to implement a road project in time.

DC Chacha issued the instruction on Wednesday when he made an inspection visit of the Nyanshishi-Fela road project that was supposed to be completed on September 1 this year but the contractor has not said anything on this.

The DC explained that after the TARURA manager was visited by PCCB officials for investigations regarding receiving 15m/- bribe, he allegedly threatened them to shoot them, hence they withdrew after failing in their

mission. "And you, manager, when they came to you, you began cleaning your pistol saying whoever approaches you, you would either kill them or kill himself, hence the DC instructed the OCD to reclaim the weapon from the TARURA Manager and follow fresh procedure to own a firearm," DC Chacha said.

He also directed the District PCCB Commander to continue with their investigations on the TARURA manager on the alleged acts of corruption involving TARURA officials and the contractor awarded road tender and other projects.

With depression, we get by with a little help from our friends

ORTY-FOUR per cent of college students report experiencing symptoms of depression and 37 per cent report experiencing symptoms of anxiety.

This is according to the March 2023 Healthy Minds Survey, an annual webbased survey examining mental health among college students.

The study shows that 15 per cent report seriously considered suicide in

ARDLY anyone expected that a decade into the commercial exploitation of our vast natural gas reserves and sources of hydropower generation, our country would be having a 400-megawatt shortfall at present.

Authorities in the giant national power generation and supply firm, Tanesco, may wish to ascribe the current situation the need for major repairs on their systems.

But experience shows that in a nonmarket economy or power supply system, things only go from bad to worse. The more outlays the corporation has in place, the less it is capable of keeping the system properly maintained.

A singular example suffices in illustrating the scenario: that when a road network is maintained by some private agency with fees paid by a local authority, maximum care is taken to ensure that there is no damage on that network so that there is some profit on the margin made.

When the network shifts to the public sector, supervisors benefit by regularly applying for sizeable funds to rebuild damaged roads. And, as a rule, they will keep the roads in that state to pressure for the disbursement of funds. It's much the same for power systems and the consequent repairs.

There was a time a mushrooming of power projects was noticed, to fill a similar gap as now obtains, and then the projects fizzled out after a few troubled contracts where the public felt that all these projects were corrupt.

Trouble is that at least some of these projects were not developed to supply directly to the public in actual competition with the national firm, but only as an addition to the latter's outlays.

Now, those outlays are being boosted by upwards of 2,000 megawatts from the Julius Nyerere hydropower plant (JNHPP) coming to berth soon, though that won't end the matter.

day that it is possible to reduce the 400-MW shortfall by 100 MW on average a month by fast-tracking current repair efforts. That would hopefully end the problem by next March. However, it would be more useful

looking over the longer term. As current production stands at 1,900 MW and is being doubled next year, maintaining the same structures implies possibly doubling the complications in due course.

The maintenance work shall be doubled while climate change impacts could go from bad to worse, depending on how deforestation is handled.

Let's hope nutrition remains stable after five-year project

IPLOMATS from USAID and livestock rearing. and scores of Tanzanian government officials were lately winding down 'Sustainable Nutrition', a project widely described as a hallmark in the journey towards better nutrition across the country

The project was a learning and resource channelling effort, where people are given the seed capital with which to organise domestic feeding differently, in the hope that when the project ends the work will stand.

Of course, that is what is expected, and it is also possible that there is a certain amount of behaviour change or resource stability in improving nutrition habits or enhancing capacities.

There is a snag is in at least one area, though, in that the project covered only four regions, and even then not entire villages or districts.

The will maybe have been valid reasons for that being the case, while the problem remains as to how far there is need for such a project for behaviour change to occur, and if it will stabilise.

A publication unveiled at the wrapping-up ceremony nearly gave away the secret, merely in the need for documented testimonies that the project had introduced a certain amount of change in their lives.

There were suggestions that things could have been done better - but that was only to be expected. It is a mental construct, at best, but psychological needs arise from real shortcomings in life.

The areas touched by the project have ample opportunity to persist with their engagements if they proved gainful, even without new project cash being disbursed.

Typically in keeping with traditional mindsets at both these spheres of organisation, what might happen is figuring out how the project is extended to different areas - possibly, with the same aid agency.

Chances are that this will not be forthcoming as issues that need emergency attention pile up by the day and alternative ways of funding such projects are needed.

That is why funds would be more available if policy was designed to enable revolving funds to be set up for the purpose, so that those benefiting pay up to enable the same to be done elsewhere.

Looking at the buzz of activities where the key objective was to reinforce local nutritional efforts having partnerships with over 300 private entities, there is every reason for the efforts to be organised differently.

The key element is that a private agent puts the funds on the ground for designed activities and is paid by beneficiaries to return the cash to a bank account catering for such projects in a particular district or a zone. That stands to prove the recipe for the sustainable success of the projects concerned.

For me, as a mother of three young adults and a professor who teaches many college students, these numbers are heartbreaking.

But the good news is that the current mental health crisis on college campuses and elsewhere around the US is decidedly not inevitable.

Empirical research, including work I have conducted in collaboration with my colleagues and thesis students, provides valuable insight into how parents, educators and peers can help foster better psychological wellbeing in college students and anyone struggling with depression or prone to its symptoms.

Reduce stigma of mental health support

Many college students spend considerable time and energy trying to present themselves as thriving academically and socially. Adolescents care deeply about fitting in with their peers and are highly motivated to hide any signs of weakness or insecurity.

This tendency makes it really hard for people to admit that they need help, especially when they think they are the only ones having trouble.

This tendency is often described as the "duck syndrome", the idea that people are paddling furiously under the surface to stay afloat while simultaneously presenting the image of a cool, relaxed individual, gliding on the water.

Duck syndrome is the "feeling that everyone is doing really well except for you", wrote Ishaan Singh, a student at Stanford University, where the term duck syndrome was first coined, "and the feeling that everyone around you is in total control but that everything is falling apart for you".

Of course, this feeling of isolation -"It's only me who is struggling" - makes mental health issues feel even worse.

third focused on improving mental health through stress management.

Two months later, we measured the effects of all three workshops on students' attitudes. We found that students clearly benefited from receiving accurate information about the prevalence of mental health issues on campus.

The workshop correcting misperceptions about mental health issues on campus was just as effective as the general education workshop at improving attitudes towards seeking professional help for mental health issues. This workshop was also more effective than the one on stress management.

Although our study did not find evidence that receiving accurate information about mental health norms led to an increase in actually seeking help, our follow-up period of two months may have been too short to see such an effect.

Prior studies demonstrating the role of attitudes in predicting behaviour suggest that these students might be more willing to seek therapy for mental health issues in the future. And given the epidemic of suicides among undergraduates, this kind of behaviour change could well help save lives.

Build meaningful connections

Empirical research clearly demonstrates that developing meaningful social connections can go a long way towards improving psychological well-being.

People who are more socially connected to their communities are happier and physically healthier -and report fewer mental health problems. Such connections may be especially valuable for adolescents and young adults, who often prioritise social relationships above all else.

One of the most promising approaches to fostering such connections on college campuses is ProjectConnect, a programme designed to help small groups of

assigned to participate in the programme in the autumn semester, or to wait until the spring semester.

Those in the program participated in five weekly hour-long sessions, including: three sessions with guided conversation focused on increasing intimacy, one session with a community-building task, and one session with a casual meal and opportunity for programme reflection. Results from the one-month follow-up revealed that people who participated in ProjectConnect showed decreases in loneliness, suggesting that even a relatively brief opportunity to build connections could lead to substantial benefits.

These findings are particularly encouraging, particularly considering that findings from a nationwide study of nearly 33,000 college students revealed that two-thirds of students report feeling lonely and isolated.

"Helping build stronger connections on campus may be the most powerful thing we can do to improve students' mental health and well-being," says Jessica Gifford, ProjectConnect founder and chief connection officer. She adds: "Every act of connection - large and small - makes a difference. When you connect, you protect."

Train people to support friends in need

Like many other young people, college students spend considerable time with their friends: They eat together in common dining halls, attend classes and study together, and may even sleep together in the same dormitory rooms.

Friends are therefore likely to be among the first to recognize signs of mental health issues - and may be uniquely able to help students get mental health services.

In fact, a 2019 survey by the American College Health Association found that among students who seek help for their mental health, most initially did so after being encouraged workshops.

One workshop provided specific skills and knowledge to help a peer struggling with mental health, such as active listening techniques and campus mental health resources.

A second workshop provided information correcting commonly held misperceptions that inhibit people from helping a peer struggling with mental health, such as that asking a friend about suicidal feelings would make the situation worse.

The third workshop meanwhile provided strategies for empathetic listening and responding to a peer struggling with mental health.

Our findings from a three-month follow-up reveal that even brief online interventions can play a role in reducing the mental health crisis.

Students who received training in specific skills to help a friend, or who got information correcting common misperceptions about mental health, reported less fear that intervening would hurt their friendship.

This fear often inhibits people from intervening when they worry that a friend needs help. Alleviating the fear may help someone intervene when she or he sees a friend who is struggling.

Our research suggests that increasing help-seeking behaviour among college students likely relies on their willingness and ability to speak up when they worry that a friend needs help.

Increasing training in bystander intervention for mental health concerns may play an important role in linking peers to on-campus mental health resources and improving college students' psychological wellbeing.

Basic procedures of dealing with civil cases in court (4)

Trial stage

Litigation in adversarial system is not to seek the truth but a skill of testing evidence which is in one's possession within the parameters of the law which governs an issue in dispute.

So it is one's duty to convince a judge or magistrate to believe their facts and not to tell the truth as many people think. That is why we still believe this task can only be properly performed by a trained person such as an advocate who is in a position to control the flow of evidence in a case in accordance with the law.

Litigation is not an issue of telling a story as many people think. Rather, it is to convince the bench so that they believe that what you present is the truth. Therefore, selection of material facts is one of the very important tasks which need to be adhered to when conducting a trail.

Trial stage can be divided into six phases, namely (i) opening statement, (ii) examination in chief by plaintiff (iii) cross examination of the plaintiff (iv) examination of the defendant (v) and cross examination of the defendant.

Opening statement

Essentially, this is the summary of the parties in the case whereby the court is provided with general scope of what the case is all about and the nature of witnesses required to be summoned. It is one of the very important stages where the court gets general picture of the case before dealing with specific issues in dispute between

the parties.

This is a stage in which one pursues the court by simply by trying to show the roadmap of the case and provide brief demonstrations of the nature of evidence intended to be tendered during substantive hearing of the dispute.

This phase is not available in the Civil Procedure Code and it is not common in our jurisdiction but in some other civil laws such as High Court Commercial Rules under Rule 45 and in labour laws.

Examination in chief of the plaintiff

This is the stage where the claimant or plaintiff establishes his or her case by production of evidence and exhibits. It is a matter of law that a case must be proved by primary evidence and not hearsay.

Therefore, the one who is summoned to testify before a court should not stand on the dock and testify hearsay evidence. Rather, it must be a person who actually participated or is actually aware of the facts he or she is presenting.

Hearsay evidence is prohibited and it cannot be used by the court in composing a judgment. This principle is extended even for examination in chief un-

to the tendering of exhibits in that the law demands that a case should be proved by primary evidence or exhibits and in case a party intends to use secondary evidence, then there must be good and sufficient reason as to why secondary evidence should be accepted by the trial court.

Due to current development of law in our jurisdiction, particularly on the Civil Procedure Code Vide GN No. 760 of 2021, upon application by parties, then evidence in chief shall be given orally or by witness statement.

Availability of the said law does not change the law. Rather, instead of proceeding with the production of evidence in chief orally, the same can be given in written form and later on the court concentrates on admission of exhibits listed in the witness statement while taking into account requirements of the law

A person composing witness statement should be very careful because once one opts to testify by this way, they are not allowed to add anything during hearing. Instead, their appearance in court will be for tendering exhibits, cross examination and reexamination and not

less leave is obtained from the court of law upon showing good reason as to why that request should be accommodated.

In short, it is very important to build your case while testifying in examination of chief because after closing the same, you will not have automatic right to redo it, unless leave of the court is granted.

Cross examination

This is A process in which the Plaintiff is being asked questions by the opposing party. The major aim is to challenge or test the credibility, knowledge or consistency of the witness's testimony.

For practicing lawyers, this is always the stage in which they completely destroy the plaintiff's case while maintaining or demonstrating that what was pleaded in the defence is the right thing.

Most of the questions asked at this stage are not demonstrations. Rather, they tend to be leading questions whereby the opponent suggests the answers are recorded in court proceedings through the plaintiff and not otherwise. So, one needs to be careful at this stage because a good case can be destroyed during cross examination.

Reexamination

This is always done after cross examination. That means if there is no cross examination. then there is no need for reexamination because it is a process involving either provision of clarification or rehabilitation of contradictions which arose during cross examination so that the court can be in a better position to get the real picture.

It is always limited to matters raised during cross examination and one cannot introduce new issues at this stage. It is advisable in most cases that if you have a weak case or weak witness, then do not conduct reexamination because it could further destroy your case by further exposing yourself during that stage. Therefore, this process should only be done when necessary and in very few circumstances.

Once the process of tendering evidence is done by the plaintiff by summoning all witnesses, then the plaintiff closes his or her case and paves the way for the defendant to proceed with defence.

In some circumstances, the court either on its own motion or on application by the defendant may make a ruling whether the plaintiff's case is made or not (prima facie case).

This is very common in criminal cases but its applicability in civil cases is through case law. In case the court makes a finding that a case is not made by the plaintiff, then the case is dismissed at that stage.

It should be known that a plaintiff's case cannot in either way be built on the weakness of the defence. Rather, the law requires the plaintiff to prove his or her case on balance of probabilities. In the case of failure to meet the above threshold, then the case is dismissed without even summoning the defendant.

Examination in chief by the defendant

This stage is where the defendant presents his or her defence of the case preferred against him or her. It should be within the parameters of law in connection with what is pleaded in the written statement of defence.

Parties are bound by their own pleadings. Therefore, the defence tendered during the hearing should flow from the pleadings. Once the said process is done, then the plaintiff is called to cross examine the defendant and always the rule is to destroy the defence while trying to indicate that what was stated by the plaintiff is right and has not been destroyed by the presented defence.

Examination in chief can also be by way of witness statement. Therefore, once the plaintiff's case is closed, that is when the defendant's witness statement can be filed within seven days or if more time is granted by the court.

Post-trial

After the defendant closes his or her case, parties may opt to file closing or final submissions. This can be orally or by way of written submissions. However, in case of a written submission, the same needs to be filed in court by both parties at the same time.

It is not mandatory to file the same and in case an order is issued, then failure to file by either of the parties cannot bar the court from delivering the judgment. Rather, the court may proceed to compose the judgment through evidence and exhibits already tendered.

This is a very important stage in court proceedings because it is a stage in which each party to the case tries to convince the court that all evidence and exhibits tendered during hearing are in support of the case based on the statutory law or case law.

In most cases, circumstances of a case are not new because a similar case might have already been decided by the same court or the higher court. Therefore, under the law of precedent, a subordinate court is required to follow the same which makes it a very important stage where one makes changes of the case or notion of the court on particular things. The remaining two stages of judgment and appeal will be covered in the next article.

Skyrocketing inflation puts food security in Pakistan at risk **G** WE are under extreme stress about skyrocketing prices of essential edible commodities

electricity. The situation is becoming worse because every day. We must pay more for wheat flour, sugar, tea, milk, oil, etc.," Azizullah Khan, a civil servant, says.

Khan draws a monthly salary of 30,000 rupees (USD100), but the cost of living is increasing daily, making it hard for his family of eight to survive.

The electricity bill for August was 20,000 rupees (USD67), and two-thirds of his salary went into paying that, while the remaining 10,000 rupees (USD33) is meant to pay for gas and other family expenses, which, he says, is next to impossible.

"Now, we are seriously thinking of selling the small house we inherited from our parents because we have to repay loans to the shopkeepers and pay the school fees of three children," says Khan, 30. He lives on the outskirts of Peshawar, the provincial capital of Khyber Pakhtunkhwa, one of Pakistan's four provinces.

Pakistan's leading economy and business analyst, Khurram Hussain, told IPS that the country has been seeing relentless and unending pressure on the exchange rate and price levels for more than two and a half years.

"The present bout of exchange rate volatility began in May 2021 and has continued unabated since then," Hussain says. The dollar had from around 150 rupees to the dollar to about 300 to the dollar, he says.

Quoted in Dawn, a newspaper in Pakistan, he noted: "It took ten years for the dollar to double in value from 75 to 150 rupees, from 2008 till 2019. It took less than two and a half years to double again from May 2021 till today.

At the same time, inflation, as measured by the Consumer Price Index, started to skyrocket a few months after May 2021 and has risen relentlessly until now, with a few interruptions.

Muhammad Raees, 28, a daily wager, is severely hit by the cost of living.

"One year back, the price of 20 kg wheat four was Rs1300, which has now increased to Rs3000. I don't find work every day because the construction ac-

tivities have nosedived due to cement, iron, marble, and tile prices, and most of the contractors have stopped work," Raees, a father of two, says. "Many times, I have thought

of committing suicide, but then I think of my children and wife," he says.

At least ten people have committed suicide in the past two months.

"They were unable to pay electricity bills. Now, the government is mulling about jacking up the gas price by 50 percent. The poor population is the worst hit," he says.

Javid Shah, a vegetable seller in Nowshera city adjacent to Peshawar, is fed up with life. "Cost of transportation has increased, and so the prices of vegetables and, as a result, sales have declined. Many who bought 1 kg of tomatoes, lady fingers, and potatoes daily are now taking half a kg," he says. "I have to discard rotten vegetables daily for lack of sales."

Akram Ali, a fruit seller in a tiny shop, also constantly complains of high inflation and devaluation of rupees. Ali says his business has reached a standstill as people no longer buy fruits due to high prices.

"As a result, I am going to close shop and start the business in a hand pushcart to save on rent." "My two sons are going to school, but the last one and half years have been tough, and I cannot pay their fees. Both have quit schools and sit at home," he complained.

Saleem Ahmed, a local economist, tells IPS that pulses, considered poor men's diet, are so expensive they are out of reach of many.

"All pulses are imported in dollars, so their prices have increased. The people are struck by inflation, and they cannot buy items, like pulses, which used to be cheap," he said.

Prices were stable until former Prime Minister Imran Khan was removed in April 2022 in a noconfidence vote at the National

Assembly.

"People have been running from pillar to post for two square meals. As if inflation wasn't enough, huge smuggling of sugar, wheat flour, pulses, oil, etc. to neighboring Afghanistan have hammered the last nail in the coffin of the poverty-stricken masses," he said.

Ahmed says the government is taking loans from the IMF, the World Bank, and other lenders with high interest rates, impacting the cost of living.

In such a scenario, Afghan refugees living in Pakistan are jubilant over the rising Afghan economy under the Taliban, and many are weighing options to return to

their country.

"In Pakistan, the US dollar is equal to 300 rupees while it is traded for 75 Afghani back home," Muhammad Mustafa, an Afghan with a sanitary business in Peshawar. savs.

Mustafa says he had sent his elder son to Kabul to search for the rented shop so he could shift his business there.

"All my family live in Kabul, and we want to be there. The time is ripe for us to shift (back) there," he says.

Petrol is being sold at 312 rupees (USD1.5) per liter in Pakistan, while its rate was 80 Afghani (USD1.02) in Kabul.

Navigating challenges in development of Indonesia's future capital

ANY nations are engaged in ambitious urban planning endeavors and the creation of new capital cities. Nusantara, Indonesia, is the latest in a series of modern cities that have sprung up across Asia.

The government aims to create a model capital city based on the principles of liveability and green urban development on the island of Borneo.

Indonesia seeks to relocate its capital due to flooding, land subsidence, overpopulation and congestion in Jakarta, located on the island of Java, where 60 per cent of the country's population of close to 280 million lives.

Nusantara will also play a role in rebalancing the country's economy, and redistributing economic growth outside Java. But how can the government get such a complex endeavor right?


In this article, we explore how planners of Nusantara are leveraging a UN-supported mechanism, called the Voluntary Local Review (VLR), to promote sustainability and uphold human rights. VLRs are typically performed by authorities of existing subnational administrative areas such as provinces and cities.

Nusantara will be the first VLR for a new city ever undertaken – in order for authorities to integrate sustainability actions and key principles such as leaving no one behind already during the development stage.

Valuable lessons from other new Asian cities

Malaysia's sustainable approach: Putrajaya, just south of Kuala Lumpur, was designed as an intelligent garden city. Its planning emphasizes green and sustainable development. Rather than separating indigenous residents from their traditional land, it incorporated existing Malay villages into the plan. The lesson here is that new capital cities should prioritize local land rights and sustainability through green infrastructure. Such initiatives contribute to a better quality of life and environmental preservation.

Republic of Korea's phased development: Sejong City's incremental approach to its development as an administrative capital is a testament to the advantages of not rushing construction and drawing from lessons learned throughout the process. It was created to decentralize economic and political power away from Seoul. It also showcases the importance of designing new capital cities with resilience to climate change in mind, given the increasing threats of extreme weather events. Kazakhstan's sustained investments: Astana's development and transformation as a capital city involved substantial investment in infrastructure, including the futuristic Norman Foster-designed Khan Shatyr Entertainment Center and the Bayterek Tower. One key lesson is that comprehensive urban planning, including spatial integration of transportation, housing, green spaces and public services, are crucial. Astana's transformation into a thriving city of 1.3 million

demonstrates the importance of having a clear, long-term vision.

Seven key takeaways for Nusantara's way forward

Nusantara is learning from these examples by leveraging sustainability in its master planning and closely working with ESCAP, the UN Country Team in Indonesia and the Asian Development Bank to prepare a baseline VLR report as a tool for fostering inclusive, sustainable and rights-based development.

Transparency and accountability The VLR promotes transparency by providing detailed information about the progress and challenges faced in implementing the new capital. This transparency can help build trust among stakeholders, including the public, investors and government agencies. The VLR can demonstrate how the new capital's development aligns with global goals. Assessment of progress

The VLR can evaluate the sustain-

ability of the new capital, including its

expected environmental impact and

efforts to promote sustainable practic-

es. Nusantara aims to be a "sustainable



Data-driven decision making

By collecting and presenting data on the new capital's development in one place, the VLR can facilitate integrated data-driven decision-making. It can help policymakers identify trends and make informed choices regarding resource allocation and policy adjustments. In this process, the VLR requires municipal government departments to effectively work together and break down silos.

Stakeholder engagement

Indigenous communities live on the site, including approximately 800 families of the Balik people. The VLR can highlight the importance of involving local communities in the planning and implementation process. It can document community feedback and demonstrate how their input has been considered and make recommendations for institutionalizing stakeholder engagement processes.

Attracting investment

The cost estimate for Nusantara is \$33 billion (Rp466 trillion), with the state budget only able to cover up to 19 per cent of the cost. Investors often look for transparent and well-documented information when considering investments. A VLR can serve as a tool to attract both domestic and international investors by showcasing the potential and progress of the new capital.

International collaboration

Sharing a VLR report with international organizations and other countries can open avenues for benchmarking, collaboration and support. This can include financial aid, technical assistance, and knowledge exchange. Risk mitigation

Identifying risks and challenges in the VLR allows for proactive mitigation strategies. This can help prevent delays and cost overruns in the development process.

While significant attention is focused on Nusantara, it's clear that relocating administrative functions may not address all social and environmental problems in Jakarta, especially for those most vulnerable.

The development of Nusantara has the potential to help Jakarta address its longstanding problems by relieving population pressure, improving infrastructure and setting an example for sustainable urban development. However, the success of this endeavor will depend on careful planning, infrastructure investment, and effective governance.

International Safe Abortion Day is commemorated amid appeals for raising of voices on a 'basic right'

S the world marked International Safe Abortion Day on September 28, Women's Global Network for Reproductive Rights Africa (WGNRR Africa) and its partners have taken action and speak out for the right to safe abortion.


WGNRR Africa and its partners met in Dar es Salaam to discuss issues related to the promotion of safe, legal, and accessible abortion services and the advocacy for Sexual and Reproductive Health and Rights (SRHR) and the day carries profound significance in the ongoing struggle for women's rights and the pursuit of gender equality.

"This year, we are also highlighting how young people are themselves a powerhouse of unstoppable forces, taking leadership in the movement. This September 28, we celebrate diverse young people and how they are fearlessly taking and creating spaces and employing innovative advocacy strategies to champion safe abortion rights and reproductive justice. Young people's active engagement and valuable contributions are indispensable in advancing our shared objective," the Regional Director of WGNRR Africa, Nondo Ejano said.

He added: "The leadership of young women in the safe abortion rights movement is not just inspiring; it is essential. As such, we join them in calling for the support and empowerment of young leaders through equal access to opportunities, resources and platforms."

He pointed out that International Safe Abortion (September 28) is deeply rooted in the global movement dedicated to advancing women's reproductive rights and promoting gender equality.

"It primarily champions the cause



of reproductive rights, with a specific focus on the right to safe and legal abortion. This emphasis underscores the utmost importance of empowering women with control over their bodies, choices, and futures," he said.

He noted: "This Day plays a vital role in raising awareness. It serves as a powerful educational tool on a global scale, shedding light on the alarming prevalence of unsafe abortions and the severe consequences they entail. It also emphasizes the urgent necessity of ensuring universal access to safe

abortion services."

He also pointed out that this year, WGNRR Africa, in alignment with the call to action, has chosen to unite with its partners in commemorating this day by coming together as this year's theme, "Unstoppable Movement: Movement building, solidarity, and justice for the right to safe abortion." The objective is to harness collective strength and amplify advocacy efforts.

Some of the participants have urged Tanzania and other East African Community (EAC) member states to ensure that all women and girls, regardless of their backgrounds, have access to safe abortion care.

"We are calling Tanzania and countries in the regional bloc to make sure that all women and girls are accessing safe abortion care," Nasra Iuma said.

Other participants who attended online, Nancy Baraza from Nairobi, Kenya said that in many African nations, abortion rights have been surrounded by stigma and silence hence calling for an access to safe abortion services and ways to mobilize public support for post-abortion care.

On her part, Anitha Samson from a Mwanza based Non-Government Organization–Wadada Solutions on Gender Based Violence said the community should have the same voice so as to make women and girls receive reproducing rights including the rights to safe abortion.

Other participants said that there is a need for the community to have collective strategies so as to enhance solidarity in advocating for improved

abortion services.

The event was designed as a hybrid gathering, seamlessly combining inperson participation in Dar es Salaam with a dynamic online component. This inclusive format ensures wideranging accessibility and engagement, bridging geographical distances and fostering a global conversation.

During the one-day event, participants took part in a panel discussion that consisted of representatives from Tanzania, Kenya and Uganda who shared their experience of working on abortion under restrictive legal environments in their respective countries and will conclude with the way forward of planning for the Jointly strategy on advocating for safe abortion in the region.

"It is a good thing that the participants have gained a deeper understanding of the history of September 28 and partners have shared experience on working on abortion under restrictive legal environments," Organizers of the event WGNRR - Africa's official Fabiola Odira said.

She added: "The participants have got time to enhance understanding of Sept 28 among participants and create solidarity in the campaign for expanding safe abortion access. Partners shared their experience on working on abortion under the restrictive environment."

"At the end of the one day workshop, participants were able to develop Joint Strategy that will strengthen the unstoppable abortion movement as well as promote the MimiCare App among Dar es Salaam stakeholders so that they can collaborate with WGNRR Africa during their youthrelated activities," she observed.

The event was attended by 38 participants who included YouCAN partners, SRHR Allies, Health and Legal professionals, survivors of unsafe abortion, CSOs, media personnel and Youths champions.

Zimbabwe ramps up efforts to eliminate malaria

KADOMA, Zimbabwe

Ministry ZIMBABWE of Health and Child Care (MoHCC) with support from World Health Organization (WHO) and other partners conducted a Malaria quarterly review and planning meeting to assess the progress made in malaria control efforts over the third quarter of 2023.

The meeting evaluated the 2022/2023 National Indoor Residual Spraying (IRS) campaign to determine the effectiveness and its impact, measure the reduction in malaria transmission rates and identify any potential areas for improvement.

The Chief Director of Public Health in MOHCC, Dr Mu-

nyaradzi Dobbie, acknowledged the support from partners in tackling malaria in the country.

"We truly cherish the support from all our partners who have helped us achieve immense gains in our response to malaria and we hope the training will enhance expertise in carrying out the forthcoming IRS programme and we are looking forward to seeing a decrease in cases going forward," he said.

Prof Jean-Marie Dangou, WHO Representative to Zimbabwe said: "We continue to applaud the work being done by the Government of Zimbabwe in strengthening malaria intervention, and review meetings such

as these ones. The abovementioned meeting is key in taking stock of progress and coming up with innova-

tive improvements that can bring better results.'

The review meeting provided valuable insights into the coverage and compliance levels of IRS interventions, identified resource needs, and ensured that this essential intervention reaches vulnerable communities and contributes significantly to the global efforts of eradicating malaria.

Malaria remains a serious public health problem, with more than 5 million people at risk of contracting malaria annually in Zimbabwe. It accounts for about 40 percent of outpatient at-

tendances in the moderate to high transmission districts, especially during the peak transmission period. By August 2023, the coun-

try had recorded 144 508 positive malaria cases with Provinces like Mashonaland Central, Mashonaland East, Manicaland, Matabeleland North and Masvingo contributing 97 percent of the cases. While the country is doing well and has made progress towards making malaria services accessible to many, Zimbabwe, like the rest of the world, is also faced with growing insecticide resistance, and this calls for increased investments towards finding alternative interventions for malaria control and elimination.

African nations urged to raise use of new technologies in agriculture

GABORONE

AFRICAN countries cannot ignore the adoption of new technologies in research and development, said Botswanan Minister of Agriculture Fidelis Molao, who stressed the importance of establishing strategic collaborations aimed at enhancing resilience and increasing agricultural productivity.

Speaking on Tuesday at the 8th All Africa Conference on Animal Agriculture, scheduled from Sept. 26 to 29 in Gaborone, the capital of Botswana, Molao urged both organizers and participants to seize the opportunity presented by the conference to find solutions that can enhance food security in

Research and development are pivotal to improving livestock and poultry production, Molao said. He also emphasized the need for adequate funding of research and extension services in Africa to address the challenges facing the agriculture sector.

Molao said that according to the African Development Bank's 2022 report, most African countries allocate less than 1 percent of their gross domestic product to research and development, while the global average stands at 1.7 percent.

This underscores the necessity for all countries to shift their approach and increase funding for research and development, he added.

The government of Botswana has initiated various projects to transform the agriculture sector, create employment opportunities, and sustain the livelihoods of the people in rural areas who rely directly and indirectly on agriculture. These initiatives include breeding and disseminating highquality livestock breeds to farmers and employing assisted reproductive technologies to enhance livestock quality.

The conference, themed "Sustainable African Animal Agriculture: Challenges and Future Prospects," takes place every four years to provide a platform for animal science professionals and the farming community to stay informed about the latest developments in animal agriculture.

Nigerian women challenge 'colonialist' patriarchy

UKES Saliu wakes up very early every workday to beat the gruesome Lagos traffic to head to a job quite unusual for a woman to engage in Nigeria. She is a forklift operator in one of the busy depots in the coastal city, a task traditionally meant for men in the West African country.

In a country where women are seen as second-class citizens and whose roles are expected to be confined to the kitchen, Saliu is not letting patriarchal norms put her in a box.

"People are always thrilled when I tell them what I do. Sometimes I get snide remarks from some men I work with, but I don't allow that to get to me," Saliu says.

In August 2022, her curiosity was piqued when she came across a post on WhatsApp from her friend featuring a woman confidently posed beside a forklift machine. That ignited her interest in the job. Soon after, she enrolled in training to become a skilled forklift operator.

"It was a change of career path for me. I used to be a project manager with a non-profit, but I left the job to be a forklift operator. The first day I started work, I was a bit afraid, but now I operate the machine like any other man would do. I believe that women should be allowed at the table because it brings different perspectives, ideas, and experiences," she adds.

Patriarchy lives in Nigeria

Discrimination against women has been a serious problem in Nigeria. Women still grapple with an array of challenges and are marginalized despite the Nigerian constitution providing for gender equality and nondiscrimination

Women face a heavier burden of violence, and different types of bias, which creates significant obstacles in their quest for gender equality. This



election, and only one woman emerged as a presidential candidate.

Women are often excluded from economic prospects. Within Nigeria's populace exceeding 200 million, a mere 60.5 million people contribute to its labor force. Among this workforce, around 27.1 million women participate, a significant portion of whom find themselves involved in low-skilled employment. Nigeria's position on the World Eco-

elected as senators as against nine in the last nomic Forum's Gender Gap Index is a lowly 123rd out of 156 nations.

Swimming against the tide

A limited number of women are challenging conventional gender norms for the purpose of livelihood, stepping into roles that are male dominated in Nigeria. However, this transition is often met with resistance and negative reactions.

In 2021, Iyeyemi Adediran gained wide-

spread attention for her exceptional mastery of driving long-haul trucks for oil companies. However, despite her remarkable skill, the then 26-year-old shared that she faced derogatory remarks for daring to break gender norms associated with truck driving-an occupation traditionally considered male-dominated.

In 2015, Sandra Aguebor, Nigeria's first female mechanic, gained widespread attention for her all-female garages across the country.



However, she revealed that her mother initially did not support her ambitions, believing that fixing cars should only be done by men.

Faith Oyita, a shoemaker in Benue State, Nigeria, is not letting patriarchal norms stop her. Despite Aba, a growing men-led market in southeast Nigeria, dominating the shoemaking industry, Oyita has been determined to make a name for herself since 2015, even though she resides kilometers away. She says she has trained over 300 other people on how to make shoes.

"When I first started, I didn't care about the challenges that came with shoemaking. I had a deep passion for it, and I wanted to beautify people's legs. Even though it was a skill dominated by men, I was determined to do things differently. I knew that greatness doesn't come from convenience. In the beginning, many people questioned why I chose shoemaking. Even the man who taught me was hesitant and doubted my potential. I was the only female among all his apprentices, and many assumed that I came because I wanted to date him. Despite all the negative remarks, I never gave up," she tells IPS.

Patriarchy came through colonialism

"A lot of what is happening today is not how we originally lived our lives as Nigerian women. Patriarchy actually entered our society during the colonial era. Before colonization, both men and women were able to do things without being restricted by gender. Historically, women were involved in trading goods and services, and they could even marry multiple wives for themselves.

"However, when the colonialists arrived, they distorted our culture and, using religion, promoted the idea that men held more power. We should strive to correct this narrative. It's unfortunate that we have been socialized to believe that men should always be in leadership positions and that women should only be in a man's home," says Añuli Aniebo Ola-Olaniyi, Executive Director, HEIR Women Hub

Speaking further, Ola-Olaniyi argues that women who want to break gender norms must have a change of mindset and be ready to face challenges.

"The country that colonized us has

is frequently caused by unfair laws, religious and cultural traditions, gender stereotypes, limited education opportunities, and the unequal impact of poverty on women.

Although the government has attempted to tackle these deep-rooted issues, the pace of progress remains sluggish. Women's representation within politics and decision-making spheres remains poor. For example, out of a total of 15,307 candidates in the 2023 general elections, only 1,550 were women. Only three women were

their women driving buses and flying planes. They have progressed from where they colonized us. But Nigeria has failed to empower its women. When a Nigerian woman does something that is traditionally seen as only for men, it is seen as a big accomplishment. However, she has always been capable of doing those things. It's just that the opportunities were not available. I don't even think it's a switch in gender roles. I believe that women are simply starting to realize their potential," she tells IPS.

However, cumbersome processes around the issuance of titles (especially unit titles) continue to pose a challenge by affecting most Tanzanians eligibility to access residential mortgages.

Efforts to develop housing projects by developers continue with a special focus on Dodoma Capital City as the government has relocated its administrative functions there, which has increased demands for housing, both residential and commercial.

Demand for housing and housing loans remains extremely high as it is constrained by inadequate supply of equitable houses and high-interest rates charged on housing loans.

Most lenders offer loans for home purchase and equity release while a few offer loans for self-construction which continue to be expensive and beyond the reach of the average Tanzanians.

While interests on residential mortgages improved from 22 - 24 percent in 2010 to 15 - 19 percent offered today, to ensure the Chinese new investment market interest rates are still relatively

high hence negatively affecting affordability.

Further, competition in the market has led to emergence of other products that are impacting mortgage market growth as the products have favorable terms than mortgage product and are used for housing purposes. These products are competing with mortgage in terms of loan amount and to some extent tenor as they are offering consumer loans for the tenor of up to seven years amounting to around 120mn/-, an amount enough to buy a housing unit.

The competition comes from the ease with which competing products, specifically, consumer loans is available relatively easily compared to lengthy process experienced in mortgage loans as well as additional costs in mortgage loans including registration and valuation fees as well as insurance costs which are not applicable in consumer loans.

Housing is a fundamental aspect of architecture, providing shelter, which is essential for everyone. In urban environments, addressing the housing challenge is both urgent and complex.

Social housing initiatives aim to provide a substantial portion of the population with access to this fundamental architectural concept: a home.

Social housing poses a dual challenge: it serves as a canvas for architectural experimentation on both medium and large scales, exemplified by projects like Affonso Eduardo Reidy's Pedregulho, con-

Expansion of NATO called out as great risk

THE United States-led NATO expansion and confrontational attitude have been called out for posing great risks to the Asian region, as the 78th United Nations General Assembly came to a close in New York on Tuesday

Representatives from the Democratic People's Republic of Korea and the Syrian Arab Republic blamed the US for its selfish geopolitical interests, which have led to destabilization and insecurity, as well as exploitation of Syria's natural resources.

During his speech, Kim Song, ambassador and permanent representative of the DPRK to the UN, accused Washington of trying to create "the Asian version of NATO". The North Atlantic Treaty Organization was formed in 1949 in response to the emerging Cold War. The military bloc includes European nations, the US and Canada.

Kim said the US made 2023 "an extremely dangerous year" by trying to provoke a nuclear war. He denounced leaders of both the US and the Republic of Korea for their "hysterical remarks" of confrontation, like the "end of the regime" and "occupation of Pyongyang", in flagrant violation of the principles and purposes of the UN Charter.

"The DPRK remains steadfast and unchanged in its determination to firmly defend the national sovereignty, security in- a power vacuum in northern Syria for oil

terests and well-being of the people against the hostile threats from outside," Kim said.

Lakhvinder Singh, director of the peace program at the Asia Institute in Seoul, said that he "strongly agrees" with Kim's view that the UN Security Council needs to be reformed and Asian countries should be given due representation in the decisionmaking process.

"So far, Western countries have mainly used it to promote their own narrow national interests," Singh said.

Syrian Vice-Minister for Foreign Affairs Bassam Sabbagh said the "policies of creative chaos" adopted by successive US administrations "in our region" serve their geopolitical and selfish interests, and this "led to destabilization and insecurity".

Sabbagh blamed "systematic American plunder" of the Syrian people's national wealth, such as oil and gas, that has deprived his country of its resources.

Political convenience must not determine response to terrorism, says Jaishankar

NEW YORK

EXTERNAL Affairs Minister S Jaishankar on Tuesday said that "political convenience" should not be countenanced in determining responses to terrorism and extrem-



ism in an apparent reference to Canada amid a diplomatic standoff between the two countries.

Addresing the United Nations General Assembly, Jaishankar (pictured) also said that respect for territorial integrity and non-interference in internal affairs cannot be exercises in cherry picking.

He said there is a thrust on the promotion of a rulesbased order and respect for the UN Charter is also invoked and that rules will work only when they apply equally to all.

"But for all the talk, it is still a few nations who shape the agenda and seek to define the norms. This cannot go on indefinitely. Nor will it go unchallenged. A fair, equitable and democratic order will surely emerge, once we all put our minds to it. And for a start, that means ensuring that rule-makers do not subjugate rule-takers. After all, rules will work only when they apply equally to all," he said.

He referred to "vaccine apartheid" and also said that climate action too cannot continue to witness an evasion of historical responsibilities.

"The power of markets should not be utilized to steer food and energy from the needy to the wealthy. Nor must we countenance that political convenience determines responses to terrorism, extremism and violence," the minister said.

"Similarly, respect for territorial integrity and non-interference in internal affairs cannot be exercises in cherry picking. When reality departs from rhetoric, we must have the courage to call it out. Without genuine solidarity, there can never be real trust. This is very much the sentiment of the Global South," he added.

The relations between India and Canada have plummeted over the activities of Khalistani activists including their threats to India's High Commission and Consulates in Canada.

There has been diplomatic tit-for-tat following Canada's decision to expel an Indian diplomat. India said last week that no information has been shared by Canada regarding the killing of a Khalistani terrorist following allegations by Canadian Prime Minister Justin Trudeau.

Answering queries during a press conference last week, Ministry of External Affairs spokesperson Arindam Bagchi said that if there is any country that needs to look at reputational damage, it is Canada.

"I think it is Canada and its growing reputation as a safe haven for terrorists, for extremists, and for organized crime. And I think that's a country that needs to worry about its international reputation," Bagchi had said.

The spokesperson said terrorism is being funded and supported.

"We know this for some time, from our western neighbour Pakistan. But the issue of safe havens and places to operate is being provided abroad, including in Canada... The question is, do we have the political will to address terrorism? Or we want to justify it and condone it," Bagchi had said.

He said he also counts on the developed country to deliver a promise they made in 2009 to give their developing counterparts \$100 billion a year to help

fulfill their green transition. "The fact that finance has not been made available, accessible or affordable has delayed

progress... and that's why the Paris Agreement has not been implemented very much," he said, referring to the agreement reached by world leaders in 2015 to best keep global temperature increases below 1.5 C compared with pre-industrial levels.

The UNFCCC Secretariat earlier this month released a report on the first Global Stocktake, which measures progress towards meeting the goals of the Paris Climate Change Agreement since 2015.

The report said that the window to raise ambition and implementing existing pledges to limit warming to 1.5 C above pre-industrial levels is narrowing rapidly, and international public finance must be strategi-

cally deployed to avoid climate disasters.

Al Jaber said: "Unfortunately, it has been proven that there has not been much progress. We are way off track.'

He said he wished to restore confidence at COP 28, and use the event as a vehicle to turn rhetoric into actions and workable timelines, in the hopes of successfully reducing 22 giga tons of greenhouse gas emissions by 2030, which Al Jaber said was his "north star" and the baseline requirement to keep the 1.5 C target within reach.

"We should no longer be pointing fingers at anybody thinking they are the problem. Our enemy is emission," he said. Xinhua

In his remarks at the UNGA, Jaishankar said the United Nations will be hosting the Summit of the Future next year.

"This should serve as a serious opportunity to drive change, champion fairness and reform multilateralism, including the expansion of the Security Council memberships. We must address global challenges imbued with the conviction that we are one earth and one family, with one future," he said.

Jaishankar said India has entered the Amrit Kaal, a quarter century "where greater progress and transformation awaits us".

"We are confident that our talent and creativity, now so visibly unleashed, will power us forward. The world saw a glimpse of what is to come when our Chandrayaan-3 landed on the moon.

"Today, our message to the world is in digitally enabled governance and delivery, in the widening ambit of amenities and services, in rapidly growing infrastructure, and in our energetic Startup culture. It is visible too in vibrant cultural expressions, such as in the arts, yoga, wellness, and lifestyle. Our latest assertion is in a pathbreaking legislation to reserve one-third of the seats for women in our legislatures," he said.

Jaishankar said he represents a society where ancient traditions of democracy have struck deep modern roots.

"As a result, our thinking, approaches and actions are now more grounded and authentic. As a civilizational polity that embraces modernity, we bring both tradition and technology equally confidently to the table. It is this fusion that today defines India, that is Bharat," he said.

Israel reopens Gaza crossings, lets Palestinians back to work

GAZA

ISRAEL reopened crossing points with Gaza yesterday, allowing thousands of Palestinian workers to get to their jobs in Israel and the West Bank, after nearly two weeks of closure prompted by violent protests along the border.

Around 18,000 Gazans have permits from Israeli authorities to work outside the blockaded enclave, providing an injection of cash amounting to some \$2 million a day to the impoverished territory's economy.

The move comes amid stepped-up international efforts by Egypt and the United Nations to defuse tensions and prevent a new round of armed conflict in the enclave.

For around two weeks, protestors throwing stones and explosive devices have faced off against Israeli troops who have responded with live fire, killing at least one man and wounding dozens more.

Protests on Wednesday were less intense, and so was the Israeli response. A Palestinian official familiar with mediation efforts told Reuters the development came "upon the request of mediators to de-escalate tensions".

Desperate to go back to their jobs, workers began to flock to the Palestinian side of the crossing soon after Israel made the announcement late on Wednesday.

"We want to go to work and earn a living for our children because the situation was too bad for us the past two weeks," said Khaled Zurub, 57, who works in construction in Israel

Cogat, the Israeli Defence Ministry agency that coordinates with the Palestinians, said security assessments would determine whether the border remained open

Hazem Qassem, a spokesman for the armed Islamist Hamas group that rules Gaza and opposes peace deals with Israel, said Israel was constantly violating Gazans' fundamental right to freedom of movement with repeated border closures and the blockade of Gaza.

Israel blocks many goods from entering Gaza with Egyptian backing, citing security concerns, and also reserves the right to restrict exports.

According to IMF figures, per capita income in Gaza is only a quarter of that of Palestinians in the Israeli-occupied West Bank. The World Bank says unemployment is nearly 50 percent.

UN humanitarians concerned over clashes in Mali as peacekeepers withdraw

UNITED NATIONS

WHILE UN peacekeepers withdraw from Mali, UN humanitarians express deep concern over escalating clashes in northern and eastern parts of the country.

The UN Office for the Coordination of Humanitarian Affairs (OCHA) said Wednesday that it was concerned about escalating tensions and clashes in Timbuktu, Gao, and Menaka regions.

The humanitarian office said agencies this year assisted 1.2 million people across the country. But they are only a fraction of the 9 million people in need.

Aid agencies need safe and unimpeded access to affected communities to maintain operations and scale up the humanitarian response.

"They also urgently need additional resources to ensure critical enabling services are in place for humanitarian action, including logistics and mine action activities," OCHA said. Stephane Dujarric, the chief

spokesman for UN Secretary-General Antonio Guterres, said peacekeepers will continue drawdown and withdrawal by yearend in accordance with Security Council Resolution 2690.

"The peacekeepers in Mali are continuing to draw down and withdraw from the country in an extremely challenging security environment, to say the least," he said. Citing reports from colleagues in Mali, Dujarric said clashes in recent weeks in Gao, Kidal, and Timbuktu regions are impacting the mission's drawdown and withdrawal plan.

However, he said contingency plans are also in place in case the security situation continues to deteriorate as it executes the next phase of the drawdown and withdrawal plan. "Up until now ... Ogossagou, Ber, Gundam, and Menaka have been va-

cated and handed over to the competent Malian authorities, he said.

"From Oct. 1 onwards, the mission will use its remaining capacities to focus on its safe and orderly drawdown and withdrawal." In line with the Security Council resolution, the spokesman said the mission will no longer be authorized, nor will it have the means and capacities to respond to imminent threats of violence against the civilian population or to contribute to the safe civilian-led delivery of humanitarian goods and services.Dujarric said the 2023 humanitarian response plan for Mali, which requests 752 million U.S. dollars, is only 22 percent funded, with critical sectors facing even more significant funding gaps.

For example, food security is 18 percent funded; health 17 percent funded; water, sanitation and hygiene only 14 percent funded. "We need more cash," said the spokesman.

In a beauty store in the TaiKoo Li Sanlitun complex, customers were trying makeup in front of augmented realityenabled "magic mirrors," which were able to show beforeand-after images. These "magic mirrors" clearly displayed makeup effects, providing customers with better references in selecting and buying suitable cosmetics.

Shopping malls and districts are important parts of a city's business infrastructure, serving as carriers to promote circulation innovation and nurture emerging consumption.

At present, many brick-and-mortar stores in China are adapting to new changes in demands for consumption upgrades by employing new technologies like 5G, internet of things, big data, cloud computing, artificial intelligence, and virtual reality, in an attempt to construct smart stores, innovate consumption scenarios, and improve consumer experiences.

ACCORDING to recent research from the University of Missouri School of Medicine, there may be another approach to cure cigarette addiction.

Researchers observed that theta-burst transcranial magnetic stimulation (TBS), which uses powerful, rapidly fluctuating magnetic field pulses to influence brain activity, can promote self-control, reduce cravings, and, as a result, lead to reduced smoking.

People with nicotine dependence tend to have significant structural and functional differences in the brain, compared to healthy non-smokers. Smoking cigarettes has been shown to be associated with less grev matter, which means they have less neurons and other cells in the brain.

Research suggests these differences may affect inhibitory control (IC), which is our control over automatic urges and response to stimuli - what enables humans to stop an impulsive reaction to something.

"Having difficulties with IC may make it harder to avoid smoking when the urge arises, in response to all the cues and contexts in the environment that trigger the behavior to light a cigarette," said lead author Brett Froeliger, PhD, professor of Psychiatry.

TBS refers to when magnetic pulses are applied to the brain in bursts of three and come in two forms: continuous TBS (cTBS) and intermittent TBS (iTBS). cTBS consists of applying these three bursts repeatedly for 40 seconds, whereas iTBS applies the same number of pulses irregularly for more than 190 seconds.

Magnetic stimulation has been used to treat other mental illnesses and disorders. cTBS has been experimentally tested to treat generalized anxiety disorder, whereas iTBS to the left dorsolateral prefrontal cortex – a part of your brain responsible for cognitive processes - is FDA-approved for treating major depressive disorder.

The study involved 37 participants, mostly in their late 40's, and examined the effects of both cTBS and iTBS to the right inferior frontal gyrus, a brain region heavily involved with IC. Researchers found that cTBS improved IC, whereas both cTBS and iTBS reduced cravings and, subsequently, smoking.

"Identifying treatments that improve IC may help reduce smoking and can potentially help with preventing relapse following when a person attempts to quit smoking," Froeliger said, adding,

"Treatments that improve IC may also help disrupt the cycle of drug use among individuals with other substance use disorders; however, further research is needed to examine the clinical value of TBS for treating substance use disorders."

Adults with intellectual disabilities are at risk for dementia

INTELLECTUAL disability (ID) is thought to be associated with an increased risk of dementia and its onset is influenced by both inherited and acquired factors. It is also known that a lower cognitive reserve-the capacity for thinking developed by learning and deliberate mental effort-increases the risk of dementia in the general population.

It is hypothesised that dementia is more common in people with ID given the likelihood of a shorter educational lifespan and a reduced intellectual capacity.

The prevalence of dementia among individuals with ID without Down syndrome (DS) in comparison to the general population is unknown, and the risk variables that affect dementia risk aren't fully understood.

Recently, researchers uncovered the prevalence of dementia and identified the risk factors that can lead to dementia among people with ID in Japan. The

team was led by Professor Shintaro Takenoshita, Assistant Professor in the Department of Neuropsychiatry at Okayama University Hospital, Japan. Their findings were published in the journal Alzheimer's Research & Therapy on 18 July 2023.

"Diagnosing dementia in people with ID is difficult owing to the mixed effects of innate cognitive decline and the cognitive decline that occurs over time due to dementia. However, it is quite possible to diagnose dementia if cognitive and lifestyle functions are assessed chronologically based on information from family and other support persons. We believe that even in persons with intellectual disabilities, dementia needs to be properly evaluated," explains Prof. Takenoshita regarding the group's motivation to pursue the study.

The team surveyed the severity of ID, educational history, and comorbidities across 1,831 participants in residential treatment facilities spread across Japan. The relevant data was collected by interviewing caregivers of all the

participants, and a direct examination available could be the first steps in prewas performed-using clinical criteria for dementia and neurocognitive disorders-for participants suspected of having cognitive decline.

Emphasizing the report's key findings, Prof. Takenoshita says, "We found that 6.44% of the participants were diagnosed with dementia. Furthermore, our analyses revealed that dementia was more prevalent in younger people with ID compared to the general population. Lastly, we pinpointed seven factors with significant links to dementia. These were hypertension, depression, stroke, age, severity of ID, duration of education, and traumatic brain injury."

These findings are expected to enable better screening for dementia and improve the support and medical care for people with ID. It is important to note that some of the risk factors are modifiable. Therefore, depending on a patient's profile, providing adequate education, preventing head trauma and stroke, and making hypertension and depression medications readily

venting the onset of dementia in people with ID.

"This is the largest study that explores the prevalence of dementia in a population with ID. Additionally, we minimized the study's bias by surveying participants from a wide geographic range. This implies that the risk factors we identified are reliable targets for designing interventions intended to minimize the risk of dementia in people with ID," explains Prof. Takenoshita.

Moving forward, Prof. Takenoshita is confident that future studies can build on the scope of his team's work. As the understanding of dementia evolves, public health recommendations in medical policies can be developed specifically for people diagnosed with ID. Along these lines, the insights on the modifiable risk factors can potentially help catch the onset of dementia and ensure that people with ID do not miss out on treatment or interventions that are readily available.

Motsepe's vision for rotation gives 'EA Pamoja **Bid' triumph for 2027 AFCON hosting**

URING the previous African Nations Championship (CHAN) held in Algeria, CAF president Patrice Motsepe hinted at a vision for the regional rotation of the Africa Cup of Nations tournament hosts.

Motsepe, like many footballloving Africans, must be tired of the recent dominance by North and West African nations when it comes to the showpiece's hosting.

The mindset of the most prominent man at CAF gives hope to the joint bid, dubbed 'East Africa Pamoja Bid', given the region has not hosted the AFCON tournament since 1976.

Motsepe noted: "We cannot assign the organization successively to the same region."

However, that could be undone by CAF secretary-general Veron Mosengo-Omba, who said such rotation may not always be possible.

The official noted: "Today, only five or six countries out of the 54 Caf members can apply to host (AFCON). Consequently, it will not be possible to make this alternation."

At last, CAF announced that Kenya, Uganda, and Tanzania will host the 2027 Africa Cup of Nations, beating out bids from Egypt, Senegal, and Botswana.

Although the 'East Africa Pamoja Bid' received recommendations from several nations, it was ultimately chosen by the CAF Executive Committee.

As all things are constant, the 'East Africa Pamoja Bid' faced opposition from Senegal who were regarded as front-runners for the hosting rights for two reasons. East Africa has never hosted the continental event and would be viable for CAF to reward the re-

Senegal enjoys the fact that its FA president Augustin Senghor doubles up as the CAF vice president and could pull the strings to earn his country rights to host the showdown, even though they would be required to build five new stadiums before then since they only have a single facil-

ity that meets CAF's interna-Algeria. tional standards.

football enthusiasts have poured cold water on the region's ambition to host the rest of Africa in four years while others remain meet the CAF minimum reoptimistic about getting the

Soccer player Paulinho won't let intolerance of his Afro-Brazilian religion stop his faith

LAGOA SANTA, Brazil

WHEN Brazilian soccer player Paulinho scored a goal at the Tokyo Olympics, he celebrated by pointing an imaginary arrow at the flashing cameras as homage to a deity in his persecuted Afro-Brazilian faith and taking aim at religious intolerance.

Shortly after, he lost more than 10,000 followers on social media for his public gesture paying tribute to Oxóssi- a godly archer who uses his bow to hunt and feed the hungry.

But he says he gradually gained new fans in his soccer-crazed South American country for representing his Afro-Brazilian religion Candomblé and challenging religious intolerance. His religion has faced a rising tide of harassment, sometimes linked to Brazil's fast spread of evangelical Christianity.

"Some players ask me about my religion, they want to know what it's like, ... I always tell them, they listen. But it's still a small minority in soccer," the 23-year-old player for Brazilian club Atletico Mineiro said in an interview at his home outside the southeastern city of Belo Horizonte. "I...get messages about the way I express myself about the faith, some from people who also believe in the faith, but who aren't too outspoken. And it's nice to feel they see something good in what I do.'

Just a small minority in Brazil practices Candomblé. But in recent years there have been increased reports of incidents of religious intolerance against them, particularly at the hands of members of Pentecostal and neo-Pentecostal churches, which focus on spreading faith among nonbelievers.

While most proselytizing is peaceful, some members of African-influenced religions have faced verbal abuse, discrimination and even the destruction of their temples and forced expulsion from neighborhoods

Growing up in Rio de Janeiro, Paulinho said he suffered prejudice because of his faith -- like his mother and grandmother before him.

Although he wasn't as involved with Candomblé at the time, he said he also felt targeted after he started his professional career at popular club Vasco da Gama in 2017.

His mother, Ana Christina Sampaio, recalled feeling offended when parents of other players suggested that her son was thriving on the soccer field only because he was being helped by Afro-Brazilian sacrificial rituals.

"They dismissed Paulinho's talents and effort," she said. "There's religious intolerance, of course, but in Brazil it looks like religious racism against Candomblé.

As Portuguese Catholic colonists brought enslaved Africans to Brazil, those men and women developed blends of their traditional religions with Catholicism. Currently, those faiths are practiced by less than 1% of

Academics and religious-freedom advocates say that Afro-Brazilian religions are sometimes demonized in neo-Pentecostal churches. In rare instances, pastors have been found explicitly directing radicalized evangelicals to dispense violence.

"Candomblé has always been persecuted, the only place in Brazil where their followers are the majority is at Carnival," said sociologist Reginaldo Prandi. He was making note of the popular traditional samba school competition where lyrics citing Candomblé deities, or orixas, have been a constant for decades.

In recent years, samba schools have made a plea to accept people of Afro-Brazilian faith and end religious abuse.

"Prejudice is not enough to annul his soccer skills. If he turns out to be a great player, everybody forgets about his religion. That's Brazil's tradition," Prandi said. "But when he doesn't do well it will naturally be one of the first things people will say."

Paulinho said some of the prejudice he endured, prompted him to leave Brazil for European soccer. In 2018, he moved to German club Bayer Leverkusen in a transfer worth \$21 million. He played 79 matches and scored nine goals in four years. His faith, he said, was never an issue there.

Paulinho now plays for Brazil's Atlético Mineiro, a club that during the 1980s had some of the first outspoken evangelical soccer players in the country. He still dreams of playing in England or Spain.

In Brazil, though, he has become a powerful voice for an often-marginalized religious group.

"People realize that I have a greater understanding and knowledge about our religion," he said. "Looking back... Candomblé has been present in every phase, showing us the way. And now, I can speak with greater confidence.'

Earlier this year, Paulinho once again showed his pride in Candomblé during a game, again stirring his critics and emboldening his supporters. After scoring a goal, he took off his shirt and showed a new tattoo. It read "Áse -- or "energy" in Yoruba, or as Brazilians know it, Axé, which is key to Candomblé.

The backlash came soon after: "Get out of our club, macumbeiro!" an Atletico Mineiro fan said in a posting on Paulinho's Instagram account. That term is sometimes derisively used to describe members of Macumba, which is defined as "a polytheistic religion of African origin ... practiced mainly by Black Brazilians in urban areas.3

In the same post, another club supporter said: "You care more about candomblé and politics than soccer, you shouldn't be here."

she got a standing ovation and grand reception after winning a bronze medal during the recently held Berlin Marathon, the ace runner from Arusha said she is confident of earning a gold medal in France in 2024.

Magdalena participated in the Berlin Marathon in which she finished third in the women's race and, upon landing in Arusha, the athlete said her next major feat is the forthcoming Olympics. The female runner won

the bronze medal after covering the 42-kilometer showdown in Berlin recording 2:18:41 and breaking a national record in the process. She finished third, following Ethiopian and Kenyan female runners.

Magdalena, an athlete from the Arusha base of the forthcoming Olympics in said Tanzania still has ample Paris.

The marathoner disclosed: "I appeal to Athletics Tanzania (AT) to set up a proper preparatory base for the country's Olympics team to ensure that the local athletes get fully equipped to bring home medals".

At the moment, Tanzania has three qualified athletes who will be representing the country in the Paris Olympics next year. The Games are to be held from July 26 to August 11, 2024.

The other two sports envoys happen to be males, Alfonce Simbu and Gabriel Geay both from Arusha, just like Magdalena.

Simbu also promised to work hard to ensure that a gold medal from Paris comes to Tanzania next year in his bag. sha.

However, Simbu said the

time to enlist more local runners to participate in the Paris Olympics.

"We have until May next year to submit the list of athletes that will represent Tanzania to the Olympics 2024 in France, we therefore need more support from stakeholders in the preparation of the national team," Rogath revealed.

He explained that in the next eight months, Tanzania needs to send more athletes to participate in a series of international events so that they may qualify for the Olympics in 2024.
