Samia launches fertiliser subsidy scheme, decries NARCO's record

PRESIDENT Samia Suluhu Hassan yesterday launched a national fertiliser subsidy scheme meant to help farmers to access key farm inputs at nearly half the market price.

Officiating at the climax of the annual Farmers Exhibitions held at the John Mwakangale grounds in Mbeya city, the president said the measure was in response to rises in the price of fertilisers in the global market and help farmers incur lower costs and increase crop production.

The government committed to providing a subsidy package for farm inputs to support

Accordingly, in the current (2022/2023) farming season, Diammonium phosphate (DAP) will be sold at 70,000/- instead of the previous 131,675/-.

The price of urea, which now stands at 124,714/- in the market per 50-kg bag, is cut down to 70,000/-. CAN price meanwhile falls from 108,156/- to 60,000/-, while SA (sulphate of ammonia) will be sold at 50,000/- instead of the previous 87,872/-. NPK fertilizers will be sold at 70,000/-, down from 122,695/- earlier.

Subsidising fertilisers will enable farmers to get the input timely and at affordable prices, the

BoT: Growth rates stable, with inflation pace risks

■ Bank's monetary policy committee stresses adequacy of foreign reserves

TRENDS in economic growth in the first half of 2022 remained stable and in line with central bank estimates for economic growth for 2022, at 4.7 per cent and 5.4 per cent for the Mainland and Zanzibar, respectively.

Prof Florens Luoga, the governor of the Bank of Tanzania, said in a statement yesterday that inflation rose to 4.0 per cent in May and June 2022 owing to the rising cost of imports, even though it still remains within BoT projections of 3.0 to 5.0 per cent for the Mainland and 5.0 per cent for

Implementation of the 2021/22 budget framework was satisfactory and the level of revenue collection has continued to rise, he said, noting that the monetary policy committee is closely following up the inflationary spiral, occasioned by "rising prices of imported goods."

Germany extends 23.7bn/- to tame wildlife conflicts, up gender justice

GERMANY yesterday signed a euro 10m (23.7bn/-) grant agreement with the government for mitigation of human-wildlife conflicts, access to justice for women and children, plus feasibility studies and paying experts.

Emmanuel Tutuba, the Treasury permanent secretary, said at the signing ceremony that out of the money euro 6m is meant for humanwildlife conflict (HWC) mitigation, to help strengthen capacity to better manage conflicts in areas surrounding game reserves.

Z'bar wants robust plans to cut food import needs

KEY lessons from current global challenges in grain, edible oil and fertilizer imports is to develop robust plans for food self-sufficiency, Zanzibar President Dr Hussein Ali Mwinyi has declared.

Gracing the Farmers' Exhibition at Dole fair grounds in Unguja West A District, the president tasked the Ministry of Agriculture to set out strategies to drastically reduce dependence on food imports.

He said the world is faced with many challenges that impact on food security and transportation, especially in the wake of the Covid-19 pandemic, intensified by



the Russian invasion of Ukraine This has magnified risks in accessing grain, edible oil and fertilizer shipments, he stated.

The agro-sector exhibition was themed "farming is business, participate in the census for better agricultural planning," with the president pointing at the state of panic for grain supplies, with several agroproduce surplus countries moving to control export of grain and other food products.

Zanzibar was facing the fallout of these steps, witnessing the rising prices of basic food products and engendering inflation, he

To mitigate the situation, the government has reduced taxes and levies on basic goods to subside the costs, which has in turn affected revenue collection and heightened expenditure needs. "But it is the government's responsibility to reduce the burdens that the people face," he declared.

Agro-based outreach activities and farm sector investments will enable Zanzibar to make big strides in developing commercial farming, he stated, reminding the Ministry of Agriculture of its responsibility for strategies to move away from dependence

president said.

Agriculture minister Hussein Bashe meanwhile set out in detail how the ministry would monitor in real time the distribution and sale of fertiliser as each bag sold bears a digital code and all eligible farmers will be registered beforehand.

Farmers need to utilise the subsided fertilisers by expanding their fields and production to ensure enough farm produce for their own sustenance and for sale, the president urged.

The subsidy policy will not be permanent, "so whenever the chance comes, the farmers have to utilize it well," she said, noting that the government is making efforts to increase local production of fertilizers to check dependency on imports.

The government has increased the farm sector budget from 294bn/- to 954bn/- in the current fiscal year to address challenges in irrigation, extension services and construction of storage facilities in rural areas. The idea is to achieve 10 percent agriculture sector growth by 2030, she stated.

Data gathered in 2020 show that farming is relied upon by 65.9 percent of the workforce, and makes 65 percent contribution to raw materials for local industries, indicating that the sector was in tandem with demand for food and commercial produce globally, he

The government has continued to create a conducive environment for investors to put funds into big agriculture projects, increase production and strengthen food security here and in the sub-region,

Pointing at the youth, the president said they have to utilize opportunities in farming as the government plans to set aside farms with title deeds to young people interested in working in

She also urged farmers to ensure that they register in the fertilizer marketing

invests heavily in increasing local production so as to strengthen supply of the products and reduce imports,"

She similarly remarked that the National Ranching Co. (NARCO) wasn't fulfilling its required role but invests efforts to take care of livestock owned by private individuals.

This prevents the entity from operating commercially, she said, noting that in all 14 ranches with a total of 155,554 animals just 22,842 were owned by NARCO.

"NARCO owns only 15 percent of all livestock in the ranches. The company has failed to fulfill the goals of its establishment," she stated, directing the board of directors to conduct an assessment of all ranches and lending

They should explain if they are paying and perhaps dissolve all blocks and make better use of the blocks for the government to benefit. "I want this to be conducted immediately as the ranches were only benefiting a few people and not NARCO or the government. We need to address this and ensure that the ranches starts to inject funds as per the goals set out," she emphasized.

Upwards of 21 irrigation contracts taking up 182bn/- were signed before the president, covering 12 districts in seven regions, totaling 26,700 hectares.

Minister Bashe said that once completed, the projects will create 102,159 employment opportunities and enhance rice production by 97,300

The irrigation budget has grown from 57bn/- in the 2021/22 financial year to 416bn/- in the current budget, indicating a sharp thrust towards agrosector uplift.

"We will commence with the Membe irrigation project in Dodoma, involving a youth block farm of 8000 acres. It will have a huge dam to ensure water is available," he said.

Govt provides 169bn/- for building 60 vocational colleges nationwide

THE Government has provided a total of 168.7bn/- in FY 2021/2022 and 2022/2023 for constructing 60 VETA colleges in various districts countrywide.

This was revealed to the Prime Minister, Kassim Majaliwa by the Acting VETA Director General, Anthony Kasoleat the weekend during the PM's inspection and the laying of the foundation stone of the Ikungi District VBETA college project.

Majaliwa is in Singida District for the inspection of development projects implemented by VETA.

Kasole said in FY 2021/22 the government has provided 68.7bn/- to the Ministry for Education, Science and Technology for the construction of 25 district VETA colleges, the Ikungi one being one of them.

of the Ikungi VETA College the Government provided 2.3bn/- and additional 893m/- from the Covid-19

"The Ikungi VETA College project will comprise 17 buildings and we have acquired a 50-acre land area whose title deeds has been issued," he said.

Kasole added that in FY 2022/23 100bn/- has been provided by the government for the construction of 35 other District VETA colleges and He said in regard to the construction a regional VETA College in Songwe District.

breastfeeding - it pays, says expert

MEN engagement is said to be among the best strategies to ensure mothers practice exclusive breastfeeding (EBF) which is crucial in tackling mental retardation in children.

Dr Grace Mosha, a nutritionist from the Ministry of Health, said that at times women do not breastfeed their children over fear that lactation will adversely affect the appearance of the breasts.

Dr Mosha was speaking recently during a seminar to journalists being part of celebrating the World Breastfeeding Week (WBW).

"Women should exclusively breastfeed their children to save children from diseases and mental retardation. Breast milk is rich in the nutrients that help brain growth and nervous system development. It has immune cells and other substances that prevent infection," she said.

She said that breastfeeding should continue even when mothers are pregnant, adding it is important children are breastfed for at least two years to ensure their proper growth.

Officer, Nutritional Herieth Lumanyika said statistics indicates that 53.5 percent of infants are breastfed within an hour after they are born.

According to data, 58 percent of children are exclusively breastfed for six months while 92.2 percent are breastfed for at least one year. Only 43 percent of children are breastfed for two years. She said children must be breastfed for at least two years to complete the 1,000 days of breastfeeding.

Lumanyika said 87 percent of children are fed other types of food at proper age while 35 percent are given nutritional foods that are suitable for their age.

"Most of the parents do not have proper education on the types of food to give their children at different growing stages. Most of the children are being fed porridge only, which is not right," she added.

The World Alliance for Breastfeeding Action (WABA) coordinates and organises the World Breastfeeding Week between August 1 and 7.

The World Health Organisation (WHO) recommends exclusive breastfeeding for the first 6 months of life, followed by continued breastfeeding with appropriate complementary foods for up to 2 years and beyond.

According to WHO mothers should be supported to initiate breastfeeding as soon as possible after birth, within the first hour after delivery and should receive practical support to enable them to initiate and establish breastfeeding and manage common breastfeeding difficulties.

Tanzanians called upon to embrace organic farming

TANZANIANS have been urged to embrace organic farming and invest in the area as much as they can due to its numerous benefits and the growing demand of the products locally and in the foreign markets.

An expert from the Sustainable Agriculture Tanzania (SAT), Mbwana Rwambo made the call in Morogoro during the weekend at the farmers exhibitions, saying that organic agriculture has low costs and ensures safety of both farmers and consumers.

"We should together convince the farmers to go organic. There are challenges due to low awareness but if this education reaches as many people, we can have a country that produces more organic food and related products," he said.

He said "When farmers embrace organic agriculture, their production process gives them the first round of safety, then the consumer as well. Farmers should embrace organic agriculture so that they can enjoy more harvest, good health as well as conserve the environment."

said SAT, through implementation of various projects, has been instilling organic farming knowledge and skills among the groups of farmers thus promoting natural and conservation farming which eventually help to improve income and reduce conflicts.

He urged farmers and pastoralists to have a vision of their activities which include investing in producing quality products, packaging them to sell in local and international markets.

"Organic farming pays a lot, a growing demand of naturally produced food products call for more people to embark in this farming, there is no cost of artificial fertilizers and pesticides, so farming costs are low compared with

the normal farming, we encourage Tanzanians to see this opportunity so as to improve their income and stay healthy," he explained.

In June this year, Prime Minister Kassim Majaliwa said that the government was working on a plan to invest heavily in promoting organic farming which includes advising farmers on proper use of pesticides so as to increase yields.

He told the Parliament that the strategy was aimed to help the country's agriculture shift to organic farming and get rid of using industrial fertilizers and pesticides for sustainable development.

"The government has witnessed how organic farming is doing well, we have seen it in various crops such as maize, coffee, tea and others. So we are going to ensure that we strengthen organic farming and attract more farmers to take this as their sustainable activity which will transform their incomes and lives for the better," he said.

The premier's statement came in response to a question raised by Special Seats MP, Asha Abdullah Juma who said many countries in the world had started preventing the use of industrial fertilisers and pesticides in agriculture and instead they are focusing more on developing organic farming but Tanzania was still back in making decisions.

He said the government will also introduce a special department in the ministry of agriculture for supervising and motivating farmers to engage in organic farming.

"In land where there is no need to use artificial fertilizer, the farmers are encouraged to embark on organic farming and I have witnessed a number of coffee, tea growers reaping big from the crops only by using organic methods, pesticides and fertiliser," Majaliwa added.

Dr Fidelice Mafumiko, the Government Chief Chemist made the caution yesterday after touring the Southern Agricultural Growth Corridor of Tanzania (SAGCOT) pavilion at the ongoing Nanenane Agricultural Exhibition held in Mbeya region.

He said the government through the Government Chemistry Laboratory Authority (GCLA) was ready to conduct awareness to the farmers, livestock keepers and fishermen to help them to know the right use and safe use of chemicals to get quality yields.

"I commended SAGGOT for the continuous efforts to ensure all stakeholders get knowledge about correct use of chemicals to enhance food security, improve livelihoods and ensure environmental sustainability," he said. "Under SAGGOT coordination GCLA has trained 30 business men in the agriculture, livestock and fishery value chain about the role and the laws," he added.

He called upon the stakeholders to use the GCLA to test the quality and security that will help to increase the quality of the products.

He further urged other stakeholders using chemicals in agriculture and livestock to contact the authority to get knowledge on how to destroy chemicals.



International Day of World's Indigenous Peoples should not avoid sustainable development issues

NE international day event that is unlikely to be missed in local corridors of the fraternity of non-governmental organisations in Tanzania is the International Day of the World's Indigenous Peoples. It was first pronounced by the United Nations General Assembly in December 1994, with a whole decade devoted to that theme at the UN, the first international decade of indigenous peoples, from 1995 to 2004. This is a theme that UN activists have made a pointed effort to uphold, intensively.

A UN chronicler says that in 2004, the General Assembly proclaimed a Second International Decade from 2005 to 2015 with the theme "A Decade for Action and Dignity" The key issue was that people from different nations were encouraged to participate in observing the day, to spread the UN message on indigenous peoples, its activities focusing on educational forums or classroom activities "to gain an appreciation, a better understanding of indigenous peoples." It is an exotic issue to a huge number of activists, where the crucial issue is to protect their way of life.

It goes without saying that in that outlook, what matters is to let indigenous people remain on their ancestral lands without the slightest disturbance from what they often call 'human activities,' which by definition destroy the environment. In other words there is an inbuilt anti-development and pristine nature ethos which makes indigenous people a de-facto ally to what amounts to rejection of development, couched in nature protection terms, singularly. That is why for each strategic project the government takes up, whether it is a road from Arusha to Musoma or a hydropower project on a tiny piece of

land inside limitless jungle, an uproar

stars. It took around 12 years to attain the International Day of the World's Indigenous People resolution. The chosen day, August 9, marks the day of the first meeting in 1982 of the UN Working Group on Indigenous Populations. It noticeably is described as a sub-commission on the promotion and protection of human rights.

That is where developmental thinking and activism cross hairs, as the content of human rights in this context isn't enabling life, protecting it (for instance via health and educational services, apart from uplifting income generation activities). What is targeted in the UN definition is the right to be indigenous. Altering that outlook via education or transforming housing or manner of dressing is at times described as cultural genocide by activism. Plainly seeing them as a special group of humans.

A substantial follow-up occurred more than a decade later, in 2016, where UN-linked reports affirmed that about 2,680 indigenous languages were in danger and on the verge of becoming extinct. In that case the UN designated 2019 as an International Year of Indigenous Languages "to persuade, convince and create awareness to people about indigenous languages.

fuel prices being acutely felt in national economic life, the fact that Tanzania has substantial reserves of natural gas which is usable for motor vehicles is starting to get the sort of attention it has minimally obtained up to now. When petrol prices are feasible for motorists, getting people to change to using gas would be like a change in fashion, but it includes altering a number of things in how a vehicle operates. That needs money and isn't paid for by public authorities.

As petrol prices are already a menace, partly for what they already are and similarly as the situation in the future is more or less unpredictable, gas use seems to be a solution. The Tanzania Petroleum Development Corporation (TPDC) has been making contingent plans for that situation over a period, more than a year definitely, and seem to be elevating what they have been doing a notch higher. The trouble is that it is unclear whether there is a pilot project about using gas that is being conducted, or it is already commercialized.

In case the latter interpretation is correct, it follows that there is a careful plan to move into the market, on a slow pace of issuing tenders, which is hard to interpret. Do petrol sellers tendered by anyone for the purpose? If not, can't conversion to gas just take the same format?

There was an announcement at the weekend that TPDC is receiving tenders for the construction motor vehicle gas selling stations, one of them at the University of Dar es Salaam, and three others at Muhimbili. Other areas

TITH the rise in global would in that sense have to wait for a year, and so far it is lorries that are targeted, whereas petrol stations can organize such chambers on the basis of the facilities they have. Similarly, it is uncertain if a tender is needed at UDSM or elsewhere to make such changes on vehicles, as any good mechanic can download a formula and they brainstorm, etc.

> A top official at TPDC said the parastatal was now proceeding with making a selection, citing next Friday as the last day to receive tender bids. There was no additional explanation why it shouldn't just be a technical issue with the relevant body, the Tanzania Bureau of Standards (TBS) being charged with the quality of the mechanical work involved, and the Energy and Water Utilities Regulatory Authority (EWURA) inspecting the separation of facilities, pricing of the gas filling branches, and other attendant aspects. The revenue authority would in a sense opt to set up a distinctive reporting mechanism by specialized EDFs, etc.

> There is every possibility that the pace of conversion quicken up, rapidly enable faster cost cutting when vehicles shift to gas en masse within this financial year. That means specialized mechanics and companies that can offer such services simply be free to do so, and each regulatory authority remain within its current precincts as relates to the oil and gas industry. As the adage goes, the issue of initiating a rapid shift from using imported petroleum on all vehicles countrywide, or the pace of that conversion, is far too important to be left to TPDC exclusively.



Global warming and human security in Africa

warming LOBAL contributing to more and extended heat waves, a tripling of droughts, a quadrupling of storms, and a tenfold increase in flooding since the 1970s in Africa, exacerbating security threats on the continent.

Measuring women's empowerment in Benin, Malawi and Nigeria

66 WOMEN'S capacity to exercise time-use agency is conditional on gendered power dynamics and other barriers within households, which together are reciprocally related to local gender norms that dictate how women should spend their time."

Time use, or how women and men allocate their time, is an important element of empowerment processes. Target 5.4 of Sustainable Development Goal (SDG) 5 seeks to "recognize and value unpaid care and domestic work through the provision of policies and the promotion of shared responsibility within the household and family", while Target 5.5 aims to "ensure women's full participation...at all levels". To integrate more fully the literature on time use and agency, this article proposes a new concept called time-use agency: an individual's confidence and ability to make and act upon strategic choices about how to allocate one's time. Using qualitative data collected with women and men engaged in onand off-farm agricultural livelihoods in Benin, Malawi, and Nigeria, it examines normative expectations about women's and men's time use and

(or not) over the use of their time. The aim is to explore time-use agency as a component of empowerment.

The article presents formative research to explore the salience, underlying components, experiences of time-use agency gleaned from 92 semi-structured interviews conducted as part of three qualitative studies linked to gendersensitive agricultural development projects in Benin, Malawi, and Nigeria. Among other things, these projects, which are detailed in the article, aimed to increase women's involvement in and earnings from market-focused agricultural activities, thereby increasing demands on their time and placing them in new roles in their communities and households.

The article organise the results following a socio-ecological model. First, it presents the context of opportunity and constraint, outlining normative expectations of men's and women's time use and the gendered nature of structural inequities in time poverty. In all three country contexts, most women and men described prevailing normative expectations about how men and women should spend their time. Such expectations

as the provider, decision maker, and protector of the household. For women, expectations centred on their role as unpaid caregivers responsible for domestic responsibilities. Many women across the sample shared experiences of disproportionate time burdens in fulfilling their expected roles and responsibilities, primarily in relation to household chores such as cleaning, childcare, and food preparation. Examples provided here highlight the higher value placed on the typically remunerative work to which men allocated time and the diminished social values placed on women's typically unpaid domestic labour and care work.

The analysis then explores time-use agency concepts, such as awareness of inequalities in control over men's and women's time use. For instance, a woman in Benin highlighted the potential consequences women who break norms face, inducing a level of fear she could lose her household (or security, children, etc.). This dynamic helps to prevent a woman from deviating from norms, reinforcing the notion that she does not have control over her time. In contrast, men are not similarly constrained. In all three study

their experiences of exercising agency for men centred around their role sites, several men and women shared examples of expressing their voice to convey concern or desire about how to spend their own time and feelings regarding how their spouses spent their time. In Benin and Malawi, this discussion centred around a woman attending an agricultural training programme. In general, women shared some control over deciding when and how to spend their time on normative and expected tasks and responsibilities, but men controlled the decision making on all tasks beyond such activities. Discussions of perceived conflict about time use are resolved by the husband's authority across all three countries and highlight various patterns of negotiation that women may employ to mitigate conflict or influence the result to achieve desired outcomes.

"These findings suggest that timeuse agency is important for fully understanding empowerment with respect to time use. While time poverty often serves as a proxy indicator of one dimension of empowerment (or disempowerment), it does not elaborate on the extent to which one is able to choose and then to spend and manage one's time to

ENYA, with a gloomy and sordid history of fierce electoral disputes and violence, s scheduled to hold general elections on Tuesday 9 August 2022. In these elections, citizens will elect the president, members of the National Assembly and Senate, county governors as well as members of the 47 county assemblies.

Electoral trajectories of modern Kenyan politics

The build-up to these elections is engulfed by the fall-out of former allies and strongmen in modern Kenyan politics: the incumbent president, Uhuru Kenyatta and his current deputy president, William Ruto. The root cause for their loggerheads is unquestionably submerged by incongruencies of accusations levelled against each other.

More intensely, even though Ruto was Kenyatta's running mate in the last presidential elections that took place in 2017, Kenyatta is hell-bent on impeding the deputy president from being his successor.

A major variable of this twist emanates from Kenyatta's endorsement of the perennial candidate in the presidential elections who is also a former Kenyan prime minister, Raila Odinga. The latter is a presidential candidate for the Orange Democratic Movement (ODM) under the auspices of the Azimio La Umoja coalition.

Interestingly, during the 2017 presidential elections, Kenyatta joined forces and formed a functional alliance with Ruto. After the electoral management body, Independent Electoral and Boundaries Commission (IEBC), declared the duo as election winners, Odinga lodged an electoral dispute based on rife allegations of vote rigging. Principally, adducing concrete evidence that proved that IEBC's server was hacked and its database had been tampered with.

Fifth time lucky? Raila Odinga targets triumph in Kenya presidential election

Eventually, the Supreme Court of Kenya, led by the present-day retired Chief Justice and President, Justice David Maraga, annulled the results of the presidential elections and ordered fresh elections.

To ensure free and credible election re-run, Odinga further requested for the overhaul of electoral systems, and his plea was not granted. While protesting the failure to heed his call for Visit Daily Maverick's home page reforming electoral systems and the

IEBC, and although not official as dictated by Kenyan electoral laws, Odinga withdrew from the runoff election, thus paving the way to the duo's electoral victory again.

Odinga's perennial candidacy in presidential elections

Raila Odinga, the son of Oginga Odinga, Kenya's first vice-president (from 12 December 1964 to 14 April 1966) and subsequently opposition leader, has unsuccessfully contested the presidential election four times in 1997, 2007, 2013 and 2017.

Boasted by the support from Kenyatta, Odinga's fifth contestation in presidential elections may spell a greater chance to lead Kenya at the age of 77 years. Comparatively, Hakainde Hichilema, the current president of Zambia, contested the presidential election five times: 2006, 2008, 2011, 2015 and 2016, before being triumphant in the 2021 presidential election, accumulating over 59% of the vote.

With the considerable support of president Kenyatta, the incoming presidential elections may either deliver Odinga to the State House or indefinitely

condemn him into his undesirable perennial candidacy. Possibly, a fifth unsuccessful presidential contestation may compel Odinga to gracefully retire from active politics.

Kenyatta's choice for Odinga

In the aftermath of unsuccessfully contesting four times in elections, loathness for a fifth attempt to run for the position of Kenya's presidency overwhelmed Odinga. This reluctance was unveiled by president Kenyatta during a congregation with Luo and Luhya leaders in Nyanza. In fact,

Kenyatta induced Odinga by asserting that he was the sole alternative who could emerge victorious against Ruto. The latter is the presidential candidate for the United Democratic Alliance, which is the largest party under the Kenya Kwanza coalition.

Kenyatta points out that he has overlooked other presidential hopefuls such as Musalia Mudavadi, Kalonzo Musyoka, Peter Kenneth, Fred Matiang'i, Justin Muturi and Dr Mukhisa Kituyi. While Odinga's running mate is Martha Wangari Karua, the Kenya Kwanza Coalition has opted for Rigathi Gachagua as the deputy presidential candidate aligned with

The smoothened relations between president Kenyatta and Odinga owe their threshold to the popular 'handshake' between the two newly found allies, which occurred on 9 March 2018. The 'handshake' is the labelling of the unforeseen political allegiance between them. Within the pair's lenses, this signalled the end of tension, distrust and hostilities and envisioned a mandatory roadmap for devising common ground for driving forward the economic and political interests of Kenya.

'Handshaking' into the succession plan?

In the view of Kenyatta, Kenya's prospects of eradicating endemic corruption stem from Odinga's ascension into the presidency. This bold statement may be construed as an implication that Ruto's leadership could plunge the country into irreversible bad governance. More so, to Kenvatta, since their momentary 'mandshake', Odinga had demonstrated goodwill, whilst Ruto has resorted to divisive politicking that negates the country's progress.

Importantly, having previously vied for the presidency four times, with divisive politics, electoral rigging, and subsequent politically motivated violence, perhaps the endorsement of Odinga may change the political landscape of Kenyan elections. Nevertheless, for president Kenyatta, his succession plan is not merely confined to the quest for national cohesion, but also development.

All factors considered; 25 years since his first presidential contestation in 1997, one may still ponder if Raila Odinga can triumph in his fifth attempt to lead Kenya as president.

AILA Odinga, 77, lost the past three previous and disputed Kenyan presidential contests, out this time polls show him winning in the first round with more than 53%. That would avoid an even more tense run-off against Ruto, 55. Some analysts caution that Ruto, running on a populist ticket, could "do a Trump or a Brexit" and outpace his chief rival on the home straight.

The potential for violence when the results come in is always quite high in Kenya and every election inevitably raises the spectre of a replay of the killing of more than 1,100 people in the political violence, mainly in the Rift Valley, after the 2017 polls.

Few are expecting anything on that scale this time, though the potential for violence still remains high, according to a report by the independent National Cohesion and Integration Commission, because of old conflicts and mistrust of institutions.

In particular, neither ordinary Kenyans nor analysts nor politicians have gained much faith in the Independent Electoral and Boundaries Commission (IEBC). After Uhuru Kenyatta beat Odinga in the August 2017 elections, the Supreme Court annulled the results because it said the IEBC had run them so badly.

The court forced a run-off which Kenyatta won after a boycott by Odinga because he said the IEBC remained unreformed. Analysts say the IEBC has still not changed fundamentally. It even has the same chairperson, Wafula Chebukati, though it has made some changes to the systems which failed in 2017.

'Illusion of choice'

Some analysts have characterised this election as "the illusion of choice", because it offers so little that is new, as it is effectively a two-horse race in which Kenya's 22 million voters can really only pick between two veteran politicians who have alternated between fighting each other or allying with each other in several successive previous polls. Yet the poll is unusual in one way. President Kenyatta - who has to step down because he has completed his constitutionally limited two terms – is backing his old rival Odinga in the election, not his own vice president Ruto.

Kenyatta and Ruto fell out in 2018, ending a two-decade partnership dubbed "Uhuruto', and Kenyatta instead launched an unexpected new alliance with his old rival Odinga with a famous public "handshake."

That has put Ruto in the awkward position of being the opposition candidate while Odinga has conversely become in effect the incumbent candidate, backed by Kenyatta – and by state resources.

In 2017 the IEBC failed mainly because of the failure of its system for electronic checking of voter identities and for transmitting results from the country's 40,833 polling stations to the central counting centres. The number of polling stations has now climbed to 46,233.

Since 2017, the IEBC has introduced manual systems – including a requirement for the paper forms certifying the results from all the polling stations to be physically transported to the IEBC central counting centre in Nairobi – as a backup to the digital systems, but some analysts warn that the system is still not tamper-proof.

The results could depend in part on how the IEBC performs but also on how

successfully each candidate gets out his voters, as Nic Cheeseman, Gabrielle Lynch and Justin Willis note in an article in The Elephant, a Kenyan online journal.

Youth swing vote

The critical swing vote could come from youth, about three million of whom lack unemployment. This has created considerable voter apathy so that the IEBC could register only 2.5 million new voters for this election well short of its six million target.

Odinga's Azimio La Umoja alliance ("Resolution in Unity") a coalition of seven major political parties, has the more efficient party machine to ensure its supporters actually vote.

Ruto, backed by his Kenya Kwanza alliance ("Kenya First") of nine parties, is pitching his campaign as a contest of "Hustlers" versus "Dynasties" - ie of ordinary Kenyans battling to make ends meet in a tough economic climate versus political elites. Ruto is playing on the fact that both Odinga and his main backer Kenyatta are scions of old political families. Kenyatta's father Jomo Kenyatta was independent Kenya's first president and Odinga's father Oginga Odinga was his vice-president until they fell out in 1966.

Ruto is appealing especially to the

disenchanted youth. He has promised to hand out major funds and programmes for them, in part funded by targeting "wealthy dynasties", for wealth and land distribution.

Odinga has countered with promises such as a monthly grant of 6,000

shillings (about \$60 or R1,000) to two million vulnerable Kenyans. No one seems to have much faith that many of these promises will be kept after Tuesday's poll results are in.

Odinga in narrow lead

Ruto was clearly ahead of Odinga earlier this year - by 38% to 27% according to one poll, but in the past

few weeks Odinga has pulled past him into a narrow lead. Odinga apparently overtook Ruto at the point when both chose their running mates. Ruto chose Rigathi Gachagua, an MP with little political profile, who faces money laundering charges. Odinga, by most accounts, made a far better choice in Martha Karua, a high court advocate and veteran of the struggle for multi-party democracy. Karua has solid anti-corruption credentials and she will attract women voters.

Both Gachagua and Karua are members of Kenya's largest ethnic group, the Kikuyu, and both were strategic choices by Ruto and Odinga. Ruto is a Kalenjin and Odinga a Luo and both clearly felt the need to get Kikuyu backing.

In the past, Kenya's shifting electoral coalitions have pitted different ethnic groups against each another.. Having Kikuyus on both tickets should help defuse the ethnic tensions which triggered so much of the political violence in the past.

"Some Kenyan observers say that the selection of Kikuyu running mates sends a powerful message that Kikuyu, Luo and Kalenjin elites can work together and....move past ethnicbased politics," the Africa Center for Strategic Studies says.

It notes that in previous elections Kikuyu and Kalenjin clashed over contested land in the Rift Valley, while Kikuyu and Luo also battled, in part over the Luo's complaint that they have always been cheated out of power and privilege. If Odinga wins on Tuesday, he would be Kenya's first Luo president.

Kikuyu outreach effects

The outreach of both frontrunners to the Kikuyu has also changed the campaign dynamics. Cheeseman,

Lynch and Willis note that while Odinga has maintained his traditional Luo stronghold in Nyanza near Lake Victoria, and Ruto has maintained his lead in his Rift Valley backyard, "the rest of the country will likely split

"While the majority of citizens in Nairobi, North Eastern and at the Coast appear to be backing Odinga, competition remains fierce in both areas. Similarly, while Ruto retains a lead in Central Kenya, the vote in Eastern is divided between the two candidates, and both alliances know that they can secure significant votes in all of these areas."

Though the margin between Odinga and Ruto is very slim, analysts say what is encouraging for Odinga is that he has momentum as his support has been increasing by about 5% in each successive poll and also because his supporters tell pollsters they are more certain of voting for him than Ruto's supporters are to vote for him.

Yet analysts also warn that many polls are conducted by phone and may be missing poorer voters who are more likely to vote for Ruto because they are attracted by his "hus-

Some analysts predict that in such a close contest the backing of Kenyatta and the state machinery is likely to help Odinga cross the line first, no matter what happens on Tues-

Though many analysts are predicting a second-round runoff between Odinga and Ruto because the race is so close, others believe because the other two presidential candidates have so little support, Odinga could in fact attain the 50% plus one vote that he needs to avoid a runoff.

This is particularly so since the third-runner, George Wajackoyah – a former spy and now a lawyer who gained some support by calling for the legalisation of marijuana recently threw his support behind Odinga, though he remains on the ballot.

Monitors

Several major international election observer groups are in Kenya to monitor the elections - including those from the African Union, the European Union, the Common Market of Eastern and Southern Africa (Comesa) the Intergovernmental Authority for Development, the Commonwealth, America's Carter Center, South Africa's Electoral Institute for Sustainable Democracy and the Brenthurst Foundation.

However, the key watchdogs will probably be the 5,108 local observers deployed across the country by Kenya's Election Observation Group (ELOG), a coalition of civil society groups.

Critical to their success will be their parallel voter tabulation system (PVT) of separately registering and recording a sample of results at polling stations and constituency counting centres to check against any tampering with the results by the IEBC during transmission, as ELOG chairperson Ann Ireri explains.

The media is also expected to play a key role in verifying the IEBC results by likewise reporting the results independently from some of these stations and centres.

All observers and analysts agree that the critical moment in these elections – like those in the past – will not be on voting day on Tuesday, but when the results start coming in in the following days.

Though almost all the attention has been on the presidential race, Kenyans will have to vote six times on Tuesday – also for the governors of 47 counties, for national senators and members of the national assembly, for special seats allocated for women members of the national assembly and for members of county assemblies.

'Legal framework is crucial in curtailing stunting in children'

LACK of legal framework to coordinate and link experts in the nutrition sector hinders the war against stunting in children in the country, it has been said.

Celestine Mgoba, researcher at the Tanzania Food and Nutrition Center (TFNC) called for enactment of a law which will create a pool of experts working on nutrition to empower the center in the fight against stunting.

One of the existing was that the Tanzania Medicines and Medical Devices Authority (TMDA) is under the ministry of Health while the Tanzania Bureau of Standard (TBS) is under the ministry of trade a move which makes the war uncoordinated because the experts feel they are in two different

He said there is no legal framework to regulate management of food supplements to guide processors a move that drags the war against stunting in under-five children.

He said nutritional researchers in the country have been working in providing education aimed at informing processors on the type and level of supplements needed to be

The National Nutrition Status Report 2018 shows that 32 percent of children under five are stunted, dropping from 35 percent in 2014.

Dar es Salaam is one of the leading regions with poor nutrition and stunting on a large scale, in other regions are Kagera, Kigoma, Mara, and Dodoma.

The situation forced the government in 2017 to launch the Tanzania National Multi-Sector Nutrition Action Plan 1 (NMNAP) with the aim of reducing the stunting rate among children under five years from 34 percent in 2015 (TDHS



2015/16) to 28 percent in 2021.

tion in the country.

However, until last year, it had not

achieved the goal because the report shows that the country still has stunting and lack of nutrition at 32 percent. This means that the strategy of putting nutrients in the mentioned food products has not reached the target.

Maize flour is the most eaten food in Tanzania, although the law ordered the flour to be fortified as one of the ways to reduce poor nutrition and stunting, the issue has not brought good results because only a small amount of fortified maize flour is sold in the shops.

Omar Shabani one of the small maize millers who said that he does not see a reason to add nutrients to flour because customers do not like to use flour with such nutrients.

"I'm looking at the market's demand my sister, if customers don't want flour with nutrients, why should I put it? When the time comes, I see that there is a need to put nutrients in the flour, I will put it, I don't want to lose my customers," he said.

A retail shop owner at Tabata, Dar es Salaam, Shabani Ally (39), said that when she goes to buy flour, she pays more attention to the quality of the flour because many customers of the product like soft flour.

The idea was supported by Dorkas Michael (45), a restaurant owner at Kariakoo, Dar es Salaam who says that she has not considered buying flour with nutrients because she has never heard of such a thing.

The liaison officer of t SANKU, International Institute that supplies food nutrients to maize, Paula Kawiche, said that Tanzania has 23,000 small flour processors but only 600 receive nutrients.

An officer of Dar es Salaam, Janet Stanley, said the Ministry of Health has noticed the challenge through their officers who visit millers to raise awareness, provide education and measure the level of nutrients, and they are working on

Nine firms sign agreements on the distribution of subsidised fertiliser

NINE firms importing fertiliser into the country have already signed agreements on subsidised fertiliser distribution.

He said more firms are still in the process of signing the agreements to enable them distribute subsidized fertiliser to farmers.

These signing of these agreements are the continuation of the process to make sure farmers receive subsidized fertiliser in time for them to use at the start of the farming season.

Dr Ngailo said that fertiliser importing or producto support local farmers ing firms will pack them to access key agricultural in 25 and 50kg bags with a inputs at affordable prices.

subsidy note written "subsidies fertiliser" and printed with a barcode to ease TFRA monitoring.

After being registered, farmers will access the fertilizer at a registered agent by showing an indication number obtained during registration, handed the fertilizer after the agent verifies that identification online, to check eligibility for subsidized inputs, he explained.

Malawi moves 263 elephants to restock degraded national park

EARLY one July morning, a helicopter with wildlife officials on board flies above the forests of Malawi's Liwonde National Park in search of elephants. Within half an hour, a small herd has been spotted and the crew radios a support team on the ground.

As the ground team gets in place, the pilot maneuvers the plane to herd the four elephants to an open area, descending low enough to allow the experts on board to fire tranquilizer darts at the elephants. It will take less than 8 minutes for the sedative to take effect, the officials say.

As soon as the animals are down, the ground team starts taking measurements, collar-

ing and labelling the elephats before tying ropes to their feet, hooking them to a crane and lifting the elephants into trucks. There, an antidote is administered to reverse the effects of the tranquilizer and get the elephants back on their feet ahead of the 350-kilometer (217-mile) journey to their new home in Kasungu National Park.

These scenes played out repeatedly for a month, until more than 260 elephants were relocated from Liwonde National Park, managed by African Parks, a South Africa-headquartered NGO, to restock the governmentrun Kasungu National Park, where the elephant population has been hit by poaching.

The translocation, estimated to cost more than \$1 million, is



aimed at building viable populations of the key species and promoting tourism in the park, said Brighton Kumchedwa, director of Malawi's Department of National Parks and Wildlife.

It's also intended to prevent degradation of wildlife habitat as well as human-animal conflict in the 580-square-kilometer (224-square-mile) Liwonde National Park, which currently has more elephants than its ecosystem can support.

"With close to 600 elephants living within the park, space and availability of natural resources are near to capacity," says Sam Kamoto, African Parks' country manager for Malawi. "The increasing density of this population is causing degradation of wildlife habitats and intensifying human-wildlife conflict, largely deriving from crop-raiding elephants."

Kasungu National Park lies on Malawi's western border with Zambia. It's part of the Malawi-Zambia Transfrontier Conservation Area, a 32,000-km2 (12,355-mi2) conservation zone encompassing protected areas on both sides of the border. Until recently, the conservation area was a major source and transit route for ivory markets in China and Southeast Asia, resulting in a severe decline in elephant population in the corridor. In Kasungu National Park, elephant numbers dwindled from 1,200 in the 1970s to just 50 in 2015, according to government figures.

EW telemedicine technology, Daktari Smart, aims to mitigate the gap between child patients and medical specialists in rural Kenya.

Officially launched in November 2021, the system was built to help sick children have easy access to medical specialists minus the cost of being physically present (remote/digital access). According to them, this will help optimise the delivery of healthcare systems.

Kenya Medical Practitioners and Dentist Board estimate that the current patient-to-doctor ratio is 6,355 to 1. These statistics highlight the difficulty that patients have in accessing qualified medical personnel and specialists. Patients from rural and marginalised areas are especially disadvantaged, with some dealing with a total lack of adequate facilities. Others are left to contend with referrals that see them delay treatment.

Daktari Smart thus comes in as the "haven" that these patients had been waiting for, targeting over 32,000 children in Homabay, Samburu, Baringo and Lamu counties in its first phase of operation.

"Daktari Smart is a telemedicine device that offers connections between different counties or locations and the provider of the services," says Olivia Achieng, program coordinator at Gertrude's Hospital Foundation.

Bringing specialist telemedicine to children living in rural Kenya

"This telemedicine system involves electronic medical devices connected to form a platform that enables the clinical workers at the different counties to interact directly with the specialists and sub-specialists in Gertrude's Children's Hospital."

Like many developing countries, Kenya is characterised by limited health facilities in rural areas. Most health specialists and special care facilities are located in the city, mainly Nairobi. Kenyatta National Hospital, Nairobi hospital, and Aga Khan Hospital are among the largest and most reputable hospitals in Nairobi, Kenya, but are over 400 kilometres from Lamu, Homabay, and Samburu coun-

Specialists include paediatricians, surgeons, psychiatrists, and neurologists - the list is long.

"The poor doctor-to-patient ratio makes it hard to get specialists in farflung areas, making it hard for these patients to get the quality care they deserve. To get the specialist care they need, they will need to travel to cities like Nairobi, Kisumu, Eldoret or Nakuru, which is expensive and timeconsuming. This is the gap that Daktari Smart is trying to bridge," Achieng explained.

Rather than send the patient to a different facility or hospital, the referral process will now be able to be done within the same facility. The patient will be booked and referred over the telemedicine platform.

According to Achieng, the system comprises several electronic devices such as a stethoscope, vital sign monitor, derma scope, electrocardiogram, and ultrasound machine, among many other medical devices assembled to form the telemedicine plat-

All these devices are attached to a monitor, which allows the specialist to see the patient's information in realtime. This means that the specialist doesn't have to rely on second-hand information or someone else's interpretation of the patient's condition because they can see everything as it is transmitted first-hand.

Anyango said that once the specialist in Nairobi is done attending to whether he has any bookings from training," Owino said. Lamu, Samburu, Homabay or Baringo county.

"It is also important to note that this is a paediatric referral platform which means that before a child is referred, he or she has to be properly assessed by the health worker to determine whether or not the case requires a specialist's attention," she said.

The M-PESA Foundation invested over Ksh 168 million (about 1.4 million US dollars) in the project, with the expectation of bringing on board

two more needy counties and ensuring they can help as many patients as

"One of our main pillars under M-PESA Foundation is healthcare. For this particular telemedicine program, we have partnered with Gertrude's Hospital Foundation, Gertrude's Hospital and Safaricom PLC," said Karen Basiye, Director, Sustainable Business, Social Impact and M-PESA Founda-

"Our aim is to address the delays in receiving adequate healthcare in rural and underserved areas through telemedicine, starting with Samburu, Homabay, Baringo and Lamu Counties. Two other counties will be brought on board in the next phase of this program," Basiye told IPS.

"Patients, who have children aged up to 21 years, who would otherwise have to spend a significant amount of time and money on travelling long distances to urban areas to seek care, will now be able to receive specialist care from their local health facility. As a foundation, we are the program's main funder, investing over Ksh 168 million towards the initiative over the next three years," added Basiye.

Basiye said that the bandwidth requirement for the system is low, ranging from 512kps to 2Mbps, which makes it suitable for use in rural areas with poor internet connectivity.

"The mission and vision for Gertrude's Hospital Foundation are to ensure the poor and the needy in the community are taken care of. We noted that the hard-to-reach areas in Kenya are underserved in terms of medical specialists, and this project thus enables us to offer the health part, while M-PESA Foundation helps with the financial side," Anyango con-

Dr Alex Owino, Medical Superintendent, Katulani Sub- County hospital, Kitui, agrees that Daktari smart is a great initiative given the few specialist doctors who handle delicate and complex medical cases

"Most of these specialist doctors are found in major towns, which makes access to specialist care by patients from rural areas very difficult as they have to use a lot of resources just to get to them," Owino told IPS. "The whole of Kitui county, for instance, has only three paediatricians serving it, which means that general practitioners like ourselves will have to cover the gaps".

"Having specialists use technology to provide care for patients in hardto-reach areas will thus lead to better health outcomes as it cuts the need for the children he is with, he can then movement for patients who need help go to the telemedicine room and see and health workers who may need

> Owino explained technology is quickly revolutionising medicine with various gadgets and applications being introduced to help improve areas of weakness that have mainly been witnessed in developing countries.

> "This technology will not only help the patients but also be very useful in helping improve the knowledge and skills for the health workers in those areas," Owino concluded.

Tanzania all at to reclaim its position as global top sisal producer

N 1964, Tanzania was the largest producer and exporter of sisal in the world. The country was producing 230,000 tons with the industry evolving over mil-

lion people as farmers and estate workers. Sisal was locally used to produce ropes, twine and bags. The large quantity of the crop was exported to the world market.

Available data shows the crop was also generating 35 per cent of the country's foreign exchange and earning itself the "green gold" tag.

Years later however, sisal production began to decline, due to the decrease of the world prices, as synthetic nylon and juke bags became substitutes to sisal made products.

Statistics however indicate that in 2013, the global production of sisal fiber accounted for 281,000 tons with Brazil being the largest producer with 150,000 tons, followed by Tanzania, Kenya, Madagascar and China.

According to the World Bank data, the global price for sisal (Under Grade) increased by 1.3 percent to \$1.70per kilo during the year ending June, 2022 from \$1.68 per kilo in June, 2021.

Tanzania Sisal Board (TSB) Acting Director General Saddy Kambona says with increased demand for natural fibers on the global market, sisal has the potential to reclaim its position as Tanzania's leading foreign exchange earner.

Speaking to The Guardian recently, Kambona said in a bid to capitalize on the growing de-

mand, attributed to its multiple uses in various sector including construction and automotive, Tanzania has already drawn a roadmap to triple its production capacity from the current 40,000 tonnes per annum to 120,000 tonnes in 2025.

"We were once global top producer in 1960s, but production fell drastically because of decrease in demands, following the introduction of sisal alternatives, especially plastics. With the increased global demand, we have no option but to increase production, so as to take advantage of the increasing global demands," he said.

He noted that, as part of the United Nations Environmental, Social, and Governance (ESG)

guidelines on environmental sustainability; sisal has increasingly been used as a reinforcement agent in various sectors.

"Sisal has lately been used as a reinforcement agent especially in the manufacturing sector. Because of global environmental sustainability issues; it is now used as an alternative to wood; and also used in various beauty products like wigs, as a country, we have no option but to increase production to tap into the opportunities created by the growing demand of sisal," he said.

Empowerment of smallholder farmers

For many years, sisal has been produced on large scale in Tanzania unlike other countries like Brazil where smallholder farmers take cent-

As part of efforts to increase sisal production, he said, the Government of Tanzania tasked the sisal board to embark on a sensitization campaign for smallholder sisal farmers that will help in attaining its ambitious target of 120,000 tonnes per annum.

According to him, the board last year alone registered 8,721 smallholder farmers and targets registering 60,000 smallholder farmers by 2025

The board anticipates that the smallholder farmers in 16 regions including Tanga, Pwani, Morogoro, Dodoma, Singida, Shinyanga, Mwanza, Geita, Simiyu, Mara, Kagera, Manyara, Kilimanjaro, Lindi, Kigoma na Tabora will be in a position to produce 60,257 tonnes per annum.

Other sisal producing regions include Rukwa, Katavi, Mtwara and Ruvuma.



Kambona said they will also encourage youth to tap into sisal farming, noting that the sector gives higher returns.

TSB has started sensitizing small-scale out growers to increase their production capacities to embrace opportunities created by the global demand, he noted.

According to statistics from the Sisal Board, China is the biggest market of Tanzania's sisal accounting for 15,817 tonnes (53.7 per cent) followed by Saudi Arabia and Nigeria that account for 3,507 and 1,958 tonnes respectively.

Commenting on the effect of Covid-19 and the ongoing Russia-Ukraine war, Kambona said the sector was not affected as such but there was a disruption in logistics in terms of transport logistics for sisal export.

Tanzania's sisal sub-sector is the oldest commercially organized agricultural undertaking and one of the longest surviving agricultural industries in the country.

The sisal industry in Tanzania employs over 100,000 people, with a total production of 33,766 tonnes in 2018, down from about 40,000 tonnes in 2014.

Using Indian mode to expand cleaner cooking energy use in Tanzania

INDIAN oil and gas marketing companies have promised to help campaigning cleaner cooking energy use in Tanzania, especially low income earners, to save women from harmful biomass smokes.

This comes after being learned that, it has been so difficult for many low income earners in Tanzania to transform from the use of biomass energy such as firewood and charcoal to low carbon energy, mainly Liquefied Petroleum Gas

According to a statement by Indian High Commission to Tanzania the delegation are in Tanzania for four days to discuss how two countries can work together to expand low carbon cooking energy among low income earners.

The commission said India succeeded to expand the use of clear cooking energy among low income population through two implemented schemes namely Pradhan Mantri Ujjwala Yojana (PMUY) and City Gas Distribution (CGD).

"India is now moving fast to low carbon cooking energy and majority of households use LPG as their primary cooking fuel," the commission said. "These two schemes are currently implemented in India with great success and achieved more their targets well within the targeted time

The main goal of the campaign in Tanzania is help women from poor families use Liquified Petroleum Gas (LPG) in cooking, improve the health and safety, stop deforestation,

reducing carbon emissions and eliminating health hazards of conventional fuels.

According to the commission, PMUY is a scheme established by the ministry of Petroleum and natural gas for providing LPG connections to low income households of economically weaker section in far-flung areas.

He noted said, through PMUY scheme, launched in different areas across India 5 years ago, the penetration of LPG use in cooking jumped from 62 percent in 2016 to currently 99 percent.

Apart from that, the commission said Hindustan Petroleum Corporation Limited (HPCL), the government led-firm has already launched light-weight LPG cylinder equipped with better safety measures for consumers' needs that are now available in different capacities in India, and this can be copied in Tanzania.

Indian companies are also interested to invest in Tanzania, including reducing the size of LPG cooking gas cylinders up to 5kg of gas for many Tanzanian consumers to afford.

Nine Indian oil and gas marketing companies including HPCL, IOCL, BPCL and GAIL which are a government of Indian enterprises with its headquarters at Mumbai / Delhi are the main companies that were in Tanzania for a working visit.

Currently, majority of people especially women living in remote areas are still using traditional solid fuels such as firewood, agriculture residue, charcoal, kerosene for cooking that causes health problems. "If Tanzanian government will need our support we will support it to bring clean cooking energy to remove smoke in kitchens,"

Elaborating on City Gas Distribution (CGD), the commission says, gas utilization in India was about 6 percent percent of the energy basket in 2016; the target is to reach 15 percent by 2030.

"Currently India has covered entire country by dividing into various geographical areas and called out for bids from CGD entities and giving them exclusivity period 8 years for Gas Marketing in this territory and 25 years for the Gas Infrastructure development within the allocated territory," the statement noted.

The CGD entities were required to quote for the infrastructure that they intend to provide, as project are to be completed in eight years period.

This way, the entire country shall be covered with national network in eight years' time.

India has already commissioned around 4500 Compressed Natural Gas (CNG) stations and 10million domestic gas connections, of which the same design can be done in Tanzania with the few modifications to suite the local demand and available of natural gas.

Also, Tanzanian delegation will visit in India to see how HPCL and other oil and gas companies are operating their activities and learn from them.

In India, users are also trained regularly on the safe usage of LPG in Kitchens.

Global stocks up after US job gain paves way for rate hike

BEIJING

LOBAL stocks gained Monday after strong US jobs data cleared the way for more interest rate hikes and Chinese exports rose by double digits.

London, Shanghai, Tokyo Frankfurt advanced. Hong Kong retreated. Oil prices edged higher.

Wall Street's benchmark S&P 500 lost 0.2% on Friday after government data showed American employers added more jobs than expected in June. That undercut expectations a slowing economy might prompt the Fed to postpone or scale back plans for more rate hikes to cool inflation.

"Now it seems they will be debating whether they need to be even more aggressive," Edward Moya of Oanda said in a report.

In early trading, the FTSE 100 in London was up 0.4% at 7,471.08 and the DAX in Frankfurt added 0.4% to 13,629.44. The CAC 40 in Paris advanced 0.6% to 6,512.74.

On Wall Street, the future for the S&P 500 rose 0.3% while that for the Dow Jones Industrial Average was up 0.2%.

The S&P declined 0.2% on Friday after government data showed employers hired more Americans in July than forecast. The Dow added 0.2% while the Nasdaq composite lost 0.5%.

In Asia, the Shanghai Composite Index rose 0.3% to 3,236.93 after China's July exports rose 18% over a year earlier, beating forecasts.

China's trade surplus swelled to \$101 billion in July after imports rose just 2.3% over a year ago, reflecting weak domestic demand. The Hang Seng in Hong Kong fell 0.8% to 20,050.15 while the Nikkei 225 in Tokyo gained 0.2% to 26.241.13.

The Kospi in Seoul gained less than 0.1% to 2,493.10 and Sydney's S&P-ASX 200 shed less than 0.1% to 7,020.60.

India's Sensex gained 0.9% at 58,892.25. Taiwan, New Zealand, Singapore and Bangkok retreated while Jakarta gained.

Investors worry tighter policy from the Fed and central banks in Europe and Asia to cool inflation that is running at multi-decade highs might derail global economic growth.

Markets also have been rattled by Russia's war on Ukraine, which caused a spike in prices of oil, wheat and other commodities, and by uncertainty about Chinese anti-virus curbs that have disrupted manufacturing and shipping.

Last week's strong U.S. employment data gave ammunition to Fed officials who say the economy can tolerate higher borrowing costs

to cool inflation.

After Friday's announcement, traders expect the Fed to raise its benchmark rate by 0.75 percentage points next month, up from forecasts of half a point. That would be triple the usual margin and the third such outsized hike this year.

Higher interest rates are meant to counter inflation by cooling business activity, but that also raises the risk of recession and job losses. The latest inflationary spike is unusual because forecasters have blamed shortages of goods due to the coronavirus pandemic, rather than rapid economic growth.

Wall Street is coming off its best month for stocks since late 2020, a rally driven by falling bond yields. Traders hoped the economy was slowing enough for the Fed to ease off.

NSE shakes off polls jitters to add Sh85 billion wealth

NAIROBI

HE Nairobi Securities Exchange (NSE) has added Sh85 billion in investor wealth in the last two weeks, showing no sign of pre-election jitters as retail investors continue to buy up cheap stocks.

The bourse's market capitalisation stood at Sh2.21 trillion at close of trading on Friday, having gained four percent in two weeks.

The number of investors trading also went up week-on-week as they defied expectations of caution ahead of what is expected to be a tightly contested presidential election.

The number of equity deals rose to 5,402 last week from 4,765 the previous week, while traded turnover rose to Sh1.62 billion from Sh967 million previously.

The defiant market mirrors the situation in the run-up to the last elections in 2017 when the NSE gained Sh73 billion in the last fortnight to the disputed polls whose aftermath was characterised by nullification of presidential results and riots in the city.

Kenyans will tomorrow head back to the ballot to elect a successor to President Uhuru Kenyatta, from among four candidates. The two leading contenders are former Prime Minister Raila Odinga and Deputy President William Ruto.

The prolonged campaigns, which ended on Saturday, passed largely peacefully, giving investors confidence that the transition will not disrupt business and markets.

Local investors have been more active on the buying side of the market in recent weeks, taking up attractively priced shares from foreign counterparts who have been selling up and moving their capital to western markets in pursuit of higher interest



rates that are on offer there.

Having shunned the market earlier in the year, they are now providing demand to counter the supply pressure caused by foreign selling, thus boosting share prices at the bourse.

"What we've largely been seeing is locals taking advantage of the low share prices and absorbing foreign selling pressure. While risks are still viewed as elevated, the robust earnings across multiple sectors are too attractive to ignore, hence investors are adopting a moderately optimistic long-term view that things will improve in a post-election environment," said a dealer at an investment bank.

The outflows look set to continue, with inflation in western economies showing little sign of easing. In the US, which is grappling with 40-year high inflation, the US Federal Reserve was forced to raise its policy rate by 0.75 percentage points at the end of July to a range of 2.25 percent to 2.5 percent–from near zero in March.

Last week, England's apex bank also made in the market.

its biggest rate hike in 27 years –0.5 percentage points to 1.75 percent– as it battles a 13.3 percent inflation.

Key stocks such as Safaricom, EABL and Equity Group, which had sunk to multi-year lows towards the end of June on foreign selling pressure, have now rebounded with gains of 13 percent, 11 percent and 11.6 percent respectively in the past one month.

They have backed a Sh393 billion gain in market capitalisation at the NSE since June 27, when the bourse hit its lowest wealth level in over five years of Sh1.82 trillion.

These three stocks, alongside KCB, are the most preferred among foreign investors at the bourse owing to their high liquidity and solid fundamentals, which include consistent payment of dividends.

The continued recovery of the market will, however, depend largely on the post-election environment in the country, with any prolonged dispute over results likely to raise jitters in the market.

Ukraine faces key test on debt freeze plan in bid to avoiding messy default

LONDON

UKRAINE'S creditors vote this week on a government proposal to defer payments on the war-torn country's international bonds for 24 months as Kyiv hopes to swerve a \$20 billion messy default.

Bondholders have until 5 p.m. New York time (2100 GMT) on Tuesday to decide whether to back or vote down the proposal by Ukraine's government, which faces a \$5 billion monthly financing gap and liquidity pressures following Russia's invasion on Feb. 24. Time is precious: the country has a \$1 billion bond maturing on Sept. 1.

Creditors will likely wait until relatively close to the deadline to vote, said a person familiar with Ukraine's thinking. Investors are expected to support the debt standstill, the person added.

When announcing its proposal, Ukraine's finance minister Sergii Marchenko said it had "explicit indications of support" from some of the world's biggest investment funds including BlackRock, Fidelity, Amia Capital and Gemsstock.

Creditors of Ukravtodor and Ukrenergo, two state-owned firms that have government guarantees on their debt, also have until Aug. 9 to vote on a plan similar to the sovereign.

The two-year moratorium on external debt payments would allow Ukraine to avoid a contractual or legal default, as any amendment on the bonds' terms would have the creditors' backing, Rodrigo Olivares-Caminal, professor of banking and finance law, at Queen Mary University of London, told Reuters.

However, creditors could ask whether a default insurance known as credit default swaps (CDS) should kick in, as a deferral of payments might be considered a credit event by the International Swaps and Derivatives Association (ISDA).

Investors are sitting on about \$221 million of insurance on Ukraine's debt, according to Depository Trust & Clearing Corporation (DTCC) data

Credit rating agencies might also classify this as a "selective default" or "default".

"A contractual default, a credit event and a credit rating default are three different albeit related concepts," Olivares-Caminal said. "Incurring any of the three doesn't mean that the other two will trigger."

While investors are expected to back the freeze it is unclear whether the country may still need a debt restructuring in the medium term.

"It is just a pause button - we do not know what shape Ukraine will be in in a few months or a few years down the line," said Luis Peixoto, emerging markets economist at BNP Paribas in London. "Investors are already preparing for a debt restructuring."

The dollar-denominated bonds trade at deeply

distressed, some as low as 17 cents in the dollar.

Battered by the war, which Russia calls a "special military operation", Ukraine faces a 35%-45% economic contraction in 2022, according to estimates from the government and analysts, and is heavily reliant on foreign financing from its Western partners.

Ukraine aims to strike a deal for a \$15 billion-\$20 billion programme with the International Monetary Fund before the end of the year.

Ukraine restructured its debt in 2015 after an economic crisis linked to a Russia-backed insurgency in its industrial east. The deal left it with a large number of payments due annually between 2019 and 2027, and it returned to international markets in 2017 with a \$3 billion hard-currency debt issuance.



Dollar extends increase against Japanese yen

OTTAWA

THE dollar extended it best rally against the yen since mid-June on Monday, buoyed by higher Treasury yields after blockbuster U.S. jobs data lifted expectations for more aggressive Federal Reserve policy tightening.

The greenback was last 0.31% higher at 135.42 yen, and earlier rose to 135.585 yen, its highest since July 28, after surging 1.57% in the previous session, its biggest single-day gain since June 17.

The dollar index, which measures the currency against six counterparts, stood at 106.77, from a Friday peak of 106.93, also the strongest since July 28.

Traders currently see a 73.5% probability the Fed continues the pace of 75 basis-point interest-rate increases for its next policy decision on Sept. 21, from about 41% before surprisingly strong payrolls data on Friday raised worries that wage growth would fuel inflationary pressures.

The focus this week will be on the U.S. consumer price index due Wednesday, and whether it can cement the odds for super-sized rate rises. Analysts polled by Reuters expect annual inflation eased to 8.7% in July from 9.1% previously.

"It will likely take a number below 8.4% to get the odds of a 50bp hike in September as the default setting," although that "seems unlikely," Chris Weston, head of research at Pepperstone, wrote in a note.

"I wouldn't want to be short USDs if

the CPI print comes in above 9%."
The two-year Treasury yield remained elevated at 3.2628% in Tokyo trading on Monday, after reaching 3.3310% at the end of last week, a level not seen since

The 10-year yield stood at 2.8470%, sticking close to the two-week high of 2.8690% touched Friday.

The negative spread between the twoand 10-year yields was 42 basis points, having hit 45 basis points on Friday, the most since August 2000. An inverted yield curve is widely interpreted as a pre-cursor to a recession.

Elsewhere, the euro sank 0.35% to \$1.01595 while sterling slid 0.19% to

The British pound dropped as low as \$1.2004 on Friday, a day after the Bank of England raises interest rates by an asexpected half a point at the same time as warning of a protracted downturn.

"The Bank of England's forecast of recession underpins the vulnerability of the pound going forward," Rabobank senior FX strategist Jane Foley wrote in a note, predicting sterling could dip to \$1.14 within three months.

Meanwhile, the Australian dollar slipped 0.06% to \$0.6907, while the New Zealand dollar fell 0.19% to \$0.62315.

Euro zone bonds recovering from post-US payroll selloff

LONDOI

EURO zone bond yields fell on Monday, having risen sharply after stronger-than-expected US jobs data at the end of last week, while Italian bonds appeared to brush off a decision by Moody's to lower Italy's ratings outlook.

Safe-haven bonds also drew support from geopolitical tensions. China's military announced fresh drills on Monday in the seas and airspace around Taiwan - a day after the scheduled end of its largest ever exercises to protest against last week's visit to Taipei by US House Speaker Nancy Pelosi.

Germany's 10-year Bund yield was down 5 bps at 0.90%.

It rose 15 bps on Friday in its biggest one-day surge since March 2020. This move followed data showing the US economy created 528,000 new jobs in July, which stoked expectations for a supersized September US rate hike and pushed up Treasury yields 10-22 basis points (bps).

French and Dutch 10-year bond yields were also 5 bps lower on the day after rising sharply on Friday.

A rise in US rate-hike bets for September also boosted bets for another big rate rise from the European Central Bank next month.

Money markets now price in about a 90% chance of a 50 bps rate rise from

the ECB in September, up from around a 50% chance a week ago.

Italian bonds underperformed their peers, with 10-year Italian bond yields just 1 bps lower at 3.01%.

Italy's closely watched bond yield

gap over top-rated Germany was at around 211 bps, versus 205 bps late on Friday. Ratings agency Moody's cut Italy's

outlook to "negative" from "stable" on Friday, weeks after Prime Minister Mario Draghi's resignation sparked fresh political uncertainty. Moody's said risks to Italy's credit

profile had risen due to political developments and the economic fallout of Russia's invasion of Ukraine.

S&P Global last month cut its ratings outlook to stable from positive, citing concern that political instability could slow the path for key economic reforms. "The same rating action by S&P the other week already prepared markets for a less dovish rating dynamics but failed to cause lasting pressure," said Michael Leister, head of interest rates strategy at Commerzbank.

"We expect BTPs to continue to grind tighter," he said, referring to the Italian bond spread over Italy.

Data last week showing the ECB had skewed reinvestments from maturing bonds from its PEPP stimulus scheme to Italy was expected to bolster Italian debt.

Climate change compensation fight brews ahead of UN summit

BRUSSELS

TENSIONS are mounting ahead of this year's UN climate summit, as vulnerable countries ramp up demands for rich countries to pay compensation for losses inflicted on the world's poorest people by climate change.

When diplomats from nearly 200 countries meet on Nov 7 in the beachside resort town of Sharm El Sheikh, Egypt, negotiations will tackle how to cut the CO2 emissions causing climate change and cope with existing climate impacts, including deadly heatwaves, wildfires, rising seas and drought.

But another issue is likely to dominate the talks: "loss and damage," or climaterelated destruction to homes, infrastructure and livelihoods in the poorest countries that have contributed least to global warming.

The world's 46 least developed countries, home to 14 percent of the global population, produce just 1 percent of the world's annual CO2 emissions from burning fossil fuels, according to the UN.

As COP27 approaches, climate losses are surging - in rich and poor countries alike. In recent weeks, wildfires have swallowed huge swathes of land in Morocco, Greece and Canada, drought has ravaged Italy's vineyards, and fatal floods hit Gambia.

"That's been the critical juncture. We've been affected and talked about it for a long time. But now rich countries are being affected as well," said Saleemul Huq, an adviser to the Climate Vulnerable Forum group of 55 countries.

Wealthy countries also failed to deliver a promise for \$100 billion a year by 2020 to help poor countries lower emissions and prepare for climate change. Loss and damage payments would be in addition to that \$100 billion.

"It's not ambiguous. Finance means money. It means put your hand in your pocket and bring out a dollar, a euro, a ven and put it on the table for the victims of climate change," Huq said.

Hope despite hurdles

Just getting loss and damage finance into the COP27 discussion is proving contentious, as a proposal to add it to the agenda has not yet won broad sup-

The issue was also not added to pre-COP27 talks in June in Bonn, Germany. Talks there on UN technical assistance on accounting for loss and damage also ended without agreement, due to disputes over how that scheme should be

COP27 will be no easier, as rich countries arrive with purse strings tightened by soaring energy costs, the economic fallout of the Ukraine crisis and the COVID-19 pandemic, which prompted wealthy countries spend trillions of dollars propping up their

"It's my hope that developing nations will galvanize their collective voices to push for adequate treatment of loss and damage," said Matthew Samuda, a minister in Jamaica's economic growth ministry who works on climate change.

Historically, rich economies including the United States and the 27-country European Union have resisted steps that could assign legal liability or lead to compensation.

Negotiators at last year's COP26 UN summit agreed to launch a two-year dialogue on loss and damage, but stopped short of setting up an actual fund.

Putting the topic on the COP27 agenda could open up discussions on where the money would come from, how it would be distributed or even how to define climate-induced losses. Some research suggests such losses could reach \$580 billion per year

"Everything's been left quite uncertain on how to rebuild the trust between developed and developing countries," said Alex Scott, climate diplomacy expert at think tank E3G.

Still, some resource-challenged countries hope for a break-

through.

"We are hopeful that the international community will soon step up," said Madeleine Diouf Sarr, chair of the Least Developed Countries bloc in UN climate negotiations, pointing to a growing acknowledgement among rich countries of the need.

During a visit to Pacific archipelago Palau last month, for example, Germany's foreign minister said her country would prioritize the issue in its own international climate policy.

"This is an issue we haven't talked enough about for a very long time," Annalena Baerbock said. "And it really is about fi-Agencies

Japan urged to stop echoing **US negative words on Taiwan**

CHINESE Ambassador to Japan Kong Xuanyou on Thursday stated China's solemn position to Japanese Vice-Foreign Minister Takeo Mori on Speaker of the US House of Representatives Nancy Pelosi's visit to China's Taiwan region, and lodged solemn representations



the Japanese side over the negative Taiwan-related statement issued by the G7 foreign ministers.

Kong (pictured) said that China has repeatedly stated its solemn position on Pelosi's visit to Taiwan. Japan insists on cooperating with the United States and other G7 countries in issuing the so-called foreign ministers' statement concerning Taiwan, grossly interfering in China's internal affairs, seriously violating the basic norms governing international relations, deliberately confusing right and wrong, and trying to gang up to contain China, adding that China firmly opposes and strongly condemns such behavior.

The Taiwan question is China's internal affair, which brooks no external interference, he said, noting the one-China principle is a widely recognized norm governing international relations and tolerates no provocation.

The complete reunification of China is the common aspiration of all Chinese and an unstoppable historical trend, Kong said, adding that no country, no force, and no individual should ever underestimate the firm resolve, iron will, and strong capability of the Chinese government and people to defend national sovereignty and territorial integrity, as well as achieve national reunification and reiuvenation.

Kong pointed out that the ins and outs of the current tension over the Taiwan Straits are crystal clear, so are the rights and wrongs.

The United States insisted on arranging Pelosi's visit to Taiwan, deliberately provoking China and playing with fire, seriously violating the one-China principle and the stipulations of the three China-US joint communiques, gravely infringing upon China's sovereignty and territorial integrity, severely undermining peace and stability across the Taiwan Straits, and sending a wrong signal to the "Taiwan independence" separatist forces, he said.

China will not sit idly by, Kong said, noting it is completely justified and reasonable for China to take resolute measures to safeguard its territorial integrity and core interests. Such measures are a warning to provocateurs and a safeguard for regional stability and peace across the Taiwan Straits.

Kong said that it is the Taiwan authorities and the United States that are currently changing the status quo of the Taiwan question and creating tensions. The Taiwan authorities have kept seeking US support for their "independence" agenda, engaged in "de-sinicization," and promoted "incremental independence."

'Russian foreign ministry in contact with Cuba on fire at oil storage facility

MOSCOW

RUSSIA'S foreign ministry is in contact with the Cuban side to coordinate efforts to put out fire at an oil storage facility in the Matanzas province. Russian Foreign Ministry Spokeswoman Maria Zakharova said on Sunday.

"Following the disaster, Cuba has requested international assistance. Rus-

sia's foreign ministry and relevant agencies are in contact with the Cuban side to coordinate possible joint actions and necessary assistance," she said.

"In these hard for Cuba days, the Russian foreign ministry offers the sincerest words of support to the Cuban friends, extends condolences to the families of those killed and wishes the soonest recovery to those injured," she said.

The fire at an oil storage facility in the Cuban province of Matanzas, which held around 25,000 cubic meters of oil, broke out on August 5 after a lightning strike. Several explosions followed. Firefighting operations continue, in-

volving Cuba's air forces. According to official data, several people died, dozens were hurt and many more are missing. Some 2,000 people have been evacuated from the accident zone. Cuba's Minister of Energy Nicolas Arronte Cruz is among those hurt, the ministry recalled.

Israel and Palestinian militants declare Gaza truce

ISRAEL and the Palestinian Islamic Jihad militant group declared a truce late on Sunday, raising hopes of an end to the most serious flare-up on the Gaza frontier in more than a year.

Israeli forces pounded Palestinian targets through the weekend, triggering rocket attacks against its cities, which largely tapered off by the time the truce came into effect at 23:30 (20:30 GMT).

Israeli forces pounded Palestinian targets through the weekend, triggering rocket attacks against its cities, which largely tapered off by the time the truce came into effect at 23:30 (20:30 GMT).

It was announced in separate statements by Islamic Jihad and then Israel, who both thanked Egypt for mediating the ceasefire.

The three-day clashes echoed preludes to previous Gaza wars, though they were relatively contained as Hamas, the governing Islamist group in the Gaza Strip and a more powerful force than Iranian-backed Islamic Jihad, had so far stayed out.

Gaza officials said 44 Palestinians, almost half of them civilians and including children, had so far been killed. The rockets have threatened much of southern Israel and sent residents in cities including Tel Aviv and Ashkelon to shelters.

Israel launched what it called pre-emptive strikes on Friday against what it anticipated would be an Islamic Jihad attack meant to avenge the arrest of a leader of the group, Bassam al-Saadi, in the occupied West Bank.

In response, Islamic Jihad fired hundreds of rockets at Israel. At a news conference in Tehran, the group's leader Ziyad al-Nakhala, said Cairo would "work to secure the release" of al-Saadi. Israeli and Egyptian officials did not immediately respond to requests for comment.

On Sunday, Islamic Jihad extended its range to fire toward Jerusalem in what it described as retaliation for the overnight killing of its southern Gaza commander by Israel - the second such senior officer it has lost in the fighting.

Second Hainan Expo reveals increasingly stronger appeal of Chinese market

Rwanda makes strides in plastic ban

FOR visitors who arrive in Rwanda for the first time by air, their first impression about this small central African country is most likely to be its great efforts in plastic control.

At the Kigali International Airport, visitors are asked to refrain from bringing plastic bags into the country, as any plastic bags will be confiscated at the airport or other points of entry. On the outskirts of the capital city Kigali, different machines at the site of waste collection company COPED can be seen busy running, making piercing noises as they grind waste.

Rwanda's efforts to be plastic free are expressed through relevant laws that were introduced as early as 2008. In that year, the country passed its first law banning the manufacture, import, use, and sale of polyethylene

Four years later, as part of supporting the aforementioned law, Rwanda created the Environment and Climate Change Fund as a cross-sector financing mechanism to achieve the development goals of environmentally sustainable, climateresilient, and green economic

In 2019, Rwanda passed a transformative law that began phasing out all single-use plas-



tics. The law aims to control the growing habit of unnecessary consumption and disposal of single-use plastic items that became a burden on the environ-

The law also imposes stiff fines against users using single-use plastics. In recent years, the country has taken a step further to make plastic waste an investment opportunity. COPED is one of the most known waste collection companies in Kigali.

The company recycles certain non-perishable waste, including single-use plastic materials, and plastic and glass bottles, into building materials, such as cobblestones and building blocks.

"We filter the perishable waste from the non-perishable ones, then from the perishable waste we produce manure and we grind the imperishable, (from which) we produce building materials.

So for us, waste is another way to do business and make money," Mutabazi Emmanuel, COPED production Manager told Xinhua in a recent interview."We use plastic porridge instead of sand, and glass bottle powder instead of cement," he said, adding that their business is contributing to environmental protection because the extraction of sand, the production of cement, as well as plastic waste, damage the environ-

Youth associations in collaboration with the Rwanda Environment Management Authority (REMA) are also organizing community mobilization activities to combat plastic waste.

The Rwanda Scouts Association, for instance, has a project called "Tide Turner Plastic Challenge" to initiate the scouts and the communities to fight against the pollution caused by

Virgile Uzabumugabo, National Coordinator of the Rwanda Scouts Association said the association started its activities after the call of the government to fight against plastic waste and think about profiting from it.

"We started the project with sponsorship from the United Nations Environment Programme, UNEP. We intend to strengthen our collaboration with REMA, and fellow youth associations until we create our own factory that transforms plastic waste into other objects," said Uzabumugabo.

Uzabumugabo said that at the moment, their work is limited to raising awareness and collecting waste which they sell to companies that transform it into other environmentally friendly and useful things.

According to REMA, the plastic problem worries the world at large due to the environmental degradation both on land and in water.

Jeannette Mugwaneza, REMA's project manager, said REMA promotes the production of other materials from plastic waste and sensitizes the public about the dangers of plastics and the benefits of recycling.

China launches scientific expedition to investigate ice, carbon storage in Yangtze headwaters

Advanced monitoring equipment was employed during the expedition. Hong Xiaofeng, deputy director from the wafice at the CRSRI told People's Daily that a 3D laser scanner was used in the expedition, which has a scanning radius of 6 kilometers and millimeter-level accuracy. It can superimpose measurement results recorded in different periods and then analyze the changes in glacier movement, said Hong, who has joined multiple expeditions to glaciers.

A three-dimensional observation system was established, Hong said, adding that it helped acquire data in uninhabited areas and overcome the difficulties of data collection in winter. The system included an unattended meteorological

station, a snow analysis system that can transmit temperature, humidity, radiation, and precipitation data regularly, a glacier foreland observation system and other devices.

In the wetland in the Damqu River basin, which has an average altitude of about 4,800 meters, scientists took soil samples through drilling machines and took photos of the area via drones. More than 100 water, soil and vegetation samples were collected.

"The soil showed clear strata and the carbon concentration varied from stratum to stratum; underground roots were around 20 millimeters deep in meadows densely covered by ponds, and the well-developed roots had a strong capability in water and carbon fixation," said Zhao Dengzhong, deputy director of the CRSRI's scientific exchange and international cooperation

Carbon sink is a process when carbon is collected and fixed. To improve the capacity of the ecological carbon sink is of great importance for mitigating global climate change. Examining the carbon sink in the headwater regions was also a focus of this expedition.

"We analyzed the variation of carbon distribution at different depths of the soil to find out how carbon storage varies on an annual basis and draw an accurate conclusion of the carbon sink potential in the headwater regions,"

Zhao said.

Scientists acquired the CO2 and methane contents at the air-water interface and the soil-air interface with trace gas analyzers to obtain carbon flux information from different subsurface. They also made hyperspectral satellite remote sensing images with Beidou satellites and drones, and gradually established a monitoring network, Zhao explained.

"Taking frozen soil as an example, over the recent years, impacted by the warming and humidification of the climate on the Qinghai-Tibet Plateau, a part of the frozen soil would release carbon when melting. This process in turn promotes the reproduction of animals and plants, and thus further enhances carbon sink," Zhao said.

"The research of the carbon cycling mechanism and carbon sequestration potential of the wetland ecological system on the Qinghai-Tibet Plateau is of important significance for ecological protection on the Earth's third pole and for achieving carbon peak and carbon neutrality goals," Xu noted.

The expedition will further the understanding of the current state of the ecological environment in the headwater regions of the two rivers, and will provide basic data for research projects including the protection of the Yangtze River and the construction of the Sanjiangyuan National Park.

Chad, rebels sign peace deal in Qatar ahead of national dialogue

CHAD'S transitional authorities and rebel groups signed a peace agreement in Doha yesternday ahead of a broad national reconciliation dialogue to take place later this month.

A signing ceremony for the agreement, which included the parties agreeing to take part in a national, inclusive dialogue, was attended by more than 30 rebel groups and followed months of talks in the Qatari capital.

Details, such as how the deal will be implemented and how adherence to it will be monitored, were not immediately released.

Mahamat Zene Cherif, the interim military government's foreign minister, told reporters he believed the agreement would lead to sustainable peace in Chad, adding that 1,500 representatives would attend the national dialogue on August 20.

The national dialogue is meant to include a wide range of groups and parties as well as the government and the rebels.

"Most of the armed groups signed this agreement and they will take part in the national dialogue. And this national, inclusive dialogue is a forum for all Chadian people," he said, brushing off negotiations.

concerns that not all groups had signed up to the deal. A source familiar with the

agreement said those who had signed had agreed to a permanent ceasefire and to work towards civilian disarmament. Chad's interim military government had also committed to not

launching military or police operations in neighboring countries against groups who had signed up to the deal, the source said, speaking on condition of anonymity.

The interim military government is headed by Mahamat Idriss Deby, who last year seized power following his father's death.

Deby declared himself head of a Transitional Military Council in April 2021 after his father, longtime ruler Idriss Deby, was killed while visiting troops fighting the rebel insurgency in the north.

Initially, his council said it would oversee an 18-month transition to democratic rule, but it has shown little sign of organizing elections as that deadline has neared.

Qatar's foreign minister, Sheikh Mohammed bin Abdulrahman Al-Thani, speaking at the signing, called on groups that had not signed to join the agreement.

Wandi was adamant his club is still going strong because the key players have been successfully replaced and the newly recruited footballers are expected to bring competition.

"In the pre-season, the players went for training to prepare for the 2022/23 season, I want to assure you that we loaned several players to Ruvu Shooting, Dodoma Jiji FC, and Mbeya Kwanza FC, they have made their way back, each position is fully covered following the arrival of new players as well," he stated.

Wandi noted: "This year we have well prepared strategic plans for improving our club but now it's not the right time to make them public, when the time comes everything would be unveiled."

Coastal Union's key footballers recruited by other top-flight squads are among others, Nigerian midfielder Victor Akpan who inked a two-year contract with Simba SC, Mustapha Chambo, and Amani Kyata who joined Dodoma Jiji FC, and attacker Abdulhamis Suleiman who moved to Azam FC.

This season's Premier League duel between Coastal Union and Yanga will have the Tanga club fighting to get the better of the defending champion, given the visitors had cruised to a 2-0 win when they met in the previous season's first phase duel at Mkwakwani Stadium.

Yanga later made a double via garnering a comprehensive 3-0 victory over Coastal Union in the second phase game held at Benjamin Mkapa Stadium in Dar es

The Jangwani Street side had in the process officially emerged as the 2021/22 Premier League winner, clinching a record 28th top-flight title.

In the previous season's Federation Cup final that witnessed Yanga locking horns with Coastal Union in Arusha in July, the former endured stiff opposition showcased by the latter.

The regular 90 minutes and the extra time had witnessed the clubs locked to a 3-3 draw, forcing penalty shootouts to get

the champion. The penalty shootout ended with Coastal Union conceding a 4-1 loss to Yanga which

in the end won the third silverware. The Jangwani Street side had early in the season lifted the Community Shield with a 1-0 win over cross-town rivals, Simba SC.

The records further show that the 2021/22 top-flight's first phase clash between Coastal Union and Kinondoni Municipal Council FC which took place at Mkwakwani Stadium on October 2, 2021, witnessed them share the spoils with a 0-0 draw.

The two clubs locked horns in the other clash at Azam Complex Stadium in Dar es Salaam on May 7 this year, in which Coastal Union cruised to a 3-2 victory over Kinondoni Municipal Council FC.

Dar boxers grab bronze medals in **2022** Commonwealth Games

TANZANIA's boxers' dreams of making it to the finals of the 2022 Commonwealth Games were banished on Saturday as they lost their respective semi-final bouts in the ongoing showdown in England.

Light Heavyweight pugilist Yusuf Changalawe and Light Middleweight pugilist Kassim Mbundwike were the East African country's envoys in the showdown, the pugilists lost to Mozambican Tiago Muxanga and Scottish Sean Lazzarini respectively.

Muxanga defeated Changalawe 4-1, whereas Mbundwike suffered a 3-2 loss to Lazzarini.

To reach the round, Mbundwike beat Faustino Marion AH Tong from Samoa Island via Referee Stop the Contest (RSC) in the third round, spending 1.53 minutes.

Changalawe was victorious in the bout against St. Lucia boxer Arthur Langelier in a similar manner in bout number 119, grabbing a win in the first round and spending 2.18 minutes.

This is the first time in 16 years that Tanzania won medals at Commonwealth Games, the last time was at Melbourne Games in 2006, where the country won one gold and one bronze.

Three Tanzania athletes will officially return home with medals, two bronze, and one silver medal which was won by marathoner Alphonce Simbu.

While handing over the national flag to Tanzania's representatives in the showpiece, Minister for Culture, Arts, and Sports Mohamed Mchengerwa challenged the athletes to perform well in the Games, saying the country wants medals.

He promised to hand over cash prizes to contenders who will bring home gold, silver, and bronze medals.

"The government has spent a lot of money to see our athletes prepare well for the Commonwealth Games," the minister disclosed.

"There are also cash prizes which will be handed over to those who will bring home gold, silver, and bronze medals, go there and do your country proud," he noted.

Haaland won't solve all Man City's 'problems' - Pep

PEP Guardiola said Erling Haaland will "not solve all our problems" and claimed he wants to make the 22-year-old a better player after the £51 million summer signing marked his Premier League debut with both goals in Manchester City's 2-0 win at West Ham United.

Having failed to score in his first appearance in English football during last week's 3-1 Community Shield defeat against Liverpool, Haaland showcased his goalscoring ability with a first-half penalty and second-half strike against David Moyes' team.

But City manager Guardiola said he will not make his team over-reliant on the Norway international, despite his goalscoring pedigree.

"All the team were amazing, but for Erling to score the first two goals is good for him and for us," Guardiola said. "He is a threat for us now, but he is not going to solve all our problems.

"He will add something to our team. But if we just rely on him, we will be making a mistake.

"One week ago [after the Community Shield], he could not adapt in the Premier League and now he is alongside Thierry Henry, Alan Shearer and Cristiano Ronaldo, so.

"I'm so happy for him. Two goals, the destarving for goals, and want more, but at bate is over. He scored goals in Salzburg, Dortmund, so hope he can do it here."

When Guardiola arrived at City in 2016, he urged striker Sergio Aguero to add more to his game and become a greater team player and he said that he also wants Haaland to evolve his game.

"He came for five years, hopefully he will stay for this time, even longer," Guardiola said. "He can be good for us and the team, but we can push him more and add something more to his game and make him a better player, not just the guy who scores

"I don't know him much, so we need time, but I know how he handled criticism this week and he was really calm. I don't know yet how he reacts to compliments, we will see. But I like how he took the penalty, his self-confidence. I think he will punch a teammate in the face if they try to take it off him and I like that.'

In a post-match interview, Haaland said it was "a bit s***" that he was unable to score a hat trick on his debut before being substituted in the closing stages.

But Guardiola said that reaction was what he would expect from a top player.

"I was fortunate to be with [Lionel] Messi," Guardiola said. "When he scores two, he wants three, when he scores three, he wants four. All the top players are the

ERIK ten Hag pleaded for time after starting his Manchester United reign with a disappointing loss. Erling Haaland didn't need much time at all to show what kind of impact he will have at Manchester City.

The two biggest offseason arrivals in Manchester had starkly different starts to the Premier League season on Sunday.

Ten Hag looked grim-faced on the sideline as the Dutch coach watched United slump to a 2-1 loss to Brighton at Old Trafford, with his side being outplayed in the first half before a second-half rally came up short.

Haaland scored twice to lead Man City to a 2-0 win at West Ham, netting from the penalty spot in the first half then adding a clinical finish in the second.

Ten Hag was brought in by United to help close the gap to its crosstown rival, having finished 35 points behind champion Man City in the league last season.

If anything, the gap seems to have only grown – thanks largely to Haaland.

The Norway striker was recruited by City to provide a clear focal point to the team's attack, with Pep Guardiola having spent much of last season playing without a recognized striker. And the towering Haaland, who scored 86 goals in 89 games during his three seasons at Borussia Dortmund to establish himself as one of the most-wanted players in Europe, will clearly add vet another dimension to a team that still led the league in scoring last season with 99 goals.

"We didn't have any doubt. When a guy has scored goals since he was born, why should he not score here?" Guardiola said of Haaland's debut performance.

United fans, meanwhile, are still waiting to see what kind of impact Ten Hag will have after a dispiriting performance against Brighton that showed that many of the team's old weaknesses still
