HEALTH experts believe that the use of electronic devices by children requires maximum supervision, in which case African countries need to exhaustively discuss the use of technology for children below five years, the government has stated.

Representing President Samia Suluhu Hassan, the Community Development, Gender, Elderly, Women and Special Groups minister Dr Dorothy Gwajima, yesterday asked African countries to invest more on childcare and upbringing.

She was opening a four-day international conference on early child care, upbringing and development, themed: 'Investing in early childhood; building human capital along the life course,' underlining the need for the continent to invest in a healthier productive work-

#### 'EACJ lacks support from member states'

EAST African Court of Justice presiding judge, Justice Nestor Kayobera has appealed to the partner states to ensure that the regional judicial entity is well supported in order to execute its tasks promptly and diligently.

Gracing a media training event on judicial reporting in the East African Community zone, he said that the East African Court of Justice is accessible to all residents of the EAC partner states.

The court procedure does not require applicants to first exhaust legal procedures in their respective countries before filing cases at its Arusha seat, he said, expressing concern that the regional legal facility is yet to be fully utilized among East African people.

Hinting at how EAC member states see the court, he pointed out that EACJ is the most respected legal facility, such that so far no member state has ignored its decisions.

"We effectively execute our legal mandate in compliance with the laws and the EAC treaty of establishment," the presiding judge emphasised.

Topics being covered in the three-day session include aspects of EACJ establishment, institutional and legal framework presented by Dr Henry Onoria, a consultant with ALP

East Africa, a regional law firm. Advocate Christine Mutimura the EACJ deputy registrar, gave the members of the regional media fraternity an overview of the court and its operations, while advocate Jenerali

income growth for fiscal 2023.24.

He listed 162 projects and programmes to be implemented in the annual plan, geared at an economy that will generate employment and stimulate exports of value-added

Overall growth stood at 5.3 percent in the January to September 2023 period, inching up from 5.2 percent growth in the corresponding period for 2022, he stated.

Finance and insurance led income growth at 16.0 percent, mining and quarrying (10.2 percent), electricity (10.0 percent), arts and entertainment (10.0 percent), accommodation and food (8.9 percent), while information and communication registered 7.9 percent growth, he said.

Large contributors to the gross national product were agriculture (24.8 percent), construction (13.6 percent), mining and quarrying (9.7 percent), trade and maintenance (8.4 percent), transportation and warehousing (7.2 percent), and industry (6.9 percent).

Over 100 programmes and projects will be implemented in the next financial year that the government sees as model projects in stimulating competition and wide ranging growth infrastructure, notably the standard gauge railway (SGR) and the Julius Nyerere hydropower project.

There are other hydropower projects for Ruhudji, Rusumo and Rumakali as well as the Kinyerezi gas propelled power station, alongside solar and wind power projects.

He said the government will invest in roads, aviation, transportation in lakes and sea, as well as in environmentally friendly energy sources such as compressed natural gas (CNG) in vehicles to start reducing dependence on imported oil.

Research will be conducted for producing quality seeds especially

for strategic crops to increase agrosector productivity, enhance crop values and strengthen food security, and promote crop markets.

Strengthening extension services, expanding irrigation agriculture by completing 25 schemes, rehabilitating 30 schemes and finishing works on 14 dams to harvest rainwater, is envisaged.

Enhancing access to farm inputs, procuring five vehicles carrying 30 tons of seeds, building two seed laboratories, purchasing research equipment and building three seed storage warehouses are also envis-

Building a Better Tomorrow (BBT) programme will be boosted with 30 new farms in five regions, surveying land for investment in ten regions and providing training to 1000 BBT beneficiaries, the minister noted.

Providing low interest loans to youth and women plus widening extension efforts involving young people graduating from agricultural training will be pursued, he said.

Preparations are being made for a project to supply clean water from Lake Victoria to Singida and Dodoma regions both for domestic use and irrigation, he said.

The government expects to extend loans to 93,500 degree students and 10,000 diploma course students, implement new education policies and curricula, including teacher training, he further noted.

The government will pursue efforts to build communications towers in rural areas to align rural residents to foster application of IT in economic and social activities, he

Plans for establishing car batteries and machinery factories were being pursued, along with programmes to control and eradicate mosquito breeding sites by using pesticides, so that malaria infection is brought down to 3.5 percent prevalence by 2025, he added

was speeding, trying to overtake other vehicles and switching lanes without caution, hence colliding with the bus in a horrific accident, he stated.

The deceased include seven men and two women, with the injured being two men and one woman, two of them already been transferred to the Muhimbili National Hospital (MNH) for intensive attention.

Bodies of the deceased were being kept at the Bagamoyo District Hospital for examination and handing over to relatives for burial services, he said, urging motor vehicle drivers and road users generally to adhere to road safety rules to avoid causing unnecessary accidents.

Regional Commissioner Abubakar Kunenge arrived at the scene to console those injured and relatives of the deceased, in yet another tragic event disrupting public calm.

Global traffic reports show that 80 percent of accidents are caused by reckless driving, 12 percent by mechanical problems, six percent by adverse weather, and just two percent of road accidents arise from poor road networks.

Road safety data approved by the World Health Organisation (WHO) indicates that road traffic injuries are the leading killers of people aged 5-29 years.

Each year road accidents claim lives of more than 1.3m people and disproportionately affect the developing countries, the UN agency as-

serts.

# Libyan rival leaders agree to establish unified government

CAIRO

AFTER more than a decade of political deadlock, the leaders of Libya's opposing governments have reached a significant milestone by agreeing to establish a unified government, marking a crucial step towards resolving the protracted

In a joint statement issued on Sunday, the leaders affirmed their commitment to the formation of a new unified government tasked with overseeing the much-awaited elections and consolidating sovereign positions.

The discussions, facilitated by Arab League Secretary General Ahmed Aboul Gheit, took place in Cairo, Egypt, bringing together key figures from Libya's disparate fac-

Among them were the President of the Libyan Presidential Council, the Head of the High State Council based in Tripoli, and the Speaker of the House of Representatives representing the rival administration in Benghazi.

The fracturing of Libya ensued following the ousting of long time ruler Colonel Muammar Gaddafi in 2011, leading to a division between the internationally recognised government in the western region, led by interim Prime Minister Abdul

Hamid Dbeibah in Tripoli, and a parallel administration in the east under the leadership of military strongman Khalifa Haftar in Beng-

The agreement to establish a unified government represents a crucial breakthrough in Libya's tumultuous journey toward stability and national reconciliation. This development may pave the way for a peaceful transition, fostering unity and progress across the nation.

stimulation, responsive nurturing, child protection and safety can help make the child smart, ready to be a productive adult, she said.

"Various studies in Africa show that investment in child upbringing and care is still low. The ratio between child care and investment is not in synchrony with the science of child care," she said.

"If this continues, we will prepare children who are unproductive and create unproductive human capital for our nations," she said, urging the

representatives of the various countries to use public funds to whatever extent possible to bolster early child upbringing.

The four-day meeting will help to chart out a roadmap for implementing agreements reached by Heads of State during the African Union's human capital summit back in July last year in Dar es Salaam, she elaborated.

Investment in bolstering human resources needs to focus on young children as the foundation, she said, appealing to conference participants come up with effective strategies to strengthen interventions for early child care.

Upbringing adhering to good customs and traditions was vital, she said, laying emphasis on good customs because some of them have negative effects on children, citing female genital mutilation (FGM).

Children should not experience such practices which are detrimental to their development, she said, pointing out that child upbringing is nowadays affected by many things like family conflicts where children comes out unavoidably as

"Parents and guardians have no time to care for the children as they are busy with other activities. Hence, children are left alone to look out for themselves or remain under the care of housemaids. We need to rethink and take action. These are some of the obstacles against our children's upbringing," she argued.

Information and communication technology poses many challenges such as improper and immoral use of online platforms exposing children to online child exploitation and abuse, the minister added.

THE Tanzania Ports Authority (TPA) has clarified that the Dubaibased DP World hasn't started operation at the Dar es Salaam port as it rumoured.

A statement from the TPA's directorate of marketing and relations availed to the media yesterday stated that all port management activities are still managed by the authority and when DPW will start operation at the port, the public will be informed officially.

It stated that even when DPW starts operating at the Port of Dar es Salaam, the wharfage fee will continue to be TPA's income in accordance with the agreement entered between the two sides.

According to the statement, the wharfage is currently collected through the Tanzania Customs Integrated System (TANCIS) which is

The statement noted that for domestic cargo, the wharfage fee is charged for the value of the cargo (Custom Value) whose rate is 1.6 percent for the cargo in the container as well as the cargo that is not in the container (Loose Cargo).

It stated that the on-transit cargo, which is not in a container (Loose Cargo), is charged by weight or volume at the rate of \$3. For transit cargo in containers it is charged at \$ 90 dollars for a 20 feet and \$180 for a 40 feet container.

The statement further noted that the fees are charged through the system without human intervention, so there is no possibility of making a mistake due to charging the customer more or less than the required amount according to the value of his cargo.

## Govt all for use of NeST in all funds disbursed for its development projects

THE government mulls using the National e Procurement System of Tanzania (NeST) in all funds disbursed for development projects at the grassroots, it has been revealed.

NeST means a system developed, hosted and operated by the government of Tanzania in 2022 for facilitation of procurement functions by means of information and communication technology.

NeST is the electronic system that facilitates e-registration, e-tendering, e-contract management, ecatalogue and e-auction. Public procurement is an important economic activity involving a large part of the National Gross Domestic Product

According to the new approach, all those implementing the projects will be required to adopt the new system which is at its final stages of completion at that level.

It has therefore directed that supervisors of projects will be required to adopt the NeST in all funds disbursed to implement development projects.

The Deputy Permanent Secretary in the Ministry of State, President's Office, Regional Administration and Local Government, Dr Charles Msonde issued the directive in Dodoma when launching a training on

A large part of the government budget is spent on public procurement (excluding the salary budget and the national debt).

Public Procurement in the country is governed by the Public Procurement Act Chapter 410. This Act has created the PPRA with the aim of ensuring that the public procurement system in the country is fair, competitive, transparent and adheres to value for money. Speaking at the training session, the Deputy Permanent Secretary (PS) noted:

"Currently, the sixth phase gov-

ernment is planning to disburse money to projects that will be implemented at the village level especially in education and health sectors, that is why we have decided to come up with a new transparent system that will be completed any time soon."

Dr Msonde further directed Regional Administrative Secretaries, Regional and District Procurement Officers to make sure they provide training to heads of both primary and secondary schools as well as doctors in charge of all health facili-

"A lot of funds from the government will be channelled at the grassroots level in concerted efforts to increase efficiency, therefore it is your obligation to intensify massive training so that the projects are well expedited during implementation as well as considering value for money," added Dr Msonde.

Speaking at the occasion, Training Manager from the Public Procurement Regulatory Authority (PPRA), Castor Komba, noted that the state-owned public procurement body had ensured that the eprocurement system was improved to ensure that there was smooth implementation of development projects

## CBE to introduce long-term course on corruption to bolster good governance

Prof. Lwoga said that CBE has already started the process of providing that course and she invited people from different countries to go and pursue the course at the college.

She explained that in order to ensure that the procedures of the course are followed; they will cooperate with the National Council of Examinations NECTA to find a Curriculum that will meet the teaching

The CBE Rector said that the tion, can do good work with great course will be taught at the certificate level and later the students will be given exams that will be recognized in the country and will enable the graduate to work anywhere in the world.

"Currently at CBE we offer short courses to government and private institutions on the investigation of corruption, but we are currently planning to start offering long-term courses from the certificate onwards, we are preparing the curriculum once it is completed, we will send it to NECTA for review." Prof.

Stella Cosmas, CBE Lawyer and Corruption trainer, said that after starting the long-term certificate course, students will take international exams that will enable many Tanzanians to be recognized internationally.

She said that currently many institutions have hired people from outside the country to do the work while there are many youth here in

the country who, if given the educa-

competence. The Morogoro District Commissioner, Rebecca Nsemwa, said corruption is a big challenge in the country and greatly affects access to justice in decision-making bodies including the courts and the police.

She hailed CBE for introducing the course which she said will greatly help the country heighten efforts on the war against corruption as many people will have wider understanding of the effects of corruption.

# WFP urged to restore stalled school feeding programme in schools

AUTHORITIES in Arusha Region have asked the World Food Programme (WFP) and other stakeholders to restore the school feeding plan in schools in the pastoralist communities to save children from malnutrition.

Ngorongoro district commissioner, Col Wilson Sakulo made the call here at the weekend during the launch of WFP's offices in the re-

Col. Sakulo said that WFP used to provide food to schools in the periphery and to pastoral societies, a move which contributed to increase in academic performance, understanding and decrease in school pupils skipping schools.

"The current situation has worsened and contributed to the increase in malnutrition for children below five years old especially in Longido and Monduli districts after the cessation of the feeding project. This has resulted in the decline in pupils' performance and focus in their studies in the many of the schools in the periphery," he said.

Col. Sakulo said the situation is attributed to the effects of climate change which have caused drought and frequent floods that have affected crop cultivation and animal keeping which are the primary income generation activities.

"Apart from the impacts on agriculture, drought has also affected the wild animals that attract tourists and help generate income for the people in the region and the nation. I request WFP to ponder on how to restore a sustainable plan for a balanced diet in schools in these areas in collaboration with the government, stakeholders and parents," he said.

Shayo stated that there were no women in management positions for a period of three to four years. However, thanks to the Female Future Programme run by the Association of Tanzania Employers (ATE), GGML has now appointed two women to management positions.

Additionally, GGML has launched two major campaigns: one discouraging inappropriate behaviour and the other raising awareness to eliminate sexual violence in the workplace. Any employee found guilty of such behaviour will be immediately dismissed.

Regarding the International Women's Day, the Head of State encouraged women to participate in both local government elections later this year and the general election to be held next year.

"Ahead of forthcoming elections, I would like to encourage women to show up and participate in big numbers, this would help them to communicate their concerns," she underlined.

President Samia expressed the government commitment to attain the 50/50 threshold but was quick to warn that such a goal will never come on a silver plate, insisting that delivering to the expectations of the public would always be the key.

## Women journos called on to reflect on the emerging media ecosystem

THE United Nations Educational, Scientific and Cultural Organization (UNESCO) has challenged women journalists to reflect on the emerging media ecosystem in Tanzania and globally and take full advantage of its opportunities.

Nancy Angulo, Head of the Communication and Information Programme at UNESCO Dar es Salaam made the call in Dar es Salaam over the weekend when speaking at an event to commemorate the International Women's Day (IWD).

Meeting under the auspices of Kike Africa, an emerging femaleowned tech and media company that seeks to tell women's stories in innovative ways, the event attracted over 100 participants including practitioners in the media industry and students in various colleges.

emphasised Angulo importance of journalists investing in knowledge and skill acquisition, saying it is only through such a process that journalists, especially women, can overcome their barriers.

"The digital ecosystem has unleashed a flood of competing content and turned large internet companies into the new gatekeepers. The traditional business models underpinning media sustainability are in crisis,"

She noted that the UNESCO World Trends in Freedom of Expression and Media Development: Global Report 2021/2022 highlights that audiences and revenue continue to move online, placing news media's traditional business models in crucial danger. Global newspaper ad revenue dropped by half in the last five years and by two-thirds in

the last ten years.

Social media users nearly doubled from 2.3 billion in 2016 to 4.2 billion in 2021. This has allowed for greater access to content and more voices-but not necessarily that with the distinctive value-add of journalistic content.

"As local newsrooms disappear, we as the public and communities lose our local news sources and our identity, civic engagement, and knowledge suffer from prevalent misinformation, harmful abuse and harassment on online platforms, and fading accountability," Angulo noted.

She added: "We are in a new era, defined by the power of data, the influence of the media and the imperative of inclusion."

co-founder Kike Africa Khadija Mahanga said the occasion sought to honour the achievements and contributions of women in Tanzania's media industry, particularly through the transformative power of data and technology.

Our initiatives [at Kike Africa] focus on harnessing the power technology, advocating for creativity, and fostering entrepreneurship skills through our coding and data hub," Mahanga, a software developer, said.

She added, "We firmly believe that by empowering the next generation of tech and media professionals, we can drive innovation, diversity, and excellence in these fields."

Data is the lifeline of the digital age. It holds within it the potential to transform lives, communities, and entire societies. It is not just numbers, but the faces and lives behind the statistics, a true reflection of our collective experiences, aspirations, challenges and opportunities.

To keep up with the trends, we must invest and harness the data-driven approach. Using data to inform policies and solutions must first overcome significant gaps in availability, accessibility, utilization, and stability," she said.

"In this digital age, the media is the storyteller of our times. It is, faster and stronger than ever before, shaping perceptions, influencing opinions, driving change (good or bad). It has the power to amplify voices, challenge norms and foster understanding across borders and barriers. However, with this power comes a responsibility to ensure that the stories we tell reflect the richness and diversity of who we truly are as a people. Our local stories, the local content we continue to produce are an opportunity to create placebased initiatives, driven by the specific information needs of their communities," she detailed.

She however said gender still greatly shapes the likelihood of success in the media in Tanzania, with women carrying the biggest burden of its challenges.

Maphosa Banduka, Co-Founder at Nukta Africa urged women and girls to realise power within them, utilise education opportunities and work hard to reach their full potential.

Rehema Wami, resident at Mpunguzi ward said women in rural areas were still deprived of their rights and many of them do not know how to claim them.

She said that during the harvesting period, men have been taking the lead in auctions writing their names to receive the payments which truly, their wives are required to receive because According to him, it seems they are the ones who work hard in

THIRTY people have reported to have contracted cholera in Babati District, Manyara Region where some of them are in critical condition.

Suten Mwabulambo, Manyara Region Health Officer made the statement on Friday in Babati when presenting a report before the Regional Commissioner Queen Sendiga.

He said that so far a total of 26 people have got treatment and discharged from hospitals but four were still hospitalised.

He said that the disease erupted on January 26 at Mirerani town in Simanjiro District before spreading to other areas of the region.

"So far, there is no recorded death and experts are doing all their efforts to fight the spread of the disease which include offering treatment on time and educating the public to take precautionary measures," he said.

He said in Babati Town Council, eleven cases have been reported, one case in Simanjiro Districts, and nine cases in Babati

He said the research findings will only give solutions to the rare diseases and give advice on policy and guidelines to end the diseases.

Prof Sunguya admitted that one of the big challenges is lack of scientific knowledge and credible, information on rare diseases.

rare, adding that there is often not much information already available about it.

Sharifa Mbarak, founder of Ali Kimara Rare Disease Foundation said that it was only through research the solution can be obtained.

Mbarak said that rare diseases occur when the immune system, which normally helps protect the body from infection and disease, attacks its own tissue.

She said many rare diseases have very common symptoms that can make it harder not only to identify the issue, but move further beyond

He said that some diseases are so common causes or diseases.

"It is our hope that detailed research may help to diagnose the disease and get the right treatment,"

Mbarak called on the government partners to consider supporting home schooling for children suffering rare diseases such as Lupus and supply of enough medicine at affordable prices.

"Children suffering from this type of disease cannot attend class sessions as normal. Therefore, home schooling support is important to help them learn and do examinations while at home," she said, also challenging universities

and colleges to incorporate rare diseases in the curriculum to enable new emerging doctors to know it.

According to her, studies have

shown that doctors are often taught to first consider a common diagnosis and not a rare one. Prof Karim Manji, paediatrician

said that increased awareness to the public is very important to eliminate stigma and segregation to patients suffering the diseases including right support.

He said most children born with disease do not get proper treatment and eventually die fearing stigma from the community and lack of awareness.

#### More firms could support clean cooking drive if it is above CSR

is definitely going to preoccupy portions of the public authorities for quite a while.

Th.is is even as the fortunes and possibilities of the drive seem to be one thing for those more forthcoming on the drive and as a different item altogether for the more skeptical.

To a certain extent, the positivelooking side feels - and they are largely on the right track - that it is more costly to buy charcoal than gas for a month of cooking.

When this sort of margin in the ability to refill on request would touch well over 70 per cent of households, there would likely be difficulties in ensuring that many families make the move quickly enough.

As a matter of fact, the shift would be more rapid if charcoal was not available on the market, but just slapping a ban would have exaggerated social implications including that the well-off are tired of the cooking habits of the poor.

There are locked-out options, among them cheap locally installed biomass sourcing of energy, as it would find it hard to cross regulatory controls, and dirty briquettes tied to coal dust.

While the broad emphasis on clean energy can be grasped from various angles, it has a nonnegligible cost aspect.

This is in that the project is part of wider global action on climate change adaptation, where the fossil fuel bit is left out in preference for the notion of clean energy.

It isn't as clean as renewable energy, though, as the latter no trace in the atmosphere even as the rare metals needed for renewable energy outlays especially solar energy will eventually be recognized as carry

HIFTING to clean energy risk of relatively environmentally tolerable level.

The question is what can be done right away to permit, support or facilitate more corporate entities to take up clean cooking solutions as a number of appeals have been made and taken up by some gas cylinder marketing firms.

For other companies to take up the clean cooking energy drive, it would imply they would be looking for long-term customers for the same gas firms, which can scarcely be approved by governing boards.

That means that the ball is in the court of the regulatory authorities that is, as to how clean energy can be more attractive as an agenda item targeting communities and not merely as vendors of gas cylinders.

There are two relatively simple ways to widen this appeal, one being a move by the government to absorb gas cylinder costs and slightly subsidizing prices, hence banning charcoal and obtaining the change from global climate funds.

This would enliven the gas cylinders take-up pace with community groups coming in to train women on safety in use, beefing up savings and credit cooperative societies to lend for gas refilling from time to time within a locality, etc.

The other way is roll back regulatory controls on electricity generation and the placing of meters in households or institutions as Tanzania Electric Supply Company Limited (Tanesco) business by law.

That would presumably, or hopefully, open the way for hundreds of start-ups in biogas investments, with all sorts of institutions taking up the matter in an effort to develop new sources of energy. Indeed, as founder president Mwalimu Nyerere once said, to plan is to choose.



## African Union action to reinforce elections on the continent should be driven from the top

WENTY-ONE African countries are expected to hold elections in 2024, according to the African Union's (AU) calendar. Already, the first two scheduled polls in Comoros and Senegal – which each held the last two AU chairships have been marred by irregularities.

Voter apathy characterised the presidential and island assemblies election in Comoros, where President Azali Assoumani's victory – based on a paltry 16.3% voter turnout - was disputed by the opposition, who alleged ballot rigging.

In Senegal, President Macky Sall's domination of the electoral process and postponement of the polls initially scheduled for February were met with widespread protest in a traditionally stable state. Although the Constitutional Council has overturned the postponement and elections are now set for 24 March, Sall's tampering with the process jeopardised the credibility of the polls and increased the likelihood of electoral violence.

Both instances suggest that AU member states don't respect the principles and norms of the organisation they are members of, and in Comoros and Senegal's cases, have recently led. As immediate past AU chairs, countries at the helm of the union should be setting a better electoral example.

Other than rotating among Africa's regions, there are no selection criteria for choosing the AU chair. Even so, an unwritten rule is that the chair must comply with and foster the organisation's norms and principles. When AU chairs conduct poor elections in their own countries, does this misgovernance at the top trickle down?

**Voter apathy and suppression** Africa's electoral landscape is now characterised by voter apathy, mistrust in election management bodies and destructive power contestation among political elites. A tripartite relationship exists between the AU Commission, AU chair and member states, requiring all parties to respect and enforce instruments such as the African Charter on Democracy, Elections and Governance. Have all three arms fallen short on electoral norm enforcement, and if so, how can this be fixed?

#### **Troublesome AU chairs**

The choice of AU chair is likely to have a bearing on how member states and incumbents running for re-election perceive the AU's role and influence on polls and good governance more broadly. So far, the electoral record of several African governments chairing the

Apart from the recent Senegal and Comoros cases, Egypt – while – implemented electoral reforms

Abdel Fattah El-Sisi to stand for a third term in the December 2023 elections and extend his stay in power until 2030. The 2024-25 AU Chair, Mauritania,

will hold presidential and senate elections in June this year. The country has a history of military coups, and only experienced its first peaceful transfer of power in 2019. It now faces a litmus test to determine whether its path towards democratic consolidation can be maintained. Mauritania's electoral process should be closely watched, as it could have implications both domestically and across Africa.

Although the AU prides itself on the principle of non-indifference, a chasm exists between AU norms and the practice of its member states - and the gap is widening when it comes to the conduct of elections.

Irregularities during Comoros' elections - while its president chaired the AU - were a prime reflection of how many African countries and the AU Commission undertake, observe and report on polls. The commission congratulated Assoumani on his re-election, approving the results and the electoral process, and calling for dialogue to ease political divisions. This is despite the meagre voter turnout and widespread local rejection of the outcome.

Countries

improve must

implementing AU instruments like the African Charter on Democracy, Elections and Governance. Only Rwanda and Togo have so far submitted reports. This process is a key tool that allows the AU's Department of Political Affairs, Peace and Security and member states to assess electoral and governance performance.

More sober assessments by AU election observer missions are also needed. The AU Commission's elections report to the Peace and Security Council on 24 January highlighted challenges and painted a worrying outlook for 2024 polls. This comes amid mounting criticism from civil society and opposition parties that the AU rubberstamps elections.

The AU Commission's report is a positive step, but more stringent enforcement mechanisms are needed to ensure compliance with its recommendations. One measure could be to use the implementation rate of previous observer missions' recommendations to determine whether future missions are sent.

Selection of the AU chair should also be guided by the extent to which the nominated member state complies with the organisation's instruments on governance, peace and security. The history and pattern of governance in a country should be considered when selecting the AU chair.

It is a question of forming agrosector cooperatives anchored in the private sector, where each youth brings into the project a portion of land either inherited or purchased within the vicinity as project land.

The land in question is then registered to obtain a title deed where each original participant has a specific share portion in the lot. It then thus can be used to borrow money from banks for working capital when its quality and market aspects are clear to bank analysts looking at the issue.

In both the WFP-TAHA initiative in the northern regions and in the wider skills training project for a semblance of commercial agriculture, plenty of donation financing is expected which limits the scope of take-up and success of such projects.

Thus, the very idea of business in agriculture as a preoccupation of the state and UN agencies is a welcome novelty for those with long memories of what the government has been doing in agriculture for well over 60 years.

Optimism comes in handy here: time will come when the horizon will clear up - and hence the need to hope that having weak agribusiness will one day prove better than having no agribusiness at all.

Tanzania Fisheries Research Institute (TAFIRI) report of 2023, citing FAO (2022), shows that "Tanzania is ranked 8th among the top 25 inland fish producers in the world, and is second only to Uganda in Africa and East Africa."

TAFIRI, which conducts research and monitoring on fisheries resources in Mainland Tanzania, says Lake Victoria's productive fisheries are dominated by Nile perch (Sangara), cyprinids (Dagaa) and haplochromines (Furu). According to the Fisheries Sector Master Plan (2021/22-2036/37), Lake Victoria produces about 80 per cent of all inland fish production and hosts one of the most significant export commodities, which contribute considerably to the country's fisheries export earnings.

It indicates that the fisheries sector is dominated by capture fisheries and aquaculture and is characterised by small-scale fishers and aquafarmers, who contribute more than 95 per cent of the country's total catch. Furthermore, the sector contributes about 1.7 per cent to the GDP. "The per capita fish consumption is 8.5 kg, and about 30 per cent of animal protein consumption in Tanzania is from fish and the sector is a source of foreign earnings, with an average of 10.5 per cent of annual fish landings exported to various regional and international markets."

The master plan says a big share of these products comes from inland waters and the main export product is Nile perch from Lake Victoria. "Fishing in inland waters is dominated by small-scale fishers and fish from inland waters is estimated to be 384,356 metric tonnes (equivalent to 78.63 per cent of the total weight of fish captured in Tanzania).

Fish is an important source of nutrients. It provides protein, fatty acids and minerals, particularly in areas with high fish consumption. The sector plays a significant role in socioeconomic development, foreign exchange and employment. According to the Ministry of Livestock and Fisheries (MLF, 2020), the fisheries sector provided direct employment to fishers, with the number increasing over time, from 133,197 in 2005 to 195,435 in 2020. "About 200,000 people (0.35 per cent) are full-time small-scale fishers and about 4.5 million Tanzanians (6.89 per cent) are indirectly employed in the fisheries sector in Mainland Tanzania.'

The master plan states that over the past 10 years, fish catches from inland and marine waters ranged from 375,533 tonnes in 2005 to 473,592 tonnes in 2020 (MLF, 2020), about 85 per cent of the production coming from

inland capture fisheries, 14 per cent from marine capture fisheries and 1 per cent from aquaculture. "Major commercial species include Nile perch, Tilapia and Lake Victoria sardines, while commercial marine fish includes both territorial and Exclusive Economic Zone (EEZ) species."

It shows that in 2020, 473,592 tonnes of fish (Sh2.37 trillion) were harvested compared to 362,645 tonnes (Sh1.48 trillion) harvested in 2015. Out of the 2020 harvest, 409,828.31 tonnes were harvested from inland waters and 63,763.93 tonnes from marine waters compared to 470,309.5 tonnes harvested in 2019, of which 409,333

tonnes were harvested from inland waters and 60,976.51 tonnes from marine waters. The increase in the harvest is attributed to a decline in illegal fishing activities.

Statistics show that it is mainly Nile perch fillets which are exported to international markets (mainly to the European Union, Japan and the United States), dried Lake Victoria sardines are exported to regional markets, mainly to the Democratic Republic of Congo (DRC), Zambia, Malawi and Burundi.

Other fisheries export products include crabs, prawns, fish maws, octopus, seashells, live lobsters, squid, seaweed

and ornamental fish.

Increased fisheries export products from an average of Sh379 billion (equivalent to \$164,782,608.7 per annum in 2008/09) to Sh691 billion (equivalent to \$300,434,782.6 in 2018/19) registered an increase of 82.3 per cent, which depicts a significant increase that enabled the country to earn more foreign exchange, according to a United Republic of Tanzania (URT) Report of 2020.

Based on fish stock assessment surveys conducted in different water bodies and in different years (1970s, 1994, 1998 and 2019), the abundance of fish in terms of biomass (standing stock) shows that Lake Victoria is leading (1,109,932 tonnes), followed by Lake Tanganyika (295,000 tonnes), Lake Nyasa (168,000 tonnes) and marine territorial waters (100,000 tonnes), according to TAFIRI report of

Other contributions come from small water bodies. However, the maximum sustainable yield (MSY) for Nile perch in Lake Victoria could be as high as 315,844 tonnes per year.

According to TAFIRI Mwanza and the Fisheries Department Catch Assessment Survey (CAS) conducted in 2017, Nile perch, Dagaa, Furu and Tilapia are the major commercial fish species from Lake Victoria. Dagaa contributed more to the total catch by weight (41.9 per cent), although its contribution in monetary value was low (21.5 per cent) when compared to that of the Nile perch (28.4 per

The CAS shows that Tilapia was among the species that had low catches and a very low contribution to the total catch (2.0 per cent, but highly preferred by people in the Lake Zone and its market price was second to that of the Nile perch.

# Gender inclusion is an imperative for future-ready workplaces

IHIS International Women's Day, I have been reflecting on how fortunate I am to work with so many incredible women within PwC and beyond. I see it daily on the personal side with my wife, daughter, step-daughters, daughters-in-law and many nieces, as well as the many talented women at PwC and from the broader stakeholder groups we interact with.

New insights from our Workplace Inclusion Indicator Index - which draws on findings from PwC's annual survey of close to 54,000 workers across 46 countries and territories show there remains a gender inclusion gap in the workplace that is holding women back.

The index measures the extent to which workers feel they are experiencing belonging, fairness and inclusive decisionmaking in their current work environment, and it finds that men experience higher levels of inclusion than women.

Closing this gap is critical to advancing gender equity in the workplace. Women with inclusion scores in the top quartile were 1.5 times more likely to ask for a promotion and 1.7 times more likely to seek opportunities to learn and develop new skills than those with lower inclusion scores.

Inclusion is particularly important in today's rapidly changing environment, where technologies such as artificial intelligence (AI) are reshaping the world of work and businesses have to transform their organization to remain

Inclusion in a transforming world

People need to understand the changes and prepare for what's to come. The findings point to some further concerning gender gaps but also suggest that inclusion supports women's greater readiness to try to future-proof their ca-

Women with higher inclusion scores foresee greater benefits to their jobs from AI (+6 points), have a clearer sense of how the skills their jobs require will change in the next five years (+14 points) and are, on average, 21% more confident their employers will support them with upskilling on key skills such as digital, leadership, critical thinking, and green

It's up to all of us as leaders and citizens of the world to do all we can to build inclusive workplaces where everyone has equal opportunities to develop the skills they need and reach their full potential - now and in the future.

This levelling of the playing field isn't just good for people and society but also for business. Those transforming their organization to respond to pressures such as technology, climate change and other megatrends will need the engagement and support of their entire workforce to succeed.

Focusing on inclusion can also help businesses plug talent gaps - those existing today and those we see on the horizon. Our research found that women who report higher levels of inclusion are 2.2 times more likely to recommend their employer as a good place to work and are 1.2 times less likely to change employers than women with lower inclusion scores.

So what should employers be doing now to build a more inclusive workplace?

Building an inclusive workplace culture

Based on what we learned from our own experience at

XILED and migrant women, plus those banished by the regime of Daniel Ortega and Rosario Murillo, united in a march of "resistance" and 'solidarity," held in Costa Rica on March 8th, in commemoration of International Women's Day.

The demonstrators, a key component of San Jose's national march, issued an urgent call to the democratic governments of Latin America and the world to adopt conclusive measures to stop the Nicaraguan government

Beginning at 4 pm, a diverse group of Nicaraguan women gathered at San Jose's Central Park in response to a call from the group Nicaraguan Feminists Exiled in Costa Rica. The group is made up of women's collectives and organizations, plus independent feminists residing in the country. This is the sixth year they've marched in Costa Rica, since all non-government demonstrations have been prohibited in Nicaragua since 2018, when a de facto police state was imposed there.

"We demand justice, and we persist in the struggle for our rights in the face of the escalation of state violence we've faced in Nicaragua since 2007, violence that intensified during the crisis of 2018. Marching in this country [Costa Rica] is an act of resistance," declared Diana Herrera of the La Corriente Feminist Association, one of more than 200 women's organizations shuttered by the Nicaraguan dictatorship and reestablished in Costa Rica in 2023.

The organizing commission for the March 8 march in Costa Rica opted to place the Nicaraguan bloc at the head

of the demonstration, right after the initial banner that

opened the march, which began at 5 pm. The Nicaraguan feminists held signs with the faces of the 19 female political and student activists, feminists, and human rights advocates that are still being held as political prisoners in Nicaragua.

"It's impossible for the Ortega-Murillo government to speak about women's rights in a country where they don't guarantee minimum conditions to live with dignity and access to justice. Marching here signifies resistance, and our determination to continue fighting for our rights and for the women who are still in Nicaragua, with no access to a decent life," commented "Cosette," an independent feminist who lives in Costa Rica. She asked to remain

# **Great Barrier Reef: New mass** bleaching event posing threat to famous world heritage site

USTRALIA'S iconic Great Barrier Reef is suffering another mass bleaching event, officials have con-

Bleaching occurs when heatstressed corals expel the algae that give them life and colour. It is the fifth time in eight years

widespread damage has been detected at the Unesco World Heritage site. Only two mass bleaching events

had been recorded until 2016, and scientists say urgent climate action is needed for the reef to survive.

"The frequency and scale at which these mass bleaching events are now occurring is frightening - every summer we're holding our breath," said Greenpeace Australia's David Ritter.

"Claims that Australia is taking the health of the Great Barrier Reef seriously ring hollow when we continue to expand and subsidise the coal and gas industry to the tune of billions every year."

"It's literally cooking the Reef," the Climate Council's Simon Bradshaw added.

Stretching over 2,300km (1,400

miles) off Australia's north-east coast, the Great Barrier Reef is the world's largest coral system and one of its most biodiverse habitats.

An aerial survey of 320 reefs - from the tip of Australia to the city of Bundaberg - showed most are experiencing prevalent bleaching, after a summer of heightened sea temperatures.

# It's Africa's time to shine, says UN **Under Secretary Claver Gatete**

**VICTORIA FALLS** 

WITH 20 percent of the global population and vast untapped natural resources, not forgetting its human capital, it is time Africa had its rightful seat at the global table, the United Nations Under Secretary and Executive Secretary of the Economic Commission for Africa (ECA), Claver Gatete (pictured) declared.

Decrying that Africa has been on the back foot on the global stage when key political and economic decisions are made, Gatete says it is time Africa claimed its voice. Gatete told a recent conference of African finance ministers in Victoria Falls, Zimbabwe, that Africa is in a financial and fiscal crisis because a global financial system does not have the interests of the continent at heart.

#### **Africa Must Be Heard**

"So, what will it take for African countries to really feel heard? Gatete asked.

"It is okay for us to say that 80 years ago, Africa was not at the table. It is probably acceptable to say that when the Millennium Development Goals were adopted, we were also at the periphery," he said, adding, "But we will not be forgiven today if we do not occupy centre stage as architects of a new global financial architecture that works for

Africa, he noted, was facing multiple crises that it was not directly responsible for but bore the worst impacts from the Ukraine-Russia war, COV-ID-19, and high indebtedness to climate change.

The financial difficulties that Africa is currently facing are not solely the result of COVID-19 or recent conflicts but also have their roots in an inadequate global financial architecture and a multilateral financial system that does not adequately serve Africa's needs, Gatete said.

Referring to the creation of the UN in 1945, Gatate pointed out that the five permanent members of the Security Council-China, the United States, the United Kingdom, France, and Russia–made up almost 50 percent of the world's population then, countries in Europe earn over USD 100." 

but today that figure is just 26 percent.

"While Africa now represents nearly 20 percent of the global population, it is not represented at the G7, whose proportion of the global population is only 9.7 percent. So how do you solve today's problems with outdated 80-year old structures that do not reflect the global shifts that have occurred?'

Africa has long pushed for a seat on the UN Security Council, calling for the reform of the United Nations in line with the Ezulwini Consensus, agreed in 2022. The Ezulwini Consensus is a position on international relations and UN reform agreed upon by the African Union. Africa wants at least two permanent seats and five non-permanent Security Council seats chosen by the African

Addressing the third summit of a group of developing countries (G77) in Uganda in January this year, UN Secretary General, Antonio Guterres said there is agreement for Africa's representation on the Security Council.

"So for the first time, I'm hopeful that at least a partial reform of the UN Security Council could be possible for this flagrant injustice to be corrected and for Africa to have at least one permanent member in the Security Council," Guterres said.

#### A Green Transition Good for Africa

Highlighting that a productive green finance system in Africa has the potential to generate USD 3 trillion by 2030, Gatete urged that Africa needs to move from 'potential' to tangible actions with bankable regional projects.

Innovative instruments like debt-for-nature swaps, regional blue bonds, natural capital accounting, and regional carbon markets can provide financing that addresses debt issues and fosters environmental action, he noted, emphasizing that Africa wants a fair price for carbon trading.

"It does not make sense for African countries to earn less than USD 10 per ton of carbon while



#### A Call to Change the Global Financial Architec-

It is estimated that Africa spends nearly USD 100 billion on debt repayments annually, forcing many governments to defer investments in social spending on health, education, and food security.

ECA Deputy Executive Secretary and Chief Economist, Hanan Morsy, weighed in, saying there is a need to reduce the debt burden on African countries to enable them to allocate more resources to critical sectors like healthcare and education instead of high debt ser-

"It is imperative to enhance Africa's voice and representation, shifting from being rule takers to rule makers," said Morsy, adding, "This involves bolstering international cooperation on taxation and combating IFFs, including reducing tax evasion and profit shifting.'

Deputy Chairperson of the African Union Commission, Monique Nsanzabaganwa, said Africa's potential to reclaim its long-overdue rightful treatment was materializing as the global landscape took multi-polar shapes and the African Union became a full member

"Africa is stronger together," Nsanzabaganwa said, adding, "I will argue that the value proposition of the African Union is indeed to foster coherence in our strategies and amplify our common voice."

# In climate-related flooding, Ugandan river turns poisonous

IGHT as the Nyamwamba River emerges from the foothills of western Uganda's Rwenzori Mountains and begins its final descent onto the savanna, it passes by a curious sight.

On the far bank from the road, past piles of sun-bleached stones on the now-dry riverbed, the earth has been disturbed. Towering walls stand naked and exposed amid the surrounding hills, as if a mighty hand has taken a scoop from the very landscape itself. Sheer cliffs emerge abruptly from the green scrub above, crashing downward into a flat, brownish pit of sand and rocks.

This is a copper tailings pool. Along with its siblings, it's poisoning this part of Uganda.

The pools were built to hold waste from a mine once operated by Falconbridge, a Canadian company that ruled over the Rwenzori foothills from the 1950s to late '70s. In its hevday, Falconbridge's copper mine, based just up the road in the small town of Kilembe, was the churning engine of Uganda's economy. The mine once employed more than 6,000 people and accounted for nearly a third of the coun-

Falconbridge was chased out of Uganda by Idi Amin in 1977, who nationalized the mine in the final years of his rule, convinced that his government could run it as well as the Canadians and keep more of the copper's value at home. By 1982, it was shuttered.

In Kilembe, Falconbridge's ghostly remains are ubiquitous. Decaying company housing is still occupied by former employees and their descendants. Rickety mining infrastructure dots the hillside. The tailings pools stand as monuments to what was once taken from here and sent northward to feed the booming engines of Western capitalism's golden age.



Pools of menace

In all, there are 15 million metric tons of copper tailings in the area around Kilembe. A decade ago, Mwesigye and his colleagues began to investigate their impact on health and the environment. In the period since, study after study have shown startling results.



In Kilembe, the soil is contaminated, dust found inside of people's homes is toxic, and even the grasses that livestock and wild animals graze on show elevated traces of heavy metals.

Copper, cobalt, arsenic, nickel, zinc and lead is everywhere. There's nickel in the cassava and beans grown along the Nyamwamba's banks. Copper concentrations are several times higher than average in people's toenails. In more than half of the samples taken of drinking water near Kilembe and downstream in 2017, there were unsafe levels of cobalt. The soil is contaminated, dust found inside of people's homes is toxic, and even the grasses that livestock and wild animals graze on show elevated traces of heavy metals.

The concentrations are particularly high, often dangerously so, near Kilembe. But they can also be found further downriver, near the more populous

"Over times these wastes have been eroded into farms and the River Nyamwamba, which is a main water source for locals," Mwesigye said in a phone interview with Mongabay. "The danger is that they contain heavy metals, including those which are very toxic. We're looking at copper, cobalt, zinc, arsenic, manganese and iron. We tested and found more than 42 elements in those wastes, and they are ending up in drinking water supplies and agriculture." Some of the elements washing into the Nyamwamba are carcinogenic. Cobalt, for example, was recently escalated by the European Commission as a Class 1B risk, meaning excessive exposure to it is almost certain to cause cancer. Samples of vams grown near Kilembe in 2019 showed levels of cobalt that exceeded the safe limit for children

in particular. "Cobalt is the second most abundant contaminant within Kilembe after copper," Mwesigye said. These toxins are causing a silent but growing health

crisis in Kilembe, he added. "We surveyed the Kilembe hospitals and health facilities, and we found that there are high rates of cancer and gastrointestinal diseases, both of which are associated with exposure."

There have been no definitive studies linking the prevalence of heavy metals in Kilembe and Kasese with elevated cancer rates – yet. But media reports suggest these rates are higher than average compared with other parts of Uganda. Municipal officials in Kasese say they suspect the tailing pools are to blame, with toxins showing up in the produce people eat.

"We are afraid that the increase in cancer in the area might partly be caused by the water used to grow food," said Chance Kahindo, Kasese's mayor.

Mwesigye's findings have been backed up by other researchers. In a 2020 study published in the Octa Journal of Environmental Research, samples taken from the Nyamwamba near Kilembe were shown to have levels of copper and cobalt that exceeded safe limits set by the World Health Organization. Tissue samples taken from the river's fish, a crucial source of local food, were also recorded as having accumulated unsafe amounts of cobalt, lead and zinc.

Environmental advocates say it's almost certain that the metals are also affecting wildlife in Queen Elizabeth National Park, a sprawling nature reserve that the Nyamwamba cuts through on its way into Lake George. A UNESCO World Heritage Site, the park is home to lions, buffalo, leopards, hippos and African savanna elephants. "These copper tailings end up journeying into the water," said Edwin Mumbere, director of a Kasesebased environmental group. "So there's heavy metal pollution that isn't only affecting us as a community, it's affecting animals in the park."

As far back as 2003, a study showed higher-than-normal concentrations of copper and zinc in Lake George, about 30 kilometers (19 miles) downstream of Kilembe, including in the fish that feed tens of thousands of people in the region. The levels detected in their flesh were considered safe for human consumption – but that was before the Nyamwamba's floods started getting worse and more frequent.

In 2022, a researcher with the Uganda Cancer Institute told a journalist that cancer cases from Kasese "seem to be increasing," but the link between health problems in the region and the prevalence of heavy metals hasn't been thoroughly studied.

According to unpublished data shared by the Kampala-based Uganda Cancer Institute, a recent study did not show higher-than-average rates of cancer in Kasese district as a whole. But the figures covered the district's full 800,000-strong population, and hadn't been disag-

"Foods that are grown in Kilembe are sold all over Kasese town," Mwesigye said. "So there's a likelihood that residents of Kasese are consuming contaminated foods ... and when there's flooding, you'll find the tailings there, because the River Nyamwamba busts its banks and spreads waste all over."

For people in the region who do contract cancer, wherever it comes from, a painful ordeal often awaits. If they don't have the money to pay for treatment in one of Kampala's specialized private wards, there's little they can do besides wait for the disease to consume them. Media reports speak of stricken patients slowly dying at home without receiving proper care.

Old scars reopened by new wounds

The toxins coursing through the life systems of Kilembe have produced a catastrophe that's both urgent and, at least for now, part of the fabric of life. There's no choice: even as the waters rise and the poisons soak deeper into it every year, people who call the Nyamwamba's banks home must adjust. It isn't a unique situation. As ecologies change and the bill for the 20th century comes due, people closest to that debt often don't have any option other than to try and work around it.

Across the African continent, as well as in other places whose forests and mines fed the engine of global growth, there are wounds, infected and seeping even when the hands that opened them are long gone.

"We're still in the extractive phase in countries in Latin America and Africa, but the problem will be in a century when they will have the legacies," said Flaviano Bianchini, director of Source International, an NGO that campaigns on behalf of mining-affected communities. "The cost of cleaning the pollution caused by a mine is huge, enormous. Millions and millions and millions [of dollarsl."

In Africa, these legacies are already festering. In Uganda's neighbor, the Democratic Republic of Congo, a copper mine owned by the Swiss multinational Glencore in Lualaba province has rendered farmland unusable and poisoned local waterways. In 2022, the company agreed to pay \$180 million to the country after admitting that it spent more than a decade bribing senior officials there.

Further south, in Zambia, children born in the town of Kabwe, which hosted a lead mine operated by the British giant Anglo-American between 1925 and 1974, can have blood lead levels as high as 20 times the safe limit. Kilembe isn't an outlier – it's the norm.


Some public interest lawyers are trying to turn the tide and hold companies accountable. But they face an uphill battle. In December, a South African court threw out a case that the U.K.-based firm Leigh Day brought against Anglo-American over the damage it left behind in Kabwe.

The court said that by trying to force Anglo-American to pay for the mess, the plaintiffs wanted to "advance an untenable claim that would set a grave precedent."

While Leigh Day is currently working towards appealing the ruling, it symbolized the difficulties that communities face in African courts when they take on mining giants or governments. Impunity has taken a toll. "When it comes to the harm that has been suffered by workers and communities, the lack of access to justice locally has meant a lack of deterrence and an insufficient incentive on companies to behave better," said Richard Meeran, the lead attorney from Leigh Day on the Kabwe case.

When companies pack up and leave, whether because a mine has been depleted, the operation has become financially unviable, or over a dispute with the government, it's the people who live nearby – those with the least resources – who are left holding with the bill. "Legal systems must evolve to hold companies accountable," Marcos Orellana, the U.N. special rapporteur on toxics and human rights, said, adding polluters should be held accountable for the harm they have caused to communities and the environment."

It won't do much good for anyone living in Kilembe or Kasese to knock on Falconbridge's door. In 2006, it was acquired by the Swiss-Anglo firm Xstrata, in a \$22.5 billion deal that was one of the biggest in Canadian history at the time. A few years later, Xstrata was taken over by Glencore, the world's largest commodities trader. According to company data, in 2022 Glencore posted a record profit of \$17.3 billion, paying more than













# Horticulture keeps its spot in 1trn/- industry club

ORTICULTURE sub-sector, which employs at least four million people, has maintained its slot on 1trn/- industry club, after doubling its exports earnings over the last five years, which is nearly half of the amount generated from traditional exports.

According to the provisional data by Tanzania Revenue Authority (TRA) and Bank of Tanzania (BoT) computations, earnings from exported horticultural products amounted to US\$414.8 million (1.04trn/-) during the year ending in January, 2024, compared to US\$212 million (526bln/-) recorded in

The amount was higher than the exports earnings from cashewnuts, cotton, sisal and tea combined, and was nearly a third of earnings from exported manufactured goods.

Currently, the horticulture industry contributes 38 percent of the total agricultural sector's foreign exchange earnings.

Provisional data show the edible vegetables accounted for three quarters of total earnings from exported horticultural products, which amounted to US\$312 million in January this year, more than doubled of US\$145 million recorded in 2020.

However, the amount of earnings from exported edible vegetables was lower than US\$313.3 million recorded in 2022, whereby the total earnings from exported horticultural products amounted to US\$381.1 million.

The BoT's monthly economic review for February has shown that the earnings from exported floriculture amounted



to US\$26.6 million during the year ending in January, 2024, lower than US\$31.9 million recorded during similar period in 2020.

Exports earnings from fruits increased four times to US\$43.2 million during the year ending January 2024, from US\$10.6 million recorded in 2020, while other horticultural products fetched US\$32.3 million, an increase from US\$23.7 million, according to TRA data.

With the purchase of Air Tanzania Limited's new cargo plane, stakeholders say they expect further increase of exports of horticultural products, as it has solved the long term logistic challenges, specifically air transport to move perishable products to overseas market.

According to the International Trade Centre (ITC), major Tanzanian trading partners for fruits and vegetables include European Union, the Middle East, East African Community (EAC)

and SADC member countries.

Tanzania is among the 20 largest producers of fresh horticultural produce globally, while the leading countries are Mexico, Vietnam, the Netherlands, the United States, Spain, Germany, Canada, China, Peru, and Turkey.

According to Tanzania Horticultural Association (TAHA), the major regions in Tanzania where horticultural crops are grown include Morogoro, Iringa, Mbeya, and Ruvuma in the Southern highlands; Arusha, Kilimanjaro, Tanga and Manyara regions in the Northern corridor and Coast region, Zanzibar in the Coastal zone (usually dominated by small-scale farm-

Looking forward, the government plans to unlock the full potential of horticulture as it seeks to make the industry the largest source of foreign exchange by targeting US\$2 billion by 2030.

According to TAHA appropriate infrastructure, right skills to farm-

ers to produce required quality and volume to meet the standards of oversee markets, and investmentfriendly policies to attract Foreign Direct Investments are necessary to spur growth of the industry.

In 2021, the government published the National Horticulture Development Strategy and Action Plan 2021-2031 to guide a horticultural sub-sector in the next ten years (2021-2031) towards a vibrant and sustainably competitive in the domestic, regional and international

The total cost of implementing the National Horticulture Strategy is expected to be around 4.7trn/-, according to the ministry of agricul-

The strategy envisages transforming horticulture into a competitive industry capable of contributing significant generation of foreign income and reducing poverty through the sustainable supply of high quality produces to domestic, regional and international markets.

# Indian diaspora propose for Zanzibar-India direct flight

INDIAN Diaspora have called upon Indian government to introduce an additional direct flights from India to Zanzibar at least twice a week to enable businesspersons, tourists, Indian diaspora, students and patients to go to India on time as well as boosting trade and tourism.



# Firm benefits villagers through its PPP project

WHEN properly planned, organized and well implemented, the Public Private Partnership (PPP) can bring about gains not only to the investor but also to the surrounding community where's the project is being implemented.

## Pound beats 92pc of global currencies on **UK economic rebound**

**LONDON** 

THE British pound is beating more than 90pc of the world's currencies this year on signs the nation's economy is holding up better than expected, keeping interest rates higher for longer.

Only 11 currencies – including those of Kenya, Zambia and Sri Lanka – have outperformed sterling in 2024. according to a universe of more than 140 global foreign-exchange rates tracked by Bloomberg.

The reason is simple, according to analysts: Britain's economy is looking more resilient than feared. That's set to encourage the UK to keep interest rates at their current levels for longer than many of its largest counterparts, including the US Federal Reserve and European Central Bank.

While the Fed and ECB are seen cutting in June, traders only expect the Bank of England to begin easing

"Last year the UK had the worst growth-inflation mix in major economies. Now, the economy seems to be recovering, while inflation is coming down," said Athanasios Vamvakidis, head of G-10 currency strategy at Bank of America, who sees the pound rising to \$1.37 by yearend. "The data mix is getting better, which supports GBP, particularly given a bearish consensus."

The pound rose to around \$1.29 last week, its highest level in seven months, recording its best week since November versus the dollar. Data in coming days could help reinforce those gains and bolster the narrative that the UK economy is making a comeback.

Average weekly earnings are forecast to show the job market in the UK remains robust, with wages rising 5.7 percent. Monthly gross domestic product data will likely show the economy growing again in January after a mild contraction in December, while industrial production is set to post a 0.7 percent

annual advance, a slightly faster pace than the month prior.

The UK avoided the sharp downturn that many had predicted for 2023, but aggressive interest rate hikes that took the key rate to 5.25 percent still left the economy stagnating. Consumers came under immense pressure as the cost of food, energy and mortgage payments all soared, crimping spending, and business confidence plunged to its lowest since the global financial crisis.

But Bank of England Governor Andrew Bailey last month said there had been "encouraging signs" on the key indicators in the jobs market and services prices, even as he stressed that policymakers are looking for evidence that progress can be sustained. And there's ample reason to remain cautious: UK consumer confidence for example slipped back in February, suggesting households are not ready to splash out.

Bailey's "assertion that the worst is already over for the UK economy is finding a little traction," said Jane Foley, the head of FX strategy at Rabobank. "This will be tested next week with the release of key data."

The rally also comes as the market leaves behind the uncertainty surrounding the UK announcement last week.

Some investors had been worried the government could announce big giveaways before elections later this year – especially given the Conservatives are trailing in the polls by a wide margin to opposition Labour. Markets went into a tailspin in 2022 after Liz Truss' government tried to stimulate growth with unfunded tax cuts.

"The fact that the pound has risen and bond yields have fallen in a Budget week is a sign of how far we have moved on from the ill-fated Truss era," said Kathleen Brooks, research director at XTB. "The pound's rally is also a sign of confidence in the UK, after a fairly dismal few year.

# Bank group reports resilient earnings amid tough environment

ABSA group reported a resilient set of results for 2023, delivered in an operating environment that was weaker than expected, particularly in South Africa where continued electricity supply disruptions, supply chain logistic issues and sticky inflation along with a higher interest rate environment weighed on growth prospects for customers and clients alike.

However, Africa regions reported very strong growth, well ahead of South Africa.

Within this context, normalised headline earnings increased 1 percent as pre-provision growth of 6 percent reflected continued momentum in the business, offset by higher credit impairments, particularly in South Africa, Absa's largest market by revenue.

Strong revenue growth of 8 percent to R104.5 billion meant that the Group crossed the R100 billion revenue thresholds for the first time, with stronger growth being generated within Africa Regions.

"Despite a challenging climate, Absa remains resilient and the underlying franchise is strong and growing," said Arrie Rautenbach, Absa Group Chief Executive Officer. "We are seeing the benefits of the strategic choices we made in 2018, as is evident from our diversified business, growing customer franchise and engaged workforce," he said yesterday when presenting the performanc-

The Group's customer base expanded 4 percent to 12.2 million in 2023 from 11.7 mil-

lion a year earlier and customer experience scores, which measure the quality of service experienced by customers, increased across all business units.

Absa is driving organisational health gains through a journey that commenced with a strengthened leadership team and a reorganised business model in 2022. In 2023, the Group rallied behind a co-created corporate purpose and a refreshed set of values as it drives a culture shift in order to promote sustainable outcomes.

Employee net promoter score, which indicates the likelihood of employees recommending Absa as a bank of choice, increased materially, signaling enhanced organisational health.

The Group's broad-based black economic empowerment transaction, which placed 7 per cent of Group shareholding (equivalent to R11.2 billion at the time) in the hands of employees and communities, is anticipated to further support this culture shift.

In addition to its investment in the B-BBEE transaction, Absa invested in other areas for future growth, recruiting additional frontline staff, acquiring new technology and refreshing its brand.

These were among costs that contributed to a 10 percent increase in operating ex-

Absa expanded its employee base and at the same time invested more in new digital capabilities to enhance customer experience both in branches and online.

The number of digitally active customers

increased from 3.4 million to Africa regions grew to 29 3.8 million.

Absa also invested in updating its brand identity and positioning during 2023, culminating in the launch in February 2024 of its repositioned brand, signaling a shift to being a more deliberately customer-centric business with the new brand promise of 'Your Story Matters'. The new brand promise commits Absa to demonstrating empathy and offering seamless customer experience.

"We have made significant strides in the last five years in strengthening our business," said Chris Snyman, Absa Group interim Financial Director. "We have strengthened our balance sheet, enhanced diversification and we continued to grow, while focusing on efficiency," he said.

The Group achieved 7 percent compound growth in revenues since 2018, while cost-to-income ratio improved to 52 percent from 58 percent in 2018.

Absa's results showed the benefit of diversification and

percent of total Group preprovision profit, compared with 20 percent in 2018.

The Group's Corporate and Investment Banking arm now contributes a third of Group pre-provision profit, compared with 28 percent in 2018.

Absa acquired HSBC Mauritius' Wealth, and Personal Banking and Business Banking businesses, pending regulatory approvals, during the year. covered, including their tuition fee. The SKIES initiative commenced with a call for applications that drew responses from 1,167 rapid tech skills students, showcasing a significant demand for such programs.

## Uganda Airlines seeks renewal of operation licence

OFFICIALS at the national carrier this week defended their application to renew their licence of operations before the Board Air Service Licensing Committee of Uganda Civil Aviation Authority (CAA).

This comes after the civil aviation conducted a public hearing to interact with stakeholders from the aviation industry to consider deferent applications and renewal of licence by the regulators.

Uganda Airlines chief executive Jenifer Bamuturaki said the airlines has registered 66 percent of internally generated funds to facilitate its operations away from government support and this is attributed to its newly opened routes and increase in number of passengers.

"The government supports us with almost 34 percent," she said, "our vision is to be completely independent and instead support the government as Uganda Airlines."

She added the national carrier is set to fly to China. "We are looking at the route to Guangzhou, the teams have already submitted all requirements needed by the Chinese authorities," Bamuturaki revealed.

Two air operators, including Aero Maintenance Company Ltd, joined Uganda Airlines, seeking to operate a nonscheduled passenger and cargo service and eagle air seeking to operate aerial work including survey and photography in the air space are part of the licence applicants.

The Board chairperson of Air Service Licensing Committee, Justice Steven Kavuma, said: "I'm so glad that Uganda airlines and CAA are working together to improve the operations within the aviation industry."

The applicants have to be approved by the regulators in a period of 30 days to start their operations.

Last year, the civil aviation authority successfully passed the Universal Safety Audit Oversight (USAO) under International Civil Aviation Organization (ICAO) with over 72.2 percent, a best performance on safety.

Deputy Director General, CAA, Olive Birungi Lumonya said the stakeholders meeting aimed at discussing regulations, strategic plans, challenges among others across the aviation

"I would expect a hotter number to drive the market down unnecessarily," said Peter Andersen, founder of Andersen Capital Management in Boston. "Though there is still a narrative that the Fed will cut rates as soon as possible."

Sticky inflation data for January and signs of a robust economy halted the AI-led rally last month, leading traders to push back bets on

the timing of the first interestrate cut to June from March. Federal Reserve officials

are in a media blackout ahead of their latest rate-setting meeting next week.

At 9:39 a.m. ET, the Dow Jones Industrial Average was down 75.72 points, or 0.20 percent, at 38,646.97, the S&P 500 was down 9.74 points, or 0.19 percent, at 5,113.95, and the Nasdaq Composite was down 21.81 points, or 0.14 percent, at 16,063.31.

#### Macron backs 'end of life' bill, aims for parliament debate

**PARIS** 

PRESIDENT Emmanuel Macron said on Sunday for the first time that he backed new end-of-life legislation that would allow what he called "help to die" and wanted his government to put forward a draft bill to parliament in May.

France's neighbors Switzerland, Belgium and the Netherlands have adopted laws that allow medically assisted dying in some cases. But France has resisted that step, in part under pressure from the Catholic Church.

The Claeys-Leonetti law on the end of life, adopted in 2016, authorizes deep sedation but only for people whose prognosis is threatened in the short-term.

In an interview with Liberation newspaper, Macon said he did not want to call the new legislation euthanasia or assisted suicide, but rather "help to die".

"It does not, strictly speaking, create a new right nor a freedom, but it traces a path which did not exist until now and which opens the possibility of requesting assistance in dying under certain strict conditions," he said.

Macron said those conditions would need to be met and a medical team would assess and ensure the criteria for the decision was correct.

It would concern only adults capable of making the decision and whose life prognosis is threatened in the medium-term such as final-stage cancer, he said.

Family members would also be able to appeal the decision, Macron said.

The bill builds on the work of a group of 184 randomly appointed French citizens who debated the issue.

They concluded their work last year with 76 percent of them saying they favored allowing some form of assistance to die, for those who want it.

The decision to push ahead with the end of life legislation comes after the right to abortion was enshrined into the French constitution, following an overwhelming vote by lawmakers earlier this month.

Macron has sought to bolster his image as a social reformer just three months before June's European parliamentary elections. His party is more than 10 points behind the far-right Rassemblement National in polls.

#### AU expresses deep concern over security threats to Africa's development

#### **ADDIS ABABA**

THE African Union (AU) has expressed its "deep concern" over prevailing security perils across Africa as major impediments to the socio-economic development of the continent.

The statement was made by the AU's Peace and Security Council in a communique issued Saturday that followed its recent meeting, which dwelt upon the current situation in the conflict-hit eastern Democratic Republic of the Congo

Reiterating its deep concern over the scourge of conflicts across different parts of Africa, the council said these conflict and insecurity situations are obstructing the socio-economic development of the continent.

Against this backdrop, the council underscored the 55-member continental organization's strong commitment to realizing its 50-year continental devel-

opment blueprint, Agenda 2063, with particular emphasis on its flagship peace and security aspirations, including silencing the guns in Africa by 2030.

It further stressed the need to realize African leaders' recent pledge to achieve the goal of a conflict-free continent, to make peace a reality for all of Africa's citizens and not to bequeath the burden of conflicts to future generations.

Addressing the 37th Ordinary Session of the Assembly of the Heads of State and Government of the AU last month, AU Commission Chairperson Moussa Faki Mahamat expressed similar concern over peace and security challenges in Af-

Faki specifically highlighted recurrent conflict situations, unconstitutional changes of governments and political and institutional instability as factors jeopardizing the continent's stability, peace and development.

tares). In addition, the county has established a white lotus industrial chain with an annual comprehensive output value of more than three billion yuan (\$416.8 million). Behind the thriving white lotus industry are magic space-bred seeds.

Established in 1984, the Guangchang White Lotus Research Institute strived to cultivate new varieties of lotus seeds. However, no matter how hard researchers tried, the yield per mu of lotus seeds remained at around 50 kilograms.

To break through the bottleneck problem, the institute had to take a different approach. In 1994, Liu Guangliang, the then head of the institute, attended a meeting in Beijing and learned that China was conducting space breeding to mutate genes

of seeds in the special mutagenesis environment in space, so as to create new varieties.

That year, researchers sent 442 lotus seeds selected from over 10 lotus varieties into space by a retrievable satellite. The lotus seeds were subjected to space mutation for 14 days and were then mailed back to the institute. After categorizing and numbering the seeds by variety, staff members sowed each seed in a separate breeding container.

Unexpectedly, over 180 lotus seeds failed to germinate initially. After extensive consultations and research, researchers realized that cosmic rays in space were strong enough to result in the failure of germination of some weak seeds.

To ensure that the remaining lotus seeds would sprout, Liu and team members got to the institute early and stayed late. Lacking temperature-controlled incubators, researchers got up at 5 a.m. to put seed trays in the sun. Several months later, they achieved encouraging results: some varieties showed early ripening, with flowers being more than that of ordinary varieties, which indicated a very high yield potential.

These unique varieties were then propagated several times. After four years of careful breeding, a new variety named "No. 36 space lotus" was created, with longer growth duration, more flowers, larger lotus seedpods, higher ripening rate, and better quality. The per-mu yield of seeds of the new variety exceeded 120 kilograms.

In 1999, Guangchang started the experimental planting of the No. 36 space lotus in over 20

planting bases. At first, farmers who used to grow traditional lotus varieties were not interested in the new variety. Encouraged by technicians from the institute, Xie Changjun, the then head of Xialan village in Xujiang town, Guangchang, took the lead to plant the space lotus on four mu of land.

When summer arrived, the space lotus grew beyond Xie's expectations, with the average yield of lotus seeds per mu of farmland reaching 130 kilograms that year. This made a splash in the whole town as crowds of people lined up in the fields to purchase Xie's lotus seedlings.

In just a few years, the planting area of the space lotus in Guangchang exceeded 100,000 mu. Since then, the No. 36 space lotus has made its

name and has been promoted to production areas of lotus

seeds across China. "A number of lotus varieties bred using the space lotus as the main breeding material have become the top choices for aquatic landscaping in China, driving the development of the country's lotus tourism," said Jie Zhihui, director of the white lotus industry develop-

ment center in Guangchang. Jie added that the No. 36 space lotus has been promoted across the country with a growing area of more than 20 million mu, accounting for over 80 percent of the total cultivation area of lotus seeds nationwide.

In Guangchang alone, the annual output of dried white lotus seeds reaches 9000 tons, generating an output value of

800 million yuan. In addition, the county receives 2.7 million tourist visits annually, with its tourism revenue surpassing 700 million yuan.

Guangchang is now home to several manufacturers of automatic lotus seed processing machinery, over 20 white lotus product processing enterprises, and more than 130 white lotus cooperatives, with the annual comprehensive output value of the white lotus industry exceeding three billion yuan.

To continue expanding production and strengthening brand building, Guangchang has placed importance on attracting talents and promoting innovation.

Zheng Xingwen, a genetics PhD student at Wuhan University's College of Life Sciences in central China, is one of the outstanding talents introduced to Guangchang.

## US presidential election enters new phase as Biden, Trump ratchet up fight

WASHINGTON

THE 2024 U.S. presidential election has entered a new phase as both U.S. President Joe Biden, the Democratic incumbent, and former President Donald Trump, the presumptive Republican nominee, held campaign rallies in the swing state of Georgia recently to step up their reelection ef-

The two launched attacks against each other while having deep political grievances. They also have significant differences in their major policy posi-

Analysts believe that as the election campaign unfolds, it may further intensify political disputes and public divisions in the country, potentially leading to more chaos.

"Trump and I have a very different value set," Biden told supporters in Atlanta, Georgia, noting that if Trump returns to the White House, the United States will be filled with "resentment, revenge and retribution."

Additionally, Biden criticized Trump's positions on issues such as abortion, taxes, and immigration.

On the same day, Trump held a rally in Rome, Georgia, where he attacked Biden on immigration and border security, accusing him of allowing illegal

immigration from the southern border, saying Biden's "crime" will never be forgiven.

At the rally, Trump also mocked Biden's mannerisms. Georgia, located in the southeastern United States, was won by Trump in the 2016 presidential election. Four years later, Biden narrowly claimed victory

On that day, four states -- Georgia, Hawaii, Mississippi, and Washington -- will hold Republican primaries. Meanwhile, Biden is expected to secure the Democratic presidential nomination as early as March 19.

"A rematch means the stakes are high for America," Brookings Institution Senior Fellow Darrell West told Xinhua. "The visions Trump and Biden have for the country are radically different," he said.

In recent national polls, Trump is slightly ahead of Biden, and he leads in most swing states' polls. Biden has stated that these polls don't mean anything, and it is too early to conclude.

An analysis by Politico suggests that Trump is "gaining momentum," but he faces issues such as campaign funding, party unity, and a series of legal troubles.

Trump is embroiled in four criminal cases, facing a total of 91 felony charges, and has recently been fined hundreds of millions of dollars in two civil cases. He denies all charges and accuses Biden and the Democratic Party of ongoing "political witch hunts" against him.

# Guizhou transforms its bridges into catalysts driving regional development

Known as the "Museum of world Bridges", Guizhou is making full use of its bridge resources, with scenery and the bridges complementing each other. The fusion of bridges and tourism is becoming a new driver of tourism growth in Guizhou.

Driving along the expanded six-lane Banqiao to Xinpu section of the Lanzhou-Haikou Expressway in Guizhou province, one could get a sense of time travel while passing through the many tunnels and bridges. Along this 37-kilometer stretch, there are 13 bridges and seven tunnels, which make up 65.8

percent of the section's total length. The Tuanze Service Area along the section is where the first expressway logistics park in southwest China locates. Goods can be directly distributed in the park without leaving the expressway system.

Song Meng, general manager of the service management company under Guizhou Ex-

pressway Investment Group, told People's Daily that building logistics parks in service areas gives play to expressways' advantages in location, traffic flow and transportation, and is thus beneficial for creating new business models and op-

"This is a proactive attempt for us to explore developing

road economy along the expressways and promoting economic growth across the expressway network," Song said.

The bridges have not only boosted logistics, but also spawned clusters of B&B hotels. Located halfway up a hill in Manzhai village, Baishui township, Guanling Buyei and Miao autonomous county, the internet-famous B&B hotel Jianglu · Yueshan is known for its views of the Baling River Bridge. Since this Spring Festival, the hotel has been fully booked every day.

The popularity of the hotel has further unleashed the tourism value of the Baling River Bridge, with many boutique high-end B&B hotels clustering in Manzhai village, which generate over 16 million yuan (\$2.22 million) annually. Guizhou has cleverly capital-

ized on its bridges to stimulate economic growth across multiple industries, including tourism, local specialty processing, and catering.

By building on its inherent assets and strategically expanding roads and bridges, Guizhou has transformed tourism appeal and logistics capabilities into catalysts that drive regional development.

## Simba SC ought to give Kennedy Juma more playing time

SIMBA SC's defensive woes in the 2023/24 NBC Premier League have prolonged, with solutions being found within the squad.

The outfit's technical bench should decide on how to use the first defensive pair Henock Inonga and Che Malone and how to rotate them.

In recent days, the absence of either

In recent days, the absence of either Malone or Inonga has seen Simba SC fail to either get good results or leak in goals because of 'schoolboy' defending, with a match against Tanzania Prisons being a prime example.

This may result from a lack of game time among some defenders in the central defensive area. I have a difficult time understanding why center-back Kennedy Juma is not getting many minutes in either the NBC Premier League or CAF Champions League.

The Msimbazi Street squad needs to give Juma more game time given the footballer is a senior defender who is still at his peak-.

Youthful central defender Hussein Kazi has more playing days- he still has a lot to learn, given he is still young.

When a soccer supporter traces Juma's senior national team call-ups done by coaches that have led Taifa Stars, the defender makes the finals squad cut but ends up on the bench.

Juma has played alongside Joash Onyango at Simba SC and he played at the top level at the back- with the former having the ability to either execute long balls or play cutting passes which break zones of the offensive teams.

The former Singida United captain has played alongside Inonga from last season to this season and he played a top-notch performance for the club but, in all seasons, he has been a fringe player at Simba SC.

In Tanzania's senior national soccer team, Juma has largely been sitting on the bench.

In Taifa Stars' recent games, he did not receive a call-up and it is easy to know why because he does not get enough playing time at Simba SC.

Simba SC's technical bench needs to understand that no player will become reliable if he largely sits on the bench.

In the world, all the best defenders play week in and week out, whereas Juma always plays in the absence of either Malone or Inonga.

The good aspect is, he always showcases a memorable performance once he plays with either Inonga or Malone.

If he plays with either of the two and he

If he plays with either of the two and he makes no mistakes, why should the club's technical bench not start him against a

native defender like Kazi in the central defense? In the NBC Premier League, Juma has neither cost Simba

SC a goal nor committed a mistake that led to a goal. He as well hardly done so with the senior national team, it is probably because he does not get enough playing time

in the squad but that is not the case.

For Simba SC to have healthy competition and defensive prowess, they have to make sure their defenders are all getting enough playing time and there should be a better

Such a plan will see to it the outfit keeps the competition level up in an area that has seen many woes in defensive transitions especially when defending counterattacks.

The 29-year-old Juma brings height to Simba SC's defense, efficiently dealing with long balls and set pieces the club has been struggling to deal with of late.

the club has been struggling to deal with of late.

He adds calmness from the back with his ball-playing ability and good decision-making from each pass he makes.

ability and good decision-making from each pass he makes. He has played both domestic and international games for clubs and country and he seems like a commanding leader from the back.

Wasting his talent on the bench is what costs Simba SC due to lacking straight options that are sharp once either Malone or Inonga is missing.

Some may wonder why Taifa Stars' coaches are calling him up in either a provisional or actual 25-man squad,

much as he is a fringe player at his outfit.

If he was not a good

defender he would not have been getting senior national team call-ups and, with Inonga facing fitness issues lately, Juma should play more games in the Congolese center-back's absence and should keep on playing when Inonga returns.

In his six years at Simba SC, if Juma was not a top defender the club would have released him a long time ago, sometimes it is all about having trust in a player. Simba SC seems to be lacking trust in Juma as the side's starter.

At Yanga, the squad's central defenders- Bakari Mwamnyeto, Ibrahim Hamad, and Dickson Jobalso feature for the senior national team.

Rotation lies between them, while Uganda Cranes defender Gift Fred fails to break into the Yanga starting team.

Simba SC fullbacks, Shomari Kapombe and Mohamed Hussein, are native players who have played for many years at the club, as it has had trust in them.

Unlike Yanga which boasts competent native central defenders, Simba SC's central defensive pair of Inonga and Malone has leaked in many goals.

The two sides' defenses are good in launching attacks and moving up forward, but Simba SC has allowed many goals from counterattacks.

Simba SC should have a ball-playing central defender- who has pace and is good at launching attacks- qualities that Juma possesses.

Juma moreover offers calmness in defense when the team is under pressure, he provides balance in central defensive play.

# Man City survive Liverpool 'tsunami' to leave title race on knife-edge

PEP Guardiola said Manchester City survived a second-half "tsunami" from Liverpool to secure a 1-1 draw that leaves three sides separated by just one point at the top of the Premier League.

Arsenal lead the way on goal difference from Liverpool with defending champions City just one point back in third.

Guardiola is still to win in front of a crowd at Anfield as City's only victory stretching back to 2003 remains in a behind closed doors clash in 2021.

However, the visitors were the happier to escape with a point after Liverpool laid siege to the City goal after Alexis Mac Allister's penalty cancelled out John Stones' first-half opener.

The final Premier League clash between Jurgen Klopp and Guardiola did not disappoint as Liverpool roared back in a breathless second half despite being depleted by injury.

Klopp's men could have regrets if they do not go on to break City's run of three consecutive titles, though, as they missed a plethora of chances to secure a crucial win and were controversially denied a second penalty deep into stoppage time.

"I think that is a game that defined what both clubs have been for many years," said Guardiola. "Sooner or later in this stadium it is like a tsunami!"

A share of the spoils leaves Arsenal as the winners of the weekend as eight consecutive league victories have taken the Gunners top, but they travel to City in their next league match on March 31.

But Klopp is confident his side will emerge infused with more belief they can deliver the title in his final season after leaving City hanging on after the break.

"Today I saw the best 53 minutes (second half) we had against Manchester City. It was exceptional how we played," said Klopp.

But should they remain in striking distance in early April, City will be confident of reeling in the leaders with a trip to Tottenham on paper the only tricky fixture in their final eight games.

#### Matampi, Gamondi scoop Premier League monthly awards for February

COASTAL Union Goalkeeper Ley Matampi has won the 2023/24 NBC Premier League Player of the Month award for February, with Young Africans SC boss Miguel Gamondi scooping the Coach of the Month prize.

Congolese international Matampi has been one of Coastal Union's most consistent players this season.

In February he picked three clean sheets as Coastal Union rode out 1-0 wins against Mtibwa Sugar and Dodoma Jiji as well as a goalless result on the road against Kinondoni Municipal Council FC.

The Coastal Union's leading goalkeeper now boasts the cleanest sheets of all goalkeepers across the NBC Premier League and is two ahead of the duo of Tabora United's John Noble and Constantine Deusdedith of Geita Gold FC in second.

The former TP Mazembe and DR Congo senior national team shot-stopper has kept nine clean sheets in 16 league appearances for his outfit, alias 'Wagosi wa Kayo'

He took the number one spot from Burundian international Justin Ndikumana who moved to Mtibwa Sugar during the December-January transfer window

Matampi beat Young Africans SC attacking midfielder Mudathir Yahya and Tanzania Prisons' striker Samson Mbangula to claim the gong and is the first Coastal Union player to win it this season.

Coach Miguel Gamondi has been named NBC Premier League Coach of the Month for the second time this season, after being awarded February's award.

The Young Africans SC boss once again came out on top of the voting after guiding his side to four wins from five during the month, collecting 13 points from matches.

The Argentine guided his outfit to victories over Dodoma Jiji FC, Mashujaa FC, Tanzania Prisons, and Kinondoni Municipal Council FC, as well as a goalless draw against Kagera Sugar.

That saw him edge out Simba SC's head coach Abdelhak Benchikha and Tanzania Prisons' head coach Ahmad Ally to see him add to his triumphs in August.

The Tanzania Premier League Awards Committee has also chosen the Azam Complex Stadium Manager, Amir Juma, to be the Best Stadium Manager for February, due to his exemplary performance of various ground management duties as well as issues related to the infrastructure in the stadium.

# Simba SC and Yanga set to know CAF CL quarterfinal opponents today

TANZANIA's envoys in the 2023/24 CAF Champions League, Simba SC, and Yanga, are set to discover their opponents for the showdown's quarterfinals with the draw slated to take place in Egypt today

The quarterfinals' first leg matches have been staged to take place from March 29-31 and the second leg clashes are set for April 5-7.

Simba SC and Yanga made history for the first time in the Tanzania football scene as both teams advanced to the last eight of the CAF Champions League.

The draw will be conducted in Cairo, Egypt starting with the CAF Confederation Cup at 14h00 Cairo time (12h00 GMT) and the CAF Champions League at 15h00 Cairo time (13h00 GMT).

The teams that will participate in the quarterfinals of the TotalEnergies CAF Champions League and TotalEnergies CAF Confederation Cup are known following the conclusion of the Group Stage earlier this

Simba SC advanced for the second time in a row and third time in the last four years- and five times in CAF inter-club competitions in a row- as they aim to advance to the semi-finals for the first time.

Yanga advanced to the final of the 2022/23 CAF Confederation Cup and ended as the showdown's runners-up after losing to Algeria's USMA Algers by an awaygoal rule.

The teams were locked to a 2-2 aggregate result after the two-leg final and USMA Algers won the title given the squad defeated Yanga 2-1 in the first leg that was held at Benjamin Mkapa Stadium in Dar es Salaam.

The second tier of continental club showdowns' rematch that was played at Stade Juliet in Algeria culminated in a 1-0 victory for Yanga.

This year, Simba SC will have to beat either Petro de Luanda, Mamelodi Sundowns, or Al Ahly if the Tanzanian club draws one of the trio in the CAF Champions League last-eight matches to advance into the semi-finals of the competition.

Al Ahly is the defending champion of the

competition while Mamelodi Sundowns won the maiden African Football League played this year after beating Al Ahly.

Petro de Luanda advanced to the premier continental showpiece's quarterfinals with six clean sheets from six Group Stage

Yanga will have an uphill task in its pursuit of progression to the semi-finals, as the club has to beat either ASEC Mimosas, Mamelodi Sundowns, or Petro de Luanda if the NBC Premier League defending champion draws any of the trio.
