



■PM forms probe team with disbelief spreads and uneasines raging

PRESIDENT Samia Suluhu Hassan yesterday directed a multi-agency team to thoroughly investigate what caused the fire that gutted the historic Kariakoo market on Saturday night.

A huge ball of fire could be seen at the centre of the city where the city's main trading facility, with observers at a loss to say if anything remained in the main market complex, apart from the older market on the other side of the compound.

Directorate of Presidential Communications said in a statement yesterday that i9n the wake of huge losses caused by the fire, President Samia has directed that defence and security organs and other agencies tasked to probe the matter conduct a thorough investigation and ascertain the cause of the inferno.

Kariakoo is the city's biggest market that drew traders from within and outside the TURN TO PAGE 2



Abiy in clear polls win as famine stalks Tigray zone

ADDIS ABABA

ETHIOPIAN Prime Minister Abiy Ahmed (pictured) has won the country's delayed elections with an overwhelming majority and is set to lead the country for another five years amid crisis in the northern Tigray region.

The election board said on Saturday that Abiy's Prosperity Party won 410 out of 436 seats, giving him another five-year term in office.

However, a fifth of the country failed to



carry out voting overall due to insecurity and logistical problems.

Polls were not held in the war-torn Tigray region, where hundreds of thousands face extensive famine.

Another round of elections has been penned for September 6 in the affected areas, but a date has not been confirmed for Tigray, following the delay of polls due to the pandemic, but rebel leaders in Tigray proceeded with their own polls and won the local mandate for the Tigray People's Liberation Front (TPLF).

Abiy, winner of the Nobel Peace Prize for his reforms and reaching peace with Eritrea, described the vote as a "historically inclusive election" in a statement on his twitter page.

A new government is expected to be formed in October. However, there are concerns about the election's integrity, with opposition parties complaining that a government crackdown against critics had disrupted their polls preparation

Similarly, President Mwinyi has instructed the Zanzibar Anti-Corruption and Economic Crimes Authority (ZAECA) and the police to probe suspected theft in the Zanzibar Electricity Co. (ZECO) at its various selling centres, with legal and disciplinary measures being instituted on all those found to be involved.

The directive was given when Dr Mwinyi addressed government officials when visiting Unguja Urban West Region, underlining that indications show that massive thefts of funds took place in electricity selling points. The two institutions need to probe the issue and steps seen to be taken, he emphasised.

He also directed the suspension of ZECO staff involved in uprooting power poles at Mwachealale area in Unguja West District-A, reminding the corporation that it has to take poles and transformers to areas that need to be the airport since I pass through it from

supplied with electricity.

To boost entrepreneurial outreach, President Mwinyi instructed that statebased investment funds be placed under one roof, including those catering for people with disabilities, the youth and women, so that their functions are properly managed.

Credit from these funds was being issued without proper safeguards, resulting in many beneficiaries failing to repay the loans, the Isles leader stated, tasking the Blue Economy ministry as well as Fisheries to empower entrepreneurs, but ensure improved financial accounting.

Apart from the huge number of traders, the market was a trading hub for various commodities demanded by people from various parts of East Africa, the president noted, underlining that its destruction was not only a loss to traders, but to the government and the country at large.

Prime Minister Kassim Majaliwa visited the site of the raging fire yesterday morning and unveiled a probe team to investigate how the building caught fire and if there was arson behind it.

Addressing reporters and shocked area residents and traders, the PM gave the team seven days to complete the investigation and give a report on what happened.

The team comprises of State House officials (President's Office -Regional Administration and Local Governments), the Directorate of Disaster Management in the Prime Minister's Office, the regional defence and security committee, the military, the police, the Fire and Rescue Force as well as the anti-graft agency.

The premier also named the Tanzania Building Agency (TBA), the Tanzania Electric Supply Co. (TANESCO), the Attorney General's Office and the Director of Public Prosecutions (DPP) to send officials as part of the probe

"If it is established that somebody was

involved in one way or another, appropriate measures will be taken immediately," he said, expressing skepticism as to why the market has been here for years and it catches fire today. "The probe must be thorough," he emphasised.

The Kariakoo market building was designed by local architect Beda Amuli, one of the first East Africans to set up architectural firms, with construction starting in 1972 and completed in 1974 but was launched in 1975.

Its tree-shaped roof and column allowed rainwater to be caught and captured in underground water tanks, while its large openings allowed air to flow through freely and keep the building cool in the hot weather of Dar es Salaam and the large numbers of people visiting or doing business there routinely.

Despite that the city is now dotted with well built market structures in the suburbs, it remained the main bargain centre, and thus was key to the city's small-scale economy as the source of most of its supplies.

Auxiliary traders found in city streets indistinguishably set up shop in the open area outside, in many ases also specializing in rare products sought for in the city and far beyond.

Early last month, President Samia made an impromptu visit to the marked and suspended top managers of the holding organization, the Kariakoo Markets Corporation following complaints over the congestion of merchandise and blocking of the main entries for much of the day. Traders also complained of high charges for rented space for stalls.

He has clamped down on corruption, released political prisoners, appointed more women to the cabinet and made peace with neighbouring Eritrea, following a 1998-2000 border war that left tens of thousands of people dead.

He won the 2019 Nobel Peace Prize, but just a year later, he launched the military operation against Tigray province to oust the TPLF as the party defied the federal authorities, seizing military bases in the region in a move that observers interpreted differently, either as bid to overthrow Abiy, intention of secession or forceful demand for a weaker federal structure.

The conflict in Tigray has killed thousands of people more from food insecurity than military operations, as many abandoned their towns and villages to seek shelter across the border in Sudan. Eritrea forces, traditional enemies of TPLF, carried out operations laced with brutality, external observers maintained.

On Saturday, for the first time in two weeks, the UN World Food Programme began moving aid into Tigray, following weeks of trading accusations on blocking muchneeded shipments.

The UN said on Friday that humanitarian operations were being constrained by the absence of essential services including fuel, telecommunications and electricity.

Kikwete to join Agra board food systems tour of Africa

FORMER President Jakaya Kikwete will embark on a tour of Uganda, Zambia and Mozambique to mobilise political leadership and private sector participation in promoting agribusiness as a strategy for ending food insecurity and increasing household incomes in the continent.

The former Prime Minister of Ethiopia and Board Chair of the Alliance for a Green Revolution in Africa (AGRA), Hailemariam Dessalegn, paid Kikwete, a courtesy call at the Jakaya Kikwete Foundation (JMKF) offices in Dar es Salaam on Friday evening.

In conversation with Kikwete, Dessalegn appealed for support to small and medium-sized enterprises (SMEs), which he said are important for the faster growth of the agricultural industry.

"SMEs processing agricultural commodities understand consumer needs better than anyone. For agricultural transformation, and to respond to the market in a bigger way, it is important to place them at the fore-front," said Kikwete, who is also one of the members of AGRA board, which is chaired by Dessalegn.

The meeting was also attended by Minister for Agriculture, Prof Adolf Mkenda and Minister for Industry and Trade, Prof Kitila Mkumbo.

Mkumbo shared his ministry's priorities, while recognizing AGRA's role in advocating for the removal of VAT on some post-harvest management technologies. AGRA provided an economic analysis study to inform the debate on rescinding the 18 percent tax on hermetic bags, making them more affordable to smallholder farmers. The AGRA study found that the removal of tax would increase demand for the bags by 150 percent, while raising the total net benefit to the society by US\$10.9 million per season.

'Kaaya's death has put Kilimanjaro convention centre project in limbo'

The untimely death of Elishilia Kaaya who until his demise last weekend has been the managing director of both the Arusha International Conference Centre and Dar-es-Salaam's Julius Nyerere Convention Centre, has left a number of his initiated major projects here hanging including the proposed giant convention and exhibition centre structure.

SADC launches online vulnerability atlas to store and share data on food, nutrition

Southern African Development Community (SADC) has launched a new online vulnerability atlas designed to store and share data relating to food, nutrition and livelihoods security from member states.

The online atlas developed by the SADC Regional Vulnerability Assessment and Analysis (RVAA) Programme aims to provide easy access to quality vulnerability assessments and analysis data inform evidence-based policymaking and programming.

The RVAA programme was developed the online atlas through technical support from the WFP and financial support from UK - Foreign, Commonwealth &

Development Office (FCDO) and the Swiss Agency for Development and Cooperation (SDC). "The high levels of vulnerabilities

that characterise the SADC region highlight the critical need for generating and providing decision makers with credible information to facilitate informed decisions to address emergency food and nutrition insecurity development planning" emphasized the Director, Food Agriculture and Natural Resources Domingos Zefanias Gove, officially launching the online vulnerability

Deputy Regional Director, WFP Southern Africa Region Office, Margaret Malu said: "the Online

Atlas comes at a critical time when umbers are likely to increase with there is increasing complexity and demand of food and nutrition responses. In essence, the Online Atlas will deal with the mounting food security challenges by providing credible and comparable trend data on food and nutrition security."

Malu also appealed for maintenance of Quality Assurance (QA) in all aspects of vulnerability assessments and analysis processes.

Andrew Odero, the Head of Vulnerability Assessment and Mapping (VAM)/RVAA Technical Support Team said: "The idea of an Online Atlas came out of the need to respond to the strategic need to consolidate the gains of the RVAA Programme and add-value by making food and nutrition security information generated by 16 Member States easily accessible to a wide range of users working to improve the well-being of people

in the SADC region." The SADC Synthesis Report on the State of Food and Nutrition Security and Vulnerability in Southern Africa (Dec 2020) projected a rise from 41million (2019/20) to 51.3 million food insecure people in both urban and rural areas at peak lean season.

Latest figures are expected to be published end of July following the just ended 2021 Annual Dissemination Forum. These

the extended impacts of COVID-19 that has worsened the situation insecurity information to inform that has been predominantly caused by climate shocks (drought, floods, storms), climate stressors (land degradation, pests and diseases) and economic shocks. To address vulnerability, it is

important for decision-makers to have access to credible information. This applies to both emergency response as well longer-term development planning. Quantifying the situation on

the ground and tracking changes in conditions is critical because without comparable data it is difficult to achieve efficiency, accountability and transparency.

Over the years the programme generated a wealth of data and information on food, nutrition, and livelihoods security from SADC Member States. However, that data was shared and stored using unreliable tools which could easily be corrupted or misplaced.

The online atlas runs from a server hosted at the SADC Secretariat in Gaborone, Botswana. It is freely accessible from any location in the world where there is internet connectivity.

Users can find data, analyse trends across space and time, compare food security behaviour between and amongst different countries in the region and generate maps.

TRC's record shows joint venture need for SGR run

operations of the new rapid train services is gearing up, with the government having allocated 11.3bn/- this financial year for procurement of 65 Standard Gauge Railway (SGR) wagons with rides and operations set for December. This is a big step in the proper realization of the project, affirmed in the second meeting of the new board of directors of the Tanzania Railways Corporation (TRC) at midweek. Works and Transport, minister Dr Leonard Chamuriho said that the target was to ensure that operations start once construction works are completed.

The shift from predominant steam and diesel engine trains to rapid electric train facility can be compared the change in recent years at the Muhimbili National Hispital where cases that used to be referred abroad are now being handled locally, especially at the Jakaya Kikwete Cardiac Institute (JKCI). MNH sent specialist doctors abroad for training, but they did not just come back to stard handling those operations on their own. A linkage programme was created where specialists from abroad worked with MNH specialists for several operations of a particular kind, until the imparting of skills was sharpened enough.

This model comes to mind because of the disturbing record of TRC in the past, as train collisions or railroad cars, one such accident happening around two years ago or a bit earlier when inspecting the Ruvu-Segera rail link. Senior officials of certain departments

EADINESS for starting at TRC perished, and way back in 1998 a train rolled back with engine failure and hit into an oncoming train, with more than 300 people killed on the spot.

> Some will say that was in the past but accidents have in no way been totally dissipated at the corporation, in which case there needs to be adequate safeguards in the SGR trial and operational start.

Strictly speaking there is a case for making an oversight arrangement with foreign experts a continuous situation, unless it can be explained why for 40 years TRC never speared capable of running trains with sufficient assurance. The huge calamities with ships also emerged in the same context, thus the transition to rapid train, with greater potential or error, looms large and errors will be more costly than in the past. TRC may have trained or are training personnel, but as they say, 'to be forewarned is to be forearmed.'

It will not be surprising if any effort to seek safeguards meets with resistance as often the wish to be fully independent and be proud of it is well underlined in the public service, and needs no reiteration. Yet it will be difficult to say that the past TRC record and even within the past few years augurs well for total trust in rapidly trained personnel to handle rapid trains, as they would be beginners where they have taken their courses, but when they come back they are given full charge of operating speed trains. Evidently they will be qualified but not experienced on the job, while past experience on a diesel train is

Noise pollution issue must take note of group needs

crackdown

has been announced, focused entertainment joints but with an eagle eye on churches in residential neighbourhoods. This affirmation has kbeen made by the National Environment Management Council which said on Friday that beginning Saturday it would embark on a crackdown on noise pollution, underlining that it is increasingly becoming a menace in major cities and towns. That assertion may be right or false depending on where one stays or sees as dangerous noise levels, for once.

NEC Director General Dr Samwel Gwamaka told reporters that the onslaught targets entertainment joints such as bars, night clubs and function halls as well as places of worship located within residential areas. Accompanied by police officers, NEC officials will go to suburbs notorious for deafening noise on the basis of complaints received by NEMC. There is something disturbing about this explanation, as bars are restricted in playing loud music at midnight on weekends, but NEMC is creating an artificial total ban.

What is not in doubt is that NEMC is proceeding with precisely what business groups have been asking President Samia Suluhu Hassan to change in relation to executive agencies, that they shouldn't be doing business themselves. NEMC is supposed to be a consulting body on such issues, in which case it is local authorities which look at noise levels generally, and if it is past midnight, or 11pm on weekdays, then police patrols might raise questions, for instance a neighbour or cell leader phones to complain. There is virtually no room for NEMC enforcing noise pollution standards on the streets but for pecuniary

State organizations, once there is something that is of interest to them,

seek to bend executive directives as much as is possible. For several years if not the whole decade the traffic police were openly declaring to be raising revenue by slapping fines, until President Samia publicly decried this habit. The Prevention and Combating of Corruption Bureau (PCCB) eventually admitted that it framed hundreds of cases, and NEMC restricted harvesting of sand at Jangwani Valley and now the bridge is close to be submerged by seasonal water; it listens to residents of nearby raised ground saying harvesting sand puts houses

In addition, there are tussles of a commercial sort between different religious groups or denominational loyalties, where new churches acclaimed for miracle healing 'poach' thousands of worshippers from traditional domains, to their chagrin. It is entirely possible such interest groups seek to use this regulatory agency to prune activities of such groups, ostensibly on account noise while actually seeking to clip their wings. So NEMC shouldn't exercise foreign standards in relation to what is described as noise pollution, as on that score it would have to close virtually all garages in the city, welding workshops, factories, etc.

For one thing, noise by a single individual upon others, especially well past midnight, may not be tolerated, but justifiable noise of a community sort is likely to blend with culture, and thus with liberty in general,, as collective freedoms are essential to liberty.

So noise in bars and prayer halls should be left to local authorities, to consult with those conducting activities, and if need be, there are police patrols too. Extraordinary initiatives like a NEMC swoop smack of other prerogatives, not the civic harmony we desire, and which the president has repeatedly



Time with Attilio Tagalile: A journalist whose revolutionary work protested Africa's oppression, exploitation and racism

ECENTLY, a legendary Tanzanian footballer, Leodgar Tenga, desired we should develop and sustain a celebrated and progressive culture of honouring hard earned achievements of others.

What a wise and positive comment from a legend. And, these are the building blocks of, not only a civilized society but also a developed one. It is a pull strategy for awakening a sleeping giant. Our youths crave for role models.

All successful societies encourage development by recognizing the achievements of their distinguished performers.

If was a norm, therefore, the late Atilio Tagalile (71) who was called by his maker on 9 July, 2021, would have never gone timidly as he seems.

One can cry a bucket for Africans to adopt a new culture that would default us pant for celebrating and preserving our own heritage, obviously for successful succession.

Our youngsters could not wallow through the air for inspiration. We need clear heroes across fields. ATILIO was role model to many in the media fraternity.

There would be countless heroes to look up to, for the motivation to traverse over life billows through a pinnacle of success.

Most of our new generation turn to our past oppressors for heroes. This may not be a welcome news.

He booked an appointment to meet me through a Doctor in the making, Leah Mwainyekule, one of my former students at Tanzania School of Journalism, currently writing her doctoral research.

ATILIO and I were not met before that day, though I knew him. He was a popular fellow in the media. He wanted to appreciate the effort God manifested in me, the attempt to put up a book. He encouraged me to write another one. This blessed me. He quickly signed a copy of his

book and handed it down to the palms of my hands. Here is a selfless man. A very fine

soul who recognized effort, albeit at infancy, he motivated me to take another step and push the book writing barriers.

I am crying for such a patriot, a pan africanist, activist, a revolutionary and a unifying soul which now departs at such a critical moment Africa crosses the turbulent times in the history of continental political independence.

With unique writing skills, Brother ATTILIO showcased an exceptional command of English language.

He was not only a prolific writer and a thinker but also a talented story teller.

In 1984, he was among a team of 21 Tanzanians who formed a UN

observers mission in South Africa's first democratic election, in which Nelson Mandela on ANC ticket, won a landslide vote, to become the country's first post Apartheid black

It was hidden to me that on 23 December, 2020, our God was preparing me to honor him with obituary for the heroic deeds he moulded by his hands to inspire Africans never to give up the struggle.

The giant, though unsung, is no more. His soul is distinct from the host. He knows not what is goes on. He is silent. Adam of Eden and his wife Eve regretted seeing the first death of their son Abel.

ambo, greetings for the coming week, and how much mail do you readers expect to receive during itif at all?

Pn not referring to electronic e.mails etc, but the real thing....paper mail in envelops, or postcards with exotic stamps, which in England, is delivered to your house by a postal worker....how's that for service!

Anyway, I don't possess one of those irritating items called a 'smart phone', but just an old un-smart version, which is left behind when I leave for Britain.

Once there, I have the perfect communication known as a 'land line', and on it, can make and receive phone calls, but only if I'm at home, and why would I want to make calls outside....I have freedom inside!

Strangely, I never thought that clever Tanzanians would allow themselves to be enslaved by this aspect of the white mans magic.... yet the majority have whole heartedly done so....along with the accompanying 'god'...the mobile phone...this can totally take over their lives....allowing them to be as suitably re-colonized as the colonizers themselves....but what's next?

Sometimes on going to Britain, (yes-minus the mobile) I take a few local newspaper stories about life here, to show some of the fortunate 'wazungu' what real hardship is.

Though over the years, admittedly with some success, the donor community and the government have raised the GDP (gross domestic product) an indicator of the national income, and though the gap between the haves and the have nots seems slow to reconcile, the sign

What doesn't seem to change as I come and go, is the poverty reduction industry, but it's ironic that over the years, a lot of funding has gone into this, which like corruption, can appear to increase in direct proportion to the strategies designed to retard it.

Rwandan leader Paul Kagame was reputedly the first African President to describe aid as an indignity and many agree with him.

Family planning saves lives: We need to spread the message to men and women

year ago, I met a 26-yearold breastfeeding mother who was a graduate student. She was married with three children; the youngest was just eight months old. She started using oral contraceptives after the return of her menses following the birth, but she hid the pills from her husband. When he discovered them, he forced her to throw them away.

Not long after that, she conceived again. Three months later, she had a miscarriage caused by stress. She was admitted into hospital with infection and blood loss. Thankfully, she survived, and her husband has since changed his attitude towards contraceptive use.

In my work in rural areas of Nigeria, attending mostly to uneducated women, their inability to make their own decisions on contraceptive use, combined with lack of awareness of what contraceptive methods are available, are prominent factors that affect contraceptive uptake. About 80 percent of the women we see do not use modern contraceptives because of lack of knowledge, or because their spouses are against it.

However, it is cheering to note that when I talk with couples about the importance of contraception to a woman's health and her family's welfare, I see a marked change in attitude. From my conversations with others working in reproductive health



services, it seems that they have also had success when they talk to couples.

It is already a government policy to increase the use of modern contraceptives in Nigeria. The official goal, first set in 2012 and revised in 2017, was to reach a modern contraceptive prevalence rate of 27 percent by the year 2020. Unfortunately, the level of contraceptive use reached in 2020 was only 12 percent, one of the lowest rates in the world.

A key reason for the low level of contraceptive use is lack of government leadership. Despite making promises to fund modern contraception, the government actually cut funds for family planning by 80 percent in its 2019 budget, with further cuts in 2020. In effect, the government is leaving international

While NGOs do an admirable job, none has the capacity to run a sustained national awareness campaign, or to change deeply ingrained social attitudes affecting contraceptive uptake. This is the work of government, which needs to invest in family planning education, including in schools, and ensure modern contraceptives are widely available at little or no cost.

The government also needs to tackle stigma. Here in Nigeria, we need to stop being embarrassed about contraception or treating it as a secret. We can learn from the success of immunisation campaigns against childhood diseases, for example, which have used massive awareness campaigns and health workers going house to house to carryout vaccinations.

Today, it is quite normal to vaccinate children when it was previously viewed with suspicion. The government should apply the same strategy to family planning, using health workers to educate couples and deliver contraceptive services at home. They would have an opportunity to speak to couples together, and importantly include men in the conversation.

By speaking with couples normally about contraception, we in the health sector can show that there is nothing to be embarrassed or ashamed about, reassure both women and men that the products are safe, and address any misconceptions and answer questions. The problem now is that the system non-governmental organisations (NGOs) encourages secrecy and misinformation, to pay for most of the contraception making it even harder for women to and family planning services in Nigeria. control their fertility, and often putting

their health and welfare at risk.

The cost of this problem to the country is significant. The health and social impacts that I see frequently include unplanned pregnancies, unsafe abortion, maternal deaths, perpetuation of poverty, malnutrition, frequent hospital visits and children dropping out of school.

If all the unmet needs of modern contraception were satisfied, it is estimated that unintended pregnancies in Nigeria would drop by 77 percent - from 2.5 million to555,000 per year - and the number of abortions would drop from 1.3 million to 287,000. Full provision of modern contraception, combined with other medical care, would reduce maternal deaths by 68 percent (61,000 to 19,000 per year) and newborn deaths would drop by 85 percent (from 255,000 to 38,000 per year).

We know that our rapidly growing population is one of the country's biggest economic and political challenges. Latest official data puts Nigeria's Gross Domestic Product (GDP) and population growth at 2.2 percent and 2.6 percent, respectively. We are poised to be the third most populous country in the world by 2050, ahead of the United States. Finding jobs for all these people is already extremely difficult. Protecting our environment in the face of massive population growth is another challenge. Contraceptives have always been a vital tool for countries to build viable societies,

and when given the option, most families make responsible decisions, ensuring that they can provide for the children they have.

I want to emphasise that this is not just a problem facing poor people in rural areas. The woman I described at the beginning of this article is well-educated, living a comfortable middle-class life. Yet the taboos around family planning affected her just as much as the rural women I also treat on a regular basis.

This is a problem impacting every part of the Nigerian society. Therefore, I call on government at all levels to prioritise family planning. It will be necessary to increase spending, employ more health workers, carry out awareness raising campaigns, and take contraceptive services to homes, as they do for immunisation. Perhaps they can combine these roles - training vaccination teams to also deliver contraception.

As a man, a father, and a husband, as well as a doctor, I also call on all men to educate themselves about these issues and consider their wives and children's well-being above all. The benefits of change will flow not only to women, but to the whole country, by enabling families to prosper, reducing poverty, protecting our environment, and building a more sustainable future.

Amidst COVID -19, health facility quality ratings give a false sense of security

Health facilities across South Africa are regularly assessed and rated on their quality and ability to meet patient needs. Currently, the way these assessments are performed means that despite an excellent rating, things may not be what they seem.

As South Africa faces a severe third wave of COVID-19, communities deserve a standard of care that can stand up to scrutiny every day and during a devastating pandemic, it is even more urgent to ensure transparency and accountability in our quality assessment processes. Imagine this scenario:

Leilah - a suspected COVID-19 case - enters her local health facility with breathing difficulties. She needs an oxygen mask, which had been confirmed as available in the facility just hours before she arrived. Leilah's condition quickly deteriorates, and she passes away because there was no mask. Upon investigation, several compliance issues emerged that had not been apparent on the day

of the assessment. The facility was checked, and the masks were there but only because they were borrowed from a neighbouring clinic in an attempt to pass the inspection. The masks were returned swiftly afterwards. Shortcuts and false compliance

South Africa's Department of Health has two quality assurance programmes which both assess the compliance of health facilities to the minimum health standards.

Currently, the national Department of Health benchmarks quality of care through assessments conducted by "peers", which include a group of nurses within the local area. These groups move from site to site, assessing each other with a standard checklist and provide a score that rates the quality at the site. These assessments form part of the Ideal Clinic Realisation and Maintenance programme, also referred to as the Ideal Clinic programme.

These assessments differ from the assessments conducted by the Office of Health Standards Compliance (OHSC), which uses



trained inspectors in a legislated assurance programme quality based on the National Core Standards (NCS). The Ideal Clinic programme was implemented after the roll-out of NCS to create a more sustainable, hands-on programme that would allow health staff to engage with quality assurance activities on a more frequent basis. The OHSC remains in place to provide oversight but the two assessments are not currently being monitored or reported on in one combined document and sites are receiving accolades on the peerassessed programme as opposed to the legislative programme.

In my experience working in public health quality assurance across government, municipal and NGO spaces, I design and conduct assessments and can see first-hand the shortcuts taken to gain good ratings, and the strategies used to avoid true compliance. The current system of health facility assessments is seen as a tick box exercise or a short-term hurdle to overcome to please management or

False compliance continues to lead to gaps in care and even when health facilities receive high ratings, the experience of patients does not bear this out. The cost of failing to

address this is high. Assessments lack objectivity

A critical study from the University of KwaZulu-Natal published in the journal Curationis found that among the many challenges facing the healthcare system in South Africa, the lack of objectivity in health facility assessments is one reason millions still experience preventable harm every day due to poor health services.

Even with these dubious attempts at increasing scores, only a third of provinces meet the scores necessary to qualify for support. In 2018, 47% of sites accessed by the Office of Health Standards Compliance were deemed compliant. In the 2018/19 financial year, the Office of Health Standards Compliance released an annual inspection report in which it stated that only 137 out of the 730 (18,7%) health facilities assessed in South Africa were compliant. Interestingly, the same listed health facilities that were not compliant with the National Core Standards have received awards in their Ideal Clinic assessments.

A comparison of the various

assessment outcomes is not reviewed by the OHSC or the Department of Health and the question remains how one site could be both compliant and not compliant in the same period. Over the 3-year period (2019 - 2021), the government has allocated R19.2 billion to improve facilities and an additional R4.3 billion via the National Health Insurance Fund, but these funds remain largely untouched and may even create further perverse incentive manipulating assessment outcomes.

We must ensure that quality services and lifesaving facilities are available to communities and that compliance assessments are done with integrity and without bias. That means ensuring more accountability in peer and selfassessments, by including external verification and transparent communication of findings to communities. These external assessments from unrelated entities ensure the findings are correct and provide training to peer assessors to ensure consistency.

Rwanda deploys 1,000 soldiers to Mozambique's Cabo Delgado

WANDA has started deploying 1,000-strong forces to Mozambique to help it combat worsening violence in the gas-rich northern Cabo Delgado province.

The announcement came on Friday after the 16-member Southern African Development Community (SADC) approved last month the deployment of joint forces to help Mozambique respond to the nearly four-year-old conflict, which has killed some 3,000 people and displaced almost 800,000, half of whom are children.

member of SADC, would fight alongside Mozambique's forces and SADC troops, the Rwandan government said in a statement.

"The Rwandan contingent will support efforts to restore Mozambican state authority by conducting combat and security operations, as well as stabilisation and securitysector reform," it added.

Rwandan defence forces spokesman Ronald Rwivanga told Reuters news agency the new forces would have deployed in full by Saturday.

He said the Rwandan contingent was made up of members of the police force and Soldiers from Rwanda, which is not a troops trained "to deal with terrorism and

security-related issues" in Cabo Delgado.

Alexandre Raymakers, Africa analyst at the United Kingdom-based global risk consultancy Verisk Maplecroft, said he believes the Rwandan contingent could be used to secure key liquefied natural gas (LNG) sites in an effort to lure back international inves-

"The Rwandan security forces have developed a reputation for being a highly capable fighting force," he said.

But, he added, "The presence of multiple military missions, in the form of a potential Rwandan contingent and the SADC, will likely lead to conflicting priorities and fric-

tion at the military command level, hindering the overall." Attacks by an armed group known locally as al-Shabab, whose origins, analysts say, are steeped in local political, religious and economic discontent, have steadily increased in the Cabo Delgado province since October 2017. The sophistication of the attacks has increased, too.

The fighters linked to ISIL (ISIS) have ransacked towns and gained control of key roadways, destroying infrastructure and beheading civilians. In some cases, they have forced locals into their ranks or held them as sex slaves.

Since August 2020, the fighters have been

in control of the key port town of Mocimboa da Praia, while in March, they launched a coordinated assault on Palma town, killing dozens and displacing tens of thousands, while also forcing the French energy firm Total to suspend its \$20bn LNG project.

The government has deployed thousands of soldiers to Cabo Delgado to combat the fighters, but analysts have long cautioned that Mozambique's army has historically been weak, poorly trained and underequipped.

The World Food Programme has warned of a growing hunger crisis as nearly one million people need food aid.

Measles vaccines missed because of Covid focus

MANY children are missing out on measles vaccines because of disruption caused by the coronavirus pandemic, fears are growing that there could be an outbreak of the disease in the Democratic Republic of Congo.

"In the last two to three months we've not been able to carry out routine measles vaccinations, which is worrying," says Eugénie Ngabo Nzigire, a nurse based in the eastern city of Bukavu.

"It takes just one sick child and the whole community is in danger," adds the 57-year-old head of the maternity unit at Skyborne Hospital.

The World Health Organization (WHO) has warned that with an estimated 140 million measles vaccinations around the world having been missed due to Covid-19 disruption, countries with fragile healthcare systems, such as DR Congo, could be sitting on a 'time bomb' of potential outbreaks.

DR Congo reported 440,000 cases in its last measles outbreak, which ended in September.

Nearly 8,000 people - mainly children died from measles between 2018 and 2020 in the country, according to monitoring data from the WHO.

Measles is the most infectious preventable disease in the world, much more contagious than Covid-19. It is spread through contact and droplets that can remain in the air for hours.

Still a common killer, there are outbreaks currently in Pakistan and Yemen as well as concerns that there could be one in the Tigray region of Ethiopia.

"A child can get measles and die wherever they are in the world, but the likelihood of death is much higher for children younger than one and if there are other stresses like malnutrition or vitamin A deficiency, these really increase the risk of death," said Dr Natasha Crowcroft, senior technical advisor for measles and rubella at the WHO.

Bukavu is a bustling commercial centre and home to around a million people. It is also where Ngabo Nzigire has dedicated more than three decades of her life to treating children.

"I knew I wanted to be a nurse at a very young age, so it's not just a job that I fell into but a vocation to care for people," says the mother of 11.

Human-wildlife conflict one of greatest threats to wildlife species - reveals new report

A new report by the World Wildlife Fund (WWF) and the United **Nations** Environment Programme (UNEP) has cited the human-wildlife conflicts as one of the greatest threats to wildlife

species. Conflict between people and animals, from China's famed wandering elephants raiding farms for food and water; to wolves preying on cattle in Idaho, USA; to a crocodile killing hundreds of people in Burundi, is one of the main threats to the long-term survival of some of the world's most emblematic species, warns a new report.

It said human-wildlife conflict - when struggles arise from people and animals coming into contact - often leads to people killing animals in self-defence, or as pre-emptive or retaliatory killings, which can drive species to extinction.

The report, a future for all - the need for humanwildlife coexistence, highlights that globally, conflict-related killing affects more than 75% of the world's wild cat species, as well as many other terrestrial and marine carnivore species such as polar bears and Mediterranean monk seals, and large herbivores such as elephants.

"Within a human lifetime, we have already seen extraordinary and unparalleled changes to our planet. Global wildlife populations have fallen an average of 68 per cent since 1970," said Margaret Kinnaird, Global Wildlife Practice Leader at WWF International.

added: Kinnaird "Human-wildlife conflict, combination with other threats, has driven significant decline of species that were once abundant, and species that are naturally less abundant have been pushed to the brink of extinction. Unless urgent action is taken, this devastating trend will only worsen, wreaking detrimental and, in some cases, irreversible impacts on ecosystems and biodiversity."

human-wildlife "If conflict is not adequately addressed by international community, WWF believes it will have a considerable negative impact on countries' ability to meet the majority of the SDGs," said Dr Kinnaird.

The report featured contributions from 155 experts from 40 organisations based in 27 countries.

Susan Gardner, Director of UNEP's Ecosystems Division said: "This report is a clarion call to elevate

wildlife conflict and give it the attention it deserves in national and international processes.'

"It is a call for the adoption of approaches that identify and address the deeper, underlying causes of conflict while developing systemic solutions with affected communities as active and equal participants in the process. As demonstrated in many of the case studies in this report, coexistence is both possible and

attainable," she said. According to the report, human-wildlife conflict is as much a development and humanitarian issue as it is a conservation concern, affecting the income of farmers, herders, artisanal fishers, and Indigenous peoples, particularly those living in poverty.

It also interferes with access to water for communities competing with wildlife for local water sources and drives inequality as those who pay the price for living with wildlife rarely receive the benefits of coexistence.

Despite being so strongly linked to the Sustainable Development Goals (SDGs), human-wildlife conflict continues to be overlooked by policymak-

The report shows that completely eradicating

the problem of human human-wildlife conflict is not possible but that well-planned, integrated approaches to managing it can reduce conflicts and lead to a form of coexistence between people and animals. Such approaches require work on prevention, mitigation, response, research and monitoring all backed by strong policy support and the participation of local communities.

> In South Africa at the Kavango Zambezi Trans-Conservation frontier Area an integrated approach to managing human-wildlife conflicts has led to a 95 percent reduction in livestock killings, resulting in zero retaliatory killings of lions in 2016 (at least 17 were killed in 2012 and 2013) and allowing previously threatened lion populations to recover.

> Reducing human-wildlife conflict in this way can lead to opportunities and benefits not only for biodiversity and impacted communities, but for society, sustainable development, production, and the global economy at large.

The post-2020 global biodiversity framework is expected to be adopted in October at the Fifteenth meeting of the Conference of the Parties (COP15), where world leaders will sign a new 10year commitment to protect biodiversity.

Conflating the Zuma judgment with politics, illegality and unconstitutionality is a dangerous shot in the dark

am not a prophet of doom, but signs are that those who hold the firm view that the judiciary is politically biased against Jacob Zuma seem prepared to throw out of the window any respect for the judiciary left in their fibre. And there is no unequivocal assurance from the ANC as the governing party that things will not deteriorate further.

The initial optimism about the South African Constitution as one of the most exemplary and best in the world concerning the protection of rights and freedoms, and the Constitutional Court as the ultimate enforcer of the rule of law and the interpretation and protection of our rights and freedoms, seem to be fading with time.

The Constitutional Court judgment, in the case of Secretary of the Judicial Commission of Inquiry into Allegations of State Capture, Corruption and Fraud in the Public Sector including Organs of State v Zuma and Others [2021] ZACC 18 sought to remind us that courts are established as the last line of defence for the South African constitutional order and the rule of law and to help the country ward off the threat from new authoritar-

Justice Leona Theron, in her dissenting judgment with the judgment of the majority penned by the then acting Chief Justice Sisi Khampepe, referred to it as bad and unconstitutional because the judgment "has pushed the bounds of our law of contempt in order to meet these exceptional circumstances" [at par:191]. The unequivocal message by the majority judgment that the Constitution is sacrosanct and that the rule of law must be respected has not gone down well, obviously, with

As a disclaimer, it must be noted that I do not take a position here on the correct outcome in the Zuma case. I do, however, hold a view that the majority judgment was convincingly well reasoned in light of the facts of the case compared with the minority judgment, though I have described the dissenting decision as the perfect gift for spin doctors. So important to the Zuma defence is the Theron dissenting judgment that even his



supporters, sympathisers as a country after the Conand ordinary citizens refer to it as they gather at Nkandla in a show of unwavering support, some pledging even to die for the former president before he can be arrested if their disregard of the Covid-19 pandemic threat has not killed them by then.

One cannot ignore the possibility of another Marikana moment considering that some of the protesters at Nkandla brandished firearms and knobkerries. Or ing for the Constitutional are we facing the possibility of a coup against the withdraw its judgment current ANC government should law enforcement agencies align themselves to the MKMVA position? Nobody wishes any of such happening because we will all be losers.

We are entering another week of uncertainty and being on tenterhooks

stitutional Court agreed to hear Zuma's application for a rescission of its contempt judgment and sentencing against him in terms of Rule 42 of the Uniform Rules of the Court. secure rescission.

A careful reading of the affidavit by Zuma indicates that he is appealing to humanity in the form of its "judicial being" and to the intelligence of the

court, and also making a case that the majority judgment by Khampepe made a serious error on merits and in the process betrayed the Constitution and the Constitutional Court itself as an institu-

Further, that the Constitutional Court is dangerously overreaching under the guise of protecting constitutional values Zuma, in essence, aligned himself to the minority judgment of Theron, and considers the majority judgment of Khampepe unconstitutional, irrational and pronounced by a court that lacked independence and impartiality. There is some kind of chastising language in Zuma's affidavit, and although a bit toned down compared with his previous statements, public speeches and defiance of the Constitutional Court, is not surprising.

Notable contentions by Zuma, without in-depth discussion in this opinion, include: admitting in the alternative that he is guilty of the offence of contempt of court and that he needs to take advantage of the opportunity previously given to him by the court – which he scorned – to argue in mitigation of sentence [par.11]; and reminding the court that he is aware of the passionate disdain it holds against him for defying its

orders [par:11].

More interesting is Zuma's note that his freedom and "health challenges facing the country should all combine" in favour of the Constitutional Court hearing the application [par:14]. Reference to the country's health challenges is curious, unless the statement was meant to mean health challenges facing Zuma as further in paragraph 16 of the affidavit he notes that incarceration threatens his health. Perhaps this is a sneak preview into the possibility of Zuma applying for medical parole or release from prison fearing that Covid-19 and overcrowding in prison pose serious health risks to him.

To this end, Zuma will be taking full advantage of what is permissible in terms of the Correctional Services Act should he not be paroled after serving a quarter of his sentence or get mercy from President Cyril Ramaphosa by authorising presidential parole or correctional supervision under section 82 of the Act.

Zuma makes it clear that his health will be key to his sentence mitigation statement. In his affidavit, he alerted the court that he suffers from ill health that will require him to be in and out of hospital to receive the appropriate medical attention. [Par:18] It is interesting that as an

icon of the freedom Struggle and a role player in the liberation of the country towards constitutional democracy steeped in the rule of law, Zuma declared that he is not proud of being the first prisoner of the Constitutional Court in post-apartheid South Africa [par:19]. Perhaps if he was given substantively proper counsel and defence he could have dragged himself to the Zondo Commission and the Constitutional Court. despite his disdain of the two.

Or perhaps this is just a belated change of heart about his respect for the

administration of justice. So far one does not know what to believe in now. Zuma swears that he never vowed not to attend the commission, and instead levelled a serious allegation that the commission acted in bad faith in issuing summons when kept in notice of his inability to attend the commission

[par:21]. The politicisation and out-of-context nence given to the dissenting judgment by Theron has the potential and threat of transforming justice into a spectacle, and individualisation of justice. Come on South Africa! The rhetorical trick of conflating the majority judgment with politics, illegality and unconstitutionality is a dangerous shot in the dark.

It must be emphasised that there is nothing unusual about the sharp disagreements between the majority and the minority judgments in this case. Judges do not always agree and this should not be strange. Like lawyers and judges would say, what would be strange would be if judges agree on everything, for the law is not, like mathematics, an exact science - it is at best an analysis, a person's opinion, a judgment.

Of course, one must acknowledge that we may have reached an impasse in the Zuma matter; and that expecting the Constitutional Court to jettison last week's judgment because of the adverse reception of the judgment, without anything new to indicate that indeed the court was wrong, will further plunge the country into anarchy.

Constitutional The Court was essentially doing its job of protecting the rule of law like it did when it asserted its judicial oversight against Parliament in several of its cases. This has not prevented some experts, including legal experts in the form of academics and lawyers, to have taken opportunities to write commentaries to fuel and incite defiance of the judgment, planting fears that there is a third hand controlling the South African judiciary.

I am not a prophet of doom, but signs are that those who hold the firm view that the judiciary is politically biased against Zuma seem prepared to throw out of the window any respect for the judiciary left in their fibre. It has been a long and winding road to this cul de sac between Zuma and the courts, and there is no strong, unequivocal assurance from the ANC as the governing party that things will not deteriorate further.

It is unclear if the Constitutional Court agreeing to hear Zuma's rescission application will be met with an acknowledgement of its authority, of respect for whatever its decision will be. So far, acting Chief Justice Raymond Zondo has been singled out by Niehaus as having gone out of his way to target Zuma.

"We see here that Mr Zondo is going out of his way to try and get the harshest sentence, to target him again. Those actions just confirm to us once again that he's biased against president Zuma and that Zuma will not be able to get a fair hearing as long as it is chaired by Zondo," said Niehaus. He also fired a warning shot that imprisonment of Zuma "will be entirely unacceptable to us" and that the arrest "will inevitably lead to upheaval and instability in South Africa and cause further divisions within the ANC".

The possibility of an argument after the hearing and judgment that the judges who concurred with Khampepe in the majority judgment are a poisoned chalice and should not have sat on the bench or been allowed to pen the ruling should not be discounted.



MultiChoice refutes claims as it looks to avoid Nigeria crisis

ABUJA

MultiChoice is scrambling to avoid a potential financial crisis as a result of a directive issued by Nigeria's Federal Inland Revenue Service (FIRS) to banks to freeze accounts of the pay television operation pending the collection of outstanding fiscal payments.

On Thursday 8 July FIRS claimed that MuliChoice Nigeria had defaulted on tax payments to the amount of 1.8-trillion Naira (over US\$4-billion). The company is also accused of providing incorrect information to FIRS related to its income and subscriber numbers.

In a statement the Authority said companies operated by MultiChoice in Nigeria (DStv) "would not promptly respond to correspondences, they lacked data integrity and are not transparent as they continually deny FIRS access" to

under-remittance of taxes which necessitated a critical review of the tax-compliance level of the company," further reads the statement from the revenue authority. This means that MultiChoice Nigeria will not be able to access or

make payments from some of its key bank accounts within the country.

The company said that it is engaging the tax authority and has insisted it is up to date with its tax payments. "We have been- and are currently in discussion with FIRS regarding their concerns and believe that we will be able to resolve the matter amicably," read a statement issued by MultiChoice Nigeria.

It also claimed that it had not yet been notified of the position taken by the FIRS. Nigeria is a key market for Multi-Choice owing to Africa's biggest economy's booming population and growing middle class.

In November last year, MultiChoice said it had a subscriber base of 11.4m households (57%) "in the Rest of Africa" segment, which includes Nigeria, although it did not reveal the numbers for the West African country.

KCB Bank youth entrepreneurship graduates set to get 5m/- soft loans

RADUATES of a KCB Bank Tanzania Limited's six months '2jiajiri youth entrepreneurship training program' will get 5m/-in soft loan to develop their businesses if they come up with a bankable project.

Speaking at the closure of a threeday orientation course for the 118 young entrepreneurs, KCB Head of Marketing and Corporate Affairs, Christina Manyenye said only those who will write bankable business plans will qualify for the seed capital from the lender's entrepreneurship empowerment

"We have invited them to submit their business proposals and those with well presented ones are likely to be issued with a loan of 5mn/- and above depending on their demand," Manyenye said.

The KCB programme has so far involved

300 young graduates from Arusha, Dar es Salaam, Kilimanjaro, Morogoro, Mwanza and Zanzibar will also provide mentorship to the entrepreneurs. "The next step from here is linking them to processing and manufacturing industries for a period of six months to gain more practical skills," she said.

Far from the financial assistance to grow their small businesses, Manyenye said that the young entrepreneurs will be provided with three experts in the areas of marketing, law and accounts from KCB who will play a role of counselling them on good approaches of running their businesses.

"We are looking forward to starting to equip youth with required skills for the construction industry, innovation, arts and business. We generally aim at equipping about 4,000 young graduates in these areas so that they acquire required skills that will make them competent for self employment and competitive in the market," she added.

Peter Sona, one of the beneficiaries who is from information and communication technology field said that the knowledge and skills acquired opens up a new avenue for them because theories from university and college is not enough to make them competent.

"Majority of the youth graduate with little practical skills of their profession hence programs such as '2jiajiri' play a vital tool to equip us with such skills," said Sona who also commended KCB Bank's management for coming up with such as initiative. According to him, all graduates had already opened savings and business accounts at KCB that will not only enable them save their business income but also to qualify for loans the lender.

Banks, which have traditionally paid the largest bonuses on rising profits in the past, led in trimming the cash

period. Four firms - KCB, NCBA, Britam and Liberty Holdings – suspended bonus payouts to their executives while six (Absa, StanChart, Bamburi, BOC Kenya, Longhorn and Unga Group) reduced the cash incentives.

KCB's chief executive, Joshua Oigara, missed out on bonus payment unlike in the previous year when he took home Sh193.7 million – Sh145.3 million in cash and Sh48.4 million deferred. The bank's chief financial officer, Lawrence Kimathi, also did not earn any bonus unlike in 2019 when he received Sh29.4 million and Sh9.8 million in cash and deferred respectively. The missed bonuses came as the lender's net profit fell 22 percent to Sh19.6 billion in the year ended December on the back of increased provisions for coronavirus-related loan defaults.

Nigerian lawmakers pass historic oil overhaul bill

Both chambers of Nigeria's parliament have passed a bill that overhauls nearly every aspect of the country's oil and gas production, putting a project that has been in the works for two decades one step closer to

presidential sign-off. Legislators have been hashing out details of the bill since President Muhammadu Buhari presented an initial version in September last year, but an overhaul has been in the works for some 20 years. The chambers had

been expected to vote clause by clause on the more than 400-page long report, but instead quickly approved the full package.

Each chamber made changes before approving the package, and the senate lowered the share of money for oil-producing communities. The chambers will need to meet again to work out the details, but members were optimistic that they would come to an agreement next week, after which it could go for presidential sign-off.

Analysts say its approval is essential to at-

tracting a shrinking pool of capital for fossil fuel development. Earlier in the day, senators entered a closed-door session with the petroleum minister and the head of state oil company NNPC for a briefing on the technical terms and details.

The last key controversies related to the share of wealth for communities in areas where petroleum is produced, and those in the northern and central parts of Nigeria where there is exploration but no production yet. The house bill signed off on an in-

crease in the share of regional oil wealth generated from production that host communities can claim from 2.5% to 5%, but the senate approved 3%. Communities had pushed for a 10% share. Sources said disagreements with northern leaders were managed separately following several hours-long sessions between them and federal government officials early this week.

The package also includes a string of changes sought by oil majors, including amended royalties and fiscal terms for oil

and gas production, and the transfer of state oil company NNPC's assets and liabilities to a limited liability corporation created by the bill. It also divided the stakes in the new NNPC Limited evenly between the finance and petroleum ministries, but would not allow for public share sales without further government approval. Leaders agreed earlier this year to sweeten the terms for oil companies in an effort to attract much-needed investment in an era of shrinking global cash for fossil fuel production.

Jafo touts online application for scrap metal dealers

INISTER of State Vice President's Office (Union and Environment) Seleman Jafo has given 45 days to National Environmental Management Council (NEMC) to ensure that an online application system for permits to export, purchase and storage of scrap metal products is completed.

Jafo made the remarks at a meeting with stakeholders who included collectors, storage, transportation and recycling of hazardous waste in Dar es Salaam last week that new regulations for hazardous waste of 2021 regulations are now effective.

"I want by September 1, the online application system for permits to be completed because it is likely that online applications will increase numbers," Jafo while adding that issuance of the permits should not take more than 14 days if the applicant has everything in place.

with the special approval of the minister if it is considered important as industrial raw materials when the country is facing deficits.

Meanwhile Minister Jafo has ordered Gueng Cheng factory located in Kigamboni district in Dar es Salaam which uses tires as raw material to make various products including cables and bricks, to either relocate the factory or prevent smoke from affecting the neighbourhood public.

"The process of burning your tires is causing a lot of pollution and concern among the public, I give you a six-month provision to change or shift to new premises, "Jafo ordered while stressing that the Chinese company should invest in a modern plant for the factory.

The minister was angry at the factory owners absence when he visited despite the fact that they had information relating to his visit. Jafo who was greeted by

residents of the area brandishing placards condemning the factory for endangering their health and the environment.

"I have visited this factory but I have found that even the machines have been turned off so that I do not see the smoke affecting the environment, now I have given instructions to the people of Nemc but also to the factory owners and I will come here again to follow up," Jafo warned.

In another development, Minister Jafo gave a three months ultimatum to a plastic processing industry owned by Ruidar Company to address its sewage system which is not environmentally friendly.

"Discharging wastewater from the factory into residential areas is not acceptable so make plans to address how your waste water is disposed of," he advised. The factory's manager, Ping Zhang promise to implement the order within the given time.

Uganda enforces a new 12pc excise duty tax on data bundles

KAMPALA

The Ugandan government has enforced a new 12% excise duty on data bundles following the scrapping of the daily UGX 200 OTT tax.

Officials said the OTT tax failed to perform to expected levels with many internet users finding ways to bypass the regulation. The 12% excise duty was approved by Parliament in April after it passed an Amendment Bill 2021. The new tax is expected to impact data prices which are considered high compared to other countries in the Eastern and Southern Africa.

Telecommunication operators in the country, including Airtel Uganda and MTN Uganda, have confirmed that for now, they will absorb the 12% tax on data until they have fully assessed the impact of the new tax on data prices.

Airtel CCO Amit Kapur said: "Our subscribers will not be required to pay OTT in order to access social media websites and Apps. We shall institutionalise the 12% excise duty tax as mandated by the government of Uganda. However, Airtel Uganda will absorb the excise duty for all prepaid data packs, thus maintaining our pre-paid data prices. This will allow Ugandan customers to enjoy and connect with the world seamlessly using our affordable and reliable 4G smartphone network with no limitation.'

MTN Uganda said it will maintain current data plans despite the new tax coming into force. Rhona Arinaitwe, MTN Uganda senior communications manager said the company is still assessing the impact of the tax and that it will have to wait for an informed deci-

"All other standardised and customised voice and data bundles remain unchanged and are accessible on all our platforms. We believe everyone deserves the benefits of a modern, connected life. Accordingly, all customers can now access the internet and social media platforms without paying the said tax. All OTT tax, inclusive data of bundles, has been discontinued." The Uganda Communications Commission (UCC) said there were over seven million smartphones connected to the internet (mobile internet) as of December 2020.



The link between red meat consumption and climate change was made by Minister of Consumer Affairs Alberto Garzón in a video eliminating net greenhouse gas published on his Twitter account emissions by 2050, in line with Wednesday. People should eat a a European Union target, it will more varied diet, with less animal products, because it is healthier and better for the environment: "I don't want to scold anyone, but to reflect on this before the problem becomes chronic."

on an official visit in Lithuania. "To me, eating a steak cooked to perfection, that's unbeatable," he told reporters.

If Spain is to achieve its goal of need to tackle emissions from agriculture. "What we're saying is not that we have to stop consuming meat," he said, "but that we have to follow the levels recommended by science, between 200 and 500 grams week."

Violence spreads to South Africa's economic hub in wake of Zuma jailing

JOHANNESBURG

SHOPS were looted overnight and a section of the M2 highway was closed in Johannesburg yesterday, as sporadic acts of violence following the jailing of former South African President Jacob Zuma spread to the country's main economic hub.

Violence had mainly been concentrated in Zuma's home province of KwaZulu-Natal (KZN), where he started serving a 15-month sentence for contempt of court on Wednesday night.

Police said criminals were taking advantage of the anger some feel over Zuma's imprisonment to steal and cause

The Johannesburg Metropolitan Police Department (JMPD) said there had been looting in the Alexandra township and Jeppestown suburb. The M2 was closed off after there were reports of shots being fired at passing vehicles.

Protests were ongoing in the Hillbrow neighbourhood yesterday morning, JMPD spokesman Wayne Minnaar said.

KZN police spokesman Jay Naicker said there had also been looting in eThekwini, the municipality that includes Durban, and that nine people had been arrested, taking the number of arrests in the province since Friday to 37.

Kenya struggles to address cases of missing children

NAIROBI

THERE was laughter and joy as a young Frank played with his friend outside their home located on the northern edges of the Kenyan capital, Nairobi. While his friend returned home that day, Frank's parents spent the whole night scouring their neighbourhood for their three-yearold son taken by persons unknown to them.

"A neighbour alerted me that a woman was walking off with Frank. This was around 10 a.m. local time. Aware that I had not allowed anyone to take Frank, I rushed out of the house but failed to see them.

Both Frank and the woman were gone within minutes," James Mwangi, father to Frank said during a recent inter-

Mwangi and his wife have momentarily lost sense of the world with the unfortunate disappearance of their child. Since June 22, when their son was withdrawn from them, the family has been in a state of hopelessness.

Regrettably, other families share in Mwangi's anguish after their children have also gone missing. In the recent past, cases of child abductions have been making headlines in the local media.

In the capital, the cluster of kidnappings is emanating from Zimmerman, a suburb 13 kilometres from downtown Nairobi. Mwangi resides in this area together with his young family.

The coastal city of Mombasa has also been in the spotlight with area residents being left shaken by soaring cases of violence meted upon children in the hands of their abductors.

"The incident has left her traumatized and is now threatening her pregnancy. We have been going to the hospital more frequently because of Frank," said a distraught Mwangi.

Because of the situation, school buses are delivering children right outside their homes unlike before when they would be dropped off a few blocks away. Also, the young ones can be heard playing within the confines of their building blocks kept under lock and key round the

"Anxiety is at an all-time high; no parent wants to see a stranger talking to their child. There is fear of even sending them to the shops because that could put them right in the path of the kidnappers," said Irene. "Last week, a car was upturned with two men inside.

The two men failed to provide details of a young child in their possession. Within minutes people waged an assault against them. They were saved by the police," she added.

Responding to the dire situation, the cabinet secretary for Labour and social protection, Simon Chelugui said the government had constituted a special unit that would address cases of missing children, according to local media.

Missing child Kenya, a non-profit organization at the forefront of reuniting missing children with their kin, released a report for last year when 242 children were reported missing, 131 were reunited with their families, and 10 were confirmed dead. Xinhua

Some US legal acts show the country is split, Russian diplomat says

MOSCOW

A number of recently adopted legal acts in some US states point to the current split in the country as well as growing "cultural wars" in the United States, Russian Foreign Ministry Spokeswoman Maria Zakharova wrote on her Telegram channel yesterday.

"America is split, and 'cultural wars' are becoming more sophisticated and are ensured with laws now," the diplomat said.

Zakharova drew attention to two recently passed legal acts in some US states.

In particular, California's State Attorney General banned local state workers from traveling to some other regions in the country. According to the diplomat, the reason is Sacramento's different political views compared with the positions of 17 states regarding

Furthermore, Arkansas prohibited doctors to conduct gender surgery for minors. Florida, Montana and West Virginia also imposed a ban on transgender girls to take part in school sports competitions. In North Dakota, a bill was passed allowing student organizations to refuse to accept LGBT students.

"In general, even in the twisted logic of the US left-wing liberal ideology many legislators at the regional level understand that it's impossible to cross the line, especially in the issues concerning children and the youth.

But the liberal dictatorship has another view. California's authorities now won't 'make friends' with other US federation subjects," Zakharova noted. "It cannot be ruled out that the ban on trips is just the beginning of pressure of the US richest state on less wealthy regions."

According to the diplomat, against this backdrop another regional legal act comes to the forefront. Florida compelled colleges and universities to monitor the freedom of political views of the youth. This points to "a state political control over free dissemination of ideas among students in the worst traditions of dictatorships of the last century," the diplomat explained. "This is another step towards punishment for thought crimes," she stressed.

India pulls out staff from Kandahar consulate

INDIA'S foreign ministry spokesperson Arindam Bagchi yesterday said India was monitoring the situation in Afghanistan and has brought back staff from the Kandahar consulate for time being in wake of the intense firing

"India is closely monitoring the evolving security situation in Afghanistan. The safety and security of our personnel are paramount. The Consulate General of India in Kandahar has not been closed. However, due to the intense fighting near Kandahar city, India-based personnel have been brought back for the time being," Bagchi said in a statement.

"I want to emphasize that this is a purely temporary measure until the situation stabilizes. The consulate continues to operate through our local staff members.

The statement came in wake of media reports that around 50 diplomats and other staff members at the Kandahar consulate in Afghanistan have been evacuated by India, in view of the Taliban fighters rapidly seizing control of a number of key areas in the region.

According to reports, the personnel were flown out on an air force plane and the Kandahar consulate has been closed temporarily.

"Arrangements are being made to ensure continued delivery of visa and consular services through our Embassy in Kabul," the spokesperson said.

As the United States looked to complete the withdrawal of its forces from Afghanistan by August-end, ending nearly two-decade of its military presence in the war-ravaged Afghanistan, a surge in series of attacks has been witnessed in the last few weeks in the

The statement called on the United Nations Security Council to bear its responsibilities and take all needed measures "to oblige Israel to abide by interna-

tional and humanitarian laws."

US leaves Afghanistan 'nothing but trash'

BAGRAM, Afghanistan

STILL surrounded by concrete walls and razor wire, the Bagram Airfield, also known as Bagram Airbase, had been home to the U.S. troops in Afghanistan in the past 20 years.

The airbase was handed over to the Afghan forces early this month." Nothing important was left at the airbase," Gen. Mir Assadullah Kohistani, now commander of the airbase, told Xinhua.

"The U.S. forces destroyed all the facilities and military equipment that the Afghan forces could not use or their shifting to America was expensive."

Piles of trash heaped up at the airbase are to be sold to local dealers, said Gul Mohammad, a scrap dealer in Bagram.But the real mess the U.S. troops have left behind in the country is triggering concern across the world.

U.S. President Joe Biden in April ordered the complete withdrawal of the country's troops from the war-torn Afghanistan by Sept. 11 this year, the 20th anniversary of the terrorist attacks on New York and Washington that precipitated the so-called U.S. war on terror.

Claiming to be in pursuit of Osama bin Laden, the alleged mastermind of the 9/11 terror attacks, the U.S.-led military forces invaded Afghanistan and ousted the Taliban within weeks of the terror attacks.

With over 90 percent of the withdrawal being completed now, Biden said that the mission was to be concluded by Aug. 31, a few days ahead of the original deadline.

Taliban militants have been more active since the withdrawal of the U.S. troops at the beginning of May, resulting in the deteriorating security situation in Afghanistan.

According to a Taliban source, the group now controls 85 percent of Afghan-

istan's territory. A visiting Taliban delegation to Moscow said on Friday that their militias have controlled 250 out of 398 districts in the country, though the claims cannot be verified so far.

The hasty withdrawal is widely regarded as a defeat for the United States, both in Afghanistan and throughout the region.

The United States invaded Afghanistan under the pretext of fighting terrorism in late 2001 and dethroned the Taliban regime and its alleged supporter al-Qaida network, Atequllah Omarkhil, a retired army general as well as a military and political analyst, told Xinhua.

According to Omarkhil, only the Taliban and al-Qaida were operational in Afghanistan in 2001. Today more than 20 militant groups, including the Islamic State, are active.

Twenty years later, the United States left Afghanistan with fighting and violence still ravaging the country, the retired army general said.

The legacy of the U.S.-led forces' 20-year presence in Afghanistan is nothing more than brutal fighting and insurgency, he said, adding that the "ongoing war and destruction are the outcome of the U.S.-led military invasion.

"The United States termed its mission in Afghanistan as a defensive maneuver against terrorists, and the mission was supposed to bring peace to Afghanistan and help the Afghans establish a stable society.

The Pentagon claimed recently that over 2,400 U.S. troops have been killed and 20,000 others wounded in Afghanistan over the past two decades.

The most conservative estimates by local and international rights groups suggest that close to 47,600 civilians have been killed and more than double that number injured in Afghanistan during the 20 years of war, according to figures from the Watson Institute of International and Public Affairs at Brown University.

The whole affair has been a brutal fiasco, serving no perceptible purpose and achieving noth-

"After Vietnam, Afghanistan is the second country that the U.S. military is leaving after suffering military defeat," Khan Mohammad Daneshjo, an analyst, told Xinhua. '

The U.S. defeat and its troops' departure from Afghanistan would further increase the already fierce fighting in the conflict-plagued country," Daneshjo said.

The U.S. mission in Afghanistan asserted it was to annihilate terrorists, bring about peace and help Afghans establish a peaceful and prosperous society, but fighting has been continuing and Afghans are still suffering, said the analyst.

The Bilateral Security Agreement inked between the United States and Afghanistan years ago was a commitment by Washington to defend Afghanistan "whenever needed," an obligation conveniently overlooked during the withdrawal,

Daneshjo said, adding that the United States has left Afghanistan at war with itself, a war characterized by insurgency, fear and poverty.

The United States and the Taliban signed a peace deal in February last year, calling for a gradual withdrawal of the U.S. troops on condition that the Taliban cut ties

Habitats of endangered wild animals improve evidently in China

AS China has made active efforts to protect ecological environment and biodiversity, the country is seeing more and more traces of wild animals, which signals evident improvement and restoration of China's wildlife habitats.

The country has established a relatively complete system of nature reserves that systematically and thoroughly puts large areas of natural ecosystems under protection, and effectively improves the living environment of wildlife, said Cui Shuhong, director-general of the Department of Nature and Ecology Conservation of China's Ministry of Ecology and Environment, at a press conference on July

The wild giant panda, Tibetan antelope, Milu deer, and other rare and endangered species are living in better environments, as pointed out by Cui at the press conference on the Eco Forum Global Guiyang 2021, a national-level high-end platform on ecological civilization to be held in Guiyang, capital of southwest China's Guizhou province, on July 12 and 13.

Populations of several rare and endangered species have gradually recovered, and the numbers of Siberian tigers, Amur leopards, Asian elephants and crested ibises have grown rapidly, he added.

Wild giant pandas were once on the verge of extinction, but now their status has been officially downgraded from "endangered" to "vulnerable" on the International Union for Conservation of Nature (IUCN) Red List of Threatened Species as their population grows. At present, over 1,800 giant pandas are living in the wild.

There have been many reports recently on rare and endangered

wild animals, which Cui believes have mirrored China's fruits in biodiversity conservation and ecological restoration.

Rare and endangered wild animals including wild giant pandas and snow leopards have been reported to be frequently captured by cameras. Siberian tigers appearing in villages in northeast China's Heilongjiang province and Asian elephants heading north in southwest China's Yunnan province were also on the news. Recently, a Bryde's whale was discovered at the Mirs Bay, Shenzhen, south China's Guangdong province.

During the annual sessions of China's national legislature and top political advisory body in March, the delegation of northwest China's Qinghai province showed photos of Chinese desert cats, a wild animal species under Grade-I conservation in China. The photos were taken in the Oilian Mountain National Park. Chinese desert cats, known as one of the most mysterious species of the Felidae family, are rare and sparse, and have been hardly trailed over the years.

In the same month, photographers captured images of three

rufous-necked hornbills, also under Grade-I conservation in China, in mountain forests more than 2,000 meters above the sea level in Yingjiang county, Dehong Dai and Jingpo autonomous prefecture of Yunnan. It was the first time to capture images of this species since the 1980s.

Rufous-necked hornbill has been listed in the Appendix I of the Convention on International Trade in Endangered Species of Wild Fauna and Flora as one of the species threatened with extinction which are or may be affected by trade in specimens.

In recent years, China has carried out major activities and taken effective measures to safeguard biodiversity, and remarkable results have been achieved.

Cui noted that China has significantly accelerated the mainstreaming of biodiversity, and gradually incorporated biodiversity protection, an important part of the ecological civilization construction, into various national plans and projects.

In its five-year plans for national economic and social development, the country made maintaining biodiversity a key task of ecological protection and restoration.

In 2010, China drafted and adopted the National Biodiversity Conservation Strategy and Action Plan (2011-2030), which serves as a guide to its mid- and long-term biodiversity conservation efforts.

In June 2020, the country issued a master plan that includes major projects protecting key ecosystems, preparing to comprehensively strengthen the conservation and restoration of ecosystems and biodiversity.

According to Cui, China has

steadily formed an ecological red line system that enforces strict protection over certain zones, and basically finished identifying such zones for ecological conservation. At least 25 percent of China's land area shall be demarcated for ecological protection, covering major ecological functional zones, regions that are ecologically sensitive and vulnerable, as well as key regions for biodiversity.

China has also constantly improved in-situ and ex-situ ecological conservation networks, as Cui pointed out. By the end of 2019, China had 11,800 nature reserves of various types, which covered an area of over 170 million hectares and accounted for 18 percent of the country's land area. It helped China meet the Aichi Biodiversity Targets goal of protecting 17 percent of terrestrial areas ahead of schedule, Cui said, adding that the country has also set up botanical gardens and wildlife breeding bases and successfully bred a large number of rare and endangered species.

Cui noted that China has made major progress in ecosystem protection and restoration. By implementing and advancing a large batch of ecological conservation and restoration projects, including comprehensive and systematic treatment of mountains, waters, forests, farmlands, lakes, grasslands, and deserts, natural forest conservation, turning the low-yielding farmland back into forests and pasture, and wetland protection and restoration, China has seen a continuous increase in forest coverage and decrease in degraded land areas.

Growing express delivery capacity helps unleash consumption potential in China

CHINA'S express delivery sector has continued to maintain robust momentum for growth since the beginning of 2021, with the number of parcels handled exceeding 50 billion as of July 4, close to that of the whole year of 2018, according to the country's State Post Bureau (SPB).

It only took the industry six months to register a business volume of 50 billion this year, about two months earlier than in 2020. In addition, the sector serves an average of about 600 million customers per day, and handled up to over 400 million packages a day during the annual "618" (June 18) online shopping festival, continuously creating notable new records.

The rapidly rising business volume and increasing delivery speed reveal the country's flourishing consumer market and witness a boom in online retail market of China.

Of the 50 billion parcels handled in the country, about one third were sent to rural areas, representing a fast growth. The consumption potential of rural residents has been gradually released as the network of China's consumer market extends to rural areas, and manufactured goods enjoy increasingly smooth channels for transport, sales and marketing in the countryside.

While the number of parcels sent to rural areas increases, the amount of packages sent out from these areas has also surged, reflecting huge potential for sales growth of agricultural products in urban areas.

Due to poor logistics, Raohe county of Shuangyashan city, northeast China's Heilongjiang province, a core area of national nature reserve for black bees, had difficulty selling local honey and increasing local residents' income.

"After express delivery services became available in our

village, we can sell individually wrapped honey on e-commerce platforms at a price of up to 40 yuan (about \$6.16) per kilogram. Our life is much better now," Li Shuying, a beekeeper in Raohe county, told People's Daily.

According to Li, before the village was connected to the country's express delivery network, her family could only sell the honey they harvested to a few passersby, and then sell the rest in bulk at low prices to processing plants.

In one of the areas covered by express delivery service outlets in Raohe county, where there are 21 beekeeping house-

holds and about 75,000 kilograms of honey is produced a year, the income of beekeepers has increased by 1.2 million yuan after express delivery services have been launched in the locality.

Encouraged by the SPB, courier companies in China have pushed ahead efforts to make express delivery services available in rural areas by adopting various models according to local conditions in recent years.

By 2020, all the townships in China had been basically covered by express delivery network, and more than 50 percent of the packages had been able to be sent directly to villages.

The ever-expanding express delivery network and improving express delivery services in rural areas have brought more and more agricultural products onto dining tables of urban residents, while helping rural residents enjoy continuous increase in their income.

As their income has grown, rural residents show stronger willingness to spend, which has further speeded up the introduction of manufactured products into rural areas and made rural market a new growth driver for express delivery sector and a new "blue ocean" of consumer market.

The service capacity of the express delivery sector decides to some extent the product mix of consumers' online shopping list. After all, efficient express delivery services can surely make online shopping more appealing.

Looking forward, express delivery sector in China is expected to contribute more to unleashing consumption potential and facilitating the forming of a new development pattern.

Messi's Argentina trophy odyssey ends in Brazil

RIO DE JANEIRO

WHEN Lionel Messi, already a regular starter for the mighty Barcelona, made his international bow in 2005 as an 18-year-old for a powerful Argentina side he surely never imagined it would take him 16 years to finally claim a trophy with his country.

But the six time Ballon d'Or winner had to suffer numerous disappointments, including losing four finals, before leading his country to a 1-0 victory over "eternal rivals" Brazil in the Copa America final at Rio de Janeiro's iconic Maracana stadium on

Despite a glittering career that has seen him help Barcelona to win the Champions League four times, La Liga 10 times and the Copa Del Rey seven times, Messi's hopes of matching that with international success were repeatedly frustrated.

In truth he wasn't as inspired in the final as throughout the tournament, even slipping over when clean through two minutes from time and facing Brazil's goalkeeper Ederson with a chance to finish the match.

But the way his teammates threw him into the air after the final whistle showed how important and appreciated he is within the Argentina camp.

"It was my dream. It was what I wanted most in the world," said Argentina goalkeeper Emiliano Martinez following the triumph.

"We gave it to Messi, who deserved it the most." Three times previously -- in 2007, 2015 and 2016 -- his Argentina lost in the final at the Copa while the South Americans were also defeated 1-0 by Germany in the 2014 World Cup final at the Mara-

History would not repeat itself this time around as Messi not only inspired his side but also finished the tournament as top goalscorer and with the

He was named player of the tournament, during which Messi equalled and then broke Javier Mascerano's record of 147 caps for Argentina, setting a new mark of 151 on Saturday.

His four goals during the competition took him to 76 for his country, just one off all-time South American mark set by Pele for Brazil.

Winning this tournament was no simple feat for an Argentina that was outclassed by Brazil in the semi-finals two years ago.

They had gone 28 years without a major trophy and hadn't won on Brazilian soil since 1998 -- in a friendly -- while the hosts hadn't lost at home in 2,553 days.

Neymar, who missed Brazil's victory two years ago through injury, was also seeking his first major title with the Selecao.

His wait goes on but at 29, he's five years younger

than Messi, who was playing in his sixth Copa. - Next stop Qatar -

While he had been unable to replicate his club success at country level, Messi's never stopped trying and has always led Argentina by example.

In this tournament Messi shed blood -- from his ankle in a bruising semi-final win over Colombia

-- and sweat to drag his side into the title match. Argentina coach Lionel Scaloni even revealed

Messi had played the final with a tight hamstring. "If Argentines knew him like we (the players and staff) do, they would love him even more than they

Raja survive battering with 10 men to win CAF **Confederation Cup**

COTONOU

MOROCCAN club Raja Casablanca survived a second-half battering from Algerian rivals JS Kabylie with 10 men to win the CAF Confederation Cup final 2-1 in Benin's economic capital Cotonou on Saturday.

In a tale of two halves at the Stade de l'Amitie the Casablanca outfit raced into a two-goal lead within 14 minutes through goals from star attackers Soufiane Rahimi and Ben Malango.

But Kabylie pulled one goal in the first minute of the second half through Zakaria Boulahia and took control when Omar Arjoune was shown a straight red card on 63 minutes.

A Kabylie side that had been disorganised during the opening half began to string together passes and some of the football drew warm applause from a limited crowd in the 20,000-seater due to coronavirus.

But an equaliser evaded the club from the northeastern city of Tizi Ouzou and Algeria remain without a winner since the African equivalent of the UEFA Europa League kicked off 17 years ago.

Rahimi, voted the outstanding player at the African Nations Championship in Cameroon last February, dribbled past goalkeeper Oussama Benbot to score on five minutes.

Kabylie protested that the Moroccan was offside, but South African referee Victor Gomes awarded the goal after a VAR check.

Rahimi turned creator as Raja doubled their advantage on 14 minutes thanks to a close-range shot from physically imposing Congolese Malango.

Boulahia scored his third goal of the Confederation Cup campaign by slamming a rebound past goalkeeper Anas Zniti and into the bottom left corner of the net. AFP

Messi pays his debt to Argentina with Copa America title

RGENTINA finally made Lionel Messi cry with joy.

After losing four times in finals, early exits in major tournaments and even a decision to retire from the national team, the superstar celebrated a much-awaited title with Argentina at Saturday's 1-0 win against Brazil in the Maracana Stadium.

The title ended Argentina's 28-year drought of major trophies, with Messi as the best player with four goals and five assists. The captain also broke the team's record for international appearances with 151 matches.

"I needed to remove from myself the thorn of achieving something with the national team," Messi said after celebrating with his teammates.

When Uruguayan referee Esteban Ostojich blew the final whistle, Messi knelt down on the pitch and covered his face with his hands.

After he lifted the Copa America trophy, Messi said on the pitch and spoke to his family on the phone. He flicked the golden medal around his neck and shouted "I won, I won!"

The next challenge is to win the World Cup in Qatar next year, which would be the first since Maradona took the team to the title in 1986.

Until Saturday, Messi's titles with Argen-

tina were only the U-20 World Cup title in 2005 and a gold medal at the Beijing Olympics in

His first frustration at the senior-team level started at age 19 in the World Cup quarterfinals elimination against Germany in 2006. One year later, he saw Brazil beat Argentina 3-0 in the Copa America final.

His next major shot at winning with Argentina came in the 2014 World Cup final against Germany. The 1-0 defeat at the Maracana Stadium in Rio frustrated the star, who was voted the best player of the tournament, though his form was not as impressive as it was at his club.

Chile would crush Messi's hopes in two

Copa America finals, in 2015 and 2016, both on penalties.

After the second defeat to Chile, Messi told iournalists that the national team was over for

"It is not for me. I tried, I think that is it," he said. But he returned for South American World Cup qualifiers in which Argentina struggled. He took the team to Russia, but the round-of-16 defeat against France came at a turbulent time for the team.

Messi became more aggressive in the 2019 Copa America, much to the pleasure of Argentinian fans who considered him to be too cold, too European. Under a coach with little experience, Lionel Scaloni, he was surrounded by young players who got the best of him.

On Saturday Messi kissed the Copa America trophy and lifted it at age 34. The biggest gap in his decorated career is now

His first public words after the title showed how thrilled and relieved he felt.

"What a beautiful madness!," said in an Instagram showing post shirtless holding the Copa America trophy at the Maracana's dressing room. "This is unbelievable! Thank you, God! We are the champions!"

Goalkeeper Emiliano Martinez, one Argentina's key players

Messi "is the one who most deserved" to win the South American title. Later at a news conference Messi said happiness

"unexplainable." "I was sad before, but I knew that at some point it was going to happen," he said. "I feel that God was saving this moment for me, against Brazil in a final and in their country."

Meanwhile, Ángel Di María once admitted that he sought out a psychologist to help him deal with the trauma of his performance in finals. He overcame that stigma on Saturday with the goal that gave Argentina a 1-0 victory over Brazil in the final of the Copa America at the Maracana Stadium.

"I can't cry, I can't fall, we dreamed so much of achieving this. So many people said I shouldn't come back, I kept banging my head against the wall and today it happened," the veteran winger said after the match in Rio de Janeiro. His goal gave Argentina its first major title in 28 vears

Argentina's winner came in the 22nd minute after Rodrigo de Paul made a long pass to Di Maria. The 33-year-old striker counted on poor defending by Brazil leftback Renan Lodi to take control and lob it past goalkeeper Ederson.

Maria, captain in the tournament, said Lionel Messi and striker

Sergio Agüero are the sole survivors of the squad that lost the 2014 World Cup final in Brazil. They also experienced defeat against Chile in the deciders of Copa America in 2015 and 2016.

The winger had several setbacks due to injury.

"(Messi) said 'thank you' and I said 'thank you' to him. He told me it was going to be my final," an emotional Di Maria said. "Soccer is like this, comebacks are like this and it had to be today."

Di Maria didn't play in the 2014 World Cup final due to an injury in the quarterfinals against Belgium. One year later, another muscle injury forced him out during the Copa America final against Chile. He was also unfit during the Copa America Centenario decider in 2016.

That is when Di Maria started seeing a psychiatrist. Argentina fans wanted him out of the squad, but he turned the tables on them on Saturday, despite fact he started the the tournament as a substitute.

.Di Maria promised more joy for Argentina fans after the Copa title Saturday.

"This is enough to continue here. The World Cup is coming soon, and this is a great push," he said.

Argentina's team effort over Brazil leads Messi to Copa America glory

IN the end, Brazil's dependence on Neymar was greater than Argentina's on Lionel Messi. Argentina's 12th goal of the tournament was the first and only one not to involve Messi -- and it was enough to bring Messi the first senior title of his international career, as well as Argentina's first since 1993.

The 1-0 victory in the Copa America final on Saturday was the fruit of Argentina coach Lionel Scaloni's willingness to change a winning team -- or at least one that had come through a semifinal after a penalty shootout. He changed five of the side -- half of the outfield contingent -- from the lineup of Tuesday's game against Colombia. One was routine, with centre-back Cristian Romero returning after injury. Both full-backs were changed; Scaloni clearly wanting fresh legs down the flanks.

And the other two altered the structure of the side. The most defensive midfielder, Guido Rodriguez, gave way to Leandro Paredes. This might have seemed strange. But Scaloni decided he did not need to start with Rodriguez because he strengthened the sector. Instead of the normal 4-3-3, Argentina lined up in a 4-4-2. Nicolas Gonzalez on the left wing gave way to Angel Di Maria.

It was a match winner, a title-winning switch.

There was a price to pay. Giovani Lo Celso was pushed wider to the left, further from Messi. This was the partnership that had consistently



got the team off to a fast start throughout the tournament. There was no fast start this time. But there was something to celebrate at the end, because the thinking behind the inclusion of Di Maria proved correct. His role was to cut inside, behind left back Renan Lodi, attacking the space of Thiago Silva. It was where the game was

Rodrigo De Paul, a strong candidate for man of the match, gave a long diagonal ball for Di Maria to chase. Renan Lodi could not control, and Di Maria was there to beat Ederson with a cute lob. Scaloni was rewarded for making changes to his team.

Brazil coach Tite might regret not doing likewise. He sent out the same lineup that had beaten Peru on Monday. Some of their problems were predictable. A key flaw in the goal was the lack of pressure placed on De Paul in the middle of the field. Brazil have been pressing better when Eder Militao has featured at centre-back. But Tite stuck with Thiago Silva, who has inevitably lost some of his pace. He tends to stay deeper, and the team breaks up into separate units as a result. In attack, Tite gained little from winger Everton Soares, who was the breakout star and Golden Boot winner at the 2019 Copa but has not been in top form recently. Brazil's coach worked overtime try-

during the course of the game. Roberto Firmino came on at the interval, pushing back the Argentina centre-backs and giving Neymar space to bring Richarlison into the game, cutting in from the right. It was the closest Brazil came to a goal, with Richarlison having one strike ruled and another well-saved by Emiliano Martinez. On came Vinicius Ju-

ing to rebuild his attack nior to provide some thrust down the left. On came striker Gabriel Barbosa, who forced another smart save from Martinez. Argentina withdrew. Messi was left all alone up front, though he did have a chance to clinch things toward the end after a superb one-two with De Paul, only to lose control out for a narrow offside at the vital moment. De Paul burst through to be stopped by Ederson, but the action by then was

happening at the other

Argentina set out to stop Neymar any way they could, fair means and foul, even queueing up to try to rugby tackle him in desperation. It was a time for cool heads, and Brazil struggled to stay calm. The fouls, the constant interruptions, the yellow cards -- all worked in Argentina's favour.

It was not pretty; it was no classic. But it will live long in the Argentine memory, especially in the memories of those fans -- 10% of the stadium capacity -- who were controversially and chaotically allowed to enter Rio de Janeiro's Maracana stadium.

A long wait has come to an end. At the final whistle, the entire Argentina team ran toward Messi -- a graphic illustration of how well he is integrated into the squad. Few will begrudge him his moment -- and the long embrace between him and Neymar a few minutes after the whistle was as memorable as anything that happened on the field.

SIMBA SC has confirmed it is supporting the new initiative by the Confederation of African Football to start an African Super League.

As the project aiming at creating an African Super League is on track, Simba SC Chairman Murtaza Mangungu said it is a pride for his club to be part of this launch process.

Simba made it to the quarterfinals of CAF Champions League two times in three seasons.

The Tanzania football giants have for that matter proved to be a African football force after making yet another statement by topping their group this season with 13 points ahead of the season's Champions League finalists, Egypt's Al Ahly.

In a press release made public on the CAF website on June 20, CAF president Patrice Motsepe returned to the African Super League project.

For him, it will be effective, but the European model should inspire them so that Africa does not fall apart.

to learn from their failure," he said. Thus, without a doubt, the creation of the African

Super League will see the light of day. But if either the start date or the names of the clubs that will play in the championship have not

filtered, Mangungu has affirmed with certainty that his club will participate in this launch. Better still, he is proud of it.

"Regardless of the Super League, it is difficult to talk about anything at the moment as we are in the early stages of negotiating on it," Mangungu disclosed.

He revealed: "At the moment we can't say what stage we have reached because as I said we are in the early stages, and we will provide more information when the process is complete, but we are proud to be part of this process, this certainly shows the size we as a team have."

Motsepe said in a previous interview: "We are assessing and in preliminary discussions to start an inclusive and broadly supported and beneficial CAF African Super League."

It should be noted the project of the African Super League emanates from an idea presented by world soccer governing body (FIFA) president, Gianni In-

Infantino said that this project would include 20 clubs which will be grouped into a closed league and which would generate nearly 5.1bn/- Euros as
