# Samia: Storied buildings suitable in urban schools

Launch of first digital bank branch

PRESIDENT Samia Suluhu Hassan has directed that future public school construction projects in urban areas with limited land must use storied buildings to fully utilise available space.

Inaugurating the 4.3km Mwenge-Morocco dual carriageway in Dar es Salaam yesterday, the president made this affirmation in response to remarks by Kinondoni MP Tarimba Abbas, who cited space limitations in building classrooms under the recent IMF Covid-19 relief loan package.


The MP said the district has obtained 3.3bn/- out of the 1.3trn/-loan for construction of classrooms and hospitals; noting that the district needs two secondary schools as Tandale and Kinondoni wards have no secondary school facilities.

The government similarly received euro 27m (over 55bn/-) as a loan from the European Union (EU) to sort out challenges brought about by the Covid-19 pandemic for the development of social services including education and health.

In response President Samia said the problem of confined areas for building schools is rising, in which case municipal authorities must consider changing building formats to address the challenge.

"Yesterday when I was in Mkuranga, I encountered a similar problem in regard to insufficient space for construction of school buildings. It is high time to change the style, instead of ordinary buildings we should embark on storied ones,"

## PM urges private sector clean energy role

THE government has appealed to the private sector to invest more in clean energy projects to complement public sector efforts towards mitigating offcets of climate showers.

Prime Minister Kassim Majaliwa issued this call during the weekend in Dar es Salaam at an annual dinner gala organised by the CEOs Roundtable, saying that there are plenty of opportunities that private firms can take up, in forestry and commercial agriculture, creating

wealth and helping to conserve the environment.

Stressing the government's goal of reducing carbon emission from 35 percent to 30 percent of total energy generated in the country in 2030, he said that Tanzania generates 10 tonnes of waste a day of which seven percent comes from plastic ornaments.

He appealed to private sector chief executives to initiate processing industries making use of the waste to avoid environmental pollution that threatens human health. "The government 44

# Simanjiro shines for mitigation of climate

SIMANJIRO District in Manyara Region has registered advances in climate change mitigation worthy emulating in other parts of the country.

Selemani Jafo, the Minister of State in the Vice President's Office (Union and Environment) made this observation after inspecting projects implemented in the district under the World Hank supported 'Ecosystem-Based Adaptation for Rural Resilience' (EBARR) project during the weekend.

Apart from Simanjiro, the project is also being implemented in Kishapu (Shinyanga region), Mpwapwa (Dodoma region), Mvomero (Morogoro region) and North "A' (Unguja island) at a combined cost of \$7.5m (17bn/-).

The minister expressed satisfaction with implementation of the projects as they take into account the needs of the community in line with value for money, directing that the projects be completed and launched a month from now.

District Commissioner Dr Suleiman Serera thanked the VPO for coming up with the environmental projects initiative in the district, noting that the projects have been a great help to the people.

The secret to success in implementing the projects was the presence of independent experts managing the situation, enabling the project supervisors to organise the work properly.

GEF was established at the time of the Rio Earth Summit in 1992 to tackle the planet's most pressing environmental problems. Since then it has provided upwards of \$21.7bn in grants, mobilising an additional \$119bn in cofinancing for more than 5,000 environmental projects and programs.

The GEF is the largest multilateral trust fund focused on enabling developing countries to invest in nature, supporting the implementation of major international environmental conventions touching on biodiversity, climate change, environmentally harmful use and disposal of chemicals, along with challenges of desertification.

It brings together 184 member governments in addition to civil society, international organizations, and private sector partners, where the small grants programme it provides support to more than 25,000 civil society groups and community initiatives in 133 countries.

their government wasn't issuing passports to ordinary citizens," he recalled.

"Ethiopia is landlocked and never allowed citizens to travel outside their country since their government feared they might never return, thus passports were never issued," recalls the retired envoy, who was appointed commander of the army after it was revamped following a mutiny at Colito (later Lugalo) Barracks in January 1964.

He recalled having had to strike a friendship with the Head of Immigration in Ethiopia, managing to convince him to start providing international travel documents to citizens, having in view chances that many would come to Tanzania and climb the Kilimanjaro.

"I assured Ethiopian officials that they need not worry as Tanzania would ensure that none of their citizens sneaked out from the visiting team," he said.

"That assurance worked, and

the military government started issuing passports to citizens, but on condition that they were only going to climb Mount Kilimanjaro in Tanzania," he stated.

From that time Tanzania started receiving tourists from Ethiopia coming to climb Mount Kilimanjaro, but upon landing at the Kilimanjaro International Airport (KIA), officials of the Immigration Department took their passports for safe keeping. They only returned them when the Ethiopians were board-

ing the plane back home, he explained.

That created trust and since then, the Ethiopian government would be providing passports to its people mainly for Kilimanjaro trips and the tradition was gradually being formalised.

"Suffice to say that Mount Kilimanjaro opened Ethiopia to the world. Many Ethiopians in the Diaspora acquired their first passports through the Kilimanjaro initiative," the retired envoy noted, affirming that most of them still

remember the role which Tanzania played in paving the way for them to become freer, and some even call him to express gratitude. General (rtd) George Waitara, the board chairman for Tanzania National Parks (TANAPA, also a former CDF, is leading an expedition to climb Mount Kilimanjaro to once more plant the national flag at Uhuru Peak at independence day on Thursday. The expedition is replaying the feat of the night of December 8 1961 at the dawn

of independence when the national flag and Uhuru Torch were put on top of Kiliman-jaro by a team led by Second Lieutenant Alex Nyirenda, the role model for annual Uhuru Torch runs.

Charles Ngendo, who oversees tour visitations at the Kilimanjaro National Park (KINAPA), said the nearly 150 Uhuru climbers started their trek yesterday via the Marangu Gate, and will return to base next Friday, the day after the anniversary.

she asserted.

The government also plans to postpone follow up assessment of the project funds, where it will now employ to make the projects follow ups.

The 1.3trn/- funds from IMF will be followed up at present, but the government should strengthen the valuation and assessment section to make follow ups. After a short time you will know steps taken by the Treasury, she stated, hinting at appointing evaluation commissioners or directors in following up use of IMF funds countrywide.

President Samia thanked the Japanese government for the aid it continues providing towards the improvement of road building and bridges, pledging to work on challenges experienced in implementing projects to avoid their being repeated in future.

She said that widening of the dual carriageway will reduce accidents and traffic congestion for vehicles entering the city of Dar es Salaam, urging road users to protect the roadside environment to make the facility last longer.

Works and Transport minister Prof Makame Mbarawa said the road improvement project cost 3.7bn Yen (71.85bn/-), being a key project to solve traffic flow challenges in the city, noting that the road will reduce accidents, and expressing strong appreciation to the Japanese government.

Ambassador Goto Shinichi said that for 58 years Japan has been assisting Tanzania in its national development agenda in various sectors pointing at continuous improvement of the road infrastructure Japanese aid helped with widening Morogoro Road, Ali Hassan Mwinyi Road, Kilwa Road and part of the Nelson Mandela Expressway, with the Mwenge-Morocco portion being part of New Bagamoyo Road.

## Samia commends TPA for suspending dubious project

PRESIDENT Samia Suluhu Hassan has commended the decision by the Tanzania Ports Authority (TPA) to suspend dubious project for the construction of fuel tanks at the Dar es Salaam port.

The government has shares in PUMA Energy Tanzania Limited and the Tanzania International Petroleum Reserves Limited (TI-PER), which had several unused tanks.

According to the head of state, it was not clicking into her mind when the government had 50 per cent stake in shares of Puma Energy Tanzania, a subsidiary of global oil firm Puma International, then at the same time TPA contracting other private companies to do a similar job at the country's major port.

President Samia (pictured) was speaking on Saturday during her working visit at the Dar es Salaam port where among other things, expressed her dismay over several working irregularities within some officials at the port.

At the event, the President equally inaugurated berths number 1 to 7 at the Dar es Salaam port.

The head of state said among the projects that she came across at the beginning of her presidency in March 2021, was the project aiming at putting up fuel tanks at the coun-

"After realising that this multi-million shillings project was not in favour of the national interests, I directed the TPA director general, Erick Hamis to suspend the contract immediately, because the project was not viable to the nation.

The president said that she was glad that the project was halted after her directives, at the same time asking the TPA DG to initiate



the tendering process afresh. She added that it was high time to think of companies which the government had a joint venture with.

"What stunned me was the fact that the government has 50 per cent in Puma Energy Tanzania, which had several unused fuel tanks, wondering why it was important to go into initiating a process to contract another private company."

The government owns a 50 per cent stake in Puma Energy, a globally integrated midstream and downstream energy company operating in the country since 2011. The company is jointly owned by the government through the Treasury Registrar and the Ministry of Finance and Planning, each holding 50 per cent of the company's equity.

President Samia insisted that in initiating development projects, TPS should think of engaging companies in partnership with the government in order to increase performance.

"I want to reiterate that upon implementation of serious projects, the TPA boss and the ministry should make sure that they keep their eyes on the projects and ensure professionalism and accountability.

According to Dar es Salaam Urban Transport Master Plan, New Bagamoyo Road is one of the most congested roads in the city. In addressing this challenge, Government of Tanzania came with decision to widen New Baganoyo Road. New Bagamoyo Road was a major hindrance to smooth traffic between the city center and suburbs, it was regarded as a high priority project.

> Dar es Salaam plays a central role in the economy and physical distribution of Tanzania. As the city is the starting point for all transport systems, including the road, rail, air and maritime transport, it is truly a strategic point for transport in Tanzania.

Over the last 10 years, the number of registered vehicles in the city has grown at an annual rate of 14% which is higher than the population growth rate. As a result, the traffic congestion along trunk roads has been worsening every year, thereby hampering economic activities. Furthermore, since population in Dar es Salaam has displayed a high growth rate of 4% in recent years, it is forecast that traffic congestion in the urban area will continue to deteriorate from now on.

JICA Preparatory Survey Team came to Tanzania to conduct the field survey from April 6 to May 12, 2014, and confirmed the level of necessity and urgency of upgrading New Bagamoyo Road.

#### The Project for Widening of New **Bagamoyo Road**


The Project for Widening of New Bagamoyo Road was formulated. New Bagamoyo Road has been widened to four lanes with 9 m width of central median for future Bus Rapid Transit (BRT) over a section of approximately 4.3 km from the boundary of the BRT phase-1 works at Morocco Intersection to Mwenge Intersection. Intersections have been improved in order to secure safe and smooth traffic flows. Service roads and sidewalks are installed in order to secure the road service level and safety. Road drainage facilities for resolving road inundation; auxiliary facilities for securing the road functions; and traffic safety facilities for securing traffic safety are installed.

The Project beneficiaries are a large number of residents living in the northern parts of Tanzania, the north of Dar es Salaam and the entire city area. The Project was urgently required in order to rectify income differentials, strengthen the trunk road transportation network, improve the living environment of residents and remove impediments to improvement of citizen lifestyles and economic activity caused by the serious congestion occurring on the target road section.

Thanks to mitigation of road flooding, congestion is relieved, while the improvement of unsuitable soil prevents subsidence of paved surfaces and enhance road safety. Maintenance of the newly widened New Bagamoyo Road by Tanzanian side will not require excessively sophisticated technology.

The New Bagamoyo Road is likely to contribute to rectifying poverty differentials, which is a common goal in national development plans in Tanzania, and it is going to help improve and strengthen the trunk road network. The Project observed all environmental and social guidelines.

The Project has shortened travelling time thus reducing transportation costs. Transport capacity on the road has increased leading to improvement of the level of convenience of transport in Dar es Salaam. The new road secures regularity of passenger and goods distribution, access to the center of Dar es Salaam and port facilities will soon be improved, thereby contributing to the social and economic vitalization of Tanzania.

Widened New Bagamoyo Road makes it possible to separate vehicles travelling at the standard speed from slower vehicles, thereby ensuring safe and smooth traffic flow. Through stabilizing access from surrounding farm areas (Bunju and Bagamoyo) to markets, the stable transportation of goods is secured, thereby leading to lower transportation costs and contributing to stable prices.

Likewise, average travel speed during the morning-noon and evening peaks (a total of seven hours: from 06:00 to 10:00 in the morning and from 16:00 to 19:00 in the evening) has increased from 3 km/h (due to congestion) to around 40 km/h, thereby greatly shortening travel times.

Traffic capacity has increased from the current some 830 vehicles/hr/ lane to 1,740 vehicles/hr/lane. Days of inundation will improve from the current some 30 days/year to 0.

The construction of service roads leading into the New Bagamoyo Road is highly effective in securing smooth traffic flow. It was decided to adopt service roads of around 4-6 m. The service roads have been designed in consideration of the systems adopted at both Makumbusho and Mwenge Bus Terminals.

This project much cares a pedestrian

safety. Sidewalks have been constructed alongside New Bagamoyo Road. Bus bays have been improved and built to reduce risks of accidents and minimize congestion. Street lights have been installed along the New Bagamoyo Road to serve motorists and pedestrians in consideration of night traffic safety. New Bagamoyo Road has a central median 9 m wide that will serve as the BRT zone in the future.

Since the Project was implemented under the grant aid scheme of the Government of Japan, the following points were taken into consideration as a guideline for execution. **Implementation** method and construction schedule in reflection of the local natural conditions such as weather, terrain and local features and current traffic conditions on the Project, consideration of maintenance capacity on the Tanzanian side, adoption of common execution methods that do not require special construction machinery or technology following construction, ample consideration to the social environment and traffic safety, and utilization of locally procurable materials as much as possible in order to contribute to vitalization of the local economy.

The Contractor for the Project complied with appropriate labour conditions and customs in line with existing construction legislations in Tanzania,

and strived to prevent disputes with workers and secure safety during the working period. The Contractor was an equal opportunity employer.

The Project for Widening of New Bagamoyo Road is under the partnership of Government of Tanzania and Japan International Cooperation Agency (JICA). The new road will be another model of "high-quality infrastructure" that is a foundation of inclusive development for all people in Tanzania. The Project is part of the measures to decongest Dar es Salaam City.

The Contractor gave social and environmental consideration during the works period.

Safety during works was secured, safety facilities such as barricades, colour cones, revolving lights were used. Also traffic controllers were assigned.

#### Further collaboration between the **Government of Tanzania and JICA**

JICA together with the Government proposed a concept of "Transit-Oriented-Development (TOD)". This concept encourages modal shift from automobile use to public transportation use. Increasing road capacity to meet the increasing demand is difficult, so modal shift would be promoted. Not only development of transport nodes such as MRT/BRT station, but also enhancing attractiveness of areas around public transport at the various Sub Centre, District Centre and/or Satellite City. JICA considers that TOD will contribute the additional revenue to the public transport (such as BRT) so that they are able to reinvest to the remaining phase of the projects.

Furthermore, JICA is considering extending its cooperation to the capital city, Dodoma. Together with the strong initiative and leadership of the Government of Tanzania, the capital city is experiencing the fastest growth. To accommodate the increasing traffic demand, JICA is conducting a feasibility study of development of inner-city roads.

on corridor development. The projects that are under planning stage are "the Project for the Rehabilitation of Kigoma Port" and the "Arusha-Holili Road Improvement Project". These projects will address safety concerns in addition to improvement of efficiency of transportation of the economic corridors.

Kigoma Port is a transportation hub of the Central Corridor connecting Tanzania, Burundi and the Democratic Republic of Congo through Lake Tanganyika. While lake transport is an essential route for the residents, the passenger terminal has serious damages, and people are not able to board a vessel directly. The Arusha-Holili Road is a main transport route between Arusha and Kenya. The upcoming project will increase traffic capacity by widening busy sections of roads. In addition, the project will address the safety concern of a bridge section at Kikafu between Kilimanjaro International Airport and Moshi.

Last but not least, While developing transport infrastructure, it is also necessary to involve assistance designed to make wise use of developed infrastructure. For the development and effective use of infrastructure, JICA has been engaged in the development of the related human resources. JICA's Knowledge Co-Creation Program (KCCP) invites Tanzanian people in Japan, and it has significance with regard to the utilization of Japan's development experience and knowhow by adapting them to the partner country, rather than only sharing Japan's advanced technologies and skills. Since the commencement of the cooperation, over 21,000 Tanzanian people visited Japan for training. JICA will continue to provide KCCP for further human resource development in transport sector and other related sectors.

JICA, through the soon-coming projects, will contribute towards the further development of Tanzania hand-in-hand with the people and the Government of Tanzania, and strengthen the longlasting bilateral cooperation between

Speaking during the closing of a three-day accountants' annual conference in Dar es Salaam during the weekend, Emmnuel Tutuba, Permanent Secretary, Ministry of Finance and Planning said that the quality of information and how it is presented is vital in allowing users to make well-informed deci-

The event also went along with awards giving to best presented financial statements of the year 2020 which is organised by the National Board of Auditors and Accountants (NBAA).

the Accountant General, Leonard Mkude, the PS said the quality of the information and how it is presented is vital in allowing users to make well-informed decisions.

He urged accounting and auditing firms to conduct their activities faithfully and legally and avoid facilitating fraud by producing false financial statements, something which affects the health and stability of the country's financial sys-

"In order to promote compliance and attract investors for our country, we need financial statements that provide maximum insight into the financial conditions and risk positions of financial intermediaries. #### Tanzanians urged to stop hiding suspects of GBV

TANZANIANS have been advised to stop hiding suspects of Gender Based Violence (GBV) cases, but should effectively participate by providing cooperation at the court, something that will eliminate the challenge in the country.

Inspector of Police in Manyara Region Nuru Lucas made the call here during the national forum to end GBV in line with commemoration of 16 days of activism against

According to her, most of the victim's side ends up negotiating with suspects of violence thus killing the whole case.

She said it has been found that some of the families of GBV victims have been receiving money, goats or cattle from the suspects' family and then refusing to continue giving evidence or naming suspects.

"For example, despite taking all the needed efforts to ensure that a child who is a victims of rape gets his/her right, parents fail us by taking bribe from suspects forcing them to close the case," she said.

She called on the public to offer needed cooperation to police during solving violence cases for justice to be provided.



#### **Heed PM's warning on Covid-19 omicron wave**

PRIME Minister Kassim Majaliwa was at midweek making a point of emphasis on taking up vaccination among adults as earlier variants of the Covid-19 pandemic are rapidly being replaced by the Omicron variant. The debilitating new wave emerged apparently in Botswana and then spread around the world after it was isolated as a new variant in South Africa. Reports indicate that cases of infections were tripling and quadrupling within a week, after topping over two thousand cases the previous week. As the variant was almost immediately diagnosed in other parts of the world, its characteristics are now clearer.

For one thing, in South Africa a worrying aspect is that this variant is affecting scores of children under five years of age, which wasn't the case even with the Delta variant, the most powerful before this new variant arose. And it isn't that it is attacking a different age group but age groups on the whole do not matter so much anymore, so it is a long story from the time Covid-19 was a disease chiefly of aged people. That is why premier Majaliwa has been at pains to remind people that

the pandemic is worsening. As Tanzania has had a fairly good environment while other countries saw on a daily scale people dying in hundreds or thousands from the pandemic and for fairly long periods, here we have seen bouts of the pandemic, as if it was a fever. There was a moment, early this year when the Beta variant was spreading, that some wards in Kilimanjaro districts recorded more than a dozen burials in a single day. But those instances were few and far between, each ward having a bout of attacks or its kith and kin living in towns or cities being brought home for burial, and often in a restricted manner for fear of a wave of infections.

There are several characteristics that make Tanzania compare with South Africa but the contrasts are sharper, so to speak. We compare in the number of vaccinated adults as percentage of the adult population, where as a matter of fact they are well ahead of us, despite that by Western standards their vaccination rate is a disappointing third of all adults. Here the figure is much lower as we scarcely have two million people already vaccinated, but many are beginning to understand that escape routes are few.

When it comes to other lines of defence like wearing masks and using sanitisers, evidently South Africa is ahead of us in that aspect as people falling sick with the virus, and even acute hospitalization is more common. But as it was the case with the AIDS pandemic earlier, many people strongly believe in their immunity or assurance by some luck mechanism and take no precautions. This wave is harder to combat than previous variants of the coronavirus, but as Tanzania has never had a full pandemic many people are lukewarm on preventions; more care is needed here.

#### **International Civil Aviation Day has greater** appeal with a revamped airline, open skies

ternational Civil Aviation Day on December 7, Tanzania is in a better position to have wide ranging self-examination of the state of aviation in the country, first on account of revamping the national carrier and then with heightened activity as business improves.

There are more companies and individuals operating planes for various business requirements, as the country's aviation sector moves gradually towards modernization. It is a sphere of considerable global inequality, where the developed countries dominate the manufacturing and use of airplanes, a situation unlikely to change soon.

Strictly speaking we have made considerable advances in that regard as well, thought operating conditions for 'rapid transit' air services are still a problem to be worked out. Listening to the figures, it is clear that the issue at the local level isn't the fares that commercial airlines or charter services take up but the low purchasing power.

Airfare to Kigoma for instance is put at 350,000/- and that is land distance of more than 1,000 kilometers which means more people are taking to regular air travel chiefly for business.

Still there are forces working to diminish the potential of air travel, like information technology recent appliances enabling group exchanges merely on mobile phone, rather than elaborate conferencing arrangement and booking special lines for distance group meetings.

With the Covid-19 pandemic this way of communication was becoming the form rather than an exception, but life tional law as yet.

AS the world marks the In- was gradually coming back to normal, and it will still improve despite the latest omicron variant scare around the world. The data shows that it is susceptible to elevated containment for fully vaccinated people and especially with booster shots.

## Ethiopia is tearing itself apart

ALEXANDER Rondos warns that the ongoing conflict spells turmoil for the Horn of Africa. The longer the 12-month conflict in Ethiopia drags on, the greater the damage to the fragile stability of the Horn of Africa. It has already sown the seeds of regional destabilization that will accelerate if a political settlement is not sought urgently.

It is a sign of this concern that President Uhuru Kenyatta of neighbouring Kenya is actively engaged in trying to promote a resolution to the conflict and to lay the groundwork for a longer-term political settlement in Ethiopia.

At issue now is whether a country of 110 million people can be prevented from unraveling

From the moment the fighting began, Ethiopia's neighbours sensed unprecedented danger. If not rapidly contained, which it was not, the conflict would trigger a chain reaction of claims for selfdetermination and drain the economy. The consequences would not be confined within the borders of Ethiopia. At issue now is whether a country of 110 million people can be prevented from unraveling.

The effects of failure will be felt in neighbouring states, in the fragile relations among the countries of the region and in the strategic environment surrounding the Horn of Africa.

Conflict and economic collapse beget displacement and the hardest hit by a migratory wave will be Kenya and probably Somalia. If this wave grows, migrants - and the numbers could be very high - will try to reach South Africa and Europe. All of Ethiopia's neighbours have their own economic challenges and this additional influx will test their financial capacities.

Ethiopia's centrifugal political forces were contained over the past 30 years by significant budget subsidies to the regions nearest to the frontier. This is no longer the case. The cost of war has diminished the subsidies to these already impoverished border populations, who will seek more opportunity across the frontier. Once the provider of stability in the region, Ethiopia has become an exporter of insecurity. Ethiopia is now over-armed and under-financed. Weapons are making their way across frontiers and one should be alarmed that the jihadist group al-Shabaab, for example, can buy guns more cheaply from the Ethiopian market than it does from Yemen.

Ethiopia's deteriorating internal security is being exploited by al-Shabaab and other likeminded groups to infiltrate and recruit in Ethiopia. If this persists and succeeds, an entirely new front is opened making Kenya's security even more fragile.

The threat has now been exacerbated by Abiy Ahmed, the Ethiopian prime minister, calling for a levee en masse under which every locality has been encouraged to arm itself, unleashing



weaponized radical groups or plain local warlordism.

The dispute over centralization of political authority in Ethiopia, which spilled over into the war with Tigray, was accompanied by a deliberate and parallel strategy to realign influence in the Horn of Africa.

It is now emerging that the agreement between Isaias Afewerki, the president of Eritrea, and Abiy - for which the latter won a Nobel Peace Prize in 2019 - supplemented by the inclusion of Somalia into a trilateral agreement, was to create a bloc of countries with highly centralized and authoritarian political systems to control the eastern coastline of Africa, from Eritrea to Somalia. In the process, efforts to consolidate cooperative security and development in the region, under the umbrella of the Intergovernmental Authority on Development, were jettisoned, leaving it with new divisions and no institution to manage differences.

Multilateral options, in short, were deliberately abandoned. The Horn of Africa thus hovers over how the fate of this political axis will be managed in an institutional vacuum. Djibouti is caught between the contending politics of Ethiopia, Eritrea and Somalia. In Sudan the move to overthrow the experiment in political reform in favour of the military is colliding with sustained popular resistance. South Sudan is prey to its own post-independence demons. Kenya is fighting to inoculate its open economy and competitive political system from the infection of a region where the centre - usually Ethiopia no longer holds.

Abiy's war on Tigray has turned into the potential dissolution of Ethiopia. Nothing is permanent, not least in a region which has recognized two secessions and lives with another in Somaliland.

The current successor of the Ethiopian empire may collapse. Eritrea's lethally eccentric regime cannot last forever. But Ethiopia's vast population, whether living in a united country or as separate entities, will inevitably seek access to the sea.

For many years, Ethiopian hegemony in the region allowed for the containment of crises. Ethiopian troops served in peacekeeping operations and in AMISOM, the African Union Mission in Somalia. Ethiopia and Kenya had an understanding that dated back half a century. Ethiopia's relations with Sudan were balanced by a Faustian bargain between Omar al-Bashir's Islamists and the regime controlled by the Tigray People's Liberation Front in Addis Ababa. Eritrea's bizarre isolation could gradually have ended with the rapprochement with Abiy.

All these assumptions have now been shattered. Ethiopia must struggle to avoid dissolution. Eritrea's authoritarian vision of order in the region will be replaced by that of the political victors in Addis and their vision of Ethiopia's relations with its neighbours and the wider world.

Thus, a new transition beckons for Ethiopia. But this time, it must encompass the whole region which will have been so damaged by the events of the past few years.

The international community will have to consider how this transition is not hijacked again and under what conditions it can be sustained financially to give populations the belief that peace does not degenerate again into war and regional insecurity.

Mohamed Husein Ahmed Abdulla Sumar completed his primary education at Mingoyo and then went to the Indian Public School in Lindi. One of Mohamed's early school mates were Mohamed Gulamhussein Pardhan who later became a lawyer and returned to practise in Lindi in partnership with Yusuf Lilani.

After completing high school, Mohamed desired to go to United Kingdom to study law but his father did not have the means. Mohamed took a loan of 4000 shillings and went to study at the Royal College, Nairobi (later Nairobi University, a college of the East African University). Amid stiff competition, he qualified to study and graduated as an architect in 1963 and after getting his professional license, joined the British firm of French & Hastings in Dar es Salaam, the capital of the newly independent Tanzania.

In April 1970, he opened his own architect firm called "Sumar, Varma & Associates" which he ran continuously until his retirement in 2017.

In the 54 years of his professional life, Mohamed's firm successfully completed some 800 projects including commercial, industrial (paper-mills), educational (university campus, schools and hostels), residential (diplomatic missions) properties. In fact, the largest tower in the country at that time, a 26 storey building now called Benjamin Mkapa Towers was designed by his firm.

During this period, Mohamed Sumar has been an exemplary citizen of the country of his birth. ## State property....divested or privatised......is it still a problem?

AMBO for the coming week, which finds me trawling through old columns, which might be worthy of a re-check to browse through, but if you 'browsers' aren't interested....turn on your and tune in to the football instead!

Well, three years ago, readers could well have been asked, how they felt about the government taking back some of the sold off state assets, having already started the process with a group of formerly privatised hotels.

By using the term "sold off", I'm showing my bias, as this somehow sounds more dubious, than merely 'being sold', though I could be justified, as much of the privatisation programme often seemed inept at its best, or bogus at its worst.

Towards the end of 1998, Tanzanian government leaders were voluntarily giving details of their assets, with the public arena set for a collective display of honesty and moral probity.

....but this was in contrast with some of those in charge of valuable state properties, who under the divestiture programme were greedily hiving them off at give-away prices, as they pocketed the reward from the grateful buyers....definitely lacking in morals and

I interviewed someone then, who'd just bought a small tile-making plant, and said this expensive machinery had stood outside for many years. Shockingly, it was imported from Germany at huge cost by a state-owned company in Tanzania, but then literally, left to rot without ever being used.

.....Whether this particular case of neglect was by design or default, we don't know, but both should have qualified as "economic sabotage".

The tile plant buyer said it was disturbing to realise the lost opportunities and revenue it presented for the nation, and had learnt it was one of many such on-going examples.

With the coming celebration of 60 years of independence, it must have been questioned by the public, but at what point did all that idealistic patriotism in the beginninging....turn into a sort of Tanzanian wild west, with those in a position to profit like some in the divesture programme doing so .....big time.... and as I've often written before...they didn't even need a horse...or a gun!

I'm only commenting on this now because if there's ever a new state "take back", it might be useful to remember what happened at the original sell out....and maybe something can be learned from it.

The Parastatal Sector Reform Commission was formed in 1992, to supervise the privatisation of gov-

ernment-owned enterprises, many of which had been when then Vice President the late Dr Omar Ali Juma underperforming.

A notable reminder of this came at the end of 1998 that the "VP's follow-up will go beyond Kiltex, and

was touring Arusha region to see the ravaged skeleton of the Kilimanjaro Textile Corporation.

A leading newspaper at the time wrote..."We hope

though true that many properties don't have buyers for them, we suspect there's another story regarding the diverstiture, that the public don't know about, like investors being asked for kickbacks as a condition to win tenders.

Standard stuff for Tanzania perhaps, but since these 'tricks' could have been expected. Rigid checks and balances should have been at the very core of the commission. Though there are a few effective ways to deter economic crimes, including exposure of the misdeeds via the Controller and Auditor General's reports.

Notwithstanding the progress made since independence, looking back, the divestiture exercise appeared to be a time in the nation's history of frantic pillage, as like mice on a sinking ship, 'the foragers' sought to escape with something to show for their time on it!

We can gain some insight from a story in the media at the time, of a parastatal for sale, in which one firm was the successful bidder.

Though soon after winning the tender and agreeing to the conditions and payment, they asked for a reduction on the agreed price, and received

By a coincidence, one of the directors was related to the PSRC chairman, who intervened with fellow officials, and objected to this flouting of normal procedures.

This is an illuminating tale, and if correct, gives a possible explanation into some of the delays surrounding quite straitforward and simple sales.

Anyway, I don't know when the PRSC was terminated, or what it cost the nation, but I wrote some years ago that under the lunatic exercise of the National Bank of Commerce paying a foreign debt collection agency more than they'd collected in debts... so we hope that the Commissions' operation didn't cost more than it ever netted...... and in "shutting down the shop"...... we hope they didn't even need that horse....or a gun......or did they?

## REA's journey towards lighting up rural areas

IN 2007, when the government moved in and established the Rural Energy Agency (REA) no one could believe that 69.6 percent of rural mainland Tanzania would have access to electricity by 2020.

This exceeded the 50 per cent target that the state-run agency had planned. When REA started its journey 14 years ago, there were only 2 per cent of rural homes connected to the national grid.

Being an autonomous body under the ministry of Energy, REA's main role is to promote and facilitate improved access to energy in rural areas on the Tanzania mainland.

Presenting a report on the establishment of Rural Energy Agency, responsibilities and achievements in Dar es Salaam recently, REA director general Hassan Saidy said: "We're determined to ensure that all the remaining 3,800 villages will be connected to electricity supply under the ongoing REA-III Phase II project by December next year."

The project initiated in 2007 through the Rural Energy Act No 8 of 2005 has so far seen over 60 per cent of villages having access to electricity.

He said: "So far 750,000 households had been connected to electricity by end of June this year, up from 716,847 connected by June last year, underlining that the government is well prepared to pursue the exercise, covering all areas and households, to stimulate individual incomes and development generally."

The implementation of the REA project has seen the country increasing access to power to 69.6 per cent of villages in June 2020, up from two percent when the project started in 2007. So, all the remaining villages are covered with the ongoing phase, he stated.

In the intervening period, electronic device manufacturing industries in the country have increased from four to 39, thus providing employment opportunities to youth

and women, he said.

According to him, the agency had up to June last year installed 13,700 transformers, connected 35,253.43 kilometers of low voltage lines, another 38,296.56 kilometers of medium voltage lines thus connecting 716, 847 consumers at a budget of 2.66trn/-, he elaborated.

Several small energy access projects have been implemented to support the main REA projects, like the generation of power from stand-alone solar PV (photovoltaic) systems and from biomass (plants, wood and waste).

About 21 such projects were implemented, with 13 be-

ing mini-hydro projects, seven wielding solar energy and a biomass system in Mafia Island.

The agency also facilitated the installation of 725 biogas plants in different rural areas in the country, as well as installing electricity systems to 831 civil servants households in the education and health sector in Shinyanga, Kigoma, Kagera, Coast, Lindi, Mtwara, Ruvuma and Tabora.

The outcome is improved social services in health, education and business in rural areas.

With such improvements, 7,735 education institutions have been connected to electricity, along with 19,667 en

tities doing business, 3,400 water pumping machines and 4,002 health facilities in rural habitats.

Saidy said through the agency the government was able to supply electricity to all districts headquarters in the

According to REA, the agency plans to give electricity access to 75 per cent of rural Tanzania by 2025 and achieve a fully coverage come 2030.

The REA boss said: "We'd continue to cooperate with financial institution to finance more power projects in rural areas. These projects need big funding and its success also depends on good government support, and that of development partners and donors."

Moreover, he stated there are still challenges that limits some of the rural to yet get access of electricity include poor infrastructures, lack of awareness and some unable to buy some of the connecting supplies due to income restrictions. Energy ministry assistant commissioner for electricity development, Styden Rwebangila, said that in line with promoting clean energy through the project, a 50MW of geothermal project has been approved, while investors are expected to develop geothermal, wind and solar power projects of 145MW total capacity.

The REA project started with first connecting village centers by supplying key infrastructures, followed by connecting households. The demand is higher than what was planned for some regions where a big number of people show interest in being connected, he said.

The ministry is going on with sensitizing campaigns in villages where power supply has reached as some residents don't show interest in being connected, he stated.

The Rural Energy Master Plan being finalised will enable 75 percent access to electricity by 2025 and 100 per cent access by 2030, the commissioner added.

#### Scaling up technology and innovation to lift the economy of small producers

ONE of the responsibilities of Science Granting Councils (SGC) is to promote social and economic development of small producers through application of science technology and innovation. The Councils are thus central to funding and catalyzing research and innovation in order to further application of technology and innovation. It's an increasingly important role of these councils in national science systems in African countries.

However, SGCs face various challenges including limited capacity and inadequate funding, hence the establishment of the Science Granting Councils Initiative in sub-Saharan Africa (SGCI) which aims to strengthen the capacities of science granting councils to support research and evidence-based policies that contribute to economic and social development and establish partnerships among councils and with other science system stakeholders.

Implementation of SGCI programme thus creates partnerships and networks between the Councils as well as among the programmes beneficiaries. This relationship is vital in promoting science, technology and innovation among the general public in a bid to accelerate social and economic development.

Tanzania's Science Granting Council, the Tanzania Commission for Science and Technology, is participating in the programme which is now in its second phase. "We have participated in this

programme since 2015 and in due course we have acquired new partners. The number of institutions we support has grown from two in 2015 (MUHAS and UDSM) to include University of Dodoma (UDOM), Sokoine University of Agriculture (SUA) and Tanzania Engineering and Manufacturing Organisation(TEMDO), among others," explains Ms. Neema Tindamanyire, Coordinator of the SGCI programme in Tanzania. She says that the new partnerships and networks provide a forum for sharing new knowledge and experiences. "The ongoing gender at work programmenamely Research Excellence and Gender Equality and Inclusivityhas also brought up a new taste to our staff who are participating in this two year coaching program. We are also conducting researchwith support from International Development Research Centre (IDRC) which has also helped to bring in private sector partners to work with our researchers," she

One of the partners of the second phase SGCI programme is TEMDO who is conducting research in the use of simple technology to refine

sunflower oil. The research which is conducted in Singida, Dodoma, Manyara and Arusha regions aims to enable small-scale producers of sunflower oil earn more money from sale of the edible oil by value addition through use of simple and affordable technology. "Currently a small-scale producer of sunflower oil sells one litre of unrefined oil for 5,000/- or less. Our partnership with COSTECH has enabled us to come up with simple technology that would enable farmers to sell a litre of oil at between 6,000/- and 10,000/-," explains Eng. Honest Lyaruu who is the Principal Investigator of the project. He adds that currently available machines in the market for refining sunflower oil are too expensive for small producers to afford. "Machines that are available in the market sell at about 500m/-, these are meant for large producers and small producers cannot afford them. Our research has designed two types of machines: one that has capacity to refine 800 litres of oil and another has capacity to refine 1,000litres of oil," says the Engineer, adding that machines sell at 17m/- and 36m/- respectively.

Tanzania is the second biggest produce r of sunflower seeds in Africa and stands sixth in the world. "But we have not been able to fully exploit our potential because most of our product is crude oil. This research therefore seeks to enable small farmers exploit the sunflower market through value addition and thereby raise their incomes in a bid to lift themselves out of poverty," explains Eng. Lvaruu.

According to UNIDO, Dodoma region is a major producer of sunflower oil, accounting for over 20 per cent of national production. "About half of the region's farmers are engaged in sunflower oil production, but few small-scale producers have realized the full potential of this sector, either in terms of improved quality or higher volumes. Among the factors contributing to low productivity and quality are inadequate machinery and limited or no access to value-added services and markets," reads part of a publication by the UN Agency.

Besides COSTECH, implementation of the sunflower oil projectthrough SGCI has created new partners. UNIDO is one of the partners that have contributed to the sunflower refining project.

"They have provided us with some equipment and also trained us in designing the refining process. We cooperate with them in many other aspects," says Engineer Lyaruu.

The project also works closely with sunflower farmers, sunflower oil producers as well as large-scale producers of sunflower oil and buyers of sunflower seeds. Since

the aim is to add value to edible oil produced by small farmers, other stakeholders in the sunflower oil value chain have also a contribution

"Basically it is about simple technology to enable small-scale oil producers add value to their product, yet this is not an isolated issue. Quality seeds, abundant harvest of sunflower seeds, transportation and proper storage of seeds before they are processed, all these finally add up Some small producers of oil are not farmers or to what has to be refined and the quality of the product," explains Engineer Lyaruu.

Improved oil production means there should be an abundant and reliable supply of seeds to enable the machines to operate as required. "That is why we also work with farmers to encourage them to increase production of quality seeds so that they too can raise their income.

don't produce enough to meet their requirements so their operations depend on sustainable supply from farmers," says Eng. Lyaruu.

This project therefore rhymes well with the objectives of SGCI programme; that of improving research management in order to catalyze social and economic development in countries where the programme is implemented.

## Stop censorship: Zambia's 'New Dawn' should extend to digital rights and freedom of online expression

N his inauguration speech on 24 August 2021, President Hakainde Hichilema declared a "new dawn" for Zambia. It is critical that this transformation extends to the internet sphere.

Digital rights in Zambia suffered under former president Edgar Lungu, as documented in recent research from Freedom House and Paradigm Initiative. Zambians saw this at play during the August general elections: reports spread weeks ahead of polling day that then president Lungu would cut off the internet as voting took place.

Zambian and international civil society mobilised in response, prompting the government to deny the reports. Then, on election day, WhatsApp, Facebook, Twitter and Messenger were blocked on most networks, apparently on the order of the Zambia Information and Communications Technology Authority (ZICTA). The restrictions cut off discussion about voting and day-to-day conversation alike. Access was restored only after Chapter One Foundation, a Zambian human rights organisation, sued ZICTA.

To reverse the decline in Zambia's internet freedom, President Hichilema should ensure open access to the internet, reject a trend toward prosecutions for online speech and protect Zambians' personal data.

A commitment to respecting online expression and privacy would ensure that the internet continues to serve as a tool for civic engagement and as an enabler of democracy in Zambia.

#### Ensuring access and protecting free speech

First, Hichelema and the newly created Ministry of Technology and Science should signal a break with the previous administration by announc-

ing a commitment to ensuring access to the internet and social media.

In previous years, network disruptions were reported in strongholds of Hichilema's United Party for National Development in times of political sensitivity. Such blunt censorship interrupts everything from everyday communication to digital financial transactions to online learning.

A commitment from Hichilema to refrain from ordering internet shutdowns and social media blocks would be a powerful testimony to his government's change in approach.

The new administration should further safeguard the right of Zambians to express themselves without fear of repercussions. Under the former president, Zambians risked arrest for speech on social media deemed insulting to Lungu. Take, for instance, Facebook user Enockson Banda, who was sentenced to two years' imprisonment in March 2019 for deriding Lungu on the platform.

When people can be arrested or fined for their posts online, they may begin to censor themselves. But unfettered speech – even when rancorous - is critical to maintaining a vibrant democracy. Hichilema's government should refrain from prosecuting such dissent, and direct law enforcement agents must avoid wrongfully arresting Zambians for speaking out on social

Worryingly, in March 2021, the Lungu government dramatically reshaped its approach to online content, with concerning implications for online speech.

The Cyber Security and Cyber Crimes Act bars the production and distribution of content "tending to corrupt morals". It also criminalises the use of electronic communications to "coerce, intimidate, harass or cause emotional distress to a person", without defining those terms. Such broad, vague language is ripe for abuse by powerful people seeking to suppress online criticism.

Some of these provisions carry hefty penalties of up to five years' imprisonment. Speculation about the Cyber Security Act's enforcement has further driven self-censorship among Zambi-

While users must remain on guard against misinformation and propaganda, the internet facilitates the spread of necessary and reliable information, particularly from journalists, bloggers and social media users reporting on key events.

#### Protecting user data

Finally, the new government should protect the privacy of Zambians.

The Data Protection Act 2021 establishes landmark safeguards for personal data in the country. Without the resources for implementation and enforcement, however, the law will do little to safeguard Zambians' personal

information from private companies and bad actors, nor will it promote the country's aspirations of a transformed digital economy.

Hichilema's administration should ensure the timely establishment of a Data Protection Commission, with an independent and competent commissioner to spearhead and enforce Zambia's personal data protection agenda. Hichilema should, moreover, hold his own government to the same standards to which he holds private compa-

The Cyber Security Act expands the scope of how the government can monitor the communication of Zambians, while the Data Protection Act offers problematic exceptions to safeguards for personal data in criminal investigations.

Zambia's law enforcement should only seek access to personal data when it is essential to the investigation at hand, explicitly provided for under Zambian law and subject to judicial oversight.

Personal data and communications information can be exploited by companies and governments alike to expose the intimate details of peoples' lives, from their involvement in social movements to their personal beliefs and professional pursuits. At-risk communities like political dissidents, human rights defenders, civil society actors, whistle-blowers and journalists are particularly vulnerable to such monitoring.

By protecting Zambians' privacy, the new president can affirm his commitment to human rights.

During the August elections, Zambians acted to protect internet freedom. Now, President Hichilema must act to safeguard Zambians' digital rights for the future.

## Rogue matatus in city roundabouts put on notice

Public service vehicles (PSVs), which have turned roundabouts in Nairobi into termini, lay-bays and parking areas, have been put on no-

Members of the County Assembly (MCAs) have approved a motion calling on City Hall and the Nairobi Metropolitan Services (NMS) to clampdown on such matatus. The motion by Komarock MCA John Kamau wants the rogue matatu operators who illegally use the roundabouts to be pun-

Mr Kamau decried the persistent use of roundabouts by PSVs as termini which causes heavy tailbacks of traffic on key roads such as the Outer Ring Road leading to loss of productive time and value for public money and investments.

He pointed out that the Nairobi City yoike added: "If you happen to pass

County Traffic Act 2020 prohibits matatus from picking and dropping passengers at undesignated bus stops with the Act further prohibiting persons from parking on public roads in a manner that impedes traffic flow.

"The County Executive and NMS should issue a public notice prohibiting public transport from using roundabouts as termini, lay-bays and parking areas with punitive measures against operators who defy the order." said Mr Kamau.

Minority Whip Peter Imwatok cited Outer Ring Road and Globe Cinema roundabouts which have been turned into parking termini creating snarlups on Nairobi roads. "If you go to Outer Ring Road you will find that the bus terminus operators or the brokers are the ones manning these termini," said the Makongeni MCA.

## Barrick, Novagold agree on next steps towards advancement of Donlin Gold

Donlin Gold LLC which is owned 50/50 by Barrick Gold Corporation and Novagold Resources Inc. has reported on progress made during the executive management workshop and site visit in early September between senior representatives from the two companies accompanied by Donlin Gold management

Additional assay results for 18 completed drill holes, plus partial results for 22 holes from the 2021 drill program indicated that during the September 2021 executive management meetings in Alaska, the combined team reaffirmed its confidence in the deposit and charted a course toward advancing the project up the value chain.

partners are well positioned to be able to proceed with a feasibility study update in 2022. The release noted that this year's drill program delivered consistent results.

"The 2021 drill program was completed in September with 79 holes drilled for a total of 24,264 meters. To date, Donlin Gold has reported assays for 36 complete holes and 22 partial holes, encompassing 15,700 meters of length drilled," the statement said.

The last core was logged in mid-October with final samples sent off site to laboratories for further processing. # Thw world's biggest ever soybean crop gets bigger, keeping a lid on prices

There are fresh signs the world's largest ever soybean crop is getting even bigger, driving down global prices. Brazil has seen nearly ideal weather for growing the oilseed, with abundant rains during planting season followed by plenty of sunshine in key regions like Mato Grosso.

As the harvest approaches, local prices are sliding, pointing to expectations of a bumper haul. Private consulting companies are now raising the country's output to 145 million metric tons, a world record.


The gigantic harvest could help to alleviate some of the inflation that has global food prices at the highest in years. "Of course the weather in December will be key," Marcelo Lacerda, head sales trader for HedgePoint in Brazil. "But I see a good crop coming out of

Supplies are still leftover from the previous season, which is

weighing on the market and helping to make Brazil's products cheaper than its main competitor, the U.S. Prices are so low that farmers are withholding sales, hoping that better deals will come up in January. That's driven down overseas shipments. A standard 60-kilogram bag of soybeans plunged about 10% over the last two weeks.

There's still room for rallies. There's drought in the southern state of Rio Grande do Sul and in Argentina. La Nina weather patterns, currently in play, are a wild card. Any such shifts could impact yields, according to Lacerda.

Buyers of soybeans including local industries like chicken farms are also at the sidelines. They're waiting for the harvest to start, when supplies will really mount and drive down prices even lower. Brazilian corn, known as safrinha, is also benefiting from the favourable weather, and output is expected to reach all-time highs.

# Virus: Britain tightens testing for inbound travelers

**LONDON** 

BRITAIN will require all inbound travelers to take a pre-departure COV-ID-19 test and arrivals from Nigeria will have to quarantine in hotels to slow the spread of the Omicron variant, health minister Sajid Javid said on Saturday.

Prime Minister Boris Johnson has said that travel restrictions are necessary to slow the spread of Omicron while scientists work to understand more about the transmissibility and implications for vaccine effectiveness of the variant.

The UK Health Security Agency said a stating blow" for the industry, while

The pre-departure testing requirement will mean that, from 0400 GMT on Tuesday, all inbound travelers must take a either a PCR or a rapid lateral flow test a maximum of 48 hours before departure.

## Omicron mutations signal vaccine evasion, same symptoms

As fears of another global surge of COVID-19 cases send jitters through global markets, spur a new round of travel bans and cause Americans to rethink their holiday plans, scientists studying the Omicron variant are getting the first hints of what's in store for the months to come.

The new variant's mutations suggest that it is likely to evade the protections of vaccines to at least some extent, but that it is unlikely to cause more severe illness than previous versions of the coronavirus.

These early hypothesis appear in line with real-world observations from places like South Africa, where infections have included the vaccinated and previously ill but appear so far largely mild. That data, however, is thus far extremely limited, so much current evidence has come from computer modeling and comparing Omicron's physical structure to past variants.

twice the number of mutations as the delta variant, with the bulk found in the spike, the crownlike protein on the surface of the virus that vaccines train our bodies to attack. The appear-

ance of such a highly mutated virus nearly two years into the pandemic caught the scientific community by surprise, as many had hypothesized that the ultracontagious delta variant might mark the last major wave, peaking and then eventually burning out, much like the 1918 influenza pandemic.

It will take scientists weeks of careful laboratory testing and study to untangle exactly what Omicron's mutations mean, and definitively nail down details about how much more contagious it is and what the implications are for those who get infected. But early observations have already allowed scientists to make some informed guesses about what's to come.

The location of Omicron's mutations suggest two things. The first is that the virus is likely to evade vaccines to some extent. Some of the spike mutations are in the same locations seen in other variants that spread quickly. In past variants those mutations A lot remains a mystery about have led to what's known as anomicron, which has more than tibody escape, in which the virus is able to evade the attack of antibodies generated by vaccines or a previous COVID-19 infection.

The second insight is that it be impervious to the body's to help confirm this suspicion. have been seen before in previ-

second line of defense, T-cells. They work hand-in-hand with antibodies to ward off infection and the development of disease. If a virus manages to escape the attacks of antibodies, T-cells then get to work killing infected cells.

"Many of the mutations occur in the hotspots on the spike protein, which we know are important for antibodies to bind," said Wendy Burgers, an immunologist at the University of Cape Town. "What we predict is that a lot of the T-cell response will still be active against Omicron."

Her lab is awaiting samples from omicron-infected patients and spike-protein based on But early computer analysis has backed up the theory.

Antibodies have narrow targets of attack on the spike protein, aiming for just two specific regions known as the receptor binding domain and the N-terminal domain. That means that a handful of mutations in those regions can significantly impact

the ability of antibodies to attack. T-cells, on the other hand, target the entire spike. A handful of changes are less likely to impact their effectiveness.

"What we need to confirm with our lab experiments is how much is the T-cell response affected?" she said. While some of appears likely omicron won't omicron to begin experiments Omicron's dozens of mutations

ous variants, many are completely novel. That means more time and data will be necessary to fully understand the full impact of omicron with any certainty.

At Rockefeller University in New York, Theodora Hatziioannou's lab has spent the past year experimenting with a non-dangerous, synthetic version of the virus to see what might happen were there significant numbers of mutations to the COVID-19 spike protein, many in the same locations as Omicron.

"We can be quite confident that this new spike is going to be rather resistant to neutralization by antibodies," she said. "I am hoping that this omicron spike will not escape every single response of our immune system and that the vaccines will still afford some protection from severe disease."

In the long term, what these mutations highlight is that predictions about the pandemic are

hard to make. Charles Chiu, a microbiologist at University of California, San Francisco whose lab sequenced the first-known US case of Omicron, said that he was in the camp of scientists that suspected the delta variant was the beginning of the end of the pandemic.

#### THE parents of a Michigan teenager accused of murdering four fellow high school students were taken into custody on Saturday, a day after each was

charged with four counts of involuntary manslaughter in connection with the campus mass Authorities began searching for James and Jennifer Crumbley after Oakland County prosecu-

tors announced the charges on Friday, saying the Crumbleys bought the gun for their son as a Christmas present and then ignored warning signs that may have presaged such a massacre.

Detroit police said in the early hours of Saturday that they had taken the couple into custody.

The police found the two at what "looked like a residential building," Detroit police spokesman Rudy Harper said.

#### Parents of suspected Michigan school shooter arrested

"We arrested them," Harper said when asked if the parents turned themselves in.

The couple's 15-year-old son, Ethan Crumbley, is being held without bail and has been charged as adult on suspicion of carrying out the deadliest US school shooting of 2021 on Tuesday at Oxford High School, about 40 miles (60 km) north of Detroit.

Crumbley's parents were expected to appear for a Friday afternoon arraignment but stopped responding to calls from their attorneys, according to Oakland County Undersheriff Mike Mc-Cabe, prompting a search by the Sheriff's Fugitive Apprehension Team.

After they failed to appear, the US Marshals Service said it had taken on the case and was joining Oakland County officials in the search.

"The action of fleeing and ignoring their attorney certainly adds weight to the charges," Oakland County Sheriff Michael Bouchard said in a statement on Friday. "They cannot run from their part in this tragedy."

Even so, lawyers for the parents issued a state-

ment on Friday saying they intended to return for their arraignment.

"They are not fleeing from law enforcement," attorneys Shannon Smith and Mariell Lehman said.

#### **Gun Purchase**

Four days before the shooting, Ethan accompanied his father to a gun shop, where James Crumbley bought a 9mm handgun, prosecutors

Ethan posted photos of the gun on social media, writing, "Just got my new beauty today." The next day his mother posted that the two of them were "testing out his new Christmas present," Oakland County Prosecutor Karen McDonald

McDonald detailed a number of other warning signs that she said the parents failed to act on. On Nov 21, a teacher found Ethan Crumbley searching for ammunition on his phone. His mother later texted him, "LOL, I'm not mad at vou. You have to learn not to get caught."

On the morning of the shooting, a teacher discovered drawings by Ethan Crumbley that depicted a handgun, a bullet, and a bleeding figure next to the words "Blood everywhere," "My life is useless," and "The thoughts won't stop - help me."

School officials summoned the Crumbleys and instructed them to get Ethan into counseling within 48 hours, McDonald said. The parents "resisted" the idea of taking their son home from school and did not search his backpack nor ask him about the gun, she said.

After the Crumbleys left the meeting without their son, Ethan Crumbley was returned to class and later walked out of a bathroom with the gun, killing four students and injuring seven other people, authorities said.

## Russia bashes new Western sanctions against Belarus - foreign ministry

**MOSCOW** 

MOSCOW firmly denounces the new sanctions imposed by the United States, the European Union, the United Kingdom and Canada on Belarus on December 2. and believes that those restrictions are illegitimate, Russian Foreign Ministry Spokeswoman Maria



Zakharova said in a statement posted on the Russian Foreign Ministry's website on Saturday.

"We strongly condemn the new restrictive measures against Belarus, which were synchronously approved on December 2 by the United States, the European Union, the United Kingdom, and Canada. These sanctions are illegitimate, like any other restrictions imposed in circumvention of the United Nations Security Council. They are inhumane due to their negative impact on the lives of ordinary citizens of Belarus," the statement said.

Zakharova added that the West's sanctions against Belarus have "a clear political connotation and are another example of interference in the internal affairs of a sovereign state."

'Their authors do not conceal that they intentionally deliver blows to the backbone of the Belarusian economy," the diplomat said. "They obviously aim at its collapse and at reducing the Belarusians' living standards, thus attempting to set preconditions for another 'color revolution'.'

#### **Payback for migrants**

Zakharova pointed out that the option for sanctions was "extremely cynical."

"The Western countries are trying to use it in order to punish Belarus for the migrant crisis, which was caused by their own policy of 'democracy export' to the Middle East and North Africa," she explained. 'That neocolonial policy destabilized and shattered the sovereignty, statehood, civilizational foundations and socio-economic patterns of regional nations, and resulted in a mass exodus of migrants and mounting cross-border threats."

According to the Russian Foreign Ministry spokeswoman, the hypocrisy of the sanctions is becoming more and more evident against the backdrop of continuing gross violations of human rights and refugee rights by Western countries.

"Poland and Lithuania perfidiously refuse to comply with international obligations by denying entry to asylum seekers. The incidents of brutal treatment towards migrants by Polish and Lithuanian border guards and service members have been documented by relevant bodies of the United Nations, the Council of Europe and the European Border and Coast Guard Agency Frontex," the diplomat said.

She pointed out that even in these conditions, the Belarusian counterparts, on the contrary, "in spite of illegal sanctions and sweeping accusations, show a humane attitude to the refugees on their territory."

"We expect that international agencies will take the necessarv measures to exert their influence on Warsaw and Vilnius to make them stop mistreating migrants," Zakharova stressed.

#### **Solutions**

The Russian Foreign Ministry spokesperson recalled that the history of previous migration crises proves that their solutions "can be found only through close cooperation between the countries of origin, transit and destination of migrants."

"We call on the Western states to abandon double standards and the policy of illegitimate sanctions, but to demonstrate a civilized approach and proceed with the practical settlement of the migrant crisis in cooperation with the authorities of the Republic of Belarus," the diplomat

The European Union enforced the fifth package of anti-Belarusian sanctions on December 2. The sanctions cover 17 individuals and 11 organizations. The US Department of the Treasury also imposed restrictions on Belarus' public debt securities and banned operations with the country's new promissory notes with a maturity of more than 90 days issued after December 2.

Apart from that, 20 individuals, 12 legal entities and three aircraft were backlisted in connection with the migration crisis and in the light of allegations about the clampdown on civil freedoms. The United Kingdom and Canada also announced extra sanctions against Belarus.

Meanwhile, Belarusian Foreign Minister Vladimir Makei said at a meeting of the OSCE top diplomats that his country was being punished with sanctions because it had highlighted "the dark side of European democracy."

## Putin and Biden to hold online meeting on Ukraine

**WASHINGTON/MOSCOW** 

US President Joe Biden and Russian President Vladimir Putin will hold a video call tomorrow, with the two leaders set to discuss the tense situation in Ukraine.

"Biden will underscore US concerns with Russian military activities on the border with Ukraine and reaffirm the United States' support for the sovereignty and territorial integrity of Ukraine," White House spokesperson Jen Psaki said in a statement.

She said other topics would include "strategic stability, cyber and regional issues."

The two will also talk about bilateral ties and the implementation of agreements reached at their Geneva

summit in June, the Kremlin said on Saturday.

"The conversation will indeed take place on Tuesday,"
Kremlin spokesman Dmitry Peskov told Reuters. "Bilateral relations, of course Ukraine and the realization of the agreements reached in Geneva are the main (items) on the agenda," he said.

The exact timing of the call was not disclosed.

More than 94,000 Russian troops are believed to be massed near Ukraine's borders. Ukraine Defense Minister Oleksii Reznikov said on Friday that Moscow may be planning a large-scale military offensive at the end of January, citing intelligence reports. US officials have come to similar conclusions, they said.

Biden, meanwhile, has rejected Russian demands for security guarantees in the region.

"My expectation is we're going to have a long discussion with Putin," Biden told reporters on Friday as he departed for a weekend trip to Camp David. "I don't accept anybody's red lines," he said.

The US president said he and his advisers were preparing a comprehensive set of initiatives aimed at deterring Putin from an invasion. He did not give further details, but the administration has discussed partnering with European allies to impose more sanctions on Russia.

US Defense Secretary Lloyd Austin separately said that Washington was committed to ensuring that Ukraine had what it needed to protect its territory.

Austin added that there was a lot of space for diplomacy and leadership to work on Ukraine.

At the same conference, James C McConville, chief of staff of the US Army, on Saturday referred to estimates of 95,000 to 100,000 Russian troops on the border with Ukraine.

"I don't know what they are going to do, but I am very, very concerned," McConville said.

Moscow accuses Kyiv of pursuing its own military build-up. It has dismissed as inflammatory suggestions that it is preparing for an attack on its southern neighbor and has defended its right to deploy troops on its own territory as it sees fit.

US officials say they do not know yet what Putin's intentions are, including whether Putin has made a decision to invade Ukraine.

US-Russia relations have been deteriorating for years, notably with Russia's 2014 annexation of Crimea from Ukraine, its 2015 intervention in Syria and US intelligence charges of meddling in the 2016 election won by now-former President Donald Trump.

But they have become more volatile in recent months.

The Biden administration has asked Moscow to crack down on ransomware and cyber-crime attacks emanating from Russian soil, and in November charged a Ukraine national and a Russian in one of the worst ransomware attacks against American targets.

Russia has repeatedly denied carrying out or tolerating cyber-attacks.

The two leaders have had one face-to-face meeting since Biden took office in January, sitting down for talks in Geneva in June. They last talked by phone on July 9. Biden relishes direct talks with world leaders, seeing them as a way to lower tensions.

US Secretary of State Antony Blinken warned Russian Foreign Minister Sergei Lavrov in Stockholm earlier this week that the United States and its European allies would impose "severe costs and consequences on Russia if it takes further aggressive action against Ukraine."

"Somali Army's commandos, Danab destroyed al-Shabab hideouts and killed several terrorists in a planned security operation near Leego village in Lower Shabelle region on Saturday," the state-owned radio reported

The SNA commanders said the Danab forces stormed the Leego village and destroyed the terrorist cells that had made life difficult for the region's farmers and livestock traders.

### Industrial heritage in China gains new vigor

SHOUGANG Park, the century-old former production premises of Chinese steelmaker Shougang Group in Shijingshan district of Beijing, is now a famous cultural and sports complex that enjoys increasing popularity.

Many tourists have been attracted to the special park, which has crisscross footpaths and ingenious landscape designs, and more importantly, a magnificent newly-built large ski-jumping platform, one of the venues for the Beijing 2022 Olympic and Paralympic Winter Games.

The raw material area of the old plant has been transformed into the work site of the Beijing Organising Committee for the 2022 Olympic and Paralympic Winter Games, while the past clean coal workshops have become the training field of China's national ice and snow sports teams.

Besides the old production premises of Shougang Group, many other old industrial sites, including factories, mines, and industrial areas, have gradually fallen into decay and become industrial heritage with the passing of time

Since industrial heritage mirrors the history of technology and industry and is of important social, architectural, and scientific value, many Chinese cities are looking for the right way to deal with it so as to revitalize industrial relics, inject new vitality into them, and enable them to generate new value.

Some people didn't understand the value of industrial heritage, and even regarded industrial remains as a burden to the rapid development of cities. Some industrial remains have been pulled down to make room for highrise buildings, and some were left to go to waste and decay.

In fact, industrial relics scattered in various parts of the country are like a book on the history of Chinese manufacturing.

As witnesses to the country's industrialization process and economic structural transformation, factories and workshops, which used to be filled with rumble of busy machines, are precious pages of the book on the industrial culture of China, and refresh people's memories of the development of Chinese manufacturing.

As industrial heritage is rich and diverse in content, it is necessary to explore distinctive development paths and models to protect and utilize it,

instead of adopting an identical approach. In recent years, some cities in China have carried out pilot projects in this regard, setting different examples that are worth learning

Jingdezhen city in east China's Jiangxi province, which is known as China's porcelain capital, has made good use of old state-owned ceramics factories and created a special zone for cultural and creative industries named Taoxichuan Ceramic Art Revenue. Nearly 15,000 Chinese and foreign makers have been attracted to the place to set up their own business-

es or make innovations.

In Qingdao city, east China's Shandong province, a beer museum has been set up inside the century-old plant of the Tsingtao Brewery Co., Ltd., one of China's largest breweries.

Bringing people closer to the long history of the brewery as well as its technological processes, the museum has emerged as a part of a high-quality experience-oriented tourist route.

Such examples have proven

Such examples have proven that besides the role of production property, old factories and machines can still be useful and their value can be fully unleashed as long as people can accurately highlight and tap into their cultural features.

Nevertheless, revitalization of industrial heritage is not easy. It requires proper handling of the relations between protection and development. During the transformation of the Shougang Park, for instance, in an effort to preserve the original texture of the old blast furnace, engineers specially developed clear lacquer that can not only prevent hot blast stove from continuing to rust, but also preserve its original appearance.

China can learn from the experience of some developed countries in reusing industrial heritage. The key to the successful transformation of Ironbridge Gorge in Shropshire, England, and the Ruhr area in Germany, among others, lies in good design and planning.

Through creative display and industrial upgrading on the premise of overall protection, the UK and Germany have effectively injected new vigor into their industrial heritage.

As the world's largest manufacturer, China has rich industrial resources. As industrial transformation and upgrading speed up across the country, industrial and mining enterprises across the country have shut down or transformed some of their plants, which can be valuable industrial heritage.

Injecting new vitality into industrial heritage through protection, development, and reutilization is not only an inevitable trend of the innovation-driven development of cities, but a necessity for fostering new drivers of development.

## French right picks Paris region chief to challenge Macron

FRANCE'S Republicans nominated their first woman presidential candidate in a primary that sharpened the focus of the challenge facing Emmanuel Macron in next year's election.



Valerie Pecresse won the final round of the conservative's ballot on Saturday after 61 percent of members backed her. Eric Ciotti, a lawmaker from southern France often compared to far-right rival Eric Zemmour, took 39 percent.

By selecting the Paris region leader over Ciotti, the party of General Charles de Gaulle, Jacques Chirac, and Nicolas Sarkozy opted against joining the crowded battle for the extremist vote and instead chose a candidate who can compete with Macron for moderate voters.

Pecresse, 54, is wagering that she can reinvigorate the party that was set to reclaim the presidency in 2017 until her predecessor, Francois Fillon, was undermined by a corruption scandal that opened the door to Macron.

"What's striking is that this seemingly old-fashioned right has picked a woman," said Bruno Jeanbart, a pollster at Opinionway. "This will represent a powerful change." An adviser to Macron's government said recently that Pecresse could pose a serious threat to his re-election. The president declined to comment on the ballot during an official visit to Saudi Arabia.

Pecresse said Saturday she would save public services including hospitals, schools and the legal system, defend social justice, reassert the value of work, raise France's global standing and reform Europe.

"Dear friends, the Republican right is back," she said. "The right of convictions, the right of solutions is united."

The latest Ifop poll published Nov 28 showed Pecresse with 10 percent of votes, in fourth place behind Macron on 25 percent. His longtime rival and nationalist leader Marine Le Pen polled 19.5 percent and Zemmour, 15 percent.

Pecresse polled highest among people 65 and older, who tend to be the most frequent voters, as well as right-wing voters


Opinionway's Jeanbart said the way forward for her is to court those who think Macron hasn't done enough on security, immigration and reining in public finances, while also convincing Le Pen's supporters that she has greater chances of winning.

It's what Sarkozy, Pecresse's former mentor, did in 2007.

That year, the Socialists picked Segolene Royal as the first woman to head its presidential ticket. Its 2022 candidate is Paris Mayor Anne Hidalgo. The party dominated French politics along with Republicans until Macron's centrist run.

## Striker Haaland fumes at 'arrogant' ref in Bayern loss

DORTMUND

STRIKER Erling Haaland fumed at referee Felix Zwayer over his decision not to award Borussia Dortmund a penalty in their 3-2 defeat to Bayern Munich in a crucial top-of-the-table clash in the Bundesliga on Saturday.

Dortmund had two claims for a penalty in a match that also saw manager Marco Rose sent off with a second booking for dissent, but referee Zwayer refused both times to review the plays, most notably when winger Marco Reus went down in the box after a tussle with opposing defender Lucas Hernandez.

"I think it was a scandal when it comes to the referee," Haaland told ViaPlay. "I asked him [Zwayer] 'why didn't you just go and look?' He said: 'No, there is no need.'

"I need to calm down a little bit now. He was arrogant, and I will not say more."

However, Bayern were given a break when Robert Lewandowski scored the disputed winner from the spot in the 78th minute, after referee Zwaver awarded the penalty following a VAR check. Zwayer penalized Mats Hummels for handball after Serge Gnabry's corner struck the Dortmund defender's elbow as he appeared to stumble.

Zwayer said he saw Hummels' elbow make contact with the ball, but he was not sure whether the elbow was in or out, so he checked the video footage. He said it was not necessary to check Reus' penalty appeal because he had a clear view of the incident and the video referee watching in Cologne did not contradict his decision.

"I had a very clear and unambiguous impression that was ultimately checked and also confirmed on the monitor in Cologne," Zwayer said.

Dortmund midfielder Emre Can also made his frustrations with the referee clear after the match, saying: "It's a shame that such a crappy penalty decides the game. I'm sorry I have to say that.

"I stand here and talk again about a referee's decision. We played a great game today and then this happens."

Dortmund midfielder Julian Brandt opened the scoring when he found the top right corner of the goal in the fifth minute before Bayern forward Thomas Muller chased down a poor touch from Hummels to set up Lewandowski, who

Bayern winger Kingsley Coman put his side ahead on the stroke of half-time with a deflected shot, but Haaland hit back in the second half to level the scores.

Lewandowski -- who ranked the top striker in ESPN FC 100 -- then scored a spot kick, his 11th league goal in eight games this season.

On the two disputed no-calls for Dortmund in the match, Bayern coach Julian Nagelsman said: "I think we deserved to win but I also understand the discussions over the two penalty situations."

"It's a shame because we had played well in the second half. It's a defeat that hurts, but that's football. Sometimes you win without deserving it, like against Villarreal, but today it was the opposite."

Xavi also confirmed that young midfielder Gavi, who suffered a knock to the head in the first half, has been taken to hospital as a precaution.

## West Ham defeat exposed weaknesses that could harm Chelsea's EPL title challenge

success Chelsea's Premier League title campaign is poised to be decided by how well they can continue their remarkable defensive record under Thomas Tuchel -- and therefore West Ham exposed weaknesses on Saturday afternoon that must be quickly eradicated.

This 3-2 defeat at the London Stadium constitutes the first time this season the Blues had conceded more than once in any competition, and it is only the third occasion since Tuchel took charge 11 months ago. It should trigger a kneejerk reaction now given that, in the German's 53 matches at the helm, they have conceded just 29 goals.

But while Chelsea continue to struggle to find proper attacking fluidity -- and another subdued substitute display from Romelu Lukaku was a reminder of the distance to travel in that aim -- the chances of lasting the pace with Liverpool and Manchester City rely precisely on the efficient, controlled defending which was absent against West Ham.

Troublingly Tuchel, this isn't the first time. Last weekend's 1-1 draw against Manchester United featured an error from Jorginho, which gifted Jadon Sancho his goal. Mean-


