TTB reaffirms 5m tourists goal, 2025

TANZANIA Tourist Board (TTB) management has reaffirmed that it expects tourist arrivals to hit the five million mark

Dr Gladstone Mlay, the agency's acting marketing director, made this assertion at the Kilimanjaro International Airport (KIA) here at the weekend when receiving more than 200 tourists from France.

He said the tourists drive in the French market was part of the government's aim to attain five million tourist arrivals by 2025, alluding to expectations to land one million French tourists by that time.

This compares with 100,370 visitors from that market on the basis of last year's data, he said, noting that with the 160,000 tourists from the US last year, France was next "and what we now want is to make sure this increases, but also obtain more visitors from other nations."

Large numbers of visitors are expected from China, as there are 40 tourist agents from China visiting the country to hold discussions with their local counterparts, he said.

Christine Mwakatobe, the Kilimanjaro Airport Development Co. (KADCO) managing director, said the agency is

Districts to build 64 vocational colleges

THE government has talked of plans to have 64 more institutions of vocational and technical training completed and operational in financial year 2023/2024. They will be in every district across the country.

Dr Adolf Rutayuga, executive secretary for the National Council for Technical and Vocational Education and Training (NACTVET), said this at the annual vocational and technical education exhibition held here at the weekend.

The institution's director of certification, Dr Geoffrey Oleke, said the past two years, upwards of 120,000 to 150,000 students were being registered.

More young people are opting for technical studies, he remarked as new students joining NACTVET institutions start being registered, and set for closure at the end of next month.

Qualified applicants have been advised to send their submissions directly to their colleges of choice, except those registering for special studies. Students opting for health and allied sciences should apply for the programmes online at the central admission system portal, at www.nacte. go.tz., he specified.

Govt uplifts cross-channel cooperation on land issues

THE government has directed the Zanzibar Housing Corporation (ZHC) and its Mainland counterpart, the

National Housing Corporation (NHC) to rapidly enter the implementation stage of a housing development scheme signed between the two agencies.

Dr Angeline Mabula, the Lands, Housing

and Human Settlements Development minister, said at a short signing event in the capital at the weekend that the Memorandum of Understanding (MoU)

HOST government agreements for the Lindi liquefied natural gas (LNG) project, widely known as Tanzania LNG, and a productionsharing agreement (PSA) for offshore blocks 1, 2 and 4 are expected to be signed in the coming weeks.

The development was projected in international business media and confirmed by Energy minister January Makamba, who said at the weekend that key negotiations with a consortium of energy companies have been concluded.

He said that part of the natural gas will be exported and part of it will be used locally, with the government satisfied with results of negotiations with an international energy consortium for the long awaited \$40bn LNG

Final agreements are set to be signed in the coming weeks, on the basis of reports as well as the minister, who affirmed that the project will be one of the largest in Africa.

It will have a base investment of upwards of \$42bn, with a large part of the amount likely to be spent locally, he stated, expressing satisfaction with "concluding negotiation for a large energy project after many years of negotiations," praising the spirit of the sixth phase government for this achievement.

He said the project would touch off a significant increase in foreign currency,

growth of national income, direct employment for 10,000 people and indirect employment for upwards of 40,000 people.

The consortium, comprising Equinor, Shell and Exxon Mobil, based in Norway, Britain and the United States respectively, will develop an onshore LNG plant in Lindi Region, close to huge offshore gas fields.

Proiect talks stalled for years before President Samia Suluhu Hassan intervened upon taking office, visited France and the European Union headquarters and met with top executives of interested companies for preliminary agreements.

Increasing the capacity of local experts in the oil and gas sector is another beneficial aspect, along with government income from the sale of gas.

Some of the dividends will flow to the Tanzania Petroleum Development Corporation (TPDC) as a shareholder for the project, the minister stated, noting that gasbased electricity generation will be scaled up, thus providing greater energy security.

Tanzanian entrepreneurs will supply materials needed in the implementation of the project, starting from transportation, construction of houses, financial services and security oversight.

"The price of gas will be good and many Tanzanians will be able to use it," he said, outlining plans to take gas to households by reviving the National Gas Utilisation Plan.

The LNG project is expected to contribute 7bn/- to the gross domestic product per year, ushering in significant prosperity to sections of the country and wider overall benefits.

Jared Kuehl, Shell vice president presiding over the project for the firm, said in a statement that the Host Government Agreement (HGA), and a Production Sharing

Charles Sangweni, director general at the Petroleum Upstream Regulatory Authority (PURA) and chief negotiator in the LNG talks, said the proposed HGA was likely to be approved by the cabinet and the legislature in a short while, with total project investment envisaged to hit \$42bn.

Battles rage hours after Sudan rivals agree to ceasefire

Residents of Sudan's capital again awoke to heavy clashes yesterday morning just hours after rival generals agreed to an upcoming one-week ceasefire amid ongoing talks in Saudi Arabia.

The ceasefire -- the latest following many successive truces that have been systematically violated -- is set to go into effect at 9:45 pm (1945 GMT) today, the US and Saudi Arabia said in a joint statement.

The ceasefire "shall remain in effect for seven days and may be extended with the agreement of both parties", the statement added after talks in Jeddah.

Multiple truces have been violated since fighting broke out five weeks ago, which the Saudi foreign ministry acknowledged in a statement published by the official Saudi Press Agency early yesterday.

"Unlike previous ceasefires, the the conflict erupted on April 15. Agreement reached in Jeddah was signed by the parties and will be supported by a US-Saudi and international-supported ceasefire monitoring mechanism," it said.

But Khartoum residents -- who for weeks have been sheltering from brutal urban warfare amid desperately low supplies of food and vital resources -- were sceptical that this time would be any different.

"They have announced truces that they have not held to before," said Hussein Mohammed, who remains in Khartoum North, sheltering in place with his sick mother even as their neighbourhood became deserted.

"We hope that this time mediators can monitor that the ceasefire is implemented," he told AFP, adding that his mother has been unable to make her regular doctor's appointments since before The fighting pits the Sudanese

"We do not trust the warring sides," said Adam Issa, a shop owner in El-Geneina, West Darfur. "Every time they announce a truce and they go back to fighting. We want a permanent ceasefire, not a temporary truce."

The region is still reeling from a conflict that erupted in 2003 when

former autocrat Omar al-Bashir unleashed the feared Janjaweed militia -- which formed the basis for the RSF -- to crush a rebellion by ethnic minority groups.

In October 2021, the warring generals collaborated to oust a civilian government, derailing a transition to democracy following Bashir's ouster in 2019.

They installed a ruling Sovereign Council with Burhan at its head and Daglo as his deputy, but their marriage of convenience later disintegrated, and their power struggle came to blows.

Burhan officially sacked Daglo from his position on Friday, giving his title of vice president of the council to former rebel leader Malik Agar.

In a statement Saturday, Agar said he was determined to try to "end the war" and press for negotiations.

More than half of world's large lakes are drying up, study finds

More than half of the world's large lakes and reservoirs have shrunk since the early 1990s, chiefly because of climate change, intensifying concerns about water for agriculture, hydropower and human consumption, a study published Thursday found.

An international team of researchers reported that some of the world's most important water sources – from the Caspian Sea between Europe and Asia to South America's Lake Titicaca – lost water at a cumulative rate of about 22 gigatonnes per year for nearly three decades. That's about 17 times the

reservoir in the United States.

Fangfang Yao, a surface hydrologist at the University of Virginia who led the study in the journal Science, said 56 per cent of the decline in natural lakes was driven by climate warming and human consumption, with warming "the larger share of that."

Climate scientists generally think that the world's arid areas will become drier under climate change and wet areas will get wetter, but the study found significant water loss even in humid regions. "This should not be overlooked," Yao said.

Scientists assessed almost

volume of Lake Mead, the largest 2,000 large lakes using satellite to avoid the most catastrophic measurements combined with climate and hydrological models.

They found that unsustainable human use, changes in rainfall and runoff, sedimentation, and rising temperatures have driven lake levels down globally, with 53 per cent of lakes showing a decline from 1992 to 2020.

Nearly 2 billion people who live in drying lake basins are directly affected, and many regions have faced water shortages in recent

consequences of climate change. The world has already warmed about 1.1C (1.9F).

Thursday's study unsustainable human use dried up lakes such as the Aral Sea in Central Asia and the Dead Sea in the Middle East, while lakes in Afghanistan, Egypt and Mongolia were hit by rising temperatures, which can increase water loss to the atmosphere.

Water levels rose in a quarter of the lakes, often as a result of dam construction in remote areas such as the Inner Tibetan Plateau.

EAMCEF dishes out over 15bn/- to save eastern arc mountains in 5 regions

THE Eastern Arc Mountains Conservation Endowment Fund (EAMCEF) has spent over 15bn/- to finance projects to change people's behaviour to stop invading forests, conservation and research in the arc mountains in five regions and 15 districts countrywide.

The amount has succeeded in changing the habits of communities that depend on forests for human activities including cutting trees for charcoal, firewood and some of them do so for hunting wild animals. Those people are in village which are close to the eastern arc mountains located in the regions of Tanga, Morogoro, Kilimanjaro, Dodoma and Iringa.

Francis Sabuni, executive director of EAMCEF unveiled this over the weekend when speaking to the Norwegian ambassador to Tanzania Elisabeth Jacobsen, who visited the fund in Morogoro Municipality. He said the funds have been used from 2006 to 2023 and have helped to bring back Biodiversity and species that were facing the threat of extinction.

Sabuni said the mountains include East and West Usambara and Nguu (Tanga), Nguru mountains, Uluguru, Ukaguru, Udzungwa, Malundwe, Mahenge and Rubeho (Morogoro), Upare mountains in the North and South (Kilimanjaro), Rubeho (Dodoma) and Udzungwa mountains in Iringa region.

The EAMCEF director said that the mountains are recognized in the world as one of the 34 areas rich in biodiversity and wildlife that due to human activities were facing the threat of extinction.

Sabuni explained that in that period, 50 per cent of the funds have helped social projects by removing them from dependence on forest resources to run their lives and to start projects for economic growth, 35 per cent have been used for the conservation of the forests while 15 per cent have been used for of Research projects.

He said that when they started the projects, they started with a budget of 400m/-, it increased from 600m/- to 800m/- and now they have reached a budget of 1.8bn/-, which they have been looking for themselves and others from donors.

He mentioned one of the donors who supported the projects is the Norwegian government through their embassy in Tanzania who started funding since June 2011 for the projects and operation of the fund which will end this year and that after that the fund will run itself with the invested money in case another donor is missing.

EAMCEF board chairman Prof. John Kessy said the benefits in the community have been seen through the project for those who were relying on getting vegetables as wild game from the forest have started projects to raise goats, goats, chickens and rabbits as a condiment and to increase their income.

Prof Kessy said that the community that depended on forests for firewood and charcoal have been started with tree planting projects in various areas including schools, government institutions and open areas so that they can use that energy instead of destroying the conservation forests.

"We have managed to save our forests, the community used to depend on getting products like wild meat and firewood but we have decided to start projects like raising chickens, goats, goats, rabbits, raising fish and bees as well as planting trees for firewood, charcoal and construction and it has helped to eliminate the use of forests now" said Prof Kessy.

The Norwegian Ambassador to Tanzania, Elisabeth Jacobsen, said that the funding they provided has helped to bring about environmental conservation in the mountains of the Eastern Arch as well as develop important policies that will help the community contribute to the conservation.

Tanzania can lose status as pyrethrum leading producers, stakeholders warn

STAKEHOLDERS in pyrethrum crop in the country have cautioned that Tanzania could lose its status being the leading pyrethrum producer in Africa if farmers will continue selling their crop to private firms whilst containing more than 13 per cent moisture content.

They issued the cautioned here at the weekend at the meeting that brought together pyrethrum stakeholders that aimed to provide training to more than 200 agents on appropriate ways to purchase and sell the crop of high quality in order to increase its value chain from farmers to the market.

Mbeya District Agriculture Officer, Gideon Maunda said the practice by middlemen to purchase pyrethrum flowers and sell to firms while not adequately dry threatens the sustainability of the pyrethrum market within and outside the

Mapunda added that Tanzania is

of pyrethrum but during the last season, the crop was not of high quality due to purchasing flowers that are not dry to acceptable level.

"We have received complaints from seven firms that the toxin has been reduced in the crop because agents (middlemen) buy pyrethrum flowers that are not well dried, this situation is not good at all, these firms who came here to buy the crop can even decide to quit," Mapunda said.

He owned the middlemen doing this that the government will not close its eyes on the deeds, saying the country's laws are clear, as those found to be doing so can face fines and or jail terms.

Pyrethrum Crop Controller from Tanzania Pyrethrum Board (TPB), Edwin Margwe stresses that the Board administers the crop to make sure that no side is being favoured due to negligence by a certain side.

He warned that the government will not hesitate to revoke licences of firms that will not abide by the laws governing the crop, especially buying flower thereof whose moisture content exceeds 13 per

Representative of Pareto (PCT), pyrethrum buying company Jerald Joseph said 30 per cent of the pyrethrum flowers they bought in the last harvest season had moisture content above 13 per cent.

He said in the circumstances, the company incurred 1bn/- loss because they had to dry the crop anew, the process that decreased its weight.

Govt, LSF launch national women's economic forum

THE Ministry of Community Development, Gender, Women and Special Groups in collaboration with Legal services facility (LSF) have launched the national women economic forum (NWEF) in order to reach women in various economic sectors and pool their efforts to help them identify opportunities around them for their economic benefits.

The forum will assist women economically through improvement of policies and laws to enable them engage in equal economic opportunities by enhancing the knowledge within women groups in regard to trade, access to capital country's laws on issues of economy and how to survive economically.

The ministry had already such forums at regional level and formulated guidelines that guide them including the national forum, whose structure involves forms leaders - chairmen and secretaries thereof from all 26 mainland

Speaking at the NWEF launch in Dodoma last week, Dr Dorothy Gwajima, the minister for Community Development, Gender, Women and Special Groups said the government has continued implementing various zonal and international protocols on enhancing of gender equality and empowering women economically.

"Through resolutions adopted at the 1995 Women conference in Beijing, Tanzania decide to dwell on four areas: women economic empowerment, women legal rights, equality in education, training and employment and women in leadership positions.

In addition, in 2021 Tanzania participated in the generation equality forum held in Paris, France where Tanzania was represented by President Samia Suluhu Hassan," said Dr Gwaiima.

She also appealed to forums leaders from various regions to fully

supervise the forums by connecting women to access banks loans, markets and boost expertise in the production of their goods.

'Mixing tobacco with stones will destroy farmers' market'

TOBACCO farmers have been warned to stop the habit of mixing their crops with stones to increase weight because doing so will kill the market for their produce locally and internationally.

Nyakunga, deputy Collins registrar of cooperatives said this in Morogoro over the weekend while speaking to tobacco farmers and other agricultural stakeholders, including assistant registrars of cooperatives in the regions that grow the crop and managers of the main tobacco cooperatives.

Nyakunga urged managers to take action against all who will be found destroying the crop by mixing with unwanted materials, saying is to sabotage the market of the produce and instead confiscate their tobacco.

He asked the cooperatives to join the Information and Communication Technologies (ICTs) systems, in order to simplify their work and promised that they are in the process of establishing a national cooperative bank so that the cooperatives should buy enough shares to get enough to achieve the mission.

more than 7000 girl students from various secondary schools including 15-secondary chools (KISA project) and 12-secondary schools (Binti Shupavu project) which makes a total of 27-secondary

school in Kilimanjaro Region. She added, GLAMI mentors secondary school girls in Tanzania to complete their education, develop into confident leaders, and transform their own lives and their communities.

"We equip girls to overcome challenges and reach their full potential because educated girls create lasting positive change. The outcome is proactive, resilient, and socially-responsible girls who secure better jobs, raise healthier families, and increase the standing of women in society" the GLAMI's project boss explained.

According to her, Sexual harassment against the girl child is prevalent both in the workplace and at school.

"Child abuse or child maltreatment is physical, sexual, and/or psychological maltreatment or neglect of a child or children, especially by a parent or a guardian," she further explained.

Commenting on the problem, the social welfare officer from Mwanga DC, Alex Kameo said that the problem of CSA rising in his district is a result of some parents/guardians who hides them, or 'finishing' them illegally at a family level after being reported to the legal authorities.

Other aims of the Council is to control the effects of climate change and eradicate herderfarmers conflicts that have been causing disastrous effects including deaths destruction of property.

Speaking about the projects, Morogoro District agriculture and livestock officer, Ndelisho Moshi said another aim is to assist herders from moving about with

> He explained that the plan will also help herders who can now stay in one area and start modern livestock keeping because they will no longer have the excuse to wander with their herds in search of pasture and water.

ZHC to build houses for low-income people in Unguja and Pemba islands

ZANZIBAR Housing Corporation (ZHC) has said it has a plan to build houses for low-income people in various areas of Unguja and Pemba.

Mwanaisha Ali Said, ZHC director general unveiled this here over the weekend when speaking with journalists at her office. Mwanaisha said that the Zanzibar government has set aside reserve land for development, so ZHC will use the opportunity to build houses to rent and sell to various

citizens in order to bring better together, or the way to pay the housing. She said the corporation has now started building houses for sale in the Mombasa area for Chinese, but even a citizen with a low income can buy due to the good procedure set up to sell the houses. She explained that the houses will be sold to Zanzibari people who are inside and outside the country, it is important that someone follows the purchase procedures set by the organization. According to Mwanaisha, ZHC will sell the houses in three ways, either the way to pay all the money

money in four installments or through the bank (mortgage is not sold). We receive money from the bank, but the customer will sign a contract with the bank to deduct the money for the house," she said.

She also noted that ZHC is ready to receive money for houses being built in Mombasa kwa Mchina as the construction has started since March 2023 and will end after 15 months from that month.

Mwanaisha said the houses will be sold at different prices due to the number of rooms as there are two-bedroom houses that will be sold for 136m/- and three-bedroom houses will be sold for 153m/-, those prices are exclusive of value added tax (VAT).

She further stated that ZHC will hand over those houses to the Condominium Board which is one of the institutions of the Ministry of Land and Housing Development that will bear the guarantee of keeping the environment clean in the areas of the houses.

Mwanaisha has thanked the Zanzibar President Dr Hussein Ali Mwinyi for supporting them in the construction costs of the houses because without getting help from the central government the organization would not have been able to.

TAWA to people near wildlife reserves: Be extra cautious when moving at night

PEOPLE living near wildlife protected areas including national parks and game reserve have been cautioned to exercise utmost care during the night as wild animals including elephants roam at night looking for grass.

Mlage Kabange, acting commissioner of conservation in Tanzania Wildlife Management Authority (TAWA) gave the caution in Mvomero District during a debate to find solutions to Human Wildlife Conflicts (HWC) facing Mvomero district, Morogoro Region.

Kabange said research by TAWA in various areas in the country found out that many people are adversely affected when moving about during the night when fierce animals roam about looking for pasture.

He called on the people to adhere to directives given by wildlife officials, including avoiding coming close to the wildlife, especially elephants.

"We are stressing on the people to continue reporting incidences of invasion by fierce and destructive wildlife in their areas in order to

address the situation," said Kabange. He also warned the people not to come to close to the fierce animals including taking selfies near them.

For his part, Mvomero District Commissioner Judith Nguli also warned the people to stop the habit of inciting wildlife including elephants, the acts that have been enraging them and later return to harm the people even killing them.

She said some people have the habit of climbing up the trees and hunt game using inappropriate weapons, thereby only wounding them thereby enraging them and later come to revenge.

The DC advised TAWA and other conservation authorities to boost the wildlife personnel including working tools including weapons in order to reduce or completely eradicate adverse effects from the fierce wildlife.

Mvomero Constituency Member of Parliament Van Zealand advised wildlife authorities to crop the elephant population to reduce their adverse effects on the people including wounding them or even causing death to them.

The debate involved various stakeholders including village officials including those bordering reserve areas, Mvomero District officials and conservation officers from both TAWA and TANAPA.

Tanroads to construct road network totalling 600 kms for Mwanza

TANZANIA Roads Agency (TANROADS) has contracted consultants to conduct a feasibility study in depth and design different roads to be built to tarmac level in Mwanza Region with a total length of 652.2 kilometres.

Mwanza regional TANROADS manager Eng. Ambrose Pascal said that contracts whose value is approximately 5.6bn/- were signed between 2014 and 2021.

Eng. Pascal said that roads under the plan with their length in brackets are meant to improve transport conditions and push forward socio-economic development in the areas.

He mentioned the roads as Mwanangwa-Misasi-Salawe-Kahama (Nyihogo) (150km) located in Mwanza and Shinyanga that cost 798,801,250/- as well as Kamanga-Katunguru-Sengerema (36km) with a cost of 575,919,650/-

Other roads are Magu-Bukwimba-Ngudu-Hungumalwa (71km) 638,486,200/-, Sengerema-

including Katunguru-Nyamazugo, Bukokwa-Nyakalilo and Nyehunge-Nyamadoke 779,274,725/-

He said that other roads are Mkuyuni-Nyakato (10km) first package and Nyakato Veta-Buswelu-Mhonze (14.2km) second package 219,010,000/- and Mwanza-Nyanguge (35km) 387,410,000/-

Others include: Mwanza airport-Igombe-Nyanguge (46km) 206,845,500/- and the on-going project on Mwanza-Shinyanga Road border (104km) 980,840,000/- that started in 2020 and feasibility study and design is scheduled for completion in May this year.

According to the engineer, also the plan includes the final feasibility study on the Simiyu Bridge with a view to design and construct it that has cost 374,650,000/- as well as Sukuma Bridge (70km) with feeder roads (2km) 612,810,000/-

He said that aim is to ensure roads managed by the agency are in good condition and passable throughout to solve transport challenges among the people in the region.

Govt advised to reduce taxes on private schools

Human capital uplift just a part of addressing youth jobs challenges

launching preparations of the Africa human capital summit in Dar es Salaam late July, brainstorming on what precisely ought too be done to overcome the challenges besieging the continent's rapidly growing population is at a brisk pace. Yet there is already a clearly defined approach to the matter that is implicitly the solution, and the summit will just seek to see how to achieve its tenets. It focuses on training youths, women for own projects.

This approach is beginning to be a global paradigm on the issues, as it is also quite visible in relation to rethinking the curriculums offered at primary, secondary, high school, college and university levels. A newly fangled method imbibes all levels of education with vocational skills training, eroding strict learning as we know it, and turning to working on things. It is altogether different and likely to create a hierarchy of schools, of learners and tillers, etc.

Focus on human capital training hinges on two relatively inaccurate propositions, one being that graduates are not employable as they have poor skills by the time they graduate. The second proposition is that with the right skills upon leaving school, youths can start own income generating projects, now also angled on the use of information technology, as well as micro-lending that Vice President Dr Philip Mpango lately emphasised. It is a solid approach.

Admittedly, under conditions prevailing globally since the turn of the century, not much else can be expected, as the rest of the world failed to follow the post-World War II growth example in Europe. The Far East and parts of South Asia enacted own model and succeeded targeted assistance.

TITH the government in breaking the barriers of poverty with a solid intention of catching up with Europe. Africa and many parts of Asia and Latin America don't have this goal, postulating distributive or similar solutions.

> Tanzania is intellectually or ideologically well positioned to host the summit, as its underlying philosophy of development sees people as the centre of the development effort. This idea of learning life skills to use after school is the centrepiece of the paper, Education for Self Reliance, drawn up after the Arusha Declaration early 1967. The wider outlay of a planned economy has since been obliterated but the core issues remain in place, including inability to see how the economy can be opened up and jobs be available for anyone wishing to

> That isn't impossible and it is really what makes Western countries what they are, and African youths flock by the thousand to these climes. Training them in gardening, woodwork or beauty skills like shaving, sewing shoes will make no difference. The issue is to open up economies to deepen capital, industry, jobs.

Many observers extol Tanzanian's experience, for the simple reason that the goals we have set for ourselves are in the first place timid, lacking aspirations like those of the Far East, etc. Still, youth unemployment bode NGOs ameliorate condition of youths, college skills uses well for capital inflows as it provides cheap labour for industries being relocated from the West, while other youths obtain the skills they can muster to do something to make ends meet. It is a workable method and the summit will deepen its prospects further, to unblock much needed

Cultural Diversity Day should promote harmonious living in a diverse society

Diversity for Dialogue and Development, sometimes abbreviated World Day for Cultural Diversity, is a United Nations-sanctioned observance day for the promotion of diversity and intercultural dialogue.

Tanzania has approximately 60 million inhabitants and over 120 tribes that live together peacefully. It is a safe and politically stable country, with very friendly and relaxed people. Due to the large ethnic differences, the Tanzanian culture is very diverse. There are multiple possibilities to get acquainted with the Tanzanian culture.

The Millennium Development Goals issued by the United Nations in 2000 did not mention culture as an aspect or facilitator of development. Since then, some UN agencies, especially the United Nations Educational, Scientific and Cultural Organisation (UNESCO) have worked to encourage cultural diversity as an integral part of development. UNESCO's Universal Declaration on Cultural Diversity in November 2001 called for measures to protect the world's cultural diversity from the risk of globalisation.

document described cultural diversity as the 'common heritage of humanity' and set out actions that member states could take to promote it. It was the first international instrument enshrining the value of cultural diversity and intercultural dialogue and led to further international efforts to promote diversity as a shared goal. One such effort was proclaimed unanimously by the United Nations General Assembly on 20 December 2002, naming 21 May as the World Day for Cultural Diversity for Dialogue and Development.

Through the Universal Declaration and other activities, UNESCO has

HE World Day for Cultural promoted a new interpretation of culture. While cultural diversity was previously understood in terms of the preservation of established cultural material, the new interpretation emphasises an ongoing process of interaction and dialogue. On the 2009 World Day for Cultural Diversity, UNESCO's Director-General Kichir Matsuura specified that the organisation 'believes that cultures are not monolithic but interdependent, resulting from mutual exchanges and borrowings'.

> The day is celebrated by events bringing together specialists from many areas of culture as well as representatives of government and non-government agencies. Since 2011, the United Nations Alliance of Civilisations (UNAOC) has run the 'Do One Thing for Diversity and Inclusion' campaign, in partnership with UNESCO and other public and private organisations. This asks people to spend the World Day for Cultural Diversity learning about other cultures or sharing their own culture with other people.

> It recommended that cultural institutions and public bodies extend their support for art from diverse cultures and remove barriers to participation for immigrant artists and performers.

The observance day is regularly celebrated in Botswana with national and tribal ceremonies and artistic events. This has helped to raise awareness of the Batlokwa minority ethnic culture, and enabled observers to document and preserve this culture by recording events. 

With the right tech, Tanzania's women in business will stay ahead of the pack

RGUABLY more than any other East African country, Tanzania has been at the centre of numerous regional and continental trade initiatives with an enormous impact on its women traders.

It is the only country that is a member of both the East African Community (EAC) and the Southern African Development Community (SADC). This is because of not only Tanzania's historical association with the liberation movements in Southern African countries, but also because Tanzania borders non- EAC states such as Zambia, Malawi, and Mozambique. It is well known that the country's first president Mwalimu Julius Nyerere swung open the country's doors to support the fight for freedom across Southern Africa, cementing solid relations that continue to this day.

Moreover, the African Continental Free Trade Area (AfCFTA) has expanded the possibilities for trade, bringing together 55 countries and eight regional economic blocs in Africa. This is one of the flagship projects of the African Union's Agenda 2063 - with the potential to foster industrialization, job creation, and investment across the continent.



Of significance, too, is the fact that Tanzanian women have led other womenfolk in East Africa on various fronts, giving them the confidence to excel in business and other fields. Today, President Samia Suluhu Hassan is the region's only female head of state, signalling to every woman and girl child across the length and breadth of the country that there is no limit to what they can achieve.

Indeed, from Mtwara to Mwanza, the story is the same: The women of this great nation are determined to fight poverty, overcome patriarchy, and do whatever it takes to put their children in school and ensure there compliance requirements across

is food on the table. It is a strong culture upon which innovations can thrive and even struggling entrepreneurs can overcome the unpredictable tides of business.

Despite these advantages, women traders in Tanzania are far from realizing their full potential, partly because they do not possess the information they sorely need to remain competitive in a rapidly changing world.

This lack of information at the time it is needed is responsible for delays in responding to market changes and demand; poor knowledge of trade regimes and regulatory

borders; and even the inability to obtain help when faced with harassment at border points and roadblocks.

In an effort to overcome these hurdles and further improve the lot of the country's women traders, the Tanzania Women's Chamber of Commerce (TWCC) in collaboration with TradeMark Africa (TMA) has developed iSOKO, an online women trading portal designed to fill this information gap.

Developed with the support of Global Affairs Canada, the iSOKO platform is an online business portal that targets women traders across the five East African countries the others being Kenya, Uganda, Rwanda and Burundi. Kenya and Uganda have already launched this mobile and web-based platform, while in Tanzania it will be launched on 24 May 2023.

Once fully operational, the portal will revolutionize trade in East Africa and further cement the gains made by Tanzania's women traders over the years. Registration is free, and it is incumbent upon women everywhere to take full advantage of the new technology to grow their businesses.

Beyond corruption within the judiciary

N his 2008 US\$1.4 Million corruption trial, former interim President Charles Gyude Bryant (late), in accusing the government of unfair trial said he was not being tried by "jurors of his peers."

From a legal perspective, a juror of one's peer is a jury whose members are from the same community as the person on trial.

It is also a way of getting a fair jury made up of men and women who could be considered peers of the person who is on trial. This helps in reducing the chances of bias among the jurors.

In the late Bryant's argument, members of the jury who were charged with responsibility of deciding whether, on the facts of the case, he was guilty or not guilty of the offense for which he was charged were men and women outside of his social circle and therefore, not qualified to try him.

In other words, they could not

understand the intricacies of the with the authority to determine matter at hand and therefore could not have handed down a fair and unbiased verdict in the trial.

The late Bryant's argument of not being tried by "jurors of his peers" is one of the fundamental problems facing the Liberian Justice System that is most often or not ignored by critics of the local justice system.

Human Rights reports on the Liberian Judiciary have remained focused on bribery and corruption within the local justice system and how the rich and powerful are able to manipulate the system to steer justice in their favor.

But what has not been mentioned beyond bribery and corruption, particularly in criminal trials is the role of jurors. An uninformed jury is totally not aware of the fundamentals of the case at hand and is unable to hand down a fair and unbiased verdict that could be considered a miscarriage of justice

The argument here is that select individuals who are clothed the factual questions and final judgment should have knowledge of the matter at trial and not just be hand-picked to sit on a juror panel.

From personal experience, it appears that some jurors are not just abreast of the charges or have no experience in such cases. In such situations, verdicts are most likely to be influenced by emotions, intimidation, etc.

When jurors are far from or not connected to the argument of the case at hand, they remained uninformed and have no idea about the factual question of the case at hand. Therefore, their verdict will not just be unfair and biased, but it will also compromise the entire

This raises the question as to how jurors are selected to preside over jury trials here. In one particular case, I was told, the jurors were selected based on their college experiences and not their experiences on such matters.

Selecting a juror because he or

she is a "college" graduate with no prior experience sitting on a jury panel to preside over a matter of national security speaks volumes.

In most jurisdictions, relevant life experiences as it relates to the case in question are considered an important aspect in selecting or deselecting a potential juror.

Other things to consider could include but are not limited to the person's ability to withstand social pressure, legal opinions, ability to be impartial, etc. To select a group of individuals in the name of forming a jury panel is a mockery of the intent of the framers of the Constitution.

In the late Gyude Bryant trial, the Liberian government lost the case following a series of prohibitions one of which was a writ of prohibition issued by the Supreme Court. Bryant's lawyers asked the Supreme Court to stop his prosecution on grounds that the late Bryant was a former head of state who brought peace to the country and could not be held for actions he took while he was in office.

Samia's satellite plan means empowerment of more Tanzanians

UR country has experienced a substantial growth of the broadcasting sub-sector with latest figures showing that a total of 741 broadcasting and online media service providers are registered. Statistics released in November last year by Tanzania Communications Regulatory Authority (TCRA) show that 61 television stations, 390 internet televisions, 65 cable television and 218 radio stations were

According to TCRA, there were 3,326,845 active TV set-top boxes as of September 2022. Also, there were 1,656,460 Digital Terrestrial Television (DTT) set-top boxes compared to 1,670,385 STBs (Satellite Receiver Box) with Dar es Salaam Region having the highest number of set-top boxes at 1,270,755.

But this is just a drop in the ocean if juxtaposed with the 2022 Population and Housing Census which shows that Tanzania had 61,741,120 people of which 59,851,347 were in the Mainland and 1,889,773 in Zanzibar.

This means that we have a long way to go as a country. And the tested and passed technology that makes broadcasting cheap hence accessible to many all over the world is satellite. Since satellites are located at a certain height above earth, communication takes place between any two earth stations easily via satellite. It overcomes the limitation of communication between two earth stations due to earth's curvature.

Satellite systems offer broader coverage than cell networks currently being used in our country. Constructing a large number of towers can be costly and difficulteven impossible in remote areas. In contrast, satellite beams cover vast areas and no towers are required, so coverage extends to the hardest-to-reach locations.

The latest Low Earth Orbit (LOD) satellites orbit closer to the earth than geosynchronous satellites. This makes them ideal for voice and data communications. Wi-Fi networks, internet service providers and emergency communications services use them. Satellites are nowadays commonly used for broadcasting applications, including sending radio and television signals to consum-

That is why I was pleased last week when President Samia Suluhu Hassan made public the government's intention to launch an operational earth observation satellite to boost broadcasting and bring down the cost of communication out of the country.

Speaking at an event to launch digital terrestrial transmission services by Azam Media Group in Dar es Sa-

laam, the president said the technology will uplift broadcasting sub-sector and eliminate the use of towers now proliferating all over the country.

She said the government will set up a space agency to coordinate satellite operations, adding that although the matter is still just a plan; the government has firm intention of launching a satellite.

"We are well prepared. We have started discussions, and rest assured that Tanzania will have its own satellite in the near future," she said and added "This will become a reality." Why not? Last month, Kenya launched its first operational earth observation satellite onboard billionaire Elon Musk's SpaceX rocket from the United States.

The satellite developed by nine Kenyan engineers will collect agricultural and environmental data, including on floods, drought and wildfires, that authorities in the neighbouring country plan to use for disaster management and to combat food insecurity.

The Falcon 9 rocket carrying the Taifa-1 satellite, took off without incident from Vandenberg Base in California, after three previous postponements due to bad weather.

"Taifa-1 separation confirmed," SpaceX said in its broadcast when the satellite was released about

an hour and four minutes after the rocket's launch.

"We have the challenges that have been brought about by climate change, which the satellite, by virtue of being able to capture images (will be able to help monitor)", Captain Alloyce Were, an aeronautical engineer and deputy director of Navigation and Positioning at the government-run Kenya Space Agency, said before the satellite's launch.

After the establishment of Tanzania space agency to oversee the project as the president promised, Tanzanians will be overwhelmed

our very own Kilimanjaro 1 satellite or any other name picked.

It should be remembered that within the East African Community (EAC), Rwanda and Uganda have already done it after sending their first working satellites to space in 2019 and 2022, respectively.

Three Ugandan engineers teamed up with Japanese counterparts to develop the PearlAfricaSat-1 satellite deployed last November to provide research and observation data for solutions in weather forecast, border security, agriculture monitoring,

with joy to witness the launch of land, water bodies, infrastructure planning, disaster prevention and mineral mapping. Across the border, RwaSat-1 satellite, built by Rwandan engineers in partnership with Japanese scientists and deployed in December 2019, was meant to provide

Needed: A guide for natural resources management in Tanzania

zania are generally taken for granted with no serious appreciation of their value and contribution to job creation and economic growth. Hence, they remain what they have been for decades-a potential.

Providing decision makers with a support system or simply a guide may: (a) help to assess for example the advantages or disadvantages of different development options in an area; (b) provide decision makers with relevant information in an easily understandable format like comparing different development options and (c) consider the real value of natural resources and the benefits accruing therein.

Also (d) consider mitigation measures not only for large scale investments but also the influence of smallscale activities like shifting cultivation, charcoal production, grazing and other livelihood activities which may subsequently have huge impacts on an ecosystem; and (e) alert beforehand on all development options so that before making decisions, they are examined for the likelihood of any interventions bringing impacts to humans, natural resources or ecosystem services.

Information pertinent to any future guidance of a management area could include an analysis of the resourc-



es of the area, identification of land use suitability and capability, land acquisition and disposal requirements, determination and designation of land use zones, and development of management policies, objectives, responsibilities, guide-

Such guidance is intended to introduce resource specialists to the basic concepts and principles that can be used in a planning effort, such as: the need for public involvement and proper evaluation of resources technical information; proper

need for implementation schedules; need for monitoring and updating information; and providing managers with a road map to wise resource use.

Thus, the overall objective of such a guide would be to ensure that ecosystem resilience is maintained to sustainably provide socio-economic and environmental benefits to local communities in the country. More specifically, the objective would be to ensure improved and enabling environment and strengthened public inputs; collection of appropriate capacities for sustainable management of natural resources linked to an equitable analysis of the technical information; local economic development, resulting in

increased benefits.

In order to analyze the implementation of development interventions in an integrated manner in any given area, population, agriculture and water use constitute the core of simulation models. Population gives insights over the development of a fixed number of people that live in the area and indicates changes in their employment and incomes.

Agriculture can disaggregate the main crop types that are grown in the area and that can be subject to changes under the development interventions. Agriculture production, employment and fertilizer

use can also be estimated and costs compared with the benefits, to gain insight of the economic viability of planned interventions. Water on the other hand should cover precipitation, surface- and ground water stocks, as well as the runoff.

Mining alone in Tanzania is huge and incudes metals (gold, iron ore, nickel, copper, cobalt, silver), industrial minerals (diamonds, tanzanite, ruby, garnet, limestone, soda ash, gypsum, salt, phosphate, gravel, sand, dimension stones and graphite), and fuel minerals (coal, uranium).

Europe sells to Africa and Asia 90 pc of its used clothes, textiles waste

NCE the moneymaking businesses have turned Asia and Africa into their low-cost factories, to produce and market at higher prices their clothes and footwear, obtaining more profits by selling to these two continents around 90% of all their used and textiles waste.

Not only: such a business alleviates the harsh environmental impacts of the lucrative clothing and fashion industry, and the cost of recycling and eliminating the leftovers of these products.

Just know that textiles are on average "the fourth-highest source of pressure on the environment and climate change from a European consumption perspective," the European Environment Agency (EEA) on 26 April 2023 reported.

"Europe Consequently, faces major challenges managing used textiles, including textiles waste."

Europe exports much more than textile waste

Lars Mortensen, EEA expert on circular economy, confirms that textile production and consumption in the European Union have significant impacts on the environment and climate.

"Textile consumption causes the third largest land use and water use in the value chain, and the fifth largest material resource use and greenhouse gas emissions. Also, textiles cause pressures and impacts from their chemicals on the environment and climate".

The poisoning plastic

A 27 January 2023 EEA briefing focusses on another big problem: plastic.

"Plastic-based – or 'svnthetic'– textiles are woven into daily lives in Europe, in the clothes we wear, the towels and the bed sheets, in the carpets, curtains and cushions. And they are in safety belts, car tyres, workwear and sportswear."

Synthetic textile fibres are produced from fossil fuel resources, such as oil and natural gas, the briefing goes on, adding that their production, consumption and related waste handling generate greenhouse gas emissions, use non-renewable resources and can release microplastics.

consumers discard about 5.8 million tonnes of textiles annually - around 11 kg per person - of which about two-thirds consist of synthetic fibres, according to the briefing.

"In Europe, about one-third of textile waste is collected separately, and a large part is exported."

Africa and Asia are therefore the largest destinations of these toxic fibres.

Simply put: by exporting European used clothes and textiles waste, their impacts necessarily fall on the shoulders of Africans and Asians.

A highly uncertain fate

Indeed, "as reuse and recycling capacities in Europe are limited, a large share of used textiles collected in the EU is traded and exported to Africa and Asia, and their fate is highly uncertain," says the European Environmental Agency.

In fact, throughout the past two decades, Africa has been the main continent receiving used textiles from the European Union (EU), importing more than 60% of EU exports.

But while in 2000 Asia received only 26% of EU exports, by 2019 it had significantly increased its share to 41% of EU imports. This is almost equal to Africa, which still imported 46% of EU ex-

Where do second-hand clothes end up?

In the African countries studied, the EEA report says that the import of used textiles seems to be mainly meant for local reuse. This is because there is a demand for cheap, used clothes from Europe, which seem to be preferred to new items.

"What is not fit for reuse mostly ends up in open landfills and informal waste streams."

In Asia, however, most of the used textiles are imported to so-called economic zones where they are sorted and processed. In the countries studied for this briefing, import for local reuse is restricted.

Instead, used textiles seem to be recycled locally, mostly downcycled into industrial rags or filling, or re-exported either for recycling in other Asian countries or reuse in Africa.

poet Kwame Dawes, the film addresses subjects such as sexual abuse, society's view perspectives from which experiences are recalled and retold. It will have a special screening this month at the prestigious Calabash International Literary Festival in Jamaica (May 26-28), and while viewers can expect to be moved by the whole story, they will be haunted by one stunning, unexpect-

In its minimalist mise-en-scène, Moon Over Aburi is reminiscent of a play, with two main actors in the spotlight, or rather the moonlight, playing off each other Ghanaian-British actress Anniwaa Buachie and her Ghanaian compatriot Brian Angels (whose credits include the 2015 feature Beasts of No Nation, starring Idris Elba).

Buachie plays a mysterious woman, the owner of a small food kiosk who seems tied to something in her past. Angels plays the man who visits the kiosk on a moonlit night and asks for a meal. As the two exchange cryptic words and stories, it becomes clear that the man knows more about her than he lets on, and the colossal secret she carries is gradually revealed, as enigmatic shots of the full moon emphasise the mystique.

Buachie, who produced the film and codirected (with Sheila Nortley), has a background in both cinema and theatre, having performed at London's Old Vic and other venues. She has also appeared in guest roles in popular television series such as Eastenders. But making Moon Over Aburi was not a shoo-in for her, she says. She and her team had to overcome certain obstacles for the work to see the light of day - because in a world where the number of films seems to be ever growing, only a selected few filmmakers acquire the resources to pursue their art.

In the following, edited, interview, Buachie speaks with SWAN about the film's journey to the screen.

SWAN: Moon Over Aburi is a shocking, thought-provoking film that is beautifully made. How did it come about?

Anniwaa Buachie: As an actor, I provided the voice of the audiobook in the anthology Accra Noir, edited by Nana Ama Danquah [and published by New York-based publisher Akashic Books]. I fell in love with the story Moon Over Aburi by Kwame Dawes.

I remember when I started reading this story, I immediately had goose bumps. The story was honest, visceral, poetic, chilling... a dance of cat and mouse between two people, a man and woman, secret and lies, making one question whether two wrongs can make a

It sat with me, it was in my heart, my mind, my body. I had never read a story that highlighted the vicious cycle of domestic violence, but also explored how a woman ruthlessly and unapologetically takes back her power.

Society tends to excuse the faults of a man and blame the women in that man's life. The woman who raised him, the woman who married him, the woman who rejected him. Power is given to a woman to birth and nurture a child, yet it is taken from her as soon as she seeks equality, acknowledgement, and respect. It is a story that pushes the brutal subject matter of domestic violence into the light, a much-needed conversation that often lies in the shadow, swept under the carpet. I had to bring this story to light.

challenges in adapting the short story to suit the demands of a different medium, film?

Monday 22 May 2023

A.B.: Kwame Dawes' writing is beautiful, lyrical and poetic, and it was important to me to ensure that the film produced stayed true to the mystical element of the original.

Many stories are written in the first person, and the reader already is biased as they often attach themselves to the main narrator / protagonist. However, with Moon Over Aburi, Kwame had already written it in a dialogue format. The story was a script in the first instance, so adapting it to film was a joy, to be honest.

What was tricky was deciding how much detail to pack from a 20-page short story into a 10-page script. The world that Kwame had created was so intricate, intimate through words, and heavily reliant on the reader's interpretation. However, with a screenplay, you have to make definitive decisions and find ways to utilise camera shots, sounds, and the colour palette to influence the viewer's perspective.

Film also demands a particular structure that a short story can forego. Screenplays require scenes that establish each character and a clear breaking point in the middle of the script that take characters to the emotional extreme - into fight or flight mode. The audience needs to be taken on an emotional ride, and this is influenced by the whole creative team: producer, director, cinematographer, etc.

Personally, it was a challenge for me to maintain a balance between being an actor and being the producer, and co-directing.

The actor inside me wanted to play forever and fully immerse myself in the character. However, there was a part of my brain that, as the producer, always had to be focused on the practicalities, thinking about if the budget is being used effectively, if everyone is happy on set, if cast and crew have been fed and have what they need to maintain a high quality!

Also, once a film project is done, an actor can switch off and think about their next project, whereas the role of the filmmaker doesn't stop there - now it's about implementing, marketing, sourcing additional finance, distribution. Good thing I am a great multi-tasker!

SWAN: The shots of the landscape, the moon, and the setting overall, are artistic and evocative. Can you tell us more about the photography and where it took place?

A.B.: The story takes place in the Aburi, the eastern region of Ghana, and in Accra, the main city. Whilst the story leaves room for the imagination, I am so thankful to Ghanaian-based cinematographer extraordinaire Apag Annankra of Apag Studios and art director Godwin Sunday Ashong. Their knowledge of the neighbourhood and the scenery enabled us to find places within Aburi and Accra that provide a magical realism.

We used drone shots to capture the vastness of Aburi and correlated this with the earthy green and blue colours and rural setting in the country scenes, and juxtaposed this with our city location - with intimate shots, highly saturated neon colours, and an abstract setting. The city locations were based in Jamestown, the vibrant heart of Accra, and Cantonments.

SWAN: The films you've produced carry a social message - about the treatment of girls and women - but it is left up to viewers to draw their own conclusions, or to see the light, so to speak. How do you balance artistic subtlety and activism?

A.B.: It is important to me, as an artist, to present situations that encourage conversations, a reflection of self and to identify how one contributes or blocks the development of girls and women. The best teaching is when the viewer has space for analysis themselves, as opposed to being force fed an opinion. I simply ensure that the films I produce have

in-depth perspectives, of extreme impactful situ-

ations, drawing the viewer in on an emotional,

TMRC sees oversubscription on fourth tranche corporate bond

THE Tanzania Mortgage Refinance Company Limited (TMRC) has listed its tranche four corporate bonds on medium term note at the Dar es Salaam Stock Exchange (DSE) with an oversubscription record of 12.8 percent.

The listing held last Friday is part of TMRC's 120bn/- executed at the bourse that saw individual retail investors' appetite growing.

Oscar Mgaya TMRC chief executive officer said at the listing event that the fourth tranche was successfully raised 11.28bn/- from a issuance aimed at raising 10bn/-.

According to him, the first tranche had an oversubscription of four percent, tranche two had an oversubscription of two percent, and tranche three 27 percent subscription.

"I'm happy to report that in tranche four there was good participation both

from individual investors and corporate ones. In terms of number of investors 69 percent were individuals and 31 percent were corporates," said Mgaya.

The participation shows that the public is becoming more aware of the product and it is gaining confidence with TMRC since it started issuing corporate bonds in 2018.

He said the oversubscription proves that one can raise funds from domestic capital markets through corporate bonds. The total funds mobilized I the four tranches worth 42bn/- alongside private corporate bond issues which attracted 62bn/- in total.

"The country's mortgage market is still struggling to grow. One of the measures of the size of the mortgage market which is the mortgage to GDP ratio shows the size of the market in relation to it is less than one percent," said Mgaya.

In comparison with some of the countries in the East African region, Keya's

growth is 2.5 percent, Uganda is less than one percent and Rwanda is 3.7 percent. He said the current performance should motivate stakeholders to collectively strive for higher growth.

"Some policy measures need to be observed to grow the market, especially that differentiates the mortgage product from other real estate sector products;

Most of the mortgage lending is done by banks while in other markets you may find mortgage financing companies only focus on one product," he said.

According to him, in 2021 the mortgage product risk wave rate capital was reduced to 50 percent while other loans maintained 100 percent.

The purpose was to steer

people towards mortgages. Recently, salary loans have also been pegged at 50 percent risk wave and personal loans destined to housing are acquired through this window.

Nocodemus Mkama, chief executive officer Capital Markets and Securities Authority (CMSA) said that the appetite from individual retail investors is likely to boost liquidity of the capital market.

"The bond has been oversubscribed due to the conducive investment environment created by the government. During the financial year ending June 2022 through the Finance Act waived withholding tax corporate bonds issued by companies," he said.

He said the decision has contributed to attracting more participation from corporate and individuals. The minimum corporate bond threshold for individual investors has been reduced to 500,000/- from the previous 1m/-.

The value of total investment on capital markets has grown by 7.87 percent attracting 35.39trn/as of April 2023 compared to 32.81trn/- in April 2022.

Investments on treasury bonds have grown by 1653 percent to 18.37trn/- compared to 15.76trn/of the corresponding periods.

Japhet Justin, commissioner of debt at the Ministry of Finance and Planning said that the public need to be sensitized on opportunities available at the TMRC especially when it comes to acquiring mortgage loans from the company.

"Majority of the people have been acquiring loans from commercial banks for building houses under the personal loan window. We need to educate these people on the difference of mortgage loans to personal loans in achieving the same goal," said Justin.

Rwanda tops profit earnings for Kenyan banks

KIGALI

RWANDA contributed the highest volume of profit earnings for Kenyan bank subsidiaries in East Africa and beyond last year, a new report by the Central Bank of Kenya (CBK) said.

The CBK said the regional subsidiaries of Kenyan banks posted a combined pre-tax profit of Sh32.51 billion as of December 31, 2022, an increase of 88.65 percent from Sh.17.23 billion reported on December 31, 2021.

"Rwanda contributed the highest earnings capacity recording Sh.10.16 billion in profits, translating to 31.26 percent of the total profits. Subsidiaries operating in DRC (Democratic Republic of Congo) and Uganda contributed 30.10 percent and 16.11 percent of the total profits respectively while subsidiaries in South Sudan contributed 14.28 percent of the total profits" the CBK said.

Several Kenyan banks have expanded operations in the East African Community (EAC) partner states and beyond in markets such as Mauritius, Malawi, and Mozambique.

These banks include KCB Group, Diamond Trust Bank, NCBA, Guaranty Trust Bank Kenya Limited, Equity Group, I&M Holdings Plc, African Banking Corporation Limited, and the Co-operative Bank of Kenya

with a presence in EAC. Some of the Kenyan lenders such

expanded beyond the EAC jurisdiction. For instance, I&M has a 50 percent shareholding in Bank One Limited in Mauritius, Prime Bank has a 10.6 percent shareholding of First Capital Bank Malawi, 6.62 percent shareholding of First Capital Bank of Botswana and 5.0 percent share-

as I&M and Prime Bank Limited have holding of First Capital Bank SA, Mozambique.

The CBK report said that Kenyan bank units operating in Mauritius, Tanzania, and Burundi were the least profitable and contributed 4.50 percent, 2.82 percent, and 0.93 percent of the total profits respectively.

"Three subsidiaries registered a

combined loss of Sh2.4 billion. Out of the three loss-making subsidiaries, two were operating in Tanzania and one in Uganda" the regulator said.

The CBK report said the total assets of Kenyan bank subsidiaries abroad stood at Sh1.61 trillion as of December 31, 2022, compared to Sh1.21 trillion as of December 31,

2021. "A significant contributor to the asset base was Equity Group Plc's subsidiary in DRC, Banque Commerciale Du Congo -BCDC with total assets of Sh442 billion and KCB Group Plc's subsidiary in DRC, Trust Merchant Bank with total assets of Sh212 billion," it said.

The Kenyan banks' subsidiaries accounted for a combined deposit base of Sh1.28 trillion in December 2022 compared to Sh940 billion in December 2021.

The main contributors of deposits were Equity's subsidiary in DRC, Banque Commerciale Du Congo -BCDC, with total deposits of Sh365 billion or 28 percent of the total deposits of subsidiaries in the host countries, and KCB Group's subsidiary in DR Congo, Trust Merchant Bank, with total deposits of Sh180 billion or 14 percent of the total deposits of subsidiaries in the host countries.

The combined gross loans for the subsidiaries in the host countries stood at Sh725.8 billion as of December 31, 2022, an increase of 42.2 percent from Sh510.3 billion as of

December 31, 2021. The Kenyan banks' subsidiaries operating in DRC recorded the highest level of gross loans at Sh.244.5 billion accounting for 33.69 percent of gross loans in all the subsidiaries

Subsidiaries operating in Tanzania accounted for 20.37 percent of the gross loans. Uganda and Rwanda accounted for 17.16 percent and 16.53 percent of the gross loans respectively. Mauritius recorded gross loans of Sh73.1 billion accounting for 10.07 percent of gross loans.

In March it was reported that the Democratic Republic of the Congo (DRC) has handed Equity Group and KCB Group their largest and most profitable operations outside the Kenyan market with the market setting itself apart from subsidiaries in other markets.

An analysis of the bank's most recent set of financial results shows the DRC housed the operations with the most assets for both banks outside Kenya -and the most profitable unit for Equity in the region.

Disclosures by KCB for instance show the Trust Merchant Bank (TMB), which the lender acquired last year, held 13.5 percent of KCB's total assets of Sh1.55 trillion as of December.

Further, TMB is larger than the National Bank of Kenya which is a KCB subsidiary domiciled in Kenya.

NBK ranks as the second largest subsidiary for KCB ahead of BPR Rwanda which also represents a recent acquisition, KCB Tanzania, KCB Uganda, KCB South Sudan and KCB Burundi.

Kenya offers 100 dams to private investors in Sh1.7trn project deal

NAIROBI

KENYA has offered private investors a chance to invest in 100 dams and unveiled a set of land incentives as it seeks Sh1.7 trillion to address the country's water scarcity challenges.

Addressing investors at a pre-bid meeting, Water Cabinet Secretary Alice Wahome said some of the dams are on public land, including forested areas, and will not be sold to them to ensure the project retains its status as a national endeavour.

"The government plans to partner with private investors by offering land, as some of the dam sites are on government land, especially in forests. It is important to note that the government will not be selling land as the land and the entire project will remain under the jurisdiction of the national government," said Ms Wahome.

She said water scarcity has been a pressing issue, particularly in peri-urban, rural and marginalised areas, adding that through the adoption of Public Private Partnership (PPP) initiatives, the ministry intends to ensure that sustainable and reliable water services are accessible to every citizen.

She added, however, that with an investor on board, it will function as a joint venture during the construction and payback periods to ensure the investor's return on investment.

"Once the project is completed, it will be taken over by the national government. The government will implement this initiative through its Water Works Development Agencies, which will cover all nine regions of the country as a matter of priority," she said.

The 100 PPP dams initiative seeks private sector capital and technology through a design, build, finance, operate, maintain and transfer model.

The programme aims to provide safe drinking water to an additional six million households, bring one million hectares under irrigation and generate 554MW of hydropower.

"The Ministry of Water and Sanitation recognises the urgency of this challenge and understands that collaboration with the private sector is critical to effectively address it. Through PPPs, the Ministry can leverage the expertise, resources and innovation of the private sector to improve water infrastructure and service delivery," said the CS.

Investors have always shied away from the water sector due to low returns despite being capital-intensive.

President William Ruto said in September that private firms will be allowed to invest in water and sell to the national government

Under the proposed arrangements,

private firms will build dams and drill water to sell to State-owned water agencies which will supply it to homes and other public entities at lower charges. Water purchase deals with

the private sector will help the government to pursue capital-intensive water projects without relying on loans as the country moves to ease the debt burden that has squeezed funds available for development ex-

The PPPs will promote the adoption of innovative technologies and sustainable water management practices, including the implementation of efficient irrigation systems, rainwater harvesting and conservation.

By integrating technology and sustainable approaches, the ministry aims to optimise water use, reduce wastage and ensure long-term water security for the nation.

"The PPPs will prioritise the provision of affordable and equitable water services to underserved areas. By adopting innovative financing models and optimising operational efficiency, the Ministry aims to ensure that water services are accessible and affordable to all Kenyan citizens, irrespective of their socio-economic background," said Ms Wahome.

Amendments to the Water Act, she said, provide for public-private partnerships in dam construction, bulk water sales, a groundwater centre and asset transfer.

"Our target is three million acres; we have a total of about 670,000 acres, which is not enough to give us the food security that our country needs. The aim of the PPP programme is to provide water to six million households, doubling the current number," said the minister.

The Buhari Legacy: Killings without end, N77 trillion debt, 22pc inflation

LAGOS

IT may be wrong to assume President Muhammadu Buhari's legacy would be a subject of controversy.

No, it won't be like the bequest of many leaders, who had superintended over the affairs of nations

That might be a break from tradition as the legacies of national leaders have always been subjects of critical argument for analysts and scholars.

In Nigeria, to date, the Yakubu Gowon, Ibrahim Babangida, Olusegun Obasanjo, Umar Yar'Adua and even Murtala Mohammed years are often issues of robust debate, especially on national development, unity and growth.

In matching his promise with performance, historians and analysts may have an easy consensus on many aspects of his scorecard.

Put differently, it's unlikely the President's record would be open to more than one interpretation.

Buhari, who, in his inaugural address in 2015, had said, "Nigerians will not regret that they have entrusted national responsibility to us. We must not succumb to hopelessness and defeatism. We can fix our problems," is leaving behind an inheritance fraught with many puzzles.

Record-breaking

As his tenure ends at noon next Monday, the nation Buhari leaves behind is in sharp contrast with Nigeria he inherited from former President Goodluck Jonathan in 2015.

Observers believe Buhari's is a more divided, unsettled and impoverished Nigeria.

The President, who had premised his campaign on security, economy and anti-corruption, is believed to have failed on the promises eight years after.

He didn't resolve Nigeria's age-long socio-economic challenges, but under his watch, the nation witnessed record-breaking retrogression on several Human Development Indices, HDI.

His staunch supporters and the President himself had severally scored the administration high, but statistics say something different on the economy, security, anti-corruption, infrastructure and national unity among others.

ECONOMY: From 9pc inflation to 22pc

At the time Buhari came to power on May 29, 2015, Nigeria's economy wasn't the best of it as crude oil earnings had plummeted.

A barrel of oil sold at \$65 against the \$100 it attained under the Jonathan administration.



True COVID-19 death toll estimated at 14.9m'

COVID-19 has directly or indirectly killed 14.9 million people globally in 2020 and 2021, the World Health Organization said in its latest annual world health statistics report released on Friday.

As of March 11, 6.9 million deaths have been reported to the WHO. But the figure is seen by the global health agency as a significant undercount, as disruptions to healthcare services during the pandemic could lead to indirect life losses.

The WHO's analysis used mathematical modeling to calculate "excess mortality" for 2020 and 2021 – how many more people died than would normally be expected based on mortality in the same area if the crisis had not happened.

The true death toll includes deaths directly attributed to COVID-19 that were reported to the WHO, deaths directly

UN appeals funding to help people fleeing Sudan to Ethiopia

ADDIS ABABA

NEW DELHI

THE United Nations Office for the Coordination of Humanitarian Affairs appealed for additional funding to address the needs of people crossing into Ethiopia due to the ongoing security situation in Sudan.

The UNOCHA, in its latest situation update issued Friday, said some 85,0000 people are projected to enter Ethiopia from Sudan, with humanitarian needs forecasted to rise steeply in such a scenario.

"Additional financial resources are required to meet the current needs and the ongoing flow of arrivals expected in the weeks ahead," it said.

Figures from the UNOCHA show that between April 21 and May 16, more than 22,600 arrivals have been recorded from more than 64 nationalities at Metema crossing point in Ethiopia's northwest Amhara region. Metema crossing point is now receiving the largest share of people fleeing conflict in Sudan.

According to the UNOCHA, arrivals have been observed to have largely come from the city of Khartoum, the Sudanese capital, representing 76 percent of the total arrivals. Some 18 percent of them are said to be from the city of Om-

On Wednesday, the International Organization for Migration had launched a response plan appealing for \$209 million to provide humanitarian assistance to the people affected by the crisis and outbreak of violence in Sudan.

The UN migration agency said the deteriorating situation in Sudan is also having dramatic implications on neighboring countries, many of which are grappling with their own protracted crises.

Sudan has witnessed deadly armed clashes between the Sudanese Armed Forces and the paramilitary Rapid Support Forces in the capital city of Khartoum and other areas since April 15, with the two sides accusing each other of initiating the conflict.

Iran's Khamenei warns of foreign bids to cause tensions

TEHRAN

IRAN'S Supreme Leader Ali Khamenei said on Saturday that some foreign sides seek to cause problems in the country's relations with its neighbors, calling on Iranian officials to prevent the implementation of such policies.

The leader made the remarks in a meeting held in Tehran with the Iranian Foreign Ministry's officials as well as the country's ambassadors, elaborating on Iran's foreign policy principles and priorities, according to the leader's website.

US-manipulated G7 rips world apart, creates tension

AT the Group of Seven Summit starting in Hiroshima on Friday, the US-led clique is again hyping up their so-called "law and order," whereas political observers have precisely debunked the essence of their lies – a scheme to play small-clique politics and dictate to the rest of the world.

US undermining free trade

The G7 on Saturday issued a statement concerning economic resilience and security, threatening to counter "economic coercion," which will de facto divide the world into two markets and two systems in such areas as semiconductors and critical minerals under the pretext of reducing dependence on China.

As reported by the Financial Times, "the co-ordination on China follows two years of efforts by the Biden administration, helped by Japan." The United States is the main culprit in lulling its allies into unplugging from China, which constitutes a serious violation of the principles of free trade and market economy and will harm global economic develop-

The longer-term cost of trade fragmentation could reach up to 7 percent of global output and some countries could see losses of up to 12 percent of GDP in case of additional technological decoupling, the International Monetary Fund said in a report in January.

The United States has been trying

to jeopardize the Chinese economy through various means including trade wars, but the ever-growing China-US trade in itself demonstrates that US businesses and people need trade with China, Kazuteru Saionji, a visiting professor at Higashi Nippon International University, told Xinhua in a recent interview.

"By dragging the G7 bloc to suppress China under the pretext of de-risking this time, the country is conducting an atrocity deliberately undermining free trade and the world economic division of labor system," the professor noted.

Recent years have seen the G7, also known as "the rich club," suffering an irreversible decline of national power. The Japanese newspaper Nihon Keizai Shimbun reported that the G7's share of the global economy has fallen from nearly 70 percent in the 1980s to currently about 40 percent, which shows no sign of ceasing to decline.

The G7, with significantly weakening economic heft, is unable to represent the world, yet they have failed to face up to the general trend of the times and fixated on Cold War mentality, said Japanese political observers.

"The G7 has descended into a group of old-fashioned countries clinging to the so-called established international political order," said Atsushi Koketsu, emeritus professor at Yamaguchi University of Japan, adding that with the international community moving forward to pluralism, the G7's relentless efforts to University, pointed out that the United

Russia embarked on the path "of most dramatic confrontation with the aggressive bloc comprising the Unites States, the European Union and the North Atlantic Alliance."

"The objective was announced loudly and frankly, which is to defeat Russia on the battlefield,

and without stopping at this, to eliminate it later as a geopolitical rival, so to speak, along with any other country that claims an independent place in the world, they will be suppressed as opponents," the minister added.

The top diplomat also pointed out that the Western countries' expert community is overtly discussing the order to work out scenarios aimed at Russia's breakup, and "they do not conceal that the existence of Russia as an independent center is incompatible with the goal of the West's global domination."

Nuggets on brink of NBA Finals with 119-108 win over Lakers in Game 3

LOS ANGELES

NIKOLA Jokic was far from his usual dominant self while mired in foul trouble, and Jamal Murray cooled off after his scorching first half. The Denver Nuggets' big early lead disappeared entirely in the fourth quarter of Game 3, and the Lakers' home crowd was in a frenzy.

The Nuggets weathered every setback and calmly, methodically took control with a poise worthy of champions.

With one more victory, they'll finally get the chance to play for their first rings.

Murray scored 37 points, Jokic added 24 points and eight assists and the Nuggets rolled to a 3-0 lead in the Western Conference finals with a 119-108 victory over Los Angeles on Saturday night.

Kentavious Caldwell-Pope scored 12 of his 17 points in the second half against his former team for the top-seeded Nuggets, who have never been this close to the NBA Finals in 47 years in the league. Denver is making its fifth straight playoff appearance, and the ultimate stage is now just one win away.

"I learn a lot about this team every time we play," Caldwell-Pope said. "We have that dog mentality where no matter if we're up, down, we're going to continue to fight and play our game, and do it at a high level. We're going to continue to do that for the rest of these games."

Denver blew a 14-point lead in Game 3, but made a decisive 13-0 run in the fourth quarter to snap the Lakers' nine-game home winning streak since March 26, including seven straight victories since the regular season ended. The Nuggets excelled down the stretch with Murray and Jokic repeatedly running a two-man pick-and-roll game suggested by "Coach Jokic," according to coach Michael Malone.

"This group is capable of doing great things, and they believe," Malone said. "Belief is a very powerful thing."

No team has rallied from a 3-0 playoff series deficit in NBA history. Game 4 is Monday night in Los Angeles.

"I can't speak for the guys right now because I don't know what's going through all their minds, but I still (believe)," said LeBron James, who had 23 points, 12 assists and seven rebounds. "So it's time to go right back home and start to refuel and start the treatment process and recovery process and get ready for Monday. My mindset is always locked in."

Anthony Davis had 28 points and 18 rebounds for the seventh-seeded Lakers, who hadn't lost three straight games since early February. Los Angeles' prolonged, desperate surge ever since the trade deadline has finally run out of steam

against the powerhouse Nuggets, who have won five consecutive playoff games.

"They've been at the top of the food chain for a reason, and have a plethora of guys that can hurt you, as was on full display tonight," Lakers coach Darvin Ham said. "But you know, circumstances are what they are. Difficult, but not impossible."

James hit three 3-pointers after starting the series 0 for 13 from distance, and Austin Reaves added 23 points and seven rebounds. But Rui Hachimura was the only other Lakers scorer to crack double figures with 13 points, and they couldn't counter the Nuggets' balanced effort down the stretch.

"Our backs have been against the wall (for) probably about the last two months, maybe more than that since the trade deadline," Reaves said. "Swinging, throwing punches to fight to get to this opportunity. ... We can either come out Monday and go home, or we can fight for another day. And with the group of guys that we've got, I know what that answer will be."

Jokic's streak of four consecutive triple-doubles ended in a fairly quiet game for the two-time MVP, who got his fourth foul in the third quarter. But Murray scored 17 points in a dynamic first quarter following his 23-point fourth quarter two nights ago, and he had 30 points by halftime of Game 3.

Bruce Brown scored 15 points and hit a key 3-pointer down the stretch for the Nuggets before Jokic all but iced it on a 3-pointer with 3:17 to play.

The Lakers' passionate fans turned out in force for the 17-time champion franchise's first conference finals games at home since 2010. Los Angeles tried desperately to get back in the series, with James playing 43 minutes after spraining his left ankle in Game 2 on top of his already sore right foot.

But the Nuggets' flight to the coast didn't cool off Murray in the slightest: The Canadian guard poured in 17 points in the first quarter and had 26 midway through the second. Reaves racked up 15 points, three assists and three rebounds in the second quarter alone to keep LA in it.

Hachimura's 3-pointer early in the fourth gave the Lakers their first lead since the opening minutes, but the Nuggets took charge again in a rally highlighted by Brown's 3-pointer with 7:02 to play, after which he taunted the Lakers' bench with Los Angeles' own "Freeze" 3-point

D'Angelo Russell had another rough game for the Lakers, scoring three points on 1-of-8 shooting in 20 minutes. The Lakers' biggest addition in their trade deadline transformation has just 21 points in the series.

'Benefit of doubt' for Simba SC with Sundowns loss to Wydad Casablanca

AS the two continental tourneys veer to a close, results of upper rounds of the competition will reverberate on the local scene, as the manner in which a team is defeated is also evaluated by the prospects of the side which beat it. In that case a preliminary comparison makes Simba SC still the better side at the moment, much less owing to its recent derby win, but the continental run. Despite the awe about Young Africans SC reaching the final of the second tier tourney, questions abound.

For once, the local champions were edged out of the top tier tournament on identical results in home and away ties, losing 1-0 to Al Hilal, the Sudanese champions. Al Hilal then proceeded to exit at the group stage where Al Ahly and Mamelodi Sundowns were the two top sides, taking up the quarter finals, to be grouped with other winners, where for once Simba and Raja |Casablanca had both qualified. That was a net difference, as Al Hilal didn't survive in the later stages.

Plenty of hay has been made out of the fact that the local champions, once they relocated to the second tier tournament, proceeded to do wonders there. Part of the reason is that the format of the tourney favours early losers of the Champions League who are then 'relegated' to the Confederation Cup. Noticeably, later losers in the top tier tourney are no longer included in the later stages of the second tier tournament, which favours early losers; the bigger competitors are then excluded.

This method of doing things is in a way inherited from the upper organisations of global football, like the UEFA circuit and in a sense, FIFA itself. Draws are made where top teams face one another in lower stages of a tournament, like Paris Saint Germain encountering Bayern Munich in the round of 16 stage, while two Italian sides, AC Milan and Internationale Milan met in the semifinals. They had floored less imposing opposition like Benfica of Portugal, Italian champions Napoli, etc.

Simba comes in good mention in relation to upper-level results of the toptier tournament because the side which eliminated it on penalties has survived up to the final. That implies the Msimbazi Street side had what it really takes as those

who removed the side from the top tier competition have proved a hard nut to crack for the teams that remained. Mamelodi Sundowns have lately attested to this rule, which hands plaudits to the local contenders - in having contested with the best.

Some reflections at the end of the second semifinal tie between the South African and Moroccan sides were interesting as to what they may also tell or imply for the way Simba went out of the top-tier tournament. The Mamelodi coach talked at some length or say repeatedly on the experience that their opponents have in the competition, which comes to saying that they knew how to govern their time and their energy. They knew how to spot weaknesses and appropriately use them.

A supplementary illustration of the need for evaluation of opponents for realism as to a team's performance in the respective tournament is the way in which Yanga tossed out Marumo Gallants. The side then proceeded to lose 0-2 against Moroka Swallows and officially exited the DSTV Premier League, which suggests that Yanga winning by that margin at home, and then 2-1 in away encounter was no miracle. Encountering Wydad could hardly have produced that kind of outcome.

What was somewhat surprising was that the side which Simba found hardest to play with actually failed to demonstrate that ability at the upper round. It is Raja Casablanca which won 3-0 at 'Estadio Lupaso' and conceded a goal at the King Mohamed V Stadium back home, toasting a 3-1 win. The local side was definitely more comfortable playing Wydad than Raja, despite that it is Wydad which stood the quarter final grip, Raja losing against perennial Egyptian champions Al Ahly.

To the fans in the Msimbazi Street club rank and file, it is Raja who ought to have come at the top in the semifinal stage, as they were definitely a better side for the home team compared with Wydad. Yet soccer is not fully predictable, so Raja were not in a position to click

against Al Ahly, where this experience argument may be somewhat handy. The defending champions who are in the final and the perennial finalists and more often the winners, know how to find their way there.

Directed at the city rivals, this series of results tell something as to the relation between quality and experience, where quality determines the stage a team reaches, and experience enables it to handle a particular contest. Team quality provides the premise for readiness for tasks, ability to discern an opportunity and making use of it, while experience decides some tactical moves at a given moment. Where such moves involve the use of the last ten minutes for at least one more goal, it may as well be the proverbial 'last straw that broke the camel's back,' even with quality.

Thus the local champions had quality for the second tier despite lack of experience.

Yanga threatens Gor Mahia's 36-year-old record

AS per ethics allow me to grudgingly congratulate Young Africans SC for making their first ever CAF Confederation Cup final.

Yanga beat South African strugglers Marumo Gallants 4-1 on aggregate last week to sail through to the two-legged final set for the end of May and early June.

It's no mean feat for a club from Sub-Saharan Africa, and East Africa for that matter, to scale such heights in a competition known to be dominated by North Africans, like all others under CAF.

To hard-core Simba SC, Yanga's arch rivals, and Gor Mahia fans, it's a bitter pill to swallow, yet, there's only one known reward for proper planning and hard work; success.

Yanga has grown in leaps and bounds, and without a doubt deserves this moment of glory. You can't take it away from them.

Should they win the second-tier continental club championship against USM Alger of Algeria, then Yanga, or the

Wananchi as they are fondly referred to, will become the first Tanzanian club to do so.

What's more, they will shutter Gor Mahia's 36-year-old record of being the only East African club to have won a continental trophy.

K'Ogalo, as Gor Mahia is nicknamed,

bagged the 1987 African Cup Winners' Cup, then known as Mandela Cup, a bragging right they've worn with pride and cherished for over three decades, but which is now under real danger.

To rub salt into the wound, up to very recently, Yanga was no match for the record 19-time Kenyan champions.

In the 2018 Confederation Cup group stage, K'Ogalo hammered them 7-2 on aggregate

Yet, a series of structural and managerial moves a few years later, which saw them bring on board a strategic partner, has had Yanga morph into a local and continental juggernaut.

Meanwhile, sadly, Gor Mahia has regressed over the same period and is still steeped in maladministration and backwardness. The most you hear about the fallen giants lately are cases of players taking them to FIFA over contractual breaches.

However, Gor Mahia is just a reflection of how bad Kenyan football has become. Juxtaposed to Tanzania's Premier League, the Football Kenya Federation Premier League (FKFPL) is a far cry of what a proper league should look like.

Since 2016 when Supersport, the South Africa-based pay television behemoth, unceremoniously left the scene, FKFPL has operated without a broadcaster. On the other hand, NBC Premier League has enjoyed world-class coverage courtesy of Azam TV.

Azam recently gave Kenyans a taste of what they are capable of in terms of marketing a league and quality production when they acquired media rights for the Mashemeji Derby.

To say the least, they left many fans of Kenyan football, both local and abroad, who managed to catch the games using Azam TV mobile app, yearning for a permanent deal.

Haaland's appetite for goals fuels Man City's title triumph

LONDON

ERLING Haaland inspired Manchester City's Premier League title triumph with a record-breaking goal spree fuelled by his voracious appetite for success.

Haaland has taken the Premier League by storm since arriving from Borussia Dortmund last year in a £51 million (\$63 million) deal that already looks a bargain.

After scoring twice on his topflight debut at West Ham in August, the 22-year-old striker maintained an astonishing goal pace that left a trail of broken records in his wake en route to clinching the title on Saturday.

He shattered the Premier League's single-season goal record, netting 36 times in 33 matches to move beyond the 34 scored by Alan Shearer and Andy Cole in the 1990s. "If you were building a centre-forward from the ground up, Erling is what you would be left with. He's a goal machine," Shearer said.

The Norwegian has scored 52 times in all competitions, including one five-goal haul and five other hat-tricks.

While rival managers endure sleepless nights at the prospect of trying to subdue him, Haaland leaves no stone unturned in the pursuit of excellence.

Obsessed with staying in peak physical condition, Haaland claims his daily diet of heart, liver, milk and lasagne amounts to a whopping 6,000 calories.

Haaland even wolfed down a tray of nutrition-rich beef liver after scoring in City's recent win at Everton, declaring the meal "bloody lovely" after fans reacted with surprise to an Instagram post of his dinner.

"People say meat is bad for you but which? The meat you get at McDonald's? Or the local cow eating grass right over there? I eat the heart and the liver," Haaland said in a documentary about his move to Manchester.

Haaland has also created a "magic potion" milk smoothie, featuring kale and spinach, that forms a key part of his diet.

Haaland's father Alfie helps by milking cows back home in Norway and delivering the pints to the striker in Manchester.

There is no detail too small for Haaland to control as he aims to come. maximise his natural talent.

He installed a cryotherapy chamber in his house to help recover after matches and wears special glasses to reduce the sleep-depriving effects of screens.

- 'Best professional'

Despite his blistering form, there was speculation earlier in the season that Haaland might not be entirely happy after City coach Pep Guardiola admitted the striker was still adapting to the Spaniard's tactics during an inconsistent spell for

Guardiola's men won successive league titles playing largely without an attacking focal point and when Arsenal stormed ahead in the title race, there were claims City had been thrown off course by Haaland's arrival.

But Guardiola soon found the solution to balance the side as Haaland's deluge of goals never stopped.

"I love to play under Pep. I'm enjoying every single game," Haaland said. "It's hard, he demands a lot, but I try to do my best to develop."

Haaland's impact on City has been felt not just in the goal charts but also in the dressing room, where teammates have embraced his single-minded dedication to his craft -- even if it means missing a night out with Jack Grealish.

"He is the best professional I have ever seen," Grealish said.

"He does everything. Recovers. In the gym. Ten hours of treatment a day. Ice baths. Diet. I swear I couldn't be like that.

"We have a great friendship but he will point at me after a game and say: 'Hey. Don't you go out tonight partying'. "I just tell him to shut up and go and sit in his ice bath."

Although he relishes rewriting the record books, Haaland has made clear his desire is for trophies rather than personal milestones.

Having secured the Premier League title in his debut season, Haaland has his sights set on firing City to the treble.

They face Manchester United in the FA Cup final at Wembley on June 3 before heading to Istanbul to meet Inter Milan in the Champions League final seven days later.

City are looking to win the Champions League for the first time.

Yet even leading City to their European holy grail would be unlikely to sate Haaland's hunger to feast on opposing defences for years to

Wydad claw back twice to reach **CAF Champions League final**

HOLDERS Wydad Casablanca of Morocco equalised twice to draw 2-2 with Mamelodi Sundowns of South Africa on Saturday, and book a second straight CAF Champions League final against Al Ahly of Egypt.

Captain Themba Zwane and later Peter Shalulile put the home team ahead in a semi-final, second leg thriller watched by a 45,000 crowd in Pretoria.

But Ayoub el Amloud cancelled out Sundowns' first goal and an own-goal by Mothobi Mvala levelled the scoreline again, and gave Wydad an ultimately decisive aggregate advantage through away goals after a goalless stalemate in the first leg.

Record 10-time champions Ahly had a much more comfortable passage to the final, defeating Esperance of Tunisia 1-0 in Cairo on Friday to complete a 4-0 aggregate triumph.

Set to make a record-extending 16th final appearance in the premier African club competition, Ahly will host the first leg on June 4 with the second leg on June 11.

The 2022 final involved a single match and a couple of goals from Zouhair el Moutaraji gave Wydad a 2-0 victory over Ahly in a match controversially staged in Casablanca.

Ahly wanted the final played at a neutral venue, but an appeal to the Court of Arbitration for Sport (CAS) was unsuccessful. The drama led to two-leg finals being reinstated.

Recently-hired Belgian Vandenbroeck - the fourth coach of Wydad this season - said the experience of his players pulled them through in pursuit of a fourth Champions League title.

Experience told' -

"Sundowns were probably the better team over the two legs, but our greater experience and mental strength told," he said.

"Wydad against Ahly is going to be a beautiful final and I am hoping for the same outcome as last season.

"There is little to choose between two great teams, but I think playing at home in the second leg may give us a slight advantage."

Sundowns coach Rhulani Mokwena agreed with Vandenbroeck, saying: "The experience of Wydad was crucial - they were smarter in some big mo-

"I am bitterly disappointed, but the compliments I received from the Wydad coach have eased the pain a little. "You cannot buy experience - you have to learn from sad occasions like this. I cannot say when, but Sundowns will win the Champions League."

Moroccan Mohamed Ounajem and Shalulile had the best chances of a cagey first half before the match came alive on 50 minutes at a stadium Sundowns share with the Bulls rugby

Wydad were dispossessed in their half and Zwane took advantage to beat goalkeeper Youssef el Motie, who stood motionless as the ball hit the net.

El Amloud crept unnoticed into the box to level on 72 minutes with a header off a Yahya Jabrane cross only for Shalulile to put Sundowns back in front via a deflected shot seven minutes later. The tie-deciding goal came with seven minutes of regular time remaining as Mvala, attempting to clear a free-kick, headed into his own net.

Manchester City has proved unstoppable once again

A third straight Premier League title, and a seventh in 12 seasons, was clinched on Saturday thanks to Arsenal's loss at Nottingham Forest and represents one of the most dominant spells by a club in the history of English soccer.

HAALAND'S GOALS

It's surely the most astonishing debut season in Premier League history. Starting with the two-goal performance against West Ham on the opening weekend, Haaland has taken English soccer by storm. A mindblowing 36 goals, four hat tricks (including three in successive home games), scissor-kick acrobatics and a bunch of scoring records including the most goals in a 38-game or 42-game season. And Haaland could easily have gotten more had Pep Guardiola not chosen to bring the fearsome Norway striker off early at times to manage his fitness. Haaland has added a new dimension to Guardiola's attack, given he can play as a target man when City has possession and as a counterattacking weapon on the rare occasions the team is not dominating the ball.

TACTICAL SWITCH

Guardiola, the deep thinker and master tactician, has evolved his formation this season from a 4-3-3 to an innovative and fluid 3-2-4-1 lineup, essentially to accommodate the arrival of Haaland and make better use of City's dominance of possession. The change came midway through the season, with Guardiola first using Rico Lewis - an 18-year-old full back from the academy – as an inverted center midfielder in possession and a regular defender out of it. Eventually that hybrid role was

passed to John Stones, a ball-playing center back, and he has excelled in it. Indeed, City hasn't lost a match since Stones took up the role in late March. Joao Cancelo appeared to be the defender with the best skillset to fulfill the hybrid position but, unhappy at dropping out of the team because of poor form and after reportedly clashing with Guardiola in training, the Portugal full back was allowed to join Bayern Munich. It was a brave call by Guardiola, given the importance of Cancelo in City's buildup play in recent seasons, but it has been justified. The tactical switch also saw central midfielder Ilkay Gundogan and Kevin De Bruyne play further forward, ahead of Stones and Rodri, and they have prospered by going on scoring runs. GREALISH EMERGENCE

Jack Grealish was something of a letdown in his first season at City when he was, at the time, the most expensive player in the history of English soccer. His second year has been much, much better, to such an extent that he is now one of Guardiola's key players in adding an element of control to City's attacks and generating space for City's other offensive players to flourish. Grealish acknowledged it has taken time to get used to City's style of play compared to that of boyhood club Aston Villa, where he was the main man rather than one of many star players. "I came into City, having been at Villa my whole life, and I'd never had to change," he said. "I didn't realize how hard it is to adapt to a different team and manager." With five goals and seven assists, his numbers have

improved as well, and should continue to.

RODRI'S RELIABILITY

The reliability and consistency of Rodri as the holding midfielder and Guardiola's brains on the field cannot be overstated. In fact, he has proved once again this season that he might be City's most important player because of the way he shields the defense and starts attacks. The dependence on Rodri has increased because the guy City signed to be a backup anchorman in midfield following the departure of former captain Fernandinho appears to be out of his depth, for now anyway. Kalvin Phillips, who joined in the offseason from Leeds, hasn't been trusted to start a league game this season and only comes on when wins are secure and to give Rodri a breather. Guardiola might need to find another backup this summer.

ANOTHER STREAK

Once again, City has picked its moment to produce an end-of-season burst that blows away a challenger for its title. In recent years, it was Liverpool feeling the force of a long winning streak by City to close out a league season. This time it was Arsenal, which has buckled under the pressure of a fast-finishing City and ahead of the prospect of capturing a first league title since 2004. Arsenal was five points clear with a game in hand after City's 1-0 loss to Tottenham on Feb. 5. Since then, City has won 13 of its 14 games, only drawing the other after conceding a late goal at Nottingham Forest, to slowly and almost inevitably reel in Arsenal, whose young team started to falter. The 4-1 win over Arsenal on April 26 was a reality check for the long-time leaders and a muscle flex by City, highlighting the gulf between the two title rivals. City, as ever, has powered over the line.

Jose Mourinho is at it again: winning trophies and upsetting people

TWENTY years now since a Uefa Cup final in Seville in which the victorious Porto side rewrote the book on tactical time-wasting - from extensive treatment on injuries that mysteriously cleared up, to goal celebrations that seemed to go on for-

The opposing manager Martin O'Neill would later say of the time it took to treat Vitor Baia that he was surprised a helicopter was not called to fly the goalkeeper to hospital. The defender Jorge Costa was alleged to have hit the Celtic goalkeeper coach. The Celtic fans chanted that Porto were cheats as they went to get the trophy. "You know the way people get to a certain age and say 'Listen, I wouldn't change a thing'. Well, there's lots of things I would change," O'Neill said recently. "First of all, the Uefa Cup final of 2003."

Jose Mourinho, on the other hand, was very happy with the way it went. The young Porto manager's career was on an extraordinary upwards trajectory. All systems Jose.

Two decades later, he is back at the same place. The Uefa Cup final is now the Europa League final. The 2003 Porto, who would shock Europe by winning the Champions League 12 months later, are a skint 2023 Roma. They sold one of their best players to Galatasaray this season, but only because Nicolo Zaniolo did not fancy Bournemouth. Mourinho won the Europa Conference League last season and at 60 he is gloriously at it again. Winning trophies and upsetting people.

At Roma he has the power. At the Trigoria training ground, he is the biggest name in the building and his word is the law. If he says a player's Roma career is over, the club falls into line. In the case of the Dutch fullback Rick Karsdorp, there has been a reprieve - but only on Mourinho's

Tactically he still goes uber-Jose when required. The goalless draw in the Europa League semi-final on Thursday night, defending a one-

goal lead from the first leg, was sensational in its negativity. Roma had no attempts on target, and only one off-target, as opposed to 23 from Bayer Leverkusen. Less than 29 per cent possession. An xG of 0.03. That, as Mourinho would doubtless say, is football 'eritage.

The question now, as his hair goes snowy white, and his stubbornness endures, is: where next? His dance with the possibility of the manager's job at Paris Saint-Germain will be a fascinating end to the season. Of course, Mourinho must feel the pull of being at a club that is capable of punching others in the face for players, prestige, trophies. Yet for all Roma's unsuitability for doing that, they have a strange compatibility with

Roma has reminded us of something else too: Mourinho can make something of whatever raw materials are presented to him. As long as all involved are prepared to subject themselves to pure Jose-ism. It might not always be fun, but it does work.

Roma's US owners spent around €1 billion in the first three years on the acquisition of the club, investment and the salary of Mourinho and his technical team. Having done so they switched to a strategy of cheap - or free - signings and development players. Indeed, it was a goal from Edoardo Bove, 21, Rome-born and club-developed, that decided the semi-final. He started both legs and others like Ebrima Darboe, 21; Cristian Volpato, 19; and Benjamin Tahirovic, 20, have played games this season.

Post-victory, Mourinho said that no club had reached a European final spending as little as Roma had on transfer fees. He quoted €7 million although the figure is close to €9 million, with €7 million on the very decent Mehmet Celik from Lille. Kudos to the sporting director Tiago Pinto in whom a number of Premier League clubs are taking a keen interest. It is far from perfect. Roma are sixth in the league and lost both games to local rivals Lazio, who are in fourth and six points better off at the start of the weekend. Roma have lost twice to Cremonese. They do not score many goals and Tammy Abraham is among those not scoring. But as he did with Manchester United in 2015-2016, Mourinho has compensated for failings in the league by grinding out the Europa League and pursuing the Champions League place it offers.

At a club like United, with decades of success, Mourinho proved a bitter pill. At Spurs, with decades of believing they might be successful, that was equally hard. But at Roma there is a logic to it.

This is an intensely local, big club. Rome media directs fierce scrutiny on the team and specifically its local lads and then the Italian contingent in general. Those close to the club say Mourinho is unperturbed. Also, by making everything about him, or the referees, or the authorities, or other clubs, he diverts the gaze from his players. He has always been good at

Huge CAF prize money increase for Simba, Yanga

THE Confederation of African Football (CAF) announced on Friday that the prize money for the CAF Champions League and Confederation Cup will be increased by 40 percent.

CAF confirmed that President Patrice Motsepe has stuck to his promise of a "new prize money structure", which resulted in a 40% percent in-

"The announcement saw prize monies for the two competitions increase by 40% - in line with Dr Motsepe's commitment to making African football competitions globally competitive and self-sustaining," CAF explained.

"In the CAF Champions League, the winner will receive \$4 million, an increase from the previous prize of \$2.5 million. In the CAF Confederation Cup, the prize money for the winner has increased from \$1.25 million to \$2 million," the statement added.

As a consequence, Tanzania's Young Africans, who play USM Algiers in the final of the CAF Confederations Cup, have secured \$1 million (Tsh2.3 billion) already but that amount could double to \$2 million (Tsh 4.6million) should they manage to lift the trophy.

Young Africans made it to the final for the first time in their history after seeing off South Africa's Marumo Gallants in the semi-final on a 4-1

On the other hand, USM Alger punched their continental final ticket after beating ASEC Mimosas from Ivory Coast.

Nasreddine Nabi's charges finished on top of the Group D with 13 points after they secured a 0-1 away win against TP Mazembe of DR Congo while Rivers United finished runners-up behind ASEC Mimosas of Cote d'Ivoire to reach the last eight of the tournament.

They qualified for the semi-finals of the CAF Confederation Cup, beating Nigeria's Rivers United on 2-0 aggregate.

On Saturday they will host USM Alger in the CAF Confederation Cup final first leg at Benjamin Mkapa National Stadium before travelling to Algeria for the return leg on June 3 as they aim to lift their maiden continental title.

Simba, meanwhile, have secured \$900,000 (Tsh2.1 billion) for their run into the CAF Champions League quarter-finals.

They advanced to the quarter-finals for the third time in a row after finishing second in Group C behind Moroccan giants Raja Casablanca.

A 7-0 mauling of Guinea's Horoya and a double over Uganda's Vipers ensured Simba finished with nine points to confirm a place in the last eight with one game to spare, before being knocked by defending champions Wydad on a penalty shootout in Casablanca.

TFF extends NBC Premier League season

YOUNG Africans' CAF Confederation Cup commitments have led to the Tanzania Premier League Board (TPLB) to postpone their fixtures and therefore extend the 2022/23 NBC Premier League season to June 9.

Young Africans are set to face Mbeya City on Wednesday and Tanzania Prisons on Saturday, but these penultimate and endof-the-season fixtures have been postponed to allow the Tanzanian representatives ample time to prepare and also honour their CAF Confederation Cup final.

After their last weekend Federation Cup semi-final clash with Singida Big Stars at Liti Stadium, Young Africans will shift focus back to the CAF Confederation Cup final when they host USM Alger in the first leg on Saturday before travelling to Algeria for the return leg on June 3.

"The Tanzania Premier League Board (TPLB) informs you that all teams participating in the NBC Premier League for the 2022/2023 season will play their last games (round 30) on June 9, 2023 to allow Young Africans a chance to play its two final games of the Confederations Cup in Africa on May 28 and June 3, 2023 against USM Algiers," the TPLB statement said

"According to the schedule of the NBC Premier League sent to the club recently and announced to the public yesterday, the last games for all clubs (excluding Tanzania Prisons and Young Africans) were scheduled for May 28, 2023 but the Board has had to make the change after discussions internally focused on ensuring the presence of justice and equality in sports by removing the environment that may lead to match-fixing.

"The change goes in line with the change in the date of the 29th round games where all teams will now play on June 6, 2023."

The statement added: "The board is aware that the clubs started preparing for the games based on the previously announced dates and regretfully understands that these changes may affect the preparations in one way or another.

"However, the Board would like to inform the public that it has had to make these changes in the wider interest of the League and our football in general. The board wishes all clubs good preparation for the remaining games and all the best in completing the 2022/2023 season."

The league campaign is scheduled to end on June 9, with the curtain coming down on the campaign a week later with the Federation Cup final on June 7. The new schedule automatically also

shifts the promotion and relegation playoffs.

CAF set Afcon 2023 draw date as they approve WC 2026 qualifiers calendar

AFRICA Cup of Nations, Côte d'Ivoire 2023 draw date will be conducted on October 12, three months before the continent's flagship football event is held in the West African country, Confederation of African Football (CAF) has confirmed.

The decision to grant Ivory Coast the tournament's hosting rights comes after Morocco withdrew its bid to host the event in support of the West African country's candi-

The date was decided during the latest CAF Executive Committee meeting in Algiers.

Senegal, Tunisia, Burkina Faso, South Africa, Algeria and Morocco are the teams that have already qualified, joining the host, Ivory Coast.

The remaining group matches are set to be played during the June and September FIFA international breaks.

The tournament is set to kick off on January 13, next year and will culminate on February 11 at the Alassane Ouattara Stadium in Abidjan.

It will be the second time that the Ivorians are hosting the tournament, having staged the 1984 edition when Cameroon were crowned champions.

Meanwhile, the CAF Executive Committee noted its satisfaction with the progress and the level of preparedness by the host nation, seven months before the tournament starts.

CAF President Dr. Patrice Motsepe expressed his gratitude to the President of Ivory Coast, Alassane Ouattara, and the Prime Minister, Patrick Achi, for their cooperation and commitment to ensuring the successful hosting of the tourna-

Also, The Confederation of African Football (CAF) announced that its Executive Committee (EXCO) has approved the FIFA 2026 World Cup qualifiers schedule.

The Executive Committee also approved the format and dates for the continent's 2026 World Cup qualifiers. Aligning with FIFA's expanded World Cup format, the qualifiers will involve all 54 CAF member associations divided into nine groups.

The winners of each group will automatically qualify for the global tournament. Meanwhile, the four best runners-up from the groups will participate in a CAF Play-Off tournament, with the winner advancing to the FIFA Play-Off Tourna-

The official draw for the World Cup's African Qualifiers is scheduled for July 12, 2023, in Cotonou, Benin.

Matchdays 1 and 2 of the World Cup qualifiers will take place between November 13 and 21, 2023, followed by matchdays 3 and 4 between June 3 and 11, 2024.

Meanwhile, matchdays 5 and 6 are scheduled between March 17 and 25, 2025, followed by matchdays 7 and 8 later in the same year between October 6 and 14.

Matchdays 9 and 10 are scheduled between October 10 and 18, 2025, while the CAF Play-Off Tournament will take place between November 10 and 18, 2023.

Meanwhile, the FIFA Play-Off Tournament is set to take place in March 2026.
