



PRIME Minister Kassim Majaliwa yesterday directed the Ministry of Industry and Trade to fast-track indicative prices for cement, to control unscrupulous traders and agents from hiking prices of the product.

The premier also warned cement selling point agents to stop hiding the product for purposes of creating an artificial shortage, noting that cement dealers proved to hide cement will be arraigned with economic sabotage charges.

He issued the directive at a virtual conference with top regional administrators and those of the relevant ministries plus major cement suppliers in the market.

Those included in the virtual conference are regional commissioners, regional administrative secretaries, regional commercial officers, major cement suppliers, along with permanent secretaries of the Ministry of Trade and Industries, the Ministry of Works and the Ministry of Transport and Communication, with the meeting

Korea gives WFP 292.5 tonnes of fortified corn for refugee camps

THE World Food Programme (WFP) is to dispatch 292.5 tonnes of super cereal worth US\$300,000 (695.80m/-) to three refugee camps in Kigoma Region.

The consignment of corn soya blended with sugar from South Africa is meant for hundreds of families living in Nduta, Mtendeli and Nyarugusu refugee camps, who largely rely on the WFP food assistance.

The consignment arrived at the port of Dar es Salaam last week, following a donation of U\$300,000 dollars (695.80m/-) for the purpose by the Republic of Korea to WFP.

Accepting the humanitarian aid at a handover ceremony at the port of Dar es Salaam yesterday, WFP Country Director Sarah Gordon said the super cereal with sugar will be distributed to an estimated 242,000 beneficiaries and will cover their food needs for 24 days. Maalim Seif taking oath of office today

ZANZIBAR President Dr Hussein Ali Mwinyi is today expected to swear in Seif Sharif Hamad as First Vice President at the Zanzibar State House.

Maalim Seif was appointed on Monday to the post in line with the requirements of Article 9(3) of the Amended 1984 Zanzibar Constitution which provides for power sharing in the Isles.

Chief Secretary Dr Abdulhamid Yahya Mzee, who is also the secretary of the Zanzibar Revolutionary Council, said in a statement that the appointment took effect on Sunday, December 6.

"The Zanzibar Revolutionary Government system will be of national unity and its working will be in accordance with the procedure that ensures the perpetuation of the country's national unity to attain democracy."

The move has come after the opposition ACT-Wazalendo agreed to join the Government of National Unity (GNU) in the eighth phase government led by President Dr Hussein Ali Mwinyi.

Secretary General Ado Shaibu told reporters in Dar es Salaam on Sunday that members of the Central Committee of the opposition ACT-Wazalendo have agreed to the quest by Zanzibar President Dr Hussein Ali Mwinyi to become part of the GNU, considering that it is being formed with good intentions and for the interests of Zanzibar people and the country at large.

The party has allowed its cadres who were elected to be members of the House of Representatives, MPs

TPDF praises Ngerengere airport environment boost

THE Ministry of Defence and National Service has handed over a tractor and grass cutting machine worth 57.2m/- to the TPDF Air Force Command to facilitate cleanliness at the military airport at Ngerengere in Morogoro Region.

The Ngerengere military airport is one of the best specialised airports in the region, accommodating large aircrafts such as Boeing or Dreamliner passenger jets, following major rehabilitation in the past few years.

Speaking during the handing over ceremony yesterday in Dar es Salaam, Major General Kaisy Njelekela, the Judge Advocate General of the Tanzania People's Defense Forces said workers at the airport were using mowers to keep the area tidy, which is time consuming and ineffective.

Standing in for Permanent Secretary Faraji Mnyepe, the senior officer said the tractor worth 48.7m/- was bought by the ministry while the 8.5m/grass cutting machine was donated by the Chief of National Service, Major General Charles Mbuge.

The government recognizes the value of a modern military airport at Ngerengere, in which case its surrounding environment must be kept clean, he stated.

aimed at exploring the causes and stopping the hiking of cement price and availability of the commodity.

The premier asserted that indicative prices for cement will be essential as people need to know know the price of the product in their respective regions and that it remains stable to plan building activities.

"We cannot have cement sold at 28,000/- per 50kg bag in Morogoro Region while it has been produced in Dar es Salaam or Tanga Region. We need to control and set indicative prices to avoid those in peripheral regions purchasing cement at hiked prices," he stated.

He said the government does not need to form a committee to deal with the matter since there are specific ministries, regulatory institutions and supervisory departments that can resolve the problem smoothly.

Не directed the Fair Competition Commission (FCC) to conduct investigations on whether the current prices are competitive and reasonable, expressing concern that cement is sold at even higher prices in some parts of the country, thus causing inconveniences to users.

Cement has for a whole been sold at higher prices in various inland regions including Dodoma, Ruvuma, Simiyu and Tabora.

A 50kg bag of cement retails for 15,000/- ordinarily but data from the National Bureau of Statistics (NBS) for October indicated that the price had risen by 30 percent to 22,000/- in various parts of the country.

Many homeless as winds cause havoc in 3 Kyela villages

MORE than 108 households in three villages of Ipinda Ward in Kyela District Mbeya Region have after strong winds no homes damaged roofs of their houses including Ipinda secondary school.

Chairman of Kyela disasters committee Amos Kayembele said the incident occurred last week that saw some villagers being sheltered by neighbours while trying to repair their houses.

He mentioned the villages involved as Kafundo (with 35 households), Ikulu (16) and Ipinda (57) and added that Ipinda secondary school's classrooms, teachers pit latrines and a library.

He said as for now the committee was repairing public infrastructure at the school and called on villagers to embark on rehabilitating their houses.

Edward Mohamed, Ipinda Ward acting executive officer said they have started working with various stakeholders including cocoa farming investors to repair the secondary school's infrastructure.

Addressing a press conference here, he noted that the exhibition that started in 1993 had been held 28 times in six out of the eight agro-ecological zones. It is the first time the national exhibition will be held in the western zone. He said the farmers' exhibition have been held in the following in southern highland, northern highland, central, eastern, southern and lake zones.

The PS noted that in all the zones, the

He said the exhibitions were held at different grounds in the eight zones of Eastern zone (Mwalimu Nyerer-Morogoro),Central (Nzuguni-Dodoma) Southern (Ngongo Lindi) Southern Highlands (John Mwakangale-Mbeya), Eastern Lake (Nyakabindi-Simiyu),Western Lake (Nyamhongolo-Mwanza),Western (Fatma Mwassa-Tabora) and Northern (Themi-Arusha).

Meanwhile, the PS also observed that the ministry is working on a strategy to boost horticulture sub-sector in the country, being a directive of President John Magufuli.


He noted that the main focus is on how to improve horticulture, noting that to achieve this, the government has plans to purchase cargo plane to ease transportation of fruits,

He said the president emphasized the need for Ministry of Agriculture, Trade, Foreign Affairs, ambassadors and the private sector to find markets and sign contracts that will benefit the country.

He noted that in according to the president's speech, the horticulture is one of the subsectors in the country that are growing very rapidly, making Tanzania ranking 20th globally.

The PS explained that export of horticulture has increased from \$ 412 m/- in 2015 to \$779m/- in 2019. The existence of the East African Community(EAC) and Southern African Development Community (SADC) with a population of 500 million people is a big market opportunity for horticultural products.

TAWOMA out to inspire more women on mining

THE Tanzania Women Miners Association (TAWOMA) is considering empowering women to higher levels through mining, said the chairperson, Gilly Raja.

Raja who was recently elected into the position replacing the outgoing chairperson, Eunice Ngele also observed that the mining sector contributes immensely to the national economy but women are left behind.

Speaking after the association's election held in Dodoma, the new leaders came out strongly vowing to work on the challenges facing women miners in a bid to help them improve their livelihoods as well as boosting the country's economy.

The election which saw Raja emerging victorious on the position of chairperson, replacing former chairperson of the association Eunice Ngele, who led the association for the past five years. In that election, Salma Kundy was elected the Secretary General of the association.

Speaking after the election, the new chairperson expressed optimism that it was time for women to get out of poverty through mining, a sector that contributes immensely to the country's economy.

Currently, the mining sector's contribution to the Gross Domestic Product (GDP) is estimated at 4.8per cent.

"One of our main tasks is to lift women from poor to higher status of lives through mining," she said adding that there was a need to increase value chain in mining activities especially gemstones in the country.

In ensuring that TAWOMA seeks for market in the mining sector, she insisted, from now on, the association would start convening a series of meetings with women in the mining sectors and all stakeholders involved.

In the same note, the association's Secretary General Salma Kundy who was elected unanimously by members to serve for the second term said that her main task was to establish TAWOMA shops countrywide beginning with Dar es Salaam, Dodoma, Arusha and Mwanza.

According to her, the shops were vital in helping women miners to have market to their mineral products. "We want to make sure that we help women in the mining sector to get out of poverty," she insisted.

TAWOMA's vision is to eliminate poverty while creating new jobs for women and youths within the mining sector.

Founded on August 22, 1997, the association also supports the education of women miners on topics such as the dangers of mining, health and safety, and the use of chemicals, such as cyanide and mercury for gold mining, and its effects on their health and the environment.

TAWOMA's main purpose is to develop and promote women miners and mining communities and address the problems of disorganized mining including economic hardships, poverty alleviation and the general needs of members.

The association cooperates with various national and International organisations to achieve its goals. They include the Southern Eastern Minerals Centre (SEAMIC) and University of Dar es Salaam (Geology Department).

Others are Tanzania Chambers of Commerce, Industry (TCCIA), and Agriculture Tanzania Chamber of Energy and Minerals, Commission for Science and Technology (COSTECH), MTL Consultants Limited, Gemological Institute of America (GIA), PACT TZ, UNECA and the Small Scale Gemstone Mining Cluster.

Govt to spend 20bn/- to cement diplomatic ties, serving embassies abroad, official says

THE government is set to spend 20bn/- in this fiscal year to cement bilateral relations with other countries as well as serving embassies abroad.

Permanent Secretary Ministry of Foreign Affairs and East African Cooperation, Ambassador Brigadier General Wilbert Ibuge revealed this here yesterday when opening a five-day seminar on Public Procurement Act, 2011 and regulations 2013,

involving directors and heads of department in the ministry.

Speaking on his behalf, director of human resources in the ministry, Alex Mfungo said, Tanzania owns recommendations from the 106 buildings in foreign countries and 11 land plots, this reveals a sustainable relationship with other nations, hence there's a need to repair infrastructures to avoid ambassadors not depends on these economic projects or entered unnecessarily.

"I hope this seminar will enable proper use of the 20bn/- in improving our diplomatic matters as well as construction and

maintenance of our buildings in our embassies," he disclosed.

He said the government has considered needs and embassies that's why it decided to increase the budget from 4bn/- in 2019/2020 to 20bn/- in 2020/21 financial year.

Media key pillar in fight against GBV - activists

HUMAN rights activists have described members of media fraternity as crucial pillars in the national battle against genderbased violence in Tanzania.

"We cannot win this war if media people are sidelined," said Wallace Mayunga, Executive Director of a non-government organisation, The Right Way (TRW) during consultative seminar for TRW executives held in Dar es Salaam over the weekend. Organised by TRW, the forum is part of the commemoration of 16 days of activism against gender-based violence in Tanzania.

"Effective active and participation of media people and media outlets is more than important in the fight against GBV," stressed Mayunga.

Media people should be in the forefront if "we want to battle out the vice, which mostly affects women and female childrensubjecting them to untold

suffering and various forms of laws, setting up guidelines and violence," according to Mayunga.

Media information and investigative stories on various incidents related to gender based violence committed at the family, ward levels etc, helps the society to understand the magnitude of the problem, he said adding that "on the other hand, such information assist responsible government agencies to take correct actions and measures against perpetuators of these incidents."

"It's difficult to get to know how big the problem is without correct information...it is not ease for the government agencies to work on the problem without proper information on gender-based violence," said Mayunga, insisting that "such information needs to be traced and published by media people through their media outlets, including social media."

According to TRW boss, the government had taken initiatives in the fight against GBV by enacting

policies, but "implementation of these laws and policies would be "next to impossible" in the absence of active and effective participation of media peoplewho are responsible to investigate and dissemination stories on GBV incidents happening at the family, wards, district levels."

As part of its contribution the war against GBV, The Right Way has come up with a comprehensive and long-term strategy to equip primary and secondary school students (main victims of GBV) with requisite knowledge and education on issues related to gender-based violence.

of financial "Because constraints, we will start with few schools based in Dar es Salaam, covering five schools every month. However, as time goes on, the project will be expanded to other regions and ultimately reaching out to many schools countrywide," noted TRW

director.

An activist and human rights defender, Kidani Mhenga said "16 days activism against gender based violence should not be confined to the national forums only, but it's the duty of local leaders and society members to educative activities down to the grassroots levels....education on gender based violence should be a daily and regular activity, we should not confine ourselves to the commemoration of 16 days of activisms alone."

On her part, Coordinator of The Right Way, Mary Mihambo, proposed complete overhauling of operational systems, organs and regulations of various political parties in the country in order to get rid of "patriarchy systems" which discriminate against women-the main objective being to enable women participate effectively and efficiently in the political party-decision making processes and operations generally.

FOREST stakeholders have underscored the need for the government to facilitate investigative reporting in forest value chain so as to highlight the underlying challenges facing the sector for the decision makers to act on them.

national programme The coordinator for Forest and Value Chains Development Programme (FORVAC) in the Ministry of Natural Resources and Tourism Emmanuel Msofe said this over the weekend when speaking at the two-day media training in Ruangwa District, Lindi Region.

According to Msofe, media is a right channel to communicate the potential of value chains in the forest products economically and socially. "Investigative reporting in forest sector helps to broaden awareness to the public about the values of forest products and thus enable them increase conservation of forest resources, the reporting will also reveal the illegal acts that happen in the forests as well as to highlight the good development done by villagers in the forest," he said.

The training is part of the ongoing four years project dubbed; Forest and Value Chain Development Programme (FORVAC) 2018-2022 at a cost of 25bn/-, it is funded by the Ministry of Foreign Affairs of Finland and implemented by Ministry of Natural Resources and Tourism.

He added that, the government has been working hard on community based forest management (CBFM), but through FORVAC programme, the ministry is intending to increase awareness on the values of forest economically so as to benefit the community.

"We have been encouraging the government institutions working in forest sector to amend their laws and policies mainly to stimulate the

the media to join the efforts," he added.

Msofe said that Tanzania has more than 48 milion hectares of forests whereby 22 milion hectares are in the villages, while only 2milion are conserved by villagers a situation which calls for journalists to highlight the need for forest conservation through reporting.

"So far, the project has benefited more than 330,000 people based in Lindi, Ruvuma and Tanga regions, but the intention is to reach more people," Msofe added.

According to him, the project is working to increase the value chain in the forest products like wood, charcoal and others available in the forest.

Senior advisor for FORVAC Tanzania Juhani Harkonen said that they are happy after reaching 10 districts in the programme which is scheduled to end in 2022.

He mentioned the districts that have benefited from the programme as Ruangwa, Nachingwea, Liwale, Namtumbo, Mbinga, Songea, Nyasa, Mpwapwa, Handeni and Kilindi.

"We believe that FORVAC will stimulate the development of (CBFM), but the media have a great role to make sure that the initiative yields positive results," he emphasized.

Natural resources officer for Lindi Region, Zawadi Joseph said the authority in the region provide fully support to the initiative together with other institutions working to encourage sustainable forest conservation.

He said the region is having more than 900,000 hectors of forest which are present in 70 villages; the idea is to strengthen conservation of the forest and its products.

Joseph added that, through the project, they have managed to develop proper land use management plan that put boundaries of forest and village land.

Madaba District farmers earn 1bn/- from ginger

FARMERS in Madaba District, Ruvuma Region have earned more than 1bn/- from sale of ginger crop for the 2019/20.

Joseph Mrimi, the district's agricultural, irrigation and cooperative officer told this paper at the weekend from the sale, Madaba District Council earned 16m/- as levy from three per cent of income.

Mrimi said ginger production in the district topped 5,117 tons that was sole inside and outside the country. "We, at Madaba District Council have in place a strategy to add value to the crop as well as to increase production as its demand is high," he said.

He said the Council has set aside a total of 400 hectares for investment in various agro processing factories including ginger.

Bosko Komba, Madaba District Council economist said the Council has taken various steps to advertise the crop at the Nanenane Agricultural Exhibition in Mbeya Zone as well at Investment Exhibition in Ruvuma Region this year. He said already Tanzanice Company has pledged to buy ginger from farmers in Madaba and they expect in future the Council will get a big processor for the crop.

However, he said the Council plans to mobilise farmers who are able to cultivate and process the crop to do so, saying one farmer from Ifinga Village has come up and pledged to cultivate and process ginger.

He said it was the intention of the Council in cooperation with various stakeholders to buy and process ginger to enable it boost Madaba district's economy and Ruvuma Region in general.

Mbeya-WSSA needs 75bn/- injection from govt to have massive water project going

MBEYA Water Supply and Sanitation Authority (Mbeya-WSSA seeks 75bn/- from the government for the construction of Kiwira River water project which when completed will eradicate water problems in the region.

Edna Mwaigomole, Mbeya-WSSA board chairman issued the request during a visit by Mbeya Urban Member of Parliament Dr Tulia Ackson to various water projects in Mbeya City.

Mwaigomole said if the grand water project would be completed, the City's water woes would be history and spur industrial activities that need a lot of water.

She said the project's evaluation has been completed and what remains was funds to enable pumping water from the project site to Mbeya City and other districts.

"Mbeya City is the centre for economic activities in in the southern highlands zone, hence many such activities need water, also considering its fast growing population, hence the project is very much needed," said Mwaigomole.

She added: "We appeal to the government for assistance since the money involved is huge and we wanted to implement the project ourselves it will take us a very long time to complete."

Ndele Mengo, Mbeya-WSSA managing director said the project, when completed, will make Mbeya City to attain its water supply at 100 per cent as well as reducing water supply problems in the neighbouring Songwe Region.

He said other districts to benefit from the water project include Chunya and Mbarali.

Mengo said the project will have the capacity to produce 100,000 litres of water per day while Mbeya City's water supply requirement was only 70,000 litres per day.

He said as for now the City was facing a shortfall of 30,000 litres of water per day as the total supply from the city's all water sources include boreholes stands at 40,000 litres per day.

Speaking after inspection various water sources in the city, Dr Tulia Ackson said the project was huge hence she would work together with other MPs from areas to benefit from the project to jointly plead to the government for funds.

She said due to huge amount of money involved there was the possibility for the government to conduct research to satisfy itself before committing funds.

Huge improvements needed in quality and safety of medicines

science and practice of establishing the diagnosis, prognosis, treatment, and prevention of disease. Medicine encompasses a variety of health care practices evolved to maintain and restore health by the prevention and treatment of illness. Contemporary medicine applies biomedical sciences, biomedical research, genetics, and medical technology to diagnose, treat, and prevent injury and disease, typically through pharmaceuticals or surgery, but also through therapies as diverse as psychotherapy, external splints and traction, medical devices, biologics, and ionizing radiation, amongst others.

Medicine has been practiced since prehistoric times, during most of which it was an art (an area of skill and knowledge) frequently having connections to the religious and philosophical beliefs of local culture. Prescientific forms of medicine are now known as traditional medicine and folk medicine.

They remain commonly used with, or instead of, scientific medicine and are thus called alternative medicine. As an example, evidence on the effectiveness of acupuncture is "variable and inconsistent" for any condition, but is generally safe when done by an appropriately trained practitioner. In contrast, alternative treatments outside the bounds not just of scientific medicine, but also outside the bounds of safety and efficacy are termed quackery. This can encompass an array of practices and practitioners, irrespective of whether they are prescientific (traditional medicine and folk medicine) or modern pseudoscientific, including chiropractic which rejects modern scientific

EDICINE is the invisible subluxation of the bones, predominantly of the spine and less so of other bones), with just over half of chiropractors also rejecting the science of immunisation.

The Tanzania Medicines and Medical Devices Authority (TMDA) has launched a special project, which is aimed to foster medicine quality, safety, and ethical practices on clinical trials in the country.

Dubbed 'ASCEND-Moving clinical research Tanzania's ethics and medicines regulatory capacity to the next level', the two years and a half project will focus on strengthening systems and facilitate more clinical research.

Speaking during the project kickoff meeting held in Dar es Salaam over the weekend, TMDA director general Adam Fimbo said the project is expected to strengthen pharmacovigilance systems to increase reports on adverse events and reactions originating from clinical trials and establishing an effective system for information sharing.

Pharmacovigilance, also known as drug safety, is the pharmacological science relating to the collection, detection, assessment, monitoring, and prevention of adverse effects with pharmaceutical products.

He said the project also secured funds worth Euro 498,750 (1.4bn/-) from the European Development Countries Clinical Trials Partnership (EDCTP) whereby the process of funding acquisition began in October 2019, the acquisition process engaged Seven institutions.

He cited the seven institutions as Kilimanjaro Clinical Research (KCRI), Muhimbili Institute University of Health and Allied Sciences (MUHAS), National Institute for Medical Research (NIMR), Zanzibar Food and Drugs Authority (ZFDA), Zanzibar Health



IBERIANS are beginning to raise concern whether their Representatives are lawmakers or 'lawbreakers' as they allegedly ignored measures put in by the Liberian Government through the Ministry of Health in the midst of the Coronavirus in the country.

Will the election make any difference to corruption?

HE two front-runners in Ghana's 2020 election have weak records on tackling corruption. This leaves voters with little choice.

Make no mistake, Ghana is doing well. It's one of only four sub-Saharan African countries ranked "free" in 2020 on the Freedom in the World index that measures political rights and civil liberties.

In addition, Ghana has a strong and independent broadcast media and consistently ranks in the top three countries in Africa for freedom of speech and press freedom.

As for the economy, the West African country shows an "impressive story of economic growth," to use the words of the World Bank. In the past three decades, real GDP growth has quadrupled and extreme poverty dropped by half. There is little doubt that the country of nearly 30 million people is on course to lift its citizens out of poverty.

Ghana plagued by corruption It isn't all rosy, however. Pervasive corruption in the public sector is undermining Ghana's progress.

Thiscosts the country \$3 billion (€2.47 billion) every year, according to the Ghana chapter of Transparency International. That is a third of what the country needs to stop perennial flooding.

Corruption has long been a topical issue in the country, with corruption stories consistently making headlines.

And ahead of Ghana's presidential election on December 7, much of the discussion is about which candidate is potentially less corrupt.

A dozen candidates are running for president but only two are serious contenders: Former president John Mahama (pictured top right) of the National Democratic Congress (NDC) and the incumbent, President Nana Akufo-Addo (pictured top left) of the New Patriotic Party (NPP).

Akufo-Addo and Mahama have both only served as president for a single term, although both have also

been active in high-level politics for more than two decades.

John Mahama's administration hit by youth unemployment scandal

Let's start by looking at the corruption record of John Mahama, who was president from 2013 till January 2017.

In 2015, mid-way through Mahama's term, Ghana ranked seventh in Africa on Transparency International's Corruption Perceptions Index. That sounds good on the surface, but in fact Mahama's administration was hit by several corruption scandals.

In one of the biggest, an investigation by Ghanaian journalist Manasseh Azure Awuni in 2013 revealed that the government agency GYEEDA had spent nearly \$500 million on a program that was supposed to provide employable skills to young people. But 80% of the funds ended up in the pockets of politicians, their cronies and crooked business people.

The seeds for this scandal might have been sown under the previous NPP government. But Mahama failed to terminate corrupt contracts or prosecute the officials involved.

Nana Akufo-Addo accused of corruption

President Akufo-Addo, who won the December 2016 election, campaigned vigorously on the promise of fighting corruption.

A year after assuming office, he created the Office of the Special Prosecutor to investigate corruption, including cases implicating public servants and politicians.

The head of that office, Martin Amidu -- who resigned recently amid controversy -- is a leading member of the opposition NDC.

But in November 2020, after more than two years in office and with very little to show for this period, Amidu accused Akufo-Addo of corruption. Before the resignation of the special prosecutor, the auditor general Daniel Yaw Domelevo was placed on involuntary leave by the Akufo-Addo administration, effectively hounding Domelevo out of office.

Covid-19 has tested Africa to the limits – but there are signs of hope

HE Covid-19 pandemic is one of the most devastating global health and economic crises in modern history. The crisis has affected virtually every facet of socioeconomic functioning, including public finance, which is concerned with the capacity of governments to mobilise resources, primarily for building institutions to promote security, competition and market development, as well as for redistributive purposes.

The pandemic has significantly compromised Africa's state of public finance. First, it led to unprecedented contraction of tax revenue. Second, it placed extreme stress on public spending as governments struggled to respond to the health crisis, including increased funding for the health sector, social and business relief, measures to reduce and combat the spread of the virus and various other related needs.

Covid-19 poses tremendous challenges for Africa. However, it also offers opportunities for constructive change.

Challenges for public finance in Africa

The onset of the viral outbreak exposed and amplified existing weaknesses in public finance management in African countries. Inefficiencies and inequalities in the delivery of public services were magnified. The crisis also revealed a lack of preparedness when it comes to the ability to weather economic shocks and manage resources effectively.

Poor GDP Growth

The African Development Bank projects that real GDP growth could reach -3% in Africa due to the Covid-19 pandemic - a collapse of about seven percentage points from the growth rate achieved in 2019, the worst outcome in the region since the 1990s. Reduced GDP growth means reduced mobilisation of taxes, adding fuel to macroeconomic instability and burden of debt.

Given the weakened macroeconomic stability in Africa prior to Covid-19,



trade restrictions, regional lockdowns and other Covid-19 measures impeding economic activities further compromise fiscal sustainability in the wake of the crisis.

Rising debt levels

Despite a recent rise in debt levels, the Covid-19 crisis forced many African countries to borrow even further to cope with the increased demands. According to the World Bank, public debt in emerging markets has surged to levels not seen in 50 years. Not only has the crisis worsened fiscal deficits for African countries, but it limits future borrowing capacity.

This puts increased pressure on macroeconomic stability and fiscal sustainability, especially due to the need to continue dispensing large amounts of funds to combat the virus. The debt burden is further heightened by often high borrowing interest rates, exchange rates for foreign loans and other influential economic factors. Increased poverty and social needs

High levels of African populations across all sectors suffered loss of earnings as a result of the pandemic. The World Bank estimates that the Covid-19 pandemic will set back global poverty reduction goals by three years. The African Economic Research Consortium's (AERC) recent work in five African countries showed that policy responses to contain the spread of the virus, such as lockdowns, closing down of some businesses, travel and mobility restrictions and so forth, led to an increase in poverty levels that washed out gains that had been made in the past decade.

Most importantly, inequality worsened in the five countries as the burden of economic slowdown fell disproportionately on low wage earners, small business owners and casual labourers.

Opportunities and the way forward for Africa Despite the dire situation, it is not all doom and gloom for Africa. This crisis has also revealed opportunities for positive change. There are some measures that can help move the continent forward:

Fast-track reforms in public finance management aimed at tackling future debt burdens;

Citizen participation and support are also key to transformative solutions; Use the pandemic as an opportunity to

recognise the importance of having strong healthcare systems, including financing and access to resources;

Appreciate healthcare workers and the resilience they have shown during this period, and look at ways to improve earnings and benefits aimed at retaining skilled healthcare workers;

Improve ICT mechanisms relating to both the health sector and overall public services for enhanced communication and service delivery to citizens for both emergency and day-to-day needs;

Develop cross-country peer exchange systems that will allow countries to share information on response efforts with each other in real time, thus pooling knowledge resources and working together to help with Covid-19 reduction, as well as other healthcare, social or economic crises that might occur in the future;

Stimulate local and intra-African trade to reduce the shocks of global crises felt by the continent. As highlighted by the Organisation for Economic Cooperation and Development (OECD), a high dependency on imports in areas such as food, drugs, machinery and equipment over-exposed African countries to the economic consequences of the pandemic. Hence, we need to build infrastructural and trade frameworks to boost in-country and pan-African economic capabilities, and reduce our level of reliance on imports;

Explore the scope for instituting effective, comprehensive social programmes in Africa;

Foster better transparency and governance to improve trust in the rule of law, strengthen business conditions and encourage external support as key elements for developing a better future; and

Transformative domestic reforms to improve revenue mobilisation, digitalisation, trade integration, competition, social safety nets and climate-change mitigation will be critical for Africa's resilience, growth and job creation (IMF)

While the sheer destructive impact of the Covid-19 pandemic continues to resonate across the continent, we should not ignore the lessons learnt and the uplifting stories that have risen up through the crisis. Never have Africans come together the way we have during this catastrophic situation we have seen the best of humanity through this trying period.

International aid organisations, local charities and normal citizens showed compassion and care in helping out their fellow citizens. Healthcare and essential workers rose to the title of "hero" for the sacrifices they made to keep country processes going. African countries were lauded by our Western counterparts for the way we responded to the pandemic, including our swift action in imposing lockdowns. African governments did well overall when it came to educating the population on Covid-19 prevention measures, and hence helped save lives on a large scale.

The road ahead for Africa is difficult, and the challenges undeniable. But for us to overcome, rebuild and move forward stronger than ever, we need to take an inspired and solutions-focused stance, and work together for the benefit of the continent and its people as a whole.

Cold War back in the 1960s, a Peruvian diplomat, Dr. Victor Andres Belaunde, characterized the United Nations as a politically wobbly institution that survives only at the will- and pleasure- of the five big powers.

Simplifying his argument in more realistic terms, he said: "When two small powers have a dispute, the dispute disappears. When a great power and a small power are in conflict, the small power disappears. And when two great powers have a dispute, the United Nations disappears."

And more appropriately, it is the UN Security Council (UNSC) that vanishes into oblivion, particularly when big powers clash, warranting a ceasefire, not in some distant military conflict, but inside the UNSC chamber itself.

The only international body with the primary responsibility for the maintenance of global peace and security, the UNSC has often remained in a state of near-paralysis, particularly when the five vetowielding members (the P-5)namely the US, UK and France (in one corner) and China and Russia (on the other)– are determined to protect either their national interests, or the interests of political and military allies and client states.

As the New York Times pointed out last week, the world now has to cope with the new political realities of an "aggressive Russia" and a "rising China" which will continue to be reflected in the Security Council chamber.

After nearly 75 years in existence, one of the UNSC's biggest single failures is its inability to end the Israeli occupation of

The UNSC has also remained either frozen or failed to help resolve some of the ongoing military conflicts and civil insurrections worldwide, including in Syria, Yemen, Libya, Afghanistan, Myanmar, Hongkong, Somalia, Western Sahara, and most recently, Ethiopia, among others.

Stephen Zunes, Professor of Politics and coordinator of Middle Eastern Studies at the University of San Francisco who has written authoritatively on the politics of the Security Council, told IPS perhaps the biggest failure has been the UNSC's inability to effectively respond to the illegal expansion by some member states of their territory by force.

"It was such aggression by the Axis powers in World War II that led to the UN's founding and the categorical prohibition of such invasions in the UN Charter. Yet Israel and Morocco, protected by the veto power of allies on the Security Council, continue their illegal occupation and colonization of territories (Palestine and Western Sahara respectively) they forcibly took over". Similarly, he argued. Russia has effectively gotten away with its occupation of Crimea.

The Security Council, Zunes pointed out, was unable to enforce its resolutions regarding Indonesia's conquest of East Timor and apartheid South Africa's continued occupation of Namibia until global civil society campaigns forced them to eventually withdraw decades later. If the Security Council cannot even prevent member states from invading and occupying other nations, something that the UN's founders assumed the world body

Asked if big power rivalry, and protection of client states, were some of the reasons for the frequent deadlocks in the UNSC over the years, Zunes said the United States prides itself on the principle of the universal applicability of domestic lawthat is, the decision to uphold certain legal principles should not be based on an individual's politics, position, of personal connections.

tough sanctions towards adversarial nations regarding weapons proliferation, support for terrorism, and conquest of neighboring states while blocking the UN from taking any effective action towards allies guilty of the same offenses.

Meanwhile, he pointed out the United States and Russia have abused their veto power to protect Israel and Syria respectively from accountability for major violations of international humanitarian law. Ultimately, the failure is not with the United Nations system. It is the failure of the United States and other P5 members to live up to their responsibility as Security Council members to enforce the Charter and related international legal statutes based on their merit, not on narrow geo-political interests, said Zunes, a columnist and senior analyst, Foreign Policy in Focus.

Bozkir said last month the early appointment of the co-chairs should allow for Member States to start their consultations in a timely manner - and he encouraged delegations to look into starting the intergovernmental negotiations early in 2021 and increasing the number of meetings this session.

He said dialogue among Member States is the most effective way

Brenden Varma, Spokesperson for the President, told reporters the President hopes that, through active engagement of Member States and pragmatic approaches, "we would be able to make meaningful progress on this difficult issue". On the question of equitable representation and an increase in the membership of the Security Council, about 113 Member States (out of 122 who submitted their positions in a Framework Document), support expansion in both of the existing categories.

Currently, the UNSC has five permanent members and 10 non-permanent members who are elected to serve two-year terms on the basis of geographical rotation.

The potential candidates for permanent memberships include India, Japan and Germany, with South Africa or Nigeria (in Africa) and Brazil or Argentina (in Latin America). But any new permanent members are unlikely to have veto powers - a privilege only the P-5 countries will exercise as their "legitimate birthright".

But, considering the deadlock, and the implicit opposition from the P-5, what are the chances of significant changes in both the composition and working of the UNSC?

Asked if the current attempt at reforming the Security Council is just another exercise in political futility, Zunes said: "There is no serious chance that the P5 will allow these reforms to go through any time soon".

However, repeatedly calling attention to the undemocratic and unrepresentative nature of the Security Council is important to mobilize the world's governments and global civil society to press harder to make the United Nations live up to its mission, he declared.

Millions now denied right to education in Zimbabwe

HE education sector in Zimbabwe has been rapidly deteriorating, yet the government is unmoved. This year, because of Covid-19 and striking teachers, most learners have had no teaching at all. Inequalities in education have widened and education is becoming a luxury most people can't afford. What will happen to Zimbabwe's children?

In January 2020, teachers in Zimbabwe did not go back to work when schools opened. They said they were incapacitated, they did not have transport money to go to and from work and they did not have any money to buy meals to eat at work. They also said they could not afford to clothe themselves for work.

Not only that, teachers explained that with their meagre salaries, they could not afford to pay school fees for their own children at the same schools they taught at. They said they could not afford to buy uniforms, school shoes, stationery, textbooks and lunches for their school-going children. They also lamented about how they could no longer afford to pay domestic workers to look after their children while they were at work

There were endless negotiations between the several teachers' unions in the country but despite the back and forth, teachers and their employer (government) failed to reach a suitable compromise. Teachers decided they would go back to school, but they would only go on certain days. Some schools had lessons just once a week, others twice a week and the lucky ones got to have lessons on three days of the week.

The first school term of each year is important as that is when students in new grades are introduced to new syllabi and concepts. It is in the first term that students are introduced to new teachers and must familiarise themselves with those teachers' teaching styles. It is in the first term that teachers familiarise themselves with new learners and adapt to their capabilities, deficiencies and learning styles.

Zimbabwean students and teachers did not go through this process in 2020. Instead, the government through its state media - newspapers, radio and television - ignored the strike by pretending nothing was happening. They wanted to portray an image that all was well.

Children at private schools, however, were going to school as normal from January 2020.

In March 2020, due to the Covid-19

babwe Schools Examinations Council (Zimsec) examinations would be required to return to class on Monday 28 September to start preparations for their final examinations. All other grades returned on 9 November.

The majority of Zimbabweans are rural-based. They have no access to the internet because of poor network coverage as well as poverty, which means very few have smartphones or laptops with which their children can access online learning platforms. The majority of Zimbabwean rural areas are also not electrified.

The government announced that universities, colleges and schools were to hold lessons virtually during the lockdown period and there was an outcry from parents and students about how that was an impossible feat for students in the rural areas and poor urban dwellers who, even if they had smartphones, could not afford to buy data for their children to participate in virtual lessons.

In a bid to again portray a false image of normality, the government introduced radio lessons. These failed dismally to address the challenge as, again, rural learners were excluded as many have no radios or even electricity.

This means that between March and November 2020, the majority of Zimbabwean learners had no access to education.

During the same period, however, children in private schools were learning via the various online learning methods such as ZOOM and Google classroom. They were able to have virtual lessons and to do classwork and homework and submit assignments to teachers for marking.

The opening of schools on 9 November brought with it myriad challenges. Teachers again announced they were incapacitated, citing the same reasons as at the beginning of the first term. The government offered a 40% salary increase which teachers rejected and called a mockery. They vowed not to return to school until they were paid a decent living wage.

The 40% increment would have led to teachers earning ZW\$18,237 (about R2.500). Teachers demanded at least US\$520 (around R7,900) which is what they were earning before the government reverted back to the local currency

The government threatened to fire striking teachers and replace them with unemployed teachers desperate for work. One of the teachers' unions, the Zimbabwe Teachers Association (ZIM-

go back to work until their grievances were met.

Some teachers have gone back to work out of fear of victimisation as well as unemployment, but the majority just go to check in, but not teach. The government is fine with that situation as all it wants is to portray an image of normality, even at the cost of education.

Children of most of Zimbabwe's elite attend private schools and have not been affected much by the teachers' strikes and by Covid-19. Government officials in Zimbabwe also send their children to private schools, which could explain why they are neglecting the plight of public schools. Teachers and parents who speak out about the death of education in the country are victimised by the government and accused of being "regime change agents" who are paid by the West to destabilise the country.

The education sector in Zimbabwe has been rapidly deteriorating and the government is unmoved. In 2019, several schools reported a zero percent schools difficult.

In one school, the headmaster explained that most of their students could not afford exercise books so they could not make notes, they could not write down classwork and homework, making it difficult for students to remember concepts and for teachers to assess progress.

A teacher at another school explained that some of her students walked up to 15km to get to school. She said many of her students were too tired or hungry to learn as most of them walked these distances on empty stomachs. She said their school used to get donations of porridge and beans and learners could at least have a meal a day at school, but the school was no longer getting those food donations. She explained that the teachers were not motivated either because they too were hungry.

There is a crisis in education in Zimbabwe and the government is turning a blind eye. Covid-19 has made things worse with many schools closed due to a spike in Covid-19 infections. Schools were opened despite teachers explaining that they did not have adequate PPE and that most schools had no capacity to adhere to Covid-19 requirements. Learners in most schools have to share scarce resources such as textbooks and desks so physical distancing is almost impossible.

Due to water shortages, many schools have no running water so it is difficult to ensure consistent washing of hands. This is exacerbated by the shortage of funds to purchase hand sanitisers. Most parents cannot afford to buy their children PPE or hand sanitiser. To portray an image of normality, and to pretend there is no crisis in Zimbabwe, the government opened schools and the Zimbabwe School Examinations Council (ZIMSEC) announced examination dates.

Teachers and parents protested against the move to make learners write final examinations when the entire education year had been lost due to Covid-19 and the incapacitation of parents, teachers, schools and learners.

How can students who had not learnt anything since January write exams? How can exams proceed when many schools have been forced to shut because of Covid-19 outbreaks? Who will invigilate the exams considering that most teachers are on strike? How will physical distancing be managed, seeing as many schools do not have enough furniture and not enough classrooms?

Robson Chere, the secretary-general of the Amalgamated Rural Teachers Union of Zimbabwe (ARTUZ), says they have launched a campaign to help save education as the government is failing to prioritise this sector in Zimbabwe. He says education has been privatised, taking it out of the reach of most families.

Children of most of Zimbabwe's elite attend private schools and have not been affected much by the teachers' strikes and by Covid-19. Government officials in Zimbabwe also send their children to private schools, which could explain why they are neglecting the plight of public schools. Teachers and parents who speak out about the death of education in the country are victimised by the government and accused of being "regime change agents" who are paid by the West to destabilise the country.

What will happen to Zimbabwe's children as the government buries its head in the sand and ignores the plight of education in the country?

Education is a basic human right and to pretend all is well in the education sector, when nothing is well, is a human rights abuse. It is also unjust to have a situation where only children of the elite have access to quality education. All children deserve equal opportunities, especially in education

Persons with disabilities among worst affected by coronavirus

KATHMANDU, Nepal

HE 13th session of the Conference of States Parties (COSP) that was initially supposed to be held in New York back in June recently wrapped up with the final session coinciding with the International Day of People with Disabilities, whose theme, this year was on the issue of building back better inclusively.

In the context of Covid -19, this means creating accessible and sustainable post pandemic pathways of self-realization and prosperity for persons with disabilities. More than what it is normally thought, disabilities are not really isolated conditions affecting the few but rather the opposite.

Millions of people worldwide have their lives adversely impacted by them, often with ailments that are apparently invisible, if you think, for example, to all of us suffering of mental health.

The COSP therefore is very important for many of us and is undoubtedly the premier annual event centered on disabilities.

Its focus this year was on three related topics: inclusive job markets, the need to address the needs of older persons with disabilities and the promotion of inclusive environments for the full implementation of the Convention on the Rights of Persons with Disabilities.

These are big topics that should be find appropriate space on the major news outlets but instead the same COSP is just an "expert" meeting, a niche forum that is very far from receiving the due coverage that it really deserves.

At the moment of writing, no major news outlets have been reporting about it and neither other "powerful" organizations with global outreach seemed to care about it.

For example, on the main homepage of the influential World Economic Forum, I found a vast array of issues from the need to have leadership and trust to fight corruption to an op-ed piece by Imran Khan, the Prime Minister of Pakistan about leading by doing in climate action.

Yes quite understandably climate change is big for the World Economic Forum together with a focus on work diversity, a consequence of Black Lives Matter protests. Unfortunately, I could not find anything about disabilities.

The problem is the inability to connect the threads of social problems affecting the world.

For example, it is a huge missed opportunity not link-

ing the ongoing debate on how to make working places more diverse and inclusive of minority groups to the wider debate on the rights of persons with disabilities to employment and job security.

After all a global job market that is truly inclusive refers to wide opportunities for all members of minority groups, not just those who are more vocal and loud.

The idea of building back better that normally refers to more sustainable and eco-friendly solutions, from more environmentally friendly means of transportations to more efficient and cleaner energies, is set to play a determinant role if we want to achieve net zero emissions in the decades ahead.

While the 13th COSP focused on its last day on inclusive reconstruction and more accessible environment for persons with disabilities, there is an urgent need to link the rethinking of urban places with the overall prominence disability rights should receive in this global "building back better" movement.

It is not just about redesigning urban

spaces that are fully accessible while being eco-friendly and it is not only about better approaches to have more persons with disabilities in the work places everywhere, from developed nations to those still developing.

We need instead to frame one comprehensive and holistic strategy, from transportations to energies to jobs to affordable housing that is truly inclusive for all citizens, especially members of minority groups that have been so far often excluded from the economic gains of this world economic order.

Connecting the dots is the only way to really provide persons with disabilities and, very importantly, members of other vulnerable groups, with the opportunities to have fulfilling and meaningful lives.

Employment is so central in this equation and consequentially, only after achieving it, persons with disabilities and their "invisible" peers will become equal actors in the post pandemic order.

Some examples of disconnected approaches. In relation to better urban patterns, the global network of major global cities, C40 has leading a progressive agenda to reinvent urban spaces but again, accessibility and inclusion of persons with disabilities is not on their radar.

Also, within the United Nations, the New Urban Agenda is promising for its holistic inclusiveness that covers also the economic sphere but again we need major efforts to connecting the dots, including such agenda with broader development priorities, rather than keeping such strategy as standing alone framework in an already very fragmented development agenda.

The Sustainable Development Goals, SDGs, should help in this tactical exercise to frame and organize issues according to different priorities and agendas, linking together issues that only apparently seems disconnected.

How many of us are really aware of the New Urban Agenda? How many times did you read about it in the last 6 to 8 months?

As per Joan Clos I Matheu, the former Executive Director of UN Habitat, the United Nations Conference on Housing and Sustainable Development, Habitat III held in Quito in 2016 from where the New Urban Agenda stems from, we were supposed to moving towards "a new sustainable urban paradigm" back then. Four years forwards, only the most devastating pandemic of the century is forcing us to rethink our priorities and the way we want to live.

Yet no matter how inclusive urban spaces will be, real inclusion will

only happen when minority groups without much a voice on world stage, will be able to reclaim their rights to participation and economic prosper-

Inclusion is only one and multifaceted, let's not forget it. That's why events like COSP should have a much stronger visibility on the world stage. That's why International Disability Alliance should be supported to establish new partnerships with influential business and other lobbying organizations across the sectors.

Disability, after all, should not be just an "UN agenda" targeting diplomats and experts.

For example, the World Economic Forum's Platform for Shaping the Future of the New Economy and Society is a unique initiative that should be better resourced and highlighted 365 days a year, not just occasionally.

All of us interested and engaged in the disability sector, we need better public relations and better connections with the international media.

That's why Maria Soledad Cisternas Reyes, the Special Envoy of the Secretary-General on Disability and Accessibility and Professor Gerard Quinn, the recently appointed UN Special Rapporteur on the rights of persons with disabilities have their work cut out.

For them to succeed and become visible, they will need support, extensive resources to raise the issues of persons with disabilities on the global stage.

The goal is to make the next COSP a truly big deal for the world.

'Don't hide children with disabilities'

PARENTS having children with disabilities have been urged not to hide them at home instead help in giving them hope by ensuring they go to school.

Representing Kinondoni District Commissioner, Daniel Chongolo, Kawe Division Officer, Salum Chitale called upon parents having children with disabilities to grab the loan opportunities at the district office to be able to establish income generating activities.

He was speaking recently during an event to mark the International Day of Persons with Disabilities (IDPD) held at Antonia Verna children centre in Kawe, Dar es Salaam. The centre takes care of children with disabilities including youth.

The event was organized by the 'All Inclusive' project- a multi sectoral initiative fostering the inclusion of people with disabilities within the Dar es Salaam community. It was funded by the Italian Agency for Cooperation and development and implemented by Com. Sol in collaboration with Ivrea Sisters and other partners.

The law requires each of the districts across the country to set aside 10 percent of its internal revenues for issuance of loans to special groups including women, youth and the disabled.

"There are loan opportunities for people with disabilities and women at the Kinondoni district; grab them so that you can raise more income to take care of the disabled children and your families," said Chitale.

pervisor of the centre which includes a hospital and school, appealed for more support to be able to take care of children as the their number increases every day.

Sister Kaihura noted that the centre is need of nutritional food, medical supplies, health care providers and physical fitness exercise equipment.

Survey: Repeated waves of the giant African land snail invasion in Kerala

A recent study on the Giant African Snail (Achatina fulica) in Asia and Africa has found that the dangerous pest species had multiple episodes of invasion in India, particularly Kerala, and that new snail populations continue to arrive in India from snail-infested countries across the world.

The study observed that its population found in India had a higher genetic variety than those in the native African continent. "The higher genetic diversity found in our country indicates that the snail continues to have multiple invasions from different countries," said Keerthy Vijayan, assistant professor, Kalasalingam Academy of Research and Education (KARE), Tamil Nadu.

The study done along with researchers from the Environmental Agency, UAE; Nottingham University; and Natural History Museum, London; found the same genetic strains of the snail population in India and the UAE.

"The populations in India and the UAE share the same haplotypes (a set of genes within an organism inherited together from a single parent). The snail could be introduced repeatedly back and forth in the UAE and India, considering material movement between the two countries," said Dr. Keerthy.

Study period

Conducted at the Kerala Forest Research Institute (KFRI) with the support of the Kerala State Council for Science, Technology and Environment (KSCSTE) between 2016 and 2020, the study was published in the biological journal of the Linnean Society.

According to Dr. Keerthy, the snail reached Kerala for the first time when a researcher brought them from Annamalai University, Tamil Nadu, and accidentally released them at Elapully in Palakkad in the early 1950s.



Population spread

The snail population spread rapidly in the State, spurred by two more waves of invasion in the 1970s and in 2005.

The import of timber from two dozen snail-infested countries sped up their spread in Kerala. "In 2005, this snail was recorded only in Palakkad, Ernakulam and Pathanamthitta. But by 2020, it has spread to all districts except Idukki," said Dr. Keerthy.

One of the worst invasive species declared by the International Union for Conservation of Nature (IUCN), the Giant African Snail is suspected to spread eosinophilic meningitis, septicaemia and peritonitis in humans.

Many cases of eosinophilic meningitis were reported among children in Ernakulam and Thiruvananthapuram.

Dr. Keerthy said controlling this snail would be difficult because of its repeated invasions.

Editors vow to lead changes to ensure media are suitable amid Covid-19, digital disruption

KENYA'S editors have pledged to play their role in leading the changes to ensure media sustainability in the wake of the Covid-19 pandemic and digital disruption.

But they also called on the government to play its role in safeguarding media survival, through tax and other regulatory policies, including reverting to advertising directly, and reducing or removing the role of the Government Advertising Agency. The editors said in a statement that the government should also pay for the advertising services, which have remained as pending bills for years.

The editors requested that consideration should also be given to proposals to set up a media sustainability fund which has been discussed.

These were some of the resolutions reached at the end of the four-day Third Kenya Editors' Annual Convention in Kisumu. The theme for the Convention 2020 was: Redefining the Media in the Post Covid-19 Era.

The Convention had three training tracks, themed: Innovative Change: Management and Leadership in the 21st Century Media, Driving the Digital Culture in the Newsroom, Legitimacy and Elections: The Role of the Media in the Democratic Process.

The elections training benefited journalists from counties in the region, including Kisumu, Kakamega, Vihiga, Bungoma, Kisii and Nyamira, were trained on election reporting. The training was jointly carried out by the Kenya Editors' Guild, Elections Observations Group (ELOG) and the Independent Electoral and Boundaries Commission (IEBC). Editors were also

trained on how to develop innovative and transformational leadership to ensure they possess the knowledge and skills to handle current challenges. The editors also examined the opportunities and challenges brought about by digital technologies.

There were also discussions on the journalists' welfare, including mental health, newsroom safety, government and media relations during and post covid-19.

They said: "Training is critical for continuous development. New skill sets are necessary in a new media landscape, and newsroom culture that is dynamic. In the dynamic environment, knowledge and skills are important on how to adapt to the developments, and deal with both societal and newsroom changes.

On innovative change, they said: "A new type of leadership is necessary, and management skills are key to dealing with challenges that journalists are currently facing and what they anticipate in terms of innovative and transformational leadership."

On driving the digital culture in the newsroom, editors said: "It is important to note that technologies have disrupted business models, newsroom cultures and operations.

Journalists must thus develop visions and strategies that work for both the media houses and themselves. Journalists must find ways of appropriating technologies and making them work.

This includes developing new business models, new revenue streams, producing interesting and appealing content, which can be monetised to develop sustainable media keen to promote public interest."

'The great Covid-19 vaccine heist'

hy COVAX is a part of a bigger global health injustice and patent monopoly problem

So, 2020 is almost over, the Covid-19 pandemic is not. Worse, socioeconomic inequality, hunger and health colonialism have been aggravated.

Vaccine research has accelerated on an unprecedented, although welcomed, basis, with over 200 vaccine candidates in various stages of clinical research.

Early results from among a handful of vaccine candidates show some promise that in the medium term we could exit this pandemic, but perhaps not its devastating consequences.

Global health leaders have agreed that potential future Covid-19 vaccines must be considered a global public good and become the People's Vaccine. And last week, the UK government even issued emergency regulatory approval for one such vaccine candidate.

But it is one thing to have an approved vaccine, quite another to afford and have access to it, in an equitable fashion. This is because rich countries have pre-ordered enough doses to cover their populations several times over, leaving us in the global south with insufficient supplies for our populations in greatest need and at high risk.

In South Africa, this is exacerbated by our two-tiered health system which often benefits those with private health insurance, unless of course, the government steps in to develop an equitable access and allocation plan or framework.

Also, it is important to note that despite the pace of global developments and research, there is no clinically approved vaccine candidate for the South African market yet. And any commitment to purchase one or more vaccine/s will be speculative, even if necessary

This is because from among the range of potential vaccine products being investigated in many parts of the world, including South Africa, no one knows which candidate will work in the long term and for our context and health burden.

Nor do we know the full details of the cost of production and pricing determinations. There is only limited information, largely being pieced together by activists and journalists on the level of public funding and other forms of non-commercial investment in vaccine research, most notably the US government's Operation Warp Speed.

The South African government has spent public funds on vaccine clinical research (approximately R10-million) and has committed to "sign up" to COVAX.

For example, to give a sense of scale: MSF reports that vaccine candidates are benefit-



and Moderna.

Mariana Mazzucato, Henry Lishi and Els Torreele in Project Syndicate wrote that BioNTech received \$445-million from the German government, while Moderna was also given \$1-million by the Coalition for Epidemic Preparedness Innovations. The AstraZeneca-Oxford University vaccine research has been reported to have received more than £1-billion (about \$1.3-billion) of public funding.

In addition, while governments, philanthropists, multilateral institutions and drug companies have been working on researching vaccines, richer countries have also been "buying up" potential vaccine candidates. In other words, committing to advance purchase agreements, via bilateral agreements with drug companies, the terms of which are often secret. Recent estimates suggest that rich countries representing 13% of the world population including the US, UK, Canada and countries in the EU have bought up at least half of the world's global potential vaccine supply before these vaccine candidates have even been approved for use.

Like most poor countries around the world that did not have the resources and funds to behave in a nationalistic way, the South African government to our knowledge has not committed to any advanced purchase of any vaccine candidate with any drug company, yet. Richer countries, on the other hand, are buying hope and effectively have "VIP vaccine access". In some cases, by being guaranteed access, they have committed to a price, independently of their country's medicine price regulatory framework, and agreed to patent rights or even monopolies in advance by precluding the possibility of accessing a generic version over time either through public health crisis licensing negotiation or by issuing a compulsory license as sovereign state actors.

bought 3.8 billion doses from different vaccine makers, compared with 3.2 billion (which includes about 700 million doses via COVAX) for the rest of the world combined.

Even though there are at least four Covid-19 vaccine clinical trials being conducted in South Africa with potentially two vaccine manufacturing agreements (still being negotiated) to produce just two of the many vaccine candidates being researched globally and here, if they are eventually approved for use in South Africa, there is no guarantee of access, preferential pricing or supplies for South Africans and other global south countries or populations in need either. No one has seen these agreements (or drafts) and we have not been assured as a nation, that if we manufacture certain vaccines in East London, that East London and other parts of South Africa will benefit too - in terms of supplies and no profit pricing.

Alongside the bilateral contracting taking place between richer countries and drug companies, COVAX (the Covid-19 Vaccine Global Access Facility), a new global financing mechanism that is being coordinated by Gavi, the Vaccine Alliance and the Coalition for Epidemic Preparedness Innovations (CEPI) was established in the context of the WHO's Access to Covid-19 Tools (ACT) Accelerator Initiative.

About two weeks ago, it was reported that South Africa missed the deadline for signing up to the voluntary COVAX facility. Last week much was made (in error, in my view) of the COVAX imposed "payment deadline" being missed by our government - following on from a public commitment by the South African Minister of Finance to contribute at least R500-million to COVAX, presumably to secure some supplies of a potential vaccine, one day.

Because COVAX is a pooled negotiating mechanism, not a company, or supplier, it is incapable of being subject to public tender and procurement rules or PFMA norms - not just for South Africa, but for many countries with strict public procurement rules. Not all countries have signed on to COVAX

yet, and not all drug companies are participating in COVAX exclusively either (in other words, in a global pandemic, countries and companies are hedging their bets, by pursuing bilateral pre-purchases). It is also unclear whether COVAX will continue beyond 2021, whether low, or no profit price agreements are temporary or if they terminate mid-2021 or December 2021 or rather when each individual drug company "deems" the pandemic being "over". This has opened-up an important debate about COVAX itself - where however well-intentioned it may be, it now yields extraordinary global power, and only recently agreed to civil society representation on its structures after organisations such as MSF and others advocated for this.

In respect of South Africa and COVAX, media reports last week suggested that the Solidarity Fund will pay the "COVAX commitment fee" because of PFMA and other considerations that led to a delay in the payment. COVAX limitations aside, the Solidarity Fund, which is being treated as a private funder, may now be involving itself in highly complex vaccine selection and procurement acquisition processes with COVAX - itself an imperfect voluntary structure.

Because we live in a time of great anxiety, it is understandable that people around the world want their governments to be part of initiatives such as COVAX. But countries such as South Africa, regarded (wrongly, I believe) as "middle income" countries (MICs) do not qualify for subsidised support in COVAX and have to self-finance their participation. Low-income countries (LICs) are eligible for support mainly by virtue of ODA and philanthropic support to COVAX, but only for limited dosages and supplies that many reports indicate is likely to only vaccinate up to 20% of their respective populations, when herd immunity requires much greater population coverage. MICs are also being asked to self-

and allocation, then unfortunately, COVAX may not alone lend itself to that. Because everyone, everywhere will not be guaranteed vaccine access as things stand. While we advocate that vaccines and other interventions that could save lives in this pandemic be regarded as "global public goods" and while our president promotes "the people's vaccine", even with COVAX, the public does not own the intellectual property yet, nor have governments around the world retained the rights to "determine adequate production, supply and allocation", or compelit. Without that, drug companies can determine which country gets supplies and when, at what price as well as the quantities.

Instead, what we need is a global equitable allocation process and plan - and for states to reassert their authority and mainly, exercise powers that could guarantee equitable access and allocation in a public health crisis. This includes restrictions on patent monopolies.

Interestingly, because of the concern about the undue exercise of monopoly rights in a pandemic, in October, South Africa and India submitted a joint formal request for a waiver from certain provisions of the TRIPS agreement (agreement on Trade-Related Aspects of Intellectual Property Rights) for the prevention, containment and treatment of Covid-19 for the duration of the pandemic. Support for the request is growing including from several developing countries. Small village in China's mountainous area shakes off poverty, marches towards prosperity

TH 3,439 mu (about 229.27 hectares) of woodlands, 502 mu of arable land, annual average temperature of 23 degrees Celsius, and annual precipitation of 1374 millimeters, Manbansandui hamlet located in the mountainous area of southwest China's Yunnan province is a place where "whatever sowed can flourish".

However, such a great place for growing crops was classified as severely impoverished village in 2014.

As a natural village of Mannan village in Bulangshan township, Menghai county, Xishuangbanna Dai autonomous prefecture of Yunnan province, Manbansandui hamlet is inhabitated by people of Lahu ethnic group, who experienced a dramatic change in society from primitive society directly to socialist society after the founding of the People's Republic of China.

After two times of relocation and years of construction of supporting facilities, villagers in Manbansandui hamlet now live in wooden stilt houses.

The per capita net income of residents in the hemlet jumped from 350 yuan (\$53.2) in 2008 to 2,380 yuan in 2014. However, it was still below the national poverty line in 2014.

"One of the major causes of poverty was low level of education," said Luo Zhihua, head of the poverty alleviation working group stationed in Manbansandui hamlet.

Almost none of the villagers above the age of 16 has been to school, and most of them do not understand and cannot speak Mandarin Chinese, according to Luo, who added that most of the 58 residents in the village have never left the village.

Since they were dispatched to Manbansandui hamlet at the end of 2015, Luo and his fellow team members have made continuous efforts to help improve the literacy of the locals, change their outdated ideas and notions, and enhance their initiative in seeking development.

Besides hunting and gathering food, villagers in Manbansandui hamlet also grow tea, transplant rice seedlings, and raise pigs.

In the eyes of Luo, villagers took a laissez-faire attitude toward the crops they planted in the past. Their tea trees were of old varieties, and they never made plans for growing and simply let nature take its course. Besides, they neither watered nor weeded their rice fields.

The poverty alleviation working group then adopted the approach of unified organi-

zation, management and sale for farming, and helped villagers gradually learn and get used to more scientific methods such as introduction and breeding of new varieties, fine planting, weeding and fertilization.

Over the years, villagers of Manbansandui hamlet have tasted the fruits of the new production modes.

Rice and corn are now grown in two seasons in the village, instead of just one in the past.

The rice yield per mu has increased from 299 kg to 560 kg. Since the annual rice output of the village can support villagers for three years, Manbansandui hamlet no longer needs relief grain from government.

At the same time, the tea planting area of the village has grown from 60 mu to 460 mu, generating an average annual income of 1,165 yuan for each household.

The family of Nasi, a villager in the hamlet, now owns 8 mu of rice paddies, 4 mu of cornfields, and five pigs. The family of seven sees good rice harvest every year. The rice they collect is always more than they could eat. They feed their pigs and chickens on corn.

Nasi and her husband hold high expectations of their new tea garden, which covers an area of nearly 30 mu and will be ready for picking tea leaves next year.

The couple received training in tea picking and raw tea processing from a factory under Taetea Group, world's largest Pu'er tea group. Nasi's husband even took part in a tea art competition in Menghai county.

"Tea produced in Bulangshan township is famous. Many bosses outside the village have contacted me via WeChat to buy tea," Nasi said happily.

The poverty alleviation working group has organized cultural training for young and middle-aged residents in the village.

Villagers aged between 18 and 45 years old all came to take part in the training, said Li Huobao, a member of the poverty alleviation working group.

"We started by teaching them how to hold a pen correctly. Eventually 15 of them received a certificate for Mandarin training," Li added.

In an effort to encourage villagers to take part in activities such as improving the living environment and transforming social traditions, and change their old-fashioned ideas and living habits bit by bit, the working group has also established a shop that allows villagers to exchange the credits they gained because of good behavior for daily necessities.

So far, Manbansandui hamlet has basically shaken off poverty. All registered poverty stricken households in the village have been freed from worries over food and clothing and have access to compulsory education, basic medical services and safe housing.

In addition, many residents in the hamlet have learnt to use short video platform Tik Tok, shop online, and contact tea buyers via WeChat.

Villagers of the hamlet have also started to show their talents in cultural activities and celebrations held by Bulangshan township and Xishuangbanna Dai autonomous prefecture.

AU Member States underscore need to start trading activities under AfCFTA

AFRICAN Union Heads of State and Government have underscored the urgent need for member states to kick-start trading activities, under the African Continental Free Trade Area (AfCFTA).

The decision was adopted during a virtual meeting of the 13th Extra Ordinary Session of the Assembly of the Union on the AfCFTA, held on Saturday 5 December 2020, under the Chairmanship of Cyril Ramaphosa, President of the Republic of South Africa and Chairperson of the African Union (AU).

The summit is taking place just four weeks before the AfCFTA commences trading on the 1st of January 2021, to consider the adoption of the legal instruments that will facilitate its operation.

Welcoming all the participants to the 13th Extraordinary Session of the Assembly of the Heads of State and Government of the African Union, Chairperson Ramaphosa said "today we stand on the cusp of a new era in the progress of our continent.

The moment that we have all been working painstakingly towards has finally arrived...We are all filled with a great sense of pride at how far we have come to reach this moment".

The AU Chairperson further recalled the collective journey embarked upon over four decades ago, with the adoption of the Monrovia Strategy in 1979, followed by the Lagos Plan of Action in 1980, the Abuja Treaty in 1991 and the subsequent Decisions and Declarations adopted during previous Summits relating to the economic development and integration of the African continent.

"And now, we are about to witness the realisation of one of the flagship projects of Agenda 2063." Stated the Chairperson of the Union, with great relieve.

"Throughout this process, we have stood united, with 55 sovereign AU Member States rallying together, despite different levels of economic development and diverse strategic priorities. The commencement of trading under the AfCFTA on the 1st of January 2021 is one of the most significant milestones in the continental integration project, " the UN chairperson noted.

He underlined that, this is going to be the clearest affirmation that Africa is determined to take charge of its own destiny, and that its success and development is fundamentally tied to harnessing the potential and energies of her citizens.

According to President Cyrl Ramaphosa, the AfCFTA will boost intra-African trade, it will promote industrialisation and competitiveness and contribute to job creation, and it will unleash regional value chains that will facilitate Africa's meaningful integration into the global economy.

The AfCFTA will also improve the prospects of Africa as an attractive investment destination. It will help advance the empowerment of Africa's women, by improving women's access to trade opportunities which will in turn facilitate economic freedom for women, and expand the productive capacity of countries.

"To support this, we must strengthen women's participation in the continental economy by ensuring there is greater public procurement earmarked for womenowned businesses. We must ensure that there is sufficient support given to women-owned SMMEs and cooperatives in both local and regional economies" Emphasised Chairperson Ramaphosa.

Moussa Faki Mahamat, Chairperson of the AU Commission on his part expressed satisfaction on the millstone achieved in the implementation of the AfCFTA.

He said it is the fulfilment of the dream long aspired by the founding fathers of the Organisation of African Unity (OAU), who have always wanted to create an African common market.

Moussa Faki noted that, for this dream to finally become a reality, this continental project had to go through several stages. First was the signing in 1991 of the Treaty establishing the African Economic Community, followed by the signing in March 2018 in Kigali, Rwanda, of the Agreement establishing the AfCFTA, during which 44 countries signed the Agreement, and it is with great satisfaction that in record time 34 countries have ratified the legal instrument on the AfCFTA .

This, the AUC Chairperson said, shows the determination by member state to quickly achieve the economic integration of the continent.

Speaking from the headquarters of the AfCFTA Secretariat in Accra, Ghana,

NAIROBI County government is staring at total service paralysis on Governor Mike Sonko's refusal to authorise withdrawal of cash from City Hall's accounts.

This as the budget impasse between Sonko and the county assembly continues with the county government unable to implement the Sh37.5 billion budget.

City Hall employees, MCAs and assembly staff have not been paid salaries for the last two months because of the stalemate.

The budget was passed by ward representatives (MCAs) in October but the governor declined to assent to the Nairobi City County Appropriations Bill, 2020 referring the bill back to the assembly through a memorandum.

The memorandum was later rejected by the assembly on November 3 and the bill gazetted into law a week later.

The contested budget allocated Nairobi Metropolitan Services (NMS) Sh27.1 billion, leaving Mr Sonko's administration with Sh8.4 billion and the county assembly with Sh2 billion.

Nairobi County government has been using Vote on Accounts, which allows it to access 25 percent of the annual budget or approximately Sh8.5 billion - to run its recurrent expenditure since June.

However, this was stopped last month by the Controller of Budget Margaret Nyakang'o after the passage of the budget. Sonko's spokesperson Ben Mulwa confirmed that use of the Vote on Account was stopped leaving the county government unable to run both recurrent and development expenditure until the new budget is uploaded to enable release of funds to the county.

He said the contested budget cannot be implemented without Governor Sonko signing warrants - a document authorising withdrawal of funds from the County Revenue Fund.

The National Treasury, Controller of Budget and Central Bank require the warrants to implement a budget, the abscence of which has left the Nairobi county government technically grounded.

"Everyone is stuck and we cannot move because without the warrants, funds cannot be withdrawn. Everybody is grounded. MCAs and county staff are likely to stay without salaries for the next six months as it is impossible to pay them without the budget," Mulwa said.

Nairobi County Assembly Speaker Benson Mutura faulted the governor for the impasse, likening Mr Sonko's refusal to holding MCAs, county staff and residents at ransom.

"No one can access any fund, not the assembly, NMS or Nairobi County government. That is the problem we are currently facing. We are staring at a paralysis just because the governor has not signed the warrants," said Mutura. the Secretary General of AfCFTA, Wamkele Mene stressed that integrating 55 markets will not be easy but giving up is not an option.

He recalled that in August 2020, the Government of Ghana officially handed over the AfCFTA Secretariat building to the AUC Chairperson, Moussa Faki Mahamat. Reiterating that, H.E. President Akufo-Addo has given his full support and is committed to see the AfCFTA truly commercially start off trading by the announced date of 1st of January 2021.


"Today, 54 countries have signed the agreement while 34 countries have deposited their instruments of ratification, and 41 countries/customs unions have submitted their tariff offers, including the EAC and ECOWAS" underlined the AfCFTA SG. He however noted that, none of this remarkable progress would have been achieved without the unwavering leadership and commitment of President Mahamadou Issoufou, the Champion and Leader of the AfCFTA".

SG Wemkele called on AU Member States to aggressively implement the AfCFTA as one of the tools for effecting a fundamental structural transformation of Africa's economy and placing Africa on a path of long term industrial development.

He said; "women in trade, young Africans and SMEs, confront significant challenges when attempting to benefit from trade agreements". Adding that, for the AfCFTA to be inclusive and to ensure shared growth across the continent; women, young Africans and SMEs have to be at the heart of its implementation.

Worth recalling that it is the AU Assembly Decision adopted at its 33rd Ordinary Session held in Addis Ababa, Ethiopia, on 9th - 10th February, 2020, that recommended the holding of this 13th Extraordinary Summit to approve all instruments required for the start of trading under the AfCFTA.

During the meeting, the Heads of State expressed their appreciation to the report presented by Issoufou Mahamadou, President of the Republic of Niger, the leader and Champion of the AfCFTA, and adopted the recommendations thereof on the progress achieved on the establishment of the African Continental Free Trade Area (AfCFTA).

Rolls-Royce kicks off disposal plan with nuke instrument sale

BRITAIN'S Rolls-Royce has signed a deal to sell its civil nuclear instrumentation and control business for an undisclosed sum, kicking off a plan to raise 2 billion pounds (\$2.65 billion) from disposals to recover from the pandemic.

COVID-19 has shattered the aeroengine maker's finances because it is paid by airlines on a flying-hours basis. It has raised 2 billion pounds from shareholders, taken on new debt and said it will raise another 2 billion pounds from selling off units.

The company has said it wants to sell its Spain-based ITP Aero business, and analysts have said smaller disposals will make up the remainder of the target.

Rolls-Royce said in a statement on Monday that it had agreed to sell its I&C business, which has operations in France, the Czech Republic and China and employs 550 staff, to French engineering company Framatome.

"This transaction marks a further simplification of our business and contributes towards our target to generate over 2 billion pounds from disposals," said Rolls-Royce chief executive Warren East in the statement.

The I&C business sits in Rolls' power systems division and had revenues of 94 million euros in 2019.

The British company said none of its staff in the UK would be affected by the sale which, subject to regulatory approval, it expects to complete at the beginning of the second half of 2021.

PRESIDENT-ELECT Joe Biden has made his selections for two key public health positions, sources said on Sunday, as he prepares to take office next month as the coronavirus pandemic rages to new levels across the United States.

Biden plans to nominate California Attorney General Xavier Becerra as secretary of health and human services, two sources said, placing the Latino former congressman in a critical role battling the pandemic.

The former vice president is also expected to nominate Rochelle Walensky, chief of infectious diseases at Massachusetts General Hospital, to run the U.S. Centers for Disease Control and Prevention, a person familiar with the decision said.

The choice of Becerra, 62, who also had been considered a candidate for U.S. attorney general, came as Biden faced more pressure to add diversity to his Cabinet appointments, including complaints from the Congressional Hispanic Caucus about the lack of Latinos.

Becerra will lead the health agency as it struggles to handle a resurgence of the coro-

navirus, including record infections and a daily death toll that has exceeded 2,000 in recent days, and prepares a mammoth effort to vaccinate Americans against the virus.

Neither Becerra nor Walensky could be reached for immediate comment. A spokesman for Biden's transition declined to comment.

More than 281,000 Americans have died from the COVID-19 disease, according to a Reuters tally.

The announcement of the choice of Becerra could come as soon as Monday, said one of the sources familiar with the decision. Biden named some top members of his health team last week, and is expected to roll out the full team this week.

"Biden is living up to his commitment to make the Cabinet a reflection of diversity," said Robert Garcia, mayor of Long Beach, California, and a longtime ally of Becerra and Biden.

Garcia said Becerra "has a strong record on healthcare but I think it goes beyond that. The president-elect selected someone with the highest levels of integrity and intellect."

In Congress, Becerra played a key role in

passing the Affordable Care Act - former President Barack Obama's key domestic policy achievement. In his current role, Becerra leads the coalition of 20 states defending the program better known as Obamacare, including before the Supreme Court last month.

Biden has asked Anthony Fauci, director of the National Institute of Allergy and Infectious Diseases and a member of President Donald Trump's coronavirus task force, to stay on as chief medical adviser.

The Democratic president-elect also has named Jeff Zients, an economic adviser touted for his managerial skills, as a coronavirus "czar" to oversee an unprecedented operation to distribute hundreds of millions of doses of a new vaccine, coordinating efforts across multiple federal agencies.

Biden picked Vivek Murthy, a physician and former surgeon general who has gained prominence in recent months as co-chairman of Biden's advisory board dealing with the pandemic, to return for a second go-around as surgeon general.

Becerra served as a Democratic U.S. representative from 1993 to 2017 before moving back to his home state to become attorney general. In that post, he succeeded Vice President-elect Kamala Harris. **Agencies**

UK, EU negotiators meet in 'last-ditch' effort to strike post-Brexit deal

LONDON

NEGOTIATORS from Britain and the European Union (EU) resumed their talks in Brussels on Sunday in a "final throw of the dice" as they try to secure a post-Brexit trade deal before the Brexit transition period expires at the end of this month

British chief negotiator David Frost and his EU counterpart Michel Barnier met in a last-ditch effort to resolve the remaining issues in the trade talks as the time is running out.

Ahead of the meeting on Sunday, however, British sources warned there was no guarantee they would succeed, the London-based Evening Standard newspaper reported.

"We will be working very hard to try to get a deal," Frost told reporters at the Brussels train station as he arrived from London by Eurostar train. "We will be looking forward to meeting our European colleagues later on this afternoon."

The return to the negotiating table followed an hourlong call on Saturday between British Prime Minister Boris Johnson and European Commission President Ursula von der Leyen, in which they agreed on a final push to get an agreement.

Frost and Barnier wrote on Twitter on Friday that "the conditions for an agreement are not met, due to significant divergences on level playing field, governance and fisheries.

They agreed to "pause the talks in order to brief their Principals on the state of play of the negotiations."

Failure to reach a free trade agreement with the EU means bilateral trade will fall back on World Trade Organization (WTO) rules in 2021. Xinhua

Iran says 'smart satellite-controlled machine gun' killed top nuclear

DUBAI

THE killing of Iran's top nuclear scientist last month was carried out remotely with artificial intelligence and a machine gun equipped with a "satellite-controlled smart system", Tasnim news agency quoted a senior commander as saying.



Iran has blamed Israel for the assassination of Mohsen Fakhrizadeh (pictured), who was seen by Western intelligence services as the mastermind of a covert Iranian programme to develop nuclear weapons capability. Tehran has long denied any such ambition.

Israel has neither confirmed nor denied responsibility for the killing, but in the past has acknowledged pursuing covert, intelligence-gathering operations against the nuclear programme of its arch-enemy Iran.

The Islamic Republic has given contradictory details of Fakhrizadeh's death in a daytime Nov. 27 ambush on his car on a highway near Tehran.

Last week Ali Shamkhani, Secretary of the Supreme National Security Council of Iran, said the killing was carried out with "electronic devices" with no people on the ground.

Experts and officials told Reuters last week Fakhrizadeh's killing exposed security gaps that suggest its security forces may have been infiltrated and that the Islamic Republic is vulnerable to further attacks.

"Some 13 shots were fired at martyr Fakhrizadeh with a machine gun controlled by satellite...During the operation artificial intelligence and face recognition was used," Fadavi said. "His wife, sitting 25 centimetres away from him in the same car, was not injured."

Fakhrizadeh, identified by Israel as a prime player in what it says is a continuing Iranian quest for a nuclear weapon, was the fifth Iranian nuclear scientist killed in targeted attacks since 2010 inside Iran, and the second slaying of a high-ranking Iranian official in 2020.

The commander of the Revolutionary Guards' elite Quds Force, Qassem Soleimani, was killed in a U.S. drone strike in Iraq in January. Tehran retaliated by firing missiles at U.S. military targets in Iraq.

Giuliani tests positive for COVID-19, latest in Trump's inner circle

PRESIDENT Donald Trump's lawyer Rudy Giuliani has tested positive for COVID-19, Trump said on Sunday, prompting one state legislature to close for a week after Giuliani visited to try to persuade lawmakers to help reverse Trump's election defeat.

The 76-year-old former New York mayor is the latest in a long string of people close to the White House, including Trump himself, sickened in a pandemic that has killed more than 280,000 Americans.

"@RudyGiuliani, by far the greatest mayor in the history of NYC, and who has been working tirelessly exposing the most corrupt election (by far!) in the history of the USA, has tested positive for the China Virus," Trump said, using a term for COVID-19 that has drawn backlash.

Giuliani tweeted his thanks to "friends and followers" Sunday evening for their concern about him. "I'm getting great care and feeling good. Recovering quickly and keeping up with everything," he wrote on Twitter.

Two sources familiar with the situation told Reuters that Giuliani was at Georgetown University Hospital in Washington, D.C., on Sunday and one said he had been admitted for treatment. The hospital did not immediately respond to requests for confirmation.

Giuliani has been spearheading Trump's floundering effort to overturn his Nov. 3 election loss to Democratic President-elect Joe Biden through a flurry of lawsuits. Both Trump and Giuliani have repeatedly claimed, contrary to evidence, that the outcome was marred by widespread fraud.

State and federal officials have repeatedly said there is no evidence of fraud on any significant scale.

Giuliani visited Georgia on Thursday, where he urged state lawmakers to intervene to overturn Biden's victory in

the state, after making similar pleas in Michigan on Wednesday and Arizona on Monday.

After news of Giuliani's test, the Arizona state legislature said it would close both chambers this week out of caution "for recent cases and concerns relating to COVID-19." Giuliani met with about a dozen Republican lawmakers there last week.

The Trump campaign released a statement from the president's legal team Sunday evening saying Giuliani had tested negative just before his trip to the three states.

"Mayor Giuliani tested negative twice immediately preceding his trip to Arizona, Michigan, and Georgia. The Mayor did not experience any symptoms or test positive for COV-ID-19 until more than 48 hours after his return," the statement said. "No legislators in any state or members of the press are on the contact tracing list, under current CDC (Centers for Disease Control) Guidelines."

It said other members of the president's legal team "who are defined as having had close contact" will follow their doctors' orders and CDC guidelines about self-isolation and testing. Trump and many of his close associates have balked at public health officials' advice to wear masks and avoid crowds to stem transmission of the respiratory illness, which has roared to record levels in the United

Moscow deputy mayor says 'no end in sight' to fight against coronavirus pandemic

THERE is "no end in sight" to the fight against the coronavirus pandemic, Moscow Deputy Mayor Anastasia Rakova said at the 13th Russian Scientific and Practical Conference with international participation dubbed "Medicine and Quality 2020" yesterday.

"We have been fighting the infection for nine months. The marathon continues with no end in sight," she pointed out.

However, Rakova was hopeful that Moscow would be able to defeat the pandemic in the coming months.

"The pandemic made the entire world, including our country and city, face unprecedented challenges. In order to combat them, we had to completely overhaul the city's healthcare system," the deputy mayor noted.

According to her, "rapid responses and moves to change the existing rules" were crucial. "I think we have never before had to make changes so fast as far as the healthcare system is concerned.

It's important not only to be able to promptly change the rules of the game depending on how the situation develops. It's crucial to make sure that doctors start using new technologies as soon as possible," Rakova added.

"At the beginning of the pandemic, we had to establish a new system to manage all the processes," she went on to say.

"All work, from detecting suspected patients and providing drugs to patients, is carried out for each individual case. The focus is on the people," the Moscow deputy mayor emphasized.

China launches 1st lunar sample return mission, aims for multiple breakthroughs in aerospace history

THE Long March-5 Y5, China's state-of-the-art carrier rocket and strongest member of the Long March launch vehicle family, blasted off early on Tuesday morning, November 24, from the Wenchang Space Launch Center located in South China's Hainan Province, successfully sending the Change-5 lunar probe into planned orbit.

About 2,200 seconds after lift-off, the Chang'e-5 lunar probe separated from the rocket and entered the Earth-Moon transfer orbit with the perigee at 200 km and the apogee at about 410,000 km.

Despite the difficulties brought by the COVID-19 epidemic, China's aerospace sector has been able to launch not only the country's first-ever Tianwen-1 Mars probe, but also the latest lunar sample return mission, showcasing the country's resilience and increasingly mature capabilities in the space sphere, according to observers.

Dubbed one of the most complicated and challenging space exploration projects ever attempted, Change-5 will carry out the third stage of China's current lunar programs, which involves three phases-orbiting, landing and return. The first two phases have been completed successfully.

Wang Yanan, chief editor of Aerospace Knowledge magazine, told the Global Times that the highly complex, forward-looking technology applied in this project could be regarded as "an unmanned task that lays the foundation for future manned lunar missions.'

"Analysis of the lunar samples shows that contents within the soil and rocks could be turned into water and oxygen, which will be useful in supporting the operation of the Moon base and serve as supplementary fuel for lunar landing vehicles," Pang Zhihao, a Beijing-based space expert, told the Global Times.

Russia to start deliveries of 'world's best' Armata tank to troops in 2021

More importantly, scientists have found in the lunar samples the ideal material for nuclear fusion, and enough of it to meet human's energy needs for about 10,000 years, Pang added.

China's future Chang'e-6 mission will also automatically collect lunar samples for comprehensive analysis and research, and hopefully carry international payloads on board.

Change-7 will comprehensively explore the moon, while Change-8 will explore the possibility of building an international lunar research base, Global Times previously learned from CNSA. Chang'e-8 will also test 3D printer technology in the hopes of assisting future lunar residents.

"To build a research base on the Moon, we first need to figure out what it is made of, by analyzing the soil composition and geological structure, and then making use of the raw materials at hand on the Moon for our own exploration purposes," Song Zhongping, an aerospace observer and TV commentator, told the Global Times.

Perfect success rate

China launched its first lunar probe mission, Chang'e-1, in October 24, 2007 via a Long March 3A Y14 carrier rocket. In the 13 years since then, China has launched a total of five missions, all named after the lunar goddess Chang'e, with domestically developed Long March rockets, scoring a perfect success rate.

The 57-meter-long Long March-5, with a take-off weight of about 870 tons and a thrust of over 1,000 tons, is capable of launching a payload of up to 14 tons into the geosynchronous transfer orbit (GTO), making it the go-to rocket model for the mission, as the Change-5 lunar probe weighs 8.2 tons, one of the heaviest probes that has ever been launched by China.

SERIAL deliveries of the latest T-14 'Armata' tank to the Russian troops will begin in 2021, Head of the state hitech corporation Rostec Sergei Chemezov announced yesterday.

MOSCOW

"Serial deliveries of the T-14 tank based on the Armata platform will begin in



2021. This is, undoubtedly, the world's best tank today. In the future, this vehicle will become the main battle tank in the Russian Army," the Rostec chief said.

In 2019, Russia formalized all the necessary documents for the export of Armata tanks, he said.

"We are advertising this tank to foreign customers. This year, it was demonstrated 'live' at the Army forum: visitors could come up to it, take a picture of it and touch it. It is a pity it has been impossible to demonstrate it abroad yet due to the absence of foreign exhibitions," the Rostec chief said.

for other land-based robots, Chemezov said.

Currently, Russia's Kalashnikov Group is actively developing ground combat robots. These systems have also been employed in Syria. the Rostec chief said.

"A number of our other enterprises are working on developing such systems. Even the Armata was tested as an unmanned tank. Of course, this will not be a serial-produced vehicle. We are testing unmanned technologies on it," he explained.

However, even the serialproduced Armata tank with the crew will be maximally robotized, the Rostec chief

"The Armata crew does not need to aim accurately. It only has to aim the gun roughly. Electronics will do all the rest: it will accurately determine the distance to the target and aim the gun

at it. That is, the vehicle uses artificial intelligence elements that help the crew deliver fire," the Rostec chief said.

This algorithm is already being used in the combat robots that have been tested in Syria, he stressed.

The Armata is a heavy tracked standardized platform serving as the basis to develop a main battle tank, an infantry fighting vehi-

cle, an armored personnel carrier and some other armored vehicles.

The T-14 tank based on the Armata combat platform has been developed by Uralvagonzavod defense manufacturer (part of Rostec). The latest tank was shown to the public for the first time at Red Square's Victory Day parade on May 9, 2015. The Armata tank underwent preliminary trials in 2019.

The new combat vehicle differs fundamentally from its predecessors. It features fully digitized equipment, an unmanned turret and an isolated armored capsule for the crew. Agencies

Ethiopia's Abiy denies guerrilla war emerging in Tigray

ADDIS ABABA/NAIROBI

ETHIOPIAN Prime Minister Abiy Ahmed denied yesterday that a rebellious northern force his troops have battled for over a month would have the capacity to mount a guerrilla war from the mountains of Tigray.

Federal troops have captured the regional capital Mekelle from the former local ruling party, the Tigray People's Liberation Front (TPLF), and declared an end to their offensive.

But TPLF leaders say they are fighting back on various fronts around Mekelle. Ethiopia experts fear a drawn-out insurgency with a destabilising impact around east

Africa.

"The criminal clique pushed a patently false narrative that its fighters and supporters are battle-hardened and well-armed, posing the risk of protracted insurgency in the rugged mountains of Tigray," Abiy said in a statement.

"It also claimed that it has managed to undertake strategic retreat with all its capability and regional government apparatus intact. The reality is the criminal clique is thoroughly defeated and in disarray, with insignificant capability to mount a protracted insur-



gency.' There was no immediate TPLF response. With communications

largely down and access for humanitarian workers and media restricted, Reuters has not been able to verify claims from all sides on the state of fighting.

AID NEEDED FAST

The conflict, which has its roots in Abiy's pushback against Tigrayans' past dominance of federal government and military posts, is thought to have killed thousands of people.

It has also sent nearly 50,000 refugees fleeing to Sudan, seen TPLF rockets fired into Eritrea, stirred ethnic divisions, and led to

the disarming of Tigrayans in Ethiopia's peacekeeping contingency combating al Qaeda-linked militants in Somalia.

The United Nations and aid agencies are pressing for safe access to Tigray, which is home to more than 5 million people and where 600,000 relied on food aid even before the war.

However, two senior aid officials told Reuters over the weekend that looting and lawlessness meant the region was still too dangerous to dispatch convoys.

The government says that with peace restored, its priorities are the welfare of Tigravans and return of refugees. However, some residents, diplomats and the TPLF say clashes persist, with protests and looting also reported in Mekelle on Friday.

The TPLF dominated government for nearly three decades, until Abiy took power in 2018 and began democratic reforms.

The party accuses him of seeking to centralise power at the expense of Ethiopia's 10 regions and says Tigrayan officials were unfairly targeted in a crackdown on corruption and rights abuses. The government denies that and accuses TPLF leaders of treason for attacking federal forces in early November.

SOCCER enthusiasts in Dar es Salaam and well beyond are having a hard time trying to put down lessons of the results of two matches in the preliminary round of the 2020/21 CAF Champions League pitting Simba SC and Plateau United of Nigeria.

The tantalizing issue is not the fact that the Nigerian side lost at home and Simba held to their goal in the home game, but rather the idea that the side was the best Nigerian football can offer, even if most Nigerian soccer stars play in Europe and elsewhere.

It is this seizing up of Plateau United which shall take a while to settle- and perhaps in due course be forgotten.

For one thing, except perhaps in the Nigerian social media, there was little in the major print media or outlets on reactions to the 1-0 loss the side suffered in the home game to the visiting Tanzanian champions, and not much of reflection on the return game either.

With pundits used to the hard hitting Envimba FC and earlier Enugu Rangers and others, this plainly ordinary side from Plateau State in the middle belt of the country as a bit of a novelty.

But surprisingly Nigeria does not have major club sides identified with the two major cities, namely Lagos and Abuja, with provincial teams doing the rounds.

After the first match, home side

for a pushover, and then it eats into their physical and psychological preparations.

A top side from Nigeria will respect clubs from North Africa and a few on the southern belt like DR Congo's TP Mazembe or AC Horoya of Guinea and a few others, not more.

So there is always the shadowy advantage of not being well known to your opponents, as for instance Simba would have worked hard as the side was from Nigeria, not because it knows the club specifically.

When one introduces a club as Nigerian champions, one has a feeling that it is better, or it can be better than Enyimba FC, and that is to say a lot, and this is not the sort of impression that the fans got in the game in Dar es Salaam, and the previous one in Jos couldn't have been an improved version, definitely.

That leads to a rather confusing situation as to how it comes to represent Nigeria in the CAF top tourney.

One could take an example of the often recurring situation locally where once in a while we have two clubs in the CAF Champions League preliminaries, or where the winners of the FA Cup (the Azam Sports Federation Cup more accurately) features in the CAF Confederation Cup tourney.

So one meets a side like Namungo FC or say Ihefu FC as Tanzanian second top most club, and there is consternation, as the win was based on some chance

Midfielder Ndala, after his team suffered a 1-0 defeat at home, is reported to have 'promised revenge' in the return match, which does not say much about recriminations in the dressing rooms and club corridors on apportioning blame.

Again it was hard to find any such material in routine searches, in which case one is pushes to the routine newspaper refrain, 'no news means good news,' that there was no discussion on the loss in an audible manner because it was not surprising.

That would scarcely be the case with Enyimba as then Simba would have floored an elephant, and people start looking at the new powerhouse in soccer, that is, at the continental level, as winning over Plateau United journeymen is not a frenzied feat out there.

To get a glimpse of the psychological tussling with the situation, a local newspaper wrote that the Simba CEO, Barbara Gonzalez, hailed the players and the team's technical bench for winning the away clash in Nigeria, 'where she (sic) said it is always difficult to come out with a win when playing teams like Envimba, who are among the heavyweights in African football and rated among the favourites in CAF Champions League'.

Voila! Scarcely was anyone thinking of Plateau United, except in the faulty impression that it was an equal to Enyimba, which means to the likes of TP Mazembe, AC Horoya or Al Ahly, that rank. Just figure out that a January 2018 list of club's players had just one foreign professional, Junior Salomon, from nearby Benin. It is the proper ranking of the Jos hard hitters as a professional side.

with many top clubs around the globe, said U-20 is the right age group for identifying talents that can sustain clubs for a long time.

The scout, who opted for anonymity, has a vast experience in managing players, especially those from the East Africa region.

He revealed that he was impressed with the performance of many of Ngorongoro Heroes' players.

He, however, stopped short of mentioning players he has identified, saying he and his technical department's members needed to analyze the earmarked players, contact the prospective clubs and then make the players' names public.

"Yes I was in Arusha watching the CECAFA U-20 Championship's matches, it was a good tournament with abundant talents, we managed to spot genuine talents," he disclosed.

They settled for the runners-up spot in the CECAFA U-20 Championship after losing 4-1 to Uganda in the final.

The Ngorongoro Heroes have such good players, who were at their best in the showpiece, like Kelvin John, Khelfin Hamdoun, Abdul Selemani, who was the tournament's top goal scorer, and the tournament's best player, Paschal Mshindo.

Palace flop Sorloth aiming to shoot down Man Utd for RB Leipzig

LONDON

AFTER finally breaking his goal drought for RB Leipzig, the pressure is on Norway striker Alexander Sorloth to hit the net again in Tuesday's Champions League clash at home to Manchester United with a last-16 berth at stake.

Having failed to score in his first 10 games for Leipzig, Sorloth struck a last-gasp winner in the crucial 4-3 victory at Istanbul Basaksehir last Wednesday to his huge relief.

Sorloth came on for the last 25 minutes and his low drive sealed the away win which kept Leipzig's hopes of reaching the knock-out stages in their own hands.

"It's always important to score your first goal for a new club -- I am incredibly happy and relieved," Sorloth beamed in Istanbul.

"In an exciting and balanced group, it was a very, very important victory.

"Now we have a final against Manchester United that we definitely want to win."

Only victory on Tuesday will assure either club a last-16 spot.

Going into the final round of matches, Leipzig, Man Utd and Paris Saint-Germain are all on nine points in Group H.

- Score to settle

To add extra spice, Leipzig have a score to settle from October's 5-0 thrashing at Old Trafford when United striker Marcus Rushford scored a hat-trick.

Backed by energy drinks giants Red Bull, RB Leipzig want to be a permanent fixture in the Champions League and build on last season's run to the semi-finals.

Bowing out in the group stage would hurt the ambitious club from Germany's east.

Leipzig paid Palace 20 million euros (\$24 million) for Sorloth in September to replace Timo Werner following the Germany striker's move to Chelsea.

While Norway national teammate Erling Braut Haaland has sent Bundesliga records tumbling at Dortmund since his January transfer from Salzburg, Sorloth has not found the move to Germany so easy.

Despite sealing the win over Basaksehir, Sorloth is likely to start on

the bench having often struggled in front of goal this season.

Another goal in Europe would boost his standing.

After forwards Emil Forsberg, Justin Kluivert and Christopher Nkunku all netted in Saturday's 3-3 draw at Bayern Munich, Sorloth came on for the last 13 minutes at the Allianz Arena.

Sorloth is still waiting for his first Bundesliga goal after nine games, including four starts. He is no stranger to goal droughts.

Crystal Palace paid Danish side Midtjylland nine million pounds (\$12 million) for Sorloth in 2018, but he failed to score a Premier League goal in 16 appearances -- 12 off the bench.

He was loaned out to Gent, then Trabzonspor, where he hit the ground running last season with six goals and three assists in his first nine appearances.

- Turnaround in Turkey -

He set the Turkish league alight with 24 goals in 34 games, ending with a total of 33 goals in 49 appearances in 2019/20.

Trabzonspor wanted to sign Sorloth permanently. However, the club's ban from UEFA competitions for breaching financial fair-play rules left Sorloth searching for a Champions League club.

Leipzig came calling.

After failing to score in his first seven Bundesliga games, worry lines were etched on his face after his weak penalty attempt was saved in a 2-1 win at Arminia Bielefeld 10 days ago.

Sorloth's goal drought was such a concern that Leipzig coach Julian Nagelsmann admitted "a stone lifted from our hearts" when he scored in Istanbul.

In a bid to boost his confidence, Nagelsmann sat down with Sorloth before the Basaksehir game to watch videos of his time in Turkey and his goals for their rivals Trabzonspor.

The result was the winner as Sorloth combined with Yussuf Poulsen to score with a superb finish and his head coach would love to see another goal against Man Utd.

"Things will probably be easier for him -- that's mostly how it is with strikers," said Nagelsmann. *AFP*

Arsenal exposed by Spurs as Arteta falls into Mourinho's trap

IN trying to be the team Mikel Arteta wants them to be, Arsenal revealed yet again what they actually are. On Sunday, Tottenham beat Arsenal 2-0 in the North London derby, and nobody could be surprised about how it happened. Nobody, that is, except Arteta, who by setting up his team with greater attacking purpose than in many of Arsenal's biggest games, fell neatly into the trap Jose Mourinho was always going to set.

Anyone with even a passing knowledge of the methodology with which Spurs have climbed to the top of the Premier League table would understand the importance and form of Son Heung-Min and Harry Kane adding a razor-sharp edge to an otherwise conservative approach. Spurs beat Manchester City in precisely this manner two weekends ago, but there was at least a sense of jeopardy on that occasion as Pep Guardiola's side probed with more purpose than Arsenal managed at Tottenham Hotspur Stadium. Arteta's side could have played on for another half an hour and not scored, so content Spurs were to dig in and defend what they had once the damage had been done.

It was, in truth, another entry in the catalogue of alarmingly naive and painfully blunted performances that have cost Arteta's predecessors their jobs.

Put simply, Arsenal have been done on the break for years, usually at Emirates Stadium. The scenery changed, but the story remains the same. The Gunners won the FA Cup last season with a highly effective counter-attacking style of Arteta's making, ceding possession and territory to City and Chelsea before picking them off on the break. A back three was central to achieving this greater balance and stability yet here he went to a 4-2-3-1 shape to little effect.

Sunday's deployment was more in line with the "Guardiola style" that Arteta was expected to deliver, yet this was further evidence they are simply not capable of playing that way against the top sides with their current squad.

"In terms of the performance, they did everything I asked them to do," Arteta said after the match. "We played the way I believe we have to play this game. If you look at all the stats, they are in our favour but at the end of the day it is about putting the ball in the box.

"We had the chances, we generated probably more than ever this season, we put the ball in the box more than ever, we had the numbers, but at the end of the day, you have to score the goals. To build something, you need results."

Arsenal lack the requisite quality in midfield to dictate terms without leaving themselves vulnerable on the counterattack. That is why Arteta tried to sign two central midfielders in the summer; it also explains the gamble in starting Thomas Partey despite private reservations he had not yet fully recovered from a thigh problem. The acute nature of this problem was best exemplified by the sight of Arteta pushing a palpably injured Partey back onto the pitch in a forlorn hope of stopping Spurs scoring on the counter-attack.

Perhaps the most damning indictment of Arsenal overall was that Mourinho appeared only too happy to give them the ball. Spurs sat on the edge of their box and waiting for Arsenal's attacks to break down. Granit Xhaka was terrified of allowing Kane to turn and launch Tottenham on the counterattack, rugby tackling him as early as the second minute, but the England captain was able to wriggle free all too easily to play to Son into space on the left with just 13 minutes played.

Hector Bellerin made the first of a series of mistakes -- later

right foot, before the Spurs attacker unleashed a superb curling shot that gave Bernd Leno no chance. Son has now scored 10 league goals this season: the same number as Arsenal.

Long periods of sterile Arsenal possession followed, punctuated by Spurs threatening on the break. And, yet again, perhaps tellingly in contrast to Chelsea, who deliberately opted not to over-commit numbers forward in their goal-less draw with Tottenham last Sunday, the visitors were caught out. This time it ended with Son releasing Kane, who thrashed a left-foot shot in off the crossbar.

Son and Kane have now combined for 31 league goals, with only Didier Drogba and Frank Lampard (36) boasting a better record. You've probably heard that before, because everyone has. Yet Arsenal were caught out. Arteta knows it too, of course. He's a studious and diligent manager trying to restore Arsenal to the fearsome presence of the peak Arsene Wenger years.

Stopping the Kane-Son axis is clearly easier said than done, but Arteta abandoned the short-term pragmatism, which got him promising results, for a more expansive strategy against Tottenham that ultimately backfired. In one sense, he was trying to run before he could walk.

Arsenal ended with 69.2% possession and just two shots on target, both second-half headers from Alexandre Lacazette. They attempted 44 crosses,

was, of course, also due to another superbly organised and disciplined Tottenham performance, with Pierre-Emile Hojbjerg at the heart of it. He was not the most high-profile summer signing, but Hojbjerg's £15 million arrival from Southampton is a huge factor in enabling Mourinho to play the way he wants to.

Sergio Reguilon's dynamic style at left-back also helps Spurs transition with lightning speed. Gareth Bale, just as he was against Chelsea, watched the entire game as an unused substitute.

Arsenal need to be equally shrewd in the market going forward. Arteta previously adapted the style of football he wants to play so that his side could have greater stability, but somewhere along the way they've lost the attacking threat that gave them a fighting chance in almost any game. The difficulty now for Arteta is that he needs to find a route to more consistent short-term results before the squad overhaul Arsenal desperately need.

"It's very simple. We need to score goals. If not, it doesn't matter what we do in the other departments of the pitch," Arteta said. "If we don't score goals, we can do nothing, so we need to put the ball in the net urgently."

There is a widespread recognition of the sheer scale of the task the Spaniard has inherited, but Arsenal are 15th in the table now, 11 points adrift of their bitterest rivals. Otherwise there is further pain ahead, exacerbated by Tottenham's continuing emergence as genuine title

contenders.

Son, Kane worked like 'animals' vs. Arsenal - Mourinho

TOTTENHAM Hotspur strike duo Harry Kane and Son Heungmin both scored in Sunday's 2-0 derby win over Arsenal, but manager Jose Mourinho was more impressed with their work rate when Spurs were out of possession.

Spurs absorbed huge amounts of Arsenal pressure and scored twice on the counter-attack in the first half, with Kane and Son assisting each other in two clinical moves.

Mourinho praised his two forwards, who have scored 18 league goals between them this season, for being "world class professionals."

"They are working like animals, with all due respect to animals, I love animals," Mourinho told Sky Sports.

"They worked amazingly hard when the team didn't have the ball. Harry Kane was clearing balls in the box. Son, in the first 60 minutes as a winger working a lot on [Hector] Bellerin, then as a second striker working a lot on the centrebacks.

"They have a very good sense of the balance that they need and they also do incredible tactical work for the team when the team doesn't have the ball."

Spurs' form has given fans hope that their trophy drought will soon be over. They have not won the league since 1961 and last picked up a trophy in 2008 with their League Cup triumph.

"One game at a time," Kane said. "We're doing well in a tough period, but results like this will only help us.

"We go away to [Crystal] Palace next week and then to Liverpool (three days later), so the tough games keep on coming."

Spurs have now picked up seven points from their last three games against Manchester City, Chelsea and Arsenal. They lead the table on goal difference from Liverpool. Meanwhile, Arsenal's Thomas

Partey suffered a recurrence of a thigh injury in their 2-0 defeat at Tottenham Hotspur, manager Mikel Arteta said.

The Ghana international, who moved to Arsenal from Atletico Madrid for \notin 50 million during the summer, injured his thigh last month and only returned to the side on Sunday.

Partey pulled up injured shortly before half-time and was standing on the touchline when Spurs broke from their own box. Arteta then urged him back on to try to stop the counter-attack but the midfielder could only run a few yards before stopping.

Ahead of Partey, Spurs striker Harry Kane finished off Spurs' sweeping attack, handing the Premier League leaders their two-goal cushion.

"I was trying to push him but I don't think he realised the gravity of the situation when he left his position but that was probably because he was in a lot of pain," Arteta told reporters.

"Suddenly they are coming to attack us and Thomas is walking to me and I was trying to push him. I haven't spoken to him so I don't know exactly how it happened or if he felt something really serious."

Partey's absence will be a cause for concern for Arteta amid a busy schedule where Arsenal, 15th in the league, play eight games in 23 days.

QATAR is now planning for a "complete normal" World Cup in 2022 after the rapid progress in producing vaccines for the coronavirus, the tournament CEO told The Associated Press on Sunday ahead of the European qualifying draw.

Early in the pandemic that forced the cancelation of the European Championship and Olympics this year, Qatar was concerned about the long-term impact of COVID-19 on the first World Cup to be staged in the Middle East.

Across the world sports have resumed in front of limited or no crowds, but the vaccines have provided hope that crowds can return in large numbers from next year.

"The introduction of the vaccine and the rollout of the vaccine, it's definitely good news for everybody," 2022 World Cup chief executive Nasser Al-Khater said in an interview with the AP. "Everybody's looking forward to going back to some sort of normalcy in life and especially in sports as well.

"We're very hopeful and very looking forward that, by 2022, hopefully things will really be back to complete normal and looking forward to hosting the fans and having a normal and successful World Cup."

European nations on Monday will discover their path to securing one of 13 spots in the tournament when the qualifying draw is staged at FIFA HQ in Zurich. The pandemic has prevented the event being staged in the host nation as would usually happen before a World Cup.

"In the post-COVID pandemic era, we hope that sports will go back to normal as quickly as possible," Al-Khater said.

The tournament isn't just going to a new region, but being played at the end of 2022 rather than the usual June-July slot, due to the fierce summer heat in the Gulf nation.

"When the announcement was made for the World Cup to be played in November and December, obviously at that time there was a lot of feedback about the disruption to the different calendars of the leagues," Al-Khater said. "One thing we learned from the pandemic is that many leagues were able to adapt."

And the months without any football during the pandemic will put into a new

perspective the necessary break in the European seasons in 2022 to accommodate the World Cup. The later tournament gives more breathing space for qualifying to be completed rather than the tournament starting in about 18 months. It also should provide a break eventually for players in the summer of 2022 after enduring a long stretch of games from around June this year through rescheduled events, including the Euros, and next season.

"There was always that advantage that the World Cup is taking place midseason, so players are going to be fresh and it would translate into much better football on the field of play," Al-Khater said. "We hope that remains the same that they will have a break in the summer (of 2022)."

Last week marked 10 years since Qatar won the right to host the World Cup in a contentious FIFA vote that sparked corruption investigations into the entire bidding process. Evidence was not found by FIFA to warrant stripping Qatar of the hosting rights. **AP**

All set for inaugural Dar-Moshi cycling tour

OVER 28 riders have lined up for the maiden Dar-Moshi Cycling Tour as preparations for the race, scheduled for later next week, are on top gear

The 552.1km cycling race, slated to start from Dar es Salaam and climax in Moshi, Kilimanjaro, has been scheduled for December 18-20 this year.

The race, known as 'Grand Dar es Salaam-Moshi tour', comes after successful hosting of a race, dubbed 'Twende Butiama Cycling Challenge', which is the longest cycling tour in the country.

The 'Twende Butiama Cycling Challenge' was held in October this year to honour former President, the late Mwalimu Julius Kambarage Nyerere.

The whole Dar-Moshi Cycling Tour, according to the race's organizers, will cover four regions.

Gabriel Landa, one of the event's organizers, said in Dar es Salaam on Saturday that everything is going well so far.

He confirmed that 28 cyclists, including himself, have been listed for the event.

Landa said out of all 28 participants, there is only one female cyclist, Ruth Wangui, in the list.

He mentioned other participants as Abdu Elmahry, Ammar Yunus, Amon Mwaka, Amon Hendry, Khuzeima Khanbhai, Eden Mushi, Frank Marariki, Godbless Baluhya, Hafeez Thawer, Hesam Thawer, Hubert Pius, Hussein Dossajee, Hillary Edward and Issa Murshid.

Others are Kwasi Frimpong, Martin Mchemwa, Murtaza Mesmailjee, Omary Makumba, Omary Fire, Peter Nkwabi, Pritesh Dharsi, Rob Mwamamba, Robert Komba, Salehe Mvungi, Salum Kizoka and Shafran Merali.

Landa added that the three-day race will have three service stops at Msata in Coast Region, Same in Kilimanjaro and the final spot in Moshi, Kilimanjaro.

He stated: "The first service stop will be at Msata, 195.2km from Msasani, Dar es Salaam, and the next day's stop is Same, about 249.9km from Msata, from Same, riders will complete the final 107km distance to Moshi, the final destination."
