

Govt to reopen closed foreign currency shops based in Arusha

■92.1 billion/- stimulus package expected to revive the country's tourism industry

ARUSHA-BASED bureaux de change which the government ordered closed in 2018 over irregularities will soon resume business, as the country gears up to unlock the tourism industry.

President Samia Suluhu Hassan made a pronouncement to this effect here yesterday.

She said in an address at the Sheikh Amri Abeid Stadium that the Finance and Planning ministry and the Bank of Tanzania are in the final stages of going through a draft of new regulations to govern the establishment of forex shops.

"We will soon issue new operating licences for Arusha-based bureaux-de-change, which are important components in the country's tourism industry," she said, meanwhile stressing the need for the outlets' owners and operators to ensure that they comply with all standing guidelines. November 2018 saw the Bank of Tanzania

(BoT) order foreign exchange shops here closed following suspicions of involvement in money laundering and associated illegal transactions.

The move was part of a countrywide crackdown against masterminds of syndicates behind money laundering and unlicensed foreign exchange transactions.

For three years now, most of these transactions have been undertaken by local commercial banks, which many people see as a serious challenge, chiefly in that banks seldom operate beyond normal working hours or on weekends and public holidays.

The president meanwhile stated that the government will put in place a 92.1bn/stimulus package primarily to revive the country's tourism industry, which has

THE Higher Education Students' Loans Board (HESLB) yesterday released 37,731 names as those of the first batch of first year university and college students to receive a total of 99.9bn/- in loans for the 2021/2022 academic year, which begins next week.

HESLB managing director Abdul-Razaq Badru said 23,379 of the beneficiaries are male and 14,352 are women.

He said that the board has started disbursing the money through the respective institutions ready for bank deposits to be made for the students concerned, subsequently advising the beneficiaries to check with the institutions and see whether deposits have actually been effected.

"The students should thereafter get full information from the accounts they used Account (SIPA), and prepare themselves to travel to their colleges for registration," he added. Badru was categorical that the government has already provided the board with the funds and the board has started transmitting the money to the

> respective universities. "We are determined to make sure that the students will find the money upon reporting for their studies," he added.

Sudanese protesters demand dissolution of transitional govt

KHARTOUM

Sudanese protesters take part in a rally demanding the dissolution of the transitional government, outside the presidential palace in Khartoum on October 16, 2021.

Thousands of pro-military protesters rallied in central Khartoum Saturday, vowing not to leave until the government is dissolved in a threat to Sudan's transition to civilian rule.

The protest comes as Sudanese politics reels from divisions among the factions steering the rocky transition from two decades of dictatorship under president Omar al-Bashir, who was ousted by the army in April 2019 following weeks of mass protests.

Saturday's protest was organised by a splinter faction of the Forces for Freedom and Change (FFC), a civilian alliance which spearheaded the anti-Bashir protests and became a key plank of the transition.

"We need a military government, the current government has failed to bring us justice and equality," said Abboud Ahmed, a 50-year-old protester.

Saturday evening, On demonstrators set up tents outside the presidential palace demanding the dismissal of the government of Prime Minister Abdalla Hamdok, a former UN economist whose IMFbacked reforms have hit the pockets of many Sudanese.

The government's supporters charged that the protest was orchestrated by sympathisers of the Bashir regime, which was dominated by Islamists and the military.

Protesters chanted "one army, one people" and "the army will bring us bread.'

"We are marching in a peaceful

protest and we want a military government," said housewife Enaam Mohamed.

Abdelnaby Abdelelah, a protester from the eastern state of Kassala, complained that the government has overlooked other states beyond Khartoum.

"We want a government that knows about the things going on in the east," he said.

Outside the presidential palace, the protesters chanted: "We will stay put where we are... we want the dissolution of this government."

Hamdok warned on Friday that the transition was facing its "worst and most dangerous" crisis.

The mainstream faction of the FFC said: "The current crisis is not related to dissolution of the government or not.

"It is engineered by some parties to overthrow the revolutionary forces... paving the way for the return of remnants of the previous regime."

Support for the transitional government has waned in recent months in the face of its tough economic reforms, which have included the slashing of fuel subsidies and a managed float of the Sudanese pound.

Inflation has skyrocketed, reaching 422 percent in July, before easing slightly in August and September.

Protests have rocked eastern Sudan where demonstrators have blocked trade through the key hub of Port Sudan since September.

On September 21, the government said it thwarted a coup attempt which it blamed on military officers and civilians linked to Bashir's regime.

Govt orders institutions to oversee implementation of projects more effectively

THE Deputy Minister for Works and Transport, Godfrey Kasekenya, has instructed institutions under the ministry to ensure that they supervise implementation of their projects effectively so as to achieve targeted goals and be able to contribute to the country's socio-economic development.

Eng. Kasekenya made the statement in Dar es Salaam over the weekend when speaking at the 14th Joint Transport Sector Review (JTSR-2021) meeting that brought on board officials from the government, development partners, civil societies, financial institutions, academia, Private Sector as well as representatives from local government authorities (LGAs).

Others included the National institute of Transport (NIT), Land Transport Regulatory Authority (LATRA), Tanzania Port Authority (TPA), Tanzania Shipping Agency Corporation (TASAC), Tanzania Meteorological Authority (TMA), Air Tanzania, and Civil Aviation Training Centre (CATC).

The meeting was meant to examine, evaluate and deliberate upon various transport sector policy, management, development and operational issues and deliberate on the sector challenges and ways to mitigate them in noted.

LIVESTOCK and Fisheries minister Mashinda Ndaki has urged pastoral communities in Serengeti District, Mara Region to shun from nomadic livestock keeping and adopt smart cattle farming for their development.

He made the call over the weekend at Bisarara village during the tour of eight sectoral ministers who are in the region to address land conflicts in 975 villages.

Ndaki said that it is high time pastoralists should shun away from out-dated livestock keeping and adopt new ways so as to earn more

income and transform their lives.

"Due to population growth and development, land demand has become high, so we should promote sustainable land use so as to enable everyone to benefit from what we animal feed land in Katavi, Mbeya, have. We encourage pastoralists to Lindi, Rukwa and Mtwara. This embark on a smart livestock keeping system by reducing the number of animals for their development," he said

to ensure that they adhere to the country's laws by avoiding sending their cattle in restricted areas.

"As we speak there is scarcity of alerts all of us to take durable measures so as to ensure that our animals continue to get enough feed, and this can only be addressed cattle farming," he added.

According to the minister, if pastoralists change their minds and start keeping a small number of animals in a designated area, it will greatly help reduce land conflicts but also improve income.

Addressing journalists in Dar es Salaam over the weekend, Dr Mengestu said vaccination offers strong immunity which protects against severe and deadly COVID-19.

"Tanzania aims at vaccinating up to 60 per cent of its population and we're here to support the initiative, this is why we are calling on the public to go and get vaccinated in order to protect our loved ones," he said.

She further noted that there was a notable drop in demand after the initial big demand when the vaccines arrived but since the government and stakeholders embarked on a campaign for COVID -19 vaccines, the uptake has picked up.

that Tanzania manages one of the strongest routine vaccination system in Africa with coverage maintained at more than 90 per cent for most vaccines," she noted

MANY farmers in southern highlands regions have been urged to use fertiliser with the sulphur content to increase crops production.

Submitting his research report on soil status in Iringa Region at the weekend, a researcher from the Uyole Centre of Tanzania Agricultural Research Institute (TARI-Uyole), Watson Matamwa said use of sulphur-less fertiliser has caused the soil in many areas to have acid that has impacted on crops production.

He said some farmers have a negative on fertiliser with sulphur claiming it destroys the soil, which he said was not true. "We have a great task in educating our farmers on the use of sulphur fertiliser because it helps in providing nutrients to the

soil and increase crops profitability," said Matamwa.

For his part, another TARI-Uyole researcher, Frederick Mlowe said Iringa soil has a small sulphur content that cause many crops including wheat and rice not reaching their maximum profitability as anticipated by farmers.

Mlowe said TARI continues to conduct research on soil in various southern highlands regions and invent technologies that will help to increase nutrients in the soil to help farmers reap more crops, as well as to fight plants' diseases.

Following reports showing Iringa Region being faced by soil nutrients, TARI-Uyole director Dr Tulole Bucheveki said nutrients in soils had diminished, and advised to use the correct measurements every time they apply fertiliser so as not to affect crops in the fields.

OCP, sponsors of soil testing project in the four southern highlands regions including Mbeya and Iringa, Prof Mshindo Msola said various steps have taken to fight lack nutrients in soils

Among them is to provide education on better use of fertiliser and distribution of the farm inputs to enable farmers harvest more crops. For his part, assistant Iringa Region Economic planning secretary, Wilfer Myuyu said they will go to work on the report in order to increase nutrients in the soil.

> He said the government wants to increase tarmac roads from the current 2,405 kilometres to 3,856 kilometres but also increase gravel roads from the current 2,812km to 6,620km.

> He stated that the second strategy is meant to bring big reforms on infrastructure whereby villages whose roads are now blocked will be unblocked and keeping transport menace at bay.

"The government's zeal is to

ensure that all roads are passable to enable people transport agroproducts easily to reach markets but also facilitate rural dwellers to reach town centres easily when seeking for various social services," he explained.

According to him, since TARURA started operations in July 2017 to June this year, it has spent approximately 1.3tr/- in its first phase plan to construct roads with a total length of 24,979 kilometers of which 955 are tarmac and the rest are at gravel level.

Govt allays fear on SA beverage batch

THE government has allayed fears that the troubled apple ceres juice batch produced in June 2021 by a South African beverage manufacturer hasn't entered into the country's market.

The decision was taken after reports from the International Food Safety Authorities Network (INFOSAN) which is under Food and Agriculture Organisation (FAO) and World Health Organisation (WHO) claiming that the said juice (produced between June 14th to 30th this year) to have contamination of mould toxins named patulin.

Director of Quality Management at the Tanzania Bureau of Standards (TBS) TBS, Lazaro Msasalaga made the clarification during the weekend in Dar es Salaam as he addressed a news conference.

"Soon after we received the information from INFOSAN network, we took some steps including conducting a crackdown operation of such juices in the market that were produced between June 14 to 30 this year and visited the sole distributor who is based in Dar es Salaam , reviewed all permit documents and inspected all juices at the godown," Msasalaga said.

He narrated that after the close follow up, TBS discovered that the said juice was not imported in the country, and it will make sure that it is not allowed in the Tanzanian market.

Msasalaga said patulin toxin comes from the Aspergillus , penicillium and byssochlamys aflaxotin which is produced when the fruits start to decay.

According to him, once consumed, the said juice or fruit can cause nausea, gastrointestinal disturbances and vomiting.

He also said the changes of Finance Act no 8 of 2019 where food security and cosmetics were and gastrointestinal symptoms.

shifted from former TFDA to TBS did not affect any operation.

Msasalaga said other roles are to register premises and products for local manufacturers which is done through quality management systems.

"We have been conducting food risk assessment as it was done earlier by the former Tanzania Food and Drugs Authority (TFDA)," he said

He assured the public that the bureau would continue to protect safety and quality of all products every time for the benefits of consumers and a nation.

Earlier it was reported that the South African food and beverage manufacturer Pioneer Foods has recalled its Ceres apple juice brands that sold in Kenya and other Common Market for Eastern and Southern Africa (Comesa) countries due to contamination of mould toxins.

Common Market for Eastern and Southern Africa (Comesa) Competition Commission on Wednesday said Pioneer Foods had informed it that the affected juice brands were imported and marketed in several countries.

"In view of the foregoing...the Commission would like to inform the general public to exercise caution and avoid the purchase or consumption of the recalled products," said the regional trading bloc's competition watchdog in a statement. "If the above products were already purchased, consumers are advised to return the products where they were purchased for a refund or replacement."

The World Health Organisation states patulin, which is classified as a cotoxin, is a naturally occurring toxin created by certain mycotoxins that can be found in apples and apple products. The risk of consuming patulin exceeding some of the roles particularly in $50 \rightarrow g/l$ may lead to vomiting, nausea

TANZANIA can make strides in combating counterfeits if it fully adopts Electronic Tax Stamps (ETS), thanks to their ability to track and trace manufactured goods.

This is due to the fact that tracking and tracing security features that are embedded in the ETS' make it easy to tell which one is fake and which one is original according to ETS project manager at Tanzania Revenue Authority (TRA) Innocent Minja.

ETS' -- which was adopted in January 2019 -- both the taxman and the consumer can easily and effectively tell whether the stamp fixed on a product is original or fake.

Minja said through a mobile app, which is set for launch soon, every individual will also be able to track and trace the authenticity of a product before consuming.

This is contrary to the previous paper stamps which were difficult to tell between the original and the fake one.

Data from TRA show that there had been a significant rise in the number of manufacturers whose products are affixed with ETS' during the past two years.

"The number of manufacturers of beer, spirits and wines has risen significantly from only 57 before the introduction of ETs' to 272 as of August this year," said Minja.

In Tanzania, the government announced plans to adopt the Electronic Tax Stamps (ETS) system in June 2018 and the first phase was conducted on January 15, 2019 whereby stamps were installed on companies that produce beer, wine and spirits.

Phase two of the project was rolled out on August 1, 2019 when ETS' were stamped on sweetened flavored water and other non-alcoholic beverages, like energy and malt drinks and soda.

The third phase, which involved enrolling electronic stamps on fruit juices (including grape must), vegetable juices (under Heading 20.09), and bottled drinking water, was conducted November 1, 2020.

This, according to Minja, is also a step ahead to both the government and manufacturers because it removes the need for TRA officials and a manufacturing company or an importer to go through the hassle of sitting down and discussing the right amount to be paid in tax.

Since the adoption of ETS', excise duty collections have risen 60 - percent if the three years prior to the rollout of ETS' on beer, wines and spirits is compared to an almost similar period after the rollout.

We need to build community resilience to disasters globally

problem occurring over a short or long period of time that causes widespread human, material, economic or environmental loss which exceeds the ability of the affected community or society to cope using its own resources. Developing countries suffer the greatest costs when a disaster hits - more than 95 per cent of all deaths caused by hazards occur in developing countries, and losses due to natural hazards are 20 times greater (as a percentage of GDP) in developing countries than in industrialized countries. No matter what society disasters occur in, they tend to induce change in government and social life. They may even alter the course of history by broadly affecting entire populations and exposing mismanagement or corruption regardless of how tightly information is controlled in a society.

The United Nations General Assembly designated the 1990s as the International Decade for Natural Disaster Reduction. Its basic objective was to decrease the loss of life, property destruction and social and economic disruption caused by natural disasters, such as earthquakes, tsunamis, floods, landslides, volcanic eruptions, droughts, locust infestations, and other disasters of natural origin. An

disaster is a serious International Decade for Natural Disaster Reduction, beginning on 1 January 1990, was launched by the United Nations, following the adoption of resolution. The decade was intended to reduce, through concerted international action, especially in developing countries, loss of life, property damage and social and economic disruption caused by natural disasters. To support the activities of the decade, a Secretariat was established at the United Nations Office in Geneva, in close association with UNDRO.

The International Day for Disaster Reduction (IDDR) is an international day that encourages every citizen and government to take part in building more disaster-resilient communities and nations. 

problem perennial for many developing countries is how to retain highly-trained medical staff within the public sector without breaking the national budget, thus causing an economic collapse, or without having to ration medical services by ability to pay by allowing the private health sector to dominate.

Zimbabwe faces this problem. A lot of effort and money is spent on training doctors, nurses and other health professionals and the numbers that go through university and nursing schools is more than adequate to meet national requirements.

Improving health staff conditions the panacea



have significant influences on a couple's contraceptive use, pilot programmes to engage men have focused on increasing knowledge, enhancing spousal communication, and de-stigmatising use of family planning methods.

Renewed interests in involving men stem not only from women's reproductive health needs, but also to address men's own sexual health concerns, as well as efforts to achieve the Sustainable Development Goals for reduction of maternal mortality and HIV transmission.

Use of modern contraception and family planning services is integral in the prevention of unwanted pregnancy, reduction of unsafe abortions, and promotion of childbirth spacing to lower maternal and child mortality risks in developing countries. Family planning also promotes gender equity and greater educational and economic opportunities for women.

Vasectomy is a surgical procedure for male sterilisation or permanent contraception. During the procedure, the male vasa deferentia are cut and tied or sealed so as to prevent sperm from entering into the urethra and thereby prevent fertilisation of a female through sexual intercourse. Vasectomies are usually performed in a physician's office, medical clinic, or, when performed on an animal, in a veterinary clinic-hospitalisation is not normally required as the procedure is not complicated, the incisions are small, and the necessary equipment routine.

There are several methods by which a surgeon might complete a vasectomy procedure, all of which occlude (i.e., "seal") at least one side of each vas deferens. To help reduce anxiety and increase patient comfort, men who have an aversion to needles may consider a "noneedle" application of anesthesia while the "no-scalpel" or "openended" techniques help to accelerate recovery times and increase the many vasectomy patients find that they can resume their typical sexual behaviour within a week, and do so with little or no discomfort.

Because the procedure is considered a permanent method of contraception and is not easily reversed, men are usually counseled and advised to consider how the long-term outcome of a vasectomy might affect them both emotionally and physically. The procedure is not often encouraged for young single childless men as their chances for biological parenthood are thereby more or less permanently reduced to almost zero, but ultimately is up to their own comfort in possibly wanting to conceive a child with a partner. It is seldom performed on dogs (castration, a different procedure, remains the preferred reproductive control option for canines) but is regularly performed on bulls.

World Vasectomy Day (WVD) is an annual event to raise global awareness of vasectomy as a male-oriented solution to prevent unintended pregnancies. The goal is for doctors all over the world to perform vasectomies, connected to the event via Skype and social media platforms.

WVD was founded in 2012 by the American film-maker Jonathan Stack while he was working on a documentary about the decision of having a vasectomy. The underlying goal was to involve men in family planning decisions and educate them about vasectomies as a simple way of taking responsibility for birth control.

In 2013, prolific vasectomist Dr Douglas Stein was scheduled to perform vasectomies in front of an audience at the Royal Institution of Australia (RiAus) to launch the inaugural World Vasectomy Day with the world's first live-streamed vasectomy. Stein answered questions from a live audience in Australia and an international online audience.

But then two problems arise. The first is the strong flow from the public sector into private practice and private health facilities. These are continually expanding, with the expansion driven in a large part, at least in the past, by a decline in the public sector. In many ways that flow of skilled professional staff accelerated the public sector decline.

Private hospitals and clinics could pay better, and could ensure that their staff had access to the necessary equipment, medications and medical supplies

Normally such a flow would be limited, as even when fees are charged the amount a patient or a patient's family has to find in the public sector is a small fraction of what purely private professionals, hospitals and health centres will charge. But families, faced with serious illness, will find the money, even if they have to borrow.

But generally the top 10 percent of the population in terms of family income use a substantial percentage of available health resources. Yet the other 90 percent, who cannot afford the private sector, are not measurably healthier.

The second problem, and this accelerated in the economic meltdown in the days of hyperinflation, is the emigration drift. Zimbabwean training is considered excellent and the professional certifying bodies are considered very good gatekeepers in setting international standards. Zimbabwean doctors and nurses are seen as desirable immigrants into countries with money but a shortage of professional health staff.

Even in the growing international anti-immigrant cultures, medical professionals can find openings denied to many others, although they might well have to spend some years at the beginning filling posts that local people are reluctant to fill. But emigration has been an option and is still an option, especially for younger professionals who can go through the mill of working in areas that are considered less desirable for a few years.

Some serious work has been done in the Second Republic on fixing the public health sector. Within the last two years a lot of hospitals have had at least the worst of neglected maintenance work done and in the general drive for improvement the shortages of equipment and drugs has been seriously addressed. This is continuous of course, and the budget has to cope with catching up as well as the routine maintenance that still needs to take place. But the work is now being done.

A lot of bad staff relations are now being fixed. The near continuous labour disputes have been tackled, partly through the general progress being made by the Government for the whole State sector as part of economic and budgetary reform. Progress is obviously not as fast as staff would desire but at least there is a plus sign on the directions.

One important aspect comes with economic growth. In the end, pushing Zimbabwe into a middle income economy will automatically ensure that the level of tax gathered will, with the health budget taking the same percentage, be enough to equip the public hospitals and clinics and pay the staff properly.

But part of that growth is dependent on having a fully functioning public health system in place now. It is not something that can be neglected and added later when there is enough money.

The Government has been tackling this problem since it came into office, and the advent of Covid-19 helped to accelerate the progress as well as exposing gaps that needed urgent ad hoc action. One of these major gaps was the discovery that the urban local authorities in general, and those in Chitungwiza and Harare in particular, had as part of their general poor administration been skimping seriously on health.

Government has decided to take over the municipal health staff, to ensure that they are at least paid, paid on time and that the hundreds of vacancies that have arisen are filled so that the basic clinic system can function. When some remote rural district council manages its basic primary health system better than Harare we know there are troubles.

Now the Cabinet wants to go further and this week started looking at how to convert the rhetoric on perks into action. Basically the idea is to start capitalising some of the staff requirements. Already a fair number of professionals have access to inexpensive State housing, with rural health centres totally reliant on providing this if they want even a nurse. It is not new but obviously the State housing schemes now in progress have to include a significant

element for health staff.

This must include both institutional houses and flats near hospitals and health centres for those assigned to these and a way of helping staff buy or build their own homes.

Getting transport sorted out seems essential. Many medical professionals work shifts and relying on public transport does not seem possible, let alone ideal. Again the Government has been allocating a decent share of the new buses and other public transport services to the health sector and now want to do more.

Car loan schemes have been on the books in the past with the general intent damaged by inflation and other economic problems now being sorted out. Ideally there should be a block of capital that health staff can tap into to buy their private vehicles with the repayments being used to lend to the next batch of applicants. Lowish inflation seems essential for this work, again linking the system to economic reforms.

But the general concept could be extended, the Cabinet believes. It seems that with this desire, coupled with the significant improvements in labour relations, some detailed and creative discussions should be possible that tie together the budgets available with the priorities that staff have. Again the important point is continual improvement since sudden jumps are difficult.

Table banking helping women in Kenya to put food on the table

NAIROBI

ASCALINE Chemutai's five acres of land located in the country's breadbasket region of Rift Valley recently produced 115 bags of maize, each weighing 90 kilograms. She tells IPS that of these, 110 bags will be transported to traders in Nairobi and neighbouring Kiambu County at a negotiated price of \$23 per bag.

In all, she will have pocketed about \$2,500, a significant amount in the village. Not only will she have enough to feed her family of five, but to pay for their school fees and other basic needs. Besides maize farming, Chemutai sells milk to residents in town.

The 45-year-old farmer widowed eight years ago with five young children says that her life as a farmer was made possible and is sustained through table banking.

"My husband was in charge of our farm and handled all business related to the farm. I knew how to farm because I grew up cultivating land, but I had no money to buy seeds and fertilizer or knowledge on the business side of farming," she says.

Fortunately, a year before the demise of her husband, Chemutai joined a table banking group under the Joyful Women Organization (JOYWO), a registered NGO focused on the economic empowerment of women.

As the name suggests, women place their savings on a table and immediately loan each other accumulated funds.

"Women knew of village saving groups where contributions were spent on household items such as cups, plates and even beddings. We were now learning about saving and borrowing," she says.

Sharon Alice Anyango says that the simple concept of table banking, where a group of 10 to 35 members use the group-based strategy to fundraise by saving, placing their savings on a table, and borrowing immediately, has turned tables on the systematic and systemic financial exclusion of women.

"Table banking is addressing the primary challenges that women face when dealing with banks and other financial institutions. Where they needed collateral that they did not have to access bank loans, today, they successfully fundraise amongst themselves," says Anyango, a project officer at the Ministry of Public Service, Youth and Gender.

JOYWO, whose current patron is Rachael Ruto, the wife of Deputy President William Ruto, claims to have a revolving fund of at least \$27 million in the hands of its estimated 200,000 members across 1,200 table banking groups in all parts of the country.

"Other estimates show that so popular is the table banking movement that cumulatively, table banking groups throughout the country circulate approximately \$550,000 to \$730,000," Anyango says.

She explains that only women were involved at the start, but as they started to accumulate funds, men became interested.

"Men have seen the magic," she says.

Now the table banking fraternity allows men to join, but the groups' constitutions ensure that at least 70 percent of the members and all the leadership positions are women.

Chemutai says that their table banking group of 20 members currently has a revolving fund of \$30,000. She has taken loans valued at \$2,000 to fund various farming and animal husbandry ventures in the last year.

"Seeds, fertilizer, labour, tractors and veterinary services, salary for my farm boy and feeds for my cows cost a lot of money. I borrow from the group and repay, and this cycle repeats itself every year, and all my activities are running smoothly," she tells IPS.

"Table banking has also linked me to a reliable market. We started interacting with other table banking groups from other parts of the country, and that is how I man-

aged to find a market. I sell all my maize to other women in table banking groups within Nairobi and Kiambu counties. I would never have met these women if it was not for table banking," she says.

Chemutai's story is in line with research from the Barilla Center for Food and Nutrition that points to "a high probability that any agricultural product that we buy has been produced by a woman. Women's contribution is essential for the food security of entire communities and for the farming production of many developing and rural communities.

The research further points to the many gender disparities that prevent women such as Chemutai from accessing financing. On paper, Chemutai does not own an asset to be used as collateral despite having access to five acres of land because the land is 'ancestral' land.

As per the Barilla Center for Food and Nutrition and

undoubtedly true for many women in agriculture, "when women are guaranteed the same access as men to community resources, services and economic opportunities, production increased, the economic and social benefits of the community improve, and malnutrition and poverty are reduced."

Celebrated every October 16, as the global community marks yet another World Food Day under the theme "Our actions are our future. Better production, better nutrition, a better environment and a better life", gender experts, such as Anyango, tell IPS that this is the level of access that women need to feed the global population.

Agriculture is still the largest employment sector for 60 percent of women in Sub-Saharan Africa. Women like Chemutai also make up two-thirds of the world's 600 million small livestock managers, according to the U.N's Food and Agriculture Organization (FAO).

Despite their contribution to agriculture, financing is still largely not affordable, available, and accessible to women farmers. In this East African nation where the table banking movement is more concentrated in rural areas, women now have a lifeline to fund agricultural activities with loans taken under friendly terms and conditions.

Anyango asserts that women must be at the centre of World Food Day's collective action across 150 countries to promote worldwide awareness of global hunger and the need to ensure healthy diets for all.

Covid-19 deepened the challenges faced by small-scale fishers in South Africa

ASTAL small-scale fishing communities in South Africa are often marginal communities situated in rural areas, with limited job and income opportunities. Fishing plays an extremely important role in ensuring local food and nutrition security as well as in developing the local economy

Fish is an integral part of the diet of coastal communities, providing important micronutrients and ensuring

a moment of crisis. This has emphasised the need for the development of more localised markets, the recognition of the sector as an important provider of nutritious food, and the prioritisation of small-scale fishing in policy.

For example, small-scale fishers in the Western Cape export a large amount of their catch to the Chinese and European markets, and also supply the tourist and restaurant markets with fresh fish, illustrating a reliance on what are termed 'long value chains'. Long value chains include



which, although necessary, failed to meet the food security and household needs.

Looking to the future, a more resilient small-scale fisheries food system would align with the principles of food sovereignty, putting people's need for food at the centre of policies, localising food systems and valuing food providers and producers, and building on traditional knowledge.

A more resilient food system would keep the highly nutritious food within the community, rather than relying on long value chains and exporting nutritional food sources or feeding into an elite market. A more resilient food system would be supported in keeping the control local, benefiting the broader community, and incorporating and strengthening the role of women in the value chain through the development of cold storage infrastructures and processing facilities. It is imperative that the implementation of the Small-scale Fisheries Policy of 2012 in the Western Cape is a just, equitable, and inclusive process. The formation of the small-scale fishing cooperatives under the policy needs to include adequate training and a mentorship programme in order to ensure the success of the cooperatives and to allow for the development of the sector and the inclusion and benefit of the broader community. **DM**

a more holistic nutrient profile. Fishing also represents more than access to livelihoods, food, and nutrition; it represents a cultural, traditional, and historical connection to their way of life, to the ocean, and to their ancestors.

World Food Day on 16 October 2021, was an opportunity to reflect on the past year and a half of South Africa under the lockdowns and regulations imposed by the government in response to the Covid-19 pandemic, and examine the impact that this has had on the small-scale fisheries food system.

When we do this we find that the restrictions that were implemented in response to Covid-19 have highlighted the flaws in the system and deepened the existing challenges that have been faced by small-scale fishers. This food system has exhibited a lack of resilience in the face of

multiple points of value-adding activities with different food system actors, such as traders, marketers, and markets. Fish passes hands multiple times between producer and consumer, resulting in increased travel time as well as decreased income for the producer.

The export ban and the closure of restaurants resulted in a sudden decrease in demand and therefore a drastic drop in fish prices.

Small-scale fishers, despite being recognised as essential service providers on 26 March 2020 and being able to practise their livelihood, were unable to sell their catch and lost out on a large portion of their annual income. This case illustrates the lack of resilience in long value chains. Shorter value chains and more localised markets better withstand shocks to the system while keeping control local and ensuring community food

WFD: Time for global leaders to invest in Africa's agriculture

MORE than six out of every 10 people in Sub-Saharan Africa work in the continent's agriculture sector. We may not realize that what grows from African soil may be connected to some of the world's most popular foods.

Africa produces the world's largest supply of cocoa, used in chocolate bars and other products. Ethiopia and Uganda-grown coffee beans, which dominate Africa's coffee exports, valued at nearly \$2 billion last year.

The volume of African commodity exports is rising. At the same time, more Africans are facing food insecurity. Around 246 million Africans go to bed hungry every night. The pace of Africa's agricultural growth is not keeping up with Africa's population growth.

On World Food Day, it is time for African and global leaders, as well as development organizations, to ioin the African Development Bank Group's call for increased investments in agricultural technologies that boost Africa's food production and food security in the face of climate change.

The continent has immense potential to feed itself and to become a breadbasket to the world: about 65 percent of Earth's remaining uncultivated, arable land is in Africa. However, that potential is threatened by erratic weather extremes.

It is also stunted because a majority of African food growers are subsistence smallholder farmers. We need to scale up delivery of modern and climate-smart farming practices.

The African Development Bank Group's investments are helping African farmers put more food in the mouths of more Africans. Since the Bank launched its Feed Africa Strategy in 2015, more than 74 million people are benefiting from access to improved agricultural technologies, resulting in higher food production.

Our flagship program, Technologies for African Agricultural Transformation (TAAT) has provided 11 million farmers across 29 African countries with proven agricultural technologies such as drought-resistant maize, heat-resistant wheat, higher-yielding seed varieties and seed treatments to protect against pests like the fall armyworm, which has been devastating African crops in waves of hungry, winged swarms.

TAAT has produced astonishing results in under three years. African food production has expanded by more than 12 million metric tons. TAAT has reduced Africa's food imports worth \$814 million. We are on our way to reaching our target of reaching 40 million farmers with modern and climate-resilient technologies.

Aligned with the World Food Day 2021 theme, "Our actions are our future. Better production, bet-

ter nutrition, a better environment and a better life," the Bank is delivering higher food production, access to more nutritious foods and helping farmers adapt to environments impacted by climate change. We advocate for gender-sensitive policy reform and gender-inclusive development.

Combined, these activities are raising incomes for women and men in farming and contributing to a better quality of life for Africans

The Bank's Affirmative Finance Action for Women in Africa (AFAWA) initiative aims to reduce the access to financing gap women businesses face across the continent, including women working in agriculture.

AFAWA has just put \$20 million into a project on financing climateresilient agricultural practices in

Ghana. It will target hundreds of women-led enterprises through lines of credit with Ecobank Ghana, as well as provide them skills training on climate adaptive farming.

We are on the right path, but we need to do more. At a recent "Feeding Africa" event hosted by the Bank and the UN International Fund for Agricultural Development, more than a dozen African heads of state and other world leaders endorsed proach to investing in agriculture and agri-business, based on five pillars--scaling up of proven climateadapted, science-based production and other technologies; creating an enabling environment for enhanc-

cess to modern technologies; building critical backbone infrastructure linking production areas to markets and processing at African national and regional levels; crowding in private-sector investments and access to finance. Private sector investment and business expertise will grow food supply chain commercial viability, as well as inclusion of more small and medium enterprises and smallholder farmers and support to an African special emergency assistance fund on famine and drought.

The Facility expects to mobilize \$1 billion over the next two years from green funds, bilateral and multilateral donors to support these pillars. We need more government, development partner, private sector and foundation "buy in" to scale up investments in this Facility.

The African Development Bank envisages a food-secure Africa that uses advanced technologies, creatively adapts to climate change and develops a new generation of "agripreneurs" - empowered youth and women who will modernize and industrialize agriculture.

The Financing Facility aims to accomplish that by bringing smart "agritech" to help millions of more African farmers to double major crop yields, produce enough food to feed an additional 200 million people and reduce incidents of malnutrition.

Zanzibar activist queries authorities over appointment of liquor board

ZANZIBAR-based human rights and good governance activist, Ali Makame Issa has said it was inappropriate for the Zanzibar Government to quietly appoint a new Alcohol Prevention and Control Board, saying it was against the law.

Addressing reporters here

over the weekend, Issa said the board is supposed to be officially announced to enable the public to know the appointed board members to assess their ethical outlook and standing in managing the law following liquor becoming a grave issue for concern in the Isles.

"We congratulate president Hussein Ali Mwinyi for creating a new board, but we appeal for the names of its members to be published just as for the other government appointments, it

should not have been done so quietly," he added. He said the new board is supposed to oversee the law because right now there are European

investors in the tourism sector who also import alcoholic drinks

thereby denying the government of revenue.

"The Zanzibar Alcohol Control Act (No. 9 of 2020) says importers of alcoholic drinks must be Zanzibaris qualified as citizens and residents of Zanzibar, so we want the new Board to oversee the laws just like it was enacted," he said.

He further said the govern-

ment must abide by the basics of its laws especially on the issue of tendering to avoid the possibility of many issues going against the law just as it was in the case of Bwawani Hotel.

"Bwawani Hotel was demolished and the tender awarded to an investor but so far no development is being made regarding the project thereby denying the government of revenue due to lack of good governance," Makame added.

He said the board was dissolved after it failed to oversee the Zanzibar Alcohol Control Act (No 9 of 2020), including issuing liquor import permits to more than three firms as well as contravening Section 28(k) of the Act that had set a condition for bars

to be more than 1,000 metres away from areas with basic social services including schools, health centres, mosques, churches, madrassas, markets or bus stations.

For his part, the Chairman of the new board, Khamis Haji confirmed that he was indeed the chairman of the new board, but was not ready to name board members.

Unprecedented hunger to follow in wake of the climate crisis, WFP calls for urgent action

THE world faces an exponential increase in hunger fuelled by the climate crisis if urgent global action to help communities adapt to climatic shocks and stresses is ignored, the United Nations World Food Programme (WFP) warns ahead of World Food Day, on 16 October.

A WFP analysis shows that a 2°C rise in average global temperature from pre-industrial levels will see a staggering 189 million additional people in the grips of hunger. Vulnerable communities, a vast majority of whom rely on agriculture, fishing, and livestock and, who contribute the least to the climate crisis, will continue to bear the brunt of the impacts with limited means to cushion the blow.

"Large swathes of the globe, from Madagascar to Honduras to Bangladesh, are in the throes of a climate crisis that is now a daily reality for millions. The climate crisis is fuelling a food crisis," said WFP Executive Director David Beasley.

Tens of thousands of lives are at

of the potentially many places in the world currently where faminelike conditions have been driven by climate change. Consecutive droughts have pushed nearly 1.1 million people into severe hunger. Nearly 14,000 of them are in famine-like conditions and this number is expected to double by the end of the year. Up to 63 percent of people in the south of the country are subsistence farmers who have seen their livelihoods collapse, and their only source of food dry up, due to drought.

The climate crisis: a threat multiplier

When coupled with conflict, the climate crisis exacerbates existing vulnerabilities, magnifying the damage, destruction and despair. Extreme climate events in conflictaffected areas destroy the already meagre resources at the disposal of families and even hamper humanitarian efforts reaching communities.

In Afghanistan, severe drought tied to conflict and economic hard-

risk in southern Madagascar, one ship has left a third of the population reeling with hunger.

> "If this is the new normal, we can't keep lurching from disaster to disaster. We need to go beyond just picking up the pieces after the crisis hits, and instead manage climate risks so they no longer have the power to destroy the food security of vulnerable communities. This is where WFP's unique expertise comes in," added Beasley.

Manage risks rather than disasters

WFP is helping communities adapt to the changing climate that threatens their ability to grow food, secure incomes and withstand shocks. It has supported 39 governments, helping them realize their national climate ambitions.

In 2020, WFP implemented climate risk management solutions in 28 countries, benefiting more than six million people so that they are better prepared for climate shocks and stresses and can recover faster. WFP has mobilized nearly US\$300 million for climate action in the past decade.

In Bangladesh, WFP supports communities affected by heavy monsoons and flooding with cash assistance ahead of disasters so that they are able to buy food and medicine, protect critical assets, and transport livestock and families to safe places. By using early warning data to trigger action, WFP empowered households to prepare for flood impacts and prevent losses and damages. This reduced the cost of the emergency response by over half.

WFP, working with partners, has protected 1.5 million people in Mali, Mauritania, Burkina Faso, Zimbabwe, and the Gambia from catastrophic drought events with climate risk insurance, through the African Risk Capacity Replica Initiative.

"Conflict is plunging millions into hunger today, but the climate crisis has the potential to dwarf conflict as the main cause of hunger tomorrow. We urgently need to invest in early warning systems and climate adaptation and resilience programmes to avert this looming humanitarian disaster," said Beasley.

THE government of Sweden, and United Nations Development Programme (UNDP) have signed a SEK 5,000,000 agreement to promote socio-economic development and peacebuilding in Africa's borderland regions in the Liptako-Gourma in West Africa, and the Karamoja Cluster in East Africa. In many of these communities however, insecurity and poverty, made worse by climate change emergencies, conflict and, more recently, the COVID-19 pandemic, remain a critical impedi-

ment to socio-economic progress. This agreement confirms the firm conviction of Sweden, UNDP and their implementing partners that improved circumstances could help unlock the development potential and local innovation capabilities of Africa's borderland communities and strengthen their progress towards achieving the SDGs and Africa's Agenda 2063.

Ulla Andrén, Head of Regional Development Cooperation at the Embassy of Sweden in Addis Ababa signed the agreement on behalf of Sweden and stated, "We are glad to be able to support innovative projects like this. Many borderland regions experience challenging security issues, and we need to support initiatives that promote all the positive aspects of the dynamic borderland areas in the joint strive for a peaceful and secure Africa. We are particularly looking forward to following how this partnership will enhance the involvement of women and youth."

Stan Nkwain, Director a.i. of the UNDP Regional Service Centre for Africa, signed the agreement on behalf of UNDP and stated, "I would like to thank the Government and the people of Sweden for their partnership and commitment in supporting historically marginalized communities in Africa's borderlands, through UNDP's Africa Borderlands Centre. I hope that this initiative can be a catalyst to bring more attention and resources to Africa's borderlands."

The one-year partnership, which will be implemented by UNDP's Regional Programme for Africa, will embrace the opportunities in Africa's borderlands with a particular focus on engaging and empowering women and youth.

There are three areas of focus for the partnership--Improving livelihoods for borderland communities in the Liptako-Gourma region through promoting innovation on informal cross-border trade and access to markets in Niger, Mali and Burkina Faso; strengthening the engagement and capacity of borderland civil society organizations in East Africa and the Horn of Africa; and promoting sustainable peace and development in the Karamoja region of Uganda and Kenya, while supporting the Governments of Kenya and Uganda in the development a cross-border programme.

This is why Pakistani women feel unsafe in public spaces

HE mauling, groping and tossing of a young woman by a crowd of between 300 and 400 men in a park in the eastern city of Lahore, in the Punjab province, may have caused a wave of country-wide disgust, but speaks volumes of how unsafe public spaces are for Pakistani women.

"If I'm not safe in my own city, I can never be safe in any corner of the world," said the woman survivor, also a TikTokker, in an interview narrating the incident that occurred on Pakistan's 74th day of independence and was captured on videos that went viral soon after.

Actor Ushna Shah echoed the same sentiment on Twitter: "What else has to happen for every single person to accept the fact that women are not safe in Pakistan. Women are not safe."

"Over the years, public spaces for women in Pakistan have been decreasing," lamented Sheema Kermani, a renowned classical dancer, and founder of Karachi-based Tehrik-e-Niswan, a women's rights group. She and her group have had their share of unwarranted episodes, performing in public spaces, even doing street theatre. They have had stones hurled at them or have been asked to stop their performance, in which case they pack up immediately and leave to "avoid confrontation".

Despite more women joining the workforce and the emergence of young feminist groups that have "actually pushed for making public spaces safe for women," Kermani observed, "the last couple of years has

taken Pakistani society back many hundreds of years" where women are "hated, demeaned, exploited, abused, even raped". She added: "It is as if their lives are of little consequence.'

And that is what the TikTokker felt when she said: "They [men] were playing with me," as they ripped off her clothes.

This incident comes just weeks after the beheading of a former diplomat's daughter in the capital. Another undated video that went viral, following the TikTokker's assault, showed a man lunging towards two women riding on the back of a rickshaw and is heard kissing one of them. Police are investigating yet another video of a woman being stripped by a group of men in a park.

Prime Minister Imran Khan does not make it easier either when he blames women for these crimes that he says are "spreading like cancer". "Wearing very few clothes," he said, will have an "impact on the men unless they are robots". In 2019, the information minister quoted the Prime Minister for blaming TikTok, a social media platform, for the "growing obscenity and vulgarity in society".

"But I was not even vulgarly dressed," the TikTok survivor had said in her interview.

"I can well imagine this woman's trauma," said TV anchorperson Maria Memon.

She had faced an unruly mob while covering an anti-government protest sit-in by the now ruling Pakistan Tehrik-e-Insaf (PTI), in Faisalabad, also in Punjab, in 2014, that had left her "shaken to the core" after being attacked by a volley of ver-

bal abuse.

"They wanted to see me break down," she said. When that did not happen, they started "throwing empty plastic water bottles and sticks at me," she told IPS over the phone from Islamabad, the country's capital.

Seven years later, said Memon, Pakistani women journalists remain "untrained", "unprepared", and "vulnerable" to a crowd that can quickly turn violent. While media outlets want to send women to these events, they seldom have a contingency escape plan to quickly evacuate them when things get rough.

In 2018, the London-based Thomson Reuters Foundation ranked Pakistan the sixth most dangerous country and fifth on nonsexual violence, including domestic abuse in the world for women.

"Unless these men are not punished, there

will be no stopping them," said Sana Mirza, Memon's colleague, who faced a similar situation in another PTI rally in Lahore, just a few weeks after Memon, in 2014.

Unlike Memon, she broke down in front of the camera, "feeling humiliated," she said, and the episode continued haunting her, and she refused to go out in the field for a good eight months. "I even removed myself from social media as these platforms had become too toxic, and I was unable to sleep," she told IPS over the phone from Islamabad.

While many women, had they experienced what the TikTokker's went through, would have kept silent, Mirza said, she saluted this woman "for her courage to lodge a complaint to the police".

So far, over 60 men have been arrested after they were identified through the video using the national database. The police have

geo-fenced 28,000 people police uniform than in plain and shortlisted 350 suspects, and the arrests continue.

But Mirza remains unconvinced the arrested men arrested will be punished. "They never are. Just look at the statistics!" she said.

According to Karachibased War Against Rape, while sexual assault and rape cases have increased, the conviction rate is less than 3%. And this figure is about the crimes that are reported. While the "system may not be perfect", Amna Baig, an Islamabad-based police-

woman, defending the police system by not reporting such incidents was "emboldening" perpetrators. She termed the complaint filing by the Tik-Tok user, albeit three days late, a very "courageous" step.

In her five years of being in the force at various cities in Punjab, she said, she had come across several murders of women by their spouses. Still, neither the deceased nor any family member ever filed a complaint of domestic violence (DV) before the murder.

"You can save so many lives if you report," she said, adding, "Just lodging a complaint can act as a deterrent because the person knows he will be held accountable". Interestingly, Baig feels "safer" and "empowered" in a

clothes. "I think the uniform exudes both the fear factor as well as respect," and has never been harassed while on duty.

Still, it is not too late to ensure "women's choices, voices, and lives count" if you ask Senator Sherry Rehman.

It was time to bring to life the domestic violence bill that she had first introduced back in 2004, as a member of the national assembly, but which she continues to stumble "on the barriers of misogyny and anti-women lobbies".

The Council of Islamic Ideology (CII) is vetting it to ensure it is in tandem with the Shariah [Islamic law].

"Why are only legislations related to women sent to the CII?" asked Rehman. "Like the rest, these too, can be discussed in the parliament, and their fate decided through voting just the way other bills are discussed and passed," she added.

While she admitted no one law or series of laws would change the game, moving the law is the starting point, not the endpoint for change.

"Without baseline laws against domestic violence, for instance, such as the one in Sindh, the courts won't have the legal scaffolding to provide the relief even if they are so inclined," she pointed out. **IPS**

China uses digital technologies to cut carbon emissions in transportation

HE rapid development of digital technologies is prompting a shift in China's traditional transportation industry.

Achieving a fuel consumption of 27.75 liters per 100 km, Jiang Zhili, a 39-year-old truck driver from central China's Henan Province, was the runner-up in an online fuel-saving contest involving truck drivers.

try's total carbon emissions, with over 80 percent from the road freight transport, data showed.

As China strives to meet its commitment to peak carbon emissions before 2030 and achieve carbon neutrality before 2060, it has encouraged deep integration of new technologies like big data, internet, artificial intelligence and blockchain with the transport sector, as well as more efforts to foster

cities nationwide. With smart recommendations through the use of big

data, Manbang Group helps truck drivers find goods quickly and reduces empty-load rates and fuel consumption, cutting carbon emissions by an estimated 330,000 tonnes in 2020, the company said.

"We actively fulfill our social responsibilities and obligations by promoting cost reduction, efficiency, energy conservation and emission reduction in the logistics industry," said Xu Oiang, vice president of Manbang Group. In the future, the company will establish a carbon emission management platform, optimize the transportation organization mode and promote the use of new energy vehicles, Xu added. Besides highway freight service, other sectors in the transportation field have also been adopting new technologies to tackle carbon emissions. When an aircraft descends,



In addition to excellent driving skills and experience, Jiang attributed his success to a mobile app that can monitor diesel consumption of vehicles in real time, evaluate drivers' operation and give reasonable suggestions after analysis.

Developed by Jiefang, a truck subsidiary of China's leading automaker FAW Group, the app was launched in 2019, which has made truck driving easier and more fuel-efficient.

Transport is responsible for around a quarter of direct CO2 emissions from fossil fuel combustion, according to statistics from a United Nations report on sustainable transport. Carbon emissions by the transport sector in China account for about 10 percent of the couna green and low-carbon way of transport.

The total size of China's intelligent transportation market increased from 42 billion yuan (about 6.53 billion U.S. dollars) in 2011 to 165.8 billion yuan in 2020, with an annual growth rate of about 20 percent, according to statistics released by China Intelligent Transportation Systems Association. Manbang Group, China's leading domestic freight service platform, has used digitization to help reduce carbon emissions in transportation. Headquartered in Guiyang, capital of southwest China's Guizhou Province, the company serves around one-fifth of the country's truck drivers, with businesses covering more than 300

"The full application of internet and digital technology in the transportation sector plays an active role in improving the industry efficiency and

Nigeria home services app to get makeover after securing US\$1.4m

LAGOS

LAGOS-BASED home services app Eden Life has secured a US\$1.4-million in investment which it says it will use to "build out" its in-house technology, develop its own kitchens and operations hubs as part of the construction of new tech-based platform in a fresh effort to bolster Africa's service industry.

The funding round was led by UK-based LocalGlobe, along with participation from Samurai Incu-

bate, Future Africa, Village Global, Rising Tide Africa and Enza Capital. The platform is used to schedule food, laundry and cleaning services and according to Eden Life, the latest funding brings total investment to date to US\$2-m following pre-seed backing from all of Andela's original co-founders, and additional accelerator support over the last 18 months.

Launched in 2019 by three former Andelans, and dubbed "the concierge of comfort", Eden Life was developed for busy Lagos professionals who are often time-poor due to long working hours and struggle to source and coordinate dependable, efficient and trustworthy home services providers.

The app, available on Google Play and the App Store, offers users a subscription service that delivers high quality chef-cooked meals, laundry service and home cleaning as well as tracking progress on all their services. Users can subscribe to one or more of the services and set the frequency they want the services delivered.

INVESTMENT French government to support African tech startups with additional \$150m funding

PARIS

FRENCH President Emmanuel Macron has made a new US\$150 million commitment to support 500 African startups for the next three years as part of redefining the Digital Africa Initiative. This new funding was announced at the New Africa-France Summit.

He further affirmed that Digital Africa is now part of Proparco, the private sector subsidiary of the Agence Française de Développement (AFD). Launched in 2018 with the mission to equip African tech entrepreneurs with capabilities to design and scale up ground-breaking innovations for the real economy, Digital Africa brings together startups, academia, incubators, institutional financiers, venture capitalists and technology clusters to help develop the African startup

space

At the event, Digital Africa also unveiled a host of new programmes. In terms of financing, it announced the Fuzé project, which focuses on Francophone Africa and aims to support at least 200 tech startups by early 2022 via a new small ticket fund. This will provide, in stages, funds of between EUR10,000 (US\$12,000) to EUR200,000 (US\$230,000) in the form of repayable loans.

In terms of skills, Digital Africa has joined forces with Make IT and the German government to set up Talent4StartUps, a fellowship programme designed to meet the needs of talents that have been trained in tech and digital, and put them in touch with startups actively recruiting.

More broadly, Digital Africa will continue to develop non-financial

activities such as knowledge production, training, networking, research, and support for the evolution of regulatory frameworks, while having the opportunity to raise funds from other public or private donors. This will be enabled by its new status as a subsidiary of Proparco.

"Digital Africa's new organisation, redefined with our partners, allows us to reinforce our commitment to "made in Africa" tech innovations and become a factory for future African unicorns. Startups need a one-stop-shop combining training, research, projectstructuring, support to pro-tech and pro-innovation reforms, and financing," said Digital Africa's chief executive officer (CEO) Stéphan-Eloise Gras.

"From now on, thanks to the merger with Proparco, they will find in Digital Africa a partner capable of offering them support from ideation and seed to growth and hypergrowth. By putting tech at the service of transparency and efficiency in development aid, and by getting closer to the private sector, Digital Africa wants to make a long-lasting difference."

The Digital Africa team is now preparing a roadshow that will take place at the end of this quarter and will stop in several African regions to strengthen connections with key partners and players, promote the programmes, and invite African startups to apply. These field trips will also be an opportunity to finalise new projects, including the "product-market fit academy" designed to improve the suitability of tech solutions for local markets, to be launched in 2022.

State Aviation a granted permit to offer chopper services to Zanzibar

NON-scheduled charter services provider, State Aviation Limited has been granted permission by Zanzibar to offer helicopter services to passengers travelling to Dar es Salaam's Julius Nyerere International Airport, Unguja's Abeid Amani Karume International Airport and Pemba Airport.

Speaking to The Guardian last week, State Aviation's Chief Operating Officer, Amour Abdallah said the helicopter services will act as a catalyst in boosting Zanzibar's tourism potential. "We have commenced offering helicopter services in Zanzibar this month to high-end tourists who prefer to use charter services from the airport to their hotels. This does not only save their time but also gives them a unique aerial viewing experience," Abdallah said.

He explained that the helicopter services will also help in complementing the Isles government's blue economy initiative. "We have started operations with a single engine helicopter but we will be adding another twin engine helicopter to cater for high-end passengers especially tourists," he added.

The State Aviation's COO, hinted that the company will introduce a seven days unique insurance emergency and evacuation scheme dubbed 'Medevac' geared towards ensuring tourists' safety while in Zanzibar. Abdallah said the scheme that will only cost U\$15 (approximately 35,000/-) will cater for evacuations in case of emergency.

"We will be launching this scheme in State Aviation Limited's COO, Amour Abdallah



Zanzibar as a pilot but we expect to roll it out to Tanzania Mainland in the near future. This will ensure that tourists enjoy stress free travel," he stated while noting that in case of emergency, tourists with valid Medevac Schemes will be airlifted by the company's helicopters to hospitals.

State Aviation started operations in the country two years ago and has since been offering a wide range of chopper services mainly targeting the tourism, mining, oil and gas industries. CENSURE Kisutu court orders ex-NICOL chair to pay 50 million/- in compensation

A former NICOL chairman, Felix Mosha has, been ordered by Kisutu Resident Magistrate Court to pay the company 50m/- and return Toyota Land Cruiser with registration number T 133 AVG which he currently owns.

In a ruling given last week by Kisutu Resident Magistrate, Yusto Rubonga regarding civil case number 282 of 2017 filed by NICOL against Mosha and ousted CEO, Kathleen Armstrong, the court confirmed that the two defendants, were lawfully removed by shareholders from their respective positions during an extra ordinary meeting held in April 2012 due to poor performance.

Magistrate Rubonga further stated that the arguments by the defendants that they were restored by Justice Faudhi Twaibu in a ruling to civil case No 16 of 2011 was incorrect and misleading as the order clearly stated that the trial judge order could not have permanent effect. The ruling further stated that

the shareholders decision to appoint a new management was lawful as it was upheld by several decisions of the High Court and that the shareholders resolution dated 14th April 2012 has never been overturned by any court of

law to date.

"The court is therefore, ordering Mosha and Armstrong to immediately return the motor vehicle No. T 133 AVG to the NICOL, pay 14.4m/- in compensation for financial losses suffered by NICOL for hiring an alternative vehicle, pay 22m/- for financial losses suffered by NICOL for un authorized sale of its property namely, Mitsubishi Fuso, with registration No. T227 AXA and also pay 10m/- to NICOL in general damages and cost of the suit," the ruling said. In this case NICOL was represented by Advocate Benjamin Mwakagamba of BM Attorneys, while Mosha and Armstrong were represented by Advocate Dominic Daniel.

IEA warns world isn't investing enough for future energy needs

PARIS

THE world is failing to invest in energy on the scale needed to escape catastrophic climate change and avoid sharp increases in fossil fuel prices, the International Energy Agency warned.

In a report just weeks before a key climate change summit known as COP26, the agency said that investment in green energy like solar and wind is falling short of what's needed to keep the planet from warming up significantly. At the same time, spending on fossil fuels is lower than needed if current demand growth for oil, natural gas and coal continues. "There is a looming risk of more turbulence for global energy markets," Fatih Birol, the head of the agency, said in a statement Wednesday. "We are not investing enough to meet for future energy needs."

The stark warning comes as the global economy weathers the most crippling energy crunch in at least a decade, with rolling power blackouts hitting China and India. Even in Europe fertilizer producers and steel-makers have been forced to shut down due to record electricity and gas prices. And yet, global emissions are on track to post their second-largest annual increase in 2021, nearing an all-time high.

In the past, the agency – which advises some of the most industrialized countries including the U.S., Germany and Japan - has focused its warnings on the lack of spending in green energy. But in its flagship World Energy Outlook report it also underlined that current investment isn't enough if the planet continues to rely as heavily on fossil fuels at it does now.

"In recent years, investment in oil and gas supply has often appeared to be geared toward a world of stagnant or even falling demand, while purchases of internal combustion engine vehicles and expansion of natural gas infrastructure point the other way: toward ever-increasing oil and gas consumption."

The pandemic, which led to a near-record low in new oil and gas investment in 2020, has intensified the trend, the IEA said. "If demand remains at higher levels, this would result in tight supply in the years ahead, raising the risks of higher and more volatile prices.'


Over the last month, the cost of coal has surged to a record well above \$200 a ton, surpassing the 2008 peak during the last commodity boom, and natural gas has hit all-time highs in Europe and Asia. U.K. shortterm electricity prices surged at one point to more than 400 pounds (\$544) per megawatt hour, about 10 times normal levels. And crude has surged to a seven-year high above \$80 a barrel as demand for gasoline, diesel and other refined petroleum products surges.

The IEA appears to be trying to walk a fine line. In the past, it has

been criticised by green campaigners for missing the explosive growth in solar and wind power and the huge drop in green energy costs. Since then, the Paris-based body changed tack, focusing more on clean energy, and at times advocating for lower spending on fossil fuels.

That has worried some of the IEA's member countries, which fear fossil fuel supply may fall faster than demand, triggering price spikes that could undermine political support for climate policies.

Birol said that encouraging signs in clean energy were running up "against the stubborn incumbency of fossil fuels," adding: "Governments need to resolve this at COP26 by giving a clear and unmistakable signal that they are committed to rapidly scaling up the clean and resilient technologies of the future.'

Three scenarios

The COP26 meeting in Glasgow, Scotland, that starts at the end of October, has been called the last opportunity the world has to avert catastrophic climate change.

The IEA presented policy makers with three scenarios - rather than forecasts - of how the world's energy map may evolve over the next 30 years.

RELIEF **China breaks silence** on Evergrande, saying risks are 'controllable'

BEIJING

CHINA'S central bank broke its silence on the crisis at China Evergrande Group, saying risks to the financial system stemming from the developer's struggles are "controllable" and unlikely to spread.

Authorities and local governments are resolving the situation based on "market-oriented and rule-of-law principles," People's Bank of China official Zou Lan said at a news briefing on Friday. The central bank has asked lenders to keep credit

to the real estate sector "stable and orderly," said Zou, who is head of the financial market department.

Concerns are growing that the cash crunch at Evergrande is spilling over to other developers as President Xi Jinping maintains strict measures to cool the property market. Contagion fears intensified over the past two weeks after a surprise default by Fantasia Holdings Group Co. and a warning from Sinic Holdings Group Co. that its default was imminent.

"In recent years, the company failed to manage its business well and to operate prudently amid changing market conditions," Zou said of Evergrande, which has more than \$300 billion of liabilities. "Instead it blindly expanded and diversified."

The central bank is urging property firms and their shareholders to fulfill their debt obligations, Zou said. A slump in developers' offshore dollar bonds is a natural market response to defaults, he added.

Zou also said: China's government has insisted that property not be used as a short-term stimulus for the economy; Cities have seen an excessive surge in property prices, which mortgage restrictions helped to curtail; Property investment has slumped recently after some developers faced credit problems, but this is a normal market phenomenon; and Some banks have misunderstood macroprudential policies regarding the property sector.

Financial regulators have told some major banks to accelerate approval of mortgages in the last quarter, Bloomberg reported earlier Friday. Lenders were also permitted to apply to sell securities backed by residential mortgages to free up loan quotas, easing a ban imposed early this year, according to people familiar with the matter.

Regulators will ensure financial support is provided so that Evergrande's property projects may resume, Zou said. The developer's rapid expansion "led to severe worsening of its financial metrics, and risks blew up in the end," he said. In a rare public rebuke in August, the central bank told Evergrande to resolve its debt problems and refrain from spreading "untrue" information, after a meeting with the developer's executives.

feeling rather than truly serious data." FDA staff in documents posted on Tuesday said data for Moderna's vaccine showed that the booster does increase protective antibodies.

But they also said the difference in antibody levels before and after the shot was not wide enough by one measure of success specified by the FDA, particularly in those whose antibody levels had remained high.

Moderna is seeking authorization of a booster that contains 50 micrograms of vaccine, half of strength of its regular dose but still higher than the Pfizer/BioNTech shot using similar technology at 30 micrograms.

The booster would be administered to people at least six months after the initial two-shot inoculation.

In another development, President Joe Biden touted the success of mandates in spurring vaccination against COVID-19 in the United States on Thursday but said more needed to be done to

get the 66 million people who are eligible but still unvaccinated to get the shot. Vaccination rates against COVID-19

in the United States have risen by more than 20 percentage points after multiple institutions adopted vaccine requirements in recent months, while case numbers and deaths from the virus are down, Biden administration officials said on Wednesday.

Biden said in July federal workers needed to be vaccinated or get tested regularly. In September, he said federal workers needed to be vaccinated or face losing their jobs, and that employees at big companies needed to get jabs or be tested.

"The vaccine requirements that we started rolling out in the summer are working," Biden said, noting that the Labor Department's completed rule on vaccination requirements for businesses would be coming out shortly.

Meeting with Putin to be crucial for gas contract, says Serbian President

BELGRADE

THE meeting with Russian President Vladimir Putin will be crucial for the contract on gas supply to Serbia, Serbian Aleksandar President



Vucic said in an interview aired by the TV Prva channel. "By the end of 2021 we will be purchasing 6.5 mln cu-

bic meters of gas each day, now we already spend over 6.5 mln, for which we pay \$270, it is currently the best price in Europe, while in the winter we will spend 11.5 mln.

On October 10, following talks with Russian Foreign Minister Sergev Lavrov, the Serbian leader said that he addressed the Russian president with a request for an affordable gas price.

It was reported earlier that Serbia had been discussing with Russia freezing the gas price at the level of \$270 per 1,000 cubic meters for six months in 2022.

On October 7, at a meeting of the Russian-Serbian intergovernmental committee on trade, economic and scientific-technical cooperation, Russian Deputy Prime Minister Yuri Borisov stated that he hoped to conclude a long-term contract on gas deliveries from Russia to Serbia before the end of 2021. Amir of Qatar calls on the International Community to assume its responsibilities towards Afghanistan

The vote to back Moderna's booster was 19-0.

"The data itself is not strong, but it is certainly going in the direction that is supportable of this vote," said Dr. Patrick Moore of the University of Pittsburgh School of Medicine. Moore said he voted in favor of Moderna boosters based largely on a "gut

Murder of British lawmaker deemed terrorism with investigation underway

LONDON

THE murder of British lawmaker David Amess was declared a terrorist incident by London's metropolitan police on Saturday.

Britain's ruling Conservative Party's member of the parliament (MP) David Amess has died after being stabbed on Friday at a constituency meeting in Essex, a county in southeastern England.

As tributes continued to pour in for the 69-years-old lawmaker, a statement released early Saturday by the metropolitan's counterterrorism unit confirmed the crime as an act of terrorism.

Sudan's PM vows not to allow coup against revolution achievements

KHARTOUM

SUDANESE Prime Minister Abdalla Hamdok on Friday voiced the transitional government's commitment to not allow any coup against what has been achieved in the December Revolution.

Hamdok made the remarks in a speech broadcast by Sudan's official TV. The Sudanese army ousted former President Omar al-Bashir in April 2019 amid popular protests that erupted in December 2018

against deteriorating economic conditions and hike in prices of basic commodities. The army then established a transitional military council that had ruled the country until August 2019, when the military and the opposition Freedom and Change Alliance established a transitional government for a 39-month rule.

The transitional period is set to be followed by elections to form a new government. Hamdok described the current division between

the components of the transitional government as "the worst and most serious crisis threatening the transition." "If we cannot achieve the slogans of the revolution of freedom, peace and justice and reach the desired ends of the transition, we will not forgive ourselves and neither will history forgive us," he said.

However, Hamdok denied any dispute between the civilian and military components, saying "it is a dispute between the civil democratic transition

camp and the camp of coup against the revolution." "It is a conflict in which I am neither neutral nor a mediator.

Mv clear and strict position is the full bias for the civil democratic transition, completion of the tasks of the glorious December Revolution, and realization of its slogans of freedom, peace and justice," the prime minister noted.

He further proposed a road map out of the current crisis, calling for immediate cessa-

They expressed such views at online side events at the 48th session of the United Nations Human Rights Council (UNHRC), which were held by social organizations and human rights research institutes including China Society for Human Rights Studies and China NGO Network for International Exchanges

(CNIE).

The country won wide recognition at multiple side events for its achievements in protecting the rights of ethnic minority groups as well as other aspects of its human rights progress.

Through institutional and policy guarantees, China ensures that ethnic minority citizens enjoy rights to equality and freedom and to economic, social and cultural services. China helps all ethnic minority areas accelerate their economic and cultural development, according to attendees at these side events.

China's efforts and achievements in promoting overall, comprehensive, proactive, and substantial protection of the rights of people of all ethnic groups in its

Tibet autonomous region over the past 70 years since the peaceful liberation of the region have fully demonstrated socialist system's advantage and characteristic of protecting the rights of ethnic minority groups, said Yang Zongke, president of Northwest University of Political Science and Law in China.

China's experience in protecting human rights in Tibet has offered the world good examples of human rights protection, Yang said.

China's success in reducing poverty in Tibet has further guaranteed a fair and just environment for human rights development, strengthened the capabilities of impoverished population in Tibet to take part in social and economic

development and share the fruits of development, and better safeguarded the rights of residents in the region to subsistence and development, representing a historic achievement in human rights in Tibet, said Kelsang Drolma, a researcher on Tibetan economy and society with the China Tibetology Research Center. By showing the realities of the sound

economic and social development in northwest China's Xinjiang Uygur autonomous region, participants in these side events have debunked the false allegations against the region made by a handful of Western countries who have attempted to smear China.

Carlos Martinez, an independent researcher and political activist from the UK, said that he hasn't seen any phenomenon of the so-called "cultural extinction" or "religious persecution" in Xinjiang during his visits to the region in recent years. The accusation of human rights violations in Xinjiang made by certain Western countries is entirely groundless, according to him.

Muhammad Zamir Assadi, a journalist with Independent News Pakistan, said he has visited Xinjiang and had a wonderful time there. During his stay in the region, he could truly feel that the Chinese government respects the traditional culture and folk customs of the ethnic minority groups in Xinjiang very much and fully guarantees local Muslims' freedom of religious belief, ac-

cording to Assadi.

Last month, China's State Council Information Office released the "Human Rights Action Plan of China (2021-2025)," the country's fourth human rights action plan. It attracted wide attention and became a hot topic at online side events.

China's fourth human rights action plan is in line with the country's social and cultural environment and shows the country's attention to safeguarding the rights of special groups and commitment to solving problems including poverty, said Sitsangkhom Sisaketh, Lao deputy permanent representative to the United Nations Office at Geneva (UNOG).

Russian Defence Ministry summons US military attache over Sea of Japan destroyer incident

THE Russian Defense Ministry has summoned the US military attache and pointed out the unprofessional actions of the crew of the US Navy's destroyer Chafee that attempted to cross the Russian border in the Sea of Japan, the military agency told journalists on Friday.

"The position of the Russian military agency was conveyed to the representative of the US armed forces in relation to the US Navy's destroyer Chafee's attempted violation of the state border of the Russian Federation in the area of the Peter the Great Bay on October 15," the statement said.

As the Defense Ministry emphasized, the unprofessional actions of

the American crew were pointed out to the military attache since they grossly violated the international regulations for preventing collisions at sea and the provisions of the Russia-US agreement on preventing incidents at sea and in airspace.

The US military attache was summoned to the Main Directorate for International Military Cooperation of Russia's Defense Ministry in the evening of October 15.

On October 15, about 17:00 local time, the US Navy's destroyer Chafee approached the territorial waters of the Russian Federation and attempted to cross the state border. The Pacific Fleet's large anti-submarine warfare ship Admiral Tributs prevented the destroyer from violating the state border. Agencies

THE U.S. administration is in the hot seat, as prices for food and multiple consumer items are rising at a rapid clip and a massive supply-chain breakdown has exploded nationwide.

Food prices overall climbed 4.6 percent since September last year, according to information published on Wednesday by the U.S. Bureau of Labor Statistics (BLS). The Consumer Price Index, a measure of changes in prices for goods and services, grew 5.4 percent from a year ago.

PRICE HIKES OF DAILY GOODS

The prices of meat, eggs, fish and poultry saw a 10.5 percent increase over the past year, with beef alone skyrocketing 17 percent, according to the BLS.


All this has pushed annual inflation to the highest levels in the past 13 years. Jerome Powell, chairman of the U.S. Federal Reserve, has attributed the recent price increases to supply chain bottlenecks caused by the pandemic. With less supply, prices go up.

The U.S. administration is pushing to fix the problem by Christmas, in a bid to ease supply chain constraints by the holiday shopping season. But that could prove to be an uphill climb, some U.S. media outlets argued.

U.S. President Joe Biden on Wednesday met with a number of industry leaders and heads of ports and unions in an effort to tackle problems within the supply chain, from shipping, warehousing to labor.

It was later announced that the port of Los Angeles would ramp up operations with a new, 24-hour, 7-day-per-week schedule. "This is an across-the-board commitment to going to 24/7," Biden said Efforts to ramp up operations at the port, as well as vows from some major retailers to work around the clock to move more goods, are a big first step, said the president.

"We need the rest of the private sector chain to step up as well." But some economists said these efforts may not

INFLATION Desmond Lachman, resident fellow at the American Enterprise Institute, told Xinhua that the current rise in U.S. inflation is the result of two basic causes. The first cause is from demand-pull factors. Those have resulted from excessively expansive monetary and fiscal policies, which increased aggregate demand, and from global supply chain problems, especially in the area of computer chips important to the automobile and appliance sector, restricting aggregate supply, Lachman said. That has caused demand to exceed supply in the goods sector, which in turn has driven up prices, he added.

The second cause is from cost-push factors, including the big increases in international energy, metal, and food prices as well as the rise in world shipping costs.

Those factors are pushing up costs that then get passed onto consumers in the form of price increases, said the expert.

This combination of demand-pull and cost-push factors, together with the very rapid rate of increase in U.S. house prices and rents, makes it "very likely" that inflation will prove to be "much longer lasting and more intractable than the Federal Reserve would have us believe," Lachman noted.

US sanctions on Iran not conducive to alleviating global energy crisis

TEHRAN

AS the world, particularly the West, is facing a grave energy crisis caused by growing demand for fossil fuels, the U.S. sanctions on Iran have hindered an alleviation of the crisis.

ENERGY CRISIS

With major economies slowly recovering from the COVID-19 pandemic, the previous harsh winter having depleted Europe's gas reserves and cold days ahead, global demand for energy has shot up and commodity prices are

consequently going up. In European states, gas prices are at record levels, leading to significant increases in the price of other goods and services.

Britain is one of the hardest-hit European countries due to the dwindling North Sea supplies and its limited gas storage. Among others, Spain and France are also suffering from the crisis, seeing surges in electricity prices and other commodity prices.

Meanwhile, gas prices are soaring in the United States amid a sudden increase in

the price of oil, USA Today has reported. A real solution to the energy crisis is still not in sight. Although Russia has promised to increase exports, the remaining major fossil fuel suppliers currently seem either unable or unwilling to make a significant contribution to the alleviation of the crisis.

The global energy market needs new blood, analysts have said.

IRAN AS A RELIABLE SUPPLIER

Iran has abundant hydro-

carbon resources. It held 32 trillion cubic meters of proven gas reserves as of 2019, ranking second in the world and accounting for about 16 percent of the total global natural gas reserves, according to the BP Statistical Review of World Energy 2020.

In addition, the report said the country held 156 billion barrels of proven oil reserves as of 2019, ranking fourth in the world and accounting for about 9 percent of the entire global oil reserves.

The country, located along International Norththe

South Transport Corridor and having access to the high seas, Europe through Turkey and Central Asia, can also be a source of rather cheap energy owing to its geographical position, said observers.

Prior to Washington's withdrawal in 2018 from the Joint Comprehensive Plan of Action and the reimposition of the unilateral sanctions mainly targeting the oil and gas sector, Iran used to pump about 2.8 million barrels per day of crude oil into the global market.

Iran is also exporting gas to

some neighboring countries, including Turkey and Iraq, and can be a reliable supplier to Europe as well as the rest of the world in the long run. Iranian energy expert Morteza Behrouzi told state-

run news outlet ISNA that Iran can increase its oil exports by 1.5 million barrels per day in less than six months if the sanctions are lifted, which can create a winwin situation.

WHAT'S THE OBSTACLE? The U.S. sanctions on Iran

have, however, deprived the

world of the boon as they have denied the Islamic Republic access to billions of dollars in annual revenues, thus creating a zero-sum game.

Earlier, Iranian Oil Minister Javad Owji has said that the United States and some European countries have hindered Iran from exporting oil for many years, and Iran is not the only one paying the price. This unilateral policy also has a negative impact on the American and European people.

Their players have mostly ended up making the most of the South Africa Premier League.

East Africa national outfits' journey to World Cup is still long. Apart from the players, even the domestic leagues do not have what it takes to secure competent representatives for top competitions.

So far our neighbours have begun to feel more comfortable playing in Tanzania than elsewhere in the region.

I believe that even Benin would be a threat to this region's national squads.

It is obvious we cannot compare them to other West African nations like Ivory Coast, Cameroon, or Nigeria but it is clear that if they were in our region it is no wonder they would be a force to reckon with

After three straight losses in months, Abdallah Pazi ripe for new pastures

TANZANIA boxing icon, Abdallah Pazi, popularly known as 'Dullah Mbabe', has suffered three straight losses in slightly over five months, such that he announced he was going to rest for a while and then make up his mind what next in his career.

Scores of issues come up in that regard, the first of which is self-esteem and belief that he can still do what he was doing before, which also has to do with what those around him will demonstrate in his regard, either trust or scorn, and the latter is somewhat more forthcoming of late.

If only because of that atmosphere, the fighter should possibly choose new ventures, due to his style.

Psychologically speaking, a quiet and unassuming fighter can lose one or two bouts, perhaps even three, take the back seat for a while and reassess his thrust of energy at the physical level to make a decision.

He also has psychological problems to handle but ordinarily, they are more manageable when one is unassuming, modest, and easygoing, not when one is bombastic, flamboyant, and visceral to his opponents, like Mike Tyson or Muhammad Ali. Dullah falls into this scheme of things, as an extrovert.

What this indicates is that he will find it harder to come back to the right than if he was quiet and unassuming, in like manner as one of his latest opponents, Twaha Kassim or 'Kiduku', whose name may suggest he knows how to 'duck' a blow.

'Mbabe' is a different kind of tag, as an all-conquering sort of boxer, whose time on the ring is required to be short- by winning in the first or middle rounds, not more.

At the same time, his overall ring time is short by comparison, as the mode of fighting by jab explosion is also a pattern of career, that when he can no longer do that he leaves the ring to other fighters, simply so.

The trouble with jab explosion boxers with an aura of invincibility around them is that they often live the way they fight, as flamboyant extroverts surrounded by a bevy of admirers.

When things turn badly around they

have a lot of refurbishing to do, remaking their training camp or sliding into oblivion and avoiding plenty of people, as the sort of aura they are used to evoke no longer works, after three straight defeats, the last by Technical Knockout.

For those not adept with professional boxing practices, there is a feeling that the boxer may have piled too many fights in a short period, which has two likely explanations, a technical aspect, and a routine or

Such a rule would also be an extension of regional or continental rules on such requirements, seeking out an opponent or accepting one in the pursuit or defense of a title, as it may be.

As these fights - and losses - have occurred within the May-October period, following a win earlier in February, it is unclear how far there was compulsion locally or regionally, not to say internationally.

But as the cohort of boxers that Dullah faced came from near and far, it would imply that the sequence is ordinary, as three fighters he met out of four were foreign, where he lost the first match with one of them and then lost two others, and another local fight in between two fights with foreigners.

So the fights were blended into the same flow of action rather than the boxer being pushed to fight amid a period of rest, etc.

Declaring that he is taking a rest for a while implies that he is not on the lookout for opponents at present, and implicitly foreign boxers looking for titles in the same weight or cohort of weights shall be advised to look for other opponents.

There may also be rules if a boxer who loses three fights consecutively can gun for a career fight in the sense of chasing titles, what sort of boxer he can pick out and ask for a fight, as the same demand becomes a career option, or requirement, on the part of the opponent.

It implies that the boxer comes out more or less as a novice trying to prove his worth in the ring, totally unlike himself.

Those above us in FIFA rankings, DR Congo and Benin, Tanzania's opponents in qualifiers for World Cup, are not as competent as West African nations' squads.

If any of the two books a place in the next round, they will easily crash out, losing to such squads, Senegal, Ivory Coast, Egypt, Tunisia, Nigeria, and others. This is the bitter truth about our group.

There is a lot of work to be done in this region to be able to go to the World Cup.

There is also a lot of work to be done to win the African Nations Championship and continental competitions at the club level.

If a soccer lover looks closely, the people of West Africa and those of North Africa have shared in the success.

Those in North Africa excel in clubs while those in West Africa excel in national teams.

It is not surprising to see Enyimba become the last team from West Africa to win the CAF Champions League. It is almost 20 years now since they did so in 2003.

IOC: FIFA's World Cup plan will hurt Olympics

LONDON

THE International Olympic Committee said on Saturday that it has "concerns" about FIFA's push for soccer World Cups every two years.

Though IOC President Thomas Bach said last month that "we will not interfere in this discussion," his organization stepped in on Saturday after meeting in Athens to detail objections it shared with soccer stakeholders.

Clashes in the schedule with other sports, the men's World Cup overshadowing women's editions of the tournament, and "a further massive strain" on athlete welfare were all cited in an IOC statement after an executive board meeting.

The IOC did not refer to potential future World Cup-Olympics clashes -- potentially as soon as 2028 when the Summer Games are hosted by Los Angeles -- in its statement.

The IOC did criticize FIFA's tactics in promoting the biennial World Cup project by noting a wider consultation across soccer "has obviously not taken place."

FIFA revealed its detailed plan last month, after meeting with retired players, to redraft the calendar of international soccer competitions with biennial World Cups for men and women at the heart. The proposal strongly backed

by FIFA president Gianni Infanti-

no was announced before formally consulting member federations in the World Cup strongholds of Europe and South America. Those regions' governing bodies, UEFA and CONMEBOL, have warned of a World Cup boycott if FIFA pushes ahead with a plan that would undermine their continental championships, which are organized on the same four-year cycle as the IOC's Summer Games. All are next

due in 2024. The IOC cited "tennis, cycling, golf, gymnastics, swimming, athletics, Formula One and many others" as sports which would be affected by more World Cups.

"This would undermine the diversity and development of sports other than football," the Olympic body said.

FIFA, whose next scheduled World Cups are in 2022 and 2026, has not specified wanting to stay on even-numbered years for a biennial men's World Cup. A switch to odd-numbered years, possibly starting in 2029, could be proposed. At an Olympic briefing after an executive board meeting. spokesperson Mark Adams was asked whether Infantino, who is an IOC member, had talked with Bach about the biennial World Cup plan before going public with it.

Adams said he could not give details though the IOC kept in touch with sports governing bodies. (Agencies)

Solskjaer under pressure again as Man United slump to heavy loss at Leicester

LEICESTER, England

IT was a day to remember for Mason Greenwood and Marcus Rashford at the King Power Stadium, and one to forget for Harry Maguire and Ole Gunnar Solskjaer. It sums up where Manchester United are at the moment: bits of good and lots of bad culminated in a 4-2 defeat to Leicester City, and the pressure is mounting on the Norwegian.

This was a Leicester side that had not won in the Premier League since August, yet United found a way to lose, and most of it was their own doing

Greenwood scored with a stunning strike and Rashford marked his comeback from injury with a goal, but when your defence -- which inUnited's attacking quality, as well as the fact they have any one of about six or seven players in their squad

capable of moments like these. So why have they been struggling? The answer came 10 minutes later. Leicester didn't look as if they needed any help breaching a United defence that had not kept a clean sheet since August, but United obliged anvway.

From their own free-kick, Paul Pogba passed to Victor Lindelof, who passed to De Gea. He rolled the ball out to Maguire, who decided to wait long enough to let Kelechi Iheanacho nip in and steal possession; five seconds later, the ball was in the net thanks to an outrageous finish from Youri Tielemans. A great goal, yes, but from Solskjaer's point of view, it was avoidable -- something it had in common with most of the goals they've conceded this season. United have had just one clean sheet in the past 19 games, and afterwards, Solskjaer was forced to defend his decision to bring back Maguire after just one training session on Friday morning following three weeks out with a calf injury. Maguire's first touch of the game was a heavy one that bounced into the advertising boards, and his day never improved. "It was my decision to play Harry," Solskjaer said. "He has worked really hard on the rehab, and he looked ready and looked sharp. He's a big, massive player for us. He's the captain, and we want to bring him back as soon as we can. I'm not pointing fingers at any player, but we have to do better."

Vieira can underline Arsenal's decline when he brings Palace to the Emirates

OF all the subplots contained within Patrick Vieira's return to Arsenal on Monday, perhaps the most curious is this: The man trying to beat the Gunners is also a man trying to buy them.

The 45-year-old occupies a curious position given that he's now the manager of a Crystal Palace side attempting to win a Premier League game at Emirates Stadium for only the second time in 20 visits, while also remaining part of a consortium that had a £1.8 billion takeover bid rejected earlier this year. Spotify owner Daniel Ek was the front man, but within his inner circle were three club legends -- Vieira, Thierry Henry and Dennis Bergkamp -- all of whom hail from an era Arsenal have struggled to recapture ever since the trio's playing careers ended in the mid-to late-2000s.

The fact that only three places and three points separate the Gunners from a Palace team for whom a top-half finish is typically the limit of their aspirations serves as another reminder of the decline Mikel Arteta is charged with reversing.

Vieira's involvement with Palace and Ek puts him firmly in Arsenal's past, present and future: a symbol of former greatness, an immediate challenge to overcome and a possible component part of a new era.

Kroenke Sports & Entertainment have continually dismissed any suggestion they would sell to Ek, but the presence of three players from the "Invincibles" era gives the bid an obvious appeal to supporters.

It has never been made entirely clear what role they would all assume, but Henry was pictured sat next to Ek at last month's north London derby win over Tottenham Hotspur, suggesting it's more than an exercise in clever public relations. Henry's subsequent message that "we are here to stay" means KSE may soon have another bid to consider, and any change in stance would in fact complicate things for Vieira given his role at Palace.

A source at the Premier League has indicated that he would fail the Owners' and Directors' test if he were to try to become an Arsenal director under rule F.1.4, specifically on the grounds that "either directly or indirectly he/ she is involved in or has any power to determine or influence the manage-

if he had any sort of management of administrative power. Vieira would be in breach of Rule I.2 and Palace would fall foul of I.1, both of which relate to individuals or clubs having influence at more than one team.

It remains possible Vieira could hold a more informal role, with the source suggesting an unpaid ambassadorial position could at least be submitted for consideration, but the man himself has never specified precisely what position he would assume.

"I was just expressing myself as Patrick, ex-Arsenal football player," Vieira said when asked about his support for Ek's takeover plans. "That comment was based on how the direction [of the club] was going. I was talking to somebody who had a different view and a different way of taking [forward] Arsenal Football Club.

"I am in a different position than a couple of months ago, so I'm not going to express myself in the same way than when I was just an ex-Arsenal football player."

There was a time when it appeared Vieira would become Arsenal manager. Toward the troubled end of Arsene Wenger's reign, Vieira was embarking on a positive start to life in the dugout with MLS side New York City FC. In 2016, he secured New York City's first ever playoff appearance and followed that up with a second-place finish in the combined MLS standings behind Toronto FC.

By the time Wenger was nudged through the exit door in 2018, Vieira was under serious consideration to replace him -- as was Arteta, then an assistant at Manchester City - before Arsenal settled on Unai Emery. Vieira

afar and choosing to partner up with Ek as the opposition among supporters toward KSE grew to unprecedented levels. The sight of Arteta and Vieira in opposing dugouts at Emirates Stadium qualifies as another facet of the legacy Wenger's tenure left behind.

Arteta was one of a plethora of signings charged with the responsibility of reestablishing the midfield authority that departed with Vieira when he joined Juventus in 2005. The titanic struggles between Vieira and Roy Keane personified the battle for supremacy between Arsenal and Manchester United either side of the Millennium that defined English football for a decade.

It is hard to overstate Vieira's influence. Arsenal supporters voted him the fifth "Greatest Gunner" of all time in a 2008 poll (behind Henry, Bergkamp, Tony Adams and Ian Wright), but Wenger was clear in determining which signing would provide the catalyst for his success in north London. Occupying relative obscurity as a 20-year-old languishing in AC Milan's reserves, Vieira joined Arsenal for £3.5 million in August 1996, two months before Wenger took charge, but he did so -and turning down Ajax Amsterdam in the process -- in the knowledge his fellow Frenchman would be in the dugout.

"Right from his very first match [as a substitute against Sheffield Wednesday in September that year], when he was as yet unknown to the English public, he showed just how talented he was," wrote Wenger in his autobiography, "My Life in Red and White," released last year. "No the club that I needed in order to take it in the direction I wanted."

During Wenger's almost-22-year reign, no player made more appearances for him than Vieira's 401 (Theo Walcott was next on 397). Three Premier League titles and four FA Cups followed, the last of which was secured with his final kick for the club - a decisive penalty in a fortuitous shootout win over United.

Wenger talked Vieira into staying that season rather than push for a move to Real Madrid, but he joined Juventus for £12m in 2005, chiefly because he was only offered a two-year deal aged 29 at Arsenal as opposed to the five-year contract on the table in Italy. Vieira later claimed he opted to leave because then-vice-chairman David Dein told him "we are neutral" over whether he stayed, having accepted Juventus' offer -- a stance that left him "angry, surprised and upset."

Yet the Gunners' approach was indicative of the shifting financial landscape resulting from their selffunded move to Emirates Stadium from Highbury. Vieira's exit was followed by Robert Pires to Villarreal a year later and Henry to Barcelona 12 months after that. The club went from 2006 Champions League finalists to no European football at all in 2021 as Wenger gradually lost the battle to keep Arsenal competitive, not least due to a mixed record in the transfer market when more money became available again as the stadium debt eased. Vieira is a symbol of a bygone era, simultaneously a reminder of what was and what still could be.

"I had a chance to play for this club for nine years -- I arrived when I was a kid and left as a man," said Vieira on Friday. "This is the club where I played my best football so obviously going back will be emotional, but I will put that on the side because what is important for us is to perform well and try to get the points."

Arsenal believe they already have a former midfielder steering them back to the top in Arteta, who was questioned during the international break by Henry.

"I don't know if things are going in the right direction," Henry said, a comment that is impossible to entirely remove from the context of his involvement in a possible takeover. Vieira has

cluded a very rusty Maguire -- seems determined to concede at every opportunity, it doesn't really matter what happens at the other end. The defeat -- United's first away from home in the league since January 2020 -- would have been even heavier had it not been for David De Gea.

Depending on how you like your stats packaged, it's now four defeats in the past seven games, or one win in five. "We didn't deserve the points today. We gifted them the first goal. All the goals were disappointing, the way we conceded them. We were too easy to play through. It was the team as a whole. We need to be more compact and more aggressive. We didn't defend well enough.

"We've been really good at showing our character when we've needed it. The attitude has always been good. We need to stick together and work hard. We need to perform better.'

United needed only the first 45 minutes to demonstrate the best and worst of their season so far: individual brilliance followed quickly by collective incompetence.

Solskjaer's team had not started well when Greenwood picked up the ball on the right after 19 minutes. Without much going on in front of him, the 20-year-old burrowed forward and smashed a stunning leftfoot rocket in off the far post. It was a moment to remind everyone of

It got even worse for Solskjaer during a chaotic final 15 minutes. Caglar Soyuncu put Leicester ahead from a corner, but Rashford, on as a secondhalf substitute, looked to have got Solskjaer out of trouble with an emphatic finish from Lindelof's wonderful 40-yard pass.

With eight minutes still to play, it should have been United's turn to put their foot down, but instead, just 54 seconds after the restart, Jamie Vardy put Leicester back in front. Patson Daka's fourth in stoppage time only compounded Solskjaer's misery as the United boss stood motionless, arms folded, on the touchline.

He couldn't have had many complaints if Leicester had scored six; they perhaps would have done had De Gea not tipped Tielemans' shot onto the post and Ricardo Pereira not missed a good chance.

Brendan Rodgers and Kasper Schmeichel had both fulfilled their postmatch media duties by the time Solskjaer emerged from the dressing room 45 minutes after the final whistle. **ESPN**

TIME will tell whether this was the sort of fortuitous win carved out by Premier League champions or a result to mask their shortcomings, but Chelsea's defensive record continues to be the foundation of Thomas Tuchel's success. Brentford defied their newly-promoted status to dominate the second half of Saturday's encounter and were desperately unlucky to lose 1-0 on a night when they registered seven shots on target and shook the European champions in a manner rarely witnessed under Tuchel.

While other players on the team let Chelsea down -- chiefly another off night for Timo Werner and Romelu Lukaku -- goalkeeper Edouard Mendy proved the match-winner with a series of fine saves amid the bedlam Brentford created through a chaotic finale.

Goalscorer Ben Chilwell summed it up best. "It was pretty much hell on earth for the last 20 minutes," he told Sky Sports. "We have got Edou to thank, he's amazing."

Chelsea's defensive problems on the eve of this game were welltelegraphed given Antonio Rudiger returned injured from international duty with Germany and Thiago Silva was unable to take part after playing 90 minutes for Brazil on Thursday night.

Tuchel's solution was to hand Malang Sarr his first Premier League start alongside Andreas Christensen and Trevoh Chalobah, with Chilwell and Cesar Azpilicueta operating as wing-backs and Ruben Loftus-Cheek assuming the Jorginho role at the base of Chelsea's midfield. What followed was perhaps a predictably disjointed display from a makeshift side, includ-

ing a curious first half in which they struggled to make efficient use of the ball while both Werner and Lukaku wasted presentable opportunities to tilt the game in their favour. It required Chilwell to fire home

his third goal in three matches for Chelsea and England, continuing his personal renaissance, to give the Blues something to hold on to. And hold on they did, requiring all of Mendy's poise in a second period during which Brentford threatened to overwhelm the visitors on several occasions.

Bryan Mbeumo hit the post in both halves, the second time after 75 minutes after which Mendy's goal resembled the Alamo. Substitute Saman Ghoddos had a shot saved before Chalobah cleared off the line from Christian Norgaard. Norgaard then had a brilliant overhead kick tipped over as Mendy continued to repel everything thrown at him, securing Tuchel's 25th clean sheet since taking over from Frank Lampard in

That figure is higher than any other team in Europe's top five leagues during the same period and remains the basis upon which Chelsea will build their title credentials. "It is more important that he performs like this than being on

any list," Tuchel said. "I hope it does not bother him because it does not bother me too much and it seems like he is not influenced by that, which is a good thing.

"They put a lot of free-kicks, corners and throw-ins into your box, so it was a constant threat. In the last 20 minutes, the match turned into a cup game: they took a lot of risks and we could not keep them away from shooting and having the big chances. Edou was absolutely decisive to escape with a clean sheet."

Chilwell's goal marked a third strike in three games for Chelsea and England, another step forward in his revival after a difficult summer in which he was an unused member of Gareth Southgate's England squad at Euro 2020. Tuchel admitted that period had left Chilwell "mentally tired," but he has seized his opportunity for club and country in the last fortnight.

"I was very honest with you guys, I felt him a little bit tired, mentally a bit drained and it needs time," Tuchel said. "He got his chance against Southampton [prior to the international break]. He was able to score and play for England [against Andorra] which gave him more confidence and today he was strong again, in good shape.' **ESPN**

START THE WEEK WITH CYNTHIA STACEY Mwalimu still praised by the people!

AMBO for the week.....in a month which has seen many things "Nyerereian" discussed, revered, honoured, and of arse......criticised, in equal measure because today is Mwalimu's Remembrance Day.

I coined the word 'Nyerereism' to see how it looked in print, and when used to describe his ideology and place in Tanzania's history.

Somehow though, the description doesn't quite work when applied to his predecessors as in "Mwinyism""Mkapaism'...or "Kikweteism", but they didn't have an ideology like "Ujamaa" or African socialism to define their term of office.

In Britain, the period spanning the very lengthy reign of Queen Victoria is defined by the term "Victorian'. Similarly, the later reign of King Edward is referred to as the Edwardian era, and that of a much earlier monarch Queen Elizabeth the 1st', as "Elizabethan".

But as a descriptive methodology this can be inconsistent. For example, we talk of "Stalinism" after brutal dictator Joseph Stalin, yet not of "Hitlerism". While Mrs. Thatchers's draconian policies are instantly recalled in the term "Thatcherism"..... or of being a "Thatcherite".

But let's get back to Julius Kambarage Nyerere and as I've already written, the mention of which can usually give rise to criticisim or praise in equal measure. But in the western press at the time of his death, amidst the eulogising and plaudits he received, there were often even as a prelude to praise, statements likethe former president of Tanzania, whose country was ravaged by socialism..."

Yet many foreigners here at that time like me, never felt that they were residing in a 'ravaged country', a poor one yes with a fragile economy, but that seemed understandable given the impact of the hugely expensive war with Uganda.

But with such issues aside, I still recall thinking that perhaps the value system was superior to the one I left in Britain, and felt there was a lot to learn from the African culture.

Also, there were some countries that had gone from command economies to market ones, with often disastrous results for the populace,

freedom.They might have got the free term 'ravaged by capitalism.' speech, but soon learned that it

would confer on them wealth and wielded power. Oddly though, whenever but a local news reporter here defensively By the time Mwalimu died in 1999, many

the 'conversion' failed, we didn't hear the wrote "When dozens were killed in the Uk's worst rail disaster, citizens vented their anger on the newly privatised rail network as standards, and questioned why it was privatised at all".

The writer also pointed out that problems facing the railways in Tanzania have been blamed on the nation's socialist past doctrine, but added that "as the UK accident showed, such tragedies occur regardless of politicial ideologies."

Following Nyerere's death, a German newspaper reporter wrote that during his term of office, the country made no economic progress until Mkapa picked up the reins, but how do we effectively evaluate progress?

Survival for Tribal People, a body that champions the rights of indigenous groups, some years ago criticised the Canadian government for the treatment of the native Inuit, or Eskimos. The organsiation said that these people had been adversely affected by aggressive development projects, and their cultural heritage was being eroded.

No doubt though, in a high rise expensive office somewhere, this will have been recorded as "advancement".

I've commented on this before, but I'm reminded also of the story of a social scientist visiting a 'backward' tribe and reporting of the people's miserable existent in hovels, ecking out a subsistence living.

However, it was later discovered that they were a very contented group, well nourished, perfectly sustained, and with a fantastic level of communal and social cohesion long since missing in the western world. Nor did they know that they were miserable and living in poverty untill they were told so. ...but it's the western reference point which sets the standard for contentment.....and certainly these people didn't have television, washing machines, or mobile phones!

Anyway, let's quote our scribe again, who when some of the privatised public enterprizes in Tanzania were currently being re-possesed, he wrote......"to understand the nation's economic performance, we must go beyond orthodox indicators like GDP growth, as many think tanks agree that this isn't an end in itself, but rather how it translates into human development, so we should judge Nyerere's economic policies in that light".



More coups likely in Africa unless AU addresses 'unconstitutional preservation of power' instances

OUPS used to be the method of choice in Africa for changing governments, with over 90 occurring between 1951 and mid-2020. During those years, only 30 incumbent leaders were peacefully removed from power by their political opponents in elections.

And in that time, just 28 heads of state voluntarily left office after serving their legally allowed number of terms as president, says Issaka Souaré, Director of the Sahel and West Africa Programme at the Stockholm International Peace Research Institute.

In 2000, the propensity for staging coups - there had been 15 in the previous decade - worried the Organisation of African Unity (OAU) enough to adopt the Lomé Declaration. In a radical departure from the OAU's firm policy of turning a blind eye to member states' 'internal affairs', it decreed that any member taking power through an "unconstitutional change of government" would be suspended. In practice, this referred to military coups.

After replacing the OAU, the African Union (AU) has exercised that power of suspension 14 times since 2003. After the Lomé Declaration, the incidence of coups steadily declined from 15 in the previous decade (1991 to 2000) to eight in the decade after, and

five between 2011 and 2020. The extent to which the declaration played a role in this reduction is unclear, considering that the trend suddenly seemed to reverse last year. In fewer than 13 months from 18 August 2020, four coups have occurred. Two happened in Mali (August 2020 and May 2021), one in Chad (May 2021) and one in Guinea last month. This prompted the Institute for Security Studies (ISS) to tackle the question: Are coups back

week. Answering it would require a crystal ball, but the discussion suggested that although the long-term trend was positive, coups could be here to stay. What might help prevent that would be better responses from the AU, regional bodies and international partners to coups and other forms of unconstitutional change of governments. And most importantly to what Souaré and other participants labelled "UPP" – the unconstitutional

preservation of power. The first step in tightening up the Lomé Declaration and matching instruments in the regional economic communities (RECs) – is to apply the measures consistently across different countries, said ISS Senior Research Consultant David Zounmenou.

He cited the sharp difference in approach towards Mali and Chad. The former was suspended from the AU

and the Economic Communitv of West African States (Ecowas) after the 2020 and 2021 coups. In contrast, Chad was allowed to remain in the AU pending a transition to elections and civilian rule.

The AU and Ecowas lifted their suspension of Mali a few weeks after August 2020 when the heads of a new civilian transitional administration - vetted by coup leader Assimi Goïta - were announced. Goïta's toppling of those same civilian leaders in May this year suggested the AU and Ecowas had misjudged Goïta's commitment to truly civilian rule. As Zounmenou said, if military leaders see they can seize power with impunity, there's likely to be a proliferation of coups. All the ISS seminar participants agreed that the real focus of the AU, RECs and other external actors should be on addressing the causes of coups, which include the "unconstitutional preservation of

power". Kwesi Aning, Director of Academic Affairs and Research at the Kofi Annan International Peacekeeping Training Centre in Accra, suggested that optimism around the declining rate of coups this century needed to be treated with caution. He said forecasts should account for a "teeming democratic sea ... of frustrated, uneducated, barely educated, unemployed and increasingly unemployable youths ... who see the possi-

bilities of their participation in the domestic governing of their countries truncated by people who want to stay in power."

chanted were clear when they lined the streets of Conakry in Guinea to applaud Colonel Mamady Doumbouya after he toppled Alpha Condé last month. Similar scenes of popular jubilation greeted Mali's Colonel Goïta in Bamako last year after he ousted Ibrahim Boubacar Keïta.

Aning and the others agreed that the AU, RECs and others could help discourage coups by targeting incumbents who cling to power beyond their terms. Condé was a prime example of the consequences of the "unconstitutional preservation of power". He forced through an unwelcome constitutional change in 2019 to rescind the two-presidential term limit, at the cost of many protesters' lives.

Doumbouya cited this as one of the main reasons for the coup. As Souaré observed, we have no way of knowing if that was Doumbouya's true motive but the possibility

should be removed, not only for its own sake but as a plausible pretext for coups.

Andrews Atta-Asamoah, Head of the ISS's African Peace and Security Governance programme, noted that the Lomé Declaration went further than military coups and other violent power seizures as a trigger for suspension from the AU. An unconstitutional change of government could also include "the refusal by an incumbent government to relinquish power to the winning party after free, fair and regular elections."

And he noted that the AU's 2009 Ezulwini Framework for enhancing implementation of the Lomé Declaration's measures against unconstitutional changes of government had gone further still. It stipulated that "the constitution shall not be manipulated in order to hold onto power against the will of the people" and granted the African Court of Justice and Human Rights the jurisdiction to prosecute coup makers.

Atta-Asamoah felt the AU should be commended as a 'norm entrepreneur' for establishing the principle that coups were bad. Nonetheless, the frameworks for preventing unconstitutional changes of government were not really working because they were reactive, not preventive, he said.

So instead of addressing the grievances that sparked the coup, the AU and RECs' post facto interventions often pitted them "against the overwhelming will of the people in the street", especially when the AU and RECs insisted on restoring the old regime.

Perhaps the root causes of coups run too deep within a country for any external actor to influence much. But to the extent that they can, the AU and RECs should use their power preventively, focusing more on sanctioning "unconstitutional preservation of power" and other undemocratic behaviour to try to preempt coups. DM
