Mwinyi dies at 98

To be buried in Zanzibar tomorrow

FORMER President Ali Hassan Mwinyi (98) died yesterday at a Dar es Salaam hospital, where he was undergoing treatment for lung cancer.

President Samia Suluhu Hassan announced the sad news in a brief televised address at State House in the commercial capital, declaring seven days of national mourning starting today.

She said that flags across the country will fly at half-mast across the mourning period, with the burial lined up for tomorrow in

"With great sadness, I hereby announce the passing of former President Ali Hassan Mwinyi, who died this evening at Mzena Hospital in Dar es Salaam where he was undergoing treatment of lung cancer," the president, visibly grief-stricken said.

She said the former president had been undergoing treatment since November last year when he was flown to a London hospital and later readmitted to Mzena Hospital. Born on May 8, 1925 at Kivure village, Coast

Region, on Tanzania Mainland and raised in Zanzibar, Mwinyi served as the second President of the United Republic of Tanzania from November 5, 1985 to November 23, 1995.


He had earlier served as third President of Zanzibar - from January 30, 1984 to October

He had his primary and secondary education at Mangapwani and Dole Secondary School in Zanzibar, respectively, from 1933 to 1942 and thereafter attended a two-year teaching course at the Zanzibar Teachers' Training College.

He pursued further professional training at the University of Durham, near Newcastle city, in north east England, thus setting for a professional career in teaching.

He became principal of the Zanzibar Teachers' Training College and was soon thereafter recruited into public administration in 1963 as principal secretary in Zanzibar's Ministry of Education.

From 1970 to 1975 he served as Minister of State in the Union President's Office, Health minister and Home Affairs minister, where-TURN TO PAGE 2

ATCL clears the air over engine fault on Saturday

AIR Tanzania Co. Ltd (ATCL) has cleared the air on how one engine of its Airbus A220-300 aircraft started emitting smoke in the air and was rerouted to Dar es Salaam last weekend.

Ladislaus Matindi, the ATCL director

general, told journalists in Dar es Salaam yesterday that the plane was recently in Germany for maintenance. It was used for 200 hours in the country since it was

delivered from maintenance, he said. Up to that point the plane did not show signs of technical failure but then it developed a technical fault mid-air, with

the passengers scenting smoke that was traced to a fault in one of its engines, he

affirmed. The plane which was heading to Mbeya, a two hour trip, took off in Dar es Salaam at 6:00 am on Saturday and after half an hour the fault was noticed, as the engine got very hot and started emitting smoke that entered the air conditioning

system, he explained. The smoke continued for five minutes while the pilot and crew examined the situation, so the pilot decided to turn off

fisheries and forestry, we will capture the majority of the population, hence pushing ahead with ending poverty," he said.

17 pupils confirmed dead as meningitis hits Nigeria

LAGOS

AT least 17 schoolchildren across five schools in Nigeria's northeastern Yobe state have died after an outbreak of meningitis, authorities have confirmed.

Among the deceased are pupils in primary schools and others in boarding secondary schools, the state commissioner for education, Mohammed Sani-Idris, told the BBC.

A total of 473 suspected cases have been recorded so far, he said.

Meningitis is an infection which causes an acute inflammation of the outer layers of the brain and spinal cord. It can be life-threatening unless diagnosed and treated early. Vaccination is an effective way of

preventing meningitis. The Nigeria Centre for Disease Control and Prevention (NCDC) had earlier in the year put out a public

health advisory on the disease. It highlighted that the dry season could "increase the risk of infection, especially with crowding and poor ventilation".

Most cases of the disease in Nigeria are reported in what has been termed the "Meningitis Belt," which covers all 19 states in the northern region.

As the air started clearing, the crew informed the passengers of the mishap, and further, that the plane was to be rerouted back to

After the plane arrived in Dar es Salaam, 104 passengers agreed to travel using another ATCL plane while 18 passengers requested to change the day for them to travel.

"It is true that the engine malfunctioned and smoke entered the plane, but there was no fire and the passengers were not handed breathing equipment," he said.

Online entries said that smoke filled the cabin, making it difficult to breathe, a situation that lasted less

than five minutes, which the CEO said was a routine problem.

Online discussion affirms routine emission of smoke on take-off, while emitting smoke after half hour duration of the flight is not a common occurrence. The CEO said that the public must understand that it is an aircraft and situations of malfunctioning are not surprising. "If a malfunction occurs, safety measures should be given priority and we at ATCL our priority is the safety of passengers," he elaborated, stressing that none of the 122 passengers

on board suffered any harm Emmanuel Twai, the firm's head of security, said failure is expected on any vessel, but what is essential is to observe safety precautions when it happens.

The pilot of the Airbus was right to return the plane to Dar es Salaam so that the plane's engineers could check the problem and work on it before starting another journey, he stated.

"The action taken by the pilot was absolutely correct because if they had gone to Mbeya, the plane might not have received the same quick services as it did here in Dar es Salaam where there are all engineers and aviation professionals," he said.

He said that not every error that occurs during flight is notified to the public and that has been done to remove the panic in the community about civil aviation.

"When incidents like this happen, we have internal procedures to monitor and deal with them, that's

why you won't hear everything, we have come forward to inform the public after seeing others misleading about what happened," the CEO intoned.

VPO stresses broad soil quality research

GAPS in soil quality research affects food production amid extreme weather patterns due to climate change, Union and Environment minister Dr Selemani Jafo has declared.

He made this assessment at a side event, the policy business forum at the sixth international conference of the United Nations Environment Agency (UNEA 6) in Nairobi, scheduled for Wednesday to Friday

A statement released yesterday by the Vice President's Office (VPO) said that the minister expressed Tanzania's desire to improve capacity for research in soil quality to map out land degradation that

affects food production and the economy in general.

In his remarks, he recounted strides that the country has made in environmental conservation, explaining the efforts that Tanzania is taking to deal with the challenges of land quality.

The government has increased budgetary allocations for the agriculture sector, including investing in modern agriculture, he stated, urging institutions as well as businesses to take up soil research investments as it is key to the production of quality raw materials and food crops.

UNEA 6 focused on the effects of climate change, biodiversity destruction and environmental pollution, where the 2024 meeting

came under the theme 'Strong, Integrated and Sustainable Efforts to Combat Climate Change, Biodiversity Destruction and Pollution.'

The UNEA global meet is intended to help restore harmony between humanity and nature, thus improving the lives of the world's most vulnerable people, a background statement indicated.

As the planet's only universal membership forum for the environment, UNEA provides a unique platform for courageous decisions and new ideas to chart a bold plan of collective environmental action. In so doing, UNEA-6 facilitates efforts to achieve the sustainable development goals,

Abdallah the Union deputy permanent secretary in the VPO accompanied the minister, as well as a range of experts in the conference, which opened on February 26 and closed

Conference delegates seek to prepare a policy formula on the environment that restores ecological harmony, to improve the lives of people facing environmental challenges.

Tanzania is one among countries facing the effects of climate change by causing drought, unpredictable rain, floods and livestock deaths. In response to those challenges, the government has been taking various measures to deal with those effects, the minister underlined.

US govt hands over two renovated labs to TPDF

THE US government through Walter Reed Army Institute of Research-Department of Defence (WRAIR-DoD) vesterday handed over two renovated laboratory buildings at Makambako Dispensary in Njombe Region and Mbalizi Military Hospital in Mbeya Region to the Tanzania People's Defence Force (TPDF).

A statement released yesterday by the US embassy in Dar es Salaam said the handover ceremony, held at the Mbalizi Military Hospital, was attended by Brig Gen Charles Mwanziva of TPDF, Defence Attaché at the US Embassy LTC Gerald Mathis, WRAIR-DoD Country Director Mark Breda and Henry Jackson Foundation Medical Research International (HJFMRI) Executive Director Sally Talike Chalamila.

The US government, through PEPFAR, is the largest supporter of HIV/AIDS relief in Tanzania.

"So far, the President's Emergency Plan for AIDS Relief (PEPFAR) in Tanzania supports more than 1.5 million people on lifesaving treatment," reads the statement.

"WRAIR-DoD has been operating in Tanzania since 1999, working to end HIV through research and the implementation of PEPFAR prevention, care, and treatment programs for civilian and military populations."

Since 2006, the US has provided lifesaving treatment to a total of 23,730 clients 88 percent of whom are virally suppressed and can no longer transmit the disease.

At the event, Mwanziva said: "I thank WRAIR-DoD from the American Embassy, the funders of the HJFMRI project, who are successfully implementing various HIV interventions in our 21 military health centers. I am pleased that the Defence Attaché from the American Embassy, LTC Gerard Mathis has joined us here today. This demonstrates the strong cooperation between the US Department of Defence and the TPDF."

LTC Mathis said: "Through funding from the United States President's Emergency Plan for AIDS Relief (PEPFAR), WRAIR-DoD will continue to support the TPDF in the provision of quality HIV/AIDS services at all 21 supported military facilities

throughout Tanzania attain the 95/95/95 UNAIDS goals and achieve HIV epidemic control by 2030."

Breda pledged to "continue supporting this program to significantly strengthen TPDF laboratory testing capacity and help ensure appropriate treatment, which in turn will save lives."

"The initiative is part of PEPFAR's investment through the Walter Reed Army Institute of Research to support the Country's initiatives of strengthening laboratory services to provide informed decisions to various HIV clinical and diagnostic activities within the TPDF health facilities, said Chalamila.

"WRAIR-DoD has been operating in Tanzania since 1999, working to end HIV through research and the implementation of PEPFAR prevention, care, and treatment programs for civilian and military populations."

Govt assures insurance investors: **Conducive condition guaranteed**

THE government has assured investors in the insurance sector that Tanzania has huge potential for returns and offers an opportunity to expand their businesses to other countries within the eastern and southern Africa.

Prof Kitila Mkumbo, Minister of State in the President's Office (Planning and Investment), made the statement in Dar es Salaam on Wednesday during the 25th anniversary celebration since the founding of ICEA LION General Insurance company in Tanzania. The celebration was attended by a wide range of insurance firms, brokers, agents and clients.

"I want to assure you that this country at the moment provides the best environment for investment. We tick in almost every factor that is important in terms of attracting investors. If you speak of political stability and security which is the first factor which investors look at, we are okay," he said.

Prof Mkumbo said that Tanzania has a population of over 60 million people which serves as a potential internal market, adding that the country also serves as a link to other countries such as the DRC, Burundi, Uganda, Kenya and Rwanda owing to the good bilateral ties Tanzania has with its neighbours and its political stability, peace and security.

He said that the government is continuing to improve the legal framework, citing the Tanzania Insurance Regulatory Authority (TIRA) as a notable example.

"This is why we have made serious reforms in the past 25 years both legally and policy-wise with respect to the insurance industry here in Tanzania. We will also keep on improving our education system to ensure we produce people who are skilled, who will be able to match with the requirements of the investors. llagers engaged in eco-friendly projects to protect forest

RESIDENTS of 21 villages surrounding Magamba Nature Reserve Forest in Lushoto District, Tanga Region have benefited from various agriculture and eco-friendly projects supported by the Eastern Arc Mountains Conservation Fund (EAMCEF).

The projects include avocado and spice farming, beekeeping, aquaculture and production of energy-saving stoves to help reduce deforestation.

Addressing reporters here recently, tree planting project coordinator in Lushoto District Mfaume Mhonda said the project commenced in 2013 and has benefited 11 groups established by the villagers.

He named some of the beneficiary villages as Magamba, Migambo, Irente, Kwesimu, Gorogoro and Nywelo.

"The project involves training villagers on preparation of tree nurseries and working closely to ensure that trees are planted and cared for; we want to ensure that ecofriendly initiatives are sustainable to fight deforestation and other activities that harm the environment," he said.

Shafii Salehe, secretary of Umoja Tree Planting Group said in 2023, they grew a total of 10,000 tree seedlings and sold 6,000 of them and distributed 2,000 seedlings free to the communities.

"These initiatives do not only conserve the environment but also increase income," he

Joyce Shedafa, also a beneficiary, said the project has helped them improve their lives and that many people have started to join the groups due to various benefits which they have witnessed.

"We were spending most of our time in the forest for charcoal production and firewood collection in order to get income, but now with the projects, our priorities have changed since work hard through our groups to improve incomes and at the same time conserve the environment," she said.

Magreth Victor, EAMCEF programmes officer in Northern Zone, said the tree planting project is implemented in the villages to restore destroyed forest and degraded land in

"We have been issuing 15m/- to a group when it sends a project proposal, this has been done to many groups and others have started to get profit from their projects," she

Yohana Mtangi, chairman of Yoghoi environmental protection group, said that the group started with a tree planting project in 2017 and has since added avocado farming to improve income.

"In 2022, we received a funding of 10m/from EAMCEF with which we planted a total of 15,000 tree seedlings, some of which we sold and others we planted in our villages," he said.

Govt promises action as PWDs list challenges

THE government plans to review laws, policies and regulations governing people with disabilities to enable them fully access their

It also intends to start visiting the private sector employers to see if they comply with the employment requirements for people with disabilities.

Deputy Minister of State in the Prime Minister's Office (Labour, Youth, Employment and People Disabilities) Patrobas Katambi made the statement here yesterday, adding that while the law is quite clear, some employers deny people with disabilities their rights.

He said while the Persons with Disabilities Act, No 9 of 2010 clearly stipulates the rights, most employers do not adhere to it, adding that even some offices do not have friendly infrastructure for the group nor the equipment.

The meeting convened by Ikupa Trust Fund brought together over 150 people with disabilities from

across the country to discuss challenges facing them.

According to the deputy minister, the government has approved a 3bn/- budget for the renovation of colleges of people with disabilities and a similar amount for construction of two new ones in Mwanza and Kigoma regions.

"Leaders at all levels should implement the people with disabilities law to the letter, failure of which is tantamount to discrimination," he said.

He added that the government considers establishing a special fund for the support of people with disabilities in the country.

Speaking earlier, Hamisi Sekejo, chairperson of workers with disability who is Procurement Officer with the Tanzania Electric Supply Company (TANESCO) highlighted several challenges facing PWDs at work.

He cited lack of support equipment and infrastructure in most public offices, negative perception that PWDs should be given light duties or easy tasks and lack of database of people with disabilities, their levels of education and expertise.

Other challenges, he said include lack of experts to empower PWDs to cope and benefit at different environments in the country and the need for special allowances to enable them to attend training, seminars and courses.

This, he said, should enable them to pay for upkeep of their assistants.

Stella Ikupa, founder and executive director of Ikupa Trust Fund, said the meeting was focused on success and challenges facing PWDs in the workplace.

She noted that despite efforts put in place to improve the working environment, PWDs still face several challenges with infrastructure leading on the list.



EU avails additional 6.6bn/for clean cooking initiative

THE United Nations Capital Development Fund (UNCDF) has received additional funding of euros 2.4 million (6.6bn/-) from the European Union (EU) to facilitate expansion of the CookFund programme in Tanzania.

This, according to UNCDF, increases the overall funding from Euro17.0 million to euros 19.4 million to implement the programme until September 2026.

Peter Malika, head of UNCDF Tanzania said in a statement yesterday that the programme which is implemented in five regions of Tanzania Mainland and aims to curb reliance on charcoal and firewood for cooking in the country.

It is implemented in Morogoro, Coast, Dar es Salaam, Mwanza and Dodoma regions.

He said the additional funding enriches the programme impact by supporting legal and legislative aspects of biomass energy, including enforceability as well as piloting the switch and transitioning of public institutions from the use of

fuel and appliances.

"Strengthening the framework and raising awareness on the urgency of climate change mitigation by adopting cleaner and efficient cooking alternatives contributes to achieving the National Energy Policy Sustainable Development Goals. The strategic partnership with the government of Tanzania and European Union is the driving force for achieving these goals," he said.

Malika said clean cooking solutions serve a pivotal role in mitigating climate change impacts, forest degradation prevention and reducing health issues related to traditional cooking methods.

Over time, these solutions also aid in cutting down household expenditure recurring on purchases of charcoal or wood, he

He noted that addressing the market barriers of clean cooking business in Tanzania by increasing end-user affordability, enterprises capitalization and expanding availability outreach remains the primary focus of the programme.

"It's been 12 years of pain...and frustration," she told the BBC. "Every time they come, they promise, but their promises, they are unkept... And we are worried that time is really moving and nothing has been done."



Researching on school dropouts can help a bit

apart in education in our country, but there are reasons to worry.

That is, if a section of our young people are satisfied with reading and writing, and need more than a push to join secondary school.

Signs of this situation have been there for years, like when pupils write obscenities in school leaving exam

Each sphere of life or socio-ecology has its attractions for young people, regardless of whether it is early marriage or fishing along the coast, mining in Lake Zone regions, etc. Roaming with cattle and earning millions isn't out of order either.

Wishing not to depend solely on wisdom or hearsay, the upper level authorities concerned have formed a team of researchers to find out why the number of school dropouts across the country is rising.

The idea is to come up with recommendations on how to deal with the challenge, even if the key indications may be that society should simply live with it.

Education, Science and Technology minister Prof Adolf Mkenda just the other day announced the move at a two-day conference bringing on board education stakeholders and researchers from within and outside Tanzania, where dropping out of school was among the key issues.

The wider formulation of the issue, 'climate, environment and education', was prophetic in explaining the lack of interest in many years of climate change tuition.

This pushed young people to various survival strategies a bit early in life. In a past epoch that would have seemed all right in that they were armed with education and life skills.

But now things have changed somewhat, with education now having a more intensive definition

HINGS are not quite falling than just reading and writing and life skills also involving the ability to set up something of one's own preference.

> To convert this difference into sociological terms, in his 1967 essay, Mwalimu Nyerere saw pupils and students as future peasants and workers.

The current mood in compulsory secondary school attendance and the youth's initiative for 'agribusiness' meanwhile in a sense mean seeing in each youth a hidden entrepreneur.

We see anyone still unable to start an income-generating project as yet uneducated, for life at present is selfemployment, etc.

Then there is a hidden, if slightly cynical, position that all the hue and cry about dropping out of school mostly targets the boys.

In a way, the relevant authorities are unlikely to get sleepless nights that youths opt to tend cattle as their possible inheritance instead of $attending\,secondary\,school.$

Opting for artisanal mining isn't as disturbing either, in which case where the shoe pinches most is dropping out of school to get married. Still, these choices are tied together while youths abandoning school, and others, also need to marry.

An excellent illustration is when the minister reflected on Geita Region as top culprit in the school dropout tendency, wondering whether the cause was mining activities, and if yes, if it was the only reason.

Efforts to factor in other aspects such as sports and nutrition came in, while issues like the number of teachers and infrastructure or amenities to cater for girls' specific needs come up in dropping out of secondary school.

Still, it isn't easy to see how the government resolves these bottlenecks, ensuring that schoolgoing youths already desperate in their situations heed appeals to continue studying rather than stay idle.

Tanzania's voice at regional electricity trade meeting should have been louder

HERE was something a big achievement compared to the curious in reports in the Tanzanian media on a just-ended meeting in the Kenyan capital, Nairobi, bringing together ministers in charge of electricity from eastern African

It was a three-day event deliberating on ways to promote regional trade in electricity, or at least to put some nuts and bolts in place, as promotions of the sort date back two decades already.

Reports said that the 18th Eastern Africa Power Pool (EAPP) council of ministers meeting brought together senior government officials from 13 African countries determined to make advances in regional cooperation in the energy sector.

One problem was that just a few areas were cited, and Tanzania appeared to be on the margin, while some projects were more elaborately set out.

There is no question, as Kenyan top energy and petroleum officials noted, that governments in the region are committed to approving policies, plans and budgets helping to scale up the level of interconnectivity of eastern African grid electricity going forward.

The only case of significance cited was the importation of 200 megawatts in renewable energy from Ethiopia by Kenya and engaging in an energy exchange with Uganda.

It would thus appear that in the past few years of the past decade Tanzania isn't on everybody's lips as a source country to fall back on in case of electricity shortage. Unreliable hydropower source was swiftly given as the reason.

Tanzania's importance in the EAPP arrangement seems to have been the reverse of the wider tendency.

Officials at the meeting said countries in EAPP zone are currently trading over 3,400 GWh annually, which represents lowly 504 GWh in 2005.

While readers in Tanzania are more comfortable with megawatt hours, it is evident that Tanzania was more active when the trading levels were low but is on the margin when trading is admittedly higher. Leading the pack is Ethiopia, the generation capacity of whose main hydropower project stands at 5,150MW and comfortably supplies 200MW to Kenya.

Tanzania has equally significant plans especially when the 2,115-MW JNHPP is fully operational, as EAPP had plans to complete, commission and operationalise the Egypt-Libya, Egypt-Sudan, Ethiopia-Djibouti electricity transmission lines.

Interestingly, Ethiopia is not targeting Sudan for power sales but Tanzania has links with Zambia, Rwanda, Uganda, Burundi and Malawi is not far from grid lines, when the capacity is right. We are a bit silent for a while.

A top Ugandan official said that regional trade is designed to move electricity from countries with surplus production to those with deficit production, thus ensuring reliable energy supply and reduced electricity outage risks.

Dar es Salaam residents would likely have wished that some electivity were purchased to ease outages. However, when the power sector is fully controlled by state-run firms, they presumably would rather have outages than import power possibly on cash

That being the scenario, the EAPP framework is of massive relevance to our state-run Tanzania Electric Supply Company Ltd (Tanesco) and the Energy ministry as they can use it to sell electricity if it is in surplus. But importing power to stem outages demands a competitive environment, not monopolies.



Despite AI, audience preferences still central to content production

ESPITE all the attention on artificial intelligence machine-based learning and various other technological advancements, the audience remains at the centre of journalism and news business models.

This is according to Sinead Boucher, Executive Chair at Stuff in New Zealand.

Bharat Gupta, CEO of India's Jagran New Media, meanwhile told the recently concluded Digital Media Asia 2023 conference in Singapore: "It is important to learn the reasons driving audience growth, given that India will soon possess the largest internet-using audience globally."

"In the past, growth was relatively static, with publishers focusing on producing content and expecting users to consume it. This later moved on to creating more interactive and dynamic sites," he

Elaborating, Gupta said: "Understanding audience science and behaviour - what content they want to consume and why - is essential in content production. Content teams should set goals in order to create content that will benefit their audiences."

Understanding the audience profile will help content teams to identify if a product is sufficient for the entire audience or not.

For instance, it is important to understand that GenZ (name given to the generation of people born between 1997 and 2012), GenX (people born between 1965 and 1980), millennials, and local communities have different interests, requirements, preferences with regard to content presentation.

This will go a long way towards enhancing the type of content produced, meanwhile as language, user experience, privacy and safety are also paramount.

Thomas Schultz-Homberg, CEO of Germany's Kölner Stadt-Anzeiger Medien, pointed out how AI can help identify different audiences and recommend content that is specific to their individual interests.

Nonetheless, **AI cannot replace** editors who are needed in the content development process, he said.

The audience is the focus at Stuff Ltd, although New Zealand has a much smaller population than India, said Sinead Boucher, adding: "We are part of people's everyday lives in New Zealand and are really proud of that."



She said the core priorities at Stuff place customers at the heart of the business model. These priorities include optimising data and intelligence to attract customers, improve their lives, and help them win with valuable content, products, and services.

Boucher also noted the importance placed on building the deepest, richest knowledge of New Zealanders by developing real-world connections with the audience of Stuff.

"Our audience is a direct mirror of the New Zealand population," she said, adding that, as such, it is important to understand the sentiments of the audience rather than merely examining data on engagement and site visits.

Boucher at it yet again: "We also noticed that people desired meaningful and joyful communal experiences following the (Covid-19) pandemic lockdowns. We realised that we needed to use our platforms to drive these experiences and tie in our digital and print content with these live events."

pointed Schultz-Homberg out that, moving forward, it is also crucial to foster the kind of journalism the audience wants and not merely provide them with content that publishers want them to consume.

Jagran New Media's Gupta additionally advised that content teams need to reflect the audience, saying. "If you are catering to an inclusive and diverse society, your team should also be representative of that change in order to produce content or bring that experience to the product."

The audience can also help produce content, advised Boucher, saying the Stuff Ltd-owned social media platform Neighbourly comprises 950,000 verified users and provides key data and insights into the lives of New Zealanders.

future

Business models and newsrooms require fundamental changes to cope with future challenges because, as Schultz-Homberg aptly warned: "Without technology, there is no future for newsrooms."

He said that it was vital for publishers to be ahead of the curve and identify how technology can help steer the way towards the future of publishing - such as with natural language processing.

Echoing his sentiment was Uma Patel, News Lab Lead at Google, Australia & New Zealand. She described newsrooms as the "engine rooms" and main drivers of business models.

"Newsrooms are good at holding powerful institutions accountable with a healthy dose of skepticism, but that skepticism can make it difficult to encourage risk - a vital ingredient for experimenting," she

Adapting and experimenting within newsrooms are crucial to ensuring the effective management of disruptions.

On this score, Patel described framework created at Google that sought to help journalists experiment from newsrooms, resulting in newsroom innovation. "It is important to embrace failure as well. If every experiment succeeds then we aren't experimenting," she said.

Combating misinformation

Recognising that Stuff was an essential source of quality, accurate news in New Zealand prompted executive Boucher to buy the company for one New Zealand dollar when the previous owners intended to close it. This involved completely resetting and reimagining the 165-year-old business to rebuild it for the future.

To grow specific reader revenue

products, the company needed to completely change its structure to pursue different strategies for digital and masthead publications.

"A large sector of the population was becoming very susceptible to misinformation," she said, adding: "Our vision was to become the most trusted news organisation in New Zealand."

Journalism has experienced diminished trust over the past few years, so we wanted to rebuild trust in journalism and media, she noted further.

Jaime Ho, Editor at Singapore's The Straits Times, SPH Media, submitted that there was an unmistakable trend towards polarisation, trust in the news had declined globally, and the news industry needed to identify how it played a part in fermenting or mitigating the issue.

He further submitted that Singapore's news media had largely managed to maintain audience trust, "but being widely read does not necessarily equate to trust, and vice versa. Furthermore, maintaining audience trust will continue to pose a challenge".

Overcoming news fatigue

According to Ho, audiences have actively minimised news consumption, including from social media, to better protect their mental health.

He said this has a direct impact on journalists and editors who must evaluate the risk-benefit ratio of news consumption - that is, recognising and minimising the downsides of social media while continuing to provide vital content.

"News avoidance, or malaise may prove more detrimental than technology if we do not take steps to address these issues," Ho said.

He elaborated: "The most important disruption is the one that threatens the core of what we do and that is the relationship we have with our audiences...

"We need the courage to test new ideas, platforms, and work processes to combat these issues, and newsrooms must encourage creativity and experimentation.

"We can often get quite glum talking about our challenges, but I daresay there still remains a lot of joy and meaning in what we do."

N increasing trend of Human-Wildlife Conflicts (HWC) incidences in various parts of the country, especially at villages bordering National Parks, Game and Forest Reserves requires stakeholders' concerted efforts to ensure safety of both wild animals and human beings.

When wild animals, mostly elephants invade people's homes and farms they end up causing damages to properties and crops. At times, the big animals are killed by angry citizens.

These incidences have been increasing annually with the situation attributed to blockage of wildlife corridors, inadequate land-use planning, livestock intrusion into protected areas, climate change, disregard for advice given by experts on how to avoid HWC effects as well as existence of false beliefs in some societies.

Current statistics from the Tanzania Wildlife Management Authority (TAWA) shows that incidences of HWC have been increasing at annual average of 23.76 percent while crop damage increases at an annual average of 118.1

According to Isaac Chamba, TAWA Conservation Officer, the confrontations between humans and wildlife are historical; adding the Ministry of Natural Resources and Tourism has been dealing with the challenge through its Wildlife Department before the authority was established in 2016.

"There was an increase in humanwildlife conflicts incidents in 2018. Before that time, the problem was small with little impact to the lives and properties of the people. The increase, led the ministry coming up with a National Human-Wildlife Conflict Management Strategy 2020-2024," said Chamba, noting the strategy that was launched in October 2020 is implemented by TAWA, Tanzania National Parks (TANAPA), Ngorongoro Conservation Area Authority (NCAA), Tanzania Forest Service Agency (TFS) and Tanzania Wildlife Research Institute (TAWIRI).

He said in 2016/2017 there were 833 incidents whereas the number increased to 997 in 2017/2018 and 1510 in 2028/2019. He added that in 2019/2020, there were 1426 recorded HWC incidents. The number increased tremen-

dously in 2020/2021 reaching 1706, 2304 incidences in 2021/2022 and 2817 in 2022/2023.

Chamba who was speaking recently at a training organized by the Journalists' Environmental Association of Tanzania (JET) with support from the Mitigation of Human Wildlife Conflicts in Tanzania project that is implemented by GIZ on behalf of the Federal Ministry for Economic Cooperation and Development (BMZ), said so far, a total of 44 districts are facing the challenge mentioning them as Busega, Kilosa, Meatu, Nachingwea, Rufiji, Lindi, Manyoni, Itilima, Tunduru and Bunda.

The project which is implemented in the Ruvuma landscape by the ministry of Natural Resources and Tourism will cover three districts-Liwale, Tunduru and Namtumbo

Elephants are the leading wild animals in HWC as they contribute to the problem by 80 percent, he said, adding the other remained 20 percent involves wild animals such as lions, hyenas and monkeys.

The TAWA official noted that when the big animals enter into people's homes, citizens are required to inform wildlife officers instead of killing them since such an act is a legal of-

"TAWA officers are responsible of taking the animals pack to the park. In between 2017/2018 and 2022/2023, the author successfully moved 60 lions and two hyenas from human settlements. In 2022, we returned 270 elephants back to the forest reserve in Liwale and Nachingwea districts," he added.

In April last year when addressing the National Assembly, Deputy Minister for Natural Resources and Tourism Dunstan Kitandula told the August House that the government is working to craft an emergency strategy to address complaints from victims of wild animal

The current wildlife regulations direct that survivors of wildlife attack should receive 200,000/- in compensation, 500,000/- for victims who have lost body parts and 1m/- for the death, said Kitandula, noting the government does not pay compensation for loss of life or injury caused by dangerous wild animals. It only pays consolation to the victim for the loss of life or injury.

The rate and procedure for payment of consolation for death caused by wildlife is stipulated under section 69 to 71 of the Wildlife Conservation Act, 2009 and the Wildlife Conservation (Dangerous Animals Damage Consolation) Regulations, 2011.

Application of the regulations took effect in 2012 whereas between 2012/2023 and 2022/2023, a total of 11.3bn/- has been paid to people who sustained injuries or died from wild animal attacks or incurred losses caused by straying destructive wild animals.

Expert opinions John Noronha, HWC Expert said that in-

planning and implementing any human-wildlife conflict mitigation initiative, one should understand the values, social norms, beliefs, culture, economics, interactions between stakeholders and other social and political factors.

According to Noronha, mitigation and damage reduction interventions must be designed and managed collaboratively whereas officials and project staff need to build rapport with the affected communities and other involved parties, while remaining aware of their own positions.

He added that most of the conflicts involve species that range across highly fragmented habitats and or well beyond protected areas into human-dominated landscapes, noting that mitigating damage by wildlife to promote tolerance by people may provide only a shortterm solution.

"It is important that communities living near wildlife are actively engaged in ideas and decisions, supporting, for example, biologists, ecologists and geographers in gaining an understanding of a given species' movement patterns, resource needs and behaviour. Such kind of planning generates important sectoral collaborations, across sectors-agriculture, forestry, health, environment, transport and energy

agencies," he added. The expert said that it is possible for humans to live with wild animals, but this requires people to apply protective measures such as building strong fences, cultivating crops that are not eaten by elephants, planting peppers around homes and farms.

He however noted that such protective measures against wildlife cannot be applicable at all places; hence the need to know the exact method to be applied to control damages at each of the specific ar-

Coexistence suggests that at some level and in some form a choice is being made by humans to share landscapes and natural resources with wildlife in sustainable ways. Moving from conflict to coexistence cannot be described as a continuum in which neither conflict nor coexistence is locked at a fixed point along the scale.

"Conflicts are not always negative, and words and language matter. Conflicts bring about change. They can be a positive opportunities leading to dialogue, stimulating action and forcing a potentially bad situation to be resolved or improved," said Noronha, adding if addressed properly, HWC can force people to look at underlying tensions and inequalities, thus work together for improved well-being, development and conservation.

Media role

Head of Communications Department at Ministry, John Mapepele, said the contribution of journalists in conservation efforts is important taking into considerations that a third of the country is reserved.

JET Executive Director, John Chikomo said they conducted training to equip journalists with the precise knowledge on HWC before they embark of field trips at the three districts. He said journalists will visit 30 villages across the districts whereas they are expected to accurately report to the public.

"Engaging journalists in mitigation of HWC is essential as they can reach a good number of people. Tanzanians need to be educated on the matter as well as informed on how they can protect themselves from the wild animals," stated Chikomo, adding that similar training will be conducted to journalists in the specific districts.

Anna Kimambo is the Advisor, Mitigation of Human-Wildlife Conflicts from GIZ, she added: "We are engaging journalists because we want the public to be well informed and stop considering the animals as enemies. This will help change people's attitude against wildlife and ultimately stop attacking them when pass near their homes.'

Ugandan warlord LRA's victims awarded share of £56m

THE HAGUE

TCTIMS of Ugandan warlord Dominic Ongwen have been awarded more than €52m (\$56m; £44.5m) by the International Criminal Court (ICC).

The order covers almost 50,000 people, including former child soldiers and children born out of rapes and forced marriages.

Ongwen was a ruthless rebel commander in the Lord's Resistance Army (LRA).

He is currently serving a 25-year prison term in Norway for multiple war crimes and crimes against humanity.

He was originally abducted as a child and forced to join the LRA but went on to become one of the leaders of the notorious rebel group. During his trial, his argument that he should also be treated as a victim was rejected by the court.

The crimes were committed by his rebel fighters in northern Uganda in the early

As part of the extensive compensation package, everyone who suffered, directly or otherwise, as a result of what Presiding Judge Bertram Schmitt described as Ongwen's "unimaginable atrocities" will be awarded €750

Judge Schmitt described physical, moral, material, community and transgenerational harm, and explained the remainder of the \$56m would constitute collective reparations, to be invested in projects designed to rehabilitate and rebuild broken lives.

The LRA was formed in the late 1980s in Uganda, where it said its goal was to install a government based on the biblical Ten Commandments.

It was eventually forced out of the country

As a reminder of the many ways in which communities were affected by the LRA, an extensive list of the ruthless acts committed by Ongwen was read out during the hearing.

These included a catalogue of harrowing sexual and gender-based crimes that came to characterise Ongwen's campaign of terror.

Judge Schmitt recounted that soldiers had raped a woman with a stick used for cooking while her husband was forced to watch, babies were thrown into bushes and left to perish because their crying made it hard for new mothers to carry looted goods, women and girls were "distributed"

to soldiers and kept as sexual slaves - many forced to bear children after rape or forced marriage.

Children kidnapped and trained to be child soldiers were also among the victims - some were forced to kill others, as lessons to anyone who considered attempting to escape.

"Tens of thousands of individuals

suffered tremendous harm due to the unimaginable atrocities committed," as rebel fighters led by Ongwen attacked four camps for displaced people in northern Uganda, said Judge Schmitt.

Entire communities and families witnessed the attacks, after which people had to walk through villages strewn with dead bodies.

The court acknowledged it would take time before any payments were actually distributed and that not all victims would receive the amount at the same time - priority would be given to the most vulnerable people with the greatest need.

Ongwen has been declared indigent so the money will come from the Trust Fund for Victims.

The trust relies on voluntary contributions from ICC member states and to a lesser extent other public and private donors.

The trust's mandate is to fulfil reparation orders and provide victims with physical and psychosocial rehabilitation or support.

During the hearing, the judge said the trust didn't currently have enough to cover the full \$56m reparations, and urged countries, organisations, corporations and private individuals to step up and support its mission.

A compensation plan must be submitted to the ICC by September 2024.

The ICC, located in the Dutch city of The Hague, was set up to prosecute war crimes and crimes of humanity and genocide.

The ICC believes reparations symbolise and promote hope and resilience within war-ravaged communities and serve as evidence of the court's commitment to restorative justice.

Activists urge Nigeria to delay Shell's \$2.4bn sale of assets in deeply polluted Niger Delta

NIGERIAN activists and international environmental groups want the government to delay approving the sale of oil company Shell's onshore assets, claiming Shell is trying to shirk its environmental and social responsibilities in the highly polluted Niger Delta.

The London-based company is trying to sell its subsidiary Shell Petroleum Development Company – which operates its onshore assets in the delta – to Renaissance Africa Energy Company, a consortium of local companies. Shell says the \$2.4 billion divestment deal is part of a "wider reconfiguration of the Nigerian oil and gas sector."

But the Centre for Research on Multinational Corporations (SOMO), a Dutch non-profit, released a report Wednesday saying Shell shouldn't be allowed to divest in the delta unless it takes "responsibility for its toxic legacy of pollution and ensures the safe decommissioning of abandoned oil infrastructure."

Protesters have appealed to the government of Nigeria, Africa's top oil producer, to halt the sale until environmental concerns are addressed. Lezina Mgbar, a 54-year-old healthcare worker and farmer who participated in a weekend demonstration in the country's oil capital of Port Harcourt, said her Korokoro Tai community in Ogoniland has been "severely" affected by oil spills.

"In the morning, children and women have to travel far to get water, so children often cannot get to school on time, and our farm yields are poor," Mgbar told The Associated Press. "We demand that Shell restore our land and clean our water before any divestment."

Scientific studies have found high levels of chemical compounds from crude oil, as well as heavy metals, in the delta, of environmental pollution that were

where the industry largely drives Nigeria's economy but can leave communities' water sources slick with contaminants

Activists say Shell has a history of poor divestment in the region. They point to a wellhead blowout in the Santa Barbara River, which flows through the Niger Delta, in 2021. The wellhead wasn't producing but wasn't decommissioned by Shell or its new owners, Aiteo Eastern E & P. The facility spewed crude oil and associated gas for 38 days and caused planet-warming methane to be released into the atmosphere, killed fish and devastated riverside farms.

Richard Steiner, an environmental consultant with a history of work in the Niger Delta, said the blowout on the Santa Barbara River highlights the risk of Shell and other oil majors transferring assets to new local firms without resolving legacy environmental and social concerns first.

"Many of the purchasing companies do not have the technical or financial capacity to manage these oil and gas operations safely," he said.

Shell says it assesses the financial strength, culture and social and environmental performance records of companies it sells assets to. A spokesperson added that "mandatory submissions to the federal government allow the regulators to apply scrutiny across a wide range of issues and recommend approval of these divestments, provided they meet all requirements."

Nigerian President Bola Tinubu, who holds the portfolio of petroleum minister, will ultimately decide the fate of the Shell-Renaissance transaction. His spokesperson did not comment when contactedon Monday.

SOMO's report documents other cases

allegedly not addressed by Shell before past divestments. Two communities, Ogale and Bille in Rivers State, have been in court pushing to make the company address past environmental concerns.

Shell and other oil companies often blame third-party interference, namely militant attacks and vandalism by oil thieves, for spills. However, companies still must clean up regardless of the cause, according to

The deal with Renaissance is the latest move by Shell to limit its onshore operations in Nigeria while focusing on deepwater operations. Other companies, including Chevron, ExxonMobil and TotalEnergies, have been taking similar steps but without the scale of protests Shell,

which is the most dominant in the region, has faced.

The civil society coalition that helped organize protests aimed at delaying the sale have petitioned Tinubu to adopt a set of principles to ensure more responsible petroleum industry divestments.

That "would help ensure a transparent process that would assess the capacity of the incoming companies, with meaningful community consultation throughout, address environmental pollution and deteriorating and abandoned infrastructure," said Florence Kayemba, director of the Niger Delta-focused Stakeholder Democracy Network, one of the groups that came up with

the principles. Unlike in previous sales, Shell is transferring all its subsidiary shares to Renaissance, resulting in a change of ownership that would see SPDC continue to carry liabilities. Shell has said SPDC, with new ownership, will continue with the current staff and be responsible for remediation where spills have occurred in the past.

SOMO's report noted the arrangement but said the energy giant is still trying to avoid its responsibility.

Audrey Gaughran, SOMO's director, said in a statement that "ensuring that the historical pollution, the lack of funding for safe decommissioning and poor financial transparency are fully addressed in Nigeria will be an important litmus test for a just energy transition across the

he late founding father of the nation, Mwalimu Nyerere once said that 'Books are the very important way to knowledge and to self-improvement; from them we can learn new ideas; new techniques of working and new methods. We can learn about the development of men in all aspects; we can broaden our understanding of other people's and even of ourselves. All experience of mankind and all his discoveries and his inventions can be learned about through reading".

Realizing Education for Development (READ) Tanzania, a local Non-Government Organization (NGO) aiming to improve the quality of education in the country, collaborate with the government to build libraries in public schools, and since its establishment, it has reached more than 162 schools in 22 regions in Tanzania mainland. The NGO executes the projects with support from Probono.

Students from Kiluvya secondary school at Kibamba, Ubungo municipality shared their experience after the library project was completed at their school. They expressed how the library is useful to their academic journey.

Doreen Mlay, a form two student said the library helped her to develop a reading culture thus increase her knowledge in subjects such as English by learning new vocabularies. Doreen has been a good ambassador and at forefront to encourage her fellow students to make a habit of reading various books available at the library.

"My performance in English has improved a lot because I can access various books like dictionaries, literature and story books. I used to score an average of 'C' but nowadays my average is A. We also have reading clubs and the number of students is increasing day by day" said Doreen who reads four to five books per week.

Apart from performing well in English subject, she is also competent in science subjects, something which was contributed by Instilling reading culture: NGO constructs library at Dar's Kiluvya Secondary School



the availability of the library and various science books.

Abdul Masawe, a Form Two student said the library project has made his learning journey supportive because he has been studying hard and passing examinations since Form One by conducting assignments and school projects.

Masawe narrated that he is impressed by the library environments and resources such as varieties of books like civics which has made him develop an interest in becoming a soldier, a dream which he has had for many vears.

"Previous, we did not have enough books and space. It was just a room with no resources. I have also realized that studying in class only without learning more in the library, you cannot succeed. thors, and develop her skills by conducting projects well by attaining materials and details from the library.

"Before we had challenges when it came to school projects, but now we have plenty of books to help us make references from books and gain knowledge. Also, my grammar has improved. The library is attractive, books are well placed therefore encourages us to read and learn from what we are being taught in classes." said Loveness who reads three books per week, especially literature books.

Loveness added that she

has been sharing books with her fellow students through group discussions, something which contributes to her expanding knowledge and learning new skills.

Kachinga Mkoma, a Form Six teacher said the presence of the library has greatly aided his teaching capability because of its resources.

"I am now able to access a lot of materials which I can then provide to my students. Additionally, the students have been performing well in both assignments and projects given to them outside of school" said teacher Mkoma commenting that books at the library are modern, competencythe syllabus, allowing the students to excel in various projects and examinations.

Mkoma added that sometimes, the existence of this library alone gives students topics to work on, as they search for materials independently and hence overall academic performance has significantly improved compared to before the establishment of this library.

"The library has helped me enhance my skills and advance my career as I continuously expand my knowledge through reading various books. I assign tasks to my students with confidence, knowing that they have access to resources that facilitate their success. However, we would appreciate additional books, especially in the field of Geography." said Mkoma.

Glory Njau, a Swahili

teacher and the Librarian shared her career journey of multitasking: "We have books from Tanzania Institute of Education (TIE), Oxford and others. Students can easily use them for reference and gather relevant material for their studies. Teaching has become more practical, with students having their own books and receiving accurate examples. Initially, teaching was challenging due to limited books, but now, with a wide range of resources available, both students and teachers based, and aligned with have seen remarkable improvement in academic performance.'

> She added that through the library, teachers have been able to achieve their teaching goals, as they can prepare their teaching notes and provide relevant references, allowing students to have their own books and provide accurate examples.

"Initially, it was challenging since we had few books compared to the number of students. Significant successes have been achieved, particularly in language proficiency. 

TACKLING TANZANIA'S HOUSING CRISIS AMIDST A SURGING POPULATION GROWTH

AVIGATING the housing demands of Tanzania's burgeoning population, calls for a comprehensive approach that intricately integrates urban planning, affordability, sustainability, community engagement, technological innovation, and equitable access to essential services.

Based on current data, Tanzania, currently holding the 26th position among countries representing 75.1 percent of the global population, is poised to ascend to the 14th rank by 2050, with a projected population of 137 million.

With the current population standing at 62.7 million, the demand for housing is skyrocketing at an unprecedented rate, outstripping the available supply and intensifying the housing deficit.

Therefore, through strategic prioritization of initiatives and fostering strong collaboration among government entities, private sector stakeholders, and local communities, Tanzania can effectively address its housing challenges head-

This approach not only addresses the immediate housing needs but also sets the groundwork for vibrant, resilient communities where future generations can thrive.

In an exclusive interview with The Guardian, Dr. Iulius

Shija, a London-based architect, highlighted that Tanzania, like many other developing nations, is grappling with rapid population growth.

With this surge, there is an urgent need for adequate housing to accommodate the expanding population.

"The magnitude of the housing demand is staggering, with an estimated shortage of 3 million units, growing annually by 200,000 units according to Shelter Afrique. This statistic not only underscores the pressing need for housing but also highlights the dire situation faced by millions of Tanzanians," he noted.

Adding: "As the demand for housing continues to surge, the existing deficit becomes increasingly glaring, particularly when considering the substandard quality of many homes and the overcrowded conditions exacerbated by inadequate access to essential services like water and elec-

According to him, delving deeper into the urban landscape of Tanzania, the housing deficit looms large, reaching an estimated 1.2 million units. Within this context, the bustling metropolis of Dar Es Salaam shoulders a significant burden, accounting for a staggering 36 percent of the total shortfall.

"These statistics paint a vivid picture of the housing crisis

gripping urban Tanzania, underscoring the urgent need for comprehensive interventions to address this pressing issue and ensure that every Tanzanian has access to safe, decent, and dignified housing," he maintained.

Therefore, Dr Shija is of the view that in order to address the matter, requires a multifaceted approach that considers factors such as urbanization, infrastructure development, affordability, and sustainability.

For him, effective urban planning is essential to accommodate the burgeoning population in Tanzanian cities.

"Planned expansion and zoning regulations can help prevent unplanned settlements and slum proliferation, ensuring that new housing developments are integrated into the existing urban fabric,"

he claimed. Dr Shija believes that access to affordable housing is a critical issue for many Tanzanians, and that the government, in collaboration with private sector partners and international organizations, can implement initiatives to increase the supply of affordable housing units.

"This can include subsidies for low-income households. microfinance programs, and public-private partnerships aimed at constructing affordable housing developments," the Tanzania-born expert expressed.

For Mariam Ibrahim, an independent land management specialist, Tanzania need to incorporate sustainable construction practices, for longterm environmental and economic viability.

According to her, by prioritizing sustainability, Tanzania can mitigate the environmental impact of rapid urbanization while reducing long-term operational costs for homeowners.

On the other hand, Mariam stressed the need for adopting an efficient land use management, saying it is crucial for optimizing available space and preventing sprawl.

"We can achieve this through comprehensive land use planning, land titling reforms to formalize informal settlements, and incentivizing mixed-use developments that combine residential, commercial, and recreational spaces," she maintained.

Adding: "By maximizing the utility of land resources, Tanzania can accommodate its growing population while preserving valuable natural areas."

According to her, elevating the country's infrastructure through investments in slum upgrading programs and urban renewal projects is imperative. This strategy not only enhances the quality of housing in informal settlements but also amplifies access to fundamental services like water, sanitation, and electricity.

She envisions a Tanzania where revitalized neighborhoods and upgraded infrastructure form the bedrock of inclusive and resilient urban environments.

For her, embracing technology and innovation stands as a crucial pillar in optimizing the housing construction process and making it more afford-

On a different note, a moth-

er of three advocates for the integration of digital tools such as geographic information systems (GIS) to inform decision-making processes and bolster the effectiveness of urban planning endeavors.

Jemimah John, a student at the University of Coventry in England, underscores the significance of involving local communities in the housing development journey, saying Tanzania can cultivate neighborhoods that are not only inclusive but also socially cohesive.

"Involving locals in the housing development journey is essential for fostering a sense of ownership and ensuring that the needs of residents are met. When communities are engaged in the planning and decision-making processes, they can offer valuable insights, preferences, and concerns that might otherwise be overlooked," she said.

Adding; "This inclusive approach also builds trust and collaboration between stakeholders, leading to more sustainable and successful housing initiatives."

Additionally, Jemimah further explained that by empowering locals to actively participate in shaping their built environment, communities can develop a stronger sense of pride and attachment to their neighborhoods, contributing to social cohesion and overall well-being.

Ayala land's AREIT to proliferate asset base to \$3 billion by 2030

AREIT, the real estate investment trust controlled by billionaire Jaime Zobel de Ayala and his family, plans to increase the assets it manages by 50 percent to \$3 billion in the next six years as it acquires more properties from parent Ayala Land Inc. (ALI).

Following a series of acquisitions in the past four years, AREIT has quadrupled its assets under management to 117 billion pesos (\$2 billion) from 27 billion pesos in 2020, when it listed on the Philippine Stock Exchange. "Size is important because it gives us visibility to not only domestic investors but foreign investors," Carol T. Mills, president and CEO of AREIT, said in a recent interview at the company headquarters in the Makati business district of Manila.

Buoyed by recent asset injections from Ayala Land, AREIT's net income, excluding exceptional gains, surged 43 percent to 4.9 billion pesos in 2023. "This is a testament that AREIT, led by its sponsor Ayala Land, is an integral vehicle for capital recycling and growth," Mills said. "We remain steadfast in our vision of being the leading and most diversified Philippine REIT."

Last November, AREIT announced it was acquiring some 30 billion pesos of



industrial properties from ALI and its affiliates, which could add some 2 billion pesos in annual operating income to AREIT, Mills said. AREIT will have to continue acquiring more assets from Ayala Land to sustain its double-digit growth momentum, she added.

The latest acquisition includes the 40-story Ayala Triangle Gardens Tower 2, home to the headquarters of ALI's parent company, Ayala Corp, along with the nearby 348-room Holiday Inn and Suites Makati and the Greenbelt 3 and 5 shopping malls.

In Cebu, 800 kilometers south of Manila, AREIT is buying the 301-room Seda Ayala Center Cebu. In El Nido, a luxury holiday destination in the northern shores of Palawan, it is buying the Seda Lio, a 153-room beach resort.

The Seda Lio luxury re-

sifying our asset base, reducing concentration risks on all fronts," Mills said. "By diversifying, we reduce geographic risk and lower tenant concentration risk." Shares of AREIT have climbed 30 percent since its market debut thanks to steady increases in earnings and dividend payouts.

Once the acquisitions are completed by the end of this year, Mills said, offices will account for 76 percent of AREIT's portfolio compared to 87 percent before. Although companies have adopted remote and hybrid work arrangements since the pandemic, demand for office space remains robust, Mills said, with the company signing more than 100,000 new tenancy agreements and renewing leases for more than 80 percent of existing tenants in the past year.

"At the end of day, we can't work totally in isolation," said sort in the norther shores of Mills, who also heads Ayala Palawan, the Philippines' last Land's office division. "As humans, we are social beings."

Occupancy across ALI and are a mix of offices, malls, AREIT's portfolio of over 1.4

million square meters of gross floor area in Metro Manila and Cebu currently stands at 97 percent. Some properties like One Ayala–a newly-built mixed-use office, retail and hotel complex along Metro Manila's perennially gridlocked main highway-are fully occupied.

With the acquisition of Greenbelt 3 and 5 shopping malls in Makati, retail space will account for 11 percent of AREIT's portfolio compared to 8 percent before. Despite the increasing popularity of e-commerce and online shopping, Mills said, brick-andmortar shopping is robust and retail tenants are benefiting. "Sales of many of our merchants are back to prepandemic levels or even higher," she said. "There's been revenge spending. There's an eagerness to go back to the malls. The malls are more than shopping. It's experiential."

To tap into a nascent tourism boom in the Philippines, AREIT is doubling its exposure in the hospitality sector to 6 percent of total assets once the acquisitions of the Holiday Inn in Makati and Seda hotels in Palawan and Cebu are completed. "This is a very promising sector," Mills said. Domestic tourism has rebounded above pre-pandemic levels, while international arrivals have also increased.

With the acquisition of 276 hectares of land in Zambales, north of Manila, from a subsidiary of ACEN Corp, the renewable energy unit of Ayala Corp., AREIT's industrial properties will account for 7 percent of its portfolio, up from 2 percent. The land will be leased back to ACEN's Giga Ace 8, which is operating a solar farm on the site, for 25 years, providing AREIT guaranteed rental income.

With a net worth of \$2.8 billion, Jaime Zobel de Ayala, 89, was ranked the country's ninth-richest person when the list of the Philippines' 50 Richest was published last August. The family patriarch retired in 2006, and his eldest son Jaime Augusto Zobel de Ayala, who had been the CEO of Ayala Corp. since 1994, succeeded him as chairman. Ayala Corp is among the archipelago's oldest conglomerates, which traces its roots to the Spanish colonial era. Besides real estate and power, it has interests in banking and telecommunications.

don't think I have ever told you about my "bathroom" story? To a limited number of people, yes I have, but maybe not you. Well let's just say it involves a washout one-bedroom house with a leaking bathtub, three university-aged tenants, three weeks of continuous use of that leaking bathtub, and my bad mistake of not employing the services of a plumber.

It was a low point in my investing career but a turning point as well. I realized the type of investor I wanted to be and the type of investor I did not want to be. I no longer work on bathrooms. I am glad to say the its been ages since then, but I still think of it when I hear people say, "I would never want to invest in real estate because I don't want to fix things like bathrooms, they cost a lot!" well it's a valid concern.

However, the truth is there are many, many ways to make money in real estate without needing to "play plumber." Today I want to talk about them.

In Tanzania alone, I know a number of wealthy people that have become rich through real estate. Well some it was more of a family thing but to others it was a hustle from the very beginning.

The problem for many is that investing in real estate demands a huge sum of money of which most don't have. Well the secret to making money in real estate as I have gathered from my research, talking with the key players and experience is finding the project you want and throw your body mind and soul into it.

There are simple ways well not that simple but doable ways to turn real estate into a money-making business.

Number one is the purchasing of land that does not yield any cash flow but if its improved can add value. Hence by doing that and subdividing it can bring profit upon sale. Also, the same land can be used for farming so as to get produce from the land of which can generate profit hence adding money for further investments.

The easiest of most used investment for first time investors is building "Single Family Homes" They are easy to rent, easy to sell, and easy to finance. They may be more difficult to cash flow, and can take a significant amount of time and effort to purchase just one unit.

In Tanzania we are not accustomed to the use of Mobile Homes. Mobile Toilets ves, but not homes. However, if one was to invest in these or have a yard of them or buy and sell them off it could serve a lot of housing problems and add profit.

you can buy land and have mobile homes on them that are full furnished and cheaper that building a house. A used one is far decent than a "used" house.

The other way is to buy a cheap house, fix it up, re-sell it. You are guaranteed to get a profit on this one as long as you can keep your renovation expenses at a low, value for money and DO IT YOURSELF if you can. Or you could buy a house hold it for a year or 5 or ten and sold it at a market value that is higher than it was before for it is bound to rise up unless there is a



crisis. But with the demand with housing in Tanzania, a profit is 80 percent guaranteed.

Well to make is more interesting you could in another alternative especially for beginners do a wholesale purchase. Wholesaling involves scouting your local area, finding great deals, putting those deals under contract to buy, and then "assigning" (selling) those deals to an investor for a fee.

One of my personal favorites, this incorporates finding the good deal and remodeling the home. Simply, a singlefamily home is purchased for a low price during a low market, remodeled to force appreciation, and held until the market improves and sold. This method seeks to maximize the rate of profit while limiting

There is also what is known as a car-

ry on mortgage where what happens is, if you have the cash, you can buy properties and then immediately re-sell them to buyers who may not be able to conventionally qualify for a mortgage. You can carry the mortgage for as long as you'd like, or sell the note for cash in the future. Make sure to collect a large down payment when using this method.

There is another Fun way of real estate purchase where without actually owning the property, lease-options allow a person to gain control of a property by leasing it with a legal "option" to purchase the property at a specified price within a specified time period. Often times these properties can be "re-sold" using another lease option and the investor simply makes money being the "middle man."

A rather interesting move which often works is if a seller owns a property free-and-clear (no mortgage), they often times will be willing to finance the sale themselves. This enables you to buy a property without the hassle and costs of going through a bank or other lending institution. This is often an excellent way to acquire larger apartment complexes or commercial buildings, as the owners may want to continue receiving an income but not want the hassle of dealing with tenants.

While there are many different strategies that you can employ to make money out of property, there are really only two real ways to make a profit: the first is from rental income, the second from capital growth. The first puts money directly in your pocket. If the rental income from a property exceeds its costs, the remaining rent is the profit - these properties are known as cash flow positive. Cash flow positive properties usually have a gross rental yield of 9 percent or above.

The second way of making money relies on properties increasing in value. Property has historically increased in value, typically faster than inflation: you'll have already noticed this if you've bought your own home and sold it for a better price, making a profit. Most people fear of losing their money if they invest in the property industry, if you look at the experiences of the US and UK during the Global Financial Crisis.

However, the Tanzanian market is seen to be quite different from other markets, which is underpinning strong long-term growth. To keep up with the movements of the property market, you should aim to find time to log onto online property forums, sign up for electronic market updates and read magazines such as the Dar property magazine which feature indepth reports about real estate developments, real estate deals and comprehensive suburb listings. Why green real estate is the way forward

Singapore

Going green has gone from being a luxury option to a necessity for the global built environment sector today.

For cities around the world it has a key role to play in helping to cut their long-term carbon footprint. In Singapore, for example, the built environment is responsible for almost a quarter of our carbon emissions.

To reduce this, we need to change not just the way buildings are constructed and run but also the perception of sustainability.

In the early stages of Singapore's green building movement, green building practices were not perceived to offer any competitive advantage.

However, today, we are seeing a shift in mindset with green buildings now regarded as a form of value creation for developers.

Adding green building certifications such as Singapore's Building and Construction Authority's (BCA) Green Mark to a development's list of credentials can help boost the developer's corporate image and the prestige of such developments.

A green work in progress

Such moves are driving rapid change. Over the past decade, Singapore has greened almost onethird of its building stock including improving energy and water efficiency, using eco-friendly construction material and creating healthier indoor space.

It is well on track to achieving

the target of greening 80 percent of all the buildings by 2030 to meet the standards set by the BCA Green Mark certification process.

Other cities can learn from the initiatives used to make progress. The Singapore government, for example, offers incentives for higher green building ratings. One of the most popular for developers is to obtain up to 2 percent additional Gross Floor Area when they achieve higher Green Mark ratings for new developments.

For older buildings, BCA also provides support to building owners to co-fund up to 50 percent of the energy efficiency retrofit cost. We've seen that retrofitted commercial buildings can benefit from an increase in their capital value of about 2 percent.

This is proof that profit and eco-consciousness can go handin-hand for green real estate.

It's not just developers embracing sustainability; increasingly, green real estate is driven by tenants. Businesses which strongly advocate corporate social responsibility are increasingly expecting a better indoor environment, lower operating costs and enhanced market value for their spaces.

Once again, governments can help boost demand for sustainable buildings by extending green building certifications to tenants. In Singapore, the public sector champions this by leasing office spaces only from buildings which are at least certified Green Mark GoldPLUS. Public sector events

Green Mark-certified venues.

Real estate intermediaries are also stepping up to meet such demands. Through green leases and green facilities management, they now offer prospective building tenants a way to differentiate themselves by making a positive commitment to the environment, without undermining the viability of their business.

However, there's a flipside to this as more buildings meet green standards, the additional value these currently provide is likely to decrease. To truly reflect the advantages offered by green buildings, more efforts by real estate apare also required to be held in praisers will be required on tate investors. For example, in

how best to capture the value of green attributes.

All of this is just the start of a long-term sustainability commitment. The next challenge for cities is to ensure that green building practices are self-sustaining. A critical factor is to have a business environment that values green spaces and the people who created

Regulation will have huge impact on the future of green real estate around the world. Following the Paris agreement which came into force on 4 November 2016, sustainability regulations will become even more relevant to global real esthe European Union, cities will be going beyond just greening buildings, to having net-zero buildings as a regulatory reauirement.

Jurisdictions will also be created to mandate public disclosure of building energy use data, further intertwining energy use into decision-making on leasing and investment.

Stepping out of the "business as usual" approach may appear daunting, but with strong industry leadership and greater collaboration among all stakeholders, coupled with a forward-looking mandatory framework, the road to having "future-ready" green buildings and cities is a promising one.

Equans Regeneration over £136million loss

London

EQUANS Regeneration, a significant player in the construction industry, has made a strategic decision to exit the newbuild housing market following a substantial financial setback. With a reported loss of £135.6 million for the year 2022, the company has undertaken a comprehensive reassessment of its operations and future direction.

This decision reflects the challenging economic landscape and underscores the importance of adaptability and prudent decision-making in navigating volatile markets.

The move by Equans Regeneration to withdraw from the new-build housing sector marks a significant shift in its business strategy. By reallocating resources and refocusing efforts on more profitable ventures, the company aims to mitigate further financial risks and position itself for sustainable growth in the long term.

While this decision may signal a shift in priorities, it also presents an opportunity for Equans Regeneration to streamline its operations and enhance its competitiveness in other areas of the construction industry.

In its first published accounts since being acquired by Bouygues in October 2022, the group admitted that higher turnover failed to prevent a plunge into the red in 2022 amid "particular pressure in the new-build sector".

The firm - ranked 23rd in the CN100 2023 list of top contractors based on its 2021 figures - saw revenue rise from £869.8m that year to £926m in the 12 months ending 31 December 2022.

But the cost of sales also soared from £811.2m to £981.2m, which played a major role in turning its £62.6m pre-tax profit in 2021 into a loss of £135.6m in 2022.

In his strategic report accompanying the latest accounts, Equans director Colin Macpherson revealed that the company decided to stop building new homes, apart from student homes, in October

Macpherson noted that 2022 saw "particular pressure in the new-build sector due to a combination of cost increases, supply-chain insolvency, legislative changes (particularly the impact of the Building Safety Act 2022) and unsustainably low levels of return across the indus-

He said the decision to quit new-build housing work was "in order to reposition our business and focus our construction activities exclusively within the studentaccommodation market.

US multifamily construction seen declining in 2024

Las Vegas

ACCORDING to the National Association of Home Builders (NAHB), Multifamily starts in the US are predicted to decline in 2024. Meanwhile, the remodeling sector remains on solid ground and will hold steady this

Multifamily starts totaled 472,000 units in 2023, down 14 percent compared to the previous year. NAHB is projecting that multifamily starts will fall 20 percent this year to a 379,000 total.

"Multifamily construction is forecasted to post a large decline in 2024 as the number of



tion approximately 1 million is near the highest level since 1973," said Danushka Nanayakkara-Skillington, NAHB's assistant vice president for forecasting and analysis.

Nanayakkara-Skillington said this at a press conference held during the NAHB International Builders' Show in Las Vegas, units currently under construc- adding: "Tight lending condi-

tions and the high cost of development loans continue to hinder additional multifamily housing production.'

As these new apartment units come online, rent growth will slow, helping to ease inflation, noted Nanayakkara-Skillington. However, this new supply will chill the market before stabilizing in 2025. NAHB is forecasting for 388,000 units in 2025.

In addition to tight lending conditions and the high cost of development loans, a shortage of skilled labor is another headwind facing the multifamily market, as well as the overall housing market. The industry is short more than 400,000 workers, and this challenge will grow worse as building rebounds.

"Attracting skilled labor will remain a key objective for construction firms in the coming years," said Nanayakkara-Skillington. "Efforts by the Home Builders Institute and state and local home builders' associations to promote workforce development are critically important to help address the

shortage of workers."

Meanwhile, residential remodeling activity is estimated to hold steady and remain flat in 2024 compared to 2023. Remodeling growth is expected to post a nominal 2 percent gain in 2025.

"While we may not see growth in the remodeling market this year, it still remains on solid ground," said Eric Lynch, an economist with NAHB.

"Many demand-side factors, including the low inventory of homes on the market, aging housing stock and growing equity owners have in their homes, continue to support remodeling demand," he added.

IN TANZANIA: WHERE DOES THE LINE LIE? EXPLORING THE DEPTHS OF CRIMINAL TRESPASS

espect for private property rights is a fundamental aspect of law and order in any society, including Tanzania, whereby entering someone's property without permission not only violates the law but also undermines the sense of security and autonomy that property owners

In a recent publication by ABC Attorneys, criminal trespassing is defined as the act of being on someone else's property without lawful permission. However, the legal nuances of this offense extend beyond mere presence on restricted premises.

According to Tanzanian law, criminal trespassing encompasses entering or remaining on property belonging to another individual with the intent to commit an offense, or to intimidate, insult, or annoy the lawful occupant of the property.

This broader interpretation underscores the gravity of the offense and emphasizes the importance of respecting property rights and personal boundaries in Tanzanian society.

Section 299 of the penal code, [CAP. 16 R.E. 2022] provides for the criminal trespass in Tanzania and defines the same to mean unlawfully entrance into or upon property in the possession of another with intent to commit an offence or to intimidate, insult or annoy any person in possession of the property.

Criminal trespass goes further to the having lawfully entered into or upon the property and unlawfully remains with intent thereby to intimidate, insult or annoy the person in possession of the property or with intent to commit an of-



A person who commits this type of offence is guilty of "criminal trespass" as an offence and becomes liable to imprisonment for three months, and where the property upon which the offence is committed is any building, tent or vessel used as a human dwelling or any building used as a place of worship or as a place for the custody of property, the offender is liable to imprisonment for one

The article portrays typical elements of the criminal trespass are as follows: Intent, which means intentionally entering or remaining on someone else's

property without authorization. To be deemed guilty of criminal trespass, an individual must knowingly enter or remain on property without lawful

permission. Accidental trespassing, such as inadvertently wandering onto someone's land while hiking, typically does not meet the criteria for criminal trespass.

Additionally, establishing criminal trespass often requires evidence of prior warning indicating that entry onto the property is prohibited before a conviction can be secured.

While property owners can directly instruct trespassers to vacate the premises, various methods can serve as alternative forms of notice that the property is offlimits, especially in states where specific warnings are legally required.

These methods may include prominently displayed signs stating "No Trespassing," the installation of fencing around the property, or securing entry points with locks. Such measures help reinforce property boundaries and inform individuals of the consequences of unauthorized entry.

Furthermore, the ABC Attorney elucidated in the article that the legal principle extends to public places, wherein individuals may still be found guilty of trespassing even if initially permitted entry to an area accessible to the public, ries a penalty of imprisonment for ten such as a store or park.

However, remaining on the premises after closing hours or disregarding orders to depart can lead to charges of criminal trespass, emphasizing the importance of respecting property regulations and lawful directives to maintain order and safety in public spaces.

Offense amounting to criminal tres-

According to ABC Attorney, in Tanzania, specific acts amounts to criminal trespass though many states have a general description of trespassing and outline specific acts that count as the crime.

House breaking

In Tanzania, Criminal trespass is related to house breaking and burglary but is generally considered to be a less serious crime. It's often a misdemeanor or an in-

Section 294 of the penal code provides that, a person who breaks and enters any building, tent or vessel used as a human dwelling with intent to commit an offence therein; or having entered any building, tent or vessel used as a human dwelling with intent to commit an offence is guilty of housebreaking and is liable to imprisonment for fourteen years.

When the same offence is committed in the night it amounts to burglary and the offender is liable to imprisonment for twenty years.

The penal code delineates additional offenses constituting criminal trespass in Tanzania. Section 295 of the penal code addresses the act of entering or occupying any building, tent, or vessel used as a human dwelling with the intent to commit an offense therein. This offense caryears, with an extended term of fourteen years if committed during the night.

Similarly, Section 296 of the penal code encompasses offenses akin to housebreaking and burglary, such as breaking and entering various premises including schoolhouses, shops, warehouses, and places of worship, with the intent to commit an offense therein. Individuals found guilty under this provision face a sentence of ten years' imprisonment.

Moreover, Section 297 of the penal code details another offense akin to criminal trespass, wherein individuals unlawfully break and enter various premises listed under Section 296 with the intent to commit an offense. This offense carries a more severe penalty of imprisonment for fourteen years. These legal provisions underscore the seriousness with which Tanzanian law addresses violations of property rights and the safety and security of dwellings and commercial establishments.

Conclusively, in addition to criminal charges amounting to the criminal trespass in Tanzania, a trespasser can also face civil liabilities as governed by the civil procedure code, CAP 33 R.E.2022. This is because that "trespass" is a violation of someone's property rights, thus a property owner can sue a trespasser for money, even if the trespasser didn't cause any harm.

(If the trespasser's presence didn't hurt anyone or damage property, though, the plaintiff will likely only be able to recover nominal damages.) Property owners can sometimes sue not only for money, but also for an order putting a stop to a continuing trespass.



'Mob rule' replacing democracy in Britain, warns UK PM Sunak

BRITAIN is descending into "mob rule" and police will do more to protect the country's democracy, Prime Minister Rishi Sunak said on Wednesday, after the government announced extra funding to keep lawmakers safe.

Many British lawmakers have said the abuse directed at them has become more intense since the Oct 7 Hamas attack on Israel that sparked the war in Gaza, with some fearing for their safety if they air their views on the conflict.

Last week parliament descended into chaos as tensions flared over a vote on Gaza, with the House of Commons speaker citing "frightening" threats against lawmakers for a decision to break with usual parliamentary procedure.

It also makes clear that from now on police should take a "consistent and robust approach ... to protect our democratic processes from intimidation, disruption, from subversion", he said.

Putin sets Russia's priorities in science and technologies for 10 years – decree

MOSCOW

RUSSIAN President Vladimir Putin has set the priorities of the country's scientific and technological development for the next ten years.

These include "areas that make it possible to obtain significant scientific and scientific-technical results, to create domestic high-tech technologies," according to the decree of the head of state. There are nine reference points in the document.

- Creation of high-tech products, new materials and chemical compounds, development of machine learning and artificial intelligence technologies.

Environmentally friendly and resource-saving energy, growing efficiency of hydrocarbon production and processing, the formation of new energy sources, as well as technologies of its transmission and stor-

- Transition to personalized, predictive and preventive, high-tech medicine, including through the rational use of medicaments (primarily antibacterial) and the use of genetic data and technologies.

- Highly productive and environmentally friendly agricultural and aquatic farming, creation of safe and high-quality food products.

- Counteracting man-made, biogenic, sociocultural threats, terrorism and extremism, destructive foreign information and psychological influence, as well as cyber threats and other sources of danger to society, the economy and the state, strengthening the country's defense capability and national security in the face of growing hybrid threats.

- Increasing the connectivity of the Russian territory through the creation of intelligent transport, energy and telecommunication systems. Leadership in the formation of international transport and logistics routes, the development and use of outer and air space, the World Ocean, the Arctic and Antarctic.

- An effective response of Russian society to great challenges, taking into account the growing relevance of synthetic scientific disciplines created at the intersection of psychology, sociology, political science, history and scientific research related to the ethical aspects of scientific and technological development, changes in social, political and economic re-

lations. - Objective assessment of emissions and absorption of climate-active substances, reducing their negative impact on the environment, increasing the possibility of highquality adaptation of ecosystems, populations and economic sectors to climate change.

- Development of nature-like technologies that reproduce systems and processes of living nature in the form of technical systems and processes integrated into the natural environment and natural resource circulation.

The abovenamed priorities are part of the Strategy for Scientific and Technological Development of the Russian Federation, approved by the

Trump is disqualified from Illinois ballot, judge rules

AN Illinois state judge on Wednesday barred Donald Trump from appearing on the Illinois' Republican presidential primary ballot because of his role in the insurrection at the US Capitol on Jan 6, 2021, but she delayed her ruling from taking effect in light of an expected appeal by the former US president.

Cook County Circuit Judge Tracie Porter sided with Illinois voters who argued that the former president should be disqualified from the state's March 19 primary ballot and its Nov 5 general election ballot for violating the anti-insurrection clause of the US Constitution's 14th Amendment.

The final outcome of the Illinois case and similar challenges will likely be decided by the US Supreme Court, which heard arguments related to Trump's ballot eligibility on Feb 8.

Porter said she was staying her decision because she expected his appeal to Illinois' appellate courts, and a potential ruling from the US Supreme Court.

The advocacy group Free Speech For People, which spearheaded the Illinois disqualification effort, praised the ruling as a "historic victory" in a statement.

A campaign spokesperson for Trump, the national

frontrunner for the 2024 Republican nomination, said in a statement this "is an unconstitutional ruling that we will quickly appeal."

Colorado and Maine earlier removed Trump from their state ballots after determining he is disqualified under Section 3 of the 14th Amendment to the Constitution. Both decisions are on hold while Trump appeals.

Section 3 bars from public office anyone who took an oath to support the US Constitution and then has "engaged in insurrection or rebellion against the same, or given aid or comfort to the enemies thereof."

Trump supporters on Jan 6, 2021, attacked police and swarmed the

Capitol in a bid to prevent Congress from certifying Democrat Joe Biden's 2020 election victory. Trump gave an incendiary speech to supporters beforehand, telling them to go to the Capitol and "fight like hell". He then for hours did not act on requests that he urge the mob to stop.

The Supreme Court is currently weighing Trump's challenge to his Colorado disqualification. The justices in Washington appeared skeptical of the decision during oral arguments in the case, expressing concerns about states taking sweeping actions that could affect the national election.

Xi calls for solid actions on Chinese modernization

Crops wither in Zimbabwe as dry spell bites

BEATRICE

HOLDING hands behind her back, Jane Chari looked at her wilting maize crop in a parched field in Beatrice, about 40 km to the southwest of Harare, Zimbabwe's capital.

The 64-year-old grandmother's hope for a harvest is now all but evaporated in the arid air. "It's so painful that I cannot sleep, worrying how I will feed my grandchildren," Chari

A dry spell has persisted in Zimbabwe for close to a month, hurting the maize crop, her only source of livelihood. "I have never seen this level of wilting. I cannot even think of how we are going to survive," Chari said. "We are totally clueless." Erina Mazwi, another farmer from the same area, said groundwater is drying up, and it is now very difficult to get water from

"I was expecting a bumper harvest, but the dry spell changed all that," she said. "It is just painful. Sometimes I wonder how I am going to feed the family." Maize, Zimbabwe's main staple crop, does not take droughts kindly.

Due to a lack of access to irrigation facilities, small-scale farmers like Chari and Mazwi are at the mercy of the increasingly unpredictable weather.

The meteorological services have warned of below-normal rainfall due to the impact of El Nino, a phenomenon that warms parts of the Pacific,

affecting weather patterns.

Zimbabwe's main rainfall season normally runs from October to March, but due to El Nino, it was delayed by about five weeks, subjecting early planted crops to moisture stress.

The situation was further exacerbated by the ongoing dry spell. The World Food Program (WFP) warned last Tuesday that more people in Zimbabwe will likely require emergency food aid during the lean season when rural households face grain shortages while waiting for the harvest.

The government, in its latest livelihood

assessment, said about 2.7 million people in rural areas, out of the country's total population of 16 million, face food insecurity in the current lean season, which typically starts in October and reaches its peak between January and March.

Farai Mawarire, another farmer from Beatrice, said the dry spell caught many farmers unprepared, adding that farmers need to consider drought-resistant crops such as traditional small grains. "In the previous years, we would harvest with no challenges, so we never considered drought-resistant crops such as millet or sorghum. We

have learned a lesson, and in the following seasons we will adopt drought-resistant crops," he told Xinhua.

While Mawarire's maize crop is now a write-off, his fallback is on groundnuts. "Of all the crops that we cultivated, only groundnuts are promising," he said. "If we receive rains, even once, they will mature. That's our only hope for a harvest."

Meanwhile, Gilbert Mukatyei, another farmer, confronted the drought with climate-smart agricultural practices such as deep plowing, mulching and adopting early maturing crop varieties.

"Besides the deep plowing, we are also applying manure. We are also irrigating, and we are going to increase the number of boreholes this year. We also want to go solar (as a power source for irrigation)," he told Xinhua.

"We have plenty of sunshine here. We need to make use of it." The effects of the drought are being felt in other sectors of Zimbabwe's economy as well. Tobacco, one of the highest foreign currency earners for the country, has also been affected by the dry spell, and slightly reduced yields are expected.

The tourism sector has not been spared either. At least 100 elephants died in Hwange National Park, Zimbabwe's largest game reserve, due to the drought late last year, according to the International Fund for Animal Welfare.

Finance Minister Mthuli Ncube has projected that Zimbabwe's 2024 economic growth rate will slow to 3.5 percent, down from 5.3 percent in 2023, partly due to the expected impact of El Nino.

'Claims about Russian calls for coup d'etat in Armenia baseless'

MOSCOW

REMARKS by Armenian Prime Minister Nikol Pashinyan about Russia purportedly calling for a coup d'etat in the republic are absolutely unfounded, Russian Foreign Ministry Spokeswoman Maria Zakharova said at a briefing.

"The grievances by Armenian prime min-

ister that you mentioned are absolutely baseless," the diplomat said addressing a reporter. "Russian officials have never allowed for even a hint of calling for overthrowing legitimately elected authorities anywhere at all," she added.

The diplomat said that the Russian side is using the same approach "both with regard to the current authorities in Yerevan and the previous authorities in Yerevan and in general, with regard to any sovereign country.'

"A logical question emerges - those who are in power in Yerevan now, do they follow the same logic with regard to other countries or their own domestic political process? It seems to me that it's a good idea to discuss the subject, we all remember recent history, something that happened a couple of years ago," the diplomat concluded.

Earlier, Pashinyan in an interview with France 24, claimed that in the fall of last year, Russian officials called to overthrow government authorities in Armenia.

India, US review counter-terrorism cooperation, reaffirm commitment to boost people-to-people ties

NEW DELHI

INDIA and the United States on Wednesday reviewed ongoing cooperation in counter-terrorism and security domains in a daylong Homeland Security Dialogue (HSD), discussing steps to bolster bilateral efforts to combat terrorism and reaffirming their commitment to strengthen the vibrant people-to-people ties between the two countries by taking steps to enable safe and legal migration.

The India-US Senior Officials' Homeland Security Dialogue (HSD) was held here in New Delhi.

Ajay Bhalla, Home Secretary, Ministry of Home Affairs, Government of India and Kristie Canegallo, Acting Deputy Secretary, US Department of Homeland Security, led the respective delegations.

"During the dialogue, both sides reviewed ongoing cooperation in counter-terrorism and security domains, which has been a key pillar of the India-US strategic partnership," the Ministry of Home Affairs (MHA) said in a statement.

In this context, the MHA statement mentioned, "They (the officials) discussed steps that can be taken to bolster bilateral efforts to combat terrorism and violent extremism, drug trafficking, organised crime and ensure transportation security."

"They also reaffirmed their commitment to strengthening the vibrant people-to-people ties between the two countries, by taking steps to enable safe and legal migration, counter illegal migration, human trafficking, money laundering, cybercrimes, and misuse of the cyber domain for illegal activities, including terror financing," it

The co-chairs reiterated their keen interest in consolidating the mutually beneficial collaboration between the respective law enforcement agencies through the exchange of information, capacity building, technical assistance and regular meetings of sub-groups set up under the framework of the Homeland Security Dialogue.

Palestinian president urges Arab League's push for obtaining UN full membership

CAIRO

PALESTINIAN President Mahmoud Abbas on Wednesday called on the Arab League (AL) to support Palestine in obtaining full membership in the United Nations (UN), the AL statement said.

The Palestinians currently have non-member observer state status at the UN. AL's Secretary-General Ahmed Aboul Gheit received a written message from Abbas, calling for an international conference to adopt a comprehensive peace plan with international guarantees and a timeline for the implementation of ending the Israeli occupation of Palestinian territories.

The Palestinian president voiced "categorical Palestinian rejection" of the Israeli prime minister's postwar plan for Gaza.

On Feb. 23, Israeli Prime Minister Benjamin Netanyahu presented his first official "day after" plan for the Gaza Strip once the war ends, saying Israel will keep security control over Palestinian areas and make reconstruction based on de-

militarization.

Abbas warned about the danger of the plan's principles, especially in terms of denying the existence of the Palestinian people and insisting on imposing Israeli sover-

eignty over the entire land extending from the Mediterranean to the Jordan River.

The plan showed the intentions of the Israeli government to re-colonize the Gaza Strip and entrench

the occupation in the West Bank and East Jerusalem through building thousands of settlement units, Abbas said.

"The Palestinian Authority is ready to take necessary steps to assume governance responsibilities in the Gaza Strip, the West Bank, and East Jerusalem," Abbas said in his message.

He urged the AL to continue working to achieve a ceasefire, the complete withdrawal of Israeli forces from the Gaza Strip, the delivery of humanitarian aid, and the return of the displaced to their homes in the north of the territory.

Meanwhile, Aboul Gheit reaffirmed his commitment to working to achieve the objectives outlined in Abbas's letter, especially an immediate cessation of hostilities, the urgent and sustainable delivery of aid, and a firm rejection of the plan for displacement.

"Halting the brutal war remains a top priority for the AL and its member states," Aboul Gheit reit-

China makes breakthrough in brain-computer interface technology

YANG, wearing an air-filled glove on his right hand, firmly held a cup, lifted it, took a sip and put it back down. This simple action, which most people take for granted, is a miraculous feat for Yang, as he has been bedridden for 14 years due to a car accident that left him paralyzed.

The technology that enabled him to go from paralysis to being able to "drink water with his mind" is called braincomputer interface (BCI) technology.

On Jan. 29, Professor Zhao Guoguang's team from Xuanwu Hospital affiliated to Capital Medical University and Professor Hong Bo's team from the School of Medicine, Tsinghua University announced a groundbreaking advancement in the treatment of quadriplegia caused by cervical spinal cord injury using an implanted BCI with epidural electrode. The patient in this case was exactly Yang, who underwent the BCI surgery in October last vear.

BCI typically refers to the use of devices to capture electrical activity inside the brain and create a direct communication pathway, allowing signals to connect the brain with a computer and thus enabling "mind control of computers."

Technically, to make Yang's right hand move again despite his quadriplegia, it takes a three-step process.

The first step was to find a suitable "landing point" for the BCI processor.

On Oct. 24, 2023, the two teams successfully completed the first clinical implantation trial of a wireless BCI processor called Neural Electronic Opportunity (NEO).

Specifically, two coin-sized BCI processors were implanted into Yang's skull by a neurosurgeon, enabling the successful collection of neural signals from the motor cortex.

"These two processors each have four contact points, totaling eight, placed on the motor cortex of Yang's brain that controls his right hand," said Zhao.

"How did we locate this area? Before the surgery, we used functional magnetic resonance imaging to determine the activation area of the brain, which allowed us to find it," he explained.

This was not easy at all. Zhao gave an analogy, saying, "It's like walking into a soccer stadium with 30,000 to 40,000 spectators all cheering at the same time, and we have to detect what two people in the 80th row of the south stand are saying. Moreover, the brain has not just thousands, but millions of cells, so you can imagine the difficulty."

In the second step, after the area was determined, the appropriate technique was chosen to implant the device into the brain.

How was the BCI processor implanted? The Chinese teams achieved two major breakthroughs in wireless minimally invasive proce-

On one hand, they implanted the NEO within the skull, with the electrodes covering the outer layer of the dura mater, ensuring the quality of intracranial signals without damaging the neural tissues. On the other hand, they utilized near-field wireless power supply and signal transmission, eliminating the need for batteries in the implanted intracranial device.

The third step was to "decode" the brain signals into computer language.

Ten days after a successful

surgery, Yang was discharged from the hospital and returned home. When using the system at home, the external device needed to be placed over the scalp to provide power to the implanted device and receive the neural signals from the brain. These signals were then transmitted to a computer or smart phone, ultimately enabling communication through the BCI.

"We encountered countless millisecond-level electrical signals, and without analyzing them, we would have no idea what they represented. Therefore, decoding is crucial," said

"What do we decode them into? We decode them into a code that computers understand, which is 0 and 1. Once decoded, they could be transformed into various real-life scenarios, such as controlling an air-filled glove to grasp

objects, operating an electric wheelchair, or even turning on and off a television. All these actions can be controlled through the power of thought," Zhao explained.

After three months of rehabilitation at home, Yang is now able to use his brain activity to control the air-filled glove, which enables him to independently drink water and make other movements. Moreover, his accuracy in grasping objects has exceeded 90 percent.

"We are especially grateful to Yang, who was the first to try this groundbreaking technology. It demonstrated his strong vitality and desire for recovery," said Zhao.

"Thanks to the BCI technology, Yang has shown significant improvement within three months. This is not only inspiring for patients and their families, but also for medical

staff, engineering technicians, and equipment manufacturers, motivating us to explore more unknown territories," Zhao told People's Daily.

The concept of BCI has been around for 50 years. In recent years, research in this field has become a hot pursuit for countries worldwide.

The future applications of BCI technology are incredibly diverse. By recording and interpreting brain signals, it enables direct communication between the brain and computers. This technology not only holds the potential to aid in the rehabilitation of patients with brain disorders such as ALS, spinal cord injuries, and epilepsy, but also has the possibility to achieve brain-computer fusion intelligence and expand the capabilities of human brain in information processing.

Mbappe no longer untouchable as PSG prepare Champions League return

PARIS

KYLIAN Mbappe will face former club Monaco for the final time as a Paris Saint-Germain player today, provided coach Luis Enrique selects his star player.

The France captain's relationship with the PSG boss has come under the spotlight with Mbappe discovering he is no longer assured of a place in the line-up since telling the Qatar-owned club he would leave at the end of this season.

Mbappe informed PSG in mid-February that he intended to depart when his contract expires in June, after seven years at the Parc des Princes, with Real Madrid his likely next destination.

Luis Enrique responded to that by leaving the 25-year-old on the bench for their next game at Nantes, although Mbappe came on to score a penalty in a 2-0 win.

More surprisingly, Mbappe started last week's home meeting with Rennes and wore the captain's armband in the absence of Marquinhos, but was substituted on 65 minutes.

Trailing 1-0 at the time, PSG came back to draw thanks to a penalty won and converted by his replacement, Goncalo Ramos.

PSG's all-time top scorer with 244 goals, Mbappe has rarely started on the bench in 292 appearances since signing from Monaco in 2017.

He has occasionally been substituted earlier than was the case last weekend, but always either due to injury or with PSG already winning.

"It's very simple. Sooner or later, when it happens, we are going to have to get used to playing without Kylian," Luis Enrique said when asked to explain why he had taken Mbappe off. "When I want to play him I will do so, and if I don't want to, the same thing."

PSG have to prepare for the future, and their position of strength in Ligue 1 allows them to do so -- despite drawing against Rennes, Luis Enrique's team are 11 points clear of second-placed Brest with 11 games remaining.

Perhaps there could even be a temptation to rest Mbappe in Monaco, given that Paris go to Spain defending a 2-0 lead into the second leg of their Champions League last-16 tie against Real Sociedad next Tuesday.

They have been knocked out in the last 16 in five of the last seven seasons and reaching the quarter-finals this year is the minimum objective in Europe for the French champions.

Yet Mbappe will want to play in Monaco, who are themselves chasing Champions League qualification and are third in the table.

It was in the principality where he emerged as such a thrilling talent and starred as Monaco won the title in 2016/17. His impending move abroad means he may not get a chance to return to the Stade Louis II again any time soon.

SIMONE Inzaghi could barely contain his glee on Wednesday night as his Inter Milan put four goals past Atalanta and took another step towards a 20th Serie A title.

Usually happy to trot out the usual post-match cliches with a stern expression, Inzaghi had to try his very hardest not to let a huge grin spread across his face as TV pundits on DAZN praise on a team they classed as "unplayable" for the rest of Italy's top flight.

Wednesday's emphatic 4-0 win at the San Siro moved Inter 12 points clear of closest rivals Juventus, who are now trailing in the distance after leading the pack little over a month ago.

On Monday night Inter face Genoa on a run of 11 straight wins in all competitions since the turn of the year, their last four in the league coming with four goals.

Inzaghi is closing in on the first league title of his managerial career after narrowly losing last season's Champions League final to Manchester City.

"The team is playing really well but I've been enjoying watching them for two-and-a-half years because we've won five trophies and got to a Champions League final" said Inzaghi.

"I have a team which sticks to its principles regardless of who plays. That had to be the most satisfying thing... whoever comes on it's a pleasure to watch them play. Sometimes I find it hard to pick the team."

Inter have the league's top scorer in Lautaro Martinez and have scored 67 times -- more than any team in Europe's top five leagues.

Fans spent the last few minutes of Wednesday's match belting out 'Ole' to their team's every touch as Inter netted four goals without reply for the third straight league match.

Man Utd and Liverpool to meet in FA Cup quarter-finals, Chelsea survive

LONDON

ANCHESTER United will host Liverpool in an FA Cup quarter-final block-buster after the bitter rivals took contrasting routes to their fifth round victories on Wednesday.

United eased the pressure on beleaguered boss Erik ten Hag as they scraped through with a 1-0 win at Nottingham Forest thanks to Casemiro's late goal.

Fresh from their League Cup final triumph against Chelsea on Sunday, Liverpool relied on their youngsters again in a 3-0 win against second tier Southampton at Anfield.

Chelsea bounced back from their painful 1-0 defeat to Liverpool at Wembley, snatching a 3-2 win against Championship promotion chasers Leeds to book a last eight date with Leicester.

After Liverpool's ball boys paraded the League Cup around Anfield prior to kick-off, Jurgen Klopp's kids gave another glimpse into a bright future as two of their young guns inspired the win.

With Liverpool ravaged by injuries to Mohamed Salah, Darwin Nunez, Diogo Jota and Alisson Becker among others, Lewis Koumas, the son of former Wales and West Brom midfielder Jason Koumas, marked his debut with the opening goal in the 44th minute.

The 18-year-old forward drilled a fierce low drive that deflected in off Southampton's Jack Stephens.

Jayden Danns, another 18-year-old offspring of a former player -- his father Neil starred for Crystal Palace -- netted Liverpool's second in the 73rd minute with a composed finish that belied his tender age.

James McConnell, 19, and Bobby Clark, 19, also impressed for Liverpool, who introduced 16-year-old Trey Nyoni to become their youngest ever FA Cup player in the second half.

Danns capped the victory in the 88th minute when he lashed home in front of The Kop.

"We don't take these things for granted," Klopp said of facing United.

At the City Ground, United reached the FA Cup quarter-finals for a record

Ten Hag insisted this week that he doesn't need a public vote of confidence from Jim Ratcliffe after the British billionaire took charge of United's football operations.

But United are languishing in sixth place in the Premier League, eight points adrift of the top four, after Saturday's shock 2-1 home defeat against Fulham.

A loss to Forest would have been a major blow for Ten Hag after Rat-

cliffe was linked with a move for former Real Madrid boss Zinedine Zidane.

The FA Cup represents United's last silverware chance this term and, after missing a host of chances, they finally hit the target in the 89th minute when Bruno Fernandes' free-kick was headed in by Casemiro.

Ten Hag will hope a 1-0 FA Cup win at Forest proves a launchpad for sustained success at United in the same way it did for former boss Alex Ferguson in 1990.

"It's the best time to score at the end. On Saturday we felt the defeat in stoppage-time. What they showed today is great," Ten Hag said.

At Stamford Bridge, Mauricio Pochettino will have felt similar relief to Ten Hag.

With the pressure mounting in his troubled first season in charge, the Argentine was indebted to Conor Gallagher for a late winner.

It was the first FA Cup tie between

Chelsea and Leeds since the Blues won the 1970 FA Cup final replay, a booking-filled clash regarded as one of the most vicious matches in English football history.

Mateo Joseph put Leeds ahead before Nicolas Jackson and Mykhailo Mudryk netted to give Chelsea the lead.

Joseph scored again but Gallagher won it in the 90th minute.

"In the context of the week, I'm happy. The performance wasn't great but of course it's about building our confidence again," Pochettino said.

Elsewhere, Wolves beat Brighton 1-0 at Molineux, with Mario Lemina's goal after just 77 seconds securing a home tie against second tier Coventry.

Holders Manchester City, who beat Luton 6-2 on Tuesday, will host Newcastle in the other quarter-final.

"You saw that Forest were targeting him," said Ten Hag. "It was a serious injury and then I see they criticise him, it is pathetic, it can't be. He has a serious injury and he continued to play on Saturday and fought to be part of this game.

"He has a very high pain threshold. He did something similar in the semi-final last year and that shows his character and that shows as a leader and flows into the team. There were many fouls on him. You "Se

"In the last six months, I have sent my resignation letter to the committee eleven times but they say no,

The gaffer insisted: "My future is in the hands of the two presidents but in front of God my conscience is clear because I am working hard every second, every day. My experience, energy, emotions I give for this club, city, region."

He disclosed: "I am always ready to work. I give new ideas to the committee, what is good for us, what is important and good to improve a profes-

He added: "Maybe nobody listens to me. Maybe somebody will say I am stupid because I know one guy said I am stupid 'mzungu'."
