Ngarash overwhelmed as body lands in ATCL plane

N Air Tanzania Co. Ltd (ATCL) plane 5H-TGF carrying the mortal remains of former prime minister Edward Lowassa, arrived towards midday yesterday, followed by a military procession from KIA to Monduli, a trip of over 100km.

Thousands of mourners lined up on both sides of the road along the Moshi- Arusha highway from the moment it touched at the Kilimanjaro International Airport (KIA) at around 11:20 am to a vast sombre mood, gripping multitudes of mourners who thronged the airport to witness the arrival

Many mourners were waving their hands to the military occupants of the vehicle carrying the casket of the fallen ex-premier, until arrival at his home village of Ngarash, to lie in state at the family compound until formal burial ceremonies are conducted later tomorrow.

At King'ori and Usa-river, outlying areas to Arusha city, thousands of people were

Samia visit ends with MoU on food security

Evaluate deeply, Ps urge

A SECTION of the legislature has demanded an in-depth evaluation of the secondary education quality improvement program (SEQUIP) after an audit showed shortfalls in its implementation.

Naghenjwa Kaboyoka (Special Seats, Chadema) the chairperson of the Public Accounts Committee (PAC) of the National Assembly issued this demand yesterday, when tabling the committee's performance report for 2023.

She said that the audit showed various shortfalls including flops in procurement, finance management, human resource management and other issues, urging that the project be handed to qualified experts, unlike at present.

SEQUIP, funded by the International Development Association (IDA), a soft loan window of the World Bank, is designed to increase access to secondary education, provide responsive learning environments for girls, and improve completion of quality secondary education for girls and boys.

When it was rolled out, it was designed to benefit about 6.5m pupils evenly divided between girls, at 3.2m and boys at 3.3m, the report noted, affirming that identifying ar-

Fall armyworms variant destroying potato farms

OVER 2500 acres of potato farms in six wards of Makete District in Njombe Region have been destroyed by a variant of fall army-

Farmers in the areas say that the pests look like fall armyworms, are systematically destructive and

We will not leave here without coming up with a formula for robust measures to eradicate these pests

there is no pesticide which is so far helpful in controlling them.

Ackson Mbogela, a farmer, said the pests eat crop leaves and flow-

ers just as they also eat potatoes like fall armyworms do in grain crops. The rather unfamiliar species of invasive pests threatens the harvests and incomes of the farmers, he stated.

"When you pass in the destroyed farms what you find is only roots," he said, noting that this situation is hugely scaring as farmers have

spent a lot to grow potatoes and they now we worry they may get nothing at harvest time.

Akim Aloyce, another farmer, appealed for urgent support from the relevant authorities to find ways to overcome the challenge as farmers

Samia visit ends with MoU on food security

the state of the bilateral relations, airing expectations that the visit will pave the way for even closer links.

The visit was timed with marking 50 years of collaboration in agriculture, which contributed to the formulation policy orientations in the sector over the period. President Samia was accompanied by five cabinet ministers, senior government officials and leaders of the local business community.

The visit arose from an invitation by King Harald V and Queen Sonja, also marking 60 years of diplomatic relations with the north European social democratic monarchy. The statement affirmed that the visit demonstrates the shared enduring commitment to advance and diversify longterm friendship and cooperation. Sixty years of cooperation and shared experiences have forged strong bonds between the two countries and peoples, it emphasised.

The two countries agreed to leverage attention to enhancing trade and business cooperation, expressing satisfaction with the holding of the Tanzania-Norway business forum, meeting for the first time during the

The two leaders shared concerns about the global geopolitical situation, with increased tensions and armed conflict, its impact on global supply chains and commodity prices, with grave consequences for developing countries.

have tried all they could to control the pests without success.

William Makufwe, the district executive director, listed affected wards as Ikuwo, Kigala, Itundu, Mlondwe, Matamba and Kinyika. Experts have started to visit areas that are yet to be affected to take measures advised by experts to check the dreaded invasion by the dreaded

He said that farmers all over the district need to focus on such measure, noting that initial evaluation has indicated that over 2500 hectares had been destroyed by the pests.

The government was investigating ecological factors associated with this outbreak, he said, noting that as the insects are not familiar, experts need to study them for a while and advise on the measures to take.

Already a team of experts from the

(TARI) Uyole campus in Mbeya Region have arrived in the district ready to commence investigations on anatomy of the pests and figure out how to control them, he stated.

Dr Dora Mende, the lead researcher, said investigations will help to map out their physical attributes and feeding habits, essential to identifying workable pesticides to control the pests.

Tanzania Agriculture Research Institute ing up with a formula for robust measures to eradicate these pests," she said.

Anincent Ndunguru, head of the district agriculture and fisheries unit, said that they have started to supply some pesticides issued by the Tanzania Plant

Health and Pesticide Authority (TPHPA). Agricultural officers in villages and wards work with the farmers on the task, and most of the area invaded by the pests had already been sprayed, the official af-

Out of the lot, 24 secondary schools visited by the technical evaluation team had no title deeds, she said, similarly pointing at the failure to prepare ownership documents due to the undue hurry in implementing

the building of secondary schools. "Thus, the projects did not have a title until the time of the technical inspection, placing the school areas at the risk of land conflicts. There is a lack of evidence of legal ownership of the relevant land," she said.

The audit showed that 19 construction sites, out of the 24 visited, had not been measured and a land map prepared to determine the actual size of those sites, she

This situation arose from the district council not prioritizing land surveying before acquiring land and starting construction works, she said, pointing out gaps in building schools in Lushoto, Ikungi and Tunduma districts with conflicting infrastructure space and loca-

"The audit indicated that 470m/- was allocated for the construction of each secondary school, but a review of project documents and construction payment vouchers for the 24 secondary schools visited indicated that only three were properly accounted for," she further noted. The lack of some drawings and detailed information contributed to shortcomings in the implementation of the SEQUIP project, like the non-construction of gas systems in the laboratories, owing to the lack of drawings for those systems, she said. The audit affirmed that the Ministry of Education, Science and Technology was late in completing the hiring process of an independent project auditor by not including this element in its procurement plan for fiscal 2020/21, she

The delay in the procurement of an independent project auditor arose from the lack of qualified bidders, compelling repeat of the advert for the procurement of an independent project auditor.

"Failure to comply with the agreement made between IDA and the government of Tanzania may result in the termination of the loan," the committee leader cautioned.

The technical teams to evaluate the projects were formed by teachers and village or hamlet officials in areas where the project was implemented. Due to the lack of people with expertise in construction, the daily tasks were managed by teachers, thus failing to identify technical errors in carrying out the school building work, she added.

Speaker terms lack of toilets as an 'unhealthy' discussion

SPEAKER of the National Assembly Dr Tulia Ackson has asked the government to end lack of toilets in health and education sectors, saying it is not healthy to discuss the matter in parliament.

She made the call yesterday in the National Assembly after some MPs wanted to know the government's strategy to end the problem in their constituen-

"It is not healthy to hear MPs complaining on the issue of toilets here. We should not be here discussing lack of toilets in schools, dispensaries and health centres because the challenge can be completely ended in one year if we are serious," she said.

She said the government implements a number of mega projects and that the issue of toilets in public institutions was a very minor issue.

Joseph Tadayo, (Mwanga) said Lang'ata health centre in the constituency has no latrines

because those that have been there for over 40 years are full hence filthy and cannot be used.

"This is distressing, it is not important for the government to set aside even 100m/- to construct toilets in our health centres and schools; remember that the country works hard to overcome diseases and our environment is like this," he said.

Deputy Minister in the President's Office (Regional Administration and Local Governments) Dr Festo Dugange said the government had already instructed Mwanga District Executive Director to ensure that there is no health facility which lacks toilets.

"I instruct again the DED to allocate emergency funds from internal revenues to facilitate construction of toilets in all health facilities," he said.

In his basic question, Tadayo asked when the government will send funds for the rehabilitation of Lang'ata health centre in Mwanga.

Responding, Dr Dugange said the government has already conducted an assessment of old and dilapidated health centres which need renovation.

"So far, a total of 202 dilapidated health centres have been identified for renovation including Lang'ata health centre whereby budget for the work will be allocated in phases," he explained.

The deputy minister said apart from the health centres, there are 50 district hospitals which were also assessed and 38 of them were given a total of 34.2bn/- for rehabilitation in 2022/23 and 2023/24 financial

Minister for Education, Science and Technology Prof Adolf Mkenda said the government has started to collect information from schools in order to assess toilet challenges in the country.

This came after the government came across a video clip that went viral on social media showing a school in Chato District, Geita Region with 1500 pupils who release themselves in nearby bushes.

He said that public and private sector leaders, development stakeholders and the general public should come up with strategies to promote cooperation and invest in the infrastructure of Information and communication technologies (ICT) to increasing digital and financial inclusion.

The premier called on mobile

phone companies to set reasonable communication costs to attract more subscribers, including women so that they can fully participate in the digital economy.

He also asked the private sector stakeholders to use platforms like Future Ready Summit to prepare programmes to empower women and youth so that they can participate in contributing to the national economy.

"Use this opportunity well, cooperate with facilitators for productive discussions so that the training is productive as expected," he said.

Majaliwa said the government is implementing a project to build 26 national secondary schools for girls specifically for science studies as part of a strategy to encourage female students to love science. The premier said that the schools are being built in all regions at a cost of 104bn/- with each school costing 4bn/-.

"In this, I really commend President Samia Suluhu Hassan who leads in promoting science, technology and mathematics. This is due to her will and the deliberate steps she took to ensure that girls participate fully in opportunities for science and mathematics studies," he said.



RC closes dam as cholera cases surge in Shinyanga

SHINYANGA Regional Christina Commissioner Mndeme as ordered closure a dam after people used its water and fell ill of cholera, leading to the surge of the number of patients in the region.

Speaking while opening primary health services committee meeting to discuss preparation for national vaccination campaign against measles rubella, nutrition assessment and cholera trends here on Wednesday, she said a total of 11 new patients were confirmed in Kishapu District on Tuesday this week after they used unclean water they drew from Songwa Dam.

"The number of patients in our region now stands at 192 and six deaths," she said. "I have ordered the clo-

sure of the dam with immediate effect."

the region to effectively utilise funds meant for nutrition to address stunting in children.

She said there are financial challenges in the implementation of nutrition interventions, including funds not being released on time.

She appealed that funds be released on time and not being directed to other activities so that the initiatives can be executed successfully.

"Despite the fact that our region's stunting rate in children under the age of five has decreased from 32 percent in 2018 to 27 percent in 2022, we still have a high stunting rate compared to national average of 20 percent. We have to reduce it to less than 20 percent," she said.

The RC also asked district nutrition officers to educate parents on the importance of feeding their children a balanced diet to combat stunting.

Dispensary gets cervical cancer treatment tools

THE Tanzania Health Promotion Support (THPS) and Centres for Disease Control and Prevention (CDC) have handed over a renovated care and treatment unit as well as facilities worth 660m/- to Mwendapole Dispensary in Kibaha District, Coast Region to support cervical cancer treatment to patients who are at child bearing stage.

It is a five-year (2021-2026) project dubbed 'Afya Hatua Project' funded by the US President's Emergency Plan for Aids Relief (PEPFAR) and aimed at undertaking screening and prevention of cervical cancer to more than 485,000 women in the region.

Speaking at the handing over event yesterday Coast Regional Administrative Secretary Rashid Mchatta commended THPS and CDC for their support that he said saves lives in the region.

"I appreciate the role played by THPS and CDC through generous support towards Aids control and this new initiatives that will save lives," he said.

"Let me assure CDC and THPS that the regional leadership and the government as a whole recognise your contribution to the fight against HIV/Aids and cancer."

Dr. Ann Buff, CDC associate director for data and science said cervical cancer is the most common cancer in the country with nearly 10,000 new cases and 7,000 deaths each year.

"The good news is that cervical cancer is preventable. It is caused by infection with human papillomavirus (HPV). We can prevent HPV infection and cervical cancer with the HPV vaccine." she said.

According to her, they demonstrated the feasibility of large-scale routine HPV vaccination in Tanzania and created critical national momentum, adding that in 2023, the government of Tanzania updated its vaccination guidelines to a single dose of HPV vaccine and expanded eligibility to all girls aged between nine and 14 years.

She hailed the collaboration and partnership that exists between the government and CDC which she said will contribute to the significant reduction of cancer prevalence rate in the country, which currently stands at 3.1 percent.

"Increased collaboration and partnership for cervical cancer care and prevention, along with support from the government of Tanzania will reduce cancer morbidity and mortality in Tanzania," she said.

George Anatory, THPS acting executive director said THPS is committed to continue complementing governments' efforts in ensuring that all Tanzanians have access to quality healthcare and contribute actively to the country's socioeconomic development.

"We trust that the support we have provided will help to improve efficiency and ensure quality service delivery of comprehensive HIV prevention, care and treatment services and cervical cancer screening and prevention, leading to saved lives in the region", he said.

The handed items are five thermocoagulation and six cryotherapy machines that will be distributed to eleven dispensaries to help increase treatment rate of identified early-stage cervical lesions within the region.

The list also includes 125 modern tablets that will be used in 85 health facilities in the region to improve documentation and bi-directional referral mechanisms

between health facilities and the community. THPS has supported the region with office furniture that includes modern chairs and tables, drug storage cabinets, file cabinets and benches to be used by clients visiting the health facilities.

Bank partner with ZHC to offer mortgage financing

"Let me congratulate ZHC's management for coming forward to partner with us in offering this new facility which targets to serve ordinary people," said Lohay.

He pointed out that as one of the pioneers in offering mortgage financing in the country, Azania Bank has also been targeting millions of ordinary people in improving their family housing units in both the mainland and the isles.

"We have enough experience in offering housing financing at affordable rate of not more than 14 percent compared to others in the market with a repayment schedule of up to

Empty stomaches fuel unrest, warns UN chief

NEW YORK

IN a stark warning, the United Nations chief said on Tuesday that the combined impact of climate chaos and food crises are increasing threats to global peace.

Speaking at the UN Security Council in New York, Antonio Guterres said climate disasters have a negative impact on food production which kindles social unrest.

"A global food crisis is creating a hellscape of anger and heartache for many of the world's poorest people. And the climate crisis is accelerating with the deadly force, and last year was the hottest ever." "Both of these facts undermine peace. Empty bellies fuel unrest. In Por-

'In a house with no bread, everyone argues and no one is right," he said.

Guterres urged the UN Security Council to address the impact of food shortages and rising prices on international peace and security, saying climate and conflict are the two leading drivers of the global food crises.

"In Gaza, no one has enough to eat. Of the 700,000 hungriest people in the worlds, four in five inhabit that tiny strip of land," he said.

"In many places, climate disasters add another dimension. Every one of the 14 countries most at risk from climate change are suffering conflicts; 13 of them faced humanitarian crises this year."

Kenya relocates 21 black rhinos to new sanctuary

NAIROBI

TBS drills food processors on how to remove contaminants

THE Tanzania Bureau of Standards (TBS) has asked flour millers and peanut butter makers to strengthen their safety systems to protect consumers against fungal and toxin contaminants.

TBS director general Dr Athumani Ngenya made the call in Dar es Salaam yesterday while opening a training session for stakeholders processing maize flour, mixed flour and peanut butter.

He said food is a necessary human need that plays important role in people's prosperity and development, making its safety and quality very important not only to individuals but also communities and the country as a whole.

"If food is not safe, it causes health complications and even death and the two affect the economy," he said.

Dr Nyenya said the government's aim is to build a strong and sustainable economy which is competitive by attracting investments and improving the business environment.

"Food safety must be ensured in our country for us to achieve these goals," he said.

He said that in supporting all plans and efforts made by the government, TBS is responsible for ensuring that food and other products produced in the country and those imported from abroad meet the set standards.

"We all realize that products made from grains, especially flour and peanut products, are the the foods that are widely used in the country and that means if they do not meet standards, they can cause health and economic harm," he

Baraka Nyirenda, a flour miller from Songwe Region, said the training was of help

to participants as it focused on quality which if improved can enable processors expand local market and even penetrate regional or international market.

"This is an opportunity for us to increase quality of our products and my take home is that if a product is tested by TBS and meets the set standards, it can be sold in any market in the world," he said.

Janeth Mashauri who makes peanut butter said that the training took them through how to avoid fungal and toxin contaminants that can not only affect health of consumers but also destroy reputation and the business itself.

"I strongly advise all producers of flour and peanut butter to attend trainings like this because since the awareness helps a lot in improve quality which is number one requirement for a product to penetrate international market," she said.

ment reporting to the legislature as stakeholders for various corporate entities stifled in their activities by delays in value added tax (VAT) refunds by the Tanzania Revenue Authority (TRA) had plenty to say on the issue in a recent committee report.

They said that the non-refunding had for two years running adversely affected efficiency in claimant companies, often subsidiaries of state firms not fully charged with the direct conduct of commerce in the

How far that consideration is part of the non-refunding of the dues is one thing but it is also apparent that as state entities themselves, TRA risks no legal action on this.

A report compiled by the legislative body's Public Investments Committee cited the dues as those claimed by Stamigold, subsidiary of the State Mining Corporation(Stamico) at 12.30bn/-; Gasco, a subsidiary of the Tanzania Petroleum Development Corporation at 3.01bn/-; and the Electrical Transmission and Distributions Constructions and Maintenance Co. Ltd (ETDCO) at 563m/-, a subisidiary of the state electricity monopoly, Tanesco. It is really unclear who really is complaining: the subsidiaries or the mother firms.

A range of Tanzania's development partners, including the Millennium Challenge Corporation, wish for markets being sharpened for better results. However, the reflex of economic administrators lies elsewhere.

There is a BRICS-like attitude where state monopolies are left in place, and they form trading units to avoid having to work with the private sector in a transparent man-

collusion was possible, when it was curbed, they reabsorb the task.

It is possible, as the parliamentary committee apparently believes, that there is just procrastination on the part of TRA to have not met the VAT refund claims.

When a company has 15.9bn/held somewhere for a whole two years, it definitely will stretch out its working capital capacities. However, citing revenues collected through tax and dividends, the committee report affirmed that the government was not the big loser.

When Stamigold is said to be operating under negative capital of up to 11.7bn/- and it is still afloat, the key issue isn't that TRA fast-tracks the refunds to stabilise its liquidity.

The more significant point is if the Treasury in liaison with its core operational agency, TRA, knows the threshold capital for the subsidiaries to operate, or tasks the mother company to increase the capital base or working capital. In that sense, the refund claims being withheld are an indirect dividend.

The committee's report was emphatic that the Value Added Tax Act, 2014 requires that TRA makes refunds to taxpayers within three months - and at most 12 months after claims are filed. That would imply that TRA isn't observing the law in its handling of these subsidiaries' claims. Yet ETDCO, a Tanesco subsidiary set up in December 2014 to produce concrete poles, has not started production as it has not landed any allocation.

The 'sweetener' is that during the past ten years, Tanesco has been hiring ETDCO as an agent for procuring concrete poles from private manufacturers while the relevant operational framework stands undefined.



Is it last chance saloon? Myanmar junta imposes military conscription

MAE SOT, Thailand

he news travelled like wildfire. In the teashops, bars, and market stalls that make Thailand's border town of Mae Sot feel far more Burmese than Thai, the feared rumours circulating at the weekend were suddenly confirmed.

Military conscription would be imposed on young men and women for two to five years, regimebroadcasters controlled in Myanmar announced on the Saturday night airwaves. Details were sparse.

Panic scrolling through social media suddenly replaced conversation in one popular Mae Sot hangout run by a Burmese activistentrepreneur for his clientele of exiles, fugitives, and migrants. Pool players stopped mid-break. "What the ***!" exclaimed the member of a rock band.

Myanmar's junta has been at war with much of the country since staging a coup three years ago, but still, it has come as a serious shock that for the first time in modern history, the military will impose on young people the choice of two uniforms-army or prison.

Analysts-Burmese and foreign-interpreted the developments in various ways. For some, it was a clear sign that the military was losing this patchwork civil war and could not sustain itself. For decades, it had thrived on recruiting youngsters from poor areas of the Bamar-majority heartlands of Sagaing and Magwe. But now those same arid regions are hotbeds of resistance against the regime, its forces stretched across the length and breadth of almost the entire country, depending mostly on air power to bomb civilian areas into submission. "An act of desperation,"

Igor Blazevic said of the junta's move, which follows sizeable territorial losses and a meltdown of its forces in northern Shan State late last year. Blazevic, a Myan-

May slipped across the nearby border into Mae Sot with her family after spending two years as a refugee in a camp run by a section of the Karen National Liberation Army fighting what is known as the world's longest-running civil war dating back to 1949.

"I cannot go back to Myanmar," she said. At 19 years old, she fits the age range of

18 to 27 for single women to be conscripted. For men, it is 18 to 35 years, rising to 45for specialists like doctors and IT workers who quit their state sector posts in droves after the coup, joining the Civil Disobedience Movement (CDM) of nonviolent resistance.

On Sunday night in Mae Sot, large crowds of this latest wave of the Myanmar diaspora gathered for an outdoor CDM fund-raising concert, featuring dancing and music performed by several of the country's ethnic minorities, including Karen and Chin. The concert was sponsored by an online bank set up by the resistance. Stalls sold knick-knacks and garments, and beer and hot food were swiftly ferried about by teams of neatly dressed waiters.

May and her entrepreneurial family had their properties and businesses seized and sealed by the military near Mandalay and are now rebuilding their lives, running a small restaurant among the estimated 100,000 to 200,000 Burmese living in and around Mae Sot, setting up businesses, social services, and accommodation safe from predatory Thai officials and regime spies.

May remains determined to study medicine somewhere somehow, representative of a young, capable, and innovative generation of Burmese plugged into a digital world while moving in and out of the shadows of war.

Bo Kyi, a veteran activist and former prisoner who co-founded the Assistance Association of Political Prisoners in Mae Sot 24 years ago, saw the military's conscription order as a "huge challenge" for young people, especially those who had tried to keep out of politics and war. It would become very hard to leave the country legally now, he

"Millions will suffer and Burma will lose its human resources," he said.

Practical experience in respect of the law of dispute settlement agreement

DISPUTE occurs when one not yet referred the dispute party within a community or society feels or became aware of their rights and whether they are breached or jeopardized by action or inaction of other party.

Under normal circumstances, aggrieved party may not remain without remedy, hence, may opt to either initiate legal process or resolve dispute through court proceedings, mediation and other means available including court proceedings.

Once a dispute is resolved, without subjecting to court litigation, then it is legally advisable, to have in place settlement agreement drafted and signed between parties to the dispute contained agreeable terms and conditions

Nature of this document and its effect demands legal minds to be involved before executing the same. In this article, we shall point out some relevant issues, which we think, our readers should have some basic understanding.

What is settlement agreement?

We think, it is imperative to describe each word before combining the two legal words.. In our context, settlement refers to resolution of the dispute between parties. This can be done while parties have in court or when dispute is

Once both parties are amicably able to resolve a dispute between them, then agreement can be entered. Therefore, the word agreement is similarly to other agreement, in the sense that, the same should be secured where there is meeting of minds (consensus ad idem).

In view of the above settlement description, agreement refers to legally binding agreement when evidenced dispute between two or more parties is amicable resolved without going into trail or litigation.

Why Settlement agree-

As a matter of practice, settlement agreement is obtained through amicable understanding between the parties. Therefore, controller of the settlement proceedings are governed by the parties themselves

and not the court or other

judicial board.

In most cases, cost involved dealing with dispute is less, as compared to when the court of law is involved in its fullest. Time consume is less because legal procedural technicalities are not applicable, and parties are more relaxing when looking for solution of their dispute.

Settlement can be done



either through third parties, such as mediator or through parties in dispute. For example, commercial case can be filed at the High Court of Tanzania, Commercial Division at Court fees of 10m/- and can take more than year, until its judgment is delivered.

In most cases, prospect of the aggrieved parties to challenge the said decision through an appeal can take more than two years until the court delivers its ruling. Therefore, it is our firm opinion that, settlement agreement is more viable and practicable in this mercantile word.

Stage in which settlement agreement can be secured

agreement Settlement can be secured at different stages. One, it can be secured before parties opt to initiate legal proceedings. Here parties decided to resolve their dispute and having in place settlement agreement contained terms and conditions therein, in which parties at their own freely willing opt to comply the same, without subjecting dispute in court.

In the events, when parties breach what seems to be agreed between them, one may initiate legal proceedings in the court of law. We re- emphasize that, proper drafted terms and conditions can even assist parties for quickly secure court judgment under summary judgment.

While on other side, settlement agreement can also be secured while the case is pending in court of law or even after delivery of the judgment or at the appeal stage. One thing needs to be noted is that, regardless of anything, settlement agreement secured while the case is pending should have an enforcement of the court order.

We termed, out of court settlement agreement can be obtained during court case is in progress, but parties opt to have out of court settlement understanding. This can be done without judgment or during appeal being controlled by the court, it is by parties themselves whereas it end up being recorded in court. Settlement can be either full or part of the disputed amount.

How to enforce settlement agreement

Through practical experience, enforcement of settlement agreement can be done depending on three circumstances. One, if the same is secured before initiating legal proceedings, parties would smoothly comply with the agreeable terms, in case of non-compliance then the right and viable way, is for aggrieved part to file case in court for the purposes of obtained decree or any other remedy agreed between the parties.

Upon obtained court order, the same can be executed through available modes provided in our laws, as decree or order of the court.

Second, is settlement obtained before delivery of the judgment. Once both parties secured out of court settlement agreement and record in court, the court will deliver consent judgment and its decree. Execution of the decree extracted from consent judgment can be done through available modes of execution.

Lastly, is the settlement secured after delivery of the stage. It should be known, legally no dispute to settle at this stage but parties are at liberty to have in place settlement agreement on the decretal sum.

Parties are liberty either to settle whole decretal sum or part of it. Once this is done, then, either decree holder or judgment debtor, depending on circumstance may registered the same at execution court. Registration of either settlement is important because it informed the court on what has been done in respect of its decree failure of which then the said settlement agreement would not have enforcement of the law.

How to set aside a settlement agreement

As the matter of practice, settlement agreement does secure through full participation of each part to that agreement, therefore it is not easy to set aside or to challenge the same save for very exception circumstances.

Major grounds which courts do accept to set aside, is in the event where one can prove settlement agreement was fraudulent procured or in violation of the law, which goes to the merit of the said settlement. See case No. 449 of 2016 between Radvan Shercali versus Lilian Joseph Ogutu and two others.

Conclusion

Settlement agreement is among of the viable and practical way of resolving dispute between the parties. This trend is also adopted in criminal cases in which some of the offences can be settled through bargaining subject Director of the prosecution's consent hence settlement agreement and recorded the same in court.

We need to re-emphasize before commencement of settlement process resulted to the binding settlement agreement, it is always important to seek legal advice because various legal procedures are involved to make same to be enforceable in the eyes of the law.

Turning the tide against FGM: Survivors can be effective agents of transformation

IN the final push towards ending Female Genital Mutilation (FGM), we need to dig deep to cross the finish line.

The United Nations Population Fund (UNFPA) estimates that progress needs to be increased at least tenfold. The adoption by the General Assembly in 2022 of resolution 77/195, calling for the intensification of global efforts for the elimination of FGM, and in 2023 of resolution 78/188 on the girl child, urging States and other entities to ensure holistic support for girls who are at risk of or who have experienced FGM, are solid political commit-

More work is needed, however, to convert resolution into ac-

tion, and to scale up movements and interventions to abandon this practice.

Fortunately, we have the "know-how" and other tools needed to end FGM. Community engagement approaches, media tools, health education and involvement of influential members of society are positively linked with attitudinal changes towards abandonment of the practice.

Millions of women and girls, boys and men, religious and cultural leaders, and health workers have been engaging in and leading abandonment efforts in their communities. Such efforts have yielded results over the last 30 years: almost all countries where FGM was prevalent have outlawed this harmful practice.

The 200 million girls and women who have been subjected to FGM should not be forgotten in the pursuit of elimination, as their daughters are more likely to undergo the practice and need special attention.

Dozens of Nicaraguan migrants die from fentanyl in the United States

WO milligrams of fentanyl, equivalent to just ten to fifteen grains of salt, is enough to kill a person. Even so, every day more and more people - consciously or not - ingest the so-called "zombie drug", considered an epidemic that in the last two years has killed more than 140,000 people in the United States.

The epidemic has also reached Nicaraguan migrants in that country. Data estimates that in 2023, at least 40 Nicaraguans died from causes related to the consumption of drugs that were laced with fentanyl. Most of them were young people who had migrated not long before.

Fentanyl, which circulates through the streets of the United States, has reached migrants, and is "ending the American dream of many Nicaraguans," warned the Texas Nicaraguan Community (TNC), at the end of 2023.

TNC confirmed that, as of April 2023, at least six Nicaraguans had died as a consequence, although many other cases were not registered at the request of family members.

A registry of 140 Nicaraguan migrant deaths in the United States that occurred in 2023, the deaths were reported in press releases, social networks, TNC publications, and from users seeking funds to repatriate their relatives.

On most occasions, these deaths were attributed to heart attacks - the ultimate cause of death - due to the fear of social stigma towards the migrant community.

Many families, who ask for money to repatriate their deceased, fear that people will refuse to support them thinking that "he died because he was a drug addict." However, the fentanyl epidemic is more complex, and it is a drug that has taken root in the United States.

"Fentanyl is a potent synthetic opioid, up to 50 times stronger than heroin and 100 times stronger than morphine," states the #APillKills campaign, from the Texas Health and Human Services Commission, where an average of five people die every day from fentanyl overdoses, including accidental poisonings.

Carlos was killed by fentanyl

Carlos, 29 years old, had only spent three months as a migrant in the United States before he

died from fentanyl-laced drugs.

The young man was originally from Managua, where he worked in construction. He had a wife and two daughters, ages eight and one. Before leaving, his family said, he had never used drugs.

He was affectionate with his daughters and made sure they had everything they needed, said his wife in an interview to a local media, when they were carrying out a campaign to repatriate his body. More than four thousand kilometers away from them, and depressed by loneliness, he tried drugs.

The day Carlos died, he had called his wife on the phone. He told her that he was drinking alcohol with other migrants, but that he would soon return to his apartment. The next thing she knew, he dropped dead on a New York street. Carlos had taken drugs adulterated with fentanyl. The consumption of these, along with liquor, caused him to have a seizure that prompted him to run out of the apartment and onto the street.

TNC gave the details in a publication that was later removed at the request of family members. Likely, the young migrant did not know he was using drugs adulterated with fentanyl. TNC explains that the migrant community is getting fentanyl mixed with other drugs.

Migration stress and drug

The majority of reported deaths from TNC in 2023 were of men between 20 and 30 years of age. Their youth, difficulties adjusting to a new country, depression, and work burdens are causing many to use drugs, the

Nicaraguan NGO said.

At the end of September 2023, the organization surveyed Nicaraguan migrants. Thirty-nine percent of 800 respondents said they were disappointed with their situation in the United States, that they have problems adapting, and have considered returning to Nicaragua.

Migrants tend to suffer from "migratory stress," anxiety, and depression due to the fragmentation of their daily lives, according to a study entitled Drug use and responses to migratory stress among Mexican migrants heading to the United States, by Dr. Jorge Luis Arellanez, of the Universidad Veracruzana.

Depending on people's resources and strategies, there may be a greater or lesser level of adjustment, the specialist adds. Some migrants will be able to integrate and others who have fewer resources will face their emotional discomfort with "the abuse of alcoholic beverages, the consumption of high amounts of tobacco and even experimentation with illicit drugs."

TNC: 152 Nicaraguan migrants dead in 2023

In 2023, 152 Nicaraguan migrants died in the United States, according to a count published by the Texas Nicaraguan Community.

Database shows that 140 Nica-raguan migrants died from different causes in 2023, twelve less than those reported by TNC. Of that list, 48 died in traffic accidents and 40 from heart attacks or cardiac arrest, among them several related to the consumption of adulterated drugs.

Eleven others were murdered, and ten died of cancer, leukemia, or other diseases. In addition, three died in fires, three from femicides, two from work-related accidents, and one from drowning. The causes of death are unknown for 12.

Of the 140 migrants who died, 35 were between 20 and 29 years of age, and 34 were between 30 and 39. This means that 49 percent were under 40 years of age. Another 16 (11 percent) were between 40 and 49 years old.

Although there is no detailed information on how long ago they migrated, it is known that 22 of the 140 had migrated less than a year before their death, and 17 had migrated between one to two years prior. Many of them lived in California, Texas, and Florida.

Conditions for most Nicaragu-

an migrants in the United States are not favorable, according to the results of the TNC survey. Of the 800 migrants who participated, only four out of ten Nicaraguans said that they were "doing well." The rest said they were not doing well because of unemployment, adjustment problems, and disillusionment upon arrival.

The NGO warned that these conditions have caused many migrants to fall into drug and alcohol problems. Although some of the cases of deceased migrants are often reported on social networks as deaths due to heart attacks, several of these are related to the consumption of drugs adulterated with fentanyl.

What is fentanyl?

Fentanyl is a synthetic opioid 100 times stronger than morphine. Opioids are a class of drugs found naturally in the poppy plant. Some opioids are made directly from the plant. Others, such as fentanyl, are created in laboratories. These are known as synthetic opioids, explains the U.S. National Institute on Drug

Fentanyl has its origins in China, where its production was legal until 2017. After its prohibition, Mexican drug traffickers learned how to "cook" it to continue the million-dollar business of distributing it.

A "cook" of the Sinaloa Cartel stated, in a report to the Spanish newspaper El País, that he could earn up to 25,000 dollars in a single day. According to estimates by the Drug Enforcement Administration (DEA) - quoted in the same report - fentanyl can generate profits of between \$160,000 and US\$640,000 per kilo.

An aggravating condition for the circulation and consumption of fentanyl is that its manufacturing cost is relatively low. In the United States, the Centers for Disease Control and Prevention (CDC) details that sellers make illegal mixtures, so some may not be aware that they are consuming drugs laced with fentanyl, because it cannot be seen, smelled, or tasted.

"It is nearly impossible to tell if drugs were laced with fentanyl unless they test their drugs with fentanyl test strips," CDC warns.

Like heroin or morphine, fentanyl acts by binding to opioid receptors found in the brain that control pain and emotions.

The "zombie drug" induces "powerful stimulation," which can lead to brain changes (or neuroadaptations), including "in-

creased tolerance (requiring increasing doses to achieve desired effects), dependence, addiction, and withdrawal symptoms," according to a scientific report in National Geographic magazine.

"The toxicity and addictive potential of these narcotic compounds exceed those of morphine and heroin," warns the publication. It adds that fentanyl "is 50 times more potent than heroin, a potency that has made it one of the most prominent and feared synthetic opioids."

The consumption of fentanyl causes extreme euphoria, lethargy, nausea, confusion, sedation, breathing problems, and loss of consciousness. After repeated use, the brain adapts and its sensitivity decreases, increasing dependence, according to the National Institute on Drug Abuse in the United States.

A person who is suffering from a fentanyl overdose tends to present the following symptoms, small, constricted, pinpoint-like pupils, falling asleep or losing consciousness, slow, weak or no breathing, gagging or gurgling sounds, limp body, cold or clammy skin as well as pots on the skin (especially on the lips and fingernails)

It is important to identify these symptoms, because the person may survive if given a dose of naloxone, a powerful drug capable of reversing overdoses of heroin, fentanyl, and other opioids, the CDC says.

Naloxone has been proven to restore a person's breathing, and in the United States, it is allowed for sale without a prescription. It is also available through community programs.

The CDC recommends the purchase of naloxone for the general population because statistics indicate that 40% of overdose deaths occur in front of other people.

Actions to combat fentanyl

Fentanyl use in the United States began to increase in 2016, but record fentanyl deaths skyrocketed in 2021, with 70,601 deaths. The following year there were another 73,798 deaths.

From 2012 to 2023, some 144 399 people died from overdoses of drugs adulterated with fentanyl, 2.5 times the number of people needed to fill Dodger Stadium, the largest capacity baseball stadium in the United States.

On October 5, 2023, the Mexican and U.S. governments signed an agreement to address fentanyl trafficking. U.S. authorities claim that fentanyl is created in clandestine laboratories and trafficked by Mexican cartels.

"The fentanyl that these cartels produce and traffic is the deadliest drug threat the United States has ever faced," said U.S. Attorney General Merrick Garland.

Mexican authorities have dismantled 37 fentanyl pill manufacturing laboratories since President Manuel Lopez Obrador came to power in 2018, El Pais revealed. However, Mexican authorities and their president claimed until recently that no such drug was produced in their country.

In June 2023, the United States filed charges against four Chinese-based chemical companies and eight Chinese nationals for trafficking precursor chemicals used to create fentanyl.

Several studies reveal that fentanyl overdose deaths are disproportionately affecting minorities in the United States. In New York, the health department reported that there are more deaths among African Americans and Latinos.

A New York Health Department report said that "disparities in deaths by race-ethnicity, age, income, and neighborhood have widened as the magnitude of the overdose crisis has worsened."

According to provisional figures from the CDC, the United States closed 2023 with a record number of more than 112,000 drug overdose deaths, 70 percent of which would be related to fentanyl, which has become the leading cause of overdose deaths in major U.S. cities. In the case of Nicaraguan migrants, it is -for now-the second leading cause of

T the bar that Sandra manages in Panama City's central financial district, the variety offered on the menu has shrunk due to delays in ship traffic through the Panama Canal, one of the world's major shipping routes.

"We are out of stock of some of our foreign beers, because the shipment didn't arrive. I hope it will get here one of these days," the Panamanian bar-keeper said, as she pointed to a half-empty refrigerator in the bar nestled between skyscrapers.

"Above and beyond the ship traffic, the canal should provide raw water for the populations of (the provinces) of Panama and Colon. The delays have been repeated since drought took hold in this Central American nation throughout 2023, exacerbated by the effects of the climate crisis and the cyclical El Niño Southern Oscillation (ENSO) weather phenomenon that warms the waters of the Pacific Ocean.

This mixture of phenomena has repercussions on the forested areas surrounding the canal and the Alhajuela, Gatun and Miraflores artificial reservoirs that supply it and provide water for more than half of the country's total population of 4.7 million people.

Due to the lack of rain, the level of Gatun Lake, the main source of water for the canal inaugurated in 1914, dropped from its normal height of 26 meters above sea level to less than 24 in recent weeks.

Six per cent of the world's maritime trade, especially container trade, goes through the canal connecting the Atlantic and Pacific oceans.

In addition, the interoceanic waterway has lost volume through evaporation due to warming water temperatures, according to a 2022 study by the Netherlands Water Partnership (NWP), a network of 180 public and private organizations.

Drought narrows Panama Canal and delays shipping

(ACP), founded in 1978 to manage the company, said the situation stems from including the canal in its current watershed and expanding it since 2016, which doubled its capacity and the volume of ships, in addition to leading to the prohibition of the construction of more dams.

But the slowdown stems from the crucial element of the infrastructure: water, whose scarcity means fewer commercial vessels can cross from one ocean to the other. The reservoirs that feed the canal have a capacity of 1,857 hectoliters and currently hold

At the same time, the demand for different activities is increasing, leading to greater competition for consumption and conflicts that will intensify throughout this century.

Law 93 of 1999, modified by Law 44 of 2006, establishes the limits of the canal's watershed, which covers 343,521 hectares and is one of 52 in the country.

The rainy season in this tropical country runs from May to November, but the last quarter of last year recorded lower rainfall, and the drought will worsen in the first half of 2024.

The population of the provinces of Panama and Colon also depends on water from the canal. in its strong phase, as meteorolo-But the problem is aggravated by waste, the leakage of at least 40 percent of the water due to broken pipes and the lack of efficient infrastructure.

This is despite the fact that this nation ranks fifth in the world in annual rainfall, has six times the world average of fresh water per person, in addition to 500 rivers, in an area of only 75,517 square

But on the other hand, it has the highest individual consumption in Latin America, with 507 litres per inhabitant. Panama has an availability of about 115,000 cubic meters per inhabitant/year, according to the Inter-American Development Bank (IDB).

The consequences of the climate crisis and ENSO cloud the outlook for the water supply, since they mean that both excess and scarcity of water will create trouble for this Central American country. El Niño has reappeared lion liters of water per vessel, loading it onto ships.

The ACP estimates that the basin captures almost 4.4 billion cubic meters (m3) annually, of which the canal consumes 70 percent for navigation and 15 percent for drinking water.

Victim of nature

In response to the crisis, the ACP adjusted the maximum draft, the daily traffic capacity and the reuse of diverted water.

As a result, it reduced the number of vessels crossing the 82-kilometer route to 24 per day from an average of between 38 and 40, which could drop to 18 this February, when traffic is expected to decline by one-third from its usual level.

The canal already suffered an acute water crisis in 2016, but it has been aggravated now by a strong ENSO.

William Hugues, a member of the non-governmental National Front for the Defense of Social and Economic Rights, said the crisis was foreseeable and exposed the underlying aim of prioritizing the canal over the water supply to the local population.

"We issued a warning in 2006, when the expansion was being discussed, that larger locks would cause more salt water to enter Gatun. This demand would threaten the supply of drinking water. We have to accept that the canal has physical limits and we cannot respond to the dynamics of the international economy," the economist, whose group includes social organizations, trade unions and other groups, told

Hugues, author of a book on the expansion of the canal traffic, pointed out that there is always a line of ships waiting to cross during the dry season and that the measures applied are the same as before the expansion.

Due to cargo demand, the expansion, undertaken in 2007 and completed in 2016, added two locks to accommodate the larger, heavier Neopanamax cargo ships, which need more water to transport up to 120,000 tons, especially gas cargo. But the expansion has had repercussions on the demand for water.

The use of the canal brings more than four billion dollars into the Panamanian coffers annually, approximately six percent of GDP. The drop in traffic could mean a financial loss of more than 200 million dollars a year and, therefore, will have an impact on the already stressed finances of this Central American

Although it had promised to do so, the ACP did not respond to an IPS query about forecasts for canal activity in 2024.

The crisis has forced ships to take longer and more expensive routes, such as around Cape Horn, to the south of Chile, or to move cargo overland from coast to coast in Panama, before re-

OFTEN referred to as the "Sun continent," Africa receives more hours of bright sunlight than any other continent. But even with 60 per cent of the world's solar resources, Africa has only one per cent of solar generation capacity, according to the International Energy Agency (IEA).

Due to energy production and infrastructure challenges, many African countries regularly deal with blackouts, brownouts and poor electricity supply. Then the COVID-19 pandemic hit the global economy hard, and commodity prices surged after the invasion of Ukraine, making energy even more difficult for poorer Africans

Increasingly, start-ups rather than established corporations are offering access to advanced solar energy solutions to the majority of people across Africa. By harnessing the sun's power and transitioning to clean energy, Africans can expect major economic and social developments across the

Headquartered in Nairobi, Sun-Culture has raised over \$40 million to equip rural farmers with solar-powered irrigation systems. Instead of counting on rainfall or revving up diesel or petrol pumps, farmers can now rely on solar-powered systems that are cheaper, use renewable energy

and need minimal maintenance. Once the company installs a

solar panel on top of a farmer's house and connects it to a battery-powered water pump, the irrigation system can cover up to three acres.

"Solar is particularly attractive because of its positive environmental impact, job creation potential, and economic development potential," said Mikavla Czajkowski, chief of staff at Sun-Culture.

"African nations have immense potential to benefit from utilizing solar energy - especially in remote and under-served regions where energy access is limited and facilitates a reduction in no shortage of original solar enthe continent's carbon footprint, making a valuable contribution to global efforts to combat climate change," Czajkowski added.

negotiating directly with original equipment manufacturers for better prices and warranties and by working with developers for supply chain support.

"Operations and maintenance, especially in remote areas, can be a big hurdle," Ms. McAteer said. "We offer hardware and software that sits on top of solar assets so that operators and investors can get deep insight into performance and optimize performance of

their systems." More than 500 million people living in Africa have no access to electricity, according the IEA Africa Energy Outlook 2022. Governments and non-governmental organizations have launched many high-profile schemes to boost the solar energy sector in African countries, with mixed success. The continent needs a global response to address a challenge of this immense scale.

Launched in 2012, the US-Africa Clean Energy Finance (US-ACEF) initiative attempted to offset the costs of the early-stage development of clean energy projects, in a bid to draw investment to these ventures.

Nijhad Jamal, managing partner of Equator, an early-stage venture capital firm focusing on climate technology in sub-Saharan Africa, agrees that Africa's solar energy sector has benefited greatly from US-ACEF.

"There is a lot more impact to come from US-ACEF with projects like the Health Electrification Alliance, which aims to electrify over 10,000 health facilities in Africa," Jamal said. "Most of the US-ACEF projects emphasize sustainability. In our opinion, this will have a lasting impact on the solar energy

Political odyssey of Edward Ngoyai Lowassa: Chronicle of joining, departing from Chadema

HE arrival of former Prime Minister Edward Lowassa to the opposition–Chama cha Demokrasia na Maendeleo (Chadema) sparked controversy, signifying a pivotal moment in Tanzania's opposition history.

The development triggered disagreement, prompting prominent figures like former Chadema Secretary General Wilbroad Slaa to distance themselves from these political changes.

In a political whirlwind on July 28th, 2015, Chadema experienced a notable surge in members, stemming from a surprising source - CCM, Tanzania's ruling party.

However, as the calendar flipped to 2016, a reverse trend emerged, with individuals gradually retracing their steps back to their political origins.

By the time 2020 dawned, not a single member from the initial influx remained. The tale of this political migration unveils a captivating narrative of shifting loyalties and the ever-changing dynamics of Tanzanian politics.

The influx into Chadema in August 2015 was a result of the preliminary election process within CCM to select a presidential candidate. Edward Lowassa, a former Prime Minister, wielded considerable influence. However, he faced setbacks

Lowassa, with his slogan "Journey of Hope," built high expectations among his followers, a large group within CCM, and many Tanzanians, that he would be the chosen CCM candidate for the presidency, eventually becoming the Fifth President.


He crafted an image of a powerful politician, creating a buzz with his activities. The way various groups, including religious leaders, emerged to persuade him to run, led some to claim it was all staged.

When warned by CCM's former Secretary of Ideology and Publicity, Nape Nnauye, about the surge of people urging him to run, Lowassa responded, "I cannot stop floods with my hands." This earned him the nickname "Mzee wa Mafuriko" (The Elder of Floods).

Every move Lowassa made towards the Tanzanian presidency in 2015 was impactful. He distributed money to churches and mosques, and when questioned about the source, he simply said, "from friends." Hundreds of millions were involved.

The Sheikh Amri Abed Stadium overflowed when Lowassa declared his intention. Then planes and helicopters dotted the skies, buses adorned with Lowassa's pictures and the slogan "Journey of Hope," a procession of Toyota Land Cruiser 200 series turned the country's roads into a frenzy. Lowassa tire-

lessly sought sponsors.

Hundreds of thousands came forward to sponsor Lowassa. The sponsorship was overwhelming. Everything related to Lowassa and the presidency in 2015 had a significant impact, even when he was cut, leaving many astonished. It seemed impossible to cut him.

Because Lowassa was the 'owner' of the political buzz, especially regarding the presidency in 2015, when he announced his departure from CCM to join Chadema, it was a departure with a significant impact. CCM's top leaders and senior members followed him. You could call it a flood migration based on his statement.

Chadema's Chairman, Freeman Mbowe, greeted the former presidential candidate of the party, Edward Lowassa, during one of the party's internal meetings in 2015 leading up to the general election.

Lowassa was the one with the most impact. Those who refused to welcome him had to leave. Dr. Willibrod Slaa, the Secretary General of Chadema, stepped aside, allowing Lowassa to become the presidential candidate. Slaa objected to accepting Lowassa.

As the 2015 General Election approached, Chadema joined forces with CUF, NCCR-Mageuzi, and NLD, under the umbrella of the Coalition of Defenders of the People's Constitution (UKAWA), to nominate a joint presidential candidate. Lowassa was endorsed. CUF's Chairman, Prof Ibrahim Lipumba, resigned, though he later returned when he rescinded his resignation.

Lowassa's political footprints were accompanied by many. The first was the veteran Communist, Kingunge Ngombale Mwiru, who refused to take a party card but declared he "supported the change." He even climbed the Chadema platforms to campaign

for Lowassa.

Former Minister of Home Affairs, Laurence Masha, CCM's Chairmen, Hamis Mgeja (Shinyanga), and Mgana Msindai (Singida), were among the CCM dignitaries who loudly declared, "Where you are, we are," indicating that wherever Lowassa went, they would follow him.

Fredrick Sumaye, who served as the Prime Minister for both terms in the Third Phase Government, surprised many when he joined Lowassa in Chadema.

When they were both in CCM, they did not see eye to eye. Tambwe Hiza, a CUF member who switched to CCM during Yusuf Makamba's tenure as Secretary General, also joined the opposition, Chadema, to unite with Lowassa.

Some were defeated in CCM's primary elections for parliamentary seats and then joined Lowassa's Chadema. Dr. Milton Makongoro Mahanga and James Lembeli, who moved to Chadema after losing in CCM, were among them.

Esther Bulaya, the former Chadema Member of Parliament for Bunda Urban, was a CCM Special Seats MP from 2010 to 2015 and was expected to run for primary elections in CCM. However,

she switched gears at the last minute, moved to Chadema, and was given the candidacy, defeating the senior politician in the country, Stephen Wasira.

Bulaya, even though she joined Chadema during Lowassa's movement, was not part of the "where Lowassa is, we are" group, as she had long been associated with Chadema due to her close friendship with Halima Mdee, the Member of Parliament for Kawe and Chairperson of the Chadema Women's Council (BAWACHA).

I corrected Bulaya's migration to illustrate the broader picture of how the "Lowassa Chadema book" was closed. No remnants remained. Many returned to CCM, and three were called by God.

The first to return to CCM was Ambassador Mwapachu, who returned his CCM card to the Mikocheni Ward office early in March 2016 and the one who closed the book was Dr. Mahanga, who passed away on March 23 this year.

Tambwe passed away early in February 2018 while still in Chadema. On March 2, 2018, Kingunge passed away. Although Kingunge never took a Chadema card, he was associated with the party and Lowassa until his death.

From March 2016, when Ambassador Mwapachu, a former CCM member, praised President John Magufuli's performance and admitted he was wrong to leave, others returned to CCM in installments

and was expected to run for primary elections in CCM. However, Sumaye, after failing to secure the East African Legislative As-

sembly seat on Chadema's ticket, did not take long to return to CCM, saying "Opposition cannot win the presidency."

On March 1 last year, Lowassa returned to CCM. After that, Mgeja received the call of God. Those who claimed "where Lowassa is, we are" either returned or were overtaken by death.

So far, by the end of 2019, Sumaye and Mahanga seemed reluctant to return to CCM. In December 2019, Sumaye resigned from Chadema and retired from politics, claiming the party lacked democracy.

In February last year, Sumaye returned to CCM. Now, Mahanga was the only one left stubbornly resisting returning to CCM. Then he, too, was taken by God. Now, after Mahanga's death, the book of Lowassa within Chadema is closed. Everyone either returned or was overtaken by death.

In a twist of political fate, the once-accused Edward Lowassa found himself at the center of a controversy that unfolded in Tanzania in 2007. Chadema, a prominent political party, released a list of 11 individuals labeled as corrupt during a gathering at Mwembeyanga grounds, Temeke, Dar es Salaam, on September 15, 2007. Lowassa's name featured on this list, accused of violating a contract with the City Water company in Dar es Salaam.

The accusations stemmed from the City Water contract breach, which prompted Chadema's criticism of Lowassa for what they perceived as an authoritarian decision with potential financial repercussions for the nation. However, the government won the case in court, and the corruption allegations against Lowassa were dismissed.

For the first time in four years, Lowassa openly stated that none of those accused of corruption in the 2007 list, including President Kikwete, had been cleared by any committee or court. This revelation marked a pivotal moment in the ongoing power struggles within the ruling party.

Dr Harrison Mwakyembe, who chaired the parliamentary special committee investigating the Richmond scandal, shed light on the complexities surrounding Lowassa's downfall. Contrary to popular belief, Lowassa's involvement in the Richmond saga was not due to ownership but his role as prime minister overseeing the contract award. The committee initially avoided implicating President Kikwete but later learned that the president was aware and approved of the parliamentary proceedings against Loward.

Edward Lowassa's political journey in Tanzania is a tale of intrigue, controversy, and shifting alliances that have left an indelible mark on the nation's political landscape. The power struggle between Lowassa and Samuel Sitta, fueled by President Kikwete's promises during the election campaign, set the stage for a series of unexpected events.

US extends funding to a local school

shortage of affordable housing is a global issue impacting millions, experts propose that the solution isn't merely erecting more houses, but rather prioritizing the development of sustainable communities.

For instance, in his recent article dubbed: "Sustainable Affordable Housing in Africa: Building for the Future," Scotland-based Architect David-Isaac Arinze has highlighted what sustainable communities are, saying they provide people with safe, healthy, and comfortable homes.

According to him, these homes meet its dwellers' needs yet without compromising the needs of future generations.

"The lack of affordable housing in Africa is a growing concern, with millions of people living in inadequate,

overcrowded, and unsafe housing conditions. However, building more affordable housing is not enough," he insists.

The Architect is of the view that creating homes that are not only affordable but also energy-efficient, environmentally friendly, and socially inclusive, can lead to improved living conditions for residents, reduced energy costs, and reduced carbon emissions.

"Sustainable affordable housing can also promote ing for a collaboration beeconomic development by creating jobs in the construction and maintenance of buildings, as well as improving access to basic services like healthcare and education," the paper read in part.

Citing Kenya and Malawi, Azure thinks innovative solutions should be explored to address the matter, for instance he said: "One approach is to use local materials and techniques to build affordable, sustainable homes."

He added: "In Malawi and Kenya, solutions are created using 3D printing technology to build affordable homes in less than 24 hours. Another approach is to provide access to finance for low-income families to build or improve their homes. This can be done through microfinance institutions or government-sponsored programs."

On the other hand, the construction expert is calltween private sector and government and of which later would provide land, infrastructure, and regulatory frameworks to enable the private sector to build sustainable affordable housing.

"The private sector can bring in innovative financing models, technology, and expertise to build and maintain these homes," he said in his article.

Added he: "By incorporating sustainable design, mate-

rials, and infrastructure, we can build affordable housing that meets the needs of residents while protecting the environment and preserving resources for future generations.'

Therefore, he maintained that collaboration between governments and the private sector is essential to address the affordable housing crisis in Africa and build a better future for all.

For her party, Aysher Mahmood, an independent Quantity Surveyor said: "Of course, housing affordability remains a challenge and it is worsening due to, among other factors, the economic effects. Therefore, having a sustainable community would help in preventing city expansion on the basis of informal land development and informal housing supply.

"According to the 202 census, the country's population stands at 62 million, an increase of 37 percent from 2012 and by 2050, it is projected that Tanzania will have a population of 137 million. The question is, will the country's housing sector ready to meet the demand?" she probed.

Adding: "Currently the sector faces several key constraints that inhibit its future development, which includes limited access to land, that why people prefer the informal land sector which results to informal settlement coupled with substandard construction."

Dr Tatu Limbuka, Senior Research Fellow at Ardhi University, was one time quoted when giving a keynote speech on the pursuit of a modern city and affordable housing in Tanzania saying by 2050, it is estimated that most African countries will have over 50 percent of their population living in urban areas.

She believes that such unprecedented urbanization move, has not been accompanied by significant economic performance. As a result, informality and urban poverty are an everyday reality.

"High population growth and unsatisfied housing needs force many residents to live in informal, inadequate, and substandard housing with poor water and sanitation infrastructure. Every year, 4.5 million new residents move into informal settlements of Sub-Saharan African cities, which are often located in risky areas exposed to climate impacts," she said.

Therefore, the call to building sustainable communities that provide people with safe, healthy, and comfortable homes that meet their needs without compromising the needs of future generations becomes vital.

And this is why Davis Omondi an engineer by profession highlights the importance of sustainable communities in response to affordable housing.

"For sustainable communities, housing should be easily available, and must be affordable, economically and ecologically designed and comfortable, thus better suiting the needs of a person," he said.

Tenant sues landlord claiming a UK flat was sublet as he was stranded abroad

LONDON

A social housing tenant is suing his landlord for £1m in damages, alleging that a housing officer illegally sublet his home when he was stranded abroad at the start of the Covid pandemic in 2020.

Filippe Scalora's case against Clarion will allege that when he returned to the flat he discovered a stranger had been sleeping in his bed and using his towels, cutlery, crockery and computer.

The case over the onebedroom property in Chelsea, south-west London, goes to trial at the high court in London on Thursday. Clarion is the UK's largest housing association.

"I walked into the flat and saw half of my stuff there and someone living in it," the 43-year-old former regulatory compliance official told the Guardian. "My mail

was open, really private stuff like bank accounts and NHS appointment forms. I was devastated."

Scalora was allocated the flat on Cale Street by the Royal Borough of Kensington and Chelsea (RBKC) with a lifetime tenancy because of a medical condition. The rent was about £600 a month but would cost roughly £2,000 a month on the open market,

He has been homeless since he returned to the UK, living in budget hotels and temporary accommodation. He said his home remained occupied by the person the housing officer moved in in 2020.

Scalora was in Australia when the pandemic hit and claims he contacted his housing officer explaining he would not be able to get back to his home. He says the officer asked him to send his keys for a gas in-

RBKC wanted to allocate it to a temporary tenant.

He said he was promised he would get his flat back, or another one, when he was able to return.

His account is that when he realised he would be

spection and later told him stranded abroad he asked a friend to remove his belongings to allow for the new occupant, but it would later transpire that not everything was removed.

ficer stopped replying to his messages and the council told him it had no record of moving anyone else into the

In April 2022 he returned to the UK and hired a locksmith to get him in, which was when he discovered another person had been living there. "It was very uncomfortable seeing someone had been sleeping in my bed, using my towels," he said. "It was just theft."

Clarion declined to comment before the trial, where it will contest the case. It referred instead to a statement it made in October 2022 that a Clarion staff member, the unauthorised person residing in the home and Scalora were suspected of colluding to commit tenancy fraud and were under criminal investigation. That is something Scalora strongly denies.

Scotland Yard said it had received a report that an "unknown person was believed to have been residing at the address while the occupier was abroad", that the "tenancy issue was a matter for the relevant housing authority" and that no arrests had been made.

It did not say Scalora was under investigation. RBKC said it had "established that any legal action had to be pursued by Clarion". Scalora said he was interviewed under caution in late 2022

but the investigation did not proceed. Clarion said it had not been pursuing any legal action.

About one in 20 social homes in London, and one in 30 elsewhere in England, are subject to some sort of tenancy fraud, according to a study by the Tenancy Fraud Forum and the Fraud Advisory Panel. It can include tenants subletting their properties on platforms such as Airbnb. RBKC has previously esti-

mated that tenancy fraud costs the public purse an average of £42,000 a year for each home.

With about 148,000 properties affected, the problem has been getting worse, with a shortage of affordable housing in the private sector, shrinking or stagnant incomes and pressure on budgets, staffing and skills among social housing providers considered the main drivers.

Illegal subletting can net fraudsters thousands of pounds and is punishable by fines or up to two years in prison.

UK housing market recovers as price falls

LONDON

THE housing market is expected to stage a recovery in 2024 after average UK house prices fell by only £4,000 last year, according to official figures.

The price of the average home decreased by 1.4 percent in the 12 months to December 2023, an improvement on an annual fall of 2.3 percent recorded in November, the Office for National Statistics (ONS) said.

The figures suggest that a slowdown in the housing sector in 2023 triggered by rising mortgage costs may be over, and a downward trend in house prices has bottomed out.

After gains of more than 20 percent since 2020 that added more than £60,000 to the average UK house price, the latest figures show an annual drop of £4,000 to £285,000 in December. Prices hit a peak of £291,100 in the autumn of 2022.

Pent-up demand from cash buyers and first-time buyers who can access much cheaper mortgages than they could in 2023 is expected to push up prices back towards their peak this year, according to many economists.

The Bank of England is forecast to cut interest rates this year from 5.25 percent to 4.5 percent, prompting lenders to cut their latest two- and five-year fixedrate mortgage offers.

Figures from the Halifax and Nationwide have shown prices bouncing back since the start of the year as mortgage loan costs tumble.

Gabriella Dickens, a UK econo-

mist at Pantheon Macroeconomics, said: "We expect the official measure to follow the Nationwide measure and start to rebound, as the fall in mortgage rates and recovery in real incomes boosts affordability."

England had the highest average prices of all the UK nations and it experienced the biggest fall last year, down 2.1 percent to £302,000. Property values in Wales fell by 2.5 percent.

Scotland had the lowest average price and a rise in prices of 3.3 percent to £190,000, closing the gap in prices across the UK.

The north-west of England had the highest annual percentage change in 2023 - up 1.2 percent while the lowest was in London, at -4.8 percent.

While house prices dipped in 2023, private rents continued to soar. In the two years before March 2020, when the coronavirus pandemic forced the government to lockdown the economy, rental inflation averaged 1.5 percent. Since then, rental costs have jumped year on year before levelling off at 6 percent over the last four months of 2023.

"Private rental prices paid by tenants in the UK rose by 6.2 percent in the 12 months to January 2024, unchanged for the second consecutive month," the ONS

"Within England, London had the highest annual percentage change in private rental prices in the 12 months to January 2024, at 6.9 percent, while the north-east saw the lowest, at 4.7 percent."

At the height of the crisis in 2022, inflation surpassed 50 percent and the government defaulted on loan payments.


It subsequently restructured its debt with creditors to qualify a bailout from the International Monetary Fund (IMF).

Mohammed Amin Adam, who previously served as deputy energy minister and minister of state in the finance ministry, was on Wednesday appointed as Ofori-Atta's replacement.

Adam is expected to oversee the ongoing \$3bn IMF economic recovery program as well as debt restructuring negotiations with the country's commercial creditors.

President Akufo-Addo replaced 12 other ministers in Wednesday's cabinet reshuffle, which precedes Ghana's December presidential elections.





UK ECONOMY SHRINKS AFTER FOLKS CUT BACK ON SPENDING

EOPLE spending less, doctors' strikes and a fall in school attendance dragged the UK into recession at the end of last year, official figures show.

The economy shrunk by a larger than expected 0.3 percent between October and December, after it had already contracted between July and September.

The UK is in recession if it fails to grow for two successive quarters.

The figures raise questions over whether Premier Rishi Sunak has met his pledge made last January to grow the economy.

The government has never publicly said what measure should be used to assess if it had met Sunak's pledge to "grow the economy", despite repeated requests.

Kushner worked on a wide range of issues and policies in the Trump administration, including Middle East peace efforts, and developed a relationship with Saudi Arabia's Crown Prince Mohammed bin Salman, who has overseen social and economic reforms and a far-reaching crackdown on dissent in the kingdom.

After Kushner left the White House, he started a private equity firm that received a reported \$2 billion investment from the sovereign wealth fund controlled by Prince Mohammed, drawing scrutiny from Democrats.

Kushner, speaking at a summit in Miami on Tuesday hosted by media company Axios, said

UN envoy: Red Sea tension slows down Yemen's peace process

SANAA/ADEN

THE UN Special Envoy for Yemen, Hans Grundberg, on Wednesday warned that the military escalation in the Red Sea linked to the Israel-Hamas conflict in Gaza has a negative impact on the peace efforts in Yemen.

"Rising regional tensions linked to the war in Gaza, and in particular the military escalation in the Red Sea, are slowing down the pace of peace efforts in Yemen," Grundberg said in a live briefing to the UN Security Council.

The UN envoy said Yemen's rival parties vowed to operationalize commitments through a UN roadmap agreement in December last year, including a nationwide ceasefire, measures to improve living conditions, and restarting an intra-Yemeni po-

"Mediation efforts in Yemen cannot be neatly cordoned off. What happens regionally impacts Yemen, and what happens in Yemen can impact the region," he said.

Grundberg pointed out that the scale of economic challenges across the country is staggering. Civil servants, especially in Houthi-controlled areas, haven't been paid salaries in full, and people in governmentcontrolled areas face extended power outages and rising prices.

The Houthi group, which controls much of the northern populous area, has escalated attacks on commercial vessels and navy

ships of Israel, the United States, and Britain since mid-November last year, in what the group said in support of Palestinians against Israeli war in Gaza.

On Tuesday, Houthi leader Abdulmalik al-Houthi said in a televised speech that he has "no intention" to sabotage submarine internet cables in the Red Sea, a critical component in the global digital infrastructure, but he vowed to continue missile attacks against Israeli, US, and British ships transiting the Red Sea until Israel stops war on Gaza.

The military escalation in the Red Sea has forced major shipping companies to re-route around the African continent, causing prices of shipping and goods to increase dramati-

According to daily reports aired by Houthirun al-Masirah TV, the Houthi group has recruited thousands of Yemeni tribal youths since the Israel-Hamas war broke out on Oct

The Houthis trained those youths and equipped them with new weapons, telling them to get ready to go to the frontlines to fight "pro-US Yemeni government forces," said the reports.

The Yemeni government army controls all oil-rich provinces and cordoned off all Houthi-controlled northern provinces.

Relocation to Aden

Yemen's internationally recognized government on Wednesday called on all international and regional aid organizations operating in the country to relocate their headquarters from the Houthiheld capital Sanaa to Aden.

In a statement, Yemen's Ministry of Planning and International Cooperation urged all aid groups to move their main offices to Aden as part of an effort to "arrange institutional work and unify efforts" in the war-torn Arab nation.

The ministry also asked aid groups to open bank accounts with Yemen's Central Bank based in Aden.

The ministry said it would "provide full facilities to ensure a smooth and successful transfer" to Aden, the seat of the internationally recognized administration. It also vowed continued support for "sincere or-

There has been no immediate response from the various UN agencies and non-governmental organizations active in Yemen regarding the relocation request.

Most major aid organizations have kept their Yemen operations headquartered in Sanaa since it was seized by the Houthi group in late 2014. Yemen's government argues the city is no longer a legitimate base for overseeing activities in the country's war-ravaged areas.

Yemen has been depending heavily on international assistance since the civil war broke out in 2014 between the government and Houthi forces. The relocation request reflects ongoing tensions between the rival parties over the control of the aid response.

Observers warn that the politicization of aid may lead to hampering delivery and compounding suffering in what the UN calls the world's worst humanitarian crisis. Over 4 million Yemenis have been displaced by the conflict, which has pushed much of the population to the brink of famine.

financial architecture to help Africa **ADDIS ABABA**

EXECUTIVE Secretary of the United Nations Economic Commission for Africa (ECA) Claver Gatete has called for action to reform the global financial architecture to help African countries achieve sustainable develop-

The call came on Monday in Addis Ababa, the capital of Ethiopia, as the executive secretary briefed journalists alongside Zimbabwean Finance Minister Mthuli Ncube on the UNECA Conference of African Ministers of Finance, Planning and Economic Development (CoM2024) to be held in Victoria Falls, Zimbabwe, from Feb. 28 to March 5.

Gatete noted that based on the current allocation formula, the resources directed to the African continent by the International Monetary Fund, the World Bank, and others are not commensurate with its financing needs.

"The ECA believes that the international financial architecture needs to be reformed and its governance improved. Unless it is reformed, African countries will face challenges in implementing the Sustainable Development Goals and the African Union's Agenda 2063, as most of their resources are used to pay loans," Gatete said.

He said the international financial institutions need to provide long-term and concessional loans to middle- and low-income countries to help them invest in major development sectors, achieve better economic growth, and deal with their debt burdens.

"The international financial institutions are no longer fit for purpose; they should make changes about the way they function."

UK economy falls into recession, challenges Sunak's election

LONDON

BRITAIN'S economy fell into a recession in the second half of 2023, a tough backdrop for Prime Minister Rishi Sunak who has promised to boost growth ahead of an expected 2024 election.

The office for National Staexpected 0.3 percent in the three months to December having shrunk by 0.1 percent between July and September.

A Reuters poll of economists had pointed to a smaller 0.1 percent fall in the October-to-December period.

The fall in GDP in the fourth quarter was the biggest since the first quarter of 2021, the ONS said.

Britain's economy has been stagnating for nearly two years. The Bank of England has said it expects it to pick up

slightly in 2024.

"Businesses were already under no illusion about the difficulties they face, and this news will no doubt ring alarm bells for government," Alex Veitch, director of policy and insight at the British Chambers of Commerce, said.

UNECA chief calls for more attention to education for Africa's development

EXECUTIVE Secretary of the United Nations Economic Commission for Africa (UNECA) Claver Gatete called for accelerating digital education in Africa to help the continent achieve its future development agendas.

Speaking at the 44th Ordinary Session of the Executive Council of the African Union (AU), Gatete said Africa

needs to accelerate digital connectivity, accessibility, and affordability to bridge the digital divide on the conti-

Noting that education is a basic human right and a key enabler for achieving Africa's collective socioeconomic development objectives, the UNECA chief said the AU should commit to transforming the continent's education system into one that is "fit for purpose" in today's world.

The session, which comprises foreign affairs ministers from AU members and runs on Feb. 14-15, is being held under the AU's theme for the year 2024: "Educate an African fit for the 21st Century: Building resilient education systems for increased access to inclusive, lifelong, quality, and relevant learning in Africa."He urged countries in the continent to make the necessary

investments in infrastructure, mobilize resources, and develop the right curricula that will allow them to leverage their natural and human capital and demographic dividends. "By 2030, nearly one in two young people globally will be African. But the evolving population dynamics is not matched with vital skills for Africans to fully participate in a changing workforce,"

Businesses in Zimbabwe prefer USD as local currency slides

HARARE

AMID the depreciation of the Zimbabwean dollar, many informal traders in Zimbabwe are rejecting the local currency in preference for the U.S. dollar.

Zimbabwe, a country that has faced currency instability over the last two decades, uses both the U.S. dollar and the Zimba-

bwean dollar as legal tender. Businesses' and individuals' appetite for the U.S. dollar continues to grow, and the greenback now constitutes over 80 percent of domestic transac-

tions, according to the Zimbabwe National Statistics Agency (ZIM-STAT). Mandi Jari, an informal trader, said businesses have lost confidence in the local currency as a store of value. "I need the U.S. dollar to restock.

If I sell my products in Zimbabwean dollars, I will still need to buy foreign currency on the black market since the supplier wants forex," he told Xinhua Wednesday.

The trader said apart from stocking, other expenses associated with running a business including transportation and

rentals, are exclusively priced in foreign currency.

While some informal traders reject the local dollar or price their goods and services using the black market rates, the Zimbabwean government prescribes retailers using the Zimbabwean dollar exchange rate with up to a 10 percent margin, a scenario which the International Monetary Fund (IMF) said in a statement Wednesday promotes informality.

The IMF noted that local currency instability in the country has intensified over the past few months, with the official exchange rate depreciating by about 95 percent since the beginning of December 2023."

The gap to the parallel market rate remains wide (above 30 percent), and Zimbabwean dollar inflation is still very high.

This instability weighs on sentiment, while exchange rate restrictions continue to be a burden on the formal sector," the

The local dollar, which officially traded at 6,192 per 1 U.S. dollar on Jan. 2, is currently trading at 12,093 as of Feb. 14, according to tuation that has happened on the

the Reserve Bank of Zimbabwe daily exchange rate updates.

On the black market, 1 U.S. dollar is trading at over 15,000 Zimbabwean dollars. Denford Mutashu, president of the Confederation of Zimbabwe Retailers, said the local dollar depreciation has been captured by the value chains and supply chains.

"So this actually is the reason why you may have seen that products like bread have slightly gone up, and other basics have slightly gone up; it is actually on the back of that particular fluclocal currency," Mutashu told Xi-

Zimbabwe adopted a multicurrency regime in 2009 to tame inflation following years of hyperinflation. Economic analyst Prosper Chitambara sees the demand for the greenback persisting.

"The fact that we are in a dual currency framework means that the pressure on the exchange rate will always be there given the fact that a lot of economic agents prefer to hold value, or even to transact in the U.S. dollar, which is fairly stable," said Chitambara.

Japan unexpectedly slips into recession

JAPAN unexpectedly slipped into a recession at the end of last year, losing its title as the world's third-biggest economy to Germany and raising doubts about when the central bank would begin to exit its decade-long ultra-loose monetary policy.

Some analysts are warning of another contraction in the current quarter as weak demand in China, sluggish consumption, and production halts at a unit of Toyota Motor Corp all point to a challenging path to an economic

"What's particularly striking is the sluggishness in consumption and capital expenditure that are key pillars of domestic demand," said Yoshiki Shinke, senior executive economist at Dai-ichi Life Research Institute.

"The economy will continue to lack momentum for the time being with no key drivers of growth."

Japan's gross domestic product (GDP) fell an annualized 0.4 percent in the October-December period after a 3.3 percent slump in the previous quarter, government data showed on Thursday, confounding market forecasts for a 1.4 percent in-

Two consecutive quarters of contraction are typically considered the definition of a technical recession.

While many analysts still expect the Bank of Japan to phase out its massive monetary stimulus this year, the weak data may cast doubt on its forecast that rising wages will underpin consumption and keep inflation durably around its 2 percent target.

"Two consecutive declines in GDP and three consecutive declines in domestic demand are bad news, even if revisions may change the final numbers at the margin," said Stephan Angrick, senior economist at Moody's Analytics.

"This makes it harder for the central bank to justify a rate hike, let alone a series of hikes."

Economy minister Yoshitaka Shindo stressed the need to achieve solid wage growth to underpin consumption, which he described as "lacking momentum" due to rising prices.

"Our understanding is that the BOJ looks comprehensively at various data, including consumption, and risks to the economy in guiding monetary policy," he told a news conference after the data's release, when asked about the impact on BOJ

The yen was steady following the release of the data and last stood at 150.22 per dollar, pinned near a three-month low hit earlier in the week.

The Nikkei rose 0.8 percent, reversing some of its losses made from the previous session, possibly on expectations the BOJ may continue with its massive easing program for longer than expected.

On a quarterly basis, GDP slid 0.1 percent against median forecasts of a 0.3 percent gain, and compared with a 0.8 percent contraction in the previous quarter.

Consumption, Capex weak

Private consumption, which makes up more than half of economic activity, fell 0.2 percent, weaker than a market forecast for a 0.1 percent gain, as rising living costs and warm weather discouraged households from dining out and buying winter clothes.

Capital expenditure, another key private-sector growth engine, fell 0.1 percent, compared with forecasts of a 0.3 percent gain, as supply constraints delayed construction proj-

External demand, or exports minus imports, contributed 0.2 percentage point to GDP as exports rose 2.6 percent from the previous quarter, the data showed.

The BOJ has been laying the groundwork to end negative rates by April and overhaul other parts of its ultra-loose monetary framework, but is likely to go slow on any subsequent policy tightening amid lingering risks, sources have told Reuters.

While BOJ officials have not offered clues on when exactly they could end negative rates, many market players expect such an action to happen either in March or April. A Reuters poll taken in January showed April as the top choice among economists for the negative rate policy to be abandoned.

UMUSAMBI had been an average village on the outskirts of Kigali, the capital of Rwanda, until 2020 when a sanctuary was launched for birds with handicaps as a result of captiv-

Umusambi village has shot to stardom globally by providing a conducive environment for more than 50 grey-crowned cranes.

The sanctuary, with an area of roughly 21 hectares, has become a popular destination that draws tourists from Europe, Africa, and Asia who enjoy learning about conservation work and the importance of protecting natural environments.

Winnie Kyamujara, the village's head guide, said they were inspired to restore the area to conserve the majestic birds. "They were endangered, and their population was declining in the country. Besides, guides monitor the birds every morning and evening to ensure they are healthy. "We have a team of veterinary doctors who treat sick birds. We also have a clinic for wildlife which treats birds and small mammals," she said, adding that the safety of the cranes is guaranteed.

The Rwanda Wildlife Conservation Association started with campaigns on various media platforms, teaching people the dangers of keeping cranes in their homes. It carries out education campaigns in schools and communities about conservation. It also hosts schools to teach students about the importance of conserving cranes.

Kyamujara said the campaign helped combat poaching of the cranes for petty trade.Umusambi village is just one of the six places the NGO has since restored for conservation. Kyamujara thought that the lessons learned from the Umusambi village project to save cranes could help to protect other wildlife under threat.

"Many people now understand the importance of conserving the environment. But conservation requires collective efforts," said Kyamujara.

SOME fertilizer stakeholders from Tanzania participated in a virtual meeting with Russian fertilizer exporters to discuss how the two parties could cooperate and benefit from the international fertilizer trade.

The meeting was organized by the Russian Embassy in Tanzania and took place at the Russian Cultural Center in Dar es Salaam yesterday.

Among the Tanzanian attendees were representatives of the Tanzania Fertilizer Regulatory Authority, Tanzania Fertilizer Company Ltd., TIC and a large number of the Tanzanian private importers and traders.

The Russian side was presented by some of the largest Russian companies of the industry, including EuroChem Group, Uralkhem, Russian association of fertilizers producers and many others.

The round table on fertilizer trade continues the range of virtual meetings, organized by the Russian Embassy in Tanzania in cooperation with the Tanzanian Coffee Board and Cashew Board, that are dedicated to foster bilateral trade between Russia and Tanzania and give the unique opportunity to discuss in a B2B format all modalities of trade operations. Such events have already been made on topics of coffee and cashew trade.

As a follow-up to these round tables, some of the Russian participants visited Tanzania to hold more detailed business negotiations. For example, one of them was a delegation of the "United confectioners" (one of the largest confectionery company worldwide, with sales of \$3 billion) in December 2023.

Tanzania's goal is to ensure fertilizer uptake reaches 800,000 tonnes by 2025. The Russian side has acknowledged the efforts made by the Tanzanian government in successfully launching Fertilizer Subsidy Programme, inaugurated by President Samia Suluhu Hassan, which is a significant move to boost Tanzania's agricultural sector.

With this reform the Government aims to provide accessible and affordable fertilizers to farmers nationwide.

At the same time, Russian mineral fertilizer production rose 9% year-on-year in 11M 2023 to 53 million tonnes. Russia expects to reach 2021 levels or 59 million tonnes by the end of the year provided that the current capacity utilization is maintained.



If capacity utilization is sustained, fertilizer production might rise 10% in 2024 to more than 64 million tonnes and exports to the 2021 level.

New priority export destinations for Russian fertilizer producers are the countries of the global South, where three quarters of all exports are already being delivered. The largest markets at the moment are India and Brazil (Russian fertilizer shipments to Brazil grew by 1 million tonnes (or 16%) to 6.3 million tonnes in volume terms in 10M 2023).

However, due to the traditionally friendly ties that root back to the warm friendship between the late Mwalimu Julius Kamborare Nyerere and the USSSR and cooperation of Tanzania and the Soviet Union in introducing the Ujamaa policy, Russia is ready to consider opportunities of cooperating with Tanzanians in fertilizer trade.

As the Russian Ambassador to Tanzania, Andrey Avetisyan puts it, the ongoing building trade ties between the two countries is direct continuation of the Second Russia-Africa Summit held late July in Saint Petersburg, Russia. The two-day Summit was attended by Prime Minister, Kassim Majaliwa and a large group of Tanzanian

businessmen. The Russian Embassy continues its work on promoting communication and establishing direct contacts between Russian and Tanzanian business circles. Among the priority areas, now is tourism. The significant amount of Russian tourists that have visited Tanzania in 2021 (85,4 thousand people in the first quarter of the year) has proven that Tanzania and Russia have great potential in this sphere. Manchester City chasing £100m Champions League payday

MANCHESTER City's prize-money for winning back-to-back Champions League titles will top £100 million, with their perfect group stage results putting them on course for record earnings to retain Europe's biggest com-

City were one of two clubs to win six out of six group games this season when they defeated RB Leipzig, Red Star Belgrade and Young Boys earlier in the campaign, setting up their last-16 tie against FC Copenhagen.

With each victory earning £2.4 million in prize-money, City maximised their earnings with a clean sweep of wins, even with qualification secured early and their last match a dead-rubber in Belgrade.

The European champions also receive payments for making the group stage and for each round they progress, then an extra £3.8 million for winning at Wembley on Jun 1 and another £3.8 million for winning the UEFA Super Cup

in Athens in August. In total, City will earn £104.6 million should they triumph this season and they will also get a further slice of the broadcast revenue from Uefa which will be decided later, which is expected to make it a record amount for a Champions League win. Last season they banked £95 million before TV money was taken into

Pep Guardiola will also match Carlo Ancelotti's four wins in the competition if City win again and he has good memories of Wembley after winning Europe's top prize there with Barcelona as a player in 1992 and a manager in 2011. With a run to the final, he can equal Sir Alex Ferguson's record of 25 unbeaten matches in the Champions League from 2007-09.

City put one foot into the quarter-finals with their 3-1 win in Denmark, with Phil Foden wrapping up the victory with his stoppage-time goal. He is now targeting a second Champions League triumph after winning in Istanbul last season.

"I hope so yeah, we've got the squad of players for that. I look around the changing room and still see the determination and hunger - so I don't see why not," he said.

Ex-Dutch international gets six years for coke smuggling

AMSTERDAM

A DUTCH court sentenced former Ajax and international winger Ouincy Promes to six years in prison Wednesday, convicting him of smuggling more than one thousand kilogrammes of cocaine.

The 32-year-old, now playing for Spartak Moscow, was not in court to hear the sentence, a spokesperson told AFP.

Previous attempts to extradite him from Moscow have failed and on Wednesday judges at the Amsterdam District Court issued a warrant for his arrest. Summing up in court, presiding judge M. Vaandrager said Promes was an example to many, especially young people, due to his footballing talent.

"The suspect is regularly in the news, is active on social media, and has fans worldwide." the judge said.

"This makes it even worse that he has tried to increase his wealth... by participating in major international drugs trafficking.

"All things considered, the court finds a sixyear prison sentence appropriate," the judge said in a statement.

The court said Promes had smuggled a total of 1,363 kilogrammes of cocaine from Brazil in 2020, through the Belgian port of Antwerp into the Netherlands with the help of an accomplice. The drugs haul was stashed in bags of salt in containers on board a ship -- later partially intercepted by customs officials.

The ruling was based on wire-tapped conversations and encrypted messages Promes had sent under the pseudonym "Fantasma."

Prosecutors had called for a nine-year jail sentence but the court ruled they had based their request on previous cases where the punishment was too harsh.

KYLIAN Mbappe scored the opener as Paris Saint-Germain took a big step towards reaching the Champions League quarter-finals with a 2-0 win over Real Sociedad in the first leg of their last-16 tie on Wednesday.

The mediocrity of PSG's first-half performance at the Parc des Princes may have had their supporters fearing another in a long line of disappointing results down the years in earbashing at half-time the Champions League knockout stages.

But Mbappe, who is expected to leave the club at the end of the season when his contract expires, broke the deadlock from close range just before the hour mark.

Bradley Barcola's welltaken goal in the 70th minute then made it 2-0 to give the French cham-

pions a comfortable cushion to take to Spain for the return early next

"We managed to score at key moments. We are happy with this first step. There is still a lot of work to do but it is good to be going there with the advantage," Mbappe told broadcaster Canal Plus.

Captain Marquinhos added: "We were in great difficulty in the first half but we knew that would be the case.

"The coach gave us an and I think that helped because the attitude was much better in the second half.

"We know how important it is to win at home but it is not finished. We need to keep the same mindset between now and then, keep playing well in the league and then go there and play well to secure our qualification."

There was big pressure on PSG coming into this tie after they had gone out in the last 16 of the Champions League in five of the last seven seasons. Another early exit this season would be a monumental setback for the Qatar-owned club, especially as Real Sociedad were appearing in their

first Champions League knockout tie in two decades.

They also made the trip to Paris having failed to score a goal while failing to win any of their last four games in all competitions. In addition to that, they were missing captain and top scorer Mikel Oyarzabal as he recovers from injury.

PSG, who gave a Champions League bow at left-back to 20-vear-old Brazilian January signing Lucas Beraldo, were aiming to extend a run of 16 games unbeaten in all competitions stretching back to early November. - Away side threaten -

However, an early shot by Mbappe that was beaten away by visiting goalkeeper Alex Remiro was really the only time they threatened in a poor first-half showing.

Instead it was the away side, winners of their group ahead of Inter Milan, who looked more comfortable and who came closest to scoring prior to the break.

In the final minute of the half, captain Mikel Merino controlled the ball before crashing a piledriver from 25 metres off the top of the bar and over.

PSG eventually broke the deadlock on 58 minutes as Ousmane Dembele's corner from the right was helped on by Marquinhos towards the back post where Mbappe turned it in.

It was a 31st goal of the campaign in all competitions, and a fourth in the Champions League, for

the France captain who is widely tipped to move to Real Madrid after this season.

That relaxed the hosts and Mbappe almost scored again in the 63rd minute as he won the ball back high up the pitch and hit a powerful shot from outside the box which was tipped onto the bar and over by Remiro.


