Africa's water ministers fete former PM Lowassa

FORMER Prime Minister Edward Lowassa has been presented with a recognition award by the African Ministers' Council on Water (AMCOW) for his contributions to water sector modernization in the past two decades.

EU elicits Africa's support on Ukraine

THE European Union (EU) delegation in the country wants Tanzania and other African countries to be more involved on the Ukrainian conflict, underlining the principle of sovereignty and humanitarian conduct in war situations.

Ambassador Manfredo Fanti, the resident EU head of delegation told a press conference yesterday that the Russian invasion of Ukraine has resulted in a wide range of economic dislocations including inflation touched off by the surge in prices of oil and gas.

Similarly, there are diminished prospects for wheat supplies to a number of

needy countries and international organizations working with refugees around the world, apart from the huge wave of refugees in Europe which may affect the countries' capacity in development cooperation with poorer countries.

The only solution is for Russia to stop its invasion and with-

draw its claims on that country or enforcing the claims by a military expedition into its neighbor, to avoid further social and economic impacts in Europe and around the world, he

He said the EU call is in line with the view expressed a week ago by the International Court of Justice which ruled that Russia ought to suspend military operations that began on the last week of February, at a media event attended by diplomats from EU member states in the country.

Those present include France, Germany, Poland, Italy, Sweden, Finland, Spain and the

RESIDENT Samia Suluhu Hassan yesterday directed state entities involved in property development to work with the private sector to plan and implement projects to end housing woes in towns and cities.

Handing over 644 new flats at Magomeni suburb near the city centre after the area was redeveloped and former occupants given priority in the 52bn/scheme, the president said the National Housing Corporation (NHC), the Tanzania Building Agency (TBA) and Watumishi Housing Co. need to engage private sector stakeholders for greater effect.

"I'm informed that private sector players are ready to work with the government in property development. Engage them to speed up implementation." he said, noting that public agencies can't speed up the work on their own.

The president affirmed that financial institutions are ready to offer loans for real estate development in urban areas, she said, demanding that contracts with private developers ensure a win-win situation..

The demand for better housing and settlements stands at three million units while the demand increases by up to 200,000 units annually by current estimates, she said, urging the responsible agencies to speed up the work.

Building the Magomeni residential units was part of the implementation of the urban land use policy, reflected in the CCM election manifesto section 55(h) requiring the government to improve existing housing and settlement conditions.

At the newly built site, TBA needs to build a car parking lot accommodate a big number of vehicles, thus reducing parking congestion in town. It will be a good source of revenues and supermarket catchment facility, she stated.

The president accepted a proposal by the tenants to repossess the houses on tenant purchase basis to return the costs of construction and exclude the value of the land 'as otherwise they will not be able to purchase them."

The government has offered a three months free stay before starting to pay the money, she said, while Works and Transport minister Prof Makame Mbarawa said the project started on September 6 back in 2016, resonating with the Dar es Salaam city master plan

Situated on a 20 acres plot that was earlier known as Magomeni Quarters, the entire project is a commercial complex with five apartment blocks on three acres, and commercial infrastructure for shops, restaurants and a vast car park.

Around 128 families will be accommodated in one block comprising 16 apartments, with 644 families lined up for accommodation in all the five blocks, he

Turkey brings in 1m Sinovac doses

HEALTH minister, Ummy Mwalimu yesterday received another consignment of one million doses of Sinovac COVID-19 vaccines donated by Turkey.

At a reception ceremony at the Julius Nyerere International Airport (JNIA), the

minister said it is the first time the Mainland health authorities received Sinovac vaccines since the vaccination rollout started late July last

The new consignment takes to 10.8m the vaccines received, starting with Janssen, Sinopharm, Moderna, Pfizer and now Sinovac, with the

consignments put together sufficient for administering to nearly 6.4m people.

The COVID-19 vaccination drive continues at various health facilities across the country, along with mobile vaccination units, she said, pointing out that at the end of the third week of this month around three million people

had been vaccinated. The total number of those eligible for vaccination stands at around 30.7m people who are aged 18 and above, thus so far vaccination has reached 9.81 percent, she elaborated, urging political leaders, civil servants and others to maintain advocacy on the importance of being vaccinated.

They should encourage people to go for the jabs, she said, appealing to the public to maintain precautions like washing hands with soap and running water or using sanitisers, and wearing face masks. Mass protection of people against COVID-19 requires that up to vac

Netherlands, where the head of delegation laid accent on the impacts of the war as they are being felt in Europe and in Africa as well.

The war impacts Africa at this moment when countries are making efforts to recover from the social and economic impacts of the Covid-19 pandemic, he stated, reiterating that the EU condemns Russia's violation of international law and ignoring all its commitments.

The 27 EU member states adopted massive sanctions against Russia aiming to make the cost of the war unbearable to compel it to change the calculations of its authoritarian leader Vladimir Putin, whom the West says has undertaken 'a war of choice' in his invasion of Ukraine.

"Looking at the humanitarian picture; we are seeing discouraging images from Ukraine. So far, 3.5m people have been forced to leave Ukraine seeking safety elsewhere in European countries," the EU resident top diplomat explained.

The EU has decided to use its own budget to help Ukraine to defend itself against Russia, allocating around one billion euros for the campaign, he stated, whereas Nabil Hajlaoui, the French ambassador, said the country stands with the ruling of the ICJ on the matter.

"Our objective is not to go to war with Russia but to stop the war waged against Ukraine. All UN member states including Tanzania share the values of democracy and the role of law, which do not tolerate altering boundaries and sovereignty by armed force," he said. He appealed for greater awareness of the demands of the

situation in Tanzania and Africa generally as these countries have close ties with the EU, for instance being the top cohort of foreign investments in Tanzania, and within the city of Dar es Salaam in particular.

Krzysztof Buzalski, ambassador of Poland, expressed the hope that Tanzania will lend active support to the EU position as it has similar experiences of ravages of war and hosting waves of new refugees

Poland has so far received close to two million Ukrainian refugees, with current data from EU headquarters showing that the ultimate number of refugees could reach eight million if the war continues, he added.

Somalia adopts revised transition plan on transfer of security roles

MOGADISHU

A revised Somalia Transitional Plan which seeks to replace the African Union Mission in Somalia (AMISOM) with a new mission has been adopted in Mogadishu, the capital of Somalia.

The revised Somalia Transition Plan (STP) which paves way for the smooth transfer of security responsibilities to Somalia's security forces was adopted Monday at the strategic steering committee chaired by the Office of National Security.

"The plan paves the way for the end of AMISOM, with the name of the Mission being the Transitional African Union Mission in Somalia (ATMIS), and being

finalized by the end of the year 2024," the presidency said in a statement issued on Monday evening.

It said the revised STP is a key milestone for Somalia before the United Nations Security Council approves the new mandate for the new ATMIS. The meeting also agreed on the strategic standards and objectives that guide the operational mandate of the ATMIS operation, the termination plan and the withdrawal plan have been agreed upon, in line with the Somali government's guidelines and guidelines.

Somalia and the African Union have adopted a roadmap to replace AMISOM with ATMIS subject to authorization by the AU Peace and Security Council as well as the UN Security Council. Participants at the meeting which brought together representatives from the government and the international community welcomed the implementation of the STP, underlining the full readiness of the government to transfer responsibility for national security to Somalia by

AMISOM, whose mandate was due to expire in 2022, is a peace support operation with nearly 20,000 forces on the ground mainly from Kenya, Ethiopia, Uganda, Burundi and

Diibouti.

Meanwhile, a new four-year

multi-million project named 'Saameynta' - 'impact' in Somali - was launched today to achieve durable solutions for more than 75,000 internally displaced persons (IDPs) and vulnerable host communities in Somalia. Through this intervention, UN and its partners will work together with the Federal Government of Somalia to implement the National Durable Solutions Strategy. The project also seeks to decrease dependency on humanitarian aid, reduce poverty for thousands of impoverished individuals and promote IDPs integration in cities. Saameynta's unique approach aims to leverage the values

generated by planned urbaniza-

tion and investment in order to provide affordable housing, employment opportunities and community assets such as infrastructure, irrigation facilities, markets and other locally identified priorities for communities affected by displacement. Saameynta will also increase the self-reliance and access to sustainable basic services, including water, shelter, and health services for IDPs residing in the cities of Baidoa, Bossaso and Beletweyne.

The International Organization for Migration (IOM) is leading the implementation of the project and will work together with the United Nations Development Programme (UNDP)

and UN-HABITAT supported by the Integrated Office of the UN Resident Coordinator

"IDPs suffer from a lack of opportunities to grow and develop in their new communities, which make it difficult for these groups to get out the poverty cycle," said Ewa Nagvi, IOM Somalia Deputy Chief of Mission. There are an estimated 2.9 million IDPs in Somalia due to decades of conflict and extreme weather events such as drought and floods - one of the highest figures of IDPs globally. Of these, 2.2 million require urgent humanitarian assistance.

TOSCI solves problem of fake seeds sold to farmers

TANZANIA Official Seed Certification Institute (TOSCI) has solved the problem regarding weak and fake seeds that were being sold to farmers in the country making them incur

This has been possible after the Institute had increased the pace in the use of its quality standard labels for seeds being produced.

TOSCI director general, Patrick Ngwendiagi said that in the period 2014/15 300 the institute had seen 350 instances of fake and weak seeds were reported, the situation that caused big losses to farmers in the country.

regarding farmers being sold fake seeds, TOSCI came up with various strategies including enhancing seeds certification pace and using its own modern quality standards labels.

He said in the period 2016/17 they increased the pace for the issuance of the labels after certification, from two million to 10 million labels in 2019/20.

Ngwendiagi said due to quality standard labels, they have been able to assist the nation in ensuring seeds produced in the country and sold to farmers were of acceptable standards.

He said due to the achievements,

He said following many complaints per cent in 2015 to 811 per cent for all crops produced in the country.

> He said other TOSCI achievements included making the country join seeds scheme of the Organisation for Economic Co-operation and Development (OECD) that recognises Tanzania seeds quality standards with TOSCI labels, which will even make easier for the country to export its locally produced seeds.

Thadei Hafigwa, a prominent cereals farmer from Morogoro region praised TOSCI for resolving the challenge regarding fake seeds as in the past many farmers used to incur losses due to TOSCI has been able to increase the lack of proper certification control on country's seed production from 34 seeds producers in the country.

Tanzania to get 1billion/- each year from new fishing vessel operations will increase the number of indigenous cap-

MASIMBA Ndaki, Livestock and Fisheries minister, has said Tanzania will benefit by the injection of 1bn/- to its coffers each year and 300 tonnes of fish once the big fishing vessel in the Indian Ocean starts operating.

Speaking when receiving the vessel - 'Pacific Star' owned by the Al Bacora Group at the port of Dar es Salaam, Ndaki (pictured) said the profit will be realised after opening doors to big investors in the fishing sector.

He said in the agreement, the vessel owned by a Spanish national will receive a fishing licence, fly the Tanzania flag, provide training on fishing to five Tanzanians and build a fish processing plant in the country. He said the modern vessel with a capacity to carry 2,000 tonnes of fish at a go will engage in fishing of tuna in the high seas around Mauritius, Comoro and Tanzania.

He said the company will be fishing 200 tonnes of tuna fish and 100 tonnes of other kinds of fish after every four months, thereby filling the country's fish demand gap.

Zanzibar minister for Blue economy and fishing, Suleiman Masoud Makame said both the union and Zanzibar governments have optimism with the ship's coming because it will spur a new fishing revolution in the sea. He called on the Span-

Govt urges investment in irrigation schemes

THE government has called upon strategic investors to come and invest in developing irrigation schemes and infrastructures so as to increase the country's crop production and food security.

Minister for Agriculture Hussein Bashe made the call over the weekend when speaking to journalists on government's plans to woo local and foreign investors in developing irrigation schemes in the country's arable land.

According to Bashe, the room is open for any investors willing to develop the schemes and later charge fees to water users for the sustainability of the agricultural infrastructure. The move, he said will unlock the country's agriculture sector by increasing productivity per hectare.

"Our target is to ensure that more farmland is put into irrigation schemes and our people shift from seasonal rainfall. We encourage more investors in these areas," he said, noting that the government's goal can only be achieved through close engagement of the private sector in developing irrigation schemes.

Currently, the National Irrigation Commission (NIRC) is looking for further partnerships with local and foreign investors to develop over 150 new irrigation schemes across the country.

Acting Director for Design and Research at NIRC Eng Gregory Chigwiye said the move aims to complement government efforts of reaching 1.2 hectares of irrigated land by 2025.

He said the targeted schemes are part of the 274 schemes identified by the government across the country saying that if developed would increase crop yields and food security.

So far, the government has identified all schemes across the country noting that the priority is regions with irrigation potentials such as Morogoro, Mbeya, Iringa, Rukwa, and Katavi.

"But also growing food must not be done at the expense of the environment, therefore the ecofriendly methods of agriculture being introduced by Iles de Paix are very much welcome and will be supported," stated DC Luy-

To execute the programme, Iles De Paix works with various local partners, including the national networks of farmers groups in Tanzania (MVIWATA) and research, community and organisational development associates.

Dominick Ringo is the executive director for the Research, Community and organisational development associates (RECODA). He said the project will highly transform farming activities in the region.

Apart from Tanzania, Arusha in particular, Iles de Paix also works in support of family-based farming projects in Uganda, Peru, Benin and Burkina Faso, where the organisation trains and helps farmers to improve their production, harvests and storage capacity.

In response to severe drought that the region has been experiencing in later years, the organisation has been addressing the water needs of the local population, including the Maasai pastoralists to improve access to water for livestock.

Sernic arrests alleged kidnappers

MOZAMBIQUE'S National Criminal Investigation Service (SERNIC) has arrested three individuals, accused of involvement in the wave of kidnappings of business people which have been rocking Maputo city.

Sernic spokesperson Hilario Lole yesterday in Maputo told reporters that besides the criminal gang, made up of two women and a man, aged between 29 and 40 years, the authorities has also seized a luxury house in the coastal neighbourhood of Triunfo, which was being used as a private prison to hold kidnap victims.

"When they were detained, these individuals were preparing to carry out another kidnapping", Lole said. "The investigations we have made so far indicate that they paid, early in January, about 10,000 US dollars for three months' rent and the house would serve as a

Lole added that they only intended to occupy the house as from 15 February. They also purchased a vehicle from one of the Maputo car dealers which the police believed they wanted to use for future kidnappings.

The two women now under arrest claim that they had been hired for house cleaning, and knew nothing about the use of the house as a prison. "I have come here to do the cleaning. My friend said that there is someone looking for people to do house work and I agreed to do it," said one of the women.

The man, on the other hand, also claimed that he knew nothing about the use of the house to hold victims captive. He said he had only followed the orders given by a South African citizen who called him and spoke about his need to rent a house in Maputo.

Meanwhile, Judge Efigenio Baptista, of the Maputo City Court, has postponed for the second time the session of the "hidden debts" trial that would deal with the Public Prosecutor's request for the seizure of property from several of the 19 accused.

The matter should have been dealt with on Monday, but lawyers for the accused complained they had not been properly notified, with all the relevant documents. That problem continues - by Thursday it seems that the prosecution had not yet been able to gather all the documents that tie the accused to each of the properties it wishes to confiscate.

For example, the prosecution hopes to seize 40 buildings owned by Antonio Carlos do Rosario, the former head of economic intelligence in the security service, SISE, or by companies that he controls. But to do this, it must show documents such as title deeds, which prove that Rosario is indeed the owner.

So Baptista announced that the prosecution's seizure orders will be discussed at a date to be announced later by the court - and possibly after the prosecution and the defence have summed up their cases.

Chamwino District Council urged to upscale budget towards improving education

EDUCATION stakeholders have challenged the Chamwino District Council to use at least 20 percent of its domestic revenue towards improving the education sector.

Despite benefiting from the COVID-19 recovery fund to help schools, they raised concerns that the education sector within the famous district was still facing myriad setbacks.

Shortage of classrooms, desks, toilets, teacher's houses remain among key challenges in schools, mostly primary, while poor infrastructures and lack of training facilities towards students with special needs have become part and

The stakeholders sought that it was

to comply with the Dakar Framework for Action - Education for All.

In April 2000 more than 1,100 participants from 164 countries gathered in Dakar, Senegal, for the World Education Forum, ranging from teachers to prime ministers, academics to policymakers, non-governmental bodies to the heads of major international organisations, they adopted the Dakar Framework for Action, Education for All.

The framework, among others, directed governments to achieve quality basic education for all by 2015 or earlier, with particular emphasis on girls' education.

Speaking yesterday during a roundtable meeting which brought together key district officials and citizens, members of the youth forum expressed their views

prudent for the authority in the district over the need for collective interventions to help improve the sector.

> Chairperson of the youth forum, Mariam James, presented that the district was facing a shortage of a total of 747 classrooms in primary schools, 1886 pit latrines, 4,700 desks as well as 1422 teacher's houses.

> In secondary schools, she detailed that the deficit include 21 classrooms, 497 teacher's houses and six pit la-

> "The situation is not encouraging, especially in primary schools whereby in some schools around 500 pupils are being compelled to share a single room, bad enough, without desks," she said, noting that most of the available infrastructures are however dilapidated.

She spoke over the dwindling trend

in the council's budgetary allocation towards the education sector, observing: "For instance, during 2019/2020 fiscal year the district allocated 13.5 percent of its domestic revenue to support education, but in 2020/21 the budget shrank to

She also urged the authority to mull over using the province fund to help solve the challenges upsetting the schools within the district which habours the country's State House.

only 6.3 percent."

And she added, the area has so far registered more than 61 students with special needs, but saying, they're facing untold challenges to access better education due to absence of relevant trainers as well as facilities and infrastructures.

Responding, Chairman of Chamwino District Council, Edson Sweti, expressed concern over the challenges, saying they will work round the clock to improve the situation.

He however, hailed President Samia Suluhu Hassan for her positive efforts to improve the performance of the vital sector from grassroots within the district. He said despite being crippled with the few challenges, during last year the district stood second for excellence in education at the regional level.

"Among others, our focus is currently to motivate the councillors in all wards to sensitize the public to stand at forefront in paying various contributions to help spur the education sector within their areas," he noted.

Together with that, he added that the district will continue setting aside at others, based on improvement of educaleast 40 percent of its own source to suption and agriculture sectors," he briefed.

port the implementation of varied development projects, including those in the education sector.

Police in Dar arrest two suspected armed robbers

RPC Muliro said the two suspects were also found with a motorcycle with Reg. MC123DAL which they allegedly use in crime.

branches at Kibada, Pugu Road and Temeke and NMB Bank branches at Banana as well as Julius Nyerere International Airport (JNIA) all in Dar es Salaam.

He added that they also confessed to have robbed ASAS official of 30m/-. He said in 2018, one of the suspects

NIDA official said the processing and distribution of national identity cards is going through four steps which are registration of eligible citizens in all districts of mainland Tanzania and island of Zanzibar, providing National Identification Number (NIN) and distribution of national identity cards, and transfer of knowledge.

Other steps are building of data center, data recovery center, building 13 Information and Communications Technology (ICT) offices across the country and purchasing of new IDs processing machine.

He disclosed that within the year, NIDA has seen collection from data sharing improving from 17.5bn/- to 20.5bn/-, rank promotion of 485 staff, employing 22 new members of staff and sixty nine employers of the authority attended various

Tengeneza mentioned other achievements such as connect-

ing national radar to all regional administration and local government offices countrywide.

"Within the one year President Samia has been in office, NIDA has seen tremendous improvement, now 133 Tamisemi offices across the country are connected to national radar, in the past only 52 stakeholders were connected to national data sharing, but now we have 58 stakeholders who are connected of which 25 are government institutions while the remaining 32 are from the private sector," he said.

The NIDA communication head attributed the achievements to the government's tireless efforts in improving the lives of its citizens.

He added that "If you beat a child, you must also tell him why you have beaten him, the same in regard to online crime, before you deal with it first educate the people regarding which are online crimes and which are not."

Addressing seminar participants, the Director of Criminal Investigations (DCI) Camillus Wambura thanked Information, Communications and Information Technology ministry for facilitating the training saying it will help police officials to enhance their knowledge in regard to the fight against online crime.

"Technology changes daily, hence frequent training to our officials is needed in order to go abreast with the fast changes," said DCI Wambura.

Meanwhile, Senior Superintendent of Police (SSP) Joshua Mwangasa thanked the government, through the ministry for empowering police officials countrywide including ongoing efforts in building laboratories for scientific investigation in six regions of Mbeya, Arusha, Dodoma, Dar es Salaam, Mwanza and Zanzibar.

TAWA receives 2.9bn/- for development projects

Other projects is the resting area, and all the three projects will cost more than 672m/-.

In regard to the Mkungunero Forest Reserve Project, Semfuko stressed: "I call upon contractors and the reserve authorities in general to make sure the projects are taken care of and implemented in time to speed up development in tourism in the reserve, as well as making sure you provide employment to the indigenous people surrounding the area."

Earlier, TAWA Acting Commissioner for Conservation, Mabula Misungwi thanked the government for the funds, saying completion of the projects will help in strengthening road infrastructure and put in place friendly investment environment in the development of photography and hunting tourism.

He added that through the projects, people surrounding the area can benefit through so-

cial services including schools, digging of wells, libraries and dispensaries.

Meanwhile, the 42km long road supervisor in the Mkungunero reserve forest from SUMA JKT Central zone, Baraka Kiswaga said the project is now 60 per cent complete at gravel level.

He said the project that started July last year is expected to be completed in April this year and will cost 560m/-.

This was revealed by Busara Promotions Legal Director, Yussuf Mahmoud to reporters in his office here following its failure to meet operation costs without sponsors.

"Without money for paying salaries and other operational costs it is no longer possible to go on with its activities especially in regard to the festival that is well known globally in advertising Zanzibar's culture and tourism," Mahmoud said.

He said since the institution was registered in 2003 it has been making good job in advertising music and our heritage and culture held at Zanzibar Stone Town every year, the event that has been attracting visitors from many foreign coun-

He said the festival, different to other festivals in the world, concentrated in live music that gave opportunities women as well as new artistes and removed the concept of denying access to less known artistes in the country.

He said 400 groups from various countries in Africa have been entertaining audiences in the festi-

val contributing in enhancing the tourism sector, Zanzibar main economic pillar.

"For many years, the festival has been a pillar on the East African musical ecology that provided employment and enhancing talents, while giving opportunity for artistes to develop themselves by working together with various networks in the music sector," added Mahmoud.

He said all this could not have been possible without assistance from Norwegian sponsors and donors who have been doing so since

"Norway's sponsorship comes to an end this year, and unfortunately, without other sponsors from public and private sectors, Busara Promotions cannot continue to exist in Zanzibar," he added.

Busara Promotions Finance Manager, Safia Juma said when the festival was established it had 3,000 visitors from various countries, but after 19 years the number grew to 40,000 who were contributing to the Zanzibar income from tourism.

She added that the USD 150,000 provided by the Norwegian Embassy each year helped a lot in meeting operation costs of the festival, and added in case another sponsor comes forward before the March 31 deadline there is the possibility for the festival to continue for the national interest.

We want national fund for disabled persons to be fully operational - PWDs

PEOPLE with disabilities (PWDs) have appealed to the government to enable the 'National Fund for Disabled Persons' to become fully operational.

Dr Victoria Luhire, Law Lecturer at Open University of Tanzania made the recommendation in Dar es Salaam to discuss the progress in Gender and Disability Inclusion in Tanzania under one year of President Samia Suluhu Hassan.

The event involved members of Tanzania Federation of Disabled People's Organisations (SHIVYAWATA), officials from the government, and was organised by the Foundation for Civil Society (FCS) and Her - Ability Foundation

She said once it becomes functional, the government must now inject funds to support people with disabilities across the country.

"In a period of one year, the government has made progress in gender and disability inclusion including separation of the ministry for Community Development, Gender, Women and Special Group, from Health ministry," she said. The don further said that while doing that, the government must also consider providing subsidies to NGO dealing with people with disabili-

In her presentation entitled 'One year of presidency of Samia Suluhu Hassan', Dr Luhire said significant achievements had been recorded so far. She mentioned some of the progress achieved as more investment in building new reached so far, she appealed to the government schools, laboratories, universities, reverse the regressive laws against young mothers returning to school and more inclusive municipal loan requirements.

Others were review of gender and development of policy, new infrastructure in schools and health centres, embrace accessibility & inclusivity, inclusive education strategy and guidelines of early identification of children with disabilities. She said despite great achievement to change some laws such as the Marriage Act, discriminating laws and the review of personal with disability Act of 2010.

Senior Welfare Officer from the Prime Minister office, Olivia Njogopa said the government has set aside 5bn/- to construct market stalls for people with disabilities in six cities.

She said up to July 2021, the government had issued loans amounting to 53bn/- to 767 groups of people with disabilities.

RC declares war on peoples abotaging water projects

MWANZA Regional Commissioner Robert Gabriel has declared war on people sabotaging water projects implemented in various areas of the region.

Instead, he called upon residents of Mwanza Region to continue taking care of the projects for sustainable development.

The remarks were made early this week at the event to mark Water Week held at Mwamagili Village, Misungwi District on regional level.

Speaking on behalf of the RC, Magu District Commissioner. Salum Kali said if water sources are not protected, there will not be any water provision to the people

DC Kali said water is a necessity to every human being as it means life and that as for now the availability of safe and clean water in Mwanza Region stands at 66 per cent.

"According to report from Rural Water Supply and Sanitation Agency (RUWASA) national headquarters in Dodoma, the agency has signed 23 contracts for construction of water projects costing more than 70.2bn/-, which upon completion will serve 432,643, or 20 per cent of people living in rural areas of Mwanza Region, and added that the projects are set to be implemented between January this year and June 2024," he added.

He said once all projects are completed, the availability of clean and safe water will increase from the current 66 per cent to 86 per cent.

Earlier, in his report on the water situation in Mwanza Region on behalf of the region's RUWA-SA Manager, Godfrey Sanga, Emmanuel Mafuru said by February 2022, 544 villages were being provided with pipe water.

He said 449 villages enjoy clean and safe water services and those without were only 95, while work



on projects for the other 37 villages are still going on. He added that 178 villages have been placed in the budget plans for FY 2021/22.

He further said that all RUWASA projects at national level will be implemented within one year beginning January 2022 and will cost more than 60.7bn/-

Tanzania can well do with Gulf Zone trade outlets, investments

RELATIONS between Tanzania and the Gulf Zone are improving and taking a new turn, especially with the inauguration of a blue economy focus in Zanzibar over the past year.

There are also initiatives to boost and diversify trade between the two parties, one sphere being meat exports which has been the subject of substantive accords in the past few months.

The recent Dubai Exhibition, where a special day was set aside for Tanzania and elicited the presence of President Samia Suluhu Hassan, was a milestone.

There are follow-up events taking place, a notably significant one being a visit by Prime Minister Kassim Majaliwa to Qatar, where he held talks with his counterpart, Sheikh Khalid bin Khalifa bin Abdulaziz Al Thani, in which trade opportunities and finalising the required protocols were high on the agenda.

There is a joint commission for cooperation that is working to expand areas of cooperation between the two parties, according to the premier's preliminary remarks.

Contacts were encouraged in the form of enhanced consultations between the Tanzania Private Sector Foundation (TPSF) and the Tanzania Chamber of Commerce, Industry and Agriculture (TCCIA) on the one hand and Qatari trade organisations on the other.

A number of Qatari firms showed interest in exploring areas of investments in Tanzania, with the premier saying the government would coordinate their coming over for consultations with the relevant local stakeholders, via TPSF.

There was also an educational aspect meant to get students from Tanzania to study in Qatar and those from Qatar to study in Tanza-

nia, a cooperation format that helps to boost tourism and investments. Some remarks were made regard-

ing livestock processing interest. It can be said that what else can be done is ordinarily left to individuals to map out what to do. In this regard, reference can be made with respect of the scores of Chinese engineers, supervisors and other staff of construction firms putting up their savings to seek to purchase property once their working period is over.

Such investments boost the amount of capital circulating in the country, enabling the beneficiaries from property transactions to initiate bigger activities than the ones they were doing earlier before vacating their premises, urban houses or farmlands.

The only issue is to get the regulatory atmosphere right, so that Gulf investors start thinking of actual industry so as to use the wider regional market, even the much larger Continental African Free Trade Area (CAfFTA).

Accordingly, Tanzania ought to use its gateway position to a vast hinterland by localised investments.

All too often those moving investment promotions highlight the country's vast resources and stability status, at best thinking of every investor as someone who wants a piece of land to set up an industry.

These might indeed be the most important investors, but their influence in formal economy could be limited. They just would not employ large numbers these days, owing to artificial intelligence, so purchasing urban property or entering into joint ownership with locals as land prices go up would likely prove the real game changer. This is too often ignored.

Democracy isn't just behaviour but workable problem-solving methods

DEMOCRACY stakeholders in our country are bristling with proposals for reforming the way in which the political arena is administered, after more than half a decade of restrictions on activities of political parties.

It is evident that much ground has been covered, though the path ahead is uncertain, as the government wants restrained expression tied to what is being done in policy

It would also be happy seeing that, if there is wrongdoing, concerns should be raised in a procedurally sound manner, not rallying the people to demonstrations. The point has been made.

President Samia Suluhu Hassan has just received proposals and recommendations of a task force appointed by the political parties registrar, reacting to most of them and demanding precision on a few key demands, including that on an independent electoral commis-

The task force appeared to postpone expected follow-up on the key opposition demand for a new national Constitution until after the next General Election (come 2025), which the president similarly accepted.

Other proposals are being floated by well-placed stakeholders, among them the Legal and Human Rights Centre (LHRC).

Two proposals that the centre raised have been on the agenda since the multiparty system was restored, in 1992. We have thuds had 30 years of contesting the principle that presidential election results be challenged in court, or that we ought to have private candidates.

The trouble with the manner in which the proposals have consistently been made - and failed - is that they don't say what the likely scenario would be when they are put into application, and how it would thereafter be dealt with.

Those for the idea of presidential election results being contested in court are expected to show how that would not lead to instability.

This is a logical issue that hasn't been worked upon because the proposals are aired as if in pursuit of party loyalties rather than a well-considered view on managing the political platform.

Much the same is the case for private candidates - the belief that the idea of crossing to the opposition is daunting for most ruling party cadres.

LHRC, for instance, have not been very clear on how political rallies ought to be conducted, how far political parties would have to exercise restraint in what they say, or how this tendency can be checked by prior reforms to remove the crying need to "overthrow" the ruling party.

That is why a heavy dose of reforms to reduce the temptation to "take over" the state and all economic organisations it operates, by placing them under joint ventures with strategic investors, is essential for democratisation to move forward.

Holding back on democratisation isn't on the agenda at present, but walking into multiparty democracy without safeguards about political behaviour and its causes isn't much helpful either. And this explains the need to exercise care and caution

Beating corruption needs attitude change

FIGHTING corruption in Zimbabwe needs to not only tackle those who demand and take bribes, but the attitude, all too common regrettably, that a lot of people are on the take and all that is required is to find the right person, slip them a few US dollars and have what you

We have seen this in its latest manifestation with a woman who was quite ready to accept that two ZACC commissioners, and there are only nine, were quite ready to go far beyond their functions and help her have goods held by Zimra for non-payment of duty released, without any Zimra payment for duty and stor-

This is more astounding in many ways than the fact that a police superintendent and some of his buddies were allegedly running a criminal scam with two of the buddies pretending to be the corrupt ZACC commissioners and other people seeking victims to con.

We can expect con artists, and if the senior police officer is found to be one well this might be unusual, but sometimes police forces find they have criminals on the payroll and in most forces there are internal mechanisms in place to ensure a police force arrests more criminals than it employs, to quote the British Commissioner who cleaned up the Metropolitan Police 40 years ago.

But for a con to work the person being conned has to believe the lies they are told, and obviously in this case the conned woman was working on the assumption that corruption was so prevalent that even those sworn to lead the battle against corruption were willing and able, for a modest fee, to be more corrupt than many they hunt down.

So among the many threads in an anti-corruption programme is the need to get general acceptance that there is no alternative, but to go through the laid down process- lations are not there to make life es and follow the laid down rules.

If no one was willing to pay a bribe then there would be no brib-

Other forms of corruption exist of course, and we have seen this in the land scandals involving several municipalities where even the innocent who never paid a bribe were conned, along with others who knew something was not legal, but were prepared to pay a bribe for a false document.

Sometime people find the rules and regulations difficult to navigate. Here Government departments may need to be more user friendly.

A great deal has already been done in many departments to have staff who can at least explain what documents and fees someone must produce when requiring a service, and sometimes a person making a query needs a notebook and pen to write down the requirements and the steps they must follow.

Most civil servants, and for that matter police officers, are very familiar with the procedures in their office or station, but sometimes forget that the member of the public walking in is definitely not in this group.

Some, and Zimra is a good example, have built up websites that do explain what is needed to successfully navigate a procedure, but others need to do more.

Many of these rules and regu-

difficult. They are there to ensure that the process cannot be short circuited by the dishonest, either on the public side of the grill or the civil service side.

And there are some factors that have arisen in the past that require a couple of extra documents and checks, for deceit that the member of the public would have difficult imagining.

But what is critical is the necessary process to be clearly explained, and for notices and websites to be available that spell out what someone clearing a will, for example, needs to do, and what documents someone wanting to be compliant with tax laws must have and produce.

And then there must be a laid down complaints system. There is suspicion that some delays and the like are generated by those who seek a bribe. Perhaps, but a lack of competence is also possible and quite likely. But if there is a proper com-

plaints system in place then a lot of doubts can be resolved. Sometimes the complaint is not really justified; the process involved takes time although again the growing volume of information given to the public as a right should include time lines, so people know when something is not quite right.

And the complaints system must make it clear that if someone is angling for a bribe that this needs to be reported promptly, not just accepted.

Less and less of the corruption is done directly, with the corrupt driving examiners for example working through the driving schools so that no one can make a connection. But others are more obvious.

With the near universal possession of modern mobile phones evidence is now much easier to produce since a phone switched on and with the record button pressed can still be sitting in a pocket or bag gathering required evidence that will make the complaint very forceful.

Once everyone is willing to work within the system, and is willing to complain if something is not going right, corruption will be slashed.

Many civil servants and police officers are not corrupt and try under very trying circumstances to do their job properly and efficiently.

Efforts under the Second Republic have concentrated on getting the minority who are criminal or incompetent to join the majority or leave the service where they are employed.

The public can help that process by refusing to be involved in criminal activity, and paying a bribe is as corrupt as taking one, and by insisting that they are treated correctly and efficiently by those employed to serve them.

Even if you don't agree with traditional gender or family roles, you would agree that any decent human being would rush to the defence of the grandmother, and not concentrate on recording a video of your own mother being assaulted.

The view our society takes on the abuse and humiliation of those considered most vulnerable often reveals itself in seemingly innocuous, more benign incidences.

These more cut and dry horrendous incidences come about from repeated verbal, mental and emocackling crowd who stand tional violence. Far too often, those

as harmless jokes when what they mask and ultimately reveal is the horrific way we view women, children and the elderly and their right

We may insist that laughing is far from physical or even emotional abuse, but it is the lack of consternation in those instances that ultimately enables and indeed empowers this level of violence.

This outrageous incident occurred because of a decline in morality and ethical behaviour. Moral decay is often blamed on mass media, peer pressure and poor family involvement.

This family, just like the entire Namibia, should have a sit-down and find a way to heal. Namibia is an ailing society with disturbing levels of indiscipline, violence, rape, assault and fraud.

Gender-based violence and the disintegration of families have for some time been front and centre in cial evils we now face.

the media. The church, for so long the beacon of morals and ethics, has instead relegated itself to selling magic tricks and conning its clients.

Recently, so-called churches have been closed during a police operation in the North because of irregular activities on their premises. It is time for moral regeneration. However, we need to look to ourselves to improve. We need to be kinder to ourselves and each other, and make an effort to not resort to violence.

To address the moral decay we currently face requires more introspection and self-critique than perhaps we are willing to do. Viral videos and content where basic human dignity is trampled upon are a dime a dozen.

When our first reaction is to laugh, to reshare and not to condemn in those lesser moments, we bear just as much responsibility. To truly rid our society of these ills, we must address the attitudes in ourselves that allow these ills to grow and fester, and become the so-

Product quality, value addition key to success for women entrepreneurs

S more women continue making prominent appearances in business and entrepreneurship that were previously dominated by men, the main challenges they face include quality of products and value addition of the same to easily reach more customers in the country and export market.

Improving products in terms of quality as well as modern packaging with correct measurements is said to be the secret to success by entrepreneurs who have managed to capture local market and the export

This was highlighted in Dar es Salaam during recently during Women Industrial Exhibition Week which was coordinated by Tanzania Women Chamber of Commerce (TWCC) where women from across the country displayed their products.

The exhibition was officially opened by Minister of State in Vice President's Office (Union and Environment) Seleman Jafo who visited different pavilions and saw various products before officiating.

The one week of exhibition which was funded by the German Agency for International Cooperation (GIZ) attracted thousands of people who were eager to see different products made by women.

After visiting pavilions, Jafo expressed his excitement on how women some have improved in quality and value to their products, saying that is the only way to compete locally and export abroad.

He said that he was amazed at how many products made by women managed to get certified by Tanzania Bureau of Standards (TBS) and other qualify control bodies and hence managed to penetrate into the highly competitive international market.

"For sure I am very happy to see the improvement you (women entrepreneurs) have made within a very short period of time. I visited most of your pavilions and many of you have TBS certification which means you qualify to sell your product in foreign market," said Jafo.

The minister said women have shown their strength and managed to form different business groups and networks which have helped not only themselves but the nation as a whole in job creation for youth and

their fellow women.

Jafo said despite COVID-19 pandemic disruptions, Tanzania's economy has not been affected like other countries thanks to tremendous efforts and contribution made by women who continued producing goods that are exported.

"I commend you for this achievement. As a country we have reached this stage mainly because of your efforts since data show that you are good borrowers in the financial institutions who service loans timely," said Jafo.

"Don't feel inferior because you have all it takes to succeed. You are heroines of this country because you have done a tremendous job. I urge you to continue with this spirit."

The TWCC chairperson Mercy Sila said the organization has worked on creating enabling environment to boost women-owned businesses, adding that majority of successful businesswomen started with very small capital but grew the same as they improved on quality and value-addition.

Apart from growing financially and improving lives of their families, many women have made immense contribution to the country's economy by paying different taxes as most of them have established companies which are doing well, she said.

"We at TWCC and our board appreciate the government's efforts including creating enabling environment which has helped many women in the country to do their business smoothly. Business registration and formalization has been simplified in a way that a business person can register a company within hours," she said.

Sila said that in the past, many women entrepreneurs worried about certifying their products with TBS but the current trend indicates that things have changed for the better because majority have certified their products.

She added that many women entrepreneurs are beneficiaries of loans from different district councils all the country derived from 10 per cent of councils' total revenues, adding that evidence shows that women have been paying back with-

Sylvester said there is still negative notion amongst some Tanzanians that locally-made products are of inferior quality compared to the imported ones, adding that this false thinking retards not only the growth of women-owned businesses but the economy as whole.

Stela Kahwa, Acting Chief Executive Officer of Weight and Measures Agency (WMA) who participated in the exhibition advised women entrepreneurs to continue the spirit of improving quality and value addition for them to grow their busiout complications as is the case with nesses penetrate in international market

"I am happy to see a lot of improvement in this exhibition. I have seen a big difference between last exhibitions and this one because many of you have used the last training on packaging and measurements properly. I urge you to continue with this spirit," she said.

After the week of exhibition at Mnazi Mmoje grounds, aceremony to award best performers was held at Mlimani City Hall where the Chief Guest was Minister for Community Development and Special Groups, Dr Dorothy Gwajima.

Speaking during the ceremony, Dr Gwajima said women can do wonders if they are given a chance. She commended TWCC) for organizing the event, urging the organization to increase the number of trophies from the current 35 to 150 next year to motivate other women to engage in business.

"These awards are very important for women development because they encourage and inspire other women that they can," she said.

TWCC Chief Executive Officer Mwajuma Hamza said there were five judges who scrutinized entries from 16 sectors and eventually they came up with

35 winners from across the country.

She said there among the criteria used to select winners included sustainability of the business, strategic plan of the business, TBS certification and ownership of the business.

Kabongo Mbuyi, Team leader at GIZ Regional Programme Employment and Skills for Development in Africa congratulated TWCC for organizing the event and the tremendous work they have done so far to empower women across the country.

COVID diary at the forefront: A healthy dose of positivity

Γ was the third day in a row that the elderly man, a happy camper at the residential care home where I work, came out to the nurses' station to check on his neighbor, one of his close friends here.

He was there when his neighbor, a gastric cancer survivor, was rushed to the hospital in an ambulance after testing positive for COVID-19.

He got the hint when he saw no sight of his buddy days after the scene. The hospitalized neighbor didn't make it and became one of the casualties of the deadly patho-

The elderly man was gripped by panic, fearing that he might be next in line to come down with the coronavirus and be sent away.

Noticing his apparent despondency, I immediately contacted a social worker and arranged a video call for counseling. His family members were also duly notified and sent in their words of comfort via video link.

Many elderly residents in nursing homes have experienced anxiety, fear, solitude and the pain of losing of close friends. All of these were heightened by the pandem-

One elderly woman had a hard time accepting the reality. Before the pandemic, her husband, who always prepared little surprises of her favorite snacks, had visited her every day. As the pandemic worsened, outside food was banned, and so were the visits. The elderly residents were asked to try to stay in their own rooms in a bid to reduce contact with others and stop

Feeling depressed, she would come out of her room to argue with the nurses. Facing her wrath, all we could do was to try to calm her down and repeatedly explain to her what was going on. Of course, we also had a useful helping hand – her husband, who seemed to always be able to com-

Sometimes, this back-and-forth conversation would happened five times a day. It went on for a while until things took a turn for the better. Now, we have her tantrums only once every few days. I guess she had come to terms wit

When the first infection broke out in our nursing home on Feb 23, we called the families of all the elderly in our care.

Like everyone else, my family

to my post when they learned of the first infection at my workplace.

But I knew that if I flinched, the elderly, mostly unable to take care of themselves, would be left alone and unattended. It is not an option for me not to go to work. I had to keep the big picture of the whole nursing home's operation in mind and quit being self-centered. My family eventually came around.

On March 4, I began to show symptoms of a painful sore throat. I tested negative before work the next day. After the pain came back that evening, I got tested the next day but the result was still nega-

On March 7, the virus finally revealed its true colors - a faint line and a clear red line, which meant "weak positive".

In the following days, I stayed

also tried to talk me out of sticking in a hotel for quarantine to avoid passing the virus to my family and those at work. Even before I got infected, I had observed social distancing measures in our home. knowing fully well that I work in a high-risk environment. My food was served separately, and we always wore masks at home.

> So even under quarantine, I would check with my colleagues to see whether they needed my help since I had been responsible for liaising with residents' family members.

> I was cleared of the virus a week later and returned to work right away. In the morning, I would start my day by handing out medicines to about 60 senior residents, helping rubbing medical cream on some of them and cleaning their wounds. We have three nurses and two health workers who as-

The division of work blurred during the pandemic, which strained our manpower. When the first staff member was confirmed infected, we were left shorthanded. At the height of the outbreak, we were 10 percent down on our usual manpower. One caregiver had to take care of a dozen older

The nurses sometimes helped out with work that was usually done by caregivers, such as changing diapers and helping them take showers. And now we usually pair up to take care of residents to be more efficient.

With the weather getting warmer, even cleaning the resident's wounds would make me, dressed in full protective gear, sweat from head to toe. I would try to do things, such as drinking water

or going to the bathroom, at one go during my lunch hour to save myself the hassle of changing the protective gown, taking off face shield and masks. And normally, I would be five hours into my daily nine-hour shift when I can take my lunch.

Social distancing rules are also in place in the care home. We canceled mass activities, and the residents are advised to stay in their own rooms. But the difficult part remains keeping an eye on the sometimes unmasked elderly, who like to wander around to the lobby to watch television, one of their favorite activities here. It's even harder with some of the older adults who have Alzheimer's disease. They tend to forget your repeated reminders to put on masks and stay in their


In 2020, South Africa provided 81 percent of domestic funding to support TB activities. Zambia has increased its domestic funding sevenfold since 2015.

She insisted that increased funding from domestic sources and international donors is urgently needed if we are to counteract a reversal of the significant gains made against TB in the past decades.

"At the current rate of progress, the UN Sustainable Development Goals (SDGs) target of ending the TB epidemic by 2030 will not be achievable", said the WHO boss.

She added that with 36 percent of all TB deaths occurring in Africa, failure to invest in the TB response is set to take a formidable toll on African countries. Increased investment can be a game-changer, and alleviate the preventable suffering and death of millions of our people.

Growing fake medicine epidemic fueling a spiralling public health crisis in Africa's cities

ENS of thousands of people in Africa die every year from taking fake drugs. According to the World Health Organization, these are the world's most lucrative counterfeit goods, with a global market worth roughly \$200-billion. Africa accounts for around 42% of this demand because of the continent's badly monitored borders, weak legislation and poor healthcare services.

Gabon has recently emerged as a major destination for these drugs. In January 2020, over seven tonnes of counterfeit pharmaceuticals and cosmetics were destroyed in Libreville during a joint operation between the Gabonese Directorate of Medicines and Pharmacy and the Competition and Consumer Affairs Directorate against the illicit sale of counterfeit products.

On 23 December 2021, Gabonese customs officials seized a large shipment of prohibited pharmaceutical products from Cameroon and bound for Libreville. In January, Gabon's judicial authorities prosecuted traffickers from Congo-Brazzaville who had smuggled several boxes of counterfeit drugs, estimated at approximately \$34,000 (nearly 20 million francs), intended for sale in Gabon's main cities. Other products including dietary supplements and pharmaceutical stimulants were

Gabon's government has tried to stem the tide of counterfeit medicine sold in urban markets, but criminals have managed to circumvent these measures.


The smuggling of fake drugs has a long history in the country. Unlicensed medicinal drugs first appeared on Libreville's streets decades ago and have increased in range and accessibility. They were smuggled in from Benin, Côte d'Ivoire, Ghana, Nigeria and India, where genuine products are substituted with a substandard drug that excludes an active ingredient or contains a toxic substance. Tablets made in Nigeria appeared in corner shops before spreading to Libreville's main markets of Mont-Bouët and Nkembo.

Criminals selling counterfeit medicine include wholesale smugglers, cigarette vendors and street hawkers. They openly peddle fake painkillers, tranquillisers, cough syrups and rheumatism medication. Counterfeit drugs are frequently found at roadside stalls, which are common in cities but rarely regulated.

Most customers buy from roadside hawkers because fake drugs are cheaper and easier to obtain than authentic medicines. Consumers disregard professional medical warnings against taking them, not always realising the dangers these products pose to their health. In Gabon's major cities, medical experts have reported many deaths, severe

stomach and kidney ailments, and neurological disorders resulting from counterfeit medi-

The government has introduced several measures to curb the sale and use of these drugs. At the regional level, Gabon and 15 other African countries adopted the Rabat Resolution in 2018 – a new framework to address the problem. On the domestic front, anyone convicted of facilitating the purchase, sale, use, marketing, transport, import, processing, supply and distribution of counterfeit medicines can be imprisoned for up to 10 years or fined up to \$1,719,940.

Awareness campaigns have been rolled out to alert authorities and the general public to the threats posed by fake drugs. The government has organised prevention campaigns in high schools in larger cities, and Libreville's mayor has banned their sale in the city's

Despite these initiatives, counterfeit products are still being sold at markets across the Gabonese capital. Weak law enforcement fails to deter those manufacturing, selling and administering the medicines, so the trade in fake drugs continues.

Counterfeit medicines are a public health crisis for Gabon, and measures must consider the dangers of consuming these drugs. The capacity of police and prosecutors to detect, investigate, arrest and prosecute smugglers must be improved. This includes better border security and the use of improved surveillance and technology.

In partnership with pharmaceutical companies and digital service providers, Gabon should develop a technological solution that enables consumers to quickly and cheaply verify the authenticity of drugs purchased. The Mobile Authentication Service is a strategy in Nigeria that uses scratch codes and text messaging to empower consumers to check the quality and validity of medicines at the point of purchase.

These initiatives should complement police action that detects and disrupts major manufacturers and distributors in Ga-

These actions go hand in hand with a new holistic strategy developed by the United Nations Office on Drugs and Crime to combat offences related to fake drugs in Central Africa. The strategy's five pillars are awareness, legislative assistance, innovation, capacity building and cooperation. All those involved in the manufacture, distribution, regulation, law enforcement and consumption of medicines must work together to solve Gabon's counterfeit drugs problem. **DM**

Kilombero assures **Tanzanian** of sugar availability during fasting

THE Kilombero Sugar Company Limited (KSCL) has assured the public of sugar availability during the holy month of Ramadhan which is expected to start early next month.

Fimbo Butallah, the company's Commercial Head said this yesterday when speaking to journalists at the company's offices in Dar es Salaam. He said that KSCL has taken measures to addressing the issue of sugar shortages that often occur during the month of Ramadan,

Fimbo said: "We are aware that in a free market economy, we as producers are not in a position to set product prices for retailers. However we have a great responsibility to offer our advice to prevent arbitrary price increases, especially where we as sugar producers have not raised our product prices. We urge traders across the country not to raise sugar prices during the holy month of Ramadhan to avoid inconveniences to the public."

The statements comes from a history of rising prices of many food commodities each year during the holy month of Ramadhan, causing inconvenience to citizens, especially those who fast during the month of Ramadhan.

He urged all traders including wholesalers and retailers who sell 'Bwana Sukari' products to refrain from arbitrarily rising sugar prices, which has been a source of frustration for sugar consumers where the product is highly depended upon during the fasting period.

Fimbo revealed that Kilombero Sugar Company has enough sugar in stock to take the country safely through the holy month of Ramadan, adding the sugar manufacturer has already obtained permits to import sugar to close production gaps.

"We have already started the process of importing sugar which is expected to start arriving in the country any time from now. We would like to reassure the public on steady sugar prices, especially for the "Bwana Sukari" brand as the company has set strategies to address the problem of rising sugar prices which often occurs during Ramadhan," said Fimbo.

KSCL, in which Illovo Sugar Africa holds 75 percent of the shareholding and the government 25 percent is preparing for its expansion project that will double the company's sugar processing capacity and reduce sugar shortages in the

exercise. MACRA Director General Daudi Suleman said the Authority is synchronising data at the National Registration Bureau (NRB) so that it is accessible to mobile phone service providers for the purpose of SIM card registration.

According to the regulator, fraudsters use multiple SIM cards

on a single handset and that they use national identity duplicate cards or cards belonging to people who have died to register SIM cards.

He said there should only be one reference point for national IDs and that is the NRB.

Suleman said MACRA is spearheading a special taskforce involving several stakeholders to address rampant mobile fraud in the country.

It is therefore, our duty as MACRA to highlight some of these challenges as well as offer solutions to the problems to protect the consumers. Young greenpreneurs are turning waste into fertilisers and pavers

KIGALI

YOUNG greenpreneurs from different cities across the country are seeking easy access to finance to increase the production of organic fertilisers and pavers into waste.

Noel Nizeyimana, the Managing Director of Green Care Rwanda Ltd, told Doing Business that he processes 10 tonnes of waste every day, transforming them into fertilisers as well as pavers made from plastic waste in Huye district.

Waste entering into the Huye-based recycling plant is dominated by organic waste, which accounts for 75 per cent of the collected waste. Recyclable waste such as plastics is 8 per cent, papers and cupboards 6 per cent and others unrecyclable waste such as textiles 2 per cent, construction debris 1 per cent, grass 3 per cent and other hazard waste make up 3 per cent.

"We produce between 600 and 800 tonnes of packed organic compost per year by using the organic waste and 20 square metres of pavers from plastic waste per day. We sell one square metre at Rwf8,000," he said.

The firm's capital, he said, has increased from the initial Rwf1 million to Rwf35 million.

However, funding constraints are undermining their efforts to process waste into other products on a large scale, he added.

"We need a big machine that can help in mass production of pavers. For scaling up our organic fertilisers production business, we need the capital for replicating the waste management in other secondary cities and even in Kigali," he said.

Nizeyimana said that increased funding would help attract more youth in waste management.

"Banks do not consider solid waste management projects as bankable because it is social business. Even leaders and decision makers do not understand the concept. It should have a specific funding and financing model as well as technology transfer to be sustainable," he stated.

Nizeyimana added that Covid-19 pandemic has also derailed the progress to increase production and therefore access to recovery fund is needed.

"Our sales decreased during the pandemic and the organic fertiliser production reduced from two tonnes to one tonne per day," he said.

The recycling plant currently employs 25 people.

"We work with maize, chia and rice farmers in Huye district and we have 15 cooperatives that buy our organic fertilisers and four suppliers who distribute to other farmers," he said.

Felicite Nayinganyiki, a graduate from university of Rwanda in agriculture, founded Ineza Sustainable Agriculture Ltd which produces organic fertilisers from landfill site in Gicumbi district town.

She told Doing Business that she produces 100 tonnes of organic fertilisers per agriculture season and sells one kilogramme at Rwf50.

She said she also produces more 50 tonnes that are not packed in sacks per season.

"About 80 percent of the population in Gicumbi district are farmers. Therefore, I tapped into opportunities availed by waste," she said, adding that she is currently employing 15 people.

The greenpreneur said that she is also facing financial constraints to expand the business.

"Most of the youth have no collateral that can help them access loans in banks. We need modern machines to increase production. I also need a building for my operations because we are still operating in open space and we do not work when it rains," she

She said there is a need for availing loans to young greenpreneurs at lower interest rates.

"Agriculture needs particular loans. We also need partners who can help improve our business ideas and leverage financing," Nayinganyiki said.

Dominique-Xavio Imbabazi, another graduate from agriculture in university Rwanda, who recently won Rwf1.5 million award for the innovative project is producing one tonne of organic fertilizers per week in Musanze district.

He said he mixes earthworms with waste to pro-

The founder of Golden Insects Ltd said he also sells one kilogramme of fertilisers at Rwf200.

The case for scaling up organic farming

The organic fertilizer production, which promotes organic farming, is one of agro-ecology practices that need support to be scaled up across the country, agricultural experts have said.

Agro-ecology promotes farming practices that promotes environment protection through agricultural systems such as use of organic fertilizers and eco-friendly pesticides to ensure organic farming to produce healthy food without harming nature.

Thacien Munyamahame, the country programme manager at Youth in Agro-ecology and Business Learning Track (YALTA initiative told Doing Business that they are seeking to support those who aspire to agro-ecology in Rwanda.

"The youth in agro-ecology need access to market and access to finance so they scale up their businesses," he said.

He said that they are in discussions with the ministry of agriculture and animal resources to ensure agro-ecology is well integrated in agriculture planning and policy implementation.

Low smartphone penetration hits CBK's digital shilling plan

NAIROBI

THECentralBankofKenya (CBK) has warned that lack of access to smartphones by more than half of mobile users in the country will hamper the rollout of its proposed digital currency that requires access to the Internet.

CBK Governor Patrick Njoroge said in an interview that the smartphone hitch might force the bank to delay the rollout of the central bank digital currency (CBDC) -- a virtual version of the shilling which will exchange on a oneto-one basis with physical cash.

Official data show that 33 million or 56 percent of the 59 million cellphone devices are feature phones, making it difficult for half of subscribers to transact using CBDC.

Safaricom inpartnership with Google made a sales offer of one million affordable digital sets, with customers paying as little as Sh20 a day over nine months, aiming to switch

about four million 2G and 3G phones to 4G.

Dr Njoroge said the use of the digital currency on 4G-enabled phones would hurt Kenya's financial inclusion and effectively lock out half of the population from transacting in the CBDC -- which is meant to ease payments and cut transaction costs.

"The CBDC will have a minimum viable technology requirement, which may be a sort of fourth-generation environment. There is an argument to be made that such a development could lead to greater financial exclusion such that some people may fall out of the financial system just because we have adopted a CBDC... This is something we need to be careful about," said Dr Nioroge.

"We may decide therefore that we should wait a little more until everyone catches up because at this moment the lower-level technologies are quite prevalent with us."

invited public views on the potential introduction of the digital currency, in a departure from its original opposition to crypto assets. Kenyans have until May 20 to submit comments to the banking regulator.

The virtual shilling would work in the same way as physical hard currency, exchanging freely within wallets and in person-toperson payments.

Kenya pioneered mobile money payments with Safaricom's M-Pesa in 2007, but the central bank has not issued a digital currency due to concerns about the risks.

The risks include commercial banks being constrained by movement of deposits into the digital currency and financial exclusion of those without access to technological infrastructure or knowledge, the bank said on Thursday.

laundering, the CBK said.

The regulator, however, has highlighted a number of advantages in issuing a digital currency for the economy, including easing and lowering the cost of cross-border payments with other jurisdictions that design similar currencies.

It also views CBDC as a safer alternative to the existing, unregulated digital currencies such as Bitcoin, which it has in the past warned Kenyans against buying.

These cryptocurrencies are not tied to the value of an asset and are therefore highly volatile and speculative, with no recourse in case of loss through hacking or loss of wallet passwords.

Their value is also derived from processes like mining that are meant to maintain scarcity and anonymity which opens them up to abuse in dirty cash deals.

"CBDC could potentially shield the public from the A digital currency could risk of new forms of private money by providing safer and more trustworthy payment services than new

money-like instruments, such as stable coins," said the CBK.

In Africa, Ghana and Nigeria have already piloted their CBDCs, while Kenva. South Africa, Rwanda and Tanzania have been conducting research ahead of rolling out their own versions.

Nigeria, which launched Africa's first CBDC in October 2021, users are required to download the eNaira Speed application to use the digital currency.

According to the Pew Research Center, only 32.0 percent of Nigeria's cellphone users are on smart devices.

The Central Bank of Nigeria has expressed concern that the eNaira risks widening financial exclusion, partly echoing the CBK's views.

"More so, maximising the value and use cases of the eNaira depends largely on devices with Internet capabilities. The eNaira thus risks further alienating sections of the population

forms of privately issued who are uneducated, lack exposure and access to Internet services or digital devices," the Central Bank of Nigeria says in its design paper for the eNaira.

In Kenya, the CBK says deepening financial inclusion is not the core selling point for the CBDC.

"Some jurisdictions have pushed the idea that they would want to issue CBDC to improve the level of financial inclusion. Most of them would generally have low formal financial inclusion of 50.0 per cent or below," said Dr Njoroge.

"For us, our financial inclusion level is estimated at something around 85.0 percent up from 27.0 percent back in 2006/07. So, we have already made substantial inroads in financial inclusion."

The proportion of Kenya's population with access to formal financial services has been driven largely by mobile technology, especially M-Pesa -- which captures people without access to the formal banking

Banks borrowed Shs330b from **BoU** to meet financing needs

KAMPALA

COMMERCIAL banks borrowed Shs330b from the Central Bank to meet financing needs during the quarter ended January, according to Bank of Uganda.

The borrowing, provided under the Standard Lending Facility, seeks to create a safe buffer for banks facing financing gaps, many of which are recovering from the effects of Covid-19.

The Standard Lending Facility is a vital window through which banks and non-bank financial institutions borrow to meet financing needs

In the February Bank of Uganda Monetary Policy Report, the Central Bank said: "In the quarter ended January 2022, commercial banks accessed Shs330b through the Standard Lending Facility."

However, the Central Bank does not indicate which bank accessed the financing.

Bank of Uganda had last highlighted borrowing under the Standing Lending Facility in March 2021, during which three banks, which it did not name, had borrowed Shs155b to address short term liquidity needs.

In April 2020, the Central Bank created different financing windows through which constrained commercial banks could access financing to wade through Covid-19 disruptions.

The facilities had been created under the Covid-19 Liquidity Assistance Programme to mitigate challenges occasioned by Covid-19 such possible increase in nonperforming loans and reduction in income.

Other facilities such as the Emergency Liquidity Assistance, which was approved by Bank of Uganda in April 2021, were created to support banking institutions that were threatened with liquidity stress.

The facilities had been given timelines but some of them continue to operate due to existing uncertainties.

During the period ended January, the Bank of Uganda also indicated interbank lending which stood at 6.9 percent remained well anchored around the Central Bank Rate, which has in the last few months been maintained at 6.5 percent.

Poverty bites as locals in oil fields wait for pay-out

KAMPALA

AS government continues to prospect and explore oil wells in parts of western, central and northern regions, scores of homesteads that have been displaced by the quest to have oil exports ready by 2025 have lost farmlands.

In Kakumiro District in western Uganda, more than 200 people affected by the East Africa Crude Oil Pipeline (EACOP) have cited delayed compensation of their properties in the wake of signing of the tripartite pipeline between oil companies and Uganda and Tanzania governments.

Daily Monitor has established that the affected persons are mainly from Mpasana, Kisiita, Katikara, and Ntoroko sub-counties in Kakumiro.

The communities claim that they were promised compensation in 2018 but are yet to receive it.

Mr Stephen Twijukye, the Kyajawe Village chairperson in Mpasana Subcounty, said those affected have lost hope of getting their compensation.

Mr Twijukye said the delays have made their lives miserable since they are no longer allowed to use the land.

Ms Alice Kemizano, another affected resident, said she has not received information on her compensation package because her husband, who used to pursue the process, died.

"My land was largely affected by the pipeline project, including my two houses. My husband died recently and

and how I will be compensated," Ms Kemizano said.

Other residents claim they were under-valued for their land because of lack of clear compensation rates.

Mr Jasper Nshekanabo, a member of the project affected persons (PAPs) grievance committee in Mpasana Subcounty, said delayed compensation has left them in poverty.

"To date, we don't know how much we are supposed to be paid. We want our leaders to intervene and ensure that we are paid. People wanted to grow crops but they were told not to use the land, hoping that pipeline activities were going to start immediately," Mr Nshekanabo said.

The Kakumiro chief administrative officer, Mr Joram Sekitoleko, recently told the affected persons that the government will compensate them before the end of this month.

Mr Tom Baijana, a resident, said it was a wrong for government to start the project, saying oil is a non-renewable resource.

"Oil is not renewable, and we need to plan better as country but the mistake we have made is on making oil pipeline, if the oil wells dry up, what will be the use of pipeline? Instead, we should build many oil refineries for more employment," he said.

Taliban orders girl high schools remain closed

KABUL

THE Taliban yesterday backtracked on their announcement that high schools would open for girls, saying they would remain closed until a plan was drawn up in accordance with Islamic law for them to reopen.

Teachers and students from three high schools around the capital Kabul said girls had returned in excitement to campuses on Wednesday morning, but were ordered to go home.

The international community has made the education of girls a key demand for any future recognition of the Taliban administration, which took over the country in August as foreign forces withdrew. The United Nations condemned the reported closures

yesterday.The Ministry of Education had announced last week that schools for all students, including girls, would open around the country on Wednesday after months of restrictions on education for high school-aged girls.

On Tuesday evening a Ministry of Education spokesman released a video congratulating all students on their returning to class.

However on Wednesday a Ministry of Education notice said schools for girls would be closed until a plan was drawn up in accordance with Islamic law and Afghan culture, according to Bakhtar News, a government news agency.

"We inform all girls high schools and those schools that are having female students above class six that they are off until the next order," said the notice. country according to its interpretation said in a statement.

Why is the EU wary of cutting off Russian energy?

THE European Union is under mounting pressure from Washington to ban Russian energy imports as European leaders and U.S. President Joe Biden are set to meet and discuss deterrence measures against Russia at a summit here today.

However, member states of the bloc have not reached an agreement yet on whether a ban would be slapped on Russian energy in the EU. "Europe's supply of energy for heating, mobility, electricity and industry currently cannot be secured in any other way," German Chancellor Olaf Scholz said at an EU leaders' summit in France earlier this month.

Over 40 percent of the EU's natural gas and 25 percent of its oil consumption come from Russia. Germany has been holding on to its rejection of an abrupt ban.

The country's Foreign Minister Annalena Baerbock argued that the proposed oil embargo was a "question of how much we depend on oil" from Russia.

Other German leaders echoed Baerbock's concern. Minister for Economic Affairs and Climate Action Robert Habeck warned on Saturday that his country would not have enough gas to heat homes and keep industry going next winter if it does not obtain more gas and if deliveries from Russia are cut off.

Other EU members, such as Austria and Finland, have also warned against hastily banning energy imports from Russia. The sanctions imposed by the United States and Britain on Russia's energy sector in response to Russia's military operation in Ukraine have already sent shockwaves across the world's energy markets.

"The implications of a potential loss of Russian oil exports to global markets cannot be understated," the International Energy Agency said in a report released last week.

According to the agency, Russia's oil production disruptions could lead to the biggest supply crisis in decades. The prospect of an EU ban on Russian oil imports has already stirred the global energy market. On Monday, the crude price jumped more than 7 percent to 115 U.S. dollars a barrel as European diplomats were debating a possible ban on Russian energy imports.

Surging oil prices have pushed transport companies to the brink of bankruptcy in Spain, where truck drivers started a national strike a week ago. As the strike enters its second week, the disruptions to transport are causing food shortages, and certain areas in northern Spain are even at the risk of running out of tap water.

The knock-on effect of energy price spikes has sent the prices of many other items skyrocketing in Germany. The German Farmers' Association said that the price of fertilizer is five times that of the same period last year.

Association President Joachim Rukwied said he was convinced that food prices would climb because farmers and food processors would have to pass the inflated costs on to customers.

The European Central Bank has already lowered its projection for economic growth in the eurozone to 3.7 percent this year. There has been a consensus among European countries that the EU's dependence on Russian fossil fuels should be reduced, if not ended altogether.

The EU unveiled a plan on March 8 to reduce energy imports from Russia. According to the plan called RE-PowerEU, the EU is striving for independence from Russian fossil fuels well before 2030.

By diversifying gas supplies, speeding up the rollout of renewable energy, and replacing gas in heating and power generation, the EU is attempting to reduce its demand for Russian gas by two-thirds before 2030. In a post on social media, European Commission President Ursula von der Leyen proposed that the EU should phase out Russian fos-

sil fuels by 2027. Considering that the bloc is far from reaching energy self-sufficiency, it appears to be a daunting and almost unattainable goal to reduce its reliance on Russia, which supplies around 10 percent of the world's oil demand.

Even if the two members of the Organization of the Petroleum Exporting Countries -- Saudi Arabia and the United Arab Emirates -- with the largest spare capacity on standby are willing to beef up production, the shortfall in supplies in the event of the loss of Russia cannot be filled, according to analysts.

European officials have recently tried to convince some Gulf countries, including Saudi Arabia and the UAE, to increase their production to tame the soaring price of oil.

Saudi Arabia and the UAE have enjoyed a windfall from the oil price spikes since the Russia-Ukraine conflict erupted and categorically rejected calls to raise oil production.

Instead, they made it clear that they would stick to the 'OPEC Plus" commitment, under which OPEC members and Russia would increase oil production at a controlled

BRITAIN'S Prince William and his wife Kate arrived in Jamaica on Tuesday as part of a week-long Caribbean tour, hours after activists protested to demand reparations for slavery amid growing scrutiny of the British Empire's colonial legacy.

The Duke and Duchess of Cambridge arrived in Belize on Saturday to start the tour that coincides with Queen Elizabeth's 70th year on the throne, and will conclude it over the weekend with a visit to The Bahamas.

They were received by Jamaican foreign affairs minister Kamina Johnson-Smith and Defense Force Chief Antonette Wemyss Gorman at Kingston's Norman Manley airport. They then left to meet Governor General Patrick Allen, who represents the British crown in Jamaica.

China home to 813 intelligent mining, tunneling sections

A total of 813 mining and tunneling sections across China have been equipped with intelligent production systems, up 65 percent from two years ago, said an official with the National Mine Safety Administration (NMSA) at a regular press conference recently held by the Ministry of Emergency Management.

In particular, 477 of them are mining sections and 336 tunneling sections, up 43 percent and 109 percent from two years ago, respectively, said Sun Qingguo, director of the Department of Safety Basic Management of the NMSA.

been employed at over 370 coal mines across the country, he added.

A batch of intelligent mining technologies have made new progress. China has developed its first intelligent full-section rectangular tunneling machine and a smart hydraulic support with a mining height of 10 meters. Besides, smart systems for water detection and release have been put into use, and there are currently 146 autonomous mining trucks in operation across the coun-

The NMSA, in collaboration with

Besides, 29 types of robots have relevant departments, have rolled out a series of policies to make coal mines more intelligent. Fourteen provinces and autonomous regions, including Shanxi, Inner Mongolia, Shandong, Henan and Shaanxi, have also launched policies to support the construction of intelligent coal mines.

Recently, the NMSA has started making 92 relevant standards on intelligent control systems and auxiliary production systems. A working group for mining standardization under the National Information Technology Standardization Techni-

cal Committee was also established under the guidance of the NMSA, which has further improved the standardization system of intelligent

Supervision in the mining sector is more efficient. "We have vigorously promoted informatization and included 2,611 operational mining sites across the country in a national early warning system for mining safety," said Wang Duanwu, an official with the NMSA.

The progress made in intelligent mining construction has effectively improved safe production and sup-

plying ability of coal mines.

"The number of mining accidents dropped 46.8 percent in the first two months this year," said Zhang Xin, deputy head of the NMSA. According to him, the number of mining accidents and the number of people killed in mining accidents over the last year were down by 16 percent and 12.7 percent, respectively. The death rate per million tonnes produced hit a record low, he added.

EU fails to go extra mile on Russia clamps

JAKARTA

FOREIGN and defense ministers from the European Union meeting in Brussels on Monday failed to agree on new sanctions against Russia, with a mooted embargo on oil imports exposing some of the sharpest divisions within the bloc.

Going into the talks, the EU had announced four rounds of economic sanctions against Russia in the past three weeks in measures aimed at punishing the country for its military actions in Ukraine.

Member states such as Poland and the Baltic nations have been pushing for even tougher sanctions against Russia, including a total trade ban.

Some other member states, including Germany, with the largest economy in the EU, are more cautious about further actions, especially in the energy sector. They fear a huge blowback to their own economies in the form of massive unemployment and poverty.

"The question on an oil embargo is not a question of whether we want or don't want it," German Foreign Minister Annalena Baerbock told reporters on Monday.

"It's a question of how much we depend on oil and it's different between different European member states, and that's why it's important that we talk together about resilience

"For example, Germany is importing a lot but there are also other European countries that cannot stop importing oil from one day to the other. If we could, we would do it automatically but now we are preparing everything that we can go with these steps in the upcoming future, very soon," said Baerbock, who took up her position when a coalition headed by Chancellor Olaf Scholz took office in December.

Germany imports about 55 percent of its natural gas, 52 percent of its coal and 34 percent of its mineral oil from Russia; the EU, as a whole, imports about 27 percent of its oil from Russia.

"An agreement regarding possible EU sanctions against Russian energy supplies or their interruption will most likely not be reached," Hungarian Foreign Minister Peter Szijjarto said after the meeting. "We will not support sanctions that could pose a risk to energy supplies for Hungary."

Kremlin warning

Kremlin spokesman Dmitry Peskov warned that an oil embargo on Russia would have "a very serious negative impact on Europe's energy balance".

So far, only the United States and the United Kingdom have announced plans to ban or phase out oil imports from Russia.

Monday's meeting was held ahead of an EU summit on Thursday and Friday. US President Joe Biden, who will visit Europe later this week, will attend the EU summit as well as a NATO summit and visit Poland.

On Monday, Biden held a call with several European leaders, including Scholz, French President Emmanuel Macron, Italian Prime Minister Mario Draghi and UK Prime Minister Boris Johnson, to coordinate their efforts.

In the meeting, the EU foreign ministers agreed to provide Ukraine with a further 500 million euros (\$549 million) in arms and military equipment.

The EU's foreign policy and security chief, Josep Borrell, expressed the view that the bloc will continue to discuss further sanctions on Russia, especially in the energy sector. He pledged that the EU will keep providing all kinds of support for Ukraine.

The 27 member states approved the Strategic Compass, a plan aimed at boosting the bloc's security and defense by 2030, including in the Indo-Pacific region.

"The threats are rising and the cost of inaction is clear. The Strategic Compass is a guide for action," said Borrell.

A third of US COVID-19 cases now caused by Omicron BA2

NEW YORK

ABOUT one-in-three COVID-19 cases in the United States are now caused by the BA2 Omicron sub-variant of the coronavirus, according to government data on Tuesday that also showed overall infections still declining from January's record highs.

Despite the rise of the extremely contagious subvariant also seen in other countries, US health experts say a major wave of new infections here appears unlikely.

In the Northeast, including New Jersey, New York and Massachusetts, Omicron BA2 now makes up more than half the cases, according to data from the US Centers for Disease Control and Prevention.

It accounted for 35 percent of US infections for the week ending March 19, CDC said. That compares with 22.3 percent for the week ending March 12, which was revised down from 23.1 percent, according to a CDC model that estimates proportions of circulating variants.

Top US infectious disease official Dr Anthony Fauci said at a Washington Post event on Tuesday that he does not believe there will be a major surge soon, "unless something changes dramatically."

Still, Fauci noted that cases in the United States generally lag around three weeks behind the United Kingdom, "so if we are going to see an uptick, we should

Zelensky renews peace talks offer with Putin

UKRAINIAN President Volodymyr Zelensky renewed an offer of direct peace talks with Russian President Vladimir Putin late Monday, and Moscow has announced the first prisoner exchange between the two countries.

In an interview with Ukrainian media outlet Suspilne late on Monday, Zelensky said he was ready to meet with Putin "in any format" to discuss ending the almost monthlong "special military operation" that has shattered several Ukrainian cities.

Zelensky said even the status of Crimea and Russian-backed statelets in Donbas was up for discussion. It was the first time he said the status of disputed territories could be up for discussion and a possible referendum.

"At the first meeting with the president of Russia, I am ready to raise these issues," he said.

Although Zelensky signaled that he is willing to talk about the status of the three areas, he has repeatedly insisted all three are part of Ukraine and that his country would not surrender.

Satellite images taken on Monday showed Russian artillery positions west of Russian-held Antonov Air Base, northwest of Kyiv. Those positions resemble other Russian artillery positions, with earthen berms been built around them.

Damage from Russian military strikes was also visible in images of Irpin, northwest of Kyiv. Two distinct fires could be seen in central Irpin near a city government complex and other buildings.

Russia has not responded to Zelensky's meeting offer, but an-

nounced the first prisoner exchange between the two neighboring countries, Russian state media TASS reported on Tuesday.

"The first exchange happened. We returned nine of our boys," Human Rights Commissioner in Russia Tatyana Moskalkova said in an interview with RT, Russia's English-language TV news network. She confirmed that Russian servicemen were exchanged for the mayor of the Ukrai-

nian city Melitopol, Ivan Fedorov. The Office of the President of Ukraine also confirmed the exchange.

Russia announced that Moscow is ending peace treaty talks with Tokyo in light of new unilateral restrictions against Russia that Japan adopted in response to the Ukraine situation. Russia cited the "impossibility" of continuing discussions "with a country that has taken an openly hostile

position and is striving to cause harm to the interest of our country".

Japan and its Group of Seven allies have been united in imposing tough sanctions on Russian financial institutions and leaders.

The Russian Foreign Ministry said it was ending a visa-free policy for Japanese people to visit the disputed Kuril Islands which Tokyo calls the Northern Territories and was pulling

China-Myanmar 'Paukphaw' friendship flowers in Chinese village

AFTER she married a Chinese villager in north China's Shanxi province, San Hmwe, a Myanmese whose Chinese name is Ma Xiaoyue, settled in her husband's hometown and can now even speak fluent local dialect.

Ma and her husband Gao Baohong met and fell in love when they were both working in Myanmar. In fact, after hearing stories about China when she was little, Ma has always wanted to visit the big country.

Fourteen years ago, she came to Jingfeng village, Qinyuan county, Shanxi, with her husband. At first, Ma could barely understand Mandarin, not to mention local dialect. To fit in as soon as possible, she would learn Mandarin with TV shows every day and local dialect from residents in the village.

As she could speak Mandarin and local dialect better and better, Ma feels more at home here. Meanwhile, she finds her life getting happier.

In 2014, a resident working team was sent to Jingfeng village to help local people fight poverty. With a loan got with the help of the working team, Ma's family joined the village's cattle-raising cooperative.

"There are a dozen head of cattle in the cooperative, which are from various households in the village. Each household sends one person to pasture the cattle during the day in turn," Ma said, adding that raising cattle brings her family an annual income of more than 10,000 yuan (\$1,572).

Meanwhile, benefiting from government policy, her husband Gao became a forest ranger, and has earned an income of over 10,000 yuan a year by protecting and patrolling forests and mountains regularly.

As their income constantly increases, the living environment of Ma's family has also improved continuously.

Thanks to a project launched by Jingfeng village to renovate dilapidated houses, Ma's old house took on a new look. "The wooden window frames were replaced by aluminum alloy ones, and the earth walls were changed into brick walls," Ma recalled.

In front of Ma's house flows a river which is about seven or eight meters wide. In the past, people had to step carefully across the river on stone piers. In rainy season, the river would rise and submerge the stone piers, which made it difficult for children to go to school.

To help residents cross the river safely, the village built a new suspension bridge over the river last year. "I no longer worry about my kids being late for

school," Ma said.

Ma enjoys sharing the constant changes in her life in China with her mother and sister back in Myanmar when speaking with them over video calls.

"Our village has witnessed tremendous changes during the past few years," said Ma excitedly. By carrying out projects to improve the infrastructure, the picturesque village located in the hinterland of Taiyue Mountain has effectively promoted rural tourism in recent years.

Ma's family also took the opportunity to develop tourism-related business. "We have several spare rooms. So we decided to refurbish them to develop agritainment business on the advice of village cadres," she said.

While decorating the rooms, she also opened an account on a short video platform to share with Internet users her everyday life in Jingfeng village through livestreaming, winning thousands of followers.

Last year, the government of Qinyuan county promoted local agricultural products online, and Ma was invited to be a host to help promote the products via livestreaming platform.

"I was really nervous during my

Ma took part in several other livestreaming shows for sales promotion afterwards. "The number of viewers has gradually risen. I once helped sell several thousand yuan worth of products during one show, and my earnings also grew," Ma said.

A Myanmese song called "For Ma" was popular on the social media platforms in Myanmar a few years ago. Ma often uses it as background music when making short videos. The Chinese version of the song is "the world is so big but I still meet you", according to Ma.

"I feel like it is talking about how destiny leads me to my husband, and also the close "Paukphaw" (fraternal) friendships between the Myanmese and Chinese people," Ma said.

"Hand in hand we lived for so long. Though far apart, we do keep our story deep in mind," she quoted the lyrics.

UNICEF fears voiced for Ukrainian children

UKRAINIAN children today seem overwhelmed by fear, tears and sorrow, said a spokesman for the United Nations Children's Fund.

"Tve seen so many thousands of these children go ... husbands and wives farewelling each other, the fathers explaining to the little 7-year-old daughters or 10-year-old sons why they have to leave or why they're being separated," UNICEF spokesman James Elder told China Daily in an interview on Tuesday.

About 1.7 million Ukrainian children have fled their country so far, Elder said.

"We can see a refugee crisis, with Ukraine refugees in the fastest outflow, in terms of speed and scale, unprecedented since World War II and showing no sign of slowing down," said Elder from inside Ukraine.

"This already comes after the trauma of those children being in bunkers and under bombardment, so it's an incredibly dangerous, difficult and sad time for children across the country and for those many, many who have had to flee."

In cities like Mariupol, there is no water supply, no power and heating. "So children's destiny (is being) decided as we speak," Elder said.

"It's a very dark time for those who are trapped, and those in bunkers." Moreover, scores have been killed and many more injured.

He described the "absolutely harrowing" situation for children in Ukraine, and only an end to the conflict can serve them well.

Risk of separation

Like all children driven from their homes amid war and conflict, Ukrainian children arriving in neighboring countries are at real risk of family

UKRAINIAN children today seem separation, violence and trafficking.

"Now, the safest and fastest way out of this catastrophe indeed the only way out of this catastrophe is for this war to end, and end now. But until then, attacks in civilian areas and on civilian infrastructure must stop," Elder said.

"They must stop because they're claiming lives. They must stop because they're forcing people to miss out on essential health services, despite catastrophic needs. They must stop for millions of children remaining in areas of conflict in Ukraine."

A UNICEF team in Ukraine has been distributing truck after truck of medical supplies such as surgical, midwifery and obstetrics kits, oxygen generators and concentrators, as well as water, sanitation and hygiene essentials.

"Everything is needed right now," Elder said.

He also said UNICEF operates in neighboring countries where families can get information about support and protection services for those who had to flee.

Yet, "we must be clear, despite all those efforts in Ukraine from volunteers, Ukraine grandmothers to governments, from Ukrainian scouts and teenagers to United Nations agencies, so long as this war continues, the situation of Ukraine's children will only get worse".

"It's truly awful. I don't want to compare crises with everyone: there's Yemen, Syria and Ethiopia,... heartbreaking," Elder said. "But this one is no less, and it's just happening so fast. I haven't met a single Ukrainian who wants to leave their country."

World Cup draw seedings skewed by war, pandemic

NEXT week's World Cup draw will have some of its seedings skewed because of Russia's war with Ukraine and the COVID-19 pandemic.

FIFA outlined the procedure Tuesday for the draw in Qatar on April 1. Only 29 of the 32 teams in the draw will be known by then because of the war and global health crisis.

The three remaining places will be decided in June, one from Europe in matches involving Ukraine and the others from the intercontinental

At the draw in Doha, the 29 qualified teams will be put into four pots according to their FIFA ranking, which is based on national team results and will be updated the day before the draw.

Host Qatar is in Pot 1 along with defending champion France, Belgium, Brazil, Argentina, England and Spain. The final top-seeded team will likely be either Italy or Portugal, who are in the same play-

Germany, the 2014 World Cup champion, has been ranked outside the top 10 for more than three years and will be in Pot 2.

FIFA resolved the uncertainty around how to seed the three undecided entries by creating placeholder spots in Pot 4. The teams affected could land in a tougher World Cup group than their ranking merits simply because they could not complete their games as originally scheduled.

Besides Ukraine, Wales and Colombia are among the teams that could be affected. Each of the three, if they were to qualify, would likely have been in

Only 15 teams have so far qualified for the World Cup ahead of more games around the world over the next week.

Ukraine was scheduled to play at Scotland on Thursday with the winner advancing to play either Wales or Austria on March 29. Ukraine asked for a postponement because it was not possible for home-based players to train and travel during the Russian invasion.

The pandemic also created a backlog of games, wiping out nearly all national team soccer outside Europe in 2020 and causing the intercontinental playoffs to be delayed.

Those playoffs are scheduled to be played in Qatar on June 13-14. An Asian team will play a South American team, and the Oceania representative will play a team from the North American region.

World Cup draws are balanced to separate teams from the same continent. The 13 European nations will be allocated so that none of the eight groups has more than two teams from that continent.

The World Cup is scheduled to be played from Nov. 21-Dec. 18 in eight stadiums around the Qatari capital of Doha.

Pogba's World **Cup medal stolen** during burglary

FRANCE midfielder Paul Pogba said his World Cup winner's medal was among the items stolen during a burglary at his home last week.

Pogba's house was broken into on March 15 while his children were sleeping, with the incident taking place during Manchester United's Champions League match against Atletico Madrid at Old

The 29-year-old won the 2018 World Cup when France beat Croatia in the final in Russia.

"There were jewels from my mother, my world champion medal," Pogba told French newspaper Le Figaro on Tuesday.

"What scared me the most was that my two children were at home with the nanny during this in-

"She overheard everything, called my wife and security, then locked herself with the boys in a room. For several days, she was shocked. The main thing is that my children are well."

Pogba, who is in the France squad for friendlies against Ivory Coast and South Africa, also opened up about the mental health issues that he has faced during his career, particularly under former Man United boss Jose Mourinho.

"I've had depression in my career, but we don't talk about it," he said.

"Sometimes you don't know who you are, you just want to isolate yourself, be alone. These are unmistakable signs.

"Personally, it started when I was with Jose Mourinho at United. You ask yourself questions, you wonder if you are at fault because you have never experienced these moments in your life.

"All top athletes go through these moments but few talk about it. Inevitably, you will feel it [depression] in your body, in your head, and you may have a month, even a year, where you are not well. But you don't have to say it. In any case publicly.

"We earn a lot of money and we don't complain really, but that doesn't prevent us from going through moments that are more difficult than others, like everyone else in life."

World Cup playoffs: No Ronaldo, Salah or Italy? What's at stake?

CAN vou imagine a FIFA World Cup in Qatar without Portugal's Cristiano Ronaldo or Egypt's Mohamed Salah? Or a tournament in which European champions Italy or African champions Senegal fail to qualify? Well the bad news for those mentioned, and fans across the globe, is that some of the game's headline acts will see their Oatar 2022 dreams extinguished in the coming days during the World Cup play-

By the end of this international break, seven nations will have booked their place in this year's World Cup through the playoffs. Three more will be confirmed when the Intercontinental playoffs and the culmination of the European path involving Ukraine take place in June.

In Europe, some of the major nations, including Portugal and Italy, are walking a tightrope after failing to top their qualification groups. And in Africa, five head-to-head ties over two legs will see some of the continent's traditional powerhouse countries miss

It promises to be a tense and dramatic round of playoffs in Europe and Africa, so here's your guide as to how it will all play out.

*How it works

In Europe, the 10 runnersup from the group stage, plus the two highest-placed teams in the 2021 Nations League who failed to achieve a top-two group finish (Austria and Czech Republic), have been drawn into three separate playoff paths.

Each path has four teams, with two one-legged semifinals feeding into a one-off final. The seeded team is at would not play any game home in the semifinal and a against the Russians. draw has already taken place to decide who has home advantage in the final.

So there is no margin for error. It's one game, in both the semis and the final, to decide who qualifies.

Path A involves Wales vs. Austria in Cardiff (Thursday, 2.45 p.m ET., stream live on ESPN+) and Scotland vs. Ukraine in Glasgow, meeting to set up a final in Cardiff or Vienna. However, the conflict in Ukraine means this path will not be concluded during this international break.

Path B was due to be Russia vs. Poland in Moscow and Sweden vs. Czech Republic in Stockholm (Thursday, 2.45 p.m ET., stream live on ESPN+), feeding into a final held in either Moscow or Chorzow, but Russia's invasion of Ukraine has led to FIFA kicking the 2018 World Cup hosts out of the competition. Poland get a bye.

Path C is the real show-stopper, with Portugal vs. Turkey in Porto (Thursday, 2.45 p.m ET., stream live on ESPN2) and Italy vs. North Macedonia in Palermo (Thursday, 2.45 p.m ET., stream live on ESPN+) potentially setting up a clash between Portugal and Italy in Porto for a place at the World Cup. Turkey will play Italy or North Macedonia in Konya if they beat Portugal on Thursday.

In Africa, there is slightly more breathing room for the teams involved, with five separate ties being played over two legs. But some of Africa's biggest teams and stars will miss out, with the winners of each tie qualifying for Qatar. Here's the draw:

World Cup playoffs?

Following Russia's invasion of Ukraine last month, FIFA suspended Russia from all competitive football. The Russian Football Union (RFU) appealed against the decision at the Court of Arbitration for Sport (CAS), but that was

rejected on March 15. Prior to Russia being kicked out of the playoffs, the national associations of Poland, Sweden and the Czech Republic -- Russia's Path B rivals -- all issued statements insisting they

Poland have now been given a bye to the Path B final and will face either Sweden or the Czechs at Slaski Stadium in Chorzow on March 29.

In Path A. the Ukrainian Association of Football (UAF) requested a postponement of their playoff against Scotland. More than half of the Ukraine squad play their football in the country, so the majority of their players are unable to leave or prepare for a World Cup playoff.

FIFA has sanctioned the postponement, and although no date has been confirmed for the Scotland-Ukraine game to be rescheduled, sources have told ESPN that it is hoped the fixture may be played in June. However, if the conflict continues, FIFA faces a tough decision in terms of a cut-off point for Path A to be concluded.

The other semifinal between Wales and Austria will take place in Cardiff on Thursday, with the winners then playing a home tie against Scotland or Ukraine in the final at a time and date to be decided.

*Who are the big names who could miss out in Europe?

One of the last two European champions won't make it. Thanks to Portugal and Italy being drawn in the same path, one of the biggest nations in world football won't qualify for

Failure to qualify would be disastrous for Italy. The four-time World Cup winco (Friday, 10 a.m. ET, stream ners missed out in 2018

after losing a two-legged playoff against Sweden, but they now risk the same fate less than 12 months after beating England in the Euro 2020 final.

A 90th-minute penalty miss by Jorginho against Switzerland in Rome last November cost the Italians top spot in Group C and has now left the Azzurri needing to beat North Macedonia before a one-off final against Portugal or Turkey for a place in Qatar.

It's also possible there will be no World Cup swan song for Cristiano Ronaldo in Qatar. The 37-year-old, the all-time leading goal scorer in men's international football, has said he will retire from international duty after the World Cup, but he may not get that far. But for a 90th-minute goal for Serbia scored by Aleksandar Mitrovic in a 2-1 win in Lisbon last November, Portugal would have avoided the playoffs and qualified as group winwinners face two tough games to qualify.

In Path B, 40-yearold Zlatan Ibrahimovic is back in the Sweden squad and aiming to make it to Oatar after missing the 2018 competition. But if the AC Milan forward gets there, it will mean no World Cup for Bayern's Robert Lewandowski, whose Poland team await the winners of Sweden vs. the Czech Republic in the final after their bye against Russia. So we could be set for a Lewandowski vs. Ibrahimovic showdown in Chorzow on March 29.

The Confederation of African Football (CAF) performed the draw for the African playoff route on Jan. 22, which was the midway point of the 2022 Africa Cup of Nations in Cameroon. As a result, the seeded draw was based on the FIFA World Ranking prior to the tournament, with the five highest-ranked teams in one pot and the remaining teams in the other.

The downside to that decision has been borne out in the playoff draw, which will see the two AFCON finalists -- Senegal and Egypt 2022 World Cup. If CAF had done the draw after the team which goes through tournament, Egypt would have been among the top seeds and Africa would not

have been faced with two of its best teams battling it out for one place in Qatar.

But aside from one of Africa's best two teams missing out, we also face either Sadio Mane or Mohamed Salah failing to qualify for the World Cup. Mane and Salah are two of the biggest, if not THE biggest, stars in African football. They are also stellar names in the Premier League and Champions Leagues following their goal-scoring feats with Liverpool. But one of them will be spending November and December at home while the World Cup plays

Cameroon vs. Algeria will see one World Cup regular qualify at the expense of another, while two of the traditional giants of African football, Ghana and Nigeria, will also play for one

*Are there any other playoffs?

Qatar is staging a fourto the Intercontinental playoffs from the Oceania (OFC) region.

However, an outbreak of COVID-19 infections forced Vanuatu to withdraw from the qualifiers over the weekend and the Cook Islands have also revealed a number of positive results, so the Solomon Islands and Tahiti are expected to progress by default and face New Zealand and Fiji in Qatar this week. The winner of the Oceania playoffs will then face the fourth-placed team in North America (CONCACAF) in Qatar on June 13-14 for a place at the World Cup.

The fourth-placed team in Asia (AFC) will face the fifth-placed team in South America (CONMEBOL) for one qualification spot in Doha on June 13-14. Ahead of the final round of qualifiers, the AFC team will be either Australia or the United Arab Emirates, to play against Peru from CONMEBOL.

*When is the World Cup draw? It's closer than you think. The draw for the group stage of Qatar 2022 will be on April 1 at the Doha Exhibition and Convention Center at 7 p.m. local time

(4 p.m. GMT / 11 a.m. ET).

Thirty-two nations will be drawn into eight groups of four and the draw will be seeded based on the FIFA World Ranking. Those teams involved in playoffs in June will be assigned groups on a qualifier TBC basis.

Teams from the same continental confederation, other than UEFA, cannot be paired together in the same group. A maximum of two UEFA nations can be placed in the same group.

The 2022 World Cup starts on Nov. 21, with hosts ners. Now the Euro 2016 -- meeting for a place at the team playoff between Qatar playing the opening March 27-30 to decide the game at the Al Bayt Stadium in Al Khor. The final will be staged at the Lusail Stadium, Doha, on Dec. 18.

Nyambui recently announced that he will encourage his athletes to look for international events, saying they will keep the athletes psychologically ready for the Commonwealth Games.
