## in key construction work'

THE government has called for increased participation of local contractors in the implementation of major construction projects.

Works minister Innocent Bashungwa (pictured) said this in the direction of the Tanzania Roads Agency (Tanroads) at a consultation meeting with contractors and the regional authorities to discuss local contractors' role in project imple-

He expressed satisfaction with Tanroads' procedure of setting aside projects to be taken up by local contractors to help them grow and gain experience in managing major projects.

During fiscal 2023/204, four road projects of 50 kilometers each have been allocated for local contractors, which is an opportunity to build the capacity of local contractors, he said.



have been allocated to women contractors, in pieces of five kilometres each, bringing to 220kms of roads to be built by local contractors for the current financial year, he stated.

Road maintenance works managed by Tanroads using funds from the Road Fund at 600bn/- will be carried out by local contractors, he said, affirming that

President Samia Suluhu Hassan has decided that road maintenance should be managed by local governments.

The law on public procurement has been amended to increase the value and number of projects to be implemented by local contractors without competing with foreign contractors, he declared.

Finance minister Dr Mwigulu Nchemba asked the contractors to take advantage of the opportunity that President Samia has given them, making best use of opportunities that come their way.

The government expects to increase road maintenance funds disbursed each month to Tanroads so that it speeds up debt payments to local contractors.

CCM secretary general Daniel Chongolo said at the occasion that the party's election manifesto for 2020-2025 promised to ensure that it creates an enabling environment for local contractors.

He appealed to them to work according to the rules, ethics of the profession, while the meeting explored strategies for collaboration between the government and stakeholders in the construction industry.

NEARLY 52m Tanzanians are using mobile financial services, the Tanzania Communications Regulatory Authority (TCRA) has declared.

Semu Mwakyanjala, the TCRA corporate communications officer, made this observation yesterday at the threshold of the national financial services week slated for the Sheikh Amri Abeid Stadium, with Prime Minister Kassim Majaliwa hopefully officiating at its opening.

He said that Tanzania is a pioneer in digital inclusion in Africa with more than 90 percent of the country's residents actively accessing mobile financial services.

Back in September, TCRA director general Dr Jabir Bakari said that the number of active SIM cards stands at 67.1m, which by implication shows that many people are accessible with simcards of their close relatives.

However, TCRA cautions against racketeers using the same platform to swindle gullible users of their hard earned cash, citing messages from unknown senders luring people into joining dubious projects or lotteries, all of which seek to grab and go.

Such messages are rampant even though the culprits are being arrested on a daily basis, he said, urging phone users not to re-

## French companies seek health care, aeronautics partnerships

French SMEs are eager to engage with their Tanzanian counterparts to learn from them and improve their products in order to make them more suitable for the Tanzanian market

A DELEGATION of 13 French companies is in the country for a three-day visit seeking business and investment partnerships with Tanzanian firms in health-

care, aeronauts and services. Nabil Hajlaoui, the French ambassa-

dor, told journalists in Dar es Salaam on Monday that the delegation of small and medium sized enterprises (SMEs) is exploring business and investment opportunities in a number of potential sectors.

The firms opted to seek commercial opportunities here as the country's economy is growing with increased value of investment, he said, noting that the country's foreign direct investment (FDI) rate has now reached 18bn/- per year.

The visit marks a new step in Franco-Tanzania trade relations, he said, affirming that business ties are dynamic, illus-

Mourad Chouiga, head of the delegation and regional manager for eastern, southern Africa and Indian Ocean at Bpifrance, said there are investment potentials in Tanzania, where French companies can partner with local firms.

The first mission of French SMEs to Tanzania took place last year.

Bpifrance is a French public investment bank devoted to financing companies at each stage of their growth through loans, guarantees and equity.

## DRC's opposition leader Moise Katumbi launches presidential campaign

**KINSHASA** 

OPPOSITION leader, Moise Katumbi, officially launched his campaign for president of the Democratic Republic of Congo at a rally in Kisangani on Monday, one month ahead of the election.

The 58-year-old millionaire businessman has promised to fight graft, create jobs, and reform the country's ailing economy.

He has criticised incumbent President Felix Tshisekedi's record in the DRC's volatile east, where the army has been battling M23 rebels and other armed groups.

Katumbi claimed the president was recruiting foreign mercenaries instead of increasing the salaries of military and police.

"The current government has promised you a lot. I'm telling you that these stories will never be repeated. I'm telling you that we're going to improve the conditions of our soldiers who must defend our country, and we're going to drive out all these forces that are in our country," he said at the rally.

Young people attending the rally in Kisangani said they were eager for change five years after Tshisekedi came to power in the disputed 2018 election that Katumbi was blocked from taking part in.

"They promised us security, nothing happened. They promised employment, nothing came. They

promised road construction but nothing, they have done nothing good," said Abdullah Simba.

Katumbi's rally came a day after his two main competitors, Tshisekedi and opposition figure Martin Fayulu, started their campaigns ahead of the 20 December vote.

In 2018, Katumbi attempted to run for president but was thwarted by President Joseph Kabila's government, which cancelled his Congolese passport while he was out of the country.

His critics this time question his eligibility for the presidency, alleging his father was not a Congolese citizen. However, a top court last month threw out a lawsuit seeking to block Katumbi from running.

Several opposition candidates have withdrawn from the race and thrown their support behind him.

## Africa's shortage of dollars pushes more countries to economic crises

AFRICA is in the grip of a dollar drought and the current continentwide scarcity of the US dollar is further pushing many already beleaguered African countries into deeper economic crises, according to a new Bloomberg report.

Several Sub-Saharan African (SSA) countries, including Kenya, Nigeria, Ghana and Tanzania, have for several months experienced

shortages of the greenback, which ers and local businesses as import are also steering clear of countries is a huge challenge for businesses on the continent, as the US dollar is the dominant currency in international transactions. The Bloomberg report also states that governments are now turning to bartering, currency devaluations, central bank exchange controls, and help from the International Monetary Fund (IMF) and the Middle East to shore up their balance sheets. The dollar shortage is also hurting consum-

costs soar, fueling inflation, the report noted.

In the same vein, it noted that investors are rewarding nations whose efforts to boost dollar liquidity are paying off, but are punishing those that can't guarantee access to the currency they need to invest and repatriate returns, and are steering clear of countries without adequate reserves to cover import costs or debt repayments. They

without adequate reserves to cover import costs or debt repayments. "African currencies are the worst performers in the world this year, with about a dozen sliding at least 15% against the dollar," the report added. #### India's External Affairs minister calls for use of local currencies in foreign trading

BUSINESS leaders and bankers in Tanzania and India have been urged to employ the use of local currencies in trading activities as the move will add an alternative trade volume for both countries

Shri V. Muraleedharan, India's Minister of State for External Affairs & Parliamentary Affairs made the call yesterday when addressing 30 Indian business delegates and investors at the finale of a three-day Tanzania Business Forum at the Indian High Commission in Dar es Salaam.

Minister Muraleedharan said the application of such innovative mechanisms would businesses from both ends.

"India is actively promoting trade in local currencies and Tanzania is among our earliest partners in this endeavour. A few transactions are already taking place using the mechanism of payment in Indian rupees and Tanzanian shillings. This new trade mechanism will provide an alternative trade avenue for businesses on both sides. And I call upon Indian & Tanzanian banks and business leaders to support and promote this innovative approach," he said.

He also added that with India amounting to become the fifth largest economy globally, the government is vigorously pursuing economic reforms which will offer opportunities for Tanzanian businessmen to become part of our growth story.

According to India's Cabinet member, India investments in Tanzania have been rising to \$3.7bn spanning in various sectors from pharmaceuticals, hospitals, education, mining and Agroprocessing, highlighting that with the newly proposed 1000-acre industrial park near Dar es Salaam, the move will be a significant boost to Indian investors in Tanzania.

He also hailed President Samia Suluhu Hassan efforts to cement bilateral ties between the two

last month, adding that President Samia had pushed for establishment for a hub for manufacturing pharmaceuticals, Agro-processing and traditional medicines in Tanzania as a gateway to East Africa and key transit trade point.

Ambassador Mbarouk Nassor Mbarouk, Deputy Minister for Foreign Affairs and East Africa Cooperation commended the visit by his ministerial counterpart and the business delegates highlighting India as among the top five investment sources in Tanzania.

"To see a business delegation from India accompanied by the minister of external affairs is a clear testimony that the state visit in India by president Samia was a very fruitful one. Tanzania and India share a vibrant economic partnership in the areas of trade and investment that made India to be the fourth largest trading partner of Tanzania with a bilateral volume of \$6.5billion currently," he said.

He added: "Five years ago, the figures whereby \$2.6billion, this shows that the trade and investment relation between Tanzania and India is continuously growing very fast."

## Dar, Oslo varsities team up to address ethical dilemmas in clinical practice

THE University of Dar es Salaam (UDSM) in collaboration with Oslo University of Norway is undertaking a capacity building training of ethicists and healthcare professionals at Mbeya Zonal Referral Hospital (MZRH) aimed at addressing ethical dilemmas in clinical practices.

The four days training is run through the Enhancing Ethics and Integrity in Medical Research and Clinical Practice (ETHIMED) project that runs from 2022 - 2026, funded by the Norwegian Partnership Programme for Global Academic Cooperation (NORPART) called for handling daily ethical dilemmas emerging in clinical practices.

The project is being implemented by UDSM through the Department of Philosophy and Religious Studies, University of Oslo (UiO), Norway through the Centre for Medical Ethics and the University of Rwanda to address the emerging challenges in the areas.

Speaking at the opening of the training, coordinator for programme Lukas Kitula said the course is essential for the Sub-Saharan context due to increased moral cases in clinical practice.

"Yet, there are no established clinical ethics support services to assist healthcare professionals in addressing them" he said.

He named some of the cases as intercultural issues in healthcare settings, religious issues conflicting with biomedical interventions, and allocation of medical resources in the healthcare setting encountering need such guidelines.

He said the programme will also facilitate the establishment of an ethical committee which will be addressing clinical dilemmas contrary to the discipline committee which has been there to discipline those who breach ethics.

He said Tanzania will be the second country to have such committees as countries like Norway have such committees in all their main hospitals.

Dr Shija Kuhumba, from UDSM expressed the need to develop clinical ethics guidelines for healthcare professionals but also incorporate clinical ethics courses into the educational curriculum in health and allied science programmes.

He said the committee will not replace the disciplinary committee saying it will focus on issuing guidelines which will help in overcoming professional dilemmas by discussing with patients to address challenges.

He said the committee will involve lawyers and religious leaders who will be given special training when the committee will be operational in February 2024.

#### US ambassador applauds outreach services via mobile clinic in Mbeya Region villages

THE US Ambassador to Tanzania commended Michael Battle outreach initiatives implemented Medical Research International (HJFMRI) for bringing HIV prevention services, including voluntary male circumcision (VMMC), closer to the community using a new mobile van clinic.

Ambassador Battle visited the VMMC mobile van last week at Mjele village in Mbeya District Council.

"I am thrilled to see you here, and I will always pray for you," said Ambassador Battle "I will ensure my government will continue to support this initiative, and I am happy this mobile clinic van is reaching you," he said.

VMMC is an evidence-based HIV prevention strategy. Research shows that being circumcised reduces the risk of acquiring HIV by 60 percent. VMMC also protects against other sexually transmitted diseases, such as HPV, which can cause cervical cancer in women.

James, a client who received mobilize men who are eligible for VMMC services during the ongoing outreach, told Ambassador Battle that with the availability of the van in his village, he was able to receive services he always dreamed of having. Distance to healthcare had previously prevented him from receiving these services.

Chairman of Mjele Village, Emanuel Masebo, says his village has a population of 6,738, and the majority travel 30-50 kilometers to access healthcare services when they are in need.

He said the availability of the VMMC mobile van has dramatically impacted many men who need the services.

"I am told every day more than 20 men are visiting the mobile clinic to access the services at their convenience, even at night. We wish the service could be prolonged for at least two to three months," said Masebo.

Dr Castro Masanja, Acting VMMC Senior Advisor at HJFMRI, said peer educators travel around villages and Health.

the services according to PEPFAR guidance and direct them to where the van is stationed in the village.

"Most of the people in this area are pastoralists, and with this van, we can reach them where they are," said Dr Castro. We provide VMMC and other HIV prevention services including HIV self-test kits, condoms and PrEP services," he noted.

From October 2022 through September 2023, more than 140,347 men aged 20 years and above received free VMMC services provided by HJFMRI in the regions of Mbeya, Songwe, Rukwa, Katavi and Ruvuma.

#### LHRC urges govt to work on 11 issues in the recently tabled electoral reform bills

THE Legal and Human Rights Centre (LHRC) has issued 11 recommendations for improvements of recently tabled electoral reform bills to strengthen democratic processes in the country including establishing a system to recruit the chairperson of the National Electoral Commission

The government recently tabled the National Electoral Commission bill 2023, the Political Parties Affairs Laws (Amendment), bill 2023 and the Presidential, Parliamentary and Local government Elections bill, 2023, to be read for the first time in parliament in the just ended seating.

Addressing journalists in Dar es Salaam yesterday, LHRC Managing Director Dr Anna Henga said the new reforms should include allowing prisoners to vote but also making constitutional reforms to create a system for the recruitment of the chairperson and deputy of the electoral body.

"The bills should clearly show the qualifications of the commissioners of the electoral body by restricting them to be members of a political party five years before elections but also formulate a body to solve conflicts in political parties," she

She said the new bills should also include a requirement for a national debate for all presidential aspirants.

"The bill should also create a system which allows the diaspora to vote in a system which will be indicated by the commission," she added.

She further said the government should table a bill in the coming parliamentary seating to let the electoral body oversee the local government elections instead of the case now where the ministry responsible for local government manages the elections.

"The bill should also put in place a

system which should allow political parties and other stakeholders to take part in voter registration updates together with the electoral commission," she said.

She said the government should come up with a system to let the citizenry to register themselves as

voters through agents. Dr Anna said a section in the bills which requires a voter to pay for a lost voter card should be removed as doing so will deny several eligible voters from exercising their rights.

She faulted some of the sections including that which gives the director of elections to be the secretary for the recruitment team.

Ther tabled bill proposes that Chairman and Vice Chairman will be required to be judges of the Court of Appeal and the High Court with qualities to be an advocate practicing not less than 15 years.

Section 9(3) of National Electoral Commission bill 2023, proposes establishment of a recruitment committee for commissioners in which the direct of elections will the secretary.

## Serengeti beats 200 other national parks in Africa in Safari Bookings

FOR the fourth consecutive time, Serengeti National Park in Tanzania has emerged the best African Safari Park from the 2023 study conducted through Safari Bookings.

SafariBookings.com, is the largest online marketplace for African safaris and has conducted the study to determine the 50 best African safari parks for 2023.

The remaining 1,114 park reviews were written by renowned international safari-industry experts, including guidebook authors working with Lonely Planet, Rough Guides, Frommer's Bradt Travel Guides and Footprint. According to Safari Bookings,

The commencement of the MoUs entered in May this year marks the beginning of extending communication services by connecting 1,974 wards with 5,111 villages through the construction of 2,149 new mobile towers.

The new towers are however expected to boost the penetration of the current 2G, 3G and 4G internet speeds from the current 69 percent, 62 percent and 50 percent to over 90 percent respectively.

Justina Mashiba, UCSAF Chief Executive Officer made this observation to journalists yesterday in Dar es Salaam saying that the target is to boost connectivity especially in remote areas.

Mashiba said that so far 1,197 wards with 3,613 villages with approximately 14,572,644 residents have been connected to communication services such as internet, mobile money and calls, after 1,321 towers were constructed in those wards.

According to her, the mobile towers construction project that fetches 326bn/- is ongoing in another 777 wards formed by 1,498 villages and domiciled by 9,226,204 people.

Speaking of the state of communication in the country, Mashiba said that 1,120 schools have been provided with ICT equipment, with each school being provided with an average of five computers, one printer and one

"For the financial year 2022/23, 150 schools were provided with ICT

equipment 1.8bn/-," she said. Likewise, she said, collaboration with internet providers UCSAF is considering the connection of the rapid transit bus stops and that negotiations with

service providers are still ongoing. Mashiba said UCSAF in collaboration with mobile service providers is working to improve the functioning capacity of 127 mobile towers.

"As of today almost 111 towers have already been improved in their functionalities in the project that fetched 5.14bn/-, the improvement of the remaining towers is expected to be accomplished by December this year," said Mashiba.

Regarding the telemedicine project, Mashiba said that UCSAF is implementing the initiative in collaboration with the Dar es Salaam Institute of Technology (DIT), Muhimbili National Hospital (MNH), and Muhimbili Orthopaedic Institute (MOI).

She said the hospitals connected to the service so far are Morogoro Regional Hospital, Ruvuma Regional Hospital, Tanga Regional Hospital, Katavi Regional Hospital, Nzega District Hospital and Chato District Hospital.

On the part of Zanzibar, she asserted that UCSA hopes to connect Abdalla Mzee Hospital in Pemba with Mnazi Mmoja Referral Hospital in Unguja when the project implementation reaches the final stages.

Regarding the Digital Tanzania project, Mashiba said 758 towers will be built in 713 wards.

She added that 127 districts will benefit when the project is completed and will benefit almost 8.5 million people.

## Africa CDC and IHME joining forces to train health officials

AFRICA Centres for Disease Control and Prevention (CDC) has made spectacular contributions to tackling epidemics and fighting positioning inequities, the organisation as the continent's leading public health body, it has been declared.

Africa CDC, an independent health agency of the African Union, and IHME joined forces to promote data science and evidence-based decision-making throughout Africa.

Together, over the past year, the two organizations have hosted four workshops across the continent, collaboratively training approximately 140 people from

individuals working in ministries of institutes.

The partners wrapped up the final session of their Africa-wide Global Burden of Disease (GBD) training at Africa CDC's headquarters in Addis Ababa, Ethiopia, in October. The workshop, which included attendees from Central and North African countries, focused on understanding how the GBD study findings can be used to inform policymaking. Training attendees also learned about the science behind the research.

At the workshop, Dr Awoke Misganaw Temesgen, an IHME As a result, the country developed faculty member and leader of the interventions to address non-

48 African countries, primarily Ethiopia Subnational Burden of Disease Initiative, spoke about health and national public health how his country passed laws banning smoking in public places, such as restaurants and public transportation, given the GBD study's findings.

**Participants** brainstormed ways that they could use findings from the GBD study to shape policy decisions in their own countries. To improve the health of birthing parents and newborns, they recommended strengthening health care during pregnancy and childbirth, reducing infections during pregnancy, and ameliorating maternal nutrition.

#### Adesina urges global lenders to prioritise Africa's climate needs

AS global leaders prepare for the 2023 United Nations Climate Change Conference (COP28), the President of the African Development Bank, Dr Akinwumi Adesina, says their deliberations must support a new climate finance architecture that prioritises Africa's needs.

Adesina also urged wealthy nations to fulfill their commitments to provide \$100 billion annually in climate finance.

COP28, will take place from November 30 to December 12 in Dubai, United Arab Emirates. Under the theme 'Unite, Act, Deliver' the event represents a milestone moment for the world to take stock of its progress on the Paris Agreement. This will help align climate change efforts, including measures to bridge the gaps in progress.

In its latest Africa Economic Outlook report, the Africa

the continent requires as much proper valuation of its abundant implement its climate commitments as set out in countries' recently submitted Nationally Determined Contributions (NDCs). However, Africa's inflows of climate finance remain very low (only 3% of global climate finance), and tend to focus on small-scale, fragmented and uncoordinated operations primarily concentrated in middle-income

Dr Adesina said urgent responses to the climate emergency were needed at several levels.

"At the global level, the developed economies must meet their commitment to provide \$100 billion annually in climate finance. The global climate financial architecture must be changed to prioritize the needs of Africa. At the national level, we must accelerate actions on climate adaptation," he reiterated.

Adesina said Africa must revalue

as \$2.8 trillion through 2030 to natural resources, including its vast forests and peatlands that sequester carbon.

He said African nations should voluntarily consider climate-friendly endeavours "not because someone has told us so, but because we have to".

Adesina highlighted a number of key Bank initiatives to support a climate-resilient and decarbonized future for Africa. It is also championing several flagship programmes to scale up climate action and green investments across the continent.

For example, the Bank has pledged to double its climate finance to \$25 billion by 2025. It has also launched the \$20 billion Desert to Power initiative to harness solar power and deliver clean electricity to 250 million people in the Sahel region. "We must power every home, every school and every hospital," said Development Bank estimates that its wealth by accounting for the Adesina, who will lead a Bank Group

The African Development Bank is working with the Global Center on Adaptation to mobilize an additional \$12.5 billion to galvanize and scale up climate-resilient actions.

At COP28, the Bank will seek to amplify Africa's voice and profile on climate change while enhancing strategic partnerships for the significant mobilization of new financial resources. Its participation will help reshape the global narrative on key issues such as energy transition, nature-based solutions, adaptation finance, reform of multilateral development banks, carbon markets and restitution for loss and damage. As in previous years, the Bank will host an Africa Pavilion with other African institutions during COP28 to amplify the continent's priorities.

Dr Adesina, and senior Bank executives will participate in highlevel sessions at the conference, including a summit of global leaders.

#### Scholz vows greater investment in Africa's green energy sector

GERMANY will invest 4 billion euros in green energy projects in Africa until 2030, Chancellor Olaf Scholz said on Monday, noting these could in turn help Europe's largest economy achieve its own transition to carbon neutrality.

Germany will need to import large quantities of green hydrogen going forward, including from Africa, if it is to achieve its goal of net zero emissions by 2045, he said at a German-African business forum in Berlin.

The forum preceded a summit of the "G20 Compact with Africa" that aims to drum up investment in the world's poorest but fast-growing continent by coordinating the development agendas of reformminded countries and identifying business opportunities.

"Hydrogen production requires considerable investment at the start, so clear signals for a longterm and durable cooperation are needed," said Scholz, who has made five trips to Africa since taking office in late 2021 in a bid to increase engagement with the continent.

"The Compact with Africa conference aims to send this signal: You can count on Germany as a partner." The 4 billion euros would be channelled into the common EU-Africa Initiative for Green Energy. The European Union had already announced it would deliver it 3.4 billion euros in grants.

African countries have long complained that while Europe talks about investment, China actually provides financing without any moral lecturing. Still, Chinese lending in Africa is in decline, while European interest is rising.

Indeed the West is increasingly jostling with China and Russia for geopolitical influence, critical minerals and new economic opportunities in the continent.

"The global order is shifting and Europe and Germany cannot just sit on the sidelines," Finance Minister Christian Lindner said after meeting with his counterparts from several African countries at the conference.

The summit of the G20 Compact with Africa on Monday was its fifth since its creation in 2017 under the German G20 presidency and convened the leaders of more than a dozen African states.

German trade with Africa was 60 billion euros (\$65.4 billion) last year, which is a fraction of its trade with Asia but up 21.7% on 2021.

Ivory Coast President Alassane Ouattara said the number of German companies had tripled in five years while Morocco's Prime Minister Aziz Akhannouch said German investment had increased sixfold since 2015.

The member countries of the G20 Compact are Morocco, Tunisia, Egypt, Senegal, Guinea, Ivory Coast, Ghana, Togo, Benin, Burkina Faso, Rwanda, Democratic Republic of Congo and Ethiopia.

#### Global agencies call for urgent action to address antimicrobial resistance in Africa

**HARARE** 

GLOBAL agencies have stressed the growing urgency for Africa to scale up efforts to combat antimicrobial resistance (AMR), amid its significant implications for global health and food security.

Being the hardest hit by AMR, Africa needs political will across the continent to marshal resources towards an AMR fight that would leave no part of the continent behind, a senior UN official said.

"As we observe World AMR Awareness Week (WAAW) 2023, the United Nations, in collaboration with the African Union and the Republic of Zimbabwe, calls for enhanced political advocacy to highlight the severity of the growing AMR threat across the continent," said UN Resident Coordinator in Zimbabwe, Edward Kallon, in a speech read on his behalf at an event commemorating the WAAW that runs on Nov. 18-24 in Harare, the capital of Zimbabwe.

The World Health Organization (WHO) has already identified AMR as one of the top 10 global public health threats facing humanity, and the theme for this year's event: "Preventing Antimicrobial Resistance Together" underscores the need for urgent multi-sectoral action under the One Health Approach to safeguard the effectiveness of antimicrobial medicines, he said.

Unregulated and inappropriate use of antimicrobials across various sectors, including human, animal, and plant use, as well as inadequate access to clean water, lack of sanitation, and insufficient infection prevention and control measures are major drivers in the development of drug-resistant pathogens in Africa, Kallon said.

"These factors not only jeopardize health but also endanger several key sustainable development goals related to health, agriculture, animals, the environment, and food security," he said.

In Africa, AMR has become a silent pandemic and already been documented to be a bigger problem than HIV, Malaria and TB combined. By 2050, millions of people could be affected, said Director General of Africa Center for Disease Control and Prevention (Africa CDC) Jean Kaseya.

"We therefore require a very strong, coordinated, multi-sectoral and multi-disciplinary approach to tackle this growing problem," he said.

African Union Inter-African Bureau for Animal Resources (AU IBAR) director, Huyam Salih, called for collaborative efforts and equitable financing to tackle AMR on the African continent.

"It is imperative that we prioritize equitable financing for AMR-related activities to ensure that no country is left behind. The fight against AMR should be a collective effort with resources allocated equitably. We should redouble our efforts that emphasize preventive measures and the importance of practices aimed at reducing reliance on antimicrobials," she said.

Lindiwe Makubalo, the assistant regional director at WHO, said compared to other regions, Sub-Saharan Africa has the highest AMRassociated deaths at 99 deaths per 100,000 people, with drug resistance to commonly used HIV medicines also being detected in almost 60 percent of cases on the continent.

The WHO Regional Office for Africa was making steady progress to capacitate member countries to fight AMR, including assisting 46 member states to develop AMR national action plans and surveillance capacity building, among other initiatives, Makubalo said.

She added that the fight against AMR was being hampered by several challenges, including weak one-health governance and multisectoral coordination in member countries, weak health care systems, unavailability of AMR representative data in over 40 percent of African countries and a lack of sustainable domestic financing for AMR national action plans implementation.

Disjointed systems for supply and distribution of medicines and poor enforcement of regulatory frameworks related to the use and sale of antimicrobial medicines were the other challenges.

She said despite the challenges, the continent must maintain its resolve to fight AMR through enhanced collaborations, development of alternatives to antimicrobial use including the use of vaccines for infectious vaccine-preventable diseases and reinforcing surveillance systems to monitor resistance patterns, enhance regulatory frameworks, and promote education and awareness campaigns to empower individuals with the knowledge needed to take action.

Food and Agriculture Organization of the United Nations (FAO) Assistant Director-General and Regional Representative for Africa, Abebe Haile-Gabriel, said the FAO was supporting national and regional initiatives in Africa to address AMR, focusing on its vision to reduce AMR levels and slow the emergence and spread of resistance across food production and value chains and for all food and agriculture sectors.

#### Campaigns notwithstanding, lack of toilets is still a blot in health system people stepping back to examine how

'naming and shaming' operation of sorts was being conducted the other day when the Health minister marked World Toilet Day by setting out regions said to be leading in poor supply or availability of toilets.

The regions singled out for mention are Katavi, Simiyu, Manyara, Tabora and Arusha, within the background where 9.8 per cent of the entire population did not entirely have the allimportant facilities at household level.

This is the king of data that many people often 'conveniently' skip and look the other side, as if it isn't a problem of policy.

This data lead back to the problem of spreading out community health officials and administering a universal health coverage system, as its application requires serious efforts aimed at prevention of diseases.

It implies logically that a house without working toilets would not exactly be qualified for inclusion in the coverage as chances are that such a household would be a burden.

Those who drafted the proposals sent to the legislature and approved were basically worried about what they said were 15 million out of the country's population of roundabout 62 million people categorised as too poor

That is one aspect of the data on the availability of toilets and the way that can impinge the prospects of workable rollout of universal coverage.

The other matter it would be interesting to see how the Health ministry believes it can tackle is how public authorities can bring that hardcore part of the population that appears to detest or abhor toilets to which regulations are attached.

Some people would recommend imposing fines or hauling people to remand prison for that reason, but that might be frowned upon as a reminder of colonialism.

That would bring up some sheepish smiles on the faces of a few, with

far some distress on what happened

during that time was warranted. In a way, the biggest issue was crushing those who objected to the rise of a new order, but how else would

such a development have come about? Can it really be agreed that the new order that some warrior-minded clusters went that far to oppose was really a bad thing?

Making some basic requirements of a healthy public order dependent on what one feels would amount to limiting the pace of development, occasioning, precipitating aggravating disease and putting plenty of pressure on public resources.

It can also be a reason for stunting, with children being down with environmentally-based ailments all the time, sucking up vitality.

This would likely be an area where local governments ought to be in vigilant command so that the various representatives of top government officials see to it that it is done.

In the past few years there have been staged nationwide campaigns, whose message was to the effect that a household's dignity lay with the state of

However, a significant portion of the population does not appear to have heard, or grasped, what the particular crusades were all about.

The answer to that situation is not the conducting of follow-up campaigns but entrusting the matter to local governments, and in particular district commissioners, to sort out.

If a clean-up campaign is carried out under central government oversight there will likely be more complaints, particularly from those defending indigenous peoples on just about everything.

When local administrations take up by central government directives, things can work better as then the local representatives would be the government's emissaries on the matter. Worth a try, wrong?

### **BRICS: New hope for Africa's economic liberation**

14-year-old intergovernmental political and economic organisation recently comprising Brazil, Russia, India, China and South Africa and therefore popularly known by the acronym BRICS, representing its member states' initials (in English), calls for no introduction.

This group of major emerging economies seeking to reshape global order currently boasts 11 member countries. The membership expansion came true after six countries were accepted at the (last - 15th) BRICS Summit held in Johannesburg this August.

The new members which joined the BRICS are Argentina, Saudi Arabia, the United Arab Emirates (UAE), Egypt, Iran and Ethiopia.

The addition of the six members makes BRICS stand as a group with a population of 3.67 billion, which accounts for around 47 per cent of the world's total population. It also boasts a total GDP of 29 trillion US dollars, which accounts for approximately 29 per cent of the global GDP.

Along with the increase countries, member Iohannesburg summit concluded with positive results, including encouraging the use of local currencies for trade among members and other developing countries.

The expansion of BRICS has raised new hopes for stronger commercial cooperation with mutual benefit that will promote the development of Africa. This hope is based on the fact that BRICS countries oppose the Cold War mentality and unilateralism.

For that reason, they are committedtopromotingmultilateral cooperation, mutual respect, mutual trust and cooperation in strengthening an alternative international developmental path that is inclusive.

Unlike some countries bent on dividing the world into exclusive blocs and expanding their military alliance to maintain their rule, BRICS countries focus on maintaining world peace and promoting common development.

Considering the enhancement of the economic and political power of the 'bloc' and its cooperation with Africa, the African countries have become more interested in BRICS

than obtained previously. And the major explanation here is that it offers new opportunities for trade, investment and technology transfer, which will help promote the development and integration of the African continent.

countries, BRICS member especially China, have in recent years expanded their economic cooperation with Africa. In fact, China is currently Africa's largest trading partner and has granted greater market access to African products.

For example, last year saw nearly 15 per cent of Africa's exports go to currencies in trade, African China, compared to 3.8 per cent in

And, according to official statistics, the value of trade between China and Africa reached a new high of 282 billion US dollars last year, which increased 10.9 per cent year on year.

Additionally, China has invested massively in infrastructure and industrial projects in African nations.

India has also meanwhile stepped up its trade and investment cooperation with Africa, particularly in agriculture, health care, renewable energy, water supply infrastructure, education and information technology. Furthermore, it has established a fund of 10 billion US dollars to support development projects in

According to the statistics of India's Commerce and Industry ministry, financial year 2022/2023 saw trade between India and Africa grow by 9.26 per cent to almost 100 billion US dollars - from 7 billion US dollars in 2001. Economic research data for

calendar year 2022 from the African Development Bank (AfDB) meanwhile show that BRICS is now Africa's largest trading partner with their trade expected to exceed 500 billion US dollars by 2030.

It is clear that BRICS countries have contributes far more appreciably to Africa's economic development than have members.

It is important to note that African countries have realised that depending on Western countries makes them vulnerable, especially when their interests collide.

That they have to sell their oil and other resources to Western countries at a fixed price, trade in US dollars and use the West-dominated financial system are just some of the disadvantages in dealing with Western economies.

Largely owing to BRICS' new

financial strategy and its decision innovation, regional integration to encourage the use of local and sustainable development. countries would be well advised to use this opportunity to fight for their full economic independence. They need to take decisive actions to reduce their economic dependence on the US dollar and Western financial institutions, especially private creditors.

This freedom includes appreciating the importance of economic emancipation as well as freedom to do business based on equality and to manage their internal affairs independently, without being subject to Western countries' interference.

BRICS' new financial system, BRICS PAY, provides an opportunity for the bloc's member countries and other developing countries to receive and make payments in their respective local currencies.

In the circumstances, there is every need for African countries to join this system so as to reduce the risk of economic instability resulting from unilateral sanctions imposed by Western nations.

But in order to benefit most from the BRICS PAY system, African countries need to increase trade with BRICS countries and use their strength and resources for mutual benefit.

This can be done effectively if African countries adopt a strategic approach in cooperation with BRICS based on the assessment of their respective strengths and weaknesses and the pursuit of mutual benefit.

To that end, African countries need to strengthen their internal institutions and policies, strengthen regional cooperation and carry out cooperation with BRICS member nations in a bold but prudent way based on a shared vision of common prosperity.

In addition, African countries need to take advantage of the opportunities offered by BRICS by prioritising investment in education, technology infrastructure alongside promoting

Above all, African countries need to attract more investments and increase trade volumes with BRICS member countries and other developing nations. In doing so, they will realise their full potential and contribute more meaningfully to the shaping of a global economic order that is more equitable and inclusive.

It is worth noting that, since and before independence, African countries have had to live with Western financial systems as well as the strict conditions attached to the latter's economic and financial aid.

This is because there was no alternative financial system or other institutions with which to replace the Western ones. Therefore, African countries had to use the monopolistic SWIFT system and comply with the wishes of those Western countries.

For that reason and in order to break free from over-dependence on the SWIFT system and the aid provided by Western financial institutions, African countries may find it beneficial to join the BRICS PAY and strengthen trade cooperation with BRICS member countries.

Additionally, it is advisable for them to start doing business using their own currencies so as to lessen the risk of ending up with insufficient capability to service foreign debt and to purchase foreign goods and services.

As countries increasingly realise the importance and benefits of doing business in their respective local currencies, we expect to witness the emergence of a decentralised and more complex international financial system in which BRICS member countries, particularly China, play an increasingly important and noticeable role.

#### Govt tiring in shouting about corruption; curbs don't work

OME top-level government officials have lately been hard lamenting - not really complaining-that corruption is shooting up to the roof, at least relative to standards that we have for some years been used to appreciate.

Tanzania has for a while scaled up some notches with respect to sensitivity to corruption and, since then - admittedly, with more freedoms - our ability to keep to that record is diminishing.

It is a lesson in politics that can scarcely be offered in a lecture theatre - that democratic anti-corruption methods don't work effectively enough, at least in Africa.

Most people would stiffen at such a suggestion but there are those who silently know that being tougher or less tolerant works.

Of course, the wider problem might remain where it is: how to combine good governance, which presumes democratic conduct, and effectiveness in combating corruption.

So far, a sufficiently working or sustainable remedy has not been found, as whatever we may have previously relied on in curbing manifestations of corruption, diminishing the number of those in authority by deliberate embezzlements, can no longer be applied. So, there is a choice that looks like picking a rock or a hard place, since neither is really sufficiently 'potent'.

The issue is what really concerns people most, as this is where what is known as politics basically falls namely, solving problems among people on the basis of what they prize

countries, it would appear - it is democracy that boasts the uppermost value and the fight against corruption comes second in that agenda.

In our case - and in all democratic

The crusade in no way fetches or

elicits as much attention as broad freedoms, while these freedoms imply a certain mode conduct in the running of government business.

Democracy isn't just a system but, rather, a culture where everyone in the government is entitled to enjoy shielding those testing the will of authorities.

It is precisely this that a well-placed individual in combating such situations, that is, the minister responsible for Public Service Management and Good Governance, was recently saying in exasperation that corruption is now afoot everywhere.

The minister directed his remarks at small bribes that deny people services in public institutions, with varying levels of impact, though at no point can it be said that such situations are harmless.

He was talking to officers - and commanders - of the national anticorruption bureau, most of whom are understood to exercise their functions carefully, taking account of the prevailing mood in the country.

At times MPs have pointed out in debate that some local government officials protect one another, but they have been cautioned against "reckless generalisation".

Looking at the issue at close range, not much is likely to happen as people in public office know their range of privileges and how far complaints can

be worked upon or resolved. So, what will be uppermost is the freedom that people will have in registering and voting in the civic polls next year and the all-important General Elections the following year.

Corruption will be diminished by greater transparency and, to an extent, greater political competition compelling those in authority to act so as to reinforce the trust the public has placed in them.

## Volcanic eruptions: Rare catastrophes with hidden benefits

normally hazards that much because they rarely occur. Naturally, people are conditioned with what they regularly see. The fact that geohazards occur and leave catastrophic impact on humans man and the environment calls out everyone to be aware of the causes and effects of geohazards together with their prevention, mitigation and adaptation meas-

Volcanic eruptions are one of the geohazards that result from erupting magma from the earth's sub surface, pouring on the surface in the form of lava. Magmatic fluids are very hot, they burn anything they touch be it people, buildings, plantations and so on. Some magma can reach temperatures of up to 1400 degrees celsius.

The magmatic fluids turned into lava are accompanied by rock fragments, volcanic gases and ash. Volcanic gases which are toxic and contain smoke when inhaled lead to death. This happened recently in 2021 when Mount Nyiragongo erupted near the city of Goma in the Democratic Republic of Congo. When emitted, volcanic gases go up and block sun rays which eventually cool the earth's temperature.

Deep down in the earth's interior mantle, there oc-



curs magma which moves from side to side. This movement of magma is caused by convection currents. There are various volcanic activities happening on earth with Indonesia having the maximum number of active volcanoes.

Most of the volcanoes happen in the oceans, making minimum impacts to people and properties. They mostly occur around diverging and converging boundary plates.

Volcanoes on land mostly happen as a result of stretching and thinning of the crust such as the East African Rift and Rio Grande Rift in North America. Africa has been experiencing volcanic eruptions in Ethiopia, Tanzania and Democratic Republic of Congo. Volcanic eruptions have had severe damages to people: causing death, destruction of properties and displacement of people. People are forced

to evacuate their homes for safe places like in the Nyiragongo case in where 400,000 people left their homes. Volcanism has a long-term effect to climate due to the gases and ash emitted that go on to cool the earth's temperature, causing problems in health, agriculture and other socioeconomic activities. At times volcanic eruptions also cause earthquakes, resulting in destruction of buildings and death.

Despite the harsh effects, volcanism is also advantageous in that it contributes to the formation of essential metals and minerals like gold, silver, copper, nickel, zinc, diamond and lead.

Volcanic fluids contain elements that are of importance in agricultural soils. These elements are calcium, potassium and sodium. This is why we observe good crop yields in mountainous areas like those around Mount Kilimanjaro.

Volcanic eruptions are useful in research and tourism activities which in turn create revenue for people and governments. Mountains Kilimanjaro, Meru and Rungwe are some of the volcanic tourist attractions in Tanzania. According to the 2013 World Bank report on Tourism in Africa, Mountain Kilimanjaro National Park contributed 13 percent of Tanzania's gross domestic product which goes to the national development plans and also improves the livelihoods of people around the area.

Volcanism has also made it possible to tap geothermal energy. Water in the underground gets hotter when near volcanic fires, resulting in features like geysers, fumaroles, hotsprings and mudspots. Steam from hot water can be used to run the turbines, eventually producing electricity.

To ensure that volcanic disasters are prevented, it

is very useful to carry out hazard mapping and regular surveys around volcanic regions so as to predict early the occurrence of a volcano to alert people for evacuation before it is too late. As the saying goes, the earlier the better. It is also important that governments allocate funds for such hazards so that mitigation and adaptation measures can be carried out earlier other than waiting until lives are lost and properties destroyed.

### Israel recalls its SA ambassador ahead of parliamentary vote on EFF motion to shut embassy in Pretoria

SRAEL has recalled its ambassador to South Africa after strong criticism by Pretoria and the ANC of Israel's continuing military assault on Gaza.

The Israeli government has recalled Ambassador Eliav Belotserkovsky "for consultations" following the "latest statements from South Africa", Israel's Foreign Ministry spokesperson Lior Haiat said on Monday in a post on X, formerly Twitter.

He did not specify the statements, but the SA government and ANC have been growing increasingly critical of Israel as the war in Gaza unfolds and the death toll

Pretoria recently announced that it was recalling all of its diplomats from its embassy in Tel Aviv and it issued a démarche – a very stern form of diplomatic rebuke – to Belotserkovsky. It has also referred Israeli Prime Minister Benjamin Netanyahu to the International Criminal

Israel's decision on Monday to recall Belotserkovsky came a day before Parliament was expected to vote on an EFF motion calling upon "the government to close the Israeli Embassy in South Africa and suspend all diplomatic relations with Israel".

Daily Maverick's Marianne Merten has reported that while the ANC supported the motion in principle, the ruling party and the government were unlikely to support it because of the practical implications - including the fact that breaking diplomatic relations with Israel would mean that South Africa would no longer be able

to maintain its embassy to Palestine in Jerusalem. It seemed likely that the ANC would settle for a compromise of expelling Belotserkovsky but not cutting relations with Israel. Now it seems Israel has pre-empted that move by recalling the ambassador.

The South African Zionist Federation condemned "South Africa's increasingly antagonistic and discriminatory position against the world's only Jewish State" which it said had led to Israel's decision to recall Belotserkovsky.

Africa4Palestine, a South African NGO, welcomed the decision to recall Belotserkovsky ahead of the vote in Parliament.

"South Africa now has no ambassador in Israel, and Israel has no ambassador in South Africa," it said.

It said Israel was being isolated, in a similar fashion to South Africa's apartheid government, which it described as a crucial step towards holding the country accountable. "People and countries across the globe are making it clear: no normal relations with an abnormal state."

#### **Test for BRICS**

Meanwhile, the crisis in the Middle East could present the BRICS bloc with an important test of unity as its leaders gather on Tuesday for a virtual summit hosted by BRICS chairperson President Cyril Ramaphosa to discuss the humanitarian crisis in Gaza.

He will be joined by most of the leaders of the other BRICS member states, Brazil, Russia, India and China, as well as the six countries that were admitted to BRICS at its summit in Johannesburg in August: Saudi Arabia,

Argentina, Egypt, Ethiopia, Iran and the United Arab Emirates.

United Nations Secretary-General António Guterres will also participate in the virtual meeting, at the end of which leaders are expected to adopt a joint statement on the situation in the Middle East with particular reference to Gaza, the South Afri-

can Presidency announced. Russian President Vladimir Putin and Chinese President Xi Jinping are expected to participate, but Indian Prime Minister Narendra Modi will not, South African officials have confirmed, and will instead be represented by Foreign Minister Subrahmanyam Jaishankar. Although the official explanation is a scheduling problem, there is a suspicion that the real reason could be India's outlier position on the Middle East

India is the only BRICS member

which abstained from the UN General Assembly resolution on 26 October calling for "an immediate, durable and sustained humanitarian truce leading to a cessation of hostilities" between Israel and Hamas and for unhindered humanitarian access to Gaza.

India explained that it did not support the resolution because it failed to condemn Hamas for its 7 October attack on Israel, in which it killed more than 1,200 people, mainly civilians, and took about 240 hostages. In retaliation, Israel launched an attack on Hamas in Gaza which by Monday had killed about 13,000 people, also mostly civilians.

Last week, Modi told the virtual Voice of Global South Summit that "India has condemned the dastardly terror attack on Israel on October 7". He added that India urged a "restrained response along with dia-

logue and diplomacy" from Israel. "We strongly condemn the death of civilians in the Israel-Hamas conflict," Modi said.

Five of the six new BRICS candidate countries which will attend Ramaphosa's virtual summit on Tuesday also supported the UN General Assembly ceasefire resolution, but Ethiopia, like India, abstained.

Iran openly provides military and financial support to Hamas and has publicly welcomed its attack on Israel, so it would be the least likely participant in Ramaphosa's meeting to agree to any criticism of Hamas in the joint statement which the 11 participating leaders are scheduled to issue at the end of their meeting.

Official sources have confirmed that Argentine President Alberto Fernández will participate in the virtual summit though he is about to leave office and it is uncertain

whether his successor, Javier Milei, will take up the invitation for Argentina to join BRICS.

Milei, who has just been elected, is a right-wing, antigovernment populist in the Donald Trump mould and stated during his election campaign that he was opposed to Argentina joining BRICS.

In a statement on the recall of Belotserkovsky, South African Zionist Federation chairperson Rowan Polovin said: "The ANC's prejudicial posturing on this conflict will have profound implications for our country, as well as Jewish and Christian South Africans and others with religious and spiritual ties to Israel."

He added that the government's "one-sided and irresponsible rhetoric" and refusal to engage in dialogue with Israel had prevented SA from playing any meaningful role in ending the current war or in any future peace efforts.

"All it has achieved is [to] deepen the divisions in South Africa, undermine our country's international standing and economic interests, and harm the constitutional rights of our citizens.

"We hope this is a temporary recall and that diplomacy can continue," Polovin said.

## The world's right-wing and left-wing torturers

EANNE Kirkpatrick, a former U.S. ambassador to the United Nations, once made the distinction between "friendly" right-wing authoritarian regimes (which were mostly U.S. and Western allies) and afriendly" left-wing totalitarian dictatorships (which the U.S. abhorred).

Among the "dictators" the U.S. shunned in the 1970s and 80s were Zimbabwe's Robert Mugabe, Myanmar's General Than Shwe, Iraq's Saddam Hussein, Cuba's Fidel Castro, Libya's Mummar al-Qaddafi, Syria's Hafez al-Assad and North Korea's Kim IL-Sung.

At the same time, successive U.S. administrations cozied up to a rash of right-wing authoritarian regimes and family-run fiefdoms, mostly in South-East Asia, Latin America and particularly the Middle East.

These regimes were widely accused by human rights organizations of instituting emergency laws, detaining dissidents, cracking down on the press, torturing and executing political prisoners and rigging elections. (As a South-East Asian right-wing dictator once said: "I promised you I will give you the right to vote, but I did not say anything about counting those votes.")

Kirkpatrick's distinction between user-friendly rightwing regimes and unfriendly left-wing dictators prompted a response from former US Secretary of State Cyrus Vance, who shot back: "It seems to me that if you're on the rack (and being tortured), it doesn't make any difference if your torturer is right-handed or left-handed."

But some of the Western nations have tried to politically separate "right-wing governments" from "left-wing governments" - the white-hatted good guys from the black-hatted bad guys, as in Hollywood movies of the wild West.

The strongest link between the United States and some of the oppressive Middle East regimes, including Egypt and Saudi Arabia, is primarily military.

And Israel's right-wing government, accused by Amnesty International, of human rights abuses and torture, is a coalition of seven political parties.

The ongoing devastating and one-side battle between Israel, a strong US ally, and the militant group Hamas has underlined a longstanding double standard on torture and human rights abuses.

The US rarely, if ever, is critical of Israel and exercises its political clout to veto any Security Council resolution condemning the Jewish state, as it did last week.

Dr. Simon Adams, President and CEO of the Center for Victims of Torture, told IPS: "Unfortunately, if history teaches us anything it is that most governments are capable of perpetrating torture, regardless of their political complexion.

Some democracies, he pointed out, try to justify torture in moments of extreme crisis, like the United States after 9/11, while dictatorships often commit torture as part of an industrial system of terror and control, like North Korea or the Assad regime in Syria.

"The sad, reality is that authoritarian governments that declare themselves as belonging to the far left or to the extreme right have often committed torture in the name of advancing their cause," he noted.

"The more deluded a government is regarding the alleged purity of the ruling ideology, the more likely they are to perpetrate torture against dissidents and nonbelievers. What all authoritarian regimes have in common is disdain for universal human rights" declared Dr

Meanwhile, in a report released in early November, Amnesty International (AI), a leading human rights organization, says testimony from released detainees and human rights lawyers, as well as video footage and images illustrate some of the forms of torture and other ill-treatment prisoners have been subjected to by Israeli forces over the past four weeks.

These include severe beatings and humiliation of detainees, including by forcing them to keep their heads down, to kneel on the floor during inmate count, and to sing Israeli songs.

Heba Morayef, AI's Regional Director for the Middle East and North Africa says: "Over the last month we have witnessed a significant spike in Israel's use of administrative detention – detention without charge or trial that can be renewed indefinitely – which was already at a 20year high before the latest escalation in hostilities on 7



"Administrative detention is one of the key tools through which Israel has enforced its system of apartheid against Palestinians.

Testimonies and video evidence also point to numerous incidents of torture and other ill-treatment by Israeli forces including severe beatings and deliberate humiliation of Palestinians who are detained in dire conditions," says Morayef.

The AI also says the summary killings and hostage-taking by Hamas and other armed groups on 7 October are war crimes and must be condemned as such, but Israeli authorities must not use these attacks to justify their own unlawful attacks and collective punishment of civilians in the besieged Gaza Strip and the use of torture, arbitrary detention and other violations of the rights of Palestinian prisoners.

never be suspended or derogated from, including - and especially - at times like these," said AI.

Amnesty International says it has for decades documented widespread torture by Israeli authorities in places of detention across the West Bank.

However, over the past four weeks, videos and images have been shared widely online showing gruesome scenes of Israeli soldiers beating and humiliating Palestinians while detaining them blindfolded, stripped, with their hands tied, in a particularly chilling public display of torture and humiliation of Palestinian detainees. In one image analyzed, by Amnesty International's Crisis Evidence Lab, three Palestinian men, blindfolded and stripped of their clothes can be seen beside a soldier, wearing a green olive

"The prohibition against torture can uniform like those worn by the Israeli ground forces.

> A Haaretz investigation published on 19 October found that the image was taken in Wadi al-Seeq, a village East of Ramallah, on 12 October. One of the three victims depicted in the photograph told Amnesty International that he had initially been held and beaten by settlers but two hours later an Israeli military jeep arrived:

> "One of the Israeli officers who came, approached me and kicked me on my left side, then jumped on my head with his two legs pushing my face further into the dirt and then continued kicking me as I was head down, into the dirt, with my hands tied behind my back. He then got a knife and tore all of my clothes off except for my underwear and used part of my torn clothes to blindfold me".

"The beating to the rest of my body did

not stop, at one point he started jumping on my back - three or four times - while yelling 'die, die you trash' ... in the end before this finally stopped, another officer urinated on my face and body while also yelling at us 'to die'."

Meanwhile, the UN Committee against Torture is currently holding its sessions, through November 24, during which it will examine Burundi, Costa Rica, Kiribati, Denmark, Egypt and Slovenia.

These six countries are among the 173 States parties to the Convention against Torture and Other Cruel, Inhuman or Degrading Treatment or Punishment. They are required to undergo regular reviews by the Committee of 10 independent international experts on how they are implementing the Convention.

## Kibaha reagents plant becomes 'game changer' in Tanzania's medical sector

IN efforts to reduce cost of medical reagents and improve supply of quality medical products to hospitals in the country, the government in collaboration with investors has introduced Health Technology Centre in Kibaha. The center runs by Action Medeorthe German-based largest medicine organization.

The center has significantly reduced the cost of medical reagents. "For instance, in the past the reagents were sold at the price of 320,000/-, but now the price has dropped to 80,000/-, which is a significantly lower cost," Dr Godwin Mollel, Deputy Minister for Health said recently when speaking at the official launch of the center.

This benefits the government by ensuring a steady supply of quality medical products to hospitals, without any allocation or delay issues. It has brought about significant economic advancements for Tanzania and helped to address the issue of unemployment among Tanzanians.

Prior to its establishment, many Tanzanians were employed in its con-

As its operations progress, it is expected to employ more than 20 individuals to meet the growing production demands.

It stimulates the economic growth of neighbouring countries as well. After initiating production, there is the potential to fulfill both domestic and international demands for medical reagents, thus contributing to Tanzania's revenue and generating numerous new jobs.

According to Mollel, since President Samia Suluhu Hassan got into office, the ministry has so far received a total of 6.7trn/-

He said that the money dished out by the government has gone to the construction of health facilities and procurement of critical medical equipment such as x-rays, CT-scans and MRI.

"Efforts by the President Samia, to open up and encourage investment in the health sector has seen the only haematology reagent factory in Eastern and Central Africa being established in Tanzania," the minister said.

According to him, the establishment of the factory will bring major revolution to the health sector something which President Samia has always been encouraging.

Dr Mollel directed the Tanzania Medicines and Medical Devices Authority (TMDA) to ensure efforts are made so that the plant kick starts operations within two-week's time.

On Covid-19 pandemic, Dr Mollel said: "This is a big lesson learned during the time on the importance of having local factories, saying investors like Action Medeor need to be embraced."

He urged Tanzanians working at the centre to acquire skills and later on become innovators rather than remaining as mere machine operators so as to help the country realise its ambitious plan of industrialisation.

Christoph Bonsmann, Country Director and Executive Director at Action Medeor International Healthcare noted that the reagent is ISO certified,

saying currently it is awaiting TMDA registration for its take off.

"The product is expected to bring down cost of reagents by 70 per cent thus saving Tanzania from huge importation costs from abroad," he said.

Upon starting operation, he said they can produce up to 500 tonnes per year, meaning that the product can be marketed outside East African Community

However, he noted that their goal is to expand the production base to other crucial medical supplies in the near future.

Hassan Hamis Hafidh, Zanzibar Deputy Minister for Health applauded the Action Medeor, noting that their step is important one as it paves the way for creating a healthier future for Tanzania.

He indicated that Zanzibar has made major reforms in their health sector whereby bureaucracy is discouraged, welcoming Action Medeor in Zanzibar should they want to invest.

Kibaha District Commissioner Nickson Simon observed that the Coast Region currently accommo-

dates 1,523 industries and 434 health facilities, adding that 22 plots have been earmarked for industries in the region.

The DC Simon called on investors to chip in and invest in the Coast Region because of its countless opportunities.

So far, the region has a Special Export Zone valued at 3trn/-, that has been designed to accommodate around 200 factories.

## After seven months of war, Sudan faces risk of collapse

SEVEN months of war between rival generals in Sudan have resulted in thousands of deaths, millions of displaced persons and the risk of disintegration of the country, which was already in a fragile state before the outbreak of hostilities.

As the paramilitary Rapid Support Forces (RSF) continue their brutal offensive in the Darfur region (west), experts fear a "Libyan scenario", in reference to the inextricable political crisis shaking this North African country neighbouring Sudan, where two governments are vying for power, one established in the west and the other in the

In Sudan, the RSF, which now controls most of the capital Khartoum, has made lightning advances in Darfur. At the same time, the government and army leaders have left the capital to retreat to the city of Port Sudan, which has been spared the fighting, exacerbating fears of a break-up of the country.

"Continued fighting could lead to terrifying scenarios, including division," warns Omar Youssef, spokesman for the Forces for Freedom and Change (FLC), the civilian bloc ousted from power in the 2021 putsch led by the two generals who were allies at the time and are now at war.

"The growing wave of militarisation (of civilians) is aggravating the social fissures", he added.

At the negotiating table, the two sides, unable to gain a decisive advantage, have little intention of making concessions, as demonstrated once again by the failure in early November of talks sponsored by the United States and Saudi Arabia, leading to fears of fragmentation of the country if the status quo is prolonged.

Failure to reach a political solution could lead to a situation similar to that in Libya, which has been plunged into a major political crisis since the 2011 revolt, with "more than one government, with no real effectiveness or international recognition", explains Fayez al-Salik,

political analyst and journalist.

The conflict that broke out on 15 April between the head of the army, General Abdel Fattah al-Burhane, and his deputy-turned-rival, General Mohamed Hamdane Daglo, has claimed more than 10,000 lives, according to an estimate by the NGO Armed Conflict Location & Event Data Project (Acled), which is widely considered to be an underestimate.

It also displaced more than six million people and destroyed most of the infrastruc-

At the beginning of November, new massacres were reported following a large-scale offensive by the RSF in Darfur, where the militia quickly claimed control of army bases in almost all the major towns in

In the town of Ardamata alone, hundreds of people are reported to have been killed by armed groups, who have forced more than 8,000 people to flee to neighbouring Chad in the space of a week, according to

The European Union (EU) said it was "appalled" by the "more than 1,000 deaths" in two days in Ardamata, warning of possible "ethnic cleansing."

Since the start of the war, the UN has counted more than 1.5 million internally displaced people in Darfur, a region the size of France and home to a quarter of Sudan's 48 million

While General Daglo can count on the support of powerful allies, foremost among them the United Arab Emirates, General Burhane retains his role as de facto head of state on the international stage, regularly taking part in UN and Arab League summits.

On the ground, however, the unbridled advance of the RSF in Darfur "gives them an advantage and allows them to move within their base", according to Mr Salik, referring to the Arab

It is Arab militiamen, the Janjaweed, who form the bulk of the RSF troops and who in the 2000s, under the command of General Daglo, carried out a

scorched earth policy in Darfur, pillaging, raping and killing members of non-Arab ethnic groups on behalf of deposed dictator Omar al-Bashir.

Despite the paramilitary advances in Darfur, the chances of either side achieving a decisive victory remain slim, according to a military expert speaking to AFP on condition of anonymity.

According to him, "even if (the army) manages to regain control of Khartoum, which looks very arduous, sending troops to retake the areas of Darfur controlled by the RSF represents an enormous logistical challenge", with more than 1,400 kilometres separating Khartoum from the town of El-Geneina, on the border with Chad.

## Gender norms 'still block African women in science'

RADITIONAL gender norms continue to stymy the progress of women in science in Africa, says Hulda Swai, one of two women appointed as chairs at an African research initiative dedicated to anti-apartheid icon Oliver Tambo.

The O.R. Tambo Africa Research Chairs Initiative (ORTARCHI), which works to support research for socio-economic development across the continent, aspired to ensure that at least half of its chairs - appointed in 2020 for a five-year term - were women researchers. But only two slots out of the ten chairs slots ultimately went to women.

African Institution of Science and Technology (NM-AIST) in Tanzania, be-

lieves lack of support and role models are blocking progress for women. "Women in Africa often face societal and cultural expectations that make it more difficult for them to pursue careers in science," Swai told

"Sometimes, even their own families are not supportive of their goals." She says men must step up to support women in their families in pursuing science pathways.

"Traditional gender roles and societal expectations, such as marriage and family responsibilities, can hinder women's progress in the field," she

"Encouragement from the broader society, including husbands, fathers, and brothers, can play a pivotal role in supporting women in science." Dorothy Ngila, from South Africa's National Research Foundation, which is a core partner in the initiative, explained that the reason the

gender requirements were not met was because of the poor women representation already existing in research and STEM. "Research has consistently indicated that, globally, we have fewer wom-

en in research leadership positions," Ngila said. This, she said, is reflected in the pool of applications that were received



for the ORTARCHI chairs, as there were fewer applications from women.

Ngila told SciDev.Net of the effort the initiative is making to increase women representation, including tracking the number of postgraduate students and postdoctoral student that the chairs are mentoring and ensuring that women are represented in that cohort.

"The chairs are collectively supporting 157 masters and PhD and Postdocs, of which 42 per cent are women," she said.

"Additionally, of the cumulative 316 core research team members across all the chairs, 34 per cent are women."

Last month, researchers and scientists from across Africa gathered in Pretoria, South Africa, for the 2023 ORTARCHI Annual

The meeting brought together researchers and scientists from across Africa to explore how to achieve research excellence through collaborations across the continent.

It sought to honour the legacy of its namesake Tambo, a South African anti-apartheid activist and former science teacher who co-founded the African National Congress Youth League alongside Nelson Mandela.

Tambo was dedicated to a free and united Africa and saw South Africa's knowledge and expertise as a resource to be shared with the rest of the continent.

Swai commended the Annual Gathering for including female scientists and researchers as facilitators and speakers, sharing their expertise. She views this as a positive sign of

progress for science in Africa.

She says more needs to be done to promote the value of science among young women and to give them the resources they need.

'Institutional change' needed to meet gender equity goals Bridging South Africa's math's language gap Impact of global South research 'should be recognised' "For example, in Tanzania, I talk to female teenag-

ers in various schools, and when they look at you as professor in science, they get so excited. "What they need is to be encouraged," she said in an

interview with SciDev.Net after the event. She is hopeful that Africa will see change for the bet-

ter, as has been seen elsewhere. "In Europe, for example, women are increasingly taking on leadership roles, and their contributions are

being celebrated," she says. "We can learn from these successes and work towards a more supportive environment for women in

Swai said she believed initiatives like ORTARChI had an important role to play in promoting the growth and development of young researchers in Africa, especially women.

"If the ORTARCHI is successful in promoting the value of science and supporting the development of young researchers, it could lead to a positive cycle of growth and development on the continent," she said.

She hopes it will serve as a model for future partnerships that support African researchers and lead to innovative breakthroughs that improve people's lives

## Obama, Clooney and Gates: 'We can end child marriage in a generation'

HREE of the world's most influential women have told BBC News they want to end child marriage within a generation.

Michelle Obama, Amal Clooney and Melinda French Gates announced last year a collaboration between their foundations to combat the problem.

At the current rate of progress, the UN has warned it will not be eradicated for 300 years.

But former First Lady Mrs Obama told BBC News: "It is an issue that can be solved tomorrow."

The three women spoke exclusively to BBC 100 Women during a visit to Malawi and South Africa.

"I'm sorry," said 26-year-old Lucy, as she choked back tears. "I feel emotional."

Lucy was in the library of Ludzi Girls secondary school in the central region of Malawi. US secret service agents stood outside, under the red flame trees of the school grounds. She had just been speaking about the importance of girls staying in school, and spared the fate of marriage to much older men, before emotion suddenly overcame her.

Around the table, three of the world's most influential humanitarians - Melinda French Gates, Amal Clooney and Michelle Obama - had quietly listened to her story.

According to the NGO, Girls Not Brides, Malawi has one of the highest child marriage rates in Eastern and Southern Africa, with 42% of girls already married by the age of 18. In Mchinji District, where Ludzi Girls school is located, 33% of girls are reported to fall pregnant before they reach 18, and leave education.

Lucy could have been one of those girls. Her father had wanted her out of school when she was 14, but she resisted, and later became the first girl in her village to go to university. Now, with a degree in education, she is a district leader for AGE Africa, an organisation that provides scholarships for vulnerable girls in Malawi, a country where secondary education is not free. Lucy was once a student in the programme, and now she helps girls like herself.

Her mother is overjoyed at her achievement, Lucy said, although her father is less so. She said he is still coming to terms with an independent daughter. Sharing all this left her overwhelmed.

The former First Lady of the US, sitting to Lucy's left, spoke up. "Will you send your father a message for me? Next time you see him, tell him that Michelle and Barack Obama are so proud of you, and the woman you have be-

Lucy looked up, smiling. On Lucy's right sat international human rights barrister Mrs Clooney. "And tell him you

have a lawyer too now," she added.

BBC 100 Women names 100 inspiring and influential women around the world every year - Michelle Obama and Amal Clooney are on this year's list, while Melinda French Gates was listed in 2021.

After announcing their collaboration to combat child marriage last year, Michelle Obama, Amal Clooney and Melinda French Gates visited Malawi and South Africa together to amplify the work of grassroots organisations focusing on the issue, and to meet girls and women whose lives have been affected.

Mrs Obama's education-focused organisation, Girls Opportunity Alliance, had already identified that girls around the world were leaving school due to pregnancy and teenage marriage. Mrs Clooney was working to make sure girls in rural communities were aware of their rights, and many of Ms French Gates's projects had focussed on improving healthcare - including treatment for girls who experience complications after giving birth at a young age.

All are passionate about defending the rights of women and girls, so a coalition seemed like a natural fit.

"It's been a really lovely and very organic partnership, and friend-

ship, between the three of us," international human rights lawyer Mrs Clooney told BBC 100 Women.

"In an early conversation with the Gates Foundation, I said: 'You're working on gender justice at a massive scale, but mostly you're not using law as a tool. You're looking at economics, and you're looking at health. Maybe we can form a partnership?'"

Ms French Gates, who got a spontaneous cheer from the Ludzi schoolgirls when she said it was her fifth visit to Malawi, said working together was a strategic decision, and that their overlapping areas of expertise would make them more effective.

"Women, I think, naturally work in collectives," she told the BBC. "I've talked to a number of women who are older than me who made it as CEO, or CFO, in their company. And there's some regret that they didn't do it in concert with other women. They didn't pull other women up and along with them. The generation that we've been part of -Michelle and I are essentially the same age we've wanted to pull everybody up with us."

According to Unicef, 650 million girls and women are alive today who married under the age of 18, and currently more than 12 million girls a year marry in legal and traditional ceremonies around the world. South Asia and Sub-Saharan Africa have the highest rates globally, but this is not just an issue in the global south. Five states in the US have no minimum age of marriage as long as parents consent.

Some countries, such as Malawi, have progressive laws that outlaw marriage under the age of 18, although these often come up against longstanding cultural barriers. On Monday, following the visit of the three campaigners, President Lazarus Chakwera announced further funding for a national strategy to end child marriage. Until now there have been very few prosecutions.

Mrs Clooney thinks outreach is a solution. Her Waging Justice for Women programme funds the Women Lawyers Association of Malawi, which arranges for specialists to travel to rural communities to seek out women looking for help. More than 85% of Malawi's population lives in villages, set in expanses of land governed by chiefs, living in huts under baobab trees, miles from roads and electricity.

"We formed a network of mobile legal aid clinics, which means literally, there's a van that goes out with lawyers, and we go out in a community and say to girls, 'These are your rights. If you need a lawyer - for free - to protect you, we are here.

"We wage justice, and we say 'waging' because you can't assume it's going to happen," Mrs Clooney said. "You have to form alliances and fight against these kinds of injustices with the determination that it takes to win

The BBC visited a legal clinic under a makeshift tent in a village in Mchinji district - it had more than 1,000 attendees, mostly women. Some were pregnant teenagers, asking what they could do to stay in school after giving birth.

"I see myself in the girls that we're fighting for," Mrs Obama told the BBC. "I see my daughters in those girls."


There is, however, concern this issue has no solution, at least in the short term. In a report earlier this year, Unicef said child marriages now made up 19% of all marriages, down from 23% 10 years ago. But it added that eliminating child marriage could still take about 300 years.

"This is an urgent issue," said Mrs Obama. "We can't afford to ignore it and assume that we can make headway on all the other big stuff that we're trying to deal with - poverty, climate change, war, and the rest - unless we're doing right by 50% of our population.


"It is an issue that can be solved tomorrow. If all the world leaders got together and made it a priority, it wouldn't take 300 years. It could happen in less than a generation."

Michelle Obama, Amal Clooney and Melinda French Gates chose to visit Malawi because each of their programmes was already supporting projects in the country. What form their long-term collaboration will take is still being worked out, but for now the women say they will back in-country organisations that have been working with communities for years.

"Large scale international organisations that are supposed to be dealing with this, like the UN Security Council, like powerful governments, are not delivering," said Mrs Clooney. "So I think philanthropy and individuals have to play a larger role."

## Dr Abbas says NMB smart beekeeping drive becomes boon for BBT initiative

NMB Bank has initiated a special programme to promote sustainable commercial beekeeping by distributing modern beehives in line with efforts to make the trade a strategic growth sub-sector.


Dr Hassan Abbas, Permanent Secretary in the Ministry of Natural Resources and Tourism, made the revelation on Monday when nationally officiating the launch of the ecofriendly honey production drive in Morogoro, which together with Tabora and Njombe regions will benefit from the distribution of the first 500 beehives under the programme.

He said that the undertaking complements the government's endeavour to make apiculture part of the Build a Better Tomorrow (BBT) initia-

According to him, beekeeping was a lucrative enterprise with impactful socio-economic benefits that will add tremendous value to the BBT youth empowerment strategy, which principally seeks to promote Tanzanian youth's engagement in sustainable agribusiness activities.

"Apart from the biodiversity benefits of bee pollination, beekeeping and forests play a significant but unheralded role in the national economy," the seasoned technocrat said in Gairo where he handed over 200 sheds earmarked for beekeepers in Morogoro

The smart beehives will be distrib-

uted equally in Gairo and Kilombero districts. Overall, the NMB programme to boost livelihoods and spur the economy will benefit over 300 members of the targeted 17 beekeepers' groups in the three regions.

"Currently these two sub-sectors employ more than two million people across the country and account for 3.5 per cent of national output (GDP) as well as 5.9 per cent of foreign exchange earnings," Dr Abbas stated.

"Because of their enormous commercial, fiscal and economic potential, the government has directed us to prepare a strategic action plan to incorporate them into BBT," he pointed out.

The importance the Sixth Phase Government accords to beekeeping, he explained, is better explained by the investments being made to make the sub-sector flourish and play its due role in national development.

These include over 2bn/- invest-

ed in seven honey packaging materials plants and establishment of a special fund to support beekeepers that has disbursed 2.9bn/- in the last five years.

Dr Abbas also mentioned a related 27bn/- joint Tanzania-EU project being implemented in five regions, namely Tabora, Shinyinga, Singida, Katavi and Kigoma.

"Among other things, this project seeks to enhance the quality of Tanzanian honey, which is highly regarded in the world," he

said, lauding NMB for the supportive investment.

## Sugar prices rising worldwide

SKYROCKETING sugar prices left Ishaq Abdulraheem with few choices. Increasing the cost of bread would mean declining sales, so the Nigerian baker decided to cut his production by half.

For scores of other bakers struggling to stay afloat while enduring higher costs for fuel and flour, the stratospheric sugar prices proved to be the last straw, and they closed

Sugar is needed to make bread, which is a staple for Nigeria's 210 million people, and for many who are struggling to put food on the table, it offers a cheap source of calories. Surging sugar prices – an increase of 55% in two months – means fewer bakers and less bread.

"It is a very serious situation," Abdulraheem said.

Sugar worldwide is trading at the highest prices since 2011, mainly due to lower global supplies after unusually dry weather damaged harvests in India and Thailand, the world's second- and third-largest exporters.

This is just the latest hit for developing nations already coping with shortages in staples like rice and bans on food trade that have added to food inflation. All of it contributes to food insecurity because of the combined effects of the naturally occurring climate phenomenon El Nino, the war in Ukraine and weaker currencies. Wealthier Western nations can absorb the higher costs, but poorer nations are struggling.

The United Nations Food and Agriculture Organization is predicting a 2% decline in global sugar production in the 2023-24 season, compared with the previous year, translating to a loss of about 3.5 million

metric tons (3.8 million U.S. tons), said Fabio Palmeri, an FAO global commodities market researcher. Increasingly, sugar is being used for biofuels like ethanol, so global reserves of sugar are at their lowest since 2009.

Brazil is the biggest sugar exporter, but its harvest will only help plug gaps later in 2024. Until then, import-dependent countries - like most of those in sub-Saharan Africa - remain vulnerable.

Nigeria, for instance, buys 98% of its raw sugar from other countries. In 2021, it banned imports of refined sugar that ran counter to a plan to build up domestic sugar processing and announced a \$73-million project to expand sugar infrastructure. But those are longer-term strategies. Abuja traders like Abba Usman are facing problems now.

The same 50-kilogram (110-pound) bag of sugar that Usman bought a week ago for \$66 now costs \$81. As prices rise, his customers are dwindling.

"The price keeps increasing every day, and we don't know why," Usman said.

It's partly due to the El Nino, a natural phenomenon that shifts global weather patterns and can cause extreme weather conditions ranging from drought to flooding. Scientists believe climate change is making El Nino stronger.

India endured its driest August in over a century, and crops in the western state of Maharashtra, which accounts for over a third of its sugarcane production, were stunted during the crucial growing phase.

India's sugar production is likely to decline by 8% this year, according to the Indian Sugar Mills Association. The world's most populated nation is also the biggest consumer

ing season altered not just the quantity but also the quality of the harvest, said Naradhip Anantasuk, leader of the Thailand Sugar Planters Association. He expects only 76 million metric tons (84 million U.S. tons) of sugarcane to be milled in the 2024 harvest season, compared with 93 million metric tons (103 million U.S. tons) this

A report by U.S. Department of Agriculture predicted a 15% dip in output in Thailand in Oc-

Thailand reversed a hike in sugar prices within days, imposing price controls for the first time since 2018. Anantasuk said this would discourage farmers from growing sugar by capping their in-

"It's like preventing the industry from growing, preventing an open competition," he said.

Wholesale prices had been allowed to rise to

help farmers cope with higher costs – partly due to government demands that they not burn their fields, which makes harvesting cheaper but envelops much of Thailand in heavy smog.

Looking ahead, Brazil's harvest is forecast to be 20% bigger than last year's, said Kelly Goughary. a senior research analyst at the agriculture data and analytics firm Gro Intelligence. But since the country is in the Southern Hemisphere, the boost to global supplies won't come until March.

This is because of favorable weather earlier this year in Brazil along with an increase in areas where sugarcane was planted, according to the

The next few months are the greatest concern, said the FAO's Palmeri. Population growth and rising sugar consumption will further strain sugar reserves, he said.

The world now has less than 68 days of sugar in stockpiles to meet its needs, compared with 106 days when they began declining in 2020, according to data from the USDA.

"It's at the lowest levels since 2010," said Joseph Glauber, senior research fellow at the International Food Policy Research Institute.

Indonesia – the biggest sugar importer last year, according to the USDA – has cut back on imports and China, the No. 2 importer, was forced to release sugar from its stocks to offset high prices domesti-

cally for the first time in six years, Palmeri said. For some countries, importing more expensive sugar eats up reserves of foreign currency like dollars and euros that also are needed to pay for oil and other crucial commodities, said El Mamoun Amrouk, an FAO economist.

That includes Kenya. Once self-sufficient in sugar, it now imports 200,000 metric tons (110,000 U.S. tons) a year from a regional trade bloc. In 2021, the government limited imports to protect local farmers from foreign competition, but it reversed that decision as harvests shrank due to insufficient rain and mismanagement.

### Co-op Bank Q3 profit rises to Sh18 billion

#### **NAIROBI**

CO-OPERATIVE Bank of Kenya posted a 7.5 percent profit growth to Sh18.4 billion in the nine months ended September, driven by higher interest income from loans.

The net earnings grew from Sh17 billion a year earlier. Co-op Bank's total interest income increased 12.8 percent to Sh49.3 billion as the lender increased its lending to ordinary customers and the government via purchase of treas-

"The strong performance by the bank is in line with the group's strategic focus on sustainable growth, resilience, and agility," said Gideon Muriuki, Co-op Bank managing

The Nairobi Securities Exchange-listed firm expanded its loan book by Sh42.9 billion to Sh378 billion while its investments in government debt securities increased by Sh2.7 billion to Sh185.1 billion.

Rising interest rates are expected to lift lending margins for banks, especially those that can avoid a substantial increase in their cost of funds as well as non-performing loans.

Co-op Bank's deposit base increased by Sh835.7 million to Sh432.8 billion while interest paid to depositors grew by Sh4.8 billion to Sh16.5 billion, reflecting the impact of rising rates.

The average rate on fixed deposit accounts across the banking sector rose steadily to peak at 8.39 percent in August, according to the Central Bank of Kenya. Lending margins have meanwhile remained stable at about 5.4 percent as lending rates also rose to hit an average of 13.24 percent in August.

Besides higher income from lending, Co-op

Bank also benefitted from lower operating costs. The bank's total operating expenses shrunk by Sh629.1 million to Sh29 billion, partly due to loan loss provision falling by Sh1.5 billion to Sh4.2 bil-

The bank's gross non-performing loans meanwhile increased by Sh10.1 billion to Sh61.9 billion. Other operating costs also fell to Sh8.8 billion from Sh9.8 billion.

Co-op Bank's subsidiaries made positive contributions to the group's overall results in the review period. Kingdom Bank posted a net profit of Sh784 million –a 28.7 percent growth from Sh609 million.

Co-op Consultancy & Bancassurance Intermediary Limited posted a pre-tax profit of Sh762.9 million while Co-operative Bank of South Sudan returned a pre-tax profit of Sh43.5 million after factoring in hyperinflation.

Co-op Trust Investment Services Limited contributed Sh154.5 million pre-tax profit as the subsidiary's funds under management closed the period at Sh196

In September this year the Co-operative Bank of Kenya overtaken KCB Group to become the second most valuable lender on the Nairobi Securities Exchange as the latter's share price continued to fall.

Co-op Bank's stock was unchanged at Sh11.85, giving it a market capitalisation of Sh69.5 billion.

This saw the lender overtake KCB for the first time, opening a gap of Sh2.3 bil-

KCB's share price fell 4.78 percent on Thursday to close at a new 52-week low

of Sh20.9, assigning it a market value of Sh67.1 billion. The bank's share price fall gained pace in recent weeks after it reported lower earnings and a surge in provisions for loan defaults in the half year ended June.

At the start of the year, KCB's market value was ahead of Co-op Bank by Sh52.2 billion. KCB's relegation to third place came after it shed Sh56 billion in paper wealth since the first trade of the year.

Over the same period, Co-op Bank has lost only Sh1.4 billion. The bank has one of the lowest share price volatility among the country's publicly-traded lenders.

Equity Group remains the most valuable bank at Sh135.6 billion despite losing Sh34.3 billion over the review period.

At current levels, Equity is valued at almost KCB and Co-op Bank combined. The second-place rank is likely to remain in contention as observers watch the evolution of the performance of the two lenders in the next few quarters. Their rivalry is among the upheavals in the league table of Kenya's listed banks.

Standard Chartered Bank Kenya has also closed in on NCBA Group with their market capitalisation standing at Sh61.8 billion and Sh62.1 billion respectively as of Thursday.

StanChart has grown its market value by Sh7 billion since the start of the year while NCBA has lost Sh2 billion over the same period, leading to the convergence. The biggest change in shareholder paper wealth was seen at KCB whose chief executive Paul Russo, now in his second year at the helm, is taking measures to

KCB reported a 20 percent net profit drop in the six months to June, nearly tripling its provisioning for loan defaults. Its net profit fell to Sh15.5 billion from Sh19.5 billion posted in the preceding similar period.

address the legacy bad debt at the lender.

KCB's operating expenses increased by 60 percent to Sh50.61 billion while provisions for non-performing loans jumped 2.4 times to Sh10.2 billion from Sh4.32

Analysts say investors have overreacted to the bank's spike in provisions, placing a buy recommendation on the stock.

All the listed banks remain undervalued by historical standards, with the lenders having previously traded at multiples of their net assets before the onset of the bear run.

### Kenya takes a step towards regulating crypto-currency

#### **NAIROBI**

THE Kenyan government has asked the Blockchain Association of Kenya (BAK) to write the first draught of the Crypto Bill, also known as the Virtual Asset Service Provider's Bill, in a move that could see crypto-currencies regulated.

The government made the recommendation after BAK appeared before the National Assembly Committee on Finance and National Planning.

BAK appeared before the committee to discuss digital asset legislation and how it may collaborate with the government to promote advantageous digital asset policy.

Representatives from Binance, Yellow Card, Kotani Pay, and the Law Society of Kenya were also present throughout the deliberations

They gave a comprehensive presentation to the committee outlining critical factors for implementing a strong crypto regulatory framework.

This featured a clear licencing structure, a tax framework, a framework for consumer protection, anti-money laundering and counter-terrorism financing measures, and a regulatory sandbox.

This is not the first time that Kenyans have discussed crypto-currency regulations.

The Kenyan Senate took the proactive move in February of this year to engage the Central Bank of Kenya (CBK) in discussions that could result in the country legalising the usage of crypto-currency as legal cash.

The Senate's Standing Committee on Information, Communication, and Technology, chaired by Trans Nzoia Senator Allan Chesang, led the debate.

The CBK addressed the need, opportunity, and risks provided by digital currencies in Kenya in its discussion

The regulatory framework is planned to investigate a wide range of digital payments, including electronic money (e-money), crypto-currency, stable coins, and Central Bank Digital Currency, which is defined by the CBK as a digital currency issued by the central bank and intended to serve as legal tender.

It is the same as fiat currency and may be exchanged one for one with fiat currency, except that it is in elec-

The CBK also invited members of the public, industry, and stakeholders to peruse the Discussion Paper and provide appropriate feedback.

Kenya is Africa's third most active Bitcoin asset trader, with the largest web traffic to crypto-currency sites.

If passed, the bill will be a key step towards the realisation of a comprehensive regulatory framework for Kenya's digital asset business.

## UN chief calls for 'record action' to tackle climate change

**UNITED NATIONS/NAIROBI** 

Antonio Secretary-General Guterres on Monday called for "record action" from world leaders to tackle cli-

Present climate trends are racing planet Earth down a dead-end threedegree temperature rise, he said at the launch of the Emissions Gap Report 2023 of the UN Environment Program

"In short, the report shows that the emissions gap is more like an emissions canyon -- a canyon littered with broken promises, broken lives, and broken records," said Guterres.

All of this is a failure of leadership, a betrayal of the vulnerable people, and a massive missed opportunity, he said. "Leaders must drastically up their game now, with record ambition, record action, and record emissions reductions."


The next round of national climate plans will be pivotal. These plans must be backed with the finance, technology, support and partnerships to make them possible. The task of leaders at the upcoming UN Climate Change Conference in the United Arab Emirates (COP28) is to make sure that happens,

COP28 will respond to the Global Stocktake -- an inventory of countries' climate plans that will show just how far the world is from meeting the goals of the Paris Agreement. That response is vital. Voluntary initiatives and nonbinding commitments can play an important role. But they are no substitute for a global response agreed by all, he

"The response to the Global Stocktake must light the fuse to an explosion of ambition in 2025. It must align with what the science tells us is needed. It must set out plans to massively increase ambition and investment in adaptation. It must commit to a surge in finance and cooperation. And it must set an expectation for more ambitious and detailed national climate plans," he

That means national plans with clear 2030 and 2035 targets, that align with 1.5 C, that cover the whole economy, and that plot a course for ending fossil fuels, he said.

Achieving all this depends on countries cooperating and working together. The recent climate statement between China and the United States is a posi-

tive first step. But much more needs to be weather events, low-carbon lifestyles must bedone, said Guterres.

"At a time of doubt, division and distrust, we need the response to the Global Stocktake to restore credibility in climate action. Leaders can't kick the can any further. We're out of road. COP28 must set us up for dramatic climate action -- now," said Guterres.

#### 'India-Australia important for each other's future'

**NEW DELHI** 

THE Australian Minister for Foreign Affairs, Penny Wong (pictured) said yesterday that the India-Australia bilateral relationship is really significant for both countries' futures and



expressed her determination to work together to achieve shared objectives in the region.

"We (India-Australia) share so much. We share a history. We both value our democratic traditions. We both love our sporting traditions. But I think, even more importantly, we understand how important we are to each other's future," she said.

While speaking at the Foreign Ministers' Framework Dialogue with External Affairs Minister S Jaishankar, she added, "That is a point about the bilateral relationship, that's a point about us working together in the region. As you said, whether it is bilaterally or through the Quad or through other mechanisms, we know that this partnership is to the peace, prosperity and stability of the region. We are very focused on and determined to work with you towards that shared objective."

EAM Jaishankar met his Australian counterpart Penny Wong in the national capital for the Foreign Ministers' Framework Dialogue on Tuesday morning.

"Glad to welcome FM @SenatorWong of Australia to Hyderabad House today morning. Our Foreign Ministers' Framework Dialogue will advance our strategic partnership," Jaishankar posted on X (formerly Twitter).

Earlier on Monday, the India-Australia 2+2 Ministerial Dialogue took place with EAM Jaishankar and Defence Minister Rajnath Singh participating with their Australian counterparts; Australian Foreign Minister Penny Wong and Australian Defence Minister Richard Marles.

In her opening remarks, Wong said that Canberra deeply values its bilateral relationship with New Delhi, adding that it is "crucial to region" where sovereignty is respected. She further noted that the two nations have done a lot together bilaterally and hope to do more.

During the meeting, Jaishankar said that the bilateral relationship between India and Australia has grown rapidly and noted that it has larger implications for the region. He called the partnership between India and Australia in Quad format "very beneficial" for bilateral relations and the Indo-Pacific region.

## China's role in volunteerism praised by UN

A senior United Nations official in charge of the UN volunteers who contribute to global socioeconomic development has hailed China's focus on volunteerism, welcoming the Chinese volunteers' role in bolstering sustainable development worldwide.

Toily Kurbanov, executive coordinator of United Nations Volunteers, noted that volunteers are taking the lead in climate action and creating a world without poverty and hunger, and that through volunteering, "young people in particular are honing their talents and acquiring exposure to international development".

"Through its important steps, China is encouraging young people to volunteer and to become global advocates for sustainable development," he said in an exclusive interview with China Daily.

He noted that this year, 134 Chinese nationals have served as UN Volunteers. Among them, 85 work with 11 UN agencies within China, including the UN Development Programme.

"These volunteers work on important projects throughout China in areas such as poverty alleviation, food security, environmental protection, children's rights and women's empowerment," he said.

Forty-nine UN Volunteers from China are working with the UN in 21 countries in Asia, Africa and Latin America, including Nepal, Sri Lanka, Turkiye, Kazakhstan,

#### Fight against terrorism should not violate humanitarian law – Lavrov

**MOSCOW** 

RUSSIA does not support terrorism in any form but does not believe the fight against it should violate humanitarian law, Russian Foreign Minister Sergey Lavrov said, commenting on the Israeli-Palestinian conflict.

"I would like to reiterate that we condemn each and every form of terrorism but when it comes to the fight against terrorism, there is a need to use methods that neither suggest collective punishment nor run counter to international humanitarian law, or rather, frankly speaking, blatantly violate it," the top Russian diplomat pointed out at a meeting with his counterparts from a number of Arab League and Organization of Islamic Cooperation member

Tensions in the Middle East flared up again after Hamas militants infiltrated Israel from the Gaza Strip on October 7, killing residents of border settlements and taking people hostage.

The Palestinian movement described its attack as a response to the actions of Israeli authorities against the Al-Aqsa Mosque on Jerusalem's Temple Mount.

Israel announced a total blockade of Gaza and started carrying out strikes on the Palestinian enclave, as well as on certain areas in Lebanon and Syria.

### Sunak reportedly said 'just let people die', virus inquiry hears

LONDON

PRIME Minister Rishi Sunak was quoted as saying the government should "just let people die" during the COVID-19 pandemic rather than impose a second national lockdown, the inquiry into how Britain handled the crisis heard on Monday.

Patrick Vallance, who was the government's chief scientific adviser during COVID, made a note in his diary on Oct 25, 2020, about a meeting involving then Prime Minister Boris Johnson and Sunak, who was finance minister.

The diary entry shown to the inquiry recorded how Dominic Cummings, Johnson's most senior adviser during the pandemic, had relayed to Vallance what he said he had heard at the meeting.

Vallance quoted Cummings in his diary as saying: "Rishi thinks just let people die and that's okay. This all feels like a complete lack of leader-

ship." A spokesman for Sunak said the prime minister would set out his position when he gives evidence to the inquiry "rather than respond to each one in piecemeal".

The inquiry is examining the government's response to the coronavirus pandemic that shut large sections of the economy and killed more than 220,000 people in Britain. It is due to run until the summer of 2026.

Senior government officials have repeatedly said the government was unprepared for the pandemic and a "toxic" and "macho" culture hampered the response to the health

The danger for Sunak is that evidence at the inquiry undermines his attempt to cast himself as a change to the chaotic leadership of Johnson even though he was one of the most senior ministers in that government.

### UAE minister calls on global leaders to unleash potential of food systems in fight against climate change

TODAY, Mariam bint Mohammed Almheiri, UAE Minister of Climate Change and Environment and COP28 Food Systems Lead, addressed the Global Food Security Summit in London, where she called on global leaders to find the will to work collectively and creatively to unleash the potential of food systems in the fight against climate

The Summit held in partnership between the UAE, the UK and Somalia, and sponsored by the Children's Investment Fund Foundation and the Bill Melinda Gates Foundation, saw the United Kingdom show strong support for the COP28 Food Systems and Agriculture Agenda, including their endorsement of the Emirates Declaration on Resilient Food Systems, Sustainable Agriculture, and Climate Action.

The Declaration commits nations to putting climate action at the heart of their food systems by aligning their national food systems and agricultural strategies with their Nationally Determined Contributions, National Adaptation Plans and National Biodiversity

The Declaration forms part of the first of four pillar's that make up the COP28 Food Systems and Agriculture Agenda galvanizing national leadership; involving non-state actors; boosting innovation; and scaling up finance.

Almheiri said: "What we are seeing unfold around the global is a devastating cycle of escalating climate threats that can be avoided, but only if we show the resolve to make a difference and walk the talk".

"I am delighted that the United Kingdom supporting Emirates Declaration on Resilient Food Systems, Sustainable

Agriculture, and Climate Action. It is only through collective action can we make a substantial change and protect our planet and people'

In her opening remarks in the presence of dignitaries including Rishi Sunak, Prime Minister of the United Kingdom, and Hassan Sheikh Mohamud, President of Somalia, Almheiri stressed as hosts of COP28 in just 10 days' time the UAE intends to "build on top of the momentum of action for the food and climate agenda which was firmly set on course by the United Kingdom at COP26 and then accelerated and further accentuated by Egypt at COP27".

She outlined through its COP28 Food Systems and Agriculture Agenda the UAE will elevate the food systems debate and "place it at the very heart of the Presidential Action Agenda".

Looking ahead to COP28 in 10 days' time, the minister added, "The program of the COP28 Presidency begins with a able agriculture sector and Food Syshigh-level session on Food and Climate. Every day thereafter includes at least one Presidency-hosted event related to agriculture and food systems, with the program reaching a crescendo on December 10, before the Parties move on to the final negotiations on December 11 and 12, we are marking a day dedicated to food, agriculture, and water".

The minister stressed: "Our goal is to highlight the severe pressure and risks that climate change puts on food, agricultural and water systems, which are pivotal to human well-being. At the dedicated day to food, agriculture, and water at COP28, we will reiterate both the challenge and the opportunity presented by food systems and their interactions with our precious planet."

Later in the afternoon, Almheiri also opened a series of panel discussions on 'Building a climate resilient and sustaintem'. She spoke about the importance of innovation, technology, and finance in transforming our food systems and creating a more sustainable world.

The minister detailed the key milestones in UAE's climate journey to date such as the Cabinet's recent approval of the Net Zero 2050 Strategy that outlines mechanisms to achieve zero emissions in the UAE across all core sectors, including agriculture, as well as the UAE's Third Update to its Second Nationally Determined Contribution, the third in three years.

She stated: "By progressively raising ambition we are making real change in our green transformation. It is through the wise direction of the UAE's leadership that we are able to take bold and deceive steps towards Net Zero and a greener future".

## Putin points to UNHRC's political bias in Donbass conflict

**MOSCOW** 

THE Human Rights Council (UNHRC) and other international institutions in the field of human rights have demonstrated their



political bias throughout the duration of the conflict in the Donbass republics and Novorossiya, Russian President Vladimir Putin said.

"Unfortunately, throughout the history of the conflict in Donbass and Novorossiya, international institutions which are supposed to guarantee and promote human rights - the UNHRC, the Council of Europe and others have demonstrated their biased position and inability to do their job," he said, addressing an international conference on the 75th Anniversary of the Universal Declaration of Human Rights (UDHR) underway in Moscow.

"Given their clearly biased stance, Russia was forced to withdraw from these institutions, but it continues to strictly adhere to its human rights commitments," Putin said.

The international community is screaming for radical changes, the Russian leader said as he called for ensuring a fair approach to the implementation of human rights based on mutual respect, with the cultural and historical peculiarities of countries being taken into account.

Also, Putin urged that civic institutions should play a substantial role in achieving this goal.

## China's logistics sector injects new vigor into world economy

IN recent years, Chinese logistics companies have rapidly expanded their presence in overseas markets alongside the growth of China's cross-border e-commerce platforms. Over the course of 48 hours, millions of people worldwide witnessed the complete journey of cross-border packages, from packing and sorting to shipping, consolidation, and loading onto international cargo planes.

Cainiao Global, the official global parcel tracking platform of China's Alibaba Group, has introduced its flagship product, the "Global 5-Day Delivery" express service, for this year's "Double 11" shopping festival. This service allows products sent from China to reach consumers thousands of miles away in just five days.

To achieve such fast delivery, Cainiao Global has made significant advancements in logistics technology and infrastructure. The company has established the country's largest cross-border logistics park, equipped with intelligent sorting machines and an automated air freight center. Additionally, the use of a Boeing 747 widebody freighter further enhances the efficiency of the delivery

come a competition for faster delivery, receipt, and after-sales service for cross-border merchants and overseas consumers.

The "Double 11" shopping festival is China's biggest shopping event. Since its inception in 2009, the festival has been known for its abundance of discounts, promotions, and offers. This year, instead of solely engaging in the price war, companies have prioritized providing high-quality services to their cus-

JD Logistics, the logistics unit of Chinese e-commerce giant JD.com, has been making consistent investments in overseas supply chain logistics facilities.

With nearly 90 bonded warehouses, overseas warehouses, and direct mail warehouses worldwide, JD Logistics has established a self-operated warehousing network in European countries like Germany, France, and the UK. Alongside expanding its warehousing capacity, JD Logistics Europe is actively collaborating with local service providers to enhance its last-mile delivery capabilities.

In 2022, China's total social logistics reached 347.6 trillion yuan (about \$47.89 trillion), marking a 3.4 percent year-on-year growth. With this growth, China's logistics market has maintained its position as the global leader for seven consecutive years, solidifying its status as a logistics power-

The steady and positive growth of the Chinese economy has provided significant support for the rapid development of the logistics industry. The government's increased support to promote economic growth, coupled with a rebound in consumer spending, has led to impressive economic performance in the third quarter.

Data released by the National Bureau of Statistics of China shows that the country's GDP grew by 4.9 percent year-on-year between July and September this year, surpassing economists' median forecast of 4.5 percent.

The growth of cross-border e-commerce has contributed to the expansion of China's cross-border logistics industry.

According to recent data from the Korea Customs Service, Koreans spent a total of 4.79 trillion won (approximately \$3.65 billion) on cross-border online shopping from Q1 to Q3 this year, marking a 20.4 percent increase compared to the previous year. Chinese e-commerce accounted for 46.4 percent of this total, with sales amounting to 2.22 trillion won.

According to China's Ministry of Commerce, the import and export volume of China's cross-border e-commerce reached 1.7 trillion yuan from January to September this year, marking a year-on-year increase of 14.4 percent. China has established trade

partnerships with countries worldwide, being one of the countries with the most comprehensive cross-bor der e-commerce ecosystem.

Overseas warehouses play a crucial role as key nodes for cross-border ecommerce and logistics. They serve as new foreign trade infrastructure and a vital platform for driving the high-quality development of foreign trade.

Xue Qun, head of JD Logistics International, recently expressed that JD.com plans to construct a comprehensive global supply chain logistics network in the coming three years. This network will encompass overseas warehouse networks, international transit hubs, distribution networks in foreign countries, and cross-border transportation networks encompassing key routes.

According to a news report by Quartz, China views logistics as a strategically important industry underpinning the efficiency and competitiveness of its economy. The Chinese government wants to take that a step further by building a modern circulation system that integrates flows of commerce, finance, transportation, and commodities.

According to the news report, one area where China has made significant progress in recent years is the number of overseas warehouses it operates via exporters or cross-border e-commerce firms with operations in international markets. These now number over 2,000, up from less than 100 in 2015, according to Chinese government fig-

### India advocates for sovereign, independent state of palestine at UN, opposes violence

Speaking at the United Nations General Assembly informal discussions on the humanitarian situation in Palestine on Monday, Kamboj said, "India's consistent position of achieving a just, peaceful and lasting solution to the Israel-Palestine issue. India has always advocated the resumption of direct negotiations towards establishing a sovereign, independent and viable state of Palestine living within secure and recognised borders side by side at peace with Israel."

Kamboj, welcoming the international efforts to ensure further de-escalation of the conflict, also affirmed that India opposes terrorism in all its forms and manifestations and is clearly against violence.

She said, "India welcomes all efforts by the international community that strive towards a de-escalation of the conflict and enables the delivery of urgent humanitarian assistance to the people of Palestine."

She added, "The message from our leaders has been clear and consistent - we are firmly opposed to terrorism in all its forms and manifestations, clearly against violence and are on the side of adherence to international humanitarian law and ensuring that further escalation is prevented, humanitarian aid delivery continues, all hostages are released unconditionally and

all parties work towards an early restoration of peace and stability. Towards this, INDIA advocates for the resumption of we also welcome efforts for humanitarian pauses.

Kamboj highlighted that India has already delivered 70 tonnes of disaster relief materials, including medicines and medical supplies, to the people of Palestine.

She stated, "We are also firm in our commitment to provide humanitarian aid to the people of Palestine and have already delivered 70 tonnes of disaster relief materials including 17 tonnes of medicines and medical supplies in two tranches and our humanitarian support continues. Similarly, India continues to play an active role as Member of the Advisory Commission of the United Nations Relief and Works Agency for Palestine Refugees in the Near East (UNRWA)."

Israel announced war against Hamas after it launched attack on Israel on October 7 and killed about 1,200 people, mostly civilians, with around 240 people taken hostage, according to Israeli officials.

Meanwhile, amid the ongoing situation in Gaza, South African President Cyril Ramaphosa will host the BRICS groups of nations to convene a virtual BRICS Extraordinary Joint Meeting on Monday, the South African President Office said.

In a major development, United Nations Secretary General Antonio Guterres will also participate in the virtual meeting.

As per the press statement, in the meeting, the South African President will deliver an opening speech, followed by speeches from invited states and members on the current humanitarian crisis in Gaza.

HARDLY anyone is talking about improving the Young Africans SC line up or back up squad, in the wake of an unheralded 5-1 win against archrivals Simba SC, in an encounter where all the cards were staked in favour of the latter, except the timing.

They were just coming out of a social celebration of sorts two days earlier, presumably going well into early hours of the next day. As they say, the rest is history; the Msimbazi Street side is still ruing the fallout with a members' revolt.

Before the phenomenal rout of the more ambitious club side in relation to continental competitions, it was the Jangwani Street side which appeared to be in need of an uplift as it had suffered a defeat at Ihefu FC and with the archrivals at the start of the season.

While the club side was itself convinced of its prowess as it reached the group stage of the CAF Champions League, close watchers saw many gaps in the qualification, as El Mirreikh is a pale shadow of its former self.

It lost most of its foreign players, with the exception of a South Sudanese and a Colombian.

What has given the Jangwani Street side vastly renewed confidence is the derby drubbing of their archrivals, such that for a few weeks if not months it will be overly difficult to speak of the team except in

Yet this will have its limits and it may not have to wait long, as upsets like the Ihefu encounter can always be produced out of insufficient attention, following some 5G outcome or anything.

The point is that the 5G win against their rivals was a bolt from the blue.

It unavoidably had links with structural strengths and weaknesses of their rivals, sort of exaggerated to the limit because of the festival environment, so finally it is this atmosphere that did it.

There was perceptibly a wrong choice of players in the goalkeeping though pundits don't agree about that, and there are stories of changing room shenanigans where some calming spray would have

been used in the room before the half time breather. It took energy out of the side and failed it, plus faulty team selection options that have elicited vibrant defence from pundits.

Put differently, there is going to be a short period of experimentation for the

Jangwani Street side, especially its fan base, to actually arrive at the position that the side needs a new coat of paint.

On the whole, the club has been relatively less disposed of discussing its actual team strength on account of the Confederation Cup final appearance in the past season. It was twice dented, and then

Despite that former coach Nasreddine Nabi took the club to heights in continental competition - via a window that is now closed - there are areas where the current coach can claim to be more successful in

Since there were no star signings for instance in the likeness of ex-Yanga striker and now Pyramids superstar Fiston Mayele, the tactical arrangements of Miguel Gamondi have in a sense produced the chemistry that the side needed, with the new signings that came on board.

They weren't as expensive compared to their

archrivals across the street.

That is what made a number of observers see a brighter future for Simba SC in this year's tournaments, but at the local league level their rivals have been somewhat more convincing, despite slips ups like the sharp pain of Ihefu FC defeat.

It was a reminder that the side still needs to be improved, but after crossing the Champions League preliminary stages and enter the group stage, despite glaringly benefiting from the ravages in Khartoum and Omdurman, the worry subsided somewhat.

The massive derby win stands to silence voices for a while, till reality comes knocking.

The dreaded moments aren't far to seek, as the Jangwani Street side drew two of

CAF Champions League best sides in its group, that is, along with Medeama FC of Ghana.

The two are Algerian champions Belouizdad FC and veteran Egyptian continental leaders Al Ahly, in a sense the toughest draw that the Jangwani Street side could have expected.

Their rivals by contrast only have Wydad Casablanca as an acknowledged strong side to be worried about, while Botswana hard hitters

Jwaneng Galaxy and Ivorian side ASEC Mimosas are fellow travelers like Simba.

It is thus staggering to any aware observer that the Jangwani Street side has fewer chances of making it beyond the group stage, and equally, faces little fan base pressure to improve the side in terms of signings.

The club's situation in the local league is largely comfortable as league leaders, with a series of excellent wins.

It is reason enough to believe that the side is in safe hands, and has a performing squad.

That is what is being projected into the continental championship, where the fans believe that the side is strong enough for the challenges, but the leadership is more reserved, reiterating their group stage target for this year, following the biting draw.

There was a time some people started projecting the team at higher stages but for all intents and purposes this has ended.

Few believe they can scale up the tree and emerge among the best two; afterwards, they may start rethinking **SPORTS**

#### Southgate expects Euro charge despite drab draw with North Macedonia

#### LONDON

GARETH Southgate insists England's lacklustre finish to the Euro 2024 qualifying campaign will mean nothing when they start their bid to win the tournament in Germany.

Such are the expectations that Southgate is working under these days that qualifying with an unbeaten record from a potentially tricky group including Italy and Ukraine earned him few plaudits.

Being held to a 1-1 draw by North Macedonia on Monday meant England failed to beat a side as low as 66th in the FIFA rankings for the first time since 2016, when they drew with

But with a runners-up finish at the last European Championship in 2021, as well as World Cup semi-final and quarter-final appearances in the Southgate era, England's status as one of the Euro favourites is well earned after six victories from their eight qualifiers.

And Southgate is confident England's drab end to the qualifying campaign will prove nothing more than an irrelevant blip.

"The really big results were in March against Italy and Ukraine. It meant coming here was a completely different test," he said.

"I thought that given we had already qualified and everything had been achieved the mentality of the players was excellent.

"The quality on the ball was good on a difficult pitch. Just that final pass or finish was difficult to find. But I thought there were lots of positive performances."

One area of concern for Southgate could be his team's struggle to pierce the massed ranks of North Macedonia and Malta's defences over the last four

Southgate was without influential Real Madrid midfielder Jude Bellingham due to injury for both qualifiers, while England's record scorer Harry Kane was left on the bench for the first 58 minutes against North

Only when Kane came on did England snatch their equaliser, an own goal from Jani Atanasov as he tried to stop the Bayern Munich striker turning in Phil Foden's corner.

## Holders Italy secure Euro 2024 place, Czech Republic and Slovenia qualify

REIGNING champions Italy secured their ticket for Euro 2024 on Monday after holding on for a nervy goalless draw against Ukraine in their final qualifier, while the Czech Republic and Slovenia also clinched places at next year's finals.

Italy only needed the draw in a game played in Leverkusen, Germany, in order to qualify but a defeat against their direct rivals in Group C would have left their fate to be decided in play-offs next

That was a scenario they desperately wanted to avoid following the trauma of failing to qualify for the 2018 and 2022 World Cups after losing in play-offs, either side of winning the last European Championship in 2021.

The high stakes made it a tense occasion and Italy goalkeeper Gianluigi Donnarumma had to produce a firm hand low down to keep out an early Georgiy Sudakov

"We are delighted. After all the difficulties we have had, we will be in Germany and we will be going there as reigning champions and going there to win," Donnarumma told broadcaster Rai 1.

## Everton to argue 10-point deduction was unconstitutional in appeal to Premier League

THE Premier League's failure to adopt a detailed "sanction policy" for its financial rules could form a key plank of Everton's appeal against an unprecedented 10-point deduction, Telegraph Sport can reveal.

The club is formulating its strategy for overturning their "wholly disproportionate" punishment for breaking profit and sustainability (PSR) regulations and it may include zeroing in on one element of the judgment by an independent commission.

The 41-page decision stated that: "On 10 August 2023 the Premier League board adopted a sanction policy that it considered to be appropriate to breaches of the PSR."


It went on to state that included a starting point of a six-point deduction plus a point for every £5 million by which those rules had been broken.

The independent commission refused to use that formula for a case that was brought before the Premier League came up with that "policy" but still ended up imposing a sanction almost exactly in line with it.

Everton may need to convince an appeal board to take an even dimmer view of the lack of a detailed sanction policy if they are to succeed in securing a more lenient punishment.

The original commission made clear Premier League rules gave it the power to impose a range of sanctions that include deducting points, and that although the English Football League did have sanctioning guidelines, commissions were not bound by them.

An appeal board would also have the power to increase Everton's sanction but the prospect of it doing so is remote given the original punishment ended up in line with the Premier League "policy".

\*Everton will stress they were not guilty of a 'deliberate cynical breach' The club could also point to the original commission's ruling that they were not guilty of a "deliberate cynical breach of the PSR to achieve a sporting advantage" - although it did nevertheless find a sporting advantage had been obtained - and may argue again that they "cooperated fully with the Premier League's investigations".

Everton's appeal must be lodged by December 1 under a 14-day timetable outlined in the governing body's rules.

Rival teams relegated during the period of the club's rule breach - including Leeds United, Leicester City, Burnley and Southampton - have a further two weeks to lodge claims for compensation that could exceed

Everton would fight any such claims, while their appeal has won the backing of the Liverpool-supporting Mayor of the Liverpool City Region, Steve Rotheram.

of the Premier League, Richard Masters, Rotheram wrote: "While I understand, and indeed support, the importance of maintaining discipline and upholding the integrity of the sport, it is crucial to ensure that any punitive measures are proportionate and just. I do not believe that this punishment fits the crime.

In a letter to the chief executive

"As many people have pointed out, the punishment imposed appears severe for the charge in question and sets a new precedent.

"In 2010, when Portsmouth entered administration, a case of serious mismanagement, they were hit with only a nine-point penalty. For falling into administration a second time in three years, in 2012, they faced a 10-point deduction. The implication that Everton's actions are somehow more egregious is, frankly, ludicrous.

"I completely support the club's appeal and would urge you to take a more balanced approach and consider alternative forms of punishment that do not unfairly penalise the club's players and supporters. As a founding member of both the Football League and Premier League, Everton are an important part of the fabric of English football. They deserve to be treated fairly, justly and with respect."

**RECORD Tanzanian champions** Young Africans yesterday left the country for Algeria where they will kick start their 2023/24 CAF Champions League group stage campaign.

Young Africans are lined up to play against CR Belouizdad of Algeria at the Stade du Juillet 1962 Stadium on Friday from 10 pm (East African Time).

The first batch of Young African players and technical bench members left Dar for Algiers yesterday

The group is mainly composed of players who were not called up for national team duties during the international break.

The final batch, including Aboutwalib Mshery, Metacha Mnata, Dickson Job, Bakari Mwamnyeto, Ibrahim Hamad, Nickson Kibabage and Mudathir Yahya, who were with Taifa Stars, was

expected to leave today at 4 am following their involvement in the game against Morocco last night.

Stephane Azizi Ki, Djigui Diarra and Khalid Aucho, who were with Burkina Faso, Mali and Uganda national teams, are expected to join the rest of the team immediately after their international

Speaking just before the first batch of players boarded Turkish Airlines, club spokesman Ali Kamwe said they are to report no injury in the squad.

"The technical bench tracked all groups. It was easy to monitor and issue instructions to the first group that remained here. The other groups, in the sense of the players in the national teams, we tracked them to check their fitness levels.

"We would not like to see our players in the national team have a drop in fitness levels. We are monitoring them to see if there are minor injuries they have received and how we can solve them quickly. We are grateful that until now before Tuesday's games all our players are well.

"And the entire traveling batch is also safe. The coach is satisfied with their fitness and we believe they are going to fight to ensure we get a good result in Algeria,"

Young Africans will not be taking part in any of the NBC Premiership action for the rest of November as they look to do well in their long-awaited return to Africa's premier club competition.

After the North African trip, their first home outing will come against Al Ahly at the Benjamin Mkapa Stadium on Saturday, December 2 (19:00 EAT) on matchday two of CAF Champions League group stage.

A busy December will also see Young Africans travel to Ghana for a date with Medeama for the first time since 2016 when the two teams met in the CAF Confederation Cup group stage. The game is set to take place on Friday, December 8 (kick-off 19:00 EAT).

The reverse fixture in Dar will follow next on matchday four, as Wananchi host the Ghanaians. The confirmed date for that encounter is Wednesday, November 20 (16:00 EAT).

## Prisons part ways with head coach Fred Minziro

TANZANIA Prisons have parted company with head coach Fred 'Minziro' Kataraiya. Minziro's departure took the total number of coaches' exits in the NBC Premier League to seven for the season.

It comes after a disappointing run for the Mbeya side, losing four of their opening nine matches of the

There have been losses to Kagera Sugar, Simba, Tabora United and

The team managed one victory and four draws to collect seven points that leave them in the relegation zone. Minziro took the reins at Prisons

in July. He had coached Geita Gold for two years helping them secure a top-four finish in their debut top-He eventually led them to the Confederation Cup. He parted ways

with Geita Gold at the end of last Prisons said in a statement: "For the great benefit of the team, the management has mutually termi-

nated the contract of coach Minziro effective from today." Wajelajela have also confirmed that assistant coach Shaban Mtupa

will take charge on an interim basis. The team is currently third from the bottom of the NBC Premier League and next faces Coastal

Union tomorrow. Through just nine games, seven coaches have already been sacked or resigned following starts not aligning with preseason expecta-

The first coach to leave their job this season was Singida Fountain Gate's Hans van der Pluijm. He resigned from his post on August 30, having led them to a top-four finish.

Pluijm was replaced by Ernst Middendorp, who guided the team in just one game before stepping down from his post.

Ihefu coach Zuberi Katwila was next in line.

Katwila resigned and was subsequently unveiled as the new Mtibwa Sugar head coach. He was succeeded by Ugandan coach Moses Basena.

The third coach to be sacked was Habib Kondo.

Mtibwa Sugar sacked Kondo on October 18 following a poor start to the season. He was removed while the club was languishing in the relegation zone and replaced him with Katwila, who had already coached the team.

The next to go was Namungo head coach Cedric Kaze with the club struggling at the bottom of the table with no win from six games. Dennis Kambi, who was part of the technical bench, came in his place.

On October 26, relegation battlers Coastal Union pulled the trigger on Mwinyi Zahera after his side had collected just five points from the first seven games.

He was replaced by Kenyan coach David Ouma.

Brazilian Robert 'Robertinho' Oliveira was relieved of his duties as Simba head coach a day after losing 5-1 to arch -rivals Young Africans.
