New US app rollout easing fight against rabies in Mara region

SCIENTISTS working in Tanzania have developed a new internet application that can determine if a dog was vaccinated for the rabies virus with a cellphone camera imagebilled as a game changer in the fight against the disease.

The research team based out of the Washington State University (WSU) Paul G. Allen School of Global Animal Health is working with PiP My Pet, the firm that developed a mobile application using facial recognition to reunite lost pets with their owners.

A statement published yesterday by WSU said that rather than locate the lost animals, the company designed a new app to track which dogs were vaccinated for the rabies virus, and more importantly which dogs still require the vaccine.

The app is currently being rolled out in a series of field trials as part of the National Institute of Health, a government agency now handling a vaccination trial in Mara region, it

The trial, which will provide the first mass dog vaccination against rabies in the region is aimed at testing the efficacy of two delivery

First, it uses teams of vaccinators in vehicles to visit each village in turn, whilst the second uses village-based vaccinators to deliver mass vaccination of dogs.

"This technology means we don't have to insert expensive microchips to identify each vaccinated dog," explains Felix Lankester, director of the WSU Rabies Free Tanzania program. "It saves us time and money, both very important commodities in our mission to eliminate human rabies in East Africa."

Each microchip costs about \$1 US, which quickly adds up when you consider that the WSU rabies elimination campaign vaccinated more than 275,000 dogs in 2019 in Kenya and Tanzania. The effort is now nearing two million vaccinations.

The World Health Organization affirms that rabies kills about 59,000 people every year, mostly in Africa and Asia, where 95 percent of human rabies cases occur. More than 99 percent of human rabies cases are due to transmission from rabid dogs.

"People in the West are often surprised to hear that in East Africa rabies kills so many people each year and mostly children," Lankester said. "Because we no longer need

NSSF turns Dar apartment blocks into student hostels

THE National Social Security Fund (NSSF) has turned its Dar es Salaam-based apartment blocks into hostels for university students after seeing this rental mode is more viable business than rental housing.

The NSSF director of planning, investments and projects. Gabriel Silavo told The Guardian in an interview that the decision to turn Mtoni Kijichi properties into students' accommodation was reached after conducting a thorough market demand study.

"We first studied market demand and recognized that there is still a challenge in students' accommodation. So we thought it was better to sign agreements with colleges," he said.

Silayo said that despite market demand, the fund decided to bring its services close to students who are grappling with proximate and safe residence for studies.

"It is not that we failed to rent the apartments

to other people but our aim is also to help students especially girls get safe places to stay and concentrate on their studies.'

On transport, Silayo said that there will be bus shuttles to take the students to and from the hostels.

"There will be no challenge in transport as most colleges are located near the hostels for example the Dar es Salaam University College of Education (DUCE), the Tanzania Institute of Accountancy (TIA) and the Mwalimu Nyerere Memorial University, while the Institute of Finance Management (IFM) and the Dar es Salaam Institute of Technology (DIT) are much farther within the city centre," he said.

On accommodation expenses, Silayo said that this will be supervised by the universities themselves at affordable rates.

Late last month, NSSF handed over buildings with a total of 32 floors located at Mtoni Kijichi suburb in Dar es Salaam to be used by six

ATCL urges local merchants to start using its Mumbai route

AIR Tanzania Company Limited (ATCL) is set to carry a delegation of Tanzanian businesspeople to India to attend a trade forum with their counterparts in the Asian country.

The forum is also expected to allow the Tanzanian delegation to pursue various opportunities for crop markets.

Speaking at a press conference yesterday, ATCL head of communications Japhet Kagirwa said the trip will involve the company's Boeing 787 Dreamliner which has the capacity to carry 262

passengers. "This trip will take place on March 4, and will involve investors and businesspeople for a meeting which will take place in Mumbai," he

The delegation is expected to return on March 7 after the two days forum, he said, noting that costs for the trip like transport and accommodation are set at \$500 to \$700.

"If you choose to participate in the forum, \$500 will include go and return tickets while the \$700 will include tickets to and from plus accommodation."

and competitive law that takes into consideration the needs of investors," she said.

The changes are also meant to attract more investments into agriculture, livestock and fisheries that are seen as risky areas in the current environment, she stated.

The minister hinted at the possibility of commercial banks being compelled by law to issue loans to investors in agriculture, livestock and fisheries, an idea likely to garner support in a forum for agriculture, livestock and fisheries stakeholders.

Kariuki said current trends show that salaried employees can easily access loans than investors in agriculture and its subsectors, a trend which she said runs counter to the country's development needs.

Speaking at the event, the Permanent Secretary in the Ministry of Livestock Prof Elisante ole Gabriel said Tanzania boasts 32.5 million cattle, 20 million goats, 5.5 million sheep and 79.1 million chickens laying four billion eggs annually at present.

"As of 2018 we had 2.8 billion kilogrammes of fish in our water bodies yet we spent 56.04bn/- importing fish which has since gone down to 37m/-," he said, pointing out that this is equivalent to 99 per cent reduction.

Ease of doing business has been the major concern of the business community in Tanzania as well as foreign investors. In May last year, the government and the British business community in the country launched a dialogue aimed at identifying and ironing out bottlenecks.

The dialogue focused at the regulatory and policy environment, along with challenges faced by British businesses investing in Tanzania.

Policy Analysis Group (PAG) chairman Audax Rukonge said that AAPC is a high level policy dialogue convening key stakeholders among public agencies and the private sector.

They come to present their research findings, success stories, progress made, share best practices and chart a transformative way forward for future reforms, he said.

Philip Rooyakkers, CEO of PiP My Pet, said it took about a year of addressing challenges before the app could be rolled out, one of the biggest being a way for the app to backup data in the field, miles from internet capability.

Rooyakkers stands by his product and its accuracy.

"Really early on we discovered that if

we look at the current state of human body scars, torn ears, other identifying rates and strategies in both arms of facial recognition technology, you couldn't use it for animals," Rooyakkers said. "Human faces are oval, we know where the ears are, we know where the nose is, although someone may have glasses on, all that is relatively easy to overcome compared to dogs and cats whose faces vary so much in shape."

To address those limitations, the technology provides images of the five most closely recognized dogs in the database and allows the vaccinator to

narrow from there, he explained. "We filter those by male and female,

Rooyakkers said he chose to waive the app's licensing fee for the Allen School.

NIT to acquire two planes–Cessna 172

THE National Institute of Transport (NIT) will this October receive two planes-Cessna 172 to be used for training purposes as it prepares to start offering pilot courses locally. According to NIT Rector, Prof Zacharia Mganilwa the institute has so far completed preparations for conducive teaching environment such as classrooms and teachers.

"All is set for the institute to offer pilot courses, we are only waiting for the planes to arrive", he insisted.

Prof Mganilwa made the remarks in Dar es Salaam when briefing a delegation from NIT national leaders council who visited the institute yesterday.

"We are expecting to receive the new planes in between October and November this year. The two aircrafts-'Cessna 172' from the United States of America will have capacity to carry four passengers", said the Rector noting NIT has all the required equipment for training of aircraft engineers.

He added: "We will continue procuring other equipment for training of aircraft engineers with the support from World Bank. The institute has started offering cabin crew courses although it is grappling with teaching equipment".

Prof Mganilwa said the institute has ordered various teaching equipment worth 50bn/- to facilitate teaching of different aviation, railway and marine courses. He said thy have a good number of teachers for each of the courses.

According to him two batches of students taking flight attendant courses have graduated, adding the third batch will graduate later this year.

He however noted that two batches of aircraft engineers have graduated. He said students are attached to various mega state-owned construction projects for practical trainings

NIT national leaders council chairman, Prof Bavo Nyichomba said the institute aims at producing professionals who will participate in the country's industrialization drive as well as contribute to economic growth through construction

Community supports two girls who dropped out of school to complete basic education

Promote professionalism, legal practitioners urged

MINISTER for Justice and Constitutional Affairs Dr Augustine Mahiga has urged legal practitioners and court workers to promote civility, and professionalism when executing their duties.

Dr Mahiga made the call on Tuesday when speaking at the launch of guidelines on running disciplinary committees to court officials at district and regional levels.

He said that adhering to professionalism is important for maintaining respect of this important pillar that ensures that the laws of the land are implemented in letter and spirit and a sense of justice and fair play pervades in society.

He said according to article 107A (1) of the Tanzania Constitution, the judiciary is the 'authority with final decision in dispensation of justice in the United Republic of Tanzania'.

Judicial authority of the Republic vests in the courts, which are required not to delay dispensation of justice without reasonable grounds as well as dispensing justice without being tied up with technicalities which may obstruct the dispensation of justice. "That's why it is important for legal practitioners to continue working in those lines."

"I call upon some few employees who continue to carry out unprofessional practices that violate the ethics to stop it and maintain the good image of the court for their job security," he warned..

He noted that the government has prioritized especially when they go to court.

ethics in public service to enhance the public's confidence in their government.

Dr Mahiga said, the efforts have brought great impact where the values in public service have significantly improved and many people are satisfied with the services provided at various public institutions.

"In ensuring that the Tanzanian court provides quality service to the public, it has decided to maintain discipline and ethics for judicial officers at all levels including strengthening the ethics committees for judicial officers," he said.

He said the committees have a great role in managing, developing and maintaining the values of the judiciary in order to promote public confidence.

Tanzania has huge potential to grow pyrethrum

YRETHRUM was a genus east and Arusha to the north. of several old world plants which are cultivated as ornamentals for their showy flower heads. Pyrethrum continues to be used as a common name for plants formerly included in the genus pyrethrum. Pyrethrum is also the name of a natural insecticide made from the dried flower heads.

Pyrethrum has been used for centuries as an insecticide, and as a lice remedy in the Middle East. It is one of the most commonly used non-synthetic insecticides allowed in certified organic agriculture. Pyrethrum farming has proved to be a vital component in improving living standards of rural life as well as strengthening the national economy through foreign currency earnings.

The cash crop came in the country from Kenya in the 1930s, being cultivated in large estates in the highlands-Kilimanjaro, Arusha and Tanga regions. Stakeholders in Tanzania provide high-quality pyrethrum to the local and export destinations and also source the raw fresh pyrethrum from family growers in the country. Tanzania pyrethrum (pyrethrins) or Pareto in Swahili is a natural insecticide from several types of flowers in the chrysanthemum genus. Two of these include C. cinerariifolium and C. coccineum. Each produces white-colored flowers with yellow central buds. In dried form, the flowers produce the insecticide.

Pyrethrum came to Tanzania in the 1930s courtesy of settlers from the northern neighbour, Kenya. The crop was once a major export from the two East African countries in the years just before and after independence. The nations' respective sectors have diminished in glory since then. The biggest pyrethrum farmlands in Tanzania include Tanga to the north-

Tanzania pyrethrum is from the highlands in the south of the country. family growers own an average of 0.5 hectares of land which they cultivate with farmyard manure. They also keep their crop free of chemical sprays to reduce residual levels.

Tanzania pyrethrum is harvested at early dawn when the flowers are still fresh and untainted by the sun. Trained army of workers plucks each flower head by hand but often uses garden scissors to cut it at the stem.

Former Prime Minister Mizengo Pinda has praised the efforts made by the Pyrethrum Company of Tanzania (PCT) to revitalize the pyrethrum farming in southern regions which is key in addressing poverty and improving the economy in the country.

He called on Iringa regional leadership to invest in educative programmes, work on encouraging more farmers to embark on the pyrethrum farming thus lift the economy of the farmers and the region at large.

"Authorities this is your time now to promote pyrethrum farming, as it is one of the crops that can boost your region's revenue collection because you have a factory that adds value to this," he said.

For his part, PCT production manager Benedict Kafyulilo said the factory produces more than two thousand tonnes per year, and it is likely to increase production to at least four thousand tonnes that will enable the factory to operate consistently throughout the year.

The Pyrethrum Company of Tanzania is leading a multi-year expansion programme to revitalize pyrethrum growing in the southern highlands as well as the Arusha region. PCT is also investing in its extraction plant in Mafinga so as to be able to process the expanded harvest of pyrethrum flowers now growing across Tanzania.

World Radio Day: Why radio remains Africa's best media tool

forms of mass media. One would think that the ■invention of the internet and the proliferation of social media sites would undermine the essence and value of the radio broadcasting but that has not happened, at least not in Africa.

While the internet largely serves its part in mass communication, radio still champions the cause, especially at the local and communal level.

The radio broadcast in itself has modified over time to suit more purposes and contexts. From the terrestrial zone, other alternatives like cable radio, local wire television networks, satellite radio, and internet radio have emerged.

Guglielmo Marconi is recognised as the inventor of the radio. However, it is on record that several engineers before him had made contributions towards it. Marconi had the privilege of working on existing works of others. He harnessed them and gave a somewhat finishing touch on it to make it what today is identified as the radio.

Radio always has something for everyone- from local to international news, music of all genres, drama, entertainment, cultural and topical

In the international scene, there has been an upsurge in radio broadcasting, thanks to technological advancements. Radio is the transmission and reception of electromagnetic waves of radio frequency, especially those carrying sound messages. Cellular phones are linked by radio rather than wires. Telecommunications in Tanzania include radio, television, fixed and mobile telephones, and the Internet available in mainland Tanzania and the semiautonomous Zanzibar archipelago.

Radio remains the most used masscommunication medium in Africa. It has the widest geographical reach and

ADIO is one of the oldest the greatest audiences compared with the Internet, television and newspapers. The statistics from the Tanzania Communication Regulatory Authority (TCRA) show that from 86 licensed radio in 2012, the number almost doubled until 2017. Following a request from the Spanish Radio Academy on 20 September 2010, Spain proposed that the UNESCO executive board include an agenda item on the proclamation of a World Radio Day. UNESCO's executive board approved the agenda item in its provisional agenda for the proclamation of a 'World Radio Day' on 29 September 2011. UNESCO carried out a wide consultation in 2011 with diverse stakeholders, such as broadcasting associations.

The board recommended to the UNESCO 36th session of the General Conference that it proclaim a World Radio Day at its 36th session, and that this day be celebrated by UNESCO on 13 February, the anniversary of the day that the United Nations established the United Nations Radio in 1946. It also invited all United Nations member states, organizations of the United Nations system and other international regional organizations,

professional associations and broadcasting unions, as well as civil society, including non-governmental organizations and individuals, to duly celebrate World Radio Day, in the way that each considers most adequate. The board further requested that UNESCO's Director-General bring the resolution to the attention of the Secretary-General of the United Nations, so that World Radio Day could be endorsed by the General Assembly and celebrated by the whole system. The matter was subsequently treated by UNESCO's general conference, which adopted resolution. World Radio Day was thus unanimously proclaimed by all member states of UNESCO in November 2011.

To silence the guns, restore nature

'N the span of a human life, Mozambique's majestic Gorongosa National Park has flipped: from wildlife haven to killing ground to sacred ground of peacemaking and recovery. This past week, as African heads of state gathered in Addis Ababa to evaluate progress toward "silencing the guns" and creating an environment conducive to development, Gorongosa stands as both a warning sign and a symbol of

Battles waged in Gorongosa during Mozambique's 1977-1992 civil war left millions of people dead or wounded. It also ruined the ecosystem and killed 90 percent of elephants, buffalo, zebra, and wildebeest as soldiers poached them for money or slaughtered them for meat. At the war's end, just 15 buffalo and 100 hippo survived. Few lions remained.

But with peace came opportunities to rebuild communities for 100,000 local people and to restore the environment. By 2018, grasslands, shrublands and forests were recovering. Some 1.000 buffalo roamed the area and the hippo population had increased five-fold. When Cyclone Idai struck last year, healthy ecosystems absorbed tens of millions of gallons of water, saving nearby villages from floods. Meanwhile, through programs of the Gorongosa Restoration Project, families have improved their agriculture and health, and the education of their children. Today, ecotourism adds local jobs, as the area reclaims an essential balance between nature and human development.

As in Gorongosa, the protection of nature everywhere is central to sustainable development, to the mitigation of climate change, and to secure and peaceful societies. Yet nature is being lost is being lost at a frightening rate.

Habitat conversion, the unsustainable use of natural resources, urbanization, and climate change all undermine the foundations of the natural world. The earth has lost 60% of terrestrial wildlife and 90% of the big ocean fish. One million plant and animal species are threatened with extinction. We are clear cutting rainforests at a rate of four football fields per minute.

The impacts of land and ecosystem degradation on biodiversity, land productivity, and human well-being in Africa has affected over 485 million people and costs an estimated US\$9.3 billion annually.

That which has been destroyed in centuries, we must act to restore in



the next decade in order to avert even greater natural, climate and human catastrophes.

Roadmap to Action

There is a roadmap to action. The Campaign for Nature offers a sciencedriven, ambitious new deal for nature that calls on world leaders to protect at least 30 percent of the planet-its land and water-by 2030. This rallying cry of "30X30" fuels the Campaign, which is a partnership of the Wyss Campaign for Nature, National Geographic Society, and a growing coalition of more than 100 conservation and indigenous peoples' organizations around the world. The Campaign has also launched a High Ambition Coalition (HAC) for Nature and People composed of government leaders to drive highlevel action on 30X30.

The Campaign calls on world leaders help mobilize financial resources to properly manage protected areas, and to fully integrate and respect indigenous leadership and rights in the work of conservation. We know from experience that local communities have to own the protected areas as their own and benefit from their protection. Only in this way will conservation succeed and promote inclusive economic and social development.

The Campaign's main measures are crucial to Africa's peaceful development. Africa generates 62 percent of its GDP through industries that are highly or moderately dependent on nature, most especially agriculture. One of the major risks business faces from the loss of nature is increased conflict. The protection of nature is paramount.

Africa can and should take the lead in driving action toward 30X30. A crucial opportunity to do so will be at the meeting of the 15th Conference of the Parties to the Convention on Biological Diversity in Kunming, China, later this year. There, Convention targets will be updated to reflect the full extent of our planetary crisis.

Many African countries have already

committed to conserving their natural heritage as integral to sustainable development. The governments of both Rwanda and Uganda have resolved to protect 30 percent of their natural lands by 2030. Ethiopia has written environmental protection into its Constitution so that every political party that comes into power must act accordingly. Namibia has designated its entire coastline as a national park.

Gorongosa National Park has shown us that nature recovers if given a chance. And like streams across a watershed, the benefits flow from

By investing in national parks, natural reserves, sustainable tourism, and community-led conservation areas, and by partnering with indigenous and local people, by building a global consensus for 30X30, we can not only save biodiversity but also generate jobs and income, significantly mitigate climate change, and silence the guns.

Inequalities in human development in 21st century

NEOUALITIES. The evidence is everywhere. And although they may be hard to measure and summarize, there is a sense in many countries that many are approaching a precipice beyond which it will be difficult to recover.

Not all inequalities are harmful, but those that are perceived as being unfair tend to be. Under the shadow of sweeping technological change and the climate crisis, those inequalities hurt almost everyone.

They weaken social cohesion and people's trust in government, institutions, and each other. They are wasteful, preventing people from reaching their full potential at work and in civic life, hurting economies and societies. And when taken to the extreme, people can take to the streets.

The United Nations Development Programme's (UNDP) 2019 Human Development Report, opens a new window to understand and address inequalities in human development. "Beyond income, beyond averages, beyond today: Inequalities in human development in the 21st Century" asks what forms of inequality matter and what causes them.

It recognizes that pernicious inequalities are generally better thought of as a symptom of broader problems in a society and economy. It also asks what policies can tackle the underlying drivers-policies that can simultaneously help nations to grow their economies sustainably and equitably expand human development.

There is far too much in the report to cover in this short post so let me focus on two important points.


1. A NEW GENERATION OF INE-QUALITIES IS EMERGING, EVEN IF MANY 20TH CENTURY INEQUALI-TIES ARE DECLINING


It is common knowledge that some basic inequalities are slowly narrowing in many countries, even if much remains to be done. The indicators of basic achievements in the figure below all show narrowing inequalities between countries in different human development groups, though the gaps are still wide.


In life expectancy at birth (driven mainly by survival to age 5), in access to primary education, and in access to mobile phones, countries with lower human development are catching up with more developed countries.

In contrast, and much less well known, inequalities in more advanced areas are widening. Countries with higher human development have longer life expectancy at older ages, higher tertiary education enrollment and more access to broadband-and they are increasing their lead.

These new inequalities may be one reason behind an apparent increase in concern about inequality: These







are the inequalities that will shape people's ability to seize the opportunities of the 21st century and function in a knowledge economy, and to meet challenges, including the ability to cope with climate change.

2. INEOUALITIES IN HUMAN DE-VELOPMENT CAN ACCUMULATE THROUGH LIFE, FREQUENTLY HEIGHTENED BY POWER IMBAL-

Understanding inequality-even income inequality-means looking well beyond income. Different inequalities interact, while their size and impact shifts over a person's lifetime.

Inequalities start before birth, and the gaps can increase over a person's life if they are not counteracted, creating self-perpetuating engines of privilege and disadvantage. This can happen in many ways, and the report looks in detail at one set of linkages: the nexus between health, education,

and parental income. Parental incomes and circumstancSlow convergence in basic, rapid divergence in enhanced capabili-

es affect the health, education, and incomes of children. Health gradients-disparities in health across socioeconomic groups-can start before birth and may accumulate.

When that happens, inequalities compound and spiral: Children born to low-income families are more prone to poor health and lower education. Those with lower education are less likely to earn as much as others, while children in poorer health are more likely to miss school.

typically partner with someone having similar socioeconomic status, reinforcing the inequalities across generations. It is a cycle that is often difficult to break, not least because of the way inequalities in income and political power co-evolve.

When the wealthy shape policies that favor themselves and their children-as they often do-that drives further accumulation of income and opportunity at the top. Unsurprising, then, that mobility tends to be

lower in more unequal societies.

A NEW TAKE ON THE GREAT

The positive correlation between higher income inequality and lower intergenerational mobility in income is well known. This relation, known as the Great Gatsby Curve, also holds true using a measure of inequality in human development instead of income inequality alone (see Figure 2).

The greater the inequality in human development, the lower the intergenerational mobility in income-and vice versa. These two factors go hand in hand, but that does not imply that one causes the other.

In fact, it is more likely that both are driven by underlying economic and social factors, so understanding and tackling these drivers could both promote mobility and redress inequality.

WHERE TO NEXT?

The report has a template framing a rich set of policy suggestions for governments wishing to act, but stresses that there is no silver bullet. Tackling inequalities requires addressing the drivers, not just the symptoms. Two arguments are central to this.

The first is that inequalities do not always damage a society, nor do they always reflect an unfair world. Some inequality is productive in rewarding talent and effort, and some is probably inevitable, such as the inequalities from diffusing a new technology.

Preventing anyone from access to a new health treatment until everyone can have it makes no sense. But some inequalities-especially in opportunities-are unjust and damaging. They have deep roots, and we focus on these inequalities and their drivers.

The second argument is that the sorts of inequalities that concern us most are not so much a cause of unfairness as a consequence of an unfairness deeply embedded in our economies, societies, and politics. That sense of unfairness can lead to alienation and become a wellspring of anger.

The human development lens-placing people at the heart-is central to approaching inequalities and asking why they matter, how they manifest themselves and how best to tackle them. This is a conversation that every society must have for itself, and that should begin today. The 2019 Human And when children grow up, they Development Report is a contribution to inform and to help shape those conversations.

Note: Inequality in human development is measured as the percentage loss in Human Development Index value due to inequality in three components: income, education, and health. The higher the intergenerational income elasticity, the stronger the association between parents' income and their children's income, reflecting lower intergenerational mobility.

If you could represent that to your organization, or future employers, wouldn't that be more valuable than saying you have an accounting degree from 5 years ago? Wouldn't you want that Hr manager to understand what you have learned since then? That's meaningful and something that I wish human resource managers would want to hear from us more when carrying through the inter-

view process.



Could Africa's marketplace platforms help upskill generation for digital age?

NAIROBI

2030, sub-Saharan Africa will be home to more than a guarter of the world's population under 25. Between 15 and 20 million young people will enter the African workforce each year, joining the ranks of the millions of currently under- and unemployed people searching for better livelihoods.

Does this massive growth present an urgent challenge or an extraordinary opportunity? It depends in part on whether young people can acquire the skills they will need to participate in an increasingly digital economy.

One pathway to learning these skills has, until now, gone mostly under the radar, but it may be a surprisingly powerful ally in meeting this challenge.

Some of the same digital marketplace platforms that are changing economic sectors and connecting workers to gigs are now putting training at the core of their operations. This upskilling has become essential to providing the levels of service and quality customers demand.

There are currently more than 250 marketplace platforms active in sub-Saharan Africa alone. They touch many economic sectors: ride hailing and delivery, freelancing, services and trades, even agriculture, the biggest employer on the continent.

When these platforms train, they train broadly. While coding or IT skills are an important component, many platforms train in a variety of subject matters, using a variety of methods.

Some platforms offer training in digital and financial literacy; Uber has partnered with Old Mutual to deliver money management classes to driverpartners. Some platforms teach specific vocational skills, like the Kenyan service platform Lynk, which prepares people to be everything from carpenters to beauty technicians.

Other platforms teach soft skills, like Nigerian ride-hailing platforms Gokada and MAX, which invest extensively



in customer service training while onboarding drivers.

Importantly, all of these skills are portable. They can be applied on and off the job, and, once transferred, they can't be taken away. If the scale and quality of platform-led upskilling continues to rise, it could have a transformational impact on economic growth and sustainable development in the

With the support of the Mastercard Foundation, Caribou Digital has produced a white paper analyzing the potential of training programs offered by platforms.

We found three broad approaches in practice. The first is of course to provide online training materials,

ranging from simple "FAQs" and ing, allowing small merchants to blog posts to videos and tutorials.

Notably, we found many using innovative approaches, like Sendy, an African delivery and logistics platform that has designed videos for drivers to watch at mechanic workshops or gas stations while their bikes are being maintained.

Some of the larger platforms offer training moments within workflows-training that happens almost without the user's awareness. For example, the African e-commerce site Jumia uses AI to offer sellers a "Content Score" that automatically measures the products. quality of a product's content list-

improve their advertisements in real time.

However, we were most surprised by the amount of coaching that happens face to face. For example, the Kenyan services platform Lynk has set up Fundi Works, a production workshop that allows carpenters to train with a master carpenter to improve their techniques.

They are also trained on procurement of raw materials, storage practices, and the processes involved in furniture design, to ensure high quality finished

Meanwhile the Nigerian ride- to training correlates with their

hailing platform Gokada has partnered with a defensive driving academy that has reduced training time in the classroom and the field from seven days to three. Almost every platform we spoke to, large and small, relies on some degree of interpersonal

training to upskill its workers and

suppliers.

The influence of platforms on all kinds of markets is likely to grow. Not all of this influence is good–platformization has raised important concerns about competition, worker safety, wages, and consumer choice.

But if platforms' commitment

growth, their influence on skills acquisition around the world could have a major positive impact. Our research shows that marketplace platforms can be powerful new partners for governments, educational institutions, and worker organizations looking to upskill the continent's workforce.

It is therefore time to foster collaboration around what we have dubbed "platform-led upskilling". With a dedicated community and shared perspective comes the opportunity to compile best practices across industry sectors and training approaches as well as to analyze returns on investment to platforms, and the efficacy of skills training and improved livelihoods among their workers and suppli-

A lot of this evidence is currently hidden and fragmented, held inside different platforms' vendor support departments. The development community can act as a catalyst and partner with platforms to more systematically gather and share this evidence.

Preparing a generation of young Africans with the skills for the digital age will require all handson deck. Platforms won't replace investments in improving and extending schools, NGOs, and training academies, or in advancing employee training.

But the reach of platform-led upskilling is growing along with the rise of platforms.

The question "Could Africa's marketplace platforms help upskill a generation?" is still open, but the answer is worth pursuing systematically and vigorously. Platform-led upskilling is a promising way in which platforms can act not just as disruptors but as stewards of the markets in which they play.

War no more: Honouring UN 75th anniversary

NEW YORK

5 years ago following the end of the Second World War and the first time any state has dropped an atomic bomb, not once, but twice, on Hiroshima and Nagasaki, 51 countries from all continents met to create the United Nations. Its primary purpose, as stated in the

Charter says: "We the peoples of the United Nations determined to save succeeding generations from the scourge of war..." Of course, it is also dedicated to human rights for all and equal rights for men and women and nations large and small and more...

But peace, prevention of war, is its "most profound purpose," Ambassador William vanden Heuvel said when he suggested we organize this conference on "War No More".

It is to this purpose, to save humanity from war, that the Committee on Teaching About the UN with the co-sponsorship of the Permanent Mission of the Republic of Korea to the UN, has dedicated its conference which will convene on February 28, 2020. https://teachun.org/

conference/2020-un/. We honor the UN on its 75th anniversary and call for the full implementation of this purpose.

It is often said that as long as there are people there will be war. But it hasn't always been that way and certainly war is not inevitable.

Indeed, not only has the UN called for saving succeeding generations, but the Charter also calls for "...the least diversion for armaments of the world's human and economic resources..." (Art 26); the First Committee is dedicated to Disarmament.

It goes on, "... (Art 2.3) All Members shall settle their international disputes by peaceful means..." and (2.4) states, "All Members shall refrain from the threat or use of force..."

Some say that as long as there is a right of self-defense (Art 51) there shall be war. We will see what the lawyers and experts including Liechtenstein's Ambassador Christian Wenaweser and James Ranney, international law professor, say in their conversation.

Have you heard of Bertha von Suttner, the young poor Princess who answered



an ad from Alfred Nobel for a housekeeper. In short, she left his employ having persuaded him to turn the profits from his invention of dynamite to sup-

port a Nobel Peace Prize. In 1905 Bertha became a Nobel Peace Laureate for writing the best-selling, "Lay Down Your Arms", (Die Waffen Neider) probably the only novel written about disarmament, and for organizing the world's first International Peace

Congress. It resulted in banning hot air balloons,

MWANZA Regional Commissioner John Mongella has appealed to residents of Maisome and Kaunda islands in Lake Victoria to exercise patience over the challenge they are facing following the collapse of the berth used by MV Tegemeo ferry due to ongoing rains and assured them that the government is working on the matter.

Mongella gave the assurance at the weekend during his inspection visit on the destruction to various infrastructures, roads and bridges following heavy rains in Sengerema and Buchosa districts in the region.

He said Tanzania Mechanical and Electronics Services Agency (TEME-SA) have brought in engineers to assess the situation and decide what can be done as an urgent measure to help passengers use the ferry.

He also called upon TEMESA to ensure they work day and night to deal with the challenge, adding that the government will be laughed at if it embarks on a shortcut solution to deal with the challenge.

He also appealed to TEMESA to con-

struct a shelter to be used as waiting room for passengers as well as toilets saying these should be ready by June

In addition, he said TEMESA should prepare a timetable for the ferry that should be well understood as well a schedule for the cost of passenger fares and luggage.

The Sengerema District Commissioner Dr Emmanuel Kipole said the ferry has been serving two regions -Geita and Mwanza but due to berth's collapse the timetable has been altered.

He said the ferry will end its daily services at 6.30 pm when there is still light so that the wananchi should not be attacked by wild beasts such as crocodiles and hippos.

Residents of the area, Samsoni Nyanda and Marco Lufungulo said the berth's collapse after being submerged in water has instilled fear in wananchi's lives when travelling and appealed to the government to work on the berth as quickly as possible.

COVID-19: New coronavirus disease named by WHO

THE new coronavirus disease has been named COVID-19, the World Health Organization announced Tues-

This strain of coronavirus was first detected in December in the Chinese city of Wuhan.

The illness caused by the virus, which has since infected thousands in China and several other countries, had been nameless since the outbreak began. It was commonly referred to as 2019-nCoV by health officials.

The UN health agency explained that the name COVID-19 consists of the CO in coronavirus, VI in virus and D for disease; 19 stands for the year 2019.

WHO chief Tedros Adhanom Ghebreyesus said the name was carefully chosen to avoid stigma and that other names could be inaccurate.

"We had to find a name that did not refer to a geographical location, an animal or an individual or group of peo-

ple," he said. "Having a name matters to prevent the use of other names that can be ina standard format to use for any future coronavirus outbreaks."

Tedros said there are currently more than 42,000 confirmed cases of COV-ID-19 in China. A total of 1,017 people have died in the outbreak. Outside of China, there are 393 cases reported in 24 countries.

During a press conference, Tedros urged countries to be "as aggressive as possible" in fighting the outbreak.

"If the world doesn't want to wake up and consider the virus as public enemy number 1, I don't think we will learn from our lessons," Tedros said.

"We are still in containment strategy and should not allow the virus to have a space to have local transmission."

The virus that causes COVID-19 was also renamed Tuesday. The International Committee on Taxonomy of Viruses, which classifies and names viruses, stated that the virus was now to be called SARS-CoV-2, which stands for "severe acute respiratory syndrome coronavirus 2."

It made this decision based on its assessment that this new virus was a "sister" to other SARS viruses.

Jinping, general secretary of the Communist Party of China Central Committee, stressed resolutely winning the people's war against pneumonia epidemic caused by the novel corona-

He first went to the Anhuali Community in Chaoyang District to learn about the epidemic prevention and control at the primary level and stressed the role of community in effectively containing the spread of the

At Beijing Ditan Hospital, a designated institution treating the novel coronavirus pneumonia, Xi checked the treatment of hospitalized patients at the monitoring center and talked to medical staff on duty via a video link.

Xi called on medical staff to continue to improve the diagnosis and treatment plan, save patients at all costs and reminded them to take good selfprotection.

"Wuhan is a heroic city, and people of Hubei and Wuhan are heroic people who have never been crushed by any difficulty and danger in history," Xi said, speaking to officials fighting the epidemic in Hubei in a video-

Noting that Hubei and Wuhan are the top priority for epidemic prevention and control, Xi called for greater efforts in hospital ad-

mission, treatment, social management, public communication and unified commanding in the epidemic prevention and control work. He also urged more caring for the frontline medical personnel.

ECONOMIC IMPACT SHORT-

Leaving the hospital, Xi went to the center for disease control and prevention of Chaoyang District. Xi presided over a meeting and listened to report on the epidemic prevention and control work of Beijing.

Xi highlighted the urgency of putting in place targeted measures to address the rising risk of epidemic spread following the post-festival travel peak, called for efforts to work out more effective treatment plans to reduce the rates of infection and mortality and demanded resolute punishments on illegal activities such as price gouging.

Xi stressed that the fundamentals of China's long-term economic development remain unchanged and the impact of the novel coronavirus epidemic on the economy is short-lived.

He called for greater efforts to minimize the impact of the epidemic on the economy and reach goals and tasks of economic and social development this year. Close attention must be paid to employment and large-scale layoffs should be avoided, he added.

XI THE COMMANDER

Xi is the commander of the people's war against the epidemic.

Over the past few weeks, he has called multiple meetings, heard reports, made important instructions on the prevention and control work and discussed the topic with foreign leaders.

One message is consistent and crystal clear: People always come first. Xi has stressed putting people's lives and health as the top priority.

On Jan. 25, Xi chaired a meeting of the Standing Committee of the Political Bureau of the CPC Central Committee and demanded that epidemic prevention and control be taken as the most important task.

In the last week of January. Xi entrusted senior officials to inspect epidemic control work in Wuhan, made instructions to Party organizations, members and officials as well as the military and met with the World Health Organization (WHO) Director-General Tedros Adhanom Ghebreyesus.

In early February, Xi again chaired a meeting of the Standing Committee of the Political Bureau of the CPC Central Committee on epidemic prevention and control and later a high-level meeting on overall law-based governance, requiring strong legal guarantee to epidemic con-

Under Xi's leadership, China has carried out national mobilization, across-the-board deployment and swift responses, adopted the most comprehensive and rigorous prevention and control measures and launched a people's war against the epidemic.

Though the battle remains arduous, especially in Hubei, the number of daily new confirmed cases outside the province has been dropping for six consecutive days since Feb. 4.

In the past week, Xi also discussed epidemic control when he met with Cambodian Prime Minister Samdech Techo Hun Sen in Beijing and spoke over the phone with Saudi King Salman bin Abdulaziz Al Saud and U.S. President Donald Trump respectively.

Xi told King Salman that the strong measures China has taken are not only responsible for the health of the Chinese people, but have also made huge contributions to the world's public safety.

According to statistics of the WHO, the outbreak has affected about two dozens countries but all with limited cases.

"We would have seen many more cases outside China...if it were not for the (Chinese) government's efforts and the progress they have made to protect their own people and the people of the world," Tedros, the WHO chief, said. Xinhua

Where do Sahel terrorists get their heavy weapons?

ERROR attacks on military outposts in the Liptako-Gourma area where Mali, Burkina Faso and Niger meet are increasingly ambitious and complex. Their frequency and the damage inflicted on defence and security forces is worrying, and raises questions about where the terror groups are sourcing their heavy weapons.


New research by the Institute for Security Studies (ISS) on the links between violent extremism, organised crime and local conflicts in Liptako-Gourma reveals that terrorist groups in the Sahel region - of which Liptako-Gourma forms part - are using weapons from the military barracks they're looting.

Since the outbreak of the crisis in Mali in 2012, the origin of the many weapons circulating in the area has generated speculation. Libya was at one point the main source of arms. Weapons proliferation was linked to the fall of the Muammar Gaddafi regime in 2011. Following the North Atlantic Treaty Organization (NATO)-led military intervention, Libya lost control of a large part of the stockpiles it had amassed over 40 years.

The transfer of weapons from Libya strengthened armed rebel movements in Mali in 2012. It facilitated the acquisition of arms by terror groups such as

operating in the Sahel region. Since 2013 however, the flow of weapons from Libya is said to have decreased for various reasons. First, the growing military presence in Mali, as well as the deployment of military reinforcements on the Nigerien and Algerian borders, have led to the interception of arms shipments destined for terrorist and other armed groups.

Second, the intensification of the Libyan civil war has increased the internal demand for arms, which means there are less weapons to export. Nevertheless, arms trafficking networks continue to exploit this channel to obtain other supplies.

But these smuggling networks are just one of the supply channels for non-state armed groups. Another comes from weapons diverted from poorly controlled national stockpiles, as well as arms trafficking from the various crises that have shaken West Africa - in Libealso allegedly used for the transport of arms.

More recent attacks on isolated military barracks - during which equipment was stolen - shows that violent extremists are getting their weapons from looted military barracks. Terror groups in the Sahel now launch large-scale attacks on military garrisons or positions, exploiting their vulnerabilities. Using the element of surprise, attackers arrive in large numbers, on motorcycles or in pick-up trucks. They surround the camp and pound it with mortar shells or rockets to disrupt its defences.

Vehicle-borne improvised explosive devices are used to clear the way for the assault on multiple fronts. Soldiers are overwhelmed and the attackers gain control of the outposts and seize weapons, ammunition and other materials.

This modus operandi, which has enabled terrorist groups to accumulate large stockpiles of ammunition and weapons, is becoming the main source of supply, offsetting the decline in flows from Libya and other former conflict zones.

Securing armouries and weapons stocks has become a real challenge for defence and security forces of states in the Liptako-Gourma region. Rigorous stockpile management in barracks is needed to control the exit of weapons and ammunition, and improve their traceability. To prevent the theft of weapons, stricter measures are needed to ensure soldiers take responsibility for the weapons they

The governments concerned also need to strengthen their operational capabilities and boost soldiers' morale in the face of violent attacks and equipment theft. Curbing weapons proliferation is a priority and there's no better time than now for countries in the Sahel to get behind the African Union's 2020 focus on Silencing the

attract investment from both foreign and local investors, insurance remains laggard which has prompted the government to provide an effective policy and regulatory framework for the industry to grow and support development.

SOME 34 small agro-processing industries have received over 1.34bn/- in loans between July 2015 and September 2019 through a Small Industries Development Organization and CRDB Bank Plc partnership.

Sido's small and medium size enterprises Credit Guarantee Scheme's Program Officer, Ismail Tego said the agro-processors received between 10m/and 50m/- loan packages.

CBK rolls out mobile bonds platform with eye on mass market

NAIROBI

THE Central Bank of Kenya (CBK) has rolled out a mobile platform through which retail investors will be able to apply for and trade Treasury

The government's fiscal agent says the new service will make it easier to process transactions of Sh140,000 and below. The move could potentially take investing in Treasuries to the mass market by eliminating the friction in the current market infrastructure.

"The Bank is pleased to inform you about the roll-out of the Treasury Mobile Direct (TMD) services, designed to facilitate investment in Government Securities using the mobile telephone," CBK said in a notice to inves-"To access these services, investors will be required to register for this

facility at the nearest Central Bank of Kenya (CBK) Branch or Currency Centre." Retail investors have been applying for the debt instruments on physical forms that are delivered to CBK branches and currency centres.

They have had to contact the CBK to confirm if their applications were successful and the amounts they are to pay. Alternatively, the investors have hired banks to apply for the securities on their behalf. The lenders charge a commission of 0.15 percent of the actual amount invested in a bond or T-bill.

The small investors have also relied on CBK's website and newspaper advertisements for announcements of new T-bill and bond auctions. The mobile service will now aggregate all these services and others including request of statements and receipt of the cash value of maturing securities.

"For transactions whose amount exceeds Sh140,000 or other prevailing transaction limit, CBK will at its sole discretion determine the best alternative means of disbursing or receiving the funds," the lender of last

The mobile service is expected to avail to retail investors the same level of convenience that big buyers of treasuries such as banks have been enjoying. For more than a year now, banks have been placing their bids for treasuries through an online platform.

Retail investors and other nonbank participants had bought a cumulative Sh125 billion worth of treasuries as of January 31, 2020, representing 4.27 percent of the total domestic sovereign debt. CBK's Treasury Mobile Direct platform builds on the M-Akiba service which has raised nearly Sh800 million from more than half-a-million investors.

Absa's new boss faces tough fight to win back business

JOHANNESBURG

The Reserve Bank's former secondin-command, Daniel Mminele, will have his work cut out for him when he takes office as the new CEO of Absa on January 15. Absa is currently fighting to reclaim market share it lost to rivals over the years because of its conservative approach to lending under Barclays' rule.

Statistics from Genesis Financial News & Data show that Absa's market share in mortgage advances had shrunk to 21% in October 2019 from highs of around 31% a decade earlier in 2009. Barclays took a controlling stake in Absa in 2005, but in 2017 reduced its majority stake from 62% to 15%.

Through the new strategy which Absa adopted after the "divorce" with its parent company, Barclays, the bank wants to restore its leadership in SA retail banking. In 2018, the bank's retail unit launched a strategy to increase loans, which had stagnated over the past two years, as well as deposits.

Bloomberg reported that retail and business banking were the first of Absa's divisions to undergo a management restructuring in June 2018. Analysts believe Mminele won't bring drastic changes but continue with the strategy already in motion.

Gryphon Asset Management's Casparus Treurnicht believes Mminele will, in fact, be well placed to help the bank reconstruct its retail and

business division. "He has no emotional relationships with existing structures and policies. rid of forces working against

the strategy." In Treurnicht's view, the fact that Mminele's experience lies primarily Resetting (the retail unit) could outside of large corporate be strengthened by getting entities makes "more radical changes less likely."

According to Treurnicht, in addition to dealing with a shrinking mortgage book, the bank is also addressing market share loss which they have suffered in the last decade.

"I am sceptical whether they will succeed. The times we live in will make it hard for the retail segment to recoup clients while Capitec, Tymebank and Discovery are fueling headwinds," said Treurnicht.

Harry Botha, banking analyst at Avior Capital Markets, said Mminele would probably take the next few months to acquaint himself with the business. After all, Absa is a big bank with operations in different jurisdictions, and is also in the middle of executing a new strategy - one in which divisional executives have more power to make their own decisions.

Thereafter, his measure of success will be how he steers Absa through its "Africanacity" strategy, which the bank adopted in 2018. "His stepping into the role doesn't disrupt things dramatically now...The key thing is that when the board hired Mminele, it made sure that he was comfortable with the strategy that's in place so that there wouldn't be too much disruption," said Botha.

Mminele's impact remains to be seen. "He comes with regulatory and commercial banking experience but lacks retail banking experience which is the division that requires the most turnaround. He is, however, a safe option," said Mergence Investment analyst Managers Mthombeni.

DBS evacuates 300 Singapore staff after **Coronavirus case**

SINGAPORE

DBS Group Holdings Ltd. has evacuated 300 employees from an office floor in the heart of Singapore's financial district after one of its workers tested positive for the coronavirus.

Southeast Asia's biggest bank has told the staff members on Level 43 at Marina Bay Financial Centre Tower 3 to work from home for the time being, the company said in a statement. The number of evacuees was given in a memo seen by Bloomberg earlier and confirmed by the bank.

"During this difficult time, the bank will be providing this employee and his family with every support and guidance," it said. "We are also currently conducting detailed contact tracing with all employees and other parties that the infected employee may have come into contact with." DBS is deep-cleaning and disinfecting the affected office space.

The coronavirus had already been detected in Singapore's financial district earlier this week, prompting some companies to send workers home and temperature screening checkpoints to be set up at the entrances of several towers. Singapore has 47 confirmed cases of the disease, according to health ministry figures as of Tuesday. Only Hong Kong has a larger number outside mainland China, excluding an outbreak on a cruise ship quarantined in Yokohama.

The virus that originated in China has now claimed 1,115 lives, all but two on the mainland. Singapore last week raised its disease response level to "orange," the same grade used during the SARS epidemic, as it braced for what Prime Minister Lee Hsien Loong said was a "major test for our nation."

Care packs

Since the alert, DBS has been doing temperature screening and stepped up cleaning of its premises. Next week it will issue staff with care packs including masks, a thermometer, hand sanitiser and vitamin C, it said in the statement.

"The health and well-being of our staff are a top priority for us, and we will lend them every support to get through these uncertain times," DBS said. The infection comes a day before the bank is scheduled to report fourth-quarter earnings. DBS economists last week cut their forecast for Singapore's gross domestic product by 0.5 percentage point, citing the expected impact of the outbreak on tourism.

DBS has a 30% stake in MBFC Tower 3, which serves as its headquarters. The 46-story property is home to more than 4,800 employees, according to a filing in December 2012. Other tenants include Rio Tinto Group and law firms Clifford Chance and WongPartnership, according to the property's website.

A worker at an unnamed firm in nearby MBFC Tower 1 was confirmed as being infected with the coronavirus over the weekend, and another case was detected at Clifford Centre. That person is an employee of United Industrial Corp., according to an advisory to tenants in the building where UIC is located.

Trade sector leads in non-performing loans

KIGALI

Trade sector is leading among industries with the highest Non-Performing Loans (NPLs) ratio, the Central Bank says.

Following last week's Financial Stability Committee sitting, the Central Bank noted that NPL's had generally declined from 6.4 per cent in December 2018 to 4.9 per cent in December 2019.

The Central Bank benchmark of 5 per cent is 5 per cent. The ban observed that the economic performance in 2019 was a key driver in the reduction of NPLs and enabled borrowers improve their debt service capacity.

Valence Kimenyi, the Director of Financial Stability and Monitoring at the Central Bank said that trade was the sector with highest NPLs adding that it could be a consequence of external trade fluctuations currently being experienced globally.

The banking sector's profits went up in 2019 Rwf 76bn from Rwf 57B in 2018 and Rwf 29bn in 2017. Profits in the Micro-finance sector increased from Rwf 7.3bn in 2018 to Rwf 12 in 2019. New authorized loans in 2019 increased by 20.1 per cent from 17.2 per cent in the previous year.

The central Bank expressed concern over the state of affairs saying that reliance and underwriting losses in the motor vehicle and medical insurance products are a major risk to the development of the sector.

US Fed says coronavirus spread to have spillover effects on global economy

Spillover effects from the novel coronavirus present a new risk to the global economy, the US Federal Reserve said in its latest monetary policy report.

The Fed said in a bi-annual report to the Congress that the global economy and the US could be further affected due to the Chinese economy's size. "Downside risks to the US outlook seem to have receded in the latter part of the year, as the conflicts over trade policy diminished somewhat. economic growth abroad showed signs of stabilising, and financial conditions eased," the bank said.

"More recently, possible spillovers from the effects of the coronavirus in China have presented a new risk to the outlook," the report said. The rapid spread of the virus, which has so far claimed 722 lives and infected around 35,000 people, brought China - the world's second-largest economy - to a virtual standstill as Beijing rushed to contain the epidemic by enforcing a lockdown on domestic travel.

As a result, the country's economy is expected to continue to slide, like in 2019 - which was primarily a consequence of its trade war with the US. China, which accounted for 20 per cent of global manufacturing output in 2018, is expected to see its annual gross domestic product slide to 5 per cent from 5.7 per cent due to the economic fallout from the virus, S&P Global Ratings predicts. In a bid to boost its economy, China's government injected 1.2tn yuan into financial markets last week, in addition to lowering interest rates on reverse repurchase agreements by 10 basis points.

Beijing also halved tariffs on \$75bn worth of US goods as a result of a phase one trade deal with the US last month. Goods earlier taxed at 10 per cent will be levied a 5 per cent fee, while those having a tariff of 5 per cent will now have a 2.5 per cent duty from February 14 onwards. The US is also expected to reciprocate, rolling back some of its tariffs on Chinese goods.

The Fed also noted that the spillover from the coronavirus further weakened the outlook of Asian economies which have been hit by political unrest in Hong Kong, slow growth in India and trade tensions with the US. While it was "premature" to speculate about the economic impact of the epidemic, China's economy will most certainly be affected in the first quarter, the International Monetary Fund's chief Kristalina Georgieva said last month.

"It would be irresponsible to offer any speculations around what may happen. What I can do is refer to a similar case of Severe Acute Respiratory Syndrome, [or] the SARS epidemics. What happened then was indeed a slow-down in the short term and then rebalancing of economic growth," she said. Former IMF chief Christine Lagarde, who currently heads the European Central Bank, also cited the virus threat as a new risk to the economic outlook, replacing the US-China trade war. "While the threat of a trade war between the US and China appears to have receded, the coronavirus adds a new layer of uncertainty," Ms Lagarde said on Thursday.

Vaccine for coronavirus could be ready in 18 months, says WHO

GENEVA

The World Health Organization (WHO) on Tuesday announced a new name of the deadly novel coronavirus disease and said the vaccines to the novel coronavirus could be available in 18 months.

The novel coronavirus disease now has an official name COVID-19, which stands for the coronavirus disease originated in 2019, WHO Director-General Tedros Adhanom Ghebreyesus said at a press briefing in Geneva on Tuesday.

Under the guidelines of the WHO, the World Organization for Animal Health, and Food and Agriculture Organization, the name for the disease has to avoid reference to a geographic location, an animal, an individual, or group of people, Tedros said.

"Having a name matters to prevent the use of other names that can be inaccurate or stigmatizing; it also gives us a standard format to use for any future coronavirus outbreaks," he added.

Despite the ongoing global research effort, the WHO chief estimated that it

could take 18 months for the first COV-ID-19 vaccines to be ready.

For the moment, he recommends basic precaution measures for the public such as washing hands regularly either with alcohol-based drop or soap, keeping distance from people who are coughing or sneezing, and covering the mouth and nose with tissue or the elbow when coughing or sneezing.

While reiterating that now is a window opportunity to fight the disease as most of the cases have so far remained in China, Tedros also expressed his concerns for the virus to spread to the countries with weaker public health system, which he said "will create hav-

He said that as time passes, his confidence in stopping the outbreak will depend on the strength of measures taken, hence asking all countries to be "as aggressive as possible" and not to allow the virus "have a space" for regional transmission.

At Tuesday's briefing, the WHO also announced that it will initiate a UN Crisis Management Team against the vi-

rus, while bringing in other UN agencies.

To fast-track the global research on the disease, a two-day WHO-coordinated research and innovation forum was held in Geneva on Tuesday to gather about 400 scientists and researchers as well as some 25 funders from around world to discuss a priority research agenda for the COVID-19 outbreak.

The event, organized in collaboration with the Global Research Collaboration for Infectious Disease Preparedness, focuses on pursuing critical research and the development of vaccines. therapeutics and diagnostics, among other inno-

The participants, either attending in person or online, are expected to shape a roadmap to prioritize the areas and questions of research that need to be addressed in urgency.

According to Soumya Swaminathan, WHO chief

scientist, it is very fortunate to have doctors from the Chinese Center for Disease Control and Prevention at the forum online to present the data of research already initiated in China.

"Measures in China (are) incredible, unprecedented, from which we can learn a lot of how this kind of outbreak is handled," she said, adding that as more data comes in a few months, "we will be able to learn a lot of lessons about the quarantine and travel restriction, and how effective those

She also appreciated China's sharing of the genetic sequence of the virus, which helped other countries to quickly detect and prepare for the

"Early data sharing really helps save lives," she said, commending and congratulating China for being that open and transparent.

Egypt proposes joint force to fight terrorism on African continent

CAIRO

EGYPTIAN President Abdel-Fattah al-Sisi has said Egypt is ready to host a special African summit to discuss setting up an African force to fight terrorism on the continent.

The Egyptian president made the remarks during a televised speech on Sunday during the opening ceremony of the 33rd African Union (AU) Summit in Addis

Sanders narrowly wins in New Hampshire Democratic primary

BERNIE Sanders narrowly won New Hampshire's Democraticpresidential primary on Tuesday, solidifying his front-runner status in the White House race and dealing a setback to moderate rival Joe Biden, who finished a disappointing fifth.

Pete Buttigieg, the former mayor of South Bend, Indiana, who narrowly edged out Sanders in last week's messy Iowa caucuses, came in a close second, after splitting much of the centrist vote with Senator Amy Klobu-

Sanders, a progressive senator from neighboring Vermont, prevailed after fending off attacks from rivals who

warned his left-wing views would lead the party to defeat in the Nov 3 election against Republican President Donald Trump.

"This victory here is the beginning of the end for Donald Trump," Sanders told supporters in Manchester, New Hampshire.

In a sign of the growing rivalry between Sanders, the 78-year-old selfprofessed democratic socialist, and Buttigieg, a 38-year-old moderate, Sanders' supporters booed and chanted "Wall Street Pete!" when Buttigieg's post-primary speech was shown on

It was also a good night for Klobuchar, who rode a wave of momentum

third-place finish. But Senator Elizabeth Warren, who was considered a favorite in New Hampshire until a few months ago, finished fourth, which cast further doubt over her continued viability as the progressive alternative to Sanders.

The results provided no clear answers for Democrats trying to decide whether their best choice to challenge Trump would be a moderate like Buttigieg, Klobuchar or Biden, or a progressive like Sanders and Warren, who represents neighboring Massachusetts.

Turnout in New Hampshire approached the record 287,000 who cast ballots in the 2008 Democratic prifrom a strong debate on Friday into a mary, when the battle between Barack



Obama and Hillary Clinton energized the party. That could ease Democratic concerns about the smaller-than-expected turnout in Iowa.

Biden, the former vice president who was once the front-runner in the Democratic race, limped to his second consecutive poor finish after placing fourth in Iowa. He is certain to face growing questions about his campaign's staying power and his ability to consolidate moderate support against a surging Buttigieg and Klobuchar.

He also faces competition from Michael Bloomberg, the billionaire former New York mayor who is skipping the four early voting states in February and pouring resources into much larger, delegate-rich states such as California that will vote on March 3, known as Super Tuesday.

Nations should join forces in fight against virus, says Rand adviser

WASHINGTON

SENIOR policy researcher and Tang Chair in China Policy Studies at the RAND Corporation, Dr. Jennifer Bouey, said during an interview with People's Daily that the coronavirus outbreak was a "battle between humans and viruses, not between people, not between countries."

The fight against coronavirus pandemics highlight the importance of prioritizing global health research and increase openness and cooperation among scientists worldwide.

As an epidemiologist focused on global health and health strategies, Bouey has taught at Georgetown University and participated in studies on global health security issues in the US and China.

Since the SARS outbreak, China's response capabilities during a pandemic and its health management system have improved significantly. The country has invested in a nationwide network consisting of disease control centers at every level, Bouey noted.

The centers are connected by a real-time, web-based system for emerging public health events.

"The coronavirus is the most serious test for China's strengthened epidemic surveillance and response systems since new measures were implemented after the SARS outbreak," Bouey said.

Following the outbreak of the novel coronavirus, China and WHO officials began communicating with each other to share the disease's genetic sequence in efforts to prevent and control the epidemic.

Bouey said that because Chinese rus they could conduct genomic sequencing experiments an share their findings with the world in such a short period. Their efforts helped identify the virus and enabled China and other countries to develop earlv detection testing kits.

"This was a very important step in controlling the outbreak, the Chinese scientists in this regard are doing very well," Bouey said.

The World Health Organization



(WHO) classified the outbreak as a public health emergency of international concern (PHEIC) while stressing that travel and trade restrictions would be unnecessary. Since then, a few countries have implemented so-called "travel bans," barring Chinese from entering their countries.

Bouev said travel bans are an overreaction based on multiple factors, would have huge social and economic impacts, and would not be an effective response to the out-

"A travel ban does not protect a country from the virus. It gives the illusion that it can be contained in China, which it isn't," she explained.

As for the growing discrimination against Chinese due to coronavirus in other countries and regions, Bouey said this phenomenon should be condemned. As Bouey explained, epidemic disease outbreaks are often accompanied by rumors and discrimination and lack a scientific basis, stigma, and prejudice.

Also, punitive remarks preclude a sense of goodwill and more than likely undermine transparency, making the disease harder to com-

"The coronavirus is a threat to all human beings, not to a particular country or nation, and international cooperation is needed to deal with it," Bouey elaborated.

History has revealed that China and the US maintained strong communication and cooperation in the fight against SARS, H5N1, H1N1, H7N9, influenza, and Ebola, and have made great contributions to the progress of human health, said

Looking forward, Bouey said that scientists isolated the coronavi- in a globalized environment, the distance between countries is very small. The unfolding battle against this new pandemic, meanwhile, highlights the importance of transparency and open collaboration among scientists globally.

"It is a reminder that all nations should prioritize, and protect global health research, capacity building and cooperation," she said.

Russia cannot just sit and wait for further developments in Syria's Idlib – diplomat

RUSSIA cannot just sit and wait for further developments in Syria's Idlib where terrorists shell Syrian army's positions daily, head of the Russian Foreign Ministry's Department of International Organizations Pyotr Ilyichev said on Tuesday at the opening ceremony of the 9th session of the Uniteted Nations Model at the Diplomatic Academy of the Ministry of Foreign Affairs.

In response to a question on how the latest developments in Idlib affect Russian-Turkish relations, Ilyichev reminded about the memorandum

September 2018 which "reiterates, firstly, respect for sovereignty, territorial integrity, unity of the Syrian Arab Republic, and that the agreement on establishing a security zone in Idlib is temporary."

Furthermore, there were very important details, according to which Turkey pledged to disengage moderate opposition from terrorists, pledged to create a demilitarized zone, pledged to ensure free access to two national highways – M-4 and M-5. Over the last oneand-a-half years, nothing was done," he added.

"We understand difficulties that our

on the de-escalation zone in Idlib from Turkish partners face. However, the positions of Syrian forces, the positions of Russian forces - the Hmeymim air base, drone attacks – come under fire daily," he noted. "We cannot just sit and wait what will happen in Idlib next," he stressed.

The situation in Idlib escalataed after Russian and Turkish military made another attempt to introduce a ceasefire regime but terrorists only stepped up their attacks.

As a result, Russian and Turkish mili tary specialists were killed. In response, the Syrian army took control over the city of Saraqib in Idlib province on February 5. Agencies

PALESTINIAN President Mahmoud Abbas on Tuesday reiterated the rejection of a newly released U.S. Middle East peace plan, calling it an "Israeli-American proposal."

"I have come to you on behalf of 13 million Palestinians to call for a just peace. That is all. I have come to you today to reaffirm the Palestinian position that rejects the Israeli-American proposal," Abbas told the UN Security Council, which met to discuss the U.S.

The rejection of this plan reaffirms, or is the result of its unilateral steps and the fact that it violates international legitimacy and the Arab Peace Initiative, said Abbas.

"It annuls the legitimacy of Palestinian rights, our rights to self-determination, freedom, and independence in our own state. It legitimized what is illegal: settlements and confiscation of land, and annexation of Palestinian

"I would like to reaffirm that this plan or any part in this plan should not be considered as an international reference for negotiations," he said. "This is an Israeli-American preemptive plan in order to put an end to the question of Palestine. It was rejected by us because it considers that East Jerusalem is no longer under the sovereignty of the state of Palestine. That alone is enough for us to reject this plan."

He warned that the plan would put an end to the question of Palestinian refugees. It will end all basis for a peace plan. It means the rejection of all agreements and obligations to establish two states along the pre-1967 lines, said Ab-

"This plan will not bring peace or stability to the region. And therefore, we will not accept this plan. We will confront its application on the ground."

Showing a copy of a map of the U.S.proposed two-state solution for Israel and Palestine, Abbas said it looks like a piece of "Swiss cheese," which features large

"This is the summary of the project that was presented to us. This is the state that they will give us. It's like a Swiss cheese, really," said Abbas.

"Who among you will accept a similar state and similar conditions?" he asked. The U.S. plan includes the entrenchment of occupation and annexation by military force and the strengthening of "the apartheid regime," said Abbas. "This plan rewards the occupation, instead of holding it accountable for all the crimes it perpetrated against our people and our land."

"In this difficult time and before it is too late, I would like to say to (U.S. President) Mr. Donald Trump that the proposed American deal cannot achieve peace and security, because it canceled international legitimacy," said Abbas.

"Who can cancel international legitimacy, international legitimacy, who can annul and cancel it? President Trump did so. It cancels all resolutions of international legitimacy. It cancels all the rights of the Palestinian people. It even decided that East Jerusalem is no longer part of the Palestinian sovereignty. This does not meet the aspirations of a two-state solution (for) Israel and Palestine."

Businessman Andrew Yang ends eclectic presidential bid

ANDREW Yang, an entrepreneur whose unlikely White House bid evolved into a serious campaign thanks to grassroots enthusiasm, pulled out of the Democratic presidential race on Tuesday after New Hampshire delivered him a second straight poor showing.

Yang, 45, who ran for president despite having no political background, surprised many observers by qualifying for debates and remaining in the contest longer than some veteran poli-

The Ivy League-educated son of Taiwanese immigrants, who was bidding to be the country's first Asian-American president, launched his long-shot candidacy in 2017 as a virtual un-

Yang's signature proposal, a universal basic income that would pay every American US\$1,000 a month, was his answer to the "fourth industrial revolution," the rise of automation that he said destroyed millions of manufacturing jobs and, as a consequence, paved the way for Donald Trump's

Yang told supporters in New Hampshire on Tuesday night he would support whoever wins the Democratic nomination to take on Trump in November, while continuing to push his own message.

"This is just the starting line. This campaign has awakened something fundamental in this country and ourselves," he said.

On the trail, Yang warned that automation would hit major industries like retail, customer service and trucking. He noted that technology companies were paying almost no taxes despite profiting from people's personal data, and vowed to impose new taxes on tech giants to finance his "Freedom Dividend."

Supporters said they were drawn to Yang's diagnosis of the country's problems, saying it resonated much more

than a typical politician's speech. His devoted followers, fueled in part by his campaign's savvy use of social media, called themselves the "Yang Gang."

He had long pointed to New Hampshire as a natural place for him to Harder." succeed given its large proportion of independent voters. But the results on Tuesday - and last week in Iowa - made it unlikely he could raise enough money to continue campaigning.

As senators and governors saw their campaigns fizzle in what was the largest field of presidential candidates in U.S. history, Yang qualified for almost every debate thanks to a broad donor base and solid polling figures.

He was fond of noting he was the "opposite" of Donald Trump: "An Asian guy who likes math."

He often sported a MATH hat, which also stood for "Make America Think

He was a funny and amiable presence on the campaign trail, cracking jokes and occasionally breaking into

At a CNN town hall in New Hampshire last week, Yang got several questions from undecided voters until he finally smiled and said, "One of you should just pretend to be for me,' drawing laughs from the crowd.

Coronavirus outbreak is not an opportunity to score points against China

ON Feb. 1, Cui Tiankai, China's ambassador to the United States, gave a talk at a UC San Diego forum on China-US relations.

In his remarks at the forum, the ambassador said that the prevention and control of the coronavirus outbreak in China is the top priority for the country and that the well-being of people always

comes first. He stressed that China is doing whatever it can and using whatever means it must to curb the spread of the coronavirus and treat those affected.

The ambassador also emphasized that China is doing all this not just for the health and safety of the Chinese people, but for the health and safety of the entire global community.

He pointed out that the fight against the coronavirus once again shows that we live in a shared community where all of us are in this together.

China has taken extraordinary measures to combat the coronavirus outbreak.

The entire country has gone into battle mode to combat it. In Wuhan, the epicenter of the coronavirus outbreak, China recently completed the construction of a 1,000-bed emergency hospital in days and a second 1,600-bed hospital is under construction.

The People's Liberation Army has also set up medical teams to help local medical staff in this bat-

The coronavirus is only one of many health threats that we face as a global community and China is moving mountains to contain it. The H1N1 influenza virus that originated in the United States in 2009, for example, killed an estimated 151,700-575,400 people worldwide during the first year the virus circulated, according to official esti-

The United States did not do enough to stop the global spread of H1N1 but it has done too much in response to the novel corona-



virus outbreak in terms of restrictions, which is more harmful than

Many believe that the US response to the coronavirus outbreak has set a bad example for

other countries and created unnecessary fear and anxiety. The United States had raised its advisory for China to Level 4, telling Americans not to travel to China and for those currently in China to attempt to depart as soon as possible. It has also banned the entry of all foreign nationals who have been to China in the last 14 days, which goes against the recommendation of the World Health Organization that there should not be any travel or trade restrictions.

All countries should take appropriate defensive measures in times of uncertainty to protect the health and safety of their citizens, but we should also be careful

not to heighten fears around the world, fueling a wave of panic and overreaction and a wave of racism and xenophobia.

To add insult to injury, certain US officials see the misfortune as an opportunity to score points against China. Around the time that WHO declared the coronavirus outbreak a public health emergency of international concern, Secretary of State Mike Pompeo attacked the Communist Party of China, calling it "the central threat of our times," even though China's ruling party is going all out to lead the fight against the outbreak, and Commerce Secretary Wilbur Ross suggested that the coronavirus a

good thing, saying that it will "help" to accelerate the return of American jobs.

Unnecessary panic and cruel and heartless comments will do nothing to help contain the virus and will only heighten negative feelings, including racism and hostility. As the Chinese ambassador pointed out in his remarks, we must guard against any "political viruses" that prevent the two largest countries from joining hands to meet shared challenges.

We cannot let unnecessary panic or malicious agendas to control the response to a problem that requires all of us to work together.

Harden, Westbrook help Rockets beat Celtics 116-105

AFTER James Harden and Russell Westbrook combined for 78 points Tuesday night, Harden was asked just how dangerous this combination can be when it gets rolling.

"It's pretty scary," Harden said. Harden scored 42 points, Westbrook had 36 and Houston snapped Boston's seven-game win streak with a 116-105 victory over the Celtics in a game that showcased the Rockets' dynamic small-ball lineup.

Harden had eight rebounds and seven assists and Westbrook finished with 10 rebounds and five assists as the Rockets used a starting lineup without a true center after trading Clint Capela last week.

"It's helping both of them," coach Mike D'Antoni said. "It should. It opens up the floor for them. Both of them are great drivers and great finishers ... and it should trickle down to everybody else, too."

Houston broke it open with a 15-2 run that made it 116-98 with about two minutes left. Harden scored six points during the decisive stretch, and Danuel House had five.

Boston had two turnovers and missed numerous shots to allow the Rockets to turn the close game into one where D'Antoni cleared the bench for the last minute with the game well in hand.

"Harden was great ... and Westbrook was great," Boston coach Brad Stevens said. "Those guys are two of the best in the world and they showed it again tonight."

The Rockets enjoyed a big advantage at the line, going 37 for 42 compared to 20 for 25 for the Celtics. Harden made 17 of 18 foul shots.

Gordon Hayward had 20 points in Boston's first loss since Jan. 26. Jaylen Brown scored 19, and Jayson Tatum had 15 on 5-for-15 shooting.

Westbrook, who is in his first season in Houston after a trade from Oklahoma City, is excited for the possibilities for this lineup once they have more experience with it.

"We can be pretty successful," he said. "We've just got to find ways to continue to be effective, efficient and make the right plays."

Harden, who scored 19 points in Blazers 138-117 on Tuesday night.

the third quarter to help Houston take control, picked up his fifth foul with about eight minutes left. But he was able to stay in the game and avoid fouling out.

and seven rebounds in his fourth game since he was acquired as part of the four-team trade that sent Capela to the Hawks.

The Rockets were up by seven with about eight minutes left when Harden picked up three fouls in about 30 seconds. The Celtics then closed to 96-94 on Brown's 3-pointer and a dunk by Tatum with 5:40 to go.

But Houston made five straight free throws to push the lead to 101-94 before making the big run to put the game away.

Meanwhile, in New Orleans, Zion Williamson has recorded his first 30-point performance just nine games into his NBA career.

Williamson scored 31 points in barely 28 minutes on the court, and the New Orleans Pelicans used a dominant second half to defeat the Portland Trail

"I expect to make an impact but I don't expect to do nothing like this," Williamson said in his usual, grinning, affable manner. "I just kind of look to come in, just kind of fit in, just not try Robert Covington had 12 points to mess up, but my teammates and coaches are always pushing me."

"I do hold myself to high expectations, but I think it's just finding the line between reality and dreams," Williamson added. "If my teammates find me, they find me. If not, just got to make another play, get the rebound and just play defense.'

Williamson used his 6-foot-6, 285-pound frame, quick feet and explosive vertical to have his way with every defender Portland tried against him. Williamson was either too strong, too fast, or both. He mixed spinning dribbles and sudden baseline drives into his usual arsenal of soaring transition dunks and tenacious putbacks. Six of his nine rebounds came on the offensive end.

"I don't really think he's comparable to anyone that I have seen," Portland forward Carmelo Anthony said of Williamson. "Someone who is as

powerful as that, who jumps like that ... you can tell he's getting better and getting a feel for the game.'

JJ Redick scored 20 for New Orleans, which trailed by as many as 16 in the first quarter before taking command en route to a third straight victory. Josh Hart's 17 points included an alley-oop dunk set up by Williamson's lob in transition.

"It's kind of scary to see how good he is this early," Hart said.

Jrue Holiday contributed 16 points and 10 assists for New Orleans, while Lonzo Ball added 10 points and 10

Portland star Damian Lillard scored 20 points – less than half of his 42-point average over his previous 10 games. But his playing time was limited in the fourth quarter when the Pelicans, who led by as many as 26, had put the game out of reach.

CJ McCollum had 20 points for the Trail Blazers, and Anthony finished with 18, but just four after halftime. Hassan Whiteside had 17 points and 14 rebounds.

Tiger's pursuit resumes for No. 83 at Riviera

LOS ANGELES

THERE is no better place for Tiger Woods to set the PGA Tour record for most career victories than at Riviera.

Because this is where he played his first PGA Tour event as a 16-year-old amateur?

Because he now is tournament host of the Genesis Invitational, giving it the kind of elevated status – smaller field, bigger purse – enjoyed only by Jack Nicklaus at the Memorial and the late Arnold Palmer at Bay Hill?

Not necessarily.

Because it's the course Woods has played the most times - 10 as a professional – without ever having won and he's due?

Not at all.

What makes Riviera ideal is because it's the next one on his schedule. And the sooner Woods can win No. 83 to break the record he shares with Sam Snead, the sooner everyone can stop speculating about the inevitable.

The question came up Tuesday how could it not? – about how special it would be for Woods to set the record at Riviera. He interjected by saying with a smile, "Yes, that's been mentioned."

It was mentioned three weeks ago at Torrey Pines when he started the new year, and that made just as much sense. Torrey Pines was the first PGA Tour event he attended with L.A. his father, the course where he won eight times, including that 2008 U.S. Open that he played with a double stress fracture and shredded knee ligaments.

Then again, Woods has left such an enormous trail in golf that winning anywhere would have some historical perspective.

Woods has done well all over his home state: eight victories at Torrey Pines, three at La Costa, two at Pebble Beach, one at Harding Park (not including the Presidents Cup in 2009, where he went 5-0).

Riviera hasn't been so friendly to

Woods withdrew after narrowly making the cut in 2006 because he was ill, and he stayed away for the next 12 years, only returning when a new title sponsor came on board and took on his TGR Ventures as the group running the tournament.

Not all memories are bad. He was runner-up in 1999 to Ernie Els - a bogey on the 13th cost him dearly, and a bogey on the final hole ended it for Woods. He also shared a story about one of the occasions he was at the tournament without clubs.

Woods was behind the ropes watching on the 11th tee when he heard Tom Watson was coming up the eighth hole, which was right behind him. He got there just in time for Watson to miss left while aiming for the back left pin position.

"I'm basically one of the only ones over there and Bruce (Edwards) was on the bag and I'm standing looking at the golf ball," Woods said. "He comes over and says, 'Move out of the way, kid,' and pushes me out of the way. So I'm out on tour telling him this story and he says, 'Well, you

were in the way.' "So for me to have experiences like that here at Riv and to have now this be my event ... hopefully on Sunday we'll be having this discussion a little bit more."

If not Sunday, then soon.

Klinsmann quits Hertha, calls it 'suicide mission'

HERTHA Berlin head coach Jurgen Klinsmann has left his role at the Bundesliga club after less than three months in charge, saying "I took over a suicide mission."

The former Bayern Munich, Germany and U.S. men's national team coach confirmed his departure in a statement posted on his Facebook page and said he will remain at the club in a supervisory role.

"I took over a suicide mission," Klinsmann told Bild. "Only in one match, we did not get what I hoped for. The coaching staff managed to stabilize the team and get it away from the relegation ranks.

"From my understanding, a coach should have the full sporting responsibility, just like the English model. And, thus, also over transfers. This gives the position more power. The last few weeks cost too much energy spent with side issues. If I am responsible for the team as a coach, I want to put all my energy into working with the squad."

Those quotes followed his earlier statement on Facebook, in which he said: "I would like to say a big thank you to all players, fans, spectators, staff and my colleagues at Hertha Berlin for the support, the many meetings and the talks over the past ten weeks. It was an incredibly exciting time for me with many new interesting insights. The club and the city have grown on me even

"In late November, we followed the request of the club leadership with a highly competent team and helped out during a difficult time. Within a relatively short period of time we set out on a good path. Also because of the support of many people we put six points between us and the relegation playoff place despite mostly difficult games.

"I am more than convinced that Hertha will reach its goal to stay up. But for this job, which is not done yet, as the head coach I need the trust of the acting persons. Especially in a relegation battle unity, team spirit and focus on the basics are the most important elements. If they are not guaranteed, I can't live up to my potential as a head coach and fulfil my responsibility.

"That's why, after long consideration, I have come to the conclusion that I will leave my post as the Hertha Berlin head coach and return to my initial long-term task as a member of the supervisory board. The supporters, the players and staff have grown dear to me in this

"I continue to look forward to the many encounters with you in the city or in the stadium.'

Sources close to Klinsmann told ESPN last week that he felt unnerved by what he thought was a lack of support over a coaching license issue in January.

Having not coached in Germany since his dismissal at Bayern Munich in early 2009, Klinsmann had not renewed his license, which is required every three years in Germany. He had to provide documents as proof of continuing education to have his license renewed in time for the Bayern Munich home match, Hertha's first game of 2020.

Hertha cancelled Tuesday's scheduled news conference with Alexander Nouri, one of Klinsmann's assistant coaches, as the players trained ahead of the trip to Paderborn on Saturday.

"We were all in the meeting room and the players thought it was the meeting after the game against Mainz, but instead he said he won't be our coach anymore," midfielder Marko Grujic, on loan from Liverpool, told reporters.

"Strange news this morning. We are all a little bit confused. After the match we received the information that we won't train for two days to clear our heads. Because it was far from good on Saturday.'

"It's a great shock," defender Dedryck Boyata added.

Winger Javairo Dilrosun called Klinsmann's departure a "great loss" for the club.

He said: "He was a great personality. Now, there's chaos here. And we need to win on Saturday to calm things down."

"We were surprised by the developments this morning. Especially after such a trustful cooperation during the intense winter transfer period, there were no signs at all for this," Michael Preetz, Hertha Berlin's sporting executive, said.

"We will inform about the further developments at a given time."

He added that Nouri will take charge of the club on an interim

Klinsmann, 55, was appointed won just three of his 10 matches in charge, losing four and drawing

Hertha are 14th in the Bundesliga, six points off the relegation places. In January, they signed Krzysztof Piatek from AC Milan; sources told ESPN the striker cost a fee in the region of €27 million -- a club record.

Italian ref banned for head-butting goalkeeper

AN Italian soccer referee has been banned for one year after he lost his cool and head-butted a goalkeeper he had sent off during a minor league game earlier this month, ANSA news agency reported on Tuesday.

In a match between Borgo Mogliano and Montottone in Macerata on Feb. 1, the referee Antonio Martiniello had given Borgo Mogliano's goalkeeper Matteo Ciccioli his marching orders as the hosts won

The pair faced off outside the changing room after the game as

the goalkeeper sought an explanation for the dismissal. The referee head-butted Ciccioli, who was taken to hospital to treat his injuries.

Martiniello's ban will not only prevent him from officiating games for the next year but also from entering the facilities of teams in the top three tiers of Italian soccer, minor and amateur leagues, and matches involving the Italy national

The office of the Macerata police chief said the ban was fully warranted as Martiniello had failed to set an example for youngsters.

Zidane vs. Setien will determine who wins La Liga

NLESS you believe that Getafe, with European football to distract them and the possibility of losing their talismanic goal-scoring substitute Angel to Barcelona, can close a 10-point gap on La Liga leaders Real Madrid, then we must accept that Spain now has a 15-game, 15-week two-horse race for the title: Barcelona vs. Real Madrid.

If it's a reduced field, then, at least it's between two thoroughbreds (who happen to meet at the Bernabeu on March 1). One which has known its way to the finishing post almost by regal instinct throughout the past 15 years -- often winning at a canter. The other younger, more muscular, fiery, looking like it has the legs and lungs to take down the champion.

But this past weekend emphasised something about the jockeys: Quique Setien and Zinedine Zidane. While racegoers would tell you that it's almost always about the quality of the horseflesh, why is it that some jockeys spend a career lifting prize fee after prize fee? Because they matter. Thus, I think, it'll prove to be between now and May. One thoroughbred has a distinct advantage in terms of who's in the saddle.

First things first: Barcelona are gradually improving under Setien. Ernesto Valverde's reign ended with them disastrously unable to protect a one-goal lead with time running out against both Espanyol in the Catalan derbi and Atletico Madrid in the Spanish Supercopa semifinal. Since Setien took over, the reigning champions have had bad days and their flaws are not anything like wholly corrected, but one of the positive signs is that they've protected singlegoal leads against Granada, Levante and now Real Betis.

Little by little, Setien's pupils look sharper; slightly quicker off their toes, slightly longer on stamina and beginning to move the ball in a way that is, at least, not totally alien to the best days of the Camp Nou in those 15 years of rarely broken domestic domination: pass, move, press, win possession, pass, move, score.

Frenkie de Jong is beginning to break lines. Ansu Fati is starting to impose himself. Clement Lenglet is scoring goals and has proven that he's far ahead of Samuel Umtiti in the pecking order. Sergio Busquets, very slowly, is becoming recognisable once more. Arturo Vidal and Lionel Messi are having a shot at recreating the previously exclusive society from which Messi and Luis Suarez benefitted so much.

But Setien, compared to Zidane, is a novice. Not simply at winning trophies, not because he didn't have a career worth a hoot compared to the great Frenchman. No. Setien has staunch, clear-cut and highly entertaining footballing principles: win the ball quickly, pass it sharply and repetitively, move off the ball, creating supporting triangles of passing options for the man on the ball, try to take control of a match.

Win, yes, but win with flair and attacking verve if at all possible. Simply because he's at Camp Nou, suddenly with better players than ever before, there's nothing for him to update about the football ideals that have sustained him through his playing days and past his 60th year.

His pending task is learning about his squad; learning about their moods, their individual capacities, when to push them, when to rest them, when to chastise them, when to confer with them and trust them. Ask any coach: learning about and fully understanding, then motivating and leading, a group of 20-plus athletes is complex, frustrating and the biggest part of how you earn your salary.

Add the fact that your squad is composed of multi-multi millionaires -- one of whom earns about €100 million a year -- and full of guys who've genuinely seen it all, done it all, and the difficulty factor multiplies by about the numerals contained in a Messi pay packet: millions.

Zidane is in a different situation, and it shows. More, we are talking about the very factor most likely to differentiate the two men in the 15-match race to the tape.

He took over a rabble last season. He was the third coach in that term; the players were either tired, bored,

under-cooked or half-hearted. His appointment of fitness coach Gregory Dupont has been a masterstroke.

Unlike Diego Simeone, who's stuck with an increasingly unpopular and outdated fitness coach in "Profe" Oscar Ortega, Zidane's new appointment has utterly revitalised Los Blancos' squad. It took time -- witness the 3-0 defeat at Paris Saint-Germain in the autumn -- but for many weeks now Madrid probably only have Getafe as rivals in the fitness-staminasharpness stakes.

But with this newly revitalised raw material Zidane has worked wonders. I'm not claiming that, in comparison to Setien or any of his elite rivals in Europe, Zidane is an outright tactical genius. Instead, to me, the 47-year-old possesses qualities that remind me of a young Sir Alex Ferguson.

Ferguson, whether at Aberdeen, where he won two European trophies, or at Manchester United, where he dominated England, wasn't generally understood to be a tactical genius. His genius lay in implacably understanding his resources. Who was strong? Who was his on-pitch lieutenant? Which guy needed pushing? Which guy was self motivated? Which player would need a rest in five weeks' time? Which star was on the wane and needed selling? Ferguson was not flawless, even in this aspect -- take his handling of Jaap Stam and Roy Keane, for example.

But when you speak to any alumni of that Ferguson era at Old Trafford, they'll tell you of the enormous hold the Scot had over each and every one of his successful footballers. He told them something and they believed it. They cringed at the thought of letting him down. He imbued them with not just a winning attitude, but a brutal hatred of defeat. He was, to them, a guru; someone who convinced, who inspired and who cajoled all at the same time.

Zidane may not be as publicly fiery as Ferguson, but his ability to understand his playing staff -- what they

need to motivate them, when to play them, when to rotate them, when to bring them on in matches and, above all, when to take an instinctive risk (so Alex Ferguson) -- is what elevates him above not only Setien but almost every top manager in Europe.

Sunday was an example. Just as in recent weeks Zidane has rested Raphael Varane, Casemiro, Luka Modric and Federico Valverde in matches in which it appeared folly not to use his best players without exception, he left out Toni Kroos and the in-form Vinicius for what undoubtedly appeared like an ultra-challenging test in Pamplona against Osasuna.

The midfield functioned. Isco, deputising for Kroos, scored and was in the top three or four performing players. Modric, played as a second his season and was involved in three of the four goals. When the game was simmering and tense, Zidane brought on Lucas Vazquez (who scored) and Luka Jovic (who also scored). It felt like the man who broke the bank at Monte Carlo, saying "Let it roll" as his roulette chip towers built up on zero again and again and again.

Whatever Zidane touched: gold. It's been the same for the past few weeks. Mr. Midas rests Valverde against punchy, punishing Getafe away, brings him on with 20 minutes left and the Uruguayan produces an assist for Modric. "Zizou" leaves a tiring Lucas on against Sevilla, much against expectation given that it's the Galician's first appearance after a two-month injury absence, and Lucas rewards his manager by crossing for Casemiro's headed winner.

Against Valladolid with Dani Carvajal suspended, Zidane doesn't choose the younger, faster, taller, fitter Eder Militao to deputise at right-back, he chooses the loyal, likeable but lowon-form Nacho. For a late corner, Zidane instructs the diminutive defender how and where to attack the ball, and Nacho heads home the win-

the first-half tactics and personnel choice. Without hesitation he corrects it at half-time, brings on two wide men and Vinicius, who's getting personal tuition from the French World Cup winner and multi-time Champions League-winning coach, catalyses the move for the 1-0 winner.

Zidane is in the zone. He knows his troops inside out, judges brilliantly what to ask of them, when to feed and water them and when to shout "Into battle!" It's fascinating to watch.

Not to be unfair to Setien, he's new in the saddle. His refusal to use Vidal at Athletic Bilbao in midweek possibly cost Barcelona a place in the Copa del Rey semifinals. His distinctly odd decision not only to rest Ansu but to not then introduce him at halftime at Betis while Rubi's side played striker, had one of the great games of a ridiculously high defensive line and Barcelona screamed out for another player to run beyond that flimsy barrier and collect passes from Busquets, Messi and De Jong, well, that felt bizarre.

> There are other examples: starting off thinking that Umtiti -- slow and in terrible form -- should keep Lenglet on the bench, proclaiming that the notoriously injury-prone Ousmane Dembele was going to be "like a great new signing" about two days before the Frenchman collapsed in a heap again and wrote off the rest of the season.

> Football is like that. Decisions come at a cost, fortune only favours the brave sometimes, and Setien is inarguably making progress. It's just that time between now and the crucial months in which this league will be decided is very tight indeed.

> And while there looks to be a slight advantage to the machine in royal white colours that is a nose ahead more than halfway around the course, I think that Zidane is the rider who has the confidence, the knowledge and the little sprinkling of magic dust that will help Madrid gallop away from the popular champion and burst past the winning post -probably before we've reached May.

TCA ropes in Steve Tikolo as national cricket team coach

SENIOR national cricket squad's preparations for the ICC Africa T2O competition, which will be played in Nairobi in March, have got a boost as the Tanzania Cricket Association (TCA) has roped in Kenyan coach, Steve Tikolo, as the squad's head coach.

The TCA chairman, Premji Pindoria, disclosed Tikolo, who has a two-year contract with the association, will oversee the senior national men's team preparation for and participation in the Africa T20 tournament slated for March 20-18 in Nairobi.

Hosts, Kenya, and Uganda will also be looking for top honours in the showdown.

Pindoria noted he is confident Tanzania will excel in major international assignments given Tikolo is not only a well experienced coach, but also has played cricket in the World Cup, representing his country well.

Tikolo will, among other major assignments, coach the national Under-19 team to shape up for the African tournament to be played in Uganda in dates to be announced.

Tikolo pointed out his ambition during his two-year coaching career is to see to it Tanzania qualifies for the World Cup. The decorated former Kenya senior national team's player said that Tanzania has hugely talented players who lack some technical aspects from a qualified coach to help the country excel in ICC World Cup Qualifiers and African tournaments, among others.

Lack of an international exposure, according to him, is also one of reasons which have brought about Tanzania's failure to qualify for the World Cup. He pointed out that Kenya boasts of best cricket records, among others playing against World cricket big guns, West Indies.

The five-time World Cup player Kenya senior national team said that he will work collectively with TCA development officers and other stakeholders to make sure that Tanzania starts to see changes at least after either six months or a year once he takes charge.

"I may not predict for the future, because qualifying for the World Cup is a progress (pathway) from which we need to make our plans and investments for the youth," Tikolo, who took Uganda to the World Cup during his tenure, disclosed.

Tikolo said Tanzania is like a second home to him, having visited several times for playing cricket.

"I last came to Tanzania during the 2000's when I came to play in the Advanced Players League (APL), it is therefore my pleasure to be Tanzania's national team coach," Tikolo said.

Tikolo (born in 1971) headed Uganda in several International Cricket Council (ICC) tournaments including the World Cup.

He was widely regarded as the greatest Kenyan cricketer ever, he had scored the most runs and taken the second most wickets for the Kenya's national team in One Day International matches (ODI's).

He made his ODI debut in 1996 against India by the time he had played 11 caps for Kenyan teams. His last ODI was against Canada in 1993.

Pindoria, said that Tikolo was most needed because of his experience, success and exposure. "We kindly welcome him in Tanzania and great pleasure to work with him," the official said.

Shaheed Dhanan, TCA vice-chairman, disclosed; "I played cricket for over a decade as a national team player and always dream of playing in his level."

Tanzania has for years been taking part in major continental and ICC qualifying series, but performed poorly, prompting the new TCA leadership to look for a qualified coach to open a new chapter.

Khwaja to contest Graves for ICC chairmanship

IMRAN Khawaja, the ICC's deputy chairman, is set to contest the leadership of the global governing body against the ECB chairman Colin Graves at its annual meeting in June, ushering in a period of furious lobbying by both sides ahead of the vote of the board.

If elected, Khawaja, the former president of the Singapore Cricket Association, would be the first leader in the ICC's history to come from outside the governing body's traditional clique of Full Member nations, with India having four men in the role, England and South Africa two, and Australia, New Zealand, Pakistan and West Indies one each.

While it has been reported that Graves has the support of India, the ICC's re-constitution under the leadership of the current chairman Shashank Manohar in 2017 has added a far greater degree of diversity to the board. Formerly dominated by the voting rights of the 10 Full Members, it is now a far more varied coalition, including an independent female director Indra Nooyi, plus the additions of representatives for Afghanistan and Ireland in addition to the Associate directors from Scotland, Malaysia and Singapore - Khawaja.

ESPNcricinfo understands that while Graves currently has the support of other major nations, including Australia, New Zealand and Pakistan, the traditional Full Members now represent only 10 of 17 available votes on the board.

Khawaja, a longtime presence on ICC boards and committees, was named as Manohar's deputy in June 2017, and as a senior lawyer and chairman of the ICC's associate member committee has been an influential player among the game's decision-makers for quite some time. The most recent example of Khawaja's influence came when he convinced Manohar to take back his resignation and finish his two-year tenure.

He was also instrumental in helping reshape the ICC constitution to encourage a wider power base and greater number of nations involved in decision-making, something he made clear when accepting the deputy role. "It is a great honour to be elected Deputy Chairman especially whilst wearing the hat of an Associate," Khawaja said at the time.

"I am also privileged to be part of the working group to have authored and reinvented the ICC constitution to make it one of the most inclusive, transparent and merit based sports governing bodies in the world. I have no doubts that a new era is dawning on our great game which will see not only a more vibrant membership but also a competition structure that sees cricket played at the highest level."

Graves was also involved in these changes, but in recent times he has taken the step of allying himself closely with the BCCI and its new incoming leadership, fronted by Sourav Ganguly as president but with plenty of other familiar administrative figures behind him, including secretary Jay Shah and the former ICC chairman N Srinivasan.

It was Graves who authored a letter to the ICC's chief executive, Manu Sawhney, in November that expressed strong opposition to his plans for the next global broadcast rights cycle from 2023 to 2031, in which another global event would be added to the calendar in an attempt to generate more revenue for members, who have been suffering from the steady loss on value for rights to bilateral series, even those featuring India.

"We are keen to work closely together with ICC to promote the interests of cricket globally, to attract more fans to the game, and to optimise commercial returns without further compromising the existing balance between ICC Events and bilateral cricket," Graves wrote in part. "I am of the strong belief that working together as stakeholders, we can establish a calendar of events from 2023 onwards that achieves all of these aims and serves the interests of all ICC Members."

One of Graves' points of opposition to Sawhney's proposal was the clash of the extra ICC event with the World Test Championship final scheduled for 2023 - a decider that was the end result of years of work by the ICC and member boards to establish a workable league structure for the game's oldest and longest format. **AGENCIES**
