Treasury holds talks with two companies for power outlays

Despite having a power surplus some parts of the country still lack access to electricity, while being unable to export excess power to neighbouring countries due to inadequate transmission networks

A director with the Treasury has said that the government is in talks with two foreign investors expressing interest to build power transmission projects valued at \$1.2bn altogether.

David Kafulila, the treasury director for the public-private partnership (PPP) centre, made this affirmation at a press conference on current PPP initiatives in the power sector. If successful, these will be the first PPP power transmission projects, at present handled by the Tanzania Electric Supply Co. Ltd (TANESCO), with involvement of the private sector in constructing high-voltage power lines marking a new approach in the sector, he

SGR: TPA expresses high business hopes

THE Tanzania Ports Authority (TPA) has high hopes on the standard gauge railway (SGR) as it will greatly contribute to achieving port expansion and efficiency goal, the management has stated.

Plasduce Mbossa, the TPA director general, made this observation in Dar es Salaam yesterday at the launch of the corporate customer service week, explaining that this situation will foster development in the transport sector, benefiting the neighbouring countries as well.

Considerable investments at the port are meant to enhance competitiveness and optimize the use of the SGR for cargo transportation, pointing at SGR electric train project as poised to accelerate economic growth.

"The construction of the SGR will enable faster cargo transport and boost port productivity particularly for Dar es Salaam, which handles large shipments from various countries," he stated.

As the government actively seeks markets for crops such as cashews and peas, the SGR will strengthen the economy and increase incomes in various sectors, he said.

TPA plans to build ten piers to expand the Dar es Salaam port and enhance its regional competitiveness, he elaborated, affirming that the goal is to capture the port market for East Africa, first.

CHINA has declared its support to government efforts to promote the use of clean cooking energy.

Ambassador Chen Mingjian made this affirmation here yesterday, at a ceremony to distribute 800 gas cylinders and stoves to teachers, drivers, various public employees and journalists.

The use of gas in cooking would not only improve the lives of teachers but also plant the seeds of environmental protection in the hearts of both teachers and pupils, she said, asserting that Chinese President Xi Jinping often emphasizes the protection of the sea and mountains.

China recognizes the strong diplomatic relationship between the two countries as well as efforts by President Samia Suluhu Hassan to encourage Tanzanians to use clean cooking energy to protect the country's natural vegetation

Asserting that Tanzania is an environmentally friendly country, she said that it prioritises the conservation of Mount Kilimanjaro and the Serengeti National Park, among other captivating landscapes.

"During my three years of work here, I have witnessed incredible efforts Tanzania has made in environmental conservation," she stated, underlining that China and Tanzania have both refused to follow the old path of environmental degradation.

"We have chosen to prioritize ecological sustainability and green development," she said, emphasizing that promoting environmental conservation will also support the country's economic growth and improve people's lives.

Back in May this year when President Samia launched the clean cooking energy initiative, it was clear it fully reflected Tanzania's philosophy of putting its people first and living harmoniously with nature, she remarked.

"China and Tanzania are like brother and sister; we always support each other. Last month, the China-Africa Cooperation Forum held in Beijing brought together leaders from 53 countries, including President Samia, whereas they also deliberated to promote the use of clean energy," the envoy recalled.

During the China-Africa forum, a number of areas of cooperation were announced including a proposal for China to implement 30 clean energy projects in Africa to help the continent achieve green development, she

Arusha Urban MP Mrisho Gambo noted that Oryx Gas (T) Ltd (OGTL) has become the first company in the northern city to show commitment to supporting President Samia's clean energy campaign.

The company was liaising with the Chinese Embassy in financing the provision of gas cylinders and stoves to various groups in the region, he said, while OGTL managing director Benoit Araman said the availability of clean cooking solutions was a priority at present.

With two foreign companies expressing interest in investing in power transmission lines through the PPP Centre, the centre's mandate is to scrutinize investment the relevant proposals, he stated.

There is also limited expertise in key government entities, along with a pressing need for technical assistance and capacity-building support to enable the government to adopt PPPs in the energy sector effectively, the director underlined.

He pointed at a number of development partners advocating for the PPP agenda in power transmission across East Africa, currently collaborating in Kenyan and Ugandan projects.

He referred to views by energy

could become self-financing if tariffs are set at commercially viable rates, pointing at local power rates as the lowest electricity tariffs in East Africa.

This has made the country gain recognition for fostering an inclusive economy, he stated, recalling that in 2022, the government announced plans to invest \$1.9bn to upgrade the country's electricity transmission infrastructure.

GST allocates 73bn/- for airborne geophysical survey countrywide

THE Geological Survey of Tanzania (GST) has set aside 73bn/for a major high-resolution airborne geophysical survey across various areas mapped within the country's western zone.

Priscus Benard, GST's planning and marketing manager unveiled this here yesterday when speaking during the ongoing mining technology exhibitions.

He said that in its nearly 100year history, the GST has conducted high-resolution surveys for only 16 percent of Tanzania using specialized jets, stressing that the government provided the budget to acquire a tailor-made geophysical survey plane, which is projected to cost around 4bn/-.

"For the first time in our history, we will have our jet dedicated to conducting high-resolution airborne geophysical surveys of rock deposits, a development that is expected to elevate the sector," he stated.

With the new jet, GST aims to survey western Tanzania, potentially increasing the surveyed area by 18 percent.

Currently, GST has completed low-resolution surveys for approximately 97 percent of the country, geochemical surveys for 24 percent, and has conducted over 99 percent of geophysical surveys.

"These surveys have been instrumental in supporting the mining sector, and we anticipate that the upcoming high-resolution air-

borne survey will further advance include the adoption of advanced the industry," he said.

GST also plans to invest 20bn/in constructing three state-of-theart laboratories to enhance mineral sampling across the country.

"These labs, located in Mbeya, Geita, and Dodoma, will be equipped with cutting-edge technology to provide artisanal miners with professional testing of their mineral samples," he said.

The facility in Dodoma will serve as the country's mineral sampling headquarters, with the capacity to test all types of mineral samples. Construction processes for this facility are currently in the preliminary stages.

Benard also highlighted the government's commitment to equity and professional transformation in the mining sector, which will technologies like high-resolution airborne geophysical and geotechnical surveys.

"The establishment of modern mineral testing labs will play a crucial role in attracting more investors to the sector and enhancing overall performance," he said.

GST actively promotes mineral exploration and mining in Tanzania, engaging in geological mapping, mineral evaluation, and research on geological processes and geohazards.

With a vision to become a centre of excellence, GST aims to provide essential geoscientific data for the sustainable utilization of natural resources while balancing its responsibilities in geological mapping, data management, and

Salali acknowledged her work in making healthcare, especially the provision of sunscreen lotion, more accessible to people with albinism (PWA). Under her leadership, economic opportunities have albinism in Tanzania survive skin cancer to

also expanded, allowing people with the age of 40. albinism to participate more actively, such as through the Rafiki Briquettes project, which has enabled many to become selfemployed.

PWAs faced severe Previously, challenges, including limited access to crucial medical services like sunscreen, which is essential to protect them from harmful UV rays. The government's efforts have contributed to improving their quality of life and reducing the risk of skin cancer, which significantly affects the albinism community in Tanzania. Statistics show that only 2 percent of persons with

Salali emphasized the importance of increasing sunscreen production, highlighting concerns over reduced output from the Kilimanjaro Sunscreen Production Unit (KSPU), the only local producer of sunscreens specifically designed for PWAs. President Samia's initiatives, including plans for specialized clinics to serve the albinism community in all regions, have been praised as transformative steps toward better healthcare and inclusion.

This recognition comes as part of the broader progress toward supporting the rights and well-being of persons with albinism in Tanzania.

Campaigners seek supportive laws, robust plans for girls development

GIRLS across mainland Tanzania continue to experience violation of various rights with many facing psychological violence, child marriage and limited access to quality education, a new report

The report, titled "Situation of Girls' Rights and Wellbeing Analysis," conducted by the Msichana Initiative has identified that despite efforts conducted by the government and stakeholders to heighten girls' development, many do not achieve their potential due to various challenges they face.

Key issues identified by community stakeholders include sexual violence and the suppression of girls' voices, alongside psychological violence and inadequate parental guidance. The report notes that girls living in rural areas and those with disabilities are disproportionately affected by the challenges, which are exacerbated by deep-rooted patriarchal customs and traditions.

During a presentation of the findings in Dar es Salaam yesterday, report author Fundikila Wazambi emphasized that mental health is a significant concern for

He pointed out that unfriendly laws, poverty, sexual corruption, and neglect further hinder their rights and wellbeing.

Wazambi highlighted harmful cultural norms that deny girls fundamental rights and freedoms, as well as gaps in legal protections that have led to an increase in gender-based violence, including child marriage and denial of inheritance rights.

The report identified poverty, child marriage, parental attitudes, illiteracy, and poor sanitation in schools as the top five issues threatening girls' access to education.

Wazambi noted that the quality of education is declining, particularly as girls reach upper secondary levels, due to inadequate funding, shortages of educational resources, and difficult working conditions for teachers.

Additionally, a lack of parental support and guidance has been identified as a barrier to girls accessing quality education. Some parents reportedly encourage their daughters to fail exams, further limiting their opportunities.

underscores report importance of school attendance for girls' empowerment, suggesting that school clubs can provide vital education and help girls claim their rights. Evidence from NGOs indicates a positive correlation between club membership and improved academic performance.

To address the challenges, the report calls for the Parliament to amend the Marriage Act of 1971 to establish 18 years as the minimum legal age for marriage, thereby outlawing child marriage.

Recommendations also classifying sanitary pads as essential needs and implementing a free sanitary pad program for school-going students. Key informants, including girls' rights experts, have urged the removal of taxes on sanitary pads, emphasizing that access to these products is a basic necessity for girls.

The Ministry of Education is encouraged to reinforce the re-entry policy for pregnant and married girls, ensuring their right to education is upheld in accordance with international human rights standards.

Rebeca Gyumi, executive director of the Msichana Initiative, noted that the assessment aimed to evaluate the state of girls' rights and wellbeing in Tanzania, focusing on education, health, and agency.

She noted that analysis of police reports from 2018 to 2023 shows that 8 out of 10 victims of violence against children are girls, with rape being the most reported form of sexual abuse.

As the world prepares to commemorate the International Day of the Girl Child in the coming days, under the theme "Girls' Vision for the Future," Gyumi emphasized the urgent need for action to amplify girls' voices and visions for their future.

Kijo Bisimba, a veteran activist, echoed the sentiments, noting that today's generation of girls, faces numerous challenges, including climate crises, conflict, and poverty, which threaten their rights and limits their potential.

She urged the government to amend the Marriage Act of 1971 as it thwarts various efforts aimed at promoting girl's dignity and development.

"The court has already instructed for the amendment, what are you researching again in this law," she said.

The unsustainable farming practices causes severe soil erosion which leads to land degradation and sedimentation of rivers and Lake Tanganyika.

Given the importance of the Malagarasi watershed, which constitutes 30% of the Lake Tanganyika's total watershed area, addressing the most pervasive threats to the watershed is needed to secure its integrity for the long-term.

As the impacts of climate change intensify, there is an increasing need to adopt sustainable agricultural practices that can enhance resilience, restore degraded lands, and improve livelihoods. Regenerative agriculture, which focuses on restoring soil health, increasing biodiversity, and enhancing water retention, presents a viable approach to achieving these objectives.

The Nature Conservancy has been successfully working in the Greater Mahale Ecosystem (GME) for 12 years through its Tuungane Program. The Mahale Mountains National Park is part of the GME which borders Lake Tanganyika in its South. Tuungane Program would like to scale up its successes into the Malagalarasi-Moyowosi-Ugalla complex, a much larger ecosystem than GME that extends for more than 3.5 million hectares East of Uvinza. GME and the Malagarasi-Muyovozi-Ugalla complex share important ecosystem similarities that make lessons learned in one potentially transferrable to the other. Tuungane program envisages to bring to this new geography its experiences in addressing common conservation challenges existing in both systems.



tatisticians trained on database system

TANZANIA has started the process to adopt the National Accounts Compilation Software by all East African Community (EAC) member states by training the National Accounts Compilers in the country

Officials from the National Bureau of Statistics (NBS) and those from the Office of the Chief Government Statistician Zanzibar (OCGS) convened in Dodoma for training on the National Accounts Database System (NADABAS), a free, Excel-based software for compiling national accounts.

NADABAS was developed through a joint Scandinavian project in Mozambique in 2004.

Since then, the system has been Bureau of Statistics. adopted in several countries, including Lesotho, Kenya, Eswatini, Namibia and Botswana.

The training which kicked off on Monday seeks to equip participants from the National Bureau of Statistics (NBS)and those from the Office of the Chief Government Statistician Zanzibar (OCGS) with skills that will help them in the compilation of the will help them in the compilation of the NADABAS.

Participants in the training included Tanzanians from the National Accounts Statistics Department, representatives from EAC Secretariat, the African Union Institute for Statistics (STATAFRIC), Statistics Norway and the Kenya the 2022 Population Census, meets international standards.

The training seeks to ensure that Tanzania also adopts the system. According to the National Accounts Expert from the EAC Secretariat, Gervais Nduwimana, STATAFRIC in collaboration with EAC developed software which if adopted by member states can help to facilitate an exercise towards having the EAC Monetary Union Protocol.

"As EAC member states move into the monetary union venture, it is important to harmonise our statistics so that they are comparable, therefore national accounts are critical," he noted.

Speaking when opening the training session, Commissar of

Anne Makinda, paid tribute to the EAC Secretariat for organizing the training which she said demonstrates its commitment to see the governments of member states to continuously improve their national accounts statistics.

"This training will equip you with the skills to efficiently utilize NADABAS, thus appropriately helping you in preparation and organisation of all statistics related to the economic activities conducted in our country."

At the occasion, NBS Chief Statistician, Dr Albina Chuwa said that Tanzania values the contribution of statistics to the national economy and is committed to ensuring that data

Farmers issue policy proposals to lower land-related challenges

FARMERS have issued policy proposals aimed to address the main land-related challenges faced by small scale farmers across the nation.

The recommendations were reached after a two days National Land Rights Dialogue for Sustainable Production, held in Dodoma and brought together farmers from different parts of the country and government officials to discuss the challenges.

They argued that land-related issues continue to be a major challenge, especially for small farmers who depend on it for crop production, livestock and other economic activities.

The meeting was organized by the Tanzania Federation of Small Farmers Associations (SHIWAKUTA), a member organization of smallholder farmers in the country.

Reading the statement at the end of the meeting, SHIWAKUTA's Policy and Advocacy Officer, Thomas Laizer, said the proposals aim to address the main land-related challenges faced by smallholder farmers and the need for improvement.

He argued that small farmers often lack security of land ownership, making them vulnerable to eviction, land confiscation, and acquisition and response to land disputes. "Without formal title or legal recognition, farmers have little incentive to invest in land improvement or establish sustainable land use practices" he said, calling on the government to ensure they get documents.

On land damage, he noted that unsustainable farming practices, deforestation, and arbitrary farming have led to widespread land degradation in many areas, leading to a decline in soil fertility and a decline in agricultural and livestock production.

Degraded land also exacerbates the effects of climate change, such as soil erosion, flooding, and drought, which reduces the size of productive lands and affects smallholder farmers in the country.

Laizer explained that despite their important contribution to agriculture, women often face significant barriers to land acquisition and land ownership.

The participants pointed at practices of gender-biased land ownership, a law that does not discriminate against women's land ownership rights, and traditional practices prevent women from acquiring and owning land, limiting agricultural production and denying women the opportunity to participate in decision-making and land use.

They noted that in many rural areas, there are land disputes between different stakeholders such as farmers, ranchers, and investors, leading to a significant increase in land use disputes.

"These conflicts not only endanger agricultural activities, but also threaten peace, social cohesion and social stability", reads their statement.

In their recommendations, the association noted that to promote sustainable agricultural production, governments and policymakers should focus on strengthening land tenure security for smallholder farmers.

They said the land is part of the constitution and should be made in chapter one of the constitution as proposed in the Land Policy 1995. formalizing customary land rights through registration and title issuing programmes and establishing community land management systems to manage shared resources and resolve disputes.

The meeting also called on the government and the Ministry of Natural Resources and Tourism, to oversee the implementation of the Act No. 5 of 2009, not to divide the land of villages into wildlife reserves.

There should be national land rights debates regularly to identify challenges and to strategize land dispute resolution and the government in collaboration with development stakeholders should increase the power to provide education to the community on land laws and policies.

A DETAILED analysis of 2,384 reviews written by safari-goers and international safari experts has just determined the top 50 best safari parks on the African continent.

And the winner is Serengeti National Park in Tanzania, which takes the first position as Africa's top safari park for 2024, according to an official statement from Anita Kovalevska of SafariBookings.com.

Ruaha National Park which celebrates its 60th Birthday has also entered into the list for the first time, taking the 4th Position.

Also in the top ten listing is Katavi, another Tanzanian National Park at number 10.

Tanzania has essentially four entries in the 2024 winners; Serengeti at Number One, Ruaha at Number Four, the Ngorongoro Crater at Number 9 and Katavi closing the Top Ten.

SafariBookings.com, the largest online marketplace for African safaris, conducted its annual study to determine the 50 best African safari parks for 2024.

Private sector engagement crucial for sustainable healthcare services

MUTUAL trust, collaboration and transparency between the government and private health stakeholders are crucial in ensuring sustainability of health care services in the country.

Speaking during the 11th Tanzania Health Summit (THS) which was held in Zanzibar, Director of Health, Social Welfare and Nutrition Services at the President's Office (Regional Administration and Local Government Authority), Dr Rashid Mfaume said that currently about 85 percent of health care services in Dar es Salaam are provided by private health care facilities.

"The government has shown political will and implemented policies that create a conducive environment for private sector stakeholders to work towards achieving their goals while collaborating with the government" said Dr Mfaume while speaking at a Health Forum organized by Deloitte with the support of the U.S. President's Emergency Plan for AIDS Relief (PEPFAR) PEPFAR through United States Agency for International Development (USAID).

Deputy Chief of Party for USAID Kizazi Hodari Southern Zone Kenneth Chima said despite these achievements, the project still faces challenges due to limited funding and competing from the government priorities.

USAID Kizazi Hodari Southern Zone is a five-year project which is being funded by PEPFAR through USAID, and was highlighted as a good example of such private sector engagement.

The project, which kicked off in 2022, works with 14 civil society organizations in Southern Tanzania and aims at improving health, wellbeing and protection of orphans, vulnerable children and youth in communities with high HIV burden.

recent seminar in .African researchers to conflict resolution in the continent has reopened a can of worms many will have thought had long been disposed of.

A top cabinet official objected to prioritising research themes arising from the interests of foreign organisations funding such studies, demanding that patriotism come before any other consideration.

When this is the stated position of senior public officers, both retired and serving, it is hard to see how they would resolve issues confronting the continent.

The issue isn't that everyone should accept that democracy be seen as legitimate, but rather how far African states are nearing an ideal democratic environment or have simply failed.

It is noteworthy that this was the first Africa Peace and Security Dialogue (APSD), organised by the Thabo Mbeki Foundation in the South African commercial capital.

Scholars, civil society organisations and research institutions working on African matters brainstormed on the issues. The idea that they should place patriotism and the continent's interests first presumed that there is a clear dichotomy between the two, such that each of us, first as citizens and then as researchers for those marked out in that category, has to take sides.

Yet the issue is less the pursuit of the national interests of those funding research but their ideological interests in the conflict sphere.

Celebrating 20 years of gorilla conservation in Rwanda

Rwanda's the Commissioner to Tanzania, I have come to learn specific lessons or observations about conservation in Tanzania that resonate deeply with Rwanda's own experiences. Tanzania and Rwanda have specific conservation practices or principles in common, underscoring our mutual commitment to preserving our natural heritage.

In the aftermath of the 1994 Genocide against the Tutsi, Rwanda faced monumental challenges. The tragedy impacted not only the people of Rwanda but also its natural habitats and wildlife. Among the severely affected species were the country's mountain gorillas, then teetering on the brink of extinction. As Rwanda embarked on a path to rebuild its nation, its government, formed in the wake of unimaginable human loss, recognized the critical need to include the protection of its natural heritage in its recovery efforts.

This led to the inception of 'Kwita Izina' (loosely translated as "naming") in 2005. Inspired by a centuries-old tradition where Rwandan families gathered to name newborn children eight days post-birth, Rwanda decided to extend the ceremony to its beloved residents - the mountain gorillas to promote their conservation and protection. This event was not just a naming ceremony but a societal celebration to integrate the child

When the Rwandan government began officially naming mountain gorillas, it formally declared the value of each gorilla to the Rwandan nation, and the importance of protecting both the gorillas and their habitat. Now, Kwita Izina has evolved into a global event that draws conservationists, celebrities, and policymakers from around the world to celebrate Rwanda's dedication to preserving its biodiversity.

A year on, October 7 is sharp reminder of how horror can serve as the key to change

OCAL and international America. airwaves have devoted portion of their broadcasting time to mark October 7 as an anniversary relating to an attack in southern Israel on a religious festival.

Wars between Israel and its neighbours are habitual in the region, but the year-long skirmishes are different as they are dragging the region into an unbridled regional conflict.

The global powers will not be far behind, but they are tied down to worries of their own.

Trying to grapple with what happened on October 7, 2023 is to try and fathom what is impossible to swallow as a proposition.

It comes down to the proposition that if a guerrilla force attacks one's neighbouring country massively enough to push it to frontal war, demands of the attacking party will have to be met at the world stage to avoid physical extermination of a certain people. It is unclear if this strategy is still viable, and whether any such eventuality is on the horizon.

In a speech midway in the yearlong conflict, the now deceased leader of a kindred political and military organisation in Lebanon took stock of the issues in vital strategic or vision clarification

He said that one thing October 7 attained was that many in Israel were now busy re-examining whether they should be there or move back to Europe and

A sharp contrast was that, in the wake of the war extending to Lebanon and arguably drawing Iran into a military showdown with Israel, the top echelon of the political/military leadership in Tel Aviv thought that things must change.

For those who have time or ability to sit back and reflect on matters, the big issue in the conflict is whether it had to arrive at October 7 as an explosive expression of the potential for dialogue.

The background to this colossal collapse of civilised dialogue on the Middle East conflict were the Abraham Accords drawn up and signed between the United States and several countries in the Gulf

At the time October 7 was being rolled out, it is understood that Saudi Arabia had mended relations with Iran and looked forward to joining the pivotal

A most regrettable facet of the conflict is that having kindred and arguably great historical track of roles in history had all but failed to bring the two sides together in a stabilising entente.

They say that history repeats itself, and indeed the Yom Kippur War of October 1973 was repeated half a century later - in 2023 - but that is as far as it goes. Gaza and Israel will hopefully not be able to live a year-long horror again in the

AI has a stupid secret: We're still not sure how to test for human levels of intelligence

TWO of San Francisco's leading players in artificial intelligence have challenged the public to come up with questions capable of testing the capabilities of large language models (LLMs) like Google Gemini and OpenAI's o1. Scale AI, which specialises in preparing the vast tracts of data on which the LLMs are trained, teamed up with the Center for AI Safety (CAIS) to launch the initiative, Humanity's Last

Featuring prizes of US\$5,000 (£3,800) for those who come up with the top 50 questions selected for the test, Scale and CAIS say the goal is to test how close we are to achieving "expert-level AI systems" using the "largest, broadest coalition of experts in

Why do this? The leading LLMs are already acing many established tests in intelligence, mathematics and law, but it's hard to be sure how meaningful this is. In many cases, they may have pre-learned the answers due to the gargantuan quantities of data on which they are trained, including a significant percentage of everything on the internet.

Data is fundamental to this whole area. It is behind the paradigm shift from conventional computing to AI, from "telling" to "showing" these machines what to do. This requires good training datasets, but also good tests. Developers typically do this using data that hasn't already been used for training, known in the jargon as "test datasets".

If LLMs are not already able to pre-learn the answer to established tests like bar exams, they probably will soon. The AI analytics site Epoch estimates that 2028 will mark the point at which the AIs will effectively have read everything ever written by humans. An equally important challenge is how to keep

assessing AIs once that rubicon has been crossed. Of course, the internet is expanding all the time, with millions of new items being added daily. Could

that take care of these problems? Perhaps, but this bleeds into another insidious difficulty, referred to as "model collapse". As the internet becomes increasingly flooded by AI-generated material which recirculates into future AI training sets, this may cause AIs to perform increasingly poorly. To overcome this problem, many developers are already collecting data from their AIs' human interactions, adding fresh data for training and test-

Some specialists argue that AIs also need to become "embodied": moving around in the real world

and acquiring their own experiences, as humans do. This might sound far-fetched until you realise that Tesla has been doing it for years with its cars. Another opportunity is human wearables, such as Meta's popular smart glasses by Ray-Ban. These are equipped with cameras and microphones, and can be used to collect vast quantities of human-centric video and audio data.

Narrow tests

Yet even if such products guarantee enough training data in future, there is still the conundrum of how to define and measure intelligence - particularly artificial general intelligence (AGI), meaning an AI that equals or surpasses human intelligence.

Traditional human IQ tests have long been controversial for failing to capture the multifaceted nature of intelligence, encompassing everything from language to mathematics to empathy to sense of direc-

There's an analagous problem with the tests used on AIs. There are many well established tests covering such tasks as summarising text, understanding it, drawing correct inferences from information, recognising human poses and gestures, and machine

Some tests are being retired, usually because the Als are doing so well at them, but they're so taskspecific as to be very narrow measures of intelligence. For instance, the chess-playing AI Stockfish is way ahead of Magnus Carlsen, the highest scoring human player of all time, on the Elo rating system. Yet Stockfish is incapable of doing other tasks such as understanding language. Clearly it would be wrong to conflate its chess capabilities with broader intelligence.

But with AIs now demonstrating broader intelligent behaviour, the challenge is to devise new benchmarks for comparing and measuring their progress. One notable approach has come from French Google engineer François Chollet. He argues that true intelligence lies in the ability to adapt and generalise learning to new, unseen situations. In 2019, he came up with the "abstraction and reasoning corpus" (ARC), a collection of puzzles in the form of simple visual grids designed to test an AI's ability to infer and apply abstract rules.

Unlike previous benchmarks that test visual object recognition by training an AI on millions of images, each with information about the objects contained, ARC gives it minimal examples in advance. The AI has to figure out the puzzle logic and can't just learn all the possible answers.

EGIONAL director for the World Health Organization (WHO) African region, Dr Faustine Ndugulile, has urged the public to establish regular health checkups to better monitor and maintain their overall health.

Dr Ndugulile made these remarks over the weekend while launching a three-day eye health camp at Vijibweni Hospital in Kigamboni district, Dar es Salaam. The event was organized by the Lalji Foundation in collaboration with the Lions Club of Dar es Salaam host.

"It is now more important than ever to know your health status. Key information, such as your weight, height, and blood pressure, plays a critical role in maintaining good health. Equally important is knowing your blood sugar levels. Awareness of your health helps you take preventive measures and avoid serious complications. Ignorance of your health status can be extremely dangerous," Dr Ndugulile stated. He further explained that many

people suffer from eye problems linked to conditions like high blood pressure or diabetes, often because they were unaware of their health issues in time. "Had they known earlier, they could have managed their blood pressure or sugar levels, preventing these problems. That's why it's so important to make routine health checks a habit," he emphasized.

Dr Ndugulile encouraged Kigamboni residents and those from nearby areas to take advantage of the free services offered at the medical camp. He stressed the importance of eye health for all age groups, not just the elderly, urging families to bring their children for check-ups as well.

"I want to thank the people of Kigamboni for turning out in large numbers. Eyesight is essential to our daily lives, and everyone, including children, should have regular eye exams. Let's be ambassadors of this camp and encourage our peers to come and benefit from these services. Together, we can build a healthier community, fully engaged in everyday activities," he said.

He also called on the Lalji Foun-

dation and the Lions Club of Dar es Salaam to continue organizing such camps for the community, recognizing their significant im-

"Medical camps like this are vital for our communities. I encourage us to sustain these efforts and include specialists in other areas, such as orthopaedics and paedi-

atrics, to continue benefiting the people. Let's establish a system that provides ongoing quality healthcare services," Dr Nduguli-

Imtiaz Lalji, chairman of the Lalji Foundation, stated that the camp aims to serve approximately 3,000 patients, urging residents to take advantage of the opportunity.

"We expect to serve at least 3,000 patients by the end of this camp. We appreciate the great response from the residents of Kigamboni," Lalji said. He highlighted the need for such medical services in Kigamboni and praised the significant turnout.

"On the first day, we saw 700 people, with 88 receiving eye surgeries. On the second day, we had already registered 800 people," he explained, adding that these camps will continue in different areas to reach more communities.

Why Africa should embrace territorial markets to stand climate shocks and crises

FRICAN policymakers, local leaders and the private sector have been asked to create an enabling environment that will help African traders and farmer folks build reliable systems for food security and resilience through territorial markets.

During a week-long 2024 Africa Agroecological Entrepreneurship and Seed Festival in Harare, Zimbabwe, experts observed that persistent crises have shown the importance of resilient close-tohome 'territorial' markets that feed billions of people every dayfrom public markets and street vendors to cooperatives, from urban agriculture to online direct sales, and from food hubs to community kitchens.

"For instance, following Russia's invasion of Ukraine, global food prices spiked by 15 percent, forcing policymakers around the world to question how to reduce dependency on volatile global markets and strengthen food self-sufficiency," said Dr. Million Belay, the General Coordinator at the Alliance for Food Sovereignty in Africa (AFSA).

"Further, questions have been raised about how people are actually fed and by whom, prompting us to ask: in this century of crisis, what kinds of food supply chains and markets can build resilience and help fulfill the right to foodnourishing people around the world more sustainably and equitably?" asked Belay.

To answer the question, experts are calling for policies and a sound working environment that will empower territorial markets that promote dietary diversity and affordable nutritious foods for all, allow producers and food workers to retain control over their livelihoods, and produce food that is adaptable to climate change shocks and emerging crises.

These markets have been broadly defined as markets that are centered on small-scale agroecological food producers and business owners that produce and sell a variety of commodities, and often meet the preferences of the majority of farmers, traders and consumers.

Studies have shown that these markets play a crucial role in making food accessible and affordable, especially for low-income populations in the Global South, allowing for the purchase of small and flexible quantities of food, price bargaining, informal credit arrangements, and being located in or near low-income neighborhoods.

A new study launched on the sidelines of the Harare event that culminated into the fifth Biennial Africa Food Systems Conference. however, shows that profit-oriented corporate value chains are highly concentrated in Africa's market places.

The report, titled 'Food from Somewhere,' by the International Panel of Experts on Sustainable Food Systems (IPES Food), finds that just seven grain traders control at least 50 percent of the global grain trade, six major corporations control 78 percent of the agrochemical market, the top eight carriers of freight account for more than 80 percent of the market for ocean freight capacity and globally, 1 percent of the world's largest farms control 70 percent of the world's farmland.

This, according to experts, amounts to a corporate capture of

Africa's food systems.

The report is therefore advocating for a paradigm shift, urging governments to reinvest in local and regional supply infrastructure, relocalize public purchasing and develop food security strategies for a more resilient and equitable approach to food security.

"The problem for smallholders is not of being connected to markets (most are already involved in markets) but rather the conditions of their access and the rules and logics by which markets operate—who determines prices and on what criteria, who controls the costs of production, who holds market power, among other issues," said Mamadou Goïta, a member of IPES and the lead author.

A spot check at the Mbare Musika territorial market in Harare found a variety of foodstuffs sourced from all eight regions of Zimbabwe, among others from neighboring countries, such as apples and other fruits from South Africa, fish and ginger from Mozambique, groundnuts from Malawi, sorghum from Botswana, as well as grapes from Egypt and tamarind from Tanzania, among others.

"This is the central hub for smallholder farmers and traders, supporting over seven million people from all over Zimbabwe and other parts of the continent," said Charles Dhewa, Chief Executive Officer, Knowledge Transfer Africa (KTA), whose flagship known as

a physical and web-based market for agriculture and rural development, integrating the use of mobile phones and the internet to create. adapt and share knowledge.

Mbare Musika Market, which is in the outskirts of Harare, is located next to the main bus-park, through which food is brought in using informal means such as passenger buses and vans from different parts of the country, in small and big quantities, and of different varieties and qualities.

"The evidence is clear-localized food systems are vital for feeding an increasingly hungry planet and preventing food insecurity and famine," said Shalmali Guttal, the Executive Director of Focus on the eMkambo (eMarket) is to create Global South. "They provide nutri-

tious, affordable food and are far more adaptable to global shocks and disruptions than industrial supply chains," she added.

Jennifer Clapp, professor and Canada Research Chair in Global Food Security and Sustainability at the University of Waterloo, Canada, pointed out that during this time of rising hunger and ecological fragility, global industrial food chains will be catastrophically liable to break down under the strain of frequent crises.

"To have a chance of reaching the world's zero hunger goal by 2030, we need to re-imagine our food systems, and we need to bolster the food markets that serve the poor," she said.

ACT unveils unsettled in 2020 election issues

erty we experience has been inflicted upon us by those in power," Othman stated.

He pointed out that smaller island nations with fewer resources have prospered due to their ability to manage their own affairs independently.

"These countries have thrived because they maintain full autonomy over their economies and resources," he added.

Othman also paid tribute to the late Mohammed Shamte, a native of Chambani, recognizing his role in securing Zanzibar's membership in

the United Nations.

"Even after the 1964 revolution, President Karume exercised this right by nominating ambassadors," he noted.

During the same rally, Deputy Secretary General Omar Ali Shekhe alleged that local government leaders, known as Sheikhas, were collecting voter cards from residents to determine their political affiliations.

"Do not give your voter card or its number to these leaders, as their motives ahead of the elections-just 390 days away-are suspicious," he warned.

Shekhe reaffirmed the party's commitment to protecting the right to freely elect leaders at all levels, noting that Zanzibar has long been governed by leaders who were not chosen by the peo-

"Beyond that, we advocate for the right to live, access social services, employment, and equitable enjoyment of our country's natural resources," he said.

He concluded by stating that the pursuit of an autonomous Zanzibar is the key factor that distinguishes ACT Wazalendo from other politi-

Smokers have a higher level of harmful bacteria in the mouth

A recent report by the World Health Organization (WHO) estimated that 8 million people die annually from smoking related complications. Despite efforts by governments and various organisations to create awareness about the dangers, around 1.3 billion people still use some form of tobacco and 80% of them live in low to middle income countries.

There is no safe level of smoking. Even second-hand smoke can lead to serious complications such as cardiovascular disease and cancer.

The mouth (oral cavity) is the first port of entry to the rest of the body and is home to a complex and diverse community of microorganisms, known as the oral microbiome. These organisms live in harmony with one another. They protect the normal oral environment, aid digestion, regulate the immune system and promote health.

If this balance is disturbed however, it can lead to the development of periodontitis (gum infections), inflammation and serious diseases, such as heart disease, cancer, liver and renal disease.

Changes to the bacterial composition of the mouth can be caused by several factors, such as bad oral hygiene, diet, alcohol and smoking.

We've looked into exactly what types of bacteria are affected. Our research did this by examining the oral health of 128 individuals who had participated in a 2014/2016 study of vascular and metabolic health.

We found clear differences in the bacteria present in the mouths of smokers compared to non-smokers.

Smokers had higher levels of harmful bacteria - like Fusobacterium, Campylobacter and Tannerella forsythia - in their mouths.

These bacteria can cause gum disease and may increase the risk of heart disease because they can trigger inflammation and other harmful effects in the body.

How smoking affects the oral biome

Tobacco and cigarettes contain several toxic substances which include nicotine, tar. radioactive chemicals, lead and ammonia. Many of these are formed from burning the tobacco. As a cigarette is smoked, these chemicals enter the oral cavity and change the surrounding environment by



reducing oxygen levels, changing the pH (level of acidity) and preventing adequate production of saliva.

Saliva not only keeps the mouth moist and helps digestion, but also has important antibacterial properties which assist in destroying dangerous germs and keeping the oral cavity healthy.

A dry mouth together with low oxygen levels in the mouth allows harmful bacteria to multiply.

The overgrowth of these organisms destroys the balance of the healthy bacteria normally found on the surfaces of the teeth, tongue and palate.

Nicotine

One common chemical

found in cigarettes is nicotine. This toxin can increase the number of proteins on the surface of certain harmful bacteria such as P. gingivalis.

These proteins or receptors give the bacteria an advantage over the normal microorganisms and allows them to attach firmly to surfaces where they multiply into colonies and form biofilms. Dental biofilms are a complex community of microorganisms which can form on the teeth and other hard surfaces. If not controlled, they can lead to plaque formation, periodontitis, gum disease and tooth decay.

Smoking and serious dis-

These abnormal colonies can influence the immune system, leading to slow healing, inflammation and even antibiotic resistance. The chronic inflammation caused by gum disease can lead to tooth loss and the destruction of gum tissue, which has been linked to systemic diseases such as cardiovascular disease.

Another bacterium, Streptococcus mutans, can also become abundant in people who smoke heavily. This organism is often present in healthy conditions but when the environment is disrupted, it can multiply and form part of dental biofilms, leading to tooth decay and oral cancer.

Vaping and e-cigarettes

Electronic cigarettes or vapes operate with a battery and heating element which heats up a liquid. This produces an aerosol which is inhaled by the user. The liquid contains different flavourings as well as harmful chemicals such as nicotine and lead.

Early research seems to suggest that e-cigarettes are not a good alternative to smoking tobacco. Although their effects on the oral microbiota have not been well studied, the increased growth of bacteria such as Fusobacterium and Bacteroidales has been observed in people who vape.

Both of these bacteria can cause periodontitis (gum dis-

Can these changes be reversed?

It is clear that the harmful chemicals in cigarettes and other forms of tobacco can lead to serious diseases which often begin in the oral cavity. The good news is that these can be prevented and the risk reduced.

Although it may take time, the healthy diversity of the oral biome can be restored by quitting smoking. This reduces the risk of gum disease, promotes the production of saliva and improves health.

Prevention is better than cure and governments and organisations such as the WHO need to continue to create awareness around the dangers of smoking, particularly among the youth.

Current account deficit narrows as exports boost Tanzania's recovery

TANZANIA'S current account deficit significantly narrowed to US\$2,567.2 million in the year ending August 2024, from US\$3,846.5 million in the corresponding period in 2023, driven by the improved performance of the external sector.

This progress has been supported by global economic recovery, strong export growth, and a moderated rise in import bills, alongside favorable international commodity prices.

Bank of Tanzania's (BoT) monthly economic review for September shows that exports of goods and services surged to US\$ 15,064.6 million in the year ending August 2024, compared to US\$ 13,290.1 million during the same period in 2023.

This remarkable growth was largely fueled by higher service receipts, particularly from tourism, as well as increased exports of gold and traditional goods such as tobacco, cashew nuts, and horticultural products.

Traditional exports reached US\$ 1,099.9 million in the year ending Au-

gust 2024, up from US\$ 807.9 million the previous year, with much of the increase attributed to tobacco and cashew nut exports due to both volume and price effects.

Non-traditional exports rose slightly to US\$ 6,568.3 million from US\$ 6,349.8 million in the preceding year. A key driver behind this increase was the rise in gold exports, which surged by 8.2 percent to US\$ 3,189.4 million, reflecting both volume and price ef-

Horticultural exports, particularly edible vegetables, experienced robust growth, increasing by 35.3 percent to US\$ 454.4 million due to higher shipment volumes.

surge, climbing to US\$ 6,948.5 million in the year ending August 2024, up from US\$ 5,711.3 million in 2023.

Service receipts saw a significant

This growth was largely attributed to strong performances in travel and transport services, with tourism leading the charge.

Tourist arrivals increased by 21.7 percent, reaching 2,051,404, a clear indication of the sector's recovery.

Transport earnings, mainly from freight charges, also grew, amounting to US\$ 2,597.6 million compared to US\$ 2,184.7 million in the previ-

On the import side, goods and services imports rose modestly to US\$ 16,427.5 million in the year ending August 2024, compared to US\$ 16,327.7 million in 2023.

Key drivers of this increase were the imports of refined petroleum products, iron and steel, and electrical machinery.

On a monthly basis, goods imports totaled US\$ 1,468.3 million in August 2024, up from US\$ 1,163.9 million in the corresponding period

The primary income account deficit widened to US\$ 1,760.8 million for the year ending August 2024, up from US\$ 1,446.4 million in the previous year, primarily due to increased interest payments.

However, on a monthly basis, the primary income account deficit narrowed to US\$ 96.2 million in August 2024, compared to US\$ 114.9 million in August 2023.

The secondary income account recorded a surplus of US\$ 556.5 million for the year ending August 2024, slightly down from US\$ 637.6 million in the same period in 2023.

This surplus was bolstered by a rise in personal transfers. On a monthly basis, the secondary income account registered a surplus of US\$ 43.5 million in August 2024, comparable to the same period in 2023.

This robust performance of the external sector, particularly driven by export growth and a stable import environment, underscores Tanzania's gradual recovery amid improving global economic conditions.

State-owned firms' CEOs urged to play productive leadership roles

CHIEF Executive Officers (CEOs) have been urged to play a vital role in realizing productive leadership within public-led institutions.

This call was made on Monday evening by Dr. Tausi Kida, the Permanent Secretary in the Ministry of Planning and Investment, on behalf of Chief Secretary Dr. Moses Kusiluka.

She inaugurated a three-day induction program for CEOs currently taking place in Kibaha district.

Themed 'Enhancing Leadership and Strategic Management in Public and Statutory Corporations for Sustainable Development,' the program aims to equip CEOs with intensive leadership skills.

Dr. Kida stated that the program, which includes all appointees from 2022 to the present, is designed to provide new executives with essential frameworks and concepts to optimize workforce performance and

She challenged the heads of public entities to step up their efforts to increase contributions to the Consolidated Fund, which would complement tax revenue in financing development projects and social services.

"President Dr. Samia Suluhu Hassan wishes to see positive changes in the entities you lead. We, as the government, need a return on investment," Dr. Kida remarked.

Tanzania has 309 State-Owned Enterprises with an investment capital of 75.8trn/-.

The Treasury Registrar, Nehemiah Mchechu,

indicated that the induction program would feature high-impact sessions led by esteemed experts from both the public and private sectors.

According to him, the mandatory program will provide new heads of public entities with skills in strategic resource management, strategic leadership, financial management, public ties. procurement, and public investment oversight.

"The induction program will lay the essential foundations for new executives to align their leadership competencies with the vision of a thriving public sector," Mchechu explained.

He asserted that the purpose of the CEOs Induction Program is to prepare newly appointed executives to better serve the citizens of Tanzania through exemplary leadership and to contribute to real value creation across the govern- to inspire colleagues. AfCFTA lags behind as it accounts for 16 pc of Africa's overall trade

AFRICA'S AfCFTA trade agreement is the world's largest free trade bloc. It opens access to potential markets of about 1.3 billion people and an estimated combined GDP of \$3.4tn.

Still, as delegates attending the Standard Bank Africa Unlocked conference in Cape Town heard recently, intra-African trade, at 16 percent, lags far behind other blocs.

Discussing the introduction of the African Continental Free Trade Area (AfCFTA) Agreement at the conference, panel members highlighted that, in contrast to intra-Africa trade, which accounts for about 16 percent of Africa's total exports, levels of bloc trading have reached 55 percent in Asia, 49 percent in North America and 63 percent in countries within the EU.

Given these statistics, it was highlighted that the AfCFTA should be leveraged to position African products more relevantly across global and intra-African markets.

A significant factor delaying this progress is Africa's failure to become economically complex by using its available products to develop products that can open opportunities in new

The principle of economic complexity, mastered in developed countries, has enabled countries such as the USA to create and export products based on oil for more than a century.

Nigeria, which also has access to oil, has not taken the step into complexity. As a result, the country is importing petroleum jelly; a product that could easily be locally duplicated. The same problem exists in many African markets where, for decades, beneficiation of raw materials has not occurred.

Covid-19 has been another limiting factor for African trade, and the continent is still recovering from the pandemic's impact, while many parts still grapple with the economic damage inflicted by it. At the same time, Africa still suffers the effects of having to shoulder a disproportionate disease burden in comparison with that carried by other continents.

Despite the disease burden, the continent still imports most of its healthcare supplies, and its trade deficit continues to increase.

Rectifying this situation and providing for a more significant portion of its own healthcare requirements would greatly support the contiCovid-19 has been another limiting factor for African trade nent in its effort to become 'healthier' at lower cost, saving precious foreign currency and promoting competitive growth through intra-Afri-

The panel affirmed that three conditions must be present for trade to improve welfare levels and fulfil the mission of leveraging intra-African and global trade to reduce poverty and increase employment among participating na-

The first of these is financial development. When domestic private credit extension as a share of GDP reaches 18 percent, trade begins to reduce poverty.

Education is the second factor. A better-educated labour force translates into enhanced capabilities and productivity.

The third factor is governance. Although trade oils the machinery of growth, research has shown that in countries with higher levels of sound governance in all sectors of society, trade is far more effective at reducing poverty.

In practical terms, promoting intra-African trade and global exports of African goods

means connecting buyers and sellers so that markets can be explored, and products and services can be evaluated and adopted.

In African countries, more attention must be paid to forming strong local and international links and taking the necessary steps to ensure that all potential importers and exporters are fully aware of regulations, legislation and other important factors impacting potential partners.

The Gold price correction, however, appears cushioned by a broad pullback in the US Dollar (USD) alongside the US Treasury bond yields, following the dovish remarks from St. Louis Fed President Alberto Musalem. Musalem said late Monday that "further gradual reductions in the policy rate will likely be appropriate over time," adding that "I will not prejudge the size or timing of future adjustments to policy."

His comments fuelled a fresh leg down in the USD, despite markets ruling out a 50 basis points (bps) Fed rate cut next month.

Markets are currently pricing in about an 86 percent chance that the Fed will opt for a 25 bps rate cut at its next meeting, the CME Group's FedWatch Tool shows.

Looking ahead, speeches from Atlanta

Fed President Raphael Bostic and Fed Vice Chairman Philip Jefferson will be closely scrutinized in the absence of any top-tier economic data releases from the US later on Tuesday.

Traders will also pay attention to the escalating conflict between Israel and Iran, especially after the Iran-backed militant group, Hezbollah, fired dozens of rockets at Israel's third-largest city, Haifa. Meanwhile, the Israeli military has described its recent ground operation in Lebanon as "localized, limited and targeted," but it has steadily increased in scale beginning last week.

Following a gradual decline over the last four days, Gold buyers are seen challenging the key static support of \$2,630.

The 14-day Relative Strength Index (RSI), however, stays well above the midline, currently near 62, suggesting that any decline in Gold price could be likely bought into.

Gold price needs a daily candlestick closing above the strong resistance near \$2,670 to negate the near-term downside pressure. The next resistance is aligned at the re-

Oil edges lower after rallying to highest level

OIL prices edged lower in early Asian trading hours yesterday as traders booked profits after prices rallied to their highest in over a month on Monday amid fears that the Middle East could be on the brink of a region-

Fighting in the Middle East intensified after Iranbacked Hezbollah fired rockets at Israel's third-largest city, Haifa, and Israel looked poised to expand its offensive into Lebanon, a year after the Hamas attack on Israel that sparked the Israel's ongoing war in Gaza.

Brent crude futures fell 23 cents, or 0.3 percent, to \$80.70 per barrel by 0029 GMT. US West Texas Intermediate futures fell 20 cents, or 0.3 percent, to \$76.94

Both contracts rose over 3 percent on Monday to hit their highest levels since late-August, adding to last week's rally that saw them rise by over 8 percent for the biggest weekly gains in over a year.

The rally began after Iran launched a missile barrage on Israel on Oct. 1. Israel has sworn to retaliate and is weighing its options, with Iran's oil facilities considered a possible target.

However, some analysts believe that an attack on Iranian oil infrastructure is unlikely and have warned that oil prices could face considerable downward pressure if Israel focuses on any other target.

Even if an attack targets Iranian oil facilities, there is 7 million barrels per day of spare supply capacity within the Organization of Petroleum Exporting Countries (OPEC) to make up for the loss of its oil output, ANZ Bank analysts noted on Friday.

Israel starts ground operations in Lebanon as Iran delivers warning

BEIRUT/GAZA/JERUSALEM

ISRAEL'S military said yesterday it had begun ground operations in southwest Lebanon, expanding its incursions to a new zone a year after exchanges of fire began with Hezbollah and amid pleas by the UN for a diplomatic solution.

The regional tensions triggered a year ago by Hamas's attack on southern Israel have spiraled to a string of Israeli operations by land and air over Lebanon and direct attacks by Iran onto Israeli military installations.

Iran warned Israel yesterday against any attacks on the Islamic Republic, a week after Tehran fired a barrage of missiles on it, putting the Middle East

Any attack on Iran's infrastructure will be met with retaliation, Foreign Minister Abbas Araqchi said, warning Israel against attacks on his country.

Araqchi will visit Saudi Arabia and other countries in the Middle East starting on Tuesday to discuss regional issues and work on stopping Israel's "crimes" in Gaza and Lebanon, Iran's ISNA news agency reported.

Hamas, which has seen the Palestinian territory of Gaza laid waste by Israel's war, vowed to rise "like a phoenix" from the ashes despite heavy losses from a year of fighting.

The UN agency for Palestine refugees said Monday that the year-long "brutal" war has turned the Gaza Strip into a graveyard for tens of thousands and a sea of rubble.

"Twelve months of brutal war have transformed the Gaza Strip into an unrecognizable sea of rubble and a graveyard for tens of thousands of people, among them far too many children," Philippe Lazzarini, commissioner-general of the United Nations Relief and Works Agency for Palestine Refugees in the Near East (UNRWA), said on social media platform X on the

first anniversary of the Gaza conflict. Stressing that the Middle East is "sinking deeper into conflict, killing, and sheer horrors", he said: "The expansion of the war into Lebanon is wreaking havoc on civilians, many forced to relive traumas of the past."

Hezbollah said it targeted a military base south of Haifa with "Fadi 1" missiles and launched another strike on Tiberias, 65 km away.

They also targeted areas north of Haifa with missiles. Israel's military said around 190 projectiles had entered Israeli territory on Monday. There were at least 12 injuries.

Gulf states have sought to reassure Iran of their neutrality in the Iran-Israel conflict, sources told Reuters last

In Lebanon, the Israeli military piled more pressure on Lebanon's Iranbacked Hezbollah, saying it was conducting "limited, localized, targeted operations" in Lebanon's southwest after announcing such operations for the to respond to Tehran's ballistic mis-

Putin to receive CIS leaders in Kremlin

MOSCOW

RUSSIAN President Vladimir Putin, whose country holds the rotating presidency in the Commonwealth of Independent States (CIS) this year, will receive CIS leaders in the Kremlin in the run-up to the organization's summit.



Prior to the summit, the Russian leader will hold two bilateral meetings - with Azerbaijani President Ilkham Aliyev and Armenian Prime Minister Nikol Pashinyan. Both will focus on normalization of relations between Baku and Yerevan on the basis of the 2020 trilateral agreement.

The bilateral meetings will be followed by CIS talks in narrow and extended formats. The meeting with limited attendance will be held in the format of a free discussion, where every participant will have an opportunity to bring about issues of their highest concern.

During the summit, the leaders will discuss key cooperation tasks of the Commonwealth, as well as topical regional and international problems and outline main areas of work in the future. It is expected that the decision will be made to pass CIS chairmanship from Russia to Tajikistan in 2025.

The leaders are expected to sign a number of important documents. The summit will end with a formal reception for the foreign delegations.

Wrapping up results and drafting future plans

During the meeting in the Kremlin, leaders of CIS countries will conclude results of the Russian presidency in the Commonwealth and outline plans for 2025, aide to the Russian President Yury Ushakov said.

"All the main activities have already been implemented and the forthcoming meeting in the Kremlin tomorrow will become the culmination of the whole our work as the presiding party," Ushakov said. "The Russian president will inform his counterparts about preliminary results of the Russian presidency."

This year, Moscow focused "on tasks of further deepening the comprehensive partnership within the framework of the Commonwealth, increasing efficiency of its activities and strengthening the role and the weight of CIS," the presidential aide continued.

CIS leaders are expected "to conclude results of cooperation within the framework of the Commonwealth in this year and will determine main tasks for 2025," Ushakov added. Furthermore, "current regional international problems and steps to increase the activity of the work of the organization, its executive entities and sectoral authorities" will be discussed.

It is also planned to sign a number of multilateral documents promoting cooperation in the economy, culture, law enforcement, and humanitarian and military spheres, as well as to adopt an Address by the CIS Heads of State to the Commonwealth nations and the world community on the 80th anniversary of the Victory of the Soviet people in the Great Patriotic War of 1941-1945.

CIS Secretary General Sergey Lebedev is expected to brief journalists about the results of the summit.

Awards and decorations of the Commonwealth will be bestowed in connection with the summit, including a honorary certificate that will be handed over to TASS Director General Andrey Kondrashov to mark his "great personal contribution into shaping of the Commonwealth's common information space."

The next official summit of the CIS will take place on October 10, 2025, in Tajikistan's capital Dushanbe.

PM Modi to embark on Laos visit to attend 21st ASEAN-India, 19th East Asia Summits

NEW DELHI

PRIME Minister Narendra Modi will visit Laos from October 10-11, the Ministry of External Affairs said yesterday. The Prime Minister's visit comes at a time when India is marking a decade of the Act East Policy this year.

PM Modi's visit to Vientiane comes at the invitation of counterpart Sonexay Siphandone, Prime Minister of the Lao People's Democratic Republic.

During his visit, Prime Minister Modi will attend the 21st ASEAN-India Summit and the 19th East Asia Summit being hosted by Laos, which is the current Chair of the Association of Southeast Asian Nations.

"India is marking a decade of the Act East Policy this year. Relations with ASEAN are a central pillar of the Act East Policy and our Indo-Pacific vision," the MEA said in an official statement.

The ASEAN-India Summit will review progress of India-ASEAN relations through Comprehensive Strategic Partnership and chart the future direction of cooperation.

Hopfield and Hinton win 2024 Nobel Prize in Physics

STOCKHOLM

SCIENTISTS John Hopfield and Geoffrey Hinton won the 2024 Nobel Prize in Physics for discoveries and inventions that enable machine learning within artificial neural networks, the award-giving body said

The award comes with a prize sum of 11 million Swedish crowns (\$1.1 million), which is shared between the winners if there are several. The physics prize is awarded by the Royal Swedish Academy of Sciences. "This year's two Nobel Laureates in physics have used tools from physics to develop methods that are the foundation of today's powerful machine learning," the award-giving body said in a statement.

Widely considered the most prestigious prize for physicists across the world, it was created, along with awards for achievements in science, literature and peace, in the will of Alfred Nobel.

The prizes have been awarded with a few interruptions since 1901, though the Nobel economics honor is a later addition in memory of the Swedish businessman and philanthropist, who had made a fortune from his invention of dynamite.

Outside the sometimes controversial choices for peace and literature, physics often makes the biggest splash among the prizes, with the list of past winners featuring scientific superstars such as Albert Einstein,

China keeps advancing space exploration technology

AS one of the two operational space stations in the world, the Chinese space station Tiangong weighs over 100 tons and offers more than 100 cubic meters of living and working space, showcasing superior technology

worldwide. "Every small step forward brings us closer to our aspirations. The Chinese space station is always worth looking forward to!" This was the heartfelt exclamation made by Chinese astronaut Liu Yang on September 2, 2022, upon completing her first spacewalk during the Shenzhou-14 mission.

In 2012, Liu made her first journey to space aboard the Shenzhou-9 spacecraft. As she left the Tiangong-1 experimental space lab, she made a wish: "I will definitely come back." Ten years later, Liu realized her dream of "flying to the heavens" once again.

During the Shenzhou-14 mission, Liu and other crew members welcomed the arrival of two lab modules, Wentian and Mengtian. The two modules, together with the Tianhe core module, formed the space station's basic configuration in T shape, demonstrating the ingenious design of the Chinese space station.

Nie Haisheng, another Chinese astronaut who was tasked with three of China's

pioneering spaceflights, has gained new insights and experiences each time. He said that the Chinese space station is continuously enhancing comfort, increasing reliability, expanding living space, and diversifying space food.

"Upon entering the space station, my first impression was how spacious it felt, with a real sense of depth," said astronaut Tang Hongbo.

"My second impression was how quiet the sleeping area was, with very little noise. The third one was that this was truly a 'room with a view," Tang added.

"When I was off work, I would always grab my phone and snap pictures of the stunning scenery outside the window. It's also a unique opportunity to conduct experiments and get firsthand experiences there," Tang said.

China's manned space program has always aimed for world-class standards, working toward major breakthroughs in key technologies.

China has tackled critical technological challenges in space exploration, including space transportation, space extravehicular activity, and space docking. It has independently developed a unique space station robotic arm system that meets mission requirements.

All components and core elements are manufactured

Starting with the launch of the Tianhe core module in April 2021, China completed the comprehensive construction of its space station in less than 20 months, setting a world record for the fastest space station assembly.

China's manned space program has completed what took developed countries half a century in just 30 years, from unmanned flights to manned missions, from single-day solo flights to multi-person extended stays, from in-cabin experiments to extravehicular activities, and from single spacecraft flights to the space station orbiting the Earth.

Behind these achievements lie the collaborative efforts of over 110 research institutes, more than 3,000 scientific research units, and hundreds of thousands of researchers, all working together to drive China's advancements in space.

Equally eye-catching are the applications of space technologies across different industries.

In 2016, during the Shenzhou-11 mission, China cultivated vegetables in space for the first time. Astronaut Jing Haipeng wrote in his diary: "At that time, my fellow crew member Chen Dong and I were both thrilled. We immediately shared this good news with the ground staff. We took many photos and even posed for pictures with the lettuce sprouts.

Six years later, Chinese astronauts celebrated the Mid-Autumn Festival in space for the first time, enjoying fresh lettuce they had grown themselves. "The taste was fantastic," said astronaut Cai Xuzhe.

The primary objective of building spacecraft and space stations is to apply research advancements. In these Chinese national space laboratories, various experiments are underway, with an increasing number of applications successfully transferred and

European leaders call for ceasefire, two-state solution in Gaza conflict

BRATISLAVA

MANY European leaders on Monday called for an immediate ceasefire in the Gaza Strip while repeating their support for the two-state solution.

Since Israel launched a largescale offensive in Gaza to retaliate against a surprise attack by Hamas on the southern Israeli border on Oct. 7 last year, 41,909 Palestinians have been killed, and 97,303 others injured in Gaza, including many children and women, according to health authorities in Gaza on Monday.

On the Israeli side, Hamas' attack has killed over 1,250 Israelis and foreign nationals, with more than 250 people abducted and taken to Gaza. Many Israeli hostages haven't returned yet while some were killed in bombard-

On Monday, the EU's foreign policy chief Josep Borrell described an immediate ceasefire as "the only way" to secure the release of hostages and de-escalate the "dangerous" situation in the Middle East. He reaffirmed the EU's commitment to diplomacy, stating: "The time for a ceasefire is now.'

European Parliament President Roberta Metsola echoed these sentiments, affirming the parliament's unwavering calls for a ceasefire and the release of hos-

UK Prime Minister Keir Starm-



EU leaders came up with a compromise text that condemns Hamas' attack and backs Israel's right to defend itself "in

stopping the "living nightmare" of Palestinians and vowed to use the "power of diplomacy" to minimize their suffering on the ground. German Chancellor Olaf Scholz noted the "violence and hunger" inflicted on the Palestinians in Gaza every day.

He said the German government is committed to a ceasefire, the release of hostages, and the advancement of the political process, despite the immense chal-

On social media, Spanish Prime Minister Pedro Sanchez highlighted the shocking toll on civilians from the spiral of violence in Gaza, the West Bank and now Lebanon. He posted:

"The situation is unbearable. The war must end now." Addressing an official ceremony in Rome er stressed the importance of to mourn the victims of the yearlong conflict, Italian Prime Minister Giorgia Meloni noted Israel's legitimate right to defend itself, while stressing the need to perform the right per international humanitarian law. "We cannot remain indifferent to the enormous toll of innocent civilian victims in

Gaza," she said. Also on Monday, Slovenian Prime Minister Robert Golob blamed the Israeli army for "one of the largest massacres we know in our times," condemning the killing of civilians as disproportionate to the right to selfdefense, and calling for stronger international intervention.

Many European governments, including the UK, Germany, and Spain, also reaffirmed their support for a two-state solution. Starmer said a two-state solution is "the only viable long-term

route through" the conflicts in the Middle East.

Countries such as Norway, Ireland, and Spain have officially recognized Palestine, following the example of several other EU members, though major powers like France and Germany have yet to do so. However,

Scholz said on Monday, in the end, a two-state solution is the only way to a peaceful coexistence of Israelis and Palestinians.

PRO-PALESTINE PROTESTS

Since the weekend, Europe has seen waves of protests demanding an immediate ceasefire in the Middle East. In Britain, multiple demonstrations took place in several cities, with 17 arrests made after a pro-Palestinian march in London on Saturday.

In Rome, several thousand pro-Palestinian demonstrators gathered on Saturday without official authorization. Clashes broke out between some protesters and police, causing some 30 law enforcement officers and three demonstrators to be iniured.

Also on Saturday, thousands of people held a demonstration in Warsaw, the capital of Poland, chanting slogans like "Stop Israel's death machine!" Similar protests also took place in other Polish cities and Latvia's capital Riga. And on Monday, protests were held in front of Romania's Parliament and in Valletta, Malta.

Ethiopian parliament appoints FM as new president

ADDIS ABABA

THE two houses of the Ethiopian parliament on Monday appointed Foreign Minister Taye Atske Selassie as the new

The appointment followed the end of the term of current President Sahle-Work Zewde after six years of service as the country's head of state. The newly-appointed president was sworn in on Monday before members of Ethiopia's House of Peoples' Representatives (HoPR) and House of Federation as the new leader of Africa's second most populous nation.

With a diplomatic career spanning three decades, including his role as Ethiopia's permanent representative to the United Nations, Atske Selassie has served as the country's foreign minister since February this year until his new appoint-

Prior to his appointment as the country's foreign minister, he also held the position of foreign policy adviser to Prime Minister Abiy Ahmed. Zewde was elected as Ethiopia's first female president in October 2018.

In his acceptance speech following his appointment, Atske Selassie expressed his strong commitment to serving Ethiopia and its people, with a particular focus on fostering national unity and togetherness. "Deep foresight and patience are the poles of Ethiopia's endurance.

Hence, it is necessary to move forward by moving away from distractive ideas,' he told members of the Ethiopian parliament. He further stressed the collective responsibility to maintain national harmony to tackle socioeconomic and governance challenges while preserving recent positive achievements.

Atske Selassie also called on Ethiopians from all walks of life to exert concerted efforts towards the realization of the country's development aspirations.

Addressing a joint session of the two houses, Atske Selassie said the government is striving to achieve 8.4 percent economic growth in the current fiscal year starting on July 8.

To reach this goal, efforts are being made to address foreign currency shortages, curb inflation, and build a resilient agricultural sector that can withstand



the impacts of climate change. He noted that Ethiopia achieved 8.1 percent economic growth last fiscal year, significantly reducing inflation and creating job opportunities for over 4 million people.

"The government will focus on expanding mechanized agriculture, creating a favorable investment climate, substituting imported commodities, implementing macroeconomic reforms, and improving tax and non-tax collections to meet the target," the new president said.

Atske Selassie also highlighted Ethiopia's deepening diplomatic relations with China, which have been elevated to an all-weather strategic partnership.

He emphasized that Ethiopia's engagement with China continues to gain momentum. He also said that Ethiopia's diplomatic influence in multilateralism has strengthened with its recent entry into the BRICS mechanism earlier this year.

Ethiopia, which operates under a parliamentary political system, grants its president largely ceremonial powers.

These include granting amnesty to prisoners, officially opening the annual sessions of the parliament's two houses, receiving foreign ambassadors, and presenting the country's annual objectives to the parliament.

In contrast, the prime minister serves as the head of government, with the party or coalition holding at least 51 percent of the seats in the HoPR, the parliament's lower house, forming the government.

South Korean envoy lauds growing India-South Korea ties

SOUTH Korean Ambassador Chang Jae bok yesterday expressed confidence that India-South Korea relations will strengthen further through cultural and peopleto-people exchanges while indicating high-level visits between the two nations in the near future.

However, he declined to provide further details about the anticipated "high-

Speaking to ANI, the ambassador highlighted the crucial role of cultural exchanges in bringing the two nations closer.

"Based on the people-to-people exchanges and culture, the relations between our two people, the relations between India and Korea, will increase and will be strengthened further. So we hope that high-level exchange of visits will be realised very soon," Chang Jae bok said.

When asked whether any high-level visit is being planned between the two nations, he refused to give details.

The ambassador was the chief guest at the Hangeul Day celebrations at Apeejay School, Panchsheel.

Hangul Day is celebrated October 9th

in Korea to honor the institution of the Korean writing script, hangul by King Sejong in 1446.

The ambassador was impressed by the performances of the students, noting their enthusiasm for Korean culture.

"I was touched by the school's warm welcome and amazed by the students' enthusiasm for Hangeul and Korean culture," he said.

On the ongoing conflict in West Asia, the Ambassador acknowledged India's significant influence, particularly in West Asia, and stressed the importance of close cooperation between the Korean and Indian governments moving forward.

"So we looking forward to the close cooperation with India, government (on the matter)," he said.

The night economy is an important part of urban commerce. In China, the booming night economy has evolved from traditional night markets centered around dining and shopping to integrated hubs for culture, tourism, and entertainment.

Night economy thrives across China Cities across the country are

striving to boost nighttime cultural and tourism consumption and offer a wide range of nighttime activities in line with local conditions, injecting fresh energy into the consumer market.

For instance, the 5th Tianjin Nighttime Life Festival was recently held in north China's Tianjin municipality, including over 100 events integrating shopping, tourism, culture, and sports.

In Shenyang, capital of northeast China's Liaoning province, the First Traditional Chinese Medicine (TCM) Culture Night Market was launched, where people could learn traditional Chinese fitness exercises like Baduanjin, Wuqinxi, and Tai Chi from experts.

Shijiazhuang, capital of

north China's Hebei province, has integrated business models such as nighttime entertainment, tourism, and sports, providing a range of sports activities for its residents.

Apart from diverse and vibrant urban nighttime activities, the night economy in Chinese rural areas also has its unique appeal.

For example, in Wangjiazhuang village, Lingtai county, Pingliang, northwest China's Gansu province, people came together for vibrant bonfire parties and village basketball competitions, also known as "CunBA" usually held after sun-

Local farmers in Shuijing village, Zhenning county, Anshun, southwest China's Guizhou province, tapped into the beauty of a vast lotus pond to attract visitors to come and inevitably face disturbances appreciate the lotus flowers while tasting local snacks.

According to Pan Helin, an official with China's Ministry of Industry and Information Technology, the Chinese night economy is flourishing with numerous highlights: themed night markets with cultural and creative products and delicious food have enriched the options for nighttime consumption; nighttime bookstores and museums are merging with technology and cultural tourism sectors to create new consumption models. "All these services cater to the unique and wide-ranging demands of Chinese consumers," Pan added.

However, as the night economy develops, residents living near commercial districts

such as nighttime noise, lights, and cooking fumes. While promoting the night economy, regions across the country have improved their management and provided better public services to minimize the negative impacts on the surrounding environment.

For instance, Maoming North Road located in Nanjing West Road business circle in Shanghai's Jing'an district has turned into a pedestrian street every weekend and on all Chinese national holidays. This year, during events like the UEFA EURO football championship and the Paris Olympics Games, some bars and restaurants there were allowed to extend their opening hours from 1 a.m. to 3 a.m. on weekends.

It is reported that relevant

local government departments have reached agreements with nearby businesses and shop owners on the allocation of outdoor business areas, maintaining consistent LED brightness levels and prohibiting outdoor loudspeaker advertisements at night. In addition, the property management company of the pedestrian has set up a selfregulating committee for shop owners to oversee and enforce these regulations.

The Chinese night economy is developing in tandem with new business forms such as on-demand retail and community e-commerce, better meeting consumers' nighttime consumption needs.

"I was worried about my child getting cold while swimming at night, so I ordered a few cups of hot ginger tea and

some snacks. To my surprise, they arrived in just over 10 minutes," said Yu Mengying, a resident in Lianyungang, east China's Jiangsu province, who was unfolding a picnic blanket on a beach.

"Now we can travel light as we don't need to take too many things with us. We can place orders on our phones anytime, and the delivery is fast," she

New technologies like big data have also improved the management and service quality of the Chinese night econo-

At the Caita night market in Shenyang, a market regulation enforcement officer was checking food vendors using a smart monitoring platform while recording his findings on a mobile application. The inspection was completed in just

Sean Combs' mother breaks silence: 'My son is not the monster they have painted him to be'

SEAN Combs' mother, Janice Smalls Combs, says she is "devastated" by the "narrative created out of lies" about her son, likening the fervor surrounding the Bad Boy Entertainment founder to a "public lynching."

The 83-year-old released a statement in defense of Combs on Sunday night – her first public comments since Combs' barrage of civil lawsuits last fall and his arrest on sex trafficking and racketeering charges in September.

Combs begged the world to "not judge" her son before hearing "his side" and claimed prosecutors used Combs' settlement with exgirlfriend Casandra "Cassie" Ventura "as an admission of guilt" to build a federal criminal case against him.

"My son is not the monster they have painted him to be, and he deserves the chance to tell his side," Janice's statement read. "I can only pray that I am alive to see him speak his truth and be vindicated."

Combs is being held without bail after he was arrested in New York City on Sept. 16. He is appealing the judge's decision, with the next court date set for Thursday. While a trial looms, he is also facing nearly a dozen civil lawsuits brought against him by several women and one man who claim Combs sexually assaulted them. The alleged encounters date back from 1990 to as recently as this summer.

Last week, Houston attorney Tony Buzbee announced in a press conference that he was representing upward of 120 accusers – both men and women – who say they have sexual abuse claims against Combs and his associates. Buzbee said 25 of the accusers were minors at the time of the alleged abuse – including a nine-year-old boy who claims he was forced to perform oral sex on Combs after auditioning for the iconic record label.

In her statement, Janice Combs broadly labeled these claims as "lies" that are "motivated by those seeking a financial gain, and not justice." "These individuals saw how quickly my son's civil legal team settled his exgirlfriend's lawsuit, so they believe they can receive a quick payday by falsely accusing my son," she added.

"False allegations of sexual assault thwart true victims of sexual violence from getting the justice they deserve." (Combs' lawyer, Erica Wolff, said Combs "emphatically and categorically denies as false and defamatory any claim that he sexually abused anyone, including minors.")

Janice acknowledged that Combs wasn't perfect and "made mistakes in his past," referring to unearthed hotel surveillance footage that showed Combs violently stomping on Ventura before dragging her back toward his hotel suite.

"My son may not have been entirely truthful about certain things," she wrote. "Sometimes, the truth and a lie become so closely intertwined that it becomes terrifying to admit one part of the story, especially when that truth is outside the norm or is too complicated to be believed."

*Janice Smalls Combs' Full Statement

"I come to you today as a mother that is devastated and profoundly saddened by the allegations made against my son, Sean Combs. It is heartbreaking to see my son judged not for the truth, but for a narrative created out of lies. To bear witness what seems to be like a public lynching of my son before he has had the opportunity to prove his innocence is a pain too unbearable to put into words. Like every human being, my son deserves to have his day in court, to finally share his side, and to prove his innocence.

"I am not here to portray my son as perfect because he is not. He has made mistakes in his past, as we all have. My son may not have been entirely truthful about certain things, such as denying he has ever gotten violent with an ex-girlfriend when the hotel's surveillance showed otherwise.

"Sometimes, the truth and a lie become so closely intertwined that it becomes terrifying to admit one part of the story, especially when that truth is outside the norm or is too complicated to be believed. This is why I believe my son's civil legal team opted to settle the ex-girlfriend's lawsuit instead of contesting it until the end, resulting in a ricochet effect as the federal government used this decision against my son by interpreting it as an admission of guilt.

"It is important to recognize that none of us, regardless of our status, are immune to fear or mistakes. Not being entirely straightforward about one issue does not mean my son is guilty of the repulsive allegations and the grave charges leveled against him. Many individuals who were wrongfully convicted and later exonerated had their freedom taken from them not because they were guilty of the crimes they were accused of, but because they didn't fit the image of what this society considers to be a 'good person.' History has showed us how individuals can be wrongfully convicted due to their past actions or mistakes.

"Watching the world make jokes and laugh at my son's life crumbling before our eyes is something I can never forget. It is truly agonizing to watch the world turn against my son so quickly and easily over lies and misconceptions, without ever hearing his side or affording him the opportunity to present his side

"These lies thrown at him are motivated by those seeking a financial gain, and not justice. These individuals saw how quickly my son's civil legal team settled his ex-girlfriend's lawsuit, so they believe they can receive a quick payday by falsely accusing my son. False allegations of sexual assault thwart true victims of sexual violence from getting the justice they deserve.

"To make matters worse, the federal government is now using these lies to prosecute my son. This injustice has been unbearable for our family. The worst part of this ordeal is watching my beloved son be stripped of his dignity, not for what he did, but for what people choose to believe about him.

"I ask his supporters, fans, colleagues, friends, and the public to not judge him before you've had the chance to hear his side. I beg you to think about those who have been wrongfully persecuted, to remember that not everyone who has made mistakes in life deserves to have their entire existence judged by a single action or a few mistakes.

"My son is not the monster they have painted him to be, and he deserves the chance to tell his side. I can only pray that I am alive to see him speak his truth and be vindicated." **RollingStone**

Michael Jordan and Front Row's Bob Jenkins standing firm in their fight against NASCAR

MICHAEL Jordan arrived at Talladega Superspeedway about 30 minutes before the start of the playoff race and made his way directly to Bubba Wallace's pit stand for a quick visit with his guys.

The NBA great eventually made his way down pit road to Tyler Reddick's stand, where he sat on the wall and waited for Front Row Motorsports owner Bob Jenkins. Both NASCAR team owners have refused to sign NASCAR's charter agreement and last week filed a federal antitrust lawsuit against the stock car series.

The brief exchange Sunday was planned as a show of solidarity by the only two teams that chose not to accept NASCAR's terms for its new revenue-sharing model. 23XI Racing and Front Row want a jury to decide if NASCAR is, indeed, "monopolistic bullies" as the suit alleges.

Jordan said before the race the lawsuit is on behalf of all Cup Series teams; 13 organizations signed the charter agreement, with 23XI and Front Row the only holdouts. Many team owners have said they signed on deadline and under threat of having the entire charter system revoked.

"I think everybody should have an opportunity to be successful in any business and my voice is saying it hasn't been happening," Jordan told Fox Sports.

He said he had no intention of speaking with NASCAR chairman Jim France, who is named in the suit, while in Talladega over the weekend.

The legal battle has become the biggest talking point in NASCAR in the middle of its playoffs as the entire industry waits to see what happens next. NASCAR has declined to comment and France declined to discuss it at Talladega. NASCAR's court response could come as early as this week ahead of Sunday's playoff elimination race at Charlotte Motor Speedway.

Michael McDowell, who won the pole for Sunday's race for Front Row, defended Jenkins' decision to battle NASCAR. McDowell decided months ago he was leaving the team he's driven for since 2018 at the end of the season, but is supportive of what Jenkins and 23XI are trying to

"Bob Jenkins is so dedicated to this sport," McDowell said. "He has spent millions and millions and millions and millions of his own dollars to be in this sport and to be competitive. Nobody does that unless they're insane or super passionate.

"He's passionate about our race team and being competitive. It's been a steady progression and I feel like we're at a point now where we're a contender," McDowell continued. "There is nobody spending what we spend and performing how we perform. Nobody. And if he has to spend his own money, there is a problem."

Denny Hamlin, who co-owns 23XI Racing with Jordan and Curtis Polk, also defended taking the fight to court.

"It's been stated in statements by Michael Jordan that he loves NASCAR," Hamlin said. "We've obviously invested heavily in NASCAR and reinvested what I got out of this sport as a driver back into it as an owner. Certainly, we love the sport, just would love to see change as well."

Asked if he thinks NASCAR has any appreciation for what Hamlin – who as a Charlotte Hornets season ticket-holder developed a relationship with Jordan and then persuaded Jordan to start a NASCAR

team with him – and 23XI have done for the sport, Hamlin took a long pause.

"Probably not," he finally answered.

Jordan is the highest-profile team owner in NASCAR, and one of only two who are Black. 23XI also has one of the most diverse teams in the garage, from driver Wallace to crew members and non-competition employees.

The lawsuit has raised another concern around the garage: Team owner Richard Childress said he was not sure if the agreement he signed is the same terms that, say, Hendrick Motorsports received – and if 23XI and Front Row eventually reach an agreement with NASCAR will organizations that have already signed be guaranteed the same terms?

"I don't know what's going to happen because it's just so unprecedented in our sport," Trackhouse Racing owner Justin Marks said. "There's no historical precedent. I think in other cases like this, in other sports, you have collective bargaining unions. So it's just a very, very different setting. I think we have a blank slate and we can land anywhere. I think whatever comes out of this, I have to believe that it should affect everybody the same."

Will global soccer be reshaped after EU's top court issued a major ruling in Lassana Diarra case?

THE global soccer transfer market, worth more than \$10 billion each season, is facing a revolutionary overhaul or a nuanced evolution following last week's ruling by the European Court of Justice in the Lassana Diarra case.

By ruling that some FIFA regulations on player transfers are contrary to EU legislation relating to competition and freedom of movement, the bloc's top court has paved the way for deep changes in the sport's economy.

Here is a look at the key elements of the case and the possible impact of the landmark ruling.

*Who is Lassana Diarra?

Lassana Diarra (pictured) is a former much-traveled footballer whose career saw him play for prestigious clubs such as Chelsea, Paris Saint-Germain and Real Madrid. He represented France 34 times. At one point in his career, Diarra moved to the Russian league. It's a dispute with Lokomotiv Moscow that triggered the legal case examined by the European Court of Justice (ECJ).

*How did we get there?

Diarra signed a four-year contract with Lokomotiv in 2013. The deal was terminated a year later after he was unhappy with alleged pay cuts. Lokomotiv applied to the FIFA dispute resolution chamber for compensation and the player submitted a counterclaim seeking compensation for unpaid wages. The Court of Arbitration for Sport found the Russian club terminated the contract "with just cause" and the player had to pay 10.5 million euros (\$11.2 million). Diarra said his search for a new team was hampered by FIFA rules stipulating that any new club would be jointly responsible with him for paying compensation to Lokomotiv.

*Why does the court believe FIFA rules are in breach of EU law?

Free movement is a fundamental right of workers in the European Union within the single market. On that basis, the EU's top court said that the FIFA rules, including the one that resulted in the refusal to provide Diarra with an international transfer certificate (ITC) for a move to Charleroi, restricted his freedom of movement.

The court also found that FIFA regulations breached the bloc's competition law because they aim at restricting and preventing "cross-border competition which could be pursued by all clubs established in the European Union."

*What is the next legal step?

The ECJ ruling will now be referred back to the appeal court in Mons, Belgium, which will rule on the Diarra case. This could take years rather than months. Although FIFA said it was satisfied "that the legality of key principles of the transfer system have been reconfirmed," Diarra's lawyers claimed "total victory."

The judges in Luxembourg acknowledged having stability in player rosters and regularity in competitions are legitimate objectives for FIFA, but that rules must be applied proportionally.

*Is the Diarra ruling comparable to Bosman?

Some analysts have compared it to the ECJ's 1995 decision on Belgian Jean-Marc Bosman. That ruling removed restrictions placed on foreign EU footballers within national leagues and allowed players in the bloc to move to another club for free when their contracts ended. Those principles had an obviously wider focus than the narrower scope of Diarra, about terminating a contract for cause

For now, the decision on Diarra does not change how the transfer market functions. But many legal experts believe that the ruling will ultimately have major effects on the sport's economy.

"The decision essentially says the current system is too restrictive and so will have to change," said Ian Giles, a partner at Norton Rose Fulbright law firm. "It's entirely possible this means players will feel they can now break contracts and sign on with new clubs, without the selling club being able to hold them or demand significant transfer fees. This will likely result in reduced transfer fees and more economic power for players – but over time things will have to stabilize to allow clubs to remain economically viable."

It took more than five years after the Bosman ruling for updated FIFA transfer rules to be published in 2001. Some of those debates then will now be revisited.

*Effect on the European soccer industry

A major reset of transfer fee values can seriously affect many smaller market clubs. Bosman already accelerated gaps in wealth and competitive balance across European soccer, which is increasingly dominated by a small group of clubs. They can lure free-agent players with higher signing bonuses and salaries - money that previously would be more widely distributed via transfer fees.

Spending by super-wealthy clubs can still reward smaller ones who excel at investing time and expertise in scouting and developing local and global talent: Ajax, Brighton, Genk in Belgium, which nurtured Kevin De Bruyne, Thibaut Courtois and Leandro Trossard.

The influential European Club Association, which represents more than 700 teams, sees potential threats to the industry's health in the fallout from Diarra. Transfer fees and payments to clubs from former players being sold later in their career "are an efficient and effective means of wealth distribution from bigger clubs to smaller ones," the ECA noted.

*Lawfare against FIFA

The soccer industry is increasingly a game being played by lawyers in courts and government offices.

FIFA is being challenged in several legal arenas, in part because it works (Diarra, Super League, agents regulations). There is also a growing perception FIFA does not listen before launching projects and that protransparency reforms demanded and passed a decade ago are in decline.

Within hours of the Diarra ruling Friday, the group of domestic leagues and player unions announced a news conference in Brussels for Oct. 14 to explain their filing to the European Commission. The complaint on competition law grounds argues FIFA adds new and bigger tournaments to the congested calendar without proper consultation.

European Leagues and FIFPRO once had a seat at FIFA's Football Stakeholders Committee that was a key forum for debate, including on the transfer market. FIFA paused the panel in 2021 and soon its president Gianni Infantino pushed for playing World Cups every two years. The idea was resisted by a widespread backlash. The leagues group says the Diarra ruling shows how representation at FIFA is "becoming legally essential."

FIFA had indicated before Friday it would consult widely on transfer market reforms it believes can focus on specific issues raised by Diarra, rather than a total overhaul.

Diarra's lawyer Jean-Louis Dupont – who also represented Bosman 30 years ago – sees a bigger picture. He appeared to be recruiting for a wider suit against FIFA by claiming "all professional players have been affected by these illegal rules" and could now seek compensation.

Man City v Premier League legal case verdict - what it all means

THE verdict has been announced in Manchester City's legal case against the Premier League over the league's rules on commercial deals

involving clubs' owners.
City, who are owned by the Abu
Dhabi-backed City Football Group,
had some complaints upheld, with
two aspects of the associated party
transaction (APT) rules deemed unlawful by a tribunal.

But the Premier League says the tribunal rejected the majority of Manchester City's challenges and "endorsed the overall objectives, framework and decision-making of the APT system".

APTs are aimed at the value of sponsorship deals with companies linked to clubs' owners.

This case is not directly related to the Premier League disciplinary commission which will hear 115 charges against City for allegedly breaching its financial regulations, some of which date back to 2009.

The tribunal - in a 175-page document - ruled that shareholder loans should not be excluded from the scope of APT rules and that some amendments made in February by the Premier League should not be retained.

In this arbitration process, Chelsea, Newcastle and Everton all acted as witnesses for City.

Witnesses for the Premier League included Manchester United, Liverpool, Arsenal, Tottenham, Brighton and West Ham.

Brentford, Bournemouth, Fulham and Wolves wrote letters in support of the rules.

BBC Sport has asked all the clubs mentioned for comment and none have yet responded.

Simon Leaf, partner and head of sport at law firm Mishcon de Reya, told BBC Sport: "Whilst the decision will be embarrassing for the Premier League, because in a couple of narrow areas their rules have been found to be unlawful, generally speaking the decision confirms that the vast majority of the APT rules are indeed lawful.

"Therefore whilst we can expect to see some changes to the rules going forwards, on the whole this isn't a resounding victory for Manchester City by any stretch of the imagination"

The Premier League has called a meeting for next week to discuss the implications of the judgement.

*How did we get here?

APTs are commercial deals involving clubs and companies to which they have close ties. Restrictions on fair market values (FMVs) were introduced in December 2021, shortly after a Saudi-led takeover of Newcas-

The Premier League has the right to assess the value of such deals to ensure they have not been inflated, which could give clubs more to spend under current financial rules.

The rules were changed following a vote in February that was not unanimous. Twelve clubs voted to change the rules, with two abstaining and six voting against the changes.

Those rule changes involved amendments to the definition FMV, and shifting the burden of proof to a club to show a transaction is at fair market value.

The BBC reported in June that City were due to face the Premier League in a legal battle.

The Premier League and Manchester City both said they welcomed the tribunal findings announced on Monday, with each side focusing on the elements in their favour.

*What the Premier League says... The Premier League's statement said that City "brought a wholesale challenge" to the APT rules and were "unsuccessful in the majority" of the

challenge.

It added the tribunal deemed the APT rules to be necessary and that if prices above fair market value were paid then "competition will be distorted as the club would be benefiting from a subsidy".

The league also said the tribunal had "rejected Manchester City's argument that the object of the APT

rules was to discriminate against clubs with ownership from the Gulf region".

Its statement also said that, except in the two respects where City won, the tribunal found that City's arguments were "unfounded, including on any alleged inconsistency in approach as between certain types of clubs".

*What Manchester City say...

City's statement focused on the two areas where they won, as the club claimed the "Premier League was found to have abused its dominant position".

It said the club had "succeeded with its claim" and that "the APT rules were found to be unlawful".

City added that the tribunal found "both the original APT rules and the... amended... rules violate UK competition law... and the requirements of procedural fairness".

The Premier League champions said the rules were found to be "discriminatory... because they deliberately excluded shareholder loans".

And the club added "there was an unreasonable delay in the Premier League's fair market value assessment of two of the club's sponsorship transactions".

*What's next?

The Premier League says it will look to change the two aspects that the tribunal ruled against the league on.

That means integrating the tribunal's assessment of shareholder loans and removing some of the February amendments.

It says it is "conducting a process that can allow the league and clubs to enact those specific changes quickly and effectively".

*'Concerns that clubs could be hit with additional costs'

Both sides are claiming victory, and in truth the judgement contains something for both City and the Premier League.

League sources are emphasising the fact that most of City's challenges to the APT rules failed, and that the wider system was endorsed by the panel.

They also seem confident that the rules will be swiftly amended by the clubs within two weeks in order to

make them lawful.

But the panel's ruling that the exclusion from the rules of interest-free loans from owners to their clubs (shareholder loans) was unlawful, has led to concerns that clubs could now be hit with additional costs that they were not anticipating.

This could mean some are in danger of breaching PSR regulations. The suggestion is that such loans will now be subject to commercial market rates of interest.

That could have major ramifications for those clubs that owe tens (or even hundreds) of millions of pounds to their owners.

The Premier League seems relatively relaxed about that issue, along with speculation that City and other clubs could seek compensation for any losses suffered by the rules.

On shareholder loans, league officials believe a fair market value analysis of such borrowings would be placed on the cost of the loan (i.e. the interest rate), not the value of the loan itself, and that the impact on clubs, therefore, would be minimal.

They also feel that such loans will only come into the scope of APT once the rules are amended, and will not be applied retrospectively, so only future loans will be affected.

However, BBC Sport has learned that City's lawyers believe that not subjecting previous shareholder loans to a Fair Market Value assessment (while continuing to apply it to previous sponsorship deals) would be unfair, and that they may seek an injunction to prevent the Premier League from doing so.

But there will be fears from some in the game that any weakening of APT rules designed to preserve fairness and competitive balance could lead to certain clubs being able to sign more lucrative commercial deals.

There is also the question over whether this could have an impact on the 100-plus charges the league has brought against City for alleged financial rule breaches. City deny wrongdoing, and a hearing into the case continues.

Whatever the consequences, what is clear is that this dispute has reinforced the sense of division among the clubs over the financial regulations they are subject to.

The first is that for the hearing, there were 280 pages of statements and 150 pages of submissions. The second is the verdict itself, which runs to 177 pages.

On pages 161 and 162 of the verdict, eight separate areas in which City have failed in their claim are identified.

However, on page 163, it outlines that declaratory relief, injunctive relief and damages can be sought. This could be a financial problem for the Premier League depending on whether City pursue a claim - which they have indicated they will - and

what the size of it is.

Of even greater issue are the comments on page 164, which point out a number of the Premier League's rules are unlawful as they don't include shareholder loans. It is this which forms the basis of City saying the Premier League has "violated UK competition law".

In order to change the rules, the Premier League will need 14 clubs to vote in favour. However, some of the clubs benefit from shareholder loans at preferential (or non-existent) rates. Getting the rule changes required may not be straightforward.

It is also the second time in just over a month that issues with wording within Premier League regulations have been highlighted after Leicester had their financial regulations breach charge thrown out.

That regarded an issue surrounding whether they were a top-flight club on the 30 June reporting date, in a season where they competed in the Premier League but were relegated (before 30 June).

The Premier League feels it is OK after this latest decision because of the number of allegations dismissed but it remains to be seen whether their calm reaction is justified.

The fierce manner in which City have responded to the verdict, allied to the knowledge they are currently fighting the substantive issue of 115 financial charges, which they deny but if found to have breached will be seismic, suggests they have spotted a weakness in the Premier League's regulations and will look to exploit it as far as they can.

Simba aim for top spot in CAF Confederation Cup Group A

SIMBA Sports Club have learned their group-stage opponents for the CAF Confederation Cup (CAF CC) following the recent draw conducted by the Confederation of African Football (CAF).

The Tanzanian giants will compete in Group A alongside Tunisia's CS Sfaxien, Algeria's CS Constantine, and Angola's FC Bravos.

The competition in Group A is expected to be fierce, particularly from CS Sfaxien, a club with a rich history in African football. Sfaxien have made multiple appearances in the CAF Confederation Cup group stages and won the title three times, with their last triumph

Despite facing challenges in recent years, the Tunisian side remains determined to restore their former glory and will pose a significant threat to Simba's ambitions.

CS Constantine, representing Algeria, are another seasoned competitor in continental football. The club has participated in both the CAF Champions League and the CAF Confederation Cup on several occasions.

Tanzania's national football team is aiming to secure a spot in the prestigious tournament, set to take place in Morocco next year.
