MPANDA Municipal Council in Katavi Region has resolved that all secondary school female students within the municipality as well as those in standard five and six be subjected to mandatory

The decision was made at the weekend during a council meeting after it emerged that 18 students from two secondary schools within the municipality were found to be pregnant.

Earlier, before the decision was reached, the chairman of the Council HIV/Aids Control

Committee Lucas Kanoni underlined that child pregnancy is still a big challenge in the municipality.

He said in a period of three months a total of 18 students from two secondary schools were examined and found to be three months

Kanoni said girl students from Kashaulili and Kasimba secondary schools were examined and it was revealed that in the case of Kasimba Secondary School 15 students were pregnant while in Kashaulili three were pregnant.

Minister: JPM was misled on state of Mvomero farm

LAND officials are reported to have misled President John Magufuli in an assessment report on investment in a farm that they recommended be retaken by the government because it was not developed.

A statement released by the Ministry of Lands, Housing and Human Settlements Development at the weekend quoted minister William Lukuvi (pictured) as saying that before signing the reacquisition of the 1,000-acre farm located in Mvomero District, Morogoro Region, the president



sought to establish the accuracy of the report and found out that it was misleading.

Speaking in the district yesterday, Lukuvi said the president realized that the parcel investor, one Cecilia Rusimbi is now free to continue developing it.

"The decision by President Magufuli not to retake the land comes after he realized that the recommendation made by land officers who claimed that the farm undeveloped was not true," the minister announced.

Reacting at the information, Rusimbi expressed her relief, saying the intervention by the president

has prevented injustice from taking place. "I purchased and made investments on the farm since 1987 and was shocked to learn that my parcel was lined up for retaking by the government," she said.

Lukuvi called upon land officers in the country to be prudent when assessing development on

Municipal Mayor Willy Mbogo said the problem of child pregnancy is serious in Mpanda Municipality, a situation that cannot be tolerated as it is shameful.

He directed the Secondary Schools Education Officer to come up with a report of steps taken on the people who impregnated the students.

Mbogo said recently teachers of Majengo Primary School discovered that one of the students was pregnant and upon questioning she said she was impregnated by her own father. Hence

they took the culprit to court, where he was found guilty and jailed for life.

Mpanda District Education Officer Emeriana Tungulu said the main challenge from students found pregnant is that they never speak the truth when called to mention persons who impregnated them, saying they do not know who it was.

In addition some of them have been saying they met only once with the persons responsible for their pregnancies and do not know where

Another challenge is noncooperation by parents when needed to do so.

609,502 students begin Form **II National Mock Exams today**

FORM Two National Mock Examinations start today countrywide and will end 22 November in which 609,502 students from 4,796 secondary schools are expected to take part.

Speaking to reporters in Mbeya, Executive Secretary of national examinations Council of Tanzania (NECTA) Dr Charles Msonde said out of these candidates, 288,925 are boys and 320,577 girls - about 52.6 percent.

He said candidates with special needs number 1,044 of whom 396 have poor sight, 70 totally blind, and 347 with hearing impairment and 231 have body disabilities.

"This year there have been an increase of 64,636 candidates or 11.6 percent compared with last year and we expect the exams will be done in accordance with the laid down rules and procedures," said Dr Msonde.

Dr Msonde also said that 1,783,638 are expected to sit fort National Standard Four Mock Examinations from November 20 up to 22 this year and that the figure is the biggest of all

He said out these examinees boys number 901,786 (50.56 percent) and girls 881,852. He said the increase is due to parents mobilization to take their children to school following the government policy of free education.

He said examinees with special needs are 3,978 of whom 735 with poor sight, 102 with total blindness, 887 with hearing impairment and 2,254 with body disabilities.

Dr Msonde said the statistics show that the number of boys who will sit for the National standard Four Mock Examinations is the same to the number of all students who sat for Std 7 National examinations and this success is is due to free examination in primary education.

On the national Form IV Examinations that are ongoing Dr Msonde said up to now students have done exams in 17 subjects including seven that are a must and all the remaining are not mandatory.

He said since the start of the examinations there have not been any reports on cheating, quite different as it used to be in the previous years.

government officials and promised to support government initiatives.

He said MPs were taken through various law and regulation reforms aimed at ensuring that ownership of minerals is in the hands of Tanzanians.

In August, the government announced the intention to start exporting fully refined gold in two months time, upon completion of a gold refinery, the first ever in the country.

Currently gold in the country is refined to between 70 and 85 percent but with the coming of refineries, one in Dodoma and another in the Lake Zone, the mineral will now be refined up to 99.9 percent.

"According to section five of the Minerals Act 2010 as amended in 2017, minerals are in the hands of the public under the custodianship of the president," he pointed out.

The minister asserted that the management of minerals was left to the ministry and its departments but now a mining commission has been formed to oversee those duties as performed by the ministry.

The government has done a lot to empower small scale miners as in the recent past about 36 small scale miners have been connected with electricity, he added.

China offers EAC 12 cars worth US\$400,000

CHINA has made a commitment to give the East African Community 12 cars worth US\$400,000 to be used in various capacity building programmes at the East African Community (EAC).

the announcement, Liang Lin, the Political Counselor at the Chinese embassy in Dar es Salaam, said that China was keen on working with the EAC in, among other fields, education, infrastructure development, trade, prevention of Ebola, peace and security, and capacity building initiatives.

Lin, who paid a courtesy call on the EAC Secretary General, ambassador Liberat Mfumukeko, at the EAC Headquarters in Arusha, disclosed that China was working on infrastructure projects that would promote connectivity across the entire African continent including road and railway networks, adding that other areas were developing hydropower, power transmission and expansion of

The Chinese envoy further said that amb. Liberat Mfumukeko expressed his China would also assist in building industrial parks in the EAC Partner discussions on the EAC initiative on bamboo farming in the region.

He revealed that plans were underway to implement infrastructure development projects worth US\$16 billion to be implemented over a three period on the entire African continent courtesy of the 2018 Beijing Summit of the Forum on China-Africa Cooperation.

On capacity building, Lin said China would be providing 50,000 scholarships to African countries and urged EAC to tap into these study opportunities.

Speaker Ndugai calls for maximum cooperation and support for CAG

SPEAKER of the National Assembly, Job Ndugai has called on members of the parliamentary oversight committees to show their maximum cooperation to the newly appointed Controller and Auditor General (CAG), Charles Kichere.

The oversight committees include Public Accounts Committee (PAC), Local Authorities Accounts Committee (LAAC) and Public Investments Committee (PIC)

Speaker Ndugai made the remarks over the weekend during the official opening of a one-day workshop on 'Accountability and Transparency in Open Contracts' for Parliamentary Oversight Committee members organized by WAJIBU - Institute of Public Accountability.

In his address, Speaker Ndugai informed committee members that the new CAG, Charles Kichere, who was appointed by President John Magufuli on 3rd November, 2019 and sworn in on the next day, would be reporting to the parliamentary office on Monday, 11 November 2019 (today), for an official introduction.

"This appointment opens a new chapter between us and the office of the CAG. I know Mr. Kichere very well. I believe that he is coming do his job with open arms, and we will work together professionally. I would therefore like to request you honorable members to receive and show him you're best of support," said Speaker Ndugai.

He further commended WAJIBU Institute under the leadership of its Executive Director, Ludovick Utouh, who also happens to be a retired CAG, for organizing the timely training for members of the parliament.

"In national matters such as planning and production, the process of procurement cannot be avoided. I therefore believe that through this training on accountability and transparency in open contracts, the understanding of committee members on public procurement processes will be broadened, which will ultimately for the EAC political confederation assist them in overseeing this sector

Ndugai also proposed reforms in the controlling and auditing of the public sector, insisting particularly on the timely receiving of reports and investing more on the aspect of control.

"Parliament is supposed to deal with current and hot issues. We should therefore look into how we can catch up with the circle of public expenditure so members attended the conference.

that we are not left behind," he said.

In addition, Speaker Ndugai said that the office of the CAG and Parliament have to a large extent exhausted its auditing mandate but lag behind in the aspect of control.

"In our system, the aspect of control is not properly affixed, and so that we move into that aspect, we need to create a conducive environment through the constitution and respective legal frameworks so that our offices can have the clear mandate in doing so," Speaker Ndugai said while referring to cases of other parliaments in the world which have a 'Power to purse' system which allows parliament not only to pass budgets for public institutions but to also refer back to them when the respective institutions want to utilize the money at hand.

"Nevertheless, I understand that this kind of change has to take place gradually, so that we can all reach our targeted objectives," he said.

Meanwhile, the Chairperson for the Public Accounts Committee (PAC), Naghenjwa Kaboyoka said that the training is very beneficial for members of the committees because it allows the respective parliamentarians to understand their duty in overseeing the

"As you may already know, members of our committees are changed after every 2 and half years. Therefore, these kinds of workshops help new members to gain the right knowledge and experience in overseeing the government," said Kaboyoka.

Kaboyoka added that such trainings will help committee members to also understand their legal duty in performing checks and balances, doing away with the misconception that they are here to oppose the government.

"Parliament is supposed to oversee government, and not the government to oversee parliament," she emphasized.

For his part, the Executive Director of WAJIBU Institute, Ludovick Utouh, said that the among the modules that were being addressed in the workshop was transparency and accountability in public procurement act of 2011, open contracts, accountability reports and indicators of corruption in the public sector, and negotiations in procurement in the public sector.

Gender violence still on the rise - minister

DESPITE the efforts to end genderbased violence (GBV) in the country, reported cases of the problem is on the rise, deputy minister for Health, Community Development, Gender, Elderly and Children, Faustine Ndugulile, said here at the weekend.

He said the governing is conducting a study to establish the reasons behind the vice, saying may be public awareness has increased, thus people feel free to report or it is the violence that is on the increase.

Speaking at the opening of seminar organised by the UN Women to Members of Parliament, the government efforts in collaboration with other stakeholders are yielding fruits.

said that the ongoing Не implementation of a strategic plan fight against GBV was yielding positive results.

UN Women in collaboration with the government of Tanzania has helped the country in the fight against Gender Based Violence to women and children, and so far the cases have decreased significantly.

The government is currently implementing a five year strategic plan 2017/ 2018-2021/2022 which aims at seeking all possible solutions on GBV.

UN Women in Tanzania organized a three-day seminar to Members of

Parliament in the country's capital to sensitize MPs so that they can disseminate knowledge to citizens in their respective constituencies, which will get rid of the vice.

Ndugulile underscored the need for MPs to help in burying myths and negative cultural beliefs in the communities that were fueling GBV.

"At least 41,000 cases of GBV were reported in 2017 countrywide and unfortunately the cases were still on the rise especially in Dodoma region, among others" he said.

Among the key issues in the strategic plan is introduction of defence and security committees, one stop centre to deal with GBV issues whereby the centre has police officers, medical practitioners and people offering counseling services.

The minister said the government also introduced paralegals in order to provide legal aid to victims of GBV, and so far, they have helped a lot in bringing perpetrators of the vice to justice.

UN Women governance specialist advisor, Ussu Mallya said in collaboration with the Tanzanian government, said by establishing a dialogue with religious and community leaders, UN Women was determined to end GBV in the country. "UN Women work with the ministry of Justice and Constitution, ministry of Health in a bid to have a friendly environment which will help to end GBV," she said.

THE Kenya Bureau of Standards (Kebs) on Saturday suspended the licences of five maize millers over the sale of substandard flour, hours before the airing of an NTV investigation that reveals how state regulators have let millers flood the market with maize meal contaminated with high levels of cancer-causing aflatoxins.

In a statement, Kebs said it had banned Dola, Kifaru, Starehe, Jembe and 210 maize flour brands as they "do not meet the requirements of Kenyan market standards."

The announcement followed a series of calls to the Nation Media Group regarding the investigation, which is understood to have caused panic

The report, by NTV investigations editor Dennis Okari, airs on Sunday evening.

Two Ugandan businessmen shot dead in Rwanda

THE police in Rukiga District are inand killed in Rwanda about 1km away from the Mpororo border post in Kamwezi Sub County on Saturday night.

The Kigezi regional police spokesperson Mr Elly Maate confirmed the incident saying that they were still compiling information about the incident.

"We have received reports about Ugandan businessmen that were allegedly shot and killed inside Rwanda and we are compiling information about the whole incident," he said. He added that the case has been recorded at Mpororo police post as SD03/10/11/2019.

Mr Ignitius Baketonda the LCII chairperson for Kyabuhangwa parish in Kamwezi Sub County identified the deceased as Job Ebyarishanga and Bosco Tuheirwe, all residents of Nyakabungo village in his parish. "One of the deceased, Tuheirwe is my nephew. I received information at around 9PM that he had been shot and killed together with a colleague inside Rwanda as they tried to smuggle raw tobacco. They were in a group of about five people and the three managed to escape back

Baketonda added that those who he said. vestigating a case in which two Ugan- escaped have already recorded statedan businessmen were allegedly shot ments at Kamwezi Police Post as they wait for the Ugandan security personnel to help them in getting the bodies of the deceased persons for burial.

> The Kamwezi LCIII Chairman Mr Tedson Niwagaba told Daily Monitor that he was in touch with some leaders in Tabagwe village, Nyagatare in Rwanda where the deceased were killed from, to have their bodies handed over to the relatives.

"When I contacted my counterparts in Rwanda they told me that they have two bodies that they found dead in their area and they were still trying to establish their identities. I have reported the matter to the police for further investigations and best way forward," he said.

Mr Niwagaba cautioned traders living along the Uganda-Rwanda border to desist from smuggling goods into Rwanda because it's against the Rwandan laws.

"About two months ago, we conducted sensitisation meetings in the border communities advising them to avoid involving themselves in illegal trade in Rwanda, I am wondering why these Ugandans did not take the advice given

into Uganda. They are the ones that re- to them. Whereas I sympathise with the relatives, the victims were not in order,"

> The Rwandan ambassador to Uganda Mai Gen Frank Mugambage said on Sunday morning that he was not aware of the incident.

On May 2, 2019 a 41-year-old Rwandan businessman Innocent Ndahimana was shot and injured on the right arm by the Rwandan security officials as he tried to smuggle about 500Kgs of beans into Uganda through a porous border point in Rushaki village, Rubaya Sub County in Kabale District.

On May 24, 2019, Alex Nyesiga a resident of the same village and a Rwandan national John Batista Kyerengye, were shot and killed by Rwandan security personnel inside Rwanda has they allegedly smuggled a bale of second hand clothes into their country through Habusavu porous border entry.

On November 4, 2019 a Rwandan national Jean Piere Havugimana, 28, was shot and injured by Rwandan security personnel on the left shoulder inside Rwanda about 300 meters away from the international boundary with Uganda as he tried to smuggle about 50Kgs of Irish potato from Uganda.

Huge chunk of Sao Hill forest destroyed by fire

THE Deputy Minister for Natural Resources and Tourism, Constantine Kanyasu, yesterday visited part of Sao Hill Forest farm in Mufindi district, Iringa Region that has been adversely destroyed by fire.

The blaze that occurred at the weekend in a span of six days has destroyed more than 1,000 hectares of the state owned forest as well as in other adjoining forests owned by other institutions and individuals.

In the state owned forest alone more than 600 hectares of cypress and other kind of trees were destroyed and it is said the fire was caused by the wananchi who were preparing land for farming, and beekeeping. The fire has also caused injuries to one worker of prepare their farms during farming Sao Hill factory as he was engaged in extinguishing the raging blaze.

The blaze also destroyed an Isuzu truck, 24 beehives ,timber, logs and chainsaws that were inside the forest.

Speaking about the blaze, Kanyasu said it has caused about 5b/- loss as well making lives difficult to the wananchi who had farms in the area.

He said last year alone Sao Hill Forest fires destroyed 400 hectares of forest area causing loss of over 1b/- and called the officials of the forest to sell all trees that are 10 to 27 years old and added that this has to be done as quickly as

Vanilla farming is becoming popular, so let us move on...

fruit of the orchid family, the largest family of flowering plants in the world. There are over 150 varieties of vanilla plants. Just like grapes that make wine, no two vanilla beans are the same in flavour, aroma, or colour. Vanilla is still the most favourite ice cream flavour in the US

Vanilla is a flavouring derived from orchids of the genus vanilla, primarily from the Mexican species, flat-leaved vanilla. The word vanilla, derived from vainilla, the diminutive of the Spanish word vaina (vaina itself meaning a sheath or a pod), is translated simply as little pod . Pre-Columbian Mesoamerican people cultivated the vine of the vanilla orchid. Spanish conquistador Hernán Cortés is credited with introducing both vanilla and chocolate to Europe in the 1520s.

Pollination is required to get the vanilla fruit from which the flavouring is derived. In 1837, Belgian botanist Charles François Antoine Morren discovered this fact and pioneered a method of artificially pollinating the plant. The method proved financially unworkable and was not deployed commercially. In 1841, Edmond Albius, a slave who lived on the French island of Réunion in the Indian Ocean, discovered at the age of 12 that the plant could be hand-pollinated. Handpollination allowed global cultivation of the plant.

Three major species of vanilla currently are grown globally, all of which derive from a species originally found in Mesoamerica, including parts of modern-day Mexico. They are V. planifolia (syn. V. fragrans), grown on Madagascar, Réunion, and other tropical areas along the Indian Ocean; V. tahitensis, grown in the South Pacific;

ANILLA is the only edible and V. pompona, found in the West Indies, Central America, and South America. The majority of the world's vanilla is the V. planifolia species, more commonly known as Bourbon vanilla (after the former name of Réunion, Île Bourbon) or Madagascar vanilla, which is produced in Madagascar and neighbouring islands in the southwestern Indian Ocean, and in Indonesia. Combined, Madagascar and Indonesia produce two-thirds of the world's supply of vanilla.

Vanilla is the second-most expensive spice after saffron because growing the vanilla seed pods is labour-intensive. Despite the expense, vanilla is highly valued for its flavour. As a result, vanilla is widely used in both commercial and domestic baking, perfume manufacture, and aromatherapy.

Vanilla stakeholders from around the world converged in Moshi, Kilimanjaro region to ponder on how to increase production and quality of one of the most lucrative spices.

A statement released recently by Nestlé-one of the organisers of the three-day symposium - said the stakeholders also visited some vanilla farmers in the region to find out their challenges and figure out the kind of support they need.

"The meeting will focus on the future of vanilla and vanillin. Given the growing importance of Tanzania and neighbouring countries in the vanilla industry, we felt it is the right time to hold a vanilla meeting in the region," the statement noted.

Dried vanilla beans which are used as spice in food, beverages and fragrances are sold at 10,000/- to 15,000/- per kilogramme, making it the darling of farmers in regions whose weather favours its cultivation such as Kilimanjaro, Kagera and Morogoro.

Tolerance is of necessity for true peace and prosperity to take root

OLERATION is the allowing, permitting, or acceptance of an action, idea, object, or person which one dislikes or disagrees with. Random House Dictionary defines tolerance as "a fair, objective, and permissive attitude toward those whose opinions, beliefs, practices, racial or ethnic origins, etc., differ from one's own". Toleration may signify "no more than forbearance and the permission given by the adherents of a dominant religion for other religions to exist, even though the latter are looked on with disapproval as inferior, mistaken, or harmful."

Historically, most incidents and writings pertaining to toleration involve the status of minority and dissenting viewpoints in relation to a dominant state religion.[3] In the 20th century and after, analysis of the doctrine of toleration has been expanded to include political and ethnic groups, individuals and other minorities, and human rights embodies the principle of legally enforced toleration.

Originally from the Latin tolerans (present participle of tolerare; "to bear, endure, tolerate"), the word tolerance was first used in Middle French in the 14th century and in Early Modern English in the early 15th century. The word toleration was first used in English in the 1510s to mean "permission granted by authority, licence" from the French tolération (originally from the Latin past participle stem of tolerare, tolerationem), moving towards the meaning of "forbearance, sufferance" in the 1580s. The notion of religious toleration stems from 1609.

Religious toleration has been described as a "remarkable feature" of the Achaemenid Empire of Persia. As reported in the Old Testament, king Cyrus the Great was believed to have released the Jews from captivity in 539-530 BCE, and permitted their return to their homeland. Cyrus the Great assisted in the restoration of the sacred places of various cities.

The Hellenistic city of Alexandria, founded 331 BCE, contained a large Jewish community which lived in peace with equivalently sized Greek and Egyptian populations. According to Michael Walzer, the city provided "a useful example of what we might think of as the imperial version of multiculturalism."

The Roman Empire encouraged conquered peoples to continue worshipping their own gods. "An important part of Roman propaganda was its invitation to the gods of conquered territories to enjoy the benefits of worship within the imperium." Christians were singled out for persecution because of their own rejection of Roman pantheism and refusal to honor the emperor as a god. In 311 CE, Roman Emperor Galerius issued a general edict of toleration of Christianity, in his own name and in those of Licinius and Constantine I (who converted to Christianity the following year).

In the Old Testament, the books of Exodus, Leviticus and Deuteronomy make similar statements about the treatment of strangers. For example, Exodus 22:21 says: "Thou shalt neither vex a stranger, nor oppress him: for ye were strangers in the land of Egypt". These texts are frequently used in sermons to plead for compassion and tolerance of those who are different from us and less powerful. Julia Kristeva elucidated a philosophy of political and religious toleration based on all of our mutual identities as strangers.

The New Testament Parable of the Tares, which speaks of the difficulty of distinguishing wheat from weeds before harvest time, has also been invoked in support of religious toleration. In his "Letter to Bishop Roger of Chalons", Bishop Wazo of Liege (c. 985-1048) relied on the parable to argue that "the church should let dissent grow with orthodoxy until the Lord comes to separate and judge them".



THE executive has absolutely no regard for Parliament because a culture of 'fake accountability' has been allowed to prevail. The accountability mechanisms, such as questions to the ministers, deputy president and the president are never taken seriously. Instead, every effort is made to protect the executive from accounting as they should to Parliament and by extension to the public.

The South African Parliament has consistently been found wanting when it comes to performing its critical and constitutionally enshrined role. This has been reiterated and demonstrated on numerous occasions.

There is a fundamental lack of understanding of what the role of Parliament is and how critical the principle of separation of powers is in a constitutional democracy. Instead of vigorously and jealously guarding the integrity of Parliament as an institution, the ANC often uses its numbers in the National Assembly, the National Council of Provinces and in portfolio committees to simply undermine the role of Parliament and the people who have elected Members of Parliament to

The party continues to demonstrate its disdain for the institution through big and seemingly insignificant ways.

The two Houses of Parliament often – through their presiding officers and the portfolio committee chairs – refuse to hold the executive to account.

accounting as they should to Parliament and by extension to the public.

When ministers and their deputies appear In portfolio committee meetings to present annual reports, strategic plans or to account on specific issues, Members of Parliament leave those meetings none the wiser. Their efforts to interrogate and demand answers are thwarted by chairs of committees and the ANC majority. This past weekend, Parliament's portfolio committee on health hosted public hearings in Mpumalanga to hear the views of ordinary citizens on the National Health Insurance Bill. This is a process critical to the work of law-making.

Instead of these hearings being used to sincerely consult, educate and obtain public sentiment, they became a "clash of the buses". The ANC packed the halls with party supporters – an act which is not only wrong, but completely distorts the findings of the process. It has never demanded excellence from Cabinet ministers regarding the work they have been appointed to do. It is an indictment that a great institution that has the ability to conduct its work on behalf of the people of South Africa is reduced to some rubber-stamping desk.

One almost gets the sense that the ANC views the legislative process as its own policy wing and not an independent and credible institution of Parliament.

There are many examples around the world of how countries have in fact strengthened the arm of their parliaments or legislatures by allowing members of opposition parties to chair portfolio committee meetings, more frequent oral question sessions in parliament and far more direct accountability demanded from the executive.

One can only conclude that these mechanisms are available to South Africa, but can never be implemented until we elect people who will take their mandate to serve the public seriously. It is only when the interests of the people of South Africa outweigh party political

interests that the legislature in our country will function optimally.

T the end of the Cold War, political scientist Francis Fukuyama wrote a celebrated essay titled 'The End of History?' Communism's collapse, he argued, would clear the last obstacle separating the entire world from its destiny of liberal democracy and market economies. Many people agreed.

Today, as we face a retreat from the rules-based, liberal global order, with autocratic rulers and demagogues leading countries that contain well over half the world's population, Francis Fukuyama's essay, The End of History seems quaint and naive. But it reinforced the neoliberal economic doctrine that has prevailed for the past 40 years.

The credibility of neoliberalism's faith in unfettered markets as the surest road to shared prosperity is on life-support these days. And well it should be. The simultaneous waning of confidence in neoliberalism and in democracy is no coincidence or mere correlation. Neoliberalism has undermined democracy for 40 years.

The form of globalisation prescribed by neoliberalism left individuals and entire societies unable to control an important part of their own destiny, as Dani Rodrik of Harvard University has explained so clearly, and as I argue in my recent books Globalization and

Power, and Profits. The effects of capitalmarket liberalisation were particularly odious: If a leading presidential candidate in an emerging market lost favour with Wall Street, the banks would pull their money out of the country. Voters then faced a stark choice: Give in to Wall Street or face a severe financial crisis. It was as if Wall Street had more political power than the country's citizens. Even in rich countries, ordinary citizens were told, "You can't pursue the policies you want" – whether adequate social protection, decent wages, progressive taxation, or a well-regulated

disappear, and you will suffer." In rich and poor countries alike, elites promised that neoliberal policies would lead to faster economic growth and the benefits would trickle down so that everyone, including the poorest, would be better off. To get there, though, workers would have to accept lower wages and all citizens would have to accept cutbacks in important

financial system – "because the country

will lose competitiveness, jobs will

The elites claimed that their promises were based on scientific economic models and "evidence-based research". Well, after 40 years, the numbers are in: growth has slowed and the fruits of that

government programmes.

growth went overwhelmingly to a very few at the top. As wages stagnated and the stock market soared, income and wealth flowed up, rather than trickling

How can wage restraint – to attain or maintain competitiveness - and reduced government programmes possibly add up to higher standards of living? Ordinary citizens felt like they had been sold a bill of goods. They were right to feel conned.

We are now experiencing the political consequences of this grand deception: distrust of the elites, of the economic "science" on which neoliberalism was based, and of the money-corrupted

political system that made it all possible. The reality is that, despite its name, the era of neoliberalism was far from liberal. It imposed an intellectual orthodoxy whose guardians were utterly intolerant of dissent. Economists with heterodox views were treated as heretics to be shunned, or at best shunted off to a few isolated institutions. Neoliberalism bore little resemblance to the "open society" that Karl Popper had advocated. As George Soros has emphasised, Popper recognized that our society is a complex, ever-evolving system in which the more we learn, the more our knowledge changes the

behaviour of the system.

Nowhere was this intolerance greater than in macroeconomics, where the prevailing models ruled out the possibility of a crisis such as the one we experienced in 2008. When the impossible happened, it was treated as if it were a 500-year flood – a freak occurrence that no model could have predicted.

Even today, advocates of these theories refuse to accept that their belief in self-regulating markets and their dismissal of externalities as either nonexistent or unimportant led to the deregulation that was pivotal in fuelling the crisis. The theory continues to survive, with Ptolemaic attempts to make it fit the facts, which attests to the reality that bad ideas, once established, often have a slow death.

If the 2008 financial crisis failed to make us realise that unfettered markets don't work, the climate crisis certainly should: neoliberalism will literally bring an end to our civilisation. But it is also clear that demagogues who would have us turn our back on science and

tolerance will only make matters worse. The only way forward, the only way to save our planet and our civilisation, is a rebirth of history. We must revitalise the Enlightenment and recommit to honouring its values of freedom, respect for knowledge, and democracy.

Ifakara Health Institute: A world-class research institute

visit to Ifakara by zoologist Dr. Rudolf Geigy from Switzerland in 1949 marked the beginning of over 50-year history of Ifakara Health Institute (IHI). Geigy (1920-1995), a scientist from the Swiss Tropical Institute in Basel, sought a fieldwork location for researching on tropical diseases. Eight years later, he opened the Swiss Tropical Institute Field Laboratory (STIFL) there.

The name "Ifakara" refers to "a place you go to die", a reflection of the historically high burden of disease in the area, before major control efforts started.

In the years after the 1961 independence, STIFL played a central role in training medical officers who could serve the country after independence. The government mandated STIFL to play the role through the Rural Aid Centre, which was designed to undertake the assignment.

Tanzania adopted the nationalisation policy in the late 1960s and early 1970s which championed transferring of public institutions into the hands of Tanzanians. The policy set the stage for the integration of STIFL into a government agency -National Institute for Medical Research (NIMR) which was achieved some years later in 1990.

The following year, that's in 1991, STIFL was renamed 'Ifakara Centre' and made an affiliate of NIMR. In 1996, it was made a trust and renamed, 'Ifakara Health Research and Development Centre (IHRDC). This name lasted until 2008 when it was changed to the current one of Ifakara Health Insti-

make notable achievements in the fields of sciences, humanities and public affairs. The aim is to encourage and promote scientific, cultural and humanistic values that form part of mankind's universal heritage. In 2010, IHI received the (Tanzania) National Award for Science and Technology.

The first Tanzanian science director, Dr. Andrew Kitua, was appointed in 1993. His successors: Dr. Hassan Mshinda and Dr. Salim Abdulla, built strong teams that took the institute to the high level of excellence, extending operations of the institute to other regions.

The Institute's name was simplified to "Ifakara Health Institute," abbreviated as "IHI" in 2008. The same year, Dar es Salaam office, where IHI is currently headquartered, was opened.

In 2009, the institute extended its wings by opening a new branch in the Tanzania's colonial era capital, Bagamoyo. And three years later, in 2012, Kingani Training Centre and clinical trials facilities were built.

ent non-profit outfit, Its history dates back to 1956. It is headquartered in Dar es Salaam, but with major branches in Bagamoyo and Ifakara - its original birthplace.

It endeavors to influencing policy: Engaging communities in research activities that has helped to improve public health around IHI sites. However, influencing the lives of more people requires translation of the Institute's findings into broader policies. It has done it done this successfully for decades in international development policy, including those formulated by the World Health Organisation (WHO) intended to double efforts to ensure that more findings are communicated widely to influence health policies domestically as well.

In the same vein, IHI works to seek to help the ministry of health implement its strategies. The institute's connections with the government since its founding over fifty years ago had helped it look beyond the policy-making community to

the intended beneficiaries of the institute's efforts - that's the public.

The IHIcommunity engagement initiative, active for over a decade now, identifies issues arising from the institute's work and informs communities accordingly. Its resources, including the website, social media channels, the digital library and the data repository, now benefit the public directly.

In the years ahead, its mission remains to identify priority health needs of the Tanzanian people and to create scalable solutions for them. This is at the heart of its strategic plan 2018-2023. In the long run, IHI harbours the ambition of becoming one of the leading global think tanks and centers of excellence in public health research.

It has identified 5 imperatives to enhance its impact on health and wellbeing of people: strengthen stakeholder engagement: unlock financial resources to drive own research agenda; cultivate a world class scienceenabling environment; leverage research platforms to maximise scientific discovery; and support translation of knowledge to deepen impact.

IHI is best known for its work on malaria. However, its focuses on all health challenges identified as important by the government and the people living in communities near each of the IHI facilities. The institute's scientists are working on a wide range of diseases, ensuring that research translates into tangible health outcomes. Its research work is conducted in through

three research departments:

Environmental health and ecological sciences

We focus on the ecology and transmission of infectious diseases through developing and testing of surveillance and control measures. Key areas include: mosquito ecology and control, water, sanitation and hygiene research. Other areas are: statistics, mathematical modeling, health geography and social in-

In recent years, major activities have included research on ecology of disease-transmitting mosquitoes with special focus on malaria and now expanding to other mosquito-borne diseases, including dengue, filariasis, rift valley fever and zika.

Interventions and clinical tri-

In Ifakara, Rufiji and Bagamoyo, IHI has developed platforms for surveillance, implementation science studies and clinical trials covering district hospitals and satellite clinics, providing the basis for Phase 2 and 3 clinical trials and pharmaco-vigilance. A new centre for clinical trials at Kingani area in Bagamoyo district was opened in 2012, and has already performed a bio-equivalence study and a malaria challenge study using fully infectious purified sporozoites. The clinical trial facilities in

Bagamoyo and Ifakara are supported by laboratory capabilities in parasitology, haematology, biochemistry, immunology, molecular biology and a biosafety level 3 laboratories for bacteriology and virology.

IHI also provides technical

to start and implement clinical trials. For example, It had a group based in Equatorial Guinea supporting large-scale vaccine trial programmes.

Health systems, impact evaluation and policy

IHI conducts multi-disciplinary studies of health systems performance including service delivery, quality, effectiveness and equity. It also monitors and evaluates pilot initiatives, national programmes and changes in population health status.

Social determinants of health, health impact of public policies and social health protection are recent additions to this portfolio. Lastly, the group catalyzes uptake and effective implementation of policy changes, interventions or new approaches, by devising and testing scalable, replicable implementation models and tools.

Health and demographic surveillance

IHI's health and demographic surveillance systems in Ifakara (since 1996), Rufiji (1997) and Kigoma (2009) track vital events and cause-specific mortality. Population demographic surveillance is presently being extended to a nationallyrepresentative sample of 1,000,000 across 23 districts using Sample Vital Registration with Verbal Autopsy (SAVVY).

A second surveillance arms combined provide a rich platform for monitoring health and demographic trends of disease and service delivery, monitoring progress towards the Sustainable Development Goals (SDGs), and understanding national-scale evaluation of program implementation and impact.

HIV, TB, maternal and neonatal

The HIV clinic at Ifakara focuses on treatment adherence, treatment outcomes and PMTCT outcomes. Ongoing research, including two cohort studies (one on HIV, a second one on TB), examine comorbidities and HIV acquisition and progression; risk factors for HIV

support in other countries acquisition; community perceptions on prevention, risk factors for HIV acquisition; community perceptions on prevention; HIV health-seeking and retention, testing interventions for improving diagnosis and treatment uptake, and evaluation of the impact of recently policy programme developments.

Regarding TB, IHI works with the government through the ministry of health in mapping circulating TB strains and resistance patterns and test new diagnostics for childhood TB. Ongoing studies include the rapid evaluation of highdose nifampicin and other rifamycins, and a safety and immunogenicity evaluation of H1/IC31 - an adjuvanted TB subunit vaccine.

Research on maternal and neonatal health began with the largest-ever household survey in Tanzania to describe maternal and neonatal mortality in Mtwara and Lindi districts. Related studies examined health beliefs surrounding pregnancy and childbirth, and amenability to change hazardous practices affecting newborn children. Current research includes a range of health system-based, replicable interventions, to increase skilled birth attendance and improve the accessibility and quality of obstetric emergency care.

Emerging interests

In recently years, resurgent interest in neglected tropical diseases (NTDs) provides the opportunity to revisit and build upon IHI's historic engagement on schistomiasis, trypanosomiasis, onchocerciasis, filariasis, chikungunya and others. It anticipates a growing body of work on the epidemiology of NTDs.

Rapid demographic and lifestyle changes in developing countries, including Tanzania, also highlight the growing importance of understanding non-communicable disease (NCD) risk factors - notably diabetes and cardiovascular disease. Pipeline projects focus on identifying and evaluating primary prevention and management approaches applicable in low-income settings.

cannot marry before the elder because of tradition. Here we see tradition working against Rachael. Many are single today because tradition and culture forbid them to marry outside of the town, tribe or social class. Behind every tradition is a spirit. May God deliver you from the spirit of tradition. Tradition assisted Leah to get married but could

not sustain her in marriage nor guarantee her a happy marriage. Religious traditions kept many people single and sinning.

VICTIMS OF PARENTAL VOW

Jephthah's daughter is a good example. Her father made a vow before he went to war that he would offer unto God the first thing that comes from his house if God would help him win the war. It was rash and foolish, but a vow is a vow. We know the story. His daughter came out and had to be offered. I believe in service to the Lord, so she remained a virgin. (Judges 11:30-40).

Vows made by people who have relational authority over you could have telling effects. You must cancel every ancestral vow or pronouncements that are capable of hindering your fortunes in marriage, business or ministry. Samuel, on the other hand, was a beneficiary of a positive parental vow. (1Samuel 1:11, "And she vowed a vow, and said, O LORD of hosts, if thou wilt indeed look on the affliction of thine handmaid, and remember me, and not forget thine handmaid, but wilt give unto thine handmaid a man child, then I will give him unto the LORD all the days of his life, and there shall no razor come upon his head.")

MANIPULATION

In 1Samuel 18:17-21. King Saul had promised to give his daughter Merab to David in marriage, but he failed to deliver. But he later gave Micah to David for a very interesting reason; 'to be a snare to him'. When parents insist on their children marrying a particular person without divine guidance, the devil is setting a trap. I pray the Lord will deliver you from every parental manipulation. Micah did not enjoy her marriage. There was a long interruption, but even after they got back together, she ended up being barren.

VICTIMSOFANCESTRAL **MORAL PROBLEMS**

A good example of this is Tamar, Absalom's beautiful sister. .VICTIMS ENVIRONMENTAL **CIRCUMSTANCES**

After Lot escaped with his daughters from Sodom, they went to Zoar. There, his daughters conspired to rape him one after the other to conceive by him while he was under the influence of alcohol. ourism is travel for pleasure or business; also the theory and practice of touring, the business of attracting, accommodating, and entertaining tourists, and the business of operating tours. Tourism may be international or within the traveler's country. The World Tourism Organization defines tourism more generally, in terms which go "beyond the common perception of tourism as being limited to holiday activity only", as people "traveling to and staying in places outside their usual environment for not more than one consecutive year for leisure and not less than 24 hours, business and other purposes".

Tourism can be domestic or international, and international tourism has both incoming and outgoing implications on a country's balance of payments.

Tourism suffered as a result of a strong economic slowdown of the late-2000s recession, between the second half of 2008 and the end of 2009, and the outbreak of the H1N1 influenza virus, but slowly recovered. International tourism receipts (the travel item in the balance of payments) grew to US\$1.03 trillion (€740 billion) in 2005, corresponding to an increase in real terms of 3.8 pc from 2010. International tourist arrivals surpassed the milestone of 1 billion tourists globally for the first time in 2012, emerging markets such as China, Russia, and Brazil had significantly increased their spending over the previous decade. The ITB Berlin is the world's leading tourism trade fair. Global tourism accounts for ca. 8 pc of global greenhouse gas emissions.

The word tourist was used in 1772 and tourism in 1811. [12] It is formed from the word tour, which is derived from Old English turian, from Old French torner, from Latin tornare; 'to turn on a lathe,' which is itself from Ancient Greek.

The tourism industry, as part of the service sector, has become an important source of income for many regions and even for entire countries. The Manila Declaration on World Tourism of 1980 recognized its importance as "an activity essential to the life of nations because of its direct effects on the social, cultural, educational, and economic sectors of national societies, and on their international relations."

Tourism brings large amounts of income into a local economy in the form of payment for goods and services needed by tourists, accounting as of 2011 for 30 pc of the world's trade in services, and, as an invisible export, for 6 pc of overall exports of goods and services. It also generates opportunities for employment in the service sector of the economy associated with tourism.

The hospitality industries which benefit from tourism include transportation services (such as airlines, cruise ships, trains and taxicabs); lodging (including hotels, hostels, homestays, resorts and renting rooms); and entertainment venues (such as amusement parks, restaurants, casinos, shopping malls, music venues, and theatres). This is in addition to goods bought by tourists, including souvenirs.

On the flip-side, tourism can degrade people and sour relationships between host and guest.

Definitions

In 1936, the League of Nations defined a foreign tourist as "someone traveling

abroad for at least twentyfour hours". Its successor, the United Nations, amended this definition in 1945, by including a maximum stay of six months.

In 1941, Hunziker and Kraft defined tourism as "the sum of the phenomena and relationships arising from the travel and stay of non-residents, insofar as they do not lead to permanent residence and are not connected with any earning activity." In 1976, the Tourism Society of England's definition was: "Tourism is the temporary, shortterm movement of people to destinations outside the places where they normally live and work and their activities during the stay at each destination. It includes movements for all purposes." In 1981, the International Association of Scientific Experts in Tourism defined tourism in terms of particular activities chosen and undertaken outside the home.

der tourist travel International tourist arrivals reached 1.035 billion in 2012, up from over 996 million in 2011, and 952 million in 2010. In 2011 and 2012, international travel demand continued to recover from the losses resulting from the late-2000s recession, where tourism suffered a strong slowdown from the second half of 2008 through the end of 2009. After a 5% increase in the first half of 2008, growth in international tourist arrivals moved into negative territory in the second half of 2008, and ended up only 2% for the year, compared to a 7% increase in 2007. The negative trend intensified during 2009, exacerbated in some among travellers booking via nue; while state-owned Angocountries due to the outbreak of the H1N1 influenza virus, resulting in a worldwide decline of 4.2% in 2009 to 880 million international tourists arrivals, and a 5.7% decline in international tourism receipts.

Travel and tourism remained one of the key growth drivers of Africa's economy, contributing 8.5% of the GDP in 2018; equivalent to \$194.2 billion.

According to the 2019 Jumia Hospitality Report Africa, this growth record placed the continent as the second-fastest growing tourism region in the world, with a growth rate of 5.6% after Asia Pacific and against a 3.9% global average growth rate.

"Our focus is to continue showcasing Africa as a continent full of beauty and opportunity. Through this report, we want to help draw attention to the vast potential of the tourism industry, that we believe is an untapped lever of economic growth," said In 1994, the United Nations Jumia's Head of Travel, Estelle Verdier.

She was speaking during the official release of the annual report at the Africa Hotel Investment Forum (AHIF) in Addis Ababa, ahead of the 2019 World Tourism Day.

Africa received 67 million international tourist arrivals in 2018, to record a +7% increase from 63 million arrivals in 2017 and 58 million in 2016.

This gradual increase is attributed to the affordability and ease of travel especially within the continent, with spending among domestic travellers accounting for 56% as compared to 44% international expenditure.

Additionally, leisure travel remains an important component of Africa's tourism industry, taking up a majority 71% of the tourist expenditure in 2018.

Verdier notes that the implementation of the African Continental Free Trade Area (ACFTA) is expected to further boost domestic travel.

"To realize the full potential gains will require cooperation from all industry players. Governments have to be willing to eliminate visa requirements for African nationals traveling to their countries. Ministries and other responsible partner organizations should create campaigns that will promote their local travel destinations and tourism offerings to attract more regional travellers. At Jumia, we will continue to offer diversified products at affordable prices including resident rates for regional travelers booking through our platform".

THE report, now in its third edition, shows that while payat-hotel remained the most popular mode of payment

Jumia's travel platform, its percentage use went down from 65% in 2018 to 62% in 2019 (down -5%). Card transactions gained popularity with +24% within the same period, "and this reflects an increased trust in our booking platform," Verdier affirmed.

For instance, Ethiopia's visa relaxation policies combined with improved connectivity as a regional transport hub placed the country as Africa's fastest growing travel country, growing by 48.6% in 2018 to be

Etymology

Afri was a Latin name used to refer to the inhabitants of then-known northern Africa to the west of the Nile river, and in its widest sense referred to all lands south of the Mediterranean (Ancient Libya). This name seems to have originally referred to a native Libyan tribe, an ancestor of modern Berbers; see Terence for discussion. The name had usually been connected with the Phoenician word afar meaning "dust", but a 1981 hypothesis[13] has asserted that it stems from the Berber word ifri (plural ifran) meaning "cave", in reference to cave dwellers. The same word may be found in the name of the Banu Ifran from Algeria and Tripolitania, a Berber tribe originally from Yafran (also known as Ifrane) in northwestern Libya.

Under Roman rule, Carthage became the capital of the province it then named Africa Proconsularis, following its defeat of the Carthaginians in the Third Punic War in 146 BC, which also included the coastal part of modern Libya. The Latin suffix -ica can sometimes be used to denote a land (e.g., in Celtica from Celtae, as used by Julius Caesar). The later Muslim region of Ifriqiya, following its conquest of the Byzantine (Eastern Roman) Empire's Exarchatus Africae, also pre-

served a form of the name. According to the Romans, Africa lay to the west of Egypt, while "Asia" was used to refer to Anatolia and lands to the east. A definite line was drawn between the two continents by the geographer Ptolemy (85-165 AD), indicating Alexandria along the Prime Meridian and making the isthmus of Suez and the Red Sea the boundary between Asia and Africa. As Europeans came to knowledge.

Other etymological hypotheses have been postulated for the ancient name "Africa":

- The 1st-century Jewish historian Flavius Josephus (Ant. 1.15) asserted that it was named for Epher, grandson of Abraham according to Gen. 25:4, whose descendants, he claimed, had in-
- vaded Libya. Isidore of Seville in his 7th-century Etymologiae XIV.5.2. suggests "Africa comes from the Latin aprica, meaning "sunny".
- Massey, in 1881, stated that Africa is derived from the Egyptian afrui-ka, meaning "to turn toward the opening of the Ka." The Ka is the energetic double of every person and the "opening of the Ka" refers to a womb or birthplace. Africa would be, for the Egyptians, "the birthplace."
- Michèle Fruyt in 1976 proposed linking the Latin word with africus "south wind", which would be of Umbrian origin and mean originally "rainy wind".
- Robert R. Stieglitz of Rutgers University in 1984 proposed: "The name Africa, derived from the Latin Aphir-ic-a, is cognate to Hebrew Ophir."
- Ibn Khallikan and some other historians claim that the name of Africa came from a Himyarite king called Afrikin ibn Kais ibn Saifi also called "Afrikus son of Abrahah" who subdued Ifriqiya.

History Africa is considered by most paleoanthropologists to be the oldest inhabited territory on Earth, with the human species originating from the continent. During the mid-20th century, anthropologists discovered many fossils and evidence of human occupation perhaps as early as 7 million years ago (BP=before present). Fossil remains of several species of early apelike humans thought to have evolved into modern man, such as Australopithecus afarensis (radiometrically dated to approximately 3.9-3.0 million years BP,[25] Paranthropus boisei (c. 2.3-1.4 million years BP) and Homo ergaster (c. 1.9 million-600,000 years BP) have been discovered.

After the evolution of Homo sapiens sapiens approximately 150,000 to 100,000 years BP in Africa, the continent was mainly populated by groups of hunter-gatherers. These first modern humans left Africa and populated the rest of the globe during the Out of Africa II migration dated to approximately 50,000 years BP, exiting the continent either across Bab-el-Mandeb over the Red Sea, the Strait of Gibraltar in Morocco, or the Isthmus of Suez in Egypt.

Other migrations of modern humans within the African continent have been dated to that time, with evidence of early human settlement found in Southern Africa, Southeast Africa, North Africa, and the Sahara.

The size of the Sahara has

historically been extremely variable, with its area rapidly fluctuating and at times disappearing depending on global climatic conditions. At the end of the Ice ages, estimated to have been around 10,500 BC, the Sahara had again become a green fertile valley, and its African populations returned from the interior and coastal highlands in Sub-Saharan Africa, with rock art paintings depicting a fertile Sahara and large populations discovered in Tassili n'Ajjer dating back perhaps 10 millennia. However, the warming and drying climate meant that by 5000 BC, the Sahara region was becoming increasingly dry and hostile. Around 3500 BC, due to a tilt in the earth's orbit, the Sahara experienced a period of rapid desertification. The population trekked out of the Sahara region towards the Nile Valley below the Second Cataract where they made permanent or semi-permanent settlements. A major climatic recession occurred, lessening the heavy and persistent rains in Central and Eastern Africa. Since this time, dry conditions have prevailed in Eastern Africa and, increasingly during the last 200 years, in Ethiopia.

The domestication of cattle in Africa preceded agriculture and seems to have existed alongside huntergatherer cultures. It is speculated that by 6000 BC, cattle were domesticated in North Africa. In the Sahara-Nile complex, people domesticated many animals, including the donkey and a small screw-horned goat which was common from Algeria to Nubia.

Around 4000 BC, the Saharan climate started to become drier at an exceedingly fast pace. This climate change caused lakes and rivers to shrink significantly and caused increasing desertification. This, in turn, decreased the amount of land conducive to settlements and helped to cause migrations of farming communities to the more tropical climate of West Africa.

"Our country significant practical steps to assist sustainable development of African states. Russia provides African countries with trade and contributes to alleviating their debt burden - the total amount of debt relief exceeds US\$20 billion. Debt-for-development agreements for a total amount of US\$552 million were concluded with certain States,' Lavrov wrote in the article.

Positive dynamics are evident in the development of Russian-African cooperation in the minerals and raw materials. infrastructure, energy and many other spheres.

Some experts have offered both criticism and expert advice, often comparing Russia's economic investment and influence to other foreign players. As Dane Erickson, a lecturer at the Graduate School of Public Affairs at the University of Colorado and formerly a visiting scholar at the Africa Studies Center at Beijing University, argues that the reality is that China is among many international players that have increased their attention to Africa in recent years.

Largely due to Africa's growing reputation as a region for commerce, over the past few years China, India, Japan, and the European Union all have hosted regional meetings similar to the U.S.-Africa Leaders Summit. Africa's fractional share in global foreign direct investment (FDI) is on the rise, and trade between Africa and a multitude of nations is also increasing rapidly, according to Erickson.

Protests drowning the world after Hong Kong protesters created their own 'national anthem'

∠ ∠ Glory to Hong Kong" has become the new theme song of the months-long protests against the Hong Kong government and China.

In an online video, protesters in riot gear sing and play instruments. They have violins tucked under chins covered with masks, drumsticks swinging in blackgloved hands. And together, in Cantonese, they belt out the soundtrack to the Hong Kong resistance: a new, if unofficial, national anthem.

"Glory to Hong Kong" (Or "Glory be to thee, Hong Kong") has become the rallying cry of pro-democracy protesters in Hong Kong, one that's being sung in unison by crowds in malls and even at a soccer game this week. It's the latest act of opposition by demonstrators, who for months have been resisting creeping Chinese authority in the autonomous territory, and it may be one of the greatest signs yet of just how cohesive the resistance really is.

An anonymous user with the name "Thomas dgx yhl" posted the song and lyrics at the end of August to LIHKG, an online forum that's a bit like Reddit and a popular way for protesters to communicate. He's believed to be the composer and, accord-

ing to the New York Times, he asked other users on the forum to record themselves singing the

He collected audio versions via Google Drive, and assembled them together to make it sound as though a choir were singing. He adjusted the lyrics based on suggestions in the forum.

The anthem runs just a couple of minutes long. "We pledge: no more tears on our land," it begins. "In wrath, doubts dispell'd we make our stand. Arise! Ye who would not be slaves again:

for Hong Kong, may freedom reign!"

The song has spread since then, including that popular video of a riot-gear-clad chorus and orchestra playing the song, interspersed with scenes from the months of Hong Kong protests. (Here's the version with English subtitles.)

The anthem may have spread online, but demonstrators have blasted the resistance theme song out in public. At a World Cup qualifying soccer game on Tuesday in Hong Kong, for ex-

ample, crowds booed the Chinese national anthem and sang

"Glory to Hong Kong" instead. Crowds have also gathered in the hundreds and thousands this week to sing all over the city. In some cases it's led to conflict: At Hong Kong's busy commercial center known as the International Financial Center, or IFC, pro-Beijing counterprotesters descended on the mall, waving Chinese flags and singing the Chinese national anthem. That led to a literal sing-off, with workers and protesters drownin a war in the 1800s, Britain to do so. At that point, many

The bill would have allowed for case-by-case extraditions to countries that lack formal extradition treaties with Hong Kong, most notably mainland China. Critics worried that Beijing would take advantage of this law to arbitrarily detain Hong Kong's citizens, such as those who openly dissent against the Chinese government or advocate for human rights.

But as protests intensified – and as the government and police cracked down on the movement – the resistance morphed into something much larger: a fight to preserve democracy in Hong Kong. Just last week, in fact, Hong Kong's Beijingbacked government formally withdrew the extradition law after months of refusing protesters simply said: "too little, too late."

"Glory to Hong Kong," then, is an expression of demonstrators' fight to preserve democracy and its unique status within China for as long as they possibly can. The song recognizes the tremendous challenge they face. The odds that protesters can fend off China forever or win some of their demands – such as universal suffrage – are extraordinarily low. "Though deep is the dread that lies ahead," one line reads, "Yet still, on our faith, on we tread."


The Chinese government largely ignored the Hong Kong protests when they first began in June. But its leadership has grown increasingly impatient with the continued unrest, using harsher rhetoric against demonstrators and waging a disinformation campaign via tightly controlled, staterun media to discredit the movement.

The country is also fastapproaching a hugely important date: the 70th anniversary of the founding of the People's Republic of China on October 1. President Xi Jinping does not want the major celebration marred by scenes of protests against his government. The increasingly tense and sometimes violent demonstrations were already testing China's resolve.

90-year-old herbarium in Rwanda to be public

KIGAL

Hypoestes aristata, a 105-year-old fern that was plucked in the Usambaras in Tanzania in 1915 will be put on display next year according to University of Rwanda's Centre of Excellence for Biodiversity. It is one of the thousands of specimens of ferns and flowering plants that have been collected since 1930 to date. This collection is housed in the national herbarium located in Huye District.

Herbarium is a collection of preserved plant specimens and associated data used for scientific studies. The National Herbarium of Rwanda accommodates 17,000 types of plants that have been being collected for ninety years.

A playground for researchers

The herbarium helps in botany-related research by researchers and students from Rwanda, Nigeria, the United States, to mention but a few. Apart from being ferns and flowering plants library, the herbarium also keeps some plants that no longer exist are on the IUCN red list of endangered plants.

For instance, prunus africana is described as vulnerable and pteris kivuensis as endangered. This attracts botanists from all over the world. Gorethe Ingabire, a researcher at National Industrial Research and Development Agency (NIRDA) told

Sunday Times that they moved the herbarium's management under University of Rwanda because it is a setting for researchers, botanists and students

"The herbarium contributes a lot in research, and we wanted to make it more accessible to them," she said. Before being given to the University of Rwanda, it was managed by NIRDA when it was still the Institute of Scien-

tific and Technological Research.
Plants and people are connected

Professor Beth Kaplin, Acting Director of CoEB told Sunday Times that there are plans to expand it and make it public. She explains that there is a connection between people and plants. Some of the specimens kept at the herbarium were/are used as medicines. "We want people, not just researchers, to understand the connection between plants and people because it is there," she said.

She also emphasized that the National Herbarium of Rwanda is unique because regardless of the harsh history of Rwanda, some plants were kept for over a hundred years. Besides that, the herbarium also has some rare plants that can only be found in Rwanda. The plants are preserved in botanically approved ways to last for hundreds of years. The National Herbarium of Rwanda works in partnership with other herbariums in Burundi, Uganda,

Africa a land of opportunity once trade war ends - Bank of America

Africa is poised to become the "land of opportunity" for bond and equity investors should the US and China strike a trade deal, according to Bank of America.

"At a minimum, we think the removal of tariff and recession fears at least until the November 2020 US elections should lead to some restocking effect and green shoots by the first quarter," BofA strategists David Hauner and Claudio Irigoyen said in a client note.

Among the main emerging-market beneficiaries would be "some of the less loved currency and high-yield markets, the African 'China plays'," they said. While many investors remain skeptical about the successful conclusion of the current round of trade talks, an agreement will become more likely as the US presidential election campaign approaches, Hauner and Irigoyen wrote.

President Cyril Ramaphosa said in an interview with Bloomberg TV on Wednesday that a deal between the world's two biggest economies would greatly benefit South Africa. A trade pact would reduce the risk of a strengthening dollar, supporting emerging-market currencies and high-yield debt.

Some currencies, including the rand, would also benefit from equity inflows given that stocks are the asset class most likely to profit from an economic rebound, the strategists wrote.

"We also like Africa, where several external credits have lagged amidst the global growth concerns: Kenya, Nigeria and South Africa," they said. In South Africa, local-currency bonds also provide an opportunity after being dragged down by concern over a rating downgrade by Moody's Investors Service, which they say has been fully priced in.

Minister promises: Govt will establish horticulture agency by February 2020

N a bid to boost growth of the horticulture industry by more than doubling current annual earnings by 2021, the government will establish a Horticulture Development Agency (HDA) by February next year.

Unveiling the plans in Dodoma over the weekend, Deputy Minister for Agriculture, Food Security and Cooperatives, Hussein Bashe said several reforms geared at eliminating bottlenecks frustrating rapid growth of the horticulture industry, will also be undertaken.

Bashe said the HAD's main duty will be to oversee the rapid growth of the industry and increase annual earnings from the current U\$764 million to U\$1.85 billion by 2021 while creating jobs and wealth for youth and women in the process.

"Establishment of the Horticulture Development Agency, will completely change the business of horticulture in the country," Bashe stated after meeting with a delegation of Tanzania Horticulture Association's which attended a stakeholders' meeting convened by the Ministry in the new capital.

The meeting was also attended by Treasury's Permanent Secretary, Dotto James, members of Parliamentary Committee on Agriculture, Livestock and Water, Tanzania Investment Centre Tanzania Ports Authority, among others.

Bashe said currently, several laws and regulations are being amended to accommodate the new growth strategy of the industry towards a possible green revolution of the entire agriculture sector.

Some of the initiatives under

the flagship plan include removal of export hurdles, review of regulatory barriers but also improve logistics and infrastructure hitches to ease importation of horticultural related inputs and technologies.

In addition, the government will also merge several regulatory agencies in a bid to ease bureaucracy and save time, a bottleneck which many stakeholders complained against for many years. The ministry will dedicate three laboratories for horticultural food testing to be certified by the Global Good Agriculture Practices to relieve exporters from testing their produces abroad.

Speaking at the same event, Treasury's James advised TAHA to lease a cargo plane for horticulture exportation while promising all necessary support from the government."Before we get our own cargo planes in place, I would advise TAHA to lease one while the government provides any needed support," James promised. He also tasked TAHA to identify all nuisance taxes as well as levies and submits the list to the budget task force as soon

added production costs on the industry, TAHA Group CEO, Jacqueline Mkindi told the meeting.

Mkindi said in order to grow the industry rapidly, the government should identify, demarcate and protect land for horticulture businesses in the country while improving the entire business environment including reviewing of Plant Protection Act, fast-tracking registration of pesticides which frustrate private investors.

"As a country we need to establish special production zones for specific crops like seedless lime, mangoes and apples. These are the products that can give us huge volumes and competitive

Iringa Hydropower wind farm project expected to be completed next month

INSTALLATION of a 2.4 megawatts wind generation power plant in Iringa region's Mufindi district is due to be completed next month.

Mwenga Hydro and Rural Electrification Project Manager, Engineer Joel Gomba told members of a Parliamentary Energy and Minerals Committee who visited the site over the weekend that installation work of the wind power turbines is in the final stage.

"We have additional hydro generation facilities that we plan to develop as and when the demand from our network customers begins to outstrip the available generation capacity," Eng Gomba said while unveiling that talks are under way with Ministry of Energy on the possibility of taking over some of the remote Tanesco power lines adjacent to the project's network under some form of management contract.

He said the move could potentially allow customers to enjoy lower power tariffs, whilst also removing the (commercial and technical) burden from the struggling state utility conglomerate of supplying and servicing such rural customers.

Eng Gomba further told the law makers that Mwenga Hydro and Rural Electrification Project is now waiting for feedback from the Ministry of Energy on the concept, which has the potential to be a win-win for both

Bima App emerges best at Insurance Agents Choice awards

BIMA App has won 'Best Innovative Company' in the recently concluded Insurance Agents Choice awards 2019 beating Jubilee Insurance's, Jubicare and Jubi Agent Apps.

BIMA App, an insurance app launched in December 2018 but tested in July, beat Jubilee Insurance at the recently concluded Insurance Agents Choice awards 2019 bagging the coveted 'Best Innovative Company.' Organised annually by BIMA Intermediaries Association, the body for all insurance agents in Kenya, this year's awards were looking at rewarding key players in insurance who have disrupted the sector through adoption or introduction of novice innovation and technologies.

At present, BIMA App has 10,000 users comprising insurance agents, travel agents, insurance companies, motor dealers among other users. "Our App has seven types of users. We cater to the general public, insurance agents, insurance aggregators, insurance brokers, insurance medical insurance providers, general insurance and life insurance companies all on the same Platform," said Nancy Wangari, Head of Customer Service at BIMA App.

Further there are 10 classes on insurance available on the app including motor, domestic, travel, personal accident, golfers, life, medical, business, marine and micro insurance. "We also have the NHIF on a pilot and we forward all applications to them to handle," Ms Wangari added.

A simple interaction with the app reveals its several unique features. For instance BIMA App is the only app in Kenya that allows all insurance agents or brokers to sell any insurance product on the app without prior registration with underwriters.

Notably, all underwriters are required to sign a memorandum of understanding (MoU) with BIMA App. The terms of the MoU bars underwriters from selling on the app unless they are registered under Insurance Regulatory Authority and have paid the annual fee. Interestingly, BIMA App is the first to provide paperless quotations, notifications, renewals and claims processes.

"Through the app users are able to generate instant insurance quotes by entering the relevant information. Moreover, users are able to take pictures of relevant documents to their insurance policy such as a car log books for motor vehicle insurance," Wallace Gichoho, BIMA App CEO said.

The users then attach and send the documents to their insurance company of choice, to get an instant quotation. The user chooses mode of payment and completes the transaction. BIMA App's Emergency and Distress button, a key feature on the app, allows a user to find the nearest police station, hospital, car garage or towing companies and ambulances countrywide.

"The panic button allows a user to send a discreet picture, voice recording, video recording or GPS location to a loved one in case they are in distress and may not be unable to call. Our claims button allows users to capture details such as the date, time and location automatically," said Mr Gichoho.

He says a user is able to take relevant pictures of the scene and transmit the information to their insurance companies or agents promptly at the click of a button. Mr Gichoho advised that to facilitate quick payment of claims a user should consider sending the same report to the insurance company covering the other involved persons. During the interview, Mr Gichoho said future plans are to ensure affordable insurance coverage for the Kenyan citizenry.

Eskom: Loadshedding a last resort to avoid total blackout

JOHANNESBURG

Eskom said in a statement on Sunday morning that it wants to remind South Africans that loadshedding is a last resort to protect the power system from a total collapse or blackout.

Although the power system remains constrained and vulnerable, Eskom does not expect to implement loadshedding on Sunday. It cautioned, however, that any change in the situation could indeed lead to loadshedding at short notice. For example, additional unplanned breakdowns or the unavailability of diesel for our open cycle gas turbines or water levels at pumped storage schemes, could result in loadshedding at short

This happened on Thursday evening, for example, when Eskom had to suddenly implement stage 2 loadshedding from 22:00 until 05:00 on Friday morning. Since then no loadshedding needed to be implemented. According to

Eskom, some progress has been made in replenishing diesel for open cycle gas turbines and improving water levels for pumped storage schemes. However, given that unplanned breakdowns are above 10 500 MW the probability of loadshedding remains, but will only be implemented if absolutely necessary.

The Emergency Response Command Centre continues to monitor the system and will be in a position to give a prognosis, for the week ahead, during the course of tomorrow. Fin24 reported earlier that, after some of Eskom's generating units failed over last weekend, power supply was running dangerously low by Wednesday morning.

Unplanned outages above 9 500 MW mean Eskom has to resort to emergency power generation by using open cycle gas turbines and pumpedstorage hydroelectric plants. These are very expensive ways of generating power, particularly the gas turbines, which require large quantities of diesel.

Aramco to offer up to 0.5% of shares to individual investors as IPO starts

audi Aramco will kick off its initial offering subscription period on November 17 and offer as much as 0.5 per cent of its shares to individual investors, the company said.

The subscription period for individual investors will run until November 28 and the institutional book building period will end on December 4, the company said in its 658-page prospectus released overnight on Sat-

The company did not offer a price range and said that will be determined on December 5. Saudi Arabia's government, the main shareholder of the company will have a "lock up" period for twelve months, whereby it won't offer additional shares following the listing.

"Trading of the shares is expected to commence after all relevant legal requirements and procedures

have been completed," Aramco said, adding that an announcement of the start of trading of the shares will be made on Tadawul's website. Dates and times included in the prospectus are indicative and may be changed or extended subject to the approval of the CMA, according to the prospectus.

the IPO process confirming its intention to float its shares on the Saudi Tadawul stock exchange, the Arab world's largest market, on November 3. Saudi Aramco's listing is central to the Riyadh's ambitions to transform the kingdom's economy and the funds from the share float are expected to boost spending on Vision 2030 realisation projects such as the \$500bn futuristic economic free zone Neom and the Red Sea Project, a mega-tourism attraction, as the kingdom opens up its tourism and entertainment sector.

The energy behemoth is the world's largest integrated oil and gas company producing one in every eight barrels of crude oil globally. In 2018, the company produced 13.6 million barrels per day of oil equivalent, including 10.3 million bpd of crude oil.

Aramco generates much of Saudi Arabia's revenues. The company was originally established by royal

Bloomberg faces big challenges if he leaps into White House race

WASHINTON

FORMER New York City Mayor Michael Bloomberg has the money and name recognition to shake up the Democratic presidential race, but he will face huge hurdles to the nomination if he makes the leap to become a formal candidate.

The billionaire media mogul is laying the groundwork for a possible candidacy and kept his options open by filing paperwork on Friday to run in the Democratic primary in Alabama, which has an early deadline for ballot qualifi-

The decision to run would be an about-face for Bloomberg, 77, who announced in March that he would not seek the White House.

Ranked by Forbes as the eighth-richest American with an estimated worth of US\$53.4 billion, his potential bid drew immediate criticism that he was just another wealthy businessman trying to buy an election.

Bloomberg also will face questions about his record as a three-term mayor of New York, particularly from the Democratic Party's vocal progressive wing, and about why he is needed in a race that still has 17 candidates vying to challengeRepublican President Donald

Trump in November 2020.

"There is no constituency for Michael Bloomberg that isn't already taken by one of the candidates who are already running," said Charles Chamberlain, chair of the Vermont-based progressive group Democracy for America.

But Bloomberg is skeptical that any of the current candidates can beat Trump, according to a spokesman.

The late entry into the race would force Bloomberg to play a quick game of catch-up to build the sort of campaign infrastructure his rivals have spent months constructing.

As a result, Bloomberg will skip early contests like the Feb 3 caucus in Iowa and emphasize later voting states where his rivals will not have as big an organizing advantage, starting with the Super Tuesday primaries in at least 15 states including Alabama on March 3.

"If we run, we are confident we can win in states voting on Super Tuesday and beyond, where we will start on an even footing," Bloomberg adviser Howard Wolfson said in a statement reported by the Washington Post.

Opinion polls show three contenders battling at the top of the Democratic race: US Senators Elizabeth Warren of Massachusetts and Bernie Sanders wing, and moderate Joe Biden, the for-race.

Bloomberg has been critical of Warren and her desire to institute a tax on the super-wealthy, which she would use to fund programs ranging from universal healthcare to free college tuition.

Biden, meanwhile, has turned in uneven debate performances and lagged behind his top rivals in fundraising. Bloomberg would likely seek to appeal to the same moderate voters drawn to Biden.

"It's almost like he's running because this billionaire wants to stop Elizabeth Warren," Brad Bannon, a Democratic strategist who advises progressive groups and labor unions, said of Bloomberg. "It's lousy for Joe Biden but great for Elizabeth Warren."

Public opinion polls show most Democrats do not share Bloomberg's dissatisfaction with the contenders. A Monmouth University poll taken in late October and early November found three-fourths of Democrats were satisfied with their choice of candidates and just 16% wanted someone else.

Renewed scrutiny At 77, Bloomberg, the chief executive officer and founder of Bloomberg LP, would be the secondoldest candidate among the Democrats in a race where age has been an issue. Sanders, who took time off the campaign trail after a heart attack, is 78. Biden is 76, and Warren is 70. Trump is 73.

China praises BRICS contribution to globalisation

BRASILIA

COOPERATION between the emerging economies forming the BRICS bloc has produced positive effects and it will promote globalization for a shared future, Chinese Ambassador to

Brazil Yang Wanming has said. Yang recently spoke with Chinese media outlets, including Xinhua, in the lead-up to the 11th BRICS Summit to be held in Brasilia on Nov 13-14, which will gather leaders from the BRICS economies - Brazil, Russia, India, China and South Africa.

In the past 10 years, cooperation among the bloc members has helped spur development, ushering in a period of "golden decade" for BRICS countries. BRICS has served as a key mechanism for cooperation by bringing leaders together to forge consensus on important issues, said Yang.

"Especially on certain important international affairs, the BRICS countries are able to put forward a common position and to speak collectively with the global community, safeguarding the shared interests of the developing countries, particularly the emerging markets," Yang said.

The current rise of unilateralism and trade protectionism has exacerbated the global situation, injecting greater uncertainty and instability into the world economy, he said. Grappling with a volatile landscape, the BRICS countries strove for greater coordination last year, he noted.

Both at an informal gathering of BRICS leaders in Osaka in June and a meeting of the bloc's foreign ministers in Rio de Janeiro in July, the group issued joint statements to underscore

"They unanimously showed the world their common position in favor of multilateralism and the authority of the United Nations, facilitating free trade and investment, and spurring the construction of an open, innovative and shared global economy," said the ambassador.

Brazil holds the rotating presidency of the bloc this year. Yang said Brazilian President Jair Bolsonaro's important official visit to China in late October produced significant results.

Chinese President Xi Jinping and Bolsonaro reached new important consensus on deepening the China-Brazil comprehensive strategic partnership, to boost the pragmatic cooperation between the two countries in various fields, said Yang.

The ambassador believes the upcoming BRICS summit will mark the beginning of a new "golden decade" of cooperation, and that the bloc members will speak with a common voice calling for multilateralism and an open world economy.

Issues with Iran's upgrade of Arak reactor due to US sanctions, says Russian diplomat

MOSCOW

TEHRAN'S possible abandonment of the JCPOA (Joint Comprehensive Plan of Action) obligations, which envision modernization of the heavy-water reactor in Iran's Arak, is caused by Washington's sanctions pressure, Russian Deputy Foreign Minister Sergei Ryabkov told reporters on the sidelines of the fourth Moscow Nonproliferation Conference on Saturday.

"The problem with the Arak project is basically the same as with all other JCPOA elements. Particularly, how to make sure those facilities are resistant to the US' sanctions pressure. Secondary extraterritorial sanctions that Washington slaps literally paralyze normal operations in many cases," he explained.

"That is why you can of course turn your gaze to Iran in this or that situation following any signal from Tehran, though that is exactly what its enemies want. One should look in the opposite direction," Ryabkov added. "If the US did not seek to destroy and break all that so stubbornly there would be no questions regarding the implementation of the project on reconfiguration of the Arak reactor," he noted.

Iran's Atomic Energy Organization Spokesman Behrouz Kamalvandi said earlier on Saturday that Tehran is ready to return to implementation of the heavy-water reactor in Arak if necessary.

FSB detains IS 'fundraisers' who amassed over **\$150,000** for terrorists

MOSCOW

THE Russian Federal Security Service (FSB) has detained supporters of the international terrorist organization, the Islamic State (IS, outlawed in Russia), that had collected at least 10 million rubles (\$157,000) for the terrorists, in the Dagestan Region, the FSB Center for Public Relations (CPR) told TASS.

"The Federal Security Service in cooperation with the Investigative Committee, the Russian Interior Ministry and the Federal Service for Financial Monitoring have foiled the activity of an underground cell in the Dagestan Region that collected and transferred money for the needs of the international terrorist organization, the Islamic State," the CPR reported. According to the FSB, "they had amassed at least 10 million rubles."

"According to the assignment of these agents, members of the radical cell from among the region's residents organized resource support for the activities of the international terrorist organization, and for that purpose they collected at least 10 million rubles," the center explained. The funds were collected by way of transfers through payment systems and bank cards, and were channeled to terrorist-controlled areas in Syria.

Two members of the criminal gang were detained, and payment instruments, means of communication and fiscal receipts were confiscated along with other documents that prove their criminal activity. Those taken into custody have provided testimony to bankrolling the Islamic State, the FSB reported.

US reports 'breakthrough' in vaping lung injury probe

TESTS of lung samples taken from 29 patients with vapingrelated lung injuries suggest all contained Vitamin E acetate, a discovery US officials described as a "breakthrough" in the investigation of the nationwide outbreak that topped 2,000 cases this week.

The discovery of Vitamin E acetate in lung samples offers the first direct evidence of a link with the substance and vaping-related lung injuries. The substance has also been identified in tests by US and state officials of product samples collected from patients with the vaping injury.

In a telephone briefing on Friday, Dr Anne Schuchet, principal deputy director of the US Centers for Disease Control and Prevention (CDC), called Vitamin E acetate "a very strong culprit of concern" and referred to the discovery as "a breakthrough" in the investigation.

She cautioned that more work is needed to definitively declare it a cause, and said studies may identify other potential causes of the injuries as well.

Vitamin E acetate is believed to

be used as a cutting agent in illicit products containing THC - the component of marijuana that gets people high.

Although the substance was detected in all 29 of the lung samples, which came from patients in several different states, more testing is needed to establish a causal link between exposure and injury, Schuchet said, adding that "many substances are still under investi-

On Thursday, the CDC reported there have been 2,051 confirmed and probable US lung injury cases associated with use of e-cigarette, or vaping, products in 49 states, the District of Columbia and the US Virgin Islands, as well as 39 deaths.

Nearly 85 percent of lung injury patients in the nationwide outbreak have reported using products containing THC.

In the CDC analysis, THC was detected in 23 of 28 patient samples of lung cells, including from three patients who said they did not use THC products. Nicotine was detected in 16 of 26 patient

The results were published on Friday in the CDC's Morbidity and

In a separate report in the same journal, the Illinois Department of Public Health found that compared to vapers who did not get sick, those who had a lung injury were significantly more likely to use THC-containing vaping products exclusively or frequently, and were nine times more likely to have purchased products from illicit sources, such as from on-line

or off the street.

The vaping injury patients also had a higher rate of using "Dank Vapes," a class of largely counterfeit THC-containing products, according to the study.

Together, the findings reinforce public health officials' recommendation that people avoid using ecigarettes that contain THC or any products that come from illicit

Burkina Faso attack threatens gold's final frontier

NAIROBI/JOHANNESBURG/ LONDON

As jihadists wreaked ever more havoc in the last two years, mining firms in Burkina Faso rolled out extra security measures, from barracks for government troops protecting them to safe rooms for workers behind barbed wire and

killed in Burkina Faso since 2016 and nearly 500,000 more have fled their homes, mainly this year. In this time, there have been dozens of attacks on industrial and small-scale mining operations.

After Wednesday's attack Semafo said its Boungou mine site remained secured, but it suspended operations there.

It is a dilemma for miners. The region is seen as the gold industry's final frontier, with large untapped reserves. Lured by relatively low-cost

mining, Semafo and others like

Barrick, IAMGOLD, Endeavour Mining, and Resolute Mining, have invested billions there over the last decade - but expansion by al Qaeda and Islamic State-linked militants could force them to rethink.

Worth the risk?

"Because of the escalating security situation in Burkina, there are companies looking at decreasing their exposure to the country or leaving," said Bill Witham, the head of AAMEG, a body representing Australian resource companies in Africa.

"But the miners still see West Africa as a whole as quite a good investment."

Semafo's Toronto-listed shares have fallen 17 percent since the attack. And major mines just over the borders in northern Ghana and Ivory Coast are now within striking distance of Islamist strongholds, experts warn. Last year, AQIM, the main al

Oaeda affiliate in West Africa, told followers Western companies, especially from France, were "legitimate targets". Semafo, whose staff, contractors or escorts have been attacked three time in the last 18

months, declined to comment

further, saying only that it had beefed up security since those episodes. Eight other companies contacted by Reuters around the Sahel would not give details of

their extra security costs.

West Africa has long been considered a risky prospect where political instability, volatile tax regimes and tricky relations with small-scale miners

weigh heavily on boardrooms. Yet government incentives and the potential to produce gold relatively cheaply led to over US\$7 billion invested in mining projects in the region between 2004 and 2018, according to a tally by S&P Global, a market intelligence company.

This peaked at US\$1.2 billion in 2012, when gold prices were

at an all-time high. That year, al Qaeda-linked groups took over northern Mali but gold operations were unscathed as most mines are in the south, hundreds of kilometres away from militant strongholds.

Since then, France has deployed over 4,000 troops to the region, there is a 16,000-strong United Nations peacekeeping mission in Mali, and West

African leaders have launched regional security initiatives. However, local armies are losing ground.

Since 2017, researchers documented at least 28 violent incidents at mines or involving mining workers in Burkina Faso, 17 of them this year, according to a Reuters analysis of data compiled by the Armed Conflict Location & Event Data Project.

At least 12 of those events this year, which include attacks on workers, abductions and the use of improvised explosive devices, were linked to jihadists. Prior to Wednesday, at least 54 people had been killed in mining-related violence this year, five times as many as all of 2018.

Leave Pant alone, implores India's stand-in captain Rohit

CRITICS of India's Rishabh Pant must leave the young wicketkeeper batsman alone and let him play with freedom, stand-in captain Rohit Sharma said on Saturday.

The 22-vear-old has received lots of flak lately from India's coaching staff, pundits and the media after losing his wicket through loose shots and his position in the India test side has been taken by fit-again Wriddhiman

Former Australia batsman Dean Jones told Reuters this week that Pant needs to improve his off-side game if he wants to graduate from being a one-trick pony. [nL3N27MOYV]

"There is a lot of talk happening about Rishabh Pant every day, every minute," Rohit, who is leading the hosts in place of rested regular captain Virat Kohli, told reporters ahead of Sunday's deciding final Twenty20 international against Bangladesh at Nagpur.

"I just feel that he needs to be allowed to do what he wants to do on the field. I would request everyone to just keep their eves away from Rishabh Pant for a while."

Pant was perceived as Mahendra Singh Dhoni's natural successor in limited overs cricket for India when the former captain eventually hangs up his gloves and till recently was the preferred choice behind the stumps in all three formats.

He played 11 tests in the absence of the injured Saha and used his chances well, hitting

a century in an Oval test against England last year while smashing an unbeaten 159 versus Australia in Sydney in January.

His six-hitting ability makes him a limitedovers asset, but India head coach Ravi Shastri and batting coach Vikram Rathour said in recent interviews that the left-hander's shot selection has occasionally let the team down.

Pant played within himself and seemed to curb his natural instincts in his 26-ball knock of 27 during India's loss to Bangladesh in the first T20 in Delhi while he did not get a chance to bat during the series-levelling win

He, however, handed a reprieve to Bangladesh opener Liton Das, who was stumped off Yuzvendra Chahal but replays confirmed Pant did not collect the ball behind the stumps, with part of his gloves jutting ahead of the line.

Pant nearly repeated the mistake when effecting a similar dismissal to send back Soumya Sarkar for 30 off Chahal.

"He is a young guy ... trying to make his mark in international cricket. Every move he makes on the field, people start talking about him. It is not fair," Rohit said.

"Focus on him a lot more when he is doing good things also, not just the bad things. He is a fearless cricketer and we want him to have that freedom. And if you guys keep your eyes little bit off him, it will allow him to perform even better."

Recent Samatta goals, career plans and soccer wisdom

EGIONS of soccer analysts and betting pundits were at a loss to explain the performance put up by Belgian top club KRC Genk at the return match for the group stage of the UEFA Champions League with the focus being on the Tanzanian star forward Mbwana Samatta.


The leading KRC Genk striker actually scored in the opening tie with the current UEFA Champions League defending champions, though ruled out by VAR technicality, and ascertained his ability to score in that kind of encounter in the return match at Anfield. The match particulars didn't exactly agree with current wisdom among local soccer pundits.

One such problem was the way pundits took it for granted that KRC Gent were also-ran and not a club with 'plans' to do better or well in the Champions League, and then following up this summation with a dear wish that Samatta ought to obtain a chance with an England premier league side to enhance his

This observation was a bit contradictory since the sort of clubs that are seeking the signature of the Tanzanian player as reported so far are Newcastle United and West Ham and earlier there was talk about Everton making such a bid. It implies that only playing in England matters, not a Belgian top club.

As a matter of fact that it part of the kind of sentiments that fuel club disputes and expelling coaches in the instance that a top club side loses an important game, as this counts more than losing smaller games, which the fans - and the pundits after them, if a bit more carefully - appear to take in stride.

The fact that the player scored twice against Liverpool shows that he is good at dodging, beating and timing defenses at top level, the first

Tanzanian player to reach that level, as earlier our players turned out for relatively minor sides. This achievement is substantial, but how far necessary should it end with England

Recent experience with some Belgian players who have made names in the England premier league circuit shows that not all is well with playing for such clubs, as for once, a player like Samatta would first have to lose sight of Champions League football if he shifted.

Then, there is the whole problem of the wish to clinch trophies, and as Mathias Mnyampala said in an old poem in the 1960s, 'mother's breast is sweet even if it is buffalo's breast,' in which case a player dreams of titles, not in which premiership. In that case players like RomeluLukaku or MarouaneFellaini just attained their England premier dreams.

While the fans and even pundits for that matter think first about how much they pay in English Premier League sides compared to Belgium, it is possible that other factors also come into account. Even within the English Premier League not all players rush when an opportunity to move on comes up, as there is the whole issue of whether a player is 'happy' where he is or not.

Surprisingly enough this issue doesn't come up in local disputation or shouting on

MbwanaSamatta, as everyone seems to be preoccupied with monthly or in the England premier league case, weekly salaries. It is uncertain if Mbwana feels so as well.

In any case, obtaining a place in a premier league outfit, let alone the fact that he would scarcely appear in UEFA competitions with clubs ranking from number 15 to 20 in the Premier League, he would scarcely be the happiest person.

Being a useful substitute isn't what a good player dreams of, and in many cases if a player shifts to a powerful club, chances of making it there as in the earlier club are 50-50. In such cases the best option is to seek another middle ranking club in the same premier league or get a good position in a different championship setting, as Lukaku is living his dreams at Inter Milan, not in Manchester United.

How far Mbwana is different from most other African and Afro-Latino and Afro-European players is yet to be seen but unavoidably he will be fitting somewhere. He has so far avoided being carried away with success and losing his professional devotion to austere living when it comes to drinks and other unhealthy entertainment, a malady that has taken the toll of so many Brazilian players in the European circuit, though quite a few survived well into their 30s.

But keeping his head on the ground and regularly setting his feet in the UEFA Champions League or Europe League with his KRC Genk may easily be the most telling trial of his real character, obtaining a highly placed pedestal to play soccer and be accepted, not to run after the highest bidder and be used like a spare part and cast away. It is a lesson we haven't learned.

Runner's abuse allegations embolden other female athletes

TRACK and field is facing a painful and public reckoning with the treatment of some female athletes.

Former teen running star Mary Cain's account this week of alleged physical and emotional abuse at the recently disbanded Nike Oregon Project is prompting more top athletes to come forward.

Amy Yoder Begley, a 10,000-meter runner, said Friday she was told she had the "biggest butt on the starting line." Kara Goucher's husband said the Olympian endured "disgusting" comments from coaches.

Cain said the all-male staff told her the way to get faster

was to get thinner and thinner. Nike says it's investigating,

but the cascade of allegations that have followed Oregon Project director Alberto Salazar's four-year doping ban have called new attention to the emphasis on weight restrictions and emotional abuse.

"It's depressing, but I'm also encouraged that this message is getting out," Dr. Kathryn Ackerman, medical director of the female athlete program at Boston Children's Hospital, said Saturday. "A lot of these athletes have been really shy to share their

Questions about Salazar's methods with his top U.S. runners had swirled for years before the U.S. Anti-Doping Agency found him guilty last month of conducting experiments with supplements and testosterone that were bankrolled and supported by Nike.

But Cain's plaintive story of harassment and abuse while she was part of Salazar's training group, which she joined as a 17-year-old phenomenon in 2013, has emboldened other former Oregon Project athletes to share their stories.

In a New York Times video essay, Cain, now 23, says: "I was emotionally and physically abused by a system designed by Alberto and endorsed by Nike."

Cain said she was harangued by the staff, which had no certified nutritionist or certified sports psychologist, to lose weight and was publicly humiliated when she didn't hit targets. She said she stopped having her period for three years and lost so much bone density she broke five bones. She said

having suicidal thoughts before leaving the program in 2016.

Salazar, who has denied any involvement in doping, issued a statement to The Associated Press on Saturday saying: "I never encouraged her, or worse yet, shamed her, to maintain an unhealthy weight. Not only did I never do such a thing, I would not tolerate anyone else on my team doing any such a thing."

Nike said in a statement these are "deeply troubling allegations which have not been raised by Mary or her parents before. Mary was seeking to rejoin the Oregon Project and Alberto's team as recently as April of this year and had not raised these concerns as part of that process."

The sportswear giant added

she started cutting herself and it will "take the allegations extremely seriously and will launch an immediate investigation to hear from former Oregon Project athletes."

> "I'm so sorry ... that I never reached out to you when I saw you struggling. I made excuses to myself as to why I should mind my own business. We let you down. I will never turn my head again," Flanagan tweeted.

Yoder Begley, who now coaches the Atlanta Track Club, said she was kicked out of Salazar's group after placing sixth in the 10,000 meters at the 2011 national championships.

"I was told I was too fat and 'had the biggest butt on the starting line.' This brings those painful memories back," the 2008 Olympian said.

Goucher, a former Oregon Project runner who helped provide evidence for USADA's case against Salazar, said on Twitter "the culture was unbearable."

Her husband, Adam Goucher, who also ran for the group, tweeted that after she placed fifth in the 2011 Boston Marathon in a personal best of 2 hours, 24 minutes - one of the fastest times for an American woman that year, and six months after having a child -Salazar and a sports psychologist told her mother and sister she needed to lose her baby weight if she wanted to be fast again.

Adam Goucher said his own weight was an issue while he trained under Salazar.

"Maybe now some of you can see why I had so much anger when we left," he wrote.

Ackerman, the Boston sports medicine specialist, is calling on Nike to fund research into healthy and medically sound training in the same way the NFL has started pouring money into concussion studies.

"There are so many great opportunities for Nike to be a leader in this," she said.

Messi 'uncontrollable' in Celta masterclass - boss

CELTA Vigo coach Oscar Garcia said Lionel Messi is uncontrollable after the Barcelona forward's 34th La Liga hat trick spoiled his return to management.

Garcia replaced Fran Escriba as Celta coach earlier this week but was helpless on the touchline as three Messi set-piece goals helped Barca to a 4-1 win.

Messi opened the scoring from the penalty spot before scoring two free kicks as Ernesto Valverde's side returned to winning ways following defeat by Levante and a draw with Slavia Prague.

"With Messi, you never have the game under control," said Garcia, whose side had started the match brightly. "He's uncontrollable, he throws all [your] plans up in the air.

"His efficiency from free kicks is incredible, his percentages are so high. You can't avoid giving free kicks away there, either. He alone changes games.

"If he didn't play, it would have been very different. We could even have won this one. He conditions everything. You know something could happen every time he has

the ball, but when it's a set play you cannot control it."

Of Messi's nine goals in all competitions this season, four have come directly from free kicks. He has scored 22 free kicks since the 2015-16 season from 174 efforts -- an accuracy rate of 12.6 percent.

"It's impossible to not depend on Messi," said Barca coach Valverde when it was suggested his side are too reliant on the Argentine. "We depend on him as much as any team would depend on him.

"He lights everything up, what are we going to do!? With Leo, anything is possible.

Goalkeeper Marc-Andre ter Stegen added: "Leo's special at free kicks. It's not normal what he does, he has an amazing talent."

Celta had cancelled out Messi's opener at Camp Nou on Saturday through a free kick of their own, scored by Lucas Olaza. Messi's two dead-ball strikes killed the game, though, with Sergio Busquets adding a late fourth.

However, there was bad news for Barca in the form of a calf injury to Nelson Semedo. The right-back will be sidelined for the next five weeks.

Messi's dead-ball hat-trick puts Barca back on top

MADRID

LIONEL Messi delivered an incredible dead-ball hat-trick on Saturday to steer Barcelona to a 4-1 victory over Celta Vigo and ease the pressure on his coach Ernesto

Messi scored with a penalty and then a pair of sumptuous free-kicks either side of half-time after Lucas Olaza had briefly pulled Celta level with a free-kick of his own at Camp Nou. Sergio Busquets drove home to make sure of the win late on.

A 34th treble in La Liga puts Messi equal with Cristiano Ronaldo, while a much-needed win sends Barca above Real Madrid on goal difference and back to the top of the table at the end of a testing week.

"It is impossible not to depend on Messi, he illuminates everything," said Valverde. "We depend on him like any team would depend on him. He unlocked the game."

Madrid had briefly claimed first place after continuing their own goal-surge by hammering Eibar 4-0, a game in which Karim Benzema scored twice and Eden Hazard exploded into life.

But while Madrid appear to be hitting their stride, Barcelona's momentum had stalled. After losing to Levante and failing to break down Slavia Prague in the Champions League, scrutiny had again turned on Valverde and his future as Barcelona coach.

Barcelona's disgruntled fans had whistled their team against Slavia in midweek and when Olaza equalised for Celta, that tension and restlessness threatened to return.

Instead, Messi took command, this hat-trick taking his tally to nine goals in seven games, 612 in total for his club. "Obviously when it's tight we have the advantage of having the best player in the world and the best free-kick taker in the world," said Busquets.

Yet his precision from free-kicks is a skill the 32-year-old has worked on and improved in recent years, his conversion rate currently at four goals from his last seven attempts in the league.

The last time a player scored a hattrick from set-pieces in La Liga was when Messi himself achieved the same feat in 2012 against Espanyol, albeit with two penalties and one free-kick.

There was good news for Barcelona too in the return of Luis Suarez, who came off the bench after recovering from a calf strain.

Messi scored his penalty in the

23rd minute after Joseph Aidoo had five minutes from the finish. blocked Nelson Semedo's cross with his hand.

It was Messi that conceded the foul for Olaza's curling free-kick that was well-hit enough to beat Marc-Andre ter Stegen, even if the goalkeeper might have been disappointed not to be able to get across.

There was little Celta keeper Ruben Blanco could do about Messi's efforts, the first in stoppage time before the interval and the second three minutes after the restart.

They were almost carbon copies of each other, bending over the wall and nestling in the top right-hand corner. Celta, under their new coach Oscar

Three minutes later it was two,



half, Ivorian Sergei Alain drilled in KMC FC's only goal in the match.

KMC FC on Saturday released a press release saying they have parted ways with the coach on mutual agreement.

"The management of KMC FC would like to inform the media that they have parted ways with coach Mayanja," part of the press release availed to the media disclosed.

"The decision has come after the squad had posted poor results."

"We have mutually agreed with the coach to come to this decision. We thank him for the time spent with us and wish him the best."

Mayanja joined the Tanzanian side this summer after ending his stay with Uganda's Kyetume FC, a side he had led to promotion to the Uganda Premier League.

Anwar Binde, KMC FC information officer, said KMC FC is grateful to Mayanja for his services.

He said the club is looking for his replacement and once they fund the new coach, the public will be informed."
