LIVESTOCK keepers in Dodoma region have a reason to smile as a 4bn/- organo-mineral fertilizer factory whose main raw material is animal wastes is under construction in the city. The investment by Burundian company, Itracom Burundi is on some1600 hectares on Nala investment area located some 20 kilometers from Dodoma city. It is estimated to generate at least 3000 direct jobs and produce 500,000 metric tonnes of fertilizer per year upon completion in the next nine months. The project is a result of Tan-

Govt stops cashew levy after protests

THE government has suspended a 110/- deduction on every kilogramme of cashew nuts sold which was recently imposed to pay for inputs

loaned to farmers who have since protested the cuts. Prime Minister Kassim Majaliwa told the National Assembly during a question and answer session yesterday that implementation of the revenue collection has been put on hold.

Instead of implementing the directive issued by the Cashewnut Board of Tanzania (CBT), the government will come up with another method after farmers began rejecting farm inputs in protest of the deductions. Majaliwa was responding to a question by Liwale legislator Zuberi Kuchauka, who told the premier that

'TBS fuel marking work still in limbo'

MEMBERS of Parliament have called on the government to legally and financially empower the Tanzania Bureau of Standards (TBS) to enable it effectively undertake fuel marking which it took over recently from a consortium, Global Fluids International (GFI).

Debating the 2021/22 budget estimates for the Ministry of Energy, a section of MPs said that handing TBS the fuel marking duty was long overdue

CLARIFICATION: TASAC FINE ON VIOLATION OF EXCLUSIVE MANDATE IS NOT USD 200,000 AS REPORTED BY THE CITIZEN NEWSPAPER

On Monday 24th May, 2021, the Citizen Newspaper published on its front page an article with a message that any person caught performing exclusive functions mandated to TASAC shall be required to pay a fine of USD 200,000. The quoted figure is wrong and misleads the public.

TASAC would like to inform its customers, stakeholders and the public at large that according to the provisions of the Tanzania Shipping Agencies Act, Cap. 415 the correct fine chargeable to any person who performs any exclusive function mandated to TASAC is USD 10,000 compounded upon admission, or USD 20,000 upon conviction in the court of law.

American investors gear for hospitality, real estate sectors

CHIEF executive officers of two American companies jetted into Tanzania yesterday to scout for investment opportunities in hospitality and real estate business, among others.

Roslyn Parker, CEO of Affinity Travel Group and Miguel Pilgram, CEO of The Pilgrim

Group arrived at the Julius Nyerere International Airport where they were received by officials from the Tanzania Tourism Board (TTB) and Kilimanjaro International Tourism and Safaris Inc. (KITS) which coordinated the

ion with the TIC for its quick response when it applied for the place to be made suitable for investment.

He was impressed by efforts to connect the area with electricity and water services as they are the most essential for industries. "I'm amazed by the ongoing mobilization to ensure the area has access to water and electricity" he said. Msafiri noted that the massive effort by government authorities is a challenge for the firm to start the construction of the factory immediately, as of next week. He said the company has more than five years of experience in producing organic fertilizer in Burundi and it will provide a market for readily available animal wastes, especially cow dung.

"Cow dung is one of our biggest raw materials reaching between 70 and 80 percent followed by other wastes like kitchen wastes and other garbage," he said, noting that other types of ranimal waste apply as well.

Speaking at the construction site, TIC Central Zone Manager Abubakar Ndwata welcomed the investor, estimating that the investment will help to reduce importation of fertilizer and reduce its cost to farmers. He said Tanzania currently imports up to 700,000 metric tonnes of fertilizer, and thus production of up to 500,000 metric tonnes by the Burundian investor vastly reduces the

Healso expressed his confidence that with government efforts to improve investment infrastructure throughout the country the results are evident, as once the needed infrastructure is in place, investors find it easier to set foot.

Talking about the Nala investment area, he said with the installation of electricity and a source of water in place, the area is more conducive for investors.

In the past, possible investors would visit and seek a portion of land in the industrial area, but the biggest challenge they raised was lack of water and electricity. "We now welcome more investors to Dodoma and specifically to the Nala investment area which now has the basic needs enabling an investor to start a factory" he said. Tanzania Electric Supply Co. (TANESCO) site project manager, Tumaini Chonga said power connectivity on the five kilometer line to the factory site had taken seven days and would be completed today. "We have been working here day and night to connect this area with electricity and hopefully, tomorrow there will be light here after fixing two transformers," he elaborated, noting that with the project, area residents not connected to electricity will be connected soon. Connecting every household is a vital objective, he emphasised He lauded TIC for the spirit of

there is tension among farmers in cashew growing regions over the matter.

In his preliminary observation the MP said that they have received information that the government intends to lend farmers farm inputs which will be repaid later. "There is tension after reports

that the deduction will not consider the amount of cashew

nut which a farmer has, this is unfair because there are variations in the cashew nut that a farmer owns," he said.

In his response, Majaliwa said the directive has been now suspended and urged farmers to take the farm inputs which have been brought by the government in their respective areas, underlining that the amount of farm inputs distributed to various districts is sufficient for this growing season.

"There is a meeting set for June 6 which will show the way forward on how the money will be deducted," he said, elaborating that farmers with 10 kilogrammes and those with tonnes will not be deducted in the same manner.

The government was working on a better method to ensure that small farmers get inputs cheaply, he stated, highlighting a directive by the Ministry of Agriculture to improve market access for crops

that farmers harvest to ensure they get farm inputs timely.

"Cashewnuts is among crops which the government has been working on ensuring their proper management and tht each eligible farmer participates fully," he stated.

After the June 6h meeting that will bring together all the various parties a directive will be issued on the way forward, he added.

"The investors' visit is more beneficial to the country as we are leading a consortium of willing collaborators to construct four high-end accommodation facilities," the tour coordinator noted. The firm shall also bring into Tanzania a major US hotel brand popular around the world to build affordable accommodation in Dar es Salaam, Zanzibar, Kilimanjaro, Dodoma and in national parks, she added.



Pilgram to start with manufacturing of Industrial sugar

"Mv intention was to invest in hospitality and affordable housing but after the TIC presentation, I have decided to start with industrial sugar," he said.

This change of mind came after TIC Senior Investment Officer Latifa Kigoda said that Tanzania has an over 70 per cent gap in industrial sugar which is imported annually.

The officer said the investment needed is \$500,000 which Pilgram said his firm can manage four times over.

"We seek to convince these investors to grab opportunities at the recently demarcated Burigi-Chato and Julius Nyerere national parks which have huge potentials for accommodation facilities," said Judge (rtd) Thomas Mihayo, the TTB board chairman.

Speaking to reporters, Parker said partnering with local firms will bring more tourists in the country and create employment opportunities, stimulate economic growth in various sectors related to tourism and hospitality.

"We are excited to be in partnership with tour tourism partners especially the TTB, KITS. I know this partnership will be very fruitful and looking forward to bringing more tourists in the near future," she said.

For his part, the CEO of Pilgrim Group said that he has arrived in Tanzania for the first time, trying unsuccessfully for five years. The company was looking forward to partnership to invest in affordable real estate, he specified.

Tanzania executes new development projects worth 3 trillion/- under PPP

TANZANIA is on the verge of executing a total of 41 new development projects valued at 3.02 trillion/- under the Public-Private Partnership in line with the country's current fiveyear national development strategy plan.

That was stated by the Permanent Secretary in the Ministry of Finance and Planning, Emmanuel Tutuba during the media sensitization workshop on public-private partnership, held at the Arusha Mini-Treasury Hall and attended by editors from various outlets across the nation.

"As of 31st of May this year, there were 41 projects write-up prepared under Public Private Partnership, these cover various sectors including water, health; education; infrastructure; communication; construction and commerce," said Tutuba, adding that 40 of the said projects have been hatched by state authorities while the private sector came up with one.

Addressing the media personnel, the Permanent Secretary recapped the government's stand in recognizing the important role of the private sector in helping to push the socio-economic development wheel through partnership in major investments.

"Tanzania needs to utilize all available options to attract increased private sector investments being important in achieving the National Development Vision 2025 and the National Strategy for Growth and Reduction of Poverty (NSGRP) goals," he maintained.

It was also stated during the Arusha training sessions that Public-Private Partnership (PPP) frameworks in Tanzania were also crucial tools that provide instruments for attracting foreign investments.

It was also learned that the Public-Private Partnerships (PPPs) have been identified as sustainable means to effectively address constraints of financing, managing and maintaining public goods and services as well as involving all sectors in building the nation.

Public-Private Partnerships involve the mutual agreement between public sector and private sector in which the private entities renovate, construct, operate, maintain, and manage projects in whole or in part but in accordance with output specifications.

Participation in PPPs covers both productive and socio-economic services sectors including, agriculture, infrastructure, manufacturing, education, health, natural resources, tourism, energy, mining, water, land development, environment and solid waste management.

The projects may also cover appropriate defence infrastructure, sports, communication, information and communication technology (ICT), trade, entertainment and recreation as well as agriculture but precisely irrigation.

'Tanzania has lifted ban on mineral concentrates export'

TANZANIA has lifted a ban on mineral concentrates exports after putting in place a new and transparent method in which the government gets all the legally entitled revenues, Prime Minister Kassim Majaliwa told the National Assembly yesterday.

PM Majaliwa said this during a question and answer session to the Prime Minister saying there was no container with mineral concentrates which was moving out of the country without being sold and with proper documentation.

Majaliwa was responding to a question from Msalala legislator Iddi Kassim Iddi who wanted to know how much was the government getting from mineral concentrates which are being seen transported from Bulyankulu to the port of Dar es Salaam despite the fact that there was a ban.

"This has raised eyebrows. People want to know what is going on, what is the government stance on the matter," queried the MP.

In response, the PM said the containers which are being transported out of the country have been sold and that the government has got all the entitled revenues.

"Let me assure Tanzanians that the containers they see have been sold and that it several samples of minerals.

is the buyer who is transporting them," he said.

The PM said the government had its team at the mining site which ensures that the mineral concentrates have been sold before they get out of the site.

"We are getting a lot of money only that I do not have the figures here, but the minister for minerals detailed during his speech on how the sector was benefiting the country," he said.

The PM agreed to have seen information on social media that there are containers being transported out of the country's borders.

"Let me remind Tanzanians that we banned exportation of mineral concentrates because there were some shortfalls and we came up with a new system to handle the matter," he said.

According to the PM, the new system includes identifying the transporters of the mineral concentrates.

The late President John Magufuli formed a team to advise him on forming a company which will be jointly owned by the government and investors.

Earlier, it was advised that there was one type of minerals in the containers but after investigations it was found that there were several samples of minerals.

WHEN President Samia Suluhu Hassan delivered her maiden speech to Parliament on April 22nd, she vowed that the sixth phase government will take serious measures to stimulate economic growth, which was adversely affected by the global COVID-19 pandemic.

The growth dropped from an average of 6.6 percent to 4.7 percent last year, the president remarked.

President Samia emphasized, among various other issues, that offering incentives to investors while pursuing strategic projects, ensuring growth of investments and trade to spur economic activity and creating jobs.

Equally important is keen follow up on regulations governing investment, with a view to make them more attractive to local and foreign investors.

This leads to the need to expedite investment proposals from which the country could benefit, mindful of the need to create jobs and increase revenues.

Observers have taken note of the fact that a few days before that speech was delivered on the April 19th, the London business daily, the Financial Times announced an attractive investment deal in Tanzania Mainland and Zanzibar which relates to sale of MIC Tanzania PLC (Tigo) and Zanzibar Telecom PLC (Zantel).

No mention was made in the Financial Times article of an IPO of Tigo on the Dar es Salaam Stock Exchange, which is a legal requirement that is yet to be implemented, the consultant affirmed.

Millicom International Cellular S.A (Millicom), the parent company of MIC Tanzania PLC and Zanzibar Telecom PLC announced that it has signed an agreement for the sale of its entire operations - TIGO and Zantel - to a consortium led by Ax-

ian Group, a company based in the Malagasy capital of Antananarivo.

"Millicom is pleased to have found a strategic investor such as AXIAN Telecom, a firm committed to furthering Tigo and Zantel's long term commitment to provide accessible, affordable and innovative service to the people of Tanzania," the company stated.

City sources affirm that the sale of the Tanzania business was in line with Millicom's strategy to focus on fixed and mixed mobile services in Latin America, after investing in the development of the telecom industry in Africa for around 25 years.

Millicom, founded in 1990, is headquartered in Luxembourg. "Millicom is a Latin American- focused telecom company with 95 percent of its revenues coming from that region," the CEO of Millicom, Mauricio Ramos, told the Financial Times.

Ramos stressed that they are closing all business undertakings in Africa where revenues are much lower.

At this juncture, it is imperative to take note of the various concerns raised by potential local investors in emerging communication technologies, including mobile networks.

A media consultant familiar with the issue said that firstly, it is on old habit for foreign investors to call press conferences or distribute statements for media use in New York, London or other financial centre when they want to sign investment deals.

The local press is not invited and at times not even the local regulatory authorities are aware of sale plans, he said.

For instance, in this case the local media picked the Tigo story from the international media and sought to further its content from local sources, which shows that the trend has not changed. "We believe it would have been prudent for Millicom to have distributed the press releases abroad and then unveil the plans in Dar es Salaam at another press conference to give room to local stakeholders and media to ask relevant questions on the deal," he affirmed.

Local stakeholders are scarcely aware of the Axian Group, the strength it has in its existing operations in Madagascar (whose population does not exceed eight million people, while Tigo (T) Ltd boasts of more than 13 million subscribers as of December 2020), he elaborated.

Secondly, local investors in the telecom sector aren't aware if the local regulatory authority and other state bodies like the Tanzania Communications Regulatory Authority (TCRA), the Bank of Tanzania (BoT), the Tanzania Revenue Authority (TRA) are as yet in the picture about what has been signed.

"We believe however the regulators will have ample time to pick up the details as it will require regulatory clearance, thus cross examine the whole deal from Millicom to the Axian Group before issuing the necessary operational approvals," the consultant asserted.

The regulators will need to be convinced of the capacity of the Axian telecom firm and whether it has any concrete strategies for operating in a much larger country and can extend affordable digitalization nationwide, he emphasized.

The new investor must also tell us how the firm will operate safely in line with the global COVID-19 control measures, and inform existing staff and network partners on its plans on health issues, like taking up responsibility in educating the staff and clients on pandemic issues like vaccines, etc.

He similarly referred to unconfirmed reports that the Axian Group has already nominated a

Turkey vows to work with Tanzania to solve GBV and child abuse issues

THE Turkish government has pledged to work with Tanzania in finding solutions to various challenges facing communities across the country including the issue of gender based violence (GBV) and child abuse.

This was revealed here early this week by Turkey's Ambassador to the country, Dr Mehmet Gulluoglu during his meeting with the Ministry of Health Permanent Secretary (Community Development Department), Dr John Jingu.

Dr Gulluoglu, among others, said his country, through its various sponsors were ready to participate in Tanzania's development, especially in the sectors of education, economic empowerment for women and the fight against GBV and child abuse.

Earlier, speaking on activities coordinated by his ministry, Dr Jingo said the government has begun to invest in women economic empowerment aimed at improving households' economies and ultimately national economic growth.

He said to make sure the plans' aims are achieved, his ministry, in collaboration with the Ministry of Agriculture and various other stakeholders have begun to invest in the cultivation of avocado in Iringa, Njombe and Mbeya regions, as well as sunflower growing in Singida and Dodoma regions, whilst Kigoma region was earmarked for oil palm cultivation.

In regard to strengthening social services to the country's elders, Dr Jingu said the issue was among government's priorities, saying the government runs 13 elders' homes in the country's various areas.

On children's development, he said it is the government responsibility through his ministry to ensure children's basic services and their rights are attained including the rights of children who have infringed various laws.

In regard to Non-Governmental Organisations (NGOs), Dr Jingu said the Ministry provides guidelines and monitor their operations to ensure they operate transparently and accountably. Among the international NGOs is Turkish Maarif Foundation that deals in education issues which currently runs schools in Dar es Salaam, Arusha and Zanzibar.

The Foundation's Resident Director, Oguz Hamza said their aim is to provide quality education to Tanzania's students at low cost.

Elaborating on the cooperation among NGOs, the country's Registrar for MGOs Vickness Mayao said the issue needs collective coordination depending on the areas involved.

Singida launches vehicles electronic parking fees collection

SINGIDA Region has officially launched the electronic system for collection of parking fees known as TeRMIS.

TeRMIS - the acronym for 'Tarura e-Revenue Management Information System' is a new government revenue collection system as a way to supplement repair costs to road infrastructures.

Launching the system r here on Wednesday, Singida Regional Commissioner Dr i Binilith Mahenge urged the residents to accept it as it has been introduced with good intentions.

He said its aim is to enhance government's revenue collection, but also to reduce users' inconveniences in the payment of parking fees.

It is explained that after registration, the user will on his own start paying the amount required on daily, weekly or monthly basis via mobile transaction or any NMB, CRDB

bank branches or their agents.The RC said another relief

on users is to assist them to pay the fees from wherever he is without having to go to TARURA offices.

However, he called on TARU-RA to make frequent inspections on all those contracted to collect the revenue as precautions against fraud. Elaborating on the new system, a TARURA expert on revenue issues, Oswald Mobily said the customer can elect to pay parking fees on hourly, daily, weekly or monthly basis, He cited vehicles that will be subjected in payment of parking fees as including tri-motorcycles (Bajaj) that

will be charged 300/- per day,

1500/- per day and 6,000/- per
month.

Vehicles of not more than

2 tonnes carrying capacity

will be charged 500/- per day,

2,500/- per week and 10,000/-

per month, while vehicles of

more than 2 tonnes but less

than 3 tonnes carrying capac-

ity will be charged 200/- per

hour, 1,000/- per day, 5,000/-

per week and 20,000/- per month.

According to TARURA vehicles of more than three tonnes carrying capacity will be charged 400/- per hour, 2,000/- per day, 10,000/- per week and 40,000/- per month, while application fees for special parking will be 20,000/- per month.

Inflation rate will remain in single digit - Nchemba

THE government has affirmed that inflation rate will continue to be in the single digit at least between 3.0 and 5.0 percent, a rate that is within the East African Community (EAC) agreement.

Minister for Finance and Planning, Dr Mwigulu Nchemba said this in the National Assembly yesterday when responding to a question from Special Seats lawmaker, Cecilia Pareso (CHADEMA) who had inquired to know when will the government control inflation that has been in a surge since December last year.

Statistics from the National Bureau of Statistics (NBS) shows that the Annual Headline Inflation Rate had increased from 3.2 percent that was recorded in March, 2021 to 3.3 percent in April, 2021.

In the NBS website, it was stated that the increase of headline inflation rate means that, the speed of price change for commodities for the year ended April, 2021 had increased compared to the speed that was recorded for the year ended March, 2021.

The overall index went up from 100.63 recorded in April, 2020 to 103.95 in April, 2021. Responding to the MP's question, Dr Nchemba (pictured) said that inflation went budget policy.



up in January 2021 to an average of 3.5percent from 3.2percent that was recorded during the corresponding period in December 2020. "This was caused by scarcity of some of the products in the market, something that usually occur during the beginning of the year," he noted.



Coal can help solve energy issue locally

cerns at upper policy making levels of government clash with economic priorities of lesser potential for profit making is how to use the plenty of coal deposits for instance in the southern part of the country. Intuition in the Ministry of Energy and its institutions for electricity and petroleum or gas development respectively essentially mark out coal as one source of electricity but at no point has serious investment been made in that direction. That isn't an accident as coal is environmentally negative and can only be profitably used as a last resort mechanism, as markets often have other options.

Mixing coal or coal dust with other combustible material in order to reduce the burning rate of coal is something that has always been possible but never used as coal isn't a user friendly sort of energy. Experts at the World Health Organization do not recommend the use of unprocessed coal in households due to carcinogenic emissions and toxic elements such as fluorine, arsenic, lead, selenium and mercury, which are not destroyed by combustion.

This has affected the thinking of local engineers for decades, who assert that chemical processing of coal to remove the sulphur would be essential before its domestic use.

That however isn't the story one hears from further afield, where direct coal is used for energy generation for industrial purposes, though its emissions level raises concern, but mixed with cow dung (which isn't hard to source locally), crushed coal (also known as coal dust)

ONE area where business con- make the country a desert isn't helpful, while prices of gas, despite being relatively low, are still on the higher side for most poor families. Coal dust can help.

The trouble with this aspect of things isn't that bureaucrats are too preoccupied with sulphur or mercury to pay attention, but rather that they may not make a profit out of it.

Making 'domesticated coal' out of crushed coal or coal dust for selling to poor households in replacement of charcoal isn't the sort of big money plan that TPDC or STAMICO executives think about, or even RUBADA. The latter however, as its area of concern has some of the most vital forested zones under threat, and its hydropower dreams were dashed by redrawing of the Rufiji basin hydropower plan, could pick up this assignment, at present.

As Dangote Cement in the southern regions has an interest in using coal, the two projects can be put together so that after the hard coal is used for industry power generation the coaldust that is available on site or in industry is mixed with cow dung at controlled quantities to obtain domestic burning material. It needs to be deliberately designed to cost much less than burnt wood (charcoal) fetches at present so as to discourage charcoal makers and bring users to the new briquette technology or suchlike. There was also a biogas idea in the past that looked exciting and requiring minimal capital layout, but culturally ill adapted.

It will take a while before each family in rural and poor urban areas can cough up 20,000/- to refill a small gas cylinder for




40 years into AIDS epidemic: Africa must embody the spirit of Ubuntu if we are to end AIDS - report

Forty years ago, on 5 June 1981, the Centers for Disease Control's Morbidity and Mortality Weekly Report described five cases of Pneumocystis pneumonia in gay men. The report foreshadowed the global AIDS epidemic, which has since resulted in over 75 million HIV infections and 32 million deaths worldwide.

Since the 1980s, we have witnessed remarkable moments in science and activism, and, in the last year of AIDS' 40th decade, а global pandemic so unexpected and fierce, it has rethink made us our preparedness for health emergencies past, present and future. A clear lesson from the colliding epidemics of HIV and COVID-19 is that if we do not put human rights and social justice at the centre of our response we are bound to fail.

Africa's new innovations and investments promise growth

Africa has long been known for comes with high returns. its resource abundance in both agriculture and mineral resources. To date, though, Africa has struggled to translate these resources into shared wealth and sustained economic development. New innovations and investments promise to change that picture and create exciting growth opportunities for business.

Investors generally expect higher returns from riskier investments. When a low-risk investment is made, the return is also generally low. Similarly, high risk

Investors, particularly novices, are often advised to adopt a particular investment strategy and diversify their portfolio. Diversification has the statistical effect of reducing overall risk.

An investor may bear a risk of loss of some or all of their capital invested. Investment differs from arbitrage, in which profit is generated without investing capital or bearing risk.

With less than ten years to go to reach our common goal of Ending AIDS by 2030 as part of the Sustainable Development Goals, the adoption of the new Global AIDS Strategy 2021-2026 -End Inequalities. End AIDS. by the UNAIDS Programme Coordinating Board earlier this year has been a pivotal moment in the global AIDS response.

At a moment in history where the AIDS response is off track, the strategy provides pathways on how to correct and accelerate it. We must shift our focus and remove the factors that create vulnerability to HIV, impede access to HIV treatment and prevention services and perpetuate discrimination: inequalities, lack of social justice and human rights violations.

The eastern and southern African (ESA) region remains the most affected by HIV in the world. In 2019, there were approximately 16.9 million people living with HIV in ESA. Between 2010 and 2019 the number of people living with HIV grew by 25% and in 2019,

there were 630 000 new HIV infections.

In 2019 it was estimated that, in ESA, 28% of all new HIV infections occurred among key populations, that is, sex workers, men who have sex with men, transgender people, people who use drugs and people in prisons. Legal and political barriers for key populations exist across the region, while funding is fickle and heavily donor dependant.

While this region remains one of the most affected by criminalization of sexual and gender identities, sex work and drug use. we see many instances in which key populations build and capitalize on their resilience and keep fighting for human rights.

Inequality and stigma and discrimination are major barriers to accessing health services. While the number of new HIV infections among adolescent girls and young women between the ages of 15 and 24 is at an all-time low, 4500 acquire HIV every week in sub-Saharan Africa. Laws continue to criminalize populations; social norms continue to hinder transformation towards gender equal societies and we continue to turn away from difference and diversity.

Sex and sexuality remain taboo to discuss, drug use is ignored and forgotten, people with disabilities remain invisible, and migrant populations are the first to be denied services as they "belong" to neither the country of origin nor the host country.

UNAIDS has shown how COVID-19 has had a detrimental effect on access to health care and how human rights, especially of key populations, have been violated.

The ESA region has contributed significantly to the new Global AIDS Strategy. We held more than 80 focus group discussions across the world with civil society in all its diversity, UN partners,

The 2021 high-level meeting will be the springboard for a decade of action to reduce inequalities and root out the social determinants that fuel the HIV epidemic. We are at a historic moment for the AIDS response, 40 years into the epidemic and 25 years since the creation of UNAIDS.

Last month, African Ministers of Health endorsed a Common Africa Position for the High-Level Meeting. The document articulates the continent's unified position and priorities for the next five years. I call on African Member States to use this position to negotiate the political declaration as a unified bloc.

As Africans, we must embody the spirit of Ubuntu-that is, that we are only people through other people. We must put people at the very centre of our deliberations. And this means all people, regardless of who they are, who they love or what work they do.

Why investing in women is key to achieving the sustainable development goals

IURSDAY 3 June marks the second anniversary of the massacre of protesters in front of Sudan's army headquarters. They paid the ultimate price for what they hoped would be a political transition that would usher in peace and democratic governance. Both have eluded the country since independence in 1956.

Two years into the political transition, progress is limited and the military continues to dominate over civilian leaders. Was the 2019 revolution just another Sudan uprising? Since independence, Sudan has had four coups. Only the October Revolution of 1964 and the April Intifada of 1985 led to democratically elected civilian governments.

An Institute for Security Studies report reveals that the current transition has followed a similar trajectory to the 1964-1965 and 1985-1986 power transfers. The opportunities and problems presented this time can be better understood by looking at lessons from the past.

Four similarities underpin the success of popular uprisings in 1964, 1985 and 2019 in toppling governments: mass civilian mobilisation; successful bargaining among political elites on how to overthrow the government; civilian leaders' ability to make deals with armed rebel groups; and political actors' success in convincing the military to support regime change once protests gained momentum.

While the 1964-65 and 1985-86 political transitions led to the election of democratic civilian governments, both were ousted in military coups within four years. Four major missteps defined their ultimate failure.

The first was an inadequate response to economic crises that the protesting masses regarded as urgent. The current transition faces a similar problem. Since August 2019, Sudan's economic situation has been deteriorating. The country continues to experience soaring inflation projected at 61.5% for 2020. While Sudan's removal from the United States' sponsors of terrorism list means it can access loans, debt relief and foreign direct investment, these have mostly been pledges rather than tangible financial support.

The second major failure of past transitions was to bring about sustained peace. Political parties and post-transition civilian governments didn't honour peace deals with armed groups. Two years into the latest process, agreements have been signed with numerous armed groups, but major provisions are yet to be implemented. One reason is that two main rebel groups with significant troops on the ground are yet to sign.

Negotiations are underway with one of these - the Sudan People's Liberation Movement-North. But talks with the other, the Sudan Liberation Movement (SLM), haven't officially started. The current peace deal will be difficult to implement in the regions where these groups operate.

Negotiations were also concluded in different processes, and not all political actors agree with the Juba peace agreement's provisions. More talks are needed to resolve outstanding issues related to establishing the legislative council, demobilising and reintegrating armed groups, and security sector reform.

Other provisions of the Juba peace deal have not yet been implemented. These include the transitional justice process and setting up a special tribunal to prosecute those accused of war crimes in Darfur. People with outstanding arrest warrants have also not been handed over to the International Criminal Court, and those who participated in the 3 June

massacre have yet to be held accountable.

Among other reasons, the delays relate to Sudan's penal law, which is yet to be revised to recognise human rights violations, war crimes and crimes against humanity as punishable by law. The establishment of different commissions meant to oversee these processes is also pending.

The third reason for the failure of previous political transitions is the lack of a shared vision for Sudan among political elites. This has been a major cause of Sudan's inability to adopt a permanent constitution since independence.

The current deep-rooted ideological and political rifts in the Forces of Freedom and Change (FFC) alliance show that history is repeating itself. The FFC can't agree on Sudan's economic reform, foreign relations, legal reforms, the drafting of the constitution and other major transition issues. This has delayed these processes from advancing and significantly weakened the comparative power of civilian actors.

The fourth failure was that major concessions made with the military ultimately disempower civil-

ian actors. Sudan currently has a civilian-led transitional government. However, substantial power resides with the military, which heads the Sovereign Council for the first half of the transition period.

As council head, the military has led vital processes in which it has vested interests. These include peace negotiations with armed rebels, transitional justice provisions that require military council members to go after their own, and economic reform. The military also leads the process to dismantle the old regime and its patronage system, and security sector reform

The Juba peace agreement has reset the time frame for the political transition. It's unclear when civilians are expected to take over leadership of the Sovereign Council and when democratic elections will be held.

The current transition mirrors all four of the key mistakes that derailed past efforts to establish civilian governments.

For Sudan's political transition to succeed, these problems must be addressed. Political actors need to balance the military's power, overcome discord

in the FFC and enable the transitional government to implement its goals.

The Constitutional Document provisions on the terms for the transition period must be adhered to. While the Juba peace process has revised some of these provisions, it hasn't set clear timeframes for the transition and related processes.

Sudan's democratic future requires a constitution based on inclusive national dialogue. For this to work, political actors from the FFC, armed groups and others excluded from the FFC must overcome their deep political divisions and find common ground. Only then will the country's transition succeed this time.

Boat dwellers in SE China's Fujian province move ashore, embrace better life

Y relocating local fishermen who lived on boats to a hospitable living environment on the shore, Xiaqi village in southeast China's Fujian province has ushered in opportunities for development and embarked upon a distinctive path of rural vitalization.



The once little-known village nestled near the sea in Xiabaishi township, Fu'an city of Fujian, is now famous for helping residents move ashore.

With well-arranged rows of houses and straight roads extending in all directions, residents in Xiaqi village who had long been plagued by poverty see great improvements in their life.

Over 20 years ago, however, Xiaqi village seemed nothing like an ordinary village. By tradition, villagers stayed on boats and fished for a living against the winds and waves all the year round.

For these boat dwellers, a small wooden boat could be the home of several generations of a local family.

"My family, which had six members, lived on a boat that was less than 14 square meters in area. The cargo hold was filled with fish we caught and daily necessities. At night, we would curl up on the deck." recalled Jiang Chengcai, a resident in Xiaqi village.

The interior of the boat was always wet in windy and rainy days, according to Jiang, who added that they were often faced with the risk of losing their lives as the boat could be turned over when typhoons came.

"I remember that my parents used to tie me to our boat with a rope when I was little for fear that I might accidentally fall into the sea, as they needed to go fishing and couldn't take care of me," said Zheng Yue'e, the Party chief and also a native of Xiaqi village.

All the fishermen in the village had eagerly wished that one day they could move into new houses on the shore, sleep well at night, gain access to electricity and have enough food.

Their dream for a new life became possible in 1997, when relocating local fishermen ashore was listed as an important task of the poverty alleviation policy in Fujian, and the first batch of resettlement projects were initiated in Xiaqi village.

"It felt strange when I first started to sleep on a stable bed board instead of a jolting boat. Seeing the bright lights and feeling the walls in my new house, I realized that my over 30 years of life on the boat was finally behind me," Jiang said. He was so excited that he lost sleep the first night he lived in his new house on the shore.

From 1997 to 1999, Xiaqi village built 339 houses and relocated 2,310 fishermen in batches. So far, all 3,571 local fishermen who lived on boats have settled on the shore, and bid farewell to their old life, while Xiaqi village has also started to glow with new vigor.

out 22 favorable policies, the local government has encouraged former boat dwellers to vigorously explore aquaculture, fishing, marine transportation, commerce, tourism, and other industries to shake off poverty and march toward prosperity.

After moving ashore, Jiang has participated in training organized by the village on razor clam raising, and later signed contracts with local government to use about 6.7 hectares of mudflats for the business together with over 20 fellow villagers. They earned an average annual income of 70,000 to 80,000 yuan (\$10,860 to 12,412) from raising razor clams.

Later, Jiang led more than 30 villagers to setting up a construction and engineering team, which undertook pile foundation projects in Xiabaishi township and its neighboring areas. These efforts have made Jiang one of the front-runners in the village in pursuing a better life.

Zheng was elected the chief of Xiaqi village in 2012. Since then, she has made it an important task of her work to create wealth for villagers by developing sea-based industries.

Taking advantage of local resources, she guided villagers to large yellow croaker cage farming, seafood wholesale and processing, among other industries

Meanwhile, Xiaqi village has continuously improved infrastructure and beautified the living environment. With its brand new look and distinctive

history, it has attracted many tourists who come for sightseeing and recreation.

In 2019, nine registered poverty-stricken households in Xiaqi village were lifted out of poverty. Today, the per capita income of the village has surged to over 23,000 yuan from less than 1,000 yuan in 1997.

With the implementation of projects, including those launched to build cold stores of a seafood distribution station and a street featuring seafood in the future, Xiaqi village is expected to take an even wider path of rural vitalization through developing marine industries, while local people will continue to take big steps toward a better life.

Life below water : The UN calls for action on ocean protection

RESIDENT of the United Nations General Assembly Volkan Bozkir has told a high-level debate on oceans that the world cannot afford to delay action on ocean protection. "There is simply no scenario wherein we live on a planet without an ocean," he said.

The debate, which focused on the ocean and Sustainable Development Goal (SDG) 14: Life Below Water, took place on Jun. 1 at the UN Headquarters in New York.

It comes ahead of the Jun. 8 observance of World Oceans Day and against the backdrop of the pandemic-related postponement of the 2nd UN Ocean Conference - a major international gathering which seeks science-based solutions to sustainable ocean use.

The high-level debate was billed as a 'drumbeat' to maintain momentum ahead of the conference, now expected to take place in Lisbon next vear.

The General Assembly President said the pandemic has revealed an "appetite for change" among people who do not want to live in a world of "one crisis after the next". He said this change is possible.

"As our understanding of the true benefit of a healthy planet grows, policymakers are increasingly aware of how central a healthy ocean is to a healthy economy," he said.

"We have seen this in countries and cities that prioritised coastal and marine areas over-tourism, we have seen this in protected wetlands, we have seen this in efforts to address illegal, unreported and unregulated fishing, and regulate shipping and resource extraction. Why then can we not combine and scale up our efforts?'

The UN has been at the forefront of efforts to mobilise financial, scientific, volunteer and community support for oceans, through initiatives such as the 2021-2030 Decade of Ocean Science.

The high-level debate builds on those ocean conservation and sustainable use measures.

Special Envoy of the Secretary-General on Oceans Peter Thomson told the forum that while there have been improvements on this front,

including increased marine protected area coverage and a better understanding of the issues that impact the ocean, progress has not been adequate to address the ocean crisis.

"How can we claim success when a third of assessed global fish stocks are being overfished? When with no tangible end in sight, we have dumped around 150 million metric tons of accumulating plastic waste, microplastics and discarded fishing gear into the ocean? And while the rates of ocean acidification, deoxygenation and warmth are all continuing to head in the wrong direction?"

With 97 percent of the water on the earth's surface, the ocean is vast. It serves as a source of food and en-

ergy, while facilitating commerce, transportation and communication. Sustainable Development Goal 14 lists specific targets to reduce pollution, protect marine ecosystems, tackle illegal and over-fishing and oversee sustainable resource use.

One region taking action to address ocean issues and achieve SDG 14 is the Eastern Caribbean.

In 2012, the Organisation of Eastern Caribbean States (OECS) established an Oceans Governance Team, a regional body that oversees work on oceans governance. The team helped to develop the Eastern Caribbean Regional Ocean Policy (ECROP) which articulates the countries' vision for the ocean and principles of ocean governance.

One of the major ECROP initiatives is the Caribbean Regional Oceanscape Project, known as CROP. Through a partnership with the World Bank, CROP, with its tagline 'championing resilient oceans for prosperity,' is helping the Caribbean transition to a blue economy.

"We focus on economic growth, but we also ensure that we are conserving the resources, so that we are not damaging them and impairing our future benefits. It's really the same sustainable development agenda, focusing on the economics, the environment and the social aspects relating to the oceans," Susanna Debeauville-Scott, Project Manager in the Ocean Governance and Fisheries Unit at the OECS Secretariat, based in Saint Lucia, told IPS.

For the Caribbean, the goal is to propel discussion on ocean issues and action for the protection and sustainable use of its resources. The Unit is overseeing initiatives like Building Resilience in the Eastern Caribbean through a Reduction in Marine Pollution (ReM-Lit) to tackle marine waste.

Chinese vaccine experts share production know-how in Pakistan

ISLAMABAD

AKISTAN'S pandemic efforts have received a "booster shot" as the first batch of locally-produced COVID-19 vaccines is rolling off the line here at a national lab.

As many as 120,000 doses have recently been produced at Pakistan's National Institute of Health (NIH) under rigorous quality control with tech support from Chinese pharmaceutical firm CanSino.

Local health authorities welcomed the vaccines as a major landmark in Pakistan's efforts to attaining vaccine self-sufficiency, a much-needed, yet challenging task that Pakistan had fervently hoped to fulfil within months.

"The cooperation between the

for the South Asian country, key aspects of which, including facilities and quality control standards, had to start from scratch, said Xin, who also leads a taskforce with members from both countries.

The task was further challenged by the global supply shortage including key equipment for a lab, chemicals necessary for the production, and subsequent reliance on some manual work.

"It's like we were asked to start our experiments in an empty room," Xin recalled.

Despite all these challenges, the team created a facility that can conduct analyses such as westernblotting essential to the production process.

Working alongside Chinese counterparts has enabled Pakistani members to gain hands-on

The localization came as another first-time experience for the South Asian country in COVID-19 vaccine technology, after a successful phase III clinical trial of the vaccine under the cooperation between the NIH and CanSino.

So far, the Drug Regulatory Authority of Pakistan has approved three types of Chinese vaccines developed by pharmaceutical companies Sinovac, CanSino and Sinopharm, for emergency use.

Technology transfer enabled by bilateral cooperation has helped Pakistan to stride forward in achieving vaccine production capacity, said Ghazala Parveen, chief of the Biological Production Division at the NIH.

"The technology transfer is extremely crucial for the people of Pakistan. It helps us save money rather than buying vaccines from other countries," said Saba Haq, research official at the NIH.

Doctors, healthcare workers sound alarm over health risks of the climate change

A growing number of doctors and front-line healthcare workers are turning to climate activism to urge global leaders to declare climate change a public health emergency.

Doctors and health workers, some clad in white coats and brandishing placards, marched to the headquarters of the World Health Organisation (WHO) in Geneva on Saturday to demand that health authorities and governments prioritize climate change to avert a global health crisis.

Their demands for immediate action included a focus on preventative healthcare with education programmes in schools and the wider community, more equitable distribution and access to medical care, reducing the carbon impact of health care, and stricter control of industries to ensure clean water and air.

Underscoring the progressive nature of their platform, the protesters also called for the creation of citizen assemblies to steer strategic health decisions. Their demands were listed in a petition, signed by more than 1,200 prominent doctors and healthcare workers from around the world.

WHO Chief Dr. Tedros Adhanom Ghebreyesus, who welcomed the protesters, said that while "the pandemic will end, there is no vaccine for climate change". He later tweeted that health and climate change were "inextricably intertwined" and that the WHO would be "standing in solidarity and urging global action" with the demonstrators.

Indeed, the WHO and the prestigious Lancet medical journal have declared climate change the biggest threat to global health in the 21st century - a declaration made even before the Covid-19 crisis.

Front-line health workers and researchers may have been sounding the alarm on climate change for years, but it is only recently that more voices have stepped up to lead rallies, sign petitions and publish studies with the same fierce urgency as grassroots activists.

Professor Valerie D'Acremont, an infectious diseases physician and global health specialist at Lausanne University Hospital, is among those speaking out.

D'Acremont, who mainly divides her work between Africa and Europe, said that frustration has driven her towards more health advocacy work because "governments and the public have failed to understand the strong links between climate change and biodiversity loss and health".



"We want governments to take action," she said. "Many of us feel it makes no more sense to do our job because we are fed up with being always behind, preparing for the next health catastrophe instead of acting on the root causes of the problems. Covid-19 is one illustration of this problem."

A rise in cases of dehydration and heat stroke, and floods that spread cholera, are real consequences if countries continue on their current trajectories. Then there are the diseases not seen before in Europe, such as Dengue fever, that have reached France, Spain and Croatia. Cases of Zika have also been found in southern Europe.

Others - such as tick-borne encephalitis and the West Nile virus, which are already present in the United States - are also cause for concern.

"Some diseases like cardiovascular and respiratory illnesses will increase more strongly, but it's harder for people to make the link to climate change because they already exist,"

D'Acremont said.

D'Acremont is also a member of Doctors for Extinction Rebellion (Swiss chapter), the group behind Saturday's rally. It emerged as an offshoot of Extinction Rebellion; an environmental activism group that gained notoriety in the UK in April 2019 for hugely disruptive demonstrations that brought downtown London to a standstill and drew the ire of thousands of commuters caught up in the chaos.

British Prime Minister Boris Johnson was prompted to weigh in, dismissing the climate change protesters "crusties" who live in "hemp-smelling bivouacs".

But the British prime minister's caricature of climate activists missed the mark: a core group of front-line health workers and doctors branched off to create Doctors for Extinction Rebellion, keeping the name and merging climate activism with public health.

Dr. Rita Issa, a London-based general practitioner, academic and co-founder of Doctors for Extinction Rebellion in the UK, says that

she felt a "moral duty" as a doctor to speak up about climate change. She said she is already seeing an alarming number of patients, including children, in her clinic who suffer from a variety of health problems linked to climate change.

"Patients come with a host of factors that impact their health, like the food they eat, the houses they live in and the air they breathe," Dr. Issa said. "I'm seeing children with 10 percent reduced lung capacity. If we're truly to address their health we also have to tackle the air they breathe. If we don't want to have to treat kids with worsening lung capacity and heatstroke, then we need to take action now."

Dr. Issa's findings in her clinical practice are backed up by scientific data.

Results from a study published Monday in the journal Nature Climate Change showed that more than a third of heat-related deaths around the world from 1991 to 2018 were the result of human-induced global warming. More than 43 countries in the study recorded heat levels higher than the optimal temperature for human health.

Researchers also found that the health impacts of climate change were already being felt. Despite Covid-19 lockdowns, which saw a global fall in pollution levels last year, global temperatures still rose to 1.2° Celsius above pre-industrial levels, edging close to the 1.5°C maximum benchmark set by the world's nations.

The shock of the Covid-19 pandemic illustrated that there is a public health issue that "doesn't respect national boundaries, or care if you're rich or poor", said Dr. Issa, adding that she believed the crisis helped the health aspect of climate change break into the mainstream.

While she understands that activism is not for all doctors, Dr. Issa believes that "medicine is inherently political".

"We have a responsibility to pick up signs of things early, as part of our work as doctors, and it extends bevond individual patients. Part of the reason we founded Doctors for Extinction Rebellion was to direct insight on how issues impact our patients and community, and to communicate scientific information into something digestible."

United Nations condemns deadly attacks targeting displaced people in DR Congo

UN Secretary-General António Guterres has urged authorities in the Democratic Republic of the Congo (DRC) to investigate recent deadly attacks by insurgents in the east and bring the perpetrators to account.

At least 55 people were killed, and many others wounded, in the overnight assaults on Monday, which targeted camps hosting internally displaced people near the towns of Boga in Irumu territory, Ituri province, and Tchabi, North Kivu province. They were carried out by suspected members of the Allied Democratic Forces (ADF) armed group.

A Quick Reaction Force from the UN mission in the DRC, known as MONUSCO, was deployed to the area, and peacekeepers also assisted the wounded, including with medical evacuations.

The UN chief has strongly condemned the attacks, according to a statement issued on Tuesday by his Spokesperson, Stéphane Dujarric.

deepest condolences to the families of the victims and wishes a swift recovery to the injured", it said.

"He calls on the Congolese authorities to investigate these incidents and bring those responsible to justice.'

The Secretary-General also underlined the UN's continued support to the Congolese government and people in their efforts to achieve peace and stability in the east.

The two villages that were attacked

"The Secretary-General expresses his are located on the border between Ituri and North Kivu provinces in an area where the ADF are known to be active, according to media reports. Congolese forces have been battling the group for decades.

The UN's top humanitarian official in the country, David McLachlan-Karr, who also condemned the attacks, noted that houses were set on fire and civilians were abducted.

He said this "tragic situation" followed the looting last Friday of a facility be-

longing to a humanitarian partner in Djugu territory, Ituri province, causing the temporary suspension of their operations in the area.

"These attacks are unacceptable", McLachlan-Karr said in a statement on Tuesday.

"Parties to the conflict must protect civilian populations and these crimes must not go unpunished. Communities, already very vulnerable, must be able to live in peace wherever they are and return to their homes in safety."



'Sex for a fare' motorcycle drivers threaten Uganda's fight against Aids

UGANDA'S motorcycle taxis riders threaten to derail the country's fight against HIV because of risky sexual behaviours, including sex with clients in lieu of payment, according to a new study.

At least 12% of a sample of 281 commercial riders, a common informal job known as boda boda and dominated by young men, admitted to engaging in transactional sex with customers who failed to pay their fares; 65.7% reported having had sex with more than one partner in the past 12 months; and 23% had had multiple partners in the same period, with 57.1% reporting that they did not use a condom at all in the six months prior to the survey, conducted by Makerere University College of Education and External Studies (CEES).

"Engaging with multiple sexual partners is a high-risk sexual behaviour, especially in the absence of condom use. It leads to sexually transmitted diseases like HIV, and unwanted pregnancies," said Lillian Mbabazi, a researcher at CEES, presenting the research findings at a workshop in the capital, Kampala, last week. "It shows a need to educate young Ugandans to understand unsafe and irresponsible sexual behaviour."

The study was conducted in the districts of Wakiso and Namayingo.

"The revelation from this study, that customers who can't afford to pay their service freely offer sex and a high proportion are actually engaging in risky sexual behaviours with multiple partners without a condom, is concerning," Daniel Byabakama, head of HIV prevention at the Uganda Aids Commission (UAC), said.

"The HIV infections will definitely go up. The boda bodas need to know that HIV is still real and people are still contracting the virus," he said. Uganda has a 5.6% HIV prevalence rate.

"This study is a wake-up call that if we keep on scaling down the targeting of these boda bodas as a high priority, then we may end up in shock," said Byabakama.

"We should continue prioritising them, helping them and offering HIV prevention services, such as free condoms, so that they don't contract or transmit the virus.'

Some of the boda boda riders in Wakiso told the Guardian that transactional sex and multiple sexual partners were occupational risks.

"What do you expect me to do with a client who can't afford to pay the fee and offers you sex instead," said Patrick*, a boda boda rider at Kyaliwajjala. "I can't just let her go free. Of course I will have sex with her in exchange."

"Some of these clients are just stubborn and tempt us. The ladies intentionally refuse to pay and offer you a sex deal. If you are interested, you fall and go for it," said Joseph adding "Of course, most of the time you might not be having a condom. You end up having live unprotected sex."

Byabakama said it was a worrying picture: "We are seeing resurgence of bad sexual behaviours among this group, they are having sex with multiple sexual partners, they don't first test for HIV, and a good number of them don't use condoms. This is worrying.

"They don't care about avoiding HIV because they think there are ARVs It's a misconception. We continue to encourage them to practice HIV prevention measures as we have always taught them. We need to rekindle and reinvigorate the campaign."

Paul Birevu Muyinda, deputy principal at CEES, said the "nomadic" industry was booming and employed more than 50% of people aged 18-35 in the east African country, but riders face myriad health risks.

"The solution is to organise and bring order to the industry. Make it a safe

and gainful industry and provide continuous professional training aimed at bringing positive behavioural change," said Muyinda.

"These project findings will go a long way in helping the government to develop scientifically proven evidencebased interventions aimed at influencing behavioural change of boda boda riders in Uganda," said James Katunguka, road safety officer at the ministry of transport.

funding for a digital project

THE World Bank has approved the Digital Tanzania Project (DTP) with a financing of \$ 150 million from the International Development Association (IDA).

The project aims to increase access to high quality broadband internet services for the government, businesses and citizens, and improve the government's capacity to deliver digital public services.

The targets will be achieved through the following components, the digital ecosystem - strengthening the laws, policies, regulations, institutional capacity, and human capacity needed to promote information and communication technology (ICT) infrastructure investment, market competitiveness, digital engagement, job creation, and innovation; digital connectivity - ensuring access to affordable, high quality internet services for all citizens, including in rural areas and for critical government institutions. Building the technical capacity, skills, institutions, and local digital infrastructure for the government to deliver services to citizens and conduct its own business digitally. By the end of the project implementation, more than 75 percent of Tanzania's population will be covered by a mobile broadband network signal (3G or higher); some 425 government ministries, departments and agencies will benefit from broadband internet service; and a minimum of 40 percent of citizens (aged 15 and above) will be able to use the internet.

The number of monthly transactions accessing a public service via the internet or a mobile phone will increase from 200,000 to at least 500,000.

Child marriage and domestic violence: What we found in 16 African countries

NAIROBI

HE number of girls who marry before their 15th birthday has remained unchanged for 20 years in most countries in sub-Saharan Africa. The region has the highest rate of child marriage, with nearly four in 10 girls married before age 18. In Niger, for example, over 77% of girls are married before the age of 18.

This is despite efforts by governments, developmental partners and civil society organisations to end the practice. There are many reasons why it continues.

These include inequitable gender norms, laws that permit children to be married in some settings in sub-Saharan Africa, inadequate investment in girls' education, poverty and unintended pregnancy. In addition, child marriage is backed and justified by culture and religion.

The effects of child marriage on the health and wellbeing of girls are far-reaching and lifelong. It harms their overall health and socioeconomic wellbeing, the survival of their children, and the prosperity of their family and community.

Because child marriage harms girls' physical health and socioeconomic wellbeing, it is considered a human right violation.

The health consequences of child marriage have received significant attention. But only a few studies have examined the relationship between child marriage and intimate partner violence. One study done in Vietnam in 2013 found that there was a link between the two.

Our study examined the relationship between child marriage and intimate violence in sub-Saharan Africa. We analysed the most recent demographic and health survey data of over 28,000 young women in 16 countries in the region.

The survey data encompasses several health and wellbeing indicators including domestic violence. We ex-

We found that girls aged 20-24 years who married before they turned 18 were 20% more likely to experience intimate partner violence than those who married as adults.

Our research

Our principal aim was to assess the association between child marriage and intimate partner violence - physical, sexual or emotional from a partner. We also compared the rate of intimate partner violence between those who married as adults and those who married as children in the past 12 months.

We analysed data of countries from all four sub-regions within sub-Saharan Africa. In Central Africa, we included Angola, Cameroon and Chad. From West Africa we included Benin, Mali and Nigeria and from the east Burundi, Ethiopia, Rwanda, Tanzania and Uganda. Within Southern Africa, Malawi, Mozambique, South Africa, Zambia and Zimbabwe were selected. Countries were selected on the basis of the availability of recent survey datasets.

the respondent into unwanted sexual acts.

Our analysis of the demographic and health survey data showed that child marriage prevalence ranged from 13.5% in Rwanda to 77% in Chad. Intimate partner violence ranged from 17.5% in Mozambique to 42% in Uganda.

Past year experience of intimate partner violence was higher among young women who married or began cohabiting before the age of 18 (36.9%) than those who did at age 18 or more (32.5%).

This result was consistent for all forms of violence: physical violence (22.7% vs 19.7%), emotional violence (25.3% vs 21.9%), and sexual violence (12% vs 10.4%).

After accounting for the contributions of important socio-demographic characteristics such as educational level, place of residence, wealth status and exposure to mass media, we found that child marriage had a higher association with intimate partner violence than marriage at adulthood.

Ways forward

Overall, our findings reaffirm the link between child marriage and intimate partner violence. We found that there was a higher likelihood of intimate partner violence in 14 of the 16 countries. Angola and Chad stood out as exceptions.

As our results show, child marriage is associated with a higher likelihood of intimate partner violence in most sub-Saharan African countries. This suggests that ending child marriage would result in a substantial reduction. There is therefore a need to institute policies to support and protect women who marry as children from abusive relationship.

Fighting cultural norms that make men unaccountable is critical to ending both child marriage and intimate partner violence. And this can be done through the creation of strict laws. Currently, 43 of the 55 African Union member states have legal frameworks that put the minimum age of marriage at 18 years old or above for both boys and girls. However, 27 of these states allow child marriage with parental or guardian consent and the approval of a judge, court or state. Ten countries allow for the marriage of girls as young as 10. One, the Saharawi Arab Demo-

The demographic and health survey had questions to measure each of the indicators. These questions relate to the experience of:

Physical violence: women had been asked whether their partners had ever pushed, shaken or thrown something at them, slapped or punched them, kicked or dragged them.

Emotional violence: women had been asked if their partner ever humiliated them, threatened them with harm, insulted or made them feel bad. Sexual violence: questions had included whether the partner ever physically forced cratic Republic, has no law against child marriage.

All countries should have laws. And these should be strictly enforced. Community sensitisation on the damaging effects of both child marriage and intimate partner violence is equally critical. HELIOS TOWERS BACK MOUNT KILIMANJARO TREE PLANTING **CAMPAIGN WITH 7K SEEDLINGS**

IGO Green for Kili campaign which seeks to plant over 28,000 trees at the foot of Mount Kilimanjaro to restore its virginity and help reclaim its thawing ice cap has received 7,000 tree seedlings from Helios Towers Tanzania Limited.

According to United Nation Environment Programme, restoration and other natural solutions can deliver one third of the mitigation needed by 2030 to keep global warming below 2C while also helping societies and economies adapt to climate change.

Restoring 15 percent of converted lands in the right places could prevent 60 percent of projected species extinctions while ecosystem restoration contributes to the achievement of all 17 of the Sustainable Development Goals by their 2030 target date, including the elimination of poverty and hunger, UNEP said.

How BPR supported businesses negatively affected by pandemic

KIGALI

As a majority of business ground to a halt in much of 2020 due to the Covid-19 pandemic and measures to curb it, the transport sector emerged as one of most affected. This among other things affected transport sector businesses' ability to service loan obligations as well as pay suppliers and employees.

Among the businesses that experienced the challenges first hand were Matunda Express Ltd, a popular transport business with a fleet of over 25 buses plying between Kigali and Ngoma District, Kigali and Rusumo and Kigali-Mahama in the Eastern Province.

Eulade Bayingana the Founder and Managing Director of the firm said that before the pandemic, business was booming with operations running without any liquidity challenges. "I always paid my suppliers and employees on time and everything was going smoothly. When the pandemic came by, the government took measures to contain the spread of the virus including lockdowns and prohibiting movements of people between Kigali and other districts," he said. Bayingana said that with the pandemic halting operations, he had challenges paying suppliers and honouring monthly loan instalments. "I started getting into arrears and this worried me so much because I had never experienced it before, things were not good at all," he said. It is then when things were 'thick' that Bayingana said that he was approached by his bank, BPR, with insights on the Economic Recovery Fund, a fund set up by the government to support businesses affected by the pandemic. "I was not even aware of the fund's existence but the bank took me through the whole process and helped me secure funds that helped me revive my business," "As we speak, we resumed work; I am now in good books with all my suppliers and my bank, I also managed to reinstate into employment all staff that had lost their jobs.... I thank my bank, BPR in a very special way, because if it was not for them, I do not know where my business would be now," Bayingana said. This is one of many clients who have benefitted from the bank to access and utilize the economic recovery fund. Across the market, banks have disbursed up to Rwf13 billion. The bank has also supported businesses by restructuring customer loans by granting repayment moratoriums to over 2,800 customers holding 25 per cent of all outstanding loans. Banque Populaire du Rwanda Plc recorded an aftertax profit of Rwf 3.8 B in 2020 amid the global pandemic that has slowed down local and international economic activity.

Kenya urgently needs law on street-naming

NAIROBI

Apart from the drama surrounding her controversial nomination and subsequent appointment

On the upside, we also have appropriately named streets and roads which have immense historical significance such as Kenyatta Avenue, Tom Mboya Street, Ronald Ngala Street, Prof Wangari Mathai Road, Haile Selassie Avenue, Nyerere Road, Waiyaki Way, Muindi Mbingu Street, James Gichuru Road, to name but a few. The unfolding Francis Atwoli Road saga invites us no single lane named after to reflect on the manner in which we name the streets and roads in our urban areas. In more enlightened countries, street and road names are treated as a national resource, given as a badge of honour to preserve the memory of national or local community heroes whose lives are worthy of emulation by society in general and the young generation in particular. Those countries have clear laws and policies which define the eligibility criteria and prescribe the process of naming such monuments. In contrast, a cursory look at the names of most of our roads reveals a haphazard and unimaginative exercise conducted in an opaque style based on the whims of the city or town





as Nairobi Deputy Governor, perhaps the most newsworthy official action taken by Ann Kananu Mwenda since assuming office as "acting" Nairobi Governor has been the equally confounding renaming of Dik Dik Road in Kileleshwa, Nairobi, to Francis Atwoli Road.

For the benefit of our readers in Antarctica, Francis Atwoli is the ebullient trade unionist and maverick secretary-general of the ubiquitous Central Organisation of Trade Unions (Cotu) in Kenya. The acting governor's unilateral decision to honour the trade unionist with a road name, almost like a personal birthday gift, appears to have drawn the instant ire of many Kenyans if the raving and ranting on social media is anything to go by.

It would appear that some Kenyans were so irked by the idea of Francis Atwoli Road that they uprooted the signpost within 24 hours of its erection. The drama, however, heightened a notch higher when the signpost was reinstalled on the same day. It took no less a personage than Mr Atwoli himself to announce that the signpost had not only been reinstalled but CCTV cameras had also been deployed to guard it.

Senegal architects

ditch concrete for earth in revival of old techniques

DAKAR

Construction is booming in Dakar, where unfinished apartment blocks tower over most streets, their exposed concrete bricks a dull uniform grey. In one site, however, a building stands out - the bricks the workers are laying are made of raw, red earth.

Concrete is inexpensive and used with abandon in Senegal's capital, but it is poorly suited to the West African heat. On summer days, when temperatures frequently reach 38°C, the buildings become furnaces, cooled only with blasts of air conditioning.

Earth naturally regulates heat and humidity, say the founders of Worofila, an architecture firm specialising in bioclimatic design. Since 2016, they have been pushing for the material to make a comeback. They say it could reduce pollution from cement factories and electricity production - and keep people cool.

"Before air conditioning, people paid attention to materials and orientation for the natural regulation of heat," said Worofila co-founder Nzinga Mboup, while workers laid bricks for the upper floors of what will be a family home with a pool. "The moment A/C arrived, these considerations went out the window."

Senegal's traditional dwellings were made of mud, but that has been abandoned. Dakar's sidewalks today are littered with piles of sand and stones that are mixed with cement to make cheap building blocks. To make modern earth bricks, workers mix soil with smaller amounts of cement and water to create a mixture that they cut into blocks, compress with a hand-operated machine and leave to dry for 21 days. Unlike concrete, earth bricks require little energy to produce. Cement, the main ingredient in concrete, accounts for 8% of carbon dioxide emissions, according to British think tank Chatham House. Earth construction is niche. It costs more than concrete and many people are unaware of the option. Worofila has been longlisted for an Ashden Award, a British prize for climate solutions, which it hopes will raise visibility. "At the start we were looking for clients. Today we don't look for them. We have a lot of demand," said Doudou Deme, who in 2010 founded Elementerre, which makes earth bricks in Senegal. **Elementerre and Worofila have** partnered on private homes, offices and part of a train station, but have barely made a dent in Dakar's construction scene. Still, when Mboup explains the concept it resonates, she said. People remember that their grandmother's mud house in the village was always the coolest.

WORLD **Israeli opposition** announces new govt, set to unseat **Ben Netanyahu**

ISRAELI Prime Minister Benjamin Netanyahu yesterday fought back against an agreement by his political opponents for a government of left-wing, centrist and right-wing parties aimed at unseating him.

Netanyahu (pictured), facing the prospect of an end to his 12-year run as premier, said on Twitter "all legislators elected by votes from the right must oppose this dangerous left-wing government".

It was the first public pushback by Netanyahu, who heads the right-wing Likud party, against centrist politician Yair Lapid's announcement about 35 minutes before a Wednesday night deadline that he had succeeded in forming a governing coalition.

Under the deal, nationalist Naftali Bennett, 49, a former defence minister and a high-tech millionaire, would become prime minister and hand over the post to Lapid, 57, a former TV host and finance minister, in about two years.

The agreement capped a March 23 election in which neither Likud nor its allies nor their opponents won a majority in the legislature. It was Israel's fourth national ballot in two years.

The coalition comprises a patchwork of small and medium parties from across the political spectrum, including for the first time in Israel's history one that represents its 21 percent Arab minority - the United Arab List.

They have little in common other than



a desire to oust Netanyahu, whose is also on trial on corruption charges. He denies any wrongdoing.

The lineup includes Bennett's Yamina (Rightward), centre-left Blue and White, headed by Defence Minister Benny Gantz, the left-wing Meretz and Labour parties, former defence minister Avigdor Lieberman's nationalist Yisrael Beitenu party and New Hope, a right-wing party headed by former education minister Gideon Saar, who broke away from Likud

Political analysts have widely expected Netanyahu to try to pick off what one described as "low-hanging fruit", seizing upon Yamina members who are unhappy about joining forces with Arab and leftist lawmakers.

Tamar Zandberg, a Meretz legislator, acknowledged the difficulties in getting the alliance that her party joined off the ground.

'The coalition's test...is to be sworn in - that won't be without rough patches and problems," she said on Army Radio on Thursday.

Netanyahu controls 30 seats in the 120-member Knesset, almost twice as many as Lapid's Yesh Atid party, and he is allied with at least three other religious

and nationalist parties.

Stability

A source involved in the coalition talks said the proposed new government would try to retain consensus by avoiding hot-button ideological issues such as whether to annex or cede occupied West Bank territory that Palestinians want for a state.

Bennett has said that the creation of an independent Palestine would be suicide for Israel. He made annexation of parts of territory that Israel captured in the 1967 Middle East war a major feature of his political platform but following through on that with the broad new coalition looked to be politically unfeasible.

But any new flareup along Israel's volatile border with Gaza, nearly two weeks after a ceasefire ended 11 days of fighting with the Palestinian enclave's ruling Hamas group, could challenge the stability of the broad alliance.

During his tenure as prime minister, Netanyahu has been an often polarising figure at home and Agencies abroad.

"And that's why I'm sitting here in this chair talking to you," Kluge (pictured) said in an interview for TASS. "And I am very grateful to the administration of the president of Russia for inviting me, and for putting health - with the minister and other partners - at the top of the political agenda."

He also praised the contribution of Russian medics to the fight against the coronavirus pandemic, relaying a "low bow" of gratitude to them. "I want to thank all the health workers in the Russian Federation.

I would like to say: 'nizkiy poklon'," Kluge said, using a Russian expression for deep gratitude. He pointed out that the work of medical workers remains in very high demand, noting that they have to deal with heavy load.

Since the beginning of the pandemic, some 171.2 million people have contracted the coronavirus infection, over 3.5 million of them died.

According to the federal statistics, 5,090,249 cases have been registered in Russia, with 4,702,599 recoveries and 122,267 deaths. Russia was the first country in the world to register its coronavirus vaccine - the Sputnik V - on August 11, 2020.

This vaccine is currently registered by regulators of about 60 countries with total population of over 1.5 billion. **Agencies**

UN tribunal scraps new trial of Hariri assassin due to funding crunch

THE HAGUE

JUDGES at a UN tribunal for Lebanon have scrapped a new trial against the man convicted of the 2005 assassination of Prime Minister Rafik al-Hariri, because they expect the court to run out of money and be forced to shut down before it can finish.

Last year the tribunal, located near The Hague, convicted Salim Jamil Ayyash, a former member of the Shi'ite movement Hezbollah, in absentia for the bombing that killed veteran Sunni Muslim politician Hariri (pictured) and 21 others. That ruling is being appealed.

A second case was meant to begin on June 16, prosecuting Ayyash for another assassination and other attacks on other Lebanese politicians in 2004-2005.

But in a decision published yesterday on the court's website, the judges wrote they had canceled the case, "considering it is futile to start a trial in June which is highly likely to be terminated in July due to lack of funds".

Earlier this week, the Lebanon tribunal announced it will have to close after July if it is unable to resolve its funding shortage.

An exclusive report by Reuters last week revealed the tribunal, which is funded 51 percent by voluntary contributions and 49 percent by the Lebanese government, had run out of money.

Former Syrian diplomat says CPC represents mixture of principles, flexibility

The friendship between China and Kazakhstan, as permanent comprehensive strategic partners, is built on a deep foundation and powered with strong impetus, Xi said.


In promoting the high-quality building of the Belt and Road, Xi said the two sides

Aliyev said Azerbaijan welcomes investment by more Chinese businesses, and the nation stands ready to step up communication and cooperation with China on regional affairs.



According to preliminary estimates, when all the 1,100 workboats in the Taihu Lake basin become electrified, the transformation from fuel oil-powered boats to electric ones will reduce carbon dioxide (CO2) emissions by 75,000 tonnes a year, which is equivalent to the amount of CO2 discharged by more than 27,000 private cars.

"In the past, the fuel oil-powered workboat would leave an oily track Wuxi, east China's Jiangsu province. on the surface of the water and the

powerful and faster, yet it doesn't leave any pollutants," said Li Fenglei, a driver of the workboats in the Taihu Lake basin.

Since the beginning of this year, non-fossil energy has been developing more rapidly in China, while the country's power generation has also seen a relatively fast year-on-year growth.

Based on corresponding data of the same period in 2019, China's output of electricity generated by wind, solar, and nuclear power plants rose by 17.6 percent, 12.5 percent, and 9.6 percent respectively on average in the first quarter this year from two vears ago.

Meanwhile, power supply projects in the country received a total of 79.5 billion yuan (about \$12.37 billion) of investment, which represented a 31.3-percent year-on-year growth rate and an average growth rate of 39.9 percent from two years ago. In particular, about 91 percent of the investment was channeled to power generation projects using non-fossil energy.

"Our dining hall and kitchen have stopped using coal or natural gas, and switched to induction cookers, which are safer, produce less lampblack and smoke, and cut our energy consumption cost by half," said Lai Yong, an executive of a hot pot restaurant in Chengdu, capital of southwest China's Sichuan province. Lai is very satisfied with the decision to replace the cooking stoves of the restaurant with induction cookers.

More than 10,000 hot pot restaurants in Chengdu are using electric cooking appliances, accounting for about 70 percent of the total number of hot pot restaurants in the city.

These hot pot restaurants with electric cookers have effectively advanced the development of clean and low-carbon energy of the city, as they consume approximately 837 million kWh of electricity a year, which means they reduce over 710,000 tonnes of carbon dioxide emissions for the city every year.

In fact, many cities in China have taken active measures to promote the replacement of traditional energy with electricity in key sectors and industries, comprehensively improve resource use efficiency and facilitate the country's energy revolution.

South China's Guangdong province has come up with the idea of establishing a budget-management system for energy consumption to strictly regulate the launch of energyintensive projects.

The southern island province of Hainan plans to add 25,000 new energy vehicles (NEVs) to the city, start building a world NEV experience center, and make sure the combined floor area of prefabricated buildings in the province reach 17 million square meters this year.

Denmark agrees law to deport asylum seekers outside Europe

COPENHAGEN

DENMARK'S parliament yesterday passed a law enabling the Nordic country to relocate asylum seekers to countries outside Europe, defying calls to abandon the plans from NGOs and the United Nations, which fear an erosion of refugees' rights.

The move to pass the bill, with 70 lawmakers voting in favor and 24 against, is an apparent break with the European Union's efforts to overhaul Europe's broken migration and asylum rules, an extremely divisive subject within the bloc.

The bill would allow Denmark to move refugees arriving on Danish soil to asylum centres in a partner country, potentially outside Europe, where asylum seekers would have their asylum cases reviewed and possibly obtain protection in that country.

"If you apply for asylum in Denmark, you know that you will be sent back to a country outside Europe, and therefore we hope that people will stop seeking asylum in Denmark," the government party's immigration speaker Rasmus Stoklund told broadcaster DR earlier vesterday.

The wealthy Scandinavian nation, which has gained notoriety for its hardline immigration policies over the last decade, has a declared goal of receiving zero asylum seekers, and instead aims to only accept refugees under the UN's quota system.

Denmark has yet to reach an agreement with a partner country, but Stoklund said it was negotiating with several candidate countries.

Critics worry the plan will undermine the safety and welfare of refugees and compromise their human rights as well as allow Denmark to duck its obligations within the EU.

"The idea to externalize the responsibility of processing asylum seekers' asylum claims is both irresponsible and lacking in solidarity," Charlotte Slente, general secretary of the Danish Refugee Council, an NGO, said in an emailed statement to Reuters.

The United Nations Refugee Agency (UNHCR) last month called on Denmark not to pass the bill, which it says could catalyze a "race to the bottom" if other European countries begin mimicking Denmark's policy.

"UNHCR remains firmly opposed to externalization initiatives that forcibly transfer asylum seekers to other countries," UNHCR Assistant High Commissioner Gillian Triggs said in May.

"Such practices undermine the rights of those seeking safety and protection, demonize and punish them and may put their lives at risk," Triggs said. Agencies

Nigerian gov't accuses Twitter of double standards, supporting secessionists

THE Nigerian government on Wednesday expressed doubts about Twitter's mission in the country, accusing the U.S. technology company of double standards and supporting the secessionists in the west African country.

Information and Culture Minister Lai Mohammed took a swipe at Twitter after it deleted a tweet by President Muhammadu Buhari who issued a warning to troublemakers in Nigeria.

Violent crime on surge in US amid COVID-19 pandemic

WASHINGTON

VIOLENT crime in U.S. cities surged to record levels as the nation was struggling in the COVID-19 pandemic. Experts said deteriorating security could affect midterm elections next year.

Statistics from the Federal Bureau of Investigation show the murder rate surged by 25 percent in 2020 -- the first time the United States has seen over 20,000 annual murders since 1995 -- up from 16,000 the previous year.

This occurred in the nation's major cities, and is showing no signs of abating.

The New York Police Department reported early in May that shootings were up 166 percent in April, compared to the same period last year.In Chicago, murders surged 50 percent from 2019 to 2020, most of the victims being people of color, according to the Cook County Medical Examiner's Office.

percent from 2019 to 2020 -- the largest one-year rise in 30 years, according to the California Department of Public Health.

Carjackings -- when an assailant forces a driver out of a car with a gun and steals the automobile -- have suddenly become a major problem in Washington DC, the nation's capital. The most recent DC police data shows that over 200 carjackings were reported in DC and the counties around it between January and April this year. That's a massive surge from the 60 carjackings reported in 2020 in the same period.

Linda Scott, a housewife outside the DC area, told Xinhua: "I tell friends who are visiting not to drive through DC," she said.

Rhonda Kim, in business management outside DC, told Xinhua that she "refuses" to drive into DC at night.

Asian hate crimes have surged 146 percent in 26 of the largest jurisdictions in the United States in 2020, according to the Center for the Study of Hate and Extremism at California State University, San Bernardino. Experts said they are accelerating.

Mayors of many of the most violent cities are Democrats, and experts said that could hurt the party in the lead up to next year's midterm elections.

"The surge in violent crimes is not helping the Democratic mayors," said Brookings Institution Senior Fellow Darrell West.

"It highlights a breakdown in the law that has occurred during COVID and the financial challenges people have had. Republicans are starting to use this issue against (U.S President Joe) Biden and will continue to do so as long as the numbers remain high," West said. Republican Strategist and TV news personality Ford O'Connell said: "This is a real problem for the Demo-

crats headed into the midterms," which are slated for next year.

Indeed, midterm elections are historically won by the party not in the White House, and surging crime in America's cities adds to Democrats' woes, experts said.

Republican lawmakers in major U.S. cities, such as Atlanta, in the U.S. state of Georgia, are already capitalizing on the surge in murders. Georgia Attorney General Chris Carr last month vowed to "fill the void created by Atlanta officials' failure to lead."

While U.S. President Joe Biden, during the 1990s, was known as tough on crime, some Democrats fear that voters may no longer make this association. Rather, they fret that voters may believe Republicans' narrative that the entire party, not just its left wing, wants to de-fund the police.

"Can Republican candidates exploit the issue? Yes, they will. Can they make it the top, election-winning issue? In some mayoral races they may be able to. Will it work as a national issue?

They and (former U.S. President Donald) Trump got some mileage out of it in 2020, but not enough. They would need for the problem to keep rising," said Clay

Ramsay, a researcher at the center for international and security studies at the University of Maryland.

WHAT'S BEHIND THE VIOLENCE?

Republicans and law enforcement said the surge in violence is due to defund the police movements nationwide, which have demoralized law enforcement. The movement began to pick up steam last year after George Floyd, an unarmed black man, was killed by police.

John, a police officer in the U.S. state of Pennsylvania, told Xinhua that criminals have become emboldened, as police are now less motivated to react to every instance of violence unless it's something major. The officer did not provide his last name, as he is not cleared to speak with media.

In an opinion article in USA on Tuesday, Jason Johnson, former deputy police commissioner for the U.S. city of Baltimore and the president of the Law Enforcement Legal Defense Fund, argued that public officials' "growing hostility toward policing left law enforcement demoralized, debilitated and, in some cases, de-funded."

"Even the most dedicated officers, who

now face a greater risk of being sued, fired or prosecuted for doing their job, feel pressure to pull back,' Johnson said.

"To mitigate that risk, police take a more passive approach," Johnson argued.

Patrick Sharkey, a sociologist at Princeton University and expert on crime, told the Atlantic Monthly in a recent interview that in areas where institutions break down, people feel like they're on their own, and that creates conditions where violence becomes more likely.

"Last year, everyday patterns of life broke down... Schools shut down. Young people were on their own. There was a widespread sense of a crisis... That type of destabilization is what creates the conditions for violence to emerge," Sharkey argued.

UK and Australia bid to strike trade deal by mid-June **CANBERRA/LONDON**

BRITAIN and Australia held another round of talks to progress a free trade deal, the British envoy said yesterday, as both countries seek to strike an agreement in mid-Iune.

Britain is pursuing a deal with Australia as one of the pillars of its post-Brexit strategy to build stronger commercial and diplomatic links in the Indo-Pacific region.

Both countries in June said they have agreed on the vast majority of issues for a deal, which official estimates say could add 500 million pounds (US\$708.4 million) to British economic output over the long term.

But with some sticking points remaining, British Trade Minister Liz Truss and her Australian counterpart Dan Tehan held talks late on Thursday, the British High Commissioner to Australia Vicki Treadell said.

"We are working hard to have an agreement in principle at the bilateral between Prime Ministers Johnson and Morrison on June 15," Treadwell told reporters in Canberra. Agencies

The Abuja-Kaduna rail line and Abuja light rail were constructed by the China Civil Engineering Construction Corporation (CCECC) under the Belt and Road Initiative. have secured jobs thanks to the rail tracks, and witnessed the development and changes in the capital. Abiola is the first woman in Nige-

ria that is licensed to drive a train. In 2006, the CCECC was recruiting kitchen helpers in her hometown Ilorin, Kwara State. Learning that Chinese companies were reputable and offered decent salaries, Abiola, who had just graduated from high school, applied for a position and became an employee of the Chinese construction company.

"Chinese experiences suit the development demand of Nigeria. China is sincerely helping us, and if you can speak Chinese you will have a bright

future," Abiola told People's Daily. As she gradually had a better understanding of Chinese companies, she became more determined to develop in a Chinese firm. She spent almost all of her spare time learning Chinese.

In 2013, tracks began to be laid for the Abuja light rail, which was built in accordance with Chinese specifications and standards. Abiola, by her outstanding job performance, earned herself an opportunity to receive locomotive driving training, as the only female trainee.

Five years later, when Abuja light rail was officially put into service, Abiola became the only woman among the first batch of all locomotive drivers.

Transport is a lifeline for cities, said Nigerian President Muhammadu Buhari when declaring the full operation of Abuja light rail on July 12, 2018. Hailing the light rail as a high-quality project, he expressed

his gratefulness to the Chinese government and people for their support for Nigeria's development.

As an employee representative, Abiola handed a signal flag to Buhari who later ordered the departure of the first train on Abuja light rail.

"This moment was of historic significance," Abiola said, adding that the company's decision to have her drive the first train indicated its trust in not only herself, but also all local employees.

Most of the residents in Abuja live in the four suburban satellite towns of the city, so there are four major commute routes. The roads were always jammed during peak hours, and the traffic could stay stagnant for even half an hour.

As the first light rail in West Africa, Abuja light rail has brought conspicuous changes to local transportation and the livelihood of local residents. Abiola told People's Daily that the light rail is punctual, and is favored by more and more people. "It plays an important role in alleviating urban traffic pressure, and also reduces traffic accidents," she added.

The construction of the light rail created nearly 5,000 jobs at most for local community. And more job opportunities have been created to local residents since the project started operation, from frontier workers to key management and technical staffs.

"When I drive the train through the city, I can literally feel the benefits it brings," Abiola said. According to her, more and more stores have been opened along the route. With increasing passenger traffic, commercial areas and communities are taking shape, she added.

"I feel very happy about the life of us, which is getting better and better," she said.

Paschal Arinze Nnorli, regional chief of Nigerian Railways Corporation Abuja, said the light rail not only has created economic benefits and jobs, but also is generating long-term and incalculable value with its safe and stable performance.

Due to COVID-19 control, Abuja light rail's five-storey comprehensive maintenance center was transformed into a makeshift hospital in just 40 some days. The hospital, with 506 beds and covering 12,500 square meters, played an important role in Nigeria's fight against the virus.

"Our Chinese friends are helping not only us, but also the entire Africa. I want to contribute my own strength to my company, and to the common development of Nigeria and Africa," said Abiola, adding that she will still strive for a position on the driver's seat of a bullet train once high speed rails are paved in her country.

"I want to become the first female driver of a bullet train in Nigeria, and contribute to the 'Nigerian speed,'" she noted.

ANZANIA will not be represented by Para Swimmers and Power Lifting athletes to the coming Tokyo Paralympics, Tanzania Paralympic Committee (TPC) announced.

Ramadhan Namkoveka, TPC Secretary General, said the TPC has failed to raise money for Para athletes' trips to qualifying and classification events. Tokyo Paralympics are slat-

ed for August 24 to September 5 this year.

He said the country was to send Para athletes to classification which is slated for June 14 in Berlin, Germany, and a qualifying event slated for three days later.

The TPC official said they needed \$7046 for a coach and Para swimmer's trip to Germany for the two events.

He said TPC's efforts to secure funding for the trip of the Para swimmer Amos Boniface and his coach to travel to Germany proved futile.

He thanked one Dar es Salaam-based company, which was ready to pay part of the money.

"We needed \$7046 for the World Berlin Para Swimming and classification, the money would have catered for air tickets for the coach and swimmer, participation fee, and Covid-19 tests, but we have failed to get the funds.

"We thank a Dar es Salaambased company which was ready to pay part of the money, but we have failed to secure the remaining money," he said.

He said the country's Para Lifting contingent, made up of athlete Yohana Mwila and coach Nemes Chiwalala, needed \$5,432 to compete at the 11th we have failed, the dream of

Simba SC Disciplinary Committee set to discuss midfielder Mkude

AFTER reports of the suspension of Simba SC's midfielder, Jonas Mkude, due to misconduct, the longest-serving club player's file is has been sent to the outfit's Ethics and Disciplinary Committee.

The committee is under Suleiman Kova who is the former Dar es Salaam Special Zone Police Commissioner, and Mkude's case was referred to the committee's members and they have started the proceedings.

The 28-year-old whose contract expires at the end of the season, may also not play in the remaining Premier League matches and will still be donning the side's kits next season if Simba decides to extend his contract.

But Kova disclosed his committee would meet again on June 5 (Saturday) to continue hearing the case and if possible they would finalize and rule on it.

Kova briefed Simba members and fans who were hearing rumors about the suspension.

He noted: "The matter is indeed on our table and we have started working on it, on Saturday, June 5, his verdict will come out."

Mkude, who as well plays for national football side 'Taifa Stars, is yet to report to his club's training since May 18.

He has now been asked by the club to stay away after he decided to abscond duty.

A source within the club, who opt for anonymity, stated the decision by the club is final and the player will have to explain himself before regaining his place back in the team.

The club has reached a decision to suspend midfielder Jonas [Mkude], who is not and has never reported to camp since the team returned from South Africa where they played Kaizer Chiefs in the quarterfinals of the CAF Champions League," the source said.

"Two days after the team arrived from South Africa, all the players were asked to report to camp to start preparations for the return leg having lost 4-0 in the first leg but Mkude did not show up, and he never sent either an apology or reason as to why he was missing.

"But when he came to camp, he issued his reason for his absence to the team's head coach Didier Gomes Da Rosa and team manager Patrick Rweyemamu but both did not agree with his reason, they felt he was lying and asked him to leave.

"Since then, Mkude was asked not to report to camp but stay away from the team and he thus missed the return leg against Chiefs which Simba won 3-0 but failed to qualify for the semifinals.'

The source stated: "But even after the Chiefs game, the club is yet to allow him to return to camp or join the rest of the squad, but what I know is he has been stopped from attending anything to do with the club because of disciplinary issues, and the case is now with the team's disciplinary committee for discussion."

In January, Mkude was fined 2,000,000/- by Simba after he pleaded for forgiveness after he was found culpable for three offenses.

The first offense was his decision to skip the club's seminar which was held to discuss the team's targets for the season, his second mistake was reporting late to training ahead of their Vodacom Premier League match against Coastal Union with his third mistake being failure to report to camp on December 26, 2020, without permission.

This is not the first time Mkude has been suspended by his club for misconduct, he has missed out on the 'Simba Super Cup' and the Mapinduzi Cup competitions.

TFF hardly perpetuates favouritism, says Karia

TANZANIA Football Federation (TFF) president Wallace Karia has dismissed allegations he has been favouring Simba SC over their age-old rivals Yanga.

Karia said he only has an affiliation with Coastal Unionnow placed 16th in Vodacom Premier League with 33 points.

He was adamant that there is nothing he can help Coastal Unio with to salvage the situation despite his TFF position.

"If it is about loving a team, maybe Coastal Union but it is something that you can openly say 'yes, this is the team I support. But the allegations

"Where have I shown favour towards Simba and when did I show that I hate Yanga? I love

Coastal Union but you can see they are likely going down."

"Since I was young, I have supported Coastal Union but I found the rest of the clubs there and I have never been attached to them."

"If I had the behaviour of trying to help teams, don't you think it would have been easier to help the team that I am a registered member for?"

The TFF has recently come under fire, particularly from Yanga fans who believe the current administration is favouring Simba, the Vodacom Premier League defending champions.

The most prominent case that pitted TFF against Yanga is the case that involved Bernard Morrison's move to Simba in 2020.

The Ghanaian joined Simba even though Yanga claimed he had signed a contract extension with the outfit before TFF's Players' Status Committee ruled the winger was a free agent and was allowed to make the move.

Recently, controversy ensued when the Premier League Board rescheduled the May 8 top-flight game pitting Yanga against Simba.

Yanga protested and did not take part citing regulations that govern such instances.

The new date for the match has been given as July 3 but Yanga has indicated they will not avail themselves for the game.

Brazil, Argentina must put Copa row aside as World Cup qualifying resumes

AMID all the fuss about the upcoming Copa America and where it will be hosted, it is easy to forget that there are two rounds of 2022 FIFA World Cup qualifiers to be played in South America. These, though, are the more important games.

Originally these dates were set aside for pre-Copa friendlies. But because of the pandemic, South America is way behind. Only four rounds of fixtures have been played. Another 14 have to be squeezed in before the end of March next year. And so there is one round this Thursday and Friday, and another next Tuesday, before the teams head to Brazil for the Copa.

This puts South American international football in a curious position. There have been no competitive matches since last November. Bolivia, Chile and Ecuador managed to play friendlies in March. Everyone else is getting together for the first time in seven months. And now the warm-up matches are more important than the tournament that follows. The Copa America is clearly secondary. Everyone's priority is to make it to Qatar at the end of next year.

South American confederation CONMEBOL has four automatic slots in the 2022 World Cup, which begins on Nov. 21 next year, with the team finishing fifth having to go through a playoff. So far, three teams have pulled away from the pack at the top of the standings, and two of them face each other in the only match being played on Friday when Brazil host Ecuador in Porto Alegre.

With four wins out of four, Brazil found a blend last year that was better than anything they had done since the end of the previous set of World Cup qualifiers. The 2018 quarterfinal defeat to Belgium in Russia left coach Tite confused. His side had been too open down the left flank. He responded with a more cautious approach from his full-backs, but it never looked entirely convincing even though Brazil won the 2019 Copa on home soil. Since then he has tried something new, freeing attacking left-back Renan Lodi to push forward with midfielder Douglas Luiz covering the space behind him.

But Douglas Luiz is suspended for this game -which could offer a glimmer of hope to Ecuador, who are strong on the counter-attack. Under Argentine coach Gustavo Alfaro, Ecuador opened up with a very defensive display and a 1-0 defeat away to Argentina, followed by three thrilling victories. They will be very wary of Brazil's attacking threat, and can be expected to be cautious once more. Realistically, they will feel that anything they pick up from this match will be a bonus, and their aim will be to move on with confidence intact. Then again, Brazil have never lost a World Cup qualifier at home, a record that has to fall one day, and after so long out of action they could be more vulnerable. But a Brazil defeat would be an even bigger

Why N'Golo Kante deserves the Ballon d'Or in 2021

H E N N'Golo Kante walked into the France national team camp in Nice on Tuesday alongside Olivier Giroud and Kurt Zouma, his Chelsea teammates, he was greeted by huge cheers and applause. On Saturday evening, the French squad and manager Didier Deschamps and his staff

watched the Champions League final together, once again in total awe of their No. 13's performance.

Even after all these years -- 45 national team caps and counting since 2016 -- Kante still manages to surprise even his closest friends and teammates with the performances he turns in from week to week.

When Kante arrived, completing Les Bleus' 26-man squad for the Euros, some of the squad welcomed him with the Ballon d'Or treatment. It was half-joking, halfserious, but some teammates told him he was on the golden path to get the golden ball. Others wondered if he'd run the entire way from London to southern France ahead of their friendly with Wales (which the world champions won 3-0) while Deschamps, as always, had choice banter. But deep down, the coach and this team know how lucky they are to have such a player in his squad. As Olivier Giroud told ESPN: "N'Golo is just extraordinary. It's not just the running and the effort, or the balls re-

The other team doing well are Argentina, who under Lionel Scaloni have made great strides since the 2019 Copa, when they lost to Brazil in the semifinals. Looking more like a team than at any time since they reached the final of the Centenary Copa in the United States five years ago, they have put together three wins and a draw, and are firm favourites to chalk up another victory at home to Chile on Thursday night.

Not all of their problems have disappeared, though. There is still a dearth of talent in central defence. But will Chile be able to test the weakness? New coach Martin Lasarte is handicapped by the loss of midfield powerhouse Arturo Vidal, who has been hospitalised after testing positive for COVID-19. And the big problem is the one that previous coach Reinaldo Rueda wrestled with for two years before choosing to resign: Chile have not developed players with the quality of the generation that won back-to-back Copas in 2015-16, and are still dependent on the old guard.

Rueda jumped ship to take charge of his native Colombia. He goes straight in at the deep end with a crunch match first up away to Peru, the game that closes Thursday's action. Colombia have four points, and suffered a disastrous two rounds of heavy defeats in November. Peru have only one point, and desperately need a win to stay in touch.

Another high-pressure clash comes earlier that same day, between Uruguay and Paraguay. Both sides are in midtable with six points. The winners will join the leading pack, while the losers will slip back amongst the trailers. It will be interesting to see Uruguay's approach. Edinson Cavani is suspended, and a number of other strikers are out injured. This could be a chance, then, for coach Oscar Washington Tabarez to come off his usual 4-4-2 system. Uruguay could field more of their talented young central midfielders, and have the option to use wingers either side of Luis Suarez. It should have been an opportunity for playmaker Giorgian De Arrascaeta to be used in his favourite position, through the middle. But he, too, has gone down with COVID-19.

The other game, the first of the round, is between Bolivia and Venezuela. Bottom-of-the-table Bolivia have just one point, and all their hopes are pinned on winning this game. Venezuela, the only South American side never to have made it to a World Cup, are disappointed to have just three points thus far. And they will find things very difficult in the prevailing conditions.



KENYAN midfielder Francis Kahata is back in his home country after efforts to renew his contract with Tanzanian club Simba SC hit a snag.

Kahata former Gor Mahia midfielder, who joined Simba in the 2019/20 season as a free agent, has already returned to the country amid reports he may not return to the club.

The midfielder is among the five players whose contracts at the reigning Premier League champions come to an end at the end of the season, but he has been in talks to extend his stay, which reached an impasse, forcing him to return home.

"Francis [Kahata] is among five players running down contracts at Simba and his efforts to extend the same may have failed and it is the reason he decided to go home," a source at Simba, who did not want to be named, stated.

"Simba's leadership gave him the contract he was required to sign for free while improving his monthly salary only, an act which he has denied and instead, decided to take a break."

Kahata was recently omitted from the squad registered for the Mainland Premier League and he was replaced by Zimbabwean Perfect Chikwende, who joined Simba during the mini-transfer window this season.

When contacted for comment, Simba SC official Ally Shatry said there is no harm in Kahata returning home as he is not being used by the club in the league and was only registered to play in CAF Champions League.

"If he has returned home, then it means there will be an agreement between him and coach Gomes [Didier], because as you know the player's name was removed from the league list and instead placed in Champions League campaign," Shatry said.

"So, the coach may allow him to return home for a break as we are currently not participating in the Champions League, and we are left with the league and the Federation Cup alone and he is not serving us, but about contract issues, I have not received official information from my senior officials."

Efforts by The Guardian to reach out to Kahata, who is among two Kenyans in Simba SC squad alongside defender Joash Onyango, for a comment, bore no fruits as our calls went unanswered.
